Truck drivers coming back to work, normalcy to return in a day or two

New Delhi, January 3: Truck drivers, who went on strike to protest against the new stringent law on hit-and-run cases, have started coming back to work and normalcy will return in a day or two, truckers' body All India Motor Transport Congress (AIMTC) said on Wednesday. AIMTC on Tuesday appealed to protesting truck drivers to end their strike after the government assurance that the decision to invoke stringent jail and fine provisions for hit-and-run cases under the Bharatiya Nyay Sanhita (BNS) will be taken after consultation with the truckers' body. Representatives of AIMTC met Union Home Secretary Ajay Bhalla on Tuesday to raise the issue of stringent provisions for hit-and-run cases. "We had not given any strike call...striking drivers are coming back to work and normal operations would be restored in one or two days," AIMTC general secretary N K Gupta told PTI. Gupta said the strike by truck drivers in some places was a spontaneous reaction to the new laws and "the drivers need not worry now and should join the work and contribute to the growth of the economy". Some truck, bus and tanker operators had begun a three-day strike on Monday in several states to protest against the "stringent punishments" provisions.

Sanjay Kundu back as **Himachal Pradesh DGP**

New Delhi, January 3: Senior IPS officer Sanjay Kundu will be back as the DGP of Himachal Pradesh as the Supreme Court on Wednesday stayed the High Court's order to shift him from the top post. A Bench led by CJI DY Chandrachud also stayed the Himachal Government's order shifting him as the Principal Secretary of the Ayush Department. The Bench granted liberty to Kundu to move the High Court to seek recall of its December 26 order to the state government to shift him in view of allegations of interference in an ongoing criminal probe. Noting that the direction for transfer of Kundu from the post of DGP would



remain stayed until the recall application was disposed of, the Bench urged the High Court to dispose of such an application in two weeks. The order came after senior counsel Mukul Rohatgi submitted on behalf of Kundu that the High Court passed the impugned order without hearing him. Rohatgi had on Tuesday said the action against Kundu was "extraordinary" as the High Court did not hear him out before directing the state government to shift him. Following the High Court's order, the Himachal Pradesh Government had on Tuesday transferred Kundu to the Ayush Department as Principal Secretary. Kundu has moved the Supreme Court against the High Court's Order to shift him to ensure that he doesn't influence the probe into the alleged harassment of Palampur businessman Nishant Sharma. The Himachal Pradesh High Court had on December 26 ordered the state government to shift Kundu and Kangra Superintendent of Police Shalini Agnihotri to other posts before January 4, 2024, to ensure that "they didn't have an opportunity to influence the investigation". Nishant had, in an email complaint to the High Court, alleged that he and his family feared for their lives as he was "attacked in Gurugram and in McLeodganj". He had sought the High Court's intervention on the grounds that he "needed protection from powerful people as he was living in constant fear of being killed". In a complaint to the High Court, Nishant had alleged threat to his life from "two extremely rich and well-connected persons, a former IPS officer and a lawyer, as the complainant and his father had not yielded to their pressure".

Disabled ward of ex-servicemen entitled to lifetime pension if they were dependent on it at time of accident

Chandigarh, January 3: About 20 years after family pension being paid to him was stopped, the Armed Forces Tribunal has held that the disabled ward of an ex-serviceman is entitled to family pension for life if he had earlier been dependent on the pension. According to pension rules, ordinary family pension is paid to the ward of a government employee whose both parents have died till the age of 25 years, of for lifetime if disability renders him unable to earn an income. The recipient's father had died in 1994 and his mother in 1996. He was sanctioned family pension thereafter which was to be paid till 2004, when he attained the age of 25 years. However, in 2000, he met with an accident which resulted in 65 percent disability for life. On learning that wards of Armed Forces pensioners suffering from any mental or physical disorder or disability that makes them unable to earn a livelihood shall be granted family pension for life with effect from September 2012, he submitted a representation for grant of family pension. The claim, however, was rejected by the Principal Controller of Defence Accounts (Pensions), Allahabad, on grounds that none of his deceased parents during their life time ever declared his disability and he had declared his disability after death of his parents.

No ground to order investigation by SIT into allegations against Adani group: Supreme Court

New Delhi, January 3: The Supreme Court on Wednesday rejected petitions seeking to transfer the probe into allegations of stock price manipulation levelled by Hindenburg Report against Adani Group from SEBI to an SIT. A three-judge Bench led by CJI DY Chandrachud - which had reserved its verdict in the case on November 24 last year - said there was no ground here to transfer the probe in this case and it could only be ... raised if there was wilful or deliberate violation of rules. Noting that SEBI had already completed probes into 22 of the 24 matters, the Bench directed SEBI to complete the investigation in the other two cases in three months. The Bench, however, said, "This court has the power under Articles 32 and 142 to transfer the probe to CBI, etc, but such powers can only be used sparingly and

this court will not ordinarily supplant this role, and the petitioners must put forth strong evidence to show that the inves-



ner." It also rejected allegations of conflict of interest against the Expert Committee appointed by it to look into the matter. "The Govt of India and the SEBI to look into if there is any infraction of law by Hindenburg Report on short selling, and if so, take action in accordance with law," the CJI said, pronounc-

ing the verdict. It directed the Centre and SEBI to take into consideration the recommendations of the Expert Committee to protect interests of the Indian investors. The report of OCCRP cannot be taken into account to doubt the SEBI investigation, it said. "The reliance on OCCRP report is rejected and reliance on a third party organisation report without any verification cannot be relied upon as a proof," the top court said. While reserving the verdict, the top court had on November 24 said that it had no reason to "discredit" SEBI, which probed allegations against the Adani

group, as there was no material before it to doubt what the market regulator had done and the court did not have to treat what was set out in the Hindenburg report as a "true state of affairs".

ISRO to use Musk's SpaceX Falcon 9 rocket to launch

communication satellite in 2024 Bengaluru, January 3: ISRO's commercial arm NewSpace India Ltd has announced plans to launch its communication satellite GSAT-20 onboard Elon Musk-owned SpaceX's Falcon-9 rocket in the second quarter of 2024, to meet the broadband communication needs of the country. GSAT-20 (renamed as GSAT-N2) is a high throughput Ka-band satellite. Ka-band satellites deliver high-speed broadband internet connectivity and digital video and audio transmission. In a statement, the state owned NSIL said the bulk of the high throughput satellite (HTS) capacity onboard GSAT-20 satellite has already been secured by Indian service providers. GSAT-20 offers Ka-band HTS capacity with 32 beams having pan-India coverage including in Andaman and Nicobar and Lakshadweep islands, it said. "NSIL is realising GSAT-20 satellite through ISRO and will be launched onboard Falcon-9 under a launch service contract between NSIL and SpaceX, USA. GSAT-20, weighing 4,700 kg, offers HTS capacity of nearly 48Gpbs. The satellite has been specifically designed to meet the demanding service needs of remote/unconnected

JMM-led coalition MLAs meet to discuss political situation, Hemant Soren to remain CM

Ranchi, January 3: Legislators of the ruling coalition partners in Jharkhand on Wednesday expressed solidarity with the Hemant Soren government and said the JMM leader will continue as the state chief minister. Coming out from the meeting held here to discuss the present political scenario in the backdrop of the ED's summons to Soren, the lawmakers said they stand united and "solidly" behind Soren and there is no threat to the present government. Senior JMM leader, Mithilesh Thakur, who holds the drinking water and sanitation portfolio, said Soren will continue as the chief minister and JMM will contest the 2024 Lok Sabha and state Assembly polls under his leadership. The meeting was chaired by Soren himself. "The MLAs of the coalition parties are united, there is no threat to the present government. There was no talk of any change in the leadership in the state," a legislator said after the meeting. Soren, the 48-year-old executive president of JMM, has been in the

The Election Commission had sent a letter in August 2022 to the then governor of Jharkhand, Ramesh Bais which is believed to have recommended his disqualification as an MLA as a mining lease given to him was renewed during his tenure as the chief minister. However, neither Bais nor his successor C P Radhakrishnan

opened the letter. Meanwhile, Soren has dismissed speculations that his wife Kalpana will contest from Gandey assembly constituency in the state, which was vacated

December state election. Soren has termed the speculation that his wife will be anointed the chief minister as a "complete imagination" of the opposition BJP. "There is not an iota of truth in the speculations," he said. The speculations were triggered by the ED's latest summons to Soren coupled with the sudden resignation by JMM MLA from Gandey, Sarfaraz Ahmad on Monday. "The possibility of my wife contesting any election in the near future is completely an imagination of the BJP ... The speculation about handing over reins to her by me is a fabric woven by the BJP to build a false narrative," the chief minister told PTI on Tuesday. The saffron party has claimed that Ahmad was made to quit so that Kalpana Soren could contest from the Gandey in case of any eventuality in connection with the ED summonses. The coalition has 47 members - 29 of JMM, 17 of Congress and one of the RJD. The opposition BJP has 26 members and AJSU Party three. The NCP and CPI (ML) have one lawmaker each, apart from two Independents.



2 BTech students dupe banker of Rs 21 lakh with London job offer, held

MUMBAI. The cyber crime police have arrested two BTech students from a university in Punjab for allegedly cheating a 47-year-old assistant general manager of a private bank in the western suburbs of Rs 21 lakh with the lure of a general manager's job in a London bank.hree more accused, who had withdrawn money from various ATMs, are on the run. Police have frozen 12 accounts belonging to the accused and recovered Rs 1 lakh cash. The complainant told police that on July 22, 2023, he had received an email offering him a general manager's position in a reputed bank in London. Later, he received a phone call from a person who said he was from a recruitment agency and had seen his profile on a social media site. After several calls, an online interview was scheduled. "The complainant gave the interview, but could not see his interviewer as his camera was switched off. The complainant was later informed that he had been selected," said a police officer.

The complainant receiv-ed several calls from the accused asking him to pay fees for profile verification, portfolio management, certification, ID, and seat confirmation. Between July 26 and August 10, 2023, he transferred a total Rs 21 lakh to two bank accounts provided by the fraudsters. After paying the fees, he did not get any response from the recruiting agency. Despite several attempts, when he couldn't contact the person from the agency, he realised he had been cheated and filed a complaint with the crime branch's cyber police station on September 26, 2023.A team supervised by crime branch head Lakhmi Gautam and DCP D S Swami, and comprising senior inspector Suvarna Shinde, and officers Mahendra Jadhav, Amit Utekar, Deepak Tayede, staff Keshav Takik and Vijay Jadhav detected the case. They first arrested Pratik Singh (20), who spilled the beans on his accomplice Rushabh Dubey (25). As Dubey was in a Bhopal jail in a cyber fraud case, police took his custody on a production

Palayam traders raise disputes over rehabilitation blocks

THIRUVANANTHAPURAM. The temporary rehabilitation blocks being constructed to facilitate the redevelopment of the century-old Palayam Connemara Market are nearing completion. According to official sources, two of the three temporary blocks will be ready by January 15. However, the allocation of temporary shops has sparked a row, with a section of beneficiaries raising disputes over the inadequacy of space allotted for them. Around 50 traders running shops in Trida (Trivandrum Development Authority)owned land at Palayam close to the market have come out with stiff protests "Trida had promised to give us proper rehabilitation in the temporary rehabilitation block but now we are not being allotted the promised space. We have been running shops here for the past six decades and we gave away land for road widening and underpass construction. Trida promised to give permanent rehabilitation in the temporary blocks but now it's not being given. There are restaurants and the allotted space is not adequate. The redeveloped market is only for the traders who will be displaced from the market. We are not eligible for that," said Siyad S, president, Thozhiludama Association, an association affiliated to Kerala Vyapari Vyavasayi Ekopana

Beyond spice to medicine, culture, & more

KOCHI. India holds the title of the world's leading producer of turmeric. Beyond production, it is a significant consumer and exporter of this versatile spice, often called 'Indian Saffron.' Turmeric, or 'Haldi' as mentioned in the ancient 'Atharva Veda' dating back to 1000-1500 BC, has deep roots in India's history. Its uses extend beyond a mere spice; it has been integral to religious ceremonies, traditional medicine, and even as a natural dye. Ayurveda, the ancient Indian medical system, recognises turmeric for its medicinal properties, and recent global research has sparked heightened interest in its biomedical potential, especially in the wake of the Covid pandemic.

The rise of Turmeric Board

Turmeric, a multi-faceted commodity, is now on board with the recent establishment of the Turmeric Board by India government. In response to the growing significance of turmeric, the Government of India has recently established the Turmeric Board based in Telangana, one of the leading turmeric-producing states.

According to the Ministry of Commerce & Industry, this initiative aims to provide leadership, enhance efforts, and foster coordination among various government bodies and the Spices Board for the development and growth of the turmeric sector. India's dominance in the global turmeric market is evident, accounting for over 62% of the world's turmeric trade in 2022-23. More than 380 exporters facilitate the export of 1.534 lakh tonnes of turmeric and turmeric products (valued at \$207.45

'Kutch among districts highly vulnerable to coal phaseout'

(COP) 28 held in November-December in Dubai, India reasserted that the country cannot afford to transition from coal, its biggest power source that accounts for 75% of its energy generation requirements.A group of researchers from Ahmedbad University, who studied India's relationship with coal from economic dimensions, claimed that 10 of the districts — primarily concentrated in central India — are highly vulnerable to coal phaseout. The study 'Just transition away from coal: Vulnerability analysis of coal districts in India' by Kopal Agrawal, Minal Pathak, Kaushik Jana, Jeemol Unni and Priyadarshi Shukla was recently published in Elsevier journal Energy Research and Social Science. These vulnerable districts include Singrauli, Chatra, Bokaro, Dhanbad, Bardhaman, Korba, Jharsuguda, Rajgarh, Angul and Chandrapur."We study 88 coal districts representing 90% of the coal mining capacity

and over 50% of coal-based power generation capacity of the country. We find the vulnerability of the coal transition in India is highly regional and concentrated in 10 districts," said a researcher. Talking about the 10 districts, the researchers added that the local economy including revenue and employment is highly dependent on coal infrastructure. "The local population has low adaptive capacity in context of gross value added (GVA), low literacy rate, multidimensional poverty and higher share of unskilled labour to cope with the coal phase out," said an author. The authors added that the objective of the study was not to discuss whether India should have coal phase out/ phase down, but instead a need to understand challenges for a just transition at local level. They advocated directing the efforts of just transition policy to most vulnerable districts and rebuilding districts through redevelopment, environmental improvement, skill enhancement for local



population, reviving traditional livelihoods and diversifying industries. In Gujarat, the study took into consideration Bharuch, Kutch and Surat districts for mines and plants, Bhavnagar for only mines and Ahmedabad, Jamnagar and Kheda for only plants. Kutch is considered most vulnerable with coal transition, and Surat less vulnerable, whereas other districts were termed least vulnerable. Coal sector achieves 10.9% growth among eight core industries in NovemberThe index of coal industry has achieved a growth of 10.9% (provisional) in November 2023, reaching 185.7 points, compared to 167.5 points in the same time last year. This growth is primarily due to a substantial surge in coal production, which reached 84.52 million tonne (MT), surpassing the previous year's production of 76.16 MT. The cumulative index of the coal sector during the period of April-November, 2023-24 has also increased by 12.8% over the corresponding period of the previous year.

Why are accused stripped in lockups, Bombay HC asks state govt

MUMBAI. The Bombay high court has asked the state government why accused are stripped in the lockup of police stations even as an inquiry has held four police officers attached to Tardeo police station responsible for illegally detaining a music teacher and making him strip naked in the lockup."Why stripping is necessary of the accused (sic) when they are lodged in the lockup," said Justices Revati Mohite-Dere and Gauri Godse in a recent order. The teacher's wife moved HC with a habeas corpus petition to produce her husband.

Observing that his fundamental right to life and liberty was violated, the judges had on September 29 last year directed the state government to pay him Rs 2 lakh as compensation to be recovered from the salary of the cops found responsible for his illegal detention and to order an inquiry into the incident.

In June last year, on a student's complaint that the teacher spoke to her indecently when she questioned him about fee increase, a zero FIR was lodged at Malad police



station and transferred to Tardeo police station. On July 7, the teacher was booked for sexual harassment and insult to modesty of a woman.On July 17, on learning that he will be arrested, his advocate offered to furnish bail. Yet he was arrested at 9.30 pm and later taken to the Saat Rasta lockup. His advocate moved HC the next day. The judges, in their verdict, noted that the July 7 FIR was forwarded to the magistrate at 11.55 am on July 18 "only after we kept the matter at 2.30 pm." At 2.30 pm, they were told that he was released at 11.59 am. The judges

said the teacher's affidavit revealed that the officers "insisted that he is stripped naked ...and after a while allowed him to put on his underwear."

December 22, prosecutor Prajakta Shinde submitted the inquiry report informing that compensation was paid to him. The judges noted that the inquiry officer had fixed responsibility on the senior inspector, a police inspector and two sub-inspectors. Compensation of Rs 1 lakh and Rs

50,000 will be recovered from the SI and the investigation officer (PSI) and Rs 30.000 and Rs 20,000 each from the other PSI and PI. Shinde said it will be recovered from their salaries. Also, a "circular will shortly be issued" as directed by HC for "appropriate guidelines/directions to police stations with respect to grant of bail in bailable offences."hen Shinde sought further time to place on record what steps the police intend to take in view of what was done to the teacher while in lockup, the judges directed her to state why stripping of the accused is necessary.

No portal, GTU cannot release NCC marks

AHMEDABAD. In 2021, following a decision by All India Council of Technical Education (AICTE), the Gujarat Technological University (GTU) had introduced National Cadet Corps (NCC) as an elective subject. Many students had opted for the subject and the university had asked colleges to conduct exams of the subject. However, according to sources, as the university had to separately announce results of this subject through a new portal, it has not yet announced the results, putting many students in a fix over their final score. Sources said that the university which was to set up a separate portal to announce results of elective subjects has not yet created the portal despite repeated demand from the students. also published the following articles recentlyICMR portal down, no trace of many Covid positive casesThe ICMR portal, which provided information about new Covid cases and patient profiles, is no longer functional. DU grad dies in crash on NY; law student held for rash driving

Gurgaon. Out to celebrate New Year's eve, a Delhi University graduate who recently started working for an IT company, died after the car she was travelling in with three of her friends rammed into a divider and overturned on Golf Course Road in the early hours of Monday. Siddharth Singhal (23), a law student at Amity University who was driving the Maruti Swift, was arrested on Tuesday for rash and negligent driving. Ananya, an Economic (Hons) graduate from Miranda House college, was sitting on the left rear seat of the car when the accident occurred around 5.30am, her father Prakash Singh said. A chief engineer with NCTC, her father told TOI that the Swift overturned after it rammed a divider and recoiled after hitting a barbed wire. Ananya was thrown out of the car. Three others, including Singhal and another youth Sukrit, were not seriously hurt. She was admitted to Sanar hospital, where she succumbed to injuries.

The SHO of Sector 53 police station said an FIR was registered against Singhal under IPC sections 279 (rash driving) and 337 (causing injuries by negligence).

We have arrested Siddharth for rash and negligent driving after a complaint by her father," he said. Police said they are collecting CCTV footage to ascertain what may have happened. Prakash Singh told cops Ananya had left home with Singhal and Sukrit around 9.30pm on Sunday to celebrate New Year's eve and a friend's birthday. "My wife had a chat with Ananya at midnight to exchange New Year greetings. Ananya told her another friend will be joining them later in the night," he alleged. As Ananya was supposed to return home only in the morning, the family did not call her again. "At 8.28am on Monday, my wife received a call from Singhal's number, informing us about the crash. He said Ananya was critical. We reached the hospital, where we saw Siddharth and his parents. He had a wound above his eye. We got to know it was his car (DL9CAN8512) and he was driving rashly," Singh said."My daughter is no more because of his negligent driving. I want the police to take action against him," he said. Ananya had recently joined HCL as a finance

DTCP razes six illegal colonies, frees 15-acre agriculture land

Gurgaon. Intensifying action against illegal colonies in and around the city, the enforcement wing of the town and country planning department (DTCP) demolished six illegal colonies, spread over 15 acres of prime agricultural land. During the demolition, people gathered at the site and DTCP officials appealed to them that they should not invest their hard earned money in such unauthorised colonies and should contact the office of DTP for any enquiry before buying a land/plot.

Tuesday's demolition drive was carried out in Hayatpur and Sadrana, falling in the Gurgaon Urban Area under Sector 10A police station. District town planner (enforcement) Manish Yadav said, "The demolition drive has been carried out successfully at three locations. An unauthorised colony, having an area measuring approx 4 acres in Hayatpur village, wherein two structures, boundary wall and an entire road network were demolished. Two more such colonies, having an area measuring approx 4 acres in Sadrana village, wherein an entire road network was demolished. Three other colonies, spread over an area of 7 acres in Hayatpur village, wherein 25 structures along with boundary walls, entire road network were demolished." According to officials, the offenders are using the gaps and carving out illegal colonies on prime agricultural land in violation of Haryana Development and Regulation of Urban Areas Act, 1975. Section 7A of the Act states that the registration of sale deed of a plot having a size less than 1 acre is not allowed without a no-objection certificate (NOC) from the DTCP. Officials said the violation of the Act is a punishable offence with imprisonment up to 3 years, therefore, the department informed the police to stop the development of unauthorised colonies being done by the offenders and register FIR against them. In the last one month, eight demolition drives were carried out in Gurgaon, Sohna and Pataudi where illegal colonies were razed. The demolition team used earthmovers in presence of police force to raze more than 200 structures and seven farmhouses.

Before GRAP came into force in October 2023, DTCP had demolished around 50 illegal colonies spread over 550 acre prime land in and around the city. These colonies were situated in urban areas of Gurgaon, Sohna, Pataudi and Farrukhnagar.

Revamp soon for boosting stn to enhance water supply

Gurgaon: GMDA is planning to upgrade the Sector 16 boosting station in order to enhance water supply to a dozen tail-end areas such as Sikanderpur, Nathupur, Dundahera, Udyog Vihar, Surya Vihar, DLF-1, 2, 3 and 5. New pump chambers will be constructed and fresh machinery will be installed to cater to the increasing demand. The project has already received administrative approval in May last year.

A GMDA official informed that they have already prepared the estimate and invited bids to commission the project. The cost is coming up to Rs 11.3 crore.

"Four new pumps will also be added to improve the existing pumping capacity and overall efficiency of the boosting station. The existing pump-sets in working condition will be retained while the defunct pumps will be removed. A new electric panel room will also be built," a senior GMDA official said.

While the GMDA is intended to complete the tendering process within the next three months, the project will take around 12 months to complete. GMDA had last increased the capacity of this boosting station in 2018. Additionally, three separate water supply pipelines will also be laid from the boosting station to cater to three zones namely MG Road, Sushant Lok 1 and Udyog

Vihar to improve water supply. "We are also planning to lay additional pipelines and water will be supplied from boosting station to three different zones." the official added. At present, the city requires 650 million litres of water per day (MLD) of water, as against the actual supply of 570 MLD. The shortfall is met largely by private tankers.

Decide on 10% abadi land by Jan 10 or will ramp up protest: Farmers to Noida

Noida. The farmers protesting outside the Noida Authority office will give the state villages have been protesting government till January 10 to meet their demands for 10% abadi plots and compensation based on market rates during land acquisition for projects.

Till then, the farmers will withhold the next stage of protest they came up with on Tuesday, i.e., locking the Noida Authority office gate. The leaders said the plan changed as officials promised them that the industrial development commissioner in Lucknow would come up with solutions. Earlier, the farmers had refused to speak to the Noida Authority CEO, demanding solutions first. Farmers from more than 80 villages have been protesting outside the Noida Authority office for 22 days and called a maha panchayat last week to strengthen

"The officials met us on Tuesday and promised solutions for our demands through the industrial development commissioner in Lucknow. We have decided to give the Authority till January 10, after which we will further escalate our protests," said farmers' leader Sukhvir Khalifa.

Gurgaon. The district administration has written to the National Highways Authority of India (NHAI) to open Dwarka Expressway and its cloverleaf for traffic. Work on the city section of the expressway is nearly complete. Officials from the administration said they expected traffic to be allowed in a month.The administration has also asked NHAI to conduct safety audits of national highways passing through the city by an independent agency in view of recent cave-ins. Recently, roads caved in on Delhi-Mumbai Expressway near Subhash Chowk and on NH-8 at IFFCO Chowk

Deputy commissioner Nishant Yadav said the administration, through the state government, has written to NHAI requesting that the 18.9km portion of the expressway falling in the city be opened. "We have requested NHAI to at least open this section so that thousands of people living in new sectors get relief," said Yadav, adding that they are waiting for a reply from the highways authority. The delay in opening of Dwarka Expressway and its cloverleaf, which connects the high-

speed corridor with NH-8 and the Southern Peripheral Road (SPR), has been a matter of concern for years. Envisaged by the Haryana government in 2006, NHAI took up the project in 2016 and began construction in 2019, with an original deadline of two years. It has missed over a dozen deadlines since then. Though yet to be opened, many commuters have begun using the cloverleaf, as it provides easier access from new sectors to NH-8 and vice versa, as well as other parts of the city. The barricaded cloverleaf, as a result, sees high-speed traffic moving in both directions. Moreover, DC Yadav said in the past few months, a few incidents of cave-ins and damage to flyovers constructed over national highways have been reported in the city."We have brought these issues to the notice of NHAI officials at the highest level and expressed our concern. We have requested them to conduct a safety audit of all NHs passing through the city by an independent agency," said Yaday, adding that the audit will help in checking the structural integrity of the expressways and whether any

interventions are required. Making a list of projects that are expected to start or complete this year, the administration said work on the Gurgaon Metro is also expected to gain pace as the state government has already approved the formation of a metro corporation on the lines of Delhi's DMRC for the construction of the metro network in the city. "A notification in this regard is expected this month, which will lead to formation of the body which will initiate work on the corridor," Yaday and the Shortle Motion College said. he Sheetla Mata Medical College, two multi-level parking facilities at Kaman Sarai and Sadar Bazaar, the new district court complex, expansion of Civil Hospital and a new secretariat in Sohna are among the key projects expected to be complete in 2024.Two important roads expected to improve connectivity in rural areas within the city are also likely to be ready this year. The Gurgaon-Rewari road, which is being constructed by NHAI at a cost of Rs 900 crore, will link around 100 panchayats with Gurgaon and reduce travel time between Gurgaon and.

After reshuffle, MCG engineers get back charge of infra work

Gurgaon: The exit of PC Meena as the MCG commissioner has led to the engineering department of the civic body getting back its powers. After being sidelined as Meena had given additional charges of the MCG's engineering work to GMDA engineers, the outgoing commissioner ordered a reshuffle in the engineering department on Monday evening, giving back the powers to the corporation's executive engineers. However, residents said frequent reshuffling in the engineering department makes it difficult to keep track of officers responsible for their areas and colonies."The previous orders of engaging GMDA executive engineers had raised questions on the capability of MCG executive engineers. Moreover, it was hectic for the engineers to attend meetings at the GMDA office, then attend the field work and report back to the MCG office. We were managing the work earlier also and are capable of doing it. However, the shortage of engineers in the department is a concern that needs to be addressed. If all sanctioned posts of the engineering department are filled, our quality of work will improve since we are overburdened," said an MCG engineer. Nearly 55% of sanctioned posts in MCG are lying vacant. The most affected department, short on

Only 40% come up to clear power dues despite UIS

Noida. As the year came to an end, only 40% of the 1.6 lakh power consumers in the city who had defaulted on their electricity bill payments applied for the Uttar Pradesh Power Corporation Limited (UPPCL) one-time settlement (OTS) scheme to clear their dues. Officials said 65,098 applied for the scheme, including 2,500 on December 31."We had arrears of Rs 348 crore. Of that, we recovered Rs 81 crore under the OTS scheme till December 31," said Rajeev Mohan, chief engineer of Noida power department, Pashchimanchal Vidyut Vitran Nigam Limited (PVVNL). On Monday evening, Uttar Pradesh energy minister AK Sharma announced the extension of the OTS scheme till January 16 on X (formerly Twitter). "There was a public demand to extend the scheme as many people still want to avail its benefits. So, the minister extended the deadline to January 16," said Mohan, adding that the power department is yet to receive the government order in this regard. While a majority of the defaulters are from rural areas, technical snags on the UPPCL website, followed by a lack of awareness and consumer apathy, may have led to the low recovery. Division 2 superintendent engineer of Noida power department said only 950 people from his area applied for the scheme till December 31 and deposited at least Rs 5 crore. Sanjeev Kumar Vaishya, superintendent engineer of divisions 1, 5 and 7 in Noida, told TOI that only 400 consumers applied for the scheme, with an overall recovery of Rs 5 crore in dues. Ghaziabad, which has 3 lakh defaulters across three divisions, also stood the chance to benefit from the scheme. Rajeev Kumar Gupta,

sumers applied for the scheme from his division, which has 61,846 defaulters. The figures from the third division are still awaited. Ganesh Jatav from Aghapur village and Raj Singh from Sadullapur village said residents with outstanding dues lacked awareness about the scheme. Another resident

Man found dead at airport in Utah after climbing inside jet engine

Salt Lake Cit. A man was found dead inside an aeroplane engine on Monday in Salt Lake City International Airport in Utah in US after he breached an emergency exit door, walked onto the tarmac and climbed inside the jet's engine, said police.Officers found 30-year-old Kyler Efinger, of Park City, unconscious inside an engine mounted to the wing of a commercial aircraft loaded with passengers, the Salt Lake City Police Department announced on Tuesday. The plane had been sitting on a de-icing pad, and its engines were rotating. The manager of a store inside the airport had reported a disturbance just before 10 pm, telling dispatchers with the Airport Control Center that he saw a passenger pass through an emergency exit. Officers quickly found Efinger's clothing, shoes and other personal items on one of the runways. After locating him, the officers told air traffic controllers to notify the pilot to shut down the aircraft's engines. The specific stage of engine operation remains under investigation, police said Tuesday.

First responders pulled Efinger out of the engine intake cowling, which directs air flow to the engine fan. They attempted life-saving measures, performing CPR and administering naloxone, a fast-acting medication that can reverse opioid overdose and restore normal breathing. He was pronounced dead at the scene.

Salt Lake City police are working with the state medical examiner's office to determine the cause of death, which may include a toxicology report.

Passengers were removed from the plane when Efinger was found, but overall airport operations were not interrupted, police said. An initial investigation indicates the man accessed the airport's ramp area from the emergency exit and climbed inside the nearby engine.An airport spokesperson did not immediately respond to email and phone messages seeking comment.

US believes Hamas used Al Shifa Hospital but evacuated before Israeli operation: Report

Washington. US spy agencies assess that Islamist group Hamas and another Palestinian group fighting Israel used Gaza's Al Shifa Hospital to command forces and hold some hostages but largely evacuated the complex days before Israeli troops entered it, a US official said on Tuesday, citing declassified US intelligence.

The complex was used by both Hamas and Palestinian Islamic Jihad to command forces fighting against Israel, the US official said, speaking on condition of anonymity. US intelligence agencies have not disclosed the evidence on which they based their assessment. The official said the US had independently confirmed the information. Israel has also said that Al Shifa, which it had occupied earlier in the war in Gaza, had been used by Hamas. Israeli troops entered the hospital in November.

The targeting of the hospital had stoked global alarm over the fate of civilians and patients who were inside.

The World Health Organization last month described the emergency department in the enclave's main health facility as resembling a "bloodbath."

The American government believed that Hamas used the hospital complex and sites beneath it to carry out command and control activities, store some weapons and hold a few hostages, the US official said.

US intelligence agencies obtained information that Hamas fighters had largely evacuated the complex days before Israel's operation and destroyed documents and electronics as they left, according to the American official. The US intelligence assessment was reported first by The New York Times. A classified version of the assessment was sent to lawmakers in the US Congress.

Israeli tanks advanced on Gaza City's Al Shifa hospital, with some patients still inside, in mid-November. Israel said the hospital sat atop tunnels housing headquarters for Hamas fighters using patients as shields, which Hamas denied. The Israeli assessment was at least partially correct that some hostages were held at or under the complex, but those hostages appeared to have been moved as Hamas evacuated, The New York Times reported.In November, White House national security spokesperson John Kirby said Hamas militants were sheltering themselves in the hospital and using the facility as a shield against military action, placing patients and medical staff at risk.

We have our own intelligence that convinces us that Hamas was using Al Shifa as a command and control node, and most likely as well as a storage facility," Kirby said in November. Washington had at the time not declassified the sources of US intelligence.

Hamas' October 7 attack on Israel killed 1,200, according to Israeli tallies. Israel's subsequent assault on Hamasruled Gaza has killed over 22,000, according to Gaza

16-year-old UK girl virtually 'gangraped' in metaverse game, probe on

British Police are currently investigating a case where a girl's virtual reality (VR) avatar was allegedly gang-raped in a metaverse game, according to a report.The 16-year-old girl was using a Virtual Reality (VR) headset in an immersive game when her avatar was allegedly assaulted by avatars representing several men, the Daily Mail reported. While the victim did not experience physical harm, the emotional and psychological impact is being treated seriously by law enforcement, British officials said, as per the Daily Mail report.UK Home Secretary James Cleverly has voiced support for the investigation, stressing the significance of the psychological trauma inflicted upon the girl and warning against underestimating the seriousness of such virtual acts.

'I know it is easy to dismiss this as being not real, but the whole point of these virtual environments is they are incredibly immersive," he told LBC's "Nick Ferrari at Breakfast" program. "And we're talking about a child here, and a child who has gone through sexual trauma. It had a very significant psychological effect, and we should be very, very careful about being dismissive of this," he added

US polls: Potential Biden-Trump rematch could reshape nation's politics

Laconia U.S. presidential elections have been rocked in recent years by economic disaster, stunning gaffes, secret video and Depending on how Trump's appeals play a pandemic. But for all the tumult that defined those campaigns, the volatility surrounding this year's presidential contest has few modern parallels, posing profound challenges to the future of American democracy. Not since the Supreme Court effectively decided the 2000 campaign in favor of Republican George W. Bush has the judiciary been so intertwined with presidential politics.In the coming weeks, the high court is expected to weigh whether states can ban former President Donald Trump from the ballot for his role in leading the Jan. 6, 2021, insurrection at the U.S. Capitol. Meanwhile, a federal appeals court is weighing Trump's argument that he's immune from prosecution. The maneuvers are unfolding as prosecutors from New York to Washington and Atlanta move forward with 91 indictments across four criminal cases involving everything from Trump's part in the insurrection to his efforts to

overturn the 2020 election and his hush money paid to a porn actress.

out, he could be due in court as early as March 4, the day before Super Tuesday, raising the unprecedented prospect that he could close in on the GOP nomination from a courtroom.On the Democratic side, President Joe Biden is seeking reelection as the high inflation that defined much of his first term appears to be easing. "Everyone in the world knows, especially me, that this election is going to be really, really close."Implications for abortion, immigration and U.S. role in the worldThe results will have long-term implications on everything from the future of abortion rights and immigration policy to the role of the U.S. in the world. A Trump victory would raise the possibility of the U.S. largely abandoning Ukraine as it seeks to repel Russia's invasion. Domestic politics could also test Biden's commitment to Israel, a policy that threatens to erode his standing with young voters and people of color who are critical elements of his coalition. One of the few certainties at this

point is that Biden is a virtual lock to be the Democratic nominee again, facing only token opposition in this year's primary despite overwhelming concerns within his own party about his physical and mental fitness. And though a few rivals are fighting furiously to stop Trump, he is well positioned to win the GOP nomination for the third consecutive election. The strength of the GOP opposition to Trump will become more clear on Jan. 15 when the Iowa caucuses launch the nomination process. Trump holds a commanding lead in most national polls, although former U.N. ambassador Nikki Haley and Florida Gov. Ron DeSantis are fighting to stop him. That hasn't been easy, however, as DeSantis has struggled to connect with voters and has embraced culture war topics that often left him competing for the same base of support as Trump. And Haley's pitch as a more sensible, moderate candidate was threatened last week when she was pressed on the cause of the Civil War and didn't mention

Russian missiles hit Ukrainian cities, killing 5 and injuring more than 100, Kyiv officials say

KYIV. Ukraine's two largest cities came under attack Tuesday from Russian missiles that killed five people and injured more than 100, officials said, as the war approached its two-year mark and the Kremlin stepped up its winter bombardment of urban areas.he Ukrainian Interior Ministry said Tuesday evening that the attack killed five civilians and injured 127 as air defences downed Russian Kinzhal missiles that can fly at 10 times the speed of sound. The Kremlin's forces targeted Kyiv, the capital, and the northeastern Kharkiv region whose provincial capital is also called Kharkiv, authorities said.

There was some confusion over the death toll as Kharkiv Gov. Oleh Syniehubov initially reported one death there but later said the injured woman thought to have been killed was in a coma. He said 52 people were wounded in Kharkhiv.

Air defences shot down all 10 of the hypersonic missiles, out of about 100 of various types that were launched, Ukrainian Commander-in-Chief Gen. Valerii Zaluzhnyi claimed. It was the most Kinzhals used by Russia in one attack since the start of the war, Air Force spokesperson Yurii Ihnat said. The barrage extended Russian attacks



that began Friday with its largest single assault on Ukraine since the war started, as fighting along the 1,000-kilometer (620-mile) front line has subsided into grinding attrition amid winter. At least 41 civilians were killed since the weekend.At a nine-story Kyiv apartment building where two people were killed, 48-year-old Inna Luhina was getting ready for work when a blast shattered her windows and she and other family members, including her 80-year-old mother, were struck by flying glass.

More than 100 survivors gathered at a school set up as a temporary shelter.

Iryna Dzyhil, a 55-year-old resident of the same building, said the explosion threw her and her husband from their chairs, and a subsequent fire trapped them on the top floor until emergency crews rescued them via the roof.

'They say they're hitting military targets, but they're hitting people, killing our children and our loved ones," Dzyhil said of the Russians. Russia fired almost 100 missiles of

various types in the attacks, Zelenskyy said on X, formerly Twitter. He claimed at least 70 were shot down, almost all of them in the Kyiv area, noting that Westernsupplied air defence systems such

as Patriots and NASAMS had saved hundreds of lives.Russia's Defense Ministry said it had launched missile and drone strikes on military-industrial facilities in and around Kyiv. Depots storing missiles and munitions supplied by the West also were targeted, it said. The goal of the strike has been achieved, all the targets have been hit," it said without elaborating.It was not possible to independently verify either side's claims. Zelenskyy said that since Sunday, Russian forces have launched about 170 Shahed drones and dozens of missiles, with most aimed at civilian areas. The Kh-47M2 Kinzhal is an air-launched hypersonic ballistic missile. Russian forces rarely use such expensive missiles against Ukraine, due to their

Israeli forces are focused on Hamas but ready 'for any scenario': Military spokesman

TEL AVIV. Israel's military spokesman says the army remains focused on fighting Hamas after an explosion in Beirut that killed a senior leader of the Islamic militant group. The attack in Beirut, blamed on Israel, has raised concerns that Lebanon's Hezbollah group could strike back in revenge.Rear Adm. Daniel Hagari, speaking to media Tuesday, made no direct mention of the death of Hamas official Saleh Arouri."We are focused and remain focused on fighting against Hamas," he said. But he added, "We are on high readiness for any scenario."

Other updates

An apparent Israeli strike in the Lebanese capital of Beirut killed Hamas' second-highest ranking political leader Tuesday, marking a potential escalation of Israel's war against the militant group and heightening the risk of a wider Middle East conflict.Saleh Arouri, who was the most senior Hamas figure killed since the war with Israel began, was also a founder of the group's military wing. His death could provoke major retaliation by Lebanon's powerful Hezbollah militia. The strike hit an apartment in a building in a Shiite district of Beirut that is a Hezbollah stronghold, and Hezbollah leader Sayyed Hassan Nasrallah has vowed to strike back against any Israeli targeting of Palestinian officials in Lebanon. Hezbollah and the Israeli military have been exchanging fire almost daily over the Israeli-Lebanese border since Israel's military campaign in Gaza began nearly three months ago. But so far the Lebanese group has appeared reluctant to dramatically escalate the fighting. A significant response now could send the conflict spiraling into all-out war on Israel's northern border.Israeli officials declined to comment. the strike was carried out by an Israeli drone.

The killing comes ahead of a visit to the region by U.S. Secretary of State Antony Blinken, even as the United States has tried to prevent a spread of the conflict, repeatedly warning Hezbollah and its regional supporter, Iran — not to escalate the violence.Israeli Prime Minister Benjamin Netanyahu has vowed to press ahead with the assault in Gaza until Hamas is crushed and the more than 100 hostages still held by the militant group in Gaza are freed, which he has said could take several more months. At the same time, Israeli officials have increasingly warned in recent days of stepped-up action against Hezbollah unless its cross-border fire stops.

Netanyahu and other Israeli officials have repeatedly threatened to kill Hamas leaders wherever they are.

Pakistan: Balochistan government suspends 44 employees for participating, facilitating protest sit-in against killing of Balaach Bakhsh

ISLAMABAD. Amid the ongoing Baloch protest in Islamabad, the Balochistan government has suspended 44 government employees in Turbat and Kohlu, including some officers, for allegedly participating in and facilitating a protest sit-in and rally against the alleged killing of Balaach Mola Bakhsh, Pakistan-based Dawn reported. The commissioner of Makran Division has issued an official notification confirming the action against 30 government employees from various departments in Turbat. According to the officials, the decision was taken during a recent meeting of the district intelligence coordination committee.During the meeting, these officers were identified as providing support to to the participants of the anti-government sit-in and protest rally, according to Dawn report. According to the notification, based on the recommendations of the meeting, the commissioner has suspended 30 employees from grade 1 to 15 and disciplinary action has been initiated against officials of grade 16 and above through letters to the secretaries of concerned departments.In addition, 14 government employees in the Kohlu district were suspended for participating in the sit-in and supporting the long march participants when it reached Kohlu in December, Dawn reported. According to the notification, the action against these government employees were taken under the Balochistan Employees Efficiency and Discipline (BEEDA) Act, 2011, Dawn reported. Most of the employees against whom disciplinary action has been initiated belong to the education department, serving as teachers in various schools Notably the long march started in Turbat after the extra judicial killing of Balaach Baloch with other three in a fake encounter of Counter Terrorism Department (CTD). The authorities handed over the bodies to the families. However, Balaach's family did not accept the body and took the body to Shaheed Fida Chowk for protests, The Friday Times reported.Balaach's family requested that the city police to accept their FIR. However, the police refused to register the FIR. Then, the protestors increased and they took the protest to different areas of Turbat to let the residents join the protest, The Friday Times reported.

Harvard president Claudine Gay resigns amid plagiarism claims

Cambridge, Massachusetts Harvard University President Claudine Gay resigned on Tuesday amid plagiarism accusations and criticism over testimony at a congressional hearing where she was unable to say unequivocally that calls on campus for the genocide of Jews would violate the school's conduct policy. Gay is the second Ivy League president to resign in the past month following the congressional testimony — Liz Magill, president of the University of Pennsylvania, resigned December 9.Gay, Harvard's first Black president, announced her departure just months into her tenure in a letter to the Harvard community. Following the congressional hearing, Gay's academic career came under intense scrutiny by conservative activists who unearthed several instances of alleged plagiarism in her 1997 doctoral dissertation. The Harvard Corporation, Harvard's governing board, initially rallied behind Gay, saying a review of her scholarly work turned up "a few instances of inadequate citation" but no evidence of research misconduct. Days later, the Harvard Corporation said it found two additional examples of "duplicative language without appropriate attribution." The board said Gay would update her dissertation and request corrections. The Harvard Corporation said the resignation came "with great sadness" and thanked Gay for her "deep and unwavering commitment to Harvard and to the pursuit of academic

excellence." Alan M. Garber, provost and chief academic officer, will serve as interim president until Harvard finds a replacement, the board said in a statement. Garber, an economist and physician, has served as provost for 12 years.Gay's resignation was celebrated by the conservatives who put her alleged plagiarism in the national spotlight with additional plagiarism accusations surfacing as recently as Monday in The Washington Free Beacon, a conservative publication. Christopher Rufo, an activist who has helped rally the GOP against higher education, said he's "glad she's gone.""Rather than take responsibility for minimising antisemitism, committing serial plagiarism, intimidating the free press, and damaging the institution, she calls her critics racist," Rufo said on X, formerly Twitter. "This is the poison" of diversity, equity and inclusion ideology, said Rufo, who has led conservative attacks on DEI both in business and in education.Gay, in her letter, said it has been "distressing to have doubt cast on my commitment to confronting hate and to upholding scholarly rigour — two bedrock values that are fundamental to who I am — and frightening to be subjected to personal attacks and threats fueled by racial animus."But Gay, who is returning to the school's faculty, added "it has become clear that it is in the best interests of Harvard for me to resign so that our community can navigate this moment of extraordinary challenge."Yoel



Zimmermann, a visiting research undergrad from Munich, Germany, studying physics at Harvard, said that as a Jewish student he's noticed fellow members of the Jewish community have felt uncomfortable with the climate on campus."I think it was about time that Claudine Gay resigned," Zimmerman said. "She just did too many things wrong, especially with her testimony in Congress. I think that was just the kind of final tipping point that should have led to her removal immediately."Supporters of Gay lamented her resignation."Racist mobs won't stop until they topple all Black people from positions of power and influence who are not reinforcing the structure of racism," award-winning author Ibram X. Kendi, who survived scrutiny of an antiracist research center he founded at Boston University, said in an Instagram post. The Rev. Al Sharpton in a statement called pressure for Gay to resign "an attack on every Black woman in this country who's put a crack in the

glass ceiling" and an "assault on the health, strength, and future of diversity, equity, and inclusion." Critics welcomed her decision. House Committee on Education and the Workforce Chairwoman Rep. Virginia Foxx called Gay's resignation welcome news but said the problems at Harvard are much larger than one leader. Passengers from Gujarat agreed to pay Rs 60-80 lakh to enter US illegally'

AHMEDABAD. More than 60 people from Gujarat on board the Nicaragua-bound plane, which was sent back from France over suspected human trafficking, had agreed to pay Rs 60 lakh to Rs 80 lakh to immigration agents, who promised to cross into the US illegally after reaching the Latin American country, officials said.

According to a senior state Crime Investigation Department (CID)-Crime and Railways official, those passengers included 66 from Gujarat, who have already reached their respective native places in the state.uperintendent of police, CID- Crime and Railways, Sanjay Kharat, who is investigating the case, said these 66 Gujarat natives, including some minors, were mainly from Mehsana, Ahmedabad, Gandhinagar and Anand districts."We have already questioned 55 of them and recorded their statements. Majority of them have studied till Class 8 to 12. Each of them admitted that they had agreed to pay Rs 60 lakh to Rs 80 lakh to the local immigration agents to help them cross into the US illegally after reaching Nicaragua via Dubai," he said.he state CID has so far acquired the names and contact numbers of nearly 15 agents, who had promised to help these 55 persons enter the US illegally."These agents had asked these 55 persons to pay the money only after reaching the US. The agents had told the passengers that their men would take them to the US border from Nicaragua and then help them cross the border. It was also revealed that the agents had also booked air tickets for these passengers and gave USD 1,000 to 3,000 to each passenger to deal with any emergency situation," Kharat said.

Coimbatore corporation seized 12 tonnes of banned plastic items in 2023

COIMBATORE. The Coimbatore City Municipal Corporation (CCMC) has seized around 12 tonnes of banned plastic items and collected around Rs 25 lakh as fine from shopkeepers in 2023. However, social activists said this was not enough and more needs to be done to ensure the ban on singleuse plastics. On January1, 2019, the state banned use of 14 plastic items including single-use bags and covers, but their use has been continuing. Traders cite the lack of alternative packing material and the high cost of biodegradable alternatives. A CCMC official told TNIE, "A total of 14,151 shops were raided last year and a total of 10,957 kg of banned single-use plastic items were seized. A fine amount of Rs 24,57,500 has been collected from the violators. Out of the five zones in the city, the Central Zone collected the highest amount of fine of Rs 3.85 lakh and the East Zone collected the lowest with Rs 98,300."However, social activists demanded the officials to impose hefty fines and initiate criminal proceedings against those using the plastic items. They alleged that CCMC is taking action against small traders and ignored the big fish.

CCMC Commissioner M Sivaguru Prabakaran told TNIE, "We have been constantly conducting surprise inspections over the banned plastic items in the city. Currently, we are collecting the fine amount based on the state government's guidelines, so we don't have any plans to increase them now. Also, in order to reduce the curb the usage of banned plastic items, we have to identify its source and have deployed teams to monitor the incoming of those items into the city.

Gujarat: Cardiac crisis at record high, EMRI got 1 call every 7.5 minutes in 2023

AHMEDABAD. Year 2023, marked by eerily high prevalence of sudden deaths due Dr Chirag Doshi, director of the UN Mehta to cardiac arrests, had people's hearts in their mouths. EMRI 108 data reveals Gujarat witnessed record high cardiac emergencies in their 16-year operations in the state responding to one heart crisis call every seven and half miniutes.ardiac crisisEMRI 108 recorded 72,573 cardiac emergencies in 2023 which is a massive 35% higher compared to 53,700 in 2018. Even if one considers factors such as rise in population, the state registered 29% rise in cardiac emergencies on a year-on-year basis compared to 2022 that recorded 56,277 cases. When the data is extrapolated on the district-wise 2011 Census figures to understand prevalence of the cardiac emergency calls, Ahmedabad emerged at the top with 298 calls per 1 lakh population (21,496 calls), followed by 199 calls in Porbandar (1,167 calls), and 180 calls in Jamnagar and Devbhoomi Dwarka (1,981 calls). Major city-based hospitals specializing in cardiovascular diseases confirmed the trend. Tribal districts too recorded higher prevalence: EMRI dataMajor city-based hospitals specializing in cardiovascular diseases confirmed the trend and acknowledged rise in sudden deaths often spurred the citizens to be more conscious of the uneasiness they felt or

opted for preventive checks.

Institute of Cardiology and Research Centre (UNMICRC), said that cardiovascular diseases are on the rise globally due to lifestyle choices and other

"For example, when we talk about relatively higher prevalence in Saurashtra region, consumption of tobacco could be a major risk factor. Right from food to sedentary lifestyle, we see several factors that often prompt onset of cardiovascular diseases relatively early," he said. While state education minister Kuber Dindor had claimed in December that about 1,000 persons died due to cardiac arrests in Gujarat in six months, health minister Rushikesh Patel had later said that the state government does not have such data.

Hundreds of videos on social media however indicated the nature of sudden deaths where the persons did not get time to even get basic intervention. Several of these persons were below 30 years of age.Even tribal districts of Dang (159 calls per 1 lakh population) and Tapi (156 calls per 1 lakh population) have recorded relatively higher prevalence, pointed the data. Cardiac related emergencies were the sixth highest after pregnancy, vehicular accidents,

Bengaluru airport among top 3 most punctual in world

MUMBAI. Travellers who flew to or from between five to 30 minutes, depending on Hyderabad or Bengaluru airports last year would have experienced on-time performance that is among the best in the world. Hyderabad and Bengaluru airports

have bagged the second and third rank respectively for on-time performance in 2023 in the 'global airports' category, according to rankings released by aviation analytics firm Cirium on Tuesday.

A flight is said to be on-time if it arrives or departs within 15 minutes of the scheduled time. On-time performance (OTP) is a valuable metric of reliability, with OTP arrivals used to rank airlines and OTP departures used to rank

airports. Cirium said it uses 'Gate Arrival' to measure the OTP of airlines and airports. The difference between runway and gate arrival times can be anywhere minutes of scheduled arrival or departure,

the taxi track network of the airport and the congestion on ground. The global topper was Minneapolis' St Paul International Airport in the US, with an OTP of



84.44%. While Hyderabad's Rajiv Gandhi International Airport had 84.42% flights arrive or depart on time or within 15

Bengaluru's Kempegowda International Airport, too, came close at 84.08%. "Hyderabad airport's OTP hasn't increased year-on-year. It actually decreased by 1 percentage point in 2023 compared to

2022. However the usual winners, Japanese airports, lost ground or declined significantly in OTP in 2023," said a Cirium spokesperson. The only other Indian airport to feature in the top ten on-time performance list was Kolkata's Netaji Subhash Chandra airport, which was ranked ninth, but in the 'medium airports' category, which is based on passenger volumes handed. Both Hyderabad and Bengaluru fall in the large airports category. While none of the

Indian carriers featured in the top ten list of 'global airlines' for OTP, IndiĜo secured the eighth rank in the low-cost carriers category, with 82.12% flights on time.

Anti-drug declaration a must for admission to higher educational institutions now

BHUBANESWAR. Like an anti-ragging affidavit, students will now have to submit an anti-drug declaration during their admissions at all higher educational institutions (HEIs) in the state. The institutions - public universities, government and non-government aided colleges (both technical and general) - cannot give admissions without acquiring these affidavits from the students. This was informed by the Higher Education department to the institutions on Tuesday. The move is being implemented under the Ministry of Social Justice and Empowerment's Nasha Mukta Bharat Abhiyaan amidst growing concerns about students slipping into drug abuse across the country.

The declaration prohibits the students from carrying, selling and consuming not just drugs but also tobacco products and alcohol within their campuses. Besides, students are expected to report to the HEI authorities of any instances of drug/alcohol/tobacco consumption and sale by any student or staff on the premises or nearby.

The HEIs, on their part, have been directed to sensitise students on substance use prevention regularly through their faculty members, NSS



volunteers and student clubs. The institutions may create common clubs with various activities related to ragging prevention and non-use of substances.nder Nasha Mukta Bharat Abhiyaan programme, the departments of Higher Education, SSEPD and Health coordinate with the ministry for all aspects of drug abuse prevention, preventive measures, treatment and rehabilitation of drug users and creating public awareness on the issue. Around 5,263 youths in 50 HEIs have so far been covered under the programme in the state. The state government, on its part, is currently implementing the Navchetana programme under the National Action Plan for Drug Demand Reduction (launched last year) in 10 districts to reduce adverse consequences of drug abuse in adolescent students. As part of the programme, 10 schools in each of the 10 identified districts are being taken up with a focus on providing education and awareness on drug abuse among school-going children in the age group of 11-18 years.

Two lakh acres of forest land encroached in Karnataka: Minister

BENGALURU. Forest, Environment and Ecology Minister Eshwar Khandre on Tuesday said that two lakh acres of forest land have been encroached in the state, most of them in Shivamogga and Uttara Kannada districts.At a closed-door meeting with officials on Tuesday, Khandre directed them to clear the encroachments at the earliest on a priority basis. He said there are Central and state

government lands for forest conservation, yet it is shocking to note that there is encroachment happening. "Encroaching forest land is a crime and cases should be booked against encroachers. The first priority in clearing encroachments should be in areas around Bengaluru, especially in Kothanur, where forest land worth Rs 400 crore was encroached and converted to revenue land



by the revenue department's subdivisional officer and Tahsildar," he said, adding that while a case has been booked, the land is et to be recovered. He added that increasing encroachment was also one of the reasons for the rise in mananimal conflict.In the last three months, around 2,000 acres of encroachments have been cleared, but more needs to be done. Khandre pointed out that there are

around 13,155 cases involving 31,864 acres of land. Of this, in 7,000 cases, land was granted. The nodal officers have been directed to check and dispose of the cases at the earliest. He also told the forest officials not to harrass farmers who had encroached up to three acres of forest land before the 1980s, but instead to first target the bigger encroachers. He told the officials to prepare a list of encroachments --- districtwise, sector-wise, division-

wise and circle-wise. Based on the details, the next course of action will be decided. Meanwhile, Khandre said that on getting cabinet approval, the forest department will open a three-month window for people possessing wildlife articles to surrender them. He added that a discussion has been held with the law

Rice procurement still a challenge for Siddaramaiah govt

BENGALURU. The Siddaramaiah government's pride 'Nudidante Nadeda Sarkara' has not materialised for the rice distribution guarantee, thanks to a number of challenges in procurement, and other circumstances. Chief Minister Siddaramaiah, who has been a stickler for fulfilling poll promises made by the Congress, has had to rely on cash payout instead of rice.

The Karnataka government had been working hard for about seven months to procure rice to fulfil its Anna Bhagya poll promise of 5kg rice per head, but a drop in output for the period ending December 31 has resulted in a 48lakh tonne shortfall of rice across the nation. With the market price of rice remaining high, the state may not be able to procure the required quantity for its PDS scheme and be content to dole out cash. V Prasad, former chairman, Food Corporation of India (FCI), Food and Civil Supplies Minister K H quoted statistics and explained to Muniyappa tried several options, with a shortfall in rice surplus states.

In Chhattisgarh, there was a drop from 51.6 lakh tonne to 38.5 lakh tonne, Telangana saw a drop from 37 lakh tonne to 27 lakh tonne. In Uttar Pradesh, procurement dropped from 27 lakh tonne to 23 lakh tonne, and in Madhya Pradesh, from 20.5 lakh tonne to 11.6 lakh tonne. The overall shortfall is about 48 lakh tonne, so it

A battle to win hearts and minds in J&K

NEW DELHI deserves credit for acting with despatch in handling the recent incidents in the Poonch-Rajouri area. Four jawans were killed in an ambush on December 21; a day later, three civilians, picked up for interrogation along with others, died in custody, allegedly after being tortured. The Army Chief, Gen Manoj Pande, and Union Defence Minister Rajnath Singh visited the area within days of the civilian deaths. Neither of them addressed the brutality directly, but both sent a clear message to the Army against the recurrence of such incidents.

No doubt, the situation was an extremely difficult one for the Army. Three of the four jawans killed had been apparently decapitated. This was almost certainly aimed at instigating the kind of reaction that unfortunately did take place. The long-drawn insurgency is testing the nerves of the Army.

News reports suggest that it was New Delhi's intervention that led to the J&K police filing a case on the basis of a 29-second video clip shot in an Army camp, purportedly showing the torture. The media's role here was not particularly glorious. Most news reports spoke of three civilians being "found dead" in Bafliaz village of Poonch. Some even spoke of a 'mystery' surrounding the deaths. Since the three had been picked up by the Army a day earlier, it would not have taken a genius to realise that these were custodial deaths. What was striking was the political reaction. On December 27, the Defence Minister landed in Rajouri and exhorted the forces to "not only safeguard national interests but also win the hearts of the people." He said there should be "zero tolerance for violations of the well-established standard operating procedures."The minister met the families of the dead civilians and assured them of an "expeditious investigation into the incident, culminating in the delivery of justice."Two days later, BJP leaders, including state party president Ravinder Raina and local MP Gulam Ali Khatana, who is a Gujjar, also visited the families. They sought strict punishment for the guilty, whom they said had committed "a major crime."

Those killed were from the Gujjar and Bakarwal communities, which have largely worked with government agencies in the counter-insurgency (CI) campaign. Their support is an important element of the BJP's electoral plans in Jammu & Kashmir.The government has been suggesting that militancy in the state-turned-UT is almost over. This is not true. Given the level of security in the Kashmir valley, militancy has shifted its weight to the Pir Panjal region adjacent to Pakistan-occupied Kashmir (PoK). Thirty-six soldiers and seven civilians have been killed in the region since October 2021.

Israeli military historian Martin van Creveld has said that there are two ways to fight an insurgency. First, a sledgehammer approach, such as the one adopted by Hafiz al-Assad when he crushed the Muslim Brotherhood uprising in the city of Hama in Syria in 1982. Assad simply levelled the city with artillery and tanks, killing tens of thousands of people. The second method is the one in which the British dealt with the Irish Republican Army (IRA) insurgency beginning in the late 1960s. There were regular shootings and killings and the IRA bombing campaign even expanded to the UK. They assassinated Lord Mountbatten and blew up the hotel where then Prime Minister Margaret Thatcher was to speak; they even attacked 10, Downing Street.

According to van Creveld, the British exercised "extreme self-control". They avoided firing at crowds and desisted from collective punishment within the boundaries of the law and refrained from arbitrary torture and killings. There were violations of this code of conduct, but they were kept to a minimum. The result has been a lasting victory for the British. Actually, van Creveld's typology could well be applied to the Israeli Defence Forces, which is adopting the Assad style in Gaza by using some of the heaviest weapons in its arsenal. Remember that the Assad strategy, applied to the civil unrest that broke out in 2011, led to the whole of Syria coming apart.

Prudent lending is crucial to rein in wilful defaulters

India should improve debt recovery instead of writing off large corporate bad loans. It is imperative to implement modifications in bank credit framework.

MINISTER of State (Finance) Bhagwat Karad told the Lok Sabha last month that as on March 31, 2023, there were 2,623 borrowers in India who had been officially categorised as wilful defaulters. These borrowers collectively owe Rs 1,96,049 crore to banks across the country. Karad stated that Scheduled Commercial Banks (SCBs) and all-India financial institutions were required to submit credit information for all borrowers with a total exposure of Rs 5 crore or above to the Central Repository of Information on Large Credits.

According to data of the Reserve Bank of India (RBI), banks have written off a staggering amount of over Rs 15 lakh crore since the 2012-13 financial year. A bank writes off a loan when the borrower has defaulted on the repayment and the likelihood of recovery is extremely low. The bank then removes the non-performing asset (NPA) from the assets section and records the amount as a loss. Éxperts frown on this practice, but banks routinely do it as part of their tax management clean-up process. The beneficiaries are almost always some of our most egregious industrialist defaulters. After a loan has been written off, banks are required to continue pursuing various options to recover it. However, according to the RBI, banks recovered only Rs 1,09,186 crore (18.6 per cent) out of Rs 5,86,891 crore in loan write-offs in the past three years. Everyone in the nation is impacted by the excessive loss to the banks because the money deposited there belongs to the country's citizens. According to RBI data, NPA write-offs in SCBs (including wilful defaulters) were to the tune of Rs 63,000 crore between FY2005 and FY2014, but they skyrocketed to Rs 12.3 lakh crore between FY2015 and FY2022. The increase is largely attributed to then UPA government's overzealous loan sanctioning and evergreening policies. Banks and businesses often use restructuring as a way to keep reporting their NPAs at low levels. Evergreening loans is the practice of giving more loans to a borrower who is about to stop paying so that the loan stays on the books as being paid.Between 2000 and 2014, companies could choose more flexible ways to restructure loans, which led to many of them getting new loans from banks to keep their loan portfolios going. Even though the bankruptcy code has made it harder to keep a business going forever, the rate of recovery is still very low. According to a reply made in the Rajya Sabha (March 28, 2023), the recovery of NPAs that had been written off was only 16.6 per cent from FY18 to FY22. The quantum of banking frauds has increased 17 times — from Rs 34,993 crore (2005-14) to Rs 5.89 lakh crore during 2015-23. According to the RBI's Financial Stability Report, which came out on June 28, 2023, the SCBs' gross non-performing assets ratio continued its downtrend and fell to a 10-year low of 3.9 per cent in March 2023. It should be noted that if the amount of write-off is included, the total NPAs would rise to 7.47 per cent, whereas banks are currently reporting 3.9 per cent. According to the report, "Write-offs by public sector banks increased from Rs 7,187 crore in 2013 to Rs 1,19,713 crore in 2022." The SBI has written



off the most money among these public sector banks in the past 10 years, amounting to Rs 2,97,196 crore, followed by PNB (Rs 92,511 crore), Bank of Baroda (Rs 75,429 crore) and Bank of India (Rs 53,961 crore). For private banks, the aggregate amount of write-offs rose from Rs 4,115.02 crore in 2013 to Rs 53,087.03 crore in March 2022.In FY21-22, the total write-offs by public and private sector banks totalled Rs 1,72,800 crore, far exceeding the amount allocated to any of the three key social sectors, namely rural employment (MGNREGA), health or education in FY23-24. The NDA government has so far given Rs 2.76 lakh crore for the recapitalisation of public sector banks.In India, deliberate defaults are characterised by insufficient assessment conducted prior to loan approval and a deficiency in monitoring. Banks experience a decrease in their net interest margin due to high NPAs, and at the same time, their operating costs steadily increase. In order to offset these expenses, banks increase the convenience fee imposed on their smaller clientele. The frauds in the banking industry can be divided into four categories — 'management', 'outsider', 'insider', and 'insider and outsider' (jointly). Operational errors are the root cause of fraudulent activities, regardless of whether they originate from within the organisation or externally. Deloitte's research indicates that inadequate examination prior to disbursing funds (21 per cent) and restricted supervision of assets following disbursement (38 per cent) were the primary factors contributing to stressed assets and NPAs, respectively.

Prudent lending is crucial for banks as it helps mitigate the risk of NPAs caused by bad loans. Regulation of chartered accountants is necessary to curb the occurrence of bank NPAs. Banks should exercise caution when lending to Indian enterprises with significant overseas loans. The internal and external audit mechanisms of banks require immediate enhancement. Senior officers are responsible for making judgments about the credit sanctioning committee, whereas lower officers frequently face culpability for instances of default. Therefore, it is imperative that senior officers are held responsible. Public sector banks should establish an internal rating agency to rigorously evaluate large projects before lending. To monitor a business project's early warning signals, a good MIS (Management Information System) is needed. RBI needs human and technical resources to supervise forensic audits. AImonitored financial transactions can greatly reduce financial fraud. Digitisation beyond a certain point may be misguided because artificial intelligence only considers quantitative data. The branch's inputs on the borrowers' background and other ground realities are crucial to risk assessment. India should improve debt recovery instead of writing off large corporate bad loans. It is imperative to implement significant modifications in the bank credit framework, encompassing reforms that extend from the branches to the very core of the system. It is important to draw lessons from Islamic banking, where the bank does not provide loans but rather purchases the necessary assets on behalf of the borrower who is prepared to acquire them. In this scenario, the meal is directly provided to the 'beggar' to prevent him/her from using the alms wastefully.

ISRO begins year with another cosmic exploration


HAVING conquered the moon in 2023 with its historic Chandrayaan-3 mission, the Indian Space Research Organisation (ISRO) has begun the new year with another exciting journey into space with the successful launch of its PSLV-C58 rocket, which is carrying 11 satellites. Thanks to meticulous planning, the PSLV deployed the X-ray Polarimeter Satellite (XPoSat) into orbit 21 minutes later. Once again, wondrously, the XPoSat has cost a mere \$30 million (Rs 250 crore) as against the \$188-million NASA IXPE mission, which is on a similar foray in space since 2021. In addition, XPoSat's expected lifespan is five years as compared to the two years that its US counterpart has. However, this feat is nothing new for ISRO; the organisation has time and again stunned the world by its ability to make quality rockets and satellites on shoestring budgets. This costeffectiveness can be a game-changer as India gingerly opens the space domain to the private sector. The business of satellite-building has skyrocketed, with many domestic startups showing huge potential as they forge tie-ups with foreign companies. There is merit in ISRO Chief S Somanath's recommendation that regulations in the sector be eased so as to enable growth in space science development and eventually make India a hub of satellitemanufacturing



Take pre-emptive action to curb terror ambushes

The perpetrators invariably enjoy local support. Without such assistance, it would not be possible for the terrorists to execute an ambush.

INDIA has been a victim of terror attacks in Jammu and Kashmir over the past more than three decades. It is well known that the perpetrators are trained, funded and armed by the Pakistan army. There are also reports of terrorists and infiltrators carrying Chinese weapons; the collusion between the two 'all-weather friends' is no surprise.Of late, the thrust of these attacks has shifted from the Kashmir valley to the thickly forested southern slopes of the Pir Panjal range. These attacks continue unabated. Apart from the loss of precious lives, the frequency of these attacks creates doubt, at least in the minds of the uninformed, about the level of preparedness and efficacy of the drills and procedures adopted by the security forces. This has a negative effect on the morale of the security personnel. A ceasefire has been in place between India and Pakistan since 2003. Its observance was reiterated on February 22, 2021, during discussions over the established hotline between the directors general of military operations of the two armies. It was reported: "In a first joint statement issued by the two sides in years, India and Pakistan said they have agreed to a 'strict observance of all agreements and understandings and cease firing along the Line of Control (LoC) and all other sectors' with effect from the midnight of February 24/25." But the ground reality is different. It is empirically seen that the ceasefire is adhered to only by India. The existing situation ideally suits the Pakistan army in continuing its proxy war practically on a no-cost basis — without fear of retaliation. Even in the latest ambush that took place in the Rajouri-Poonch area on December 21, 2023, in which we lost four soldiers, the responsibility has been claimed by the little-known People's Anti-Fascist Front, which is reportedly linked to Pakistan-based terror group Jaish-e-Mohammed. It should be assumed that the Pakistani post nearest to the ambush site would have facilitated their infiltration. There is a case for subjecting such posts to appropriate deterrent punishment. Unilateral observance of the ceasefire is



proving to be counter-productive.

The perpetrators invariably enjoy local support. There is no doubt that some residents would be helping the terrorists in hiding and sneaking away subsequently. Without such support, it would not be possible for the terrorists to execute an ambush. It would, however, be wrong to suspect a whole village or community. Such support is sporadic and obtained invariably through threat and coercion. While there is no foolproof system when dealing with jihadis who come determined to kill or die, we can minimise risks and losses. Our forces are

deployed to guard the long Line of Control over rough mountainous terrain. The movement of vehicles has to imperatively take place. Though a minimum number of vehicles in a convoy and their spacing are specified, these norms get violated at times.

A vehicle column is the easiest and most vulnerable target for ambushes in the mountains. It is road-bound and visible from a distance. This enables the terrorists to predict its time of arrival and occupy their ambush positions at the last minute, thus minimising the chances of detection. The confined space inside the vehicle also

restricts speedy use of weapons. The many vulnerable sites along the route, which make an ambush easier, can be identified. The site is invariably in a concave loop where members of a group of terrorists can remain in visible contact and in mutual support. The site chosen is also on an ascending slope, where the speed of vehicles is slower. Besides, the site has to have enough foliage or folds in the ground for the terrorists to hide as well as to facilitate their getaway into the forested areas. There is a case for acquisition of land of a 50-metre swathe along the road at these vulnerable sites. These can then be cleared of foliage to make it difficult for the perpetrators to hide. The road-opening parties should also focus on these sites instead of trying to cover the entire stretch of the road, which is not practical. The vehicles used in these areas need bullet-proofing. This not only reduces the speed of movement but also curtails the life of engines; both outcomes should be acceptable. The leading vehicle in each convoy must have armour plating and a periscopic infrared camera that can detect people hidden in the bushes. Drones can also be fitted with these cameras and used to reconnoitre routes ahead of the convoys. The Army has been involved in tackling irregular warfare since Independence; it is arguably the most experienced army in the world in this regard today. The number of attacks on its columns might indicate lacunae in its tactics and adherence to SOPs (standard operating procedures). But the reality is that of all the attempted ambushes, nearly 90 per cent get aborted because of a high level of alertness of our troops. These failed attempts do not become public, leading to an incorrect negative impression of the security forces

level of preparedness. The unfortunate death of three civilians, allegedly during interrogation by the Army, must be investigated thoroughly and the guilty punished speedily to instil confidence in the public. Anger management is part of the training of troops deployed in such scenarios. Its violation must not be tolerated.

Delhi Police Form Panel To Study New Criminal Laws, Prepare Course Material

Although the Ministry of Home Affairs is yet to issue an official notification regarding the effective date of the bills, the Delhi **Police Commissioner has** constituted a committee of 13 officers, under chairmanship of IPS officer Chhaya Sharma.

New Delhi. The Delhi Police has set up a committee of high-ranking officers to study the three new criminal law bills recently passed by Parliament. The Bharatiya Nyaya (Second) Sanhita, 2023, Bharatiya Nagarik

Bharatiya Sakshya (Second) Bill, 2023, intend to replace the colonial-era IPC, CrPC, and Indian Evidence Act. These bills received President Droupadi Murmu's assent on December 25 during the winter session of Parliament. Although the Ministry of Home Affairs is yet to issue an official notification regarding the effective date of the bills, the Delhi Police Commissioner has constituted a committee of 13 officers, under chairmanship of IPS officer Chhaya Sharma. The committee is tasked with preparing course material for Investigating Officers to gain a practical understanding and study the new provisions and changes in procedures.

India To Scrap Free **Movement Regime** On India-Myanmar **Border: Report**

New Delhi. The Free Movement Regime (FMR), which allows people residing close to the India-Myanmar border to venture 16 km into each other's territory without visa, will be ended soon, a senior government functionary said on Tuesday. The 1,643-km-long India-Myanmar border, which passes through Mizoram, Manipur, Nagaland and Arunachal Pradesh, currently has FMR. It was implemented in 2018 as part of India's Act East policy. Under the FMR, every member of the hill tribes, who is either a citizen of India or a citizen of Myanmar and who is resident of any area within 16 km on either side of border can cross over on production of a border pass with one year validity and can stay up to two weeks per visit.

We are going to end the FMR along the Indo-Myanmar border soon. We are going to put fencing along the entire border. The fencing will be completed in next four-and-a-half years. Anyone coming through will have to...get a visa," the functionary said.he idea is to not only to stop the misuse of FMR, which is used by insurgent groups to carry out attacks on Indian side and flee towards Myanmar, but also put a halt to influx of illegal immigrants, and paralyse drugs and gold smuggling networks.

Tendering for an advanced smart fencing system for 300 km of the India-Myanmar border is already in pipeline and the work will be started very soon. It may be mentioned that Manipur Chief Minister N Biren Singh had urged the Centre in September 2023 to end the FMR. The state government has argued that insurgents



use the free movement regime to further their activities. Manipur shares around 390 km of porous border with Myanmar and only about 10 km has been fenced so far. In July last year, the state government shared data that around 700 illegal immigrants entered the state. Besides, Mizoram has seen an influx of anti-Junta rebels in thousands since the military coup in Myanmar on February 1, 2021. According to government estimates, several thousand refugees are living in different parts of Mizoram since the coup.Mizoram shares a 510-km-long porous border with Myanmar. The Manipur chief minister had also said that several persons from Myanmar tried to enter into his state but returned on seeing the presence of a large number of security personnel. Manipur shares a 398-km border with Myanmar. Arunachal Pradesh shares a 520-km border with Myanmar while Nagaland shares a 215-km border with the country.

26 trains delayed as fog grips Delhi-NCR, temperature dips in north India

As foggy conditions continue to persist in Delhi, the minimum temperature in the city decreased to 6-9 degrees Celsius. In other parts of north India such as Punjab and Haryana, 'cold day' conditions are likely to prevail till January 5.

New Delhi.Delhi's minimum temperature settled at 7.3 degrees Celsius on Wednesday, according to the weather department. The Indian

Railways today said that 26 Delhi-bound trains were delayed amid the presence of fog in the city. While visibility improved marginally in various parts of the national capital, Safdarjung, Delhi's primary weather station, recorded a visibility of 200 meters at 8:30 am on Wednesday, according to officials.In Uttar Pradesh's Noida and Greater Noida, the administrations ordered

schools to be shut for students up to Class 8 till January 6 due to severe cold weather conditions in the district.

Through satellite imagery, the weather department observed fog over parts of Punjab, Haryana, Chandigarh, Delhi, Uttar Pradesh, Bihar, Rajasthan, Similarly, dense to very dense fog Gujarat, north Madhya Pradesh and Assam on Wednesday morning.The

The others who are facing the ED action also include Hazaribag deputy superintendent of police Rajendra Dubey, and Sahib Ganj district collector Ram Nivas. The district collector's home is in Rajasthan.

In another case linked to an alleged land scam, the ED on Saturday issued summons for the seventh time to Mr Soren seeking to record his statement. The ED in the summons warned the Jharkhand Chief Minister that it was his last opportunity to record his statement."... We are giving you this last opportunity to record your statement under Section 50 of the Prevention of Money Laundering Act, 2002... which should be within seven days of receipt of this notice/summons," the ED said in the summons to Mr Soren.Mr Soren has called the summons "illegal", news agency ANI reported on Tuesday. In a letter to the ED, Mr Soren said he has already given the details of his properties. Soren has written to the ED in response to the summons issued to him, saying the summons are illegal. He accused ED of making a media trial of the whole matter. In his reply, he said he had already given the details of properties. He accused the ED of trying to destabilise his government," ANI reported quoting an unnamed source. Mr Soren is also being investigated over allegations of money laundering linked to the illegal mining case in Sahebganj district. The Chief Minister, who is in charge of the mines and geology department, allegedly violated election rules by giving himself a mining lease in 2021. Soren has denied any wrongdoing and alleged a larger conspiracy to "harass a tribal leader". The ED searches comes just months ahead of the national election. Mr Soren has dismissed speculation about his wife Kalpana Soren being prepped to contest from Gandey assembly constituency as a "complete imagination" of the BJP.

The speculation was triggered by the ED's latest summons to Mr Soren, coupled with the resignation by the ruling Jharkhand Mukti Morcha's MLÁ Sarfaraz Ahmad on Monday.

The BJP has alleged Mr Ahmad was made to quit so that Kalpana Soren could contest from the Gandey seat in case of any eventuality in connection with the ED matter.

Hit-and-run law: Truckers end protest after Centre says decision after talks

The All-India Motor Transport Congress called off the agitation and urged truckers protesting against the new hit-and-run law to resume work. The development came after the truckers' body's key meeting with the government on the matter.

New Delhi. The truck drivers called off their nationwide protest against the new HERE'S ARECAP penal provisions regarding hit-and-run Truck drivers across the country road accident cases as the government assured that it would consult the transport body representing them before implementing a contentious law against hit-and-run. The new rule that provides for up to ten years of punishment in hitand-run cases has not been implemented yet, the government said, adding that any decision would be taken only after discussions with the transport body.

The truckers were also urged to resume work immediately after a late-evening agreement between the transport body and the government. However, several petrol pumps in Lucknow remained closed even after the transporters' strike was called off. "No stock" posters were seen at petrol pumps in the city, causing inconvenience to locals.

The staff is saying there's no stock. I am even unable to go to work. I don't know what the government is doing regarding

this issue," a local said.

lauched protest over a provision of the new criminal law codes dealing with the issue of hit-andrun accidents. The provision in question was recently brought in by the government under the Bharatiya Nyaya Sanhita, that replaces the ritish-era Indian Penal Code. According to the new penal law, any driver who causes the death of a person by rash and negligent driving and flees from

the spot without reporting the accident to the authorities could be jailed for up to 10 years and/or be fined.Protestors blocked highways and roads in several parts of the country and refused to ply their vehicles. As the protests raged, the Ministry of Home Affairs held discussions with representatives of the All India Motor Transport Congress on January 2, the second day of the strike. Truckers protesting nationwide against the hitand-run law were urged to resume work immediately after a late-evening agreement between the transport body

representing them and the government. The government said that any decision would be taken only after discussions with the transport body. Home Secretary Ajay Bhalla said, "There was a discussion with the All India Motor Transport Congress on the law imposing a punishment of ten years (in hitand-run cases). This law has not yet been implemented. We will implement it only after discussing with the AIMTC."Meanwhile, Malkit

Singh Bal, the Chairman of the truckers' body's core committee said, "We met and discussed the provisions under the Bharatiya Nyaya Sanhita (BNS), and all issues have been resolved. The new laws have not been implemented yet and will only be implemented after consutation with AIMTC."He also said that he strike would end soon and that the drivers have been urged to resume work.

While hiking, camping and paragliding are the most sought after activities here, the place has a spiritual connection as well. Bir and Billing house two Buddhist monasteries - Chokling and the Palpung Sherabling Monastery. Both the monasteries are much revered by Tibetans and Buddhists in the region and are open to visitors. These are perfect for a short trip from Mcleodgani/Dharamsala if you are searching for a more solitary experience. A 3-4 hours drive from Dharamsala will have you in Bir-

Palampur

Palampur is a short drive (2-3 hours) from

Dharamsala and is one of the best places for the lovers of tranquility. Abundant with tea estates, trekking trails, campsites and quaint monasteries, it sees lesser crowd compared to Dharamsala. While Tashi Jong Monastery is one of the highlights of Palampur, you can also go hiking in the Dhauladhars, set camp in the pine forest around, visit the tea estates, gorge over

some homemade thukpa and Tibetan food at one of the eateries around or do nothing other than stargazing. Perfect if you wish to avoid the weekend crowd of Dharamsala and Mcleodganj in summers.

Barot

Visit Barot if you have been scouring for a "do-nothing" p 1 a c e n e a r Mcleodganj/Dharamsala. An idyllic hill town, it lies at a drive of around three hours from Mcleodganj. Barot is


hidden deep in dense cedar forest, often taking visitors by its surprisingly serene location. This charming place is lined with terrace fields and will bowl you over with the calm spread here. Only to be broken by the gushing sounds of some waterfall nearby. A lot of trekking trails in the pine forest, angling spots along Uhl river and a trout farm are some other highlights of Barot. Charming grins of the village people will, of course, woo your heart.

Chamba and Khajjiar

Another one for the lovers of offbeat, Chamba is as stunning as a tiny hamlet in Himachal Pradesh can be. It lies at some 130 km from Mcleodganj/Dharamsala and has a charm that is hard to beat. Explore the ancient temples, wooden forts, the rolling meadows and immerse yourself in the many folk tales that the locals are too happy to recount for anyone who looks keenly interested. Hailed as a land of Gods, Chamba fascinates with its sheer mysticism. Gorge over the famous rajma-chawal in one of the homestays here and head for the neighbouring Khajjiar. Its claim to fame is the title of "Mini Switzerland". A ground that resembles Alpine meadows, with a stream-fed lake in the middle, Khajjiar is a hill-lover's wish come true. You will find plenty of scenes of both Chamba as well as Khajjiar in the criticallyacclaimed movie, The Blue Umbrella.

Dalhousie

Dalhousie lies at some 120 km from Mcleodgani. A tiny town that was much fancied by the British, it still retains its oldworld charm. Walk along the pine-lined roads in the evening, savour a plate of fresh, steaming momos, buy a pair of mittens or more from the Tibetan market, visit the two churches, trek up to Dain Kund and enjoy a cup of coffee with some vintage books in the church library. If this sounds like a perfect getaway to you, hit the road to Dalhousie from Mcleodganj - a journey that is an enticing as the destination.



Guess what? You can also be a tomb raider!

ot everyone is Angelina Jolie, but then it is not mandatory to be one of the world's top actors to nurture a very niche sense of travelling. To start with, you can go globetrotting and visit some of the most famous tombs across the planet!

All of us have a set of heroes and idols musicians, actors, athletes, authors. politicians and more - people we want to meet, see and talk to in person. But what if your heroes have bidden farewell to the world before you could catch a glimpse of them? Apart from (or rather than) penning elegies and wishing you could meet them, you can visit their tombs and pay your tribute like a true admirer!

But, in case, you find this idea outlandish and not worthy of a shot, we would like to share with you the fact that the tomb of poetplaywright William Shakespeare is one of the most visited memorials on earth, let alone a forerunner in tomb destinations. The Bard of Avon was laid to rest in the Holy Trinity Church in his hometown of Stratford-on-Avon. Located on the banks of Avon river in Warwickshire, England, the tomb of the poet supreme bears an epitaph that is believed to be written by the maestro himself. More of a



warning, it reads like this: Good friend for Jesus sake forbeare, To digg the dust encloased heare. Blese be the man that spares thes stones, And curst be he that moves my bones.

.. So unless you intend to move the playwright's bones, there is no fear in visiting Stratford-on-Avon. When Elvis 'The King' Presley passed away in 1977, his fans found themselves at the end of a road that had no milestone on it, so they decided to make their hero's tombstone one! The Rock and

Roll legend rests in his home Graceland in Memphis, Tennessee. The fact that his tomb is visited by 600,000 people annually is just an indicator that 'tomb tourism' does exist. And if sources are to be believed, this alone brings over \$100 million a year to the city of Memphis!

Courtesy its illustrious founder Napoleon Bonaparte, the Pere-Lachaise cemetery in Paris marks a special territory for itself in the French capital. This place is home to the graves of eminent personalities like Edith Piaf, Max Ernst and Oscar Wilde. But the

tomb that attracts maximum visitors is that of rock legend Jim Morrison's. The Lizard King, as he is often referred to as, breathed his last in the city of Paris at the age of 27, leaving a legion of fans that would make him a cult figure in coming decades. Jim Morrison's influence on music and pop culture does not need any testimony and it is obvious that thousands of music lovers flock to his last resting ground not only to offer their homage but also to celebrate Morrison's life as the poet-musician himself observed in an

Known for his quirky wit and sharp observation, Oscar Wilde now rests under a headstone that is decked with lipstick-covered kisses! While Wilde passed away in 1900, the practice of kissing his tombstone started somewhere in the late 1990s, when someone left a kiss mark on it leading to a flood of red in coming times. In 2011, the cemetery authority placed a glass barrier around the grave which met a similar 'lipstick fate' in no time!

Reggae legend Bob Marley, literally, rules from his grave! Being fans' favourite is one thing, while getting a national holiday on your death anniversary is another level of accomplishment and Bob Marley has both in his kitty! Every year on February 2nd (his death anniversary), thousands of Marley fans gather at a music festival near his grave in his native village of Nine Miles, Jamaica. What else to expect from someone, who was buried with a guitar (either a Les Paul or a Fender Telecaster) and marijuana bud? ROCKSTAR!

Marilyn Monroe, too, continues to be the benchmark of sensuality even in this age of Irina Shayks and Emily Ratajkowskis. The eternally beautiful actor's sudden death in 1962 took the world by shock and conspiracy theories refuse to die out even today. Buried in Westwood Village Memorial Park Cemetery in Los Angeles, the tomb of this timeless diva is a crowd puller in every sense of the term. What is more intriguing is the rumour that the tomb space directly above hers is reserved for Playboy boss, Hugh Hefner!

Adani Enterprises, the conglomerate's flagship entity, saw a 2.86 per cent increase, trading at Rs 3,016.40 around 11:15 am, while Adani Ports rose by 1.27 per cent to Rs 1,092.10 apiece.Adani Transmission, which surged up to 16 per cent in early trade, continued to trade 9.03 per cent higher at Rs 1,158.40. Despite a reduction in gains, all other Adani Group shares were resilient, aligning with the market's expectations for the verdict. Anticipating a favourable verdict, Adani Group shares soared before the announcement.In its verdict on a batch of petitions related to the case, the SC stated, "There is no ground to transfer the probe in this case from Sebi to a special investigation team (SIT)." The court emphasised that the power to transfer an investigation must be exercised in exceptional circumstances, requiring cogent justifications. The SC also dismissed arguments by petitioners regarding a perceived conflict of interest among the members of the Expert Committee formed earlier.Furthermore, it directed Sebi to conclude its probe into the Adani-Hindenburg case within three months. Additionally, both Sebi and the government were instructed to investigate the allegations of shortselling as mentioned in Hindenburg Research's report. NEW DELHI. With the success of mini SUV Exter and the updated Creta to hit the market soon, the country's second-largest carmaker Hyundai (HMIL) feels that 65% or about two-thirds of its total passenger vehicle (PV) sales will come from Sports Utility Vehicles (SUVs) in 2024.

This assumption by the Korean carmaker comes after SUV share in its total sales grew from 53% in 2022 to 60% in 2023. In comparison, SUVs' contribution in market leader Maruti Suzuki sales increased from 22% in 2022 to 36% in 2023 while almost all of Mahindra & Mahindra's PV sales were SUVs.

"We feel Hyundai's SUV share in total sales can grow to 64-65% in 2024 while for the PV industry, SUV contribution can grow to 52% or 53%," said Tarun Garg, COO, Hyundai Motor India. "There were speculations that growing competition and launch of new Creta would impact demand of the current model. However, Creta remained the segment leader and did extremely well as its sales grew 12% year-on-year in 2024 to over 155,000 units," said Garg. In total, Hyundai sold over 6 lakh PVs in domestic market last year. Hyundai is all set to launch the new Creta this month and on Tuesday commenced bookings for a token amount of Rs 25,000. The new model will compete against the likes of recently launched Honda Elevate, Kia Seltos, Maruti Suzuki Grand Vitara, Toyota Hyryder, VW Taigun and Skoda Kushaq.

Led by strong demand for SUVs, annual passenger vehicle sales crossed the 40 lakh mark (about 41.08 lakh) for the first time in 2023. SUV segment's share in total sales increased from 42% in 2022 to nearly 49% in 2023. This is a sharp jump and SUVs contributed only about 20% of total passenger vehicle sales five year back. Banks with 6% net NPAs can't pay dividends

NEW DELHI. The banking regulator has proposed to make more stringent the conditions for banks to be able to declare dividend payments. The Reserve Bank of India (RBI) on Tuesday released draft guidelines in which it has proposed that a bank should have net nonperforming assets (NPAs) of less than 6% in the financial year for which the dividend has been proposed. Earlier, banks with less than 7% net NPA could give dividends to its shareholders.

The RBI has increased the capital adequacy requirement for small finance banks (SFBs) and payment banks. It proposes minimum capital requirement for commercial banks, local area banks and regional rural banks to be at 9%, while for those SFBs and payment banks it is 15%.

Apart from the overall capital requirement, banks will have to stick to minimum Tier 1 capital norms. For example, commercial banks must have 7% minimum tier 1 capital to be able to declare dividends. Meanwhile, the regulator has proposed hiking maximum dividend payout ratio to 50% from existing 40%. A bank with no net NPA can pay 50% dividend to its shareholders, 40% if net NPA is over 0 and less than 1% and 35% for banks with net NPAs more than or equal to 1% but less than 2%. A bank with net NPA of more than or equal to 2% but less than 4% can pay up to 25% dividend and 15% if the net NPA is more than or equal to 4% but less than 6%. Dividend payout ratio is the ratio between the amount of the dividend payable in a year and the net profit as per the audited financial statements for the financial year for which the dividend is

According to the guidelines, the proposed dividend payable will include dividend on equity shares only. In case the net profit for the relevant period includes any exceptional and/or extraordinary profits/ income, or if the financial statements are qualified (including 'emphasis of matter') by the statutory auditor that indicates an overstatement of net profit, the same will be reduced from net profit while determining the Dividend Payout Ratio. The guidelines apply to foreign banks for being able to remit profits to their foreign headquarters. Explaining the rationale for revision of the dividend guidelines, the RBI said that these guidelines have been reviewed in the light of implementation of Basel III standards, the revision of the prompt corrective action (PCA) framework, and the introduction of differentiated banks. CXO prenups: IT companies make jumping ship tougher

BENGALURU. With a spurt in C-suite movements in the Indian IT sector, and with some of them landing in courts, separation agreements that supersede previous employment contracts are coming into vogue.

Legal experts say they are used to remind outgoing employees of their continuing obligations towards the company and sometimes, to place additional restrictions specific to the employee's role in the company. "For instance, if the employee has relationships with one or more customers, the employer may use the agreement to remind the employee not to solicit those specific customers, which is even more critical if the employee is joining a competitor," a legal expert who did not want to be named said.

However, executives may need to be incentivised to sign such agreements, especially if they place onerous restrictions on them. Sources told TOI that former Infosys presidents Ravi Kumar and Mohit Joshi both signed separation agreements with Infosys before they quit. The agreements are said to have defined



their contractual obligations of confidentiality, non-solicitation, and nondisparagement.

Kumar moved to Cognizant as CEO less than three months after he quit Infosys. Joshi joined Tech Mahindra as CEO designate in June, immediately after he left Infosys, and went on to assume full responsibility in December when incumbent CP Gurnani retired. In 2017, Infosys is said to have signed a separation agreement with exiting CEO Vishal

Sikka, which included mutual release and non-disparagement obligations.

At least a dozen senior executives have crossed over to competitors in the past couple of years. These leaders are privy to competitive business intelligence, deal pricing, client milestones, financial obligations and penalty clauses.

Wipro recently filed a suit against former CFO Jatin Dalal - who quit Wipro in November and joined Cognizant as CFO in December - on the grounds that he violated non-compete obligations.

Pooja Ramchandani, partner for employment, labour, and benefits at law firm Shardul Amarchand Mangaldas said a separation agreement is a mutually negotiated document which sets out the terms of separation of employment. "It not only includes details of the separation package but also typically covers aspects of waiver and release of claim. It imposes post-employment restrictions on nonsolicitation," she added. An email sent to Cognizant, Infosys and Tech Mahindra on the matter didn't elicit a response till the time of going to press.

Wayne Rooney responds to sacking as Birmingham City manager after just 15 games in charge: 13 weeks not enough



London Former England and Manchester United footballer Wayne Rooney did not hold back as he expressed his disappointment over his sacking as the manager of Championship team Birmingham City FC on Tuesday, January 2. Rooney's tenure came to an abrupt end after a mere 83 days in charge, culminating in his dismissal following a string of disappointing results.Legendary Rooney had been at the helm for just 15 games, during which he managed only two victories. His short-lived stint saw the club plummet from a promising sixth place in the EFL Championship to a precarious 20th, teetering on the edge of the relegation zone. The decision to part ways with Rooney was described as being in the "best interests of the football club," a sentiment echoed in a statement by Birmingham's chief executive, Garry Cook. The club's management felt that despite Rooney and his coaching staff's best efforts, the outcome did not align with the expectations set at the beginning of his appointment. There was a sense of optimism when Rooney was unveiled as the manager in October at St Andrew's, but what was expected to be a promising association came to a crushing end."I would like to thank Tom Wagner, Tom Brady and Garry Cook for the opportunity to manage Birmingham City FC and the support they all gave me during my short period with the club," Rooney said in a social media statement."Football is a results business – and I recognise they have not been at the level I wanted them to be. However, time is the most precious commodity a manager requires and I do not believe 13 weeks was sufficient to oversee the changes that were needed," he added.Rooney expressed his intention to take a break with his family before preparing for the next chapter in his managerial career."I have been involved in professional football, as either a player or manager, since I was 16. Now, I plan to take some time with my family as I prepare for the next opportunity in my journey as a manager.

Shaheen, in the meantime, also rued the missed chances on the field in the ongoing Australian tour. In the MCG Test, Shaheen was hard done by in the first innings after Abdullah Shafique dropped a simple catch in the slip

cordon to give David Warner a lifeline. "I think that I can ake more wickets, but unfortunately, catches win matches, and unfortunately we missed those opportunities on the field most of the time. It has been a good tour so far and the last game that we played was quite awesome. As a bowling unit, and as a team, we gave our best, the result was not in our hands, but we tried," Shaheen stated. Pakistan, captained by Shan Masood, are currently trailing the series 0-2, having lost their last 18 Tests on Australian

New Delhi When David Warner was smashing bowlers for Delhi Daredevils in the Indian Premier League (IPL) 2009, the entire cricketing world was convinced about the left-hander becoming a superstar cricketer in white-ball cricket. Warner was ruthless at the top of the order and showcased his potential in the 7 games that he played during his maiden stint in the IPL. However, a certain Virender Sehwag saw a Test batter in Warner, someone similar to him. Having redefined the way openers went about their business in red-ball cricket, Virender Sehwag was confident that David Warner had the game to become a Test opener for Australia. Sehwag did not miss an opportunity to talk to Warner during the IPL 2009 season and plant that thought into his head. Coming from one of the

finest modern-day openers, who instilled fear in the minds of opposition bowlers, Warner was able to understand what Sehwag was telling him despite having not harboured thoughts of redball cricket in the past, considering the competition for sports in the Australian cricket team. Warner played two years of first-class cricket before he made his Test debut in 2011. There was no looking back from then on. Warner hit his maiden hundred in just his second Test. And in his 5th Test, Warner was up against a touring Indian side that had Virender Sehwag. Warner made it count in front of the man who pushed him to take up Test cricket, hitting a match-winning 180 for Australia at the WACA in Perth.11 years later, Warner is all set to



Warner did for Australia what Sehwag achieved for India at the top of the order. Much like Sehwag, Warner also played over 100 Tests (112 to be precise) and scored over 8000 runs. Warner went past his Sehwag's tally of 8207 runs last year and has 4 more hundreds than the former India opener. Warner will finish his career among the top 5 leading run-getters as openers in Test cricket.
