India successfully conducts 1st flight test of nuclear-capable Agni-5 missile with MIRV tech

New Delhi, March 11: In a major boost to its military might in the midst of the eastern Ladakh row, India on Monday tested Mission Divyastra - the first flight test of indigenously developed Agni-5 missile with Multiple Independently Targetable Re-entry Vehicle (MIRV) technology. Top government sources said the launch will ensure that a single missile can deploy multiple warheads at different locations. The project director of Agni 5 is a woman and the development that will alter India's geopolitical position has significant women's contribution. "With the test of Mission Divyastra, India has joined the select group of nations who have MIRV (multiple independently targetable rented vehicles)

capability. "This system is equipped with indigenous Avionics systems and high accuracy sensor packages, which ensured that the reentry vehicles reached the target points within the desired accuracy. The capability is an enunciator of India's growing technological prowess," government sources said. The Agni-5, with a range of 5,000 km, is developed considering the long-term security needs of the country. The missile can bring almost the entire Asia including the northernmost part of China as well as some regions in Europe under its striking range. The Agni 1 to 4 missiles have ranges from 700 km to 3,500 km and have already been deployed. 'Designed to polarise polls, manage headlines': Congress questions CAA rules notification timing

New Delhi, March 11: The Congress on Monday alleged that the timing of notifying the rules for the Citizenship (Amendment) Act is evidently designed to polarise the coming Lok Sabha elections, especially in West Bengal and Assam. Congress general secretary Jairam Ramesh also alleged that the announcement is yet another attempt to "manage the headlines" after the Supreme Court's strictures on the electoral bonds issue. Ramesh said it has taken four years and three months for the Narendra Modi Government to notify the rules for the law cleared by Parliament in December 2019. "After seeking nine extensions for the notification of the rules, the timing right before the elections is evidently designed to polarise the elections, especially in West Bengal and Assam," the Congress leader said. "The prime minister claims that his government works in a businesslike and time-bound manner. The time taken to notify the rules for the CAA is yet another demonstration of the prime minis-

New Delhi, March 11: A plea has been filed in the Supreme Court seeking to restrain the Centre from appointing new election commissioners as per a 2023 law, the provisions of which have been challenged in the apex court. Two vacancies of election commissioners have arisen following the resignation of Election Commissioner Arun Goel and Anup Chandra Pandey's retirement. The plea has been filed by Congress leader Jaya Thakur, who has challenged the provisions of the Chief Election Commissioner and other Election Commissioners (Appointment, Conditions of Service and terms of office) Act, 2023. In her application, Thakur informed the court that during the pendency of her plea, in which a notice was issued on January 12, "one member of Election Commission namely Arun Goel gave resignation on March 9, 2024, which has been accepted by the President". "That petitioner most respectfully submitted that in view of facts that election for Lok Sabha Election 2024 may be announced shortly, therefore appointment of member of new election commissioners is required immediately, for that this court has given clear verdict in the case of 'Anoop Baranwal Versus Union of India' (March 2, 2023 verdict) about the appointment process...," the plea said.

Navdeep Singh Sahni Gurugram, March 11: Prime Minister Narendra Modi on Monday inaugurated and laid foundation stones for 114 National Highway projects across the country worth about Rs 1 lakh crore. Among key National Highway (NH) projects, Modi inaugurated the Haryana section of the landmark Dwarka Expressway. The total length of the Dwarka Expressway is 29 km, out of which 18.9 km falls in Haryana, while the remaining 10.1 km is in Delhi. The expressway will help improve traffic flow and ease congestion between Delhi and Gurugram on NH-48. The prime minister also held a roadshow here. Dwarka Expressway is India's first elevated 8-lane access control urban expressway, being constructed at an estimated cost of Rs 9,000 crore, as part of the Centre's Rs 60,000 crore highway development plan in the NCR to decongest the national capital. The Haryana section of Dwarka

Shimla, March 11: No emperor can save his chair through intimidation, Himachal Pradesh Congress rebel Rajinder Rana said on Monday, a day after an Independent MLA and the father of another rebel were booked over "electoral offences" related to the recent Rajya Sabha polls. The case against Hamirpur's Independent MLA Ashish Sharma and Gagret's now-disqualified MLA Chetanya Sharma's father and others was registered based on a complaint lodged by Congress legislators Saniav Avasthi and Bhuvneshwar Gaur. Ashish and Chetanya are among the six Congress rebels and three Independents who had voted in favour of BJP nominee Harsh Mahajan in the recently held Rajya Sabha polls. "Battles are not won by attacking from behind like cowards. Real warriors fight from the front... No 'shahenshah' can save his chair through intimidation and registration of false cases," Rana said in a Facebook posed. Congress legislators Sanjay Avasthi



Chief Minister Sukhvinder Singh Sukhu without naming him. "Time will also take account of those registering cases and those getting them registered. Stopping the business of MLAs and allowing friends to loot, is this a change in the system?" he and Bhuvneshwar Gaur had filed the complaint, seeking an investigation into "electoral offences", bribery and criminal conspiracy in the whole sequence of events since the Rajya Sabha polls were held on February 27. They alleged "horse trading and misuse of money to influence the elections". The development evoked sharp reactions from the disqualified MLAs. On Sunday, Rana maintained that "with this attitude, the chief minister should be ready to face the consequences. If the chief minister thinks that he could win hearts by registering false complaints, he is mistaken and these pressure tactics will not help." Six Congress rebels - Sudhir Sharma, Ravi Thakur, Rajinder Rana, Inder Dutt Lakhanpal, Chetanya Sharma and Devinder Kumar - who cross-voted in favour of the BIP were disqualified for defving a whip to be present in the House and vote in favour of the government during the cut motion and budget.

Haryana Police form teams to probe liquor trader's murder in Sonepat's Murthal

Chandigarh, March 11: Haryana Police have formed eight teams to investigate the murder of a liquor trader who was allegedly shot dead by two assailants in Sonepat district, an official said on Monday. The incident took place on Sunday when Sunder Malik alighted from his car at a parking lot outside an eatery in Murthal, the police said. The two assailants fired indiscriminately at Malik, killing him on the spot, they said. Malik, a resident of Sonepat district, was earlier booked in more than 10 cases, including murder and other offences, the police said. CCTV footage of the incident showed the accused rushing towards Malik's vehicle with weapons and shooting him multiple times as soon as he came out. The duo then fled the spot, they said. Later, gangster Himanshu Bhau claimed responsibility of the murder in an unverified social media post. A police official on Monday said eight teams had been formed to probe Malik's murder case. The police said a case had been registered against unidentified persons under relevant sections of the Indian Penal Code.

Furnish electoral bonds' details to Election Commission by today

New Delhi. March 11: Dismissing the State Bank of India's plea seeking time till June 30 to disclose details of Electoral Bonds, the Supreme Court on Monday ordered it to submit the details to the Election Commission by tomorrow. A fivejudge Constitution Bench led by CJI DY Chandrachud gave time till the end of business hours on March 12 to the SBI to submit the details to the Election Commission. It directed the EC to put the information received from the SBI on its website by 5 pm on March 15. "Submissions of SBI in application indicates that info sought is readily available, thus the application by SBI seeking extension of time until June 30 is dismissed. SBI is directed to disclose the details by the close of business hours of March 12," it ordered. The Constitution Bench - which also included Justices Sanjiv Khanna, Justice BR Gavai, Justice JB Pardiwala and Justice Manoj Misra - had on February 15 declared unconstitutional the electoral secret before the court struck down elec-Salve, who offered to file a detailed affi-

They will hold similar interactions in Jammu on Wednesday, the officials said, adding they are also likely to interact with the media there. There has been a growing demand from political quarters in



Karnataka on Monday became the latest entry into a string of states that are cracking on cotton candies and gobi Manchurian after it announced the banning of food colouring agent in the food items over health concerns.

Bengaluru. Karnataka has become the latest state to crack down on food colouring agents in cotton candies and gobi manchurian due to health concerns. On Monday, Karnataka Health Minister Dinesh Gundu Rao announced the banning of the food colouring agent Rhodamine-B in cotton candy and gobi manchurian."If anyone is found using Rhodamine-B food colouring agent, then severe action will be



taken against them under the Food Safety Act," he announced at a press briefing.He said that the quality of these food items across the southern state was poor because of the artificial colouring, which is in return, adversely affecting the health of people. Of 171 samples of gobi Some of the samples of gobi manchurian manchurian collected, 64 were found to be safe while as many as 106 were found to be unsafe. Meanwhile, a total of 25 cotton

candy samples were collected, of which, 10 were found to be safe and 15 unsafe. Tartrazine, Carmoisine, Sunset Yellow and Rhodamine-1B were some of the artificial

colours found to be used in the samples.

Will Not Release Cauvery Water To Tamil Nadu": DK Shivakumar Amid Crisis

Bengaluru. Karnataka Deputy Chief Minister D K Shivakumar asserted on Monday there is no question of releasing Cauvery river water to Tamil Nadu at any cost now. Amid criticism and protest against the government over allegations that Cauvery water was being released from Krishnaraja Sagar (KRS) dam to Tamil Nadu, he clarified that the discharge was meant for Bengaluru, and not for the neighbouring state."There is no question of releasing Cauvery river water to Tamil Nadu now at any cost, we have not left (released)....How much water flows to Tamil Nadu, there is an account for it. Even if water is released today it will take four days to reach there," Shivakumar, who is also the water resources minister, told reporters here. We are not fools in this government to release water (to Tamil Nadu)," added Shivakumar, also the State Congress chief The 'Raitha Hitarakshana Samiti' had staged a protest in the district headquarters town of Mandya on Sunday alleging that water was being released from KRS dam to Tamil Nadu, amid drought and water crisis in many parts of the state.BJP too had attacked the Congress government alleging that it was keen to protect the interest of DMK, the party's alliance partner in Tamil Nadu, at the cost of Karnataka's farmers and citizens, as it targeted the Siddaramaiah administration for allegedly releasing water from Cauvery river to Tamil Nadu

Don't physically verify dairy and HR&CE stock: TN Director General of Audit

D Jaisankar, DGA, told TNIE that physical verification of stocks is beyond the scope of audit functions.

CHENNAI. Tamil Nadu Director General of Audit (DGA), who oversees audit department in the state, has instructed auditors of the milk cooperative, HR&CE, local fund audit department and others not to conduct physical verification while assessing stocks at the end of the financial year. Instead, the audit department has been told to use stock details from the departments concerned for annual auditing. The revised methodology will come into effect from March 31 and a directive to this effect was recently issued to the respective audit directorates.D Jaisankar, DGA, told TNIE that physical verification of stocks is beyond the scope of audit functions. "The audit department also lacks the wherewithal to carry out such a huge exercise. The maintenance of stock data is a responsibility



of respective department administrations, not of auditors," he said. Bid to help hide maladministration

He claimed the decision to eliminate physical verification of stocks aligns with practices followed by the Comptroller and Auditor General of India (CAG). He stressed that auditors should not engage in administrative roles, which would be both ineffective and pose unnecessary interference in departmental administration. "We have rectified the incorrect practice that had been

in place for years," he said. A section of activists in the dairy industry, however, have alleged that the move is an attempt to help Aavin and other departments conceal maladministration. Some auditors from the milk cooperative department too have said this decision lacks legislative backing and is aimed at preventing the mismanagement of dairy stocks, such as butter, milk powder, and ice cream, at dairy plants from becoming public knowledge. Along with Dwarka Expressway, UER-II stretch to open for traffic

NEW DELHI. The first leg of the Rs 9,000-crore Dwarka Expressway will be opened by Prime Minister Narendra Modi on Monday afternoon, almost 18 years after the Haryana govt had conceived to build an additional link between Delhi and Gurgaon.

While three new link roads between the two cities were proposed by the erstwhile planning commission to decongest Delhi-Gurgaon Expressway and MG Road, work on the other two - Vasant Kunj to DLF-II and MG Road to Gurgaon-Faridabad Road - has not yet started.

This will be the fifth expressway to be operational in NCR in the past six years.

Since 2018, two peripheral expressways - EPE, WPE, Delhi-Meerut Expressway and Sohna-Sawai Madhopur section of Delhi-Mumbai Expressway have been thrown open to public.

Along with the first section of Dwarka Expressway, one package of six-lane Urban Extension Road-II (UER-II) from Nangloi-Najafgarh Road to Sector 24 in Dwarka (9.6km) will also be opened for traffic on Monday.

Dwarka Expressway is part of the Centre's Rs 60,000 highway development plan in the NCR to decongest the capital. It is being built by NHAI as a 'model' urban expressway with a plan to meet the requirement for 20-25 years. Laying the foundation stone for the 28.5 km expressway on March 7, 2019, then finance minister Arun Jaitley had said expressways will "boost the economy of the country as highways boosted the economy of the United States".

430 teams deployed for anaemia screening in city

Gurgaon. A total of 430 teams of health workers will conduct health screening across the city on Monday as part of the anaemia elimination week. The teams will focus on anaemia detection and early interventions to reduce the prevalence of the disease by 1% in a year.

"There are 77 supervisors who are heading the 430 teams." Apart from routine OPDs, all health facilities are conducting haemoglobin (Hb) screening and treatment of patients across all age groups. At some health facilities, microcuvette-based digital hemoglobinometers are being used for testing," said Dr Virender Yadav, CMO Gurgaon. According to doctors, children, adolescents, women of reproductive age and pregnant women are at high risk of developing Anaemia. Maternal Anaemia is associated with adverse birth outcomes such as miscarriage, stillbirth, prematurity, and low birth weight of the baby.

Noise barrier to model markets, what's on Noida's list this year

Noida. From underpasses to a sports complex and noise barrier, the Noida Authority has a long list of projects to be undertaken this year. Two underasses will be built on the Noida expressway for around Rs 250 crore. While a 6.1km long underpass will come up near Sector 135, another – 16.9km – will be built near Sector 146. These will take the number of underpasses on the expressway to five. Three of them are already there near sectors 96,

A 2km stretch of the 4.8km elevated road linking sectors 18 and 61 will get a 2.5m-high noise barrier. The road has several hospitals, schools and other institutions along it.DGM (civil) Vijay Kumar Rawal said the noise barrier would be installed following recommendations of the CRRI. Apart from these, markets managed by the Noida Authority will also see a makeover. The Godavari market in Sector 37 and two others in Sector 110 will see a revamp for Rs 7.5 crore. The decision on these markets were taken following the facelift of the Brahmaputra market in Sector 29.

The Brahmaputra complex has been developed as a model market at an estimated cost of Rs 3 crore. The project involved upgrading the facade and landscape and creating a space with provisions for seating and entertainment. Other than these projects in the pipeline, a Rs 680-crore tender has been floated recently for the 5.5km Chilla elevated road, connecting Mayur Vihar in Delhi with the Noida Expressway. A total of Rs 900 crore will be spent on the project, work on which is expected to start this year. A sports complex has been planned at a cost of Rs 70 crore on 26 acres in Sector 123, where a waste-to-energy plant was proposed earlier but had to be shelved because of protests by residents. A tender will be floated soon, officials said.

While these projects will be undertaken in the near future, there are some that are either in progress or are expected to be ready this year. Among them are the Bhangel elevated road and Noida Authority's administrative building in Sector 96, both of which may be completed by December. Rawal said over 70% of the work on both these projects were over."Monitoring of the Bhangel elevated road is being done at two levels – every two weeks by the civil wing and once a month by the Authority CEO. A private consultant regularly conducts inspections and highlights issues with the construction work. The construction of the Authority's headquarters has been satisfactory as well," the DGM added. An international golf course in Sector 151A is chasing a March 2025 deadline. So is an approach road connecting sectors 146 and 147 through a bridge on the Hindon.Officials said that about 80% of the land for the golf course was with the Authority. Farmers are being persuaded for the remaining land. The Authority is also planning to float a fresh global tender for a proposed heliport next to the golf course.

Min temp drops by 2.5°C; gusty winds, rain likely in 2 days

Gurgaon. The minimum temperature dropped by 2.5°C to 9.9°C on Sunday, while it was recorded at 12.4°C on Saturday.India Meteorological Department (IMD) has issued a "yellow alert" for March 13 as the region is likely to witness thunderstorms and lightning accompanied with gusty winds with speed up to 40kmph.The maximum temperature was recorded at 27.9°C against 25.2°C recorded on Saturday. The wind slowed down to 5kmph from 8kmph a day ago. "A fresh western disturbance will affect northwest India from March 12, which is likely to bring thunderstorms and gusty winds to the region," an IMD official said.On Sunday, the air quality deteriorated from 'satisfactory' to 'poor'. The city's 24hour average air quality index (AQI) was recorded at 214, as compared to Saturday's 174. The air quality is likely to remain in the 'satisfactory' category till Thursday. Strong surface winds and showers are likely to improve the air quality over Delhi NCR further, according to a forecast by the System of Air Quality and Weather Forecasting and Research (SAFAR). Meanwhile, the day temperature on Sunday rose to 28.4 °C at Safdarjung, Delhi's base station, against 26.9 °C a day earlier. The minimum temperature was 10°C, four notches below normal. The Met department said maximum and minimum temperatures may increase to 29 and 12°C,



respectively, on Monday. There is a possibility of very light rain along with gusty winds on Wednesday.

'Due to the impact of a western disturbance in Delhi-NĈR, gusty winds of 25-35 kmph are likely to blow on Wednesday. A few places in the region may also see drizzle or light rain. It will lead to cloudiness, causing a further rise in the minimum temperature," said Kuldeep Srivastava, scientist and head at the

Regional Weather Forecasting Centre, India Meteorological Department.

Real or AI? Kate Middleton's photo pulled by agencies for being 'manipulated'

World Several major news agencies have withdrawn an image distributed by Kensington Palace, featuring Kate Middleton and her children, amid claims that the photo has been manipulated. On Sunday, the palace released a photo in celebration of Mother's Day in the UK, showing the 42-year-old Princess of Wales smiling at the camera while her three children — Prince George, Princess Charlotte, and Prince Louis — stood around her. The palace stated that the photo was taken by Prince William, 41, earlier in the week at the family's residence in Windsor. However, users on social media questioned the authenticity of the image, with some suggesting that it appeared edited or generated by AI.In response to these concerns, multiple photo agencies have decided to pull the image released by Kensington Palace.The Associated Press noted upon closer inspection that "it appears that the source has manipulated the image." Similarly, AFP withdrew the photo, citing "an editorial issue," and instructed that it "may no longer be used in any manner" on online platforms.Reuters picture editors pointed out a discrepancy in the alignment of the sleeve of Kate's daughter's cardigan, indicating potential alterations to the image. This photograph marked the first officially released image of the princess since her abdominal surgery in January. Its release followed weeks of speculation and social media conspiracy theories surrounding her health and whereabouts.

Balochistan CM announces 'general amnesty' for separatists

BALOCHISTAN. Balochistan chief minister Sarfraz Bugti urged Baloch insurgents to quit violence and join mainstream politics, adding that the Pakistan Peoples Party (PPP)-led government will announce a "general amnesty" to resolve the issue through dialogue, The News International reported. The chief minister said he wanted to resolve the Balochistan insurgency through dialogue and his government was ready to hold dialogue with anyone ready for it, the report stated." Many assassination attempts were made on my life but I have forgiven all those (elements), as there is no flame of revenge in my heart," Bugti said."Although I am in power, it does not mean that I start settling personal scores... I did not have any personal feud with anyone," he added."We are announcing a general amnesty and reviving a peaceful Balochistan policy under which we will try that they (insurgents) become part of mainstream politics," Bugti said.Bugti, who served as caretaker interior minister at the Centre before the February 8 elections, stressed that he has always stood by the state in its fight against separatists and has also lost his relatives, friends and colleagues in the conflict, according to The News International."But despite this, I don't have any revenge in my heart," he added.CM Bugti also warned that if the Baloch insurgents don't become part of the mainstream and abandon violence, then he has no other option but to establish the writ of the state". However, the Balochistan CM refused to share the details of "general amnesty," adding that he would elaborate on the policy once things were finalised.Responding to a question regarding the steps taken to ensure the recovery of missing persons, CM Bugti said the count of missing persons was "dicey". according to The News International. He added that the federal government had formed a commission on missing persons, which has resolved 80 per cent of the cases."I am not giving any justification, as there is no justification even if a single person is missing," Bugti said. The CM also said a "serious insurgency" was going 80,000 people losing their lives in terror incidents in the

Emergency Caribbean summit to address Haiti gang crisis

PORT-AU-PRINCE. Envoys from key nations will meet Monday in the Caribbean to address the spiraling situation in Haiti, as gang violence crippled the impoverished island nation's capital and forced foreign diplomats to flee over the weekend.

Criminal groups, which already control much of Port-au-Prince as well as roads leading to the rest of the country, have unleashed havoc in recent days as they try to oust Prime Minister Ariel Henry as leader of the Western Hemisphere's poorest country.

Caricom, an alliance of Caribbean nations, has summoned envoys from the United States, France, Canada and the United Nations to a meeting in Jamaica to discuss the violence and ways to provide assistance to Haiti.On Sunday, the vice president of Guyana, Bharrat Jagdeo, said the countries would "seek to bring order and restore some faith in the people of Haiti.

"Criminals have now take over the country. There is no government, it is becoming a failed society," he added. With dysfunction growing, bodies have been seen lying in Port-au-Prince streets and the unrest has internally displaced 362,000 Haitians, according to the International Organization for Migration.

On Sunday, the United States said it had airlifted nonessential American staff from its embassy in Port-au-Prince.The US military additionally said it had 'conducted an operation to augment the security of the US Embassy at Port-au-Prince, allow our Embassy mission operations to continue, and enable nonessential personnel to depart."A State Department spokesperson said the embassy nonetheless "remains open, on limited operations" with reduced personnel. The German foreign ministry meanwhile said its ambassador joined other European Union representatives in leaving for the Dominican Republic on Sunday."Due to the very tense security situation in Haiti, the German ambassador and the permanent representative in Port-au-Prince left for the Dominican Republic today together with representatives from the EU delegation," a ministry spokesman told AFP, adding that they would work from there "until further notice."On Saturday, dozens of residents sought safety in public buildings, with some successfully breaking into one facility, according to an AFP correspondent. And police late Friday repelled gang attacks, including on the presidential palace, and several "bandits" were killed, Lionel Lazarre of the Haitian police union said. The well-armed gangs recently have attacked critical infrastructure, including two prisons, allowing most of their 3,800 inmates to escape. Along with some ordinary Haitians, the gangs are seeking the resignation of Prime Minister Henry, who was due to leave office in February but instead agreed to a power-sharing deal with the opposition until new elections are held.

Ukraine rejects Pope's call to 'have courage' to negotiate with Russia

Kyiv, UPDATED. Ukraine on Sunday rebuffed Pope Francis's call to negotiate an end to the war with Russia, with President Volodymyr Zelenskyy saying the pontiff was engaging in "virtual mediation" and his foreign minister saying Kyiv would never capitulate. Francis said that when things were going badly for a party to a conflict one had to show the "courage of the white flag" and negotiate.Zelenskyy made no direct reference to Francis or his comments but mentioned religious figures helping inside Ukraine."They support us with prayer, with discussion and with deeds. This is indeed what a church with the people is," Zelenskyy said in his nightly video address."Not 2,500 km away, somewhere, virtual mediation between someone who wants to live and someone who wants to destroy you."Foreign Minister Dmytro Kuleba, writing on the X messaging platform, said that the strong person in any dispute "stands on the side of good rather than attempting to put them on the same footing and call it 'negotiations'". Our flag

is a yellow and blue one," Kuleba wrote in English, referring to the Ukrainian national flag."This is the flag by which we live, die, and prevail. We shall never raise any other flags."Kuleba also pointed to allegations that Pope Pius XII failed to act against the Nazis in Germany in World War Two."I urge (the Vatican) to avoid repeating the mistakes of the past and to support Ukraine and its people in their just struggle for their lives," he wrote. That was a reference to longstanding arguments that Pius took no action despite evidence that

emerged during the war of the extent of the Holocaust. A letter made public last year from the Vatican archives appeared to show that Pius was made aware of details of Nazi actions to exterminate Jews as early as 1942. Supporters of Pius say he worked behind the scenes to help Jews and did not speak out in order to prevent worsening the situation for Catholics in Nazi-occupied Europe. His detractors say he lacked the courage to



speak out on information he had despite pleas from Allied powers fighting Germany. The head of Ukraine's 5 million-strong Eastern Rite Catholic Church, Archbishop Sviatoslav Shevchuk, also rejected the pope's comments.Ukraine is wounded, but not conquered! Ukraine is exhausted, but it stands and will stand!" the church's website quoted Shevchuk as saying in New York."Believe me, no one has any idea of surrendering."Zelenskyy has

called for the withdrawal of all Russian troops and the restoration of Ukraine's post-Soviet borders. The Kremlin rules out engaging in talks on terms set by Kyiv. The Pope has upset Ukrainian officials several times in the war, including his call last year to Russian youth to take pride as heirs of tsars like Peter the Great, held up by President Vladimir Putin as an example to justify his actions in Ukraine. European officials supporting Ukraine in efforts

to evict Russian troops denounced the pope's latest comments."How about, for balance, encouraging Putin to have the courage to withdraw his army from Ukraine?" Polish Foreign Minister Radoslaw Sikorsski wrote on X.Latvian President Edgars Rinkevics, also writing on X, said: "One must not capitulate in face of evil, one must fight it and defeat it, so that the evil raises the white flag and capitulates."

Netanyahu vows to begin Rafah offensive despite Biden's 'red line' warning

Benjamin Netanyahu said on Sunday that at least 13,000 "terrorists" were among Palestinians killed during Israel's war against Hamas in the Gaza Strip and vowed to press ahead with an offensive in Rafah, in the south of the enclave -- a move US President Joe Biden has described as his "red line". Nearly 31,000 Palestinians have been killed in Gaza during the five-month, long war that

began after Hamas militants attacked Israel on October 7, 2023 killing 1,200 people and seizing 253 hostages, according to Israeli tallies. The Gaza health ministry does not break down the death toll between civilians and Hamas militants but has said that 72 per cent of those killed were women and children. Hamas dismisses Israel's toll for militants as attempts to portray 'fake victories".Netanyahu told



Springer, which owns Politico and Germany's Bild newspaper and broadcaster Welt TV, that extending Israel's offensive into Rafah in southern Gaza was key to defeating Hamas."We are very close to victory... Once we begin military action against the remaining terror battalions in Rafah, it is only a question of weeks" until the intensive phase of fighting is concluded, Bild newspaper quoted Netanyahu as saying.

German media company Axel Biden and his aides have urged

Netanyahu in strong terms not to launch a major offensive in Rafah until Israel crafts a plan for mass evacuation of civilians. More than half of Gaza's 2.3 million people are sheltering in the Rafah area. Asked by MSNBC on Saturday whether an invasion of Rafah would be a red line, Biden said, "It is a red line, but I'm never going to leave Israel. The defence of Israel is still critical. So there's no red line (in which) I'm going to cut off all weapons, so they don't have the Iron Dome to protect them."

Politico quoted Netanyau as saying on Sunday that Israeli forces would push into Rafah, adding: "You know, I have a red line. You know what the red line is, that October 7 doesn't happen again. Never happens again.

Three quarters of Hamas battalions had been destroyed and halting the offensive now would only allow them to regroup, Bild quoted Netanyahu as

US aims to be 'economic partner of choice' for Indo-Pacific: Gina Raimondo

WASHINGTON. US commerce secretary Gina Raimondo is leading a presidential trade and investment mission to the Philippines starting Monday as the United States looks to fortify economic ties across the region. Raimondo plans to tout the Philippines as a key hub for regional supply chains and investment in support of the US Indo-Pacific Strategy during the visit on Monday and Tuesday. She will then travel to Thailand for two days of meetings for a presidential export council mission.

We want to deepen our economic engagement in the Indo-Pacific, which is dynamic - some of the fastest growing, dynamic economies of the world," Raimondo said in an interview, saying the trip aims to ramp up "our economic and commercial ties in the Indo-Pacific."

Security engagements between the Philippines and the United States have stepped up considerably under President Joe Biden and his counterpart Ferdinand Marcos Jr, with both leaders keen to counter what they see as China's aggressive actions in the South China Sea and



near Taiwan. Raimondo said she is often asked if ie Onited States is asking countries in the mad Pacific to choose between China and the United States." Absolutely not - but we want the United States to be the economic partner of choice,' Raimondo said. "For that to happen, we have to show up and show up in the country with money, with collaboration and consistently show up."

Raimondo made a trip in China in August where she met Chinese leaders and touted US firms' desire to do business in China. The US delegation to the Philippines includes executives from 22 companies including United Airlines, Alphabet's Google, Black & Veatch, Visa, EchoStar/DISH, United Parcel Service (UPS), Boston Consulting Group, KKR Asia Pacific, Bechtel, FedEx, Mastercard and Microsoft, the White House said. United said last week it would launch new flights from Tokyo-Narita to Cebu, Philippines starting July 31. Raimondo said she hopes there will be new US investment announcements this week in the Philippines and that talks this week will lay the groundwork for future commercial investments.

Navigating Israeli restrictions, many Palestinians find it hard to reach Al-Aqsa

JERUSALEM. As the sermon about the Muslim holy month of Ramadan sounded over the speakers from Al-Aqsa Mosque, 13-year-old Yousef al-Sideeq sat on a bench outside the compound's gates."Most Fridays, they prevent me from getting in, for no reason," the young Jerusalem resident said, referring to the Israeli police. Every Friday, Yousef visits Jerusalem's Old City to pray at Al-Aqsa, the third-holiest site for Muslims and part of the compound sacred to Jewish people, who call it the Temple Mount. But since the Hamas-led Oct. 7 attacks and Israel's ensuing bombardment of the Gaza Strip, heavily armed Israeli police forces who guard many of the Old City's gates have stopped him from entering the compound, he said. He has managed to get in only twice. Muslim access to the mosque has long been a point of contention as Israel has exerted tighter control in recent years over the compound, one of many restrictions Palestinians living under decades of Israeli occupation have had to endure. As Ramadan begins, many also fear what, if any, additional constraints

Israel may impose on the religious site, which can draw 200,000 people in one day from not just Jerusalem but the Israeli-occupied West Bank and Israel as a whole. Israeli police said people were "entering after enhanced security." were "entering after enhanced security checks that are conducted due to the current reality, alongside efforts to prevent any disturbances." But they did not answer specific questions about whether there was a policy preventing certain worshippers, especially young men, from entering the mosque Friday. They said they were "maintaining a

balance between the freedom of worship and the imperative of ensuring security."Late Sunday, Palestinian and Israeli news media reported that police officers prevented many Palestinians from entering Al-Aqsa to perform prayers for the start of Ramadan. Both media cited a video that showed officers with batons chasing and beating some Palestinians.Israel has said there has been no change to the status quo, which allows only Muslims to worship at the compound. The site is revered by Jews as the location of two ancient temples, and by Muslims as the Noble Sanctuary, the compound

containing Al-Aqsa Mosque and other important Islamic prayer spaces. The compound includes the Dome of the Rock, a gold-domed prayer hall.Israel captured eas Jerusalem, including the Old City and the Agsa compound, from Jordan in 1967 and later annexed it. Much of the world considers it occupied territory and does not recognize Israeli sovereignty over east Jerusalem. Many Palestinians say their access to Al-Aqsa compound has become increasingly restricted in favor of Jews, who consider the Temple Mount the most sacred place in Judaism.Incidents at the compound have at times been the spark for broader conflicts. The second intifada, or Palestinian uprising, was set off in 2000 when Ariel Sharon, who later became Israel's prime minister, visited Al-Aqsa surrounded by hundreds of police officers. Confrontations at the compound in May 2021 contributed to the outbreak of an 11-day war between Israel and Hamas. Hamas, the Palestinian armed group that has been in control of Gaza for years, called its Oct. 7 attack on southern Israel the Al-

Pilot, co-pilot fall asleep for 28 minutes, plane veers off path in Indonesia

World. A plane in Indonesia strayed off its course after both pilots of the aircraft fell asleep for 28 minutes, according to a report released by the National Transportation Safety Committee (KNKT), a government agency. The Indonesia Transport Ministry will launch an investigation into the incident that took place on January 25.According to the KNKT preliminary report, both the pilot and the co-pilot of the Batik Air BTK6723 fell asleep during a flight from Kendari in Southeast Sulawesi province to Indonesian capital Jakarta. However, none of the 153 passengers and four flight attendants on board the plane were injured during the flight, and the aircraft did not suffer any damage either.Later, the flight - which lasted two hours and 35 minutes - successfully landed in Jakarta. According to the KNKT report, the aircraft

was scheduled to go from Jakarta to Kenderi, and then return. During the flight preparation in Jakarta on January 25, the co-pilot had notified his pilot that he had not had "proper rest". After the plane cruised at an altitude of 36,000 feet, the pilot asked the co-pilot to take rest,

and he slept for "about 30 minutes" inside the cockpit. The co-pilot (also known as the second-in-command pilot) woke up before the plane began descending to Kenderi.During transit, both the pilots ate "instant noodle cups in the cockpit". After the BTK6723 aircraft departed from Kenderi, and reached a cruising altitude, the pilot (also known as pilot-in-command) sought permission to sleep from the co-pilot, which he was granted. A few seconds later, the pilot slept off and

the co-pilot took over as the 'pilot monitoring (PM)'. The pilot, however, woke up some time later and asked if the co-pilot wanted to take some rest. Upon the co-pilot's decline, the pilot continued to sleep. Around 90 minutes into the flight, when the pilot remained asleep, and the co-pilot was acting both as 'pilot flying' and 'pilot monitoring', the co-pilot "inadvertently fell asleep", according to



the KNKT report. Around 12 minutes after the last recorded transmission from the co-pilot, the Jakarta area control center (ACC) tried to contact the BTK6723 pilots, but there was no reply from them. The Jakarta ACC also got other pilots to call the Batik Air pilots, but to no avail. Nearly 28 minutes later, the pilot woke up and was aware that the "aircraft was not in the correct flight path". At this point, he woke up the co-

pilot, and told the ACC that the flight had experienced a "radio communication problem" which had been resolved.

The flight was then safely landed in Jakarta.

The KNKT report did not reveal the names of the pilots, but identified the pilot as a 32-year-old and the co-pilot as a 28-year-old - both Indonesian males. The co-pilot had one-month-old twins and "had to wake up several times to help his wife take care of the babies", the report added. The Indonesia Transport Ministry will conduct a probe into the incident, state news

agency Antara, citing the civil aviation director-general M Kristi Endah Murni, said."We will conduct an investigation and review of the night flight operation in Indonesia regarding the Fatigue Risk Management for Batik Air and other fligt operators," Murni added.She further stated that flight crews of BTK6723 have also been grounded according to the Standard Operating Procedure (SOP) pending further investigation.

'Didn't see such a drought in 30-40 years': Shivakumar on Bengaluru water crisis

Bengaluru. Karnataka Deputy Chief Minister DK Shivakumar said on Monday that the state has not witnessed such a severe drought in the last 30-40 years, which has resulted in



Bengaluru's ongoing water crisis."In the last 30-40 years we have not seen such a drought; though there was drought earlier, we had never declared such a large number of taluks as drought-affected," he told reporters in Bengaluru."Wherever Cauvery river water has to be supplied, (it) is being done, but out of 13,900 odd borewells in Bengaluru, about 6,900 borewells have become defunct," he said.Shivakumar said the Karnataka government has taken "things under its control" and arranged tankers to supply water. Due to the ongoing crisis, Bengaluru is receiving 1,450 million litres per day (mld) of water from the Cauvery river for the city's supply, as opposed to the state capital's total water requirement of 2,100 mld.Karnataka, especially Bengaluru, is facing one of the worst water crises in recent years due to poor

Private agency to help curb cattle menace in Tambaram

Cattle seized in the Tambaram corporation limits are currently impounded in a shed in

CHENNAI.In a bid to strengthen efforts to curb the stray cattle menace, the Tambaram municipal corporation has decided to involve a private agency in the operations. This agency will have to conduct cattle raids across all five zones of the corporation.

Controlling stray cattle has been one of the major challenges plaguing local bodies at present. Cattle seized in the Tambaram corporation limits are currently impounded in a shed in Kondamangalam panchayat near Kattankulathur. The decision to engage a private agency was taken as the civic body was grappling with a lack of adequate manpower and resources. As per the agreement, the agency will arrange a vehicle fitted with additional facilities and also 10 workers, who are trained in such kinds of operations. The team will conduct cattle raids across all the five zones. They will seize stray cattle and move them to the shed in Kondamangalam. They will be paid Rs 1,500 for seizing a head of cattle. The corporation officials also hope to extend the raids to the newly added areas as they are often criticised as going soft on owners of



not trained and they often get injured during the seizure operations. The private agency will help ease the burden of the corporation workers," said a corporation official.Meanwhile, activists have raised certain concerns over involving a private agency in the operation. "Instead of

Criminal case filed against top Telangana cop for destruction of intel data

Hyderabad. The Special Intelligence Branch (SIB) of the Telangana Police filed a criminal conspiracy case against Deputy Superintendent of Police (DSP) Praneeth Rao for the alleged manipulation and destruction of intelligence data, as well as damaging official devices.

Praneeth Rao, who is believed to be close to former Chief Minister K Chandrashekar Rao (KCR), is accused of destroying official hard disks and other records after the state assembly election results on December 4, 2023, which dethroned KCR after Congress's win. The investigation

revealed that Praneeth misused his official position while serving in the SIB, regularly copying intelligence information into his personal drives and keeping it under his custody. After the election results, he allegedly turned off the cameras and destroyed old hard drives containing data gathered over decades.Police sources stated that Rao destroyed the hard drives and CCTV cameras to avoid any criminal action against him and others and to destroy the evidence. According to the FIR, Rao, while working in SIB, had two rooms exclusively for himself, unlike other teams, and operated with 17 systems



issued to him. He also had an exclusive and dedicated leased line with an internet connection. Through this setup, he allegedly developed profiles of unknown persons and monitored them without authorisation. The case against the officer was registered on a complaint filed by the Additiona Superintendent of Police (SIB). Rao has been charged with Criminal Breach of Trust (IPC 409), Mischief Causing Damage (IPC 427), Destroying Evidence (IPC 201), Criminal Conspiracy (IPC 120B, R), Common Intention (IPC 34), and various sections of the Prevention of Damage to Public Property Act (PDPPA) and IT Act.

Drinking water supply to all problematic areas restored in Andhra Pradesh

ONGOLE. The Rural Water Supply (RWS) division of Prakasam district has successfully restored drinking water access to all 58 areas affected by water crisis in the western region through water tankers. Notably, the district authorities have decided to enhance the provision to 40 litres per capita per day (LPCD), exceeding the previous standard of 15 LPCD, in these

affected areas. certain habitations with no groundwater availability, the State government has granted permission to month of March 2024, sanctions the delivery of 40 LPCD, deviating from

the prior directive of 15 LPCD, as per the district authority's request.RWS superintending engineer (SE) SK Mardhan Ali mentioned, "With the State government setting the outstanding bills to tanker owners up to October 2022, we can now ensure adequate water supply for drinking and cooking purposes in identified waterscarce habitations, with an increased allocation of 40 LPCD per person."

Recognising the acute water scarcity in Recent coverage by TNIE spotlighted the dire water scarcity situation in western Prakasam district, emphasising the challenges faced by residents due to the absence of groundwater resources. Consequently, the State government

has instructed RWS authorities to deliver water via tankers to these identified habitations for drinking and cooking needs at a rate of 40 LCPD. Water supply operations through tankers have commenced in Donakonda, Peddaraveedu, Pullalacheruvu, Tarlupadu, Tripurantakam, and Yerragondapalem mandal areas. State Panchayat Raj and Rural Development (PR & RD) RWS-1 principal secretary Shasi Bhushan Kumar recently issued orders authorising water provision through tankers to these identified habitations. This initiative is expected to benefit approximately 48,644 individuals,

with 428 trips allocated for 40 LPCD and 126 trips for 15 LPCD capacity tankers.During the Zilla Parishad General Body meeting, District Collector AS Dinesh Kumar informed public representatives of these developments. He announced the government has settled outstanding water transportation tanker bills amounting to Rs 41.69 crore, recorded in the Comprehensive Financial Management System (CFMS) and covering the period from January 1, 2019, to October 31, 2022. This clears the path for restoring water supplies to the aforementioned water-scarce habitations through tankers.



Go easy on students during SSLC exams, NGO tells Karnataka government

BENGALURU. With the exam season on, the Karnataka School Education Assessment Board (KSEAB) has issued guidelines instructing that the seating arrangements should be in such a way for the SSLC students that they face the wall and write the exams so that they don't get distracted. The Child Rights Trust (CRT) highlighting the above rule has written to the Minister of Primary and Literacy Education, Madhu Bangarappa stressing that this will create more fear against exams as

invigilation across centres. The NGO has issued some guidelines and asked the department to consider them during the examination process to reduce fear, anxiety and panic among students. The letter mentions that "child-friendly exam practices" should be imbibed.

"How can one write exams facing the wall? Does the education department not have faith in our children? Or has the department come to a decision that it is not possible to prevent copying? This method increases anxiety instead of reducing it, read the letter addressed to Madhu.

CRT director, Nagasimha Rao, said that the best way to inculcate good exam practices can be to include exam lessons in moral

science classes that will help students learn better. "The repercussions of cheating and copying can be highlighted in those chapters. Not all children copy... one out of ten children could do it. Is it possible to identify such children, understand their problems and mindset and offer counselling?" he wondered.

He added that children who copy are confused, and lack self-confidence, and such children need to be given psychological support.

CRT suggested that counsellors be marked in exam centres and help address such matters at the same time instead of releasing names to media and creating further negative impact.

Rao added that the department, before formulating these guidelines, did not consider students' viewpoints nor did they consult experts. This year's SSLC exams will begin on March 25 and end on April 6, with over 8.9 lakh students set to appear.

Drugs worth Rs 71 crore bound for Sri Lanka seized in Tamil Nadu

Chennai. Drugs worth Rs 71 crore bound for Sri Lanka were seized from a village in Tamil Nadu's Pudukkottai district. The narcotics were to be smuggled into the island nation via the Thondi sea route. The drugs were seized by a Central Intelligence Unit from Tiruchirappalli at a prawn farm in Mimisal village.Based on a tip off, the team reached the spot and seized the drugs, which included 70 kg of ganja oil and 950 kg of ganja. The team was monitoring movement of boats from Thondi, SP Pattinam, Devipattinam, Maraikayarpatthinam, Vedhalai, Thangachimadam,

Rudyard Kipling aptly said that people remember God and police only in distress and never before. When the distress ends, God is forgotten and the police are slighted. However, this observation is not always true. In my long police career, I have witnessed many shining instances of police personnel going out of their way to help those in distress and being gratefully acknowledged for it.

My mind travels back to a case when I was posted as DIG of the Criminal Investigation Department (CID) in Odisha. The department has a squad to trace missing persons. One day, an engineer from the Rourkela steel plant came to meet me. He looked extremely worried. His 12-year-old son had left the house about a week back after a tiff with his mother and the parents had failed to locate him. His wife was distraught and had stopped eating. He himself was passing through unbearable stress and strain. I told him that the usual practice was to publish a photograph of the boy in newspapers and show slides on television channels. However, it would be better and perhaps more fruitful if he and his wife could visit the probable places his truant son might have



gone to.I deputed a CID Inspector to accompany them so that police help could be sought whenever they visited other states. The father took two weeks' leave and set out with the Inspector. They visited various places in search of the missing boy.It was a challenging and exhausting endeavour, but the father was optimistic and the Inspector kept on motivating him all through. The police forces in different states rendered full assistance whenever it was sought.At long last, the patient but agonising search yielded results. With the help of Maharashtra police, the boy was traced to a place near Pune where he was working in a dhaba. After the tiff, he along with a friend had landed in Pune.

Tracing the boy brought immense joy and relief to the traumatised parents. I also experienced a rare sense of peace and satisfaction. The CID Inspector felt happy and victorious. He had been a pillar of support. When the engineer, with tears in his eyes, came to thank me, I told him that I too felt suffused with joy. However, I had a request to make. I wanted him to write letters to newspapers and the electronic media highlighting the help and healing touch he received from the police. Sadly, police failures are trumpeted and good deeds go unheralded.I felt here was an opportunity to set the record straight, not for my sake, but for the entire police force. The relieved father kept his word. I also experienced a sense of fulfilment.

A Simple Majority Is Very Much In BJP's Reach. Here Are The Numbers

As the general elections approach, both the Bharatiya Janata Party (BJP)-led National Democratic Alliance (NDA) and the Congress-led INDIA are powering through their campaigns. Reports are that election dates will be announced by mid-March.In the myriad poll reports that flood the news during election seasons in India, it's not uncommon to find parties and politicians describing seats as 'strong' or weak'. But how are they classified as such? Let's decode this. This 'strength scanner' this season has led the BJP and Prime Minister Narendra Modi to launch a focused outreach in the Eastern and Southern parts of India, while the Congress has been trying to firm up alliances in Northern and Eastern regions. There are a few methods through which parties distinguish strong seats from the weak. We will follow the simplest approach here, in which the strength of a seat is ascertained by the number of times a party has won it in past elections. The last delimitation exercise was carried out in 2008, which led to the renaming of a few existing seats and change in the composition/structure of each seat. The 2009 Lok Sabha elections were fought after these changes. Hence, any seat-by-seat comparison prior to the 2009 elections is not fruitful. Let's consider the last three general elections-2009, 2014 and 2019-to classify seats into four categories, A, B, C, and D.A seat is categorised as "Relatively Strong" for a party if it has won the seat two out of three times in the last three polls

C (Difficult)

A "Difficult" seat is one that has been won only once in the last three elections

D (Weak)

A seat is "Weak" if the party has never won it


Category A: While the BJP has 95 "Strong" seats, the Congress has 17. Forty of these 95 seats for the BJP are in North India, 25 in West, and 15 each in East and South India. Of the Congress's 17, eight are in South India, five in the East and four in the North.

Category B: The BJP has 167 "Relatively Strong" seats, and the Congress 34. The parties have won these seats twice in the last three electionsCategory C: There are 82 "Difficult" seats for the BJP, and 183 for the Congress. These are seats that the parties have won just once in the last three Lok Sabha electionsCategory D: While the BJP has 199 "Weak" seats (those that have never been won in the last three elections), the Congress has 309. These also include seats the parties they have left for their allies. The BJP didn't field candidates for 107 seats in 2019, while the Congress did so for 121 seats. These were seats that their allies contested (largely classified under C & D categories). As can be seen from the table, the BJP, in comparison to the Congress, has a higher number of strong and relatively strong seats and much fewer

difficult or weak seats. This gives it the strength and BJP's Focus Is On East And SouthOf the 309 seats the confidence to win a hat trick in 2024. Categories A and B alone could fetch the BJP 262 seats-just 10 short of a majority. This is of course if it manages to hold on to these seats. The Congress, meanwhile, can fetch just 51 seats, which is just three short of 54, the number required to be the official Leader of the Opposition.

Congress In A Tight Spot That the Congress faces more than 300 seats which have never been won shows that it is nearly impossible for the party to win a simple majority of its own. Even hardcore supporters today feel that 100-150 is a good bet for the party. On the other hand, of the 199 seats that the BJP has never won, 61 are in East India, 98 in South, 17 in North and 23 in West. This highlights how the party has literally 'maxed out' in the North and Western parts of India. What this signifies is that the BJP needs to focus on the East and South for additional gains. The Prime Minister, cognisant of this fact, has already visited Tamil Nadu, Odisha and West Bengal four times in 2024.

Congress has never won, 108 are in East India, 55 in South, 99 in North and 47 in West. This highlights how the Congress has been wiped out in the Eastern and Northern parts of India. It has stitched up alliances with the Samajwadi Party in Uttar Pradesh, the Rashtriya Janata Dal in Bihar, the Jharkhand Mukti Morcha in Jharkhand and the Aam Aadmi Party in Delhi and Haryana to shore up its prospects. Such liaisoning hasn't worked out with the Trinamool Congress in West Bengal. The BJP is focussing on the C and D categories to improve its tally in Eastern and Southern India. There is already buzz about a possible alliance with Naveen Patnaik's Biju Janata Dal (BJD) in Odisha and Chandrababu Naidu's Telugu Desam Party (TDP) in Andhra Pradesh. Whether the BJP will retain power depends on its ability to win a majority of its strong and relatively strong seats in 2024. And, the Congress-led INDIA bloc's success in halting the BJP's march hinges on its ability to restrain the party in these very seats.



Place a person or an object out of context and it could lead to an issue, even a crisis of both identity and identification. Where did I meet him or her? Not being able to remember the name can be taken as a measure of snobbery, or hopefully, just be passed off as plain forgetfulness. Something like that can happen with objects if they are out of place — or if they become 'something that was put somewhere safe, and now cannot be found'. In the same vein, worse, if something, someone or somewhere is wrongly or inappropriately labelled. I was in a grand government house where some artefacts and utensils had been pulled out of an old storeroom or pantry for display. There were spoons and ladles, knives and forks that one would be hard-pressed to know the use of. One large container stood out. This was labelled as a 'coffee maker'. Going by its size, there must have been a regiment of coffee drinkers to make use of this substantial metal barrel. I tried looking closer to see where the beans or power went, and could find none. Nor could one locate the place from where the beverage poured out. Then, as happens, one was told to move along. But that 'coffee maker' parked itself in an unresolved corner of my brain. Back I went. Some more digging and this wondrous contraption revealed

itself as an old-fashioned butter-churn. Now repurposed, the same venerable building has a ballroom — which on the first visit was explained as the place where 'ballroom performances' took place. There are alcoves where the spectators could sit and cheer the 'performers' along. On the second visit, the sprung floor, which gave a level of elasticity to the floorboards, was interpreted as being thus as it helped in 'jumping'. The mental picture that immediately, and appropriately, sprang to mind was a delight to behold — scores of high colonial officials jumping and leapfrogging while outside the gates, away from the skipping and cavorting, India spun its way to



freedom and slipped out of grasp.

Another once grand and now repurposed palace had the storm-water drain marked as an escape route for British viceroys on the run. The wine cellar, with its iron-bar door, was explained away as the prison where freedom fighters frittered away their fighting hours, and the meat hooks in the kitchen were where others of their ilk were supposedly hung till all traces of sedition vanished. In the same vein, the honorary secretary of an elite club decided to name the basement as 'The Torture Chamber'. Petition In Supreme Court To Restrain Centre From Appointing Poll Officers

A Congress leader from Madhya Pradesh has filed a petition citing a 2023 order to restrain the government from appointing the Election Commissioners.

New Delhi. The appointment of two Election Commissioners, expected later this week, faces a new challenge in the Supreme Court. A Congress leader from Madhya Pradesh has filed a petition citing a 2023 order to restrain the government from appointing the Election Commissioners. The two posts

of Election Commissioners fell vacant after the latest resignation of Arun Goel and the retirement of Anup Chandra Pandey last month. The three-member Election Commission of India is now left only with Chief Election Commissioner Rajiv Kumar as the national elections are likely to be announced later this week. Election Commissioners in India are appointed by the President on the recommendation of a three-member panel chaired by the Prime Minister. It also comprises a Union Minister and Congress MP Adhir Ranjan Chowdhury.

The high-powered committee is expected to finalize the appointments by March 15.In her petition, Congress leader Jaya Thakur cited the 2023 order of the Constitution Bench that ruled that election commissioners must be appointed on the advice of a panel comprising the Prime Minister, the Leader of the Opposition, and the Chief Justice of India. Terming the new law unconstitutional, Ms Thakur sought a direction from the Supreme Court for the appointment of the Election Commissioners in line with its 2023 decision. She said the inclusion of the Chief Justice in the appointments panel will ensure transparency in the process. In its 2023 order, the court had said the judgment would hold good "until a law is made by parliament".

The government brought a new law in December to establish a new mechanism to appoint the Chief Election Commissioner and the two Election Commissioners. The new law replaced the Chief Luction of India with a Union the Chief Justice of India with a Union Minister in the panel that finalizes the appointments. Opposition parties had opposed the law, alleging it gives the government greater powers on the appointment of top poll officers and compromises the autonomy of the poll body. The Supreme Court had earlier refused to page the law while begging a refused to pause the law while hearing a previous petition by Ms Thakur. Several pending cases on this subject are set to be heard in April, likely around when the country goes to polls.

The panel has stressed that any corrections to the voters' list will have to be made well in advance before the filing of nominations.

Meanwhile, the Election Committee has unveiled plans to hold other events, including a presidential debate designed to facilitate open discourse amongst candidates.Besides, a series of General Body Meetings (GBMs) will also take place, providing a platform for dialogue and deliberation on topical issues. The committee's chairman, Shailendra Kumar underscored the importance of these events, stating that they not only facilitate interaction between candidates and voters but also ensure transparency and integrity in the electoral process. He urged students to participate actively in all these events and play a crucial role in shaping the future leadership of the institution. Kumar also said that a detailed schedule for the GBMs will only be released after the final list of contesting candidates is confirmed.

Nepal is not helping us. We want to seek help from our neighbouring country, India.""We have great hope that India will help us and will not let us down. Nepal and India have a very strong relationship.

The Supreme Court on Monday refused to stay the "hard-earned" acquittal of ex-Delhi University professor GN Saibaba and five others, all of whom had been accused of Maoist links and charged under stringent anti-terror law UAPA. The court also rejected an oral request by the Maharashtra government for an early listing of its plea against the verdict of the Bombay High Court's Nagpur bench."There cannot be urgency in order of reversal of



conviction. Had it been the other way around, we would have considered," a bench of Justice BR Gavai and Justice Sandeep Mehta said, adding also that prima facie they found the Nagpur bench's judgement to be "very wellreasoned". The Supreme Court further pointed out that all six had been acquitted twice - by two different benches.In 2022 the High Court had ruled that valid sanction had not been obtained to prosecute Prof Saibaba under anti-terror law UAPA. And last week the Nagpur bench found no evidence to link the professor, or the others, to any terrorist act, and also cast doubts over "seizures" claimed by the state police. "Prosecution has failed to prove, beyond reasonable doubt, the case against the accused persons," a division bench of Justices Vinay Joshi and Valmiki SA Menezes had said last week. The court, further, held as "null and void" the sanction procured by the under UAPA, or the Unlawful Activities (Prevention) Act, and said, "Prosecution has failed to establish legal seizure or incriminating material against the accused."Referring to these, the Supreme Court set aside Prof Saibaba's sentence; this comes nearly 10 years after he was arrested and

lodged in Nagpur Central Jail in 2014. Justice Mehta called the professor's acquittal "hard-earned". The professor had been convicted of alleged Maoist links, and indulging in activities amounting to waging war against the country, by a sessions court in Gadchiroli district. Speaking after his release, he said he wanted to be reinstated and compensated for lost years of service; he had been fired Delhi's Ram Lal Anand College in 2021."I am still not able to register that

Despite these worries, they continued to attract significant investments from domestic mutual fund investors, with overall inflows reaching a 23-month high in February, as per data disclosed on Friday.HDFC Bank experienced a 1 per cent decline and emerged as the top loser on the Nifty, consequently dragging down the private bank index by 0.5 per cent.Citi downgraded the stock to "outperform" from "buy" and reduced the target price, citing challenges related to deposit growth and net interest margin recovery.Meanwhile, Tata group stocks such as Tata Consumer, Tata Steel, and Tata Motors recorded losses ranging between 0.9 per cent and 3 per cent.

HyFun Foods, which manufactures frozen potato products, on Wednesday said it will invest around Rs 850 crore to set up three plants in Gujarat to expand its business and achieve the targeted Rs 5,000 crore annual revenue by 2028. The company will also invest another Rs 150 crore to establish a water treatment plant in Gujarat.HyFun Foods has five potato processing plants in Mehsana district of Gujarat with an annual capacity of 2.5 lakh tonne. It sells more than 20 ready-to-cook frozen snacks such as french fries, potato patties (tikki), burger patties and nuggets to HoReCa (hotel, restaurants and canteens) segment, Quick Service Restaurants (QSR) and also in retail markets. It supplies to Burger King and KFC."We are setting up three new plants in Mehsana for potato flakes, french fries and potato speciality products," HyFun Foods MD and CEO Haresh Karamchandani said. He said the



construction of potato flakes plant has started and will be operational this year while the other two will come up by 2025end. Asked about investments on these three new plants, Karamchandani said it

would be around Rs 850 crore. That apart, he said the company plans to set up a water treatment plant, to treat waste water from its factories, with an investment of Rs 150 crore. The investments of Rs 1,000 crore

will be funded through internal accruals and bank loans. Asked about turnover, Karamchandani said it would be around Rs 1,300 crore this fiscal as against Rs 1,000 crore in the previous year. In volume also, it expects to achieve 30-35 per cent growth. Out of the company's current trunover, export markets contributes 70%. "We are targeting a revenue of Rs 2,000 crore in the next fiscal and Rs 5,000 crore by 2028," he said, adding that exports and domestic revenue would become equal by then.Karamchandani said the company is also expanding presence in retail, both physical and online. Its products are available in stores of Reliance Fresh. He said the company is also looking to expand portfolio of frozen food items beyond potatoes. It might go

for third party manufacturing to introduce such products. HyFun Foods buys potatoes from Gujarat, Uttar Pradesh and Madhya Pradesh.

New Delhi To flag the mismatches in payment of taxes in financial year 2023-24 (assessment year 2024-25) and the financial transactions made by persons or entities, the Income Tax Department has started sending emails and messages through SMSs to assessees.

The tax department on Sunday urged assesses, who have not paid taxes commensurate with financial transactions, to compute their advance tax liability correctly and deposit the due advance tax on or before March 15. The department is



undertaking an e-campaign that aims to inform such persons/entities of 'significant financial transactions", through email (marked as Advance Tax e-Campaign-Significant Transactions for AY 2024-25) and SMS.

"The Income Tax Department has received certain information on specific financial transactions undertaken by persons/entities during Financial Year taxes paid so far during the current financial year, the Department has identified such persons/entities where payment of taxes for FY 2023-24 (AY 2024-25) is not commensurate with the financial transactions made by the persons/entities concerned, during the said period," a statement issued by the Central Board of Direct Taxes (CBDT), Ministry of Finance said.

information of specified financial transactions of taxpayers from various sources. "To increase transparency and to promote voluntary tax compliance, this information is reflected in the Annual Information Statement (AIS) module and is available to the persons/entities for viewing. The value of 'Significant Transactions' in the AIS has been used for carrying out this analysis," it said.

This is another initiative of the department towards easing compliance for taxpayers and reinforcing its commitment towards enhancing taxpayer services, it added.To view the details of significant transactions, the persons/entities can log in to their efiling account and go to the compliance portal. On this portal, the e-campaign tab can be accessed to view significant transactions. Bumrah, Shami will trouble Australia: Paine raises concerns with batting unit

NZ vs AUS: Australia clinched a narrow victory over New Zealand in the 2nd Test match of the series. Despite a top-order failure, a strong middle-order action helped the side clinch a nervy 3-wicket win. The performance has prompted Tim Paine to criticise the team.

New Delhi. Australia clinched a narrow victory against New Zealand in the second Test match at Christchurch. A tremendous rearguard action from Mitchell Marsh, Alex

Carey and Pat Cummins helped Australia track down a total of 279 runs, despite being 80/5 at one point in time.Former Australia captain Tim Paine is not happy with the team's performance despite a 2-0 series sweep against New Zealand. Paine criticised the top order batters and said that they had been constantly failing since the West Indies Test series. In a scathing criticism, Paine said that this team would not be able to win against England and would not be able to compete vs India later in 2024 when the Rohit Sharma side visits the Australian shore.I'm disappointed. We're a better team than them (New Zealand) and it was the same against the West Indies, there seems to be a bit of a pattern. Not scoring enough runsâ€æ you can't always believe what they're telling you but the leadership and coaching and captain

and selectors say, 'we have no concerns with

our batters'. Well, I do now," Paine said on SEN Tassie Breakfast. Paine said that the Australians were concerned about the top order of Steve Smith, Usman Khawaja and Marnus Labuschagne, who have not been able to stitch a good run of form.

There are more questions coming out of the last three or four Tests than answers, and we

need to find some answers pretty quickly," Paine said on the show.Paine launched his attack on the Pat Cummins side and said that this team would not be able to face the Indian fast bowling which will include the likes of Jasprit Bumrah and Mohammed Shami.

'We might not beat New Zealand, we've

lost a Test to West Indies, we wouldn't beat England if they were playing well with a full-strength sideâ€æ India are certainly going to trouble us with Jasprit Bumrah, Mohammed Shami, Mohammed Siraj, Ravichandran Ashwin and Ravindra Jadeja, so there are some concerns," Paine further added. Australia have climbed up to the second spot in the World Test Championship table and are only behind India at the moment. Australia have 8 wins, 3 losses and 1 draw from 12 matches.
