Nashik. Congress MP Rahul Gandhi, along with the NCP(SP) chief Sharad Pawar and Shiv Sena (UBT) leader Sanjay Raut, on Thursday addressed the 'Kisan Makasalasatti Makasalasatti Nashida Nashi Mahapanchayat' in Maharashtra's Nashik on the sidelines of the Bharat Jodo Nyay Yatra.Known as the wine city of India, Nashik is a major producer of grapes, onions and tomatoes. During the mahapanchayat, several farmers shared their issues related to the Union government's policy on the export of tomatoes, grapes and onions. Speaking at the rally, farmers highlighted that when the produce of tomatoes was attracting good prices in the market, the Central government decided to import tomatoes from Nepal, which proved detrimental to prices in the wholesale market. Similarly, exports of onions were banned when they were fetching good prices in the market. Due to restrictions on onion exports, the Bangladesh government announced import duties on grapes, which affected the local farmers, farmers said."The government should at once give us a 3-foot rope so that we can hang ourselves and finish the topic. The BJP government's policies are anti-farmer. The company formed to export onions is Gujaratbased. They want local exporters to go out of



business," said Narendra Kaswal, an oniongrowing farmer, while speaking to India Today TV.Reassuring the farmers, Gandhi said, "The INDIA alliance government will be the voice of farmers and work to protect their interests.

Due to competition amongst traders, onion prices were increasing'

Mamata Banerjee Pushed From The Back Doctor Explains What He Really Meant

Kolkata. A day after stating that West Bengal Chief Minister Mamata Banerjee had a fall at her Kalighat residence "due to some push from behind" leading to injuries on forehead and nose, state-run SSKM Hospital director Manimoy Bandyopadhyay today clarified that all he meant was that the Chief Minister may have felt "a sensation of push".

Mamata Banerjee, 69, suffered a serious injury on her forehead and nose during a fall inside her Kalighat residence in South Kolkata on Thursday evening."This is a sensation of pushing from behind which led to the fall (of Ms Banerjee). Our job is to treat and we have done that. There was a misinterpretation of what I said last evening," Dr Bandyopadhyay said. The SSKM director on Thursday evening said that Banerjee had "a fall within the vicinity of her home due to some push from behind". Dr Bandypadhyay's "push from behind" theory sparked large-scale confusion and speculations over the cause of the Trinamool Congress supremo's fall. She underwent three stitches on her



forehead and one on her nose and was discharged following necessary medical tests, including radio imaging of her brain and ECG, at the hospital.Mamata Banerjee, who has been advised bed rest, was reported to be clinically "stable" this morning as doctors said they were planning to carry out a few routine checks during the day, a senior official of the SSKM hospital said. "The CM's health condition is stable. She had a good sleep in the night as senior doctors kept a close watch on her throughout the period. There will be another assessment of her condition," the official told news agency PTI on Friday. Asked about the speculations over the chief miniser's fall, a police officer told Press Trust of India, "As of now, there has been no complaint lodged in connection with her fall. New Delhi. The Gujarat High Court has decided to prioritise the petition of godman Asaram Bapu against his conviction in a rape case after noting that he was 85-yearsold and had served 10 years in prison. The High Court will start hearing Asaram Bapu's plea to suspend his prison sentence from April 4, a report in Bar and Bench said.

"He has undergone 10 years in prison and is 85-years-old. We will hear the main appeal itself instead of his plea for suspension of sentence," a division bench of Justices AS Supehia and Vimal Vyas said."Hearing of the main appeal or the plea to suspend sentence would need a similar amount of time. Thus, we will hear the main appeal from April 4," the court further said. Last year, Asaram Bapu was convicted by a trial court in Gujarat for raping a woman disciple on several occasions at his Surat ashram in 2013.He was also convicted by a POCSO court in Jodhpur and sentenced to life imprisonment for raping a teen girl in his ashram. N Biren Singh demands release of 3 members of Manipur armed outfit

Imphal. Manipur Chief Minister N Biren Singh has called upon the authorities concerned to release three members of the United National Liberation Front (UNLF) unless they are found guilty of any wrongdoing. Notably, three members of the Pambei-led United National Liberation Front (UNLF) were arrested in a joint investigation led by the National Investigation Agency (NIA) from Imphal West district in Manipur on Wednesday, March 13.Addressing the media on the sidelines of a government event in Imphal East's Nongmaiching, Singh said that the arrest of the three self-styled leaders of the UNLF (P) was made without the state government's knowledge. The Chief Minister added that he has requested the Union government for the early release of the arrested UNLF-P leaders if they are not guilty of any wrongdoing.

Singh further added that he had urged the central leaders to inform the state government whenever there is any possibility of arrests of such leaders in the future.

The chief minister added that he was informed by the sources that the arrests were made in connection with a case related to West Bengal. However, the exact reason behind the arrest is yet to be known.

Notably, the UNLF-Pambei group, the oldest armed group in Manipur, signed a peace agreement in New Delhi on November 29, 2023, after significant efforts by the central and state governments respectively.

Meanwhile, 12 civil society organisations have called for a general strike from Thursday midnight until Saturday midnight as a mark of protest against the arrest of the three Pambei-led UNLF cadres, including the

Police team attacked during raid to nab criminal in Kanpur, 3 arrested

At least three policemen were injured after being attacked by the family members of an alleged marijuana (cannabis) smuggler in Kanpur, police said on Thursday. The incident happened under the jurisdiction of the Jajmau police station when a police team raided the home of one Raja Rabbani, who was accused of smuggling marijuana. The raid was carried out under 'Operation Sudarshan', which had been launched by the Kanpur Police Commissioner against the smuggling of narcotic drugs. As the police team reached the home of the accused, his family members started pelting stones, resulting in minor injuries to two constables and one subinspector, identified as Rajan Singh.

Upon receiving the information about the attack on the police team, the additional police teams reached the spot and controlled the situation. The injured policemen were also rushed to Kanshi Ram Hospital for medical treatment.

Following the incident, a case was registered against 11 people, including Rabbani, under multiple sections of the Indian Penal Code (IPC), including section 307 (attempt to murder). At



least three women have been taken into custody, police said. Speaking about the incident, DCP East Shravan Kumar said, "... When a team from Jajmau police station raided the home of the accused, his family members tried to attack the policemen and also interfered in the government work. A case has been registered under multiple sections of the IPC, including section 307, and three people were arrested."

Tackling waste in coastal wards a major challenge for Thiruvananthapuram corporation

THIRUVANANTHAPURAM. Tackling waste in the coastal wards under the corporation area continues to remain a challenge for the city corporation. Even months after launching the Malinya Muktham Nava Keralam campaign and deploying Haritha Karma Sena for door-todoor waste collection, waste management continues to be a reeling issue in the densely populated coastal wards.

Lack of waste management infrastructure, hesitancy in paying waste handling fee and non-cooperation from the residents are some of the major issues prevailing in the 14 coastal wards coming under the Thiruvananthapuram corporation's jurisdiction. Poonthura, Vizhinjam health circles are the worst affected. The civic body has achieved around 90% waste collection coverage after the launch of the Malinya Muktham Nava Keralam campaign.

It is learnt that a large majority of the families are unable to adopt source-level waste management facilities, including kitchen bins and biogas plants, owing to space constraints. The monthly user-fee charged by the civic body for waste management is unaffordable for many families. Poonthura ward councillor Mary Jipsy said that the fee for food waste collection has been hiked and now each household has to pay '300 for handling biodegradable and nonbiodegradable waste."Haritha Karma Sena members are also struggling as timely payment of user fee is not happening; `300 is a huge sum for many families.



Thumburmuzhy aerobins are ineffective as the quantity of food waste is more. At present, the food waste is being carted away to pig farms by private service providers," she said. The wards coming under the Poonthura health circle comprising wards including Bheemapally East, Bheemapally, Puthenthoppu, Poonthura are the worst affected by the waste crisis. "People are not ready to avail of the services of Haritha Karma Sena. Its not affordable to them and the corporation council should take a call on

this and give waiver for such families from coastal wards," said a health official of Poonthura health circle.

The official said that the families are dumping or throwing waste into the sea. The health authorities have mooted the setting up of a biogas plant at Muttathara on the premises of sewage treatment plant (STP). "Lack of waste infrastructure is a major issue and the setting up of a biogas plant would help resolve the crisis. To begin with we have mooted a biogas plant that can treat 500 kg

waste and later we can scale up the capacity,' said the official. A senior official of the health wing under the city corporation said that the civic body has deployed Haritha Karma Sena in all 14 coastal wards.

The government has given waiver for disabled and elderly. The fisherman community doesn't come under this category and we have decided to give 50% discount in the user fee. A campaign is going on to educate the population in coastal wards," said the official.

UP Police paper leak: Pic leads STF to resort where 1k students were taken

Gurgaon. Away from the din of the city, a resort in Manesar has come under the scanner of STF sleuths probing the UP Police constable paper leak last month. Located 2.5km off NH-8 and 30kmfrom the city, it was at Nature Valley that around 1,000 aspirants ferried from different parts of UP and Haryana were handed question papers a few days before the police test on Feb 17 and 18. A photo taken by an aspirant and circulated on social media led cops to the resort. Nature Valley is the second resort in south Haryana to be linked to probes in connection with paper leaks in the past two months. In Jan, hundreds of students who were to appear for a foreign medical graduate exam had gathered at a resort in Nuh's Tauru to collect leaked question papers. Among those arrested in connection with the UP Police paper leak, three were from Harvana — Mahendra Sharma from Jind, Monu Sharma of Jhajjar and Vikram Dahiya from Sonipat. Vikram Pahal, a Delhi

Police constable, is believed to have orchestrated the leak.Mahendra (26) has told police he was taken to the Manesar facility by Vikram Pahal, who is from the same village in Jind as him. "Some 400 students were at the resort already 3-4 days before the exam was scheduled. Another 600 were ferried in 12 buses a little later," a police source A couple of months ago, a resort in Tauru quoted Mahendra as saying.Police sources said the aspirants were made to sit in a lawn of Nature Valley and handed out the question papers. They were also given answer keys and asked to memorise them.

"Some of the aspirants clicked a few pictures and recorded videos on their phones. One of these photos helped police trace the resort," the source said.Brajesh Singh, SP of the STF's Meerut unit, said a team of cops would visit the Manesar resort soon. "This is required for the investigation. We need to scan CCTV footage and collect as much evidence as possible. The help of local police will be taken if needed.

Legal action might be initiated against the owner and staff of the resort," he added.TOI reached out to Ashish Thakur, the general manager of the resort, but he denied any knowledge about the paper leak or the gathering of students. He also claimed to have left

came under the scanner of a police team that had gone to quell a clash among students. The cops later came to know that the youths had been asked to gather at the resort by the owner of a coaching centre who had promised to hand them question papers for a foreign medical test.Police said they were trying to find a link between the two cases. But police sources said such facilities were preferred by gangs because they were away from the cities and were less likely to come under the police's radar. Availability of space for hundreds of guests is another reason why these resorts on the outskirts are preferred, they added.

London. A plane carrying British Defense Secretary Grant Shapps had its satellite signal jammed as it flew near Russian territory, the government said on Thursday. The government said the Royal Air Force jet carrying Shapps, officials and journalists "temporarily experienced GPS jamming when they flew close to Kaliningrad" on a flight from Poland to the UK.The Times of London, whose reporter was onboard, said that for about 30 minutes, mobile phones couldn't connect to the internet and the aircraft was forced to use alternative methods to determine its location. Shapps visited Poland on Wednesday to see UK troops participating in a large Nato exercise, Steadfast Defender.

Kaliningrad is a Russian enclave bordered by Poland and Lithuania, home to the Russian Navy's Baltic Fleet.Prime Minister Rishi Sunak's spokesman, Dave Pares, said "the jamming didn't thraten the safety of the aircraft at any point". He said it was not unusual for aircraft to experience electronic jamming near Kaliningrad. Western officials say Russia has significant electronic warfare capabilities based in Kaliningrad. Since Moscow's invasion of Ukraine in 2022. Puscia has engaged in GPS imming in areas 2022, Russia has engaged in GPS jamming in areas from Finland to the Black Sea.

Israeli strikes kill 29 Gazans waiting for aid, say Palestinian officials

Cairo. At least 29 Palestinians were killed while awaiting aid in two separate Israeli attacks in the Gaza Strip on Thursday, Gaza's health ministry said. In the first incident, Palestinian health officials in the Hamas-ruled strip said eight people were killed in an airstrike on an aid distribution centre in Al-Nuseirat camp in the central Gaza Strip.Later, at least 21 people were killed and more than 150 wounded by Israeli gunfire at a crowd awaiting aid trucks at a northern Gaza roundabout, Gaza's health ministry

In a statement, Israel's military denied attacking aid centres, describing the reports as "false."

"As the IDF (Israel Defense Forces) assesses the incident with the thoroughness that it deserves, we urge the media to do the same and only rely on credible information," the statement said.

The Gaza conflict has displaced most of the enclave's 2.3 million population. Chaotic scenes and deadly incidents have taken place during aid distributions as desperately hungry people scrambled for food.

On February 29, Palestinian health authorities said Israeli forces shot dead more than 100 Palestinians as they waited for an aid delivery near Gaza City. Israel blamed the deaths on crowds that surrounded aid trucks, saying victims had been trampled or run over.

In Deir Al-Balah, also in central Gaza, an Israeli missile hit a house on Thursday, killing nine people, Palestinian medics said. Residents said Israeli aerial and ground bombardments persisted overnight across the enclave, including in Rafah in the south, where over a million displaced people are sheltering. The war was triggered by a Hamas-led attack on southern Israeli towns on October 7 that left 1,200 people killed and 253 taken hostage, according to Israeli tallies. Since then, Israel's air, sea and ground assault on Gaza has killed more than 31,000 people and wounded over 71,500, according to Gaza health authorities. Efforts to reach a ceasefire between Israel and the Islamist militant Hamas have so far failed. While Israel said it sought a deal that would secure the release of hostages in Gaza in exchange for the release of Palestinians held by Israel, Hamas insists an agreement should end the

Father of Michigan school shooter convicted of manslaughter

A jury in the US state of Michigan on Thursday convicted the father of a teenager who fatally shot four classmates at a high school near Detroit of manslaughter after prosecutors argued he bore responsibility because he and his wife gave their son a gun and ignored warning signs of violence. James Crumbley, 47, was found guilty in his trial, carried out a month after his wife. Jennifer Crumbley, was found guilty on manslaughter charges stemming from the shooting. James Crumbley faced four counts of involuntary manslaughter, one for each of the victims at Oxford High School in the 2021 shootings. Jurors began deliberating on Wednesday.

Both James and Jennifer Crumbley will be sentenced on April 9. Manslaughter carries a penalty of up to 15 years in prison. The couple's son, Ethan, was 15 at the time of the shooting at Oxford High School involving a semi-automatic handgun. He pleaded guilty in 2022 to four counts of first-degree murder and other charges and was sentenced to life in prison without parole in December. The US, a country with persistent gun violence, has experienced a series of school shootings over the years, often carried out by current or former students. The Crumbleys were the first parents to be charged with manslaughter in a child's school shooting.

This is a very egregious and rare, rare set of facts," Oakland County, Michigan, prosecutor Karen McDonald told the jury during closing arguments on Wednesday.McDonald said James Crumbley repeatedly ignored warning signs that his son was deeply disturbed, did not get him the help he needed, and did not do enough to safely store the firearm in the family home."He did nothing over and over and over again," McDonald said.

McDonald also presented the jury with texts that Ethan Crumbley had sent to a friend and journal entries he had written in the months leading up to the shooting, in which he talked about wanting medical attention and hearing voices, but he was worried his parent would be "pissed".On one occasion, according to a text message to a friend, McDonald said that Ethan had asked James Crumbley to take him to the doctor, but his dad "gave me some pills and told me to suck it up.

Defence attorney Mariell Lehman argued that James Crumbley could not have possibly foreseen that his son would carry out a mass shooting."James had no idea that his son was having a hard time," Lehman told jurors during her closing argument, saying no evidence had been presented that James knew the contents of his son's text messages or journal.Gun safety experts have said they hope the Crumbley trials serve as a wake-up call for parents to better secure weapons in their homes.

About 75 per cent of school shooters obtained the guns used in attacks from their own homes, according to government research.

French Parliament votes to 'limit excesses' of low-cost fast fashion

Paris. The French Parliament on Thursday backed a series of measures making lowcost fast fashion, especially from Chinese mass producers, less attractive to buyers.

The vote makes France the first country in the world "legislating to limit the excesses of ultra-fast fashion", said Christophe Bechu, minister for coolegied transition Very magnetical ecological transition. Key measures include a ban on advertising for the cheapest textiles, and an environmental charge slapped on low-cost items. The French clothes market has been flooded with cheap imported clothes, while several homegrown brands have declared bankruptcy.But the main arguments put forward by Horizons -- the party allied to President Emmanuel Macron submitting the draft law -- were environmental.

Textile is the most polluting industry," said Horizons deputy Anne-Cecile Violland, saying the sector accounted for 10 per cent of greenhouse gas emissions and was a major polluter of water. She singled out Chinese company Shein and its "7,200 new clothing items per day" as a prime example of intensive fashion production.



France will apply criteria such as volumes of clothes produced and turnover speed of new collections in determining what constitutes fast fashion, according to the law.Once the law comes into force --which still requires a vote in the Senate --

precise criteria will be published in a decree.Fast fashion producers will be forced to inform consumers about the environmental impact of their output.

5.45) per item is planned from next year, rising to 10 euros by 2030. The charge cannot, however, exceed 50 percent of an item's price tag. Violland said the proceeds from the charge would be used to subsidise producers of sustainable clothes, allowing them to compete more easily. A measure to limit advertising for fast fashion was also approved, although conservative lawmaker Antoine Vermorel-Marques remarked that "a ban on advertising for textiles, especially fashion, spells the end of fashion". An initiative brought by left-wing and Green party deputies to include minimum penalties for producers breaking the rules as well as import quotas and stricter workplace criteria in the industry into the new law was struck down.High-end fashion is a cornerstone of the French economy thanks to leading global luxury brands like Louis Vuitton, Chanel, Hermes, Dior and Cartier.But the French lower-end fashion segment has lost ground to European rivals Zara, H&M and, more recently, to Chinese behemoths

Europe must be ready for war if it wants peace: France's Macron

Paris. French President Emmanuel Paris. French President Emmanuel Macron called President Vladimir Putin's Russia an adversary that would not stop in Ukraine if it defeated Kyiv's troops in the two-year-old conflict, urging Europeans to not be "weak" and to get ready to

Macron caused controversy last month after he said he could not rule out the deployment of ground troops in Ukraine in the future, with many leaders distancing themselves from that, while others, especially in Eastern Europe, expressed support."If Russia wins this war, Europe's credibility will be reduced to zero," Macron said in a television interview mostly directed at a domestic audience, after French opposition leaders criticised his comments as bellicose.Macron said he "deeply" disagrees with the opposition leaders. "Today, deciding to abstain or vote against support to Ukraine, it's not absorbed to a support defeat. choosing peace, it's choosing defeat. It's different," he said. Macron's main opposition party, the far-right of Marine Le Pen, abstained in parliament on a vote earlier this week about a security pact France signed with Ukraine, while the hard-left



France Unbowed party voted against it."If war spread in Europe, Russia would be to blame," Macron added. "But if we decided to be weak; if we decided today that we would not respond, it would be choosing defeat already. And I don't want that."He said it was important for Europe not to it was important for Europe not to draw red lines, which would signal weakness to the Kremlin and encourage it to push on with its invasion of Ukraine. He refused to give details on what a deployment to Ukraine might look like.

"I don't want to do so. I want Russia to stop this war and retreat from its positions and allow peace," he said. "I'm not going to give visibility to someone who is not giving me any. This is a question for President Putin." "I have reasons not to be precise," he said.Macron said France would never initiate an offensive against Russia, and that Paris was not at war with Moscow, despite the fact that Russia had launched aggressive attacks against French interests in and outside France."The Kremlin regime is an adversary," he said, declining to call Russia an enemy. He also

said Putin making threats about nuclear strikes was "not appropriate". Macron said Ukraine was in a "difficult" situation on the ground and that stronger support from allies was necessary."Peace does not mean the capitulation of Ukraine," he said. "Wanting peace does not mean defeat. Wanting peace does not mean dropping Ukraine," he said.He also said he hoped that the time would come one day to negotiate peace with a Russian president "whoever it might be", for the first time envisaging the possibility of Putin no longer being in charge in Russia.Macron also said he had not cancelled a planned visit to Ukraine for security reasons. "That's what Russia said. You shouldn't believe them," he said.

The Centre implemented the Citizenship Amendment Act on Monday, March 11, paving the way for the grant of citizenship to



undocumented non-Muslim migrants from arrived in India before December 31, 2014.

Amid protests by opposition parties, the government issued a press statement stating that Indian Muslims need not worry as the CAA will not affect their citizenship status and assured that it has no bearing on the community, which enjoys equal rights as their Hindu counterparts.

Judge rejects bid by Donald Trump to dismiss classified documents case

World. A federal judge on Thursday rejected a bid by Donald Trump to throw out his classified documents criminal case, and appeared skeptical during hours of arguments of a separate effort to scuttle the prosecution ahead of trial.US District Judge Aileen Cannon issued a two-page order saying that though the Trump team had raised "various arguments warranting serious consideration," a dismissal of charges was not merited. The case involves boxes of records, some highly classified, that Trump took to his Mara-Lago estate when he left the White House.Cannon, who was appointed to the bench by the former president, had made clear during more than threeand-a-half hours of arguments that she was reluctant to dismiss one of the four criminal cases against the 2024 presumptive Republican presidential

nominee. She said at one point that a dismissal of the indictment would be "difficult to see" and that it would be "quite an extraordinary" step to strike down an Espionage Act statute that underpins the bulk of the felony counts against Trump but that his lawyers contend is unconstitutionally vague. The ruling from Cannon is a modest win for special counsel Jack Smith's team, which in addition to the classified documents case, is pursuing a separate prosecution of Trump on charges that he plotted to overturn the results of the 2020 presidential election.But it left unanswered questions over when the case might proceed to trial and only covered one of the two motions argued in court on Thursday. A separate motion about whether Trump was permitted under the Presidential Records Act to retain

the documents after he left the White House remains pending, but the judge also seemed disinclined to throw out the case on those grounds."It's difficult to see how this gets you to the dismissal of an indictment," she told a Trump lawyer.Trump attended Thursday's arguments, listening intently with his hands sometimes clasped in front of him on the defense table as his attorneys pressed Cannon to throw out the case. The hearing was the second this month in the case in Florida, which has unfolded slowly in the courts since prosecutors first brought charges last June. Cannon heard arguments on March 1 on when to schedule a new trial date - it was initially set for May 20 — but has yet to announce one and gave no indication on Thursday of when she might do so. Mohammad Mustafa, Palestinian President's longtime adviser, appointed PM

Palestinian. President Mahmoud Abbas has appointed his longtime economic adviser to be the next prime minister in the face of US pressure to reform the Palestinian Authority as part of Washington's postwar vision for Gaza.Mohammad Mustafa, a USeducated economist and a political independent, will head a technocratic government in the Israeli-occupied West Bank that could potentially administer Gaza ahead of eventual statehood. But those plans face major obstacles, including strong opposition from Israeli Prime Minister Benjamin Netanyahu, and the Israel-Hamas war that is still grinding on with no end in sight.It's unclear whether the appointment of a new Cabinet led by a close Abbas ally would be sufficient to meet US demands for reform, as the 88-year-old president would remain in overall control."The change that the United States of America and the countries of the region want is not necessarily the change that the Palestinian citizen wants," said Hani al-Masri, a Palestinian political analyst.

"People want a real change in politics, not a change in names... They want elections."He said Mustafa is "a respected and educated man" but will struggle to meet public demands to improve conditions in the occupied West Bank, where Israeli restrictions imposed since the start of the war have caused an economic crisis.In a statement announcing the appointment, Abbas asked Mustafa to put together plans to reunify administration in the West Bank and Gaza, lead reforms in the government, security services and economy and fight corruption. Mustafa was born in the West Bank town of Tulkarem in 1954 and earned a doctorate in business administration and economics from George Washington University. He has held senior positions at the World Bank and previously served as deputy prime minister and economy minister. He is currently the chairman of the Palestine Investment Fund. The previous prime minister, Mohammad Shtayyeh, resigned along with his government last month, saying different arrangements were



needed because of the "new reality in the Gaza Strip."The Palestinian Authority was established in the 1990s through interim peace agreements and was envisioned as a stepping-stone to eventual statehood.But the peace talks repeatedly collapsed, most recently with Netanayahu's return to power in 2009. Hamas seized power in Gaza from forces loyal to Abbas in 2007, confining his limited authority to major population centers that account for around 40% of the Israeli-occupied West Bank. Abbas is deeply unpopular among Palestinians, many of whom view the PA as little more than a subcontractor of the occupation because it cooperates with Israel on

security matters. His mandate ended in 2009, but he has refused to hold elections, blaming Israeli restrictions. Hamas won a landslide victory in the last parliamentary elections, in 2006. Although it is considered a terrorist group by Israel and Western countries, Hamas would likely perform well in any free and fair vote. Abbas, unlike his Hamas rivals, recognises Israel, has renounced armed struggle and is committed to a negotiated solution that would create an independent Palestinian state alongside Israel. That goal is shared by the international community. Israel has long criticized the PA over payments it makes to the families of Palestinians who have been killed or imprisoned by Israel, including top militants who killed Israelis. The PA defends such payments as a form of social welfare for families harmed by the decades-old conflict. The dispute has led Israel to suspend some of the taxes and customs duties it collects on behalf of the PA, contributing to years of budget shortfalls. The PA pays the salaries of tens of thousands of teachers.

10-year-old boy sexually assaulted and murdered by minor in Tamil Nadu

Dharmapuri. A 10-year-old boy was allegedly sexually assaulted and murdered by a 17year-old boy studying in 12th standard in Tamil Nadu's Dharmapuri district. The boy studying in the 5th standard from the district went missing on Wednesday afternoon. Worried over their son's disappearance, the parents began to search and learned, with the help of villagers, that the boy had gone along with a 17-year-old. The parents then filed a missing person report with the police. From the CCTV footage acquired, the police could conclude that the victim along with the 17-year-old boy went into the field, but the latter returned alone.Based on the evidence, the police detained the suspect in the murder of the 10-year-old. Upon questioning, he said



that he pushed the child into a well. A fire and rescue team reached the spot and after searching for the whole night, the child's body was recovered. The body was then sent to a government hospital for autopsy. The accused had also allegedly confessed to having sexually assaulted the boy and fearing that he might tell others had pushed him into the well and killed him. Stating that the accused had taken the child promising him to give him mangoes, the victim's uncle said, "We are extremely depressed. He was a 10year-old innocent child. I request the Chief Minister to give maximum punishment to make sure no one else do such mistakes.

What to do? Clean vessels, cook food, wash clothes....so, we have started using paper plates, that way we have cut down on our water usage. And we order food twice a week. We are using the washing machine only once in a week now," she said.

Some others have resorted to visiting a mall to take a shower or use the toilet facilities. Latest and Breaking News on

Lakshmi V, an IT professional living in

Singasandra, has been requesting her firm to allow WFH option so that she and her family can temporarily shift to her native place in Tiruchirapalli in Tamil Nadu until the situation becomes better.

If the situation persists, we are thinking of seeking a work from home option. We are planning to move to our native place in Tamil Nadu temporarily till rain arrives here," she said. Bengaluru primarily gets its water supply from two sources - Cauvery river and groundwater. For most non-drinking uses, recycled water processed by sewage treatment plants is used. With no rain for a while now, the primary sources have been stretched to their limits. Bengaluru needs 2,600-2,800 million litres of water daily, and the current supply is half of what's required. The result is a daily struggle for the city's residents.

living in the outskirts of Bengaluru, especially in 110 villages that were merged with the city in 2007. Pawan Kalyan justifies 'sacrifice' in seat-sharing formula with TDP, BJP

"Jana Sena chief and actor Pawan Kalyan, speaking exclusively to India Today, said his party made sacrifices for the greater good of Andhra Pradesh while achieving the seat-sharing formula with the TDP and the BJP.

Mangalagiri. Jana Sena Party (JSP) chief and actor Pawan Kalyan, in an exclusive interview with India Today TV, said that the alliance between the JSP, TDP and BJP is for the "greater good" and he had to "sacrifice" seats for it. The seat-sharing among the Telugu Desam Party, the BJP and the Jana Sena is final. While the TDP will contest on 17 of the 25 Lok Sabha seats in Andhra Pradesh, the BJP will contest on six seats and the Jana Sena on two seats. This means Jana Sena's original figure of three has been reduced by one.Likewise, in the assembly elections, in order to accommodate the BJP's wish to contest in 10 constituencies, Jana Sena's original number of 24 has been reduced to 21. The Telugu Desam will contest 144 of the 175 seats. In his interview. Kalvan said that he knows what it means



to lose seats being a "middleman"."I was able to give few candidates seats, and in this alliance (TDP-JSP-BJP), in the talks, we had to sacrifice a few seats. In that, it was our candidates, we lost/had to sacrifice. I very well understand what it means to lose being the middleman [sic]," he said."When we go with a big heart, we so happen to become the ones who have to make cuts. But it is good because I went with good intentions and was able to make cuts, for the five crore people, sacrificing five or ten of our people was good, I feel," Kalyan added. The actor-politician also used a saying from the ancient Indian text Vidura Neeti to explain his party's "sacrifice" in forging the alliance in Andhra

Pradesh.Speaking to India Today TV, Kalyan highlighted that he was "forced to even sacrifice" the Lok Sabha seat of his brother Naga Babu. In 2019, he contested from Narasapuram seat but lost to YSRCP's candidate."In Vidur Neeti, there is a saying which goes like this: 'for a family, a man, for a village a family and for a kingdom (rajyam) a village sacrifice' in a similar manner, for the people of Andhra Pradesh, for the welfare of the state, we had to make a few sacrifices. We were forced to even sacrifice the parliament seat of my own brother, Naga Babu. [sic]," Kalyan said.

"He (Naga Babu) is someone who taught me history lessons, who plays a huge role in my life, and still despite giving him my word on a ticket, in this alliance, the only solution for me was to sacrifice it," he added.Kalyan further said that even after losing the Lok Sabha seat, his brother vowed to work for the party and stands by him."In all that, today my brother sent me a letter saying, he'll stand by us no matter what and help in whichever way possible to help ensure we win across the 21 seats. And help win in all places wherever our alliance partners stand. I want to wholeheartedly thank my brother for his statement and belief," he said.

SARPA brings down snakebite fatalities in Kerala

THIRUVANANTHAPURAM. As summer peaks, the state is facing an increased threat of snakebites. Experts advise caution as snakes turn more aggressive during summer which is their mating season.During 2018-19, a record number of 123 snakebite deaths had happened in the state followed by 71 deaths in 2019-20. Thanks to SARPA (Snake Awareness, Rescue and Protection app) mobile application launched by the state forest department in 2020, the number of casualties due to snakebites has come down.

Annually, 12,000-15,000 calls are received by a trained group of 700 active volunteers from across the state which advises on giving immediate first-aid to the victim and also guides them to the nearest hospital where antivenoms are available. It has been found that the villain behind the maximum snakebite deaths reported from the state is Cobra. During 2020-21 the casualties had come down to a further 52. Statistics reveal that an average of 1,250 calls are received by SARPA volunteers every month. During the 2023-24 fiscal,

34 deaths have been reported due to snakebites so far. The SARPA's 2,400 certified volunteers which include 700 active volunteers get the maximum calls from Palakkad, Thrissur, Kannur and Ernakulam districts.Y Mohammed Anwar, assistant conservator of forests and state nodal officer for snake rescue who also heads the Special Investigation Team in Kollam told TNIE, "Palakkad experiences humid conditions more compared to other districts which triggers the snakes to come out of their pits. Krait is a typical nocturnal snake which has been widely found in Palakkad. Deaths due to Krait bites have also been reported. But the maximum deaths due to snakebites is caused by Cobra," said Mohammed Anwar.Herpetologist Sandeep Das who is also one of the admins of the popular FB group told TNIE, "Currently, we are undertaking a scientific study to evaluate the reasons behind the number of snakebite deaths coming down. I feel that there are multiple reasons for it. Apart from the SARPA app, medical facilities have been improved in hospitals.

University seeks students' voter ID, drops move after flak

CHENNAI. The Tamil Nadu Teachers' Education University (TNTEU) on Thursday courted controversy by issuing a circular, asking principals of its affiliated colleges to collect details of voter ID numbers of their students.

However, the circular was swiftly withdrawn. The circular issued by the registrar (in-charge) said that "oral instructions have been received from the office of the honourable governor, Raj Bhavan, to collect details of voter ID numbers of the students" admitted in the colleges of education affiliated to the university.

It asked all the principals of its affiliated colleges to treat the matter as "most urgent" and asked them to submit the details in a spreadsheet on or before March 19 "for onward transmission to the governor's secretariat". The proforma included the name of the college, the name of the student, their registration number, the programme to which the student is admitted and his/her voter ID.It may be recalled that Governor RN Ravi had a meeting with vice-chancellors

and administrators of all state universities on March 11, and discussed with them about ensuring cent per cent voting of first time voters.



He had directed the V-Cs to sensitise first time voters. To encourage the V-Cs, the governor had said in the meeting that colleges and university departments with 100% voting and universities that record highest percentage of voting will be felicitated.

India needs more pacts to boost exports

INDIA'S share of global trade is currently only about two per cent in contrast to 14 per cent for our northern neighbour, China. The country has so far not been able to become a major trading nation in the merchandise segment, though services exports in contrast are growing at a swift pace. The situation is not helped by the fact that we are not part of any major regional trade grouping. The decision to stay away from the Regional Comprehensive Economic Partnership stemmed from a fear of being overrun by imports from China. But it has not been possible to make up this lacuna by merging into any of the overarching larger groups like the Trans-Pacific Partnership.

It is in this backdrop that one must view the drive to tie up more regional and bilateral trade pacts. After concluding major agreements with leading trade partners like the UAE, Australia and Mauritius, a deal has now been struck with the four-member European Free Trade Association (EFTA). Others are being negotiated, including one with the country's biggest trade partner, the European Union (EU), the UK and Oman. There are also reports of discussions with the Gulf Cooperation Council comprising seven countries in the region. The fact that such talks are now proceeding apace indicates the country's increasing clout on the world stage as its concerns over protecting domestic interests are being given more thoughtful consideration by trading partners. The previous intractable approach in negotiations taken by the country's trade diplomats also seems to have been replaced by an appreciation of the larger picture. The fact is that allowing foreign business to have easier access to the domestic market will similarly ensure deeper access for Indian agriculture and industry to the lucrative developed economy markets. It has also been accepted that issues like sustainability, which were earlier dismissed as non-trade barriers, should be brought on board.

It is clearly the difference in approach on both sides that is leading to a much quicker conclusion of such pacts. In the case of the India-EFTA agreement, talks had originally been launched as far back as 2008, but they were called off in 2013. It took another decade for them to resume in 2023. The pact has now become a reality within a year. Similarly, negotiations with the country's largest trading partner, the EU, began in 2007 but were suspended in 2013. These were revived in 2022. With elections round the corner, it looks as if agreements with both the EU and the UK will have to await the formation of a new government. The tie-up with the EFTA, however, has been made in time to ensure that the benefits are available by next year. This particular one did not initially attract much attention, given the few countries in the grouping. This is unlike the one with the EU, which has been under much greater scrutiny. The EFTA, on the other hand, comprises only Switzerland, Norway, Iceland and the tiny principality of Liechtenstein, with two-way trade estimated at \$18 billion. The biggest trade partner of India in the group is Switzerland and the bulk of transactions with it comprise gold imports.

Yet, it must not be forgotten that this relatively small country is a major global financial and business hub. Apart from its legendary banking system, it is known for its pharmaceuticals and dairy production. It is also, in a sense, a window to Europe. Thus, the opening up of as many as 120 out of the 156 services in the pact will give a boost to Indian professionals in the IT and financial sectors. Significantly, services exports to EFTA countries are about \$5 billion annually, as compared to \$2 billion of merchandise exports. In contrast, India is not likely to benefit much from the pact in terms of tariffs as Switzerland has just announced the abolition of import duties on industrial goods from all over the world. Effectively, this means that India will have no advantage over other countries in terms of tariffs on its exports. Even so, the trade pact has become path-breaking for including investment commitments. EFTA members have pledged to provide \$100 billion of investment over the next 15 years to India.

A strategic handshake with Dragon would be in mutual interest

To pay back China in the same coin and create a pressure point for hard bargaining, India needs to play up the Taiwan issue, creating ambiguity about its status.

THE stated government policy regarding the bilateral engagement with China is predicated on restoring peace and tranquillity along the Line of Actual Control (LAC); this includes de-escalation and disengagement in east Ladakh. Overemphasis on this aspect can well be interpreted as a strident stance reflective of a strong political will, but not pragmatism. China is not only our biggest neighbour but also a major international power with whom it would be prudent to remain engaged on a variety of issues of mutual interest and at various forums.

Despite the tensions on the borders, India and China continue to be important members of international groupings like the Shanghai Cooperation Organisation and BRICS. In fact, the latter is expanding in a big way, with several nations around the globe seeking its membership. India and China have been on the same page at various fora, like the IMF and the WTO, and have expressed their solidarity against the position adopted by developed countries. Both nations also share a long history of cooperation and coordination on environmental issues at global platforms. Despite China's deep concerns about the Quad grouping, it would understand that India is strategically autonomous. The economic engagement in terms of India-China trade ties has been on the rise and it has been one of our largest sources of imports for the past 15 years despite efforts to reduce this dependency through import substitution and free trade agreements with ASEAN countries. This has resulted in an increasing trade deficit, skewed in favour of China. However, despite these commonalities, the tense and inimical situation on the LAC is likely to continue, with the possibility of unpleasant face-offs between the Indian Army and the PLA. The military commander-level talks in east Ladakh have meandered on and become an exercise in filibustering by the Chinese. The Indian Army has responded strongly and built up its capabilities with enhanced deployment of troops and equipment. In short, for us, it's a policy of containment on the northern borders and calibrated engagement on other issues. In this kind of setting, India has to keep its leverages well-honed. Surprisingly, we have not optimised these aspects in the past and followed a path of appeasement against a wily and shrewd adversary like China.

First and foremost is the Tibet issue, which seems to have increasingly lost salience internationally. The fact that the spiritual and political head of Tibet was given sanctuary in India was seen as a hostile act by the Chinese. That the Central Tibetan Administration (CTA), also labelled as the Tibetan Government-in-Exile, was allowed to be set up in Dharamsala has always irked the Chinese Communist Party. In 1959, it was a bold move, but over the years, the Chinese hysteria about Tibet and 'splittist' Tibetans has seen India go overboard in trying to downplay this card. This attitude towards a



country that makes no attempt to hide its views about J&K, disregarding Indian sensitivities, is puzzling. China has no compunction in obstructing Indian efforts at the UNO to include Pakistani perpetrators of terrorism on the list of designated terrorists. That a permanent member of the Security Council behaves in such an egregious fashion only shows that it places the narrow interests of its close ally - Pakistan - over international obligations.

The CTA now increasingly controls political aspects, with the Dalai Lama stepping into the shadows, though it is his charisma that continues to be the principal asset of the Tibetan cause. The future of the institution of the Dalai Lama is somewhat uncertain, with the present incumbent, who is getting on in years, having even mentioned that it may cease after his demise. The Chinese as well as the Indian government may have their own game plans, but the CTA is here to stay and needs to be played up in a manner which becomes a leveraging point for India. Taiwan is the most sensitive issue for China, with the US playing hot and cold in the game of power politics in the South China Sea. India, while recognising the one-China principle, has semi-formal contacts and relations with Taipei. The India-Taipei Association in Taiwan and Taipei Economic and Cultural Centre in India are quasi- missions that recognise the extensive trade relations between India and Taiwan. Visits by retired chiefs of the armed forces, politicians and artistes recognise the fact that Taiwan cannot be wished away. Interestingly, PM Narendra

Modi had visited Taiwan in 1999, when he was a BJP functionary. A bilateral investment agreement with Taiwan has been in force since 2005 and was revised in 2018, reflecting a robust and growing economic relationship with potential.

This needs to continue and gather more substance. Communist China has blatantly disregarded Indian sensitivities about Kashmir's territorial inviolability as an integral part of this country by building the China-Pakistan Economic Corridor, which runs through Pakistan-occupied Kashmir. To pay back in the same coin and create a pressure point for hard bargaining, India needs to play up the Taiwan issue, creating ambiguity about its status.

Beyond all this, India needs to look at a lasting solution to the vexed LAC issue, with its multiple disputed and sensitive points, which are on the rise. China's leadership is a master of procrastination on troublesome issues, as per its political calculus. However, that should not deter our leadership from endeavouring to resolve a macro problem which impacts both security and economy. While the next government in India is expected to prioritise development and economic progress, it would possibly have the best opportunity for resolving the border issue with China in a comprehensive manner. This would entail some give and take, for which the political narrative would have to be built, seeking a satisfactory solution. A strategic handshake with the Dragon across the Himalayas would surely be in mutual interest.

Biden vs Trump

Bitter election rematch on the cards

THE stage is set for an election rematch between US President Joe Biden (81) and his predecessor Donald Trump (77) in November after they secured their parties' presidential nominations with thumping victories in key primaries this week. Biden will formally be declared the party's candidate during the Democratic National Convention in Chicago in August, while Trump will be officially nominated at the Republican National Convention in Milwaukee in July. This will be the first presidential rematch since 1956, when Republican Dwight D Eisenhower had defeated his Democratic rival Adlai Stevenson for the second time in four years.Both Biden and Trump are likely to give no quarter to each other

has warned that the threat Trump poses is greater than ever. Appealing to voters to make a choice for the sake of the country's future, he has asked them: 'Are we going to



stand up and defend our democracy or let others tear it down?' Pulling no punches, Trump has dubbed Biden the worst President in US history. What makes the 2024 contest starkly different from the one fought in 2020 is that

Trump is facing over 90 felony charges. Later this month, he will become the first former American president to go on trial in a criminal case; he is accused of falsifying business records to hide hush money payments to a porn star. It's obvious that Trump's legal battles will run parallel to his electoral campaign, and he will leave no stone unturned to play the victim card to consolidate his vote bank. It's hard to say whether Americans will be voting for the better candidate or the lesser evil. A new opinion poll sums up the state of affairs: about 36 per cent of the respondents say they trust Trump, while 33 per cent believe in Biden; the rest trust neither. Around one in five Americans has an unfavourable

impression of both the current and the former President. Whether this significant group votes — and for whom will have a bearing on the poll outcome.

How coalition politics impacts electoral prospects

China has made no secret of its intent to recreate the Left alliance. Prachanda, though, has steered the ship deftly, balancing China with India.

INDIA witnessed the dawn of coalition politics at the Centre when the Janata dispensation led by Morarji Desai took charge in 1977. Subsequently, several multi-party governments have ruled the country.

In general, it makes sense for some coalitions to exist, given the shared interests of their constituents. Some electoral alliances appear a bit tricky, though. Take the example of West Bengal. The Trinamool Congress (TMC) and the Congress united against the then ruling Left Front in the 2011 Assembly elections; five years later, the Left Front and the Congress formed an alliance against the ruling TMC. Many political analysts expressed concern when the Left and the Congress formed a pre-election coalition with the newly formed Indian Secular Front in the 2021 Assembly elections. In Indian politics, there are neither permanent friends nor permanent enemies. "Constituent members regularly switch sides depending on the whims of their party leaders, statespecific policy concerns and sheer political expediency," Milan Vaishnav and Jamie Hintson wrote in the context of the 2019 Lok Sabha elections.

However, does an alliance inevitably result in an increase in the political parties' vote share and number of seats? In a coalition, vote shares are typically not additive. In the context of the aforementioned West Bengal Assembly elections, there are still many experts who question whether the alliance with the Congress in 2011 helped the TMC, or if it helped the Left in 2016. Furthermore, the Left Front is still reeling from the 2021 election debacle. The term 'coalition' is derived from the prefix 'co-' ('together') and the Latin verb 'alescere' ('to grow'). A coalition should, thus, be judged by how the participating parties benefit from it. There is a growing body of research in economics, especially in the field of game theory, on coalition formation, which is the process by which one or more 'coalitions' consciously come



together to decide on actions as a group. Players establish alliances, break them up later, and even reform in shifting alliances, all the while reaping 'payoffs' (according to them) based on the coalition structure prevailing at the moment. Both the cooperative game theory and non-cooperative bargaining models are applied. Numerous studies have been conducted to comprehend the ways in which pre-poll coalitions influence voting behaviour in different countries. A 2020 research paper titled 'How do coalition signals shape voting behaviour? Revealing the mediating role of coalition expectations', which was published in the journal Electoral Studies, makes a reference to a survey experiment carried out during Sweden's 2018 general election. According to a recent paper published in Nature titled 'Pre-electoral coalition agreement from the Black-Scholes point of view', political parties can be regarded as companies whose value depends on the percentage of the population supporting a party. To study the dynamics, D Mitrovic of the University of Vienna drew an analogy with option modelling, where the stock price behaves similarly to the voters' support. The June 2023 elections in Montenegro were elaborated as per this model. Conditions in India, though, might be different. When election time arrives, leading national parties invariably calculate the election math in unique ways to form a winnable coalition. The strategists might differ in their approaches and, typically, the masses are unaware of the details. In general, how would one comprehend that a coalition would be effective? It is never easy. Assume that five political parties — say P, Q, R, S and - are competing in a constituency. Their possible vote shares are 33 per cent, 26 per cent, 7 per cent, 23 per cent and 11 per cent, respectively. In the event of

no coalition, P ought to win handily. Let us now assume that O and R have formed a coalition. If, in effect, their votes are simply totalled, it would be a tight contest between P and Q+R. However, a coalition doesn't guarantee that the votes will be added straight. The coalition may unnerve certain voters. For example, some Q supporters may not want to vote for an R candidate running in their constituency, and vice versa. Because of this, Q+R's total vote share may become substantially lower than P's. Then again, a percentage of S or T voters may cast 'strategic votes' in support of P, increasing the likelihood that P will win. One should remember that sometimes, no coalition may be better than one. Alternatively, voters may experience a 'bandwagon effect' or a wave of support for the Q+R coalition, which would lead to a significant win for the combine. Therefore, it is crucial to comprehend how the coalition affects poll prospects, even though doing so is quite difficult.

Thus, by estimating the expected number of seats of Q+R alliance and the seats Q and R can win in the absence of an alliance, one can attempt to gauge whether an alliance would work. It's also possible to estimate how an alliance will impact the number of seats won by opposing parties. Case against BJP's BS Yediyurappa for allegedly assaulting minor

Bengaluru's Sadashivanagar police have filed an FIR under the POCSO Act against senior BJP leader and former Karnataka Chief Minister BS Yediyurappa for allegedly sexually assaulting a minor girl.

New Delhi. A case has been registered against former Karnataka Chief Minister and senior BJP leader BS Yediyurappa for allegedly sexually assaulting a minor girl. It has been filed based on a complaint by the mother of the girl. Yediyurappa has been charged under the POCSO (Protection of Children from Sexual Offences) Act and 354(A) (sexual harassment) of the IPC.

According to the FIR, the incident allegedly happened on February 2 when the mother and daughter visited the BJP veteran to

seek assistance in a cheating case. Yediyurappa, however, has denied the allegations, calling them "baseless". He added that the matter has been put before the police commissioner." A few days ago a woman came to my house. She was crying saying that there was some problem. I asked her what was the matter and I personally called the police commissioner about the matter and told him to help her. Later, the woman started talking against me. I have brought this matter to the attention of the police commissioner.
Yesterday police filed a complaint against me. Let's see what happens next, I can't say that there is a political motive behind this," he told news agency ANI.Meanwhile, the complainant in the case has already registered as many as 53 cases (not related to BS Yediyurappa) till date. His ofice released a list of cases she has filed in the past over different matters, insinuating she has a habit of registering cases. The complainant has lodged a series of cases against known troublemakers, and has been filing complaints since 2015, India Today has learnt. In 2015, she lodged a sexual assault complaint involving her daughter against a relative of the complainant's husband.

Congress leader and Karnataka's Home Minister G Parameshwara said that the



police are investigating the matter, and the truth will only be revealed when the probe has been completed.

On claims that the complainant is mentally ill, the minister declined to comment on the same. Parmeshwar, however, said he does not think there is any "political conspiracy" as the complaint in the matter has consistently been filing cases. The Karnataka Home Minister also declined to answer when asked if Yediyurappa would be detained or arrested."I don't want to comment on the police investigation. There is an SOP followed by police,"
Parmeshwar said. Yediyurappa served as the Chief Minister of Karnataka multiple times - between 2008 and 2011, for a

shortwhile in May 2018, and again from July 2019 to 2021.

His resignation in 2021 had come after weeks of speculation and uncertainty. While announcing his decision, Yediyurappa was caught breaking down on the stage and saying the people of the state had lost faith in the government.BS Yediyurappa was

succeeded by the BJP's Basavaraj Somappa Bommai, who became the 23rd Chief Minister of Karnataka. Bommai served in the position from July 2021 to May 2023. The BJP has announced Bommai as its candidate from Haveri constituency for the 2024 Lok Sabha

Four of family killed as car falls into gorge in Jammu and Kashmir

New Delhi Four members of a family were killed and one injured when a car they were travelling in skidded off the road and fell into a gorge in Jammu and Kashmir's Kishtwar district on Thursday, officials said. The accident took place in the Bhandarkot area when the car rolled down the hill into a deep gorge, Kishtwar Deputy Commissioner Devansh Yadav said. Four members of the family died on the spot. A child who was injured is out of danger, he said. Those dead include an employee of the health department, his wife and their two children.Democratic Progressive Azad Party chief Gulam Nabi Azad condoled the loss of lives in the accident

and called for government intervention to address the "increasing" number of accidents in Chenab Valley."My heartfelt condolences to the bereaved families Urging the administration to provide adequate compensation. The increasing



accidents in Chenab Valley are alarming; government intervention and preventive measures are imperative," Azad said on X.

Murder accused livestreams from UP jail, says 'enjoying in heaven'

New Delhi. A video of a murder accused hosting a live session on a social media platform, and saying he is "enjoying" his life in "heaven", has surfaced, triggering the police to order a probe into the matter. The accused is currently lodged in Bareilly Central Jail in Uttar Pradesh.

Police said action would be taken against whoever is found guilty in the investigation, news agency PTI reported.Deputy Inspector General (Prison) Kuntal Kishore told news agency PTI that he had seen the video."A probe in the matter is underway. After investigation, legal action will be taken against whoever is found guilty," he was quoted as saying.

The 2-minute purported video of the live showed Asif, the murder accused, saying that he is soon going to get out of prison."I am in heaven, and enjoying it. I will soon get out," he said during the live session.

Asif is accused of shooting a Public Works Department (PWD) contractor Rakesh Yadav, 34, to death in broad daylight on December 2, 2019, in Delhi's Sadar Bazar Police Station area of Shahjahanpur.

Another accused, Rahul Chaudhury, was also accused to have killed Rakesh Yadav. Both Chaudhury and Asif are currently lodged in Bareilly Central Jail.Rakesh Yadav's brother met District Magistrate Umesh Pratap Singh on Thursday after seeing the viral video and submitted a complaint latter. viral video, and submitted a complaint letter.

In the complaint, the victim's brother claimed that Asif was getting special facilities in the jail. He further said that Asif and Rahul Chaudhury were hired from Meerut to kill his brother.

Heatwave alert in parts of Karnataka, above-normal temperature likely in Andhra

New Delhi. The India Meteorological Department (IMD) stated in its Friday bulletin that isolated pockets of northern interior Karnataka may experience heatwave conditions today. Earlier predictions suggested that Karnataka would face above-normal temperatures this summer, though not exceeding 35 degrees Celsius. Additionally, the IMD forecasted hot and humid weather for Kerala, the Rayalaseema region in Andhra Pradesh, Tamil Nadu, and Puducherry over the next five days. On Thursday, Rayalaseema recorded temperatures exceeding 40 degrees Celsius.In a long-range forecast, the IMD predicted above-normal temperatures for Andhra Pradesh this summer, anticipating more heatwave days than usual. In 2023, Andhra Pradesh saw 21 heatwave days, with temperatures reaching a maximum of 46 degrees

HALF-DAY SCHOOLS IN TELANGANA

As temperatures soar above 40 degrees Celsius in various parts of Telangana, the state's schools have transitioned to half-day operations starting Friday.

Not sorry for miscommunication': Ram Gopal Varma denies political entry

New Delhi. Filmmaker Ram Gopal Varma, who on Thursday wrote on social media that he would be contesting from Pithapuram, on Friday said he wasn't making an entry into politics. Clarifying his social media post, the filmmaker today said he meant he was participating in a short film contest. Varma also said he was "not sorry" for the miscommunication, saying, he 'did not even mention the world election'."For all those dumbos who misread this tweet, I meant that I was taking part in a short film CONTEST in which I am submitting my entry which I shot in Pithapuram," Ram Gopal Varma wrote on X, quoting his earlier post.

"No I am not sorry for this miscommunication because I dint even mention the word election and the media jumped into a frenzy of speculation," he added.On Thursday, it was reported that the filmmaker announced his candidacy for the Pithapuram constituency for the upcoming Andhra Pradesh assembly elections, against actor Pawan Kalyan, who is also contesting from the Pithapuram constituency.

Half of top 30 firms that donated to political parties were probed by agencies

New Delhi. More than 15 of the top 30 companies that donated to political parties through the now-scrapped electoral bonds scheme were investigated by the Enforcement Directorate (ED), Central Bureau of Investigation (CBI), and Income Tax department. The investigations into these companies have varied in intensity, ranging from case filings to raids on their premises. Some firms also had their assets attached by the Enforcement Directorate.Among the entities that were investigated by central agencies are Future Gaming and Hotel Services, Megha Engineering and Infrastructure Limited, Haldia Energy Limited, Vedanta Limited, Yashoda Super Speciality Hospital, DLF Commercial Developers Limited, Jindal Steel and Power Limited, Chennai Greenwoods Private Limited, Dr Reddy's Laboratories Limited, IFB Agro Limited, NCC Limited, Divi S



Laboratory Limited, United Phosphorus India Limited, and Aurobindo Pharma.Finance Minister Nirmala Sitharaman, speaking at the India Today Conclave, said the link between probe agency raids and firms purchasing election bonds were based on "assumptions".

This narrative is based on huge assumptions that the money was given after the raids happened," Sitharaman said. "It may also be that the money was given earlier, and despite that, we went knocking at their doors," she said.

WHAT ELECTORAL BONDS DATAREVEALS

On Thursday, the Election Commission published detailed data on electoral bonds on its website after receiving the information from the State Bank of India (SBI), in adherence to a deadline set by the Supreme Court.Future Gaming and Hotel Services was the top buyer of electoral bonds, worth over Rs

1,350 crore. Future Gaming is a prominent lottery company owned by Santiago Martin. The second-biggest donor was Megha Engineering and Infrastructures Ltd (MEIL), which bought bonds worth Rs 966 crore. MEIL is a Hyderabad-based infrastructure giant and was involved in the Zojila tunnel project in Kashmir. Among the known firms, Anil Agarwal's

Vedanta Ltd bought Rs 398 crore worth of bonds. Airtel owner Sunil Mittal, through three companies, purchased a total of Rs 246 crore worth of bonds


Supreme Court Bar Chief On **Why Electoral Bonds** Disclosure Is Not Ideal

New Delhi: The All India Bar Association (AIBA) has written a letter to the Chief Justice of India (CJI) requesting a suo motu review of the Judgment passed in electoral bonds scheme only qua issue of disclosure of identity of donors and their contributions.AIBA Chairman Dr Adish Aggarwala who is also the President of the Supreme Court Bar Association (SCBA) and former Vice-Chairman of the Bar Council of India (BCI) stated that revealing the names of corporate donors and the amount of donations would render the corporates vulnerable for victimisation. The possibility of them being singled out by those parties, that had received less or no contribution from them, and further harassment, cannot be ruled out if the names of corporate donors and their quantum of donation to various parties are revealed. This will be reneging on the promise given to them while accepting their voluntary donation. He further submitted that at the time of the donation, the corporate donor was fully aware that after the donation, its identity, amount of donation and particulars of donee political party, would not be made public and would be kept confidential. This provision of secrecy was made in the relevant Scheme with the purpose that the donor will be not subject to victimization by any other political party to whom the donor has not donated under the Scheme. In this regard, Senior Advocate Dr Adish Aggarwala apprised the five judges Bench about his letter addressed to CJI. The Chief Justice Dr DY Chandrachud asked Advocate Aggarwala to mention the matter on Monday. Adish Aggarwala through a letter stated that as per Article 145(3) of the Indian Constitution there should be at least five judges to hear cases that involve "a substantial question of law as to the interpretation" of the Constitution, or any reference under Article 143, which deals with the power of the President of India to consult the Supreme Court of India. But in the Writ Petition (C) No. 880 of 2017 (and other connected matters), while referring the case to the Constitution Bench, the substantial questions of law as to the interpretation of the Constitution were not framed in the reference order. The following two questions of law were framed by the Constitution Bench while delivering the Judgment:a. Whether unlimited corporate funding to political parties, as envisaged by the amendment to Section 182(1) of the Companies Act infringes the principle of free and fair elections and violates Article 14 of the Constitution; andb. Whether the non-disclosure of information on voluntary contributions to political parties under the Electoral Bond Scheme and the amendments to Section 29C of the RPA, Section 182(3) of the Companies Act and Section 13A(b) of the IT Act are violative of the right to information of citizens under Article 19(1)(a) of

New Delhi The story of his life is one that epitomises the success of a man who built nothing, into an empire," says the website of the Martin Foundation about Santiago Martin, the founder and chairman of the Martin Group of Companies. He worked in Myanmar and returned in the 90s to build his empire, never shying away from controversy and rubbing shoulders with politicians. And what helped him the most was a quality attributed to politicians -knowing which side the wind would blow.Known as the 'Lottery King' of India, Santiago Martin built his empire on the dreams of people who wanted to make it big in life.Martin hit the jackpot as millions of people in states like Kerala, Sikkim, West Bengal, Punjab, and Maharashtra kept matching the numbers of their tickets with the evasive magic number.Martin, now it has become evident, helped boost the fortunes of political parties too. As the State Bank of India put in the public domain the list of companies that bought electoral bonds and helped finance political parties, Santiago Martin's organisation came on top. His Future Gaming and Hotel Services Pvt Ltd contributed Rs 1,368 crore. The Congress alleged that the BJP got crores from Martin's company and has sought a CBI probe. However, with the data shared by the Election Commission, it can't be said with certainty which party the funds went to.Martin took his first steps in the lottery industry when he was just 13, according to the Martin Charitable Trust website.He built a vast marketing network of the buyers and sellers of lotteries across India. His lottery business, Martin Lottery Tickets, has an average annual growth of 109%.

Based in Coimbatore, Santiago Martin's business interests are spread beyond India's borders. He also operates in Myanmar, a country where he worked in his early years. Part of his Martin Group of Companies are Martin Myanmar and



Martin Yangon. The companies are into real estate, construction, alternative energy, visual media entertainment, hospitality, healthcare and education among others. In India, too, he diversified from the lottery to healthcare, real estate and television broadcasting. As his companies grew, Martin Santiago kept on getting entangled in controversies.His first brush with controversy was when he was accused of defrauding the Sikkim government of Rs 4,500 crore. That would return to bite him in 2023.He was embroiled in a political funding case in Kerala, where lottery is big.In 2008, he Now, it has emerged that Santiago Martin is donated Rs 2 crore to CPI(M)'s Kerala unit and its mouthpiece, both controlled by now Chief Minister Pinarayi Vijayan. The party was seeing internal feud and V S Achuthanandan took on Vijayan over the payment and the money was returned to

Martin Santiago.In Tamil Nadu, Martin cosied up to the DMK. He produced 'Ilaignan', which was written by then Chief Minister M Karunanidhi.Martin's son-in-law, Aadhav Arjuna, is said to have been in the inner circle of the ruling DMK in Tamil Nadu. He has now joined the prominent Dalit party Viduthalai Chiruthaigal Katchi (VCK).In 2014, as the BJP was poised to sweep the Lok Sabha polls, Martin's wife Leema Rose joined the Indhiya Jananayaga Katchi (IJK), an ally of the BJP, and appeared on stage with prime ministerial candidate Narendra Modi, according to a Deccan Herald report. However, Santiago Martin's political connections couldn't keep him away from investigating agencies. In 2015, the Income Tax Department raided Martin's premises in Tamil Nadu, Kerala and Karnataka.In 2023, the Enforcement Directorate (ED) attached Martin's assets worth Rs 457 crore in connection with a case linked to the defrauding of the Sikkim government.

New Delhi Benchmark stock market indices opened Friday's trading session on a cautious note, tracking

The S&P BSE Sensex was down 0.58 per cent at 72,669.74 at 10:07 am, while the NSE Nifty50 fell 0.66 per cent to 22,001.35.Most of the broader market indices were also trading in negative territory as volatility spiked. All the Nifty sectoral indices were also trading in the red except Nifty Media. It may be noted that heavyweight indices such as Nifty IT, Nifty Bank and Nifty Financial Services fell sharply in early trade. Nifty Oil and Gas was the top loser, falling over 2 per cent after the government reduced petrol and diesel prices. The top five gainers on the Nifty50 were Bajaj Finance, Bajaj Finserv, UPL, Adani Enterprises and ITC. On the other hand, the top losers were BPCL, Coal India, NTPC, ONGC and M&M.

Meanwhile, shares of digital payments firm Paytm jumped 5 per cent after the National Payments Corporation of India (NPCI) approved its request to become a third-party UPI app. Deven Mehata, research analyst at Choice Broking, said, "Traders are advised to lighten their overnight positions as global markets are also becoming volatile. Investors can watch the lower levels for fresh investment for the long term."

"If Nifty closes below the strong support of 21850 levels today, we may witness further correction down to 21530 levels. Traders holding long positions in NIFTY should consider the support levels for their stop loss,"

Mid, small-cap funds disclose stress test results

NEW DELHI. A day before AMFI's mandate, prominent fund houses have released their first stress test report to show they will take longer time to liquidate their midcap and small-cap schemes.

A few asset managing companies (AMCs) have given a detailed analysis of where and in which category their fund is parked. They are releasing data such as volatility of the scheme and valuation which compares the portfolio PE (price-to-earning) with the benchmark PE and portfolio turnover which is a measure of how frequently assets within a mutual fund scheme are bought and sold by a fund manager over a given period of time. The fund houses have disclosed a few other additional risk-adjusted measures. The stress test evaluate the liquidity of a scheme by calculating the time required to sell off 25% and 50% of its holdings. This result would allow investors to see how long they can get their money back if the equity market crashes.

As per third-party estimates, most fund houses will take anywhere between 3 days to 111 days to liquidate their small-cap schemes. As per data sourced by industry players, it will take SBI Mutual Fund 111 days to liquidate SBI Small Cap Fund scheme. This scheme had an asset under management (AUM) of Rs 24,862 crore as of January 2024. It would take 29 days for the HDFC Small Cap Fund (AUM: Rs 28,604 crore) scheme to liquidate. Quant Mutual Fund on Thursday said the time taken for 50% portfolio liquidation is six days for its Quant Mid Cap Fund and 22 days for Quant Small Cap Fund. Further, the time taken for 25% portfolio liquidation is 3 days for Quant Mid Cap Fund and 11 days for Quant Small Cap Fund.

Nippon India Mutual Fund (MF) said it would require up to 27 days to liquidate 50% of the small-cap fund portfolio and 13 days to offload 25% of the assets. Nippon manages India's largest small-cap fund with AUM of Rs 46,044 crore. Third-party data shows schemes such as HSBC Fund, Franklin India Smaller Companies Fund, Canara Robeco Small Cap Fund, ICICI Prudential Small Cap Fund and Aditya Birla Sun their portfolio, showed the data.

Byju's ordered by US court to freeze \$533 million in relief for lenders

NEW DELHI. Think & Learn Pvt has been ordered by a US judge to freeze \$533 million in funds in a dispute with lenders claiming ownership over the money, reported Bloomberg.The decision by US Bankruptcy Judge John Dorsey came as a relief for lenders who had sought to protect their interests amid financial turbulence surrounding the education-tech firm operating as Byju's. The order, directed at Riju Ravindran, a director of the company and the brother of founder Byju Raveendran, aims to safeguard the disputed funds while addressing concerns over their whereabouts.Judge Dorsey expressed suspicion regarding Ravindran's claim of not having knowledge about the funds' location. 'I do not believe him when he says he cannot learn the location from Think & Learn," said Judge Dorsey.

Ravindran's attorney, Sheron Korpus, argued that the lenders themselves



Think & Learn was justified in withholding the funds due to what they perceived as aggressive actions by the lenders in asserting defaults on debt obligations. The company is actively contesting the lenders' claims in state courts in Delaware and New York.

The dispute over the \$533 million arises from actions taken by lenders who took control of a holding company established by Think & Learn to issue \$1.2 billion in debt. Global supply for 2024 is forecast to increase 800 kb/d to 102.9 mb/d, including a downward adjustment to OPEC+ output," the report reads. According to the IEA report, trade flow disruptions also boosted bunker fuel use. Longer shipping routes and faster vessel speeds saw Singapore bunkering reach all-time highs. That, along with surging US ethane demand for its petrochemical sector, underpins a slight upward revision to global oil demand expectations for this year by 110 kb/d compared to last month's report.

"World oil demand growth is now forecast at 1.3 mb/d in 2024, down sharply from last year's 2.3 mb/d expansion," IEA said in its monthly report. Iran, which last year ranked as the world's second-largest source of supply growth after the United States, is expected to increase production by a further 280 kb/d this year. Output policy for the remainder of the OPEC+ bloc will be revisited when ministers meet in Vienna on June 1 to review market conditions.

Virat Kohli a must for T20 World Cup 2024: Kris Srikkanth blasts 'rumour-mongers'

New Delhi Former India captain and exselection committee chairman Kris Srikkanth has lashed out at rumours over Virat Kohli's place in India's T20 World Cup 2024 squad, saying that the star batter is a must for the team if they are to go on and win the trophy. The T20 World Cup will be played in the USA and the West Indies from June 1, weeks after the completion of IPL 2024. Virat Kohli returned to the T20 set-up in the 3-match series against Afghanistan in January. it was the first time Kohli played the shortest format of the game at the highest level after the T20 World Cup semi-final in 2022. Kohli and Rohit Sharma were brought back into the T20I set-up by the Ajit Agarkar-led selection committee, signalling their intentions to have them back in the T20 World Cup set-up.

Kohli made his intentions clear in the T20I series, hitting a 16-ball 29 in the 2nd T20I and then throwing his wicket away in the 3rd T20I by trying to be aggressive. Kohli missed the 5-Test series against England in February-March to be with his wife Anushka Sharma during the birth of their second child and the former captain is expected to return to competitive action in



IPL 2024. Ahead of his competitive return, a media report claimed that the senior selection committee was mulling not considering Virat Kohli for the T20 World Cup in the USA and the West Indies.

'No chance. It's not possible to be without Virat Kohli at the T20 World Cup. He is the one who took us to the semi-finals in T20 World Cup 2022. He was the Man of the

Tournament. Who is saying all this? These rumour-mongers, don't they have any other job? What is the basis for all this chatter? If India have to win the T20 World Cup, Virat Kohli is a must in the squad," Srikkanth said in his YouTube show.

INDIA SHOULD WIN THE CUP FOR VIRAT

While there were concerns about Virat Kohli's strike rate in the past in T20I cricket, the former India captain has always managed to do what the team needs. At the T20 World Cup in 2022, Virat Kohli top-scored with 296 runs in just 6 matches and played one of the finest knocks in T20I history against Pakistan at the Melbourne Cricket Ground. While stressing India need an anchor in the batting order in the West Indies, Kris Srikkanth said that the Indian team should win the World Cup as a tribute to Virat Kohli, recalling Sachin Tendulkar's World Cup 2011 triumph."You need a guy who can just stay there. India need that sheet anchor, be it T20 World Cup or ODI World Cup," he added."Without Virat Kohli, the Indian team

cannot go. We need Virat Kohli, 100 percent.

Carlos Alcaraz sees funny side of things after bee invasion at Indian Wells

I'm a little bit afraid of the bees," said Alcaraz."Once the match started again, I managed to stay away from the bees and do the things I needed to do."Did the bee attack affect Alcaraz' performance against Zverev?The bee attack certainly didn't have an effect on Alcaraz' performance as he dispatched Zverev with ease.

Despite the disruption caused by the bee invasion, Alcaraz remained unfazed, using the break to regroup and dominate upon return. He triumphed with a scoreline of 6-3, 6-1, demonstrating formidable ball-striking and agility. This win marked Alcaraz's tenth consecutive victory at Indian Wells, propelling him into the semifinals where he would face Jannik Sinner.

All England crown my dream, says Lakshya Sen amid Olympic qualification race

Birmingham. Former finalist Lakshya Sen said he is determined to go one step further than 2022 in the ongoing All England Open badminton championships, stressing that winning the title at the prestigious tournament is one of his biggest dreams. Lakshya's comments came after the 22-year-old stormed into the men's singles quarter-final of the Super 1000 tournament on Thursday. Lakshya Sen, ranked 19, defeated 6th seed Anderson Antonsen in a sensational three-game battle at the United Arena in Birmingham. Lakshya stormed back from behind to beat the Danish shuttler 24-22, 11-22, 21-14 and set up a quarter-final clash with 2021 champion Lee Zii Lakshya Sen did not begin the season well as he faced first-round exits in India Open and Malaysia Open before exiting the Indonesia Masters in the second round. However, Lakshya bounced back to reach the semi-final of French Open before making another deep run, this time at the All England Open.

World No. 1 Satwik and Chirag bow out of All England Open 2024 in second round

New Delhi. World No. 1 Satwiksairaj Rankireddy and Chirag Shetty's wait for an All England Open crown continued as the top seeds were knocked out in the men's doubles second round by former champions Muhammad Shohibul Fikri and Bagas Maulana of Indonesia. In a shock result on Thursday, the Indian pair were beaten in straight games - 16-21, 15-21 in just 44 minutes at the United Arena in Birmingham.Satwik and Chirag exiting the prestigious Super 1000 tournament as early as the second round serves a big blow to India's hopes of

ending their long wait for an All England champion. Only Prakash Padukone in 1981 and Pullela Gopichand in 2001 are the Indian players to have won the tournament in England in the past.

Satwiksairaj Rankireddy and Chirag Shetty were unusually error-prone, especially in the front of the court as several close points

Despite their efforts to close Meanwhile, India had another disappointing the gap, the 2022 champions took the early advantage by winning the opening game. The World No. 9 pair from Indonesia did not waste the momentum gained as they stormed to a straight-game win.It was Satwik and Chirag's 3rd defeat to the

Indonesian pair in 7 meetings. The Indian duo had beaten Fikri and Maulana in straight games in Malaysia in January. The left-arm pacer was previously bought by KKR during the 2018 auction when he was bought for 9.4 crore rupees. Speaking after reaching Kolkata on Thursday ahead of the new season, Gambhir said that the price tag won't be an added pressure for Starc."I don't think the price tag will be an added pressure for him. I only hope he can do for KKR what he does for Australia in international cricket," said Gambhir.In the two seasons Starc played before his IPL hiatus, the left-arm pacer picked up a total of 34 wickets while playing for the

For Gambhir, it was an emotional homecoming on Thursday as the former opener returned to the franchise ahead of the new season. Gambhir had been the mentor of LSG for the past two seasons and made the decision to

Gambhir said that he is aware of the expectations and will be hoping to live up to them."I have always mentioned that KKR to me is not a franchise, but an emotion. I am thus happy to be back,"
