

Eshwarappa claims Amit Shah declined to meet him

Sanjay Kumar Bengaluru, April 4: Former Karnataka Deputy Chief Minister K S Eshwarappa, who is contesting as a rebel candidate against BJP's B Y Raghavendra from Shivamogga Lok Sabha seat, on Thursday claimed Union Home Minister Amit Shah did not meet him as he found it difficult to respond to questions raised by him. Eshwarappa, a senior BJP leader, said he went to Delhi as Shah had summoned him but the meeting could not happen. "I went to Delhi as I was summoned. If I had not gone there, then they would have called me arrogant. I could not meet Amit Shah. I think the meeting did not happen because I had asked him certain questions, which he found difficult to answer," the former BJP state president claimed. Eshwarappa has entered the

electoral fray in Shivamogga constituency as an against Independent, Raghavendra, son of BJP veteran B S Yediyurappa. Explaining, he alleged Shah did not allow the meeting to happen. "I went to his office where I was told not to meet him. It is good for me. What would I have done if he had

asked me to withdraw even after narrating the story of injustices?" Eshwarappa wondered. The veteran BJP leader said Shah must have thought that whatever he was doing was justified as he was fighting for justice. "He only had called me to Delhi and did not meet me," he claimed. Further, the 75-year old leader alleged, "in Karnataka, Congress culture has crept into BJP where Yediyurappa's family politics is prevailing." Sources close to Eshwarappa said he wanted a

ticket for his son K E Kantesh from Haveri constituency, which did not happen.

SC sets aside High Court verdict cancelling Amravati MP Navneet Kaur Rana's

scheduled caste certificate New Delhi, April 4: The Supreme Court on Thursday reversed a Bombay High Court verdict cancelling the scheduled caste certificate of Amravati independent MP and current BJP candidate from the constituency Navneet Kaur Rana. Allowing Rana's appeal against the high court's verdict, a Bench led by Justice JK Maheshwari said the high court should not have interfered with the



report of the Scrutiny Committee on her caste certificate, which had concluded that she belonged to the scheduled caste community. The Bench – which also included Justice Sanjay Karol - restored the validation order passed by the Scrutiny Committee. "In the instant case, the Scrutiny Committee duly considered the documents before it and passed its decision complying with principles of natural justice. It did not merit any interference under Article 226. In light of the discussion and the peculiar facts and circumstances of the case, the instant appeal stands allowed and the high court order is set aside," Justice Maheshwari said, pronouncing the judgment for the Bench. Rana had won the reserved Amravati parliamentary seat in Maharashtra as an independent candidate backed by the NCP in 2019, defeating Shiv Sena candidate Anandrao Adsul. She recently joined the BJP, which has fielded her from the same constituency. The Nagpur Bench of the Bombay High Court had on June 8, 2021, said the 'mochi' caste certificate was obtained fraudulently using fabricated documents by Rana. The high court had also slapped a fine of Rs 2 lakh on her, saying the records indicated that she belonged to the 'Sikh-Chamar' caste. However, the Supreme Court had on June 22, 2021 stayed the order of the high court that quashed her Scheduled Caste certificate. Rana had submitted before the top court that the high court was wrong in quashing her SC certificate by reversing the decision of the scrutiny committee that had found to be genuine her claim to be an SC candidate.



Thursday released its manifesto for the Lok Sabha elections, promising to scrap all "draconian" laws such as the Unlawful Activities (Prevention) Act and the Prevention of Money Laundering Act (PMLA). The CPI(M) appealed to voters to defeat the BJP, strengthen the Left, and ensure the formation of an alternative secular government at the Centre. In its manifesto, the party pledged to fight for "an uncompromising adherence to the principle that religion is sep-arated from politics". "The CPI(M) stands for the scrapping of all draconian laws like UAPA (Unlawful Activities (Prevention) Act) and PMLA," the manifesto stated. The party said it will "fight for a law against hate speech and crimes, is committed to scrapping" the Citizenship (Amendment) Act, 2019. The Communist Party of India (Marxist) promised to tax the super rich and introduce a law on general wealth tax and inheritance tax. The party said the budgetary allocation for job guarantee scheme MGNREGA must be doubled and a new law guaranteeing urban employment must be legislated.

Tihar jail officials allow Punjab CM Bhagwant Mann to meet Kejriwal as normal visitor in 'mulakat jangla'

New Delhi, April 4: A day after Punjab Chief Minister Bhagwant Mann wrote to the Tihar administration seeking a meeting with jailed AAP head Arvind Kejriwal in the prisons, the authorities said he can meet his Delhi counterpart, but as a normal visitor in the 'mulakat jangla'. The 'mulakat jangla' is an iron mesh which separates the inmate from the visitor in a room inside the jail. A visitor and an inmate can talk to each other by sitting on different sides of the mesh. The officials of the Tihar jail, while confirming the letter from the Punjab chief minister's office (CMO) to Tihar Director General Sanjay Baniwal, said the reply will be given "soon" to Mann's office. "Mann can meet Kejriwal but it can happen as a normal visitor meet in the 'mulakat jangla' in Tihar jail. The officials can make security arrangements as Mann is a chief

minister and enjoys Z+ security cover," an officer, who did not wish to be named, told PTI. He said the letter from the Punjab CMO has sought time and asked the Tihar administration to make necessary arrangements for their meeting in the prison premises. Aam Aadmi Party (AAP) convener Kejriwal, who was sent to Tihar Jail after a court remanded him to judicial custody in the excise policy case on April 1, has been lodged in jail number 2. The Delhi chief minister has given five names - including his wife, two children, his personal secretary Bibhav Kumar and AAP Rajya Sabha MP Sandeep Pathak - whom he can meet in the jail. The officer said Kejriwal will have to add one more name of Mann in the list of visitors. According to the jail manual, an inmate can give 10 names of visitors. Three of them can meet at one time, twice a week.

UP Man Busts Wife's **Extramarital Affair, She Climbs Electric Pole**

- Gorakhpur, UP. An acute need for money, a seven-year extramarital affair and a woman perched on an electric pole - high voltage drama unfolded in an Uttar Pradesh town on Wednesday, the video of which is now viral on social media.
- In Gorakhpur's Pipraich, a 34-year-old mother of three children climbed an electric pole after her husband found out about her extramarital affair. The woman was allegedly in a relationship with a man from a neighbouring village. The relationship was hidden for seven years but the woman's husband, Ram Govind, who works as a labourer, found out.Upon discovery, an argument ensued between the couple, with the woman demanding that the other man be accommodated in her household and help with the finances of the house. Ram Govind vehemently opposed the idea and dashed out of the house.Captured on video and circulated online, the woman's ascent up an electric pole stunned onlookers who called for her to climb down. A crowd watched in horror as the woman perched perilously on the pole, bound by high-tension wires.
- Local authorities swiftly responded to the crisis, dispatching teams from both the police and electricity departments to the scene. With the electricity supply cut off as a precautionary measure, efforts to coax the woman down from her precarious perch commenced. Through patient negotiation, the authorities succeeded in persuading the woman to return to solid ground.

Night Attack On Madhya Pradesh Toll Plaza, 2 Drown In Well While Fleeing

- Bhopal. Two employees of a toll plaza in Madhya Pradesh fell into a well and drowned as they were running to save themselves during an attack by masked gunmen, allegedly over a toll tax dispute. The bodies of Agra's Srinivas Parihar and Nagpur's Shivaji Kandele were recovered from the well yesterday.
- The incident, police have said, took place around 10 pm on Tuesday. Chilling footage from CCTV cameras at Dagrai toll plaza on National Highway - 44 show masked men on four bikes ride near the toll booths. They then start kicking at the doors of toll counters and some manage to enter the booths. The assailants are seen damaging computers, beating up the toll plaza staff and trying to drag them out.
- The staff, it is learnt, ran into the adjoining field to save their lives when the assailants started firing in the air. As they ran, Parihar and Kandele fell into an uncovered well right behind the office and drowned.
- The contract of the toll plaza between Jhansi and Gwalior changed on April 1, and it passed on to a new contractor. Some locals, it is learnt, had an understanding with the previous contractor and their vehicles llegedly cleared the toll booth without

CHENNAI. Members of the Ennore Makkal Paathukappu Kuzhu, a collective of protesting villages in the region, have filed a petition before the Southern Bench of the National Green Tribunal in Chennai, against the environmental clearance granted for the expansion of the Coromandel fertiliser plant in Ennore.Demanding permanent closure of the Coromandel International Limited (CIL) plant, the villagers have been protesting since December 26 last year when an ammonia gas leak accident occurred at the plant. They had also denounced the measures subsequently recommended by the technical committee of state government. The NGT previously reserved its judgment in a suo motu case initiated based on a TNIE report regarding the gas leak accident. The villagers have now filed a fresh application before the NGT against the fertiliser plant. The application seeks the tribunal to quash the environmental clearances granted to the CIL from 1993 to 2023 for the expansion of its operations.

The petition contends that the clearances were issued in violation of the Coastal Regulation Zone (CRZ) notifications. "The factory is located within the CRZ area. The CRZ notification of 1991 imposed a prohibition on the expansion of any

industry located within the CRZ and the setting up of new industries. The clearances were obtained by suppressing the fact the industry is located within the CRZ area and the expansion is legally prohibited," the Retired High Court judge K Kannan petition read.

The application also criticised the authorities for granting clearances without proper verification. "The authorities are equally culpable as they rewarded the CIL with clearances in utter disregard to the law of

environmental consequences," they added. The petition also stated that no offsite emergency preparedness plan was prepared by the plant as mandated.

Âdvocate D Shanmuga Nathan appeared on behalf of the state government. The bench issued a notice to the government and the CIL and posted the matter for further hearing on May 7.

Underground sewer work in Madipakkam may get over by next January

CHENNALAS much as 70% of the work for the underground sewer projects in Madipakkam has been completed and the Chennai Metropolitan Water Supply and Sewerage Board (CMWSSB) expects to complete the assignment by January next year. The UGD works at Ullagaram, Madipakkam, Puzhuthivakkam, Kovilambakkam, Moovarasampettai and Pallikkaranai commenced in August 2022 at a cost of `256.90 crore.A senior CMWSSB official told TNIE, "In 2025, the population in these localities is estimated to be 58,177, and consequently 6.981 MLD sewage will be generated. Within a couple of decades (2055), the population will increase by 1.49 lakh and the sewage by 17.880 MLD.Hence, it is essential to keep ready the sewerage infrastructure here. We are constructing seven sewage pumping stations in these areas, and 50% of the work has been completed. Despite expediting machine hole work, connecting the houses in the row is proving to be a challenging task. Nevertheless, we have already provided connections to 5,557 out of 10,853 houses under the project.

Bengaluru Congress Pick Says Students Forced To Attend Tejasvi Surya Rally

Bengaluru. Congress leader Soumya Reddy, who is set to take on BJP's Tejasvi Surya in the Bengaluru South Lok Sabha contest, has sought the Election Commission's intervention amid allegations that students are being pressured to attend the BJP leader's nomination rally.

In a post on X, Ms Reddy has shared screenshots of WhatsApp messages that the Congress claims were posted on groups of college students, asking them to join Mr Surya's nomination rally today. One of the messages says "no excuses will be entertained" and that those attending the rally will get t-shirts. The message also assures the students that they will get attendance for this.

Ms Reddy has also tagged a social media post by the Indian Youth Congress (IYC) on the issue. The IYC post shares a screenshot of a tweet in which a student has claimed that the president of his institution's student council is threatening them against skipping the rally.One of the screenshot shows a member of the WhatsApp group asking why attendance is mandatory. Another user replies that Mr Surya had accepted the student council's request to attend the college's fest and "now it's our turn to do the same". The IYC has questioned why students are being told to compulsorily attend a political programme. "Isn't this a violation of the code of conduct?" it asked. Sharing IYC's post, Ms Reddy has tagged the Chief Electoral Officer, Karnataka and said, "Request action to be taken."Mr Surya, who will be filing his nomination papers, today has not responded to

Over 25 lakh beneficiaries receive pension on day one in Andhra

VIJAYAWADA . Disbursement of social security pensions finally commenced at the village and ward secretariats on Wednesday afternoon. By evening, nearly 40% of the disbursement was completed in several districts.Several old and differently-abled people were seen waiting at the secretariats since early morning across the State to get their pensions. However, disbursement commenced only in the afternoon, when the secretariat staff brought the cash from the banks.Though it was announced that for the elderly, infirm, and differently-abled, pensions would be disbursed at their doorstep by the secretariat staff, at several places, beneficiaries turned up in large numbers at the secretariats out of anxiety.

There are 65,60,904 pensioners under different categories and the finance department reportedly deposited Rs 1,951.69 crore with banks for pension disbursement. As instructed, village and ward secretariat staff visited the houses of beneficiaries who are specially-abled, severely ill, bedridden, confined to wheelchairs, and elderly widows of war veterans drawing Sainik welfare pensions.Disbursement commenced in 13,669 village and ward secretariats out of 14,994. A total of 25.66 lakh beneficiaries received their pensions on Wednesday. District collectors were instructed to ensure that disbursement starts from 7.00 am

onwards from Thursday in view summer.In Visakhapatnam district, by 7 pm, 48% of social security pensions were disbursed. The highest distribution rate of 78% was recorded in Pendurthi mandal. For April 2024, a total of 1,65,432 pensions were sanctioned for Visakhapatnam district. Of the total, 79,113 pensioners have received the aid.Following orders from the District Collector, pensions were disbursed to 1,450 disabled, seriously ill, bedridden, and wheelchair-bound individuals at their residences. Additionally, around 4,800 pensions were delivered to beneficiaries residing in rural areas. At every secretariat, arrangements were made to ensure pensioners' comfort, including the provision of tents, chairs, and drinking water, so that no inconvenience is caused to them.Pension distribution will continue till April 6 at the secretariats from 7:30 am to 7 pm. Special arrangements have been made for those unable to visit the secretariats.

Pet owners & breeders will abandon dogs of 23 breeds, say activists on Centre's ban

Gurgaon. Animal rights activists are worried that dogs of 23 breeds considered "dangerous for human life" will be abandoned by families and breeders as states enforce the ban recommended by Centre on their import, sale and breeding. Activists said on Wednesday that instances of families abandoning dogs of these breeds — commonly pitbulls, rottweilers and bulldogs — had increased over the years, especially after reports of bans announced by civic authorities.In November 2022, Gurgaon's district consumer disputes redressal forum ordered MCG to ban dogs of 11 breeds, including American pitbull terriers, Dogo Argentino, rottweiler, etc. The corporation issued a notification, but the forum's order was challenged. The case is pending with the Punjab and Haryana high court.Similarly, Ghaziabad Municipal Corporation (GMC) had barred families from keeping pitbulls, rottweilers and Dogo Argentino as pets in 2022. The Centre's circular, which

directs states and UTs to issue the ban. also includes these breeds that are often considered aggressive. Till now, Haryana govt has not notified Centre's recommended ban, which has also been challenged before three high courts."MCG can implement the Centre's order to impose a ban on the import, sale and breeding of 23 ferocious dog breeds only after the state govt notifies it," a senior MCG official said on Wednesday. Animal rights activists told TOI they have many dogs of these breeds that are up for adoption. Though adoption is not illegal, activists believe no one will be willing to give these dogs a home once the ban is implemented. Registration of these dogs with civic authorities, and the rule to mandatorily sterilise them as specified in Centre's circular, also complicates any adoption attempt."People like to buy these breeds as a symbol of status and power. There is complexity to such breeds and people often get these breeds from illegal breeders. There is no ban on



adoption of these dogs from shelters but more clarity is needed. The order needs to clearly mention how the authorities will check illegal breeding. Things on the ground will not improve till this order is not implemented properly," said Surabhi Venkatesh, a canine behaviour and nutrition coach and founder of Luchi and Mutton's Dog Behaviour and

Nutrition."With the present order, the illegal nexus might go further underground. There is a need for awareness about why buying a dog who is not native to the region is not a good idea and vets also need to inform pet parents to go for sterilisation," said Anjali Gopalan, founder of non-profit All Creatures Great and Small.Asked what will happen to the dogs who don't get adopted, Gopalan said shelters will have to keep them for life.Manish Jain, who runs the animal shelter Fur Tail in Sohna, said authorities need to address the gaps when imposing such norms."Centre's circular does not talk about what happens to people who already have these dogs. And how will people adopt any of these breeds from shelters if they do not get registration from municipalities," Jain pointed out.

He also raised concerns about the practice of keeping large dog breeds in small houses. "Such breeds have a lot of energy, and they need space and engagement.



The coming tidal wave projected by this model would sweep away several major Conservative figures," it said. Teen with mental health issues shot dead in California, was armed with knife

Victorville, California, Southern California sheriff's deputies shot and killed a 17-year-old boy with mental health issues after he armed himself with a knife and locked himself inside a bathroom at a home, authorities said on Wednesday (local time). The teen was transferred from a hospital, where he had been treated after cutting himself, to a mental health facility when he escaped on Tuesday, San Bernardino County Sheriff Shannon Dicus said. The boy, a foster youth who lives in Hesperia, later showed up at a home in Victorville where his sisters live in foster care, Dicus said. Someone at the home called deputies to come arrest him, Dicus said, because he had caused trouble there. The teen was backed into a bathtub, before. The teen, who had a knife, locked himself in a bathroom, and deputies tried to get him to come out for about a half hour, according to the sheriff. But when the boy threatened to harm himself, deputies kicked down the door and tried to arrest him, Dicus said.A video and images of the encounter showed the teen holding a knife, the Riverside Press-Enterprise reported. Deputies pepper-sprayed him and one deputy's hand was sliced by the knife, the newspaper said.

His defence lawyers in the New York case in March asked Justice Juan Merchan to delay the trial until that review was complete, arguing it was relevant because prosecutors were seeking to present evidence of statements Trump made while he was president from 2017 to 2021.In a court ruling on Wednesday, Merchan said Trump had waited too long to raise the issue."Defendant had myriad opportunities to raise the claim of presidential immunity well before March 7, 2024," Merchan wrote. Todd Blanche, a lawyer for Trump, declined to comment. Trump, the Republican candidate to challenge Biden in the Nov. 5 election, has pleaded not guilty in each of the four criminal indictments he faces. The New York case could be the only one to go to trial before the election. He is accused of falsifying business records to cover up his former lawyer Michael Cohen's \$130,000 payment to porn star Stormy Daniels for her silence before the 2016



World Central Kitchen founder says Israel targeted staff in Gaza 'car by car'

World Central Kitchen (WCK) founder José Andrés has accused Israeli forces in Gaza of targeting his aid workers "systematically, car by car", the BBC reports. Monday's strike which killed seven members of his staff was not a mistake, he said, repeating that Israeli forces had been told of their movements. WCK workers from Australia, Canada, Poland, the UK and the US were killed as well as their Palestinian colleague.

Lawmakers in US' Idaho state pass bills targeting LGBTQ+ people

Idaho's lawmakers have passed a series of bills targeting LGBTQ+ residents this year, including two this week that prevent public employees from being required to use someone's preferred pronouns and redefine gender as being synonymous with sex.

Idaho's lawmakers have passed a series of bills targeting LGBTQ+ residents this year, including two this week that prevent public employees from being required to use someone's preferred pronouns and redefine gender as being synonymous with sex.On Wednesday, the Senate approved a bill allowing people to sue schools and libraries over books deemed harmful to minors, sending it to Republican Governor Brad Little.

Another bill that Little signed into law last week prevents public funds — including Medicaid — from being used for gender-affirming care.

The efforts are part of an ongoing national battle over the rights of LGBTQ+ Americans. Many Republican officials have been actively trying to limit those rights over the past several years. The legislation in Idaho was among at least nine bills directly targeting LGBTQ rights that have been proposed in the state so far this year, Rebecca De Leon, spokesperson for the ACLU of Idaho, told the Idaho Statesman. In response to the slew of actions, protesters sent more than 48,000 colourful paper hearts raining down from the fourth floor of the Statehouse to the first-floor rotunda on Tuesday, KTVB-TV reported.

The hearts symbolised the 48,000 Idaho residents who identified as part of the LGBTQ+ population in the 2020 census. The hearts were handmade and mailed to the ACLU from 18 cities across the state.We wanted specifically lawmakers



to be able to see the hearts and to hear what we have been trying to tell them all session," De Le³n told the Statesman. "It feels like they have not been listening, so we wanted to come bring the hearts to them.'

Republican Rep. Julianne Young sponsored the bill redefining gender, which refers to social and self-identity, as being synonymous with sex, which refers to biological traits. At least 12 other states have considered similar legislation this year attempting to remove non-binary and

transgender concepts from statutes. Kansas enacted a law last year ending legal recognition of transgender identities.Idaho's library bill allows community members to file written requests to remove materials they consider harmful to minors to an adults-only section, and gives library officials 60 days to make the change. After that point, the community member could sue for damages. The governor vetoed a similar

bill last year, saying he feared it would create a bounty system that would increase libraries' costs, ultimately raising prices for taxpayers.

The ACLU and other opponents of the new law preventing public money from being used for gender-affirming care say it most likely will lead to a federal lawsuit. Idaho is already embroiled in lawsuits over attempts to deny gender-affirming care to transgender residents and has not had much success so far in defending them.

Stingy salut! Malayalis prefer raising a toast to cheap liquor

KOCHI. Inebriation on a budget, that too with entry-level brown spirits, seems to be the mantra of Malayalis, as they defy the national trend of increasing demand for premium liquor.A report by the International Spirits and Wines Association of India (ISWAI) says the share of premium liquor (priced over Rs 1,000 per 750 ml) consumed in Kerala is a measly 4%, with inexpensive liquor dominating the scene with a staggering 96% share. In the neighbouring states of Karnataka and Tamil Nadu, premiumisation (trend of consuming premium liquor) shares are notably higher at 6% and 10% respectively. States like Uttar Pradesh and Rajasthan boast a 12% share, with the proportion in poorer states such as West Bengal and Odisha even touching 20.5% and 22% respectively. Telangana leads with an impressive 52% share of premium liquor to total liquor sales among Indian states. Despite being prosperous, the alcohol beverages (alcobev) industry in Kerala faces challenges due to low levels of premiumisation, says Nita Kapoor, chief executive officer of ISWAI.

- ISWAI guess-estimates IMFL volumes in Kerala at approximately 3.3 crore cases per year, with beer accounting for 33%, brandy 35%, and rum 27%. Imported products make up a small fraction of the market, roughly around 4,000-5,000 cases per month.
- ita noted that a significant 96% of the volume sold in the state consists of beer, brandy, and rum. "The entry-level prices are relatively modest, with beer starting at Rs 110 (650 ml), and brandy and rum priced at Rs 140 a nip (180 ml) and between Rs 450-750 for the larger 750 ml bottle," she said. She added that this behaviour is in sharp contrast to the state's penchant for luxury cars and other items like big-screen televisions. Nita attributed this trend to high taxes, limited access to retail outlets and substandard retail infrastructure, resulting in a poor consumer experience.

MANJUMMEL(KOCHI): Having portrayed small roles on the silver screen, K Vinod dreamt of becoming a busy actor. He also moved into his new house at Manjummel less than two months ago, wanting to live the rest of his life there taking care of his mother.

When a migrant worker from Odisha pushed the 48-year-old TTE to his death off a moving train on Tuesday, it also marked the untimely demise of Vinod's modest dreams of becoming a reliable actor and live in his new house. Now, his widowed mother Lalitha is destined to mourn the death of her only son."It was following his father's demise that Vinod secured the job in the railway. Though a workaholic, he always found time to pursue his passion for acting," said Bindu, a relative as she struggled but failed to fight back tears.A Thiruvananthapuram native, Vinod had acted in several movies, including



Mohanlal's Pulimurugan and Joju George's Joseph. "They were small roles, but Vinod was always content. He hoped of bagging bigger roles. Everything has now come to a sudden end," she said.

In February, Vinod, a divorcee with no children, moved to the new home he constructed at Manjummel with Lalitha. It marked a paradigm shift in the lives of the duo, who had until then lived in the railway quarters in Kochi.

"He lived only for his aged mother. It was always his dream to build a good home for his mother and live with her there, as they had spent a major part of their lives in the railway quarters. Though Vinod got married nearly 10 years ago, the relationship ended within a year. Our efforts to find another girl

ended in vain, as Vinod wanted to give more care to his mother. The tragedy has left her devastated. The bond they shared cannot be described in words,' said Aswathy, Vinod's niece.Vinod's friends and relatives remember him as a soft-spoken person and a man with a heart to help everyone."If you met him once, he would grab a place in your heart. He was always calm and composed. If he saw anyone suffering from financial issues, he would help without a second thought. Recently, he helped a relative with Rs 10,000 when he heard about a health issue. It's a huge loss for our family," said Beena, one of his cousin sisters, pointing to his picture on the wall.

His neighbours said he had grabbed a place in everyone's heart within a short span of time. "It was nearly a year ago that I met him when he came to start the construction of his house. In the first meeting itself, I felt like he was my son," said Unni, an elderly man who lives opposite Vinod's

house.He said whenever Vinod came to oversee the work of his house, he used to visit his home. "Our bond became stronger within a few meetings. Not just with me; he established a bond with all the neighbors. He even offered annadhanam to all the neighbours in my home on the Attukal Pongala day," said Unni.

Want same fate for accused': Wife of tailor beheaded in Udaipur

Udaipur The wife of Kanhaiya Lal Teli, the Nearly two years after the murder of Kanhaiya Udaipur tailor who was beheaded inside his shop two years ago for posting content in support of BJP leader Nupur Sharma, said she wanted the two accused to face a similar fate. Almost two years after the death of Kanhaiya The family has also been forced to live under Lal, his family still finds it hard to come to terms with the fact he has been killed."I want the same fate to be meted out to the culprits. What they did to my husband should be done to them," Kanhaiya Lal's wife told India .In June 2022, two men came to Kanhaiya Lal's shop in Udaipur and butchered him in broad daylight. The entire incident, which was captured on CCTV camera, triggered a country-wide uproar.Later, the two accused, Ghaus Mohammad and Riyas Attari, admitted to killing Kanhaiya in a pre-recorded video message. The duo were arrested subsequently.

The accused said they killed Kanhaiya Lal for supporting Nupur Sharma, a former spokesperson for the BJP who had made controversial remarks about the Prophet Muhammad he case was handed over to the National Investigation Agency (NIA) and a charge sheet was filed against Mohammed, Attari and nine others in December 2022. 2-year-old boy trapped in 15 feet deep borewell in Karnataka, rescue ops on

be stuck at a depth of 15-20 feet. The child, namely Satwik Mujagond, is likely to have fallen head first into the borewell in Vijayapura district. According to the police, the child fell into the uncovered borewell while playing near his house. The borewell was drilled into 4 acres of land belonging to the child's father, Satish

Mujagond.Rescue operations started around 6.30 pm on Wednesday. Police teams, revenue officials, members of taluk panchayat and officials from the fire department and emergency services are there to pull the child out from the borewell."All efforts are underway to rescue the child," news agency PTI reported, quoting a senior police officer.Latest video footage showed movements inside the borewell as the child was caught moving his feet.

- Police said that pipes have been inserted into the well to supply oxygen to the child.
- The rescue team has dug up to some distance, which they will use to lay a 5-foot tunnel to reach the child. Hard rocks and boulders, however, may hinder the operation. Skilled tubewell drilling workers have been roped in to speed up the rescue process.

Karnataka Minister MB Patil took to X to address the incident. He said that he instructed the Vijayapura district administration to conduct an operation at a "rapid pace" and also prayed for the toddler's safe reunion with his parents.

The prospect of a Trump presidency

THE likelihood of Donald Trump being elected US President in November is increasing by the day. Despite his legal troubles, Trump's committed vote has not been affected. If anything, he has been able to leverage the victim card skilfully to consolidate political support among the poorer, less-educated Whites, surprisingly, the Latinos and the Republican Party's hard right wing. Joe Biden is losing support among traditional Democratic Party voters. There are questions about his age (he is 81); his support for Israel has alienated university-educated Whites and Blacks as well as the significant Arab-American and Muslim constituency. While the US economy has been doing well, with declining inflation, rising wages and low unemployment, this has not yet turned political sentiment in favour of the incumbent leadership. Disaffected Democratic Party supporters may not vote for Trump, but they may end up not voting at all rather than casting their ballot for Biden. The political landscape could change in the coming months, but at this point, Trump remains ahead in the opinion polls.

A US administration under Trump is expected to support further strengthening of relations with India.Over the past decade, the India-US relations have expanded across the board and enjoyed bipartisan consensus in America. A US administration under Trump is expected to support further strengthening of relations. Additionally, if the Modi government retains power as expected, it is unlikely to be troubled by US criticism of alleged human rights violations and discrimination against the minorities in India. In some respects, relations between the two countries may become more transactional than they are currently, but this may be only a matter of degree. The transactional element is prominent even now. The need to constrain China in the Indo-Pacific has been a priority for the Biden administration. But it was under the Trump administration in 2017 that the quadrilateral of India, Australia, Japan and the US was revived. During his visit to India in 2020, Trump said at a press conference with Prime Minister Modi at his side: "Together, the Prime Minister and I are revitalising the Quad initiative (involving the US, India, Australia and Japan). Since I took office, we have held the first Quad ministerial meeting and expanded cooperation on counter-terrorism, cybersecurity and maritime security and to ensure a free and open Indo-Pacific.'

- One should expect the US Indo-Pacific strategy to continue and be further consolidated. There are recent reports that Trump may not be supportive of the AUKUS nuclear submarine alliance among Australia, the UK and the US mainly due to the high cost spread over a number of years. He may insist on Australia shouldering a higher proportion of the cost. This would be welcome news for the Chinese.
- What will Trump's policy be on Russia? This is important as it would also influence the Russia-China relations and collaterally, the India-Russia ties. There is a view that Trump will promote an immediate ceasefire in the Russia-Ukraine war, followed by a peace deal involving unspecified territorial compromises. The pressure on Ukraine will be put through denial of economic and military aid, while the pressure on Russia would be that in case the latter is recalcitrant, the US would resume large-scale support to Ukraine. However, Trump's antipathy to Ukraine is well known. It is possible that he would deny support to Kyiv and allow peace on Russian terms. But it is also likely that Europe would try and fill the breach, which it is already doing currently.

Rohingya case brings India's refugee policy under scrutiny

International norms dictate that no one can be deported without informed consent.

THE Central Government told the Supreme Court last month that illegal Rohingyas did not have the fundamental right to reside and settle in India and that New Delhi did not recognise refugee cards issued by the United Nations High Commissioner for Refugees. Rohingya settlements are in the spotlight in several Indian states. In Uttar Pradesh, the police had reportedly detained 74 Rohingya Muslims - 55 men, 14 women, and five minors — in 2023. The Rohingya case cannot be divorced from the community's institutionalised victimisation. This aspect is critical to the ongoing litigation and will clarify India's refugee policy, which will have international consequences as well.

Immigrants are vilified even in the Global North and blamed for the rise in crime and a drop in wage rates. They are dehumanised and subjected to dog-whistle tactics of mainstream politicians to induce mass anxiety. While there is no universal definition of migrants, as per the UN, refugees are people who have fled their countries to escape conflict, violence or persecution and have sought safety in another country. In line with the universally acknowledged 'refugee protection regime', the authorities as well as civil society should ensure that xenophobia is avoided with respect to the Rohingyas.

The trigger for the migration of the Rohingyas is persecution. Myanmar's version is that the Rohingyas came from Bangladesh to Rakhine and their language is Chittagonian, which has similarities with Bengali. Myanmar calls Rohingyas 'Bengalis', which goes against the universally agreed right of the community to 'self-identify'. It is said that the British, when they gained control of Rakhine, facilitated the flight of the Rohingyas as sharecroppers. The community contests this version. Its members affirm that they are native to Rakhine and have a distinct language. In this battle of versions, little attention is paid to the fact that till the British empire imploded in 1947-48 in Myanmar and India and new nation-states were created, including Myanmar and East Pakistan (which became Bangladesh in 1971), the border between the coastal Rakhine and neighbouring Bangladesh's Chittagong district was porous.As per the Arakan Project, in 2019-20, the approximate number of Rohingyas living in Bangladesh, Saudi Arabia, Pakistan, India, the UAE and Malaysia was 9.47 lakh, 5 lakh, 3.5 lakh, 40,000, 50,000 and 1.5 lakh, respectively. Except India, all countries which have hosted Rohingyas in large numbers are Muslimmajority. In India, the popular narrative around the Rohingyas seems to be a continuation from the 1990s, when illegal migration from Bangladesh was the norm. As Bangladesh's per capita income surpassed India's, illegal immigration ceased. Thus, this narrative doesn't factor in the specificities of the Rohingyas.

In the ongoing case of Mohammad Salimullah vs Union of



deportation of Rohingyas will violate the right to equality under Article 14 and also Article 21 of the Constitution, which upholds the right to life. It also has to decide whether India is bound by the 'nonrefoulement' principle, which is considered a part of customary international law, despite not having signed the 1951 Refugee Convention. Importantly, in an interim order, the SC said in April 2021 that Articles 14 and 21 were guaranteed to all, irrespective of citizenship. However, the court added: "The right not to be deported is ancillary or concomitant to the right to reside or settle in any part of the territory of India guaranteed under Article 19(1)(e)." This meant that Article 19(1)(e) only applied to Indian citizens. The court further ordered that unless the procedure prescribed for such deportation is followed, it cannot be undertaken.

International norms dictate that no one can be deported without informed consent. The Centre has stated that the deportation process will follow the procedure of notifying the government of the country of origin of the foreigners and the deportation will be ordered only when confirmed by that government that the persons concerned are citizens/nationals of that country and that they are entitled to come back. Practically, the same procedure is being followed for non-Rohingya Myanmar refugees living in Manipur, who escaped after the 2021 coup. The first batch was deported from India last month. For all practical purposes, even if this procedure is adhered to, the Rohingya deportation is subject to the Myanmar Government's consent, which is an unlikely scenario. The ongoing case also cannot be

delinked from the litigation on the Citizenship Amendment Act (CAA). Except the clause on religion, the Rohingyas fulfil the criterion of persecution mentioned in the CAA. The apex court will also have to reconcile Article 21 and Article 19(1)(e) in its final order. This will determine whether refugees coming to India will have legal recourse like they do in some Western democracies or their stay/deportation will solely depend on the executive's discretionary powers.

Rohingyas are usually employed as daily labourers. In India, some contractors hire them for governmentfunded projects and other work as they charge lower wages compared to the locals. A key argument in support of their deportation is that their stay in India may endanger national security. However, there is no evidence to this effect, a fact underlined by security officials. To sum up, the intent to deport the Rohingyas is empty rhetoric. With the forcible deportation of a community universally recognised as one of the most persecuted an unlikely prospect, India should take the lead in constituting a consortium of host countries to address the challenges facing the Rohingyas, including formulating innovative solutions for the community members. This would enable them to work legally and also address the concerns of law enforcement authorities in the host countries. Saudi Arabia has mooted proposals like the issuance of permanent residency. Some of the Gulf countries concerned may be willing to join India to fund this consortium, and this can provide a template for similarly persecuted refugees and their host countries elsewhere.

THE India Employment Report 2024, released recently by the Institute for Human Development in partnership with the International Labour Organisation, provides a comprehensive analysis of the latest official data. Some of its key findings are: the slow transition to non-farm employment has reversed; nearly 82 per cent of the workforce is engaged in the informal sector and around 90 per cent is informally employed; the youth unemployment rate has increased in accordance with the level of education, with the highest rate among those with a graduate degree or higher; and the real wages of regular workers have either remained stagnant or declined.

This is the situation even when GDP growth rates have been rising after the post-Covid recovery. If growth rates rise further, the acute problem regarding employment will continue. This calls for a policy response. But when looking for one, there is a mindset barrier that needs to be overcome first. One way of understanding this is to compare our performance with that of China. In 1991, the per capita incomes of the two nations were almost the same, and technologically, we were on a par, notwithstanding China being a powerful centralised state. Today, the Dragon has a per capita income that is five times ours. It has become the factory of the world and is trying to catch up with the US in frontier technologies. The primary reason for this widening gap has been our embrace of the Washington Consensus, with its faith in the efficacy of free markets, globalisation and the diminished role of the state. The state should restrict itself to providing macroeconomic stability, ease of doing business and the provision of physical

infrastructure, along with education and healthcare. The state should not pursue an old-fashioned industrial policy as it is incapable of 'choosing winners and losers'. The Chinese, on the other hand, made symbolic gestures to please the West but followed the smart industrial policies that South Korea and Japan had pursued to catch up with advanced industrial economies. The state steered the economy with pragmatic policies. The problem with our mindset was reflected in the comments of Chief Economic Adviser V Anantha Nageswaran at the release of the report; he listed all good macrolevel policies that were already there. It was now for the industry to create jobs. There was, by implication, nothing more that the government could do.Given the severity of the employment challenge, it is time for a paradigm shift. The focus needs to shift from GDP growth to the creation of more productive and better-paying jobs. GDP growth should be a corollary of job creation. The starting point for change is to realise that smart sectoral policies can steer market forces to create more jobs. The purpose of choosing sectors and policy instruments has to be higher job creation.

There are two macro-level decisions that are prerequisites for offering better incentives to firms to create jobs. The first is for the Reserve Bank of India to give up the article of faith of letting market forces determine the exchange rate rather than acting to prevent real exchange rate appreciation. Real exchange rate appreciation makes imports cheaper and exports more expensive and has an adverse impact on employment. India is getting disproportionately large capital inflows through remittances and speculative foreign investments in



our stock markets, resulting in real exchange rate appreciation. East Asian nations kept their currencies artificially depreciated to industrialise faster.More than improving the ease of doing business, firms look at the cost of doing business. The PLI (production-linked incentive) is a recognition of the fact that there is a cost disadvantage in manufacturing in India, and a cash grant is made to offset this disadvantage linked to the achievement of agreed levels of output. It would be much better to lower costs across the board. But this would involve difficult decisions. These would include bringing petrol and diesel into the GST ambit, that in the 18 per cent slab, doing away with toll highways, ending cross-subsidy in rail freight charges and making the movement of goods by rail lucrative. The high cost of logistics in India is a major source of competitive disadvantage. Further, creating affordable rental accommodation for workers near manufacturing areas would improve their productivity.A few labour-intensive sectors

with the highest potential for creating jobs need to be chosen initially for putting together a critical mass of interventions to achieve a breakthrough. Tourism creates many jobs, but it awaits state-driven investment to establish destinations that attract international tourists and wealthy Indians in large numbers. In manufacturing, selectively raising the import duty and combining this with a package of financial incentives to achieve scale and competitiveness is one option that has produced good results in the case of toys. Having an FTA (free trade agreement) with the European Union should be a priority, as it would provide duty-free access to the European market for our labour-intensive garment exports. Creating, for instance, a labourintensive ship-building industry is feasible. In the industrial era, competitive advantage is not a natural endowment; it is created. The state, in consultation with the domestic industry and global firms, can work out incentives that would lead to large-scale investment and job creation. Apple is a good example of the success of this approach in the manufacturing and export of smartphones.A national mission for achieving 100 per cent modern solid waste management, sewage treatment and processing and utilisation of bio-waste as a source of renewable energy should get the resource allocation needed for giving us a clean environment and, at the same time, creating large-scale dispersed employment.

The key is to design state interventions and allocate financial resources, giving job creation overriding priority. It should be profitable for private firms to create more jobs, and the state can and should make it happen.

22 leaders from Chirag Paswan's party resign, say will back INDIA bloc

In a major blow to Chirag Paswan's Lok Janshakti Party, 22 leaders from the party resigned after they expressed their displeasure over not getting Lok Sabha poll tickets. They said they will support the Opposition INDIA bloc.

New Delhi. Twenty-two leaders from Chirag Paswan-led Lok Janshakti Party (LJP) have resigned after they objected to not getting tickets for the upcoming Lok Sabha elections, dealing a major blow to the party days after it sealed a pre-poll alliance with the BJP.The leaders claimed that Chirag Paswan "sold all Lok Sabha tickets" and said they would now support the Opposition INDIA bloc, news agency ANI reported.Among those who stepped down include former minister Renu Kushwaha, former MLA and LJP's national general secretary Satish Kumar, state organisation secretary Ravindra Singh, state general secretary Rajesh Dangi and party

leaders Ajay Kushwaha and Sanjay Singh. Renu Kushwaha lashed out at Chirag Paswan for giving tickts to "outsiders", according to ANI."Tickets should be given to the party workers instead of people from outside. Tickets were given to outsiders, which meant that competent and hardworking people were not getting their due. Do we belong to the labour class that we will work for you and



make you a leader," Kushwaha said.Satish Kumar said the rebel LJP leaders will now back the INDIA bloc in the Lok Sabha polls. He accused Chirag Paswan of betraying the people of Bihar.

New Delhi. For the past two days, residents of Koramangala in Bengaluru have been dealing with the constant buzzing noise of a plane circling above the neighbourhood. Several X users pointed out that a Docine circle was reasoning also to the arround end did Boeing aircraft was passing close to the ground and did around six circles over the HAL (Hindustan Aeronautics Limited) Airport.Flightradar24, which tracks commercial flights, said the aircraft was a Boeing 777-337 (ER), with registration number K7067, which is used to fly VVIPs like the President, Viao President and Prime Minister Vice President and Prime Minister.

Flight data showed the aircraft departed from Delhi, and made six circles around the HAL airport. The data further revealed that the aircraft left Delhi at 5.32 pm on April 3 and returned at 10.54 pm from Bengaluru.

"A really low flying plane circling Bangalore near Koramangala, Indiranagar area. Comes really close to the ground then takes off again without touching," one of the residents posted on X.Mohan Krishnan, a retired scientist who worked at the National Informatics Centre, said since the model code of conduct was in force due to the Lok Sabha polls, the aircraft might be flying to remain in good condition or training pilots.Some users complained of the constant noise of the aircraft. "I see this every night. Flying at low altitudes, blaring," one user said. Another commented, "This one is frustrating, seeing it daily."

A resident said he noticed the aircraft multiple times over the past two weeks. An alumnus of the National Defence Academy said the HAL Airport, a defence airport, was also used for training pilots for commercial airlines as well.

'Lost 4.5-kilogram weight...': Atishi on Arvind Kejriwal's health inside jail

New Delhi Aam Aadmi Party (AAP) leader and Delhi Minister Atishi on Wednesday claimed that the health of Delhi Chief Minister Arvind Kejriwal has been rapidly deteriorating since his arrest on March 21 in the now-scrapped liquor policy case.he said that Kejriwal, who suffers from "severe diabetes", has lost 4.5 kg weight ever since his arrest.

'Delhi's Chief Minister Arvind Kejriwal is severely diabetic. His sugar level needs to be monitored at regular intervals throughout the day. His medicines, insulin injections, food, and diet, have to be according to the fluctuating sugar level. Severe diabetes can lead to various health complications, it can affect a person's heart, kidneys, eyes, and entire nervous system," she said in a press conference. The biggest threat of severe diabetes is a drop in the blood sugar level, which is also known as hypoglycaemia. If a patient's sugar level drops below 50, it could prove to be fatal. This is why a diabetic patient's sugar level must not go below 80" she added.Notably, Kejriwal was arrested by the Enforcement Directorate (ED) in an excise policy-linked money laundering case. He has been sent into judicial custody till April 15.

The temperatures were above normal by 1-4 degrees Celsius at many places over IndoGangetic planes, south peninsular India and West Bengal & Sikkim; at isolated places over north-east India.

IMD has predicted a gradual rise in maximum temperatures by 2-3 degrees Celsius over many parts of East India during the next 3 days and no significant change thereafter.

1854, and more recent developments since the 2016 Paris developments since the 2010 Parts deal. The historical record encompasses 122 entities linked to 72% of all the fossil fuel and cement CO2 emissions since the start of the industrial revolution, which amounts to 1,421 gigatonnes, The Guardian said.

In this long-term analysis, Chinese state coal production accounts for 14% of historic global C02, the biggest share by far in the database. This is more than double the proportion of the former Soviet Union, which is in second place, and more than three times higher than that of Saudi Aramco, which is in third



The enthusiasm among investors was further fueled by HDFC Bank's performance, particularly its exceptional showing in retail loans for the fourth quarter, where it reported over 100 per cent year-on-year growth. This performance not only bolstered the sentiments surrounding the banking sector but also contributed significantly to the upliftment of index heavyweight stocks.

Varun Aggarwal, founder and managing director, Profit Idea, said, "In the preceding session, the domestic equity benchmarks experienced a relatively flat close with a slight negative bias, amid subdued global cues. 

In a statement, the AIFF said its Internal Complaints Committee (ICC), which investigated the alleged harassment case



recently, was "not in a position to continue the investigation as the alleged victim and the other party do not wish to pursue the matter any further." "The ICC would not be in a position to continue the investigation as any complaint and/or further information regarding the alleged incident has been denied by the concerned individuals. "In

view of the above, the investigation was concluded as withdrawn," the AIFF said in the statement. Two footballers of Himachal Pradesh-based Khad FC, taking part in the Indian Women's Football (IWL) League On Tuesday, the AIFF also dissolved the threesecond division, had alleged that Sharma, the owner of the club, had barged into their room and physically assaulted them on the night of

March 28.On Saturday, the AIFF asked Sharma to refrain from football-related activities till the conclusion of a probe by a panel into his alleged incident. Sharma was arrested by Goa police after the host state association lodged a complaint and later released on bail. Before that, the Emergency Committee of the AIFF comprising president Kalyan Chaubey, vice-president N A Haris and treasurer Kipa Ajay, on Monday took stock of the complaints received from the players against Sharma.

Thereafter, a meeting of AIFF member associations was held on Monday night and "Sharma was called and heard for a few minutes before he was advised to leave the meeting."
