"In a major breakthrough in West Bengal's Bhupatinagar blast case, in which three persons were killed in December 2022, the NIA arrested two key conspirators amid stiff resistance from an unruly crowd in the state's East Medinipore dis-

trict," the spokesperson said. The duo - Balai Charan Maity and Manobrata Jana - were arrested after extensive searches at five locations, including the house of Jana, where locals tried to obstruct the NIA team. A member of the NIA team suffered minor injury and the agency's official vehicle was also damaged, the spokesperson added. Three persons were killed when an explosion ripped apart a kutcha house

Bhupatinagar on December 3, 2022. The investigation was later handed over to the NIA. Saturday's incident also brought back memories of January 5 when officials of the three Enforcement Directorate were attacked by a mob in North 24 Parganas district's Sandeshkhali during a search on the premises of ruling Trinamool Congress leader Shajahan Sheikh in connection with alleged irregularities in the public dis-

New Delhi, April 6: The Communist Party of India (CPI) released its manifesto for the Lok Sabha election on Saturday, promising to scrap the Citizenship (Amendment) Act, remove the 50 per cent cap on reservations for SCs,

STs and OBCs, and enhance the daily wage under MGNREGA to Rs 700. The Left party called for the defeat of the ruling Bharatiya Janata Party (BJP) to save secular democracy. It said the 10-year BJP rule has proven to be a disaster for the country. If elected to power, the CPI promised to scrap the Citizenship (Amendment) Act, remove the 50 per cent cap on reservations, conduct a caste census, introduce taxation measures such as wealth tax

and inheritance tax, increase corporate tax, introduce reservation in the private sector, and raise the daily wage under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)

Rs 700."General elections for the 18th Lok Sabha are going to be very crucial and critical for our secular democratic republic, its future and to our constitutional ethos." the CPI manifesto stated. After releasing the manifesto, CPI general secretary D Raja



said, "The elections are very critical for the country and its future. (Prime Minister Narendra) Modi's rule has been disastrous for the country." "The Constitution is under attack. BJP being political army of RSS is trying to change the Constitution and ulti-

mately replace it," he alleged. The Left party said if voted to power, it will introduce measures to address the growing inequality. The CPI also said it aims to bring central investigative agencies like the Enforcement Directorate (ED) and the Central Bureau of

Investigation (CBI) under the purview of Parliament, and added it will "intensify its struggle for the abolition of Governor's Office to strengthen federalism by removing Union's interference." "Elected governments in states should be empowered to take major policy decisions...," the manifesto stated. The CPI said it will continue to fight politically and legally to remove the "arbitrary" cap of 50 per cent on reservations for SCs, STs and OBCs, and implement women's reservation immediately by removing

the clause relating to delimitation and census. The party promised increasing the available work days under the MGNREGA to 200 in a calendar year as well as introducing an Urban Employment Guarantee Act and social security for gig-workers.

New Delhi, April 6: The Congress on Saturday hit back at Narendra Modi over his remarks that the party's manifesto bore a Muslim League imprint, saying the prime minister "does not know his history" as it was none other than Jan Sangh founder Syama Prasad Mookerjee himself who was part of a coalition government in Bengal with the League in the early 1940s. Addressing an election rally in Saharanpur, Modi said the Congress manifesto bears a Muslim League imprint while a part of it is dominated by the leftists. Reacting to the prime minister's remarks, Congress general secretary Jairam Ramesh said, "The prime minister does not know his history as it was, in fact, none other than Mookerjee, the president of the Hindu Mahasabha then, who was himself part of the coalition government in Bengal with the Muslim League." The Hindu Mahasabha was also in coalition with the Muslim League in Sindh and North-West Frontier Province. "It is the BJP, not the Congress, that believes in and practices the politics of divisiveness,' Ramesh said.

Days get hotter across Telangana, respite in sight

HYDERABAD. Telangana, on Friday, experienced one of the hottest days since the onset of summer, with most districts recording maximum temperatures above 420 Celsius. According to the Telangana State Development Planning Society (TSDPS), the day's highest temperature of 43.50 Celsius was recorded at Ibrahimpet in Nalgonda district, followed by 43.30 Celsius in Kumurambheem Asifabad district. The maximum average temperature in the state during the day was 40.50 Celsius against the 38.60 Celsius normal.

Within the Greater Hyderabad Municipal Corporation (GHMC) limits, the highest temperature recorded on Friday was 420 Celsius at Langar Houz. The maximum average temperature within GHMC limits during the day is Celsius against 37.80 Celsius.As per the India Meteorological Department (IMD), heatwave conditions are likely to prevail at isolated pockets in Khammam, Nalgonda, Suryapet, Mahabubnagar, Nagarkurnool, Wanaparthy, Narayanpet, and Jogulamba Gadwal districts on Saturday. Due to the intense heat, NREGA workers and employees from various departments who work outdoors have been advised to limit or avoid work between 12 pm and 5 pm.The IMD has also forecasted thunderstorms accompanied by lightning and gusty winds of 30-40 kmph at isolated places in Adilabad, Kumurambheem Asifabad, Mancherial, Nirmal and Nizamabad districts on April 7.

Thunderstorms are expected at isolated places till April 9.In view of the heatwave alert issued by the IMD, the Director of Public Health for Telangana has issued a public advisory with precautionary measures to avoid any adverse health effects due to the rising temperatures

13 escape unhurt as fire breaks out in office building in Bengaluru


BENGALURU. Thirteen employees of a private company escaped unhurt after a major fire broke out in the basement of their office building in the city on Friday, thanks to a fire safety training provided to them a few days ago. It was work as usual for the employees of Business Solution Ltd at the Miracle Drinks complex on 80ft Road in RT Nagar.Aravind, an employee of the company, noticed sparks in one of the generators in the basement of the building around 1.50pm. Soon, the generator caught fire. Aravind attempted to douse the fire with the help of an extinguisher, but could not. He rushed to the first floor and alerted other employees there. By then, the fire spread to other parts of the building. All 13 employees took the staircase to the second floor and were looking for ways to get out of the building.

Meanwhile, a ladder was reached out to them from an adjacent building. By the time personnel from the Fire and Emergency Services Department arrived at the spot, five employees reached the adjacent building safely through the ladder. The rest were rescued by the firefighters. "We received fire safety training sometime ago and it helped us in escaping unhurt. Five of us could reach the adjacent building with the help of the ladder. Later, the firefighters rescued the remaining employees. Two employees faced breathing problems and were rushed to a nearby hospital," Aravind told TNIE. The company has 50 employees and only 13 were in office on Friday. The rest worked from home. Twenty-five motorcycles and some boxes containing ayurvedic products were destroyed in the fire that engulfed the basement, according to sources.Deputy Director (Fire Prevention) Dr Yunus Ali said six fire tenders took three hours to douse the fire. The reason for the fire is yet to be ascertained. "There were generators and two-wheelers in the basement." he added.

Team of anti-terror agency NIA attacked in Bengal's East Medinipur, officer injured

A team of the National Investigation Agency (NIA) was attacked in the Bhupatinagar area in East Medinipur district of West Bengal on Saturday during a raid in a 2022 bomb blast case. An officer was injured in the incident.

Kolkata. A team of the National Investigation Agency (NIA) was attacked in Bengal's East Medinipur district on Saturday during a raid in connection with a 2022 bomb blast case. An officer of the anti-terror agency has been injured in the attack that happened in the Bhupitaninagar area.During the raid, a mob suddenly attacked the team and vandalised the agency's car, resulting in the vehicle's windscreen being broken.A video showed several men and women blocking a police vehicle and shouting at the police, asking them to go back. The women were seen sitting on the street in front of security personnel with bamboo sticks in their hands.

An FIR has been registered with the local police regarding the incident under Sections 341 (wrongful restraint), 332 (voluntary hurt to deter public servant of duty), 352 (assault or criminal force without any grave provocation), 186 (obstructing public



servant in discharge of public functions), 323 (voluntarily causing hurt), 427 (mischief causing damage to the amount of fifty rupees or upwards), and 34 (criminal action committed by several persons with common intention) of the Indian Penal Code (IPC) and Section 3 of the Prevention of Damage to Public Property (PDPP) Act. The case has been lodged against Monobroto Jana, his family members and other unidentified

persons. An NIA source told India Today that the local police station was informed beforehand about the raid, and yet proper security arrangements were not put in place. According to police sources, however, the NIA team went to Bhupitaninagar at 5.30 am much earlier than they were supposed to -and then called for reinforcements.The situation is under control now and the police have launched an investigation into the nave faunched an investigation into the attack. The Bhupatinagar blast took place in December 2022 at a Trinamool Congress (TMC) leader's home in the Naryabila village under Bhupatinagar Police Station, killing three people. The NIA began probing the metter in the 2023 The attack on the the matter in June 2023. The attack on the NIA team came just two months after an attack on a team of the Enforcement Directorate (ED) in Bengal's Sandeshkhali on January 5. Expelled TMC leader Sheikh Shahjahan was arrested pertaining to the attack nearly two months after he was on the run. Some of his associates, including his security guard as well as his brother have also been arrested by the Central Bureau of Investigation (CBI) in connection with the January 5 attack on the ED team.

Poor awareness & tedious paperwork: Why only 8,467 transpersons have voter IDs in TN

CHENNAI.Out of the 6.23 crore voters enrolled in the state, the voting population of transgender people is a meagre 8,467 as per the data of the state election commission. The figure has triggered concerns among the community members who points out that the number is much lower than their actual population.As per the 2011 census, the number of transgender people in Tamil Nadu was 22,364 and in the last 12 years, the number would have doubled, at least. According to an estimate by activists, there are not less than 60,000 transgender people in the state but due to their minuscule representation in the voters' list, they feel left out in the electoral process.

Apart from social stigma, community members attribute lack of a proper survey and awareness by the state government and election commission as the main reasons behind the poor enrollment.

Grace Banu, a transgender rights activist, blamed the state government for not conducting a proper survey. "TN claims to be one of the first states in the country to introduce a transgender welfare policy, but what is its use if you don't have exact data on the community's population?" asked Banu, who has filed a petition in the Madras HC seeking reservation for trans people in job and education.

The activist claimed until three years ago, to get a transgender ID card, the community members had to undergo medical and psychiatric tests, due to which many refrained from getting it. And without a transgender ID card, it is difficult to get a voters' ID with the gender rightly mentioned."As per my voter ID card, I'm a female. Due to the tedious paperwork, I never tried to update it as trans woman," she added.M Radha, a trans woman who contested in the 2019 general election and is currently a member of the transgender welfare board, said that trans people can easily get the ID cards using Aadhaar card.K Padma, another trans woman, said before every poll, the election commission runs campaigns to raise awareness on voting but they have not focused on educating transgender people about the process. "If we are not counted as voters, how will the political parties work for our welfare?" asked Padma.Jaya from Sahodaran, an LGBTQIA+ organisation, said, "Due to a lack of awareness and burden of paperwork, many trans individuals vote by categorising themselves as male or female.'

Bengaluru firm workers hire goons to beat 'strict' colleague, arrested

Bengaluru The Bengaluru Police on Friday arrested five people for assaulting a man who works as an auditor with a private firm. Two of the five people arrested were colleagues of the auditor, and they had hired the goons to beat him up, the police said. The police took action after a video of the assault went viral on social media. The video, which was shot on the dash camera of a car, shows the accused men beating Suresh, the auditor, with an iron rod on the ring road near Kalyan Nagar.According to the police, Suresh works as an auditor with a milk

product company in Bengaluru. Umashankar and Vinesh, among those arrested by the police, also worked with



accused admitted to the crime, claiming that Suresh put a lot of pressure on them. The accused said Suresh had joined the

company a year ago and was a strict auditing officer. He allegedly harassed and demanded that all employees clear the stock balance promptly.

Before Suresh's arrival, these accused individuals were lax and delayed in clearing the balance, the police said. Suresh brought this to the attention of the company's seniors and took strict action against Umashankar and Vinesh.Miffed over Suresh's action, Umashankar contacted a former employee who introduced him to Sandeep, another accused.Following

Kerala: One killed, 3 injured in blast while making bomb in Panur

KANNUR. A bomb went off while being made, killing a 35-year-old and seriously injuring three others in Panur, Kannur, on Friday. The deceased has been identified as Kattintavida Sheril. Expenses deter migrant workers from going home for voting

TNIE spoke to a few north Indian labourers to know if they would be going to their native places to vote in the election.

COIMBATORE. Though the Election Commission of India (ECI) has been actively involved in awareness campaigns to boost poll percentages in the upcoming Lok Sabha election, many north Indian migrant workers in Coimbatore and Tiruppur districts are not keen on going to their native places to cast their votes. The migrants are mostly employed in industries or work as street vendors. Travel expenses and loss of salary or daily wages discourage them from going to home states ahead of the voting day. Shockingly, some workers are not even aware of the forthcoming election dates in their respective states. The seven-phase Lok Sabha election starts on April 19 and ends on June 1.TNIE spoke to a few north Indian labourers to know if they would be going to their native places to vote in the election. Several labourers replied that they are not



interested to go home and cited various reasons, though a few expressed intent to be there for voting. A labour, A Ashokumar (22), hailing from Patna in Bihar, who has been working at a hotel in Gandhipuram bus stand told TNIE, "If I go to my hometown to cast a vote, I should spend around Rs 5,000 for travel, food, etc. I have to stay at least 15 days there. Thus I will lose about Rs 8,000 from my salary. This poses a financial burden on my family," he said, adding, he is not even aware of the polling date in his state. Swaraj (28), who is from Uttar Pradesh, runs a small

'beeda' shop at Saradha Mill road in the city for the last eight years. He said, "I go to my native place once a year. I returned from there only five months ago." When asked about casting his vote, he admitted he may incur about Rs 7,000 for travelling to home state and can't spend that much.C Ajith Kumar, who is working in a garment unit on Mangalam road in Tiruppur, told TNIE, "My friends will travel to Jharkhand and Bihar to vote, but some of them have decided to stay back. The cost of travelling and other expenses would come to Rs 2,000. So myself

No fire stations in new sectors': Residents want infra set up, write to DC

- Gurgaon: Residents of new sectors along Dwarka Expressway have written to the deputy commissioner seeking to build proper fire infrastructure in highrises. These sectors, developed over the last 10 years, lack basic amenities such as a fire station in the area.
- With over 50,000 families living in around 40 societies between sectors 99 and 115, absence of a fire station in the locality is not a promising situation.
- The nearest fire station is in Sector 29 around 20km from the societies along the expressway. Residents said this could lead to delayed response time in case of a fire, posing risks to both life and property.
- Pravin Kaushal, a resident of Sobha City, highlighted the urgency for a fire station in sectors 108 and 109 due to the area's high population density. "We are struggling with basic government services, such as fire stations, which are essential for safety. At present, response time for a fire emergency is about one hour, which could result in significant losses," he added.
- According to the Haryana Fire Services Act, urban areas should ideally have a response time of five minutes while rural areas can have 15 minutes.
- Sunil Sareen, a resident of Imperial Gardens in Sector 102 pointed out, "While neighbouring Delhi boasts an advanced and modern firefighting infrastructure, the same cannot be said about Gurgaon," he said.
- The city currently has seven fire stations with a fleet of 64 fire tenders. Fire stations have been proposed in sectors 9, 9A, 23, 43, 92, and 95. Gulshan Kalra, deputy director (technical) of Haryana fire services, said the proposals have been sent to state govt. "HSVP will build these fire stations and transfer them to the fire department," he said.

- Noida. A group of farmers in Jewar's Ranhera village held a meeting on Friday and decided to abstain from voting in the Lok Sabha election. The farmers had given their land for development of the Noida airport. They were shifted to Jewar Bangar township. However, the township residents have claimed that govt has not put in place all the facilities that were promised before rehabilitation, including a community hall, a post office, a health centre and a crematorium.
- Neeraj Kumar Singh, a Ranhera resident, said that Noida international airport was projected as one of the world's leading airport projects, and was meant to develop the area further. "However, the project has badly affected the original land owners, who have been displaced. The farmers' lands have been acquired and the local youth, earlier involved in farming, are now jobless. The development we expected has not been witnessed," he said. Another resident said that they had asked the govt to make a gaushala (cowshed) for the farmers to keep their cattle. A boy died, but missing manhole covers threaten more tragedies

Gurgaon. Days after a two-year-old boy died after slipping into an open manhole in Sector 37, there are still several drains and manholes lying uncovered in some of the city's most densely populated areas such as Basai and Harsaru.On Friday, hundreds of vehicles were seen crossing by an open manhole on Pataudi road in Harsaru. Residents of the village said they have raised multiple complaints with MCG. The corporation's staff even brought a cover two months ago, but when that didn't fit, they took it back, leaving the manhole open since, they said."We have raised the complaint a number of times, but MCG does not resolve the issue. This manhole is right in the middle of a road. It is a potential threat to the lives of commuters. There have been various accidents on this road due to this open manhole. Authorities are waiting for a major mishap before they act," said Kulwant Sabharwal, a resident of Harsaru.Sube Singh, who runs a shop nearby, said some MCG staffers had visited the spot months ago. "They got the cover, but it was too big, and made the road surface uneven. So the manhole was left open. It will be even more dangerous during the monsoon as the road tends to



get waterlogged and it already has a lot of potholes," Singh said.At Basai Chowk, one of the busiest intersections in the city, is a 7-foot-deep drain that was left open after some workers came with an earthmover two months ago and lifted the slab on it."We requested them not to take the cover of the drain as it is deep and anyone can slip into it. But it was taken away. A tape has been put to highlight the danger that the drain is uncovered. But it has been this way for months now," said Suhail Ahmed, a juice shop owner in

Basai.MCG had started a campaign to replace damaged manhole covers and install new ones across the city in Sept last year. But the drive fizzled out soon after.Residents of Ardee City and Sushant Lok-3, which were taken over by MCG in June 2022, said they have also complained to the corporation about the risk of open manholes in the colonies."There are seeral open manholes in Ardee City, but one of them is on a main road within the colony. Most people have to use that road. It can't be avoided. We

2 yrs gone & 2.5cr paid to co, but waste collection scan tag plan yet to take off

Gurgaon. Two years after its launch, MCG's ambitious radio-frequency identification (RFID) tags project, which is aimed at ensuring real-time monitoring of door-to-door waste collection, has failed to get under way ..

There is no clarity on the project from solid waste management concessionaire Ecogreen. Hence, the work has been put on hold. We had also written to MCG to get the project started. However, we received no communication from them on this," said a representative of the private agency that secured the project in 2022.

We have so far received Rs 2.5 crore from MCG as payment for the project. The total project cost is Rs 9 crore, which includes Rs 3 crore for operations and maintenance for three years after the project commences," the representative added. The agency claimed it has installed 2 lakh RFID tags outside households to track their waste collection and will install the remaining 1 lakh tags after MCG instructs them to do so.

Ecogreen drivers were given electronic readers to ensure the use of RFID tags installed outside houses. However, it did not work out. We will ensure the start of operations of the system when a new agency takes up the primary waste collection or the existing agency streamlines the process," said MCG Joint Commissioner (Swachh Bharat Mission) Naresh Kumar.A committee was recently constituted to carry out a comparative analysis of the RFID tags in the city and those in Manesar, since the tags installed in Manesar were made operational and were cheaper compared to those installed in the city. However, it has not yet submitted its report. The civic body had set Nov 30, 2022 deadline for installation of RFID tags outside three lakh households in the city. Gzb to NIA in 37 mins: RRTS route plan ready

- Noida. The NCR Transport Corporation has submitted its final report for the 72.3km RRTS-cum-metro corridor from Ghaziabad rapid rail station to Noida International Airport (NIA), which is likely to be operational by April 2030.Once ready, the total time needed to cover the distance from Ghaziabad to the airport will be 37 minutes for fast service and 50 minutes for normal service. Fliers can also reach Sarai Kale Khan from NIA in 56 minutes and IGI airport in 66 minutes. It will take commuters to Meerut in 72 minutes. According to the project report, the corridor will have two sections - one from Ghaziabad RRTS station to Ecotech VI near Kasna and another from Ecotech VI to the ground transport centre (GTC) of Noida airport.Initially, the corridor will have 22 stations, but 13 stations can be added later, the draft plan states. The first section will be 39.4 km and have seven RRTS and 11 metro stations with a provision to add three stations later. The second section, which will be 32.9 km long, will have four RRTS stations initially. Ten stations — one RRTS and nine metro — can be added later in this segment.
- Officials said the rapid rail trains will halt only at RRTS stations but metro trains will halt at all the stations.
- Work on the corridor is slated to start once it gets UP govt nod. Officials said both the sections will be built simultaneously and the Rs 20,043.6-crore corridor is expected to be constructed in five years. According to the DPR, section 1 will have an interchange with the proposed Aqua Line metro station at Greater Noida West's Sector 4 station and the existing station at Alpha 1. It will be an elevated corridor and start from Ghaziabad RRTS station. It will traverse along Vishwakarma Road (Siddharth Vihar/Pratap Vihar in Ghaziabad), Taj Highway, Char Murti Chowk, Greater Noida Link Road (Knowledge Park-V) and then turn to Surajpur-Kasna road. The route will pass through Pari Chowk to end at EcoTech VI in the Kasna area. The alignment of the second leg will start from EcoTech VI and cross the Eastern Peripheral Expressway (EPE) to connect nearby areas, such as Dankaur, Kanarsi, Dhanauri Khurd, Bhatta, Parsaul, Rabupura, Dayanatpur, and Kishorpur. It will conclude at the GTC near NIA's Terminal 1.

13 units shut for discharging chemicals into Yamuna in Sonipat, city factories on radar

Gurgaon. As many as 13 dyeing units in Sonipat have been shut down after they were found discharging untreated effluents into open areas and drains, which ultimately flow into the Yamuna.

This was submitted to the National Green Tribunal (NGT) on Friday by a joint committee comprising representatives from the Central Pollution Control Board (CPCB), Haryana State Pollution Control Board (HSPCB), and district magistrates from Sonipat.In Jan, the tribunal directed four districts of Haryana — Gurgaon, Sonipat, Faridabad and Jhajjar - to carry out a ground survey and inspect dyeing units falling in the 'red category', which have high pollution levels. The districts requested eight weeks' time on Friday to complete the task.NGT's directions came while hearing a petition stating that residential areas in the four Haryana districts are grappling with severe water contamination due to the presence of 'red category' units."During a survey of the area, 13 jeans dyeing and washing units were found operating illegally and discharging untreated effluent directly/indirectly into drain No. 6. All

the 13 units have been closed by the board and electricity connections of all units have also been disconnected on the spot," the report by HSPCB Sonipat stated."The complete survey of the areas mentioned in the case will be carried out by a joint committee and action shall be taken against all illegal industries found operating in violation of the provisions of law. It is requested to kindly provide eight weeks' time for completion of the survey and action against illegal industries, the report further stated.

Meanwhile, reports from Gurgaon, Faridabad and Jhajjar are still pending.

The US Centers for Disease Control and Prevention (CDC) on Friday (local time) issued a health alert to inform clinicians, state health departments and the public of a case of avian influenza in a person who had contact with dairy cows presumed to be infected with the virus. The farm worker from Texas was reported to be infected on April 1, making it the second case of the H5N1 strain of avian influenza, commonly known as bird flu, identified in a person in the US.It follows a 2022 case in Colorado and comes as the virus is spreading to new mammals, including dairy cattle, for the first time.

To prevent infection from the virus, the CDC recommends the use of personal protective equipment (PPE), testing, antiviral treatment, patient investigations and monitoring of persons exposed to sick or dead, wild and domesticated animals and livestock that may have been infected with the virus.Earlier this week, the CDC said the infection does not change the risk assessment for the US general public from H5N1 bird flu, which it considers to be low. The Texas patient's only symptom was eye inflammation, according to the state's health department.

Donald Trump demands new judge ahead of hush money criminal trial

- New York, Former US President Donald Trump is demanding a new judge just days before his hush money criminal trial is set to begin, rehashing longstanding grievances with the current judge in a long-shot, eleventh-hour bid to disrupt and delay the case.
- Trump's lawyers, echoing his recent social media complaints, urged Manhattan Judge Juan M Merchan to step aside from the case, alleging bias and a conflict of interest because his daughter is a Democratic political consultant. The judge rejected a similar request last August.In court papers made public on Friday, Trump's lawyers said it was improper for Merchan "to preside over these proceedings while Ms Merchan benefits, financially and reputationally, from the manner in which this case is interfering" with Trump's campaign as the presumptive Republican presidential nominee. The trial is scheduled to begin April 15. It is the first of Trump's four criminal cases scheduled to go to trial and would be the first-ever criminal trial of a former president.
- Merchan didn't immediately rule. The decision is entirely up to him. If he were to exit, it would throw the trial schedule into disarray, giving Trump a long-sought postponement while a new judge gets up to speed.
- Messages seeking comment were left for a court spokesperson and Merchan's daughter, Loren Merchan. The Manhattan district attorney's office said it saw no reason for Merchan to step aside. The defence's claims that Loren Merchan was profiting from her father's decisions require "multiple attenuated factual leaps here that undercut any direct connection" between her firm and this case, prosecutor Matthew Colangelo wrote in a letter to the judge.
- 'This daisy chain of innuendos is a far cry from evidence" that Judge Merchan has a direct, personal or financial interest in reaching a particular conclusion, Colangelo wrote.Loren Merchan is president of Authentic Campaigns, which has collected at least \$70 million in payments from Democratic candidates and causes since she helped found the company in 2018, records show.The firm's past clients include President Joe Biden, Vice President Kamala Harris and Senate Majority PAC, a big-spending political committee affiliated with Senate Majority Leader Chuck Schumer. Senate Majority PAC has paid Authentic Campaigns \$15.2 million, according to campaign finance disclosures.In a separate development on Friday,

France: Schoolboy dies after attack as Macron warns of teenage violence

A teenage schoolboy died on Friday after he was badly beaten near his school in a town south of Paris as President Emmanuel Macron warned schools should be protected from "uninhibited violence" among some youths. The 15-year-old boy suffered cardiorespiratory arrest after he was attacked by three people wearing balaclavas on Thursday, according to a police source, leading to his death the following day. Thursday's attack comes at a time of heightened tensions in French schools.Jean-Marie Vilain, the mayor of Viry-Chatillon, said the boy was walking home after a music class when he was set upon by "the worst kind of thugs". "This extreme violence is becoming commonplace," he added. Government spokeswoman Prisca Thevenot denounced what she called a "barbaric crime." Till now five people, including a 17-year-old, and 20 year old, linked to the attack have been arrested

An anonymous student said that the



schoolboy, identified as Shamseddine, "got on well with everyone."

This was the second assault this week. Earlier a teen girl was left temporarily

comatose after being attacked outside her school in the southern city of Montpellier on Tuesday. The victim, identified as Samara, was allegedly

attacked by three people.

The police had already arrested three people including a 14-year-old girl from the same school in the city's lowincome area of La Mosson-La Paillade, and two boys."Each of them admits to having hit the victim," prosecutor Fabrice Belargent said on Friday, adding the oldest of the three would remain in temporary detention. The 13 year old victim was attacked because Samara posted a picture of the attacker with an insult on social media, according to fellow student.Looking at the growing number of physical assault cases in the country, President macron said, "We have a form of uninhibited violence among our teenagers and sometimes among increasingly younger ones." 'Schools need to be shielded from this,"

he said, adding they should "remain a

sanctuary for our children, for their families, for our teachers... We will be intransigent against all forms of violence," he added.

Maldives thanks India for allowing limited essential exports amid tensions

Maldivian Foreign Minister Moosa Zameer on Saturday thanked India for its decision to increase the export of essential supplies to the island nation for the fiscal year 2024-25, despite diplomatic tensions between both countries. New Jersey earthquake strongest in over 240 years, 11 aftershocks follow

World As many as 11 aftershocks jolted parts of New York City and surrounding areas after the region was rattled by a magnitude 4.8 earthquake on Friday, shaking buildings up and down the East Coast and surprising residents in an area that rarely experiences notable seismic activity.

According to the United States Geological Survey (USGS), the 4.8 magnitude earthquake was the third-largest earthquake recorded in the area in the last five decades and the strongest in New Jersey in more than 240 years. The initial tremor was felt just after 10.20 am (US local time), at a depth of 4.7 kilometres (2.9 miles). An hour after the initial impact, a 2.0 aftershock struck west of Bedminster, New Jersey. At around 12.30 pm, there was a 1.8 magnitude aftershock, another 2.0 aftershock at 1.14 pm, and another 2.0 aftershock shortly before 3 pm, the USGS said. Though no major damage was reported, engineering teams were inspecting roads and bridges.People from Baltimore to Boston reported feeling rumbling and shaking, with some running outside to try to detect the source. A video shared by EarthCam on X showed the moment the 4.8-magnitude earthquake struck New Jersey and surrounding states. Addressing a news conference post the tremors, New York Governor Kathy Hochul said, "This is one of the largest earthquakes on the East Coast in the last century."Later, James Pittinger, mayor of Lebanon, New Jersey, termed the earthquake a "crazy experience" and said, "I was sitting in my home office when things started to fall off the walls and shelves."Charita Walcott, a 38-yearold resident in the Bronx borough of New York, told CNN the quake felt "like a violent rumble that lasted about 30 seconds or so. It was kind of

like being in a drum circle, that vibration."



New York, New York City agreed to pay \$17.5 million to settle a lawsuit by two Muslim-American women who said the police violated their rights after arresting them by forcing them to remove their hijabs before being photographed. The preliminary class action settlement covers men and women required to remove religious attire before being photographed. It was filed on Friday (local time) in Manhattan federal court and required approval by US District Judge Analisa Torres.Payouts will total about \$13.1 million

after legal fees and costs are deducted, and could increase if enough of the more than 3,600 eligible class members submit claims. Each recipient will be paid between \$7,824 and \$13,125. The settlement resolves a lawsuit filed in 2018 by Jamilla Clark and Arwa Aziz, who said they felt



shame and trauma when police forced them to remove their hijabs for their mugshots the prior year in Manhattan and Brooklyn, respectively.Both had been arrested for violating orders of protection that they called bogus. Their lawyers likened removing the hijabs to being strip-searched."When they forced me to take off my hijab, I felt as in a statement provided by her lawyers. "I'm not sure if words can capture how exposed and violated I felt."In response to the lawsuit, New York's police department agreed in 2020 to let men and women wear head coverings during mugshots, so long as their faces could be seen.

"This settlement resulted in a positive reform for the NYPD," said Nicholas Paolucci, a spokesman for the city's law department.

"The agreement carefully balances the department's respect for firmly held religious beliefs with the important law enforcement need to take arrest photos."The new policy extended to other religious headwear, including wigs and yarmulkes worn by Jews and turbans worn by Sikhs.

The rocks in the western US are younger and contain more faults that absorb earthquake energy.Friday's tremor was the largest felt in the city since a 5.8-magnitude earthquake in 2011 in Virginia prompted evacuations of City Hall and other buildings, thus causing damage in Washington. The quake comes just a few months after the USGS warned nearly 75 per cent of the United States could face damaging quakes in the next 100 years.

Joe Biden visits Baltimore bridge collapse site, meets families of victims

Dundalk. President Joe Biden got a firsthand look Friday at efforts to clear away the "mangled mess" of remains of the collapsed Francis Scott Key Bridge in Baltimore, as cranes, ships and diving crews work to reopen one of the nation's main shipping lanes.

Aboard Marine One, circling the warped metal remains and the mass of construction and salvage equipment trying to clear the wreckage of last week's collapse, which killed six workers, Biden got an up-close view of the devastation.

On the ground later, he received a briefing from local officials, the US Coast Guard and Army Corps of Engineers on the situation in the water and its impact on the region. The President also greeted police officers who helped block traffic to the bridge in the moments before it was hit by a ship — which helped avert an even larger loss of life."I'm here to say your nation has your back and I mean it." Biden said from the shoreline overlooking the collapsed bridge in Dundalk, just outside Baltimore. "Your nation has your back."Eight workers immigrants from Mexico, Guatemala, Honduras and El Salvador — were filling potholes on the bridge when it was hit by

a huge cargo ship and collapsed in the middle of the night of March 26. Two men were rescued and the bodies of two others were recovered in subsequent days.Authorities announced Friday evening that salvage divers had recovered, in the hours before Biden arrived, a third body from the water, that of Maynor Yasir Suazo-Sandoval, 38, one of the missing workers. They said the search for the other victims will continue. The President also

met for more than an hour with the families of those killed."The damage is devastating and our hearts are still Biden said.Officials have breaking,' established a temporary, alternate channel for vessels involved in clearing debris. The Army Corps of Engineers hopes to open a limited-access channel for barge container ships and some vessels moving cars and farm equipment by the end of this month, and to restore normal capacity to Baltimore's port by May 31, the White House says.

That's important since longer delays in reopening shipping lanes could send shockwaves through the economy. As



moves through Baltimore's port per day, and it is the leading hub for importing and exporting vehicles.More than 50 salvage divers and 12 cranes are on site to help cut out sections of the bridge and remove them from the key waterway. Officials told Biden they had all the resources they needed to meet the targets for opening the channel into the Baltimore port. The President announced that some of the largest employers affected by the collapse, including Amazon, Home Depot and Domino Sugar, have committed to keeping their employees on payroll until the port is reopened. That followed days of outreach by state and federal officials to try to mitigate the economic impact.

"From the air, I saw the bridge that has been ripped apart," Biden said, "but here on the ground, I see a community that's pulled together."It is still unclear, though, how the costs of cleanup and building a new bridge will be covered. The Federal Highway Administration has provided \$60 million in "quick release" emergency relief funds to get started. Exactly how much the collapse will ultimately cost is unclear,

though some experts estimate recovery will take at least \$400 million and 18 months.Biden said within hours of the collapse that "the federal government will pay for the entire cost of reconstructing that bridge, and I expect the Congress to support my effort."

Senate Republican Leader Mitch McConnell likened the bridge collapse to assistance that flows after natural disasters and said "The federal government will step up and do the lion's share" of funding. But the authorisation could cause some squabbles in Congress.

Kolkata Amrita Roy, the 62-year-old 'Rajmata' (Queen Mother) of the Kolkata Krishnanagar Palace has been fielded by the BJP against the incumbent MP and Trinamool Congress leader Mahua Moitra for the upcoming Lok Sabha elections. The wife of Saumish Chandra Roy, ninth heir of Raja Krishnachandra Roy, Amrita Roy has been vocal about her family history and the allegations of being "traitors"

Raja Krishnachandra remains a key figure in Bengal's history. He is prominently remembered for his pact with the East India Company and Mir Jafar to defeat Nawab of Bengal Siraj ud-Daulah in the Battle of Plassey, which paved the way for two centuries of British rule in the Indian subcontinent.In an exclusive interview with India Today TV, the erstwhile royal queen spoke over a range of subjects, including her family history, her plunge into politics, and her challenger Mahua Moitra. She also spoke about the Sandeshkhali incident and equated suspended Trinamool Congress leader Sheikh Shahjahan to Siraj ud-Daulah over alleged harassment of women.Here are the excerpts from her interview:

Q: Were you ever interested in politics? Your entry seems quite unexpected.

Amrita Roy: I had never been interested in politics, nor was my family. However, 10 years ago, the BJP approached me through Tathagata Roy, but I declined as I wasn't confident about entering politics at the time. Recently, I was approached again and decided to join the party after considering the corruption scams and the impact on society.Q: Can you tell us about your conversation with Prime Minister Narendra Modi when he first called you?Amrita Roy: It was divine and overwhelming. He made me feel comfortable, as if we had known each other for a long time. He bestowed a significant responsibility upon me, emphasising that I must not be deterred by what people say.

Q: You have a big challenge ahead of you in restoring control of the Krishnanagar seat. How are you preparing for this?

Amrita Roy: Modiji has given me guidance and advice, emphasising the importance of utilising recovered corruption funds to benefit Bengal's poor people. I aim to contribute to society's betterment and fight corruption.Q: How did your entry into BJP and politics come about? Were you in touch with the party leadership?Amrita Roy: I wasn't in touch with them initially. They approached me within 48 hours, stating that I had a clean image and a non-scandalous background. I saw this as an opportunity to bring about positive changes.

Q: Has your family ever been in touch with any other political party or the present West Bengal dispensation, considering your illustrious family history?

Amrita Roy: Apart from having Doctor Bidhan Ch Roy as a family friend in the past, we kept away from politics due to personal reasons.Q: What triggered you to join politics after seeing West Bengal's situation in the last



decade?Amrita Roy: After being approached ten years ago, I focused on preserving the legacy and heritage of the Rajbari, which faced challenges due to local goons and authorities. Keeping the property intact has been a significant challenge.

Q: What kind of disturbances do you face from local authorities and the TMC government? Amrita Roy: I'm not referring to any particular party or government. However, dealing with locals in power can be challenging, as they sometimes misuse their authority, expecting favours or resorting to threats.

Q: Your opponent, Mahua Moitra, is also a first-time MP from Krishnanagar and has been expelled from Parliament due to serious charges. What are your thoughts on her and the challenge she poses?

Amrita Roy: She doesn't pose any challenge because her expulsion from Parliament indicates serious issues. Instead of clearing her name, she should address the allegations against her.Q: Mahua Moitra claims that central agencies like CBI and ED are hounding her out of a political vendetta. How do you respond to this? Amrita Roy: If there's no proof of corruption, why would these agencies pursue her? Her expulsion suggests that something must be amiss.

Election brings a dilemma for seasonal migrant workers in Odisha

BHUBANESWAR. For migrant labourers of Odisha, voting is both a celebration of democracy and a dilemma. Every election, those who head out of the southern districts are able to return home to exercise their franchise but their counterparts from western Odisha find it difficult to participate in the biggest festival of democracy.Odisha. despite being one of the states registering a high percentage of both traditional and seasonal labour migration, faces a huge challenge in ensuring voting by migrant workers.Political party candidates arrange for their return to their native land prior to polling but their efforts bear fruit in southern Odisha only. In western districts, the number of labourers who return is just 20 per cent of the total migrant population. As per the report, 'Migration in India' based on

Periodic Labour Force Survey 2020-21, released by Ministry of Statistics and Programme Implementation, there are 8.51 lakh labourers who migrate for jobs from the state. There are 10 migration prone districts in the state - Bargarh, Balangir, Kalahandi, Nuapada, Ganjam, Gajapati, Kandhamal, Koraput, Nabarangpur and Rayagada. Labourers from these districts migrate to Telangana, Andhra Pradesh, Karnataka, Tamil Nadu, Gujarat and Kerala for work. The Labour department mandates registration

of all labourers at the source point following which they are issued 'movement slips' to head to the destination states. But the number of migrant labourer registrations is miniscule compared to the migration that happens at the grassroots, sources in the Labour department acknowledge. In reply to a query in the Assembly in March last year, the then Labour minister Srikant Sahu had produced a report which stated that in 2022, 362 labour sardars were issued licences to take 26,700 registered labourers to other states for work. In 2021, as many as 271 labour agents were permitted to take 31,785 labourers and in 2020, 117 sardars were allowed to take 11,177 migrant labourers. This year 4,800 registered labourers have been taken to different states by 82 licensed sardars.While traditional migration from Ganjam and other southern Odisha districts take place round the year, September to June is when western Odisha witnesses seasonal migration as people head to brick kilns in neighbouring Telangana and Andhra Pradesh. Traditional migrants from southern Odisha return home once a year but seasonal migrants of western

districts cannot, before completion of 10 months (brick-making period before monsoon)."The trend of migration in southern districts is entirely different from western districts. In southern Odisha, only male members of a family migrate while in western Odisha, migration is family-based as an entire unit is required to contribute towards making bricks," said Loknath Mishra, a migrant rights activist from Berhampur.In the election year, politicians and their supporters in Ganjam and other southern districts facilitate movement of the male members who are eligible voters. "But this election, the pressure on political leaders for getting the workers back from other states is a lot less. Because, a majority of them have already returned owing to the wedding season and the ongoing Danda

Nacha which sees participation of many migrant youths," Mishra said. With Berhampur, Koraput, Nabarangpur going to polls on May 13, supporters of candidates have already approached them to stay back, he added. However, in western Odisha, most of the labourers are likely to give voting a miss. Election in Kalahandi is on May 13 while in Bargarh, Sundargarh and Balangir, it is scheduled on May 20. "Politicians in western Odisha are not interested in getting these seasonal labourers back as they cannot leave the worksite before June. In the past elections, some political workers had approached kiln owners to take back the workers for voting but the latter allowed just male members of the family to go and held back their elderly parents, wives and children," said activist Sushant Panigrahi.

TN govt schools to outsource security, sanitation

CHENNAI. To address issues concerning sanitation and security facilities in government schools, the Tamil Nadu school education department has decided to outsource housekeeping, sanitation, open area maintenance and security work in 1,954 government schools across the state at a cost of Rs 130 crore. About 8,000 workers may be deployed in July to implement this first-ever outsourcing project in Tamil Nadu government schools, sources said. The school education department has divided the state into four zones for selecting the schools for the project based on their student count. "High schools and higher secondary schools with more than 475 students have been selected for implementing the project. The scheme will be extended to other schools over the next three years," a top official in the school education department said. Although the department tried to issue a tender in 2021 to roll out a similar project, it was halted due to legal challenges from some bidders. The education department, however, has now successfully floated tenders following court directives, sources said.



At present, there are less than 500 workers employed in these schools and they would be allowed to continue their work till retirement. The state government has planned the system based on Andhra Pradesh model where external agencies maintain clean and safe environment in government schools.Under the proposed system, security personnel will work in shifts round the clock while the housekeeping and sanitation staff will work from 7am to 3pm. Their duties will include opening and locking of school gates, classrooms, toilets, staff rooms, and other areas.More children will enol if school premises is kept clean, says parent

They will maintain registers for vehicles and visitors and ensure the safety of children on campus. Additionally, they will also report on maintenance requirement and oversee aspects such as water management, ground maintenance, and storage areas.Zonal heads, area managers and supervisors will provide oversight, with periodic inspections conducted by school headmasters, Block Resource Teacher Educators (BRTE s), Chief Educational Officers (CEO s), and Joint Directors. While the monitoring process will ensure safety, training will be provided to employees regarding responsibilities.A web-based mobile application monitoring system should be developed by successful bidders for the project. The application will display the pre and post cleaning status with images and videos. The same has to be uploaded on a daily basis. It will also incorporate AI tools to check the pre and post cleaning status."One of the major concerns of parents while enrolling their children in government schools is the unhygienic condition on premises, especially bathrooms.

FDA suspends south Mumbai bakery licence over hygiene deficiency

MUMBAI. The state Food and Drug Administration (FDA) has suspended the licence of popular bakery Suleman Usman Mithaiwala on Mohammed Ali Road due to hygiene shortcomings, improper waste food disposal and inadequate health checks for staff, among other violations. The food regulatory body has instructed it to cease operations from April 2 to April 10. However, when TOI visited the restaurant on Friday, it was operational. The restaurant claimed it is yet to receive any orders. FDA officials said they initially identified violations in Jan through online images uploaded by the restaurant on the Food Safety Compliance System (FosCos). This web portal, managed by FSSAI, serves as a platform for food licensing and registration. It was followed by a physical inspection in Feb where FDA pointed out several violations.Dr Shailesh Adhao, joint commissioner (food), highlighted areas of partial compliance, including the cleaning of equipment and premises as per the scheduled requirements. Additionally, officials noted partial adherence to the periodic removal

of food waste. They also identified insufficient lighting.Of significant concern was the absence of annual medical examinations and vaccinations for food handlers against enteric diseases. Further, there was partial compliance



in providing food handlers with essential protective gear such as aprons, gloves, headgear and shoe covers. Adhao said a food safety officer will inspect the premises on Saturday, and if found open despite the order, further action will be initiated. When TOI contacted the bakery, it confirmed it was being inspected.

Concerns abound over social media data collection

A bipartisan Bill that would force Chinese tech giant ByteDance, the parent company of TikTok, to sell the social media app or face a ban for all US devices was approved by the US House in March, reflecting the growing multidimensional unease that US lawmakers feel about Big Tech. While President Biden said he would sign the proposed legislation to ban TikTok if the Congress passed it, it's uncertain what will happen to the Bill in the Senate, and its ramifications are neither simple nor straightforward.With nearly 170 million TikTok users in the US, a ban on the app will undoubtedly hurt millions of businesses, deny artistes a platform and ruin the livelihoods of countless creators across the country. Furthermore, as Donald Trump anticipates, it will undoubtedly increase Facebook's dominance. However, national security (or at least a concern on that count) is much more important.

- In 2020, then President Trump moved to outlaw TikTok and another popular app, WeChat; later, President Biden reversed that decision. Governments in various countries have banned TikTok on official devices due to concerns about cybersecurity and privacy, perhaps primarily for its Chinese connections. For instance, due to privacy and security concerns, India banned TikTok and dozens of other Chinese apps, including WeChat, in 2020. Several other countries have also enforced a ban on TikTok.
- In March 2023, Shou Zi Chew, TikTok's CEO, gave testimony before a US congressional committee. Security experts believe that the US government's current concerns seem to be based primarily on the 'potential' for TikTok to be used for foreign intelligence. US lawmakers continue to perceive that TikTok poses a serious threat to national security because of its ties to China. Secretary of State Antony Blinken has said that TikTok should be "ended one way or another."
- Working with a privacy researcher, The Washington Post came to the conclusion in 2020 that TikTok didn't seem to gather any more data than the average major social media platform. A 2022 study by the mobile marketing company URL Genius, however, found that out of all social media apps, consumers' personal data was tracked more by YouTube and TikTok.
- But even if TikTok gathers data comparable to that of other major social media platforms like Facebook or X, that's still a significant amount of information. It includes details about the videos users watch, the comments they make, the private messages they send, and, if they consent to this degree of access, their precise geolocation and contact lists. In addition, according to TikTok's privacy statement, the company gathers user data such as email addresses, phone numbers, age, search and browsing histories, details about the images and videos users upload, and, if consented to, the contents of their device's clipboard, allowing them to copy and paste information into the app.As per several studies, TikTok follows users online even when they aren't using the app. TikTok said the information is used to bolster its advertising business. And TikTok is not unusual in this regard; many tech giants employ the same tool on a far greater scale. TikTok is, therefore, merely a product of the broader surveillance capitalism economy, which frequently directs users into rabbit holes of uncertainty. Yes, many of the apps we use collect too much information about us. Typically, they gather users' personal data primarily for their own use to show data primarily for their own use to show consumers relevant advertisements. Companies can impact our behaviour in ways we are frequently unaware of by getting more information about our preferences, shortcomings and areas of interest. The Cambridge Analytica

We need to vote wisely for the sake of participative democracy

Freedom during the pre-election phase is an essential precondition for democracy because it prioritises choice.

THERE was a time, not so long ago, when theorists of substantive democracy scoffed at the two presuppositions of minimalist theories of democracies. One, democracy is a method of choosing leaders who will rule the country for the next five years. Two, democracy is valuable because it enables a peaceful transfer of power from one set of political elites to another. For defenders of substantive democracy, this interpretation is simply unpersuasive. Democracy as a form of rule is valuable not only because it grants all eligible citizens the right to exercise their franchise, but also because it enables the realisation of the foundational principles of a good life: liberty, equality, distributive justice, political participation, the rule of law and the accountability of the elected. These are realisable because substantive democracies possess a vibrant civil society, an independent media and an impartial judiciary to defend the rights of citizens.With the onslaught of 'elected authoritarians' — a phrase that is an oxymoron at best - most committed democrats have been compelled to put aside their dreams of substantive democracy and focus their attention on free and fair elections. Ahead of the General Election, it is worthwhile to recollect that the electoral process consists of three phases: the pre-election period, voting and the outcome. No one should be able to tamper with the result. This violates the basic right of individuals to choose their leaders, howsoever fractured the outcome of the election might be. We certainly have to ensure that the pre-election process is free and fair. Think of elections as a gigantic marketplace in which the voter has the choice to cast his vote in favour of candidate X, Y or Z. Freedom during the pre-election phase is an essential precondition for democracy because it prioritises choice. A citizen can only choose if he has options. Without options, the right to choose is completely hollowed out, much like a shopping mall where only one brand is on offer. This is a violation of the basic right to franchise. The right to vote is a basic right, not only because the voter can opt for a candidate or a political party that will rule over him, but also because voting enables him to transition from a subject to a citizen. Members of a society in which one political party dominates like a veritable colossus over the others, either because it has got Opposition leaders imprisoned or has allegedly given directions to freeze an Opposition party's bank accounts, are not citizens who have inviolable rights. They are subjects, much as Indians were subjects of the British Empire. Millions of Indians bravely fought for the independence of their country from British colonialism. What were they fighting for, if not democracy? The shift from substantive democracy to minimal democracy, at least for the moment, is largely due to huge disappointment with the way political parties have misused this form of government. For



democrats of this genre, democracy is a 'hurrah' word, simply because it helps realise many things that are of value: from warding off war to ensuring economic growth and wellbeing to making the world a better place to live in. The most persuasive argument for substantive democracy is the right to participate in processes of decision-making protected by a vibrant civil society and the media. This realises the political competence of every individual. Participative or deliberative democracy is a perfect form of modern democracy because it gives each citizen a voice and the right to be heard. Every citizen has the right to be treated with dignity, and the best way to ensure this is to protect a deliberative arena of equals, or at least an arena fired by enthusiasm for equality. A society of equals is a just society.Today, priorities are bound to be different. We always knew that money power ruled. Now we know for certain that politics is bolstered by big businesses, as the data on electoral bonds reveals. Political parties and their agendas are up for sale to the highest bidder. Processes of

decision-making are shrouded in secrecy. A section of the media has become servile; appalling poverty and unbelievably vulgar spectacles mounted by the affluent exist cheek by jowl. Social prejudice against minorities is fomented by cynical politicians to cause a divide in public opinion, and unthinkable discrimination continues to dog the disadvantaged.

Our faith in democracy has not been shaken, but our confidence in the party system that throws up politicians who are power-hungry and contemptuous of the fundamental rights granted by the Constitution has been eroded.Indian citizens stand at a crossroads ahead of the Lok Sabha polls. We will vote, but in a society where the advantages of democracy, the rule of law, fundamental rights and an independent media have been steadily whittled away, we are left with only elections.

We have to choose wisely, not to facilitate power-hungry candidates to acquire power, but because we want more. We want the candidates we vote for to contribute to the making of the good society we yearn for.

CITING 'emerging challenges due to the current socio-cultural, religious and political situation' in the country, the Catholic Bishops' Conference of India (CBCI) has issued a set of guidelines for all educational institutions under its jurisdiction. These include recitation of the Preamble to the Constitution by students during the daily morning assembly, showing respect for all faiths and traditions, not forcing Christian traditions on students of other religions, and setting up an inter-religious prayer room on the campus. This is imperative in view of the all-pervasive polarisation in the country. The CBCI guidelines can serve as a model to be emulated by all educational institutions with religious affiliations. The Supreme Court had shown the way in January this year by observing that the right of minorities to establish and administer any educational institution under Article 30(1) of the Constitution was not meant to ghettoise any community. A welcoming and harmonious environment on every

incident, however, demonstrated how successfully personal information can be exploited to even sway major elections. However, more than the app itself, TikTok's ownership and governance policies may be the main cause for concern. TikTok doesn't operate in China, but it's apprehended that ByteDance and, by extension, TikTok, may be forced to cooperate with a wide range of security activities, including perhaps the transfer of data, since the Chinese government enjoys significant leverage over businesses under its jurisdiction.

A below-the-belt blow on poll eve Kejriwal's arrest has shaken the conscience of the nation's right-thinking citizens

I have met Arvind Kejriwal only once. It was sometime in 2005 or 2006 at a meeting of trustees of the Public Concern for Governance Trust (PCGT). BG Deshmukh, former Cabinet Secretary and former Principal Secretary to the Prime Minister, was the trust chairman at that time. Kejriwal had been invited to meet the trustees and explain to them the work he was doing to combat corruption in the Income Tax (I-T) Department in New Delhi.Kejriwal was a regular recruit to the Indian Revenue Service through the UPSC's civil services examination, the one in which Deshmukh and I had appeared years earlier - Deshmukh got into the IAS and I into the IPS.Kejriwal used to arrive for work an hour before the official time and set up a small table with a chair outside the central I-T office. Applicants for I-T refunds or PAN cards could take his help to get their work completed expeditiously without payment of 'speed money'. It worked, but not without ruffling feathers. He displeased many of his colleagues. How many of them are in the Enforcement Directorate (ED) today? Are any of them handling the investigation against him?Since the PCGT had been established for the express purpose of improving the quality of life of the common resident of Mumbai by monitoring governance, Kejriwal told us of an NGO in the national capital that he was mentoring so that people's woes could be addressed. The trustees of the PCGT were impressed with his commitment to the cause of integrity and justice. Would, nay could, a man so devoted to values of good governance transform overnight into an ogre bent on fattening himself on filthy lucre? To those who have had a glimpse of his personality, his thinking and his attitude of mind and heart, it seems impossible. Like in the case of AAP MP Sanjay Singh, no money has been traced to him. The next time Kejriwal came to my attention was when he rode on the back of that great exponent of good conduct and honest, simple living - Anna Hazare. Now, Anna was an institution in my state, Maharashtra. Like many people

there, I know most things about Anna. I interacted with him on more than a couple of occasions. Anna is a simple man, but since he has been lionised and feted by so many individuals so many times, the adulation has affected his capacity to weigh possibilities and probabilities calmly. The combination of Anna and Kejriwal had the promise of becoming a game-changer. But Kejriwal had other ideas. These ideas were not anticipated by Anna or by most citizens who applauded the two for raising the banner of revolt against one of the two biggest impediments to India's progress — corruption (the other is communalism). Just as the battle was taking a winning turn, Kejriwal announced his intent to enter the political arena by forming the Aam Aadmi Party (AAP).

This decision dismayed Anna and sundry other admirers like me. He saw in this move a betrayal by a man in whom he had placed his trust. Anna had always

dreamed of himself as a moral force who kept away from the spoils that politics engenders. But that is a different story. Today, we are concerned with the BJP's intricate plan of extinguishing all credible opposition to its political hegemony.

Kejriwal is accused of unfairly tweaking the Delhi Government's excise policy for the sale of liquor in the Capital. If he had a hand in shaping or changing that policy, I would not be surprised. All political parties need money to operate. They have no means of financing their activities, except kickbacks from contracts and dispensation of favours to business houses. Turnkey deals like the purchase of the Bofors guns or the Rafale



jet fighters are the most obvious temptations. Every citizen knows that this is routinely done by governments and condemned by Opposition parties. But the Indian citizen is impervious to such peccadilloes. She/he has accepted it as inevitable.What the citizen is not accustomed to is the single-minded hounding of Opposition parties and their leaders by unleashing the ED and the I-T authorities relentlessly on their opponents to ensure an Opposition-mukt Bharat. Kejriwal's arrest has shaken the conscience of the nation's right-thinking citizens even more than the I-T Department's initial order freezing the Congress' bank accounts for the recovery of I-T dues (coercive action has now been put on hold). These are below-the-belt blows delivered by a boxer who viciously pulverises his opponent even though the latter is losing!The BJP conceived of electoral bonds for financing the costs of fighting elections. Its pickings would hurtle it to victory because Opposition parties would be left with the crumbs. In a country where money is used to buy votes and bring down governments formed on the basis of the people's mandate, it is not surprising that an upand-coming party like AAP would formulate a scheme to add substance to its piggy bank.Kejriwal has certainly not used any of the money his party has raised via the alleged kickbacks from liquor dealers, whether they hailed from the South or the North, for his personal expenses. If that is the allegation against him, no one will believe that such a thought could even enter his mind. It is equivalent to accusing the chowkidar of being a thief!

Among the witnesses the ED has stacked up to prove Kejriwal's guilt, the main

one is a co-accused who has turned approver on the promise of a pardon. That same approver bought electoral bonds worth crores of rupees days after he turned approver and was set free on bail. The approver's father, Magunta Sreenivasulu Reddy, has been given the ticket by the Telugu Desam Party, a BJP ally, from the Ongole Lok Sabha seat in Andhra Pradesh.

The old man who delivers my newspapers is my sounding board for what the poorer citizens think of political events. "Poor Kejriwal," he said, "he had done much for the jhuggi-jhopri dwellers of Delhi in the fields of education and health and given them free electricity. Now, he will languish in jail unless he joins the BJP."

The draft resolution titled 'Human rights situation in the Occupied Palestinian Territory, including East Jerusalem, and the obligation to ensure accountability and justice' was adopted by the Geneva-based

UNHRC. It also demanded that Israel "end its occupation of the Palestinian territory", including East Jerusalem since 1967."The Council also demanded that Israel immediately lift INDIA'S VOTE IN FAVOUR OF UN its blockade on the Gaza Strip and all other forms of collective punishment, The UNHRC adopted five resolutions, and called for an immediate ceasefire in Gaza. The Council called upon all States to take immediate action to prevent the continued forcible transfer of Palestinians within or from Gaza," a statement by the UNHRC read. The resolution condemned Israeli actions that may amount to ethnic cleansing in Palestine, and called upon all states to take immediate action to prevent the continued forcible transfer of Palestinians within or from Gaza.

New Delhi. The Central Bureau of Investigation (CBI) raided several locations across Delhi in connection with child trafficking. Two newborn babies were rescued from a house located in Keshavpuram, shedding light on a sinister underworld of infant trade. According to CBI sources, newborns were being bought and sold as commodities in the black market. The CBI is currently in the midst of interrogating all parties



involved, including both the woman who sold the children and the buyers themselves. The scope of this operation extends far beyond the borders of Delhi, with the CBI making arrests of individuals involved in trafficking seven to eight children across the National Capital Region (NCR).

Among those arrested are a hospital ward boy and several other women. According to CBI sources, approximately 10 children have been sold within the past month alone. The CBI investigation has now spread its reach across multiple states, with several major hospitals coming under intense scrutiny. Newborns were being sold for exorbitant sums ranging from ? 4 to 5 lakh, the sources said.



Another Indian Student Dies In US, 10th Incident This Year

New Delhi. An Indian student has died in the US state of Ohio, the Indian Consulate in New York said on Friday, adding that an investigation is underway to ascertain the cause of death.

The student, identified as Uma Satya Sai Gadde, was pursuing his education in Ohio's Cleveland. The Indian Consulate expressed deep sorrow over the loss and extended condolences to the bereaved family. They assured that every possible support, including facilitating the transportation of his body to India, is being provided to the family during this distressing time."Deeply saddened by the unfortunate demise of Mr. Uma Satya Sai Gadde, an Indian student in Cleveland, Ohio," the Indian Consulate in New York wrote in a post on X. "Police investigation is underway. @IndiainNewYork continues to remain in touch with



the family in India. All possible assistance is being extended, including to transport Mr Uma Gadde's mortal remains to India at the earliest."

This incident marks yet another episode in a concerning trend of deaths involving Indian-origin students in the United States. In March, another Indian student, Mohammed Abdul Arafat, went missing from the Cleveland area under mysterious circumstances. His family then received a ransom call demanding payment for his release.

Earlier this year, Syed Mazahir Ali, a student from Hyderabad, was brutally attacked in Chicago, leaving him severely injured. The Indian Consulate in Chicago promptly intervened, offering support to Mr Ali and his family. The death of Neel Acharya, a student at Indiana's Purdue University, and the brutal killing of Vivek Saini in Georgia, sent shockwaves among the Indian community in the US.

The Congress also said it will respect and uphold the fundamental right to practise one's faith and the rights guaranteed to religious minorities under articles 15, 16, 25, 26, 28, 29 and 30 of the Constitution."After wide consultation, Congress will bring a law to recognise civil unions between couples belonging to the LGBTQIA+ community," the manifesto said.LGBTQIA stands for Lesbian, Gay, Bisexual, Transgender,

The additional "+" stands for all of the other identities not encompassed in the short acronym."We will also respect and uphold the rights of linguistic minorities guaranteed under Articles 15, 16, 29 and 30 of the Constitution," the Congress said. The party also promised to encourage and assist students and youngsters belonging to the minority communities to take full advantage of the growing opportunities in

education, employment, business, services, sports, arts and other fields."We will restore the Maulana Azad Scholarships for study abroad and increase the number of scholarships," the manifesto said.Noting that the economic empowerment of the minorities is a necessary step for India to realise its full potential, the Congress said it will ensure that banks provide institutional credit to minorities without discrimination."We

will ensure that the minorities receive their fair share of opportunities in education, healthcare, public employment, public work contracts, skill development, sports and cultural activities without discrimination," the party said.

The Congress said it will ensure that like every citizen of the country, the minorities too have the freedom of choice of dress, food, language and personal laws."We will encourage reform of personal laws. Such reform must be undertaken with the participation and consent of the communities concerned," it said.

The Congress promised to meet the longstanding demands for the inclusion of more languages in the Eighth Schedule to the Constitution. The manifesto, focusing on five "pillars of justice" and 25 guarantees under those, was released at the AICC headquarters on Friday in the presence of Congress president Mallikarjun Kharge and former party chiefs Sonia Gandhi and Rahul Gandhi.The Lok Sabha polls are scheduled to be held in seven phases starting April 19 and the counting of votes will be taken up on June 4.

Has that left you staring at the screen twiddling your thumbs muttering to yourself that this is your manager's job? Well, we're going to make the job easier for you today.

Many organisations ask employees to assess themselves as the first step of the evaluation process in the appraisal. This is done to give employees a 'voice' rather than simply be a recipient of feedback from their manager. Such participation helps make employees more engaged in their performance as well as the review process.

But, as we all know, that is easier said than done. Don't worry, though. With these nuggets of advice pooled from HR experts around the globe, you'll be writing your self-assessment in no time!

START WITH THE TECHNICAL **GOALS**

Vedant Kantharia, Director at Unify Search Solutions, an HR Consultancy firm, suggests that you first identify the technical and nontechnical goals. "Technical goals include those that are directly related to the specific skillsets needed for your job," says Kantharia. "For example, sales targets for a salesperson or increasing website traffic for a digital marketing executive - these are technical goals.Such goals are usually quantifiable and easier to assess. Evaluate yourself against these targets first. Then, move on to nontechnical goals, which are mainly soft skills. For example, communication skills or people management -these are nontechnical goals." TALK TO PEOPLE

Apple lays off more than 600 employees in the US

NEW DELHI. Apple Inc recently laid off more than 600 employees in California, the US, a move linked to the company's decision to discontinue its car project and in-house efforts to build Apple Watch displays.Both projects were shelved in February 2024. The car project's cancellation stemmed from executive indecision regarding its direction and mounting cost concerns. Similarly, the smartwatch display programme faced engineering hurdles, supplier

challenges, and ultimately proved too expensive to continue. This information comes from WARN notices, or worker adjustment and retraining notification filings, submitted by Apple to the California Employment Development Department These filings are required by law when a company conducts mass layoffs. To comply with the regulations,



Apple filed eight separate reports, each detailing layoffs at a specific California location. Nearly 87 of the affected employees worked at a facility dedicated to Apple's next-generation screen development, while others were located for the car project. The brunt of the layoffs impacted Apple's main carrelated office in Santa Clara, California, where 371 employees were let go.

Dozens more working in satellite offices also lost their jobs. However, some members of the car team were reportedly reassigned to other areas within Apple, including artificial intelligence and personal robotics.alt's important to note that the WARN notices might not capture the full scope of job reductions. Apple likely had engineers working on these projects in other locations, such as Arizona. Historically, layoffs

haven't been a common occurrence at Apple, unlike other ech giants like Alphabet, Amazon, and Microsoft.

Krishnamurthy Subramanian has previously served as a Chief Economic Advisor for the government of India.

IMF had clarified that the recent growth projections made by Krishnamurthy Subramanian, the Executive Director representing India at the IMF, do not reflect the official views of the organization.

n response to Subramanian's remarks predicting an 8 percent growth rate for India, IMF spokesperson Julie Kozack stated that his comments were made in his capacity as India's representative. "The views conveyed ...by Mr. Subramanian were in his role as India's representative at the IMF," she said according to a PTI report. New Delhi.India to soon have 'One Airspace': India is moving forward with a plan to streamline its airspace management to enhance efficiency and reduce emissions. The initiative aims to consolidate control over the airspace

airlines to identify more efficient flight routes, resulting in reduced travel time and fuel consumption. By facilitating consistent flight patterns at higher altitudes and smoother descents for landing, the initiative aims to enhance operational efficiency.Senior air traffic control officials emphasized the current challenges of coordinating flights across different regions and the anticipated simplification with the centralized control in Nagpur. "Currently, when an aircraft passes over the Indian region, the controllers have to hand it over to the other region, which includes a lot of coordination especially over busier air routes," an official was quoted as saying. "Once a single unified sky is achieved, almost 75-80% of controllers will be based in Nagpur, reducing the need for coordination, leading to less stress and fatigue. Single coordination also allows restructuring of air routes, opening up more fuel-efficient routes for airlines," the official said. This shift is expected to significantly reduce coordination efforts, alleviate stress, and

enhance operational fluidity for pilots as well. Pilots welcomed the initiative, noting that it would streamline communication processes and reduce cockpit workload. The unified airspace management system will provide pilots with advance information on altitude and routing, enabling smoother transitions across regions and minimizing the need for frequent radio frequency changes."You get to know your altitude, routing well in advance and if you are flying above 25,000 feet, you can overfly with complete radio silence without seeking multiple clearances and reducing communication with the ATC (air traffic control)," a senior commander was quoted as saying. The decision to enhance airspace efficiency aligns with the growing demand for air travel in India, as seen by the substantial increase in aircraft orders by domestic carriers. Civil aviation minister Jyotiraditya Scindia has in the past highlighted the significant growth in the Indian aviation sector, with projections indicating a doubling.

This brings the total year-to-date buying by the RBI to over 13 tonnes, with total gold reserves now reaching 817 tonnes.India's consistent efforts to bolster its gold reserves reflect a strategy aimed at diversifying its foreign exchange reserves and mitigating risks associated with currency fluctuations and economic uncertainties.While India remains a significant player in the global gold market, other central banks also contributed to the accumulation in February.Central banks around the globe continued their steady accumulation of gold reserves, albeit at a slower pace compared to the previous month, in February.This trend has been predominantly driven by emerging market banks, particularly those of India and China, as reported by the World Gold Council.According to a report Published in the World Gold Council by Senior Analyst, EMEA World Gold Council,



Krishna Gopal, global central banks increased their gold reserves by a net of 19 tonnes in February.

While this marks the ninth consecutive month of growth, it represents a significant slowdown from January, with a 58 per cent decrease in net

purchases.Despite the deceleration, the broader trend of central bank buying remains intact. Year-to-date data for January and February shows an addition of 64 tonnes, indicating a fourfold increase compared to the same period in 2022, although it's notably 43 per cent lower than the corresponding period in 2023.

The People's Bank of China (PBoC) emerged as the largest buyer during the month, increasing its gold reserves by 12 tonnes. However, amid the overall trend of accumulation, there were notable instances of selling as well.Despite the slower pace of accumulation witnessed in February, analysts remain optimistic about the outlook for central bank demand for gold.he broader trend indicates a continued interest among central banks in diversifying their reserve assets, particularly amidst geopolitical uncertainties and economic volatility.Looking ahead, market observers anticipate the release of the next Gold Demand Trends report in late April, which will provide comprehensive insights into central bank demand for the entire first quarter of the year. Overall, while the pace may have moderated in February, the underlying trend suggests that central banks, including India's RBI, remain committed to bolstering their gold reserves as a strategic hedge against global economic uncertainties.
