Ir September 2020, AMU completed 100 years as a university, becoming one of the oldest universities in India. The university has had no woman vice chancellor so far. In 1920, Begum Sultan Jahan was appointed the AMU chancellor. She continues to be the only woman to have

Narendra Modi renews 'redistribution of wealth' attack against Congress

Neha Hiremath (23), daughter of Congress councillor of Hubballi-Dharwad Municipal Corporation Niranjan Hiremath, was allegedly stabbed to death on the campus of BVB College on Thursday. The accused Fayaz Khondunaik who fled from the scene, was arrested by the police subsequently. Neha was a first year Master of Computer Application student and Fayaz was earlier her classmate. "We have decided to give it to the CID. We will set up a special court for it. Charge sheet has to be filed in a time-bound manner and the case has to be disposed off, so the special court," Siddaramaiah

Centre moves Supreme Court for modification of 2012 verdict on 2G spectrum

New Delhi, April 22: The Centre on Monday moved the Supreme Court seeking modification of its 2012 2G spectrum verdict requiring the Government to adopt the auction route for transferring or alienating the country's natural resources. The top court had on February 2, 2012 quashed 2G spectrum licences given to various companies in January 2008 during the UPA Government when A Raja was the Telecom Minister. Attorney General R Venkataramani mentioned the Centre's plea seeking modification of the 2012 verdict before a Bench led by Chief Justice of India DY Chandrachud for urgent listing as the Government wanted to grant 2G spectrum licences in some cases. The Bench asked the Attorney General to send an email - a procedural requirement for urgent listing of cases. "We will see, you please move an e-mail," the CJI told Venkataramani. Surat, April 22: BJP candidate Mukesh Dalal was on Monday elected unopposed from Surat Lok Sabha constituency in Gujarat after all other nominees withdrew from the fray, a poll

official said. The development marks the first victory of the Bharatiya Janata Party in the ongoing Lok Sabha elections. "I declare that Mukesh kumar Chandrakant Dalal, sponsored by the BJP, has been duly elected to fill the seat in the House from Surat parliamentary constituency," district collector cum election officer Saurabh Pardhi told media persons as he handed over the Certificate of Election to Dalal. Voting for all 26 constituencies in Gujarat is scheduled for May 7, but with

the result of Surat seat already out, polling will be held on 25 seats. Except

for Dalal, all 8 candidates in the fray from Surat- 4 Independents, 3 from smaller parties and Pyarelal Bharti of Bahujan Samai Party- withdrew their nomination papers on the last day, as per the Surat district election office. Notably, the candi-



dature of Congress' Nilesh Kumbhani from Surat seat was rejected on Sunday after the district returning officer prima

New Delhi, April 22: Normalisation of scores for the Common University Entrance Test-UG and the National Eligibility Test is being done away with from this year, according to UGC chief Jagadesh Kumar. "No normalisation of scores will be required this year since both exams will be conducted in a single shift for a subject," Kumar told PTI. Normalisation is a process for revising the score of a student in a way that it becomes comparable with the score of another. This becomes necessary when an examination in the same subject is held in multiple sessions, each with a different paper. Students have been raising concerns about the normalisation of scores "unfairly" impacting their performance in the exam. "Earlier, we had to conduct the test for the same paper for two or three days in our endeavour to provide the first-choice centre to the students as much as possible. But this year, by adopting the OMR mode, a large number of centres will be

UG, NET to be done away with available at schools and colleges, enabling us to conduct the test across the country on the same day. "If the test is conducted on multiple days for the same paper, normalisation is required and it is a scientific method," the UGC chair-man said. The CUET-UG will be conducted from May 15 to 24 this time. In a shift from the earlier pattern of conducting the crucial exam for admission to undergraduate courses in a Computer Based Test (CBT) mode, CUET-UG for 15 subjects will be conducted in pen and paper mode while for 48 subjects in online mode. Similarly, the UGC-NET, which was earlier conducted in CBT mode, will be held in pen and paper mode on June 16. UGC-NET is an exam to determine the eligibility of Indian nationals for the "award of Junior Research Fellowship and appointment as assistant professor", "appointment as assistant professor and admission to PhD" and "admission to PhD only" in Indian universities and colleges.

Beyond nameplate, mum's the word

Mumbai: A day after the state cabinet unanimously approved the landmark women's policy, submitted by woman and child welfare minister Aditi Tatkare, making the mother's name mandatory in govt documents, CM Eknath Shinde was the first cabinet member to add his mother's name to his nameplate at Mantralaya-changing the name from Eknath Sambhaji Shinde to Eknath Gangubai Shinde.

Both deputy CMs, Devendra Fadnavis and Ajit Pawar, chief secretary Nitin Kareer, BMC chief Bhushan Gagrani and Mumbai collector Sanjay Yadav did the same. Across the state, most bureaucrats and high ranking IPS officers added their mother's name to their nameplates.But, no one changed his name on official govt records on the grounds that it is a very tedious and long drawn process. To begin with, one will have to first update the Aadhaar card. Although UIDAI officials say changes to Aadhaar card can be done online and take only a few minutes, in reality, it is difficult because of which many people keep the wrong spellings of their names or their addresses. Even making changes to the passport is a herculean task. For that, one will have to change the school records.Top politicians feel that adding the mother's name to the nameplate is a step towards empowerment of women and is not merely symbolic. In 1994-95, when Sharad Pawar was the CM, the then woman and child welfare secretary Chandra Iyengar had brought in a comprehensive women's policy, which provided for 33% reservation for women in local bodies. This policy was then followed across the country. After the firing at the residence of actor Salman Khan, it was expected that many heads would roll in Mumbai police. However, even after CM Eknath Shinde's personal visit to Khan's residence, responsibility has not been fixed.

STATE Pooram fiasco: Kerala government transfers Thrissur police commissioner, ACP



THIRUVANANTHAPURAM : Amid mounting criticism of police "high-handedness" during the Thrissur Pooram, the state government on Sunday cracked the whip, ordering the transfer of Thrissur Police Commissioner Ankit Asokan and Assistant Commissioner (ACP) K Sudersan. The transfers will be effected after getting the consent of the Election Commission owing to the model code of conduct, a statement said.Chief Minister Pinarayi Vijayan, who is in-charge of the

home portfolio, also directed the state police chief to conduct a departmental probe into the complaints and submit a report within a week.

The government's order came after the restrictions imposed by the police during the pooram invited severe criticism and gave ammunition for the UDF and the BJP to ramp up its attack against the Left front and the state government during the last phase of the election campaign.

Protesting the police restrictions, the Thiruvambady devaswom had stopped the ceremonies abruptly late on Friday. Subsequently, the fireworks display was delayed by over three hours. The



devaswom authorities had alleged that police used barricades wherever possible and restricted free movement of people. Amid complaints that the police went overboard in its security arrangements, a video has surfaced on social media that showed the police commissioner blocking the committee members and volunteers who were heading to feed elephants and taking parasols for Kudamattam inside the temple.

'Many cops on duty were unaware of rituals, timings

An internal report of the Special Branch has held the commissioner responsible for the unexpected events, according to sources.

As per the special branch report, only superior officers were briefed about the pooram duty beforehand, while the other personnel on duty were ignorant about festival rituals and its timings.

It is learnt that many police personnel were unaware of the madathil varavu ceremony at night and hence, blocked its way around 10.30pm, creating a chaos at Pazhayanadakkavu. The report also said on several occasions, the police commissioner behaved rudely with the public and even committee members of devaswom, resulting in a discontent. About 3,500

cops were deployed on duty for ensuring safety during the 36 hours of Thrissur pooram festivities. Due to the duty allocation ahead of the election, those who were on pooram duty were mainly from other districts with no knowledge about its rituals. It is learnt that the location of the duty and timings were provided only on the eve of the pooram with no briefing about the arrangements.

3,000 acres of land changed hands in financial year '24, a rise of 58%

Mumbai: Almost 3,000 acres of land changed hands in 101 separate transactions by developers and entities across the country in the financial year 2023-24, according to data compiled by ANAROCK.In terms of total area, around 58% more land was purchased in the financial year 2023-24 as compared to FY 2022-23, which recorded 88 land deals for around 1,886 acres. "Interestingly, out of the total land deals in FY24, over 83 deals for about 1,135 acres were closed in the top seven cities alone," said Anuj Puri, chairman, ANAROCK Group.

3,000 acres of land changed hands in financial year '24, a rise of 58%"The remaining 18 deals, accounting for over 1,853 acres, were sealed in various tier 2 and 3 cities like Ahmedabad, Ayodhya, Jaipur, Nagpur, Mysuru, Ludhiana, and Surat. Tier 2 & 3 cities have once again emerged as redoubtable growth engines, thanks to their rapidly improving infrastructure and growth opportunities," he said. Among land deals in the top seven cities, NCR topped with 29 deals for over 313 acres, followed by the Mumbai Metropolitan Region (MMR) with 19 deals for approximately 157-plus acres. In terms of total land area, Bengaluru saw 14 deals for over 490 acres transacted - the highest among all top seven cities.

- Developers who bought land parcels for various developments in FY24 include Godrej Properties, Eldeco Group, Adani Realty, Signature Global, Oberoi Realty, DLF India, Prestige Group, K Raheja Corp, and Brigade Group, among others.
- According to a report released by ANAROCK on Sunday, of the total land deals in FY-24, around 80 separate deals for about 2,252 acres are for proposed residential, plotted development & township projects.In the residential category, deals were closed in Pune, Bengaluru, MMR, Hyderabad, NCR, Chennai, Mysuru, Ayodhya, and Jaipur.Deals for proposed plotted development projects were sealed in cities like Sonipat, Nagpur, Surat and Ahmedabad, while township projects were slated in Ahmedabad, Bengaluru, Thane, Ludhiana and Ghaziabad.

Commercial and retail together saw 4 separate deals for over 42 acres closed. Of these, three were for commercial developments - one each in Gurugram, Noida and Mumbai — and one retail deal was closed in Thane. At least 79 acres in four separate deals have been earmarked for mixeduse developments in cities including Pune. Mumbai and Ludhiana. The residential segment continues to drive the market, which is also reflected in the land deals it is generating. Amid all-time high residential demand, several large and listed developers and other entities continued to snap up land, said ANAROCK.

Canada dreams to be distant for 50% of Gujarat students

AHMEDABAD: From May 15, international With Canada setting a cap of 3.64 lakh study graduates of Canadian college programmes delivered through a public-private curriculum licensing arrangement will no longer qualify for post-graduation work permits (PGWP). The move, aimed at restricting the number of students staying back in Canada for work after their studies, is likely to impact about 10,000-odd students enrolling from Gujarat, mainly in major cities and populous provinces. A vast majority of Gujarat students in Canada work while studying in order to pay off their education loans.

Electoral bonds, PM Cares big scandals, says Parakala Prabhakar

BENGALURU: Terming the Electoral Bonds issue as the "biggest scam in the world", considering the quantum of funds involved, political economist Parakala Prabhakar said the BJP government's claim of transparent political funding did not hold water. He spoke of crony capitalism as a maior corruption issue, and said the PM Cares Fund is also a scam.Asked about PM Narendra Modi's explanation of the Electoral Bonds, he said, "If it is about transparency in political funding, why didn't the government tell the people about it since 2018, since when it has been in force. Why did the petitioners have to go to the highest court, the Supreme Court, to find out the truth, and why did the government ask for time till

Monkeys breaking pots, invading kitchens; residents at wits' end

NOIDA: Residents of sectors 122 and 51 in Noida and Delta 1 in Greater Noida have complained of monkey menace. From damaging water tanks, breaking pots and planters to invading kitchens, residents said the animals had become a cause for concern."Sector 122 has been facing this problem for the last 4 years. Not only do they break the water tanks and flower pots on the roof, uproot plants in the balcony, damage cars, they create havoc by entering the kitchens, scattering items from the fridge and stealing food items," said Umesh Sharma RWA president of Sector 122.

- While Sharma has made several complaints and urged the Noida Authority health department to take the matter seriously, he says that the problem has persisted for long."Last year too, I had complained to the Authority as there is a fear of monkeys among the residents of the sector. Children are afraid to leave the house. The health department is requested to find an immediate solution to this," said Sharma.
- The situation is the same in several other sectors across the city. "People are facing problems due to monkeys in Sector 51. In the residential areas, especially C block park and houses, monkeys can be found invading houses, on rooftops and in the streets. They damage household items as well as trees and plants. We also wrote a letter to the Authority earlier this week, requesting a solution to the problem," said Sanjeev Kumar, RWA general secretary of Sector 51The monkey menace problem has also been plaguing the loclals in some sectors of Greater oida as well, residents said."Recently a monkey attacked a woman in the sector," said Rishipal Bhati, who is the RWA general secretary of Sector Delta 1, Greater Noida. While officials from both the GNIDA as well as the Noida Authority assured that they will look into the matter, any results on the ground are still awaited.

How oral drugs are helping doctors treat & manage cancer

Gurgaon: Doctors are increasingly turning to oral therapy for treating and managing advanced stages of cancer as the method is perceived to be an effective and convenient way for patients to cope with the illness.A 60-year-old woman from Jalandhar who was diagnosed with stage-four recurrent Granulosa cell tumour in an ovary approached doctors at CK Birla Hospital in the city in May last year. She was unwilling to go through chemotherapy again as she had undergone three surgeries and over 15 chemotherapy cycles between 2019 and 2021 for the recurring cancer.

At CK Birla hospital, an MRI and CT scn showed metastasis of cancer in the vaginal wall, lungs and liver, along with a pelvic tumour. Doctors then recommended oral drugs, which she took for 6-7 months. Her followup showed that her tumour had reduced % in size, and she was in good health.Dr Pooja Babbar, who is a consultant in medical oncology at CK Birla Hospital, told TOI on Sunday that doctors are using oral therapy for advanced-stage cancer treatment.Dr Babbar cited another example. A 54-year-old woman from Mauritius with metastatic stage-four malignant melanoma (skin cancer) showed significant improvement after just two months of targeted oral therapy, she said. Another case involved a 61-year-old woman from Noida, who was diagnosed with left breast cancer (TNBC). Despite surgery, chemotherapy and radiation therapy in 2021, she experienced severe cervical pain, headaches and

Papua New Guinea PM reacts to Biden's 'uncle eaten by cannibals' claim

Sydeney. Papua New Guinea Prime Minister James Marape says his nation does not deserve to be labelled cannibals, and urged the US to clear up the remnants of World War Two littered across the Pacific, after comments by President Joe Biden about his missing serviceman uncle.den had "appeared to imply his uncle was eaten by cannibals after his plane was shot down over PNG during WWII", Marape's office said in a statement late on Sunday.President Biden's remarks may have been a slip of the tongue; however, my country does not deserve to be labelled as such," Marape said in the statement

- I urge President Biden to get the White House to look into cleaning up these remains of WWII so the truth about missing servicemen like Ambrose Finnegan can be put to rest."The US signed a defence cooperation agreement with Papua New Guinea last year, amid competition for influence in the region with China, which has a security pact with the neighbouring Solomon Islands.China's Foreign Minister Wang Yi met with Marape in the capital Port Moresby on Sunday to build closer economic ties, while Australia's Prime Minister Anthony Albanese arrives this week to commemorate World War Two history.Biden has previously cited his personal connection with Papua New Guinea's wartime history on visits to Australia, telling the story of his uncle who died in a plane crash in May 1944.Biden last week raised the possibility his uncle might have fallen victim to cannibals, after visiting a missing-in-action war memorial in Pennsylvania.Historians say Papua New Guinea was crucial to the United States' drive across the Pacific to liberate the Philippines in World War Two, while Australia has said the wartime history showed the renewed strategic importance of its northern neighbour.
- The impact of the war remains sensitive among Pacific Islanders, however.Marape said his nation was "needlessly dragged into a conflict that was not their doing".Papua New Guinea and Solomon Islands remain littered with wartime human remains, plane wrecks, ship wrecks and tunnels, as well as leftover bombs which were still killing people, he said.

Terry Anderson, US journalist held hostage for 7 years in Lebanon, dies at 76

- New York. Terry Anderson, a US journalist who was held captive by Islamist militants for almost seven years in Lebanon and came to symbolise the plight of Western hostages during the country's 1975-1990 civil war, died on Sunday at age 76, his daughter said in a statement. The former chief Middle East correspondent for The Associated Press, who was the longest held hostage of the scores of Westerners abducted in Lebanon, died at his home in Greenwood Lake, New York, said his daughter Sulome Anderson, who was born three months after he was seized. No cause of death was givenept in barely-lit cells by mostly Shi'ite Muslim groups in what was known as The Hostage Crisis, and chained by his hands and feet and blindfolded much of the time, the former Marine later recalled that he "almost went insane" and that only his Roman Catholic faith prevented him from taking his life before he was freed in December 1991.
- 'Though my father's life was marked by extreme suffering during his time as a hostage in captivity, he found a quiet, comfortable peace in recent years. I know he would choose to be remembered not by his very worst experience, but through his humanitarian work with the Vietnam Children's Fund, the Committee to Protect Journalists, homeless veterans and many other incredible causes," Sulome Anderson said. The family will take some time to organise a memorial, she said. Anderson's ordeal began in Beirut on the morning of March 16, 1985, after he played a round of tennis. A green Mercedes sedan with curtains over the rear window pulled up, three gunmen jumped out and dragged Anderson, still dressed in shorts, into the car. The pro-Iran Islamic Jihad group claimed responsibility for the kidnapping, saying it was part of "continuing operations against Americans." The abductors demanded freedom for Shi'ite Muslims jailed in Kuwait for bomb attacks against the US and French embassies there.It was the start of a nightmare for Anderson that would last six years and nine months during which he was stuck in cells under the rubble-strewn streets of Beirut and elsewhere, often badly fed and seeping on a thin, dirty mattress on a concrete floor. During captivity, both his father and brother would die of cancer and he would not see his daughter Sulome until she was six years old.

India is now second-largest source for new citizens in US: Report

Washington.A total of 65,960 Indians officially became US citizens, making India the second-largest source country for new citizens in America after Mexico, according to the latest Congressional report.An estimated 46 million foreignborn persons resided in the United States in 2022, approximately 14 per cent of the total US population of 333 million, according to American Community Survey data from the US Census Bureau.

Of these, 24.5 million, about 53 per cent, reported their status as naturalised citizens.In its latest "US Naturalisation Policy" report of April 15, the independent Congressional Research Service in the fiscal year 2022, a total of 969,380 individuals became naturalised US citizens."Individuals born in Mexico represented the largest number of naturalisations, followed by persons from India, Philippines, Cuba, and the Dominican Republic," it said.Based on the latest available data, CRS said in 2022, as many as 128,878, Mexican nationals became American citizens. They were followed by Indians (65,960), the Philippines (53,413), Cuba (46,913), the



Dominican Republic (34,525), Vietnam As of 2023, as many as 290,000 India-born (33,246) and China (27,038). According to CRS as of 2023, a total of 2,831,330 foreign-born American nationals were from India, which is the second-largest number after Mexico's 10,638,429. Mexico and India are followed by China with 2,225,447 foreign-born American nationals.However, as many as 42 per cent of the India-born foreign nationals living in the US are currently ineligible to become US citizens, the CRS report said.

foreign nationals who were on Green Card or Legal Permanent Residency (LPR) were potentially eligible for naturalisation.CRS said in recent years, some observers have expressed concern over USCIS processing backlogs for naturalisation applications. Although there continues to be a backlog of naturalisation applications since FY2020 the agency has reduced the number of applications pending completion by more

than half.As of the end of FY2023, USCIS had approximately 408,000 pending naturalisation applications, down from 550,000 at the end of FY2022; 840,000 at the end of FY2021; and 943,000 at the end of FY2020.In FY2023, 823,702 LPRs submitted naturalisation applications. The number of individuals who have recently applied for citizenship remains well below the estimated population of 9 million LPRs who were eligible to naturalise in 2023. The percentage of foreign-born individuals who are naturalized varies by several factors, including country of origin.Immigrants from Honduras, Guatemala, Venezuela, Mexico, El Salvador, and Brazil have the lowest percentages of naturalized foreignborn, while those from Vietnam, the Philippines, Russia, Jamaica, and Pakistan have the highest. To be eligible for naturalisation, an applicant must fulfil certain eligibility requirements outlined in the Immigration and Nationality Act (INA)

Global military spending reaches all-time high, India in top 5 spenders

Stockholm. Global military expenditure saw its steepest increase in over a decade in 2023, reaching an all-time high of \$2.4 trillion as wars and rising tensions fuelled spending across the world, researchers said Monday.Military spending rose across the globe with particularly large increases in Europe, the Middle East and Asia, according to a new report by the Stockholm International Peace Research Institute (SIPRI)."Total military spending is at an all-time high ... and for the first time since 2009, we saw spending increase across all five geographical regions," Nan Tian, a senior researcher at SIPRI, told

AFP."It's a reflection of the deterioration of peace and security around the world. There's really not a region in the world where things have gotten better," Tian said. The United Limited room States, China, Russia, India and Saudi Arabia were the top five spenders, respectively. The continuation of the

war in Ukraine led to an increase in



spending by Ukraine, Russia and "a whole host" of European countries, Tian said.Russia boosted spending by 24 per cent, reaching \$109 billion in 2023, according to SIPRI's estimates.Since 2014, when Russia annexed Ukraine's Crimea, the country's military spending has isen by 57 per cent.

Ukraine's military spending rose by 51 per cent, reaching \$64.8 billion, but the country also received \$35 billion in military aid, of which the majority

Biden slams 'dangerous' anti-Israel protests amid Columbia University chaos

US President Joe Biden has condemned the anti-Israel protests on college campuses amid tension at Columbia University, saying that such antisemitism is "reprehensible and dangerous".

world. US President Joe Biden has slammed anti-Israel protests at universities, saying such "blatant antisemitism" is "reprehensible and dangerous". His statement came amid continued pro-Palestine stir at Columbia University, where the crisis triggered a rabbi to urge Jewish students to stay home

until the tense environment at the Ivy League school subsides. Though Biden didn't mention Columbia University in his statement released by the White House, he stressed that antisemitism has "absolutely no place on college campuses, or anywhere in our country". The demonstrations, underway for days, coincide with the Jewish Passover holiday, which is a 7day observance commemorating the mass exodus of Jews from Egypt.The US President said that Jews around the world are still coping with the horrors of Hamas's attack on Israel on October 7, 2023. "This Passover falls particularly hard on hostage families trying to honour the spirit of the holiday – a story centered on freedom – while their loved ones remain in captivity. Our hearts are with all the victims, survivors, families, and friends whose loved ones have been killed, taken hostage, wounded, displaced, or are in harm's way," his statement added. He said that his administration would continue to speak out and "aggressively implement the first-ever National Strategy to Counter Antisemitism" to provide the Jewish community with the complete backing of the federal



government.Joe Biden's statement came hours after the White House released one independently, condemning the "violence and physical intimidation targeting Jewish students and the Jewish community". White House deputy press secretary Andrew Bates called such acts "antisemitic, unconscionable, and dangerous", after videos reportedly appeared to show pro-Palestinian activists telling Jewish students that October 7th is "going to be every day for you". The Columbia University crisis escalated recently after university officials testified before the US Congress about antisemitism on campus, causing pro-Palestinian demonstrations on and

near campus to surge.On April 19 the varsity's President Nemat Minouche Shafik authorised the New York Police Department (NYPD) to raid an encampment of pro-Palestinian protesters, which led to the arrest of 108 protesters. The university has also suspended the daughter of controversial US Congress member Ilhan Omar over the protest.Even then, the protests raged on over the weekend, with protesters putting up tents to participate in the stir. Some 200

protesters protested on Saturday, according to The New York Post.The tension caused Rabbi Elie Buechler, associated with the Ivy League school's Orthodox Union Jewish Learning Initiative on Campus, to "strongly' recommend about 300 - mostly orthodox Jewish students - to go home and stay there. He sent a WhatsApp message to these students, CNN reported."It deeply pains me to say that I would strongly recommend you return home as soon as possible and remain home until the reality in and around campus has dramatically improved," the message read, according to the CNN report.

Unions to petition BEST demanding 3,337 undertakingowned buses in fleet

- MUMBAI: Various unions, big and small, of BEST undertaking have come together to take up the issue of BEST owned buses dropping to one third of its original fleet a few years back, and this has affected the operations majorly, union leaders said on Monday.
- There is not only a shortage of buses, but a lack of well trained drivers to run the existing fleet. The contractual buses, which form twothird of the fleet, are run by private and



"mostly less experienced" drivers hired by contractors, they alleged. The group of unions, which met at Dadar for a day recently, will petition BEST management this week as they feel "cheated" regarding a MoU which was signed a few years back to maintain a minimum 3,337 BEST owned buses in the fleet.While workers threaten protest, they also seek to approach politicians, especially candidates standing for Lok Sabha elections in Mumbai constituencies, to take up their cause at rallies starting soon.

Will 'imported' sugar barons sweeten BJP's Maharashtra tally?

Mumbai: Nothing sweetens a politician's chances in Maharashtra like sugar. Former CMs Vasantdada Patil, S B Chavan, Vilasrao Deshmukh and Ashok Chavan were all sugar barons. So were the bulk of cabinet ministers.For a long time, the state's cooperative sugar sector, which dominates the rural economy in western Maharashtra and parts of Marathwada, leaned towards Congress and NCP. The late Gopinath Munde was one of the few BJP leaders to set up sugar factories in Marathwada, until the

party went on a drive to mop up sugar barons from rival camps in 2019.

Among the top 'imports' were former Congress leaders Radhakrishna Vikhe Patil and Harshavardhan Patil, as well as the family of Vijaysinh Mohite Patil, who is now on his way back to NCP (Sharad Pawar). Vikhe Patil's son Sujay is a BJP MP while Mohite Patil's son Ranjitsinh is a BJP MLC. Later entrants include Hasan Mushrif, who joined Ajit Pawar's faction of NCP, and Ashok Chavan, who leftCongress for BJP.

Centre also set up a Union Cooperation ministry under Amit Shah in 2021 although cooperatives are a state subject. But will these imports help BJP in Lok Sabha polls?Steady Gains In State's WestConsider the numbers. The cooperative network has an influence on at least 16 of Maharashtra's 48 Lok Sabha seats. Western Maharashtra's sugar bowl has 10 of these. In 2009, Congress-NCP won six seats, but in the Modi wave of 2014, BJP won three and its alliance partner Shiv Sena won two, while NCP took four. By 2019, BJP had four seats, Shiv Sena three and NCP was down to three.However, observers say this sugar



high has its limits. "There is now a disconnect between sugar barons who have gained financially and politically, and farmers who are the voters," says Ajit Navale from Kisan Sabha.For the farmervoter, the sugar export ban that caused domestic prices to slide, and low prices for the local soya bean crop are more important, says farmer leader Raju Shetti, who rose politically by taking on sugar barons. He is contesting as an Independent candidate from Hat-kanangale in the sugar belt.Shetti says BJP might also have to worry about the fallout from splitting NCP and Shiv Sena, andthe Maratha quota agitation: "The sympathy wave towards Sharad Pawar and Uddhav Thackeray will also be a factor in this election, especially in western Maharashtra."Growng Disconnect With FarmersMaharashtra is India's second biggest sugar producer after UP, and many of its cooperative sugar factories were set up in the 1960s. These spawned a larger web of cooperative banks, dairies and educational institutions, giving their masters enormous political clout.However, the influence of sugar barons over farmers waned as the feeling that they were self-serving and had run cooperative institutions to the ground grew. Several cooperative sugar factories

were auctioned at throwaway prices, often to be run by the same politicians. Currently, there are more private sugar mills (105) than cooperatives (95) in the state.

Political Chameleons AllFor all their political and financial clout, these barons have been ideologically fluid, siding with the winning side. Both Radhakrishna Vikhe Patil and Harshavardhan Patil left Congress and joined Shiv Sena-BJP govt in

1995. They later returned to Congress but are with BJP now. Originally with NCP, Vijaysinh Mohite Patil's family aligned with BJP in 2019 and Ranjitsinh Mohite Patil became a party MLC. The family was expecting a BJP ticket for Vijaysinh's nephew Dhairyasheel Mohite Patil, but after BJP nominated the family's local rival and sitting MP Ranjeetsinh Nimbalkar from Madha, Dhairyasheel joined NCP (Sharad Pawar) and got the party's Madha ticket. YSRC & TDP fight dissidence to win big in Kadapa

KADAPA: With elections fast approaching, campaigning has intensified in Kadapa district. However, it seems that the TDP has fallen behind in electioneering as the party leadership is busy pacifying disgruntled seniors, who are ready to quit over not being considered for contesting the elections. Following in their footsteps are the second-rung leaders, giving a new headache for the TDP high command. Though the TDP had issued press statements claiming that members of the YS family would join the party, there has been no such development so far. However, the YSRC has succeeded in poaching prominent leaders from the yellow party such as SV Satish Reddy, former deputy chairman of AP Legislative Council and rival of YS Rajasekhara Reddy, and former MLAR Ramesh Kumar Reddy. Additionally, second-rung leadership too has joined the ruling party. Talks are on with former Kamalapuram MLA G Veera Shiva Reddy and in all likelihood, he will be shifting to YSRC from TDP.In 2019, YSRC made a clean sweep as it emerged victorious in the Kadapa Parliamentary constituency and the seven Assembly segments - Kadapa, Mydukur, Badvel, Proddatur, Kamalapuram, Pulivendula and Jammalamadugu.Incumbent MP and YSRC's candidate for Kadapa LS seat, YS Avinash Reddy, along with the Parliamentary coordinator K Suresh Babu, is pulling out all stops to ensure that there is no change in the status quo. On the other hand, TDP politburo member R Srinivasulu Reddy is the only visible leader across the district, while all others are limited to their respective constituencies.Six of YSRC's candidates for the seven Assembly constituencies are vying for a hat-trick win. They are: Party president and Chief Minister YS Jagan Mohan Reddy (Pulivendula), Deputy Chief Minister SB Amzath Basha (Kadapa), S Raghurami Reddy (Mydukur), Dr Dasari Sudha (Badvel), Rachamallu Sivaprasad Reddy (Proddatur) and P Ravindranath Reddy (Kamalapuram).

Congress is fielding Afzal Khan for the Kadapa Assembly seat. He was YSRC party secretary and joined the grand old party recently. Meanwhile, the TDP has fielded R Madhavi Reddy, wife of politburo member R Srinivasulu Reddy. Though the couple are actively campaigning, they are not getting adequate support from party leaders VS Amir Babu, who aspired for the ticket, and Lakshmi Reddy, who sought a ticket for his daughter-in-law Uma. Srinivasulu Reddy is reportedly not making much effort to pacify the miffed leaders. YSRC's Raghurami Reddy, though an elderly legislator, is actively canvassing in Mydukur. He is not getting the needed support from Mydukur municipal chairman M Chandra. Putta Sudhakar Yadhav, contesting for the third time on the TDP ticket is also making every effort to wrest the seat from the YSRC. He is focusing on wooing YSRC activists into the TDP fold.In Badvel, YSRC's Dr Sudha has support of former MLC DC Govinda Reddy and others. The NDA has fielded BJP's Bojja Roshanna, a close aide of TDP constituency in-charge K Vijayamma. Vijayamma and her son Ritesh Reddy are making every effort for Roshanna's victory.YSRC candidate in Proddatur, Sivaprasad Reddy is not getting the support of MLC Ramesh Yadav. Hence, Rachamallu is making every effort to get the support of the Yadav community. However, dissidents in the YSRC like K Shiva Chandra Reddy and K Babu have joined the TDP. TDP candidate and veteran leader N Varadharajulu Reddy is facing a similar trouble as former MLAM Linga Reddy and constituency in-charge G Praveen Kumar Reddy are not supporting him.

Rain, gale flatten 10k banana trees MBCs bar SC villagers from using local salon near Alangulam in Tamil Nadu

TENKASI: People belonging to a Scheduled Caste (SC) community in Ayyanarkulam village near Alangulam alleged that the members of a Most Backward Class (MBC) community are preventing hairdressers from giving them haircuts.

According to the SC residents, over 1,000 BC, MBC and SC families reside in Avvanarkulam. "Of these, at least 50 families belong to the SC community. Since we are denied haircuts at the salon in our village, we visit the neighbouring Nallur village or Alangulam town.

This has been happening for many years. Recently, an eight-year-old boy hailing from an SC family went to the salon in our village.



After making him wait for more than an hour, the hairdresser refused to cut his hair, stating that he was abiding by the instructions of the MBCs," residents said on the condition of anonymity.

"People from the MBC community also asked us not to visit the salon and told us to get a separate hairdresser. The district administration must intervene and end this discriminationtowards us," they said. Recently, the SC residents verbally highlighted this

issue to the village administrative officer (VAO) and Alangulam police. However, fearing repercussions, they are yet to submit a written complint to the police.When contacted, Ayyanarkulam VAO Santhakumar told TNIE that SC residents are indeed

denied services at the salon. "The SC residents always visit the neighbouring villages to get haircuts. Memories that food triggers


Travelling around, one has had good food, terrible food, excellent food and strange food. Also, 'food' that should not be called food. Years ago, when Hong Kong had just gone back to China, tired after travel, we searched high and we searched low for a vegetarian meal. None seemed to be forthcoming and we settled for bread and jam. At least that was available. That was a minor adventure. That was a far-off place. Let's come closer home and to some other minor forays into uncharted gastronomic territory Places that are relatively free of the 'edible menace'. At a small dhaba in Spiti, one asked for thupka, which was something that one was familiar with and fond of. The soup was a generous dose of red chilli powder stirred in tepid water with an afterthought of noodles. At another time, in the village of Janjheli, tucked in the inner hills around Mandi, another dhaba offered meat in rajma. The thought of mutton cooked in kidney beans sounded deliciously exotic, but the result that arrived in a steel bowl was a disappointment — the flavour of both had been lost. This was no fusion, this was more like culinary fission. Janjheli, home of that rare meal of rajma-meat, like other parts of the Mandi parliamentary constituency, is going to see a fair bit of activity in the coming weeks. There is another place in another district that also witnesses its share of action, and is one where election hopefuls go to seek blessings of the divine. The temple of Baglamata lies near the little village of Bankhandi in the district of Kangra. It is nestled in a dip by an ancient peepal tree and the highway takes a long sweeping bend around it. Symbolic of the colour associated with the goddess, this is painted a bright yellow. Enshrined at various places around India, Baglamukhi is considered the eighth of the 10 Mahavidhyas, the 'Great Goddesses of Wisdom'. In belief, she holds the cudgel that dispels and destroys a believer's illusions — this great power can also destroy enmity. It is widely believed that Baglamata's blessings bring victory in elections and without them, there is no mandate.It was three decades ago in an old Ambassador car that a driver, who seemed to know every cow and goat in every village, took us to Bankhandi. My sister and I were taking what would perhaps be the last trip of just the two of us. After this, there would be spouses, children, the roll call of responsibility and a separation of several thousand miles. We would be lucky if we met once a year and talked about the weather and compared the noses and teeth of children who were now cousins; discussed whose jaw had originated with which grandfather. As we knew then, our parents would soon be gone and the bonds of the time when we were inseparable could loosen. We knew and did not speak of it, but this trip was to be the last chapter of what remained of childhood.

We rattled past the earth and stone walls covered with bright bracts of bougainvillea; we walked by banyans that proclaimed sacred domains. Karam Singh, the driver, had worked everything out for us; we were friends now. Ten days of companionship had taken care of that. He was the older one and he decided whom we would meet and where we would eat. Apart from a brief and passing delusion, one has had no plans of entering politics. Going to the temple of Baglamata was simply for darshan and lunch at this temple, that lies on the road between the village of Dehra and the town of Dharamsala.

Have we frittered away the wealth of civilised innocence of a nation for the mockery of hustings as they have come to pass



was at home on winter vacation in a mofussil town of Punjab, where my father was posted as the Deputy Commissioner, and Prime Minister Jawaharlal Nehru was scheduled to address an election rally in the last week of December 1951. Here I was to witness the diligent administrator, criss-crossing his district from dawn to dusk, ensuring that all his subordinate revenue functionaries down to the patwari and the police constabulary at each thana understood the import of the historic change-in-the-making, and their onerous responsibility to maintain peace for free and fair polling. The PM's motor cavalcade was late by an hour and the crowd of several thousand peasants was becoming restive. However, the moment Nehru, in a brown woollen achkan and white churidar, mounted the podium, the audience fell into instant reverential silence. Though I was privileged to sit on one of the few chairs upon the rostrum, I too was so mesmerised in the shadow of the great man that I registered not a word of his speech.

e concluded, asking the audience to arise and join him in a full-throated chorus of 'Bharat Mata Ki Jai Ho', three times over! And that chant persisted for at least the next half hour, till the last of the gathering had dispersed!

Perhaps an unparalleled episode which captures the magic moments of India's first election comes from the book 'The Vanishing Indian Tiger: Diary of a Forest Officer', edited and gifted to us by the late Vice Admiral MP Awati. A Divisional Forest Officer posted in the interiors of Madhya Pradesh had set out on a 106km-long bumpy ride over a dirt track to establish a polling booth in Pathera village, along with one clerk,



When this column celebrates birth anniversaries of famous writers, how can April go by without a column on William Shakespeare (April 23, 1564 -April 23, 1616), on his 460th birth anniversary. It is true that Shakespeare came to us with colonialism, may even have been introduced to India as part of a 'civilising mission', may have been seen as a good foundation for an education meant to turn out officials working for the white rulers, but Shakespeare came to occupy a different place in the theatrical (and later cinematic) world and was also seen as a playwright who could be approached and read from various Indian points of view. It is very often said that after the blackout of Shakespeare during the high nationalistic phase, we got back to his plays only after Independence with a new confidence, beginning with translations and productions by Utpal Dutt in Bengali.

While this may be true, early productions and translations of Shakespeare constantly Indianised his plays. While visiting troupes performed Shakespeare in Bombay (Mumbai) and Calcutta (Kolkata) from the second half of the 18th century, his plays began to be performed by Indians in the 19th century. In Mysore, the Maharaja was the patron of the Palace Company which was formed in 1881. They performed Shakespeare's plays in Kannada and the translations changed the settings and the names of characters so as to not alienate the audiences. This resulted in interesting changes. Ananda Rao, who translated 'Romeo and Juliet', writes that many parts of the play would appeal to only an English audience and had to be changed. Most significantly, he changes the ending of 'Ramavarma-Lilavati' (1889) by adding a short scene where the friar prays to God that the lovers be saved, and God obliges. The lovers come back alive and live happilv ever after Ananda



Rao felt that according to Indian conventions, plays should have a happy ending. You can see such changes in many Indian languages.

While changing names and settings is almost to be expected, it is this imposition of Indian theatrical conventions that make late 19th century translations/performances interesting. Girish Chandra Ghosh, one of the major figures in Bengali theatre, translated 'Macbeth' in 1893. The changes he effects in the play start right at the beginning! While he kept close to Shakespeare otherwise, the structure he adopts is of Sanskrit plays. Sanskrit plays begin

with naandi, a prayer or benedictory verse, followed by a prologue that speaks about the play to be performed. Ghosh says here that this play of his is his token of appreciation to the great playwright Shakespeare. There are other ways in which Ghosh Indianises the play, making it speak to the Bengali audience. All this is to point out that we have a history of appropriating Shakespeare's plays, enriching our theatres, while our conventions and worldview had an impact on the plays. So, while it is true that Utpal Dutt brought insouciance to the translation and performance of Shakespeare, which could be seen later in Habib Tanvir's versions as well, it is only a renewed attempt by a resurgent Independent India. So Shakespeare was performed not just in different languages, but also in different performance traditions like Kathakali.Shakespeare has had such an impact that we see echoes of his plays in many of our movies made in India. However, I want to highlight the adaptations of Shakespeare by Hindi cinema which I have seen and liked. Gulzar's 'Angoor' (1982), which is based on 'Comedy of Errors', is a brilliant adaptation. I recommend that you should watch it if you haven't or even if you did a long time ago! Jumping to this century, I will recommend Vishal Bhardwaj's trilogy — 'Maqbool' (2003), 'Omkara' (2006) and 'Haider' (2014). They are based on 'Macbeth', 'Othello' and 'Hamlet', respectively. 'Macbeth' becomes a gangster film set in the Bombay underworld, 'Omkara' about the political system in Uttar Pradesh, and 'Haider' about the Kashmir conflict in the mid-1990s. Thus, the colonial imposition Shakespeare still inspires and entertains us, nor have his plays lost their political edge under a different sky! He can speak to us about 118

2,018 Criminal Cases Against MPs, MLAs Decided In 2023, Supreme Court Told

New Delhi: Special courts for trial of criminal cases related to Members of Parliament and Members of Legislative The same was the position in 2019 Lok Sabha Assembly decided more than 2,000 cases in 2023, the Supreme Court has been informed.

In an affidavit filed by senior advocate Vijay Hansaria, who has been appointed amicus curiae in a PIL seeking expeditious disposal of criminal cases against MPs/MLAs, said that more directions are needed for speedy adjudication of pending trials and their investigation under strict monitoring by the respective high courts, as there are around 501 candidates with criminal cases who are contesting the Lok Sabha elections in the first two phases.Referring to a report of NGO 'Association of Democratic Reforms for the Lok Sabha elections 2024 Phase I and Phase II,' Mr Hansaria, assisted by advocate Sneha Kalita, said that out of 2,810 candidates (Phase I - 1,618 candidates and Phase II - 1,192 candidates), 501 (18 per cent) candidates have criminal cases against them, out of which, 327 (12 per cent) are serious criminal cases

(punishable with imprisonment of 5 years and more).

elections in which out of 7,928 candidates, 1,500 candidates (19%) had criminal cases, out of which 1,070 candidates (13%) were serious criminal cases. However, out of 514 elected members of 17th Lok Sabha (2019-2024), 225 members (44%) had criminal cases against them."Thus, the candidates with criminal cases have won more seats than candidates without criminal cases. In this context, it is necessary that this court may pass further orders for expeditious disposal of pending trials and investigation under strict monitoring by the respective high courts," the affidavit said.Mr Hansaria, who is assisting the court in the PIL filed by Ashwini Upadhyay for speedy disposal of cases against the lawmakers, said, "It may be noted that in view of the direction issued by this court in the present proceedings, the steps taken by the respective high courts, and expeditious hearing by the special court MP/MLA. more than 2000 cases have been decided in the year 2023. However, a large number of cases are pending, and many of them are for a long period."He gave a tabular chart based on the information received from different high courts, under which as on January 1, 2023, there were 4,697 criminal cases against the lawmakers and 2,018 cases were decided last year. The affidavit said 1,746 fresh criminal cases were filed in 2023 against the MPs/MLAs and therefore total of 4,474 cases remain pending as on January 1, 2024. The maximum, 766 cases out of 1,300, as on January 1, 2023, were adjudicated by the special courts in Uttar Pradesh. Delhi, which had 105 cases at the start of last year, disposed of 103 cases by December 31, 2023. Some of the big states, like Maharashtra, decided 232 cases out of 476 cases against MPs/MLAs as on January 1, 2023, West Bengal 13 out of 26, Gujarat 30 out of 48, Karnataka 150 out of 226, Kerala 132 out of 370, and Bihar decided 171 cases out of 525 cases.

It is thus necessary that the High Court may call for a report from the presiding officers of the Special Court MP/MLA of all those



cases which are pending for 3 or more years with reason for long pendency along with a copy of the order sheet of last one year.

"It may be clarified that only a copy of the order sheet is to be sent and not the entire case file so that the trial is not affected. The High Court may thereafter, pass appropriate orders on micro examination of each case with a positive direction that a trial may be completed within one year," he said.He sought direction from the top court for creating a model website on the pattern of National Judicial Data Grid for uploading real-time information on the

progress of the trial of cases against lawmakers."For this purpose, this court may constitute a committee under the chairmanship of a sitting Judge of this court. The committee may comprise of Chief Justice/ Judges of some of the high courts, a member of e-Committee, a nominee National Informatics Centre (NIC) and such other persons as this court may think appropriate," the affidavit said.

Odisha, Bengal, Jharkhand reel under severe heatwave, rain on cards

New Delhi: Parts of India, especially the eastern states, continue to swelter in heatwave conditions even as the India Meteorological Department (IMD) has forecast no immediate respite. In its latest bulletin, the weather department predicted heatwave conditions in Bengal, Odisha, Jharkhand, Bihar and Uttar Pradesh till April 26. Day temperatures in Odisha and Gangetic West Bengal are expected to surpass 40 degrees Celsius today.Besides these states, hot and humid weather is very likely in parts Odisha, Bengal, Bihar and Jharkhand of several southern states and Union Territories, such as coastal Andhra Pradesh, Kerala, Puducherry and Tamil Nadu, among others. The latest IMD forecast came even as the maximum temperature settled at between 42 and 45 degrees Celsius on Sunday in parts of Odisha, Rayalaseema, Gangetic West Bengal, Jharkhand, Vidarbha, Chhattisgarh, Madhya Pradesh, Telangana, and

So try to include raitas in your meals or use yoghurt as a salad dressing," she adds. Dr. Apratim Goel, dermatologist, says that antioxidants helps to counter the damage caused by over exposure to the sun. "Raw tomatoes are an excellent source of antioxidants. The bottom line for great summer skin, however, is maximum hydration," she explains.

What does one drink in summer for optimum hydration?

Setalvad strongly recommends raw mango drinks (popularly known as aam panna in most parts of India). Avoid alcohol and sugary fluids like sherbets and aerated drinks. Salted lemon water, buttermilk, jal jeera and caffeine-free herbal infusions like peppermint or coriander drinks are ideal.

Does a predominantly fruit and vegetable diet ensure great skin?

Not all veggies are ideal for summer. Pumpkins, snake gourds, cucumbers, tomatoes and lettuce are good for light summer meals. Setalvad suggests incorporating slices of raw mango into salads or snacks. "Mango pickle is an excellent option since it helps to re plenish the essential salts lost due to perspiration," she explains. Melons and mangoes are well known 'summer fruits'. However, the innocuous mango is often thought to be

responsible for pimples. "Don't blend mangoes with milk or sugar," warns Setalvad. Mango is alkaline while milk is acidic, resulting in a disrupted pH. This causes indigestion and skin break outs when the body tries to eliminate the accumulated toxins. Setalvad also suggests sprinkling dry ginger pow dry ginger powder on mango in order to reduce the risk of flatulence. What is the basic skin care regimen that one

should follow during summer?

Your skin needs moisturising even in summer.Dr Goel recommends making an emulsion of your regular moisturiser by mixing it with a little water and applying this to the face and neck. She suggests a natural remedy to rejuvenate tired, summer



India's direct tax collections jump 18% to Rs 19.58 lakh crore in FY24

NEW DELHI: India's net direct tax collections rose by 17.7% to reach Rs 19.58 lakh crore in FY24 on account of significant growth in personal income tax. The collections slightly exceeded the revised estimates of Rs 19.45 lakh crore by 0.7%, as per the government data.The original direct tax collection target was Rs 18.23 lakh crore, which was later revised to Rs 19.45 lakh crore. Presently, collections have surpassed both the initial and revised estimates by 7.7% and 0.7% respectively, despite a significant increase in refunds.

The surge in Personal Income Taxes elevated its share to 53.3% from 50.06% previously, while Corporate Taxes' contribution decreased to 46.5% from 49.6%.Direct taxes consist of personal income tax (including securities transaction tax) and corporate income tax (CIT). An increase in direct taxes signals growth in both personal income and business profitability. The Net Personal Income Tax collection (including securities transaction tax or STT) in FY 24 stood at R10.44 lakh crore with a growth of 25.23% year-on-year. Meanwhile, the provisional net corporate tax collection in FY24 stood at Rs 9.11 lakh crore, indicating a 10.26% growth compared to the previous year's collection of R 8.26 lakh crore.Refunds of R3.79 lakh crore have been issued in the FY 2023-24 showing an increase of 22.74% over the refunds of R 3.09 lakh crore issued in FY 2022-23," the government said in a statement.

India Needs Rate Cuts to **Reach Potential Growth, Say MPC** Members

NEW DELHI: India needs to cut interest rates to help its economy reach its potential growth but the members of the South Asian nation's monetary policy committee (MPC) are divided on the timing of such cuts, interviews with two external members suggest."We are in a catch-up growth phase. Growth has to go up in order to create employment and jobs for young people, for the investment cycle to take off, and so on," Ashima Goyal, one of three external members on the sixmember MPC, told Reuters."To the extent inflation is within our tolerance band and is approaching target, we have not yet reached potential. That means we can afford to grow at higher rates." growth currently being robust — at an estimated 7.6% for 2023/24 — and several uncertainties on the inflation front, it was better to maintain stability and thus, a status quo on rates.Earlier this month, the MPC kept the lending rate steady at 6.5% for the seventh meeting in a row after having raised it by a total of 250 basis points between May 2022 and February 2023. The market expects rate cuts only in early 2025, with Morgan Stanley ruling out any cuts this fiscal year.India's success in the disinflation process should not distract the MPC from the inflation trajectory's vulnerability to frequent supply-side shocks, Governor Shaktikanta Das wrote in the minutes of that meeting released on Friday.

Jayanth Varma, another external MPC member, was the only member to vote for a rate cut for a second straight meeting."My vote for a rate cut in nominal terms is actually a vote against rising real rates when growth is slackening," Varma told Reuters in an interview after the minutes were released."High real rates could also hinder private sector capital investment, which is critical in an environment of fiscal consolidation."

While Goyal agreed the real neutral rate would stay above 1% if rates were cut, and keep monetary policy contractionary, she was wary about the 2000s, when an overheated capex cycle in the private sector led to large borrowings and a surge in defaults."So, we don't want that kind of capex cycle. We want a slow and sustainable cycle and that seems to be happening," Goyal said, also in an interview after the minutes were released.

Tesla cuts the price of its "Full Self Driving" system by a third to 8,000

NEW DELHI: Tesla knocked roughly a third off the price of its "Full Self Driving" system - which can't drive itself and so drivers must remain alert and be ready to intervene - to \$8,000 from \$12,000, according to the company website.Tesla CEO and billionaire Elon Musk promised in 2019 that there would be a fleet of robotaxis on the road in 2020, but the promise has yet to materialize, and the system still has to be supervised by humans. The cuts, which occurred on Saturday, follow Tesla's moves to slash \$2,000 off the prices of three of its five models in the United States late Friday. That's the latest evidence of the challenges facing the electric vehicle maker. Tesla knocked \$2,000 off the prices of three of its five models in the United States late Friday. The company cut the prices of the Model Y, a small SUV which is Tesla's most popular model and the top-selling electric vehicle in the U.S., and also of the Models X and S, its older and more expensive models. Prices for the Model 3 sedan and the Cybertruck stayed the same. The cuts reduced the starting price for a Model Y to \$42,990 and to \$72,990 for a Model S and \$77,990 for a Model X.The move came the day after Tesla's stock tumbled below \$150 per share, eliminating all gains made over the past year. The Austin, Texas, company's stock price has dropped about 40% so far this year amid falling sales and increased competition. Discounted sticker prices are a way to try to entice more car buyers. Industry analysts have been waiting for Tesla to introduce a small electric vehicle that would cost around \$25,000, the Model 2. Media reports this month that Musk planned to scrap the project created more uncertainty over the company's direction, although Musk called them untrue. The price cuts ended a long workweek at Tesla, which announced Monday that it was cutting 10% of its staff globally, about 14,000 jobs. The company also said it was recalling nearly 4,000 of its 2024 Cybertrucks after discovering the accelerator pedal can get stuck, potentially causing the vehicle to accelerate unintentionally and increase the risk of a crash.On Saturday, Musk confirmed he had postponed a planned weekend trip to India to meet with Prime Minister Narendra Modi, citing "very heavy Tesla obligations." He said on X that he looked forward

Wipro Shares Gain Over 2% As Q4 Earnings Beat Expectations; Should You Buy, Sell Or Hold?

NEW DELHI: Wipro shares gained over 2 per cent on Monday as investors reacted to the IT services firm's fourth-quarter results, which was better than what market analysts expected.At around 10.50 am, shares of the company were up 2.46 per cent to Rs 464 on the Bombay Stock Exchange (BSE). Wipro has beaten the Street estimates with a 5 per cent rise in net profit for the January-March quarter, but persisting cost-cutting measures, decline in headcount and a sluggish guidance for the next quarter fuelled concern among brokerages that a recovery for the IT major may still be some time away. The company's net profit rose 5 per cent on-quarter to Rs 2,835 crore in January-March, surpassing the market projection of Rs 2,748 crore, while its revenue too exceeded expectations, despite staying largely flattish on-quarter at Rs 22,208.3 crore as against the Street estimate of Rs 22,117 crore.Operational efficiencies helped the company expand its EBIT margins by 40 basis points sequentially to 16.4 percent. Going ahead, the management has kept its revenue guidance unchanged for Q1 FY25 to -1.5



percent to 0.5 percent.

It is this sluggish growth guidance from Wipro that left brokerages like JP Morgan, Nomura, HSBC and UBS in a state of discomfiture. While Nomura believes the Q1 FY25 guidance reflects discretionary weakness, UBS sees it as a sign of revival still being afar.Both Nomura and HSBC have maintained reduced ratings on Wipro with target prices of Rs 410 and Rs 385, respectively.

"Wipro cautioned that the revival in BFSI (+2.1% q-q) is partly due to the reversal of furloughs seen in 3Q and discretionary demand remains challenging. Despite healthy order booking, Wipro's 1Q FY25F revenue growth guidance of -1.5% to +0.5% q-q in cc reflects our view," Nomura said.On the other hand, HSBC highlighted the continued market share loss of Wipro as it feels that signs of operational improvement are still not imminent. According to the brokerage, growth acceleration for Wipro also doesn't look imminent as cost-cutting measures continue. Regardless, the brokerage is still positive over the elevation of an internal veteran to lead the company. HSBC also has a 'reduce' call on Wipro with a price target of Rs 385.

Morgan Stanley reduced the target price to Rs 421 saying that although the commentary suggests stabilization in the BFSI vertical, there is limited clarity on pace of recovery.UBS also has a sell rating with a target price of Rs 430. "Management optimism in last quarter around revival in consulting on basis of Capco order book did translate into soft growth but not enough to drive overall revenue growth. Further, a weak Q1FY25 guidance indicates revival still some time away," it said.Based on the sluggish growth guidance, Nuvama Institutional Equities also expects Wipro to underperform peers, however, it feels its inexpensive valuation and high dividend yield limit the downside potential. Nuvama has a 'hold' call with a price target of Rs 460.

He admitted to the offence and accepted the Match Referee's sanction. For Level 1 breaches of the Code of Conduct, the Match Referee's decision is final and binding," the statement read.
- Sam Curran was given out LBW after he opened the batting to bolster their batting line-up. However, Curran managed just 20 runs as PBKS's batting crumbled again, managing just 142 on the board in 20 overs. Despite a disciplined effort with the ball, PBKS ended up losing the contest after Rahul Tewatia came up with a handy late cameo from Gujarat.

New Delhi.Virender Sehwag has slammed PBKS stand-in skipper Sam Curran, saying that he wouldn't have him in the team as a batting or a bowling all-rounder as Punjab slumped to their 6th loss of the season.



Curran scored 20 off 19 balls and picked up one wicket from his two overs as he conceded 18 runs. GT would end up winning the match as PBKS' Mullanpur struggles continued.Speaking to Cricbuzz, Sehwag was very critical of Curran performances with both bat and ball, saying

that a person who is doing some batting and bowling isn't helping the side. The former India cricketer said that he needs to help the side with either the bat or with the ball, which he feels the England all-rounder has struggled to do all season."I wouldn't keep Sam Curran as a batting all-rounder or a

bowling all-rounder. Because such a player is of no use, who does some batting and some bowling. Either you win the game with your batting or win the game with your bowling. Either you hit the bullseye or you don't perform at all," said Sehwag.

How well has Curran fared this season? Curran started things off with a fine performance with the bat against DC as he scored 63 to get PBKS off to a winning start. However, since then, the England allrounder has struggled to make any impact with the ball or bat. In 8 matches so far, Curran has just 153 runs to his name with an average of 19. Curran had scored 276 runs last season in the IPL at an average of 27.60

In terms of bowling, while he has picked up 11 wickets, the economy rate has been 8.79 and he decided to only use himself twice against GT.Curran and Punjab will next be in action against KKR at the Eden Gardens on Friday, April 26 as they look to end their losing streak and return back to winning ways. The defeat to Gujarat means that PBKS are 9th on the table.
