Haryana notifies streamlined recovery process for homebuyers

(Regulation Chandigarh, May 18: In a major relief to homebuyers constrained to approach the court following the failure of the authorities concerned to execute recovery warrant/certificates issued against the promoters despite the lapse of several years, the State of Haryana has come out with a notification to streamline the recovery process. The notification came after the Punjab and Haryana High Court observed it had "come across many such cases, and records were replete, where investors were constrained to approach the court for the authorities failed to execute the recovery certificates, though years have gone by". The Bench of Justice Arun Palli and Justice Vikram Aggarwal was hearing a bunch Haryana of 25 petitions on the issue. A substantial number of petitioners were complainants before Gurugram Haryana Real Estate Regulatory Authority.

Development) Act, 2016, were allowed years ago. The competent authority or the adjudicating officer subsequently issued recovery certificates, whereby the amount they were entitled to, was determined upon initiating the execution proceedings. In one of the matters, the entire land belonging to a promoter was attached. BJP is planning to ban RSS: **Uddhav Thackeray**

Mumbai, May 18: Shiv Sena (UBT) chief Uddhav Thackeray on Saturday claimed that BJP was planning to ban its ideological parent, the Rashtriya Swayamsevak Sangh (RSS), after winning a third term in power. Speaking at his last rally here before the campaigning for the Lok Sabha elections ended in Maharashtra, Thackeray also said that the Election Commissioner who was "acting like Modi's servant" will be removed after the INDIA alliance government comes to power. "The way they tried to use and throw the Shiv Sena, a similar game will be played by Narendra Modi in future (with RSS). and that has been stated by (BJP president) JP Nadda, he said. Thackeray was referring to Nadda's comments to a newspaper that when BJP was a small party and less capable, it needed RSS, but now the saffron party has grown, become more capable, and "runs itself".

"Nadda said there was a need of RSS until now, (but) we are capable now and we don't need RSS. If they (BJP) came to power, it is a bigger danger for RSS workers because they will ban the RSS," Thackeray claimed. In the past, (then Union home minister) Sardar Vallabhbhai Patel had banned the RSS, he noted. "Those who call our party 'nakli' (fake) Shiv Sena will call the Sangh 'nakli',' Thackeray further said, referring to Prime Minister Modi's jibe at the Sena (UBT).

Defence Ministry on reports of model of Chinook chopper going missing

New Delhi, May 18: The defence ministry on Saturday trashed reports that a model of a Chinook chopper installed by the Defence Research and Development Organisation (DRDO) at the 2020 edition of DefExpo went missing. Defence Ministry spokesperson A Bharat Bhushan Babu said DRDO never installed any helicopter model in Lucknow. "The news circulating about a DRDO installed Chinook Helicopter Model at Lucknow during DefExpo 2020 missing is misleading," he said in a brief statement. "Chinook is made by Boeing and DRDO has never installed any helicopter model at Lucknow anytime. DefExpo2020 was an incident-free exhibition and no product or model went missing during its conduct," Babu said. DRDO also described the reports as "misleading". "There is news circulating that DRDO had installed Chinook helicopter model at Lucknow during DefExpo 2020 and model is now missing," it said on X. "This information is misleading as DRDO has never installed any Helicopter Model at Lucknow anytime," it said. Officials said there was a model of a helicopter in a dilapidated condition at Sector 20 of the Vrindavan Yojna area in Lucknow and it was removed following a recommendation by security personnel as a helipad had to be constructed for the Prime Minister's visit to the city for an event relat-

"The BJP has one by one sent our party leaders to jail, they have today arrested Bibhav, next they will arrest Raghav Chadha who has just come back, following they will arrest Saurabh Bhardwaj and Atishi," he claimed at a press briefing hours after his aide Bibhav Kumar was arrested in connection with the alleged assault on his party's MP Swati Maliwal. Kejriwal has continued to observe silence in the Swati Maliwal 'assault' case at CM's residence. "Tomorrow I will be going to the BJP headquarters along with senior party leaders. Arrest anyone you want to," said Kejriwal. Kejriwal, who is also the AAP national convener, however, asserted that his party could not be crushed by sending its leaders to jail. "The AAP is an idea. For as many AAP leaders you jail, the country

Existing LAC pacts favour China: Arunachal Governor

New Delhi, May 18: Four years since the military standoff with China along the Line of Actual Control (LAC) in eastern Ladakh, Lt Gen KT Parnaik (retd), Arunachal Pradesh Governor, today said the existing "peace and tranquility" agreements on protocols for troops at the LAC favoured the Chinese. "It is time the Ministry and External Affairs and the Ministry of Defence Affairs entered new agreements with Beijing," said Lt Gen Parnaik, who was the Northern Army Commander from January 2011 to June 2013. He was delivering the keynote address of the second Lt Gen PS Bhagat Memorial Lecture here. Lieutenant General Bhagat (1918-1975) coauthored the Henderson Brooks report on the 1962 India-China war. Lt Gen Parnaik said, "The existing agreements on the LAC suit the People's Liberation Army. We are guarding an invisible line. There are frequent violations of agreement. The MoD and MEA need to be ready with a new set of agreements." "India needs to counter the Chinese claims of its dynasties having ruled some parts at some point in history," he said.

New Delhi, May 18: Congress leader Rahul Gandhi on Saturday claimed that Narendra Modi is refusing to have a debate with him as the prime minister cannot answer questions about his "links" with a few favoured businessmen and how he "misused" electoral bonds. Addressing a public meeting organised by the Congress in Delhi, he urged workers of his party and of the Aam Aadmi Party to work together and ensure victory for their alliance on all seven Lok Sabha seats in the national capital. "It's interesting that I'll vote for AAP and Arvind Kejriwal will vote for Congress in these elections," he said. Gandhi said the first aim of everyone should be to save the Constitution from those "hell-bent on destroying it". Attacking the prime minister, the Congress leader said, "PM Modi is giving non-stop interviews to his favourite journalists but he will not have a debate

High Court raps 'incorrigible' Punjab Police for failure to depose in drug cases

Chandigarh, May 18: The Punjab and Haryana High Court on Saturday said the State of Punjab did not need a reminder of the widespread drug menace prevalent in "this part of the country" before rapping it for its failure to ensure the presence of police officials as prosecution witnesses in such matters despite assurance by the state police chief. The Bench made it clear that the court would no longer accept apologies and assurances on future compliance by the state. Concrete steps were required to be taken to ensure accountability, including initiation of disciplinary action against erring officials if required. Justice Manjari Nehru Kaul noted that the court had repeatedly observed consistent failure on part of the prosecution witnesses to appear before the trial court to provide their testimony, particularly in cases under the provisions of Narcotic Drugs and the Psychotropic Substances Act. Justice Kaul added the Punjab

asked to appear before the Bench on a previous occasion following persistent irregular appearances of the police officials in drug cases. The police chief, in response, gave a categorical undertaking after appearing before the Bench that the prosecution witnesses would regularly attend the proceedings in such matters before the court concerned and get their evidence recorded promptly. "Despite this assurance, the problem persists, and obviously it has not produced the desired results. It is imperative that the State of Puniab addresses the recurring issue of prosecution witnesses' irregular appearances in cases under the NDPS Act and implement effective remedial measures, rather than repeatedly apologizing to this Court. It is made clear that this Court would no longer accept any apologies and assurances by the State of Punjab of future compliance," Justice Kaul asserted.

Karnataka urges Maharashtra to give

BELAGAVI: To tide over the worsening drought in several parts of Karnataka, the State Government has appealed to the Maharashtra government for release of water from Koyna dam to the Krishna river, Karantaka PWD Minister Satish Jarkiholi has said. Speaking to the media in Belagavi on Friday, Satish said that the government is confident that Maharashtra would release water. The meagre amount of water available in the Krishna river currently would last only for the next 10 days, he said, adding that if the water was released from Maharashtra's Koyna dam, it would help people of several drought-hit areas in North

However, the government would utilise water from Hidkal dam to ensure a continued supply of water to all the affected areas if the situation demanded after 10 days, he said. Arrangements had been made to supply 1 tmcft of water from Hidkal dam to the Krishna river and another 1 tmcft would also be released soon, he said. Tahsildars have been asked to take immediate measures to ensure supply of drinking water in the affected areas, he added.





Orange alert issued in five TN districts for May 18,19

CHENNAI: Several places across Tamil Nadu received widespread rains on Thursday and Friday. Mylaudy in Kanniyakumari district registered the highest rainfall of 7 cm in the 24 hours ending at 8.30 am on Friday. Tiruchendur in Thoothukudi, Valparai in Coimbatore, and Nannilam in Tiruvarur received 6 cm each; Cuddalore and Kottaram in Kanniyakumari received 5 cm each; and Kayalpattinam in Thoothukudi received 4 cm during the same period. Karur Paramathi received 4.5 cm of rain from 8.30 am to 7.30 on Friday. Coimbatore, Tiruchy, and Dharmapuri received 3.5 cm, 3.3 cm and 3.2 cm, respectively in the same period. The regional meteorological centre said that the Southwest monsoon is very likely to advance into the South Andaman Sea, some parts of the Southeast Bay of Bengal and Nicobar Islands around May 19. "However, the monsoon will set in the mainland around May 31. TN usually receives 35-37% of annual total rainfall during this period. The moisture level in the interior districts will increase during this period. The rain the state is



getting now is due to cyclonic circulation," said an official from the RMC.RMC's forecast said light to moderate rain at many places with thunderstorms, lightning and gusty winds with speed of 30-40 kmph at one or two places is likely to continue till May 21. It also added that moderate rainfall is likely in Chennai city. It also gave orange alerts to several districts over the next few days including Theni, Dindigul and Tenkasi for Saturday and Sunday. The alert also extends to Kanniyakumari and Tirunelveli on Sunday. Meanwhile, heavy rain is likely over The Nilgiris, Coimbatore, Erode, Salem, Dharmapuri, Krishnagiri, Tirupattur, Kanyakumari, Tirunelveli, Tiruppur, Virudhunagar, Thoothukudi and Madurai districts on Saturday.

On Friday, the maximum temperature of various districts was below normal. On Thursday, Meenambakkam registered 10.3°C below normal

Three-day synchronised elephant census in southern states from May 23

The exercise aims to understand the area, the conflict and chalk out better policies for better coordination and future planning.

BENGALURU: An elephant census in the border areas of Karnataka, Tamil Nadu, Kerala, Telangana, and Andhra Pradesh will be held from May 23 to 25. While the elephant census is usually held for an entire forest patch once every five years, this time it will be held only in the border areas of the southern states."The exercise aims to understand the area, the conflict and chalk out better policies for better coordination and future planning. This is the first time such an exercise is being carried out. It is the outcome of the inter-state coordination committee meeting held in March 2024 in Bandipur Tiger Reserve," said a senior Karnataka Forest Department official. The inter-state meeting was held after a radio-collared tuskless male (makhana) killed a man in Wayanad, Kerala. The makhana was radio-collared by Karnataka forest officials after it was captured in Hassan. In the meeting, an Interstate Coordination Committee Charter 2024 was prepared to foster collaboration for humananimal conflict mitigation. The charter was signed by chief wildlife wardens and heads of forest departments of Karnataka, Kerala, and Tamil Nadu on March 10, 2024.



The charter listed five sections for implementation, one of them included population estimation exercises.

Earlier in 2022–23, Karnataka had taken the lead for southern states elephant estimation reports, which showed that Karnataka topped the charts, housing 6,395

elephants. The report, Asian Elephant (Elephas maximus) Population Size and Structure Estimates for Karnataka-Interim Report, August 2023, also quoted that there has been an increase in the population by 346 since 2017. "This census exercise will be limited to only the bordering areas to identify conflict areas and chalk out better solutions. On the first day (May 23), the block count will be done, the transect method will be done on May 24, and the waterhole count will be done on May 25. Radio-collared elephants will also be tracked. Only the wild ones will be tracked and assessed, not those in captivity. The all-India elephant assessment will be done later on a large scale," the official added.In Karnataka, the exercise will be done in Kolar, Bannerghatta National Park, Cauvery Wildlife Sanctuary, MM Hills (all bordering Tamil Nadu), Bandipur Tiger Reserve (bordering Tamil Nadu and Kerala), Nagarahole Tiger Reserve (bordering Kerala), and all three divisions of Kodagu. The other forest divisions of the state are not included in this exercise.

Kerala under-reports illnesses related to heat: central expert

THIRUVANANTHAPURAM: Even as Kerala sweltered under a hostile summer, the state "significantly under-reported heatrelated illnesses", National Research Development Corporation (NRDC) health and climate resilience lead Abhiyant Tiwari has said.In an exclusive interaction with TNIE, Tiwari said only 25% of public healthcare institutions in the state reported such incidents to central authorities. Gujarat, at 95%, leads in reporting of such cases while Telangana comes second with 83%, he said. A leading climate resilience and health

consultant, Tiwari was part of the development and implementation of the first Heat Action Plan (HAP) of South Asia in 2013. "Kerala should strengthen its heat and health surveillance system," he said, on the

sidelines of a workshop on 'Impact of Extreme Heat on Kerala, organised by the Kerala Union for Working Journalists (KUWJ) in collaboration with ASAR in Thiruvananthapuram on Friday. The National Programme on Climate Change and Human Health (NPCCHH) – under the Ministry of health and Family Welfare - has been collecting heat-related health illness and mortality data from every state since 2018-19 to come up with policies and programmes to review the impact and to increase national level preparedness.

"I was surprised that the cases in Kerala were under-reported. Only 25% of the public sector health facilities report data to NPCCHH. Kerala, being a pioneer in the health sector, could do better. The state did a



wonderful job during the pandemic and the overall public awareness is much better compared to any other state in the country. But the state is still not at par with our expectation when it comes to heat-health surveillance," Tiwari said.

The state should set an example by coming up with technical solutions. I am sure heat health is something (for which) Kerala can set an

example," he added.An effective early warning system could help reduce mortality rate due to disaster by eight times, he pointed out."What Kerala and any other state should be doing is to come up with strategies and policies to mitigate disasters and increase preparedness. The National Disaster Management Authority (NDMA) is preparing strategic policies and new frameworks for various sectors like agriculture, fishing and many more that can be adapted by the states for better preparedness and mitigation," he said. The 15th financial commission has allocated special funds for disaster risk mitigation and the NDMA wants the states to come up with projects and policies to tap these funds, he

Tamil Nadu: SC youth attacked as stone thrown at dog lands in graveyard

SALEM: In a disturbing incident that highlights the continuation of caste discrimination, two engineering students hailing from an SC community were assaulted by 10 inebriated people from a dominant caste near Jalakandapuram on Wednesday evening when they were returning home from college. Police arrested one suspect on Friday.According to police, the victims, R Kamalesh and Magi K, both 18-year-old, are studying in a private engineering college at Mecheri. The two were 500 metres away from their house when a street dog began chasing them.n an attempt to shoo the dog away, the youth threw stones, which landed near a funeral site where 10 to 15 intoxicated people were present. Upon questioning the boys about their background, the people learned that both Kamalesh and Magi belonged to the SC community and assaulted them. The students

suffered injuries on their legs and neck and were admitted in Salem GH.

Karthi, Magi's father, said, "The boys are severely traumatised by the incident and are scared to come out."Magi recounted the harrowing experience to TNIE, saying, "I was beaten and subjected to humiliating remarks about my caste. One member of the mob even spat in my face and questioned what I hoped to achieve by pursuing education. I am afraid to leave my home."Jalakandapuram police registered a case under sections 143, 341, 294(b), 323,324 506 and SC/STAct.

Sources said A Jayavel, one of the suspects, was arrested on Friday morning. "We are investigating further and searching for others using CCTV footage. We will arrest all the 10 people responsible for this assault," Jalakandapuram police told TNIE.

8 killed, more than 20 injured as bus catches fire in Haryana

NEW DELHI.At least eight people were killed and more than 20 sustained injuries after the bus they were travelling in caught fire near Tauru in Haryana's Nuh district in the early hours of Saturday

The bus was carrying around 60 people, all of whom were residents of Punjab and Chandigarh and were returning from Mathura-Vrindavan. The incident took place around 2 am on the Kundli-Manesar-Palwal (KMP) Expressway, according to police reports.

Local residents who witnessed the fire immediately took action, pursuing the bus and urging the driver to bring the vehicle to a halt. They also alerted the police and fire department about the unfolding emergency.

Despite their efforts, at least eight individuals tragically lost their lives, succumbing to the flames inside the bus. More than 20 passengers sustained injuries in the incident and were swiftly transported to nearby hospitals for medical treatment, as confirmed by the

Pet pit bull bites child in Noida, owner arrested

Noida. A 22-year-old Sorkha resident was arrested on Friday, days after his pet dog - believed to be a pit bull bit an 8-year-old boy who was visiting a family next door.Police said Santosh, a Noida resident, filed a complaint at Sector 113 station on May 15.Santosh alleged that on May 14, his son Shivam was visiting his aunt's house in Sorkha village when the pet dog belonging to a neighbour attacked him. Santosh alleged that the dog was never muzzled, and attacked any person who would approach. Shivam has five bite marks on his hands, stomach and other parts of his body, the complainant said, adding that the boy was treated at a city hospital. Based on the complaint, an FIR was registered against Abhishek Kumar under section 289 (negligent conduct with respect to animal) of the IPC. Abhishek was arrested, and further investigation is underway," said additional DCP (Noida) Manish Kumar Mishra. On Friday, Abhishek's family - who live in a rented accommodation in Sorkha - said the complainant had deliberately said their pet dog was a pit bull, a breed considered by many to be aggressive. Police said they have asked the district



veterinary officer to ascertain the pet dog's breed. The additional DCP added that Abhishek could not produce the regitration certificate of his pet dog when asked.Incidents of dog bites and persistent conflict between animal lovers and residents aren't uncommon in NCR, especially in densely populated areas or in apartment complexes. Often, residents demand stricter rules for keeping and walking pets outdoors, including muzzling the dog - a practice that isn't mandated by the Animal Welfare Board of India. Experts and animal rights activists say the solution isn't to ban any dog breeds, but to ensure that larger and high-energy dogs like pit bulls are not tied up and are kept in larger spaces to ensure they don't become aggressive. Last month, the Delhi high court struck down a central govt circular that banned the import, breeding and sale of 23 dog breeds that it said were considered "ferocious". The list included American pit bulls. The HC was hearing a bunch of pleas challenging the March 12 order that asked states to ban the breeds.

Farmhouse in Noida's Sector-135 raided for 'unauthorized' party; several detained for serving liquor, hookah 'illegally'

NOIDA. In a late-night raid, Noida police detained over half a dozen individuals, including two women, at a farmhouse party in Sector-135 for allegedly serving liquor and hookah without proper permissions. The police were alerted to the event through a social media post that had gone viral. A police team conducted a raid at the farmhouse located within the jurisdiction of Expressway Police Station on the night between Friday and Saturday, confiscating a significant amount of illicit alcohol and hookah. The police stated that they were alerted to a post circulating on multiple social media platforms regarding an unlawfully organized farmhouse event."We received information from sector 135. A video had gone viral on social media that a party is being organised illegally, following which a team was sent," Additional DCP Manish Kumar Mishra said.

'When the team reached the farmhouse, they found that many outsiders were at the party, and the organizers were serving liquor. . It was said that it is a launch party for a song, but on further investigating we found irregularities. We also recovered hookah and smoking material in large quantity," he said. Additional DCP Mishra further said that several people have been detained and their identities were being ascertained."Two women and a few men have been detained and their identities are being ascertained. They have been taken to the police station, and an inquiry has been initiated. Further action will be taken accordingly," he added.

Boiler blast: Worker's body found; factory owners, 2 others booked

Gurgaon: Two days after a boiler exploded at a factory making catechu extracts at Kundli in Sonipat, the body of a worker was found on Friday. While two workers near the boiler were killed on the spot on Wednesday night, one was missing, and three others were injured and are in hospital.Sukhdev Pandit's body was discovered after an extensive search by National Disaster Response Force (NDRF) personnel on Friday afternoon.

Police have booked five people in the case — including the owners of the factory — based on a complaint filed by Sukhdev's son. No arrests have been made so far.

The incident took place at the factory, which is owned by Shree Ganesh Industries, around 11.45pm on Wednesday. The

factory caved in and its tin shade was blown away. The bodies of Brajesh and Gulab Kurmi, both in their 20s, were retrieved from the rubble by Thursday morning. A total of 20 people were injured and are undergoing treatment at different hospitals in Delhi and Sonipat — some of them were working at the factory when the blast happened, others were rescued

Chandan told cops that the boiler was malfunctioning and despite repeated complaints about the machine as well as the risk of a gas leak, the factory owners failed to address the issue, endangering the lives of the workers. Workers were forced to work under these unsafe conditions, which led to the fatal accident, he alleged."My father had been working at the factory for about

ten years. He was told to work overtime on Wednesday night. When he refused, he was threatened with dismissal and was thus forced to work. Upon receiving the news of the explosion, I rushed to the factory, where I learnt about the casualties and my father being possibly trapped under the debris. We kept trying his phone, but it was unreachable," he said.

Death at police post: Two women arrested for abetment to suicide

Noida. Two women were arrested for abetment to suicide after a 20-year-old bakery staffer, a colleague whom one of them had accused of rape, was found hanging in a police post. Police said the women are sisters who worked at a Bisrakh bakery along with the 20-yearold. They were called in for questioning and taken into judicial remand after being produced before a court on Friday, said ACP-2 (Central Noida) Hemant Upadhyay.

They were booked hours after Yogesh Kumar was found dead in a barrack on Thursday, less than 24 hours after being taken to the Chipyana police chowki. Cops said Yogesh was called for questioning after they received a rape complaint from one of the two women held on Friday. Yogesh's family has alleged that the women were harassing him after a dispute at the bakery over their salaries. They also said cops at the chowki took a bribe of Rs 53,000 from them and demanded another Rs 4.5 lakh to hush up the rape complaint. Yogesh was detained on Wednesday, though an FIR

was not filed over the rape complaint. After his death was reported, Noida police suspended four sub-inspectors stationed at the chowki and ordered an inquiry against cops, including the SHO and ACP. "Both women accused by Yogesh's family have been sent to judicial custody for 14 days. There is evidence that Yogesh was being harassed by them. We also asked them to share any evidence related to the rape complaint. So far, they have not produced anything," Upadhyay said.On Friday, Yogesh's brother Jitendra Kumar told TOI that he was taking the body back to the family's hometown in Aligarh.Crying on the phone, Jitendra said: "Our family has fallen apart."He said Yogesh was planning to shift their elderly mother to Noida. "Ma ko yeh Noida laana chahta tha... ab isse aise dekh ke kya haalat hogi (he wanted to bring mother to Noida... how will she react once she sees him like this)," Jitendra said.He said that their mother was waiting to meet Yogesh, who had told her he will visit Aligarh soon. "Now, Ma will

never be able to meet him again," he added.On the arrests of the two women, Jitendra said they caused harm to his family with false charges. "Our father is a small farmer. We came so far from our home to earn a living. Look what has happened to us," he said. Yogesh's second brother Dharamveer, who also worked at the Bisrakh bakery, said that the women followed. We are also going to check if there was any brutality on the part of

Maintenance of portal hits op at RTO, no driving licence issued for 2 days

Noida. The regional transport office (RTO) has not processed or renewed driving licences since Thursday over software maintenance. Officials said the services were likely to resume by Saturday.

The RTO receives nearly 200 applications for driving licenses daily from Noida and Ghaziabad besides a significant number of applications for rectification and change in name, address and renewal of DLs. The maintenance of Sarathi portal has halted work related to driving licenses in Ghaziabad and Noida, additional regional transport officer (Ghaziabad) Rahul Srivastava said.

'In Ghaziabad, we usually receive around 100 applications for new driving licences

each day, while some individuals visit for changes in their names and addresses," the official said. Services like registration of new vehicles, however, have not been interrupted as the Vahan portal remained unaffected. Deadline to clear Bandhwari legacy waste set to be deferred again, to Dec 31 this time

Gurgaon. MCG has informed the National Green Tribunal (NGT) that it will process 16.36 lakh metric tonnes (MT) of legacy waste at Bandhwari landfill site by Dec 31. The new deadline suggests an extension from the corporation's previous commitment of completing the processing by

According to the affidavit submitted by the corporation on May 14, sanitation agencies working at Bandhwari have already processed 9 lakh MT of legacy waste between Jan 1 and May 13. The breakdown shows that 4.9 lakh MT was processed from Jan to March, and an additional 4.19 lakh MT was processed from April 1 to May 13. The civic body has also estimated that it will receive 3.9 lakh MT of daily waste from May to Dec 31."We have submitted to the green tribunal that we will process the remaining legacy waste by Dec 31. We have also made an assessment of daily fresh waste that we will receive in coming months. The number of days from May 14 to Dec 31 is 232, and we will have 190 days left for waste processing after deducting monsoon days and festivals," an MCG official said, adding that the waste processing would be carried out at a rate of 8,610 tonnes per day (TDP).MCG has reported to NGT that the processing of 16.36 lakh MT of legacy waste will result in 3.5 lakh MT of refusederived fuel (RDF), 9 lakh MT of biosoil, 3 lakh MT of inert material and 0.73 lakh MT of construction and demolition waste. The municipal corporation's May 14 affidavit also stated, "Sincere efforts are being made for processing legacy trash, daily waste and leachate accordig to the green tribunal's directions. It is prayed that the directions may be passed to NTPC, NHAI, HAU, NCCBM to collaborate with MCG and to utilise fractions obtained by processing of legacy waste."Despite setting monthly targets for garbage processing in December last year, the municipal corporation fell short of its goals, achieving only 50.7% of waste processing in March, 46.5% in February and 19% in January.

Come June, night out at Gurgaon bar will be a bigger hit on your wallet

Gurgaon. The state's new excise policy for 2024-25 will make drinking at pubs and bars more expensive from June when it will come into effect once the model code of conduct, now in force for the general elections, is lifted.

Among key changes in the policy that will affect bar economics and almost certainly cascade to the customer's wallet are changes both in base licence fee and business hours. Under terms of the new policy, licence fee will more than double for bars that want to do business till 2am. Bar and restaurant owners warned the new

policy would be detrimental to the city's nightlife and dampen mood in the afterhours at leisure hubs that have been increasingly facing competition from Aerocity in Delhi.The new policy increases the basic annual licence fee for bars to Rs 20 lakh from Rs 16 lakh but shortens business hours allowed under it to midnight from 2am. Bars that want to stay open for business till 2am will need to pay additional Rs 20 lakh as licence fee. Effectively, for the same business hours for which they paid Rs 16 lakh in 2023-24, owners have to shell out Rs 40 lakh. The 8am window - which lets bars in

the city stay open through the night - on payment of a special licence fee remains available, but again, at double the current fee. In 2023-24, bar owners who paid Rs 36 lakh (Rs 16 lakh basic fee and Rs 20 lakh additional) for the 8am window will in this fiscal have to pay Rs 70 lakh (Rs 40 lakh till 2am and Rs 5 1 a k h p e r h o u r thereafter). The new policy will come into effect from June 12. Rahul Singh, founder of Beer Cafe and a

member of the National Restaurant Association of India, said a significant portion of the city's population works in the corporate sector and likes to hang out at its different watering holes in the evenings and late evenings. "People come to restaurants and cafes with their families and friends to unwind after long working hours. The reduction in liquor-serving hours and the exorbitant fees for staying open past midnight is not commercially feasible for most restaurants. There are some nightclubs whose business model



operates on different parameters, and they can afford to pay high fees," said Singh.

Singh pointed out that to promote healthy drinking through low-alcohol beverages, excise duty had been reduced on bottled beers, "but it is perplexing why excise duty on draught beer has been increased, considering it is mainly consumed at restaurants and not permitted for retail vends or at BYOB (ahata) establishments". "Delhi increased annual fee for restaurants by 10%, but Gurgaon has increased the licence fee by 25%, which might wean away investment and will impact local employment," said Singh.

Ankur Arora of Impromptu described the new policy fees as "regressive" that "make it difficult for standalone restaurants to survive". He said it will ultimately help ahatas, which have in recent years seen a transformation as snazzy 'BYOBs', pulling in customers who would not go to an ahata. "We pay a huge licence fee, rent and taxes and comply with a number of norms, and we will have to pay a premium for operating after midnight even as ahatas

can operate till early (morning)," said Arora. Another restaurant owner said reduced business hours under the regular licence would put pressure on margins because the establishment costs are high in the city. "Gurgaon has high rental and operating costs for restaurants and bars. A hike in licence fee will make this business unfeasible for standalone restaurants and smaller players," said the restaurant owner, adding big players will eventually

Kamala Harris agrees to debate Donald Trump's vice presidential pick

Washington. Vice President Kamala Harris has accepted an invitation from CBS News to debate former President Donald Trump's vice presidential pick this summer, the Biden campaign said on Thursday, as the Republican said he might wait until his party's convention in July to announce his selection. Harris's team told the network she would debate in-studio on Tuesday, July 23, or Tuesday, August 13, and encouraged the Trump campaign to agree to one of the dates for his eventual vice presidential pick. The Trump campaign didn't immediately comment on the debate invite. Trump, in an interview with TMJ4 taped from New York, said there was "a pretty good chance" he would announce his vice presidential pick at the GOP convention in Milwaukee, which begins on July 15, rather than before."I don't say anything is 100%, but you're getting pretty close," he was quoted saying. "I'll be doing it in Milwaukee. We're going to have a great time."

The announcement comes after President Joe Biden and Trump agreed to two debates this summer to be hosted by CNN on June 27 and ABC on September 10.

The debates are not expected to take place before live audiences- a key demand of the Biden campaign that contributed to its decision to ditch the debates organised by the nonpartisan Commission on Presidential Debates, which had organised every presidential and vice presidential general election debate since 1988.

US teen dies of heart attack after eating ultra-spicy chip in a challenge

World A 14-year-old boy in Massachusetts died of a heart attack after he ate a tortilla chip containing a high concentration of a chemical compound found in chilli peppers. The incident happened last September. However, the cause of the boy's death was determined only on Thursday. According to a report with CNN, the boy, identified as Harris Wolobah, was suffering from a congenital heart defect.In September last year, he attempted Paqui's ultra-spicy "One Chip Challenge" when he ingested the tortilla chip seasoned with both the Carolina Reaper pepper and the Naga Viper pepper.In a statement to CNN, the chief medical examiner's office on Thursday confirmed that Wolobah died of cardiopulmonary arrest after eating a food substance "with (a) high capsaicin concentration."A Paqui spokesperson also told the publication that the challenge was intended only for adults."Paqui's One Chip Challenge was intended for adults only, with clear and prominent labelling highlighting that the product was not for children or anyone sensitive to spicy foods or with underlying health conditions," he said.

Capsaicin is the spicy, naturally occurring chemical in chilli peppers. The Carolina Reaper Pepper ranks just under pepper spray on the Scoville scale, which measures the pungency of peppers and chillis.

The Naga Viper is a bit less pungent, coming in at around 1.2 million heat units on the scale, which is far spicier than a jalapeno pepper, which comes in at about 5,000 heat units, the report said.

British Sikh peer faces Parliament ban for 'bullying, harassment' while drunk

London The UK Parliament's Conduct Committee on Friday released its report into the conduct of British Sikh peer Lord Kulveer Ranger and found him in breach of the Code of Conduct on bullying and harassment following a drunken incident in the House of Lords.

The 49-year-old Parliamentarian, who has apologised for his conduct, will be suspended for three weeks and also be banned from access to the bars in Parliament for a period of 12 months after the committee said it was "struck by the seriousness of the incident". The report entitled 'The conduct of Lord Ranger of Northwood' goes on to detail how two complainants, both members of the Parliamentary community, were accosted with inappropriate comments and invasion of their personal space in a way they found threatening. Their report will now be tabled before the Lords to agree its findings of the sanction after the House reconvenes early next month."We recommend that Lord Ranger of Northwood be suspended from the service of the House for three weeks," concludes the report by the crossparty Conduct Committee."We further recommend that Lord Ranger of Northwood be denied access to bars in the House of Lords for a period of 12 months, and that in other Lords catering venues that serve both alcohol and food, he be denied service of alcohol for the same period. We invite the Commons authorities to consider whether a similar response would be appropriate with regard to the facilities administered by that House," it notes. The committee's report follows findings by the House of Lords Commissioner for Standards, Martin Jelley, who concluded Ranger had breached paragraph 19 of the Code of Conduct applying to bullying and harassment.

He, however, recommended a shorter one-week suspension taking Lord Ranger's apology and "out of character" nature of the conduct into account, which the committee felt was not sufficient given the "aggravating factors" of Ranger's alcohol intake and the power imbalance between him and the complainants."I am deeply mortified at the descriptions of my behaviour. I must say I have little recollection of the incident but that is in no way to diminish how you both have described my actions or how they made you feel," reads Ranger's letter of "sincere" apology to the complainants, also published alongside the committee's report."Throughout my life I have never seen it fit to behave in an aggressive or rude manner. I can only add that I have had a variety of very concerning health issues for both my children and wife during December and January that have been very stressful and taken a significant toll on my physical capacity and mental health, and may have had some bearing on my wholly uncharacteristic outburst and responses to your questions, for which again I am extremely sorry," he adds. The committee said Ranger did not appeal against either the commissioner's findings or the recommended sanction and instead wrote a further letter of apology to the Conduct Committee, enclosing two character references

Israel makes advances in Gaza's Jabalia, Hamas attacks tanks in Rafah

Cairo Israeli forces battled Hamas fighters in the narrow alleyways of Jabalia in northern Gaza on Friday in some of the fiercest engagements since they returned to the area a week ago, while in the south militants attacked tanks massing around RafahResidents said Israeli armour had thrust as far as the market at the heart of Jabalia, the largest of Gaza's eight historic refugee camps, and that bulldozers were demolishing homes and shops in the path of the advance."Tanks and planes are wiping out residential districts and markets, shops, restaurants, everything. It is all happening before the one-eyed world," Ayman Rajab, a resident of western Jabalia, said via a chat app. Israel had said its forces cleared Jabalia months earlier in the Gaza war, triggered by the deadly Hamas-led attacks on southern Israel on October 7, 2023, but said last week it was returning to prevent Islamist militants re-grouping there. In southern Gaza bordering Egypt, thick smoke rose over Rafah, where an escalating Israeli assault has sent hundreds of thousands of people fleeing from what was one of the few remaining places of refuge"People are terrified, and they're trying to get

away," Jens Laerke, UN humanitarian office spokesperson, said in Geneva, adding that most were following orders to move north towards the coast but that there were no safe routes or destinations. As the fighting raged, the US military said trucks started moving aid ashore from a temporary pier, the first to reach the besieged enclave by sea in weekThe World Food Programme, which expects food, water, shelter and medical supplies to arrive through the floating dock, said the aid was transported to its warehouses in Deir Al Balah in central Gaza and told partners it was ready for distribution. The UN earlier reiterated that truck convoys by land -- disrupted this month by the assault on Rafah -- were still the most efficient way of getting aid in.
"To stave off the horrors of famine, we must use the fastest and most obvious route to reach the people of Gaza, and for that, we need access by land now," deputy UN spokesperson Farhan Haq said.

US aid was arriving in Cyprus for delivery to Gaza via the new pier, Washington said. Hamas demanded an end to Israel's siege and accused Washington of complicity



with an Israeli policy of "starvation and blockade".The White House said US national security adviser Jake Sullivan would visit Israel on Sunday and stress the need for a targeted offensive against Hamas militants rather than a full-scale assault on Rafah.A group of US medical workers left the Gaza Strip after getting stuck at the hospital where they were providing care, the White House said. **HUMANITARIAN FEARS**

The Israel Defense Forces (IDF) said troops killed more than 60 militants in Jabalia in recent days and located a weapons warehouse in a "divisional-level offensive". A divisional operation would typically involve several brigades of

thousands of troops each, making it one of the biggest of the war."The 7th Brigade's fire control centre directed dozens of airstrikes, eliminated terrorists and destroyed terrorist infrastructure," the IDF said. 4 Indians among 6 indicted for staging robberies in US to obtain U-visas

Washington Six individuals, including four Indian nationals, were on Friday indicated by a federal court for staging armed robberies in Chicago and the suburbs so that the victims could apply for immigration visas reserved for certain crime victims in the United

According to an indictment unsealed in federal court in Chicago, the four individuals Bhikhabhai Patel, Nilesh Patel, Ravinaben Patel and Rajni Kumar Patel, arranged with Parth Nayi and Kewong Young to be "victims" of the staged robberies so that they could submit applications for U nonimmigrant status ("U-visa")

U-Visa is set aside for victims of certain crimes who have suffered mental or physical abuse and is helpful to law enforcement or government officials in an investigation or prosecution. The indictment alleges that the four



individuals paid Nayi thousands of dollars to participate in the scam.

During the staged robberies, individuals acting as robbers brandished what appeared to be firearms, approached the purported victims and demanded money and property, the indictment states. Afterwards, some of the purported victims submitted forms to local law enforcement to obtain certification that they were victims of a qualifying crime and had been or

would be helpful in the investigation, the indictment states. Upon receiving certification, some of the purported victims then submitted fraudulent U-visa applications to US Citizenship and Immigration Services predicated upon their alleged status as a robbery victim, the Department of Justice said in a the Department of Justice said in a statement.Nayi, 26, Young, 31, Bhikhabhai Patel, 51, Nilesh Patel, 32, Ravinaben Patel, 23, and Rajnikumar Patel, 32, are charged with

conspiracy to commit visa fraud. Ravinaben Patel is also charged with an

individual count of making a false statement in a visa application.
The conspiracy charge is punishable by a

maximum sentence of five years in federal prison, while the false statement charge against Ravinaben Patel is punishable by up to ten years, the media release said.

Boeing whistleblower John Barnett died by suicide, note read 'I'm at peace'

Boeing whistleblower John Barnett took his own life, police said on Friday, after concluding their investigation into the case. Barnett, who worked as a former manager at the aerospace manufacturing firm, was found dead in his truck in March following several days of depositions in

The 62-year-old's death was discovered after he failed to appear for his second day of depositions in a lawsuit against Boeing. His lawyers called for a wellness check, and Barnett was found with a gunshot wound to his left temple. He had a pistol in his right hand, and police said that the injuries were self-inflicted. Investigators also found a single shell casing in the truck and a suicide note on the passenger seat. The coroner's report, which has been released, has confirmed suicide. "All findings were consistent with a self-inflicted gunshot wound," Fox News reported, quoting the report from Charleston County Coroner Bobbi Jo O'Neal.Furthermore, the contents of the suicide note have been revealed, in which John Barnett wrote, "I can't do this any longer. Enough."

He also wrote, "F*** Boeing" and a "I love you all"



Nice for them': White House jokes about Putin, Xi Jinping exchanging hug

- Speaking about Russian **President Vladimir Putin** and his Chinese counterpart Xi Jinping's meeting that saw the two exchange a hug, **US National Security Council** spokesman John Kirby joked and said, "Well, that's nice for them."

The White House said Friday that it had not seen any surprising advance in relations between China and Russia despite Vladimir Putin exchanging a hug with Xi Jinping on a visit to Beijing."Exchanging hugs? Well, that's nice for them," National Security Council spokesman John Kirby told a briefing when asked about the significance of photos showing the two



US adversaries locked in an embrace."I'm not good at talking about personal human bodily affection one way or the other. I think I'll leave it to these two gents to talk about why they thought it was good to hug one another," said Kirby, a naval admiral

from the podium. The United States has repeatedly voiced concerns about Chinese companies supplying Russia with technology for its invasion of Ukraine.But Kirby said Putin's visit did not seem to have secured any major advances in this regard and Washington had not seen Xi "rush" to assist Moscow's armed forces."We didn't see anything coming out of this meeting that we were necessarily surprised by," he said.But he added that "I wouldn't go so far as to say we weren't concerned about this relationship and where

it's going. "We're watching."Putin arrived Thursday on his first trip abroad since his March re-election, meeting Xi for talks in which the leaders framed their nations' ties as a stabilising force in a chaotic world.

Authorities said they have authenticated the handwriting as that of John Barnett's because only his fingerprints were found on the notebook. Police also said that the Boeing whistleblower was locked inside his truck alone when they found him, along with the key fob. They didn't find any sign of unusual travel patterns or communications in his phone records, and hotel surveillance video also showed Barnett leaving the place alone before reversing into a car park shortly after. No one came or went from his vehicle until he was discovered dead, Fox News reported. Additionally, police said records showed John Barnett bought the handgun legally in 2000. John Barnett was a longtime Boeing employee and worked as a quality-control manager before he retired in 2017. Later, he shared his concerns with journalists, saying he noticed discarded metal shavings near wiring for the flight controls of Boeing planes that could've cut the wiring and caused a catastrophe.

Volodymyr Zelenskyy expects Russia to intensify offensive in northeast Ukraine

Kyiv, UPDATED. Ukrainian President Volodymyr Zelenskyy said in an exclusive interview with AFP on Friday he expects Russia to step up its offensive in the northeast and warned Kyiv only has a quarter of the air defences it needs to hold the front line.Russian forces, which have made only moderate advances in recent months, launched a surprise assault in Kharkiv region on May 10 that has resulted in their biggest territorial gains in a year-and-a-half.Zelenskyy said Russian troops managed to advance between five and 10 km along the northeastern border before being stopped by Ukrainian forces, but added that the region could be the "first wave" in a wider offensive."I won't say it's a great success (for Russia) but we have to be sober and understand that they are going deeper into our territory," he said, speaking from Kyiv in his first interview with foreign media since the offensive began. Zelenskyy said the situation in Kharkiv region has been "controlled" but "not stabilised".He doubled down on pleas to allies to send more air defence and fighter jets to combat Russia's air superiority as the war grinds through its third year."Today, we have about 25 per cent of what we need to



defend Ukraine. I'm talking about air defence," he said. Ukraine needs "120 to 130" F-16 fighter jets or other advanced aircraft to achieve air "parity" with Russia, Zelenskyy said.Kharkiv offensiveRussian President Vladimir Putin said during a trip to China this week the northeastern offensive was in retaliation for Ukraine's shelling of border regions and that Moscow was trying to create a "security zone".Russian

forces have taken 278 square km between May 9 and 15, their biggest gains since the end of 2022, AFP calculated using data from the Institute for the Study of War (ISW).Both countries said Russian troops are still advancing, while Moscow's defence ministry said its forces have captured 12 villages in the Kharkiv region so farUkraine has evacuated almost 9,000 people from the northeast border area since Russia launched the

Mobilisation law

Putin said there was no intention at this stage to take Kharkiv, Ukraine's second city, about 30 km from the border. More than one million people still live there. The Ukrainian governor of the Kharkiv region, Oleg Synegubov, warned, however, that Russia was gaining ground near Lukyantsi, a village around 20 km northeast of Kharkiv city. Kyiv pulled its troops back from that area this week amid heavy fire and has rushed in reinforcements. Military analysts say the northeastern offensive could aim to further stretch Ukrainian troops and resources, with Russia pressing its manpower and ammunition advantage.

Jkraine army chief Oleksandr Syrsky said Russia was trying to force Ukraine to pull up even more troops from its reserves."We realise that there will be heavy fighting ahead and the enemy is preparing for it," he said.

Clay & glass bottles to replace plastic in Srisailam

Honey-trap victims' accounts being used to move swindled money

Unearthing a startling new pattern in cyber crime, the police have found that scamsters have started using honeytrapping methods to get hold of their victim's bank accounts and transfer the swindled amount through

them. The new modus operandi came to the fore during a probe into the case in which Rs 3.65 lakh was swindled from a Thrissur native. Police had earlier detected that Cambodiabased financial scamsters were behind the operation, which was reported by TNIE. The police had arrested two people -- Mufliq and Vishnu -- in connection with the case.During a subsequent probe, it was found that the swindled cash was transferred

through several bank accounts to throw investigators off the trail. Two bank accounts involved in the transaction were identified and during further probe, it was found that one of them was that of a Keralite.he investigation revealed that the account holder, hailing from Varkala in Thiruvananthapuram, was befriended by a female operative of the cyber crime racket. The woman, suspected to be a Keralite working in the scamming firm based out of Cambodia, sweet-talked the man and used

his bank account to transfer part of the

booty to another account. An officer privy to the probe said Rs 1 lakh was deposited to the Varkala native's account by the woman, who then transferred the whole amount to a third account. "The woman



lured the man into letting her do the transaction via his bank account. He was not part of the racket and knew nothing about their operation. But as his bank account is involved in the crime, he has been arraigned as an accused," said the officer.nother account used for transactions was found to be that of a Cuddalore native. Police on Friday reached his place to record his statement. However, police sources said they cannot comment on how man's bank account was obtained to circulate the swindled cash.

"We can come to a conclusion only after taking his statement, "said an officer. Earlier, the cyber wing had uncovered the identity of around 50 Keralites, including women, who were working for Cambodiabased operators running online financial

> rackets. It was also found that some of the companies were owned and operated by Chinese nationals, who employ Keralites to target fellow compatriots. Those associated with these firms mostly fell in the 20-30 age bracket and were responsible for collecting details of potential victims, procuring Indian SIM cards, and luring the gullible into investing money in fraudulent schemes. The modus operandi of the scamsters had emerged during the interrogation of 22year-old Mufliq. He was found to have helped the Cambodia-

based handlers access Indian SIM cards. Based on his statement, a mobile shop owner, Vishnu, was arrested for having provided large number of SIMs procured by fraudulent means to Muflig.

TIRUPATTUR: "It gives me immense joy that my daughter, who will be joining Class 6 in the upcoming academic year, has received her ST community certificate. This will help her pursue higher education and secure dormitory facilities," said S Ambika (35), a resident of the Irular colony in Bapanapalli near Vaniyambadi. On Thursday, Collector K Tharpagaraj issued Scheduled Tribe (ST) certificates to six school students from the community, marking a milestone in the nearly 50-year struggle of the residents. For decades, the lack of the document significantly affected the 25 families, comprising 64 residents, from the colony. They were denied housing and other basic amenities by the civic bodies and it further affected their children's education. On December 18, 2023, TNIE highlighted this issue, detailing the community's long-standing difficulties on the same. Meanwhile, an official release stated, the collector issued free pattas to



nine families in Chinnapallikuppam near Ambur. Tharpagaraj told TNIE that these families would receive free houses under the Pradhan Mantri Awas Yojana or PM's Janman Scheme. He outlined the plans to organise a camp with the revenue divisional officer and tahsildar to ensure that all the Irular residents received their community certificates and government welfare benefits. Karnataka has enough coal to operate its thermal plants

BENGALURU: The State government is stocking up on coal at thermal power plants so they run to full capacity and there are no power cuts. As on May 13, state-run thermal power stations had a stock of 8,51,275 tonnes of coal, and according to Karnataka Power Corporation Limited (KPCL) officials, this is sufficient for the next 15-18 days. Apart from this, 2,00,813 tonnes of coal is available at Udupi Power Corporation Limited (UPCL) which is managed by the Adani Group."We are in a comfortable situation. We are also getting imported coal which is blended with coal generated in other Indian coal mines. A total of 28 rakes are

expected to arrive in the coming days. The government wants to ensure there are no power cuts, hence all thrust is on thermal at the moment. Besides, renewable energy is not a completely reliable energy source," said an official from the energy department, not wanting to be named. The official explained that at the moment, the state is generating 967MW of solar and 610MW of wind energy. The total power generated from nonconventional sources is 1,718MW, including minihydro and biomass. "When there is cloud cover, like nowadays, there is zero solar generation in some places. Wind is also not constant. All organisations that run on solar energy during the day need equal or more thermal energy post sunset, like the airport. Also, hydro power generation is very limited at the moment because of the drought," the official said.



According to KPCL, hydro generation is 790MW. The total thermal generation is 2,056MW from Raichur, Ballari and Yeramarus thermal power stations. There is an additional 888MW from IPP-thermal power plants. The power generation from state sources as on May 17, is 3,825MW. "To meet net zero emission target and the Paris Agreement, there is a need to reduce coal-based power generation. But at moments like these, there is no option. It is the only reliable backup source of power.

It's time to 'belong', not just 'fit in'

Bengluru. It is not hard to notice that Karnataka is the microcosm of India. The diversity in terms of religions, castes (and sub-castes), languages and the racial mix gives the state a character which reflects that of the whole

But such a diversity poses a challenge to make some segments 'belong' to the whole rather than merely 'fit in' to display that diversity. Throw in a hefty dose of political agendalinked hollow narratives — as we are witnessing with the ongoing electoral process — and that very diversity threatens to be compromised. Deep fissures appear in

society. Each segment in this diverse mix seems to be merely 'fitting in' to make the whole rather than 'belong' within the society. Terms like 'minority', 'majority', 'upper caste', 'lower caste' and such — which are potential vote banks for the politicos become words spelling division, bringing the proud "unity in diversity" tag line under a cloud. This goes against the human need to 'belong'. The 'othering' and the "us-andthem" narratives are seeded in these.

Erich Fromm, the German-American social psychologist, psychoanalyst and sociologist, in his famous work Escape From Freedom, writes, "Religion and nationalism, as well as any custom and any belief, however absurd and degrading, if it only connects the individual with others, are refuges from what man most dreads: isolation.'

The 19th century French novelist and playwright, Honore de Balzac, states in The Inventor's Suffering: "...man has a horror for aloneness. And of all kinds of aloneness, moral aloneness is the most terrible....The first thought of man, be he a leper or a prisoner, a sinner or an invalid, is to have a companion (or companions) of his fate. In order to satisfy this drive...he applies all his strength, all his power, the energy of his whole life..."One might instantly point out that whatsoever the divisions, we do belong to some segment or the other. But belonging has various levels, mainly categorised into intimate, personal, social and public. As no human is completely isolated by society, like a marooned creature, it is assumed that the intimate and the personal side of 'belonging' is a given. It is the latter two (social and public belonging) that gain importance for groups and communities. They can't just exhibit a sense of belonging by only 'fitting in' to display a whole, they actually must get that sense of 'belonging' to the society, the state and the nation.Brené Brown, researcher and storyteller who studied courage, vulnerability, shame and empathy, accurately explains the difference between 'fitting in' and 'belonging'. In her book, Daring Greatly: How the Courage to Be Vulnerable Transforms the Way We Live, Love, Parent, and Lead, she explains, "...fitting in and belonging are not the same thing. In fact, fitting in is one of the greatest barriers to belonging. Fitting in is about assessing a situation and becoming who you need to be in order to be accepted.

All is not bright on the BJP front

THE Bombay Stock Exchange (BSE) and the more recently established National Stock Exchange (NSE) have spoken. The BSE's Sensex, which began teetering after the first round of the Lok Sabha elections, fell with a bang by a thousand points after the third phase! Sensex and the BSE's Nifty are fairly reliable guides to political situations.In 2014, the market was anxiously awaiting the arrival of a right-wing government. Speculators had predicted a victory for the BJP. The party's performance in the polls was even better than what the optimists had visualised. Sensex took off at a very fast clip initially and then settled down to a steadier pace till it reached astronomical heights recently when Modi declared that he was aiming for 400 Lok Sabha seats. The share market is the biggest single gambling den in my city. Of course, gambling on stocks is perfectly legal, though very risky all the same. The operators are not going to venture in without their dollop of khabar. Since their money is at stake, the gems of information that Dalal Street operators collect are more authentic than what normal rumour mills produce.

The steep drop in the prices of shares like those of Reliance Industries, HDFC Bank, L&T and TCS, all market leaders, is nothing but ominous. The market feels that the Modi-Shah duo is in trouble. I suspect (kindly note that my suspicion is just that - a suspicion) that the voting trends must have been garnered from the foot soldiers serving the army of 'exit' pollsters. They have been debarred by the Election Commission of India (ECI) from publicising their findings till the last vote is punched in on the last day of the month-and-ahalf-long battle. The BJP's inability to enthuse voters this time has been doing the rounds on the streets of our cities and towns. That there is no 'wave' is also apparent. The use of unfair, ungentlemanly tactics like imprisoning a leader of a national party at election time is another clear indication of the nervousness that has taken hold. Even the spectacular inauguration of the Ram Mandir at Ayodhya did not help, as we now note with the benefit of hindsight.

To add what we desis call masala to the narrative, one of the first accusations Arvind Kejriwal made on being released on bail to canvas for INDIA candidates was that Narendra Modi would step down at the age of 75 in September next year and that he would be succeeded by Amit Shah as the Prime Minister. This possibility, which incidentally the common man had already predicted, ruffled the feathers of BJP bigwigs Four of them — Shah himself, Rajnath Singh, Nirmala Sitharaman and JP Nadda — protested vociferously. They asserted that Modi would serve his full term of five years.

By doing so, they confirmed two hypotheses that would often be debated in parlours and marketplaces and set our doubts at rest. The first was that Modi's diktat that leaders should retire at 75 applies only to his colleagues, not to him. The second, more relevant to us citizens, is that Shah is not the people's choice or even the BJP's rank and file's choice for the top job. The very mention of that possibility by a sworn enemy (Kejriwal) set the alarm bells ringing. Kejriwal is set to return to Tihar jail on June 2. Before that date, he should draw some more rabbits out of his AAP hat in order to elicit some more truths from the BJP's top brass. When Kejriwal was released on bail by the Supreme Court, a BJP leader even suggested that the honourable judges were taking sides in the ongoing Lok Sabha elections. That inference was in very poor taste. The judges explained in detail why they had decided as they did. What the judges refrained from saying, but was probably on their minds, was that it was the Enforcement Directorate (ED) which was taking sides in the elections by waiting for nearly two years to arrest the leader of an up-and-coming party like AAP. The ED had issued summons to Kejriwal nine times before the arrest. It could have applied the guillotine after the third summons was dishonoured. But, no, the ED obviously had a grander design. By releasing Kejriwal for the period of the elections, the judges have righted a wrong that the ED had perpetrated and provided a level playing field for the electoral game. The decision restored the people's faith in the impartiality of the judiciary which, unfortunately, was under question at times of late.

WITH the conclusion of the fourth phase of the Lok Sabha elections on May 13, the electoral fate of contestants from 379 of the 543 seats seeking election to the highest forum of Indian democracy is sealed in ballot boxes. The election, seen as transformative of the nation's political landscape, is

witnessing a spirited pushback to the Modi regime from the INDIA bloc, even as the ruling dispensation led by the PM has had a clear head start in scripting its campaign

The Opposition's counter narrative, focused on the defence of constitutional democracy and its concomitant values, is premised on the authoritarian impulses of a muscular state that negate the first principles of liberal democracy and accountability of power encased in the nation's republican charter. The unprecedented arrests across India of the ruling regime's key political adversaries, a demonstrable decline of constitutional institutions, a captive bureaucracy and a generally obsequious media, are cited in support. Ensuring a national resonance for its inspirational

narrative is the principal challenge for the Opposition.Regrettably, the diminishing and debilitating tone of a cacophonic campaign on both sides seems to have drowned out the real issues, with abuse and calumny substituting for reason and contestation. The perversion of democratic discourse helmed by leaders unable to rise above themselves attests to a flailing democracy. The pursuit of power for its appellations alone, with scant regard for its ends and a cynical deriding of political idealism as a utopian dream to be argued out of consciousness, presents the electoral exercise as clothing the pursuit of personal ambitions with a semblance of democratic legitimacy. If indeed the BJP and the Opposition consider this election a watershed moment that will determine the future of the country, they must continue to focus public attention on core national issues. The INDIA bloc, speaking in multiple voices, cannot forget "the plain lesson of history, that the wants of men will only

secure recognition to the point that they are forcibly articulate...," as Harold Laski put it. The power of a clear statement is critical for the success of the Opposition's campaign. Apart from an unrelenting focus on its core campaign theme, communicated and made intelligible to each voter, the alliance



cannot shirk the critical question of an alternative leadership of the nation. The Congress, as the principal Opposition party, has advisedly chosen not to formally present its chief campaigner, Rahul Gandhi, as the prime ministerial candidate. Whatever the limitations and logic of the situation, the question of leadership will be critical to the outcome of the campaign, flawed comparisons with the past notwithstanding. As a necessary condition of revitalising itself to serve as the fulcrum of Opposition unity, the grand old party must recognise the distinction between servility and loyalty of its members. Only then can it reclaim the willing allegiance of its alienated cadres. In its internal functioning, it must listen magnanimously to 'the hidden silences'.

Evidently, self-effacing humility and generosity of heart to heal the erasure of conscience are critical attributes of leadership needed for national renewal. The PM, as the chief campaigner and torchbearer of his party's ideology, has demonstrated an

exceptional tenacity of purpose and will to prevail against the combined opposition of 26 parties. He has strategically anchored his party's campaign in an appealing sense of national glory, hope for the people in their future and emotional sensitivities, and he may well win a third consecutive term in

> office. But he would, in his wisdom, know that the ideas of justice, dignity and freedom outlive the seduction of power. As the leader of a nation defined by its diversity, he must accept that his primary obligation is to nurture a unifying politics to sustain national unity and bridge the myriad socio-political divides. Electoral victory must mean more than an arithmetical majority.Irrespective of who forms the government, victory must belong to those whose politics and votes sustain and strengthen a democracy founded on justice and human dignity, in which all of us can hold our heads high as empowered citizens of an enlightened nation that aspires to be the vishwaguru.

In this aspirational view of our common future, there is no scope for narrowness of mind, wilfulness or

transient responses to political exigencies at the cost of the nation's foundational principles. In this moment of test, those who stand on the side of freedom will find themselves on the right side of history. This election, seen as a historic milestone in the life of the nation, will test our collective wisdom on how we establish justice as the first virtue of social and political institutions and the basis of a just state. The election is about reinforcing the liberties of equal citizenship and ensuring that the power sought in the name of the people is used in furtherance of their inherent rights. It will define the land and its people, who alone must mediate their future, remembering that the inviolability of freedom depends on the moral courage, fearlessness and magnanimity of its defenders. This election cannot be about one's victimhood. It must instead heal the deepening fissures in our social fabric so that we can claim that Indian democracy is not a beguiling dream.

Why aren't district courts and high courts doing their job of providing legal redress in cases of personal liberty

IN the film world, we are used to the phenomenon of delayed releases. It seems to be so in the judicial world as well. Arvind Kejriwal has been released after 50 days in captivity, all during peak election campaigning. And now the Supreme Court has set at liberty Prabir Purkayastha after he has been inside a prison for about 225 days. While there is relief at the release, one must question why it takes so long, and what kind of laws keep men behind bars so easily.

Purkayastha is the head of NewsClick, an online journalistic platform known for its sharp reporting, independent views and for not being particularly respectful of the powers that be. People like him are irritants to excessively strong governments, which like media outlets to be supportive by nature or bought out otherwise. How dare he focus on the farmers' agitation, Covid failures and the like! He was charged with a rather unusual offence — of accepting funds from Chinese sources to influence the political narrative in India. A bit surprising, since one doesn't remember any pro-Chinese narrative from NewsClick. While one should be wary of China, one would have thought that would extend to preventing border incursions and curbing excessive dependence on imports. But no, Purkayastha is the problem, it seems. An associate turned approver not much to wonder about that since this is happening pretty regularly now, as witnessed in the Kejriwal case. The flaw in the case was a gaping one. Purkayastha and his lawyer were not informed about the grounds for his arrest and the remand order was passed before the lawyer had received the remand application. Now this kind of non-conformity with the law is what lawyers and judges call "going to the root of the matter"; it vitiates the entire proceedings. Notice that this flaw happened on day one. Yet, and this is what should disturb us, it has taken the judicial system more than half a year to release him.

We need to focus on why it is that invariably the accused has to travel all the way to the apex court to obtain release. Why aren't district courts and high courts doing their job of providing legal redress in cases of personal liberty? While the members of

the former may not feel sufficiently protected, HC judges have as much constitutional protection for their independence as the judges of the Supreme Court have. What prevents them from stepping up to the plate, especially when the facts are stark enough? The system works well when each level of the judiciary plays its part, and an overdependence on the highest court is not healthy. Even there, we have seen the unusual phenomenon of withdrawal of personal liberty cases of prominent individuals after a noticeable change of the roster. One cannot blame our judges overmuch, however. The chief problem is the monstrous nature of the laws under which these detentions are made. These are the Unlawful Activities Prevention Act (UAPA), 1967, and the Prevention of Money Laundering Act (PMLA), 2002. Purkayastha, Sudha Bharadwaj, Gautam Navlakha, the late Father Stan Swamy and other Bhima Koregaon accused were held under the first, and Kejriwal, Hemant Soren, K Kavitha,

Manish Sisodia and other politicians under the latter. These Acts and later amendments — and here both the BJP and Congress governments are to blame make it virtually impossible to get bail, mandating that the judge first find that the accused is prima facie innocent; this is an inversion of the time-honoured principle of presumption of innocence. This principle is the first rule of civilised societies, and any departure from it, unless justified by extreme risk to society, is an indication that the rule of law has

become a casualty to politics. There are other damaging provisions — the authorities can arrest without much cause; the normal criminal law restrictions on the police are absent; confessions obtained in custody are valid. Above all, there is the



application of this draconian statute to ordinary offences. Even the dreaded Maintenance of Internal Secuddrity Act (MISA), 1976, had an advisory board of high court judges to review detentions during the Emergency; it is noteworthy that the laws in question have no such provision in free India. The sad part of the story is that the SC has upheld the validity of these laws — lock, stock and barrel — for the State and against citizens. A blot on our judicial landscape is the judgment of Justice AM Khanwilkar in the VM Choudhary case, equalling the constitutional and public damage that was done in that infamous judgment (ADM Jabalpur vs Shivkant Shukla, 1976) where it was held four to one (the great Justice HR Khanna dissented) that with the proclamation of the Emergency and suspension of fundamental rights,

citizens were at the mercy of the State. The SC has admitted a review of the Choudhary judgment, but this is another priority case languishing without a hearing. Of cheer today, however, is the judgment of Justices Abhay S Oka and Ujjal Bhuyan, curbing the ED's power to arrest after the special court takes cognisance of a complaint. Purkayastha's long detention is particularly disturbing because courts worldwide are usually quick to examine cases of journalists being held in preventive custody. The judiciary and a free press are pillars of democracy, and the courts must be more vigilant in checking overbearing governments of whichever hue which threaten their members. But recent detentions have lasted long — journalist Siddique Kappan, for example. In contrast, Arnab Goswami (albeit not arrested under these laws) got doublequick release; these are not good messages to

he record of the authorities in proving guilt and securing convictions under these laws is abysmal as low as 3 per cent. This means that citizens were being held despite being innocent, and often without reasonable cause. When will our laws and courts start thinking about compensation for unjust imprisonment and deprival of liberty? And when will we teach officers of such agencies and their political masters that they do not have immunity for mala fide and wantonly wrongful acts? Is the arm of the law sufficiently long?

Indian students in Kyrgyzstan asked to stay indoors after mob violence

Saturday advised students in Bishkek "to stay indoors" amid mob violence targeting international students erupted in Kyrgyzstan's capital city. While the Embassy of India in Kyrgyzstan said the "situation is presently calm", Pakistan's mission said a few hostels of medical universities in Bishkek, where students from India, Bangladesh and Pakistan reside, have been attacked amid the violence.

"We are in touch with our students. The situation is presently calm, but students are advised to stay indoors for the moment and get in touch with the Embassy in case of any issue. Our 24—7 contact number is 0555710041," the Indian mission in Bishkek tweeted. According to data from the Ministry of External Affairs, some 14,500 Indian students reside in Kyrgyzstan.External Affairs Minister S Jaishankar retweeted the Embassy post, and said, "Monitoring the welfare of Indian students in Bishkek. Situation is reportedly calm now."

New Delhi: India, as well as Pakistan, on In its advisory posted on social media, Pakistan's Embassy in Bishkek said that the matter escalated after videos of a fight between Kyrgyz and Egyptian students on May 13 went viral online on Friday."A few hostels of medical universities in Bishkek and private residences of international students, including Pakistanis, have been attacked. The hostels are inhabited by students from India, Pakistan and Bangladesh," it said."There have been reports of light injuries to a number of students from Pakistan. Despite social media posts about the alleged death and rape of Pakistani students, so far, we have not received any confirmed reports."The Embassy further said that Pakistani students have been asked to "stay indoors until the situation returns to normal", adding that the violence appeared to be directed against all foreign students, and not just Pakistanis. There are about 10,000 Pakistani students in te Central Asian nation currently. Meanwhile, Pakistan's Ambassador to



Kyrgyzstan, Hasan Zaigham said authorities Pakistan Prime Minister Shehbaz Sharif has Bishkek to ensure the safety of students.

Indian students, hiding in a Bishkek cafe, seek embassy's help

New Delhi: As a mob went on a rampage in Kyrgyzstan, attacking international students, a video went viral on X showing a group of Indian students contacting presumably an Indian Embassy employee, seeking help.In the video, the student says he, along with other youngsters, were hiding in a cafe in Bishkek. He could be heard asking the staffer about the steps being taken by the government to protect the Indian students. To this, the alleged staffer says "nothing can be done in the middle of the night."

Reportedly, there have been several incidents of mob violence against foreign students in Bishkek since last evening, the Pakistan Embassy in Kyrgyzstan said in a social media post. Swati Maliwal's medical report after 'assault' reveals bruises on face, leg

New Delhi: A medical report of Aam Aadmi Party (AAP) MP Swati Maliwal has revealed bruises on her face and leg after she was allegedly assaulted by Arvind Kejriwal's aide Bibhav Kumar at the Chief Minister's residence on May 13. As per the report by the Jai Prakash Narayan Apex Trauma Centre at AIIMS, Delhi, Maliwal sustained injuries to four parts of her body, including her left leg and below the right eye. The test was Maliwal was conducted on Thursday and the report was published the following day. According to her medico-legal certificate (MLC), the AAP MP has "bruises over proximal left leg dorsal aspect of approx size 3x2 cm and right cheek elbow below right eye of approx size 2x2 cm". It also stated that according to the "history provided by the patient" of being assaulted by Bibhav Kumar at the Chief Minister's residence, she was "slapped multiple times", and "hit her head on a sharp object after she was pushed" by the accused.

She fell on the floor and after that, she was hit multiple times by legs on her chest, abdomen and pelvis. (The) patient at present is complaining of pain over thighs, pelvis, neck stiffness and headache," it added. However, the report did not state the nature of the injury. In her complaint to the Delhi Police against Bibhav Kumar, Maliwal claimed that Chief Minister's aide slapped her, beat her with sticks, hit her in the stomach, and physically assaulted her.

Based on the complaint, the police registered an FIR against Kumar on Thursday.No formal complaint was filed when the former head of the Delhi Commission for Women (DCW) had first alleged on Monday that Bibhav Kumar assaulted" her at the Chief Minister's official residence.A day after the charges, AAP confirmed the allegations and stated that Kejriwal has directed stern action to be taken in the matter.In the early hours of Saturday, a Delhi Police team left Kejriwal's residence afteEarlier on Friday, Maliwal was taken to the residence to recreate the crime scene. She was accompanied by a team from the Forensic Science Laboratory (FSL), as well as Delhi Police

Meanwhile, Bibhav Kumar has filed a counter-complaint against Maliwal, saying that she was "trying to falsely implicate" him in an effort to "create undue pressure". He claimed that she tried to "create a ruckus and assault" him as she "forcefully and unauthorisedly" entered the Delhi Chief Minister's residence. Asking the police to take strict action as per law, he alleged that "all of this may have been done at the behest of the BJP" as the Lok Sabha polls are ongoing."It is therefore requested that her call records, chats and interactions with BJP leaders should also be investigated."

In 10 Years, India Adds 31,000-Km Rail Network - Equal To All Of Germany

New Delhi: Union Minister for Railways, Communications and IT Ashwini Vaishnaw has reeled out data to showcase transformative changes in the Indian Railways in the past 10 years of the Modi government while also highlighting its neglect during Congress-led

- Speak about your career vision. When you know how the job fits in the grand picture of your career, the interviewer is most likely to choose you because it creates certainty.



The multitude and variety of tasks can become overwhelming; many employees are unable to handle the stress and face a dip in their productivity . Prioritization skills become a handy tool in such cases and allow professionals to plan their day in a manner that not only creates value, but creates the right value.

Why is prioritizing of workload necessary at all? Abhijit Nimgaonkar, India capability & expertise centre head and office managing principal (Delhi), ZS, answers, "The classic situation faced by employees today is simultaneous urgent requests from multiple stakeholders. In the context of a global marketplace (different time zones), increasing compensation (higher expectations), many communication channels (request reach and immediacy), prioritising daily, weekly, monthly tasks is key to effective responsibility management. Working faster is not the solution; instead, working on the right tasks is essential."



A broad categorization of all tasks is essential to bring prioritization in motion. Srinivas Ghanagam, head HR, Freudenberg India, explains, "Being able to distinguish between 'urgent' and important' tasks is one of the best known ways of dealing with a flood of emails, projects and presentations, the former being less critical than the latter. The focus should, therefore, be placed on 'important' work, which is usually more strategic in nature; losing focus of the same can be the undoing of an up and coming executive." Manuel D'Souza, director - HR, Serco Global Services, tells us how such measures also allow work-life balance, "Time spent on planning activities saves sufficient time in execution. On a regular basis, prioritizing not only makes a person more efficient at daily work-related activities, but also gives them the latitude to focus on their personal goals. It helps strike the right balance to handle both, their professional and personal life."

How can one's prioritization skills be honed? Rajiv Naithani, associate VP HR and L&D, GlobalLogic, gives suggestions:

- Make a work list:

You probably can't get to everything on your list. Focus on the priorities that you know you must and can complete

Mehul Shah, MD, Collabera, describes the Pareto principle in the context of prioritization of workload, "The Pareto principle states that of the things you do during your day, only 20 per cent produce 80 per cent of your results. It emphasizes on putting more energy in prioritizing your tasks in the first hour at work and focus on the 20 per cent that matters. When the fire drills of the day begin to sap your time and something in the schedule has to slip, make sure it's not part of that 20 per cent."

Prioritization also enables employees to maintain clarity on the ultimate goals of the organization. Sailesh Shetty, VP human resources & services, Toyota Kirloskar Motor, explains, "Organisations should make every employee understand the role he or she is playing in solving the issues important for the organisation. Employees should have clarity on what is expected from them; this enables them to prioritise better. When the employer engages employees every day in analysing and solving problems, they feel highly motivated."

Thus, prioritisation can make a lot of difference in employee efficiency and productivity.

An INDIA alliance victory will lead to de-rating of markets: Brokerage report

NEW DELHI.If Congress-led INDIA alliance comes to power, it will lead to de-rating in markets and in specific sectors such as defence, capital goods, tourism, PSU's (including banks), drones, AMC, wires and cables, plastic pipes and EMS, said brokerage firm Prabhudas Lilladher in its 'India Strategy Report – Mandate 2024, Brace of Volatility' report on Friday.

The report comes as India completes the 4th phase of what it calls the most 'hotly contested Lok Sabha elections in its history'. It added that the narrative of NDA falling short of a majority or INDIA alliance coming to power is raising their head, at least in social media and global press. Most brokerages and opinion polls, however, still feel a win for the Prime Minister Narendra Modi-led BJP.Markets have been nervous for the past couple of weeks and sustained volatility in the run-up to June 4 seems likely. Fear around a repeat of UPA victory in 2004 is making markets nervous as the unexpected event had resulted in a 15% decline in Sensex in a single day. Owing to low voter turnout, the market experienced a major correction last week with the benchmarks (BSE Sensex and NSE Nifty) plummeting 2% each. The bloodbath was more visible in the midcap and small-cap stocks.

The market, however, made a quick recovery this week as low inflation data in the US raised chances of at least two rate cuts by the Federal Reserve in 2024, a big positive for the market. Sensex gained 2.7% this week to close the Friday session at 73,917 while Nifty settled 2.3% higher at 22,466.

TechM former vice chairman Vineet Nayyar dies

BENGALURU. Former Tech Mahindra vice chairman Vineet Nayyar, 85, passed away on Thursday. A civil servant turned corporate professional; he was one of the doyens of the Indian tech industry. He worked with the World Bank and then went on to serve state-owned energy corporation GAIL as its inaugural chairman and MD.He later joined HCL Corporation as its MD and became vice chairman of HCL Technologies. Anand Mahindra, chairman of Mahindra Group, wrote on X, "Vineet was a larger than life figure in Indian business landscape. A distinguished IAS officer, who served with the World Bank, became the first Chairman of GAIL. He made a successful transition to the private sector becoming MD of HCL and the Vice Chairman of HCL Technologies."

GAIL net profit triples on gas biz turnaround

NEW DELHI. State-owned gas utility GAIL (India) on Thursday reported more than tripling of its fourth quarter net profit as its natural gas transmission and petrochemical business saw a turnaround.

Its standalone net profit of Rs 2,176.97 crore in the fourth quarter of 2023-24 - was 261% more than Rs 603.52 crore net profit in the same period last year, according to stock exchange filing by the company.

The net profit was, however, 26 per cent lower than Rs 2,842.62 crore earning in the preceding quarter of October-December. The year-on-year rise in profit was aided by a turnaround in the natural gas transmission



and petrochemicals business and an uptick in gas marketing. Against a loss of Rs 16.41 crore in the gas transmission business in January-March 2023, India's largest gas transportation and marketing firm booked a pre-tax profit of Rs 980 crore.

NEW DELHI. Benchmark Indian equity markets, both BSE Sensex and NSE Nifty, will remain closed on Monday, May 20, on account of Lok Sabha general elections. According to the BSE's website, equity, equity derivates, and SLB and currency segments will remain closed on Monday. The market will now be opened on Tuesday, May 21.

double by 2031, coupled with an increase in consumption expenditure and a consistent uptrend in financial services spending, India is positioned to maintain its status as the world's fastest-growing economy in the years ahead. She stressed that India looks at the private sector as a partner in the development of India. Meanwhile she also said the full budget for FY25 will be announced in July 2024 when the new government will be formed. As per Sitharaman, the opportunity provided by India's demographic dividend spans the next 30 years.India's shift towards green energy and a sustainable economy is poised to create a fresh market and global demand. Referring to a 2021 World Economic Forum report, she highlighted projections of 50 million net new economy jobs emerging in India, along with a \$1 trillion economic impact by 2030.In addition, Arvind Panagariya, Chairman of the 16th Finance Commission, said if India

sustains the growth trend seen over the past two decades, it can rank as the world's third-largest economy by 2027-28. Recommendations on OTT communication apps soon

NEW DELHI. The Telecom Regulatory Authority of India (TRAI) is in the process of finalising its recommendations on whether over-the-top (OTT) communication apps like WhatsApp, Telegram, and Signal need to be regulated.

The regulatory body announced an open house discussion in next two to three months over the regulation of OTT communication apps. TRAI chairman Anil Kumar Lahoti, on the sidelines of an event on Friday, dismissed that current OTT paper has become infructuous in the wake of notification of the Telecom Act. The Telecommunication Act 2023 removed the provision of regulation of OTT communication from its final version. "I know, we have an ongoing consultation on OTT communications. It is just that in last few months we are burning the midnight oil, clearing the number of references pending with us, and OTT communication is also in the line," said Lahoti.

In July 2023, TRAI had come up with a consultation paper on the regulatory mechanism for OTT communication services, after the Department of Telecommunications (DoT) asked the agency to reconsider its 2020 recommendations. In its 2020 recommendation, TRAI had proposed no regulation OTT services. In December 2023, telecom minister Ashwini Vaishnaw said OTT players or applications won't be covered under the new telecom bill and will



continue to be regulated by the IT Act of 2000. When asked if the consultation paper was infructuous after enacting the Telecom Act, Lahoti answered in the negative. He said the OTT consultation was initiated after the recommendation of a Parliamentary panel so this consultation will be completed."The OTT consultation was initiated after the recommendation of a Parliamentary panel so this consultation will be completed, and we will give our recommendation... which Act it becomes a part of and which ministry, or which regulator deals with it, is a separate matter," he said. SpiceJet gets relief from paying Rs 270 cr to Maran

managing director Ajay Singh challenging the single judge's July 31, 2023 order. "The appeals stand allowed. Consequently, the July 31, 2023 order (of the single judge) is set aside," the bench said. Following this development, shares of SpiceJet rose as much as 6.5% and closed 5.5% higher at Rs 63 apiece.

The bench had earlier refused to stay the single judge's order and had asked Maran and his company Kal Airways to respond to the appeal. SpiceJet and

during FY24 at Rs 1.75 lakh crore. During the previous financial year (FY24), the company produced highest ever crude steel at 26.43 million tonne,

and sold highest-ever saleable steel at 24.78 million tonne.

Hours of net batting, power hitting irrespective of formats during Andhra camp: Reddy's mantra for success

HYDERABAD. All-rounder Nitish Kumar "He has always been a batting all-Reddy has been a revelation for the Sunrisers Hyderabad this season. The 20-year-old from Andhra turned out to be a vital cog for the 2016 champions in their resurgence. He has played a couple of brilliant knocks to steer the team to safety after the early fall of the wickets on a few occasions. His 37-ball 64 against Punjab Kings and a quickfire 76 off just 42 balls against Rajasthan Royals Reddy's last domestic season with helped the Pat Cummins-led side to win the matches despite being in trouble at the early

Reddy might have rescued SRH with the bat when they were in trouble but he himself was in trouble and in dire need of a quick turnaround when the season started. After making his IPL debut in 2023, where he didn't get the opportunity to bat in two matches he played, his performance with the ball was below par as he leaked 54 runs from five overs he bowled across the two outings. He was fortunate that the Hyderabad franchise decided to retain him but needed to prove his worth. Knowing the situation, Reddy started working on his game at the commencement of the 2023-24 domestic season with Andhra head coach N Nirmal Kumar. The fact that he trained under Kumar for three seasons during his under-19 days rounder. In fact, in his first U-19 season with Andhra, he used to open the batting and bowling. I changed that the next season as I knew India U-19 team has so many specialised opening batters and bowlers. Since then, he has picked up both with the willow and ball," coach Kumar told this daily.

Andhra can be termed satisfactory if not excellent as he played quite a few good innings in both the Ranji Trophy and limited-overs tournaments. Since the early days, Reddy has been a freeflowing batter but the same was not getting translated on the field. Kumar knew that and he decided to give him a free hand no matter which format he was playing."I asked him to play his natural game irrespective of the formats. We

treated him as a specialised batter when it comes to training in the nets in the last season. He used to bat for at least an hour in the nets alongside our pure batters every day. I made him face all kinds of bowlers to give him that confidence and practice," added Kumar.There were areas where Reddy needed to improve. The incoming deliveries from the left-arm spinners were troubling him. Similarly, his downswing speed of the



bat was just not proving enough for the perfect execution of the shots. Kumar, who has been working with various Andhra teams for the last 25 years, found out the flaws and decided to work on them.

"He was stretching a lot while facing the leftarm spinners. The wide gap between two legs meant it was his pad which was coming first so he was getting trapped in front of the wickets. I asked him to reduce the gap between the legs. This change helped him

bring the bat first while defending. Similarly, we worked on his downswing of the bat with the trainer. To get the requisite speed, we asked him to have a backlift so as to get the speed for downswing to execute the shots perfectly."These minor changes did wonders for Reddy as he looked like a different batter this season. In nine matches so far, he has scored 239 runs with an average of 47.80 and a strike rate of 152.22. He has scored two halfcenturies hitting 12 fours and 17 sixes. Kumar credited the hard work his ward did during the camps for the success. "We focussed completely on power hitting during the camps. While others were given the practice according to the formats, instructions to him were clear.

Focus on power hitting and try to be as natural as he can be irrespective of the formats," said the coach.Kumar is happy with Reddy's show so far. "He was quite eager to perform when the IPL started. We spoke on a few occasions but exchange messages quite regularly. After every match, I message him explaining what went well and what areas he needs to improve. For me, it's just the beginning as given his potential, he will only improve from here onwards,"



When Rishi Kapoor Took Dig at Amitabh Bachchan: 'He Has Never Given Due Credit to His Co-actors'



ishi Kapoor, who died in April 2020 after battling cancer, was one of the most brutally honest celebrities in Bollywood. Apart from entertaining the audience with his versatile acting for several decades, he was known for his no-holds-barred attitude. In his memoir 'Khullam Khulla: Rishi Kapoor Uncensored', Rishi candidly spoke about his personal and professional life, from his relationship with wife Neetu Kapoor to his 'lingering issue' with Amitabh Bachchan. The actor had revealed that back in the days, a lot of actors would not prefer to work with Amitabh because "directors and writers unfailingly reserved their strongest, pivotal roles" for him.In his book, Rishi wrote, "I must confess there is still a lingering issue I have with Amitabh Bachchan. A big disadvantage of working in an all-star movie in those days was that everybody only wanted to make action films, which automatically meant that the star who could carry off action with the most flair would get the meatiest part. That's how, with the exception of Kabhi Kabhie, which was a romantic film, none of the multi-starrers I featured in had an author-backed role for me. Directors and writers unfailingly reserved their strongest, pivotal roles for Amitabh Bachchan. And it wasn't just me. Shashi Kapoor, Shatrughan Sinhad, Dharmendra, Vinod Khanna faced it too. He added, "Amitabh is undeniably a superb actor, immensely talented and, at the time, the number one star who ruled the boxoffice. He was an action hero, the angry young man. So roles were written for him. Although we may have been smaller stars, we were not lesser actors. Yet, the rest of us had to constantly measure up to him. We had to work hard, really exert ourselves to match up. In my time, the musical/romantic hero had no place. Amitabh was an action hero in an era of action films. As such, writers gave him the lion's share and he had the authorbacked roles in almost all his
