### Rajkot gaming zone fire: Gujarat Congress demands FIR against senior officials

Ahmedabad, May 27: The Gujarat Congress on Monday demanded that senior civic and state officials, and office-bearers of the ruling BJP be named in the FIR registered in connection with the Rajkot game zone fire that claimed 27 lives. Rajkot gaming zone fire: 6 officials suspended for lapses; Gujarat High Court says it doesn't have faith in state machinery Addressing a press conference, state Congress president Shaktisinh Gohil also asked the government to consider giving "generous" compensation to the kin of those killed saying the majority of the families belong to humble backgrounds. "We also demand generous compensation for the kin of the deceased," he said. So far, the state and Centre have announced a cumulative compensation of Rs 6 lakh for the kin of each deceased. Gohil's statement came soon after the state government ordered the suspension of six officials for "gross negligence in allowing the game zone to operate without necessary approvals". The Congress leader said the action was only taken against some low-ranking officials. There is no meaning in suspending junior-level officers who do not have any powers, he said, demanding that

senior civic and state officials and BJP officebearers be named as accused in the FIR. The senior Congress leader said there was a time when the Union railway minister and civil aviation minister used to resign after major accidents. "In the past, several high-ranking officials, including the Rajkot mayor, collector and municipal commissioner, had visited this place and shared their photographs on social media too. In such a scenario, how can you expect that a junior officer could dare to take action against the game zone management?" asked Gohil. Gohil also shared some photos posted on the Facebook page of the TRP Game Zone, where 27 persons, including four children under the age of 12, were killed in a massive fire on May 25. "In one of the photos taken in 2022, BJP's office-bearers, including former mayor Pradip Day, can be seen at the TRP Arena. In another photograph, former BJP MLA Arvind Raiyani and some other local leaders can be seen at the same place," claimed Gohil. He wondered how the officials failed to notice that such a large recreation complex was being run illegally, particularly when the Gujarat High Court had repeatedly asked the government to ensure compliance with fire safety norms at such places.

## No family member of terrorists, stonepelters will get govt job in J-K: Amit Shah

New Delhi, May 27: Sending a tough message, Union Home Minister Amit Shah has said

that no family member of any terrorist nor close relatives of stonepelters will get government jobs in Jammu and Kashmir. Shah said the Narendra Modi government had not only targeted terrorists but also eliminated the terror ecosystem, resulting in a drastic fall in terror incidents in the country. "In Kashmir, we have taken a decision that if someone joins a terrorist organisation, their family members will not get a government job," he told PTI in an interview over the weekend. Similarly, Shah said, if someone indulges in stone-pelting, his family members will also not get a government job.

He said some human rights activists went to the Supreme Court against the decision but the government prevailed. The home minister, however, said the government a family came forward and informed the authorities that his or her close relative had joined a

terror outfit. Such families would be given

relief, he said. Earlier, funeral processions used to be taken out in Kashmir after a terrorist was killed, Shah said. "We have stopped this trend. We have ensured that the terrorist is buried

with all religious formalities but in an isolated place," he said. The home minister said when a terrorist is surrounded by the security forces, he is first given a chance to surrender. "We call

family members like his mother or wife and ask them to make an appeal to the terrorist to surrender. If he (the terrorist) does not listen, he dies," Shah said. The home minister said terror incidents have gone down significantly in Jammu and Kashmir as the government has not only targeted the terrorists but also eliminated the terror ecosystem. "Through the NIA (National Investigation Agency), we have taken strong action against terror funding and ended it. We have taken a very tough stand on terror funding," he said. In case of the banned Popular Front of India (PFI), Shah said the government has imposed a ban on publication and spread of the terrorist ideology by it. Muslim radical group PFI, founded in Kerala, was

#### Supreme Court refuses to entertain BJP's plea against Calcutta High Court order on advertisements

New Delhi, May 27: The Supreme Court on Monday refused to entertain the BJP's petition challenging the Calcutta High Court's order restraining the saffron party from publishing certain alleged derogatory advertisements against the TMC and its leaders during the ongoing Lok Sabha polls as they violated the Model Code of Conduct. "This is not in the interest of voters. This will degenerate... We are not inclined to interfere (with the high court's order)," a Vacation Bench of Justice JK Maheshwari and Justice KV Viswanathan told senior counsel PS Patwalia who represented the BJP. "We have seen the advertisements. Prima facie, the advertisements are disparaging. You can say you are the best...but we don't want to lend our hands to promote further acrimony...., Justice Viswanathan said even as Patwalia asserted



that the advertisements were based on facts. As the Bench was not inclined to entertain the petition Patwalia chose to withdraw the petition and it was "dismissed as withdrawn". "Your rival is not your enemy," the Bench noted. The top court had on Friday agreed to consider the BJP's petition after it was mentioned before another Vacation Bench led by Justice Bela M Trivedi for urgent listing. A Division Bench of the Calcutta High Court had on May 22 refused to interfere with a single-judge order restraining the BJP from publishing 'derogatory' advertisements against the TMC and its leaders, saying "Laxman Rekha" should not be crossed and there should not be any personal attacks. Refusing to interfere with the May 20 single judge order, the Division Bench had said the BJP could move the single judge, seeking a review or recall of its order. "You (BJP) are a national party. There should be an internal mechanism either at central or state level which will approve what propaganda can be printed. There should be some Lakshman Rekha... We are not complimenting them (TMC)...but imagine the impact on normal people," the HC had said. The BJP had contended that the single judge passed the order without giving it hearing and that the Election Commission was the appropriate authority for redress in case of any dispute during a poll process.

#### PM Narendra Modi's 'mujra' remark condemnable

Jalandhar, May 27: Prime Minister Narendra Modi's 'mujra' remark is unfortunate and condemnable. This was stated by Congress national spokesperson Charan Sapra while addressing mediapersons here today. Charan Sapra said the Prime Minister remembers 'mutton', 'machli', 'Mughal', 'mangalsutra' and 'mujra', but not 'maryada' (dignity), which is essential for the PM's post. Speaking to mediapersons, Sapra said: "An unfortunate incident happened in Bihar yesterday when the PM used "mujra" remarks. He couldn't retain the dignity of his post. After remaining the Prime Minister for 10 years, it is not dignified for the PM to use such language. He could have rather talked about inflation, unemployment, economy, farmers." Sapra said: "Voting for the BJP means voting for inflation, voting for a weak economy and voting for ending reservation. The PM should present the BJP's 10-year report card rather than targeting others. He should also tell that if the debts of farmers were not pardoned and guarantees not provided, why the BJP is instead interested in filling the coffers of the corporate. If corporate taxes could be pardoned then why not exempt farmers from the GST.

### Jammu and Kashmir records highest voter turnout in 35 years

New Delhi, May 27: The Election Commission (ECI) on Monday said Jammu and Kashmir recorded the highest voter turnout in a Lok Sabha election in last 35 years, with the Kashmir Valley witnessing a "massive" 30 points jump in poll participation compared to 2019. "This active participation is a huge positive for the assembly elections to be held soon so that the democratic process continues to thrive in the Union Territory," said Chief Election Commissioner (CEC) Rajiv Kumar while responding to the turnout. The poll panel also said the combined voter turnout at the polling stations for the entire Union Territory with five Lok Sabha seats was 58.46 per cent. On Saturday, CEC Kumar said that encouraged by the voter turnout in Jammu and Kashmir in the Lok Sabha polls, ECI will "very soon" initiate the process of holding the assembly polls in the Union Territory. The three seats in the Valley — Srinagar, Baramulla and Anantnag-Rajouri — recorded turnout of 38.49 per cent, 59.1 per cent and 54.84 per cent respectively, which has been the highest in last three decades. The other two seats in the UT — Udhampur and Jammu — recorded 68.27 per cent and 72.22 per cent voter turnout respectively, it said. ECI said that younger people have asserted their faith and embraced democracy in a big way. Another interesting perspective is the electors in the age group of 18-59 years forms the major part of electors in the UT, it underlined.

Bengaluru, May 27: Exactly a month after he left the country, Hassan MP Prajwal Revanna, who is facing charges of sexually abusing several women, has said he will appear before the Special Investigation Team (SIT), probing the cases against him, on May 31. Terming the cases against him as "false" and part of a "political conspiracy", he said he had gone into depression. "I will personally come before the SIT on Friday, May 31 at 10 am and cooperate with the investigation and also respond to it (charges). I have faith in the judiciary and I am confident that I will come out of false cases, through court," Prajwal said in a video statement that is now widely being circulated. There was no independent confirmation from the JD(S) or the family of the suspended party MP immediately over the matter. "Let the blessings of God, people and my family be on me. I will surely appear before SIT on May 31, Friday. After coming, I will try to put an end to all this. Keep faith in me," he added in his video

### Seven-year-old girl eats fried rice in Salem, dies with nosebleed


SALEM: A seven-year-old girl died after experiencing sudden nosebleeds following her dinner at Fairlands, Salem on Friday. The case has drawn attention to potential health risks in frequently consuming preservative-laden foods. Her mother, S Poojakumari, told TNIE that as the girl, S Lakshmikumari, loved fried rice, she ate it regularly and on Friday night her dinner comprised fried rice, chapati, and brinjal curry, and around 10 pm, her nose started bleeding. Though the child's parents rushed her to Salem Government Hospital, she was declared dead on arrival. A



case was registered at the Fairlands police station.Preliminary findings from the autopsy results indicated the presence of fluids in her body. These samples have been sent to a laboratory for detailed analysis to determine the exact cause of death.Police suspect that the regular consumption of fried rice may have impacted her digestive system, potentially leading to a nostril block and the fatal nosebleed. Fairlands police Inspector told TNIE, "We are conducting a thorough investigation and awaiting the results of the fluid samples."

## Illegal constructions at Varkala Cliff must go, says municipality

THIRUVANANTHAPURAM: Waking up from slumber, the Varkala municipality has served notices on owners of commercial establishments at Varkala Cliff, ordering them to immediately knock down all illegal structures located beyond

the footpath facing the seafront. They have until Monday to comply with the fiat.

The municipality's move follows multiple reports published by TNIE, extensively covering the pathetic condition of the eroding Varkala Cliff in Thiruvananthapuram. One of the most popular tourist destinations in the state, the Cliff has been tourist destinations in the state, the Cliff has been facing constant neglect by the tourism department as well as the municipality, and is becoming increasingly unsafe for the scores of visitors frequenting it daily, owing to rapidly worsening erosion. Earlier this month, huge holes ad appeared on the Cliff, triggering safety concerns.he municipality ordered the owners of commercial establishments to remove all illegal extensions and seating arrangements beyond the footpath by 2 pm. Should they fail, the municipality will remove the same and collect the expenses from the owners, the order issued by the local body said. Several temporary structures, sign boards, and other extensions of trade establishments dot the area beyond the footpath. The recent heavy rain further accelerated the erosion. Parts of the Cliff have collapsed in multiple locations along the footpath, making it dangerous for visitors, reidents and tourism stakeholders alike. Every year, 50,000 foreign tourists visit Varkala on an average. The 6.1-km-long red laterite cliff is a major attraction, drawing scores of domestic tourists. The conservation project of the Cliff has been long pending.Other than a few studies, the state government has not done much to preserve or conserve the rare geological formation, which was declared a Geo Heritage Site by the Geological Survey of India in 2014.

#### Widespread encroachment blamed for cliff destruction

Following reports by TNIE, the tourism department had directed the District Disaster Management Authority (DDMA) to visit the Varkala Cliff and review the situation.

A DDMA team visited the spot and submitted a report to the collector. Subsequently, several safety measures, including hand railings and warning boards, were put up at many spots. The DDMA had also directed the municipality to act. Varkala Municipality authorities said rampant encroachment on the cliff is the primary reason for its destruction. Absence of infrastructure to manage waste water is another.

The Varkala Tourism Development Association is gearing up to put up fencing to prevent accidents and ensure visitors' safety. "We have also submitted a project for the cliff's conservation. The government is yet to approve it. Once it gives its nod, we are ready to demonstrate the surface strengthening work on the cliff," said Sanjay Sahadevan, advisor to VTDA.

# Survey by forest dept reveals Catfish posing threat to native species in Periyar Tiger Reserve

KOCHI: The first composite aquatic Carp), Oreochromis faunal and odonate survey conducted by the forest department in the Periyar Tiger Reserve (PTR) from May 16 to 19 reveals a decline in population of native species due to the increase in population of exotic species like catfish. The survey identified 56 fish species which makes it the highest count ever from any study conducted in the PTR since 1940. The study revealed the presence of seven new species of fish from the various tributaries inside the PTR. The PTR will have to conduct molecular studies to confirm whether these species are new or the subspecies of existing fish species.arious water bodies in the PTR harbours 30% of all fish species found in Kerala. Among them, nine fish species are restricted to the PJShuhaib. but one, could be recorded during the current survey. Four exotic fish species, including Clarias gariepinus (African Catfish), Cyprinus carpio (Common

mossambicus (Mozambique Tilapia), and Oreochromis niloticus (Nile Tilapia) were recorded in the survey."Over the years we have observed a decline in cormorants and darters in our lake. This can be attributed to the decrease in population of native fishes and increase in the population of catfish. In 1986, catfish from a nearby fish farm had entered the lake during floods. We had found more exotic species in the lake after the

2018 floods. The survey will help understand the population of native fish," said Periyar East Assistant Field Director

### Custodial death probe handed over to CID in Karnataka's Channagiri

DAVANAGERE: The Criminal Investigation n Adil's body was conducted in the Department (CID) will take over the investigation into the alleged death of a man in police custody in Channagiri on Friday, said Superintendent of Police Uma Prashanth here on Sunday. She said the district police have arrested 25 persons for vandalising the police station, attacking police personnel and damaging police vehicles, based on video evidence available with the police. The accused have been charged under Sections 353 and 307 of IPC and were produced before court, which has handed them over to judicial custody. The accused are from Nalluru, Honnebaagi and Channagiri. They were part of a mob that attacked the police station after an arrested person, Adil, died in police custody.

presence of a judge on Saturday and the report is expected in three days. The report will reveal the real cause of Adil's death, she said.Channagiri DySP Prashanth Munnoli has obtained all information on those who attacked the police station, in which 11 police personnel suffered injuries.Six complaints have been registered over vandalising the police station, injuring police personnel and damaging police vehicles, she said.Channagiri, which was tense over the custodial death, returned to normal on Sunday. ### Death in treacherous waters of Karnataka

**BENGALURU:** A spate of drowning cases across Karnataka has cast a shadow over the past few weeks. While many lost their lives after venturing into water bodies at tourist spots, several drowned in lakes and agricultural ponds in rural areas, with most of the deaths being accidentsExperts say the primary cause of accidental drowning incidents is often the 'lack of adequate swimming skills' among people, and highlighted the importance of adhering to safety measures, especially around open water bodies like seas. Experts stressed that even if individuals are proficient swimmers in pools, the challenges posed by the currents, waves and other unpredictable factors in natural water settings require additional training and awareness.Experts also pointed out that a significant number of drowning incidents occur around tourist spots, and recommended that schools should prioritise teaching swimming skills, particularly in rural areas wher children frequently play near lakes and ponds. While awareness can be raised through signs and other methods, it is crucial to understand the

formidable force of water. "Often, people slip and then experience breathing difficulties, which can be fatal. In such scenarios, knowing how to swim could be life-saving," experts

Several incidents were recently reported from Bengaluru Rural and Ramanagara districts where youths lost their lives while enjoying themselves near water bodies with friends. Police officials said that most of these incidents happened because of the carelessness of those who entered the water without being aware of the factors that ultimately claimed their lives. Contrary to common belief that most drowning cases are suicidal, data from Bengaluru Rural suggest that the majority are accidental. Till May this year, there were a total of 36 drowning cases, of which 30 were accidental and six were suicidal.Bengaluru Rural SP Mallikarjun Baladandi mentioned that people often go in groups to tourist spots and engage in restricted activities to seek thrills, which tragically leads to loss of life. Moreover, the growing trend of



recording vlogs or videos, and taking selfies at every location they visit sometimes proves fatal, as people fail to pay attention to their surroundings and can be swept away by waves or fall into water bodies.

### High risk at tourist spots

Approximately 20 people have drowned in the river Cauvery in Mysuru region from January to mid-May, with most incidents occurring at tourist spots. Police authorities say that a majority of drowning incidents occur at picnic

and religious sites such as Balmuri, Muthathi, KRS backwaters, Chunchanakatte falls, Sangama, Gaganachukki and Barachukki falls, and areas near the Cauvery river." Most of the fatalities involve young individuals who attempt to enter deep waters despite lacking swimming skills. Despite repeated warnings, people enter rivers and lakes and meet their end in watery accidents," an officer stated.M Sukumar, a national-level swimmer and coach who represented Karnataka 29 times and is one of the country's top divers, emphasised that swimming lessons be mandated in schools and colleges. "The government made education compulsory, followed by compulsory physical education in schools. Now, there is a call for swimming to be included as part of education. This initiative will help reduce the number of drowning incidents in future," he said, and stressed the need for stringent measures around water bodies.Sukumar insisted that eeryone, including expert swimmers, should be prohibited from entering deep waters at tourist

### 22-year-old woman stabbed to death by friend in PG facility

Gurgaon: Enraged over a rape case registered against him two years ago in Maharashtra and alleged "harassment for money" by the survivor, a youth stabbed a woman to death in a paying guest hostel facility in Sector 48 on Saturday.

After killing her, the accused called police and informed them about it, following which he was taken into custody. Police registered a suo motu case under IPC Section 302.

he 22-year old woman was from Maharashtra's Akola and her friend Suraj Verma is a native of the same district. Suraj (26) works as an HR manager at a private company operating from JMD Megapolis building in Sector 48. For the past eight months, he has been staying at Rohit PG guest house in Sector 48.On Saturday evening, the woman visited Suraj at the PG and he took her to his room.

"Around two hours later, a police team reached the guest house asking for details of Suraj's room. We came to know about the murder only after the police team arrived. Suraj has been staying with us for about eight months in the first-floor room. He is an HR manager in an IT company and we never had any complaints. The woman came to meet him around 4 pm on Saturday and she went to Suraj's room. Suraj shares the room with another man but he was not there at that time. Police found the woman murdered in the room lying on the floor next to the bed," Rohit PG operator Balwan said.

Police opened the door and found the woman lying on the floor in a pool of blood. "Cops collected CCTV footage and details of Suraj from us," Balwan said.

The body has been sent for autopsy. During the preliminary probe, police came to know that the woman knew Suraj well and on her complaint, a rape case under IPC Section 376 had been registered."Preliminary information is that the woman and the accused knew each other and there was a case against him in Maharashtra. Suraj stabbed the victim to death with a knife," Gurgaon Sadar inspector Arjun Dev said.

ACP (Gurgaon Sadar) Kapil Ahlawat said the accused has been taken into custody and during the preliminary probe it came to light that the accused was "angry with the victim" about the police case registered against him in Maharashtra.

### 3 handed life in jail for murder in 2019

Gurgaon: A local court has sentenced three people to life imprisonment for murder of a 32-year-old carpenter in 2019. One of the accused was related to the victim.

Police said Dev and Kanhaiya from Faridabad and Sheetal from Jakhopur in Sohna were found guilty of killing Sheetal's uncle, Rakesh, in Jakhopur on March 27, 2019. Sheetal was in a relationship with Kanhaiya and Rakesh had opposed their involvement. So, Dev and Kanhaiya shot Rakesh dead at his house.

Kanhaiya is a grocery store operator in Faridabad and Dev alias Monu is his nephew.

A few years prior to the murder, Rakesh's wife had eloped with Sheetal's husband and since then, Sheetal has been staying at her uncle, Rakesh's place. According to police, Sheetal was involved with Kanhaiya from before she got married."On the day of the murder, Sheetal went out of the house along with her grandmother, leaving Rakesh alone at home. Meanwhile, Kanhaiya and Dev went to Rakesh's house and while Kanhaiya held Rakesh, Dev shot him in the head," Sandeep Kumar, spokesperson for Gurgaon police, said. After the murder, Sheetal and her grandmother returned home and she pretended that unknown assailants had shot her uncle in their absence.

However, cops said, call records suggested that Sheetal was in contact with Kanhaiya both before and after the crime. It was also established that Kanhaiya and Dev were in Jakhopur on that day. Kanhaiya and Dev were arrested from Faridabad on March 31 that year and based on their confession, Sheetal was arrested on April 3. After the trial, on Thursday, Mona Singh, additional sessions judge, sentenced the trio to life imprisonment under IPC sections 302 (murder) and 120B (criminal conspiracy). ### Work at plant sparks water crisis, tempers rise in hsg societies

Gurgaon. Several parts of the city have been reeling from severe water shortage as the temperature is soaring. On Sunday, they faced shortfall in supply due to maintenance work at the treatment plant (WTP) in Basai. GMDA said a three-hour shutdown was carried out at the plant, partially affecting the supply. The affected areas include sectors 14,12,21,22,23,1,2,3,18, and Udyog Vihar, Palam Vihar, Dundahera and Maruti Udyog."The shutdown was necessary to carry out maintenance work at the Basai WTP plant. As a result, supply was partially affected in some areas. We resumed the supply around 7pm, it is expected to be fully streamlined by Monday morning," a GMDA

The recent disruption has worsened the existing water supply problems in certain areas. For instance, residents of Sector 21 have been dealing with severe water shortages, as the water pressure has dropped to around 70 psi, which is significantly lower than the normal range of 130 psi. This decrease in pressure has left residents without water for days, leading them to depend on water tankers." Apart from technical issues, we are also dealing with an inconsistent presence of pump operators. The pump operator is available only sometimes and does not switch on the tubewells, reducing the pressure of water supply to the sector,' Prakash Lamba, RWA president of Sector 21 complained."Water meant for Sector 21 continues to be diverted to Mullahera village due to a temporary connection pending the completion of a direct supply line. The upkeep of the motor and other equipment at the Sector 21 pump house has been poor, with a tubewell remaining non-operational due to delayed electrical repairs," a resident said.

# YEIDA plans to acquire 6,000 hectares in 2 yrs, spend 60k cr to develop them

**Noida.** Yamuna Expressway Industrial Development Authority (YEIDA) has planned to acquire more than 6,000 hectares worth Rs 14,000 crore over the next two years. Officials said the Authority would spend Rs 63,500 crore in developing infrastructure such as roads, drains, parks and set up electricity connections in these areas before they are handed out for both industrial and residential projects

The land will be acquired from 40 villages through various means, including mutual agreements, acquisition and reclamation.

Of the total 6,065 hectares, 1,609 hectares will be bought directly from farmers through mutual agreements while 4,076 hectares will be acquired. Some 380 hectares of govt land will be reclaimed. Some of the key villages where land is set

to be acquired are Rabupura (994

hectares), Tirthali (479), Karauli Bangar (250), Muradgarhi (336), Tappal-Bajna (771), Mudrah (290), Kallupura (218) and Mayana (252).Officials said this acquired land would be utilised for establishing new sectors and industrial cities. Some of the sectors that will be developed on this land are 5, 6, 7, 8, 9, 10 and 11. Additionally, 712 hectares will be acquired for the Tappal-Bajna urban centre and 528 hectares for a logistics park proposed in Dorpuri and Syarol villages. The process of acquiring land is underway in four of six villages in Sector 10, while the proposal for getting land in Tappal-Bajna and in sectors 5, 6, 7 and 8 have been sent to the govt for

In March this year, UP govt had issued a notification for acquiring land to develop Sector 10, which will include five industrial parks, one of which will be used for manufacturing electronics equipment. A Fintech City is proposed in Sector 11, while Japanese and Korean cities will be developed in sectors 5A and 4A, respectively. YEIDA will need 395 hectares for the Japanese City and 365 hectares for the Korean project.

The Authority has received interest-free loans of around Rs 3,300 crore so far to meet the financial requirements of these projects. YEIDA plans to contribute its share from profits earned over the next few years, revenue generated from various plot schemes and loans from banks to complete the land acquisition process. ### 1-mth-old with rare heart defect treated at city hosp

Gurgaon: A one-month-old infant suffering from a rare congenital heart defect — LV apical aneurysm — was successfully treated at a city hospital. The condition, which replaces the apical part of the heart's left ventricle with fibrous tissue, is exceptionally rare — with only 809 cases reported worldwide since 1816. This case marks the youngest of its kind, doctors said.In a case like this, fibrous tissue makes the heart thin and weak, making it prone to spontaneous rupture and posing significant structural and functional challenges. The condition can remain undiagnosed for years after birth and poses a serious risk of sudden cardiac events, such as sudden infantile death syndrome (SIDS), especially during periods of stress such as crying or physical activity.

Its exact cause is often unknown and it can occur without any genetic predisposition or identifiable contributing factors.r Deepak Thakur, senior consultant, paediatric and fetal cardiology, Paras Hospitals, Gurgaon, noted, "Congenital heart defects affect the structure of the heart and are Dr Shyamveer Singh Khangarot, typically detected either at birth or before. In this extraordinary case, the condition was diagnosed during fetal echocardiography at 26 weeks of pregnancy. The fetal echocardiography played an important

role in helping diagnose such a rare anomaly and further helped in planning the course of treatment. After diagnosis, the child was closely monitored with bi-weekly follow-ups until delivery to ensure that the size of the aneurysm did not increase. Following birth, an MRI was performed to confirm the diagnosis, which corroborated with echocardiography findings. The parents were advised for close followup on medical management; however, after a month, when the size of the aneurysm increased and the child started experiencing breathing difficulties, it was decided to perform the surgery.

The surgery was performed when the baby was 1 month old, weighing 3.4 kg. Doctors chose to strictly monitor the infant's condition from birth and waited as long as possible before operating to allow the heart muscles to grow. Eventually, a team of doctors comprising pediatric cardiologists, cardiac surgeons, perfusionists, and cardiac anesthetists.

consultant, congenital (neonatal and pediatric) cardiac surgeon, emphasized the unique challenges posed while treating this rare condition in an infant, stating, "Neonatal and infant cardiac surgeries are inherently complex; however, the rarity and complexity of this disease made the task even more challenging. The involvement of the left side of the heart added another layer of complexity. The surgical procedure performed, known as left ventricular endoaneurysmorrhaphy, required meticulous planning due to the infant's small heart size. Every millimetre of tissue in the infant's heart was critical, and we had to carefully consider not only the immediate outcome but also the longterm growth potential. After 6 hours of surgery, the aneurysm was repaired with a composite patch of polyester and pericardium with another layer of epicardium. Even before the surgery, contingency preparation was done to support the baby on ECMO, if required, in the form of an integrated ECMO/CPB circuit, given the uncharted nature of the post-operative course due to the rarity and c o m p l e x i t y o f t h e procedure."Highlighting the importance of post-treatment care, Dr

Alok Sahoo, cardiac anesthetist, Paras, said, "During the postoperative period, we maintained constant vigilance over the baby, ensuring optimal care of

### Bus accident: School director surrenders in court after 43 daysa

Gurgaon: The director of GL Public School in Mahendragarh district, who is the primary suspect in the tragic school bus accident on April 11 that resulted in the deaths of six students, surrendered in Kanina court on Friday, 43 days after the incident. The police have taken Subhash Lodha into custody on a four-day remand.

On April 11, a bus carrying 34 students rammed into a tree and overturned near Unhani village around 8.30am, killing six students and injuring

The driver was allegedly drunk and speeding at 120 kmph, causing the accident. It was also found that the bus lacked a fitness certificate.

With Subhash's surrender, police have arrested 10 suspects in the case so far. Bus driver Dharmendra, school principal Deepti Yadav, and school secretary Hoshiyar Singh were arrested the same evening. Deepti is Subhash's wife, and Hoshiyar is his younger brother. On April 15, four more individuals — Harish, Sandeep, Bhudev, and Naresh alias Kaliya — were arrested for consuming alcohol with Dharmendra inside the bus. Around a week later, on April 17, the school chairman and BJP functionary, Rajendra Lodha, was also taken into custody from a brick kiln in a Rewari village.

Subhash had been evading arrest for 43 days, with police continuously raiding potential hideouts. During this period, he filed an anticipatory bail

### Israeli airstrike kills 30 in Rafah as tents for displaced people hit

World At least 30 Palestinians were killed and dozens of others were wounded after the Israeli air strikes hit the southern Gaza Strip city of Rafah housing the displaced, local authorities said on Sunday. Palestinian health and civil emergency service officials said that the strikes hit a neighbourhood in western Rafah, sheltering thousands of people who had fled the eastern areas of the city after Israeli forces launched a ground offensive there over 15 days ago. A field hospital in Rafah, run by The International Committee of the Red Cross, saw an influx of casualties while other medical facilities were also receiving patients in large numbers. Medics refrained from confirming the final death toll in the Israeli strikes as several of the injured were in critical condition.

Holding the United States responsible for providing weapons and financial aid to Israel, a senior Hamas official called the attack a 'massacre." The air strikes burnt the tents, the tents are melting and the people's bodies are also melting", a resident at a hospital was quoted as saying by news agency Reuters.

As per a statement by the Hamas al-Qassam Brigades, the rockets were launched in response to 'Zionist massacres against civilians'. Israel had earlier said it wanted to eradicate Hamas fighters in Rafah and rescue hostages it claimed were being held in the area. Rockets fired from Rafah prove that the (Israel Defense Forces) must operate in every place Hamas still operates from", Israeli war cabinet minister Benny Gantz said.

Meanwhile, Defence Minister Yoav Gallant conducted an operational evaluation in Rafah."He was briefed on troops' operations above and below the ground, as well as the deepening of operations in additional areas with the aim of dismantling Hamas battalions", Gallant's office said. Gaza's health ministry said that nearly 36,000 Palestinians have been killed in Israeli strikes so far.

Israel launched an offensive in Gaza after Hamas militants attacked Israel on October 7, 2023, killing around 1,200 people and holding over 250 people as hostages.

Over the past few months, the international community has condemned Israel's offensive on Gaza and has called

# North Korea informs Japan of satellite launch plan by early next week

launch a satellite by early next week, Japan said on Monday, an apparent effort to put the North's second military spy satellite into orbit in yet another violation of UN bans. The launch notification came as leaders of South Korea, Japan and China gathered in Seoul for their first trilateral meeting on Monday.Japan's Coast Guard said it was notified by North Korea about its planned launch of a "satellite rocket", with safety caution in the waters between the Korean Peninsula and China and east of the Philippine island of Luzon beginning on Monday and running through midnight June 3.North Korea gives Japan its launch information because Japan's coast guard coordinates and distributes maritime safety information in East Asia.Japanese Prime Minister Fumio Kishida instructed officials to cooperate with the US, South Korea and other countries to strongly request North Korea not to go ahead with the launch and to take the utmost measures in case of any contingency, his office said. The launch plan likely refers to the North's push to launch its second

Korea's military said on Friday that it detected signs that North Korea was engaging in activities believed to be preparations to launch a spy satellite at its main Tongchangri launch facility in the northwest. The UN bans North Korea from conducting any satellite launches, viewing them as cover for testing its longrange missile technology. North Korea has steadfastly maintained it has the right to launch satellites and test missiles. It says spy satellites would allow it to better monitor the US and South Korea's moves and enhance the precision-strike capability of its nuclear-capable missiles.In phone talks, senior diplomats from Japan, South Korea and the US agreed to urge North Korea to cancel the launch, noting that any North Korean launch using ballistic technology would violate multiple UN Security Council resolutions.outh Korea's Unification Ministry separately called a satellite launch by North Korea "a provocation that seriously threatens our and regional security."Last November, North Korea sent its first military reconnaissance



to cope with what it calls increasing US-led military threats.North Korean leader Kim Jong Un later told a year-end governing party meeting that the country would launch three additional military spy satellites in 2024. There is widespread doubt about how much militarily meaningful imagery the North Korean satellite can produce. But some civilian experts say the operation of several such satellites could still help North Korea monitor big targets among its rivals at all times.ccording to North Korea's latest launch notification to Japan, the danger zones where rocket debris would fall are

the same places the country identified prior to its November launch. That suggests North Korea would use the same first and second stages of the rocket as those in the previous launch, said Chang Young-keun, a missile expert at the Seoul-based Korea Research Institute for National Strategy.Chang said the launch of three more spy satellites this year would allow North Korea to obtain imagery on sites in South Korea,

Japan and the US Pacific territory of Guam more frequently. Since 2022, North Korea has been engaged in a provocative run of missile tests to modernise and expand its weapons arsenals, prompting the US, South Korea and Japan to strengthen their security partnership in response.Experts say North Korea likely believes an enlarged weapons arsenal would increase its leverage in future diplomacy with the US.North Korea wasn't among matters listed on the official agenda for Monday's trilateral meeting between Kishida, South Korean President Yoon Suk Yeol and Chinese Premier Li Qiang.

### Israeli strikes kill 35 in Rafah, its army claims Hamas commanders eliminated

World At least 35 Palestinians were killed, and dozens of others injured in Gaza's southern city of Rafah, after Israeli strikes hit the southern Gaza Strip city on Sunday, according to Palestinian health and civil emergency service officials. Rafah houses hundreds of displaced Palestinians who fled the northern part of Gaza since Israel's counterattack against Hamas's October 7 assault began last year. In a post on X, the Israel Defense Forces (IDF) said that it struck a compound in Rafah that was housing "significant Hamas terrorists" and was carried out with "precise munitions and on the basis of precise intelligence". It further claimed that the strikes killed Hamas's chief of staff for the West Bank and another senior official of the Palestinian Islamist group. The strikes happened after Hamas claimed to have launched a barrage of rockets at Israel's Tel Aviv for the first time in months as rocket sirens blared across the central part of the Jewish nation, news agency Reuters reported. Following the Israeli strikes in Rafah, Hamas reportedly asked Palestinians to "rise up and march" against the Israeli Army's "massacre". In light of the horrific Zionist massacre this

evening committed by the criminal occupation army against the tents of the displacedâ€æ we call on the masses of our people in the West Bank, Jerusalem, the occupied territories and abroad to rise up and march angrily against the ongoing Zionist massacre against our people in the sector," the group said, according to Times of Israel.A spokesperson for the White House National Security Council told the Times of Israel that the US President Joe Biden-led administration is following the situation regarding Israeli strikes on a displaced people's camp in Rafah."We're aware of the reports about the incident in Rafah and are gathering more information," the spokesperson added. The Israeli Army said that the strikes took out Yassin Rabia, Hamas's chief of staff for the West Bank and Khaled Najjar, a senior member of the Palestinian group. According to the IDF, Rabia was "involved in the transfer of funds for terror purposes and directed attacks by Hamas operatives" in the West Bank. He was also involved in committing multiple deadly attacks himself in 2001 and 2002, killing Israeli soldiers. Najjar also carried out attacks between 2001 and

2003, according to the IDF, killing civilians and killing and injuring soldiers. The Israeli strikes in Rafah came two days after the United Nation's top court, the International Court of Justice (ICJ), ordered Israel to "immediately halt its military offensive" in the Gaza city. The ruling came in support of South Africa's application last week that sought several measures against Israel. The court said that it considered the humanitarian situation in Rafah "disastrous", adding that UN officials have indicated it was set to "intensify even further" if the military operation in Rafah

### Palestinian medics say Israeli airstrikes kill 35 in Gaza's Rafah as displaced people are hit

**DEIR AL-BALAH.** Palestinian health workers said Israeli airstrikes killed at civilians were harmed. Defense massive air, sea and ground offensive. There were no reports of casualties in least 35 people Sunday and hit tents for displaced people in the southern Gaza city of Rafah, and "numerous" others were trapped in flaming debris. Gaza's Health Ministry said women and children made up most of the dead and dozens of wounded. # France to lift state of emergency in riot-hit New Caledonia to enable dialogue

Paris, UPDATED: French President Emmanuel Macron has decided to lift the state of emergency in the French Pacific territory of New Caledonia on Monday, in a move meant to allow political dialogue following the unrest that left seven people dead and a trail of destruction, his office

The president's office said in a statement the state of emergency won't be extended "for the moment" and will therefore end on Monday at 8 pm in Paris, which is 5 am Tuesday in New Caledonia. The decision aims at "enabling meetings of the various components" of the pro-independence movement FLNKS, the Kanak and Socialist National Liberation Front, and allow elected officials and other local leaders "in a position to call" for lifting the barricades to go there and meet with protesters, the statement said.Macron repeatedly pushed for the removal of protesters' barricades with leaders on both sides of New Caledonia's bitter divide -- Indigenous Kanaks, who want independence, and the pro-Paris leaders, who do not. In the statement, he insisted it is "the necessary condition for the opening of concrete and serious



negotiations".

Macron's move comes after he travelled to New Caledonia on Thursday (May 23).

The statement said 480 additional gendarmes are to arrive in the archipelago 'in the next few hours", putting security reinforcements at more than 3,500.

The seven people killed in the shootings include two gendarmes. The state of

emergency had been imposed by Paris on May 15 for at least 12 days to boost police powers. The emergency measures give authorities greater powers to tackle the violence, including the possibility of house detention for people deemed a threat to public order and expanded powers to conduct searches, seize weapons and restrict movements, with

This month's unrest erupted as the French legislature in Paris debated amending the French constitution to make changes to voter lists in New Caledonia. The leader of a pro-independence party in New Caledonia on Saturday called on supporters to "remain mobilised" across the French Pacific archipelago and "maintain resistance" against the Paris government's efforts to impose electoral reforms that the Indigenous Kanak people fear would further marginalise them.

Christian Tein, the leader of the proindependence party known as The Field Action Coordination Unit, addressed supporters and protesters in a video message posted on social media.

In a separate statement, the Kanak and Socialist National Liberation Front called on Macron to withdraw the electoral reform bill if Fnce wants to "end the crisis."New Caledonia became French in 1853 under Emperor Napoleon III, Napoleon's nephew and heir.

It became an overseas territory after World War II, with French citizenship granted to all Kanaks in 1957.

The incident happened when R Lavanya (5) and Rashmitha (2) from Kokkampalayam village, daughters of Raja who works abroad, visited the place of their cousins — M Janusha (3) and M Balamithiran (2), children of A Manikandan — in the nearby Kottarakuppam village to attend a temple festival. As per a doctor treating them, the children are under observation as the effect of the poison may take up to 72 hours to become evident. "While three of them



only started brushing their teeth using the paste, one child, Balamithiran, swallowed some of it," said the senior doctor from Government Cuddalore Medical College Hospital in Chidambaram.Police said the children were playing with the rat killer paste tube and later used the same to brush teeth. "On seeing the kids with the tube in hand and the paste in mouth, family members rushed them to the government hospital in Vriddhachalam and then shifted them to the medical college hospital," said police. Upon parents' request, the kids were transferred to JIPMER on Sunday night.

TN banned rat paste in 2022

The Tamil Nadu government had imposed a permanent ban on the sale of rat paste in grocery shops, supermarkets, and medical

shops in 2022. However, sources alleged that some shops, especially those in the Tamil Nadu-Puducherry border villages, still sell it illegally. Police said that the rat paste used by the children was bought by Manikandan two years ago and kept in the house. Police have not filed a case yet as no complaint was received until Sunday evening

However, an inquiry is under way. An official from the Health and Family Welfare department said though the item is banned, it is the police department's responsibility to enforce the ban as it is still available in small shops. A senior police official from Cuddalore told TNIE that they have already spread awareness about the dangers of the banned rodenticide

The bacteria leptospira can enter the body through tiny wounds. The patient may experience fever, headache and muscle pain. Delayed treatment can even lead to death," said Dr Rajeev Jayadevan of the Indian Medical Association's Kerala unit.

Over 41 deaths due to leptospirosis have been reported in the state already. "Consulting a doctor early is important. Also, preventative medicine is available at government health centres for those at high risk of contracting the disease," Dr Rajeev said.

With the advent of the monsoon, a spike in dengue cases is also to be expected. The state has reported 16 dengue deaths already. "The conditions will be very favourable for mosquitoes to breed. Wearing full-sleeve clothes while working outside, and using mosquito nets and repellents are advised," Dr Rajeev saidThis year, the number of leptospirosis and dengue cases is already high even before the monsoon. "We can even expect an outbreak," warned Dr Anish T S of the Government Medical College in Manjeri, adding, "Leptospirosis can cause death in 10 per cent of the people infected. Therefore, people at risk should take medicines."

The spread of hepatitis, as reported in Malappuram and Ernakulam's Vengoor village, is also a matter of concern.

This disease also spreads through water. Prevention is key, and ensuring hygiene is crucial. It's all preventable with basic, practical measures. Simple fever can lead to serious health issues. People suffering from fever should refrain from work, social functions and school. It can help prevent the spread of diseases," Dr Anish added.

Spread of hepatitis a matter of concern

This year, the number of leptospirosis and dengue cases is already high even before the monsoon. With the advent of the monsoon, a spike in dengue cases is also to be expected. The spread of hepatitis, as reported in Malappuram and Ernakulam's Vengoor village, is also a matter of concern. Considering the situation, doctors have urged people to be cautious, highlighting that delayed treatment can likely result in death.

### 12 killed as rain wreaks havoc in Telangana

HYDERABAD: Twelve persons died as gusty winds and a heavy rain wreaked havoc in several districts in the state on Sunday. Four persons, including a 10-year-old girl, died on the spot when the compound wall of an under-construction dairy farm fell on them in Tandur in Nagarkurnool district. Four sustained injuries in the incident. The deceased were identified as owner of the farm Belle Mallsh (38) and his daughter Anusha (10) and two workers, S Ramulu (35) and his wife Chennamma (34). Mallesh's wife Parvathamma and workers Raju, Chinna Nagulu and Kumuraiah sustained injuries. As the condition of Chinna Nagulu was critical, he was shifted to a hospital in Hyderabad. The remaining three were admitted to the Nagarkunrool

A three-year-old boy and a 45-year-old man died in Sai Nagar of Hafeezpet following a drizzle in Hyderabad on Sunday. The boy was killed when the roof of the balcony of the adjacent house fell on him while he was sleeping in his home. 36In another incident in the same area, a man, identified as Rashid, 45, suffered severe injuries after bricks fell on him while he was walking. He was rushed to a private hospital where he succumbed to injuries. Meanwhile, a 12-year-old boy, Dandu Lakshman, died in Telakapalli mandal and a man, Jaipal Naik, suffered injuries at Nukalachinta tanda in Nagarkurnool district when lightning struck.

Additionally, Venu (38), a driver from Vikarabad, died when an iron shed fell on him and lightening claimed the life of a person at Nandivaddeman Palli in Bijinapally mandal in the district. Meanwhile, two persons died and three were injured when the wall of a poultry farm collapsed at Kshirasagar in Mulugu mandal of Siddipet district. The deceased were identified as Gowri Shankar, 45, and Bhagyamma, 40. Three persons were injured in the incident. In another incident in Keesara in Medchal district, two persons died when a tree fell on their two-wheeler. According to sources, two persons belonging to Bommalaramaram in Yadadri district were travelling on a two-wheeler from Keesara to Shamirpet. When they reached Timmaipalli, a big tree fell on their two-wheeler. One person died on the spot and another succumbed to injuries while undergoing treatment in a hospital. Moderate to heavy rains accompanied by gales uprooted scores of trees and electricity poles in Nagarkurnool, Vikarabad, Kamareddy and Yadadri-Bhuvanagiri districts.

# MCC halts works to combat

animal threat at Tirumala

**TIRUMALA:** Of the total Rs 3.75 crore allocated by the Tirumala Tirupati Devasthanams (TTD) to take measures for protection of devotees from wildlife, only Rs 75 lakh has been utilised so far. It has been learnt that works were stalled after the Model Code of Conduct

(MCC) was imposed in the State. orest Department officials asserted that works will be resumed with the remaining Rs 3 crore, once the code is lifted on June 6. The Srivari temple Trust allocated the fund following the rise in mananimal conflicts on the trekking paths. It may be recalled that a sixyear-old girl was mauled to death by a leopard along the Alipiri footpath last year. Subsequently, a team of experts visited Tirumala forest region and recommended certain measures to prevent such issues. The TTD and the forest department, took steps to implement the recommendations

and also allocated Rs 3.75 crore for the same. As part of the efforts to address the issue, designated wings of the TTD and the forest department extracted footage from the 500-odd closed circuit cameras which were installed at various vulnerable points in the forest area, particularly along both the footpaths leading to the hill shrine. The footage showed the movements of leopards, sloth bears, and other wildlife in the forest and vicinity of the pedestrian paths. As per the recommendation of the central committee, comprising officials from the Central Zoological Authority (CZA), certain proposals were approved and the required equipment was being procured. Necessary staff have already been deployed and veterinary experts, too, have been camping regularly at vulnerable points along the footpaths.\Since May 15, when the pilgrims' rush to the holy hill shrine started increasing, leopards were spotted five times and sloth bears twice. Recently, an incident of two leopards attacking deer near the G&C toll gate in Tirumala was reported, reinforcing the need for the early completion of the measures to avoid mananimal conflicts. When the issue was brought to the notice of N Nageswara Rao, the Chief Conservator, Wildlife Management, Tirupati circle, he maintained that the works were stopped due to the election code. We have stopped the procrement of equipment needed for the project," he said. Forest department officials said once the equipment is procured, it will be handed over to the personnel deployed for the project, particularly to man the command control rooms either at Alipiri.

### 11 new fish species found along Andhra Pradesh coast

VISAKHAPATNAM; A recent study has documented 11 fish species for the first time along the Andhra Pradesh coastline, highlighting the rich biodiversity associated with artificial reefs and rocky shoreline habitats. The research, led by Dr JS Yogesh Kumar, Scientist-E from the Zoological Survey of India, was published in the Journal of Fisheries under the title "Notes on some newly recorded fish from the Andhra Pradesh coast, India."The newly-identified species include the Vermiculated Blenny, Singular Bannerfish, Sea Blenny, Similar Damsel, Blotcheye Soldierfish, Seychelles Soldier,

Threespot Squirrelfish, Moon Wrasse, Peacock Sole, Whitelipped Eel Catfish, and Papuan Toby. Notably, Entomacrodus Thalassinus has been recorde fr the first time in India. The study, conducted between 2019 and 2023, involved scuba diving and collection from trawler trash and Visakhapatnam Fishing Harbour. Specimens were photographed and preserved, with identifications based on morphological characteristics. These specimens are now part of the National Zoological Collections at the ZSI Sunderban Regional Centre. Nine of the 10 species, recorded for the first time in Andhra Pradesh, have been classified as least concern by the IUCN, while one has not been evaluated.Researchers emphasised the significance of reef habitats, which provide foraging grounds and shelter for marine organisms, including crustaceans and mollusks. Approximately 25% of marine fish are associated with reef ecosystems. Reef fish diversity is closely-linked to the health of reef ecosystems, which face threats from thermal fluctuations, coral bleaching, coastal development, and overfishing."AP, ranked third in marine fish production in India, has a fish species compared to its production. Previous studies have largely focused on economically profitable fish collected from markets, which do not accurately represent the diversity of reef-associated species. Fish trawlers often avoid reef areas to prevent net entanglement and reef destruction," it noted. The findings highlight the critical role of reef fish in maintaining the health of reef ecosystems. The newly-recorded species, including Entomacrodus Thalassinus, indicate that non-commercial benthic fish have been overlooked.

relatively low number of documented marine The research calls for comprehensive future

studies on blennies (generally bottomdwelling fishes) and other reef-associated species to better understand their biology and ecology, which is essential for conservation planning.Further, researchers mention that the discovery of new species not only enhances understanding of marine biodiversity in AP, but also aids in the development of more effective conservation strategies. Given that almost 25% of marine fish are associated with reef ecosystems, protecting these habitats is crucial for maintaining marine diversity and ecosystem health, the study observed.

### Need to amend legislation to ensure professional liability

While exempting lawyers from any professional liability for deficient services under the Consumer Protection (CP) Act, a two-judge Bench of the Supreme Court has opened a Pandora's box by recommending to the Chief Justice of India that a 1995 judgment of the apex court that held a contrary view vis-à-vis medical professionals be re-considered! Whatever may be the response of the Chief Justice, this will certainly spur not just medical professionals but many others to re-open the issue and this does not augur well for consumer protection and justice. And unless the Union Ministry of Consumer Affairs acts quickly and makes the necessary changes in the law, consumers may well lose their right under the CP Act to hold professionals, including doctors, radiographers, pharmacists, chartered accountants, engineers and architects, liable for their deficient services.

The judgment of the Supreme Court in the Bar of Indian Lawyers vs DK Gandhi case, delivered on May 14, holding that legal professionals are not accountable to consumers under the CP Act, certainly comes as a very big disappointment to consumers. Of course, the consumers' right to sue their lawyers under the CP Act was more or less extinguished way back in 2009, when the Supreme Court stayed the order of the apex consumer court in DK Gandhi vs M Mathias case delivered in 2007, in favour of the consumer. If in the last decade-and-a-half — when the appeals against this order were pending before the Supreme Court — consumers had harboured any hope of a favourable judgment, that hope has now been dashed. But even now, the Union Ministry of Consumer Affairs, along with DK Gandhi, the complainant in the case, should file a review petition before the Supreme Court.

But what is more alarming is the view expressed in the judgment that the Supreme Court should reopen a much hailed judgment of the apex court in the Indian Medical Association vs VP Shantha case delivered in 1995, holding that consumers can seek compensation from medical professionals for negligence under the Consumer Protection Act.Not many consumers today are aware of the situation that existed before the consumer protection law came into force in 1986. Be it a case of a doctor operating on the wrong leg, or leaving behind a pair of scissors in the abdomen post-surgery, or administering wrong medication to a patient or conducting needless hysterectomy or C-Section, the victims or their relatives in most cases suffered in silence because they could not afford to go to a civil court and fight a long legal battle to seek compensation. The Consumer Protection Act of 1986 for the first time gave them the right to seek damages for medical negligence and soon, cases began to be filed against doctors and hospitals.

The reaction from the medical professionals was quick, adverse and, sometimes, even violent. They rose as one in protest and exerted considerable pressure on the government to keep them out of the purview of the CP Act. The consumer activists had to fight hard to ensure that the government did not give in to the wishes of the doctors. What finally settled the matter in favour of consumers was the extremely clear and lucid judgment of the Supreme Court in 1995 in the VP Shantha case. After carefully examining the provisions of the CP Act, the three-judge Bench held that the services rendered to a patient by a medical practitioner by way of consultation, diagnosis and treatment, both medicinal and surgical, would fall within the ambit of 'service' as defined in the Act. The fact that medical practitioners belonged to the medical profession and were subject to the disciplinary control of the Medical Council of India/State Medical Council constituted under the Indian Medical Council Act would not exclude the services rendered by them from the ambit of the Act.he present judgment of the Supreme Court, pertaining to lawyers, on the other hand, says that the legislature never intended to include professionals within the purview of the CP Act. Even if it did, the legal profession is 'sui generis' or unique in nature and cannot be equated with other professions and brought under the ambit of the CPAct.

### Between despair & hope

We've come a long way since 1947 and yes, some terrible mistakes have been made. But if we were to blindly believe international reportage, everyone in India is a bigoted bully

If one were to believe our newspapers or the bilge that is sent out on WhatsApp groups, it is easy to be persuaded that doomsday is upon us. Perhaps, it is a sign of the times that makes us so negative and humourless, or perhaps, it is that we wish to join the herd. It seems almost sinful to be happy and satisfied in a world that has shrunk into small groups, provinces and regions that are eternally at daggers drawn. Yet, look around you and point me to a country (other than little Bhutan) where natural surroundings are preserved, people are polite, caring and gentle, communities live in harmony and simplicity of life is a quality that is actively promoted.Long ago, before Ravish Kumar became the self-appointed keeper of this nation's conscience, he used to bring to us moving human stories, many of which have stayed with me. His coverage of Varanasi as he did a programme on the constituency that Modi had chosen in 2014, focused not on the campaign but on the forgotten history of Banaras. So he took us to Lamahi, the village that Premchand grew up in and where his memory is preserved in a modest museum. This remarkable institution has a self-appointed caretaker (a Mishraji, if I remember correctly), who guided Ravish through it. The episode ended with Mishraji saying that he felt he had graduated from being a reader of Premchand's fiction to becoming a character from that world. Nothing, in essence, had changed herein for almost a century. The village and its people were still battling with the same social problems that Premchand describes so hauntingly.

There are two other episodes that I remember as vividly: one on the first Gandhi Ashram (now a crumbling ruin) set up somewhere in Meerut and the other on the condition of the poor patients who flock to Delhi's AIIMS for treatment. As they await their turn, several poor patients and their families lie on the pavement outside since they cannot afford to stay anywhere else. Here again, a Dr Dash took us with Ravish to the cancer section and explained how no one, no matter how poor, was ever turned away for lack of money. The purpose of this long recall is that there is still hope if only we are able to see it. However, since it is sexier to peddle stories of poverty, misery and social injustice, we have forgotten to register that India is multiple times the size of the small developed countries that have



you to some of the stories that come to us from there. The National Health Service (NHS) in UK is now in a state of terminal decline. Its doctors and nurses have gone on strike and in any case, it is so overloaded that even an urgent X-ray requires a long wait. Private healthcare is out of the reach of most, so unlike in India, where the neighbourhood 'dactar' provides immediate care (say nothing of the steroids being pumped into uneducated veins). We seem no worse off. It is almost the same in the US, where unless you are covered by expensive insurance, you can wait eternally for a kidney transplant or heart surgery. It is no wonder that medical tourism is now a widespread way to access quality medical attention in Indian hospitals. Go to any wellregarded private hospital in India and you will meet people from all over the world, accompanied by touts and translators, who take them to our best doctors and at a fraction of the cost abroad.

Come now to the shameful international reportage of our communal tensions. If we were to blindly believe all we hear and read, everyone in India is a bigoted bully. Yet, honestly speaking, is the Islamophobia in the US any better? Add to that now anti-Semitism, with university campuses across the US erupting in huge student protests, brutally handled by the police and university authorities. Let us not even speak of the rampant racism still practised all over the white world. I concede that comparisons are odious and that we have a shameful record on communal politics, yet how long shall we tolerate different rules applied to developing countries, simply because the big boys' clubs cannot make place for new entrants? My simple point is that we have all come a long way since 1947 and yes, some terrible mistakes and decisions were taken in those years but, by and large, when I look around the world and try to see one country that has a flawless record in upholding social justice, equality, brotherhood and love, I'm afraid I fail each time. As I said earlier, apart from Bhutan (that practises a form of benign monarchy), I can't think of another country that I would like to live in. Dynastic politics, feudal values, a deep commitment to one's faith, along with some religious intolerance towards those of another faith — these are the warp and weft of India. Trying to eradicate all evil forever will never happen, not at least in my lifetime. So the next time you open a toxic post or sign a public petition, don't think you've played your part as a responsible citizen. We still have a long journey ahead.

### **Muted voices**

Young women take a back seat in Haryana polls

WHEN the results of Haryana's 10 Lok Sabha seats that went to the polls on Saturday are out on June 4, they will, sadly, reflect the muffled voices of women voters in the 18-19 age group, drowned out by the louder participation of their male counterparts. For, the data from the Election Commission of India reveals a glaring gender imbalance: only 34 per cent of these first-time voters are women. Of the nearly 4.2 lakh such voters, a staggering 2.8 lakh are men. This disparity highlights the state's patriarchal character and deep-rooted societal biases, where the registration of young women as voters is often postponed until after marriage. Efforts by officials to encourage voter registration among

young women face resistance. Many families prioritise marriage over political engagement, reinforcing a cycle of



disenfranchisement. Making matters worse, women's political agency is further limited as men are often seen dictating their choices. Equally skewed is the

representation of women in the electoral fray. Of the 223 candidates in the contest in Haryana in the General Election, just 16 are women — including five from mainstream political parties — even though women constitute nearly 47 per cent of the voters. Major parties, despite their claims of supporting women's rights, have failed to field female nominees proportionately. However, there is a silver lining in certain pockets of the state. Women are beginning to voice their concerns on issues like water supply, electricity and employment; an increased female participation at public meetings has also been witnessed. But a lot remains to be done to bridge the gender divide and dismantle patriarchal structures. Amplifying women's

voices is essential for making India a truly transparent and inclusive democracy.

# When Nehru visited Hisar, and NDA

During our trip to the United Kingdom to meet our son last year, we also visited the grandson's school at Harrow. While showing us around, he pointed to the room where Jawaharlal Nehru had stayed as a student. It stirred some memories.

In 1951, the Prime Minister visited Hisar. My brother, commanding the military police unit, piloted the VIP cavalcade to various meeting venues. At the end, after the departing convoy was on the main road, he halted on the side and saluted as the PM's car passed. Within yards, the car screeched to a halt and reversed. Pandit Nehru came out, shook hands with my brother and said, "Thank you, young man, for all your help." My brother remembered that humane gesture all his life.Prime Minister Nehru was instrumental in selecting Khadakvasla (Pune) as the new site for the National Defence Academy and reviewed the first passing-out parade there in June 1955. He visited NDA again on May 14, 1961. The visit concluded with lunch in the cadets' mess. As per protocol, a visiting dignitary was seated between the Commandant and the Academy Cadet Captain (ACC). I was the ACC.

During the period, our only access to the world was through newspapers. Given our tight schedule, we only read the sports page. As a result, our horizon was limited. Since the PM would have had a discussion with the Commandant during pre-lunch hours, it was expected that he would spend more time interacting with me. The prospect was intimidating. No one had tutored me on what I should say or discuss. Such freedom was part of our grooming.

After receiving him in the foyer, I guided the PM to his seat on the centre table on a raised platform. Frail and slightly stooped, he had a handsome peach red



complexion. He must have realised the nervous apprehension of a teenager sitting to his right. The hallmark of a great person lies in his descending to the level of the other in conversation. This the PM did, starting with asking where I hailed from.

When I mentioned my village in Rohtak district, he

enquired whether we had electricity, roads, running water, etc. I told him of the stone-soled road with once-a-day bus service to the town and that we drew drinking water from the well. More than half the houses were mud structures. There was no electricity and I studied in the dim light of a kerosene lamp.

Maybe it was to put me at ease, he evinced keen interest in whatever I told him. On electricity, he said we woud be getting it soon; and we did, the very next year.He asked me about our life in the Academy. Here I was on firm ground. Emboldened by his easy manner, I ventured into asking, "Sir, why is India a poor country?" He smiled, giving no indication of my naiveté. Then he gave a detailed explanation of how we started at near zero at Independence. I suddenly felt the person sitting beside me was not only the PM of the world's largest democracy with a strong global presence, but was also a patient teacher, a gentle elder."Sir, won't the Bhakra Nangal Dam improve our irrigation?" I was in Class 8 when the dam was inaugurated in 1954.

'Yes, of course it will," he replied, predicting that Punjab would soon be India's food basket. He went on to elaborate the country's efforts at industrialisation and scientific progress. In fact, starting a worldclass defence academy itself was a great achievement, he mentioned.

When lunch finished, I guided him to the table where the visitors' book was kept. While getting down the approximately 12-inch step, he placed his hand on my shoulder for

support. I was suddenly emotional and saw a father figure in him. We were in North Kashmir when on May 27, 1964 — 60 years ago — news broadcaster Melville de Mellow announced the death of PM Nehru. 'What' and not 'who' after Nehru was the common concern of most Indians.

New Delhi: As storm clouds gathered, people battened down the hatches and sheltered in place, a lone boat ventured out to sea to capture Cyclone Remal on camera as it churned towards the coast, creating a now-viral video showcasing

the storm's immense power. The video, Homes, particularly those with thatched shot by a daring videographer from Bangladeshi daily The Daily Star, depicts a towering column of dark clouds rolling across a gloomy sky, casting an ominous shadow over the heaving Bay of Bengal. As the storm surges, thunder rumbles and strong winds whip up tidal waves.

Cyclone Remal made landfall on Sunday night, slamming into the coasts of West Bengal and Bangladesh between Sagar Island and Khepupara. The storm caused widespread devastation in both leaving a trail of destruction in its wake.

Heavy rains accompanying the storm led to waterlogging in several areas, further compounding the woes of residents. Farmlands were also inundated by floodwaters. Power supply was snapped in many areas in advance to avoid roofs, were severely damaged by the strong winds. Uprooted trees and downed power lines caused significant disruptions across the affected areas, and two people were killed in Kolkata. The Bangladeshi government evacuated 8 lakh people from vulnerable areas before the storm's arrival, moving them to shelters for safety.

The country's weather department had warned of potential high tidal surges and heavy rainfall in coastal districts like Satkhira and Cox's Bazar.

### Your rival is not your enemy': entertain BJP plea against order

New Delhi: The Supreme Court on Monday declined to entertain the West Bengal BJP's plea challenging a Calcutta High Court order that restrained it from publishing certain advertisements targeting the ruling Trinamool Congress in the state.Senior advocate S S Patwalia, appearing for the BJP, told a two-judge vacation bench of Justices J K Maheshwari and K V Viswanathan that the advertisements were based on facts.But Justice Viswanathan said, "We have seen the advertisements. Prima facie, the advertisements are disparaging. You can say you are the best... but...we don't want to lend our hands to promote further acrimony.""This is not in the interests of the voter," he said. "Your rival is not your enemy." Justice Maheshwari said, "Don't precipitate the issue. We are not inclined to interfere."Patwalia then chose to withdraw the petition saying he would file a reply before the single judge of the high court before whom it is pending. The apex court allowed this and dismissed the petition as withdrawn. On May 20, the single bench of Justice Sabyasachi Bhattacharyya restrained the BJP from publishing any kind of derogatory advertisements about the TMC that violate the model code of conduct till June 4 and until further orders. The high court noted that the advertisements published during the "silence period" (a day prior to the polling day) were violative of the model code of conduct and also impinged on TMC's rights and also the citizens' right to free and fair elections. The single-judge bench also criticised the Election Commission of India for "grossly failing" to address complaints filed by the TMC against the BJP advertisements that targeted the ruling party in West

### Jihadis across border supporting SP, Congress: PM Modi

Deoria. Prime Minister Narendra Modi on Sunday claimed that "jihadis" across the border are supporting the Samajwadi Party and the Congress who are appealing for "vote jihad" in the country. Addressing an election rally here in support of BJP candidates in Bansgaon and Deoria Lok Sabha seats, he alleged that the INDIA bloc does not want to take the country forward, but back by several decades, "Their agenda is not the development of India," Modi said.In Pakistan, 'duas' (prayers) are being made for the INDI alliance of Samajwadi Party and Congress. Jihadis across the border are supporting them. The SP and the Congress are making an appeal for 'vote jihad' here," said the prime minister in an apparent reference to a remark by an INDIA bloc candidate.

He said, "This (INDIA bloc) group is saying that if they come to power, they will reimpose Article 370 in Kashmir. They will repeal the CAA (Citizenship (Amendment) Act) which gives citizenship again to the victims of Partition. Whose agenda is this... this is what these anti-India forces want? Modi went on to allege, "Their agenda is not the development of India. They want to take back the country by several decades.' Hitting out at the bloc, Prime Minister Modi claimed the "INDI jamaat" has been abusing him for his opposition to reservation on the basis of religion."I want to remind you that in 2012, the SP in its manifesto had stated that Muslim should get reservation equal to that of Dalits. The INDI jamaat wants to change the Constitution for this. When I ask them (about reservation) they abuse Modi," he said, adding he is opposing reservation on the basis of religion.He accused the SP of doing "dynastic politics". "In the (tenure of the) SP government, mafias had built palaces on public land. But since Yogi Adityanath has come (as chief minister of Uttar Pradesh) the environment has changed. Now, the good days of mafias are over. Houses of the poor are being built in place of their palaces. This is the difference between the BJP and the INDI alliance," he said. Modi also alleged that the Congress "created roadblocks for countries that wanted to purchase BrahMos missiles". Accusing the Congress of always playing with the country's security, the prime minister said, "Our country makes BrahMos missiles and the day is not far when BrahMos missiles will be made in Uttar Pradesh."

A grand wedding ceremony was scheduled later this year. Their bodies were burnt beyond recognition. While Akshay's body was identified with the help of the ring he was wearing, the bodies of Khyati and Harita have been sent for DNA testing. The

# Parents of seven babies who died in Delhi hospital fire recount ordeal

With the postmortem reports of some babies still pending, some parents have yet to receive bodies.

New Delhi:"Allah ko pyaari ho gayi meri beti," said Ansaar, whose 11-day-old daughter was among the seven newborns killed in a blaze at a childcare hospital in Delhi. The fire broke out at the Baby Care New Born Hospital in Vivek Vihar area around 11:30 pm on Saturday and spread to two adjacent buildings. The Delhi Fire Services (DFS) had to deploy 16 fire tenders to douse the flames in three buildings. With the postmortem pending, authorities are yet to hand over Ansaar, his baby's body. The other six families are

"I saw my baby yesterday. She had a fever and was admitted to the hospital two days ago. This morning I was told about the fire", said the mother of 17-day-old Ruhi, who was killed in the fire. The grieving mother recalled that when she admitted Ruhi to the hospital she was wearing a "Najar ki mala" to wade off evil spirits. "They (hospital staff) removed that and the necklace. Ruhi was in a diaper", she said. Ansaar's daughter was born at another hospital on May 15. "She developed some health issues and was admitted to the hospital (Baby Care New Born Hospital) 10 days ago", he said"Allah ko pyaari ho gayi meri beti," he said and added that he learnt about the Parvinder Kumar, a relative of another incident from his friends. "When I reached, I came to know that my daughter had died." Ansaar said. For Masialam, a labourer, tragedy struck him again after five years."I lost my son five years ago. On Saturday, my newborn son died. What kind of facilities do they have?" he asked.Many parents sold their jewellery



or loaned money to pay for their children's treatment at the hospital, Masialam, the They did not answer questions about if the father of a three-year-old girl, said. He said his son was born at another hospital and was admitted to Baby Care New Born Hospital after he developed an infection.

### What to expect from the new government

**NEW DELHI** In a few days, the biggest democratic exercise in the world will determine the fate of the incumbent Narendra Modi government. No matter the next ruling dispensation, your money deserves a government that manages finances well. Your money is affected by the inflation and interest rates in the economy. You want your government to generate sufficient tax revenue to pay for adequate expenditure on infrastructure. While generating sufficient tax revenue, you want the new government to be fair to you as a taxpayer.

Taxing times

From the election campaign, you could pick up economic noises. The present government, led by Prime Minister Narendra Modi, promises more of the same for managing government finances and capital expenditure on infrastructure in the economy. They believe that investing in infrastructure could trigger economic activity and enhance productivity in the long term. On the other hand, the opposition parties want to give more money to the hands of people experiencing poverty to boost rural and urban consumption. All political parties are very clear about the fact that India is not a tax haven state. The opposition parties have spoken of redistribution of wealth from the rich to the poor. That means there would be little hope for lower taxes for those already paying them. However, the new government has much to consider in rationalising the existing tax system.

The goods and services tax (GST) monthly collection is at a record high for April 2024. The government is collecting the expenditure tax from everyone. It means no matter your income, you pay GST on everything you consume. That was the case before GST implementation, too. You paid a multitude of central, state and local body taxes.GST has combined everything and created a more straightforward administrative system. That has resulted in an efficient and high collection of indirect taxes. The government needs to bring down peak GST rates as revenue grows to give relief to the ordinary people.

On the income tax issue, it is a tricky situation. Significantly, few people in the country pay taxes. It is a truth that does not require any specific data. At the same time, the economic inequality in the country continues to remain elevated. Depending on the data you look at, there could be a possibility of a marginal decline in it. However, a paper by Thomas Piketty, a Nobel Laureate and three of his other colleagues argues that the inequality in India is rooted in the caste

The Chennai-based group, founded by the industry veterans Ramamurthy Thyagarajan, AVS Raja and T Jayaraman way back in 1974, is also into general and life insurance businesses, apart from wealth management, and real estate besides the cash-cow commercial vehicles, two & fourwheelers, gold loans, and small business loans. "We are looking at a strategic/financial partner for Shriram Finance. Though I have the board mandate to rope in a strategic partner, I haven't started negotiations with anyone yet. But yes, we are seriously looking at strategic investment, we have a huge growth opportunity in our business," the vice chairman Umesh ovind Revankar told TNIE in an interaction at his Mumbai headquarters without offering a timeline for the same and how much stake they are ready to pare except saying the holding company's 25% stake won't be diluted. When asked if it could be a PE partner, he ruled out they being the preferred choice saying "we aren't keen on roping in a private equity player; we would be keen on a strong group with deep pockets to be our financial and strategic partner". Explaining the rationale for looking at a non-PE partner Revankar said, normally PEs invest in listed companies and our holding company Shriram Capital is privately held.

NEW DELHI. The economy appears to have seen its slowest growth in a year during the January-March quarter due to weakened demand, according to a Reuters poll of economists.he slow growth highlights that the possibility of growth surpassing earlier forecasts remains low, indicating a cautious outlook among experts. The gross domestic product (GDP) increased by 8.4% during the October-December period, compared to the previous year, due to a substantial drop in subsidies, which increased net indirect taxes. However, economic activity, as measured by gross value added (GVA), showed a modest increase of 6.5%

Economists participating in the poll



indicated that such a scenario was unlikely to repeat in the last quarter.

The anticipated growth for Asia's thirdlargest economy is around 6.7% annually for January-March, aligning more closely with the long-term GDP growth rate. Gross value added (GVA) growth is expected to slow to 6.2%. The majority of economists highlighted moderation in both the manufacturing and services sectors, along with a muted contribution from agriculture, as reasons for the expected slowdown in growth. Forecasts for GDP growth ranged from 5.6% to 8.0%. The upcoming data release, scheduled to release on May 31, just days before general election results are announced on June 4, will be crucial.

unal Kundu, an economist at Societe Generale, said that there are chances for a return to stability in economic conditions. We expect some sanity to return. Among the components, we do not expect any major improvement. Core inflation continuing to drop and recording the lowest growth since the onset of the pandemic is symptomatic of weak domestic demand," Kundu told Reuters.

Despite averaging 7.7% growth last fiscal year, the forecast suggests a slowdown to 6.8% this fiscal year and 6.6% in the next, indicating that consistent 8% growth remains a distant goal for the world's fastest-growing major economy.

While many economists advocate for 8% or higher growth to adequately address employment needs for the burgeoning young workforce, there are doubts about the sustainability of such growth.

Miguel Chanco, chief emerging Asia economist at Pantheon Macroeconomics, said that a reasonable potential growth rate for India's economy lies between 5-6%. The divergence between financial economists' GDP forecasts and government estimates has also raised questions regarding how India measures growth.The National Statistical Office (NSO) projected GDP growth to be 5.9% in the January-March quarter, indicating a potential overestimation of the informal sector GDP, Dhiraj Nim, an economist at ANZ told Reuters. The informal sector, which contributes nearly half of the country's GDP and employs about 90% of India's workforce, highlightsthe importance of accurately assessing economic growth for comprehensive policy planning and implementation.

### All you want to know about KYC rule relaxation for MF investors

**MUMBAI.** As part of its efforts to increase "ease of investing", the capital markets watchdog Sebi early this month did away with two cumbersome KYC requirements, both for the mutual funds sector. One is the withdrawal of the mandatory requirement of linking the PAN with the Aadhaar from May 14, and the other is the doing-away of the mandatory inputting of a nominee in case if the MF investment account is a joint account from April 30.What's KYC registration?The know-yourclient (KYC) regulation is the process commercial banks, mutual fund houses and stock brokers are asked to verify an investor's identity before being allowed to invest in stocks or mutual funds or enter the equity markets through mutual fund schemes. In a revised circular issued on May 14, the regulator has done away with the requirement of the mandatory checking of PAN-Aadhaar link, offering a big relief to both existing investors as well as those looking to enter the market either directly into equities or passively through the mutual funds route—the

two investment avenues which have been rocking in recent months. Linking these two official identity documents enables an investor the all-important 'KYC-registered' status. In the second relief, it had done away with the mandatory nominee demand for joint MFs investments from April 30. And all that the regulator wanted from an investor was to prove her/his identity based on the 'officially valid document (OVD) such as the Aadhaar, passport, the PAN number or the voter ID card.'What's the MF nomination?

by which financial entities such as Nomination is a rocess of appointing a person to take care of your assets in the event of your untimely death. In case if you do not wish to nominate, you have the option of opting out of the process while filling up the form but with attendant difficulties later. When you have a registered nominee or when you complete the nominee registration process, it facilitates easy transfer of funds to your nominee in the event of your death. In the absence of a nominee, your heirs/claimants will need to produce a host of documents like a will, legal heir certificate, NoCs from other

legal heirs etc, to get your MF units transferred in her/his name.Earlier, if your PAN and the Aadhaar were not linked your KYC would be on hold, which means your investment cannot be withdrawn. But now, if your Aadhaar and PAN are not linked and if you still do Aadhaar-based KYC, then you will get a KYC-registered status. This is what the regulator has done away with the May 14 circular. Another requirement pertained to optional nominations for joint mutual fund accounts, which it has done away with through the April 30 circular. The Sebi circular dated April 30 states that the requirement for nomination in Clause 17.16 of the master circular for mutual funds is now optional for jointly held mutual fund folios. However, all other rules regarding nomination in the master circular from May 19, 2023, and the Sebi circular from December 27, 2023, remain unchanged. Had it not been done away with after June 30, 2024, which was the fourth extension, fund houses would have frozen those folios which don't have a nominee in

### Simulating Market Impact of Election Results

NEW DELHI I do not claim to be a political soothsayer or expert by any yardstick, and my area of limited domain expertise remains the financial markets. As I have often said before, usually the only thing tougher than predicting the markets is predicting an electoral verdict. While investing, one needs to be clinical and set aside one's political views and prejudices. Hence, let us embark on an electoral verdict

simulation exercise and its probable impact on the stock indices which have understandably turned volatile ahead of the election finale. Given that the ruling party and the formation it leads started this election as favourites and still remains so, we shall base all our hypothesis around the number of seats they might win.

Scenario 1: The ruling BJP secures 340-350 seats and the NDA Alliance crosses 370 seats (2/3rd majority ).hile the immediate reaction to this verdict might be euphoric, it could lead to a cooloff thereafter as the return to business as usual commences. Thereafter, a growth-oriented Budget powered by a two-third majority, could then propel the race of the Sensex to new highs. The 'continuity' factor that the equity market usually derives comfort from, will provide an additional booster. Scenario 2: The ruling BJP secures 290-315 seats and the NDA Alliance secures 315-345 seats (clear majority)

While the immediate reaction to this verdict might be muted given that expectations were running high at the outset, it could lead to a period of sideways movement as the market waits to gauge the direction provided in the Budget that follows. Scenario 3: The ruling BJP secures 240-265 seats and the NDA Alliance secures 272-290 seats (narrow majority)

While the immediate reaction to this verdict might be alarming, it could lead to a minor sell-off as the market waits to gauge which parties will help to form the government and the ministries they might extract as a result.

Scenario 4: The ruling BJP secures lesser than 210-230 seats and the NDA Alliance secures 235-250 seats (short of majority )While the immediate reaction to this verdict might be panic, it could lead to a sell-off as the market waits to gauge which parties will form the government and the ministries they might gain as a result. The choice of the finance minister in this case, more than the earlier simulated three scenarios, could well determine the mood of the market thereafter.Do any of these four simulations suggest that longterm investors need to react immediately before or post the electoral result? Methinks not. Given that the Indian economy is well poised to continue reaping the benefits of the economic liberalisation program initiated three decades ago, chances are that the Indian equity market which withstood the outflow of FII funds preelection could get a booster shot when they

# How will stock markets react if BJP wins 272 seats or more UBS explains

Lok Sabha elections: Brokerage firm UBS has shared four potential outcomes and their impact on the stock market.

Brokerage firm UBS recently indicated that it considers a scenario where the Bharatiya Janata Party (BJP) retains an absolute majority in the Lok Sabha elections to be highly probable.

The brokerage said in a note that this outcome is anticipated to propel the stock market indices, the S&P BSE Sensex and the NSE Nifty50, to new heights. However, if the opposition coalition INDIA (Indian National Developmental Inclusive Alliance) comes to power, it could negatively impact equities, with UBS warning of potential stock market valuation deratings and a return to pre-NDA valuation multiples.UBS noted in its analysis that

political alliances have historically played a crucial role in Indian elections. However, the BJP's dominance as a single party in the last two general elections has somewhat diminished the influence of coalitions in government formation.

The 2019 general elections saw the BJP securing a voter share above 50% in 222 out of the 303 seats won, with a victory margin exceeding 5% in 259 seats, accounting for over 85% of the total seats won. The opinion polls show the newly formed coalition, INDIA, may struggle to gain voter share as BJP's dominance seems to be continuing in the 2024 elections as well," UBS said.

The brokerage firm highlighted that any market underperformance triggered by election results tends to reverse in the medium to long term as investors and businesses adapt to new government policies."Despite the potential for nearterm election-driven uncertainty, we reiterate our view that any sharp weakness in equities could offer buying opportunities," UBS said.

Prevailing uncertainty

While opinion polls before the elections UBS outlined four potential election



suggested further seat gains for the BJP, the actual progress in the first five phases of the election has been less clear.

UBS observed that lower voter participation so far, coupled with a possible loss of voter share in key states such as Maharashtra, Karnataka, West Bengal, and Bihar due to regional political uncertainty, has raised questions about the NDA's ability to secure a third term.Despite these concerns, PM Modi and Union Home Minister Amit Shah have recently allayed investor fears, hinting at a strong win for the BJP in the ongoing general elections.

UBS on possible outcomes

outcomes and their implications for financial markets:

BJP retains single-party majority: Based on opinion polls, UBS assumes the BJP will retain its single-party majority. In this scenario, markets are likely to remain confident about policy continuity, with the potential for further reforms including disinvestment, the land bill, and the uniform civil code, depending on

the number of seats won. "Overall, we believe the financial market sentiment will likely remain positive," UBS said.BJP forms government with NDA majority: If the BJP fails to retain its single majority but forms a government with the NDA holding a majority (> 272 seats), markets could be slightly less confident about policy stability as fiscal consolidation could be slower than envisaged. There could be pressure from other political alliances, but overall macro stability could still persist, leading to a mixed impact on financial markets.

Hung parliament: In this scenario, the NDA fails to secure a majority.

foothold back into the contest. KKR chased down the target with 9.3 overs left in their innings. Shreyas lauded Mitchell Starc, who


