Sam Pitroda resigns as Chairman of **Indian Overseas Congress**

New Delhi, May 8: Congress leader Sam Pitroda on Wednesday resigned as the Chairman of the Indian Overseas Congress after his controversial remarks spurred the BJP to label the party

"racist". Congress general secretary Jairam Ramesh said on X that party chief Mallikarjun Kharge had accepted Pitroda's decision. "Mr Sam Pitroda has decided to step down as Chairman of the Indian Overseas Congress of his own accord. The Congress President has accepted his decision," Ramesh said in his post. The development came after Pitroda's choice of ethnic and racial identities like Chinese, Arabs, Whites and Africans at a podcast to describe how Indians from different parts of the country look triggered a political firestorm. The Congress swiftly distanced itself from his words, calling the remarks "most unfortunate and unacceptable". With campaigning in full

swing ahead of the fourth phase of polls, Prime Minister Narendra Modi led the BJP's all-out attack on the Congress on Pitroda's analogy and asserted that people would not tolerate the attempt to insult them on the basis of their skin



colour. At his rallies in Telangana and Andhra Pradesh, Modi said he is livid with the racial profiling of Indians by the US-based "philosopher and uncle of 'Shehzada". As the row erupted,

Congress general secretary Jairam Ramesh said on X: "The analogies drawn by Mr Sam Pitroda in a podcast to illustrate India's diversity are most unfortunate and unacceptable. The Indian

National Congress completely dissociates itself from these analogies."Ramesh later announced Pitroda's decision to resign and that the Congress president had accepted it. The BJP dismissed the Congress's disassociation from the controversial comments as it noted at a press conference that Pitroda has a history of making "insulting and demeaning" comments, including on terrorism and the 1984 anti-Sikh riots. Air India Express cabin crew go on 'mass sick' leave, 80 flights cancelled

New Delhi, May 8: Air India Express has cancelled more than 80 flights and scores of flights have been delayed as a section of cabin crew members have

reported sick to protest against the alleged mismanagement at the Tata Group-owned airline, sources said on Wednesday. The airline, which is in the process of merging AIX Connect (formerly AirAsia India) with itself, is to operate 360 daily flights during the summer schedule that started in the last week of March. An Air India Express spokesperson said the airline is engaging with the cabin crew members to understand the reasons for reporting sick and also apologised for the flight disrup-

tions. Discontent has been brewing among a section of the cabin crew at the low-cost carrier for some time now, especially after

the start of the merger process. The sources on Wednesday told PTI that more than 200 cabin crew are believed to have reported sick to protest against the alleged mismanagement at the airline. The cabin



tion of at least more than 80 flights since Tuesday night and scores of flights were delayed. Flight disruptions are happening

Calicut and Bangalore, they added. The sources also said there was chaos at some airports due to the sudden cancellation of flights, including to overseas destinations. "A section of our cabin crew has reported sick at the last minute, starting last night, resulting in flight delays and cancellations. "While we are engaging with the crew to understand the reasons behind these occurrences, our teams are actively addressing this issue to minimise any inconvenience caused to our guests as a result," the Air India Express spokesper son said in a statement. Apologising to

the customers for the "unexpected disruption", the spokesperson said those impacted by the cancellations will be offered a full refund or complimentary rescheduling to another date. Late last month, a union representing a section of the Air India Express cabin crew alleged that the airline is being mismanaged and there is a lack of equality in the treatment

Over 55% of final yr BCom students fail examinations

Mumbai: Over 55% BCom students have failed in their final-year exams conducted by the Mumbai University. The university managed to announce the BCom results in a record 24 days. While before the pandemic the success rate of BCom was over 60%, it dropped to 38% last year and this year it has gone up to 43.5%. However, results of a large number of students are also kept on reserve for not clearing lower exams and for unconfirmed admissions.Principal Marie Fernandes of St Andrews College said that they have been witnessing poor performance of students for the last two years. "Many students are simply not interested in studies. They are not regular in their attendance; many are unable to write answers. It is not just the final-year students, but we are seeing this trend across first and second year students too. In fact, teachers are holding multiple meetings with parents, who are taking cognisance of the problem," said the principal. At 95.15 per cent, TN tribal schools' Class 12 pass score improves

Among 35 schools across the state, 14 record 100% pass rate; 7 students score centum

CHENNAI: From the bottom of the performance table two years ago, the schools run by the tribal welfare department have come a long way, recording a pass percentage of 94.82 in

2023 and 95.15 this year. As per the data collated by the department, out of the total 35 schools, 14 have achieved 100% pass rate, compared to just 10 schools last year. Additionally, seven students have scored centum in various subjects against just one student who managed to get it last year.

In 2022, the pass percentage of class 12 students from tribal welfare schools was 86, lower than the 89 recorded by all the government schools. This year, out of the 1,402 students who wrote the examination, 1,334 passed. Among the 35 schools under the department,

including seven Ekalavya Model Residential Schools (EMRS), 10 government tribal residential schools and four EMRS schools achieved a 100% pass rate.A top tribal welfare department official said one of the main complaints against the department was there was no regular monitoring of the schools. "We changed that now and gave more importance to the schools. Results were reviewed after every examination and measures were taken to improve them," he

While the overall pass percentage are Teachers also said there is still scope for encouraging, only 8% of students



managed to score above 80%. About 47% of students scored between 60 and 79%, while 44% fell within the range of 35 to 59%. Headmasters and teachers working in the tribal schools said this is due to absenteeism and lack of proper primary education."About 10 to 20% of the students start working after class 10. We have to convince them to continue schooling. This apart, primary level education should also be strengthened to improve the results," said D Vijayan, Karumandhurai Governent Tribal Residential School

Got I-T notice? File your ITR or face scrutiny

Mumbai: If a taxpayer does not file an income-tax return in response to an inquiry notice, the case will be picked up for scrutiny. This notice — under section 142(1) — seeking information, is issued when a taxpayer has not filed the tax return or is issued to seek additional preliminary information regarding a particular detail — say bank interest or long-term capital gains/loss on sale of a property. This guidance is part of a comprehensive set of guidelines issued recently by the Central Board of Direct Taxes for compulsory selection of I-T returns for the purpose of complete scrutiny. These guidelines, which are issued annually, pertain to the selection and complete scrutiny that is to be undertaken during the current financial year and cover survey cases, search and seizure cases, tax evasion cases, cases where no I-T return was filed in response to an inquiry notice. It also covers cases relating to non-registration or cancellation of registration under various sections — such as registration under various sections — such as 12A/12AB relating to registration of charitable organisations to be eligible for tax benefit. In addition, if in an earlier year, an addition was made to the taxpayers' income on a recurring issue, then subject to monetary limits that have been laid down, the I-T return will be picked up under compulsory scrutiny guidelines. The guidelines also prescribe the role and responsibilities of the I-T officers and the National Faceless Assessment Centre Ketan Vaiani, a chartered accountant said Centre.Ketan Vajani, a chartered accountant, said



there is no significant change in the criteria for compulsory scrutiny as compared to the present position. "The guideline points out that all I-T returns filed during FY24, will have the outer time limit for issue of a notice by June 30, 2024."Complete scrutiny is a regular feature carried out in selective cases to ascertain whether the taxpayer has declared income correctly in the I-T returns and has paid the taxes due.

Fish processing units affecting quality of life: Pottaloorani villagers in TN tell SHRC to intervene

After the commotion and the minister's exit from the village, people said the police refused to arrest the goons who entered the village with weapons.

THOOTHUKUDI: Stating that three fish processing units are allegedly polluting the environment, thereby depriving them of good hygiene, fresh air and clean water, the residents of Pottaloorani village sought the intervention of the State Human Rights Commission (SHRC).Pottaloorani village, located in Ellainayakkanpatti panchayat, was in the news recently when the villagers decided to boycott elections on April 19. The boycott took a violent turn after the villagers denied entry to Fisheries Minister Anitha R Radhakrishnan, who came to appease them.In a petition to the SHRC chairman, the petitioner A Shanmugam, on behalf of the

villagers, demanded the permanent withdrawal of the licences of the three fish processing companies, claiming that they are adversely impacting their fundamental right to health and hygiene. Cases were also registered against the villagers after their confrontation with the police and goons on April 19. The villagers had demanded action against the



village administrative officer (VAO), alleging that the VAO had intentionally let a DMK-man, Perumal from Deivaseyalpuram, into the polling station at Pottaloorani for reasons best known to him, and that was the inception of disturbing public tranquillity on April 19, when the state went for Lok Sabha polls. The collector, who is also the district election officer (DEO), failed to address their

'reasonable demands' despite repeated requests. The government must act against the collector for failing to hold talks, which snowballed into a violent issue, the petitioners stated. After the commotion and the minister's exit from the village, people said the police refused to arrest the goons who entered the village with weapons. The villagers faulted the Pudukottai inspector and Thoothukudi rural DSP for failing to arrest Perumal, who was causing nuisance at the polling station, and sought departmental and legal action against both of them.

Besides, the protesters urged the SHRC to ensure protection from DMK functionaries Suresh Gandhi, Perumal and Mariappan, as well as the owners of the three fish processing units. Fearing attacks by the three DMK men, the villagers urged the SHRC to shift the functions of the VAO office, the revenue inspector's office and the panchayat office to Pottaloorani from

Deivaseyalpuram, to protect their rights.

Kerala varsities ready to roll out 4-year UG courses

THIRUVANANTHAPURAM: As the state's higher education sector is poised to fully implement the four-year undergraduate programmes starting this year, major universities have cleared the decks for the rollout of a variety of interdisciplinary and multidisciplinary courses. University of Kerala (KU) pioneered the four-year UG programme in the state last year by offering such a course in Politics and International Relations. This year, the varsity is set to roll out 15 more 'Four-Year Undergraduate Programme (FYUP) - Honours with Research' courses in science, arts, commerce and business administration. Students can choose their 'major' subject from any of the 16 programmes at the end of the first year of the four-year course. Along with it, they can

choose their 'minor' subject from as many as 51 innovative minor courses offered by the 44 teaching and research departments of the

university. The choice of minor subjects includes data science, data analytics, applied linguistics, cyber security, supply chain, bio-diversity, nanoscience, biotechnology, biochemistry, climate change, functional materials, machine learning and artificial intelligence. Unlike the conventional three-year degree course, the four-year programme provides students the option to pursue more than one discipline. If a student secures the required credit in a 'minor' subject, he or she can continue pursuing the subject at the postgraduate and research levels. According to KU Vice-Chancellor Mohanan Kunnummal,

a variety of online courses, skill development programmes, internships and research projects also form an integral part of the fouryear UG programme offered by the varsity."The Four-Year Undergraduate Programme (FYUP) - Honours with Research has been conceived to instil in students a multidisciplinary approach, social commitment and research aptitude. 4 nominations rejected, 26 candidates in poll fray

Gurgaon. Scrutiny of nominations for the Gurgaon parliamentary seat took place at the mini secretariat on Tuesday. Of the 30 candidates who filed their nomination papers, 26 were found valid, while four were rejected. The candidates had altogether filed 49 nominations. The rejected nominations belonged to candidates of major political parties, including Manita Singh (BJP), Rahul Yadav (JJP), Jitendra Bhardwaj (INC) and Mohammad Naseem (INLD). All four were covering the main candidates of their parties. According to deputy commissioner Nishant Kumar Yadav, who is also the returning officer, all nomination papers were scrutinised in the presence of candidates and their representatives. Reasons for rejections included deficiencies in the affidavit or incomplete columns in formds. During the nomination process from April 29 to May 6, candidates submitted varying sets of nomination papers, ranging from two to four. Yadav announced the list of 26 candidates whose nominations were found valid, which included prominent names such as Rao Inderjit Singh (BJP), Raj Babbar (Congress) and Rahul Yadav Fazilpuria (JJP). Vandana Gulia (Right to Recall), Shravan Kumar (SUCI-Communist), Lal Chand Yadav (Bharatiya Jawan Kisan Party), Vijay Kumar (Jan Sewak Kranti Party), Dharmendra Thakran (Swayam Shashan Party), Ishwar Singh (People's Party of India-Democratic), Akash Vyas (Bharatiya Shakti Chetna Party), Vijay Kumar (BSP), Samay Singh (Bahujan Mukti Party), Sampoorn Anand (Rashtriya Lok Swaraj Party), Saurabh Khan (INLD) and Anwar (Social Democratic Party of India) are also in the fray. The independent candidates include Fauji Jai Kawar Tyagi (Dixit), Ashok Jangra and Azad Singh, Rahul Thakran, Balwan Singh, Akshat Gait, Sony Hemlata, Ajay Kumar, Vishnu Yadav, and Kushever Bhagat.

The deadline for withdrawing nominations is 3pm on May 9. Election symbols will be allotted the same day. JJP candidate Fazilpuria held nearly 20 meetings at several places, including Raipur, Khijuri, Alwalpur and Bidwas on Tuesday and appealed to the people to vote for JJP in "favour of change".

Khattar hails bravery & patriotism of Mewatis as BJP steps up Nuh outreach

Gurgaon.BJP stepped up its outreach in Nuh on Tuesday, with Manohar Lal Khattar picking up from where he had left off at a public event in March — just before stepping down as CM — in which he said he worked the same for Nuh as he did for his home constituency Karnal.Speaking at the Vijay Sankalp rally in Ferozepur Jhirka, Khattar hailed the bravery and patriotism of Mewatis and described 16th-century freedom fighter Hasan Khan Mewati as an inspiration. Khattar had unveiled a statue of Hasan Khan Mewati in March.He also underlined the "unprecedented" work done by the central and state govts in Nuh, but expressed disappointment that despite this, it "does not let BJP win".

BJP, he said, works on the concept of "sabka saath, sabka vikas"."BJP is committed to the development of Nuh and welfare of its people. It deserves their support in the election," said the former CM while campaigning for five-time MP Rao Inderjit Singh, who is contesting for a sixth term from Gurgaon.

Nuh, where a majority of voters are Muslims, is part of the Gurgaon parliamentary constituency.

Khattar in his speech dismissed "featactics" of the Congress and claimed that BJP does not discriminate against any one on the basis of their religion. Saying that BJP considers "humanity, and not religion", Khattar cited the example of Prime Minister Narendra Modi's govt outlawing triple talaq.

"PM had consulted every one before making this decision... BJP govt works for the poor, youth, women, and farmers, irrespective of religion or caste. Welfare schemes have been implemented by the Modi govt without any discrimination," he said, claiming that Muslims have been safer under the BJP govt, which cracked down on communal riots since 2014.

Last year, six people lost their lives in violence that erupted during a religious procession in Nuh on July 31 and fanned out to other parts of south Haryana, including Gurgaon. Nuh police had registered 61 cases and arrested 350 suspects in the weeks after the riots. Dozens of properties linked to alleged rioters were bulldozed in the days after communal clashes, though the district administration said action was taken as the structures were illegal.

Double whammy for city: Outages amid soaring heat

Gurgaon: At a time when the maximum temperature is soaring to nearly 42 degrees Celsius, residents across several colonies are grappling with erratic power supply. In Ardee City, power was disrupted around 10pm on Monday and restored after 16 hours, around 2pm the next day. Residents said the outages were caused by bursting of power cables and short circuits in meter panels at several areas in the colony on Monday night. An electricity pole also caught fire due to high power demand, they said.

While the colony's population has grown over the years, the power infrastructure has not been upgraded to meet the demand, according to residents. Besides the discomfort caused by the heat, the outages also disrupt water supply, further irking residents.

'We had a sleepless night on Monday due to DHBVN staff's apathy. Last summer, there were adequate transformers in the colony. But many transformers have been removed in the last eight months. This has overloaded the existing infrastructure, resulting in frequent blasts and fires. We are dreading the peak of summer. Both DHBVN and HVPNL pass the buck," said Chaitali Mandhotra, a member of Ardee City RWA.Panini Gupta, a resident of B block, said: "A cable was burnt last night, and DHBVN could only restore power after 16 hours. Even the battery of our inverter was drained and it was difficult to manage in the sweltering heat."Sushant Lok 1 has a simiar story to tell. The colony has been witnessing erratic supply over the past week.

MCG sets up teams to conduct checks & prevent fire outbreaks at landfill site

Gurgaon. MCG has constituted teams for time of their duties," said an MCG round-the-clock surveillance at Bandhwari landfill site to avert fire outbreaks. The action came after the National Green Tribunal (NGT) took suo motu cognisance of the fires broke out at the landfill site last month. They will also be keeping records of their observations, any reported incidents and actions taken to address them. It is mandatory for all the assistant engineers to attend to the eight-hour duty besides their regular work."The assistant engineers have been assigned the duties to prevent any possible fire incident and will have to be physically present at the

official privy to the matter."Responsibilities of the assigned assistant engineers include but are not limited to conducting regular inspections of the landfill site to identify potential fire hazards, monitoring temperature levels and other indicators that may suggest the onset of a fire, coordinating with relevant authorities and emergency services in the event of a fire incident and implementing preventive measures as per established protocols to mitigate the risk of fires," read the order issued by Nijesh Kumar MCG executive engineer -Swachh Bharat Mission. Admin nod for 2 hsg colonies to install 11 gates on internal roads

Gurgaon. Deputy commissioner Nishant Yadav has allowed installation of 11 gates in Vatika India Next and South City 1 after residents flagged security concerns. Residents of four colonies sought permission from the DC's office to install internal gates. After examining the applications, approval was given to install 10 gates in Vatika India Next Colony and one gate in South City 1 on the recommendation of the department of town and country planning (DTCP) and police, officials said on Wednesday. Police are yet to approve the other applications, due to which no decision has been taken yet on installation of gates in BPTP Astaire Garden and Experion colony off Dwarka Expressway. On March 29, DC Nishant Yadav held a meeting over installation of gates, in which permission was sought for 10 gates in Vatika India Next, one in South City 1, 10 in BPTP Astaire Garden and one in Experion. District town planner (enforcement) Manish Yadav, who is a member of the committee checking applications, informed Yadav that no comments had been received yet from police for BPTP and Experion Colony. "Due to this, no decision has been taken yet on the applications of these two colonies," Yadav said. According to norms, before installing gates or boom barriers in a colony, residents have to apply to the deputy commissioner and the office of district town planner (enforcement). following which the latter tables these applications in the meeting and a final decision is taken on the basis of committee members' opinions. A senior official from the district administration said, "Approval to install gates on internal roads was given after examining security concerns and impact on traffic movement in the area. RWAs and residents, in their applications, explained security concerns. Local police examined these and submitted a report to the DC," he said. Under the rulers, only internal roads

within residential blocks can be allowed to install boom barriers. "There has to be a security guard at all boom barriers so that it can be managed in case of any emergency. If gates have been erected in the past and with permission from a competent authority like HSVP, MCG or others, colonies must display the opening and closing hours and strictly follow the guidelines, failing which they may face action and permission may be revoked,"

Elon Musk on Canada's move to curb online hate content: 'This sounds insane'

World Tesla CEO Elon Musk has commented on a Canadian legislation that aims to curb online hate content and create stronger online protection for people in the country, especially children. The Independent newspaper reported that Musk on Tuesday retweeted a news article, which "appeared to be an untrue claim", that the legislation would give power to the police to arrest anyone who has ever posted hate speech, even before the bill was introduced in February this year.Community Notes is the X microblogging platform's crowdsourced fact checking service.

The bill, dubbed as the Online Harms Act, was introduced by the Justin Trudeau-led Canadian government on February 26."The bill would create stronger online protections for children and better safeguard everyone in Canada from online hate and other types of harmful content," the government had said in an official statement at the time."It would hold online platforms, including livestreaming and user-uploaded adult content services, accountable for reducing users' exposure to harmful content on their platforms and help prevent its spread."The legislation would also enforce the removal of content that "sexually victimises a child or revictimises a survivor and intimate content communicated without consent".

It will further increase the maximum sentences for illegal hate speech, while allowing citizens to report discriminatory speech to a human rights tribunal, which could entail a compensation up to 20,000 Canadian dollars or a fine of 50,000 Canadian dollars, the Independent reported.

Maldivian Foreign Minister Moosa Zameer to visit India on Thursday

World Maldivian Foreign Minister Moosa Zameer will visit India on May 9, in the first high-level trip from Male after the Maldives' pro-China president Mohamed Muizzu assumed office six months ago.

nnouncing Zameer's visit, the Ministry of External Affairs said it is expected to lend further momentum to the bilateral cooperation. The ties between the two countries came under severe strain in view of Muizzu insisting on withdrawal of Indian military personnel operating three military platforms in the island nation. India has already withdrawn most of its military personnel. President Muizzu had set May 10 as the deadline for withdrawal of the Indian military troops from his country.

'Moosa Zameer, Minister of Foreign Affairs of the Maldives, will be in India on an official visit on May 9," the Ministry of External Affairs (MEA) said on Tuesday.

It said Zameer will meet External Affairs Minister S Jaishankar for discussions on bilateral and regional issues of mutual interest."The Maldives is India's key maritime neighbour in the Indian Ocean Region and Foreign Minister Zameer's visit is expected to lend further momentum to the bilateral cooperation between the two countries," the MEA said in a statement.

The Maldivian foreign ministry said Zameer will hold talks with Jaishankar focusing on "deepening and expanding the longstanding" Maldives-India partnership."This is Foreign Minister Zameer's first official visit to India since assuming office," it said.

Stormy Daniels describes meeting Trump during occasionally graphic testimony in hush money trial

NEW YORK. With Donald Trump sitting just feet away, Stormy Daniels testified Tuesday at the former president's hush money trial about a sexual encounter the porn actor says they had in 2006 that resulted in her being paid to keep silent during the presidential race 10 years later.

Jurors appeared riveted as Daniels offered a detailed and at times graphic account of the encounter Trump has denied. Trump stared straight ahead when Daniels entered the courtroom, later whispering to his lawyers and shaking his head as she testified.

The testimony was by far the most-awaited spectacle in a trial that has toggled between tabloidesque elements and dry record-keeping details. A courtroom appearance by a porn actor who says she had an intimate encounter with a former American president added to the long list of historic firsts in a landmark case laden with claims of sex, payoffs and cover-ups and unfolding as the presumptive Republican nominee makes another bid for the White House.

Daniels veered into salacious details despite the repeated objections of defense lawyers, who demanded a mistrial over what they said were prejudicial and irrelevant comments.

"This is the kind of testimony that makes it impossible to come back from," attorney Todd Blanche said. "How can we come back from this in a way that's fair to President Trump?"

The judge rejected the request and said defense lawyers should have raised more objections during the testimony. The Trump team later in the day used its opportunity to question Daniels to paint her as motivated by personal animus and profiting off her claims against Trump.

"Am I correct that you hate President Trump?" defense lawyer Susan Necheles asked Daniels.

"Yes," she acknowledged. Daniels' statements are central to the case because in the final weeks of Trump's 2016 Republican presidential campaign, his then-lawyer and personal fixer, Michael Cohen, paid her \$130,000 to keep quiet about what she says was an awkward and unexpected sexual encounter with Trump in July 2006 at a celebrity golf outing in Lake Tahoe. Trump has pleaded not guilty

TikTok's Chinese owner sues US government over potential ban

Washington TikTok and its Chinese parent company ByteDance sued in US federal court on Tuesday seeking to block a law signed by President Joe Biden that would force the divestiture of the short video app used by 170 million Americans or ban it.

The companies filed their lawsuit in the US Court of Appeals for the District of Columbia Circuit, arguing that the law violates the US Constitution on a number of grounds including running afoul of First Amendment free speech protections."For the first time in history, Congress has enacted a law that subjects a single, named speech platform to a permanent, nationwide ban," the companies said in the lawsuit. The lawsuit said the divestiture "is simply not possible: not commercially, not technologically, not legally. ... There is no question: the Act (law) will force a shutdown of TikTok by January 19, 2025, silencing the 170 million Americans who use the platform to communicate in ways that cannot be replicated elsewhere."

The White House has said it wants to see Chinese-based ownership ended on national security grounds but not a ban on TikTok. The White House and Justice Department declined to comment on the lawsuit. The lawsuit is the latest move by TikTok to keep ahead of efforts to shut it down in the United States as companies such as Snap and Meta look to capitalise on TikTok's political uncertainty to take away advertising dollars from their rival.

Driven by worries among US lawmakers that China could access data on Americans or spy on them with the app, the measure was passed overwhelmingly in Congress just weeks after being introduced. Tik Tok has denied that it has or ever would share US user data, accusing American lawmakers in the lawsuit of advancing "speculative" concerns. Representative Raja Krishnamoorthi, top Democrat on a House committee on China, said the legislation is "the only way to address the national security threat posed by ByteDance's ownership of apps like TikTok.""Instead of continuing its deceptive tactics, it's time for ByteDance to start the divestment process," he said.



he law prohibits app stores like Apple and Alphabet's Google from offering TikTok and bars internet hosting services from supporting TikTok unless ByteDance divests TikTok by January 19.

The suit said the Chinese government "has made clear that it would not permit a divestment of the recommendation engine that is a key to the success of TikTok in the United States."The companies asked the DC Circuit to block US. Attorney General Merrick Garland from enforcing the law and says "prospective injunctive relief" is warranted. According to the suit, 58% of ByteDance is owned by global

BlackRock, General Atlantic and Susquehanna International Group, 21% owned by the company's Chinese founder and 21% owned by employees including about 7,000 Americans.

TENSIONS OVER INTERNET AND TECHNOLOGYThe four-year battle over TikTok is a significant front in the ongoing conflict over the internet and technology between the United States and China. In April, Apple said China had ordered it to remove Meta Platforms' WhatsApp and Threads from its App Store in China over Chinese national security concerns. TikTok has spent \$2 billion to implement measures to protect the data of US users and made additional commitments in a 90-page draft National Security Agreement developed through negotiations with the Committee on Foreign Investment in the United States (CFIUS), according to the lawsuit.

That pact included TikTok agreeing to a "shut-down option" that would give the US government the authority to suspend TikTok in the United States if it violates some obligations, according to the suit.

Donald Trump's classified documents trial start indefinitely delayed, says court

Washington Donald Trump's trial in Florida on charges of illegally keeping classified documents after leaving office has been indefinitely postponed, a judge decided on Tuesday, greatly reducing the odds he will face a jury in either of the two federal criminal cases against him before the November 5 US election. Trump, seeking to regain the presidency, previously had been scheduled to go to trial on May 20 in the documents case brought by Special Counsel Jack Smith, but the prosecution and defence had both acknowledged that date would need to be delayed.US District Judge Aileen Cannon, who was appointed to the bench by Trump in 2020, said on Tuesday the trial would no longer begin May 20 but did not set a new date. Cannon scheduled pre-trial hearings to run through July 22. Trump has pleaded not guilty to 40 federal counts accusing him of retaining sensitive national security documents at his Mar-a-Lago estate in Florida after leaving office in 2021 and obstructing US government efforts to retrieve them.



Trump is the Republican candidate challenging Democratic President Joe Biden, who defeated him four years ago.Smith faces significant obstacles to getting either federal case against Trump to trial before the election. Cannon is yet to rule on several legal issues crucial to the documents case and has signalled support for Trump's defence on some matters. In a separate case brought by Smith involving Trump's efforts to overturn his 2020 election loss, the US Supreme Court seems poised to recognise that former presidents have at least some immunity from prosecution over official actions. That outcome, mostly likely, would further delay Trump's election-related

allegations against him are covered by that legal shield.

Trump's lawyers had said a trial in the documents case should not start until after the election, but also suggested an August 12 date in response to an order from Cannon to propose a timeline for the case. Smith proposed a July start date. Trump's lawyers have worked to delay all four criminal cases he faces.

We're in this absolutely unprecedented situation where a defendant is potentially going to have the power to shut down his own prosecution," George Washington University law professor Randall Eliason, an expert in white-collar criminal cases, said.

US paused weapons shipment to Israel to head off Rafah offensive: Report

World The United States last week temporarily halted a planned weapons shipment to Israel due to concerns that the Israeli military was preparing for a major ground operation in Rafah, the southern Gaza enclave housing over a million Palestinians. The White House administration official told news agency Reuters that as Israeli leaders appeared to be moving toward a decision on a Rafah incursion, the US began a thorough review of proposed weapons transfers to Israel. The situation in Rafah has escalated, with hundreds of thousands of Palestinian civilians seeking refuge from combat in other parts of Gaza. US President Joe Biden's administration has been actively working to prevent a full-scale assault by Israeli forces in Rafah, the official said."The US position has been that Israel should not launch a major ground operation in Rafah, where more than a million people are sheltering with nowhere else to go," the official stated.

'Unlisted NCD redemption not capital gain, but interest income'

Mumbai: The Income-Tax Appellate Tribunal recently held that the differential sum between the proceeds received on redemption of unlisted non-convertible debentures (NCDs) and its purchase cost, will be treated as 'interest income' and taxed under the head 'income from other sources', in the hands of the investor. Thus, ITAT (Mumbai bench) also denied tax sops available for investment of long-term capital gains related proceeds in specified assets.Under a corporate insolvency resolution process, two private companies issued NCDs to banks against their outstanding loans. The issue was under the rehabilitation scheme sanctioned by the Board for Industrial and Financial Reconstruction. Later, the bankers pressed for recovery of the NCDs from the directors of the companies. K C Thackersey, one of the directors, purchased the NCDs from nationalised banks. During financial year 2009-10, he declared long-term capital gains on redemption of these NCDs. The I-T Act provides for tax benefits if on earning longterm capital gains, the proceeds are invested in a house property or capital gains bonds. As Thackersey had made such investments, he claimed a deduction under sections 54F and 54EC, respectively.Redemption of unlisted NCDs will not result in cap gains, but interest incomeThe ITAT ruled on NCDs, treating profit gap as interest income, not capital gains. Mumbai: From enforcement of anti-littering laws to open space development, from increased importance to be given to water quality index to accessible healthcare and affordable student hostels in the city, a manifesto developed by a youth-led organization working on improving electoral literacy, highlights some of the key issues plaguing the city. The organization, based on research, rigorous discussion and expert inputs, have divided their demands in three broad areas, including city & infrastructure, healthcare and environment. Health, environment & infra are key demands in youth manifestoMark Your Presence, an NGO, founded by Chaitanya Prabhu in 2018, is primarily managed by young students from across the city. The organization has been working with young voters in creating awareness and making college campuses voter friendly. Ahead of the elections, based on surveys with close to 1,000 students, it has drawn up an action plan for the political representatives. The idea was to bridge the gap between the youth and their elected representatives and to increase their participation in the democratic process. Prabhu, who conceived the idea of the manifesto document about a year and a half ago, said that many youths are politically aware and are interested in participating in the political discourse. "Documents like these are a reflection of youth's interest in the democratic process," he said. Among their long list of demands, divided in three sections, the students have asked for more open spaces, more employment opportunities from educational institutions, comprehensive waste management infrastructure, regulation of medical institutions, addressing the problem of ageing population, government grants for medical innovations, awareness workshops on health insurance, timely alerts and information on AQIs, better monitoring network, and incentives for cleaner energy sources. The NGO, which worked on the manifesto for over a year, not only took opinions from a diverse student population through questionnaires, held focused group discussions, but also took expert consultations. Housing expert and urban planner Chandrasekhar Prabhu, former dean of KEM Hospital Dr Avinash Supe and founder of Vanshakti and environmental activist Stalin Dayanand were part of the expert committee, which contributed to the manifesto. The organization also held workshops to ensure that their manifesto resonates with the grassroots. Feedback was also taken from the stakeholders and incorporated in the final

But there are others that are not doing well. The situation has become more stressed in these malls with vacancy

Multipronged strategy a must to curb data poisoning

DATA is a powerful weapon. It is a treasure trove of information. While data has been a driving force for civilisation in the 21st century, there has been an ever-growing trend of data reliance. In fact, data is the lifeblood of a marvel of the contemporary world — artificial intelligence (AI).

However, the training data of the AI models has become the Achilles' heel of this wonderful transformative technology. Tay, Microsoft's Twitter chatbot, is an early example of this. Tay's introduction on Twitter in 2016 was intended to aid in the development of her conversational abilities through human interactions. Tay was created to mimic a teenage girl but was removed from the platform within 24 hours for expressing racist, misogynistic and Nazi-loving ideas that she had picked up from other Twitter users. Tay is an early illustration of the potential dangers associated with training data issues. It is possible that a model's training data gets contaminated. A covert saboteur with significant ramifications has surfaced in the recent past: data poisoning. Adversaries can introduce biases, errors or unique vulnerabilities into the training dataset of an AI tool by adding, removing or altering certain data points. These vulnerabilities get manifested when the compromised model makes predictions or choices. An AI tool's output may thus become erroneous, discriminating or unsuitable if its dataset has been changed or distorted in any manner.

In the realm of AI innovation, data can play the role of a Trojan horse. Consider, for instance, that an AI model has been taught to identify suspicious emails or unusual behaviour on a corporate network. Successful data poisoning may make it possible for ransomware or phishing attempts to evade detection and get past spam and email filters. Similarly, accidents may arise from AI system errors in self-driving cars. Financial models distorted by biased data, medical algorithms misinterpreting distorted test results and facial recognition systems powered by biased datasets that greatly enhance the likelihood of falsely accusing members of a certain racial group of crimes are all at risk. These examples show how data poisoning can penetrate and skew the fundamentals of AI systems, leading to severe financial losses, reputational harm and moral ambiguities that undermine faith in technology.cholars are debating the nature of various types of data poisoning and potential countermeasures. According to Google research from July last year on various types of threats to AI systems, an attacker only needs to control 0.01 per cent of a dataset to poison a model. And because the datasets being used usually contain millions of samples, it is difficult to identify this kind of attack

Data poisoning as a defensive strategy is also garnering a lot of attention. Users are downloading Nightshade and Glaze, two freeware software programmes from the University of Chicago. While Glaze is a defensive tool that individual artists can use to defend themselves against style-mimicking attacks, Nightshade is an offensive tool that can be used to disrupt AI models that scrape their images as part of training data without permission. The University of Chicago's press department refers to Nightshade as the 'poison pill' because it modifies an image's pixels in a way that causes mayhem for computer vision while leaving the image intact for human eyes. By contaminating the practice data and by making some of the outputs of imagegenerating AI models useless — dogs turning into cats, cars turning into houses, and so on—Nightshade could harm subsequent generations of these models.

Trouble-torn Manipur needs an out-of-the-box solution

THE security situation in Manipur has become even worse a year after violence broke out. The only way out is for the principal stakeholders to come together and thrash out a way for immediate course correction.One must put into perspective three recent incidents in the state. Miscreants triggered an IED blast on a bridge on National Highway-2 in Kangpokpi district on April 24. The bridge connects Imphal with Nagaland's Dimapur. The highway is a major lifeline of the state and its severance has led to the stranding of over 100 trucks carrying essential supplies for the people of Manipu

Two CRPF personnel were killed in an attack at Naranseina in Bishnupur district on April 27. A camp of the India Reserve Battalion (IRB) was located about 200 metres from the area where the CRPF men were billeted. The IRB personnel were primarily from the Meitei community. The CRPF personnel were reportedly in the process of vacating the camp and only a platoon had been left behind.

It is possible that the attackers wanted to target the Meitei members of the IRB; as the attack was carried out in the dead of night, they mistook the CRPF camp for the IRB one.

However, the target could actually have been the CRPF — a throwback to the United Liberation Front of Asom's (ULFA) modus operandi during the mid-1990s, when the insurgent group went on a spree of killing Hindi-speaking people of Assam. The ULFA was keen to attract the attention of New Delhi, which it was successful in doing. A slew of MPs from Uttar Pradesh and Bihar had descended on Assam to provide succour to their Hindispeaking brethren. There was (and continues to be) a section of people among the Assamese population who are against outsiders setting up shop in that state. With regard to the Naranseina incident, lawlessness in Manipur has gone so deep that there are elements which are beginning to feel that New Delhi needs to be taught a lesson. It is important to note that Central paramilitary forces such as the CRPF and the BSF had not been targeted in the past.

The finger of suspicion for the IED explosion on the bridge and the attack on the CRPF camp was mainly pointed at Kuki militants. However, it could well have been anybody. In a state that has been careening out of control since May 3, 2023, almost every group has become militarised.

The third incident pertains to anarchy continuing under political patronage. Meira Paibis waylaid an Army Casspir vehicle after the column had



apprehended cadres of the Arambai Tenggol with illegal weapons. Hundreds of Meira Paibis surrounded the Casspir and were berating the soldiers. If the Army men had lost their composure, there could have been a bloodbath.


Assam has ushered in an era of peace as a result of well-honed teamwork. It is recommended that a Unified Command Structure (UCS) — as was the case in Assam — must be immediately formed for Manipur, Nagaland and south Arunachal Pradesh. It should be under the overall command of the General Officer Commanding of the Rangapahar-based 3 Corps. There must be one clear voice (naturally after due consultations) that should focus on strategy and ways and means for peace and normalcy to return.

Manipur is a house divided. The state police force is almost dysfunctional. It has abdicated its responsibility to a radical militia organisation which brooks no opposition. A DSP was picked up by the Arambai Tenggol, forcing some cops to lay down their arms. At this juncture, the police need leadership. Unfortunately, it is not going to emerge from within the force. The power over it has to be vested in a firm leader with strong organisational backing, such as the General Officer Commanding of 3 Corps. The Assam Rifles is doing a tremendous job, but it is being accused unjustly of being partisan. Residents of the Manipur valley had asked for its removal. The Armed Forces Special Powers

Act has been removed from many areas in Manipur, and one has witnessed the acts that non-state actors are perpetrating in the state. The Assam Rifles is already under the operational command of 3 Corps. But making it a part of the UCS would not only permit it to calibrate its operational moves with the Army, the Manipur Police and the Central paramilitary forces, but allow it greater manoeuvrability by way of robust intelligence gathering in consonance with other end users in the UCS.It is due to the overlapping issues that Manipur, Nagaland and south Arunachal are being clubbed. For instance, one cannot divorce the problem of valley-based insurgent groups' entry into Manipur with the help of the National Socialist Council of Nagaland-Isak-Muivah (NSCN-IM) from the manner in which the game will play out after the carving out of separate administrative zones. Similarly, the subterfuges in Tirap, Changlang and Longding districts of south Arunachal have to be seen in light of the support that the NSCN(IM) is receiving from the Eastern Naga National Government. The Indian state and its Army are powerful entities. They can face any challenge. The only step that New Delhi needs to take at this critical juncture is to empower its forces. The Army is capable of achieving the impossible. Manipur would be irrevocably lost if the present imbroglio is allowed to continue.

Extinguish the suffocating fumes in Nuh



In an interview last week, Defence Minister Rajnath Singh said the talks were progressing well. He expressed optimism that there would be a positive outcome. However, recent meetings have not witnessed any breakthrough; both countries have only reiterated their commitment

to maintaining peace and tranquillity on the ground and keeping the lines of communication open.



Beijing's troop buildup and infrastructure development along the LAC have not helped matters. This has left India with no option but to augment its military presence in the

border areas and develop infrastructure at a rapid pace in order to catch up with the Chinese. Even as the situation has remained stable but sensitive, as described by Army Chief Gen Manoj Pande, the shadow of the Galwan clash of June 2020 continues to loom large, keeping Indian and Chinese troops on their toes. Progress on the diplomatic front has been stymied by the inadequacy of the interaction between PM Narendra Modi and President X1 Jinping in recent years. Modi last visited China in 2018, while Xi has not travelled to India since the Mamallapuram summit of October 2019. The Chinese President also chose to skip the G20 summit hosted by New Delhi last year. The political leadership of the two nations needs to proactively engage with each other to reduce

the trust deficit. This holds the key to resolving the border dispute and ending the prolonged standoff.

An overreaction to student protests

Prestigious American universities have floundered in dealing with the situation

THE growing intensity of pro-Palestine protests by students in the US has led to an aggressive crackdown by administrators and the police in the form of arrests, suspensions and class cancellations. The demonstrators, who set up encampments in over 120 universities and colleges across the US, have been galvanised by the humanitarian crisis in Gaza and have called on their institutions to divest from Israeli firms. However, some Jewish students have called the protesters anti-Semitic and expressed concern about their safety. In the election year, politicians have stepped in to term the protests 'anti-Semitic' and demanded a crackdown. The protests are against the policies of the Israeli government, but somehow it is made out that they are against the Jewish community. In India, it is easy to understand the difference, but in the West, with its terrible history of murderous anti-Semitism, public opinion is often manipulated on the issue by the powerful Jewish lobby in the US.

The protests reflect that young Americans are more likely to oppose Israel's actions than the older ones. A Gallup survey in March found that 55 per cent of the Americans disapproved of the Israeli military action in Gaza, with 63 per cent of them in the age group of 18-34. Student protests can be sometimes immature, are always impassioned and often over the top. Indeed, students and protests often go hand in hand and are a hallmark of a flourishing democracy. But American adults, from the President downwards, seem to be failing their country. President Biden, under pressure from the left wing of the Democrats, has backed the students' right to protest, "but not the right to cause chaos". American students have a sixdecade-old tradition of protest. They were at the forefront of the anti-segregation movement in the 1950s and 1960s; they protested Free Speech limitations in Berkeley in 1964, thereafter the

retribution for the Hamas terrorist attack of October 7 has been wildly disproportionate. There has been little evidence that Israel has sought to apply discriminate force in its battle with the Hamas. Even its mentor, the US, has raised the issue of its humanitarian conduct with Israel. The International Criminal Court has been conducting hearings on the Israeli actions in Gaza. Separately, the International Court of Justice is hearing a case filed by South Africa, alleging Israel's violation of the international law by committing and failing to prevent genocidal acts. The US has a certain vanity about its traditions of free speech and expression, but when push comes to shove, there is a tendency to overreact. And this is what seems to have happened on many campuses. College and university administrators have not handled the issues very competently. The University of Southern California, for example, cancelled a valedictory speech by a top student who happened to be a Muslim girl, leading to an uprising that prompted the university president to call the police. The University of California, Los Angeles, had adopted a liberal approach and allowed an encampment, but summons by a Republican-led congressional committee probably panicked it into calling the police, who came in along with a group of non-student counterprotesters, triggering violence. Prestigious universities like Harvard, Columbia and Indiana have floundered in dealing with the protests and have hastily called in the police to tackle the situation. Some non-student provocateurs from the right and

the left have promoted violence, but even the New

York Police Department acknowledged that the

protests had been non-violent. In many instances, the

students have been joined by faculty members, who have criticised their administrators for mishandling the protests. While US colleges and universities like Brown University, Northwestern University and the University of Minnesota have brokered deals with the students, others like University of California (Berkeley) and Wesleyan College have allowed protest encampments.

The allegation of anti-Semitism in colleges has been taken up by the right wing in Congress. Acrimonious hearings by a House Committee have put college administrators on the back foot and forced some of them to resign. Two weeks ago, the Speaker of the US House of Representatives, Mike Johnson, himself descended on Columbia University and met Jewish students. At a press conference there, he called on the president of the university, Minouche Shafik, to resign and suggested that the National Guard be summoned to deal with the demonstrations.

More than two dozen Republican senators signed a letter calling on Biden to restore order to the campuses by using federal laws against "the outbreak of anti-Semitic, pro-terrorist mobs". Such labelling of protesters, most of whom have been motivated by the humanitarian concerns arising out of the deaths of around 35,000 Palestinians, more than half of them children, indicates the moral vacuum in the hearts of many contemporary American

politicians. Johnson has probably forgotten history in suggesting a militarised response to deal with peaceful protests. In 1970, the Ohio National Guard fired at and killed four unarmed students and wounded nine who were protesting against the Vietnam War at Kent State University. There is, of course, the irony of someone like Johnson calling for a 'law and order' crackdown, considering his support to the January 6, 2021, insurrection which attempted to violently overturn the results of the 2020 American

n a recent column, Edward Luce, US commentator for Financial Times, noted that while student protests could be "foolishness — or worse", it was American adults "who are making the biggest dunces of themselves". 

The Cuban Corner

cigar lovers. The Wall Of Rebellion

Now who would have thought that Miami would be home to some of the finest graffitis in the world. Wynwood Art District is for those who wish to step out of comfortable galleries and experience the maniacal thoughts that reside in the head of artists, who literally use the world as their canvas. Here you will find art in every imaginable form. From abstract art to geometric patterns that can only be created once your mind is pushed into an overdrive ... Wynwood has it all. The entire district is a massive canvas - you won't find a single wall or street that's not covered.

Tripping on art

Museums is something I am happy to give a miss. But when my charming tour guide



suggested a quick stop at the Perez Art Museum, we obliged, albeit grudgingly. What we expected: an hour-long snooze fest. The reality: a mind-blowing experience. This haven for modern and contemporary international art of the 20th and 21st centuries is unlike any other museum. From the first exhibit to the final one, there was not a single piece that didn't transfix us. From using light to mirrors and sound to miniatures, the works at Perez are such that they take you on a trip that's parallel to this universe, and yet not from our realm. Sounds absolutely bonkers, but Perez is a sensory overload that's a must-do in Miami.

The Wild Zone

Like most cities, Miami too has its own little paradise for animal lovers. The Jungle Island is a place that both kids and adults would love to visit. Built about 80 years ago, most of the

animals are kept in massive enclosures that mimic their natural habitats. You also get to spend quality one-on-one time with certain four-legged friends. Your head can be a dance floor for the a bunch of lemurs or your can get some much-needed TLC from a baby Capuchin monkey (the same breed that Ross had in Friends) - all-in-all a once-in-a-lifetime experience.

If you have a couple of days to spare, do visit Orlando. It might not have the glitz and glamour of Miami, but what it scores high on is a strong dose of testosterone in the form of some crazy simulation rides at Universal Studios. Also, if you have grown up binge watching cartoons, a trip to the Walt Disney World will rake up some memories.

Nordic adventure

My summer adventure in Iceland had a big plus point, the travel part apart. For company, I had a local writer, poet, social activist and a political adviser all rolled into one! I also got the chance to mingle with the natives, experience their culture (two weddings and a ceremony accepting me as an honorary Viking) and try some of Iceland's unique culinary treats like fermented shark, minke whale, puffin and, of course, Iceland's famous hot dogs.

Gushing start

Two hours from Reykjavik, is one of Iceland's most magnificent waterfalls Seljalandsfoss — that drops down from a height of 60 metres. Keep your rubber boots and raincoat handy if you want to walk to the big cave behind the falls. (If you are warm enough, you'll never want to leave this picturesque icy cold wonder.) Another 30 minutes of driving got us to another impressive waterfall, Skogafoss. Most tourists attempt a one-day hike from here to reach the famous Eyjafjallajokull volcano.

Blacked-out

When Halla mentioned a visit to a black beach called Reynisfjara, I didn't take her seriously. Not even after I was standing in the middle of this vast blackness! The black escapade continued with a hike to Svartifoss aka Black Waterfall. Why black? Because of the dark basalt columns here.

Eastern Fjords

Iceland's eastern coastline is full of numerous mountains, beaches and countless majestic fjords (long, narrow inlets created by glacial erosion), which are home to the country's diverse wildlife - wild reindeer, seal colonies, birds. The jagged, snow-capped profile of the



Eastern Fjords provides the first glimpse of Iceland. Each fjord looks more amazing than the last one, so take a deep breath and enjoy the ride. We were lucky enough to get to see a couple of swans strut around the Swan

Fjord, as it is known. The last stop was Borgarfjorour Eystri, a quaint little town that ended the trip on a high note - literally. The Daler Mehendi-crazy crowd here (yes!) threw a party for their "friend from India" and we danced all night to paaji's bhangra beats. In the end, words like beautiful, amazing, must-visit fail to describe my Iceland experience. Life altering comes close... perhaps.

The Nayab Singh Saini government cleared

a trust vote soon after he took over in March.

BJP's former ally Jannayak Janta Party (JJP) has offered support to the Congress. JJP leader and former Deputy Chief Minister Dushyant Chautala has said the government has lost the trust of the people. "We will support a move to bring down the government. The Congress has to decide if it will make a move or not," he said. This comes less than two months after the BJP parted ways with JJP, which has 10 MLAs, and cobbled together enough numbers

members. This means the majority mark is 45. The BJP has 40 MLAs of its own and is supported by three out of 6 Independent MLAs. This makes it 43, two short of the magic figure. The Congress has 30 legislators and three Independents now support it. If the JJP backs it, the Congress will have the support of 43 MLAs. This leaves two MLAs -- one from Haryana Lokhit Party and the other from INLD.

The Chautala Family Factor

An interesting subplot playing out amid the Haryana government crisis is linked to the Chautala clan that once dominated the state's political landscape before a string of poll setbacks, convictions and a split reduced INLD to a one-man party in the Assembly. Currently, INLD general secretary Abhay Chautala is the party's lone MLA in the Assembly. Now that the JJP, led by Mr Chautala's estranged nephew Dushyant Chautala has offered support to the Congress, the question is will Abhay Chautala remain on the same side or join ranks with BJP.



Maldivian Foreign Minister Moosa Zameer to visit India on Thursday

New Delhi: Maldivian Foreign Minister Moosa Zameer will visit India on May 9, in the first highlevel trip from Male after the Maldives' pro-China president Mohamed Muizzu assumed office six months ago. Announcing Zameer's visit, the Ministry of External Affairs said it is expected to lend further momentum to the bilateral cooperation. The ties between the two countries came under severe strain in view of Muizzu insisting on withdrawal of Indian military personnel operating three military platforms in the island nation.

India has already withdrawn most of its military personnel. President Muizzu had set May 10 as the deadline for withdrawal of the Indian military troops from his country." Moosa Zameer, Minister of Foreign Affairs of the Maldives, will be in India on an official visit on May 9," the Ministry of External Affairs (MEA) said on Tuesday. It said Zameer will meet External Affairs Minister S Jaishankar for discussions on bilateral and regional issues of mutual interest."The Maldives is India's key maritime neighbour in the Indian Ocean Region and Foreign Minister Zameer's visit is expected to lend further momentum to the bilateral cooperation between the two countries," the MEA said in a statement.

The Maldivian foreign ministry said Zameer will hold talks with Jaishankar focusing on "deepening and expanding the longstanding" Maldives-India partnership.

This is Foreign Minister Zameer's first official visit to India since assuming office," it said.

Live-In Relation Still A "Stigma" In Indian Culture: Chhattisgarh High Court

New Delhi: The Chhattisgarh High Court has said that the live-in relationship is an "imported" philosophy contrary to the general expectations of Indian tenets and that it is still considered a "stigma" in the Indian culture.

While dismissing a man's appeal for custody of a child born from a live-in relationship, a bench of Justice Goutam Bhaduri and Justice Sanjay S Agrawal recently observed that such a relationship is preferred over marriage because it provides a "convenient escape when things fail to work between partners". "The security, social acceptance, progress, and stability which the institution of marriage provides to a person is never provided by live-in relationship," the bench noted.

'The close inspection of society shows that the institution of marriage no longer controls the people as it did in the past due to the cultural influence of the western countries and this significant shift and apathy towards matrimonial duties has probably given rise to the concept of live-in relationship," the High Court said.

The petitioner, Abdul Hameed Siddiqui, a resident of Chhattisgarh's Dantewada, had sought custody of a child born from his live-in relationship with Kavita

Both were in a relationship for three years and got married in 2021 without conversion. A Dantewada family court had turned down his plea in2023, following which he moved to the High Court.He claimed that in August 2023, Ms Gupta had moved with the child to her parent's home, after which he moved to the court seeking the child's custody.Mr Siddiqui's lawyer said that both parties performed marriage under the Special Marriage Act, 1954, and since he is governed by the Mahomedan law, he is allowed to perform a second marriage and that his marriage with Ms Gupta was legal.

It was also contended that he would be the natural guardian of the child born out of such marriage, and was entitled to custody of the ward.Mr Gupta, however, claimed that a second marriage was not permissible in the facts of the case as his first wife was alive. Her counsel argued that Mr Siddiqui could not claim to be a legal guardian for a child born out of such a relationship. The bench observed that the provisions relating to more than one marriage of a Muslim man under their personal law "cannot be invoked before any Court of law unless and until the same is pleaded and proved".

AstraZeneca withdraws Covid vaccine globally: What happens in India?

New Delhi: Pharmaceutical giant AstraZeneca has announced the global withdrawal of its Covid-19 vaccine, Vaxzevria, citing a surplus of newer vaccine options as the primary reason.

The company has voluntarily withdrawn the "marketing authorization" for the vaccine within the European Union, and similar applications are expected to be made in other countries where the vaccine

was approved. The decision comes amidst ongoing legal battles faced by AstraZeneca over allegations that its vaccine, developed in collaboration with the University of Oxford, led to fatalities and severe injuries, including Thrombosis with Thrombocytopenia Syndrome (TTS).

However, the company has maintained that the withdrawal is not linked to the The vaccine, known as Covishield in court case or its admission of TTS side effects, but rather due to commercial



multiple, variant Covid-19 vaccines have since been developed, there is a surplus of available updated vaccines," AstraZeneca said in a statement, adding that this had led to a decline in demand for Vaxzevria, which is no longer being manufactured or supplied.

WHAT HAPPENS IN INDIA?

India and other low- and middleincome countries, was developed by

AstraZeneca and Oxford University in response to the coronavirus pandemic in 2020.It played a crucial role in the global vaccination effort, with independent estimates suggesting that over 6.5 million lives were saved in the first year of its use alone.

While AstraZeneca has voluntarily withdrawn the marketing authorization for Vaxzevria in the European

Union, similar applications are expected to be made in other countries, including India, where the vaccine was manufactured and distributed by the Serum Institute of India (SII) under a license.Sources within the Health Ministry told India Today that the Indian government has not purchased any Covid-19 vaccines in the last two years, and there is no indication of purchasing any more vaccines in the near future.

86 Air India Express Flights Cancelled As Crew Goes On "Mass Sick Leave"

New Delhi: At least 86 Air India Express flights were cancelled after the cabin crew members went on a "mass sick leave", official sources said on Wednesday. The international and domestic flights were cancelled after about 300 senior cabin crew members reported sick at the last minute and switched off their mobile phones

The Air India Express management is currently trying to reach out to the crew, who are protesting against the new employment term at the Tata Group-owned airline, sources said."A section of our cabin crew has reported sick at the last minute, starting last night, resulting in flight delays and cancellations. While we are engaging with the crew to understand the reasons behind these occurrences, our teams are actively addressing this issue to minimise any inconvenience caused to our guests as a result," an Air India Express

spokesperson said. We sincerely apologise to our guests for this unexpected disruption and emphasise that this situation does not reflect the standard of service we strive to provide," the spokesperson added. Guests impacted by cancellations will be offered a full refund or complimentary rescheduling to another date, the airline said. Several passengers took to their social media accounts and complained about the sudden cancellations of their flights. They said that they had "no information" about the cancellations.A "very disappointed" passenger on X said he had reached the airport when he was informed that his flight was cancelled.

"We apologise for any inconvenience. Please be informed that your flight has been cancelled due to operational reasons," Air India Express said in

response to his post.

According to sources, the crew at the Air India Express, a subsidiary of Air India, has alleged that there was a lack of equality in the treatment of the staff after the merger with Tata Group. They claim that some staff members were offered lower job positions despite clearing interviews. The crew has also alleged that the key parts of the compensation package have been modified or removed and that the airline management is shutting down the dissenting voices, sources said.

The airline is currently also in the process of merging AIX Connect (formerly AirAsia India) with itself. The crisis at Air India Express comes a month after Tata Group full-service carrier Vistara witnessed cancellations due to pilot woes. Discontentment had simmered among pilots at Vistara, which is in the process of getting merged with Air India, following the new contracts wherein there were concerns on rosters for pilots operating flights and a component of their salary

Chief Justice Shares He Was Caned In Class 5 And Why He Can't Forget It

Speaking at a seminar on Saturday, he recalled when he was caned at school for a small mistake.

New Delhi: While corporal punishment is now looked down upon as a cruel method to discipline children, it was very much a reality for generations that did their schooling decades ago. For Chief Justice of India DY Chandrachud, it wasn't different either.

Speaking at a seminar on Saturday, he recalled when he was caned at school for a small mistake"How you treat children has

a deep impact on their minds throughout their life...I will never forget that day in school. I was not a juvenile delinquent when my hands were caned. I was learning craft and didn't bring the right

sized needles to class for the assignment," he said. The Chief Justice, who was then in Class 5, said the way people treat children leaves a lasting impact on their minds."I still remember that I requested my teacher to cane my bum and not my hand," he added. Out of shame, he could not tell his parents and had to hide his injured right palm for 10 days."The physical wound healed, but left an everlasting imprint on the mind and soul. It is still with me when I do my work. The impact of such travesty on children is so deep," said the

The Chief Justice of India shared the Symposium on Juvenile Justice organised by the Supreme Court of Nepal in Kathmandu. While discussing juvenile justice, we need to recognise the vulnerabilities and unique needs of children embroiled in legal disputes and ensure that our justice systems respond



with compassion, rehabilitation and opportunities for reintegration into society, said CJI Chandrachud.

7 reasons to visit Kullu-Manali

From the snowy delights of Rohtang Pass to the soothing warmth of the surrounding thermal springs, there are several places to visit in Kullu Manali for nature lovers and thrill seekers. With its picturesque views of snow-clad mountains, river valleys, charming cafes and laidback vibe, this hill station in Himachal Pradesh is an immensely popular vacation spot with both domestic and foreign tourists. Its widespread appeal draws everyone from adventure sport enthusiasts and vacationing families and honeymoon couples and hippie backpackers. Here are seven places you must visit during your holiday.

Hadimba Temple

This wood and stone temple is dedicated to Hadimba, the wife of Bhima, one of the Pandava brothers from the Mahabharata. It was constructed in 1553, and is located in the middle of the Dhungri Park. The structure has a four-tiered pagoda-shaped roof, and a carved doorway that is embellished with figures of Hindu gods and symbols. Ghatotkach, the son of Bhima and Hidimba, is also worshipped as a sacred tree.

Gadhan Thekchokling Gompa

Manali houses a small Tibetan community, and has a couple of peaceful Buddhist monasteries. Built in 1969,

this prayer hall is decorated with wall paintings and contains a statue of Shakyamuni. Nearby, the Gelukpa Cultural Society Gompa has statues of 'boddhisatvas' and Buddhist lamas, and a workshop for Tibetan carpets.

Rohtang Pass

This snow-covered pass is located on the highway to Leh, and is only open from June to October every year. It lies at a height of 3979 metres, and offers spectacular views of glaciers, mountain peaks and the Chandra River. The pass is a gateway to Lahaul, Spiti, Pangi and Leh. Due to its increasingly popularity, the route to Rohtang is often clogged with traffic during the peak tourist season. However, once you reach, there are facilities for skiing and sledging near the pass, and plenty of photo opportunities for snap-happy tourists.

Naggar

The former capital of Kullu, this town lies on the left bank of River Beas, 21 kilometres from Manali. It was founded by Raja Visudhpal and remained the political centre until the capital was shifted to Sultanpur in 1460 AD. Its major attraction is a beautiful castle, which has now been converted into a heritage hotel operated by the Himachal Pradesh Tourism Development Corporation. The building was once the residence of the rulers of Kullu, and is an excellent example of western Himalayan architecture. It is made of wood and stone, and has carved doors and windows. There is a small museum, a temple and a nice restaurant within the premises. Naggar was also the home of Russian painter Nicholas Roerich, who lived here from 1929 till his death in 1947. His house has been converted into an art gallery, which exhibits his colourful paintings of the surrounding Himalayan ranges.

Solang Valley

Around 13 kilometres away from Manali, this pretty valley is a popular spot for adventure sports, especially skiing. Situated between Solang village and Beas Kund, it offers panoramic views of the surrounding snow-capped mountains and glaciers. In summer, it has facilities for paragliding, zorbing, mountain biking and horse riding. In winter, especially between January and March, it is used for skiing, snowboarding and sledging. It also hosts a winter skiing festival. The Directorate of Mountaineering & Allied Sports in Manali also organises basic, advance and intermediate level courses in skiing. For the less-adventurous, there are also plenty of walking trails all around.

Dharamshala

Top attractions in Dharamshala Best known as the base of the Dalai Lama in India, and its strong Tibetan influence, Dharamshala is a small hill station that lies on the spur of the Dhauladhar range high up in the Kangra Valley in Himachal Pradesh.

Bhagsunag

The Bhagsunag shrine is about as old as the Dal Lake, and originated around a myth about a great fight between the demon king (Bhagsu) and the snake god (Nag). It has been rebuilt more than once, and although it is presently covered in white tiles, there is something about the place that draws you in.

Sensex falls over 250 points, Nifty tumbles as market opens in red

New Delhi, Benchmark stock indices opened in red on Wednesday with volatility remaining high amid the ongoing Lok Sabha elections. The S&P BSE Sensex dropped 0.4% to 73,251.88 points, while the NSE Nifty50 declined 0.5% to 22,190 points. The volatility index surged by 7.7% to 18.32, marking a 15-month high for the third consecutive session. This spike reflects the prevailing uncertainty surrounding the national elections, persistent foreign divestments, and market analysts' responses to corporate earnings, all contributing to investor unease. Tuesday's trading saw notable volatility, with indices starting higher but ultimately closing lower by the end of the day.

V K Vijayakumar, chief investment strategist at Geojit Financial Services, highlighted that market pressure stems from election result uncertainties amidst widespread media speculation.

Pharmaceutical stocks declined by 1.2%, largely due to a 4% fall in Dr Reddy's shares despite reporting betterthan-expected fourth-quarter profits. Analysts observed that its core operations fell short of market expectations. Among the Nifty50 stocks, Coal India, Bharat Petroleum Corporation Limited (BPCL), Maruti Suzuki, Tata Steel, and SBI Life Insurance emerged as top gainers.Dr Reddy's, Larsen and Toubro, Hindustan Unilever Limited, HDFC Bank, and Asian Paints were the top losers during the market's opening.

Asian markets mixed as traders weigh rates outlook

HONG KONG. Asian markets fluctuated Wednesday as the latest rally ran out of steam due to a lack of major catalysts, while investors contemplated the outlook for monetary policy. While Europe enjoyed a firm session, Wall Street was a little more tepid after surging in reaction to Friday's below-forecast US jobs data, which ramped up bets on a Federal Reserve interest rate cut. With the next major economic release on inflation not until next week and many big-ticket earnings releases out of the way, investors are keeping tabs on comments from central bankers, hoping for an idea about their plans. There was limited data on corporate earnings to worry the markets, with no unexpected surprises and a lack of major US economic data in the days ahead," said Kyle Rodda at Capital.com.

Many have spent the year pushing back against market expectations for how many cuts will be enacted this year as inflation comes down, and with recent data suggesting that the battle still has a long way to go, they are sticking to their guns. The latest, Minneapolis Fed boss Neel Kashkari said that he thought borrowing costs would likely stay higher for some time so that officials could be sure prices were being brought under control and get inflation back to the two percent target.

"The most likely scenario is we sit here for an extended period of time. If inflation starts to tick back down or we see some marked weakening in the labor market then that might cause us to cut back on interest rates,"" he said, according to Bloomberg News. Indian domestic automobile retail sales surge 27 per cent year-on-year growth in April: **FADA**

NEW DELHI: Passenger vehicle retail sales in India rose 27 per cent year-on-year to 22,06,070 units in April as all segments, including passenger vehicles and two-wheelers, witnessed growth, industry body FADA said on Wednesday. The overall vehicle registrations stood at 17,40,649 units in April 2023. Passenger vehicle retail sales rose 16 per cent to 3,35,123 units last month as compared to 2,89,056 units in the same month last year. Similarly, twowheeler registrations increased 33 per cent to



16,43,510 units in April against 12,33,763 units in the same month last year. Commercial vehicle retail witnessed a 2 per cent year-on-year jump to 90,707 units in April. Three-wheeler sales rose 9 per cent yearon-year to 80,105 units while tractors witnessed growth of 1 per cent at 56,625 units in April.

'While some attribute this growth to the shift in Navratri to April instead of March last year, the overall increase was significant," the Federation of Automobile Dealers Associations (FADA) President Manish Raj Singhania said."Despite strong bookings nd customer flow, high competition, excess supply and discounting presented challenges for sustained growth. Additionally, the lack of new models in some portfolios impacted market traction," Singhania said. FADA said it collated vehicle retail data from 1,360 out of 1,503 RTOs across the country.

NEW DELHI: India's toy exports have hit the slow lane after showing spectacular rise since

After touching a peak of \$177 million in FY22, exports of toys have been declining ever since. As per the data collated by the Global Trade Research Institute (GTRI), toy exports have come down to \$152 million in FY24. Simultaneously, there has been a rise in imports. Toy imports have risen 81% since FY22 to \$65 million. As per the industry, the tapering off of exports could be attributed to slowdown in major markets like the US and Europe. The stagnation could be attributed to 'cost disability' that Indian manufacturers face due to high subsidies given to manufacturers in China and Vietnam. Talking to TNIE, chairman of Toy Association of India Manu Gupta said that India has achieved a certain critical level of toy exports, but in order to exponentially grow from here, the industry needs to overcome the cost disability it faces due to massive subsidies offered by countries like China and Vietnam. He says in order to grow toy exports in the country, the government should consider the request for a Production-Linked Incentive scheme for the sector. He also bats for a National Toys Policy for a comprehensive boost to the sector.

Ajay Srivastava, founder, GTRI, however, attributes the stagnation in exports to the inability of quality control measures to boost exports. "While quality control measures were primarily aimed at boosting local industry and ensuring safety, they did not significantly enhance India's toy exports," says Srivastava of GTRI. Introduction of higher import duties and the quality control measures has impacted the toy trade in India with imports falling drastically from \$304.1 million in FY19 to \$64.9 million in FY24.During the same time, exports increased modestly from \$109 million to \$177 million. However, by FY24, exports have decreased to \$152.3 million. While the share of imports from China dropped from 87% of India's total toy imports in FY19 to 64% in FY24, imports from other regions such as ASEAN countries, Sri Lanka, and the Czech Republic have increased during the period. Share of ASEAN countries in Indian toy imports at the end of FY24 was 16.7%, Sri Lanka 12.4%, and Czech Republic 4.7%. According to Manu Gupta of Toy Association of India, the increase in imports can be partly attributed to illegal imports in the guise of imports of toy components.

Kerala: Ageing weavers, low earnings leave Chendamangalam handloom in dire straits

KOCHI. Known as the best fabric in Kerala, the Chendamangalam handloom is struggling to hold on to its legacy. Even as its master craftspersons are ageing, Chendamangalam is finding it hard to attract the young generation of weavers into its fold. Among the 13 handloom societies in Ernakulam district, the Chendamangalam handloom sector in Paravoor taluk comprising five societies has an uphill task ahead: around 70% of their members are above 60. While a daily wage worker in the construction field earns Rs 900 to 1,200 a day, a handloom weaver receives merely Rs 250 to 300. Further, the lack of job security keeps the youth away from the sector, officials say.

The weavers in Chendamangalam, the ancient handloom village with Geographical Identification tagging, are known for their expertise in producing authentic Kerala attire like

the 'set-mundu' and the 'kasavu' saree for weddings, besides the common bath towel 'thorthu'." Handloom needs high subtlety, from boiling the yarn to turning it into a piece of cloth. Most of the societies are surviving with tiny orders. It's difficult to meet these orders by depending solely on an elderly workforce," says C S Saritha, secretary of the Kuriyapilly Handloom Society. The sector continues to survive because of various grants and allowances from the state government, which has been pending from 2019, she points out. As a representative of the 24-member handloom society, Saritha asserts the introduction of new products and designs can change the situation for the better.P A Sojan, a former secretary of the Chendamangalam Handloom Weavers' Cooperative Society, is concerned over the declining numbers of workers in the sector."Each

handloom society had more than 650 workers 15 years ago. Now the five societies in Paravoor are working with 600 to 650 workers and about 200 allied workers. Moreover, they are knitting less than 10% of the actual need," he says. If a worker weaves four metres (the normal size of a 'double mundu') a day, and if it is priced at Rs 1,000, the weaver gets only Rs 200 to 250 a day, Sojan points out."Through a power loom (mechanised loom), the production will increase and reach the market for Rs 250-400/dhoti. But it won't have the quality of handmade fabric," stresses Sojan, who has 42 years of experience in the handloom sector.He admits that government grants and allowances like the subsidies for hank yarn and chemicals, rebates for school uniforms, and grants for exhibitions and handloom machines upgrading help workers overcome some of their problems.

The sources also said that the crew members wanted to avoid chaos at airports. Meanwhile, efforts to reach out to the protesting cabin crew members have been fruitless so far.In a statement earlier, an Air India Express spokesperson said, "A section of



our cabin crew reported sick at the last minute, starting last night, resulting in flight delays and cancellations. While we the reasons behind these occurrences, our teams are actively addressing this issue to minimise any inconvenience caused to our guests as a result.""We sincerely apologise to our guests for this unexpected disruption and emphasise standard of service we strive to provide. Guests impacted by cancellations will be offered a full refund or complimentary rescheduling to another date," it added.

Missing for decades, Maradona's rediscovered Golden Ball trophy set to be auctioned in Paris

Paris. Diego Maradona's Golden Ball trophy from the 1986 World Cup has resurfaced. The award, which had been missing for decades, will be auctioned in Paris next month, the Aguttes house said Tuesday. Maradona, who died in 2020 at age 60, was awarded the trophy for his scintillating play at the tournament, where he captained Argentina in its 3-2 win over West Germany in the final in Mexico City. Before that, he scored the controversial "Hand of God" goal and the "Goal of the Century" in a 2-1 win over England in the quarterfinals.

The auction house said it expects the trophy

"to fetch millions due to its uniqueness." Maradona received the award - given to the tournament's best player - at a ceremony at the Lido cabaret on the Champs-%lysées in 1986. It subsequently disappeared, giving rise to rumors. Some say it was lost during a wild poker game, or sold to pay off debts, Aguttes said.

Others said Maradona had stored it in a safe in a Naples bank that was robbed by local gangsters in 1989, when he played in the Italian league. According to the story told by a reformed member of the mafia, the trophy was then melted down into gold pieces. "A



far-fetched theory, given that it was made of a gold-copper alloy," Aguttes said in its auction catalogue.

Aguttes said the trophy reappeared in 2016 among other lots that were acquired from a private collection at auction in Paris. "It was thoroughly investigated and authenticated as Diego Maradona's Adidas Golden Ball trophy," Aguttes said. The "Hand of God" goal came when Maradona punched the ball into England's net for his team's opener. Maradona was also a magician with the ball at his feet and four minutes later, he weaved through England's midfield and defense and then past goalkeeper Peter Shilton for what FIFA later declared the greatest goal in World Cup history.

"To say that this World Cup had it all would be an understatement ... it was also, and above all, the tournament where Diego Maradona really showed the world what he could do with his feet, and even with his hands," said François Thierry, a sports expert at Aguttes. Bidders will be asked to deposit 150,000 euros (\$161,000) to participate in the June 6 auction.

Dortmund won this year's semi-final second leg 1-0 at the Parc des Princes courtesy of a header by Mats Hummels, who also played for

Dortmund in the 2013 final. BVB advanced 2-0 on aggregate, having won the first leg with the same result. The 34-year-old, who joined Dortmund in 2012 after spending a decade as a youth player, will leave after the season with two German Cups but neither Bundesliga nor Champions League titles. 
