Attempting to stop evergrowing cases of cyber fraud in which citizens are losing hard-earned money, Department of the Telecom on Friday said directions have been issued to block 28,200 mobile handsets and immediate re-verification of 20 lakh mobile connections linked to these mobile handsets has been ordered. Failing re-verification of identity, the SIM card will be disconnected. Mobile handsets are blocked on the basis of their International Mobile Equipment Identity (IMEI) number that is unique to each handset. Telecom service providers have been asked to ensure a pan-India block on these 28,200 mobile handsets

and to carryout immediate re-verification of 20 lakh mobile connections linked to these mobile handsets, the DoT said adding that these SIM cards would be disconnected if re-verification failed. An analysis was carried out by Ministry of Home Affairs and State Police forces that identified these 28,200 mobile handsets were misused in cybercrimes. The DoT further analysed and found that a staggering 20 lakh numbers were used with these mobile handsets. This is not the first such instance of the DoT stepping in. The Lok Sabha was informed on February 6 this year that the government had blocked 3,20,000 SIM cards and 49,000 International Mobile Equipment Identity (IMEI) numbers reported

by the police.

Bijapur, May 10: Twelve Naxalites were gunned down in an encounter with security personnel in Chhattisgarh's Bijapur district on Friday, police said, taking the number of left-wing extremists killed in the state so far this year to 103. Two security personnel were also injured in an Improvised Explosive Device (IED) blast triggered by Maoists during the operation, they said. This was the third major strike on Naxalites by security forces in the last one month and comes three weeks after 29 extremists were killed in an encounter in Kanker district. Chief Minister Vishnu Deo Sai congratulated security forces and senior officials for the successful offensive in Bijapur. The latest gunfight took place in a forest near Pidia village under Gangaloor police station limits when a joint team of security personnel was out on an anti-Naxal operation, a police official said. Personnel belonging to the District Reserve Guard (DRG) from Bijapur, Dantewada and Sukma districts, Bastar Fighters, Special Task Force (STF), Central Reserve Police Force (CRPF) and its elite unit CoBRA (Commando Battalion for Resolute Action) were involved in the operation, he said.

#### intimidation). "There is sufficient evidence to frame charges against the accused," the judge said. The court, however, discharged Singh in a complaint filed by one of the six women wrestlers, citing lack of sufficient evidence in the complaint. The court will formally frame the charges on May 21. It also ordered framing of charges in the case against co-accused and former WFI assistant secretary Vinod Tomar. Reacting to the court decision, Singh said he will consult his lawyers and take a decision on whether to appeal against the order before a higher court or challenge it before the ACMM. "I welcome this decision of the judiciary. I had protested against the framing of charges but I did that within certain limits but now I have various options open to me. Either I appeal against the order or contest it. I will consult my lawyer and take a decision. I am not hurt, I was prepared for it. If the case continues, I will get an opportunity to present my side," Singh told PTI. Singh, an influential Rajput leader from Uttar Pradesh, has been denied BJP ticket from Kaiserganj Lok Sabha seat in the wake of the sexual harassment allegations levelled against him. The BJP has fielded his son Karan Bhushan Singh in Kaiserganj, his stronghold. The Delhi Police had filed a charge sheet in the case against Singh on June 15 under sections 354, 354A, 354D (stalking) and 506 of the Indian Penal Code.

## Indian Air Force draws up roadmap to outsource overhaul of 60 AN-32 aircraft to the industry

Chandigarh, May 10: The Indian Air Force (IAF) has drawn up a roadmap to outsource part of the repair and overhaul of airframes along with certain components of the Soviet-origin AN-32 tactical transport aircraft to the industry. The IAF is seeking proposals from the industry, including original equipment manufacturers and joint venture firms for overhaul processes as well as carrying out studies for technical life extension of the airframes and components beyond 40 years. Outsourcing is expected to commence this year. The IAF's defined requirement is to overhaul 60 AN-32 aircraft by the end of 2028-29 fiscal, with the average output being 15 aircraft per overhaul cycle. The AN-32 overhaul process includes a total of 11 stages, out of which five would be outsourced to the industry, air force sources said. These include disassembly of sub-systems and components, cleaning and paint removal, structural repair and refurbishment, re-assembly of sub-systems and final

painting. The work would be carried out at No. 1 Base Repair Depot (BRD) at Kanpur. While this depot is responsible for the repair and overhaul of AN-32 airframe and other components, the engines of these aircraft are overhauled at No. 3 BRD in Chandigarh. The IAF will provide the physical infrastructure, including work space and hangars, overhaul technology, training, specialised tools and test rigs, while the industrial partner will be responsible for provisioning manpower, general tools, spares and aggregates and ensuring safety protocols. Procured from the erstwhile Soviet Union, the twin-engine AN-32 turboprop began entering Indian service in 1984. A total of 125 aircraft were bought, out of which over 100 are said to be in service. These are heavily used for crucial air maintenance in northern and north-eastern sectors, besides performing other tasks such as tactical airlift, communication, para-troop training and disaster management.

New Delhi, May 10: A delegation of opposition party leaders on Friday met the top brass of the Election Commission (ECI) and raised its concerns over the delay in releasing voter turnout figures for the first two phases, and urged them to take action on complaints of model code violations by ruling BJP leaders during the ongoing polls. Samajwadi Party leader Javed Ali, meanwhile, raised the issue of a "red card" being issued by the Uttar Pradesh Police to people in the state, which they said is stopping many from exercising their franchise. The delegation included Congress leaders Abhishek Manu Singhvi, Salman Khurshid, TMC's Derek O'Brien, DMK's TR Baalu, JMM's Mahua Majhi, CPI's Binoy Viswam, and Ali among others. "We have a very distinguished gathering of INDIA alliance. Each party across India is represented. **TIRUCHY:** The fresh heart-shaped leaves plucked from the evergreen betel vine may be an essential ingredient for the auspicious rituals and ceremonies. But farmers from Karur, Tiruchy, Thanjavur, and Dharmapuri see their fortunes slip away in the adverse weather conditions and unprecedented water scarcity.Most farmers TNIE spoke to are at loss of words to explain how the heatwave-like conditions over the past few weeks coupled with the lack of availability of Cauvery water for irrigation

brought down their yield. Some say it is down by as much as 50%.K Rajmohan, a farmer from Thottiyam in Tiruchy, said those who took up betel leaf cultivation in the district are now buying water from tanker lorries to save their crop. "Because of the production loss, the revenue earned by the farmers does not cover the exenses incurred to raise the crop," he says.Since last June, farmers in Karur district have raised the crop on about 1,250 acres while its cultivation has been taken up on about 200 acres in Tiruchy, according to horticulture department officials.

Unlike other plantation crops, betel leaves are very tender in nature. This leaves it unable to endure the rising mercury levels," says K Ramasamy of Velayuthampalayam and secretary of the betel leaf farmers' assAccording to him,



the betel leaf cultivation began from June 2023. "The crop started yielding after two months. We can go for its harvest once every 20 days and it will keep yielding for three years. The crop is now a year old. It is the perfect season when farmers get higher vield. But the water scarcity and the scorching summer heat have reduced production. While we got about 200 bundles (of 2,500 leaves each) per acre last year, these days we get less than 100 bundles," he said.S Manimekalai, deputy director of Horticulture (Karur), told TNIE that the banks of the Cauvery and its major tributaries help raise nurseries for betel vine in Karur, Tiruchy and Thanjavur copious amounts of water. Most farmers irrigate betel-leaf crop by digging trenches, the official said."While the government is advocating for several

water management methods like sprinklers and drip irrigation, in the case of betel vine, no such method can be adopted as the crop is a creeper," the official added.

Thanjavur is a district where farmers undertook betel vine cultivation on a larger scale, covering around 6,000 acres, particularly in Kumbakonam and Papanasam and Thiruvaiyaru areas. Currently, they cultivated it on around 500 acres, a decrease from the few thousand acres cultivated sometimes ago.Kumbakonam, a

popular pilgrimage centre, is also famous for betel leaves. Farmers and traders say that betel leaves grown in Kumbakonam are considered the best, due to their freshness and strong quality.A wholesale trader of betel leaves in Kumbakonam, A Batcha, said this year's arrival was significantly lower compared to last year, attributing it to reduced production caused by prevailing temperatures. This had led to a price hike for the betel leaves. "Last year, we sold each bundle (containing 100 leaves) for Rs 80 to Rs 100. This year, we are compelled to sell them for Rs 120 to Rs 170 per bundle," Batcha said.

## Fierce battle on cards in **Ongole Assembly** segment

**ONGOLE:** The Ongole Assembly constituency, a key coastal region in Prakasam district, is the administrative capital of the district. With the highest number of voters (around 2.39 lakh), the segment plays a pivotal role in deciding the fate of the contenders in the coming elections

Further as a district headquarters and stronghold of fishermen folks, its political mood radiates impact throughout the district and a few surrounding places which fall into the limits of neighbouring Bapatla and Nellore district. Since its inception in 1951, a total of 17 elections were held from 1952 to 2019, which gave an opportunity for people to elect many great public leaders and political stalwarts like 'Andhra Kesari' Tanguturi Prakasam Pantulu, CR Reddy, BVL Narayana, S Jivaratnam Naidu and others. While YSRC has fielded sitting MLA Balineni Srinivasa Reddy, who won Ongole MLA seat for a record five times, TDP nominated Damacharla Janardhana Rao to win back the segment. Besides Balineni and Damacharla, Turkapalli Naga Lakshmi (Congress) and Tatiparti Venkata Swamy (BSP) are also in the poll fray.

The Ongole Assembly constituency has only two mandals-Ongole and Kothapatnam. The residents of the constituency have been suffering from scarcity of potable water for a long time as there is no sufficient surface water available in Ongole Municipal Corporation (OMC) limits. The Ongole Municipal Corporation (OMC) authorities are drawing water from the Kandula Obula Reddy Gundlakamma Reservoir as well as from the Ramatheertham Balancing Reservoir near Chimakurthy to fill-up two Summer Storage (SS-1 & SS-2) tanks to cater the drinking water needs of the people.With the efforts of MLA Balineni Srinivasa Reddy, the State government has sanctioned around Rs 400 crore for the water supply schemes and Jal Jeevan Mission (JJM) works are underway. Another major issue is the pollution plaguing Pothuraju Canal. To address this problem, around Rs 100 crore was sanctioned by the government to start the desilting, expansion and revetment works of the canal. ## Car registrations rise by40% this Akshaya Tritiya

Mumbai: New car registrations surged by around 40% in the past one week for special deliveries on Akshaya Tritiya compared to the festival period last year. There was a 22% rise in overall vehicle registrations during this festival period while the registrations of two-wheelers also rose by 19%, according to transport department statistics. The maximum number of cars, 489, was registered with the Borivli RTO, while Wadala RTO reported the highest number of bike registrations at 835, sources at RTO said.Car registrations rise by40% this Akshaya TritiyaNearly 1,500 new cars and over 2,700 two-wheelers were registered for deliveries. The purchase of new automobiles in Mumbai usually peaks during four days of the year -- Gudi Padwa, Akshaya Tritiya, Dussehra and Diwali. These are actually auspicious days for starting new ventures or making new purchases.hen it came to green vehicles, statistics showed that there were 162 new electric vehicles booked for Akshaya Tritiya while the registration of CNG vehicles was 546 at the four RTOs collectively in the past one week. Transport experts are worried about the increasing vehicular population on city roads, especially two-wheelers. While the total vehicle population in the city has crossed 46 lakh, there are around 13 lakh private cars and 28 lakh two-wheelers. The density of vehicles in Mumbai is one of the highest in the country at 2,300 vehicles per km.n official from the Federation of Automobile Dealer's Association, however, said that private vehicles have become a necessity and are no longer a status symbol. "It is fair for a family to have 2-3 cars. It can be an utility -- some elderly person cannot travel without a car or someone who needs a car to travel long distances daily. It is something that you need to use," he Experts indicated with the car population bursting at its seams and limited roads, the density of vehicles could shoot over 2400 vehicles per km and cars over 700 per km in 2024, If left unchecked. They added that if this is not

regulated by strengthening public transport and dissuading people from bringing private cars and bikes on roads, this could lead to more congestion, pollution and also delays in daily commute. ## **37 arrested for rioting at Pirana shrine**

Ahmedabad: The Ahmedabad rural police have arrested 37 people in connection with a clash between two groups at Pirana shrine after the graves of Imamshah Bawa and his family members were allegedly flattened by a faction of trustees. The shrine has been a symbol of Hindu-Muslim amity.

During the clash that occurred on Tuesday night, members of two communities pelted stones at each other, injuring four people including a cop. Superintendent of police (Ahmedabad rural) Omprakash Jat said, "So far, 37 people from both the communities have been arrested. More arrests will be made. Owing to some differences, one of the trustees flattened the graves of Sufi saint Imamshah Bawa and his family members, leading to stone pelting."Those arrested were booked under sections of the Indian Penal Code (IPC) pertaining to attempt to murder, rioting, and damage to public property among others, he said. The differences among the trustees on religious lines started becoming apparent over the last few decades, with the Muslim members

The department has also written to the CBSE Board and RTE officials under the Union education ministry, urging them to ensure admissions are carried out as per RTE requirements.Despite several warnings, the schools have not facilitated the admission of RTEallocated students. The district magistrate has also assured to look into the matter. Schools have been given one week's time. If they don't admit the students, actions will be taken against them. We will also urge the CBSE to withdraw their registration or affiliations, as RTE is a mandate that all schools must follow," said Raj Singh Yadav, in-charge at the basic education department, Noida.Currently, the third phase of RTE applications is underway in GB Nagar, with 1,500 applications received for admission to private schools. The district has 1,062 private schools with 16,516 seats reserved under RTE.Meanwhile, the education department has updated the U-DISE portal with the data of students for the academic year 2023-24. Students have been assigned permanent education numbers (PEN), but several schools lack a U-DISE code. Schools have been given a deadline of May 18 to apply for the same. Noida. The Noida Authority met builders of defaulter projects and CREDAI officials on Thursday and urged them to expedite the process to Developers of 15 projects, who owe a pay 25% of the revised dues under UP govt's rehabilitation package for stalled projects.Noida Authority CEO Lokesh M said of the 57 defaulter projects, developers of 20 have deposited Rs 170.8 crore, which is 25% of the total amount payable after relief from interest and penal interest approximately Rs 450 crore from these 20 builders altogether. A total of 1,604 registries are to be executed in these projects. So far, 530 have been completed," he said. The CEO said developers of four other projects have deposited a partial amount of Rs 53.7 crore of the 25% dues, which amounts to Rs 83.5 crore, and registry of flats in these projects would commence soon. Since Jan, the Authority collected Rs 224.4 crore as part of the govt package

The city is likely to get brief respite from the heat on Friday and Saturday, as India Meteorological Department (IMD) has issued a "yellow" alert for the city warning of thunderstorms with lightning. The thunderstorms are likely to be accompanied by gusty winds with speeds of 30kmph-40kmph, the forecast said.Meanwhile, Thursday's minimum temperature was 25.9 degrees Celsius, slightly higher than normal for this time but down from Wednesday's 27.8 degrees. According to the IMD forecast, the weather will be partly cloudy in the coming days with chances of rain, thunderstorms or dust storms, especially on Friday and Saturday. The maximum temperature during this period is anticipated to hover between 38 and 40 degrees Celsius.IMD officials said a fresh western disturbance is currently influencing the weather patterns in northwest India. Despite this, the city is unlikely to get any substantial relief from the heat. Residents should, therefore, take necessary precautions to stay cool and hydrated.Meanwhile, the air quality in the city continued to stay in the 'moderate' category on Thursday. The 24-hour average AQI was recorded at 152, an improvement from 189 on Wednesday.

Some parts of Delhi may witness very light rain or drizzle from Friday night to Monday under the influence of a western disturbance. The maximum temperature is likely to rise to 40 degrees Celsius on Friday, but it may dip again due to clouds, rain and strong winds.IMD's data shows that the maximum temperature was 38.8 degrees Celsius on Thursday. The minimum temperature was 26 degrees Celsius. The relative humidity oscillated between 41% and 69%."The mercury is likely to touch 40 degrees Celsius on Friday, but there is a possibility of drizzle during the night. However, day temperature may dip slightly to 39 degrees Celsius on Saturday. Light rain or thunderstorm has been predicted for Sunday," said an IMD official.

## Bread taken off shelves in Japan after consumers find 'rodent' in them

Tokyo, UPDATE Loaves of bread have been taken off store shelves in Japan after the remains of "a small animal" believed to be a rat were found.Production of the bread was halted at a Tokyo factory, with 104,000 packages being recalled, according to Pasco Shikishima Corp.The company apologised and promised compensation. We will do our utmost to strengthen our quality controls so that this will never happen again. We ask for your understanding and your cooperation," it said in a statement this week.Japanese media reports said at least two people who bought the bread in Gunma Prefecture, northwest of Tokyo, complained to the company about finding a rodent in the bread. The bread had been sold in various areas, including Ibaraki, Niigata, Kanagawa, Fukushima, Aomori and Tokyo, according to Pasco.

The company, based in Nagoya city, central Japan, also makes rolls, bagels and muffins.

Japan boasts relatively high food safety standards. But the nation has been rocked by food woes recently, including 1,000 schoolchildren sickened by milk and two people who got sick after eating steak at a restaurant, both earlier this month.Widespread food poisoning from a health supplement product broke out in March and killed five people.

## US refutes Russia's meddling charge: 'Don't involve ourselves in Indian polls'

- World "No, of course, we don't involve ourselves in elections in India," US State Department Spokesperson Matthew Miller said, refuting Russian allegations accusing America of meddling in the Lok Sabha polls.
- A day ago, Russia had claimed that the United States was trying to interfere in India's parliamentary elections and "unbalance" the internal political situation in the country.In a media briefing, Russian Foreign Ministry spokesperson Maria Zakharova also said the US was yet to provide "reliable evidence" of the involvement of Indian citizens in the foiled murder plot against Khalistani separatist Gurpatwant Singh Pannun."No, of course, we don't involve ourselves in elections in India as we don't involve ourselves in elections anywhere in the world. Those are decisions for the people of India to make," Miller said in a press conference.
- Speaking to reporters in Moscow, Zakharova called it 'Regular unfounded accusations by the United States against New Delhi."We see that they groundlessly accuse not only India but also many other states of violating religious freedoms, which are a reflection of the United States' misunderstanding of the national mentality, the historical context of the development of the Indian state and disrespect for India as a state," Zakharov added. However, refusing to comment on the alleged plot to kill Pannun, Miller said "There is a publicly returned indictment that contains alleged facts. They are allegations until they're proven before a jury that anyone can go and read. I won't speak to them here because, of course, it's an ongoing legal matter, and I'll leave it at that.'

Trump, 77, has pleaded not guilty to 34 counts of falsifying business records to cover up his former lawyer and fixer Michael Cohen's \$130,000 payment to Daniels, 45, for her silence ahead of the 2016 US presidential election about the alleged encounter. Trump has denied ever having sex with Daniels.Trump, the Republican candidate challenging Democratic President Joe Biden in the November 5 US election, has called the trial a politically motivated attempt to undermine his campaign.Prosecutors have said Trump's efforts to obscure the paper trail for the payment to Daniels corrupted the 2016 election in which he defeated Democrat Hillary Clinton by preventing voters from learning about a story that might have swayed their vote.After testimony ended on Thursday, Trump lawyer Todd Blanche once again asked Justice Juan Merchan to declare a mistrial on the basis of Daniels' testimony.Blanche argued that her detailed testimony about the alleged sexual

encounter, including her statement that Trump was not wearing a condom, had veered into territory that was irrelevant to the case and would prejudice jurors against Trump."This is not a case about sex," Blanche said. "This is not a case about whether that incident took place or didn't take place."Merchan denied the request, saying that because Blanche had argued in his opening statement on April 22 that the encounter never happened, prosecutors were allowed to try to rehabilitate Daniels' credibility."Your denial puts the jury in a position of having to choose who they believe," Merchan said. The judge also denied a similar



#### request on Tuesday.

In addition, Blance requested that a gag order restricting Trump's public comments about jurros and witnesses be loosened to let the defendant publicly respond to questions about Daniels' testimony.Merchan also denied that request, stating that other witnesses may see Trump's comments and become concerned that he would say similar things about them. Christopher Conroy, a prosecutor, suggested that the proper way for Trump to respond to Daniels would be to testify in his own defence. Trump before the trial told reporters he would testify, though it remains to be seen

whether he will do so."There is a proceeding here that this (gag) order is designed to protect," Conroy said. "If somebody wants to respond to something that's said in this room, that can happen in this room.

The judge has fined Trump \$10,000 for running afoul of the gag order 10 times, and said further violations could land him in jail.

DEFENCE SAYS DANIELS 'MADE ALL THIS UP'

In nearly four hours of cross-examination on Tuesday and Thursday, Necheles asked Daniels about her earlier testimony of the alleged encounter compared with versions in a book she wrote and interviews she gave over the years.

She asked Daniels why in a 2018 interview to Vogue magazine she did not mention that Trump's bodyguard had been outside the hotel room where the encounter happened.Daniels on Tuesday had testified that her awareness of the bodyguard's presence contributed to a power imbalance with Trump that left her feeling uncomfortable.

## 782 acre salt pan lands: HC upholds lease termination

Mumbai: Bombay High Court on Wednesday dismissed a suit filed in 2005 and upheld the termination of lease of 782 acres of salt pan land spread across Mulund, Bhandup and Kanjur Marg. Justice S V Marne directed the lease holder to hand over vacant lands to the salt commissioner.A Dadar resident, Vikas Walawalkar had filed the suit to challenge an order passed by the deputy salt commissioner terminating the lease of salt lands. Walawalkar had sought a declaration that the lease was valid for another 99 years. The dismissal could now pave the way for widening of Goregaon-Mulund Link Road (GMLR), as the BMC could not take possession of the requisite lands because of an interim order in the proceedings. The GMLR project is a connector between Eastern and Western Express Highway, said the BMC.

## Lowering the bar: KSEAB decreases pass mark from 35 to 25 per cent

BENGALURU: Despite the SSLC Board decreasing the qualifying marks from 35 per cent to 25 per cent, the total pass percentage of the state is just 73.4 per cent. This is the lowest pass percentage in the past four years, when the qualifying mark was 35 per cent.Karnataka State Examination and Assessment Board (KSEAB) is being widely criticised by educational experts for decreasing the qualifying marks instead of improving the overall quality of education in the state.

They also raised eyebrows about the future of students, and how well they can adjust in PUC if they cannot score the aggregate in Class 10.On Thursday, KSEAB, while declaring the results, announced that for academic year 2023-24, grace marks were increased from 10% to 20% in all subjects. The board called it a 'one-time measure for all three SSLC exams of 2024'. This change was attributed to the 30 per cent decrease in pass percentage since last year, which was at 83.89 per cent. According to officials, over 1,70,000 students were awarded grace marks under the new rule, bringing the pass percentage to 73.40 per cent. However, approximately only 54% of 8.5 lakh students have cleared the exams under the previous assessment. At least 78 schools in the state had zero students passing their boards, with Kalaburagi district recording the highest number of 18 schools with zero pass percentage

'Not Completed' vs 'Failed'

In an official statement, KSEAB said, "The



pass percentage has declined by 30% in the last one year. Hence, the government has decided to enhance normalisation in the interest of students, since webcasting is a new intervention." This has restored integrity and inculcated a habit of writing exams without resorting to unfair practices, defended Ritesh Kumar Singh, principal secretary, School Education and Literacy department. The system shows 'Not Completed (NC)' instead of 'Failed', for the 2,28,763 students who have not cleared this exam.KSEAB Chairperson Manjushree N told TNIE that only students in C+ (50-59%) and C (35-49%) grades have benefited from the grace marks, which was done to encourage them to perform better in the forthcoming exams. "As far as the total of 625 is concerned, a student needs to score at least 175 aggregate marks to qualify for grace marks. But this year, the bar was dropped to 125 marks. We saw that some students had scored 175 and above, but failed in some subjects. To help them move to the next class, grace marks were introduced. The aggregate will still be 35 per cent only. Next year, this system won't be necessary," he explained Educationists, principals and private school associations have questioned the department's move. "The department has failed to provide quality education. Poor quality education should not be encouraged," said secretary of Associated Management of Primary and Secondary Schools in Karnataka Shashi Kumar D.President of the Karnataka

Private School College Parent Associations Coordination Committee, Yogananda BN said, "Why were grace marks introduced in the first exam when students still have two more attempts? How will children adjust in PUC if they cannot score the aggregate in Class 10?" Tie for Second rank, Both girls aspire to

## Tata Sons doubles royalty fee to 200cr

Mumbai: Tata Sons, owner of the Tata brand, has doubled the royalty fee - paid by its operating companies - to Rs 200 crore. Companies like TCS, Tata Steel and Tata Motors pay the royalty fee for using the Tata name.Tata Sons has doubled the fee five years after fixing it at Rs 100 crore. Simultaneously, the holding company of Tata Group is ramping up its brand-building exercise through the title sponsorship of IPL, among other initiatives.TCS, in its notice to shareholders, revealed that it made a royalty payout of Rs 200 crore to Tata Sons in FY24.Tata Sons chairman emeritus Ratan Tata had introduced the brand subscription scheme in 1996 that required a group company, using the Tata name directly, to shell out 0.25% of its annual revenue or 5% of its pre-tax profit, whichever was lower, whereas a group entity, using the Tata name indirectly, has to pay 0.15% of its annual revenue. In 2015, Tata Sons, then led by the late Cyrus Mistry, capped the maximum brand subscription fee at Rs 75 crore. This was subsequently increased by 33% by current chairman N Chandrasekaran. For fiscal years 2023 and 2022, TCS shelled out Rs 100 crore each to Tata Sons.

A source said besides revising the upper limit to Rs 200 crore, Tata Sons has done away with the fee based on a company's pre-tax profit. In other words, an operating entity has to pay 0.25% of its annual revenue, with the maximum fee now set at Rs 200 crore.Brand subscription fee is one of the revenue streams of Tata Sons. In FY23, it earned Rs 1,008 crore as brand subscription income. This kitty has swollen over the years as fortunes of operating companies changed drastically with multi-billion-dollar businesses built through acquisitions and expansions. Tata Sons' FY23 brand subscription income saw a jump of 23% from Rs 820 crore in FY22. The holding company uses the brand subscription fund to promote and protect the Tata brand, which is worth \$29 billion (about Rs 2.4 lakh crore), according to international consultancy firm Brand Finance.

Tata Sons doubles royalty fee to Rs 200 croreTata Sons increased the royalty fee to Rs 200 crore for operating companies. Brand promotion includes IPL sponsorship. Brand Finance values the Tata brand at \$29 billion, with revenue streams from the fee reaching Rs 1,008 crore in FY23.

## Kathakali artist in Kerala takes crash-course route to popularise the art form

THRISSUR: With its origins around the 16th century, kathakali is a classical performance art that combines dance, drama and music, and is rightly considered a national treasure.But society's unfettered march towards modernity has left practitioners worried about the art form losing its popularity and old-world charm. Realising the predicament, KalamandalamRajeev decided to do something about it. He developed a kathakaliappreciation course that has been piquing people's interest in the art form and its nuances.Despite its traditional underpinnings, kathakali can be considered part of the state's pop culture, featuring in movies, endorsement campaigns and tourism promotion efforts. Yet performers accept the fact that its audience is shrinking. Rajeev's online course is an attempt to reverse the trend, by popularising the art form by sharing its stage magic. "It began during the

Covid days when everybody was locked up in their houses with nothing to do. While it was started as a lockdown activity, the response I received became the fuel to take it forward," shares Rajeev. In the last four years, more than 500 people have taken the six-month course, with some even inspired to pursue learning the art form. "The classes have been meticulously

## Budget tourism project a hit, KSRTC now eyeing expansion to Tamil Nadu, Karnataka

KOCHI: KSRTC's budget tourism project is going great guns. Things are so rosy that the state-run carrier is now planning to expand its list of destinations in its tour packages by including popular spots in neighbouring Karnataka and Tamil Nadu."We have placed two proposals each before the RTCs of both the states," said Sunil Kumar, state coordinator, KSRTC (budget tourism)."One proposal is that KSRTC applies for temporary permits for its buses to conduct destination tours to these states. The second proposes a collaboration, under which we will take tourists to the Kerala-TN or Kerala-Karnataka borders. From there, they will proceed to the destinations in buses arranged by the respective RTCs," Sunil said.

Hill stations Ooty and Kodaikanal, besides Rameshwaram, Vellankanni and Kanyakumari, in TN, are the destinations shortlisted, said Sunil.As for the rates, he said, "Since the proposals are mooted under our budget tourism project, the charges will be commensurate to the rates charged for present tours." KSRTC is expecting a very good response to its proposed tours to the neighbouring states once they are rolled out.As of now, KSRTC's budget tourism has been a huge success. "From its inception in November 2021 to March this year, we have generated Rs 39 crore in revenue from 10,500 trips. A total 5.95 lakh people availed the trips," Sunil said.Meanwhile, KSRTC is also exploring a tourism collaboration with the IRCTC that covers inbound and outbound travellers, said Sunil. "In the case of inbound travellers, KSRTC has proposed picking up tourists from railway stations and taking them to destinations listed in their tour packages. For outbound tourists, KSRTC will provide them the facility to book IRCTC's tour packages," he said.On the city tour programme started in Thiruvananthapuram, Sunil said the project, which employs a double-decker electric bus, has



received wide acceptance in the two months of its launch."We are monitoring the progress of the project, but as of now, things are looking very good," Sunil said.Considering the

programme's initial success, KSRTC is studying the viability of launching similar projects in Ernakulam and Kozhikode, he said."Studies are on to determine the most viable routes for the tours. In Ernakulam, it has been observed that people are more into visiting coastal areas. There is the question of getting buses though.

The Thiruvananthapuram city tour bus was launched with the help of Smart City Mission. We are looking into something similar in Ernakulam and Kozhikode as the buses are very costly. Converting our old double-decker buses into electric vehicles and using them for the project is another possibility being explored," Sunil said.

Like many things, KSRTC's budget tourism project also faced some setbacks in the past few months, Sunil said. "Closure of tourist destinations in Wayanad and the heatwave did affect our operations to some extent," he said.

## aPeace elusive without unanimity

WORLD history of the past 400 years shows that geographically large nations have been relatively benign or far less aggressive compared to countries with smaller territories. The latter have demonstrated a peculiar penchant for worldwide expansion conquering, killing, plundering and profiting while redrawing maps and dividing weak nations.Take today's 10 biggest nations in terms of area — Russia, Canada, the US, China, Brazil, Australia, India, Argentina, Kazakhstan and Algeria. They are no match for nine particular countries/empires -Portugal, Spain, Britain, France, Italy, Germany, Denmark, Belgium and the Netherlands — when it comes to overseas aggression and transcontinental imperial conquests.Barring the post-1945 hostile posturing of the US and the post-1949 Chinese belligerence, the 'big 10' have largely avoided any activity aimed at intercontinental usurpation. Today's Russia-Ukraine conflict, however, is an aberration; it is an exception to the rule owing to a combination of factors for which neither Russia nor Ukraine is solely responsible. Till 1991, both were part of the Soviet Union and never did their rulers resort to a ruthless assault on territories abroad. The Soviet invasion of Afghanistan in 1979 was an aberration as well. Among the other constituents of the 'big 10', Australia and Canada were British dominions, whereas Argentina and Brazil were under Spanish and Portuguese empires for hundreds of years. Algeria came out of French clutches after being vanquished in the 19th century. India was partitioned by the British, while the 1991 breakup of the USSR led to the birth of landlocked Kazakhstan and other nations.

Contextually, one understands how and why the West felt the need for an overarching umbrella to launch a collective attack like that on Yugoslavia in 1999, and on Iraq and Afghanistan in the beginning of this century. Now, it is the bloc of nations under the North Atlantic Treaty Organisation and the European Union that is keen to prolong the Russia-Ukraine conflict at the behest of warmongers.In the midst of the war in eastern Europe comes the proposal to hold the Ukraine peace summit at Burgenstock, Switzerland, in June. On the face of it, this is good news, yet Russia's reported absence/non-participation makes the summit a potential non-starter because no peace move can fructify without the presence of all belligerents on the high table. Russia's exclusion would only result in a stillborn agenda.Germany, Europe's most populous and second largest country, is a key member of the anti-Russia front of the West. Berlin needs to recall its own humiliation at the Treaty of Versailles in June 1919, when the German delegation was threatened that war would be resumed in five days if the draft treaty was not signed instantly. German signatories were not even allowed to sit with the Anglo-French delegates at the negotiating table. Germany must also not forget its bifurcation after World War II. Having been among the worst sufferers of 20th-century wars, Germany must put its foot down to abort any peace summit without Russia's participation and not provoke Moscow into causing mutually assured destruction. Of late, political stalwarts of the

## **Right to apprenticeship should be a priority in India**

## Skill policies and schemes need a big overhaul on the lines of Swiss and Germanic models, in which the youth and the industry take centre stage.

IN its manifesto for the 2024 elections, the Congress announced a right to apprenticeship (RA) for all post-secondary certificate/degree/diploma holders. It guarantees all under-25-year-olds the right to apprenticeship with firms where the youth can get training and work together, based on the duality principle of the Germanic skilling model (involving schooling and simultaneous work experience). India has always had a supply-driven vocational skilling ecosystem, where youth are getting educated but not 'skilled' in a true sense, where there is very little employer connect and no requirement for internship or apprenticeship. This calls for a scrutiny of the performance of the government's skill development initiatives in India and why reforms like an RA are a step in the right direction.

Vocational education and training (VET) has been neglected in India for over half a century until the 2000s (just as school education had remained neglected in India's planning strategy) — the costs of which we continue to pay today. In 1991, when India's economic reforms began, literacy was 51 per cent — or half of India's population was illiterate, mostly concentrated in the agriculture sector. Although school education received a new-found emphasis in public spending in the 1990s, VET still continued to be neglected (although that was not the case for technical higher education). The 11th Five-Year Plan (2007-12) was the first Plan that

had a chapter on skill development. The result is that India's manufacturing and services workforce still has very low levels of education. Worse, the National Sample Survey Office's Employment-Unemployment Survey (2011-12) says 2.2 per cent of the workforce had received formal VET. Periodic Labour Force Survey (PLFS) data shows that the percentage of formally vocationally trained individuals decreased from 2.2 per cent (10.43 million) in 2011-12 to 2 per cent (9.14 million) in 2017-18, but in five years, rose to 3.7 per cent (21.05 million) in 2022-23. So, who have been added as 'vocationally trained'?

PLFS 2017-18 shows that 22 per cent of total vocationally trained undertook less than six-month courses, and that share has now risen to 37 per cent. More worryingly, in 2017, 29 per cent individuals used to take two-year or longer courses, now

reduced to 14.29 per cent. The VET duration of Skill India Mission courses is very short (in some cases, only 10 days).Since 1961, India has had the Apprentices Act, which requires all registered firms to accept apprentices for at least one year or more. Ten years ago, about 250,000 apprentices existed in registered non-farm enterprises. In August 2016, the government of India launched the National Apprenticeship Promotion Scheme (NAPS), worth Rs 10,000 crore. Though the objective was to train The urgency arises from the following facts: The 50 lakh apprentices by 2020, only 20 lakh could be trained by 2022. Out of the envisioned Rs 10,000 crore, only around Rs 650 crore was disbursed to



states between 2017 and 2022. NAPS-2 was launched in 2023; no figures for the same are In the light of educated unemployment, a lack of currently available.An International Labour Organisation study in 2022 concluded that the amendments to the 1961 Act have contributed to an increase in the number of apprentices in India. In a workforce of 570 million in 2022-23 (PLFS), the apprentices were just over a half million, a rise from 2.5 lakh 10 years ago. Clearly, the amendments have not worked wonders. This is not surprising, given that practically the entire private corporate sector has largely ignored the apprenticeship schemes. Only central and state public enterprises have tended to fulfil their obligations. MSMEs still continue to ignore the scheme. The result: Germany, with a 46-million workforce, has at least 6 million apprentices; India has, by contrast, half a million. The difference arises from the industry/employer Skill policies and schemes have failed; they need a big involvement in pre-employment training — which makes India's approach supply-driven, but successful VET programmes around the globe have been demand-driven.What India's youth need

urgently, as 6 million or more join the labour force each year, and over 100 million wait in the wings as NEETs (Not in Education, Employment or Training), is a pathway to work from their education, whether the education is of a general academic nature or vocational or technical. India Skills Report 2021 argues that nearly half of India's graduates are unemployable. Open unemployment was barely 2.1 per cent in 2012 and

had already nearly tripled to 6.1 per cent in 2018, the highest rate in 45 years of India's labour force surveys. The number of unemployed was one crore in 2012; it tripled to three crore by 2018. The youth unemployment rates went through the roof for those with middle school (Class VIII) education, rising from 4.5 per cent to 13.7 per cent; those with secondary education (Class X) from 5.9 per cent to 14.4 per cent; and with higher secondary (Class XII) education from 10.8 per cent to 23.8 per cent. Educated unemployment worsened sharply. For graduates, the unemployment rate rose from 19.2 per cent to 35.8 per cent; and for postgraduates from 21.3 per cent to 36.2 per cent (2022-23).

## The enduring lesson of strategic restraint



## Powerful nations employing disproportionate force to achieve tactical objectives need to introspect.

IN 1999, Pakistan's Kargil intrusions challenged India's territorial integrity. Emboldened by its nuclear tests conducted the year before, Pakistan aimed to internationalise Kashmir as a nuclear flashpoint, assuming that its newly acquired capability would deter India from a full-scale military response, forcing early mediation and allowing it to keep the intruded territory across the Line of Control (LoC). To resolve the unprecedented crisis, India categorically rebutted any diplomatic efforts proposed by Pakistan until the intruders were completely evicted. A long period of diplomatic parleys would have afforded adequate time for the Pakistani intruders to consolidate their positions and indulge in excessive nuclear rhetoric to pressure India to accept the new alignment. Accordingly, the Cabinet Committee on Security instructed the armed forces on May 18, 1999, to clear the intrusions employing air power offensively but laying down a term of reference not to cross the LoC.India's declaratory self-imposed caveat of not crossing the LoC, reflecting its policy of 'strategic restraint', was aimed at garnering international acceptance of a responsible nation avoiding escalation and prioritising peace. This could also help lift sanctions imposed by the global community after it had conducted nuclear tests in 1998, though this stance left many questioning the policy. Not surprisingly, it created a paradox, wherein India wanted to evict the intruders from its territory but was not ready to enter Pakistan-occupied Kashmir (PoK), which was under Pakistan's illegal control since 1948. It was tantamount to accepting the LoC as the international border and abdicating its claim to PoK. This limitation bolstered Pakistan's belief that India feared escalation because of the former's nuclear capability. The restriction also caused tremendous

consternation among the Army and the Indian Air Force (IAF), as it involved frontal attacks along the expected approaches, causing larger Army casualties and curtailing the radius of the circuit of IAF combat aircraft. On being explained the adverse implications for the conduct of military operations, as the contingency might arise to cross the LoC, the National Security Adviser diluted the restriction, stating publicly that not crossing the LoC holds good today, but not sure what would happen tomorrow. The damage was, however, done, with Pakistan perceiving it as a meek military response.

Pakistan raised the spectre of a nuclear confrontation, with its Prime Minister, Nawaz Sharif, declaring its newfound confidence in countering an Indian attack on equal terms. Days later, Pakistan issued an official warning of retaliation, implicitly with its nuclear weapons. These threats were primarily aimed at the international community, especially the US and other Western nations, to pressure them to restrain India's military push. However, New Delhi dismissed these threats, well aware of Islamabad's limited nuclear capability - possessing only a few undeveloped nuclear weapons with restricted delivery systems sans a proper command structure for using them. Lt Gen Prakash Menon, former Military Adviser to the National Security Council Secretariat, aptly remarked: "It was with a non-existent capability around which Pakistan wove its paradigm of a nuclear umbrella, to prevent escalation as well as leverage the nuclear flashpoint card internationally."

The internationa community, initially swayed by Pakistan's rhetoric, saw through it as India presented concrete evidence of the Pakistani army's involvement in the intrusions. The shift in the narrative compelled Pakistan to tone down its rhetoric. Reacting to Islamabad's threats of more incursions, New Delhi hinted at military action across the border. The Army's success in recapturing the intruded heights reflected the hollowness of Pakistan's nuclear rhetoric. India carefully calibrated strategic troops posturing close to the border and relocating naval assets to the Arabian Sea to create a strategic asymmetry along the entire Indo-Pak front to achieve escalation dominance, should there be a need for war. While the Western media overplayed



the nuclear threat, Pakistan's attempt to link its actions to a potential nuclear flashpoint failed. Instead, it came under intense international pressure to withdraw.As the Indian military operations gathered momentum, Pakistan sought an exit strategy. Its Prime Minister visited Washington in July 1999 to meet then US President Bill Clinton, who categorically rejected Pakistan's repeated pleas for direct US intervention in the J&K dispute and called again for withdrawal. Pakistan eventually agreed, and the Indian Army accepted a phased withdrawal on its terms and conditions. The Pakistani army withdrew by July 17, barring three areas, which were cleared by the Indian Army by July 25. On July 26, the Indian Army declared the successful conclusion of the Kargil War. The Kargil conflict marked a strategic shift in the international perception of India, whose measured response, exercise of strategic restraint and prioritisation of regional stability over escalation were viewed positively. The US unequivocally favoured India, with its Congress recommending the suspension of loans from international financial institutions to Pakistan until it withdrew its troops. The G8 countries and the European Union adopted a similar stance. Russia was more supportive, while Pakistan's trusted ally, China, maintained a neutral stand. Most of the other countries showed evenhandedness, asking for restraint, while Saudi Arabia and Iran sought UN intervention. The saga of the unparalleled courage and bravery of Indian soldiers was superbly supplemented by politico-diplomatic initiatives bolstering India's international standing as a responsible country. Pakistan was humiliated not only on the Kargil battlefield, but also globally.

The Kargil conflict highlighted the contrasting perspectives of India and Pakistan. India conceptualised a limited conventional war as an option below the nuclear threshold. Pakistan, however, believed that its newly acquired nuclear capability had deterred a stronger Indian response, emboldening it to continue using terrorism as an instrument of state policy, as evidenced by the terrorist attacks on Parliament in December 2001 and the Mumbai terror attack in November 2008. Whether an all-out war in 1999 could have prevented major terror attacks originating in Pakistan remains debatable. The strategy of restraint can be a powerful tool of a strong nation and not a sign of weakness, as it underscores a country's confidence in its long-term strategic approach.



## The art of finding lost things



Lost your house keys? Can't find your specs? Your daughter can't find her favourite doll? Try some findology to prevent losing things around the house. According to Findologist Michael Solomon, author of How to Find Lost Objects: "Don't get frantic and keep searching around. There are no missing objects, only unsystematic searches and clutter."

Solomon says if everything is in its place, nothing will be lost. Meaning: design spaces for specific things. So, your keys, spectacles, mobile, its charger and all thingamajigs must have designated spaces - and then, consistently put the objects there.

#### **Clutter begone**

While designing a house, it's important to keep it free of clutter. Because amid clutter, things become invisible and virtually unfindable. ## **Covishield Side Effects: Doctors' Group Urges Centre To Review All Covid Vaccines**

New Delhi: In the wake of pharmaceutical giant AstraZeneca admitting in a UK court that its Covid vaccine can cause blood clots in rare cases, a group of doctors on Thursday expressed deep concern over the safety of the Covishield vaccine manufactured by the Serum Institute of India.

At a press conference, the doctors, under the banner of the Awaken India Movement (AIM), urged the government to review the science behind all Covid vaccines and audit their commercialisation as well as implementation of active surveillance and monitoring mechanism to ensure vaccine adverse events are identified as early as possible"The government has wholly ignored the rising number of cases of tragic deaths post-Covid vaccination all the while and continues to promote Covid vaccines as 'safe and effective', without scientific investigation and invoking epidemiology," Dr Tarun Kothari, a radiologist and an activist, said at the press conference.

The world is learning about a side effect of the Covid vaccine called Thrombosis with Thrombocytopenia Syndrome (TTS), he said.When the COVID-19 vaccines were being administered, not many people were aware that it was being done without the completion of phase-3 trials. Administration of COVID-19 vaccines was started without

the manufacturers having complete information and data on the possible shortterm or long-term side effects, or fatalities, said Dr Sujata Mittal, a gynaecologist and oncologist. There is an already low awareness around vaccine injuries, especially in India, she said. Thousands of women reported abnormalities in their menstrual cycles, which was confirmed much later as a side effect of the vaccine in a study published in September 2022, she added."The Awaken India Movement (AIM) has been collecting details of Covid Vaccine deaths covered by media/social media in India and sharing them with various high authorities of the country since 2021, when the vaccination began. The government has failed to respond to our repeated requests to investigate deaths and debilitation from adverse effects of



vaccination," Dr Kothari said. The AIM urged the government of India to compensate all the victims of Covid vaccines, including their family members, through a mechanism that involves vaccine manufacturers as well.

"We also demand establishing fast track courts and vaccine courts to provide swift justice to the vaccine injured and their families," Dr Mittal said.Besides, active surveillance and monitoring mechanisms should be implemented to ensure vaccine adverse events are identified as early as possible and early treatment protocols must be created and widely publicised so that lives can be saved, she stated."Review science behind all Covid vaccines and audit their commercialisation," Dr Kothari said

## Convict Can't Get Parole To Just Maintain Relationship With Live-In Partner: High Court

New Delhi: The Delhi High Court has held that Indian law, including the Delhi Prison Rules, does not permit the grant of parole to a convict solely for the purpose of maintaining a conjugal relationship with a live-in partner, especially when the convict is already legally married.

- Justice Swarana Kanta Sharma said that parole cannot be granted to a convict on grounds of having a child or maintaining conjugal relationships with a live-in partner when the convict has a legally wedded wife and children born from that marriage.Granting such parole, the court cautioned, would set a detrimental precedent. The court's observations came while dismissing a plea by a murder convict seeking parole to consummate his marriage with his live-in partner and to maintain social ties. The convict failed to disclose his existing marriage and children from his first marriage.
- Justice Sharma said that a live-in partner, lacking legal recognition as a spouse, does not fall within the scope of the definition of "family" under the Delhi Prison Rules, which include grandparents, parents, siblings, spouse, children, and grandchildren.While acknowledging the personal choices and relationships of individuals, the court clarified that it doesn't interfere in the personal lives of adults unless there are criminal complaints. Some are practically indestructible. It is estimated that there are more than 1,300 species of orchids found in India, primarily in the Northeast -Assam, Meghalaya and Arunachal Pradesh -and also in Sikkim and south India. Most orchids are perennial herbs with simple leaves and if raised in the right conditions (temperature not less than 16-17oC), they should last eight weeks with flowers, after which the blooms slowly start dropping off. They eventually re-flower. A word of caution: Never cut off the aerial roots, and never, ever remove the orchids from the pots they root in. **BEGINNERS' CHALLENGE** 

Growing orchids can be addictive. But you can take proper care of your orchid only when you know its genus. Most orchids you get in nurseries are hybrids, created specifically for flowers. They are easy to care for at homes and offices. However, a few things should be kept in mind, like light and humidity. If you can imitate a plant's natural habitat, it will thrive

available orchids, such as 🗳 the Moth Orchid, Phalaenopsis and Cattleya are so popular because they grow well at home. Phalaenopsis hybrids are usually considered the 'beginners' orchids', largely because they re-bloom under the conditions most windowsill growers can offer them. They require lower light.African violets can adapt to different humidity levels. They, however, easily die off due to over-watering. Underwatering can be a problem too. In Vedic scriptures, there is mention of a plant named Vanda, which has been adapted as a generic name for one of the most beautiful group of orchids. "Vandas could be mostly found on trees. And unlike most plants, they do not grow in soil, but air. Their roots attach to trees or rocks, and they draw moisture and nutrients that wash over them in the forest," Dr Rahman tells us. SOIL Beginners often make the mistake of assuming that orchids need to be potted in soil like other

blooming flowers. That would be a grave mistake. Most orchid roots need far more air than potting soil would give them. So, look for a porous mix.

#### LIGHTING

Direct sunlight should be avoided. Some common types of orchids that thrive on bright light are Cattleya and Vanda, while low light is preferred by Phalaenopsis and Pahiopedilum, among others. Orchids should be given as much light as they can tolerate. Varieties with thicker and erect leaves can tolerate more light than those with thinner or more horizontal leaves. Too little light is one of the common mistakes beginners make.

#### **TEMPERATURE**

Warm-growing orchids like day temperatures between 21oC and 29oC. This includes Phalaenopsis orchids. The commonly available orchids that are sold in nurseries do well in temperatures that are comfortable for human beings.

#### HUMIDITY

Most orchids like about 70 pre cent humidity in the atmosphere, which is more humid than most homes. So, you have to make an effort to provide your plants with extra humidity . Orchids usually appreciate misting with a spray bottle. If the plant has aerial roots growing up and out of the pot, those roots will like getting some moisture. At home, you can keep the the planter on a tray. Fill it with water and gravel. As the water evaporates, it will provide some extra humidity to the plant. For anyone keeping tropical plants on a windowsill, this technique really

## Vegetable garden

Have you, inspired by what Jyotika did in 36 Vayadhinile, wanted a terrace veggie garden of your own? It's a good idea, actually, to grow everyday spices and herbs, so that you have them at hand - fresh - whenever needed. But if you're among the many who don't know how to go about setting up this garden, read on ...

#### Choose the right space

Go to the terrace, take a good look. Judge the play of the sun throughout the day. And then, select a place that is shady, but at the same time, gets direct sunlight for some part of the day. You've

to ensure that the plants get at least five hours of sunlight daily. But mind you, herbs are delicate leaves, so be careful that the sunlight is not so strong that the leaves get scorched by the heat.

Get this ....

The state government, as part of its environment and green cover initiatives, provides coir peats that come in plastic bags, which means you can

grow the veggies in them, without having to bother about spending on pots. To begin with, wet the peats, place them on a sheet in the terrace. Keep watering them regularly, and in about a week, you'll see what looked like a small brick would've expanded to look like debris, and filled the bag. Now, to plant the seeds ....

#### **Prepare the soil**

Get some soil and natural manure from any nursery, and mix it well with the peats. If you want to keep it organic, add cow dung or goat dung manure to the mix. Leave this mix aside for a few days. Meanwhile, when you peel veggies, etc, do not throw away the skin. Instead, create your own compost with these vegetable skins and waste veggies in another pot in the terrace, and add them to this mix. After about a week, this mix is ready for plantation. Get the seeds of whatever you want to grow (tomatoes, chillies, coriander, basil and herbs are good choices). Sprinkle a few seeds over the mix, slightly dab them in with your hand, and leave it be for a couple of days. Watch them grow. Pick the right veggies



To start with, try out just one or two vegetables, and then go in for more veggies. Tomatoes, chillies and keerai (spinach) are easy to grow, so start with them. Sometimes you might need to net out the seeds and the saplings as they grow, to keep pesky sparrows and other birds from feasting on them.

#### Watering is the key factor

Water the plants regularly, as and when

needed. Excess water often causes damage and decay to plant roots, and it also washes away the nutrients of the soil. Also, post every heavy rainfall, remember to add manure to the soil.

## Air India Express expects operations to normalise within next two days

Air India Express, which normally operates approximately 380 flights daily, had to scale back operations due to the strike.An official told news agency PTI on Friday that normal operations are anticipated to resume within the next two days. The cabin crew members who



participated in the strike are now rejoining the workforce, and the airline is assisting them in obtaining the necessary fitness certificates required to resume their duties, the official told PTI.The official also said that most international flights are scheduled in the evening, and with more cabin crew available, operations in this segment are expected to improve starting from

Friday.The airline operates 120 international flights and 260 domestic services daily, though the number of flights may vary on certain days.

in response to the cabin crew shortage, Air India Express had to cancel 85 flights on Thursday, which represents around 23% of its total daily capacity.Following the resolution of the strike on Thursday, the airline announced to restore its flight schedule

and apologised to affected passengers for the disruptions caused.

Air India Express, which is currently in the process of merging with AIX Connect (formerly AirAsia India), employs around 6,000 individuals, including over 2,000 cabin crew members.

**NEW DELHI.** After a tepid FY23, the PSU oil marketing companies have turned the table and raked in record Indian Oil Corporation, the country's profits in FY24. The three state-owned oil marketing companies (OMCs) -IOCL, BPCL and HPCL - have together posted `82,500 crore

While the net interest

The 37-year-old has featured in 65 T20Is, 57 ODIs and a single Test for New Zealand, with his last appearance coming in their T20I home series against India back in 2020. With New Zealand announcing their pick of players for the upcoming T20 World Cup, Munro was one of the lot who did not make the cut. The usually explosive batter went on to cite his exclusion from the squad as the ideal window of opportunity to finally call time on his illustrious career. At the end of Munro's international career, the

batter finished sixth on the list of New Zealand's all-time leading T20I run-scorer with his 1,724 runs at an average of 31 and a strike-rate of 156.4. His prowess in the shortest format of the game saw three

brilliant centuries, which is also the highest by any batter to have played for his national side. Taking to his social media handles, Munro reflected on his time representing New Zealand and how he deems the time fit for his ultimate retirement from national team duties."Playing for the BlackCaps has always been the biggest achievement in my playing career. I never felt prouder than donning that jersey, and the fact I have been able to do that 123 times across all formats is something I will always be incredibly proud of. I am today announcing my retirement from International cricket." Munro's post said.Munro went on to give his take on his absence from New Zealand's recent T20I fixtures, while reflecting on the reasons behind that.
