14 Naxalites, including 11 with cumulative bounty of Rs 41 lakh

Bijapur, May 13: 14 Naxalites, including 11 carrying a cumulative bounty of Rs 41 lakh on their heads. arrested Chhattigarh's Bijapur district, a police official said on Monday. These ultras, comprising six women and eight men, were part of the outlawed Left Wing movement's 'military company number 2' and 'Gangaloor area committee', the official said. They were held on Sunday from forests of Mutvendi and Pidia villages under Gangaloor police station limits by a joint team of the District Reserve Guard and district police, a statement from Bijapur police said. "Eleven of the 14 Naxalites were carrying cumulative reward of Rs 41 lakh. These include Renu Kovasi, a member of mili-

tary company number 2 and Mangli Avlam of Gangaloor area committee with reward of Rs 8 lakh each," the release said. "Gangaloor area committee members Bichchem Uika, Sharmila Kursam and Lakshmi Tati were carrying rewards of Rs 5 lakh each Four cadres were having bounties of Rs 2 lakh each and two had rewards of Rs 1 lakh each," it added. Based on their questioning, four tiffin bombs, two cooker bombs, detonators, cordex wire, gelatin sticks, firecrackers and other Maoists related materials concealed by them were recovered release Incidentally, security forces had gunned 12 Naxalites in a 12-hour long operation in the forests of Pidia village on May 10 and had rounded up several persons from the site on suspicion.

Supreme Court notice to Himachal Pradesh High Court on plea of two district judges questioning HC collegium picks

New Delhi, May 13: The Supreme Court on Monday sought a response from the registrar general of the Himachal Pradesh High Court on a plea of two senior most district and sessions judges alleging that their merit and seniority were not considered by the high court collegium in selection of names for HC judgeship. A bench comprising justices Hrishikesh Roy and Prashant Kumar Mishra took note of the submissions of senior advocate Arvind Datar, appearing for the two district and sessions judges, that the judicial officers, who are junior to them, had been recommended for the high court judgeship under the in-service quota. The petition was filed by Chirag Bhanu Singh and Arvind Malhotra, who are presently serving as the district and sessions judges at Bilaspur and Solan, respec



tively in the state, alleging non-consideration of their names by the high court collegium for the judgeship The senior lawyer referred to a collegium resolution of January 4, 2024 of the apex court and the subsequent communication of the Union Ministry of Law and Justice to the Himachal Pradesh High Court and said that as per these, the names of the petitioner judicial officers should have been considered by the high court collegium. "The petitioners are the senior most judicial officers in the state and they have unblemished records," Datar said. The plea questioned the selection process of the judicial officers by the high court collegiums for elevation to as HC judges and said their merit and seniority were ignored despite the issue being specifically referred to in the apex court collegium's resolution. The plea said the apex court collegium's decision to send their names for reconsideration by the HC collegiums was followed by a communication from Union law minister to the Chief Justice of the high court urging him to reconsider the names of the petitioner judicial officers. It alleged that the high court collegiums did not consider these and proceeded to deliberate upon names of other judicial officers.

Lok Sabha elections 2024 Phase 4: Over 62 per cent turnout

New Delhi, May 13: A voter turnout of more than 62 per cent was recorded on Monday in the fourth phase of the Lok Sabha polls in 96 constituencies spread over 10 states and Union Territories amid incidents of violence in Andhra Pradesh and West Bengal. According to the Election Commission, a voting percentage of 62.31 was recorded till 5 pm. The voting will continue till 6 pm. Jammu and Kashmir witnessed the lowest voting percentage till 5 pm with 35.75 per cent of voters exercising their franchise, while West Bengal recorded the highest with 75.66 per cent. Among other states, Andhra Pradesh recorded 68.04 per cent polling, Bihar 54.14 per cent, Jharkhand 63.14 per cent, Madhya Pradesh 68.01 per cent, Maharashtra 52.49 per cent, Odisha 62.96 per cent, Telangana 61.16 per cent and Uttar Pradesh 56.35 per cent. Haven't received anything worthy of being probed by Indian agencies

Mumbai, May 13: India has not received anything which is specific and worthy of being pursued by its probe agencies, External Affairs Minister S Jaishankar on Monday said over a fourth arrest made by Canada in the killing of Khalistan separatist Hardeep Singh Nijjar. Jaishankar said New Delhi is open to an investigation if Ottawa has any evidence or information related to any violence which is relevant to be investigated in India. "We have not received anything which is specific and worthy of being pursued by our investigative agencies and I am not aware that anything has changed in the last few days in that regard," the minister said in response to a question during a press conference here. As a consular practice, it is informed to the government or the embassy of the country of origin when arrests of foreign nationals are made, Jaishankar said. Nijjar, 45, was killed outside Guru Nanak gurdwara in Surrey, British Columbia, on June 18, 2023. A fourth Indian national has been arrested by Canadian authorities in connection with the killing of Nijjar, a week after police arrested three Indians linked with the high-profile case that has severely strained India's relations with

SC issues notice to ED on ex-Jharkhand **CM Hemant Soren's petition**

New Delhi, May 13: The Supreme Court on Monday issued notice to the Enforcement Directorate (ED) on former Iharkhand Chief Minister and IMM leader Hemant Soren's petition challenging his arrest in a money-laundering case linked to a land scam. A Bench of Justice Sanjiv Khanna and Justice Dipankar Datta asked the ED to respond to Soren's petition by May 17, the next date of hearing. Initially, the Bench was not inclined to take up the matter before May 20 but it agreed to list it on May 17 after senior counsel Kapil Sibal submitted on behalf of Soren that the whole exercise would become infructuous if there was delay in deciding the petition as the Lok Sabha election would be over. Sibal sought to emphasise that Soren's prayer for release was covered by the top court's May 10 order granting a three-week interim bail to Delhi Chief Minister Arvind Kejriwal to campaign in the ongoing Lok Sabha polls. Polling for 14 Lok Sabha seats in Jharkhand is scheduled to be held in four phases - May 13 (4 seats). May 20 (3 seats), May 25 (4 seats) and

Class 10, 12 supplementary exams to be conducted from July 15: CBSE

New Delhi, May 13: The supplementary exams for classes 10 and 12 will be conducted from July 15, Central Board of Secondary Education (CBSE) officials announced on Monday. Over 1.32 lakh candidates have been placed in the supplementary category or compartment in class 10, while the number of such candidates in class 12 is over 1.22 lakh. Based on National Education Policy, 2020 recommendations, the CBSE had last year changed the nomenclature of the compartment examination to supplementary examination. According to CBSE Examination Controller Sanyam Bhardwaj, class 12 students will be allowed to improve their performance in one subject in the supplementary examination and class 10 students will be allowed to improve their performance in two subjects in the supplementary examination. "Three categories of students will be eligible to appear in the supplementary examinations—class 10 students who were unable to pass two subjects and class 12 students who were unable to pass one subject and were placed in compartment category; students who were declared pass by replacing sixth or seventh subject; and class 10 and 12 students who were declared pass but wish to improve their performance in two and one subject respectively," Bhardwaj said.

JD(S) MLA HD Revanna granted bail in kidnap case by Bengaluru court

Bengaluru, May 13: A Special Court for Elected Representatives on Monday granted bail to JD(S) MLA H D Revanna in connection with a kidnap case. The 66-year-old former Minister was arrested by the Special Investigation Team (SIT) in an alleged case of abduction of a woman, linked to the allegations of sexual abuse of women by his son and Hassan MP Prajwal Revanna, on May 4. The special court judge Santhosh Gajanan Bhat heard the matter and granted conditional bail to Revanna. While granting the bail, the court invoked conditions, as per which Revanna will be given bail upon executing Rs 5 lakh bond, he shouldn't be allowed to leave the country, and he should not try to influence the victim or other related parties to the case. According to sources, he is likely to be released from prison on Tuesday. Revanna's three-day police custody



Scattered incidents of violence mar 4th phase polling in Bengal: Dilip Ghosh Stones were hurled at his convoy,

Kolkata, May 13: Scattered incidents of violence marred the fourth phase of Lok Sabha polls in the eight parliamentary constituencies of West Bengal on Monday as TMC and BJP workers clashed in various parts of violence-hit Birbhum Bardhaman-Durgapur seats. Although the poll panel claimed that voting has been peaceful so far, it said it had received 1,700 complaints till 1 pm from different political parties alleging EVM malfunctioning and agents being stopped from entering booths. Clashes broke out between supporters of TMC and BJP in Monteswar's Susunia area of Bardhaman-Durgapur Lok Sabha seat around noon, as BJP candidate Dilip Ghosh was on his way to a polling booth following complaints of booth jamming. As Ghosh was on his way, TMC supporters blocked his convoy and squatted in front of his vehicle, starting a protest against him.

following which some of the cars of the security personnel tailing his convoy were damaged. Ghosh was also heckled by the TMC activists, sources claimed. "Police are just mute spectators. The TMC has let loose a reign of terror. Since morning, TMC goons have beaten up our polling agents and are not allowing polling to be free and fair," Ghosh told reporters. Ghosh's convoy was again attacked at Kalna gate in Bardhaman-Durgapur constituency. Ghosh said he had gone to a booth there following allegations of TMC not allowing BJP's booth agents. Bricks were pelted at his convoy leading to serious injury of central police personnel deployed in his security, sources claimed. "This is for the second time that my convoy was attacked today. Two of my security personnel were injured and had to be taken to hospital for treatment,' Ghosh said.

Optimal age for motherhood is 21: ICMR report

Bengaluru: New research from the National Institute for Nutrition under the Indian Council of Medical Research (ICMR) indicates that 21 is the ideal age for a woman to get pregnant and begin motherhood. This claim is supported by evidence showing the biological and social factors that align at age 21 to meet the demands of pregnancy and childbirth.

At 21, a woman's cervix is fully mature and her pelvis has finished developing, reducing risks during labour and delivery. The chances of contracting sexually transmitted infections such as chlamydia, gonorrhoea, syphilis and infections causing cervical, vaginal or vulvar cancers are also lower compared to younger ages.

Gynaecologists also say instances of preterm babies and chances of infant mortality are high with teen

pregnancies. As per the ICMR report, undernourished women are at higher risk of giving birth to babies with small gestational age or low birth weight (under 2.5kg), or even preterm babies. Although the state govt says it has, through awareness and health schemes, ensured a reduction in cases of low weight at childbirth, its latest Economic Survey points to low birth weight being a major cause of infant deaths in 2020."The ideal age for pregnancy differs for each individual, but for many, 21 represents a balance of physical readiness and

Most candidates find ComedK exam easy

Bengaluru: Over 1 lakh candidates participated in the computer-based ComedK's UGET-2024 exam held on Sunday at 264 centres in 189 cities across India, including 72 in Karnataka and 33 in Bengaluru.UGET-2024, the gateway for admissions to UG engineering courses in private colleges of Karnataka and select colleges elsewhere in India, by the ComedK, was held in three sessions. About 88% of the 1.2 lakh registered candidates turned up.Sarvasya MJ, a candidate, said: "I wrote physics, chemistry, and maths exams, and found it moderately easy. Though I hadn't prepared well, I found the papers easier than last year." Another student, Harshi A, echoed the same sentiment: "It was a simple entrance exam, so I studied the basic 12th grade portions. I'm writing JEE (Joint Entrance Exam) too, so this was a good practice. There were no issues at the centre." The preparation that went into the exam was okay. I also wrote KSET (Karnataka State Eligibility Test), so the preparation was the same for this exam too. I think physics and chemistry are doable," said Dhruv Shivaprasad, a candidate. Though the overall impression of the test for most students was good,



some found physics paper lengthy. Aditi SH, a candidate, said: "I'm preparing for NEET, so the maths paper was a little tough, but I could manage physics and chemistry, though I found the physics paper quite lengthy..."The exam is for admissions to about 20,000 UG seats in 150 engineering colleges of Karnataka and 40 private universities in India. The provisional answer keys will be notified Tuesday along with forms for challenging them. The final answer key is slated for release on May 21, followed by the scorecard release on May 24.

Puducherry residents demand new shed, more taps at purified water distribution units

The units operate between 7 am-12 pm and 4 pm-7 pm, besides being open for half a day on Sundays and closed on public holidays.

PUDUCHERRY: The residents from several areas in Puducherry have demanded the government install sheds and more water taps at several of the 69 purified drinking water distribution units established across the region. A majority of the residents, who purchase purified water for Rs 7 per 20-litre can and Rs 3 for the lid from these units, belong to the lower and middle economic strata and could not afford to have water purifiers at home or spend over Rs 20 per water can. The Puducherry government, in collaboration with the Public Works Department (PWD) and private organisations, established the water distribution units, with five of the 69 maintained directly by the PWD and the rest by several private entities. The units operate between 7 am-12 pm and 4 pm-7 pm, besides being open for half a day on Sundays and closed on public holidays.N Jeeva Lakshmi, a resident of Anna Nagar, said that though the equipment is housed in closed sheds, the

water taps remain exposed. Because of this, the residents have to wait outside, often in longer queues, despite the



weather, added the resident. One Naratajan from Netaji Nagar in Oupalam, said that it is difficult to wait in the heat, especially this year.

"During rainy seasons, rainwater fills our cans, rendering them useless to carry purified water. In our area, there's a large tree by the unit. Dried leaves and bird waste often fall into our cans. We have to empty and clean them each time, which incurs an additional cost as the unit operators do not provide a refill for free," he said. The residents reportedly wanted the unhygienic conditions of the units to be addressed. They further raised concerns about difficulties in obtaining change as several units are allegedly not accepting ten-rupee coins. A senior PWD official said, "The purification equipment is ten years old, limiting us to two taps per unit. We have proposed a revamp, but due to the elections, the approval is delayed." The residents' demands would be considered though there was no immediate plan to install sheds for taps, added the official. They are

considering issuing prepaid cards, the official said for the ten-rupee coin issue, assuring to look into the matter.

However, the staff at the liquor outlets said complying with the order is not practically possible, and, if so, the sales time is likely to drop significantly from one to two hours as they have to complete all their work in the shop within the timelimit as per the new order. The new instruction was given on May 10, following a police inquiry held at Katoor

police station on Thursday (May 9). The "Business in outlets starts at 12 pm and goes on sources said the police team from the Katoor station picked up the staff of the Tasmac shop (No: 1543) for inquiry as they were in the shop before 12 pm. Though they explained that they were preparing for sales, the police accused them that it was an offence as they were at the shop before the permitted time. Later the staff explained the nature of the work and the need for their presence earlier for preparation. Upon hearing the explanation, police set them free and the issue was settled. But after knowing about the issue, the Coimbatore North District Tasmac Manager issued an order barring the staff from entering the shop before 12 pm and after 10 pm. The staff strongly opposed it and felt it would directly impact the liquor sales.

till 10 pm without any break. Therefore, the staff should come to the store before 12 pm and check the stock in the store, the details of newly arrived stocks and maintain records. Since Tasmac shops mostly operate in a single room, it takes time to prepare the stock for retail sale after disposing of empty cartons and bottles and stacking the bottles to be sold for the day. Similarly, after the sale, the day's revenue should be tallied and compared with the number of bottles sold. Therefore, an average of one-and-a-half hours of administrative and preparatory work is required before and after the sale every day. We can't start selling without doing these basic works. We are doing these works beyond our work schedule," said a supervisor

on condition of anonymity. A John, secretary of the TASMAC employees' association affiliated with CITU, said it's practically impossible to have staff come in just as customers arrive at the opening time. "If this order is implemented, the sales hours will decrease and hence the revenue will fall in each outlet. Obviously, it indirectly creates a favourable situation for private bars. The officers should consider the practical difficulties in the operation," he said. When asked, Manager M Vanilakshmi Jagathambal said that the instruction has been given to the staff to avoid law and order issues as the model code of conduct is in force. Forgotten survivors of Irshalwadi landslide shunned by candidates

Mumbai: Away from the high-pitched electioneering in the hilly backyards of a 'Third Mumbai' connected to the island city by the Atal Setu, are the forgotten people of Irshalwadi in makeshift barracks on the village's outskirts. This is the location in Raigad district where over 80% of a village was obliterated by a catastrophic landslide, killing 84 people on July 19 last year. Of the 228 inhabitants from 43 families, 144, including 23 children, survived. The bodies of 57 of those killed still lie buried in the landmass visible on the hill, as a daily reminder of the tragedy. The villagers are part of the Maval Lok Sabha constituency that is going to polls on Monday, the fourth phase of general elections in Maharashtra. Chief minister Eknath Shinde Sena's sitting MP Shrirang Barne and Shiv Sena (UBT)'s Sanjog Waghere are the prominent candidates locked in battle. However, the candidates have not been seen here.

UBT Sena spokesperson Harshal Pradhan blames the govt for neglecting Irshalgad and its survivors, but is silent on why candidates are not approaching them. "Other than just offering them homes and money, a serious attempt should have been made by the govt machinery to restore their day-to-day livelihood and ensure that they move ahead and make progress in their life."Mangesh Chivate, Officer on Special Duty to the CMO on relief measures, however, said besides new homes and compensation, govt was trying its best to provide a livelihood to the survivors by offering skill training and creating better academic as well as job opportunities for them in the viinity of the Ganpat said all affected villagers, except village. The survivors say they will soon get their new homes at the foothills this year and have received some cash as aid from the govt and NGOs, but their traditional way of life in homes on the hilltop surrounded by farms is gone forever. Before the tragedy last year, the entire village practiced collective farming.

Ganpat Pardhi, the president of the union of displaced villagers of Irshalwadi, who is among 11 surviving families said, "Orphans

are now being taken care of by the close relatives who are alive. However, breathing new life into the day-to-day chores of all whose morale has been low is a challenge. We all need a strong shoulder to get back to the original livelihood we enjoyed," he said, Pardhi, like other survivors from affected families, lives in the rectangular container-shaped artificial barracks set up on an area of an abandoned petrol pump along the old Pune highway near Chauk village.

for 11 families whose homes remained intact to a certain extent, have received monetary help. "We too have lost livelihood and homes like others because our buried village and surrounding farms have been closed owing to the risks," says Rajendra, Ganpat's brother. Majority of youths here used to earn Rs 500 to 1,000 daily by helping trekkers to the fort atop the hill almost every season. Temporarily, Ganpat has taken up a



job as a cook with a hotel nearby, while Rajendra is a daily-wage worker.Gangu Laxman Pujari, a 40-year-old farmer and homemaker, lost seven of her family members on that dreadful night and is taking care of their orphaned children. Today, she is struggling to make ends meet."I am alive as I was away from the village with my daughter that night

Gurgaon s Several homebuyers of Renuka Aashiyara, an affordable housing project in Sector 37C, took to the streets on Sunday against the builder due to delay in handover their flats. Gurgaon: The 19-year-old runner from Nuh, Parvej Khan clinched gold in 1,500 metres and bronze in 800 metres during the early hours of Sunday in the prestigious NCAA Championships in Boston, US. With his showmanship during the 1,500 metres preliminaries going viral—he waved to the crowd while comfortable winning the race, he told his father Nafees Ahmed, "It was meant for entertainment and not disrespect.

Parvej further said, "The 1500m finale came easy for me. I did not give my 100% all throughout, as I also had to run 800m. I only changed gears in the last 200m.

Nafees reminisced about his son's dedication to running, often prioritising it over academics during his school years. Parvej's journey from Nuh to the University of Florida is a remarkable story. Nuh is amongst the most backward districts in the country. Nafees says, "Nuh is full of kids like Parvej. It's just they can't fight enough for their dreams because of financial restraints.

His journey to success began in the small village of Chahalka in Nuh, where his father works as a farmer, cultivating wheat and cattle fodder on a five-acre plot shared with his brothers. Despite financial problems, Khan harboured aspirations beyond the confines of his village. His father recounts, "Neither my wife nor I am educated. We have always felt that there was no future in sports. We wanted him to prepare for the army, and we believed only that could solve our problems. And in my village, there's no sportsperson. But our son has always been someone who wanted to do something different."Khan left for Delhi at the age of 13 to pursue his passion for sports. Facing the challenges of limited resources, Khan remained determined to achieve his athletic dreams. A controversy arose when Parvej was declared overage at the National Junior Championships in 2021, but he was cleared to compete at the senior level, winning gold in the 1,500 metres at the National Open Championships in Warangal. Parvej's success is motivating the youth in Nuh, a region with untapped potential. His move to Delhi for training, paved the way for his scholarship offer from the University of Florida, from another college of Japan and from the Indian Navy, which he had qualified for. The family hopes he will remain in the US until June to pursue Olympic qualification, a shared dream they all hold dear. With visitors pouring in to congratulate the family and Nafees's phone buzzing with well-wishes, Parvej's victory has brought immense pride to Chahalka village.

3 masked men chase, assault MCG engineer on way home

Gurgaon: A junior engineer of MCG was chased and assaulted by some masked men on Friday. Based on the engineer's complaint, the police registered a case and launched a manhunt to nab the offenders.

During the early hours of Friday, when MCG's junior engineer, Tilak Sharma, was returning from his workplace at the Bandhwari landfill to his home in Gandhi Nagar near Sector 10, he was chased by three masked men in a car. Tilak, who was riding a bike, realised that he was being chased after reaching Sikanderpur when the assailants in the car came closer and asked him to stop the vehicle.

Alarmed, Tilak sped up his bike and continued to drive towards IFFCO Chowk. The assailants in a white Swift continued to chase him, and intercepted his bike when he was about to get onto the Ghoda Flyover. "They attacked me with sticks and left the place after threatening to kill me. The vehicle's number plate was covered with mud, and I was not able to see the number. All three offenders had covered their faces with masks," Tilak alleged in his complaint to the police.

A labourer, an ex-guard & an MBA:a Independents who threw hat in ringaza

Gurgaon: Anwar, a labourer from Nuh, Jai Kanwar Tyagi (Dixit), a former security guard at Raj Ghat, Kusheshwar Bhagat, a pav bhaji seller, and Akshat Gait, a corporate professional with an MBA degree from Germany, are all vying to represent the parliamentary constituency of Gurgaon, throwing their hats into the election ring as Independents.

Their chances of winning may be slim, but there is no lack of optimism in them. The four are among the 23 contenders from the constituency where voting will take place in the sixth phase on May 25. Anwar (34), who works at construction sites to earn his living, said he filed his nomination from the Nuh assembly seat in the 2019 state polls but drew a blank. 'Nuh is one of the most backward districts

of the country, and my objective is to highlight its issues," Anwar told TOI. The district, which saw large-scale communal clashes in 2023, has been a Congress stronghold. But Anwar says all



political parties are supporting dynasts. "These parties are too crowded and are controlled by a few families. I am aware of my prospects in the election but still hope to create awareness among people and encourage more youngsters to come forward and participate in elections," he

said.Jai Kanwar, who is contesting for the third time, too feels political parties are not working in the interest of the people. "All are neck-deep in corruption and only interested in pursuing their agenda," he said.In 2014, Jai Kanwar took voluntary retirement from his job as a security guard

at Raj Ghat to contest the Lok Sabha election from the Gurgaon constituency. He filed papers again in 2019 but did not get much success. Gait, in contrast, is a newcomer. A salaried corporate employee, the 36-year-old has thrown his hat into the ring to work on education and environment. His education and environment. His corporate-salaried job has not held him back. "Corporates get affected by politics and so they work hand-in-hand with the government. I have got immense backing of my colleagues," he told TOI.Among the most educated candidates in the fray for the seat Gait candidates in the fray for the seat, Gait completed his BTech in computer science from Pune's Army Institute of Technology and MBA from Management Development Institute (MDI) and an institute in Germany. He currently works as a business

consultant with EY Parthenon. Apart from filing nominations, the Independents are yet to start canvassing. With limited resources and manpower, most are relying on their personal connections and their simple and honest approach in this

Hry sees 38% jump in plastic waste generation in a year

Gurgaon: The state has seen a steep rise in plastic waste generation, with 1,79,406.5 tonnes recorded in 2023 —

a 38% jump from the previous year (1,29,866.7 tonnes). Around 14% of this ended up in landfills, according to the annual report published by Haryana State Pollution Control Board (HSPCB). The state is recycling approximately 78% of its plastic waste. The report has indicated a surge in plastic usage in the state, which is likely contributing to increased generation of plastic waste. The trend is worrisome as it poses significant challenges to waste management and has potential long-term impacts on the environment, experts said. The key to addressing this issue lies in reducing plastic usage and promoting sustainable alternatives, they added. Ashish Jain, director of Indian Pollution

Control Association (IPCA), an NGO, said: "A city that is growing and accommodating an urban population and consuming lots of natural resources leads to a lot of environmental issues, including waste management, air pollution, and sewage. A holistic approach with the integration of multiple departments and a common action plan is needed.

Creating infrastructure for material resource facilities (MRFs) to increase segregation of waste will also help."

Burning of plastic waste at landfills is another area of concern, experts said. "Landfills are often poorly managed, and we see frequent instances of fires breaking out. Plastics burning as part of landfill fires are known to be significant pollution sources leading to toxic PM and gaseous emissions. So, disposing of plastics in landfills should be avoided as much as possible," said Dr R Subramanian, sector head (air quality) at Center for Study of Science, Technology, and Policy.Officials, meanwhile, said efforts are being made to enhance waste management practices and increase the recycling rate. According to HSPCB, a total of 18,023 challans amounting to Rs 1.5 crore were imposed by the urban local bodies department on violators from April 2022 to March 2023."Door-todoor waste collection and segregation are being done through private bodies in almost all municipal areas. All municipal corporations have been directed to set up MRFs as per requirement and to manage their plastic waste as per the Solid Waste Management Rules, 2016 and Plastic

Waste Management Rules, 2016. 6 more weeks for Hry to set deadline for wetland notification

Gurgaon. The National Green Tribunal (NGT) has granted an extension of weeks to the Haryana govt for filng an affidavit specifying the timeline for declaring Najafgarh Jheel as a transboundary wetland during a hearing. The counsel for NCT of Delhi had earlier informed the tribunal about its decision to declare the water body as a wetland on Dec 22, 2023. However, the Haryana govt sought more time to file the affidavit in the case which dates to 2014, when a Delhi-based NGO — Indian National Trust for Art and Cultural Heritage — filed an application in the NGT demanding the lake be declared a wetland and adequate steps be taken to conserve it. "The

Haryana wetland authority has submitted that all the incumbent except member secretary of the authority have been reshuffled in March. The member secretary has been assigned parliamentary election duty in Sikkim since March 2024. Therefore, the meeting could not be convened, and the affidavit could not be filed. Having regard to the difficulty, which is expressed in the application for adjournment, the prayer is allowed and further six weeks are granted to the Haryana govt to file the affidavit," stated chairperson Prakash Shrivastava and expert member A Senthil Vel in the order. Scottish man behind viral whitegold dress admits he tried to strangle wife

World Back in 2015, a 38-year-old Scottish man, Keir Johnston, sparked a debate on social media over the colour of a dress that was worn by his mother-in-law at his wedding. The dress went insanely viral as some people saw it as "black and blue", others thought that it was "gold and white".

Eight years later, the same man behind the viral dress pleaded guilty to endangering his wife's life, and admitted to attempting to strangle her.

Keir Johnston appeared at the High Court in Glasgow on Thursday, where he pleaded guilty to a "terrifying" attack on his wife, Grace Johnston, that left her "fearing for her life", but alive, according to The Daily Record. Johnston, from the Isle of Colonsay, off the west coast of Scotland, was remanded in custody until his sentence next month, scheduled for June 6.

The debate over the dress's true colours broke the internet, drawing thousands of comments, including from celebrities. Kim Kardashian also posted that she had argued about it with her then-husband, Kanye West.

Ellen DeGeneres invited the Johnstons onto her talk show, where they were given \$10,000 and a trip to Grenada.

This week, the Scottish court heard that Johnston left his wife fearing for her life, and had a history of domestic abuse towards her. Chris Macintosh, prosecutor for the Crown, told Lady Drummond and the court how Grace lived in fear of her abusive husband. "There is no permanent police presence on the island, and she was in a situation where she felt trapped," he said.

The court heard that Grace had once refused her husband's demands not to attend a job interview on the mainland. Days later, he told her he was leaving her before the pair got into an altercation where Johnston grabbed his wife and threw her to the ground. "Johnston woke up and said that he was going to leave her. She went outside the property to stop him leaving. He followed her and pinned her to the ground," Macintosh said, according to The Record."He placed both knees on her arms, so she was unable to move. He then began strangling her with

"She was initially able to scream and feared for her life and believed Johnston intended to kill her as he was very forceful," Macintosh said that despite suffering severe bruising, Johnston did not require medical treatment.

Lawyers for Johnston said he had accepted responsibility for the assault. Lady Drummond denied Johnston bail and placed him in custody, telling him, "I have no need to tell you that this is a serious and violent offence.

Hamas condemns Biden for saying 'truce tomorrow if hostages freed'

DOHA. Remarks by US Prez Joe Biden that a ceasefire in Gaza would be possible if Hamas released its hostages are a "setback" to negotiations, the Palestinian militant goup said Sunday. "We condemn this position by the US prez, we consider it a setback from the outcomes of the latest round of negotiations, which led to the movement's agreement to proposal put forward by mediators," Hamas said in a statement.

Biden said on Saturdsay that a ceasefire in the Israel-Hamas war would be possible "tomorrow" if Hamas gave up hostages seized in its Oct 7 attack. The US prez raised the topic of the hostages during a speech in Seattle. Negotiations between Hamas and Israel for a truce and hostage exchange deal, mediated by Egypt, Qatar and the US, appear to have stalled amid Israeli military action in the southern Gaza city. Hamas said Israeli PM Benjamin Netanyahu had "rushed to overturn" the talks by launching an offensive in

UK foreign secretary says halting arms sales to Israel would only strengthen Hamas

LONDON. Halting arms exports to Israel is "not a wise path" and would only strengthen Hamas, Britain's foreign secretary said Sunday. Asked whether the UK would follow the US in threatening to cut the supply of offensive weapons to Israel if it carried out an attack on the southern Gaza city of Rafah, Foreign Secretary David Cameron said the two countries cannot be compared because unlike the US, Britain supplies a very



small amount of Israel's weapons

'The UK provides less than 1% of Israel's weapons and it's not a state supplier," Cameron told the BBC on Sunday. "We have a licensing system and those licences can be closed if it's judged there's a serious risk of a serious international human rights violation.'

US President Joe Biden has said that his government will stop supplying weapons and artillery to Israel if its forces launch an all-out assault on Rafah, the last major Hamas stronghold in Gaza.Britain's opposition Labour Party and human rights groups have argued that the UK should follow a similar position and stop the sale of British-

made weapons or components in a Rafah offensive. The US government said Friday that Israel's use of USprovided weapons in Gaza likely violated international humanitarian law. But it added that wartime conditions prevented US officials from determining that for certain in specific airstrikes. Cameron said the UK did not support a major offensive in Rafah without a clear plan about how civilians can be protected. The Campaign Against Arms Trade nonprofit group estimates that the real value of UK arms exports of Israel is at least 1 billion pounds since 2015, much higher than government figures. It says that British industry, namely BAE Systems, provides about 15% of the components in the F-35 stealth combat aircraft used by Israel. The group alleges that the jets were used in recent bombardment of Gaza. The full value of component and other licenses is not known, it said. Cameron also said that putting British boots on the ground in Gaza as part of international efforts to deliver aid would be "a risk that we shouldn't take". His comments came after reports that UK

Vladimir Putin replaces Sergei Shoigu as defence minister in surprise move

Moscow Russian President Vladimir Putin tapped a civilian economist as his surprise new defence minister on Sunday in an was approaching a situation like the attempt to gird Russia for economic war by trying to better utilise the defence budget and harness greater innovation to win in Ukraine.More than two years into the conflict, which has cost both sides heavy casualties, Putin proposed Andrei Belousov, a 65-year-old former deputy prime minister who specialises in economics, to replace his long-term ally, Sergei Shoigu, 68, as defence minister. Putin wants Shoigu, in charge of defence since 2012 and a long-standing friend and ally, to become the secretary of Russia's powerful Security Council, replacing incumbent Nikolai Patrushev, and to also have responsibilities for the military-industrial complex, the Kremlin said. Patrushev will get a new, as yet unannounced, job. The changes, certain to be approved by parliamentarians, are the most significant Putin has made to the military command since sending tens of thousands of troops into Ukraine in February 2022 in what he called a special military operation.

Valery Gerasimov, the chief of Russia's General Staff and someone with a more hands-on role when it comes to directing the war, will remain in post.

Shoigu was heavily criticised by Russian military bloggers for a series of retreats the Russian military was forced to make in 2022. Yevgeny Prigozhin, the leader of the Wagner mercenary group and one of Shoigu's fiercest critics.

6.4-magnitude earthquake strikes near Mexico-Guatemala border

Mexico and Guatemala early Sunday, driving frightened residents into the streets. The temblor struck just before 6 a.m. near the Mexican border town of Suchiate, where a river by the same name divides the two countries.

A strong earthquake measuring 6.4 on but there were no reports of deaths. In Tapachula, near the border, civil defence brigades were moving through



Didier Solares, an official with Suchiate's Civil Defense agency, said so far they had not found damage.

"Luckily, everything is good," Solares said. "We are talking with companies, to the (rural areas) via radio and there's nothing, there's no damage thank God," he said. The early morning quake still gave people a fright.

In the mountainous and picturesque colonial city of San Cristobal, the shaking was strong.

"Here we got up because we have the seismic alert service," said resident Joaquin Morales. "The alert woke me up because it comes 30 seconds before (the quake)."In Tuxtla Chico, a town near Tapachula, Mar-a Guzman, a teacher said: "It was horrible, it felt strong. It was a real scare."Later Sunday, there was a swarm of at least two dozen small earthquakes in Mexico's northern state of Baja California, near the

US border. The largest of the quakes was of 4.6 magnitude, while the majority were between 2.5 and 3.7.No immediate damage was reported in the sparsely populated region roughly 50 m south of a relatively unpopulated aea south of El Centro, California. They did not appear related to the quake in Suchiate, which is almost 3,750 km to the southeast.

Blinken questions Israel's post-war plan as forces push deeper into Rafah

World Israel's offensive against Hamas intensified further as Israeli forces pushed deeper into the city of Rafah in southern Gaza, with Palestinian health officials reporting 19 deaths and dozens of injuries. As Israel expanded its operations, US Secretary of State Antony Blinken reiterated America's strong opposition to a major military assault on the enclave that houses over a million Palestinians, saying that Israel would "be left holding the bag on an enduring insurgency" without an exit from Gaza and a post-war governance plan.Meanwhile, ramping up the pressure on Tel Aviv, Egypt on Sunday said it would intervene in support of South Africa's case against Israel at the International Court of

Here are the latest developments in the Israel-Hamas war:Israeli forces sent tanks into eastern Jabalia in the northern Gaza Strip, with heavy aerial and ground bombardments. They also pushed deep into Jabalia camp, closer than the first time when they invaded northern Gaza. The Palestinian health ministry said the death toll in the war had exceeded 35,000 people. Antony Blinken said the United States was continuing to press Israeli leaders to provide a plan for Gaza once the war is finally

"Israel's on the trajectory, potentially, to inherit an insurgency with many armed Hamas left, or if it leaves, a vacuum filled by chaos, filled by anarchy and probably refilled by Hamas," he

Citing the growing scale of Israel's operations in Gaza and their impact on civilians, Egypt pledged support to South Africa's ongoing accusing Israel of genocide in Gaza.

The intervention in this case comes in light of the expansion in scope and scale of Israeli violations against civilians in Gaza," the Egyptian foreign ministry said, without specifying what the intervention would entail.

Israeli Prime Minister Benjamin Netanyahu in a Memorial Day speech vowed to continue fighting until victory in memory of those killed in the war. Netanyahu said that Israel has "completed about half" of its war against Hamas in Gaza, "but we are committed to completing this sacred task".

Meanwhile, pro-Palestine protesters disrupted college graduation ceremonies throughout the US over the weekend, with students walking out in protest of commencement speaker Jerry Seinfeld at Duke University and demonstrators splashing red paint on the steps of a building at the University of North Carolina.

Ex-US Marine pilot arrested in Australia had links with Chinese hacker: Lawyer

Sydney, UPDATED A former US Marine pilot fighting extradition from Australia on US charges of training Chinese military pilots to land on aircraft carriers unknowingly worked with a Chinese hacker, his lawyer said.

Daniel Duggan, 55, a naturalised Australian citizen, feared requests by Western intelligence agencies for sensitive information were putting his family at risk, the lawyer said in a legal filing seen by Reuters. The lawyer's lining supports Reuter reporting linking Duggan to convicted Chinese defence hacker Su Bin.Duggan denies the allegations that he broke US arms control laws. He has been in an Australian maximum security prison since his 2022 arrest after returning from six years working in BeijingUS authorities found correspondence with Duggan on electronic devices seized from Su Bin, Duggan's lawyer Bernard Collaery said in the March submission to Australian Attorney General Mark Dreyfus, who will decide whether to surrender Duggan to the US after a magistrate hears Duggan's extradition caseThe case will be heard in a Sydney court this month, two years after his arrest in rural Australia at a time when Britain was warning its



former military pilots not to work for China.u Bin, arrested in Canada in 2014, pleaded guilty in 2016 to theft of US military aircraft designs by hacking major US defence contractors. He is listed among seven co-conspirators with Duggan in the extradition request.Duggan knew Su Bin as an employment broker for Chinese state aviation company AVIC, lawyer Collaery wrote, and the hacking case was "totally unrelated to our client". Although Su Bin "may have had an improper connection to

(Chinese) agents, this was unknown to our client", Duggan's lawyer wrote. 'OVERT INTELLIGENCE CONTACT' AVIC was blacklisted by the US last year as a Chinese military-linked company.

Messages retrieved from Su Bin's electronic devices show he paid for Duggan's travel from Australia to Beijing in May 2012, according to extradition documents lodged by the United States with the Australian court.

Duggan asked Su Bin to help source

Chinese aircraft parts for his Top Gun tourist flight business in Australia, Collaery wrote. The Australian Security Intelligence Organisation (ASIO) and US Navy criminal investigators knew Duggan was training pilots for AVIC and met him in Australia's Tasmania state in December 2012 and February 2013, his lawyer wrote. ASIO and the US Navy Criminal Investigation Service did not respond to Reuters requests for comment on the meetings. ASIO has previously said it would not comment as the matter was before the court.

An ASIO officer suggested that while carrying on his legitimate business operations in China, Mr Duggan may be able to gather sensitive information," his lawyer wrote. Duggan moved to China in 2013 and was barred from leaving the country in 2014, his lawyer said. Duggan's LinkedIn profile and aviation sources who knew him said he was working in China as an aviation consultant in 2013 and 2014.

He renounced his US citizenship in 2016 at the US embassy in Beijing, backdated to 2012 on a certificate, after "overt intelligence contact by US authorities that may have compromised his family safety", his lawyer wrote.

Rooftop solar panel users in Kerala decry generation duty hike

THIRUVANANTHAPURAM: Consumers who have installed rooftop solar panels have been dealt a severe blow with a steep increase in electricity generation duty imposed on them. The levy on consumers who generate energy for their consumption has been raised from

1.2 paise to 15 paise per unit from April 1.

department, the KSEB and the chief electrical inspector for violating the central government's decision that generation duty should not be collected for solar power, which is renewable energy. The chief electrical inspector had come out with an order dated March 27 stating that electricity generation duty would be imposed on all licensees from the start of the financial year. It was only when consumers received their generation bills this month that the additional burden came to light. Besides this tariff, these consumers

also pay a fixed charge, meter rent, energy charges, duty, fuel surcharge and monthly fuel surcharge. One consumer's Rs 2,380 bill included Rs 89.55 in generation duty.Discussion threads on the Kerala Solar Power Community Facebook page, which includes those who have installed rooftop solar panels among its 72,000 membes, have been deeply critical of the move.Jameskutty Thomas, a rooftop solar power unit owner who is also a retired

electrical inspector, said that it was in 1968 that the state government promulgated the Electrical Duty Act and Rules that said 1.2 paise per unit of power should be procured from consumers.

Violates central directive'

"The 2023-24 state budget increased it to 15 paise per unit. This was despite the Centre maintaining that consumers cannot be charged generation duty for renewable



energy. For every Rs 6 per unit of power generated, the duty has gone up by 11.5%. For instance, a person who receives Rs 1,260 as generation bill will have to pay Rs 100-120 as generation duty," Thomas told TNIE.Chief electrical inspector G Vinod said the 1968 Rules did not have any mention of solar power. The electrical inspectorate had proposed amending the legislation.

government of the Centre's recommendation not to impose generation duty. We are awaiting a policy decision. Also, currently the full budget has not yet been approved. The organization, based on research, rigorous discussion and expert inputs, have divided their demands in three broad areas, including city & infrastructure, healthcare and environment. Health, environment & infra are key demands in youth manifestoMark Your Presence, an NGO, founded by Chaitanya Prabhu in 2018, is primarily managed by young students from across the city. The organization has been working with young voters in creating awareness and making college campuses voter friendly. Ahead of the elections, based on surveys with close to 1,000 students, it has drawn up an action plan for the political representatives. The idea was to bridge the gap between the youth and their elected representatives and to increase their participation in the democratic process. Prabhu, who conceived the idea of the manifesto document about a year and a half ago, said that many youths are politically aware and are interested in participating in the political discourse. "Documents like these are a reflection of youth's interest in the democratic process," he said. Among their long list of demands, divided in three sections, the students have asked for more open spaces, more employment opportunities from educational institutions, comprehensive waste management infrastructure, regulation of medical institutions, addressing the problem of ageing population, government grants for medical innovations, awareness workshops on health insurance, timely alerts and information on AQIs, better monitoring network, and incentives for cleaner energy sources. The NGO, which worked on the manifesto for over a year, not only took opinions from a diverse student population through questionnaires, held focused group discussions, but also took expert consultations. Housing expert and urban planner Chandrasekhar Prabhu, former dean of KEM Hospital Dr Avinash Supe and founder of Vanshakti and environmental activist Stalin Davanand were part of the expert committee. which contributed to the manifesto. The organization also held workshops to ensure that their manifesto resonates with the grassroots. Feedback was also taken from the stakeholders and incorporated in the final

Another star hotel asked fighting couple, aide to leave Kolkata: A day after a businessman from Gujarat and his aide from Mumbai were arrested for a severe

attack on the businessman's wife at a star hotel in the city, police found on Sunday that the three had recently put up at another star hotel, which had asked them to leave on the night of May 8 for their constant rows, which had led other guests to expressed their displeasure. The wife, a transwoman, was also arrested on Sunday under Foreigners Act for using fake citizenship documents. After being asked to vacate that hotel, the three had checked into the star hotel on E M Bypass on May 9. Another star hotel asked fighting couple, aide to leave

Police said the couple had legally got married on May 2. "But the Vadodara-based businessman claimed they got married on May 6. Shortly, the woman apparently told him she faced multiple problems adjusting to his demands and that she wanted to end their marriage. The woman said she felt like a victim of marital rape," said an officer, adding this led to the couple's constant fights at the two hotels. On the intervening night of Friday and Saturday, the woman was found severely injured in the hotel's lobby and she had claimed she had been assaulted by her husband and his aide. The two men were arrested from near the airport and booked for attempt to murder and assault. "The men have been remanded in police custody till May 16 and the woman till May 18," said DC (East) Arish Bilal. Police are checking the CCTV footage from the two hotels' lobbies.

A probe has revealed the businessman's family was upset with the wedding and that they had sent his aide, who ran a security agency, to visit Kolkata and convince the businessman to break up. But with the turn of the event, the aide told police, he had sided with the businessman. Cops said the woman was a Bangladeshi national from Barisal who had illegally entered India through the Tripura border in 2012. She lived in Guwahati for some time, used forged documents to get an Aadhaar card from Howrah and started a sex-change procedure at a clinic in Delhi's Rohini in 2013. In 2020, she shifted to Uluberia and started living with a 'guruma'. She then frequented dance bars in Bihar, Delhi and Goa. She had met the businessman at a New Year's party last year in Goa and the two decided to get married, police said.

While Madhavi is challenging AIMIM's Asaduddin Owaisi in Hyderabad Lok Sabha constituency, a seat dominated by the MIM for the past 40 years, Suneetha is pitted against veteran politician and former minister Eatela Rajender of BJP, who is also testing his electoral fortunes for the first time in parliamentary election from Malkajgiri constituency. Even Congress candidate Sameer Waliullah from Hyderabad and BRS candidate Ragidi Laxma Reddy from Malkajgiri are making their debut in the Lok Sabha polls. Tribal girl in Tamil Nadu tops class 10 boards from outside network coverage

TIRUCHY: "The number you're trying to reach is not available at the moment," echoes the recording whenever someone attempts to contact R Dhanusha, a tribal community girl from Sillaiyur village who has secured a centum in mathematics in the class 10 public examination. As there is no mobile phone tower in her place, it's quite tricky to reach out to Dhanusha and her parents, who are cashew farm workers in the village at Vannadu panchayat, nestled in the hills of Pachamalai. In order to talk to TNIE, she had to walk over a kilometre to

get connectivity. A student of Government Tribal Residential Higher Secondary School in Chinna Illupur, Dhanusha is the only student among all the five tribal residential schools in the Thuraiyur region to score a centum in the boards this year. Scoring a total of 450 marks, Dhanusha is also the topper of her school. With her voice breaking up over the call, Dhanusha said, "I travelled back and forth to my village on weekends to work alongside my parents in the agriculture field. When my father goes to work in the downhill area, I



take responsibility of the field along with

Rathika, mother of Dhanusha, said, "We are cashew cultivators by profession. Along with her studies, she helped us a lot with work. Whatever she opts to study, we will stand by her and help her achieve her dream."P Selvam, headmaster of the school, said, "We are happy that our student has achieved a centum. She has scored 450 in the exam and topped in the school. Hailing from a poor background, she was able to achieve this through her hard work under teachers' guidance. Since she is staying in the hostel, we gave

her focused training." He added, "If she had scored more than 90 in English, she might have scored above 480, setting a record for the highest marks scored by a student in the school's history. We are aiming for more centums in the next year."The same school achieved two centums in Science last year in the tenth public examination, as per sources. Dhanusha said, "I want to become a Collector (IAS officer) and do good for the people in my area. I want to thank my teacher R Suji and the headmaster for making this possible."

On Mother's Day, and every day

I can't forget that ear twisting I got from mom. I had taken a 10 paisa coin from her purse to buy a kulfi without permission. Stealing is a bad habit was a lesson learnt, the harder way at that tender age of five. Her supervision and concern for me hasn't abated even after half a century of my existence. As the saying goes, life doesn't come with a manual, but it does come with a mother. Born in a middle class family in the mofussil town of Nabha, she disregarded the patriarchal societal diktats that discouraged girls from various outdoor activities. Be it playing hockey for college or attending NCC camps or pursuing her passion for music, she didn't let gender hamper her dreams. Later, she chose to teach instrumental music as a profession, something that wasn't common amng girls from the so-called 'good families'. Finally retiring as a college principal, she was an epitome of women empowerment in

Our father being in the Army was mostly away, posted in field areas. The responsibility of bringing up children singlehandedly fell upon her. During my years in boarding school, she would look me up every fortnight, travelling all the way in a bus on Sundays — the only easy day, perhaps, a working woman gets. When both her sons got commissioned, mom got the smartest salute from them. No doubt, a mother can take place of all others, but whose place no one else can take.

On entering teenage, I would get a pestering dose of lectures against drugs and juvenile vices to refrain from. 'I have raised him this far, now I entrust you with the responsibility of grooming him for ethical soldiering'— she wouldn't hesitate even to 'instruct' my first commanding officer, who had been my father's subordinate in



the same regiment. A house proud octogenarian, she still manages her kitchen. On my getting married, she packed a 'working kitchen' for my bride, with an advice that the 'lady who manages the kitchen, controls the house'. Even today, she is our supplier of pickles, pinnis, homegrown mangoes and homemade wine. Before travelling, she never forgets to hand us an artistically packed meal for the journey. Love is invariably the secret ingredient in her cooking. She taught me the concept of God and that faith has always kept me anchored. A silent prayer of gratitude is better than a prayer of request, is what I learnt from her. Whenever the sea of life got rough, and for some reason I found God missing, I looked upon my mother to help me steer the right course.

Now, in the evening of her life, we don't have much time left under her protective wings. I dread the deafening silence that will follow once she returns to her maker. To the world, she is our mother, but to her family, she is the world.

I feel blessed that she has held my hand for such a long time, a privilege that has been denied to

Social erasure of women

Remember that many women are still laapataa. Worse, they don't even care to find themselves

Let us take a break from the daily exchange of disgusting barbs being flung by our venerable political leaders at each other. The level of political discourse has sunk so low by now that short of using actual swear words, rival candidates have tried everything else. So, a resolute silence over who will win and who will lose the 2024 elections! As far as I am concerned — and I'm sure there are many like me — we have all lost. Pity this proud democracy and its citizens for having such a useless bunch of leaders. That said, let me take you as far away from this muck as I can by recommending a film that needs to be seen and discussed for many reasons. Called 'Laapataa Ladies', produced by Aamir Khan and Kiran Rao, it is now available on Netflix for those who missed it in cinema halls. Long, long ago, Rabindranath Tagore wrote a story called 'Nouka Dubi' (The Boat Capsized) that had a similar theme. A barge carrying two sets of newly-wed couples capsizes, and in the melee that follows, the brides get exchanged. The story was made into a film and although I never saw it, it always tickled my fancy.

After all these years, Kiran Rao has picked up the same dilemma and brought it up to the present times by including some interesting twists in the plot. 'Laapataa Ladies' is set in the rural backwaters of the Hindi heartland, the last bastion of Hindu orthodoxy and patriarchal families. Like many of us, Rao says she always wondered what life in those sad-looking stations that trains pass by must be like. Dotting wind-swept fields and often a mere cluster of mud jhuggis with thatched roofs, they belong to an era that the rest of India left decades ago. Dusty, dismal, with no visible signs of modernity (such as electricity pylons, Internet towers and pucca buildings), life here seems frozen in a time warp. As we whizz past them in air-conditioned coaches, munching snacks and sipping fruit drinks, it is difficult to register this forgotten India that we all prefer not to see or think about, and ever visit.

The main plot of Rao's film is a variation of the Tagore story, where two brides — their faces covered by veils — get mixed up in the confusion of alighting Beyond this, the curious case of a girl who doesn't from a train and end up with the wrong husband and wrong villages. One finds a home in the wrong sasural but the other — the really lost bride — has neither a home nor a sasural and ends up sitting on the platform of a tiny railway station, hoping that her husband (whose name she does not utter) will find



her. The efforts of the kindly station master and the local thanedar come to naught for Phool (this laapataa bride) cannot remember the name of her native village or that of her husband's village. Let me not say more about the delightful twists and turns that are negotiated by the scriptwriter and give the plot away, but here are some points that moved me.

Tempting as it must be to resort to stereotypes when creating low-level government characters, Rao manages to mine their softer side to reveal that humanity is still alive and kicking in India. Missing people are not just grainy photographs published in a remote corner of our newspapers, but lives that have an individual story that can shake one. That orphans, beggars and those with the least to offer are often the most generous among us, and that goodness is not yet completely buried by greed, goons and government karamcharis.

remember her own name brought to my mind those countless women in our part of North India whose names were erased by their roles. So, bahu, bahurani, so-and-so ki amma, bitiya... all these were ways of making young brides forget that they had an identity of their own. Years ago, my nieces

decided to create a family tree of the women in their father's family. They were young feminists who did not like the idea that the official family tree they were shown had only men in all the branches. So they decided to ask their grandfather (the oldest person in their family) to help them fill in the blanks. Shockingly, he did not know his mother's name because she had passed away when he was just three. His own sisters, surrogate guardians after his mother's demise, were known as Choti Di, Bari Di, and referred to as only that. Other loving female relatives were Chachi, Bua, Mami and so on. Their names were laapata! When our family panditji conducted any shraddh or puja, he only asked for the names of the males on either side (the paternal and maternal) to be recited. No woman was ever remembered in such rituals after she died.

PN Haksar's beautiful memoir ('One More Life, 1913-1929') is dedicated to all the nameless women of his family who gave him such a memorable early life, but who had no names other than the titles they were given in the family.

Think about this social erasure of women and remember that many women are still laapataa. Worse, they don't even care to find themselves.

Donkey flights

Jamaican case turns spotlight on the menace

LESS than five months after a Nicaragua-bound chartered plane, carrying mostly Indians, landed in Mumbai after running into trouble with the French authorities, a flight with 200-odd Indians on board was sent back to Dubai from Jamaica as immigration officials detected discrepancies in the passengers' documents. The group was reportedly transiting through the Caribbean country, with some of its travellers destined for Nicaragua 'in the hope of participating in a major housing development project.

The Nicaragua angle has again turned the spotlight on the menace of donkey/dunki flights. Unscrupulous travel agents arrange such flights to Central American nations with the aim of facilitating passengers' illegal entry into the US. Nicaragua is popular among migrants apparently due to the ease of obtaining travel papers for the purpose. In January, the Gujarat Crime Investigation Department had said that the 66 passengers from the state on the chartered flight that was



grounded at Vatry airport in France in December 2023 on the suspicion of human trafficking had agreed to pay Rs

60-80 lakh to agents to illegally migrate to the US. Some passengers had allegedly paid an advance of up to Rs 8 lakh. At that time, the Punjab Police had formed an SIT to probe the case as several passengers were from the northern state.

It is obvious that an international network of agents - hand in glove with officials at every stage — is helping illegal migrants move from one country to another. The desperate travellers are risking life and limb, besides their life savings, to reach their final destination. Close coordination between agencies of various countries is needed to bust the flourishing human trafficking racket. It is a cause for concern that many unauthorised agents continue to ply their trade despite the frequently reported cases of boat tragedies and grounded flights. The Indian authorities must get their act together as the repeated involvement of its nationals in such illicit activities is an

embarrassment for the nation.

Long court vacation goes against consumer interest

Consumer Protection Act mandates that cases be decided as expeditiously as possible. It is ironic that lawyers are seeking directions that go against the law

I have nothing against lawyers per se, but I certainly have strong reservations about their presence in consumer courts, because it militates against the very principle on which consumer protection jurisprudence and the grievance redress mechanism are built. They have not only slowed down the adjudication process in the consumer tribunals through repeated adjournments, but have also brought all the trappings of the civil court, making it difficult for consumers to fight their cases without lawyers. Now they want the apex consumer court, the National Consumer Disputes Redressal Commission, to have long summer and winter vacations like the Supreme Court and the High Courts and have sought the intervention of the Delhi High Court to ensure that. If you look at the Consumer Protection (Consumer Commission Procedure) Regulations, first notified in 1987 (under the Consumer Protection Act of 1986), later revised in 2005 and notified again in 2020 under the new Consumer Protection Act, 2019, none of them provide for winter and summer vacations. The Regulations mandate normal working hours on all working days of the Central government in case of the National Commission and all working days of the state government in case of state consumer disputes redressal commissions and the district consumer disputes redressal commissions. So, declaring summer and winter vacations clearly violates the law.

Yet, in a writ petition filed before the Delhi High Court, the All India Bar Association of the National Consumer Disputes Redressal Commission has sought directions from the High Court to the Union government as well as the National Consumer Disputes Redressal Commission to restore the summer vacation in the month of June and winter

vacation in the last week of December in the calendar of the Commission, in consonance with the calendars of the Supreme Court and the High Court and other tribunals and commissions working under different ministries. It is truly ironic that the lawyers, who are supposed to uphold the law, are seeking directions that go against the law!Unfortunately, the consumer commissions at the national, state and the district levels did violate the Regulations of 1987 and 2005 and enjoyed summer, winter and even Dasehra vacations. In fact, a look at the National Commission's calendar shows the declaration of summer and winter vacations till the year 2020. The calendar, however, changes from 2021 when the National Commission decided to abide by the Regulation notified in July 2020 and put a stop to those vacations and asked the state commissions and the district commissions to follow suit. Initially, some of the states were reluctant to comply, forcing the consumer affairs ministry in May 2022 to write to the chief secretaries

of the states and the state commissions, urging them to comply with the Regulations in the interest of timely disposal of cases.

The effect of this, along with facilities like e-filing and videoconferencing, can be seen in the fact that the consumer commissions are recording for the first time a new, highly positive trend — the number of cases resolved in a year is more than the number of cases filed in that year. In 2023, for example, as against 1.26 lakh complaints filed, the number of




cases disposed of was 1.36 lakh. The record of the National Commission vis-à-vis the disposal rate was even more remarkable. Consequently, there is a slow decline in the number of pending cases before these commissions in the last few years. From 5,60,700 in 2021, the number of pending cases came down to 5,43,359 in 2023.

While consumers are upbeat about this, it is unfortunate that the lawyers are seeking an interim order from the Delhi High Court directing the National Commission not to list any cases in the months of June and the last week of December. In other words, the lawyers now want a reversal of the encouraging developments of the last few years, just to suit their convenience. With its promise of simple and speedy consumer justice, the Consumer Protection Act mandates that cases be decided as expeditiously as possible and within three months. The law also says that no adjournment shall ordinarily be given. But, unfortunately, adjournments have been commonplace, thanks to lawyers.

Studies on the working of the consumer courts, by the Indian Institute of Public Administration, have consistently underscored this. Pointing to frequent postponement of the hearings as the biggest impediment to speedy justice before the consumer courts, its report of 2020 said that in 71.8 per cent of the cases filed before the

district commissions, adjournments, often given for frivolous reasons, delayed the proceedings. In 25.6 per cent of the cases, such adjournments exceeded seven!The study, which analysed the procedural delay in the disposal of consumer complaints, also blamed lawyers for introducing unnecessary technicalities in the proceedings. Now, their writ petition, seeking to restore the long vacations of the apex consumer court, is certainly not in the interest of consumers or consumer justice.

Hoax Bomb Scare Grips Delhi Hospitals, Airport After Threats To Schools

New Delhi: Several hospitals in Delhi, along with the Indira Gandhi International Airport, received bomb threat emails on Sunday, triggering a panic and sending the security personnel into a tizzy. However, subsequent investigations by Delhi Police revealed the threats to be false alarms.

The fresh incident follows closely on the heels of a similar incident over 10 days ago when over 100 schools across Delhi-NCR received hoax threat emails, prompting widespread police response searches.On Sunday, bomb threat emails were sent to 21 addresses, prompting the hospitals to notify police, who along with bomb disposal squads conducted extensive searches of all the premises, yet no evidence of any explosives was discovered.

At around 3.30 p.m. on Sunday, a bomb hoax email was received at GTB Hospital, GTB Enclave. Hospital authorities informed the local police about that email. Immediately, the police swung into action and called the Bomb Disposal Squad at the Hospital and nothing threatening was uncovered.

Blues In Indian Market: Sensex Declines Over 650 Points, Nifty Below 21,900

New Delhi. The BSE Sensex on May 13 declined 656.52 points to 72,007, while the NSE Nifty also dropped 174.15 points to below 21,900. Tata Motors, JSW Steel, Tata Steel, SBI and NTPC were the biggest laggards dragging the domestic equities market. The rupee also opened on a flat note at 83.51 against US dollar.

Among the Sensex shares, 27 out of 30 shares were trading in the red. Only Sun Pharma, Asian Paints and Kotak Mahindra Bank were in the green.

V K Vijayakumar, chief investment strategist at Geojit Financial Services, said, "There is confusion regarding the reasons for the aggressive FPI selling in May. There are media reports attributing the FPI selling to possible setbacks to the NDA/BJP in the elections. It is important to understand that the FPI selling is due to a change in FPI stance from 'sell China, buy India' earlier to 'sell India, buy China' now. This change in stance has been caused by the recent outperformance of China (Shanghai Composite up by 3.96% and Hang Seng up by 10.93% last one month) and underperformance of India (Nifty down by 2.06% last one month). This is likely to be a near-term trend triggered by the cheap valuations of Chinese stocks and the relative high valuations of India.'

He added that it is important to understand that India's long-term prospects are much better than China's. Results of the autos sector are good. The sector is in a cyclical uptrend. Technical View

Nifty fell below 22,000 raising concerns of a drop to 21,500. There's a slim chance of a short-term bounce to 22,400 early this week based on technical indicators, but only if Nifty stays above 21,777 and surpasses 22,095. Anand James, chief market strategist at Geojit Financial Services, said

'The break of 22000 in Nifty did bring in jitters, and the recovery swing on Friday failed to push much above our upside marker of 22095. Seen in isolation this suggests that the 21500 trajectory that we had set out with on Friday continues to be in play.'

Tata Motors Declines 7.7% To Below Rs 1,000 On BSE: What **Brokerages Say?**

New Delhi. Tata Motors on Monday declined 7.68 per cent to below Rs 1,000 at Rs 966.40 apiece on the BSE in the early trade, as its Q4 results missed Street estimates and brokerage retained 'Reduce' position. Its net profit during January-March 2024 soared over threefold in Q4, with its share price rising on Friday. However, it missed Street estimates on revenue and Ebitda fronts.

Tata Motors' total consolidated revenue from operations during January-March 2024 stood at Rs 1,19,986.31 crore, compared with Rs 1,05,932.35 crore in the yearago period. Following the Q4 results, brokerage Emkay Global retained its 'Reduce' rating on the Tata Motors stock, with an unchanged target price of Rs 950 per

It said Tata Motors' Q4 earnings were muted, with limited margin expansion across businesses, despite higher volumes. While deleveraging progress continued, it believes the best may be behind for all businesses amid declining orderbook, normalising mix, flattish growth outlook for domestic CV space; and moderating India

Another brokerage Novuma also retained its 'Reduce' view. It said, "A muted showing in India CV is likely due to loss of share to railways (DFC), slowdown in infra spend and high base. We are building in a moderate revenue/EBITDA CAGR of 8 per cent/13 per cent over FY24–26E versus 21 per cent/25 per cent over FY21–24. Tata Motors has rallied 15 per cent/60 per cent in past three/six months, and 1-year forward EV/EBITDA is 6 times against 5-year mean of 5 times. Retain 'REDUCE' with target at Rs 940 (unchanged)."

HDFC Bank Reduces Notice Period From 90 Days To 30 Days

businesses have come in and New Delhi.HDFC Bank, India's largest private sector lender, has reduced its notice period for employees from 90 days to 30 days, according to an FE report. The bank hopes that this change will improve flexibility. This is the second private sector lender to make this change after ICICI Bank in 2020 cut the notice period from 90 days to 30 days. "This change in policy aims to provide more flexibility for employees while ensuring smooth transitions," the FE report quoted a senior HDFC Bank official as saying.



HDFC Bank employees were informed of the change in the HR policy by email on May 6, according to the report citing sources.

According to the latest changes, employees under probation need to serve a 30-day notice period. However, employees, according to the report, employees can even be relieved in less than 30 days if their request is approved by their reporting manager. Currently, Kotak Mahindra Bank has a notice period of 90 days. Public sector lenders like State Bank of India, Punjab National Bank and Bank of Baroda also have the same duration of notice period. The total number of employees at HDFC Bank crossed the 2 lakh mark to reach 208,066 in the third quarter of FY24.In Q4 FY24, HDFC Bank reported a 37.05 per cent jump in its standalone net profit to Rs 16,511.85 crore. Its net interest income (interest earned less interest expended) during the quarter ended March 31, 2024, grew 24.51 per cent to Rs 29,076.82 crore, from Rs 23,351.83 crore a year ago, according to a BSE filing. For the full year 2023-24, Its net profit stood at Rs 60,810 crore, which is 37.9 per cent higher as compared with that in the year-ago period.



Bengaluru Faf du Plessis' RCB stayed alive in the playoffs race after winning their home game against DC on Sunday, 12 May. This was RCB's 5th straight win in the Indian Premier League as the side turned its fortunes after a hapless start to the season. Before the winning streak, RCB had lost 6 matches in a row, which got them to the brink of getting knocked out of the tournament.

However, the Bengaluru-based side made some crucial changes in approach to turn their fortunes around. The RCB side burst into celebrations in the dressing room after their win against DC on Sunday. The coaching staff lauded each and every player who did well and the celebration was like none other seen so far in the Indian Premier League's 2024 season. media where the likes of Cameron Green and Rajat Patidar can be seen enjoying in full blast.Earlier, RCB head coach Andy Flower had spoken about the change of approach made by the top order, who looked to be more attacking from the very start. Flower had lauded the bowling unit as well who were trying to be as attacking with their lengths and options as possible.

'Faf and Virat particularly have led from the front with their actions, and the rest of the team have been outstanding. I think we have seen an uptick in the way that we've bowled in the powerplay, and I think that's been led by Siraj and Yash Dayal. Both have been very skilful and courageous with the new ball," Flower said in an RCB video.RCB have a faint chance of qualifying through to the playoffs stage if they

beat CSK at home in their final group stage game in the Indian Premier League. The team has risen to the 5th spot in the league table with 12 points from 13 matches. Ahead of RCB are SRH, CSK, RR and KKR. KKR has already qualified while the other teams are just one win away from the playoffs spot.

Rajat Patidar's cover drive was just like one from Virat Kohli: Brett Lee

Patidar continued his form against Delhi as he came to RCB's rescue with his 5th fifty of the campaign. Amidst some of the brilliant shots he played was a cover drive he hit off Mukesh Kumar's bowling in the 5th over of the game, which had left the pundits in awe.Lee, while talking to JioCinema, after RCB's 47-run win on Sunday said that if someone was watching the highlights, they would think it was a shot from Virat Kohli. The Aussie pacer said that the shot was as good as it gets and is hoping that Patidar can continue his form.

right away.""It's his 5th 50 this season, you know, we know he's played test cricket, but it took him a while to get going. How well has Patidar performed this season? Patidar had a rather slow start to the IPL 2024 season as he was coming into the campaign on the back of a lacklustre India vs England Test series. The MP batter had to step in as RCB were having an issue with the poor form of Glenn Maxwell.Patidar has taken up the role of Maxwell and has started to attack the spinners with ease and has hit more than 20 sixes against spin this season. Patidar, with his 52 against DC, has now scored 320 runs from 13 matches with a strike-rate of more than 179.Patidar will be key to RCB's chances of making it to the playoffs as they will face CSK in their final league game on May 18 in Bengaluru.

Kylian Mbappe gets booed by fans in final PSG home game vs Toulouse

New Delhi Outgoing PSG star Kylian Mbappe was booed by a section of the fans in his final home game at Parc des Princes on Sunday, 12 May. Mbappe, who had announced that he would be leaving the club on a free transfer in 2024, caught the ire of the fans. The 25-year-old's name was announced ahead of the match when PSG were announcing their line-up and the PSG ultras let their feelings known for the player.

The video of the incident was captured by one of the fans in the stadium. Incidentally, both Lionel Messi and Neymar were booed by the ultras before their exit earlier this season as well. On the day, Mbappe's departure became more painful after the team failed to win its home game against Toulouse. PSG vs Toulouse: As It Happened

Paris St Germain were left stunned after they were beaten 3-1 by Toulouse on Sunday, with the newly-crowned champions slumping to only their second Ligue 1 defeat this season.Luis Enrique's side struggled for form after their midweek Champions League semi-final loss to Borussia Dortmund and remain on 70 points from 32 games, six clear of second-placed AS Monaco with two games remaining."This defeat spoils the party a bit. It's always



frustrating, even if you're champion, to lose like that in front of your home crowd," PSG forward Ousmane Dembele told Canal+

We need to rethink things after a defeat and not lose like that at home, even if we are champions. "Kylian Mbappe, who confirmed on Friday that he will leave PSG at the end of the season, opened the scoring after eight minutes with a fine finish into an open goal following a pinpoint clearance from goalkeeper Arnau Tenas.

'He gave so much to the club, he did so much," Dembele said referring to Mbappe. "We're happy with everything he's done, he's grown up well at PSG, he's achieved so much, he's a PSG legend. We're proud of him."Toulouse equalised five minutes later through Thijs Dalling, who coolly slotted home from close range before Yann Gboho put the visitors ahead with a superb curling effort into the top right corner in the 68th minute.Frank Magri's stoppage-time strike sealed the win for Toulouse, who are 10th in the standings with 43 points.

PSG visit Nice on Wednesday before their final league game against Metz and the French Cup final on May 25. There's still the Cup final, a big match against Nice. We have to give 100% in every match and show a good image of Paris St Germain,' Dembele added. Elsewhere, second-half goals from Kassoum Ouattara and Youssouf Fofana earned Monaco a 2-0 away win over Montpellier to secure second place and a return to the Champions League. They will return to the group stage of the Europe's premier club competition for the first time since the 2018-19 season.Ligue 1's secondtop scorer Jonathan David scored a first-half brace to earn Lille a 2-1 win at Nantes to close in a Champions League spot as they climbed to third place, ahead of Brest on goal difference. They are level on 58 points

Premier League: Arsenal secure hard-fought 1-0 win against Manchester to go top again

New Delhi Arsenal's Leandro Trossard capitalised on dreadful Manchester United defending to secure a 1-0 win on Sunday that saw his side provisionally overtake Manchester City atop the Premier League and guaranteed the title race will go down to the final day. While Arsenal, who won for just the second time at Old Trafford in their last 17 visits, have 86 points with one game left of the tightest title race in years, holders City remain in the driving seat with 85 points and two matches to play. City, who are aiming for an unprecedented fourth consecutive English top-flight title, can retake the lead when they play at Arsenal's London rivals Tottenham Hotspur on Tuesday. Trossard scored in the 20th minute when Kai Havertz sauntered barely challenged into space on the right before

sending the ball into the box for Trossard to tuck home. Heads turned to check for an offside flag but Casemiro -- recently moved from midfield into United's injurydepleted back line -- had slowly moved out from the box and kept Havertz onside after goalkeeper Andre Onana launched the ball upfield.United manager Erik ten Hag was left shaking his head in frustration. The game swung from end to end over a final tense few minutes,

with Onana leaping to push away shots from Arsenal substitute Gabriel Martinelli and Declan Rice. United, who were hoping to bounce back after a woeful 4-0 loss at Crystal Palace on Monday, are eighth with two games left. They trail sixth-placed



Newcastle by three points in their quest for a European berth next season, setting up a key showdown when the Magpies visit Old Trafford on Wednesday. Trossard's goal was the 82nd Ten Hag's team have conceded this season in all competitions -their most in a single campaign since 197071United enjoyed plenty of the ball in the final third, and had 14 shots to Arsenal's 11, but struggled to create many quality chances.

Alejandro Garnacho was United's biggest threat, particularly in the second half. He launched one shot wide and sent another into the side netting before hanging his head in frustration. The visiting fans, whose singing did not let up all evening, erupted at the final whistle after a game that was
