New Delhi, May 5: Distribution of wrong question papers at a NEET exam centre in Rajasthan on Sunday led to some candidates walking out with the papers, the National Testing Agency (NTA) said, claiming the integrity of the examination process was not compromised. The exam was later reconducted for the 120 affected candidates at the centre, said Sadhna Parashar, Senior Director, NTA. According to NTA sources, some candidates were distributed question papers in languages other than their choice of medium which prompted them to walk out of the centre. "During NEET-UG examination, it came to attention that at one exam Girls Higher centre, Secondary Model School, Mantown, Sawai Madhopur, there was an incident of incorrect distribution of question

papers by the centre superintendent. Despite efforts by invigilators to prevent it, some candidates left the exam centre with the question papers," Parashar said. "In order to uphold the principles of fairness and equal opportunity for all candidates, the NTA has taken proactive measures. The examination of approximately 120 affected candidates at the centre is being conducted today, ensuring that their academic aspirations are not hindered by this incident," she added. Several social media posts alleged the question paper was leaked The NTA, however, denied any possibility of a leak. This year, a record 23 lakh candidates registered for the National Eligibility-cum-Test Entrance Undergraduate (NEET-UG)

of which over 10 lakh were male students, over 13 lakh were girls and 24 students registered under the third gender category.

Campaigning ends for third phase of Lok Sabha election, high stakes for BJP

Ahmedabad/Bengaluru, May 5: The highoctane campaign for the third phase of Lok Sabha election that saw the BJP-led NDA and the INDIA bloc fiercely attacking each other on issues like reservations and sexual harassment charges against JD(S) leader Prajwal Revanna concluded on Sunday evening in 92 seats spread over 11 states and Union Territories. The stakes are significant for the BJP in this round as the party had in 2019 won an overwhelming majority of these seats, including all in Gujarat, Chhattisgarh, Bihar and Madhya Pradesh, that will go to polls on May 7. Prime Minister Narendra Modi led the BJP charge, asking the Congress to give in writing that it will not hand over the quota for Scheduled Castes, Scheduled Tribes and Other Backward Classes to Muslims. The Congress and its allies accused the BJP of trying to tamper with the Constitution and do away with reservations. The principal opposition party, which has promised to remove the 50 per cent cap on reservations, also asked the BJP to clear its stance on the issue. Congress chief Mallikarjun Kharge along with party leaders Rahul Gandhi and Priyanka Gandhi Vadra

35 Naxalites surrender in Chhattisgarh's Dantewada district

Dantewada, May 5: A total of 35 Naxalites, three of them carrying a cumulative reward of Rs 3 lakh, surrendered in Chhattisgarh's Dantewada district on Sunday, a senior police official said. A 16-year-old girl and an 18-yearold boy are among those who turned themselves in before the police, he said. These cadres were tasked with digging roads, felling trees to block roads and putting up posters and banners during shutdowns called by Naxalites, the official said. Of the surrendered Naxalites, Baman Kartam (39) was the Jiyakodta Panchayat Militia Platoon Commander of the outlawed Maoists organisation, while Bhima Kunjam (28) was the Aranpur Panchayat CNM president, Dantewada Superintendent of Police Gaurav Rai said. Chetna Natya Mandli (CNM) is a cultural wing of Maoists. Woman Naxalite Kumme Lekam (35), who carried a reward of Rs 1 lakh, was the Hurrepal Panchayat Krantikari Mahila Adivasi Sangthan (KAMS) president, he said. "They were part of Bhairamgarh, Malanger and Katekalyan area committees of the Maoists in south Bastar. They said they were impressed by the police's rehabilitation drive 'Lon Varratu' (return to your home) and disappointed with the hollow Maoist ideology," Rai said.

Raipur, May 5: AICC spokesperson Radhika Khera on Sunday resigned from the party claiming that criticism over her visit to Lord Ram temple in Ayodhya led to the denial of justice to her in the incident that happened at the Chhattisgarh Congress office. Khera also claimed she didn't get justice even after repeatedly informing all the top leaders of the party. Stating that those who support religion have always faced opposition, Khera cited examples of mythological demons Hiranyakashyap, Ravan and Kansa to claim that some people oppose those who take the name of Lord Shri Ram in the same way. The AICC's communication and media coordinator for Chhattisgarh posted her resignation letter, addressed to Congress president Mallikarjuj Kharge, on her 'X' handle. Notably, an argument took place between Khera and Chhattisgarh Congress' communication wing chairperson Sushil Anand Shukla on April 30 in the party office in Raipur over the visit of sen-

Bengaluru, May 5: Holenarasipura MLA H D Revanna on Sunday called his arrest over the allegations of abducting a woman, whom Revanna's son is alleged to have sexually abused, an outcome of a political conspiracy. The former minister, who is the

son of former prime minister H D Deve Gowda, is facing the charge of kidnapping and illegally confining a woman who is the mother of three children. The complaint was lodged by the woman's son on Thursday. Revanna claimed there is no evidence of his involvement in the case based on the complaint against him registered on May 2. "There are no evidences pertaining to the May 2 complaint. It's a big political conspiracy... A conspiracy was hatched against me," Revanna told reporters at the Bowring and Lady Curzon Hospital, where he was taken for a medical checkup before being produced in court. Revanna was brought to the court by the

members of a Special Investigation Team. The SIT is investigating sexual abuse allegations involving his son and Hassan JD(S) MP Prajwal Revanna, after a huge cache of explicit videos allegedly involving Prajwal sexually abusing several women surfaced in



the public domain and were widely shared. In the complaint of abduction against H D Revanna to the KR Nagar police, the 20-yearold son of the victim alleged that Revanna's

close aide Sathish Babanna had taken his mother away on a motorcycle on April 29, stating that the MLA wanted to see her. The complainant stated that Babanna told him that if his mother "opened her mouth before the police", she and her family members would be arrested. Later, the 20-year-old complainant got to know from a friend and relative that his mother was among the women in the cache of videos that has gone public, and that it showed her being tied up and raped allegedly by Prajwal. As he expressed fear that his mother was in danger, police arrested Sathish Babanna and secured the victim from a farmhouse. Prajwal Revanna (33), who is the BJP-JD(S) Hassan Lok Sabha candidate, faces rape and molestation charges. The Karnataka government formed a Special Investigation Team on the recommendation of the Karnataka State Commission for Women Nagalakshmi Chowdhary, and is

Bhopal, May 5: Corporal Vikky Pahade who was killed in a terror attack in Poonch region of Jammu and Kashmir on Saturday. was supposed to return home to celebrate his son's birthday on May 7. The slain soldier hailed from Madhya Pradesh's Chhindwara district and was a resident of Nonia-Karbal village. Former Madhya Pradesh Chief Minister, Kamal Nath, in a social media post said: "I salute the martyrdom of Vicky Pahade, a resident of Nonia-Karbal, Chhindwara district, Madhya Pradesh, and pay my tribute to the immortal martyr." Cpl Pahade had visited his family last month to attend his sister's wedding and had joined the unit on April 18, local residents told IANS. Cpl Pahde (33) had joined the Indian Air Force (IAF) in 2011. He is survived by his five-year-old son, wife, mother and three sisters. Pahade was killed while four other IAF soldiers were injured when militants ambushed a convoy of IAF in Poonch on May 4. The IAF said that the Air Warriors fought back by returning fire. The Indian Air Force's official X handle stated.

Discrepancies in probe into Rohith Vemula's death, will ensure justice

New Delhi, May 5: The Congress on Sunday said there were many discrepancies in the investigation conducted previously into Rohith Vemula's death in 2016 and asserted that its government in Telangana will leave no stone unturned to ensure justice for his family. Police in Telangana have filed a closure report before a court in its probe into the death of Rohith Vemula, a student of the University of Hyderabad, claiming he was not a Dalit and died by suicide in 2016 as he feared that his "real caste" would be discovered. Congress general secretary, organisation, K C Venugopal, said Rohith Vemula's death was a grave atrocity that completely exposed the "anti-Dalit mindset" of the BJP. "The Congress, including Rahul Gandhi ji, has stood with Rohith Vemula's family through this difficult period," he said in a post on X. As has been clarified by the Telangana Police, the closure report concerned was prepared in June 2023, Venugopal said. "There were many

discrepancies in the investigation The conducted previously. Congress government Telangana will leave no stone unturned to ensure justice for Rohith's family," he asserted. The Congress came to power in the state last year by defeating the Bharat Rashtra Samithi (BRS). "Not only that, when we form a government at the Centre, we will pass a Rohith Vemula Act, specifically addressing the issue of caste and communal atrocities on campuses to ensure no student coming from socio-economic backward ness has to face the same plight as Rohith ever again," he said. Venugopal's remarks came a day after Rohith Vemula's mother Radhika Vemula met Telangana Chief Minister A Revanth Reddy in Hvderabad and urged him to see to it that "justice" is done to the family. Reddy assured her that an investigation would be conducted again into the University of Hyderabad student's suicide in 2016 and that justice would be done.

investigating the matter. Public at large thinks criminal trials are 'neither free nor fair', laments Supreme Court

New Delhi, May 5: Lamenting that there is "practically no effective and meaningful cross-examination" by public prosecutors of hostile witnesses during criminal trials, the Supreme Court has said the public at large thinks criminal trials are "neither free nor fair". "Free and fair trial is the very foundation of criminal jurisprudence. There is a reasonable apprehension in the mind of the public at large that the criminal trial is neither free nor fair with the prosecutor appointed by the state government conducting the trial in a manner where frequently the prosecution witnesses turn hostile," a Bench of CJI DY Chandrachud, Justice JB Pardiwala and Justice Manoj Misra said. Describing public prosecutors as "one of judges' natural counterparts in the trial proceedings", Justice Pardiwala said, "Time and again, this court has, through its judgments, said

like appointment to the post of public prosecutor, etc." Writing the judgment for the Bench, Justice Pardiwala said, "The only consideration for the government should be the merit of the person. The person should be not only competent, but he should also be a man of impeccable character and integrity. He should be a person who should be able to work independently without any reservations, dictates or other constraints. The relations between the Public Prosecution Service and the judiciary are the very cornerstone of the criminal justice system." The Bench said, "It is the duty of

the court to arrive at the truth and subserve the ends of justice. The courts have to take a participatory role in the trial and not act as mere tape recorders

that there should not be any element to record whatever is being stated by The court must be conscious of seriof political consideration in the matters the witnesses." The Bench said, "The ous pitfalls and dereliction of duty on



judge has to monitor the proceedings in aid of justice. Even if the prosecutor is remiss or lethargic in some ways, the court should control the proceedings effectively so that the ultimate objective that is the truth is arrived at.

Any committed crime against an individual is crime against the entire society. manner. The top court upheld the May 2014 verdict of the Delhi High Court affirming the conviction and life sentence awarded to one Annes by a sessions court for the 1995 murder of his wife in Mustafabad area in Delhi.

ENIL revenue rises 13.6% to 500cr for FY24

Mumbai: Entertainment Network (India) Ltd, operator of Radio Mirchi, reported a net revenue of Rs 149.3 crore for the fourth quarter of FY24, marking a 42.4% rise compared to the same quarter of FY23.Radio revenue witnessed growth of 26.4% in the fourth quarter of FY24, while non-FCT (Free Commercial Time) revenue surged by 48.1%, according to a company statement. It added that throughout FY24, radio experienced growth of 10.8%, whereas non-FCT grew by 8%. The families of former chief ministers S Bangarappa and BS Yediyurappa have locked horns in yet another political battle in Shimoga constituency, which goes to the polls on Tuesday.Spicing up an otherwise regular electoral bout between the two families is the entry of former deputy chief minister KS Eshwarappa, who has openly defied the BJP brass and has been dismissed from the

party.Eshwarappa, who had taken ticket denial in the 2023 elections in his stride, didn't take kindly to the party with which he had been since its birth denying ticket to his son KE Kanthesh this election. Believing that Yediyurappa and his sons were behind it, he has vowed out to teach them a 'lesson' by denting the prospects of sitting MP BY Raghavendra, the elder son of the BJP strongman. Speaking to STOI, he asserted he was contesting only to rid the BJP of its illusion that Yediyurappa and his family are indispensable for the party in Karnataka.

Knowing well that Hindutva sells better in Shivamogga, Eshwarappa has been constantly highlighting how Yediyurappa and his sons have sidelined hardcore Hindutva ideologues like CT Ravi, Nalin Kumar Kateel, and DV Sadananda Gowda. He is also banking on women self-help groups which have benefited from his family-run microfinancing company and Tamilians who constitute around 25,000 of the electorate.While it remains to be seen how many votes Eshwarappa will snatch



from Raghavendra's camp, his rebellion has certainly buoyed the Congress camp. "The more votes he takes, the brighter our chances of victory," said Basavarajappa, a Congress worker who runs a shop in Eesuru village in the segment.Congress' confidence is reflected in the campaigning of its candidate, Geetha Shivarajkumar, Bangarappa's daughter and wife of Sandalwood star Shivarajkumar. With her husband and her brother Madhu Bangarappa, a minister in the Siddaramaiah govt, throwing their all into the campaigning for the past month, Geetha is seeking to end her family's losing streak against the Yediyurappa family. This is the fifth time the families are facing off in a Lok Sabha election, and the Bangarappas haven't won even once previously.Geetha is also banking on Congress govt's five guarantees and the party's promise to give Rs 1 lakh a year to women heads of families if it wins the Lok Sabha polls. "Since the constituency is predominantly dominated by backward classes, SCs and STs, and most of them have benefited

from the Congress' guarantees, Geetha's victory seems certain," said Naveen, a Congress sympathiser. She and her brother have also been working to consolidate about four lakh votes from their own community - the Idigas. A few film actors, including Duniya Vijay, have also been drawing good crowds to her meetings and rallies. On his part, Raghavendra is banking on his father's popularity among voters cutting across caste barriers, PM

Narendra Modi's appeal, and the unprecedented development works the constituency, especially in urban pockets, has witnessed over the past decade. Be it building national highways, improving district and village roads, introducing more rails or constructing an airport, people believe Yediyurappa and Raghavendra have been instrumental. "Raghanna is a worker," is what even his opponents say. The Yediyurappa family is also campaigning aggressively, leaving nothing to chance as it is aware that losing Shivamogga will end the family's grip on the state BJP unit, considering the growing opposition to them within the party after BY Vijayendra, the younger son of Yediyurappa, took over as the state party president.We do realise the importance of winning this election and the necessity of overcoming Eshwarappa's rebellion. But my performance as an MP and Modi's popularity will help me win. People are also aware it is Modi's election and they should vote for BJP," Raghavendra said.

Rattled by fake videos in poll season, city cops seek X's help

Kolkata: City cops, faced with multiple fake and hate videos in the recent past, has requested social media platform X to ensure that the nodal officers, with whom senior cops are coordinating and are appointed on behalf of the company, act on their reports quickly. Ever since the election season has set in, cops registered as many as 10 FIRs in this regard. According to police sources, they have found at least two instances when videos from Sambalpur and Rajasthan were passed as that taking place in Kolkata.Rattled by fake videos in poll season, city cops seek X's help"As the probe progressed, we found that there were verified accounts belonging to those from the right wing that were spreading the maximum hate with fake videos. When we sent them legal notices under CrPC 149 on the X platform, we found that those who re-tweeted had removed them. But the content creators did not pay any heed to the notices. It is then that we requested X to remove them. So far, over two dozen such requests for removal of posts and videos have been made," said an officer.

Cops also took to the X platform, using its own DCP Cyber Kolkata Police handle, to state that it was necessary to recheck what is being reposted



on social media. "The misleading video is being circulated on social media claiming it to be from West Bengal. However, the incident happened in Sambalpur in 2023. Strict legal action is being taken against such profiles," stated one such message from cops.Cops said they were keeping the language of the notice simple for everyone to comprehend. "You are directed to immediately disclose your identity including name and residence. If the information sought is not revealed, you shall be liable for legal action under 42 CrPC. Cyber PS, Lalbazar," the tweets said. The official legal notice added: "It has been observed that you are using social media post for posting malicious and inciting content. Cyber police station hereby is issuing notice against you under CrPc 149 for posting such malicious content on social media that can adversely affect the law and order situation." The cops also shared the respective URL. The notice ended asking the user to delete the offensive post immediately.

The city's cyber cell and STF have also begun demarcating each fake or inciting video - from those circulating only on WhatsApp to those being shared across social media platforms. "One video is making its way to various types of

Mumbai constable's mysterious death investigation unveils surprising details

MUMBAI: The Government Railway Police (GRP) investigating the mysterious death of Mumbai police constable Vishal Pawar (30) are trying to determine his location between 7.30pm and 11.20 pm on April 27 in Thane, even though his scheduled work time to report was at 7 pm in Byculla. Additionally, Pawar's assertion that the 'Fatka Gang' had supposedly stolen his mobile phone and Rs200 in cash was proven to be false. "The technical assistance used in the probe showed that the mobile which Pawar claimed to have stolen was with himself and he had used it to make calls the next day," said a GRP police officer.

The officer stated that the investigation team gathered multiple CCTV footage from Thane to Dadar. The footage revealed Pawar boarding the 11.20 pm fast CST local train from Thane on April 27, getting off at Dadar at 11.54pm, and then going to a bar outside the station where he spent 30 minutes drinking alcohol before going to different places instead of reporting for duty.

A senior GRP officer told TOI on Saturday: "The CCTV grabs availed and his family's statements mentioned that Pawar left his Kopri home at around 7.30 pm while he boarded the fast train at 11.20 pm from Thane on Apr 27 which has a direct halt at Dadar. The CCTV footage at Dadar station captured him exiting the station at approximately 11.54 pm. He spent at least 30 minutes drinking at a bar in Dadar before visiting different locations and walking along the tracks to Parel, where he slept. He then boarded the train on Apr 28 in the morning back to Thane. The investigation by GRP also found from the post-mortem report that the deceased policeman was not injected with any poisonous substance as he had claimed, suggesting that his account was false. The investigation team will conclude the case within a day or two, giving details on the circumstances of the constable's death.

Chennai: Amidst soaring summer temperatures, the state school education department is clamping down on govt and Summer holidays for govt, govt-aided, and private schools conducting special classes during the summer holidays. This action follows a surge in complaints from parents regarding their children's well-being in the intense heat.School education secretary J Kumaragurubaran confirmed receiving reports of schools conducting classes. These initial complaints surfaced in Virudhunagar district, prompting the department to instruct all chief and district

education officers statewide to investigate schools within their jurisdictions, he said.

private schools commenced on April 13. However, some schools across the state scheduled preparatory classes for the upcoming year and career counselling sessions. "We instructed chief education officers and district education officers across the state to verify these reports and ensure schools are adhering to summer break guidelines," said Kumaragurubaran.While recognising the

value of these classes, he said, "Given the rising temperatures, it's not the right time to conduct them in person." He further added that schools found violating the guidelines would be issued warnings.Govt school teachers said they conducted summer camps and NEET coaching sessions as soon as schools closed for the holidays. But those concluded on Saturday. "It is extremely hot. Students are not interested in stepping out. Parents, too, want the children to be at home," said Janaki M, a govt high school teacher from Navalur. While some parents found these classes beneficial, many students were unhappy, particularly due to the heat. "My son's school conducted classes three times a week," said Ambika Venugopal, a parent from Semmenchery. "While I didn't mind, the heat was too much for him," she added. The school education department plans to transition to online resources for career counselling and other specialised classes, Kumaragurubaran said. "This would allow students to access this information from home and still enjoy their holidays," he said. Although government

schools are still in the early stages of digitalisation, Kumaragurubaran said he is optimistic about implementing this transition within the next three to four months with proper teacher training.NCERT books for classes 1 & 2 in UP govt schoolsUP Basic Education Council implements NCERT textbooks for classes 1 and 2. Pickup and drop for 85-plus and disabled voters in city

- Gurgaon. People aged 85 and above and those with at least 40% disability will be picked up from home and dropped back on the voting day on May 25 if they don't opt for postal ballot, a facility that allows them to exercise their franchise from home.
- A recent survey has revealed that the Gurgaon parliamentary seat has 50,790 such voters. Electoral teams are now reaching out to them with Form D, which is required to be filled if the voters opt for postal ballot facility. If they don't, their names will be included on the list of voters who would be offered pickup and drop facility."We will first ask them if they want to cast their votes from homes through postal ballots. An entire booth will be set up in a room in that case. But those who want to visit the local booths will be picked up and driven back. They need not stand in queue," said deputy commissioner Nishant Yadav.
- Elderly voters heading out will be accompanied by a govt official and a volunteer. The volunteers will be responsible for ensuring such voters on the list are picked up in time and dropped back safely too.
- "For the pickup and drop facility, voters can call on our toll-free number 1950 and book their rides according to their convenience," said Yadav.Vidhya Devi of Pataudi, who is in her late eighties, is among those planning to head to a booth on May 25. "I haven't filled Form D. I want to vote to pay my tributes to those who have laid down their lives to free this country from the British," she told TOI, adding that never missed an opportunity to exercise her franchise. The move to bring polling booths to homes and offer pickup services is aimed at ensuring a better turnout for the Gurgaon seat, where voter participation has been a cause for concern.In 2019, the voting percentage in Gurgaon was 65%, compared to the state average of 72% and the national figure of 75%. Officials said the district administration was leaving no stone unturned to improve numbers this time.

A simple reading of the Congress list of candidates shows who is calling the shots. Despite strong opposition by what is described as the 'SRK' grouping — of Kumari Selja, Randeep Surjewala and Kiran Choudhry — eight of the party's nine candidates are loyalists of former chief minister Bhupinder Singh Hooda or those who he specifically wanted in the electoral fray, like Raj Babbar. Congress hasn't fielded a candidate in Kurukshetra, which is being contested by its INDIA bloc partner AAP. In Gurgaon, Raj Babbar was fielded over

the grouping's choice, which was former minister Capt Ajay Yadav. Similarly, Tosham MLA Kiran Choudhry's daughter, and granddaughter of former CM Bansi Lal, Shruti Choudhry, was replaced with Rao Dan Singh from the Bhiwani-Mahendergarh seat. The constituency is considered a stronghold

minister Chaudhary Birender Singh, was widely expected to get the ticket from Hisar, but he was bypassed for Jai Prakash, who is also close to Hooda. Brijendra, who was the sitting MP in Hisar, had left BJP earlier this year and joined Congress.In Faridabad, too, Karan Singh Dalal was considered a strong contender, but Congress fielded former state minister Mahendra Pratap.Asked about talk of resentment in a section of the party's state unit, a senior Congress functionary told TOI that among considerations in choosing Haryana candidates was also the assembly elections. Harvana will go to polls to elect its next govt later this year, and Congress wants to capitalise on anti-incumbency and anger against BJP after the farmers agitation. "To do so, the central leadership has to rely on the state leadership, and that is Hooda," the senior functionary said. Another party insider said the focus is also on getting Jat votes, and Hooda is a prominent Jat leader in



Congress. "This is the main reason for importance that has been given to Hooda by the party high command. The former CM's proximity to Congress president Mallikarjun Kharge is clear from the fact that he and state party president Udai Bhan were in constant touch with senior members of AICC (All India Congress Committee), even as the SRK grouping held meetings with Sonia Gandhi," the party insider said.Asked about Hooda's influence in ticket distribution, AICC Haryana in-charge Deepak Babaria said

on Friday that tickets were "strictly given on the basis of merit, which is winnability, social composition and 36 biradari (caste equations)". Babaria added, "As far as Hooda is concerned, he is a strong party functionary who has good hold in the region."The only Congress candidate where Hooda didn't have is way is Selja. The former Union minister and party general secretary will contest from Sirsa, a reserved seat, against former

Haryana Congress president Ashok Tanwar, who has joined BJP.

On May 1, when Selja filed her nomination from Sirsa, no one from the Hooda camp was present. She was accompanied by Birender Singh, Kiran Chaudhry and Randeep Surjewala, among others. Asked about differences within the party, Selja had said that all leaders try to make an impact, but everyone eventually comes together to ensure the party's victory in the elections.

1st FOB on Golf Course Roaad may open in June

Gurgaon. A foot overbridge (FOB) on Golf Course Road, connecting Chakkarpur village with Ashoka Crescent Marg, has again missed its March 2024 deadline and is likely to be commissioned by June.

At present, the structure of the FOB has been installed and work on the elevator and other minor works are being carried out. The FOB is among four bridges planned to ease pedestrians' movement on the 6km-long stretch, among the busiest roads in the city. Around 85% work has been completed

and the structure of FOB has been installed at the site. The work on elevator and last touches are under progress. Shortage of manpower has slowed down the pace of work since March as many labourers have gone to their hometowns for festivals, harvesting or to cast their vote in the Lok Sabha elections. These included delays in obtaining permission for tree cutting, remove utilities that fall within the alignment, changes in the design of the structure and construction ban under GRAP. This had pushed the executing company to revise the deadline to March 2024. While the FOB at Chakkarpur village is likely to be completed soon, work on the other three FOBs are still on papers."We have sent multiple reminders to DLF to submit designs for other three FOBs on Golf Course Road for approvals. But till date there has been no concrete submission made from their end. We have already raised the matter with the higher authority.

Sydney, Australian police said on Sunday they shot dead a boy after he stabbed a man in Western Australia's capital Perth, in an attack authorities said indicated terrorism. There were signs the 16-year-old, armed with a kitchen knife, had been radicalised online, state authorities said, adding they received calls from concerned members of the local Muslim community before the attack, which occurred late on Saturday night. The attack, in the suburb of Willetton, had "hallmarks" of terrorism but was yet to be declared a terrorist act, police said.At this stage it appears that he acted solely and alone," Western Australia Premier Roger Cook said in a televised news conference in Perth, regarding the attacker.

- The victim, stabbed in the back, was stable in hospital, authorities said. The incident comes after New South Wales police last month charged several boys with terrorism-related offences in investigations following the stabbing of an Assyrian Christian bishop while he was giving a live-streamed sermon in Sydney, on April 15.The attack on the bishop came only days after a deadly mass stabbing in the Sydney beachside suburb of Bondi that claimed the lives of six people.

Northern Gaza is now in 'full-blown famine': UN World Food Program chief

The panel that serves as the internationally recognised monitor for food crises said in March that northern Gaza was on the brink of famine and likely to experience it in May.

WASHINGTON. A top UN official said Friday that hard-hit northern Gaza was now in "full-blown famine" after more than six months of war between Israel and Hamas and severe Israeli restrictions on food deliveries to the Palestinian territory. Cindy McCain, the American director of the UN World Food Program, became the most prominent international official so far to declare that trapped civilians in the most cut-off part of Gaza had gone over the brink into famine.

"It's horror," McCain told NBC's "Meet the

Press" in an interview to air Sunday "There is famine—full-blown famine—in the north, and it's moving its way south."She said a cease-fire and a greatly increased flow of aid through land and sea routes was essential to confronting the growing humanitarian catastrophe in Gaza, home to 2.3 million people. There was no immediate comment from Israel, which controls entrance into Gaza and says it is beginning to allow in more food and other humanitarian aid through land crossings. The panel that serves as the internationally recognised monitor for food crises said in March that northern Gaza was on the brink of famine and likely to experience it in May.Since March, northern Gaza had not received anything like the aid needed to stave off famine, a US Agency for International Development humanitarian official for Gaza told The Associated Press. The panel's next update will not come before this summer. The USAID official said on-the-ground preparations



for a new US-led sea route were on track to bring in more food-including treatment for hundreds of thousands of starving children-by early or mid-May. That's when the American military expects to finish building a floating pier to receive the shipments.Ramping up the delivery of aid on the planned US-backed sea route will be gradual as aid groups test the distribution and security arrangements for relief workers, the USAID official said. The official spoke on condition of anonymity, citing security concerns accompanying the official's work on conflicts. They were some of the agency's first comments on the status of preparations for the Biden administration's \$320 million Gaza pier project, for which USAID is helping coordinate on-the-ground security and distribution.At a factory in rural Georgia on Friday, USAID Administrator Samantha Power pointed to the food crises in Gaza and other parts of the world as she announced a \$200 million investment aimed at increasing production of emergency nutritional paste for starving children under 5.

Power spoke to factory workers, peanut farmers and local dignitaries sitting among pallets of the paste at the Mana nonprofit in Fitzgerald. It is one of two factories in the US that produces the nutritional food, which is used in clinical settings and made from ground peanuts, powdered milk, sugar and oil, ready to eat in plastic pouches resembling large ketchup packets."This effort, this vision meets the moment," Power said. "And it could not be more timely, more necessary or more important.

Afghan diplomat, caught smuggling gold, resigns due to 'personal attacks'

World A senior Afghan diplomat in India has resigned from her position after reports of her involvement in gold smuggling from Dubai surfaced. Zakia Wardak was reportedly caught at the Mumbai airport last month for allegedly trying to smuggle 25 kg of gold worth Rs 18.6 crore from the capital of the UAE.She had been the acting Ambassador of Afghanistan to New Delhi since late last year after working as the Afghan Consul General in Mumbai for more than two years. Taking to X, Wardak mentioned "numerous personal attacks and defamation" directed towards her as well as her family that impacted her ability to operate in the position of an Afghan diplomat. However, she didn't mention the reports of the Directorate of Revenue Intelligence (DRI) seizing gold from her on April 25. Wardak was

not arrested for her diplomatic immunity, news agency PTI reported. These attacks, which appear to be organised, have severely impacted my ability to effectively operate in my role and have demonstrated the challenges



faced by wome in Afghan society who strive to modernise and bring positive change amidst ongoing propaganda campaigns," her statement, released in both Pashto and English, read.

Wardak said the "persistent and coordinated" attacks exceeded a "tolerable threshold". She further stated that while she was prepared to tackle the attacks on her character that were "not altogether surprising", she was not "unprepared for the toll it took on those close to me".Zakia Wardak said while it's her passion to serve her country and bring about a positive change, in the wake of the attacks, she has to prioritise her "well-being and

Nearly 60 killed, over 69,000 displaced as heavy rains batter southern Brazil

Sao Paulo, Brazil.a Heavy rains in Brazil's southernmost state of Rio Grande do Sul this week killed at least 55 people, local authorities said on Saturday evening, while dozens remain unaccounted for.

=Rio Grande do Sul's civil defence authority said 74 people were still missing and more than 69,000 had been displaced as storms in the last few days have affected nearly two thirds of the 497 cities in the state, which borders Uruguay and Argentina.1The local authority said it is now investigating whether another seven deaths were related to the storms, after earlier in the day it had reported a total of more than 55 deaths. Floods destroyed roads and bridges in several regions of the state. The storm also triggered landslides and the partial collapse of a dam at a small hydroelectric power plant. A second dam in the city of Bento Goncalves is also at risk of collapsing, authorities said.

In Porto Alegre, the capital of Rio Grande do Sul, the Guaiba lake broke its banks, flooding streets

Porto Alegre's international airport has suspended all flights for an indefinite period.

State Governor Eduardo Leite told reporters on Saturday evening that Rio Grande do Sul would need a "Marshall Plan" to recover from the storms and its consequences, referring to a plan for Europe's economic recovery after World War Two.Brazil's President Luiz Inacio Lula da Silva, who had visited Rio Grande do Sul on Thursday, will travel back to the state on Sunday to follow the rescue efforts, his chief of communication Paulo Pimenta said on Saturday.Lula said on X that his government is in constant contact with state and cities' authorities to support the region with whatever they need. Rains are expected in the northern and northeastern regions of the state until Sunday, but the volume of precipitation has been declining, and should be well below the peak seen earlier in the week, according to the state meteorology authority. Still, "river water levels should stay high for some days", Leite said earlier on Saturday. Rio Grande do Sul is at a geographical meeting

Pakistan: Milk price soars to PKR 210 per litre in Karachi

- KARACHI. The price of milk at Karachi in fiscallystressed Pakistan shot up to 10 per litre after the city's commissioner approved a hike, acceding to the demands of the Dairy Farmers Association, ARY News reported.
- As per the commissioner's directives, the price of milk has surged by PKR 10 per litre, with shops in Karachi now selling milk at PKR 210 per litre.
- Earlier speculations of a potential PKR 50 per litre increase in milk prices have loomed over the inflationburdened citizens of Karachi, ARY News reported.
- Mubasher Qadeer Abbasi, the president of Dairy Farmers Karachi, has indicated that an increase of PKR 50 per litre of milk is expected soon for the people of Karachi. Abbasi cited the high cost of milk production, soaring cattle prices, and government negligence as factors contributing to this imminent rise. Abbasi stressed the urgency for the Karachi Commissioner to promptly issue a notification regarding the new prices aligned with the milk production costs.He further emphasised that if the authorities do not announce the increase in milk prices by May 10, stakeholders will take matters into their own hands and raise prices after consensus.

LONDON. London's Labour mayor Sadiq Khan on Saturday secured a record third term, dealing the Conservatives another damaging defeat in their worst local election results in recent memory months before an expected general election.

Khan, 53, easily beat Tory challenger Susan Hall to scupper largely forlorn Tory hopes that they could prise the UK capital away from Labour for the first time since 2016. The first Muslim mayor of a Western capital when first elected then, he had been widely expected to win as Labour surged nationally and the Conservatives suffer in the polls.In the end, he saw his margin of victory increase compared to the last contest in 2021.

"It's truly an honour to be re-elected for a

third term as Tories routed in local polls third term," Khan told supporters, accusing his Tory opponent of "fearmongering"."We ran a campaign that was in keeping with the spirit and values of this great city, a city that regards our diversity not as a weakness, but as an almighty strength-and one that rejects right hard-wing populism," he added.It adds to a dismal set of results for Prime Minister Rishi Sunak, as his Tories finished a humiliating third in local council tallies after losing nearly 500 seats in voting Thursday across England.With Labour making huge gains, the beleaguered leader's Conservatives lost crunch mayoral races in Manchester, Liverpool, and Yorkshire, as well as the capital and elsewhere.In the West Midlands, Tory incumbent Andy Street, bidding for his

own third term, reportedly requested a recount in one district, with the contest too close to call.An unexpected Tory defeat there could leave Sunak with only one notable success: the party's mayor winning a third term in Tees Valley, northeast England, albeit with a vastly reduced majority.

Voters are frustrated'

Writing in Saturday's Daily Telegraph, Sunak conceded "voters are frustrated" but insisted "Labour is not winning in places they admit they need for a majority.""We Conservatives have everything to fight for," Sunak argued. Labour, out of power since 2010 and trounced by Boris Johnson's Conservatives at the last general election in 2019, also emphatically snatched a parliamentary.

Anti-Israel protest at US university declared 'unlawful assembly', 25 arrested

World At least 25 people were arrested during a clash between pro-Palestine protesters and the police at the University of Virginia in the US after the demonstrators refused to remove their tents from the campus. The university located in Charlottesville said the police had to "declare an unlawful assembly" at the protest site due to "violent conduct and failure to follow police directions". This latest development comes as more than 2,000 people have been arrested in the US since mid-April for staging protests at college and university campus across the nation against the Israel-Hamas war in Gaza. Dozens of Virginia State Police officers in

riot gear surrounded the student encampment area on Saturday and used a chemical spray to disperse the protesters from the area.In a tweet on Sunday morning, the university said, "A pro-Palestinian protest ended on Grounds Saturday after University, local and state police cleared the area. This followed repeated policy violations. Violent conduct and failure to follow police directions led officers to declare an

unlawful assembly."The university also said that it was awaiting confirmation on how many of the 25 arrested individuals were affiliated with the school. On May 7, the students launched their protest on a lawn outside the university chapel. On Saturday, however, they refused to remove their encampments despite repeated requests by the university authorities.

Soon thereafter, state police troopers wearing heavy riot gear and holding shields lined up on the campus, while the defiant protesters chanted slogans like "shame on you" and "free Palestine".A video on social media shows police officers moving in on the encampment on the campus' lawn, cuffing some demonstrators with zip-ties and using what appeared to be pepper spray.

Speaking to The Washington Post, Laura Goldblatt, an assistant professor of English and global studies, said the protesting students were pushed to the ground as soon as the police moved in. She said the students were "sprayed with a chemical irritant" and forcibly pulled by their arms.Our concern since this



began has been the safety of our students. Students are not safe right now," Goldblatt said.In a statement, the University of Virginia said the Virginia State Police were asked to help with enforcement as the tents and canopies erected by the protesters were "prohibited under school policy" and were asked to remove them. University of Virginia president James E. Ryan said the protesters "complied with requests to adhere to university policies, including a long-standing prohibition on erecting tents absent a permit" until Friday evening.But on Saturday morning, when the University Police Department "offered a final warning to the protesters, reminding them once again of their

University policy violations and pleading for a peaceful resolution. That request was ignored", he said in a letter to the student community.When the department's "attempts to resolve the situation were met with physical confrontation and attempted assault, it became necessary to rely on assistance from the Virginia State Police", Ryan noted."The police declared an unlawful assembly, issued no trespass orders to those who refused to disperse, and arrested those who

continued to refuse dispersal," he added.Besides the arrests at the University of Virginia, dozens of people were taken into custody for criminal trespass outside the Art Institute of Chicago at a demonstration, reports Reuters news agency. The arrests occurred after the institute called in police to remove protesters it said were illegally occupying its property, according to the Chicago Police Department.Meanwhile, at Ann Arbor, pro-Palestinian protesters briefly disrupted a commencement ceremony at the University of Michigan.

Clear 'no dues' cert to poll nominees, EC tells chief secvs

Kolkata: After the disqualification of candidature of ex-IPS officer Debashis Dhar, who had filed nomination from Birbhum as a BJP candidate but failed to provide the "no dues" certificate, the Election Commission has asked all chief secretaries to issue the "no dues" certificate to intending candidates on an emergency basis. The chief secretaries have been told to clear the "no dues" certificate within 48 hours of he receipt of such a plea.Dhar had moved the Supreme Court after his nomination was cancelled. The EC missive on May 3 said: "An intending candidate could not obtain the 'no dues' certificate from the authority concerned and thus could not contest. 20 Shiv Sainiks acquitted in 2005 Narayan Rane protest case

MUMBAI: Nineteen years after 20 Shiv Sainiks were accused of being part of an unlawful assembly that protested against now BJP leader and union minister Narayan Rane, following his dismissal from the party, by blocking a road at Dadar and damaging public property by pelting stones, a special court this week acquitted them after cops part of the investigations could not identify the accused due to lapse of time.

Among the accused is former city mayor Vishaka Raut (61). Two accused died during the pendency of the trial. The court also pointed out that the prosecution had failed to bring to court material evidence such as broken pieces of glass of the vehicles, chappals, stones and bricks, all seized from the scene of the incident. "It is contextually relevant to note that none of the accused was arrested from the spot of the incident. This fact cannot be lost sight of. Moreover, the prosecution failed to examine any independent witness including the driver of the tanker (whose windshield was shattered during the stone pelting) in support of the prosecution," the judge said. It was the prosecution's case that on July 24, 2005, at about 2.55pm, police received information that the road was blocked at Jakhadevi Square, Dadar. Therefore, on



the orders of superiors, a police sub inspector went there along with the police team for bandobast duty. It was further alleged that at that time, a crowd of around 150 to 200 Shiv Sainiks were sitting on the road at Jakhadevi Square. It was alleged that the Sena office-bearers and activists including the accused were shouting slogans. It was alleged that the entire road was blocked with stones. It was further submitted that around that time the Shiv Sainiks stopped a tanker and damaged it. It was further alleged that the Shiv Sainiks also hurled stones at

Kolkata: Children and their parents braved the worst April heatwave in four decades to visit the two science centres in Kolkata in large numbers last month. AICTE issues approval letters to 694 colleges in Karnataka

Bengaluru: As many as 694 colleges in the state got inprinciple letter of approval from All-India Council of Technical Education to run BBA/BCA/BMS courses. However, colleges said even while they have been informed through email, they are yet to receive the letter.As per data from regulatory body AICTE, 3,127 colleges in the country have been granted letter of principle and another 5,009 colleges extension of approval. It may be recalled that from this year, all

colleges who want to offer these undergraduate courses (Bachelor in Business Administration, Bachelor in Computer Applications and Bachelor in Managament Studies) will have to apply to AICTE. Thus far, only postgraduate courses like MBA and MCA were under AICTE

ambit, apart from technical courses. According to latest data, 694 colleges in Karnataka, 467 in Maharashtra and 309 colleges in Kerala got letter of approval, followed by Madhya Pradesh (183), Punjab (159) and Telengana (158). A college principal said, "We received an e-mail which said the council has decided to recommend letter of approval to the institution on as-is-where-is-basis, based on self disclosure data received on the portal. In case of any discrepancy, the letter of approval will be withdrawn.

It also said that the letter will be made available to download in due course of time. However, most of us are yet to receive it.""Without the letter, universities are unable to send local inspection committees for continuation of affiliation. Admissions

should ideally happen only after that. However, with PU results out already, it is impossible for colleges to not start admissions. Politics of new and old dynasts

DYNASTIC politics is hogging the headlines and dominating the exchange of abuses at election rallies. What is on display are families investing their political capital earned over generations to grab and accumulate more power. In a social milieu where public office instantly gets translated into brute power and ill-gotten wealth, politics is enterprise and politicians its biggest entrepreneurs - from district-level wannabes to state satraps to the mighty monarchs holding sway over vast swathes of the nation.Otherwise, Karan Bhushan Singh, Prajwal Revanna and Rahul Gandhi's Raebareli candidature would not have seized disproportionate news space and TV time. The three are representative examples of dynasty in Indian politics not just at the three levels — local, regional and national — but also because they belong to three different kinds of political formations. One is from a purely familybased national political enterprise, the second belongs to a caste-based family outfit limited to a state and the third is from a cadre-based ideological organisation that professedly propagates cultural nationalism and worships the idea of Bharat Mata.And they all practise the same politics of patriarchal inheritance of power. Not only these three, but across the country from Kashmir to Kanyakumari, Indian politics is dominated by inheritors - while Omar Abdullah is a successful third-generation former J&K Chief Minister, MK Stalin is a sitting second-generation Tamil Nadu CM. In almost all states, dynasties have struck roots, whatever be the nature of the ideology that has nurtured the organisation — linguistic nationalism for the DMK or the antifeudal, pro-nationalist stance of the National Conference or the Maharashtrian-first strong-arm tactics of Shiv Sena or Yadav empowerment for the Rashtriya Janata Dal/Samajwadi Party or Dalit emancipation of the Bahujan Samaj Party.

- This widespread phenomenon is best explained by the candidature of Karan Bhushan, son of BJP MP Brij Bhushan Sharan Singh. The latter is one of the most controversial contemporary political figures, who was accused and later acquitted in the sensational JJ Hospital shootout case of the 1990s, involving the Dawood Ibrahim gang. He has brought a bad name not only to the BJP, but also to the administration of Indian sports, drawing accusations of molestation from women wrestlers. Yet, he has been able to control his pocket borough by getting his son nominated from Kaiserganj on the BJP ticket. Why?
- Even a cadre-based organisation cannot afford to discount the political capital that a local strongman builds over the years. In a tight contest where every seat counts, electability trumps organisational principles. Reportedly, Brij Bhushan controls 54 educational institutions across four districts of Uttar Pradesh. So, it is not even a question of one constituency, but influence over three-four seats and a dominant caste. These are individuals who, with their feudal intervention in the social and economic life, build a local connect and turn it into political capital, which later becomes an instrument of inheritance.

Prajwal is the grandson of former Prime Minister HD Deve Gowda and the inheritor of the family's pocket borough, Hassan. When the BJP struck an alliance with the Janata Dal (Secular) for the 2024 Lok Sabha polls, it had to shoulder the burden of this controversial MP. In fact, Gowda Sr had vacated this safe seat for the sake of his grandson and contested and lost Tumakuru in 2019. The need for stitching an alliance had blinded the BJP to the glaring allegations of sexual assault against Prajwal, levelled by Karnataka BJP leader Devaraje Gowda in a letter in December 2023 to state BJP president BY endra, whos himself is a dynast — former CM BS Yediyurappa's son. Even the ruling Congress in Karnataka, it seems, dithered while filing a case against Prajwal waiting for polling in constituencies dominated by Vokkaliga (Deve Gowda's community) to get over on April 26. This is the strength of identity politics that becomes the stable foundation for these enterprising clans to build their political careers, which in the course of time accrue enough political principal to start yielding interest for the newer, idler generations.

Blinken's China visit brings to the fore bilateral tensions

There was little evidence of Beijing trying to create a favourable atmosphere for the talks, despite senior Chinese officials calling for constructive China-US relations.



THE US Secretary of State, Antony Blinken, met Chinese President Xi Jinping, Foreign Minister Wang Yi and, quite unusually, China's Minister of Public Security Wang Xiaohong during his three-day visit to Beijing and Shanghai from April 24 to 26. However, it was an unsuccessful attempt to arrest the slide in bilateral relations, even as he reiterated the US 'red lines'. This was Blinken's second trip to China in 10 months; he is the senior-most official of the Joe Biden administration to visit the country.Not without an obvious design, Blinken's visit took place in the backdrop of reports that Washington was identifying Chinese banks - from a list of 100 — that should be sanctioned for aiding Russia in its war with Ukraine. More disconcerting for China would be the reports that US authorities had also begun compiling lists of Chinese Communist Party cadres and their assets in the US and the West that could be covered by sanctions. The visit also coincided with the US authorising a \$95-billion war aid package to Ukraine, Israel and Taiwan.During the meetings in Beijing, China clearly conveyed that it was not prepared to yield ground and make concessions. It used the visit to set out its 'red lines', restate its ambitions and signal that it had serious reservations about the US claims that it wants to stabilise relations and doesn't want to challenge China's core interests or prevent its growth. The Dragon has been particularly apprehensive of America's efforts to


'friendshore' manufacturing to 'trusted' partners.

Blinken's visit came amid repeated attempts by US President Biden to reduce tensions. Chinese and US military and diplomatic officials have held numerous meetings in addition to at least 20 ongoing talks between the two countries. At the senior level, US Treasury Secretary Janet Yellen visited (April 4-9) Guangzhou and Beijing for talks with China's senior-most finance officials to address concerns that Washington was trying to prevent Beijing's growth. US Defence Secretary Lloyd Austin and China's new Defence Minister, Dong Jun, had their first video talks last month, in which the latter "underscored that the Taiwan question is at the core of China's core interests, which brook no compromise". Early last month, Chinese Vice-Minister of Commerce Wang Shouwen travelled to Washington for the first meeting of a working group on bilateral trade, where he highlighted China's concerns over the imposition of Section 301 tariffs by the US and associated inquiries against Beijing and demanded that both must manage their disputes and increase collaboration.

On the day prior to Blinken's arrival in Shanghai, Yang Tao, the head of China's department for US and Oceania, appeared to set the stage in a lengthy, strongly worded briefing to journalists. He appeared to focus on negative factors in Sino-US relations and accused America of continuing to 'contain China', interfering in its internal

affairs and harming its interests. There was particular focus on Taiwan, which he described as "the first insurmountable red line in Sino-US relations" and "the biggest threat to peace and stability across the Taiwan Strait". He also warned that "the Asia-Pacific region is not anyone's back garden and should not become a battleground for major powers". His briefing provoked questions in the US about the need for Blinken to visit Beijing.Blinken and Chinese Foreign Minister Wang Yi had nearly five-and-a-half hours of talks, during which the latter spoke entirely from a prepared text. His remarks largely echoed Yang Tao's comments. Wang Yi also said that "negative factors in Sino-US relations are still rising and accumulating". He said that "China's legitimate right to development is being unreasonably suppressed" and its core interests are being challenged. He further emphasised that the US should not interfere in China's internal affairs, suppress its development or step on its 'red lines' regarding its sovereignty, security and development interests.

- In his remarks to journalists, Blinken noted that the first US-China talks on artificial intelligence would be held within weeks. He also observed that since there are fewer than 900 Americans studying in China compared to more than 2,90,000 Chinese students in the US, their number should be increased.
- He stressed that the US was "very clear-eyed about the challenges posed by the PRC (People's Republic of China) and about their competing visions for the future" and asserted that America "will always defend our core interests and values". He said he had conveyed serious concerns about China providing components that are "powering Russia's brutal war of aggression against Ukraine". He told Beijing that it cannot achieve better relations with Europe while supporting the greatest threat to European security since the end of the Cold War and "made clear that if China does not address this problem, we will". He also expressed concern about Beijing's unfair trade practices and the potential consequences of industrial overcapacity. Blinken discussed China's 'dangerous actions' in the South China Sea and reaffirmed that US "defence commitments to the Philippines remain ironclad". He emphasised the maintenance of peace and stability across the Taiwan Strait and raised the issues of Hong Kong, Xinjiang, Tibet and the wrongful detention of American citizens.
- Both sides used Blinken's visit to bluntly spell out their respective concerns. Taiwan figured extensively in the talks, with the Chinese robustly declaring it their inviolable 'red line'. Notably, 22 Chinese fighter aircraft flew over the Taiwan Strait soon after Blinken's departure. Middle class facing a massive squeeze

The living standards of the middle class have worsened or remained stagnant for more than a decade.

I grew up in a middle-class South Delhi colony in the 1970s and 1980s. We lived in a single-storey rented house with a small garden, shaded by a mango tree. There was space for a car to be parked, but we had none. Inside, the décor was limited to a few framed prints and tons of books. In the living room, there was an old sofa, a divan that doubled up as a bed for guests, and a second-hand dining table, bought from a family friend who needed money to fund his trip to England. The only car in our larger family belonged to my mother's elder brother, a well-respected doctor who had made money working in the West. For entertainment, we had a record player and a big transistor radio, on which we heard the news. There was a cinema hall close by, where we went to watch old Hollywood movies a couple of times a month. Clothes were bought twice a year, during festivals. Birthday gifts were almost always books. children, my sister and I used to play with kids who lived next door. They were relatively rich, and had air conditioners in their rooms. Their living room was modelled on what Hindi cinema homes looked like. Red sofas, plush carpets and garish paint on the walls. Yet, we never envied them nor felt any need to emulate their lives. That was how the middle class lived. That was what we aspired to. We knew that the rich lived a more comfortable life, but we were also very aware that they lacked social capital. More importantly, consumer goods were few and far between. So, the rich had very little to flaunt or parade their wealth. If anyone did, they were immediately labelled as 'smugglers'!In fact, throughout the 1970s, the gap between the rich and the middle class narrowed dramatically. For instance, in 1972, the year I was born, the richest 10 per cent of Indians earned 35 per cent of our national income, while the next 30 per cent — the middle class -

earned another 36 per cent. By 1982, the share of the top 10 per cent had dropped to 31 per cent, while that of the 'middle class' had risen to 39 per cent. In terms of average income, the richest 10 per cent actually saw their pre-tax earnings drop by 0.4 per cent per year in this 10-year period, while that of the middle class increased at an annual rate of 1.7 per cent.

The year 1982 was a turning point. That was the year when Suzuki beat rival Daihatsu to get to tie up with Maruti Udyog Limited to launch India's first 'people's car'. It was also the year when New Delhi got spruced up for Asiad-82 and Doordarshan began broadcasting in colour. During that year, more than one lakh colour $T\bar{V}$ sets were imported at a 190 per cent import duty. New fashion brands took advantage of the rise of middle-class consumerism to expand across the metros. The most prominent amongst them was Intercraft, whose brand F.U's (Fit You Superbly)

became a huge success, before global brands like Benetton and Levi's entered India.

These were not arbitrary changes. Indira Gandhi's second coming involved a major policy shift towards market-based reforms and encouraging the private sector. They came right after India took an IMF loan, and were bundled together in a policy project called Operation Forward. Rajiv Gandhi opened things up even more, removing state monopolies in many sectors, diluting regulation of big business and liberalising exports and imports.

The economic reforms in the 1980s helped the middle class improve their living standards. Between 1982 and 1991 — the year of the Rao-Manmohan reforms



- middle-class incomes increased at an annual rate of 2.2 per cent. But it was the richest 10 per cent who were the biggest gainers - their income rose at 4 per cent per year. This was a complete reversal of what happened in the 1970s. In terms of share of national income too, the rich gained, moving from 31 per cent in 1982 to 35 per cent in 1991. On the other side, the middle class' share dropped to 37 per cent from 39 per cent.Since then, this gap has only widened. By 2014, the share of the richest 10 per cent increased to 57 per cent, while that of the next 30 per cent of earners dropped to less than 25 per cent. In terms of annual growth in earnings, that of the top 10 per cent has grown at 5.4 per cent per year since 1991, while that of the middle class has grown at a staid 2.4 per cent.

Anecdotal evidence tells us that the middle class is now facing a massive squeeze. Three indicators show this. The first is the sale of fast-moving consumer goods (FMCGs). The profits of companies which cater to middle-class consumers -Hindustan Unilever Limited and Tata Consumer - have contracted, while Nestle India, which sells to the more affluent, has risen sharply. The second key indicator is car sales; in 2023-24, cheaper compact cars sold 30 per cent less than in 2018-19. On the other side, more expensive multi-utility vehicle sales rose by 167 per cent. The third indicator of this sharp divergence between the consumption of the middle class and the affluent is home sales. Affordable homes have seen a drop in sales in the first three months of 2024, while the sale of premium homes has shot up.

White-collar jobs, which form the foundation of the middle class, have steadily declined over the past few years. The number of 'white-collar' vacancies in January this year was 24 per cent less than those of last year, and 35 per cent less compared to January 2022. At the same time, retail inflation has eaten into real incomes.

The living standards of the middle class have either worsened or remained stagnant for more than a decade. Educated middle-class youth entering the job market are reconciling to earning less than their parents did. It is a class that is neither benefiting from the K-shaped recovery nor from the government's welfare schemes.

Terror Attack On IAF Convoy In Jammu And Kashmir: One Soldier Killed, 4 Injured In Poonch Ambush

Poonch: One soldier was killed, and four Indian Air Force soldiers were injured in a terror attack in the Poonch district of the Jammu region. A convoy of the Indian Air Force was attacked by terrorists in the Surankote area of Poonch district on Saturday evening. All five injured soldiers were evacuated to the Army's base hospital, where one soldier succumbed to his injuries.Security forces, including the Indian army and the Jammu and Kashmir Police, rushed to the spot where terrorists opened heavy fire on the IAF convoy. A massive cordon and search operation was launched by the forces to apprehend the attackers in the area. Initial reports suggest that two terrorists were involved in the attack.

This is the first major attack in the region this year, as Poonch and Rajouri saw multiple attacks last year. Security forces have been on high alert since then and have prevented any major attacks. The entire Poonch district has now been put on high alert. The attack took place in the Shah Sattar forest area, which is densely covered with trees and falls between Surankote's Sanai Top and Mendhar's Gursai area of the border Poonch district. This is the first major attack on the armed forces this year in the region, which witnessed a series of terror attacks on the army last year. Visuals from the attack site showed at least a dozen bullet holes on the windscreen of the vehicle that came under fire.Sources said the injured air warriors were airlifted to Command Hospital Udhampur from Poonch within half an hour of the attack, while the other vehicles of the convoy had been secured and safely reached their destination.

In a statement, the Indian Air Force said, "In the ensuing gunfight with terrorists, the Air Warriors fought back by returning fire. In the process, five IAF personnel received bullet injuries and were evacuated to the nearest military hospital for immediate medical attention. One Air Warrior succumbed to his injuries later. Further operations are underway by the local security forces."Sources said a combing and search operation had been ongoing in the area between Mendhar and adjoining Surankote for the past few days following reports of movement of terrorists. During the searches, terrorists opened fire on a vehicle carrying Air Force personnel. The latter retaliated, and in the ensuing firefight, five personnel were injured. Reinforcements of police and security forces were rushed to the area as soon as reports of the attack came in.A cordon and search operation has been initiated by the

local Rashtriya Rifles unit to apprehend the perpetrators. The area has been cordoned off, and searches are in progress, sources said. This is the second militant attack in the Pir Panjal region, spread over Rajouri and

The Problem With Wrongly Labelling Real Or Edited Videos As 'Deepfakes'

New Delhi: An edited video of Home Minister Amit Shah went viral recently, falsely showing him promising an end to reservations for Scheduled Tribes, Scheduled Castes, and Other Backward Classes. While BOOM's fact-check found that the video was doctored using video editing tools, it was falsely labelled as a 'deepfake' by other Bharatiya Janata Party leaders, and various mainstream media outlets. Political parties in India are experimenting with AI in myriad ways this election season. For instance, AI voice clones of politicians are being used to craft cadre and voter outreach messages. Political parties are also skirting any social media rules by using satirical videos which use voice cloning, face swap and other AI editing techniques, to target their political rivals. These videos are posted on their official Instagram and YouTube handles.However, the damaging deepfakes that are outright deceptive, are being shared either by IT cell workers, or through proxies and diffused actors, who support the party and their ideology.

With misinformation peaking during election seasons in India, shallow fakes or cheapfakes still make up most of the misinformation seen online so far. Not Always Deepfakes Multiple mainstream media outlets such as the Indian Express, Times Now, Republic and DNA, among others dubbed the doctored Amit Shah video, a deepfake. While speaking at a rally in Maharashtra's Satara, Prime Minister Narendra Modi also referred to this video as being altered using artificial intelligence.

Siblings Found Dead Inside Family Shop In Delhi, Cops Hunt For Father

New Delhi: A 13-year-old girl and his younger brother were found dead inside their father's grocery shop in northwest Delhi's Keshav Puram area on Saturday, police said.

The children's father Manish, who is suspected to have killed the two siblings, is on the run and efforts are on to nab him, they said. A call regarding the incident was received at 7.15 pm, police said. Manish's

wife told police that both the children had gone to school but they did not return home. Initially, she thought that they were with their father as he would often pick them up from their school, they said.

She tried to contact Manish but his mobile phone was not reachable. In



the evening, when other family members opened the shutter of their shop, they found the two siblings lying inside in an unconscious condition," an officer said. They were taken to hospital where doctors declared them dead, he said, adding that their school bags were also lying inside the shop, located on the ground floor of their house.

According to a police officer, it is suspected that Manish killed his children by giving them some poisonous substance or by smothering them."The matter is being investigated from all possible angles and the bodies have been sent for post-mortem," the officer said, adding the actual cause of death will be ascertained only after the report comes.During the

investigation, it was found that Manish was upset due to some financial issue, however, further probe is underway. The statements of the family members have been taken, police said. The CCTVs in the locality are being scanned and teams were formed to locate Manish, police said.

BJP Will Never Change Constitution, **Congress Creating Fear Psychosis: Rajnath Singh**

Chief Justice Shares He Was Caned In Class 5 And Why He Can't Forget It

Speaking at a seminar on Saturday, he recalled when he was caned at school for a small mistake.

New Delhi: While corporal punishment is now looked down upon as a cruel method to discipline children, it was very much a reality for generations that did their schooling decades ago. For Chief Justice of India DY Chandrachud, it wasn't different either.

Speaking at a seminar on Saturday, he recalled when he was caned at school for a small mistake"How you treat children has their life...I will never forget that day in school. I was not a juvenile delinquent when my hands were caned. I was learning craft and didn't bring the right

sized needles to class for the assignment," he said. The Chief Justice, who was then in Class 5, said the way people treat children leaves a lasting impact on their minds."I still remember that I requested my teacher to cane my bum and not my hand," he added. Out of shame, he could not tell his parents and had to hide his injured right palm for 10 days."The physical wound healed, but left an everlasting imprint on the mind and soul. It is still with me when I do my work. The impact of such travesty on children is so deep," said the CJI.

The Chief Justice of India shared the incident while speaking at the National Symposium on Juvenile Justice organised by the Supreme Court of Nepal in







NCLT hearings, HC stays: Why Noida is struggling to recover ?8k crore dues

- Noida: The Noida Authority is faced with an uphill task of recovering Rs 8,400 crore from 10 developers of commercial projects who are also its primary defaulters. The companies include prominent realtors such as Supertech, ATS, Boulevard, Sunshine, Granite Hill and BPTP International, among others.
- Officials said the Authority's efforts in recovering the amounts have been hit hard by various factors, such as ongoing insolvency proceedings at NCLT and stay orders secured by some of the developers from the Allahabad high court. A few cases are also pending at the state govt level.NCLT hearings, HC stays: Why Noida is struggling to recover ?8k crore duesAccording to data sourced from the Authority, Supertech's Supernova project in Sector 94 owes the highest amount, exceeding Rs 2,100 crore.
- The developer moved the high court in 2021 after the Noida Authority issued a notice and also obtained a stay order against any "coercive action".
- ATS Knightsbridge in Sector 124 is second on the list, with dues amounting to almost Rs 2,000 crore.
- Recovering the amount has hit a hurdle here too as NCLT has recently admitted an application by an investment company that has financed the project and appointed an IRP.Boulevard Projects Pvt Ltd, a special purpose vehicle owned by the promoters of 3C group, has a debt of more than Rs 1,450 crore related to its Delhi One project in Sector 16B. The project was acquired by Max Estates - a realty firm under Max Group - after their bid was approved by NCLT last year. Noida Authority, however, appealed in the tribunal that it should be considered as a financial creditor.
- Developed by MMR Saha, 52nd Avenue in Sector 52 owes Noida over Rs 1,100 crore. The group has urged the state govt for a zero period waiver because of NGT's ban on construction to tackle deteriorating air quality levels in winter. Other companies that are yet to clear the Authority's dues are Sunshine Trade Tower's business park in Sector 94 (Rs 470 crore); The Downtown of Granite Hill Properties in Sector 98 (Rs 387 crore); BPTP International Trade Centre in Sector 94 (Rs 309 crore), Hotshot Developer's E-Square in Sector 96 (Rs 297 crore), Invoke Realtor's Logix City Centre in Sector 32 (Rs 153 crore), and International Recreational Park's The Great India Place (Rs 137 crore)

Cipla, Glenmark recall drugs from US market: USFDA

- NEW DELHI: Drug makers Cipla and Glenmark are recalling products from the American market due to manufacturing issues, according to the US health regulator. As per the latest Enforcement Report issued by the US Food and Drug Administration (USFDA), a New Jersey-based subsidiary of Cipla is recalling 59,244 packs of Ipratropium Bromide and Albuterol Sulfate Inhalation Solution. The medication, produced at the company's Indore SEZ plant, is used to help control the symptoms of lung diseases, such as asthma, chronic bronchitis and emphysema.
- Cipla USA is recalling the affected lot due to "short fill". There were complaints of less fill volume in respule and few drops of liquid observed in the intact pouch, USFDA said.Cipla initiated the Class II recall in the US market on March 26 this year.USFDA also said that Glenmark Pharma is recalling 3,264 bottles of Diltiazem Hydrochloride extended-release capsules indicated for high blood pressure.

Pesticide residue in Indian herbs and spices? Food regulator denounces claims as 'false and malicious'

NEW DELHI. The Food Safety and Standards Authority of India (FSSAI) have dismissed reports alleging high pesticide residue in Indian herbs and spices as 'false and malicious'.

In a press release, the food safety regulator clarified that India maintains stringent standards for Maximum Residue Limits (MRLs), tailored to individual food products according to risk assessments.

Pesticides fall under the purview of the ministry of agriculture and farmers welfare, regulated by the central insecticide board and registration committee established under the Insecticide Act of 1968. The process involves the examination of data by the scientific panel on pesticides residues of FSSAI.Recommendations for MRLs are made following risk assessments, considering dietary habits and health concerns across various age groups in India. With over 295 registered pesticides, including 139 authorized for spice use, the regulations align with Codex standards.Pesticides are registered



across multiple food categories with varying MRLs based on risk assessments. For example, Monocrotophos exhibits different MRLs on rice, citrus fruits, coffee beans, and cardamom, ranging

from 0.03 mg/kg to 0.5 mg/kg. Flubendiamide's MRL, similarly, varies among crops like brinjal, Bengal gram, cabbage, tomato, and tea, reflecting different levels of pesticide tolerance.

The FSSAI said that the MRLs undergo regular revision based on scientific evidence, conforming to global standards to enssure validity and alignment with the latest research and international norms.

Kotak Mahindra Bank is redoubling its efforts on the tech front, and winning back trust is the "top priority" for the lender now.

NEW DELHI. Kotak Mahindra Bank is expecting business restrictions imposed by the Reserve Bank to have a "relatively small" financial impact but is more concerned about the reputational damage, a top official said on Saturday.

Hinting that it expects the restrictions to last for a "couple of months", its managing director and chief executive Ashok Vaswani told reporters that it will have a limited impact on liability growth.Late last month, the RBI barred Kotak Mahindra Bank from onboarding new customers through its online and mobile banking channels and issuing fresh credit cards with immediate effect as the lender was found deficient in its

IT risk management.Vaswani, who took over office only in January this year, said it is redoubling its efforts on the tech front, and winning back trust is the "top priority" for the lender now.He admitted that the order will have an impact on the credit card business and its digital banking-focused 811 businesses as they are unable to do their work."I am more worried about the reputational impact than the financial impact. The financial impact will be relatively small,'

Vaswani told reporters.Its deputy managing director Shanti Ekambaram said the bank will focus on doing more business with its existing customers and deepening relationships through more cross-selling.She also added that the order does not prohibit the bank from adding new customers at the branches or in digitally-assisted journeys.Its group chief financial officer Devang Gheewalla said the bank spent 10 per cent of its operating expenses on the tech front in FY24, and added that the order may lead to an



acceleration of the spending.Vaswani, who comes with a background in technology, said the spending was around Rs 1,700 crore in FY24 against about Rs 1,300 crore in the year-ago period, and added that they will increase it at a similar rate.Over the past two years, the overall spending on the tech front has gone up, Vaswani said, adding that the efforts, which include new senior-level hires in tech functions, and augmenting the overall team, have "clearly fallen short". The demand for the services has also gone up

simultaneously, he said, adding that the bank has climbed up over five places to be the fifth busiest on the surging UPI transactions front.He, however, made it clear that it is not only a capacity issue but also about risk and resilience and assured that the bank will be looking at all three elements. The bank will also be hiring an external auditor to assess the overall technology architecture soon, as mandated by the RBI, he said.There will also be a

reprioritisation of the expenses to be undertaken and also advancing of the targets on attaining certain benchmarks being pursued, he said. When asked to quantify the cost of such a strong action, he declined to quantify saying it is a complex situation. The bank will try to make from the existing customers, which will entail a market share gain, but will lose out because it is deprived of growing the business, Vaswani said. adding that he expects to "come out ok" on a net basis.

Green revolution: Meet the next generation of Indian pitches

CHENNAI. Toss. Weather. Conditions. Pitch. Dew. Outfield. These are just some of the factors that have a significant say in the way a team approaches a match, irrespective of the format. Among the above, pitch takes prominence for how it behaves could dictate the pace at which play progresses. While cricket is still scratching the surface when it comes to data, significant technological advancements have been made in many other aspects, including the pitch.

Whether it is drop-in or conventional, there are different types of pitches based on the soil used, and so on. Over the past decade or so, hybrid pitches, too, have come into practice, especially for the white-ball format.

SISGrass, a UK-based synthetic turf manufacturer, has been a pioneer in the field not just in cricket but also in football, rugby and hockey. With over 650 hybrid pitches installed across the globe, including Dubai, where conditions are vastly different from England. And now, joining hands with Himachal Pradesh Cricket Association (HPCA), they have installed four hybrid pitches on the square of the scenic venue at the foothills of the Dhauladhar Range and two pitches in the nets outside. While they are used just for practice at the moment, it is the first time a venue in the country has installed hybrid pitches.Now, what is a hybrid pitch and how is it different from a conventional surface? Paul Taylor, former England cricketer and International Sales Director, Cricket at SIS Grass, explains."There are different kinds of hybrid pitches. There is an artificial hybrid, a concrete base with a carpet on top and then a soil profile on top of that. There's a carpeted hybrid, which is a synthetic carpet. It's then filled with soil, and then grass grows within that soil. Then there's the stitched hybrid, which is what we do. It takes your existing natural turf pitch and we inject synthetic fibres into that surface. And the stitching is at 20*20m centres. It covers the whole pitch,



and it extends beyond the stump lines by about a metre to make sure that the back foot contact for the bowlers is part of the system. The fundamental thing that is different about our pitch, is that it's still 95 percent a natural turf surface. There's only 5 percent of fibre injected into it," Taylor tells this daily.

"The stitching goes to a depth of 90mm but we can stitch deeper. In cricket, we only stitch to 90mm because that's all that's really needed. The fibre that we use is a polyethylene monofilament fibre. It's the latest technology in terms of how that's made. It's resilient and durable. It enhances performance. It doesn't fade in UV light and things like that. And it comes in different colours as well. We have a green fibre, a beige fibre, then a mixture of green and beige, so whatever the surface that

we're stitching into, we can pick the suit," he adds. The 5 percent fibre is expected to keep the wear and tear in check; it also enables the grass to recover after a match. "The fibres help the grass plant to become stronger. There's a natural air space around the fibre when it's injected, obviously, water will go down. And all the nutrients that are put onto cricket squares will also get down to the root. So the grass is a lot stronger, a lot more durable. You get up to three times the amount of cricket on one pitch that you would ordinarily get with a fully natural surface," says Taylor. However, when it comes to pitches, it is never one size fits all. The conditions in England, where SIS Grass began working in 2017, is very different from India, a country where different states will have different climatic conditions throughout the year. This is where the other factors like soil content and clay content come into play. "It is different in different places. However, we have installed it in Australia, New Zealand, Dubai and so on. One of the things we noticed when we installed the pitches in the UK is that the moisture content within the soil profile needed to be about 40% to allow the injecting needles to inject the fibres. In India, because the clay content is a lot higher


