New Delhi, June 14: An IAF aircraft carrying the bodies of 14 of the 45 Indians who died in a devastating fire at a building in Kuwait landed in Delhi from Kerala's Kochi on Friday evening, a senior official said. IAF plane carrying bodies of 45 Indians killed in Kuwait fire lands in Kochi A C-130J aircraft carrying the 45 bodies landed at the Kochi international airport around 10.30 am. Thirty-one bodies were received at the airport by Central and state ministers, including Kerala Chief Minister Pinarayi Vijayan. The remaining 14 bodies were sent to Delhi in the same aircraft as a domestic flight from Kochi, airport authorities in Kerala said. After the plane arrived in the national capital, newly elected MPs Yogender Chandolia and Kamaljeet Sehrawat stood on the tarmac with folded hands as the caskets were lowered from the aircraft. The special IAF aircraft had taken off for Kochi from Kuwait on Friday morning.

CBI admits in Mumbai court

Mumbai, June 14: In a bizarre development, the CBI has told a special Mumbai court that the bones and mortal remains purportedly of Mumbai executive Sheena Bora recovered by Raigad police after her murder 12 years ago, are reportedly "missing" and untraceable. The revelation came up during the examination of a witness, Dr Zeba Khan, a forensic expert at the Sir J. J. Hospital here, who was the first person to confirm that the bones and other remains found were of a human being. With the help of a local policeman, the bones were recovered by the Pen police in Raigad from the spot where Bora's body was allegedly burnt and dumped in the deep forests near Gagode-Khurd village.Police said that Bora, an executive with Mumbai Metro, was allegedly eliminated by her mother, and her ex-husband in connivance with her driver on April 24, 2012, but the shocking killing came to light only around

August 2015. At the court hearing on May 7, Public Prosecutor C.J. Nandode, appear-



ing for the CBI, sought to show the bones that were recovered, for identification by Dr Khan, but despite a diligent search, they could not be located. At the next hearing on Thursday, the CBI admitted that the

two marked packets containing the evidence (bones) could not be traced, and the examination of the witness (Dr Khan) would continue without showing it to her, though it was crucial for the case.According to the prosecution, Bora's mother and former media baroness Indrani Mukerjea, along with her ex-husband Sanjeev Khanna and her driver Shyamvar Rai, had strangled her in a car on the night of April 24, 2012. Later that night, they took her body, concealed in a suitcase, down to Gagode-Khurd, burnt the bag, and dumped the remnants in the forest before returning home early the next morning.A month later, the burnt bones and remains were found by the local police, but the sensational murder case came to light only in August 2015, after the arrests of Rai, Indrani and later Khanna. Indrani was released on bail in May 2022, while Rai was released earlier after he agreed to become a prosecution witness in

Bengaluru, June 14: A joint venture between Reliance Industries' Jio Platforms and Luxembourg-based SES to provide gigabit fibre internet has won approval from the Indian space regulator to operate satellites there, a government executive said. The three approvals issued to Orbit Connect India - which aims to provide satellite-based high-speed internet access - come as companies from Amazon.com to Elon Musk's Starlink have been vying for the go-ahead to launch satellite communication services in the world's most populous nation. The authorisations have not been previously reported. They were granted in April and June from the Indian National Space Promotion and Authorisation Centre, known as IN-SPACe. These allow Orbit Connect to operate satellites above India, but further approvals are needed by the country's department of telecoms to begin operations. Reliance, which owns Jio, did not respond to an email seeking further details.Inmarsat, another company hoping to provide high-speed satellitebased internet, has also gotten approval to operate satellites over India, IN-SPACe chairman Pawan Goenka told Reuters.

It is a pity. there is a tragedy."Yageshwar is said to be one of the probable candidates for Channapatna bypolls from BJP-JD(S) alliance.

"Issue notice," the bench said, adding that they would be taken up for hearing on July 8.The NTA, meanwhile, said it wanted to withdraw three other petitions, which were seeking transfer of cases from high courts to the top court, as they

Infant, 2 women killed as bus rams truck near Tenkasi in TN

TENKASI: Three passengers of a private bus, including a four-year-old boy, died and at least 16 others were injured as the vehicle toppled after being hit by a Keralabased tipper truck on the Thirumangalam-Kollam National Highway in Elathur near Tenkasi on Thursday. The Elathur police identified the deceased persons as M Alagu Sundari (35) and her son M Atchaya Bala (4), residents of Sivaramapettai, and M Selvi (55), a resident of Sankarankovil.According to sources, the private bus was en route to Srivilliputhur of Virudhunagar from Tenkasi new bus stand. C Vignesh (27) of Aemanpatti was driving the bus, when it was hit by the truck, which is usually used for transporting stones from Tamil Nadu to Kerala. When both the vehicles were approaching Elathur Vilakku junction, the truck hit the bus, and the latter toppled on the road. M Muthuraj (25) of Azhagapuram was driving the truck, sources said.

While Sundari and Selvi died on the spot, Bala sustained severe injuries and was shifted to the Government District Headquarters Hospital (GHQH) in Tenkasi, where he succumbed later. Further, 16 passengers of the bus, including the driver and conductor, suffered injuries. Nine of them were admitted to GHQH as in-patients, and six others received treatment as out-patients, sources added.Meanwhile, District Collector AK Kamal Kishore rushed to the spot soon after the accident and monitored the rescue measures. It is learnt that a traffic police inspector, Mani, saved a child's life by rushing the kid to the GHQH on his vehicle.

on Thursday to the students in order to claim the loss suffered by the institute due to students' protests. The penalty, amounting to Rs 6,61,155 per student, was imposed on Vaishakh Premkumar and Ben Thomas of the Department of electronics, Kailash Nath of the department of Computer Science and engineering, Irshad Ibrahim of the department of Mechanical Engineering,

and Adarsh of the department of material science and engineering. The protest which took place on March 22 resulted in significant

disruptions on the campus. The protesters prevented employees from entering the campus, and a working day was lost, according to NIT-C officials. NIT-C admin gives students 7-day

perceived losses incurred due to the protest. "We will seek legal advice before The institute authorities said in the notice responding to the show-cause notice issued by the registrar," Kailash Nath told TNIE."I first received the notice on

The main gate was closed as part of the protest, but regular activities of the college were unaffected. The administration cited safety concerns and the negative impact of late-night activities on students' health and academic

performance as reasons for introducing the new rules. These curbs, which had been lifted in 2020, were reinstated following complaints about students roaming the campus late at night.

The administration stressed that the unrestricted late-night access and the 24hour canteen operations posed challenges to maintaining order on campus. The imposition of night curfew triggered unrest among the student.

TN govt ordered to classify trans persons under special category for jobs, education

CHENNAI: Asserting that denial to consider trans perons under a special category is against the orders of the Supreme Court, the Madras High Court has ordered the Tamil Nadu government to treat trans persons under a separate category while considering them for public employment and educational opportunities.

The second respondent (Home Secretary) is directed to treat the trans persons under special category and not to treat them under female or male category in all education and employment avenues," Justice Bhavani Subbaroyan said in an order passed on Wednesday. The court also asked the Home Secretary to direct all the recruiting agencies to specify transgender as a special category and prescribe separate and lower cut-off marks, age relaxation and other norms as done for other categories like caste-based ones.

The order was passed on a petition filed by a trans person, R Anushree, seeking orders to the Tamil Nadu Public Service Commission (TNPSC) to consider her application under a special category of transgenders for recruitment to the posts falling under the Combined Civil Services Group-II A as per a notification of 2017. The petitioner stated that though she scored 121.5 marks in the exam, she was not called for certificate verification as she was treated as an SC (woman), for whom the cut-off mark was higher than her score. The TNPSC submitted that she could not be considered under a special category as she has marked SC and trans persons in separate columns for caste and gender in the application. However, Justice Bhavani Subbaroyan ordered TNPSC to consider her for recruitment by allowing her to submit her certificates for verification for the ongoing recruitment process to Combined Civil Services Group- II A as per a 2022 notification, by placing her in the special category and giving her preference.She observed that if there was a special reservation, as directed by the Supreme Court, the petitioner would have found a way to lead a life the same as any other citizen of this country. "The denial to consider the petitioner under a special category is against the direction issued by the Supreme Court and there cannot be any reason for not doing so," she said. The judge commented that every denial of opportunity to a trans person, that too when there is only a minimal number of educationally qualified, would pull back the community to lead an 'abnormal' life. It is for the government to improve their quality of life by providing sufficient opportunities in education and employment, the judge said. The judge further stated if the trans persons are

Of these, 34 were confiscated for not obtaining the mandatory annual fitness certificate, while the rest were seized due to irregularities in other essential documents, including road tax.It should be noted that a fitness certificate is valid for one year, which expires every yearon May 15.A notable case involving a bus owner fined Rs 2.68 lakh for pending taxes on a recently bought omnibus. The fine included Rs 2.43 lakh in pending taxes and Rs 25,000 as penalties. The fine was collected from Pragnya IAS Academy in Musheerabad when the bus was intercepted during an inspection drive on Wednesday. The bus was being used as a school bus without the required authorisation from the District Education Office (DEO) to run a passenger vehicle

Kochi city master plan gets Kerala government's nod

KOCHI: Kochi City's master plan, which has been on the table since 2002, received approval from the Kerala government on Thursday. After thorough legal scrutiny, the master plan was approved by the Local Self-Government Minister, among others. The new master plan provisions will be applicable from the date of issuance of the government notification. "Once the notification is issued, all building construction and development activities will be in adherence to the new master plan. With the implementation of the new master plan, the structure plan 1991 (general town planning scheme), which is applicable until now, will be revoked within the corporation area," said Mayor M Anilkumar.

The master plan (2019-2040) will endeavour to

Sanitation worker hit by cab, dies; 1 arrested

Gurgaon: A 51-year-old sanitation worker was killed after she was hit by a speeding cab near Vatika Chowk on Thursday morning. The driver allegedly abandoned his vehicle and fled the spot. Sanitation workers later staged a protest on the road, demanding the driver's arrest. The driver was arrested the same day.Around 7.30am on Thursday, Saroj was deployed along with some co-workers near Vatika Chowk to clean the road. As Saroj was sweeping on the SPR, a cab coming from Golf Course Road Extension hit her. She died on the spot due to severe injuries, an officer said. A case was registered under IPC sections 279 (rash driving on a public way) and 304-A (causing death due to rash or negligent act) at Badshapur police station. The driver was later identified as Md Chand, from Farrukhabad in Uttar Pradesh. Police managed to trace the driver and arrested him.Earlier in the day, agitated sanitation workers had blocked the road in protest. It was not immediately clear if Mulr, of Fort Worth, had retained an attorney in the case, which was filed in the US District Court for the Northern District of Texas. Prosecutors referred to Hunter Biden only by the initials "HB" but the dates of the criminal case against him match those of the president's son.According to the criminal complaint, Muller on June 11 called an FBI agent who had been

assigned to investigate a laptop belonging to Hunter Biden. When the agent disconnected the call, Muller called again and left a threatening voice message, the complaint alleged. Biden on June 11 was convicted of lying about his illegal drug use to buy a gun.Prosecutors say Muller accused the agent of covering up crimes committed by Biden and said that if former US President

Donald Trump were elected in November, the FBI agent would be iailed.

"Or, you can steal another election, and then the guns will come out, and we'll hunt you down and slaughter you like the traitorous dogs you are in your own homes in your own beds," Muller said in the message, according to the criminal complaint.

- Both the Forensic Medicine Service and the Ministry of Health did not respond to requests for information from The Associated Press made on Wednesday.
- The government statement did not say how many bodies were involved but said a malfunctioning refrigerated unit where bodies are kept when the morgue is full had been repaired.During the past week, forensic services collected 40 bodies that were victims of violence in a city that in 2023 recorded a total of 3,762 violent deaths, according to police figures. Most of the deaths are the result of clashes between gangs fighting over territory and drug distribution routes, which has created unprecedented levels of violence in this port city of 2.72 million inhabitants.

US Supreme Court junks bid to prevent access to abortion pill mifepristone

Washington DC, The US Supreme Court rejected a bid by anti-abortion groups and doctors to restrict access to the abortion pill, handing a victory on Thursday to President Joe Biden's administration in its efforts to preserve broad access to the drug. The justices, two years after ending the recognition of a constitutional right to abortion, ruled 9-0 to overturn a lower court's decision to roll back US Food and Drug Administration steps in 2016 and 2021 that eased how the drug, called mifepristone, is prescribed and distributed. The decision was authored by conservative Justice Brett Kavanaugh.The pill, given FDA regulatory approval in 2000, is used in more than 60 per cent of US abortions. The justices ruled that the plaintiffs, who sued in Texas in 2022, lacked the necessary legal standing to pursue the case, which required that they show they have been harmed in a way that can be traced to the FDA.

The Supreme Court, which has a 6-3 conservative majority, in 2022 overturned its 1973 Roe vs Wade precedent that had legalised abortion nationwide, prompting 14 states to enact measures banning or sharply restricting the procedure.

Biden, a Democrat seeking a second term in office in the November 5 US election, took aim at Republican officials behind such bans, saying they want to outlaw abortion nationwide and that Thursday's ruling "does not change the fact that the fight for reproductive freedom continues"."It does not change the fact that the Supreme Court overturned Roe v. Wade two years ago, and women lost a fundamental freedom. It does not change the fact that the right for a woman to get

the treatment she needs is imperilled if not impossible in many states," Biden added.Kavanaugh wrote that even though the plaintiffs, led by a group called the Alliance for Hippocratic Medicine, do not prescribe or use mifepristone, they wanted the FDA to make it harder for other doctors to prescribe it and women to receive it."Under Article III of the Constitution, a plaintiff's desire to make a drug less available for others does not establish standing to sue," Kavanaugh wrote, referring to the constitutional provision laying out the authority of the US government's judicial branch.

Kavanaugh rejected the argument made by the plaintiffs that the FDA's actions will force them to provide abortions, violating their consciences, because federal law already protects them.A ruling in favour of the plaintiffs could have threatened the regulatory authority of the FDA over drug safety. The plaintiffs targeted FDA regulatory actions in 2016 and 2021, including allowing for medication abortions at up to 10 weeks of pregnancy instead of seven, and for mail delivery of the drug without a woman first seeing a clinician in-person. The suit initially had

sought to reverse FDA approval of mifepristone, but that aspect was rebuffed by a lower court.Biden and other Democrats have sought to make abortion rights a central theme against Republicans in the election. Biden said he



will continue to urge Congress to codify abortion rights in federal law. Biden noted that some state abortion bans include no exceptions for rape or incest.

Women are being turned away from emergency rooms, or forced to go to court to plead for care that their doctor recommended or to travel hundreds of miles for care," Biden said. "Doctors and nurses are being threatened with jail time, including life in prison, for providing the health care they have been trained to provide. And contraception and IVF (in vitro fertilisation) are under attack," he added. The Supreme Court by the end of June is expected to rule on the legality of Idaho's strict Republican-backed abortion ban that forbids terminating a

pregnancy even if necessary to protect the health of a pregnant woman facing a medical emergency. In the 14 states that have banned abortion with limited exceptions, medical providers cannot prescribe or dispense mifepristone under

state law. Patients in those states might continue to take the legal risk of ordering the pills online from providers in other states or they might travel out-of-state to legally obtain the pills.

- Erin Hawley, a lawyer with the Alliance Defending Freedom, a conservative Christian legal group representing the plaintiffs, expressed disappointment with the ruling, but said it was on a

"legal technicality" and not the merits of the legal arguments.

The plaintiffs argued that the FDA acted contrary to its mandate to ensure that medications are safe when it eased restrictions on mifepristone. The plaintiffs accused the FDA of violating a federal law governing the actions of regulatory agencies.Hawley said she expected the litigation to continue given that three states - Idaho, Missouri and Kansas - already have intervened in it.

We are very hopeful that the federal courts will have a chance to hold the FDA accountable for its unlawful actions in removing these long-standing safeguards for women," Hawley said.

Kerala man, son killed after drunk driver's SUV rams scooter

KOCHI: A 46-year-old and his 11-year-old son died after an SUV driven by a drunk man crashed into their scooter in Ponnurunni, Kochi, on Wednesday night.Police confirmed that the car driver, Sujith M S, 31, of Kongad, Palakkad, was under the influence of liquor. Dennison was a sixthgrader of CKC School in Ponnurunni. Doctors said both of them suffered fatal injuries," he added. Denny is survived by wife Soniya and 14-year-old daughter Densia. The bodies were handed over to relatives after postmortem. The funeral will be held later.

Climate change taking its toll on wildlife too

BENGALURU: The sudden varying and rising temperatures across the country, heatwave conditions and excess rain have impacted humans and animals alike, especially those in the wild. The impact is seen not just in Karnataka, but across the country, in the form of increasing cases of conflict and death. To mitigate conflict, state governments undertook the task of drilling borewells and filling waterholes inside forests. Experts and officials from the Ministry of Environment, Forests and Climate Change (MoEFCC) and Wildlife Institute of India (WII) condemned this and asserted that the natural course should not be disturbed and there should be least human interference.

Taking a cue, they said this was the right time take up a study on the impact and chalk out an action plan for the future. They also noted that it was not just the natural weather course, but various infrastructure projects undertaken over the years have worsened the situation in forests. This is also impacting the mental health of animals, which needs to be studied."A detailed weather impact study of each landscape, along with a management plan, should be conducted. The physiological impact on animals and plants also needs to be studied. The best way to ensure safety of wildlife is to make sure that natural water bodies are not touched by construction of dams. Rivers and rivulets should be protected, as also natural vegetation as animals shift zones as the day progresses and weather changes," the MoEFCC official said.

Six drug peddlers arrested in TN, booked under Goondas Act

NAMAKKAL: Six people were arrested under the Goondas Act for selling illegal drug tablets and operating a fake, unlicensed medical shop in Namakkal town. The arrests on Thursday morning followed a wellcoordinated police operation. Sources revealed that police were tipped off about a gang selling drug tablets and injection drugs near a lake at Pothanur, Paramathivelur, in Namakkal. Acting on this information, Paramathi Velur police surrounded the suspects on Wednesday evening, catching them red-handed. They



confiscated 10 drug tablets, 10 injection drugs, Rs 50,000 in cash. two bikes, and six cell phones, all used in the smuggling operation. The arrested persons have been identified as M Chidambaram (27), S Pasupathi (24), G Nithesh (24), Muhammed Husain (24), R Gokulraj (20), and M Selvam(23).

Karnataka education department nod for hiring 35,000 guest teachers, HMs to decide

- BENGALURU: The Department of School Education and Literacy (DSEL) recently approved the appointment of 35,000 guest teachers for primary government schools in the state and 10,000 for high schools. The vacancies in about 49,679 government schools in the state were pending for a long time and raised several questions on the quality of education in government schools. While the new academic year already began during the first week of June, the government hopes to fill these vacancies soon for 2024-25.
- So far, according to sources in the education department, the temporary recruitment of guest teachers is in full swing. The department has assigned the Head Masters (HMs) of the schools to recruit individuals at a school level to speed up the process. The circular mentioned that the recruitment drive should prioritise hiring guest lecturers in rural areas, schools with no teachers and more so schools with high student ratios.
- Speaking to TNIE, BB Cauvery, Education Commissioner, DSEL, said, "We've asked the HMs to focus on hiring for Science, Maths and English as students mostly find these difficult to cope with. The other reason is also that the results indicate that these are the three subjects where students underperform, and we see most failures."
- She added that the vacancies for different subjects vary from taluk to taluk and the Deputy Directors of Public Instruction (DDPIs) are made accountable for the hiring and will need to update on a timely basis. The Commissioner assured that all of the sanctioned guest teachers will be soon occupied. The HMs will hire on the basis of





Time to put S&T policies back on track

IN the past 10 years, innovation was perhaps the most quoted buzzword in speeches of the Prime Minister, Cabinet ministers and science bureaucrats in India. Several awards, missions and schemes were announced to promote sciencebased innovation in different sectors. It is, however, surprising that all this was happening without a proper enabling environment. The grand intentions of the Modi 2.0 government to boost scientific research remained a 'work in progress' at a time when the global research landscape is fast changing with the emergence of deep tech. Little progress was made on three critical counts - science and technology (S&T) policies, funding mechanisms and research priorities — and the new government's agenda should be to prioritise them.An exercise to develop a new National Science, Technology and Innovation (STI) policy was initiated during the Covid-19 pandemic in 2020. Several drafts were prepared, but the policy remains on paper and is yet to be finalised. The policy was to replace the one released in 2013 by the UPA government. The first task of the new government on the science and technology front, therefore, should be to finalise the STI Policy and start its implementation in earnest. If the new dispensation finds that the draft is not good enough, it should junk it and continue with the 2013 STI policy framework. The policy goals enunciated in 2013 remain unfulfilled even after a decade.Among the key objectives of the 2013 policy was to position India among the top five global scientific powers by 2020' and to increase the gross expenditure on R&D (GERD) to 2 per cent of the GDP. We have seen little progress on the expenditure front. India has slipped on this parameter. The GERD in 2013 was 1 per cent of the GDP. It came down to 0.66 per cent and 0.64 per cent during 2019–20 and 2020–21, respectively, according to the latest available data from the Department of Science and Technology. The 2013 policy was unequivocal about the need to increase GERD and enhance public investment in scientific research, but the 2020 STI draft is vague on this count. It talks of developing a 'financial landscape of the STI ecosystem' in which departments and ministries of the central, state, and local governments as well as government and private companies will set up an STI unit with 'a minimum earmarked budget to pursue STI activities.' On the face of it, it is an outdated idea. It was first proposed in the 1980s.

The technology development roadmap suggested in the draft is equally adrift. The policy draft seeks to promote technology self-reliance and indigenisation to achieve the larger goal of Atmanirbhar Bharat. For this, a two-way approach has been prescribed — indigenous development of technology as well as technology indigenisation. At the same time, it says, "international engagements will be facilitated to gain essential know-how towards creation and development of indigenous technologies."

Another grand idea of the Modi government was the National Research Foundation (NRF) as a supra-research funding agency. It was first announced by Finance Minister Nirmala Sitharaman in her Budget speech in 2019. The NRF is still to see the light of day even after Parliament passed a Bill for its formation in 2023. The idea of a funding agency along the lines of America's National Science Foundation was first proposed by the Scientific Advisory Committee to the Prime Minister, headed by Prof CNR Rao, in 2005. As a result, the Science and Engineering Research Board (SERB) was established in 2008 to streamline funding for scientific research. The NRF Act of 2023 repealed the SERB Act of 2008 and dissolved SERB.There has been no credible justification from the government for replacing SERB with a new body. The only intention seems to be to create a centralised body to fund and also regulate research. NRF's Governing Board will be presided over by the Prime Minister and two ministers (Science and technology and education) will be the Vice-Presidents. Even with SERB, researchers complained of bureaucratic delays, one can imagine the fate of such a heavily political governing structure for the NRF. In a large and diverse country like India, do we need a centralised funding mechanism based in New Delhi or multiple channels of funding in different sectors?

Focus on agriculture as the fulcrum of economic growth

The need of the hour is to promote precision farming, which can give us more from less.

THE new government is expected to spell out a fresh policy to boost economic growth and improve consumption as well as investment. In the past decade, absolute power enabled the BJP-led government to formulate and push policies of its choosing swiftly without any concern over political opposition. Now, it is a different ballgame. The emphasis will be more on compromise and accommodation.

The chances are that economic growth will slow down a bit. Hence, the challenge will be to devise innovative ways to arrest the slide. It is hoped that technology will help turn the tide. The government should focus particularly on agriculture. Modi 3.0 has made a good start on this front by releasing the PM Kisan Nidhi instalment of Rs 20,000 crore to transfer Rs 6,000 each per year into the bank accounts of over nine crore farmers.But there has to be a follow-up after the sop. There has to be a new technology policy to take agriculture forward. The government can take a cue from the success story which Madhya Pradesh crafted to transform agriculture. Perhaps fittingly, former CM Shivraj Singh Chouhan, who did a good job in his home state, will hopefully do it at the Centre too as the new Union Agriculture and Rural Development Minister.

During the 10-year period till 2022-23, agriculture grew in MP by 6.1 per cent on an average annually compared to the national average of 3.9 per cent. One way in which this was done was not by putting under the plough virgin land but by more cropping. By cropping on the same land, the net sown area went up multiple times.

Other than effectively having more land, Madhya Pradesh was able to get more water. It did not build new canals but instead had concrete lining done for existing ones, besides desilting, cleaning and fixing breaches. Thus, the state was able to get a lot of canal areas without having to dig in entirely new ones. There should not necessarily be any effort by the Centre to get the states to go in for all this. There may be discord between states over groundwater drawn by irrigation tubewells that run on subsidised power. The Centre needs to persuade the states to move away from this process so that the sharp drop in groundwater levels can be curbed.

The government also needs to spur agriculture by bringing in new technology. The use of fertilisers, which helped usher in the Green Revolution, is becoming passe. New technology is needed to protect crops from pests, pathogens and weeds.Mechanisation and agronomic intervention can be promoted. Tractors have practically replaced bullocks. Now, there are new ploughs that can do deep tillage, mix pulverised soil and break hardpan layers. There is also new technology for irrigation -- drip irrigation and laser land levellers which place seeds and fertilisers. What can be done can be visualised from the



fact there are pomegranates being grown in Rajasthan on arid land through drip irrigation and water-soluble liquid fertilisers. When it comes to the new technologies for which the Centre is seeking support from the states, there is an overriding concern. The country needs to preserve land, water and air so that its citizens, who now number the largest in the world, are able to grow enough to preserve themselves. They also need to be able to cope with heat and pollution. The new policies which have to be evolved must make the Centre and the states put their heads together so that biodiversity is preserved. The ever-growing number of people must be able to survive and thrive in a sustainable manner.

But the good news from academics is that if farmers follow the right practices, yields can return to normal levels after some time. What is needed are policy decisions with better and more scientific evidence instead of going back to nature as Sri Lanka attempted to do by trying to do away with fertilisers and Sikkim ventured to do as well. The need of the hour is to promote precision farming, which can give us more from less. Geographical information system, artificial intelligence and machine learning, which can use enormous data to bring about

precision in farming, the use of sensors, drones, LEOs (low earth orbits), space technologies and cloud computing are all bursting out to provide the basis for a revolutionary epoch. Drips, hydroponics and aeroponics are available to get much more with very little exploitation of the planet's natural resources. But what stands in the way of this is the political economy.

Huge amounts of subsidy have been handed out by way of free power, free water and urea with 80-90 per cent subsidy. The subsidies may have been good in the 1960s and 1970s to meet the country's food deficit, but this has been continuing. Farmers in the northwestern region are continuing to grow the same paddy, wheat and sugarcane with state subsidy. The initiative by the government to enact new farming laws was negated by a long, revolutionary agitation. There is now an absolute need to ensure limited use of natural resources. The irrational exploitation of nature's wealth must be severely curtailed, if not stopped eventually. This is what the new government must try to do. To be able to do this, the Centre will need to have a dialogue and reach an agreement with the states. These are the new dynamics which the election outcome has handed down.

NEET fails to provide a level playing field

Merit must be measured in terms of societal good. The policy of 'one nation, one test' requires a serious review and improvement.

ISSUING notices to the National Testing Agency (NTA) and the Central Government on pleas seeking a fresh NEET-UG 2024 examination amid allegations of a paper leak, the Supreme Court's vacation Bench said, "Sanctity has been affected and we need answers." It has again been proven that NEET is not a neat way of testing students. There are serious allegations of papr leak and the possibility of an unfair advantage given to some candidates. Questions are being raised about the integrity of the test. Technical glitches, such as poor network connectivity, were faced by many students at a number of centres, leading to disruptions in the test.

An unusually large number of candidates have obtained high scores. As many as 67 candidates scored a perfect 720, with each scoring 99.997129 percentile. The fact that six of them were at the same centre has raised eyebrows. The grant of grace marks to around 1,560 candidates for the loss of time is also being criticised, as the NTA did not disclose details of the formula based on the Supreme Court's 2018 decision. The NTA's clarification is that candidates were compensated through grace marks.NEET is a unique system of admission. To pursue a medical course in Îndia, one must clear this test. The idea of common tests was initiated by Murli Manohar Joshi when he was the HRD Minister in the then NDA government. It found some support in the judgment of the Supreme Court in TMA Pai Foundation vs State of Karnataka (2002).NEET was notified by the Medical Council of India (MCI) in 2010. But, in 2013, a three-Judge majority decision in Christian Medical College Vellore Association vs Union of India struck down NEET. The decision was widely criticised as antistudent and one that would lower the standards of medical education. As a result, the Indian Medical Council Act, 1956, was amended and Section 10D was inserted to empower the MCI to conduct NEET. A review petition against this judgment was allowed in 2016, and the apex court ordered the conduct of NEET from 2016 itself.

Surprisingly, the Bench did not accept the Government of

India's repeated requests to permit state governments to conduct their tests at least in 2016. Interestingly, the

dissenting Judge of the 2013 judgment made NEET compulsory even prior to a full hearing by the Constitution Bench. NEET was thus imposed by the court and not the Narendra Modi government. The Justice Arun Mishra-led Bench in 2020 again upheld NEET, even in respect of minority institutions. Unfortunately, the top court considered just the legality of NEET and overlooked the real impact it would have on the ground, particularly on the underprivileged and minority institutions.

Why is NEET not really student-friendly? First, if a student falls ill or doesn't do well in the single test, he or she will not get a chance to qualify in another without losing a year. Second, it gives a student the right to select an institution of his or her choice by applying to particular institutions if multiple tests are conducted. In centralised NEET counselling, he ends up with colleges which he may not want to join.

The NEET paper leak has created problems for over 2.3 million candidates. There are translation-related errors in the question paper. NEET does not test qualities that a doctor must possess, such as compassion, empathy and passion to serve humanity. And finally, one single test is not the correct yardstick. Global best practices give weightage to marks in qualifying examinations, extracurricular activities and the statement of purpose.

But NEET is considered the best option, as our judges and the government think it promotes merit. But is there consensus on what merit really means? British sociologist Michael Dunlop Young's book The Rise of the Meritocracy (1958) popularised what is called 'meritocracy'. Meritocracy requires competition and equality of opportunity. Is it not a fact that the NTA and judges believe that the multidimensional construct of merit can be adequately, if not accurately, measured?



When NEET and other such admission tests do not meet this fundamental criterion, competition cannot be termed as fair and just, and the equality of opportunity becomes illusionary. There are scholars in the West who argue that common admission tests cannot measure abilities that are essential for learning, such as imagination, curiosity and motivation

There is indeed an element of class in NEET, and the Justice AK Rajan Committee did find hard evidence of such elitism. The Justice Rajan report on the impact of NEET in Tamil Nadu substantiated arguments against a single test. A majority of the 86,342 people the panel spoke to were opposed to NEET. The diversity in Tamil medical institutions has been affected with the

introduction of NEET. The percentage of students from rural areas has dropped from 61.45 per cent to 50.81 per cent.Similarly, the percentage of candidates from government schools has gone down from 1.12 per cent to 0.6 per cent. The percentage of English-medium students - already dominating medical education — went up from 85.12 per cent to 98.01 per cent. For students from economically poorer sections, it was a decline — from 47.42 per cent to 41.05 per cent. The number of firstgeneration learners has also dipped. If similar committees are appointed in other states, we may get similar findings. The Tamil Nadu Assembly did pass a law against NEET in 2021, but the Governor returned it in 2022. On the resubmission of the Bill, the Governor referred it to the President, who is unlikely to give her assent.Moreover, with just one national test, commercial coaching institutes are making a lot of money. And since most of them are based in big cities, poorer students from a rural background and those who have studied in vernacular mediums remain

at a disadvantage. There is also large-scale variation in the syllabus when it comes to the CBSE and state boards. If unequals are tested on the basis of one test, ie EET, the mandate of equality is violated.

We need to redefine our notions of merit in terms of a more inclusive and plural society. Merit cannot lead to exclusion. CJI DY Chandrachud rightly held that the transformative vision of the Constitution cannot be buried by the myths around 'merit'. Merit must be measured in terms of societal good. The policy of 'one nation, one test' requires a serious review and improvement.

Kuwait Building Fire: Plane Carrying Bodies Of 45 Indians To Land In Kochi

Kuwait Building Fire: Out of the 176 Indian workers in the housing facility, 45 have died, while 33 are hospitalised and the rest are reportedly safe.

New Delhi: India will bring back the bodies of 45 of its nationals killed in a devastating fire in Kuwait City on Wednesday by a special flight which will land in Kochi on Friday morning before heading for Delhi, the Indian Embassy in Kuwait said in a statement on Thursday night.ccording to

the statement, most of the victims are from Kerala (23), followed by seven from Tamil Nadu, three each from Andhra Pradesh and Uttar Pradesh, two from Odisha, and one each from Bihar, Punjab, Karnataka, Maharashtra, West Bengal, Jharkhand, and Haryana.Minister of State for External Affairs, Kirti Vardhan Singh, acting on the directions of Prime Minister Narendra Modi, reached Kuwait on Thursday forenoon to coordinate with the Kuwaiti government for the early repatriation of the mortal remains of the victims as well as to ensure the well-being of those injured in the tragic fire incident at a labour housing facility in the Mangaf area on Wednesday, the statement said.

Out of the 176 Indian workers in the housing facility, 45 have died, while 33 are hospitalised and the rest are reportedly safe. Immediately upon his arrival, the Minister visited five hospitals (Adan, Mubarak Al-Kabeer, Jaber, Farwaniya and Jahra), where



the injured Indians are being treated, and interacted with them. According to hospital authorities, all the patients are reportedly safe and will be discharged progressively depending on their medical conditioKirti



This decision came shortly after the new BJP government in Odisha, led by Chief Ashwa Dwara (Horse Gate): Located in Minister Mohan Majhi, approved the move in its first Cabinet meeting.

Puri's Shree Jagannath Temple's four gates: Significance

These gates have been part of the temple's architecture and rituals since ancient times. Each gate is associated with a specific direction and symbolism:Singha Dwara (Lion's Gate): Located in the east, it is considered the main entrance and symbolises liberation (moksha). Entering through this gate is believed to Some of them were kept closed to lead a devotee towards spiritual liberation.Vyaghra Dwara (Tiger Gate): Positioned in the west, it symbolises righteousness (dharma). - Keep adding soil and water until the level of the soil is correct and all of it is moist.

- Once the stem extends beyond the top of the bottle, gradually add more soil to give the stem and roots time to adjust being covered. With such a small opening, the soil may not be able to take in enough air at times and may sour due to over-watering. Now, that might be fatal to the roots.

- If the bottle is big enough, a layer of brick pieces of about 10 mm thickness should be laid (instead of gravel) at the bottom. This will absorb accidental application of excess water. Preparing the soil.

- The soil mixture should be porous and friable. This helps in aeration of roots. In case of a bottle garden, it is not easy to loosen the soil at regular intervals. Hence porous soil is essential.

- For this, take one part red garden soil, one part crushed brick pieces and one part leaf mould. In case leaf mould is not available, 1/2 part of welldecomposed manure may be used in the mixture. It is not necessary to sterilise the soil mixture.

- To take care of fungus and insect infection, add a small quantity of fungicide and insecticide to the soil mixture. It is advisable that these chemicals are mixed in water and then added to the soil.

Making the soil moist has certain advantages.

The dust will not fly while you fill the bottle with soil. And when you plant the saplings, the soil won't crack. Selection of plants

- The plants chosen should be slow-growing because fast-growing plants need frequent pruning, which is bit difficult in case of a bottle garden.

- Herbs like sage, oregano, basil and ferns work quite well for a bottle garden as they usually adapt to the size of their environment be it a small bottle or a big container.

- Keep the bottle near a window. But direct sunlight must be avoided, or else plants will wilt inside. How to sow a sapling Place the selected saplings inside the bottle with the help of fork and forcep. Pour a few droplets of water and close the lid of the bottle. The plants start growing inside the closed bottle. You should not water again unless the saplings start wilting. So, what are you waiting for? Happy gardening!

New Delhi. Wholesale prices in India rose by 2.61% in May, up from 1.26% in April, marking a notable increase driven by higher costs in the food and fuel sectors, according to data released by the Ministry of Commerce & Industry. The annual rate of inflation based on all

India Wholesale Price Index (WPI) number is2.61% (Provisional) for the month of May, 2024(over May, 2023). Positive rate of inflation in May, 2024 is primarily due toincreasein prices offood articles, manufacture of food products, crude petroleum & natural gas, mineral oils, other manufacturing tec," said the press release. The Wholesale Price Index (WPI), which tracks the average change



in prices at the wholesale level, saw a month-on-month increase of 0.20% compared to April. The spike in prices was particularly pronounced in food items and fuel. The WPI Food Index, encompassing

essentials like cereals, vegetables, milk, and meat, climbed to 185.7 in May from 183.6 in April.

This increase led to a rise in inflation within the food category from 5.52% in April to

7.40% in May.Primary articles, including food and minerals, spiked up by 0.54% to 187.7 in May, reflecting higher prices in food articles and minerals by 1.48% and 1.08%, respectively.Meanwhile, non-food articles and crude petroleum prices showed a decline of 1.26% and 3.56% in May compared to April.

In contrast, the fuel and power index dropped by 2.71% to 150.6 in May, primarily due to a decrease in electricity prices by 11.67%. Prices of mineral oils and coal, however, r e m a i n e d unchanged.Manufactured products, another significant component of the WPI, recorded an increase of 0.64% to 141.7 in May from 140.8 in April.

Among the 22 groups tracked under manufactured products, 13 reported higher prices, 8 saw declines, and 1 remained steady.

Notably, sectors such as basic metals, food products, and electrical equipment saw price hikes, while fabricated metal products and chemicals experienced price reductions.

The term "petrodollars" refers to the US dollars earned by oil-exporting countries through the sale of oil. The concept emerged in the early 1970s and has played a significant role in global economics and geopolitics.

History behind petrodollars

Initially, the Bretton Woods Agreement of 1944 established the US dollar as the world's primary reserve currency, pegged to gold. This facilitated international trade and economic stability post-World War II.However, in 1971, US President Richard Nixon ended the dollar's convertibility to gold, leading to floating exchange rates and increased currency volatility. In the following year, the Organization of Petroleum Exporting Countries (OPEC) imposed an oil embargo in response to US



support for Israel during the Yom Kippur War, causing oil prices to skyrocket. The US struck a deal with Saudi Arabia and other OPEC countries to stabilise the situation, where oil

Other central banks have aggressively hiked interest rates to tackle soaring inflation in recent years.But the BoJ has largely stuck to its easy-money policies -culminating in the Japanese currency hitting a 34-year low in April that led authorities to step into forex markets."Reducing bond purchases is an important aspect for the Bank of Japan as it aims to normalise its monetary policy and support the yen," Wael Makarem, financial markets strategists lead at Exness, told AFP before the decision."However, given Japan's fragile economic recovery and high public debt, the central bank may have to proceed cautiously," he said. The BoJ wants to see demand-driven inflation of two percent, fuelled by wage increases.Japanese inflation has been above the target since April 2022, but analysts question to what extent this is caused by temporary factors such as the war in Ukraine.

On Friday, the bank said factors including accommodative financial conditions were behind the gradual intensification of "a virtuous cycle from income to spending".But "there remain high uncertainties surrounding Japan's economic activity and prices", it said.

rate above Scotland. Hence, Scotland would need to beat Australia in order to edge past England in the Super 8 stage. Meanwhile, captain Marsh could face a ban if Australia manipulate Scotland's result to knock England out.
