Ensure complete transparency of EVMs or abolish them: Rahul Gandhi

New Delhi, June 17: Raising questions on the reliability of EVMs, Congress leader Rahul Gandhi on Monday asked the Election Commission to ensure complete transparency of the machines and processes or abolish them. The demand came a day after the Congress leader alleged that the electronic voting machine is a "black box" and nobody is allowed to scrutinise it while further alleging that serious concerns are being raised about transparency in our electoral process."When democratic institutions are captured, the only safeguard lies in electoral processes



Congress leader Gaurav Gogoi said, "Before treating the Electronic Voting Machines as infallible, the Election Commission of India should put out data on how many Electronic Voting Machines were found faulty throughout the elections." "How many machines showed the wrong time, date, votes registered? How many EVMs had their components replaced - counting unit? ballot unit? How many EVMs were found faulty during the mock poll?" he asked. "Having contested the elections, I can confidently say that these machines have shown inaccurate results. I hope the Election Commission puts out the above data because the public have the right to know." Gogoi said in a post on X.A fresh political slugfest has erupted over EVM tampering claims with Gandhi and other opposition leaders citing a media report that alleged that a relative of the Shiv Sena candidate in Mumbai North West Lok Sabha constituency was found using a mobile phone "connected" to an electronic voting machine during the counting of votes on June 4. However, Vandana Suryavanshi, the returning officer of the constituency, dismissed the report as "false news" and said a defamation notice had been issued to the publication. She asserted the EVM is a standalone system, not programmable and has no wireless communication capabilities. The BJP hit out at the opposition leaders over the issue and demanded that the Election Commission should prosecute all those who "amplified the lie" by sharing the news report. Ministry of Home Affairs to talk to Meiteis, Kukis in Manipur to bridge ethnic divide: Amit Shah

New Delhi, June 17: Union Home Minister Amit Shah on Monday said the Ministry of Home Affairs (MHA) would talk to both Meitei and Kuki communities at the earliest so as to bridge the ethnic divide in Manipur. Reviewing the security situation in Manipur here, Shah said strict action must be taken as per law against the perpetrators of violence in the northeastern state. The home minister said the central forces' deployment would be increased, if required, and that they should be deployed strategically to restore peace and tranquillity in the state, according to an official statement. Shah directed the officials to ensure that no further incident of violence took place in the state which has been witnessing ethnic violence for over a year. The MHA would talk to both the groups, Meiteis and Kukis, so as to bridge the ethnic divide at the earliest, Shah was quoted as saying in the statement. He also asked the chief secretary of Manipur to ensure proper health and education facilities for the displaced people and their rehabilitation. The home minister said the Centre is fully committed to ensuring safety and security of all citizens of the northeastern state. Shah also reviewed the situation in relief camps, especially in respect of proper availability of food, water, medicines and other basic amenities.

New Delhi, June 17: Political scientists Yogendra Yadav and Suhas Palshikar on Monday wrote to NCERT objecting to new textbooks carrying their names even after they had disassociated themselves from the revisions and said they would be forced to take legal recourse if these books with their names are not withdrawn immediately.In their letter, Palshikar and Yadav said they do not want the NCERT to "hide" behind their names to pass on to students such textbooks of political science that are "politically biased, academically indefensible and pedagogically dysfunctional". Palshikar and Yadav, who were chief advisors for political science textbooks, had last year said that the rationalisation exercise has "mutilated" the books beyond recognition and rendered them "academically dysfunctional" and demanded that their names be dropped from the books. They had stated that the textbooks which were a source of pride for them earlier had now

them as chief advisors."Besides the earlier practice of selective deletions, the NCERT has resorted to significant additions and rewriting that are out of sync with the spirit of the original textbooks... the NCERT has no moral or legal right to distort these textbooks without consulting any of us and yet publish these under

the letter said."There can be arguments and debates about someone's claims to authorship of any given work. But it is bizarre that authors and editors are forced to associate their names with a work they no longer identify as their own," it added. The NCERT is once again at the centre of a controversy with the revised Class 12 political science textbook not mentioning the Babri Masjid but referring to it as a "three-domed structure". The latest deletions in the textbooks include: BJP's 'rath yatra' from Somnath in Gujarat to Ayodhya; the role of kar sevaks; communal violence in the wake of the demolition of the Babri Masjid; President's rule in BJP-ruled states; and the BJP's expression of "regret over the happenings at Ayodhya". The letter by Palshikar and Yadav said, "Both of us do not want the NCERT to hide behind our names to pass on to students such textbooks of political science that we find politically biased, academically indefensi-

Narayanpur, June 17: Six of the eight Naxalites killed in an encounter with security personnel in Chhattisgarh's Narayanpur district two days back were senior rank cadres and carried cumulative cash rewards of Rs 48 lakh, police said. These cadres belonged to the People's Liberation Guerrilla Army (PLGA) military company no. 1 of Naxalites and Maad division supply team formations, they said. This is the second major success of the 'Maad Bachao Abhiyan' (anti-Naxalite operation) of Narayanpur police within a week and the fourth major success in 45 days, Inspector General of Police, Bastar range, Sundarraj P said in a press conference here on Sunday."Abhujmaad (in Narayanpur district) had been suffering from Naxal violence and fear for 40 years but now the natives, tribals and villagers are imagining it free from violence, fear and Naxalism. Successful anti-Naxal campaigns have been speeding up development," he said. Police on Saturday claimed to have gunned down eight Naxalites during an encounter in forests near Kutul-Farasbeda and Kodtameta villages in the district. New Delhi, June 17: Congress leader Rahul Gandhi will retain the Rae Bareli Lok Sabha constituency in Uttar Pradesh and vacate his Wayanad seat in Kerala from where his sister Privanka Gandhi Vadra will make her electoral debut. Congress chief Mallikarjun Kharge announced the decision on Monday after the party's top brass held discussions on the issue at his residence here. Besides, Kharge and Rahul, Congress Parliamentary Party chairperson Sonia Gandhi and party general secretaries K C Venugopal and Priyanka Gandhi Vadra were present at the meeting. If elected, this will be the first time Priyanka Gandhi Vadra will enter Parliament as an MP. This will also be the first time that all three Gandhi family members - Sonia Gandhi, Rahul and Priyanka - will be in Parliament together. The BJP has, however, attacked the Congress for the decision saying it is a

Shezad Poonawala said, "It proves that the Congress is not a party but a family company". Rahul Gandhi has to vacate one of the seats within 14 days of the Lok Sabha results, which came out on June 4. "Rahul Gandhi won from two Lok Saba seats but as per the law, he has to vacate one seat. Officials fret as wild jumbo spotted gobbling plastic waste in TN's Gudalur

COIMBATORE: A viral video of an elephant consuming plastic waste along with the leftover food on the roadside at Nellakottai on the Gudalur Sultan Bathery road left activists and forest officials worried. A tourist who was driving from Kerala shot the video, and shared it on social media. Though activists had earlier spotted plastic paper, sanitary napkins, and masks in elephant dung in Maruthamalai foothills and Gudalur, this is the first evidence of an elephant consuming plastic.Consuming plastic will not harm an elephant. But if food is stale, it will cause health issues for them, a forest veterinarian said on the condition of anonymity. "Since elephants have a simple digestive system, nearly 40 to 50% of whatever they consume will not be digested and released through dung. Elephants suffer diarrhoea and other infection if they consume stale food, chutney, sambar etc that are thrown along the roadsides. A scientific study should be carried out to find out the effects when animals, especially elephants, consume plastics," he said.N Sadiq Ali, founder of the Wildlife and Nature Conservation Trust (WNCT) said "The incident shows the poor handling of solid waste by Nellakottai municipality since plastic usage is banned across the district. 'The collector M Aruna should order all municipalities and panchayats to clear waste on a regular basis for the welfare of wild animals. Hoardings should be placed whereever possible to raise awareness among tourists to prevent them from dumping garbage in the open."Stating that elephant consuming plastic was rare, a senior official of Mudumalai Tiger Reserve (MTR) said it is difficult to find out who dumps garbage in the open as covering the roadside using CCTV cameras is a Herculean task.

Colleges fleecing; students in Tamil Nadu want transparency

CHENNAI: When S Adhithyan enrolled in a BSc Mathematics programme at a government-aided college in 2019, he was told to pay a fee of Rs 61,000 for the threeyear course by the management. His father is a daily wager and his mother took a loan from a self-help group to support his studies. That is why, the family was slightly relieved when the

physical classes were disrupted due to Covid-19 and the government announced that colleges should only collect 75% of the fees.

However, they were shocked when the college allegedly insisted he pay the full amount despite these directives. The management even silenced his questions by threatening to harm his academics. Frustrated over this, Adhithyan consulted some of his seniors and discovered that the government-fixed fees for his course were less than Rs

5,000.Upon graduating, Adhithyan filed a case against the institution seeking the college to return the excess fees. Adhithyan is one among many students who are robbed in daylight by some of the government-aided and government arts and science colleges in the state.In government-aided colleges, the government pays the salaries for teachers, non-teaching staff, and clerical staff, in addition to providing the land and initial infrastructure. The government also

released a fee structure for government and aided colleges in 1997. However, taking advantage of the lack of transparency in the fees fixed by the government, many government aided colleges and a few government colleges charge exorbitant fees, said students. All government-aided colleges have two

batches-morning batch students who were admitted in government quota and selffinancing students in the evening batch. Even though the government-fixed fees are around Rs 3,000 to Rs 5,000 for the morning batch, aided colleges, especially those with 'star status,' overcharge the students by five to six times the actual amount without any repercussions," said K Kathiravan, president of the Tamil Nadu Universities and Colleges SC/ST Teachers' Association. While the association welcomes the Tamil Puthalvan

and Pudhumai Pen schemes under which the government gives Rs 1,000 to government school students pursuing higher education, they appeal to the government to monitor the fees collection as the students from underprivileged backgrounds are unable to study in these sought-after colleges despite having good

marks, added Kathiravan.Several teachers' associations have been urging the Directorate of Collegiate Education to release the government-fixed fee structure on its website and to publish a white paper on the colleges that are overcharging students. They also want the government to stop funding colleges that defy the government order and suspend the principals of these institutions. "There are 163 government-aided arts and science colleges in the state. Only 10% of the colleges adhere to the fee structure fixed by the government. For the past decade, we have been urging the government to establish a fee

regulatory committee similar to the ones for engineering and medical colleges," said J Gandhiraj, president of the Association of University Teachers.Officials from the directorate of collegiate education said that they have taken action against colleges for which they have received complaints. When asked about appointing a fee regulatory committee, a top official said that the directorate would look into the demand and take necessary steps.

Karnataka: 1,419 government schools to start bilingual education

BENGALURU: Taking note of the poor performance of Kannada and other language medium schools in SSLC exams, and their dwindling numbers in the state, the Department of School Education and Literacy (DSEL) recently passed an order to start bilingual education - in English and Kannada. The department had invited applications for beginning bilingual classes from schools and received 1,800 applications, of which 1,419 government schools have been given the nod post scrutiny under certain criteria.

The Congress government, too, had promoted bilingual schools in its budget and set a target of 2,000 schools for this academic year; however, that could not be met. The highest number of government schools allowed to teach in the English language is in Kalyan Karnataka (Kalaburagi division) region, with 872 schools in seven districts, followed by Bengaluru division with 297 schools, Mysuru division with 140 schools and Dharwad division with 110 schools. The academic year 2024-25 began on May 29; however, the order was passed only on June 15. Officials cited the model code of conduct for the delay. Education Commissioner BB Cauvery told TNIE, "The academic year has just commenced and there is time till the end of the month for new admissions. Despite the official order delay, all schools are ready for these classes, as the proposals came from their side and we have approved only those that have the necessary infrastructure." She added that in terms of teachers, guest lecturers will be given priority in bilingual schools.On the high number of approvals for Kalyan Karnataka region, the Commissioner said the Akshara Avishkara scheme that aims to improve the performance of primary and high schools in the region, pushed more schools to meet the criteria. "Also, the ratio of students enrolling in government schools in this region is high, prompting conducive intervention from the state government," she said. Earlier, the department had directed te Regional Institute of English, South India, and Department of State Educational Research and Training to prepare an action plan for teacher training. A detailed report on the introduction of English medium classes in government primary schools was sought. Since 2019-20, there are 2,404 bilingual schools in the state. Officials in the department, on assurance of anonymity, also said that parents are keen to enrol their children in bilingual schools, which has increased the ratio. "At the field level, we are seeing increased interest in parents wanting their children to learn English from a young age. The department received many proposals but was rejected because of lack of infrastructure," the official

Lobbying intensifies in Congress for Palakkad and Chelakkara seats

THIRUVANANTHAPURAM: Though the Election Commission of India is yet to announce the date for by elections to seats rendered vacant following the Lok Sabha elections, lobbying is on in the Congress for the Chelakkara and Palakkad assembly berths. The Congress state leadership is yet to hold talks on the by elections, including the one likely in Wayanad Lok Sabha constituency. Preliminary-level talks on by elections are expected in the state executive committee meeting on Thursday. Ramya Haridas, 38, who tasted defeat at the hands of CPM's K Radhakrishnan in the Alathur LS constituency, is a serious contender for the reserved Chelakkara seat. Though posters appeared in Chelakkara against her, the party is keen on projecting her as its candidate. However, some in the Congress feel she might prove detrimental to the ministerial prospects of another senior leader from the SC community, A P Anil Kumar, the Wandoor MLA."If Ramya wins from Chelakkara,



she has every chance of emerging as a minister in a possible UDF cabinet after the 2026 assembly elections, as she is a woman candidate and hails from the SC community. This might hamper the prospects of Anil, the most trusted lieutenant of national general secretary (organisation) K C Venugopal in Kerala," a Congress leader told TNIE. The most prominent among other hopefuls in Chelakkara is K B Sasikumar, son of

former Chelakkara MLA K K Balakrishnan. Currently KPCC secretary, Sasikumar lost to Radhakrishnan in the 2011 assembly elections. Other names include K V Dasan, a former district panchayat president, and Sivan Veettikunnu, a local panchayat leader.

In Palakkad, the onus is on Shafi Parambil. who relinquished his legislator post after his win from Vadakara, to suggest a candidate. His protégé, Youth Congress state president Rahul Mamkootathil, is most likely to get the ticket. However, the fact that he hails from Adoor may work against Rahul.In such a case, KPCC vicepresident V T Balram will contest from Palakkad. Having shone in the state assembly for two terms, Balram, 46, lost to CPM's M B Rajesh in Thrithala by 3,173 votes in the 2021 elections.



Fever cases in Kerala see 65 per cent spike, cross one lakh-mark in June

THIRUVANANTHAPURAM: More than 1 lakh fever cases have been reported across the state this month alone, with outpatient visits seeing a 65% rise till June 15. In total, the state has reported over 10 lakh fever cases so far this year. From 5,533 on June 1, daily OP visits by people suffering from fever rose to 9,102 on June 15, taking the total number of cases reported till mid-June to 1,06,176. Daily hospital admissions saw 9% rise, from 104 on June 1 to 198 on une 15, while 22 deaths have been reported s far this month.Cold, cough, viral fever, influenza-H1N1, dengue, leptospirosis, and diarrhoeal diseases were the common ailments for which treatment was sought.

Health experts attributed the spike in viral fever to reopening of schools and sporadic rainfall. They also expressed worries over a further spike when monsoon strengthens. The concerns come at a time when Local Self-Government Minister M B Rajesh acknowledged the shortcomings in pre-monsoon cleaning during the summer due to the enforcement of the Model Code of Conduct. The bird flu outbreak in Alappuzha has also caused worries. Dr Purushothaman Kuzhikkathukandiyil of MES Medical College stressed the need for heighteed surveillance following the outbreak."Though transmission of infection from birds to humans is rare, we need to see whether or not there is any mutation.

Baby sale racket: Raid on quack's farmhouse reveals buried foetuses

BELAGAVI: Police officials, in association with health and revenue departments, raided the farmhouse of a quack and carried out a search operation in Basarakod village of Kittur taluk on Sunday. During the operation, officials traced the remains of three foetuses buried on the property. It may be recalled that the Malmaruti police of Belagavi had arrested five individuals on June 9, including a fake doctor, for attempting to sell a one-month-old infant girl for Rs 1.5 lakh. The accused were identified as Mahadevi alias Priyanka Bahubali Jain from Neginhal village in Bailhongal taluk, Dr Abdul Gafar Husainsab Ladkhan, a fake doctor from Kittur, Chandan Girimallappa Subhedar from Bailhongal taluk, Pavitra Somappa Madiwalar and Praveen Manjunath Madiwalar. Rajkumar Singappa

Rathod, coordinator of the District Child Protection Unit at the Government Adoption Centre, filed a case against them. According to police sources, the one-month-old baby was born after Dr Ladkhan, who was approached by Praveen and Pavitra Madiwalar, helped in the delivery. The couple had initially approached Dr Ladkhan to carry out an abortion. However, Dr Ladkhan facilitated the delivery and kept the baby with him. He allegedly sold the baby for Rs 60,000, and later commission agents attempted to sell her for Rs 1.40 lakh. Acting on this information, police nabbed the accused, who confessed to the crime during interrogation.Ladkhan had been running a clinic in Kittur town, posing as an MBBS doctor for over 10 years. A couple of days ago, the health department seized his



clinic. Ladkhan was arrested for allegedly assisting Mahadevi Jain, a nurse from Neginahal village, sell babies to affluent families after purchasing them from the poor at a low cost. In the wee hours of Sunday, officials from health, revenue and police departments, led by Assistant Commissioner Prabhavati Fakirpur, local tahsildar Ravindra Hadimani, District Health Officer Dr Mahesh Koni and DySP Ravi Naik raided Ladkhan's farmhouse.

Quack's aide being questioned

The action was taken in response to a complaint filed by taluk medical officer Sanjay Siddannavar, regarding illegal child abortions being done in the clinic run by Ladkhan. While searching the farmhouse, officials found foetuses which guided police to investigate not only the child trafficking angle but also an illegal abortion racket. Police have taken Rohit Kuppasagoudar, an assistant of Ladkhan in the clinic, into custody for interrogation.

"The web series is full of nudity, abusive language and objectionable scenes. Students of this prestigious school have been shown taking alcohol in the hostel. The coaches are being shown demanding sexual favours from girl students. Immediately after the release, a letter was sent to the producers, asking them to remove the logo of the school and the uniform, but nothing was done," said the FIR lodged by school's vice-principal Ghoshal on May 27 last year. She told the cops in her complaint that a show 'Rang De Mohe' was shot in Dec 2021 by a Mumbai-based company, M/s Click On RM Private Ltd.It was released one year and four months later on the OTT platform MX Player under the new name 'Virodh'.Prior to release, the producers had sought an NOC for release, but the school administration had refused to give it without first watching the content. However, instead of showing it to the administration, the producers released it on the OTT platform, the FIR stated.

Following the vice-principal's complaint, the Rai police filed a case against Trehan, Dahiya and MX Player under Section 67 of the IT Act on June 5, 2023 and launched an investigation into the matter. Trehan, who was called in on Wednesday to participate in the investigation, alleged that Col Mor (retd) had made additional demands in exchange for issuing the NOC,

They lost money to cons posing as relatives and colleagues

Gurgaon: At least four people were duped in the city in the last 10 days by cyber fraudsters posing as their acquaintances. No arrests have been made in the cases so far. Police said Rohit Kumar, a corporate employee from Begampur Khatola complained on Saturday that he had received a call on June 7 from an unknown number. The caller introduced himself as his brother-in-law and claimed that he would deposit Rs 45,000 in Rohit's bank account. Rohit was then asked to send the amount to a phone number given by him through UPI.

Subsequently, Rohit received two SMS indicating money deposited in his account.

"After transferring the amount when I checked the balance, I realized that no amount was credited to my account and the SMS messages I had received were sent by the fraudster, not the bank," the victim said. Cyber South police then registered a case under sections 419 (Punishment for cheating by personation), 420 (Cheating and dishonestly inducing delivery of property) of the IPC.

Similarly, three other people — all employees of different private companies — from the city were duped in the last 10 days. A total of 1.4 lakh has been duped from all the four victims. "We are analyzing the call and bank transaction details linked to the fraudsters to identify and arrest the offenders," a senior cyber crime official said. Cyber frauds pose as DSP, cheat ex-sarpanch of 95k, land in net

Gurgaon. Two cyber fraudsters, identified as Akeel and Khalid, have been arrested in Nuh for allegedly cheating an ex-sarpanch of Rs 95,000 by posing as a DSP Shamsher. The duo used the display picture of the DSP on WhatsApp to call the victim and asked for Rs 95,000, citing a personal emergency. After Dilbagh, former Sarpanch of Reeth village, sent the money, thinking that his police officer friend was in real need, the duo contacted him again, asking for more money, which triggered suspicion. Realising he had been cheated, Dilbagh approached the police, who caught the two men. The accused are now in remand.

Khalid belongs to Kherli village, and Akeel is from Otha village.

According to Nuh police spokesperson, Khalid called Dilbagh on WhatsApp, posing as DSP Shamsher, on June 12. Dilbagh got acquainted with DSP Shamsher a long time back but did not have his phone number. Believing that the DSP was calling him, he enquired

posing as the DSP cut the call after a brief chat.On June 13, the fraudster again called Dilbagh, asking him for money. "The caller's WhatsApp display picture had DSP Shamsher's photo in police uniform. Even on Truecaller, DSP Shamsher's name appeared. So I believed that it was him. He suddenly asked for Rs 95,000, stating that he had a family problem and needed the amount urgently. I told my younger brother to transfer the amount to the SBI account given by the man posing as DSP," Dilbagh alleged.

On June 14, the fraudster again called Dilbagh and asked for more money, and Dilbagh realised that it could be a fraud. When Dilbagh confronted the fraudster, he switched off the phone. Dilbagh filed a complaint immediately with the police.

Police then arrested Khalid and Akeel on Friday from their homes."The main accused, Khalid, posed as the DSP, and Akeel helped him execute the fraud. Khalid was also involved in communal violence at Nuh on July 31 last year. He pelted stones on people at Adbar Chowk and attacked the cyber crime police station with the mob," the spokesperson said. GPS must for waste collection vans in 7 days: MCG chief

Gurgaon: MCG commissioner Narhari Singh Bangar has ordered all agencies to ensure GPS integration for all waste collection vans within seven days, linking them to GMDA's command and control centre. Non-compliance will result in non-payment and potential blacklisting, he said at a meeting with MCG officials on Sunday. Over the past two days, MCG enforcement teams seized five vehicles found illegally dumping construction and demolition (C&D) waste at Sector 29, Subhash Chowk, and Hero Honda Chowk. Additionally, MCG cleanliness teams issued fines of Rs 500 to nine individuals for littering public spaces on Sunday.

Under commissioner Bangar's direction, three special enforcement teams have been formed, tasked with monitoring and taking action against illegal dumpers around the clock. This crackdown is part of a broader effort by the MCG to address the persistent issue of illegal waste disposal."Complaints have been filed with the local police stations to initiate legal action against the perpetrators, and the five vehicles have been impounded," said an official. Previously, the MCG terminated its contract with Ecogreen Energy due to unsatisfactory performance in garbage management. Despite repeated requests for improvement, the company failed to meet the required standards. Commissioner Bangar has now directed officials to clean up garbage hotspots across the city."The municipal corporation is implementing micro-level planning to overhaul the cleanliness system. Officials will verify and take over all vehicles used in door-to-door collection along with assets. They will ensure every household is serviced through a ward-wise route chart to prevent open dumping, and violators will be fined," said Bangar. The MCG is intensifying efforts against illegal garbage disposal as part of a special cleanliness campaign "Nine individuals were fined Rs 500 on Sunday for littering public spaces and were warned of potential FIRs for repeat offenses. The campaign aims to maintain cleanliness and effectively penalize violators,' said the official.In an effort to accelerate the removal of C&D waste from public areas, 600 tonnes of C&D waste were collected from National Highway-8 and other locations and transported to the Basai C&D waste management plant over the weekend. Police protection: 'AC jackets' with ice pads and fans to beat the heat in Gurgaon

GURGAON. In a bid to bring relief to personnel deployed on the roads amid the ongoing heatwave, traffic police have introduced cooling jackets. Powered by batteries, these 'AC jackets' are equipped with fans and ice pads and can bring down the body temperature by 3-4 degrees The jackets have been manufactured Celsius for up to five hours, according to cops.A trial has been rolled out to assess the jackets' effectiveness. "The jackets are designed to keep the upper body cool, and the built-in fans can operate for three to five hours. They can be recharged using readily available charging points," ACP (headquarters/traffic) Sukhbir Singh said.

Asked about the cost per jacket, he added, 'The overall effectiveness of the jackets is still being evaluated, and we are waiting During the testing phase, the jackets on the response from the personnel using it before working out budgeting and other

"DCP (traffic) Virender Vij distributed the jackets to 13 zonal officers at his office on Thursday, kickstarting the trial. "These officers will wear the jackets while on duty at their respective checkpoints and provide feedback, on the basis of which we will take a call before distributing the jackets to all traffic police personnel," he said.

In 2017, the Hyderabad traffic police had acquired similar jackets for their teams, but they were discontinued due to negative feedback regarding their effectiveness. Traffic police personnel had then said the jackets were cumbersome and lost their cooling properties rapidly due to condensation. Gurgaon police, however, said modifications have been made to the jackets and they plan to gather feedback from at least 50 policemen before giving them to all personnel.

This app helps cops track down cyber cons; 57 held in city & Nuh Gurgaon. Developed by the Union home ministry, the Pratibimb app has helped Gurgaon and Nuh police arrest 57 suspected cyber fraudsters not long after they alleged-

ly cheated people into transferring money. The app helps investigators geospatially locate the phones used by cyber cons after a person calls the national helpline 1930 to report online frauds. Police then find out the last known location of a fraudster as they have a tie-up with mobile service providers. Over the last month, Gurgaon police arrested 18 suspects with the use of the app. Similarly, Nuh police nabbed 39 suspects within two days by tracking the accused's locations. Though the app was launched four years back, the feature to trace cyber cons was introduced only last year, with a pilot run starting in Nov 2023 in Jamtara - the Jharkhand town that became famous as a hotspot for cybercriminals. After Jharkhand Police, Gurgaon was the first city to use the feature this month, followed by Nuh. Waves of cyber frauds originating from areas across Nuh have led to them being called 'new Jamtara'. Among those arrested by Gurgaon cops was a Manesar-based suspect who allegedly cheated an electric bike rider of Rs 26,000. Eight members of a gang that operated in Sector 49 of the city were also

nabbed for offering fake loans to online users. "Once we get the offender's location through Pratibimb app, our teams launch a probe to zero in on the offender. The offenders who resort to impersonation frauds, OTP frauds, loan frauds, online harassment and KYC frauds are being arrested with the help of this app," said assistant commissioner of police (cybercrime) Priyanshu Dewan.Most of the suspects arrested from Nuh were unemployed youngsters in their 20s and early 30s." They were involved in conning people in Telangana, Gujarat, Bengal, Karnataka, West Bengal, Delhi and Haryana," said Vimal Rai, an inspector at Nuh cybercrime police station. The inspector said Nuh police have registered 20 cases against the suspects under sections 419 (cheating by impersonation), 420 (cheating), 467 (forgery of valuable security or will, etc.), 468 (forgery for purpose of cheating) and 471 (using as genuine a forged document) of the Indian Penal Code. This is the latest crackdown on cyber criminals in Nuh since the arrests of 66 youngsters in a coordinated raid by Haryana Police in over 300 spots in the district in April 2023For now, access to the app has been given to cybercrime investigators of inspector and above ranks. On logging into the app, they can get locations of suspects in their specific jurisdiction.

New Zealand Prime Minister's plane breaks down on way to Japan

Wellington The New Zealand defence force plane flying New Zealand's Prime Minister Christopher Luxon to Japan broke down on Sunday, forcing the Prime Minister to take a commercial flight, his office confirmed on Monday.

Luxon is spending four days in Japan, where he is expected to meet with Japan's Prime Minister Fumio Kishida and spend time promoting New Zealand business.New Zealand media reported that the Boeing 757 broke down during a refuelling stop in Papua New Guinea, leaving the business delegation and journalists stranded in Port Moresby, while Luxon flew commercial to Japan. The New Zealand Defence Force's two 757s are more than 30 years old and their age has made them increasingly unreliable. New Zealand Defence Ministe Judith Collins told radio station Newstalk ZB on Monday that the consistent flight issues were "embarrassing" and that the ministry was looking at flying Luxon and his delegation commercially from now on.New Zealand's defence force is struggling with ageing equipment and retaining sufficient personnel. The government has said it would like to spend more on defence but is also trying to reduce spending as the country faces economic headwinds.

California wildfire forces evacuation, high temperature hampers dousing efforts

UPDATED. A wildfire burning northwest of Los Angeles on Sunday has forced the evacuation of over 1,000 people from a popular outdoor recreation area and burned over 12,000 acres, authorities said.

Some 400 firefighters armed with 70 firetrucks and two bulldozers are battling the Post fire, which is just 2% contained, according to Cal Fire. It is burning south of Gorman, California, about 60 miles (96.5 km) northwest of Los Angeles. The fire, which started Saturday afternoon, is moving to the southeast, toward Pyramid Lake, Cal Fire said. Some 1,200 people have been evacuated from the Hungry Valley recreation area, which has trails for motorcycles and off-road vehicles, since the fire broke out. Two structures have been destroyed so far. Cal Fire said that efforts to contain the wildfire are being hampered by high temperatures, low humidity and strong winds, forecast to continue through Sunday night.

Water-dropping aircraft are working to halt forward progress of the fire, while firefighters are constructing perimeter fire lines in an effort to get the blaze under more control

Indian accused in Pannun killing plot extradited to US from Czech Republic

Indian national Nikhil Gupta accused in Khalistani terrorist Gurpatwant Singh Pannun murder plot, has been extradited to the US from Czech Republic, news agency Reuters reported.

World Indian national Nikhil Gupta, who has been accused in the murder plot of Khalistani terrorist and US citizen Gurpatwant Singh Pannun on American soil, has been extradited to the United States from the Czech Republic, news agency Reuters reported, citing the Federal Bureau Prisons website and a source familiar with the matter.

A search on the Bureau of Prisons website by inmate name showed on Sunday (June 16) that Gupta, 52, is being held at the Metropolitan Detention Center, Brooklyn, a federal administrative detention facility. Furthermore, a source independently confirmed to Reuters, on condition of anonymity, Gupta's extradition and his detention in Brooklyn.Last month, a Czech court rejected Nikhil Gupta's petition to avoid being sent to the US, paving the way for the Czech



justice minister to extradite him. Gupta was arrested in the Czech Republic on June 30 last year, based on US allegations of his involvement in a conspiracy to commit the killing. According to US federal prosecutors, Gupta was implicated in a plot to hire a hitman to kill a US citizen, purportedly under the direction of an Indian government official. The target was identified as Pannun.

Nikhil Gupta's extradition comes ahead of US National Security Advisor Jake Sullivan's visit to New Delhi for the annual ICET dialogue. The matter is expected to be raised by Sullivan before his Indian counterpart Ajit Doval.India has denied its involvement in the Pannun murder plot and has constituted a probe committee to investigate the US's allegations.

Nikhil Gupta too, through his sattorney, has denied the charges and has said he has been "unfairly charged".

Gurpatwant Singh Pannun holds dual citizenship of the US and Canada, and is wanted in India on terror charges. He has been designated a terrorist by the Union Home Minister under the stringent anti-terror law Unlawful Activities (Prevention) Act.

Kochi Metro marks 7th anniversary on June 17; average daily ridership nears one lakh

KOCHI: The seventh anniversary of Kochi Metro, which falls on Monday, marks a significant milestone for the company, at a time when it has completed the 28km-long phase 1 corridor from Aluva to Tripunithura, covering a total of 25 stations. Work on the phase 2 corridor is expected to be completed within 18 months, once the tender is awarded by the Asian Infrastructure Investment Bank (AIIB), which has offered a loan for the project. Over the years, Kochi Metro has developed itself into the lifeline of the city. Construction work on the first phase began in June 2013. The 13.4km section of the line from Aluva to Palarivattom, consisting of 11 stations, was opened to passengers on June 17, 2017, by Prime Minister Narendra Modi, who also inaugurated the last stretch of phase 1, between SN Junction and Tripunithura on March 6 this year.

The number of daily commuters is approaching one lakh. "At present, on average of over 90,000 people travel on the metro every day. In May this year, average daily passenger ridership was 99,000 and for around 14 days the number crossed 1 lakh," a KMRL official said. According to KMRL reports, over 10 crore people have travelled on the metro since its inception. Of this, 3.11 crore people used the service in 2023. The tender for phase 2, from JLN Stadium to Infopark, known as Pink Line, is under review and may likely be awarded to Afcons Infrastructure Ltd, which has made the lowest bid.

Alarm bells over mushrooming mental health clinics in Kerala

KOCHI: In the post-Covid era, social media has played a huge role in raising awareness on the significance of mental health, therapy centres, virtual counselling and consultations. With the increased popularity and acceptance, the state has been witnessing a rise in the number of private mental health clinics. However, a lack of legislation to regulate and monitor the functioning of these clinics and virtual consultants has led to credibility issues, misdiagnosis of mental conditions,

and delays in providing treatment, experts pointed out. Wrong people giving counselling to people lead to tragic events," said

senior psychiatrist C J John, citing the

instance of a person who attempted suicide and later consulted him. "He was suffering from depressive disorder, which required medication, and was taking advice from a former police officer. These pieces of advice did not help him, leading to the suicide attempt," Dr John said. Many unscientific practices are entering the field of psychology because of the notion that anyone can practice counselling, pointed out Dr Arun B Nair.

We have seen some religious leaders counselling and using spirituality in this field. Unscientific interventions can even lead to the spread of malpractices, pseudoscience, and pseudo-beliefs," he said. According to experts, counselling is not everyone's cup of tea and a degree or post-graduation in psychology does not qualify anyone for the job. Rather, proper training is imperative. "Only those with some knowledge of psychiatry and neurological disorders can understand if

psychological therapy. Awareness on psychiatric and brain disorders that can come with psychiatric symptoms is important," Dr John said.Counselling requires confidentiality and technique, and importantly, the person has to adhere to training under the supervision of qualified and senior practitioners, he added."A poorly trained person

counselling a patient may fail to diagnose the condition, or even misdiagnose, thereby delaying treatment and worsening the condition," said Dr Dhanya Chandran, head of the department of psychology at Amrita Hospital, Kochi.Sometimes, brain disorders can also be projected through psychiatric symptoms, Dr Arun said. "A counsellor needs to have the capability to understand and diagnose such issues," he pointed out.lf-styled counsellors charging a huge fee after giving some random advice, Dr Dhanya said."Counsellors and therapists get huge amounts as fees. Somewhere around Rs 500 for a one-hour session. It is an income source for several people," she

of 2021."The Act directs state governments to come up with a regulatory body for professionals and it will come into force in the state once the Act is implemented at the national level," the official said."Licensing should be made mandatory before establishing a counselling clinic. Such clinics should be registered with the local bodies," Dr John stressed. The Mental Health Care Act 2017 has made it mandatory for mental health establishments to have

registration and licence. "The state has established a Mental Health Authority based on the Act. The Act has specified the qualifications required for rehabilitation professionals. But counselling is not covered under it," Dr Arun said, adding that awareness need to be spread on the qualifications."Often, people with mental health issues approach life coaches, trainers, and mind power trainers who may be qualified or trained in psychology. They can only give motivational speeches and train people to enhance business," he said. Writing down the qualifications and degrees on a name board should be made mandatory to prevent exploitation of patients, demanded Dr John.

GMC to implement special action plan to curb stray dog menace

GUNTUR: The Guntur Municipal Corporation (GMC) is taking steps to address the stray dog menace by implementing a special action plan for mass anti-rabies vaccination. The civic body has become increasingly vigilant following a series of incidents where stray dogs attacked children and the elderly. The GMC's veterinary wing has identified over 20,000 stray dogs in the city, and complaints about these dogs have surged recently. The issue was brought into sharp focus after a six-year-old boy and a sevenyear-old girl were attacked by packs of stray

dogs in quick succession. A Rangaraju, a resident of AT Agraharam, expressed concern over the growing stray dog menace in Guntur district. "During the night, over 20 to 30 stray dogs roam the streets and chase vehicles. We are afraid to go out late at night because of these dogs," he said. Rangaraju pointed out that poor sanitation exacerbates the problem, with many dogs gathering near dumping bins where heaps of waste are left on the roadside. He urged civic officials to take immediate action to address the issue.In response to the rising complaints, the GMC has decided to ramp up the sterilisation of stray dogs in the city. GMC Commissioner Kirthi Chekuri announced that the State government has contracted the Haryana-based Sneh Welfare Society, recognised by the National Animal Welfare Organisation, to carry out the sterilisation and mass anti-rabies vaccination drive from 2023 to 2026. Under the supervision of the GMC officials committee and experts at the Animal Birth Control Centre on Etukuru Road, sterilisation surgeries will be conducted on street dogs. Following surgery, the dogs will receive necessary medical care and will be released back into their original locations once fully recovered. The chief emphasised that only trained GMC staff would be involved in capturing the dogs and called on citizens, animal welfare organisations, and dog lovers to cooperate with the officials in this effort.

Tamil Nadu: Transfer of patta is now instant after registering property sans sub-division

CHENNAI: The automatic transfer of patta ownership for properties that do not involve the creation of subdivisions is now instantaneous, thanks to the integration of registration and revenue portals. When a buyer purchases a land parcel, house or other property that does not require any change in the extent of the land, the title is updated instantly on the online patta portal upon registration. The online patta can be downloaded within a few minutes from https://eservices.tn.gov.in by entering details such as district, taluk, town/village, survey number, and sub-division, according to officials. Once the property is registered, the new land owner's name will appear instantly on the encumbrance certificate, which can be viewed through the registration portal at https://tnreginet.gov.in/portal/. "Similarly, land buyers can view and download online patta instantly after registration. This transfer will only occur if the property seller has an individual patta in their name, and the extent of the property remains unchanged," Madhusudhan Reddy, Director of Survey and Settlement, said.Reddy added that currently, about 85,000 documents are registered every month at sub-registrar offices across the state, with 33,000 not requiring subdivision creation. "During the registration process, text alerts are sent to land buyers, and once registration is completed, a text alert confirming the title transfer will be sent," he said.

If the sellers do not have patta in their names, buyers have to apply for patta through e-seva centres, which will be approved within 15 days. "For patta requests requiring a survey for property subdivision, revenue officials directed to complete the exercise within 30 days," Reddy added. The revenue departments receive about three lakh applications seeking patta each month. "About two lakh applications are pending across the state. Previously, delays in issuing patta were due to a shortage of surveyors and staff. Now, with the vacancies filled, we have set deadlines for processing patta requests," Reddy said. This initiative is expected to benefit people who purchase apartments or individual houses/land parcels from approved layouts, which typically do not involve subdivision of property. The automatic land transfer initiative was launched three years ago, but it took several days for title changes to be updated as the earlier system required approval from revenue authorities. "Now, with the integration of registration and revenue portals, the scheme is fully implemented statewide," an official said.

Gender parity: Karnataka Fire & **Emergency Services DGP wants** women to gear up, fight fire

BENGALURU: For the first time in 82 years, the traditionally maledominated Fire & Emergency Services Department has approached the state government to appoint women firefighters. Accordingly, the department has recommended at least 10 per cent reservation for women in the recruitment of firefighters. Currently, the role of women staffers at the Karnataka State Fire & Emergency Services Department is limited to desk work. The inclusion of female firefighters in the workforce would be a significant move in promoting gender equality within the fire service. The proposal has been made by the Director General of Police (DGP) of the Fire & Emergency Services, Kamal Pant. "Women have proved themselves in various challenging roles across different sectors, including the Armed Forces and the police department. It's time we recognise their potential in the fire services as well," Pant said. "We have proposed to the government the need to change the cadre and recruitment rules to facilitate reservation for women. The proposal is being examined and will soon be sent to the government. The selection process for men and women remains the same," the senior IPS officer said, adding, "The department maintains strict recruitment standards. Our primary concern is public safety. All recruits must be regardless of gender and must meet the standards." Another senior officer from the fire department mentioned that they plan to improve facilities and working conditions to make the environment more conducive for

Cricketers as marasis

There's self-deprecating humour, and then there's other-deprecating humour. The former may lay bare deep insecurities, but it's deemed acceptable because it hurts none; other-deprecating humour, however, can and will cause hurt and anger, especially if done in public.Marasis — Punjab's rustic comedians — indulge in other-deprecating humour; they make fun of people's facial features, body shape, handicaps.

Where does humour lie? In prose and on the stage, it's often found in exaggeration; in the world of marasis, humour lies in lampooning and deriding and mocking others, and often the frailties that they can't do anything about — such as short stature or a limp or crooked teeth.

Kamran Akmal, the former Pakistan cricketer, was in the role of a marasi when he cracked a 12 o'clock joke about Arshdeep Singh, the India and Punjab pace bowler, when Îndia played Pakistan in the T20 World Cup in New York.

Now, we've all heard such jokes — Sikh friends have related these with relish, too. There is no one rule that fits all situations of humour, but such jokes are often alright among friends in a private sphere; but in public, and coming from a stranger, such jokes become offensive — an other-deprecating taunt likely to cause anger.

Cricketers learn to grow a thick skin, for they've heard all sorts of abuse from their opponents. Such harsh and cruel words, though, are often spoken in the heat of the moment, on the field of play. When a cricketer-analyst passes inappropriate jokes on live television, it's nothing but crass jeering, betraying a lack of sensitivity and good taste. But then, in a region — including India and Pakistan — where an amputee could be referred to as tunda, a man with a squint called bhainga to his face, and a dark-skinned person nicknamed kalu, it would be too much to expect a man like Akmal to be oversensitive. Add to it the state-sponsored hate for the minorities in Pakistani schoolbooks, and you can well believe that Akmal is a victim, too, and what he said about Arshdeep was quite inevitable. Maybe it's because we in Punjab have similar marasi/comedian culture, our own Navjot Singh Sidhu, humour king on TV, can laugh at people's appearance on reality shows. A few years ago, he had this to say about the Bangladeshi team: "Jo kangal, behal Bangladesh tha, woh khushhaal aur maalamaal..." This caused resentment in Bangladesh, as did his comment likening the team to "cockroaches" that can't fly. Sidhu's coarse humour may have raised some laughs, but such humour is clearly offensive and inappropriate. Between crass humour and extreme political correctness, there's much territory on which humour can flourish — middle ground that Akmal and Sidhu can occupy, removing their marasi hats. Givingup boorishness isn't a bad idea. When Hardik met Natasa, sparks flew; he liked her face, she liked his style, and love blossomed. It was 2018, and in 2020, they were married — cricketer Hardik Pandya and Natasa Stankovic, an actress and model from Serbia.

But in between was 2019, too, when Pandya put his foot in the mouth in a big way — in a TV interview, he boasted about his adventures with multiple women, saying this about his method of picking them up: "At a party, my parents asked me, 'Achcha tera wala (women) kaun sa hai,' so I said, 'Yeh, yeh, yeh (pointing out women)'... And they were like 'waah, proud of you beta!'"'I like to watch and observe how they move" Pandya said, adding that he paid particular attention to "the backside". Pandya and KL Rahul — also part of the interview, but much more restrained were criticised for being misogynists. It could be argued that Pandya didn't bring forth his misogyny — dislike for women; it was philogyny — love for women, instead. But it was peppered with deep contempt for them — due to their easy availability, added to his upbringing in a patriarchal society. Anyone who has covered cricket tours would testify that hundreds of young women practically throw themselves on cricketers all the time; during the IPL parties in Lalit Modi's era, stories of casual after-match trysts were legion. If the young Pandya, among others, succumbed to temptation, how much can he be blamed? As for him and Natasa, love seems to have soured; she got married to him despite his crassness. Speculation now centres round how much of his wealth would she be entitled to if they get divorced—a sordid end to love.

ENVIRONMENTAL conservation and climate issues were consigned to oblivion by various political parties in the recent Lok Sabha elections, despite a heatwave sweeping through many parts of the country. Delhi is making headlines over its drinking water crisis. The AAP government has claimed that the Capital is facing a water shortage of 50 million gallons per day. The most polluted capital city in the world is struggling to cope with the heatwave. The weather conditions have hit poor people

the hardest; they lack access to basic needs, such as food, water, health, housing and electricity, to fight or adapt to heatwaves. The impact of climate change is not the same for the rich and the poor. Societal inequalities exacerbate the effect of heatwaves on the poor, whereas the rich can afford to adapt to them. Over 80 per cent of the street vendors surveyed in Delhi reported a decline in customers amid the heatwave in April and May, and around 50 per cent experienced significant income loss, according to a report by think tank Greenpeace India and the National Hawker Federation.

While the rich contribute to climate change, it is the poor that suffer its negative effects, such as high temperatures or heatwaves. Rising temperatures cause a multitude of problems, such as health issues, water scarcity and food adulteration. Heatwave-related morbidities like dehydration, weakness, restlessness, headache, diarrhoea, skin rashes,

heatstroke and sleeplessness continue to affect people, especially children, the elderly, women and those with

Climate change has adversely affected the adequacy, accessibility and affordability of drinking water, with an increase in demand for it in Delhi. Residents, especially those in slums, continue to grapple with water shortage. The fundamental right to access clean water is denied even as the government proclaims the success of the Jal Jeevan Mission for an assured supply of rural drinking water and the Atal Mission for Rejuvenation and Urban Transformation for the universal coverage of drinking water supply in urban areas. Further, the past two months have seen a high demand for climate adaptation appliances like fans, air coolers, air conditioners and refrigerators in India. And there has been a huge surge in the consumption of electricity. Frequent incidents of fire are reported amid high temperatures and a corresponding

increase in the consumption of electricity to ward off the heat. The NCR has around 750 slum settlements, housing 3,50,000 families with a total population of 20 lakh. Poverty, sweltering heatwaves and an inadequacy of water have worsened the living conditions of slumdwellers. With limited economic resilience, the poor are unable to adapt to the climate. The poor seek relief from the excessive heat inside their homes — which have plastic and asbestos roofs — in open spaces like



footpaths, parks and the areas under flyovers. Children, the elderly and women remain the hardest hit. The rich, on the other hand, can adapt to the heatwaves, as they have access to water and air conditioners. These unsustainable human lifestyles and the extractive and exploitative use of common property resources can create problems for the common man in India.Governments are hardly prepared to face the greater developmental challenges posed by climate change. There is an urgent need to economically empower the poor to battle climate change. Sunstroke is not treated as a natural disaster in policy forums, and there are no rehabilitation centres or livelihood support for the poor who suffer because of heatwaves. There is an urgent need to assess urban climate risks for each city for a holistic climate resilience policy in India. The urban climate risk and vulnerability assessment - in terms of the number of people vulnerable to climate-related disasters, the damage to humans and infrastructure and the financial support needed to rebuild — is important for climate resilience. The system requires three kinds of resources to fight climate change at the city level: natural (forest and water), man-made (infrastructure) and human (technology and employment). Without them, an individual's capacity for climate resilience is highly limited. Climate resilience largely relies on the sustainable development of cities through practices like


> rainwater harvesting, replenishing groundwater and the conservation of urban forests, land, biodiversity, lakes, rivers and trees.Indian cities lack modern and sustainable infrastructure. Most of the infrastructure is old, and it cannot support the growing demands, for example, multimodal public transport, 24x7 water supply, sewage and solid waste management, green energy, urban housing and public hospitals and schools.

It is also imperative to improve the human capital through education, technology, health, jobs and a decline in poverty and income inequality. Inclusive development, such as social protection, acts as an insurance against climate change. The poor need financial, technical and

institutional support in the form of poverty reduction programmes, social security schemes, etc, to improve their quality of life and develop climate resilience. Indian cities need to have institutional capacity to adapt to climate change. Systemic wealth and income inequalities have exacerbated the impact of climate change on the poor. The present model of economic development perpetuates inequalities and fails to reallocate and redistribute resources. Economic inequality and climate change are intricately linked to an unequal distribution of income and resources, limiting the economic resilience of the poor to fight climate change. Therefore, there is an urgent need to restructure economic and environmental governance systems to achieve inclusive development and strike a balance between ecological and economic stability to tackle climate change in India.

Biannual admissions

Implement in phases, ensure quality education



Students in India can now be admitted in January-February as well as in July-August, as is the case in most foreign universities. The UGC chairperson feels the policy will benefit students who missed admission due to a delay in the



announcement of board results, health issues or personal reasons. The education regulator's experiment of biannual admission for open and distance learning and online programmes, he claims, has helped nearly five lakh students join degree programmes without waiting one full academic year. That's commendable, but what may work for online and distance education programmes may not necessarily turn out to be feasible for on-campus

While one would advocate keeping an open mind on the new policy, what can't be discounted are the apprehensions regarding its potential impact on educational quality. Allowing double the intake of students without ensuring a commensurate presence of qualified teaching staff can spell chaos. Phased implementation, with an ample scope for course correction, appears to be the ideal strategy. As the UGC presses for biannual admissions, it will have to ensure that the process is not misused as a money-making opportunity.

The students must not lose out.

Our lives will pass, and if there is a statue or a road named after that passing, it has no relevance to mortal life. Humanity does


The formidable Joseph Campbell's immense body of work covered mythology, religion and belief systems. His writings provided substantial insights into the human experience and its behaviour. He once wrote, "Every myth is psychologically symbolic. Its narratives and images are to be read, therefore, not literally, but as metaphors.'

Of the many books bought by my parents when I was young was the obligatory 'Tales from Akbar and Birbal'. Akbar and his trusted courtier Birbal would thrust and parry, and in doing so created some wonderful stories and parables. Some may be fiction, some may be fantasy and some may be outright lies. Be it so. They, however, are simply delightful. In one story, Akbar packs Birbal off to search for the most beautiful child in the kingdom. Birbal returns and asks the Emperor to accompany him. Hiding behind a bush, they see a small child come out of a hut. Akbar angrily whispers in his ear, "You have brought me to see this? This must be the ugliest child in my kingdom."In moments, the child's mother appears and lovingly clasps the child to her chest. She calls him the 'most precious jewel in the world', her 'piece of the moon' and a dozen other endearments. Akbar watches and listens silently. Then Birbal says, "Now you know why he is the most beautiful child in Hinustan? It is because his mother thinks so."

This lack of or the presence of the beauty of the child may be transferred to other situations, to other places and to other people. This metaphor can become the prism to look at those that have ruled us, and to those that shall. Each turn of history has had

its beautiful, as well as its ugly, children sitting at the helm of affairs. With either, it is a question of perception. My saint may be your sinner — and the other way round. The scales that decide which is which, is

what we call 'humanity and civilisation'. One of the most polarising politicians of post-World War-



II England was Enoch Powell. He called for an end to migration from the Commonwealth countries to Great Britain. In 1968, Powell made his deeply disturbing 'Rivers of Blood' speech which was, supposedly, the result of the Race Relations Act introduced by the Labour Government. The Legislation would prohibit

discrimination on grounds of race in certain aspects of British life, especially by persons or councils denying non-whites places of residence. The press lashed back and The Times called it an "evil speech"

Edward Heath, as leader of the Opposition, sacked Powell from his Shadow Cabinet and Powell did not hold a

political post again. However, just a year later, a Gallup poll placed Powell as the most 'admired person' in public opinion. In later years, based on various polls, Powell's popularity remained and there is a school of thought that he would have won had he contested for political leadership. While there are several other issues and standpoints involved, echoes of Powell's stance continue to the present day; for example, Nigel Farage of the UKIP considers Powell to be his political hero.

Somewhere parked at the back of my head, along with other pointless clutter, is an image of ancient Rome. I know precious little of modern Rome, far less the ancient. But this image, which has roots in Europe's broader tradition, if not in reality, appears repeatedly in art and elsewhere. In my image, a triumphant General is returning in glory. Whoever he was sent out to sort, has been sorted. The enemy, real or imagined, has been conquered. Crushed. Decimated. Rome is as triumphant as ever. The victor's chariot is drawn by the finest horses. The crowds cheer him and flower petals come as thick and fast as the arrows he fended in battle.

Standing behind the victor on the chariot is a slave. Amidst the din of adulation, he has just one task. He holds a crown over the victor's head and constantly whispers in his ear, 'Respice post te. Hominem te esse memento. Memento mori.' From Latin, this roughly translates as, 'Look after yourself. Remember you're a man. Remember you will die.'If we would like to call ourselves civilised, or wish to hold a candle to basic humanity, there is the essence of that phrase, 'Memento mori' (Remember you are

mortal). Our lives will pass, and if there is a statue or a road named after that passing, it has no relevance to mortal life. Humanity does. This is valid for whichever side one is cheering for — the left, the right, the pink, the blue or, the sweet old lady, who before one steps into it, clears her dog's litter in the park.

Solah Shringar

The science behind it



'I adore wearing gems, but not because they are mine. You can't possess radiance. You can only admire it,' said Elizabeth Taylor, my favourite actor.

The radiance of ornaments, jewels, pearls or gems have always been fascinating. But here in India, we don't just admire the radiance. Here it is a belief through the ages that it is wise to embellish ourselves with ornaments. Excavations revealed and cave paintings depict that during the early historical periods both men and women favoured wearing ornaments.

Indian literature is replete with descriptions of women arraying themselves with ornaments while shringar rasa is a significant motif in all Indian classical dance forms. In Bhanushinger Padavali beautifying herself for a tryst with Krishna, Tagore's Radha says:

Dress me with pearls and jewels Decorate my forehead with mantika

My hair is spilling to the ground

Bind it with garlands of champak

Given that Shringar is interwoven into all Indian arts, shouldn't we pause to ask why wearing ornaments. throughout the vast and diverse India, has become almost ritualistic?

Ancient Vedic texts mention Solah Shringar with which they proclaim a woman must adorn herself. Solah Shringar or sixteen embellishments comprise the bindi, necklaces, earrings, flowers in the hair, finger rings, bangles, armlets, waistbands, ankle-bells, kajal, toe-rings, henna, perfume, sandal wood paste, the upper garment and lower garment. Though some of these have been discarded by the modern Indian woman for practical reasons, much of this list is still in vogue.

The texts also claim a scientific basis to the use of Solah Shringar. Though garments are for modesty and some adornments like perfumes are to allure, the belief is many of the sixteen embellishments aid in good health and well being of the wearer. To Hindus, women are embodiments of Shakti. So traditionally, ornaments are worn to protect orifices and extremities and thus control the power that can emanate from these parts of the body.

Let's trawl through some interesting hypotheses.

The bindi, an ornamental dot placed on the forehead between the eyebrows signifies the mystical third eye, the invisible organ of spiritual perception and second sight.



It's worth a thought that the two eyes are regarded as the sun and the moon capable of seeing the past and the present. The symbolic third eye represents fire with the perceptive powers to see into the future.

Women who get their nose pierced for the nose ring are said to experience less pain during childbirth. Some say that it prevents the woman from being hypnotized as it controls brain wavelength.

Bangles are said to increase a woman's blood circulation and revert back to her the cosmic energy that is passing through her body due to their circular shape. Toe rings supposedly regularize the woman's menstrual

cycle. Apparently nerves in the second toe, where rings are worn, are connected to the uterus and friction with the rings help to revitalize the reproductive organ.

You will notice that people wear finger rings on the fourth finger from the thumb. The belief is the nerve passing through this finger is evenly spread through brain neuron cells. Frequent metallic friction is good for the health of the wearers and helps them to handle life with ease and confidence.

Necklaces like the mangalsutra are worn to control blood pressure levels and regularize blood circulation.

Waistbands are not regularly used these days, but they prevent saturation of fat in the waist and maintain a woman's figure.

Kajal is used purely to enhance the size and shape of the eves.

After all the eyes are called the windows of the soul and convey the feelings of the heart. Natural kajal or kohl can be easily prepared at home by collecting soot in a silver bowl balanced over a wick burning in mustard oil. Sometimes camphor is added to the oil. This mixture is applied with a silver stick to the outer rims of the eyes. When it mixes with the natural tears, it is said

to protect the eyes from the harsh sunlight and dust. It must be of dark, kohled eyes sparkling with light that the poet has said.

'My eyes are not eyes, Beloved, but arrows of light; My eyebrows are not eyebrows but swords for your destruction.'

Despite assertions by traditionalists, medical science does not corroborate claims that ornaments actually keep wearers in better health. Still, cultural rituals have grown around these beliefs. People bless a new-born infant or a new bride by offering them gold jewellery or coins for good fortune. Infants are made to wear



ornaments as protection against illness.

Of course, men will argue that women have never needed an excuse to wear jewels or take care of their shringar. Nevertheless, today a lot of men also wear jewellery because it brings them luck.

Monitoring shows snow levels are almost a fifth below normal across the region this year, with the most dramatic declines in the west, where its contribution to water supply is the highest.

New Delhi: The Hindu Kush Himalaya is experiencing significantly lower snow persistence this year, raising serious concern over water security for downstream communities, according to a new report.

Leading experts from the International Centre for Integrated Mountain Development (ICIMOD), a Nepal-based intergovernmental organisation, have urged water management officials to initiate drought management strategies and preemptive emergency water supply measures. The Hindu Kush Himalaya (HKH) region heavily depends on the cryosphere -- frozen water on the Earth's The Helmand river basin shows the most surface, including snow, permafrost, and ice from glaciers, lakes and rivers. This frozen water is a critical source of freshwater for around 240 million (24 crore) people living in the HKH region and has far-reaching benefits for around 1.65 billion (165 crore) people downstrea. Snowmelt accounts for around 23 per cent of the total water flow of 12 major river basins originating in the HKH. However,

its contribution varies from river to river, representing 74 per cent of the Amu Darya's flow, 77 per cent of the Helmand's flow, and 40 per cent of the Indus' flow. Monitoring shows snow levels are almost a fifth below normal across the region this year, with the most dramatic declines in the west, where its contribution to water supply is the highest. Snow persistence dropped 17 per cent below normal in the Ganga basin and 14.6 per cent below normal in the Brahmaputra basin, said the Snow Update Report - 2024, released on Monday.

significant drop in snow persistence at 31.8 per cent below normal. Its previous lowest level was in 2018, with a 42 per cent reduction.he Indus basin has fallen to 23.3 per cent below normal, the lowest level in 22 years. The previous lowest year for this basin was 2018, with a 9.4 per cent shortfall. The Mekong basin had the smallest variation from normal, with snow persistence around 1 per



cent below normal

We have seen a pattern of decreasing amounts and persistence of snow across the Hindu Kush Himalaya, with 13 of the past 22 years registering lower-than-normal seasonal snow persistence," said ICIMOD cryosphere specialist Sher Muhammad, who is also author of the report."This is a wake-up call for researchers, policymakers and downstream communities. Lower snow accumulation and

fluctuating snow levels pose a serious increased risk of water shortages, particularly this year," he said.Miriam Jackson, ICIMOD's senior cryosphere specialist, said agencies must take proactive steps to address possible drought situations, especially in early summer. "Plans must be updated to accommodate water stress, and communities need to be notified of the risks." "Beyond that, it's clear that governments and people in this region need urgent support to adapt to changes in snow patterns that carbon emissions have already locked in. G20 countries need to cut emissions faster than ever before to prevent even more changes that could prove disastrous to major population centres and industries reliant on snowmelt in the mountains," she said. The experts said promoting rainwater harvesting and establishing local water committees may help mitigate the immediate impacts of belownormal snowfall on the water supply in the HKH region.

Missing for 3 days, American base jumper found dead in Himachal

New Delhi: Three days after an American citizen went missing, his body was recovered in a ravine between Kee and Tashigang in Himachal Pradesh's Lahaul and Spiti district on Sunday, police said. Trevor Bokstaahlar (31) went missing on Thursday during his visit to the Spiti Valley, following which a search team was constituted, they said. According to the police, the team conducted searches in various areas of Kaza and recovered a motorcycle rented by the deceased near a deserted area close to Tashigang, but no further clues

A day later, with the assistance of the Dogra Regiment of the Army, a drone on Friday identified a parachute stuck



in a deep ravine between Kee and Tashigang, they said. The police suspected the parachute belonged to Trevor, who was a base jumper, Superintendent of Police (SP) Lahaul and Spiti, Mayank Chaudhary said. onsequently, teams from the Indo-Tibetan Border Police (IIBP) and State Disaster Response Force (SDRF), trained in such rescue operations and adverse conditions, were deployed and Trevor's body was brought down, SP Chaudhary said. The information has been shared with the American Embassy, and we are in constant contact with them, the SP said, adding that the body would be handed over to them after the formalities

"Accident Saddening, Rescue Ops Underway": PM Modi On **Bengal Train Collision**

New Delhi: Extending his condolences to the families of the people killed in this morning's train accident in West Bengal's Darjeeling district, Prime Minister Narendra Modi has said that he has spoken to officials to take stock of the situation and Railway Minister Ashwini Vaishnaw is also headed to the site. Describing the collision as saddening, the PM said he is praying for the speedy recovery of the injured. In a post on X, the Prime Minister wrote, "The railway accident in West Bengal is saddening. Condolences to those who lost their loved ones. I pray that the injured recover at the earliest. Spoke to officials and took stock of the situation. Rescue operations are



underway to assist the affected. The Railways Minister Shri @AshwiniVaishnaw Ji is on the way to the site of the mishap as well."

The Prime Minister's Office has also announced a compensation of ? 2 lakh each to the families of the dead and ? 50,000 to the injured.

Eight people - including three Railway staffers - were killed and at least 25 were injured after the Kanchanjunga Express, headed to Sealdah in Kolkata from Silchar in Assam was hit from the rear by a goods train near Rangapani station, close to New Jalpaiguri. The New Jalpaiguri railway station is a busy one and is used by passengers from all states during their journey to Darjeeling.







Global concerns grow over concerns about use of AI in news production: Reuters study

NEW DELHI Global concerns about the use of artificial intelligence (AI) in news production and misinformation are growing, a report published by the Reuters Institute for the Study of Journalism found, posing fresh challenges to newsrooms already

struggling to engage audiences.
The institute's annual Digital News Report published on Monday, which this year is based on surveys of nearly 100,000 people across 47 countries, offers a picture of the hurdles news media faces in lifting revenue and sustaining business, Reuters reported. Newsrooms globally are working to address a new challenge with generative AI, as tech giants and start-ups like Google and OpenAI build tools that can offer summaries of information and siphon traffic from news websites.

But the report found that consumers are suspicious about the use of AI to create news content, particularly for sensitive subjects such as politics.

According to the survey, 52 per cent of US respondents and 63 per cent of UK respondents said they would be uncomfortable with news produced mostly with AI. The report surveyed 2,000 people in each country, noting that respondents were more comfortable with behind-the-scenes uses of AI to make journalists' work more efficient."It was surprising to see the level of suspicion," said Nic Newman, senior research associate at the Reuters Institute and lead author of the Digital News Report. "People broadly had fears about what might happen to content reliability and trust."

Sri Lankan economy bounces back as inflation dips

COLUMBO.Sri Lanka on Monday hailed data showing the economy grew far more than expected in the first quarter, as the country continued its recovery from a crippling foreign exchange crisis. The 5.3 percent expansion in January-March marked an increase from the previous three months and was a huge improvement on the 10.7 percent contraction in the same quarter last year.It also topped forecasts of 4.0 percent in a survey by Bloomberg News.

Deputy finance minister Ranjith Siyambalapitiya said the government expected overall annual growth in 2024 to be about 2.2 percent."It is remarkable that we were able to achieve positive growth two years after facing the worst economic crisis ever," he said in a statement Official figures showed a sharp recovery in statement.Official figures showed a sharp recovery in the industrial sector, with an expansion of 11.8 percent in the first quarter, compared with a 24.3 percent contraction in January-March 2023.

The construction sector also showed improvement, as inflation came off a peak of 70 percent in September 2022 to 0.9 percent in May.Last week, the International Monetary Fund released \$336 million as part of a fouryear \$2.9 billion bailout for Sri Lanka, which defaulted on its \$46 billion foreign debt in April 2022. The peak of the economic crisis in 2022 saw months of food, fuel and medicine shortages after the island ran out of foreign exchange to pay for imports.

The resulting civil unrest forced the ouster of thenpresident Gotabaya Rajapaksa, when protesters stormed his residence. His successor Ranil Wickremesinghe has doubled taxes, withdrawn generous energy subsidies and raised prices of essentials to shore up state revenue.

India is an inviting market for those who build tech the right way: Tally MD

BENGALURU. India is a hard market but if you build technology correctly it is a very open and extremely inviting market, said Tejas Goenka, Managing Director, Tally Solutions. Homegrown accounting software major Tally, which is planning to launch its new releases soon, is also growing rapidly in international markets. Over the next several quarters, we will keep making more connections," Goenka said.

Talking about competition, Goenka said, "There has always been heavy competition and local competition is very large in India. I think for us we don't really look at the competition much. We have to always exceed the expectations of customers."The company is also making use of Artificial Intelligence. Speaking about it, he said, "It is a very strict rule that we will never ever take your (customers) data. For us, the AI story that we want to create is very different from what others are doing. Others are taking data and teaching the models. We have to build an experience that allows customers to use the power of AI, multiple use cases will be there, but we have to do it such that no engineer inside Tally can ever say I have seen the data. The model should be able to learn from customers' data and it should never ever move out of the scope of the customer's system."For Tally, Saudi Arabia is an up-and-coming market and in the next release, it got native Arabic version coming out as well. Goenka wants to make sure that Tally is continuously relevant to its customers and aims to launch innovative solutions for the market.

Zomato in preliminary talks to acquire Paytm's movie, ticketing business

Zomato confirmed in a stock exchange filing that it is in talks to acquire Paytm's ticketing business, but no final decision has been made.

NEW DELHI. Food delivery firm Zomato has confirmed that it is in discussions to acquire Paytm's movies and ticketing business, as per an exchange filing, putting an end to speculations."We acknowledge that we are in discussions with Paytm for the aforementioned transaction, however, no binding decision has been taken at this stage that would warrant a board approval and subsequent disclosure in accordance with applicable

law," said Zomato in the exchange filing. The above discussion is being undertaken with an intent to further strengthen our Going-out business and is in line with our stated position of focusing only on our four key businesses currently," it further added.Paytm also confirmed the discussions regarding the potential transfer of its entertainment business in an exchange filing, stating that all discussions are preliminary and non-binding at this stage.

If the deal goes through, it will be one of the largest buyouts for Zomato. Previously, Zomato acquired Uber Eats in 2020 and took over the quick commerce platform Blinkit (formerly known as Grofers) in 2021 in an all-stock deal valued at Rs 4,447 crore. This potential acquisition fits well with Zomato's goal to expand its

"Going-out" segment, which covers dining out, events, and entertainment services. By incorporating Paytm's movie and ticketing business, Zomato plans to offer a more complete service to its users, encompassing a broader array of activities and experiences. Budget 2024: Is tax relief on cards as government looks to boost consumption?

New Delhi The government is reportedly considering reforms to the current income tax structure, particularly targeting lower income levels, to boost consumption, reported The Indian Express. The report, quoting two government officials, suggests the budget announcement in July might prioritize tax cuts for low earners instead of increasing welfare spending.

These proposed tax cuts are intended to enhance disposable income, thereby stimulating economic activity and consumption. The report highlights concerns about the steep rise in marginal income tax rates under the new tax system.

Relief likely for low-earners

The officials noted that tax cuts may be more efficient in enhancing consumption, rather than increasing welfare spending. One of the officials quoted in the report said rationalising tax slabs will lead to greater disposable income, which translates to "greater consumption, greater economic activities, more GST collection". Currently, the tax rate begins at 5% for income starting at Rs 3 lakh, but escalates sharply to 30% for

income at Rs 15 lakh. This sixfold This budget will outline the economic increase in tax rate, despite only a agenda of the Modi 3.0 government, fivefold increase in income, is deemed excessive and in need of rationalisation.Implementing these tax cuts is expected to significantly boost consumption, a crucial factor for



reviving demand and restarting the investment cycle, particularly in consumer-driven sectors. This move could also lead to increased GST collections. As the budget for the fiscal year 2024-25 approaches, with a likely presentation in Parliament in late July, Finance Minister Nirmala Sitharaman is set to begin pre-budget discussions with industry groups around June 20, following a meeting with Revenue Secretary Sanjay Malhotra on June 18. focusing on stimulating growth without exacerbating inflation, while securing resources for coalition commitments. The overarching goal is to position India as a USD 5-trillion economy and transform it into a 'Developed India' by 2047.

The Reserve Bank of India (RBI) forecasts a 7.2 percent growth for the Indian economy this fiscal year, driven by improving rural demand and easing inflation. Key priorities for Prime Minister Modi's third term include addressing agricultural challenges, job creation, sustaining capital expenditure, and enhancing revenue growth to maintain fiscal consolidation. The economic policies of the past decade have been positively received, with rating agency S&P upgrading India's sovereign rating outlook to positive, and a potential further upgrade in the next 1-2 years contingent upon meeting fiscal deficit targets.Despite strong tax revenues, non-tax revenue remains a challenge due to limited progress in strategic disinvestment, with the sale of Air India being a notable exception.

Unlike other investment vehicles, contributions by Family Offices/Resident Individuals are considered Overseas Portfolio Investment (OPI). Family Investment Funds in GIFT City have a wide range of permissible investments and enjoy tax benefits, including a tax holiday on business income for up to ten years within a fifteen-year period, nil Minimum Alternate Tax (MAT) for domestic companies opting for a concessional tax regime, and a 10% tax rate on dividends paid to nonresidents.Is it important to set up a physical office in GIFT City?Lokesh Shah, partner with IndusLaw said, "It is mandatory to set up a physical office in GIFT City by FIFs. In order to set up FIF in GIFT City, one of the preliminary steps is to identify space and obtain a provisional letter of allotment for the office space.

Extreme heat melts diesel demand, sales drop 4 per cent in June

Fuel sales, which traditionally surge during polls, have defied the trend this year, falling month after month and the decline has now extended even after the end of the general elections.

NEW DELHI. India's diesel demand slumped in June as extreme heat conditions in parts of the country curtailed travel, preliminary data of state-owned firms showed on Monday.

Fuel sales, which traditionally surge during elections, have defied the trend this year, falling month after month. And the decline has now extended even after the end of the general elections.Petrol sales of three stateowned firms, which control 90 per cent of the fuel market, at 1.42 million tonnes in the first half of June was almost the same as 1.41 million tonnes of fuel consumed in the same period last year. Month-onmonth consumption dropped 4.6 per cent. Diesel sales dropped 3.9 per cent to 3.95 million tonnes during June 1 to 15 when However, this year has defied the trend.



compared with the year-ago period. The demand for the nation's most consumed fuel had fallen 2.3 per cent in April and 2.7 per cent in March.

In May it fell 1.1 per cent.

Besides electioneering, the summer harvest season as also the scorching summer that increases the demand for air conditioning in cars, should have led to a rise in fuel consumption.

Petrol and diesel prices were reduced by Rs 2 per litre in mid-March, ending a nearly two-year-long hiatus in rate revision, which should have also propelled sales.

Month-on-month petrol sales fell 3.6 per cent compared to 1.47 million tonnes of consumption during May 1-15. Diesel demand was flat month-on-month against 3.54 million tonnes in the first half of May.Diesel is India's most consumed fuel, accounting for almost 40 ner cent of all netroleum product consumption.

The transport sector accounts for 70 per cent of all diesel sales in the country.

It is also the predominant fuel used in agriculture sectors, including in harvesters and tractors. Consumption of petrol during June 1-15 was 4.6 per cent lower than in the first fortnight of June 2022, and 28.1 per cent more than in the Covid-marred same period of 2020.

Diesel demand slumped 10.5 per cent over June 1-15, 2022, and 14 per cent higher compared to June 1-15, 2020. Jet fuel (ATF) sales rose 2.3 per cent year-onyear to 331,000 tonnes during June 1-15, 2024.But, this was 4.5 per cent lower month-on-month when compared to 346,500 tonnes in May 1-15, the data showed.Like petrol and diesel, ATF demand, too, is now firmly above pre-Covid levels.ATF consumption was 10.1 per cent more than during June 1-15, 2022, and 6.1 per cent more than in June 1-15, 2020, as per the data. Cooking gas LPG sales were up 0.1 per cent year-onyear to 1.24 million tonnes in June 1-15, 2024.LPG consumption dropped 0.9 per cent as compared to June 1-15, 2022 and was 32 per cent more than June 1-15, 2020.Month-on-month, LPG demand fell 5.2 per cent against 1.3 million tonnes consumption during May 1-15, the data
