

Sanjay Kumar Morena, June 19: Four months after a married woman and her brother-inlaw eloped, their highly decomposed bodies were recovered from a car that got submerged in a stop dam in Morena district of Madhya Pradesh, police said on Wednesday. The car with their bodies was spotted, on Tuesday, by the residents of a village after the water level of the stop dam receded, they said. According to the police, the deceased woman, identified as Mithlesh (30), and her brother-in-law, Neeraj Sakhwar (34), were in love and left their homes in February."Their highly decomposed bodies were recovered from a car that was found in a stop dam built on the Kwari river in Gopi village," Sihoniya police station in-charge Dharmendra Gaur said."Every year, water is released from the stop dam

in order to clean it. After the water level receded, a car was seen in the middle of the stop dam when water was released from it on Tuesday afternoon," he said.A police team reached the spot after being alerted by villagers, who saw the car in the middle of the stop dam. They found that the highly decomposed bodies were that of a man and woman."During the probe, the police established the identity of the deceased. The woman, Mithlesh, was a sister-inlaw of another deceased Neerai Sakhwar. From the interrogation of their family members, it came to light that both of them were in love and fled from home on February ," he said.Mithlesh's husband Mukesh Sakhwar had complained that his wife had gone to the market and then eloped with his cousin Neeraj from there.



## Haryana in 10 years, says Bhupinder Hooda

Chandigarh, June 19: Leader of Opposition Bhupinder Singh Hooda today said that there was an outcry in the state due to a shortage of electricity and water, but the Bharatiya Janata Party (BJP) could not fulfil even the basic needs of the public, and hence had no right to remain in power. He claimed that during the Congress tenure, Haryana had become pwer surplus. "The state has many power plants and production capacity of its own and is capable of meeting the needs of the state," he said. "The BJP is not producing enough electricity from these plants. Many units are closed. Due to this, the state has to depend on private companies. No new plant was started in the past 10 years," he said. "Private companies take advantage of the shortage of electricity and sell it to the government at expensive rates. The payment is made by looting the hard-earned money of the common people," he added.

## Government raises paddy MSP by Rs 117 per quintal

New Delhi, June 19: The government on Wednesday raised the minimum support price (MSP) for paddy by 5.35 per cent to Rs 2,300 per quintal for the 2024-25 kharif marketing season, a move that comes ahead of key state assembly polls. The Rs 117 per quintal hike in paddy support price comes despite the government grappling with massive rice surpluses but it is significant ahead of elections in states like Haryana, Maharashtra, Jharkhand and Delhi. The MSP increase in the 14 kharif (summer) crops is the first major decision of Prime Minister Narendra Modi's third term in office and shows the government's "clear policy" to keep support prices at least 1.5 times the cost of production, Information and Broadcasting Minister Ashwini Vaishnaw said. Paddy is the main kharif crop. Sowing of kharif crops usually begins with the onset of the southwest monsoon in June. Announcing the MSP increase, Vaishnaw said the Cabinet has boosting farmers' income, the minister by Rs 191 to Rs 3,371 per quintal, while approved the minimum support prices said. The MSP for 'common' grade



for 14 kharif crops based on recommendations from the Commission for Agricultural Costs and Prices (CACP). The total financial implication from the MSP hike is estimated at Rs 2,00,000 crore, about Rs 35,000 crore higher than the previous season, significantly paddy has been raised by Rs 117 to Rs 2,300 per quintal, while for the 'A' grade variety, it has been hiked to Rs 2,320 per quintal for the upcoming kharif season, Vaishnaw told reporters. Among cereals, the MSP for 'hybrid' grade jowar has been raised for the 'Maldani' variety, it has been hiked by Rs 196 to Rs 3,421 per quintal for the 2024-25 marketing season (October-September). The support price for bajra has been increased by Rs 125 to Rs 2,625 per quintal, for ragi by Rs 444 to Rs 4,290 per guintal and for maize it has been increased by Rs 135 to Rs 2,225 per quintal for 2024-25. To reduce the country's dependence on import of pulses, the MSP for tur has been raised by Rs 550 to Rs 7,550 per quintal, for urad by Rs 450 to Rs 7,400 per quintal and for moong by Rs 124 to Rs 8,682 per quintal for the 2024-25 kharif marketing season. Similarly, the support price for sunflower seed has been raised by Rs 520 to Rs 7,280 per quintal, for groundnut by Rs 406 to Rs 6,783 per quintal, for soybean (yellow) by Rs 292 to Rs 4,892 per quintal for the upcoming kharif season. The support price for sesamum has been increased by Rs 632 to Rs 9,267 per quintal, and for nigerseed by Rs 983 to Rs 8,717 per quintal for 2024-25.

## 90-year-old killed in bomb blast in Kannur KANNUR : An elderly man was killed in a

blast when he unwittingly tried to open a steel bomb he found from his neighbour's uninhabited plot at Eranholi in Thalassery on Tuesday. The deceased, Velayudhan K K, 90, had gone there to collect coconuts. Velayudhan suffered fatal injuries to his head and his hands were shattered in the impact of the blast, the police said.

The house and the farmland where the blast occurred has been uninhabited for a long time. According to local residents, Velayudhan frequented the place to collect coconuts. The Thalassery police, who have launched an investigation, confirmed to TNIE that the blast was accidental."The victim is an old man. The incident occurred when he went there to collect coconuts. The bomb squad conducted detailed examination at the site and no other bombs were found from there," said a police officer with the Thalassery station. Senior police officials, including Kannur range DIG Thomson Jose IPS, visited the spot. The police said a special team will be formed to investigate the case. Velayudhan's body will be released to relatives on Wednesday after completing the postmortem, they said.Kannur has had a long history of country bomb attacks and related mishaps. ## **IISc researchers studying string** theory find new formula for pi



**BENGALURU:** Indian Institute of Science (IISc) researchers have accidentally stumbled upon a new finding -- a new series of representing the age-old mathematical formula of pi.While investigating how string theory can be used to explain certain physical phenomena, they found a new series representation for the irrational number pi.

Aninda Sinha, Professor at the Centre for High Energy Physics, IISc, one of the researchers of the study, told The New Indian Express that the new formula is different from the ones taught in schools

and colleges. The formula taught then has a never ending series of digits.He added that there have been many derivations of formulae over time. The formula the team has found is close to what was found by Indian mathematician Sangamagrama Madhava, which was written in the 15th century, in a poetic language.It is now universally accepted, and was the first ever series of pi recorded in history. Arnab Sinha was also a part of the new study at IISc, which is now published in Physical Review Letters. Sinha said they were studying high energy physics in quantum theory and were

working on developing a new model on how particles interacted and their accurate parameters. A new model was being developed when this finding happened.

A release from IISc said researchers were interested in string theory – the theoretical framework that presumes that all quantum processes in nature simply use different modes of vibrations plucked on a string. Their work was focused on how high energy particles interact with each other, such as protons smashing together.

What the team found was not only an efficient model that could explain particle interaction, but also a series representation of pi. In mathematics, a series is used to represent a parameter such as pi in its component form. Pi can be represented as a combination of many numbers of parameters (or ingredients). Finding the correct number and combination of the parameters to reach close to its exact value has always been challenging. The series found by IISc

researchers combines specific parameters in such a way that scientists can rapidly arrive at the value of pi, which can then be incorporated in calculations, like those involved in deciphering scattering of highenergy particles, the release said. Sinha said though the findings are theoretical at the moment, it is not impossible that they may lead to practical applications in future. "Doing this kind of work, although it may not see immediate application in daily life, gives the pure pleasure of doing theory for the sake of doing it," Sinha added.

## **Sterlite firing:** Madras HC says need to look into rights violations



CHENNAI: The Madras High Court on Tuesday stated that the issue does not end with payment of compensation to victims, even as it is laudable on the part of the government, but human rights violations have to be ascertained before proceeding further against revenue and police officials in connection with the police firing on anti-Sterlite protestors in Thoothukudi in 2018. A division bench of justices SS Sundar and N Senthilkumar made the remarks while hearing a public interest litigation petition filed by People's Watch executive director Henri Tiphagne, seeking a direction to the National Human Rights Commission (NHRC) to reopen the probe into the firing which took the lives of 13 protesters. The court had impleaded then Thoothukudi collector N Venkatesh, three revenue department officers and 17 police officers including then IG (south zone) Shailesh Kumar Yadav, DIG Kapil Kumar C Saratkar and SP Mahendran in the previous hearing, and directed them to file counter-affidavit.

Objecting to certain submissions by additional advocate general J Ravindran, appearing for the state, the bench said that the state's interest is well protected if it does not open its mouth. "We get the impression that you seem to be more interested in not serving the interests of the public," the bench stated. The bench further stated that the matter does not end with compensation to the victims and the question is whether human rights violations were committed or not, adding that if there were violations, and if the bench made some observations, the parties concerned (impleaded officers) must be heard because such observations may affect them. The counsel for CBI informed the court that an additional charge sheet has been filed, after holding further investigation, before the special court in Madurai as per the orders of the court which had rejected the original charge sheet. The bench adjourned the hearing to July 1.

## **NEET-UG 2024: Calls for transparency, state** control amid allegations of malpractice

VIJAYAWADA: The alleged malpractices in the conduct of the NEET-UG 2024 exam have raised significant concerns among students and parents, affecting both top performers and those who qualified. The controversy began with the awarding of grace marks to 1,563 students and escalated due to allegations of a paper leak.As counselling dates approach, tension among students is increasing daily, especially since the Supreme Court postponed the case hearing to July 8. The controversy continues to evoke diverse opinions and calls for action to ensure transparency and fairness in medical admissions across India. Previously, the purview of the conduct of entrance examinations was under State government jurisdiction, but the Central government's decision to conduct nationwide NEET has faced opposition from States like Tamil Nadu.B Jahnavi from Visakhapatnam, who secured 326 marks, demanded the release of the list of



1,563 students who benefitted from the grace marks allocated by the National Testing Agency (NTA). She emphasised that the re-exam, scheduled for June 23, must be conducted by another agency instead of NTA for all 1,563 students without any clauses and appealed that no grace marks should be added in the future for any reason.Jahnavi accused the NTA of concealing information to protect themselves and alleged that fraud had

re-exam within the time given by the NTA, given that the exam is scheduled for June 23 and the results are tobe announced on June 30.Speaking to TNIE, Member of Legislative Council (Krishna-Guntur Teachers Constituency ) KS Lakshmana Rao emphasised India's federal structure and criticised the Centre's control over the education system. He supported conducting examinations like NEET at the state level and echoed Tamil Nadu's demands. Rao called the situation a failure of the Centre and National Testing Agency (NTA), urging a thorough investigation into the allegations and advocating for a possible re-conduct of NEET to ensure fairness for talented students, following the Supreme Court's directives.Dr AN Radhakrishna Yadav, a Professor in Pediatric Dentistry, expressed deep concern for the 24 lakh

Yadav urged State governments to take a firm stance against such irregularities and recommended considering a reexamination to uphold integrity. Speaking to TNIE, AP Medicos Parents ssociation State President Dr Ala Venkateswarlu dismissed the possibility of a NEET reexam due to students' unwillingness to go through the labour of preparing for one of the toughest exams in India.Stating that the alleged malpractices in conducting Neet in other States have affected the students across the nation, particularly the students of Telugu States, Venkateswarlu proposed cancelling the national pool of 15% this year to prioritise local talent. This move would reserve the national quota of 400 medical seats in Andhra Pradesh to State rankers.Pointing out anomalies in the exam results where 67




## **Cloud changes linked to frequent lightning**

## THIRUVANANTHAPURAM: Once The southwest monsoon this year is

confined to specific months, lightning has become a year-round occurrence in Kerala, including during the monsoon season, mainly due to shifts in cloud structure and extended dry periods. This monsoon, lightning strikes have already claimed four lives, two each in Thrissur and Kollam, in the state.Experts attribute the increased occurrence of lightning to the frequent presence of Cumulonimbus clouds, heavy and dense cloud of considerable vertical extent, during the monsoon.Rajeevan Erikkulam, a meteorologist with the Kerala State Disaster Management Authority (KSDMA), said the frequency of lightning increases in the break period during the monsoon.

characterised by longer breaks interspersed with shorter active spells. Notwithstanding the prediction of an above-normal rainfall, the state has recorded a rainfall deficit so far this season."Earlier, Cumulonimbus clouds were seen during pre and post-monsoon periods only. Monsoon is characterised by stratus clouds. However, this structure seems to have altered in recent years," Rajeevan said, while also highlighting recent studies, especially by the Cochin University of Science and Technology, on the presence of Cumulonimbus during monsoons. "After a longer break period, winds carrying rain-bearing clouds are expected to get stronger from June 21," he



said

The India Meteorological Department (IMD) has declared an orange alert in Malappuram, Kozhikode and Kannur on the day. The state gets more lightning during pre-monsoon period between April and May and during the northeast monsoon season starting from October."Kerala is one of the major states

affected by lightning though deaths due to it have declined owing to better awareness and development," said a hazard analyst, who did not wish to be named.

He said casualties of lightning strikes in Odisha and West Bengal are higher as more people work in fields."In Kerala, pucca houses, tall trees and fewer field activities have prevented a high number of casualties. However, construction

workers, MGNREGA workers, and painters are a risk category," he said. A study by National Centre for Earth Science Studies in 2016 said earlier, over 70 people died of lightning each year. In 2015, the Kerala government classified lightning as a statespecific disaster.

## Factory gets land to shift, key NH-8 link may finally be ready

Gurgaon. HSVP has agreed to provide alternative land to an auto parts factory that had held up the construction of a crucial road linking NH-8 to new sectors for almost a decade. While the rest of the road has been constructed, just around 190 metres is left to be laid. Once complete, it will provide direct access from NH-8 to Pataudi Road and Sultanpur Lake via sectors 82-89.Earlier, the private company, whose manufacturing unit is spread across 1,500 sq yds, had approached the high court. But the court asked both parties to find an amicable solution. HSVP then prepared an exchange proposal offering alternate land, which has recently been approved by the state govt. An official from HSVP confirmed the development and said they will hand over possession of the land to GMDA soon so that the road can finally be completed. "The exchange proposal has been approved by the govt, and we are in the process of completing all necessary legal formalities. This should be finalised within a month, after which land will be handed over to GMDA for construction of the missing link," said Vikas Dhanda, HSVP estate officer-1.

- GMDA said construction would be "taken up promptly" once the plot is handed over. "The road dividing sectors 88 and 89 is not connected to Pataudi Road because of the acquisition dispute. As soon as we receive possession, we will construct the remaining portion of the 60m-wide road. This will further improve connectivity in new sectors," a senior official from the metropolitan authority said.
- Residents and commuters welcomed the move, saying the road is crucial for reducing travel time and enhancing access between key sectors and Pataudi Road."This road has been lying incomplete for so long. There is a dead end on the road dividing sectors 88 and 89, and we are either forced to drive on an adjoining unpaved stretch to reach Pataudi Road or get stuck in traffic jams at the roundabout near Aarvy Hospital. The unpaved stretch is unmotorable during rains, as the area gets muddy and slippery. We are happy that the issue is finally getting some resolution. 

# Transformers added, yet 12 of 71 Gurgaon's substations overloaded

GURGAON.Twelve of the city's 71 substations, including two with a capacity of 220kV, are overloaded and have been the prime reason for recurrent outages in the city. None of these substations were overloaded last year. This time, however, the city has seen a 60% to 80% rise in power demand compared to the same period in 2023, and the surge has put a strain on the existing infrastructure, causing frequent power disruptions.To mitigate the issue of overloading, Haryana Vidyut Prasaran Nigam Limited (HVPNL) has decided to install additional transformers. In the past two months, around 150 transformers have been installed to deal with the additional load. But these measures have been insufficient to meet the growing power demand, resulting in many parts of the city facing power cuts lasting up to four hours daily. The overloaded substations cater to areas such as Vipul World, Mayfield Garden, Sushant Lok, Ardee City, Malibu Towne, sectors 10A, 22, 23, 45 and 46, Sohna Road, Palam Vihar, Old Gurgaon, and sectors along Dwarka

Expressway and Southern Peripheral Road.Ajay Kaura, a resident of Sector 23, said they are facing frequent power cuts and not getting any response from the discom. "All calls to the discom's customer care, linemen, and power officials are going unanswered. The recurrent power outages are disrupting daily life. People are falling sick due to the weather," said Kaura.Abhilash Chetia, who lives kaura. Aonitasii Cheua, who hyves in Palam Vihar, said the heat is already unbearable and power cuts are making the situation worse. "We are facing several hours of power cuts daily, yet there is no confirmation of work even being started to address this issue. This is the situation of Millennium City," he

said.iscom officials, meanwhile, are having a hard time dealing with consumers' grievances. "Our phones never stop ringing; we are on our toes all the time. We are doing all that is in our capacity to ensure power supply, but still face the anger of residents," a DHBVN



official said. The discom said it is closely monitoring the load at all substations round the clock and has sufficient power supply. "As a precautionary measure, whenever the load increases beyond a point that could potentially damage the substation, we have to resort to cutting power supply for a few hours to prevent any long-term damage to the infrastructure," the official added. While these temporary measures are helping manage the immediate crisis, there is a pressing need for a more comprehensive and long-term solution to address the root cause of the problem. The official said after summer, they will have to go back to the drawing board to make a fresh plan for the upgrade of power infrastructure, considering the increasing power demand. The city requires more substations due to the development of new sectors and the increase in the population of the existing

areas. According to DHBVN, there is a need for new substations in Pataudi and sectors 5 and 29. While construction of a substation in Sector 29 is a future requirement, substations will be needed in the next few years at Sector 5 and Pataudi, but availability of land is an issue in both areas, officials said

According to the state higher education department, there is a requirement of 8,843 posts.

## Pvt company fails to sweep roads, MCG goes to police

Gurgaon: Days after chief secretary TVSN Prasad declared a solid waste management exigency in the city, an FIR has been filed against a private agency given the contract to sweep roads and ensure cleanliness in some parts of city.

In his complaint to police, MCG senior sanitary inspector Devinder Kumar accused the private firm of neglecting their responsibilities in sweeping the designated areas or providing efficient services as per their contract with the corporation. The corporation awarded the contract for sweeping roads, cleaning drains and uprooting bushes in zones 1A and 2B to the firm last Aug.Moreover, the company failed to deploy sufficient manpower and resources to carry out the sweeping tasks effectively, which led to its inability to maintain cleanliness in the assigned zones, the complaint said. According to the civic body, the agency is also not dumping waste after manual sweeping at the designated sites, which is also a violation of the contract.

We have served multiple notices to the firm and imposed a penalty on it. The areas that fall under the agency's jurisdiction for sweeping have mounds of garbage and the drains in these areas are also blocked with trash," an MCG official said. ## The sun staring at them, they scale up poles to fix faults

Noida.With daytime temperatures refusing to come down from the upper levels of 40s, overheated power equipment is leading to voltage fluctuations and tripping and forcing discom officials to resort to outages, TOI has learnt after speaking to several linemen.Outages continued in several areas of the twin cities of Noida and Ghaziabad on Tuesday, when the mercury touched 46 degrees Celsius. In Ghaziabad, power cuts were reported in Vijay Nagar, Sudamapuri, Siddharth Vihar and so on.

- Residents of Gaur Siddhartham said they had no power since Monday night.Rajesh Kumar, junior engineer at Abhay Khand 1, agreed the feeder had tripped because of overheating. Earlier, a shutdown was taken because of a fire on a pole in Makanpur Vistar area," said Kumar. The situation in Noida wasn't any better. Outages were reported from sectors 55, 56, 71, 122, 50, 117 and 104 and more, with officials blaming them on overheating of the supply network.
- Officials said when the system heats up beyond capacity, it either trips on its own or they have to resort to 'rostering'. In both cases, houses plunge into darkness — which can range from 3 minutes to an hour."Line workers and engineers have been working day and night to supply power to consumers. In this scorching heat, transformers have even been exploding because they are overloaded. There are faults in cables too," said an official of the power department. With the sun blazing with all its might, the linemen have a tough job at hand. "When the mercury is hitting 46-47 degrees Celsius in some parts, they still have to climb up iron poles, which are boiling hot. Some of them even get blisters in their hands," the official added.Neeraj Kashup, a lineman working in sectors 19 and 27, described it as a professional hazard.



## **US Secret Service agent** robbed at gunpoint during **Biden's Los Angeles trip**

World . A Southwest Airlines flight came within 400 feet of crashing into the Pacific Ocean off the coast of Hawaii after pilots were forced to change course as they were unable to see the runway due to unfavourable weather conditions.Passengers travelling on the Boeing 737 Max 8 aircraft from Honolulu International Airport to Lihue Airport in Kauai had their hearts missing the beats when the plane dropped from an altitude of 16,000 feet to 409 feet. The incident occurred on April 11 when the pilots were forced to abort a landing attempt after bad weather blocked them from seeing the runway, according to a Southwest Airlines memo to pilots accessed by Bloomberg. The first officer, who is less experienced, "inadvertently" pushed forward on the control column, which controls the plane's pitch and roll, then reduced the speed, causing the flight to lose altitude and descend rapidly. According to the memo, the captain opted to put the first officer in command of the 100-mile flight despite the adverse weather. The captain ordered the first officer to increase thrust, which resulted in the plane "climbing aggressively" at 8,500 feet per minute.

Amidst this, an alarm on the warning system was sounded to signify that the aircraft was coming very close to the terrain due to the pilot's aggressive movement. The flight, which was to be completed in around 22 minutes, left Honolulu at 6:45 pm (local time) and returned to Hawaii's capital again at 8:09 pm after the incident. Nobody suffered any injuries during the whiteknuckling ride. A Southwest Airlines spokesperson told Fox News Digital in a statement that the issue "was being addressed appropriately"."Nothing is more important to Southwest than safety. Through our robust Safety Management System, the event was addressed appropriately as we always strive for continuous improvement," the spokesperson said. The Federal Aviation Administration, the US's civil aviation agency, told Fox News Digital that it was "investigating the incident". This came after a similar incident involving a United Airlines flight occurred off Maui on December 18, 2022. The plane, a Boeing 777-200, plummeted to 775 feet above sea level from 2,200 feet for almost 20 seconds after it took off from Maui

## Vladimir Putin meets Kim Jong Un in first visit to North Korea in 24 years

Russian President Vladimir Putin arrived in North Korea early on Wednesday, after saying the two countries want to cooperate closely to overcome U.S.-led sanctions in the face of intensifying confrontations with Washington.Putin was met at Pyongyang's airport by North Korean leader Kim Jong Un. They shook hands and embraced, and Kim later joined Putin in his car to personally guide him to Pyongyang's Kumsusan State Guest House, North Korea's official Korean Central News Agency said. The agency described their meeting as a historic event that demonstrates the "invincibility and durability" of the two nations' friendship and unity.
- Putin, making his first trip to North Korea in 24 years, said in comments that appeared in its state media hours before he landed that he appreciates the country's firm support of his military actions in Ukraine. The Kremlin launched a full-scale invasion of the neighboring country in 2022. He said the countries would continue to "resolutely oppose" what he described as Western ambitions "to hinder the establishment of a multipolar

## 550 Haj pilgrims die amid scorching heat in Mecca, mercury rises to 51 degrees Each year, tens of thousands of pilgrims

**Riyadh.** Diplomats on Tuesday said at least 550 pilgrims died during the Haj, underscoring the grueling nature of the pilgrimage which again unfolded in scorching temperatures this year.

At least 323 of those who died were Egyptians, most of them succumbing to heat-related illnesses, two Arab diplomats coordinating their countries' national meteor responses told AFP."All of them (the **HEAT STRESS** Egyptians) died because of heat" except for one who sustained fatal injuries during a minor crowd crush, one of the with Saudi authorities on search diplomats said, adding the total figure came from the hospital morgue in the Al-Muaisem neighbourhood of Mecca.At least 60 Jordanians also died, the diplomats said, up from an official tally of 41 given earlier on Tuesday by Amman. The new deaths bring the total reported so

far by multiple countries to 577, according to an AFP tally. The diplomats said the total at the morgue in Al-Muaisem, one of the biggest in Mecca, was 550. The Haj is one of the five pillars of Islam and all Muslims with the means must complete it at least once.

Washington. Indian-American Suhas Subramanyam has won the Democratic primary for a Congressional seat in Virginia, defeating 11 other candidates, including fellow Indian-American Krystle Kaul.The first Indian-American, South Asian and Hindu to be elected to the Virginia General Assembly in 2019 and to the Virginia State Senate in 2023, Subramanyam was running for the US House of Representatives from the 10th Congressional District of Virginia, which has a sizable Indian-American population.Its current occupant, Democrat Congresswoman Jennifer Wexton, announced last year that she would not be running for the



seat.Subramanyam, 37, was born in Houston to Indian-American parents who migrated to the US from Bengaluru. In 2015, he was appointed by then-President Barack Obama to serve as a White House technology policy advisor.Wexton had endorsed Subramanyam, who now faces Mike Clancy from the Republican Party.

**Singapore** A court in Singapore has sentenced an Indian-origin man to five weeks in jail for punching a Singapore police officer in an inebriated state while arguing in a rowdy crowd of over 10 men.

The single punch was so powerful that it knocked the officer unconscious "for at least a minute" and caused him to suffer temporary memory loss, according to a report by TODAY newspaper.

On Tuesday, Devesh Raj Rajasegaran, 24, was sentenced to five weeks in prison. He had pleaded guilty in March this year to one count of voluntarily causing hurt.Devesh will appeal against the sentence, according to the report.

The court heard that the victim was one of four police officers dispatched to an area in Circular Road in the central business district on June 25, 2022, after a member of the public informed them around 3 am of "more than 10 people having an argument". Prior to this, Devesh and his friend Eeshwar Ravi were drinking alcohol nearby.

When the police arrived, they spotted a group of individuals, including Devesh and Eeshwar, involved in a "commotion" in Circular Road.

The officers, who were wearing civilian clothes at the time, approached the group, identifying themselves as police officers. Three of them were volunteer police officers.While the victim and another officer were interviewing a member of the group, Devesh approached them to confront

The hotel offers a wide range of beverages, including single malt Scotch whiskies and Armagnacs, with some bottles priced up to \$5,100.At one point, just before closing, somebody got up to go to the bathroom and left his drink on the table. When the guy came back, Justin was drinking his drink," an insider told The NY Post. "The guy goes, 'Justin, that's my drink!""It remains unclear what exactly the singer was drinking or what he accidentally sipped from the other person's drink.

U.S. Secretary of State Antony Blinken, in a recent visit to Israel, said he was working around the clock to end the delays.

## Why G7 needs allies like India

PRIME Minister Narendra Modi's presence as an outreach guest at the G7 summit in Italy is a useful backdrop for the launch of the new government's foreign and security policy. The G7 meeting has brought out just how fragile the world order is these days. India occupies a unique position here as an oasis of political and economic stability, but it cannot but take into account the turbulent waters that are washing its shores.

The political situation in four of the G7 nations appears brittle — the US and the UK are going to the polls amid uncertainty, while Germany and France are witnessing the rise of right-wing forces. Two of the big world powers are, of course, entirely out of the G7 process, which purports to promote democracy. But those two, China and Russia, are making major efforts separately and collectively to challenge the G7's purported global hegemony. The presence of Îndia, Turkey, Brazil and some other countries is an acknowledgement that the G7 needs allies to manage issues relating to migration, climate change, economic competition with China and the wars in Ukraine and Gaza. In turn, these countries are seeking to persuade the G7 nations, which are increasingly economically and demographically challenged, on the need for more equity and balance in global decisionmaking.In all this, Modi's central challenge and opportunities are in India's neighbourhood and beyond. While continuity has been the central message that the BJP-led NDA government has sent out, there will be inevitable changes arising from the very fact that the General Election has shifted the national political paradigm.

The presence of leaders from Bangladesh, Bhutan, Nepal, Sri Lanka, Maldives, Mauritius and Seychelles at the swearing-in of the new government speaks for itself, as does the fact that the leaders of Myanmar, Pakistan and Afghanistan were not invited. India's relations with those invited are fairly even, even though we face challenges in Nepal, Sri Lanka and the Maldives. The participation of Maldives President Mohamed Muizzu was significant because of our strained relations with the island republic. The Indian strategy of riding out the Chinese challenge in the neighbourhood was most visible last year when Sri Lanka faced a financial crisis. China played hard to get, but New Delhi immediately provided humanitarian and financial assistance of \$4 billion, surpassing even the International Monetary Fund's (IMF's) 48-month bailout package of \$3 billion. By providing financial assurances, New Delhi also shored up Sri Lanka's IMF process. The absence of Pakistan, whose then Prime Minister Nawaz Sharif had attended PM Modi's 2014 swearingin, has its own story of just how sharply India-Pakistan relations have deteriorated, even though the government in power is that of the Pakistan Muslim League (Nawaz), albeit in a coalition.

India says it emphasises its Neighbourhood First policy as well as SAGAR (Security and Growth for all in the Region) for the Indian Ocean Region (IOR). It has China very much on its mind. Whatever may be the military challenge India confronts along the disputed border, the one it faces from China in South Asia and the IOR is equally significant and has implications for the geopolitical future of the region. China, too, is a neighbour and, it too, was not present. In an interview to Newsweek on the eve of the General Election, Prime Minister Modi had noted that there was a need to "urgently address the prolonged situation on our borders so that the abnormality in our bilateral interactions can be put behind us." Last week, speaking in Mumbai after taking charge of the Ministry of External Affairs for a second term, S Jaishankar said India would focus on finding solutions to the border issues that had bedevilled their relationship. American ties with New Delhi are on a high after Modi's Washington visit last June. While US elections could disrupt some of the bonhomie, they are unlikely to lead to any major change. But managing ties in a potential Trump presidency will definitely be a strain, though the Gurpatwant Singh Pannun issue is unlikely to create major problems. The American focus, regardless of who wins, is likely to be China, though there is a danger that another US-China tariff war could affect us in the form of collateral damage.

## Agnipath, other questionable schemes under scrutiny

### The adage that a soldier is never off duty was applied literally by the ruling party to boost its political prospects and force-multiply its message via the country's soldiery.

THE advent of a genuine coalition government has kindled hope among a cross-section of defence veterans and security analysts regarding a salutary makeover of some questionable schemes and directives imposed upon the military by the political leadership over the past decade.

The foremost among these is the Agnipath scheme, launched in mid-2022, to recruit

personnel below officer rank (PBOR), known as Agniveers, for a limited tour of duty (ToD). The Janata Dal (United), a critical constituent of the National Democratic Alliance, has demanded a review of the scheme amid public disaffection with it in Bihar and other states. According to reports, the government has tasked a group of secretaries from 10 ministries to review Agnipath and suggest ways to make the recruitment programme more attractive.Under Agnipath, PBOR are being recruited for all three services for a four-year ToD, following which just 25 per cent of them would be retained to complete 15 years of military service. The remaining 75 per cent — the demobilised Agniveers - would reportedly be provided employment in the paramilitary, state or railway police forces or other attendant security

agencies. Public sector banks and insurance companies and other associated state-run financial organisations, too, would be called upon by the government to absorb these disbanded soldiers, airmen and sailors, each of whom would receive around Rs 12 lakh, tax-exempt, as their severance pay.Meanwhile, a series of directives from the Ministry of Defence (MoD) to the armed forces, which triggered unease within the services as well as among veterans, are likely to be reassessed or quietly abandoned.

One such was the mandate issued last May by the Army headquarters at the MoD's behest, requiring all soldiers on home leave to promote 'nation-building' endeavours in their respective village, town and city neighbourhood communities by publicising the merits of government welfare schemes like Swachh Bharat Abhiyan and Sarva Shiksha Abhiyan. The scheme was to be monitored by the soldiers' individual units through a quarterly feedback, supported by photographs and video clips.

Additionally, these 'soldier ambassadors' were directed by the Army's Ceremonials and Welfare Directorate, which functions under the Adjutant General's office responsible for the forces' overall administration — to instil patriotism and nationalism in their respective circles, motivate and mentor the youth and organise In its directive, the MoD had declared that these 'selfie sports events for them.Senior military officials said the Army Training Command in Shimla had issued guidelines for these soldiers to follow with regard to these 'educative' tasks with the aim of 'leveraging' their skills and innate discipline towards augmenting nation-

building. Senior veterans had estimated that at any given time, the armed forces would have 3,50,000 'social warriors' engaged in this government-led mega publicity drive. All soldiers are entitled to two months' leave annually, in addition to 30 days of casual leave, but for now it remains unclear how successful this scheme has proved to be.At that time, many veterans had said that this scheme had been foisted upon the services, its instructions framed by the MoD to make it appear voluntary to ward off protests and court cases. The PIB went on to state that Udbhav was a "visionary initiative by the Army seeking to integrate age-old wisdom with contemporary military pedagogy", in addition to enhancing "strategic thinking, statecraft and warfare". In short, Udbhav, according to the government, was poised to "foster deeper understanding of military matters and contribute to enriching military curricula".

Regrettably, it was left to veterans, albeit sotto voce, to flag these political and contentious enterprises, and to those still in service to implement this publicity blitzkrieg. Perhaps after the recent electoral verdict, both domains will breathe somewhat easier.

> passenger trains on the Howrah-Chennai line in Andhra Pradesh's Vizianagaram district had claimed 14 lives; in February this year, a freight train ran driverless for about 70 km from Kathua (Jammu) to Dasuya (Punjab) - it was just a stroke of luck that no major accident happened.

The spotlight is back on Kavach, the 'train collision avoidance' system aimed at preventing accidents due to human error. It is being implemented in a phased manner but the pace of route coverage is rather slow - in stark contrast to the government's emphasis on speed on the rail tracks. Prime Minister Narendra Modi and his Japanese counterpart Fumio Kishida have pledged to expedite the bullet train project, but the Bengal mishap has shown that safety must

## **Clean up NEET to restore public confidence**

The National Testing Agency must live up to expectations and, together with the Centre, take immediate remedial measures that reassure all stakeholders.

IN an article published in The Tribune (August 5, 2023), I had argued that the NEET (National Eligibility-cum-Entrance Test) system was a desirable and essential piece of reform, but it required fine-tuning. The recent controversy surrounding NEET-UG 2024 underscores the urgency for improvement, though it points only towards the mishandling of the NEET exam and not the redundancy of the system itself. The issue is now before the Supreme Court. We must realise that an exercise that borders on the sacred for our students and their parents must be executed flawlessly and in a manner that inspires the highest measure of confidence in the system. Events such as those that have transpired this year erode confidence in the system and demoralise students.NEET was introduced to bring about transparency and meritocracy in the admission system. Genuine concerns had been raised about the earlier admission system adopted by some private medical institutions being opaque and dishonest. Evils like capitation fees had tainted the system. Besides, candidates were forced to undergo multiple entrance examinations across the country to maximise their chances of getting admission to one medical college or another. A single nationwide examination like NEET was necessary to address this.

Unsurprisingly, this much-needed measure of reform was resisted by some. NEET, though initially planned in 2010, could not be implemented for a year or so on account of perceived flaws in its initial notification. It was only in 2012 that the Medical Council of India, in consultation with the Union Government, properly notified it. The exam could not be conducted that year since students did not have enough time to prepare. Before it could be rolled out from the next year onwards, the apex court intervened. The notification of the exam was set aside by a three-judge Bench with a 2:1 verdict. The court was approached to review and reconsider its decision. Ultimately, it reversed the decison and allowed NEET to be implemented.

This landmark ruling paved the way for a major verhaul of

the medical admission system in India. The NEET system could finally be put in place. Wider consultations with stakeholders and state governments had also brought out the need to hold NEET in local languages in addition to English. This was important to ensure equity among students coming from different regions. Of course, it was visualised by the policymakers that once NEET was rolled out, improvements would be made whenever necessary.

Over the years, the conduct of NEET has, more or less, been free from controversy. In this backdrop, this year's events are unfortunate. It is vital that all issues that have arisen be resolved as soon as possible. The National Testing Agency must live up to expectations and, together with the Central Government, take immediate remedial measures that reassure all stakeholders. Honesty, transparency and accountability in the admission process ust be seen and felt as

having been restored. If there are any systemic issues that call for change, those must not be swept under the carpet They must be urgently and constructively addressed.

One oft-debated area of concern is whether a multiplechoice question (MCQ)-based examination is the best method of selecting medical students. A related and valid criticism is that this format of examination has resulted in the mushrooming of private coaching academies to prepare students for the high-level competition. These academies are prohibitively expensive and concentrated in tier I and tier II cities and towns. As a result, students whose families cannot afford to pay such high fees are deprived of this valuable training tool. Urban students are able to gain an unfair advantage over their rural counterparts, who may lack easy access to coaching academies. There is a widespread belief that without the benefit of coaching in



these expensive academies, it is very difficult to compete for admission to medical colleges. Many meritorious students from a poor or rural background thus feel handicapped.

Additionally, students begin to ignore their Class XII board exams, where a 50 per cent score is sufficient to be eligible for taking NEET. Consequently, students do not take their Class XI and XII studies or exams seriously, losing out on the development of analytical and scientific skills. I am shocked to learn from some students that many of their classmates join such academies and don't attend classes at school. It appears that some schools are keen to certify them as regular students so as to allow them to sit in the Class XII board examination.Some alterations to the current system must be considered. The NEET question papers could include questions framed on the basis of the state board syllabi, so that an equal opportunity is available to

students from all regions. Welldesigned MCQs, which can assess the intellectual capacity of our students and not merely their rote learning, must be introduced. The emphasis needs to be on evaluating the mental ability, quality of reasoning, depth of knowledge and analytical thinking.

It will also be helpful to attach some weightage in the medical admission process to the Class XII board examination score. This may motivate students to undertake a more broadbased learning approach and reduce the importance of coaching institutes focusing only on rote learning and mastering multiple-choice questions.Policymakers should examine the possibility of a hybrid system for undergraduate medical admissions, with weightage for the NEET score (say 50 per cent) and the

balance weightage for the score in the Class XII board examination or other similar (objective and transparent) performance criteria. This approach may not be met with much objection as far as the state quota seats are concerned. However, in view of the differing standards and the evaluation process across different states, it may be less than ideal for the all-India quota seats and Central institutes like AIIMS unless some system of equalisation or normalisation is put in place to be applied to various education boards.

NEET was an essential step in the right direction. The present controversy has impacted its credibility. Necessary action must be taken immediately to restore public confidence. Politicisation of the issue must be avoided at all costs. We cannot afford to return to the old ways of doing things. The very future of our young citizens is at stake.

## Nalanda University: Then and Now **A 1600-year transformation in pics**

Nalanda University was established in 450 CE by **Gupta Emperor** Kumaragupta I. Later, it also received patronage from Harshavardhana and the Pala rulers. According to legends, invaders destroyed this university in the 12th century. Before that, this ancient institution had been providing education for approximately 800 years.

New Delhi:Established around 450 CE by Gupta Emperor Kumaragupta I, Nalanda University was a beacon of learning in ancient India. Nestled in the heart of Bihar, this institution was not just a university but a monumental centre of education, attracting scholars from across the globe. Over time, it garnered the patronage of prominent rulers like Harshavardhana and the Pala kings, which allowed it to flourish for centuries. Prime Minister Narendra Modi on Wednesday inaugurated the new campus of Nalanda University, worth Rs 1700 crore. This marks

his first official visit to the state since being sworn in for a record third term as Prime Minister.PM Modi in his address expressed his pleasure at visiting Nalanda University within just 10 days of beginning his third term as Prime Minister. He emphasised that Nalanda represents more than just a name; it embodies identity, reverence, and enduring values. Regarded as the second-oldest university in the world after Takshashila, it served as a residential campus and existed for 800 years.Nalanda University was

Last year, the LDA, citing illegal construction on Kukrail's riverbed and banks, told the Allahabad High Court that the Kukrail water channel be kept clean. The authority told the court that slum dwellers, over a long period of time, have unauthorisedly occupied the banks of the Kukrail water channel. All the drains of the slum, containing its waste (such as fecal matter) were let loose in the Kukrail water channel, which flows to the river Gomti, it said.

Vinod Barara, who ran a computer institute, was married to Nidhi and the couple had a daughter. They lived in Haryana's Panipat.However, things took a turn in their life after Nidhi fell in love with her gym trainer, Sumit, and an affair started. Vinod soon got a whiff of their affair and confronted his wife. The issue led to frequent arguments between the couple.Nidhi, unable to take the daily altercations,

plotted to kill her husband with Sumit. The duo gave contract to Dev Sunar of Punjab to kill Vinod by crushing him under his truck. Sunar was paid around Rs 10 lakh in cash for the hit job.However, Vinod managed to survive

5, 2021, even though he suffered serious injuries.Desperate to get Vinod killed, Nidhi then activated plan B and asked Dev Sunar to shoot her husband. Around two months after the accident, Sunar barged into Vinod's home and shot him



dead at point-blank range.Sunar was arrested and he confessed to the crime. He claimed that he killed Vinod as he refused to reach an out-of-court settlement. While Sunar was in jail, Nidhi and Sumit

The messgae was sent by Vinod's brother Pramod, who stays in Australia. The police formed a team and started looking into Sunar's call details. Police found that Sunar was constantly in touch with Sumit.As police started to dig deep, they found several calls were made by Sumit to Nidhi, Vinod's wife. Some of the calls were of long durations.Sumit was taken into custody by police and he eventually confessed that he got Vinod killed on the orders of Nidhi.



While it cannot compete with Sultanahmet Mosque in size, it's the grandeur that astonishes visitors. With its finely decorated interior, it looks more like a Beaux Arts Parisian residence than a mosque.

#### **Istiklal Street**

Istiklal Street, the main arterial road of Istanbul, is a 1.3-km-long avenue in the heart of the European side of the city, the Beyoglu (Pera) district. It connects Taksim Square all the way down to Tunel, one of the oldest metro stations in the world used since 1875, located not far away from Galata Tower. Its name translates to Independence Avenue, which was given after the birth of the Republic of Turkey in 1923.

The architecture is a variegated mix, including late Ottoman houses to Art Nouveau buildings and Neo-Gothic residences. While exploring the main avenue and its alleys, you will see mosques as well as Catholic, Armenian and Greek Orthodox churches existing side by side. A not to be missed highlight is Cicek Pasaji (Flower Passage), a beautiful gallery built in European style. However, its most distinctive feature is probably the historical

tram making its way through the crowds of people on the pedestrian avenue. Sitting, eating and relaxing are some of the favourite activities that can be done on Istiklal Street, but many still prefer to go shopping and browsing fashion outlets, vintage shops, fancy bakeries and musical records.

Walking the length of Istiklal Street can sometimes be intimidating because of the massive presence of police at every corner that is ready to take action against any possible revolt.

#### Suleymaniye Mosque

Dominating the skyline of the Sultanahmet area at the entrance of the Golden Horn, Suleymaniye Mosque was built on top a small hill on the order of Sultan Suleyman and completed in 1558. It was built by the famous architect Mimar Sinan, and later served as a reference for the construction of the Blue Mosque, and even of the Taj Mahal in Agra. Built at an elevated position as compared to the surrounding buildings, the mosque stands out and can be seen from a distance, making it a well-known landmark. A mere glance at this massive edifice with glorious design, and it remains deeply entrenched in one's memory.

Suleymaniye Mosque was originally a big complex including a caravanserai, a Koranic School and a hammam, among others. It's considered to be the biggest mosque in Istanbul with a majestic colonnade topped with 28 domes and with a minaret in each corner. The interior might not be as inspiring as that of Sultan Ahmed Mosque, but it still impresses for its size and architectural details. Features of Byzantine architecture were borrowed from the close by Hagia Sophia, with the abundance of perforated walls allowing natural light to enter and semidomes used as buttresses.

Once you are done with your visit and go back to the ferry landing for a view of the Galata Tower, do have a look at the locals fishing and then grilling and serving their prey to visitors.

As of 10:19 am, the shares of the company recovered slightly and were trading 4.28% lower at Rs 329.80.The steep decline followed news that Vodafone Group has significantly increased its share sale in Indus Towers. It may be noted that the Vodafone Group has raised its stake sale in Indus Towers to nearly 18%, up from about 10%, for up to Rs 16,500 crore, according to a term sheet seeny news agency Reuters.
- This block sale by Vodafone Group affiliates has been increased to a 17.98% stake, compared to the previous 9.94%. The sudden increase in the share sale has led to a sell-off in Indus Towers' stock, with shares sliding nearly 10%.Despite the current trading price drop, analysts on average rate Indus Towers as a "hold" with a median price target of Rs 350, which is slightly higher than the current trading price, according to LSEG data quoted by Reuters.

Options data suggests a trading range of 23,000-24,000, with significant resistance at 24,000 and support at 23,000."Meanwhile, Dr. VK Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said, "Higher highs and higher lows are clear indicators of a strong bull rally. This is happening now in the Nifty which has set four days of record highs. Net institutional activity has turned positive with both FIIs and DIIs turning buyers."

## Bank deposits outshine credit by Rs 1 lakh cr in May

MUMBAI. Banks' continuous efforts to mobilise deposits are finally bearing fruit with the funds mobilsed during the last fortnight of May overshooting the loans provided to customers in absolute terms. Deposits totalled at Rs 2.7 trillion (Rs 2.7 lakh cr) as against credit offtake totalling at Rs 1.7 trillion, something that has been the opposite in over two years.Banks have been chasing deposits with attractive pricing as the people were parking their money in stocks and mutual funds which have been offering more returns. Leading banks have increased their deposit pricing many times in the past a few quarters as there were more demand for credit.

However in percentage growth terms, credit expansion is higher by 19.8% year-on-year (YoY) to reach Rs 167.8 trillion for the fortnight ending May 31, 2024. In absolute terms, credit expanded by Rs 27.7 trillion during the past 12 months to reach Rs 167.8 trillion as of May 31, while deposits grew by 12.8% YoY for the fortnight or by Rs 25.1 trillion over the last 12 months to reach Rs 210.9 trillion. However for the fortnight to May 31, in absolute terms, deposit expanded by Rs 2.7 trillion as against credit expansion of Rs 1.7 trillion, according to the RBI data collated by Care Ratings. While sequentially credit expansion was up only by 1%, deposits increase has been by 1.3% in the reporting fortnight, said Sanjay Agarwal, a senior director with the agency. This has had the credit-to-deposit ratio, which has been hovering around 80 since September 2023, has declined marginally or by 20 bps to 79.6 for the fortnight ending May 31.Deposit growth, though showing improvement, has lagged credit growth in the past year. Meanwhile, last year, Pinkvilla reported that Sai Pallavi is charging Rs 6 crore for her portrayal of Goddess Sita. She has doubled her reported fees of Rs 2.5 crore to Rs 3 crore for the film.

Director Nitesh Tiwari began shooting for Ramayana earlier this summer. Actress Akruti Singh took to her Instagram stories and shared a video from the film's grand Ayodhya set in Mumbai. Later, photos of Lara Dutta and Arun G o vil from the sets have been leaked.Following the leak, Nitesh took a drastic step to combat these measures. According to a report by India Today, director Nitesh Tiwari was quite upset with the leak and thus, a "strict no-phone policy has been imposed on the set". The director has also mandated that extra staff and crew be off the set when the shooting begins. As per the report, only required actors and technicians can be on set.
