Sanjay Kumar Bengaluru, June 25: Another FIR has been registered against former MP Prajwal Revanna on charges of sexual harassment, stalking and criminal intimidation, police sources said on Tuesday. Along with him, three others, including former BJP MLA from Hassan Preetham Gowda has also been named in the FIR for allegedly sharing images captured by Prajwal during sexual harassment of the victim on a video call, they said. With the fresh FIR, this is the fourth case registered against Prajwal. "A fresh case has been registered by the SIT against Prajwal and three others. BJP MLA Former Preetham Gowda has also been named in the FIR," a police source confirmed. The case has been regis-

tered under Sections 355 A

(sexual harassment), 354 B

(assault or use of criminal force to woman with intent to disrobe), 354 D (stalking), 506 (criminal intimidation) of the IPC and 66 E (punishment for violation of privacy) of the IT Act. according to the police sources. Meanwhile Prajwal is currently in police custody. The 33-yearold grandson of JD(S) patriarch and former Prime Minister HD Deve Gowda had failed in his bid to retain the Hassan parliamentary constituency in the recent polls. SIT officials arrested Prajwal soon after he landed at Bengaluru Airport from Germany on May 31. He had left for Germany on April 27, a day after Hassan went to Lok Sabha the polls. A 'Blue Corner Notice' seeking information on his whereabouts had earlier been issued by the Interpol following a request by SIT

"Dead" man turns up alive at his own funeral in Telangana

Hyderabad, June 25: In a case of mistaken identity of a dead person, a man turned up alive at his "funeral" in Vikarabad district of Telangana where his family and relatives were making arrangements for burial after being informed about his death. The incident took place in Navandgi village in Basheerabad mandal of Vikarabad district, an official of Government Railway Police (GRP) said on Tuesday. The man, P Yellappa, (40), a daily wage labourer was presumed dead after his family members were informed about his death when a body was found with a mobile phone on it. The GRP personnel found the body of an unidentified person on the tracks at the Vikarabad railway station on the night of June 22, with the head crushed and beyond recognition, the official said. One mobile phone was found near the body and police officials called up the family members from the phone, who informed that it belonged to Yellappa. Yellappa's wife and his family members reached the government hospital in Vikarabad on June 23 and "identified" the body to be that of Yellappa, the official said. After an autopsy, the family members were handed over the body and they took it to their village. As the family and relatives were making arrangements for the burial, some villagers informed them in the afternoon that they had seen



#### TRAI tells mobile firms to enhance apps, web portals to curb spam calls, messages

New Delhi, June 25: In a bid to curb spam calls and messages, the government has issued fresh directions to mobile services providers. The Telecom Regulatory Authority of India (TRAI) has mandated mobile services providers to enhance their mobile apps and web portals to make them more user-friendly for registration of Unsolicited Commercial Communication (UCC) complaints. The TRAI has mandated mobile services providers to ensure that options for UCC complaint registration and preference management are easily accessible on their mobile applications and websites. "Also, essential details for the registration of complaints should be automatically populated, if users grant permission to access their call logs and other relevant data," said the telecom regulatory body.

New Delhi, June 25 : In a sharp critique of Prime Minister Narendra Modi's governance, Congress president Mallikarjun Kharge on Tuesday accused the ruling administration of under-

mining democracy and the Constitution over the past decade. Kharge's response came to PM Modi's statement recalling the Emergency declared by the then Congress prime minister Indira Gandhi in 1975 to suppress civil liberties, citing Article 352 of the Indian Constitution on June 25. "The mindset which led to the imposition of the Emergency is very much alive among the same party which imposed it. They hide their disdain for the Constitution through their tokenism but the people of India have seen through their antics and that is why they have rejected them time

and again," PM Modi wrote a post on X. "Those who imposed the Emergency have no right to profess their love for our Constitution. These are the same people who have imposed Article 356 on innumerable occasions, got a Bill to destroy



violated every aspect of the Constitution," he added. Kharge highlighted a series of actions that he termed

as an "undeclared Emergency", including the misuse of investigative agencies against opposition leaders, toppling elected governments, and passing significant laws without proper consensus. Kharge questioned the democratic values of the

Modi government, pointing out the suspension of 146 opposition MPs and passing of critical laws such as the Bharatiya Nyaya Sanhita, 2023, without adequate parliamentary debate. He criticised the imposition of controversial agricultural laws, which led to prolonged protests. The Congress president further lambasted the BJP government for hasty decisions like demonetisation and the abrupt lockdown during the pandemic, citing a lack of cooperation and transparency. He also condemned the unilateral relocation of statues of national icons like Chhatrapati Shivaji Maharaj and Mahatma Gandhi

Chandigarh, June 25: The conclusion to the election of the Lok Sabha Speaker scheduled on Wednesday may be long forgone but opposition INDIA bloc putting up Congress candidate K Suresh (though TMC says it was "not consulted") against the ruling NDA's Om Birla is not just an indication of times to come in the 18th Lok Sabha but also the "deepening trust deficit" between the BJP-led government and opposition parties. Notably, this is the first time in the country's Parliamentary history that the opposition has set up a contest for the key constitutional post, normally it is by consensus. Both sides are accusing each other of not following "Parliamentary conventions and traditions". However, before that the President swears in the pro tem Speaker, who is normally the seniormost member of the House, who then administers the oath or the affirmation to the newly elected members. Then the elected representatives become the members of the new Parliament and elect the Speaker from amongst themselves. As per convention, the post of Deputy Speaker is given to a member of opposition. As the head of the Lok Sabha, the Speaker is the custodian of the House, maintains order in the House, can adjourn/suspend proceedings in case of absence of decorum etc. Importantly the Speaker is also the final authority regarding rules and procedures and for a party which may not be having a majority on its own, he or she also holds the key to its stability with final say in voter.

#### Kallakurichi hooch tragedy: AIADMK MLAs evicted en masse after disrupting TN Assembly proceedings

CHENNAI. The AIADMK MLAs were, on Tuesday, evicted en masse from the State Assembly after they insisted on a discussion during the question hour and raised slogans. As soon as the question started at 9.30 a.m,

- Leader of the Opposition, Edappadi K Palaniswami and his party colleagues stood up and demanded a discussion on the Kallakurichi hooch tragedy.
- Assembly Speaker M Appavu said the AIADMK MLAs could raise this issue after the question hour is over. However, the AIADMK MLAs were on their feet demanding a discussion on the hooch tragedy immediately. They also squatted around the podium of the Speaker and started raising slogans. The Speaker said whatever they said would not go on record. As his appeals to the AIADMK MLAs failed, the Speaker called in the Marshals of the House to evict the AIADMK MLAs.Later, Municipal Administration Minister KN Nehru moved a resolution for suspending those AIADMK MLAs who disrupted the House proceedings for the rest of the session. However, Chief Minister MK Stalin recommended that they could be barred from participating in the proceedings of the House only for the rest of the day. The Speaker accepted that.
- The CM said the AIADMK MLAs could not digest the sweeping victory of the DMK-led alliance in the Lok Sabha elections and so are trying to divert the attention of the people by disrupting the House proceedings.Later, Palaniswami told reporters that the Speaker did not allow them to raise the hooch tragedy as the number of deaths are going up.Palaniswami and his party colleagues are meeting Governor RN Ravi to submit a representation to him seeking a CBI inquiry into the hooch tragedy.

# Odisha government admits helplessness in controlling soaring prices of essential commodities

BHUBANESWAR. As soaring prices of essential commodities cripple the common man, the state government on Monday virtually expressed its helplessness to come to the rescue of consumers by stating that price regulation is beyond its control.

Taking a review of the prevailing prices of essential commodities for the second consecutive day on Monday, Food Supplies and Consumer Welfare Minister Krushna Chandra Patra said the government has no control over prices as Odisha is dependent on other states for the items.

The minister told mediapersons that Odisha largely depends on Assam and West Bengal to meet its potato requirement while Maharashtra is the major source market for onions. The state is now sourcing onion from Andhra Pradesh where price is ruling high.

Patra attributed the spiralling prices of potato in the state to rising cost of the tuber at source markets. He said the department is contemplating to go for market intervention through central agency National Agricultural Cooperative Marketing Federation (NAFED) to stabilise prices of potato and onion.However, general secretary of Kuberpuri Byabasayee Sangha, Shakti Shankar Mishra gave a completely different picture. He said the wholesale price of potato in West Bengal is Rs 1,800 per quintal but Odisha traders are buying the tuber at Rs 2,100 to Rs 2,200 per quintal. The retail price of potato should be ideally Rs 26 per kg but it is now selling at Rs 35 a kg. The minister said onions are now procured from Nashik in Maharashtra and Andhra Pradesh at Rs 2,900 per quintal, traders are selling the commodity at Rs 40 a kg which include the transportation cost of Rs 4 per kg and their profit margin. The actual retail price across



Ahmednagar, Aurangabad and Nashik where the wholesale rate is Rs 2,500-Rs 3,000 per quintal depending on the quality of products. The wholesale price of onion in Odisha is Rs 32-Rs 34 per kg. General secretary of Odisha Byabasayee Mahasangha, Sudhakar Panda said,

The price of rice has jumped from Rs 3,000-Rs 3,100 to Rs 3,700-Rs 3,800 per quintal. Similarly, wheat and its products have witnessed a price rise of Rs 200 per quintal, be it atta, maida or suji. Edible oil has also increased by Rs 5 to Rs 15 per litre.

### Seal factories that don't have **BU, fire NOC: AMC chief**

Ahmedabad. Ahmedabad municipal commissioner M Thennarasan on Monday met officials from AMC's estate and town development department and expressed dissatisfaction with their performance. He ordered officials to start sealing factories and industrial units in eastern Ahmedabad operating without building use (BU) permission. Sources said that officials cited staff shortage and other excuses, but the commissioner reiterated that the department has sufficient staff to seal such factories.Sources in Ahmedabad Municipal Corporation said the meeting follows state urban development department's four-page letter to all municipal corporations holding them responsible for buildings operating without BU permissions and fire NOCs. The meeting was attended by the deputy municipal

commissioner and other senior officers. The sources added that the civic body does not act against irregularities despite being aware of them unless it is rebuked by state govt or the high court. During a suo motu petition on pollûtion in Sabarmati, the court had reprimanded AMC and only then had the civic body started disconnecting illegal sewer connections in eastern areas. ### Metro 3: Train trials completed, testing of electrical systems on

Mumbai. The Research Design and Standards Organisation (RDSO) of Indian Railways has completed trials for the rolling stock or train set that will be deployed for commercial services on the underground Metro 3 (Colaba-Bandra-Seepz). Trials are currently underway for the Phase I stretch between Bandra-Kurla Complex (BKC) and Aarey."This is a significant milestone as oscillation trials for the Metro rakes have been concluded. RDSO will now send its report of this segment of trials to the railway board and the commissioner of metro rail safety," said a senior MMRCL official, adding: "Testing of other electrical systems and integrated testing of the rolling stock with signalling is in progress. After completion of testing, the commissioner of metro rail safety will be invited."These trials, which commenced June 8, were undertaken at a maximum speed limit of 95kmph with both empty and loaded rakes. Oscillation trials for Metro systems test the dynamic performance and stability of the train at different speeds. The key aspects tested during



these trials include determining ride comfort by evaluating the vibrations and accelerations experienced inside the train to ensure passenger comfort. The dynamic stability is also checked to assess the train's stability to avoid derailments, particularly at high speeds and during curves. Analysis of how the train interacts with the track, including the forces exerted on the rails and the potential for rail wear or damage, is also undertaken. Manthan K Mehta

### Andhra's Bapatla district shuts down beaches after multiple drownings

GUNTUR.Following the two tragic incidents in which as many as six people drowned at Vodarevu beach in Bapatla district in the past week, as a precautionary measure, the police temporarily shut down three beaches in the district. Last week, over 20 people washed away in the sea due to heavy tides in two separate incidents. While police rescued 14 people, six persons, including four youth from West Godavari district and two from Mangalagiri, drowned and died. Following this, the police closed both Suryalanka, Ramapuram and Vodarevu beaches and imposed a ban from entering into the sea until further notice.Speaking to TNIE, Bapatla SP Vakul Jindal said that due to some geological reasons, the sea is more aggressive and sand pits are forming due to heavy tides. "As a result, even though tourists are not venturing into deep waters, they are getting caught in these sand pits and are drowning. As police cannot be present everywhere and rescue everyone, the ban is enforced as a preventive measure," he said.

He also informed that the police are roping in resort managements at both beaches to appoint skilled swimmers and prevent tourists from venturing into sea until the precautionary measures are in place. "Cautionary boards are



being set up and safe spots for tourists to venture into sea will be marked with red ropes, skilled divers and outpost police will be set up in the next four to five days, and until then the ban will be in force", he added.With a 76-km long coastline, Suryalanka, Ramapuram and Vodarevu beaches are the most attractive tourist spots in Bapatla district. Two years back, due to an increase in drowning cases, the police and district administration appointed 10 skilled divers, outpost police personnel, and set up three watchtowers, and a first-aid centre at Suryalanka beach.

### Latin Archdiocese alleges fake email in Vizhinjam port expansion hearing

THIRUVANANTHAPURAM. The Latin Archdiocese of Thiruvananthapuram and affiliated organisations have raised serious concerns over procedural lapses by the State Pollution Control Board (SPCB) in conducting the public hearing on the Vizhinjam International Seaport expansion held on June 19. They discovered that the email address (ceetvm.kspcb@gmail.com) provided for submitting opinions and concerns regarding the project expansion was fake. The public hearing on the Environment Impact Assessment (EIA) draft for the second and third phases of the port expansion took place at an auditorium in Venganoor. According to representatives from the Church, individuals who opted to send their opinions via email felt deceived."This appears to be a deliberate attempt to undermine the public hearing process, which is a legal requirement for obtaining clearance. By publishing a fake email address, they have

deprived citizens of their right to express their views and concerns about the project.

### Squatters to be cleared from green belts and footpaths on MG Road

Gurgaon: GMDA has planned a drive to raze illegal shops from the greenbelt alongside MG Road. This comes after repeated complaints from residents of Beverly Park 1 and 2. The team led by district town planner RS Batth, along with residents of the condominiums, examined the encroachment on this stretch on Monday.. The vendors and makeshift shops on the greenbelts and footpaths result in traffic and parking choas. The authority has assured the residents a drive will be conducted to clear the encroached areas soon. Further, as per directions issued by GMDA, the enforcement wing will be seen on ground to identify govt land and free it from encroachment.

Batth said, "The team found many unauthorised vendors and temporary shops operating without permission from the authority concerned. The menace is obstructing traffic flow and causing snarls and illegal parking."Another official said that the authority is also surveying spots where govt land, that is ROW (right of way) and green belts and infrastructure projects are hampered due to encroachments. ### After singe, the pinch: Heat burns a hole in pocket as veggie prices soar

- Noida. A summer with temperatures higher than 40 degrees Celsius for over a month and barely any premonsoon showers affected crop yields across states, leading to a spike in the cost of vegetables being sold at markets in Delhi-NCR.At Indira Market in Sector 27, 1kg of onion was being sold for Rs 50 on Monday, a 25% increase from Rs 40 a week before. The rate of tomatoes was up 67% -- from Rs 30/kg to Rs 50/kg. And potatoes cost Rs 40 per kg, a hike of Rs 10 from the last week. The cost of carrots, typically a winter vegetable, doubled from Rs 40 to Rs 80 per kg.
- And coriander, the rate of which also doubled, was up to Rs 200 per kg.Shopkeepers said that they were no longer giving green chillies (Rs 100 per kg) and coriander complementary with other vegetables to customers.Rajesh Kumar, a vendor in Sector 27, said that wholesale costs of procuring vegetables has increased. "Naturally, retail prices will also increase that way," he said. The only vegetable that saw its rate per kg fall in a week was pointed gourd - which went from Rs 80 to Rs 60-due to arrival of fresh stocks.
- Rajinder, a resident of Sector 168 who was shopping at the market on Monday, said she is concerned about the prices hitting her family's monthly budget."Govt should keep a check as it directly affects our pockets," the 60-year-old said.

# Onion & tomato at 50 a kilo, potato at ?40, veggie prices see sharp rise after heatwave

Gurgaon. The prolonged spell of heat and little to no pre-monsoon rainfall affected crop yields in large parts of north India, leading to a surge in prices of vegetables across Delhi-NCR. The prices of tomatoes and green vegetables have shot up over the past few weeks as supply was lower than expected, wholesale traders said on Monday. At Khandsa market, the wholesale price of potatoes was Rs 20-25 per kg on Monday, almost double of Rs 12-20 weeks earlier. The kitchen staple was being sold for Rs 40-50 to customers on Monday. Rates of onions and tomatoes also saw a hike of Rs 20-30 per kg. Customers were buying these vegetables at Rs 50-60/kg.

The cost of other commonly used vegetables were high too - capsicum was Rs 180 per kg (from Rs 50), garlic was Rs 180 per kg (from Rs 90), cucumber was Rs 60/kg (from Rs 30-40) and beans was Rs 120/kg (from Rs 80). Vendors said they had stopped giving

complementary coriander and green chillies as their rates had shot up. Coriander was being sold for Rs 300/kg,



triple of that from Rs 100 a few weeks ago. Green chillies cost Rs 160 per kg on Monday.Raju, a vendor near Sector 10A, said lack of rainfall and extreme heat affected crop production. "Prices have gone up Rs 10-20 per kg. Despite selling without a high margin of profit,

customers are buying less," he said.Residents, too, were rethinking their grocery budgets. Kapil Raghav, who works in Sector 44, said he remembers buying a kilogram of tomatoes for Rs 20 weeks before. "Now, they cost Rs 50. Even other vegetables

like ladyfinger, round gourd and sponge gourd are priced at Rs 60 per kg. These were earlier around Rs 40/kg/. Every week, it seems like prices are higher. It's becoming difficult to manage the household budget," he said.

Krishan Kumar Yadav, a resident of Sector 15, said vegetable rates usually go up during the monsoon. "But monsoon hasn't even begun. It will be very difficult to manage if prices keep increasing," he added. Basant Kumar Yadav, secretary and executive officer of the Gurgaon market committee, said extreme heat impacts crop yields, causing a supply shortfall."

We are seeing reduced yields across the board. The upcoming rainy season will support the next cycle of crops, which may lead to some dip in prices. But excessive rainfall or flooding of farms could adversely impact standing crops, further widening the gap between demand and supply," he warned.

### Makeover for key stretch linking Dwarka eway, IMT Manesar soon

Gurgaon. An arterial stretch connecting Dwarka Expressway to Manesar is set for a major revamp. GMDA officials said the six-lane main carriageway as well as service roads on both sides of the 5.3km master road passing through sectors 84-91 will be redeveloped under the project.

The metropolitan authority approved the Rs 77.7 crore project last Jan. "We will be undertaking a comprehensive upgrade of this crucial stretch to enhance the commuting experience. The proposed redevelopment will follow the model of the ongoing Rampura-Pataudi Road project. We have issued a tender and are making efforts to complete the process within the next 3-4 months. We are hoping to start work on the ground after the monsoon," a senior GMDA official said. The road begins at the CPR interchange of Dwarka Expressway and connects it to IMT Manesar passing through sectors 84, 85, 86, 87, 88, 89, 90 and 91. Originally constructed in 2010-2011 by the

Haryana Shahari Vikas Pradhikaran (HSVP), the road has deteriorated significantly with damaged surfaces and gaping potholes. With the opening of Dwarka Expressway, the traffic load on this stretch has increased manifold. According to GMDA, this road is used by around 28,000 vehicles daily. The key road provides direct connectivity from these sectors to Dwarka Expressway and further to NH-8, Sohna Road and the Southern Peripheral Road (SPR). The 5.3 kmlong stretch is dotted with several residential societies, commercial space, shopping complexes, and schools. While many projects are already occupied, others are either in the construction phase or proposed.

Additionally, Gurugram University, located in Sector 87's Kankrola village along this road, was inaugurated earlier this year. The entire campus is expected to be operational by the end of the year, which is expected to add to traffic on the stretch. Under the project, the main

carriageways will be strengthened and upgraded and service roads will be built on both sides. Similarly, surface drains will be constructed to ensure proper drainage and prevent waterlogging, the GMDA official said."Dedicated cycle tracks and footpaths will be developed to promote sustainable transportation and pedestrian safety. Green belts will also be developed along the stretch. Besides, road safety furniture and streetlights will be installed to improve safety and visibility for all road users," the official added.

Residents have for years been demanding that this road be redeveloped due to its deteriorating condition and increasing traffic load. "The current state of the road makes commuting very difficult, as there are numerous potholes and rough patches. This project will improve connectivity to Manesar industrial areas and Gurugram University," said Vivek Prakash, a resident of New Town Heights in Sector 86.

### Where did fuel go? At Bandhwari, a fresh question

Gurgaon: A controversy has erupted over legacy waste processing at the Bandhwari landfill after an MCG probe found that a private firm tasked with processing four lakh tonnes of waste allegedly submitted fraudulent documents claiming it transported refuse-derived fuel (RDF) to cement industries in Madhya Pradesh. Two cement companies informed the corporation they hadn't received any RDF from the firm, sparking concerns over violations of environmental norms regarding disposal of the waste byproduct.RDF is produced from municipal solid waste, which includes biodegradable material as well as plastic. Noncombustible materials such as glass and metals are removed, and the residual material is shredded and incinerated to generate electricity. The municipal corporation or agencies processing waste are supposed to send it to cement or waste-to-energy plants for use as fuel.Letters accessed by TOI revealed that two cement companies located in MP's Jabalpur and Singrauli informed MCG that they have not received any RDF from the agency. According to sources, MCG is planning to float another tender for legacy waste processing at Bandhwari, and the private firm is aiming to again land the contract. The agency, Patheya, was deployed for legacy waste processing at Bandhwari in 2022-23 and finished the task early last year. After it told MCG that RDF was being sent to MP, the corporation constituted a committee in July last year for physical verification of the claims.

Of the three cement companies the committee visited for inspection in MP, two denied having received RDF as claimed by the private agency. The companies also stated they haven't issued any certificates stating this either, the committee said in a confidential report filed in Sept last year





The video circulating on social media and verified by Reuters showed a Palestinian resident of Jenin, Muiahed Azmi, on a military icen that resident of Jenin, Mujahed Azmi, on a military jeep that passed between two ambulances. The Israeli military in a statement said Israeli forces were fired at and exchanged fire, wounding a suspect and apprehending him.
- Soldiers then violated military protocol, the statement said. The military said the "conduct of the forces in the video of the incident does not conform to the values" of the Israeli military and the incident will be investigated and dealt with. The military said the man was transferred to medics for treatment."I saw the statement they made out that the actions were inconsistent with the orders those soldiers received and that is being investigated, and the people involved will be dealt with accordingly. - A second avalanche blocked an access road in the mountains, leaving nine people trapped in the town of Banos Morales and 20 stuck in Lo Valdes, according to Cortes' office.Both towns are awaiting snow plows to clear roads, where 10 meters (33 feet) of snow built up after the avalanche.

# Louisiana sued for requiring to display list of religious precepts in classrooms

Louisiana became the only US state requiring displays of the Ten **Commandments when Governor Jeff** Landry, a Republican, signed the law on June 19.

Louisiana was sued on Monday (local time) over a new law requiring the display of the Ten Commandments in all public school classrooms in the state. The complaint said displaying the Ten Commandments violates the First Amendment of the US Constitution, and "simply cannot be reconciled with the fundamental religious-freedom principles that animated the founding of our nation".Nine families, including several clergy, with children in public schools filed the lawsuit in the Baton Rouge, Louisiana federal court, seeking an injunction against the law.Louisiana became the only US state requiring displays of the Ten Commandments when

Governor Jeff Landry, a Republican, signed the law on June 19. The law is also part of a broader push by conservative groups to make expressions of gloups to make expressions of faith a more prominent part in society.Some hope that such laws, when challenged in court, could eventually receive a friendly welcome at the US Supreme Court, which has a 6.3 conservative which has a 6-3 conservative majority.That court in 1980 declared unconstitutional a Kentucky law requiring the display of the Ten Commandments in public schools.But in 2022, the court sided with a high school

football coach in Washington state who said he had a constitutional right to pray with his players at the 50-yard line after games.Landry's office did not immediately respond to requests for comment.In signing the Louisiana law, Landry said displaying the Ten Commandments would help expand faith in public schools."If you want to respect the rule of law, you've got to start from the



original law-giver, which was Moses," he said. The plaintiffs said the law violates the First Amendment's prohibition against state establishment of religion. They also said the law violates the First Amendment's free exercise clause by pressuring parents and children to accept the state's favoured religious message."It is our children's right" to decide what views to accept, plaintiff Darcy Roake, a minister in the Unitarian Universalist

Church whose husband is Jewish and also a plaintiff, said on a conference call with reporters.In the Christian and Jewish faiths, God revealed the Ten Commandments to the Hebrew prophet Moses.Louisiana's law requires an easy-to-read, poster-sized display of the Ten Commandments in all classrooms, from kindergarten through public colleges.

It also requires a statement that the Ten Commandments had been "a prominent part of American public education for almost three centuries".Such a statement could suggest that the Ten Commandments have historical, as well as religious, value. The lawsuit was assigned to US District Judge John deGravelles, who was appointed to the bench by Democratic President Barack Obama.

The SAVE plan provides more generous terms than past income-based repayment plans, lowering monthly payments for eligible borrowers and allowing those whose original principal balances were \$12,000 or less to have their debt forgiven after 10 years. Missouri Attorney General Andrew Bailey, a Republican who helped lead the litigation, hailed Ross' decision. "Congress never gave Biden the authority to saddle working Americans with half-a-trillion dollars in other people's debt," he wrote on social media platform X. The Education Department and the White House had no immediate comment.Biden, a Democrat, announced the SAVE Plan in 2022, alongside a broader \$430 billion program that would have fulfilled a campaign promise by cancelling up to \$20,000 in debt for up to 43 million Americans. It was ultimately blocked by the conservative- majority US Supreme Court in June 2023. The SAVE Plan was slated to fully take effect on July 1, though parts of it already been implemented, with 414,000 borrowers by mid-May having been granted \$5.5 billion in debt relief, according to the Education Department. The White House has said that over 20 million borrowers could benefit from the SAVE Plan. The administration in May said that 8 million are already enrolled, including 4.6 million whose monthly payments have been reduced to \$0.Eleven states challenged the plan in a lawsuit in Kansas. Crabtree had recently dismissed eight of the states' claims, but allowed South Carolina, Texas and Alaska to push forward. Seven other states sued in Missouri.

### Ukraine to combat Russia's strikes

US to send \$150 million in military aid to

Washington The US is expected to announce on Tuesday that it will be sending an additional \$150 million (approx Rs 12.52 crore) in critically needed munitions to Ukraine, as Russia accuses Ukraine of using USprovided munitions to strike inside Russia or Russian-held territory, according to two US officials.On Monday, Russia summoned the American ambassador to protest what it says was the use of US-made advanced missiles in a Ukrainian The continued flow of US munitions, attack on Crimea on June 23 that reportedly killed four people and wounded more than 150.

Crimea, which Russia seized from Ukraine in 2014 in a move that most of the world rejected as unlawful, had

long been declared a fair target for Ukraine by its Western allies. However, the Pentagon said last week that Ukraine's military is also now allowed to use longer-range missiles provided by the US to strike targets inside Russia if it is acting in self-defence. Since the outset of the war, the US had maintained a policy of not allowing Ukraine to use the weapons it provided to hit targets on Russian soil for fear of further escalating the conflict.

The upcoming shipment is expected to include munitions for the High Mobility Artillery Rocket Systems, or HIMARS. One of the US officials said they could not verify whether this aid package included ATACMS munitions, but said the aid did not include cluster munitions. The package also includes anti-armour weapons, small arms and grenades and the highly sought-after 155 mm and 105 mm artillery rounds, among other support.

It has sparked a humanitarian crisis and displaced most of the territory's 2.3 million population.

# **Russia blames US for Ukrainian strike on** Crimea, promises retaliation

Moscow The Kremlin on Monday squarely blamed the United States for an attack on Crimea with US-supplied ATACMS missiles that killed at least four people and injured 151, and Moscow formally warned the US ambassador that retaliation would follow.

The war in Ukraine has deepened a crisis in relations between Russia and the West, and Russian officials have said the conflict is entering the most dangerous escalation to date.But directly blaming the United States for an attack on Crimea which Russia unilaterally annexed in 2014, although most of the world considers it part of Ukraine - is a step further. You should ask my colleagues in Europe, and above all in Washington, the press secretaries, why their governments are killing Russian children," Kremlin spokesperson Dmitry Peskov told reporters.At least two children were killed in the attack on Sevastopol on Sunday, according to Russian officials. People were shown running from a beach near Sevastopol and some of the injured being carried off on sun loungers. Kviv did not comment on the attack but denies targeting civilians. Russia said the United

States had supplied the weapons, while the US military had aimed them and provided data.Russia's Foreign Ministry summoned US Ambassador Lynne Tracy and told her Washington was "waging a hybrid war against Russia and has actually become a party to the conflict"."Retaliatory measures will definitely follow," it said. Tracy said Washington regretted any loss to civilian life, State Department spokesperson Matthew Miller told reporters, adding that Washington provided weapons to Ukraine, so it could defend its sovereign territory, including Crimea.Pentagon spokesperson Major Charlie Dietz said that "Ukraine makes its own targeting decisions and conducts its own military operations." US official later said that Ukaine was not targeting civilians. It seemed that the Russians were able to intercept an ATACMS missile that was targeting a missile launcher, and the ATACMS exploded with shrapnel raining down on the beach, the American official added.President Vladimir Putin has repeatedly warned of the risk of a much broader war involving the world's biggest nuclear powers, though he has said Russia does not want a



conflict with the US-led NATO alliance.RUSSIAN RETALIATORY MEASURESUS President Joe Biden has ruled out sending US troops to fight in Ukraine and said shortly after the 2022 full-scale Russian invasion that a direct confrontation between NATO and Russia would mean World War Three.Putin presents the Ukraine war as part of a wider struggle with the U.S., which he says ignored Moscow's interests after the Soviet Union's 1991 break-up, then plotted to split Russia apart and seize its natural resources.Leaders of the West and Ukraine have cast the war as an imperialstyle land-grab. The West denies wanting to destroy Russia, which in turn denies intending to invade any NATO member

state.After the United States allowed Ukraine to direct some US weapons into Russia, the Kremlin sent signals that it viewed this as a serious escalation.Putin has ordered drills to practise deployment of tactical nuclear weapons, suggested Russia could station conventional missiles within striking distance of the United States and its allies, and sealed a mutual defence pact with

North Korea.Washington still prohibits Kyiv from striking recognised Russian territory with ATACMS, which have a range of up to 186 miles (300 km), and other long-range U.S. weapons.Putin said on Thursday that Russia might supply weapons to North Korea in what he suggested would be a like-for-like response to the Western arming of Ukraine.Asked what the Russian answer would be to the attack in Crimea, Peskov recalled Putin's words on June 6 about wider placement of conventional weapons."Of course, the involvement of the United States in the fighting, as a result of which peaceful Russians are dying, cannot but have consequences." Peskov said.

# **Telangana exploring ways to** stop auction of mines

The state government is planning to urge the Centre to allocate these mines to public sector units and not private

#### companies.

HYDERABAD. After the Union minister of mines wrote a letter, asking it to auction at least six mines by June 30, the state government is exploring ways to stop the auction process. The state government is reportedly taking the matter seriously as there is a risk of Telangana losing rights over valuable mineral wealth due to the "mistakes made by the previous government". The state government is planning to urge the Centre to allocate these mines to public sector units and not private companies.

Official sources said that the previous BRS government gave green signal to auction of mines in Telangana and that is the reason the Centre is forcing the state government to auction mines.

It may be mentioned here that recently the Ministry of mines wrote a letter to the state government to auction at least six out of the 11 notified mines by June 30.

The previous government took a decision to allocate all the mines and mineral wealth in the state to private companies. Eight years ago, related files were prepared to hand over limestone and iron ore mines to private companies. In 2018,



the state government took a decision to auction three limestone mines in the state. As a part of that, plans have been made for auctioning of the limestone mines located in Pasupulabodu, Saidulunama and Sultanpur of Suryapet district, which are notified by the Centre. On September 16, 2020, the then chief secretary wrote a letter to the Union ministry, giving consent for the auction," sources said.Responding to that letter, on December 12, 2021, the Union government gave permission to auction and lease these limestone mines. The letter also clarified that since the state government has agreed, no prior permission from the Centre is required

and the auction process should continue, sources added. If the six mines are not auctioned by the June 30 deadline, the Centre may auction these mines as per Sections 10B and 11 of the Mines and Minerals (Development and Regulation) Act, (MMDR Act)."The Union government is controlling Telangana mines only because of a wrong decision taken by the previous state government," sources said

"With the ulterior motive of handing over these mines to private companies, the previous government sought permission from the Centre to auction. But now the BRS leaders are politicising the issue," they added.

# 1.76L fail to qualify for school scholarships

Ahmedabad: The Gujarat Secondary and Higher Secondary Education Board on Monday announced the results of its primary school and secondary school scholarship exams held on April 28. Of the 2.29 lakh primary school students who took the exam, 72,171 qualified. Of the 51,000 students who took the secondary exam, 31,731 qualified. Thus, of the 2.80 lakh students who took the two exams, 1.04 lakh scored qualifying marks - 35% or 70 marks out of 200—and 1.76 lakh students failed to.

The board conducts exams to pick students for primary school and secondary school scholarships. The online form submission process was conducted from March 1-11.

Some 2.57 lakh primary school students and 64,000 secondary school students had registered online for the exams. Students of Class 6 and Class 9 were eligible for the primary and secondary school scholarships respectively. They also needed to have scored at least 50% the previous year. In the primary school exam, 23,000 students scored more than 100 marks,



3,255 scored over 130 marks, 438 over 150, 103 over 160 marks and six more than 175.In the secondary exam, 16,000 scored over 100 marks, 4,215 over 130, 1,206 over 150, 473 over 160, and 57 over 175.

## D-DAD centres in Kerala free 232 children from digital addiction

KOCHI. Asha (name changed), a teenager from Kochi, used to spend countless hours on social media platforms like Facebook and Instagram. - A few months on, Asha has now recovered from digital addiction, thanks to the Digital De-Addiction Centre (D-DAD) in Kochi operated by state police, which changed her life for good through counselling and other interventions. Asha's case, though concerning, is not as serious as that of many of her peers, who got involved in crimes and even ended their life due to excess internet usage.
- The Kerala Police established D-DAD centres one-and-a-half years ago, in response to the rising concerns over digital addiction among children. They have



successfully counselled and rehabilitated 232 children, helping them return to a balanced life. The centres employ psychologists, counsellors, and are equipped with child-friendly tools. Their approach includes interactive education, device-free retreats, and scientifically supported diversion techniques.

Six D-DAD centres are operational, one each in Thiruvananthapuram, Kollam, Ernakulam, Thrissur, Kozhikode, and Kannur. Currently, 86 children are receiving counselling from experts at these centres. According to officials,

### 'Inaccessible' new terminal at Tiruchy international airport adds to passengers' woes

TIRUCHY.The integrated terminal building (ITB) at the international airport here, which was commissioned into use on June 11, still lacks proper access due to non-availability of city buses or battery-operated vehicles. As a result, passengers are forced to walk one kilometre from the entry point to ITB and vice-versa.

Earlier, airport director P Subramani had assured arrangements would be made to operate a city bus for the convenience of passengers to reach the terminal buildings. Subsequently, talks were held with TNSTC officials in the city. However, no progress has been attained in that front, complain passengers.A Venkatraman, who arrived at the Tiruchy airport from Chennai, had no option but to walk one kilometre from the terminal building to the main road to board a bus to Namakkal on Sunday. "This is my first time travelling to Tiruchy. When I enquired about a cab, the driver demanded Rs 700 to reach the central bus stand. So, I waited for an auto. Since no auto arrived, I started walking," he said. "It would be better if they operate either a bus or battery-operated vehicles, similar to those at the railway junction," he added.Rajkumar, another passenger, has appealed to airport authorities to arrange a TNSTC shuttle bus service between the main road and the terminal building. Another visitor Mohan Pillai, in a social media post, sought an auto service. "Tiruchy is a small town and all domestic flight passengers are from nearby areas. Not everyone wants to take a taxi to the airport," he said. However, P Kalyan, a native of Perambalur who accompanied his



cousin bound for Singapore. told TNIE that auto drivers charge Rs 250 to Rs 300 just to shuttle passengers between the one-km stretch.He suggested that the fare would likely be more affordable if the airport authorities operated battery-operated cars instead. An auto driver who did not wish to be named told TNIE that they are compelled to charge high fares as airport officials collect Rs 80 as an access fee for each trip.

### Tamil Nadu to declare heat waves as state-specific disaster soon

CHENNAI: Revenue Minister KKSSR Ramachandran on Monday announced that heat wave would be declared as a state-specific disaster soon to enable the state government to take preventive steps for the condition as per the rules of the State Disaster Response Fund and offer relief assistance to those who get affected.Replying to the discussion on demands for grants for the revenue department, the minister said due to climate change, Tamil Nadu faced extreme heat and heat waves in April and during the first two weeks of May. The state has taken steps to help the people cope with the heat conditions by establishing water kiosks and creating separate units in government hospitals to treat people affected by heat waves.Official sources said a notification for declaring heat waves as a disaster will be issued soon as per the

guidelines of the Government of India. Only when heat waves are declared as a state-specific disaster, the Tamil Nadu government can provide relief assistance to those affected by them. During summer, funds can also be allocated to the health department from the SDRF for providing ORS at hospitals and setting up water pandals. '59% TN people exposed to over 35 0C weather'Some states, which have declared heat waves as state-specific disaster, have issued norms for relief assistance for heat waves, sunstroke and sunburn. The relief assistance includes solatium to the families of persons who died due to heat waves and those who suffered injuries, and ex gratia for loss of eyesight due to heat, etc.Recently, the State Planning Commission submitted a report to the state government titled "Beating the Heat: Tamil Nadu Heat



Mitigation Strategy". The report said Madurai, Chennai and Thoothukudi are the districts most affected by

extreme heat, which has increased between 2003 and 2023, with night temperatures almost on a par with daytime temperatures. The report pointed out that nearly 59% of state's population is exposed to temperatures above 35°C and there is an urgent need to build heat resilience in the state as climate change-driven heat is only expected to intensify. As per India Meteorological Department, heat waves generally occur over plains of northwest India, Central, East and north Peninsular India from March to June. It covers Punjab, Haryana, Delhi, Uttar Pradesh, Bihar, Jharkhand, West Bengal, Odisha, Madhya Pradesh, Chhattisgarh, Rajasthan, Gujarat, parts of Maharashtra and Karnataka, Andhra Pradesh and Telangana. Sometimes it occurs over TN and Kerala too. So, most states are prone to heat waves, IMD said.

# Swiss-led peace talks a flop as Russia left out

DID the Swiss-mediated Burgenstock peace conference collapse because the organisers did not study how delicate peace negotiations are conducted? Did the conference fail because Russia was not invited?In the past, the 1993 Oslo Accords temporarily halted Israel-Palestinian wars. Similarly, the 1998 Good Friday Agreement brought peace between Britain and the Irish Republican Army. The Oslo process was started in 1992-93 by Terje Larsen, a Norwegian sociologist, and Yossi Beilin, a member of Israel's Labour Party government that had come to power in 1992. This had the backing of Israeli leaders and Palestine Liberation Organisation (PLO) chief Yasser Arafat.Since the Israeli law banned contacts with the PLO, Larsen and Beilin set up a secret backchannel between two Israeli professors and three PLO leaders, including Ahmed Qurei. Their first meeting was held during January 1993 at the residence of then Norwegian Defence Minister Johan Jorgen Holst. The US Department of State archive says "strict secrecy allowed the negotiators to discuss scenarios and potential concessions without incurring domestic political costs."In May 1993, Israel decided to elevate the talks to the official level and sent then Director General of Foreign Ministry Uri Savir. In August that year, the Israeli and Palestinian chief negotiators initialled the Declaration of Principles on Interim Self-Government Arrangements (DOP) in Oslo. The formal signing ceremony was held at the White House in September, when Israeli Prime Minister Yitzhak Rabin and PLO chairman Arafat 'shook hands'.

- Although permanent peace remained elusive, the Oslo Accords were an important milestone in West Asian peace, like the 1978 Camp David Accords, brokered by US President Jimmy Carter, between Egyptian President Anwar Sadat and Israeli Prime Minister Menachem Begin, bringing peace between Egypt and Israel. Together with the DOP, the agreement also included 'Letters of Mutual Recognition', through which the PLO recognised the existence of Israel for the first time.Israel also recognised the PLO as the legitimate representative of the Palestinian people. Besides, Israel committed itself to withdrawing from parts of the Gaza Strip and the West Bank and acknowledged the Palestinian right to self-rule in those territories under a Palestinian Authority.
- Similarly, Senator George Mitchell, who was designated as a 'Special Envoy' by then US President Bill Clinton, had to toil between September 1996 and April 1998 to bring in peace in Northern Ireland, ending 30 years of violence. He had to overcome hostility from the 'unionists', who wanted Northern Ireland to remain with Britain, as they felt that President Clinton had imposed mediation efforts to their detriment.
- It is said that they also opposed secret talks in a foreign place away from Belfast, as they wanted to avoid the possibility of being politically ambushed away from their home base. Mitchell's tactic was his infinite patience to listen to the opposing parties whose hostility to each other was so intense that there "was very little inclination to listen to the other side, let alone compromise with them," as he told an interviewer later. The cardinal principle in all such negotiations is the secrecy of proposals put across by contending sides so that no embarrassment is caused to either of them by sending wrong signals

### The exam system needs urgent course correction

The practice of appointing members to recruitment commissions based on political connections must be ended.

THE Ministry of Education has cancelled the 2024 UGC-NET (University Grants Commission-National Eligibility Test) in view of a paper leak. The case is now under the purview of the CBI, which will conduct further investigation. The ministry has also handed over the case of alleged irregularities in the conduct of the 2024 NEET-UG (National Eligibility-cum-Entrance Test-Undergraduate) to the CBI. The NEET medical entrance exam is also under the scrutiny of the Supreme Court. In this year's NEET (UG), a record-breaking 23 lakh candidates had got themselves registered.

Meanwhile, Subodh Kumar Singh has been removed from the post of Director General of the National Testing Agency (NTA) amid the controversy over the NEET-UG and UGC-NET exams. In another significant development, the government has postponed the NEET-PG. These cases of question paper leak are not isolated, but rather part of a long history of incidents. The IIT-JEE of 1997 and the All India Pre Medical Test of 2011 witnessed this menace. The phenomenon is seen in many states, regardless of which political party is in power. There is a high incidence of paper leak in India. As a result, numerous examinations have to be cancelled. According to media reports, over the past seven years, more than 70 examination papers have been illicitly disclosed in various states, resulting in adverse consequences for the professional prospects of over 1.7 crore individuals. Instances of leaked exam papers and answer keys are frequently shared on social media platforms such as WhatsApp, X (formerly Twitter) and Facebook.

The NTA need not be scrapped; only the examination system needs to be revamped. Each year, over 10 lakh candidates participate in the Civil Services examinations, yet the Union Public Service Commission (UPSC) manages to conduct a secure examination. However, when it comes to online exams, there is a potential risk of leak due to the use of technology. The likelihood of the threat intensifying is certain to rise amid the use of artificial intelligence (AI). Given these circumstances, AI is poised to become a significant menace. If the website of the Home Ministry can be compromised, it is reasonable to question why these exams cannot be similarly vulnerable to hacking. Every exam that is scrapped not only wastes the time and money of millions of students, but also consumes taxpayers' money. The NTA is exceeding its brief by repeatedly employing a trial-and-error approach in conducting these examinations. The agency was established in 2017. However, even after seven years, the scourge of paper leak persists. The NTA must take lessons from the UPSC.



The practice of appointing members to recruitment commissions based on political connections must be ended. Additionally, the examination commission should possess its own printing press or alternatively, the digital copy should be directly transmitted through a code lock system - 15 minutes prior to the examination - to the designated examination centre. The document ought to be printed and distributed among the candidates. By employing this approach, the cost of question papers will undoubtedly be slightly higher compared to press printing, but they will be secure and impervious to leaks. It is imperative that the punishment for the paper mafia is administered promptly within a specified timeframe in a fast-track court, ideally within a month of the arrests. If any coaching institute is found to be involved, appropriate action should be taken against the individuals responsible and the institute should be shut down. The participation of external agencies facilitates unethical practices. From the initial creation of paper sets to their delivery to the examination centre, a large number of individuals are involved in the process. As a result, each person has a clearly defined responsibility within the hierarchy. Question papers undergo multiple stages involving drafting, printing and transportation before reaching the examination centres. It is imperative to prohibit the use of mobile phones by

all persons involved. The majority of the examination centres are privately owned institutions, and a significant number of them do not meet the required standards. Examinations ought to be exclusively administered at government-approved facilities, with papers subject to constant surveillance and monitoring via CCTV cameras. The leak of question papers for public examinations has a significant impact on public trust, besides causing a substantial financial burden on the state exchequer. The Public Examination (Prevention of Unfair Means) Act, 2024, also known as the anti-paper leak law, has come into effect. But the notification of the Central Government regarding the Act contains a lacunae that require an urgent resolution. The new legislation mandates a minimum prison sentence of three years; it should be increased to a minimum of 10 years. The severity of the punishment should align with the seriousness of the offence. There is no provision for conducting investigations within a specified time-frame. In addition to imposing an additional prison sentence for failure to pay a fine for an offence under the Act, the provision for confiscation of the offender's property should also be included. The candidate who engages in exploiting unfair methods should be disqualified from appearing in any subsequent examination.

THE apocalyptic nuclear weapons and a parlous global security framework were in focus this month, with two major reports being released on the same day (June 17) - one by the ICAN (International Campaign to Abolish Nuclear Weapons) and the second by SIPRI (Stockholm International Peace Research Institute). Their findings are both distressing and bleak. The ICAN report reveals that the nine nuclear-weapon-capable nations (the US, UK, Russia, China, France, India, Israel, Pakistan and North Korea) collectively spent \$91 billion last year in modernising and increasing their respective arsenals. Assuaging a deep-seated strategic insecurity syndrome apropos of the adversarial 'other' is the common thread for all nine nations.Predictably, the top three spenders are the US with \$51.5 billion, which is more than half of the global nuclear weapon-related spending in 2023, followed by China (\$11.8 billion) and Russia (\$8.3 billion). ICAN Director Melissa Parke noted that the nuclear powers collectively spent \$2,898 per second last year on these weapons and that these funds exceed what the World Food Programme estimates as necessary to end world hunger. She added that "a million trees could be planted for each minute of spending on nuclear weapons". The reference to the number of trees that could be planted is particularly relevant in the context of the irreversible global warming and climate change exigency that the world responds to in an effete and indifferent manner. India, which is reeling under a scorching summer and a dangerously low people-tree ratio, is among the most affected among large nations (in terms of total area and demography). This geo-physical trend may soon prove to be the most serious threat to human security globally. The recent heatwave-related deaths during the Haj pilgrimage are illustrative.

The SIPRI Yearbook 2024 is a comprehensive volume that provides an overview of developments in international security, weapons and technology, military expenditure, arms production and the arms trade as well as armed conflicts and conflict management, along with efforts to

ICAN and SIPRI reports paint a grim picture on the global nuclear front



control conventional, nuclear, chemical and biological weapons. The nuclear chapter of almost 100 pages is a valuable summary of recent developments and trends in the nuclear domain over the last year. Authors Hans Kristensen and Matt Korda are to be commended for their due diligence in furrowing a tenaciously opaque domain, where facts, information, disinformation and political rhetoric abound.

The key findings of the SIPRI nuclear survey are that the number and types of nuclear weapons in development have increased, as all nine nations deepen their reliance on nuclear deterrence to safeguard what they perceive as their core national interest. The most recent example is that of the Russia-Ukraine war, where Moscow has rattled its nuclear sabre to warn the US-led NATO about redlines, and in response, both NATO and the US have stated that they will enhance their nuclear readiness across the board. The SIPRI nuclear overview indicates that in early 2024, the nuclear nine (N9) "possessed approximately 12,121 nuclear weapons, of which 9,585 were considered to be potentially operationally available. An estimated 3,904 of these warheads were deployed with operational forces, including about 2,100 that were kept in a state of high operational alert - about 100 more than the previous year."While the US and Russia still account for 88 per cent of the total global arsenal, an instructive statistic has been highlighted by SIPRI in relation to China, whose nuclear arsenal "has increased significantly from 410 warheads in January 2023 to 500 by January 2024, with expectations of continued growth". It adds that China is in the middle of a significant modernisation and expansion of its nuclear arsenal over the next decade and "some projections suggest that China could potentially deploy at least as many intercontinental ballistic missiles as either Russia or the US in that period".

While China may be pitting itself against the US, a visible increase in the deployment of Chinese nukes (from the current 24) would have significant implications for South Asian strategic stability that would be of grave import to New Delhi.During the Cold War, the nuclear missile contest was played out between the US and its allies (UK and France) and the then USSR from 1945 to 1991. After the 'scare' of the 1962 Cuban missile crisis, both sides warily moved towards a degree of credible, robust nuclear deterrence that was predicated on arms control agreements and MAD (mutually assured destruction). This geopolitical, steady-state plateau had an ironic anomaly, wherein a deep techno-strategic insecurity was assuaged by accepting MAD — and the acronym captures the apocalyptic sardonicism.

ince the Russian invasion of Ukraine in February 2022, the world has been getting divided into two competing nuclear weapon clusters: the US-led military alliance (with the UK and France) versus the Russia-China dyad having North Korea as a junior partner. The other three members of N9 — India, Pakistan and Israel — have not formally joined either cluster, though their geopolitical orientation is self-evident.

The bleakness referred to at the outset stems from the fact that since 2022, the world has drifted from reasonably robust deterrence to one of fragile fecklessness. The earlier strategic communication among the major powers and well-entrenched arms control and restraint agreements have steadily frayed. The US is going through an intense domestic socio-political churn with the possibility of a second Trump presidency. Russia remains determined to prosecute its war in Ukraine, come what may, while Chinese belligerence over its territorial claims continues to be brittle. This is a bleak augury. The ICAN and SIPRI reports illuminate this arid landscape in an objective manner but underscore the grim reality that there is no light at the end of this tunnel.

Another doctor Manoj Jain said, "Problems in professional life affect brain activity. It causes stress and affects quality of life. # NEET scam targeted 700 students, aimed for Rs 300 crore: Paper leak mafia

New Delhi: Amid the NEET paper leak scam, India Today's special investigation team tracked down a key member of the network, who explained the intricate layers of the operation. Bijender Gupta was involved in multiple paper leak cases in the past, and was arrested twice but managed to evade the police.A video of him from March predicting that the NEET-UG paper would be leaked has gone viral.Gupta was involved in the 2023 Odisha Staff Selection Commission (OSSC) exam paper leak case, the Bihar Public Service Commission and Madhya Pradesh Public Service Commission paper leaks. With 24 years in the paper leak network, Bijender Gupta claims networking is all that matters in this business.

He also said that the NEET-UG paper leak targeted 700 students, and the racket aimed for Rs 200-300 crore. In the sting by India Today, Bijender Gupta explained how boxes are broken during transportation and blacklisted companies manage to get

tenders. He knows key NEET accused Sanjeev Mukhiya, who is on the run, and recently arrested Vishal Chaurasia.Gupta bluntly summed up the operations. "Jail jayenge, phir bail, aur phir shuru hoga khel (There's jail followed by bail, and the game goes on)," Bijender Gupta said in the sting.

- New Delhi: A Delhi Court has sentenced a man to a 20year jail term under the Protection of Children from Sexual Offences (POCSO) Act for sexually assaulting a boy. The court has granted a compensation of ? 20 Lakh for the rehabilitation of the victim, who is now a college-going boy. He was a minor of 16 years when he was sodomized by the convict in 2021.An FIR was lodged by the father of the victim at Rajouri Garden police station.
- Special judge (POCSO) Preeti Pareva sentenced the convict Mahendra to a rigorous jail term of 20 years and imposed a fine of ? 52000 under sections 6 and 12 of POCSO and sections of IPCAdditionally, the man was also convicted under Section 66 E (punishment for violation of privacy) under the Information and Technology (IT) Act. While sentencing the convicts, the court said, "The purpose of the criminal justice system is not only to attain catharsis by handing down proportionate punishment to the offender but also to rehabilitate the victim, who is scarred physically and mentally, forever.
- "If we fail to do so, we are indicating our duty towards the victim, whose psychological well-being has been denied and may have longer repercussions," it added.his case was lodged on 11 February 2021 by the father of the victim boy who alleged that his son was sodomized by the Convict and he also took pictures of the victim. On the basis of this complaint, a case under sections of POCSO, IPC and IT Act was registered.

New Delhi: After questions being raised over various institutions conducting examinations across the country, selection processes are under scrutiny. Conducting entrance or recruitment exams for a large number of candidates using new scientific processes in the computer age is itself challenging. Until the allegations against NTA regarding NEET exams are proven or deserving students get selected, not only will there be a delay, but the mental state of children will be so adversely impacted that it is impossible to fathom.Whether entrance exams or recruitment exams, if there are any allegations, there must definitely be a thorough investigation and the governments must fix responsibility. Otherwise, the courage of professional paper leakers will keep rising. It is a different matter that the Union Education Minister Dharmendra Pradhan has admitted that there were irregularities in the NEET recruitment. Admitting the truth was also his duty.

- However, no official system has the right to play with the lives of lakhs of children. In fact, whenever any kind of entrance exam is conducted and the number of candidates runs into lakhs, every agency adopts a different method of conducting the exam. UGC has a different pattern and NTA has a different one, while at the state level, selection agencies conduct exams differently. Similarly, the exam process of State Selection Commissions or State Public Service Commissions or UPSC is also different.
- When everyone adopts new methods, flaws are natural to occur. It is these flaws that paper leakers are exploiting.
- It has been observed that the officers responsible for conducting the exams often portray most of the processes as confidential. These are limited to a few individuals, lacking transparency. This is where the possibility of irregularity arises.
- In Himachal Pradesh too, there was an MBBS exam scam in Himachal Pradesh University in the year 2006. NEET-like processes did not exist then. Although the paper leak was exposed in 2006, who knows since when doctors recruited through cheating have been practicing at big hospitals. It is an irony that the former accused could not be caught due to lack of evidence. It is also important to know that scams come to light only when they are caught.

# Ayodhya Ram Temple roof leaking after heavy rain, no drainage of water: Priest

New Delhi: Water was leaking from the roof of the sanctum sanctorum at the Ram temple in Uttar Pradesh's Ayodhya after the first heavy showers since it was opened to the public, its chief priest Acharya Satyendra Das said on MondayAlleging negligence in the construction of the temple, Das claimed that there was also no arrangement for the drainage of rainwater from the temple premises after the showers on Saturday midnight and urged the temple authorities to take necessary corrective measures. After the senior officials were informed about the incident of water leaking from the roof, the chairman of the temple construction committee, Nripendra Mishra, reached the temple and gave instructions to repair the roof and make them waterproof, temple trust

sources said.Speaking separately to

reporters about the progress of temple

construction, Mishra said that work on the

first floor was on and will be finished by



July this year, and expressed the hope that the construction of the temple will be completed by December.

Acharya Satyendra Das told reporters there was heavy leakage from the roof of the temple's sanctum sanctorum in the first heavy showers that occurred at midnight on Saturday. Rainwater was leaking from the roof directly above the place where the priest sits in front of Ram Lalla's idol and where people come for VIP darshan, he said."It is very surprising that engineers from all over the country are building the Ram temple. The temple was inaugurated on January 22. But, no one knew that if it rains, the roof would leak. It is surprising that the roof of a worldfamous temple is leaking. Why did this happen?"

'Such an incident is happening in the presence of such big engiee, which is very wrong," he said.Meanwhile, rains on Saturday night caused severe waterlogging on the Rampath road and its adjoining laneshere. While sewer water entered houses in the area, the Rampath road and other newly constructed roads in Ayodhya caved in at some places. There was waterlogging from Jalwanpura to Hanumangarhi Bhaktipath and from Tedhi Bazaar to the inner areas, locals said.Reacting to the sewer water entering houses in the lanes of Rampath during the rain, Ayodhya Mayor Girish Pati Tripathi said, "I have started damage control since morning. I have deployed several teams of the municipality to remove water from the houses."However, attempts to seek the response of top officials of the Public Works Department (PWD) did not fructify.Meanwhile, the Congress accused the ruling Bharatiya Janata Party (BJP) of indulging in corruption in the temple construction and building of civic facilities in the temple town."Be it the coffin of the martyrs or the temple of God, all these have become opportunities for corruption for the BJP. Even the symbols of faith and purity in the country are just opportunities of loot for them," Uttar Pradesh Congress chief Ajay Rai alleged in a statement on Monday."It has become clear from the statement of chief priest Satyendra Das that water is leaking in the sanctum sanctorum of the Ram temple built at a cost of crores due to the first rain and there is no proper drainage system," he said.Rai said, "Not only this, the mask of the BJP, which was beating the drum of development of Ayodhya, has come off with the road collapsing at many places on the Rampath built at a cost of Rs 624 crore.'



"The most exciting aspect of our findings is that cognitive tutoring not only improves performance, but is also anxiety-reducing," said the study's senior author Vinod Menon professor of psychiatry and behavioural sciences at Stanford University School of Medicine in California, US.

"It was surprising that we could, in fact, get remediation of math anxiety," Menon noted.

Even if they are good at math, many children feel anxious about doing math problems.

For some, the anxiety persists throughout life, discouraging them from pursuing advanced math and science classes as well as careers that rely on mathematical expertise.

The study included 46 children in third grade. Before receiving tutoring, each child took a test that assessed his or her level of math anxiety.

The brain scans of the children with high levels of math anxiety showed activation in the brain's fear circuits and so-called "fear centre", or amygdala, before tutoring.

Children then participated in an intensive, eight-week tutoring programme consisting of 22 lessons involving addition and subtraction problems. Tutors gave the lessons to each child individually. All of the children performed better on addition and subtraction problems after tutoring. The children who started

the study with high levels of math anxiety had reduced anxiety after tutoring, while those in the low-math-anxiety group had no change in their anxiety levels.

After tutoring, the fear circuits and amygdala were no longer activated in children who had begun the study with high math anxiety, confirming that tutoring ameliorated the anxiety itself, rather than providing the kids with a coping mechanism that relies on other brain circuits.

"It is reassuring that we could actually help these children reduce anxiety by mere exposure to problems," the study's lead author Kaustubh Supekar from Stanford University noted.

### Current account swings to 5.7 bn surplus in Q4FY24

NEW DELHI: Driven by a sharper fall in imports and a marginal fall in exports helped the economy narrow trade deficit, which along with robust services exports helped it report a current account surplus of \$5.7 billion or 0.6% of GDP in the fourth quarter of the fiscal 2024 frist time in 10 quarters, compared to a deficit of \$1.3 billion or 0.2% in the year-ago quarter, according to the latest RBI data.In the December 2023 quarter, the current account deficit stood at 8.7 billion or 1% of GDP, show the latest data. The current account logged a surplus in the March quarter largely due to higher services, the Reserve Bank said on Monday. The current account surplus stood at \$5.7 billion in the fourth reporting quarter as against a deficit of \$8.7 billion or 1 percent of GDP in the preceding quarter.

For the full yearm, the deficit narrowed sharply to \$23.2 billion, or 0.7% of GDP, this is lowest in seven years, as against \$67 billion or 2% of GD in FY23, the central bank said. The 0.6% surplus in the March quarter marks a significant improvement from the year-ago period, where the country had a current account deficit of \$1.3 billion or 0.2% of GDP.During the March quarter, net outgo on the primary income account, primarily reflecting payments of investment income, increased to \$ 14.8 billion from \$ 12.6 billion a year ago, the RBI said. Private transfer receipts, mainly representing remittances, amounted to \$32 billion, an increase of 11.9% on-year, it added. In the financial account, net foreign direct investment flows were \$2 billion compared to \$6.4 billion a year ago, said the central bank.Foreign portfolio investment saw a net inflow of \$11.4 billion as against a net outflow of \$1.7 billion on-

CLSA, which has been increasing its price targets for Zomato since May 2023 (Rs 80

Among other parameters, Swiggy had 387,000 active delivery partners against Zomato's 4,18,000. Also, Swiggy Instamart had 487 active dark stores compared to 526 for Blinkit.Investment risks in Zomato includes subdued urban consumer sentiment hindering growth, high competitive intensity, and regulatory strictness. Significant consumer adoption of the ONDC network could have some negative impact on take rates, which is also a key risk, it said.

CLSA values Blinkit at a 30 per cent discount to its 67 times PE multiple used for DMart. It believes, given profitability for DMart is much higher and the business model is more stable, such a discount for Blinkit is valid.

### **Prosus marks 493 mn loss in** Byju's, writes off stake

**BENGALURU:** Investment firm Prosus on Monday said it has written off its 9.6% stake in Byju's. In its FY24 annual report, the Naspers-owned firm said a fair value loss of \$493 million was recognised in other comprehensive income in the current year.In a statement, Prosus said, "We impaired Byju's mark down to zero at the end of FY24. The fair value written down was \$493 mn for FY24. We have written down Byju's because we have inadequate information on Byju's financial health, liabilities, and future outlook.

The investment firm has invested over \$500 million in the edtech firm, and this write off comes at a time when the edtech firm has been struggling with various challenges including the ongoing legal troubles. Recently, in a note financial firm HSBC assigned

zero value to Prosus' 9.6% stake in Byju's. It said, "We assign zero value to Byju's stake amid multiple legal cases and funding crunch." It added in the note, "Previously, we valued around 10% stake in Byju's by applying an 80% discount to the latst publicly disclosed valuation."The edtech firm was once valued at \$22 billion, and in November last year, Prosus had marked down the firm's valuation to less than \$3 billion. In January this year, US-based asset manager BlackRock slashed Byju's valuation to \$1 billion as of October 2023.

### **EU Regulators Accuse Apple Of Breaching New Digital Competition Rules**

NEW DELHI: European Union regulators on Monday levelled the first charges against giant phone maker Apple under new digital competition rules. The EU accuses Apple of preventing users from switching to cheaper alternatives outside its app store. The European Commission, the executive branch of the European Union, cited the initial results of its preliminary investigation and said that Apple's restrictions on developers using its mobile app store violate the group's Digital Markets Act.

The Digital Competition Manual (DMA), provides for heavy financial penalties to deter major technology companies from targeting digital markets. It was implemented in March. Under this, the European Commission has launched a preliminary round of investigation against iPhone maker Apple. A separate investigation is already underway against Apple over whether it is taking sufficient steps to allow users to easily switch web browsers. The other cases under DMA involve Google and Meta. The European Commission said that the rules of the iPhone App Store prevent app developers from freely directing consumers to alternative channels for offerings and content. Apple will now have to respond to these findings of the European Commission. The Commission will take a final decision on this matter by March 2025. If found guilty of violating competition rules, the American company may have to pay a fine of up to 10 percent of its global revenue, which will be equivalent to billions of euros.

Facing a slowdown in fresh demand after two years of blockbuster sales, carmakers have taken the route of massive discounts and attractive offers to lure buyers.Passenger vehicle sales meanwhile slumped to 3,03,358 units - down 0.96% over last year (3,06,305 units) and down 9.48% compared to April 2024 (3,35,123 units). Excepts of a few SUVs which continue to command a waiting period, every product including some best selling models, available in the market carries some form of reward. Add to it, many carmakers have either gone for steep price cut or launched new variants to attract buyers interest.


