Sanjay Kumar New Delhi, June 28: The Congress party has launched a scathing attack Minister Prime on Narendra Modi and his government following the tragic roof collapse at Terminal 1 of New Delhi's Indira Gandhi International Airport (IGIA). The incident, which was triggered by heavy rains, resulted in the death of one person and left five others injured. Congress president Mallikarjun Kharge minced no words in his condemnation, attributing the collapse to "corruption and criminal negligence." "The shoddy infrastructure, falling like a deck of cards, is a glaring testament to the past ten years of PM Modi's governance,' Kharge stated. He pointed to a series of infrastructure failures, including the Jabalpur airport roof col-

CSIR develops compact, low-cost tractor for small farmers to replace bullock plough

Chandigarh, June 28: A compact, affordable and easily maneuverable tractor catering for small and marginal farmers that could help them increase agricultural productivity while keeping their costs low has been developed by the Council for Scientific and Industrial Research (CSIR) ... Marginal and small farmers comprise over 80 per cent of cultivators in India and a large proportion of them still depend on bullock-pulled tilling implements in which operational costs, maintenance costs and poor returns pose a challenge. Though power tillers are replacing the bullock pulled plough, they are cumbersome to operate. Commercially available tractors in the market, on the other hand, are unsuitable and unaffordable for most small farmers. In order to address these challenges, CSIR's Central Mechanical Engineering Research Institute (CMERI) developed a compact and affordable tractor of low horsepower range to meet the requirement of the marginal and small farmers, according to a statement issued by the Ministry of Science and Technology today. CMERI is also discussing licensing the technology to local companies for large scale manufacturing so that the benefits can reach the local farmers and awareness is being spread about it among farmers' associations and self-help groups, the statement added.

CBI arrests school principal, vice-principal in NEET paper leak case

New Delhi, June 28: The CBI on Friday arrested the principal and vice-principal of a school in Jharkhand's Hazaribagh in connection with the NEET-UG paper leak case, officials said. Ehsanul Haque, the principal of Oasis School, was made the city coordinator of Hazaribagh for the medical entrance exam conducted by the National Testing Agency (NTA) on May 5, they said. Vice-principal Imtiaz Alam was designated as the NTA's observer and the centre coordinator at the Oasis School, officials said, adding the CBI is also questioning five more people from the district in connection with the paper leak case. The federal probe agency arrested Haque and Alam after detailed questioning, they said. Both the accused came under scanner during a probe by the Bihar Police's Economic Offences Unit (EOU) which was investigating the case earlier. The team had found burnt question papers of NEET-UG during a raid at a hideout of the solver gang, officials said. In a state-ment, the EOU had claimed the "leaked"



Yediyurappa, aides paid money to sexual assault victim, mother to buy their silence

Bengaluru, June 28: The Criminal Investigation Department (CID) probing charges against former Karnataka chief minister BS Yediyurappa of sexually assaulting a minor girl, has alleged in the chargesheet that the BJP leader and three other accused paid money to the alleged victim and her mother to buy their silence. The 81-year-old Yediyurappa has been charged under Section 8 (punishment for sexual assault) of the Protection of Children from Sexual Offences (POCSO) Act and Sections 354-A (sexual harassment), 204 (destruction of document or electronic record to prevent



restoration of property in consideration of screening offender) of the IPC. The other three co-accused - Arun YM, Rudresh M and G Mariswamy, who are aides of Yediyurappa – are charged under Sections 204 and 214 of the IPC in the chargesheet filed at the Fast Track Court 1 for POCSO Act cases here on Thursday. According to the chargesheet, on February 2 this year, at around 11.15 am, the 17-year-old alleged victim, along with her 54-year-old mother -- the complainant -- visited Yediyurappa at his residence in Dollar's Colony here seeking help in getting justice in a previous case of sexual assault (on the daughter) and other issues. While Yediyurappa was speaking to the mother, he was holding the victim's right wrist with his left hand, it said. Yediyurappa then called the minor inside a meeting room next to the hall and locked the door. He then asked the victim whether she remembered the face of the person who had sexually assaulted her earlier to which the victim replied twice saying that she did, the chargesheet said. After this Yediyurappa asked her what her age was then, to which she replied six-and-a-half; at this point he tried to sexually assault her, the CID alleged. It said the horrified victim pushed Yediyurappa's hand, moved away and asked him to open the door. Yediyurappa then opened the door and exited after putting some cash in the hands of the victim from his pocket. He then told the victim's mother that he couldn't help them in the case and also gave her some money from his pocket and sent them away, the chargesheet said.

Ranchi, June 28: Former Jharkhand Chief Minister Hemant Soren was released from Birsa Munda Jail here on Friday after the high court granted bail to him in a money-laundering case linked to a land scam, an official said. Falsely implicated, I was forced to spend 5 months in jail: Hemant Soren As Soren stepped out of the jail, a large number of JMM supporters cheered and raised slogans in favour of him. Soren's wife Kalpana Soren, a IMM legislator, thanked the judiciary and people for their support. "Heman Soren was released from the jail after completion of legal formalities," the official said. Soren, on his release from the jail, was seen waving at people and seeking blessings from his father and JMM supremo Shibu Soren. A single bench of Justice Rongon Mukhopadhyay granted bail to the former chief minister of Jharkhand earlier in the day. "... Soren, the executive president of the Jharkhand Mukti Morcha (JMM), was arrested by the

Mumbai, June 28: A woman passenger on board IndiGo flight 5292 from Varanasi to Mumbai was booked for allegedly abusing and misbehaving with cabin crew over a change in seat, police have said. The incident took place on Monday, a police official said. "The flight with 175 passengers took off from Varanasi 29 minutes late. The woman, occupying seat 9, asked for a change in seat but refused when the crew asked her to take seat 15. Some 15 minutes later, she went to the lavatory and then started abusing and misbehaving with the crew," the official said on Thursday. "Though crew members initially ignored her rants, she continued to shout at them. After the crew as well as some other passengers complained about her behaviour, she was declared an unruly passenger after following the due process for such a move," the official said. She was handed over to Sahar police after the flight landed at Mumbai airport and based on the complaint of a crew member, she was booked under provisions of the Indian Penal Code and Aircraft Rules, the official said.

Delhi Police nab man who brought shooters to outlet

New Delhi, June 28: The Delhi Police on Friday made its first arrest in connection with the recent murder of a man at a food outlet in west Delhi's Rajouri Garden, officials said. The arrested accused Bijender (27), a resident of Rohtak in Haryana, is the one who allegedly brought the two shooters in his vehicle at the spot to commit the murder, a senior police officer said. The police said three other suspects, the woman who accompanied the victim at the outlet and the two shooters, are still at large. The incident took place on June 18 around 9.30 pm at a Burger King outlet on the Najafgarh Road in Rajouri Garden, the officer said. Three people came on a motorcycle and parked outside the outlet. One person remained outside to keep surveillance and as back-up with a weapon, while two of them went inside and indiscriminately fired around 40 rounds at the victim who died on the spot, he added. The victim was later identified as Aman Joon (26), a resi-dent of Jhajjar in Haryana. He was sitting with a woman inside the outlet when the incident happened. Later, a criminal gang based outside India took responsibility of eliminating the man, the officer said. During investigation, the shooters who were involved in the incident were identified as Ashish, Vikas, and Bijender. On Friday, the police got inputs on the whereabouts of Bijender and nabbed him from the Rohini area. A sophisticated pistol, eight live cartridges, and a motorcycle have been recovered from his possession, Special Commissioner of Police (Special Cell) R P Upadhyay said. He was previously involved in five cases of murder, attempt to murder, and cases under the Arms Act, Upadhyay said. During interrogation, Bijender disclosed that the murder of Joon was committed in a pre-planned manner allegedly on the direction of a criminal gang based abroad,

Cab driver dead, 6 injured as portion of roof collapses at Delhi airport's Terminal-1

New Delhi, June 28: A cab driver died and six people were injured after a portion of a canopy at Delhi airport's Terminal-1 collapsed on cars amid heavy rain early on Friday, leading to suspension of flight departures, according to officials. Heavy rain pounds Delhi as monsoon arrives; waterlogging, traffic snarls, power cuts add to chaos Delhi Fire Services (DFS) officials said three fire tenders were rushed to Terminal-1 (T1) of the airport after a call about the incident was received around 5:30 am. Besides the roof sheet, the support beams collapsed, damaging the cars parked in the pick-up and drop area of the terminal. A search operation was conducted to make sure no one was trapped inside the damaged vehicles, they said. The injured have been admitted to Medanta Hospital near the airport. One of them was rescued from a car on

More officers for wetland reclamation regularisation in Kerala

THIRUVANANTHAPURAM: The revenue department will assign more officers to process applications for regularising reclamation of old wetlands and paddy fields.In a statement on Thursday, the department said the strength of officers will be increased from the present 27 to 71 from July 1. Taluk-based processing will be adopted, the statement said. The statement said as per the Kerala Conservation of Paddy Land and Wetland Act, 2008, only revenue divisional officers (RDOs) can approve regularisation applications and subsequent category change of land in revenue records. The current



strength of 27 officers has created a huge backlog of applications, and to resolve this, the assembly enacted an amendment to enhance the number of officers, said the statement.As per the amendment, an RDO means "an officer designated by the government not below the rank of deputy collector," helping the government increase the number of sanctioning officers to 71, said the statement.

The government has also made other arrangements to clear the backlog, like creating 68 junior superintendents and 181 clerk posts to assist the RDOs. An order to appoint 123 surveyors on a temporary basis and hire 220 vehicles on rent was issued.

Malayali engineering graduates develop new tech for surgical planning

The technology is also used to teach medical students about human anatomy.

KOCHI: With proper guidance, support and determination, anyone can be innovative. This was proven true once again when a team of Malayali engineering graduates developed a software system to revolutionise medical diagnostics and surgeries. Over the past year, the team from Barton Hill College in Thiruvananthapuram have been tirelessly working to develop a 3D imaging software to enhance the accuracy and efficiency of medical care."The idea struck us when Sree Chitra Thirunal Institute for Medical Sciences and Technology approached our college for collaborations. We knew that our team, hailing from the electronics and communication department, had much to contribute here. So we did, by way of our final project. We connected with professor Kesavadas to understand the inadequacies and develop a solution," says Aloysius



Bejoy, a final-year BTech student at the college and the team lead.

The technology works by converting CT scan files into 3D images, which can then be projected onto a white screen or other surfaces using 3D glasses. This allows for detailed visualisation of various organs, enabling accurate identification of cancers, delicate nerves, bone fractures, and more. The technology is also used to teach medical students about human anatomy.C Kesavadas from the Department of Radiology at the Sree Chitra Thirunal

Institute has been instrumental in applying this technology to medical practices. The technical support for the project was provided by EMBEDITE, a local company. The software's potential became clear when Dr Dinesh Raja P from Sree Chitra Thirunal Institute suggested its application in cardiology. "Feedback from an actual doctor provided more insights, leading to further customisation and improvement. Now, the system can visualise the heart and associated structures with clarity," Aloysius says. The software addresses the

limitations of 2D imaging by offering detailed 3D visualisations, making minute details visible that are otherwise missed. "Initially, this initiative was aimed at neuro-anatomy teaching. Our founder, Dr M S Valiathan, envisioned a tool for visualisation in medical education and recommended collaborating with the Indian Institute of Information Technology, Hyderabad. IIT Hyderabad developed the initial visualisation tool, which we used to teach brain anatomy. This was the starting point. Realising its potential for surgical planning, Barton Hill Government Engineering College took over the software development. Dr Arun Anirudhan V from the Biomedical Technology Wing also collaborated, leading to an MOU with Barton Hill," Dr Kesavadas says.

He further explains, "The software was further developed and tested with engineering students, demonstrating its utility for surgical planning and teaching cardiac anatomy. Originally a neuroanatomy project, it expanded to clinical use, focusing on cardiac and abdominal surgeries. The software can now be used to teach surgical procedures, with plans to extend its application to other organs."The institute and Barton Hill College are considering getting a patent for the system. Efforts are also on to make the system portable for wider use.

Hic! Faulty breathalyser causes 'high' drama at KSRTC bus depot in Kothamangalam

KOCHI: Who's to 'fault' when the pot calls the kettle black? 'High' drama unfolded at the Kothamangalam KSRTC bus depot on Thursday morning after two vigilance inspectors found many employees in an inebriated condition.Pushed to a corner but refusing to back down, the road transport company's staffers insisted that the duo undergo the breathalyser test. And lo and behold, one of the inspectors also tested positive! It was then that it dawned: the device is defective. It all started around 3.30 am when the team of vigilance inspectors reached the depot to conduct surprise breathalyser tests on drivers."The first service from the depot is at

3.50 am. Vigilance inspectors Ravi and Samson went about their job swiftly, subjecting bus crew to the test. Things went smoothly for nearly four hours," said an



official in charge of the depot.It was then that they tested conductor P V Biju, a crew on the Palakkad service scheduled to depart at 8.05 am. The device showed a reading of 39%. However, Biju protested,

saying he hadn't had even a drop of alcohol. A war of words ensued and Biju's colleagues stood by him.

Station master Shaju Sebastian arrived at the scene and he too backed Biju. The irate inspectors then urged Shaju to undergo the test. The latter obliged and the machine read 40%. Labourer shot dead after casteist slur, cops deployed

S Police were deployed to quell tension in Fatehpur Billoch village near Ballabhgarh after a 30-year-old Dalit labourer was allegedly shot dead by a member of another community on Wednesday night. Another Dalit man was also injured during the firing.

Devender, the deceased, had left home on a bike around 7.30pm on Wednesday and was intercepted by accused Om Prakash along with nine others, all members of his family, shortly after."Om Prakash's family intercepted Devender and shot him. After Devender collapsed in the lane, the accused kept firing into the air while raising objectionable comments against our community," Sundar Lal, Devender's cousin, told cops in his complaint. Hearing the gunshots, other people from their community began to gather, and the accused opened fire on the crowd, Lal alleged. Another Dalit man, Babulal, was shot in his jaw.A police team reached the spot and the two men were brought to a nearby hospital where Devender was declared dead. Babulal is currently undergoing treatment and his condition is stable, police said. "We have deployed adequate police force in the village to prevent any untoward incident. The motive behind the attack is yet to be ascertained," said ACP (Tigaon) Rajesh Kumar Lohan.A case has been registered against 10 accused and unknown persons under sections 148 (rioting armed with deadly weapons), 149 (unlawful assembly), 302 (murder), 506 (criminal intimidation), Arms Act, and SC&ST (POA).

Saini flags off 50 EVs for doorstep waste pickup

Gurgaon: Chief minister Nayab Singh Saini flagged off 50 new electric vehicles in the city on Thursday to streamline doorstep waste collection. This is the first time that electric vehicles will be utilised for doorstep waste collection in the city. With this, the fleet of garbage pickup vehicles has expanded to over 500.By incorporating electric vehicles in the waste collection process, officials said the civic body aims to not only expedite the collection of garbage but also contribute to environmental conservation efforts.

'Electric vehicles that we have flagged off won't only speed up garbage collection from households, but will also help the environment," CM Saini said during the launch.On June 19, Gurgaon divisional commissioner RC Bidhan flagged off 350 vehicles for primary waste collection. The corporation has also constituted 50 teams to identify gaps in door-to-door waste collection. Based on the findings of this survey, MCG will hire more vehicles to strengthen doorstep waste collection.

Residents, however, said doorstep waste collection is irregular in various parts of the city since the private agencies hired by MCG don't have requisite manpower and vehicles. The new agencies also have no



clarity on their respective jurisdictions, making it difficult for residents, they said. "Door-to-door waste collection is not at all happening in our sector despite the corporation's tall claims of gradually adding vehicles to their fleet. Earlier, Ecogreen covered 70% of the sector and the remaining 30% was covered by the

private vendors. But now, the new vendors are not turning up because they don't have the required manpower and vehicles. MCG had sufficient time to make arrangements for this before the elections when they issued the preliminary termination notice to Ecogreen," said Lalit Suraj Bhola,

general secretary of Sector 9A RWA. The CM also inaugurated cloth bag vending machines on Thursday. These machines will be installed across public places in the city soon. Residents can get cloth bags by inserting a Rs 10 coin or using UPI. CM Saini also inaugurated sanitary pad vending machines.

Fix city's waste woes in a week: CM to MCG

Gurgaon. Chief minister Nayab Singh Saini on Thursday gave MCG officials a week's time to fix the city's sanitation system. Infectious diseases data not on portal, 20 labs get notices

Gurgaon. A total of 20 registered laboratories were served notices by the health department on Thursday for failing to report notifiable infectious diseases.

The health department identified this lapse during routine inspection. The city currently has a total of 150 registered laboratories. Notifiable infectious diseases are those that pose a significant public health risk and require immediate reporting."We have directed these labs to upload the data about infectious diseases on the integrated health information platform (IHIP) portal within 48 hours. In case any of them fails to do so, we will take action against them. It is mandatory for labs to upload details and inform the health department within 24 hours of detection of any infectious diseases," said chief medical officer Virender Yadav. Laboratories play a crucial role in disease surveillance, conducting tests, and quickly reporting positive cases to health authorities. Failure to report can delay essential public health action to control disease spread. The health department has urged all labs to have the infrastructure and trained staff to identify and report notifiable such diseases. The department also directed the labs to maintain accurate records and provide timely information to the authorities. The CMO stated that the health department will regularly inspect laboratories and enforce strict actions against those violating reporting guidelines. How mute button will work at tonight's Biden-Trump debate

World. Joe Biden and Donald Trump will clash with each other at the much-awaited first presidential debate on CNN Thursday. This is the first time that there will be no live audience to cheer or boo the speakers. There will also be a mute button -- which was introduced in 2020 from the second debate after Trump and Biden talked over each other in the first debate.CNN's debate night control room will mute the microphones of candidates when it is not their turn to speak.

How will the mute button work?

- Behind the podiums, there will be two green lights which are a signal that his microphones are on. When the lights are off, the microphone is mute. CNN showed how the mute button will work and how will viewers see it on their screen. When a candidate speaks, the microphone of the other remains off and at that time if the second one interrupts the first one, his voice will not reach the viewers -- he will only be seen miming.

- But as they are be standing at lecterns that are only 8 feet apart, they will hear each other, even if on mute.
- In the demo video, CNN reiterated that both the campaign agreed to abide by these rules. "By agreeing to participate in this debate, both campaigns and candidates have also agreed to abide by these rules," CNN said. The 90-minute debate will include two commercial breaks, and campaign staff cannot interact with their candidate during the break, the network said. The second debate between Biden and Trump is slated for September on ABC.
- CNN moderators Jake Tapper and Dana Bash, already accused by Trump's campaign of spreading fake news against Trump, will use "all tools at their disposal" to ensure a civilized discussion. The debate starts at 9 pm and will continue for 90 minutes -- with only two commercial breaks. This is a normal length for a presidential debate, but the commercial breaks are noteworthy: General-election debates in past cycles, sponsored by the Commission on Presidential Debates rather than an individual news organization, did not have them. The candidates will not be allowed to talk to their aides during the commercial breaks, but they will have time to take a breather and collect themselves in a way they would not have in past years

Russian satellite breaks up in Space, forces ISS astronauts to shelter

World. A Russian Earth observation satellite, RESURS-P1, which was declared dead in 2022, has disintegrated into more than 100 pieces of debris in orbit. The break-up occurred on Wednesday, near the International Space Station (ISS), causing the astronauts on board to take shelter in their spacecraft for about an hour as a precautionary measure. US Space Command stated that there was no immediate threat to other satellites.

The cause of the satellite's break-up is currently unknown, and Russia's space agency, Roscosmos, has not provided any comments on the incident. LeoLabs, a US space-tracking firm, detected the satellite releasing fragments until 6 pm Mountain Time. US Space Command confirmed that the event generated "over 100 pieces of trackable debris."Large debrisgenerating events in orbit are uncommon but are becoming a growing concern as space becomes increasingly crowded with vital satellite networks. In 2021,

Russia faced strong criticism from Western countries when it destroyed one of its defunct satellites using a groundbased anti-satellite (ASAT) missile, creating thousands of pieces of orbital debris. While the RESURS-P1 passed over the Plesetsk rocket site during the initial break-up window, there was no immediate indication that Russia had launched a missile to strike the satellite.

When satellites reach the end of their operational life, they either remain in orbit until they eventually descend into Earth's atmosphere and burn up, or they are moved to a "graveyard orbit" 36,000 km from Earth to minimize the risk of colliding with active satellites. Roscosmos decommissioned RESURS-P1 in 2021 due to onboard equipment failures and had been lowering its altitude for an eventual atmospheric reentry.

The incident highlights the growing need for an international mechanism to manage space traffic and address the risks



associated with satellite collisions and space warfare. Space advocates and lawyers have been calling for countries to

establish such a system, which does not currently exist, to ensure the safe and sustainable use of space for all.

Elon Musk's SpaceX gets \$843m to help discard ISS around 2030

WASHINGTON. Nasa awarded SpaceX \$843m to build a vehicle capable of pushing the Internation Space Station into Earth's atmosphere for its planned destruction around 2030, it said on Wednesday, a task originally meant for Russia's thrusters.

Under its new Nasa contract, SpaceX will build what the space agency called the US Deorbit Vehicle to deorbit the ISS and avoid risks to populated areas, with Nasa taking ownership of the craft and handling the deorbiting operation. The football field-sized research lab, led primarily by the US and Russia, has been continuously staffed with govt astronauts during its some 24 years of operation, but its aging components have led Nasa and its foreign partners to set 2030 as a planned retirement date. The first segment of the ISS was launched in 1998. Weighing 430,000kg, ISS is by far the largest single structure ever built in space. Based on past observations of how other stations such as Mir and Skylab disintegrated on atmospheric re-entry, Nasa engineers expect the orbital outpost to break up in three stages. First, the massive solar arrays and the radiators that keep the orbital lab cool will come off, then individual modules will break off from the truss.


China: In a First, Two Former Defence Ministers to Be Tried for Corruption, Expelled from Communist Party

Beijing, China Two former Chinese defence ministers, Wei Fenghe and his successor Li Shangfu, who worked under President Xi Jinping's watch were on Thursday expelled from the ruling Communist Party and are set to be prosecuted in what was regarded as the worst scandal to hit the People's Liberation Army. The Communist Party headed by Xi, has expelled Gen. Wei, 70, and Gen. Li, 66, for alleged corruption and launched prosecution proceedings against them after investigations Both were deprived of their qualification reportedly found both of them indulged in corruption, separate official announcements said. The year 2023 will also go down as the worst year for Chinese ministers as three of them including former Foreign Minister Qin Gang besides Wei and Li disappeared from public view.Li, who went missing last year following an investigation into alleged corrupt practices, was expelled from the party on Thursday for serious violation of Party discipline and the law, the state-run Xinhua news agency reported.A similar announcement said Wei too was expelled from the party and to be prosecuted.Wei served as Defence Minister from 2018-23 and Li barely served a few months as his successor.Li, a Chinese aerospace engineer who headed

the People's Liberation Army's all important Rocket (Missile) Force and was personally picked up for the top defence post by Xi himself, went missing last year, sparking speculation that he was being investigated for corruption and indiscipline.Both served as State Councillors, the top post in the party and as a member of the Central Military Commission (CMC), the overall high command of the PLA headed by Xi.

His sacking followed a major shakeup in the PLA Rocket (missile) Force in which its commander Li Yuchao and political commissar Xu Zhongbo along with others, were replaced without any official explanation. In a similar announcement, the CMC's disciplinary and supervisory agency launched an investigation against Li and Wei. The investigation found that they seriously violated political and organisational discipline. They sought



improper benefits in personnel arrangements for themselves and others, took advantage of their posts to seek benefits for others, and accepted a huge amount of money and valuables in return. Media reports here last month said Wei, whose prolonged absence from the public has sparked speculation about his fate, was reported to be politically safe after his name figured in the tributes paid to a senior Chinese legislator who passed away.But not so as the party came down heavily on him too saying that a disciplinary and supervisory probe launched against him found that he had seriously violated party discipline and indulged in corruption. The

announcement said as high-ranking officials of the Party and the military, both lost faith and loyalty. Their actions failed the trust of the Party Central Committee and the CMC, and severely contaminated the political environment of the military, bringing enormous damage to the Party's cause, the development of national defence and the armed forces, as well as the image of senior officials, Xinhua reported.Wei's violations are extremely serious, with a highly detrimental impact and tremendous harm, according to the investigation findings.

The Political Bureau has decided to forward their suspected criminal case to procuratorial organs of the military for examination and prosecution.

Li and Wei are just the latest senior PLA officers to be brought down in the ongoing anti-graft campaign. Nine generals, including previous and serving commanders of the PLA Rocket Force and the Air Force as well as several CMC officials with the Equipment Development Department, were dismissed from the National People's Congress in December.

Soaring vegetable prices in Andhra burden people

GUNTUR: Soaring prices of vegetables and essential commodities are burdening the common man, who are struggling hard to get things in order. With tomatoes surpassing Rs 100 per kg, other vegetables, including beans, bottle gourd, chillies, brinjal and okra, have also increased by two-fold due to a lack of supply.Similarly, the prices of mint and coriander leaves also climbed up the price chart in the last couple of weeks. The prices of vegetables, oils, pulses, dal and groceries have increased in the past few months burning a hole in the pockets of the common man.Expressing her ordeal, A Rama Lakshmi, a 34-year-old teacher, said, "Usually the monthly expenditure of our family of four on groceries is between Rs 4,000 to Rs 5,000. Now, it is exceeding Rs 6,000 to Rs 7,000. The prices of almost everything have increased, making life difficult for us".Following this, the Guntur district administration swung into action to curtail the spiralling prices by reducing the costs of basic essential commodities. Plans are on anvil to provide tomatoes at fixed prices through market intervention. As the prices of tomatoes have increased from Rs 60 to Rs 90 in Chittoor market due to less yield, the officials informed that with the Rs 5 lakh revolving funds allotted by the State government and marketing department, the vegetables will be sold in the local markets at the same price as sold at Chittoor market. Very recently, the prices monitoring committee held a review meeting and discussed the measues to be taken amid the soaring prices. They instructed the officials to take stern action against the traders for hoarding and creating artificial scarcity in the market.

Andhra to disburse Rs 4,399.89 crore in pensions door-to-door on July 1

VIJAYAWADA: The State government has made all arrangements for the disbursal of Rs 4,399.89 crore towards social security pensions (NTR Bharosa) to all the 65.18 lakh beneficiaries at their doorstep in a single day on July 1.Chief Secretary Neerabh Kumar Prasad said employees of village/ward secretariats will commence the distribution of pensions at 6 am. Each employee will be allocated 50 houses. Employees of other government departments will also be deputed for the purpose if needed.Holding a video conference with all the District Collectors from the State Secretariat on Thursday, he said the enhanced pension amount of Rs 7,000 for beneficiaries under Category I (aged and widows, and 11 sub-categories) will be disbursed at their doorstep. The sum includes enhanced pension of Rs 4,000, along with three months arrears of Rs 1,000 each.Similarly, for the partially disabled beneficiaries, who come under Category II, will be given the enhanced pension of Rs 6,000 from Rs 3,000. Permanently disabled beneficiaries under Category III will be given Rs 15,000, which has been enhanced from Rs 5,000. Beneficiaries under Category IV, who are suffering from chronic diseases like renal ailments and thalassemia, will get the enhanced pension of Rs 10,000 from Rs 5,000 per month, the Chief Secretary explained.

Out of the total Rs 4,399.89 crore, a sum of Rs 4,369.82 crore will be disbursed to

64.75 lakh beneficiaries in cash at their doorstep directly. The remaining Rs 30.05 crore will be credited into the bank accounts of 43,000 beneficiaries residing outside the State under the Direct Benefit Transfer mode.Directing the District Collectors to withdraw the money from banks on June 29 itself, the Chief Secretary said they should strive to complete the entire exercise on July 1 itself and issue the pension distribution certificates. If the distribution of pensions is not completed on July 1 due to any unavoidable reasons, it can be continued on July 2, he said. The pension amount will be disbursed at the doorstep of beneficiaries through Biometric Authentication or IRIS Authentication of

Aadhaar Based Face Authentication or Real Time Identification of Beneficiary System or Pensioner Facial Authentication. Puducherry education department orders closure of 33 more unrecognized schools

PUDUCHERRY: The Puducherry Department of School Education has ordered the closure of 33 more unrecognized private schools on June 25, while cautioning parents against admitting their children to such institutions. This decision follows an earlier

proper authorization from the Directorate of School Education, Puducherry.In total, 66 schools have now been ordered to shut down due to their illegal operations. Running a school without recognition violates the "Puducherry School Education Act,

1987" and the "Pondicherry School Education Rules, 1996," she said.Under Section 18(5) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009, individuals running schools without obtaining a recognition certificate are subject to a penalty. The responsible parties face a fine of one lakh rupees, with an additional penalty of up to ten thousand rupees for each day the school continues to operate in violation of the rules.The Department has strongly advised parents to ensure their children are admitted to schools that are properly accredited by the Directorate of School Education, Puducherry, to avoid potential issues and ensure compliance with local education

MYSURU: The BJP-JDS alliance winning a majority of seats in the recently-concluded Lok Sabha elections and delivering its best performance in the Vokkaliga-dominated Old Mysuru region, has made the Congress rethink about holding the much-awaited elections to Bruhat Bengaluru Mahanagara Palike, Mysore City Corporation and zilla and taluk panchayats. Though there was pressure from within the party to hold BBMP, corporation and zilla panchayat polls, the Lok Sabha election verdict has dented the morale of Congress leaders and workers. As the BJP-JDS managed to get the lead in 146 assembly segments, BJP and JDS camps are in an upbeat mood and have further cemented their alliance, announcing they will go together in the panchayat elections.

Sources in the Congress revealed that legislators and leaders are in no hurry for elections as an internal survey does not give a favourable opinion. The BJP-JDS would do well in southern districts and wrest power in corporations and panchayats if elections are held now, with its seat-sharing arrangements.Mysuru City Congress leaders had prevailed on Chief Minister Siddaramaiah to hold the corporation election ahead of Lok Sabha elections, claiming they would win more than 35 of 65 wards. The Congress had won 24, BJP 21 and JDS 18 wards in the corporation. But BJP MP Yaduveer Krishnadutta Narashimaraja Wadiyar's emphatic win has made Congress leaders change their tone.

- A senior leader said despite putting up a good fight in the Lok Sabha election, Congress will find it difficult to win more than 12-13 wards if elections are held now. BJP has managed to improve its vote share from 53,000 to 62,000 votes in Hindu-dominated areas like NR Mohalla, Kesare, Yaraganahalli, Raghavendra Nagar and others.
- Congress legislators in Mysuru, Mandya, Kolar and other districts are also not in favour of zilla and taluk panchayat polls as JDS and BJP candidates have not only won but also got the lead in a majority of assembly segments. Pleading anonymity, they said the tempo of the BJP-JDS victory would subside in a few months, and the Congress has started holding booth and ward-level meetings to introspect and organise the party.
- Though zilla and taluk panchayat elections depend on local issues and local candidates, they feel it is best not to rush, as the JDS is ready to compromise to any extent with the BJP to defeat the Congress. Legislators and leaders in Bengaluru have also expressed their opinion to the CM on Congress prospects in the Palike election.Sources said JDS leaders GT Deve Gowda, Sa Ra Mahesh and others

A street library is a library, built by a corporation or any local body, on a vacant space beside a road to

The library in Officers Colony was constructed at a cost of Rs 20 lakh and can stock about 500 books. It was opened in December 2018. Free run for online taxis in Kerala as Vehicle Aggregator Policy fails to take off

the state government issued an order formulating the State Motor Vehicle Aggregator Policy, based on the Motor Vehicle Aggregator Guidelines-2020 of the Union Ministry of Road Transport and Highways (MoRTH), there is still confusion surrounding its implementation. The policy aims to streamline the operation of public transport vehicles, particularly online taxi services. While the motor vehicles department (MVD) says further clarity is needed regarding the policy, many online taxi vehicles have failed to obtain Meanwhile, the taxi drivers' union has approached the necessary aggregator licence, which is essential for safeguarding the rights of both passengers and drivers. Despite the existence of the government order, compliance with this requirement has been lacking.It was on November 27, 2020, that MoRTH shared the Motor Vehicle Aggregators Guidelines-2020, with the state governments and Union territories so that they could use it for issuance of licences as well as regulating the business being conducted by the Cab Aggregators (CA). After four years, on April 8, Kerala rolled out its aggregator policy 'to ensure the conduct of responsible, effective and efficient conduct of business by the aggregators and urges every statutory authority to implement this policy in letter and spirit.'

KOTTAYAM: Despite two months passing since MVD officials said that they would send a letter to the government seeking clarification on the implementation of the new policy. "The government order did not specify the authority responsible for issuing aggregator licences. According to the order, it will be either the government or an authority appointed by the government that will determine the licence issuing authority. We will soon send a letter to the government seeking clarification on the matter," said an official.

> the government and MVD seeking urgent action to ensure the strict enforcement of the aggregator policy throughout the state. "Currently, online taxi services, including Uber and Ola are operating unauthorisedly without aggregator policy. It is imperative that measures are taken promptly to address the situation and uphold the standards set forth in the State Motor Vehicle Aggregator Policy," said Manoj Pallikkunnel, chief patron, Keraleeyam Taxi Drivers Organisation. The new policy ensures various safety measures for passengers including ensuring appropriate functioning of the GPS installed in the vehicle and providing efficient resolution of any issues that may develop in its functioning.

Karnataka: After cotton candy & kebabs, lens now on pani puri

BENGALURU: Following the ban on use of artificial colours in cotton candy, gobi manchurian and recently kebabs, the state health department is now likely to regulate the sale of pani puri, suspecting that carcinogenic colouring agents are mixed with the water used in the preparations.Speaking to TNIE, officials of the Food Safety and Standards Authority of India (FSSAI) said they have collected over 200 samples of pani puris across the state and are currently awaiting the test results. A senior FSSAI official mentioned that the department collected

the samples from various spots like wedding halls and shopping malls apart from street vendors outside malls, parks, educational institutes and offices. Asked about the department's next focus in the interests of public safety, the official said there is a possibility of regulating the sale of Indian sweets.

The department is actively picking up random food samples that are often consumed, and the next target could be sweets, particularly jalebi, laddu and jahangir, which are notable for their bright colour," the official said. As festivals are approaching, the demand for sweets typically surge. At such times, sellers usually receive substantial orders. To proactively protect consumers from potential additives, stringent measures are being planned and will be implemented in advance, the official added. The continuous testing initiative not only aims to educate citizens about the risks associated with street food and the potential presence of harmful chemicals, but also serves as a warning to vendors and sellers to strictly adhere to food safety regulations.

Canada's provocations know no bounds

ON June 18, a year after the killing of Hardeep Singh Nijjar in Surrey, British Columbia, the Canadian authorities allowed a 'mock trial' in front of the Consulate General of India (CGI) in Vancouver. According to a report carried by the Canadian Broadcasting Corporation (CBC), "an effigy of Modi, dressed in prison stripes, was paraded down the street in a makeshift cage before the mock trial began". Photographs of the encaged effigy were carried in the Canadian media. This outrageous protest was organised by supporters of Nijjar, who was declared a terrorist under Indian laws a few years ago; he advocated violent secessionism. Once again, Canada ignored this while giving permission for the outrage against a foreign leader. So did the Canadian Parliament. It paid homage to Nijjar on his death anniversary. It is one matter for the Canadian Government to consider the killing of its national by proxies of foreign agents as a violation of its sovereignty and quite another for its Parliament to honour the memory of one who advocated violence. Canada simply does not get this basic fact.Canada also does not appreciate what its veteran journalist Stephen Maher has noted in his recently published book on Prime Minister Justin Trudeau, The Prince: "The dream of an independent Khalistan in Punjab, an idea long dead in India, lives on in the minds of many Canadian Sikhs." Instead of giving its people a reality check, Canada has not discouraged violence and separatism among some of its misguided people.ndia's reaction to Canada's recent provocations was subdued. The Ministry of External Affairs' spokesperson said on June 21: "We naturally oppose any moves giving political space to extremists and those advocating violence." He also reiterated the government's serious concern over Khalistani and anti-Indian activities in Canada. The spokesperson should have specifically denounced Canada for allowing the highly objectionable protest in front of the CGI. And, this occurred after Prime Minister Narendra Modi shook hands with Trudeau at the G7 summit in Italy recently. While Modi merely tweeted a photograph of his interaction, Trudeau told CBC on June 17: "Now that he is through his election, I think that there is an opportunity for us to engage, including on some very serious issues around national security and keeping Canadians safe and the rule of law". These are obviously code words for the Nijjar killing. Trudeau can hardly expect that Modi will be willing to 'engage' after what he allowed on Nijjar's death anniversary.Trudeau has subordinated his India policy to his politics. Canadian Sikh votes are vital for his Liberal Party. Maher notes in The Prince: "The Liberals want Sikh votes. The Conservatives are after the Hindus." Besides, Trudeau is dependent on Jagmeet Singh's New Democratic Party for a majority in Parliament; his own party is in a minority. Thus, more than the claim that seeking secession is not against Canadian law, it is Trudeau's political compulsions that have consistently led him to ignore India's concerns.

Soon after returning home following the G20 summit in New Delhi in September last year, Trudeau informed the Canadian Parliament that the country's agencies were "actively pursuing credible allegations of a potential link between agents of the Government of India" and Nijjar's killing. He gave no information or evidence to back his claim. Initially, he secured the support of

PLA reorganisation has implications for China's neighbours

As the conflicts in Ukraine and West Asia have shown, the battle of perception has become very important in present-day warfare to win popular support.

APPARENTLY undeterred by the turbulence in the People's Liberation Army (PLA), sparked by the disappearance of China's then Defence Minister Gen Li Shangfu and the 'removal' soon thereafter of the Commander and Political Commissar of the PLA Rocket Force and at least 11 other Generals, Chinese President Xi Jinping has effected the largest reorganisation of the PLA since 2016. It demonstrated his grip on the PLA. It showed that the PLA officers have imbibed lessons from their close study of the wars in Ukraine and Gaza. One major lesson has been the importance of propaganda and the ability to craft and shape popular perceptions. In Gaza, for example, Israel found that it lost global popular support, which had suddenly and overwhelmingly shifted in favour of Palestine. This was one backdrop that possibly precipitated the dissolution of the PLA Strategic Support Force (SSF) and the establishment of the PLA Information Support Force (ISF).

ISF. He simultaneously announced the establishment of the PLA Aerospace Support Force and the PLA Cyberspace Support Force and the dissolution of the PLA SSF. The order of precedence for the new services, important for the hierarchy-conscious PLA, was The main functions of the PLA ISF, as presently indicated as thus: the PLA Aerospace Support Force, PLA Cyberspace Support Force, PLA ISF and the Joint Logistics Support Force. Each of these is now an independent entity at the Deputy Theatre Commanderlevel, reporting directly to the Central Military Commission (CMC). They have single missions and are focused on one aspect of warfare, which would be intended to make command and control, as well as their performance, more effective. Among the reasons for the reorganisation would be that the capital-intensive PLA SSF encompassed a range of varied aspects of modern hi-technology warfare capabilities, probably making it difficult for the PLA SSF Commander to pay adequate attention to the individual specialised forces under his command. At a time of rapid advances in technology and battlefield tactics evolving on the battlegrounds in Ukraine and West Asia, which the PLA leadership has been studying and analysing very carefully, this would be an impediment to the PLA becoming a world-class military capable of fighting and winning wars. As the conflicts in Ukraine and West Asia have also shown, the battle of perception has become very important in present-day warfare to win popular support and influence outcomes. Information warfare and shaping scenarios has been noticeably prominent and successful in both these conflict zones. Reorganisation of the SSF will ensure focused attention and better utilisation of funds for each force. Since all forces are specialised, they will establish separate training establishments so that professionally competent personnel are available.



discernible, includes communications, including satellite communications, analysis of battlefield environment and target data, and maintenance, disruption and monitoring of cyber and communications channels. Many of the entities integrated into the ISF are from the SSF.Available information shows that the agencies integrated into the PLA ISF include the headquarters of the now-disbanded SSF, the Information and Communication Base, and the Information and Communication Brigades of the Xinjiang and Tibet Military Districts. Additionally, it encompasses the Target Data Battalion, Battlefield Environment Battalion, Communications Support Battalion, Spectrum Control Battalion, and the Intelligence Analysis Centre of the Joint Staff Department of the CMC. Certain functions and capabilities from the Battlefield Situation and Strategic Early Warning Sub-Centres of the Joint Operations Command Centre of the CMC, as well as the Battlefield Situation Battalion, Information Service Battalion, and Command Operations and Maintenance Battalion of the Theatre Command Joint Operations Centres, have also been integrated. Furthermore, some forces from the 35th Base and the Satellite Communications Centre of the former SSF, along with the Battlefield Environment Research Institute and the Network Information Research Institute of the Systems Engineering Research Academy of the Academy of Military Sciences, are now part of the ISF.Most personnel of these formations and units would have been retained and moved to the ISF with their

India losing ground on global research front China has surged ahead of not just India but also the US and Europe on important parameters like the publication of scientific papers.

INDIA is facing its worst-ever crisis in higher education. Admission tests for entry into medical colleges and research institutions have been affected by serious questions about the credibility of the process. Among the tests hit because of the leak of question papers is the qualifying test for research fellowships in national laboratories and lectureship in sciences in Indian universities. Top institutions like the Indian Institute of Science and Indian Institutes of Technology (IITs) depend on the National Eligibility Test (NET) for their intake of entry-level research students. Qualifying in NET is a prerequisite for PhD admissions and teaching jobs in universities. The timely conduct of the examination and its integrity have a direct bearing on the future of higher education and research in India.

While the Central Government and its agencies grapple with the unprecedented situation, the global research landscape is changing fast, and India is lagging badly behind its neighbour China. Two prestigious publications — the scientific journal Nature and the international weekly The Economist - have declared the emergence of China as a global research leader and a science superpower. India has long taken pride in possessing the world's third-largest pool of science and technology manpower and claimed success in sectors like atomic energy, space and vaccine development. This is changing. China has surged ahead of not just India but also the US and Europe as well in several key sectors and on important parameters like the publication of scientific papers. The science and technology prowess of any nation is determined by the expanse of its higher education and research infrastructure and its ability to produce high-quality research. The output can be measured in many ways — the publication of scientific papers, the number of patents, international awards like the Nobel Prize, technology transfer to industry and contribution to society. The annual listing of research leaders, published by Nature, uses research publication as its main criterion. It ranks 500 institutions based on

counts of high-quality research outputs in the last calendar year (January 1 to December 31, 2023). It is an indication of research performance at the institutional level. The list is based on the publication output in 145 natural science and health science journals selected by an independent panel of scientists. In the research output of countries, China is at the top and ahead of America, Germany, the UK, Japan, France, Canada

and South Korea. India is at the ninth position on the list. It's good news that India figures among the top 10 countries in terms of high-quality research output, and its change in share from last year is marginally higher than that of China. However, the picture gets dismal for India if we look at the institutional-level output. Of the top 10 scientific institutions globally, seven are from China. The only non-China institutions in the top 10 are Harvard (at No. 2), the Max Planck Society (ranked third) and the French National Centre for Scientific Research (seventh). The MIT (Massachusetts Institute of Technology) and Stanford University are at 14th and 15th positions, respectively. The Chinese Academy of Sciences tops the chart. Among the top 500 institutions, Indian research universities are ranked much lower -Indian Institute of Science (174), IIT-Bombay (247), Council of Scientific and Industrial Research (CSIR) as a whole (275), Tata Institute of Fundamental

Research (283), Homi Bhabha National Institute (296), Indian Institute of Science Education and Research (IISER) Kolkata (321), IIT Guwahati (355), Indian Association for the Cultivation of Science (363), IISER-Bhopal (379), IIT-Kanpur (405), IIT-Madras (407), IIT-Delhi (428), IISER Pune (439), Jawaharlal Nehru Centre for Advanced Scientific Research (450) and the

Academy of Scientific and Innovative Research How should India react to China being named the science (487). Among the research subjects in which China leads the world are physical science, chemistry and earth and environment sciences, while America and Europe retain their lead in general biology and medical research. China dominates in research papers relating to applied sciences. China has invested hugely in some big science



projects as well, like the world's largest filled-aperture radio telescope and a massive underground dark-matter detector. Several Chinese laboratories have dedicated groups working on quantum computing. In space, China is at least 10 years ahead of India, having sent its first manned spaceflight in 2003. It is already building a space station. Recently, it executed a robotic sample-return mission from the Moon

superpower or a global leader in research? An easier option, which the government has exercised in the past 10 years with such indices, is to reject the research index or point holes in its methodology. But this is not going to change the situation on the ground or alter the global perception of Indian science.

> A saner approach would be to welcome the fact that India figures in the top 10 countries and seek ways to improve that position further. We also need to see what China has done right and where it has faltered. In recent years, the Dragon has invested heavily in initiatives like the China Nine League or Project 211 to develop its universities and government labs into world-class research institutions. The Indian initiative to develop IISERs as research universities has paid rich dividends, but we need to do much more to nurture research in middle-ranking universities. China has gone wrong with the initiative to provide cash incentives for the publication of research papers, which led to unethical practices. India should refrain from doing so. The general stagnation on several fronts - research funding as a percentage of the GDP, funding mechanisms, creation of new research institutions, promotion of research in universities, and so on - is worrying. The institutions that are

supposed to generate new ideas and public discourse national science academies, the office of the Principal Scientific Adviser, the technology forecasting agency and others — appear to be in deep slumber or busy conducting celebratory events of the government by setting up selfie points. The reports on China's leadership in science should serve as a wake-up call.



Time to Notify Heatwave as Disaster? **Current Heat Action Plans Failing in Cooling Down Cities, Finds Study**

for cities and districts are ineffective in mitigating the oppressive heat that claimed hundreds of lives across India this summer, according to a recent assessment led by Delhi-based think tank iForest. Deadly heatwaves battered India during the last three months claiming hundreds of lives, despite heat action plans (HAPs) being in place in all the 23 vulnerable states/UTs. In addition to this, 200 cities/districts also have their local action plans. The team at iForest - the International Forum for Environment, Sustainability and Technology studied the action plans for nine cities and five districts and found that they mostly "consist of general information and recommendations, and are not designed for action".

According to the study, most action plans are not tailored for local heat thresholds and lack proper impact assessment on sectors like energy, power, transport, agriculture and water."The biggest drawback of the National Disaster Management Authority (NDMA) guidelines for HAP is that they are weak in implementing heat-reducing strategies. The focus is on adaptation and creating awareness. It needs to be more specific and actionable. Another problem is that it lacks financial and legal backing due to which the implementation is weak on the ground," said Dr Chandra Bhushan, President and CEO of iFOREST. Delhi records 228.1 mm rain in 24 hours, capital comes to a halt

New Delhi:Delhi has recorded 228.1 mm of rain in the past 24 hours in one of the wettest spells the capital has recorded in June, causing waterlogging in several parts of the national capital. In the three hours between 2.30 am and 5.30 am, Delhi saw over 150 mm of rainfall. The highest ever rainfall recorded in 24 hours at Safdarjung, the primary observatory of Delhi, during the month of June was 235.5 mm on June 28, 1936. The IMD is verifying the data to see if Friday's rain is the second highest ever.

Visuals shared by people on social media showed roads inundated and long traffic snarls in parts of Delhi.

Severe waterlogging on Delhi's Minto road led to vehicles being submerged. Trucks were also submerged in water at the Azad Market underpass.Visuals from Connaught Place and areas outside several metro stations showed inundated roads.

The Delhi Traffic Police said the crucial Ring Road has been impacted in both directions from Naraina to Moti Bagh due to waterlogging under Dhaula Kuan flyover.Waterlogged roads due to incessant rainfall in Noida and Ghaziabad also inconvenienced office goers. A portion of the roof of Delhi airport's Terminal 1 fell on cars during heavy rainfall in the early hours of Friday, killing one and injuring two others. As a safety measure, all departures from Terminal 1 have been temporarily halted, and check-in counters closed. "Can't Even Write...": Supreme Court Raps Bihar Teachers Over 'Skip Test' Request

- New Delhi: Panchayat teachers from Bihar government schools who went to the Supreme Court seeking exemption from a competency test introduced by the state government in 2023 - if they want to continue working - returned home empty-handed.
- The Supreme Court in strong remarks criticised the teachers for even thinking they can skip the competency test, and upheld the state law."Is this the level of education in the country? A postgraduate who gets a job and cannot even write an application for leave? When a state like Bihar tries to improve this system and conducts a qualifying examination for this, it is opposed," Justice BV Nagarathna said on the petition filed by the nonprofit Parivartankari Prarambhik Sikshak Sangh.

The Konark Sun Temple is a marvel of Eastern Indian architecture and a symbol of India's heritage. This famous tourist spot features a massive temple dedicated to the Sun God. The name 'Konark' combines two words: 'Kona' meaning 'Corner' and 'Arka' meaning 'Sun', translating to 'Sun of the Corner'. Positioned on the northeastern corner of

Puri, the Konark Sun Temple is also known as Arka Khetra. It stands as a significant cultural and historical site, attracting visitors from around the world. Many people would consider the wheel structure carved on the walls of the temple a mere representation of decorative architecture, but the fact is it is way more scientific than on may think. There is a story relating it, an old yogi was seen calculating the time using the essence of the wheels. This revealed that the wheel is a sundial and it depicts the time according to the movement of

sunlight throughout the day.

The large sundial consists of 8 major spokes and similar 8 thin and minor spokes. The major ones divide the time of 24 hours into 8 parts, of 3 hours each and the minor spokes divide this 3 hours into 1.5 hours or 90 minutes each. Beads between the spokes divide the time further by 3 minutes each. But the question is when the sunlight crosses the temple? There is another similar sundial structure on the other side wall of the temple which is for another half of the day.

What after the day?

The Temple also has 24 similar dials considered to be time calculating in the night and hence said as the moondials. The temple was built in the shape of a massive chariot with 7 horses tied to it, depicting the 7 days of a week. The Konark sun temple faced the turbulence of time and some big invaders trying to destroy the architectural site. It is said that the present-day structure of the temple is only the front half part. The major part has been destroyed which was the Garbhgrih structure according to the architectural plan.


1. Bind your old hard cover books together (side by side), such that it looks like a plank. You can use this as a book shelf and place them on your wall. This is a funky way of upcycling.

Bharti Airtel announces 10-21 per cent hike in mobile tariffs from July 3

New Delhi. Bharti Airtel on Friday announced between 10 and 21 per cent hike in mobile tariffs, a day after larger rival Reliance Jio announced an increase in rates. Airtel, in a release, said that the revision in mobile tariffs will be effective from July 3.

- We have ensured that there is a very modest price increase (less than 70 paise per day) on entry-level plans, in order to eliminate any burden on budget challenged consumers," the Sunil Mittal-led telecom firm said announcing the revision in mobile tariffs.
- Bharti Airtel said it has maintained that the mobile Average Revenue Per User (ARPU) needs to be upwards of Rs 300, to enable a financially healthy business model for telecoms in India."We believe that this level of ARPU will enable the substantial investments required in network technology and spectrum and offer a modest return on capital," the telco said. Among the unlimited voice plans, Airtel has raised tariffs in the ballpark range of about 11 per cent. Accordingly, rates are revised from Rs 179 to Rs 199; from Rs 455 to Rs 509; and from Rs 1,799 to Rs 1,999. In the daily data plan category, the Rs 479 plan has been increased to Rs 579 (20.8 per cent increase).

The mobile tariff hike from mobile operators comes immediately after the 10th spectrum auction, which ended in just two days with muted response from the industry.

While no further tariff hikes are expected until FY27, Morgan Stanley suggested that a 20% increase next year could boost earnings by 10-15 percent.Kotak Securities viewed the tariff hike positively, expecting competitors Bharti and Vi to follow suit, and set a target price of Rs 3,300 for RIL

Centrum Broking reiterated that industry ARPU is likely to grow at a 10-12% CAGR to Rs 300 over the next 3-4 years, considering the consolidated industry structure and higher ARPU requirements for Jio to justify significant 5G investments and a potential IPO.



RBI warns of faster private credit growth, says it risks financial stability

The Reserve Bank has wanred of the rapid growth of private credit, which has jumped over four-fold in the past 10 years, due to their growing interconnectedness with banks and nonbanking lenders, which can create vulnerabilities.Private credit is provided by non-bank lenders to corporates on a bilateral basis and the same grown fourfolds over the past ten years, the RBI said in the financial stability report Thursday. "The rapid growth of private credit and increasing interconnectedness with banks and non-banks and their opacity can



create vulnerabilities that can become systemic."The report said private credit is essentially provided by non-bank lenders to businesses on a bilateral basis, has grown four-folds over the past 10 years, emerging as a major source of corporate financing among middle-market firms that have low or negative earnings, high leverage, and lack of high quality collateral.In the report, Governor Shaktikanta Das said balance of risks for

global financial stability has improved since the past issue of the report in December 2023. The risks of a hard landing for the global economy have also abated, even though progress in disinflation has been slow and world trade continues to face fragmentation and realignment of supply chains. - Former England captain Michael Vaughan didn't mince his words when he said that the T20 World Cup is "purely set up for India" and ICC should have been a bit more "fairer" to other countries because this is not a bilateral event."Well, it's their tournament isn't it? Literally it's that. You know that. They get to play whenever they want, they know where their semifinal is, they play every single game in the morning so people can watch them at night, obviously in India on TV," Vaughan said during a podcast with Australian great Adam Gilchrist on the YouTube channel Club Prairie Fire.

New Delhi. Unbeaten India are back in a men's T20 World Cup final after a 68-run mauling of defending champions England in a lopsided semi-final in Guyana. India's pursuit of an ICC title appears on track after Rohit Sharma and his men bowled England out for 103 after first posting 171 for 7 in Providence, Guyana. The mismatch from Adelaide 2022 was turned on its head and the title clash against a formidable South African team presents an opportunity for India to break their ICC trophy drought.

India faced a daunting challenge batting first in the semifinals, having previously lost all five ICC tournament encounters under similar circumstances since 2021. However, crucial contributions from Rohit Sharma (57), Suryakumar Yadav (47), and a stellar performance by Axar Patel with three early wickets ensured India's comprehensive victory over England by 68 runs.Rohit-led India also achieved a remarkable hat-trick, reaching the final of all three major ICC tournaments in one year: the World Test Championship, the ODI World Cup, and the T20 World Cup. With this achievement, Rohit Sharma also tags along with former New Zealand skipper Kane Williamson in the elite club of captains, who have led their national cricket teams to ICC Finals across all formats—Tests, ODIs, and T20Is.

CAN ROHIT ACHIEVE REDEMPTION? The Indian fans had to suffer twin heartbreaks at the hands of Australia, first in the WTC final in England and then the 2023 World Cup final at home. But now, the unbeaten

run presents Rohit an opportunity to finally redeem himself after losing two ICC finals albeit in different formats. When asked about the title drought, Rohit has vowed to bring the trophy home, expressing confidence in his team's ability to deliver a strong performance in the upcoming final. "It is a very satisfying win. Everybody worked incredibly hard, and we adapted well to the conditions, which has been our recipe for success. When you play according to the conditions, everything falls into place. Initially, we aimed for 140-150 runs, but as partnerships developed, we pushed for 20-30 runs more. Our bowlers were exceptional, executing their plans effectively, particularly our spinners who capitalized on the conditions by targeting the stumps.'
