New Delhi, July 2: A court here on Tuesday granted twohour custody parole to Kashmiri leader Sheikh Abdul Rashid to take oath as a Lok Sabha MP on July 5. Rashid, also known as Engineer Rashid, was elected from Baramulla seat as an independent candidate defeating National Conference leader Omar Abdullah in the recent Lok Sabha polls. He was arrested in a 2017 Jammu and Kashmir terror funding case. Rashid had moved the court seeking interim bail, or custody parole in the alternative, to take oath and perform his parliamentary functions. Additional Sessions Judge Chander Jit Singh allowed custody parole for two hours on July 5 to enable him to take oath. A detailed order is awaited. On Monday, the NIA's counsel did not oppose Rashid's plea and said his oath

taking should be subject to some conditions like not speaking to the media and completing all formalities within a day. Rashid has been in jail since 2019 after he was charged by the NIA under the Unlawful Activities (Prevention) Act for his alleged involvement in a terror funding case. He is currently lodged in Tihar jail. The former MLA's name cropped up during the investigation of businessman Kashmiri Zahoor Watali, who the NIA had arrested for allegedly funding terrorist groups and separatists in the Kashmir valley. The NIA had filed a charge sheet against several individuals, including Kashmiri sepa ratist leader Yasin Malik

116 dead in stampede at religious congregation in UP's Hathras Simmi Kaur Babbar

Hathras, July 2: A stampede at a reli-

gious congregation here killed 116 people on Tuesday as devotees suffocated to their deaths and bodies piled atop each other in the worst such tragedy in recent years. The stampede took place as people headed home after a 'satsang' in the district's Phulrai village, conducted by a preacher known as Bhole Baba. Twentyseven bodies were brought to a hospital in neighbouring Etah district. Senior Superintendent of Police Rajesh Kumar Singh said 23 of them were women. And 89 lay dead in Hathras itself. Aligarh Range Inspector General of Police Shalabh Mathur put the death toll at 116. Victims, dead or unconscious, were brought to the Sikandara Rao Trauma Centre in trucks and 'tempos'. The bodies lav scattered outside the health centre as people milled around them. One video clip showed a woman crying, sitting amid five or six bodies in a truck. Another showed a man and a woman lifeless in another vehicle. Clips before the stam-

Lufthansa plane experiences fire in wheel after landing at Delhi airport

New Delhi, July 2: A Lufthansa wide-body

A380 aircraft from Munich experienced fire in one of the wheels during landing at the Delhi airport on Monday night, according to sources. The aircraft, which operated flight LH 762, landed safely at the Indira Gandhi International Airport (IGIA). Since the plane had to undergo checks and spare parts were not immediately available, the return flight to Munich was cancelled, they added. Sources said there were around 490 passengers on board the aircraft, which made a controlled landing at the airport. "While LH762 landed safely in Delhi, a short term technical deregistration of the aircraft was required due to the lack of availability of spare parts after a controlled landing. Safety is our top priority at Lufthansa," an airline spokesperson said in a statement on Tuesday. Sources said the fire was noticed in one of the wheels during landing. Further, sources said that due to the incident, the return flight LH 763 was cancelled after boarding passes were issued to the passengers. The Lufthansa spokesperson said the aircraft DAIMC is scheduled to operate flight LH 763 from the national capital to Munich on July 3.

When they turned back, some slipped. Sikandra Rao police station SHO Ashish sang'. Another eyewitness, who left the place before the 'satsang' ended, said the arrangements were not adequate, given the number of devotees. Agra's additional director general of police and Aligarh divisional commissioner are part of a team that would probe the incident, the state government said. The team has been asked to give its report in 24 hours. Amid his reply to a two-day debate in Parliament on the motion of thanks on the President's address to both Houses of Parliament, Prime Minister Narendra Modi condoled the deaths. "In the midst of discussions, I have also been given sad news. It has come to my attention that there have been many tragic deaths in a stampede in Hathras, UP," he said in the Lok Sabha. The prime minister said senior officials of the central government are in constant contact with the Uttar Pradesh administration to coordinate aid efforts. On social media, President Droupadi Murmu said the news was heart-rending. Congress president Mallikarjun Kharge expressed sadness.

CJI-led Bench to hear on July 8 petitions seeking scrapping of NEET-UG 2024

New Delhi, July 2: A three-judge Bench led by Chief Justice DY Chandrachud will hear on July 8 petitions seeking scrapping of NEET-UG for alleged paper leak and irregularities. According to the cause list for July 8 uploaded on the top court's website, as many as 26 petitions were listed before the CJI-led Bench - which also included Justice JB Pardiwala and Justice Manoj Misra. So far, the top court has refused to stay the counselling of the successful candidates for admissions to MBBS, BDS and other courses. Around 24 lakh students appeared for NEET-UG 2024 conducted on May 5 by the NTA across 4,750 centres in 511 cities and 14 centres abroad for admission to MBBS, BDS, AYUSH and other related courses in more than 700 government and private institutions. As many as 67 students got a perfect score of 720 out of 720 and some of the Rank 1 holders had the same sequence of roll numbers, which raised

suspicion of malpractice and irregularities. The majority of them were from the same examination centres in Rajasthan (11), Tamil Nadu (8), Maharashtra (7), Haryana (6) and four each from Andhra Pradesh and Bihar. In 2019 and 2020, there was one

Selective expunction defies logic, expunged remarks be restored: Rahul Gandhi

New Delhi, July 2: Leader of Opposition in Lok Sabha and Congress MP Rahul Gandhi has written a letter to Lok Sabha Speaker Om Birla, expressing his concerns over the expunging of significant portions of his speech during the Motion of Thanks on the President's address on Monday. 'Truth can be expunged in Modi's world': Rahul Gandhi after portions of his Lok Sabha speech deleted In the letter, Gandhi expressed his shock and disappointment at the manner in which his remarks were removed from the official proceedings, suggesting that this action under




mines the principles of parliamentary democracy and the rights of elected representatives. Gandhi acknowledged that while the Chair has the authority to expunge certain remarks as per Rule 380 of the Rules of Procedure and Conduct of Business in Lok Sabha he argued that the expunged portions of his speech did not violate this rule. "I am, however, shocked to note the manner in which considerable portions of my speech have been simply taken off from the proceedings under the garb of expunction," Gandhi wrote. He included relevant portions of the uncorrected debates of Lok Sabha dated July 2 to substantiate his claim. Gandhi emphasised that his expunged remarks reflected ground realities and factual positions, asserting his right as a member of the House to speak freely as enshrined in Article 105(1) of the Constitution of India. "Every member of the House who personifies the collective voice of people whom he or she represents has the freedom of speech... It is every member's right to raise people's concerns on the floor of the House," he asserted. He further stated that the removal of his remarks from the records goes against the core principles of parliamentary democracy. In his letter, Gandhi drew attention to a perceived double standard in the application of expunction rules. He pointed out that BJP MP Anurag Thakur's speech, which contained numerous allegations, had only one word expunged. "With due respect to your good self, this selective expunction defies logic," he noted, implying a bias in the handling of parliamentary speeches.

New Delhi, July 2: Prime Minister Narendra Modi on Tuesday mounted a stinging counterattack on Leader of Opposition Rahul Gandhi as he mocked him as 'balak buddhi' (childish mind), accused him of linking Hindus with violence and making false claims in Lok Sabha, and sought stringent action against him to protect parliamentary democracy. Replying to a nearly 18-hour-long discussion on the Motion of Thanks on the President's Address in the Lower House, Modi said the Congress and its "ecosystem" are working day and night to impress upon people that the BJP-led NDA has been defeated in the elections despite voters handing his government a historic third-term for stability and continuity. "I will tell Congress leaders not to suppress people's mandate under the garb of fake victory celebrations," he said and added the opposition party was behaving as if it

CBI seizes Rs 1.59 crore cash in Mumbai Passport corruption ring case

New Delhi, July 2: The Central Bureau of Investigation (CBI) seized Rs 1.59 crore cash and crucial digital evidence during its three-day search operation after busting a corruption racket in Mumbai's Passport Seva Kendras, officials said on Tuesday. After registering 12 cases on Friday against 14 officials of Passport Sewa Kendras (PSKs) of Lower Parel and Malad, and 18 touts and middlemen, the CBI began a massive search operation in Mumbai and Nashik, which continued until Monday. Besides the cash, the CBI stumbled upon five diaries containing alleged details of transactions and crucial information about the bribery ring, they said. The agency has alleged that the accused officials and middlemen indulged in "collusive corruption," allowing passports to be issued based on incomplete documents or manipulating the particulars of passport applicants. The alleged activities of the officials and the middlemen were detected dur-

ing a joint surprise check at the PSKs conducted by the vigilance wing of the External Affairs Ministry and the CBI. The office desks and mobile phones of the suspect officers were analysed. "The analysis of documents, social media chats and Unified Payments Interface ID activities of suspect public servants had revealed various suspicious transactions by some officials of PSKs indicating demand and acceptance of undue advantage through the passport facilitation agents for issuance of passports as well as to get passports issued based on inadequate/fake/forged documents," a CBI spokesperson said after the registration of the FIR. The agency alleged that the PSK officials, in connivance with touts, were allegedly receiving huge monetary undue advantages directly in their own bank accounts or in the bank accounts of their family members to the tune of several lakhs of rupees, he said.



Three soldiers from Andhra among five killed in Ladakh

VIJAYAWADA: Mortal remains of three soldiers of the Indian Army, who died on Saturday while withdrawing from a military training activity that involved crossing the Shyok River at the Daulat Beg Oldi (DBO) area of eastern Ladakh, reached Vijayawada International Airport in Gannavaram on Monday afternoon.A special plane of the Indian Air Force arrived at the airport from Gwalior. On behalf of Andhra Pradesh Governor S Abdul Nazeer, Major Deepak Sharma laid a wreath and paid tributes to the brave soldiers at the airport. Later, bodies of the soldiers were shifted to their native villages in three special vehicles.Members of the 52 Armoured Regiment, the soldiers had participated in a routine exercise on Saturday (June 28). While crossing the River near Mandir Morh, 148 kilometres from Leh on their T-72 tank, the water levels suddenly began to rise and soon the tank and the soldiers were washed away due to the strong current. Three soldiers from Andhra Pradesh - Risaldar M Ramakrishna Reddy from Kalavapalli village in Prakasam district, Havildar Subhan Khan from Islampur in Bapatla district, and Craftsman Sadaraboina Nagaraju from Chevendra village in Krishna district — lost their lives. Two other soldiers also died in the incident.As per reports reaching here, Sadaraboina Nagaraju (32) joined the Armed forces seven years ago. He is survived by his wife, Mangadevi, and a daughter. Nagaraju joined the Army, taking inspiration from his elder brother Sivayya, who is also in the Armed forces.Born to a patriotic couple, Dhanalakshmi and Venkayya, the brothers are role models for the villagers.

17 per cent coral bleach in Gulf of Mannar Marine National Park, but recovery on

CHENNAI: A comprehensive rapid assessment conducted at the Gulf of Mannar Marine National Park has revealed that 17% of coral reefs have bleached due to the unprecedented marine heatwave that triggered a global coral bleaching event. However, the good news is that the corals have shown resilience and are currently in recovery. Predominantly, fast-growing coral genera such as Acropora, Montipora and Pocillopora and slow-growing genera like Porites, Platygyra and Dipsastraea have been bleached. In Palk Bay, 14% of live corals have bleached.Considering the kind of abnormal ocean temperatures observed between April to May this year, Tamil Nadu forest officials and experts feared there would be mass coral mortality, which would be detrimental for the ecosystem and fisheries production. However, the situation is not that bad as ocean temperatures have retracted to threshold levels allowing the bleached corals to slowly recover. Additional Chief Secretary of Environment, Climate Change and Forests, Supriya Sahu, said the threshold level for Gulf of Mannar and Palk Bay corals is 30 degree Celsius. In April, the water temperature was 33.0-33.70°C.

Temperatures remained very high between 33.5°C and 34°C until mid-May, after which they decreased due to rainfall and winds, currently ranging from 28.5-31.5°C," she noted. The latest survey conducted from May 27 to June 5 included



all 21 islands in the Gulf of Mannar and four reef sites in Palk Bay.

The survey was done by Suganthi Devadason from the Marine Research Institute (SDMRI), who confirmed that Exposed skeletons branched coral reefs are beginning to Corals rely on single-celled algae called recover. The NOAA Coral Reef Watch, which initially issued a red alert for the Gulf of Mannar in April, has also predicted cooler temperatures for the Gulf of Mannar supporting this recovery.

Amid transition concerns, Kerala police welcome new criminal laws

KOCHI: Amid anxieties over the new criminal laws — Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS) and Bharatiya Sakshya Adhiniyam (BSA) — that came into effect on Monday, the state police has given its thumbs up to the transition. Compared with the Indian Penal Code (with 576 sections in total), the BNS has 358 sections, with provisions for 20 new crimes. The clubbing of similar sections into defined categories and the training given to impose the laws will aid in their execution, several officers said.

A mobile application of the National Crime Records Bureau, NCRB Sankalan, helps officials and the public understand the changes, an officer said. "BNS has a lot of modifications. But we have had familiarisation classes. Difficulties may arise when we implement the new laws," an SHO-ranked officer said. Various sections under IPC have been numbered differently under BNS. Cases related to grievous harm, property, and offences against woman are sorted in their respective sections. An officer can easily adapt to these modifications, he said. "The facility to determine the new sections in the FIR-registering software also helps," he added. Responding to the transition, Ernakulam Rural police chief Vaibhav Saxena said, "Police officers have received specialised training on BNS. We don't anticipate any complications, and there is clarity in enforcing the law," he said."BNS came into effect on July 1. So, a crime that happened or was reported before July 1 will be registered under sections of the IPC, but the investigations will follow BNS," added Saxena.

Kochi commissioner S Syamsundar said, "Officers have been well trained in executing the new criminal laws. The guidelines and tables related to BNS were made available to all stations." We are fully prepared for this transition, he added.

Kondotty registers first FIR under BNS in Kerala

In Kerala, the first case under BNS was registered at Kondotty police station, in Malappuram. The case was registered against a two-wheeler rider for reckless driving and endangering human life at 12.20 am on Monday. The FIR was registered under section 281 of BNS and Section 194 D of the Motor Vehicle Act. Section 173 of BNSS was also slapped

In Kochi, auto drivers first to be booked under BNS

A 54-year-old auto-rickshaw driver was the first to be booked under BNS in Kochi city police limits. East traffic police booked the man from Chengampuzha Nagar at 9.25 am on Monday on charges of rash and negligent driving, and drunk driving as to endanger human life. Section 194 D of the Motor Vehicle Act was also imposed. However, the auto driver told TNIE that he was merely parking the vehicle when he was questioned by police outside a workshop at Kalamassery Aryaas Junction. "I work in the meat market, I got drunk after completing work early on Monday," he added.

Small shops, houses to get EB connection without building completion certificate in TN

COIMBATORE: The state government Exemption from these norms is given only has passed an order allowing small commercial buildings and houses to get new electricity connection without submitting building completion certificates from the local bodies.The exemption is given to residential buildings not exceeding either eight dwelling units or 750 square metres (8,073 square feet) of built-up area and for commercial buildings not exceeding 300 sq m (3,229 sq ft) area and 14 meters (45 feet) in height, states the G.O.This news is a great relief for many shop owners who have been unable to obtain Electricity Board connections for several years. Applications seeking new connections, particularly for commercial use, have been pending for months in several offices across the state due to the norms prescribed by the Tamil Nadu Combined Development and Building Rules, 2019.As per the existing rule, to get a new power connection for a commercial establishment, the owner must submit the building completion certificate and the building plan approval from the local body.

The exemptions came into force in February 2020 and since then several applicants who built their establishments above the limit have been waiting to get new connections.

However, many could not produce the building completion certificates as they had reportedly violated the plan while

KOCHI: When it comes to the fear of snakes, this seems the season of double jeopardy! The arrival of monsoon, following the delayed mating season of the slithering reptiles, has the public worried about the increased chance of snakebite.

Moreover, misconceptions related to snakebite, the unscientific handling of such a situation, missteps that follow, lack of knowledge about whom to contact in case of an emergency, etc., contribute to worsening the overall situation."In a city like Kochi, snakes are usually forced out of their hideouts during the monsoon by waterlogging. We respond to any emergencies," says Sreenivas P Kamath, the Ernakulam district facilitator of the Snake Awareness Rescue and Protection (Sarpa) team. In case a Sarpa volunteer cannot reach your location, they will share a message with the authority concerned in the forest department and take appropriate measures, he says. "There are around 180 licensed rescuers in the Ernakulam range. Of this, more than 60 Sarpa volunteers will be involved in rescue at any given time. They are well-trained in catching snakes," says Sreenivas. "When a Sarpa volunteer catches a snake, it is handed over to the Ernakulam

social forestry division.



Following a rescue in a farflung area, the rescuer himself becomes the custodian of the snake for a short period. The animal is then shifted to the forestry team," he points out. Prior to 2019, on average over 110 people died from snakebite every year in the state. This has declined to 44 after the functioning of Sarpa," says Sreenivas. Team members are volunteers who don't take any remuneration, he adds.

Dr Sandeep Das, a herpetologist and post-doctoral fellow, points out that there are around 130 species of snakes in the state, but only four spectacled cobra, common krait, Russell's viper, and sawscaled viper — are dangerous enough to cause human deaths. "There are another 20 snakes, including the hump-nosed pit viper, commonly seen in Kerala, that are venomous. But their venom is not strong enough to harm people," he said.Until 2020, approximately 50,000 to 60,000 people died every year in the country from snakebite.

The death rate in Kerala has been much lower than the national average, Sandeep adds.While appreciating improvements in medical facilities and public awareness, he bemoaned the misconceptions related to snakebite. "Anti-venom is the only treatment for snakebite. Herbal

therapies, outdated medical practices, and irrelevant delaying of treatment will worsen the condition of a patient."Pressure bandaging helps encourage blood clotting, but sometimes it works to the detriment, by causing a blood surge. Delaying treatment to identify the animal that caused the bite will only worsen the health condition of victims," the Sarpa master trainer added.Highlighting the rise in snakebite cases during the monsoon, Muhammad Anwar Yunus, the assistant conservator of forests with the biodiversity cell, said, "The breeding season of snakes is usually from March to April, but this year it got delayed to May-June. This also delayed their search for appropriate hideouts, which is reflected in the number of snakebite cases."There has been an increase in baby viper bites in recent days. But fatalities have dropped as a result of proper medical consciousness, he said.

47 per cent of urban families conned financially in Bengaluru

BENGALURU: A recent survey has revealed that 47 per cent of urban Indian families have experienced some type of financial fraud, with 53 per cent reporting that they or someone in their immediate family have been a victim in the past five years. The survey, conducted via 48,000 responses from citizens across 367 districts and found that six in 10 Indians do not report financial frauds to regulators or law enforcement agencies when the value is under Rs 1,000, so 90 per cent remains unreported. The survey identified credit/debit card and UPI fraud, buying or selling classified site users, and bank account fraud as the top types of financial cheating experienced by families. The findings highlighted that 17 per cent of citizens admitted to storing important

passwords (ATM, debit/credit cards, bank accounts, app/play store) on their mobile devices, making them highly vulnerable to data theft. In terms of password storage, about 34 per cent of citizens admitted to sharing important passwords with someone else, typically a family member. LocalCircles platform, gathered over On storing of important passwords, 9 per cent of respondents indicated that they store passwords in mobile phone notes, 4 per cent in mobile phone contact list, 4 per cent in a password app on the phone, and 4 per cent in any other app. Additionally, 5 per cent keep them in their wallet or purse, 14 per cent have them memorised, and 16 per cent store them on their computer. The survey also found that Aadhaar card, PAN card and driving licence are the top three identities shared by citizens for various applications, proofs, bookings and stays



over the past five years.

Car crashes into canter-truck on KMP Expressway, four of a family die; two injured

NEWS BOX

GURGAON: Four people died, and two others suffered severe injuries as a Maruti Ertiga collided with a canter-truck on KMP Expressway in Farrukhnagar on Monday afternoon. The impact of the collision was so severe that the car was completely shattered.

According to witnesses, both vehicles were travelling in the same direction when the accident occurred. The driver of the Ertiga was attempting to overtake the canter-truck at high speed, while the latter was trying to exit the expressway. The car driver, unfortunately, failed to react in time and crashed into the truck's rear side. The truck driver is on the run.



After the collision, the car flipped several times before coming to a halt and breaking apart. Among the six family members, four -- Brijesh Kaushik (52), his wife Sunita (48), his mother Kamla Devi (74), and his sister-in-law Kiran Kaushik (46) - lost their lives on the spot, while two others are in critical condition, cops said.Bystanders quickly rushed to their aid, contacted the police and hailed ambulances. Cops arrived at the spot and immediately transported the passengers to hospital. The family from Rajasthan's Sikar was on their way back from Garh Ganga after attending the last rites of a relative. They were being followed by relatives in another vehicle. "A preliminary investigation has revealed that the car driver was trying to overtake the canter when it rammed into it and overturned. The injured are undergoing treatment at the govt hospital in Sector 10," said police spokesperson Sandeep Kumar.

CO level in city 68 times higher than safe limit, says **CPCB** data

Gurgaon: The city has been experiencing an unusual shift in its air pollution profile recently, with carbon monoxide (CO) emerging as the lead pollutant, surpassing usual concerns of particulate matter such as PM 10 and PM 2.5. The CO levels in the city is over 68 times the permissible limit in the past seven days, according to the Central Pollution Control Board (CPCB) data. The CO concentration between June 24 and June 30 varied between $114\mu g/m^3$ and $168\mu g/m^3$, while the safe limit is $1.7\mu g/m^3$. The city's authorities are being called upon to take immediate measures to curb waste burning incidents and enforce stricter waste management protocols. Joe Biden on immunity ruling for Donald Trump: There are no kings in America

- **Washington** US President Joe Biden on Monday criticized the Supreme Court ruling on presidential immunity that was seen as a win for his rival, former President Donald Trump, in forceful remarks from the White House.
- The US Supreme Court found on Monday that Trump cannot be prosecuted for any actions that were within his constitutional powers as president, but can be for private acts, in a landmark ruling recognizing for the first time any form of presidential immunity from prosecution."This nation was founded on the principle that there are no kings in America," Biden said, adding that no one is above the law. With the Supreme Court decision, he said, "That fundamentally changed."Biden is running for re-election against Trump and has been sharply critical of his rival's actions related to the January 6, 2021, raid on the US Capitol by Trump's supporters, who believed Trump's false claims that he had won the 2020 election.
- Biden, 81, was making his first set of remarks at the White House since his shaky debate against Trump last week led to calls for him to step aside as the Democratic Party's standard-bearer for the election.
- After he stumbled over his words on the Atlanta debate stage, his remarks and comportment will be scrutinized for signs that he is up to the job of running for re-election and of governing the country for four more years.

Five members of Georgia family killed after plane crashes in New York

Masonville, New York Five members of a family from Georgia who were visiting Cooperstown, New York, for a baseball tournament died when their small plane crashed in a wooded area of upstate New York, authorities said Monday. The single-engine Piper PA-46 crashed around 2 pm Sunday after taking off from Albert S. Nader Regional Airport in Oneonta, the Federal Aviation Administration said in a statement. The wreckage of the plane and the remains of the five people on board were found Sunday night in the town of Masonville, the New York State Police said in a news release. Drones, allterrain vehicles and helicopters were used to search for the remote crash site, which was about 125 miles (200 kilometers) northwest of New York City. The victims were identified as Roger Beggs, 76; Laura VanEpps, 43; Ryan VanEpps, 42; James VanEpps, 12; and Harrison VanEpps, 10.The family was returning to Georgia after attending a tournament in Cooperstown, the home of the Baseball Hall of Fame, police said. The plane was headed to Cobb County

Palestinian group Islamic Jihad fires rockets into Israel, no casualties reported

Cairo. The Palestinian militant group Islamic Jihad fired a barrage of rockets into Israel on Monday as fighting raged in Gaza and Israeli tanks advanced deeper in parts of the enclave, residents and officials said.

Islamic Jihad, an ally of Hamas - both of whom are backed by Iran - said its fighters fired rockets towards several Israeli communities near the fence with Gaza in response to "the crimes of the Zionist enemy against our Palestinian people". The volley of about 20 rockets caused no casualties, the Israeli military said. But the attack showed militants still possess rocket capabilities almost nine months into an offensive that Israel says is aimed at neutralising threats against it.Residents of several neighbourhoods in eastern Khan Younis, which is in southern Gaza, said they had received audio messages from Israeli phone numbers ordering them to leave their homes."For your safety, you must evacuate immediately to the humanitarian zone," army spokesperson Avichay Adraee posted on social media platform X in a

call to residents and displaced people living in those areas. Some suggested this could mean Israeli forces will return to the area, which they left several weeks ago. The Israeli military said in a statement earlier on Monday the rockets were fired from the Khan Younis area.Prime Minister Benjamin Netanyahu said Israel was nearing its goal of taking out the military capabilities of Hamas, the Islamist group that governs Gaza and led the Oct. 7 assault on Israel that sparked the war. Less intense operations would continue, he said."We are advancing to the end of the phase of eliminating the terrorist army of Hamas, and there will be a continuation to strike its remnants," Netanyahu said.Violence also flared on Monday in the Israeli-occupied West Bank, where the Palestinian health ministry said a woman and a boy were killed in the city of Tulkarm during an operation by Israeli forces. A day earlier, an Israeli strike in the same area killed an Islamic Jihad member.In some parts of Gaza, militants continue to stage attacks on Israeli forces



in areas that the army had left months ago. Israeli tanks deepened incursions into the Shejaia suburb of eastern Gaza City for a fifth day, and tanks advanced further in western and central Rafah, in southern Gaza near the border with Egypt, residents said. The Israeli military said it had killed a number of militants in combat in Shejaia on Monday and found large amounts of weapons there. Hamas said its fighters had lured an Israeli force into a booby-trapped house in the east of Rafah and blown it up, causing casualties. The Israeli military announced the death of a soldier in southern Gaza without providing details. Israel's Army Radio said the soldier was killed in Rafah in a booby-trapped house - a possible reference to the incident reported by Islamic Jihad. Also in Rafah, the Israeli military said that an airstrike killed a militant who fired an anti-tank missile at its troops.Israel has signalled that its operation in Rafah, meant to stamp out Hamas, will soon be concluded. After the intense phase of the war is over, its forces will focus on smaller scale operations meant to stop Hamas reassembling, officials say. The war began when Hamasled fighters burst into southern Israel on Oct. 7, killed 1,200 people and took around 250 hostages, including civilians and soldiers, back into Gaza, according to Israeli tallies. The offensive launched by Israel in retaliation has killed nearly 38,000 people, according to the Gaza health ministry, and has left the heavily built-up coastal enclave in ruins. The Gaza health ministry does not distinguish between combatants and non-combatants, but officials say most of the dead are civilians

US heightens security alert at European bases due to multiple threats

Washington The US military has raised the security protection measures it is taking at its bases throughout Europe, asking service members to be more vigilant and keep a lower profile due to a combination of threats it is seeing across the region.US European Command said in a statement Sunday that a "variety of factors play into the safety of US military community abroad."Increasing the threat level to Charlie, the second-highest of five levels for service members, is the result of a combination of events occurring across Europe, including elections in France and the UK, the upcoming Olympics and other major sporting events, and the ongoing wars in Ukraine and Gaza, according to two US officials who spoke on the condition of anonymity to provide additional details. But they said they were unaware of any specific

threat.Pentagon deputy press secretary Sabrina Singh would not say Monday whether bases in the Middle East, Africa or the Indo-Pacific were at similar increased force protection



levels. However, one of the officials said that many of those bases, especially bases throughout the Middle East and Africa, already maintain higher security levels.Force protection Charlie is instituted "when an incident occurs or intelligence is received indicating that some form of terrorist action or targeting against personnel or facilities is likely." The highest of the five levels is Delta, which applies

where a terrorist attack has occurred or when intelligence indicates terrorist action against a person or place is imminent, followed by Charlie, Bravo, Alpha and Normal, the minimum level.

Raising the threat level to Charlie means additional security measures will be in place at US military installations, but it's up to each commander's discretion

to determine what those measures are. It also means service members and their families who are living in each community should be more aware of their surroundings and maintain a lower profile, one of the officials said.

Hunter Biden sues Fox News over showing his explicit images in miniseries

New York US President Joe Biden's son Hunter is suing right-wing Fox News for airing nude images of him in a miniseries that he claims amount to "revenge porn," court documents showed Monday.

The Trial of Hunter Biden" was made up of six episodes published in 2022 on Fox Nation, the conservative broadcaster's online platform owned by the family of media mogul Rupert Murdoch.A dramatised version of a criminal trial, the series contained a warning the proceedings were fiction, depicting the first son being prosecuted for graft -- accusations that have been made for years by Donald Trump supporters who point to Hunter Biden's past business ties with Ukraine and China. The accusations have never led to legal action.But the series integrates real images of Biden, "depicting him in the nude, depicting an unclothed or exposed intimate part of him, as well as engaged in sex acts," the complaint alleges."Fox published and disseminated these intimate images to its vast audience of millions as part of an entertainment program in order to humiliate, harass, annoy and alarm Mr. Biden and to tarnish his reputation.'

The images originated from a laptop that Hunter Biden dropped off at a computer repair shop, but which he never collected.Its contents have been circulating ever since, and are the subject of widespread conspiracy theories as well as

Why did the US judge call Karen Read's cop boyfriend murder 'mistrial'

world. A Massachusetts judge in the US declared Karen Read's murder trial "mistrial" after jurors deadlocked in the case with no decision despite over 26 hours of deliberation. The court came to this conclusion after the jurors sent notes to Cannone saying they were hopelessly deadlocked. The judge delivered Tuey-Rodriguez instructions — sometimes referred to as "dynamite" instructions intended to blast apart deadlocked juries in Massachusetts, the Washington Post reported.Moments after Judge Beverly J Cannone called a mistrial, Norfolk County District Attorney Michael Morrissey's office announced that they intend to retry the case. The prosecutors said in a statement, "First, we thank the O'Keefe family for their commitment and dedication to this long process. They maintained sight of the true core of this case — to find justice for John O'Keefe. The Commonwealth intends to re-try the case," according to AP.According to the prosecutor, Karen Read, who was accused of drunkenly driving into her police officer boyfriend and leaving him to die in January 2022, was drinking with her partner O'Keefe before she dropped him off at a party at the home of Brian Albert, a fellow officer. They said she hit him with her SUV before driving away.While prosecutors were blaming her for Keefe's death, the defence lawyers tried to paint her as the victim in the case. The defence said that Keefe was killed inside Albert's home and then dragged outside and left for dead, reported Washington Post. North Korea tests missile capable of carrying super-large warhead: Report

Seou North Korea said it successfully tested a new tactical ballistic missile on Monday capable of carrying a 4.5-ton super-large warhead, state news agency KCNA reported on Tuesday. day earlier, South Korea reported the launch of two ballistic missiles by North Korea and said the second likely failed soon after launch, blowing up in flight over land. The KCNA report did not make clear if two missiles were launched and referred to the projectile in a singular term. It said the test of the new tactical ballistic missile, named Hwasongpho-11 Da-4.5, was conducted with a simulated heavy warhead to verify flight stability and accuracy. It did not elaborate on the nature of the simulated warhead.North Korea's report on the missile test was likely "deception" with one of the two missiles flying abnormally and appearing to show up in a field not far from Pyongyang, Seoul's Joint Chiefs of Staff (JCS) spokesperson Colonel Lee Sung-jun told a briefing."Conducting a test-fire inland is extremely rare and it is highly likely to be false to claim it has succeeded," Lee said.South Korea's military conducted artillery drills at ranges within five kms

(three miles) of the Military Demarcation Line inside the Demilitarized Zone (DMZ) separating the two Koreas on Tuesday morning, an Army official said during the briefing. The resumption of such livefire exercises near the border comes following the suspension of a military pact signed with Pyongyang after the North launched hundreds of balloons carried by wind across the border that dropped trash throughout South Korea. The country's Missile Administration will

conduct another launch of the same type of missile in July to test the "explosion power" of the super-large warhead, KCNA said in a rare disclosure of a future missile launch plan.he Hwasongpho-11, or Hwasong-11, is a series of short-range ballistic missiles (SRBM) developed by the North that are otherwise known as KN-23 and KN-24.South Korea's military said on Monday the first of the two missiles launched by the North appeared to be a KN-23 that flew about 600 km (373 miles). The KN-23 is likely the missile that North Korea has supplied to Russia and was used in the war against Ukraine, according to Ukrainian



authorities who examined debris from missiles launched by Russia since December.North Korea and Russia deny any arms trade, but their ties have rapidly developed since their leaders met in September in Russia pledging closer military cooperation.Russian President Vladimir Putin and North Korean leader Kim Jong Un met again in Pyongyang in June and signed a pact on a Comprehensive Strategic Partnership that in cluded a mutual defence agreement.South Korean officials have said North Korea's recent short-range ballistic missile launches may be intended to show its wares to potential buyers. The second missile launched on Monday flew about 120 km, the South Korean military said. Given the trajectory and the location of the launch near the west coast, the missile likely fell inland in North Korea, South Korea's military said.

North Korea has raced to develop a range of ballistic missiles in recent years, which it names with the Hwasong identifier, including its intercontinental ballistic missiles (ICBM). Hwasong is Korean for

Mars.On Tuesday, KCNA reported the North's ruling Workers' Party Central Committee concluded four days of policy meetings led by its leader Kim.

Heavy rain continues to lash Gujarat, causing road closures, flooding in cities

VALSAD. Gujarat continues to experience heavy rainfall, causing significant disruptions and damage across the state. In Valsad, severe flooding has led to the closure of two main underpasses, with the city receiving 3.45 inches of rain in just two hours on Tuesday morning.

The police have placed barricades to prevent access to the flooded underpasses, and waterlogging has affected the service road of National Highway 48 in the city.

Junagadh district has also been heavily impacted, with many roads, including two national highways, closed on Monday due to heavy rain. District authorities have reported the closure of three state highways, six major district connecting roads, and 40 panchayat roads due to flooding."Three state highways in Junagadh have been closed. Once the water level goes down, the situation will be under control. In low-lying areas, we have issued alerts and closed waterlogged roads," said JP Zala, Junagadh deputy collector.

The India Meteorological Department (IMD) has predicted that parts of south Gujarat and Saurashtra may receive very heavy rains in isolated places on July 2, while heavy rain is expected to lash several parts of north Gujarat, central Gujarat, and the Saurashtra region. On July 3, the IMD has forecasted very heavy rains in "Surat, Navsari, Valsad, Daman, and Dadra Nagar Haveli. The wet spell in Gujarat is attributed to two cyclonic circulations over the north and south of the state, according to the IMD.A 'red alert' has been issued for several districts, indicating



extremely heavy rain in Surat, Navsari, and Valsad in south Gujarat, as well as Jamnagar, Porbandar, Junagadh, Dwarka, and Kutch in the Saurashtra-Kutch region.The continuous rain has caused damage to many roads in the state. In Ahmedabad Smart City, a massive sinkhole resembling a meteor crater formed when a portion of a road caved in during heavy rainfall at Shela. Waterlogging and uprooted trees have also

been reported in several places in Ahmedabad, with vehicles being damaged drop-off area of Rajkot airport collapsed on Saturday. sources said some members of the public had thrown it open. "As work is not complete, we had to stop traffic movement on the bridge," said an officer. The misalignment of the Barfiwala flyover with Gokhale bridge had drawn sharp criticism when it came to light in Feb-the day a reconstructed arm of Gokhale bridge opened to motorists. Barfiwala flyover was shut since

that day to rectify the alignment. Locals were happy happiness was short-lived. Additional municipal commissioner Abhijit Bangar said, "I will ask the leputy municipal commissioner t removed these barricades. We will be opening the connector on July 4. The load test report shows the bridge is structurally safe and we have also received a letter from VJTI to the effect," he said. Officials said the Barfiwala flyover, once open, can be used only by light vehicles. They said the reason is that it connects with the partially opened Gokhale bridge which permits light vehicles to ply to avoid load on the structure for commuter safety as it is being used for two-way traffic. The traffic department had written to BMC asking it to fulfil certain requirements before the Barfiwala connector could

be thrown open to motorists. The letter, dated June 30, asked for safety infrastructure such as a traffic signal at the location where the Barfiwala connector and Gokhale bridge meet. The letter asked for a speed breaker, a pedestrian crossing and a stop line to be constructed around 35 feet from the start of the Barfiwala flyover, at Mayor Hall signal, to the location where it connects with

Gokhale bridge. it was opened on July 1, as promised by BMC. Their Locals said it was difficult to believe the barricades could be removed by the public and it was likely there was miscommunication between authorities. The entire Gokhale bridge is proposed to be in March 2025. This is also when the second arm of Barfiwala flyover would be ready. Meanwhile, BMC is likely to build a staircase for pedestrians for East-West connectivity in Andheri.



State's Q1 GST revenue collection up by 14%

- Ahmedabad. Goods and services tax collection from Gujarat grew by 14% in the first quarter of the 2024-25 fiscal year. The state's revenues from GST stood at Rs 29,621 crore from April to June 2024, higher than Rs 26.066.48 crore collected in the same period last year, according to data from the state commercial tax department. Economic growth and improved industrial activity in addition to inflation are key factors behind the rise in the state's revenues through GST, sources told.
- This revenue includes GST, VAT, electricity duty, excise duty and business tax. In the 2023-24 fiscal year, GST collection clocked 9.7% growth to Rs 1.25 lakh crore from Rs 1.14 lakh crore in 2022-23, according to the data from the Union finance ministry.
- As the GST regime completed seven years on Monday July 1, Gujarat has fared well, clocking an average of 14% growth in tax revenues, according to sources."There is a marked improvement in economic activity in Gujarat over the past year, with revival in order volumes, greater exports, higher sales and further expansion of industries augmenting industrial growth, revenue and tax collection," said a state government source, on condition of anonymity.
- The increase in GST mop-up also reflects a disciplined taxpayer base with a greater degree of compliance in return filing and payments. At least 80% of taxpayers in Gujarat file returns before the deadline. Overall, the state's compliance is above 95%," the official added.
- In June 2024, the state revenue department received Rs 9,589 crore from EST, VAT, excise duty and business tax, a 14% increase from June 2023.Gujarat has recorded a collection of Rs 5,561 crore in June this year, which is 10% more than in June 2023.
- In FY 2024, VAT revenue from non-subsumed items was estimated to be Rs 3,149 crore, tax revenue was Rs 858 crore and business tax revenue was Rs 21 crore.

Solitary complaint filed under BNS in city on Day 1

Ahmedabad. On Sunday, 193 criminal cases were filed in the city, but there were just 13 filed on Monday (till 6pm).Of these 13, only one case was registered under the Bharatiya Nyaya Sanhita (BNS), under Section 281, which deals with rash driving.

City police said of the 13 complaints filed until 6pm on Monday, eight were under the Prohibition Act, one under the Prohibition Act and Motor Vehicles Act, one complaint under the Gambling Act, and a complaint under IPC Section 379 for theft.Three new criminal laws - the Bharatiya Nyaya Sanhita (BNS), the Bhartiya Nagrik Suraksha Sanhita (BNSS) and the Bharatiya Sakshya Adhiniyam (BSA) — came into force on Monday. These new laws have replaced the Indian Penal Code, the Code of Criminal Procedure and the Indian Evidence Act respectively. The complaints filed in the city by traffic and city police

show that the first complaint in Ahmedabad city under BNS was filed by B Division traffic police against Mukesh Dantani, a resident of Nava Vadaj. Dantani was caught driving his scooter on the wrong side of the road near the Old Vadaj Circle. This was the only complaint filed under BNS on the first day of it coming into force.Officials said that usually, if a person is caught drunk, city police register a case under IPC Section 279 (riding a vehicle in a negligent manner) along with charges under the Motor Vehicles Act and prohibition laws. However, on Monday, Isanpur police registered a case only under the Motor Vehicles Act and prohibition laws.In Odhav, a vehicle theft from the night of June 23 was reported under IPC Section 379.Officials stated that traffic police have begun a one-month campaign against wrong-side driving. During this drive, an

average of 200 complaints for driving on the wrong side were registered every day since June 22, but on Monday, just one was filed, by B Division police. This was the only complaint under BNS.Officials also said police personnel are yet to fully understand the changes in the new laws.Police remand period continues to be 15 days under BNS: Amit ShahAmit Shah highlighted the replacement of the British-era Indian Evidence Act with the BSA under the new laws. The provisions of BNS, BNSS, and BSA include a 15-day police custody within a 60-day limit, with the Delhi case resolved using the review provision.111407664

Civility a casualty in Biden-Trump debate

ANOTHER hallowed beacon of democracy died in the US last week on the day the country's two main presidential candidates in this November's election held their first debate in a cable TV studio.The independent Commission on Presidential Debates (CPD) had steered some of the mainstay quadrennial events in US presidential politics, beginning with the election to the White House in 1988. Its 36-year record has been so outstanding that presidential debates has been so butstanding that presidential debates hosted by the CPD became one of the most popular events of every presidential cycle in the oldest democracy in the world. At least 15 nations around the world, especially emerging post-Cold War democracies like Romania and Ukraine and newly born countries like Bosnia-Herzegovina, have adopted the US presidential debate model. CPD staff have worked with these 15 struggling democracies to implement its model during their presidential election cycles. This year's US presidential aspirants — Democrat Joe Biden and Republican Donald Trump — junked the CPD and opted for a studio debate at the CNN headquarters in Atlanta. For the first time, the debate was held without an audience and without its customary welcome applause for the candidates. Having been part of the foreign media contingent at 12 previous presidential debates, the revelry associated with them is memorable for this writer. Popular participation in those debates was not confined to the auditoriums where the candidates sparred. Such democracy in action eventually became folklore and legends in towns which hosted the debates. Festivities on the streets, in pubs and at debate-watch parties, combined with the serious business of politics, saw the dramatis personae in election after election travel to small towns and diverse states. The CPD debates mostly took place in universities. This, in turn, motivated young people to vote in a country where the turnout has been low for many decades. The CPD may live on in East Europe and Africa, but in the US, the institution is dead, for now.

Customary civility was a casualty during the first Biden-Trump debate of 2024. The two candidates did not shake hands like they used to amidst thundering bipartisan applause from the audience. That tradition now lies buried amidst partisan acrimony. At the two Biden-Trump debates in 2020, too, the candidates did not shake hands on the way to the lecterns. But that was under medical advice because the Covid-19 pandemic was raging at that time. Physical contact was discouraged, especially among those over 60 years of age, and social distancing was encouraged among all. The wives of the candidates did not hug each other after the debates in 2020, as was the practice because of the pandemic. Nor did they do so last week. There was no audience the spouses could be a part of to climb the podium and join their husbands at the end of the 90-minute grilling by the moderators, usually TV anchors with coastto-coast name recognition. Such gracious acts in the past were integral to the idea that when the elections were over, the US would go back to truly being the united states of the American people. No more.No matter who wins the November election, the US Supreme Court made it explicit last week that its judges were no longer going to sit back and watch their country descend into a banana republic and hurtle towards African- or Latin American-style chaos in public life. Onus on West to bring Ukraine war to an end

LOVE him or hate him, but you just cannot ignore him. His comments and views merit an in-depth analysis. In a BBC interview and an article in The Telegraph, Nigel Farage of the Reform UK party (a pivotal figure of Brexit) questioned the West's conventional wisdom: "Don't blame me for telling the truth about Putin's war. Facing up facts about the mistakes of the past has to be the first step towards the peaceful future we all want to see..." Farage was speaking on the genesis of the Russian invasion of Ukraine and the ongoing war.

Without mincing words, Farage called out the February 2022 invasion of Ukraine as "immoral and outrageous". Yet, he recalled his 2014 statement in the European Parliament that "there will be a war in Ukraine" because "the expansion of NATO and the European Union was giving Putin a pretext he would not ignore". Farage added: "If you poke the Russian bear with a stick, don't be surprised if he responds."That takes us to the history as well as geography of the

world and of Russia to assess the present imbroglio that the West is well aware of, owing to its past of gory wars and expansionist power politics for two centuries.Let's be clear about Russia's size, location, position and vastness. The erstwhile USSR had an area of 2.26 crore square km. It lost 55 lakh square km in the 1991 breakup. Fourteen of its border provinces became independent. In one stroke, the 'land border' came back to haunt Russian rulers as the prime factor for the safety, security and sovereignty of mighty Moscow.Naval historian Alfred Thayer Mahan's theory that "land powers are perennially insecure" holds true for Moscow as things have gone from bad to worse. Thus, no sooner did Russia shrink - what Napoleon and Hitler failed to do with their guns - that NATO and EU got into the expansion game, as is made clear by Farage.After the 9/11 terror attacks, Russia unconditionally supported the US, leading to the Moscow-Washington summit of Ljubljana, Slovenia, in June 2002. However, it was followed by NATO leading the charge for the membership of Bulgaria, Estonia, Latvia, Lithuania, Romania, Slovakia and Slovenia to expand its zone of political and military influence. NATO was closing in towards 21st-century



Russia's underbelly as well as routes through which Napoleon and Hitler ravaged Russia.What happened before begs a reference pertaining to the Russianspeaking demography in Ukraine. Essentially, the problem originated because a lack of "national or ethnic homogeneity" is common to all former Soviet republics. Let's now look beyond Russia. Why did France and Germany fight for years over Alsace-Lorraine and Eupen-Malmedy? Why did Germany find it compelling to annex Bohemia, Moravia, Slovakia, Schleswig and Holstein in the 19th and 20th centuries? Why does China object to anyone even talking about Tibet and Taiwan? Why can't India allow any power to go near Bhutanese territory and why does it want its

island neighbours not to pose a threat to Indian security? Why does Iran want the narrow and shallow Strait of Hormuz to be free of US carriers? Why did Margaret Thatcher fight the 1982 war in the Falkland Islands, which are some 10,000 miles from the British Isles? Why does Australia feel apprehensive of any non-Western nation approaching Tasmania, New Zealand and islands around Canberra? Why did the Anglo-French forces fight Egypt in 1956 over the Suez Canal, which legitimately belongs to Cairo and neither to Paris nor London? Why did the US retaliate against Japan with atomic bombs in 1945 and punish Iraq and Afghanistan over the 9/11 attacks? Why is the Levant war, instead of ceasing, showing signs of extinction of several groups

which flourished for years owing to the geopolitical interests of the West? Can it be said that whereas war is the terror of the prosperous, terror is the war of the poor?

Coming back to Farage, there is no doubt that Russian President Vladimir Putin is the aggressor and Ukraine the victim. The West did provoke Putin to the point of no return. It's, therefore, the duty and responsibility of the West to find ways to stop the Ukraine war. Wake-up call for infra and urban planning



government has touted infrastructure development as a cornerstone of India's economic policy, with more thanRs 44 trillion to be invested over the next two years. However, the emphasis on rapid construction has seemingly overshadowed the importance of stringent standards and maintenance. The rush to inaugurate projects, often ahead of elections, compromises quality, turning these marvels into electoral gimmicks. Regular

FRIDAY's roof collapse at the busy Delhi airport serves as a reminder of the underlying problems plaguing India's ambitious infrastructure push. The incident, which occurred during the heaviest rainfall recorded in Delhi on a June day in 88 years, caused the death of one person and left several injured. It not only disrupted airport operations but also shook public confidence in the robustness of our infrastructure. The incident is symptomatic of a broader problem as similar lapses have been reported across the country.

From the collapse of bridges in Bihar to water leakage in the newly built Ram Temple and the fury unleashed by the monsoon in Himachal Pradesh, such disasters raise questions about planning, execution and maintenance of projects. The problem isn't merely the rain; it is faulty drainage. As cities expand and green spaces turn to grey concrete, rainwater floods roads. Most new development projects lack proper stormwater drains, and many existing ones are

repurposed for sewage. Elevated green belts and tiled roadsides obstruct natural drainage, leading to persistent urban flooding — an anthropogenic phenomenon. It calls for a re-evaluation of urban planning. The Delhi airport incident also underscores the necessity of monitoring major projects. The Modi audits, adherence to international norms and accountability mechanisms are essential to prevent such tragedies. Ultimately, infrastructure is about more than just

economic growth; it is about the wellbeing of the people, with their safety being a non-negotiable aspect of development. The roof collapse should catalyse a comprehensive overhaul of infrastructure policies to prioritise long-term safety and sustainability.

No room for complacency in J&K as terror threat persists



A decline in violence and the diminished residual strength of terrorists active in J&K should not lull us into a false sense of security and normalcy.

LAST month, terrorists opened fire on a bus carrying pilgrims returning from the Shiv Khori shrine in Reasi. The driver lost control of the bus, causing it to veer off the road and plunge into a gorge. Nine people were killed and 33 others injured. PM Narendra Modi chaired a review meeting days later to assess the situation in Jammu and Kashmir after a spike in terror incidents. He was given an overview by Home Minister Amit Shah and National Security Adviser Ajit Doval. Reportedly, he directed them to deploy the full spectrum of the armed forces' counter-terror capabilities. This directive does not call for any dramatic or knee-jerk reaction by the security establishment. However, it is imperative to carry out an in-depth analysis of the security situation and recognise the conceptual shifts taking place in the character of this conflict so as to suitably tailor and direct the state response.

We need to understand that, historically, all conflicts even the seemingly intractable ones — transform over a period of time, and so has the conflict in J&K. There are numerous factors, both internal and external, including geopolitical changes, that alter the very nature of conflicts. In the state-turned-UT, external factors are more pronounced than the internal ones. Therefore, the intensity of violence in J&K is dependent directly on the role and scope of the support provided by Pakistan to keep the pot boiling. Even if the power of the Pakistani army diminishes, a strong democratic government is unlikely to give up the use of terrorism as an instrument of state policy. With an uncontrollable internal security situation, a fragile economy and an increasingly adverse geostrategic environment, Pakistan has been forced to scale down the terrorists' activities. Therefore, a decline in violence and the diminished residual strength of terrorists active in J&K should not lull us into a false sense of security and normalcy. In such circumstances, the clamour for the reduction of force levels or the revocation of the Armed Forces (Special Powers) Act from various quarters should not unduly influence policy decisions. The generalisation of episodic events can cloud our judgement. PM Modi's two-day visit to J&K (June 20-21) to launch a developmental project worthRs 1,800 crore and participate in the International Yoga Day celebrations was significant but not an indicator of normalcy in the UT.

The Army needs to retain and sustain a robust counterinfiltration posture on the LoC and an extensive counter-terrorism grid in the depth areas irrespective of overall violence levels in J&K. Stability and continuity of these grids are established over a protracted period and cannot be achieved by the induction of incremental forces following an incident. A responsive counter-terrorism deployment with a large footprint in the depth areas denies operating space to the terrorists, who otherwise would have free rein to influence the local populace and execute their nefarious designs with impunity.he Rashtriya Rifles units provide the foundation for such a deployment, and their combat edge should not be diluted. At present, there is no room for complacency or letting the guard down in view of the security situation in J&K. The gains made by the security forces should not be frittered away.

The terrorists involved in the recent Reasi and Hiranagar incidents are believed to have crossed the international border, exploiting the gaps in deployment. The deployment of the Central Armed Police Forces and the border police and their operating procedures along the border fence also need to be modified. The existing surveillance mechanisms are insufficient to prevent well-coordinated and determined infiltration attempts. At this stage, the situation is not conducive for the police to take over the task of the Army/paramilitary forces completely. However, an allout effort should be made to ensure that the police become confident, self-sufficient and ready for the

training threshold need to be improved accordingly. The use of artificial intelligence in the recognition of terrorists/overground workers (OGWs) and monitoring their communications, anti-drone measures and leveraging technology to counter IEDs (improvised explosive devices) should be incorporated on priority.



The goals set originally by the parties to the conflict also change as they come to be regarded as unattainable or requiring unacceptable efforts. Accordingly, while Pakistan's stated aim is to annex J&K, apparently it has been modified to wait for favourable conditions. Similarly, resources and methods have been modified. The attack on Hindu pilgrims in Reasi was an attempt to create communal hatred among religious groups through their network, including OGWs. The use of IEDs is also likely to rise as a low-cost option.

Its equipment profile and The Election Commission stated in May that J&K had recorded the highest voter turnout in a Lok Sabha poll in the last 35 years, with the Kashmir valley witnessing a 'massive' 30-point jump in poll participation this year compared to 2019. It is a clear mandate by the people of the UT for good governance and aspirations for a better quality of life. While the Jammu region has been hit by a

number of terrorist strikes of late, there is a perceptible transformation in the attitude of people and waning support for the terrorists. Overall, the majority of the population remains neutral, and it is this segment that we should strive to win over. Jihad is no longer a cause for the mass movement, but it continues to be a means of prosperity for some. Fear of the gun continues to be the main sustainer of terrorism. The populace has become aware of the benefits of the expanding Indian economy and those accruing locally from expanding tourism and a dip in violence.he changes in the dynamics of terrorism in J&K necessitate the security forces to suitably modify their operational techniques in order to maintain their continued ascendancy over the terrorists. Accordingly, the forces' operations should focus on making the terrorists irrelevant by removing their ability to influence people.

Gradually, as the violence levels drop further and the residual strength of terrorists reduces, the operations of the forces will need to change focus from carrying out purely offensive operations aimed at the destruction of terrorists to positive steps designed to retain and increase the allegiance of the public. Combined with other government initiatives in terms of economic, political and social measures, such changes are likely to reduce public support for the terrorists.

Parents can benefit by looking at themselves as coaches who build life skills. In an extract from her book, a family therapist and psychologist prescribes a gentler approach.

We measure our worth according to how well the children fit into those dreams. If they fall short, we feel cheated, angry, depressed and wonder 'Why me?' We feel inadequate and, in our anxiety, react by cranking up our resentment towards our children. We become judgemental, critical and comparative. And, therefore, get stuck in a spiral of negativity. Before we know it, unhealthy patterns of a lifetime get carved out. A long time back I came across this book titled, Stop Parenting, Start Coaching and I really loved the title.It resonated so deeply with my belief that our role as parents is to help our children build life skills. Here are seven steps to highly effective coaching.

CLEAR GOAL

'What is the one skill I want to nurture in my child which will help her become a more healthy, responsible, independent and happy human being?' Depending on the age of the child, it could range from eating well, sleeping on her own, staying fit, doing less screen, being more organised, managing time better, being financially savvy, getting better grades, being more communicative, articulate, confident, happy, sociable, respectful, emotionally balanced, focused and so on and so forth. We would all like that in our children. It makes our work easier as parents and feels good to boot. However, just start with one or two skills. Make it very specific. Rather than making good habits a goal as it is too vague, be more specific and narrow it down to one or, maybe, two activities. For example, clear up the bathroom after using it or go and play in the park every day.

Rate it on a scale of 0 to 10 where 5 is in the middle

'Where is my child right now in that skill?' 'Where does he need to be?'

'What is the one step he needs to take that will help him move one point up in that scale?' 'What would I need to do to help him move one

step further?

These are extremely important questions as they help you clarify the goal and establish the next step forward, for you and for your child. For example, you want your child to get better grades. You might identify that on the scale he is at 3 where the goal is 8. I would always suggest that you stay away from making 10 as a goal as it will then make you seek perfection (which I think is a huge problem) and establish extremely high expectations (for a child who is at 3 right now). The next step that you might think would work in helping him move to 4 would be to make him sit down and study for an extra half hour every day. You might want to keep yourself free around that time so that you could provide him some level of 'scaffolding' till he is ready to sit and work on his own.

ASK INSTEAD OF TELLING

We are constantly telling children what they need to do and not ask them as much as is required what they would want to do. So, you could sit down with your child and ask, 'Are you happy with your grades right now? Do you think you are putting in enough time? How can I help you in this?' Make sure you ask without sounding sarcastic or angry.

know it can be a drag sometimes. I remember feeling like that), but bring him back to the issue (I can understand you find it boring but we still need to do it). After being listened to and understanding your point of view, he might agree that he needs to work on his grades too. That's when you need to gently work out a plan of action. On a scale of 0 to 10, she is on 3 and needs to reach 6:

- Through active recognitions you could highlight the child every time you see her put her things in the proper place: 'I see you have put the books in your school bag.'

- By giving value recognitions you could focus on the skills you want to help build in your child: 'I saw you put the toothbrush and toothpaste back in the mug. I see that your organisational muscles are becoming stronger.'

- Proactive recognitions could be used to rather than throwing the towel on the floor, tried with so many issues -anger, tantrums, you hung it back on the peg. I think the crankiness, bed-wetting, soiling, laziness,

and 'careful with her things'. We have to water the wholesome seeds rather than just the negativity seeds of lack, deficit and what's wrong.

EXTERNALISATION However, you might want to address the 'problem' sometimes, but how can you do that without the child feeling attacked. In Narrative Therapy, we use an approach pioneered by the late Michael White called

Externalisation. Through this approach, we place the problem outside the child rather than within him and give it a name. So, for example, if the child is struggling with anger we might call the problem Anger and talk to the child as if the Anger was separate from him. So the questions please, perform and be perfect in order to statements might go as, 'Did you see how Anger was controlling you yesterday?' (It is best to do this when the child is calm and more receptive.) I think Anger is really 'Can you make out when Anger is coming close?' It might seem a little bizarre but children take to this slight change in language and approach very well. Personifying feelings, difficulties, imaginations and fantasies come very easily to them.

Do remember you have to be consistent in this approach otherwise you might end up confusing the child.If you feel unsure about it or after trying it you feel it does not work, just drop it. It needs practice and a way of thinking (the problem is the problem, the child is not the problem) that does not come easily to most of us. Swati Maliwal flags 'systemic erosion' of Delhi women panel, helpline shutdown

In a letter to Arvind Kejriwal, Swati Maliwal underscored several issues being faced by the DCW, including lack of funding, cuts in budget and removal of staff. **New Delhi:** AAP Rajya Sabha MP Swati Maliwal has urged Delhi Chief Minister Arvind Kejriwal to address the shutdown of the 181 women helpline and the "systemic erosion" of the Delhi Commission for Women (DCW) since her resignation.In a letter to Arvind Kejriwal, Maliwal underscored several issues being faced by the DCW, including lack of funding, cuts in budget and removal of staff.Maliwal has also flagged that the post of DCW chief was lying vacant since she was nominated to

Rajya Sabha by the Aam Aadmi Party (AAP)."I am writing this letter to bring attention to how the Delhi Government has been systematically dismantling the DCW since my resignation from the position of chairperson in January 2024. It is deeply regrettable that the systems that I painstakingly built since 2015, are being



destroyed by the Government," Maliwal said."As the Chief Minister of a city infamous as the 'Rape Capital of the World', it is crucial to safeguard systems that protet women and girls," the AAP leader said.Maliwal said the shutdown of the 181 women helpline was "appalling", asserting that survivors of rape and other crimes have been left without crucial assistance for the past 48 hours.Maliwal's letter comes a day after Delhi Women and Child Development minister Kailash Gahlot said the 181 helpline would now be run by his department rather than the DCW. Gahlot also said the number would be closed for a few days for transition."The commission has been informed that the order was issued after the approval of the concerned minister and is supposedly in compliance with a Central government directive which states that 181 Women

Helpline should be run by WCD departments in states," the letter said."The DCW works under the aegis of the WCD Department. Hence, there was no need to take over the helpline from the commission," Maliwal wrote.She also alleged that funds to the commission were halted, disrupting its operations."This funding deprivation over the past six months has crippled the commission... the dedicated women ground staff members of the commission, many of whom are survivors of atrocities like acid attacks and sexual assault, have been deprived of their rightful salaries since November 2023," Maliwal further said.

Maliwal, who has recently accused Kejriwal's aide Bibhav Kumar of assault, said the commission's budget was "unexpectedly reduced" by Rs 10 crore, amounting to a 28.5 per cent cut. The Rajya Sabha MP also said the DCW was ordered by the WCD department in April 2024 to immediately remove all its contractual staff."However, the commission did not implement the decision, as this would have led to a complete breakdown in its functioning. Child Labourers At Madhya Pradesh Distillery Worked 11 Hours A Day: Report

New Delhi: The Madhya Pradesh government's inspection of a Som Group distillery said child labourers, some aged between 13 and 17, were made to fill and pack liquor bottles and worked long hours.Police are investigating the use of child labour at the distillery in Madhya Pradesh after the National Commission for Protection of Child Rights said last month it had found 58 children working illegally at the factory.The commission released photos of some with hands showing chemical burns and said some children were transported in school buses for factory work.

A day after the children were found on June 15, an inspection report was drafted by the state's industrial health and safety department based on interviews with 27 workers, the youngest among them being 13 years old. The state says those aged under 21 cannot work in a liquor factory. The report, which is not public but was seen by Reuters, says children were working 11-hour shifts starting at 8 am.Som and the Madhya Pradesh government did not respond to Reuters' requests for comment. In a submission to the state government on June 18, also seen by Reuters, Som said some children would visit the company to deliver food and medicines to their parents, and no worker was younger than 21.Som is one of the smaller distilleries in India's thriving alcohol industry, where both foreign and domestic players operate. Its website describes it as an "internationally acclaimed brand" available in more than 20 markets including the US, New Zealand and the UK.

New Delhi: 24-Year-Old Posed As Senior Citizen In 'Donkey Route' Attempt To Reach US

Guru Sewak had dyed his hair and beard white and wore glasses to appear elderly. New Delhi: In his desperate quest to leave the country for the United States, a 24year-old man from Uttar Pradesh's Lucknow went to great lengths, including transforming his appearance to resemble a 67-year-old. On the evening of June 18, around 5:20 pm, the Central Industrial Security Force (CISF) stationed at Delhi Airport's Terminal 3 intercepted a suspicious couple. Guru Sewak Singh, accompanied by his wife, approached the immigration counter with forged documents and an appearance designed to deceive. The passport in his possession identified him as Rashwinder Singh Sahota, allegedly born on February 2, 1957 in Punjab's Jalandhar and bound for Canada on Air Canada flight AC 043. The passport bore the number 438851 and

listed Rashwinder's age as 67.However, discrepancies between Guru Sewak's physical appearance and the details in the passport immediately raised red flags. The immigration officer noted inconsistencies in his appearance, voice, and demeanor, sparking suspicion about the authenticity of the documents and the traveler's actual identity.

Closer examination revealed that Guru Sewak had dyed his hair and beard white and wore glasses to appear elderly. Despite these efforts, the mismatch between his youthful energy and the age stated on the passport was apparent. This inconsistency prompted CISF personnel to conduct a more thorough inspection.During the search, authorities found a soft copy of another passport on Guru Sewak's mobile phone. This passport, bearing the name Guru Sewak Singh and a birthdate of June 10, 2000, with the number V4770942,



revealed the passenger's true identity. Confronted with this evidence, Guru Sewak confessed to his real age and name, admitting that the passport in the name of Rashwinder Singh Sahota was forged.Further investigation uncovered a meticulously planned scheme. Guru Sewak disclosed that he and his wife had sought the help of a travel agent named Jaggi. Desperate to reach the United States, Guru Sewak agreed to pay Jaggi a staggering ? 60 lakh for the journey. Jaggi's plan involved flying the couple to Canada, from where they intended to enter the United States using the "Donkey Route," a clandestine path often used by illegal immigrants.

Guru Sewak had already paid Jaggi ? 30 lakh as an advance. To facilitate the journey, Jaggi had arranged for a fake passport and the necessary visas, providing the couple with fabricated identities.The CISF handed Guru Sewak and his wife over to the Delhi

Sewak and his wife over to the Delhi Police for legal action. They were arrested on charges of possessing forged passports and attempting to travel abroad illegally. An FIR was registered, and authorities have launched an investigation to determine the extent of Jaggi's operations and uncover how many individuals he may have sent abroad using similar tactics. Babbling and cooing are a baby's way of making small talk. A primer on important developmental milestones, and how to track them.

Baby buddy

Babies are interested and fascinated by other babies well before they are a year old, but they don't know to 'play' vet. By 18-24 months, they take part in parallel play where they may play next to each other but not with each other. Interactive play starts after two years of age. "A quiet, passive child in the first few months is a cause for concern. No big smiles or warm expressions by six months or thereafter, no babbling after a year, or no use of gestures like pointing, showing or waving, no meaningful words by 16 to 18 months are all red flags. This means that development is not proceeding as expected," explains Deshpande. A child who is not responding to his name by 10 months will also need to consult a specialist.

Early exposure to the television has a proven impact on language development, attention and concentration skills and social skill development. "When a mother is singing to the baby, social and interactional skills develop as against when the same song is being played through a DVD," says Deshpande.

Doctors suggest no TV-time until the child is two and not more than an hour thereafter. "Lack of interaction and stimulation at home is one of the most important environmental factors, which delay speech and language skills," says an. Instead, she suggests reading Srinivas

Social and language skills are equally important and tricky to detect during an occasional doctor's visit. Child specialists suggest that parents, who spend maximum time with the child, keep an eye out for the

"A child with speech delays or difficulties with play skills could find it harder to socially engage," explains Dr Roopa Srinivasan, developmental paediatrician at Ummeed Child Development Centre. In serious cases, it could be diagnosed as developmental difficulties like speech delays, intellectual disability, cerebral palsy, autism and attention deficit hyperactivity

Toothless talk

Decoding baby talk begins with understanding that crying, garbled sounds or facial expressions are the first signs of communication, explains Deshpande.

Language development includes speaking and understanding. So responsiveness like reacting to a mother's words, smiling back and cooing starts in the second month. "Identifying isolated hearing loss and addressing it in the first six months of life could ensure that a child has normal speech in future," says Srinivasan. Repetitive babbling starts in month six and goes on till the 12th. Here, nonverbal ways of

communication like smiling responsively, shaking the head and knowing to wave back when saying 'bye' begins in the first year. By six-eight weeks, they have already started to show interest in their surroundings. Interactive games like peek-a-boo will stimulate this behavio

Doctors commonly use behavioural measures of reading readiness for assessments of ability.

Other measures such as cognitive ability, early linguistic skills, measures of the environment such as socioeconomic status and whether there is a family member with reading problems or dyslexia are

all common early factors used to assess risk of developing reading difficulties

"What was intriguing in this study was that brain development in regions important to reading predicted above and beyond all of these measures," Hoeft added.

In the study, researchers examined brain scans of 38 kindergarteners as they were learning to read formally at school and tracked their white matter development until third grade.

Left hemisphere white matter in the temporo-parietal region just behind and above the left ear thought to be important for language, reading and speech - was highly predictive of reading acquisition, the researchers found.

Hindenburg said that brokerage firms founded by Uday Kotak created and managed the offshore fund structure used by its investor partner to bet against Adani group shares.It mentioned that Sebi only referred to the K-India Opportunities fund and used the acronym 'KMIL' to mask the 'Kotak' name.

"While Sebi tried to claim jurisdiction over us, its notice did not name the party actually tied to India: Kotak Bank, one of India's largest banks and brokerage firms founded by Uday Kotak, which created and managed the offshore fund structure used by our investor partner to bet against Adani. Instead, it named the K-India Opportunities fund and masked the 'Kotak' name with the acronym 'KMIL," Hindenburg said in a blog post.

It said that KMIL stands for Kotak Mahindra Investment."We suspect Sebi's omission of Kotak or any Kotak board member may be to protect yet another powerful Indian businessman from scrutiny, a role Sebi seems to embrace," Hindenburg added.In 2023, Hindenburg



Research said that it held short positions in Adani Group companies through UStraded bonds and non-Indian-traded derivatives but did not reveal the size of its bets or the specific derivatives and reference securities used.Hindenburg's new note said that Uday Kotak, the bank's founder, personally led Sebi's 2017 committee on corporate governance.indenburg Research alleged that much of Sebi's notice was intended to suggest that its legal and disclosed

investment stance was secretive or dubious, or to present new legal arguments claiming jurisdiction over it. Note that we are a US-based research firm with no Indian entities, employees, consultants, or operations. Some of these arguments seemed circular," Hindenburg added.Hindenburg said the regulator claimed the disclaimers in its report were misleading because it was indirectly participating in the Indian securities market, and therefore, was shortAdani.

NEW DELHI: Shares of stock broking firms declined sharply on Tuesday, following a directive from the Securities and Exchange Board of India (SEBI) mandating a uniform and equal charge structure for all members of stock exchanges and other market infrastructure institutions (MIIs), rather than varying charges based on their volume or activity.

The stock of Angel One tumbled 10.50%, Geojit Financial Services tanked 5.86%, Dolat Algotech dropped 5.39%, 5paisa Capital declined 4.51%, Motilal Oswal Financial Services went lower by 3.70%, and SMC Global Securities dipped 2.41% on the BSE.SEBI's directive, issued in a circular on Monday, instructed stock exchanges, clearing corporations, and depositories constituted as MIIs



to ensure that any charges recovered from the end client are "True to Label." This means that if a certain charge is levied on the end client by members including stock brokers, depository participants, and clearing members MIIs must ensure that the same amount is received by them."To begin with, the new charge structure designed by MIIs should give due consideration to the existing per unit charges realized by MIIs, so that the end clients benefit from the reduction of charges," SEBI stated.

The regulator has asked MIIs to comply with these additional principles while designing the processes for charges levied on their members, which are to be recovered from the end clients. MIIs, being public utility institutions, act as first-level regulators and are entrusted with the responsibility of providing equal, unrestricted, transparent, and fair access to all market participants.

Non-bailable warrant against Vijay Mallya in Rs 180-crore loan default case

A CBI court has issued a nonbailable warrant (NBW) against fugitive businessman Vijay Mallya in a Rs 180-crore loan default case linked to Indian Overseas Bank.

Mumbai A special court in Mumbai has issued a non-bailable warrant (NBW) against fugitive businessman Vijay Mallya in a Rs 180-crore loan default case linked to Indian Overseas Bank (IOB).The NBW was issued against Mallya on June 29 by special CBI court judge SP Naik Nimbalkar and a detailed order was made available on Monday.Citing other non-bailable warrants issued against the 68-year-old businessman after taking into account CBI submission, and his status as a "fugitive", the court noted, "this is a fit case to issue an open-ended NBW against him to secure his presence". The CBI,

probing the case, has claimed the promoter of the now defunct Kingfisher Airlines caused a wrongful loss of more than Rs 180 crore to the government-run bank by "wilfully" defaulting in payments.The embattled liquor tycoon, who has already been declared a fugitive economic offender in a money laundering case probed by the Enforcement Directorate(ED), currently resides in London and the Indian government is seeking his extradition.

The warrant was related to a cheating case registered by the CBI for alleged diversion of loans availed by the thenoperational Kingfisher Airlines from IOB between 2007 and 2012.

As per a chargesheet filed in the case in the court recently by the central agency, these credit facilities were issued to the grounded private carrier by the bank under an agreement.

The Reserve Bank of India (RBI) had in August 2010 directed the complainant bank (in the case) State Bank of India (SBI) to consider the proposal of



Kingfisher Airlines Ltd (KAL) for restructuring of existing facilities by relaxing the concerned guidelines as a one-time measure for the aviation sector, the probe agency said in the document.

Accordingly, the lenders, including IOB, restructured the existing credit facilities to KAL through a Master Debt Recast Agreement (MDRA). The agreement was signed between the KAL and a consortium of 18 banks. The allegations in the case pertain to false promises, diversion of loans for the purposes other than it was availed, the CBI said.

The accused dishonestly and with intent to

cheat, "wilfully" defaulted on the repayment obligations under the aforesaid loans and caused a wrongful loss of Rs 141.91 crore on the account of default on loans, the chargesheet claimed.

The probe agency further alleged that an additional wrongful loss of Rs 38.30 crores was caused on the account conversion of loans to shares.Taking cognizance of the charge-sheet, the CBI court issued process (summons) against Mallya and five other accused in the

case. However, the probe agency pressed for issuance of an NBW against Mallya, saying "the accused is a fugitive and an absconder".Citing multiple cases where NBWs and summonses have been issued against the embattled businessman, the CBI's plea said he is presently living in England and "continues to subvert the process of law in India."Considering the CBI submission, the court said Mallya has absconded, declared a fugitive and NBWs are pending for execution against him in other cases. So no purpose will be served by issuing process (summons) to him.

Four-time NBA champion Klay Thompson agreed to a sign-and-trade deal to join the Dallas Mavericks, according to multiple reports, closing the historic championship chapter of his career with the Golden State Warriors.In a statement Monday night, the Warriors did not confirm details of the trade but thanked Thompson for his contributions to their dynastic run and promised his No. 11 jersey would be retired by the franchise someday. Thompson, 34, teamed with Steph Curry for four NBA championships in 13 seasons with the

Warriors but turned down a contract extension offer last season that was reportedly for two years and \$48 million.ESPN reported Thompson would sign a three-year, \$50 million contract to join the Mavericks and team with All-Star guards Luka Doncic and Kyrie Irving. Dallas lost in the NBA Finals to the Boston Celtics last month. As part of the three-team trade, the Mavericks confirmed they are trading Josh Green to the Charlotte Hornets. ESPN and The Athletic reported the Warriors

will receive a financial trade exception and two second-round picks from Dallas. The exception could be used in the Warriors' trade conversations around versatile forwards. Golden State is reportedly high on Jazz forward Lauri Markkanen.A five-time All-Star and two-time All-NBA pick, Thompson was the 11th overall pick in the 2011 draft out of Washington State and has never played for another NBA team. Warriors coach Steve Kerr said at his press conference kicking off Team USA training camp last month that Golden State "desperately" wanted Thompson to return.We can't overstate Klay Thompson's incredible and legendary contributions with



the Warriors during his 13 years with the team," the Warriors' statement Monday night said, highlighting Thompson's NBA records for points scored in a quarter (37) and most 3-pointers made in a game (14)
