33 Indian farm labourers freed from 'slavery' in Italy's Verona province

Rome, July 13: Italian police said on Saturday they had freed 33 Indian farm labourers from slave-like working conditions in the northern Verona province and seized almost half a million euros (\$545,300) from their two alleged abusers. Labour exploitation is in the spotlight in Italy following an accident in June in which an Indian fruit picker died after his arm was severed by machinery. In the latest case, police said the alleged gang-masters, also from India, brought fellow nationals to Italy on seasonal work permits, asking them to pay 17,000 euros each and promising them a better future. The migrants were given farm jobs, working seven days a week and 10-12 hours a day for just 4 euros per hour, which was entirely docked from them until they settled all their debts, police said, describing the migrants' treatment as "slavery". Some were asked to continue working for free to pay an additional 13,000 euros for a permanent work permit "which, in reality, would have never been given to them," the police statement said. The alleged abusers were charged with crimes connected to slavery and labour exploitation, while the victims will be offered protection, work opportunities and legal

Chandigarh, July 13: Punjab Chief Minister Bhagwant Mann on Saturday said the big margin of victory of the AAP in the Jalandhar West assembly bypoll shows that people are "very happy" with the state government's work. One-sided result for AAP in Jalandhar West bypoll; two-time loser from BJP, Mohinder Bhagat third-time lucky The bypoll was necessitated after Sheetal Angural resigned as the AAP legislator from the seat, and joined the



BIP in March. Aam Aadmi Party (AAP) candidate Mohinder Bhagat defeated BJP's Angural by a margin of 37 325 votes. While Bhagat polled 55,246 votes while Angural secured 17,921 according to officials. Congress nominee Surinder Kaur, who was at the third spot, got 16,757 votes. "Congratulations to all for Aam Aadmi Party's great victory in the Jalandhar West Vidhan Sabha constituency by-elections. The victory with a big lead shows that people across Punjab are very happy with the work of our government. We will make Jalandhar West the 'best' as promised during the bypoll. Congratulations to Mohinder Bhagat ji," Mann said in a post on X. Celebrations broke out at the residence of Bhagat in Jalandhar as his family members and supporters were ecstatic over the victory. AAP activists burst firecrackers, distributed sweets and danced to the beats of 'dhol' over the victory of Bhagat. The AAP also took out a victory march in Jalandhar. With this victory, the ruling party AAP will have 91 MLAs in the 117-member Punjab assembly. The bypoll was being seen as a litmus test for the Punjab chief minister who wanted the AAP to register victory to retain this reserved constituency. The victory was also important for Mann and the AAP as the party faced a drubbing in the Lok Sabha polls in which it could win just three of the state's 13 parliamentary constituencies.

CJI Chandrachud for imparting legal education and conducting court proceedings in regional languages

New Delhi, July 13: Emphasising the need to make law and legal education accessible to millions of Indian citizens, Chief Justice of India DY Chandrachud on Saturday said universities should

come together to prepare teaching modules in regional languages Addressing the 3rd convocation at Dr Ram Manohar Lohia National Law University (RMLNLU), Lucknow, the CJI said a survey of 81 universities and colleges recent-Department of the Supreme Court found that the common people faced difficulties in understanding various schemes relating to their rights due to their inability to understand English. Justice Chandrachud, however, sought to

reiterate that English should not be done away with as a medium of instruction for legal education and that regional languages should be adopted along with English. He suggested that legal theories and procedures can be explained to students and the common man through informative videos prepared in regional languages. "In many countries across the world, both legal education and legal pro-



ceedings are conducted in the regional language, ensuring that all citizens can not only access the legal system but also aspire to be lawyers and judges. "It is only when we teach core principles of law

to our students efficiently while acquainting them with the local context and local legal terms, that we can create socially responsible lawyers in the future, who can truly understand the issues and concerns of the local community," the CJI said. "I often discuss with my colleagues and all the educationists of the country as to how the study of law can be taught in simple language. As such, there are certain rules and basic principles in different provisions of the Constitution. We teach those principles well in English, but we often find ourselves uncomfortable explaining those principles in regional languages," Justice Chandrachud said. "If we are not able to explain the principles of law to the general public in simple language, then it shows the lack of legal profession and legal education. This affects the common citizens, especially the weaker section of the society,' said the CJI who has taken initiatives for making available the top court's judgments in Hindi and other regional lan-

Sukhu as party hoppers suffer defeat

Shimla, July 13: A little over a month after it's dismal performance in Lok Sabha polls, in which it drew a blank, the Congress has won two out of three assembly bypolls in Himachal Pradesh

the results for which were declared on Saturday. The party won Dehra and Nalagarh while BJP won from Hamirpur. These constituencies had to go to polls following the resignation of three Independent MLA's who had joined the BJP to contest on the saffron ticket. Despite the rebellion by six Congress legislators by cross voting in the Rajya Sabha election on February 27, the bypoll results have consolidated the position of Chief Minister Sukhvinder Singh Sukhu. Interestingly, the tally of

Congress which had won 40 seats in the 2022 Vidhan Sabha polls is back to 40. The

Congress had also won four of the six assembly bypolls held with the Lok Sabha elections. Himachal Pradesh bypoll results: Congress wins Dehra, Nalagarh; Hamirpur BIP Anger against Independents joining BJP helped

Congress win Dehra, Nalagarh bypolls in Himachal Pradesh: Pratibha Singh Congress candidate Harpreet Singh Bawa won from Nalagarh by a margin of over 6,000 and Ashsih Sharma of the BJP from Hamirpur by 1571 votes. The victory of Kamlesh Thakur, wife of CM Sukhu by a margin of over 9399 votes from Dehra has enabled the Congress to wrest the Dehra seat after almost two decades. The move of

the Congress high command to field CM's wife from Dehra against the two time Independent MLA has paid off. Sukhu has been able to send a strong signal to even his detractors within the party that he can steer the party out of crisis thrust by 'Operation Lotus' that was played out in the Rajya Sabha polls on February 27, 2024. The stakes were very high for chief Sukhu as ensuring victory of his wife was imperative for him not just to send a strong signal to the BJP but also to detractors within his own party. Hoshyar Singh had won the 2022 polls by a margin of 3877 votes. The three Independent legislators Hoshyar Singh (Dehra), KL Thakur

(Hamirpur) had resigned and on March 22 and joined the BJP the very next day to contest on the saffron ticket. Interestingly, despite the BJP getting massive leads in all the three assembly segments in the recently held Lok Sabha polls, two of the three BJP candidates have now lost the bypolls reflecting the public sentiment against their move to resign to seek reelection on BJP ticket. Infact, the three MLA's even sat on a dharna outside the Vidhan Sabha to press for the acceptance of their resignation by the Speaker Kuldeep Pathania. They were keen that bypolls in their constituencies are held with the Lok Sabha and. However, that did not happen as the Speaker accepted their resignation after the polls. CM's wife Kamlesh made her electoral debut against Hoshyar Singh from Dehra which is her maternal home, much against the wishes of the CM and she herself. Centre gives more powers to J-K Lieutenant Governor on matters related to police



New Delhi/Srinagar, July 13: The Centre has significantly strengthened the authority of the Lieutenant Governor in Jammu and Kashmir, empowering him to make decisions on crucial matters such as police, and all-India services officers and granting sanctions for prosecution in various cases. The Opposition slammed the Union Government's move and termed it a step towards "disempowering" the people of Jammu and Kashmir. The Union Home Ministry gave more powers to the L-G on Friday by amending rules framed under the Jammu and Kashmir Reorganisation Act, 2019. This Act, passed alongside the abrogation of Article 370, bifurcated the erstwhile state into two Union Territories-Jammu and Kashmir and Ladakh. In the past, proposals concerning police, public order, all-India services and the Anti-Corruption Bureau required approval from the finance department of Jammu and Kashmir before reaching the L-G. Under the revised rules, such proposals must now be presented directly to the L-G through

appointment of the Advocate-General and other law officers. These appointments, previously decided upon by the government, will now require the L-G's approval. The Centre's decision has met with criticism from political parties in Jammu and Kashmir, who view it as an attempt to undermine the power of an elected government. The Supreme Court has directed the restoration of statehood in Jammu and Kashmir "at the earliest" and holding elections to the Assembly by September 30, 2024. On Saturday, various political parties expressed their disapproval of the Centre's move to grant additional powers to Jammu and Kashmir's Lieutenant Governor in matters concerning

The L-G's role in bureaucrat-

ic matters has also been amplified. Proposals secretaries, along with those concerning IAS and IPS officers, will be routed through the L-G's office. Reacting to this order, NC vicepresident Omar Abdullah raised concerns about the implications of having a "powerless and rubber stamp" chief minister who would need the L-G's approval even for minor appointments. Despite acknowledging the timing of the decision in relation to upcoming elections, Abdullah emphasised the importance of a clear commitment towards restoring full statehood of Jammu and Kashmir. "This is why a firm commitment to laying out the timeline for restoration of full and undiluted statehood for Jammu and Kashmir is a prerequisite for these polls. "The people of Jammu and Kashmir deserve better than a powerless and rubber stamp CM who will have to beg the L-G to get his/her peon appointed," the NC vice president said. Congress general secretary Jairam Ramesh remarked that the increased powers given to the Jammu and Kashmir L-G suggested a dim outlook for the restoration of a full-fledged statehood in the near future. The highlights of the event include - a guided tour of NIMHANS with Director Dr Pratima Murthy on July 15, from 9-11 am, providing an in-depth look at the institution's history and research, along with a visit to the Brain Museum, a book talk by Dr Sanjeev Jain on July 17 from 4-5.30 pm at Atta Galatta, discussing his book 'Mindscape and Landscape: An Illustrated History of NIMHANS', an art exhibition titled 'Through the Looking Glass' on July 20 at the Neurobiology Research Centre, featuring artwork and images related to mental health and neuroscience, a panel discussion on the portrayal of mental health in films on July 20, from 6.30-8 pm at Bangalore International Centre (BIC), and a storytelling workshop by Dr Ankit Dwivedi on July 21 from 5-7 pm at BIC, focusing on mental wellness through narratives.

Submission of DPR to raise **Poondi level by end of July**

CHENNAI. The Water Resources Department is expected to submit a detailed project report to the state government by July end with regard to raising the Poondi Reservoir level from 35 feet to 37 feet. This will increase the water storage capacity from the present 3.231 tmcft to 3.971 tmcft. The state government allocated Rs 48 lakh in 2022 for investigation and preparation of the report. The surveying and levelling works are done. We are now working on the



detailed design and drawing. We are yet to finalise the project cost, but it is estimated

to be around Rs 100 crore. WRD plans to complete the project in four to five years," a

senior WRD official told.

Another official said that the project is necessary to meet the drinking water needs of the growing population of Chennai. Currently, six reservoirs -- Cholavaram, Chembarambakkam, Poondi, Red Hills, Kannankottai Thervaikandigai, and Veeranam -- with a combined capacity of 13.222 tmcft, supply drinking water to Chennai. However, the annual demand for drinking and industrial water is about 22 tmcft, which could rise to 32 tmcft by 2035 due to population growth.

Hence, this project is a priority for the state government, the official added. Under the Krishna water supply project, the capacity of the Poondi reservoir was increased from 2.750 tmcft to 3.231 tmcft by raising its 'Full Reservoir Level' from 33 feet to 35 feet during 1990-1996.

To tackle dengue, Lokayukta inspects waste disposal land in Karnataka

BENGALURU. Following the alarming rise in dengue cases in Karnataka in general and Bengaluru in particular, Karnataka Lokayukta Justice BS Patil along with Upa Lokayuktas Justices KN Phaneendra and B Veerappa examined Kammagondanahalli and Abbigere and Kereguddadahalli lake to check blackspots and proper disposal of waste.

The inspection was mainly to tackle the problem of waste disposal in these areas following complaints from the public. After inspection at Kereguddadahalli lake, the Lokayukta said, "Funds were released to clean the lake three months ago, but people are seen disposing of wastes into it." He directed officials to get the work done within a week.

- He also told the officials to prepare weekly reports on the status of cleanliness. Addressing the media after the inspection, Justice Patil said it is noticed that the waste disposal was not done appropriately, which could lead to viral infections like dengue. He warned of stringent action against officials if the problems are not fixed at the earliest.
- Justice Phaneendra said waste should not be dumped on railway tracks, which could lead to water stagnation. The Bruhat Bengaluru Mahanagara Palike (BBMP) should involve NSS and NCC volunteers from various schools and colleges in keeping the city clean, he suggested.

TNPSC aspirant murdered, body buried near Palar; two friends nabbed

Poonamallee police said the deceased, Rajendran (63), has three daughters and a son, Venkatesan. Venkatesan, who runs a travel company, had a conflict with his father about a six-cent plot over the past few years.
- While Rajendran, who owned the land, wanted to split it equally among his children, Venkatesan wanted the whole plot to himself and just give '5 lakh each to the sisters," a police source said.

On Wednesday night, Rajendran was clearing undergrowth in his land, when a van ran over him. Analysis of CCTV footage allegedly revealed that Venkatesan was driving the van when the incident occurred. A case has been registered and police launched a search for Rajendran.

Vijayawada Municipal Corporation takes APJUDA stir against attack on doctors at Siddhartha Medical College in Vijayawada steps to prevent water logging on roads

VIJAYAWADA. The Andhra Pradesh Junior Doctors Association (APJUDA) of Siddhartha Medical College (SMC) declared that their strike will continue until their demands are resolved. The strike was called at the SMC campus on Friday, alleging that the relatives of a patient forcibly entered the Intensive Care Unit (ICU), attacked them, and damaged hospital property.

The junior doctors raised their slogans seeking justice and safety, demanding measures to control attacks on doctors and paramedical staff. The Indian Medical Association (IMA) -Andhra Pradesh also announced their support for their strike.

According to the doctors, a 54year-old male patients who consumed an unknown amount of glyphosate GGH Superintendent D ammonium poison was brought to Vijayawada Government General Hospital (GGH) on Thursday morning. He was admitted to a private hospital on Wednesday at around 10.30 pm.



Though the doctors shifted him to the ICU from casualty and tried to save his life, the patient unfortunately died. Later, a group of the patient's relatives attacked the duty doctor and other staff, using objectionable foul language. The junior doctors of SMC then decided to call for a strike under the auspices of SMC JUDA leader Dr R Harish. About 300 postgraduate students and house surgeons staged a protest by boycotting duties except for emergency, casualty

and labour duties. Venkateswar Rao shared a letter with the students stating that they would pursue the demands and take preventive measures against such attacks. However, the students did not accept his assurance and

continued their strike. Directorate of Medical Education (DME) Dr Narasimham urged the

leaders of JUDA to call off the strike for the sake of poor patients and discussed resolving their demands. Meanwhile, IMA State President Dr M Jaya Chandra Naidu and General Secretary Dr P Phanidhar visited the camp on

Friday, announced their support, and discussed the issue with DME. President of APJUDA-SMC wing Dr Dharmakar Pujari

declared that they will continue their strike until the Minister of Health, Y Satya Kumar, assures measures to be taken to stop future attacks on doctors. Dharmakar demanded the arrest of the accused and the registration of a nonbailable case against them. The accused has warned the

doctors during the strike that they would attack them again when they came out of the hospital premises. We need a permanent solution for such issues. Until then, the strike will continue," he added.

Seeman has no political standing to comment on Kalaignar: Geetha Jeevan

THOOTHUKUDI. Social Welfare and Women Empowerment Minister Geetha Jeevan condemned NTK coordinator Seeman for his derogatory remarks against DMK patron and former chief minister M Karunanidhi at the MLA office on Friday.

"Seeman has no political standing to comment on Karunanidhi, who dominated Tamil politics for over 70 years. Seeman supports his party members, who make

derogatory comments about senior leaders of other parties, and does not restrict them. VIJAYAWADA. Ensuring the safety and convenience of residents is our top priority, said Vijayawada Municipal Corporation (VMC) Incharge Commissioner A Mahesh. He inspected various areas under Circle II and Circle II, including Gymkhana Grounds, Gandhinagar, BRTC Road, Sarada College, Guru Nanak Colony, Benz Circle, and other areas on Friday.

No seat, no fan: Visitors 'jailed' for long hours on Vellore prison floor

VELLORE. Suresh, who came from Chennai to visit his brother at Vellore Central Prison on Thursday, had to sit on the floor for two hours in the waiting room that had no ceiling fan. Such is the plight of visitors, who come to meet their relatives and friends, who are lodged in the Vellore Central Prison.

The second largest jail of Tamil Nadu lacks basic amenities in its waiting room. The Not only the waiting rooms, but the visitors room is devoid of chairs, ceiling fans, and has poor drinking water facilities. According to visitors, there are no breastfeeding rooms for mothers. Additionally, the telecom service for speaking with inmates is also not functioning properly, leaving visitors in a difficult situation.Official sources report that the men's prison houses around 1,000

inmates, with the facility of receiving 100-150 visitors daily. Prison authorities have drafted visit schedules to alleviate the crowding issue. Relatives are allowed to visit remand prisoners on Mondays, Wednesdays, and Fridays, while convicts and Tamil Nadu Goondas Act detainees are allowed visits on Tuesdays and Thursdays.

Gurgaon. A 15-year-old student was apprehended in Rajasthan for allegedly threatening to kill cow vigilante Raj Kumar alias Bittu Bajrangi over the phone. 'State acted like child': Court acquits medical shop owner charged under PC-PNDT Act

Gurgaon. Charged for sex determination nine years ago, the owner of a medical store in Rohtak was acquitted by a trial court that came down heavily on state authorities who had "acted like a child" and slapped the case after "ayurvedic" pills promising birth of a male child were found at the shop. Additional chief judicial magistrate Manglesh Kumar Choubey said in his July 7 order that the case was a "classic example of misuse of power", and that the accused was "compelled" to face an 8-yearlong trial for an act that was "not an offence" under The Pre-Conception and Pre-Natal Diagnostic Techniques (PC-PNDT) Act.Choubey said that PC-PNDT Act prohibits sex determination, and any "competent" investigator "should have been wise enough to understand that from an ayurvedic medicine, sex selection does not take place". The case was filed by the health department after a local journalist claimed to have carried out a "sting operation" and said that the Jagdamba Medical Shop was selling a drug for Rs 5,100, which promised delivery of a male child. The department conducted a raid at the shop and pills named Shivlingi Bij, Shivputra, and Jeeval Bij were recovered. An FIR was registered against the store owner under Section 420 (cheating) of the IPC and provisions of the PC-PNDT Act. The accused was arrested in Sept that year, and as PC-PNDT Act is a nonbailable offence, he remained in jail till this month. The case went to trial in 2016. Accused's counsel Harish Sikri told the court during trial that of the 15 witnesses listed by the prosecution, some had turned hostile and the journalist had failed to give a statement. Another witness, Dr Satish Khurana, told the court that the pills found in the store contained ayurvedic herbs and compounds that were easily available at a paan shop. Another witness, Dr Harpal Bhudwar, said the products in the pills were not banned and available in the market.

Irregularities in electoral roll revision: 35 BLOs suspended

Gurgaon. The district administration has suspended 35 booth level officers (BLOs) for irregularities in the revision of the electoral roll. The administration has already started a drive to add to and delete names from the existing list after verification as the assembly polls are only a few months away.Deputy commissioner and district election officer Nishant Kumar Yadav ordered suspension of BLOs -22 from Gurgaon, seven from Pataudi, four from Sohna and two from Badshahpur — who have been accused of manipulating the voters' list by unauthorised addition and deletion of names."According to the guidelines of the state's chief electoral officer, these BLOs had to complete home-to-

home verification by July 4. A total of 35 BLOs from the four assembly segments, however, did not complete the work on time, showing negligence. The disciplinary action came after a proposal from the concerned SDMs. Employees who do not take election duties seriously will not be spared, and the election BLOs Santra, Dharmpal, Indu and commission may even terminate their

services," said Yadav.After voters alleged irregularities in the voter list during the Lok Sabha polls, the administration launched a revision drive to make corrections and add new voters by July 18. The final draft for the assembly election will be published on Aug 20. 20km pipeline soon to boost water supply to tail-end areas

Gurgaon. GMDA will lay a 20.5km master supply pipeline from Basai water treatment plant (part 2) to tail-end areas of the city. The agency will submit its technical plans within a week and float a tender soon, an official said.Last year, the govt approved GMDA's proposal for the master pipeline, which will have a capacity of up to 200 million litres per day (MLD) and will be constructed at an estimated cost of Rs 125 crore. The pipeline will be laid with looping arrangements using glandless bush-mechanised resilient seated sluice valves, the official said. According to GMDA's Infrastructure Development Plan, an additional water treatment plant (WTP) with a capacity of 200 MLD will be required in addition to the existing 270 MLD at Basai WTP, to meet the prospective water demand.At present, GMDA supplies 128 MLD to the tail-end areas, whereas water demand is 152.4 and a new pipeline needs to be laid to MLD, which is expected to escalate to 328 MLD by 2041. On Wednesday, the GMDA board approved upgrade work on the Basai water treatment plant (part 2) with a new filtration unit of 100 MLD, which will be



Project Report (DPR), we will invite the tender for the same," said a senior official of the GMDA.The proposed master water supply line will be laid along the Dwarka Expressway towards sectors 101, 104, 108, 110, and 110A, dividing roads of sectors 110A or 111, railway crossing, dividing roads of sectors 1/2, 23A/23, 22, 19/22, and 19/20, NH-8 crossing, and connecting to the Cyber Hub and Sector 16 line in the end. However, it will take at least three years to complete the project once it is allotted.Currently, there are three rising main lines from the Basai water treatment plant, which include a 1300mm pipeline, a 1200mm pipeline, and a 400mm pipeline.The 1300mm line carries 200 MLD of water against the designed capacity of 170 MLD.

A yr gone,140cr green fines still not recovered

Gurgaon: Haryana State Pollution Control Board (HSPCB) is yet to recover penalties amounting to Rs 140 crore imposed on polluting industrial and commercial units in the city as environmental compensation (EC) over the past 16 months.From Dec 1, 2022 to April 30 this year, a total of Rs 134 crore was imposed as EC in the north circle of Gurgaon, and Rs 6 crore in the south circle. But no recovery of fines has been made so far.

Experts suggest that the delay in penalty recovery could be a strategy to benefit the violators, as EC might be written off if the units are declared dismantled or nonfunctional. The policy instrument of environmental compensation operates on the 'polluter pay principle'. The primary objective of this policy is environmental protection. The National Green Tribunal (NGT) has empowered state pollution control boards to establish a methodology to assess and recover compensation for environmental damages. The recovered amounts are then utilised through action plans for environmental protection.Delhi-based activist Varun Gulati, who filed an RTI on this issue, said, "It's clear that HSPCB has failed to do its job, even though it has imposed EC. Instead of paying up the fines, many of the 'sealed' or 'closed' units just begin operations somewhere else in Gurgaon, Faridabad, Sonipat, or nearby places. The owners get away by saying the units have been dismantled or closed after the fines were imposed. This reveals the huge nexus between HSPCB staff and these polluters."Normally, food joints and other commercial/industrial units have to apply to the pollution control board for the consent to operate (CTO) certification. They have to furnish details of waste likely to be generated, mechanism of disposal, and if they plan to use generator sets for power backup. at these establishments.

Joe Biden says Kamala Harris is 'qualified to be president'

Washington. US President Joe Biden on Thursday said his d eputy, Vice President Kamala Harris, is "qualified" to lead the country. At a high-stake press conference here on Thursday, Biden said, "From the very beginning, I made no bones about that. She is qualified to be the president. That's why I picked her."When asked about the reasons for this, he said "Firstly because of the way she's handled the issue of freedom of women's bodies, to have control of their bodies and secondly, her ability to handle almost any issue on the board."This was a hell of a prosecutor. She was a first-rate person and in the Senate, she was really good. I wouldn't have picked her unless I thought she was qualified to be the president," Biden said.

Harris, 59, is the first woman, the first Black American, and the first South Asian American to be elected as US Vice President in 2020.Biden's remarks on Harris came amidst growing calls for the 81-year-old to step aside from the race for the White House in November since he stumbled through a TV debate with his Republican rival Donald Trump last month. The president mistakenly referred to Kamala Harris as former president Trump during the press conference. He said, "I wouldn't have picked Trump to be the vice president, did I think she was not qualified to be presidentâ€æ.""The fact is that the consideration is that I think I'm the most qualified person to run for president. I beat him once and I will beat him again," Biden said."The idea that senators and congressmen are running for office worrying about the ticket is not unusual. And I might add, there were at least five presidents running or incumbent presidents who had lower numbers than I have now later in a campaign," he said. So, there's a long way to go in this campaign and so I'm just going to keep moving, Biden, the presumptive candidate of the Democratic Party, said.

Russian assassination plots against those supporting Ukraine uncovered in Europe, official says

WASHINGTON.Western intelligence agencies have uncovered Russian plots to carry out assassinations, arson and other sabotage in Europe against companies and people linked to support for Ukraine's military - one of the most serious being a plan to kill the head of a German arms manufacturer, a Western government official said. The plots have sometimes involved recruiting common criminals in foreign countries to conduct the attacks, said the official, who is familiar with the situation but not authorized to comment and spoke on the condition of anonymity. One major plot recently uncovered had targeted Armin Papperger, CEO of defense company Rheinmetall, the official said. The official declined to offer any details on other plots, which were first reported by CNN. The CNN report said the US informed Germany, whose security services were able to protect Papperger and foil the plot. Rheinmetall is a major supplier of military technology

and artillery rounds for Ukraine as it fights off Russian forces. The company last month opened an armored vehicle maintenance and repair facility in western Ukraine and also aims to start production inside the country.White House National Security Council spokesperson Adrienne Watson declined to comment on the alleged plot to kill Papperger but said, "Russia's intensifying campaign of subversion is something that we are taking extremely seriously and have been intently focused on over the past few months."

Imran Khan's PTI to emerge as largest party in Parliament after court's ruling

Islamabad. Pakistan's Supreme Court on Friday ruled that Imran Khan's party was eligible for more than 20 seats reserved for women and minorities in Parliament, in a major legal victory for the jailed former prime minister, who demanded the resignation of the election commission chief.

Candidates backed by Khan's Pakistan Tehreek-e-Insaf (PTI) party, who had contested and won the February 8 elections as independents after their party was stripped of its election symbol, had joined the Sunni Ittehad Council (SIC), a political alliance of Islamic political and Barelvi religious parties in Pakistan, to form a coalition of convenience. The SIC had filed a plea challenging the Peshawar High Court (PHC) decision upholding the Election Commission of Pakistan (ECP) move to deny its share in reserved seats in the assemblies.A 13-member full bench headed by Chief Justice Qazi Faez Isa heard the case. The ruling in the keenly awaited case is viewed as a major setback to Prime Minister Shehbaz Sharif's ruling coalition though there is no immediate threat to the federal government. Chief Justice Isa had announced after the proceedings on Tuesday that the panel decided to reserve the verdict for mutual consultation, which it announced on Friday.A majority of eight judges ruled in favour of SIC by overturning the orders of the top election body and the judgment of the Peshawar High Court. The judgment was announced by Justice Mansoor Ali Shah."The order of the Election Commission of Pakistan, dated 1st of March 2024, is declared to be to ultra vires to (beyond the powers of) the Constitution, without lawful authority and of no legal effect," according to the verdict."The notifications of various dates, whereby the persons respectively mentioned therein, being the persons identified in the commission's notification, dated 13th of May, 2024, have been declared to be returned candidates for reserved seats for women and minorities in the national and provincial assemblies, are declared to be ultra vires to the Constitution, without lawful authority and of no legal effect, and are quashed from 6th of May 2024 onwards," it read. The court went ahead to declare "the lack or denial of an election symbol does not in any manner affect the constitutional and legal rights of a political party to participate in an election (whether general or by) and to field candidates and the Commission is under a constitutional duty to act, and construe and apply all statutory provisions, accordingly". The verdict further declared that the Pakistan Tehreek-e-Insaf was a political party and eligible for reserved seats "The Pakistan Tehreek-e-Insaf (PTI) was a political party.

Actor Alec Baldwin cries in court as judge dismisses 'Rust' shooting case

Los Angeles. Alec Baldwin's trial for involuntary manslaughter collapsed in spectacular fashion on Friday (local time) as a judge found key evidence over a fatal shooting on the set of "Rust" had been withheld from the defence, and dismissed the case.Judge Mary Marlowe Sommer, presiding over the trial in Santa Fe, New Mexico, said bullets potentially linked to the death of cinematographer Halyna Hutchins that could have been favourable to Baldwin's case had not been shared with his lawyers by police and prosecutors. The Hollywood A-lister immediately burst into tears, as the case -- which could have seen him sentenced to 18 months in prison if found guilty -- was abruptly tossed out in sensational scenes."The state's willful withholding of this information was intentional and deliberate. If this conduct does not rise to the level of bad faith, it certainly comes so near to bad faith as to show signs of scorching prejudice," said Marlowe Sommer.

"The court concludes that this conduct is highly prejudicial to the defendant."



Baldwin was holding a gun in the direction of Hutchins during a rehearsal in October 2021 when the weapon fired, killing Hutchins and wounding the film's director. The movie's armourer Hannah Gutierrez, who loaded the fatal weapon, is already serving 18 months in prison for involuntary manslaughter.Baldwin was facing the same charge. Prosecutors claim he ignored basic gun safety laws and acted recklessly on set. Baldwin's celebrity lawyer Alex Spiro argued the actor had no responsibility for checking the weapon's deadly contents and did not know it contained live rounds.But the defence's case also rested heavily on discrediting the police investigation.And Spiro on Thursday introduced evidence that live bullets potentially linked to the shooting had been handed to police, but not disclosed to Baldwin's lawyers. 'BURIED'

The bullets were handed to police by a "Good Samaritan" earlier this year, more than two years after the "Rust" tragedy.The "Good

Samaritan" was a former police officer and a family friend of Gutierrez, the armourer. He told police the bullets matched the rounds that killed Hutchins.Spiro accused police of having "buried" evidence by not filing it under the "Rust" case, depriving the defence of a chance to see it."It was a perfect plan," he told the court.Crime scene technician Marissa Poppell, under questioning from Spiro, said she had catalogued the bullets, but had been told not to file them under the "Rust" case.Special prosecutor Kari Morrissey scrambled to respond, telling the court she had never seen or heard of the bullets before this week.

'Cosmic ballet': Nasa unveils stunning images of two galaxies merging in Space

World Nasa on Friday unveiled a set of images of two galaxies merging in sort of a "cosmic ballet". The galaxies, affectionately named the Penguin and the Egg, are located 326 million light-years away in the constellation Hydra.The release of these images marked the second anniversary of the telescope's first scientific results. The image was taken by the James Webb Space Telescope which was launched in 2021 and began collecting the data since that year.Since becoming operational, Webb has observed galaxies teeming with stars that formed within a few hundred million years of the Big Bang event that marked the beginning of the universe about 13.8 billion years ago."We see two galaxies, each a collection of billions of stars. The galaxies are in the process of merging. That's a common way that galaxies like our own build up over time, to grow from small galaxies - like those that Webb has found shortly after the Big Bang – into mature galaxies like our own Milky Way," Reuters quoted Jane Rigby, Nasa Webb senior project scientist, as saying. The Penguin and Egg galaxies, collectively known as Arp 142, are shown in the images connected by a haze of stars and gas as they slowly merge. The Penguin galaxy, formally called NGC 2936, is a distorted spiral galaxy, while the Egg galaxy, NGC 2937, is a compact elliptical galaxy. Their interaction began between 25 and 75 million years ago, and they are expected to become a single galaxy in hundreds of millions of years. Webb has made significant contributions to the understanding of the universe, detecting the earliest known galaxies and providing insights into exoplanet composition and star-forming regions."This mission has allowed us to look back to the most distant galaxies ever observed and understand the very early universe in a new way," said Mark Clampin, astrophysics division director at NASA headquarters. "For example, with Webb, we've found that these very early galaxies are more massive and brighter than we expected, posing the question: How did they get so big so quickly?"As the largest and most powerful telescope ever put in space, Webb specialises in capturing infrared light, allowing it to see through dust and gas and examine the composition of exoplanet atmospheres with unprecedented detail.

Amid calls to quit race, Biden tells supporters, 'I promise you, I'm ok'

Detroit, UPDATED. Seeking to revive his struggling re-election campaign, President Joe Biden held a rare rally in Detroit on Friday (local time), telling a cheering crowd he wasn't going to leave the race and warning that Republican Donald Trump poses a serious threat.Biden, 81, is trying to shift the conversation from his mental sharpness and a growing number of Democratic defections to the impact of another Trump presidency, as he tries to reboot his campaign after a shaky debate performance on June 27."I am running and we're going to win," he said to a crowd that carried "Motown is Joetown" signs and chanted, "Don't you quit.""I'm the nominee," he said. "I'm not going anywhere."Pointing to the press area in the gym, Biden said, "They've been hammering me," to which the crowd booed. "Guess what, Donald Trump has got a free pass," he added."Hopefully with age comes a little wisdom," Biden said, in a defiant and sometimes gleeful performance. "Here's what I know - I know how to tell the truth, I know right from wrong and I know Americans want a president, not a dictator."Biden also laid out what he intended to do with his first



100 days of a second term, including codifying abortion rights, signing the John Lewis Voting Rights Act, ending medical debt, raising the minimum wage and banning assault weapons. These sweeping changes would be difficult or

impossible without Democratic majorities in both houses of Congress. While union and religious leaders attended, Michigan's governor Gretchen Whitmer and its Democratic senators, Debbie Stabenow and Gary Peters, did

not.Earlier on Friday, Biden made a surprise stop at a restaurant in a Detroit suburb, where he told diners he planned to "finish the job," and said, "I promise you. I'm okay."Biden got a boost on Friday when two prominent Democrats - Representative James Clyburn and California Governor Gavin Newsom - said he should stay in the race.On Friday afternoon, United Auto Workers president Shawn Fain, who had previously said he was worried about the president's chances, praised Biden for standing "with the working class," without using his name.But there were signs that his support was weakening elsewhere, as two more lawmakers called on him to drop out."It is time to move forward. With a new leader," Representative Mike Levin, from California, said in a statement. Levin, like many others who have called on Biden to leave the race, faces a competitive re-election battle of his own this year. Fraudsters cheat public on servicing RO units in Bengaluru

- BENGALURU. As dengue cases rise, more people are seeking to service their RO (reverse osmosis) units to ensure clean water. Cyberfraudsters, however, are exploiting this demand by posing as RO service providers. After receiving numerous complaints, the city police have flagged this as a new trend in online scam and warned the public against making any advance online payments.
- A police officer told that approximately 100 such complaints from different parts of the city have been received.
- Another senior police officer said, "The caller typically claims that the water purifier needs servicing or a part replacement, creating a false sense of urgency. As most branded companies regularly call to offer services every six months, people are falling prey to the scam, mistaking them to be genuine calls."
- In some cases, fraudsters would already possess information about individuals who have inquired about the service, enabling them to call back and make the scam appear genuine, the officer added.
- Fraudsters schedule a service visit and demand an advance fee for the appointment or for replacing parts. Though the amount they collect is typically low, it provides the fraudsters with access to some sensitive information, the officer said, and added that they use these details to either set up a mule account or target the same individual again for future scams.he officer said that in some instances, a person shows up to service the unit, tampers with the machine to aggravate issues or installs substandard parts, only to extort more money from their victims. In most cases reported so far, nobody arrived.

U-shaped flyover near Tidel Park signal to be ready in two weeks

Will provide huge relief from traffic congestion during peak hours at junction, which will soon be made bidirectional

CHENNAI. The extensive traffic congestion at Tidel Park Junction on Rajiv Gandhi Salai will soon be a thing of the past as the second U-shaped flyover on the stretch is nearing completion. After the flyover is opened for public use, right turn for vehicles coming from East Coast Road will not be permitted towards Indira Nagar, making the Tidel Park Junction bidirectional.

The two-lane, unidirectional flyover that spans over 230 metres, aims to enhance traffic flow by allowing motorists from Thiruvanmiyur/ECR to proceed towards Sources said traffic police have proposed Indira Nagar by making a U-turn on the

OMR Road near Tidel Park. Official sources from the Tamil Nadu Road Development Company (TNRDC) said as much as 95% work has been completed and the remaining civil work To reduce traffic congestion on OMR and is expected to be finished in two weeks. Tidel Park Junction witnesses huge traffic congestion during peak hours since it facilitates traffic in all four directions. Additionally, the ongoing construction of metro phase II shrunk the carriageway of Rajiv Gandhi Salai, further slowing down vehicular movement.

The new flyover will significantly reduce congestion in the Madhya Kailash-Kandanchavadi section," said a traffic police official.S Chakravarthi of Thiruvanmiyur commented, "It takes nearly 20 minutes to cross the Tidel Park signal during peak hours. Once the junction is made bidirectional, the police should ensure that vehicles don't pile up near the new flyovers."

What Modi can learn from Sunak

- RISHI Sunak and his Conservative Party badly lost the parliamentary elections in the UK last week. He was gracious in defeat. "I can hear your anger. I take responsibility for the loss to the many good, hardworking candidates," he said. He resigned as the Prime Minister immediately after the expected verdict was announced. The next day, he resigned as the leader of the Conservative Party, leaving the field open to ambitious politicians to vie for the top job in the party. Considering that only 36.56 per cent of the voters supported the BJP this time, he should listen to the voices of those who voted against his party.
- Sunak's stature in my eyes, at least, and I am sure in the eyes of Indians who think and feel, went up by several notches. I compared his reaction to the defeat to that of our own popular Prime Minister when the BJP lost 60 seats in the Lok Sabha compared to its 2019 tally of 303.
- Narendra Modi had set his sights on winning 400 seats this time. He had launched several infrastructure projects, traversed the length and breadth of the country in his peripatetic fervour, and inaugurated the Ram Janmabhoomi temple in Ayodhya all by himself. All his efforts were in vain. His party lost ground in Uttar Pradesh and, wonder of wonders, the BJP lost the Ayodhya seat to Akhilesh Yadav's Samajwadi Party.

But our Prime Minister is made of sterner stuff than our former colonial master's ex-PM. Modi did not mention 'defeat' even once. He claimed victory for the NDA. His pre-poll tieup with Chandrababu Naidu's TDP and the mercurial Nitish Kumar's JD(U) took the BJP-led alliance past the halfway mark.Modi began his cherished third term without batting an eyelid. For him, it was business as usual. He showed no discomfiture at the BJP's below-par show in the Lok Sabha elections and did not think it necessary to offer any explanation to his party members for what can only be described as his personal failure as the BJP fought the elections in his name.Sunak is of Indian origin. His family has its roots in Punjab. His wife, Akshata Murthy, is the daughter of Narayan Murthy, the founder of Infosys. Her roots are in Karnataka. They hail from the same stock as Modi and millions of Indians. Yet, Sunak's reaction to a setback in his career was diametrically opposite to that of Modi.Sunak is a practising Hindu. It is obvious that he follows the essence of his religion. He was humble and penitent. He accepted responsibility for the defeat. The RSS should comment on this aspect of his personality and behaviour like it commented on Modi's without naming him. After all, the core teachings of the great religions in the world are similar. They all teach humility and reject arrogance. They disapprove of lies. They preach compassion and service without expectation of reward. Then, why do our desi politicians differ from our brethren who have migrated to other countries and achieved unbelievable recognition? Sunak became the Prime Minister of the country that ruled over us for two centuries or more. Kamala Harris, whose mother's family migrated to the US from Tamil Nadu, is the Vice-President of the world's most powerful country.Besides Indians seeking a better quality of life in the West, there are Indian-origin citizens of smaller countries in the world. Their ancestors had been recruited as indentured labour to work in the cotton and sugarcane fields in British-ruled colonies in the West Indies, Mauritius and Fiji. Starting with Sir Seewoosagar Ramgoolam, the Prime Ministers of Mauritius have been of Indian origin.Sir Vidiadhar Surajprasad Naipaul, whose origins are in a Dubey family from a village in Uttar Pradesh, is acknowledged as one of the greatest writers in the English language. His family was transshipped to the West Indies two or more centuries ago. He won the Nobel Prize for Literature for his writings, including A House for Mr Biswas, An Area of Darkness and India:

Of the \$50 billion the US has committed for the semiconductor sector, \$11 billion will be spent on R&D. We see no such focus in India.

AMID Russia's chairmanship of BRICS, Beijing and Moscow are making efforts to rapidly expand the grouping and gain traction for the organisation to challenge Western domination. They aim to position BRICS as an upholder of the values of the Global South. BRICS has traditionally tried to find better economic avenues not dependent on the West. It is also an important effort for a multipolar world.

As many as 33 countries are waiting to join BRICS. This is a huge number. Since 2010, when South Africa

joined BRICS, it remained a club of five countries Brazil, Russia, India, China and South Africa. In 2023, during the South African chairmanship, six countries were invited to join the bloc: Argentina, Ethiopia, Egypt, Iran, Saudi Arabia and the UAE. Argentina withdrew, while Saudi Arabia has not ratified its membership. The criteria-based approach was ignored in this rush.

Among Ethiopia, Iran, the UAE and Egypt, there is a mix of pro- and anti-Western countries. But the dominant theme is how to join another pole in the emerging international order and seek greater economic opportunities for themselves.

Indonesia's reluctance to join the first expansion has left a gap in BRICS because no Southeast Asian country is a member so far. Indonesia, which was then the chair of ASEAN and had successfully helmed the G20 in 2022, was seen as an ideal

partner. But it demurred. One reason was that it did not want to be a party to the international contestation between the US and China, assuming that it saw BRICS as a China-led grouping. Economically, Indonesia placed its bets on its application for the membership of the OECD (Organisation for Economic Cooperation and Development). Hence, it did not find BRICS equally attractive.Currently, there are three ASEAN countries seeking BRICS membership - Vietnam, Thailand and Malaysia. Public pronouncements by their leadership have varied. Thailand and Malaysia are more public about their efforts, while Vietnam, which recently hosted Russian President Vladimir Putin, has been discreet. Other applicants include Venezuela, Senegal, Cuba, Kazakhstan, Belarus, Bahrain and Pakistan.

Why this eagerness of ASEAN countries to join BRICS? They are not taking an ASEAN position on BRICS. Indonesia perhaps thought there should be an ASEAN point of view on BRICS before ASEAN members sought to join. On international issues like the Ukraine war and the Gaza crisis, there is minimal, if any,

common ASEAN view. Various ASEAN countries see BRICS as having political and economic influence, which has been significantly higher since the outbreak of the Ukraine crisis. Russia, China and India offer economic opportunities for trade and investment, which several applicants for BRICS membership think could benefit them. Thailand and Malaysia view their applications as a Global South initiative to seek a more determined international order where they could have a



bigger voice. They seek to leverage South-South cooperation, play a more proactive role through BRICS and participate in a more balanced international order. Prioritising multilateralism, strengthening the role of the countries of the South and enhancing economic opportunities are the main reasons cited.

Within Thailand and Malaysia, however, there are voices that challenge their governments' inclination towards BRICS. They aver that ASEAN has traditionally maintained its strategic autonomy, which, in real terms, has come to mean close economic engagement with China and a security understanding with the US-led Western bloc. The discomfort that ASEAN countries had with Quad has diminished, but that this would lead to a rush to join BRICS was unanticipated.

It is not as if Vietnam, Malaysia and Thailand have had similar voting patterns on the Ukraine crisis in the UN. They voted separately. Now, they are keen on BRICS membership, even though Russia and Iran are under US sanctions and China leads the anti-Western bloc. When these countries' push for membership is challenged

domestically on the grounds of strategic autonomy,

they revert to citing economic opportunities. However, this does not hold much water because Vietnam, Malaysia and Thailand are closely aligned with China in economic terms. For several years, Beijing has been their largest trading partner, and they are benefiting from the Belt and Road Initiative. They are all members of the Regional Comprehensive Economic Partnership, from which India withdrew in 2019. Yet, they are all members of the Indo-Pacific Economic Framework for

Prosperity, which is led by Quad countries. Vietnam is also a member of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership, with several members from the Asia-Pacific; both China and Taiwan are among the applicants.

The changing of the guard in Indonesia will take place in October, when Gen Prabowo Subianto will take over the presidency from Joko Widodo. This is likely to see a shift in the Indonesian position as well. Indonesia may not be able to enter the BRICS fray in time for the summit in Russia in October, when Vietnam, Malaysia and Thailand will be considered, but it could very well be a subsequent applicant. Prabowo has a geopolitical sense of foreign policy and is unlikely to feel the constraints that Widodo felt, even when Indonesia was a natural

contender to join BRICS during the expansion in 2023. Overall, the entry of ASEAN nations into BRICS will improve its geographical coverage and bring countries in the ambit of India's Act East Policy into the grouping. India should have no difficulty in supporting Vietnam, Malaysia and Thailand for their entry into BRICS and Indonesia whenever it seeks to join. India has close ties with these countries. And the economic and political expansion of relations with them remains a keystone of India's Act East Policy. They are all friends of India and could benefit by balancing the composition of BRICS. However, all of them are close economic partners of China, whose heft with their inclusion into BRICS would be clearly felt. India has been comfortable with the new members who have had good relations with it but prosperous economic partnerships with China.

Of the 33 current applicants, perhaps five to 10 that are acceptable to the others will be approved. ASEAN countries, with their wider reach and support from China, Russia and India, would perhaps find it easier to enter BRICS at this stage.



re-election bid, the US has declared that it will start deploying longer-range missiles in Germany in 2026 in a bid to counter the 'growing threat' Russia poses to Europe. This makes it clear that the West is unwilling to bring Russia to the negotiating table, a stark reality that was laid bare by Moscow's absence from the Ukraine peace summit hosted by Switzerland last month.

The US-led NATO has also not stopped short of riling China, calling it a 'decisive enabler' of Russia's war in Ukraine. Reacting sharply, Beijing has urged NATO to 'reflect on the root cause of the crisis and take concrete action to de-escalate rather than shift the blame' Indeed, NATO would do well to introspect and shun belligerent rhetoric; otherwise, this can worsen the situation in eastern Europe and bring the world to the brink of a catastrophic conflagration.

- THE monsoon is the cruellest season in India. One of the most terrifying experiences is to witness a river breach an embankment and instantly eat up swathes of land. I have reported on floods for decades; the fury of a cloudburst or a landslip or rising water level is almost incomparable. To see huge chunks of solid earth being devoured by a hungry tide is numbing.
- After a scorching summer, a wave of floods is sweeping India from the north to the east and the west. About 49 million hectares (of 3,290 lakh hectares) of land are prone to floods in India. According to the National Disaster Management Authority, on an average every year, "75 lakh hectares of land is affected, 1,600 lives are lost and the damage caused to crops, houses and public utilities is Rs 1,805 crore due to floods." This year, at least 85 lives have been lost so far. Over 30.83 lakh people are affected, with 3,154 villages submerged and 49,014 hectares of crop area damaged. But the impact of floods is not a mere statistic.
- Flood studies and reportage almost invariably miss out on the inequality and the cumulative loss. Typically, a flood story is about loss of home, cropland, livestock, relief camps, fleeing or dead wildlife, aerial survey by ministers and vox pops of survivors demanding more attention. As the water recedes, the attention shifts till the next monsoon, when the same low-lying areas will go under water. If you are lucky, the house is still standing but will need repairs. To get through another season without crops, one must borrow money. To feed too many mouths gets difficult, encouraging traffickers to take away children who drop out of school that turn into temporary shelters. The following year, the story repeats itself, and over a decade, each family is caught in an inescapable cycle of debt. In many cases, entire houses go under water and rehabilitation is rare as well as circuitous. It often strips families of every piece of possession without any help whatsoever.We are not even halfway through the monsoon and 27 districts of Assam are flooded; 18 lakh people are affected. Beyond

Flawed development models worsen flood misery



Delhi has realised that its interests are better served when its ties with Moscow are growing

Dibrugarh in upper Assam, amid challenging logistics, the media coverage reduces. Cachar, one of the worst-affected, has not even received relief. A large section of flooded India remains invisible. Parts of Arunachal Pradesh are cut off, hampering relief efforts. The Army and the air force are routinely called in to help such is the scale of devastation year after year. Roads are blocked and damaged. By the time the government can repair them, another wave hits the hills. This year, Manipur has been hit by floods, with the Imphal and Iril rivers breaching 📷 embankments. Flood warnings have been sounded in Bihar and a flood-like situation is being reported from north Bengal.

While rivers in the east are known to flood their plains, the misery that follows is largely created by flawed development models and corruption. Embankments are not adequately reinforced, leading to breaches. An alleged nexus between contractors and government agencies (earlier, armed groups were involved in many states) ends up doing a poor job. The bigger

problem is persistent erosion that robs landmass. Since 1950, Assam has lost 7.4 per cent of its land.

grew up in the hills, where the monsoon meant incessant rains, but it didn't trigger floods. Today, Indian hills and plains are both vulnerable. Mumbai city can't bear the monsoon downpour and New Delhi is thrown off gear with just one good shower. The hills of Uttarakhand and Himachal Pradesh are chipping away. The reasons are simple: hill-cutting, making tunnels across mountains, rampant illegal construction and unplanned city development with poor or no drainage system and no master plans for cities.Mumbai city was built by the reclamation of seven major islands connected by the



Mithi river that served for drainage. The river swells during the monsoon, flooding the city that reclaims more and more land for expansion. In the past 40 years, the city reclaimed double the land compared to the previous 300 years, reducing the width of the river dumped with waste, filled with slums and killing mangroves along the way while reinforcing the retaining wall. The sum result is a history of disastrous flooding, the worst recorded in 2005 that killed more than a thousand people. This monsoon, the city is again reporting floods drowning parts of it within hours of rain. While the 2005 Mumbai floods called attention to India's vulnerabilities in disaster management, no lessons seems to have been learnt. In 2023, the Yamuna

reached a record high of 208.66 metres, much above the level recorded during the last great flood in Delhi in 1978. It is well known how the Capital choked the great river by discharging polluted water, leading to siltation and a rise in the level of the riverbed. The normal flow of water is impeded, causing flooding of the city, which is always undeprepared to deal with any amount of rainfall.Bengaluru urban and rural are the most flood-prone in all of South India, save a few places in Kerala. From 1969 to 2021, IMD (India Meteorological Department) data shows Bengaluru recorded more than 70 flood events almost entirely due to urbanisation. Today, the city has 250 flood hotspots and planners are still figuring out how to drain rainwater.

Chennai is also emerging as a city that can no longer manage rains, but it is telling how such disasters are embedded within inequality and settlements in low-lying areas.But the most dangerous destruction of the ecosystem leading to catastrophic floods is the unstable Himalayan belt of Uttarakhand and Himachal. Images of houses, roads and people being

washed away is becoming a regular phenomenon. At least six districts of Uttar Pradesh are under threat from the water released in Uttarakhand. Sharda, Rapti and Gandak are flowing above the danger mark, affecting more than 20 villages.

The big picture is grim, and any long-term study or coverage on loss of human and animal lives is episodic. While weather conditions are beyond our control, early warning systems, community involvement and better planning of development projects and flood management are obvious ways to mitigate this annual disaster. Despite state governments' demand, floods are not yet a national calamity. Is it because they affect the most vulnerable of our population?



Fear of snakes and serpent guards of Jagannath's Ratna Bhandar

Days before the opening of the inner secret chamber of Puri Jagannath Temple's Ratna Bhandar, the temple committee was looking for a skilled snake catcher. This, amid rumours of hissing sounds from the **Bhitara Bhandar and** legends that a group of serpents guard the valuables. What's the fact and myth?

New Delhi: Be it the snake tales of the world's richest Sree Padmanabhaswamy Temple in Thiruvananthapuram, or the stories of dancing Burmese pythons guarding the relics of Gautam Buddha buried deep beneath the Mandalay temple's foundations, snakes and serpents have often been regarded as guardians of treasures. The talk of snakes coiled around the hidden riches has long been common in Hindu and Buddhist traditions. Mythology and movies like Naag Nagin (1989), too, have been full of such instances. The Ratna Bhandar of the Jagannath Temple, therefore, is no exception. There are legends of a group of serpents closely guarding the valuables of the Mahaprahu, Lord Jagannath, and the other deities of the temple in Puri.

SNAKE SCARE AT JAGANNATH TEMPLE AHEAD OF RATNA **BHANDAR OPENING?**

Six years ago, in 2018, following an order from the Orissa High Court, a joint team



from the Archaeological Survey of India (ASI) and officials from Puri's Jagannath Temple ventured into the Ratna Bhandar to examine its structural condition.Outside, along with a buzzing crowd of devotees and rescue personnel, two expert snake catchers, specially called in from Bhubaneswar, stood ready to assist if needed.On the eve of the 2018 search, when sand artist Sudarsan Pattnaik, now a member of the temple committee, amplified the cause of the Ratna

Bhandar on the Puri beach, a snake found prominence in his artwork.

New Delhi: The Ministry of Home Affairs has amended the rules of the Jammu and Kashmir Reorganisation The Department of Law, Justice and Act 2019, giving more power to Lieutenant Governor Manoj Sinha amid speculation of assembly polls being held in the Union Territory soon. This effectively means any elected government in the Union Territory will have limited powers when it comes to critical matters, including internal security, transfers, prosecution, and appointment of government lawyers, including the Attorney-General.

Bypoll results: INDIA jolts BJP, wins 4 of 13 assembly seats, ahead in 7

New Delhi:Kamlesh Thakur, wife of Himachal Pradesh Chief Minister Sukhvinder Sukhu and the INDIA bloc's candidate, won the Dehra assembly byelection on her poll debut. Meanwhile, the Aam Aadmi Party (AAP) secured the Jalandhar West constituency in Punjab while the Trinamool Congress bagged two seats in Bengal. The opposition INDIA bloc looked set to give the ruling BJP a jolt in the by-elections for 13 seats across seven states. The INDIA bloc is leading in 7 of the rest 9 seats. The bypolls are being considered as a litmus test for the BJP, which is reeling from the rude shock of failing to clear the majority mark in last month's Lok Sabha elections. The counting of votes began at 8 am at key constituencies in West Bengal, Uttarakhand, Madhya Pradesh. Himachal Pradesh, Tamil Nadu, Punjab and Bihar. The fiercely contested bypolls, that took place on July 10, are the first since the Lok Sabha election, with the ruling BJP and the opposition INDIA

bloc, comprising Congress, Trinamool Congress, DMK and the Aam Aadmi Party, vying for the seats.In Punjab's Jalandhar West seat, AAP's Mohinder Bhagat defeated his nearest rival and Congress nominee Surinder Kaur by 37.325 votes. Bypolls were announced in the constituency after Sheetal Angural, the AAP legislator, jumped ship to the BJP. The hill state of Himachal Pradesh was witnessing a Congress surge, with the ruling party's candidates putting up a strong show in all three seats that went to bypolls. Chief Minister Sukhvinder Sukhu congratulated his wife Kamlesh Thakur for her win in Dehra. Thakur beat her nearest rival, BJP's Hoshiyar Singh, by a margin of 9,399 votes. In the Hamirpur seat, Congress's Pushpinder Verma was ahead by 1,707 votes against BJP candidate Ashish Sharma. Hardeep Singh Bawa of the Congress was also leading by 1,571 votes against the BJP's KL Thakur in Nalagarh.All three BJP candidates used to be independent legislators, who resigned from the Himachal assembly after voting for the saffron party in the Rajya Sabha polls earlier this year. In West Bengal, where



four seats are up for grabs, Trinamool Congress's Madhupurna Thakur and Krishna Kalyani won by a landslide in Bagda and Raiganj respectively. The ruling party's candidates also took the ead in Ranaghat and Maniktala.Madhuparna (25), the daughter of Trinamool's Rajya Sabha MP

Mamatabala Thakur, is set to be the youngest member of the Bengal assembly.Congress candidate Qazi Nizamuddin was ahead in Uttarakhand's Manglaur with 12,540 votes, followed by BSP nominee Ubedur Rehman, and the

BJP's Gujjar leader Kartar Singh Bhadana a distant third. The constituency had witnessed violence on the day of polling.n Badrinath, Congress newcomer Lakhpat Singh Butola was leading. He is facing off against BJP's Rajendra Bhandari.

The ruling DMK's candidate Annivur Siva (alias Sivashanmugam A) was leading in the Vikravandi assembly constituency in Tamil Nadu in early trends. He is pitted against C Anbumani and Naam Tamilar Katchi's K Abinaya.In Bihar, JD(U)'s Kaladhar Prasad Mandal was leading by 2,433 votes over his nearest rival, an independent candidate, in the Rupauli bypoll. RJD nominee Bima Bharti was in third place with 2,359 votes.

Stuck in the wrong job? Brave enough to have changed careers, three go-getters explain how you can exchange 'earning a living' to `living a life'.

Stuck in the Wrong Career?

Strong performances certainly helped make Raju Hirani's 3 Idiots a record breaking success, but more than the calibre of its actors, what seemed to resonate more with the country's young audience was its message -one's career choice should not be dictated by parents or peers. It should, instead, reflect one's own predilections. Shalini Umachandran's new book You Can Make Your Dreams Work profiles 15 individuals who have managed to fight against all odds and pursue a career option of their choice years after having started out in another profession.

Umachandran says the motivation was simple -people switched careers to follow their own interests or passions. "Not all of us have one overarching passion. We don't always know what we want, but you need to zero in on what you like most," says the author and journalist. Most of the profiles in Umachandran's book are of people who had spent five-six years in a certain profession before they decided to make a shift. So, one would imagine that they had a body of work to fall back on. But Umachandran informs that none of them considered their previous profession as a backup. "When you decide to take the plunge, you ought to have an 'all or nothing' perspective.If you have a 'plan B', you won't be as committed. They also said it is best not to give oneself a deadline like: 'I'll try it out for a year'," explains the author.

Featured in Umachandran's book, here are three career mavericks who have managed to ditch their old jobs to follow their dream. They tell us how to figure out if you're in the wrong profession, find what's best for you and prepare for metamorphosis.

FROM TOXICOLOGY TO SOCCER

Abhijit Barse was living the great American dream after a PhD in aquatic toxicology. He had joined a German company in the US as a toxicologist, but a year and a half later, he somehow felt empty.

you're in the wrong job. "PRIOR RESEARCH IS ESSENTIAL"

If you're just beginning your career, it's easier to make a shift. As time passes, responsibilities pile up and you can't chuck one job and pick another easily. I didn't do it overnight. I eased myself into it. A change of job can leave you with psychological problems, especially when you go from a '9 to 5' job to one where you don't have assigned timings. When I started out, there was no money, projects or structure, so I had to study about the field. This is essential before you nose-dive into a new profession. You need to know exactly what your job description would be and what the job entails.

FROM WALL STREET TO SOCIAL WORK

Vikram Bhat, a Wall Street analyst in New York, gave up his 10-year career in finance and computer engineering in 2008. Having moved to Bangalore, Bhat decided to teach in a school for children from low-income families.

"AVOID UNREALISTIC EXPECTATIONS"

Financial security is the biggest obstacle when trying out a new profes sion. At 33, when I decided to figure out what I wanted to do, I was old enough to not have to listen to my parents. My wife is a doctor and it helped that she had a stable income and was willing to support me. The biggest challenge when you enter a new career is that you have unrealistic expectations about how satisfying it will be. We all have a certain vi sion of ourselves, but we don't build on it much. Try to figure out how practical or impractical that vision is by making it more realistic for yourself. have your basic finances sorted and have close ones on board with your decision. Find yourself a mentor and periodically remind yourself why you made the shift. You have to be patient as you will face disappointment in your new career. You need to envision the progress you see for yourself in this new chapter.

FROM LAW TO LEH

Piya Bose ditched the legal profession to launch Girls On The Go, an allwomen's travel company, in 2008. Initially clueless about what she wanted to do, the former corporate lawyer's only mission was, 'I would rather live than spend my life earning a living'.

"EMBRACE THE UNPREDICTABLE"

I was working at a reputed law firm in Mumbai and I took home a fat paycheck. But the work I was doing failed to inspire me. I had no doubt that I was stuck in the wrong job.Stepping into a new profession without a guide was a trial by fire. Startup cash was a challenge. I overcame that with a zero-cash business model. Entrepreneurship is all about unpredictability, a certain risk appetite and having faith in the invisible forces that govern the market. I once went through a prolonged rough patch when things didn't work out as planned. I encountered aggressive clients and started losing faith in myself, but I couldn't give up.

Barse returned to India and decided to teach at a college in Nagpur and then quit teaching to join Nagpur-based Slum Soccer in 2010, an organisation that uses football to keep kids in school and off drugs."

Gossip

Gossip in the workplace can function as a weapon to attack people's reputation or a gift in enhancing it, according to researchers.

Lead researcher Tim Hallett, assistant professor in Indiana University Bloomington's Department of Sociology, and team looked at the power dynamics involved in organizational charts as the gossip unfolded.

The study "identifies subtle ways that people who are targets of gossip are negatively evaluated during formal work meetings, including veiling criticism with sarcasm or talking up another colleague for comparison.

"It also discusses how efforts to embark on negative gossip can be effectively -- and again, subtly -- derailed, by changing the subject, targeting someone else for criticism or by pre-emptive comments that are positive."

Hallett said: "When you're sitting in that business meeting, be attentive to when the talk drifts away from the official task at hand to people who aren't present.

"Be aware that what is going on is a form of politics and it's a form of politics that can be a weapon to undermine people who aren't present. But it also can be a gift. If people are talking positively it can be a way to enhance someone's reputation."

The research, co-authored by IU sociologist Donna Eder, a leading authority in gossip research, and Brent Harger, now a sociologist at Albright College, further discovered that gossip in a formal setting is more likely to involve veiled criticism.

Hallett said: "If you're interested in learning how an organization works, you can look at the organizational chart, which can be useful. "But often people say, 'I still can't tell how things get done, who the



prime movers are.' If you're attentive, you can see who has the

informal status, which isn't on the formal charts. It can help you

understand how work actually gets done."

Promoters sell stakes worth Rs 1.1 lakh crore in 15 months amid stock market surge

Mumbai The big jump in valuations that the market and the companies are now commanding is enticing an increasing number of promoters – both local and multinational – and private equity (PE) funds to divest stakes and book bumper profits. In the last 15 months, Indian promoters have sold over Rs 1.12 lakh crore (Rs 82,005 crore in FY24 and Rs 35,588 crore in the first quarter of FY25) of equity through the secondary market. This is equivalent to the net systematic investment plan (SIP) inflow to mutual funds during this period. This is a big rise from Rs 45,448 crore share sales by promoters in FY23. In May alone, Indian and MNC promoters of 20 companies have sold up to 20 per cent of their stakes in the secondary market raising Rs 40,000 crore, according to a research report prepared by Axis Mutual Fund Chief Investment Officer Ashish Gupta.

The report also said only 6.6 per cent – around Rs 5,300 crore — of Rs 80,000 crore raised from the market was used for capital expenditure as two third was "offer for sale" from private equity investors and promoters with money going to their coffers. The Sensex jumped by over 32 per cent, or 21,000 points, to over 80,000 since April 2023, sending stock valuations to new highs. This had prompted PE funds and promoters to book profits. Stake sale by MNC parents in past 15 months amounted to nearly Rs 74,000 crore (Rs 46,822 crore in FY24 and Rs 27,118 crore in Q1 of FY25) as against Rs 12,114 crore in FY23. "This is not surprising with nearly a dozen MNC subsidiaries in India today trading at four times the multiple their parents trade at in the home market," Gupta said. Secondary market sales by promoters and of private equity stakes since April 2022 has been Rs 4.42 lakh crore compared to gross SIP flows of Rs 3.96 lakh crore and overall net inflow of Rs 5.02 lakh crore into mutual funds, the report said.Gupta's report said private equity funds have arguably reaped the most benefits from rising equities. In the past 15 months, they have also divested Rs 1.15 lakh crore (Rs 79,812 crore in FY24 and Rs 35,558 crore in Q1 of FY25) worth of equity stakes in the secondary market, in



addition to the stakes offered in the initial public offerings (IPO). The accelerated pace of PE exits is reflected in the decline in net FDI over the past few years, with FDI outflows rising from Rs 2.25 lakh crore to Rs 3.40 lakh crore, the report said.The 91 IPOs that have come to the market in the past 15 months have raised Rs 80,000 crore. "Unlike in the past most of this raise has not been growth capital. Two-thirds of these have been "offer for sale" from private equity investors and promoters. Of the remaining one-third, only 20 per cent of IPO proceeds are intended for capex and another 15 per cent raised by financial companies to augment their lending capabilities," Gupta said. The IPO pipeline over the next few months is larger at another Rs 93,000 crore. "Private equity selling is likely to accelerate. These funds currently hold Rs 277,000 crore worth of stakes in listed companies and of these over Rs 217,000 crore are of more than 3-year vintage and therefore should be offered in the market sooner rather than later. In the

coming months, pre-IPO locked in shares of the 91 recent IPOs will also come to the market given that on average these IPOs are up 79 per cent from their issue price," the report said.In addition, these funds have investments of Rs 4.67 lakh crore in companies that are still private. Of this, Rs 3.70 lakh crore is of more than three-year vintage. Assuming, 60 per cent of these are exited via the public market route and have MOIC (multiple of invested capital) of two times, and 50 per cent will be sold in IPOs these will be another Rs 2,24,000 crore of potential supply, it said. Stake sale by MNC parents in past 15 months amounted to nearly Rs 74,000 crore.

HCL Q1 profit rises 20% to Rs 4,257 cr

BENGALURU. HCL Tech's June quarter performance beat Street estimates as the IT services firm posted a 20% year-on-year increase in its consolidated net profit at Rs 4,257 crore compared to Rs 3,534 crore in the year-ago period.Its revenue from operations in the first quarter was Rs 28,057 crore, up 6.7% compared to Rs 26,296 crore in the same quarter last year. The company retained its constant currency (CC) revenue growth guidance between 3% and 5% in FY25 and EBIT margin is expected to be between 18% and 19%.Briefing the

media on outlook for Q2, C Vijayakumar, CEO & MD, HCLTech said, "In the second quarter, we expect to grow in all geographies and verticals except financial services. Even in manufacturing we expect to recover in Q2."Usually Q1 is a seasonally soft quarter for the company. He added that Q2 will be a soft quarter for

financial services after that we are confident of sequential growth in financial services. Its financial services was down 1.3% in Q1 and



manufacturing grew 3.5% YoY. The CEO added that discretionary spending will be the same as last year and we continue to spend on Gen AI and other emerging technologies. "We clocked in \$2 billion TCV (total contract value) of new business bookings," he said. The CEO said there are over 200 Gen AI PoCs (proof of concepts) and several of them are going into production.

Roshni Nadar Malhotra, Chairperson, HCLTech, said, "With our future-ready portfolio, we are well placed to tap emerging opportunities led by GenAI." Prateek Aggarwal, CFO said, the

company delivered an INR revenue growth of 6.7% YoY, healthy given the global environment. EBIT margins came in at 17.1%, steady on YoY basis.

The company's headcount was reduced by 8,080 in the first quarter and it lost around 7,398 employees due to divestiture. It added 1,078 freshers in the June quarter and is likely to hire 10,000 freshers in FY25.

Amid criticism over delayed resolution of cases under the Insolvency and Bankruptcy Code (IBC), the chairman of insolvency regulator pointed out on Friday that 270 cases defaults were resolved in 2023-24 against the average 125 in the previous years. Ravi Mital, the chairman of Insolvency and Bankruptcy Board of India (IBBI), said that the number of resolution per year would continue to grow.Mital was speaking at an event organized by the Institute of Chartered Accountants of India (ICAI). He said that it is crucial for project completion to be timely and efficient. "Faster resolutions can address many concerns," said Mital.He said that India has outperformed many countries in insolvency resolution, and Indian resolution professionals should extend their expertise globally."IBC not only protects creditors' interests but also promotes economic growth in the nation, which is reflected by NPAs being at the lowest levels," he added.

The IBC has successfully settled around 28,000 cases, and around Rs 3.4 lakh crore debt has been settled. Mital, however, pointed out the need for

Moreover, the total refunds issued in FY 2024-25 amounted to Rs 70,902 crore, representing a significant surge of 64.49 per cent compared to the previous year.In FY 2023-24, the total tax refunds issued by the government were Rs 43,105 crore. The increase in tax refunds highlights the
