UP Deputy CM Keshav Prasad Maurya's cryptic post on X

Lucknow, July 17: Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya on Wednesday said the party is bigger than the government, a cryptic remark on X that has fuelled speculation over a "rift" in the BJP state unit. "The organisation is bigger than the government, the pain of the workers is my pain. No one is bigger than the organisation, the workers are the pride," the post shared by the office of the deputy CM on X said. It quoted a part of Maurya's address during the BJP's working committee meeting in Lucknow on Sunday. The post also had a picture of the meeting in the backdrop. "The organisation was bigger than the government and will always be bigger. The doors of my residence at 7 Kalidas Marg are open to everyone. I am Deputy Chief Minister later

but first I am a worker," Maurya said in the meeting. He also urged all the ministers, MLAs, and public representatives to respect party workers. The post comes a day after Maurya met BJP president J P Nadda in New Delhi amidst rumours of an alleged rift between him and Chief Minister Yogi Adityanath. Neither the BJP nor Maurya said anything about the meeting while senior BJP leaders, including Uttar Pradesh Minister Swatantra Dev Singh and Finance Minister Suresh Khanna, have also remained Meanwhile,

Samajwadi Party president Akhilesh Yadav has alleged "infighting" in the BJP and claimed it was harming people's welfare. "In this fight for power, it is the people of Uttar Pradesh who are suffering," Yadav told reporters at the SP headquarters here earlier in the day.

Puja Khedkar's disability certificate has factory address

Chandigarh, July 17: The Pune Police said they would probe the veracity of medical certificates of probationary IAS officer Puja Khedkar. Khedkar-the 2023batch officer currently posted in Washim district-had submitted to the Union Public Service Commission (UPSC) multiple medical certificates, one of them indicating visual impairment, under the Persons with Benchmark Disabilities (PwBD) provision. The 34year-old Maharashtra cadre officer faces accusations of using fraudulent means to clear her civil services exam, including allegedly misrepresenting herself under the physical disabilities and OBC categories, and misusing power and privileges during her posting in Pune. Meanwhile, questions are now being raised on a disability certificate issued to her by a Pune hospital. This is among the several disability certificates that have emerged over the last couple of weeks after her selection into civil service came under the scanner. She had submitted two certificates issued by the Ahmednagar District Civil Hospital in 2018 and 2021 to the UPSC. She had also applied for a disability certificate from Aundh government hospital in Pune in 2022, but the application was rejected after medical tests. The disability certificate issued by Pune's Yashwantrao Chavan Memorial Hospital is dated August 24, 2022. It mentioned Khedkar's address as "Plot No 53. Dehu Alandi Road, Talawade, Pimpri Chinchwad" in Pune district. No house was found at this location, but a factory named Thermoverta Engineering Company. However, her luxury car-confiscated by police for allegedly stalling a red beacon light on it illegally –is registered in the name of this company. The Office of the Commissioner For Persons With Disabilities has written a letter to the Pune police and the district collectorate to verify the certificates submitted by Khedkar. It has also emerged that the controversial junior IAS officer had submitted a fitness certificate while securing admission to a private medical college in 2007.

New Delhi, July 17: Asserting that he was "not a terrorist", but the Chief Minister of Delhi, AAP leader Arvind Kejriwal on Wednesday assailed his arrest by the CBI in a corruption case linked to excise policy 'scam' and sought his release on bail, saying his arrest was not as per the mandate of the law. "It is unfortunately an insurance arrest. I have effectively three release orders in my favour (in the ED case) under very stringent provisions... These orders show that the man is entitled to be released. He would have been released but for this insurance arrest," senior advocate Abhishek Manu Singhvi told Justice Neena Bansal Krishna on behalf of Kejriwal. CBI counsel DP Singh opposed Kejriwal's petition against his arrest and said that terming the arrest an "insurance arrest" was unjustified. Justice Krishna, who heard the matter on a holiday on account of Muharram, reserved the order on Kejriwal's petitions challenging his arrest by the CBI in the excise policy case and seeking interim

Grading of employee cannot be reduced only because he is wheelchair-bound: Delhi High Court

Chandigarh, July 17: Observing that superior officers should write annual confidential reports (ACR) in a fair, objective and dispassionate manner, the Delhi High Court has held that the performance of a disabled employee who

has been working diligently cannot be downgraded only because he was wheelchair bound. An Assistant Sub-Inspector employed as a dental technician in the Border Security Force (BSF), while returning to his place of posting in Punjab after leave, had met with an accident in 2014, which severely affected the lower part of his body. A medial board declared him a paraplegic and his disability was

assessed at 100 per cent. However,

despite the disability, he continued to diligently serve the BSF and was always awarded 'very good' grading in his ACR till 2016-17. However, in his next three ACRs, his performance was downgraded

to only 'good'. This, according to his petition, affected his chance to get promotion

under the modified assured career progression scheme. He represented against the ACRs, but to no avail. In 2021, he was discharged from service on medical



grounds. He averred that the grading of 'good' was wholly unsustainable as his reporting officer, despite noticing the fact that irrespective of his disability, he was working diligently, had downgraded him

plegic and wheelchair bound. The remarks in his last three ACRs mentioned that he is a paraplegic and needs assistance. He contended that he had been downgraded only because he was suffer-

ing from 100 percent disability and not because of any shortcoming in his performance which was evident from the fact that there is no comment/ or observation in any of the three ACRS that his performance had dipped in any manner. Nor was he ever issued any warning letter or a show cause notice. Expressing anguish over the manner in which the petitioner's ACRs have been recorded by the reporting officer and subsequently approved by the reviewing and accepting officers, the Bench said that the respon-

dents, despite being well aware that the petitioner in spite of 100 disability was continuing to sincerely perform the work assigned to him, were clearly swayed by the fact that he was using a wheelchair and needed assistance.

Justice N Kotiswar Singh and Justice R Mahadevan to take oath as Supreme Court judges today

New Delhi, July 17: Justice N Kotiswar Singh and Justice R Mahadevan will take oath as Supreme Court judges on Thursday. Chief Justice of India DY Chandrachud will administer the oath of office to the two newlyappointed judges of the top court at 10.30 AM, sources said, adding the Supreme Court will regain its full strength of 34 judges, including the CJI. The Centre had on Tuesday notified their appointments, five days after the Supreme Court Collegium recommended the elevation to the top court. Justice Singh, who has been the Chief Justice of the High Court for Jammu and Kashmir and Ladakh since February 2023, is the first judge from Manipur to be elevated to the Supreme Court. "His (Justice Singh's) appointment will provide representation to the North-East, and in particular he will be the first judge from Manipur to be appointed as a judge of the SC, the Collegium had said. 

Mumbai, July 17: A Marathi weekly linked to the RSS has sought to blame the NCP for the BJP's poor performance in the recent Lok Sabha elections, stating that public sentiments completely went against the saffron party after it joined hands with the Ajit Pawarled outfit. According to it, the Bharatiya Janata Party (BJP) members and others it interacted with said they did not approve of the party's move of joining hands with the Nationalist Congress Party (NCP). It added that the unrest among the party cadre was just the "tip of the iceberg". It also said that coordination and the importance given to party workers in decision-making and governance helped the BJP sweep the Lok Sabha polls in Madhya Pradesh. In the Lok Sabha polls, the BJP's seat tally in Maharashtra came down to nine from 23. Its ally Eknath Shinde-led Shiv Sena won seven seats, while another Mahayuti constituent - Ajit Pawar's NCP - could just bag one. The Opposition Maha Vikas Aghadi (MVA), comprising the

The Election Commission of India (ECI) and legislative assembly speaker later upheld his claims. "However, the sentiments went

totally against the party (BJP) after it joined hands with NCP. The question also arises about the future plans of the party when political arithmetic went against it because of NCP," it added. The BJP got the image of inducting leaders from other parties, completely ignoring the organisational process of grooming leaders, which in the past existed and benefited in the form of Atal Bihari Vajpayee or at the state level with Gopinath Munde, Pramod Mahajan, Nitin Gadkari and Devendra Fadnavis. All of them were humble party workers and later became leaders, and they always knew this fact, the article said. It made an indirect reference to state BJP functionary Shweta Shalini's legal notice to YouTuber Bhau Torsekar, who propagates Hindutva ideology through his channel. In one of the recent posts, he made a critical remark against Shalini, following which she issued a legal notice to him. However, she later withdrew it. Wait to end, piped water supply to Gwalpahari by '26

Gurgaon. The long wait for piped water supply for residential societies in Gwalpahari is likely to end soon, with GMDA allotting work for construction of a boosting station in the area. The Rs 4.3-crore project includes an underground tank with a capacity of 4,000 kilolitres, along with a sump and pump house and is expected to be completed in 18 months. At present, residents of highrise societies and villages in the area rely on borewells or water tankers to meet their daily needs. This project has been in the pipeline since 2019, and the work was allotted to an agency in 2020. But execution was delayed due to pending litigation over land acquisition, which was resolved last year, officials said. With the resolution, the metropolitan authority re-initiated the tendering process in Nov 2023.

GMDA officials said they floated tenders four times before the project work was finally awarded to a contractor recently. Water from the Chandu Budhera water treatment plant (WTP) will be supplied to the boosting station in Sector 72, from where it will be further sent to the Gwalpahari boosting station for distribution in residential areas there.

"The authority is making efforts to ensure canal water supply in Gwalpahari. We have awarded the project for the construction of a boosting station to an agency, and work will start soon. We are hoping to complete the work within the stipulated timeline of 18 months," said Rajesh Bansal, GMDA chief engineer.GMDA is also planning to take up completion of 2.1km of water pipelines in the area from HSVP, which will be connected to the proposed boosting station in Gwalpahari. This development will provide much-needed relief to the residents who have been struggling with inadequate water supply for years. According to GMDA's infrastructure development plan, the projected population of Gwalpahari will touch 43,516 by 2031 and 51,707 by 2041.

10cm gap: Rapid & new metro lines can't be merged, so interchange stn proposed

Gurgaon. The Gurugram Metro Rail Limited (GMRL) is considering building an interchange station, possibly at Cyber City – all because of a 0.1-metre (or 10cm) difference in the width of a regular metro coach and a Rapid Metro coach. The interchange station, officials said on Tuesday, is meant to connect the proposed Huda City Centre-Cyber City corridor with the Rapid Metro line in the city. Had the technicalities matched, authorities could have simply extended the Rapid Metro line and allowed trains to run on the same tracks. Officials said they recognised some challenges in being able to use the Rapid Metro line infrastructure. For instance, the coach of a train on the Rapid Metro line is 2.8 metres wide, and that on a regular metro line is 2.9m."Running a regular metro train on the existing Rapid Metro line would require significant alterations, including layout changes, procurement of new coaches for Rapid line and sourcing electricity. Additionally, the duration for which the Rapid Metro would have to be made non-functional during these alterations may not be feasible," a GMRL official said.

The official added that the Delhi Metro Rail Corporation (DMRC) will submit a feasibility report. Though no decision has been made, the interchange station could be built at Cyber City. Public transportation in Gurgaon has barely seen any change even though the city's population and reputation as a hub of corporates and IT firms has rapidly grown over the years. Currently, the city has just 17km of metro line -- 5.3km of the Delhi Metro's yellow line, and 11.7km of Rapid Metro. The last expansion was in 2017, when the Rapid Metro, which connects Cyber City and almost the entire length of Golf Course Road, was thrown open to commuters in its entirety. In June 2023, the Union Cabinet approved the 28.5km corridor between Millennium City Centre and Cyber City with 27 elevated stations that will cross Old Gurgaon as well. Its estimated cost is Rs 5,452 crore. Prime Minister Narendra Modi laid the foundation stone for the corridor in Feb this year.

On Tuesday, GMRL decided to open the bid of the lone firm that applied for the position of a detailed design consultant (DDC) for the project.

Property dealer shot at in leg over monetary dispute

Gurgaon. A property dealer was allegedly shot at in his leg, and his friend was physically assaulted at another property dealer's office near Dwarka Expressway in Daultabad over a monetary dispute in the early hours of Monday. According to police, the accused are currently absconding. The duo — Rajkumar Sahrawat and Sachin Gulati from New Colony — are currently undergoing treatment and are stable, officials said. According to police, at 2am on Monday, the duo had gone to visit the accused, Mogli at his office.

Subsequently, a disagreement over money arose between Rajkumar and Mogli. Later, the situation escalated and the accused fired around 5-6 rounds—out of which a few rounds were fired in the air— and one bullet hit Rajkumar in the leg. Meanwhile, Sachin was physically assaulted by Mogli's associates.

'A preliminary probe revealed that Rajkumar owed around Rs 5-6 lakh to another property dealer and had not paid the amount on time," said an official.

According to the official, the accused and his associates left the crime scene immediately. The passersby informed the police and took the duo to Civil Hospital in Sector 10." From Goldy Brar to Arshdeep Dalla to Rohit Godara: Haryana Police's global pursuit of gang leaders

GURGAON. The special task force through a similar deportation process. (STF) of Haryana Police on Tuesday handed over a list of 20 gangsters, who are operating their networks to carry out criminal activities in the state and Delhi-NCR while staying abroad, to the Union home ministry and Interpol seeking their deportation.

The list includes some known names the likes of Goldy Brar, Lipin Nehra, and Rohit Godara of the Lawrence Bishnoi gang. All three are believed to be in Canada, and Brar is a key accused in the 2022 murder of Punjabi singer Sidhu Moosewala.Others on the list are Himanshu Bhau, the gang leader who claimed on social media that he had orchestrated the shooting of a man at a Burger King outlet in Delhi's Rajouri Garden this June. Bhau is believed to be in Portugal. Last week, Kala Khairampuria, who allegedly had a hand in the Burger King shooting, was brought back to India from Thailand

Khairmpuria absconded after he was released on parole in 2020. His network operates in Haryana, Delhi and 228 Rajasthan, and charges against the gang include murder and extortion. In the last five years, three more gangsters were repatriated to India from their hideouts in foreign countries and arrested by Haryana Police. Gangster Kaushal, who fled to Dubai in 2017, was extradited in 2019 and arrested on his return to NCR. He is lodged in Bhondsi jail. Gangster Raju Bishodi was brought from Thailand in 2020 and is imprisoned in Bhondsi jail too. Vikas Lagarpuria, one of the most wanted gangsters in Delhi and Haryana with at least 30 criminal cases against him, was repatriated in 2022 from Dubai. Langarpuria, lodged in Bhondsi jail, was allegedly behind the multi-crore heist from an apartment in Gurgaon's Sector 84 in 2021. A senior police officer said on Tuesday that

on fake passports and documents, and still manage to pull the strings while in hiding. "Even after issuing a Red Corner notice, gangsters leave India after getting passports on fake documents. They make calls from abroad and orchestrate crimes like extortion, murder and supply of arms and drugs," the officer said. This trend of evading prosecution in India, another senior police officer said, began with Surendra Gyong, of Kaithal in Haryana, who fled to South Africa in the early 2000s and died in an encounter with Haryana Police in 2017.Other gangsters started following in his footsteps, initially taking cover in countries that offer visa-on-arrival to Indians - Thailand, Dubai, Malaysia, etc.After that, the network spread to Canada and US, and in recent years, wanted criminals opted for countries like Azerbaijan, Portugal and even

'Twenty gangsters operating criminal activities in India from abroad are on our radar. The process to deport them back to India has started. It is ongoing in different phases as the deportation process is separate for each. They will be brought back once it is complete," said Simardeep Singh, DIG STF.Some other prominent names on Haryana Police's list are Arshdeep Singh alias Arsh Dalla, who was allegedly behind the beheading of a man in northwest Delhi last year and is also wanted by police in Sonipat.

3 illegal colonies razed in Sohna, 10-acre land cleared

Gurgaon. Three unauthorised colonies were razed in the revenue estates of Lakhuwas and Sohna in a drive conducted on Tuesday. Severeal illegal buildings were demolished in an attempt to curb unauthorised land development in the area. In Lakhuwas, five structures, one boundary wall, and a 400-metre road network built on a 4acre colony were demolished.

In Sohna, two unauthorised colonies, each spread over approximately 3 acres, were demolished. The colonies were located along the Sohna-Palwal and Sohna-Nuh roads, where illegal construction is frequently observed. As many as 15 structures and a 200metre internal road network were demolished.Officials have appealed to the public to avoid investing in unauthorised colonies. They have emphasised the importance of verifying the legal status of land and properties before purchasing.

Wait to end, piped water supply to Gwalpahari by '26

Gurgaon. The long wait for piped water supply for residential societies in Gwalpahari is likely to end soon, with GMDA allotting work for construction of a boosting station in the area. The Rs 4.3-crore project includes an underground tank with a capacity of 4,000 kilolitres, along with a sump and pump house and is expected to be completed in 18 months.At present, residents of highrise societies and villages in the area rely on borewells or water tankers to meet their daily needs. This project has been in the pipeline since 2019, and the work was allotted to an agency in 2020. But execution was delayed due to pending litigation over land acquisition, which was resolved last year, officials said. With the resolution, the metropolitan authority re-initiated the tendering process in Nov 2023.

GMDA officials said they floated tenders four times before the project work was finally awarded to a contractor recently. Water from the Chandu Budhera water treatment plant (WTP) will be supplied to the boosting station in Sector 72, from where it will be further sent to the Gwalpahari boosting station for distribution in residential areas there.

"The authority is making efforts to ensure canal water supply in Gwalpahari. We have awarded the project for the construction of a boosting station to an agency, and work will start soon. We are hoping to complete the work within the stipulated timeline of 18 months," said Rajesh Bansal, GMDA chief engineer.GMDA is also planning to take up completion of 2.1km of water pipelines in the area from HSVP, which will be connected to the proposed boosting station in Gwalpahari. This development will provide much-needed relief to the residents who have been struggling with inadequate water supply for years. According to GMDA's infrastructure development plan, the projected population of Gwalpahari will touch 43,516 by 2031 and 51,707 by 2041.

10cm gap: Rapid & new metro lines can't be merged, so interchange stn proposed

Gurgaon. The Gurugram Metro Rail Limited (GMRL) is considering building an interchange station, possibly at Cyber City – all because of a 0.1-metre (or 10cm) difference in the width of a regular metro coach and a Rapid Metro coach. The interchange station, officials said on Tuesday, is meant to connect the proposed Huda City Centre-Cyber City corridor with the Rapid Metro line in the city. Had the technicalities matched, authorities could have simply extended the Rapid Metro line and allowed trains to run on the same tracks. Officials said they recognised some challenges in being able to use the Rapid Metro line infrastructure. For instance, the coach of a train on the Rapid Metro line is 2.8 metres wide, and that on a regular metro line is 2.9m. "Running a regular metro train on the existing Rapid Metro line would require significant alterations, including layout changes, procurement of new coaches for Rapid line and sourcing electricity. Additionally, the duration for which the Rapid Metro would have to be made non-functional during these alterations may not be feasible," a GMRL official said.

The official added that the Delhi Metro Rail Corporation (DMRC) will submit a feasibility report. Though no decision has been made, the interchange station could be built at Cyber City. Public transportation in Gurgaon has barely seen any change even though the city's population and reputation as a hub of corporates and IT firms has rapidly grown over the years. Currently, the city has just 17km of metro line -- 5.3km of the Delhi Metro's yellow line, and 11.7km of Rapid Metro. The last expansion was in 2017, when the Rapid Metro, which connects Cyber City and almost the entire length of Golf Course Road, was thrown open to commuters in its entirety. In June 2023, the Union Cabinet approved the 28.5km corridor between Millennium City Centre and Cyber City with 27 elevated stations that will cross Old Gurgaon as well. Its estimated cost is Rs 5,452 crore. Prime Minister Narendra Modi laid the foundation stone for the corridor in Feb this year.

On Tuesday, GMRL decided to open the bid of the lone firm that applied for the position of a detailed design consultant (DDC) for the project.

Property dealer shot at in leg over monetary dispute

Gurgaon. A property dealer was allegedly shot at in his leg, and his friend was physically assaulted at another property dealer's office near Dwarka Expressway in Daultabad over a monetary dispute in the early hours of Monday. From Goldy Brar to Arshdeep Dalla to Rohit Godara: Haryana Police's global pursuit of gang leaders

GURGAON. The special task force (STF) of Haryana Police on Tuesday handed over a list of 20 gangsters, who are operating their networks to carry out criminal activities in the state and Delhi-NCR while staying abroad, to the Union home ministry and Interpol seeking their deportation.

The list includes some known names the likes of Goldy Brar, Lipin Nehra, and Rohit Godara of the Lawrence Bishnoi gang. All three are believed to be in Canada, and Brar is a key accused in the 2022 murder of Punjabi singer Sidhu Moosewala.Others on the list are Himanshu Bhau, the gang leader who claimed on social media that he had orchestrated the shooting of a man at a Burger King outlet in Delhi's Rajouri Garden this June. Bhau is believed to be in Portugal. Last week, Kala Khairampuria, who allegedly had a hand in the Burger King shooting, was brought back to India from Thailand through a similar deportation process. Khairmpuria absconded after he was released on parole in 2020. His network operates in Haryana, Delhi and 23s Rajasthan, and charges against the gang include murder and extortion. In the last five years, three more gangsters were repatriated to India from their hideouts in foreign countries and arrested by Haryana Police. Gangster Kaushal, who fled to Dubai in 2017, was extradited in 2019 and arrested on his return to NCR. He is lodged in Bhondsi jail. Gangster Raju Bishodi was brought from Thailand in 2020 and is imprisoned in Bhondsi jail too. Vikas Lagarpuria, one of the most wanted gangsters in Delhi and Haryana with at least 30 criminal cases against him, was repatriated in 2022 from Dubai. Langarpuria, lodged in Bhondsi jail, was allegedly behind the multi-crore heist from an apartment in Gurgaon's Sector 84 in 2021. A senior police officer said on Tuesday that



wanted gangsters end up going abroad on fake passports and documents, and still manage to pull the strings while in hiding. "Even after issuing a Red Corner notice, gangsters leave India after getting passports on fake documents. They make calls from abroad and orchestrate crimes like extortion, murder and supply of arms and drugs," the officer said. Sydney. Tenacious D frontman Jack Black has cancelled the comedy-rock group's tour of Australia and New Zealand, after his bandmate stoked outrage with a quip about the attempted assassination of Donald Trump.

Guitarist Kyle Gass said "don't miss Trump next time" when asked to make a birthday wish while playing a packed gig in Sydney over the weekend, part of the band's "Spicy Meatball" tour. While the jibe drew laughter and applause from the crowd, it swiftly sparked controversy when posted online."I was blindsided by what was said at the show on Sunday," said Black, the Hollywood funnyman who starred in films such as "School of Rock", "High Fidelity" and "Kung Fu Panda"."After much reflection, I no longer feel it is appropriate to continue the Tenacious D tour, and all future creative plans are on hold," he said on Instagram late Tuesday night. Australia's ambassador to the United States, former prime minister Kevin Rudd, said the comment made him "feel sick". "People might think it's a bit of 'funny haha' at a concert. But it's not. "These people should just grow up and find a decent job."Four remaining shows in Australia have been cancelled along with two dates in New Zealand, management company Frontier Touring said Wednesday in a statement. The band's biggest hit came in 2002 with the track "Tribute", which fans commonly refer to as the "greatest song in the world", a reference to its tongue-in-cheek lyrics.Gunman Thomas Matthew Crooks opened fire at a rally in Pennsylvania on Saturday -- a near-miss assassination attempt that left Trump bleeding from his

Islamic State claims responsibility for Oman mosque attack that left 9 dead

Cairo Islamic State claimed responsibility for an attack at a Shi'ite Muslim mosque in Oman, the group said on Tuesday, which left at least nine people dead, including three attackers, a rare security breach in the oilproducing Gulf state. The attack on Monday, which is unusual in the wealthy, Sunni Muslim-dominated Gulf states, raises fears that the Islamic State group may be trying to gain a foothold in new territory.


Three suicide attackers from the Islamic State attacked last night a gathering of Shi'ite (Muslims) while they were practicing their annual rituals at a temple in the Wadi al-Kabir district in the (Omani) capital," according to group's statement, which cited three security sources. The Islamic State fighters fired on Shi'ite worshippers and exchanged gunfire with Omani security forces until morning, the statement added.

Islamic State late on Tuesday published what it said was a video of the attack on its Telegram site. The group also said that the attack left more than 30 Shi'ite Muslims and five Omani forces, including a police officer, killed

Joe Biden pledges 'I am all in,' criticises Trump on economic policy

Addressing people in his address at a convention, US President Joe Biden said that he was "all in" to seek reelection and criticised his Republican rival **Donald Trump on various fronts including his** handling of the economy during the Covid-19

Washington DC President Joe Biden promised Black voters on Tuesday that he was "all in" to seek re-election on November 5 and assailed Donald Trump's record as president, in his first political speech since his Republican rival's attempted assassination.Biden was greeted by chants of "four more years" as he spoke to the NAACP's annual convention in Las Vegas, a major gathering of Black voters. Biden said he was grateful that Trump was not seriously hurt at a campaign rally in Pennsylvania on Saturday but roundly criticised him on a variety of fronts, including his handling of the economy during the coronavirus pandemic. Let me say it again because Trump is lying like hell about it - Black unemployment hit a record low under the Biden-Harris administration," Biden said.He scolded Trump for



initially contending that former President Barack Obama was not an American citizen and for his reference to "Black jobs" at the Trump-Biden debate on June 27."I am all in," said Biden.

The attempt on Trump's life on Saturday prompted the Biden campaign to pull its television ads, call off verbal attacks on the former president and focus instead on a message of uity."Our politics got too heated," said Biden. The campaign's strategy previously was to focus on tough criticism of Trump as a threat to U.S. democracy and to highlight his failure to admit his 2020 election loss and his felony convictions.

Now, it is trying to calibrate a less pugilistic message that still strikes a stark comparison between the two candidates. The National Association for the Advancement of Colored People, the oldest and largest US civil rights organisation, represents a key constituency for the Democratic Party. While Black voters turned out heavily for Biden in 2020, polls have shown waning support for him from the constituency in this election.

Torrential rain triggers flash flooding, power outage in Canada's Toronto

Heavy rain led to flash flooding in Toronto, causing significant disruptions in the city. Power outages, travel delays, and flooded streets were reported as emergency services responded.

Toronto. Torrential rain on Tuesday triggered flash flooding in parts of Toronto, Canada's financial center, causing power outages, disrupting traffic and forcing airlines to curtail service. Toronto Hydro, the local power distribution company, said it was responding to scattered outages that it suspected were caused by flooding at a transmission station. At 3 p.m., about 123,000 customers were without power, it said.Billy Bishop Airport, situated on an island off downtown Toronto, said the underwater pedestrian tunnel leading to



the passenger terminal, was flooded and temporarily closed. At least some flights were delayed or canceled. At lunchtime, many of downtown Toronto's normally bustling restaurants were darkened, with kitchen workers and waiters gathered outside, chatting and waiting for the lights to come back. With traffic lights out, cars

and delivery trucks backed on city streets, snarling some intersections. Across the world, intense rain storms are becoming more common because of climate change, weather experts say, putting a heavy strain on infrastructure that in many cities is not designed to handle heavy, sustained

operates subway, bus and trolley service, said trains were bypassing Union Station, the city's main rail terminal. Go Transit, which operates train service to and from Toronto's suburbs, said the flooding had caused some disruptions.Parts of the Don Valley Parkway, a major highway running east of downtown, resembled a river soon after the rains began, with images showing cars stalled out in the brownish waters several feet (dozens of

Brandon Rolle, 24 said he was stuck inside his car on the Don Valley Parkway for two hours before the fire service came to rescue him. But his car was still stuck on the flooded highway until it could be towed off, he said."They're saying they have to wait until the water recedes," he said. The rains stopped around midday, and Environment Canada forecast partly cloudy skies for the rest of Tuesday.

Toronto Mayor Olivia Chow in a televised briefing said emergency services were not affected by the flooding, but there was some water in parts of the City Hall.

Hot air from Africa bakes southern Europe, severe heat warning in Italy

Rome The Italian health ministry placed 12 cities under the most severe heat warning Tuesday as a wave of hot air from Africa baked southern Europe and the Balkans and sent temperatures over 40 degrees Celsius (104 degrees Fahrenheit), with the worst still to come.Croatia reported the highestever temperatures of the Adriatic Sea, with the thermometer reaching nearly 30 degrees Celsius (86 degrees Fahrenheit) at the southern walled city of Dubrovnik, the country's most popular tourism spot. In Serbia, the state power company reported record consumption Tuesday due to the use of air conditioning. Municipal authorities in several southern European and Balkan cities took measures to look after elderly people in particular as civil protection crews fielded calls for water-dropping aircraft such as Canadairs to douse wildfires that raged in southern Italy and North Macedonia. "It's hellishly hot," said Carmen Dear a tourist from Madrid Carmen D-az, a tourist from Madrid who was trying to keep cool with a fan at lunchtime in Rome. "These fanshelp a little too, but it's really hot." In Greece, municipalities made air-conditioned spaces available to the public. Certain forms of outdoor work were banned,

such as manual labor, deliveries and construction, during the hottest time of the day when temperatures reached 40 C.Temperatures were expected to hit 42 C on Wednesday and Thursday in several countries. Spain's national weather service said thermometers



could reach 44 C in the southern Guadalquivir river basin in the coming days. To beat the heat, Rome's zoo made plans to offer popsicle respite for the animals later this week when temperatures were expected to top 38 C. For those flocking to the Eternal City's Coldplay concerts this week, there were no such icy treats."It really feels like we are in an oven with a hair dryer pointed at us," said Patrizia Valerio, who had just arrived in Rome from Varese for the band's final performance

Tuesday night.Fellow concert-goer Mattia Rossi was more philosophical, noting that the freak storms that hit Italy earlier this summer as evidence of climate change wreaking havoc on the southern Mediterranean's weather systems."These are all symptoms of a

planet that is suffering in my opinion," Rossi said.In Albania, where temperatures were expected to hit 42 C, a 72-year-old man was found dead at his farm in Memaliaj, 200 kilometers (125 miles) south of the capital Tirana and the cause of the death is believed to be the heat, the local Panorama portal reported. There was no immediate confirmation by health authorities.In Tirana itself, streets

and cafes seemed almost empty, with the few people out and about using umbrellas to shade themselves. High temperatures and winds were fanning wildfires from the south to the north in recent weeks. Even with temperatures a comparatively cool 34 C, the Istanbul municipality issued a heat warning on Tuesday advising residents — especially the elderly, pregnant women, children, and those with health issues — to avoid going out between 10 am and 4 pm.

Putin didn't start wars, invasions when Trump was **President: Nikki Haley**

World Endorsing Republican nominee Donald Trump for the November 2024 US presidential election, former South Carolina Governor Nikki Haley said that Russian President Vladimir Putin refrained from "invasions" and "wars" when Trump was the US president. Haley was a former leading rival of Trump for the Republican presidential nomination. She stated that when Barack Obama was president, Vladimir Putin invaded. Crimon and under Los Biden's invaded Crimea, and under Joe Biden's presidency, he invaded all of Ukraine. However, Putin knew "Donald Trump was tough", she said at the Republican National Convention."When Donald Trump was president, Putin did nothing. No invasions, no warsâ€æPutin didn't attack Ukraine because he knew Donald Trump was tough. A strong president doesn't start wars, a strong president prevents wars," Haley asserted. 'In this moment, we have a chance to set aside our differences, and focus on what unites us and strengthens our country," she said in her address at the Republican convention days after the assassination attempt on Donald Trump during an election rally.



She further stressed unity in her speech, and said, "Our foreign enemies win when they see Americans hate each other. They see that today, whether it's on college campuses or in a field in Butler, Pennsylvania. But we can conquer those fears with strength and unity". Haley, who had described Trump as unelectable and unfit for office during her campaign, urged her supporters to vote for him over Democratic President Joe Biden "for the sake of our nation", adding that "You don't have to agree with Trump 100 per cent of the time to vote for him". During her campaign, Haley had been highly critical of Dold Trump, alleging that the former President was siding with

6 foreigners found dead in Bangkok hotel, Thai PM orders probe

Bangkok. Thai police are investigating the deaths of six foreign national whose bodies were found in a room at an upmarket hotel in Bangkok on Tuesday, including looking for a seventh person in connection with the incident.All six, who were of Vietnamese descent, with two carrying US passports, checked into Bangkok's Grand Hyatt Erawan hotel at two separate times after arriving on Saturday and Sunday, police official Thiti Saengsawang told reporters. The group - three men and three women checked into different rooms but their bodies were found in one room, which did not show any signs of struggle, he said."This was not self harm, but someone caused the deaths," said Thiti, adding that police were looking for a seventh person connected with the group."We are tracing every step since they got off the plane."Police officers found the bodies after a call from the



hotel staff at around 5.30 p.m. (1030 GMT) reporting that there had been deaths, the Thai police said in a statement. Thai prime minister Srettha Thavisin, who visited the hotel late on Tuesday with senior police officials, ordered a swift investigation on the matter, the government said in a statement."The prime minister has ordered all agencies to urgently take action to avoid impact on tourism," it said. The US State Department was "closely monitoring the situation and (we) stand ready to provide consular

assistance," a spokesperson said, circumstances of the deaths to local authorities. The Vietnamese embassy in Bangkok did not respond to calls from Reuters. The Grand Hyatt Erawan, which has over 350 rooms and is located in a popular tourist district in the Thai capital known for luxury shopping and restaurants, also did not immediately respond to calls or an email seeking comment. Tourism serves as a key driver for Southeast Asia's second-largest economy, with the government expecting 35 million foreign arrivals this year after 28 million visited the country in 2023, spending 1.2 trillion baht (\$33.71 billion). The tourism sector was shaken in October by a shooting spree at a luxury shopping mall close to the Hyatt in which two foreigners were killed, prompting government measures to improve confidence.

6 dead in Bangladesh as job quota protest turns violent, schools, colleges shut

Dhaka At least six people, including three students, were killed and more than 100 others injured on Tuesday as protesters demanding reforms of the quota system in government jobs clashed with police in major cities across Bangladesh, forcing the closure of schools and colleges.

Police and major news outlets reported two new deaths in the capital Dhaka and the northeastern port city of Chattogram while earlier today, four deaths were The clashes, however, erupted on reported from the capital, Chattogram and northwestern Rangpur.According to the reports, at least three of the deceased were students while the violence injured some 400 others on Tuesday as protests demanding quota system reforms spread across major Bangladesh cities a day after it took a violent turn after a week of street demonstrations. Authorities today called out the paramilitary Border Guard Bangladesh (BGB) troops in four major cities after hundreds of policemen in riot gear overnight fanned out in public university campuses across the country.

The government, meanwhile, ordered closure of schools, and colleges until further order amid escalated violence. "All high schools, colleges, madrasahs

(Islamic seminaries) and polytechnic institutes under the purview of the Department of Secondary and Higher Secondary Education will be shut down until further order, considering the security of the students," an education ministry spokesman said. The violence

nearly emptied the usually crowded capital where unidentified people set on fire two buses after exploding dozens of Molotov cocktails while several parts of the city witnessed sporadic clashes causing roadblocks leaving thousands of people stranded in the streets and their workplaces.

Monday as activists of ruling Awami League's student front confronted the protestors who insist the existing quota system

was largely debarring the enrolment of meritorious students in government services.Demonstrators accused the ruling party's student wing Bangladesh Chhatra League of attacking their "peaceful protests" with backing from police. The protesters blockaded highways and railway routes in four major cities of central Dhaka, northwestern Rajshahi, southwestern Khulna and the major port city Chattogram.Police fired tear gas canisters and rubber bullets as university students battled with counter-protesters armed with sticks and brickbats.

Rival student groups marched in several key locations around the capital Dhaka, some throwing bricks at each other, with traffic in the city of 20 million almost ground to a halt. Students of the premier Dhaka University took the lead in the latest one-week protests for recruitment

in first- and second-class government jobs, demanding seats to be filled based on talent, reforming the existing quota system. The protesters said they were staging peaceful demonstrations on Monday at two public universities in Dhaka and its outskirts when they were attacked by student activists from the ruling party activists armed with sticks, rocks, machetes and Molotov cocktails.

Under the existing system, 30 per cent jobs are reserved for descendants of 1971 Liberation War veterans, 10 per cent for administrative districts, 10 per cent for women, five per cent for ethnic minority groups and one per cent for physically handicapped people.

Every year some 3,000 government jobs open up to nearly 400,000 graduates.

The student protest appears to be the first major demonstration against Prime Minister Sheikh Hasina's government

since she won a fourth straight term in January. Hasina said on Tuesday that "war veterans should receive the highest respect for their sacrifice in 1971 as they joined the war with whatever they had, abandoning the dream of their own life, leaving behind their families, parents and everything". She also criticised the protesters saying the war veterans must get the benefit instead of those who opposed the creation of Bangladesh siding with Pakistani troops in 1971, known as "razakars". The quotas were

stopped under a government circular in 2018 after mass student protests but last month, the high court ordered the quotas for veterans' families to be reinstated, angering students and triggering new demonstrations. The Appellate Division of the unitary Bangladesh's Supreme Court last week, however, temporarily halted the high court's order for four weeks while the chief justice asked protesting students to return to classes, saying the apex court would issue a decision in four weeks.

The protests, however, continued halting traffic in Dhaka.Amnesty International urged Bangladesh authorities to "immediately guarantee the safety of all peaceful protesters" while the US State Department spokesman Matthew Miller also denounced the "violence against peaceful protesters", prompting a rebuke from Bangladesh's foreign ministry.

250 candidates raise objections over errors in DSC hall ticket

HYDERABAD: Around 250 candidates for the District Selection Committee (DSC) 2024 examination approached the Directorate of School Education in the city on Tuesday to rectify errors in their hall tickets.Additional Director K Lingaiah told TNIE that the errors would be corrected by Wednesday morning. "We will make sure that we do not miss any candidates," he added. The DSC, the recruitment test for Secondary Grade Teachers, School Assistants and Language Pandits, will be held between July 18 and August 5 in two shifts.Lingaiah maintained that the errors



were not caused by the department. He said the mistakes were made by the candidates while entering their details. "While some entered the wrong medium, some entered the post they are applying to incorrectly," he added.In June, the Office of the Commissioner of School Education issued an amendment reducing the percentage of marks to the post of School Assistant in all subjects, School Assistant (Physical Education), Language Pandits and Physical Education Teachers in the DSC examination as per the National Council of Teacher Education Regulations.

While there was no significant change in the population in Periyar reserve, (811 in 2023 and 813 in 2024), an increase of 16% was recorded in Nilambur. The census showed substantial decrease in elephant population in the other two elephant reserves - Wayanad (29%) and Anamudi (12%).

The difference in numbers compared to last year is natural and insignificant, since

elephants migrate across reserves, based on water and fodder availability. The stable numbers in Periyar and Nilambur could be attributed to the undulating topography along the state border. Periyar offers more potential elephant habitats, compared to neighbouring reserves. The noticeable reduction in Wayanad could be due to climatic conditions like extreme dry seasons and late summer rain, it said.

Wayanad is surrounded by prime elephant habitats like Mudumalai, Bandipur and Nagarhole Tiger Reserves, and these flat terrains facilitate elephant movements. Such factors too have contributed in the difference, the study said.One of the noticeable findings in the census pertains to the significant elephant death rate over the years, with higher mortality in 2023. The study observed that the mortality rate could also be associated with EEHVs (Elephant Endotheliotropic Herpesviruses).

To ensure better immunity, it's critical to protect and restore natural habitats and avoid future fragmentation of herds, it suggested. While a slew of reasons might have contributed to differences in elephant population, climatic conditions play the key role. "The reduction in numbers is negligible since migration of elephants contribute to the same. The deaths could be primarily due to the herpes virus, with other minor reasons like electrocution. However, there's definitely a need to conserve natural habitats and prevent agespecific mortality through proven measures," said sources.

GCC plans to centralise evaluation of class 10 & 12 term examination papers

CHENNAI: To increase the pass rate in schools run by Greater Chennai Corporation (GCC), the civic body's education department has decided to evaluate the mid-year term exam answer sheets of class 10 and 12 students in a centralised manner. The test papers are currently being evaluated at the respective schools. The initiative is aimed at assessing the students' performance more accurately during the course of the academic year and improve the overall result in public exams, a circular issued by the corporation's education department said. According to officials, the new system has been introduced as there is a concern about teachers being liberal in evaluating the term papers of students in their own schools, which results in misleading assessment of performance.

he circular states that assistant education officers will monitor the evaluation of answer sheets, which will take place at the higher secondary schools located in Nungambakkam, from July 22 to August 2. Headmasters have been instructed to send the answer sheets to the respective evaluation centre, and teachers have been asked to participate.Evaluation for each subject will take two days for class 10 and up to four days for class

Headmasters and teachers, however, have expressed concern as the exercise may affect their academic schedule. The headmaster of a higher secondary school said teachers were already struggling to complete the syllabus within the stipulated time. With centralised evaluation being implemented for only GCC-run schools, students of these schools will miss out on two to four days of teaching every term since the teachers will have to report at the evaluation centre. At present, teachers evaluate the papers making use of the time during their leisure periods, he said.Moreover, the deployment of more teachers at the evaluation centres would leave the headmasters without enough teachers to even monitor the classes, he added. Teachers further suggested that if officials are concerned about improper evaluation in schools, they could consider exchange of answer sheets between schools in a randomised manner for evaluation instead of opting for a centralised evaluation, which, according to them, will create

Enumeration begins to relocate 100 families from George Town area, Chennai

CHENNAI: The city corporation, along with the Tamil Nadu Urban Habitat Development Board, began enumeration of over a 100 homeless families, many of whom are third generation residents, residing in Jaffar Sarang and Narayanappa Streets in George Town. They are likely to be evicted and resettled soon.Sources said the customs office along one of these streets has planned further constructions in the area and had requested corporation to offer alternative housing arrangements for these families. CHENNAI: Customs officials on Tuesday conducted searches at multiple shops in prominent malls near Egmore and Anna Salai in connection with the 267kg gold smuggling case at the Chennai airport. Sources said that important documents were seized during the searches. However, customs officials were tight-lipped about any further information. According to sources, the shops that were searched on Tuesday are linked to a few retail outlets operating in the international terminal of the airport whose employees were found to be hand in glove with gold smugglers including Sri Lankan transit passengers. One of the shops at a mall is also connected to GA Prithvi, a member of the Tamil Nadu BJP unit and former director of Vidvedaa PRG, the master concessionaire for retail at the airport. Prithvi is under the scanner of customs for his alleged role in facilitating Sabir Ali, the Youtuber turned owner of the gift shop 'Airhub', in getting a contract at the airport.

Despite multiple attempts by TNIE, Prithvi was not available for comment.Apart from probing the smuggling nexus of eight employees of Airhub, customs has expanded the scope of investigation to several other shops at the airport which were supposedly set up just to aid gold smuggling, sources said, adding that a special squad has been formed to investigate the case which is also being monitored by top officials in the Central Board of Indirect Taxes (CBIC) in New Delhi. Two shops operating in the international terminal at the airport, selling Kashmiri apparel and silk clothes, were found to be involved in gold smuggling and their contracts had been terminated. The staff of another shop specialising in selling accessories at the airport is also under customs scanner after some of its employees.



CHENNAI: Southern Railway has announced major changes in train operations due to signalling upgradation and yard redmodelling works at Tambaram. From July 23 to 31, the Vaigai and Rockfort express trains to Madurai and Tiruchy respectively will be operated from Chengalpattu instead of Egmore. The Egmore-bound Pallavan Express from Karaikudi will also be short-terminated at Chengalpattu during this period.An official note issued on Monday said nearly 20 trains operating from Tambaram will be redirected to either Chennai Beach or Chennai Egmore or Villupuram. The Tambaram-Nagercoil Antyodaya Express, a fully unreserved train, will be cancelled in both directions from July 23 to 31. The Tambaram-Hyderabad Charminar Express will be terminated at Chennai Beach, with return journeys from July 23 to 31.The Sengottai-Tambaram Express journeys on July 22, 24, 26, 27, 29, The Santragachi-Tambaram Antyodaya weekly and 31 will be short-terminated at Villupuram, and the Tambaram-Sengottai Express will operate from Villupuram on July 24, 25, 28, and 30. The Jasidih-Tambaram weekly express will be operated from Egmore in both directions until July 31. Similarly, the Mangaluru Central-Chennai Egmore Express

Violence has become a part of US polity

THE political consequences of the assassination attempt on former US President Donald Trump will be huge and they will benefit him immensely. Of great import is Trump's instinctive and combative response to the attack. As he was encircled by Secret Service agents, with blood streaking down his face, he raised his right fist, shouting "Fight. Fight". Images of a bloodied and angry Trump with a fist clenched, and an American flag fluttering behind him, have gone viral and will become iconic in the campaign. The presidential contest had already been plunged into turmoil just two weeks ago when Joe Biden's performance in the presidential debate raised questions about his ability to run an effective campaign. It has been Trump's signature approach to put himself across as a martyr and victim of persecution on account of the legal cases against him. Now, his close shave with death will add to the notion of martyrdom.

By seizing the news cycle, the Trump assassination attempt could have the inadvertent effect of stilling the campaign for the removal of Biden as the Democratic nominee following the debate debacle. The Trump campaign would like nothing better than that. The shooting will complicate the Biden campaign. In the past week, the President said he would now focus directly on Trump and his view was that he remained the best candidate to beat him. Indeed, his rhetoric that "it's time to put Trump in a bullseye" is now being retailed by some Republicans as a call to violence against their candidate. JD Vance, a potential vicepresidential candidate for the Republicans, posted that this was not an isolated incident but the inevitable consequence of the Democratic rhetoric that Trump was "an authoritarian fascist who must be stopped at all costs". The reality is that violence has become a part of American political life. The courts have not helped by loosening controls on the availability and ownership of guns. An attempt to ban assault weapons like the Colt AR-15 that was used to target Trump lasted just 10 years and faced repeated challenges in court. Currently, certain states ban such weapons through their own legislation; Pennsylvania, where the incident occurred, is not among them. It is largely with such weapons that mass shootings are carried out; in July, there has already been one other shooting, leading to five deaths. In 2023, there were 604 shootings, leaving 754 people dead and nearly 2,500 injured. To say that the US Supreme Court has been unhelpful here would be an understatement.In recent years, violence has dogged the US election process since the January 6, 2021, Capitol riot, when Trump's supporters sought to overturn the result of the election that was won by Biden. Nine people died in the mayhem before the insurrection was suppressed and for which Trump faces charges.

The current American polity is deeply divided. A Pew Research Centre poll has found that nearly two-thirds in each party believe that those in the other are immoral, dishonest and close-minded.

That Trump's rhetoric is inendiary is no secret. In an interview in March, he declared that there would be a 'bloodbath' if he lost in November; later at a rally, he repeated: "Now if I don't get elected... it's going to be a bloodbath for the country." In March 2023, he had warned of "potential death and destruction" if he was charged by the Manhattan district attorney for the case in which he was later convicted. There are numerous instances of his threats that "there will be riots in the streets", "bedlam in the country" if he was wronged. His followers have spoken of violence gainst migrants, foreigners and people of non-White races. Indeed, after his May conviction on 34 felony counts, pro-Trump websites were flooded with calls for riots, revolution and violent retribution. There has been a political pattern in the violence of recent years. In 2017, Steve Scalise, Republican House Majority Whip, was shot at during a baseball game by an anti-Republican gunman, who was shot dead. In 2018, a Florida man mailed pipe bombs to critics of then President Trump.

Subtle seizure of Russian assets by West limits diplomatic solution

The seizure of Russian assets will make the global financial transaction system subservient to international political currents.

THE Western bloc, including more than two dozen countries, is fighting a proxy war against Russia by providing weaponry and strategic, financial and logistical support to Ukraine. It has also attempted to destabilise Russia's financial situation through economic, financial and trade sanctions. In March 2022, the European Union (EU), Japan and the Group of Seven (G7) froze some 300 billion euros (\$323 billion) of Russian central bank assets to retaliate against Moscow's invasion of Ukraine.

Now, they have initiated a new battle by subtly seizing frozen Russian assets. The US and other G7 countries have agreed to provide Ukraine with a \$50-billion loan to help it acquire weapons and begin rebuilding damaged infrastructure. The loan will be repaid in about 30 years, using the interest earned on frozen Russian assets.

The rationale for utilising the interest income earned from Russian assets is based on the international legal doctrine of reprisals. However, this doctrine is truly applicable when a state inflicts harm on another, and the injured and specially affected party can undertake proportional counter-measures against the offender. Ukraine, being directly involved in the war, rightly exercised this right and seized about \$880 million in Russian-owned property and businesses within its borders in May 2022. Surprisingly, this doctrine is also being applied by the parties that are not directly affected by the Russian invasion in Ukraine. It weakens the

rules-based order that Western governments claim to be defending all the time. This measure had been taken under duress as Western leaders are fearing difficulties in future funding to Ukraine and seeking alternative solutions. The G7 nations and their allies are convinced that the Western aid to Ukraine is morally, legally and strategically urgent. But the foreign aid to fund the Ukraine war has remained politically entangled for a long time in both the EU and American politics. The EU leaders met a few times in 2023 to secure additional funding for Ukraine. In December 2023, Hungarian Prime Minister Viktor Orban vetoed the proposal of 50billion euro (\$54 billion) aid to Ukraine. Since then, the EU has been attempting to bring Hungary in line with this issue. In February this year, Hungary finally agreed to the proposal after a coordinated, behind-the-scenes pressure created by other member countries. Hungary holds the rotating presidency of the Council of EU this year and Viktor Orban may create hurdles in future funding to Ukraine. The US also faced a political challenge for further funding as House Republicans insisted on new border security policies that President Biden was unwilling to support, creating a political stalemate. Biden's proposal to provide \$61.5 billion to Ukraine was passed in April after months of hardright resistance. Ukraine faces significant threats to its ability to continue its fight and is now losing ground. The US has vehemently proposed the onetime seizure of the total Russian assets parked in the EU and the US to finance the war. But most of the frozen Russian assets are in the Brussels-based depository Euroclear and other European financial



institutions. However, the European allies did not agree to this and chose an alternative approach that they suppose is milder. But it is essentially an indirect seizure. Undoubtedly, this measure will lock Russian assets for 30 years. But it will not affect Russia economically in a significant way. Russia has had a substantial current account as well as trade surplus in the last three years that has helped it to replenish a substantial portion of the frozen assets. Sacrificing the interest on the assets parked outside will have insignificant additional effects. But it will have a profound impact on the global financial system and diplomacy. Biden did release the frozen Iranian assets in exchange for five US hostages in September last year. Likewise, the unlocked Russia's frozen assets could have been potentially utilised as a bargaining tool during negotiations to end the war. But that negotiating leverage is almost

gone now. Even if the frozen assets are used as a bargaining chip, Russia will demand back the interest earned from the frozen assets, and who will pay that? Even if Russia gets \$300 billion after 30 years, its present value is just \$50 billion (as calculated by using the economics tool 'time value of money' assuming 6 per cent discount rate and annual compounding).In 2023, Ukrainian Ambassador to Canada Yuliya Kovaliv, while hailing the proposed legislation for seizing foreign assets, in a message to the Canadian Institute for the Administration of Justice's annual conference in Ottawa, wrote, "You need to remember, most of these assets are corrupt assets, are assets of Russian oligarchs that got their huge fortune by being close to the Putin regime, by using the taxpayers' money

for their personal interests or the interests of their companies."

The US and its allies agreed with this narrative and acted in a veiled manner to acquire Russian companies' assets (along with state assets), holding them responsible for Putin's actions. Similarly, Russia can acquire public and private property belonging to its opponent states and their citizens as a countermeasure. The US and its allies are trying to end the war by exerting economic pressure on Russia. The policy is to destabilise Russia through economic


and financial sanctions along with the

continuous arming of Ukraine, virtually giving a goaway to diplomacy to contain the war. Economist Jeffrey Sachs puts it like this: "There has been a complete collapse of the diplomacy between US and Russia - instead of focusing on the policy, Biden focuses on personal vis-à-vis President Vladimir Putin. Recently, he referred to President Putin as 'a crazy SOB'." In the press conference following the NATO summit in Washington, Biden described Putin "a murderous madman on the march".

The seizure of the Russian assets will make the international financial transaction system untrustworthy and subservient to global political currents. Russia is already holding Western countries responsible for initiating and prolonging the war. Adding another dimension to the war will expand it to a new level, limiting the possibility of a diplomatic solution.

deadline for holding the Assembly elections. Repeated confrontations between the Delhi L-G and the Chief Minister have severely impacted governance in the Capital in recent years. The Centre would do well to avoid implementing such a disruptive model in J&K, whose residents affirmed their faith in democracy with an encouraging turnout in the recent Lok Sabha polls. It's time for a new beginning for the people of the trouble-torn region. The potentially new dawn should not be marred by discord and disharmony.

Operational doctrine needed to defeat proxy war

A national strategy must be formulated so as to make it cost-prohibitive for Islamabad to continue with the misadventure.

SINCE April this year, there has been a spike in terror attacks in the Jammu region. In reference to these encounters, Jammu and Kashmir (J&K) DGP RR Swain said, "A war has been imposed upon us but every terrorist in J&K will be killed." However, this war has now gone on unabated for over three decades, orchestrated by Pakistan as part of its national doctrine. India has been dealing with this menace as state-sponsored terrorism from across the border. It was in the early 1980s that Pakistan began to fuel militancy in Punjab to bleed India, having successively failed in conventional wars. The Pakistan army arranged a safe haven for the militants, providing training, arms and financial support. The decade-long militancy was ultimately defeated due to extensive coordinated operations by the security forces, coupled with a favourable groundswell. Victory came at a heavy price, both by way of bloodshed and in financial terms. Punjab was devastated and is yet to fully recover.

Given the success in Punjab, the Pakistan military top brass was convinced that its sacred mission to wrest Kashmir could be achieved through 'non-state actors'. The success of jihadis in defeating a superpower in Afghanistan reinforced the belief. Accordingly, Pakistan's 'Deep State' launched the proxy war in J&K in 1989-90, contemplating a local uprising, an exodus of minorities, rendering the civil apparatus defunct and defeating the security forces through irregular warfare. Though terrorists initially gained the upper hand, by the mid-1990s, the Indian Army was able to stabilise the situation. While normalcy was a far cry, the danger of the Kashmir valley slipping away had been averted. In the initial stages, the foreign outfits - mainly Lashkar-e-Taiba (LeT) and Jaish-e-Mohammed (JeM) - were the mainstay of the proxy war, the Valley being the main

focus. Even around early 2000, when I was commanding a formation in the Valley, foreign terrorists had a viable presence in Baramulla and south Kashmir.In September 1998, although India and Pakistan agreed to hold a composite dialogue which included issues such as terrorism and narcotics, Gen Pervez Musharraf, the then Chief of

Army Staff, had different plans. Pakistan continued to use the jihadi groups to undertake calibrated operations, often changing the modus operandi. India's response remained largely defensive, with no concrete measures to target terrorist infrastructure in Pakistan. A nexus between local politicians, terrorists and Pakistan's ISI (Înter-Services Intelligence) remained intact.

Following the 'Ceasefire Agreement' (CFA) on the Line of Control (LoC) in 2003, it became easier for Pakistani handlers to infiltrate terrorists into J&K. There was also a shift in Pakistan's strategy to lend a local touch to the proxy war by involving groups like the Hizbul Mujahideen. Given its nuclear capability, Pakistan has succeeded in significantly constraining India's conventional options. The Pakistan perception was reinforced during the 1999 Kargil conflict as India's response was rather

India's approach to cross-border terrorism remained reactive, marked by restraint, although public opinion was often for strong military action against Pakistan, especially after the terror attacks at Parliament in 2001 and Mumbai in 2008. The Pakistan army has been able to regulate the proxy war and keep the Indian security forces engaged while imposing substantial costs, knowing that India lacks effective deterrence. The Pakistan assumption did get challenged when India undertook surgical strikes For Pakistan, the proxy war against India is a lucrative across the LoC in 2016 and the air strike at Balakot in 2019. Thereon, Pakistan's approach has been to avoid major actions so as to obviate retaliation.

With the abrogation of Article 370 in 2019 and reorganising of J&K into two union territories, the situation in the Valley has shown a marked




improvement. Consequently, Pakistan changed its strategy by shifting the operations from the Kashmir valley to the south of the Pir Panjal - the Jammu region - after almost two decades. Over the last three years, the Rajouri-Poonch region has witnessed a series of terror strikes, with the security forces suffering significant losses. The continued proxy war underscores the fragility of the situation in the region.

option. It offers high returns at a minimal cost. Rawalpindi has shown flexibility to exploit vulnerabilities across the Indian borders and the hinterland. Hence, India must accept this reality and shed the notion of perceiving it to be just cross-border terrorism. Further, it must stop dealing with the

situation in piecemeal binaries - North-South of the Pir Panjal and LoC-IB sectors - as also the notion that the Pakistani designs can be defeated by reactive tactical operations.It is imperative for India's security planners to formulate a national strategy encompassing politico-diplomatic-economic measures to make it cost-prohibitive for Islamabad to continue with the misadventure. The collusion between Pakistan and China needs to be factored in as the latter is now a stakeholder in the game. Alongside, there is an immediate requirement to formulate an integrated 'counterproxy war doctrine', which should be multidimensional, encompassing operations across the LoC to destroy terrorists' launch pads and target Pakistani posts assisting infiltration at the LoC, to create a conducive environment and favourable ecosystem. The CFA needs to be

abrogated as it provides immunity to the Pakistan army against punitive actions by the Indian security forces.

In J&K, since 1990, around 6,480 security personnel have lost their lives and about 38,720 civilians have been killed (including an unspecified number of terrorists). Evidently, India has paid a heavy price. It is time to replace the existing format with a prudent strategy and operational doctrine to defeat the Pakistan-sponsored proxy war. Else, we are destined to continue to suffer the fait accompli.

River cruise on the Brahmaputra

The river runs through the entire length of Assam but the stretch that touches Guwahati is the most highlighted one, courtesy the city's commercial and political status and the famous Saraighat Bridge. The Brahmaputra divides the city into two parts while on its imposing journey from the Himalayan glaciers to the Bay of Bengal. charm once you set foot in them. And we are referring to the literal meaning of the word

'foot' here as these vintage parts are best explored if you walk down its alleys and corridors. The major areas that fall under this bracket are?the academic hub of Panbazar, the colonial remnant Uzanbazar, the roads of Kharghuli, the entire area of Digholipukhuri and some parts of Aambari area. We suggest you start with Panbazar amid its old bookshops and historic publishing houses. Home to Assam's premier educational institute, Cotton College, Panbazar is a place which is always alive with young student crowd. Then head towards the Digholipukhuri (a massive pond with boating facilities), one of the most happening landmarks of the city before rerouting to Uzanbazar where you will come face to face with some of the oldest residential colonies in Guwahati. From here you can head to the Kharghuli area where a beautiful stretch of road goes parallel with the Brahmaputra amid lush greenery.

Trekking in Nilachal Hills


If you are in North East and you don't climb a hill, your stay is incomplete so this is one thing you must do! The entire city is surrounded by hills and the best parts to go trekking are Nilachal hill and the hills of Nizorapaar. For easy accessibility and identification of Nilachal hill, just ask your cabbie or auto rickshaw driver to go to Kamakhya Temple. You will be dropped at the entry gate of the temple which is adjacent to the main road. From there, you can start your hike amid rich flora and fauna and even if you don't intend to visit the temple, be assured that your trekking experience will be one

The next hiking destination you can hit is the hills of Nizorapaar. Located in the famous Chanmari area of Guwahati, this hill is somewhat more populated than Nilachal but scores in terms of scenic beauty and mindboggling views. The roads are serpentine and some parts offer steep climb that you normally don't expect in an inhabited hilly region. You may come across the odd vehicle but as you go up, the number will come down drastically.

Go for a ride in Accoland

Who does not like a fun outing in an amusement park located in the backdrop of a hillock? So even if you are not accompanied by a kid, you can anyway head towards Accoland, the best amusement park in Guwahati. Located on Rani Road in Patgaon area, this place is just over 5 kms from the Guwahati airport. Accoland is loaded with over 12 different rides and 16 other fun activities which give you the opportunity to get some adrenaline highs.

As common with amusement parks, the atmosphere here is of joy and fun so this is the best place to unwind a bit. Traveling, no matter how exciting it could be, always runs the risk of being tad tiresome and sometimes takes a toll on the traveler. But take a dip in the massive swimming pool in Accoland and get rejuvenated for the rest of the journey. The food joints in the park offer delicious snacks and beverage options and nothing completes fun like food, right?



Himachal's pot secret - it's not what you think

A 20-minute drive from Palampur in the Kangra booked for the next two months. Clearly, District of Himachal Pradesh brings you to Andretta, a quaint artist village, said to be established by an Irish theatre artiste and environmentalist called Norah Richards, who lived there during the Partition. Flanked by the Shivalik hills and the mighty Dhauladhar range, this Italian-sounding village is literally off the beaten path.

Andretta first figured on my radar because of a pottery and craft centre run by the renowned potter Mansimran Singh (fondly known as Mini) and his British wife Mary Singh. The son of the famous potter Sardar Gurcharan Singh (who set up Delhi Blue Art Pottery in 1952, inspired by blue Persian glaze), Mini set up Andretta Pottery and Craft Society in Himachal Pradesh in 1983. Equipped with a production studio, the facility provides threemonth long courses. Feeling terribly burnt out by the manic city life, I longed for a break. Delighted at the prospect of trying my hand at pottery, I set about exploring how to make this happen.

According to Google Maps, Andretta didn't exist. There was nothing but basic information available online. This would be the perfect break I was seeking. Like most travel nuts, I'd have liked to read up and familiarise myself with what to expect, but that seemed unlikely in this case. My sense of thrill was fuelled further. Andretta was remote. It was in the midst of nature. And, it offered culture along the way.

After some R&D, I managed to contact Jugal Kishore, the manager of Andretta Pottery. The course was inclusive of boarding, lodging and instruction. The boarding was a home stay which provided homecooked meals, but they could accommodate only four students that time of the year (I went last September). Much to my disappointment, I was told that they were

I had underestimated the remoteness of Andretta. Jugalji's affable voice on the line offered to inform me in case of any cancellations. Much to my delight, he did call. How long did I wish to stay, he asked. Two weeks. That's not enough time to learn pottery, I was told, but it was up to me to take a call. I confirmed. We finalised the dates; I inquired the best route to get to Andretta and it was done.

It merits mentioning that Andretta is not the most convenient place to get to. One look at the HPTDC deluxe bus made me rethink the overnight journey I had booked my ticket for. Nevertheless, the decrepit vehicle (which made my bones

ache) arrived at Palampur the next morning. My black bag, an unrecognisable gray from dust now, was handed to me. Refreshing dew-laden green greeted my eyes. There was a row of private cabs parked as Jugalji had predicted, to take me on the last leg of the journey - down the road to Andretta.

In 20 minutes, I was dropped off at Jugalji's home, which housed the centre's students. The homestay was a five-minute walk from the Pottery. Though fatigued, I was delighted to meet Jugalji and his lovely wife, Lata. As the introductions proceeded, I was distracted by the view from where I stood. My gaze met the majestic Dhauladhars. They were breathtaking. Over a cup of very welcome tea, I was told it had rained the past few days, but that morning had brought clear skies. Behind the house stood the forests of the Sivalik Hills; lush green and reverberating with early morning bird chatter. I took in the fragrance of the flora drenched in the wetness of the rain. Used to the uniformly ugly Mumbai urbanscape, my eyes greedily took in



the view. It was perfect.

Having arrived on a Sunday, I had the day to myself. Andretta is a hub for art lovers. Richards arrived in Andretta in the 1920s and built a traditional Kangra-style mud house with a small outdoor theatre, which in no time became a centre for creative arts. Her home is a 10-minute walk from the Pottery Society. It is said that a young Prithvi Raj Kapoor also spent time learning theatre here. B C Sanyal, who played a key role in setting up the Lalit Kala Akademi in New Delhi was a frequent visitor. Freda Bedi, actor Kabir Bedi's mother also lived in Andretta and is said to have been friends with Richards. Portrait painter Sardar Soba Singh and Sardar Gurcharan Singh were few of those Richards invited in her quest to establish Andretta as an Artist Village.

The next day was class. My city-bred perception of class involves a group of students and an instruction routine. Kanchanjunga express accident was 'waiting to happen', probe points to lapses

The probe report by the Commissioner of Railway Safety on the accident involving the Kanchanjunga express and a goods train found lapses at multiple levels in managing train operations.

New Delhi:The Commissioner of Railway safety has said the Kanchanjunga express accident involving a goods train was "waiting to happen" due to lapses at multiple levels in managing train operations in

automatic signal zones, and "inadequate counselling" of loco pilots and station masters. In its probe report into the June 17 accident that left 10 persons dead, including the loco pilot of the goods train, the Commissioner of Railway Safety (CRS) also recommended implementation of the Automatic Train-protection system (KAVACH) on top priority. The CRS said wrong paper authority or T/A 912 to cross defective signals was issued to the loco pilot of the goods train involved by authorities concerned. improper authority and that too without adequate information, such an incident was an "accident-in-waiting". The CRS, in its probe, found that besides the Kanchanjunga Express and the goods train, five other trains



entered the section from when the signals turned defective until the accident appened on that day."In spite of issuing the same authority, different speed pattern was followed by loco pilots," it said.

The CRS noted that only the Kanchanjunga Express followed the norm of moving at a maximum speed of 15 kmph and stopping for one minute at each defective signal while the rest of the six trains, including the goods train involved in the accident, didn't follow this norm. This shows that "action to be taken

when T/A 912 is issued to them is not clear. Some of the loco pilots have followed the 15 kmph rule while most of the loco pilots did not follow this rule. The absence of proper authority and that too without adequate information created misinterpretation and misunderstanding about the speed to be followed."PTI had first reported that the T/A 912 didn't mention speed restriction which the CRS has also flagged in its report as a major reason for the accident. Classifying the accident under the "Error in Train Working" category, the CRS said there

was "inadequate counselling of loco pilots and station masters about train operation in automatic signalling territory creating misinterpretation and misunderstanding of rules."It said the large number of signalling failures in automatic signalling territory is a cause of concern and should be taken up with those concerned to improve the reliability of the system.

'The occurrence of as many as 208 cases of Signal Passing at Danger (red signal overshooting) from 1.4.2019 to 31.03.2024, out of which 12 cases resulted in collision, highlights the limitations of preventive measures taken by zonal railways (counselling of loco pilot/assistant loco pilot, safety drives, etc.)," the CRS said.

"This underscores the need for implementation of the Automatic Train-protection system (KAVACH) on top priority. Use of nonsignalling-based systems such as Artificial intelligence-based detection of the RED aspect of the signal and providing an early warning to the loco pilot/GPS-based anticollision systems shall be explored for provision in locomotive cabs across Indian Railways in non-ATP (automatic train protection) territory," it said. The CRS said in case of multiple signal failures, there were three options left with the rail administration but they followed none of them in total.

Why IAS Officer Puja Khedkar's Training Has Been Put On Hold

New Delhi: The training of probationary IAS officer Puia Khedkar has been put on hold amid allegations of misuse of power and privileges. Ms Khedkar has been recalled to the Lal Bahadur Shastri National Academy of Administration (LBSNAA) in Mussoorie for "further necessary action". Ms Khedkar was earlier transferred to Washim from Pune following accusations of manipulating disability and OBC certificates to gain entry into the civil services.

The General Administration Department of the Maharashtra government issued a directive stating, "You are hereby relieved from the District Training Programme of the State Government of Maharashtra." The directive instructs Ms Khedkar to "join the academy at the earliest" but not later than July 23.Ms Khedkar, a 2023-batch officer from Ahmednagar, claims to be the victim of a "media trial" alleging that a misinformation campaign has been waged against her.

The authenticity of various certificates submitted by Ms Khedkar to the Union Public Service Commission (UPSC) is currently under investigation. These include certificates indicating visual impairment, which Ms Khedkar submitted under the Persons with Benchmark Disabilities (PwBD) category.Despite being referred by the UPSC for a medical examination at Delhi's All India Institute of Medical Sciences (AIIMS), Ms Khedkar reportedly missed six appointments between April and August 2022. In August 2022, she applied for another disability certificate from the Aundh government hospital in Pune, but her application was rejected following medical tests.Ms Khedkar's troubles began when she was accused of demanding unauthorised perks and facilities while serving as an assistant collector in Pune. Allegations include using a red beacon and a "Government of Maharashtra" sticker on her private Audi car, occupying the office of Pune Additional Collector Ajay More during his absence, and demanding office furniture, letterheads, a VIP number plate, a separate house, and a car. These perks are typically unavailable to probationary officers who are still in their 24-month probationary period. Following these allegations, Ms Khedkar was transferred from Pune to Washim as a supernumerary assistant collector. This move was seen as a temporary measure pending further investigation.

SC to Hear on Thursday Pleas Seeking Cancellation of NEET-UG Exam

New Delhi: The Supreme Court is slated to hear on Thursday a batch of pleas alleging irregularities in the conduct of the NEET-UG 2024 examination and seeking its cancellation. As per the cause list published on the website of the apex court, a bench presided over by CJI D.Y. Chandrachud will resume hearing the matter on July 18.In the previous hearing, the Bench, also comprising Justices J.B. Pardiwala and Manoj Misra, decided to adjourn the hearing on the joint request of the parties, noting that the CBI has put on record the status report concerning paper leak allegations. In its affidavit, the Centre told the top court that the data analysis conducted by IIT-Madras shows that there was neither any indication of mass malpractice nor a localised set of candidates being

benefitted, leading to abnormal scores in NEET-UG examination held on May 5 this year. "There is an overall increase



in the marks obtained by students, specifically in the range of 550 to 720. This increase is seen across the cities and centres. This is attributed to a 25 per cent reduction in the syllabus," said the Centre, adding that candidates obtaining such high marks were spread across multiple cities and multiple centres, indicating very "less likelihood of malpractice". After a comprehensive data analysis using parameters like marks distribution, city-wise and centre-wise rank distribution and candidates spread over a range, experts of IIT-Madras opined "no abnormality", the affidavit

Delhi Doctors Report Rise In Hand, Foot, Mouth Disease In Children

New Delhi: Monsoon is driving cases of a highly contagious hand, foot, and mouth disease (HFMD) -- a common viral illness -- in young children in the national capital, said doctors here on Wednesday.

Hand, Foot and Mouth Disease (HFMD) predominantly affects infants and young children, and is characterised by a combination of symptoms including fever, sore throat, mouth sores, and a rash on the hands and feet. The disease is caused by various enteroviruses, most commonly Coxsackievirus A16 and Enterovirus

We are seeing 4-5 cases every day, which is much higher than the average cases we used to see," Dr Krishan Chugh, Principal Director and HOD, Paediatrics, Fortis Memorial Research Institute, Gurugram, told IANS.He said, "Cases are particularly seen among children aged 1-7."

The highly contagious disease typically bgins with a fever, often accompanied by a sore throat and a general feeling of malaise. It is followed by painful sores or blisters appearing in the mouth, on the palms of the hands, and soles of the feet. These sores can be quite uncomfortable, making eating and drinking difficult for affected children. The rash on the hands and feet may appear as small red spots or blisters. In some cases, particularly with Enterovirus 71, the disease can lead to more severe complications such as viral meningitis or encephalitis. The virus spreads easily through close personal contact, respiratory droplets (coughing, sneezing), and contact with contaminated surfaces or faeces. This high level of contagiousness makes outbreaks common in settings where young children gather, such as daycares and schools.

'It is usually self-limiting and settles in two weeks or so. It is spread by close contact, respiratory droplets and skin contact. Treatment is most symptomatic and prevention is to avoid close contact and respiratory isolation," Dr Atul Gogia, senior consultant and head of Infectious Diseases at Sir Ganga Ram Hospital, told IANS.

The hot and humid weather creates an ideal environment for the virus to thrive, leading to this increase. It tends to peak in the rainy season," added Dr Poonam Sidana, Director-Neonatology & Paediatrics at the CK Birla Hospital, Delhi.In the last several days, there have been reports from Kerala of an epidemic sickness known as tomato fever. However, doctors note that it is a misleading term and is actually a hand, foot and mouth disease.

The Tribunal has directed the insurance company to pay? 1.98 crore -? 1.21 crore as compensation and around? 77.61 lakh as interest - to the parents of Sidharth Sharma within 30 days.Sidharth Sharma died after being hit by a Mercedes - driven by a minor - in the Civil Lines area of Delhi on April 4, 2016. The fatal crash was recorded by a security camera installed in the area. The Tribunal also held the minor's father responsible for failing to stop his minor son from driving, especially a Mercedes car, despite prior warnings."Instead of

preventing his minor son from driving a Mercedes, he chose to ignore the same, which implies tacit consent on his part. The very fact that at the time of the accident he was at home was all the more reason to stop his son from taking the car from the home for a jo ride," the Tribunal said in its order.In the CCTV footage, Mr Sharma was seen trying to cross the road while looking both ways. He had just bought takeout from a noodle stand and was heading home. The 32-year-old, realising that the car was not slowing down, tried to get out of the way but didn't stand a chance. After hitting Sidharth Sharma, the Mercedes went over a pavement and came to a stop as its front tyres burst. The teenager abandoned the car and ran away with his friends. The court granted the insurance company the liberty to recover the compensation amount from the father's company.

Soak in the regalia of the fairytale-like princely state of Jodhpur in Rajasthan's second largest city.

As little kids, we would pester our grandparents to tell and retell the stories of beautiful queens, handsome maharajas, fierce battles and bejewelled royal palaces. I managed to behold and soak in the regalia of one such fairytalelike princely state on my recent trip to Rajasthan's second largest city and home to the Maharajas since 1459, Jodhpur.

The silky sand dunes of the Thar Desert dotted with camels basking in the sun, towering forts and palaces glistening in red sandstone and the narrow lanes leading to shops that open into an alluring world of handicrafts are some of the welcoming sights here. We were fortunate to have a host-cum-tour guide to walk us into different eras every time we stepped inside historical monuments, temples and gardens. Madan Lal Jangid, a 69-year-old French professor, entrepreneur, researcher and an avid traveller could not be dismissed as one of those guides who takes tourism to be a revenue-making business. "I cannot wrap up the history of a place in 45 minutes, make money and let you go feeling satisfied. I remember when a diplomat from Canada had been here, we spent at least 4-5 hours in Mehrangarh Fort discussing the many stories behind every pillar and rock. That is how you connect; summarising a history in stockand trade terms is a fruitless exercise," asserts he. Our car moved through the nooks and crannies of the city in a way that the seat's window became a frame to the colourful images outside running past one after the other. From veiled women keeping up with their husbands' pace, the paan wala sprinkling water on the cascading betel leaves, little boys encircling foreign tourists to that old woman under the shade of the Clock Tower with a heap of coloured shoelaces awaiting buyers; the transition seemed like we turn pages in a photo album.

The Royal guarters of Mehrangarh Fort

The mighty walls of the Mehrangarh Fort have many secrets buried inside. Maintained by the present generation of Marwar Kings, Maharaja Gaj Singh II, the expansive courtyards, exquisite palatial spaces like the Moti Mahal (Pearl Palace), Phool Mahal (Flower Palace), Sheesha Mahal (Mirror Palace), and hidden balconies for women to listen to court proceedings, chambers and galleries enrich the fort's heritage. Our host informs us that this is the only fort where you will find the provision of an elevator allowing people to not worry about any physical barriers during their tour. There is yet another purpose of the elevator; it leads you to the Mehran Terrace, a roof-top restaurant where people take delight in indulging in the traditional Rajasthani thali. And what better way to admire the beauty of a world-class historical monument than sitting on the terrace beneath the twinkling stars and dim-lit candles on the

dining table? On reaching the top floor, the view of the entire cityscape is breathtaking. All the gates of the fort are visible and the panoramic view seems sketched on a blue canvas. Blue, because the cluster of buildings are bathed in that colour and there is a reason too. The colour was earlier identified with a certain privileged section of society, a marker of a higher caste but slowly as civilization

grew, such social indicators ceased to have any significance. Subsequently, blue emerged as the universal colour of all communities irrespective of distinctions. Jodhpur is not only known as the 'sun' city, it is also referred to as the 'blue' city, like Jaipur is the Pink City.

Note: The rooftop restaurant opens during the evenings after the fort closes. Tourists who do not intend to move around the fort and would rather revel in the maharaja-style dining on the terrace can do so. The Chokhelao garden (200-



year-old and recently refurbished) is often mistaken to be the Mehran Terrace but both are different, though within the premises of the fort area. The Chokhelao Garden leads to the Mehran Terrace

Located half way up the road that climbs onwards to the Mehrangarh fort is Jaswant Thada. Immaculate in white marble, this mausoleum was built in the year 1899 in the memory of Maharaja Jaswant Singh II. A tomb with an array of domes is the crematorium for Jodhpur rulers. As the sun rays kiss the milky surface of the monument, the memorial comes alive in a glaze and its intricate carved jalis (screens) emit a glow.

The grandeur of Umaid Bhavan This palace was born out of a crisis. When consecutive seasons went without rain. a famine-like situation arose that threatened the economic lives of people. Manaraja Umaid Singh decided to construct a palace that would not only relieve employment worries but also remain a monument of symbolic value for years. A visionary and benevolent king succeeded in his famine-relief policy that provided employment to

thousands for a period of

almost two decades from 1929-44. Anecdotes are many when it comes to discussing the Umaid Bhavan (initially called Chittar Palace for it stood on the Chittar Hills). The Art Deco furniture and impeccable interiors were originally crafted by Maples of London but unfortunately all furnishings could not reach the Palace. In the wake of World War II, the furniture-laden ship succumbed to a tragedy and was sunk by the Germans en route to India. Nothing could deter the Maharaja's plans and in came a Polish artist and refugee from war-torn Europe, Stephen Norblin, who mended what was wrecked. Familiar with the work of Art Deco connoisseurs, Norblin did not fail the King. As you look through the paintings (essentially inspired by the episodes of Ramayana), gaze at the artefacts ranging from antique clocks (some in the shape of railway locomotives and others in windmills) to ornate ceilings; you would be quick to notice a harmonious "blend of occidental symmetry and oriental texture," in the words of our host.

Umaid Bhavan has been divided into three sections- one portion is dedicated to the museum and exhibition area, the other is converted into a hotel and the third segment is owned by the current family of the royals headed by Maharaja Gaj Singh

Clock Tower and marketplace

Rajasthan is a land that celebrates colour and what better way to explore it than doing the rounds of the market area on the Nayi Sadak with the huge Clock Tower in the backdrop. Once you take a left from the Nayi Sadak, you reach the inviting world f lac bangles

sparkling in embedded mirror work and bold colours almost blinding you at first sight. A walk through the Lakhara Bazaar reminds you of Delhi's Chandni Chowk where everybody is scuttling around but with a sense of purpose. With bandhej designs, tiedye prints, ethnic footwear and all things jodhpuri, you are bound to go neck-deep in shopping. Amid all the chatter of the localites, bickering of buyers and sellers, frying of 'mirchi' vadas and mawa kachoris (chilli-infused snacks) Jodhpur brightens up in the evenings. Biting into one of the spicy vadas, our host shared a trivia, "Rajiv Gandhi loved the mirchi vadas here and would never leave the city after every visit without his share of the popular snack".


Mandore Garden is more than flower-beds Gardens are supposed to make you feel happy but I entered into the gates of the Mandore Garden with a heavy heart. It was

once a prominent entry point to the Mehrangarh Fort but today stands like an ordinary gateway. Its walls embossed in palm prints continue to speak of the cruel ritual of sati (burning of wives in the funeral pyre of their dead husbands) rampant during

crevices of lush green trees you can catch a glimpse of the Mandore temple that is believed to be named after Ravana's wife, Mandodari. On one hand, while a woman is a symbol of divinity, she is also subjected to atrocities like sati and dowry deaths; a conundrum unresolved.

Osian Village and the Great Indian Desert If Jaisalmer prides in its Golden Fort (fondly known as 'Sonar Kella' after Satyajit Ray's film by the same name), Jodhpur too flaunts the 'Khajuraho of Rajasthan', i.e. Osian Village. It is one of the ancient villages and pilgrimage centres of the Oswal Jain community that is home to ruins of Brahmanical and Jain temples dating back to the 8th Century. Almost a two-hour drive from the main city, Osian is an oasis in The Thar Desert. Once in our lifetime, some of us wish to see snow, some want to feel the sea from up-close and others long to be on the mountains. But when you find yourself standing in the middle of a desert, surrounded with nothing but golden-yellow sand dunes, the openness engulfs you. Footprints on the desert that begin to form a trail but suddenly dissolve after a distance seem like a reminder of how fragile permanence can be. Tents and resort camps situated on the picturesque Osian sand dunes can make for a peaceful stay for tourists hoping to escape their busy lives.

Bishnoi Villages The Chipko Movement can be traced back to the origin of the Bishnois (a community of nature and wildlife lovers) that revolted against the Maharaja's decision to fell trees in order to build the Mehrangarh Fort. Since the feudal power dismissed the protests by the bishnois who hugged the trees as an act of resistance, many of them were hacked with the trees. Since then, there is a day that commemorates the sacrifice of the bishnois in Khejerli Village. A glimpse into the cultural life of the bishnois in Khejerli Village, (south-east of Jodhpur is considered a place of pilgrimage) can definitely be a value addition to your trip. Village tours and safaris are conducted in Khejerli and Guda Bishnoi Villages; they are home to chinkaras and blackbucks that roam the countryside throughout the day but




Things to do in Shillong—the abode of clouds

Bajaj Auto net profit rises 18% to Rs 1,942 crore in June quarter of Fy25



NEW DELHI: Bajaj Auto on Tuesday said its consolidated profit after tax increased 18% to Rs 1,942 crore for the first quarter ending June 30, 2024, aided by robust sales across domestic and export markets.

The automaker had reported a profit after tax of Rs 1,644 crore in the same quarter of last fiscal. Total revenue from operations rose to Rs 11,932 crore for the first quarter as against Rs 10,312 crore in the year-ago period, Bajaj Auto said in a regulatory filing. On a standalone basis, the company reported a PAT of Rs 1,988 crore, an increase of 19% as compared with Rs 1,665 crore in the same period of last fiscal. Revenue from operations rose to Rs 11,928 crore as against Rs 10,310 crore in the June quarter of FY24

The company said its total sales stood 11,02,056 units in the first quarter as against 10,27,407 units, an increase of 7%. It sold 6,90,621 units in the domestic market in the first quarter, an increase of 8% over 6,41,556 units in the year-ago period. Exports increased 7% year-onyear at 4,11,435 units in the June quarter as agaist 3,85,851 units in the April-June quarter of last fiscal. Bajaj Auto said profit was driven by better realisation and cost reduction which more than offset the drag from the growing electric two-wheeler business.

NCLT admits insolvency proceedings against Byju's

BENGALURU. The National Company Law Tribunal (NCLT), Bengaluru bench, on Tuesday admitted an insolvency petition filed by the Board of Control for Cricket in India (BCCI)against edtech firm Byju's over a Rs 158 crore debt.Byju's, reached its peak valuation of \$22 billion in 2022, has to face insolvency proceedings.

The bench has appointed Pankaj Srivastava as an interim resolution professional to oversee the functions of the company. According to sources, Byju's is planning to challenge the order at National Company Law Appellate Tribunal (NCLAT). "As we have always maintained, we wish to reach an



amicable settlement with the BCCI and we are confident that, despite this order, a settlement can be reached. In the meantime, our lawyers are reviewing the order and will take necessary steps to protect the Company's interests," a spokesperson from Byju's said.Both BCCI and Byju's entered into a team sponsor agreement in 2019, and in 2022, Byju's made payment in full only against one invoice for the year 2022-2023. The edtech firm failed to make payments against the remaining invoices raied by the BCCI for the financial year 2022-23. The NCLT dismissed an application by the edtech firm to refer the matter to arbitration. "It is abundantly clear as laid down by the Apex Court that the Adjudicating Authority has to either reject or admit the application and cannot postulate a third option. In this matter, the application U/s 9 of the IBC has been admitted by the Order passed today, therefore, the application for referring the matter for Arbitration is not maintainable," the order said. Apart from BCCI, Oppo has also filed an insolvency plea against the firm. The edtech company has settled an insolvency case with Surfer Technologies and Teleperformance recently. Previously the NCLT had issued notices to Byju's parent Think and Learn in three cases due to claims of unpaid dues.

Budget 2024: Insurance sector's wishlist for FM Nirmala Sitharaman

New Delhi. Finance Minister Nirmala Sitharaman took part in the 'Halwa' ceremony, marking the final stage of the Budget preparation process for Union Budget 2024-25 on Tuesday. The Monsoon Session of Parliament begins on July 22, with Budget 2024 to be presented on July 23. He pointed out, "Over the past decade, India has achieved remarkable economic growth, with GDP consistently exceeding 6% and surpassing many global economies. As we approach this budget, we anticipate measures that will sustain and simultaneously accelerate this long-



term growth, benefiting individuals and businesses alike, with a strong emphasis on job creation.

Chugh highlighted the importance of addressing inflation to secure a robust financial future for individuals. Lower inflation would increase disposable income, allowing citizens to save and invest more towards their long-term goals and financial security.A significant part of these investments could be in life insurance products. Despite the sector's potential, life insurance remains under-penetrated in India. Chugh suggests that lower GST on life insurance products could make them more attractive. He also

recommends aligning life insurance annuities or pension products with the National Pension Scheme (NPS), allowing an additional deduction of Rs 50,000 or more under Income Tax for these products. This alignment would encourage more people to secure their post-retirement financial needs through life insurance annuities or pension products.Furthermore, Chugh proposes the introduction of Long

Term Capital Gain taxability for all high-value traditional life insurance plans (with an annual premium of more than Rs 5 lakhs). This move would bring uniformity and tax efficiency for insurance customers, making life insurance products competitive with other financial products in the market. Budget 2024: This change to old income tax regime can provide relief to

New Delhi Finance Minister Nirmala Sitharaman is set to present the Union Budget 2024 on July 23, and as usual, a key demand amongst citizens is for tax relief. While reports indicate that the government may introduce measures to enhance the appeal of the new income tax regime, tax gime, which offers the advantage of deductions. A proposal by BankBazaar aims to provide tax relief to millions of middle-class taxpayers. The proposed changes to the old income tax regime involve adjusting the income tax slabs to account for inflation, a move that could greatly benefit many. Under the current old tax regime, the tax structure has remained unchanged since 2013. The existing slabs tax are — income from Rs 2.5 lakh to Rs 5 lakh at 5%, from Rs 5 lakh to Rs 10 lakh at 20%, and any income above Rs 10 lakh at 30%. This adjustment would provide considerable relief compared to the existing Rs 10 lakh threshold, which has been in place for over a decade. How will it help taxpayers opting for old tax regime? The BankBazaar Primer for Budget 2024 highlights the necessity of updating the 20% and 30% tax slabs for the old regime. The Cost Inflation Index shows a significant rise from 200 in 2012-13 to 363 in 2024-25, an 81.5% increase, underlining the need for these adjustments.

Persistent inflation in recent years has further escalated the index, making it imperative to update the old slab rates without further delay.

The proposed income tax slab adjustments aim to address the erosion of real income and the excess taxes paid by taxpayers due to the frozen slab rates. For example, under the current old regime, taxpayers earning Rs 10 lakh are paying Rs 43,226 in excess taxes, which amounts to Rs 3,602 per month.

For an income of Rs 20 lakh, excess taxes paid are Rs 1.84 lakh in the old regime and Rs 67,978 in the new regime. The old regime, favoured by many for its numerous deductions including rent, loan payments, insurance premiums, and tax-saving investments, has not been adjusted for inflation since 2013.As a result, taxpayers are shouldering higher tax burdens while facing rising living costs.BankBazaar's proposal seeks to correct this imbalance by adjusting the slabs and enhancing specific deductions.

Stampede-like chaos at Mumbai Airport loader recruitment drive with 25,000 applicants for 2,200 vacancies

MUMBAI. A few days after a RBI report painted a rosy picture about jobs in India, a recruitment drive for airport loaders led to a stampede-like situation at Mumbai airport on Tuesday. According to a report, over 25,000 applicants turned up for a shot at the 2,216 vacancies, and the staff of Air India Airport Services Limited struggled to manage the massive crowd.Air India Airport Services Limited provides ground handling services at major airports in India.

Visuals showed the applicants jostling with each other to reach the form counters. Reports said the applicants had to wait for hours without food and water, and many of them started feeling unwell, according to NDTV.

Airport loaders are tasked with loading and unloading luggage on aircraft and



operating baggage belts and ramp tractors. Each aircraft needs at least five loaders to handle luggage, cargo and food supplies. The salary of airport loaders ranges between ? 20,000 to ? 25,000 a month, but most make over? 30,000 after overtime allowances. New Delhi. The Indian Chamber of Commerce (ICC) has suggested the government to rationalise customs duties in various sectors including steel, solar battery, aluminum, and lithium cells in a bid to boost domestic manufacturing.

Finance Minister Nirmala Sitharaman is scheduled to present the Union Budget for financial year 2024-25 on July 23.



ICC President Ameya Prabhu said protective measures are needed for the growth of domestic industry in sectors including steel, solar battery, aluminum, and lithium cells."There is a need for rationalization of customs duty in these

specific sectors in a holistic manner. Huge potential is there to boost domestic manufacturing and make India a global hub for manufacturing," Prabhu said. While adding that taxes on raw materials impact domestic players particularly the

aluminium foil sector, the President said the domestic industry has been facing severe losses as there is anti-dumping duty on raw materials whereas the finished goods are not subject to any duties on imports from China. He also asked for correction in inverted duty structure by cutting down duty on mixed petroleum gas from 5 % to 2%.He emphasized that, there is a need to increase duty on polymers - polyvinyl chloride, polyethylene terephthalate, polypropylene and polyesters to 10 per cent for improve domestic manufacturing .This will help in reducing import dependency and will drive India towards self-sufficiency in the petrochemical manufacturing segment. .On the taxation side, the chamber has suggested setting up a commission to review the Income Tax Act 1961 in its entirety and simplify the provisions, stressing that over the years amendments have made the act complex to understand and the resulting anomalies

Fernandes in his Instagram Live was seen singing racist chants along with the rest of the Argentina squad, who took an unprecedented dig towards the French Football team. The video has since gone viral on social media, and has also resulted in a legal case and a lot of backlash for the Chelsea number 8. Fofana in his social media post, shared a screenshot from Enzo Fernandes's video and labelled it "uninhibited racism". According to multiple reports, several other players in Chelsea have since shown disgust and anger at Enzo's actions. Enzo's Chelsea teammates like Fofana, Malo Gusto and Axel Diasi have blocked the Argentine midfielder on social media since the video came up."They play for France, but their parents are from Angola. Their mother is from Cameroon, while their father is from Nigeria. But their passport says French," The chants from Argentina's squad and Enzo. Moreover, The Governing Body of French Football, FFF, has also lodged a legal complaint on the Argentine squad and Enzo for the same.The president of the French Football Federation, Philippe Diallo, condemns in the strongest terms the unacceptable racist and discriminatory remarks which were made against the players of the French team in the context of a song sung by players and supporters of the Argentina team after its victory in the Copa América and broadcast in a video on social media...The president of the FFF decided to directly challenge his Argentinian counterpart and Fifa, and to file a legal complaint for insulting remarks of a racist and discriminatory nature," A statement from FFF said. Enzo has since issued and apology for the chants, through a special message via his social media accounts.

England cricketer James Vince reveals his family was attacked twice

New Delhi. England cricketer and Hampshire captain James Vince has revealed chilling details about attacks on his home that forced his family to leave their hometown in Southampton. Vince and his family had enjoyed the tranquility of their home in a village east of Southampton for nearly eight years. However, in a report to The Telegraph on Tuesday, July 16, Vince revealed that there had been two attacks on his family home in Hampshire within the last three months. Vince lives there with his wife and two children, aged seven and three.

Three months ago, the Vince family woke up in the middle of the night to the sound of glass shattering and alarms blaring. Their house and cars had been attacked. Just over a month later, after completing the repairs, the family was once again awakened by trespassers throwing bricks at their house and cars. The second attack was captured by newly installed security cameras. The footage shows two men, one wearing a hoodie with the logo of the brand Gym King on the back. This man is seen receiving bricks from another person holding a torch and possibly filming the act. Neither person's face is visible in the video. Following the attacks, support poured in from Hampshire, the ECB, and the Professional Cricketers' Association. Intelligence firms were hired to investigate the matter, but their inquiries have yielded little information so far. The pattern of attacks suggests a financial motive, such as unpaid debts. However, neither Vince nor his wife Amy found anything in their financial or phone records indicating trouble with anyone. The most plausible explanation currently is mistaken identity. Vince, typically a private individual off the field, decided to go public with a plea for information in hopes of resolving the

French football body files complaint over 'racist' song by Argenting players

New Delhi. The French Football Federation (FFF) vowed to file a complaint to the global governing body of the sport (FIFA) over a 'racist' song sung by a section of Argentina players during their post-match celebration after winning the Copa America 2024 final on Sunday. A controversy erupted when a video surfaced showing Argentine players, including Enzo Fernández, singing a racist song targeting French national team players of African descent. The song, which was posted on social media by Fernández, included offensive language and slurs that sparked widespread outrage. The FFF strongly condemned the "racist and discriminatory remarks" made by the Argentine players, stating that they would file a legal complaint over the incident. The FFF president, Philippe Diallo, expressed shock and disappointment at the "unacceptable" behavior, which he believed was contrary to the values of sport and human rights.

"Given the seriousness of these shocking remarks, which are contrary to the values of sport and human rights, the FFF president has decided to contact its Argentinian counterpart and Fifa directly to file a legal complaint for racist and discriminatory remarks," the FFF said on Tuesday. Mexico coach Jaime Lozano sacked after Copa America disappointment

Jaime Lozano has been sacked as Mexico's head coach following their Copa America group-stage exit, the country's football federation (FMF) said on Tuesday.

New Delhi. Jaime Lozano has been dismissed as head coach of Mexico's national football team two weeks after their first-round exit from the Copa América. The Mexican Football Federation (FMF) announced on Tuesday that Lozano had declined an offer to remain with the team as an assistant coach for two years, with a potential return to the head coach position after the 2026 World Cup. "This was one of the toughest decisions I have had to make," Lozano shared on his official social media accounts. "It is a matter



of principles and due to the change of direction from the original project." Javier Aguirre, a close friend of FMF commissioner Juan Carlos Rodr-guez, is considered the leading candidate for the head coach position. Aguirre previously coached Mexico during the 2002 and 2010

World Cups and had earlier declined a role to assist Lozano from a distance. The FMF indicated that a new coach could be confirmed as early as the first week of August. Lozano, who guided Mexico's Under-23 team to a bronze medal at the Tokyo Olympics, was appointed interim

head coach of the national team in May last year, replacing Diego Cocca. After winning the Gold Cup, Lozano's position became permanent in August 2023. During his tenure, Lozano managed just 10 wins out of 21 matches. In the Copa América, Mexico narrowly defeated Jamaica, lost to Venezuela, and drew with Ecuador, resulting in their elimination from Group B. Controversially, Lozano left out five experienced players from the Copa América squad, including goalkeeper Guillermo Ochoa and forwards Hirving Lozano and Raul Jimenez. He explained that he wanted to give other players leadership opportunities. The president of the FMF, Ivar Sisniega, had assured him that his job was secure regardless of the tournament's outcome. Following the Copa América exit, the FMF has begun an analysis to identify mistakes, successes, and areas for

improvement. Lozano, who spent only one year in the role, led Mexico to the 2023 Gold Cup title and reached the CONCACAF Nations League final earlier this year, where they lost to the United States. His overall record as head coach includes 10 wins, four draws, and seven losses.

IOA releases list of 117 athletes and 140 support staff for Paris Olympics 2024

New Delhi. India's final contingent for the Paris Olympics 2024 has been approved by the sports ministry. A total of 117 athletes will be travelling to Paris and will be accompanied by 140 support staff and officials. Among the support staff, 72 personnel have been granted government funding in order to cater to the needs of the participating sportspersons. However, a notable absentee from the list of 117 athletes was shot putter Abha Kathua. She had secured her qualification for the Paris Olympics through the world ranking quota. There was no explanation as to why Kathua's name was omitted. This happened after her name was found missing from World Athletics' list of Olympic participants a few days ago. The Indian contingent for the Paris Olympics will be led by the athletics team, which comprises 29 athletes, including 11 women and 18 men. The shooting team will have the second-largest Indian representation with 21 members, followed by the hockey team with 19

athletes, additional coaches and other support staff numbering 72 have been approved at cost to the Government and arrangements for their stay have been made in Hotels/in locations outside the Games Village," it added.

Indian contingent for Paris Olympics Table tennis will be represented by eight players, while badminton will feature seven competitors, including two-time Olympic medallist P.V. Sindhu. Wrestling, archery and boxing will have six representatives each. This is followed by golf with four participants

and tennis with three. Sailing and swimming will witness two Indian competitors, followed by equestrian, judo, rowing and weightlifting with one participant each.

During the last Tokyo Olympics in 2020, India was represented by a 119-member contingent. The country returned with the best-ever haul of seven medals, including a historic gold by javelin star Neeraj Chopra.

OTD: Pant hundred helps Rohit become 1st Indian captain to win ODI series vs ENG

New Delhi. On this day two years ago, India sealed a thrilling 2-1 series victory over England in the three-match ODI series after a dramatic five-wicket win at the iconic Old Trafford in Manchester on July 17, 2022. The win not only secured the series for India but also etched captain Rohit Sharma's name in the history books. He became the first Indian captain to win both the T20I and ODI series on English soil. Rishabh Pant's magnificent unbeaten century (125*) and Hardik Pandya's crucial 71 helped India chase down England's total of 259 within the 43rd over. This victory made Rohit Sharma the third captain to win an ODI series in England, joining MS Dhoni and Mohammed Azharuddin.England, put in to bat first, were bundled out for a meagre 259 runs. The Indian pace attack, led by the impressive Hardik Pandya (4/24), was ruthless, dismantling the English batting line-up. Yuzvendra Chahal (3/60) provided valuable support with his wily leg-spin, restricting the flow of runs in the middle overs. Chasing a seemingly manageable target, India suffered a top-order collapse, losing their experienced trio of Rohit Sharma, Shikhar Dhawan, and Virat Kohli early. This left them in a precarious position at 72/4, with the



pressure mounting. Rohit achieves unique feat

However, a fighting partnership between Rishabh Pant and Hardik Pandya turned the tide in India's favour. Pant, known for his aggressive stroke play, displayed remarkable maturity and played a sheet-anchor role. He stitched together a match-winning 133-run stand with Pandya (71), rescuing India from the brink of defeat. Pant's unbeaten knock of 125, laced with 16 fours and 2 sixes, was a masterclass in controlled aggression, ensuring India crossed the finish line with 47 balls to spare.Rohit Sharma's leadership throughout the series was impeccable. He displayed tactical acumen, making crucial bowling changes and backing his players at critical moments. His historic double series win in England will be a feather in his captaincy cap.

New Zealand yet to confirm ODI captain, Tom Latham one of the options: Gary Stead

New Delhi. New Zealand head coach Gary Stead said the Blackcaps are yet to take any decision on Kane Williamson's replacement as ODI captain with senior opener Tom Latham in the reckoning. With Williamson stepping down from the role, Latham has emerged as a strong candidate to succeed him. Williamson's decision to relinquish the captaincy follows his choice to turn down a central contract for the 2024/25 season, although he still aims to continue playing international cricket. Latham, who has frequently stood in as captain,

has led New Zealand in 44 ODIs, including during last year's World Cup when Williamson was sidelined with a broken thumb. His experience and leadership qualities make him a natural contender for the permanent role.Coach Gary Stead highlighted the importance of stable



leadership heading into future competitions. "We're not at the stage of confirming it yet, so I don't want to speculate whether Tom will be or not," Stead said. "But he's certainly one guy that will be in discussions around that role. The important thing is whoever is in place, we want in place for two to three years or so, leading to that next [ODI] World Cup.

That will be one of the important decision-making factors that we discuss." Latham himself expressed enthusiasm about the possibility of leading the team. "It would obviously be a real honour," he said. "For me, it's always been about trying to put the team first as best as possible, and I'm sure they'll have those discussions around what they want from a team point of view. Certainly, if I get the opportunity to do that, it would be really special."

New Zealand's upcoming schedule includes six ODIs during their home summer, with three matches each against Sri Lanka and Pakistan. Following this, they will participate in a tri-series in Pakistan ahead of the Champions Trophy, making the selection of a new captain a crucial decision in the lead-up to these significant fixtures.

Greatest Indian Olympians: Sushil Kumar

... Wrestler Sushil Kumar is one of the most successful athletes to represent India at the Olympic Games. Sushil won back to back medals in 2008 and 2012 edition of Olympic Games.

New Delhi. India are about to embark on scripting another glorious chapter in their Olympic history in the upcoming 30th edition of the mega event in Paris. A 118athlete strong contingent will carry the hopes of 1.4 billion who will be rooting for a podium finish for most of them.

In India's 124-year-long history at the grand

event, several players have risen the tricolour high giving their sweat and blood in their respective sports. One such person who made valuable contributions to India's medal tally in back-to-back editions in 2008 and 2012 is wrestler Sushil Kumar.Born in Delhi on May 26, 1983, Sushil showed signs of greatness quite early in his career as he won his first gold medal at the World Cadet Games in 1998 at the age of 15. The youngster added another gold to his tally at the Asian Junior Wrestling Championship in

Sushil's first stint at senior competitions

Having proven himself in junior competitions, Sushil made smooth transitions at the senior level as well by winning the bronze medal at the Asian Having failed to leave a mark on his Olympic Wrestling Championships in 2003. He further followed it up with a gold the same year at the Commonwealth Wrestling Championships. Sushil made his Olympic debut at the 2004 edition held in Athens but didn't have a memorable outing as he finished in 14th place in the 60 kg weight class. However, the wrestler made amends

for his poor show by winning consecutive Gold medals in the Commonwealth Wrestling Championships in 2005 and 2007

debut, Sushil once again returned at the grand event in the 2008 edition held in Beijing. However, he again didn't have a good beginning losing to Andriy Stadnik in the first round of the 66 kg freestyle wrestling event. After his loss, Sushil got his shot at the bronze medal through repechage and defeated Leonid Spiridonov in the third round by 3:1 to win India's second Wrestling medal at the grand event. The first was won by Khashaba Dadasaheb Jadhav who won Bronze medal at the 1952 Summer Olympics.

In the 2012 London Olympics, Sushil turned the Bronze to Silver losing to Japan's Tatsuhiro Yonemitsu in the final. As a result, he etched his name in history by becoming the first Indian athlete to win two medals at an individual event in Olympics.

A tragic end to a glittering career

Medals continued to flow in for India's wrestling hero who grabbed gold at the three consecutive editions of the Commonwealth games in 2010, 2014 and 2018. For his outstanding achievement in

his sport, Sushil was also bestowed with India's highest honour for sports persons the Major Dhyan Chand Khel Ratna in 2009. The subsequent year, he became the first and only Indian to win a gold medal at World Wrestling Championship defeating Russia's Alan Gogaev by 3-1. However, Sushil ended up destroying his storied legacy.
