## Four dead, several others injured as Chandigarh-Dibrugarh Express derails

Gonda, July 18: Sandeep Kumar remembers hearing the cries of a boy and his coach getting filled with dust as the Chandigarh-Dibrugarh Express derailed here on Thursday. "I remember the loud cries of a boy sitting on the berth across from me. For a moment, the coach was filled with dust and it was all dark. I don't remember what happened in the next few seconds. I only remember the cries and that some passengers pulled my hand and helped me get out of the window," said Sandeep Kumar, who was travelling in a sleeper coach. At least eight coaches of the train derailed in the Motiganj area, about 150 km from Lucknow, near Gonda on Thursday, leaving one passenger dead and 35 injured. The passenger train heading to Dibrugarh from Chandigarh crossed the Gonda station at 1.58 pm. The next stoppage was Basti, but it derailed shortly after it crossed the Motiganj railway station. "I was sitting near the window when I heard a loud noise," recalled another passenger, Manish Tiwari, 35, who was travelling in the B2 coach of the train. Tiwari said he felt a jerk

that hurled him to the ceiling of the coach. "I the gates were closed. I got hit with the gate. could not understand what happened to the climbed to the upper berth to catch a nap Had the gate been open, I would have fallen train. The loud noise of the coaches leaving

something was wrong," she said. Another passenger of the train, Sunita Sethiya (42), who was travelling from Chandigarh to Gorakhpur, said she had gone to the washroom at the time of the incident. "As soon as I came out, I felt a strong jolt. Luckily, both

Passengers had to wade through knee-deep water in the fields on either side of the track to reach the nearby approach road. Others, shocked by the accident or injured, sat on the track itself, waiting to be rescued. When police

teams reached the spot, officials made announcements asking people to stay away from the damaged coaches. The rescuers cordoned off the area and were seen entering the damaged coaches to ensure that no passenger was left behind. Dr Satya Narayan, a doctor at the CHC, said about 25 people were brought to his hospital.

New Delhi, July 18: Close on the heels of an assassination bid on former US president Donald Trump, the ruling BJP on Thursday said Indian opposition's utterances about Prime Minister Narendra Modi could have "serious implications and must be avoided". Cautioning the opposition, especially the Congress, BJP spokesperson Sudhanshu Trivedi said the words "hinsaa" and "hatya" "have repeatedly figured for PM

New Delhi, July 18: A Delhi court on Thursday referred BRS leader K Kavitha, lodged in Tihar jail in two cases related to the alleged excise scam, to AIIMS for a medical check-up. The Bharat Rashtra Samithi (BRS) MLC was taken to Deen Dayal Upadhyay Hospital after she developed a gynaecological problem and high fever on Tuesday. After staying in the hospital for two hours, she was sent back to jail, an official said. "Kavitha was taken to DDU Hospital after she developed a gynaecological problem and high fever around 4.30 pm. She was kept under observation and underwent tests," an official said. Sources said the BRS leader often has gynaecological issues in prison and a team of jail doctors looks after her. The court passed the order after Kavitha claimed her health monitoring tools were not working properly and there were discrepancies in the result.

"Foreign Secretary Vikram Misri will pay an official visit to Bhutan from July 19-20, which will be his first visit abroad after taking over as the foreign secretary," it said. He will call on the prime minister, minister of foreign affairs and external trade, and meet the foreign secretary and other senior officials of the Royal Government of Bhutan," it said. ## Supreme Court directs NTA to declare centre-wise results of NEET-UG

New Delhi, July 18: The Supreme Court on Thursday directed the National

Testing Agency (NTA) to declare by 12 noon of July 20 the centre and city-wise results of controversyridden NEET-UG 2024 while masking the identities of the aspirants, saying it wanted to ascertain whether candidates appearing at allegedly tainted centres scored more marks than those elsewhere. As it strove to address the allegations of malpractices in the conduct of the May 5 examination, a bench headed by Chief Justice D Y Chandrachud said any order for conducting it afresh has to be on

concrete conclusion that the alleged leak was "systemic" and the sanctity of the entire process was affected. "We direct the NTA to publish the marks obtained by students at the UG-2024 NEET examination, while, at the same time, without disclosing the identity of the students. The result should be declared city and centre wise by 12 noon on July 20, 2024 and shall be uploaded on the website of the NTA," the bench, also comprising



Justices JB Pardiwala and Manoj Misra, said in its order. "We want the identity of students be masked. You can have dummy roll numbers. But let us see it centre-wise what is the marks pattern," the bench said. The top court will resume hearing arguments on July 22 on a batch of pleas seeking cancellation, retest and court-monitored probe into the allegations of malpractice in the prestigious exam. The bench noted the counsel for the petitioners have submitted

that it would be appropriate if the result of NEET-UG 2024 examination was published on the NTA website so as to bring about transparency with regard to centre-wise marks obtained by candidates. It also said that material collected by the Bihar Police and the report of its Economic Offences Wing (EOW), before the investigation was taken over by the CBI, shall be filed in the court by 5 PM on July 20. At the outset, the bench said it has prioritised the hearing on the pleas over other

Puri, July 18: The Ratna Bhandar, the revered treasury of the 12th-century Jagannath temple in Puri, was reopened on Thursday for the second time in a week for shifting of valuables to a temporary strong room, officials said. The treasury was reopened at 9.51 am, they said. After offering prayers before Lord Jagannath and his siblings, the members of a supervisory committee set up by the Odisha government for the shifting of valuables from the Ratna Bhandar, entered the temple around 9 am. Speaking to media persons before entering the temple, the supervising committee's chairman and Orissa High Court former judge Justice Biswanath Rath said, "We sought the blessings of Lord Jagannath for smooth completion of shifting of all valuables stored in the inner chamber of the treasury." Last time, the treasury was opened on July 14 after 46 years. On that day, the ornaments and other valuables of the outer chamber of the

## Chancellor of state-run universities should be 'elected CM', not 'selected': CM Mann

Chandigarh, July 18: Punjab Chief Minister Bhagwant Mann on Thursday stressed that chancellor of state-run universities should be an "elected chief minister" rather than "selected", a remark which was referred to the state governor. Taking a swipe at Governor Banwarilal Purohit, Mann said if the governor does not want to give assent to any bill, then he sends it to the President who returns that bill after a couple of months. His statement came after the President returned a Punjab bill that seeks to replace the state governor with the chief minister as the chancellor of state-run universities without her assent. Mann said he will hold a meeting over the issue of the Punjab Universities Laws (Amendment) Bill, 2023, which has been returned by the President without her assent. The Punjab Universities Laws (Amendment) Bill, 2023 was for replacing the governor with the chief minister as the chancellor of staterun universities. Speaking about the current process for the appointment of vice-chancellor of staterun universities, Mann said, "If we want to appoint the VC of Punjabi University, then we will have to give three names to the governor. He will select one of them of his choice. Then who chooses? Is it elected or selected." "One should know the culture. What is Punjabi University's culture, what is the culture of Punjab Agricultural University and other universities," he added. Mann further said, "We had brought that bill (Punjab Universities Laws (Amendment) Bill, 2023) in Vidhan Sabha. We had brought the SGPC Bill as well and that was also sent there (to the President). "It means if the governor does not want to pass bills (give his assent), he sends them to the President and then the President returns after four to five months. This is our democracy," he added. Punjab Universities Laws (Amendment) Bill, 2023 and three others bills were passed by the Punjab Assembly in the two-day session in June last year but the governor had called the session "patently illegal".

Some labourers working nearby had a narrow escape as they ran away when they realised that the frame was going to collapse, an official said. National Highway Executive Engineer Tanuj Kamboj said a part of the frame of under-construction bridge has collapsed. Being built at a cost of about Rs 67 crore under the Chardham

# 1 jawan injured in gunfight with terrorists in J&K's Doda: Sources

One Indian Army personnel was wounded in the encounter that broke out in Jaddan Bata village in Jammu and Kashmir's Doda district.

Jammu. One Army jawan has been injured as a gunfight erupted between security forces and terrorists in Jammu and Kashmir's Doda district, a source informed India Today. The encounter broke out in Jaddan Bata village in the Kastigarh area around 2 am. "There was a brief exchange of fire between the security forces and terrorists around midnight in the Kastigarh area of Doda district. No fresh firing this morning," the source stated. This came two days after four Army personnel, including an officer, were martyred while fighting against terrorists in the Doda district. Soon after this, a massive crackdown against the terror network was launched in the region on the intervening nights of Monday and Tuesday.

Captain Brijesh Thapa, Naik D. Rajesh, Sepoy Bijendra, and Sepoy Ajay laid down their lives in the line of duty.

On July 14, the Indian Army thwarted an infiltration attempt along the Line of Control (LoC) in Kupwara district, successfully killing three terrorists.

On July 6, six terrorists were gunned down by security forces in twin gunfights in Kulgam district, with two soldiers also losing their lives during the separate encounters. Most recently, on June 26 in Doda, three terrorists were killed in a gunfight with security forces. The confrontation occurred after the Army cordoned off a hideout containing four terrorists, leading to the deaths of three.

## Mumbai businessman jumps off Bandra-Worli Sea Link after video call to son

MUMBAI. After making a video call to his 22-year-old son on WhatsApp to inform him that he intended to end his life by jumping off the Bandra-Worli Sea Link (BWSL), a 56-year-old Ghatkopar businessman switched off his cellphone and took the extreme step around 3.15pm on Wednesday. Police suspect the deceased, Bhavesh Seth, might have been in financial distress. His body was found after a three-hour search operation carried out by the fire brigade.andra police said Seth requested a motorist at the BWSL toll plaza to drop him in south Mumbai, saying his car had broken down and he needed to reach his destination at the earliest."However, the deceased asked the motorist to stop on the sea link. He got out of the vehicle and then made a video call to his son, informing him that he was about to jump off the sea link," said DCP (Zone IX) Raj Tilak Roshan. The incident came to light after the deceased's son approached Bandra police at 4.30pm to inform them about the tragedy. Police corroborated his account after examining the closedcircuit television (CCTV) footage at the sea link and the toll plaza, which showed Seth getting into a car and alighting on the sea link.

'The motorist, after dropping Seth, kept driving on the southbound carriage, unaware that he had jumped off," said a Bandra police officer. Police suspect Seth, who was in the business of trading ball bearings, might have been facing a financial crisis and may have been depressed.

"Seth's son said his father had left their Ghatkopar home for his South Mumbai office without exhibiting any change in his behavior. He said the family was in shock," the

## HC tells 7 in way of soc redvpt to vacate or pay Rs 5L

MUMBAI. Observing that their conduct has put the entire redevelopment at risk, Bombay high court recently directed seven members of a housing society to pay Rs 5 lakh in all in costs if they do not vacate their flats in a building at Chakala, Andheri (East), within two weeks. "The docket of this court continues to be flooded with several such matters where minority members continue to attempt to stymie redevelopment on grounds which are ex facie frivolous, untenable, and contrary to Doctor said on July 1.DEM Homes LLP had filed a commercial arbitration petition to adjudicate the dispute between it and the

dissenting members. In Sept 2023, a redevelopment agreement was executed between the developer and Taruvel CHSL. In Oct 2023, a VJTI structural audit declared the building in the C1 (dilapidated) category. In March, after obtaining the IOD (intimation of disapproval), the developer asked residents to vacate. Initially, 76 out of 84 members vacated.As the dissenting members refused to vacate, the developer moved the high court. After that, one member vacated his flat.

the well-settled position in law," Justice Arif Advocates Sarosh Bharucha and Jay Vakil said grave prejudice is caused to the developer since it commenced paying hardship compensation, rent, brokerage,

and transportation charges to members who vacated their flats. The majority of them are senior citizens. Kapadia said the dissenting members had filed a suit in the city civil court challenging the redevelopment, but there is no stay.

Advocates Narayan Bubna and Pooja Malik, representing three members, said the developer was unwilling to fulfil its obligation as it had sought exemption from executing a permanent alternate accommodation agreement with dissenting members. But Justice Doctor said the contention is misconceived as Bharucha clarified the agreement will be executed with them and they will be treated



at par. Told that the trio would oppose the petition, Justice Doctor decided to grant costs incurred in the petition. The developer submitted Rs 48 lakh in costs and the CHSL, Rs 3 lakh. In his discretion, Justice Doctor directed that Rs 5 lakh be paid if the seven members do not vacate their flats within two weeks of the upload of the order. "In the event all or any of them do not, then costs shall be borne by those who do not," he said, directing it to be paid equally to the developer and members who vacated their flats. If the costs are not paid, the developer and CHSL may recover it as arrears

## MCG official rejects pet registration application, fined

GURGAON. The Haryana Right to Service Commission (HRSC) on Wednesday imposed a fine of Rs 5,000 on an MCG official for wrongly rejecting an application for pet registration though the applicant had provided all required documents and data.An HRSC spokesperson said the commission took cognisance of an appeal made by resident Devendra Singh Bhati.Bhati filed an application for a dog registration certificate on Antyodaya Saral portal on April 10 this year. His application was rejected on April 12.

When he asked MCG officials why the application was rejected, they told him to provide residential proof, which he did soon after. He was then told that his application was complete, but he got an e-mail later in the month saying that his application was rejected.HRSC chief commissioner TC Gupta looked into the complaint and found that Bhati had provided all necessary documents, but the chief medical officer rejected the application nonetheless. MCG's health department is responsible for pet registrations. The commission concluded that the corporation's CMO, Dr Ashish Singla, did not provide the service within the specified duration and wrongly rejected the application. It then ordered that Rs 5,000 be imposed as a fine and deducted from Singla's July salary.

### Expedite drain and sewer line cleaning, MCG officials told

GURGAON. In a meeting on Wednesday, MCG commissioner Narhari Singh Banger directed officials of the corporation to accelerate cleaning of storm-water drains and sewage lines, and spoke about the importance of better coordination among executive engineers of all divisions. He directed officials to

provide 10 manhole covers to each RWA in the city. 'The officers should ensure to provide the required machinery and equipment at the time of rains. It is crucial for officers to be present on the ground and



address any complaints of waterlogging that may rise. Sewage blockages should be given priority and should be resolved swiftly," said the commissioner.

MCG had begun cleaning and repairing storm water drains and sewage lines on June 1. The engineering wing was directed by the additional commissioner, Balpreet Singh, to complete the work by June 30.

## Kanwar yatra: DME to be out of bounds for cars from July

Ghaziabad. Private cars and other light goods vehicles from Delhi to Meerut will be diverted from the Delhi-Meerut Expressway (DME) through National Highway 9 and Hapur from July 27 to make way for kanwar pilgrims as the vatra starts next week.

Ghaziabad traffic department, which issued a three-phase diversion plan, said it will also stop the entry of all vehicles on the speedway from July 29. Trucks, buses or any other heavy vehicles will also be rerouted from July 22. The diversions will continue till 8 pm on Aug 5. Additional DCP (traffic) Piyush Singh said movement of all vehicles on Gangnahar Patri Kanwar Road and Pipeline Road, two stretches used by kanwar pilgrims every year to reach Haridwar in Uttarakhand, will be completely restricted."Also, movement of vehicles from Meerut trisection to Hindon riverside, Kanawani and Indirapuram will also be restricted. These vehicles will be rerouted via the old bus stand, Chaudhary Mod, Vijaynagar railway overbridge and NH-9 to reach their destinations," the officer said. Vehicles travelling from Mohannagar, Meerut trisection, Rajnagar Extension and Hapur Chugi towards Meerut through the NH-34 will move through a single lane till July 29. Thereafter, vehicular movement on the route will be restricted till Aug 5.According to the travel advisory, vehicles travelling from Palwal and Kundli via the Eastern Peripheral Expressway (EPE) will not be permitted to move towards the main city areas, Muradnagar and Modinagar from the Duhai intersection from July 29. Instead, these vehicles will be rerouted to NH9 from the intersection. Till July 29, vehicles travelling from Meerut trisection towards Mohanagar or Seemapuri border will use a single lane of the Meerut Road. Thereafter, the route will be closed for vehicular

The signals can function for up to eight hours on a single charge and come equipped with a remote-control system for distant operation by traffic police. ## Two real-time noise monitoring stations set up in Faridabad, a first for Haryana

GURGAON: Amid growing concerns over rising noise pollution levels, Haryana State Pollution Control Board (HSPCB) has set up the state's first two real-time noise level monitoring stations in Faridabad. Linked to a centralised network, these stations will monitor noise levels 24X7. Focused on residential and silent zones at present, the board plans to add two more monitors for commercial and industrial areas next month. The initiative, mirroring the air monitoring stations, will eventually be extended across the state. The data from these stations will help the state come up with an action plan to mitigate noise pollution. The two operational stations are in Sector 16A (residential area) and ESI medical college (silent zone). The two new stations will be set up at Sector 69 (industrial area) and BK Chowk."We installed two noise monitoring stations earlier this month and two more will be installed soon. We will eventually expand it to all districts. We will analyse the data and prepare strategies on its basis. The stations have been set up first in Faridabad as a pilot project," HSPCB senior environmental engineer JP Singh said."This new project will aid our department in preparing a database, identifying major sources of noise pollution, and taking adequate action," said another official. Faridabad is the sole Haryana district on the list of 'nonattainment cities' under the National Clean Air Programme (NCAP), implying that its air failed to meet the national ambient air quality standards from 2011 to 2015. So, it was decided to set up noise monitors there to ensure that, in conjunction with air pollution, noise pollution is also monitored for analysis and formulation of a

## Gurgaon: Nod given years ago, but Rs 140 crore infra projects made little headway

GURGAON. MCG has made little headway on four development projects, altogether estimated to cost over Rs 140 crore, despite receiving approval for them years ago.

One of the projects, a Rs 19.5-crore community centre in Sector 12A, was given administrative approval in June 2022. But only 10% of the work is complete till now, with officials citing design changes as the reason for the delay. Till now, however, a mere 5% of the work has been completed. #### Dinosaur skeleton sells for record \$44.6 million at New York auction

New York. The largest stegosaurus skeleton ever found, nicknamed Apex, sold for a record breaking \$44.6 million at auction in New York on Wednesday, Sotheby's said. Estimated to be 150 million years old, Apex is said to be "among the most complete skeletons ever found," according to the auction house.t measures 11 feet (3.3 meters) tall and 27 feet long and counts 254 fossil bone elements of an approximate total of 319. The previous auction record of \$31.8 million for a dinosaur skeleton was set in 2020 for a Tyrannosaurus Rex nicknamed

Sotheby's had expected Apex to fetch between \$4 million and \$6 million, but the price quickly skyrocketed as telephone bidders deluged the sale, prompting gasps and clapping in the auction room. After the record-breaking sale, the auctioneer asked her colleague Cassandra Hatton, Sotheby's global head of science, "do you need a cigarette?"Apex was discovered in May 2022 on the private land of paleontologist Jason Cooper. The auction house says it has collaborated with Cooper to "document the entire process, from discovery and excavation to restoration, preparation and mounting," in order to guarantee the "highest standards and transparency."

In 2022, Christie's auction house had to withdraw a T-rex skeleton a few days before auction in Hong Kong, due to doubts about its authenticity. Wednesday's auction follows an increasing trend for the sale of dinosaur remains.Stegosaurus skeletons are already on display around the world, but according to Sotheby's, Apex is 30 percent larger than Sophie, the most complete stegosaurus on public display to date, which is housed in the Natural History Museum in London.

### US military to end Gaza aid pier, declaring 'mission complete'

Washington The US military announced on Wednesday that its mission to install and operate a temporary, floating pier off the coast of Gaza was complete, formally ending an extraordinary but troubled effort to bring humanitarian aid to Palestinians. The pier, announced by President Joe Biden during a televised address to Congress in March, was a massive endeavor that took about 1,000 US forces to execute. Aid began flowing via the pier to Gaza in May, an operation aimed at helping avert famine after months of war between Israel and Hamas.ut bad weather and distribution challenges inside Gaza limited the effectiveness of what the U.S. military says was its biggest aid delivery effort ever in the Middle East. The pier was only operational for about 20 days. The maritime surge mission involving the pier is complete. So there's no more need to use the pier," Navy Vice Admiral Brad Cooper, the deputy commander of US Central Command, told a news briefing

ooper said efforts to distribute aid to Gaza arriving by sea would now shift to the established port of Ashdod in Israel. At least 5 million pounds of aid, which are either in Cyprus or on ships, will be going to Ashdod in the coming days, he said."Our assessment is that the temporary pier has achieved its intended effect to surge a very high volume of aid into Gaza and ensure that aid reaches the civilians in Gaza in a quick manner," Cooper said, adding that nearly 20 million pounds of aid was delivered to Gaza. The pier became a sore point in Congress, where Republicans branded it a political stunt by Biden, who was under pressure from fellow Democrats to do more to aid Palestinians after months of staunchly supporting Israel's punishing war on Hamas. This chapter might be over in President Biden's mind, but the national embarrassment that this project has caused is not. The only miracle is that this doomedfrom-the-start operation did not cost any American lives," Senator Roger Wicker, the top Republican on the Senate Armed Services Committee, said.

Cooper said he expected the pier, which was authorized to be used until the end of July, to cost less than the \$230 million the Pentagon had expected it to cost.

Cooper said the United States had so far delivered more than 1 million pounds of aid through Ashdod and he was confident more could be delivered through that port.

### Biden Says He Would Reevaluate Presidential Bid If Serious Medical **Condition Emerged**

Washington D.C., U.S. President Joe Biden said in an interview released Wednesday that he would reassess his decision to remain in the presidential race if a doctor informed him of a medical condition that necessitated withdrawal. The 81-year-old Democrat tested positive for Covid with mild symptoms shortly after his remarks were made public. Biden gave reporters the thumbs up and said "I feel good" as he cut short a campaign trip to Las Vegas and flew to his beach home in Delaware to go into isolation, The New York Times reported. Biden has repeatedly said that no doctor has diagnosed him with a serious medical condition. After a physical examination in February, White House physician Dr. Kevin O'Connor described Biden as "a healthy, active, robust 81-yearold male." After testing positive for covid, Biden thanked well-wishers on X, adding "I will be isolating as I recover, and during this time I will continue to work to get the job done for the American people.' The infection comes at a critical moment for Biden's campaign, after a disastrous debate performance against rival Donald Trump sparked concerns about his health and calls from some Democrats for him to step aside It is also the latest development in a tumultuous few days in an already frenetic White House race that saw his Republican Trump survive an assassination attempt at a campaign rally of his own.

## Severe storm causes flooding in Toronto, tornado hits New York

severe storms pummeled a wide swath of the United States and Canada, leading to flash floods and water rescues Wednesday in the Ozark Mountains, dropping a tornado that ravaged a community in upstate New York and stranding drivers in high water around Toronto. The relentless series of storms has caused deaths or damage from the Plains to New England this week. Hundreds of thousands of people have lost power and air conditioning during days of sweltering heat. As much as 11 inches (nearly 28 centimeters) of rain fell overnight into Wednesday on parts of the Ozarks in Arkansas and Missouri, the National Weather Service said. Buses and ambulances evacuated 86 people from a nursing home in Yellville, Arkansas, where water rose to about 4 feet (1.2 meters) during flash flooding, Marion County Sheriff Gregg Alexander said. A section of a bridge washed out and a historic courthouse flooded

Cities across upstate New York were

Tuesday with high winds and spectacular lightning and flying debris that killed one person.In the small city of Rome, New York, a tornado ripped off roofs, tipped over vehicles and turned several buildings into piles of rubble. Steeples crumbled and roofs were torn apart at First Presbyterian Church and the St. Mary's Church, both built in the 1800s. Copper sheets from the roof of First Presbyterian were found wrapped around utility poles a quarter mile away.he winds were fierce enough to move a multi-ton tourist attraction, a B-52 bomber displayed at Griffiss Business and Technology Park. A mural of a Revolutionary War figure on horseback - a Rome landmark — was destroyed, along with the building on which it was painted. All that remained was an image of a horse hoof. Speaking outside St. Mary's, Gov. Kathy Hochul said it was "miraculous" no one was killed in the city of 31,000. She toured the downtown Wednesday and said 22 buildings were damaged or destroyed. She described seeing trees "collapsed like toothpicks'

### Germany to slash its military aid to Ukraine by half in 2025: Report

Berlin Germany plans to halve its military aid to Ukraine next year, despite concerns that US support for Kyiv could potentially diminish if Republican candidate Donald Trump returns to the White House.German aid to Ukraine will be cut to 4 billion euros (\$4.35 billion) in 2025 from around 8 billion euros in 2024, according to a draft of the 2025 budget seen by Reuters.

Germany hopes Ukraine will be able to meet the bulk of its military needs with the \$50 billion in loans from the proceeds of frozen Russian assets approved by the Group of Seven, and that funds earmarked for armaments will not be fully used."Ukraine's financing is secured for the foreseeable future thanks to European instruments and the G7 loans," German Finance Minister Christian Lindner said on Wednesday at a news conference ashington pushed to "front load" the loans to give Ukraine a big lump sum now.Officials say EU leaders agreed to the idea in part because it reduces the chance of Ukraine being short of funds if Trump returns to the White House. Alarm bells rang across Europe this week after Trump picked Senator JD Vance, who opposes military aid for Ukraine and warned Europe will have to rely less on the United States to defend the continent, as his candidate for vice president.Trump sparked fierce criticism from Western officials for suggesting he would not protect countries that failed to meet the transatlantic military alliance's defence spending targets and would even encourage Russia to attack them.ermany has faced criticism for repeatedly missing a NATO target of spending 2 per cent of its economic output on defence.

The stocks of Germany's armed forces, already run down by decades of underinvestment, have been further depleted by arms supplies to Kyiv.

## Secret Service chief to testify to US congressional panel on Trump shooting

Washington Secret Service Director Kimberly Cheatle has agreed to testify before the US House of Representatives Oversight Committee on July 22 for a hearing related to the shooting of former President Donald Trump at a rally, the panel said on Wednesday. Security at the Republican presidential candidate's rally in Pennsylvania has been under scrutiny after the former KEYQUOTES event. The FBI said it was probing the shooting as an assassination attempt. The shooting has raised serious concerns about how the suspect was able to access a nearby

rooftop with a direct line of sight to where Trump was speaking. Trump has since said he was doing well and has appeared at the Republican National Convention this week but the shooting left his face streaked with blood after his right ear was hit. A rally attendee was killed in the shooting, two others were wounded and the suspect is dead.

## Donald Trump's aide calls on Taiwan to boost defence spending

Milwaukee A top national security adviser to Donald Trump said on Wednesday that Taiwan needs to boost its defence spending significantly in the face of potential Chinese aggression.

The comments by Robert O'Brien, Trump's fourth and final national security adviser, follow remarks by the former president in which he said Taiwan should pay the United States for its defence. Speaking to Bloomberg Businessweek in a June 25 interview published on Tuesday, Trump said: "I know the people very well, respect them greatly. They did take about 100 per cent of our chip business. I think Taiwan should pay us for defence."

O'Brien, asked about Trump's comment at a Bloomberg Roundtable on the sidelines of the Republican National Convention in Milwaukee, said he believed Trump meant to indicate Taiwan should contribute more to its own defense.

'They've got to ramp up their spending to contend with the PRC and CCP, and we can help them, we can be part of that. But I think what President Trump is saying is ... we've got to have burden sharing." O'Brien told reporters, referring to the People's Republic of China and the ruling Chinese Communist Party.

He suggested Taiwan should consider spending at least 5 per cent of its gross domestic product on its military to keep up with China, though he implied that figure was a rough estimate.

Taipei announced a defence budget for 2024 of about \$19.1 billion.But the island's overall level of spending still pales in comparison to China's massive outlays and the historic build-up of the People's Liberation Army, which dwarfs Taiwan's forces. In March, Beijing unveiled an annual defence budget of some \$230 billion, a 7.2% increase on the year

before, though analysts say actual spending is likely much greater. The Democratic ranking member of the US House of Representatives' bipartisan select committee on China, Raja Krishnamoorthi, called Trump's comments a betrayal."Failing to provide for Taiwan's defence would not only be potentially illegal under the Taiwan Relations Act, it would be a betrayal of American values and our democratic institutions," he said in a statement. ## Strays maul toddler to death at Jawaharnagar in Telangana

HYDERABAD. In a gruesome incident, an 18-month-old toddler, Vihaan, was mauled to death by a pack of stray dogs in Adarshnagar of Jawaharnagar on the outskirts of Hyderabad late on Tuesday. He sustained multiple injuries on his head, limbs and other body parts and was rushed to a hospital where he succumbed to his injuries.CM A Revanth Reddy expressed grief over the boy's death and directed officials to take immediate measures to prevent such incidents in the future. He also ordered officials to establish a call centre or toll-free number for citizens to report stray dog-related incidents and ensure swift action. According to the preliminary inquiry by the Jawaharnagar police, Vihaan was playing outside his house when the stray dogs dragged him a few metres away. The child's parents, Bharat and Lakshmi, who hail from Siddipet district, found the body with the help of locals who had scared the dogs away.He was first rushed to a private hospital, where doctors advised them to take him to Gandhi Hospital for better treatment. The incident is one more in a growing list of attacks by stray dogs in Hyderabad and its suburbs, with children and adults being either mauled to death or seriously injured. Residents have expressed outrage over the attacks, accusing the state government of inaction. Despite multiple complaints lodged with



the civic body, no action has been taken. Vihaan's death triggered a protest led by his parents at the Jawahar Nagar municipal office. The protesters demanded compensation for the parents.

The family had moved to Jawaharnagar a few months ago. Following a complaint from the boy's parents, a case was booked under Section 194 (suspicious death) by the Jawahar Nagar police.

Meanwhile, the chief minister directed the officials to take comprehensive measures to address the stray dog menace. He told them to set up an expert committee with representatives from voluntary organisations, veterinarians and Blue Cross to study the factors contributing to

As there were technical glitches and other challenges, the deadline will now be extended by a few more months, he added.As per BBMP, the census is fully done in Hanumantha Nagar, Srinagar, Gali Anjaneya Temple, Girinagar, Kathriguppe, Vidyapeeta and two other wards. These wards have over 30,000 trees in all. The agencies have painted the code on each tree and uploaded it on the website.Jeevan, one of the two contractors, said, "Along with another agency, we have taken up the census work. The work was affected because of a software issue and fixing it took four months. When we deployed a team of botanists



and others to resume the work, some of them collapsed because of severe heat in March and April. We had to stop the work then. Now due to rain, painting codes on trees is a challenge. We expect the civic agency to extend the deadline."

## Maharashtra firm fined Rs 1 lakh for 'spiking' protein

powder & false claims

MUMBAI. Observing the recent spate of deaths across India attributed to the consumption of substandard health supplements or nutraceutical products, a consumer commission has directed a nutritional supplement firm to pay a Powai-based fitness enthusiast Rs 1.1 lakh who discovered that the Rs 1,599 protein powder he had bought from them online last year contained harmful ingredients.It deemed as unacceptable the endeavour of the company, Big Muscles Nutrition Pvt Ltd, to artificially inflate the protein content of the product by incorporating unidentified amino acids. Moreover, the product exhibited high levels of sugar and carbohydrates. "...disparity in the contents of the product as brought on record through the lab testing of the said product definitely a cause of concern and adverse effects cannot be ruled out altogether," the commission said. The complainant, Rahul Shekhawat, had



conducted tests at a reputable laboratory after coming across online reviews criticising the product. The commission ordered the company to reimburse the Rs 36,409 he had incurred for the tests and the product."Studies show that consumption of such a protein-spiked powder can lead to short-term side effects, such as headaches, acne, bloating, nausea and diarrhoea... Prolonged consumption... can lead to long-term side effects, like heart issues and liver damage," it said. The commission said laboratory reports had showed that the brand's label had made numerous false claims about the product's ingredients, particularly regarding the nature of the protein content. ...Making false claim of the content of the product sold to the customer, which can adversely affect the heath of the customer, is definitely a deficiency in service and despite the knowledge that proteinspiking is misleading to consumers, the opposite parties (company) continue to advertise, distribute, label, manufacture, market and sell the product in a misleading and deceptive manner," it said.

Shekhawat had filed the complaint in 2023, raising concerns about misleading labelling, in addition to allegations of protein content spiking.

## Beware of brain-eating amoeba, avoid freshwater activities: Doctors

BENGALURU. With Kerala reporting its fourth fatality due to a rare 'brain-eating amoeba' infection recently, experts, terming the condition as 'usually fatal,' have cautioned against engaging in water

activities in warm freshwater and diving deep into swimming pools, while emphasising the importance of proper chlorination of pools. Experts reiterated that even with treatment, the condition could prove fatal, with coma and death typically occurring within a week to ten days after symptoms set in. The brain-

eating amoeba, scientifically known as Naegleria

fowleri, is a free-living amoeba typically found in warm freshwater environments such as lakes, rivers, and hot springs. It can cause Primary Amebic Meningoencephalitis (PAM), a severe infection of the central nervous system. Dr Vikas Naik, Consultant in Neurosurgery at Fortis Hospital, highlighted that the infection is alarming because it the central nervous system through the nos Once inside, it travels to the brain, causing a rare and deadly illness, PAM.Dr Naik added that PAM results in rapid inflammation and tissue damage, leading to symptoms such as fever, hallucinations, and seizures. treatments, PAM is 'almost always fatal.'Dr Swati Rajagopal, Consultant in Infectious Disease and Travel Medicine at Aster CMI Hospital, stressed that the infection occurs when contaminated water enters the nose and travels to the brain, which can also happen with hot tap water or poorly chlorinated swimming pool water.Dr Swati added that symptoms of PAM usually appear within one to nine days after exposure and progress rapidly. "Early symptoms include severe headache, fever, nausea, vomiting, and a stiff neck, followed by confusion, loss of hallucinations and notentially leading to coma," she highlighted. While PAM is almost always fatal, with very few survivors, in suspected cases, doctors may recommend a brain biopsy to detect the presence of the amoeba and determine appropriate treatment, she said.

## Chennai man arrested for stabbing nineday-old daughter to death with scissors

CHENNAI: A 38-year-old man was arrested by the Vyasarpadi police on Wednesday for allegedly stabbing to death his nine-day-old daughter with a pair of scissors. The police said that the man was upset that his third child, born on June 29, was a girl. He already has two daughters aged four and two-and-a-half. According to the police, the arrested man was identified as Rajkumar (38), a daily



wage labourer. On July 7, Rajkumar told his wife that their newborn child had developed a medical complication and her intestine had burst. The child was taken to a government hospital. The child died

After a postmortem, the body was handed over to the parents. However, the postmortem report said that the injury suffered by the child was caused by a sharp object. The police and the district child welfare officials were alerted. The police conducted an inquiry, during which Rajkumar reportedly confessed to stabbing the child.

## Renowned cardiologist Dr MS Valiathan passes away

THIRUVANANTHAPURAM. Dr. M S Valiathan, a renowned cardiac surgeon and academic, passed away in Manipal on the night of July 17. He was 90. He played a pivotal role in founding the Sree Chitra Tirunal Institute of Medical Science, serving as its inaugural director. Under his leadership, the institute swiftly became a hub for treating cardiovascular and neurologic ailments and embarked on developing advanced cardiovascular devices.Dr. Valiathan's pioneering work in creating medical innovations such as the disposable blood bag and the tilting disc heart valve significantly contributed to India's medical device sector, making treatments more affordable for patients. He set up Sree Chitra Tirunal Institute of Medical Science in two years on the invitation of the then Chief Minister Achutha Menon. As Sree Chitra Institute grew, it received support from Prime Minister Morarji Desai and was notified as "An Institution of National Importance" by an Act of Parliament within five years of Dr. Valiathan's leadership. He later served as the first Vice-Chancellor of Manipal Academy of Higher Education (MAHE) from 1993 to 1999.Belonging to the first batch of Government Medical College Thiruvananthapuram, he held fellowships from the Royal College of Surgeons of Edinburgh, England, and Canada. He was the former chairperson of Indian Academy of Sciences. Valiathan received numerous accolades throughout his career, including the Padma Vibhushan (2005), the Padma Shri (2002), the Dr. B. C. Roy National Award, the Hunterian Professorship of the Royal College of Surgeons of England, the Chevalier of the Order of Palmes Académiques from the French Government, the Dr. Samuel P. Asper Award for International Medical Education from Johns Hopkins University, and the Lifetime Achievement Award from the Indian Medical Association. ## Jalasamrudhi: A model of water conservation success in Kerala

THIRUVANANTHAPURAM. Amid Kerala's escalating climate challenges and dwindling groundwater reserves, micro-level initiative 'Jalasamrudhi' has emerged as a beacon of success in the Kattakada assembly constituency. Implemented over the past seven years, this community-based conservation programme has not only halted the acute water scarcity the people of the locality have been facing for the past two decades but also significantly replenished groundwater levels.Initiated by MLA I B Satheesh after his election to the assembly in 2016, Jalasamrudhi represents a unique blend of local planning and governmental cooperation, catalysing a transformative movement. The project officially commenced in 2017 and has since become a cornerstone of sustainable development in the region. According to a comprehensive study by Gautam Ganapathy and Salil C S titled



'Bureaucracy, Sustainable Development and Decentralisation: Reflections on Jalasamrudhi, a Communitybased Water Conservation Programme in Kerala', groundwater availability in Kattakada has surged from 1,355 million cubic metres (mcm) to 4,908.68 mcm between 2017 and 2019. "As many as 314 ponds and more than 43,000 wells in the area were cleaned as part of the initiative.In addition, more than 300 farm ponds were dug up. Recharging structures set up in government institutions and schools also helped improve

According to the Kerala Land Use Board, a fourfold increase in groundwater recharge during monsoons was seen in the Nemom block compared to other blocks in Thiruvananthapuram district," the study says.Reflecting on the genesis of Jalasamrudhi, Satheesh highlighted the community's pivotal role in its success. During the 2016 election campaign, I witnessed firsthand the water crisis plaguing our constituency. I made a commitment to the people to find a solution," he told TNIE.

## The sacrifice of Capt Thapa can't go waste

YET another piece of tragic news has come from the Jammu region. Capt Brijesh Thapa and three other brave soldiers made the ultimate sacrifice, laying down their lives in the line of duty during counter-terror operations in the dense Desa forest of Doda district. This incident comes just a week after another grievous attack in which five soldiers were killed when their vehicle was ambushed near Badnota village in Kathua district. The once relatively calm districts of Poonch and Rajouri have witnessed a disturbing spike in terror incidents over the past two years. Now, terrorist groups are operating in areas like Reasi, Kathua and Doda, long considered militancy-free. This has resulted in the emergence of flashpoints across the entire breadth of the Jammu division, indicating a deliberate plan by terrorists to shift their focus to this region. Groups of well-trained terrorists, armed with sophisticated weapons, have managed to infiltrate across the international border in Jammu, and there are strong suspicions that infiltrations have occurred across the Punjab border as well. The J&K Director General of Police, RR Swain, has acknowledged this issue, admitting that "some infiltration is taking place; it is common knowledge". Addressing terrorism in Jammu and Kashmir involves two primary facets. The first is to deter Pakistan from using terrorists as an instrument of state policy against India. Achieving this deterrence will require continuous and credible use of India's national power to demonstrate that Pakistan's policies will ultimately harm itself. This is a long-term effort that involves diplomatic, economic and possibly military measures. The second facet is to actively stamp out terrorist activities on Indian soil. While setbacks are normal in counter-terrorism operations, a consistent pattern of attacks resulting in the loss of lives of soldiers and civilians, with no apparent damage to the terrorists, raises serious questions about the strategy and tactics employed by the security forces. It is essential for military leadership to review their methodology, and based on my own experience, I have several suggestions.

The counter-infiltration mechanism along the international border and the Line of Control should be strengthened. This may require the induction of additional forces, wherever necessary. However, it is crucial to recognise the limits of human endurance. Operating around the clock for months can lead to fatigue, causing attention to flag and increasing the likelihood of mistakes. To mitigate this, technology must play a more significant role. For over a decade, there has been talk about installing a 'smart fence' along our borders, but the implementation has been inconsistent. Rather than waiting for a perfect solution through countless trials, we should adopt a fence that offers better protection than what we currently have. Additionally, we need to find a technical solution to detect tunnels reportedly being dug across the border. The Special Forces (SF) should be given greater responsibility in counter-terrorism operations. These are our besttrained soldiers, ideally suited to operate in small teams within the mountainous and forested terrains where terrorists often find shelter. By bringing in additional SF units and granting them the freedom to operate in specified areas, we can increase the effectiveness of our operations.Intelligence is the backbone of successful operations, and human intelligence is often the most reliable. An extensive outreach to local communities can help expand our intelligence network. Although there may be some locals who support terrorists, the vast majority of Jammu's population is highly nationalistic. Therefore, treating locals with suspicion can be counterproductive. Instead, we should recruit more Special Police Officers and increase the number of Village Defence Guards from the local population. These individuals will serve as our eyes and ears, providing the first line of defence against terrorists. With more intelligence flowing in, the SF can conduct effective 'seek and destroy operations.aCurrently, there is a plethora of organisations operating in the region. The Border Security Force (BSF) handles the international border, the Central Reserve Police Force (CRPF) protects roads in the hinterland, the UT police force manages local law enforcement and the Army conducts broader counter-terrorism operations.

## Revisit economic policy to boost growth

The policy regime in India continues to draw heavily from the Western experience of economic transition.

THE Indian economy has experienced fast changes in the post-reforms period. The size of the economy has increased manifold. This has been accompanied by changes in the sectoral share in the gross domestic product (GDP) or income and the share of various sectors in employment of the workforce. There has been an increase in the share of the secondary and services sectors, while the

agriculture sector has suffered a loss both in terms of the share in income and employment. This has resulted in economic stress on the workforce and households engaged in agriculture and allied activities. The gross national product/GDP of India has grown 13 times in terms of the purchasing power parity of the rupee to the dollar between 1991 and 2023. In terms of the prevailing exchange rate, it rose nearly 14-fold during this period. The per capita income surged from \$304 in 1991, when policy changes were introduced, to \$2,484.8 in 2023. According to the National Sample Survey Office, agriculture and

allied activities employed 63.84 per cent of the total workforce in 1993-94 compared to the 25.01 per cent engaged in manufacturing, including construction. The share of services in employment was 21.16 per cent. This has changed over time. According to the Periodic Labour Force Survey 2021-22, the share of agriculture and allied activities in employment has dipped to 45.4 per cent, a decline of 18.44 percentage points. The share of the manufacturing sector has increased to 29.6 per cent. This gain is mainly contributed by construction activities, which now account for 15 per cent of the total employment in the country.

The share of the industry, both in employment and income, is not picking up as fast as required. The share of services in employment has increased to 31 per cent. This is further reflected in changes in the share of the GDP. The share of agriculture and allied activities in the income declined from 30.01 to 18.4 per cent between 1993-94 and 2021-22. This shows that now, more than 45 per cent of the population has just 18.4 per cent of the income, while 29.6 per cent of the workforce in manufacturing gets 28.3 per cent of the income and 31 per cent of the workforce in the services sector corners 53.3 per cent of the GDP.

It is obvious that the people engaged in agriculture are earning a very low income. This is reflected in the form of indebtedness and poverty leading to a high

rate of suicide by farmers and agricultural labourers. There is an urge among the youth — largely children of farmers and agricultural labourers — to look for employment in manufacturing and services. When the rural youth turn to non-agricultural activities or employment, they get low wages and poor-quality



jobs in the unorganised sector. Employment in the organised sector is skill-intensive, but it is expanding at a very slow pace. The India Employment Report 2024 by the International Labour Organisation and New Delhi-based Institute for Human Development brings out that unemployment among educated youths is nearly 21.84 per cent in the country. The figure is much higher among educated young women.

The increasing use of automation and precision technology in industry and construction work and artificial intelligence in services is not allowing the creation of jobs in proportion to the investment in these dynamic sectors. The economic transition in India is happening under conditions different from those in advanced countries. When these countries made the transition from agrarian to industrial and then to service economies, there was a massive rise in employment in non-agricultural sectors.

India had entered jobless growth in 2003-04, and now we are facing job-loss growth. This means that while income and investment are growing, jobs are shrinking. It is very difficult to provide gainful and better-quality jobs to the workforce released from agriculture because of the fast process of mechanisation and modernisation. This is the reason that the country is unable to reap the demographic dividend of its young population. This is accompanied by the fast-growing concentration of income and wealth in a few hands. There are many reports by independent agencies supported by official data that bring out that less than 1 per cent of the population annually receives more than 40 per cent of the GDP. This small section of the population has come to acquire more than 40.9 per cent of the

wealth of this country, while the bottom 50 per

cent of the population has only 5.9 per cent. Along with inequality in the distribution of income, regional inequality in the development process is getting sharpened. All this has created structural difficulties, which demand the immediate attention of policymakers. These difficulties are not recognised; hence, the policy response is missing. The policy regime in India continues to draw heavily from the Western experience of economic transition. This line of thinking has powerful support from Bretton Woods institutions like the World Bank and the International Monetary Fund. It intends to achieve this transition through liberalisation, privatisation and globalisation. This resulted in the abandonment of the employment policy when the country launched economic reforms in 1991. The youth are being left to suffer unemployment on a massive scale and face humiliation. The policy regime has moved swiftly to make the employment quality poor. This is reflected in the labour codes that not only allow employers to hire and fire but also allow working hours beyond eight hours without pay for overtime. Most of the jobs are on a contractual or temporary basis, without retirement benefits. This has led to the flourishing of the gig economy, devoid of any social protection. The whole policy response is to promote corporates without enforcing the norms of a decent livelihood for the workforce. The policy regime is not rooted in the ground reality — this can be called a policy distortion. Our policy regime must have a strong component of inclusiveness. Policy distortion has created unrest among the youth. This is a situation of a 'million mutinies', to use a term coined by Nobel


laureate VS Naipaul. The presence of latent and

open discontent has the potential to derail the

development process and tear our social fabric apart. This doesn't fit into the rising aspirations of the country to come out of the middle-income trap and join the ranks of developed countries. It is the right time for the government to have a relook at its economic policy and do course correction.s

## No let-up in J&K terror

Counter-insurgency mechanism must be reviewed



The epicentre of militant activity has shifted in recent years to Jammu from the Kashmir valley - and drastically so over the past month or so. Despite the emergence of this clear pattern, the Army, the police and the Central Armed Police Forces are struggling to counter the foreign terrorists who are infiltrating from across the border. This points to lapses on the intelligence



front, besides possible gaps in coordination among various agencies. It is apparent that militants are

exploiting these chinks to cause mayhem week after week.

The spotlight is on the usual suspect, Pakistan, which continues to pursue its strategy of bleeding India with a thousand cuts amid its own economic and political problems. While New Delhi must up the ante against Islamabad in the international arena, the entire counter-terror mechanism has to be urgently reviewed. The security forces must regain the element of surprise to turn the tables on the terrorists. At the same time, all stakeholders need to exercise restraint for the sake of peace. The J&K DGP has struck a discordant note by accusing mainstream regional parties of cultivating leaders of terror networks for political gains. The blame game will not only undermine the supreme sacrifice of soldiers but also

embolden Pakistan to further its nefarious agenda.

## Indo-Pacific at the core of NATO's strategic realignment

Strategic partnerships between the IP4 and NATO will revolve around maintaining deterrence and a rules-based order in the region and having stable ties with the West.

THE just-concluded NATO summit in Washington marked the alliance's 75th anniversary. With its historical context, this milestone summit has raised significant hopes and aspirations for extensive engagement amid the complex issues that have emerged in the past two years. Discussions revolved around the allies' collective support for Ukraine and defence expenditure, a divisive and thorny subject. However, members also discussed an issue of considerable importance to India — NATO's

strategic pivot towards the Indo-Pacific. The Indo-Pacific region is crucial for global economic growth, technological innovation and geopolitical activity. With over half of the world's population and significant global trade passing through its waters, the region's stability is paramount to international security. As threats evolve, NATO's focus, traditionally on Europe and North America, is also shifting, recognising the importance of the Indo-Pacific.It began with NATO's engagement with Australia, Japan, South Korea and New Zealand, collectively known as the Indo-Pacific Four (IP4). NATO has been collaborating with these nations since the early 2000s. However, conflict between Russia and Ukraine, security threats from China and a resurgence in global strategic contention have intensified these partnerships. As the Russia-Ukraine conflict continues and the US-China competition remains fierce, NATO can significantly enhance its strategic position through cooperation between its allies and partners in the Euro-Atlantic and Indo-Pacific regions. The IP4 group, an informal yet powerful alliance, is expected to remain a key NATO mechanism for addressing mutual interests in the foreseeable future. This alliance enables NATO to unite its member states with like-minded partners formalised regional partnerships, the IP4 is more unofficial. With its inherent flexibility and the reduced risk of China reacting negatively to what it might perceive as an Asia-Pacific NATO, this informality brings unique benefits to the alliance. The NATO summit saw the continuing involvement of Indo-Pacific partners, underscoring the importance of their cooperation in addressing shared security challenges. Focus areas include cyber defence, technological advancements and the security implications of climate change. The collaboration extends to countering hybrid threats and bolstering maritime security. NATO is expanding defence industrial cooperation with Indo-Pacific partners, aiming to leverage the production capacities of countries like Japan, South Korea, Australia and New Zealand to manage challenges posed by strategic competitors effectively. Additionally, four new flagship projects were identified for collaboration, encompassing support for Ukraine, enhanced cooperation on cyber defence, exchanging information on challenges posed by disinformation and engaging in expert discussions on artificial intelligence.NATO and its allies recognise the importance of placing the conflict in Ukraine within a global context. Since early 2022 NATO has acknowledged Europe's historical role as the centre of global power dynamics and the Indo-Pacific as the primary arena for competition. The recent NATO meetings in Madrid and Vilnius signalled a shift in focus to recognise Europe's increasing interconnectedness with global strategic dynamics. However, embracing a more global perspective faces significant challenges, with many European allies advocating for maintaining NATO's

focus on safeguarding the Euro-Atlantic region. from the Indo-Pacific region. Unlike NATO's NATO's Indo-Pacific partners prefer the alliance to



concentrate more on Asia independently. Concerns about the perception of NATO's expansion into the Indo-Pacific, driven primarily by China, highlight diplomatic sensitivities and strategic perceptions. NATO is carefully working to enhance cooperation in the Indo-Pacific, considering historical and geopolitical factors. The focus is on cybersecurity, climate security and the need to address power competition and strengthen deterrence capabilities. As the NATO summit concluded in Washington, the

alliance iterated the need to integrate its Indo-Pacific partnership agenda with the alliance's core mission: reinforcing deterrence against significant power revisionism. The growing interdependence between NATO and IP4 is due to two critical aspects. First, IP4 nations provide NATO with a dynamic defence industrial base. As the Russia-Ukraine war drags on, NATO's Euro-Atlantic allies are on the verge of depleting their cache of weapons and other military equipment. The IP4 allows NATO to develop batches of weapons and military equipment to keep the Russia-Ukraine conflict going, thus allowing their Euro-Atlantic allies to catch on. For instance. Australia has stated in its 2024 Defence Strategic Review that it aims to develop domestic missile manufacturing capabilities. Along with Pillar II of AUKUS, NATO is provided with the development of an Indo-Pacific military-industrial complex. Second, the foreign policy outlook of the IP4 is more pro-West. The IP4 has an inclusive approach to the Indo-Pacific and international security, and their reservations for decoupling from China are in tune with the preferences

of their European allies.

And yet, there are limitations to what NATO can do in the Indo-Pacific. Creating an Indo-Pacific military complex will only cause regional destabilisation, leading to China seeing NATO as a threat to its Asian sphere of influence. Also, there is a lack of consensus between the IP4 and NATO regarding China. Additionally, non-NATO nations are suspicious of NATO influence in the region as, for decades, it has only been concerned with the security of the Euro-Atlantic. These uncertainties will emerge as an obstacle to further strengthening the relations between NATO and the IP4 regarding the challenges pertaining to the Indo-Pacific. Thus, even though NATO aims to use the Indo-Pacific for arms development and procurement, strategic partnerships between the IP4 and NATO will revolve around maintaining deterrence and a rules-based order in the region and having stable relations with and are seeking out help. any drastic step. "We cajole the caller to share his/her problem in detail and vent out their bottled emotions. Once that is done its easier to address the issue and offer solutions," he added.

Many psychologists and doctors believe that suicide is a mere trigger reaction to unaddressed issues that have been piling on. Citybased psychologist, Dr Himani Chaphekar, who treats 8-10 depression patients every month, said, "Stress levels have gone up right from school level which continues well into the old age. Excessive another expectations to excel, societal pressures and being unsatisfied with what you have are the factors

that contribute largely to depression." Commenting on the fact that Indians do not take their mental health very seriously and are sceptical of addressing it she added, "There are many stigmas and misconceptions associated with mental health and well being.

While people rush to a doctor for a normal cold and flu they avoid seeing a psychologist as they feel that a psychological disorder is their own doing that they need to be ashamed of." Emphasising on the need for quick identification and diagnosis of such disorders, she added, "Very few people know that mental health is directly co-related to hormonal imbalance or chemical changes/imbalances and is hence also physiological. All this misconception ensures that people are not able to distinguish between sadness, normal anxiety and clinical depression that requires treatment."

Adding to it

The stigma for mental health patients arises from the behaviours and emotions that sets them apart from others. Once these are controlled, there is no stigma. And modern medication can do this. If diagnosed with depression the person needs to follow the prescribed medical advice. The road to recovery is normally smooth but one needs to be patient." Speaking about the average age group of

y-based psychiatrist, Neville Misquitta said,

the callers on the suicide helpline Thomas added, "15-45 is the most prominent age group that is prone to suicidal tendencies globally. The second most vulnerable age group comprises 60 plus people. While for the first age group its usually a break-up, loss of a loved one or a general loss that's the biggest trigger, among the second age group the reasons range from loneliness, chronic illnesses, coping with the lack of loved ones to

terms with retirement and making a transition to a sedentary lifestyle.'

Examinations, especially the waiting period between exams to the results being declared is when students are most vulnerable. In recent times, unemployment, an unsatisfactory financial position and marital discord have also been seen as the major reasons of depression. Blaming the changing social scenario for the rise in depression rates and subsequent suicides, Thomas said, "India has been in a transition phase, since the last 15-20 years, with a changing value and support system. The MNC culture has brought about long working hours, lesser time spent with family, more distractions and more reliance on technology etc." Pointing out the flaws in a nuclear family structure he added, "Joint families earlier used to be a huge protective set-up as there were so many people to talk to. Man is social animal and needs to constantly talk things out."

Corporations and educational institutions all have a provision for in house counsellors who can be approached. "While companies do have a counselling cell, employees refrain from using it openly or otherwise as firstly you cannot discuss work related problems there and secondly no one wants to be seen as a whiney, problematic employee," said Neelam Puri, an IT professional. "The constant competition these days is really nerve wrecking. From climbing the corporate ladder, to looking good, to managing all the stress factors related to city life and then the financial and emotional upheavals really takes a toll and all of us do feel depressed every now and



## "NEET-UG Re-Test Only If Sanctity Lost On Large Scale": Supreme Court

**NEET-UG Paper** Leak: Controversy over the 2024 NEET-UG exam - attended by nearly 24 lakh aspiring medical professionals - broke last month after allegations the question paper had been leaked.

Supreme Court said Thursday morning as it heard over 40 petitions asking for a retest. The remark was an echo of observations made last week, when the court said the "sanctity" of the examination had been affected and it demanded answers from the authorities. The court advised petitioners against a retest and said certain circumstances would argue against that measure. The court also heard petitions from the under-fire NTA the National Testing Agency, the central body responsible for the conduct of competitive exams - seeking transfer of cases filed by various state police forces to the respective High Courts to avoid potential duplication and confusion. The day's hearing began with Chief Justice DY Chandrachud remarking on the urgency of this situation as lakhs of students are waiting on the outcome of the court's decision. "We will give priority to the NEET matter because of social ramifications," the Chief Justice said.



The first significant moment was the Chief Justice's sharp response to a petitioner's request to void results of the exam for all students on grounds the leaked paper may have compromised the scores."You have to show us that the leak was systematic that it

affected the entire examination... so as to warrant cancellation of the entire exam..." the court responded, "Second, tell us what should be the direction of the investigation in

this matter," the Chief Justice-led threemember bench said firmly.

If we accept your wider submission (that leaked question papers compromised the exam results) we would also like your assistance on the lines on which the investigation must happen."The court also pointed out it may be unfeasible to identify and "segregate" the hundreds, or thousands, of students who may have conspired to access questions beforehand.

On the numbers of petitioners - seen as crucial to establish the strength of petitions seeking cancellation - the NTA responded, "There are 131 not within the 1.08 lakh (students selected for admission to private colleges) who want a re-test and there are 254 who are opposing the re-test."The question

# Stations, Trains In Last 7 Years

New Delhi: The Railway Protection Force (RPF) has rescued as many as 84,119 children who were at risk in stations and trains across the country during the last seven years (2018-2024), preventing them from falling into harm's way, according to data released by the Ministry of Railways on Wednesday. Most of these children had run away from home or were reported missing while some had been left behind at railway stations or trains. There were also some children among them who had been kidnapped.

In the first five months of 2024, the RPF has already rescued 4,607 children. With 3430 runaway children rescued, the early trends suggest a continued commitment to the operation 'Nanhe Faristey.'The numbers reflect both the persistent issues of child runaways and the dedicated efforts of the RPF to address them. The RPF's 'Nanhe Faristey' mission dedicated to rescuing children in need of care and protection across various Indian Railway Zones has turned out to be a lifeline for thousands of children who find themselves in precarious situations.

The year 2018 marked a significant start for 'Operation Nanhe Faristey' with the RPF rescuing a total of 17,112 children, including both boys and girls.Out of 17,112 children rescued, 13,187 were identified as runaway children, an alarming number of 2,105 were found to be missing, 1091 children as left behind, 400 as destitute, 87 as kidnapped, 78 as mentally challenged and 131 as street children. During 2019, the RPF's efforts continued to bear fruit, with a total of 15,932 children, including both boys and girls being rescued. Out of 15,932 children rescued, 12,708 as runaway children, 1454 as missing, 1036 children as left behind, 350 as destitute, 56 as kidnapped, 123 as mentally challenged and 171 as street children. The consistent numbers showcased the persistent issue of children running away and needing protection.

The year 2020 was challenging due to the COVID-19 pandemic, which disrupted normal life and significantly impacted operations. Despite these challenges, the RPF managed to rescue 5,011 children. During 2021, there was a resurgence in the RPF's rescue operations with 11,907 children being rescued during the year. There was a significant increase in the number of children found and protected, with 9601 children identified as runaways, 961 as missing, 648 as left behind, 370 as destitute, 78 as kidnapped, 82 as mentally challenged and 123 as street children.

Now, stem cell treatment is being used to treat orthobiologicals. The university has already used (thigh) bone. Taking cue from the method's success "Use of stem cells for orthopaedic purposes comes in adults, we will now treat children," said Dr Ajai

King George's Medical University (KGMU). The university, which has already tried the process on two children, included the modality in its treatment protocol here on Monday.

Under the process, stem cells are extracted from the patient's bone marrow in the iliac bone in the pelvic region."About 60ml bone marrow is taken and placed inside a centrifugal machine and reduced to a concentrate. A hole is drilled into the patient's affected bone. Once the concentrate is ready, it is injected on the site of problem and sealed. The entire process lasts for about an hour," said Singh.

Before orthobiologicals, patients were saved from arthritis surgically by trimming the bone affected. The joint was fixed with the help of metal plates. But this method led to permanent lifelong disability by shortening of leg besides introducing a number of side effects. "Perthes in children and avascular necrosis are similar. In both scenarios, head of the femur bone becomes dead and affects function which shows up as pain on standing, walking or on taking up activity. Orthobiologicals save children from shortening of leg."

Identified in the 4-8 years age group, Perthes affects three out of 10,000 children in India, mainly in coastal regions. Several centres in Europe and America are already using the method and have recorded a success rate of 85%.

Colorectal cancer, which is gradually turning to be a major healthconcern among the Indian population, can be prevented with early detection using enhanced technology, health experts said at an event here on Tuesday.

G-EYE, an endoscopy technology which is claimed to detect gastrointestinal diseases more accurately was introduced in India during the event, organised by Smart Medical Systemsmanufacturer of gastrointestinal endoscopy devices along with enhanced technology products supplier Ventura Business Solutions. Colorectal cancer which is mainly caused by genetic disorders or environmental factors, is gradually becoming a major health concern. Currently, around four per cent of Indians are diagnosed by colorectal cancer while it is the third most common cancer among

men and second most common in women worldwide.

"There is a serious gap in detection of gastronomical diseases in many countries and colorectal cancer is becoming a growing reason for deaths in western countries. There



cancer patients among Indians who have migrated to US," said Zamir Halpern, Professor, Tel Aviv University, Israel at the event. The latest device is expected to make it easier to detect and improve the diagnosis and therapy of gastro-intestinal disorders and diseases. The device uses innovative balloon technology to uncover precancerous polyps that are hidden behind the colon's natural folds and provides the ability to perform double balloon enteroscopy.

## India's exports in Q1 show resilience despite global slowdown: CRISIL

New Delhi.India's exports have shown resilience amidst global challenges, with merchandise exports rising by 5.8% to \$109.96 billion in the first quarter of fiscal 2025, according to CRISIL.Despite a slowdown in growth in June, non-oil exports maintained momentum at 7.7%. However, a significant 18.2% contraction in oil exports contributed to a widening merchandise trade deficit to \$21 billion."On a cumulative basis, merchandise exports rose 5.8% to \$109.96 billion for the first quarter of fiscal 2025, from \$103.9 billion in the year-ago period. This growth in exports in the first quarter of fiscal 2025 suggests that India has managed to keep its exports resilient in the wake of the ongoing conflict in Europe and the Middle East," CRISIL said. According to CRISIL, while India's fiscal year began positively with merchandise



exports showing growth in the first quarter, the widening trade deficit due to higher import growth remains a concern. The government's emphasis on foreign-trade agreements (FTAs) is anticipated to boost exports, although challenges such as potential dumping from China following US tariff hikes loom.

'That said, growth in imports so far has surpassed exports, thus widening the trade deficit. This will remain a key monitorable, especially since the US has announced tariff hikes on Chinese imports, which could potentially lead to some dumping by China in the larger Asian market, including India," added CRISIL."Cumulative imports rose at a faster pace of 7.7% to \$172.4 billion from \$160 billion. As a result, trade deficit widened to \$62.44 billion from \$56.1 billion. It is also noteworthy that the trade deficit widened due to a higher oil trade deficit, while the non-oil trade deficit narrowed compared with last year," it added.

## **IDBI Bank Privatisation Gains** Momentum as RBI Gives Nod to Investors

New Delhi. The road to privatise IDBI Bank has been largely cleared, with the Reserve Bank of India (RBI) signaling its approval of potential investors. The NDA government at the Centre initiated the stake sale process in May 2021, awaiting RBI's assessment of bidders' suitability. Confirming the development, sources within RBI reported that all but one foreign bidder has been evaluated, except failing to provide the required information, hindering the assessment process. With the receipt of RBI's favorable assessment, attention has now turned to Finance Minister Nirmala Sitharaman's budget presentation on May 23. Market sentiments are focused on indications regarding government disinvestment plans. Following RBI's 'fit and proper' nod to potential buyers, IDBI Bank shares surged by 6%, trading at Rs 92.80 on the NSE at 11 am on Thursday, July 18. The government, holding a 45.5% stake,

plans to disinvest a total of 60.7%, including shares owned by LIC.Regarding the foreign bidder, the RBI has reportedly completed assessments for all but one foreign entity. This particular bidder did not disclose the required information, nor did its foreign regulator provide the necessary data. Currently, the central government holds a 45.5% stake in IDBI Bank, while LIC possesses over 49%. Initially established as a financial institution, IDBI later transformed into a bank. Under the government's disinvestment blueprint, a total stake of 60.7% in the bank is slated for sale, comprising 30.5% from the government's share and 30.2% from LIC's. Estimations suggest that the government stands to garner more than Rs 29,000 crore from the stake sale, given IDBI Bank's current market capitalisation of approximately Rs 99.78 thousand crore. The government's disinvestment plans, which also encompass BPCL, CONCOR, BEML, Shipping Corporation, IDBI Yashraj Erande, India leader, financial services, Bank, and an insurance firm, have faced delays over the past 18 months. Union Minister Hardeep Puri recently confirmed the postponement of BPCL's disinvestment.The Finance Minister's budget is expected to provide further clarity on the disinvestment strategy. Market analysts remain optimistic about IDBÍ Bank's privatisation, viewing it as a crucial step to mitigate financial burdens stemming from past losses.Over the past decade, the government has consistently expressed its intention to divest from 'non-strategic' sectors, with Air India being the sole disinvestment thus far. Market analysts are optimistic about the privatisation of IDBI Bank, noting its status as a private entity. The government's increased stake in the bank was necessitated by the need to inject capital to offset substantial losses incurred from debt.

This tax burden would represent 0.05 per cent of India's GDP, according to the report titled "The Global South's response to a changing trade regime in the era of climate change" by an independent think tank — Centre for Science and

Environment (CSE). These findings are based on data from the past three years (2021-22, 2022-23, and 2023-24). The tax is based on the carbon emissions generated during the production of these goods. The EU argues that this mechanism creates a level playing field

for domestically manufactured goods, which must adhere to stricter environmental standards, and helps reduce emissions from imports.But other nations, particularly developing countries, are worried this would harm



their economies and make it too expensive to trade with the bloc. The move has also sparked debate at multilateral forums, including UN climate conferences, with developing countries arguing that under UN climate change rules countries cannot dictate how others should reduce emissions. Trishant

Dev, Programme Officer (Climate Change) at CSE, said that India's CBAMcovered goods exports to the EU accounted for 9.91 per cent of its total goods exports to the bloc in 2022-23.He

said 26 per cent of India's aluminium and 28 per cent of its iron and steel exports were destined for the EU in 2022-23. These sectors dominate the basket of CBAM-covered goods shipped from India to the EU.In 2022-23, the exports of CBAMcovered goods to the EU made up about one-fourth (25.7 per cent) of India's total such goods exported globally, which is significant for the industries operating in these sectors. Currently, hydrogen and electricity are not exported from India to the EU.Of India's total goods exported worldwide, CBAMcovered goods exports to the EU constitute only about 1.64 per

cent. The report recommended a countertax on rich countries historically responsible for climate change. Countries that have not historically contributed to the climate crisis may consider imposing a 'historical polluter tax' on trade partners to fund their own decarbonisation efforts, the report said.

"FIFA is aware of a video circulating on social media and the incident is being looked into," a FIFA spokesperson said. "FIFA strongly condemns any form of discrimination by anyone, including players, fans, and officials."The controversial video was live-streamed on social media by



Chelsea and Argentina midfielder Enzo Fernandez from the team bus. The footage captured players singing chants that have been condemned as "racist and discriminatory" by the FFF. The celebration followed Argentina's 1-0 win over Colombia in the Copa America final in Miami on Sunday. Chelsea defender Wesley Fofana, a teammate of Fernandez, described the video as showcasing "uninhibited racism."

Fernandez later issued an apology on social media, expressing regret for his actions.

"The song included highly offensive language, and there is absolutely no excuse for these words," Fernandez wrote. "I got caught up in the euphoria of our celebrations." Chelsea Football Club released a statement condemning the incident: "Chelsea Football Club finds all forms of discriminatory behavior completely unacceptable. We are proud to be a diverse, inclusive club where people from all cultures, communities, and identities feel welcome."This incident has rekindled memories of the racist abuse directed at France striker Kylian Mbappe and other players of African descent on the national team after their defeat to Argentina in the 2022 World Cup final. Despite the uproar, neither the Argentina Football Association nor Lionel Messi have made public comments about the incident. Representatives for both parties did not immediately respond to requests for statements. Argentina's triumph over Colombia secured them a record 16th Copa America title, celebrated by fans and players alike. However, the aftermath of their victory has now been overshadowed by this investigation, as FIFA seeks to address the serious allegations of racism within the

New Delhi. West Indies captain Kraigg Brathwaite has underscored the importance of more Test matches for his team as they gear up for the second Test against England at Trent Bridge. This came after a heavy defeat in the first Test at

Lord's, where the West Indies were thoroughly outplayed, losing by an innings and 114 runs. However, the disparity between the two teams extends beyond onfield performancEngland, along with India and Australia, is part of international cricket's financially dominant 'Big Three' nations, whereas the West Indies is one of the economically poorer members of the Test-playing elite. This financial gap is reflected in their respective fixture lists. While Tests are still primarily arranged



bilaterally between teams, the International Cricket Council (ICC) only mandates a minimum of two matches per series. For instance, Thursday's second Test at Trent Bridge will be England's seventh of 17 Test matches scheduled for this year, while it will be only the third of nine for the West Indies in 2024. "It's a challenge. I mean, we're longing for more Test cricket," Brathwaite expressed during a pre-match press conference at Trent Bridge on Wednesday. "The more you play, the faster you learn. If

it's spread over a long period, with just two Tests here and two Tests there, it takes longer to learn. We need more Tests."The 31-year-old captain added, "All I can do is keep advocating for it. I don't know how hard it is to organize a Test series for the West Indies, but I will keep asking. I hope those in charge of scheduling, amidst all the white ball and T20 tournaments, can fit in five or six more Test matches for us each year."

In the short term, the West Indies must focus on improving their batting to be

competitive in this series. At Lord's, they were bowled out for just 121 and 136, with Brathwaite himself managing only 10 runs in total during his 90th Test. "It's pretty simple what we've got to do -- we've got to bat a lot better," said Brathwaite, who scored a Test century in England at Headingley seven years ago. "We've got to find a way to put runs on the board. I know what I have to do, and it's important to lead this team and the batting. We just have to keep learning."

# Will Jay Shah take over as next chairman? Topic to be discussed during ICC AGM

The ICC Annual Conference in
Colombo will see significant
discussions on Jay Shah's potential
takeover as ICC Chairman from Greg
Barclay. Financial losses from the
T20 World Cup in the USA and other
key issues are also on the agenda.

New Delhi All eyes will be on BCCI secretary Jay Shah during the four-day ICC Annual Conference in Colombo, starting on Friday, where there might be serious discussions about when he will take over from New Zealander Greg Barclay as the chairman of the global body. The ICC conference that starts with the board meeting on Friday is expected to be dominated by losses to the tune of more than USD 20 million incurred by the global body for hosting T20 World Cup games in the United States of America. While the nine-point agenda of the AGM (a copy of which is with the PTI) doesn't include the event's financial details, but it will be discussed by the board as a "post-event report", which is a standard operating procedure.

ICC's new external auditor appointment is also on the agenda along with discussions on ICC memberships, reports from associate member's meeting and ICC development Awards presentation. The other important point -- India not travelling to Pakistan for the Champions Trophy -- is not a



part of the ICC Board's official agenda unless it is brought with permission of the chair under the section "Any Other Business". An ICC source privy to the developments, however, said that one of the main areas of interest for everyone at the ICC is when Shah takes over the reins of the

world body."It is not about how but when, as he still has one year left as BCCI secretary before his cooling off period in Indian board starts in 2025 as per constitution. However, if he has to take over in 2025, then Barclay can't complete his third term of two years from December 2024 to December 2026," the ICC source said. "There is a school of thought that what if ICC's chairmanship term changes from three terms of two years each to two terms of three years, so the cumulative term can remain six years."It is widely believed that if

Barclay's current term becomes three years, then Shah can complete his six years as BCCI secretary and take over as ICC chairman in 2025 for three years when he will be cooling off in BCCI. Then in 2028, he can come back and take over as board
