Mumbai, July 19: Airport and airline operations faced significant disruptions on Friday due to global Microsoft outage, with airlines issuing advisories to passengers. IndiGo, SpiceJet, Air India, Air India Express and Akasa saw disruptions in their online check-in and boarding processes across their networks, forcing them to switch to manual mode. "Our systems are currently impacted by a Microsoft outage, which is also affecting other companies. During this time booking, check-in, access to your boarding pass, and some flights may be impacted, IndiGo said in an update on X. "We are all hands-on decks and are working to restore stability and normalcy. Our digital team is also coordinating closely with Microsoft Azure to resolve these issues swiftly," it stated. # Supreme Court dismisses plea of two convicts in Bilkis Bano case against January 8 verdict cancelling remission

New Delhi, July 19: The Supreme Court on Friday refused to entertain a plea of two of the 11 convicts in the Bilkis Bano case challenging the January 8 verdict cancelling their remission. A Bench of Justices Sanjiv Khanna and Sanjay Kumar termed the plea as "absolutely misconceived" and said how can it sit in appeal over an order passed by another Bench of the apex court. "What is this plea? How is this plea maintainable? This is absolutely misconceived. How can an Article 32 petition be filed? We can't sit in appeal over an order passed by another bench," the bench said. Advocate Rishi Malhotra appearing for convicts Radheyshaym Bhagwandas Shah and Rajubhai Babulal Soni sought permission to withdraw the plea. The Bench allowed the counsel to withdraw the plea. Shah has also applied for interim bail. In March, both the convicts moved the top court contending that its January 8 verdict cancelling remission of their sentence was "in teeth of" a 2002 constitution bench order and sought

the issue to be referred to a larger bench for "final" adjudication. Shah and Soni, both lodged in Godhra sub-jail after the apex



court verdict, said an "anomalous" situation has arisen wherein two different coordinate benches (benches of the same strength) have taken diametrically opposite views on the same issue of premature release as well

as on which policy of the state government would apply to the petitioners for remission. The plea, filed through Malhotra, said while one bench on May 13, 2022, categorically ordered the Gujarat government to consider Shah's application for premature release in terms of the state government's remission policy of July 9, 1992, the bench that pronounced the verdict on January 8, 2024, concluded that it was Maharashtra and not the Gujarat government that was competent to grant remission. "That with greatest respect the judgment rendered on January 8, 2024, is directly in teeth of the constitution bench decision in Rupa Ashok Hurra's case of 2002 and the same needs to be set aside, as if the same is permitted then it would lead to not only judicial impropriety but to uncertainty and chaos as to which precedence (sic) of law has to be applied in future. "In other words, if any party being not satisfied with the Supreme Court judgment on an issue, he would be entitled to file a writ petition challenging the said judgment by taking recourse to the law laid down in Bilkis Bano case," the plea said.

# Ex-IAS officer fined Rs 1 lakh for filing 'frivolous' plea against J&K LG



Jammu, July 19: The Central Administrative Tribunal's Jammu Bench has imposed a fine of Rs 1 lakh on a former IAS officer for filing a "mischievous and frivolous" plea against the Lieutenant Governor of Jammu and Kashmir and other senior bureaucrats. The tribunal's judicial member Rajinder Dogra, in the July 16 order, said the application filed by former IAS officer Kumar Ranchhodbhai Parmar about his service was just to "harass" the Lt Governor Manoj Sinha and other bureaucrats. The tribunal said this was a service-related matter and instead of impleading the Union and the state governments, Parmar has impleaded Sinha and other authorities by their names. "It is quite astonishing to note that the applicant, a senior IAS officer with extensive knowledge of the Constitution and its laws, proceeded to file the application seeking relief against the Hon'ble Lieutenant

# Accused facing trial under UAPA can be granted bail, if trial moves at snail's pace: Supreme Court

New Delhi, July 19: A terror accused facing trial under the stringent provisions of the Unlawful Activities Prevention Act (UAPA), 1967, can be released on bail, if the trial moves at snail's pace, the Supreme Court has ruled. In April 2019, the top court had set aside the bail granted to Kashmiri Zahoor Ahmad Shah Watali by the Delhi High Court in a terror funding case filed against him by the National Investigation Agency (NIA). In Watali's case, it had held that bail in UAPA cases can't be granted if there was a prima facie satisfaction of the court that the material on record proved the allegations and that it's not permissible for courts to engage in a detailed analysis of prosecution case and to weigh the material before it, while considering bail. However, a Bench of Justices JB Pardiwala and Ujjal Bhuyan on Thursday said, "This decision, that is, Zahoor Ahmad Shah Watali has to be read and

### 'India values its strategic autonomy': MEA spokesperson reacts to USA Ambassador's statement

New Delhi, July 19: A week after US Ambassador to India Eric Garcetti commenting on India-US ties said "in times of conflict there is no such thing as "strategic autonomy", India on Friday said it values its "strategic autonomy". Ministry of External Affairs spokesperson Randhir Jaiswal on being asked about Garcetti's comments, said, "India, like many other countries, values its 'strategic autonomy'. The US Ambassador is entitled to his opinion. Obviously, we have different views." "Our comprehensive global strategic partnership with the US gives us the space to agree to disagree on certain issues, while respecting each other's viewpoints," Jaiswal added. "As comprehensive global strategic partners, India and the US have regular discussions on bilateral, regional and global issues of mutual interest. It is not our practice to share details of diplomatic conversations," Jaiswal added. Garcetti was speaking at an event in New Delhi on July 11, two days after

met Russian President Vladimir Putin in Moscow - when he said, "I know that India likes its strategic autonomy, I respect that, but in times of conflict there is no such thing as strategic autonomy." Though he did not elaborate, the hint was clear that the US was not happy with India's ties with Russia. Garcetti had said, "Don't take the relationship for granted, but enjoy it every day, pay something into it. It's like a marriage. Let's listen to each other in this relationship, its people, its needs." Meanwhile, the US has yet again said it wants India to support its efforts to realise an enduring and just peace for Ukraine. ### Health experts advocate for ban on chlorinated gloves

BENGALURU. Health experts have advocated a ban on chlorinated gloves, highlighting significant risks due to residual chlorine, including skin irritation and allergic reaction. Chlorinated gloves can also become brittle and tear, increasing infection risk for healthcare providers and patients, experts said.

This comes a day after the Indian Rubber Gloves Manufacturers Association (IRGMA) requested the government to ban the import of chlorinated gloves to mitigate the associated risks. In recent communications to the Ministry of Environment, Forests and Climate Change, and the Customs (Imports) Department, IRGMA highlighted violations of biowaste disposal rules and non-compliance by importers of phased-out chlorinated gloves. It advocated for the use of Bureau of Indian Standards (BIS) approved gloves only in government hospitals, aligning with the Quality Control Order (QCO).

The association noted that the Central Pollution Control Board (CPCB) had mandated phasing out chlorinated gloves by March 27, 2019, and the West Bengal State Pollution Control Board has also issued a ban on their use. Despite these regulations, chlorinated gloves continue to be imported and used, posing significant health risks.

Speaking to TNIE, experts said they have personally experienced issues with chlorine residue causing infection risks. While they welcome the switch to safer options, they emphasise the importance of ensuring readily available high-quality

# Kochi's Vypeen in focus as KSRTC plans to enhance coastal connectivity

KOCHI. The Kerala State Road Transport Corporation (KSRTC) will soon commence dedicated services connecting the coastal regions, with a focus on providing direct connectivity to islanders in and around Vypeen region to various centres in Ernakulam.

We've started planning the services, which will be operated at regular intervals. There will be more services during peak hours. The same will provide islanders with direct connectivity to various destinations in Kochi city like Vyttila hub, Ernakulam boat jetty and Kaloor. Currently, we're taking stock of the buses and the crew that can be spared for the service," a senior KSRTC official

Faced with shortage of crew, the corporation has resorted to appointing drivers on temporary In January 2023, a meeting of basis. "KSRTC has invited applications from candidates who have featured in past PSC rank lists (for the post of drivers), the validity of which have expired, to tide over the crisis," the official

Currently, private buses are not

# Garbage collection resumes as villagers near landfill stop stir in Bengaluru

The Bengaluru Solid Waste Management Limited agreed to their demands in writing on Wednesday evening and the local MLA also has been briefed.

BENGALURU. The three-day protest by residents of Mittiganahalli and Kannur against Bruhat Bengaluru Mahanagara Palike (BBMP) affected door-to-door garbage collection as well as clearing of waste from the city to the landfill. With protesters blocking entry of garbage trucks to the Mittiganahalli waste processing plant, piles of waste accumulated across the city, especially in Mahadevpura, BBMP East and BBMP South Zones.

For years, the villagers have been demanding that the Palike address the leachate issue from the garbage dumped there.

Ashok S, president of Kannur Gram Panchayat, said the panchayat consists of 15 villages that have been severely affected



due to 450 trucks dumping waste in the Mittiganahalli waste processing plant. The Bengaluru Solid Waste Management Limited agreed to their demands in writing on Wednesday evening and the local MLA also has been briefed.

"The villagers are at the receiving end of the BBMP apathy. As much as 300 crore litre of leachate has seeped into the villages and the civic body is least bothered about this. The villagers are suffering due to the unbearable stench. As there was rain, the leachate also entered the 1.5-km stormwater drain connecting Kannur to Doddagubbi. Since we have objected to the entry of trucks, the Palike officials have agreed to build a parallel stormwater drain at

a cost of Rs 22 crore and also approved Rs 70 crore to set up a 1 MLD leachate treatment plant," said Ashoka. He said about 60 per cent of waste from BBMP is

being sent to Mittiganahalli. "As we called off the protest on Wednesday night, the normal collection will resume.

Meanwhile, residents of Vignana Nagar, Whitefield, HAL, Basavanagar, Vijinapura and other wards in Mahadevpura as well as in Bengaluru East, South and other areas, said pourakarmikas had not turned up to collect waste sience Monday and garbage has piled up on street corners.

With mounds of garbage lying on the streets for the last few days and the rainfall daily, there could be health issues if not addressed," said Srujan Kadamba, a techie and Whitefield resident.A senior BBMP official said garbage collection will resume normally from Friday as trucks will start ferrying waste to the landfill from Thursday evening."As there is a huge pile of garbage to be cleared from parts of Bengaluru, the situation will become normal in a day or two," said the official.

### Railways sanctions Rs 288 crore for flyover in Sambalpur city

BHUBANESWAR. The Ministry of Railways has sanctioned Rs 288.61 crore for construction of a railway flyover connecting Sambalpur station with the city station.

The project is a part of the energy corridor scheme of Indian Railways for sustainable and efficient infrastructure development.

The flyover will facilitate simultaneous train movements from all directions at Sambalpur, easing train traffic and ensuring hassle-free operations, sources said.

Currently, cross-traffic from Jharsuguda, Titilagarh and Angul directions leads to delays and operational inefficiencies at Sambalpur



junction and Sambalpur city stations. The 8.1 km flyover will resolve these issues by enabling simultaneous train movements without surface crossings, thus preventing detentions and enhancing overall train operational capabilities in the region, they said. "It is a significant railway project for the region. Trains will no longer be detained at Sambalpur and Sambalpur city

# Wind up all road works before September: Chennai Corporation

CHENNAI. Setting a deadline for winding up A meeting chaired by Deputy Commissioner road cuts by government agencies such as CMWSSB, Tangedco and telecom companies, the city corporation officials have warned the agencies that all permissions issued will be revoked if any work is found to be underway in September. The decision comes after many residents complained to the new corporation commissioner, J Kumaragurubaran, about the distress caused by dug-up roads.

The civic body has also informed the police department of their decision and has asked them not to issue traffic diversion permission from September onwards.

(Works) V Sivakrishnamurthy every Tuesday, will review the status of ongoing road works."In Kuberan Nagar extension, the road work by metro water has been going on for two years now and is showing no signs of winding up. We have brought this to the attention of authorities multiple times. The road becomes unmotorable every time it rains," said Vignesh S, a resident.Meanwhile, Chennai-based civic action group Arappor Iyakkam has flagged the relaying of Wall Tax road by the Highways department for which tenders have been floated, stating that the roads were relaid only in 2021 and there was no need to relay the entire stretch again.

As part of monsoon preparedness, inundationprone zones along 790 km of stormwater drains are being de-silted, and blockages in the confluence of Mambalam Canal to Adyar are being cleared since Wednesday. "We have also asked the Chennai Metro Rail Limited (CMRL) to provide us with 10 HP -150 HP pumps wherever necessary. The CMRL is also fixing some drains that got damaged during metro rail work. This has been expedited following a recent review meeting headed by the chief secretary," said a city corporation official.

### 70m stretch of Dwarka expressway damaged 4 months after launch, repaired; NHAI to launch probe

GURGAON. Just four months after its inauguration, a 70m portion of the Dwarka Expressway was damaged on Thursday, raising serious concerns about the quality of construction. The stretch, which falls on the Gurgaon-Delhi carriageway of the expressway near Heritage Max society, developed an uneven surface due to a rise in the top layer of asphalt at some spots and minor cracks at others. Officials from the National Highways Authority of India (NHAI) said they will carry out a detailed probe to ascertain the cause of the damage. The damage was speedily repaired by the contractor. A visit to the site by TOI on Thursday revealed that patchwork had been carried out at three spots, while surface distress (minor cracks on the surface) was visible at two other spots.

A senior NHAI official acknowledged that the stretch developed an uneven surface. "We have asked the agency to carry out the repair work, but we will also conduct a thorough probe to understand the reasons behind this," the official said.

The 18.7km Gurgaon section of the Rs 9,000-crore expressway was inaugurated by Prime Minister Narendra Modi in March this year, almost 18 years after the Haryana govt conceived the idea of building an additional link between Delhi and Gurgaon. Being built by NHAI as a 'model' urban expressway, it is designed to meet the region's traffic requirements for the next 20 years. As a result, the Gurgaon stretch was expected to remain in good condition for many years without requiring major repairs. According to the staff present on the site, an accident that occurred a couple of days ago resulted in diesel spilling on the road surface. This, combined with a leak in the wall of the median which caused rainwater to seep in, might have led to the damage, they said. "We have carried out the repairs. A new layer of bitumen mix has been laid on the damaged patches. Also, we have sealed the bottom of the median with concrete to prevent any water spillage," a worker said.

### 53 FIRs against parents of underage drivers as police begin crackdown

Noida. Amidst outrage over a 17-year-old boy at the wheel of a Porsche running over two bike riders in Pune, police in the city and Ghaziabad have registered 53 FIRs in four days against parents or guardians of minors caught driving near schools, malls and coaching centres.Ghaziabad police said on Wednesday around 25 teams have been deployed across the city as part of their crackdown on underage driving.

They registered 48 FIRs from July 6 to July 8. On Tuesday, 24 FIRs were registered, mostly in Kavi Nagar, Vijay Nagar, Kotwali and Indirapuram. Monday saw 22 FIRs, and two on Sunday. Noida police registered five FIRs against the vehicles' owners and seized nine vehicles driven by minors.Ghaziabad police commissioner Ajay Kumar Mishra said FIRs have been registered under BNS Section 125 (endangering life or personal safety of others) and Section 199A of the Motor Vehicles Act.

Section 199A of the MV Act says that the guardian of a minor or the owner of the vehicle will be punished if road norms are violated by a minor. This law is punishable with a fine of Rs 25,000, three years in jail, or both. The vehicle's registration can be cancelled for 12 months as well, and the minor cannot get a licence till 25 years of age.

### City sees short spell of intense rain, more likely for 5 days

Gurgaon. The city on Thursday witnessed a short spell of intense showers, strong winds blowing at up to 30kmph and cloudy skies, which brought down the maximum temperature to 35.5 degrees Celsius from the previous day's 36.4 degrees. It was a notch above the season's normal. The relative humidity index oscillated between 70% and 78% during the

IMD forecasts suggested light-to-moderate showers till July 23. The minimum temperature, however, was recorded at 33 degrees Celsius, which was 29.8 degrees on Wednesday. According to the India Meteorological Department (IMD), light to moderate rainfall is expected at isolated places for the next five days. Though no alert has been issued for Friday and Saturday, IMD has sounded a yellow alert for Sunday and Monday.

'Isolated to scattered rainfall is likely to continue in Haryana for the next two days, and it will increase in the subsequent days. We are not expecting any major change in the temperature," an IMD official said. On Friday, it will be partly cloudy with possibility of one or two spells of rain or thundershowers. The minimum and maximum temperatures are expected to hover around 32 and 35 degrees Celsius, respectively.

Meanwhile, the city's air quality index remained in the "moderate" category (102), while it was 109 on the previous day. # Waste still going to Bandhwari major non-compliance: CPCB

steps to stop daily waste dumping at the Bandhwari landfill, Central Pollution Control Board (CPCB) has said in a report to National Green Tribunal (NGT). Terming it "major noncompliance", CPCB has also said MCG should augment its waste collection, segregation, transportation and processing capacity. The report also revealed that ambient air quality monitoring tests were conducted at two sites in the landfill, which revealed that PM2.5 and PM10 levels for March and April surpassed the permissible limits set by the National Ambient Air Quality Standards (NAAQS).CPCB observed in its report that the daily waste dumping continues to take place at Bandhwari because of a significant gap between waste generation and processing.."The local authorities concerned need to take immediate steps for enhancing the capacity of solid at the landfill to manage pollutant

dumpsite. This is in accordance with Rule 15 of Solid Waste Management (SWM) Rules," read the report. It was submitted on Tuesday in response to the suo moto cognizance of a major fire at the landfill by NGT in April, which was based on a TOI report. The tribunal impleaded six govt agencies. A hearing was conducted on Thursday, and the next will be held on Sept 5. Around 2,200 tonneas of waste is dumped daily at the landfill. Of this, around 1,200 tonnes of waste comes from Gurgaon, and the remaining 1,000 tonnes from Faridabad. The corporation earlier earmarked 2.5 acres of land behind the landfill, where daily waste is being dumped at present.CPCB has

### Minor held for murder in Gurgaon's first BNS case, strangled 9-year-old girl

GURGAON: A 16-year-old boy allegedly strangled to death a nine-year-old girl, his neighbour in a housing society, on Monday morning when she walked in on him trying to steal from the flat. He set her body on fire by lighting pieces of camphor and cloth he found lying around after he killed her, apparently to destroy evidence. The boy, who was apprehended under Bharatiya Nyaya Sanhita (BNS) - the first case to be registered in the city under the new law that has replaced the Indian Penal Code - had allegedly gone to the neighbour's house to steal ewellery when her mother and brother were visiting his flat. The two families live in adjacent towers of the Sector 107 society, which was built under the affordable housing scheme.he case was registered at Rajendra Park police station. The boy told

investigators he entered the neighbour's flat thinking everyone was away and panicked when the girl suddenly walked out of the washroom.

World Former United States President Donald Trump took centre stage at the Republican National Convention in Milwaukee. While accepting the Republican Party's presidential nomination, he stated, "Tonight, with faith and devotion, I proudly accept your nomination for President of the United States."Recalling the assassination attempt, Donald Trump stated that he survived it by divine intervention. "I had God on my side," he stated. It was Donald Trump's first speech since 20-year-old Thomas Mathew Crooks took a shot at him, wounding one of his ears, during a rally last weekend."I am not supposed to be here tonight — not supposed to be here," Donald Trump stated, while the crowd roared back. "Yes, you are." As he walks to the podium to deliver his acceptance speech, "God Bless the USA," a live patriotic song performed by Lee Greenwood fills the air, gradually building the intensity. The 78-year-old Republican leader stated that his supporters raised 6.3 million US dollars for the victims of the shooting incident in Pennsylvania. Trump also observed a moment of silence for Corey Comperatore, a 50-yearold firefighter and father of two, who died in the shooting at the Pennsylvania rally. The usually combative president adopted an unusually sombre, almost whispering tone as he cautioned against demonising political opponents. Trump warned against vilifying rivals and criminalising dissent. He then portrayed himself as the victim of politically motivated charges. "If Democrats want to unify our country, they should drop these partisan witch hunts," he said.

'In that spirit of unity, the Democratic Party should immediately stop weaponising the justice system and labelling their political opponent as an enemy of democracy. Especially since that is not true. In fact, I am the one saving democracy for the people of our country,'

**Rome** A Milan court has ordered a journalist to pay Italian Prime Minister Giorgia Meloni damages of 5,000 euros (\$5,465) for making fun of her in a social media post, news agency ANSA and other local media


The journalst, Giulia Cortese, was also given a suspended fine of 1,200 euros for a jibe on Twitter, now named X, in Oct. 2021 about Meloni's height, that was defined as "body shaming". In a response to a Reuters story on the verdict, Cortese wrote on X on Thursday: "Italy's government has a serious problem with freedom of expression and journalistic dissent."Meloni had launched legal action against the journalist after the two women clashed on social media three years ago.

Meloni, whose far-right Brothers of Italy party was in opposition at the time, took exception when Cortese published a mocked-up photo of her with a picture of the late fascist leader Benito Mussolini in the background.

Cortese responded with further tweets including one that translates as "you don't scare me, Giorgia Meloni. After all, you're only 1.2 metres (4 feet) tall. I can't even see you."Meloni's height is given as between 1.58 m and 1.6m on various media websites.Cortese can appeal against the sentence, and Meloni's lawyer said the prime minister would donate to charity any damages she eventually receives.

### Powerful 7.4-magnitude quake strikes north Chile near Argentine border

SANTIAGO. A magnitude 7.4 earthquake struck northern Chile near its border with Argentina late Thursday, the U.S. Geological Survey reported, shaking homes and causing power outages. There were no immediate reports of injuries or major damage.he quake's epicenter was 45 kilometers (28 miles) southeast of San Pedro de Atacama, Chile, a tourist hub on the edge of the northern desert. The trembler had a depth of 117 kilometers (72 miles), according to the USGS, which likely lessened the intensity of the shaking. The deeper an earthquake when it strikes, the less destructive a jolt it will cause at the surface. Chilean President Gabriel Boric said his government was closely examining the area but "so far there are no reports of injuries or major damage."



The quake did not activate a tsunami alarm. Footage spread online of rocks tumbling onto a highway connecting the cities of Calama to Tocopilla, east of the epicenter and local authorities reported road blocks in the area.

The shaking from deeper earthquakes tend to be felt across a wider swath of earth, experts say.

Thursday's quake rumbled across six provinces -Tarapacá, Ântofagasta, Atacama, Coquimbo, Arica and Parinacota — Chile's emergency service said. At least a dozen aftershocks have jolted the surface since.

"Despite its remarkable size, and the large number of fallen objects, it is not considered a major intensity earthquake," researchers at the non-governmental Chilean Geoscience Network reported, citing "some minor shocks to infrastructure" but no fallen buildings. "It was not difficult for residents to stand up," it said. Chile is located in the so-called "Ring of Fire" in the Pacific that is unqueely vulnerable to earthquakes Chileans still have painful memories of a magnitude 8.8 earthquake in 2010 that spawned a tsunami and killed 526 people. The Geoscience Network said that Thursday's quake was the most intense to strike Chile since 2016, when a 7.6magnitude earthquake struck the south of the country.

# Biden's chances of winning 'diminished', **Obama told Democrats: Report**

US President Joe Biden should seriously reconsider his reelection bid as his chances of winning the November 5 election have "greatly diminished", former US President Barack Obama told Democrats privately, The Washington Post reported.

World Former US President Barack Obama has told Democrats that President Joe Biden's chances of winning the November 5 election have "greatly diminished" and believes that the 81year-old leader should seriously reconsider his re-election bid, The Washington Post reported, citing multiple



spoke to Biden, who served as his vice president from 2009 to 2017, only once since his disastrous presidential debate against former US President Donald Trump last month, according to The Washington Post. Biden's debate performance was marked by frequent slip-ups and appeared to lose his train of thought, sparking concerns among the Democrats over his age and mental fitness to serve another term. Some of them, including US Representative Adam Shiff,

have publicly called on Biden to withdraw from the presidential race in favour of another candidate, though the President has remained adamant, saying he was fit to run again and defeat Trump.Obama has been clear in his conversations with the Democrats that it is up to Biden to decide his candidacy, The Washington Post reported. He has stated that his concern was to protect Biden and his legacy and has decided against pushing the thought that he alone can

influence the President's decision-making process.Earlier, Biden said he would consider quitting the race only if doctors told him that he had been diagnosed with some "medical condition", in his clearest indication to end his campaign following his debate performance on June 27.Meanwhile, Biden on Wednesday tested positive for Covid-19 while on the campaign trail in Las Vegas. He is selfisolating at the Delaware beach house after experiencing mild symptoms, the White House said. It was not clear for how long the illness would keep Biden out from campaigning. The US President has been defiant in the face of the calls to quit the race, telling one interviewer that only the "Lord Almighty" could persuade him to go.Some 40 per cent of Democraticregistered voters said Biden should drop his re-election bid, in a Reuters/Ipsos poll concluded on Tuesday. Some 65 per cent of independent registered voters agreed with them. Some 58 per cent of Democratic-registered voters told the poll they believed Biden is too old to work in government - 70 per cent of independent registered voters agreed.

# Joe Biden 'seriously considering' exit from US presidential race: Reports

World Amid a strong push from Democrats at the highest levels to rethink his election bid, US President Joe Biden is weighing whether to step out of the presidential race. A decision on the matter is likely to be made by this weekend, according to reports.

### Bangladesh protests: 39 killed, protesters set state broadcaster's building ablaze

**World** Widespread violence gripped Bangladesh after relentless clashes between student protesters, security officials, and pro-government student activists over a quota system for government jobs. At least 39 people died in the violence, with Thursday becoming the most violent day.

Police and protesters armed with sticks and rocks clashed across the country, including in the capital, Dhaka, as the students tried to shut down transportation across Bangladesh.

undreds of people were injured as police fired tear gas and rubber bullets to break up groups of protesters, who torched vehicles, police posts and other establishments.

Streets looked deserted in Bangladesh's Dhaka on Friday following the violent protests on Thursday. Bangladesh TV news channels are not transmitting on Friday, news agency Reuters reported.Communication services were widely disrupted in Bangladesh on Friday, with authorities cutting some mobile services on Thursday to try to quell the unrest but the disruption spread across the country. According to outage monitor NetBlocks, Bangladesh was plunged into a "near-total" internet shutdown as night fell. Telephone calls from overseas were mostly not getting connected and calls through the internet could not be completed.

On Thursday, the student protestors set fire to the state broadcaster's building a day after the Prime Minister, Sheikh Hasina, appeared on the network seeking to calm the clashes. Several police posts, vehicles and other establishments were also torched. Multiple Awami League officers were also attacked by the students.he protesters are demanding that the Sheikh Hasina government stop setting aside 30 per cent of government jobs for the families of people who fought in the 1971 war of independence from Pakistan. The agitation, fueled by high unemployment, is the biggest since Prime Minister Hasina was reelected earlier this year. The protests began late last month. However, it escalated on Monday when student activists at Dhaka University clashed with police and counter-protesters backed by the ruling Awami League. The protesters argue that the quota system is framed to benefit the supporters of Sheikh Hasina's Awami League, which led the independence movement. They call it a discriminatory system and want to replace it with a merit-based system. Though the Bangladesh government scrapped these quotas in 2018, a High Court reinstated them later.

The Bangladesh Supreme Court, on August 7, is set to hear the government's appeal against the High Court's order reinstating the quota, which was abolished by the government in 2018.

# Yemen's Houthi rebels launch air attack on Tel Aviv; one dead, at least 10 injured

TEL AVIV. An explosion rumbled through the streets of central Tel Aviv early Friday morning after an apparent drone strike caused shards of shrapnel to rain down, injuring at least 10 people and leaving one dead, authorities said. Israel's military said that they were reviewing the explosion and increasing air patrols after the incident, which its initial inquiries determined was caused by "an aerial target."It was not immediately clear how the strike evaded Israel's air defenses or how Israel might respond.

Tel Aviv Mayor Ron Huldai called the attack a drone strike on the social media platform X, though the military has not yet specified the nature of the attack. Yemen's Houthis have repeatedly launched drones and missiles toward Israel throughout the nine-month-long war, in sympathy with Hamas. But until Friday, all were intercepted by either Israel or Western allies with forces stationed in the region. The strike hit hours after Israel's military confirmed one of its airstrikes had killed a Hezbollah commander and other militants in southern Lebanon.Israel has so far not made attacks on the Houthis, allowing its allies instead to take the lead as it focuses its efforts on the war in Gaza and ongoing



fighting with Lebanon's Hezbollah militant group. It comes as international mediators continue to hold out hope for a cease-fire agreement, pushing Israel and Hamas toward a phased deal that would halt fighting and free about 120 hostages held by the militant group in Gaza. The prospects a deal could improve as Israeli leaders signal their operation underway

in Rafah is close to finished. However, fears of potential escalation resurfaced on Thursday after Israel's far-right national security minister, Itamar Ben-Gvir, visited Jerusalem's most sensitive holy site on Thursday to pray for the return of Israeli hostages, he said, "without a reckless deal, without surrendering.' ### Mumbai's 100km water tunnel web to be world's largest in 6 years

MUMBAI. July 2024 will go down as the month when Mumbai got its 'underground'. Any day now, a part of the city's Metro Line 3, which is almost entirely underground, will begin operations. Delhi has a 20-year lead, but not many know that Mumbai started building big tunnels and using tunnel boring machines (TBMs) much before the Capital. It's just that Mumbai's tunnels until now were meant for moving water, not

Quietly, without media frenzy, the city's water tunnel network crossed the 100km milestone on June 21, with the completion of a 9.7km underwater tunnel from Ghatkopar to Parel via Wadala. Although China, Japan and many other countries use water tunnels in cities, only New York City with a 111km water tunnel network is ahead of Mumbai now.

#### WHY DIG SO DEEP?

Mumbai's water tunnels run 100-110m below the surface - unlike pipelines that are at a depth of 3-5m - and cost almost Rs 100 crore per km to build. For instance, the 9.7km Ghatkopar-Parel tunnel cost Rs 943 crore. Wouldn't it be cheaper to stick to pipelines then? Maybe, if you could find the space to lay more of them. But additional municipal commissioner Abhijit Bangar said tunnels have several advantages. Bangar, who holds charge of Brihanmumbai Municipal Corporation's (BMC) water supply projects department, said, "Because the tunnels are deeper, the chances of contamination and theft are significantly reduced. Currently, Mumbai loses close to 35% of its water due to some of these issues. Tunnels can help reduce this loss marginally."

# Centuries-old Tippu Sulthan hotel preserves Fort Kochi's flavours

the historical buildings, the hipster cafes and art galleries, antique shops and Instagram-worthy nooks, what first catches the eye in Fort Kochi is Tippu Sulthan. No, not the Mysuru ruler, but the hotel Tippu Sulthan.

Tucked away on the busy Calvathy lane and bang opposite the teeming ferry, the centuries-old hotel welcomes all tourists and locals alike — in a humble salute. Today, however, the 18th-century establishment has started to show its age. Though the rustic, yet vintage 'thattukada' appearance still has a charm, decades of developmental works in the region have seen it 'sink' into the ground, requiring customers to 'bow' before making themselves present before Tippu. But that's not stopping its patrons, which number hundreds, if not thousands, from stopping here for their usual cuppa or a lipsmacking meal. Others, unfamiliar with the 'Tippu magic', would still storm in on learning that the prices here have remained untouched for years.

"Affordable prices... this is what distinguishes us from other establishments in the area. We serve good food for nominal rates. It has helped Tippu Sulthan remain in business for centuries," says Abdul Rahman, the hotel's current owner.

Hotel Tippu Sulthan has been in business for the past two centuries. Sadly, it does not get the attention it deserves," says Stephen Jacob, a local historian. He also adds that the hotel's ownership has changed hands numerous times. Abdul, its current owner, has been running the outlet



for the past three decades. If you are wondering how the eatery got its name, Salim, an autorickshaw driver and one of its regular patrons, has a plausible theory. "The name was suggested by a muralist who adorned the walls of Fort Kochi with Quranic passage," he says.

The nominal rates are not the only distinguishing factor. This much was clear from our visit to the establishment on one rainy afternoon. There are several dishes served here that are found nowhere else.

"For breakfast, you get beef chaps made from young cattle meat. It's a great side for appam, porotta or maniputtu (the Fort Kochi term for string hoppers)," says Salim. The Fort Kochi resident is also all praise for the chilli beef roast, which he says has a fanbase of its own. "You can't find a restaurant that serves this variety of delicious dishes at such reasonable prices," Salim adds.

The Erachichoru (meat rice) is another dish to relish at Tippu's. This plate of spicy rice and the well-cooked, flavourful meat mixed with a sweet, tangy date pickle offers a symphony of flavours. However, what sees the most patrons at this dimly lit

Biryani. As quick bites to accompany your piping hot chai, the glass shelf here is loaded with Vettucake, Bonda, Pazhampori, Vada and Kozhukatta (sweet coconut dumplings).

Everything is made fresh at Tippu's. They can you do that without at least a refrigerator... That is enough assurance for anyone about the food's quality, isn't it?" comments Hussain, Salim's friend.

The place is always packed. "Our regular customers include the locals, autorickshaw drivers, and ferry operators. Also, tourists who like to relish some traditional dishes and soak in some history," says Abdul. Back in the day, staff of The New Indian Express, too, were regular patrons, adds Salim. This was when the daily's office was on the premises of Aspwinwall House on Calvathy Road.

In the recent past, Aspinwall House was the venue of the Kochi-Muziris Biennale, an international art festival. "The atmosphere during the time of the Biennale is always amazing. Tourists from in and out of the country visited Fort Kochi then and enjoyed good business. The cancellation of this year's Biennale is certain to hurt several establishments like ours in the area. But thankfully, we have a perennial patronage of the locals," Abdul says.

Abdul wishes that the government does their fair bit to keep centuries-old structures like Hotel Tippu Sulthan intact."The road in front of the restaurant has been under construction for almost three years.

The State government issued GO 571 allotting survey numbers to the land reclaimed from the sea, and works will begin as soon as permissions from Chief Commissioner of Land Administration (CCLA) are secured. He visited the land suitable for the aqua park setup and gave necessary instructions to the officials. In the coastal district, the majority of the population in Repalle, Nizampatnam, Bapatla, Karlapalem, Chirala, Vetapalem, Chinaganjam, Nagaram, Bhattiprolu, and other regions depend on aquacultue, which is spread over 21,400 acres. The aqua products of the district are very famous worldwide, with varieties of fish and prawns worth Rs 2,250 crore exported to over 52 countries. Aqua farmers, in order to get

quality seeds of various varieties of fish and prawns, had to travel all the way to Chennai, Pondicherry, Rameshwaram, and Ramanathapuram in Tamil Nadu, bearing high transport costs. Opining that setting up an aqua park would reduce investment costs, T KrishnaPrasad, an aqua farmer in Chinaganjam, said that it would prevent the hassle of travelling to other States in search of quality seed. With the processing units, farmers would get good selling prices for their produce, he added. Though the project has been on the cards for the past couple of decades, it was delayed for various reasons. After a long wait, the foundation stone for the construction works was laid in May 2023 by former chief minister YS Jagan Mohan Reddy. The aqua park will be developed as one of its kind in the entire country, producing rare seaweeds and ornamental fish available only in the sea. Food processing units, hatcheries of rare species, and a knowledge centre to educate farmers on the latest technology in use in aquaculture will also be set up. The aqua park will contribute to the growth of the transport, economic. and tourism sectors in the region and provide direct and indirect employment to over 1,000 people. Aqua tourism will get a boost with the setup of sports fish in over 50 acres.

# Bitter pill to swallow: HIV patients complain about new batch of drugs

CHENNAI: People living with HIV (PLHIV) from Tamil Nadu have raised complaints about the extremely bitter taste of a new batch of HIV drugs, procured and distributed by the National AIDS Control Organisation.

PLHIV said they have severe concerns over the quality of fixed-dose combination tenofovir/ lamivudine/ dolutegravir (TLD) supplied to the National AIDS Control Programme (NACP).

This combination is crucial for antiretroviral therapy (ART) to suppress viral load, thereby saving lives and preventing HIV transmission. Positive Women Network, a community organisation working for women with HIV, wrote a letter on the same to the Union Health Ministry, which was signed by around 200 people from the state. The organisation stated in the letter that the community urged the Ministry of Health and Family Welfare, National AIDS Control Organisation (NACO) and Central Drugs Standard Control Organisation (CDSCO) to conduct

thorough quality control tests on the On the bitter taste of drugs, a 22-year-old tablets, revise tender requirements to mandate CDSCO registration for suppliers of antiretrovirals (ARVs) under the NACP tenders, in addition to state licensing agencies."We urgently



request CDSCO's intervention to address potential issues with substandard drugs being supplied to NACP. This issue not only affects public health but also jeopardises the lives of millions of PLHIV who rely on these ARVs provided free of cost at the ART centres nationwide," the letter

man told TNIE, "This has been the issue for the past one-and-a-half months. Earlier, the drugs were tasteless." A 13-year-old schoolgirl said she could not tolerate the

bitterness in the beginning, but she was forced to take the pill and was now beginning to 'adjust' to it.A 42year-old woman, who has been taking ART drugs for over 10 years, said she could not bear the newly found bitterness in the drugs."It tastes like biting into a raw bitter gourd. Children are on the verge of crying when it is time to take the tablets, but they have no choice," she said.Positive Women Network president (Chennai) Kousalya Periasamy said there have been complaints from the PLHIV community regarding the quality of the tablets over the last few months.

"Earlier, the patients faced the issue of drug disintegration. Now, it has a strong bitter taste. They never faced such issues with previous supplies,' she added.

**HYDERABAD**: Taking suo motu cognisance of the spate of stray dog attacks, the Telangana High Court on Thursday directed the Animal Birth Control (ABC) committee, established by the state government, **COIMBATORE:** A worker from to develop effective measures to prevent such cases. involving the Greater Hyderabad Municipal Corporation (GHMC), the state government, animal welfare organisations, and the ABC committee to address the issue effectively. "We must find a way to stop these tragic incidents," he stated. Additional Advocate General Imran Khan informed the court that the state government, in coordination with the GHMC, was striving to mitigate the stray dog menace, which has become increasingly frequent. He reported there are 3,79,156 stray dogs in the state and acknowledged that while sterilisation can reduce the dogs' aggressiveness, it alone is not a complete solution. The case was adjourned to July 31.

### Kerala: Barriers at Aroor, Thuravoor to curb heavy vehicles using the stretch

KOCHI: The Alappuzha district collector has instructed the National Highways Authority of India (NHAI) to construct height-restriction barriers at Aroor and Thuravoor to curb heavy vehicles from using the Aroor-Thuravoor stretch. The collector highlighted that despite the decision to divert heavy vehicles from Ernakulam and Kollam districts via MC Road, some still use the Aroor-Thuravoor stretch, causing damage to the newly renovated road and significant traffic congestion. The report was submitted to the Kerala High Court in response to a directive to outline steps taken to reduce traffic blocks, following the construction of the Aroor-Thuravoor

elevated highway. The report said, following the HC directive, a meeting was convened under the leadership of Agriculture Minister P Prasad, attended by district collectors of Alappuzha, Kollam and Ernakulam, along with police officers of the three districts. The meeting decided to prohibit long-route heavy vehicles from using the Aroor-Thuravoor construction area. The Aluva Rural SP has been tasked with diverting heavy vehicles moving south from Thrissur via Angamaly to MC Road. Vehicles from the Ernakulam area heading south will be diverted from Kundannoor towards MC Road. Vehicles bypassing the diversion points would be stopped before the

Kumbalam toll plaza and redirected via Kundannoor to MC Road.eavy vehicles heading towards Ernakulam from Kollam would be diverted from Kottiyam, Chavara, Titanium Junction, and Karunagappally. The Alappuzha district police chief was assigned to divert heavy vehicles from Kavamkulam, Nangyarkulangara, and Ambalappuzha towards Ernakulam. The DPO, Alappuzha, has issued instructions to ensure police personnel are on duty around the clock in Ambalappuzha and Aroor.

The report also said the construction company has been instructed to expedite work by utilising Saturdays, Sundays, and, if necessary, Mondays. The company was also tasked with promptly removing accumulated mud from the road and constructing footpaths alongside the single-lane traffic. The single-lane traffic road on the eastern side is completed, and footpath construction on both sides has commenced.

# Budget must aim for inclusive development

THE first Budget of the new government is being prepared in the backdrop of continuing tensions in the geopolitical arena. The Russia-Ukraine war and the Israel-Hamas conflict show no signs of abating. The domestic economy may be growing in a sustained manner at around 8 per cent, but the outlook may alter, depending on the stability of the external environment. Finance Minister Nirmala Sitharaman must be hoping that global oil prices would remain subdued and that Western economies emerge from recessionary trends that have affected export growth. Keeping international accordance for the contraction of the contractio international ocean lanes free from strife will also be critical to avoiding an undue rise in costs of inbound or outbound trade. Clearly, the external headwinds have the potential of playing spoilsport with the India growth story. It is, therefore, essential that the Budget keep the focus on strengthening key sectors like infrastructure and services while supporting agriculture and the rural economy in equal measure. On the infrastructure front, policymakers would do well to maintain the steep rise in capital expenditure recorded over the past few years. The 2024-25 Interim Budget scaled down the earlier 30 per cent rise in capex to about 16.9 per cent, but a higher increase is warranted, given the vast infrastructure gap in the country. Though this may not create a huge number of skilled jobs immediately, it will undoubtedly have a longterm impact on employment creation. The fact that the Reserve Bank of India has transferred Rs 2.11 lakh crore to the Central Government exchequer gives it considerable cushion to continue in this direction during the current fiscal as well.he Budget will also need to move towards creating an easier climate for private investment, which has been lagging behind the public sector. While policies already in place — such as the production-linked incentive schemes — will give a boost to manufacturing, procedures need to be further streamlined. The regulatory environment has certainly come a long way since the 1991 economic reforms. But comparisons with the past are no longer relevant. Comparisons now need to be made with other emerging economies. Countries like Vietnam and Indonesia are offering simpler and easier investment regimes, an attraction for multinationals to set up base there. India, in contrast, is not looking so appealing.

Domestic investors have to contend with higher capital and logistics costs. Yet, the main hurdle for both domestic and foreign investors remains the plethora of clearances needed to set up new projects. These issues are now largely at the level of the states or even local municipalities. Bringing the ease of doing business down to this level needs to be part of next-generation reforms.

An indication that this is already being considered lies in the economic statement issued with the 2024-25 Interim Budget in February. It referred to improving governance at the block, district and village levels. A one-time loan to states, amounting to Rs 75,000 crore, was also offered for growth and development-oriented reforms. The focus areas were identified as health, education, skilling and land acquisition.

he only snag in this plan is that not all states will cooperate despite the availability of loans to carry out reforms. BJP-ruled states are bound to comply with directives from the Centre, but the same response may not be forthcoming from other states. The aim of kickstarting next-generation reforms may, thus, be only partially successful. At the same time, some states, especially in the southern region, already seem to have streamlined regulatory processes. The result is that investors are making a beeline for them. For instance, tech giants like Apple and Microsoft are locating new projects primarily in Tamil Nadu, Karnataka and Andhra Pradesh. Policies adopted by these states need to be studied and replicated in others.In this context, budgetary provisions need to be made for the critical segment of education and skilling. While job creation is bound to be high on the government agenda, the fact is that many sectors are facing a shortage of skilled personnel. There is also a mismatch between the type of education and the specific skills needed by the industry. Long-term policy prescriptions should be formulated to resolve this issue but, in the short run, the upcoming Budget can provide adequate allocations for skling institutes.

# India needs a strategic approach to hybrid warfare

Leveraging its inherent strengths, India can put adversaries at a disadvantage and fortify its strategic stance against hybrid threats.

IN the evolving landscape of modern warfare, India must adapt to the concept of hybrid warfare to strengthen its defence and deterrence strategies. Hybrid warfare, characterised by a blend of conventional weapons, irregular tactics, cyberattacks and other unconventional methods, requires a nuanced and resilient approach to effectively counter the multifaceted threats from its adversaries. According to NATO, hybrid threats combine military and non-military as well as covert

and overt means, including disinformation, economic pressure, deployment of irregular armed groups and the use of regular forces. "Hybrid methods are used to blur the lines between war and peace, and attempt to sow doubt in the minds of target populations. They aim to destabilise and undermine societies... the speed, scale and intensity of hybrid threats have increased in recent years," observes the US-led alliance.The cornerstone of India's strategy should be resilience. Leveraging its inherent strengths, India can put adversaries at a disadvantage and fortify its strategic stance against hybrid threats. Eschewing the traditionally rigid distinctions between conventional and irregular warfare, India's approach should recognise the continuum of conflict, integrating various methods and modes of warfare.

India's western border with Pakistan is a significant area of concern. Pakistan has been accused of engaging in hybrid warfare tactics, including sabotage, terrorism and cyberattacks, particularly in regions like Jammu and Kashmir and Punjab. Recent incidents underscore the gravity of the threat. In a deadly encounter in Doda, four Army soldiers, including a Captain, were killed earlier this week, bringing the total number of personnel killed in the region to 48 over the past 32 months. The joint operation by the Army and the Jammu and Kashmir Police highlights the persistent danger of crossborder terrorism. The Army has claimed that a number of measures have been instituted to enhance synergy between various agencies, such as joint training with the J&K Police and Central Armed

Police Forces and "a robust intelligence-sharing mechanism between the Army, the police and other The insurgency landscape within India also demands intelligence agencies". The rise of narco-terrorism and the use of drones for cross-border insurgency reflects the evolving nature of this hybrid conflict. Pakistan's support for proxy forces, terrorist organisations and drug cartels poses a severe threat to India's security. The blending of advanced military capabilities with irregular tactics has been a persistent issue, necessitating preparedness to



deflect these 'wars in the shadows' while enhancing collective defence capabilities.On the northern front, India's relations with China present a different set of challenges. China's strategy includes psychological, political and legal tactics collectively known as the 'three warfares' — to achieve its geopolitical goals. The Chinese investment in the United Front Work Department to influence the Chinese diaspora and foreign communities, along with the use of front organisations, exemplifies its hybrid warfare strategy. Beijing's increasing use of commercial security operations to protect its interests abroad, coupled with its blurred tactics and quasi-military forces in the maritime domain, underscores its innovative approach to hybrid conflicts. The likelihood of indirect and proxy Chinese intervention is a growing concern, particularly as China expands its influence across Asia and beyond. attention. The spate of terror attacks in the Jammu region and the continued unrest in Manipur highlight the internal challenges. Additionally, the Naxal insurgency in central India remains a significant threat, with numerous attacks on security forces and civilians. In response to the rising terror incidents, Prime Minister Narendra Modi has

reviewed the security situation, discussing counter-terrorism efforts with top officials. The situation in Punjab is also concerning, with increased activities of narco-terrorism and drone infiltrations from Pakistan necessitating a robust response.



# Global IT outage hits flight ops in India, airlines urge fliers to reach early

A disruption in Microsoft's cloud services hit booking and check-in services of several airlines, including IndiGo, **Akasa Airlines** and SpiceJet.

New Delhi: A major disruption in Microsoft's cloud services led to widespread flight delays in India on Friday, with Delhi, Bengaluru, Kolkata, Pune and Mumbai airports facing the maximum brunt. Not only airlines, businesses, including banks, telecom companies, TV and radio broadcasters were affected after blue screen of death error screens were seen on Windows workstations across the globe. The outage hit booking and check-in services of several airlines, including Air India, IndiGo, Akasa Airlines and SpiceJet. Several airlines resorted to manual

check-in and boarding processes at the airports and requested passengers to reach the airport early. While Mumbai's Chhatrapati Shivaji Maharaj International Airport reported an average delay of 51 minutes, Delhi's IGI Airport saw its services being delayed by nearly 40 minutes. Air India said its systems were "impacted temporarily"



due to the Microsoft outage resulting in delays.Budget airline SpiceJet said it was facing a technical issue in providing updates on flights. "Our team is actively working to resolve this issue," the airline posted on X. Akasa Airlines said some of its online services

would be temporarily unavailable at the LONG QUEUES, ANGRY PASSENGERS Mumbai and Delhi airports. "Due to infrastructure issues with our service The incident left several passengers in the

### Top points on Chandigarh-Dibrugarh Express

A special train with 600 passengers of the Chandigarh-Dibrugarh Express, which derailed on Thursday, has left for Assam, an official told news agency PTI. The train departed from Mankapur, Uttar Pradesh.

The Centre has announced an ex-gratia of Rs 10 lakh for the family of the deceased, Rs 2.5 lakh for those who suffered grievous injuries, and Rs 50,000 for those with minor injuries. In the aftermath of the derailment, the Railways Ministry has initiated a high-level probe into the incident. Chief Public Relations Officer, North Eastern Railway, Pankaj Singh, stated that the probe would verify the driver's claims that a minor explosion occurred before the derailment. A commissioner of railway safety has also been ordered to look into the matter.

Following the derailment, the Congress on Thursday called on Prime Minister Narendra Modi and Railway Minister Ashwini Vaishnaw to take responsibility for the "significant lapses". It also urged the rapid installation of the Kavach anti-collision system on all railway routes.

After the incident, passengers came out of the emergency windows and doors of the sleeper coaches. In the AC coaches, passengers broke the window panes and pulled out those injured or stuck. The passengers had to wade through kneedeep water in the fields on either side of the track to reach the nearby approach road.

# Massive Microsoft outage hits flights, banks, stock exchanges, broadcasters

New Delhi: A massive Microsoft outage unleashed havoc on computer systems across the world, grounding flights and crippling banks, stock exchanges, payment systems and emergency services. Microsoft, in a tweet, said that "Multiple services are continuing to see improvements in availability as our mitigation actions progress". The outage is possibly due to the failure of Crowdstrike Falcon, a cybersecurity platform that provides security solutions for Microsoft Windows.

The disruptions continued hours after Microsoft said it was fixing the issue.In India, the outage caused widespread disruptions in flight operations, payment systems, and trading, among other services. Flight delays were reported across airports, leading to long queues. The outage affected booking and checkin services for several airlines, including IndiGo, Akasa Airlines, and SpiceJet.The central government, taking cognisance of



the cyber outage, stated that it is in discussions with Microsoft to resolve the Authorities in Spain reported a "computer issue. The Ministry of Electronics and Information Technology is likely to issue an advisory on the outage.

### AB Group to enter jewellery business next week

NEW DELHI. Billionaire Kumar Mangalam Birla-led Aditya Birla Group is all set to enter the branded jewellery market with the launch of Novel Jewels on July 26, almost a year after it first announced its intention to foray into this consumer-facing business. This would be Birla's second big debut into a new vertical after it entered the paint business with Birla Opus earlier in March.Birla will now be competing in a market that has a strong presence of other conglomerates such as Tata Group-owned Tanishq and Reliance Jewels. The other big players in the organized market are Kalyan Jewellers, Malabar Gold, Joyalukkas Jewellers and Senco Gold. In June 2023, the Group had announced its entry into the branded jewellery retail business.Backed by an investment of Rs. 5,000 crores, this new venture is called 'Novel Jewels'. Novel has aims to build large exclusive jewellery stores featuring in-house jewellery brands across India. In the paint business, Birla had committed an investment of Rs 10,000 at the time of launch. Currently, the jewellery industry stands as one of the largest in India, contributing 7% to the nation's GDP. Aditya Birla Group had earlier said that with India's jewellery industry projected to reach \$100 billion by 2027, this presents an opportunity for them to be 'big in the life' of consumers and transform the way India purchases its fashionable jewellery. For decades, India's jewellery landscape has been dominated by the unorganised sector, primarily consisting of local standalone jewellery stores. However, this trend is undergoing a radical shift in favour of national branded jewellery chains. From constituting a mere 5% of the jewellery market in 2005, branded players now make up an impressive 35% of the market.

### Government to establish PMU to oversee BSNL's 4G rollout

NEW DELHI.Telecom minister Jyotiraditya Scindia announced on Thursday that the government is establishing a project monitoring unit (PMU) to oversee 4G rollout of state-owned Bharat Sanchar Nigam Limited (BSNL).

Speaking on the sidelines of the India Mobile Congress and WTSA, the minister assured that he would monitor the progress on a daily basis. "I'm not going to give you the targets today; it's all in my head. Today, all I can commit to you is that, along with Tejas, BSNL, and C-Dot, and with all our players together, we are forming a Project Management Unit (PMU).

This PMU will not set monthly targets or weekly targets. I have mandated them to set daily targets, and those



daily targets will be monitored by myself and the secretary. So, I will commit to you that, at the earliest, and when I have that project chart ready, I'll be more than happy to share it with you," he said.

In 2023, BSNL cleared a contract of Rs 24,500 crore to a consortium led by TCS, including C-DOT and Tejas Networks, to provide 4G equipment for 100,000 new telecom towers. The company has activated 3,500 40 base transceiver stations (BTS) and will soon launch commercial 4G services.

### Big blow to crypto industry as WazirX falls victim to \$235 million hack

BENGALURU. WazirX, which is the country's largest cryptocurrency exchange by volume, on Thursday paused INR and crypto withdrawals temporarily as it suffered a security breach. According to Web3 security firm Cyvers, \$234.9 million of funds have been moved to a new address. WazirX said it is aware that one of its multi-sig wallets has experienced a security breach. "Our team is actively investigating the incident," the crypto exchange said. Crypto storage provider Liminal Custody in a statement said its preliminary investigations show that one of the self-custody multisig smart contract wallets created outside of the Liminal ecosystem has been compromised.

'We can confirm that Liminal's platform is not breached and Liminal's infrastructure, wallets and assets continue to remain safe. It is also pertinent to note that all WazirX wallets created on the Liminal platform continue to remain secure and protected. Meanwhile, all the malicious transactions to the attacker's addresses have occurred from outside of the Liminal platform," the storage provider said. Users have now questioned the safety of their funds on the exchange. This hack is a big blow to the country's crypto industry, which started showing signs of recovery only in recent times."Even though WazirX is our competitor in the Indian market, I am sad to know about the incident. It's not good news for the Indian web3 ecosystem," said Neeraj Khandelwal, co-founder, CoinDCX.Krishnendu Chatterjee, co-founder and CEO of A2Z Crypto, said, the Indian government should urgently look into regulating crypto, by separating the role of exchanges/VDAs from custodians."If most of the funds were kept under custody (with proper insurance), this kind of scenario might be averted as insurance providers will have covered for any hacks. Only with proper regulation, can investor protection be guaranteed," he said.Edul Patel, CEO of Mudrex, pointed out this incident underscores the importance of continuous monitoring and robust compliance frameworks to protect investors and ensure the integrity of the crypto ecosystem.

As of June 10, 2024, at 6:30 PM, WazirX's total holdings stood at Rs 4,203.88 crore, which is a 79% surge compared to January 2023. WazirX, which has over 16 million users, released Proof of Reserves for June 2024 recently and said it is facilitating transactions across over 350 cryptocurrencies and 700 market pairs.

According to experts, the 4% (+-2) inflation target mandated to the Reserve Bank of India (RBI) is difficult to achieve and it also keeps interest rates higher.



There might be some announcement on inflation targeting on July 23. A group of economists have suggested Sitharaman to revisit inflation targeting. There seems to be unanimity among those ecoomists," one of the sources told TNIE.

As per experts, increasing the inflation target from 4% to 6% can benefit common people by lowering borrowing costs and boosting spending. For investors, it may lead to asset value growth and profit opportunities.

"The central government assigns the

inflation target that the RBI has to pursue. The inflation targeting regime, having been in operation for nearly a decade, probably needs a re-evaluation, especially after continued high interest rates due to inflation above 4%," said Charan Singh, founder and CEO of EGROW Foundation.

The last 30-year average shows the inflation generally hovers between 5.5% and 6.5%. India has a potential to grow 10% but persistent high rates could be detrimental to growth and employment

the efficacy of the existing target of 4+/-2%," Singh argued. As per former Chief Statistician of India, TCA Anant, it is a valid consideration for the government to reassess the legislative mandate established in 2016 regarding inflation targeting and contemplate adjusting target to encompass both Wholesale Price Index (WPI) and Consumer Price Index (CPI).Dr Ashwani Mahajan, an economics professor and national coconvenor of Swadeshi Jagran Manch, says there has been a major disparity in recent years between the Consumer Price Index (CPI) and WPI, with CPI consistently higher than WPI. "Despite WPI remaining in the negative zone in the last financial year while CPI stayed elevated, the Monetary Policy Committee (MPC) adhered to CPI-focused inflation targeting as per its mandate. The Reserve Bank of India (RBI) has maintained the repo rate at 6.5% since January 2023, even with WPI showing lower or negative figures," he argues.Meanwhile, Madan Sabnavis, Chief Economist at Bank of Baroda said, based on average inflation in the past, 5% looks a fair number.

weak performance in the first quarter of FY25. The company assured that revenue and profitability will improve, with growth in merchant payment operating metrics including GMV, accelerated merchant reactivation and growing merchant base, along with continued focus on cost optimisation.Paytm announced its intention to focus on market leadership through merchant payment innovations, including the

introduction of new devices and the aggregation of various merchant discount rate (MDR)-bearing payment instruments. The company also plans to allocate additional resources to its insurance and mutual fund distribution segments, which present significant monetization opportunities.Paytm spokesperson said, "We are seeing a rebound in our merchant operating metrics and stability in our consumer
