

Sanjay Kumar New Delhi, July 3: With some Lok Sabha members resorting to sloganeering during oath taking, Speaker Om Birla has amended the rule which now bars MPs-



elect from adding any remark to the oath as members of the House. Birla added a fresh clause to 'Direction 1' to the 'Directions by the Speaker' for regulating certain matters related to the functioning of the House that are not specifically provided in the rules. According to the amendment to 'Direction 1', the new clause 3 now states that a member shall make and subscribe oath or affirmation,

and "shall not use any word or expression or make any remark as a prefix or suffix to the form of oath or affirmation". The amendment came against the backdrop of several members raising slogans like "Iai

Samvidhan" and 'Jai Hindu Rashtra' while taking oath last week. One member had also raised the slogan 'Jai Palestine', which too was objected to by several mem-

bers. The Speaker had urged the members to stick to the prescribed format but in vain. Parliamentary Affairs Minister Kiren Rijiju alleged several members used the solemn occasion of taking oath or making affirmation to send a political message. The slogans also led to a war of words between the treasury and the opposition benches on June 24 and - 25.

Discussions around AI regulations ongoing

New Delhi, July 3: Union Minister Ashwini Vaishnaw on Wednesday said discussions on AI regulations are on and a political consensus would be required. The Minister for IT and Electronics further said all sections of society must fully understand the threats and potential of Artificial Intelligence (AI). "...only then we should approach legal action," he told reporters on the sidelines of 'Global IndiaAI Summit'. Asked about the timelines for India to carve out regulation and guardrails on AI, the minister said while discussions are ongoing, political consensus would be needed. "Discussions are on... it requires political consensus," he said. Speaking at the event, Minister of State for Electronics and IT Jitin Prasada asserted that India stands ready at the forefront of AI innovation. "As the council chair of Global Partnership on AI, India has been reinforcing its commitment to furthering and democratising AI, and its associated benefits, ethically and responsibly," he said. Prasada said that India's vision is to "make AI in India" and "make AI work for India". He called for collaborative efforts to develop solutions for AI to solve problems and challenges in key sectors such as healthcare, agriculture and education

Pointing out serious lapses in aircraft operating areas at airports

Chandigarh, July 3: Listing out serious lapses such as operators falling asleep while on duty, faulty equipment and non-adherence to standard operating procedures among reasons for increasing number of safety related incidents at airports involving aircraft, vehicles and ground equipment, the Directorate General of Civil Aviation (DGCA) has issues fresh instructions on 'apron safety management'. The instructions, containing a list of 25 guidelines on prevention of apron/ramp related incidents, have been revised about 17 years after they were last issued by the regulator in December 2007. "Investigations have revealed that drivers or equipment operators have fallen asleep while operating in the apron area resulting in hitting a person, airport structure, aircraft or other vehicles," a circular issued by the DGCA on June 1 stated. Nonadherence of operating procedures by the ground staff, drivers, equipment operators, maintenance and refuelling personnel, air traffic control officers and aircraft operating crew is among the causative factors identified by DGCA on the basis of analysis of ground incident data. Faulty ground support equipment and its poor maintenance, equipment malfunction, poor or inadequate training, inadequate supervision, fatigue or increased duty hours and inclement weather are other factors listed out by the DGCA for such incidents. Apron or ramp is an important part of an aerodrome operational area where a host of activities including manoeuvring and parking of aircraft, fuelling, loading and unloading and maintenance are undertaken. It involves movement of vehicles, equipment and personnel in proximity to aircraft. Pointing out that ground collisions in the apron area can have serious conse quences, DGCA said that apron safety has been identified as one of the national high risk categories in the National Aviation Safety Plan. DGCA has stressed upon all aerodrome operators and stakeholders to establish apron safety teams, ensure that ground staff is properly trained with conducive duty hours and adequate rest, and that proper signs, markings and lighting are in place for aircraft parking areas, taxiways and service lanes.



New Delhi, July 3: The CBI arrested an alleged co-conspirator in the NEET-UG paper leak case, Aman Singh, from Dhanbad in Jharkhand, officials said on Wednesday. The CBI had developed intelligence about Jharkhandbased module allegedly involved in the paper leak that resulted in the arrest of Singh, they said. The agency had earlier arrested the principal and vice principal of Hazaribagh-based Oasis school in the case and two persons who allegedly provided safe premises to NEET candidates where burnt question papers were recovered by Bihar Police, the officials said. The CBI has registered six FIRs in the case. The FIR from Bihar pertains to leakage of paper while remaining from Gujarat and Rajasthan pertain to impersonation of candidates and cheating. The agency's own FIR on a reference from the Union Education Ministry pertains to a "comprehensive investigation" into alleged irregularities in the medical entrance examination. NEET-UG is conducted by the National Testing Agency (NTA) for admissions to MBBS, BDS, AYUSH and other related courses in government and private institutes.

Champai Soren resigns as Jharkhand CM, Hemant Soren stakes claim to form government

Ranchi, July 3: Jharkhand Chief Minister Champai Soren on Wednesday resigned from his post, following which IMM leader Hemant Soren called on Governor CP Radhakrishnan and staked claim to form the government. Earlier in the day, leaders and MLAs of the ruling coalition at a meeting at Champai Soren's residence here unanimously decided to elect Hemant Soren as the JMM legislature party leader. "I have resigned as per the decision of the JMM-led alliance. Our alliance is strong." Champai Soren said after coming out of Raj Bhavan. "All know what had happened with Hemant Soren Ji...I was given the responsibility by the coalition partners. Now, the alliance has decided in favour of Hemant Soren Ji," he said. Hemant Soren was released from jail on June 28 after nearly five months, after the high court granted him bail in a money-laundering case

colleague, Champai Soren, resigned from the top post. Soren (48), the executive president of the Jharkhand Mukti Morcha (JMM), was arrested by the ED on January 31 from the Jharkhand Raj Bhavan in Ranchi, just after he resigned as the chief minister.

CBI court sentences man to life imprisonment for killing 2 **CMOs in Lucknow**

New Delhi, July 3: A special CBI court in Lucknow on Wednesday sentenced a man to life imprisonment for killing two chief medical officers of the Uttar Pradesh family welfare department in 2010 and 2011, officials said. The court also imposed a fine of Rs 58,000 on convict Anand Prakash Tiwari who was hired by YS Sachan, the then deputy CMO in the UP family welfare department. Two other accused in the case, Vinod Sharma and RK Verma, were acquitted by the court for lack of evidence. The CBI had claimed that various issues related to the alleged expenditure of NRHM funds were the motive behind the killings. Chief Medical Officers VK Arya and BP Singh were killed while on a morning walk in the posh Gomti Nagar area of Lucknow in 2010 and 2011, respectively. They were shot dead by bike-borne assailants six months apart - October 27, 2010, and April 2, 2011. It was alleged that Sachan had hired "contract killers", including Anand

Prakash Tiwari, to eliminate Arya and Singh, a CBI spokesperson said in a statement. "In both the cases, investigation by the local police had found involvement of YS Sachan. However, he was not charge-sheeted due to his death during the investigation," the statement said. Sachan was found dead in a Lucknow prison toilet on June 22, 2011, with deep cuts on his hand. The CBI, which probed his death, had filed a closure report claiming he had died by suicide. The agency had said although there were deep cuts, there was "no injury on inaccessible parts" and there were no cuts on his clothes. During the course of an investigation into the killings of the two CMOs, the CBI examined 45 prosecution witnesses, exhibited various documents and cross-examined four defence witnesses. After filing the charge sheet in 2012, the CBI had said, "Sachan conspired with others and hired two shooters through a contractor, all based in Uttar Pradesh."

Andhra Pradesh: Black Plum prices plummet in Annamayya district

TIRUPATI: Jamun, also known as Java plum and black plum, which fetched between Rs 280 to Rs 300 per kg last season, is being sold between Rs 40 to Rs 60 at Madanapalle market in Annamayya district, creating severe concerns among the local horticulturists. The dwindling prices, driven by oversupply and production, have exacerbated the plight of the farmers who have invested significantly in the crop and expected similar prices to last season. Some spent lakhs of rupees on protective measures to ensure a high-quality yield. However, the reality has diverged sharply from expectations. Untimely rains during the critical pesticide spraying period have rendered many treatments ineffective, and fruit flies along with other pests have severely damaged the crop in numerous areas.Additionally, early rains have also played a part in spoiling the expected bumper crop and leading them to premature fall, fruit fly infestations, and blemishes on the fruit.

Black plum was cultivated on around 1,500 acres across Annamayya district. The jamun is known for its medicinal value. The fruit is being exported to Hyderabad, Chennai, Vijayawada, Guntur and also to other parts of the country. The Madanapalle black plum market, which has been expanding annually similar to the tomato market, attracts produce from the united Chittoor and Anantapur districts, as well as bordering areas of Karnataka. The season began on May 15 with optimism, as prices remained favourable until the end of the month. However, the onset of rains in June, ranging from light showers to moderate downpours, caused the fruits to split and fall prematurely.

The share of Ezhava community, with 1.15 lakh government employees, stood at 21.09%. There were 73,774 employees from the Muslim community, constituting 13.52% of the total government employees.As per data tabled in the assembly, there are 73,714 forward Christian employees in the state service, denoting a share of 21.01%. The representation of Latin Catholic employees was 22,542 with an overall share of 4.13%. The data also showed that there were 2,399 employees who converted to Christianity and another 929 employees belonging to the Nadar Christian community. If all four sections of Christian employees are taken into account, they constitute 18.25% of the total government staff. While there were 51,783 employees from the Scheduled Caste, the number of Scheduled Tribe employees stood at 10,513. Another 955 employees said they did not belong to any

Kerala government amends order to justify action against teachers from Changanassery

THIRUVANANTHAPURAM: The row over the 'punishment' transfer of five women teachers of a government school in Changanassery to various districts in northern Kerala, has turned murkier with the government hastily amending its earlier order to remove references that would imply that the action was taken allegedly due to political pressure. While listing out various reasons for the transfer of the teachers on June 25, the order by the Director of General Education (DGE) contained a reference that Changanassery MLA Job Maichil had demanded that the teachers were "not taking classes properly" and they "need to be transferred". This was mentioned in the report submitted by the Regional Deputy Director (Higher Secondary), Kottayam, and was part of the transfer order.

The initial transfer order of the DGE also had references indicating that the MLA intervened in the day-to-day functioning

"complaints" that they could not follow the classes, were cited as the reasons for the transfer.As per the initial transfer order, teachers handling English,

Physics, Commerce, Botany and Hindi subjects had "collectively ignored the directions of MLA Job Maichil and functionaries of the School Management Committee (SMC) and the Parent Teacher Association (PTA)." The order also cited that the five teachers had not cooperated with "measures to improve the results of their respective subjects."

After the transfers turned controversial, the DGE has issued a new order removing all references to the MLA in the entire episode. Other remarks that the teachers were found "sleeping in the staff room" and that they indulged in "activities unbecoming of the teacher's post" were

Karnataka HC denies bail to Udupi quadruple murder accused

BENGALURU: The Karnataka High Court rejected the bail petition filed by the accused in the Udupi quadruple murder case, considering the technical evidence relied on by the prosecution.Justice MG Uma passed the order dismissing the petition of Praveen Arun Chougule (40) from Mangaluru, saying he is not entitled for bail, considering the seriousness of the offence. The accused, who was an employee at a private airline when the crime took place, was arrested on November 15, 2023, for murdering Aynaz, an air hostess, and three of her family members. A chargesheet against Chougule was filed by the Malpe police. "Even though there are no eyewitnesses to the incident, the prosecution is relying on all these circumstantial evidence, which are strong



enough to point an accusing finger at the accused at this stage. The prosecution is also relying on CCTV footage showing the movement of the accused," said Justice Uma, while rejecting bail.As per the

submission made by Additional State Public Prosecutor Jagadeesha BN and government advocate Rahul Rai K, the accused was identified in the test identification parade, the sketch matched with him by up to 98 per cent, his hair sample found on one of the bodies matched with his DNA, and his blood-stained clothes matched the DNA of the deceased. Also, the car of the accused, which had a location tracker, showed the movement of the vehicle on the day of the incident and the previous day, when he had gone near the house of the victims. There was also an exchange of audio, photo and text messages between the petitioner and one of the deceased whom he liked. The victim had later blocked his WhatsApp number and all text messages had not reached her.

Karnataka to launch statewide online booking for trekking routes by July

MANGALURU: Karnataka Minister for Forest, Environment and Ecology Eshwar Khandre has said that online booking will be introduced for all trekking routes in the state from July third week in order to regulate the process.

Speaking to reporters after a review meeting of Mangaluru circle of the Forest Department, Khandre said that the department has already introduced online booking for Kudremukh, Netravathi and other trekking peaks in Mangaluru circle and the same will be extended across the state.A software, which provides online booking for all trekking spots in a single website, is being developed and it will be ready in a fortnight, the minister said. The new system is aimed at putting an end to irregularities in the booking system by streamlining the process, he said. Khandre



said the Forest Department has set a target to plant 5 crore saplings in Karnataka this year and the work has already begun. Last year, 5.43 crore saplings were planted against the target of 5 crore. Chief Minister Siddaramaiah has promised an additional grant of Rs 100 crore for this purpose, Khandre said. 15k cases pending, but new laws are set to make forensic experts busier

NEWS BOX

Gurgaon: The introduction of the new criminal laws is set to increase the workload of forensic experts because cases in which sections warrant punishments of seven years or more will need teams to mandatorily initiate a crime scene investigation.

- Haryana, as of now, has 17 mobile units of six forensic scientists each who visit crime scenes in the state's 22 districts and police commissionerates. While Gurgaon has two such units, the larger districts have one each. But there are some that share a team of experts - Nuh and Palwal, for instance. With more than 15,000 cases pending at the state forensic science laboratory in Madhuban and four regional facilities in Gurgaon, Hisar, Rohtak and Panchkula, the teams have their task cut out.fficials said a proposal to sanction six additional mobile forensic units was pending with the finance department."Now that the new criminal laws have been implemented, the need for teams to go on spot visits will definitely increase. We are expecting our workload to double. But unless we hire more staff and procure testing kits, investigations are bound to get delayed," a senior officer said.ven before the new laws came into effect, forensic teams would visit crime spots, but they weren't mandatory. In most instances, scientists were called by investigating officers if the crime was heinous in nature, like a rape or murder.
- For cases lodged under IPC and CrPC sections, the presence of a forensic expert was not mandatory at the scene of crime. But for all grave offences, such as sexual assault, murder, and those lodged under the NDPS Act, investigating officers would seek the help of forensic experts. In burglaries too, scientists visited the site. But these were only on a case-to-case basis," said Yashpal, a spokesperson for Faridabad police.
- "But now, forensic teams must go on field visits if the offence is punishable with a jail term of seven years or more. The mandatory visit is under Section 176 (3) of BNSS, which replaced CrPC," he added.
- In the first six months of this year, mobile forensic teams visited 3.366 crime scenes across the state
- Of these, 1,376 were related to cases involving punishments of at least seven years.So, how does a forensic team investigate a scene of crime? The sixmember mobile unit collects any kind of biological and serological evidence that may give leads about the accused — hair, semen, blood, saliva or fingerprints. The team takes photos of the scene and collects narcotic samples if required. The pieces of evidence are put in specific bags and tagged, and a list is prepared for the investigating officer.

1.2k cr for infra upgrade, but owners of illegal 4-floor bldgs to face 10x penalties

Gurgaon: The state govt has announced infrastructure upgrade in all sectors and colonies, and allowed release of Rs 1,179 crore under infrastructure augmentation charges (IAC), which was earlier collected by DTCP, HSVP, HSIIDC and ULB department against approval of stilt-plus-four floor plans.Residents, who have been opposing four-floor buildings, claimed their biggest concern is lack of key infrastructure - road, electricity, sewerage and drainage — which doesn't support four dwelling units per plot. In the 1990s, when most of the city's licensed colonies were being developed, the infrastructure was developed keeping in mind construction of two-anda-half floors on each residential plot. Over three decades later, the population has doubled but the infrastructure, however, remained unchanged, which led to a burden on civic amenities.

Crack in windshield, pellet spark gunshot fears in Noida condo

Noida. A crack in a car windshield and a pellet found nearby sparked fears of gunshots possibly being fired at Prateek Wisteria in Sector 77. While police believe the crack could have been caused by an airgun, investigation is still underway to determine the cause, an officer said on Tuesday.According to additional DCP Manish Mishra, the damage was first noted by a security guard at the society who informed the owner. The car's owner, Deepika Garg had not used the car for the last four days. When she saw the damage, she reported the incident on the police.Immediately, police teams, along with the Forensic Science Laboratory (FSL) team rushed to the spot and cordoned off the area. A pellet or bullet casing was also recovered from near the car," the additional DCP said.Garg filed a police complaint in the matter, following which an FIR was registered under section 324 (4) of the

Bhartiya Nyaya Sanhita at the Sector 113 police station. This section addresses acts of mischief causing losses between Rs 20,000 and Rs 1 lakh."The crack was likely caused by an airgun. Monsoon here but little rain as clouds drift off to foothills

Gurgaon: Southwest monsoon completed its route on Tuesday to cover north India, according to the India Meteorological Department (IMD). But besides the 100mm and 0.5mm rain on Friday and Saturday, respectively, there has been no major rainfall so far. IMD had predicted moderate to heavy rainfall from Sunday till Thursday.

Experts said that the region might not be getting much rain for the next few days as the monsoon clouds are currently around the foothills of Himalayas. IMD has already issued a yellow alert in the state till July 5. The monsoon season in India is a crucial time for agriculture as well as economy. The arrival of the southwest monsoon marks the beginning of the rainy season, which is essential for the growth of crops and the replenishment of water resources. Inadequate or excessive rainfall can lead to crop failures, affecting food security and livelihood of farmers.

Mahesh Palawat, an official at Skymet Weather, told TOI, "There is a lack of heavy rains in Delhi-NCR due to the current position of the monsoon clouds — around the foothills of the Himalayas. This means that the region might not receive much rain in the coming few days. The transition phase of the clouds was very fast in the past days, so they did not linger over the region for an extended period, resulting in the absence of heavy rain so far."The minimum temperature on Tuesday dropped by 2.5 notches. 

Pre-poll survey predicts landslide victory for Labour Party in UK polls

London. Britain's Labour Party is set to sweep to power with a record number of seats at Thursday's national election, a forecast by polling company Survation showed on Tuesday.Survation's central scenario showed Keir Starmer's Labour winning 484 of the 650 seats in parliament, far more than the 418 won by the party's former leader Tony Blair in his famous 1997 landslide win and the most in its history.The Conservatives, who have been in power for the last 14 years, were predicted to win just 64 seats, which would be the fewest since the party was founded in 1834. The right-wing Reform UK party were projected to win seven seats. The Survation analysis used the Multilevel Regression and Post-stratification (MRP) technique that estimates public opinion at a local level from large national samples. Pollsters describe it as a model that uses polling data, rather



than a poll itself.

Other MRP analyses have shown smaller margins of victory for Labour, but none have shown a different overall outcome.Earlier, a regular poll by Redfield and Wilton Strategies which measured vote share nationwide showed a slight narrowing in Labour's lead, but still put the party on course for a comfortable victory.

US Regulator Approves Eli Lilly Drug For Early Alzheimer Treatment

Washington The US Food and Drug Administration (FDA) approved a drug made by Eli Lilly on Tuesday that is designed to treat the early symptoms of Alzheimer's disease. The drug known as Kisunla should be used by "patients with mild cognitive impairment or mild dementia stage of disease," the FDA said in a statement announcing its decision to approve the drug. "Patients treated with Kisunla demonstrated a statistically significant reduction in clinical decline," and a range of other criteria, it added.

- Kisunla, which is the brand name for the drug donanemab-azbt, joins only a handful of other drugs currently approved by the US regulator to treat Alzheimer's, which currently affects more than 6.5 million Americans
- "Kisunla demonstrated very meaningful results for people with early symptomatic Alzheimer's disease," Eli Lilly executive vice president Anne White said in a statement published by the US pharmaceutical company."We know these medicines have the greatest potential benefit when people are treated earlier in their disease, and we are working hard in partnership with others to improve detection and diagnosis," she added. The approval rating of Biden, 81, has plummeted after his dismal debate performance in Atlanta last week against his predecessor Donald Trump

US Vice President Kamala Harris has a better chance of retaining the White House in the November presidential polls than her boss President Joe Biden has, according to a latest poll.Biden's approval rating has plummeted after his debate debacle in Atlanta last week against his predecessor Donald Trump, CNN reported. Since the debate, there has been increasing voices in the ruling Democratic party for Biden to step down and let someone else run the race for the crucial November 5 presidential elections.



Trump is ahead of Biden by six points. The poll also finds Harris, who is of Indian and African heritage, within striking distance of Trump in a hypothetical matchup: 47 percent of registered voters support Trump, 45 percent Harris, a result within the margin of error that suggests

there is no clear leader under such a scenario."Harris' slightly stronger showing against Trump rests at least in part on broader support from women (50% of female voters back Harris over Trump vs. 44% for Biden against Trump) and independents (43% Harris vs. 34%

Biden)," the polls said. White House Press Secretary Karine Jean-Pierre refrained to give a direct comment on the polls."I'm constrained to speaking directly to your poll and I get it and I hear the question. I got to be mindful, that is something for the campaign as you started saying, what the campaign has laid out their argument of the case. That is something for them to take up and that is something for them to answer," she told reporters when asked about it.

Biden says he 'almost fell asleep' during debate with Trump, blames jet lag

World US President Joe Biden has DEBATE admitted that he "almost fell asleep" during the disastrous debate with his Republican rival Donald Trump last week and said his feeble performance was due to jet lag from travelling "around the world a couple of times, going through around 100 time zones" before the event.

The 81-year-old's acknowledgement came amid pressure from Democrats after his poor performance at the debate, as well as growing questions about his cognitive ability to continue in office for four more years if he returns to power following the election in November."I didn't have my best night. I wasn't very smart. I decided to travel around the world a couple of times, going through around 100 time zones before the debate," he said while addressing a campaign event on Tuesday in McLean, Virginia."Didn't listen to my staff and came back and nearly fell asleep on stage ... That's no excuse, but it is an explanation."

According to a Reuters report, Biden travelled to France and Italy in a span of just two weeks in June, and then flew



overnight from the G7 Summit in Bari, Italy to Los Angeles where he appeared at a fundraiser with former US President Barack Obama.

Ahead of the June 27 debate, he spent six days at Camp David -- the country retreat for a US President near Washington D.C -- in preparation for the event. While White House officials have blamed Biden's poor performance on a cold, his re-election campaign is making all-out efforts to downplay the age factor.Biden, who is already the oldest serving American President, would turn 82 by the time he is sworn in next year if he wins the November 5 election.On Tuesday, a new Reuters/Ipsos poll revealed that one in

three Democrats thought Biden should end his re-election bid following the debate. The survey also found the 78-year-old Trump and Biden maintain the support of 40 per cent of registered voters, suggesting that the latter has not lost ground since the debate.Meanwhile, a CBS News poll released on Monday found that 45 per cent of Democrats want Biden to step aside. Lloyd Doggett, a Democratic lawmaker

in the House of Representatives, became the first in the party to publicly call for Biden to step down, saying the President's debate debacle had failed to "effectively defend his many accomplishments".In a statemet on Tuesday, Doggett said, "My decision to make these strong reservations public is not done lightly nor does it in any way diminish my respect for all that President Biden has achieved."Recognising that, unlike Trump, President Biden's first commitment has always been to our country, not himself, I am hopeful that he will make the painful and difficult decision to withdraw.

Trump's sentencing in hush money case delayed to September, weeks before US polls

Washington Donald Trump's sentencing for his conviction on criminal charges stemming from hush money paid to a porn star was delayed on Tuesday until September 18, less than seven weeks before the US election.Justice Juan Merchan pushed back the sentencing date so he can weigh the former US president's argument he should have been immune from prosecution under Monday's landmark Supreme Court ruling that presidents cannot be criminally prosecuted for official acts. The new timeline means Merchan could decide the Republican presidential candidate's punishment, including whether to jail him, in the thick of the campaign season before the November 5 election. The sentencing had previously been set for July 11, just days before the July 15 kickoff of the Republican National Convention in Milwaukee. Trump faces an uphill battle getting the hush money conviction overturned, since much of the conduct at issue in the case predated his time in office.

Frump's lawyers on Monday asked Merchan to allow them to argue his conviction should be overturned due to the justices' 6-3 ruling on July 1, which also held that evidence related to presidents' official actions cannot be used to help prove criminal cases involving unofficial actions. Prosecutors with Manhattan District Attorney Alvin Bragg's office said earlier on Tuesday that Trump's argument was "without merit," but agreed to delay the sentencing to give Trump the chance to make his case.A Manhattan jury on May 30 found Trump guilty of falsifying business records to cover up his former lawyer Michael Cohen's \$130,000 payment to adult film actress Stormy Daniels to stay quiet about an alleged 2006 sexual encounter until after the 2016 election, in which Trump defeated Democrat

US Supreme Court rejects teen sex abuse victim's bid to revive **Snapchat** lawsuit

WASHINGTON. The US Supreme Court declined on Tuesday to hear a Texas teen's bid to revive his lawsuit accusing Snapchat owner Snap of failing to protect underage users of its social media platform from sexual predators - in this case, a female teacher who pleaded guilty to sexually assaulting him. The justices turned away up an appeal brought by the plaintiff, who was not identified by name in the case because he was a minor when it was filed, after lower courts dismissed his lawsuit. Lower courts found that Snapchat was shielded by Section 230 of the Communications Decency Act, which safeguards internet companies from liability for content posted by users. Conservative Justices Clarence Thomas and Neil Gorsuch said they would have granted the appeal.The case involves a relationship between Bonnie Guess-Mazock, a high school science teacher who was 36 at the time it started in 2021, and the plaintiff, who was 15, in the Texas city of Conroe, about 40 miles (65 km) north of Houston.Criminal charges were brought against Guess-Mazock, who was sentenced to 10 years in prison after pleading guilty to sexual assault of a child, according to court filings. The plaintiff in the lawsuit accused Guess-Mazock of using Snapchat - known for its disappearing photos and videos - to groom him by sending him sexually explicit content. Over nearly a year and a half starting in 2021, Guess-Mazock sexually assaulted him until the abuse was discovered when he overdosed on drugs she either provided or paid for, the lawsuit alleged. In 2022, Doe sued Guess-Mazock, the local public school district and Snap. Only his claims against the Santa Monica, California-based company, seeking unspecified monetary damages, were at issue in his appeal to the Supreme Court. The plaintiff's civil lawsuit alleged three counts of negligence against Snapchat under Texas law. He accused the company of breaching its legal duty to protect its minor users "from sexual predators who are drawn to the Snapchat application by the privacy assurances granted by the disappearing messages feature of the application."Houston-based US District Judge Lee Rosenthal in 2022 dismissed the suit against Snapchat, finding the company was shielded by Section 230.

Police use tear gas as 'Ruto must go' chants heard at tax hike protests in Kenya

→ Protesters in Kenya have condemned police brutality amid deadly demonstrations over the withdrawn tax bill, call for president to resign.

Nairobi. Riot police fired tear gas grenades and charged at stone-throwing protesters in downtown Nairobi and across Kenya on Tuesday in the most widespread unrest since at least two dozen protesters died in clashes a week ago. The nationwide demonstrations signalled that President William Ruto had failed to appease a spontaneous youth protest movement, despite having abandoned plans for tax rises that triggered the unrest last week.Tuesday's demonstrations began in ebullient mood but turned violent as the day wore on. In Nairobi's downtown business district, police wearing helmets and carrying shields and wooden clubs charged at the protesters, and tear gas



bombs exploded crowds.BEAUTIFULDAY' in the

"We are determined to push for the president's resignation," said Ojango Omondi, an activist in Nairobi. "We hope for a peaceful protest and minimal casualties, if any.

The authorities appealed for calm.

"It's a beautiful day to choose patriotism. A beautiful day to choose peace, order and

the sanctity of our nationhood," State House communications director Gerald Bitok wrote on X on Tuesday, adding in Swahili: "Violence is not patriotism." Opposition leader Raila Odinga, runner-up in the last four presidential elections, backed the protesters though they have called on politicians to keep out of it. "The youth have given our country its last best chance," Odinga's ODM party said in

a statement. "We either seize it and swim with it by implementing all their demands, or we ignore it and sink the country altogether."The protests, which started as an online outpouring of anger over nearly \$2.7 billion of tax increases in a proposed finance bill, have grown into a nationwide movement against corruption and misgovernance.

Ruto has directed the treasury to come up with ways to cut spending to fill a budget gap left by the withdrawal of the tax plans, and also said more borrowing would be required.Veteran anti-corruption activist John Githongo told Reuters that while Ruto had addressed the nation and media, "there isn't an indication that he wants to take action" on protesters' demands, including firing corrupt officials.

'There hasn't been any indication by the government that they are going to take the calls to deal with corruption seriously," he said.The protests had been mostly peaceful until June 25, when some demonstrators briefly stormed parliament and set part of it ablaze, prompting police to open fire.

Ruto has defended the actions of the police and blamed the violence on "criminals' who had hijacked the demonstrations.





HYDERABAD: The Telangana High Court on Tuesday questioned the state government whether it had any mechanism or statutory provision to save greenery, conserve trees and maintain the ecological balance in the state, especially in urban areas. A bench of the High Court comprising Chief Justice Alok Aradhe and Justice Anil Kumar Jukanti directed Additional A-G Imran Khan to inform it by Thursday. The bench was dealing with a PIL filed by K Pratap Reddy complaining that the state government and local bodies like GHMC and municipal corporations are failing to provide adequate green spaces / park areas / recreational areas for the citizens. He said that it is a failure of the state, and violation of citizens' fundamental rights including the rights guaranteed by the Constitution. The petitioner requested the court to direct the authorities and the state government to ensure adequate maintenance of the existing public parks / green spaces and to identify and demarcate the land for development of public parks invarious urban centres of the state.Gorantla Sri Ranga Pujitha, counsel for the petitioner, submitted that indiscriminate felling of trees in rural and urban areas was leading to erratic rainfalls, recurring famines and floods, soil erosion and consequent ecological disturbances. The bench commented that the people living in the towns and cities are moving in a concrete jungle and there was a need for parks and greenery and said that the state must bring the provision to preserve the existing greenery and to ensure the new greenery and to maintain them properly.Justice Aradhe cited that the neighbouring state has a statutory provision called Karnataka Preservation Of Trees Act, 1976, which regulates the felling of trees and the planting of adequate numbers to restore ecological balance.

For BJP, Katchatheevu is only an election-time rhetoric, says Stalin

CHENNAI: Chief Minister MK Stalin on Tuesday charged that despite coming to power for the third consecutive term, the BJP-led union government has not made any tangible and meaningful effort to retrieve Katchatheevu except using the issue as election-time rhetoric.Stalin made this charge while expressing serious concern over an unprecedented increase in the instances of the arrest of fishermen from Tamil Nadu by the Sri Lankan Navy in recent weeks. Kerala: Organ harvesting racket did not pay promised compensation to donors

KOCHI: The donors who fell prey to the recently busted global organ trafficking racket were not paid the promised compensation despite the recipients paying the amounts demanded by the racket, police investigation has revealed.Kalamassery resident Sajith Shyam, 43 -- the third accused in the case -made these revelations during the interrogation. He admitted to transferring the funds collected to a

medical tourism firm operated by the prime suspect, Madhu Jayakumar, in Kochi. This firm, which posed as a medical tourism enterprise, was a cover for illegal organ transplants, sources with the police confirmed.Sajith is learnt to have told investigators that donors were promised up to Rs 6 lakh per organ, but the police found that the racket charged recipients up to Rs 50 lakh in some cases. While four persons have been arrested so far, Madhu

Jayakumar remains at large, according to the police. The investigators have found a broad criminal conspiracy behind the organ trafficking. Charges of activities, a source said. The racket was uncovered with the arrest of Valappad resident Sabith Nasar from Kochi airport on May 19. Sabith confessed to facilitating the travel of 20 Indians to Iran for organ harvesting. His confession led to Sajith's implication in the case. Sajith admitted to acting as an interlink between Madhu and the organ donors. The police found evidence of significant financial transactions, illegally

collected from the recipients, and frequent phone calls between Sajith and Madhu.Sajith and Madhu are childhood friends, with Sajith claiming that Madhu told him he was running a medical business in India and Iran. Some clients could not transfer money directly to Madhu's account, so they

transferred it to Sajith who then forwarded it to Madhu. However, the police believe Sajith had prior knowledge of the criminal activities

Guntur Municipal Corporation begins pipeline repair works to supply safe water

GUNTUR: In an initiative to provide safe drinking water, the Guntur Municipal Corporation (GMC) is undertaking significant water pipeline repair works across the city. With the population exceeding 1 million, the city's daily water requirement is 135 million litres, while 155 million litres are currently supplied. This supply includes 132 MLD from Undavalli Prakasam Barrage and 23.20 MLD from Sangam Jagarlamudi Kommamuru Canal, distributed to 43 reservoirs in 57 divisions. Engineering department officials have been instructed to inspect all reservoirs, storage points, and main pipelines from Undavalli to Takkellapadu and Sangam Jagarlamudi to MLR.

They are to carry out any necessary renovations and ensure the quality of the work. Frequent pipeline leakages have led to significant water wastage, causing shortages for residents.

Responding to numerous public complaints and petitions, the GMC council has allocated Rs 37.02 crore in the 2024-25 budget to ensure the supply of safe drinking water. An action plan has been prepared to undertake repair works across the city. This includes fixing the 800 mm dia water pipeline and 600 mm dia water pipeline that supply Guntur West constituency and the 685 mm dia water pipeline near the filtration plant that supplies the entire city from the Sangam Jagarlamudi plant. Additionally, officials have been directed to conduct ward-level inspections and address any minor pipeline repair works without delay.

Union Minister Dr Pemmasani Chandrasekhar recently highlighted the issue of insufficient drinking water, especially in merged villages and tail-end regions, during a review meeting with civic officials. He instructed civic chief Kirthi Chekuri to expedite the pipeline repairs to ensure safe drinking water is supplied citywide.

People evicted for Ukkadam flyover seek houses

MUMBAI. A youth strangled his girlfriend to death and left her house to end his life but did not dare to do so. This made him go to the Kabrastaan (graveyard) sat beside his mother's grave in Andheri (East) for over five hours before his father located him and handed him to the Sahar police station at 12.30 pm on Sunday.

Police said the 22-year-old youth named Zaib Khawaja Solkar strangled his 18- year-old girlfriend, Sara Sayyed, to death in her flat at Ashok Tower in Marol Naka, Mumbai at 4.30 after she, a Class XII college student, allowed him access to her bedroom through the backdoor late on Saturday night.

Sayyed's father and younger brother, aged around 14, were asleep in the hall, unaware of Solkar's presence due to the locked bedroom door. "Solkar, who is pursuing an AC mechanic course after completing Class XII, confessed to having a fight with the victim after spending some time together. He used Sayyed's dupatta (scarf) to strangle her," said a police officer of the Sahar police station.

In the morning, Sayyed's family found her motionless and rushed her to the hospital, where she was declared dead on arrival. Police said after committing the crime, Solkar left the flat through the back door and purchased rat poison from the Chimanpada locality in Andheri (East).

Solkar said he tried to kill himself but did not dare to consume the poison. "This made him go to the graveyard and sit beside his mother's grave before his father tracked him. Solkar and the victim have known each other for the last three years. They even had a verbal fight on social media three days ago before he killed her early morning on Sunday," said the police. Police booked Solkar under the Indian Penal Code section 302 (murder) and took him into custody for five days.COIMBATORE: Over 200 people, including sanitary workers who are residing in temporary sheds at Pullukadu, staged a dharna at the Coimbatore City Municipal Corporation (CCMC) head office on Tuesday. They demanded the civic body to vacate the traders and demolish the old fish market building and hand it over to the Tamil Nadu Slum Clearance Board at the earliest to construct a new housing unit for the 520 families who lost their houses for the Ukkadam flyover project.

The Ukkadam-Aathupalam flyover project works were started in 2018 in Coimbatore. In order to make way for the flyover's ramps, several houses and old housing units at CMC Colony in Ukkadam were demolished and the officials promised the people that they would construct a new housing unit in the same area and provide them with temporary sheds in Pullukadu. Though six years have passed, the officials have not provided them with proper housing facilities. Due to this, over 200 people residing in the sheds arrived at the CCMC head office and staged a dharna.Sumathi, one of the affected people said, "It has been over five years since we vacated our houses and moved into temporary sheds. Still, there has been no solution. Some of them had no option but to move out and rent another house as the sheds began to leak and turned to be unsafe for children and adolescent girl children.

Aditya-L1 achieves milestone with first Woman's body parts exhumed 15 years halo orbit around L1 point, ISRO confirms after she went 'missing' in Kerala BENGALURU: Aditya-L1, India's maiden mission to the Sun launched on September 2, 2023, has completed its first halo orbit around the Sun-

Earth Lagrange 1 point, ISRO announced on Tuesday. The observatory satellite was inserted into its targeted halo orbit on January 6, 2024. The spacecraft has taken 178 days to complete a revolution around the L1 point. This extraordinary feat and crucial manoeuvre was possible because of the state-of-the-art flight dynamics software developed inhouse at UR Rao Satellite Centre (URSC) in Bengaluru. Completing the orbit has made the software fully reliable, and validated the capability of Aditya-L1 missions. The spacecraft took a precise threedimensional trajectory. The final firing of the thrusters on July 2 placed the spacecraft back in the required orbit. If an accurate firing was not done, the spacecraft would have moved away from the designated orbit. Through a graph, ISRO also showed if the critical manoeuvre hadn't worked, what divergent path Aditya L1 would have been on."It underwent two station-keeping manoeuvres on February 22 and June 7, respectively, to maintain this orbit. Today's 3rd station-keeping manoeuvre has ensured that its travel continued into the revolution around the L1 point second halo orbit path around L1," said ISRO in a statement.During its travel in the halo orbit, the Aditya-L1 spacecraft was subjected to various strong and unsettling forces that caused it to depart from the targeted orbit.Scientists explained that the journey of Aditya L1 around the Sun-Earth L1 Lagrangian point involves modelling complex dynamics."Understanding of various perturbing forces acting on the spacecraft helped in determining the trajectory accurately and planning precise orbit manoeuvres," said the space agency.Aditya-L1 carries seven payloads to observe the photosphere, chromosphere and corona of the Sun using electromagnetic and particle detectors. The mission aims to provide crucial insights into solar physics and space weather and moreover.

ALAPPUZHA: It sounds like an episode out of a crime thriller series. Acting on a tip-off, police on Tuesday exhumed body parts, suspected to be of a woman who went missing 15 years ago, from the septic tank of her husband's home at Eramathoor, near Mannar. The exhumed body parts will now be sent for forensic examination and DNA test, and only after that it could be ascertained whether they were of Kala, Chaithra said. Anil, who was engaged in small-time construction works, and Kala, belonging to different castes, fell in love and got married despite opposition from his family. After the marriage, she stayed at the house of Anil's relative. After one year, she gave birth to a son. Later, Anil went to Angola for his job.After being alerted by

relatives that Kala was having an affair with a youth, Anil flew back. On the pretext of sorting out the issue through discussion, he took her to Kuttanad, and strangled her with the help of his accomplices inside the vehicle, the DPC said.Anil concocted a story that Kala eloped with her lover, abandoning her son. Everyone, including Kala's relatives, believed the story. However, her brother filed a missing complaint. The police failed to trace her. Anil married again and the couple has two children. He reconstructed the old house but did not destroy the old septic tank. He went to Israel for work a few months ago. After receiving the anonymous letter, the police reopened the file and took some relatives of Anil into custody and it led to the arrest of others.Soman, a relative of Anil, Suresh, Pramod, Santhosh, and Jinu Rajan are under police custody.

BENGALURU: Despite the ban on single-use plastic carry bags, large quantities of such used bags are seen strewn across towns and cities. Further, prohibited plastic carry bags are in circulation in the name of biodegradable ones. Taking note of this, Forest, Environment and Ecology Minister Eshwar Khandre has directed the Karnataka State Pollution Control Board (KSPCB) officials to drop or amend the plastic waste management rules. He also directed them to follow the rules introduced by the Union Government on using biodegradable carry bags that dissolve within 180 days.Khandre had held a meeting with the officials earlier, sought to know why prohibited plastic carry bags are still in use. He told them to take steps and ensure that biodegradable vegetable poly liquid acid polymer bags are manufactured and sold. The minister asked the officials to submit a report on adopting the Central Environment Department's Plastic Waste Management (Amendment) Rules, 2021-22. When the officials explained that bags made of maize extract, will dissolve within six months, Khandre said if it is proved scientifically, then permission could be ranted to manufacture them for public use.Principal secretary of Ecology and Environment, BP Ravi told TNIE that new rules are being framed and they will be sent to the urban development and finance departments for approval. Later, they will be sent to the state cabinet. "The driver of the truck abandoned the vehicle and fled the scene. The truck was seized and a case has been registered," Venkata Ramana said. "The incident of a lorry hitting a school bus near Kavali today has left me deeply worried. Sadly, a cleaner died in the accident. The authorities have been ordered to provide immediate better treatment to the children injured in the accident. School managements should keep their buses in condition and be vigilant about the fitness of the buses."Expressing shock over the incident, Nellore MP Vemireddy Prabhakar Reddy described the death of the cleaner as heartbreaking. He voiced serious concern over the injuries suffered by the children and assured government assistance for the bereaved family. The MP also pledged enhanced medical support for the injured students.

Agnipath scheme has led to an acute shortfall **in manpower**

ANY systemic transformation that relies on 'after the fact' mechanism to rectify errors is inherently flawed. The Agnipath scheme stands out as one such example. The scheme was ceremoniously rolled out two years ago. Touted to transform the recruitment process of 'personnel below officer rank' (PBOR), it has sought to cut down the burgeoning pension bill and ensure a youthful profile of other ranks in the armed forces. The scheme has faced resistance from young aspirants passionate to join the armed forces. Periodically, it has been in the news and, of late, there is a strong demand across the spectrum for its holistic review

The Agnipath idea draws from the 'Tour of Duty' (ToD) concept, which is widely prevalent in Western armies to overcome the shortage of optants for the military service. It was Gen Bipin Rawat, then Chief of Defence Staff (CDS), who conceived the idea of introducing ToD in our armed forces. The original plan was to test-bed the proposal by recruiting small numbers. However, the scheme was apparently pushed through unilaterally. It is evident from the reported disclosures in the book Four Stars of Destiny by a former Chief of Army Staff, Gen MM Naravane, wherein he describes the scheme as a 'bolt from the blue' for the three services.

Currently, under the scheme, Agniveers in the age group of 17.5 to 21 years and with Class X/XII qualification are recruited for a period of four years after six months of training. Only 25 per cent of them are to be retained and re-enrolled for a period of 15 years on fresh terms of service, with entitlement to pension and post-retirement benefits. Those released are to be given a severance package — Seva Nidhi — of Rs 10 lakh. The total number of defence pensioners is about 24.62 lakh; of them, armed forces veterans constitute around 19 lakh and civilians 5.62 lakh.Going by the figures of 2022, when the Agnipath scheme was introduced, the defence budget wasRs 5,25,166 crore, of which the pension outlay wasRs 2,07,132 crore. While the share of defence personnel stood at Rs 1,19,696 crore, the civilian component was Rs 87,436 crore, the latter accounting for a disproportionate 40 per cent share of the pensionary budget. The adverse impact of the scheme is evident from the fact that individuals seeking an honourable career in the armed forces, many in keeping with family traditions, are now looking for alternative avenues, with the Central Armed Police Forces (CAPF) being the top choice. I have witnessed this trend in my home state of Punjab. There is also a general feeling among the Agniveers that those released will bear the stigma of being discards and not be seen as proud veterans. Given the high rate of unemployment, particularly among the youth, the released Agniveers are unlikely to get a decent job; the idea of lateral placement into the CAPF is far-fetched.Recently, there were two instances of Agniveers who made the supreme sacrifice while deployed in operational areas. Their kin were entitled to only a lump sum compensation as against those of the regular soldiers who are eligible for full pension. This discrimination stands out as a serious anomaly.In the units today, there are two categories of soldiers: the regulars and the Agniveers. There is an unhealthy competition and obvious stress among the Agniveers in their quest to qualify for retention. It is indeed detrimental to the camaraderie and esprit de corps, the bedrock of unit culture and regimentation, the cutting edge f our armed forces as against the better-equipped adversaries. Incidentally, the performance of 'tourist soldiers' has been found wanting — be it Americans in Vietnam and Afghanistan, Israelis in Gaza and troops in the Russia-Ukraine war. Even the Chinese army conscripts have performed poorly in Ladakh during the ongoing standoff.Agnipath has led to an acute shortfall in manpower; while the yearly retirement count is around 70,000, the Agniveer intake is just 42,000. With 25 per cent retention, the deficiency is set to grow further.

Biden's debate fiasco deals a blow to his campaign

Russia has been the steadiest of India's allies, both in the best and the worst of times. The bilateral relations just cannot be undermined or weakened.



THERE are wars raging in Gaza and Ukraine, and tensions are running high around Taiwan and the Philippines. You may not believe it, but perhaps the gravest crisis that the world may face could be in the US, which is looking like it could elect a narcissist, liar and convicted felon as its President this November.

Millions of Americans saw President Joe Biden on debate night on Thursday, delivering his answers in a hoarse, faltering voice, slack-jawed and struggling to string his thoughts together. The performance has set off alarm bells ringing across the world. Instead of focusing on his substantial achievements as the President, we have been forced to look at the issue of his age.Biden's aides had hoped that the debate would help steady their somewhat slow-moving campaign. Instead, it may have undermined it completely. Since then, there have been calls by prominent voices for Biden to step aside to enable a younger candidate to take his place.Debate disasters are not new. But what makes this a first-class crisis is the fact that it could propel Donald Trump back into the White House. Almost all the commentary noted that Trump's attacks on Biden were often false and mostly misleading. But all he had to do was be Donald Trump. The damage was done to Biden by himself.

Given his felony convictions, other looming cases and his history, Trump is unfit to be the President of the US.

But he is what we will get, given the current circumstances. Biden supporters believe that the President has the opportunity to make up for the fiasco by improving his performance in the next debate in September. But given that things are going his way, why would Trump want any further debates?

Just 14 hours after the debate, Biden addressed a campaign rally in Raleigh, North Carolina, where he was forceful, confident and landing hard political punches on Trump and the Republicans. Unlike in the debate, he gave categorical and clear outlines of his positions on abortion, immigration, taxes and race. But does this suggest that Biden could still turn things around? It's too early to say. Over the years, the Biden team has carefully managed his sleeping hours, his walk to the Marine One helicopter and his climb aboard aircraft to mute concerns over his age. But the debate performance last week has shattered the efforts to show Biden at his best. Insiders say that Biden performs best between 10 am and 4 pm. But the debate began at 9 pm and went on till 10.30 pm.

Biden accepted at the Raleigh rally that his debate performance was poor. "I know I am not a young man. I don't walk as easy as I used to. I don't speak as smoothly as I used to. I don't debate as well as I used to," he told the crowd. But that is precisely the point: age is a factor. As of now, his allies are publicly

supporting him. This includes his former boss, ex-President Barack Obama, and a clutch of potential candidates who could replace Biden were he to step aside -- Transportation Secretary Pete Buttigieg, Governors JB Pritzker of Illinois, Gavin Newsom of California, Wes Moore of Maryland and Gretchen Whitmer of Michigan.

One major advantage is that the debate happened in June, when four more months are left for the elections. In terms of the US presidential election cycle, it is early, and it offers an opportunity for Biden to turn things around. Other events can and will take place in the US and around the world until November, dulling the impact of Biden's debate performance last week. Large numbers of Americans simply do not focus on elections until a week or two before polling. You can be sure, though, that Republicans will use videos of Biden's performance to keep memories of the debate alive through attack ads.Biden versus Trump is all about the election. And despite poor polling numbers, Biden still has a fighting chance to beat Trump. But the debate performance has thrown a bright light on the issue of Biden's age and raised doubts about whether he is capable of managing the presidency till 2029, when he will be 86. This central question, which is linked to the important decision on whether he should step aside for another candidate, demands answers, and soon. The Democratic National Convention will be held in August, and Biden could well show the electorate in the coming month that he is indeed fit to continue. But if he is unable to do so, the delay would make it difficult for the party to find another candidate to take over the campaign and win.

The Democratic Party rules make it almost impossible to replace Biden at the top of the ticket unless he voluntarily steps aside since most of the 4,000 estimated delegates are pledged to him already.

Biden could step aside, even while endorsing an alternative. But the issue would inevitably divide the Democrats at a crucial time when they need to be united not just for the presidential campaign but for the elections to the entire House of Representatives, onethird of the Senate, several governorships and state legislatures. The Democrats are hoping they can retain their Senate majority and win the House of Representatives as well. Both Houses have slim majorities, and the races there are almost as important as winning the presidential poll. The problem they now face is that the presidential worries could also adversely affect these other important elections.

THE three new criminal laws came into effect on Monday amid a verbal duel between the ruling BJP and the main Opposition party, the Congress. The former described the laws as a symbol of India's progress and resilience, while the latter accused the government of getting them forcibly passed in Parliament after the suspension of 146 MPs. The Congress has declared that the INDIA bloc will not allow such 'bulldozer justice' to prevail in the parliamentary system. The government has repeatedly stressed that these statutes — Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Adhiniyam - will give priority to providing justice and protecting rights, arguably in contrast to the draconian colonial laws which laid emphasis on penal action. However, the Opposition is not convinced. Nor are some legal experts, who have raised concerns over possible misuse of the laws. There are also

apprehensions about a surge in litigation in the form of appeals seeking re-evaluation of the existing cases (registered before July 1, 2024) or a review of the new legal framework. Even as a chaotic rollout is only to be

to get everyone on board. Implementing the new laws is a huge challenge for law enforcement agencies, judicial officers and legal professionals. Litigants, too, will have to confront new complications. Clarity and transparency hold the key to reducing uncertainty as well as confusion. The powers that be will have to work very hard to prevent the fiasco of the three farm laws, which were repealed after a year-long protest by farmers.



THE Lok Sabha elections have set the stage for a series of critical elections globally. The Iranian presidential election was held on June 24 to find a successor to President Ebrahim Raisi, who was killed in a helicopter crash in May. With none of the candidates getting at least 50 per cent of the votes, there will be a run-off between the top two contenders.In France, after his party's rout in the European parliamentary elections, President Emmanuel Macron ordered a domestic parliamentary election. Huge gains by the far-right National Rally party of Marine Le Pen are being projected. The two-phase polls will end on July 7.

- The UK is also poll-bound after Indian-origin Conservative Prime Minister Rishi Sunak ordered early parliamentary elections. A massive win for the Labour Party after 14-year Tory rule is foreseen, with Keir Starmer tipped to be the PM.
- The most significant election is of the US President in November. The opening debate between President Joe Biden and his predecessor Donald Trump was held by CNN on June 27. An incoherent and defensive Biden faced a glib and dissimulating Trump. They sparred over the economy, immigration, abortion and the Ukraine and Gaza wars. This churn in established democracies, the ascendancy of far-right parties in Europe, the possibility of Trump's re-election and Iran throwing up another conservative President raise questions about the state of the liberal democratic order. In 1989, Francis Fukuyama wrote in The National Interest that the world faced the 'end of history'. He later explained that with the Berlin Wall's fall in November 9, 1989, change appeared inevitable in the Soviet Union and Warsaw Pact nations. The Western model of a liberal democratic state tied to the market economy appeared universally acceptable. However, liberal democracies across all continents appear challenged today. Public disillusionment is being shaped by globalisation's inequitable benefits and immigration-induced

xenophobia, feeding the rise of far-right parties. In India, populist and majoritarian politics has been moulded by bigotry and jingoism. The scenario is complicated by the wars in Ukraine and Gaza. The Indian poll results brought relief to the G7 nations. The democratic recession in India and the repressive use of agencies against the Opposition have elicited criticism from the Western media and even by parliamentarians.

But the lure of Indian markets and the Indian role as a counterweight to China compelled foreign leaders to hold their noses and engage India transactionally. The BJP's loss of parliamentary majority and dependence on allies, at least theoretically, is expected to restore constitutionalism. But the ruling party's initial moves, like the renomination of Om Birla as the Speaker despite his poor record, has dampened hopes.

President Biden is in the damage-control mode after his disastrous performance in the debate with Trump. The Iran-China-Russia axis would have observed this as well as the increased possibility of Trump's return. Russian President Vladimir Putin would take solace in Trump reiterating his ability to end the Ukraine war quickly. That implies

acceptance of the status quo by Ukraine. European Union (EU) states would also brace for turbulent trade and strategic ties with a Trump-led US.There is speculation that if French President Macron's gamble goes awry, he may resign. Le Pen has moderated her party's stand on some issues, compared to her more radically right-wing father's views. She is even endorsing military support to Ukraine. However, her party remains sceptical about the benefits of the EU. After the Brexit blow by Britain in February 2020,

another exit or even a debate about it would weaken the group. The Conservative Party is projected to lose the July 4 British parliamentary elections. If elected, the Labour Party will inherit a weak economy and post-Brexit disillusionment. But its leader Keir Starmer has moved the party to the political centre, like Tony Blair in the 1990s. Labour has announced a 'free to go' for a Free Trade Agreement with India. It advocates 'progressive



realism' in foreign policy. It seeks a new geopolitical partnership with the EU and an increase of the defence budget by 2.5 per cent, besides strengthened nuclear deterrence. It recalls that it was Foreign Secretary Ernest Bevin in the post-World War II Labour government of Clement Attlee who helped create NATO and Britain's nuclear deterrence. In the Iranian presidential election, the sole reformist candidate, approved by the Guardian's Council, is Masoud Pezeshkian. He was the health minister in the government of reformist President Mohammad Khatami (1997-2005). Opposing him are conservative politicians Saeed Jalili, a former nuclear negotiator, and Mohammad Bagher Ghalibaf, Speaker of the Iranian parliament.ezeshkian's candidature is being attributed to Supreme Leader Ali Khamenei's worry over mere 48 per cent voting in 2021, when late President Raisi had won the election. The Iranian voters may be denied a real choice with politically vetted candidates, but they can express their disapproval of the

Islamic regime by avoiding voting. The elected President's legitimacy is more crucial than ever before due to the economic stress faced by the people due to Western sanctions. Huge crowds at polling booths late in the evening indicated revived public interest in the political contest.

Pezeshkian led in the first round, with Jalili second. In the runoff, the third candidate's votes will shift to Jalili because both are supported by conservatives. The same happened in the 2005 presidential election when Mahmoud Ahmadinejad was trailing in the first round and then won in the second one as the conservative votes consolidated. Iranian people can sometimes surprise the Islamic regime by voting for reform.

Even Fukuyama would concede that three-anda-half decades after his 'end of history' pronouncement, the global liberal order is

challenged by a realignment of some of the old players. Instead of the Soviet Union, it is the China-Russia-Iran axis and North Korea now. India is still doing a balancing act between the two sides in a neo-Cold War, as demonstrated by PM Modi's upcoming visit to Russia. The difference is that maintaining equidistance is more difficult as China, which is inimical to India's rise, is co-leading one side. The BJP must register the June 4 message of the people. India's enemies are abroad, not at home.

Amid Hathras tragedy, a look at India's deadly stampedes at religious events

The Hathras tragedy is not an isolated event and India has a long history of deadly stampedes at religious gatherings over the years.

New Delhi: Over 120 people, most of them women and children, died in a stampede at a satsang (religious congregation) in Uttar Pradesh's Hathras in one of the worst such tragedies in recent years. The gathering was organised by Narayan Sakaar Hari, also known as Sakaar Vishwa Hari or Bhole Baba.However, such a tragedy is not an isolated event and India has a long history of October 3, 2014: 32 people were killed, and deadly stampedes at religious gatherings over the years. One of the deadliest stampedes took place at Maharashtra's Mandhardevi temple in 2005, which claimed October 13, 2013: 115 people were killed 340 lives. Another stampede at Chamunda Devi temple in Rajasthan's Jodhpur in 2008 killed 250 people.At least 36 people died when a slab on top of an ancient 'baoli' or well collapsed during a 'havan' programme held on the occasion of Ram Navami at a temple in Indore city.January 1, 2022: At least 12 people died and over a dozen were injured in a stampede at the famous Mata Vaishno Devi shrine in Jammu and Kashmir

The accident occurred when some people fell down on the steps made slippery by the devotees breaking coconuts.August 27, 2003: 39 people were killed and around 140 injured in a stampede during the holy bath at the Kumbh Mela in Maharashtra's Nashik district.

New Delhi: A 'satsang' gathering in Uttar Pradesh addressed by self-styled godman Suraj Pal, known as Bhole Baba to his followers, descended into chaos and tragedy as a stampede resulted in the death of 121 people. The incident, which occurred in Hathras, was reportedly triggered by a frenzied rush to collect dust under the godman's feet, leading to a deadly crush where men, women, and children were trampled underfoot.

- A video that has gone viral on social media shows the godman leaving the venue in his car and hundreds of devotees running behind his car to gather the dust as a token of blessings.Suraj Pal, alias Bhole Baba, has been known for his controversial 'satsangs' and has a history of legal troubles, including allegations of sexual assault. Despite multiple cases filed against him in various jurisdictions including Agra, Etawah, Kasganj, Farrukhabad, and Rajasthan, he continues to command a considerable following, drawn to his promises of spiritual enlightenment and blessings.
- Born in Bahadur Nagar, Kasganj, Suraj Pal had a stint in the police department before facing legal troubles in 1997 related to allegations of sexual assault, for which he served time in prison. Upon his release, he reinvented himself as 'Saakar Vishwa Hari Baba', attracting devotees to his ashram in his ancestral village.

Some students claimed that they were unaware of the new dress code and were not allowed to enter the college as they wore jeans and t-shirts.The college had earlier imposed a ban on the hijab, naqab, burka, stoles, caps,

and badges inside the premises, following which the students had moved the Bombay High Court. In their petition, nine girl students said the ban was "arbitrary, unreasonable, bad-in-law and perverse". A division bench of Justices AS Chandurkar and Rajesh Patil, however, said it was not inclined to interfere in the decision taken by the college and dismissed the petition.Senior counsel Anil Anturkar, appearing for the college management, said the dress code was for all students belonging to every religion and caste.

The college claimed the decision to ban hijab, naqab, and burka was merely a disciplinary action for the uniform dress code and was not against the Muslim community.

The FIR alleged that the organisers hid the actual number of devotees coming to the 'satsang' while seeking police permission, did not cooperate in traffic management and hid evidence after the stampede.The stampede occurred as thousands of people rushed to touch the feet of the godman as he was leaving the venue.



Sensex crosses 80,000 for first time, Nifty hits record high

NEW DELHI. Benchmark stock market indices hit fresh record highs as the trading session opened on Wednesday, backed by gains in heavyweight stocks such as HDFC Bank.

- he S&P BSE Sensex crossed the 80,000 mark for the first time, while the NSE Nifty50 hit a record high of 24,292.15. At around 9:22 am, the Sensex was up 498.51 points at 79,939.96 and the Nifty gained 134.80 points to trade at 24,258.65.It may be noted that HDFC Bank rose 3.5% at the open and emerged as the top gainer on the Nifty50.All 13 major sectors recorded gains. The increase in HDFC Bank drove banks, financials, and private banks 1.3%-1.5% higher.
- Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said, "The focus of market activity today will be HDFC Bank which will continue its upward move factoring in the news of potentially increasing the weightage of the stock in the MSCI Index. The delivery-based buying in the stock witnessed in the last many days has the potential to continue for a few more days pushing the stock further up and imparting resilience to it.
- 'As the weightage of HDFC Bank in Nifty increases there will be more delivery based buying by ETFs and also active funds. There can be a marginal negative impact on other high weightage stocks in the Nifty like RIL, TCS, Infosys and ICICI Bank," he noted.

Karnataka HC sets aside NCLT order on rights issue, sends the matter back to tribunal

BENGALURU. The Karnataka High Court on Tuesday set aside the National Company Law Tribunal (NCLT) order that had restrained Byju's from launching a second rights issue. Think and Learn Pvt Limited (Byju's) and Byju Raveendran had filed writ petitions against the order of NCLT dated 12 June 2024. The High Court has remanded the matter to the NCLT for fresh consideration within 2 weeks from 4 July 2024.

- The high court also declined the request of the investors' counsel to suspend the present order by the high court which sets NCLT'S order. On June 12, the NCLT Bengaluru told the edtech firm to maintain the status quo with regard to existing shareholders and their shareholding shall be maintained till the disposal of the main petition.Earlier, four invstors including Peak XV Partners and General Atlantic Singapore accused the parent company of Byju's, Think & Learn for oppression and mismanagement. In April, Byju's said 55% of its shareholders have approved the vote for an increase in authorized share capital put forth in the form of a postal ballot and the Extraordinary General Meeting (EGM) held on March 29, 2024.
- The approval of the EGM proposals paved the way for Think & Learn Private Limited, to issue fresh shares and conclude the rights issue that was aimed at tackling the liquidity crunch, including unpaid salaries regulatory dues and vendor payments. But investors had requested the NCLT to stop the edtech firm's second rights issue as they expressed concerns that this would lead to dilution of their ownership in the company.Last week, the Ministry of Corporate Affairs (MCA) clarified that reports claiming Byju's has been cleared of financial fraud in an investigation are factually incorrect. It is about a year since MCA initiated the probe on Byju's. e ministry had ordered a probe after Byju's auditor Deloitte Haskins & Sells exited due to delay in the filing of FY22 financial results.

- MUMBAI. Though the much-anticipated inclusion of the government bonds (G-secs) in the JP Morgan's emerging market bond index from last Friday has underwhelmed the market with muted response, both in terms of inflows as well as in the flat bond yields. In the long-run this is going to a game-changer for the finance street, say both bond dealers and analysts. After closing flat on the D-day at 7.02% after rising to 7.1% in initial trade, the benchmark bonds closed 0.01% down on Tuesday, the third day since the inclusion at 7.012%, something nothing to write home about. The rupee also remained range bound and closed with a gain of 0.04 paise at 83.55 to the greenback.
- For one, the bond inclusion will bring down the borrowing cost both for government and corporates both directly and indirectly. Secondly, it will increase foreign fund flows, which many peg it at least \$25 billion by March 2025 and thus boost the rupee. Increased forex flow can boost the already-record high forex reserves as well as help bridge the current account deficit. But on the negative side, hot money inflows can raise inflation pressure, which RBI has been fighting since May 2022 with limited success.Announcing the inclusion, JP Morgan on September 21, 2023 said it will be staggered over a 10month period beginning June 28 to March 31, 2025, indicating 1% increment on its index weighting. New Delhi. It's time for the business end of Euros 2024 as the quarterfinals for the tournament was finally set on July 2, Tuesday, after the last set of Round Of 16 matches took place. The games on Tuesday saw Netherlands emerge as comfortable winners against Romania with a 3-0 win. The second match saw Turkey beat Austria 2-1 to seal their spot in the quarters. Mehri Demiral was the star of the show in Leipzig on July 2 as he scored a brace to knockout

This victory saw Norrie bounce back after first-round losses at the French Open, Queen's Club, and Eastbourne, though he has since dropped out of the world's top 40 rankings.

The Indian cricket team consisting of youngsters arrived in Zimbabwe ahead of the five-match series beginning from July 6.

New Delhi. Team India has arrived in Zimbabwe ahead of the five-match T20I series against the hosts. Notably, a young team led by Shubman Gill will take on Zimbabwe from Saturday, July 6. National Cricket Academy (NCA) head VVS Laxman will oversee the role of head coach for the entire tour. Ahead of the series, the team landed in Zimbabwe on Wednesday, July 3 as they received a warm welcome upon their arrival. In a video shared by Zimbabwe Cricket, Laxman could be seen emerging from the arrivals gate along with other members of the support staff followed by the 15-member squad. The BCCI has announced



three changes in the squad ahead of the series with batter Sai Sudharsan, wicketkeeper batter Jitesh Sharma and fast bowler Harshit Rana added to the team. The trio have replaced Sanju Samson, Shivam Dube and Yashasvi Jaiswal for the first two T20Is who

are stranded in Zimbabwe along with the Indian team due to Hurricane Beryl and are likely to join the squad later. Notably, Harshit Rana had a phenomenal season playing for KKR in the Indian Premier League 2024 as he finished as the joint fourth-highest


