Delhi government to bring law to regulate coaching centres: Atishi

Coaching centre deaths: 'Have they lost it': Delhi High Court

New Delhi, July 31: "What is Delhi Police doing? Have they lost it?" wondered the Delhi High Court on Wednesday, while castigating the police for a "strange' probe by arresting an SUV driver for his alleged role in drowning of three civil services aspirants at a coaching centre here. The strong words of the high court, how ever, did not come to the rescue of jailed SUV driver



whose bail plea was dismissed by a magisterial court later in the day. Judicial Magistrate Vinod Kumar rejected the bail plea of five accused, including SUV driver Manuj Kathuria, who was termed a "masti-khor (fun lover) by the Delhi Police in their vehement opposition to his bail plea. In the high court, a bench of Acting Chief Justice Manmohan and Justice Tushar Rao Gedela said a "strange probe" was going on with the Delhi Police taking action against a man who drove a car outside the coaching centre in Old Rajinder Nagar here but not acting against the Municipal Corporation of Delhi (MCD) officials. "What is Delhi Police doing? Have they lost it? What are its officials who are monitoring the probe doing? This is a cover up or what?" the court said. The bench said the police have arrested a bystander or some person who was driving the car over there. It asked whether some official (of MCD) has been held accountable for the incident till now. "We are telling you, once the responsibility is fixed on officials, no such incident will ever happen in future," the bench said. The high court was hearing a plea by an organisation, Kutumb, seeking constitution of a high-level committee to investigate the deaths of the three civil service aspirants on the evening of July 27. During the hearing, the bench allowed an oral prayer of the petitioner's advocate Rudra Vikram Singh to implead Delhi Police as a party to the petition. "Where is the police? Who is investigating this matter? They are trying to get hold of any passerby or driver and saying this happened because you drove a car. "Has any official been caught or interrogated? Have they interrogated the official who has not de-silted this drain?

New Delhi, July 31: The Delhi government will bring a law to regulate coaching centres in the national capital, cabinet minister Atishi said on Wednesday, days after three IAS aspirants drowned in the flooded basement of an institute in Old Rajinder Nagar. Addressing a press conference, the minister said the government would constitute a committee comprising government officials and students from different coaching hubs to frame the law. "Just like private schools and private hospitals/nursing homes are regulated by law with established guidelines for infrastructure, have regular inspections, and are given recognition by the government, the Arvind Kejriwal-led Delhi government will introduce a law to regulate all coaching institutes in the city, whether they are preparing students for IAS, IIT, NEET, CUET, NDA or any other exam," Atishi said. The minister said the Municipal Corporation of Delhi (MCD), in the last three days, has cracked down on coaching centres using basements in violation

Genetic, environmental factors in disease risk

New Delhi, July 31: Environmental factors may play a larger role in disease risk than previously thought, overshadowing genetic contributions, a study by researchers at Penn State College of Medicine reveals. Published in the journal Nature Communications, the research shows that lifestyle and environmental factors, such as air pollution, can significantly influence disease risk, offering more opportunities for mitigation. "We're trying to disentangle how much genetics and environment influences the development of disease,' said Bibo Jiang, assistant professor of public health sciences. The team used a novel spatial mixed linear effect model, combining genetics and geolocation data, to analyse disease risks. Co-senior author Dajiang Liu emphasised the importance of separating environmental influences from genetic factors, "If we can tease apart these shared environments, what's remaining could more accurately reflect genetic heritability of disease." Using data from IBM MarketScan and environmental data, the researchers re-evaluated the genetic contributions to various diseases. For example, the genetic risk of type 2 diabetes was recalibrated from 37.7 per cent to 28.4 per cent, highlighting a greater role for environ-

Thakur, during his speech on the Union Budget in the Lok Sabha, made certain remarks that were expunged from proceedings. His apparent reference about Leader of Opposition Rahul Gandhi's caste during the discussion had also caused a huge uproar in the House. Channi, a Dalit MP of

the Congress in the Lok Sabha, submitted a notice to Speaker Om Birla seeking to move a privilege motion under Rule 222 of the Rules of Procedure against the prime minister. "I hereby give notice to move a privilege motion under Rule 222 of the

Rules of Procedure and Conduct of Business in Lok Sabha against the Prime Minister for having tweeted on 'X' a portion of remarks which were expunged from the proceedings of the House by the

Chair," the former Punjab chief minister

said in his communication to Birla. On July 30, 2024, certain objectionable remarks made by Thakur were expunged from the proceedings of the House by the Lok Sabha Speaker, he said. It is, however, shocking to note that the prime minister posted on 'X' the whole video of the

speech which also contained these expunged portions, Channi said. As laid down in Practice and Procedure of Parliament, "The effect in law of an order of the Speaker expunging words, remarks or a portion of the proceedings is

as if those words/remarks or that portion of the proceedings had never been spoken. Publication of the expunged words or expressions would amount to a breach of privilege," he said citing the 'Practice and Procedure of Parliament by Kaul and Shakdher. This position has been reiterated by the Hon'ble Supreme Court in the Searchlight case, Channi said. "The prime minister's tweeting of the remarks which had been expunged from the

UPSC cancels Puja Khedkar's provisional candidature

New Delhi, July 31: The UPSC on Wednesday said it has cancelled the provisional candidature of probationary IAS officer Puja Khedkar and debarred her from all future examinations or selections "The UPSC has examined the available records carefully and found her guilty of acting in contravention of the provisions of the CSE-2022 Rules," the Union Public Service Commission (UPSC) said in a statement. It said her provisional candida-



ture for the CSE-2022 (Civil Services Examination-2022) has been "cancelled" and she has also been "debarred permanently" from all future UPSC examinations or selections. The commission said a show cause notice (SCN) was issued to Puja Manorama Dilip Khedkar on July 18 for "fraudulently" availing attempts beyond the permissible limit in the examination by "faking" her identity. She was to submit her response to the SCN by July 25 but she requested for time till August 4 to gather the necessary documents for her response, it said. The UPSC granted her a "final opportunity" to submit her response by 3:30 pm on July 30 but she "failed to submit her explanation within the prescribed time", the commission said.

40-year-old doctor found dead in car in Kota

Kota, July 31: A 40-year-old doctor was found dead on the driver's seat of his car in Kota, police said on Wednesday. Sub-Inspector Zakir Hussain of Jawahar Nagar police station said the deceased, identified as Dr Rakesh Choudhary based on documents in his car, was in an inebriated condition before his death. According to the police, a car was found parked with an unconscious man at IL Circle within the limits of Jawahar Nagar police station late on Tuesday evening. He was rushed to MBS Hospital, where he was declared brought dead, they said. Following the post-mortem by a medical board, the police handed over the doctor's body to his family on Wednesday morning and launched an investigation to determine the exact cause of the death, they added.

Death toll in Kerala landslides rises to 158

Wayanad (Kerala), July 31: The number of people who lost their lives in the devastating series of landslides in Kerala's Wayanad district has climbed to 158, with authorities on Wednesday expressing concern over the fate of 191 people who are still missing. "Rescue operations in Wayanad are continuing in full swing. Our land has never experienced such painful sights before," Kerala Chief Minister Pinarayi Vijayan said. The Wayanad district administration confirmed the deaths of 158 people in the calamity. Earlier, addressing a press conference in Thiruvananthapuram, the chief minister said that so far, 144 bodies had been recovered. Among them, 79 are men and 64 women. "As many as 191 people are still missing," according to the latest count. Earlier in the day, a cabinet meeting chaired by CM Vijayan expressed condolences to the families of those who lost their lives in the disaster. Vijayan said the scenes in Mundakkai and Chooralmala areas of the district are devastating. "Both these areas have been completely destroyed," he said. He added that efforts to

rescue as many people as possible from the Wayanad district, there are currently 8,017 breaking into the remains of houses

Mumbai: Drunk man stalks & slashes woman with blade in, held

MUMBAI. Deepak Mali (30), who claims he is a singer, was arrested on Monday for allegedly stalking and assaulting a 23-yearold woman near Bhayander station.

During interrogation, Mali admitted to the crime, claiming he was drunk and upset after an argument with his wife, said Navghar police senior inspector Aviraj Kurade. Initial investigations indicate that Mali, who lives in Borivli, and the woman were not known to each other.

The incident took place on July 23, when the victim was returning home from work. Around 11.45pm, she got off a local train at Bhayander station and was walking towards her residence, when Mali grabbed her from behind and demanded sexual favours. When she raised an alarm, he attacked her with a shaving blade on her left hand and punched her before fleeing the scene. The woman, who was in a state of shock, filed a complaint with Navghar police two days

This is the second such incident in less than a month. On June 29, a 32-year-old chartered accountant was molested and robbed of her cellphone while walking towards her Vasai (W) residence around 1.30 am. The 35-yearold accused, who was later arrested from Nalasopara, claimed to have been drunk.

In the Bhayander case, crime branch unit 1 at Kashimira scanned CCTV footage from Bhayander station and nearby areas, identified Mali, traced him to his Borivli residence and arrested him.

Kurade said Mali had followed the woman, who works at a private firm, from Borivli station, boarding the adjacent general compartment while she was in the ladies' coach, and got off at Bhayander when she did.Police sources said that during interrogation, Mali also confessed to having molested another woman at Borivli station last year, for which a case was registered with GRP. He was arrested and later released

Maharashtra nod for Rs 81k crore projects, Toyota plans Rs 25k crore plant

MUMBAI. The state's cabinet sub-committee on industry cleared 7 mega projects worth Rs 81,137 crore on Tuesday. The projects, located in Vidarbha, Marathwada and Konkan, are expected to generate 20,000 jobs. They include plants for industries such as semiconductor chips, lithium batteries, electric vehicles, and green energy. On the list is a Rs 27,200 crore project by JSW Green Mobility Ltd in Sambhajinagar for electric vehicles and hybrid vehicles. It is expected to generate 5,200 jobs and produce 5 lakh electric passenger vehicles and 1 lakh commercial vehicles.

A Rs 25,000 crore JSW Energy PSP project in Nagpur is expected to generate 5,000 jobs. The investment is for a lithium iron battery plant. The sub-committee cleared a Rs 1,500 crore fruit pulp and juice extraction project by Hindustan Coca-Cola Beverage, based in Ratnagiri. The state's first semiconductor manufacturing plant by RRP Electronics has also got the go-ahead at Taloja. It will generate an investment of Rs 12,000 crore in the first phase. The sub-committee cleared the Rs 13,647 crore AWAADA Electro Ltd projects in Nagpur and Panvel.

Hand, foot, mouth disease affecting more kids: Docs

Bengaluru. As monsoon intensifies in Bengaluru, city hospitals are noticing a spike in hand, foot and mouth disease (HFMD) among children in the age of two to seven years. The combination of seasonal weather changes and close-contact settings in schools and daycare centres has led to a notable increase in transmission of this contagious disease, say doctors. It forms blister-like rashes on children's hands, feet and sores in their mouth.Dr Parimala V Thirumalesh, senior consultant in neonatology & paediatrics at Aster CMI Hospital, shared with TOI, "We are noticing a rise in the viral infection, with five new cases per day, adding up to an average of 35 per week. Children are most susceptible to hand, foot, mouth disease. It is highly contagious and spreads through coughing, sneezing or contact with an infected person. Human faeces could be one of the infection carriers."Since there is no vaccination for HFMD, Dr Parimala emphasized the importance of taking preventive measures. "It is crucial to take steps like checking children's hands and feet every day before they get into the classroom to screen the infected ones. Generally, hand, foot, and mouth disease subsides on its own within 7 to 10 days.

Dr Prashanth Gowda, consultant paediatrician and neonatologist at Motherhood Hospitals, echoed this concern. "We are seeing almost 12 to 15 cases of kids on a weekly basis, indicating that awareness and preventive measures should be enhanced. HFMD outbreaks are prevalent in seasons, especially during humid weather when viruses spread more easily. Children in the age group of 2 to 4 years, who are frequent visitors of playschools or daycare centres, fall under the high-risk category.'

Doc dies of heart attack, wife blames apathy by officials

Hyderabad. Reportedly anguished over health authorities not restoring his post in the last five months, former superintendent of govt general hospital, Bhadradri Kothagudem, Dr Boda Kumaraswamy, died of a heart attack on Tuesday morning. He was 55 years.

Dr Kumaraswamy died in his native Warangal city. He was made superintendent of GGH in Jan 2022 and had to surrender his post in Feb this year following allegations of financial irregularities. Only last week, he was appointed as professor of general surgery in govt hospital, Mancherial. Sources said Mancherial posting was not to the liking of Dr Kumaraswamy.

Kumaraswamy's wife said that her husband felt humiliated and was extremely distressed as no financial irregularities were proven against him. "He wanted a detailed enquiry into the allegations. While someone else was found to be guilty in the alleged case, the authorities did not bother to restore his post nor paid his salary in the last five months. He was not even considered for a general posting and was told to wait," she complained.

The Telangana Teaching Govt Doctors Association (TTGDA) also said the allegations against Dr Kumaraswamy were unfounded. It called for a twominute silence in all the 34 govt medical colleges in the state on Wednesday at 11 am to express condolences to the professor.

Mumbai: 3 held for taking Rs 21 crore gold from lockers, investing proceeds in stocks

MUMBAI. Police on Monday arrested three men, including an area head and a branch manager of a financial services company, for allegedly partially selling and taking a loan against 29kg gold worth Rs 21 crore that had been stored in bank lockers. The accused allegedly invested the sale proceeds and the loan amount in the stock market.

The scam came to light after the finance company conducted an audit to find the gold missing. When confronted by company officials, the accused allegedly resorted to threats, claiming they had connections with the underworld. City crime branch's property cell has arrested the company's Dombivli branch manager Shivkumar Iyer (30) and

(29), and bullion trader Sachin Salunke (41) in the case. Police have registered a case against them under various sections of IPC. including for criminal

breach of trust, cheating, criminal conspiracy and misappropriation of funds. The complaint was filed by Akash Pachlod, an official of Rover Finance Ltd, a company that provides gold loans. In 2024, Rover Finance had taken over the loan department of Trillion Loan Fintech Pvt Ltd.During an audit conducted by the

discovered that 260 packets containing 29kg of gold ornaments, kept as mortgage in a bank locker, had gone missing. The keys to the locker were in the possession of Patil and Iyer. When questioned

about the missing gold, the accused initially evaded the issue. Iyer, though, later reportedly admitted to investing the proceeds and loan amount in stocks for higher profit in connivance with Patil since Jan 2024. The funds were invested through Salunkhe who took a bank loan against part of the gold. The proceeds were shared

between Patil who received Rs 40 lakh and Iyer who got Rs 8.7 crore. Iyer said he suffered losses in the stock market. When the complainant met Iyer in Andheri on June 4 and inquired about the gold, Iyer allegedly threatened him saying he would involve "bhai log", local colloquialism for people with a criminal history, if a complaint was filed against him. The company then lodged a complaint with Sakinaka police, alleging that Iyer and Patil had secretly taken 260 packets of gold ornaments between Jan and April. Police obtained Iyer's bank statement and found he had invested money with Salunkhe, proprietor of R K Bullion. Police also found chats between Iyer and Salunkhe.

GURGAON: A retired DHBVN employee, who is a private contractor now, received threatening calls and voice messages from an unknown person demanding Rs 50 lakh. The accused has been arrested, police said.

Based on Mehta's complaint, a case was registered under BNS Section 308 (4) (putting a person in fear of death or of grievous hurt, to commit extortion).

Yamuna breathes easy after rains, but just; pollutant levels alarming

NEW DELHI: The monsoon rains gave the Yamuna a slight respite and reduced the pollution, but the river water continues to be contaminated beyond acceptable standards. The faecal coliform level, which indicates the presence of untreated sewage in the water, is particularly worrisome and the improvement in the BOD (biochemical oxygen demand) level is insignificant.

The Delhi Pollution Control Committee (DPCC) report of the water quality for July shows that the pollution levels, although somewhat alleviated by the rains, persist at alarming levels. The monsoon arrived in the city on June 28, 5, by which time the city had received over 242mm of rainfall as measured at the base weather station at Safdarjung. According to the report, there was a big improvement in the faecal coliform measured at Palla, where the Yamuna enters the city. From 1,600 most

North Korea houses, roads hit by flooding, Kim Jong Un inspects affected areas

Seoul Over 4,000 homes in North Korea's city of Sinuiju and Uiju County near the border with China have been flooded due to heavy rainfall, state media KCNA said on Wednesday. Around 3,000 hectares (7,400 acres) of farmland along with numerous public buildings, facilities and roads were also flooded, prompting a twoday emergency meeting by the ruling Workers' Party's powerful politburo earlier this week, the report said.Leader Kim Jong Un chaired the meeting and expressed grave concern over the damage and urged strong measures to restore the affected areas, KCNA added. Kim inspected the floodd areas on Sunday.

The region has been affected by heavy rainfall from Tropical Storm Gaemi in recent days, which caused a landslide killing 12 people in southern China and flash floods elsewhere. North Korea's state media have been raising the alarm in recent weeks about the monsoon season and have issued several reports on efforts to offset damage from extreme weather.

The month of July is annually the monsoon season in the Korean peninsula, but the region has experienced extreme weather in the summer months in recent years. In South Korea, heavy rain caused landslides, train delays and heavy damage to infrastructure earlier this

973 Native American children died in US government boarding schools, probe finds

Billings, Montana At least 973 Native American children died in the US government's abusive boarding school system, according to the results of an investigation released on Tuesday by Interior Department officials who called on the government to apologise for the schools.

The investigation commissioned by Interior Secretary Deb Haaland found marked and unmarked graves at 65 of the more than 400 US boarding schools where Native American children were forcibly assimilated into white society. The findings don't specify how each child died, but officials said the causes of death included disease and abuse during a 150-year period that ended in 1969. Additional children may have died after becoming sick at school and being sent home, officials said. The findings follow a series of listening sessions held by Haaland over the past two years in which dozens of former students recounted harmful and often degrading treatment they endured at the hands of teachers and administrators while separated from their families."The federal government took deliberate and strategic action through boarding school policies to isolate children from their families, deny them their identities, and steal from them the languages, cultures, and connections that are foundational to Native people," Haaland, a member of the Laguna Pueblo tribe in New Mexico and the country's first Native American Cabint secretary, said in a Tuesday call with reporters.

'Make no mistake," she added, "This was a concerted attempt to eradicate the quote, 'Indian problem', to either assimilate or destroy native peoples altogether."

In their initial findings two years ago, officials had estimated more than 500 American Indian, Alaska Native and Native Hawaiian children died at the schools. The federal government passed laws and policies in 1819 to support the schools, which were still operating in the 1960s. The schools gave Native American kids English names, put them through military drills and forced them to perform manual labour, such as farming, brick-making and working on railroads, officials said. Former students shared tearful recollections of their experience during the listening sessions in Oklahoma, South Dakota, Michigan, Arizona, Alaska and other states. They talked about being punished for speaking their native language, getting locked in basements, and having their hair cut to stamp out their identities.

Kamala Harris to hold 1st rally with Veep pick on Aug 6 in Philadelphia: Sources

USA. Vice President Kamala Harris will hold her first rally with her new vice presidential nominee on August 6 in Philadelphia, sources say.

The location suggests Pennsylvania Governor Josh Shapiro has moved to the top of a short list of running mates, and that the Harris campaign had decided the state that Democrats won back from Republicans in 2020 is a must-win once again.

A campaign aide told Reuters on Tuesday not to read too much into the choice of the first city of a weeklong battleground state tour. The high-stakes decision on who will run with Harris has taken centre stage since she became the Democratic frontrunner for the November 5 election when U.S. President Joe Biden ended his White House bid just over a week ago. Harris is expected to announce the decision as soon as Monday, ahead of Tuesday's event, the sources said. The short list of candidates under consideration includes Shapiro, Kentucky Governor Andy Beshear, US Senator Mark Kelly of Arizona, Minnesota Governor Tim Walz and Secretary of Transportation Pete Buttigieg.If Shapiro is the pick, the Harris campaign is likely counting on the popular, 51-year-old governor to help win the state in November. Shapiro's stock among Democrats rose after he swamped his Republican opponent for governor, Doug Mastriano. winning 56 percent of the vote in a state known for tight elections. Shapiro would also become the second Jewish nominee for vice president on a major ticket in US history, following Joe Lieberman's failed 2000 bid with Al Gore.


Indian-origin woman jailed in UK for 10 years after convicted of shoplifting

→ The woman, Narinder Kaur, was previously found guilty of 26 counts of fraud, money laundering and perverting the course of justice in March 2023.

London. An Indian-origin woman was on Tuesday sentenced to 10 years' imprisonment by a court in south-west England after she was found guilty of conning retailers and other businesses out of thousands of pounds.Narinder Kaur a.k.a. Nina Tiara, 54, was previously found guilty of 26 counts of fraud, money laundering and perverting the course of justice in March 2023.Prosecutors said she had shoplifted on an industrial scale and deceived shops into refunding her for items that she had never actually purchased. She was sentenced at Gloucestershire Crown Court for stealing from more than 1,000 shops across the

UK. This sentence today sends out a clear message that West Mercia Police will deal seriously with prolific fraudsters,' said Steve Tristram, Fraud Investigator from West Mercia Police's Economic Crime Unit."Kaur is a calculated individual who committed offences across the country, dishonestly claiming refunds on items she had stolen. She showed no remorse for her actions and even thought she would get away with submitting false documents to the court with the intention of perverting the course of justice," he said. The police force took ownership of the investigation into Kaur in 2018 and worked with the UK's National Business Crime Solution, an organisation representing retailers, and other police forces as a "multi-agency approach"."We were able to investigate further into her criminal activity and found fraudulent activity in her bank accounts which subsequently brought her to justice," added Tristram.Kaur was found to have travelled extensively

known high street stores and then dishonestly claimed refunds on those items.Between July 2015 and September 2019, it is estimated Kaur netted around GBP 2,000 worth of refunds per week,

equating to over half a million pounds in fraudulent refunds and stolen goods. Knowing that she was under investigation for these offences, she is then said to

have embarked upon a scheme to defraud other businesses using the dishonestly obtained credit card details of members of the public. In March 2023, she was convicted of fraud, possessing and transferring criminal property and perverting the course of justice at Gloucester Crown Court.At the time, Crown Prosecution Service (CPS) West Midlands said that working with the police it was able to use financial data, retail records, witness evidence and CCTV which proved Kaur's pattern of offending.She was seen on CCTV entering stores, taking items from the shelves and taking them to the tills as if they had been previously purchased. Close examination of her accounts confirmed the pattern of purchases and refunds and that the same process seen on the CCTV was being repeated on hundreds of occasions.

UK bars Indian-origin lawyer from practicing over conviction in 'sham marriage'

London. A 44-year-old man who qualified as a lawyer in India has been struck off from practicing in the UK by the solicitors' watchdog after a tribunal heard of his conviction eight years ago for organising sham marriages for migrants to settle in Europe.

Mathew Moghan Rajamohan Chellam faced charges of fraudulent applications by the Solicitors Regulation Authority (SRA) and a disciplinary tribunal concluded in its ruling that there was no doubt that he knew or ought to have known that his conduct was in material breach of the obligations to protect the public and the reputation of the legal profession.In a judgment dated July 5 released recently, the tribunal notes that Chellam has since returned to India and that his current address in India was unknown."The Tribunal ordered that the Respondent, Mathew Moghan Rajamohan Chellam, solicitor, be struck off the Roll of Solicitors and it further ordered that he do pay the costs of and incidental to this application and enquiry fixed in the sum of GBP



4,058.00," reads the Solicitors Disciplinary Tribunal order.

"In assessing culpability, the Tribunal took account of the fact that the Respondent's motivation for the misconduct was for monetary gain, the fact that the misconduct arose from carefully planned actions including by using sham marriages with a view to abusing applicable laws, and that the circumstances giving rise to the misconduct were under the direct control of the Respondent and concluded that Respondent's level of culpability was extremely high," it notesAccording to the order filed with the UK's Law Society, Chellam was admitted to the UK's Roll of Solicitors in February 2013 through the Qualified Lawyers Transfer Test (QLTT) route as he was already a Legal Ádvocate in India. In 2015, he is said to have "self-reported" and confirmed that he had been charged with criminal offences under the UK's immigration legislation and that he was contesting those charges.In September 2016, at Snaresbrook Crown Court in London,

he was convicted of assisting unlawful immigration into a European Union (EU) member state, five counts of providing immigration advice and one count of seeking to obtain leave to remain in the UK by deception and was sentenced to a total term of imprisonment of eight years.

As a result, the tribunal concluded that Chellam, who was not represented at its hearing last month, had "caused tremendous harm to the reputation of the legal profession" and his misconduct "constituted various criminal offences". He has now been struck off from practicing as a lawyer

Gulf nations 'concerned' over behaviour of Pakistani expats

World A number of Gulf nations, including the United Arab Emirates (UAE), Saudi Arabia, Qatar and Kuwait, have raised grave concerns over the conduct of Pakistani expatriates and the labour force, a report said. The matter was raised by Secretary Overseas Pakistanis Dr Arshad at a Senate Standing Committee on Overseas Pakistanis, where he said that a number of Gulf countries have voiced reservations about the behaviour of overseas Pakistanis.He said that a rather concerning issue has been raised by these countries pointing at the "inappropriate" behaviour of Pakistanis in the UAE, including them making videos in front of women in Dubai.Kuwait has raised an issue concerning Pakistani nurses, who are reportedly refusing to perform certain job-related duties and instead put the onus on ward boys for regular day-to-day activities. Moreover, they do not try and learn the local language, but also want to go to Europe after only a six-month stay in the country.

Meanwhile, Qatar, as per the officials of the Ministry of Overseas Pakistanis, complained about Pakistani labourers refusing to wear safety helmets during work. Earlier in September 2023, officials had said that Pakistani beggars travel to countries like Iraq and Saudi Arabia on the pretext of 'Ziarat' (pilgrimage) and then indulge in begging-related activities. As per official data, Pakistani nationals accounted for 90 per cent of beggars arrested in these countries. Furthermore, the officials added that around 2 million Pakistanis are living in Saudi Arabia and 400,000 move to the country every year. Meanwhile, the Saudi Arabian authorities, the officials said, have asked Pakistanis not to send "beggars and sick people".

The officials said that Pakistanis visit Malaysia for a year, and are then sent to jail after they extend their stay there. Meanwhile, Senator Nasir Abbas also apprised the forum that in Iraq. Pakistanis are "helpless" as they get hired as cheap labour, adding that they are kept as "prisoners" there.

The ministry noted that these nations are now looking towards African nations for even cheaper labour. To counter this adverse situation regarding the future of the Pakistani labour force in GCC countries, the officials said that the ministry is compiling data regarding job availability and opportunities in various countries. A cabinet committee has been set up under Prime Minister Shehbaz Sharif regarding matters related to immigration, they said.

Top Hamas leader Ismail Haniyeh killed in Iran, outfit blames Israel

World. Top Hamas leader Ismail Haniyeh was killed after his residence was targeted in Tehran early on Wednesday, Iran's Islamic olutionary Guard Corps (IRGC) said in a statement, Reuters reported. Hamas, a Palestinian outfit engaged in a war with Israel in Gaza, said an "Israeli" raid killed Ismail Haniyeh and one of his bodyguards in his residence in Tehran.In a statement, Hamas said Haniyeh was killed in "a treacherous Zionist raid on his residence in Tehran".

advertisement On Tuesday, Haniyeh, who led Hamas's political operations from exile in Qatar, attended the inauguration ceremony of Iran's President Masoud Pezeshkian. "We prefer to resolve hostilities without a wider war," said



Daniel Hagari, the Israeli military spokesperson.Amid the Israel-Gaza war, Haniyeh acted as a negotiator in the ceasefire talks. Hamas claimed in April that Israeli airstrikes killed three of Haniyeh's sons and four of his grandchildren. The military wing of Hamas is led by Yahya Sinwar, believed to be the mastermind of the October 7 attack on Israel that ignited the war in Gaza. in the late 1980s and swiftly rose through the ranks to become a close associate of Hamas's founder and spiritual leader, Sheikh Ahmed Yassin.In the 1980s and 1990s, Haniyeh served several sentences in Israeli prisons. After Hamas's win in the 2006 legislative election, he became the Prime Minister of the Palestinian Authority government. However, it was short-lived as the next year he was dismissed from his position by President Mahmoud Abbas in 2007. Ten years later, in 2017, he was elected the head of Hamas's political wing. The same year, Haniyeh was named a "specially designated global terrorist" by the United States.

Raging California wildfire grows bigger than Los Angeles's size

California. The largest wildfire in the US swelled to over 600 square miles on Tuesday, bigger than the city of Los Angeles, fire officials in California said. as thousands of firefighters battled the blaze in a wilderness area north of

More than 5,500 firefighters from across California and other states were working around the clock to douse the Park Fire, burning in the state's Central Valley, about 90 miles (145 km) north of Sacramento, the capital. The fire grew to 385,065 acres (155,830 hectares), becoming the fifth-largest wildfire in Californian history, officials said.

The Park Fire on Tuesday surpassed the size of the 2020 Creek Fire in Fresno County, which burned almost 380,000 acres, fire officials said. But it is still smaller than the state's largest fire on record, the August Complex fire of 2020, which burned more than 1 million acres in seven counties in northern California. The Park Fire - fueled by dry grass, brush and timber - is fast-moving, said Fire Captain Dan Collins of the California Department of Forestry and Fire Protection or Cal Fire.



This fire has lots of fuel that is receptive to burning, and it's hard to get to," he said. "Our fire line is 260 miles around, that's the size of three Lake Tahoes. It can take two-three hours to get personnel in there over the terrain."The weather brings only a slight chance of a stray thunderstorm on Tuesday, said Ashton Robinson Cook, a

meteorologist with the National Weather Service. After that, no rain is in sight, and hot and extremely dry will prevail, he said. Temperatures will reach 100 degrees Fahrenheit (37.8°C) on Wednesday and highs could hover at that level until next Monday, he said, with relative humidity dropping to as low as 7%. The Park Fire,

which was only 14% contained on Tuesday, has forced the evacuation of more than 4,000 people and destroyed or damaged more than 192 structures, fire officials said. No injuries or deaths were reported.Jeremy Hollingshead, a spokesman for Cal Fire, said that lingering clouds of smoke have grounded the 41 helicopters used to drop water and fire retarding chemicals on the

Evacuations included Paradise, the town that was devastated by the 2018 Camp Fire, the deadliest in the state's history.

The man charged with starting the Park Fire, allegedly by pushing a flaming car down a Butte County gully last Wednesday, was formally charged with arson on Monday, but awaits additional charges, officials said. The man, Ronnie Dean Stout II, 42, of Chico, California, denied wrongdoing at an arraignment on Monday, said Butte County District Attorney Mike Ramsey at a news conference. It was unclear if Stout had an attorney. Stout did not enter a plea but was denied bail. His arraignment was continued to Thursday, as more charges could be added, Ramsey said.

Central Railway (CR): Harbour trains to terminate at Sandhurst Road?

MUMBAI. If Central Railway (CR) proceeds with its plan to lay fifth and sixth lines between CSMT and Parel, it may consider terminating Harbour line services at Sandhurst Road since Harbour platforms and tracks between CSMT and Masjid station will be needed for the new CSMT-Parel lines. CR also plans to demolish the fast corridor platforms at Byculla to create space for the new tracks. If so, there will be no stoppage for fast trains between CSMT and Dadar.

'The proposals are under serious consideration. Its feasibility is being checked," said a source. Under the plan, platforms 1 and 2 at CSMT and Masjid will be used for CR's Main line services, implying that all suburban network platforms at CSMT, from 1 to 7, will serve the

Currently, fifth and sixth lines exist between Kalvan and LTT, and work is underway to extend them between Kurla and Parel. But authorities have been debating their alignment between Parel and CSMT because of the need for land acquisition, especially private land -- a major issue. A CR official said. "Under the Railways Act, we can acquire land, but it is a time-consuming process and will cost an astronomical sum, which could make the project unviable."

A decade ago, CR proposed an alternative alignment for Harbour line from Dockyard Road over Eastern Freeway. The purpose was to free up space at both Masjid and Sandhurst Road for the exclusive use of the fifth and sixth lines from Kurla to CSMT. At the time, it was proposed to have two sister stations at Masjid and Sandhurst Road to provide points of interchange for both Main and Harbour lines. At CSMT, Harbour line trains were proposed to terminate on a deck that would come up at the existing platforms 17 and 18.

'This plan also required land from Mumbai Port Trust, which did not show a keen interest in the proposal. Additionally, MMRDA had a plan to extend its Metro 4 corridor (Wadala-Thane) to CSMT via PD'Mello Road, leading to discussions about avoiding a duplication of railway lines," said a CR official.

Buses from Bengaluru had to stop till 6am at Sakleshpur, resulting in passengers reaching their destinations 3-4 hours

"Multi-axle buses manoeuvring sharp curves at Charmadi is a safety concern, so we're running buses through Sampaje section via Madikeri. Compared to Shiradi Ghat, passengers need 45 minutes to one hour more to reach their destinations as they have to travel an additional 40km," the official said.

Shravan K, a passenger, said, "Last week, I travelled from Bengaluru to Mangaluru. The bus left around 11.30pm from Because of landslides on the track on July Majestic and reached Sakleshpur at 3.30am. The conductor then said the bus would halt till 6am. Along the route, there



was heavy congestion due to poor road conditions and bad weather.'

In Feb, Shaikh made a call to Shinde from his friend Mohsin's phone. Later, Mohsin and Yashashri befriended each other on social media.Suspecting Yashashri and Mohsin

In a major boost for tourism in the state, Gujarat govt's proposal to set up lionleopard safari parks has been approved by the Central Zoo Authority of India (CZAI). These twin safari parks, to be developed along the lines of Devalia safari park, will come up at Narayan Sarovar in Kutch and Naliya-Mandvi (Una taluka) in Gir Somnath. Nityanand Srivastava, the principal chief conservator of forests (wildlife), said, "The CZAI has given its final approval. We will now submit the proposal to the Supreme Court for its approval as these sanctuaries will be set up on forest land."The Supreme Court had earlier this year saated that prior approval

land as zoos or safari parks. The officials said that in Feb this year, the Supreme Court had stated that prior approval of the apex court is needed to notify forest land as zoos or safari parks under the Forest Conservation (Amendment) Act 2023.

The forest officials said that the Naliya-Mandvi safari park, announced earlier this year by CM Bhupendra Patel, will be about 8km from Diu. Both these safari parks will be spread over nearly 400 hectares of forest land each. The officials added that in March, Gujarat govt had decided to establish multi-species safari parks across the state to bolster wildlife conservation. Departing from the conventional model of single-species safari parks, these will offer visitors a more diverse and immersive experience by showcasing a variety of animal species.

CZAI has also given its approval for setting up a breeding centre for cheetahs in the Banni area of Kutch. The state forest department had begun laying the ground on a war footing for the cheetah breeding centre in March. To come up over 500 hectares, this will be India's first facility for the big cats where special open-to-air isolation enclosures are being built to create an environment conducive for breeding considering the mating behaviour of cheetahs.

City to fund green projects by selling AMC's unused

Ahmedabad. Driven by its agenda to be a net-zero city, the Ahmedabad Municipal Corporation (AMC) is set to unlock a green goldmine. The unused FSI, which will be sold as TDR, will belong to AMC's reserved plots in TP schemes such as those designated for social infrastructure — pumping stations, water tanks, sewage treatment plants (STP). But the poor state of the road has left not only airport-bound travellers but also locals from Hennur, Kannur, and Bagalur cursing their plight. The 21.9-km stretch from Hennur to KIA via Bagalur

is preferred by residents of Hennur, Tin Factory, Nagawara, Hegdenagar, Chokksandra, Kannur, Chikkabagalur and beyond to reach the airport. Anil Lulla, a resident of Hennur, said: "There is no road, it is just a series of potholes. BBMP isn't serious about addressing the pothole menace, it's just interested in building flyovers and other development projects." While the recent rain has worsened the road's

condition, the numerous compactors and trucks that carry waste on this stretch aren't helping. "Cabs refuse rides from people who want to go to Bagalur because of the bad road conditions," said Preeti Shenoy, a resident of Kannur. When Preeti recently tried to book a ride from her home to the airport, six drivers cancelled. She finally got a ride but was delayed by 45 minutes, narrowly making her flight.

Vipin Andrews, a resident of Hennur-Bagalur main road, said there is barely any streetlight on this stretch. "In the name of impending white-topping work, the road is barely being maintained. The authorities are delaying starting works, so we'll have to bear this nightmare," he said.

When it rains, the road is flooded and we can barely see anything. There are so many motorists who fall into stagnant water because of the lack of streetlights; only the headlights of vehicles are not enough to navigate through the road," he added.Rajeev Rajan, a resident of Bagalur Road,

said there is little hope the authorities will fix things. "Four-wheeler drivers have to literally slither like snakes trying to avoid potholes. Vehicles are getting damaged and I know of many people whose chassis has been damaged by bad roads," he said.

The poor road condition is echoing on social media too. Bipin MS (@BipinMS2) tweeted, "@DKShivakumar these things should be taken care of even before you dream about skydeck, tunnel etc. Brand Bengaluru starts with fulfilling basic infrastructure necessity and then going for advanced (sic)." India, Pakistan must work out ways to revive trade ties

NEARLY 77 years after Independence, diplomatic, political, and economic relations between India and Pakistan remain marred by enmity and hatred. They have fought two low-intensity wars (the Kashmir conflict in 1947-48 and the 1999 Kargil War) and two full-fledged ones (in 1965 and 1971). However, the contentious issues of Kashmir and cross-border terrorism remain unresolved. While political leaders from both nations have occasionally attempted to find mutually acceptable solutions, rational efforts have repeatedly been thwarted by irrational barriers. This cyclical pattern resembles a game of snakes and ladders, where progress is often undone by setbacks.

With the installation of new governments in India and Pakistan, there is a renewed glimmer of hope. Pakistan Prime Minister Shehbaz Sharif and former premier Nawaz Sharif congratulated Narendra Modi last month when he took oath as the PM for the third time. Shehbaz emphasised that peace in the region was unattainable unless the Kashmir dispute was resolved. And Nawaz called for replacing hate with hope and seizing the opportunity to shape the destiny of two billion people in South Asia. PM Modi reminded them that the people of India had always stood for peace, security and progressive ideas. However, External Affairs Minister S Jaishankar reiterated that terrorism could not be a policy of a good neighbour and, hence, it needed to be curbed.

While India insists on halting cross-border terrorism first, Pakistan demands that the Kashmir issue be addressed on priority. Both countries, however, understand that resolving these vexed issues requires mature and sustained politico-diplomatic dialogue, which, as yet, is not coming from either side. Sharat Sabharwal, a former High Commissioner to Pakistan, suggests managing the relationship at the lowest possible levels of violence and volatility, combining dialogue with deterrence, and nudging Pakistan in the right direction. He suggests that converting the LoC (Line of Control) into an international border could be a feasible non-military solution to the Kashmir issue. The prolonged delay in reaching a mutually acceptable and mature solution has complicated the issues further, with new factors — such as China's involvement adding to the complexity. Both countries have incurred significant financial and human losses because of their acrimonious relations. It has impacted crucial development issues — such as education, health and poverty eradication especially in Pakistan, which is currently facing a severe economic crisis. India had granted the most favoured nation (MFN) status to Pakistan in 1996 for trade purposes under the World Trade Organisation. But Pakistan did not reciprocate. This needs to be reviewed. Further, India revoked Pakistan's MFN status following the 2019 Pulwama attack. India should restore the neighbour's MFN status, and Pakistan should return the favour. Notably, there is huge potential for India-Pakistan trade. According to a World Bank study, it can reach \$37 billion. If the potential is fully exploited, it would also have a positive impact on trade through the integrated check-post (ICP) at Attari. The strained relations, however, have blocked India's access to Central Asia and beyond and hindered SAARC (South Asian Association for Regional Cooperation). Of late, India has strengthened its ties with Iran and signed a 10-year agreement for the management and development of the Chabahar port, which provides access to Central Asia, including Afghanistan, bypassing Pakistan. The proposed India-Middle East-Europe Economic Corridor (IMEEC) is also aimed at bypassing Pakistan and Afghanistan. While this would benefit Indian states near major ports, it is less advantageous for border and landlocked states like Punjab. Paradoxically.

As for the bulk of the Agniveers, 75 per cent of them would have options of various government jobs where they would be entitled to preferential recruitment.

Controversy arose over the scheme when, in late 2023, former Army Chief Gen MM Naravane said in his yet to be published memoir that the scheme was a "bolt out of the blue for the Navy and the IAF" and that he had proposed a four-year term only for the Army, and that too with retaining 75 per cent personnel and letting go 25 per cent. But the Ministry of Defence (MoD) reversed this to releasing 75 per cent and retaining only 25 per cent.

But we do not quite have the answer to the other question: what can or should the Agniveer be doing do for the Army?

average age of the Army. A government affidavit



claimed that India had the highest average age, 32, for below officer rank personnel as against a worldwide average of 26. But the recruitment age in the Army has always been in the 16.5-21 age group for decades. By releasing 75 per cent and infusing a new lot of personnel every cycle, the scheme expects to lower the age of the military. But as we noted, what will it get in return? There are certain realities of Indian recruits. When young men or women were recruited earlier, they were often underweight and undernourished and came from a diversity of backgrounds. Nine months of basic training just brought them to scratch in terms of physique and discipline, and thereafter there was need for professional training as an infantryman of more technical jobs as a handler of tanks, artillery, air defence systems. This could require anywhere up to another year for just proficiency.

Now, the Agniveer is inducted into the Army with just

six months of training. Given the rural background, levels of education and the age of induction, it is unlikely that an Agniveer comes in with any saleable skills. In better-off countries, a recruit would come in with a skill like driving, but in India that alone could take three months.


The government has denied that the Agnipath scheme was motivated by anything else other than the need for a younger profile of the military. In retrospect, the government needs to be upfront on the fact that it was indeed motivated by the public finance aspects of the scheme which will, however, kick in only after a decade. The pension bill which,

according to the latest budget consumed Rs 1.41 lakh crore or 22.7 per cent of the defence budget is a millstone around the military's neck. Given the calls in the past for a younger force, we need not throw the baby out with the bathwater. Instead of ending the scheme, the government needs to modify it to overcome shortcomings such as that of training and skill development. It may be a good idea to extend the Agniveer's tenure from four to seven years, an idea that has been around for some time. This will ensure enough time for training and also providing effective contribution to the service. The Agniveers will be between 24 and 28 years when released, which is ideal for the many opportunities that are opening up, somewhat belatedly, for them.

And remember, of course, that the 550-odd who died in the Kargil War in 1999 were trained, hardened and dedicated soldiers, not Agniveers. That kind of test still awaits the scheme.

But if we want to give ourselves the chance of redeeming ourselves — and the memories of these three people — then a political will must be forged to ensure that the guilty are punished. Let a national cleansing take place. Let it begin from Delhi.

When aged leaders fail to see age as a handicap

These leaders tend to be in a bubble, surrounded by loyalists and sycophants who will never tell them truths about the seriousness of their cognitive decline.

WITH octogenarian Joe Biden exiting the US presidential contest because of age-related frailties. the tables have been turned on septuagenarian Donald Trump, the Republican candidate in the November election. Trump had not criticised Biden as being too old for the presidency — not in this campaign cycle nor in the one four years ago despite calling him 'Sleepy Joe' and implying that he was not all there at the only debate this year between the two men. Trump, 78, knows he is vulnerable on the issue of his age. He is only three years junior to Biden. Old age had dogged Biden even during the 2020 election season because he has been chronically prone to gaffes and suffered from stutter as a child, which he overcame. Not many people have thought of Trump as a septuagenarian because he has talked in videos, leaked during his 2020 campaign, of groping women. And, strippers have given graphic accounts of sex with the real estate mogul who became President. The popular image of Trump is that of a man full of libido, notwithstanding his age.

Both Trump's approaching 80s and his convicted felonies and sexual escapades will be the stuff of an unfurling Democratic campaign. It will show the prowess of Kamala Harris as a former prosecutor when she is on the stump. Harris, who is Biden's presumptive replacement as the Democratic Party's candidate, is not yet 60 and can legitimately argue that Trump will soon be too old to govern if he is elected President. After all, her party replaced its candidate entirely on that ground. A majority of the Americans agreed with that decision, polls showed.

Growing old is an inevitable fact of life, but everyone recognises this handicap, except the aged Heads of State or Government themselves. Partly, this is because these leaders tend to be in a bubble, surrounded by loyalists — with the usual sprinkling of sycophants — who will never tell their bosses uncomfortable truths about the seriousness of their cognitive decline. Biden's is the most recent and widely publicised example. But there have been many before him. In India, then External Affairs Minister SM Krishna read the Portuguese Foreign Minister's speech at the United Nations Security Council in 2011. He was as old as Trump when he made the faux pas. Indian officials did not blame the gaffe on Krishna's reflexes or his agility. They said the UN staff routinely placed an English translation of a Portuguese minister's speech on top of Krishna's papers after the former

had spoken immediately before it was India's turn. Pakistanis at the UN made the most of this mistake.In 2013, LK Advani, then 86, had to be persuaded to not press his claim all the way to be the BJP's primeministerial candidate and make way for the incumbent, Narendra Modi.Dinesh Singh became External Affairs Minister when he was only 68 in 1993. Tragically, he suffered a stroke shortly after his appointment, but the then Prime Minister PV Narasimha Rao did not relieve him of the very demanding portfolio that involved frequent travel. Singh could not even go to his office in South Block and files had to be sent to his home, where he was mostly bedridden. Delhi's grapevine was rife with speculation at that time about astrologers advising Rao that Singh's presence in the Union Cabinet was auspicious. The last straw was Singh's insistence in March 1994 that he would travel to Tehran as Rao's Special Envoy to deliver a message from the Prime Minister to Iran's then President, Ali Akbar Hashemi Rafsanjani. The mission was critical. India was



seeking Iran's intervention at the UN Human Rights Commission to prevent a resolution on Kashmir being passed at the commission's annual session in Geneva. Shortly after he came back from Tehran, Rao made Pranab Mukherjee External Affairs Minister because Singh simply could not discharge his duties. But Rao retained Singh as minister without portfolio until his death in November 1995.

first interviewed Mahathir Mohamad in 1988 in Dubai. By then, he had served seven years as Malaysia's fourth Prime Minister and was full of promise as an emerging leader of developing countries and as a moderate voice in the Islamic world. Maverick leaders like Libya's Muammar Gaddafi and unpredictable dictators like Iraq's Saddam Hussein were the flavours in the Organisation of Islamic Conference — as it was then known — and in the Arab League. Mahathir's time as Prime Minister spanned a total of 24 years, Malaysia's longest. When he gave up office in 2003, he was already 78 years old. His dramatic return as Prime Minister 15 years later, when he was 93, is stuff of political legends. In 1988, Mahathir talked about his part-Indian ancestry on the condition that I will not publish it. He was then vigorously implementing the electorally rewarding 'Bumiputera' policy which gave preference to the Malays over the Chinese and Indians in Malaysia's multi-racial society. His Indian ancestry became less of a secret after he quit his first term as Prime Minister. The nonagenarian's return as Head of Government was hard fought. He had to resign from his political organisation and form a new party, whose Malay name

translates as the Malaysian United Indigenous Party. It created a coalition, which swept to power, defeating the party which had ruled Malaysia since the country's formation in 1963. Sadly, Mahathir damaged his legacy by clinging to the PM's chair even at the age of 95 although he had promised to be an interim leader. The Malaysian people defeated Mahathir in the General Election two years ago. He lost his deposit from the Langkawi constituency.

Habib Bourguiba was a leader lionised by the Tunisian people for leading his country to independence. Tunisia is a remarkable country where the Arab Spring began in 2010. Unfortunately, Bourguiba, too, did not know when to retire. At the age of 84, as President, he forgot that he had signed a decree expanding his Cabinet and appointed the head of a state-run newspaper, only to fire him in 24 hours. He recalled an Ambassador a few days after the envoy presented his credentials. Bourguiba's peaceful ouster created the term 'medical coup d'état' after his doctors declared him unfit to be President.

Rediscovering the wonders of Pune



Heritage and history have always been a part of the city's charm. Over the next few days, we will showcase what we believe to be our city's 15 wonders. We have also organised visits to some of these heritage destinations.

Nana Wada

History: The Nana Wada, built in 1780, adopting Gothic structures, used to be the home of Nanasaheb Phadnavis, an influential minister and statesman of the Maratha empire during the Peshwa administration. This wada is a large sixquadrangled, perimeter-protected construction. Back then, the Krishna river used to flow beside the Nana Wada, which had steps leading to the river. The Nana Wada has been a preferred location for many Bollywood filmmakers to shoot their movies. Mrityudand, Goonj Uthi Shehnai, Jis Desh Me Ganga Rehata Hai, and Swades are a just a few such examples.

To see: Among the things to look out for are the few temples behind the Nana Wada that have beautiful Peshwai pictures on their walls. Another interesting thing is a huge bell housed in the temple premises which was won by the Peshwas in the war of Vasai in 1707 against the British. Nana Wada can be visited from 11 am to 6 pm daily.

University of Pune

History: The main building of the University of Pune was made in 1864. During the British Raj, it was the official residence of the governor of Bombay and postindependence, the building was restored for academic and official

Inspired by Prince Albert Osborne's house on the Isle of Wight, it was built at a cost of around 1,75,000 Sterling Pound, which was nearly six times the amount raised by the sale of the previous Governor's

To see: A little ahead of the building is a small pond, with a stone prison right in the middle of it. During the British era, crocodiles were kept in the pond that surrounded the prisoners in their cells. The University can be visited between 8 am-6 pm with prior

permission. Parvati

History: Located at a height of 2,100 feet above sea level, Parvati is one of the highest points in the city and gives an excellent panoramic bird's eye view of Pune. The Parvati houses a temple complex and one needs to climb and a total of 103 steps to reach the top. The main temple was built by Shrimant Nana Saheb Peshwa in 1749 and was visited by the Prince of Wales, Albert Edward, during his visit to India in 1875. Apart from its historical importance, it is also a hot favourite among fitness enthusiasts, who come here daily for their morning and evening walks.

To see: Other than the temple, the complex also has a museum housing artefacts from the Peshwa period. The Parvati gates are open for the general public from 5.00 am to 8.00 pm.

Its cobbled streets, beautiful monuments, streets filled with music and art and charming old square make it a wonderful option for an enchanting history rich getaway.

How to get there By Air

Delhi study centre survivor recalls last words of victim: No need to panic

New Delhi. A civil service escape from the basement, but aspirant, who narrowly escaped from the flooded basement of the coaching centre in Old Rajinder Nagar area in Delhi, said one of the victims had told him not to panic. Recalling the words of Tanya Soni, who was among the three students who drowned in the basement of Rau's IAS Study Circle institute, Rishabh Pal, 21, said he would forever feel guilty for not being able to save his batchmates, PTI reported.

Shreya Yadav (25) and Nevin Dalwin (28) were the other two IAS aspirants who died on July 27. The coaching centre had permission to use the basement only as a storage, but it was turned into a library.

Rishabh Pal, from Ghaziabad, said around 15 students managed to

around 15 more were stuck there. Recounting the horrifying moment, Pal said the over 13foot-high library was filled with water in just three to four minutes. "Tanya, who was my batchmate, said there was no need to panic, and we would be saved. She also suggested forming a human chain. We tried forming a chain, but due to the flow of water we could not hold on," he said.He said that as the water started filling in, he climbed the stairs and a staff member pulled him up. Rishabh said Tanya and Shreya were standing on a table in the library the last time he saw them.

"Behind me, my friend Jaideep and a few others came out. Then, the staff members of our institute brought a rope to pull the others who were stuck in the water," he told PTI. Rishabh said that he didn't notice Nevin in the library.Praising the quick work of the employees, Rishabh said had they not acted swiftly, the number of causalities would have been more.

However, contrary to reports, he said there were no biometric locks in any part of the building. He also alleged that there was a delay in response to their distress

'Attempted murder' case against husband of woman tied to tree in Maharashtra

Mumbai.The Sindhudurg police on Tuesday registered an FIR against one Satish in connection with the matter concerning a US national, who was found chained to a tree in the jungle in Sindhudurg district

The woman is suspected to have been chained to a tree in the jungle for around 40 days. Several people have been questioned, and some teams have also left outside the state for investigation in the case.

The FIR is registered for attempted murder, illegal confinement, endangering personal safety under sections of Bhartiya Nyaya Sanhita (BNS) as per the Sindhudurg police.

Senior police officials from Maharashtra police confirmed that an FIR has been registered against the person identified as Satish whose name was provided by the 50-year-old victim.

The victim is presently recuperating at the Institute of Psychiatry and Human Behaviour (IPHB) at Goa Medical College and Hospital in Bambolim. Sources said that the victim, in initial written notes, revealed that she had been chained to the tree using shackles by her husband, with whom she had stayed in Tamil Nadu since last decade and left there to die.

In one of the notes she handed over to the police, she said "Injection for extreme psychosis which caused a severely locked jaw and inability to drink any water. Need intravenous food. 40 days without food and water. Husband tied me to a tree in the forest and said I would die there". The US national has been identified as Lalita Kayi Kumar S and her passport, an Aadhaar card bearing a Tamil Nadu address, a bag containing food and supplies and a raincoat were found from the spot. She was seen by a shepherd, who was from the nearby village of Ronapal and saw her when he had taken sheep to the jungle and was shocked to hear her screams and then informed villagers who informed the local police. The police took her to the Sindhudurg district hospital where she couldn't talk or speak due to starvation and weakness and dehydration, so she was provided initial treatment to get her energy back and then shifted to IPHB in Goa for further treatment.

Before Tuesday's flag-off, Delhi had been operating 1,650 electric buses since January 2022, which have collectively covered over 112 million kilometers, cutting down more than 91,000 tonnes of Co2.

Currently, 25 per cent of Delhi's bus fleet is electric. Delhi has the second-largest electric bus fleet in the world. With 2,267 electric buses, Santiago in Chile has the largest fleet. By 2025, Delhi aims to have a total of 10,480 buses, with 80 per cent (8,280 buses) being electric, saving 4,67,000 tonnes of CO2 annually.

'There was no rash driving': Wife of SUV driver arrested in coaching centre deaths

New Delhi. "My husband was only trying to reach a safe spot," said Shima Kathuria, wife of Manuj Kathuria, who was arrested in connection with the deaths of three civil services aspirants inside a flooded basement of a coaching centre in Delhi's Old Rajinder Nagar last week. She further said that the video clearly showed that there was no rash driving by Manuj Kathuria.

Manuj Kathuria, a businessman, was behind the wheels of an SUV which drove through the flooded street, causing the water to swell and breach the gates of the three-storey building of Rau's IAS Study Circle and inundate the basement. Defending her husband, Shima said that the allegations levelled against Manuj are "completely wrong".

There was no rash driving, the video is in front of everyone. My husband was not driving at a high speed. My husband was only trying to reach a safe spot," she said while speaking to news agency.

Furthermore, Shima also blamed Rau's IAS Study Circle for running a library in the basement of the building without permission. She also wondered why the police didn't close the roads when there was waterlogging in the area.

The authorities will figure out who is at fault. Why was the coaching institute owner running a library there when they had a NOC only for storage? When there was severe waterlogging on the roads, police should have cordoned off the roads," she said.

Shima also believed that her husband was a victim in the case and not an accused. "We are very positive. My husband has not done anything wrong. We have full faith in the judicial system and I am sure that the court will take the right decision," she said in a separate conversation with news agency.

Recalling her husband's dramatic arrest, Shima said police arrived at their residence and told the family that they had come to question Manuj.

The police said there is no criminal liability and they were just taking him for questioning since his vehicle was visible in the viral video captured around that time (when the water gushed in). Around 30 minutes later, my fatherin-law got a call from him saying he had been arrested. It created a state of panic among us," she added. Speaking about the allegations of rash driving, Shima said that video which went viral on social media 'clearly' shows that the brake lights of the vehicle were switched on.

Delhi chief secretary blames coaching centre, government calls out 'delay' in probe report submission

NEW DELHI. The Delhi chief secretary on Tuesday submitted a magisterial inquiry report to Revenue Minister Atishi in the Old Rajinder Nagar coaching centre deaths. The report said the coaching institute completely blocked the drainage system and did not take measures to meet such eventualities.

Atishi, however, said she had asked the chief secretary to initiate a magisterial probe and submit a report within 24 hours. But what she received was an incident report on Monday.

The minister was told that the inquiry would take seven more days. "It is unfortunate that the bureaucracy is showing laxity in the



investigation. It raises questions whether the culprits are being The parking access to the institute is directly exposed to the road and in case of a heavy rain, water flows directly into the parking area instead of going into the stormwater drain," the report said. Units of the Army, NDRF, SDRF and other emergency services personnel resumed operations on Day 2 and are searching under collapsed roofs and debris of destroyed houses for victims

and possible survivors. A total of 225 Army personnel have been



deployed for rescue operations. Several companies of the Army have also been moved from Thiruvananthapuram and Bengaluru to Calicut.

The Army rescued over 1,000 people using a temporary structure after a major bridge connecting Chooralmala and Mundakkai

We don't have a time machine, but we are blessed to have Matheran, which is India's lowest hill station positioned 800 m above sea level in Western Ghats in the Indian state of Maharashtra (90 km from Mumbai). The peculiar thing about this place is its pollution free environment as no motor vehicle is permitted inside the town, making it Asia's only automobile free hill station. Fresh air, picturesque beauty and enchanting landscapes make it a serene place. Most of the tourists unwind themselves during a day trip or a weekend trip, but those who love nature won't mind spending an entire week here.

There are many places to visit in Matheran, such as Sunset Point, Sunrise Point, Louisa Point, Echo Point and Honeymoon Point. Also popular are Charlotte Lake, King George Point, One Tree Hill Point, Alexander Point and Panorama Point that compel you to appreciate nature even more. Hand-pulled rickshaws and horses are used as modes of transportation inside the town. One man quoted INR 600 (negotiable) for a horse for 3 hours for around 10-15 sightseeing points. We thought of not doing things in a hurry and hence decided to walk on foot so that we can closely interact with the place. Horses are a good option if you are in Matheran just for a day or you want to visit some place too far with a steep hike. Mainly old people are seen availing the facility of hand-pulled

How to reach

What to see

Mumbai is the nearest metro city to Matheran. You can take a local train till Neral (don't get confused with Nerul-another station in Mumbai-as the two are very far from each other). After reaching Neral, you can either opt for a toy train or a shared taxi to reach Matheran. Both these options cost almost the same (INR 70), but with a tradeoff between an enjoyable experience and time. Toy train takes almost 2.5 hours while halting at various small stations. It provides a closer view of varying landscapes on one side and mountains on the other. On the other hand, taxi takes a maximum of 20 minutes to reach the town. I enjoyed the experience of toy train while going to Matheran, and decided to save time by taking taxi while heading back to Mumbai. A compulsory tax of INR 50 is levied on every visitor, and it has to be paid while entering the town.

Panorama Point

Panorama Point is the most exciting and the farthest viewpoint in Matheran. It is almost 7.5 km away from the marketplace. Taking a horse is probably the best. Another option is to take a toy train from the marketplace to the next station, but you will be required to walk at least 2 km. Horse ride takes 45-60 minutes to transport you from your hotel to this fairyland. The path is little bit rocky and hence, your back might start hurting after a while, but it's an unforgettable odyssey-you go through the forest hearing singing birds, breeze and horse's clip-clop, while having occasional glimpses of varying landscapes. The views from Panorama Point are incredibly stunning and beyond my words. This point offers a 360-degree view of

Alexander Point

Alexander Point is almost 1.5 km from the marketplace (a 20-minute walk), and is easy to reach in terms of distance, navigation and slope. It's a very pleasant walk from one's hotel to this point as you walk through woods, on a very narrow path over red soil, interacting with green trees. The peak offers good views of other points of the region and the valley below. I will call this point as a bigger version of Sunrise Point (Khandala Point) because it gives the same view as Sunrise Point, but comparatively has ample space. No doubt that it is more crowded as compared to other places because it's quite close to the toy train station. Alexander Point has some snack stalls that serve fresh juice, soda and Maharashtrian snacks to satiate your hunger. During the peak season, there is zip-lining option available from here to Rambaug Point, costing INR 350-500 per head. I am very cautious about the safety measures taken by adventure sports organisers. I saw a few Europeans doing it and they told me that Matheran's zip-lining is quite safe as compared to a few popular tourist destinations in Europe.

One Tree Hill Point

One Tree Hill Point is almost 4 km away from the marketplace, taking around an hour to walk up to this place. It's better to take a horse or a hand-pulled rickshaw. This point is you can see Karjat, Mumbai-Pune highway, Panvel city, Chowk village and a few other vantage points of Matheran. To get the best view of this peak, walk all the way to the edge and then only you'll be able to notice that why this point is called One Tree Hill. There is a trekking path from Ambewadi to One Tree Hill Point, which is pretty easy and can be done by beginners also. It takes almost 3.5 hours to climb up and 2.5 hours to descend. I'll advise to avoid this trek during monsoons or hire a guide.

King George Point

King George Point is almost 2.7 km (a 40-minute walk) from the marketplace. It takes around 10 minutes to walk here from Charlotte Lake. Many people say that it's a sin to go to Matheran and come back without visiting this vantage point. The sight from this peak is really majestic as it offers a picturesque view of the lake and waterfalls, and a large valley surrounded by three hills. The view is mesmerising and nature lovers can definitely sit here for hours. People prefer to come here in groups in the evening, take a walk, watch the sunset and enjoy baked corn with a cup of ginger tea. Sounds amazing, isn't it!


Charlotte Lake

Charlotte Lake is almost 2.5 km away from the marketplace, which is approximately a 35-minute walk. Although the walk is a bit tiring, the breathtaking view and cold breeze take away all the fatigue. There is a little waterfall near the lake which is a treat for the eyes during monsoons. During other seasons, either it is dry or the water is too less. Clear lake water, green backdrop and flawless waterfall look amazing. For a moment, you would certainly think of owning a house at a place that would offer such view. Lake area has got amazing birdlife and we got to know this when we met some passionate bird photographers here. Some people also like to visit Pisarnath Temple, which is situated to the left of the lake.

don't leave any wrapper or garbage behind. It can be quite a hike while going back to your hotel, so if you are tired, take a horse or handpulled rickshaw.

Honeymoon Point

Honeymoon Point is very tranquil and offers a wonderful view of Matheran's splendid mountains. From here, one can see Prabal Fort, various valleys accommodating civilisations and a beautiful sky that changes colours at dusk. The view of mountains from Honeymoon Point is such that you would call them 'Indian Grand Canyon'. There is no factual explanation as to why this point has been named Honeymoon Point, I brainstormed and came up with a few reasons. One hypothesis says that this place is a little secluded because you actually need to



cross some bushes to reach here. Second is that it offers a romantic view. Both facts are good enough to name this peak as Honeymoon Point. My group spent perfect 30 minutes of mindfulness hearing nothing but the sound of air and leaves, which left us rejuvenated. It was like meditation. Not many people visit this point, so you spend undisturbed moments lying down and gazing at the sky while talking to your partner.

Some people even enjoy picnicking here. Make sure that you carry your trash with you and dispose off in a dustbin. This point is very close to Louisa Point and Echo Point; and similar to them, it is a very good subject to be captured through lens as it is rarely crowded. Hence, it gives the freedom to amateur photographers to experiment with different angles and lenses to capture a variety of pictures and improve their

Echo Point

Echo Point lies in the vicinity of Louisa Point, which can be seen from here. As the name suggests, you hear your screams and yells echo at this peak. High-pitched kids are a common sight here. We even saw adults going crazy to hear their voice back. We got to know about it when a group of almost 20 screaming people captured my attention. Funny, isn't it?

The vantage point offers the best view of the Western Ghats and is very crowded during daytime. So, it's advisable to visit here early in the morning. One of the best experiences we had here was crossing the valley by zip-lining. Mostly, zip-lining is offered by some local tour operators during the peak tourist season. There are a few stalls here that offer a variety of local food like vada pay and kandha poha, along with bottled water and soda. So, it's good to relax here for a while and admire nature in its full

Louisa Point

Louisa Point is almost 1.5 km away from the marketplace and will take around 20 minutes to reach here on foot. If it's a clear sunny day, this place will offer you breathtaking views that will compel you to settle down here for a moment. This is a unique point in Matheran as it offers two different picturesque views. From one point, you can see the sky touching the mountains and a civilisation located far in a valley. If you visit during monsoon, you'll also be captivated by waterfalls. Another view is of Lake Charlotte that looks like a diamond necklace when seen from here. Louisa Point also offers a clear view of Prabal Fort. All these different views are intriguing and one can spend hours gazing at them. We sat there, soaked in the beauty of the place and relishing moments

This place is known as a photographer's paradise in Matheran because it offers panoramic views of mountains, peaks, valleys, lake and waterfalls. In most of the travel portals, blogs and magazines, Matheran has been represented by using Louisa Point's pictures. During the peak season, photo points are a little crowded and sometimes you need to be patient for your view to be 'people free', but all your waiting time is worth those beautiful, dreamy and wallpaper pictures. Some people also stay at Louisa Point to watch the sunset.

Sunrise Point

Sunrise Point, also known as Khandala Point, is located alongside the marketplace. This place is serene in the morning as very few people are able to make it to the sunrise.

Sitting here quietly works wonders as you hear the chirping of birds, sound of breeze striking against trees and music composed by tree leaves. Our ancestors used to say that when you see a rising sun, it gives you tremendous energy. Sun rising above glorious mountains with golden reddish sky forming the backdrop unquestionably make for a beautiful sight and give you positive energy. I did yoga at sunrise for 20 minutes and definitely felt very energetic that day as compared to other days where I follow a different lifestyle. It's 5-15 minutes' walk from the marketplace, depending on the

location of your hotel. Ask some local person or the receptionist of your hotel about sunrise time for the next day, before you go to bed at night. Sunrise time mentioned on the internet can be wrong sometimes and you obviously don't want to miss this sight. Videos recorded at sunrise are just perfect and can be used in any of your travel videos. I ended up with a shaky sunrise video because my view was obstructed by other photo enthusiasts and hands started trembling after a couple of minutes. So, I recommend taking your tripod along, if you intend to record the sunrise. While heading back to your hotel after seeing the sunrise, I would propose to indulge your taste buds in lip-smacking breakfast that has kandha poha and jalebi.



ITR filing deadline ends today. Will tax department extend last date

New Delhi The deadline to file Income Tax Return (ITR) for AY2024-25 ends today and there has been no formal announcement from the Income Tax Department (I-T Department) regarding an extension of the deadline.

Several citizens and tax professionals have pointed out several glitches on the tax filing portal as a reason for seeking an extension. Despite the repeated appeals, the I-T Department has urged taxpayers to complete the process by July 31, indicating that there won't be a deadline extension beyond the last date. Moreover, the tax department has also said that more than 6.5 crore ITRs have been filed till July 30, which marks an increase of over 7.5% more compared to the same period last year."The number of ITRs filed per day has exceeded over 45 lakhs on 30 July and is expected to rise exponentially on 31st July which is the due date for many taxpayers. The 6.5 crore milestone, which has been reached on 30 July this year, was achieved on 31 July last year," said the I-T Department.

New Delhi. Benchmark stock market indices gained after opening flat on Wednesday even as profit booking continued on Dalal Street. The S&P BSE Sensex was up 205.79 points at 81,661.19 at 10:10 am, while the NSE Nifty50 rose 69.05 points to trade at 24,926.35.All the other broader market indices were also trading in positive territory. High-weightage sectoral indices such as Nifty Bank, Nifty Financial Services and Nifty IT were among the gains in early trade, while Nifty Realty declined. The top five gainers on the Nifty50 were Asian Paints, NTPC, Hindalco, JSW Steel and Tech Mahindra.On the other hand, the top losers were Tata Consumer Products, Power Grid, Axis Bank, Tata Motors and IndusInd Bank.Moreover, market experts said Sebi's proposal to curb speculation in index derivatives will lead to a more stable rally in the markets.Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said, "Sebi's crackdown on F&O trade is eminently desirable and can go a long way towards making the ongoing rally healthy and less speculative.""The irrational exuberance of the retail investors, particularly the newbies who entered market after the Covid crash, will do more harm than good to the overall market in the long run. Therefore, these regulatory measures are to be welcomed," he added.Vijayakumar highlighted that global cues are likely to be supportive on expectations of a rate cut from the US Federal Reserve in September. "The Fed commentary expected tonight is likely to indicate the possibility of rate cut in September," he said.

Lastly, he added that it is time for investors to take a "long-term call" on the market and moderate their expectations to realistic levels."At this juncture in the market safety is important. Chasing super normal returns from the broader market would be a risky game," Vijayakumar said.

Nitin Gadkari seeks removal of GST on life, medical insurance premium: Report



New Delhi. Union Minister of Road Transport, and Highways Nitin Gadkari has called for the elimination of the 18% Goods and Services Tax (GST) on life and medical insurance premiums. In a letter dated July 28 to Finance Minister Nirmala Sitharaman, Gadkari argued that taxing these premiums equates to taxing life's uncertainties and hinders the growth of the insurance sector."You are requested to consider the suggestion of withdrawal of GST on life and medical insurance premium on priority as it becomes cumbersome for the senior citizens," Gadkari wrote. Currently, both life and medical insurance premiums are subject to an 18% GST."Similarly, the 18% GST on medical insurance premium is proving to be a deterrent for the growth of this segment of business which is socially necessary," he added.Gadkari's letter was a response to a memorandum from the Nagpur Divisional Life Insurance Corporation Employees Union, which highlighted the industry's challenges.

Representing Nagpur in the Lok Sabha, Gadkari expressed the union's concerns, stating, "Levying GST on life insurance premium amounts to levying tax on the uncertainties of life. The Union feels that the person who covers the risk of life's uncertainties to give some protection to the family should not be levied tax on the premium to purchase cover against this risk."Gadkari pointed out that the union also noted "differential treatment of savings by way of life insurance, reintroduction of income tax deduction for health insurance premiums and consolidation of public sector general insurance companies". The GST Council. which is responsible for tax-related decisions, is scheduled to meet in August, with its last meeting held on June 22.

Vedanta secures 75% creditor approval for major demerger plan

NEW DELHI. Anil Agarwal-led Vedanta Limited has received approval from 75% of its secured creditors to proceed with its proposed demerger. With creditors' approval, Vedanta can now seek clearance from stock exchanges and file its demerger scheme with the National Company Law Tribunal (NCLT).

The company, in September 2023, planned to demerge into six independent entities: Vedanta Aluminium, Vedanta Oil & Gas, Vedanta Power, Vedanta Steel and Ferrous Materials, Vedanta Base Metals, and a residual Vedanta Limited.



The demerger aims to simplify Vedanta's corporate structure by creating standalone businesses, offering global investors direct access to pure-play companies tied to India's growth story.

"The demerger will create six strong companies, each a Vedanta in its own right, unlocking massive value. While each entity will chart its own course, they will adhere to Vedanta's core values,

leadership," said Agarwal during the annual general meeting.

The demerger is planned to be a simple vertical split for every 1 share of Vedanta Limited, the shareholders will additionally receive 1 share of each of the 5 newly listed companies. The company said Vedanta has a track record of giving strong returns to its shareholders. Till June 2024, Vedanta's total shareholder return over 5-years stood at 276%, while the 5-years average accumulated dividend yield at 65%, delivering significant value for shareholders.

Revenue secretary Sanjay Malhotra rules out LTCG Tax changes in near future

NEW DELHI. Revenue Secretary Sanjay Malhotra confirmed on Tuesday that there will be no changes to the long-term capital gains (LTCG) tax rates in the medium term, reported The Economic Times.Speaking at a post-budget session at the PHD House of Commerce and Industry, Malhotra said that the LTCG tax rates will remain stable at their current levels.Malhotra explained

that the government had reviewed 1.05 million tax returns for the fiscal year 2023-24, which included capital gains from land and buildings. He said that the effective LTCG tax rate on real estate was 11.54% in 2022-23. Although the recent budget removed indexation benefits for LTCG on Malhotra also drew comparisons to the properties, it reduced the tax rate from 20% to 12.5%. This reduction sparked



concerns about a potential increase in tax burden. The budget also raised the tax rate on LTCG from listed equity by 2.5 percentage points to 12.5%. Malhotra described this increase as minimal and stated that the aim of the measure was to simplify the capital gains tax system.

introduction of the new tax regime, which had initially faced similar apprehensions when the new tax regime was introduced. With about 6 crore income tax returns filed last year, and 70% of them under the new regime, the focus has been on simplicity and reducing the compliance burden," he said.

Olympics: Triathlon races to go ahead as Seine

have given the green light for the Olympic women's and men's triathlons to proceed on Wednesday, following recent water tests in the Seine river that showed reduced bacteria levels. This decision ends days of uncertainty caused by heavy rains, which had raised concerns about the viability of swimming in central Paris. Initially scheduled for Tuesday, the men's triathlon was postponed to Wednesday after the river failed to meet water quality standards. The confirmation that the races would go ahead was a relief for athletes, teams, and Paris authorities, who have promised a swimmable

advertisement Seine as a lasting legacy of the Games, with the triathlon serving as a prominent test. "We are thrilled to receive this news," said Benjamin Maze, technical director for France's triathlon federation, in a statement to Reuters. "Now that the event is confirmed, we can fully focus on the competition.' Despite overnight rain, the races were approved to proceed. Organizers based their decision on the analysis of river samples collected at 5 a.m. the previous day, along with expert discussions on weather conditions, according to Paris 2024. Showers resumed at around 5:45 a.m. on Wednesday, adding to the challenge of the bike stage, which includes sharp turns and cobbled road sections. The triathlon, a central showcase of the Paris Olympics, starts and ends at the Alexandre III bridge, with the route taking athletes along part of the Champs-Elysees and past landmarks like the Musee d'Orsay. The women's race, featuring 55 competitors from 34 countries, will begin at 8 a.m. (0600 GMT). Among the top contenders for gold are France's Cassandre Beaugrand and Britain's Beth Potter, who will dive into the Seine side by side from a floating pontoon next to the bridge. The men's event will follow at 10:45 a.m. "The latest water analyses, received at 3:20 a.m., have been deemed compliant by World Triathlon, allowing the triathlon competitions to proceed," stated Paris 2024 and World Triathlon.

Paris Olympics 2024: Simone Biles makes triumphant return, leads US team to gold

New Delhi Simone Biles clinched her fifth Olympic gold medal as she made a triumphant return to the women's gymnastics team final at the Paris Games on Tuesday, reinforcing her status as one of the world's greatest athletes just three years after abruptly withdrawing from the same event at the Tokyo Games. Biles, the most decorated gymnast of all-time, earned the United States their fourth Olympic gold in the women's team event with dazzling performances on all four apparatus. The American has been on what she described as a "redemption tour" at the Paris Games after she shocked a global TV audience by suddenly withdrawing from the team final in Tokyo suffering from the "twisties", a condition involving temporary loss of spatial awareness experienced by gymnasts while performing high-difficulty elements."I started off with therapy this morning and ... I was feeling calm and ready," the 27year-old told an overflowing press conference at the Bercy Arena." As soon as I landed vault, I was like 'oh yeah, we're definitely going to do this'."With the crowd rallying behind Biles and her



teammates in the absence of the French team that failed to qualify for the final, the United States finished with a total of 171.296, an impressive 5.802 points ahead of second-placed Italy. While the Italians BILES, 'A DIFFERENT PERSON won their first women's Olympic team medal since the 1928 Olympics, an incredible, high-flying vault by Rebeca Andrade helped Brazil to land the bronze, their first ever medal in the discipline. Britain finished fourth. Biles said it was too soon to reflect on her legacy and was surprised to hear from a reporter that she has now won a jaw-dropping 38 world and Olympic medals combined."I'm doing what I love and enjoying it, that's all that matters to me," she said."Yes, it's amazing

but I don't think I'll truly understand the depth of it until I walk away from the sport."Biles, who was competing with her left calf taped after suffering a muscle strain during Sunday's qualifying competition, started her bid for the first of a possible five gold medals in Paris on the vault. She powered down the runway before soaring high into the air while executing the Cheng vault to earn 14.900 points. She then glided through her uneven bars routine with ease to the delight of the 15,000 fans packed into Bercy Arena, who serenaded her with chants of "USA, USA, USA!". She was awarded 14.400.

The star-studded crowd that included tennis great Serena Williams and the most successful Olympian ever, swimmer Michael Phelps, also roared their approval when Biles' teammates Sunisa Lee and Jordan Chiles completed their equally impressive displays on the bars by nailing their dismounts. After falling flat on the mat during the warm-up, Lee -- the defending all-around Olympic champion -- stuck her landing on the uneven bars, earning 14.566 points.

There could be a consensus about increasing the team purse up to Rs 120 crore and retentions up to six, including 'Right To Match' ® TM) options, during the IPL's Governing Council's meeting with the owners of all 10 franchises in Mumbai on Wednesday. With a big auction scheduled at the end of this year, the modalities need to be set in order and five points will be on the agenda of the BCCI-team owners meeting where divergent views could emerge on some of the points. While BCCI won't announce the rules and regulations on team building, the inputs from the owners will be taken into account. The PTI spoke to multiple franchises and there was one aspect where everyone agreed that the current team purse of Rs 100 crore needs to be increased by at least 20 to 25 percent."I think that (increase of purse) is happening for sure. The standard increase should be anywhere

between 20 to 25 percent and hence anything in the range of Rs 120 crore to 125 crore will be a fair deal. Most franchises would agree to it," a senior official of one of the IPL franchises told PTI on conditions of anonymity. However, the bigger issue is the player retention where it could be difficult to reach a common ground as most teams have The other bone of contention could be the different requirements. While one powerful franchise seemed to have suggested as many as eight retentions, including RTMs, it is unlikely others will agree to it. Currently, IPL allows four retention per year with three being Indians and one overseas. It is believed that most teams want retention to be between five to six."Obviously, continuity and maintaining a core is very important going forward. May be allow six (retentions) including a couple of RTM cards with at least one uncapped player being kept in the mix. But there could be

some debate over the number of overseas retentions."There are teams like Delhi Capitals (Jake Fraser-McGurk and Tristan Stubbs) and Sunrisers Hyderabad (Pat Cummins, Heinrich Klaasen and Travis Head), who would want more than one overseas retention," an IPL source added.

'Impact Player' rule and while India's T20 World Cup winning skipper Rohit Sharma and star batter Virat Kohli have both spoken openly about how it can affect the development of all-rounders, none of the franchises would mind a contest where 12 players will be available. achievement. The Jwala-Ashwini duo was consistently ranked amongst the top 20 in the world, reaching a peak ranking of 10th. Ashwini and Jwala competed in two Olympics together (2012 and 2016) but were unable to progress beyond the initial stages. "We wanted to get a win today.

Although we hoped for a different and better outcome, the biggest takeaway for Tanisha and me is the journey to

the Olympics. It hasn't been easy," Ashwini reflectedTanisha, also emotional, could not hold back her tears. "She [Ashwini] has been my biggest support here. We wanted a better result and to hold our heads high. She motivated me every time," she said.

Rimi, who has worked with A-listers such as Akshay Kumar and Ajay Devgn, further said that she isn't in touch with anyone from the film industry. "I can't ask anyone for help. Jab tak gidgidao nahin, help nahin milti hai. Why won't other people look for their own benefit? Why will someone go out of their way to help someone?" Rimi asked.
