Fake call centre duping people on pretext of offering jobs busted in Gurugram

Sanjay Kumar Gurugram, July 7: Gurugram cyber crime police busted a fake call centre in sector 49 area here and arrested 17 people, including 15 women, officials said on Sunday. The accused were duping people on the pretext of offering jobs and loans. Fifteen mobile phones and three laptops were recovered from their possession, they said. According to the police, they got a tip that a fake call centre is being run in an office in the Spaze IT park in sector 49 wherein people are being defrauded on the pretext of providing jobs and loans. A raid was conducted by the team of cyber crime, south police station on Saturday night. The operators failed to show any valid OSP licences of Department of Telecommunications or any other agreement/ MoU related to their work, they

said. Seventeen people, including 15 women, were arrested from the call centre, the police said. Those nabbed have been identified as Faizal, Fuzail, Priti, Sarvjeet, Aanchal, Sania, Muskan, Anita, Anjali, Shivani, Manisha, Reena, Kajal, Anjali Singh, Radha, Anushka and Priya, they said. During interrogation, it was revealed that Faizal is the team leader. Through this call centre, these people used to commit fraud on the pretext of giving jobs and loans in the name of a finance company, they said. The 15 women were hired to call people and offer jobs and loans, they said, adding the fraudsters used fake SIM cards and bank accounts to commit fraud. "They used to get a salary of Rs 10,000-20,000 and 2 per cent commission of the cheated amount for committing

Law Commission should draft crucial Bills, not panel with 'part-time' members: Chidambaram

New Delhi, July 7: A day after Vice-President Jagdeep Dhankhar lashed out at

him over his "part-timers" remark on the new criminal laws, Congress leader P Chidambaram on Sunday said drafting of such crucial bills should have been entrusted to the Law Commission and not to a committee whose members served part time. Chidambaram said in a post on X that the Union home ministry constituted a committee in May 2020 for reforms of criminal laws that had a chairman, convenor and members. Its composition was changed from time to time but, in the

end, the committee had a convenor and five members, the former Union home minister said. All but one member were serving professors of various universities and served as part-time members of the

committee, Chidambaram said. It is this Dhankhar lashed out at him over his comcommittee that submitted drafts of the three new criminal laws, he said.

Eventually, Parliament passed the laws, he

added. "I maintain that the drafting of such crucial bills should have been entrusted to the Law Commission and not to a committee whose members served part time and had other responsibilities," the Congress leader said. His remark came a day after

ment that the three new criminal laws were "drafted by part-timers". The vicepresident termed the comment "inexcus-

able" and urged the Congress leader to withdraw his "derogatory, defamatory and insulting" observation. Puri (Odisha), July 7: Thousands of people pulled forward giant chariots from the 12th-century Jagannath temple in Puri towards Gundicha temple, around 2.5 km away, on Sunday afternoon. The chariot pulling started around 5.20 pm after Puri Shankaracharya Swami Nischalanada Saraswati visited the chariots of Lord Jagannath, Lord Balabhadra and Devi Subhadra with his disciples and the Puri's titular king completed the 'Chhera Pahanra' (chariot sweeping) ritual. The wooden horses were fitted to the chariots and the servitor pilots guided the devotees to pull the chariots in the right direction. Ludhiana, July 7: Punjab Governor Banwarilal Purohit on Sunday inquired about the health of Shiv Sena (Punjab) leader Sandeep Thapar who was attacked with swords here two days ago. After reaching the Circuit House here, Purohit spoke to the doctors attending to Thapar who is admitted in a private hospital. He also talked to Ludhiana Police Commissioner Kuldip Singh Chahal and Deputy Commissioner Sakshi Sawhney, and asserted that he came to the city to gather first-hand information about the incident. The Governor asked Chahal to supervise the investigation personally. Shiv Sena (Punjab) leader Thapar got grievously injured after he was attacked with swords by three assailants in full public view here on Friday. "As far as his treatment is concerned, he is being given the best available treatment," Purohit said, adding that the Shiv Sena (Punjab) leader was fortunate that he survived the murderous attack. He suffered head

injuries, but "luckily, his brain and skull remained intact which saved his life," Purohit told reporters. Thapar also has fractures on his hands, he said. "There



will be no disability and he will be able to work normally.". Purohit said investigations are being conducted to know the motive of the culprits. "No guilty will be spared whoever he may be," he asserted. He said some senior police officials should monitor investigations so that

Purohit further said he will also monitor this case. The governor said when security is provided to somebody, he is given a guarantee of total protection. "But here, there was a total failure of security." To a question, the governor said such isolated incidents are taking place in the state which is a matter of worry. But the people of Punjab will not allow such elements to succeed in their plans to disturb brotherhood and peace in the state, he added. In a purported CCTV footage of the Friday incident, the assailants dressed as Nihangs approached Thapar while he was on a scooter with his security personnel riding pillion. While Thapar was speaking to the assailants with folded hands, one of them suddenly attacked him with a sword as passersby looked on. Another assailant appears to be pushing Thapar's security guard away. After Thapar fell down, the third assailant also started hitting Thapar with a sword. Later, two of the accused fled on Thapar's scooter, leaving him in a pool of blood.

Will question anyone required for Hathras stampede probe: Judicial panel

Noida, July 7: The judicial commission set up by the Uttar Pradesh government will speak to anyone required for its inquiry into the July 2 Hathras stampede, a probe panel member said on Sunday when asked if self-styled godman Bhole Baba would also be questioned. The commission will also issue a public notice soon, asking local people and witnesses of the tragic incident to share any evidence related to the stampede, along with their statement, another member and chairperson of the panel retired Allahabad High Court judge Brijesh Kumar Shrivastava told reporters in Hathras. "The commission will speak to anyone required for the Hathras stampede probe," former Indian Police Service (IPS) officer Bhavesh Kumar said when asked if the judicial panel would question the 'godman' as well. lawver The three-member judicial commission, also including former IAS officer Hemant Rao, on Sunday interacted with locals in Hathras, besides officials and witnesses of the tragedy that claimed 121 lives. The panel reached Hathras on Saturday and visited the

INLD to join hands with BSP again for Haryana Assembly polls

Chandigarh, July 7: The Indian National Lok Dal will enter into a tie-up with its former ally Bahujan Samaj Party for the Haryana Assembly polls, which are scheduled later this year, INLD's state unit chief Rampal Majra said on Sunday. "The two parties have in principle agreed to enter into an alliance for the upcoming Haryana assembly and a formal announcement in this regard will be made on July 11," Majra told PTI over phone. He said seat sharing and other issues related to the alliance are being firmed up. Notably, INLD secretary-general Abhay Singh Chautala met BSP president Mayawati at the latter's residence in Lucknow on Saturday. "Various issues related to the state were also discussed by the two leaders during the meeting," Majra said. All non-BJP and non-Congress outfits should "come together and strengthen the hands of Abhay Singh Chautala, the wellwisher of the farmers and the labour class", he said. "Many such outfits are already in touch with us," he said. The INLD and the BSP fought the recently held Lok Sabha polls separately in Haryana and both received a severe drubbing.

CJI-led Supreme Court Bench to hear today petitions seeking scrapping of NEET-UG 2024 exam

New Delhi, July 7: Amid allegations of paper leak and other irregularities, the Supreme Court will hear today petitions seeking scrapping of NEET-UG 2024 examination held on May 5 and conducting it afresh. There is another set of petitions, including the one filed by 56 Guiarat-based successful medical aspirants, seeking to restrain the Centre and the National Testing Agency (NTA) from going for a re-test. Both sets of petitions - totalling 38 - are listed before a Bench of Chief Justice DY Chandrachud, Justice JB Pardiwala and Justice Manoj Misra. The top court has so far refused to stay the counselling of the successful candidates for admissions to MBBS, BDS and other courses. The Union Health Ministry on Saturday refuted reports of postponement of NEET-UG counselling, saying the process was yet to be notified. Earlier, the NTA had told the top court that

However, now it's learnt that counselling

will begin in the third week o July as the process of issuing permission letters to a section of medical colleges was under way and additional seats were likely to be added. Both the Centre and the NTA which conducts the NEET-UG test - have opposed scrapping the examination. Surat building collapse death toll rises to 7

Surat, July 7: The death toll in the collapse of a six-storey building in Gujarat's Surat city has gone up to seven with the recovery of six more bodies overnight, police said on Sunday. A person who collected rent from the building occupants has been arrested. He and two owners of the structure have been booked on charges of culpable homicide not amounting to murder, they said. The residential building, which was in a dilapidated condition and located in the Pal area, collapsed at around 2.45 pm on Saturday, as per the police. A team of the National Disaster Response Force (NDRF), two teams of the State Disaster Response Force, police personnel and fire brigade were involved in the rescue operation, the Surat police said in a statement. After around three hours of operation, they managed to rescue a 20-year-old woman, named Kashish Sharma, and rushed her to the hospital for treatment. The

body of a man was pulled out on Saturday night, an official earlier said. Rescue teams later pulled out six more bodies from the debris, according to police. Seven bodies were recovered from the debris in the operation that continued through the night, Sachin GIDC police station inspector Jignesh Chaudhari said. The deceased, most of them textile workers from Madhya Pradesh and Uttar Pradesh, have been identified as Hiraman Kevat (40), Abhishek (35), Brijesh God (50), Shivpujan Kevat (26), Anmol Harijan (17), Parvesh Kevat (21), and Lalji Kevat (40), the statement said. An FIR has been registered under Section 105 (culpable homicide not amounting to murder) under Bharatiya Nyaya Sanhita against the building owners Raj Kakadiya and his mother Ramilaben Kakadiya, and one Ashwin Vekariya, who collected rent from the occupants, inspector Chaudhari said.

Poor upkeep, Ezhil Nagar TNUHDB tenements falling apart

CHENNAI: The buildings of Tamil Nadu Urban Habitat Development board tenements in Ezhil Nagar, near Kannagi Nagar, are degrading by the day, say residents. They point out to damages in the walls due to water seepage, apart from shoddy electrical cable installations that are an open hazard. The lack of common lighting in the corridors adds to their woes. Water for daily use is pumped to overhead

tanks on the terrace of each block, using motors operated by the water supply board officials. However, during pumping, the pipelines along the rear walls begin to leak owing to damages and broken valves. This continuous leakage has dampened the walls and floors. The overflow from the overhead tanks exacerbates the situation. When TNIE visited the spot, water was found dripping from the terrace to the lower floors, leaving the corridors wet and slippery."Whenever the motor pump is operated, water overflows into the building due to poor roofing and damaged the rear walls cause water damage inside the houses. Despite numerous complaints and paying maintenance charges, no proper maintenance or repairs have been done," said M Sivaprakash, a 47-year-old resident."A pipeline in our block broke a month ago, causing water to drip into my bedroom and bathrooms. Additionally, the drainage sumps are not being desilted, leading to breeding of mosquitoes," said a 33-year-old woman from block 1.

Chaos at GHMC council meeting as corporators clash over political allegiances

HYDERABAD: Unprecedented scenes were witnessed during the GHMC council meeting on Saturday with corporators of the Bharatiya Janata Party (BJP) and the All India Majlis-e-Ittehadul Muslimeen (AIMIM) almost coming to blows over saffron party leaders displaying caricatures targeting Hyderabad MP Asaduddin Owaisi, Chief Minister A Revanth Reddy and BRS president K Chandrasekhar Rao. Even as AIMIM corporators objected to the placards and tried to forcibly remove them, BRS corporators repeatedly stormed the podium, demanding the resignation of Hyderabad Mayor Gadwal Vijayalaxmi for switching loalties to the Congress.It was only due to the presence of marshals who were forced to intervene multiple times that the meeting did not descend into physical violence. However, it was no less than a street fight as leaders from all parties cast decorum aside and accorded scant respect to the situation. The meeting, held after a six-month gap, was adjourned without any agenda items being taken up, resulting in lakhs of rupees spent on arranging it going down the drainEven before the meeting began, BJP and BRS corporators made their intentions clear, reaching the venue wearing black scarves and black ribbons respectively. They also carried sewage pipelines and hyacinths from polluted water bodies to the GHMC head office. As soon as the session began, BRS, BJP and Congress corporators began heated exchanges and disrupting proceedings. Calls for Mayor Vijayalaxmi's resignation dominated through the session, with BRS corporators stating that she now lacks the majority support needed for her position. They also demanded the resignation of Deputy Mayor Mothe Srilatha Reddy who also joined the

Mayor Vijayalaxmi condemned the BRS corporators for their actions, accusing them of encouraging defections. ""For the last two years when BRS was in power, development has come to a standstill, whereas developmental works have been carried out since the last six months after Congress came to power. You did do any development of the city," the Mayor shouted at the BRS members. Following an adjournment, BJP corporators displayed the contentious posters, provoking AIMIM corporators resulting in pandemonium. Marshals intervened to diffuse the situation. Only seven of 39 safari jumbos are registered, says Kerala forest department

KOCHI: Thirty-nine elephants were utilised for illegal elephant safaris in Idukki district, the forest department has revealed. Yet, only seven of the animals possess the requisite 'performing animal' registration from the Animal Welfare Board of India.

An inquiry was conducted following an incident in which a mahout was killed by a pachyderm that had been used for safari in Kallar. Despite frequent violations, the number of cases registered by the department is surprisingly low.In the Peermade range, only one case was registered in 2019, with two more in 2022. Similarly, in the Munnar range, two cases were recorded in 2023, followed by one this year. The department filed the report in compliance with a High Court directive, which sought information regarding the legal framework governing elephant safaris conducted by private individuals.

The report said the department has issued notices to all illegal elephant camps and as of now none of them are operational. During surprise inspections or the trimonthly verification of captive elephants,



safaris or ticketed viewing of elephant baths and hand feeding of the animals had not been noticed, it said. Communication was also issued to the district monitoring committee, chaired by the district collector, The court questioned the government on

to control and curb all illegal safaris in the district. It claimed that frequent raids and surprise checks have resulted in nine cases being registered in the last four years.

Nuh yatra this year too, say outfits

GURGAON. Hindu outfits have said they will bring out their annual Brajmandal Shobha Yatra in Nuh this year too, leading to concern about law and order as the state heads into assembly elections later this year.

Violence had erupted during last year's yatra on July 31, triggering riots across several south Haryana districts and claiming seven lives, including those of two homeguards. Around 90 people were injured in the clashes. Officials said they had received no intimation about any such yatra in Nuh this year. However, members of Vishwa Hindu Parishad and Bajrang Dal claimed they were mobilising supporters from all 22 districts of the state for the procession, which is likely to be taken out on July 22."This year, the yatra will be organised on Monday, July 22, under the guidance of sadhus and religious leaders of various Hindu organisations," said Rajkumar Garg of Agrawal Mahasabha Nuh. Anurag Kulshrestha, the VHP social media head in the state, insisted the procession would be a "purely religious and non-political" event. "It will be led by sadhus, who will focus on the spiritual significance of the yatra. We will ensure it remains peaceful and devotional," he added. According to Kulshrestha, around 15,000 people are likely to participate in the rally. There will be volunteers to guard the walkers this year, Kulshrestha said. During last year's yatra, participants were pelted with stones, which sparked the violence. Nuh DC Dhirendra Khadgata said nobody had written to the authorities seeking permission for the march. Police chief Vijay Pratap said no permission had been given for any yatra. Nuh legislator Aftab Ahmed of Congress said, "I am worried because of last year's violence. The district

Doctor accused of negligence lodged false FIR too: Cops

Gurgaon: More than a year after an FIR was filed against a relative of a medical negligence victim, police in the city have filed a closure report and cancelled the FIR, stating it was found to be false and malicious.

Simran Chhabra died on Jan 21, 2023, at Jagdamba Hospital in Jyoti Park, Gurgaon, amid allegations of medical negligence. Advocate Nishant Bharihoke, representing the woman's family, said that the 22-yearold resident of Jyoti Park had admitted herself to the hospital complaining of a stomach ache on Jan 21 and passed away within a few hours. "She had arrived at the hospital on her scooter and did not have any prior history of illness," he added .When her family pursued the case, Dr Rohit Lalit, doctor who was accused of negligence, filed an FIR on April 11, 2023, accusing the deceased's family of trespassing, intimidation, and causing hurt. The crime branch of Gurgaon police investigated the allegations made by Dr Lalit and found them to be "baseless". Consequently, the police submitted a closure report for the FIR with judicial magistrate first class (JMFC) Anil Kumar Yadav earlier this week. Advocate Bharihoke further added that the false FIR was an attempt to intimidate the bereaved family amid their pursuit of justice.

"Now that the police have filed a closure report before the court and cancelled the FIR, our case against the doctor strengthens and aids in our fight for justice for Simran Chhabra," said Bharihoke, adding that Dr Lalit is also facing criminal charges for allegedly assaulting the family's advocate on Aug 27, 2023.

'The incident is recorded under FIR No. 173/2023 at Police Station New Colony, Gurgaon. Stricter regulations are needed to prevent such incidents. The case highlights the critical importance of transparency and integrity in the medical field," said Bharihoke. The court will consider the closure report on July 23, 2024. US elections: At Essence, Black Democrats rally behind Biden and talk up Kamala Harris

NEW ORLEANS. As President Joe Biden tries to revive his embattled reelection bid, Vice President Kamala Harris led a parade of Black Democrats who warned Saturday that the threat of another Donald Trump presidency remains the most important calculation ahead of November. Yet in more than 20 minutes on stage at the Essence Festival of Culture, Harris did not acknowledge Biden's dismal debate performance or calls for the 81-year-old president to end his reelection bid. In fact, she barely mentioned Biden at all – a stark contrast to the Congressional Black Caucus members who forcefully and repeatedly defended the president by name."This is probably the most significant election of our lifetime," Harris said, before riffing on Trump musing about being a dictator, pushing the Supreme Court rightward and promising retribution on political enemies. "In 122 days, we each have the power to decide what kind of country we want to live in.

Harris's appearance at the nation's largest annual celebration of Black culture underscores what a difficult task it is for the White House and campaign to navigate questions about the president's aptitude. The dynamics are especially fraught for Harris, the first Black woman and person of South Asian descent to be elected vice president, and for the Black Democrats who were so instrumental in electing Biden and her in 2020.On one hand, Harris fills the traditional role of loyal lieutenant, a job she did enthusiastically - and on the fly - in television appearances immediately after Biden's lacklustre debate ended. Yet should Biden ultimately decide to step aside as presumptive nominee, she would be among the favourites, if not the favourite, to carry the Democratic banner against Trump.

Black leaders and voters who gathered in New Orleans, meanwhile, walked the line Saturday between backing Biden and insisting that, if he does end his campaign, the party should elevate the barrier-breaking vice president rather than consider governors like Gavin Newsom of California or Gretchen Whitmer of Michigan, both of whom are white. The purpose of a vice president is to be a No. 2, to be able to step in," said Glynda Carr, who leads the Higher Heights political action organization that works to elect more Black women. "If this was an allwhite male ticket, would we be talking about other people who have less experience, less qualifications?"

It's France's moment of truth. Here's how its snap elections work and what comes next

PARIS. French voters face a decisive choice Sunday in the runoff of snap parliamentary elections that could produce the country's first far-right government since the World War II Nazi occupation — or no majority emerging at all.Marine Le Pen's anti-immigration, nationalist party National Rally stands a chance of winning a legislative majority for the first time, but the outcome remains uncertain because of a complex voting system and tactical maneuvers by political parties.

What's happening Sunday?

Voters across France and overseas territories can cast ballots for 501 of the 577 seats in the National Assembly, the lower and most important of France's two houses of parliament. The other 76 races were won outright in the first round of voting.

The National Rally and its allies arrived ahead in Round 1 with around one-third of the votes. A coalition of center-left, hard-left and greens parties called the New Popular Front came in second position, well ahead of President Emmanuel Macron's struggling centrist alliance. In the frantic wek between the two rounds, more than 200 centrist and left-wing candidates pulled out of races to boost the chances of their moderate rivals and try to keep National Rally candidates from winning. Final pre election polls suggest that tactic may have diminished the far right's chances of an absolute majority. But Le Pen's party has wider and deeper support than ever before, and it's up to voters to decide. What are the possible outcomes?

Polling projections suggest the National Rally is likely to have the most seats in the next National Assembly -which would be a historic first.

If it wins an absolute majority of 289 seats, Macron would be expected to appoint National Rally president Jordan Bardella as France's new prime minister. Bardella could then form a government, and he and Macron would share power in a system called

France is voting in key elections that could see a historic far-right win or a hung parliament

PARIS. France will vote Sunday in pivotal runoff elections that could hand a historic victory to Marine Le Pen's far-right National Rally and its inward-looking, anti-immigrant vision - or produce a hung parliament and years of political deadlockSunday's snap elections in this nuclear-armed nation have potential impact on the war in Ukraine, global diplomacy and Europe's economic stability. And they're almost certain to undercut President Emmanuel Macron for the remaining three years of his presidency. Racism and antisemitism have marred the electoral campaign, along with Russian cybercampaigns, and more than 50 candidates reported being physically attacked - highly unusual for France. The government is deploying 30,000 police on voting day. The heightened tensions come while France is celebrating a very special summer: Paris is about to host exceptionally ambitious Olympic Games, the national soccer team reached the semifinal of the Euro 2024 championship, and the Tour de France is racing around the country alongside the Olympic torch. Meanwhile, 49 million voters are in the midst of the country's most important elections in decades. France could have its first far-right government since the Nazi occupation in World War II if the National Rally wins an absolute majority and its 28year-old leader Jordan Bardella becomes prime minister. The party came out on top in the previous week's first-round voting, followed by a coalition of center-left, hard-left and Green parties, and Macron's centrist alliance. The outcome remains highly uncertain. Polls between the two rounds suggest that the National Rally may win the most seats in the 577-seat National Assembly but fall short of the 289 seats needed for a majority. That would still make history, if a party with historic links to xenophobia and downplaying the Holocaust, and long seen as a pariah, becomes France's biggest political force.

Israeli strike in Gaza school kills 16, army says targeted Hamas gunmen

An Israeli strike on a school sheltering displaced Palestinians in Gaza has killed at least 16 and wounded dozens. Israel claimed it targeted militants, while Hamas denied their presence and described the civilian toll as catastrophic.

Cairo/Gaz At least 16 people were killed in an Israeli strike on a school sheltering displaced Palestinian families in central Gaza on Saturday, the Palestinian health ministry said, in an attack Israel said had targeted militants. The health ministry said the attack on the school in Al-Nuseirat killed at least 16 people and wounded more than 50.The Israeli military said it took precautions to minimize risk to civilians before it targeted the gunmen who were using the area as a hideout to plan and carry out

fighters were there. At the scene, Ayman al-Atouneh said he saw children among the dead. "We came here running to see the targeted area, we saw bodies of children, in pieces, this is a playground, there was a trampoline here, there were swing-sets, and vendors," he said. Mahmoud Basal, spokesman of the Gaza Civil Emergency Service, said in a statement that the number of dead could be said. rise because many of the wounded were in critical condition. The attack meant no place in the enclave was safe for families who leave their houses to seek shelters, he said. Al-Nuseirat, one of Gaza Strip's eight historic refugee camps, was the site of stepped-up Israeli bombardment on Saturday. An air strike earlier on a house in the camp killed at least 10 people and wounded many others, according to medics. In its daily update of people killed in the nearly nine-month-old war, the Gaza health ministry said Israeli military strikes across the enclave killed at least 29 Palestinians in the past 24 hours and wounded 100 others. Among those killed in separate air strikes on Saturday were



five local journalists, raising the toll of journalists killed since October 7 to 158, according to the Hamas-led Gaza government media office.Gaza health uthorities say more than 38,000 Palestinians have been killed in Israel's offensive. The health ministry does not distinguish between combatants and noncombatants but officials say most the dead are civilians. Israel has lost 323 soldiers in Gaza and says at least a third of the Palestinian dead are fighters.Israel launched its offensive, aimed at eliminating the militant Islamist group Hamas, in response to a Hamas-led assault on Israel on Oct. 7 in which 1,200 people were killed and over 250 taken

Israeli forces, which have deepened their incursions into Rafah, in the south of the enclave near the border with Egypt, killed four Palestinian policemen and wounded eight others, in an air strike on their vehicle on Saturday, health officials said.

statement issued by the Hamas-run interior ministry said the four included Fares Abdel-Al, the head of the police force in western Rafah neighbourhood of Tel Al-Sultan. The Israeli military said forces continued "intelligence-base operations" in Rafah, destroyed several underground structures, seized weapons and equipment, and killed several Palestinian gunmen.

Israel has said its operations in Rafah aim to eradicate the last Hamas armed wing battalions.e Israeli military said it eliminated a Hamas rocket cell in Deir Al-Balah in central Gaza that operated from inside a humanitarian-designated area. Joe Biden says only 'Lord Almighty' could convince him to quit White House race

World. US President Joe Biden insisted that his goal was to defeat his Republican rival and former President Donald Trump, adding that only "Lord Almighty" could persuade him to withdraw himself from the race, The Guardian reported. His remarks came amid a section of Democrats calling on the 81-year-old president to pull himself out of the race following a shaky performance at the June 27 presidential debate, which saw him slipping up, stammering, appearing confused and perceived loss of train of thought.Biden, who is the oldest US President, has been under the scanner over his mental health and age concerns and whether he is fit to serve another four-year term. The Democrat leader has repeatedly insisted he was fine.In an interview with George Stephanopoulos of ABC News on Friday, Biden said, "Look. I mean, if the Lord Almighty came down and said, 'Joe, get out of the race', I'd get out of the race," he said, adding, "The Lord Almighty's not coming down."He also dismissed his lacklustre performance at the presidential debate as a "bad



episode" and took full responsibility for what transpired. "I just had a bad night. I don't know why," he said. Biden also refused to get a detailed cognitive test done and make the results public to reassure voters he is fit to run for a second time in office."I have a cognitive test every single day. Every day I have that test - everything I do (is a test)," he said. The 81-year-old Democrat insisted that fatigue was the only issue and that there were "no indications of any serious condition". "I was exhausted. I didn't listen to my instincts in terms of preparing," Biden said. He further said it was no one else's fault but his own, admitting that he had been feeling "terrible" before the debate and mentioned undergoing a Covid-19 test and checks for other

infections, all of which came back negative. "I just had a really bad cold." on staying in the race, declaring.

The President also mentioned the ongoing assessments by his personal doctors, who he said would not he sitate to inform him if something were wrong. "Can I run the 100 in 10 flat? No. But I'm still in good shape," Biden remarked.Despite the debate setback, Biden exuded confidence about having what it takes to beat Trump, brushing off growing concerns and polls showing him trailing the Republican. "I don't think anyone is more qualified," he stated. He also noted that Trump's disruptions during the debate had been distracting, admitting, "I realised that, even when I was answering a question and they turned his mic off, he was still shouting and I let it distract me. I'm not blaming it on that. But I realised that I just wasn't in control."he interview, along with campaign stops in battleground states Wisconsin and Pennsylvania, is part of Biden's effort to win back voters after his faltering debate performance. France to vote in presidential runoff today as far-right bids for power

Paris. France is set to vote in a presidential runoff on Sunday that will reconfigure the political landscape, with opinion polls forecasting the far-right National Rally (RN) will win the most votes, but likely fall short of a majority.Such an outcome could plunge the country into a chaotic hung parliament, severely denting the authority of President Emmanuel Macron. Equally, if the nationalist, eurosceptic RN did win a majority, the pro-business, pro-Europe president could find himself forced into a difficult "cohabitation". Marine Le Pen's RN scored historic gains to win last Sunday's first-round vote, raising the spectre of France's first farright government since World War Two. But after centrist and leftist parties joined

forces over the past week in a bid to forge an anti-RN barricade, Le Pen's hopes of the RN winning an absolute



majority in the 577-seat National Assembly seem less certain.Polls suggest the RN will become the dominant legislative force, but fail to reach the 289-seat majority that Le Pen and her 28-year-old protege Jordan Bardella believe would allow them to claim the prime minister's job and drag France sharply rightward.

Polls open at 8 am and close at 6 pm in towns and small cities and 8 pm in larger cities, with initial projections expected the moment voting ends, based on partial counts from a sample of polling stations. Much will depend on whether voters follow the calls of leading anti-RN alliances to block the far right from power, or support far-right contenders.Raphael Glucksmann, a member of the European Parliament who led France's leftist ticket in last month's European vote, said he viewed Sunday's run-

off as a simple referendum on whether "the Le Pen family takes over this

'France is on the cliff-edge, and we don't know if we're going to jump," he told France Inter radio last week.A longtime pariah for many due to its history of racism and antisemitism, the RN has increased its support on the back of voter anger at Macron, straitened household budgets and immigration concerns.

Reformist Pezeshkian wins Iran's presidential runoff election, besting hard-liner Jalili

DUBAI.Reformist candidate Masoud Pezeshkian won Iran's runoff presidential election Saturday, besting hard-liner Saeed Jalili by promising to reach out to the West and ease enforcement on the country's mandatory headscarf law after years of sanctions and protests squeezing the Islamic Republic.ezeshkian promised no radical changes to Iran's Shiite theocracy in his campaign and long has held Supreme Leader Ayatollah Ali Khamenei as the final arbiter of all matters of state in the country. But even Pezeshkian's modest aims will be challenged by an Iranian government still largely held by hard-liners, the ongoing Israel-Hamas war in the Gaza Strip, and Western fears over Tehran enriching uranium to nearweapons-grade levels. vote count offered by authorities put Pezeshkian as the winner with 16.3 million votes to Jalili's 13.5 million in Friday's election. Supporters of Pezeshkian, a heart surgeon and longtime lawmaker, entered the streets of Tehran and other cities before dawn to celebrate as his lead grew over Jalili, a hard-line former nuclear negotiator.But Pezeshkian's win still sees Iran at a delicate moment, with tensions high in the Mideast over the Israel-Hamas war in the Gaza Strip, Iran's advancing nuclear program, and a looming U.S. election that could put any chance of a detente between Tehran and Washington at risk. The first round of voting on June 28 saw the lowest turnout in the history of the Islamic Republic since the 1979 Islamic Revolution. Iranian officials have long pointed to turnout as a sign of support for the country's Shiite theocracy, which has been under strain after years of sanctions crushing Iran's economy, mass demonstrations and intense crackdowns on all dissent.Government officials up to Supreme Leader Ayatollah Ali Khamenei predicted a with state television airing images of modest lines at some polling centres across the country. However, online videos purported to show some polls empty while a survey of several dozen sites in the capital, Tehran, saw light traffic amid a heavy security presence on the streets. The election came amid heightened regional tensions. In April, Iran launched its first-ever direct attack on Israel over the war in Gaza, while militia groups that Tehran arms in the region — such as the Lebanese Hezbollah and Yemen's Houthi rebels — are engaged in the fighting and have escalated their attacks.Iran is also enriching uranium at near weapons-grade levels and maintains a stockpile large enough to build several nuclear weapons, should it choose to do so. And while Khamenei remains the final decisionmaker on matters of state, whichever man ends up winning the presidency could bend the country's foreign policy toward either confrontation or collaboration with the West.

Trump distances himself from 'Project 2025' to overhaul US administration

→ The Project 2025 outlines a dramatic expansion of presidential power and a plan to fire as many as 50,000 government workers to replace them with Trump loyalists.

Washington Former President Donald Trump tried to distance himself on Friday from a conservative group's sweeping plans for the next Republican presidency, days after its leader claimed a second American Revolution was underway that would "remain bloodless if the left allows it to be."The Republican presidential candidate renounced any connection with Project 2025, a plan Democrats have been attacking to highlight what they say is Trump's extreme policy agenda for a second term should he beat President Joe Biden in the Nov. 5 election. Many people involved in the project led by the Heritage

Foundation, America's top conservative think tank, worked in the Trump White House and would likely help fill out his administration if he wins in November.But Trump said on his Truth Social platform he had nothing to do with the plan."I know nothing about Project 2025. I have no idea who is behind it," he wrote."I disagree with some of the things they're saying," he continued, adding some of their assertions were "absolutely ridiculous and abysmal."

Trump's post came three days after Heritage Foundation president Kevin Roberts' comments on Steve Bannon's "War Room" podcast about a second American Revolution. Democrats and others criticised what they viewed as a veiled threat of violence. In a statement provided by a Project 2025 spokesperson on Friday, Roberts repeated his claim that Americans were carrying out a revolution "to take power back from the elites and despotic bureaucrats" and said it was the political left that had a history of political violence. The spokesperson said that



while Project 2025 provided recommendations for the next Republican president, it would be up to Trump, should he win, to decide whether to implement them. Trump's move to create distance with Project 2025 could in part reflect an effort to moderate his message in the final months of the race, especially with Biden's campaign faltering after the Democratic candidate's June 27 debate, said James Wallner, a political science professor at Clemson University."Trump is basically now seeking to appeal to a broader audience," Wallner said. The Biden campaign has stepped up its efforts to tie Trump's

campaign to Project 2025."Project 2025 is the extreme policy and personnel playbook for Trump's second term that should scare the hell out of the American people," campaign spokesperson Ammar Moussa said in a statement.The 900-page blueprint calls for drastic reform of the federal government, including a gutting of some federal agencies and a vast expansion of presidential power. Trump's statements and policy positions suggest he is aligned with some but not all of the project's agenda. The plans have been drawn up by the Heritage Foundation in coordination with a collection of other like-minded groups.A number of people who worked on Project 2025 have close ties to the former president. Russ Vought, who was Trump's director of the Office of Management and Budget and is heading up a key committee at the Republican National Convention, authored one of the project's chapters. Stephen Miller, a former senior adviser to Trump who is widely expected to be tapped for a top job in a second Trump administration, heads up a legal group on Project 2025's advisory board.

Forgery 'scandal' surfaces in Nellore

NELLORE: A major controversy has erupted in the Nellore Municipal Corporation (NMC) following allegations of forgery and misconduct, involving several officials and the husband of Mayor.n a complaint filed by advocate Kaku Murali, it was alleged that mortgage release deeds were processed without obtaining the necessary Occupancy Certificates from the NMC, with the forged Municipal Commissioner's signature, by four officials.

According to the complaint, the illegal activity had facilitated the premature release of mortgage deeds for more than 70 building files. The operation was alleged orchestrated by P Jayavardhan, husband of the Mayor, and his assistant G Siva Krishna.

In response to these serious allegations, the NMC issued show-cause notices to the officials involved, including B Praveen, M Devendra, P Nagendra Babu and K Karthik Malavya. Their explanations ranged from outright denial of involvement to claims of being manipulated by Jayavardhan and Siva Krishna.Following an initial investigation, the NMC has suspended the four officials pending a full inquiry by the Vigilance Department. A request has been made to the Regional Vigilance and Enforcement Officer of Nellore District for a detailed investigation. A letter has also been sent to the Director General of Vigilance and Enforcement in Vijayawada for a comprehensive inquiry into the matter. A show-cause notice has also been served to Dileep Kumar Chinthada, a structural engineer and licensed technical person, allegedly involved in the scandal. On Saturday, Municipal Commissioner Vikas Marmat asked for a full-fledged criminal inquiry into the matter, focusing on the main accused Jayavardhan and Siva Krishna as well as the officials involved in it. The case has raised serious concern about the integrity of administrative processes in the municipal

Trains in Chennai railway division flunk punctuality test, passengers hit hard

CHENNAI: Why are long-distance trains increasingly running late in Chennai? The punctuality of express and passenger trains operated by the Chennai division of the Southern Railways has dropped substantially in 2023-24, compared to the previous year, shows official data. The punctuality of mail and express trains dropped in 11 of 12 months from April 2023 to March 2024 compared to the corresponding period of the previous year. The punctuality of passenger trains witnessed a reduction in all 12 months. Chennai division operates around 300 mail and express trains and 170 passenger trains every day, apart from other special trains. Majority of these trains originate/terminate at Dr MGR Chennai Central and Chennai Egmore, which together account for around 60 pairs of daily trains and many other weekly, biweekly, and tri-weekly trains. The punctuality of mail/express trains dropped to 79.58% in July 2023 compared to 92.67% in July 2022. Punctuality reduced to 86.3% in April 2023 compared to 96.06% in April 2022. The punctuality of trains indicates the percentage of trains that reached the stations on time. Similarly, in case of passenger trains, the punctuality was 88.49% in August 2023 while it was 96.15% in August 2022. Responding to the information, a Southern Railway spokesperson said the cause-wise analysis of punctuality cases in Chennai division for fiscal years 2023 and 2024 showed that the planned upgradation works in Train timings to be monitored on daily infrastructure, including tracks and signal



punctuality issues. These works were carried out in addition to the mandatory scheduled maintenance work for assuring safety in train running, he added."Similar infrastructure upgradation and scheduled maintenance work in adjacent railways and divisions caused reception of trains Sridhar Joshi, a Chennai-based rail already running late at interface point stations such as Jolarpettai, Gudur, Renigunta, and Katpadi. This was also a cause for the increase in punctuality loss in the division," the official said.

Andhra Pradesh: CBI arrests 5 Guntakal railway officials on corruption charges

ANANTAPUR: The Central Bureau of Investigation (CBI) arrested five senior officials of Indian Railways at Guntakal, including Guntakal Divisional Railway Manager Vineet Singh, on charges of corruption late Friday night. The arrested officials were taken to the government hospital for medical checkup. According to CBI Deputy SP Jai Kumar Bharatiya, New Delhi, the arrests were made in connection with a case registered under U/s 61(2)-BNS and Sections 7, 8, 9, 10 and 12 of the Prevention of Corruption Act, 1988 (as amended in 2018) on July 4, 2024. The operation targeted alleged irregularities involving financial transactions and administrative processes within the railway division. The CBI special teams arrested Vineet Singh, DRM, Guntakal division, Kunda Pradeep Babu, Senior Divisional Finance Manager, U Akki Reddy, former Senior Divisional Engineer, Coordination, now transferred as Deputy CEN Track, South Central Railway, Secunderabad, M Balaji, Office Superintendent, Engineering Section, SCR, Guntakal Division, and D Lakshmi Pathi Raju, Accounts Assistant, Gati Shakti Office in the office of Chief Project Manager, SCR, Guntakal.

The CBI teams seized substantial amount of cash from the houses of some of the accused. About Rs 7 lakh was seized from the house of Vineet Singh, Rs 10 lakh from Pradeep Babu, Rs 50,000 from Balaji and Rs 50,000 from Lakshmi Pathi Raju.

It may be noted here that the CBI teams, camped in Guntakal for the past three days, gathering comprehensive information, before carrying out inspections and searches. They initially questioned Office Superintendent Raju from the Gati Shakti Department, Office Superintendent Balaji from the Budget Department, bill clerk Prasad, and Johnson, an attendant in the Accounts Office. FSSAI issues summons to KFC over use of chemical to clean oil

THOOTHUKUDI: Following the seizure of magnesium silicate- Speaking to TNIE, Food Safety synthetic (MSS) from a KFC outlet on Thursday, the Thoothukudi unit of the Food Safety and Standards of Authority of India (FSSAI) has issued summons on Saturday to the restaurant chain's Indian headquarters in Mumbai. As per the summons issued to the KFC licensee of the Thoothukudi outlet, KFC material godown in Tiruppur, and the nominee

of KFC headquarters in Mumbai, they have been asked to appear before the FSSAI's designated officer on July 8. A Delhi-based manufacturer of MSS and a packing unit in Telangana have also been summoned for an inquiry on July 15.Meanwhile, the American restaurant chain, in a statement, said, "KFC India is committed to follow the best practices and international standards. High-quality oil and chicken is sourced from reputed suppliers, and all applicable safety and quality standards laid down by the FSSAI and other authorities are stringently followed. The use of Magnesium Silicate as a clarifying agent is approved as per FSSAI, and KFC chicken is completely safe for

consumption after cooking.' 'MSS has no place in food service businesses' Designated Officer Dr Mariappan said they carried out a surprise inspection at the outlet against the backdrop of declining quantity of disposal of used oils to the authorised biodiesel dealer from the outlet."The KFC restaurant was returning only 100 litres of oil per month to the FSSAI authorised used



oil aggregators though it was consuming nearly 1,350-1,500 litres of refined edible vegetable oil every month. Thus the inspection turned Late on Thursday, the food safety towards management of used oil by the outlet as oil once used cannot be reused as per FSSAI rules," Dr Mariappan said.MSS was being used for polishing or cleaning used oil which is against

FSSAI standards, sources said. The FSSAI has permitted MSS to be used as a food additive, but restricted it to certain foods like salt and that too in manufacturing units. MSS has no role in food services businesses like restaurants. The FSSAI does not permit any additives to purify or polish used oils, Mariappan said.Disputing the claims of KFC on two counts, Mariappan said reuse of used edible oils/recycle of oil is not acceptable as per regulations governing food safety."Also nowhere the FSS Act or rules or regulations permit the use of MSS, a food additive, to polish or clean used oil. Hence, there is no role for MSS in food services establishments like restaurants," he

Elevators still a death trap for **KP Park residents in Chennai**

CHENNAI: After a 60-year-old man recently fell to death in an elevator shaft in TNUHDB's KP Park tenements in Pulianthope, the residents said not much had been done to enhance elevator safety even after the fatal incident. Owing to the looming risk posed by the elevators, the residents, irrespective of age and physical condition, are forced to climb several flights of stairs to reach their homes. During a visit by TNIE to the Tamil Nadu Urban Habitat Development Board (TNUHDB) tenements, residents said that crucial safety features for elevators such as Automatic Rescue Device (ARD) system or Uninterruptible Power Supply (UPS) were not installed in some blocks. The generator has been non-functional and power outages occur often, leading to multiple instances of individuals getting trapped in elevators and requiring urgent rescueA lift operator employed at the resettlement said, "I have operated lifts in various places, including hotels, and they are usually equipped with ARD systems. The absence of such a system here leads to people getting trapped during power outages and we have to coordinate rescue as soon as possible."

Explaining the issue further, a lift mechanic, who undertakes work in the area, said, "An elevator ARD system is designed to safely bring passengers to the nearest floor and automatically open the doors in case of a power failure, operating with a backup power source like batteries. In contrast, a UPS is a broader power-backup system.

Kottayam MCH performs first paediatric liver transplant in govt sector

KOTTAYAM: The Government Medical College Hospital (MCH) in Kottayam has achieved a significant milestone by performing the first-ever paediatric liver transplant in the government sector. The recipient of this life-saving procedure is a five-year-old, whose 25-year-old mother donated a portion of her liver. Mother and child are reported to be stable and are currently recovering. Dr R S Sindhu, head of surgical gastroenterology at MCH, led the surgery which began at 6am and concluded at 10.30 pm on Friday. The child was diagnosed with biliary atresia, a rare condition in infants that causes scarring ad blockage of the bile ducts inside and outside the liver. The procedure marks a significant achievement for the MCH as it is only the second government hospital in India, after

the Institute of Liver and Biliary Sciences (ILBS) in Delhi, to successfully perform paediatric liver transplantation.

Dr Sindhu attributed the success to the collaborative efforts of various departments. "Performing a liver transplant on a child carries inherent risks, but in cases of congenital diseases like biliary atresia, it is oten the only viable treatment option," she said. The recipient and donor have both been removed from ventilator support, with the child expected to remain in intensive care for observation for at least three weeks. The true success of the transplant will be determined after the highest risk period has passed, as acute cellular rejection (ACR) can

Kya Pappu pass ho gaya

PAPPU, as Congress leader Rahul Gandhi has been pejoratively called for several years by the ruling BJP, has cleared the people's test, as we know by now, with pretty good marks. Not with a 'first class first', as was said in the good old days, nor with 'distinction' or 'flying colours', because that would have meant that the Congress or the INDIA bloc was voted to power in the recent elections. But certainly enough to make a difference in the 18th Lok Sabha — as well as in the rest of the country. Rahul's speech in this short, inaugural session in which he invoked the gods and saints - from Shiva to Guru Nanak and Jesus Christ — as he sought to draw a distinction between the allencompassing spirit of Hinduism and a more muscular Hindutva that the BJP has recently espoused, was long needed to be made in Parliament.eanwhile, fiery Trinamool Congress leader Mahua Moitra quoted both Pablo Neruda and Puneet Sharma ("tum kaun ho bey/mujhe poochhtey ho/iss desh se mera rishta kitna gehra hai") to assert the new 'freedom from fear' that she insisted was the new leitmotif of the land.

Significantly, neither Chandrababu Naidu's TDP nor Nitish Kumar's JDU, which help keep Prime Minister Modi in power, made much of a noise. It was almost as if they didn't care. Seems both Naidu and Nitish are keenly aware despite the latter's alleged medical condition that this is the time to strike while the iron is hot. Meaning, now is the time to demand cash from the Centre to refurbish their states, with or without 'special category status'. Naidu especially, who furnishes 16 key MPs to the NDA, well understands the nature of his newfound power. He's been in a few political parties, doesn't mind the tag of a turncoat, and as Modi's ally intends to extract his pound of flesh. So, on Thursday in Delhi, he met six ministers - Amit Shah, Nitin Gadkari, Piyush Goyal, Shivraj Singh Chouhan, Manohar Lal Khattar and Hardeep Puri — apart from the PM. The Centre, he added, should set up a mechanism to 'effectively coordinate' with his state's officials for 'timely intervention' in the issues flagged - from building a ring road around the new, unbuilt capital at Amravati to demanding that Finance Minister Nirmala Sitharaman announce the establishment of a new oil refinery for Andhra Pradesh in her Budget speech.It's not clear how much money Naidu wants. Some say Rs 1 lakh crore; others say half of that. What is crystal clear is that he is going to get it. According to this hyper-realist school of thought, warm and fuzzy speeches in Parliament, like those made by Rahul and Mahua, are, frankly, irrelevant. That Modi 3.0 will last only as long as Naidu remains fully satisfied, and that therefore it will be in Modi's interest to keep him in that state of pleasure.

Moreover, it's not as if Delhi doesn't have the money - it does. It also has the smartest bureaucrats to figure out how to pay it out. Both Modi and Naidu know that. Nor has it escaped them that Nitish may be the more dangerous man today because Bihar will go to the polls next year and that a desperate man may go to any lengths to get his needs met - including switching political parties. Fortunately for all sides concerned, India is one of the few sweet spots in the world today, because its economy is doing fairly well - although it's another matter whether a substantial part of the money should be used to dress up just two states.

Which version of Delhi, then, is more true? The one that insists that India has changed because the BJP is not just no longer in majority, but on the back foot, and that people will no longer bend towards the ruling party's majoritarian agenda? Or the one that believes that Parliament must necessarily remain an upscale debating club, because the real exercise of power will always take place outside.

UK poll verdict more a Tory defeat than a Labour victory

Rishi Sunak had little time to undo the damage inflicted on the economy by Liz Truss' mismanagement.

THE overwhelming conclusion that emerges from the UK general election results is that it is more of a defeat of the Conservative Party and less of a victory for the Labour Party. Though voters demonstrated their deep disenchantment with the ruling party and the government, they did not show much enthusiasm for Labour.The protest vote against the Conservative government ensured a massive Labour majority. The electoral contest witnessed one of the lowest voter turnouts in the UK's electoral history. Many

Conservative supporters simply did not turn out to vote or voted for the more extreme right-wing party, Reform UK. This contributed significantly to the devastating rout of the Tories, to the extent that former Prime Minister Liz Truss and dozens of ministers suffered humiliating

The lack of enthusiasm for Labour was a result of the general perception that party leader Keir Starmer could not be trusted because he kept making Uturns on policies regarding green transition, taxing billionaires, improving workers' rights, child benefits and the welfare regime. He opted for politics of ambiguity by focusing on promising change, based on his assessment that voters were unhappy with the Conservative Party's governance, but stopped short

of offering concrete proposals.he dissatisfaction with the Tories also benefited the Liberal Democrats - the third largest party, after the Conservatives and Labour who were the main opponents of the Conservatives in some regions, especially South West England. Their tally of 71 seats (in a Parliament of 650 seats) is their best electoral performance since 1923. The Green Party has achieved great success. For over a decade, the party could secure just one seat. But it broke through that barrier this time, winning all four seats it had targeted with massive margins. The party had contested 574 seats all over England and Wales to ensure the presence of its vision and programme even in those places where it did not have an adequate party structure. It emerged in the second place in a substantial number of seats, suggesting the possibility of further expansion. The increasing influence of the Green Party is an indication of the growing consciousness, especially among younger and university-educated voters, of the urgency of green economic policies to avert a climate catastrophe. The party bagged nearly 8 per cent of the votes in the country, indicating that if there were to be a proportional representation system of election, the party's seats and influence in Parliament and policymaking would achieve a substantial boost.

The shift from the flawed first-past-the-post system of elections to the proportional representation system is strongly supported by the Liberal Democrats and the



Green Party. The Labour Party conference has also formally passed a resolution in favour of proportional representation, and it remains to be seen whether the new government will actively seek to bring about this change in the electoral system. The UK is the only country in Europe that does not have any proportional representation dimension in its election system. Unfortunately, the first-past-the-post system followed in the UK has left its impact on its erstwhile colonies, such as some countries in South Asia.

The mismanagement of the economy during the past five years of Conservative rule, with an emphasis on a market-oriented mode of governance, led to the weakening of public services - the National Health Service, schools, social care, sewerage and the public transport system, especially the railways. This mismanagement became most glaring during Truss' brief tenure as the PM. Her drastic policy of reducing

taxes and depending on debt to finance governance rattled the markets and led to a rise in inflation, which then fuelled an increase in interest and mortgage rates. The rise in mortgage rates, coupled with a surge in food prices because of the Russian-Ukraine conflict, led to a drastic increase in the cost of living for a wide section of the population.Rishi Sunak and his Chancellor (Finance Minister) Jeremy Hunt had little time to undo the damage inflicted on the economy by her mismanagement. Both did demonstrate some

> economic competence, which is partly the reason that they have won from their respective constituencies, while many of their colleagues have been badly defeated. However, their social base - richer sections of the population - led them to pursue economic policies like reducing welfare expenditure, which damaged their political support.

The UK is composed of four regions (called nations) - England, Scotland, Wales and Northern Ireland - and each of them has its own specific political culture and complexities. England is the biggest of the four nations.


In Scotland, the Scottish National Party (SNP), whose programme centres on seeking independence from the UK, faced a huge defeat despite no decline in the demand for independence.

Scottish voters rejected SNP candidates because of the financial mismanagement of the party and voted Labour after a long time to both punish the SNP and defeat the Conservatives.In Wales, the Conservative Party did not win a single seat. Plaid Cymru, a votary of Welsh independence from the UK, increased its seat count and vote share, though Labour won a majority.

In Northern Ireland, Sinn Féin, which advocates for a united Ireland, emerged as the single largest party for the first time; none o the England-based parties has any presence there. The incoming Labour government led by Starmer faces myriad challenges. It has to steer the economy to improve public services, manage immigration to minimise the dangers of the rise of the anti-immigrant Reform UK, devolve power to meet aspirations for independence of non-English regions, contribute to reducing tensions in Ukraine and Gaza and tackle the problems emerging from climate change.

It will be good for the country's politics if, at a time when India faces grave security challenges, all political leaders eschew the temptation of making personal remarks.

THE hope that the acrimony of the recent elections and political divisions would be put behind as the 18th Lok Sabha convened has been belied. Both the ruling BJP and the Congress-led Opposition have become more combative, and no accommodation is being shown by either side. In the process, established norms are being abandoned, with both sides blaming each other for doing so. Prime Minister Narendra Modi is attempting to impress upon the nation that the loss of the BJP's majority in the Lok Sabha will not lead to a material change in either his priorities or the manner in which he has led the government over the past decade. The steps he has taken in government formation and his addresses to both Houses of Parliament make that abundantly clear.On the other hand, the Congress and its allies are pushing the idea that the BJP's loss of 63 seats (from 303 in 2019 to 240 this time) has materially altered the political situation and that Modi cannot run the government as he did in his first two terms.

The lack of adherence to parliamentary norms and rules as well as decency by both sides during the debate on the President's address is a precursor to their approach towards each other in the coming months and years. In this context, three points can be made straightaway.

First, Rahul Gandhi, who is the first Leader of the Opposition (LoP) in the Lok Sabha in a decade, made a bitingly critical speech against the ruling dispensation, including its policies and governance style as well as methods. He was within his right to do so. Parts of his speech were expunged, and he protested to the Speaker against the action. It was perhaps the expunging of portions of his speech that led the Opposition to make a ruckus during Modi's speech. This was wrong and disrespectful to the office of the Prime Minister. It was also noteworthy that the treasury benches did not really interrupt Rahul's speech. Hence, it would have been appropriate if the same courtesy was extended to Modi. Second, no real political gains were made by the Congress



in going against convention by having a contest for the Speaker's post. What has been lost, though, is a good convention. Also, the convention that the Deputy Speaker's position goes to the Opposition was followed by previous governments. They did not suffer any political damage by doing so. The Modi government could allow the Deputy Speaker's job to go to an Opposition MP.Third, towards the conclusion of his speech in the Lok Sabha, Modi said (roughly translated from Hindi to English): "They may claim whatever they may about numbers. When we came in 2014, our strength was low in the Rajya Sabha and the chairperson's leaning was somewhat towards the other side. But we remained firm and determined in our commitment to serve." It is sad that the PM cast aspersions on the neutrality of then chairperson of the Rajya Sabha, Hamid Ansari, while speaking in the Lower House. Normally, no remarks are made about the conduct of the chairperson of one House in the other. This principle should extend to former chairpersons too. This is because they belong (or have belonged) to different political formations. Hence, if one party or formation criticises the conduct of a particular exchairperson, others are likely to do the same to others. Hence, till now, ex-chairpersons' conduct or inclinations were not commented upon. Allegations of a chairperson lacking neutrality are serious because the first requirement of the chairperson of either House is to treat all members equally. Naturally, if a chairperson does not do so, he or she violates the basic trust reposed in him or her by the House.here is another aspect: Should a charge of this kind be made when the person who held the chair is not present to mount a defence? This is an additional reason why such charges of partiality or impropriety should not be made. In view of these factors, it was surprising that neither the Speaker nor any member of the Opposition came to Ansari's defence. The Speaker could have gently pointed out to the PM that the comment on Ansari was not in keeping with the high standards of Parliament. The LoP could have done the same. It has been seven years since Ansari demitted vice-presidency. But that should not make a difference to the need to omit the PM's remarks on him from the record. Indeed, it would be gracious of Modi himself to ask that they be removed. This would add to his stature, not diminish it.

During the course of his address in the Lok Sabha, Modi without naming Rahul - made it clear that he thought the Congress leader had exhibited 'balak buddhi' (childish behaviour/intelligence). This is reminiscent of Rahul being referred to as 'Pappu'. That word is no longer used for him. The attention he gained from his Bharat Jodo Yatra and Bharat Jodo Nyay Yatra led to him being taken seriously by a large section of the people. The additional seats won by the Congress though Modi is right when he says that the NDA won the election - and Rahul becoming the LoP have also meant that he is a pushover no more. The BJP will, therefore, have to do a lot of work to make the term balak buddhi' stick in the public imagination for Rahul. It will be facilitated if he makes inaccurate or unsubstantiated comments on matters that are vital to the national interest. Hence, it will be good for the country's politics if, at a time when India faces grave security challenges, all political leaders eschew the temptation of making personal remarks. First-gen Foodpreneurs pack old vada in new pav

Several entrepreneurs are trying to change that by using global practices to sell Indian street food Green mangoes are hard. And no one knows this better than Neeraj Kakkar, co-founder of Paperboat. Hector Beverages, the makers of Paperboat, has been selling its aam panna drink (green mango juice flavoured with roasted masalas) for a while. Green mangoes are notoriously hard to process because they are tough, and Kakkar says his team had to innovate extensively to make Paperboat's aam panna flavour taste like its fresh, home-made version.

"So our biggest challenge is today our biggest advantage. Nobody has done this kind of thing before and it is difficult to replicate," says Kakkar. Paperboat now boasts an array of 10 distinct beverages including jaljeera, golgappe, kokum and chilled rasam. Many more innovative

products are under development including coconut water and the juice of purple carrots. The company, which opened its biggest factory in Mysuru a few months ago, works with agricultural universities and farmers across the country to figure out best practices, as they break new ground on products.

Across the country, entrepreneurs are picking up traditional Indian food and beverage products to challenge Western imports like colas and burgers. In some cases they are reimagining the products and offering innovative variants. Mr & Mrs Idli and Idli Factory offer exotic stuff like Idli Manchurian, Kanchivaram Idli and Punjabi Idli. Faaso's, with funding from Sequoia and Lightbox, and Kaati Zone do a variety of Indian rolls, including Cheesy Corn Salsa and Chicken Mushroom.

In other cases, they are using technology to

make the products at scale and sell them around the country, the way McDon ald's and KFC do. Ammi's Biryani, with funding from Saif Partners, is doing that with biryani, as is the Hyderabad-based chain Paradise which is opening outlets in cities like Bengaluru at a fast clip. At Paradise, the self-service counter is clearly modelled after the McDonald's and Burger Kings of the world, with combos and packages and easy-to-select options. Similarly, Jumboking pioneered the organized vada pav business, and was quickly followed by Goli Vada Pav, which has received funds from Ventureast.

Dheeraj Gupta of Mumbai initially dabbled in the Indian mithai (sweet) market. But the technology needed to keep sweets fresh was expensive and since the venture wasn't very profitable, Gupta was finding the going difficult. He looked at India's streets and realized how disorganized the vada pav business was. "Vada

pav was the largest selling snack in Mumbai but no one had thought of organizing that segment," he says. He borrowed Rs 2 lakh from his father and founded Jumboking. The venture is about to open its 100th store and is present across the top eight cities in the country. The company charges a 30% premium on vada pavs compared to the street pays. It also focussed on the bread size, weight and size of the patty and eliminated wastage. The patties needed instant quick freezing at minus 18 degrees centigrade, and with hygiene a priority for Gupta, he invested in the required technology.

Hygiene is a big focus for most, because for many middle class Indians today, that's the concern they have about food offerings from the unorganized segment. "Tea is available in all corners of this country but our focus is the white collar corporate employee in the top seven cities who are conscious about cleanliness and consistency," says Amuleek Singh Bijral, founder of Chai Point.

Most tea joints in India end up being smoking joints, which discourages nonsmoking customers. Chai Point does not allow smoking and so enjoys a broader clientele. The average price of a glass of tea at Chai Point is less than Rs 20, less than a fourth of the price at leading cafe chains, and is designed to drive volumes. The company's 50 outlets sells more than three million glasses a month.

Hygiene, comfort and innovation is also the focus of Chennai's Idli Factory. "My biggest driver is to create food for travelling, which means comfort food that is well-packaged and easy to carry," says R U Srinivas. The company's flagship product is its 'Madras bars' which are idlis shaped like bars coated with powders such as milagai podi, garlic podi and curry leaf podi. Srinivas researched and tested 300 different batters before arriving at the best combination of rices and dal to create idlis that would remain soft and fresh even after they are cold.

Arvind Singhal, chairman and MD of retail consultancy Technopak, says native food offers great opportunity in terms of revenue. "Indian food has long been neglected," he says, and appreciates startups like Chaayos and Chai Point that have leveraged Indian tea rather than going after coffee, like many

Singhal also notes that many Indian startups in this space fail because they complicate their menus by adding too many different items. Keeping it simple helps with handling the supply chain, quality assurance and faster service across all outlets, and in keeping


Bijral of Chai Point agrees. While expanding his food variety option looks enticing currently it contributes 25% of topline -Bijral wants to reduce it to 20% and focus even more on tea. "Let others sell food," he says. Idli Factory also has a skeletal menu, and Srinivas intends to keep it that way. So does Jumboking's Gupta, who notes that multinational food chains too stick to a narrow menu but offer different versions of that menu. "Once this mindset (to complicate menus) changes, it will benefit a lot of entrepreneurs," he says.

But that strategy could have its limitations too. When Mohan Kumar, partner with Norwest Venture Partners, received a request from a food startup for investment, he analysed a number of companies in the space. He found that some 25 companies in the space had touched revenues of Rs 200-300 crore, but then stopped growing. "Probably there aren't enough categories to scale up and these companies tend to get acquired by bigger ones. Big Indian players like ITC and Marico understand the market well. Some of the MNC competition too could catch up," he

Jacob Kurian, partner at private equity fund New Silk Route, which has invested in Bengaluru-based Vasudev Adigas, a south Indian food retail chain, feels that Indian food businesses tend not to grow beyond the local area as the promoters tend to be contented at a certain size. One exception, he notes, is Haldiram. "The skill set needed to grow till Rs 200 crore and to grow beyond that are different," he says.

Kurian also notes that unlike the earlier family-owned Indian businesses, those like Paperboat and Chai Point are not family businesses and don't have legacy issues. "Let these guys reach around Rs 200 crore and then we will see," he says. That could happen if the brands can go into smaller towns or even global. Paperboat's Kakkar is not sure if his drinks can be as popular as Coke in small towns. But he notes with some satisfaction: "Cola sales are declining globally."

He quit the police in 2000 to join a series of Hindu preachers and gurus who are sought by millions for miracle cures and spiritual advice. They are often called godmen, and many have been wooed by politicians for the influence they wield.

Their patrons have included international celebrities like the Beatles, who spent days in the ashram of Maharishi Mahesh Yogi in the late 1960s. Some of these gurus expanded beyond India, most famously Osho, who lived and preached in the United



States in the early 1980s.

Almost all of them are credited by their followers with miraculous powers."I had gone to one of his early gatherings and told him I had chronic pain from a kidney stone for many months," said Ramkumari, Baba's former neighbour in Bahadurnagar village in India's Uttar Pradesh state, where he was born and still has a home. The village has only about 50 homes in all and is set amid fields which grow corn, wheat and rice. On the periphery is a sprawling, pearly-white ashram run by devotees of Baba."He smiled

and blessed me with a pat on the back. The stone vanished soon after," said Ramkumari, who gave just one name. Another resident in the village, 55-year-old Surajmukhi, said Baba's blessing helped her give birth to a son after seven daughters. Heavy Rain In Early July Bridges India's **Monsoon Deficit But Causes Flooding**

India logged a rainfall deficit of 11 percent in June, with northwest India recording a shortfall of 33 per cent.

New Delhi: Heavy rainfall across large parts of India has compensated for the June deficit, bringing the overall monsoon precipitation into the surplus category. According to the India Meteorological Department (IMD), more spells of heavy to very heavy rain are likely over northwest India and the western parts of the peninsular India during the next two-three days and over the northeast during the next five days. ndia, the world's top producer of critical

crops such as rice, wheat and sugarcane, logged a rainfall deficit of 11 percent in June, with northwest India recording a shortfall of 33 per cent. Heavy rain in the first week of July compensated for the shortfall but caused flooding in many northeastern

Since the four-month monsoon season began on June 1, the country has received 214.9 mm of rainfall against a normal of 213.3 mm, according to IMD data.Northwest India and the southern peninsula have recorded 3 per cent and 13 per cent above-normal rainfall, respectively. The heavy rain in the east and northeast region has reduced the deficit from 13 per cent on June 30 to zero on July 6.The rainfall deficit in central India has decreased from 14 per cent to 6 per cent during this period. The IMD data showed that 23 per cent of the sub-divisional area of the country experienced excess to large excess rainfall, 67 percent received normal rainfall, and only 10 per cent experienced



deficient rainfall.

After making an early onset over Kerala and the northeastern region on May 30, and progressing normally up to Maharashtra, themonsoon lost momentum. This delayed the rains in West Bengal, Jharkhand, Bihar, Uttar Pradesh, Chhattisgarh, and Madhya Pradesh and exacerbated the impact of a scorching heatwave in northwest India.

Monsoonal winds stalled from June 10 to June 18 and made slow progress until June 26-27. The annual rain-bearing system covered a major part of northwest India after June 25, according to IMD data. The weather department on Saturday said heavy rainfall will continue in northeast India over the next five days.

The northeastern states are already grappling with severe floods. Assam's flood situation remains critical, with over 2.45 million people affected and 52 lives lost in the second wave of flooding this year. Heavy rainfall in Manipur, Mizoram, and Arunachal Pradesh has caused rivers to reach warning levels and triggered landslides. The IMD earlier this week said India could experience abovenormal rainfall in July, and heavy rain may lead to floods in the hilly states and river basins in the central parts of the country.Experts from the International Centre for Integrated Mountain Development (ICIMOD), a Nepal-based intergovernmental organisation, have also warned about a difficult monsoon season for the countries in the Hindukush Himalayan region, including Bangladesh, Bhutan, India, Nepal, and

The Glass House is a spacious restaurant on the first floor of Eastin Hotel, with an alfresco corridor around it which offers snack with a view of the lawns. The restaurant has a glassed-in kitchen alongside so guests can watch some of the cooking live while they eat. They also have a good-sized screen for those who want to watch some TV while they dine - it can be a good venue to watch late night football matches as the coffee shop is open 24 hours.

The Glass House does not have a large menu but offers a good selection of Indian, Italian, East Asian and other cuisine. Start with the Thai corn and coriander soup (with or without chicken), which is full of herbs and spices, and signature starters

(the classic chicken tikka but with a crunchy exterior) and conjee baby corn and vegetables. They do an excellent paneer malai tiranga and also a good gilafi subz seekh. If you like basa fish, try the machli kali pleasant seating for a meal or mirch or the South-East Asian style five spice chilli fish. They also offer assorted starter platter.

For the main course, the rarha gosht is excellent with tender mutton in mince meat (keema). The Lahori murgh korma is also pretty good. Among the vegetarian dishes, the paneer shimla mirch and subz Jodhpuri are recommended. These go well with their breads like chilli milli paratha, til aur kalonji ki naan and masala missi. They have in-house specials from time to time, specially takes on Italian cuisine like the vegetable Siciliana which is a baked vegetarian dish using peppers in the sauce, and served with crispy garlic bread, and the chicken Milano which has the

taste of fresh tomatoes, garlic and olives that are so much part of Milanese Don't miss their delicious dal maska malai, which is an interesting take on the dal makhani, which can be enjoyed with Indian breads like naan, paratha or roti, as well as with rice dishes like shahi barista jeera pulav.

End with their hot badami gulab jamun, which has a really nice soft texture. They often have a superb baked yogurt (the seasonal special is mango yogurt) and you could even ask for a dessert platter which has an Indian sweet, a western dessert and fresh fruit wedges.

Union Budget: Infra Push, Structural Reforms For Sustainable Growth Key **Industry Wish-List**

New Delhi. With the government set to present the Union Budget 2024-25 on July 23, industry leaders and experts have reiterated the importance of structural reforms to drive sustainable and inclusive economic growth, especially the critical role of infrastructure development towards India becoming the third largest economy.

According to industry chambers, by prioritising structural reforms, strategic infrastructure development, targeted sectoral initiatives and a rationalised tax system, India can navigate current challenges and emerge as a stronger, more competitive economy in the long run. Assocham has recommended accelerating investments through public-private partnerships (PPPs) with a focus on key sectors like transportation, energy, water supply, and digital infrastructure. This will enhance connectivity, improve productivity, and bolster India's overall competitiveness. In order to address the growing concern for environmental sustainability, the leading chamber of commerce urged the government to introduce policies and incentives that promote clean technologies, renewable energy sources, and sustainable practices across industries like agriculture, manufacturing, and transportation. The government can further streamline regulations, expedite approvals and permits, and leverage digitalisation to attract investments and enhance operational efficiency, according to industry watchers. According to ICRA, the government's revenue receipts are likely to witness an upward revision of Rs 1.2 trillion in the 'FY2025 Revised Budget' over the 'Interim Budget Estimate' (IBE), while pegging a relatively shallower increase in the revenue expenditure (revex) target, largely focused on the rural economy. The rating agency expects the revenue receipts of the government to increase on the back of a higher RBI dividend and a rise in tax collections."The government is likely to set a fiscal deficit target at 4.9-5.0 per cent for FY2025, vis-a-vis the IBE of 5.1 per cent of GDP, without compromising the capital expenditure target of Rs. 11.1 trillion, according to ICRA. The Budget Session of Parliament will start on July 22 and extend till August 12.
Finance Minister Nirmala Sitharaman will present the

budget at a time when the Indian economy has clocked a robust 8.2 per cent growth in 2023-24, which is the fastest among the world's major economies, and inflation coming down to below 5 per cent.

The RBI has stated that the economy is headed to an over 8 per cent growth trajectory. Prime Minister Narendra Modi has already declared that "the next five years will be a decisive fight against poverty".

Ola exits Google Maps, to save Rs 100 cr per year with in-house maps

NEW DELHI. After exiting Microsoft's Azure last month, Ola Cabs has now fully exited Google Maps, moving to its in-house Ola Maps, founder-CEO, Bhavish Aggarwal has said in a post on X. He said that the company used to spend Rs 100 crore a year on Google maps, which they have made zero by this move to in-house Ola maps. Aggarwal said that Ola Cabs will see a number of features in the coming months, which include street view, neural radiance fields (NERFs), indoor images, 3D maps and drone maps, among others.

In October 2021, Ola had acquired GeoSpoc, a Punebased company specialising in geospatial services. Ola Maps now supports the mapping requirements of its primary ride-hailing application. Additionally, the company said that it will integrate Ola Maps into its electric two-wheelers through a software update in January.In May, Aggarwal had said that his company has decided to move its entire workload out of Microsoft Azure to its own cloud platform Krutrim.

The move was a reaction to Microsoft-owned LinkedIn removing Aggarwal's post on 'pronoun illness', in which he called out the platform for imposing a 'forced ideology' over gender pronouns. Festive offer

This led to a loss of over Rs 100 crore for Microsoft in India, as Ola was its big customer. He also threw an invitation to other developers, saying if they wanted to move out of Azure, he will offer a full year of free cloud usage to them. The only condition being that they should not go back to Azure after that.

Hindenburg shared Adani report with client two months before publishing it: SEBI

NEW DELHI. US short-seller Hindenburg Research had shared an advance copy of its damning report against Adani group with New York-based hedge fund manager Mark Kingdon about two months before publishing it and profited from a deal to share spoils from share price movement, according to market regulator Sebi. The Securities and Exchange Board of India (Sebi), in its 46-page show cause notice to Hindenburg, detailed how the US short seller, the New York hedge fund and a broker tied to Kotak Mahindra Bank benefited from the over USD 150 billion routs in the market value of Adani group's 10 listed firms post-publication of the report.

ebi charged Hindenburg of making unfair profits from collusion to use non-public and misleading information and induce panic selling in Adani Group stocks. Hindenburg, which made public the Sebi notice, in its response, has described the show cause as an attempt to "silence and intimidate those who expose corruption and fraud perpetrated by the most powerful individuals in India" and revealed that the vehicle used to bet against Adani's flagship firm Adani Enterprises Ltd belonged to Kotak Mahindra (International) Ltd, a Mauritius-based subsidiary of Kotak Mahindra Bank Ltd.KMIL's fund placed bets on Adani Enterprises Ltd for its client Kingdon's Kingdon Capital Management. Sebi notice includes extracts of time-stamped chats between an employee of the hedge fund and KMIL traders for selling future contracts in AEL.

FSSAI Cracks Down on Misleading Claims on Packaged Food: Salt, Sugar, Fat Label In Bigger Font Soon

FSSAI proposes mandatory bold labeling of salt, sugar, and fat content on packaged foods

NEW DELHI. Food regulator Food Safety and Standards Authority of India (FSSAI) on Saturday approved changes in nutritional information labelling on packaged food items, proposing that total salt, sugar and saturated fat should be displayed in bold letters and in bigger font size.he FSSAI will issue a draft notification on this and seek stakeholder comments.FSSAI is the national regulatory body for food in India. It is responsible for ensuring the safety and quality of food items manufactured, stored, distributed, sold and imported in India.n an official statement, Food Safety and Standards Authority of India (FSSAI) said it has approved "a proposal to display nutritional information regarding total sugar, salt and saturated fat in bold letters and relatively increased font size on labels of packaged food items". The decision to approve the amendment in the Food Safety and Standards (Labelling and Display) Regulations, 2020 regarding nutritional information labelling was taken in the 44th meeting of the Food Authority held under the the Food Authority, held under the chairmanship of Apurva Chandra, Chairperson, FSSAI.The amendment aims to empower consumers to understand better the nutritional value of the product they are consuming and make healthier decisions," the regulator said. The draft notification for the said amendment would now be put in the public domain for inviting suggestions and objections. The information regarding per-serve percentage (%) contribution to Recommended Dietary Allowances (RDAs) would be given in bold letters for total sugar, total saturated fat and sodium content, the FSSAI said.

The regulator said that regulations 2 (v) and 5(3) of FSS (Labelling and Display) Regulation, 2020 specify requirements to mention serving size and nutritional information on the food product label,

respectively. Along with empowering consumers to make healthier choices, the amendment would also contribute towards efforts to combat the rise of Non-Communicable Diseases (NCDs) and promote public health and well-being, the statement said. The prioritisation of the development of clear and distinguished labelling requirements would help in the global effort to combat NCDs.FSSAI said it has been issuing

FPIs inject Rs 7,900cr in equities in the first week of July; investment surpasses Rs 1 lakh cr in 2024

NEW DELHI. Foreign investors infused over Rs 7,900 crore in Indian equities in the first week of the month amid a healthy economic and earnings growth momentum. With this, total FPI investment in equities reached Rs 1.16 lakh crore this year, data with the depositories showed. Going forward, the Union Budget and Q1 FY25 earnings could determine the sustainability of FPI flows, experts said.According to the data, foreign portfolio investors (FPIs) have made a net inflow of Rs 7,962 crore in equities so far this month (till July 5). This came following an inflow of Rs 26,565 crore in equities in June, driven by political stability and a sharp rebound in

markets.Before that, FPIs withdrew Rs 25,586 crore in May on poll jitters and over Rs 8.700 crore in April on concerns over a tweak in India's tax treaty with Mauritius and a sustained rise in US bond yields. Some funds were probably waiting on the sidelines for the election event to be over, Milind Muchhala, Executive Director, Julius Baer India, said."We believe that India remains an attractive investment destination amid a healthy economic and earnings growth momentum, and the FPIs cannot afford to ignore the markets for too long," he added.eojit Financial Services Chief Investment Strategist VK Vijayakumar said a significant feature of FPI flows is that

their selling in India has been triggered by external factors like rising bond yields in the US and low valuations in other emerging markets. When that situation changes, they again become buyers in India.In the fortnight that ended June 30, FPIs bought heavily in telecom and financial services. Additionally, they were buyers in autos, capital goods, healthcare and IT. On the other hand, selling was seen in metals, mining and power, which had run up too fast in recent months. Apart from equities, FPIs invested Rs 6,304 crore in the debt market during the period under review. This has pushed the debt tally to Rs 74,928 crore this

BENGALURU. The healthcare sector is on the verge of rapid consolidation as collaborations, mergers and acquisitions market dynamics in the space. Also, this is driven by cost factors and the need to make use of advanced technologies to serve patients better and faster.

The sector has been witnessing many major deals as this year alone it saw over 8 deals amounting to more than \$1,068 million. In 2023, PE-VC investments in India stood at \$4,506 million across 19 deals.

World Number one Janik Sinner will be up against 4th-seeded American Ben Shelton in his fourth-round fixture while Fifth seeded Daniil Medvedev will take on tenth-seeded Grigor Dimitrov.Sinner faced some difficulty in the first two rounds where he dropped a set each but later sailed through third round with a straight-sets win over Miomir Kecmanovic. On the other hand, Shelton has been pushed into a fifth set in each round will look to gain confidence from his ability to perform under pressure. In women's singles, second seed Coco Gauff will face-off with the 19th seeded Emma Navarro. Gauff has reached the Wimbledon fourth round twice, but has never been able to progress further ahead. However, the 20-year-old looks in good form this year coming in from three straight-set wins.

The entire Indian batting unit, which included the likes of Shubman Gill, Abhishek Sharma, Riyan Parag and Ruturaj Gaikwad failed, as Zimbabwe scripted a memorable victory.Indian Premier League stars Riyan Parag and Rinku Singh were heavily trolled by fans on social media after their loss. Both Riyan and Rinku got out to fast bowler Tendai Chatara. While Riyan scored 2 off 3 balls, Rinku got out trying to pull the fast bowler in the second ball of his innings, when he had not scored a single run. Speaking to the media after the game Bishnoi blamed the loss on the batting order collapse. At one point in time, India had lost 6 wickets inside the first 50 runs, while chasing only 116. Bishnoi felt that if India could have gotten a 20-30-run partnership in the middle overs, things might have looked different."We collapsed. The lack of partnerships, that made a difference. If we could have had 20-30 runs partnerships, the story could be different," Bishnoi said in Saturday after the match.

Euro 2024: Netherlands storm into semi-finals with comeback win over Turkiye

New Delhi, A spirited Turkiye were knocked out by Netherlands in the quarter-final of Euro 2024 on Saturday, 6 July. Hakan Calhanoglu, Arda Guler ran the show in the attacking mid-field, while Baris Alper Yilmaz ran himself to the ground, driving the ball in the final third. Arda and Calhanoglu's street smarts, mixed with Yilmaz's character and ability to give hundred per cent in every single challenge he made helped Turkiye take the lead in the first half of the match.



Fearing for her career, Juhi opted for a covert marriage with Jay in 1995, and the couple now shares two children, Jhanvi and Arjun In a conversation with former journalist Rajeev Masand on his YouTube channel a few years back, Juhi revealed, "I was just about established and just starting to do well. That's the time Jay was serenading me, and I was afraid of losing my career just when I kind of got there. So, I wanted carry on and this seemed the midway, that let's keep it quiet and it's okay, you carry on working."Reflecting on that period, Juhi shared the challenging circumstances she faced with the loss

of her mother, expressing, "That year my mother passed away as well so I had another tragedy and that was a very difficult time for me as well because I felt I was going to lose everything I had, everything I loved, my work an my mum."During a recent discussion at an event organized by the Gujarat Chamber of Commerce & Industry, Juhi shared a heartwarming anecdote about her wedding.
