Supreme Court closes contempt case against Patanjali Ayurved, Baba Ramdev and Acharya Balkrishna

New Delhi, August 13: The Supreme Court on Tuesday closed contempt proceedings against Patanjali Ayurved and its co-founders Baba Ramdev and his close aide Acharya Balkrishna in the misleading advertisements case after they undertook to cease issuing misleading advertisements and claims regarding the company's products. A Bench led by Justice Hima Kohli said the contempt proceedings were being closed accepting the apology tendered by the parties after they took steps to rectify their mistake. The Bench – which also included Ahsanuddin Amanullah



— however, warned them against repeating their past conduct, saying it would reopen the proceedings if they did anything in future in violation of its orders. The top court had initiated contempt proceedings against Patanjali Ayurved, Baba Ramdev and Acharya Balkrishna on a petition filed by Indian Medical Association (IMA) against Patanjali's advertisements attacking allopathy and making claims about curing certain diseases. On March 19, it had ordered the personal appearance of Ramdev and Balkrishna after being told that the replies to the contempt notice were not filed. Ramdev and Balkrishna had assured the court on November 21, 2023, that they would not make any "casual statements claiming medicinal efficacy, or against any system of medicine". But the very next day Ramdev held a press conference and said remedies for blood pressure were "lies spread by allopathy". On December 4, the company had issued a similar advertisement, inviting the wrath of the top court. The court had on February 27 this year issued a contempt notice to Patanjali Ayurved, its managing director Balkrishna and Ramdev for flouting earlier orders and taking the entire country for a ride. The top court had temporarily restrained Patanjali Ayurved from advertising or branding its products meant to address diseases/disorders specified in the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954.

Bangladesh interim government sets up hotline, urges people to provide info about attacks on temples

Dhaka, August 13: Bangladesh's interim government has set up a hotline asking people to provide information about attacks on Hindu temples, churches or any other religious institutions, amid reports of vandalism of religious places, businesses and properties of minorities following the ouster of prime minister Sheikh Hasina. The Ministry of Religious Affairs has requested to provide information about attacks on religious institutions, Bengali language daily Prothom Alo reported on Tuesday. "If a temple, church, pagoda or any other religious institution is attacked by miscreants, it is requested to report its information by calling this mobile number 01766843809 or by sending a small message," the paper reported, citing a notification issued by the ministry on Monday. Religious Affairs Adviser to the interim

government AFM Khalid Hossain has condemned recent attacks on religious institutions belonging to minorities. During a press briefing at the secretariat on Monday, Khalid confirmed that complaints had been received about attacks on minority homes and religious sites. He assured ongoing support for these communities. Hossain announced that deputy commissioners are compiling a list of damages. On Tuesday, interim government's Chief Adviser Muhammad Yunus reached out to the distressed Hindu community members and assured them that his government would punish those responsible for attacks on the minorities. Yunus, 84, who took charge as the Chief Advisor on Thursday, visited the Dhakeshwari National Temple where he urged the people to "exercise patience" before judging his government. "Rights are equal for everyone.

Sirsa Dera chief Gurmeet Ram Rahim walks out of jail on 21-day furlough

Chandigarh, August 13: Dera Sacha Sauda chief Gurmeet Ram Rahim on Tuesday walked out of Rohtak's Sunaria jail on a 21-day furlough. He was released after Rohtak Divisional Commissioner passed an order in his favour. During his temporary release period, the Dera chief will go to Baghpat ashram in Uttar Pradesh. On August 9, the Punjab and Haryana High Court disposed of the SGPC's petition which challenged the grant of temporary release to Ram Rahim, observing that a plea for temporary release be considered by the competent authority without any "arbitrariness or favouritism". Ram Rahim in June this year had moved the high court, seeking directions to grant him a 21-day furlough. On February 29, the high court had asked the Haryana Government not to grant further parole to the Dera Sacha Sauda chief without its permission. Ram Rahim is serving a 20-year jail term for raping two of his disciples. He was granted a 50-day parole on January 19. The Dera chief and three oth-

ers were also convicted in 2019 for the murder of a journalist more than 16 years



ago. In May this year, the high court had acquitted Ram Rahim and four others in the 2002 murder of sect's former manager Ranjit Singh, citing "tainted and sketchy"

investigations in the matter. A special CBI court had sentenced them to life imprison-

ment in the nearly 20-year-old murder case. Ram Rahim had been held guilty of hatching a criminal conspiracy with his co-accused.

BJP MP Jagdambika Pal to head joint panel on Waqf bill

New Delhi, August 13: Senior BJP Lok Sabha member Jagdambika Pal will head the joint committee of Parliament set up to examine the contentious Waqf (Amendment) Bill, officials said on Tuesday. Amid protests by the opposition in the Lok Sabha on its provisions, the government had decided to refer the bill to a joint committee of the two Houses. The joint panel has 31 members – 21 from the Lok Sabha and 10 from the Rajya Sabha – and will submit its report by the next session. The Lok Sabha and the Rajya Sabha on Friday last adopted a motion moved by Union Minority Affairs Minister Kiren Rijiju, who also holds the parliamentary affairs portfolio, naming the members to be part of the committee. A formal notification naming Pal as the chairperson of the joint committee is set to be issued shortly, the officials said. In the Lower House, 12 members of the panel are from the ruling National Democratic Alliance (NDA), including eight from the BJP, and nine from the opposition. In the Upper House, four are from the BJP, four from the opposition, one from the YSRC, which has opposed the Bill, and one is a nominated member. The Bill was introduced in the Lok Sabha on Thursday and referred to a joint committee of Parliament after a heated debate, with the government asserting the proposed law did not intend to interfere with the functioning of mosques and the opposition calling it targeting of Muslims and an attack on the Constitution.

Congress to launch national campaign demanding SEBI chief's resignation, constitution of JPC

New Delhi, August 13: The Congress would launch a national campaign around various issues including the demand for resignation of the SEBI chief and constituting a joint parliamentary committee (JPC) to probe the link between the market regulator SEBI and the Adani Group. This was decided in a meeting of AICC general secretaries, in-charges and Pradesh Congress Committee presidents, held here on Tuesday, under the chairmanship of party chief Mallikarjun Kharge. "The shocking revelations of nexus between SEBI and Adani needs to a thorough investigation. The money of small investors in the stock market can't be jeopardised. Modi Govt must immediately seek the resignation of

SEBI chairperson and constitute a JPC in this regard", Kharge said in a message posted by him on the X



after the meeting. "The pressing issues of unemployment and uncontrolled inflation and depletion of household savings are our focus. The poor and middle class have been betrayed", Kharge further

wrote. Kharge wrote that continued attack on the Constitution by the BJP and the demand for a caste census would also prominently feature in the campaign.

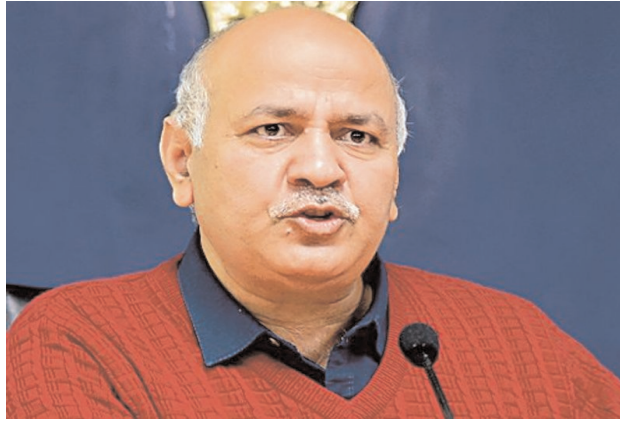
The Congress would continue its fight in demanding legal guarantee of MSP for farmers. The Agnipath Scheme imposed on our patriotic youth must be scrapped, Kharge wrote underscoring two more important demands raised by the party. "Train derailments have become a norm, as crores of passengers suffer. Climate related disasters and collapsing infrastructure is also a cause of concern", the Congress chief said, adding that a nationwide protest is being planned by the party around these demands.

Elected minister should hoist tricolour on Independence Day, politics over it unfortunate: Manish Sisodia

New Delhi, August 13: Amid a controversy over who hoists the flag at the Delhi government's Independence Day ceremony here, senior AAP leader Manish Sisodia Tuesday assailed Lt Governor V K Saxena, saying there should be no problem with an elected minister doing it. The Delhi government's General Administration Department has refused to comply with its minister Gopal Rai's direction to make arrangements for Education Minister Atishi to hoist the national flag as per a letter by Chief Minister Arvind Kejriwal to the LG. However, the LG office has maintained that no letter from Kejriwal, who is in judicial custody, has been received. Tihar jail authorities have said the CM's letter was not sent to the

LG because it was not permitted according to prison rules. Sisodia said it is "very unfortunate" that "such petty politics" is being done on the auspicious occasion of



Independence Day. "I read in the papers that when a conman Suresh writes letter, the Tihar administration duly submits it to the LG office. The LG too promptly

takes action on it. But, when the Delhi chief minister writes a letter, the LG asks Tihar officials not to send it to him," said Kejriwal's former deputy. The LG office should ideally have asked the Tihar Jail director general's office to send Chief Minister Kejriwal's letter, he said. "But, they have nothing to do with independence or the country. People like Suresh are beloved to them." The elected government or any minister should hoist the flag, he asserted. "I do not see any difficulty in it." "But, expecting democratic, constitutional (norms) from the LG and his boss is meaningless. Only dictatorship is expected from them and that is what we do," Sisodia charged. Chief Minister Kejriwal, who would have hoisted the flag at the Delhi government's Independence Day function, is currently lodged in the Tihar jail in an excise policy-related case.

Money-laundering charges framed against TMC MP Saket Gokhale

New Delhi, August 13: A special PMLA court in Ahmedabad has framed criminal charges, under the anti-money laundering law, against TMC's Rajya Sabha MP Saket Gokhale on Tuesday, the Enforcement Directorate said. The money laundering case against Gokhale stems from a Gujarat Police FIR in connection



with alleged misuse of money he had collected through crowd-funding. "The Id Principal District and Sessions Judge, Ahmedabad (Rural) and designated Special Court PMLA, Ahmedabad today framed criminal charges against Saket Gokhale, MP Rajya Sabha and national spokesperson of All India Trinamool Congress under the provisions of Prevention of Money Laundering Act, 2002..." the ED said in a statement. It said a charge sheet was filed against the 31-year-old MP under the anti-money laundering law last year. "Charges against him for the scheduled offence in the police case (Gujarat Police) had also been framed," it said. The special court had also rejected the application filed by Gokhale under Section 309 of the CrPC for keeping the proceedings under PMLA, 2002 in abeyance till the case of scheduled offence registered against him is decided by the court, the ED said. The state police had arrested Gokhale from Delhi in December 2022 in a case of alleged misuse of money he had collected through crowd-funding. The ED had informed the court that "huge amounts of money collected through crowd funding (by Gokhale) have been splurged on speculative share trading, wining and dining and other personal expenses which appear to be extravagant in nature". Gokhale, however, had denied that he misused these funds.

CBI takes over Kolkata doctor rape-murder case

Kolkata, August 13: The CBI on Tuesday took over investigation in the alleged rape and murder of a woman doctor in a medical college in Kolkata, officials said. The agency swiftly completed all the formalities within hours of the Calcutta High Court order directing the state police to hand over the case documents to the central probe agency. A team of CBI officials from Delhi along with forensic scientists and medical experts will visit Kolkata on Wednesday, they said. Earlier, the Calcutta High Court ordered the transfer of probe into the alleged rape and murder of the trainee doctor at RG Kar Medical College and Hospital from the Kolkata Police to the CBI. A widespread agitation by junior doctors has crippled state health care services for the fifth day, with the functioning of even emergency and outdoor departments coming to a halt in most state-run hospitals. The high court directed the city police to hand over the case diary to the central probe agency by this evening, and all other documents by 10 am on Wednesday. The direction was passed in the wake of a petition moved by the victim's parents praying for a court-monitored probe and multiple other PILs seeking probe transfer to the CBI. The

interim order came five days after the gruesome incident had come ahead of the probe deadline of Sunday issued to the police by Chief Minister Mamata Banerjee, beyond which she had vowed to hand over investigations to the central agency. The body of the postgraduate trainee with severe injury marks all over was found inside the seminar hall of the state-run hospital's chest department on Friday morning. The preliminary autopsy report suggested she was subjected to violent sexual assault. Despite the Kolkata Police arresting a civic volunteer named Sanjay Roy, in this connection on Saturday, the move failed to silence the clamour of allegations of a botched up investigation and evidence tampering which have now snowballed into an outrage of junior doctors spreading across medical campuses of the state and

beyond. The state's joint platform of doctors has called for strike at Out Patient



Departments in all government and private hospitals of the state on Wednesday to protest the RG Kar Hospital incident. On Tuesday, a Calcutta High Court division bench presided by Chief Justice T S Sivagnanam also urged agitating doctors in the state to call off their cease-work, maintaining that there is a "pious

obligation" on their part to treat patients who come to government hospitals. Junior doctors and interns across West Bengal continued their cease-work on Tuesday, protesting against the incident and demanding adequate security for hospital staff. The probe transfer order was passed following the court's observation that no significant progress in investigations was made by the police in the past five days, a conclusion that the bench reached after going through the case diary it had summoned to court and hearing arguments of all parties involved.

The bench further observed it was disheartening to note that the role of the RG Kar Medical College principal, Sandip Ghosh, was not proactive where he or the hospital superintendent took no initiative to file a murder complaint for the gruesome death which happened inside the campus and not on the streets outside. The state had earlier submitted that the police registered an unnatural death case instead of rape and murder since there were no immediate complaints.

Thiruvananthapuram: Woman helps husband abuse minor; couple held

THIRUVANANTHAPURAM . In a bizarre crime, a woman facilitated her husband's abuse of a minor girl in their neighbourhood to save their marriage. The husband forced the woman to help him after he discovered her extramarital affair. The Attingal police on Monday arrested a young couple for sexually abusing a 15-year-old girl for the past four years, since April 2021.

The couple was booked under relevant sections of the Pocso Act and remanded to judicial custody. The man forced his wife to groom the girl for him to take vengeance, the police said. Goaded by her husband, the woman befriended the girl and brought her in touch with him.

"After discovering that the wife had an extramarital affair, her husband forced her to facilitate the abuse of the girl. He threatened her, saying that was the only way to save their marriage."

After being continually pressed by her husband, the woman agreed to cooperate with his scheme. She developed a deep friendship with the girl and lured her into the trap. She escorted the girl to their house and helped her husband abuse her on multiple occasions," a police officer said.

The harrowing episode had a telling effect on the girl's mental health. She became reticent and gloomy and the teachers of her school noticed the changes in her. It was on the insistence of one of her teachers that a counsellor was brought in to handle the matter. During the counselling session, the girl revealed her ordeal, following which the police was apprised of the happening. The couple confessed to their crime during questioning, police sources said.

Overcrowding: Passengers protest after three women faint on board Palaruvi Express

KOCHI. The issue of overcrowding in the trains operating within the state once again came to light on Monday after three women passengers fainted on board the Tirunelveli-Palakkad Palaruvi Express when the train made a 30-minute stop at Mulanthuruthy station to make way for the Vande Bharat service.

Of the three women who fainted, two were accommodated in the disabled coach while the other was offered a seat in the guard compartment. The disabled coach was later opened up to accommodate more female passengers, owing to overcrowding in the ladies' compartment.

Following the incident, disgruntled passengers staged a protest at Ernakulam Town railway station due to the frequent prolonged halts at Mulanthuruthy. "Out of the 14 coaches in the Palaruvi Express, only 10 are available for regular commuters, as the rest are reserved. This leads to severe overcrowding, especially during rush hours," says Ajas Vadakkedam, executive member of Friends on Rails.

Passengers also pointed out the lack of train services in the time slot between Palaruvi Express and Venad Express, leading to both trains operating beyond their maximum capacity. "Forget seating, it is a miracle if we get room to stand," he says.

According to Ajas, the passengers' main demand is to increase the number of coaches and consider halting the train at Tripunithura instead of Mulanthuruthy. They believe that introducing a MEMU service in the one-and-a-half-hour gap between Palaruvi Express and Venad Express would resolve the issue.

Moolepadam Road to get 'push-through' culverts soon

KOCHI: The National Highways Authority of India (NHAI) is set to commence the construction of a 'Push-Through' culvert on Moolepadam Road in Kalamassery. The initiative is expected to put an end to the long-standing issue of waterlogging that has been plaguing the area for over 30 years.

"The measure is part of efforts to find a scientific solution to the issue. The culvert construction has been taken up after the PWD completed the renovation of the bylane road and a culvert at the Moolepadam Nagar."

This is the first of the three culverts that the NHAI is constructing on the highway stretch," said Industries Minister P. Rajeeve, who visited the area on Monday. The construction of the culvert, being taken up at a cost of '3.5 crore, is expected to be completed in six months.

Minister Rajeeve also highlighted the need for the construction of a railway culvert as the next step in achieving a comprehensive solution. "The water will seep into railway lines once the culvert on the national highway gets completed. We're hoping to get the nod of the railways at the earliest," the minister added.



Greater Cochin Development Authority to undertake urgent repairs worth Rs 13.40L at Mundamveli flats

The repairs aim to address issues such as building leaks and septic tank overflows.

KOCHI. Following numerous complaints about the poor construction quality at the Mundamveli flat complex, where former residents of the P&T Colony have been relocated, the Greater Cochin Development Authority (GCDA), the original contractor, is set to undertake urgent repairs valued at Rs 13.40 lakh.

These repairs aim to address issues such as building leaks and septic tank overflows. "After our engineering team conducted inspections, we've outlined repair works worth Rs 13.40 lakh. The Thrissur District Labour Contract Society (TDLC), the original contractor, will carry out these repairs under the terms of the agreement, within the defect notification period," a senior GCDA official said.



A special GCDA team is scheduled to inspect the Mundamveli flat complex on Tuesday to finalise the repairs. "The work will address

leaks in the flats and toilets, add shades to open areas, and include the installation of a Sewage Treatment Plant (STP), pending final approval from the state government," the official added.

In parallel, GCDA has initiated proceedings to terminate the contract with TDLC due to substandard construction. "We've decided to terminate the contractor this week. However, they will still be required to perform the temporary repairs, while the GCDA will oversee the permanent solutions," the official said.

Additionally, the formation of a sub-committee comprising representatives from multiple agencies, including the GCDA and

Kochi Corporation, to inspect and report on the Mundamveli issues, is still pending. Meanwhile, Kochi Corporation plans to undertake tress work of the entire complex to prevent further leakage. "When we were relocated from the old P&T Colony in Kammattipadam in January, we had high hopes, but the current situation is far worse. Water leaks from upper-floor flats whenever those residents use their bathrooms, making it difficult for some of us to even cook," said Abhilash P Parameshwaran, president of the P&T Apartment Residents Association.

However, the most pressing issue is the overflowing septic tanks. "Currently, the GCDA clears the septic waste every third day, but this is not sustainable. We need a permanent solution," he added. The new flat complex at Mundamveli, constructed under the LIFE Mission project, houses 77 former residents of the P&T Colony in Kammattipadam.

Where Shamsia bats life's curve balls with new determination

A native of Thodupuzha, Shamsia suffers from brittle bone disease and is a wheelchair user but the disease hasn't doused her spirit to fight for her right to live a dignified life.

THIRUVANANTHAPURAM . Kerala and India as a whole is a challenging space for persons with disabilities. However, what happens if the system and the government agencies that should aid persons with disabilities turn villain? Shamsia Fathima Moideen has been facing such a situation over the years.

It is not as if she is ineligible! "I am a post-graduate degree holder in commerce and also have a Diploma in Computerised Professional Accounting Course (C-PAC)," says Shamsia. A native of Thodupuzha, Shamsia suffers from brittle bone disease and is a wheelchair user. But the disease hasn't doused her spirit to fight for her right to live a dignified life. "I have 70 per cent disability. And the government does provide people with disabilities with job reservations. But if you are to take a survey of the government departments in the state, you won't find people like me working in any capacity," says Shamsia.

Shamsia's bad luck began when she applied for jobs advertised by the government departments. "I would clear the tests and then get the interview call letter. However, at the interview, they would tell me that I was not suitable for the job. The reason? I won't be able to go around and pick up files!" Another issue they highlighted was that if they were to appoint her, they would have to create another post — a helper to aid her in daily work. "It would be an additional financial burden on the company or department. Hence, they would reject me," she adds.

This was not a situation that she faced in a single job interview. "It happened many



times and over the years," says the 38-year-old whose never-say-die spirit has made her forge ahead by overcoming all the hurdles that life threw her way.

She says, "All of my acquaintances knew about my bitter experiences. One day, a friend called me up to inform about a job opportunity he came across on Instagram about a company. And he managed to get connect me to the owner of the firm. He even talked to the owner about me."

However, at that time work-from-home option was not available, she adds. "The owner promised that if an opportunity arrived, he would consider hiring me. So, my friend sent in my CV. After going through my CV, the CEO and MD of the

startup company Jaffar Sadique and Fazalu Rehman, head of Operations (India), called me and offered me the job," says Shamsia. She recounts how her parents are her rock. "My father, who retired from the BSNL, used to drop me off at the school and pick me up every day. This continued even during my college days," she says. However, she says that the fact that her parents were government employees always backfired. "I was deemed ineligible for grants and even quota," she says adding that if this job hadn't come her way she was planning on launching a venture. Shamsia is now preparing for PSC test to land a government job.

Seizure at airport leads sleuths to 'dense jungle' in Chennai's Kolathur

In coordination with the WCCB and the wildlife warden, the sleuths managed to secure details of an address in Kolathur in connection with the case.

CHENNAI. In one of the biggest crackdowns on wildlife trafficking in the city, officials from airport customs and the Wildlife Crime Control Bureau (WCCB) along with the Tamil Nadu Wildlife Warden seized as many as 22 animals belonging to seven exotic species that reached Chennai airport from Thailand. The seizure further led them to a two-storey house in Kolathur where several hundreds of other animals were stored.

It all began when Mohammed Meera Sardharali arrived in Chennai on Air Asia flight FD 153 at 11.10 pm on Saturday. Air Customs sleuths interrogated him and in his checked-in bag, they found 22

exotic animals, including one Siamang Gibbon (monkey native to Indonesia and Thailand), two Sunda flying lemur (a bat-like mammal native to Myanmar, Indonesia and Thailand), one red foot tortoise, five Indo-chinese box turtles, nine four-eyed turtles, one keeled box turtle, two green pythons and one white-lipped python.

Except for the lemur, all the other species are protected under the Wildlife Protection Act and the CITES (Convention on International Trade in Endangered Species of Wild Fauna and Flora).



Customs sleuths arrested Sardharali and a receiver named Mohammed Ithris from outside the airport. In most cases, this is where

the customs probe concludes.

However, in coordination with the WCCB and the wildlife warden, the sleuths managed to secure details of an address in Kolathur in connection with the case. They raided the house on Sunday, and to their utter shock, the two-storey house contained hundreds of native and exotic species of animals like star tortoise, Indian roofed turtle, tricarinate hill turtle, black pond turtle and royal ball pythons. No human was found in the house.

Tamil Nadu CM Stalin opens new fish market along Marina loop road, 332 stalls allocated

Greater Chennai Corporation Commissioner J Kumaragurubaran told that there are requests to increase the number of stalls from 366 to 500 from vendors who claim to be left out.

CHENNAI. Chief Minister MK Stalin on Monday inaugurated a fish market on Marina Loop Road near Nochikuppam. The market, built at a cost of Rs 9.97 crore, comprises 366 stalls, of which 332 have been allocated to fish vendors, on the basis of an enumeration in 2019.

Greater Chennai Corporation Commissioner J Kumaragurubaran told TNIE that there are requests to increase the number of stalls from 366 to 500 from vendors who claim to be left out. An enumeration will be

conducted to assess the needs of any remaining vendors from the area. He added that corporation-owned land along the stretch could be utilised to construct a second complex if the need arises. Corporation officials also said that contracts are to be awarded for the operation and maintenance of the fish market.

The corporation took up the market's construction following a court directive to remove encroachments by fish vendors

along Marina Loop Road. The facility now includes a dedicated fish cleaning area and a parking lot that could accommodate more than 100 cars. It also has an effluent treatment plant, toilets, and drinking water facilities.

The corporation had been facing stiff opposition from the fisherfolk community ever since it initiated the construction of the new complex. Last year, a group of fishermen took to the streets with their boats noting that the structure was being

constructed without consultations with residents of the fishing hamlets and was not in line with their needs.

K Bharathi, President of South Indian Fisheries Welfare Association told that a meeting will be held with people from the fishing villages in the area on Tuesday evening.

"Officially, we have not been informed what the rents are going to be. We will also discuss maintenance and allocation," Bharathi said.

80 illegal structures on NH8 link in Gurgaon raze



GURGAON. GMDA removed more than 80 illegal structures encroaching the roadsides and greenbelt along a 2.8km stretch connecting NH-8 and Sector 47 on Monday. The road passes through sectors 33, 38, 32, 46, and 47. The structures included shanties, tea stalls, shops, nurseries and dhabas.

Panel to be set up for flood-check plan in Gurgaon, says GMDA

Gurgaon. A day after the city was again left paralysed by severe waterlogging and flooding following the heavy downpour, civic authorities scrambled to devise a plan to combat the recurring issue. In an inter-departmental meeting chaired by GMDA chief executive officer A Sreenivas on Monday, officials from various agencies huddled together to find solutions to a problem that has plagued the city for years. Despite repeated assurances and plans in previous years, the city remains ill-prepared to handle even moderate rainfall.

To address this, Sreenivas said a committee will be formed to chart a comprehensive long-term plan, based on which remedial measures will be undertaken. "We will also identify additional new hotspots where waterlogging has been reported this year, and the list will be shared with other departments as well. A panel will be formed to chart a cohesive and long-term

HIV cases up 11% in 5 years across Haryana, govt steps up focus on campaigns & testing

GURGAON. Haryana has seen a steady rise in the number of people living with HIV though officials say the uptick in numbers is also due to increased testing across the state.

Data by the Union ministry of health and National AIDS Control Organisation showed that more than 50,000 people have been living with HIV since 2019. The annual figure was 50,604 in 2019, and it rose to 56,578 in 2023, an increase of 11% over four years. In the years between, cases rose steadily. A total of 51,840 people lived with HIV in 2020, and it rose to 53,115 in 2021 and 54,547 in 2022. AIDS, or acquired immune deficiency syndrome, is usually considered to be the last stage of HIV (human immunodeficiency virus) infection. It is considered so because the body's immune system is weak from the infection and cannot fight it. Gurgaon also witnessed an uptick in the number of people infected with HIV. The district had recorded 201 cases in 2021 and it rose to

1,491 so far this year. Officials pointed out that this could also be the result of higher testing - the number more than doubled from 30,571 in 2020 and 64,043 this year so far.

On the cases in Haryana, a health department official said on Sunday that they have introduced several measures such as more tests among high-risk populations and awareness campaigns to prevent the spread of HIV.

"The demographic most affected by the infection is the age group between 22 and 43 years. 56% of the cases are men and 40% are women and children. The remaining are transpersons. High-risk sexual behaviour followed by tattoo exposure was seen as the main reason for getting infected," the official said.

He added that increased testing, affordable medical treatment and public awareness were critical tools to eliminate the spread



of HIV. To prevent the spread of the infection, officials said people should practice safe sex, avoid sharing needles and can get regular tests done.

Virender Yadav, Gurgaon's chief medical officer, said the increase in the number of cases in the city was likely because of targeted testing. "We are carrying out targeted testing in jails, slums, among transpeople and truck drivers to identify

The New York Times says it will stop endorsing candidates in New York elections

The New York Times editorial board will stop endorsing candidates in New York elections, the paper's opinion editor said on Monday. The editorial board, which operates independently from the paper's newsroom, will continue to make endorsements in presidential elections. In a statement, Kathleen Kingsbury, head of opinion at The New York Times, did not explain a reason for the decision on the New York endorsements but said "Opinion will continue to offer perspective on the races, candidates and issues at stake." The paper reported the change would take effect immediately, with the editorial board not endorsing candidates in New York congressional or Senate races this fall, or in next year's mayoral race. Many newspapers have stopped endorsing political candidates in recent years for various reasons, including concerns over alienating readers as well as dwindling staff and resources, among other things.

An endorsement from the Times has been coveted by generations of politicians, particularly in New York City. The endorsement process has also often resulted in informative interviews between the editorial board and political candidates hoping to secure the slot. The Times has made an endorsement in every race for New York City mayor since 1897, the paper said.

Resignations of Bangladeshi officials close to Hasina are legal: Muhammad Yunus

DHAKA, Bangladesh. The head of Bangladesh's interim government, Nobel laureate Muhammad Yunus, says the high-profile resignations of authorities close to ousted Prime Minister Sheikh Hasina are legal after student leaders who organized protests against Hasina's government issued ultimatums for them to quit. "Legally ... all the steps were taken," Yunus, 83, told a group of journalists Sunday night.

The country's chief justice, five justices and central bank governor have all resigned in the past few days, part of a dramatic transformation after weeks of protests against a quota system for government jobs turned into a mass uprising. Hasina resigned and fled to India last week. Yunus said a key priority of the interim government is to restore the independence of the judiciary. He called former chief justice Obaidul Hassan "just a hangman." Syed Refaat Ahmed was appointed the new chief justice on Sunday after his name was proposed by student leaders of the protests. Students vow to cleanse the political system of Hasina's rule, which they have denounced as autocratic. More than 300 people, including students and police officers, were killed in the weeks of violence. Yunus took over on Thursday after student leaders reached out. He said the students told him he was the only one they could trust. He said he accepted "because these are the guys who broke the local government," describing it as a "student-led revolution." "It's not my dream, it's their dream. So I'm kind of helping them to make it come true," Yunus said. The interim government is expected to announce a new election, but it is not clear when it will be held.

Pakistan: Met Department predicts more monsoon rains from Aug 14

ISLAMABAD. The Pakistan Meteorological Department (PMD) has predicted more monsoon rains in the country from August 14 to 18, Geo News reported.

The weather department has forecast rain showers accompanied by storms and lightning adding that monsoon winds are expected to enter upper and middle areas of the country. The Met Office further said that the coastal areas of Sindh are anticipated to have a partially cloudy atmosphere as light rains may possibly occur. Islamabad, Rawalpindi and other areas of Punjab will likely experience rain from August 14 till August 18. According to Geo News, rain along with strong winds is expected in Murree, Galyat, Chakwal, Gujrat, Gujranwala. Apart from these areas, Hafizabad, Wazirabad, Sahiwal, Jhang, Nankana Sahib, Chiniot, Faisalabad, Lahore, Sheikhupura, Sialkot, Narawal, Okara and Pakpattan will also experience rain showers. Additionally, the met office said that rain with thunder and lightning is likely in Kasur, Khushab and Sargodha. Areas of Khyber Pakhtunkhwa will experience rain showers with thunder and lightning from August 14 to 18. The weather office said that Chitral, Dir, Swat, Bajaur, Buner, Mansehra, Abbottabad, Haripur, Peshawar, Mardan, Charsadda, Hangu, Kurram, Orakzai, Bannu and Dera Ismail Khan may also receive rain showers. The PMD has forecast a wetter-than-usual monsoon season for Pakistan even when waterlogging woes continued in several parts of the country. It remains one of the countries experts say is most vulnerable to extreme weather being spurred by climate change, Geo News reported.

US lifts curb on sale of weapons to Saudi Arabia, with eye on resolving Gaza

The United States has confirmed that it would resume sales of offensive weapons to Saudi Arabia, as concerns over human rights in the kingdom's Yemen war give way to US hopes for it to play a role in resolving the conflict in Gaza.

Washington. The United States confirmed Monday it would resume sales of offensive weapons to Saudi Arabia, as concerns over human rights in the kingdom's Yemen war give way to US hopes for it to play a role in resolving the conflict in Gaza. More than three years after imposing limits on human rights grounds over Saudi strikes in Yemen, the State Department said it would return to weapons sales "in regular order, with

appropriate congressional notification and consultation." Saudi Arabia has remained a close strategic partner of the United States, and we look forward to enhancing that partnership," State Department spokesman Vedant Patel told reporters. US President Joe Biden took office in 2021 pledging a new approach to Saudi Arabia that emphasized human rights, and immediately announced that the administration would only send "defensive" weaponry to the longtime US arms customer. The step came after thousands of civilians -- including children -- were estimated to be killed in Saudi-led airstrikes against Iranian-backed Huthi rebels, who have taken over much of Yemen. Geopolitical considerations have, however, changed markedly since then. The United Nations, with US support, brokered a truce in Yemen in early 2022 that has largely held. Since the truce, "there has not been a single Saudi airstrike into Yemen and cross-border fire from Yemen into Saudi Arabia has largely stopped," Patel said. "The Saudis



since that time have met their end of the deal, and we are prepared to meet ours," Patel said.

Saudi role in Gaza war

It is now the United States, Britain and recently Israel that have been striking Huthi targets in Yemen, with Saudi Arabia content to watch from the sidelines. The Huthis have been firing missiles at commercial ships in the vital Red Sea in professed solidarity with Palestinians, who have been in the crosshairs of Israel since the October 7 attack by Hamas. In a bid to find a long-term solution, US Secretary of State Antony Blinken has

repeatedly traveled to Saudi Arabia to discuss a package of US incentives if the kingdom recognizes Israel. Saudi Arabia has sought US security guarantees, a continued flow of weapons and potentially a civilian nuclear deal if it normalizes with Israel.

Israeli Prime Minister Benjamin Netanyahu has made normalization with Arab states a top goal and no prize would be as big as Saudi Arabia, guardian of Islam's two holiest sites. But Saudi Arabia says it cannot act without progress on a Palestinian state, an idea pushed by the Biden administration as it seeks a diplomatic way out of the Gaza conflict, but bitterly opposed by Netanyahu and his far-right allies. Representative Joaquin Castro, a progressive member of Biden's Democratic Party, said that Saudi Arabia still had a "troubling track record" on human rights. "I supported the Biden administration's initial decision to pause offensive arms sales to Saudi Arabia, and I hope to see compelling evidence that Saudi Arabia has changed its conduct," he said.

Elon Musk claims over '200 million' tuned in to interview with Trump

World Global internet traffic on Elon Musk and Donald Trump's interview on X, formerly known as Twitter, went past 200 million.

"Almost all of the legacy media will trash the Trump conversation, thus driving total listeners probably past 200 million," Elon Musk posted on X. The interview, which was delayed by 45 minutes due to a technical glitch, went around for over two hours. As the interview proceeded, Trump's X handle "received over 200 million impressions," said Collin Rugg, co-owner of Trending Politics.

In a highly anticipated interview, Republican presidential nominee Donald Trump shared a blend of grievances, personal attacks, and bold claims, while tech mogul Elon Musk occasionally offered subtle nods of encouragement. Kicking off the conversation, Donald



Trump claimed that Joe Biden's exit from the US presidential election race was a "coup." "I beat Biden so badly in the debate that he was forced out of the race — one of the greatest debate performances ever. Biden's exit was a coup," the 78-year-old told the tech billionaire. Recalling the assassination bid

against him, the former US President told Musk that it was "not pleasant." It was a hard hit. It was very, I guess you would say, surreal, but it was not surreal. You know, I was telling somebody, you have instances like this where you feel it's a surreal situation. And I never felt that way. I knew immediately that it was a bullet," Trump responded to Musk's question about what the shooting was "like for you." Earlier, ahead of the interview, Donald Trump returned to X, leaving his Truth Social behind for the first time in nearly a year. He posted a collage of him and Musk with the caption, "Donald J. Trump and Elon Musk live on X with a footer, 'Monday 8 pm ET/5 pm PT,' with the former POTUS' winky caption, 'Enjoy!'.

UN chief calls for Africa's permanent seat in UNSC, highlights under representation

world. During a recent high-level debate at the United Nations Security Council (UNSC), UN secretary-general Antonio Guterres said that UNSC has failed to keep pace with a changing world.

Advocating for a permanent seat for Africa, Guterres said, "We cannot accept that the world's preeminent peace and security body lacks a permanent voice for a continent of well over a billion people" according to Al Jazeera. He emphasised that Africa's perspectives on peace and security, both within the

continent and globally, are undervalued under the current arrangement.

The UNSC currently consists of 15 members, including five permanent members with veto power—China, France, Russia, the United States, and the United Kingdom. The remaining ten seats are non-permanent, distributed regionally, with three allocated to African states. Meanwhile, the UN general assembly President Dennis Francis said, "The fact that Africa continues to be manifestly underrepresented on the

Security Council is simply wrong, offending as it does both the principles of equity and inclusion," he said.

"It runs counter to the principle of sovereign equality of states and calls for the urgency to reform this institution to reflect the world as it is now, rather than what it was nearly 80 years ago," Francis added. The United Nations Security Council (UNSC) demanded in May that African nations take a larger role in addressing global security and development challenges.

Israel keeps up strikes in Gaza as fears of wider conflict in West Asia grow

Israel continued its offensive operations near Gaza's Khan Younis, which led to the death of 18 people and injuries to several others. The attack by Israel led to the evacuation of

Cairo,UPDATED Israeli forces pressed on with operations near the southern Gaza city of Khan Younis on Monday amid an international push for a deal to halt fighting in Gaza and prevent a slide into a wider regional conflict with Iran and its proxies.

Palestinian medics said Israeli military strikes on Khan Younis on Monday killed at least 18 people and wounded several. Meanwhile, more families and displaced persons streamed out of areas threatened by new evacuation orders telling people to clear the area. Later, an Israeli airstrike killed five people in the Zeitoun suburb of Gaza City, and two others were killed in Rafah, near the border with Egypt, medics said. As fighting continued, Hamas reacted sceptically to the latest round of Egyptian and Qatari-brokered talks due on Thursday, saying it had seen no sign of movement from the Israeli side. The group said on Sunday that mediators must force Israel to accept a ceasefire proposal based on ideas from US President Joe Biden, which Hamas had accepted, "instead of pursuing further rounds of negotiations or new proposals that would provide cover for the occupation's aggression". Two sources close to Hamas told Reuters the group was convinced the



new call for talks was coordinated beforehand with Israel to deter responses from Iran and Hezbollah to the assassination of the group's chief, Ismail Haniyeh, in Tehran and a top Hezbollah leader in Lebanon. "It is a mild rejection you can say. Should Hamas receive a workable plan, an Israeli positive response to the proposal it had accepted, things may change, but so far Hamas believes Netanyahu isn't serious about reaching a deal," said one Palestinian official close to the mediation effort. Hamas' reaction to the talks came as preparations for a larger scale confrontation grew, with Washington ordering a guided missile submarine to the Middle East and the Abraham

Lincoln strike group accelerating its deployment to the region. Israeli Defence Minister Yoav Gallant told US Defense Secretary Lloyd Austin that Iran was making preparations for a large-scale military attack on Israel, Barack Ravid, a normally well-sourced reporter for Axios News, reported on Twitter. Israel has been braced for a major attack since last month when a missile killed 12 youngsters in the Israeli-occupied Golan Heights and Israel responded by killing a senior Hezbollah commander in Beirut. A day after that operation, Haniyeh, the political leader of Hamas, was assassinated in Tehran, drawing Iranian vows of retaliation against Israel. The potential escalation underlined how far the Middle East has been thrown into turmoil by the Gaza war, now in its 11th month. Hamas-led attack on Israeli communities around the Gaza Strip on October 7 killed some 1,200 people, with more than 250 taken into captivity in Gaza, according to Israeli tallies, in one of the most devastating blows against Israel in its history. In response, Israeli forces have flattened Gaza, displaced most of the population and killed around 40,000 people, according to the Palestinian health ministry, in a war that has caused horror around the world.

Nearly 50,000 deaths reported in Europe in 2023 due to heat: Study

According to a report by the Barcelona Institute for Global Health (ISGlobal), more than 47,000 people have died in Europe due to heat in 2023, with countries in the region's south hit the hardest.

Madrid, More than 47,000 people died in Europe due to scorching temperatures in 2023, with countries in the region's south hit the hardest, according to a report by the Barcelona Institute for Global Health (ISGlobal) published on Monday. Last year was the world's hottest on record.

As climate change continues to increase temperatures, Europeans live in the world's fastest-warming continent, facing growing health risks stemming from intense heat.

The 2023 death toll - below the more than 60,000 heat-related deaths estimated for the previous year - would have been 80% higher without measures introduced in the past 20 years to help people adapt to rising temperatures, such as early warning systems and healthcare improvements, according to the report by the Spanish research centre. Researchers used death and temperature records from 35 European countries. They estimate that 47,690 died from causes related to high temperatures. Adjusting the data for population, Greece, Bulgaria, Italy and Spain were the countries with the highest mortality rates related to heat.

Thiruvananthapuram: Journalists manhandled by staff at Secretariat

THIRUVANANTHAPURAM. Media persons, who had entered the Secretariat premises to cover an event on Monday were allegedly manhandled by the staff. The journalists and crew belonging to the Media One channel were assaulted when they were recording a brawl between the canteen staff and the employees of the sub-treasury. The media persons had entered the secretariat premises to cover the press meet of Local Self Government Minister M B Rajesh. It was while returning that they spotted the fracas and tried to record it. The unruly staff threatened the journalists and manhandled them. The Kerala Union of Working Journalists (K U W J) and Thiruvananthapuram Press Club condemned the incident and called for strong action against those who assaulted the journalists. The media fraternity, meanwhile, filed a complaint with the Chief Minister seeking strong action.

MCH to soon have multi-discipline research unit in Thiruvananthapuram



THIRUVANANTHAPURAM . The health department has decided to set up a multi-disciplinary research unit with equipment such as digital PCR and stereo microscope at the Government Medical College, Thiruvananthapuram. The project, being implemented with the support of the Indian Council of Medical Research (ICMR), is expected to improve pathogenic disease surveillance. The district has reported eight confirmed cases of amoebic meningoencephalitis, and over 40 people are under observation. Earlier, the district reported an outbreak of cholera as well. Molecular-level testing facilities are key in identifying various pathogenic infections. Thiruvananthapuram GMC principal Dr Linette J Morris said the new multi-research laboratory would enhance the diagnostic capabilities of the GMC. She, however, said the existing lab facilities are capable of diagnosing amoebic meningoencephalitis. The project is expected to cost Rs 1.6 crore. The digital PCR unit, a high-performance liquid chromatography and stereo microscope with fluorescence would cost around Rs 40 lakh each. Meanwhile, the Institute of Advanced Virology (IAV) has announced plans to establish a diagnostic facility on its Thiruvananthapuram campus in response to a surge in amoebic meningoencephalitis cases in the state.

CM Pinarayi Vijayan to inaugurate renovated Changampuzha Park on September 12

KOCHI. Come Onam, the Changampuzha Park, will be once again become a hive of activities after a gap of nearly three months. The park, which has been renovated at a cost of Rs 4.31 crore, will be inaugurated by Chief Minister Pinarayi Vijayan on September 12. “The CM has tentatively given the nod on September 12. However, we’re waiting for the written confirmation which will take another three days,” said K Chandran Pillai, Chairman, Greater Cochin Development Authority (GCDA). The agency gave approval to the week-long cultural fest, suggested by the Changampuzha Cultural Centre (CCC), which is managing the park. It also gave a nod to the wishlist of artists, proposed by the centre. “We’re trying to rope in renowned artists to the likes of Carnatic vocalist T M Krishna, actor Manju Warrior and mohiniyattam exponent Methil Devika,” said CCC president P Prakash. The festival will see various events -- dance, classical music, kathakali (including the play ‘Duryodhanavadham’), stage plays, musical evening and cinema debate. The first event will be the stage play ‘Olivile Ormakal’ (Memories in Hiding), under the banner of Kerala People’s Art Club (KPAC) on August 25. It will be held as a one-off event as part of the state conference of the ‘Purogamana Kala Sahitya Sangam’. Set up in 1977, the Changampuzha Park has since grown as the city’s cultural hub. Its renovation was carried out by the GCDA in collaboration with the Cochin Smartcity Mission Limited (CSML). The work was originally scheduled to be completed in February 2024. Till May, the refurbishment work was held while simultaneously organising cultural events. However, the park was completely closed for the last three months to facilitate the quick completion of the work.

NIRF ranking: Anna University first among state-funded institutions

CHENNAI. Anna University is the best state government funded university in the country as per the NIRF rankings 2024, released by the union education ministry on Monday. The rankings introduced three new categories: Open Universities, Skill Universities and State Public Universities (state government funded government universities) this year and in the introductory edition. Anna University is ranked as the top state public university in the country followed by Jadavpur University, Kolkata, and Savitribai Phule University, Pune. In fact, 10 state funded universities from Tamil Nadu are placed in the top 50 state public universities in the country. Bharathiar University is ranked 8th while University of Madras is ranked 12. This is the sixth year that IIT-Madras has maintained its top position in both the ‘overall’ and ‘engineering’ categories in the rankings. It has been ranked first in the engineering category every year since the inception of the rankings in 2016. However, apart from this, the NIRF report has nothing new for the state to cheer about as there is not much improvement in the performance of the higher educational institutes in state. In the overall category, 18 institutions from

Tamil Nadu are in top 100 and in the universities category, 22 from the state feature in the top 100 list. The figures are similar to last year, but performance of the majority of the state funded universities have dropped this year.



There are nine state-funded universities in the top 100 university category, but only four of them have managed to better their performance. Anna University is ranked 13 this year against last year’s 14, while University of Madras’ ranking has improved to 39 against last year’s 50.

Similarly, Bharathidasan University has bettered its ranking from 41 to 36 this year while Periyar University has moved from 59 to 56th position this year. Amrita Vishwa Vidyapeetham is ranked 7th, Vellore Institute of Technology is 10th while Saveetha Institute of Medical and Technical Sciences and SRM Institute of Science and Technology have secured 11th and 12th rank respectively in the university category. However, the major disappointment is in the college category as Presidency College has dropped to 13th rank this year. For the last two years, Presidency was ranked as the third best college in the country. In the innovation category, IIT-M is in the second rank while Anna University has secured the 10th position while in the research category Anna University’s position has dropped to 17th rank against last year’s 13.10 state univs in top 50 IIT-M has been ranked first in engineering category every year since the inception of NIRF rankings in 2016. Ten state funded universities have been placed in the top 50 state public universities in the country

Jail tunnel case: After 11 years, two get bail

Ahmedabad. The Gujarat high court on Monday granted regular bail to two accused persons in the 2013 Sabarmati prison-break attempt case. They, along with 22 others, all accused in the 2008 serial blasts case, had allegedly dug a 213-foot tunnel to escape. The two men who were granted bail on Monday — Nasir Ahmed Patel and Nadeem Saiyed — are among the three who were acquitted two years ago in the 2008 serial blasts case and arrested in the tunnel digging incident. The third person, Raziuddin Nasar from Hyderabad, was granted bail by the SC in Jan. After their acquittal in the serial blasts case, in which 49 were convicted, Patel and Saiyed applied for bail. However, their request was rejected by the court citing the gravity of the offence. After filing successive bail pleas, their counsel Musaib Shaikh contended that the accused have been behind bars in the case for 11 years and there is no

possibility of a trial soon. This is because all the accused persons had been in jail and available for the trial, but certain legal tangles delayed it. Besides taking the long pendency of the trial and incarceration into consideration, Justice Nirzar Desai also considered the demand for benefit of parity as the apex court had granted regular bail to an accused in a similar case earlier this year. After the jailbreak effort came to the notice of the Sabarmati central jail authorities, Ranip police lodged an FIR and launched a probe. Twenty-four accused persons lodged in the jail in connection with the serial blasts case were charged for the jailbreak attempt and criminal conspiracy. At a later stage, the police invoked Section 130 of IPC for aiding the escape of ‘state prisoners’ or ‘prisoners of war’. This made the case grave with a punishment provision of up to life imprisonment, and the case was shifted to a sessions court for trial. Invocation of this section was a bone

of contention, and a legal battle lasted for over seven years with the HC staying the trial until it rejected the prisoners’ discharge pleas in 2022. MSID: Delhi liquor policy corruption case: Supreme Court grants bail to Manish Sisodia The Supreme Court granted bail to AAP leader and former Delhi deputy CM Manish Sisodia in corruption and money laundering cases related to the scrapped Delhi liquor policy. Despite CBI and ED’s pleas, the SC rejected imposing additional conditions on Sisodia. SC grants Sisodia bail, says trial yet to even commence The Supreme Court granted bail to Aam Aadmi Party leader Manish Sisodia in corruption and money laundering cases tied to Delhi’s excise policy changes. After 17 months in jail, the court cited the prolonged trial and violation of his fundamental rights. Conditions like surrendering his passport were imposed, rejecting prosecutorial claims of delay by Sisodia.

Gujarat eyes Olympic boost from Britain

Gandhinagar. British high commissioner Lindy Cameron engaged in discussions with chief minister Bhupendra Patel on how Gujarat can benefit from Britain’s expertise in organizing Olympic Games. Cameron, who was on her first visit to Gujarat since assuming office, was warmly welcomed by the CM in Gandhinagar. Patel highlighted Gujarat’s leading role in the renewable energy sector, mentioning the construction of the world’s largest hybrid energy park in Kutch and the state’s growing global presence in emerging fields like green hydrogen. Discussions also covered Gujarat’s potential to benefit from Britain’s expertise in cybersecurity, with details provided about the collaboration with National Forensic Sciences University (NFSU) in this domain. Meanwhile,

NFSU became a part of Interpol’s Global Academy Network. NFSU officials said that the move will help enhance regional and global police capacity as well as foster collaboration among law enforcement agencies worldwide. Paris Olympics: Britain’s Keely Hodgkinson wins women’s Olympic 800m gold Keely Hodgkinson, a 22-year-old British athlete, triumphed in the women’s 800m final at the Paris Olympics, finishing in 1:56.72. Around 1,000 units have been asked to halt operations for 57 hours from Thursday as the Ahmedabad Municipal Corporation (AMC) plans to check illegal connections in the megaline, which carries effluent from Naroda, Odhav and Vatva. Close to 1,100 units send their effluent discharge to Naroda, Odhav and Vatva common effluent treatment plants (CETPs) which is then redirected into the megaline. The megaline association, which discovered 155 illegal connections in the past two and a half years, has asked member CETPs and units to not send effluent from 10pm on Aug 15 to 7am on Aug 18. The megaline was laid in 2002 to discharge effluent from industries in Naroda, Odhav and Vatva. A special purpose vehicle, the Ahmedabad Mega Clean Association (AMCA), was established with CETPs, the industries commissionerate and the Gujarat Industrial Development Corporation. The megaline has a capacity of 90 MLD and effluents account for 60 MLD. Shailesh Patwari, advisor to AMCA, said, “There is a need to check illegal connections in the megaline. We have asked our member CETPs and their member units to stay away from operations for around 57 hours. AMC will also check if any CETP is



discharging effluent during this period. We have asked CETPs to carry out required maintenance as regular operations will be put on hold.” He added that they have seen a reduction in the megaline’s outflow after AMC declared it would inspect it. “We inform AMC and GPCB whenever we catch an illegal connection in the megaline. We believe AMC will find all the illegal connections and resolve the matter,” he said. “Units that have effluent storage facilities can continue their operations, but CETPs will not accept effluents for two days. These 1,100 units produce chemicals worth around Rs 100 crore per day,” AMCA officials said. Tamil Nadu: Groundwater comes to aid, kuruvai cultivated in 3.32 lakh acres in delta

TIRUCHY/THANJAVUR/NAGAPATTINAM. Despite uncertainty in getting enough Cauvery water, 3.32 lakh acres of kuruvai has been cultivated in delta districts this season, thanks to the availability of groundwater. While 1.30 lakh acres were covered under kuruvai in Thanjavur, highest among delta districts, 92,500 acres were covered in Tiruvapur. The total kuruvai area may go up after the final count, sources said. The kuruvai target in both districts was achieved mostly by using groundwater for irrigation as the cut-off date for kuruvai sowing was fixed as July 31. As the water from Kallanai was released only on July 31, the Cauvery water could be used only as a supplementary source for irrigation in addition to the groundwater, official sources said. In Tiruchy, against the target of 16,250 acres for kuruvai paddy set by the agriculture department, 16,105 acres have been covered. As the groundwater level has improved in the district following the copious flow of water in both the Cauvery and Kolliadam rivers for nearly a week, officials said that they have surpassed the targeted area of cultivation this kuruvai season. Since water was released from Mettur reservoir on its customary date of June 12 in 2023, farmers took up kuruvai cultivation in around 15,000 acres against the 13,000 acres covered during 2022 in Tiruchy district. While several farmers cultivating kuruvai relied solely on filter point borewells, a considerable number of them from Anthanallur, Musiri, Thottiam and Tiruverumbur irrigate their paddy fields using 14 canals, including Uyyakondan, which receive water from Cauvery, officials said. “Most of the kuruvai cultivation in Tiruchy is in areas primarily irrigated by filter point borewells. However, the rise in groundwater level due to recent flow in the rivers have encouraged the farmers who rely on Cauvery to undertake kuruvai this season, particularly from Anthanallur, Tiruverumbur, and Pullambadi. We have exceeded our target in these areas,” joint director M Sakthivel said. In the case of Mayiladuthurai, the targeted area of 90,000 has been achieved. In Nagapattinam, farmers have raised kuruvai paddy in around 3,750 acres.

Five SpiceJet flights, 17 others delayed

Ahmedabad. Low-cost carrier SpiceJet faced major operational disruptions in its flight movements on Monday — five flight departures from Ahmedabad were delayed by three to seven hours, leaving passengers in a state of frenzy. The airline’s Dubai-bound flight was delayed by seven hours, while domestic operations to Delhi, Ayodhya and Goa were also delayed. SpiceJet operates two daily flights from Ahmedabad to Delhi, one of which was delayed by three hours and the other by six-and-a-half hours. The flights to Ayodhya and Goa were also delayed by at least seven hours. Similar was the situation for the arriving flights as well. “A Goa-Ahmedabad SpiceJet flight, scheduled to land at 10.35am, arrived by 5.19pm. Similarly, a Delhi-Ahmedabad flight scheduled to arrive here by 11.45am arrived at 6pm. The flight from Ayodhya was also delayed by about 7 hours,” a source said. Responding to TOI’s query, a SpiceJet spokesperson attributed the delay in SpiceJet’s flight movements to “operational issues (grounding of an aircraft)”. “There was no commotion at the airport as most passengers were informed in advance. The early morning flight to Goa departed in the afternoon. Flight operations of the airline have been affected across India for the past couple of days,” said a source. Industry sources also cited non-payment of timely salaries to employees as a potential factor leading to operational challenges. On Monday, 22 flights departing from Ahmedabad airport were delayed by at least one-and-a-half hours. These include domestic flights to Mumbai, Bengaluru, Delhi, Jaipur, Rajkot, Pune, Chennai, Aurangabad, Goa and Hyderabad. Meanwhile, an international flight to Sharjah was also delayed for departure. According to FlightRadar24, an online aircraft tracking platform, 65% of the flight departures from the SVPI airport were delayed. Besides the reported delays in SpiceJet’s operations, bad weather conditions across India hampered flight operations leading to rotational delays and delay in arrivals. As a result, some of the departures were also delayed. Fake bomb threat by passenger at Kochi airport delays flight to Thailand A fake bomb threat by a passenger during a security check at Cochin International Airport delayed a Thai Lion Air flight by two hours and led to the passenger’s arrest. The Bomb Threat Assessment Committee conducted thorough inspections before declaring the threat non-specific. The flight departed after delays from the comprehensive checks. SpiceJet Mumbai airport dues: Flights won’t be hit, says airline Mumbai airport and SpiceJet clashed on social media over the airline’s pending dues. An advisory by the airport about disruptions in SpiceJet’s operations was deleted. SpiceJet assured normal operations and attributed the issue to a minor financial matter, now resolved. The airline has faced delays in salary payments and has a low on-time performance rate at Mumbai airport. Minor financial matter; resolved, SpiceJet says after Mumbai Airport warned of flight disruptions SpiceJet faced mounting financial troubles, struggling to raise funds and pay employees and stakeholders. Mumbai International Airport Ltd (MIAL) alerted about a potential flight disruption on Aug 13. The alert was later retracted as the issue was resolved.

All on 'account' of cash in rural bank branch

A job in a rural branch of a bank offered a variety of interesting experiences. It was a privilege for me to reside in a village amidst simple, earnest and affectionate people during the early 1980s. Joining straight after college, a couple of months before the completion of my post-graduation degree, I felt secure and comfortable. Some of the situations that I encountered were quite amusing and they taught me a lot about human nature.

I was the lone clerical staff member in that branch; the branch manager was the sole supervisory officer. The presence of both of us was necessary to run the branch. The manager used to send me, along with the subordinate staff, for remitting excess cash or receiving the required cash from a bigger branch after finishing the day's work in the afternoon. Once, when the cash box was being taken out of the branch, a local customer got suspicious and felt disturbed. He went on to question the manager as to how the hard-earned money deposited by the public was being 'irresponsibly' shifted elsewhere. The manager had to take pains to convince him that the public sector bank truly owed back the liability and would not default on payment to any customer.

On another occasion, an unscheduled payment of Rs 25,000 was to be made to a customer around 11 am. Unfortunately, our opening cash balance was much below that, and more deposits were unlikely to be made in our branch that day. I suggested that the manager himself go to secure cash from the branch situated about 9 km away. He thought of a short cut. He called up a current



account holder, a wealthy textile merchant, and asked him if he could spare Rs 25,000 for the bank's urgent need. His idea was to make him deposit the amount in his account and the cash received thereby could be used to clear the payment pending at my counter.

The customer was kind enough to agree, and his son turned up within five minutes in front of me, not with the cash, but with a cheque signed by his father! I asked him why he had brought the cheque. Pat came the reply from the young son of the valued customer: 'My father has told me that the bank can take the required amount from his account.' The shocked manager thanked him with folded hands, and he left.

We realised that the innocent customer had misunderstood our communication. After having a hearty laugh, the manager hurriedly left along with the subordinate staff to get the cash from the nearby branch. And our requirement had now gone up due to the cheque that was staring us in the face.

Strategic outcomes of 1971 war must not be jettisoned

Ousted Bangladesh PM Hasina's 'forward-looking vision' needs to be 'tied down' by India so that the genie of religion-based politics does not derail bilateral ties.

DO the recent events in Bangladesh require the jettisoning of the strategic outcomes of the December 1971 war that led to the emergence of an independent nation? What are India's broader strategic incentives in the light of these changes? At least four major strategic outcomes of the war remain relevant for India at a time when international relations are in a period of unpredictable churn.

First, the war proved the hollowness of the two-nation theory on the basis of which the British government partitioned India in August 1947. The war was triggered by the refusal of Pakistan to accept the outcome of its 1970 national elections, which had given the mandate to the Awami League, a political party based on linguistic rather than religious identity. The refusal of the Pakistan army to accept the swearing-in of Sheikh Mujibur Rahman, the Muslim leader of the Awami League, as the Prime Minister of Pakistan, led to the political dismemberment of Pakistan through the war. The strategic outcome for India's interests in independent Bangladesh that emerged from East Pakistan has been acknowledged. The dramatic transformation of the India-Bangladesh bilateral relationship is credited to the 'forward-looking vision' of ousted Bangladesh Prime Minister and Awami League leader Sheikh Hasina. It is this vision that needs to be 'tied down' by India now to ensure that the genie of religion-based politics or terror does not derail India-Bangladesh relations. India has assiduously built up a range of interlocutors in Bangladesh, particularly during the past 15 years that Hasina was in power, to calibrate this effort in a coherent manner. Second, the war proved that India could act to intervene militarily in the former East Pakistan to create "conditions of stability and wellbeing which are necessary for peaceful and friendly relations" (Article 56 of the UN Charter) between India and Bangladesh. India concluded its armed campaign on December 16, 1971, and withdrew its military forces from Bangladesh by March 12, 1972, illustrating how humanitarian intervention can work in practice in international relations. This strategic outcome has provided the foundation for the sustainable development of India-Bangladesh bilateral relations, particularly in the economic and security spheres. Major outcomes in recent years, apart from frequent high-level political exchanges which have been of mutual benefit to the people of both

countries, illustrate this well. Connectivity projects have made Bangladesh an important strategic partner for India's links with its north-eastern states through Bangladesh. This has had an impact on India's Act East Policy as well. About \$8 billion in three lines of credit have been extended by India to Bangladesh in recent years for specific connectivity projects. These include the construction of the Akhaura-Agartala rail link, the dredging of inland waterways in Bangladesh and the

inspection of boundary pillars and joint boundary demarcation, including of riverine boundaries, which impact on security and migration issues.

In July 2014, the Hague-based Permanent Court of Arbitration of the UN Convention on the Law of the Sea (UNCLOS) had awarded Bangladesh an area of 19,467 sq km, four-fifth of the total area of 25,602 sq km disputed maritime boundary with India in the Bay of Bengal. India's swift acceptance of the award provided the impetus for generating mutual trust and confidence with Bangladesh. It also led to the dynamic growth of regional cooperation, with the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC) establishing its Secretariat in Dhaka.

Third, following the unconditional surrender of the Pakistan army on December 16, 1971, to India, strategic conditions were created in South Asia for asserting the primacy of resolving disputes through bilateral treaty-based negotiations. The Simla Agreement, signed in July 1972 as a bilateral treaty, was negotiated and signed by the elected governments of India and Pakistan. It was registered with the United Nations as a legal framework that can be invoked "before any organ of the United Nations" under Article 102 of the UN Charter.

This strategic outcome has served India's interests well. It has ensured that an undemocratic and unreformed UN Security Council has not succeeded in reopening the Kashmir issue after the war. India has prioritised applying bilateral frameworks to address its disputes with its neighbours rather than issues into ineffective multilateral frameworks.

Fourth, the war established India's ability to act invoking the principle of 'strategic autonomy'. India put its national interests above international attempts to dictate terms to India through the UN in December 1971. The most striking illustration of this was the rebuff to the display of a nuclear-armed maritime force by the USS Enterprise in the Bay of Bengal to try and prevent India from achieving its objectives in the war.

At a time when international relations are being increasingly subjected to the dictates of major military powers, including the imposition of unilateral sanctions, 'strategic autonomy' is a strategic outcome of the 1971 war that India has a strong incentive to build upon as it transitions into a major power.



construction of an India-Bangladesh Friendship Pipeline for the carriage of high-speed diesel from India into Bangladesh, which was inaugurated in March 2023. As many as six pre-1965 rail links between India and Bangladesh have been reactivated, while Bangladesh's ports of Chittagong and Mongla have been made available for Indian transit cargo to North-East India.

The India-Bangladesh border, covering 4,095.7 km, is the longest land border that India shares with any of its neighbours. On the midnight of July 31, 2015, India and Bangladesh implemented their historic Land Boundary Agreement to transfer 51 erstwhile Bangladeshi enclaves in India and 111 erstwhile Indian enclaves in Bangladesh to the other country. This laid the groundwork for operationalising appropriate border management systems on both sides, including for border fencing, joint

Hindenburg at it again

Market regulator SEBI's credibility at stake

OVER a year and a half after it stirred up a hornet's nest by accusing the Adani Group of pulling off 'the largest con in corporate history', US short-seller Hindenburg Research has trained its guns on the chairperson of SEBI (Securities and Exchange Board of India), Madhabi Buch, and her husband. Flagging conflict of interest, Hindenburg has alleged that the couple had stakes in obscure offshore funds used in the financial scandal. The insinuation is that the country's market regulator, tasked with protecting the interests of investors in securities, took its foot off the probe pedal in view of a presumably commercial relationship between the Buchs and the Adanis.

The accusation — trashed by the couple as well as the conglomerate — is provocative as the Supreme Court had in January backed SEBI to the hilt, stating that the latter was conducting a 'comprehensive investigation' into alleged manipulation of stock prices and there was no need to



transfer the case to a special investigation team. The faith reposed in SEBI by the apex court had raised eyebrows;

after all, had the court trusted the board unquestioningly all along, why would it have set up a separate expert panel to look into regulatory lapses in the wake of Hindenburg's January 2023 report? At stake here is SEBI's credibility, even as knives are again out in the political arena. The Congress has reiterated its demand for a joint parliamentary committee to investigate the scam in its entirety. Repeatedly accused of going the extra mile for leading corporates, the government needs to do much better than to just allege that the main Opposition party and Hindenburg are in cahoots. Transparency is a must to clear the air; the impression that SEBI is reluctant to complete its probe in all respects ought to be dispelled. Hindenburg might not be completely above board itself, but its claims cannot be conveniently brushed aside; they need to be countered with indisputable facts. The sooner the better, failing which the government's pro-investor push will suffer a big jolt.

In New Strategy, Manipur Chief Minister Looks To Redraw District Boundaries, End "Political Convenience"



Manipur Chief Minister N Biren Singh in the state assembly on Monday blamed past governments for leaving behind a mess by slicing up districts to create new ones for "political convenience", and not "administrative convenience"

Imphal/Guwahati/New Delhi. Manipur Chief Minister N Biren Singh has indicated the state government will work with all communities and civil society organisations to discuss redrawing district boundaries based on "administrative convenience" and not on "ethnic lines".

Mr Singh in the state assembly on Monday blamed past governments for leaving behind a mess by slicing up districts to create new ones for "political convenience", and not "administrative convenience".

"Everyone keeps saying what's happened has happened. I say we should discuss what's happened and correct mistakes so that the future generations don't suffer. The districts created in the name of administrative convenience, for example, Sadar Hills and Kangpokpi, it reaches all the way to Bishnupur. If a fire or some incident happens, how are the fire officers or the police going to

reach Bishnupur from Kangpokpi?" Mr Singh said in the house. "The districts were created not for administrative convenience, but for political convenience."

He called it "most unfortunate" that there's an assumption in Manipur that districts have been created based on ethnic lines, "as if one district has been created for a particular community and given to them, forgetting what India is all about, what Manipur is all about."

The Kuki-dominant Kangpokpi district headquarters lies 45 km to the north of the state capital Imphal. Kangpokpi district was created in 2016. The district's long, inverted U-shaped area surrounds Imphal valley from the north, east and west, leaving the south open till it reaches Bishnupur district in the valley, 75 km away. In the hills on the flank of Bishnupur, Kangpokpi also



joins with another Kuki-dominated district, Churachandpur, which lies south of Bishnupur. The Manipur Chief Minister's comment that "political convenience" led to drawing district boundaries on "ethnic lines"

was seen as one example referring to the expansion of Kangpokpi district - and the troubles the state is facing today, Manipur BJP sources said.

"This (ethnic division) fault has existed for a long time, and it will not be easy to correct it today. Our inability to proudly say we, together, are the people of Manipur - Manipuri Tangkhul, Manipuri Meitei, Manipuri Pangal, Manipuri Thadou or Manipuri Paite - is a serious, chronic disease. It will take time to cure this, but cure we must," Mr Singh said in the assembly.

"To rework district boundaries based on administrative convenience and not on ethnic lines would be a good step... It seems some have started thinking they are kings of their districts. Despite living together for

generations, suddenly there are complaints about taking 'tax', about being checked or stopped while entering a district... these are not compatible with the democratic set-up of the country... So we need reorganisation of the districts, for which we should sit together and discuss," the Chief Minister, who belongs to the ruling BJP, said in the assembly.

Mr Singh's proposal, however, has been criticised by some of the 10 MLAs from the Kuki tribes and also the Opposition Congress as a way to divert attention from more immediate issues linked to the ethnic violence between the Meitei community and the Kuki tribes. The 10 Kuki MLAs are not attending the assembly session. Manipur Congress unit leader Lamtinthang Haokip in a post on X reminded the Chief Minister that he was a part of the same government when the districts were created.

New Delhi. As India prepares to celebrate its 78th Independence Day, come August 15, the 'Har Ghar Tiranga' caller tune is back. "He's So Powerful...": Principal Sent On Leave In Doctor Rape-Murder Case

Kolkata. The Calcutta High Court has ordered Dr Sandip Ghosh, the former head of Kolkata's RG Kar Medical College and Hospital - where a doctor was raped and murdered last week - to go on long leave. Dr Ghosh - under scrutiny for comments seen as victim-blaming and failing to ensure staff safety - resigned Monday, declaring "the girl who died was like my daughter... as a parent, I am resigning", but was re-appointed as Principal of the Calcutta Medical College and Hospital 24 hours later.

The court, which also asked tough questions of the state's handling of this horrific crime, including keeping the doctor's parents waiting for information and possibly even protecting Dr Ghosh, observed the tragic circumstances of the woman's death did not seem to have much affected him. "The Principal is the guardian of all doctors working there... if he doesn't show any empathy who will show? He should be at home not working anywhere..." a division bench led by Chief Justice TS Sivagnanam said, also wondering how it happens that a government lawyer is arguing for Dr Ghosh. "If the principal stepped down owing 'moral responsibility', (it is) rather serious that he is rewarded, within 12 hours, with another appointment. This Principal will not function... let him go on long leave. Otherwise we pass an order," the court said when told Dr Ghosh had been posted elsewhere.

"Why Do You Protect Him..."

The High Court this morning was hearing a clutch of petitions, including one by the doctor's parents seeking a court-monitored probe into their daughter's death. The parents claimed gross insensitivity in state authorities' handling of the aftermath of the crime, arguing, "We were told at 9.30 pm she was unwell... then (told) she committed suicide. The hospital did not allow me to see my daughter." The parents sought impleading of Dr Ghosh, which turned the court's attention on him. "He was the principal... he cannot shrug off the responsibility and must be impleaded as accused," they argued. "No man is above the law..." the court thundered, "How did he step down and then be rewarded with another responsibility?" The court, which demanded the police's case diary by 2 pm, also directed Dr Ghosh's resignation letter be filed, observing, "... we want to see what he has written."

"Accept Apology, However...": Top Court Relief For Ramdev, And A Warning

New Delhi. Yoga guru Ramdev and his aide Balakrishna today got some relief in a misleading ads case related to Patanjali products after the Supreme Court closed contempt proceedings against them. The court, however, warned them against violating court orders in the future.

The bench of Justice Hima Kohli and Justice Sandeep Mehta said in their order that the court accepts the apology of Ramdev and Balakrishna. "However, we expressly and strictly warn them that they will not do any thing in violation of the court orders like it has happened earlier in this case. We have come down heavily and we warn that this should not be done in future," the order said.

"The affidavits tendered before this court should be done with full truth. We close the contempt proceedings initiated against the party with the warning of



adhering to the orders passed by this court in this case. The notice issued to present contemnor also stands discharge and closed," the court added.

The Supreme Court had come down heavily on the Yoga guru and his aide for misleading ads of Patanjali products.

The matter dates back to the Covid years. Patanjali launched a drug, Coronil, in 2021 and Ramdev described it as the "first evidence-based medicine for

COVID-19". It also claimed that Coronil had certification from WHO. Indian Medical Association disputed this claim, saying it was a "blatant lie".

In a subsequent video, Ramdev was heard saying that allopathy was a "stupid and bankrupt science". The IMA sent a legal notice to him and sought an apology. Patanjali Yogpeeth responded that Ramdev was reading out from a forwarded WhatsApp message and has no ill-will against modern science. Then, in August 2022, IMA moved a petition against Patanjali after it published an advertisement in newspapers titled 'Misconceptions Spread By Allopathy: Save Yourself And The Country From The Misconceptions Spread By Pharma And Medical Industry'. The ad claimed that Patanjali drugs had cured people of diabetes, high blood pressure, thyroid, liver cirrhosis, arthritis and asthma.

Call To Kolkata Doctor's Family Said She Died By Suicide. Police Probe Why

Kolkata. The father of the 31-year-old doctor, who was raped and murdered at Kolkata's RG Kar Medical College and Hospital, got a phone call Friday morning. The caller said his daughter had died by suicide. When he rushed to the hospital, he learnt that his daughter's body was found in the seminar hall, half-clothed and with bruises. The investigation later revealed that the doctor had been raped and murdered.

"The Assistant Superintendent of chest medicine department called and said, 'your daughter died by suicide'. And then we saw the reality when we reached the hospital," the woman's father told the media, adding that the official did not name himself during the call. The father's remarks have triggered allegations that the college administration attempted a cover-up



after the woman doctor's body was found. According to the probe, she had dinner on Thursday night with four other colleagues on night duty. Police are also speaking to them, among others, to get to the bottom of the matter.

Sanjoy Roy, a civic volunteer who frequented the hospital, has been arrested and police said if more

culprits are involved, they would be taken into custody over the next four-five days.

Top Doctors Summoned

The Assistant Superintendent and Head of Department of the Chest Medicine wing of the state-run hospital have been summoned to find out why the woman's family were told she died by suicide. The woman's mother has told the media that even after they reached the hospital, they were not allowed to see the body. "I fell at their feet, begging them to let me see my daughter. But they did not. No one understands what I went through. They let us see her at 2 pm."

The family members have told the media that the victim called her mother that night and told her to have dinner. "We were planning her wedding next year," a relative said.

Delhi Lt Governor's instructions to implement new criminal laws with transparency

Delhi Lieutenant Governor VK Saxena conducted a review meeting on the implementation of three new criminal legislations in the national capital. He instructed the officials to implement the new criminal law with transparency.



New Delhi. Delhi Lieutenant Governor VK Saxena conducted a review meeting on the implementation of three new criminal legislations in the national capital, stressing a collaborative and streamlined approach to ensure justice and transparency across all departments.

Delhi Home Minister Kailash Gahlot attended the meeting, while Law Minister Atishi was absent due to a family medical emergency. LG Saxena instructed officials to set specific timelines for ongoing projects related to the new laws.

The discussions in the meeting included training health department nodal officers for the MedLEaPR portal, with all central government hospitals in Delhi now onboarded with the portal. MedLEaPR is a web-based reporting system to capture the Medico-Legal Report (MLR) and Post-Mortem Report (PMR) for the Directorate of Health Services in Delhi. A total of 186 Delhi government and 32 Central government doctors are registered, generating 81 reports on the portal.

The meeting also covered the procurement of mobile forensic vans, infrastructure for video conferencing in all 691 courts in Delhi, and the filling of 165 junior scientific assistant vacancies at crime scenes, with a target completion date of September 21. Besides, recruitment rules for vacant posts in the Forensic Science Laboratory (FSL) and Directorate of Prosecutions were discussed, along with plans for a new building for the Directorate.

The three legislations — Bharatiya Nyaya Samhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA) — which replaced the colonial-era Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and Indian Evidence Act, have been in effect since July 1.

PM Modi's Pakistani sister all set to tie him rakhi in Delhi this Raksha Bandhan

Qamar Sheikh has been tying 'rakhis' on PM Narendra Modi's wrist for over two decades. This year she is ready to do it for the 30th time.

Ahmedabad. Qamar Sheikh, who has been adorning Prime Minister Narendra Modi's wrist with a 'rakhi' for over two decades, is once again preparing to travel to Delhi to do the same for Raksha Bandhan on Monday, August 19. This will be the 30th consecutive year when

Sheikh will tie a rakhi to the Prime Minister's wrist. Qamar Sheikh was born into a Muslim family in Karachi and was married to Mohsin Sheikh in 1981. Since then, she migrated and settled in India. Sheikh has been in touch with PM Modi for the last 35 years, since 1990.

She considers PM Modi her brother, and he reciprocates the sentiment. Every year for Raksha Bandhan, Sheikh makes rakhi for him with her own hands and the PM gets it tied on his wrist by her 'sister'.

Raksha Bandhan is on Monday, August 19. Naturally, Sheikh has already prepared 8 to 10 Rakhis. She told Aaj Tak she does not buy Rakhis from the market. "I make many Rakhis with my own hands every year before Raksha Bandhan and in the end I tie the Rakhi that I like the most on his wrist," she added. For the 30th year of this ritual, Sheikh said she is preparing something special.

"The rakhi I have prepared this year, I have



made it on velvet. I have used pearls, metal embroideries and tikki in the Rakhi," she noted, adding that her tickets are booked to Delhi for August 19, a day before Raksha Bandhan.

Sheikh highlighted the fact that before the COVID-19 pandemic, she used to personally tie the rakhi on the PM's wrist. That stopped in the years 2020, 2021, and 2022. Owing to the pandemic, she could not travel and fulfil the ritual. Last year, however, she travelled to Delhi with her husband and tied the rakhi. And this year

too, Sheikh hopes for an invitation for the Raksha Bandhan celebrations.

As a sister, she said, she is praying for the good health of her brother. She added that PM Modi will continue the public welfare work he has done for the last decade. She went to meet Singh who was leaving the airport. Narendra Modi was also present there at that time. Singh had then told Narendra Modi that he considered Kamar Sheikh his daughter. Hearing this, PM Modi replied saying that from that onwards Kamar Sheikh would be his sister. "Since then, I have been tying Rakhi to him at the festival of Raksha Bandhan," said Sheikh. Sheikh reminisces how when she first met him, PM Modi was only a worker of the Sangh.

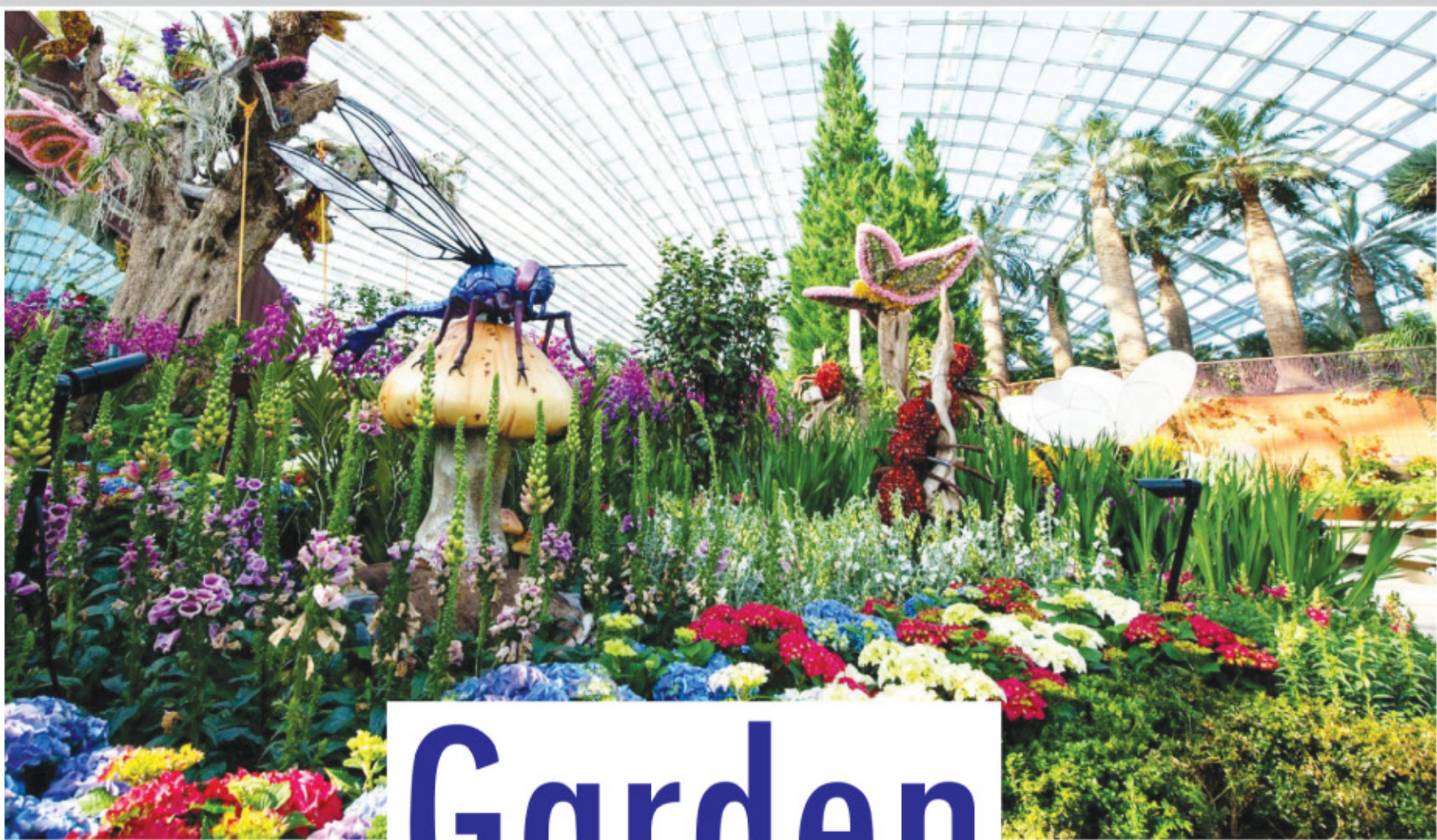

RVNL, Dixon, Vodafone Idea among stocks in focus today. Know why

New Delhi Rail Vikas Nigam Ltd (RVNL), Vodafone Idea, Dixon Technologies, Zydus Lifesciences, Prestige Estates, Oracle Financial Services and Oil India are seven stocks in focus today. While shares of RVNL, Dixon Technologies, Oil India and Oracle Financial Services have gained in early trade, the other three are trading in the red. All the above-mentioned stocks have been added to the MSCI India Domestic Index in the latest rebalancing for August. These changes will be effective after the market close on August 30, 2024.

What do analysts say?

Analysts are predicting that this rebalancing could lead to significant passive inflows into these stocks, potentially bringing up to \$3 billion into the Indian market.


Among the stocks, Dixon Technologies could see the highest passive inflows, with an estimated \$281 million, which would translate to roughly two million shares.

Vodafone Idea is expected to attract \$278 million in inflows, equating to around 1,450 million shares. Oil India and Zydus Lifesciences could also see substantial inflows, with estimates of \$238 million and \$230 million, respectively. RVNL is projected to attract \$219 million in inflows. Prestige Estate Projects and Oracle Financial Services are also expected to benefit, with anticipated inflows of \$181 million and \$170 million, respectively. On the flip side, Bandhan Bank may see outflows of \$170 million due to its exclusion from the index. MSCI also announced the inclusion of eight stocks in the MSCI India Domestic Smallcap Index, such as Bosch, PB Fintech, Phoenix Mills, and others, while 27 stocks have been added to the MSCI ACWI Index globally. The largest additions to the MSCI World Index include companies from Switzerland, Denmark, and Sweden, while the MSCI Emerging Markets Index will see new entries from Brazil, China, and the UAE.

GST Council to meet on Sept 9, to start discussion on rate rationalisation

NEW DELHI. The GST Council, chaired by Union Finance Minister Nirmala Sitharaman, will meet on September 9. "The 54th Meeting of GST Council will be held on 9th September, 2024 at New Delhi," the Council said in a post on X. The GST Council, comprising finance ministers of Centre and states, is the apex decision making body with regard to Goods and Services Tax (GST), which was rolled out on July 1, 2017. The meeting is expected to start discussion on rate rationalisation, reducing tax slabs, besides removing duty inversion under GST. After the previous Council meeting on June 23, Sitharaman had said the next meeting of the GST Council the Group of Ministers (GoM) on rate rationalisation under Bihar Deputy Chief Minister Sumant Chaudhary, will give a presentation on the status of the work and aspects covered by the panel and work pending before the panel. "There will be a presentation by the GoM irrespective of whether the report is draft and then Council will start the discussion on rate rationalisation in the next meeting," Sitharaman had said.

RBI eases capital requirements for housing finance firms by capping risk weights on undisbursed loans



MUMBAI. In a relief to housing finance companies, the Reserve Bank has tweaked the risk weights by capping it for undisbursed loans at par with that of disbursed loans. This is likely to release growth capital that was locked for undisbursed loans and make mortgage loans cheaper. "To address a potential anomaly in the computation of risk-weighted assets for undisbursed amounts of housing loans/other loans vis-a-vis that for an equivalent disbursed amount of similar exposures, it's been decided that the risk-weighted assets computed for undisbursed amounts of housing loans/other loans shall be capped at the risk-weighted asset computed on a notional basis for an equivalent amount of disbursed loans," the RBI said in circular Monday.

At the same time, the regulator segregated risk weights for standard and stressed commercial real estate--residential buildings. The central bank said the risk weight for commercial real estate--residential buildings classified as standard would continue to be 75 percent. For exposures under this category, which are not classified as standard, the risk weight shall be 100 percent. According to industry experts, if the risk capital that an HFC need to maintain against housing loans is reduced, it can increase their ability to lend more. As a result, home loans can become more accessible and affordable for buyers.

Premature deposit withdrawal from NBFCs

MUMBAI: The Reserve Bank has mandated non-banking financial companies (NBFCs) to pay 100% of the deposit amount within the first 3 months of accepting it if the depositor seeks a withdrawal, citing an emergency but without any interest. Issuing the revised regulations governing NBFCs and housing finance companies (HFCs) Monday, RBI said the new norms will be applicable from January 1, 2025. But the depositor will not get any interest if the money on premature withdrawals.

Blinkit expands quick commerce offerings with new categories, services

Blinkit now offers up to 25,000 unique SKUs, including LEGO sets and passport photo delivery in select locations.

BENGALURU. Zomato's quick commerce platform Blinkit, which has been diversifying its offerings, will continue to invest in newer categories. In the past six quarters, Blinkit has launched products in electronics, beauty & make-up, pet care, and toys & games. The platform announced that it will deliver passport-sized photos in 10 minutes for Delhi and Gurugram customers. Albinder Dhindsa, founder and CEO, Blinkit, in a post on X announced "LEGO sets are available on blinkit!" "We have been focused from the beginning to increase selection for customers and offer it in most efficient way to them... we are now

able to offer up to 25,000 unique SKUs (stock keeping units) to our customers in some locations," he said in a letter to shareholders. A large part of this expansion in selection has happened outside traditional grocery segments of FMCG, fruits & vegetables and staples, he added. The CEO said they have been adding SKUs over last four quarters. "Some of our categories have become a major percentage of the platform. As a result, they are now starting to contribute meaningfully to growth number," he said in Q1 earnings conference call. Blinkit aims to raise its dark stores to 2,000 by 2026.

"Our average GOV (gross order value) throughput per store has grown from Rs 6 lakh per day per store when we were at 383 stores a year ago to Rs 10 lakh today when we are at 639 stores. For our top 50 stores today, this number is Rs 18 lakh per day per store and growing," he said. Dhindsa added that their preference



is always to open larger stores. "Our attempt is to make sure that every new store that we open is eventually run by a local partner," he said. Blinkit wants to stick to delivering all assortments in 10 minutes. He said the platform's GOV is made up of incremental growth in consumption. "Our model is able to

New Delhi Gold and crude oil prices have experienced a significant uptick. The precious metal has extended its gains, solidifying its position as a safe-haven asset amidst global economic uncertainties. Simultaneously, crude oil has witnessed a sharp increase, primarily driven by supply concerns and robust global demand. Rising gold prices often reflect investor concerns about inflation and economic instability. Conversely, a soaring oil price can fuel inflationary pressures while also impacting consumer spending and business costs. As these trends unfold, it is crucial to monitor their impact on various sectors and markets.

Prathamesh Mallia, DVP- Research, Non-Agri Commodities and Currencies, Angel One, shared trend insights on gold, base metals and crude prices.

Gold

Gold prices surged over 1% on Monday, reaching their highest level since August 2, as safe-haven demand increased amid global geopolitical tensions and anticipation of key U.S. inflation data. The ongoing conflict between Israeli forces and militants near Gaza, coupled with a

surprise Ukrainian military advance into Russia's Kursk region, has heightened concerns about potential wider regional conflicts involving Iran and its proxies. Investors are closely watching upcoming U.S. producer and consumer price data, which could provide further insights into the Federal Reserve's interest rate trajectory. In this environment, gold is attracting attention as a traditional hedge against geopolitical instability and economic uncertainty, particularly as lower interest rates tend to boost the appeal of non-yielding assets like bullion. Outlook: Gold prices are expected to remain strong, driven by heightened geopolitical tensions and anticipation of key U.S. inflation data that could influence the Federal Reserve's rate decisions.

Crude

Oil prices surged by over 4% on Monday, marking their fifth consecutive day of gains, as escalating tensions in the Middle East raised concerns about potential disruptions to global crude supplies. The U.S. Defense Department's decision to deploy a guided missile submarine to the region underscores the seriousness of the



situation, with fears growing that Iran and Hezbollah might retaliate against Israel, potentially widening the conflict. Such an escalation could lead to U.S. sanctions on Iranian oil exports, threatening to remove approximately 1.5 million barrels per day from the market. Additionally, expectations of U.S. interest rate cuts, driven by signs of cooling inflation, have also supported oil prices, as lower rates typically boost economic activity and energy demand. Investors are also closely monitoring upcoming U.S. consumer price data, which could influence future monetary policy decisions. Meanwhile, stronger-

than-expected consumer price increases in China, the world's largest oil importer, provided further support to crude prices, signalling robust demand in the key Asian market. Outlook: Crude oil prices are expected to remain elevated as geopolitical tensions in the Middle East continue to fuel concerns over potential supply disruptions.

Base Metals

Copper prices rose on Monday as traders covered short positions, anticipating that prices may have reached a bottom ahead of crucial economic data from China and the United States. Last week, recession fears in the U.S. led to a broad selloff in equities and commodities, but stronger-than-expected U.S. jobs data helped stabilise the markets. Traders are now focused on upcoming Chinese data, including new yuan loans, industrial production, and urban investment, as indicators of future demand for industrial metals like copper. Additionally, U.S. consumer price data due on Wednesday could influence the timing of Federal Reserve interest rate cuts, potentially weakening the U.S. dollar and boosting demand for dollar-priced metals.

After Ben Stokes injury, ECB pulls Chris Woakes out of The Hundred



UPDATED The England and Wales Cricket Board (ECB) has pulled all-rounder Chris Woakes out of The Hundred, bearing in mind the upcoming Test series against Sri Lanka. Woakes was set to play for the Birmingham Phoenix in their last two league matches against Manchester Originals and Trent Rockets. On Monday, August 12, the Phoenix announced that Stokes had been made "unavailable for the remainder of the competition". However, the ECB said that withdrawing Woakes was not linked to Ben Stokes' injury. On Sunday, Stokes pulled his hamstring while playing for Northern Superchargers in their match against the Originals. He was trying to take a run when he felt some discomfort on his leg. After getting treated, Stokes was carried off the park.

Later, he was taken off on a stretcher towards an ambulance, but he returned to the dugout later on crutches. Harry Brook, the skipper of the Superchargers, had said that Stokes' injury "doesn't look great". With less than 10 days remaining for England's three-match Test series against Sri Lanka, Stokes is fighting against time to get fit.

Birmingham Phoenix yet to be in playoffs
Woakes missing out could hurt the Phoenix, who are still some distance away from securing their berth in the top three. The Phoenix, however, are on a three-match winning streak, having beaten the Rockets in their previous match. The Brave are currently placed third in the table with 10 points and a net run rate of +0.324 thanks to wins in five out of seven games in the tournament. England's opening Test against Sri Lanka starts on Wednesday, August 21 at the Emirates Old Trafford in Manchester. The iconic Lord's and Kennington Oval will host the other two Tests.

Olympics 2024: Neeraj Chopra saving grace for India in athletics at Paris

New Delhi Expectations were high from India in athletics, since they had sent a contingent of 29 members, their highest ever in the history of the Olympics. Back in 1900, Norman Pritchard brought home two silver medals for British India. But since independence, India hasn't quite made a name for themselves in the world of athletics.

Last year, for the first time, India went past the tally of 100 medals at the Asian Games. Out of them, the athletics team won 29 medals, including six golds, 14 silvers and nine bronze. With the number of participants going up in track and field events, India were expected to do better than previous editions of the Olympics. But the story wasn't any different from the previous editions.

How did India perform in the Paris Olympics? The focus was on Neeraj Chopra, who won the gold medal in Tokyo with a best throw of 87.58 metres. He became the second Indian after Pritchard to win a medal in athletics. He had also joined Abhinav Bindra as one of the two athletes from India to win an individual gold medal at the Olympics. Having won medals in the World Championships and the Diamond League, India's golden boy was again expected to step up. Hence, eyes were on him and his performance at Stade de France. Out of his six throws, five turned out to be fouls, and it was evident that he was not at his very best.

But it needed only a solitary throw of 89.45 metres in his second attempt to put him into a silver-medal winning position. Arshad Nadeem's Olympic record of 92.97 metres turned out to be insurmountable for Neeraj, who is yet to cross the 90-metre mark. Apart from Neeraj, none of the athletes could make a mark. Post independence, India are still looking for their second medalist in athletics apart from Neeraj. They have to wait for four years when the Los Angeles Olympics takes place to determine if India can broaden their horizons in athletics.

Any improvements from the Tokyo Olympics? Back in the Tokyo Olympics, India had a smaller contingent, 16 in track and field events and two relay teams. Apart from Neeraj, only discus thrower Kamalpreet Kaur made an impact after qualifying for the final. She finished in sixth spot with a best throw of 63.70 metres. This time in Paris, keeping aside Neeraj, it was only Avinash Sable who took part in the finals of an event. Sable finished fifth in the heats of the men's 3000-metre steeplechase. In the finals, he finished 11th with a timing of 8:14:18.

Losing to Vinesh Phogat, Japan's Yui Susaki vows to win Olympic gold in LA 2028

Paris Olympics: Yui Susaki was disappointed after she failed to win the gold medal, but vowed to make a strong comeback in Los Angeles four years later.

New Delhi Japan's Yui Susaki pledged to win a gold medal when she returns to take part in the Olympics in Los Angeles to be held in 2028. The Japanese wrestler won the bronze medal in Paris after beating Ukraine's Oksana Livach 10:0 via technical superiority in the third-place playoff match. But she looked a tad disappointed after not being able to finish on top. Susaki went into the women's 50kg category event as a favourite as she had an 82-0 record at the international level. But in the Round of 16, she lost to India's Vinesh Phogat 2-3. After missing out on gold, Susaki vowed to work hard and put in a strong performance when the showpiece event returns four years



later. "I had the honour of winning the bronze medal at the Paris 2024 Olympics! First of all, thank you so much for all your support. It has really helped me out! I wanted to see my family, teammates, and fans who have fought with me for the past three years to win

the gold medal, but I couldn't do it, and I'm so sorry and frustrated that I committed a betrayal," Susaki wrote.

Willing to keep going hard again

After losing to Vinesh, Susaki qualified for the bronze-medal match as the Indian made her way through to the finals. Back in 2021, Susaki bagged the gold medal in the same category, but could not defend her crown in Paris. The 25-year-old said she would look to get rid of the frustration by claiming the top prize in Los Angeles. "Despite the loss, encouraging words from all over the world and worlds that they still believe in me and will continue to support me. I wasn't able to reply, but I read every message, one by one, and I can't measure how much it touched my heart, how much it saved my heart, and how much it made me want to keep moving forward. Thank you so much! As long as there are people who still support me and believe in me, I am strongly willing to keep going hard again to achieve my goal of becoming an Olympic champion," she added. Apart from her success at the Olympics, Susaki also won 13 gold medals at the World Championships, Asian Championships and other tournaments.

Paralympian Pramod Bhagat banned for 18 months for breaching anti-doping regulations

New Delhi Pramod Bhagat will not be a part of the Paris Paralympics 2024 after being found guilty of breaching the Badminton World Federation's (BWF) anti-doping regulations. The BWF confirmed the news on Tuesday, August 13. Back on March 1, the Anti-Doping Division of the Court of Arbitration of Sport (CAS) found the badminton player in breach of the BWF anti-doping regulations for committing three whereabouts failures within 12 months.

Bhagat, who is an SL3 athlete, had appealed to the CAS Appeals Division, but his appeal was turned down on July 29, 2024. The CAS Appeals Division confirmed their decision on March 1. After the Olympics ended on August 11, the Paralympics will take place from August 28 to September 8 with the competition spanning 11 days.

Pramod Bhagat's historic feat

Pramod made history by winning the gold medal in the men's singles SL3 category at the Tokyo 2020 Paralympics. It was the first time an Indian had won a gold medal in badminton at the Paralympics. Born in 1988, Bhagat developed polio at the age of five, leading to a disability affecting his left leg. Despite this, he was drawn to badminton at the age of 13 and



went on to become a professional player. Bhagat's journey to the gold medal was marked by his determination and strategic thinking. He defeated Great Britain's Daniel Bethell, the second seed, in the final with a score of 21-14, 21-17. Throughout the tournament, Bhagat demonstrated his dominance, winning all his matches and only dropping one game against compatriot Manoj Sarkar in his opening match.

The victory not only brought India its fourth gold medal at the Tokyo Paralympics but also marked a significant milestone in Indian para-badminton history. Bhagat's achievement is a testament to his hard work and dedication, and he has become an inspiration for many aspiring athletes.

Manu, in the meantime, became the first Indian woman to win multiple medals in a single edition of the Olympics. She was also a flag-bearer for India in the Closing Ceremony.

As far as Neeraj is concerned, he won the gold medal in Tokyo and hence, expectations were high from him. However, he could not defend his crown after winning silver in Paris. In his second attempt, he threw 89.45 metres behind Pakistan's Arshad Nadeem, who set an Olympic record with a throw of over 92 metres.

Alexei Popyrin ends Australia's 21-year-long wait with Canadian Open win

Canadian Open 2024: Alexei Popyrin beat Andrey Rublev in the final 6-2, 6-4 and became the first Australian man since Lleyton Hewitt in 2003 to win an ATP 1000 title.

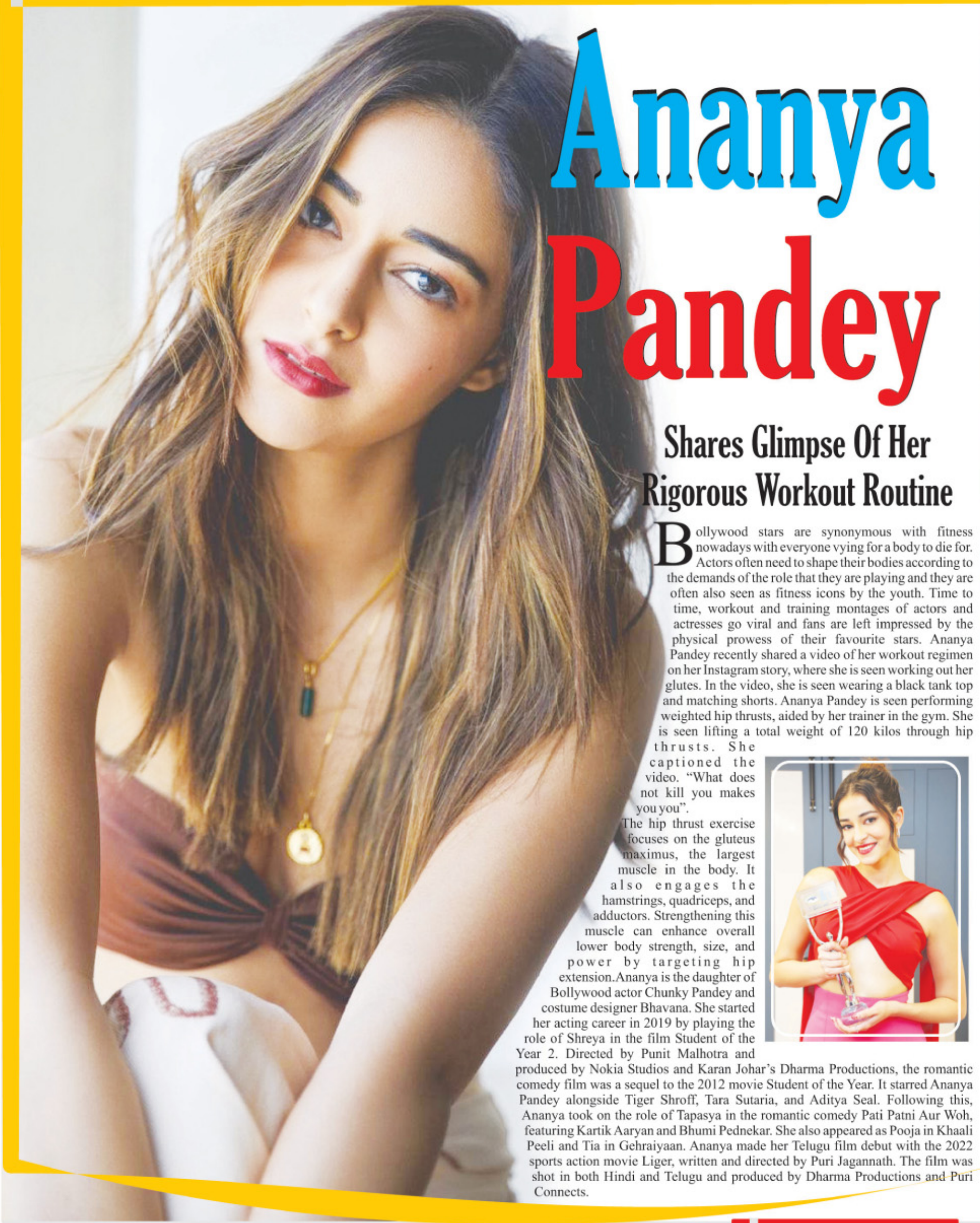

strategy featuring a booming serve and aggressive returns, Popyrin set the tone early by breaking Rublev in the very first game. The match ended 6-2, 6-4 in favor of Popyrin, who kept his composure and never looked back after gaining the initial

advantage. This victory propelled Popyrin to a career-high No. 23 in the ATP Rankings. His dominant game-play, evident in saving all four break points in the first set, showed his tenacity. Even after losing serve in the second set to level scores at 3-all, he rebounded by breaking back immediately, showcasing his resilience. With this win, Popyrin now holds a 2-1 lead in his head-to-head record with Rublev and has maintained an impeccable record in ATP Tour finals. This latest achievement adds to his tournament victories in Singapore in 2021 and Umag in 2023, solidifying his reputation as a player to watch in the coming years.

Keerthy explained that she wasn't entirely sure about the original role offered to her, though she was keen on being part of the film in some capacity. "Nagi offered me another role in the film, which I wasn't sure of. It was a human role, I'm glad I said no to it now," she said. The animated prelude 'Bujji & Bhairava' introduced this futuristic world and its characters, including Deepika Padukone's SU-M80, Kamal Haasan's Supreme Yaskin, and Amitabh Bachchan's Ashwatthama.
