## Mamata Banerjee demands capital punishment for culprits

Kolkata, August 16: West Bengal Chief Minister Mamata Banerjee on Friday accused the opposition CPI(M) and the BJP of orchestrating vandalism at RG Kar hospital and attempting to obscure the truth behind the rape and murder of a woman doctor by spreading fake news on social media. Reiterating her demand for capital punishment for the culprits involved in the crime, Banerjee commended the



Kolkata Police for their investigation, which was later transferred to the CBI by the Calcutta High Court. She also urged the Central Bureau of Investigation to resolve the case by Sunday and demanded that the culprits be hanged. "We want the truth to come out, but some quarters are spreading lies to mislead people. Attempts are being made to hide the truth by circulating fake news on social media. We condemn these activities. We want the culprits to be punished," she said while addressing a rally. Banerjee led a protest rally from Moulali to Dorina Crossing in Kolkata on Friday, demanding justice for the woman doctor who was allegedly raped and murdered at the RG Kar Medical College and Hospital last week. "The nexus between the Left and BJP should be exposed. The CPI(M) and the BJP are behind the vandalism of RG Kar Medical College and Hospital. They vandalised the hospital to destroy evidence of the ghastly crime," she said. The woman post-graduate trainee doctor was allegedly raped and murdered in the seminar room of the state-run health facility on August 9. A civic volunteer has been arrested in connection with the crime. A group of people entered the hospital and vandalised the emergency department, nursing unit and medicine store in the early hours of Thursday. The mob also damaged CCTV cameras at the state-run health facility and ransacked a stage where junior doctors had been demonstrating against the alleged rape and murder of the doctor there and demanding security at their workplace.

## In phone talks with PM Modi, Bangladesh's Yunus assures safety of Hindus

New Delhi, August 16: In his first direct contact with New Delhi after becoming the head of Bangladesh's interim government, Mohammad Yunus on Friday conveyed to Prime Minister Narendra Modi in a phone conversation that Dhaka would prioritise protection and safety of Hindus and all other minority groups. In the talks initiated by Yunus, Modi reaffirmed India's support for a democratic, stable, peaceful and progressive Bangladesh and underlined the importance of ensuring the safety of Hindus and other minority communities in the violence-hit country. The assurance by Yunus came a day after Modi, in his Independence Day speech, said 140 crore Indians are concerned over the safety of Hindus and minorities in the neighbouring country. "Received a telephone call from Professor Muhammad Yunus, @ChiefAdviserGoB. Exchanged views on the prevailing situation," Modi said on X. "Reiterated India's support for a democratic, stable, peaceful and progressive Bangladesh. He assured protection, safety and security of Hindus and all minorities in Bangladesh," he

said. In a statement, the Ministry of External Affairs (MEA) said the two leaders also discussed ways to take the bilateral relationship forward in line with the "respective national priorities". "During the call, the prime minister reaffirmed India's support for a democratic, stable, peaceful and progressive Bangladesh. He emphasised India's commitment to supporting the people of Bangladesh through various development initiatives," it said. "The prime minister also underlined the importance of ensuring the safety and protection of Hindus and all other minority communities in Bangladesh," it said. "Prof Yunus, in turn, assured that the Interim Government would prioritise protection, safety and security of Hindus and all minority groups in Bangladesh," the MEA said. There have been mounting concerns in New Delhi over widespread incidents of attacks on the

minority Hindu community in Bangladesh after Prime Minister Sheikh Hasina resigned and



fled to India on August 5 following weeks of violent unrest. Days after Hasina fled to India, the interim government, headed by Nobel laureate Yunus, was sworn in on August 8, along with 16 advisers. On Tuesday, Yunus reached out to Hindus in Bangladesh as he visited the

Dhakeshwari temple in Dhaka and said his government would punish those who attacked the minority community members. Hasina (76), who ruled Bangladesh with an iron hand for 15 years, resigned as the prime minister following massive protests that initially began as an agitation against a job-quota scheme but weeks later, morphed into a mass movement demanding her ouster from power. In his Independence Day speech from the ramparts of the Red Fort in the national capital, Modi on Thursday said India is committed to peace and that it will remain a well-wisher of Bangladesh in its development journey. "As a neighbouring country, I can understand the concern regarding whatever has happened in Bangladesh. I hope that the situation there will become normal soon," Modi said. "In particular, the concern of 140 crore countrymen is that the safety and security of Hindus and minorities there is ensured. India always wants the neighbouring country to march on the path of peace and prosperity," he said.

## Omar Abdullah welcomes announcement of assembly polls in Jammu and Kashmir

Srinagar, August 16: National Conference vice-president Omar Abdullah on Friday welcomed the Election Commission's (ECI) announcement of a three-phased assembly election in Jammu and Kashmir and said it was better late than never. "Some time back, ECI announced the schedule for assembly elections in J-K. People of J-K were waiting for this day for a long time. It is better late than never," Abdullah told reporters here. The Election Commission said the assembly polls in Jammu and Kashmir would be held in three phases on September 18, 25 and October 1, and the votes will be counted on October 4. The former Jammu and Kashmir chief minister said it is perhaps for the first time after the 1987-88 polls, that the assembly elections in Jammu and Kashmir are being held in a short time and in just few phases. "It obviously will be a new experiment for the political parties. But as far as our party is concerned, NC was prepared for this day and will soon start the electioneering," he added. Abdullah said Chief Election Commissioner Rajiv Kumar has made a thrust on conducting free and fair polls in Jammu and Kashmir and called on the poll body to take notice of the massive transfers in the police and civil administration in the Union Territory in the last 24 hours.

## Haryana to vote on October 1; Jammu and Kashmir election in 3 phases beginning September 18

Srinagar/Jammu, August 16: Political parties cutting across party lines on Friday welcomed the Election Commission's (ECI) announcement of three-phased assembly elections beginning September 18 in Jammu and Kashmir, saying the people were eagerly waiting for the restoration of democracy in the Union Territory after six years of central rule. Almost all the parties, including National Conference, Congress, BJP, CPI(M) and DPAP, thanked the Election Commission and said the poll announcement maintained the supremacy of the Supreme Court which had set the September 30 deadline for the holding of the much awaited assembly elections in J-K. The Election Commission said the assembly polls in J-K would be held in three phases on September 18, 25 and October 1. The counting of votes would be on October 4. Reacting to the ECI announcement, National Conference vice-president and former chief minister Omar Abdullah said it was better late than never. The former chief minister

said it is perhaps for the first time after the 1987-88 polls, that the assembly elections in Jammu and Kashmir are being held in a short time and in just a few phases. "It obviously will be a new experiment for the political



cal parties. But as far as our party is concerned, NC was prepared for this day and will soon start the electioneering," he added. "Better late than never," senior vice-president of Pradesh Congress Committee

Ravinder Sharma said, reacting to the announcement by the chief election commissioner Rajiv Kumar. He said the people in J-K were waiting for the assembly elections for the past six years after the fall of PDP-BJP government in June 2018. "Though we were pressing for restoration of full statehood before the holding of assembly elections, the announcement by the Election Commission is a welcome step and we are hopeful that the commission will ensure level playing field and adequate security without any discrimination," Sharma, who is also the chief spokesperson of the Congress, said. He also hoped that ECI would look into the massive reshuffle in police and civil administration ordered in the Union Territory on the day of the announcement of polls. "There should be no unnecessary transfers and if such a thing had happened, the Election Commission should take appropriate action," the Congress leader said.

## Decide CM face of MVA first; will back any candidate announced by Congress, NCP (SP): Uddhav Thackeray

Mumbai, August 16: Shiv Sena (UBT) chief Uddhav Thackeray on Friday insisted on deciding MVA's chief ministerial face first rather than going by the logic of who wins most seats, asserting that he would back any candidate announced by the Congress and NCP (SP). Addressing party workers of the opposition bloc Maha Vikas Aghadi (MVA) here, Thackeray said if the Lok Sabha polls were to protect democracy and the Constitution, then the Assembly polls are a fight to preserve Maharashtra's self-respect. Maharashtra Assembly elections are likely to be held in October or November. The MVA comprises the Sena (UBT), Sharad Pawar-led NCP (SP) and Congress. He insisted that the chief ministerial candidate must be decided first, rather than by the logic of the party that wins the most seats in the elections. Thackeray said the experience he had

during his alliance with the BJP was that whoever had the numbers would get the CM's post. But this policy was detrimental as this would lead to one party trying to defeat the other's candidate to maintain an upper hand in the alliance, he said.



"First, decide (the CM's face) and then go ahead, but do not go by this policy (those having the most seats will get the CM's post)," Thackeray said. "Uddhav Thackeray will back any candidate announced by Congress and NCP (SP) as the CM face of MVA. I don't have the feel-

ing that I am fighting for myself but it is for the rights of Maharashtra," Thackeray said. Thackeray asked the MVA cadres to rise above self-interest and fight for the sake of protecting Maharashtra's pride and interest. He also urged them to be the ambassadors of the opposition alliance in the state. On Prime Minister Narendra Modi's pitch for a secular civil code in the country, Thackeray wondered if he had given up Hindutva. During his Independence Day speech, Modi had said, "I would say, it is the need of the hour that India should have a secular civil code. We have lived 75 years with a communal civil code. Now, we have to move towards a secular civil code. Only then would religion-based discrimination end. It would also end the disconnect the common people feel." The PM noted that the Supreme Court has given various directions in this regard. The spirit of the Constitution also encourages such a code, he said, referring to Article 44 under the Directive Principles of State Policy.

## Third developmental flight of SSLV is 100 per cent success: ISRO Chairman

Sriharikota, August 16: ISRO on Friday successfully launched an Earth Observation Satellite (EOS-08) on board a small satellite launch vehicle, giving a boost to India's space programme. The third developmental flight carrying Earth Observation Satellite (EOS-08) along with a passenger satellite SR-0 DEMOSAT was successfully placed into the intended orbit as planned. "The third developmental flight LV-D3 with EOS-08 satellite has been successfully accomplished. The rocket has placed the spacecraft in the very precise orbit as planned. There are no deviations in the injection of satellites," ISRO Chairman Somanath said, addressing the gathering from the Mission Control Centre at this spaceport here. He said the launch parameters of the satellite indicate that everything (mission launch) is perfect and the Earth Observation Satellite and the passenger satellite SR-0

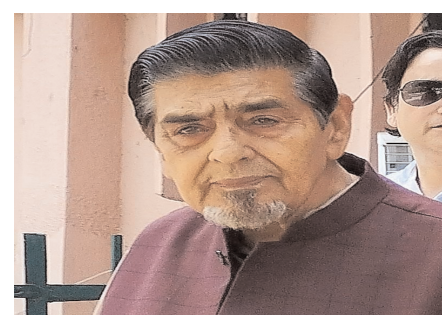
tal flight of LV has been completed," he said. "We are in the process of transferring LV technologies to industries and so it is a very good beginning for the LV and the launch vehicle," he said. The payload

carried by the rocket has been designed and realised by the ISRO team, he said. "It is 100 per cent successful. The satellite has been placed into its intended orbit," Somanath told reporters later. "As I am aware, solar panels (of the rocket) have already been deployed. Further, we are looking for certain activities in the VTM stage and all that will be completed in due course of time. So congratulations once again to the entire team who worked behind the scene to develop this LV rocket and its culmination of developmental programme. Let us give a big round of applause to the entire (SSLV-D3) team," he said. Mission Director S S Vinod said, "Today, we have achieved a major milestone in the journey of LV. The last and final developmental flight of LV-D3 has been successfully accomplished and with that we are moving into the operational phase." He said the scientists have injected the EOS satellite and the passenger satellite into the precise orbit. "The efforts put in by one and all has resulted

in this achievement. Let me take this opportunity to thank the people who were behind this. Especially the management who had the confidence and trust in us to handover the development of a new launch vehicle to a new team which was able to achieve the targeted launch of D1, D2 and D3 within a short time frame.

## Anti-Sikh riots case: Delhi court likely to pass order on framing charges against Jagdish Tytler on August 30

New Delhi, August 16: A Delhi court is likely to pass on August 30 an order on whether to frame the charges against Congress leader Jagdish Tytler in a case related to the killing of three people at Pul Bangash during the 1984-anti Sikh riots. Special CBI judge Rakesh Sibal on Friday reserved the order after getting some clarifications from the parties. "There are no further clarifications required. I am



reserving the order for August 30," the judge said. In its charge-sheet filed in May 2023, the CBI had accused Tytler, a former union minister, of "inciting, instigating and provoking the mob" which had assembled near the Pul Bangash gurdwara on November 1, 1984. Citing a witness, it claimed, Tytler alighted from a white ambassador car in front of the gurdwara and instigated the mob, shouting "Kill the Sikhs, they have killed our mother!" Three people were then done to death by the mob that was enraged over the assassination of Prime Minister Indira Gandhi by her Sikh bodyguards a day before. A sessions court had in August last year granted anticipatory bail to Tytler in the case on a personal bond of Rs 1 lakh and surety of the like amount. The Central probe agency has invoked charges under Sections 147 (rioting), 109 (abetment) read with 302 (murder) of the Indian Penal Code (IPC), among others, against Tytler.

## Top printer files cybercrime complaint in Hyderabad

HPSL manager Ramesh Philip said that the email was sent in the name of National Institute of Open Schooling (NIOS) and contained an attachment informing that HPSL has been blacklisted.

**HYDERABAD.** Hitech Print Systems Limited (HPSL), an RBI-approved printer, has filed a complaint with the cybercrime police that an email from an unknown ID that it has been blacklisted was sent to its clients.

Given that HPSL's clients include universities, banks and government departments, and it is known for handling sensitive documents such as question papers, the incident has been taken seriously.

HPSL manager Ramesh Philip said that the email was sent in the name of National Institute of Open Schooling (NIOS) and contained an attachment informing that HPSL has been blacklisted.

Philip said that the sender's email was anticorruptionofindia@proton.me and NIOS confirmed that they haven't sent any such email. "Circulating such false letters with criminal intention in mail will cause immense loss to us and also make us ineligible to participate in any tenders and will tarnish the image of the company," the complaint said.

A complaint is registered with the Cybercrime police of Hyderabad Commissionerate under Sections 66-C, 66-D ITA-2000-2008 and is being probed.

## Four-year-old dies of rabies after stray-dog attack in Tamil Nadu

First rabies case from Ranipet in 2024; official says close proximity of wound to brain may have caused boy's death

**RANIPET.** The death of a four-year-old boy on Tuesday – 17 days after a stray dog bit him – has been confirmed as a result of rabies, making it the first reported case of rabies from Ranipet district this year, according to official sources. The stray dog was killed on July 27, the day of the incident, after the villagers allegedly pelted stones at the animal. The boy, Nirmal (4), was the son of B Kalaivani and Balaji, an autorickshaw driver from Gandhipuram in Arakkonam Taluk. Nirmal had a sister Jenitha. On July 27 evening, while Nirmal was playing outside, he was attacked by the stray dog and suffered injuries to his mouth. "I had just gone inside the house to get some water. When I returned, I saw him with injuries in his mouth. He was bleeding profusely," said Balaji. The parents rushed Nirmal to the Government Head Quarters Hospital in Kancheepuram, where the doctors



administered a four-dose rabies vaccine. Upon the doctor's recommendation, Nirmal was shifted to Chengalpattu Government Hospital for plastic surgery. He was provided intensive care for 15 days in Chengalpattu. After his condition stabilised, his parents brought Nirmal back to their home. "But soon after, he started showing symptoms like shouting and crying," his father added. Again, Nirmal was taken to the

Chengalpattu GH, where the doctors informed the parents the rabies virus has infected his nervous system and that he might die within two days. Balaji said, "His condition was critical. His body also began to swell." On Tuesday, Nirmal succumbed to the viral infection. Following his parents' request, the body was cremated in their village with proper safety measures. The dean of Chengalpattu GH and senior health department officials could not be reached for a comment. Ranipet district deputy director of health services T Senthil Kumar said the boy received all four doses of the vaccine as he was treated in the medical college hospital. "The death could be due to the wound being in close proximity with the brain; in such cases it affects the brain faster. The dog that bit Nirmal attacked an 11-year-old boy and his father. The duo, after medical examination, is safe at the moment."

Municipal corporation officials said they have taken precautionary measures and removed all the stray dogs from the area.

Immediately wash the wound with soap and get rabies vaccine shots

Bleeding at the wound site indicates potentially severe exposure. So, rabies immunoglobulin should be administered near the wound along with the vaccine on the day of the first visit or within seven days from the date of the first vaccine dose

Four doses should be administered on the day of the dog bite, followed by third, seventh and 28th day

If a hospital refuses to administer the vaccine immediately after the dog bite, a complaint can be registered by calling 104

## Technically, health of ITIs in Telangana unsound

The state government allocated Rs 708 lakh to the Employment and Training Department for the FY 2024-25. This was less than the revised estimate of Rs 724 lakh in FY 2023-24.

**HYDERABAD.** Going by the condition of the Industrial Training Institute (ITI) at Mallepally, the state government has its task cut out when it comes to implementing its plans to upgrade the ITIs in the state to Advanced Technology Centres (ATCs) with the aim of providing skill development with advanced technologies.

The ITI at Mallepally, the oldest in Telangana, is the same ITI where the chief minister laid the foundation stone for the construction of an ATC in June. Such a construction, however, would exacerbate the issue of space and resources such as security and attendants.

A visit by TNIE to the site revealed that the Mallepally campus, already congested with five ITIs—Mallepally, Shantinagar, Vijaynagar, Khairatabad, and Sanathnagar—will now have to accommodate five new ATCs. The Department of Employment and Training (DET) website lists eight government ITIs in the city, but Vijaynagar, Khairatabad, Mallepally and Shantinagar ITIs all share the same address.

The Department of Employment and Training (DET) has listed eight government ITIs in the area, but Vijay Nagar, Khairatabad, Mallepally, and Shanti Nagar ITIs all share the same address, further straining the campus. Found that two trade sheds of the Mallepally ITI have been demolished to construct the Khairatabad and Shantinagar ATCs. Although the trade of Book Binding was scrapped to make way for the new construction, the trade of

Foundryman has yet to receive replacement facilities and a shed of its own. Established in 1957, the Mallepally ITI currently offers 21 trades with 37 units, accommodating over 700 students. However, several workshops, including Turner, Fitter, Machinist, and CNC, urgently require new machinery, as the existing equipment has been in use for decades.

Mallepally ITI principal P Jyothi Rani told TNIE: "As of now construction work on four ATCs is underway and it will start



soon for the Mallepally ATC."

She welcomed the government's decision to upgrade the ITIs saying that new trades would be useful in skill enhancements of students. "However, the government needs to upgrade the machinery in some of the workshops as some of the machines are over 60 years old," Jyothi Rani said.

Faculty members pointed out that while the syllabus has changed over the years, the same machines have been put to use for practical training in the workshops.

In addition, the ITI also faces a severe

shortage of attendants and security. They said that while at least 22 personnel are required, only six people are available.

Recently, the Sanathnagar ITI which was earlier located in Czech Colony, was also moved to the Mallepally campus due to nonavailability of land, the officials said.

Sanathnagar ITI principal R Srinivasa Rao told TNIE: "The ITI was moved to the Mallepally campus as there seemed to be some issue related to space for the building. We have been provided a separate facility in the Mallepally campus near Nice Hospital for workshops and classes. Our ITI has nine trades and 15 units with an intake of 224 students."

Shockingly, the Khairatabad ITI, which will also have a dedicated ATC, still does not have a building of its own since its inception in 2014. The ITI has been under the umbrella of the Mallepally ITI campus all these years. The Khairatabad ITI is now sharing space with the Sanathnagar ITI, with the uncertainty over a dedicated facility of its own continuing to loom over it. Khairatabad ITI principal K Vema Reddy said: "The Khairatabad ITI has three trades and six units with an intake of 64 students. At present we are accommodated with the Sanathnagar ITI facility and discussions are underway to provide a separate facility for us."

In fact, the Budget estimate for FY 2023-24 had sanctioned Rs 680 lakh, but it was raised to Rs 724 lakh in the revised estimate.

## Three property owners lauded for paying taxes on time



**CHENNAI.** The city corporation issued letters of appreciation to three property owners, one from each region, for ensuring that their property taxes were paid without any delay, on the occasion of Independence Day. One among them is 78-year-old Lalitha, who with her family packages loose spices for a daily wage.

Lalitha, a resident of George Town, lives with her son Ramprakash, daughter Jayarani and three grandchildren. In their 500 sq.ft house, they package loose spices for a daily wage of Rs 200 per person.

"My mother has been doing this work for the past many years. She does not like taking loans mainly because she doesn't want to give anyone the chance to walk into our house and demand their money back. It is for the same reason that the property taxes are paid on time, she doesn't want anyone to come asking," said Ramprakash.

A Karthikeyan of Vadapalani and M Sambath of Pallikarai were also issued letters of appreciation for paying taxes on time. ## Suspended Mysuru constable listed for CM's medal sparks controversy

Allegations of collusion with criminals led to Salim Pasha's suspension a month ago, yet his name appeared on the award list.



**MYSURU.** Call it an oversight or negligence of authorities, a head constable who was suspended a month back amid allegations of colluding with anti-social elements, appeared on the list of recipients for the prestigious Chief Minister's Medal.

The Chief Minister medal, an honour typically reserved for officials with exemplary service records, has now been mired in controversy following this incident. Salim Pasha, who was part of the City Crime Branch (CCB) unit in Mysuru, was suspended a month ago amid

serious allegations of misconduct. The accusations against him are far from trivial. Pasha is alleged to have colluded with criminal elements, indirectly facilitated the theft of public property, and contact with the criminal elements. On July 12, based on a report from the ACP of Vijayanagar sub division, the city police commissioner's officer ordered his suspension until pending departmental enquiry.

Despite these charges, his name was somehow included among those being recognised with the

Chief Minister's Medal, a list which was released on Wednesday, raising eyebrows and sparking outrage within the department.

According to sources, Pasha maintained suspiciously close ties with relatives of the accused in these cases and the CDR report even proved it, which ultimately led senior officials to recommend his suspension. The incident has cast a shadow over the award, with many within the police department and the public questioning how such a glaring mistake could occur. The

situation has left the police and even authorities undermining the integrity of the awards process. Though police are tight-lipped about the incident and are unavailable for calls, sources revealed that a special committee meticulously reviews the service performance of candidates before recommending names to the government, however his name might be nominated before the suspension but it could have been reviewed again, said an official, on condition of anonymity.

## All of BDA's flats priced over one crore sold out in Chandra Layout

**BENGALURU.** Within one year of commencement of sale, all 120 3BHK flats of the Bangalore Development Authority (BDA), the priciest ones to date priced at over Rs one crore, have been sold out.

Billed 'Nagarbhavi Flats', its prime location at the entrance of Chandra Layout in Nagarbhavi and proximity to the metro network and the outer ring road are cited as the key reasons for the demand.

A top official told TNIE, "We made the sale of the last flat on Saturday (August 10). This is the first time in our history that we are selling flats above Rs one crore. The response has been terrific. More than 20 of the 120 flats have been



purchased by judges and advocates." The flats are located in one ten-floored tower with 12 flats on each floor. The Rs 54.75-crore project was completed in August 2023

and the sale of flats began immediately.

"With the Nayandahalli Metro station just one km away and the outer ring road in its vicinity, connectivity serves as its biggest plus point. Three parks nearby and the Durga Parameshwari temple too proved to be big draws," he said.

Amenities like an in-house gym and roads within the apartment are offered. The base price for the flat is Rs 1.04 crore with an additional Rs 2.5 lakh charged for car parking. "This base price applies to flats up to the fifth floor. Beyond that, flats are levied an additional fee for the view of the City it offers."

## Firm flouted norms to bag waste collection contract in Gurgaon's Bandhwari: Plea to MCG

GURGAON. A private agency has submitted a complaint to the MCG commissioner alleging discrepancies in the information provided by another firm that was awarded the contract for secondary waste collection and its transportation to Bandhwari. The complaint comes days after reports of three allegedly related private firms participating in a sanitation tender in Manesar in violation of the norms. According to the complainant, the agency that was awarded the contract earlier this week and another bidder are allegedly owned by family members sharing common ownership and interests, with both companies based in Sonipat. The complainant further alleged that the firm awarded the tender doesn't meet the criteria of having completed at least one project worth Rs 1.5 crore. MCG commissioner Narhari Singh Banger flagged off the vehicles of the agency that secured the contract on Wednesday. "Both the agencies are operated by the same person as the same mobile number is mentioned in their letterheads," the complaint, which was filed on Wednesday, stated. Moreover, a check of the documents submitted by both agencies (copies of which are with TOI) revealed that the owner of one of the firms has been granted power of attorney for the other. The complainant also claimed the agency applied for contracts for two zones, but MCG awarded it the contract for all four zones. When approached by TOI, commissioner Banger said: "I'll ask the chief engineer to look into the facts of the matter and proceed accordingly." A senior MCG official, meanwhile, dismissed the allegations. "All eight agencies that participated in the bidding process met the technical requirements outlined in the tender. The contract was ultimately awarded to the firm that submitted the lowest bid. As stewards of public funds, it is crucial to allocate resources wisely and responsibly. Awarding the contract to a firm with higher rates would be an imprudent use of taxpayers' money," the official said. The official added, "The tender requirements do not stipulate that the winning agency must have completed a single solid waste management project valued at Rs 1.5 crore. This criterion can be satisfied through the completion of multiple smaller-scale projects."

## Rain streak to continue for 1 more week in Gurgaon, IMD issues yellow alert

GURGAON. The city experienced a humid day with sporadic rain (5.5mm) on Thursday. India Meteorological Department (IMD) has issued a yellow alert for one more week. The minimum temperature escalated to 27.7 degrees Celsius from Wednesday's 25 degrees. A blanket of dark clouds covered the sky during mid day and the city witnessed light drizzle, bringing the daytime temperature 1.5 notches below normal. It was recorded at 32.4 degrees Celsius on Thursday, a dip from Wednesday's 33.4 degrees. IMD has predicted more spells of moderate to heavy showers over the next few days. The maximum temperature is likely to be around 27 and 28 degrees Celsius, and the minimum around 25 degrees till Aug 16, hinting at the likelihood of heavy rainfall at isolated and scattered



locations throughout Haryana. "Moderate to heavy rainfall over southern parts of Haryana is likely for Aug 21. Active monsoon conditions will continue over Punjab, Haryana, and Chandigarh during the next five days," an IMD official said. The heavy downpour is likely to cause waterlogging in several low-lying areas of the city, causing inconvenience to the commuters. By evening, several areas in Delhi too were hit by intense rainfall. On Thursday, the maximum temperature dropped slightly at 34 degrees Celsius, the season's normal, against 35.4 degrees Celsius a day earlier. The minimum temperature was 27.2 degrees Celsius, two notches below normal, against 26.6 degrees a day earlier.

## Woman's body found at plot near Gurgaon's Ghamroj toll plaza

GURGAON. A 21-year-old woman, who arrived in the city last week to meet a friend, was found murdered in Bhandsi. Her decomposed body was found on Aug 12 at a plot near the Ghamroj toll plaza. The woman's identity was confirmed when her family recognised a tattoo on her hand. A murder case was registered on Wednesday. The woman, Kasuma alias Muskan was from Sudamanagar in UP's Firozabad. On Aug 8, she came to meet her female friend at Goverdhan Kunj in Bhandsi. She told her mother that with the help of her friend, she would look for a job in the city. On the night of Aug 10, Kusuma left her friend's place to return to Firozabad, but she did not make it to home. "The body was in a highly decomposed condition," said DCP (south) Siddhant Jain. "The death was due to blunt force trauma to the head. There were no other injuries or sexual assault," said a forensic medicine expert.

A preliminary probe revealed that Kusuma was in a relationship with Raja Yadav. Call Details Record (CDR) analysis of the woman also confirmed that she remained in contact with the offender and his presence in the city on Aug 10. "Raja is in Firozabad prison involving another case. We will take him into custody on a production warrant and question him further about the crime," said a senior police officer.

# Political maneuvering through patriotism: BJP leader Naveen Goyal's Tiranga Yatra in Gurgaon showcases his strength

GURGAON. In a display of political influence, BJP leader Naveen Goyal organised a grand "Tiranga Yatra" in Gurugram, where thousands of people participated in a patriotic bike rally. ## 9 years of wait ends, woman (44) with scar ectopic pregnancy gives birth to baby girl

GURGAON: After 9 years of attempts to conceive and losing a baby to a birth defect, a 44-year-old woman with a high risk of ectopic pregnancy gave birth to a healthy child after doctors treated her rare condition with a robotic surgery. Doctors at CK Birla Hospital in the city said it was the first time that a robotic surgery was used to treat such a condition in India. The patient, a homemaker from Bihar, approached them in August 2023, they said. "The patient had a history of unsuccessful naturally conceived pregnancies. In 2014, she underwent a caesarean section procedure but lost her baby to spina bifida, a birth defect in which the foetus does not fully develop a spine," said Dr Aruna Kalra, director of obstetrics and gynaecology at CK Birla Hospital. The patient, in June 2023, tried getting pregnant through in-vitro fertilisation (IVF), but that ended in an ectopic pregnancy at the site of the scar where her 2014 caesarean section was carried out. In scar ectopic pregnancies, the embryo implants within the scar tissue, instead of the uterine cavity, leading to an abnormal pregnancy. These are particularly rare, arising in 1% of all ectopic pregnancies, and in one of 1,500-2,000 pregnancies. The condition, doctors say, is life-threatening. Scar pregnancies can cause uterine rupture, haemorrhage and other complications. Doctors said the patient was traumatised from her previous baby's death in-utero, followed by the unsuccessful IVF pregnancy. She was determined to have a child of her own and was seeking an experienced empathetic gynaecologist who would understand her, doctors said. "Moreover, she had healthy embryos preserved in a bank. Upon finding a gynaecologist experienced in high-risk pregnancies, she took a leap of faith holding the hands of healers and scientific advancements. Aware of the risk of another ectopic pregnancy, we decided to try a robotic-assisted surgical approach," Dr Kalra said. The woman underwent the surgery in August 2023. In the minimally-invasive procedure, a robot was used to suture the site of the scar from the previous caesarean section. "The surgery was a success. There was no blood loss, tissue injury or complications, and the patient was discharged on the same day. The robustness of the stitching was such that the patient could become pregnant three months after the surgery," Dr Kalra added. In Nov 2023, the woman opted for IVF. She delivered a baby girl through caesarean section in July 2024. "This was a rare case of scar pregnancy. Because we repaired the scar robotically, it became rather simple to deliver the baby this time," Dr Kalra said. She pointed out that though scar pregnancies are rare, their incidence is increasing as more and more people are opting to give birth through caesarean section.

### Lawyer (38) collapses during visit to friend's flat, dies of heart attack in Gurgaon

GURGAON: A 38-year-old advocate working for a private law firm in the city was declared dead at a hospital after he collapsed at a friend's flat in Essel Towers on MG Road on Monday evening. Police said the death appears to be due to health reasons, possibly a heart attack, but an autopsy report is awaited. His family reached Gurgaon from their hometown in Ranchi on Tuesday evening. A case has not been registered so far. Cops said the advocate joined the law firm around four months back. He went to meet his friend, who is also a colleague in the same firm, at her house in Essel Tower's Pilot Court on Sunday. An RWA representative said the friend lives in a condominium with three other women. "Four women stay in the flat and the advocate was visiting one of them. According to security personnel, an ambulance came and took him to the hospital at around 7pm on Monday," the RWA representative said. Cops said the advocate collapsed while he was sitting with his friend and some others. "He was rushed to a nearby private hospital by the people in the flat in an ambulance, and he was declared dead by doctors," Rishi Kant,

Vaccine group Gavi says it has up to \$500 million to immunise for Mpox in Africa

**London** The global vaccine group Gavi has up to \$500 million to spend on getting shots to countries affected by an escalating mpox outbreak in Africa, its chief executive Sania Nishtar told Reuters. Gavi helps countries with fewer resources buy and deploy vaccines, usually against childhood diseases like measles, but it expanded into broader efforts during the Covid-19 pandemic. The money is available in the organization's "First Response" fund, which was set up after global health agencies like Gavi were left behind by high-income countries in procuring vaccines during the early days of Covid-19. It can be used to respond to health emergencies, which were declared by the World Health Organisation and the Africa Centres for Disease Control and Prevention (CDC) this week. The funds are largely left over from money donated by governments and global health funders for the Covid-19 response. "The money for the vaccines is ready to be tapped into," said Nishtar, but there were hurdles to clear, including official requests for vaccines from affected countries, as well as approvals of the vaccines from the World Health Organisation, which declared mpox a global health emergency on Wednesday.

Gavi and Unicef, which work together to buy vaccines, cannot do so without WHO approving them. On Wednesday, the global health agency said it was hoping to finalise its evaluation of the vaccines by September. Nishtar said Gavi was also in early talks with the manufacturers of the two mpox vaccines that are widely used, made by Bavarian Nordic (BAVA.CO), and KM Biologics. Official orders can only proceed after approval, she said.

Monsoon brides': Extreme weather fuels Pakistan child marriages

**DADU.** As monsoon rains were about to break over Pakistan, 14-year-old Shamila and her 13-year-old sister Amina were married off in exchange for money, a decision their parents made to help the family survive the threat of floods. I was happy to hear I was getting married... I thought my life would become easier," Shamila told AFP after her wedding to a man twice her age in hope of a more prosperous life. "But I have nothing more. And with the rain, I fear I will have even less, if that is possible." Pakistan's high rate of marriages for underage girls had been inching lower in recent years, but after unprecedented floods in 2022, rights workers warn such weddings are now on the rise due to climate-driven economic insecurity.

The summer monsoon between July and September is vital for the livelihoods of millions of farmers and food security, but scientists say climate change is making them heavier and longer, raising the risk of landslides, floods and long-term crop damage. Many villages in the agricultural belt of Sindh have not recovered from the 2022 floods, which plunged a third of the country underwater, displaced millions and ruined harvests. "This has led to a new trend of 'monsoon brides'," said Mashooque Birhmani, the founder of the NGO Sujag Sansar, which works with religious scholars to combat child marriage. "Families will find any means of survival. The first and most obvious way is to give their daughters away in marriage in exchange for money."

Birhmani said since the 2022 floods, child marriage has spiked in villages in Dadu district, one of the worst-hit areas that for months resembled a lake.

US unemployment benefits applications decline for second week

**World** Initial applications for US unemployment benefits fell for a second week to the lowest level since early July, despite a recent pullback in hiring. Initial claims decreased by 7,000 to 227,000 in the week ended Aug. 10, according to Labor Department data released Thursday. The median forecast in a Bloomberg survey of economists called for 235,000 applications.

Economists and investors are on the watch for signs that the labor market may be weakening faster than anticipated after the July employment report showed the jobless rate rose for a fourth month and hiring slowed. First-time applications for unemployment benefits have trended up this year but remain subdued near 2019 levels. Continuing claims, a proxy for the number of people receiving unemployment benefits, also declined, to 1.86 million, in the week ended Aug. 3. A separate report from the Commerce Department Thursday showed that US retail sales accelerated in July by the most since early 2023 in a broad advance. Sales were boosted by a sharp snapback in car sales after a cyberattack on auto dealerships earlier this year, but electronics and appliances also posted gains, pointing to a consumer that's holding up despite higher borrowing costs.

Treasury yields and stock-index spiked after the reports. The moderation in the job market, alongside recent improvement in inflation, reinforces the case for the Federal Reserve to lower interest rates next month during its September policy meeting.

**Washington,** Republican US presidential candidate Donald Trump said on Thursday he told Israeli Prime Minister Benjamin Netanyahu during their last meeting in July to quickly end Israel's war in Gaza, but the former president also criticised ceasefire demands. "He knows what he's doing, I did encourage him to get this over with," Trump told reporters at a press conference on Thursday. "It has to get over with fast. ... Get your victory and get it over with. It has to stop, the killing has to stop." Trump was referring to his meeting with Netanyahu at his Mar-a-Lago residence in late July, when Netanyahu visited the United States. He also met President Joe Biden and Vice President and Democratic presidential candidate Kamala Harris during his trip. There has been an increased risk of a broader war in the Middle East after the recent killings of Palestinian Islamist group Hamas' leader Ismail Haniyeh in Iran and Hezbollah military commander Fuad Shukr in Beirut. Both drew threats of retaliation against Israel. In an event later on Thursday about

tackling antisemitism, Trump criticised Biden and Harris' months-long calls for a ceasefire in Gaza. "From the start, Harris has worked to tie Israel's hand behind its back, demanding an immediate ceasefire, always demanding ceasefire," Trump said, adding it "would only give Hamas time to regroup and launch a new October 7 style attack." Trump added: "I will give Israel the support that it needs to win but I do want them to win fast." In the same event, Trump also labelled pro-Palestinian supporters calling for an end to US support for Israel's war as "pro-Hamas thugs" and "jihad sympathisers." He threatened to arrest and deport them from the US if he became president. Netanyahu's office and Trump both separately denied on Thursday an Axios report that said they had spoken the previous day about Gaza ceasefire and hostage release talks. Biden laid out a three-phase ceasefire proposal in



an address on May 31. Washington and regional mediators have since tried arranging the Gaza ceasefire-for-hostages deal but have run into repeated obstacles. The Axios report cited two US sources. One source said the reported call was intended to encourage Netanyahu to take the deal, but stressed he did not know if this is indeed

what the former president told Netanyahu.

Egypt, the United States and Qatar have scheduled a new round of Gaza ceasefire negotiations this week. Washington, Israel's most important ally, has said that a ceasefire in Gaza will reduce the rising threat of a wider war. The latest bloodshed in the decades-old Israeli-Palestinian conflict was triggered on October 7 when Hamas attacked Israel, killing 1,200 and taking about 250 hostages, according to Israeli tallies. Israel's subsequent assault on the Hamas-governed enclave has since killed over 40,000 Palestinians, according to the local health ministry, while also displacing nearly the entire population of 2.3 million, causing a hunger crisis and leading to genocide allegations at the World Court that Israel denies.

Kamala Harris will be 'one hell of a President': Joe Biden at 1st joint event

**World** Vice President Kamala Harris and President Joe Biden held their first joint event since Biden exited the 2024 presidential race and supported her to take his place as a Democratic nominee. Appearing at Prince George's County Community College, Biden hailed Harris, stating that she will become "one hell of a president," ABC News reported. The event came as Republican candidate Donald Trump addressed a press conference in New Jersey — his second campaign event in the last two days. On Thursday, Democrats gathered to celebrate a significant milestone for the Biden administration: a newly announced agreement aimed at reducing the cost of 10 widely used prescription drugs. This move is expected to provide financial relief to millions of Americans, addressing one of the nation's most pressing healthcare challenges. The White House stated that nearly 2,300 people attended Thursday's event in Upper



Marlboro, Maryland. During the event, President Biden boosted his vice president, bringing the crowd to their feet several times. The feeling was mutual. "There's a lot of love in this room for our president," Harris stated, adding that "few leaders in our nation have done more on so many issues, including expanding access to affordable healthcare, than Joe Biden." Earlier, the White House announced that Medicare has secured agreements with drug manufacturers to lower prices for all 10 drugs chosen in the

first round of negotiations. "It's a relief for the millions of seniors that take these drugs to treat everything from heart failure, blood clots, diabetes, arthritis, Crohn's disease, and more — and it's a relief for American taxpayers," Biden said in a statement. The Biden administration's drug pricing negotiations target 10 high-cost prescriptions, including Eliquis, Jardiance, and Stelara. These reduced prices, effective in 2026, could save taxpayers \$6 billion and Medicare Part D enrollees \$1.5 billion in out-of-pocket expenses. The Centres for Medicare and Medicaid Services estimate price cuts between 38% and 79%. The President stated that he could fly Americans to Canada or France to procure the very same drugs for far less than the "totally unaffordable" ones in the US. "Kamala and I both get it. We know it isn't just about health care — it's about your dignity," the president said.

Israel-Hamas war death toll crosses 40,000 as peace talks continue in Qatar

The White House says a new round of talks aimed at halting the Israel-Hamas war has resumed in Doha and is expected to run into Friday. The talks will also focus on securing the release of scores of hostages, with a potential deal seen as the best hope of heading off an even larger regional conflict. The United States, Qatar and Egypt were to meet with an Israeli delegation in Qatar as the Palestinian death toll from the 10-month-old war surpassed 40,000. A Palestinian official said Hamas would not take part in Thursday's talks but that its senior officials, who reside in Qatar, were ready to discuss any proposals from the mediators, as they have in past rounds. A

cease-fire in Gaza would likely calm tensions across the region and may persuade Iran and Lebanon's Hezbollah to refrain from retaliatory strikes on Israel after the killing of a top Hezbollah commander in an Israeli airstrike and of Hamas' top political leader in an explosion in Iran's capital. The mediators have spent months trying to hammer out a three-phase plan in which Hamas would release scores of hostages captured in the October 7 attack that triggered the war in exchange for a lasting cease-fire, the withdrawal of Israeli forces from Gaza and the release of Palestinians imprisoned by Israel. Qatar's Foreign Ministry

spokesman Majed al Ansari said the cease-fire talks are still ongoing and will resume on Friday. In a statement carried by the Qatari News Agency, he said "the mediators are resolute in their commitment to move forward in their endeavors to reach a cease-fire in (Gaza) that would facilitate the release of hostages and enable the entry of the largest possible amount of humanitarian aid" into the territory. Meanwhile, Prime Minister Benjamin Netanyahu and the Israeli military issued rare and swift condemnations of the attack by Israeli settlers on a village in the occupied West Bank that killed at least one Palestinian and injured another.

Thailand lawmakers to elect new PM, ousted leader's daughter is frontrunner

**Thai lawmakers will vote on Friday to decide whether to appoint billionaire Thaksin Shinawatra as prime minister, elevating a third member of the clan to the nation's top job despite her never having held office.**

**Bangkok, Thailand,** Thai lawmakers will vote Friday on whether to appoint the 37-year-old daughter of billionaire Thaksin Shinawatra as prime minister, elevating a third member of the clan to the nation's top job despite her never having held office. Paetongtarn Shinawatra, whose father and aunt have served as premier, would become the youngest leader in Thailand's history as a constitutional monarchy if elected. She would also become the kingdom's second woman prime minister, after her aunt. The vote, slated to begin at 10 am (local time), was forced after the kingdom's top court sacked premier Srettha Thavisin for appointing a cabinet minister with a criminal conviction. Srettha's ouster on Wednesday was the latest round in a long-running battle between the military, pro-royalist establishment and populist parties linked to Paetongtarn's father, a telecoms tycoon and one-time Manchester City owner. The Pheu Thai party selected Paetongtarn as its replacement candidate Thursday. None of the 10 other parties in the coalition it leads put forward an alternative. Bhumjaithai -- the third-largest party in parliament -- said it had "agreed to support a candidate" from Pheu Thai in Friday's vote. Paetongtarn must now secure 247 ballots from the body's 493 sitting members. "We are confident



that the party and coalition parties will lead our country," she said after the party announced her candidacy. However, in Thailand's tumultuous brand of politics, a win in parliament is not assured. Aetongtarn, who has never held elected office, helped run the hotel arm of the family's business empire before entering politics three years ago and was a near-constant presence on the campaign trail in 2023. That year's national election saw the fledgling Move Forward Party top the vote-getting after pledging to reform the country's strict lese-majeste laws and break up powerful business monopolies. But alarmed senators blocked MFP's attempt to form a government. Pheu Thai subsequently formed an

alliance with pro-military parties once staunchly opposed to Thaksin and his followers, leading to Srettha's ascension. Less than a year later, he became the third Pheu Thai prime minister to be kicked out by the Constitutional Court. Srettha was ousted over his appointment of Pichit Chuenban, a former lawyer associated with Thaksin's family who had a criminal conviction. View More Products Last week, the court also voted to dissolve MFP and ban its executive board members from politics for 10 years.

**ong shadow** Thaksin Shinawatra has cast a remarkable shadow over the kingdom's politics for two decades.

He transformed Thai politics in the early 2000s with populist policies that won him and his party enduring loyalty from the rural masses -- and two elections. But that success came at a cost: he was despised by Thailand's powerful elites and conservative establishment, who saw his rule as corrupt, authoritarian and socially destabilising.

Ousted as prime minister by the army in 2006, Thaksin took himself into exile two years later but never stopped commenting on national affairs -- or meddling in them, according to his critics. Thaksin returned to the country last year.

Ukraine turns tables on Russia with Kursk incursion, but challenges ahead

**After getting a string of victories in more than a week since blindsiding Russia with a lightning cross-border assault, Ukraine now plans to hold territory and use it as a buffer zone.**

**Kyiv,UPDATED** Ukraine has chalked up a string of victories more than a week since blindsiding Russia with a lightning cross-border assault, but the risks are piling up as its troops make plans to hold territory and Russia recovers its footing.

Ukraine poured thousands of troops into the western Russian region of Kursk last week, pulling down Russian flags in towns seized by its soldiers and wresting the war initiative

from Moscow for the first time in months. On Wednesday, officials in Kyiv said Ukraine would use seized Russian territory as a "buffer zone" to shield its north from Russian strikes. Oleksandr Syrskyi, head of the Ukrainian armed forces, said on Thursday that Kyiv had set up a military commandant's office in the occupied part of Kursk, suggesting ambitions to dig in. The occupied area exceeds 1,150 sq km, Syrskyi said. Ukraine's goals in Kursk include distracting Russian forces from the eastern Ukrainian region of Donbas, where Russia has made steady advances for months and which it is seeking to take in its entirety, former Ukrainian defence minister Andriy Zagorodnyuk said in an interview. There is, however, no sign of that happening for now. Apart from a reputational blow to President Vladimir Putin, the biggest

invasion of Russia since World War Two has destroyed Russian forces, captured soldiers who can be traded and created a sore on Russia's flank, said Polish military analyst Konrad Muzyka. The Russian defence ministry did not immediately respond to a request for comment. Ukraine's defence ministry referred questions to the armed forces, which did not immediately respond.

Russian officials have said the Ukrainian attack on Russian territory is a "terrorist invasion" and that civilian infrastructure was targeted, which Ukraine denies. Putin said that Russia will deliver a "worthy response" to the attack but that the immediate task is to eject all Ukrainian troops from Russian territory. Ukraine, which has not said how long it might remain, was "not interested" in permanently taking Russian land, a foreign ministry

spokesperson said this week. Putin has said Ukraine wants the territory as a bargaining chip in eventual peace talks. Serhiy Zgurets, a Kyiv-based military analyst, predicted Ukraine would seek to retain control of the land between the towns of Rylsk, Korenevoye and Sudzha and the border, giving it control of a roughly 20-km-wide strip of Russian territory. The area, he said, could be defended by a small force using long-range artillery systems and air defences. "This line is not difficult to defend, given there are few roads and a large number of rivers," Zgurets said, adding that the area could be easily supplied from the Ukrainian region of Sumy across the border. He said he didn't expect troops to press towards the Russian regional capital of Kursk, something that could expose them to attacks from the flanks.

## 11-Year-Old Girl Sexually Assaulted By Teacher At Mumbai School



**Mumbai.** An 11-year-old girl was allegedly sexually assaulted by a school teacher in Mumbai's Kandivali. The Class 7 student informed the school authorities about it on Wednesday. She told her principal that the teacher had called her after her class and touched her inappropriately, according to the police complaint. The incident occurred in July. The principal then informed her parents, who approached the police and filed the complaint.

Based on the statement of the girl, a police case has been filed under the stringent POCSO (Protection of Children from Sexual Offences) Act against the teacher.

The teacher has been summoned to record his statement. The police are also probing the CCTV footage for evidence. The incident comes amid a massive uproar over the safety of girls and women - sparked by the rape and murder of a doctor while on duty at a government hospital in Kolkata.

## Woman, 22, Gang-Raped In UP, 5 Men Detained: Cops



**Bijnor, UP.** Police have detained five men for allegedly raping a 22-year-old woman here and making a video of the act, officials said on Wednesday. The incident took place on the night of August 9, the police said citing the rape survivor.

The complainant alleged that the five accused forcefully took her from her house to a secluded place where they raped her, the police said. She also alleged that they made a video of the act and threatened to kill her, they added.

Circle Officer Anjani Kumar said the woman reported the matter to police after the accused started threatening her that they would post the video on social media.

"The FIR was lodged on Wednesday and we were able to detain all the accused. Interrogation is underway after which they will be put under arrest," Kumar said. The five accused are said to be residents of the same village as the rape survivor, he added.

## Unable To Repay Loans, 3 Of Family Die By Suicide In Karnataka: Cops

**Hassan, Karnataka.** In a tragic incident, three members of the same family killed themselves in the Hassan district of Karnataka, said police officials.

The incident took place at the Kerebidi area in Channarayana taluk of Hassan district.

Those who have been identified as Srinivas (43), Shweta (36) and Nagashree (13). Three of them, a husband-wife and daughter, committed suicide by jumping into the Hemavati canal.

The couple's body has been found in the Hemavati canal, while the search operation is continuing to find the girl's body.

Reportedly, they were unable to pay the debt, and as a result, the tragic incident occurred.

Srinivas was a car driver and his wife, Shweta, was a teacher at a private school. Srinivas had taken loans from various places but was unable to repay them.

Family members have been searching for them since last Tuesday. When they did not get any clue, they complained to the Channarayana Nagar Police Station.

The bodies of Srinivas and Shweta were found in a canal near Bagur Hobali, Mudlapur, yesterday evening, and the fire brigade personnel and the police, who removed the bodies, are continuing to search for the dead body of the girl Nagashree.

SP Hassan Mohammad Sujeta visited the place and inspected it. A case has been registered at Nugehalli Police Station and further investigation is ongoing.

# Mandatory Commissioner of Police nod delaying FIR in Chennai cybercrime cases

**Additional Director General of Police Cyber Crime Wing Dr Sandeep Mittal said a Madras High Court circular has clearly stated that FIRs need not be insisted after the crime is registered at the national portal.**

**CHENNAI.** A senior Indian Revenue Service (IRS) officer, who retired as Principal Chief Commissioner of Income Tax on July 31, had to run from pillar to post to register an FIR after he lost Rs 4.6 lakh in his bank account in an online fraud on August 4.

The inspector of the cyber crime cell of the Chintadripet Police Station, where a complaint was filed on August 7, wanted the prior approval of Greater Chennai Police Commissioner A Arun to file the FIR, DN Kar, the retired official, said.

Kar told TNIE that Rs 4.6 lakh was swindled from his account after he received an SMS about SBI netbanking reward points. He mistakenly clicked on the link which took him to a bank's mirror image site and his personal details were stolen. He later found that four debit transactions for Rs 69,874, Rs 98,879, Rs 55,986 and Rs 2,35,467 were made from his account within two hours.

He immediately called SBI's helpline number, and got his bank account and internet banking facility locked. He also registered a complaint with the Central Cybercrime Helpline 1930 and uploaded the complaint on the central government's cybercrime portal. While three transactions were reversed and the funds were returned to his bank account, SBI and a message from the cybercrime portal

informed him that an FIR was needed for reversing the fourth transaction of Rs 2.35 lakh.

Accordingly, on August 7, Kar said he had asked an Income Tax inspector to approach the Chintadripet police station along with all the required documents to file an FIR on his behalf. The complaint papers were taken by the police station staff but no acknowledgment was given, which Kar said was a violation of Section 154 of Bharatiya Nagarik Suraksha Sanhita (BNSS). After several follow-ups, including messages to the police commissioner, and intervention of a top police official, an FIR was registered at Chetpet police station on August 14.

TNIE accessed the circular dated July 22, signed by the CoP, which stated that cases pertaining to cheating or criminal breach of trust or misappropriation, forgery, immovable property frauds or grabbing, and cyber crimes should be brought to his knowledge before filing a CSR or FIR. The commissioner's concurrence should be obtained either through phone or note.

Police sources said this has resulted in delay in filing of FIRs in such cases. When contacted commissioner Arun, he said there is no need for registering an FIR in cybercrime cases such as these for the banks to take action. One can approach 1930 (Cyber Crime Helpline)

and the amount can be secured. Only in cases pertaining to data theft, FIRs are being filed, he said.

"Regarding cases pertaining to cheating or criminal breach of trust or misappropriation, forgery, immovable property frauds or grabbing, the instruction to take prior approval was given to cut down on katta panchayats (kangaroo courts)," the commissioner said. When asked about SBI seeking an FIR, the officer said that the banks may not be aware of the provisions regarding FIRs pertaining to such cases. Kar, however, said an FIR has to be filed immediately and any delay would only help the perpetrators and not the victims.

Additional Director General of Police Cyber Crime Wing Dr Sandeep Mittal said a Madras High Court circular has clearly stated that FIRs need not be insisted after the crime is registered at the national portal. Contacting 1930 immediately is the first line of action by victims against financial cyber frauds. "Golden hour" is lost in case of even slight delay, he said. "Judicial magistrates are directed not to insist on separate FIRs being registered on the basis of an application filed under Section 457 CrPC in matters or complaint that have been registered on the national cybercrime portal," the HC circular said.

## Father arrested for selling four-day-old infant for Rs 2 lakh in Chennai



**CHENNAI.** A 34-year-old man was arrested on charges of selling his four-day-old son to a couple for Rs 2 lakh. The complaint was filed by the mother of the child after she grew suspicious about claims by her husband that the baby was still undergoing treatment at the hospital. A search is on to trace the baby and the couple who bought the baby.

According to the Vyasarpadi police, the accused was identified as Sathya Das, an auto rickshaw driver. His wife Shyamala delivered a male child at the government maternity hospital in Royapuram on August 6.

On August 10, he took the child and handed it over to a mediator when Shyamala was sleeping. Sathya had received Rs 25,000 as an advance when Shyamala was seven months pregnant. After handing over the child, he received the remaining amount.

When Shyamala asked him about the child, Sathya gave evasive replies, saying that doctors had taken the child for check ups. After getting discharged, when the couple went back home, Shyamala grew suspicious when Sathya kept saying that the child was at the hospital for treatment. She then lodged a police complaint. He later told the police that his acquaintance acted as the mediator and facilitated the deal with a couple from Ennore for Rs 2 lakh. He said that he sold the child as his earnings were not enough to support a third child.

# Protests over Kolkata horror continues in Telangana

**Telangana Junior Doctors Association (T-JUDA) organised a rally at Gandhi Medical College, protesting and chanting slogans for justice. Around 600 doctors participated in the demonstration.**

**HYDERABAD.** Doctors in the state continued the protest against the rape and murder of a 31-year-old female PG resident doctor at the RG Kar Hospital in Kolkata. The protest, which started on Wednesday, continued on Thursday with rallies and black badges by the doctors.

Demanding justice for the deceased victim, the medical fraternity urged the authorities to implement the Central Protection Act to provide safety and security for the medical staff in all hospitals and medical colleges across the country. On Thursday evening, the Telangana Junior Doctors Association (T-JUDA) organised a rally at Gandhi

Medical College, protesting and chanting slogans for justice. Around 600 doctors participated in the demonstration. NIMS also witnessed a similar action as doctors led by the Resident Doctors Association (RDA) held a rally on the hospital campus.

Meanwhile, the RDA has also decided to boycott all the OPDs and elective OTs services for the next two days, starting from Friday morning, to show support for the cause. Indian Medical Association (IMA) is also planning to boycott essential services for 24 hours in the days ahead to press for their demands for justice.



# Short intense rains lash Hyderabad, leave commuters stranded

Other districts of Adilabad, Bhadrachalam, Kothagudem, Jangaon, Jayashankar Bhupalapally, Karimnagar, Kumurambheem Asifabad, Mulugu, Vikarabad experienced light to moderate rains. The highest rainfall in the state was recorded in Sangareddy at 93.8 mm,



followed by Hyderabad at 87.5 mm and Nagarkurnool at 87 mm.

IMD said the trough from Rayalaseema to the Comorin area from south Telangana

extends up to 1.5 km above mean sea level.

The state will experience light to moderate rains or thundershowers till August 20. IMD has issued a yellow alert for thunderstorms accompanied by lightning and gusty winds of around 30-40 kmph till August 20.

For the next 48 hours, the city will experience light rain or thundershowers accompanied by gusty winds up to 30-40 kmph. Maximum and minimum temperatures are likely to be around 32°C and 24°C respectively. Surface winds are likely to be Westerlies/North-Westerlies with wind speeds around 8-12 kmph.

# Woman, two others including stepbrother arrested for honeytrap in Bengaluru

**BENGALURU.** A 32-year-old woman and her stepbrother along with another male accomplice have been arrested for allegedly honey trapping some men and extorting money from them. The main accused had separated from her husband,

when the victims came to her house, she used to take them to the bedroom.

Her two associates would enter and threaten the victims and extort money from them. If the victims refused to give money, the main accused would threaten them of filing a rape complaint against them.

The accused are identified as Najma Kausar, 32, a resident of Aghara Layout, her stepbrother Khaleel, 24, and Mohammed Ashik, 20. The incident came to light after one of her victims, a delivery boy, filed a complaint in the Sampigehalli police



station. Kausar had given a missed call to the delivery boy. Assuming that it could be somebody known to him, the victim called back and got trapped on August 8.

The accused had attacked him with a lethal weapon after they did not find enough money on him. The police are on the lookout for another accused who was part of the gang. Further investigations are on.

## Karnataka faces soaring temperatures despite monsoon season

**BENGALURU.** It's monsoon, but temperatures are soaring. This phenomenon is being experienced not only in the city, but also in other parts of the state. In Bengaluru, the maximum temperature recorded on August 15 was 29.6 degrees Celsius, 1.4 degrees Celsius above normal. On August 14, the maximum temperature was 31 degrees Celsius, 2.8 degrees Celsius above normal.

On Wednesday and Thursday, the minimum temperature was 22.5 degrees Celsius, 2.4 degrees Celsius above normal. India Meteorological Department (Bengaluru) Director N Puvyarasan, told The New Indian Express that the weather conditions so far this month were similar to that of May. "The sun is blazing and the sky is clear with no wind and humidity is high. There is also a dip in rainfall, due to which the temperatures are rising across the state," he said. He said this situation will continue for the next three days when the monsoon will become active again.

## Man avails loan by impersonation over phone, held in Chennai

**CHENNAI.** A 37-year-old man was arrested by the cyber crime police on charges of impersonation and taking a loan of Rs 3 lakh by fraud from a private bank. According to the police, the accused was identified as C Rajkamal of Acharapakkam, who was employed in a telecom company.

The issue came to light when the complainant A Senthil Kumar checked his CIBIL score and found that a loan had been availed in his name. When he checked with the Bank in India, he found that another man impersonating him had availed a loan for Rs 3 lakh. "In 2021, after moving abroad, Senthil's bank account and mobile number became inactive. Rajkamal was allotted Senthil's old number when he purchased a new sim card. When he got a call on his new number offering a loan, he availed it," police said. He convinced bank officials over the phone that he was Senthil and got the loan.

## Karnataka Lokayukta office to go paperless

**BENGALURU.** Karnataka Lokayukta office will go paperless as it is adopting e-administration and digitising all sections to bring transparency and reduce the pressure on the staff, said Lokayukta Justice B S Patil at his Independence Day address on Thursday. He further said that the necessary training has been imparted to the staff of the institution to adopt e-administration with the help of the e-secretariat. In the next phase, digitalisation will be introduced in complaints receiving and technical sections also, he added. Justice Patil also said that the strength of the officials and the staff of the institution has increased after the merger of the Anti-Corruption Bureau. The service details of all 1,247 officials and staff are being digitalised.



This apart, it has been contemplated to submit a proposal before the Karnataka Public Service Commission to take necessary steps for the appointment of nine posts of First Division Assistants and 26 posts of Second Division Assistants. This was in view of the shortage of assisting staff to the officials in the institution, Justice Patil said. Speaking on the occasion, Upalokayukta Justice K N Phaneendra remembered those who fought for independence. Another Upalokayukta Justice B Veerappa administered the oath to eradicate corruption, saying that removal of corruption is freedom in the real sense.



# Focus on prevention, preparation to blunt impact of disasters

THERE was a perfect balance among natural resources in the pre-industrial period that lent stability to the land use system. But this system started giving way in the post-industrial phase, especially as a result of industrialisation, deforestation and fast-paced development. The resultant climate change has led to an increase in the frequency and intensity of hydrometeorological disasters like landslides and cloudbursts in hills, floods in plains and cyclones in coastal regions. This year has seen catastrophic destruction in Himachal Pradesh, Uttarakhand and Kerala. The situation in the NCR, Mumbai, Pune, Jaipur, etc, is not much different. There has been a colossal loss of life and property. Thousands of people have died, many are missing and several others have been displaced. Many roads, bridges and dams have been washed away. These disasters are a result of habitations that have been allowed to come up on the natural path of water movement and the infrastructure erected below the floodplain level. In the hills, fragile earth and rocks have been cut to construct roads and buildings. Mining is being carried out with complete disregard for the recommendations of the Environmental Impact Assessment and the Environmental Clearance. Forests have been degraded and damaged, reducing their power for water conservation and its smooth movement. Muck generated from construction and infrastructure development is dumped on the banks of rivers and streams to be carried away with flowing water, further raising the flood level and causing more damage and destruction. The floodgates of storage and run-of-the-river hydroelectric projects are not managed responsibly. Local residents and tourists in many places are caught off guard and washed away in flood waters in the absence of an early warning. The scientific and dynamic National Policy on Disaster Management (NPDMD), 2009, offers guidance for the holistic and strategic management of disasters. But what the policy contains is not being followed to the hilt, leading to the destruction these disasters inflict every year. The disaster management continuum in the policy is divided into the pre-disaster phase of prevention, preparation, early warning, mitigation and risk reduction and the post-disaster stage of response, rescue, evacuation, relief and rehabilitation. Most post-disaster needs assessment studies have shown that pre-disaster management is economically feasible and advantageous. This calls for a relook at the management strategy. Ensuring an effective response has always been prioritised in disaster management, ignoring the role of pre-disaster steps. The situation demands better management of these hydrometeorological disasters. The scientific guidelines of the NPDMD must be adopted. A fully prepared governance system — which prioritises prevention and adequate preparation — would drastically reduce the loss of life and property. There are standard operating procedures to prepare for all disasters. It is not understood why these are not followed. After all, half of the work is already accomplished if such a system is in place before a disaster strikes. Though the need for a comprehensive flood forecasting system has been felt, it has still not been developed. The India Meteorological Department and the Central Water Commission must promptly prepare such an early warning system for river basins, watersheds or dams in collaboration with states and union territories, as per the requirements. Despite the launch of the National Landslide Risk Mitigation Project, there is no sign of an early warning system for predicting landslides. Doppler radars have been installed to predict heavy rains and disaster situations, but every year, they fail to deliver when required. And this year was no exception. Only early warning systems developed and installed for cyclones have helped ensure almost no loss of life and minimum damage to property in the affected coastal regions.

# It is in India's interest to assist crisis-hit neighbours

There is potential for disruption to the domestic economy with a contagion effect from the countries facing economic emergencies.

AS turmoil continues in Bangladesh despite the formation of an interim government, India stands out as the sole bright spot in South Asia on the economic front. Our eastern neighbour has faced an economic downturn in recent years, while Sri Lanka in the south has been recovering from the political and economic crises that erupted two years ago. Pakistan is also struggling to deal with inflation and the burden of international debt, and its GDP growth remains below 3 per cent. In sharp contrast, India recorded robust economic growth of nearly 8 per cent in the last fiscal, and inflation has moderated to a five-year low of 3.5 per cent. Interestingly, both Sri Lanka and Bangladesh seemed to be doing better than their big brother neighbour in terms of development indices at one point. Faulty policies stalled growth and engulfed them in political upheavals that forced their heads of government to flee to safety abroad.

In the case of Bangladesh, which is in the eye of a storm, it was described as an economic miracle until recently. This was surprising for a nation considered to be a basket case for many decades since its creation in 1971. After Sheikh Hasina had assumed power in 2009, a drive was launched to accelerate the pace of development. Investment was made in infrastructure, while focus was laid on industry and services. The result was a sustained growth rate of over 6 per cent for roughly a decade. This led to a rapid rise in per capita income levels. At one point, India's per capita GDP was significantly higher than that of Bangladesh. But it had fallen behind by 2020. Other development parameters also improved, with infant mortality rates lower than those in India and Pakistan. And its life expectancy became the highest in the South Asian region. There were inherent flaws, however, in the economic strategy adopted by Hasina's Awami League government. A big one was the reliance on a single industry, that is, ready-made garments. It became a huge revenue earner for the economy, and it still accounts for 85 per cent of the country's exports. The other critical lifeline for the economy was the inflow of remittances from the overseas diaspora. The situation began to deteriorate with the onset of the Covid-19 pandemic in 2020 as garment factories shut down for months, creating widespread unemployment. The scenario worsened with the outbreak of the Ukraine war in 2022, making imports, especially fuel, more expensive. Remittances dropped while global recessionary trends led to a dip in the demand for garment exports. The current account deficit widened, and foreign exchange reserves suddenly contracted. Ultimately, Bangladesh sought a loan of \$4.7 billion, which was granted by the International Monetary Fund (IMF) in early 2023. The economic woes of the past few years have been the backdrop for the unrest that ultimately led to the downfall of the Hasina-led government. But the political upheavals could have long-



term ramifications unless bilateral relations are brought back on an even keel. Apart from the \$12-billion annual trade, Indian companies have made sizable investments in Bangladesh. Amid uncertainty, there is already talk of shifting the units back to India. Such an attitude would ultimately have a negative outcome. Firstly, the withdrawal of investments or cutting trade ties would deprive India of an easily accessible market. Secondly, creating a vacuum in the supply of basic goods could lead to a flood of cheap Chinese imports into Bangladesh. And since the long land border is relatively porous, these could find their way into India. Besides, there has been increased cooperation in infrastructure. Several credit lines had been provided to Bangladesh for the development of road, rail and port projects. In addition, India has been exporting electricity to Dhaka. It would be in the interest of both countries to ensure that such developmental projects are not disrupted in any way. There is as much concern about Sri Lanka. President Ranil Wickremesinghe had negotiated a \$2.9-billion IMF loan to bring the economy back on track. India, too, provided a \$3.5-billion loan to the cash-strapped country. The downturn in that country's fortunes was caused by a series of unusual economic policies by the previous government. This included deep tax cuts that created severe revenue shortfalls. The situation was worsened by a decision to suddenly shift to organic fertilisers. The

move led to shortages of the staple foodgrain, rice, and the main cash crop, tea. One of the key conditionalities laid down by the IMF was a rollback of the tax cuts. As for Pakistan, it has taken recourse yet again to an IMF loan. But last year's crisis, when inflation shot up to nearly 40 per cent, has been overcome; it has now moderated to 11.8 per cent. Besides, foreign exchange reserves are no longer at dangerously low levels. One of the reasons for the hardships there was a decision taken by the Imran Khan government to cut retail petroleum rates at a time when world prices had risen sharply. Debt incurred as a result of the involvement in China's Belt and Road Initiative also reportedly played a role in the economic distress. Therefore, India remains an outlier in South Asia with a sustained growth rate and steady post-Covid recovery. Yet, there is potential for disruption to the domestic economy with a contagion effect from the surrounding countries facing economic emergencies. Assistance to neighbours like Sri Lanka is very much in India's interest. The impact of a failing economy on India will be even greater in the case of Bangladesh, in view of the extremely long land border. Apart from issues related to trade and investment, an immediate concern would be an influx of refugees. It can only be hoped that the new interim government moves swiftly to restore order and ensure that the economy is back on track. This will be in the best interest of the entire region in the long run.

# The sinking feeling

Urban flooding brings cities to their knees

IN the age of so-called smart cities, the term 'urban flooding' sounds almost like an oxymoron. After all, a smart city ought to have an efficient stormwater drainage system that can handle a few hours' downpour, at the very least. On the contrary, flooded roads are a common sight during the monsoon in cities across the country, right from Delhi and Chandigarh in the north to Chennai and Bengaluru in the south. Gurugram, the Millennium City, has failed to solve this problem despite having spent more than Rs 100 crore on anti-waterlogging measures in the past three years. What else can you expect when nearly half of the drains are not cleaned before the onset of the rainy season? Incidentally, Gurugram is not part of the Centre's Smart City Mission. When asked why, the Haryana CM had said in November 2022 that the state government wanted to make it the 'smartest' city and not just 'smart'. Well, smart, smarter or smartest, the watery nightmare



continues for Gurugram residents. Stormwater drainage systems often don't operate to their designed capacities because of poor maintenance; in

some cases, the capacities have not been augmented despite the rapid pace of urbanisation. Encroachments and unplanned growth have worsened the situation. Adequate preparedness is half the battle won when it comes to flood control. However, high-intensity rainfall in a short duration invariably catches the municipal and urban development authorities off guard. And hapless citizens are left to sink or swim in waterlogged streets. Apparently, funds are not an issue. Under AMRUT (Atal Mission for Rejuvenation and Urban Transformation), 772 stormwater drainage projects worth Rs 2,140 crore have been completed in various states and union territories. Thousands of waterlogging points have been reportedly eliminated, yet the inevitable happens whenever it rains heavily. A lack of political and administrative will is reducing glitzy cities to hellholes. They must set their house in order sooner than later.

# India must invest more in regional integration

Even though India is an island of economic growth and stability in the region, its path forward lies through a stable and secure neighbourhood.

EVEN as India's 'Neighbourhood First' policy has suffered a huge blow with the meltdown of the Sheikh Hasina regime in Bangladesh, it has managed a significant turnaround with a smaller but important neighbour, Maldives. The process is an indicator as to how India is seeking to readjust its neighbourhood policy from its earlier over-emphasis on security. To be fair, both sides can take credit for this. India refused to get rattled by the initial anti-Indian moves of the Muizzu government and continued to maintain an even tenor in ties. Yet by a not-so-subtle call to boycott Maldivian tourism in January that nearly halved Indian tourist inflow into the country, New Delhi ensured that Male got the message. Muizzu changed course in March this year following his visit to China. In an interview to the local media, he spoke of the importance of India to his country and that India would "continue to remain Maldives' closest ally." He acknowledged India's role in Maldives and the importance of ongoing projects facilitated by India and expressed gratitude for their contribution. One factor in this development was the fact that Maldives is indebted to India to the tune of nearly \$0.5 billion and the new Maldivian Government has been looking for leniency in repayment terms. Muizzu could not but have seen how New Delhi had bailed out Sri Lanka in 2022 when the country was hit by a major economic crisis and at a time when China had dithered. New Delhi came through for Maldives as well when, in May, the State Bank of India deferred the repayment of \$50 million by a year. But it is not just the Indian debt that worries Muizzu. As Aditya Gowdara Shivamurthy of the Observer Research Foundation has pointed out, the nation's economy is undergoing "a severe crisis and is struggling to stay afloat". Borrowing by past governments have saddled the country with a debt-to-GDP ratio of 110 per cent and its reserves are rapidly



depleting. But none of these clouds were visible in the recently concluded three-day visit of External Affairs Minister S Jaishankar to the Maldives, the first high-level trip to the country by an Indian minister after President Muizzu assumed power in November 2023. This was a signal that India-Maldives relations were once again on an even track. Jaishankar held meetings with Muizzu, Foreign Minister Moosa Zameer, Defence Minister Ghassan Maumoon and the ministers of finance, economic development and trade. Jaishankar visited several of the projects India is involved in. Several of them are funded through India's Lines of Credit. Among the key projects are the Greater Male Connectivity Project, the Addu Reclamation and Shore Project and a major four-lane bridge project to develop it as a regional hub whose centrepiece will be the Gan International Airport. Also

being developed with Indian help is the Hanimaadhoo International Airport expansion project, whose foundation stone was laid by Jaishankar in January 2023. Relations between the two countries came under severe strain when Muizzu came to power on an 'India Out' platform and immediately pushed for the removal of all of the small number of Indian military personnel stationed in the islands to service Indian-supplied helicopters and aircraft for search and rescue operations. He pointedly made his first visit to Turkey and then to China where he signed a slew of agreements seeking to end the island nation's dependence on food imports and healthcare from India. His first meeting with Prime Minister Modi was at the sidelines of the COP28 climate summit in Dubai in December 2023. His first official visit took place in June when he visited New Delhi to attend the

swearing-in of PM Modi's third government. In the past, China has made major inroads into the Maldives by promoting a range of mega-infrastructure projects and providing liberal aid and loans. The big Indian concern is of Chinese maritime activities in the Maldives. A Chinese company has been given the lease of Feydhoo Finolhu island, located close to Male and there have been periodic reports about the sale to China of the Gadhoo island, next to the Gan airport, in the southern part of the country. Indian objections led to the scrapping of plans to build a Joint Ocean Observation Station in its western most atoll of Makunudhoo. As the record shows, India has moved beyond its 'security first' approach and is willing to engage neighbours through an all-round policy emphasising trade and development along with security. In the case of the Maldives, India has, however, taken the precaution of developing a new base in the Minicoy island that is closest to the Maldives, and shoring up its naval presence in Lakshadweep. But on a long-term basis, India needs to put serious money and effort into promoting regional integration. BIMSTEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation) has not really worked, and the Bangladesh uncertainty makes it less likely that it will do so soon. There is a need to go back to SAARC and its South Asian Free Trade Area (SAFTA) project. No doubt this involves even trickier diplomacy, especially in dealing with Pakistan, but India needs to look ahead instead of backwards. It should be clear by now that even though India is an island of economic growth and stability in the region, its path forward lies through a stable and secure neighbourhood. An integrated South Asian region provides this option and can also be the basis of common security and prosperity.

## How green is your home?

What story can the dust collected from your house tell? These organisms can indicate not just the geographical location of your residence, but also the proportion of male and female members in the house, and can also reveal if you have a pet, says a new study. The new findings highlight the impressive amount of microbial diversity in the average household. "Every day, we are surrounded by a vast array of organisms in our homes, most of which we cannot see," said co-author of the study Noah Fierer, associate professor at the University of Colorado Boulder in the US. "We live in a microbial zoo, and this study was an attempt to catalog that diversity," Fierer said. The study examined roughly 1,200 homes across the US. On average,

each home contains more than 5,000 different species of bacteria and around 2,000 species of fungi. Fungal communities tend to be more predictive of a home's location while bacterial communities provide clues about the identity of its residents. "Geography is the best predictor of fungi in your home," Fierer noted. When it comes to bacteria, however, where you live may be less important than whom you live with. From the dust samples, researchers could confidently predict which homes had pets such as cats or dogs and, to a slightly lesser extent, the gender ratio of the residents.

# Will contest J&K Assembly polls, get majority on our own, says Farooq Abdullah

**Farooq Abdullah welcomed the decision of the Election Commission to announce the election schedule for J&K, which will go to polls for the first time since Article 370 abrogation.**

**NEW DELHI.** National Conference president Farooq Abdullah said he would contest the upcoming Assembly election in Jammu and Kashmir and exuded confidence of getting a majority on its own in the Union Territory, which has been without an elected House for five years now. In an exclusive interview with India Today, Abdullah, however, did not reveal if the party planned to contest the polls solo or in an alliance. The Election Commission, which recently visited J&K to assess poll preparedness, is likely to announce the election schedule for the Union Territory today at 3 pm. This will be the first Assembly election in J&K following the scrapping of its special status under Article 370. "I welcome the decision of the ECI to announce Assembly polls in J&K. I will be contesting the elections. We will get a

majority on our own," the former Chief Minister said. The National Conference is part of the opposition's INDIA bloc. However, Abdullah said the party would hold discussions on a pre-poll alliance. "Can't say yet whether we will enter into a pre-poll alliance with any party or not. We will hold discussions on that," he told India Today. The 86-year-old leader, who did not contest the Lok Sabha polls earlier this year, has indicated on several occasions his willingness to put his hat in the Assembly election ring. Earlier this month, speaking to reporters in Doda district, Abdullah said, "Omar Abdullah (his son) does not want to fight the elections under the present setup. He has made up his mind that he will not fight the elections till the restoration of statehood (of Jammu and Kashmir). However, I am

going to fight the elections as I am not dead." The former Union Minister has said that unemployment and inflation were the biggest problems facing Jammu and Kashmir. The elections come amid growing encounters between terrorists and security forces in Jammu and Kashmir.

The National Conference chief had previously questioned the rise in infiltration of terrorists from Pakistan despite heavy military deployment, PTI reported.

"There is so much military deployed on the borders (in Jammu and Kashmir), which I feel is not there in any other country, but still they (terrorists) are managing to sneak into this side," Abdullah had said. "They are all in close collaboration, united for our destruction," he further said.



## Delhi traffic cop among 2 hurt by Chinese manjha



**NEW DELHI.** Two persons, including a policeman, were injured in separate incidents after they were "hit" by Chinese 'manjha' (string) that is still being used to fly kites despite prohibition, a Delhi Police officer said on Thursday. The condition of the injured is stated to be stable. The police said that assistant sub-inspector Surendra, posted at the Punjabi Bagh Circle, suffered an injury from the kite string while he was on his way to his workplace. The 47-year-old officer was hit by a manjha thread near Yamuna Vihar in Bhajanpura, after which he visited a nearby hospital. "He was discharged after treatment and is stable now," said a police officer. In another incident, a 34-year-old man suffered a serious injury when he was grazed by the manjha while he was riding a scooter with his wife near Signature Bridge in northeast Delhi, the police said.

The government has banned the sale, production, storage, supply, import, and use of kite flying thread made of nylon, plastic or other synthetic material. Other types of thread laced with glass, metal or any other sharp materials have also been banned since 2017. Till August 8, 147 FIRs have been registered by police during this kite flying season.

## PM Modi Urges Indian Olympians To Join 'Ek Ped Maa Ke Naam' Campaign

**New Delhi:** Prime Minister Narendra Modi has urged the Indian Paris Olympics contingent to join the 'Ek Ped Maa Ke Naam' campaign. During his interaction with the contingent at his residence on Thursday, the Prime Minister highlighted the need to create awareness about the importance of planting trees to save the environment. "Today, the country is running a campaign called 'Ek Ped Maa Ke Naam' to save the environment. I urge all of you to join this campaign and plant a tree with your mother. Many of you come from villages and ordinary families. In Paris, you saw how they are promoting the environment. So, when you visit your villages, encourage people to adopt natural farming," the Prime Minister told the sports persons. He also said the contingent members should inspire the youth to focus on fitness. PM Modi expressed confidence that the sports persons will also inspire everyone in the direction of conservation of the environment and nature. The 'Ek Ped Maa Ke Naam' campaign was launched by PM Modi on World Environment Day. He had planted a Peepal tree at Buddha Jayanti Park in the national capital. In a post on X, he wrote, "I call upon everyone, in India and around the world, to plant a tree in the coming days as a tribute to your mother."



The campaign has set an ambitious target of planting 800 million saplings by September 2024 and 1.4 billion saplings by March 2025. This large-scale initiative aims to enhance environmental protection and foster a sustainable future.

## Odisha, Bengal, Jharkhand brace for heavy rain amid cyclone threat

**A new low-pressure system has formed in the Bay of Bengal, with the IMD predicting heavy rain in the eastern states of Odisha, West Bengal, and Jharkhand.**

**NEW DELHI.** Heavy rain has been predicted in the eastern states of Odisha, West Bengal, and Jharkhand in the next 2-3 days due to the formation of a low-pressure area in the northwestern Bay of Bengal. The India Meteorological Department (IMD) said the low-pressure system is likely to intensify in the coming days. It is expected to move west-northwest, passing through Gangetic West Bengal and Jharkhand over the next 2-3 days.

The IMD said the cyclonic circulation associated with the low-pressure system could potentially drive significant weather changes across the region, leading to increased rainfall and potential floods. Under its influence, squally weather with gusty

winds reaching speeds of 40 to 50 kmph is expected over the northwestern Bay of Bengal on Friday



and Saturday, officials said. In Odisha, heavy rain is expected in Bhadrak, Balasore, Jajpur, Kendrapara, Jagatsinghpur, Cuttack,

Khurda, Nayagarh, Puri, Mayurbhanj, Keonjhar, Sundargarh, Angul, Dhenkanal, Nabarangpur, Koraput, and Malkangiri districts. Coastal Odisha and other districts such as Mayurbhanj, Keonjhar, Boudh, Kandhamal, Rayagada, Angul, and Dhenkanal will experience thunderstorms with lightning. The following 24 hours may see continued heavy rain in Mayurbhanj, Keonjhar, Sundargarh, Deogarh, Jharsuguda, Sambalpur, and Bargarh, the IMD said.

In view of the developing weather conditions, authorities have advised residents in West Bengal, Jharkhand, and Odisha to take necessary precautions. Fishermen have also been advised against venturing into the northwestern Bay of Bengal.

## Person In Constitutional Post Trying To Destroy Economy: Jagdeep Dhankhar

**New Delhi:** Vice President Jagdeep Dhankhar today accused "a person holding constitutional position" of trying to destroy the Indian economy. His comments were seen to be directed at Congress leader Rahul Gandhi over his remarks on the latest report by US short-seller Hindenburg Research. The report, which targeted India's markets regulator chief Madhabi Puri Buch, has been rejected by the SEBI boss, the Adani Group, and top economists of the country. Mr Dhankhar, addressing law students at the National Law University (NLU) on Friday, said he was "extremely worried" over what he called a narrative aimed at destroying India's economy.

"I got extremely worried when a person holding a constitutional position, just last week, declared in a well-publicised media; I would say campaign, beseeching the Supreme Court to suo-motu (on its own) invoke jurisdiction to give wings to a narrative aimed at destroying our economy," the Vice President said. He said the youth must neutralise forces that keep partisan and self-interest above that of the nation. "We cannot allow it.

It happens, it is at the cost of our rise," he added. Rahul Gandhi, the Leader of Opposition in Lok Sabha, while speaking about the Hindenburg report, had called for the Supreme Court's intervention. Mr Dhankhar urged the

students to look around and find out if the highest courts in other countries ever use "suo-motu cognisance". "Jurisdiction of institution is defined by the Indian Constitution, be it legislature, be it executive, be it judiciary. Jurisdiction of courts is decided. Look around the globe, look at the Supreme Court in the US, the highest court in the U.K. or other formats. Has there been suo-motu cognisance even once? Has a remedy been created beyond what is provided in the Constitution?" said the Vice President.

The Hindenburg report was earlier rejected by SEBI chairman and the Adani Group as "baseless" and "malicious".

## "FIR Within 6 Hours": Centre's Directive To Protect Healthcare Workers

**The notice comes amid protests over the rape and murder of a doctor at Kolkata's RG Kar Medical College and Hospital, following which medical professionals across India have gone on strike.**

**New Delhi:** The Union Health Ministry has ordered all government hospitals, centre or state, to file police complaints within six hours of violence on campus or against staff and health workers. A brief notice issued Friday morning said the head of the institution concerned

would be held responsible if no such complaint is made within the stipulated time. "Recently it has been observed that violence has become common against doctors and other healthcare staff at government hospitals. A number of healthcare workers suffered physical violence during the course of their duty. Many were threatened or exposed to verbal aggression."

Most of this violence is done either by patients or patients' attenders. In view of this it is stated that in the event of any violence against any healthcare worker while on duty, the Head of the institution shall be responsible for filing an institutional FIR within a maximum of six hours. "The notice comes amid furious protests nationwide over the rape and murder of a doctor at Kolkata's RG Kar Medical College and Hospital, following which medical professionals across the country have gone on strike demanding better protection and safer work environments. Earlier the Calcutta High

Court came down strongly on the Bengal government while hearing petitions on this issue, including one by the doctors' parents alleging lapses by hospital administration.



The state and the police have firmly denied any claim of negligence on their part. The police have firmly trashed any talk of impropriety on their part, including the parents' claim they first treated the death as a 'suicide' and then later did not allow them to view the body.

The police have also dismissed talk they failed to secure the crime scene that was believed to be the target of the vandals. The court, though, has demanded photographic proof of this. The body of the doctor was found in a seminar room on the RG Kar Hospital campus on August 9.

An autopsy confirmed multiple heinous injuries, from her arms and legs to her genitals. The grisly killing sparked a massive agitation by doctors in that hospital, from across Kolkata and Bengal, and across India. The protests were followed by vandalism at the RG Kar Hospital. In a hearing this morning the High Court had some tough questions for the police regarding the vandalism, including asking how they could have allowed a mob of 7,000 to gather. The High Court then directed the CBI to submit an interim report on the vandalism. The court had earlier handed the case over to the CBI, arguing there is "no further time to lose" in ensuring justice.

## AIIMS to lead docs' protest at Health Ministry

**Coalition of RDAs from top hospitals to protest outside Nirman Bhavan, demanding Central Protection Act and assurances from the central government**



**NEW DELHI.** The ongoing doctors' strike is set to escalate further as a coalition of resident doctors' associations (RDAs) from leading hospitals in the national capital, spearheaded by the AIIMS, plans to stage a protest outside Nirman Bhavan today at 2 pm.

This newly-formed coalition, still unnamed, has outlined four key demands, including a written assurance from the central government on the enactment of a Central Protection Act (CPA) for not only doctors but all healthcare workers.

The coalition comprises RDAs from Centre-run hospitals including AIIMS, Safdarjung, Ram Manohar Lohia, and Lady Hardinge Medical College, as well as RDAs from Delhi government-run hospitals like Pandit Deen Dayal Upadhyay and University College of Medical Sciences. A member of the group expressed the need to unite RDAs across the capital to press for the CPA as a separate and urgent issue, despite the ongoing strike already being led by national organizations such as the Federation of Resident Doctors Association (FORDA) and the Federation of All India Medical Associations (FAIMA), who share similar demands.

The group's demands also include a detailed roadmap for the implementation of the CPA, which they will present to the central ministry during today's demonstration. "All associations and members of the healthcare fraternity are invited to participate in the protest march to show solidarity and demand action. The common demands were agreed upon by all the RDA include immediate arrest of the individual responsible for the horrific and tragic murder and rape of a female doctor at Kolkata and a written assurance from the government regarding the enactment of a Central Protection Act for doctors, healthcare professionals, and hospitals. This assurance must include a clearly defined, time-bound roadmap for its implementation," a statement from the group shared with this newspaper read.

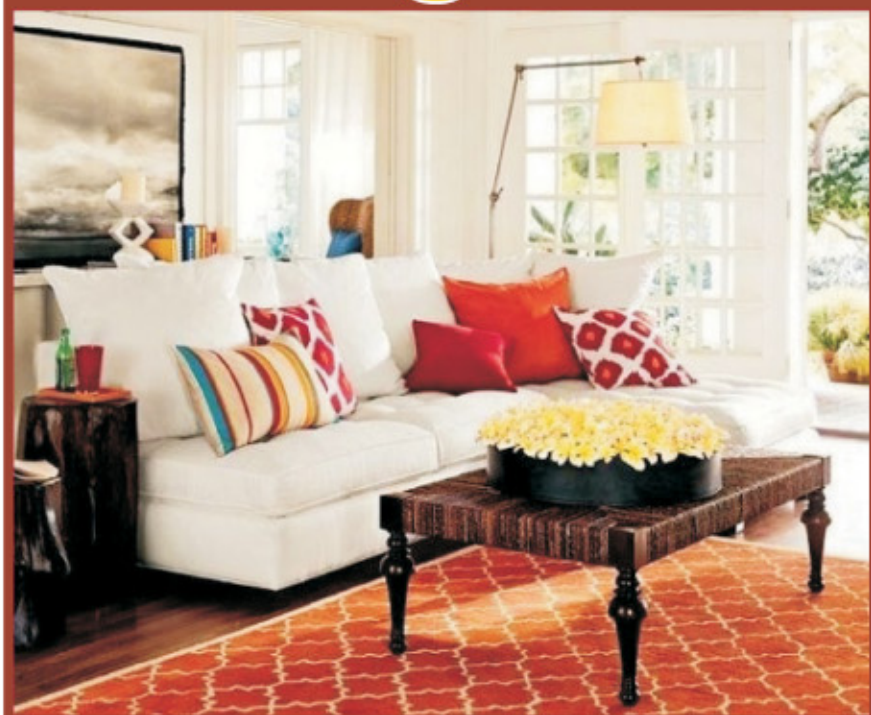
**Floor skirts** Floors look larger when the skirtings are of the same colour. When the floor skirtings are of the same colours as your walls, it gives the opposite effect.

Commonly used as a form of decoration, a bottle garden is perhaps a brilliant substitute of balcony or terrace gardens for city apartments. A plastic or a glass bottle with a narrow neck is just what you require to get started. Plants are grown inside the bottle with little exposure to sunlight, and can be contained indefinitely inside the bottle. You may wonder how the plants survive without air or water. It's pure science. When the plants are initially planted in a bottle, a small quantity of water is added. The air in the bottle provides the plants with necessary oxygen and carbon dioxide for photosynthesis. Sunlight is used to convert water and carbon dioxide into sugar. Oxygen that is liberated as a byproduct, remains trapped in the bottle and is, in turn, used for respiration by the plants. The cycle continues and thus, the plants can easily survive in a self-sufficient ecosystem.

**Green therapy** Creating a bottle garden is simple. All you need to do is select a plant with a slender stem, tolerance for lower indoor light, humidity and features of visible interest like appealing leaf colour, shape et al. Get a pretty-looking bottle and you are all set.

- Put a tablespoon of coarse aquarium gravel at the bottom of the bottle. That way you'll be able to see if there is stagnant water below the soil.

- Fill the bottle up to an inch with fine potting soil just above the gravel. Let it settle down by gently adding water, but just enough to moisten the soil.

- To prevent getting water on the mouth of the bottle and to prevent over watering, use an eye dropper. Using distilled water will help limit the amount of salts going into the soil.

- Keep adding soil and water until the level of the soil is correct and all of it is moist.

- Once the stem extends beyond the top of the bottle, gradually add more soil to give the stem and roots time to adjust being covered. With such a small opening, the soil may not be able to take in enough air at times and may sour due to over-watering. Now, that might be fatal to the roots.

- If the bottle is big enough, a layer of brick pieces of about 10 mm thickness should be laid (instead of gravel) at the bottom. This will absorb accidental application of excess water. Preparing the soil.

- The soil mixture should be porous and friable. This helps in aeration of roots. In case of a bottle garden, it is not easy to loosen the soil at regular intervals. Hence porous soil is essential.

- For this, take one part red garden soil, one part crushed brick pieces and one part leaf mould. In case leaf mould is not available, ½ part of well-decomposed manure may be used in the mixture. It is not necessary to sterilise the soil mixture.

## How to make your own Bottle garden



- To take care of fungus and insect infection, add a small quantity of fungicide and insecticide to the soil mixture. It is advisable that these chemicals are mixed in water and then added to the soil.

- Making the soil moist has certain advantages. The dust will not fly while you fill the bottle with soil. And when you plant the saplings, the soil won't crack. Selection of plants

- The plants chosen should be slow-growing because fast-growing plants need frequent pruning, which is bit difficult in case of a bottle garden.

- Herbs like sage, oregano, basil and ferns work

quite well for a bottle garden as they usually adapt to the size of their environment be it a small bottle or a big container.

- Keep the bottle near a window. But direct sunlight must be avoided, or else plants will wilt inside.

How to sow a sapling Place the selected saplings inside the bottle with the help of fork and forcep. Pour a few droplets of water and close the lid of the bottle. The plants start growing inside the closed bottle. You should not water again unless the saplings start wilting. So, what are you waiting for? Happy gardening!



Penalty if CIL fails to supply coal to consumer

NEW DELHI. In a first such instance, state-owned Coal India Limited (CIL) will be liable to pay a penalty if it fails to supply coal to consumers through e-auction. Until now, only buyers faced penalties for not lifting the full quantity bid for. The move aims to increase CIL's supply and maintain its market relevance. Currently, CIL is the sole supplier of coal via e-auction and the provision of penalty would now be part of the e-auction contracts of Coal India going ahead. The move is to make the contract equitable and fair. Earlier, there was no penalty on CIL, if CIL failed to supply coal to the consumer. It used to forfeit the security deposit of consumers, if the consumer failed to lift successful bid quantity of e-auction," said a senior official of the coal ministry. These measures aim to boost CIL's supply and maintain market relevance amid rising competition from commercial mining and private players. Phasing out of coal from certain sectors is driving CIL to prioritise supply. Reports suggest demand for CIL's coal could drop by up to 58% in next two years.

To counter this, CIL has relaxed restrictions on supply to thermal power plants and independent power plants (IPPs). These entities can receive coal beyond their annual contracted quantity (ACQ). Earlier capped at 120% of ACQ, there is no upper limit now. CIL said these measures are part of India's broader plan to reduce coal imports and become self-sufficient in coal production.

Aurobindo Pharma arm gets warning letter from USFDA for formulations unit in Telangana

NEW DELHI. Aurobindo Pharma Ltd on Friday said its arm Eugia Pharma Specialities Ltd received a warning letter from the US health regulator for its formulations manufacturing unit in Telangana. Earlier in May, the company had stated that Unit-III, a formulation manufacturing facility of Eugia Pharma Specialities Ltd., a wholly-owned subsidiary, received Official Action Indicated (OAI) status by the US Food and Drug Administration (USFDA). "Subsequent to OAI, the unit has received a warning letter," Aurobindo Pharma said in a regulatory filing. It did not elaborate on the details of the warning by the regulator. "There is no impact on the existing supplies to the US markets," the company said. Aurobindo Pharma said it remains committed to working closely with the USFDA and continues to enhance its compliance on an ongoing basis.

The USFDA conducted an inspection at Unit-III, a formulation manufacturing facility of Eugia Pharma Specialities Ltd, located at Pashamylaram, Patancheru Mandal, Sangareddy district in Telangana, from January 22 to February 2, 2024. Subsequently, the USFDA determined the inspection classification status of this facility as 'Official Action Indicated (OAI)'.

As per the USFDA, OAI implies that the regulator may withhold approval of any pending product applications or supplements filed from such facility till the outstanding observations related to non-compliance of manufacturing norms laid down by it.

SBI hikes lending rate by 10 bps across tenors, raising EMI for borrowers

NEW DELHI. State Bank of India, the country's biggest lender, has raised the Marginal Cost of Funds-based Lending Rate (MCLR) by 10 basis points (0.1 percentage point), across tenors, making most of the consumer loans costlier. This is the third time in a row that the bank has increased MCLR.

The benchmark one-year tenor MCLR, which is used to price most consumer loans such as auto and personal, is now pegged higher at 8.95 per cent against the earlier rate of 8.85 per cent, according to the information posted on its website. The three-year MCLR is 9.10 per cent, while the two-year is now 9.05 per cent, up 10 basis points. Among others, the rates of one-month, three-month and six-month tenors are in the range of 8.45-8.85 per cent. The MCLR on overnight tenor will be 8.20 per cent against 8.10 per cent. The new rates are effective from August 15, 2024, it said. The rate hike has come days after RBI kept its benchmark lending rate unchanged at 6.5 per cent for the ninth consecutive time earlier this month.

Rubber price jumps amid shortage

CHENNAI. India is facing an acute shortage of natural rubber with domestic production falling short of demand by around 5.5 lakh tonne. According to Shashi Singh, president of the All India Rubber Industries Association (AIRIA), natural rubber production in India has increased from 8.4 lakh tonne in 2022-23 to 8.6 lakh tonne in 2023-24. "But there has also been a sharp rise in natural rubber consumption which has gone from 13.5 lakh tonne in 2022-23 to 14.2 lakh tonne and so the deficit is still 5.5 lakh tonne," he said. India, he added, has always been dependent on imports because domestic production of natural rubber has not kept pace with demand. "Natural rubber imports face a 25% customs duty or Rs 30 per kg whichever is higher but that's just one part of the issue," said Singh. The other is the availability of natural rubber. "Right now China is stocking up and Bangladesh, which had become a good source of natural rubber, is in turmoil," added. The immediate result is a sharp increase in the price of natural rubber. "The price is currently at Rs 247 per kg which is the highest in 15 years compared to Rs 182 per kg as on April 1, 2024. So in 4 months, it has nearly doubled," he said.

US court orders Vedanta Group-backed Sterlite Tech to pay USD 96.5 million to Prysmian

Additionally, the court has awarded USD 200,000 penalty on Stephen Szymanski, Sterlite Technologies Inc (STI) Executive Vice President for Americas Region, for misappropriation of trade secrets of Prysmian.

NEW DELHI. An American court has ordered Vedanta Group-backed Sterlite Technologies' overseas arm to pay USD 96.5 million, about Rs 810 crore, in damages to US-based Prysmian for violating trade secrets norms, according to a regulatory filing and plaintiff's statement. Additionally, the court has awarded USD 200,000 penalty on Stephen Szymanski, Sterlite Technologies Inc (STI) Executive Vice President for Americas Region, for



misappropriation of trade secrets of Prysmian. STI is the US subsidiary of Sterlite Technologies (STL) which has contested the judgement and may file an appeal against it. Prysmian in a statement said a South Carolina jury on August 9

ordered in favour of Prysmian following a three-week trial in the district court of Columbia, South Carolina.

"The jury found that Sterlite was unjustly enriched by taking Prysmian's trade secrets and awarded USD 96.5 million in

damages against Sterlite Technologies, Inc. In addition, the jury found that Stephen Szymanski had been unjustly enriched by misappropriating Prysmian's trade secrets," Prysmian said in the statement dated August 12.

Prysmian further said that the court awarded USD 200,000 penalty against Szymanski, personally. "Szymanski ran Prysmian's optical fibre cable business in North America, and departed Prysmian for Sterlite, a direct competitor, in August 2020," the statement said. Szymanski joined STI in September 2020. STL in a regulatory filing on August 10 had informed BSE that it is not a party to this dispute neither are any claims being made against it. "STI believes the judgement is not supported by the testimony and evidence presented at trial and intends to vigorously pursue all available post-trial remedies including an appeal," the STL filing said. STL had posted a consolidated loss of Rs 48 crore and decline of about 20 per cent in revenue from operations at Rs 1,218 crore in the first quarter ended June 30, 2024.

DPIT relooks at FDI from China: Govt sources

NEW DELHI. The Department for Promotion of Industry and Internal Trade (DPIT) is considering revisiting the restrictions placed on foreign direct investment (FDI) from China as part of a broader evaluation of the country's foreign investment policies, as per the government sources. Consultations with stakeholders are underway, and a decision has not yet been reached, sources said. "DPIT is looking into what should be the revised FDI policy, and it is working in that direction. They are doing stakeholder consultations," a top official said. The Economic Survey for 2023-24, released in July, emphasised the potential benefits of increasing FDI from China to enhance India's exports. It argued that utilising FDI as part of 'China-Plus One' strategy is more beneficial than solely relying on trade.

This is relevant as China is India's largest import partner, and the trade deficit with it has been on the rise. The survey highlighted the experiences of countries like Vietnam, Mexico, Taiwan, and



South Korea, which have benefitted from increased Chinese FDI as the US shifted its trade focus away from China. As per another official, the government is aiming to cut dependence on China via Production-Linked Incentive (PLI) scheme, which encourages domestic production. As production capacities are developed under this scheme, reliance on Chinese imports will fall, he said. It's important to acknowledge India has strong domestic consumption, which will play a role in this strategy, he added. As per the latest figures from the commerce department, exports to China during April-July 2024 fell 4.54% to \$4.8 billion, while imports from China rose by 9.66% to \$35.85 billion. Meanwhile, on trade deficit with China, Sunil Barthwal, Commerce Secretary, during press conference said "no country has been able to decouple from China, including the US and EU? The point is that in trade, you are dependent upon all countries who are in the value chain." "Chinese import will fall once mfg capacities built"

Sensex zooms 1,000 points, Nifty climbs over 24,400 in market rally

NEW DELHI. Benchmark stock market indices rallied in the afternoon session on Friday as global markets gained momentum following US jobs and spending data that helped reduce fears of a recession.

The S&P BSE Sensex gained 1023.08 points to 80,128.96, while the Nifty 50 added 295.55 points to 24,439.30 as of 12:38 PM. The market capitalisation of companies listed on the BSE increased by Rs 4.77 lakh crore, reaching Rs 449.06 lakh crore, compared to Rs 444.29 lakh crore on Wednesday.

Among the 30 stocks in the Sensex, 26 were trading positively. The top performers included M&M, Tech MaA total of 81 stocks achieved their 52-week highs today. Meanwhile, 20 stocks hit their 52-week lows in early trading. Out of 3,156 stocks traded, 2,209 were in the green. About 844 stocks were in the red, while 103 stocks remained unchanged.

The BSE midcap index rose by 420 points to 46,976, and the smallcap



index surged by 490 points to 52,955.

All 19 BSE sectoral indices were in positive territory. The auto, banking, capital goods, and IT sectors were the leading gainers, with their indices climbing by 811 points, 572 points, 613 points, and 711 points, respectively.

As the market rallied this morning, 118 stocks hit their upper circuits, while 92 stocks reached their lower circuit limits. Foreign institutional investors (FIIs) sold equities worth Rs 2,595.27 crore on a net basis on Wednesday, while domestic institutional investors (DIIs) bought shares worth Rs 2,236.21

crore, according to provisional NSE data. On August 14, benchmark indices closed higher. The Sensex ended 150 points up at 79,105, and the Nifty finished 5 points higher at 24,143.

US market performance - Overnight, the US market saw significant gains. The Dow Jones rose by 538 points to 40,546, the Nasdaq gained 399 points to close at 17,591, and the S&P 500

Banks forced to raise rates as deposits dry up

MUMBAI. Amid slow growth in deposits and rising credit demand, banks are starting at lower margins/profits as they chase depositors offering them higher prices for their money. As a result, analysts see the cost of funds on average rising by as much as 25-30 bps this fiscal, which may top 5.25% system wide.

While credit growth has been averaging 15-16%, deposits accretion has been averaging at 11-12% this fiscal. In FY24, credit grew 19.3% but deposit inched up only 14.7%, forcing banks to offer higher prices for term deposits. And typically, banks earn more when interest expense (which is what they pay for their funds) is lower. In a normal scenario banks price deposits/liabilities lower than their assets/loans to protect their margins/spreads. But since lending rates are already high, banks are forced to increase deposit rates even as they hold the lending rates. According to rating agency Crisil, banks

profitability is set to moderate due to higher cost of deposits as they continue to re-price already elevated deposit rates. Deposit costs are expected to increase 25-30 bps this fiscal after having risen 140 bps since the start of the rate tightening cycle in May 2022. As a result, net interest margin is likely to compress 10-20 bps this fiscal to 3-3.1%. For instance since the beginning of this fiscal, leading banks have increased their deposit rates twice — in June and early July. Before that they had another round of deposit repricing in December 2023. State-run banks are taking a lead in raising special short-term fixed deposit schemes. The new offers vary from 7.05-7.3% for 360 to 666 days money. While BoB is offering 7.25% for rates for 399 days and 7.15% for 333 days, SBI is giving 7.25% for 444 days and 7.1% for 400 days.

This had the cost of deposits for SBI rising to 5% in the June quarter from 4.55% a year ago and 4.81% in

Q4FY24, pulling down its yield on advances to 8.83% in June 2024 from 8.91% in March 2024. Similarly, the second largest lender HDFC Bank saw its cost of funds rising to 4.9% from 4.6% and the yield on yield on assets inching down to 8.4% from 8.7%.

On the other hand, the second largest private sector lender ICICI Bank's cost of funds shot up to 4.84% this quarter from 4.31% and that of Axis Bank this increased from 5.17% to 5.44%. On the other hand, state-run banks led by SBI have hiked loan prices, too, this month to protect their margins. On Wednesday, SBI increased its lending rate by 10 bps across tenors, effective August 15 for loans priced on the marginal cost of funds-based lending rate (MCLR). The new rate varies from 8.20% for overnight rate money to 9.10% for three years loans. Earlier this month BoB, Canara Bank, and Uco Bank also hiked their MCLR-based loans by 5 bps for six-month and one-year tenures.

However, the way the team gave you farewell. I appreciate them, Sarpanch sahab (Harmanpreet Singh) did great," said PM Modi. Sreejesh also thanked his teammates for their heartfelt gesture after the game and revealed that he thanked everyone at the podium. "We could only dream about it because it was hard for us when we lost the semi final. Because when we left for Paris, we had a clear goal to play the final and win gold. However, our dreams were shattered after losing the semi final and ahead of the bronze medal matches everyone was saying we need to win it for Sree bhai. So, it's the proudest moment for me that whatever I've done for my country and thanked my mates from the podium," Sreejesh added.

The pair of Satwiksairaj Rankireddy and Chirag Shetty, the Asian Games champions, were backed to win a historic Gold medal while PV Sindhu, HS Prannoy and Lakshya Sen were in the fray in the single campaign. As many as seven shutters headed to Paris with high hopes, but Lakshya, who was the last to qualify for the Games, reached the farthest.

United have had a busy summer transfer window, which has seen names like Matthijs De Ligt, Noussair Mazraoui, Lenny Yoro and Joshua Zirkzee join the Red Devils. On the other hand, the side has also suffered a blow of injuries, which has seen Yoro and full-back Luke Shaw getting ruled out for an extended period even before the Premier League season had kicked off.

I'd like the sports ministry to prepare a draft for the same and take their feedbacks and suggestions in detail so we will be able to prepare well," he added. Notably, India last hosted a major multi-sport event back in 2010 as they welcomed athletes from other countries for the Commonwealth Games in New Delhi. To prepare for the 2036 Olympic Games, a lot of infrastructure work will be needed in the country and one of Delhi, Mumbai and Ahmedabad could potentially be the front-runners to become hosts.
