

Haryana 'first' to give award money to Paris Olympics medalists

Chandigarh, August 19: Haryana has become perhaps the first state in the country to transfer award money to its Paris Olympics medalists. The award money was transferred to the bank accounts of the medalists well before the imposition of the model code of conduct for the October 1 Assembly polls in Haryana on August 16. The beneficiaries included Vinesh Phogat, who was assured of all incentives accruing to a silver medalist by the state government even after being disqualified in the 50 kg wrestling finals for being overweight. However, the ceremonial function to felicitate the medal winners and participants, which was scheduled for August 17, was put off in the backdrop of the imposition of model code of conduct on August 16, sources said. Haryana awards a maximum of Rs 6 crore to gold medal winner, Rs 4 crore to silver medalist and Rs 2.5 crore for bronze medalist as per its much-touted sports policy. As many as 25 sportspersons from Haryana participated in the Paris Olympics with seven players—four in individual sports and three team sports (hockey) winning medals for the country.

**Relief for CM Siddaramaiah as Karnataka High Court defers special court proceedings till August 29**

Bengaluru, August 19: The Karnataka High Court on Monday directed the special court for people's representatives, slated to hear complaints against Chief Minister Siddaramaiah in the alleged Mysuru Urban Development Authority (MUDA) site allotment 'scam', to defer its proceedings till the next date of hearing on



August 29. "No injunction has been granted," said Justice M Nagaprashanna, who heard a writ petition filed by the Chief Minister challenging the legality of the August 16 order of the Governor, who accorded sanction against him under Section 17A of the Prevention of Corruption Act, 1988, and Section 218 of the Bharatiya Nyaya Suraksha Sanhita, 2023. In the petition, the Chief Minister submitted that the sanction order was issued without due application of mind, in violation of statutory mandates, and contrary to constitutional principles, including the advice of the Council of Ministers, which is binding under Article 163 of the Constitution of India. Siddaramaiah contended that the Governor's decision is legally unsustainable, procedurally flawed, and motivated by extraneous considerations, and thus, he has preferred the writ petition seeking to quash the impugned order amongst other reliefs. The Governor had issued the order after Pradeepkumar S P, T J Abraham and Snehamayi Krishna had submitted to him petitions requesting sanction for prosecution of the Chief Minister in connection with the alleged irregularities in the allotment of alternative sites to his wife Parvathi by MUDA. Abraham and Krishna have moved the special court for public representatives, and the case was slated to come up on Tuesday and Wednesday. "Since the matter is being heard by this court and the pleadings are yet to get complete, till the next date of hearing, the concerned court shall defer its proceedings," Justice Nagaprashanna said. Senior advocate and Congress spokesperson Abhishek Manu Singhvi and the Solicitor General of India Tushar Mehta appeared on behalf of the Chief Minister and Governor, respectively.

**Article 370, J-K's statehood restoration among 12 guarantees in NC manifesto**

Srinagar, August 19: Restoration of Article 370 and Jammu and Kashmir's statehood as well as implementation of the autonomy resolution passed by the erstwhile assembly in 2000 are among the National Conference's 12 guarantees announced in its manifesto for the upcoming polls. In June 2000, the National Conference government under Farooq Abdullah passed a resolution in the Assembly seeking to restore the pre-1953 constitutional position in the state. It was, however, rejected by the Union Cabinet headed by then Prime Minister Atal Behari Vajpayee. The Narendra Modi Government abrogated Article 370, which gave special status to Jammu and Kashmir, in 2019 and bifurcated the erstwhile state into two Union Territories—Jammu and Kashmir and Ladakh. Releasing the manifesto at a press conference here, NC vice-president Omar Abdullah said the party is making only those promises it can deliver. He described the manifesto as the NC's vision document and a roadmap for governance. The manifesto makes 12 broad promises, including striving for the full implementation of the Autonomy Resolution passed by the Jammu and Kashmir Assembly in 2000.

## Kolkata murder case: CBI gets nod to conduct polygraph test of accused

Kolkata, Aug 19: CBI has got permission to conduct polygraph test of the arrested accused in Kolkata hospital rape-murder case. The Central Bureau of Investigation (CBI) on Monday was granted permission to conduct polygraph test of Sanjay Roy, the prime accused in the brutal rape and murder of a post-graduate trainee doctor at Kolkata's RG Kar Medical College and Hospital. On Saturday, the CBI carried out the psychoanalysis test of the accused Roy, who is now in the agency's custody. The Kolkata Police had arrested him a day after the post-graduate trainee doctor's body was found in the seminar hall of the chest department of the RG Kar Hospital between 3 am and 5 am on Friday. Roy joined the Kolkata Police as a civic volunteer in 2019. The police alleged that he was married at least four times and was a "womaniser". A PTI report stated that the accused is a trained boxer and got close to a few senior police officers over the

ed at the police outpost at the RG Kar Medical College and Hospital. According to an Indian Express report, the autopsy report stated that the woman died due to manual strangulation associated with smothering. Several media reports had said that autopsy concluded there was evidence of "forceful penetration/insertion in her genitalia", which indicates sexual assault. As per the report, there were 16 external injuries on the victim's body, including abrasions on the cheeks, lips, nose, neck, arms and knees. The CBI, which is probing the murder case, interrogated the college's ex-principal Sandip Ghosh for the fourth consecutive day. Ghosh was asked to specify his role after getting the news of the death of the doctor, who he had contacted and why he made the parents wait for nearly three hours, an official told. The ex-principal was also questioned who had ordered the renovation of the rooms near the seminar hall at the emergency building of the hospital after the incident.

**Man charged under NSA for murdering 2 women, sexually assaulting their bodies in UP**

Barabanki (UP), August 19: The district administration here has invoked the National Security Act against a man accused of murdering two women and engaging in sexual activities with their bodies, officials said on Monday. The NSA was invoked on Saturday against Amrendra Rawat (26), who was arrested last year for the women's murder in the Ramsanehi Ghat area. Additional Superintendent of Police (South) Akhilesh Narayan Singh said. He was also booked under the Gangsters Act in May last year, the police added. Singh said the NSA was invoked considering the heinous nature of the crime, which would make it difficult for the accused to get bail. "Rawat has confessed before us of murdering the women and then performing sexual acts with the bodies," he further said. According to police, a strangled and dishevelled body of a 60-year old woman was discovered in a nearby forest in the Ramsanehi Ghat police station area on December 29, 2022. "During investigation, it was found that the woman was raped after murder," Singh said, adding it was also found that a similar incident was reported earlier in December 2022.

## Former J&K CM Mehbooba Mufti's daughter Iltija Mufti to make electoral debut from Bijbehara

Srinagar, Aug 19: Iltija Mufti had also made her electoral debut from Bijbehara in 1996, a constituency known as a stronghold of the Mufti family. Former Jammu and Kashmir chief minister Mehbooba Mufti's daughter, Iltija Mufti, will contest the upcoming assembly polls from the Bijbehara constituency. Iltija Mufti, daughter of Peoples Democratic Party (PDP) president Mehbooba Mufti (PTI). Iltija's name appeared in the list of eight candidates released by the Peoples' Democratic Party (PDP) on Monday. The party's youth leader, Waheed Para, who contested the recent Lok Sabha elections from the Srinagar constituency and lost to the National Conference's Aga Syed Rubullah Mehdi, has been fielded from Anantnag.

## Lateral entry attack on Dalits, OBCs, adivasis: Rahul Gandhi

New Delhi, August 19: Upping the ante over the lateral entry issue, Leader of Opposition in the Lok Sabha Rahul Gandhi on Monday called it an attack on Dalits, OBCs and adivasis, and accused the BJP of seeking to snatch reservations from 'bahujans'. The Congress has strongly criticised the government after the Union Public Service Commission (UPSC) on Saturday issued a notification for recruiting 45 joint secretaries, directors and deputy secretaries through lateral entry – referred to as the appointment of specialists (including those from the private sector) in government departments. "Lateral entry is an attack on Dalits, OBCs and adivasis," Gandhi said on X. "The BJP's distorted version of Ram Rajya seeks to destroy the Constitution and snatch reservations from bahujans,"

the former Congress chief said. Government sources have said the concept of lateral entry was first introduced under the Congress-led UPA regime and

was strongly endorsed by the Second Administrative Reforms Commission established by it in 2005. Also, Information and Broadcasting Minister Ashwini Vaishnaw has said the Congress's criti-

cism of the lateral entry system in senior bureaucracy shows its "hypocrisy", and asserted the BJP-led NDA government has created a transparent method to implement the concept developed by the UPA dispensation. In a post in Hindi on X on Sunday, Gandhi had termed the government's move of recruiting public servants through lateral entry an "anti-national step", alleging that the reservation for SCs, STs and OBCs is being "openly snatched away" by such an action. "Reservation of SC, ST and OBC classes is being openly snatched away by recruiting through lateral entry on important posts in various ministries of the central government," Gandhi had said. The INDIA bloc will strongly oppose this "anti-national step" that hurts both the administrative structure and social justice, Gandhi had said. "Privatisation of the IAS is Modi's guarantee for ending reservation," he had said.

## No talk yet with Champai Soren on his joining to BJP

Ranchi, August 19: Jharkhand BJP president Babul Marandi on Monday said that no talk was held yet with Champai Soren regarding his joining the saffron party. Marandi said that Champai is a seasoned politician and he would himself decide his own path. Amid speculation about a potential switch to the BJP, Champai reached Delhi on Sunday afternoon. Later in a social media post, Champai Soren said that he experienced "bitter humiliation" as chief minister, which compelled him to seek an alternative path. "No talk was held yet with Champai Soren. He is a seasoned politician and has been part of the separate Jharkhand movement. He will himself decide his own path," Marandi said. Mentioning Champai's post, he said, "It indicates that he was deeply hurt. He felt humiliated the way he was removed from the CM's post." Champai highlighted in the post that he had been asked to resign during the meeting of party legislators on July 3. He was taken aback, as himself

respect was hurt. The ex-CM said he had announced in the meeting, "a new chapter in my life is going to begin from today". He fur-

ther said he had three options. First to retire from politics, second to float separate outfit, and third, if find any ally, to carry forward with them. "From that day until now, and through the upcoming Jharkhand Assembly elections, all options are open for me in this journey," Shaddeo said.

### Pune Porsche Crash: Accused Minor Completes 15-Day Safe Driving Programme


**Pune:** The minor accused of killing two persons after ramming his Porsche car in an inebriated state into a motorcycle in Pune on May 19 has undergone a 15-day safe driving programme as mandated by a court, a Regional Transport Office (RTO) official said on Sunday. Two IT professionals from Madhya Pradesh were killed in the incident, which took place in Pune's Kalyani Nagar and triggered massive outrage nationwide, partly because of the accused getting bail from the Juvenile Justice Board on lenient terms and due to a police probe finding attempts by his family and some doctors to cover up the crime. While being released on bail by the JJB, among the conditions placed on him were writing a 300-word essay on road accidents as well as taking help of the RTO to study traffic rules and regulations.

The juvenile accused completed the safe driving programme with the RTO. With respect to the guidelines of the court, the operation was kept discreet as it could have led to issue of privacy of the juvenile, a top RTO official said. The training programme included road driving safety measures, importance of driving licence, meaning of road signals and symbols and other activities. During the process, the juvenile was also taken for on-field training, the official added.

### Man Kills His Father For Refusing To Massage His Feet In Nagpur, Arrested: Police

**Nagpur:** Enraged by his 62-year-old father's refusal to massage his feet, a 33-year-old man allegedly beaten him to death in their house in Nagpur city, police said on Sunday. Pranav rushed to his neighbour's house to seek help, but when he returned, the old man was lying unconscious with severe injuries. He was rushed to Mayo Hospital, where he was pronounced dead upon arrival, the official added.

Kushal was arrested on the charge of murder. A court remanded him in police custody till Monday.

# Prioritise underdeveloped areas to set up AIIMS: Union Minister Suresh Gopi

**THIRUVANANTHAPURAM:** Calling for a "strategic approach" in establishing the All India Institute of Medical Sciences (AIIMS) in Kerala, Union Minister Suresh Gopi has said that underdeveloped areas should be prioritised for the setting up of the national institution as it could spur economic growth and infrastructure improvement. Speaking at an interactive session organised by the Fraternity of Trivandrum Professionals on Sunday, Suresh Gopi stressed the need to prioritise locations that would benefit most from the development rather than focusing solely on major cities like Thiruvananthapuram. "I won't say AIIMS should come to Thiruvananthapuram. We should be level-headed. Places like Thiruvananthapuram are already equipped with healthcare services. AIIMS should

come at a place that has been totally sabotaged with strikes as it will be a basis for major development," Suresh Gopi said. Pointing out the potential boost to the local economy, including real estate and rental markets, he highlighted the importance of creating new zones for development. "For that, if AIIMS is a requirement of Kasaragod, it will come," he said. Further, he said the viability of Kochi Metro could be increased by extensions and that only allied installations can bring collective outcomes. He also stressed on the construction of a four-lane road from Madurai — via Cumbum, Theni, in Tamil Nadu, and Vandiperiyar, Mundakkayam, Kanjirappally, Kumarakom,



Vaikom and Muhamma in Kerala — connecting Alappuzha to the national highway passing through Tamil Nadu and other parts of the country. He said development should benefit the entire state, not just major cities or the interests of politicians and administrators. Instead, he called for a thorough audit of funds. He also suggested the creation of a consortium for

Wayanad, supervised by the High Court, to ensure transparency.

**Will court be answerable if dam collapses?**

**T'Puram:** At a time when the Wayanad landslides have reignited debates over the safety of the Mullaperiyar dam, Union Minister of State for Petroleum and Tourism Suresh Gopi sought to know who would be answerable if the 128-year-old dam collapses. "Will the court be answerable? Or will those who obtained a favourable verdict from the court to continue in the present state be answerable," he asked on Sunday. Suresh Gopi said the dam's safety looms like "thunder" over people's hearts. "We cannot afford to drown in tears again," he said, referring to the landslides.

## Gundrevula project yet to take off to end water woes of Kurnool district in Andhra Pradesh

## DYFI-Youth Congress tussle over 'Kafir' screenshot controversy intensifies

**KOZHIKODE:** The DYFI and the Youth Congress' tussle over the controversial Kafir screenshot has further escalated with the former announcing a reward of Rs 25 lakh to anyone who proves that the screenshot was taken by its Vadakara block president R S Ribesh. The announcement was made through a poster uploaded on the DYFI Vadakara block committee's Facebook page. In response, the Youth Congress issued a counter-poster, asserting that if Ribesh discloses the real culprits in the 'Kafir' screenshot case, the youth wing of the INC (Indian National Congress) party would pay the reward. The poster was endorsed by Youth Congress state general secretary V P Dulkifil. Earlier, the police submitted a report to the High Court asserting that Ribesh had first shared the screenshot in 'Red Encounter', a WhatsApp group.

Meanwhile, DYFI held an explanatory meeting on Sunday at Vadakara Bank Road to address the controversy. During the meeting, DYFI district secretary P C Shiju defended Ribesh and accused the Muslim League and the Congress of twisting his intentions. Ribesh forwarded the screenshot to expose the communal propaganda being spread by the UDF. It doesn't mean he created the screenshot. Rather, he was warning the society by being a responsible leader," Shiju said.

He further alleged that UDF leaders, including Muslim League's Parakkal Abdulla, falsely accused Ribesh of creating the screenshot. He affirmed that the DYFI would support Ribesh and invited any investigative agency to interrogate him, even expressing readiness for Ribesh to undergo a lie detector test. Shiju also accused Youth Congress state president Rahul Mamkootathil of being the mastermind behind the screenshot. "We will pay Rs 25 lakh if any agency proves Ribesh created the screenshot. If a thorough investigation is conducted, it will come to light that the 'fake' president was the one behind the screenshot, he said, targeting Mamkootathil.

Singh had been accused of a fraudulent appointment, and Sharma allegedly demanded a Rs 10 lakh bribe in

exchange for a favourable report in Singh's case. To trap the official, the Vigilance Department initiated a covert operation, recording Sharma's phone conversations. Ajay Pal Singh was instructed to deliver Rs 3 lakh as the first instalment. On Saturday, Singh arrived at the Director's office with the money, and as Sharma accepted the bribe and got into his car, the Vigilance team swooped in, catching him red-handed and recovering the bribe.

During the arrest, Sharma's driver and peon attempted to intervene, but upon realising it was a Vigilance raid, they stepped aside. Sharma is scheduled to be presented in the Meerut court on

Monday and will likely be remanded in custody. Sources revealed that RP Sharma had stalled Singh's file since February but had summoned him to the office with the phrase "bring sweets," a euphemism for a bribe. Ajay Pal Singh, speaking to India Today, disclosed that despite receiving a clear chit from the then-BSA during the investigation into his appointment, Sharma halted the approval process and demanded Rs 10 lakh through his stenographer. Singh had recorded these conversations as evidence. In a related development, two other teachers have also accused Sharma of demanding Rs 2.5 lakh in bribes.

## Withdraw GO on self-finance seats in medical colleges in Andhra Pradesh: Parents

**VIJAYAWADA:** The Parents Association of Andhra Pradesh demanded the withdrawal of the notification issued by NTR Health University regarding admissions to self-financed MBBS seats in five government medical colleges. Association president, Narahari Shikha, emphasised that this move would reduce opportunities for poor, middle-class, Scheduled Caste, Scheduled Tribe, backward classes, and minority students. In a letter to Health Minister Satya Kumar Yadav on Sunday, Narahari appealed for the reconsideration of the cancellation of GO No. 108, which pertains to self-financed MBBS seats. He urged the government to revise the policy

to ensure justice for marginalised communities. Shikha also called for setting up a task force to improve non-teaching facilities essential for quality medical education. He demanded a white paper on the state of medical education, expressing concern that declining educational standards are affecting public health. He noted that the State now has 37 medical colleges, but the lack of professors and facilities has led to a decline in standards. He pointed out that no college in the State is fully adhering to National Medical Commission (NMC) norms. Shikha said students should be cautious while selecting colleges as the application process for convener quota

seats is underway. Parents are increasingly worried about the quality of education, and he urged the government to focus on improving standards in both government and private colleges. He also highlighted the Comptroller and Auditor General (CAG) report that revealed 56% of the faculty positions in government medical colleges are vacant, while 70% of faculty positions are unfilled in private colleges. He claimed that some colleges list professors only on paper. Despite the introduction of Aadhaar Enabled Biometric Attendance System (AEBAS), fraudulent practices persist. Some colleges even close early, leaving patients unattended.

## Van rams truck on KMP Expressway, driver injured

**GURGAON.** A driver suffered severe injuries when his van rammed into a truck travelling on the KMP Expressway on Sunday morning.

He remained stuck in the van's cabin for more than half an hour. Fire department personnel moved the two vehicles using a crane and pulled him out of the mangled cabin. The driver was rushed to the Civil Hospital in an ambulance and his condition is said to be critical.

According to police, at around 11am, a van carrying milk packets from Gurgaon to Palwal hit a container truck from behind on the KMP Expressway near Pataudi toll. Due to the high-speed collision, the cabin of the milk van remained stuck with the container.

"The driver of the van suffered injuries and he was stuck in the mangled cabin. We received a rescue call at 11am by passersby. IMT Manesar fire station staff reached the spot with spreading tools and carried out the rescue operation. A crane was also called to the spot and the two vehicles were pulled apart," Manesar fire officer Lalit Kumar said.

Police teams visited the spot and worked along with the fire department officials to rescue the man. "We have no further details about the man at this moment," SI Lokpal said. Police have not registered any case. This year so far, six people lost their lives in two separate road accidents on the KMP Expressway in Gurgaon.

## Farmers set to meet, discuss protest over land grabbing in Gurgaon



**GURGAON.** The Samyukt Kisan Morcha, a coalition of farmer unions, will meet in Bhiwani on Tuesday to form a strategy to protest against the alleged attempt by a developer to take over a farmer's land in Ghamjori village of the city. Farm leaders said on Sunday they will block toll booths and launch a 'Jail Bharo Andolan' if their demands were not met.

State president of Bharatiya Kisan Union (Tikait), Ratan Mann, said on Sunday that govt has not refrained from acting against farmers.

BKU, one of the constituents of SKM, had protested at the Sohna toll plaza earlier this week and handed over a memorandum to sub-divisional magistrate Sonu Bhatt with their demands.

"Police, under pressure from the builder, are still conducting raids to arrest the farmer. Even his children, women of the family, and relatives are being subjected to torture. After discussions at the SKM meeting, a befitting response will be given to the govt for this oppression. We will block toll booths and roads, and launch a Jail Bharo Andolan," said Mann.

## Gurgaon election update: Expenditure limit set at Rs 40 Lakh for candidates

**GURGAON.** The district election officer and deputy commissioner (DC) Nishant Kumar Yadav on Sunday announced that the maximum expenditure limit for a candidate in the election has been set at Rs 40 lakh.

Candidates are required to maintain a detailed account of their election expenses throughout the campaign.

He also said each candidate will be required to submit a security deposit of Rs 10,000 to participate in the elections, while candidates from Scheduled Castes (SC) will need to deposit Rs 5,000. Yadav stated the code of conduct has already been enforced following the announcement of the elections. The nomination process will commence on Sept 5, with candidates from the Pataudi, Gurgaon, Sohna, and Badshahpur Assembly constituencies filing their papers at the respective offices of the Electoral Registration Officers (ERO). Nominations will not be accepted on Sunday, Sept 8. Candidates can submit their nomination papers until Sept 12, following which scrutiny will be conducted on Sept 13. The deadline for candidates to withdraw their nominations is Sept 16 by 3pm, following which election symbols will be allocated to the candidates from all four constituencies on the same day.

## Man strangled, body found stuffed in drum at Gurgaon's greenbelt

**GURGAON.** A 25-year-old man was strangled, and the body was stuffed in a plastic drum at a greenbelt near IMT Manesar on Saturday evening. Police said the body was noticed by workers of an automobile factory when they were clearing bushes in the greenbelt. Around 4.30 pm on Saturday, security staff of an automobile company at Sector 8 in IMT Manesar hired two migrant workers, Mohit of Amethi and Nand Kishore of Bihar, to prune trees in the greenbelt area near gate no. 1 of their company close to Aliyari Chowk. While pruning trees and clearing waste, the workers noticed a stench from a plastic drum found in the stormwater drain abutting the greenbelt. They informed the security guard, who alerted cops. Police reached the place and took out the blue drum from the drain. "When we opened the lid of the drum, the body of a man was found wrapped in a cloth in it. An electric wire was tightly wrapped around his neck," said SI Ishwer Singh of IMT Manesar police station. Based on the complaint of Sohan Singh, the security in-charge at the automobile company, a case was registered under BNS sections 103 (1) (murder) and 238 (a) (causing disappearance of evidence or giving false information to screen offender) on Saturday night.

# Snag sparks water shortage, tempers rise in Gurgaon's Sushant Lok 2 as taps sputter



It's as if they are deliberately ignoring us. I have been calling and messaging

since the problem began, but nothing has been done," said Vinita Sinha, president

of Sushant Lok-2 RWA (A and A1 blocks).

With no reliable supply, residents are paying Rs 800-1,200 for private water tankers. "We are being forced to live without water. Even the quality of water from the tubewell is poor and poses a health risk. Now, even that is unavailable. Our colony is at the far end, and both GMDA and MCG are doing nothing to resolve the issue," said Digvijay Singh, RWA vice-president.

"It's not just the water supply — sewage is overflowing, roads are broken and there is no permanent solution in sight," said Naveen Sharma, another resident.

On Sunday, a GMDA official said there was no disruption in supply from their end and issue could be because of internal distribution. A senior MCG official said the motor was repaired and electrical panel replaced. "Supply was restored by our team on Friday. But I will ask official to check," the official said.

## Haryana: Major reshuffle in DTCP ahead of assembly elections

**GURGAON.** In a significant reshuffle in the department of town and country planning (DTCP), a series of high-level transfers were executed late Friday night, coinciding with the imposition of the election code of conduct.

These changes come as the state is gearing up for elections, necessitating a reorganisation of key administrative positions.

Among the major changes, Rajesh Kaushik, previously the district town planner (DTP) in the city, has been promoted to senior town planner (STP) and assigned to the Haryana Real Estate Regulatory Authority

(HERRA).

Praveen Kumar, who was the DTP in Panipat, will take over Kaushik's former role as DTP Planning for Gurgaon. Other notable changes include the promotion of Sanjeev Maan, the STP at GMDA, who has been made the chief town planner (CTP) and posted at the Haryana State Industrial and Infrastructure Development Corporation (HSIDC) in Panchkula. Dharambir Khatri, previously DTP at GMDA, is now the STP at MCG.

Additionally, Dinesh Singh has been promoted from assistant town planner (ATP) to DTP Narnaul, while Sumit,

formerly DTP planning at MCG, has been transferred to Fatehabad with an additional charge of Sirsa. Anchal Rohilla, previously ATP in Gurgaon, has been transferred to the Sirsa DTP Office.

Three new ATPs - Naveen Bharua, Jyoti Yadav, and Rahul Dabri - have been appointed to the DTP planning office in Gurgaon, and Anish Grover has been newly appointed as ATP in the DTP enforcement office.

This reshuffle is part of the state govt's effort to realign administrative roles to ensure smooth operations in the town planning department during the election period.

## Tropical storm Ernesto regains hurricane strength, heads towards US East Coast

UPDATED Tropical Storm Ernesto became a hurricane again Sunday as it churned away from Bermuda and headed further out in the northeastern Atlantic, sending powerful swells toward the US East Coast, generating rip currents associated with at least one death and prompting many rescues. The National Hurricane Center in Miami said Ernesto's maximum sustained winds were 75 mph (120 kph), just barely Category 1 strength. More strengthening was forecast before Ernesto weakens and becomes a post-tropical cyclone on Tuesday, the hurricane center said. The storm was centered about 520 miles (840 kilometers) south of Halifax, Nova Scotia, and was expected to pass near southeastern Newfoundland late Monday and early Tuesday. Swells generated by Ernesto were affecting portions of the Bahamas, Bermuda, the US East Coast as well as the Canadian Atlantic coast. Life-threatening surf and rip current conditions are likely in these areas during the next couple of days, the hurricane center said. The National Weather Service posted a coastal flood advisory and warned of a high risk for rip currents along the Atlantic Coast through Monday evening, saying they "can sweep even the best swimmers away from shore into deeper water." A warning extended from Florida to the Boston area and portions of Maine.

In periods of high risk, rip currents become more likely and potentially more frequent, posing a danger to all levels of swimmers, not just inexperienced ones, said meteorologist Mike Lee in Mount Holly, New Jersey. "It's going to be really dangerous out in the water today," he said. At Manasquan Inlet in New Jersey, officials said a fisherman was washed off the north jetty Saturday but was quickly rescued by lifeguards. The victim had knee and back injuries and a possible concussion and was taken to a hospital, Lifeguard Chief Doug Anderson told NJ Advance Media, and lifeguards rescued at least five other people. In Ventnor to the south, Senior Lt. Meghan Holland of the city beach patrol said eight people were rescued. Forecasters, citing local emergency management, said a 41-year-old man drowned Saturday in a rip current at Surf City, North Carolina.

## Philippine vessel 'deliberately collided' with Chinese ship, claims Beijing

Beijing. China's Coast Guard said a Philippine vessel that had ignored its repeated warnings "deliberately collided" with a Chinese vessel in an "unprofessional and dangerous" manner in the disputed South China Sea, according to statements on Monday. A short video of the incident posted on China Coast Guard's social media showed the collision happened around 3:24 a.m. on Monday (1924 GMT on Sunday) and labelled the Chinese vessel as a coast guard vessel. In one of the statements, China's maritime security said the same Philippine vessel then entered waters near Second Thomas Shoal after being prevented from entering Sabina Shoal waters. Two Philippine Coast Guard vessels "illegally intruded" into waters adjacent to Sabina Shoal without permission in the early hours on Monday, according to the China Coast Guard spokesperson Gan Yu.

"The Philippines has repeatedly provoked and caused trouble, violated the temporary arrangements between China and the Philippines," Gan said, referring to Philippines' supplies missions to a vessel grounded on Second Thomas Shoal.

A Philippines Coast Guard spokesman did not immediately respond to a request for comment. China's Coast Guard said it took control measures against the Philippine ships in accordance with the law in the incidents early Monday, and warned the Philippines to "immediately stop infringement and provocation" or "bear all consequences".

## Israeli airstrikes in Gaza kill 29 as Antony Blinken looks to seal peace deal

Gaza Strip. Israeli strikes across Gaza killed 29 people, including young quintuplets, overnight and into Sunday, health officials said, as US Secretary of State Antony Blinken arrived in Israel to try to seal a cease-fire deal that could help ease soaring regional tensions. The US and fellow mediators Egypt and Qatar have said they were closing in on a deal after two days of talks in Doha, with Israeli officials expressing cautious optimism. But Hamas in a statement on Sunday accused Israeli Prime Minister Benjamin Netanyahu of setting new conditions, including his refusal of a complete withdrawal of forces from Gaza. The evolving proposal calls for a three-phase process in which Hamas would release all hostages abducted during its October 7 attack, which triggered the deadliest war fought between Israelis and Palestinians. In exchange, Israel would withdraw its forces from Gaza and release Palestinian prisoners. The war has killed over 40,000 Palestinians, according to local health authorities, displaced the vast majority of the territory's 2.3 million residents and led experts to warn of famine and the outbreak of diseases like polio.

## Cholera outbreak kills 22 in Sudan, more than 350 infected

Cairo. Sudan has been stricken by a cholera outbreak that has killed nearly two dozen people and sickened hundreds more in recent weeks, health authorities said Sunday. The African nation has been roiled by a 16-month conflict and devastating floods. Health Minister Haitham Mohamed Ibrahim said in a statement that at least 22 people have died from the disease, and that at least 354 confirmed cases of cholera have been detected across the country in recent weeks. Ibrahim didn't give a time frame for the deaths or the tally since the start of the year. The World Health Organisation, however, said that 78 deaths were recorded from cholera this year in Sudan as of July 28. The disease also sickened more than 2,400 others between January 1 and July 28, it said. Cholera is a fast-developing, highly contagious infection that causes diarrhoea, leading to severe dehydration and possible death within hours when not treated, according to WHO. It is transmitted through the ingestion of contaminated food or water. The cholera outbreak is the latest calamity for Sudan, which was plunged into chaos in April last year when simmering tensions between the military and a powerful paramilitary group exploded into open warfare across the country. The conflict has turned the capital, Khartoum and other urban areas into battlefields, wrecking civilian



infrastructure and an already battered health care system. Without the basics, many hospitals and medical facilities have closed their doors.

It has killed thousands of people and pushed many into starvation, with famine already confirmed in a sprawling camp for displaced people in the wrecked northern region of Darfur. Sudan's conflict has created the world's largest displacement crisis. More than 10.7 million people have been forced to flee their homes since fighting began, according to the International Organisation for Migration. Over 2 million of those fled to

neighboring countries. The fighting has been marked by atrocities, including mass rape and ethnically motivated killings that amount to war crimes and crimes against humanity, according to the UN and international rights groups.

Devastating seasonal floods in recent weeks have compounded the misery. Dozens of people have been killed and critical infrastructure has been washed away in 12 of Sudan's 18 provinces, according to local authorities. About 118,000 people have been displaced due to the floods, according to the UN migration agency. Cholera is not

uncommon in Sudan. A previous major outbreak left at least 700 dead and sickened about 22,000 in less than two months in 2017. Tarik Jaâaareviâ, a spokesman for WHO, said the outbreak began in the eastern province of Kassala before spreading to nine localities in five provinces. He said in comments to The Associated Press that data showed that most of the detected cases were not vaccinated. He said the WHO is now working with the Sudanese health authorities and partners to implement a vaccination campaign. Sudan's military-controlled sovereign council, meanwhile, said Sunday it will send a government delegation to meet with American officials in Cairo amid mounting US pressure on the military to join ongoing peace talks in Switzerland that aim at finding a way out of the conflict.

The council said in a statement the Cairo meeting will focus on the implementation of a deal between the military and the Rapid Support Forces, which required the paramilitary group to pull out from people's homes in Khartoum and elsewhere in the country. The talks began August 14 in Switzerland with diplomats from the US, Saudi Arabia, Egypt, the United Arab Emirates, the African Union and the United Nations attending. A delegation from the RSF was in Geneva but didn't join the meetings.

## Bangladesh will maintain support for Rohingya refugees, says Muhammad Yunus

Dhaka. Bangladesh will maintain support both for its immense Rohingya refugee population and its vital garment trade, Nobel laureate and new leader Muhammad Yunus said Sunday in his first major policy address. Yunus, 84, returned from Europe this month after a student-led revolution to take up the monumental task of steering democratic reforms in a country riven by institutional decay. His predecessor Sheikh Hasina, 76, had suddenly fled the country days earlier by helicopter after 15 years of iron-fisted rule. Setting out his priorities in front of diplomats and UN representatives, Yunus vowed continuity on two of the biggest policy challenges of his caretaker administration.

"Our government will continue to support the million-plus Rohingya people sheltered in Bangladesh," Yunus said. "We need the sustained efforts of the international community for Rohingya humanitarian operations and their eventual repatriation to their homeland, Myanmar, with safety, dignity and full rights," he added.

Bangladesh is home to around one million Rohingya




Ministry statement. The Ulchi Freedom Shield drills, which continue for 11 days, through August 29, include both computer-simulated war games and more than 40 kinds of field exercises, including live-fire drills. The allies said this year's program is focused on enhancing their readiness against various North Korean threats, including missiles, GPS jamming and cyberattacks and will also reflect lessons learned from recent armed conflicts. About 19,000 South Korean military personnel will participate in the drills, which will be held concurrently with civil defence and evacuation drills from Monday through Thursday that will include programs based on North Korean

nuclear attack scenarios. The US military has not confirmed the number of American troops participating in the drills or said whether they will involve US strategic assets. The United States in recent months has increased its regional deployment of long-range bombers, submarines and aircraft carrier strike groups to train with South Korean and Japanese forces. The drills could trigger a belligerent response from North Korea, which has been flaunting its growing weapons program and issuing verbal threats of nuclear conflict against Washington and Seoul. Earlier this month, North Korean leader Kim Jong Un staged a huge ceremony in the country's capital, Pyongyang, to mark the delivery of 250 nuclear-capable missile launchers to frontline military units and called for a ceaseless expansion of his military's nuclear program. The event added to concerns about Kim's weapons program as he demonstrates an intent to deploy battlefield nuclear weapons along the North's border with South Korea and claims that his military could react with preemptive nuclear strikes if it perceives the leadership as under threat.

## Record rain in Austria causes severe damage, traffic chaos, affect rail services

UPDATED Heavy rains lashed Alpine regions of Austria and left parts of Vienna under water at the weekend, causing severe damage in parts of the country and disrupting road and rail transport, authorities and local media said. Fast-moving torrents of muddy water swept cars through the ski resort of St. Anton, in western Austria, on Friday, footage posted on social media showed. Meanwhile record rainfall hit parts of Vienna in the east of the country on Saturday, state broadcaster ORF said. A woman was dragged under a bus by the force of flooding in the Doebling area in the north of the city on Saturday, ORF said. She



was taken to hospital in a critical condition, it added. Fire services in the capital were called out more than 450 times on Saturday as the downpours

caused traffic chaos and disrupted rail transport, according to ORF. "Heavy storms have done great damage in many parts of Austria," Chancellor Karl Nehammer said on X, thanking officials who were working to clear up the damage. In Vienna's Doebling district, officials registered 110 litres of rain per square metre, which ORF Vienna meteorologist Kevin Hebenstreit said was a record for August rainfall in the city. A large proportion of Vienna's average summer rainfall hit on Saturday in just one hour, according to weather data firm UBIMET. On average in August it rains a total of 68 litres per square metre, with the all-time record being 139 litres on May 15, 1885, according to ORF.

## Ukraine's push into Russia's Kursk to create buffer zone, says Zelenskyy

Kyiv. Ukrainian President Volodymyr Zelenskyy said Sunday the daring military incursion into Russia's Kursk region aims to create a buffer zone to prevent further attacks by Moscow across the border. It was the first time Zelenskyy clearly stated the aim of the operation, which was launched on August 6. Previously, he had said the operation aimed to protect communities in the bordering Sumy region from constant shelling. Zelenskyy said "it is now our primary task in defensive operations overall: to destroy as much Russian war potential as possible and conduct maximum counteroffensive actions. This includes creating a buffer zone on the aggressor's territory — our operation in the Kursk region," he said in his nightly address. This weekend, Ukraine destroyed a key bridge in the region and struck a second one nearby, disrupting supply lines as it pressed a stunning cross-border incursion that began August 6, officials said.

Pro-Kremlin military bloggers acknowledged the destruction of the first bridge on the Seim River near the town of Glushkovo will impede deliveries of supplies to Russian forces repelling Ukraine's incursion, although Moscow could still use pontoons and smaller bridges. Ukraine's air force chief, Lt. Gen. Mykola Oleshchuk, on Friday released a video of an airstrike that cut the bridge in two. Less than two days later, Ukrainian troops hit a second bridge in Russia, according to Oleshchuk and Russian regional Gov. Alexei Smirnov. As of Sunday morning, there were no officials giving the exact location of the second



bridge attack. But Russian Telegram channels claimed that a second bridge over the Seim, in the village of Zvannoe, had been struck. According to Russia's Mash news site, the attacks left only one intact bridge in the area. The Associated Press could not immediately verify these claims. If confirmed, the Ukrainian strikes would further complicate Moscow's attempts to replenish its forces and evacuate civilians. Glushkovo is about 12 kilometres (7.5 miles) north of the Ukrainian border, and approximately 16 kilometres (10 miles) northwest of the main battle zone in Kursk. Zvannoe is located another 8 kilometres (5 miles) to the northwest. Kyiv previously has said little about the goals of its push into Russia with tanks and other armoured vehicles, the largest attack on the country since World War II, which took the Kremlin and saw scores of villages and hundreds

of prisoners fall into Ukrainian hands. The Ukrainians drove deep into the region in several directions, facing little resistance and sowing chaos and panic as tens of thousands of civilians fled. Ukraine's Commander in Chief, Gen. Oleksandr Syrskyi, claimed last week that his forces had advanced across 1,000 square kilometres (390 square miles) of the region, although it was not possible to independently verify what Ukrainian forces effectively control.

### Buffer Zones Sought By Both Sides

In his remarks on creating a buffer zone, Zelenskyy said Ukrainian forces "achieved good and much-needed results." Analysts say that although Ukraine could try to consolidate its gains inside Russia, it would be risky, given Kyiv's limited resources, because its own supply lines extend deep into Kursk would be vulnerable. The incursion has proven Ukraine's ability to seize the initiative and has boosted its morale, which was sapped by a failed counteroffensive last summer and months of grinding Russian gains in the eastern Donbas region. For his part, Russian President Vladimir Putin said while visiting China in May that Moscow's offensive that month in Ukraine's northeastern Kharkiv region was aimed at creating a buffer zone there. That offensive opened a new front and displaced thousands of Ukrainians. The attacks were a response to Ukrainian shelling of Russia's Belgorod region, Putin said. "I have said publicly that if it continues, we will be forced to create a security zone, a sanitary zone," he said.

### Former Kerala HC acting chief justice V P Mohan Kumar passes away at 84

**KOCHI:** Former acting chief justice of Kerala High Court and acting chairperson of the Kerala State Human Rights Commission Justice V P Mohan Kumar, 84, died in Kochi on Sunday. He breathed his last around 5pm at his residence 'Sanjay' at Panampilly Nagar in Kochi. The funeral will be held at Ravipuram public crematorium at 2pm on Monday. Mohan Kumar was appointed as a judge at the Kerala HC in 1994, but was transferred to the



Karnataka HC the same year. He was the acting CJ of the Kerala HC for a period from May 25, 2002, before his retirement. He also led the commission that inquired the 2000 Kalluvathukkal hooch tragedy. He is survived by wife Omana Mohan Kumar, daughter Dr Sangeetha Kodoth (USA) and son Jayesh Mohan Kumar, a lawyer at the Kerala HC. Mohan Kumar was born to Kanhangad native Kumaran Nambiar and VP Karthyayani Amma. He enrolled as a lawyer in 1962 after pursuing a law degree from Government Law College, Ernakulam.

### Sexual assault at Tamil Nadu 'NCC camp', 7 arrested

**KRISHNAGIRI:** A day after an NTK member was booked for allegedly sexually assaulting a Class 8 girl during an unauthorised NCC camp at a private school near Bargur, seven persons, including the correspondent and principal, were arrested on Sunday for allegedly not reporting the crime and conducting the camp without permission. NTK had dismissed A Sivaraman (28) of Kaveripattinam after police booked him under sections 5, 6, 9 and 10 of the PoCoA and section 238 of BNS act. Sivaraman is on the run. The 13-year-old victim stayed at her relatives' house in Bargur. Her school conducted an NCC camp from August 5 to 9 and Sivaraman was one of the coordinators. A total of 41 students, the victim among them, attended the camp. Sources said the Class 8 girl was asked on August 9 to meet Sivaraman at a particular place, where he allegedly sexually assaulted her.

On the same day, the child spoke about the assault to another student. They alerted a few other friends, and they took the matter to the principal, A Sathish Kumar (39) of Thirupattur.

"However, he asked them not to take the matter seriously," a police source said. It was also alleged that Sivaraman allegedly sexually harassed another 12 girls at the camp. On Friday night, the victims' parents lodged a police complaint. The school education department and district child protection unit also initiated inquiries the following day. Sathish Kumar was arrested for trying to conceal the crime.

### Wearing dark shirt, driving car? AI cams in Karnataka fail to spot seatbelt, fine many

**BENGALURU:** A wave of traffic fines for seatbelt violations has swept Bengaluru, Mysuru and other parts of Karnataka, with many drivers claiming that they were wrongly penalised by AI surveillance cameras. Several drivers have taken to social media to express their frustration over receiving challans, despite wearing seatbelts. The challans were issued by the traffic department's new artificial intelligence system, which monitors compliance with safety regulations independently with the help of latest technology. A Facebook profile, going by the name siliconcity.bengaluru, complained, "Bengaluru traffic AI cameras are issuing false seatbelt ticket challans. The false tickets are due to the similar colour of the seatbelt and shirt or coat one is wearing. The issue arises from the cameras' inability to distinguish the two." Another netizen, Prithvi Chandrashekhar, said, "I request people driving cars in Mysuru to check their challans. After seeing this post, I checked my car's challan and, to my surprise, even I have a challan for not wearing a seatbelt from ITMS Udaya Ravi Road (AI-based). "I never drive a car without a seatbelt, and if I try to, my car will not allow me to drive. I believe it's a false challan and request everyone to check theirs. If many are getting such challans, it has to be brought to the attention of the authorities and action should be taken," Prithvi Chandrashekhar said.

## 113 leptospirosis deaths in Kerala so far this year



**KOCHI:** With Kerala receiving heavy rain and several areas witnessing waterlogging this monsoon, there has been a steady rise in the number of leptospirosis cases and related deaths. Many as 113 people have died of the bacterial infection so far this year, the highest in the state in the past five years. More than 50% of the fatalities were reported over the past two months. Kerala reported 1,812 confirmed cases of leptospirosis till August 16 in 2024.

According to Directorate of Health Services (DHS) data, 93 and 103 leptospirosis deaths were reported in the state in 2022 and 2023, respectively. The disease is spread by leptospira, a bacteria present in the urine of several animals. "Chances of leptospirosis spread increase during monsoon because of heavy rain and waterlogging. The rise in cases also indicates poor waste management that leads to an increase in the population of rats and other animals. It needs to be addressed," said Dr Dipu T S, associate professor of infectious diseases in the department of internal medicine at Amrita School of Medicine.

#### Early diagnosis important in preventing rat fever deaths'

Dr Altha A, professor with the department of community medicine at the Government Medical College, Thiruvananthapuram, said the number of leptospirosis cases and deaths in the state has been increasing since



2022. "The leptospira bacteria enters the body through wounds and mucus membrane. Wearing protective gear can help. People also need to maintain personal hygiene to avoid the infection," he said. Dr Altha A said.

Dr Dipu said the state government should launch more initiatives to create public awareness on preventive measures. "When a leptospirosis (rat fever) death is reported, the health department should alert the respective local body to take measures to contain its spread. Preventive medicines (doxycycline) are

available at health centres across the state. The public, especially those at high risk due to exposure to wet soil and water as part of their jobs, should be educated on the preventive measures," he said. Individuals suffering from leptospirosis may experience fever, myalgia (muscle pain) and headache, along with red flag signs and symptoms like tachypnoea (rapid breathing), hypotension, jaundice, etc. Dr Altha A said early detection is important in preventing deaths and more studies should be conducted on the spread of the disease.

## Hyderabad: HYDRAA razes 40 illegal buildings in Gandipet

**HYDERABAD:** Continuing their demolition drive, the Hyderabad Disaster Response and Assets Monitoring and Protection Agency (HYDRAA) demolished around 40 illegal structures constructed in full tank level (FTL) of Gandipet lake on Sunday. Based on the complaints of local people that buildings were constructed illegally in the FTL, HYDRAA Commissioner AV Ranganath directed staff to remove them. The officials of Municipal, Police, Revenue and HMWS&SB participated in the demolition drive. According to officials, the Grama Panchayat accorded permissions to the construction of buildings in 2009. However, the then sarpanch also gave permissions to other buildings with old dates, which was illegal. The HYDRAA said that action will be taken against officials who granted permissions for such buildings in the recent past. These permissions were invalid, said officials.

They advised people to take permissions from municipal officials as per the latest rules, adding that by allowing illegal structures within the FTL of Gandipet, the lake was being polluted by the waste generated by the people living in those illegal structures. If the Gandipet lake is polluted, the people of Hyderabad will have to face drinking water shortage, the officials said.

They further advised against constructing buildings with old dates and taking up any construction activities within the FTL. The HYDRAA further cautioned that people should not buy such illegal constructions.

## A long road ahead for the upgradation of government ITIs in Telangana

### The construction of ATCs has already begun at the ITIs of the three nodal centres — Mallepally campus, Hyderabad, Nizamabad and Khammam — in the state.

**HYDERABAD:** Although the state government has announced its plan to upgrade 65 public Industrial Training Institutes (ITIs) as Advanced Technology Centres (ATCs), the route to development for most ITIs in the district seems longer. In June, the government signed a 10-year MoU with Tata Technologies Limited (TTL) to upgrade 65 ITIs as ATCs in the state with a total investment of Rs 2,324.21 crore. Of this total amount, the state contributed Rs 307.96 crore (13.26 %) and Rs

2,016.25 (86.74%) crore was contributed by TTL. The new course in the ATCs launched by the Department of Employment and Training (DET), under the Ministry of Labour Employment Training & Factories, is set to have six trades with the latest technologies inducted in the coursework. This is to provide hands-on training to the candidates on the world standard technology, against the traditional methods on manual machineries. These trades include


Manufacturing Process Control Automation, Industrial Robotics and Digital Manufacturing, Artisan using advanced tools, Basic designer and Virtual Verifier (Mechanical), Advanced CNC Machining Technician, and Mechanic Electric Vehicle. There will reportedly be 40 seats in each trade, with a total intake of 240 seats in each ITI. After completing the one-year course, candidates will receive the ITI certification with the specific trade they opted for. It will be the same as the

certification given for the already existing ITI courses, by the Directorate General of Training (DGT) of the Centre. However, the implementation of the upgrade plan has several roadblocks before the courses start.

As a part of the MoU signed by the state government with Tata Technologies Limited (TTL), every ITI will have a new ATC attached to it, constructing a new facility with the establishment of new equipment and machinery for the trades.

## Tribal kids' education hit as NRSTCs yet to reopen in Andhra Pradesh

**VISAKHAPATNAM:** Despite the academic year starting two months ago, 81 children from several hilltop tribal villages in Anakapalle district have remained without access to formal education due to the delayed renewal of the Non-Residential Special Training Centres (NRSTCs) for 2024-25. The affected hilltop villages include Buddepadu in Golugonda mandal, Anku in Kotauratla, Mitrasi Colony in Mungapaka, and Pitrugedda in Roulugunta. The NRSTCs, crucial for providing primary education to children living in remote villages, are normally renewed annually. However, the training centres have not been reopened yet this year, leaving the tribal children without regular classes. Tribals deplore undue delay in renewal of training centre



Although these children are enrolled in a mandal-level school, and continue to receive mid-day meals, the lack of appointed teachers due to the pending renewal of NRSTCs, has left them without access to education for the past two months. The situation has sparked concern among the tribal communities, leading to protests. On Saturday, tribals of

Pitrugedda and Neellabandha, two hilltop villages in Arla panchayat, staged a protest, urging the authorities to renew the NRSTC in Pitrugedda. These villages are home to 15 families, with 12 children in the age group of 5-10 years. For these children, attending school means a demanding 20 km round trip to Arla, the nearest village with a functioning school. Last year, after several appeals, a training centre and a teacher were allotted to Pitrugedda. Tribal leader K Govind Rao led the protest. Parents of the affected children expressed their concern over the undue delay in renewing the NRSTC. "It has been two months since the academic year started, but the centre has not been renewed. Our children are receiving mid-day meals, but they are not getting education.

### Thiruvananthapuram corporation special squad seizes unauthorised septic collection lorry

**THIRUVANANTHAPURAM:** A special squad under the City Corporation has seized a vehicle involved in the illegal collection and disposal of septic waste in the state capital. The vehicle was compounded after it disposed of septic waste collected from Uday Suites Hostel into a drain near Vellar around midnight on Saturday. According to civic authorities, the vehicle - registered under the name of Uday Sky Kitchen - has been operating by falsely claiming to be registered with the city corporation. According to officials, the vehicle has been conducting such activities for the past few days. The squad identified the illegal operations of the vehicle during a GPS check of licensed septic vehicles. Following directions from the civic body, the squad conducted an on-site inspection and compounded the vehicle. The civic body will be handing over the vehicle to the district collector after completion of legal procedures.

Currently, the civic body has established a system in place where residents can avail the septic removal services by paying a fee through Smart Trivandrum mobile application or the website. A licensed vehicle will collect the waste at the scheduled time.

There are 36 tankers deployed for the service. The civic body has also granted permission for hotels and establishments to have their own septic collection vehicles, which are permitted to operate under the same system, transporting the waste to Mutathara STP for processing after paying a specified fee to the corporation.

## Public hearing for OMDC's Belkundi mines held in Andhra Pradesh

**The Odisha government has recently allowed a public hearing for the mines, which had been delayed for eight years.**

**VISAKHAPATNAM:** In a significant development, the public hearing of Belkundi Iron and Manganese mines in Barbil, operated by Orissa Minerals Development Company (OMDC) was successfully held on Saturday. The Odisha government has recently allowed a public hearing for the mines, which had been delayed for eight years. The successful public hearing is likely to secure a consistent supply of iron ore to the Rashtriya Ispat Nigam Limited (RINL), addressing a long-standing issue for the steelmaker.

According to OMDC officials, the successful conclusion of the public hearing is the result of years of persistent effort. The Belkundi mines, have a production capacity of 1.8 million tonnes per annum. This development is seen as a crucial step in resolving the iron ore supply challenges faced by the Visakhapatnam Steel Plant (RINL). RINL holds a 26% indirect stake in OMDC through its 51% ownership of Eastern Investment Ltd (EIL), which in turn owns a 51% stake in OMDC. The successful reopening of the Belkundi mines is expected to significantly benefit



Odisha government refused to renew the lease for the mines, leading to a ₹700 crore fine by the Supreme Court for legal violations and exceeding production limits. Despite paying the fine, OMDC's subsequent attempts to renew the lease were unsuccessful until now. "The recent success is largely attributed to the concerted efforts of RINL's management, particularly the Director of Projects and

Operations, Project & Works Division, and the dedicated officers of OMDC. Special recognition is given to UN Behera, General Manager (D&E) In-Charge of OMDC, and his team, who have been actively engaging with the Odisha government, local leaders, and organisations to ensure the success of the public hearing," stated SEA general secretary KVD Prasad. He further explained that following the hearing, the Odisha government is expected to formally communicate the application minutes to the Union Government and the Ministry of Steel (MoS). "The next steps will involve seeking forest and environmental clearances, a process that may take up to nine months. Once completed, this development will represent a significant asset for RINL," he noted.

Chandra Rao and Prasad elaborated on the importance of this development, emphasising that it will play a key role in securing the raw material needs of the Visakhapatnam Steel Plant, bringing much-needed stability to its operations.

## The curious case of brown bears in Kargil and Kashmir

In the spring of 2016, I embarked upon a trek in the mountains of Drass to look for and, if possible, photograph the elusive brown bear. As the Wildlife Warden of Kargil district in Jammu and Kashmir (now in Ladakh), I had received reports of cattle depredation by the bears around Drass and we were tasked with compensating the losses. Although bear appearances — often in the shape of night raids on the feebly secured cattle sheds — were frequent in the villages, a worthwhile daytime sighting in the 'wild', which I was interested in, was still a big ask. My guide, the local Ranger, well versed with the area, was confident though. Weighing up to 300 kg, brown bear is the largest land carnivore in the world. The Himalayan brown bear, inhabiting the western Himalayas from Kargil through Kashmir, Himachal and Uttarakhand, is smaller than its cousin — the Grizzly Bear of North America and Europe — and rarer to sight. A decade back, it was so difficult to see a Himalayan brown bear in the wild in our part of its range, that you could count those who had done so on your fingers!

We had started at daybreak and after a two-and-a-half-hour trek up a hill, in arguably the world's second coldest inhabited place, we arrived at a plateau, which I was told was the best location to sight the brown bear. I scanned the area with my binoculars and could see a vast tract of green meadows interspersed with patches of snow from the past winter, but no trace of the bear. We sat down beside a large rock to shield ourselves from the morning chill while we had our breakfast. Just as I rose up after finishing mine, and glanced casually over the rock, I saw, what appeared to my naked eye, a small herd of cattle grazing at the far end of the meadow. The uniform brownish colour of all the individuals in the herd made me curious and when I picked my binocs to have a better look, I was stunned to see as many as eight brown bears, three adults and five young ones of different age groups, grazing nonchalantly! I grabbed my camera to capture this spectacle, but the bears somehow sensed our presence and took off at an astonishing pace. I still managed to get six of them in the frame. Back then, I could not have imagined that the image, which through social and print media was flashed across the country, would be a precursor in turning Drass into a favourite destination for the brown bear seekers, as it has become today. Around the same time, brown bear sightings also started to become common in the Kashmir valley. During my journey from Kargil to Srinagar a few weeks later, I saw a mother bear with two cubs crossing the highway near Sonamarg. In the summer of 2017, when I was posted in south Kashmir, my staff rescued a cub from a langar camp en route to the Amarnath cave. The young one had stuck its head in a discarded ghee canister, which had to be torn open to free the poor fellow. In the following years, while Drass became a famed hotspot for brown bear viewing, sightings in Kashmir, from north to south, were reported like never before.

A camera trap installed in the Hirpora Wildlife Sanctuary in Shopian district captured a female with two cubs on a sheep carcass. A friend of mine, an avid nature lover, clicked a prime male while birding in the forests of Budgam and another recorded a huge one on his cellphone cam on a garbage dump in Gurez, Bandipora.

Increased brown bear sightings across Kargil and Kashmir over the past seven to eight years may seem to be an encouraging sign, but conservationists would advise you to take it with a pinch of salt. As I noticed in Drass later, the bears were attracted to a roadside landfill site where a local Army camp dumped its kitchen refuse. The animals would take the same route to visit the site almost every night and return to the forest by dawn. They were so punctual that you certainly would encounter one, if you were on their trail about sunrise. In Sonamarg, as also in Gurez, it's the garbage, primarily the biowaste from hotels and restaurants, that is responsible for a high bear 'encounter rate'.

JAMMU and Kashmir's decade-long wait for the Assembly polls is over, with the Election Commission announcing a three-phase polling schedule for the state-turned-UT. President's rule, abrogation of Section 370, bifurcation of the state — J&K has seen it all. The delimitation exercise necessitated by the reorganisation has altered the electoral landscape — the Jammu region's seat count has risen sizeably from 37 to 43, while the number of Assembly constituencies in Kashmir has gone up from 46 to 47. This will have a bearing on the election outcome and pre- or post-poll alliances.

The upcoming poll battle will be held against the backdrop of a series of terror attacks and encounters in the Jammu region. Terrorists have changed tack: they are targeting Hindu-dominated areas, while Muslim-majority Kashmir is no longer the epicentre of turbulence. In view of this shift, there is greater pressure on the BJP-led Central Government to ensure peaceful campaigning and polling. Elements inimical to India will try to disrupt the proceedings. The key is to create an environment

## Mamata Banerjee's political rhetoric is meaningless when women in Kolkata continue to live in fear, exposed to violence and exploitation. Enough with the empty promises — what Bengal needs is real action

The recent rape and murder of a postgraduate trainee doctor at Kolkata's RG Kar Medical College is a damning indictment of West Bengal's hollow claims of safety for women. This atrocity, committed within the walls of a medical institution, lays bare the state's failure to protect its citizens. Despite Chief Minister Mamata Banerjee's repeated assertions that West Bengal is the safest state for women, this horrific crime exposes the administration's blatant incompetence and disregard for women's safety. The police response has been nothing short of disgraceful, marked by glaring discrepancies in their actions. The Calcutta High Court's order for an immediate CBI probe underscores the state's despicable attempts to shield the real culprits. The police didn't even inform the victim's family of the rape and murder initially, instead concocting a false narrative and allegedly trying to "settle" the matter internally. This is not just negligence; it is a wilful betrayal of justice. Mamata Banerjee's political rhetoric is meaningless when women in Kolkata continue to live in fear, exposed to violence and exploitation. The state's safety measures are a cruel joke, fostering a culture of impunity where criminals walk free and victims suffer in silence. Enough with the empty promises — what Bengal needs is real action. The state government must overhaul its approach to women's safety, from enforcing stringent law enforcement to providing a robust support system for victims.

This tragedy cannot become another statistic in India's grim record of gender-based violence. The public demands justice, not just for this victim, but for a safer future for all women. The question remains: will the government act decisively, or will it continue to fail its people? The clock is ticking. On August 9, 2024, the body of a postgraduate trainee doctor was tragically found in a seminar room at RG Kar Medical College and Hospital in Kolkata. The young doctor had been brutally assaulted, with an autopsy later confirming that she had been raped and murdered. Sanjay Roy, a civic volunteer associated with the Kolkata Police, was arrested the following day after police reviewed CCTV footage from the hospital. The autopsy revealed the horrific nature of the attack. The victim had multiple injuries, including severe trauma to her face, abdomen, throat, and genitals. There was evidence of bleeding from her eyes and mouth, and shards of glass were found in her eyes, indicating the sheer brutality of the assault. Additional injuries were noted on her belly, neck, left leg, right hand, and ring finger, along with deep nail marks on her back. The investigation suggested that the murder took place in the early hours of August 9.

Sanjay Roy, who had a history of violent behaviour and was

reportedly addicted to pornography, confessed to the crime. He struck the victim with such force that her glasses shattered, driving shards into her eyes. After committing the heinous act, Roy returned to a police barrack and slept until the next morning. Police reconstructed the crime scene and gathered crucial evidence, leading to Roy's swift arrest.

This shocking incident has ignited widespread outrage and protests among junior doctors, trainee doctors, and

the Central Bureau of Investigation (CBI) was a scathing indictment of the local police's abject failure. The court's criticism of significant lapses by hospital authorities and the police's handling of the case highlighted the need for a competent and impartial investigation.

The people have no doubt that the police investigation was a botched and nonsensical exercise, characterised by mishandling of evidence, reliance on weak circumstantial evidence, and a lack of coherent strategy. This has not only delayed justice but also eroded public trust in law enforcement agencies. It is imperative that the CBI conduct a thorough, transparent, and impartial investigation to ensure justice is served and such lapses are not repeated.

### A CASE MARRED BY NEGLIGENCE AND ALLEGATIONS OF A COVER-UP

Allegations have emerged suggesting that the authorities may have attempted to shield the real culprits, further eroding public trust. The hospital administration, too, has faced scrutiny. Students have accused officials of neglecting repeated calls for enhanced security, with the removal of the hospital superintendent viewed as a reactionary measure. The swift reappointment of the former principal, amidst protests, has fuelled suspicions of a cover-up.

The TMC government's reluctance to transfer the case to the CBI until public and judicial pressure mounted only deepens these concerns. As the case now moves to the CBI, there is an urgent need for a thorough and impartial investigation to restore public confidence.

### MAMATA BANERJEE'S POLITICAL RHETORIC MUST STOP

The tragic rape and murder of the postgraduate trainee doctor has exposed a grim reality in West Bengal: the failure of the Mamata Banerjee-led TMC government to ensure safety in the state's institutions. Instead of confronting the grave lapses in security and governance, Mamata Banerjee and the TMC have resorted to political rhetoric and blame-shifting, further aggravating public outrage. Banerjee, who holds dual responsibilities as chief minister and health minister, has a direct duty to protect citizens, especially within state-run institutions like RG Kar Medical College. Yet, her response to this horrific crime has been to deflect blame and downplay the systemic failures under her administration. This strategy of political deflection cannot absolve Banerjee of responsibility. As the leader of the state, she must acknowledge the shortcomings in her administration, take decisive action to prevent such incidents in the future, and restore faith in her leadership. Anything less is a betrayal of the trust placed in her by the people of West Bengal.



medical students, all of whom are demanding stronger security measures and justice for the victim. The case has also cast a harsh light on the safety of women in West Bengal, raising serious questions about the effectiveness of the current administration's efforts to protect them.

### BOTCHED UP POLICE INVESTIGATION

The heinous crime has sent shockwaves across the nation, laying bare the grotesque ineptitude of the police investigation. This travesty has not only failed the victim and her family but also exposed the systemic rot within the law enforcement agencies. From the outset, the investigation was a catastrophic mess, marred by staggering negligence and incompetence. The police's failure to secure the crime scene promptly allowed crucial evidence to be potentially tampered with. The arrest of Sanjay Roy was based on flimsy CCTV footage and a dubious confession extracted under the influence of alcohol. The lack of rigorous forensic analysis and reliance on circumstantial evidence raised serious doubts about the investigation's integrity.

The police's inability to provide a coherent timeline of events further eroded their credibility, with conflicting statements from hospital authorities and the police adding to the confusion. The Special Investigation Team (SIT) seemed more focused on damage control than uncovering the truth.

The Calcutta High Court's decision to transfer the case to



your own family or clan where the older generation can rule by dictating rules and regulations only up to a point. If parents do not try and understand the reasons for the children revolting against these inflexible boundaries, the result is misery all around. I have so many cousins and friends who say they don't understand how their children can be so difficult when the truth is that very often, they are the ones who are more pig-headed than their progeny. August 15 is always a good time to remember Gandhiji. As I look around the angry world, I cannot help

recalling Einstein, who said of him that generations later, the world will not believe that such a man walked the earth. As children, we all sang 'De di hamein azadi bina khada bina dhal, Sabarmati ke sante tune kar diya kamaal' lustily on each Independence Day. However, non-violence is now almost a forgotten lesson even in the land Gandhi practised it, so what can one say of others. Taking grievances to the streets is a call every party gives to its followers and then looks on as they wreck public property, homes and religious places. For the time that they are part of a mob, individual identity is subsumed into that of a collective anger and a red cloud of rage in their eyes.

Yet, I often wonder how soldiers who shoot women and children, pilots who bomb cities, rapists, mass murderers or assassins and such goons sleep at night. Are they not haunted by the images of destruction that flash as soon as they shut their eyes? Whether they are ever caught and punished by law or whether they escape into anonymity, never forget that crime and punishment are bound by their own cycle of retribution. As my mother wrote once, there is no spirit so free whose feet are not bound by the chains of one's own conscience. In Christianity, a dying man is offered the choice of a last confession before a priest, so that he can die with a clear conscience after confessing and atoning for any wrongs he may have committed. Even as we hoist the National Flag at every home, lustily shout 'Bharat Mata ki Jai!', wave party flags to terrorise our neighbours and teach the young to hate the enemy out there, what about the enemy within? Are lessons of truth, ethics, civics, respect for all forms of life, reasonableness and helpfulness even taught in most schools now? High-minded slokas and mantras are a shortcut we have adopted to replace moral science. Selfishness, greed and envy are a severe handicap as they deal with the fiercely competitive life that we pitch our young into. Helping someone before grabbing your share, being kind to strangers, treating the elderly and weak with compassion — these are values children learn by seeing their family and peer groups in school. They have to be practised before they can be preached. Gandhiji instilled these values in all the people whose lives he touched, because he himself never deviated from the tough standards he expected of his followers. What is unfolding in Kolkata — ironically in a hospital in the heart of a city that worships the Devi in every corner for nine days each year — is unacceptable. Any society that allows such crimes is sick beyond repair.

# Trinamool claims BJP 'hijacking' Kolkata murder protests to topple government

 Kolkata rape case: The Trinamool Congress alleged that BJP was running a "sinister" toolkit campaign to topple the West Bengal government amid outrage over the rape and murder of a trainee doctor at RG Kar Medical College and Hospital.

NEW DELHI. The Trinamool Congress on Monday alleged that the BJP had "hijacked" the protests over the rape and murder of a 31-year-old trainee doctor at Kolkata's RG Kar Medical College and Hospital. MP Saket Gokhale alleged that a "sinister toolkit" campaign was aimed at toppling the West Bengal government over the incident. In a long post, Gokhale claimed that BJP's IT cell was running an "organised campaign", calling for the resignation of Chief Minister Mamata Banerjee. He said the party made 'Mamata must resign' trending on social media after the CBI took over the case on August 15. "BJP has unleashed a sinister toolkit in Bengal. The agenda is focused - to topple the government. There's an organised campaign being run by BJP by trending 'Mamata Must Resign'. A genuine protest has been hijacked entirely by BJP,"

Gokhale tweeted. The Trinamool Congress leader said there were "zero updates" from the CBI after taking over the case. He alleged that BJP leaders and workers had "hijacked" the protests over trainee doctor's rape and murder by replacing "genuine protesters".

"It's been 5 days since CBI took over the case and there's zero updates. But not a single protest has been done against the CBI. Genuine protesters have now been replaced by BYJM and BJP workers on the streets of Kolkata," he said. Gokhale claimed that BJP trended the 'Mamata Must Resign' hashtag and said that "more than two lakh posts were made in four days", using the hashtag, "with a reach of over 91 million". He alleged that people or



"genuine protesters" were not using the 'Mamata Must Resign' hashtag and claimed that such figures attained were "impossible for ordinary accounts". In their own words: the only agenda is toppling the government. The hashtag BJP has been trending is 'Mamata Must Resign', he tweeted.

Sharing a screenshot of the spike in traffic over the use of hashtag by various accounts, Gokhale alleged that the hashtag was being amplified by using bot accounts in various countries.

He claimed that nearly 45 per cent of posts having 'Mamata Must Resign' hashtag were from the US and from other countries, including Russia, Eritrea, Nigeria, Colombia and Suriname. Accusing the CBI of being hand-in-glove with the BJP to "hijack" the protests, Gokhale said the Trinamool Congress will give a befitting reply to what he called the saffron party's "conspiracies".

"The BJP has hijacked the protests and turned them into an agenda for toppling the Bengal government.

The CBI has been silent for five days just to

help BJP run conspiracies. This 'toolkit' of BJP+CPM to destabilise Bengal will get a befitting response. We will not allow justice to be derailed," he alleged.

## KOLKATA TRAINEE DOCTOR'S RAPE-MURDER

The semi-naked body of the trainee doctor, who was a second-year postgraduate student at RG Kar Medical College and Hospital, was found in the seminar hall of the hospital on August 9. An accused, Sanjoy Roy, a civil volunteer with the Kolkata Police, was arrested in connection with the gruesome incident. Protests broke out in Kolkata and other parts of the country soon after, demanding capital punishment for the culprits and measures to improve the security of doctors working in hospitals. The CBI took over the case from the Kolkata Police after intervention by the Calcutta High Court.

## AIADMK claims 'hidden pact' in Tamil Nadu on Karunanidhi Centenary coin release

A political showdown is brewing in Tamil Nadu as, ahead of M Karunanidhi's Centenary Year coin release, the All India Anna Dravida Munnetra Kazhagam (AIADMK) has alleged a 'hidden pact' between the long Dravida Munnetra Kazhagam (DMK) and the BJP. Former Tamil Nadu Chief Minister Edappadi K Palanisamy said that as a part of the hidden pact between the DMK and BJP, Chief Minister MK Stalin's party agreed to participate in Governor's high tea for Independence Day in return for the BJP taking part in the coin release ceremony.

"DMK announced that it will not take part in High Tea. But when Annamalai said that he would take part in the coin release function and asked DMK to take part in high tea, immediately, Stalin participated while DMK released a statement claiming that he was representing the Tamil Nadu Government and not DMK.

Isn't this funny as Stalin is the Head of DMK and Duraimurugan, who is the General Secretary of DMK participated. So, this is only showing the 'two-faces' of the party. This only shows their relationship", Palanisamy said in a briefing to the media in Salem. He said this many times. It was being said that there was a secret relationship between DMK and BJP, even our administrators were saying so. Now the media has also started to raise this question. So it has come to light that the BJP and DMK have a secret relationship", Palanisamy added.

Even a post on X by AIADMK's IT cell said, "Tamil Nadu BJP state president said we are attending the coin launch ceremony and you attend the Governor's tea party and the DMK left the boycott decision and participated in the party. DMK is a party playing a double role. DMK's secret relationship with BJP is evident from this".

**New Delhi:** A dental student at the Post Graduate Institute of Medical Sciences (PGIMS) in Haryana's Rohtak has alleged that she was kidnapped and assaulted by a resident doctor. Police filed a case, and arrested the accused. Speaking with India Today TV, Rohtak's Deputy Superintendent of Police, Virendra Singh, stated that a first-year BDS student from PGIMS lodged a complaint on Sunday night, alleging that she was kidnapped and physically assaulted by the doctor, an MD (anatomy) student.

According to the student's complaint, on August 16, the accused kidnapped her from PGIMS and took her to



Ambala and Chandigarh, where he assaulted her. No evidence of sexual harassment or rape has emerged from the victim's statement or the investigation until now, the police stated.

In a video that emerged on social media platform X, the woman is seen crying and showing the wounds on her body caused by the alleged assault. In the video, she claimed that the resident doctor has been harassing her for the last seven months. She also alleged that the accused threatened her with dire consequences if she raised the issue with college authorities. According to reports, PGIMS expelled the accused doctor and debarred him from entering the college premises. The incident comes amid nationwide protests by doctors and the medical fraternity after the brutal rape and murder of a trainee doctor at a state-run hospital in Kolkata.

Born on December 5, 1940, in Trivandrum, Kerala, General Padmanabhan had a remarkable career that spanned over 43 years, culminating in his tenure as Chief of Army Staff from September 30, 2000, to December 31, 2002. An alumnus of the prestigious Rashtriya Indian Military College (RIMC) in Dehradun and the National Defence Academy (NDA) in Khadakwasla, Pune, General Padmanabhan was commissioned into the Regiment of Artillery on December 13, 1959, after graduating from the Indian Military Academy (IMA). Throughout his career, General Padmanabhan held several prestigious command, staff and instructional positions. He

commanded the Gazala Mountain Regiment, one of the oldest artillery regiments of the Indian Army, and served as Instructor Gunnery at the School of Artillery in Deolali. ## "Makes Muslim Women's Condition Pathetic": Centre On Triple Talaq In Supreme Court

**The counter-affidavit was in response to a petition arguing that since the Supreme Court had invalidated the practice of 'triple talaq' there is no need to criminalise the same.**

**New Delhi:** The practice of 'triple talaq' is "fatal for the social institution of marriage" and "makes Muslim women's condition very pathetic", the government argued Monday in an affidavit filed before the Supreme Court.

The government said the top court's setting

aside of the practice - that had been held valid among certain Muslim communities - in 2017 had "not worked as a sufficient deterrent in bringing down the number of divorces by this practice" among members of those communities.

"Victims of 'triple talaq' have no option but to approach the police... and the police were helpless as no action could be taken against husbands in the absence of punitive provisions in the law. In order to prevent (this) there was an urgent need for stringent (legal) provisions," the government said.

The government's affidavit was in response to a petition arguing that since the Supreme Court had invalidated the practice of 'triple talaq' there is no need to criminalise the same.

The original affidavit was filed earlier this month by the Samastha Kerala Jama'atul Ulema, which describes itself as "an association of eminent Sunni scholars". Among other points, the petitioner called the Muslim Women (Protection of Rights

on Marriage) Act, 2019, is unconstitutional.


The petitioners argued that the Act violates fundamental rights, including those that guarantee Indian citizens equality before



law and prohibits discrimination on grounds of religion. In a detailed response made public this morning the government firmly dismissed the petitioners' claims, arguing that the practice of 'triple talaq' "violates fundamental rights and rights of equality guaranteed to women under the

Constitution". The Parliament, in its wisdom, enacted the impugned Act to protect rights of married Muslim women being divorced by 'triple talaq', and the law in question helps ensuring the larger constitutional goals of gender justice and equality of married Muslim women, the affidavit added. The government also pointed out the Supreme Court itself has held in the past that it cannot go into the wisdom of laws passed by Parliament or enter into discussions as to what the law should be. "It is the function of the legislature alone to determine what is and what is not good and proper for the people of the land and they must be given widest latitude to exercise their functions within the limit of their powers else all progress is barred..." the government argued. Whether or not a particular type of conduct ought to be criminalised, and what punishment is to be imposed for such conduct is to be determined by the legislature in light of prevailing

#### 1. Throw away your measure tapes

Measuring your bust is not the key to getting a great fit. Stand by the mirror and start by taking a look at how your bra fits you and then consider whether you need to adjust your back size or cup size following steps 2 and 3.

#### 2. Find the right back size (28-40)

The back size relates to how the bra fits around your body. The band around your body provides most of the support, so it should be firm but comfortable. It should be horizontal and not ride up at the back at all. If it is loose, or it rides up at the back, try a smaller back size (but remember to increase your cup size). Your bra will stretch with wash and wear, so we recommend a new bra that fits you when fastened on the loosest (outside) hook.

#### 3. Find the right cup size (D-L)

The cup size relates to the volume of your breasts.

The wires at the front should lie flat against your rib cage and should not dig in, rub or poke out at the front.

Your breasts should be enclosed in the cups and you should have a smooth line where the fabric at the top of the cup ends and meets your bust. You shouldn't have any ridge or bulging over the top or sides of the cups, even if you are wearing a balconette style or lower cut shape.



## Gold, silver price Precious metals record hike on MCX

**NEW DELHI** Both gold and silver prices recorded a hike on the Multi Commodity Exchange (MCX) on Monday, August 19, 2024. Gold futures, maturing on October 4, 2024, stood at Rs 71,590 per 10 grams on the MCX, after recording a jump of Rs 215 or 0.30 per cent. The previous close was recorded at Rs 71,375. Meanwhile, silver futures, maturing on September 5, 2024, witnessed a marginal hike of Rs 609 or 0.73 per cent and were retailing at Rs 83,634 per kg on the MCX against the previous close of Rs 83,025. Global demand also plays a key role in determining the trends observed in the rate of precious metals.

Gold prices eased on Monday and hovered around key \$2,500 level, as traders locked in profits following bullion's climb to an all-time peak in the previous session on expectations of a U.S. interest rate cut next month, news agency Reuters reported.

According to the latest metal report, spot gold dipped 0.2 per cent to \$2,502.78 per ounce by 0352 GMT, while, U.S. gold futures gained 0.2 per cent to \$2,541.80.

## The Kaiser and his link to balanced advantage funds

**New Delhi,** Franz Beckenbauer was among those rare footballers who won a World Cup, both as a player and as a coach. The 'Kaiser' as he was known as was the first to add an angle of offense to the conventional defensive position of a sweeper on the football field. He was that rare 'all rounder', who had both, the ability to move forward to attack as well as fall back to defend. Investing in many ways is no different and Balanced Advantage Funds (BAFs) offered by mutual funds are the investment equivalents of mid-fielders.

The underlying theme that emerges is that be it the football field or that of investments, it is necessary to blend caution with aggression and respond appropriately based on the situation. In the past, Balanced Funds (now renamed Hybrid Equity Funds) gained in popularity and rewarded investors seeking the risk profile it offered, fairly well. But the fact remained that with no upside equity holding restriction, some AMCs were running it literally like a pure equity fund thus exposing investors to higher risk than they had signed up for. SEBI's classification of funds helped address this issue to an extent.

But, in more recent years and post the creation of this new category of hybrid funds more than half a decade ago, Balanced Advantage Funds (BAFs), which are inherently open-ended dynamic asset allocation funds, have also become popular. It seeks to use time-tested mechanisms using a hybrid investment model to capture equity upside even while casting a safety net on the downside. The corpus of a BAF is allocated dynamically between equity and debt securities, based on certain pre-determined market valuation and analysis tools. Some AMCs use the Price to Earnings (P/E) Ratio while others use the Price to Book (P/B) Ratio as their base for determining the asset allocation mix. Then there are some that use a kind of hybrid model, incorporating both, boosted further by trend analysis. For the sake of easier comprehension, let us assume that a BAF starts off by investing 33% in pure equity and 33% in arbitrage to keep gross equity investments at or above 65% while investing the rest in debt securities. Their long-term gains thus attract Equity taxation of 10% as against Debt taxation of 20% (with indexation).

## Why building risk appetite needs education

**NEW DELHI.** There is a visible increase in your participation in equity markets. The latest data on ownership of Nifty 500 index companies shows that individual investors, who are not promoters, own 8.7% of the total market cap of over R400 lakh crore. In addition, domestic mutual funds now own 9.6% of that value. While direct individual ownership has remained the same over the past three years, the data shows an increase in the ownership of mutual funds in the Nifty 500. That shows that you directly and indirectly control a sizeable chunk of the equities market. The rising inflows in the systematic investment plans (SIPs) pushed by mutual funds create a cushion for share prices. The money designated for equity markets will be invested based on the valuation parameters. Active managers can hold back putting in the money if valuations are too high. But not for long. They must eventually deploy it. That ensures that you will have mutual funds or local investors picking up equity shares at every sharp fall in equity markets due to a global sell-off. If you are not familiar with the world of finance, it would be hard for you to connect the dots. # RIL plans to make JioCinema its only OTT platform post Disney merger: Report

**New Delhi** Reliance Industries Limited (RIL) is planning to operate just one over-the-top (OTT) platform—JioCinema, following the proposed merger with Star India's Disney+ Hotstar, reported The Economic Times. This decision by RIL is seen as a move to consolidate content and resources into a single, more robust platform, streamlining its services. Currently, Disney+ Hotstar, owned by Walt Disney's Star India, is one of India's most popular streaming services, with over 500 million downloads on the Google Play Store. In comparison, JioCinema, under Viacom18 (a company controlled by RIL), has over 100 million downloads.

Despite Disney+ Hotstar's larger user base, RIL is considering combining its content with JioCinema to create a stronger, unified platform. The idea behind this is to reduce operational costs and enhance efficiency by not running two separate streaming services. The combined platform would be better positioned to compete with global giants like YouTube, Netflix, and Amazon Prime Video. This development comes after RIL and Walt

Disney signed a deal earlier this year to merge Star India and Viacom18, forming a media conglomerate valued at around \$8.5 billion. The merged entity would control over 100 TV channels and two OTT platforms, but RIL appears to favour focusing on just one platform—JioCinema. The merger is still awaiting regulatory approval from bodies such as the Competition Commission of India (CCI) and the National Company Law Tribunal (NCLT). To mitigate concerns about the new entity's market dominance, RIL is also open to the idea of shutting down some Hindi and regional language TV channels. According to RIL's 2023 annual report, JioCinema had an average of 225 million monthly users, while Disney+ Hotstar had 333 million active users in the last quarter of 2023.

However, Disney+ Hotstar has seen a significant drop in its paid subscriber base, falling from 61 million at its peak to

35.5 million as of June 2024. This decline is partly attributed to the loss of streaming rights for popular content, including the Indian Premier League (IPL) and HBO shows. Despite the challenges faced by Disney+ Hotstar, JioCinema has been rapidly gaining traction, especially after securing digital rights to the IPL, which brought record-breaking viewership to the platform. RIL's chairman Mukesh

Ambani has pointed to this success as evidence of JioCinema's potential to attract large audiences quickly. Should the content from Disney+ Hotstar be merged into JioCinema, the latter could emerge as India's largest streaming service, offering a vast library of over 125,000 hours of entertainment, sports, and Hollywood content. This new platform would include important sports rights, such as the IPL, along with content from major studios like Disney, HBO, NBCUniversal, and Paramount Global. RIL has a history of consolidating its digital assets to strengthen its market position. For instance, the company previously merged other streaming services, like Voot, into JioCinema. Recently, JioCinema was transferred to Viacom18 following a court-approved deal that also involved a Rs 15,145 crore investment from RIL and Bodhi Tree Systems into Viacom18.

92% in just six sessions since their listing on August 9. The stock was initially listed at Rs 76, the same as its issue price. Since then, the stock has hit the upper circuit in four out of the six trading sessions. Ola Electric reported a consolidated net loss of Rs 347 crore for the quarter ending June 30, 2024. This represents a 30% increase in losses compared to Rs 267 crore in the same quarter last year. Despite the losses, the company saw its revenue from operations rise by 32.3% year-on-year, reaching Rs 1,644 crore for the quarter. The company's EBITDA (Earnings Before Interest, Taxes, Depreciation, and Amortisation) loss for the quarter stood at Rs 205 crore.

Will the rally continue? Global brokerage firm HSBC recently initiated coverage on Ola Electric following its Q1 results and subsequent conference call. HSBC gave a positive outlook on the company's future, issuing a 'buy' recommendation. The firm believes that the cost of manufacturing electric vehicles (EVs) could decrease significantly by FY27/28, while the cost of internal combustion engine (ICE) scooters may increase due to stricter emission standards. HSBC also noted that while the barriers to switching to electric two-wheelers (e2-wheelers) may decrease, Ola's battery venture could be a key factor in the company's success. The brokerage firm views Ola Electric as a promising opportunity, given the ongoing regulatory support, potential cost reductions, and a favourable risk-reward profile for the battery venture.



Hindalco emerged as the top gainer, surging by 2.93%. Following closely was BPCL with a 2.86% increase. Shriram Finance also showed strong performance, rising by 1.90%. ONGC and NTPC rounded out the top gainers, advancing by 1.88% and 1.81% respectively. Mahindra and Mahindra led the losers, dropping by 1.60%. Apollo Hospitals experienced a

decline of 1.06%, while HDFC Life fell by 1.00%. Axis Bank and Tata Consumer Products also saw declines, with their shares decreasing by 0.86% and 0.85% respectively. The sharp dip in the dollar index to 102.4 might nudge the FIIs to invest in India but the lofty valuations have been forcing them to sell. How the FIIs will address this contradiction remains to be seen. The sharp rally in gold prices is positive for gold-jewellery and gold loan companies," said Vijayakumar. ## Sensex, Nifty open in green on energy stocks rally; BPCL gains 3%

**New Delhi,** Benchmark stock market indices maintained their momentum from the last trading session and opened higher on Monday driven by gains in energy stocks. The S&P BSE Sensex gained 166.14 points to 80,602.98, while the NSE Nifty50 added 70.30 points to 24,611.45 as of 9:50 AM. Dr V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services said that the 397 point rally in the Nifty last Friday reinforces the resilience of the ongoing bull market and the consistent success of the buy on dips strategy. "The fact that this ability of the market to bounce back is happening when valuations are elevated is significant. It is also important to note that all corrections in this rally have been brief unlike in the past when corrections have been prolonged. The complete dominance of the DII and retail investors over the

"We are forming a Project Management Unit (PMU) that will set daily targets, which will be monitored by the Secretary and myself. I assure you we are working to expedite the process," said Jyotiraditya Scindia. State-run BSNL lost 18 mn customers in FY24.

While private telecom providers such as Reliance Jio, Bharti Airtel, and Vodafone Idea Limited are rolling out their 5G services, BSNL has primarily been offering 2G and 3G networks. Consequently, the telco has been losing subscribers to private operators. The telco lost 18 million customers in the last fiscal year.

## Real Madrid's problem mental, not physical: Ancelotti slams team after draw

**New Delhi** Real Madrid manager Carlo Ancelotti was left visibly frustrated after his team's lackluster performance in their 1-1 draw against Mallorca in the LaLiga season opener. Ancelotti attributed the team's struggles to mental lapses rather than physical fitness issues. Ancelotti said his players lacked focus after taking an early lead through Rodrygo in the 13th minute but allowing Mallorca to rescue a point with a Vedat Muriqi header after the break. "Today I am not happy. I think we could have been done much better," Ancelotti said in a post-match press conference. "We need to be more concentrated, work better as a group... It's not a fitness problem, it was mental. I don't want to make excuses for anything. We had to do better and show more attitude."

Ancelotti was particularly critical of his team's defensive performance, emphasising the need for a more disciplined approach. He suggested that Real could have easily lost due to their own blunders and urged his players to learn fast from Saturday's mistakes. "We started the game well, we took the lead and we had chances to score the second, but in the second half we lacked



balance," he noted. "It was a game we could have lost because we didn't have balance. It wasn't a good game. We are a very attacking team and defensive balance is a fundamental part of the way we are built." The coach highlighted the importance of collective commitment in defence, stating that the team's inability to win the ball back and press after losing possession was a key issue. "When we talk about defending, we are talking above all about collective commitment. The balance is found with the players thinking about the same thing. When we have to win the ball back we have to think about it all together," Ancelotti explained.

Ancelotti's comments underscored the need for Real Madrid to quickly address these mental and tactical issues if they are to succeed in the season ahead.


