PM Modi arrives in Poland, 1st visit by Indian Prime Minister in 45 years

Warsaw, August 21: Prime Minister Narendra Modi on Wednesday arrived in Poland on the first leg of his two-nation visit during which he will also travel to the Ukrainian capital Kyiv and share perspectives with President Volodymyr Zelenskyy on a peaceful resolution of the Ukraine conflict. Prime Minister Modi's visit to Poland is



the country in the past 45 years. During his stay in Poland, Modi will meet President Andrzej Sebastian Duda and hold bilateral talks with Prime Minister Donald Tusk. "My visit to Poland comes as we mark 70 years of our diplomatic relations. Poland is a key economic partner in Central Europe," he said. "Our mutual commitment to democracy and pluralism further reinforces our relationship. look forward to meeting my friend Prime Minister Donald Tusk and President Andrzej Duda to further advance our partnership,' Modi said in his departure statement earlier today. "I will also engage with the members of the vibrant Indian community in Poland,"

Modi said. Prime Minister Modi's discussions with the Polish leadership during his two-day visit will allow the two sides to exchange views at the top level on a variety of subjects and it will be a kind of real "useful exchange" of views, Indian Ambassador to Poland Nagma Mohamed Mallick told PTI Videos here. From Warsaw, Modi will travel to Kyiv on the first visit by an Indian prime minister to Ukraine since the country became independent in 1991. "From Poland,

will be visiting Ukraine at the invitation of President Volodymyr Zelenskyy. This is the first-ever visit by an Indian Prime Minister to Ukraine," he said. "I look forward to the opportunity to build upon earlier conversations with President Zelenskyy on strengthening bilateral cooperation and share perspectives on peaceful reso-lution of the ongoing Ukraine conflict," he said

"As a friend and partner, we hope for an early return of peace and stability in the region, he added. Modi said he was confident that his visit to Warsaw and Kyiv "will serve as a natural continuation of extensive contacts with the two countries and help create the foundation for stronger and more vibrant relations in the years ahead". The prime minister will travel to Kyiv from Poland in a 'Rail Force One' train that will take around 10 hours. The return trip will also be of the same duration. Modi's visit to Kyiv comes nearly six weeks after his high-profile trip to Moscow which triggered criticism from the US and some of its Western allies.

Bharat Bandh against Supreme Court order

New Delhi/Patna, August 21: The daylong nationwide strike called by some Dalit and Adivasi groups against the Supreme Court's verdict on the sub-classification of Scheduled Castes affected normal life in Bihar and Jharkhand as well as tribal areas of various states. Police baton-charged and used water cannons on protesters in several dis-

tricts of Bihar, including Patna, Dharbhanga and Begusarai, to remove rail and road blockades, while in Jharkhand and Odisha public transport services were partially affected. The response was tepid in other parts of the country even as several INDIA bloc parties as well as other non-BJP outfits extended their support to the bandh. The Chhattisgarh unit of the Congress said the government should consider the "legitimate demands" of the protesters sympathetically. However, the BIP's prominent tribal leader Faggan Singh Kulaste accused the opposition of politicising the Supreme Court's ruling on the issue. Former IAS probationer Puja Khedkar's fraud not only against UPSC but also public

New Delhi, August 21: The UPSC on Wednesday opposed in the Delhi High Court an anticipatory bail plea by former IAS probationer Puja Khedkar, accused of cheating and wrongly availing OBC and disability quota benefits, and said she committed a fraud against the commission and the public. The Delhi Police also sought dismissal of the pre-arrest bail plea on the ground that any relief to her would hinder its probe into the "deep rooted conspiracy" and that the case has wider implications on public trust as well as the integrity of the civil services examination Justice Subramonium Prasad listed the matter for hearing on August 29, and extended the interim protection from arrest granted to Khedkar in the meantime. In its reply filed in court, the Union Public Service Commission (UPSC) said Khedkar's custodial interrogation was necessary to unearth the magnitude of the "fraud" that could not have been done without the help of other individuals. Therefore, her pre-arrest bail plea should be dismissed, it said. "The gravin nature having been committed against not

only a constitutional body-the complainant-whose traditions are untrammelled and unparalleled but also against the public at large, including the citizens of this country who have utmost faith upon the credibility of the UPSC as well as persons who could not be appointed despite being duly eligible and qualified due to illegal means employed by the applicant to seek appointment," the reply filed through advocate Vardhman Kaushik said. The court granted time to Khedkar to respond to the stand of the UPSC as well as the Delhi Police. Khedkar allegedly misrepresented information in her application for the UPSC Civil Services Examination-2022 to get reservation benefits. The Delhi Police, in its status report, asserted that investigation had revealed that she was not entitled to benefits as an "OBC+Non-Creamy Layer" candidate but she hatched a conspiracy with other persons to get that benefit by showing that her parents are divorced. "However, despite exhausting all the permissible attempts she appeared in CSE-2021, CSE- 2022 and CSP-2023 by intentionally changing her name and making incorrect or false statements regarding the number of attempts already availed and suppressing material information which she was duty bound to furnish true and correct," the report stated. The report stated that while Khedkar claimed no connection with her father and showed her mother's income as being below the threshold to get the benefit of "OBC+Non-Creamy Layer" candi-

date, her family owns 12 vehicles, including a Mercedes car, BMW car and a Thar SUV. It stated the family owns "23 pieces of immovable properties valued crores of rupees" in different locations in Maharashtra.

Won't quit politics, open to floating new outfit: Former CM Champai Soren

Ranchi, August 21: Former Jharkhand chief minister Champai Soren on Wednesday said he would not quit politics, asserting that an option to float a new political outfit was always open to him. Soren said he was firm on his plans after "facing humiliation at the hands of leaders of JMM", a party to which the veteran leader claimed that he devoted his entire life. "It is a new chapter of my life. I won't quit politics as I have received lots of love and support from my followers. I had mentioned three options - quitting politics, organisation or friend. I



will not quit politics. The chapter (of quitting politics) has closed, I may form a new outfit," the senior Jharkhand Mukti Morcha (JMM) leader said shortly after he reached his ancestral village Jhilingora in Seraikela-Kharsawan district. The 67-year-old tribal leader has earned the nickname 'Jharkhand's Tiger' for his contribution to the fight to create a separate state in the 1990s. "No one from JMM contacted me. This is the land of Jharkhand...I have struggled since my student life. I participated in the agitation for a separate Jharkhand state under the leadership of party supremo Shibu Soren," Champai Soren said. The JMM leader said he might join hands with any outfit if he gets a like-minded organisation or a friend during his next journey. "I will strengthen the party, a new party and if I meet a good friend on the way, then I will move ahead with the friend...", he said. Referring to his post on X on August 18, the former chief minister said, "I posted what I felt was proper. The entire country is aware of what I thought." Amid speculation that he might join the BJP, the veteran politician had said he experienced "bitter humiliation" as chief minister, which compelled him to seek an alternative path.

Two tigers die of poisoning in Gudalur

NILGIRIS: An adult and a sub-adult tiger were found dead at the Sussex Estate in Bitherkad forest range in Gudalur on Tuesday. Postmortem examination revealed they had consumed a wild boar that had been poisoned. Sources in the forest department said its staff spotted the carcass of the sub-adult tiger in the pathway of the tea estate. The animal had external bleeding injuries. Following National Tiger Conservation Authority guidelines, the staff perambulated a 500m radius area and found an adult tiger, believed to be the mother, dead in a swampy marsh. The team also noticed the carcass of a wild boar within 200m. "The big cats had consumed a portion of the wild boar. During postmortem, veterinarians found wild boar flesh in their stomachs. As per the statement given by veterinarians, both tigers may have died due to poisoning. This may have happened after the tigers ate poisoned wild boar. The bleeding injuries may have been caused when they fought over the prey,' said Gudalur Forest Division DFO Venkatesh Prabhu"The veterinarians also observed samples of rice and tapioca from the stomach of the tigers, which may have been consumed by the wild boar," he added. D Venkatesh, field director of Mudumalai

Tiger Reserve (MTR), said "The sub-adult tiger could have died on Monday evening, and the adult on Tuesday morning. The colour of the internal organs has changed drastically, indicating poisoning. The tigers died one after another since they had taken secondary poison, that is from the wild boar." A case has been registered, and two special teams were formed to probe the

Social media push to revive tourism in disaster-hit Wayanad

KALPETTA: Residents, traders and tourism stakeholders in Wayanad have joined forces on social media to revive the district's tourism sector that took a massive hit following the devastating landslides on July 30. Posts and reels tagged #VisitWayanad are doing the rounds online, in a bid to attract tourists.

Almost everyone who depends on tourism suffered after all the centres under the District Tourism Promotion Council (DTPC) in Wayanad were closed following the calamity. There was mass cancellation of bookings in resorts and homestays during the Independence Day-August 15 holiday. Most resorts now have zero bookings for August. This has hit autorickshaw-taxi drivers, tourist guides, small traders, shopkeepers and hotel operators hard.hough spots such as Pookode lake, Karlad lake, Sultan Bathery Town Square, Wayanad Heritage Museum at Ambalavayal, Pazhassi Raja Landscape Museum in Pulpally, Karapuzha dam and Banasura dam are open now, the footfall is less."Tourism in Wayanad will endure only if tourist centres under the DTPC as well as the forest department are opened. We demand the intervention of the disaster management authority to reopen at least those tourist places that are safe soon," said Suresh P, a homestay owner in Padinjarathara.

In February, all eco-tourism centres under the forest department in Wayanad were closed due to recurring wildlife attacks. "At the time, our only relief was the fact that tourism centres under DTPC were open. However, with the onset of monsoon, functioning of all tourism centres came to a standstill," said Mohanan Pallikkal, an autorickshaw driver in Sultan Bathery.

After Wayanad rescue operations, offroad enthusiasts seek relaxation of laws

PATHANAMTHITTA: During the rescue operations of the Wayanad landslide tragedy, a group of off-roaders emerged as unlikely saviours who rushed to the rugged terrain despite the Motor Vehicle Department's (MVD) restrictions against them for modifying automobiles. Alteration in the tires and lights of the vehicles, mainly by the youth who engage in stunts, is against the law and also a growing concern for the MVD. However, the modified off-road vehicles having tires with more width and size than the average ones, were widely used by various collectives in Wayanad for rescue operations and even for the shifting of dozens of victims' bodies through the broken

Offroaders in Pathanamthitta

After the commendable role of expert off-road

drivers who joined in Wayanad rescue operations with their modified vehicles, Naranamoozhi Grama Panchayat in Pathanamthitta has passed a resolution to relax the law for off-road vehicles.Advocate Samji Edamuri, a panchayat member and state general secretary of the Youth Congress, who presented the resolution said, "The resolution has been passed considering the need for modified off-road vehicles in areas affected by recent landslides, floods, and other natural disasters where conventional vehicles cannot reach."

The modified off-road vehicles are seen as essential for emergency rescue operations, for navigating difficult terrains, and for fulfilling various occupational and agricultural needs in the region. Given that



off-road vehicles have often been the only means of rescue during such natural disasters, the resolution requests the legislative assembly to provide legal relaxations for these vehicles," he said, adding that the resolution has been sent to the Assembly and the panchayat members Wednesday. The district has also preserved

some heroic tales about off-road vehicles that served during the 2018 floods to shift people from stranded houses in Ranni and adjoining places. Milan, a resident of Ranni and off-road enthusiast, had volunteered in the 2018 flood relief operations. With his modified CRDe 4x4 AC of Mahindra Thar, he rescued several people from the floodaffected areas. However, after the flood operations, he was heavily fined, he said, following which he sold his vehicle.

One dead as heavy rains lashed Hyderabad, other districts

HYDERABAD: Heavy rains lashed Hyderabad and several districts in the state on Tuesday morning inundating lowlying areas. Many areas in the city received over 100 mm rainfall in a short span of time in the morning, with Saroornagar recording 132.3 mm. The city witnessed another spell of rain in the

afternoon and intense downpours in the evening leading to traffic jams as several roads were flooded. The body of a person who was suspected to have been washed away in floodwater was found at Parsigutta as rains pounded Hyderabad and Secunderabad on Tuesday morning. The victim, identified as Vijay, was washed away while he was crossing the road in the morning. Telangana urges court to close illegal phone tapping case after extensive probe

HYDERABAD: Outlining the gravity of the crime and the extensive investigation undertaken by the state authorities into the illegal phone tapping case, Special Chief Secretary of Telangana Home department, Ravi Gupta, submitted a counter affidavit on Tuesday and urged the court to close the suo motu case. He argued that a thorough investigation is going on and that the legal process is now progressing, with the magistrate having taken cognisance of the case. Gupta described the illegal phone tapping as a severe crime against society that undermines the foundations of



democracy, and assured the court that the investigation has been conducted in an unbiased and thorough manner, targeting all individuals involved, including senior police officers.He informed the court that the investigation officer has secured permission to pursue further inquiries based on new evidence and to take action against absconding accused persons. A supplementary charge sheet will be filed soon, reflecting the additional evidence gathered.

The affidavit emphasised that despite the accused being police officers with in-depth knowledge of how to obscure their crimes, the investigation team made strenuous efforts to collect all available evidence. Gupta stated that the charge sheet against the accused has already been filed and is currently under review by the magistrate.

Odisha: Post-recess Assembly session starts with Opposition ruckus

Congress members demanded student union elections this year instead of 2025 as announced by Law minister Prithiviraj Harichandan.

BHUBANESWAR: The second half of the budget session of the Assembly got off to a noisy start on Tuesday with the Congress members creating a ruckus in the House demanding students union elections this year instead of 2025 as announced by Law minister Prithiviraj Harichandan. As the House commenced after a 19-day recess, Congress members trooped into the well after the obituary references were over and demanded that elections be held this year as there is enough time for preparation for the polls. Senior MLA Tara Prasad Bahinipati told mediapersons that youth and student Congress activists will launch agitation across the state if the government does not hold elections this year. "The previous BJD government avoided college elections as it knew the BJD will be defeated. Now, the BJP government is reneging on its promise to hold elections," he alleged. The BJD members were also on their feet to draw

attention of the government to three issues. The first was for expunging the demand for arrest of leader of Opposition Naveen Patnaik for leading a walkout during the Governor's address on July 22. The second was placing the status report on the case in which Governor's son has been accused of assaulting a Raj Bhavan staff, and the third, announcement of 10 per cent reservation for Agniveers in all uniformed services of the state by Chief Minister Mohan Charan Majhi outside the Assembly."We had raised all these issus in the first half of the session but there was no response from either the state government or the BJP. We raised the issues again today," Opposition deputy chief whip Pratap Deb told mediapersons. Speaker Surama Padhy adjourned the proceedings of the House for one hour from 10.41 am to 11.41 am and again till 4 pm following the uproar by Opposition

BHUBANESWAR: The empty almirahs and chests in both the chambers of the Ratna Bhandar of Shree Jagannath temple will be shifted out of the treasury on August 23. They will be transferred to the Niladri Vihar museum located on the premises of the 12th century shrine. Public 'darshan' of the Trinity will be prohibited during the exercise.his was decided at a meeting of the 11member core committee on reopening of Ratna Bhandar on Tuesday. Committee chairman Justice Biswanath Rath said the members have decided to enter the Ratna Bhandar after the rituals are completed at 2 pm on Friday. A medical team, snake helpline members and a group of iron grill cutters will be kept in readiness within the shrine.Justice Rath

informed that almost all the wooden almirahs in both the chambers are in severely dilapidated condition and some even broke while being moved to check the presence of anything behind them, on July 18. Since the team only has a three-hour period to shift the containers, it plans to tape the broken wooden parts of the almirahs before taking them to the museum. They will be repaired at a later stage. The state government, in its SOP for shifting of the containers, has allowed cutting of the outer door of the Bahara Bhandar to take the chests out as all of them are wider than the door.If required, we will cut the door frame of the Bahara Bhandar for taking the chests out. The door frame will be brought back to the same position and shape, as per the SOP, after the chambers are repaired

and new almirahs containing the precious jewels and ornaments brought back to Bahara and Bhitara Bhandars from the temporary strongrooms," Justice Rath informed.

Gurgaon: Final voter list for assembly polls to be ready by Aug 27

GURGAON. A total of 18,013 applications for voter registration were received by the district administration by Aug 16, during the voter verification campaign ahead of the assembly elections. Of these, 5,204 names have been added to the voter list and 269 applications have been rejected. The final voter list will be published on Aug 27.The SDMs and electoral registration officers of Pataudi, Badshahpur, Sohna, and Gurgaon assembly constituencies are addressing the claims and objections received during the review campaign. This work will be completed by Aug 26, and the final voter list will be published on Aug 27. Deputy commissioner of Gurgaon, Nishant Yadav, who is also the district election officer, said that after the announcement of the assembly elections, only those who submit online or offline applications by Sept 1 will be registered. The supplementary list of the final voter list will be released on Sept 12 and the nomination process for the election will begin on Sept 5.The DC said between Aug 3 and Aug 16, as many as 6,146 applications for new voter registrations were received in the Gurgaon assembly constituency. Out of these, 47 applications were rejected, and 1,863 names were added to the voter list. The resolution of 4,236 applications is still pending. During the same period, 6,169 applications were received in the Badshahpur assembly constituency. Of these, 85 applications were rejected due to ineligibility, 2,223 names were added to the list, and 3,861 applications are pending. In Sohna, 2,711 applications for voter registration were filed between Aug 3 and Aug 16, out of which, 23 names were added, and 2,688 applications are pending. In Pataudi, 2,977 applications were received, out of which 137 were rejected, 1,095 names were added. And the resolution of 1,745 applications is still pending.

Haryana: Tumour in spine removed, woman (60) walks again

GURGAON. A 60-year-old woman, who sufferd paralysis in both legs due to a substantial spinal tumour, was successfully treated at a city hospital in Sector 50. The patient, who is from Rohtak, had initially sought treatment at a local hospital. When they failed to ascertain the cause of her condition, she was referred to the Gurgaon hospital in the last week of July. Upon arrival at CK Birla hospital, extensive diagnostic tests were done, which revealed a tumour in her spine, that had resulted in the paralysis of her lower limbs. The tumour had severely affected her ability to function. After a comprehensive consultation with Dr Arun Bhanot, director-spine surgery, CK Birla Hospital Gurgaon, the patient was informed about the microscopic tumour removal surgery that could potentially restore her mobility.Dr Bhanot said, "Utilizing the latest advancements in microscopic spine surgery and neuromonitoring techniques, the tumour excision surgery was performed successfully. By combining high-definition imaging with real-time guidance, neuromonitoring allows surgeons to accurately target and remove the tumour while preserving the surrounding healthy tissues. This advanced approach not only minimizes the risk of complications but also significantly reduces recovery time."The woman said, "When I lost the ability to walk, I feared I would never regain my independence. But thanks to the expertise of the people involved in the treatment and the advanced surgery, I am back on my feet and living my life again. The care I received was nothing short of

Cratered roads & no streetlights: 5 years after MCG took over, infra crumbles in Gurgaon's South City 1

GURGAON. It has been five years since South City 1 was handed over to MCG, yet residents are struggling with flaws in basic civic amenities. Residents on Tuesday staged a protest against MCG, alleging it's turning a blind eye to the civic woes in the society. Roads, many of which are in a state of disrepair, are riddled with potholes. The lack of adequate street lights, residents said, exacerbates the situation, causing difficulties for them while commuting and posing a risk of accidents, particularly at night. Residents further pointed out that the outdated and poorly maintained water supply infrastructure often leaves them facing disruptions in water supply.Despite repeated complaints, no measure has been made to improve the situation, they added.Holding placards with slogans such as "Har baarish sailaab aya, MCG takeover durbhagya laya" (Every monsoon brought floods, MCG takeover brought misfortune) and "Gaddhon se pareshaan, kab hoga samadhaan?" (Fed up with potholes, when will there be a solution?), residents accused the civic

body of failing to address persistent issues severely affecting the quality of life in the colony.A major concern raised by the protesters was the lack of desilting of stormwater drains and sewers, causing frequent waterlogging and unhygienic conditions, particularly during the

monsoon season."Monsoons only mean trouble for us. Every other day, the sewer overflows and takes days to clear up," said Ashwani Duggal, general secretary of South City 1.Protesters alleged the MCG has failed to ensure regular and sufficient water supply, forcing them to rely on tankers and other alternative sources."Despite buying properties worth crores, our colony still lacks basic amenities. High

property taxes are collected, but it does not reflect in services," Duggal added.Sanitation, too, remains a pressing issue. Residents claimed MCG's inadequate arrangements for waste collection and disposal have led to unhygienic conditions and a higher risk of disease. The indiscriminate cutting of trees to create entrances for houses and the encroachment of pavement areas by shopkeepers in Silokhra Market and hawkers outside South City Arcade also drew the ire of the residents."Pedestrians are left with no safe place to walk. There are frequent traffic jams on the main road



of the colony. Shops in the market have now become inaccessible due to waterlogging and encroachment. Additionally, there is rampant dumping of mixed and C&D waste in the B block service roads, which MCG is not addressing," said Savita Nagpal, a resident. The residents later met with the action to address their grievances.

Captain Raj Chopra (retd), president of South City 1, said, "Our demand is simple - regularise waste collection, ensure proper sanitation, provide 24/7 water supply, fix leakages, repair and maintain roads, footpaths, and streetlights. Around 38 people are deployed from MCG for cleaning, but no one comes, and they are drawing salaries without accountability. This is not acceptable at all.""We are not just complaining but are willing to work with MCG to find solutions. The civic body must acknowledge our concerns and take concrete steps to address them. We will not back down until our demands are met," Chorpa added.Manoj Yadav, chief engineer of MCG, said the matter was not brought to his knowledge till now. "However, I have met the residents and I have directed my officials to clean the drains immediately. The sewer issues will also be addressed swiftly, and the necessary machinery will be deployed soon. Sanitation issues will also be addressed by sanitary wing," he said.

Kite comes in contact with high-tension cable, three children suffer burn injuries in Gurgaon

GURGAON: Three boys - aged between 11 and 8 years suffered burns when the kite they were flying came in contact with an 11 kV overhead electricity line at Jharsa on Monday evening. The injured, Nitish (11), Satyam (9), and Ahsan (8), were shifted to Safdarjung Hospital for treatment and are now out of danger.The incident happened in Prempuri area of Jharsa when Nitish, his younger brother

Satyam and their neighbour Ahsan were flying kites around 6 pm. According to cops, the boys were flying a kite in front of the building



where they live. The kite got entangled in an overhead electric line, leading to sparks."The sparks fell on the three boys, causing burns on their faces, arms, and legs. They only suffered

User charge for doorstep garbage collection not to change for now in Gurgaon

GURGAON. MCG has announced that the user charges for door-to-door waste collection will remain unchanged. The fees, as notified by the corporation in 2017, will continue to be collected from residents by the agency hired for doorstep garbage collection.Based on the notification issued on Sept 5, 2017, apartments with a covered area of up to 2,000 sq ft will be charged Rs 50, while flats with a covered area exceeding 2,000 square feet will be charged Rs 100. Residents have expressed their concerns regarding the inconsistent doorstep waste collection service and have also raised objections to the higher rates being charged in comparison to what they were previously paying. The notification stated that residential properties will be subject to user



charges based on plot size. For plots measuring up to 100 sqm, a charge of Rs 20 will be levied. Residential units on plots measuring 200 square metre will pay Rs 40.Properties on plots measuring 400 square metre will be charged Rs 50, while houses on plots exceeding 400 square metre will be subject to a user charge of Rs 100.

Washington. Derek Chauvin has been transferred to a prison in Texas, the US Federal Bureau of Prisons said on Tuesday, nine months after the former Minneapolis police officer convicted in the murder of George Floyd survived a prison stabbing in

"We can confirm Derek Michael Chauvin was transferred to the Federal Correctional Institution (FCI) Big Spring on August 20, 2024," a spokesperson for the Federal Bureau of Prisons said in an emailed statement

WHY IT'S IMPORTANT

Chauvin was stabbed about 22 times last year while incarcerated in Tucson, the US Justice Department said in December. Chauvin was seriously injured but survived

Chauvin is serving 22.5 years for murder after being convicted in April 2021 of killing Floyd, a verdict widely seen as a landmark rebuke of the disproportionate use of police force against Black Americans. He is concurrently serving a 21-year sentence for violating Floyd's civil rights.

CONTEXT

Floyd's death in 2020 unleashed protests worldwide against police brutality and racism after Chauvin, who is white, knelt on the neck of the handcuffed Black man for more than eight minutes in a murder caught on cellphone video. The suspect in Chauvin's stabbing was charged with attempted murder and other offences.

Thomas Lane, a former Minneapolis officer convicted of aiding and abetting seconddegree manslaughter in the Floyd killing, was released from federal prison in Colorado on Tuesday after serving a sentence of over three years.

World's 'largest solar precinct' approved by Australian government

NEW CASTLE. An ambitious plan to build a massive solar farm in remote northern Australia that would transmit energy by submarine cable to Singapore is a step closer after the Australian government granted environmental approvals for the 30 billion Australian dollar (\$19 billion) project Wednesday. Australian company Sun Cable plans to build a 12,400-hectare solar farm and transport electricity to the northern Australian city of Darwin via an 800kilometer (497-mile) overhead transmission line, then on to large-scale industrial customers in Singapore through a 4,300-kilometer (2,672-mile) submarine cable. The Australia-Asia PowerLink project aims to deliver up to six gigawatts of green electricity each year, which according to Australian Environment Minister Tanya Plibersek will "help turn Australia into a renewable energy superpower" and boost its economy.

"This massive project is a generation-defining piece of infrastructure," Plibersek said in a written statement on Wednesday. "It will be the largest solar precinct in the world - and heralds Australia as the world leader in green energy."The project was initially backed by Australian mining magnate Andrew Forrest and Atlassian co-founder Mike Cannon-Brookes. The plans were highlighted during a state visit by then Singapore Prime Minister Lee Hsien Loong and Australian Prime Minister Anthony Albanese as part of a 'green economy 'agreement in 2022.

Bangladesh authorities file 9 more cases against Sheikh Hasina, total reaches 31

filed on Tuesday against deposed former prime minister Sheikh Hasina and her aides, taking the number of cases against her to 31, including 26 on charges of murder, four on charges of crimes against humanity and genocide and one for abduction. Supreme Court lawyer Gazi MH Tamim filed a complaint with Bangladesh's International Crimes Tribunal on behalf of Mufti Harun Ijahar Chowdhury, joint secretary general (education and law) of Hefajat-e-Islam, The Daily Star newspaper reported. The complaint accused Hasina and 23 others of committing crimes against humanity and genocide during a Hefajat-e-Islam rally at Motijheel's Shapla Chattar on May 5, 2013. We registered the complaint, and thus the investigation has started from today," Deputy Director (admin) of the investigation agency Ataur Rahman was quoted as saying by the newspaper. This is the fourth complaint filed with the International Crimes Tribunal against the former premier, who resigned and fled to India on August 5 following massive protests against her regime. Of the four, three cases are connected

to the recent violence centring on the quota reform movement. Separately, eight more cases were filed against the Awami League chairperson on Tuesday across the country, accusing her of killings committed during the recent protests, the newspaper said. With these cases, Hasina is now facing 31 cases, including 26 on charges of murder, four on charges of crimes against humanity and genocide and one for abduction, it added.Hasina's son Sajeeb Wazed Joy, daughter Saima Wazed Putul and sister

Sheikh Rehana were made co-accused in a killing case for the first time, the paper said. The prominent accused in the Hefajate-Islam case include Awami League general secretary and former road transport and bridges minister Obaidul Quader, former minister Rashed Khan Menon, former mayor of Dhaka South City Corporation Sheikh Fazle Noor Taposh, ex-advisor to prime minister Salman F Rahman, former security advisor to the prime minister Tarique Ahmed Siddique, former inspector general of police AKM Shahidul Haque, editor of ABnews24.com Subhash Singha



Roy and former army chief Aziz Ahmed.

Besides them, some unnamed ministers, state ministers and lawmakers, unnamed individuals from law enforcement agencies and the then policymakers of some electronic and print media were accused in the case. According to the complaint, the accused, by giving directives and plan, committed crimes against humanity and genocide by killing Hefajat activists in Dhaka and surrounding areas and in different districts, including Chattogram, Narayanganj and Cumilla, between May 5 and 6, 2013, the paper said. The Hasina-led government set up the International Crimes

Tribunal in March 2010 to try those who committed war crimes in 1971. A second ICT was formed later. Five Jamaat-e-Islami and a Bangladesh Nationalist Party (BNP) leader were executed following the verdicts of the two tribunals.BNP's Secretary-General Mirza Fakhrul Islam Alamgir on Tuesday asked India to extradite Hasina to face trial as he accused her of plotting to thwart the country's revolution. Mpox not the new Covid-19, says WHO official

Berlin. A World Health Organization (WHO) official stressed on Tuesday that mpox, regardless of whether it is the new or old strain, is not the new Covid, as authorities know how to control its spread."We can and must tackle mpox together," said Hans Kluge, WHO regional director for Europe, in a UN media briefing."So will we choose to put the systems in place to control and eliminate mpox globally? Or we will enter another cycle of panic and neglect? How we respond now and in the years to come will prove a critical test for Europe and the world," he added.

Mpox, a viral infection that causes pusfilled lesions and flu-like symptoms, is usually mild but can kill. The clade 1b variety has caused global concern because it seems to spread more easily though



What's behind jailed Imran Khan's bewildering Oxford chancellor bid

Former Pakistan Prime Minister Imran Khan is doing more than just stare at jail walls. He has applied to be the Chancellor of Oxford University. In jail for a year now, Imran Khan's surprise move to run for the elections for the Oxford top post could be a bid to attract global attention while his party holds rallies in Pakistan on the anniversary of his jailing. It could also be a signal to the powerful military of Pakistan that Imran is done with Pakistani politics and is interested in a third career, after cricket and politics.Imran's adviser Syed Zulfi Bukhari revealed that he submitted an application to run in the October election. He has applied at a time when elections and nominations for the position of the Chancellor have become online. The former Pakistani Prime Minister will contest to replace Chris Patten, the former Conservative minister. Patten, the chancellor of Oxford University, announced he was stepping down from the post in

February.Imran's journey in Pakistan's politics started with his promise of "Naya Pakistan" or "new Pakistan". He is now languishing in jail, facing several charges, which his supporters allege are part of a

political conspiracy. IMRAN KHAN: THE CHANCELLOR

OF OXFORD UNIVERSITY? "It's a ceremonial post but one with the utmost prestige and importance and Imran Khan, being one of the larger or more popular names coming out of Oxford, it would be brilliant to see him as chancellor," Bukhari told AFP. UK Sperm Exports Lead To Global Increase In 'Half-Siblings': Report

Source: Bureau A legal loophole is allowing sperm donated in the UK to be exported to other countries, potentially leading to the creation of large numbers of donor-conceived children worldwide. This practice violates the UK's strict 10-family limit that applies within its fertility clinics, as there are no restrictions on exporting sperm or eggs abroad. Experts warn that this could result in donor-conceived children having dozens of biological half-siblings across Europe and beyond. They are urging the Human Fertilisation and Embryology Authority (HFEA) to

tighten regulations to prevent this from happening. As per The Guardian, "If vou believe that it's necessary to enforce the 10family limit in the modern world then logically that should apply wherever the sperm are from," said Prof Jackson Kirkman-Brown, chair of the Association for Reproductive and Clinical Scientists



(ARCS). "There is data showing that some of the children who find the really big families struggle with that," he added.

Four designs shortlisted for new Telangana HC complex

HYDERABAD: The judges committee has reportedly shortlisted four out of nine designs submitted by Roads & Buildings department officials and a private architect consultancy firm for the construction of the new Telangana High Court complex. According to sources, these four designs will now be sent to Chief Minister A Revanth Reddy and R&B Minister Komatireddy Venkat Reddy, after which the Chief Justice of the High Court and the CM will finalise a design. The government has allotted 100 acres of land in Rajendranagar in Rangareddy district for construction of the new High Court complex.

Apart from the court building, the complex will have a total of 40 structures, including residential buildings for judges, State Bar Council, High Court Bar Association, an auditorium, Legal Services Authority, filing sections, record rooms, parking slots and other facilities. It may be mentioned here that as many as 19 architect firms have come forward to provide construction designs for the new HC building. After the foundation stone was laid for the new complex, the High Court Building Committee has selected one company, which prepared the designs and presented them to the committee. After finalising the design, the government would invite tenders for construction of the complex.

It may be recalled that the Chief Justice of India DY Chandrachud and Chief Justice of Telangana High Court Justice Alok Aradhe laid the foundation stone for new HC complex on May 27.

The authorities are planning to complete the construction in 18 months. The sanctioned strength of judges for the Telangana High Court is 42. The government is expecting that this number may increase in future and hence building the new complex keeping the future

Seven detained over spurious liquor incident, 21 in hospital in Berhampur

BERHAMPUR: A day after 21 persons were taken ill following consumption of spurious liquor in Chikiti, K Nuagaon police on Tuesday detained seven people, including a woman for their alleged involvement in the illicit liquor trade in the area. The victims, belonging to Jenapur-Karabalua under Chikiti notified area council, developed symptoms like loose motion, vomiting and dizziness and were initially admitted to local community health centre (CHC). Fourteen of them were later shifted to MKCG medical college and hospital (MCH), with 12 in the general medicine ward and two admitted to the ICU. The affected people reported that after finishing their cultivation work around 5 pm, about 30 people gathered in Maundpur and consumed liquor, leading to the onset of the symptoms within a few hours. Family members of the victims claimed that the liquor was illicitly brewed in a forest near Bhalughai and sold in nearby

Ganjam collector Dibyajyoti Parida, who visited the patients at MCH, stated that the condition of those under treatment, including the two in the ICU, is stable. He assured that strict measures are being taken to curb illicit liquor trade in the district, with an awareness campaign already underway in rural areas.

Excise commissioner Narasingha Bhol, who also visited the affected area, confirmed that liquor samples have been collected for laboratory testing. "A joint action team comprising police and excise officials will be formed to intensify raids on illegal liquor operations in the district," he added.Meanwhile, the incident sparked a political blame game, with BJD leader Srirup Deb holding the ruling BJP responsible for proliferation of spurious liquor in Chikiti. "The area never witnessed spurious liquor circulation which is now flourishing at the behest of ruling BJP," he

Sanitary pads procured under Khushi scheme lying expired in Cuttack DHH

CUTTACK: Khushi scheme, launched by the previous BJD government in February 2018 to provide free sanitary pads to girl students of classes VI to XII and reduce their dropout rate, seems to have failed to serve its purpose in Cuttack district as lakhs of such napkins are found lying undistributed at the district headquarters hospital here. The matter came to the fore five days back when the old building of the hospital was being demolished for construction purpose. With their expiry dates already lapsed in 2021, the pads worth lakhs of rupees are lying in damaged condition and stinking. This raises the question as to why steps were not taken for distribution of the pads before their expiry and who is responsible for the loss incurred. "Had the hospital authorities dispersed the sanitary napkins on time, they would have not gone into waste," rued a local resident. Meanwhile, hospital superintendent Dr Arun Kumar Sahu said the hospital is not to be blamed for the damage of the sanitary pads. He said the DHH had in February 2019 received around 3 lakh sanitary pads procured through Odisha State Medical Corporation Limited (OSMCL) from a company.

Seven EB staff die in 20 days in Tamil Nadu; questions arise on safety, manpower

COIMBATORE: At least seven Tangedco workers, including four wireman, had died of electrocution while attending to power failure complaints in the last 20 days across the state, bringing into focus the risky conditions under which they work and poor safety standards and compliance.

According to Tangedco staff union sources, victims Anand of Nilgiris, Aththiyappan of Kallakurichi, Selvaraj of Vazhapadi, and Samuthiram of Kadayanallu were wireman, while the other three —Dinesh and Naveen of Tiruppur district and Senthilkumar of Jayankondam — were gangmen.While officials said rules regarding the mandatory use of 'safety app' and uploading of photos showing usage of safety gear at work are honoured more in breach than in compliance, workers blame the manpower shortage for rising fatal and nonfatal accidents in the department.Wiremen and helpers play a vital role in fixing power failures, but a large number of their posts are vacant across TN. This makes the staff force gangmen who are not well-versed in technical work to take up fieldwork, and they are the ones who frequently become victims of accidents.

Poor training, work pressure also reasons for accidents'

Increasing work pressure, poor training of personnel, and rising vacancies are the



other reasons for the accidents, said Tangedco workers.

Officials, however, said that wireman and helpers, particularly gangmen, fall prey to accidents and lose their lives due to negligence in using belt rope, hand gloves and earth rods, which would give them protection from electrocution.

Supervisors have been advised to ensure that field staff use safety gear without fail while attending to electricity failures. They have also been asked to upload photos with the detail of the work being done on the app to ensure monitoring and safety compliance," a senior Tangedco

As per protocol, the supervisor who monitors the work has to upload all details, including their name, role, circle name, section name, workers' name and work description on the Android Application

While taking photos, the app also registers the latitude and longitude of the location for record maintenance. If there is any mishap due to negligence, the supervisor would be held responsible, sources said. However, some members of the staff union said that uploading photos and details consumes mobile data and want the corporation to bear that expense for better compliance.

Address overcrowding in SC, ST hostels: Karnataka HC

BENGALURU: The Karnataka High Court on Tuesday directed the state government to address on priority the issue of overcrowding in state-run hostels for scheduled caste and scheduled tribe students, and sought details on the steps taken to fill up vacant posts of wardens. Hearing a sou motu public interest litigation registered in 2023 on the issue, a division bench of Chief Justice N V Anjaria and Justice K V Aravind orally observed that a "chaotic situation" was created in hostels.

Referring to the report submitted by the state government, the court pointed out that out of the total sanctioned strength of 1,890 posts of senior



wardens, 548 were vacant, and out of 518 sanctioned junior warden posts, 53 were vacant.

Citing the number of students in various hostels as per the report, the court noted that more students were admitted than the actual capacity of the hostels. In a post-metric hostel in Sirsi of Uttara Kannada district, 151 students were admitted against the sanctioned strength of 50. In Koppal, 214 students were admitted, against the 75 sanctioned strength. The other two hostels in Koppal are not better since 250 students were admitted against the 100 sanctioned strength, the court pointed out.

Therefore, the state government should submit the details of the steps taken to fill up the vacant posts of wardens, and the measures to be taken to ensure that there is no overcrowding in hostels, the court said, adjourning the hearing to September 30.

Telangana HC orders publication of Margadarshi investigation in multiple languages

HYDERABAD: A division bench of the Telangana High Court, comprising Justice Sujoy Paul and Justice Namavarapu Rajeshwar Rao, has instructed the court registry to publish in Telugu, Hindi and English newspapers to ensure broad awareness of the ongoing investigation into the Margadarshi case among depositors who did not get back their deposits. This decision comes as part of an inquiry initiated by the Supreme Court.During the hearing on Tuesday, former MP Undavalli Arun Kumar, who is the petitioner in the case, along with senior counsel Siddhartha Ludra, representing Margadarshi Chit Funds,

attended the session virtually. Ludra sought a two-week extension to respond to a counter filed by the Reserve Bank of India (RBI). In response, Arun Kumar argued that the RBI had determined that Margadarshi Chit Funds' collection of deposits from subscribers was illegal under Section 45(S) of the RBI Act, emphasising the need for a thorough investigation at the grassroot level and for those responsible to be held accountable.Arun Kumar further urged the court to direct Margadarshi to submit the details of its 70,000 subscribers, which had previously been provided to the Supreme Court, to the High Court in a digital format.

However, the bench advised Arun Kumar to file an affidavit seeking these details. The governments of Andhra Pradesh and Telangana have been instructed to submit their counters within two weeks, with the next hearing scheduled for September 11In its recent submission, the RBI reiterated its stance that Margadarshi cannot avoid legal scrutiny by contending that Section 45(S) of the RBI Act does not specifically apply to Hindu Undivided Families (HUFs). The RBI argued that Margadarshi, by operating under an HUF, should be classified as an "association of individuals" under the Act and is therefore prohibited from accepting

public deposits. The central bank further asserted that Margadarshi Financiers, owned by the late media mogul Ch Ramoji Rao, is liable for prosecution due to its violation of regulations by collecting funds from the public. The RBI also opposed the petitions filed by Margadarshi and Ramoji Rao, which sought to quash cases initiated in 2008 by the Andhra Pradesh government. In its counter-affidavit, the RBI cited multiple judgments from both the Telangana High Court and the Supreme Court, arguing that the petitions should be dismissed as the actions of the petitioners appeared to meet the criteria for the alleged offenses.

Wayanad landslides: Final rehabilitation plan before our principal R Rajalakshmi. We after obtaining stakeholders' opinions

the birth of Lord Ram and concludes with THIRUVANANTHAPURAM: The state government is proceeding with the rehabilitation of landslide victims in wayanad, said Chief Minister Pinarayi Vijayan. The chief secretary has been assigned to discuss the different aspects of rehabilitation with disaster response experts and people's representatives from the affected areas, he told media persons here on Tuesday. The final plan will be formulated after obtaining the opinion of all stakeholders, said the CM. Initially, there were 729 families in rehabilitation camps. Except for 219 families, the rest of them moved to rented houses or relatives' homes. The government will give monthly rent to all these families. The government has repaired 75 government quarters where 83 families will be rehabilitated. The government has identified 177 houses where victims can be rehabilitated.Of them, 123 are ready to be occupied. As many as 105 houses have



already been sanctioned to victims and 22 families have started living there. The CM said some of the victims have sought more time to move out of the rehabilitation camps. So far 179 dead bodies have been identified. As many as 17 families were totally wiped away in the disaster. They comprised 65 members. Reports say that 119 persons are still missing. The government could not find the next of kin of five persons. Samples have been sent for DNA tests in such cass.Relatives of 59 deceased received Rs 4 lakh from the State Disaster Response Fund and Rs 2 lakh from the Chief Minister's Distress Relief Fund. An immediate assistance of Rs 10,000 was given to 691 families. Additionally, 172 families were given Rs 10,000 as funeral expenses.

The CM said the support of banks was inevitable to provide livelihood to the affected families. Agriculture was the source of income for the majority. Most of them had taken loans for farming, education and housing. "But they have lost their houses and farmlands. A large number of people have become lonely. The government, in this context, asked the State Level Bankers Committee meeting to write off the loans of landslide victims," he said.

No water supply for two months, say residents of TN's Punnakayal

There's more to the Preamble than a

AS I reflect on the recent controversy over the reported removal of the Preamble to the Constitution from select NCERT textbooks, I realise once again the significance of the politics of knowledge. Possibly, it is not easy for the ruling regime to free itself from the alliance of religious nationalism and market fundamentalism, or the politics centred on the cult of a narcissistic/potentially authoritarian personality. Not surprisingly, you and I need not be surprised if the establishment feels somewhat uncomfortable with the grand egalitarian/secular ideal the Preamble articulates.

However, as a teacher with a keen interest in pedagogic practices, I do not want to remain confined merely to what has been deleted from school textbooks. My question is whether the prevalent pattern of classroom transaction is capable of making the young learner understand and internalise the significance of the Preamble, even if it is included in these textbooks. As teachers and educationists, we should reflect on this pedagogic question more seriously rather than getting carried away by the rhetoric of the debate between the overnment and the Opposition.In this context, I feel tempted to refer to the experience of a workshop in which I got an opportunity (thanks to Vikash Sharma of the Shiksha Swaraj initiative) to interact with a group of Class-XI students in the hinterland of rural Bihar. Well, their NCERT text of political theory begins with the Preamble. I asked them to read and feel every word of the beautifully written Preamble: "We, the people of India, having solemnly resolved to constitute India into a sovereign, socialist, secular, democratic republic..." Well, they read it; and I was not sure whether they could make sense of it. In a culture of rote learning and exam-centric education, this grand vision of the kind of India we wish to make, I feared, has already been reduced to a mere 'fact' - soulless, and without any enchanting power, or just a two-mark question in the board examination. But then, I didn't give up; I sought to intervene; and I wanted them to think and reflect. I asked them a simple question: "Do you see democracy in your family, or in your village?" They remained silent for quite some time. It was not surprising. The teacher's monologue in the classroom in most of our schools, or the disappearance of lived experiences from our classrooms creates a culture of silence. Seldom do the students get an opportunity to see beyond the frozen words stored in the textbook, articulate their own experiences and ask new questions.

I was aware of this difficulty. Yet, I kept trying. And eventually, some of these students began to speak. "There is no democracy in my family. My father takes every decision. We have no voice," a girl finally spoke. This gave me an opportunity to make them reflect on patriarchy and how it negates the spirit of democracy - democracy as dialogue, art of listening and the process of collective decision-making. Furthermore, I wanted to make them think whether democracy as a way of life can exist in the grand political system if it is not practised in our families, villages, schools and society. Yes, this conversation began to stimulate them. And this time a Dalit girl came forward and asserted confidently. "There is no equality in my village. We are looked down upon: we are stigmatised" — her voice convinced me that education is about asking critical questions and interrogating the taken-for-granted world. In the process of this free-floating conversation, they brought the experiences of lived realities and felt encouraged to see beyond bookish knowledge. At this juncture, I asked them yet another question: "Do you think that the Preamble is just a garland of noble words, and the way our country operates is far from this grand vision?" Initially, they were silent or possibly confused. I kept waiting for their response. And then, a girl began to speak: "There is economic inequality in India; there is 'Hindu vs Muslim politics'; and there is caste oppression. But then, India should try to become like what the Preamble visualises." And this inspired me to make a couple of observations and conclude the session.

India should engage more with Taliban

Delhi must accept reality of Afghan situation without according diplomatic recognition to the regime

THREE years after the Taliban recaptured Kabul on August 15, 2021, and, for the first time, gained control over all Afghan territory, they remain firmly in the saddle. This is even though their emirate is not internationally recognised and their government is 'interim'. Top leaders of the erstwhile Afghan republic are, except Hamid Karzai and Abdullah Abdullah, scattered outside the country; they have no capacity of mounting an anti-Taliban revolt, violent or non-violent, within Afghanistan. There

have been reports of some small actions, but these do not constitute a threat to the Taliban. The initial general international response towards the Taliban after their victory was to demand (i) the formation of an 'inclusive' government representing all sections of the Afghan polity, (ii) the Taliban should prevent terrorist groups to operate from Afghanistan and (iii) follow internationally accepted standards on gender issues. The US, smarting from its defeat in the 'forever' war, also froze more than \$9 billion Afghan assets. Over the past three years, some countries have intensified contact with the Taliban individually. Indeed, China has sent a new ambassador.

The international community's engagement is through the 'Doha process' initiated by United Nations Secretary-General (UNSG) Antonio Guterres. Its third round concluded in Doha on July 1. The demand for the formation of an inclusive government, a non-starter to begin with, has been abandoned. The focus is now on conditions set out in (ii) and (iii). There is global unanimity on (ii) because it impacts all countries. It is here that the Taliban are playing a skilful game. They are seeking to counter terrorist groups that are oriented against countries showing sympathy to their regime, including Russia and China, but are encouraging those they need to use as a card. In the latter category is the Tehreek-e-Taliban-e-Pakistan (TTP). The Taliban are also against the Islamic State of Khorasan Province (ISKP), the Afghan branch of ISIS. ISKP's presence is a thorn in the Taliban side but is not a threat to their structure.

On gender issues, various countries are making the right noises but the Taliban are aware that all countries do not place the same degree of emphasis on them. Certainly, it is not a priority for China and

Russia. On its part the Taliban's theological position on them has not changed but its application on the ground is not as harsh as it was in the 1990s. Women wearing the hijab move around in Kabul, and, as of now, male doctors are permitted to attend to female patients if their families permit. A recent development is the placement of mullahs in major hospitals; doctors and staff are expected to attend The Taliban's regional and foreign engagement has their short daily discourses. Discriminatory practices against women from the middle level in



education is being practiced. United Nations reports on the Afghan situation persistently note the continuing impoverishment of the people. In his report to the UN Security Council in June this year the latest on conditions in Afghanistan - the UNSG noted "Nine out of 10 households were struggling to feed themselves adequately..." Lowlevel economic activity is taking place, but the situation continues to be dire. Consequently, those Afghans who can leave the country are doing so even as Pakistan has forced the return of a large number of refugees living for decades there. Opium cultivation, a source of income for Afghan farmers in some provinces, has been banned and its production has fallen but not eliminated. Ephedrine is also produced to prepare methamphetamine, which is smuggled out of the country through Iran to the wider world. Tensions within the Taliban interim government continue. The principal fault line is between the Haqqanis, whose power base is in the east, headquartered in Khost province, and the traditional Pashtun leadership based in Kandahar. By now, the latter, under the supreme leader, Mullah

Haibatullah Akhundzada, has been able to establish its sway. The Kandahari leaders are more hardline and less exposed to the world. They can be expected to resist any dilution of their interpretation of the Sharia in running the administration, though on the ground, practical ways are found by the people in major cities to deal with their decrees.

> Pakistan. The Pakistani establishment clearly feels that the Taliban leadership has shown scant concern for its core interests because it has not tightened the screws on the TTP. The Taliban are unlikely to change their position on the TTP, at least in the near future. Consequently, bilateral Pakistan-Taliban ties will continue to be rockyIndia should shed its inhibitions in opening full ties with the Taliban. The term 'full ties' does not imply diplomatic recognition. India's interests demand that China should not be allowed to gain primacy in Afghanistan. The Taliban have been urging India to enhance its interaction with them. Indeed, India has taken some 'practical'

steps. It should now openly clothe them formally. This could begin with calling the Technical Team what it actually is — the Indian embassy — and its head should be called a charge d'affaires. Doing so would not mean a move towards diplomatic recognition of the Taliban but accepting the reality of the Afghan situation. Also, India has already given humanitarian assistance to the Talibancontrolled Afghanistan. It should now resume project assistance. This can be done keeping the security of personnel, if they have to be sent to Afghanistan, in mind. The training of Afghan professionals should be resumed. The most important step India has to take relates to resuming the grant of visas to Afghans who wish to visit India, for instance, for medical and educational purposes. Naturally, security concerns would have to be addressed while doing so. The stoppage of visa issuance has deeply hurt Indian interests. The policy needs an immediate review. It was inexplicable to begin with and a foreign policy-oriented clarification on why it was undertaken needs to be

PM's Ukraine visit

Tightrope walk for Modi under Russian gaze



In an assertion of its strategic autonomy, India has made no effort to conceal its pro-Russia leanings, but at the same time it has continued to engage with Ukraine.



Zelenskyy had not minced words when he described PM Modi's July visit to Russia - and a hug with Putin - as a 'huge disappointment and a devastating blow to peace

efforts'. Apparently, it was this criticism that prompted the PM to do a balancing act - he lamented the loss of innocent lives in a missile strike on a children's hospital in Kyiv, a response that wasn't music to Moscow's ears.

Even as Russia will closely observe the PM's upcoming meeting with Zelenskyy, the hard fact is that the discharge of Indians from the Russian military remains a work in progress. PM Modi had reportedly got an assurance from Putin in this regard last month, but not much has happened on the ground. External Affairs Minister S Jaishankar told the Lok Sabha on August 9 that of the 91 Indian nationals recruited in the Russian army, 69 were awaiting discharge. Exerting pressure on Moscow to ensure their expeditious

return should be a top priority, but India also has to tread warily so as not to antagonise its all-weather friend.

Regime change can impact Bangladesh's defence ties with India

Faced with a crisis of legitimacy and the backsliding of democracy, Hasina's port of call was New Delhi.

IN a conversation with me after Pakistan's surrender at Bogra in the 1971 Liberation War, Maj Gen Nazir Hussain Shah, General Officer Commanding of the 16 Pakistan Infantry Division, had said prophetically: "Bangladesh will be a disturbed desh." Nobel laureate Muhammad Yunus, head of the 16member non-political interim advisory council that has two student leaders, has described Sheikh Hasina's exit as 'the second Liberation'. It has also been referred to as the 'third revolution', a redux of the 2006 Nepalese revolution and 'Arab Spring on steroids', and likened to the 2022 Aragalaya (uprising) in Sri Lanka. There are conspiracy theories attached to last month's Anti-Discrimination Students Movement. A warning by Bangladeshi filmmaker and philanthropist Chanchal Chowdhury about an impending US-led coup has gone viral on social media. The immediate fallout from Hasina's eviction will be for India, which has historically put all its eggs in the Awami League basket. Faced with a crisis of legitimacy and the backsliding of democracy, Hasina's port of call was New Delhi, which welcomed her with a bit of nervousness. The mayhem that marked the violence and revenge killings was similar to those witnessed during the regime change in Afghanistan in 2021. The army under Gen Waker-Uz-Zaman, praised by the US, carried out a coup, the fifth in 53 years.

During a lecture tour to the Centre for the Study of Genocide and Justice at the Liberation War Museum in Dhaka last November ahead of the January 2024 parliamentary elections, I failed to read the graffiti (read writing) on the wall: 'Hasina go'. And so did India. My driver told me that if a free and fair election were held, the Opposition Bangladesh Nationalist Party (BNP), led by Begum Khaleda Zia, would sweep the polls. This was echoed by an officer of the

Indian High Commission in Dhaka and several journalists. Still, India backed Hasina to the hilt. The civil-military relations seemed harmonised, with both sides marking their red lines. During several visits to Bangladesh since 1971, one saw the Awami League focus on two areas: the glorification of the legacy of the Liberation War and strengthening India-Bangladesh relations despite the lurking anti-India sentiment. The battle between the two Begums (and the proxy war between their sons Sajeeb Wazed and Tarique Rahman) was clearly manifest in their lovehate approach towards India. During the BNP's rule, the India connect with the Liberation War diminished. And when the Awami League regained power, especially in the last 15 years, emphasis was laid on reviving the cult of Sheikh Mujibur Rahman and the war. Therefore, the image of a student defacing Mujib's statue in Dhaka and the public hangings of Awami League workers illustrate the vicious cycle. India's Eastern Command, which oversaw the 1971 war, commemorates the Liberation War with Mukti Jodhas from Bangladesh every year in December. And Dhaka reciprocates with warmth through a lavish felicitation of Indian veterans of the conflict. That ritual was sanctified by the construction of a war memorial for India's 1,670-odd martyrs (similar to the one for the Indian Peace-Keeping Force in Colombo) at Ashuganj. It was to be inaugurated later this year by PM Narendra Modi and Hasina. Scholarships, medical schemes and myriad welfare facilities have been introduced for the dependants of Mukti Bahini personnel, and free medical treatment has been made available for members of the Bangladeshi armed forces.

The rise in military-to-military relations is a stellar achievement, given that the Bangladeshi military used to wargame scenarios with India as an enemy until recently. Almost everyone, other than the military and the beneficiary families, seems to have forgotten about the Liberation War. Enhanced defence cooperation between the two nations is marked by the \$500-million line of credit extended by India. There are tri-service interactions with institutionalised staff and training-level dialogue. Visits by military leaders are common. Gen Zaman was to visit India later this month. Last year,



Dimapur, where it was christened in 1971. Bangladesh was also supposed to take part in the Tarang Shakti multi-national air exercise with the Indian Air Force this month. Joint exercises and sea patrols are rising. Service chiefs presiding over passing-out parades in each other's military academies is a regular feature. Non-kinetic military equipment has been sold, as the armed forces division responsible for modernising Bangladesh's military

has categorised defence acquisitions under A. B and C groups. While India still falls in the C category, China — the mainstay of military hardware — comes under A. How much of the enhanced defence ties will survive the regime change is crucial for India.

Anti-India sentiment, a familiar refrain in the neighbourhood, has become a metaphor for New Delhi's unflinching support to Hasina. Some Indian leaders have repeatedly called for the implementation of the Citizenship Amendment

Act/National Register of Citizens and described Bangladeshis as 'insects' and

The China Media Group, along with Pakistan's ISI, is encouraging the banned Jamaat-e-Islami and its student wing, Islami Chhatra Shibir, to fuel anti-India sentiments.Bangladesh shares its border with five Indian states. The turmoil along the India-Myanmar border, coupled with simmering unrest in Manipur, can wreck India's Act East and Neighbourhood First policies if an unfriendly regime returns to Dhaka. The threat from China to the Siliguri corridor will also reappear. The BIMSTEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation) will also be destabilised as

a regional grouping. Consequently, the role of the Army will be the key to maintaining India's strategic interests and ensuring stable and friendly relations with Bangladesh, given the love and labour that have gone into building them. India must send the right feelers to the keepers of the keys in Dhaka. A great deal is at stake for New Delhi, which took its eyes off the neighbourhood.

The ride has two phases: those who're not comfortable with heights can opt to come back from the Kondoori valley a mere 400 metres up the mountain. The country's premier, and possibly only Srinagar. bonafide ski resort town, Gulmarg and its pine-fringed meadows encircled by Mount Apharwat and surrounding snow-capped mountains have been part of popular culture and Bollywood since aeons. Even today, the 'meadow of flowers,' attracts droves of visitors in the summer who come here to ride in the world's second highest cable car, play golf, and take hack rides to the glaciers at Khilanmarg and further up to Al Pather Lake. In the winter, Gulmarg transforms into a faux Alpine ski resort with its famed powder attracting extreme skiers from across the

Maharani Temple

With its bright red sloping roof framed against the snowy peaks in the background, this small Shiva temple presents a striking picture in a corner of the main meadow in Gulmarg. Its claim to fame is derived from Bollywood: the site where the popular 'Jai Jai Shiv Shankar,' song in yesteryear's hit 'Aap Ki Kasam,' was shot, it's a popular spot with visitors for a photo-op. It's also a big Al Pather Lake destination during the festival of Shivratri.

Gulmarg Golf Club

world. Gulmarg is a four hour drive from The Gulmarg Golf Club, is amongst the most

spectacular courses in the country, possibly the world, to tee it up at. With 18 holes stretching over 7505 yards, including the 665 yard par-5 fourth hole, coupled with the elevated tees, up and down fairways, and penalising rough, it presents a severe test of physical and golfing abilities. It is also the highest green course in the country and indisputably the most authentic Scottish links-style layout in the land.

A gorgeous alpine lake, accessible after an arduous trek past a ridge of Mt. Apharwat (reached via the cable car) Al Pather remains frozen for most of the year. While serious



The clear azure sky suddenly changes colours and a darker shade of grey begins to envelop the atmosphere. It looks as if the sky was perennially missing the floating grey clouds in its vicinity. The rainiest place on planet earth for a substantial period in the past, Sohra in local parlance or Cherrapunjee as the world knows, creates a heavy concoction of flowing rivers, cool breeze, swaying trees and hot noodle soups. There is a thick cover of mist that greets anyone hose footstens cross these undulating green valleys. Cherrapunjee still retains the charm of a British summer retreat with solitary dilapidated bungalows and remnants of colonial churches dotting the verdant valleys in between the prolific number of hotels that have conjured up recently in these parts. Cherrapuniee is the second largest town after the capital city of Shillong in Meghalaya and lies at a distance of close to 56 km from Shillong. There are regular cabs available from Shillong for a 2 hour drive to Cherrapunjee. The sight of the waterfalls in the monsoon season from July-September is the prettiest but this place also offers cosy retreats and nature walks during the winter months from October to February.

Dainthlen Falls



About 2 km away from Cherrapunjee, one comes across this fall which is just 5 km away from the road. The splendour of this falls is enhanced by the presence of large number of natural potholes, much bigger in size and dimension than the regular ones on the metallic roads. The view of this waterfall tumbling down from a height of close to 80-90 m is from its source and provides a good opportunity to follow the path all the way to the bottom. There is a small legend associated with the name of this fall. According to locals, there was a huge demon python by the name of Thlen who was drenched in greed and power. Some brave men caught the animal and destroyed its hood with a huge stone near this fall. Some of the marks present on the stones are still reminiscent of the violent struggle of that snake, say the naysayers. As a result, this fall got this name. The turbulence of this fall gathers a lot of steam during the monsoons compared to the rest of the year.

Mawsmai Cave

To the south of Cherrapunjee Market, about 6

km away, lies the village of Mawsmai. At the village, a small clearing in the grasslands amidst the forests surrounding it leads to the entrance of this cave. This is a popular cave among the tourists and beginners alike. This cave is not very long and provides ample opportunity to see the stalactite and stalagmite formations of water dripping along the limestone walls. This is fully lighted and divided into old and new sections. A small entrance fee is charged from the tourists for entering this cave. A torch would be extremely handy in regions of narrow opening where the main source of light gets obstructed by the close proximity of the people in the queue. For the caving enthusiasts, there are some technical and challenging caves in Jaintia Hills where proper caving gears are required to do explorations. The population of bats inside the cave is almost negligible here due to excessive lighting and heavy visits of the regular tourists here.

Kynrem Falls

Kynrem Falls, located at a distance of 12 km from Cherrapunjee in the East Khasi Hills district is a three-tiered waterfall covering a distance of 305 m vertically. The base of the falls passes through the motorable road that goes all the way to Bangladesh and a small bridge provides movement for vehicles and

people across this waterfall. The fall spreads out in two different streams or rivulets with each of them gaining momentum by getting merged while flowing down the last leg of the third tier. The source of this fall originates from Thangkharang Park. It's the 7th highest waterfall in India and due to its seasonal nature; this waterfall is best enjoyed during the monsoons. The roaring din of the cascading fall poses a healthy competition to the noisy cicadas all around the neighbourhood of this fall.

Living Root Bridge

Living Root Bridges are century-old natural shoots of the banyan fig trees grown around the vicinity of large and small rivers which in turn aid in

providing a means to cross the bridges by entangling those shoots from opposite banks. As the shoots gain strength with time, the bridges become more and more robust. The phenomenon is unique and endemic to this part and travellers from around the world come to see the miracle of these living root bridges. There is a small village known as Tyrna, about 2 km from away from Cherrapunjee where the journey to these living root bridges begins. Across 25000 steps covering a distance of close to 3.5 km, the village of Nongriat is the focal point of the famous Double Decker Living Root

There are two layers of bridges on the river here as according to local tales, the lower living Root Bridge got submerged in a heavy deluge around 40 years back. As a result, a higher elevated living root bridge above this one was conceived to tide over this problem. Contrary to the popular belief, the living Root bridges are more sturdy compared to the steel wire ones and provide a firm footing on the base for easy movement all along. The small natural swimming pools around this bridge provide

good source of relaxation after a hard day's hike. There is also a small guest house on the other

side of the bridge run by Meghalaya Tourism

Sometimes heavy mist envelops the entire canyon and sighting the waterfall turns into a peek-a- boo through the dense layer. One needs to have a bit of luck and patience to witness its full glory. There are some good viewpoints all around the canyon to witness the magnificence of this waterfall.

Nohkalikai Falls

Badlapur: 12-hour delay in sex assault FIR but protesters arrested in 24 hours

The sexual abuse of two girls at a Badlapur school in Maharashtra has triggered outrage over allegations that the parents were made to wait for 12 hours at the police station.

New Delhi: Over 70 people have been arrested and five FIRs have been filed against 500 in just 24 hours over the protests in Maharashtra's Badlapur against the sexual abuse of two kindergarten students. The alacrity of the police in arresting the protesters pales in comparison to the action taken by the cops in registering the FIR, which apparently took 12 hours. The opposition has gone hammer and tongs in attacking the Mahayuti-led government over the insensitivity of the police. The opposition Maha Vikas Aghadi, which comprises the Congress, NCP(SP) and Shiv Sena (UBT), have alleged that the parents of the girls were made to wait for 12 hours at Badlapur police station before taking their complaints. The medical BADLAPUR CASE: OUTRAGE OVER examination of the girls was also reportedly delayed by 10 hours, prompting fears of a cover-up by the administration.

What has added to the outrage is the fact that the mother of one of the two girls was made to stay at the police station for over 10 hours despite being two-months pregnant, a report in The Indian Express said.

While the Maharashtra government has suspended three police officials for alleged dereliction of duty and handed the probe to a Special Investigation Team (SIT), it has done little to quell the outrage.

The school management has suspended the principal, a class teacher and a female attendant.

DELAY IN FILING FIR

The two girls, aged three and four, were sexually abused at a school in

Maharashtra's Badlapur by a cleaning staffer between August 12-13. The On Tuesday, thousands of people entered the accused, Akshay Shinde, was arrested by the police on August 17.

As per the FIR, police were informed about the incident on August 16. The FIR was allegedly filed 12 hours later -- around 9

pm on August 16.The delay in protesters, were pelted with stones. A filing the FIR has led to an outrage as in such cases circumstantial and medical evidence are crucial. ED officer, under CBI scanner in corruption case, dies by suicide

New Delhi: An Enforcement Directorate officer, who was under the scanner of the agency and the CBI in an alleged corruption case, has died by suicide. The body of Alok Kumar Pankaj was found on a railway track in Sahibabad near Delhi on Tuesday. Alok Kumar, a resident of Ghaziabad, was on deputation with the ED in New Delhi. Earlier, he had worked with the Income Tax department. Recently, he was questioned twice by the CBI in an alleged corruption case but was let off due to lack of evidence.lok Kumar Pankaj's name had cropped up in a bribery case after an assistant director of the ED, Sandeep Singh, was arrested by the CBI. The CBI received a complaint from a person that Singh had reportedly demanded Rs 50 lakh for not arresting his son. The agency then laid a trap and Singh was caught red-handed accepting a bribe of Rs 20 lakh in Delhi.

Singh reportedly also took bribes from a Mumbai jeweller whose store was raided by the Enforcement Directorate earlier. In the same case, Alok Kumar Pankaj was named as an accused along with Sandeep Singh in the FIR. Sandeep Singh was reportedly suspended following the case. The police have shifted the ED officer's body to a mortuary for post-mortem and are probing the case to ascertain the reason behind the

Malaysia PM hopes India 'plays its part' to deal with minorities, religious issues

New Delhi: Malaysian Prime Minister Anwar Ibrahim, on a state visit to India, said on Tuesday that India had to grapple with "some serious issues" affecting minorities or religious sentiments. He expressed hope that New Delhi would continue to play its rightful role in dealing with the issues faced by minorities." I will not deny the fact that you also have to grapple with some serious issues affecting minorities or religious sentiments. But our hope is that India continues to play its rightful role because I mentioned to Prime Minister (Narendra) Modi, that these were the years when Nehru and Zhou Enlai and Sukarno and Nyerere were there standing up for the Global South against colonialism and imperialism and to struggle to ensure that we recognise what humanity is about, what freedom is all about, and what dignity of men and women," he said at an interactive session at the ICWA in Delhi.

Ibrahim's remarks come at a time when India-Malaysia bilateral ties are slowly coming back on track after former Prime Minister Mahathir Mohamed criticised India over its move to scrap Article 370 from Jammu and Kashmir that granted special status and the passing of the Citizenship Amendment Act. New Delhi lodged strong protests and imposed restrictions on Malaysian oil imports.

However, since Ibrahim took charge in 2022, both countries settled trade in their own rupee and ringgit currencies in April last year. India's Malaysian palm oil imports have increased as well. Zakir Naik, a controversial Islamic preacher, who fled India in 2016, however, continues to be a major irritant in bilateral ties. He is currently in Malaysia after getting asylum there in 2018. Naik is wanted in India for serious charges related to terrorism after his name cropped up in connection with a ghastly terror attack at Holey Artisan Bakery in Dhaka in July 2016. During his address, Ibrahim indicated that his government may consider India's request to extradite Naik if New Delhi provided evidence against him.

He also said that the issue was not raised by the Indian side during his talks with PM Modi and asserted that it should not deter the two countries from enhancing bilateral relations."Firstly, it was not raised by the (Indian side). PM (Narendra Modi) did raise it much earlier, some years back. But the issue is I am not talking about one person, I am talking about the sentiment of extremism, of a compelling case and evidence that suggest the atrocities committed by an individual or group or faction or parties," Ibrahim said.

How RG Kar Hospital, at centre of storm, started from rented house 138 years ago

New Delhi:Kolkata's RG Kar Medical College and Hospital, steeped in the rich history of West Bengal, has grabbed nationwide attention after the brutal rape and murder of a trainee doctor in its premises. A portion of the hospital, the first non-government medical college in Asia, was also vandalised on the eve of Independence Day as doctors and women protested against the gruesome incident.It is probably the first time that the hospital, established in 1886 by Dr Radha Gobinda Kar (RG Kar) and which has been a cornerstone of Kolkata's healthcare system, has been hit by controversy in its 138-year-old history.Dr Řadha Gobinda Kar or RG Kar was born in 1852 in colonial Bengal. His more famous peer, Nil Ratan Sircar, was born nine years later, in 1961. He established the Nil Ratan Sircar (NRS) Medical College, which is located in Sealdah in the heart of Kolkata.Both RG Kar and NRS hospitals are the top state governmentrun institutions in Bengal, catering to thousands of patients every day.RG Kar remained as the secretary of the medical college till his death in 1918. The West Bengal government took over the institution on May 12, 1958. The college offers post-doctorate, PG diploma, fellowship, and



undergraduate programs. WHO WAS DR RADHA GOBINDA KAR?

Radha Govind Kar, a social reformer, had a keen interest in medicine from a very young age. He completed his studies at Bengal Medical College, which was the oldest medical college in Asia at that time. It later came to be known as Calcutta Medical College. He then went to England for further

studies after graduation and returned to India in 1886 with a medical postgraduate degree. After returning to India, Radha Govind Kar realised that Calcutta did not have an adequate number of hospitals as per the population. At that time, Calcutta was under the grip of several infectious diseases like Cholera and plague. This gave him the idea of establishing a new medical college. Govind Kar then started a medical college, the Calcutta School of Medicine, from a rented house in Kolkata's Baithakkhana Bazar Road in 1886. It provided a three-year medical course and studies were

conducted in Bengali. HOW DID RG KAR HOSPITAL GET ITS NAME?



When the Wayanad disaster struck Kerala this year, the memories and grief of losing a loved one was still afresh for survivors of Kavalappara in 2019. Then, they began to see the rescuing process being carried out. They saw how people were being saved. What could be done better? In 2019, they looked with desperate eyes to see any signs of their loved ones. They have now survived the worst. This time, they knew how to be of help in the Wayanad disaster. Since the morning of the disaster, people have been seeing dead bodies floating in the river and a search has been going on the Chaliyar river. Government agencies, local residents, and youth organisations have all come together along with the Kavalappara survivors to help the disaster-hit people of Wayanad. The residents of Mundakkai and Chooralmala in Wayanad have lost their loved ones, their life's savings, and an entire village. That they are survivors is seen as the area has seen over 400 deaths. All have lost their lives, a loved one and a village. Some have lost as many as 16 family members. The search is still going on. Members of 24 families who survived the Kavalappara disaster are on their side. The extent of the Wayanad disaster can be understood by the Chaliyar River in Malappuram district. Dead bodies have reached the Pothukallu and Munderi areas through the Chaliyar, which flows across the forest for about

Court dismisses driver's plea on preserving Delhi coaching centre flooding video

A Delhi court has dismissed a petition by the SUV driver arrested in connection with the deaths of three students due to flooding at a coaching centre's basement. The plea sought directions to preserve the CCTV footage of the incident site.

New Delhi: A Delhi court on Wednesday disposed of the petition of SUV driver Manoj Kathuria seeking directions to preserve the CCTV footage of the site of the flooded basement of a coaching centre in the city's Old Rajinder Nagar area. The incident killed three students.



During the hearing, the CBI informed the court that it had preserved the digital video recorder (DVR) of Rau's IAS Study Circle and the CCTV footage of Chahal Academy located in front of Rau's coaching centre. The court also gave a week's time to the CBI to file its report on the petition demanding the release of the SUV.Kathuria is accused of driving his vehicle through a flooded

road in front of Rau's coaching centre, causing the water to swell and breach the gates of the building. The sudden flooding of the institute led to the death of three students on July 27. The three civil service aspirants -- Shreya Yadav (25) from Uttar Pradesh, Tanya Soni (25) from Telangana, and Nevin Delvin (24) from Kerala -- died when the basement of their coaching centre

flooded amid heavy rain. Kathuria was arrested on the same day. The incident has stirred massive uproar, with people questioning the institute's flouting of norms and the authorities' failure to ensure proper enforcement of laws.Last month, a Delhi court rejected the bail plea of Kathuria, who is also a businessman by profession. He has filed a second bail plea in connection with the case. In his bail plea, the SUV driver said he was "innocent" and that his involvement in the incident was "completely hypothetical".

'He (Kathuria) is innocent and is not associated with the said offence in any manner whatsoever. All involvement, as speculated by the police authorities, is completely hypothetical, and there is no material to support any allegations. The blame for statewide infrastructural breakdown is being put on a single individual," the bail plea said.

Odisha's biggest aquarium, the Paradip Marine Aquarium, is also located in the Paradip city. It has 28 tanks with different species of fish. Paradip is also famous for its port, one of the oldest in the world. It stands testimony to the rich maritime heritage of the region.

Gopalpur Beach Situated 16 km away from Berhampur,

Gopalpur-on-Sea is a splendid retreat for avid beach lovers. From golden sands to clear blue waters, the beach has everything that can entice visitors. Besides a sunkissed beach, Gopalpur-on-Sea offers glimpses of its past glory as a commercial port. The crumbling walls and pillars of an ancient jetty can still be found on the beach. In fact, Gopalpur was once a bustling maritime zone in Odisha and a sea port through which early settlers of Southeast Asia sailed off. Established during the British rule, the port stopped functioning in 1942 during the Second World War. There are ruins of several bungalows and mansions belonging to the European merchants, which give it a colonial look. A red-and-white striped lighthouse also stands on the popular beach. Commissioned in 1871, it is one of the oldest lighthouses in the state. Every year during Kartika Purnima, people sail tiny boats made of banana stems and paper, with lamps, betel leaves, crackers, fruits and coins in them, to mark the rich maritime history of Gopalpur-on-Sea. The Sand Mineral Project lies in the vicinity, and is another attraction that cannot be missed. The area near the beach has a number of resorts and sea-facing hotels that are equipped with all amenities. The ideal time to visit Aryapalli is between the months of October and June, when the weather is at its best. Travellers can reach Arypalli beach through a taxi or an auto-rickshaw after getting down at the Chatrapur railway station in Ganjam district. The beach is just eight km from the railway station. NEW DELHI. Amid growing volatility in the domestic equity market, large and mid-cap funds are likely to be a big draw among investors in the coming days, anticipates ICRA Analytics. It stated that the possibility of having a diversified portfolio coupled with good returns is attracting investors to such funds.

The global equity market, including India, is witnessing heightened volatility at peak levels following escalating geopolitical risks and global uncertainty. There are concerns about the valuation of equities listed in India, especially in the mid and small-cap segments.

Large and mid-cap funds have seen over five-fold growth



in assets under management over last five years at Rs 2.57 lakh crore in July 2024, as against Rs 0.50 lakh crore in July 2019. MUMBAI.RBI governor Shaktikanta Das has said that it is natural for young Indians to explore other markets for their savings, given rising aspirations fueled by education and exposure to the internet. However, banks need to be prepared by managing liquidity and balancing credit growth with deposit growth. In an interview with NDTV, Das said that credit growth and disbursement have sped up, thanks to technology, but deposit collection is still mostly physical. "That's why, in the previous policy, I urged banks to create new deposit products and services and to leverage their extensive branch networks," said Das."If youngsters are turning to stock markets, insurance, and mutual funds, it is a good thing. What we have done is to provide advance caution to banks; there is no problem now, but looking ahead, we want to ensure they are prepared," said Das.

Starbucks' new CEO to commute by jet daily, won't relocate to Seattle HQ

New Delhi Starbucks' new CEO, Brian Niccol, will be making an exceptional daily commute to his new role. Niccol, who currently resides in California, will travel 1,600 kilometres each day to Starbucks' headquarters in Seattle.

According to his employment agreement, Niccol will use a corporate jet for this daily journey. Despite the distance, he is expected to work from Starbucks' Seattle office at least three days a week, in line with the company's hybrid work policy, which has been in effect since 2023.

Niccol, aged 50, will receive an annual base salary of \$1.6 million. Additionally, he is eligible for a cash bonus ranging from \$3.6 million to \$7.2 million, depending on his performance. He will also have the opportunity to earn up to \$23 million in annual equity awards. This commuting arrangement is not new for Niccol. When he was CEO of Chipotle in 2018, he arranged a similar deal. Chipotle,



which was headquartered in Colorado, moved its headquarters to California just three months after Niccol took on the role. A Starbucks spokesperson said, "Brian's primary office and a majority of his time will be spent in our Seattle Support Center or out visiting partners and customers in our stores, roasteries, roasting facilities and offices around the world. His schedule will exceed the hybrid work guidelines and workplace expectations we have for all partners."Such flexible work terms are often negotiated by high-ranking executives who have significant Hillary Super, the CEO of Rihanna's lingerie brand Fenty x Savage, was granted a similar arrangement, allowing her to work from New York City instead of Victoria's Secret's headquarters near Columbus, Ohio.However, not all CEOs have such leeway. Single-digit pay hike in IT new reality

Current salary spends and increments reflect sluggish performance, says a staffing company

BENGALURU. Last week when Nasdaqlisted Cognizant rolled out an increment to employees after a four-month delay, it had to face criticism on social media as wage hike starting as low as 1%.

Soon, the company in a statement said the merit increases for this cycle are tied to both individual performance and macro industry dynamics. As per sources, employees with the highest rating received only a 4.5% salary hike. Tata Consultancy Services (TCS) rolled out double-digit wage hikes for high performers and an average 4.5% to 7% wage hike for the rest of the emloyees, with effect from April 1.Infosys' last wage hike was in November 2023. Its CFO Jayesh Sanghrajka said during the Q1 earnings conference that they take multiple factors into account (inflation, peer practice) in case of a wage hike."At

this point we are evaluating all of that..we have improved our variable pay this year versus the last quarter and last year," he said. These companies are announcing singledigit hikes due to various factors including inflation. "Tech sector's compensation spend and increments are linked to the revenue performance and outlook for revenue growth. The current compensation spends and increments reflect sluggish performance on these two parameters," said Krishna Gautam, business head, Direct Hire - IT,

Xpheno, a specialist staffing company. As per Xpheno, the collective of top 7 IT services firms have seen 3.4% annual revenue growth in the quarter ending June 2024 as against June 2023. The collective has accordingly controlled compensation costs with 2.8% annual growth for the same period.

"Having incurred high spend manpower absorptions during the buoyancy of 2021 and early 2022, the

The restrained salary hikes of 2% to 4% in IT companies this fiscal year are primarily driven by global economic headwinds and tightening profit margins, said Ramesh Alluri Reddy, CEO, TeamLease Degree Apprenticeship. While the IT sector had been offering robust increments during the pandemic to retain top talent, the current economic landscape is more challenging. "Global uncertainties and potential slowdowns in key markets like the US and Europe have led to cautious client spending, directly affecting the revenue growth of Indian IT firms. Additionally, rising inflation and the need to invest in next-generation technologies are exerting pressure on profit margins, prompting companies to adopt a conservative stance on salary increments," he explained. Moreover, IT organisations are increasingly prioritising operational efficiency and are channeling significant raises towards employees in strategic roles or those possessing niche skills that are critical for business transformation.

All eyes on Jay Shah as ICC chairman Barclay opts out of 3rd term

New Delhi Current ICC chairman Greg Barclay on Tuesday opted out of a third term following the end of his tenure on November 30, fuelling speculations on BCCI secretary Jay Shah's future at the sport's governing

Whether Shah will be interested to throw his hat in the ring will be clear by August 27, the last date for filing nominations for the chairman's post. An ICC chairman is eligible for three terms of two years each and Barclay, a New Zealand-based attorney, has so far completed four years."ICC Chair Greg Barclay confirmed to the Board that he will not stand for a third term and will step down from the post when his current tenure finishes at the end of November. Barclay was appointed as the Independent ICC Chair in



November 2020, before being re-elected in 2022," the ICC stated in a media release. In all, a person can stay in office for a cumulative period of 18 years.

Former India bowling coach Paras Mhambrey has advocated that Mayank Yadav bowl as much as he can. The injury prone pacer has been away from the game after playing 4 matches in the Indian Premier League's 2024

New Delhi. After a sensational debut in the Indian Premier League's 2024 season, things have been eerily quiet for Mayank Yadav. The young pace sensation from Delhi who took the world by storm with his exceptional speed and accuracy has not played a single match since the conclusion of the tournament. Former India bowling coach

Paras Mhambrey has advised that Yadav should not be kept in a cotton wool by the Board of Control for Cricket in India and rather should be bowling as many overs as possible in the nets, at this young age.

The 22-year-old, playing for LSG consistently breached the 150 kmph mark in the 4 matches that he bowled in, leaving seasoned batsmen bewildered. In his debut match against PBKS, Mayank clocked a speed of 155.8 kmph, the fastest ball of IPL 2024 at that point. He took three wickets, including those of Jonny Bairstow and Prabhsimran Singh, and was instrumental in LSG's victory. This performance was not a one-off, as he continued to impress against RCB, where he clocked a speed of 156.7 kmph, the

fastest delivery in IPL 2024. Mayank Yadav: Dark horse in BGT?

I strongly feel Mayank needs to grind it out in the domestic season," Mhambrey added. The

former India bowling coach said he did not care about the long term plan with Mayank, but wanted to see what the pacer brings to the table in the next 5 years."I am not looking at the next 10 or 15 years. I want to see what he can do in the next five. The next three-four years will be extremely crucial for him. Once he is 25-26, he will understand his body much better. And then he will have a good five years at the international level," Mhambrey added on the matter.

England cricket team will pay tribute to the late Graham Thorpe before the start of its Test match against Sri Lanka at Old Trafford, Manchester on Wednesday, August 21. Thorpe died by suicide, aged 55 on August 4.

Manchester, The England cricket team will pay tribute to former batter Graham Thorpe, who died earlier in the month, ahead of the first of their three-match Test series against Sri Lanka. Before the national anthems at Old Trafford in Manchester on Day 1, England players will remember the celebrated cricketer. A tribute video will be played on the big screen at the iconic cricket ground.Stand-in captain Ollie Pope confirmed that the England players will wear black armbands throughout the Test match, which gets underway on Wednesday, August 21. Thorpe died by suicide on August 4 after battling 'major depression and anxiety'. His widow Amanda confirmed that Thorpe decided to take his own life despite multiple



him battle mental health issues. Ollie Pope conceded that the news of Graham Thorpe passing away had hurt a lot of people in the England dressing room, especially those who worked with the former cricketer. Thorpe played 100 Tests for England before he worked with the senior national team in coaching roles.

The coroner, Simon Wickens, expressed heartfelt condolences to Thorpe's family and all those affected by his life and career. England will begin the first of their three Tests against Sri Lanka on August 21, hoping to stitch an unbeaten run as the race of the World Test Championship final berths reaches its last phase. Kolkata Three iconic and historic clubs of Kolkata, East Bengal, Mohun Bagan, and Mohammedan Sporting Club, held a joint press conference on Tuesday, 20 August, to demand justice for 'Abhaya'. The arch-rival clubs of Kolkata also jointly demanded that the remainder of the Durand Cup matches be played in Kolkata. The 'Big 3' also stressed that the protests made by the club supporters and officials should not be politicised. Last Sunday, the Derby match between East Bengal and Mohun Bagan was cancelled due to concerns over the law and order situation in the city. However, sports enthusiasts and fans did not take this decision well. Supporters of these iconic clubs were seen protesting against the West Bengal government and the police in front of the Vivekananda Yuva Bharati Krirangan on Sunday, 18 August, demanding justice for Abhaya.Debashis Dutta, Secretary of Mohun Bagan Club, stated, "We do not want to politicise the matter. We, from the three clubs, want justice for Abhaya."Citing security concerns, the Kolkata Police had informed the Durand committee that they could not provide a large deployment during the match. The supporters felt that the government was afraid and had to cancel the historic Kolkata Derby, one of the biggest derbies in Asia. Emotions ran high as the supporters took to the streets, demanding justice for the girl who was raped and murdered at RG Kar Hospital in Kolkata. The historic images showed the three rival clubs united in their protest, demanding justice for Abhaya. The protesters were heard raising slogans against the government and the police. The clubs also demanded justice for Abhaya. Ishtiaq Ahmed, Secretary of Mohammedan Sporting Club, said, "We are deeply saddened by the incident. We want justice for this. We demand justice for Abhaya and we want the accused to be hanged. 


