# SC terms 'extremely disturbing' police delay in registering unnatural death in Kolkata case

New Delhi, August 22: A tough-talking Supreme Court on Thursday termed "extremely disturbing" the Kolkata Police's delay in registering the unnatural death of the woman doctor raped and killed at the RG Kar Hospital, and also asked protesting doctors to get back to work. Justice and medicine cannot be stopped, the court said while hearing a suo-motu case on the Kolkata doctor's horrific end and directed the Centre and the states to take urgent steps to institutionalise the safety of medics across the country. A bench headed by Chief Justice D Y Chandrachud issued a slew of directions on the safety of doctors, norms for protests, rights of protesters as well as the West Bengal government. It said the National Task Force (NTF) formed by the apex court will take note of the suggestions of all the stakeholders while formulating a national protocol for the safety of healthcare professionals, including the associations representing resident doctors. "We direct the secretary of the Union Ministry of Health to engage with the chief secretaries of the states and directors healthcare professionals," the bench said, while ordering that the exercise be completed in a week. Appearing in the court on behalf of the Central Bureau of

Investigation (CBI), Solicitor General Tushar Mehta alleged that senior doctors at the Kolkata hospital as well as the victim's colleagues had asked for videograph, which means even they felt that there was a cover-up. "The (victim's) father insists on the registration of an FIR. The hospital does not register the FIR. The father insisted and got the FIR registered. The FIR is lodged after the cremation. This is an attempt to cover up. We entered the probe on day five, everything was altered by then," Mehta said. He said the first FIR in the incident was filed only after the victim's cremation at 11:45 pm. "Initially, the authorities told the parents that it was suicide but later, it was classified as death," he added. As the hearing commenced after lunch, the court asked what was the reason for a 14-hour delay in lodging

It directed the Kolkata Police officer, who registered the first entry about the incident that has shocked the country, to appear in the next hearing and disclose the time of the entry. Mehta told the court that the most shocking fact is that the FIR was registered at 11:45 pm, after the post-graduate medic was cremated "The state police told the parents it was suicide. Then they said it was murder. Victim's friends suspected a cover up and insisted on videography," Mehta told the bench. The bench said peaceful protests over the Kolkata

incident shall not be disturbed or disrupted by the West Bengal government. The court, however, clarified that it has not injuncted the state government from exercising such law-

### Ayodhya gang-rape accused Moid Khan's 'unauthorised' shopping complex demolished

Ayodhya (UP), August 22: The district administration on Thursday bulldozed a shopping complex here belonging to Moid Khan, a gang-rape accused alleged by BJP to be a member of the Samajwadi Party (SP). The Ayodhya police on July 30 arrested Moid Khan, who ran a bakery in Bhadarsa Nagar of the Purakalandar police station area of the district, and his employee Raju Khan for allegedly raping the 12-year-old girl two months ago and recording the act. The incident came to light when recently a medical examination revealed that the victim was pregnant. The bulldozers started demolishing the shopping complex in Bhadarsa town around 1.30 pm. According to the police, the shopping complex was vacant and a branch of a bank operating there was shifted before the demolition. Sub-Divisional Magistrate of Sohawal Tehsil AK Saini said, "The shopping complex of Moid Khan was built on government land. So action was taken to demolish the unauthorised building." Heavy security arrangements were put in place in Bhadarsa town with the deployment of provincial armed constabulary and civil police to ensure that law and order is maintained, officials said. On August 3, the Ayodhya district administration demolished Moid Khan's bakery that was allegedly built illegally over a pond. BJP leaders, including Chief Minister Yogi Adityanath, have alleged that Moid Khan is a member of the Samajwadi Party and is part of the team of Faizabad MP Awadhesh Prasad.

### 'Full emergency' at Thiruvananthapuram airport after bomb threat on Air India flight from Mumbai

Thiruvananthapuram, August 22: A full emergency was declared at Thiruvananthapuram International Airport on Thursday after a bomb threat message was found in the washroom of an Air India flight arriving from Mumbai, according to airport sources. The pilot of the aircraft informed the ATC about the threat after a 'Bomb in flight' message, written on a tissue paper, was found in the washroom of the plane, they said. They also said that the police have initiated an investigation into the incident. The aircraft is currently being inspected by security agencies, including a bomb detection squad, the sources said, adding that the passengers who travelled on the flight are presently wait



ing for their luggage to be delivered. Meanwhile, Air India, in a statement, said that a specific security alert was detected on flight AI 657 during cruise from Mumbai to Thiruvananthapuram and "the crew carried out all the laid down security drills keeping passenger safety as top priority." "All passengers and crew disembarked safely. Air India accords top priority to the safety of its passengers and crew," an airline spokesperson said. The flight with 135 passengers landed safely at the airport around 8 am and was moved to an isolation bay, airport sources said earlier.

### Alliance with Congress final on all 90 seats: NC chief Abdullah

Srinagar, August 22: An alliance with the Congress is final on all 90 Assembly seats in Jammu and Kashmir, National Conference president Farooq Adbullah said on Thursday. The announcement came after Leader of Opposition in the Lok Sabha Rahul Gandhi and Congress president Mallikarjun Kharge met the National Conference leadership at Abdullah's residence. "We had a good meeting, in a cordial atmosphere. The alliance is on track and, God willing, it will run smoothly. The alliance is final. It will be signed this evening and the alliance is on all 90 seats," Abdullah told reporters. The three-phase elections to the 90member Jammu and Kashmir Assembly will be held on September 18, September 25 and October 1.

### Flood situation in Bangladesh not due to release of waters from Indian dam on Gumti river

turned down suggestions that floods in the neighbouring Bangladesh had been caused by opening of gates of a dam across the Gumti river in Tripura. The Ministry of External Affairs issued a statement saying it has seen concerns being expressed in Bangladesh that the current situation of flood in districts on the eastern borders of Bangladesh has been caused by opening of the Dumbur dam upstream of the Gumti river in Tripura. The statement said the catchment areas of the Gumti river that flows through India and Bangladesh have witnessed heaviest rains of this year over the last few days. The flood in Bangladesh is primarily due to waters from these large catchments downstream of the dam. The Dumbur dam is located over 120 km upstream of the India-Bangladesh border. The dam is just about 30 metres in height that generates power feeding into a grid and from which Bangladesh also draws 40MW power from Tripura. Along the 120 km river course in India, there are three water-level observation sites at Amarpur, Sonamura and Sonamura 2 in Tripura. Heavy rain has been continuing since August 21 in the whole of Tripura and adjoining districts of Bangladesh.

### ITBP gets cadre officer as ADG in rare appointment

New Delhi, August 22: Sanjeev Raina, a 1987-batch ITBP officer, has been appointed Additional Director General (ADG) in the India-China LAC guarding force. He becomes only the second non-IPS officer who has been elevated to this post in the force. An order issued by the Ministry of Home Affairs (MHA) on Wednesday said Raina, serving as an Inspector General (IG) at the force's central sector headquartered in Bhopal, is being elevated to the ADG rank apart from another officer, IG Jaspal Singh, for the panel year 2024. However, Raina, 59, will serve in the new post for just over a month, as he is scheduled to retire next month. A rank-piping ceremony was held at the Indo-Tibetan Border Police (ITBP) headquarters on Lodhi Road here on Thursday in the presence of DG Rahul Rasgotra and other sen-

ior officers. Raina has now been posted as the ADG (western command) of the ITBP headquarters in Chandigarh, the order said. The formation looks after the deployment of the force along the Line of Actual Control (LAC) in Ladakh, Uttarakhand and Himachal Pradesh, apart from supervising units located in Punjab, Delhi, and Jammu and Kashmir. Officials said the ITBP was raised in 1962, and it would be the second time a cadre officer has been elevated to the ADG post, the second highest rank in the force. The ADG post in the ITBP and other Central Armed Police Forces (CAPFs) is essentially occupied by officers who come on deputation to these organisations from the Indian Police Service (IPS). A senior officer said, "This appointment also came late as the departmental promotion committee meeting was delayed. Jaspal Singh will be appointed ADG after Raina's retirement and he too will retire in a few months, in December." Raina, who hails from Kashmir, joined the ITBP in November 1987 and has served tenures in Ladakh, Jammu and Kashmir, and the Northeast.



Speaking to a Marathi news channel, the parents said there is no truth in the allegations against their son. The accused, who worked as an attendant, has been arrested for allegedly sexually molesting two 4-year-old girl students inside the toilet of a school in Badlapur town in Maharashtra's Thane district. A local court on Wednesday sent him to police custody till August 26. "Our son had been doing the job for the past 15 days. He used to go to the school by 11 am daily to clean the bathroom. He would then proceed to another place for similar work," his mother claimed. The mother

Srinagar, August 22: Congress chief Mallikarjun Kharge on Thursday expressed his willingness to forge an alliance with other opposition parties for the upcoming Jammu and Kashmir Assembly polls and termed the ruling BJP's promises to the people of the Union Territory "jumla". Kharge, along with Leader of Opposition in the Lok Sabha Rahul Gandhi, spoke to Congress leaders and workers here on Thursday to get feedback about the party's grassroots-level preparations for the Assembly polls. "This was the first meeting after the polls were announced... We are here to seek the views of local leaders and workers for the polls and alliances. Under Rahul Gandhi's leadership, we have taken the initiative to restore statehood for Jammu and Kashmir. We promise to work towards that," Kharge told reporters here. He said Gandhi is interested in forging a pre-poll alliance in the Union Territory. "Rahul Gandhi is interested in contesting the polls unitedly with other parties in Jammu and Kashmir. We have had success as well. We have seen the results in the Lok Sabha polls. The INDIA bloc stopped a dictator from coming to power (at the Centre)

with an absolute majority. This is the biggest success of the INDIA bloc," Kharge said. The Congress president said the Bharatiya Janata Party (BJP) is worried after the Lok Sabha polls as some of the legislations it was keen on passing in Parliament have either been withdrawn or sent to a Joint Parliamentary Committee. He claimed that the BJP used to take advantage of its brute majority in Parliament to pass anti-people laws like those on the farming sector. About Jammu and Kashmir, Kharge said not a single promise made by the BJP to the people of the region before elections has been fulfilled. "Not a single promise made to the people of Jammu and Kashmir before polls has

### 96 tonnes waste cleared from 1,265 Chennai bus stops

CHENNAI. Greater Chennai Corporation (GCC) conducted a mass cleaning drive across 1,265 bus stops in the city on Wednesday, removing nearly 95.7 tonnes of waste and construction debris. Moreover, as many as 4,221 posters and 47 unauthorised advertising hoardings were also taken down. Under the supervision of GCC officials, a total of 2,541 workers across all 15 zones conducted the drive which included garbage disposal, removal of construction debris, posters, and unauthorised banners, along with cleaning benches at bus stops. According to a release, overgrown shrubs were trimmed, encroachments cleared, and around 78 minor faults identified for further action.

The drive is part of a mass cleaning campaign that began on July 22, to cover 471 bus



route roads spanning 418.56 km. The campaign has since been extended to 36,640 interior roads across the city, spanning 5,270 km. Complaints regarding civic issues can be reported by calling the GCC helpline 1913.

### Home Buyers Forum urges Karnataka Governor to address **RERA** implementation **ISSUes**

BENGALURU. A forum representing home buyers across Karnataka has recently written to Governor Thaawarchand Gehlot, seeking his intervention to restore the rights of home buyers. The Karnataka Home Buyers Forum has cited irregularities and loopholes in the Real Estate Regulation Act (RERA) rules, which have rendered it ineffective and not of much use to home buyers.Its communication to the governor on July 17 says, "An important failure of RERA authority is not giving directions on implementation of section 17 of RERA 2016 which speaks about Transfer of Common Area land to association of allottees. Till today neither RERA nor Government of Karantaka have declared as to who is the competent authority for registration of apartment owners/allottees associations and how the land transfer should happen to

association as per the RERA guidelines." Due to a lack of clarity, apartment land continues to be in the name of builders or landowners, who have started mortgaging the land even after apartments have been sold to home buyers, charged the convenor of the forum, Dhananjaya Padmanabhachar. The letter urged the governor to advice the state government to restore the rights of property owners by declaring the competent authority for the apartments, as well as release guidelines on common area transfer to associations.

### Assamese girl gone missing from Kerala found from a train in

THIRUVANANTHAPURAM: Putting to rest the anxiety and apprehensions that lasted more than 36 hours, the 13-year-old Assamese girl, who went missing from Kazhakootam on Tuesday morning, was found on a train at Visakhapatnam railway station. The girl was found asleep on one of the berths in the Santragachi Antyodaya Express by Keralites, who identified her to be the missing child, and informed the matter to the Kerala Samajam members in Visakhapatnam. The child was taken out of the train and handed over to the Railway Protection Force. The child was visibly exhausted due to hunger, but her health was otherwise satisfactory, sources said. The sources added that the train reached Visakhapatnam station by 10 pm and the child was handed over to the railway officials. The matter was duly conveyed to the child's parents in Kazhakootam, who profusely thanked the state police and the media for getting the child back without any harm. The police from the CCTV visuals got to know that the girl reached Egmore station on Wednesday morning via a train from Kanyakumari. Thereafter, she took the train that departed Chennai by 8 am. The police had doubts that the child could've taken a train to Kolkata as the direct train to Guwahati was not available. The police sources said they had alerted the railway police and the local police about."There were two trains travelling towards Kolkata. On Wednesday night, one of the trains had reached Vijayawada, while the other was approaching Visakhapatnam.

# 47% of bus commuters in Mumbai now rely on apps to book tickets: Survey

MUMBAI. A collaborative survey by the Internet and Mobile Association of India (IAMAI) and Grant Thornton has shown that 47% of Mumbai's bus commuters are now using city travel apps to plan and book their journeys, signifying a significant shift towards digital convenience.

# Teen climber Preetham Goli conquers Kilimanjaro with mentor's guidance

HYDERABAD: At just 16 years old, Preetham Goli achieved something extraordinary — he reached the summit of Mount Kilimanjaro, Africa's tallest peak, with guidance from his mentor, Satyarup Siddhanta. This impressive feat showcases not only his physical strength but also his mental toughness and unyielding determination. The journey was far from easy. Over eight days, Preetham, student of Delhi Public School, Nacharam, faced the harsh realities of mountaineering: bitter cold, physical exhaustion, and the solitude of the climb. Reflecting on his experience, Preetham said, "I'll never forget those eight days. Loneliness was one of the toughest challenges, but I've learned to accept it. The hardest part was summit day — we started climbing at night and reached an altitude of 5,895 m, which was nervewracking. My hands and feet often got freezing, and on summit day, I had a terrible headache, which is common at that height, but it was still really tough." Despite these difficulties, Preetham's

resolve never wavered. His trek to Everest Base Camp had taught him the importance of mental strength. "I was physically prepared, but you can never predict how your body will react. I kept up with running, yoga, and a good diet. Mental strength is even more crucial than physical fitness. You have to be determined and not give up," he explained. Preetham's interest in mountaineering began at a young age, sparked by

documentaries about Everest and inspired

by his uncle. However, it was his connection with Satyarup Siddhanta that truly ignited his passion. "Satyarup Sir was the only one who guided, supported, and inspired me to climb Kilimanjaro. He's a role model for me and helped me every step of the way," Preetham said, clearly moved by his mentor's



support.Preetham's climb became a journey of self-discovery. He came to value companionship and the importance of nurturing relationships. "This trip made me realise how trivial it is to end a good friendship over a minor argument. Being alone made me appreciate the value of being around others. I learned that inner peace is more important than anything else," he noted. Initially, Preetham's

parents were worried about him taking on this challenge, especially after he fell ill following his Everest Base Camp trek. "At first, my family, particularly my mom, was hesitant about me going to Kilimanjaro. They were scared because I had been very sick after Everest Base Camp. But after talking it over and giving it some thought, they eventually supported my decision," Preetham

Reaching the summit was an emotional moment for Preetham. "The feeling when you reach the top is indescribable. When I eventually arrived, I was met with a breathtaking view of the crater. The mountain's beauty is beyond words. I just sat on a rock, listened to music, and soaked in the view. All I felt was pure happiness," he said.

Looking ahead, Preetham has ambitious plans. "Next year, I'm hoping to climb Mt Elbrus in Russia and will take a mountaineering course. I also want to do another Everest Base Camp trek with friends. After that, I plan to keep climbing and continue this journey indefinitely," he shared with unwavering determination.Preetham's story is about more than just a physical achievement; it's about a young man discovering his passion, pushing his limits, and inspiring others to pursue their dreams. ### Mumbai school bus association launches sensitisation camps for drivers after Badlapur incident

MUMBAI. The School Bus Owners Association (SBOA) has taken the initiative to organise sensitisation camps for bus drivers in a few schools in the far-flung western suburbs on Wednesday.

While the camp was held in four schools in Virar, three in Vasai, and one in Mira-Bhayander, it will now be conducted at Andheri and a few other schools in the western suburbs of the city on Thursday, said SBOA president Anil Garg.

This move comes in the wake of the recent incident in Badlapur, where two nursery students were sexually abused by a school sweeper. Garg stated, "In the past, there have been incidents of bus attendants or drivers molesting young students, and we want to warn everyone about the dire consequences." The association has begun training drivers and female attendants in the buses, with approximately 12 school sessions conducted on Wednesday.SBOA plans to provide similar training in all other schools in Mumbai and across the region, emphasising the importance of maintaining a professional distance from students and the severe consequences of any misconduct.

The association has also instructed all bus operators to ensure that their school buses are equipped with functional CCTV cameras and that no bus should pick up or drop off children without the presence of a female attendant. In cases where the female attendant is absent, school principals are requested to provide support staff or teachers to accompany the children on the bus."Additionally, the association stresses the importance of educating students about the concept of good touch and bad touch," Garg said. The primary objective of these sensitisation camps is to raise awareness among bus drivers and attendants regarding the grave consequences of any form of sexual abuse or training sessions will address various aspects of child safety, such as maintaining appropriate boundaries with students, ensuring the presence of a female attendant on the bus, and the proper functioning of CCTV cameras.

# Tribalography exhibition offers insight into Indian tribal life through captivating photography

HYDERABAD: Portraits of women with long and sagged ear holes, heavy jewellery covering the collarbone to neck, banglesized nose rings, and tattoos all over their bodies — wondering what? These are just a few observations from 'Tribalography', a photography exhibition on Indian tribes. Andhekar Sathish Lal, the photographer who travelled thousands of miles to capture the lifestyle of these hidden forest communities, offers Hyderabadis a glimpse through this exhibition. Capturing the essence of tribal communities for more than a decade, Sathish Lal explored nearly 20 states across the country. 'Tribalography' features around 110 photographs spread across three galleries on the second floor of the Chitramayee State Gallery of Art. Natural surroundings, festivals, candid portraits, women, and jewellery are some of the highlighted themes. The walls are adorned with beautiful pictures of tribes such as the Drokpa Tribe from Ladakh, Konyak Tribe from Nagaland, Lajia Saora Tribe from Odisha, Dongria Tribe from

Odisha, Jat Tribe from Gujarat, Munda Tribe from Jharkhand, Bonda Tribe from Odisha, and many more. Previously exhibited in New Delhi, his works received appreciation from Draupadi Murmu, President of India, and 65 of his photographs remain on permanent display at the Tribal Art Museum, Rashtrapati Bhavan. This year's exhibition featured few more tribes, including Changpa from Nagaland, Lokpa from Nagaland, Koraga from Karnataka, Halakki from Karnataka, Dhurwa from Chhattisgarh, and Muria from Chhattisgarh.

Having worked as a photographer for a Telugu daily for over 15 years, Sathish's exploration began with the Banjara and Chenchu tribes in Telangana. However, his inspiration dates back to his childhood when he grew up with his grandparents in the Ranga Reddy district of Telangana. "From childhood, I have been very keen to know about the tribals' attire and their culture because my primary studies were done in my grandmother's village where our native tribes, the Lambadas, lived



very near to my grandmother's house. At that time, many questions were in my mind why they are like this, and why their attires are different from other people... And I took this tribal photography seriously 14 years back when I read the news about how the culture of these tribes is declining day by day. So, I thought to capture all of them before they and their culture vanish due to modernisation," he shared.

Recalling a few memories from his exploration of tribal cultures, Sathish described a lifetime memory from his first

photo exhibition for tribals in a weekly market in a tribal area in Odisha.

### **Knockout blow: Boxer** lands in hot water over fake documents in Haryana

GURGAON. An FIR has been lodged against a boxer for allegedly participating in the Junior Asian Championship trials in Rohtak using forged documents. Complainant Naresh Walia alleged that Hardik, who defeated his son Devansh, a boxer from Hisar, in the final round of the trials, had used counterfeit documents to compete.Based on Walia's complaint, police have registered a case under section 318(4) (cheating and dishonesty) of BNS against the boxer, who is from Sonipat, for participating in the trials with fraudulent documents."I went to Sonipat where I was told that I could fetch the birth certificate of Hardik. I sought help from everyone I knew who could help. I also asked the federation to show me a direction. Finally, I was able to get a provisional copy of his birth certificate which showed a three-year age gap," said Walia. Police officers in the Urban Estate station in Rohtak are investigating how Hardik misled the federation to participate in Junior Asian Championship trials, which were held on August 11 at the Rajiv Gandhi Stadium in Rohtak."My son's final match in the junior group's 80kg category was against boxer Hardik. Hardik appeared to be older. When asked to provide documents to verify his age, he refused to show them," said Walia.

Walia further added that Hardik's birth certificate mentioned his date of birth as March 25, 2005. However, the certificate he provided for participating in Junior Asian Championship trials lists his date of birth as March 25, 2008."Hardik cheated my son by competing in the junior group instead of the senior group using fake documents. We have also filed a complaint against Hardik with the Boxing Federation of India," said Walia.

### Nailed: Carpenter murdered in Manesar; 3 arrested

GURGAON: Three persons were arrested for allegedly murdering a 27-year-old carpenter in Manesar. Two workers who were clearing bushes in the greenbelt found Ramparichhan Sharma's body stuffed in a plastic drum in the stormwater drain in front of an automobile company on Aug 17.On Tuesday, police arrested Sharma's brother-in-law Panchdev Thakur, a carpenter, his wife Indu, and their friend Chandan in connection with the murder.According to the police, Sharma, a resident of Begumpur Khatola, had an affair with Indu. Panchdev, who came to know about it, had made his wife call Sharma to their house in Bas Kushla and strangled him when he was asleep on the night of Aug 14.On Aug 17, police received an alert from the security staff of the automobile firm around 4.30pm about a stench from a drum, win which cops found Sharma's body with an electric wire tightly wound around his neck. The body was sent for autopsy. But the body was not identified. On Aug 18, Sharma's family members approached IMT Manesar police, saying he went missing after leaving the house on Aug 14. A missing complaint was filed on Aug 15 at Badshapur police station. The family identified the body to be of Ramparichhan Sharma on Aug 18.

After analysing Sharma's call records, cops found Panchdev had contacted him. Panchdev and Indu were taken to the police station on Aug 20 for questioning.

Indu was sent to judicial remand on Tuesday. Panchdev and Chandan are in police remand.

### Gurgaon: Final voter list for assembly polls to be ready by Aug 27

GURGAON: A total of 18,013 applications for voter registration were received by the district administration by Aug 16, during the voter verification campaign ahead of the assembly elections. Of these, 5,204 names have been added to the voter list and 269 applications have been rejected. The final voter list will be published on Aug 27. The SDMs and electoral registration officers of Pataudi, Badshahpur, Sohna, and Gurgaon assembly constituencies are addressing the claims and objections received during the review campaign. This work will be completed by Aug 26, and the final voter list will be published on Aug 27. Deputy commissioner of Gurgaon, Nishant Yadav, who is also the district election officer, said that after the announcement of the assembly elections, only those who submit online or offline applications by Sept 1 will be registered. The supplementary list of the final voter list will be released on Sept 12 and the nomination process for the election will begin on Sept 5.The DC said between Aug 3 and Aug 16, as many as 6,146 applications for new voter registrations were received in the Gurgaon assembly constituency. Out of these, 47 applications were rejected, and 1,863 names were added to the voter list. The resolution of 4,236 applications is still pending. During the same period, 6,169 applications were received in the Badshahpur assembly constituency. Of these, 85 applications were rejected due to ineligibility, 2,223 names were added to the list, and 3,861 applications are pending. In Sohna, 2,711 applications for voter registration were filed between Aug 3 and Aug 16, out of which, 23 names were added, and 2,688 applications are pending

# WHO calls for accelerated action to provide lifesaving vaccines to all children, protect adolescent girls from cervical cancer

New Delhi | 22 August 2024: The World Health Organization today called on countries in WHO South-East Asia Region to accelerate action to protect all children with life-saving vaccines being offered under the childhood immunization programme, focusing on those who have missed all or some vaccine doses, and protecting all adolescent girls from cervical cancer. "We should aim for a 'big catch-up' to vaccinate all zero dose and partially vaccinated children, and restore immunization progress lost during the pandemic; protect all adolescent girls from cervical cancer and accelerate efforts to eliminate Measles and Rubella from WHO South-East Asia by 2026," said Ms Saima Wazed, Regional Director WHO South-East Asia, in her inaugural address to the 15th Meeting of the South-East Asia Regional Immunization Technical Advisory Group (SEAR-ITAG). The Regional Director acknowledged and thanked all experts, national programme managers, immunization champions, partners including the vaccinators and community workers, and the communities themselves, on expanded immunization programme completing 50 years this year. "We can proudly say, in the last 50 years, together, immunization programmes have helped hundreds of millions of people in our Region live healthier,

longer, more productive, and prosperous lives," the Regional Director said. "Today, South-East Asia Region continues to be free of wild polio virus transmission and

has maintained elimination of maternal and neonatal tetanus as a public health problem. Five countries have eliminated measles and rubella, and six have controlled hepatitis B through immunization. Seven countries consistently reach over 90% of children with three doses of diphtheria, pertussis, and tetanus (DTP3) vaccines," she said. However, the Region missed the target to eliminate measles and rubella by 2023. The WHO/UNICEF Estimates of National Immunization Coverage data released last month shows slow

progress and no meaningful change in childhood immunization coverage last year compared to 2022, and coverage is yet to be restored to the pre-pandemic 2019 levels. "Nearly 2.7 million children in our Region did not get any vaccine and another 0.6 million children were partially vaccinated in 2023. We need to understand where and why these children were missed and priorchild should ever fall sick or die of any vaccine preventable disease, when safe and effective vaccines exist to protect them," Ms Wazed said. The stagnation in post-pan-

### Man promises to take girl to her boyfriend, kills her

Gurgaon. A 26-year-old man who promised to take an 18-year-old girl to her boyfriend — his nephew — allegedly confined her to a room for two days and then killed her. Police said the girl grew suspicious and threatened to call the cops, after which he took her to a secluded place on April 30 with promises of arranging a meeting with her boyfriend, where he killed her and dumped the body in the bushes. The accused — identified as Santosh, who is originally from UP's Aligarh and was living in a rented accommodation in Gurgaon's Shivaji Nagar — was arrested on Friday. Police said they are trying to ascertain the actual motive behind the murder and why the accused confined the girl for two days, woman's body was found in the bushes at a vacant plot near Bandhwari village on May 1. The body had a scarf wrapped around the neck. A murder case was registered at the DLF-1 police station based on a complaint by the Bandhwari sarpanch. During the investigation, the woman was identified, and the case was handed over to the Sikanderpur crime branch. Cops discovered that a complaint of a missing girl had been registered at another police station and contacted the girl's family, who identified the body. She had gone missing from the city on April 30.iven the seriousness of the crime and to identify and arrest the accused, police announced a reward of Rs 20,000 for the arrest of the accused. After several weeks of investigation, the police managed to arrest Santosh on Friday. During police interrogation, Santosh revealed that his nephew and

the girl were in a relationship. When her family found out about this, they met Santosh, who pretended to counsel the girl and gave her his mobile number. He promised to arrange her marriage with his nephew.On April 27, the girl left her house for tuition, but went to Santosh's place instead. Santosh kept her in his room for two days. When she started insisting that he take her to his nephew,

Santosh instead took her to Vrindavan, saying that his nephew would meet them there. When he didn't turn up, the girl realised she had

been cheated and threatened to report Santosh to the police if he didn't take her to her bovfriend immediately, cops said.Santosh then took her to Bandhwari, claiming his nephew was at a farmhouse there, and allegedly killed her in the nearby forest area by hitting her head with a brick and strangling her with her scarf."The accused was produced before a court on Saturday and taken into police remand for further interrogation," a senior police officer said.

# 5 bodies found from wreckage of superyacht carrying British tycoon Mike Lynch

of a superyacht that sank off Sicily found the bodies of five passengers Wednesday, leaving one still missing as questions intensified about why the vessel sank so quickly when a nearby sailboat remained largely unscathed.

Rescue crews brought four body bags ashore at Porticello. Salvatore Cocina, head of the Sicily civil protection agency, said a fifth body had been located. Divers on-scene said they would try to recover it on Thursday while continuing the search for the sixth.

The discovery made clear the operation to search the hull on the seabed 50 meters (164 feet) underwater had quickly turned into a recovery one, not a rescue, given the amount of time that had passed and with no signs of life over three days of searching. The Bayesian, a 56-metre (184-foot) Britishflagged yacht, went down in a storm early Monday as it was moored about a kilometre offshore. Civil protection officials said they believed the ship was struck by a tornado over the water, known as a waterspout.

rescued by a nearby sailboat. The body of the ship's chef, Recaldo Thomas of Antigua, was recovered on Monday. Thomas was born in Canada, according to his cousin David Isaac, but visited his parents' homeland of Antigua as a child, and moved permanently to the tiny eastern Caribbean island in his early 20s. Italian officials previously listed Antigua and Canada as the nationality of people on board. The fate of six missing passengers had driven the search effort, including British tech magnate Mike Lynch, his 18-year-old daughter and associates who had successfully defended him in a recent US federal fraud trial.Lynch's spokesperson did not respond to a request for comment Wednesday.Meanwhile, Termini Imerese Public Prosecutor's Office investigators were acquiring evidence for their criminal investigation, which they opened immediately after the tragedy despite no formal suspects having been publicly identified. Questions have abounded about what caused the superyacht, built in 2008 by Italian shipyard Perini Navi, to rapidly sink,



when the nearby Sir Robert Baden Powell sailboat was largely spared and managed to rescue the survivors. Giovanni Costantino, head of The Italian Sea Group, which owns the ship maker, blamed human error for the disaster, which he said took 16 minutes."The ship sank because it took on water. From where, the investigators will say," he told RAI state television after he met with prosecutors. Costantino cited AIS ship tracking data which he said showed the Bayesian had taken on water for four minutes when a sudden gust of wind flipped

The ship straightened up slightly and then went down, he said. But was it merely the case of a freak waterspout that knocked the ship to its side and allowed water to pour in through open hatches? What was the position of the keel, which on a large sailboat like the Bayesian might have been retractable to allow it to enter shallower ports?"There's a lot of uncertainty whether it had a lifting keel and whether it might have been up," said Jean-Baptiste Souppez, a fellow of the

Royal Institute of Naval Architects and the editor of the Journal of Sailing Technology. "But if it had, then that would reduce the amount of stability that the vessel had, and therefore made it easier for it to roll over on its side," he said in an interview. The capain of the sailboat that rescued survivors said his craft sustained minimal damage -- the frame of a sun awning broke -- even with winds that he estimated reached 12 on the Beaufort wind scale, which is the highest hurricanestrength force on the scale.

The White House was to provide further details of the call later in the day.Biden had been expected to press Netanyahu to soften a new Israeli demand that it be allowed to keep forces along a land corridor between Egypt and Gaza, a US official said before the call.

Biden is on a family vacation in the Santa Ynez Valley of California, staying on an 8,000-acre ranch.Getting a Gaza ceasefire deal is a major priority for Biden. A senior US official on Friday described the talks as close to a deal but a final agreement has been agonizingly elusive.In talks to halt fighting in the 10-month-old war.

Hamas is seeking a complete Israeli withdrawal from Gaza, including the so-called Philadelphi Corridor, a narrow 14.5-km-long (nine-mile-long) stretch of land along the coastal enclave's southern border with Egypt.Israel wants to retain control of the corridor, which it captured in late May, after destroying dozens of tunnels beneath it that it says had served to smuggle in weapons to Gaza's militant groups.

### Hezbollah fires more than 50 rockets, hitting Israeli-annexed **Golan Heights**

World. Lebanon's Hezbollah on Wednesday launched more than 50 rockets, hitting a number of private homes in the Israeli-annexed Golan Heights.

The attack came a day after U.S. Secretary of State Antony Blinken met with fellow mediators Egypt and Qatar as he pressed ahead with the latest diplomatic mission to secure a cease-fire in the war in Gaza, even as Hamas and Israel signaled that challenges remain. Diplomatic efforts had redoubled as fears grow of a wider regional war after the recent targeted killings of Hamas and Hezbollah leaders, both blamed on Israel, and threats of retaliation.Hezbollah said Wednesday's attack was in response to an Israeli strike deep into Lebanon on Tuesday night.Meanwhile, key mediator Egypt expressed skepticism Wednesday as more details emerged of the proposal meant to bridge gaps between Israel and Hamas.

Officials in Egypt, in its unique role as both a mediator and affected party since it borders Gaza, told The Associated Press that the Hamas militant group will not agree to the bridging proposal for a number of reasons — ones in addition to the long-held wariness over whether a deal would truly remove Israel forces from Gaza and end the war. Hamas is believed to still be holding around 110 hostages captured during the Oct. 7 attacks that started the war. Israeli authorities estimate around a third are dead. During the Oct. 7 attack, militants killed some 1,200 people, mostly civilians. Israel's retaliatory offensive has killed over 40,000 Palestinians, according to Gaza's Health Ministry, which does not distinguish between civilians and combatants in its count. The war has caused widespread destruction and forced the vast majority of Gaza's 2.3 million residents to flee their homes, often multiple times.

### Million miles an hour': Astronomy student discovers mysterious high-speed object racing through space

World. In Southampton, England, an astronomy student named Tom Bickle made a remarkable discovery while pursuing his passion for stargazing. In his spare time, Bickle enjoys blasting heavy metal music while meticulously analyzing time-lapses of the night sky, searching for elusive objects at the edge of our solar system. During one of these sessions, Bickle noticed something extraordinary: a faint moving blob on his computer screen."I knew immediately that it was unusual," Bickle told the New York Times. The discovery, which initially puzzled Bickle, quickly caught the attention of professional astronomers.

Further investigation revealed that the object is either a low-mass star or a brown dwarf, and it's hurtling through space at a staggering speed of one million miles per hour. At such a velocity, it could potentially escape the gravitational pull of the Milky Way, the NYT report said.

'It was right when that number came out that we realized we had something spectacular," said Adam Burgasser, a San Diego, who led the study on this observation. The findings were published this month in The Astrophysical Journal Letters.The so-called "hypervelocity object" was spotted by astronomers using

the Dark Energy Spectroscopic Instrument (DESI) Legacy Imaging Surveys. "It's a speedy little star," said Kareem El-Badry, a Nasa Hubble Fellow. If the object maintains its current trajectory, it could eventually break free of the Milky Way's gravitational pull and escape into intergalactic space. "It's on an unbound orbit, so in a few million years it will just leave our galaxy entirely and keep going," El-Badry explained. This discovery holds the potential to shed light on some of the oldest and fastest stars in our galaxy, known as halo stars. According to Dr Burgasser, these stars move in peculiar orbits.

# Bill Clinton, Kamala Harris's running mate to address Democratic Convention

Former US President Bill Clinton, **Democratic vice** presidential nominee Tim Walz and independent candidate in US polls, Robert F Kennedy, are among the speakers that will address on the third day of the **Democratic National** Convention.

Washington Democratic vice presidential nominee Tim Walz prepared for a high-profile speech at his party's convention on Wednesday, while independent candidate Robert F Kennedy appeared to be weighing an endorsement of Republican Donald Trump. Walz, the running mate of presidential nominee Kamala Harris, has energised Democrats eager to defeat the former president in the November 5 election. The Minnesota governor, 60, will talk about growing up on a farm in Nebraska, his family, and freedoms that Democrats say are under attack from Trump, who is making his third major-party run for the White House.Meanwhile, ABC News reported that Kennedy plans to abandon his bid and declare support for Trump, a development that could help the Republican pick up votes in an election that opinion polls show is likely to be close. Kennedy's campaign did not immediately

respond to a request for comment. Walz has brought a folksy charm to the campaign trail, describing himself and Harris as "joyful warriors" focused on a brighter future and accusing Republicans of stoking fear and division.He will take the stage at the Democratic National Convention in Chicago after former President

Bill Clinton, Transportation Secretary Pete Buttigieg and former House of Representatives Speaker Nancy Pelosi, who was instrumental in persuading President Joe Biden to drop his struggling reelection bid a month ago. Opinion polls showed Biden trailing Trump before he ceded the party's top spot to Harris; polls now show her besting her Republican rival in several of the states that will decide the November 5 presidential election. At the convention on Tuesday, Walz and Harris got an endorsement from



his wife Michelle Obama.

I love this guy," Obama said of Walz. "You can tell those flannel shirts he wears don't come from some consultant - they come from his closet, and they've been through some stuff."Walz's rapid rise to national fame has drawn scrutiny. Republicans say he was too slow to confront rioters after George Floyd, a Black man, was killed by a white police officer in Minneapolis in 2020, though Trump praised the governor's response at the time.

### Three caught with 4,000 old mobile phones in Telangana

HYDERABAD: Be cautious when selling your old mobile phone to unknown individuals, as it could be used for cybercrime. When the police track the identity of the device, there is a chance that the seller of the phone might also be seen as a suspect in these crimes, the Telangana police said on Wednesday. The Telangana Cyber Security Bureau identified that in the past month, three men-Mohammad Shamim (30), Abdul Salam (28), and Mohammad Iftikhar (32)- had purchased as many as 4,000 old mobile phones in Ramagundam and neighbouring districts at low rate with an intention to allegedly use the phones for committing cybercrime.Based on a tip-off, the police apprehended the accused who were in possession of three gunny bags with nearly 4,000 old phones. When inquired, the accused reportedly revealed that they intended to transport the phones to Bihar where their associate would allegedly make some repairs and change software and other components of the phones and then sell it to cyber fraudsters operating from Jamtara, Deoghar and other areas in Jharkhand."These cyber fraudsters use the repaired phones to carry out scams," said Telangana Cyber Security Bureau Director Shikha Goel on Wednesday. The fourth accused, who allegedly sells the phones to cyber fraudsters is identified as Akthar Ali. He is currently absconding. Further investigation is on.

Various suggestions including the setting up of a three-way roundabout, diverting traffic instead of allowing direct crossing at intersections, and the removal of a culvert, among others, are being considered," Tripunithura Joint RTO Abdul Rahman said. With regard to Petta junction, the department is exploring the possibility of a three-way roundabout. We'll request the Kochi traffic police to conduct a vehicle count at the junction during peak hours," the official said. With increased peak-hour traffic, the threat of accidents too looms large. ### Hyderabad: Flipkart recruiter loses Rs 24.1 lakh in cyberfraud

HYDERABAD: In a chilling cybercrime case in Rachakonda, a Flipkart HR recruiter fell victim to a complex scam and lost Rs 24.1 lakh.On June 1, Rushi, a 28-year-old Flipkart HR recruiter from Malkajgiri-Medchal District, joined a Telegram group called Carwale, which directed him to a website offering a scheme called 'Carwale Car Quest Investment'. With a promise of 30% commission and the return of investment funds after completing a series of tasks, the victim was



initially swayed by screenshots of alleged profits posted by other group members. He got convinced and invested a significant amount to perform the required tasks. Rushi was assured by one Prashanth that he could withdraw funds once all tasks were completed. But on attempting to withdraw money, he learnt his account was on hold. He was informed that additional fees for taxes and auditing were required to release the funds. Even after paying these extra fees, he was unable to access his money. Realising he had been duped, he reported the fraud to the Rachakonda Cybercrime police, seeking legal action against the scammers.

# Is M-pox the next big pandemic?

KOCHI: M-pox or monkeypox is a viral illness caused by orthopoxvirus. It's a zoonotic illness first identified in Central and West Africa around 1970. The virus How does M-pox spread? among monkeys while scientists were researching some other virus. The smallpox vaccine provided protection for monkeypox. Since the smallpox

vaccine was withdrawn after the eradication of the disease in the 1980s, there was an increase in the cases reported for M-pox in the areas where it was endemic. There have been reported cases over a period of time that were associated with travel to endemic areas.

Outbreak of M-pox This virus came into the limelight once again in

2022 as there were

new cases reported in the areas that were non-endemic and were not associated with travel-related spread. The first case in India was diagnosed in July 2022, in a 35-year-old male patient and after that, there were approximately 27 cases which were reported.Recently, WHO declared an Mpox outbreak in August 2024, as more than 100 confirmed cases were identified in four neighbouring countries of the Democratic Republic of Congo -

coming in direct contact with the infective skin lesions and fomite. This happens when a human comes in contact with an infected animal in the form of



secretions and animal bites. It has also been noted that occasionally an infected individual can spread infection four days prior to the symptom onset. The disease can spread to other individuals through the secretion of the fluid that comes out of skin lesions and pustules of the affected person's skin. Contaminated surfaces act as one of the prominent modes of transmission. Intimate contact can also lead to the spread of this virus.

Burundi, Kenya, Rwanda, and Uganda. Symptoms of M-pox

vary in severity. The incubation period of this virus varies from five-13 days but can be as long as three weeks. The most common site is the genital region, implicating the spread through intimate contact. There can be rashes ranging from small red raised lesions to large

scabbed necrotic areas. The other systems that can be seen involved in these certain cases, include the central nervous system, eyes, etc.

Treatment and prevention M-pox can be diagnosed by detecting the DNA of the virus. Antivirals are available with limited data on utilities like Tecovirimat and Cidofovir. Availability of tecovirimat may be an issue. The person with the disease needs to be in

isolation to prevent further spread. Vaccines (MVA and ACAM2000) are also available for this disease. WHO has requested for emergency listing of these vaccinations to accelerate their availability. The complete strategy for managing the disease has been delineated and thus managing the disease is possible if it is diagnosed on time. However, a high index of suspicion is required for proper treatment and prevention of spread.

### Realism, strategic interests should dictate India-China ties

A realistic assessment of the current state of India-China relations is necessary amid the apparent orchestrated pleas urging India to ease travel and import restrictions on Chinese personnel and goods. Since its military adventure in Ladakh in April 2020, Beijing has consistently sought normalisation of relations, especially economic, setting aside the situation on the border. Over the past couple of months, various business sectors, reinforced by arguments advanced by some economists and media reports, have echoed China's demands.

There is a negligible prospect of an improvement in India-China relations in the near future. The absence of communication for over four years at the highest level and China's recent protest against economic assistance to projects in Arunachal Pradesh and other border regions -- on the specious pretext that they are disputed -- are brazen examples. On the contrary, they point to China expanding the areas of pressure on India.

The bilateral relationship has been subjected to considerable strain ever since Beijing decided that it will attempt to forcibly take the territories it claims and compel India to acquiesce to China being the leading power in the region. China has simultaneously redoubled efforts to establish dominance over Asia. These developments have coincided with the view in the Chinese Communist Party (CCP) leadership that India has drawn uncomfortably close to the US. Additionally, Beijing sees India as adopting a tougher, unyielding stance, which includes building defences along the border as well as initiating steps to close off the burgeoning Indian market to China. Beijing views these as unwelcome steps, but considers that India does not yet pose a serious challenge.

The situation on the border has also not changed; 60,000-70,000 troops remain deployed on the front lines. The Chinese have built additional accommodation to billet reinforcements and new advanced weaponry and military units continue to be inducted. Border defence infrastructure is being built at a frenetic pace with plans to build 35 military or dual-use airports and major arterial railways and roads along the border in Tibet. Chinese President Xi Jinping's attitude towards India, signalled on the opening day of the 20th Party Congress in October 2022, with the screening of a video of the fateful Galwan clash of June 2020, has not altered.

In a cosmetic attempt to show that China wants to improve ties but it's India that is playing spoilsport, Beijing claimed that it had sent Ambassador Xu Feihong, who arrived in India almost 20 months after his predecessor Sun Weidong departed, to enhance communication and improve bilateral ties. This has been echoed by many Indian journalists, academics and others. Since his arrival, Xu Feihong has virtually been holding court, meeting Indian politicians, former diplomats, businessmen and others. China is keen on maintaining commercial and economic access to India's market but has no intention of taking substantive steps to ease tensions on the border. At the same time, it is determined to keep India under protracted and sustained pressure.

There are other signs of China's attitude and intentions. Xi has not initiated direct contact or meeting with Prime Minister Modi since April 2020, or even observed basic diplomatic niceties and congratulated him on his re-election. Chinese Premier Li Qiang did send a routine message of congratulations, but only after Modi's swearingin. China's Ministry of Foreign Affairs explained that it would have been 'premature' to convey greetings prior to the swearing-in. There was, however, no such hesitation in inviting Indonesia's President-elect on an official visit prior to his swearing-in! Whether this presages an to restrict China-India interaction at the level of the Chinese Premier is to be seen.

Xi also skipped the G-20 Summit and Shanghai Cooperation Organisation (SCO) meetings. A senior CCP cadre had divulged a couple of months prior to the G20 Summit that Xi would not attend the event and it would, therefore, be a failure. However, Xi's absence ensured there would be no distractions, the G20 communique was unanimously approved, and, importantly, India brought the Global South within the G20

### Women's safety at workplace ignored for too long

We need to broaden our vision and take the debate on education beyond what is deleted from or added to NCERT textbooks.

INDIA reports 86 cases of sexual assault on women every day, according to government data. The actual figure could be much higher. And no one would dispute that sexual assault is an everyday occurrence in the country. The Kolkata rape-murder has triggered nationwide protests. PM Narendra Modi has appealed to the head of Bangladesh's interim government to ensure the safety of minorities there, but he is yet to make a direct comment on the Kolkata horror, despite doctors staying away from work and threatening to suspend emergency services and 71 Padma awardee doctors writing to him to seek his intervention. In his Independence Day speech, he had stressed the need to end atrocities against women in general.Women make up around 30 per cent of the doctors and 80 per cent of the nursing staff in India. Though the Indian Medical Association has called for

hospitals to be declared safe zones with security measures akin to those at airports and courts, such steps may not be enough. After all, women are abused everywhere, from sports coaching centres to public transport and even in their own homes and at police stations.'Reclaim the Night' had a spontaneous and emotive appeal. Kolkata had not experienced a telling moment like this in a long time. But going by the NCRB data, 85 other cases may have happened that day, August 9. The last few days alone have witnessed a series of crimes against women across the country. A nurse was allegedly raped and killed while returning home from work in Uttarakhand; her body was recovered last week. A teenage girl was allegedly gangraped and murdered in Bihar. Her mutilated body was found near a pond at a village in Muzaffarpur district. A 16-year-old girl was reportedly gangraped inside a bus in Dehradun. And a female doctor was assaulted at Mumbai's Sion Hospital by an inebriated patient and his relatives.

We as a nation express selective rage and then quickly move on. We light candles on certain anniversaries and forget the rest. It is true that we cannot rise in protest 86 times a day. But certain tragic incidents become the tipping point. And the people in power, who are undeniably responsible for such crimes, have perfected Safety at the workplace or a public place is not something the art of deflection. Ironically, West Bengal CM Mamata



Baneriee, who holds the Home and Health portfolios, has called for swift justice in the Kolkata case.

West Bengal has long perpetuated a culture of political mafia to terrorise the public. On the night of August 14, a mob stormed the hospital in Kolkata where the murder was committed, vandalising property and assaulting doctors and staff members. Many of the vandals arrested are said to be members and volunteers of the ruling party in the state. Besides, we have seen men convicted of gangraping a pregnant woman, Bilkis Bano, and murdering her family members during the 2002 Gujarat riots walk out of jail on remission granted by the Gujarat Government and be greeted with garlands. The Supreme Court had to step in and restore the life sentences for

Wrestler Vinesh Phogat recently received a rousing welcome upon her return from Paris not only because of her performance on the mat (though she could not secure an Olympic medal) but also because of the larger battle waged by her and other ace wrestlers against sexual harassment by former Wrestling Federation of India (WFI) chief and six-time BJP MP Brij Bhushan Sharan Singh. 
are usually indifferent to the livin conditions of employees. And there are no policies in government or corporate sectors that measure employee satisfaction on their work and living conditions.

Rape has been an established weapon of patriarchal state violence in conflict zones in India and other countries. It has been 20 years since the gangrape and murder of Thangjam Manorama in Manipur by soldiers of the Assam Rifles. The incident had triggered mass protests. Twelve women had disrobed in front of the Assam Rifles headquarters in Imphal, forcing then PM Manmohan Singh to rush to the state and call for humane laws to replace the draconian Armed Forces Special Powers Act (AFSPA), which grants sweeping immunity to security forces. But not one person has been convicted so far. And the AFSPA remains in force. Three Kuki women were allegedly paraded naked and sexually assaulted by a Meitei mob last year. The matter is still being investigated. The survivors had sought police help, but they were left to face the mob.

In Mahasweta Devi's Draupadi, the protagonist refuses to put on her clothes after she is taken into custody and then raped by soldiers. "What's the use of clothes? # The budget & jobs: Prescriptions without diagnosis



The Union budget for 2024-25 has a grand target to provide employment to 4.1 crore young people in 5 years, which works out to 8.2 million a year. It is undoubtedly a major move for a country whose working group of those aged 20-59 will reach its peak in 2041. But the budget's employment prescriptions lack a clear diagnostic basis.

The Economic Survey 2024 does not reflect the nature and magnitude of the problem of unemployment (Chapter 8). For example, it speaks of an "improved" situation "with the unemployment declining to 3.2 percent in 2022-23", "rising youth and female participation in the workforce", and a "bounce-back of the organised manufacturing sector".

On the other hand, the Centre for Monitoring Indian Economy reports an unemployment rate of 8 percent in 2023-24 for those aged above 15, up from 7.5-7.7 percent in the preceding two years. Not only that, the employment rate-proportion of those employed in the working-age population-edged down from 38 percent in May 2024 to 37.6 percent in June 2024. ILO's Employment Report 2024 also corroborates the poor employment conditions. The Survey's optimism seems misplaced, especially given the emerging reality.India's unemployment situation is more structural than seasonal and short-term. Nearly 90 percent of the workforce is informally employed, mostly self-employed, casual labour or gig workers. That most of them live on subsistence earnings cannot be ignored without considering minimum wage legislation, social security issues and other livelihood questions. The ILO report points out that the slow transition to non-farm employment has been reversed after the pandemic. It is difficult for an economy where manufacturing employment has been stagnant around 12-14 percent to absorb surplus labour from the agricultural sector. China, which shared almost the

same economic and demographic conditions before the 1950s, achieved a significant structural transformation through manufacturing.

Let's look at women's employment and empowerment because the two are separately addressed in the budget-allocating Rs 3 trillion, but without a clear strategy. Although 'women's participation' appears in the budget speech immediately after the paras announcing three schemes of the prime minister, it is not part of it. The budget forgets that the number of women not in employment, education or training is five times larger than their male counterparts, and in 2022 constituted around 95 percent of the total youth population in this category.

Not only that, the latest Periodic Labour Force Survey's estimate of workforce participation for men and women shows a glaring difference-68.4 percent for men as against 16 percent for women in 2017-18, but 71.5 percent for men and 24 percent for women in 2022-23, as K P Kannan showed in a 2024 paper. There is not much to report. Again, according to the National Family Health Survey 2005-06, married women employed in the previous 12 months was 42.8 percent against 98.8 percent for men, but in NFHS 2019-21, it fell to 31.9 percent for women and 97.5 percent for men

Instructively, based on the World Bank Enterprise Surveys 2014 and 2022, Rozi Kumari and Rupayan Pal concluded in a 2024 paper that women's ownership and participation in the top management of registered private firms drastically decreased from "a low to a meagre level" despite high economic growth and the launch of several programmes to promote women's entrepreneurship. The budget is not sensitive to these issues. Another critical area is educated unemployment. The AISHE portal shows



the number of graduates and certificate holders in 2021-22 as 10.27 million (51.24 percent females), of whom around 8.5 million are under-graduates and post-graduates. Are they an employable resource?

So, this budget has no employment policy that squarely addresses the gender issue, educational policy and a long-term strategy for structural transformation.

Turning to the prescriptions, the budget offers five schemes to expand employment and skilling. It is by requiring the employer to register with the Employees' Provident Fund Organisation that employees are drawn into the formal sector. The schemes seek to incentivise the private sector by reducing the labour cost through wage subsidies.

The first three schemes are employment-linked incentives. Briefly, Scheme A is a direct wage subsidy of Rs 15,000 per month to cover 2.1 crore first-time employees; B, a wage subsidy to both the employer and employee to benefit first-time employees broadly to promote manufacturing; and C, support to employers with EPFO contribution for 2 years up to Rs 3,000 a month. The other two initiatives are for youth skill development, one to upgrade 1,000 Industrial

Training Institutes with the support of industry and states, and the other a grand internship project for youth in 500 top companies at an average of 4,000 interns per company per year, to be paid a monthly allowance of Rs 5,000 for 12 months. The companies have to bear a part of the training cost and monthly allowances from their CSR funds. The remedies are more easily announced than implemented. The private sector is the key driving force for employment in India. It can be stimulated only through aggregate demand via consumption, investment and exports. In a growing unequal economy-the nine-point priorities of the budget ignore it-the disposable income of the poor, whose marginal propensity to consume is high, can be increased only through employment or other

exchange entitlements. What is the budget's response? The reduction in MGNREA allocation benefitting the poor from Rs 90,806 crore in 2022-23 to Rs 86,000 crore in 2024-25

is untenable. Not much consumer demand can be promoted by increasing the income of the middle class by Rs 17,500 through changes in tax slabs, or Rs 10,000 by raising the standard deduction.

It is difficult to envisage that the entrepreneurial ecosystem would be improved by abolishing the 'angel tax' along with the Black Money Abolition Act 2015, giving immunity from benami transactions by abolishing the Benami Transactions Act, 1988 and the likes. So whom does the budget help? Annexure 7 shows a total foregone revenue of Rs 1.09 trillion. It is now well documented that tax cuts cannot promote growth and employment as Thomas Piketty in 2020, and Abhijit Banerjee and Esther Duflo showed in 2019. So it's well worth arguing that the budget prescriptions need a radical relook to serve the Indian economy in a useful way.



# Irresponsible, careless kids at obesity risk

A study has found that children showing low conscientiousness (e.g., irresponsible, careless, not persevering) could later in their life be battling obesity.

The Oregon Research Institute (ORI) study examines the relationship between childhood personality and adult health and shows a strong association between childhood conscientiousness (organized, dependable, self-disciplined) and health status in adulthood.

ORI scientist Sarah Hampson, Ph.D., and colleagues at the Kaiser Permanente Center for Health, Hawaii helped complete the study.

Hampson said that these results are significant and unique as they show the far-reaching effects of childhood conscientiousness on adult health. She said that others have shown that more conscientious children live longer but now they



have shown that these conscientious children are also healthier at midlife. This is the first study in which all the Big Five personality traits (extraversion, agreeableness, conscientiousness, emotional stability, and intellect/imagination) assessed in childhood have been used to predict objective health status assessed by multiple biomarkers over 40 years later in older adulthood.

In the 1960's, over 2,000 children from entire classrooms in elementary schools on two Hawaiian Islands were comprehensively assessed on their personality characteristics. ORI researchers were funded in 1998 by the National Institute of Mental Health to locate

and examine the health-related behaviors and

mental and physical health status of these individuals. Almost 75 per cent of those in the original

group who could be located (mean age 51 years) have agreed to participate, and over 800 individuals completed a medical and psychological examination supported by subsequent grants from the National Institute on Aging.

Hampson said that these findings suggest avenues for further research that may lead to

She asserted that people who are more conscientious tend to have better health habits and less stress, which protects them from

Hampson added that self -control is a key part of being conscientious, so our findings confirm the importance of teaching children self-control to enable then to grow up to be healthy adults.

### Chief Justice Gets - And Gives -Pronunciation Lesson In Kolkata Case

New Delhi: Chief Justice of India DY Chandrachud todav corrected himself on the pronunciation of RG Kar Medical College and Hospital and said he had been pronouncing "Kar" as "Kaar" and Supreme Court judge, Justice Hrishikesh Roy, had pointed out the error to him.he Supreme Court was hearing petitions related to the horrifying rape and murder of a 31-year-old doctor at the Kolkata hospital. When an advocate mentioned that she was representing junior doctors working at the state-run hospital, the Chief Justice replied, "By the way, Justice Hrishikesh Roy pointed out to me that you kept on saying 'Kaar', 'Kaar', it's 'Kar'. I apologise."The RG Kar Medical College was established in 1886 as the Calcutta School of Medicine by Indian physician Radha Gobinda Kar. At that point, it did not have an associated hospital or a campus of its own. In 1902, the college got a building of its own. It was renamed Belgachia Medical College in 1916. Two years later, it was renamed Carmichael Medical College in the honour of Bengal's



Governor Thomas Gibson-Carmichael. After Independence, the college was named after its founder Dr Radha Gobinda Kar. Subsequently, the West Bengal government took over the management of the hospital.

The state-run hospital in North Kolkata has made headlines after a 31-year-old postgraduate trainee doctor on duty was found dead in the hospital's seminar hall on the morning of August 9. Medical examination confirmed sexual assault. The chilling incident has sparked nationwide protests calling for swift justice. Doctors across the country have taken to the streets, demanding safe working conditions. The doctors' protest has paralysed healthcare services across the country.

The Supreme Court has set up a National Task Force to recommend steps to improve the working conditions for healthcare professionals. During the hearing today, an advocate representing a group of doctors said the medicos sometimes have to work for as much as 36 hours. To this, the Chief Justice replied, "Please assure the doctors that we know they are working for 36 hours. I have personally slept on the floor of a public hospital when one my family member was not well."

# "Not Correct...": Government On Reports India Dam Caused Bangladesh Floods

New Delhi: Flooding in the eastern districts of Bangladesh - which is facing political turmoil after violent protests forced Sheikh Hasina to resign as Prime Minister and flee to India - were not caused by the opening of a dam on the Gumti River in Tripura, the government clarified Thursday.

The External Affairs Ministry acknowledged "the catchment areas of Gumti River that flows through India and Bangladesh witnessed heaviest rains of this year over the last few days", but said the floods in Bangladesh were mainly due to waters from downstream catchments areas."The Dumbur dam is located quite far from the border -

over 120 km upstream of Bangladesh. It is a low height (about 30m) dam that generates power that feeds into a grid and from which Bangladesh also draws 40MW power from Tripura," the ministry said.

"Heavy rainfall has been continuing

since August 21 in the whole of Tripura and adjoining districts of Bangladesh. Data showing rising Officials said on Wednesday that at least trend has been supplied to Bangladesh till 1500 on August 21. At 1800, due to



flooding, there was power outage communication... we tried to maintain communication through other means..."Heavy rains in the region have also led to floods on the Indian side of the border - in Tripura.More than 34,000 people have been displaced so far due to the floods in the northeastern state.

# Plans On To Tackle "Dangerous" Glacial Lakes In Himalayas

NDTV has learnt that of the nearly 7,500 glacial lakes in the **Indian part of** Himalayas, NDMA has finalised a list of 189 lakes where the risk factor needs to be lowered.

New Delhi: The expanding glacial lakes in the Himalayas are a matter of serious concern and the National Disaster Management Authority or NDMA has finalised a list of 189 "potentially dangerous" lakes.NDTV has learnt that of the nearly 7,500 glacial lakes in the Indian

part of Himalayas, NDMA has finalised a list of 189 lakes where the risk factor needs to be lowered.Rising global temperatures lead to faster melting of ice in these lakes and pose a risk of flooding a situation known as Glacial Lake Outburst Flood or GLOF. This is the kind of flood that had devastated the Kedarnath valley in 2013 and parts of Chamoli in 2021, sources said. In October last year, the South Lhonak Lake in North Sikkim breached, causing a Glacial Lake Outburst Flood.The Teesta III dam, the biggest hydropower project in Sikkim was decimated by a GLOF, which also unleashed devastation on downstream areas and communities. Now, "all central and state agencies are working closely and have already completed expeditions to 15 of these high-risk lakes -- six in Sikkim, six in Ladakh, one in Himachal Pradesh and two in Jammu and Kashmir," a senior official told NDTV. Another seven expeditions are underway, he said."Given

the inhospitable terrain and weather conditions at heights of 4,500 m and above, there is only a June to September window to approach these formidable lakes. Several visits will be needed to



implement lake-lowering measures, some of which could require civil engineering," he said. One such expedition is going on in Arunachal Pradesh, where teams are assessing threats from six high-risk glacial lakes. Considering the risk of these glacial lakes, the NDMA has suggested that there is an immediate need to take up measures to mitigate the effects of Glacial Lake Outburst Flood.

The measures being considered include early warning systems, automatic weather stations, and others, the sources

said."These composite expeditions are assessing structural stability and potential breach points of glacial lakes, gathering relevant hydrological and geological samples and data, measuring water quality and flow rates, identifying risk zones and making downstream communities aware," said another official, explaining the work being done by NDMA. The National Glacial Outbhrst Flood Risk Mitigation Programme (NGRMP) was approved by the government on July 25.The

Home ministry has allocated Rs150 crore to support the efforts of state governments of Himachal Pradesh, Uttarakhand, Sikkim and Arunachal Pradesh in this matter. There is a separate programme envisaged on the same lines for Jammu and Kashmir and Ladakh.

Spot reduction exercises: An ineffective method of 'burning fat' followed by many people is spot reduction. The popularity of this belief can be largely attributed to the many exercise gimmicks that we often see in infomercials regarding localized weight reduction. But always keep in mind that weight loss can never be isolated to a particular area. Localized strengthening and toning exercises will only help to firm muscles but will have no effect on the fat content of the target area. A better alternative is to adopt a well-rounded fullbody weight reduction program.

Leg extensions (Seated): A very popular exercise for working the anterior thigh muscles, seated leg extensions are actually one of the most dangerous exercises in the gym. This is because the exercise places an unhealthy amount of stress on the knee joint. According to a research published in the "Journal of Orthopaedic and Sports Physical Therapy", individuals who worked on the leg extension machines found no benefit during functional tests. This can be particularly dangerous for those who have any kind of knee problems. Safer alternatives are simple lunges and squats without any added weights.

Leg press: Another form of exercise that should be avoided is the leg press as this can place undue amount of stress on the lower back. This can thus predispose a person to low back injuries. # Feeling blue? You have impaired your ability to identify colours

Taking the association between our mood and colours beyond a mere metaphor, new research has found that feeling sad can impair our ability to accurately identify colours on the blue-vellow axis.



"Our results show that mood and emotion can affect how we see the world around us," said study first author Christopher Thorstenson from University of Rochester in New York,

"Our work advances the study of perception by showing that sadness specifically impairs basic visual processes that are involved in perceiving colour," Thorstenson

In the study, the researchers had 127 undergraduate participants watch an emotional film clip and then complete a visual judgment task.


The participants were randomly assigned to watch an animated film clip intended to induce sadness or a standup comedy clip intended to induce amusement.

After watching the video clip, the participants were then shown 48 consecutive, desaturated colour patches and were asked to indicate whether each patch was red, yellow,

green, or blue. The results showed that participants

who watched the sadness video clip were less accurate in identifying colours than participants who watched the amusing clip, but only

previous work has specifically linked colour perception on the blue-yellow axis with the neurotransmitter dopamine. The new research was published in the journal Psychological Science.



### Here's how you should make turmeric

Much has been said about the benefits of drinking turmeric milk - or 'Golden Milk' as it is fondly called by the Orientals.

It has been advocated by several schools of native medicine, including Ayurveda. A simple Web search on 'turmeric milk' will tell you about benefits ranging from decongestion to weight loss, so I am not going to delve into that much in this post.

Instead, I want to share with you an authentic method of preparing it, which I zeroed in on after trying several recipes advised by Ayurvedic doctors, and found in many books.

1. Take an inch-long stick of turmeric. Remember that turmeric powder is never as effective as crushed turmeric sticks, because the chances of contamination in the powder are high, plus its



efficacy is also bound to reduce during the heatgenerating grinding process. So, take a stick of turmeric (the variety used in cooking; varali manjal in Thamizh) and crush it coarsely using a mortar and pestle. 2. Crush a few peppercorns too. The white variety is

better.

3. Mix a cup of water with a cup of milk, add the crushed turmeric and pepper and bring to a boil.

4. Simmer for 20 minutes. By this time, the milk will reduce to a cup. This is the reason why I suggest you begin with a mixture of milk and water; else you will end up with a very thick, kheer-like drink that won't be as soothing.

5. Remove from the stove, filter, add a spoonful of honey or palm sugar, and enjoy the drink warm.

6. If you are taking this to relieve a sore throat, add 1/2 teaspoon of ghee to the hot turmeric milk before drinking it. The ghee will melt and coat your throat, relieving you of cough as well.

Note: The most important part is to sit and relax with this cuppa for a few minutes, relishing its soothing flavour and rustic aroma! This will enhance the feel-good factor.

# Sebi Slaps Rs 11 Lakh Fine On IIFL Securities For Flouting Stock Brokers Rules

Sebi slapped a fine of Rs 11 lakh on brokerage firm IIFL Securities for flouting stock broker rules and other regulatory norms.

New Delhi. Capital market regulator Sebi on Wednesday slapped a fine of Rs 11 lakh on brokerage firm IIFL Securities for flouting stock broker rules and other regulatory norms. The Securities and Exchange Board of India (Sebi) inspected IIFL Securities Ltd (IIFL) to look into various compliance requirements adhered by the brokerage firm. The inspection was conducted for the period beginning April to July 2022.

Thereafter, a show cause notice (SCN) was issued to IIFL Securities on April 15, 2024 by the regulator. In its 35-page order,

Securities) has admitted to the allegations stated in the SCN in respect of the monthly/ quarterly settlement of client funds and securities stating that there was some technical error."I find that the circulars specifically mandate brokers to settle accounts and issue retention statements on a timely basis. However, the noticee failed to do so," Sebi's Adjudicating Officer Barnali Mukherjee said in the order. While the noticee has now taken corrective action, it noted that it failed to settle the funds and securities on a monthly/ quarterly basis.

The regulator also alleged that the noticee did not do periodic reconciliation of client securities lying in DP accounts, with back office holding and also reported incorrect quantity in weekly holding statement in one instance for 1,835 shares valued at Rs 11.69 lakh.

As per Sebi norms, stock reconciliation is a



critical process for all brokers to ensure that their physical inventory count matches the recorded data in their systems to make correct reporting to the exchange.IIFL Securities admitted that it was a one-off case and a very small portion of the entire holding of shares valued at Rs 120.73 crore. Therefore, the noticee failed to reconcile 1,835 shares, and hence the allegation of violation of norms by the noticee stands established, the order said."I find that the noticee has given an ambiguous reply and not addressed the issue raised in the SCN regarding the passing of penalty on short reporting of upfront margin.

The noticee has not given any reason why it had passed on a penalty to clients on account of short reporting of upfront margins amounting to Rs 24.22 lakh in the CM segment for 26 clients, Rs 56 lakh in Futures & Options segment for 13 clients and Rs 5.19 lakh in CD segment for 15

clients," Mukherjee said.Accordingly, IIFL Securities contravened the provisions of brokers'

# Zomato to buy Paytm's entertainment ticketing business for Rs 2,048 crore

The acquisition of Paytm Insider, approved by Zomato's board, will allow the food delivery giant to foray into the entertainment ticketing sector, complementing its existing dining and food delivery services.

New Delhi. Zomato has taken a significant step to broaden its business horizons by acquiring Paytm Insider, the entertainment and events ticketing arm of One 97 Communications Limited (OCL), for Rs 2048.4 crore. The acquisition, approved by Zomato's board, will allow the food delivery giant to foray into the entertainment ticketing sector, complementing its existing dining and food delivery services.

In a regulatory filing on Wednesday, Zomato detailed its agreement to enter into a Share Purchase and Subscription



Agreement (SPSA) with OCL, Wasteland Entertainment Private Limited (WEPL), and Orbgen Technologies Private Limited (OTPL) to seal the deal.

The complex transaction involves OCL transferring its movie, sports, and events ticketing businesses to its subsidiaries OTPL and WEPL through a slump sale. OCL will then inject capital into these subsidiaries via preferential allotment, using the proceeds to cover the slump sale payment. Simultaneously, Zomato will purchase OCL's entire stake in both OTPL and WEPL, effectively making them wholly owned Zomato

subsidiaries. The acquisition will be wrapped up within 90 days of signing the SPSA, with OTPL's acquisition valued at Rs 1,264.6 crore and WEPL's at Rs 783.8 crore.By stepping into the entertainment ticketing space, Zomato aims to further diversify its portfolio. The company emphasised that this move aligns with its strategic focus on bolstering its "Goingout" business, a key area of growth for the platform.OTPL, which has been operational since 2007, specializes in movie ticket listings and recorded Rs 13.14 crore in turnover as of March 31, 2024. WEPL, which entered the market in

brought in Rs 236.03 crore over the same period.Paytm, in a lighthearted social media post, welcomed Zomato to the entertainment sector. This acquisition builds on earlier reports from June when Zomato hinted at its interest in acquiring Paytm's movies and events businesses. At the time, the company noted that the move would strengthen its "going-out" segment and fall in line with its plan to concentrate on its four core businesses.Zomato's expansion into the ticketing market dovetails with the launch of 'District,' a new app focused on consolidating its "going-out" offerings. Founder and CEO Deepinder Goyal had remarked, "We believe that there is an opportunity to further expand our going-out offering, building on top of our dining-out business. said Dravid."I did not want to change anything. If you'd asked me and we had a discussion with our support staff, we'd get together with the coaches and say, what do you think we should do differently?""The common consensus (among the team) was we need to do exactly what we did. We need to create the same energy, create the same vibe, the same team atmosphere that we had and then just hope that on the day, we'll have a little bit of luck," he said. Dravid said that India had run a phenomenal campaign in the ODI World Cup, winning 10 games on a row. However, Australia defeated India by six wickets to win their sixth ODI World Cup at the Narendra Modi Stadium in Ahmedabad. Before the final, Australia lost their first two matches to India and South Africa but since then won 9 successive matches to complete one of their most memorable World Cup campaigns."I thought we ran a phenomenal campaign. We came unstuck in the final and Australia played better cricket than us on the day. They were a better team and congratulations (to them). That can happen in sport and that's what sport is about, Dravid concluded on the matter.

### Badminton, archery, boxing: India's Paris hopefuls falter, finish without medal

New Delhi After a historic performance at the Tokyo Olympics three years ago, where India set new records with a contingent of 117 athletes, hopes were high for an even better showing at the Paris Olympics 2024. There was anticipation that India might achieve a double-digit medal count for the first time in history. However, despite some bright moments, the campaign ended with six medals—one silver and five bronze.

The total medal count could still change, pending a decision on wrestler Vinesh Phogat's appeal for a silver medal. While India fell just one medal short of its Tokyo tally, the Paris Olympics marked its thirdbest performance at the Summer Games, following Tokyo 2020 and London 2012. India's archery, badminton, and boxing teams were considered strong medal contenders, but none of these sports managed a podium finish in the recentlyconcluded Paris Games.

India's archery team faced another disappointing Olympic run. Deepika Kumari's struggles on the Olympic stage continued, while Tarundeep Rai and Pravin Jadhav also failed to make a significant impact. Only Dhiraj Bommadevara and Ankita Bhakat, along with Bhajan Kaur to some extent, managed to enhance their reputations. The archery team's closest brush with a medal came in the mixed team event, where they narrowly missed out on bronze, finishing fourth against the USA. This marked India's first semifinal appearance in Olympic archery history—a notable achievement—but considering the substantial time and resources invested in this priority sport, the lack of a medal raises concerns.he archers themselves may not be entirely to blame. The federation, however, must answer for the low performance, especially regarding the absence of the highperformance director and the South Korean coach during the games. Badminton

For the first time since 2008, India's badminton contingent returned from the Olympics without a medal. Despite recent successes in team events, such as the Thomas Cup victory in 2022 and the Badminton Asia Team Championships in 2023, these achievements did not translate to individual glory in Paris.Lakshya Sen came closest to winning a medal but ultimately fell short in the bronze medal match.






