Omar Abdullah mocks Mehbooba Mufti's 'offer' for J&K polls

Srinagar, Aug 25: Omar Abdullah's remarks came a day after Mehbooba Mufti said the PDP would leave all seats for Congress-NC coalition if it accepts her party's agenda. National Conference Vice President Omar Abdullah taunted Peoples Democratic Party chief Mehbooba Mufti for allegedly copying his party's manifesto and asked the PDP not to field candidates against the Congress-NC nominees as their agenda is the same.



They (PDP) said if the NC-Congress alliance accepts their agenda, they will not put up candidates. You have put all our agenda in your manifesto," Abdullah said while addressing party workers in central Kashmir's Ganderbal district. "You have already accepted our agenda and now there is not much of a difference between your agenda and our agenda. Then do not field candidates and come, we will build a better tomorrow for Jammu and Kashmir," he added. Abdullah asserted that the PDP has essentially replicated the NC's manifesto, including promises to provide 200 free units of electricity and create one lakh government jobs within the first year—commitments that both parties have now included in their respective manifestos. "We said we will provide one lakh government jobs in the first year, they also put that in their manifesto. We talked about reopening (cross-LoC) routes, it is in their manifesto as well We talked about keeping the doors of dialogue open and they also said so. Almost everything that my colleagues put in our manifesto, they also put it," he said. Mehbooba Mufti on Saturday said her party was willing to offer full support to the Congress-NC alliance and concede all assembly seats to them, provided the coalition adopts the PDP's agenda.

Chirag Paswan re-elected as Lok Janshakti Party (Ram Vilas) chief for 5 years

Ranchi, August 25: Union minister Chirag Paswan was re-elected as the Lok Janshakti Party (Ram Vilas) president for five years at its national executive meet ing here on Sunday. The decision was taken unanimously at the meeting, Paswan said. "The national executive, in its meeting here, has re-elected me for the next five years," he said. Paswan, the Minister of Food Processing Industries, said the upcoming Assembly elections in Haryana, Jammu Kashmir and Jharkhand were also discussed at the meeting. In Jharkhand, the party may contest the polls either with national alliance partner BJP or on its own, he said.

Crimes against women unpardonable sin: PM Modi



Jalgaon (Maharashtra), August 25: Prime Minister Narendra Modi on Sunday termed crimes against women an unpardonable sin, adding the guilty should not be spared. Modi's strong remarks follow protests against the brutal rape and murder of 31-year-old trainee doctor at Kolkata's RG Kar Hospital and the sexual abuse of two four-year-old school girls in Badlapur. Speaking at the 'Lakhpati Didi Sammelan' in north Maharashtra's Jalgaon, Modi said the safety of women should be a priority. "The safety of mothers, sisters and daughters is the country's priority. I have raised this issue repeatedly from the Red Fort. Be it any state of the country, I understand the pain and anger of my sisters and daughters," he said. Modi said that he will tell every political party and state government that crime against women is an unpardonable sin. Whoever is guilty should not be spared, he added. "Those helping the perpetrators of crimes against women should not be spared. Be it a hospital, school, govern-

Sexual offenders should be castrated: Maharashtra **Deputy CM Ajit Pawar**

Yavatmal (Maharashtra), August 25: Amid the outrage over the Badlapur sexual assault incident, Maharashtra deputy Chief Minister Ajit Pawar said those guilty of offences against women should be castrated. He was speaking at an official programme about the Mahayuti Government's flagship 'Ladki Bahin' scheme for women at Yavatmal in eastern Maharashtra. The BJP-Shiv Sena-NCP government in the state would not spare anyone accused of offences against women, whoever the person may be, and a Bill providing for a more stringent punishment in such offences has been forwarded to the President for the assent, he said. "I personally feel that when such perverts lay hand on our mothers-sisters, our daughters, they should face such a legal punishment that they should not think of (repeating the offence) again. To put it in my language, such persons' private organ should be removed....Some people are so vile, that this must be done," Pawar said. Alleged sexual assault of two kindergarten girls at a school at Badlapur in Thane district has triggered intense outrage and protests in the state with the Opposition targeting the government for its 'failure' to protect women and children.

New Delhi, August 25: The lie detection test on Sanjay Roy, the main accused in the alleged rape and murder of a RG Kar Medical College trainee doctor, is under way at Kolkata's Presidency

Jail where he is lodged, officials said on Sunday. Two more individuals will undergo the test at the CBI office in Kolkata during the day, they said. Four persons, including former principal Sandip Ghosh, underwent the polygraph test on Saturday, the officials said. A team of polygraph specialists flown to Kolkata from the Central Forensic Science Laboratory (CFSL) in Delhi is conducting the tests, they said. The CBI earlier told the Supreme Court that the crime scene was altered by the time it took over the probe suggesting there was an attempt by the local police to cover up the rape and killing of the

The party has decided to field former J&K minister Abdul Majeed Wani from the Doda East Assembly constituency, former MLA Mohammad Amin Bhat from Devsar, former J&K advocate general Mohammad Aslam Goni from Bhaderwah, DDC member Saleem Parray from Dooru and Muneer Ahmed Mir from Lolab. The Aam Aadmi Party (AAP) also came out with its list of seven candidates for the

Assembly elections. The DPAP said DDC member Bilal Ahmed Deva will be its candidate from Anantnag West, Ghulam Nabi Wani (Nellora) from



Rajpora, Mir Altaf Hussain from Anantnag and Qaiser Sultan Ganai (Jin) from Ganderbal. Further, it said Ghulam Nabi Bhat would contest from Eidgah, Amir Ahmed Bhat from Khanyar, Nisar Ahmed Lone from Gurez and Peer Bilal Ahmed from Hazratbal. Amir Ahmed Bhat had recently contested the Lok Sabha polls from Srinagar but was unsuccessful. The three-phased Assembly elections for 90 constituencies in the Union territory will take place on September 18, 25 and October 1, followed by the counting of votes on October 4. The



Bengaluru Science gallery hosts Sci560 expo

BENGALURU: To cultivate a strong connection between the people, and the research institutions in Bengaluru, Science Gallery Bengaluru (SGB) unveiled a new exhibition titled 'Sci560' highlighting Bengaluru's role as India's leading militaryindustrial-academic hub. Minister for Science and Technology NS Boseraju inaugurated Sci560 on Saturday. Speaking at the inauguration, Minister Boseraju highlighted the exhibition's significance, stating that it is not just a chronicle of past achievements but a reminder of the power of scienific research to shape our future. Through a series of curated exhibits, Sci560 aims to foster cultural conversations around research, by showcasing pivotal scientific milestones that have shaped the city. Key exhibits include the historical Kolar Gold Fields neutrino experiments, the 'Bheja Fry' brain experiment, the Bangalore Torpedo developed by Madras Engineer Group, and three generations of Electronic Voting Machines (EVMs) manufactured by Bharat Electronics Limited (BEL), alongside old-fashioned ballot box. The exhibition is designed as a hybrid experience, with public programs scheduled every weekend. The opening weekend will feature a quiz titled 'Bangalore Bytes' guided walkthroughs in Kannada and English, and a public lecture on 'Map is not the territory.'

The name 'Sci560' reflects Bengaluru's pin code prefix, 560, combined with 'sci' to emphasize the exhibition's focus on science. Spurious liqour made with Pondy arrack sold in Tasmac bar, Two held

CHENNAI: The Enforcement Bureau CID of Tamil Nadu police on Friday busted a racket involved making spurious liquor made with arrack sourced from Puducherry and mixing it with colouring agents, and selling it through a Tasmac bar in Thanjavur.Police said Syed Ibrahim (46) was arrested from his house in Kumbakonam when he was loading 500 bottles of spurious liquor in his car.

On investigation, the team led by inspector J Raman found that the accused had purchased arrack from Pondicherry in bulk, mixed it with a colouring agent, bottled it in empty IMFL bottles and gave it to Tasmac shops with fake labels and holograms. Based on his interrogation, police also arrested Anbuselvan (39) for assisting Syed. Police found that the liquor was being distributed to Kolanjirajan who was running a bar attached to a Tasmac shop in Thanjavur. SMCs being revamped; phase 3 polls for higher secondary schools across TN held

CHENNAI: The school education department is reconstituting school management committees (SMCs) in government schools across the state after their two-year tenure ended. The elections for high and higher secondary schools were completed on Saturday, whereas for the primary schools, the elections were held in two phases on July 10 and 17. The elections for nearly 8,000 middle schools are scheduled for August 31, according to officials from the school education department. Further, the department has introduced model identity cards and letterheads for SMC chairpersons and members.

SMC observers have noted an increase in awareness among committee chairs and members regarding their roles and responsibilities. Though the friction between teachers and parents persists in some schools, the observers said the number of such cases has gone down. "In several schools, teachers now feel they can rely on the SMC members to handle issues such as drinking water shortage and requests for infrastructure improvements, allowing them to focus more on teaching," said an SMC observer. The SMC meetings, originally conducted once a month, are now held quarterly, after protests from teachers' associations. However, parents and activists have urged the department to return to monthly SMC meetings. S Natraj, an education activist, said, "To institutionalise the committees, it is essential that the members meet monthly and follow up on

It helps them understand their roles and responsibilities. In several schools, the SMCs are proactive and contribute to improving the learning environment. Reducing the frequency of meetings goes against the government's aim to increase community participation in education.'

Kerala: Amicus curiae recommends disaster management plan for NHAI after Shirur tragedy

The report filed in Kerala High Court pointed out that the construction particulars vary from hilly areas to plains and marshy lands. It is doubtful whether the NHAI has put in place any disaster management plans.

KOCHI: Citing the Shirur incident which led to significant environmental disasters and loss of lives, the amicus curiae appointed by the Kerala High Court has recommended that the National Highways

Authority of India (NHAI) be directed to implement a disaster management plan and take effective steps to prevent frequent landslides during the construction of national highways in the state. The NHAI oversees the construction of a 600-km stretch of national highway from Kasaragod to Thiruvananthapuram. The report highlights that in the Shirur area, hills were cut horizontally without any support from

retaining walls, causing massive landslides. Similar methods of hill cutting have been observed in Kerala as well.

Illegal slaughtering on rise in Thiruvananthapuram as modern abattoir project drags on

According to official sources, only 70 per cent of the work has been completed and the work on many key components is yet to take off.

THIRUVANANTHAPURAM: Illegal slaughtering and improper disposal of waste are becoming a growing concern in the state capital as the ambitious plan to establish a modern abattoir is dragging on inordinately. It has been nearly six years since the city corporation roped in KEL (Kerala Electrical and Allied Engg Co Ltd) for the execution of the abattoir projectEven after missing several deadlines and ultimatum, KEL is yet to complete the project. According to official sources, only 70 per cent of the work has been completed and the work on many key components is yet to take off. Recently,

Mayor Arya Rajendran held a meeting with the officials giving yet another ultimatum for the completion of the project. The modern abattoir, which is estimated to cost '10 crore, will have an outlet selling fresh meat, rendering plant which will help treat slaughter waste scientifically and convert it into numerous by-products including cosmetics and pharmaceutical items. As per rough estimates, around 20,000 kg of beef (200 cattle) and 2640 kg of mutton (200 goats) are being consumed daily in the state capital. However, the civic body has failed to ensure safe meat to the public for more than a

decade now. According to officials, it is impossible to curb illegal slaughtering and meat trade because there is no alternative facility to meet the demand of meat.Kunjalumoodu, Vallakadavu, Beemapally, Poonthura, Valiyathura, Attakulangara, Vellayani, and Karamana are some of the hotspots where illegal slaughtering is rampant in the capital. The airport authorities have also raised the issue of increased bird-hits on planes seeking intervention from the civic body."The work on the bio-filter is yet to take off and the work on many other components is also pending.

They were supposed to hand over the completed abattoir in 2021 and we have been extending the deadlines for them. KEL has sub-contracted the works and the Lok Sabha elections also caused some delay," said an official source. KEL has procured '6.5 croreworth machinery to be installed at the abattoir.The official said that KEL has promised to complete the installation of biofilters within three months and the rest of the work will be completed within a month."It is a modern facility and first of its kind in the state. We are hoping to make the abattoir operational at least by December end.

HYDRAA demolishes Nagarjuna's Rs 400 crore lake convention

Disaster Relief and Asset Protection Agency (HYDRAA) razed the highprofile N-Convention Centre, owned by Tollywood actor Akkineni Nagarjuna, early morning on Saturday. Located in Madhapur, the centre was allegedly encroaching upon the Full Tank Level (FTL) and buffer zone of Thammidi Kunta lake. 'You've got a new phone': 3 nabbed for cyber fraud in Gurgaon

GURGAON. Three cyber frauds were arrested on Friday for impersonating officials from Samsung and luring individuals on the pretence of new mobile phones. The accused, identified as Mani Chaubey from Bihar's Kaimur district, Khushwant Goit from Nai Basti in Dehradun, and Rohit Singh from New Seemapuri, Delhi, were arrested from Sector 24.ACP (cyber crime) Priyanshu Diwan said, the accused used a deceptive modus operandi to lure their victims. Mani Chaubey, the mastermind behind the scam, would impersonate a Samsung official and contact individuals, promising them a new Samsung mobile phone. He would then ask the victims to transfer a certain amount to a bank account to avail an offer. Once the money was received, he would transfer the funds to the bank accounts of his accomplices, Khushwant Goit and Rohit Singh. The trio would then proceed to block the customers' phone numbers, leaving them with no means to contact or trace them. Gurgaon police's cyber crime division managed to trace and apprehend the three through technical tracking. A case has been registered against them at the cyber police station under Section 318(4) (cheating) of BNS. The police have recovered one mobile phone and one SIM card from the possession of the accused. "We are pursuing leads to uncover any further ramifications of this scam and to ensure that all those involved are brought to justice," said the officer. The police have issued an advisory urging people to remain vigilant and cautious, requesting them to report any suspicious or fraudulent activities to the cyber crime helpline number 1930.

Gurgaon police's cyber crime division managed to trace and apprehend the three through technical tracking. A case has been registered against them at the cyber police station under Section 318(4) (cheating) of BNS. Interior designer was abducted & murdered over affair; 3 nabbed

Ghaziabad. Three persons were arrested for the alleged murder of a 34-year-old interior designer in Morta village of Bulandshahr last week. Six other accused involved in the case are currently at large.

According to police, the deceased is Tarun Panwar — a resident of Raj Nagar Extension — and he was reported to be missing on Aug 16. Parts of his body were found in a river near Morta village in Bulandshahr. The arrested accused are Pawan and Vansh of Bibinagar and Anjali from Raj Nagar extension. Others on the run are Deepanshu, Ankur and Ankit from Bibinagar, Akshay from Loni, Jeete

Police said that on August 17, Panwar's family filed a missing complaint at the Nandgram police station, explaining that the previous day he had received a call in the morning following which he went to Morta village. When he did not return home till late night and stopped responding to the family's calls, they began calling his friends but he was found nowhere, they told the cops.Later, his phone's location was traced to Morta village and his car — a Kia Sonet was found near Yashoda Hospital. A case was registered under Section 140 (1) (kidnapping for murder) of the BNS.Further investigation revealed that Panwar had been killed and his body parts were dumped in the river. Pawan, Vansh and Anjali were traced and arrested and a car and weapons used in killing the interior designer were recovered from the accused's possession.Pawan told the cops that Panwar had become close to Anjali, who allegedly had relations with both Akshay and Pawan. When both the men got to know of Tarun's relation with Anjali, they decided to kill him and made a plan with the rest of the accused. Anjali is separated from her husband while Panwar is survived by a wife and a 7-

Colleague lures woman to convert religion, arrested

Ghaziabad. A 49-year-old man was arrested on Friday for allegedly luring a married woman to convert to another religion. The woman's husband filed a complaint at Kavinagar police station and a case was registered under relevant sections of BNS and UP Prohibition of Unlawful Conversion of Religion Act, 2021. The complainant has alleged police inaction despite repeated complaints over the past few months.Rakesh Kumar (name changed) alleged that the accused, Faisal Khan — a resident of Masuri and an HR executive in a company — met his wife Savita (name changed) in June 2023, while working parttime in a school where she teaches. Kumar began coming across messages on Islam and Arabic writing on his wife's mobile phone. He also said that Savita went mising for 2 to 3 days in Nov last year and Jan this year. He claimed that in both instances, she was found in a disoriented condition. Kumar suspected Khan's involvement in this and police interrogated the latter based on the complainant's claims. However, nothing concrete came off the questioning.

The complainant began receiving letters about his wife, urging him to leave her, which he suspected were sent by Khan's wife Ghazala. Based on Kumar's complaint, Khan was arrested on Friday. Police later found that he was also implicated in a case of forced religious conversion in 2021. "Khan revealed he had given her a phone and the two spoke every day. He began sending her messages about Islam and asking her to convert. She had begun to follow some practices once he was able to convince her," ACP Abhishek Srivastava said.

5 Noida projects face insolvency, Rera asks allottees to file claims with IRP

Ghaziabad. Homebuyers of five residential projects in Noida, which are undergoing corporate insolvency resolution process, can now file their claims with the interim resolution professional, UP Rera chairman Sanjay Bhoosreddy said.

Earlier this year, the National Company Law Tribunal (NCLT) gave its nod to initiate insolvency proceedings against five developers, including Supertech Realtors Pvt Ltd's Supernova (phase 1, 2, 3 and 4) and Supertech Township Projects Ltd; Golf Country (phases 1, 2, 3 and 4); Ajnara Realtech Ltd's Le Garden Prime Tower (tower P), Le Garden (phases 1, 2, 3 and 4) and Le Garden (towers A, B and C); Rudra Buildwell Construction Pvt Ltd's KBNOWS Apartments; and Gayatri Hospitality Ltd's Gayatri Aura.

"After CIRP is initiated against a project, UP Rera informs all allottees of such projects to file their claims with the IRP so that they do not suffer losses on account of any delay or non-filing of claims," the Rera chairman said. As per the rule, once a project is admitted into CIRP, no court

cases against a debtor company. The real estate regulator has also revoked the registration of 72 projects across UP on various grounds of violations under section 7 of the Rera Act. Of these, 63 are in GB Nagar and three in Ghaziabad.

Section 7 of the Act states the regulatory authority can revoke the registration of a project if it fails to meet the requirements of the Act, rules, or regulations, violates the terms or conditions of the approval, or is involved in unfair practices or irregularities.For non-compliance with its orders, the regulatory authority has imposed a penalty of Rs 37.5 crore against 115 developers. It also imposed a Rs 9 crore fine against 120 developers for misleading advertisements and a Rs 18 crore penalty for non-filing quarterly progress reports in connection with 1,048 projects. Meanwhile, about Rs 10 crore in fines has been recovered from 225 promoters for violation of section 3 of the UP Rera Act. According to Rera officials, 60% of the total 54,730 complaints were filed in e-courts from GB Nagar. "We

Survey finds mosquito larvae in 8k homes in Gurgaon

offence or contravention GURGAON. A door-to-door survey by the state health department found mosquito larvae in 8,491 houses of the 15.38 lakh it screened. The survey was initiated after the city reported 23 cases of dengue since June this year. Those who are showing symptoms of a viral infection were also tested for various vector-borne diseases such as dengue, malaria and chikungunya at their nearest primary health centre. As many as 7,712 notices were issued to defaulters for failing to implement protective measures against vector-borne diseases. As part of precautionary measures, health officials pinpointed five hotspots for the disease- Wazirabad, Bhangrola, Nakhrola, Badshapur, and Bhondsi and put them under surveillance.

> The department also plans to geo-tag all positive larvae bases to establish a comprehensive database.All private hospitals in the city were mandated to establish a separate ward dedicated to dengue cases and collect samples from designated flu corners where individuals exhibiting symptoms can be screened."This is an ongoing process. We are conducting a survey to identify suspected cases and provide prompt



treatment. Our teams are inspecting areas where cases were previously found and also identifying water-holding containers that can serve as breeding grounds for mosquitoes. We will gradually increase the sample collection to check

Brown, Chairman of the Joint Chiefs of Staff, began his trip in Jordan and said he will also travel to Egypt and Israel in the coming days to hear the perspectives of military leaders. The top US general began an unannounced visit to the Middle East on Saturday to discuss ways to avoid any new escalation in tensions that could spiral into a broader conflict, as the region braces for a threatened Iranian attack against Israel.Air Force General C.Q. Brown, Chairman of the Joint Chiefs of Staff, began his trip in Jordan and said he will also travel to Egypt and Israel in the coming days to hear the perspectives of military leaders. At the same time, as I talk to my counterparts, what are the things we can do to deter any type of broader escalation and ensure we're taking all the appropriate steps to (avoid) ... a broader conflict," Brown told Reuters before landing in Jordan.

US President Joe Biden's administration has been seeking to limit the fallout from the war in Gaza between Hamas and Israel, now in its 11th month. The conflict has leveled huge swathes of Gaza, triggered border clashes between Israel and Lebanon's Iranian-backed Hezbollah movement and sparked attacks by Yemen's Houthis on Red Sea shipping. Meanwhile, US troops have been attacked by Iran-aligned militia in Syria, Iraq and Jordan.

Ex-Bangladesh PM Sheikh Hasina's close aides placed on remand in murder cases

Dhaka. A court on Saturday placed Salman F Rahman, private industry affairs adviser to ousted prime minister Sheikh Hasina, former law minister Anisul Huq, former social welfare minister Dipu Moni and two others on different terms of remand for interrogation in four murder cases.Dhaka Metropolitan Magistrate Mohammad Jashim passed the orders in the cases, Daily Star Newspaper quoted a sub-inspector working in the court as saying. Apart from the three, former chief whip ASM Feroz and former army officer Major General Ziaul Ahsan were also placed on remand in murder cases. Salman, Anisul and Ziaul were placed on a fresh 10-day remand in two murder cases filed with New Market and Lalbagh police stations.

Dipu Moni was placed on a four-day remand in a case filed with Badda Police Station and Feroz was placed on a seven-day remand in a case filed at Bhatara Police Station.

Cases have been filed against many officials or ministers of the ousted Hasina-led India on August 5 following massive protests against the quota reform system in Bangladesh.Many Hasina-led Awami League party members are in jail after the new interim government led by Nobel Laureate Muhammad Yunus took charge on August 8 following the fall of the previous

US's ex-Covid advisor **Anthony Fauci infected** with West Nile virus: Spokesperson

USA. Dr. Anthony Fauci, the former top US infectious disease expert, spent time in the hospital after being infected with West Nile virus and is now recovering at home, a spokesperson confirmed on Saturday.

Fauci is expected to make a full recovery, the spokesperson said on condition of anonymity due to security concerns. West Nile virus is commonly spread through the bite of an infected mosquito. While most people don't experience symptoms, about 1 in 5 can develop a fever, headache, body aches, vomiting, diarrhoea, or rash, according to the Centres for Disease Control and Prevention. About 1 out of 150 infected people develop a serious, sometimes fatal,



illness.CBS News' chief medical correspondent, Dr. Jonathan LaPook, wrote in a social media post that he spoke Saturday with Fauci, who said he was likely infected from a mosquito bite that he got in his backyard."Dr. Fauci was hospitalised about ten days ago after developing fever, chills, and severe fatigue," the post on X said. It said Fauci spent a week in the hospital.

As chief White House medical adviser, Fauci was the public face of the US government during the Covid-19 pandemic, a role that made him both a trusted voice to millions and also the target of partisan anger.

discussed new compromise proposals in Cairo on Saturday, seeking to bridge gaps between Israel and Hamas, but there was no indication of progress after hours of talks."The talks in Cairo didn't make any progress. Israel is insisting on keeping eight positions along the Philadelphi corridor," one Palestinian official close to the mediation effort told Reuters, asking not to be named due to the sensitivity of the subject. The Cairo talks came as the humanitarian situation in Gaza deteriorated, with malnutrition soaring and polio discovered in the Palestinian enclave. Israeli military strikes in Gaza killed 50 people on Saturday, Palestinian health authorities said, with victims trapped under rubble or lying on roads where fighting continued.

A Hamas delegation had arrived in Cairo on Saturday to be nearer at hand to review any proposals that emerged in the main talks between Israel and mediators Egypt, Qatar and the United States, two Egyptian security sources said.

A US official said negotiators from the United States met with Egypt, then with Egypt and Qatar on Saturday, and believed that representatives from Egypt and Qatar were meeting with Hamas.

The Hamas delegation returned to Doha, Qatar, after the briefing on the round of talks ended, the Palestinian official said. Months of on-off talks have failed to produce a breakthrough to end Israel's devastating military campaign in Gaza or free the remaining hostages seized by Hamas in the militant group's October 7 attack that triggered the war. The Egyptian sources said the new proposals include compromises on outstanding points such as how to secure key areas and the return of people to north Gaza. However, there was no sign of any breakthrough on key sticking points, including Israel's insistence that it must retain control of the so-called Philadelphi Corridor, on the border between Gaza and Egypt.

Israel Declares 48-Hour Emergency After Lebanon Strikes Spike Middle East Tensions; US Ready To Defend Ally

Jerusalem, Israeli Defence Minister Yoav Gallant announced a 48hour nationwide state of emergency on Sunday after the country's military launched "pre-emptive strikes" in Lebanon that escalated tensions in the Middle East. The region has been on edge for weeks after Hezbollah and Iran promised to respond to an Israeli strike in Beirut that killed a senior commander of the group as well as the assassination in Tehran of Hamas's political leader, also blamed on Israel. The declaration on the state of emergency enables the IDF (Israeli military) to issue instructions to the citizens of Israel, including limiting gatherings and closing sites where it may be relevant," Gallant said, in a statement issued by his office."I am convinced that there is a high probability of an attack against the civilian population in areas of the country where the declaration of a



special situation did not apply," he said, referring to previous local emergency measures. "I hereby declare a special situation on the home front in other areas of the country. The situation is valid for 48 hours starting at 6:00 am," Gallant said. In a separate statement, the defence ministry said Gallant briefed US Secretary of Defence Lloyd Austin on the overall situation. "We have conducted precise strikes in Lebanon in order to thwart an imminent threat against the citizens of Israel," Gallant

told Austin, according to the statement. "We are closely following developments in Beirut, and we are determined to use all the means at our disposal in order to defend our citizens."320 ROCKETS AT **ISRAEL OVERNIGHT** Hezbollah said Sunday it had launched

World Sicilian prosecutors said Saturday they were investigating possible manslaughter after a superyacht sank, killing seven people, as it emerged that trapped passengers scrabbled for air pockets after it went down.

UK tech tycoon Mike Lynch, his 18-year-old daughter Hannah, four friends and the yacht's cook died when the British-flagged Bayesian sank in a storm before dawn on Monday."The Public Prosecutor's Office of Termini Imerese has registered a file with the state against unknown persons, hypothesising the crimes of negligent shipwreck and multiple negligent manslaughter," state prosecutor Ambrogio Cartosio told reporters on the Italian island.

California sees 'unusual' cold weather, heavy snow shuts part of highway

Fake NCC camp: Madras High Court to hear probe transfer petition on August 27

CHENNAI: The Madras High Court on Tuesday will hear a public interest litigation petition filed by advocate AP Suryaprakasam seeking a CBI probe into the sexual assault of a girl at a fake NCC camp held in Krishnagiri district recently.

The petition has been listed for hearing before the first bench of Acting Chief Justice D Krishnakumar and Justice PB Balaji. The petitioner has sought the transfer of probe to CBI alleging that the state police "miserably failed" in its investigation and allowed the main culprit, Sivaraman, to die in custody. The investigation may be directed to be transferred to the second respondent for "proper investigation without any interference" from the authorities of the state government, he said in the petition. He expressed anguish over the possibilities of closure of investigation under the pretext of the death of the main accused. He also sought the court to issue directions to the authorities to provide all relief to the affected children without waiting for the completion of investigation.

Shoddy probe, lapses result in acquittal of two in drug bust case in Chennai

CHENNAI: Procedural lapses and lack of evidence to back conspiracy charges have led to the acquittal of a techie and his friend who were accused of procuring and selling narcotic drugs like ecstasy, LSD, and cocaine. A city court earlier this week binned the charges by police that the techie had conspired with his friend in Jolarpet to sell the drugs after procuring them through the darknet. Though the cops arrested one of the accused red-handed with the drugs at a bus stand, they did not produce any evidence to back their charge of conspiracy between the two to procure the drugs and sell them, the trial court said in its August 21 order acquitting them. The case filed by cops attached to the SRMC police station was that on August 23, 2022, they arrested Arukumar (31) from the Mugalivakkam bus stand on the Porur-Guindy road, while in possession of nine LSD stamps, five ecstasy (MDMA) pills and 13.5g of cocaine. They took his voluntary confession which stated that his friend Navin (30) from Jolarpet had procured it through the darknet and gave it to him for money. Navin was arrested by the

However, during trial, the special NDPS court judge pointed out that the police had not even done basic due diligence to prove their charges. For instance, they had seized mobile phones from both the accused, but it wasn't sent for forensic analysis to extract any details that could prove the conspiracy charge. This was important as it was the police's charge that Navin had bought the drugs from the darknet because Arunkumar had asked him to. "No linking materials were produced by the prosecution to show that both accused were in contact during the relevant period," the judge said in the order.

Apart from this, the court found procedural flaws in the investigation like mention of crime number and the sections under which the accused was charged in the seizure mahazar, which is prepared at the spot of recovery prior.

EXPRESS DIALOGUES | Hema Committee report is a wake-up call not just for Kerala but whole of India

Kerala. The Hema Committee report, which was made public on August 19, after nearly five years in cold storage has created nothing short of an explosion in the How do you look at the Malayalam cinema. Though the revelations of the report including that of systemic sexual abuse of women are not new and have always been there as rumours in the atmosphere, one thing the report has done is legitimise such experiences narrated by women and more than anything else, demand accountability. But how far can the report get us? What are the challenges on the way to holding the perpetrators accountable and implementing the

Don't disturb tigers, dwellers on Karnataka forest fringes told

BENGALURU: With the increasing reports of tiger migration being noted by experts and forest staffers and captured by camera traps, state forest department officials are now working with the locals, asking them to stay away from wandering tigers. The department has also taken up a study of wandering tigers and is creating awareness among people to reduce conflict and deaths of humas and wildlife. As per Project Tiger, there are four tiger landscape complex units in the state -Bandipur-Nagarhole, BRT-Cauvery-MM Hills, Bhadra-Kudremukh-Shivamogga-Chikkamagaluru and Kali-Belagavi-Sharavathi. Of these, 75% of the

population is housed in the Bandipur-

Nagarhole landscape."While we are



they come in conflict when a cattle kill is reported, we have also started creating awareness among people staying around forest areas to stay away from the animals. We are tracking the movement and wandering pattern of tigers. All tigers outside forests need not and cannot be captured. One killed, three injured in firecracker unit blast in Tamil Nadu



MAYILADUTHURAI: A 27-year-old worker was killed while three others sustained severe burns in an explosion that occurred at a firecracker manufacturing unit in Thiruvalankadu on Saturday afternoon. The blast, which is suspected to have occurred due to mishandling of combustible raw materials during production, completely gutted the small-scale unit, sources said. The deceased was identified as U Kannan of Thiruvavaduthurai. As per sources, the blast at the unit registered under the name of Pandiyan occurred around 1 pm. While Kannan died on the spot, V Kaliyaperumal (50) and S Lakshmanan (45) of Thiruvalankadu, and S Kumar (35) of Virudhunagar sustained severe burns. On seeing the manufacturing unit engulfed in flames, residents sent the injured to Mayiladuthurai general hospital.On information, fire and rescue personnel rushed to the site and doused the flames in about 30 minutes. By then, the factory was almost gutted completely. Collector AP Mahabharathi, DRO M Manimegalai and RDO R Vishnupriya inspected the accident sie and met the injured in hospital.n the collector's directions, injured with over 80% burns, were shifted to the Government Tiruvarur Medical College. Inspector A Jothiraman of Kuthalam police station, where a case has been registered, said, "The unit was operating for decades. The explosion might have occurred due to mishandling of combustible raw materials during production."

capturing tigers in forest fringes as soon as Land for playground can't be used for other purposes: Madras High Court

CHENNAI: Holding that a land earmarked as playground cannot be allowed to be de-reserved, the Madras High Court has refused to order the Tamil Nadu Housing Board (TNHB) to sell the playground area to a trust running a school at Tiruvanmiyur in Chennal."The land, having been reserved as a playground, cannot possibly be sold to the petitioner. Playground is a separate and distinct use category, and cannot be put to interchangeable use wholly or partly. The land reserved as an open

space for playground can never be allowed to be de-reserved," Justice J Nisha Banu said in a recent order. The judge noted that the most common reason for shrinking of playgrounds is expansion of school blocks. The observations were made while disposing of a petition filed by the Hindu Seva Samajam which runs a school in Tiruvanmiyur. The TNHB allotted 50% of a 1,889.34 sq.m land for construction of a school at a cost of Rs 22.33 lakh in 1989 at half the price, and allotted the

remaining land to be used purely as a playground. The trust approached TNHB for purchasing the playground portion and paid Rs 32.72 lakh, but the board later revised the amount after finding it was being used for other purposes. It withheld the sale deed for the school

Seeking orders for releasing the sale deed and selling the playground area, the Samajam approached the court. The judge ordered TNHB to execute sale deed for the school area.


Woman says hubby didn't allow her to eat french fries, Karnataka High Court comes to his rescue

BENGALURU: The Karnataka High Court came to the rescue of a man by permitting him to return to the United States to save his job, staying the proceedings initiated against him by his wife, who alleged that he did not allow her to eat french fries.

The Basavanagudi women police had issued an LOC (Look Out Circular) to the 36-yearold husband based on the complaint filed by his 29-year-old wife from the city. Hearing the man's petition, Justice M Nagaprasanna said permitting any investigation against the husband would become an abuse of the process of law and putting a premium on the wife's trivial allegation. There shall be an interim stay of all further investigation till next hearing, the judge said. The judge

said it is surprising as to how the jurisdictional police generated the LOC on trivial circumstances. It is a misuse of power at the behest of the complainant. The only object of the complainant appears to be stopping the petitioner from travelling back to the USA.

"I deem it appropriate to permit the husband to keep his employment in the USA... The jurisdictional police should forthwith intimate to the Bureau of Immigration with regard to the travel of the husband and not to interdict or ostracise him during his travel to the USA," the judge said. According to the interim order, the husband came down during vacation only to receive the complaint registered by his



wife against him and his family members. The husband moved the court because he is on the verge of losing the job. The court

stated that the allegation in the complaint is over minor skirmishes that happen between husband and wife in day-to-day

Quoting from the wife's complaint, the court stated that her contention was that when she delivered a child, she had high blood pressure and the husband did not allow her to eat french fries, consume rice and meat, saying she would put on weight The husband cried foul that he did all the household chores in the USA during their stay, while the wife only watched TV and while not watching TV she chatted with her family over phone. He said he washed dishes, mopped the house and then proceeded to work.

KSPCB to inspect buildings listed for demolition to stop sewage flow into lake

BENGALURU: The Bruhat Bengaluru Mahanagara Palike (BBMP) certified 19 buildings in Mahadevapura zone as illegal, and the Karnataka State Pollution Control Board (KSPCB) has taken note of it.KSPCB sources said the Board will inspect the sites and ensure that untreated waste water is not released into lakes. A senior officer from the board said, "These buildings have reportedly added more than the approved number of kitchen and bathroom units in the building, and are letting untreated wastewater into the Yelemallappa Shetty Lake. Following the inspection, measures will be taken to stop waste water flow into the lake."An official from the KSPCB environmental office of Mahadevapura zone said a few buildings in a particular layout in the Basavanapura ward are releasing untreated wastewater into the lake."Some buildings have approval for four kitchen units, but added over 15-20 kitchen units, and 30

bathrooms. The water from these enters the lake. We will inspect these buildings in September and prepare a report. Either the site owner or the builder should be held responsible for polluting the lake," said the official. An FIR will be registered against those responsible for polluting the lake, he added. A volunteer working on lake rejuvenation welcomed the move to inspect the buildings and said construction debris, carcasses of cows and waste water enter the lake through the drain. "The minor irrigation department and BWSSB knew about it. Some buildings in layouts like Sai Serenity and Sai Garden are letting their sewage into the lake. Following the National Green Tribunal observation, the state government has allocated special grants of Rs 120 crore for the rejuvenation of Madiwala and Yele Mallappa Shetty lakes. But minor irrigation officials have failed to complete fencing of the lake," said the volunteer.

Road rage: RBI officer assaulted in Bengaluru

BENGALURU: A 30-year-old RBI compliance officer from Odisha had to undergo a plastic surgery after glass pieces from his spectacles cut his face when three drunk men assaulted him in a road rage case in Adugodi police limits. The incident happened on Tuesday around 8 pm near the Bosch traffic signal when T Swagat Sahu of JP Nagar 5th Phase was returning home on his motorcycle. Two men, who were riding a motorcycle, suddenly cut through the Marble Road without giving any signal and Sahu almost hit their vehicle. When Sahu advised them to switch on the indicators of their motorcycle and left, the duo

chased him. They forced Sahu to stop near the Bosch traffic signal and started abusing him. Meanwhile, another person joined them. One of the accused punched Sahu through his helmet visor when his glasses broke. The trio left the spot after seeing Sahu bleeding profusely. Though he suffered deep cuts on his face, Sahu rushed to Adugodi police station and filed a complaint. "Many people were at the spot when the trio attacked me, but none came to my rescue. A cop, who was on his motorcycle, did not help me despite my pleas. The black motorcycle the accused were

J&K witnessed landmark elections in 2002

THE Election Commission of India's (ECI) announcement on holding the three-phase Assembly elections in Jammu and Kashmir brought back memories of the landmark polls held in September-October 2002. While the forthcoming elections would be the first in the Union Territory, the one in 2002 was also significant for several reasons.

While there has been a rise in terror attacks in the Jammu region in the recent past, it was the Kashmir valley that had witnessed an escalation of terror activities in 2002. It was the first time that the Jammu and Kashmir Peoples Democratic Party (PDP) participated in the Assembly polls. There was a call for boycotting the elections, given by the Tehreek-e-Hurriyat. This was also the first poll in J&K in which EVMs (electronic voting machines) were used.

Even before the announcement o the dates of the four-phase elections was made, it was widely known that they were in the offing. While the PDP had pulled out all stops to reach out to the electorate, the J&K National Conference appeared to be relying on its solid organisational structure down to the grassroots level in its traditional strongholds. While the political parties had already begun their preparations, the official machinery had also started gearing up for the important event. It included, besides the Central and state governments, various security forces and intelligence services. The dynamic security situation was being closely watched and discussed regularly at the Unified Command Headquarters.It was apparent that the security situation was widely different in urban and rural areas. The terrorists, wanting to make their presence felt, were more active in towns and cities, which had a large concentration of population, rather than in sparsely populated villages and hamlets. The urban population, which enjoyed better civic amenities, had more time to participate in political activities. In those areas, it was relatively easier for terrorists to enlist overground workers and quasi-political organisations like the Hurriyat. In mofussil areas, daily life was hard in the absence of basic facilities like medical treatment, supply of water and electricity which left little time for politics, except at the local level. The urban population was thus more polarised along existing political lines, whereas rural folk looked forward to the polls as an opportunity to have their say to improve their lives. In the rural areas, the enthusiasm to vote in the elections was palpable, especially among the youth and first-time voters. Interestingly, the rural population showed greater inclination to participate at the hustings, even defying threats and intimidation from terrorists and at times tearing posters warning voters of dire consequences. The first phase of the elections was to be held on September 16, 2002. James Michael Lyngdoh, then Chief Election Commissioner, visited Srinagar a few times in the weeks prior to that to hold detailed discussions with the state administration and oversee polling arrangements. He was unequivocal in emphasising that he would accept no mismanagement at booths and would order repolling as many times as needed to ensure free and fair polling. After the official announcement of the election schedule, the elected state government went into suspended animation and the Governor, Girish Saxena, took charge. About a week prior to the first round of polling, he held a meeting to take stock of the situation and satisfy himself that all was in readiness for the big event. Apart from officials directly involved in the conduct of polling, the meeting was attended by local heads of various security forces, intelligence agencies, senior bureaucrats of the state government and a few others. At the end of the meeting, the Governor wanted to know what in our estimate would be the percentage of polling (voter turnout).

Modi's Ukraine visit is the message

THE GREAT GAME: The West wants to win India over — despite its grime, it's a nation of gritty people

CHANTS of 'Har, Har Modi' and 'Jai Shri Ram' by overenthusiastic Indians in Kyiv on Friday may have somewhat marred Prime Minister Modi's solemn visit to the garden in the Ukrainian capital where Mahatma Gandhi's statue stands. Minutes later, though, the visible emotion that marked the meeting between Modi and Volodymyr Zelenskyy in front of a memorial that commemorates some of the fallen in the ongoing Russia-Ukraine war was emblematic of the difficulty that India faces as it seeks to follow the middle path in this war.On the face of it, it's a no-brainer. Russia invaded Ukraine and must be roundly condemned - many Indians as well as Russians do. But look closely, and the context creeps in. Two years ago, Russia ostensibly went to war because it was insecure about NATO expanding to its frontiers.

Today, the war is less about victory or defeat between Russia and Ukraine, old partners and co-religionists, but much more about the ongoing argument between Russia and the US about Russia's place in the world.

Everyone, especially the Ukrainians, knows that if it were not for the sophisticated weaponry being supplied by the US as well as large parts of the Western world to Zelenskyy's men, the war would have been long over. But it isn't and innocent people are continuing to die. Big power politics has taken over. This is what this Ukraine war is about. Kaun banega duniya ka dada? The Americans clearly are unwilling to relinquish the top spot since the Soviet Union collapsed in 1991-end. The Russians, still not as strong as the Americans today but strong enough, insist that there's place for more than one. And as always, the Chinese watch and wait, eager and willing to play both sides — expanding trade with the US. even as they support Vladimir Putin's anxious need to remain relevant both at home and abroad. What of PM Modi and India? The answer to where India stands in this Those in the West condemning India for refusing to ongoing great game is complex. On the one hand, Modi told Zelenskyy in Kyiv, one of the most beautiful cities in the world, that India is ready to "play an active role in any effort towards peace". Just before, the two had embraced each other warmly - a bit like the long hug into which Modi and Putin had collapsed six weeks ago in the latter's Or if, any of these Western nations, most of them dacha outside Moscow, which Zelenskyy had, openly, admitted to being upset about. Moments later, Modi placed his left hand on Zelenskyy's left shoulder, like elder brothers often do with younger ones, and left it there for many moments while the photographers took many pictures. Seems Modi was genuinely moved — it's a good thing he was. India usually stands with the underdog its defence of the Mukti Bahini in the former East Pakistan is a good example. But something else seems to be happening here. It seems as if Modi was quite persuaded that he should be seen to be standing with the Ukrainians – and therefore, the US. The Americans had



made no bones about their displeasure with Modi's visit to Moscow. The fact remains that India-US trade is still double that of between India and Russia, notwithstanding the jumped-up volumes due to the purchase of discounted oil by Delhi from Moscow in the last two years.

raised one little finger of dissent when the US decided to bomb Iraq in 2003, in ostensible anticipation of Saddam Hussein using weapons of mass destruction. Wait, one second - Saddam didn't have any.

Meanwhile, the visit of Defence Minister Rajnath Singh to Washington DC, at the exact minute that Modi was in Ukraine, may be a coincidence — signing a defence pact or two with the Americans is a fine thing to do. But if it's not a coincidence, then two other conclusions may be made.First, that America is not comfortable about dissent, including by a fellow democracy. There would have been a lot of conversation between Delhi and Washington DC as well as several other Western capitals, seeking to persuade Modi to meet Zelenskyy in Kyiv.

And second, it's clear that Ukraine is turning into Modi's toughest foreign policy challenge so far. Remember, again, that Ukraine is just an alibi, rather a notable cat's paw for the Americans. Nothing wrong with going to Kyiv — much better to check things out for yourself, no matter what Putin or Joe Biden have said. If the PM is able to manouevre between the cat's claws, like many of his predecessors have ably done, he will succeed in reestablishing India's unique place in the world.

Permanent-Five members of the UN Security Council, Certainly, the world will be watching - like it watched the Modi visit to Moscow - for any telltale signs of shift. The West wants to win India over - despite its grime, it's a nation of gritty people.

> Moreover, unlike Biden, Rishi Sunak, Emmanuel Macron, Olaf Scholz and some others, all of whom belong to the same side, India has always belonged to itself - its long and arduous walk between national interest and high morality is a challenge that it owes to itself. And so, for the moment, as the PM takes the train back from Kyiv, the inescapable conclusion is that Modi's Ukraine visit itself is the message, both to India and the world.

Ram Madhav returns

J&K polls a challenging assignment

IN the last Assembly elections held in Jammu and Kashmir in 2014, the Bharatiya Janata Party won 25 seats, more than double the 11 it got in 2008. With a three-seat lead, Peoples Democratic Party patriarch Mufti Mohammad Sayeed became the Chief Minister, but the man of the moment was Ram Madhav. The RSS's poster boy was credited with the BJP's electoral success and for engineering an alliance with the PDP. Out of favour for nearly five years, Madhav's induction as BJP's election incharge in the UT, along with Union minister G Kishan Reddy, marks an end to his political hiatus. Madhav is back in familiar territory - but with a vastly altered political, geographical and electoral landscape. The abrogation of Article 370, bifurcation of the state into UTs and the delimitation exercise have changed the dynamics. The BJP may fancy its chances with the Jammu division gaining seats in the redrawn electoral map, but the new assignment, and at such short notice,




will test Madhav's skills.Madhav's return is being

attributed to the RSS asserting itself and the BJP being pragmatic. His recent opinion piece, suggesting that the 2024 Lok Sabha election result was a mandate for humility, is a sign of the times. A pushback is apparent against the BJP's perceived brand of politics that reeks of arrogance, with no room for accommodating contrary views. Madhav has a point to prove on a personal level, and his experience in building bridges with the unlikeliest of candidates could come in handy for the party.

J&K has been without an elected government since 2018. The restoration of the democratic process through threephase elections provides an opportunity to all political parties to let people's issues take centre stage. What the UT deserves is a campaign that offers hope.

The road to Viksit Bharat is peppered with challenges



PRIME Minister Narendra Modi's Independence Day speech offered a useful insight into his key goals to take the economy forward. One is to transform agriculture and make it more robust so as to combat the growing unpredictability of monsoon and address climate change. In the manufacturing sector, the aim is to utilise the PLI (production-linked incentive) schemes in order to design in India for the world, thus making the country a global manufacturing hub.

The overall aim of economic development will be to uplift the poor. Significantly, there was no mention in the speech of the sharp disparity between the few who are extremely wealthy and the vast number of people who are poor. In 2022-23, the top 1 per cent of the Indians earned Rs 53 lakh each. In stark contrast, those falling in the bottom 50 per cent earned merely

Rs 75,000 each. Likewise, in 2022, the top 1 per cent pocketed 22.6 per cent of the income, while the bottom 50 per cent managed to get just 15 per cent of it.

Notably, the top 1 per cent controls 40 per cent of the country's total wealth. And the disparity is only growing bigger with time. The richest 1 per cent of India's population currently has the highest concentration of wealth it has had in six decades.

While inequality soars, the economy has a lot going for it. India is the fastest-growing large country in the world, with the economy growing at an average rate of around 8 per cent. Besides, the inflation rate is well within the RBI's range. The Indian stock market is among the most preferred in the world, surpassing the sentiment for the Chinese stock market. The Union Budget has also addressed one of the laggards, consumption, allowing infrastructure spending to take a back seat. So, where do we go from here if the foremost goal is to address the severe inequality, which is underlined by widespread poverty? According to the Asian Development Review (2017),



extreme poverty stood at 18.5 per cent in Bangladesh, while in India, it was 21.6 per cent. In contrast, Sri Lanka recorded just 1.9 per cent poverty. The quickest and surest way to address poverty is to create more jobs, offering people better-paying employment over time. Since rural areas witness a higher level of poverty, the key will be to create more and better jobs there.But we have to sort out a contraction. As agriculture is made more robust, better seeds, pesticides and tillage will be arranged with the help of greater mechanisation. This will modernise agriculture. But the resulting higher output will be delivered through fewer hands. So, even if we raise

farm incomes, what will those rendered jobless do? The workers thrown out of farms will have to find employment in rural services. As rural agricultural incomes grow, there will be a rise in the number of rural roads, TV sets, smartphones, motorbikes and fast-moving consumer goods like soaps and hair oil. These will have to be sold and serviced. In rural areas, more and more people will be engaged in this exercise than in actual farming.

But the rise in rural services will not be able to take care of all the farmhands who are made redundant. A significant number of people will have to move to urban areas in search of employment. We are

witnessing a steady flow of unskilled workers into urban areas, looking for jobs. And they stay wherever they can, resulting in the mushrooming of unplanned urban slums with little or no amenities. One major policy challenge will be to find rural migrants better-paying jobs in the organised sector in urban areas. Over time, the jobs in this sector will enable the workers to afford basic needs and lead a decent life. The migrants from rural areas generally join microbusinesses, which are mostly not incorporated. They function on a day-to-day basis. Inputs are acquired and workers are paid when cash comes in. But if they run out of cash, it could mean the end of the business. And the workers will then have to look for other equally unstable jobs.

For the bottom 50 per cent to earn more, the policy will have to work on several fronts. It would require workers in the informal sector to make more money. But in order to earn more, they must possess basic skills. For that, it is necessary for them to receive a minimum level of education and acquire rudimentary skills. There are some state

and Central schemes, like Ayushman Bharat, that cover one's basic healthcare needs. Plus, efforts are on to provide at least middle-school-level education to all. It seeks to ensure that everyone can master basic language comprehension exercises and do simple arithmetic calculations. Besides, there is a push to

improve the standards of industrial training institutes. The PM has announced the setting up of 75,000 medical seats so that the country can become a global hub for international students. While the plan is welcome, there is a need to first deliver on the basics highlighted above. The PM has outlined his vision to make India a developed nation (Viksit Bharat) by 2047. But for that to happen, steps will have to be taken today.



The accused, suspended constable Praveen, had signed an agreement with the victim, identified as Ankush Sharma, to buy a flat in Greater Noida's in Sector Eta 2 on February 2 through a broker named Sanchit.

"Accused Praveen fixed the deal for Ankush Sharma's flat for Rs 1.18 crore, of which Rs 88 lakh was decided as A payment and Rs 30 lakh as cash B payment. After that, Praveen transferred Rs 51 thousand online to Sharma's account as token money. Praveen transferred Rs 7 lakh in two installments and after seeing Ankush, they

both signed an agreement on March 14", Saad Miya Khan, DCP Greater Noida, said."Later, the process of Transfer Memorandum (TM) started on April 27 and on May 10, the Transfer Memorandum letter was received from the Greater Noida Industrial Development Authority, following which, the deceased went to Canada due to which the registration could not be completed", he added. Manipur Chief Minister to urge Centre to end Suspension of Operation agreement

Imphal. Manipur Chief Minister N Biren Singh has called for the withdrawal of the Suspension of Operation (SoO) agreement with certain militant groups, citing violations of the agreement's ground rules. Speaking at a press conference at the Chief Minister's Durbar Hall in Imphal on Saturday, Biren Singh emphasised that the SoO agreement, initially signed to maintain peace and improve law and order in Manipur, has been compromised by some militant groups who have disrupted peace and tranquillity in the region. The Chief Minister informed that the Manipur Legislative Assembly has resolved to urge the Centre to terminate the SoO agreement with those militant groups that are currently violating the terms amid the ongoing

'Some militant groups under SoO have already violated the ground rules and disrupted peace and tranquillity in Manipur. We are keen to expel these militant groups from the agreement, but no official update has been received from the Centre yet. However, we have received information that the Central government is discussing the matter," Singh said. The SoO agreement, which includes 25 armed Kuki militant groups in Manipur, was initially signed with both the Central Government and the Manipur government in August

Cheetahs at Kuno to be released into wild a year after enclosure stay

New Delhi: After spending a year inside enclosures, the African cheetahs brought to India as part of the world's first intercontinental translocation of the big cats are set to be released into the wild again at Kuno national park. The cheetahs were brought to the enclosures on August 13, 2023 after three adult cheetahs "died due to septicaemia after wounds beneath their dense winter coat on the back and neck regions became infested with maggots" in July. It was a major setback to the translocation project, which began in September 2022. Head of the Cheetah Steering Committee, Dr Rajesh Gopal, told The Indian Express the cheetahs will be released in a phased manner. "I was at the meeting with the National Tiger Conservation Authority (NTCA) officials where we arrived at the decision to release the cheetahs into the wild. This will be undertaken in a phased manner as the monsoons come to an end," he said.

In Madhya Pradesh, the monsoon usually withdraws from most parts by the beginning of October. Currently, there are 25 cheetahs at Kuno — 13 adults and 12 cubs, born at the national park. Under the translocation project, 20 cheetahs were brought to India in two batches — eight from Namibia in September 2022 and 12 from South Africa last February — of which seven have died until this January. The adult cheetahs gave birth to 17 cubs, of which 12 survived.

All the cheetahs are doing well, officials said, adding the animals are able to hunt chitals (spotted deer) inside their enclosures and have been designated "fit for release". Kuno officials will also be sending a compilation of the best practices learnt over the year to the NTCA for further post-release strategies, they said. Giving details of the sequence of the phase-wise release,

Dr Gopal said the coalitions (group that lives together) will be released first followed by individual cheetahs and then, at last, the mothers along with their cubs. The oldest of the cubs is around 8 months old and has begun climbing trees and following its mother on a hunt.

Said Dr Gopal: "The cheetah cubs and their mothers will be released in the last week of December. By this time, the cubs will reach a stage in their life where they will be able to hunt for themselves."The only exceptions could be two elderly cheetahs and an orphaned cub abandoned by its mother. While the old cheetahs are not expected to be released at all, Kuno officials said the cub may not be released until it is "rewilded".

After the male coalitions are released, Dr Gopal said their behaviour will be studied before the others are set into the wild. "We anticipate some unpredictable circumstances may arise. They may not immediately leave their enclosures or strat far away. We will study their behaviour and see if they are able to localise and release the other cheetahs," he said.

Uddhav Sena leader claims new pension scheme's announcement violates code of conduct

Mumbai. Shiv Sena (Uddhav Balasaheb Thackeray) leader Anand Dubey said on Saturday that the BJP-

the MCC.Notably, the Centre announced the UPS on Saturday, through which government employees will get an assured pension, family pension and an assured minimum pension. The new pension scheme will come into force from April 1, 2025.



The BJP-led Centre understood that they needed to bring a pension scheme for 23 lakh government employees. This was a demand by the Opposition as well. However, on the other hand, Assembly elections will be held in four states and Union Territory soon and the polling dates for Haryana and

Jammu and Kashmir have already been announced," Dubey said.

Dubey added that bringing any scheme, although it was being brought for betterment for the employees, after the Code of Conduct was in place, was a breach of the Model Code of Conduct.

The scheme guarantees a pension of 50 per cent of the average basic pay drawn over the last 12

months, provided the employee has completed a minimum of 25 years of service. For those with lesser service, the pension will be proportionate.

CBI raids premises of exprincipal Sanjay Ghosh in RG Kar corruption probe

New Delhi: The CBI on Sunday launched searches at 15 locations, including the premises of former RG Kar Medical College principal Sandip Ghosh, in connection with a corruption case registered by the agency. The action comes a day after the probe agency filed a case alleging financial irregularities at the Kolkata hospital, where a trainee doctor was raped and murdered on August 9. The agency took over the investigation from the special investigation team formed by the West Bengal government, following a directive from the Calcutta High Court. The court had ordered a CBI probe based on a plea by Akhtar Ali, former Deputy Superintendent of the hospital, who alleged financial misconduct during Ghosh's tenure as principal.

The High Court had previously handed over the investigation into the rape and murder of the trainee doctor to the CBI, and it has now also transferred



the corruption probe to the central agency."This Court directs that the investigation be transferred to the CBI, given that the case involved serious allegations and multiple agencies handling different aspects of the case could lead inefficiencies or inconsistency for comprehensive justice, unnecessary delays in the judicial process, and potential misinterpretation of information, thereby undermining effective and credible enforcement. Therefore, the investigation should not be fragmented between different agencies. Handing over the investigation to the CBI ensures consistency," Justice Rajarshi Bharadwaj stated in

The High Court has directed the CBI to submit a progress report on the investigation within three weeks.On Saturday, Sandip Ghosh and four others underwent polygraph tests at CBI's office in Kolkata. A team of polygraph specialists from the Central Forensic Science Laboratory in Delhi were called in to conduct the tests.Besides Ghosh, lie detection tests were conducted on two doctors, an intern and a hospital staffer who were on duty on the night the woman trainee doctor was raped and murdered in a seminar hall at RG Kar.

New Delhi:The CBI is conducting a polygraph test on Sanjoy Roy, the key accused in the rape and murder of a trainee doctor at a Kolkata hospital, sources said on Sunday. Earlier, the polygraph test on Roy was postponed due to technical

issues.On Saturday, CBI conducted lie detection tests on RG Kar Medical College and Hospital's former principal Sandip Ghosh and five others as part of their probe into the case and also CBI PROBES CORRUPTION AT RG registered a case of alleged financial irregularities at the same facility.

The polygraph tests are being conducted on Ghosh and five others, including interns, doctors, and a person connected to Roy. Technical glitches prevented civic volunteer Roy's test from being conducted as scheduled. We will soon decide when to carry out the test," an officer said.A CBI source told PTI that the test on Roy may be held on Sunday at the Presidency Correctional Home, where he is currently lodged. Due to the time-consuming nature of the polygraph tests and the limited availability of devices — only two are currently available — it may take a few more days for the CBI to complete testing all seven persons involved, the source added.On Saturday, the CBI also interrogated over



Passenger vehicle sales stagnate in FY25 amid waning demand, high inventory

NEW DELHI. After three years of blockbuster growth, passenger vehicle (PV) sales have come under pressure in FY25. Due to waning pent-up demand and lack of interest shown by new consumers, dealer showrooms are filled with inventory of unsold vehicles despite steep discounts and promotional schemes.

"PV wholesale volumes grew 3% in Q1FY25 on a YoY basis, but retail volumes fell 7% amid factors like heat conditions, implementation of model code of conduct and the General elections impacting retail footfalls. While the underlying demand drivers remain supportive, ICRA expects domestic PV sales volume growth to fall to 3-6% in FY25 on waning replacement demand and effects of a high base," said Srikumar Krishnamurthy, senior VP & co-Group head - corporate ratings, ICRA.PV industry saw sales of 42.3 lakh units in FY24 as against 38.9 lakh units sold in FY23, up 8.7% YoY. Puneet Gupta, director, S&P Global Mobility, said while the industry is expected to grow in FY25 over a high base, absence of pent-up demand, geopolitical uncertainties and delay in rate cut by the RBI remain concerns. He said to create fresh demand,



OEMs will have to realign consumer-reaching strategy. "For the last 3-4 years, it was a supply-driven market. A lot has changed now. EMIs have gone up, prices have gone up, there is no pent-up demand and inventory at showrooms has piled up. Automakers will have to rethink needs of customers, realign pricing strategy and spend heavily on marketing," said Gupta.

Amid the softening demand, especially for entry-level vehicles, inventory levels at dealer showrooms have risen to 67-72 days in July 2024, as per the Federation of Automobile Dealers Association. Earlier this month, the association said dealers are sitting on 730,000 unsold vehicles. This inventory, whose valuation pegged at Rs 73,000 crore, can meet demand for two

FPIs Inject Rs 11,366 Cr In Debt Market In Aug; Inflow Tally Crosses Rs 1 Lakh Cr For 2024

FPIs pulled out over Rs 16,305 crore from equities so far this month, due to unwinding of the yen carry trade, recession fears in the US and ongoing geopolitical conflicts.

New Delhi. Foreign investors infused Rs 11,366 crore in the Indian debt market so far this month, pushing the net inflow tally in the debt segment to over the Rs 1lakh-crore mark. Foreign investors' strong buying interest in the Indian debt market can be attributed to India's inclusion in JP Morgan's Emerging Market government bond indices in June this year. According to data from the depositories, Foreign Portfolio Investors (FPIs) injected Rs 11,366 crore in the debt market this month (till August 24). This inflow came following a net investment

of Rs 22,363 crore into the Indian debt market in July, Rs 14,955 crore in June and Rs 8,760 crore in May. Before that, they pulled out Rs 10,949 crore in April. With the latest flow, FPIs net investment in debt has reached Rs 1.02 lakh crore in 2024 so far. Market analysts said that ever since the announcement of India's inclusion came in October 2023 year, FPIs have been front-loading their investments in Indian debt markets in anticipation of the inclusion in global bond indices.Even after the inclusion, their inflows have continued to remain robust. On the other hand, FPIs pulled out over Rs 16,305 crore from equities so far this month, due to unwinding of the yen carry trade, recession fears in the US and ongoing geopolitical conflicts. Himanshu Srivastava, Associate Director, Manager Research, Morningstar Investment Research India, said the post-budget announcement of an increase in capital gains tax on equity investments has largely fueled this selling spree.In



addition, FPIs have been cautious because of the high valuations of Indian stocks, coupled with global economic concerns such as rising recession fears in the US amid weak jobs data, uncertainty over the timing of interest rate cuts, and the unwinding of yen carry trade, he added.Overall, India remains in a favourable position, attracting long-term investments from FPIs. "Amidst a global slowdown, the geo-political crisis in the Middle East and neighbouring countries, India still stands at a sweet spot compelling the foreign fraternity to take a

bet for a long-term investment horizon," Manoj Purohit, Partner & Leader, Financial Services Tax, Tax & Regulatory Services, BDO India, said. In terms of sectors, FPIs were big sellers in financials in India in the first fortnight of August. Vipul Bhowar, Director of Listed Investments, Waterfield Advisors, said that FPIs are selling banking shares due to concerns over slow deposit growth.

'There are also challenges in Q1FY25 for banks with shrinking margins, deteriorating asset quality, and rising provisions, especially in credit cards, personal loans, and agriculture portfolios," he said. Besides, selling was witnessed in many other sectors including metals on fears that the economic slowdown in the US and China will keep metal prices soft, V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said. Conversely, foreign investors were buyers in telecom and health care where the growth and earnings prospects are safe and bright, he added.

Commerce Minister Piyush criticises E-commerce giants for predatory pricing practices

New Delhi. Union Commerce and industry minister Piyush Goyal has stirred up the pot by letting go a broadside against Amazon and other ecommerce players. Attacking these eretailers for 'predatory pricing', Goyal alleged they were slowly killing the vast network of small, mom-and-pop shops through unfair competition. He also suggested Amazon was passing off fund infusions to cover Rs 6,000 crore of losses by disguising them as investments.

If you make Rs 6,000 crore loss in one year, does it not smell of predatory pricing?" he asked, claiming many e-tailers were violating foreign direct invest (FDI) laws.

industry should be complaining of the bad ways of the big e-tailers! Traders through their apex body – the Confederation of All India Traders (CAIT) – have been begging the government for years to take action against predatory pricing. To no avail!

It is ironical that Goyal was speaking at an event where a think tank, Pahle Foundation, released a report that showed ecommerce was still small play in India, and that in fact retailers had benefited hugely from combining brick-and-mortar stores with ecommerce sales. As per the report, while ecommerce is indeed growing at a fast pace, it comprised only 7.8% of total retail sales in 2022. The report estimated that there were 1.76 million online vendors, who had added 16 million jobs, including 3.5 million for women. It report also said 60% of small city vendors had reported increased sales since they had started selling online.Loopholes in the lawComing to 'predatory pricing'...

For years, small retailers have been complaining ecommerce operatives like Amazon and Walmartacquired Flipkart have been pricing goods below cost of production as a strategy to kill competition. While they incur a loss in the short term, once competitors have shut shop, the big retailers acquire a monopoly, and fix prices to the detriment of millions of consumers.Free competition is the life blood of a market economy. Section 4 of the Competition Act, 2002 forbids 'unfair or discriminatory' pricing, by the abuse of a 'dominant position'. To ensure fair competition and to weed out monopolies and trusts, the Act has set up a regulator – the Competition Commission of India (CCI) mandated to act against monopolies.

Economists predict diverging growth rates for India's June guarter, range from 6% to 7%

MUMBAI. Ahead of the official release of June quarter growth numbers next week, economists have offered differing forecasts, with rating agency Icra pegging the lowest at 6% and German brokerage Duestche Bank at the highest at 7% and Goldman Sachs seeing growth moderating to 6.6% on account of lower government capex and tepid consumption demand.

Thus far, the RBI's forecast of 7.1% is the highest but that is 20 bps lower than its June estimate. Icra cheif economist Aditi Nayar forecasting for the six quarter low growth of 6% attributed the same to the reduction in government capex and a fall in urban consumer demand. For the full fiscal year 2025, she expects the economy clipping at 6.8%, down from 8.2% in the previous fiscal. Official growth data for the June

quarter will be released by the Ministry of Statistics and Programme Implementation on August 30. In the first quarter, the economy grew at 8.2%. Nayar noted several contributing factors for the projected moderation in the June quarter such as temporary lull in various sectors due to the parliamentary elections and sluggish government capital expenditure at both central and state levels. "Lower volume growth combined with diminishing gains from commodity prices weighed upon the profitability of some industrial sectors. The heat wave also affected footfalls in service sectors. even as it provided a major boost to electricity demand. On balance, we foresee a transient moderation in gross value added (GVA) and GDP growth in Q1 to 5.7% and 6%, respectively."

eanwhile, Goldman Sachs has lowered its growth forecast by 80 bps to 6.6% for Q1 on fiscal drag and retail credit slowdown."We lower growth estimate for Q1, reflecting fall in government capex (-35% YoY) in the election quarter, and a slight fall in urban demand, partly offset by nascent recovery in rural consumption."

'As a result of these, we lower full-year growth forecast by 20 bps to 6.7%. We cut FY26 forecast by 20 bps to 6.4% as we expect a fiscal drag from Q1 of next fiscal given fiscal consolidation target at sub-4.5%," economists of the brokerage said. Easier monetary policy

She became the first ever Indian athlete since independence to win two medals in a single edition of the games. Naseem Shah slams PCB over Rawalpindi pitch: 'Thought pacers will get help'

New Delhi. Pakistan vs Bangladesh's first Test match at Rawalpindi is heading towards a draw. After four days of cricket being played, a total of 1036 runs have been scored with the loss of 17 wickets. Pakistan have just come out to bat for the second time in the match, and trail Bangladesh (565-allout) by 93 runs with 9 wickets in hand. The docile nature of the pitch has frustrated Pakistan fast bowler Naseem Shah, who has slammed the board for not preparing wickets that either help the fast bowlers or the spinners. The Rawalpindi pitch had plenty of grass cover on it, and was expected to help the pacers in the first Test. The first day of the Test match did help the pacers due to the cloud cover but it slowly waned away once the sun came out. A frustrated Naseem

spoke in the press conference after Day 4 of the Test and said that he did not get any help from the pitch."I'm playing a Test after more than a year and took me time to find my rhythm. The kind of weather we have right now, it's extremely hot, and we didn't get the kind of help from the surface as a bowling unit as we expected," Naseem Shah said after Day 4 of the first Test.

"If we're incapable of making the sort of PAK vs BAN, 1st Test, Day 4: Report pitches that help fast bowlers, then we should look at whether we can produce spin wickets. However you do it, you need to use home advantage," he added.

he Test matches in Pakistan have been drab affairs in the recent past with bowlers solely relying on reverse swing to grab wickets.

This comes in stark contrast to other pitches across the world, who have made either sporting wickets or have handed the advantage to the bowlers."People come to enjoy Test cricket in this heat, so you need to entertain them. What shouldn't happen is you're on the field at home and thinking this is hard work. The more you keep cricket entertaining, the better. It's something we need to seriously think about," Naseem said.

"We believed the fast bowlers would get plenty of help here. But what we were expecting didn't exactly happen. With four fast bowlers, your mindset is to take wickets with the quick balls. However, I don't think it'll spin either, because there's grass on the pitch. But the pitch is very dry underneath.

Rohit Sharma trains hard with Abhishek Nayar ahead of packed Test season

New Delhi India captain Rohit Sharma was spotted engaging in an intense training session with assistant coach Abhishek Nayar ahead of upcoming packed Test season. Notably, India are all set to play two-match Test series against Bangladesh from September 19.

The Rohit Sharma-led side will further play three Tests against New Zealand at home in October followed by a five-match Test series against Australia beginning in November. Ahead of the season, India captain is preparing himself through rigorous training sessions. A video of the India captain training with Abhishek Nayar has been going viral on social media. In the video, Rohit can be seen training in a park under the supervision of Nayar.The India skipper is the secondhighest run-scorer from his team in the ongoing World Test Championship (WTC) cycle 2023-25. The opening batter has amassed 700 runs from nine matches at an



average of 46.66 with three hundreds and as many fifties. India are currently on the top of the WTC points table with six wins from nine matches along with a draw and have a

points percentage of 68.51%. Australia are ranked second with eight wins from 12 matches and one draw having points percentage of 62.50%.India to take on

Australia in five-match Test seriesThe two teams are once again favourites to reach the final having met in the summit clash of the last cycle as well. Australia beat India by 209 runs in the final held at the Oval to become the first nation to have all the major ICC trophies in their cabinet.

However, ahead of the final, the two teams will clash in the highly anticipated Border Gavaskar Trophy set to begin from November 22. India have retained the trophy since 2017 having won the last four series over the current World Test Champions.

They also beat them in Australia in back-toback series held in 2018-19 and 2020-21 further adding the spice for the upcoming edition. It will be the first time that the two teams will be contesting in a five-match series since 1991-92. Hence, fans are eagerly waiting for it to get underway as captain Rohit Sharma aims to help India reach their third consecutive WTC final.

So, we have works like Vishnudharmottara Purana saying Krishna Ashtami is in the Bhadrapada month and Skanda Purana stating that it falls in the month of Shravana) in the Hindu calendar. Rasa lila, dramatic enactments of the life of Krishna, are a special feature in regions of Mathura and Vrindavan, and regions following Vaishnavism in Manipur.[2] While the Rasa lila re-creates the flirtatious aspects of Krishna's youthful days, the Dahi Handi celebrate God's playful and mischievous side, where teams of young men form human towers to reach a high-hanging pot of butter and break it. This tradition, also known as uriadi, is a major event in Tamil Nadu on Gokulashtami.

Krishna was the 8th son of Devaki and Vasudeva. Based on scriptural details and astrological calculations the date of Krishna's birth, known as Janmashtami,[3] is 19 July 3228 BCE and departed on 3102 BCE. Krishna belonged to the Vrishni clan of Yadavas from Mathura, [4] and



was the eighth son born to the princess Devaki, and her husband Vasudeva. Mathura (in present day Mathura district, Uttar Pradesh) was the capital of the Yadavas, to which Krishna's parents Vasudeva and Devaki belonged. King Kansa, Devaki's brother,[5] had ascended the throne by imprisoning his father, King Ugrasena. Afraid of a prophecy that predicted his death at the hands of Devaki's eighth son, Kansa had the couple locked into a prison cell. After Kansa killed the first six children, and Devaki's apparent miscarriage of the seventh (which was actually a secret transfer of the infant to Rohini as Balarama), Krishna was born.

After his birth Vishnu ordered Vasudeva to take Krishna to Gokul to Nanda and Yashoda where he can live safely,away from his evil Uncle Kansa.So Vasudeva took Krishna with

Some temples also conduct reading of the Hindu religious scripture Bhagavad Gita.[6]

Janmashtami Celebrations Manipur

Janmaashtami - popularly known in Manipur as Krishna Janma - is a significant festival celebrated at two temples in Imphal, the capital city of Manipur. The first festival is at the Govindaji temple, and the second is at the International Society for Krishna Consciousness temple. Devotees of Lord Krishna gather mostly at the ISKCON temple.

Places in Uttar Pradesh that are associated with Krishna's childhood, such as Mathura, Gokul and Vrindavan, attract visitors from all over India, who go there to participate in the festival celebrations.[8] People in the city of Dwarka in Gujarat where Krishna is believed to have established his Kingdom - celebrate from the 10th Skandha. Eighty percent of the population of Nepal identify themselves as Hindus and celebrate Krishna Janmashtimi. They observe Janmashtami by fasting until midnight. They chant Slokas from the Bhagavad Gita and sing religious songs called bhajans. The temples of Lord Krishna are decorated, and bhajans and kirtans are sung or played. The Krishna Mandir in Patan Durbar Square, Narayanhiti Krishnamandir, and other temples of Lord Krishna are the centers for festivities on Krishna Janmaasthimi. Numerous devotees flock to the ancient Krishna temple in old Patan Durbar Square to keep vigil through the revered night of his birth. Observances include people sitting closely together, bodies rocking as women chant the many names of Lord Krisha, such as Narayan, Narayan and Gopal, Gopal. Some sing hymns, others clap their hands, while some others pray. Crowds of men and women edge their way slowly up narrow steps through the seated devotees to the temple's dark interior, to where the main idol stands. There they offer flowers, coins and food, and wait for a glimpse of the Krishna Janmashtami idol. After the temple priest gives them prasad, they make their way home.[citation needed]

The procession dates back to 1902, but was stopped in 1948 following the establishment of Pakistan and subsequent attacks by Muslim mobs in Dhaka. The procession was resumed in 1989.[12]

They disseminate the thoughts of Bhagavad Gita through street plays around the week of Janmashtami.
