

New Delhi, August 26: Home Minister Amit Shah said the government would put an end to the drug trade by establishing offices of the Narcotics Control Bureau (NCB) in every state with the cooperation of the state governments. Speaking on the occasion of the virtual inauguration of NCB's zonal office at Raipur, Chhattisgarh, Shah said the office would play an important role in controlling narcotics not only in the state but the entire region. He said illicit trafficking of narcotics in India severely impaired the national security, observing that the money earned from illicit drug trade promoted terrorism and left-wing extremism and weakened the country's economy. Shah also chaired a review meeting on the narcotics scenario in Chhattisgarh that was attended by state Chief Minister Vishnudev Sai, Union Home Secretary Govind Mohan as well as the Directors of Intelligence Bureau and NCB, the Chief Secretary of Chhattisgarh and the Director General of Police. The Union Home Minister said the trend of drug trafficking was changing and was moving from natural to synthetic drugs.

'Batenge toh katenge': Yogi Adityanath asks people to stay united

Agra, August 26: Uttar Pradesh Chief Minister Yogi Adityanath here on Monday urged people to stay united to reach the pinnacle of prosperity, saying the mistakes in Bangladesh should not happen in India. "Batenge toh katenge (if divided, we will be cut)," he said dur-



ing an inauguration event in Agra. Bangladesh recently saw massive anti-government protests, leading to the ouster of prime minister Sheikh Hasina. The country continued to witness incidents of violence, including targeted attacks on the Hindu minority community, even after the fall of the Hasina-led government. Addressing the gathering at the programme here, Adityanath said, "There can be nothing bigger than the nation, and when will a nation be strong, when we are united and good." "Aap dekh rahe hain Bangladesh mein kya ho raha hai? Wo galatiyan yahan nahi honi chahiye. Batenge toh katenge! Ek rahenge to nek rahenge, surakshit rahenge aur samriddhi ki parakashtha ko pahuchenge," the chief minister said in Hindi. Roughly translated, he asked people if they are watching what is happening in Bangladesh and said those mistakes should not happen here, adding, "If divided, we will be cut, if together, we will be good, secure and reach the pinnacle of prosperity." The chief minister also shared a clip of his speech on X. "We have to realise the resolve of Viksit Bharat (developed India)," Adityanath said after inaugurating a statue of Durga Dass Rathore near the Taj Mahal metro station here. Rathore was a commander in the army of erstwhile Jodhpur province's king Maharaja Jaswant Singh who took on Mughal ruler Aurangzeb in the 17th century.

#### Kangana Ranaut not authorised to make statements on party'spolicy New Delhi, August 26: The BJP on

Monday expressed disagreement with its MP Kangana Ranaut's controversial remarks on the farmers' protest and said she has been directed not to make such remarks. This came after Ranaut stoked a controversy by suggesting that the farmers' protests could have led to a Bangladesh-like situation in the country if the top leadership was not strong enough. In a video shared by the Mandi MP on X, she alleged that "bodies were hanging and rapes were taking place" during the farmers' protest against the now-repealed three farm laws. "The statement made by BJP MP Kangana Ranaut in the context of the farmers' movement is not the opinion of the party. The Bharatiya Janata Party expresses its disagreement with the statement made by Kangana Ranaut," the BJP said in a statement. On behalf of the BJP, Ranaut is neither permitted nor authorised to make statements on the party's policy issues, it said. "On behalf of the Bharatiya Janata Party, Kangana Ranaut has been directed not to make any such statements in future," the statement said. "The Bharatiya Janata Party is committed to following the principles of 'Sabka Saath, Sabka Vikas, Sabka Vishwas and Sabka Prayas' and social harmony." it added.

Ranchi, August 26: Union minister Chirag Paswan was on Sunday re-elected as Lok Janshakti Party (Ram Vilas) president for five years at its national executive meeting here. The decision was taken unanimously at the meeting, Paswan said. "The national executive, in its meeting here, has re-elected me for the next five years," he said. Paswan, the Minister of Food Processing Industries, said the upcoming assembly elections in Haryana, Jammu Kashmir and Jharkhand were also discussed in the meeting. In Jharkhand, the party may contest the polls either with national alliance partner BJP or on its own, he said. "We have taken suggestions from the state units whether they want to contest the elections in alliance or alone in states where our organisation is strong ... At the national level, we have an alliance with the BIP and we are a strong coalition partner of the NDA. "In the 2014 elections, we had a tie-up with the BJP for vidhansabha polls in Jharkhand and contested the Shikaripara seat. If there is a respectable seat-sharing, we may go with an alliance or else we can go alone in the polls," Paswan said. Assembly polls are due in Jharkhand later this year. He also pitched for a nationwide caste census, but cautioned against making the figures public as it will create a "rift" in society. "We have always emphasised that we want the caste census to be conducted.

BJP-DMK enacting 'drama' of rivalry, maintaining discreet ties: AIADMK chief

New Delhi, 26 August: AIADMK general secretary and Tamil Nadu Leader of Opposition, Edappadi K Palaniswami on Sunday alleged the BJP

Kolkata, August 26: The Central Bureau of Investigation (CBI) has named Sandip Ghosh, former principal of RG Kar Medical College and Hospital, in the FIR the agency has filed in connection with its probe into the alleged financial irregularities at the institution during his tenure. The cases read together account for cognisable offences and are non-bailable in nature, a senior Calcutta High Court lawyer said. In his plea before the high court, Ali accused Ghosh of illegal sale of unclaimed corpses, trafficking of biomedical waste and passing tenders against the commission paid by medicine and medical equipment suppliers.

#### Mahadev betting app 'scam' involving Ex-CM

Raipur, August 26: The Chhattisgarh Government has decided to transfer cases related to the alleged Mahadev betting app scam to the Central Bureau of Investigation (CBI), Deputy Chief Minister Vijav Sharma said on Monday. The government issued a notification approving the CBI probe last week, he said. The alleged scam became the focal point of the BJP's campaign during the Lok Sabha elections in Chhattisgarh as prominent accused named in the FIR included former Chief Minister and senior Congress leader Bhupesh Baghel, among others. Notably,



the Enforcement Directorate (ED) has been probing money laundering cases linked to the Mahadev app scam, which came to light when the Baghel-led Congress government was in power, for more than a year. "70 cases related to the alleged Mahadev app scam were lodged at different police stations in Chhattisgarh and one case is being probed by the Economic Offences Wing (EOW). We have decided to hand over all these cases to the CBI and a notification has been issued," Sharma told reporters. The issue (Mahadev betting app scam) was a multistate matter, not restricted to Chhattisgarh, he said, adding that some kingpins were based in foreign countries. The CBI will seriously investigate the matter. "No leniency will be shown and strict action will be taken. I believe (accused persons) based abroad will be brought back,' he said. The notification issued by the Chhattisgarh's Home Department dated August 22 stated platforms. The cases were registered under Sections 420, 467, 468, 471, 201, and 120 of the Indian Penal Code (IPC) and Sections 7 and 7-A of the Prevention of Corruption Act 1958 (amended in 2018), Sections 4, 7, 8, and 11 of the Gambling Act, 1867 (amended to the Public Gambling MP Amendment Act, 1976) in police stations ACB/EOW of Raipur district, it stated.

## Chief secys of Haryana, Himachal, 15 other states to appear before SC today

New Delhi, August 26: The chief secretaries and finance secretaries of 17 states and union territories, including those of Haryana and Himachal Pradesh, will appear in person on Tuesday before the Supreme Court for failing to clear the arrears of revised salary and pension of judicial officers in terms of the Second National Judicial Pay Commission's recommendations. A three-judge Bench led by CJI DY Chandrachud on August 22 ordered them to personally appear before it to explain the non-implementation of SNJPC's recommendations after amicus curiae K Paramesha submitted that as per the responses received from the States/UTs, 17 states/UTs have still not complied with its various orders, including those passed last month. Besides Haryana, Himachal Pradesh, the states and UTs whose chief secretaries and finance secretaries will appear before the court are: Tamil Nadu, Madhya Pradesh, Andhra Pradesh, West Bengal, Chhattisgarh, Delhi, Assam, Nagaland, Meghalaya, Jammu & Kashmir, Ladakh, Jharkhand, Kerala, Bihar

#### News box Fruit flies from Dharwad to fly to space!

DHARWAD: Fruit flies from Dharwad are flying to space! The flies, with the scientific name Drosophila melanogaster, will be used in an experiment in space during the Gaganyaan manned mission, which is scheduled for next year. The flies have been developed by the Department of Biotechnology at the University of Agricultural Sciences (UAS), Dharwad.

It may sound strange, but fruit flies share about 77% of genes that cause diseases in humans. The flies are crucial to study the formation of kidney stones among astronauts in space.Kidney stones are a common health issue among astronauts. Reports indicate that kidney stones have been observed in astronauts over 30 times during space missions. They experience an increased risk of kidney stone formation because of elevated calcium excretion from bone loss, increased urine acidity, consumption of dehydrated food, reduced urine output and other factors."Fruit flies are important to better understand how the molecular mechanisms work when kidney stones are formed among humans in space. The experiment will help come up with improved treatments, particularly for Indian astronauts," said Ravi Kumar Hosmani, Assistant Professor at the UAS Biotechnology Department.

#### Inspired by Krishna, Arjuna: Telangana CM on HYDRAA demolitions

HYDERABAD: Stating categorically that he would not succumb to pressure and will continue to take strict action against the illegal structures constructed in the full tank level (FTL) of lakes, Chief Minister A Revanth Reddy said he took inspiration from the Bhagavad Gita to demolish illegal constructions.Addressing a gathering after laying the foundation stone for the Hare Krishna Heritage Tower in Kokapet on Sunday, the CM noted that the government was firm on its resolve to remove encroachments on lakes and government lands. He said that several rich individuals constructed structures within the FTL and diverted the drainage water to Gandipet and other lakes which supply drinking water to Hyderabad. "If I do not take any action, it will be construed that I have failed as a people's representative. That is why I formed HYDRAA and took action despite several pressures," he said. Speaking about the Gita, the chief minister said that during the Kurukshetra war, Arjuna dropped his weapons and refused to fight in the battle as he was unwilling to kill his brethren for the sake of ruling the kingdom.At that time, Krishna encouraged Arjuna to participate in the battle to protect Dharma, he added. "Krishna and Arjuna protected Dharma, which protected us later. Taking inspiration from the Gita, I am demolishing the illegal structures to protect natural resources," he said.e noted that Nizams developed Hyderabad as a city of lakes. "Some farmhouses have been built near those lakes and ponds which quenched the thirst of crores of people," he added, pointing out that waste water from farmhouses is being discharged into Gandipet lake and Himayatsagar, which provide drinking water to Hyderabad.

KOCHI: Emboldened by the release of the Hema Committee report that has shed light on the sexual harassments and misbehaviours that women in Malayalam film industry faced over the years, several women are speaking up against sexual assault and harassment they faced in the past. This is slowly developing like the #MeToo movement in Artist Revathy Sampath and some Hollywood in 2017 triggered by allegations against Harvey Weinstein, the powerful producer and cofounder of MiraMax Films. The revelations of Bengali actor Sreelekha Mitra and Malayalam actor Revathy Sampath led to the resignation of two heavyweights in the Malayalam film industry --Kerala Chalachitra Academy chairman Ranjith and AMMA

general secretary T Siddique -- on Sunday. Now, more women, including Divya Gopinath, Sonia Malhar, and Tess Jose, have come out against people in the industry. Artists and activists believe the incidents would encourage many others to speak up and help create a better work atmosphere for everyone in the industry.

others revealed their experiences years before through social media, pointed out social activist Mala Parvati. "But they were isolated by industry and society. As the Hema Committee report is released, there is an increased awareness and survivors are receiving positive responses from the media and public. The public too has realised that these

These women are supported by some men who have a progressive mentality as well," she said, adding that it is an outcome of the efforts of the Women in Cinema Collective (WCC), the survivor, and the release of the Hema Committee report.

### **Passenger ship service from Kerala** to Dubai may start by January 2025

KOCHI: As the soaring airfares on the Kerala - Gulf sector during festive season trigger a debate on alternative travel options, the Kerala Maritime Board (KMB) is offering a glimmer of hope to Keralites working in West Asian countries. The proposal to launch a passenger ship service connecting Kochi and Dubai is in an advanced stage and the KMB is hopeful of introducing the service as a new year gift to the NRKs.KMB chairman N S Pillai said that two operators who attended a meeting with the Shipping Corporation of India(SCI) were in the process of identifying the vessels and once they submitted the documents, they would be granted a licence in four days. "Once the licence is granted, they can complete the preparations and launch the service within



three months," he told the TNIE. "Two business groups have come forward to operate the service and we had a meeting with SCI officials two weeks ago. Both the firms do not possess vessels and they have been asked to charter vessels and submit applications to the Director General of Shipping. We have been told the licence will be issued within four days once the

documentation is over. Then, the operators have to identify travel agencies and complete preparations at the port. It will take three months to launch the service after securing the licence," said Pillai. The two companies which have evinced interest in the service are Chennai-based White Shipping and Jabal Ventures, Kozhikode. The biggest challenge is to identify and charter passenger vessels with a capacity to carry 600 to 700 people. Once the operators get the vessel, the proceedings

will be expedited. The operators have to submit an application to DG Shipping with details of the vessel, passenger capacity and other specifications.As per information, one of the operators had identified a cruise ship with a capacity to carry 600 passengers.

#### HYDRAA razed 166 structures in 58 days



HYDERABAD: The Hyderabad Disaster Response and Asset Monitoring and Protection Agency (HYDRAA) is using its full force to remove encroachments on lakes and government lands. Within 58 days since its inception, the HYDRAA has removed 166 encroachments and reclaimed 43.94 acres from lakes, parks and nalas. On Sunday, the HYDRAA submitted its report to the government detailing the encroachments removed and extent of land recovered so far. As per the report, the structures demolished by the HYDRAA belonged to senior Congress leader and former Union minister MM Pallam Raju's brother, MLAs and MLCs from AIMIM and BRS.

The agency started its first demolition on June 26 in Film Nagar Co-Operative Society and recovered 0.16 acres. A businessman, Gokul Narne, had encroached a part of the Lotus Pond park and built a compound wall, the report revealed.On August 18, as many as 24 encroachments were dismantled in Gandipet lake (Osman Sagar) at Khanapur and Chilkur villages and 15.25 acres of land were recovered.

The agency demolished two buildings, a compound wall and 11 temporary sheds in the extent of 8.75 acres at Khanapur. Similarly, at Chilkur, six buildings and three compound walls in the extent of 6.5 acres were dismantled.One of the demolished structures built on the encroached Gandipet lake land was ORO Sports Village belonging to Pallam Raju's brother Pallam Anand, while three others were built by former TDP member GV Bhasker Rao of Kaveri Seeds, BJP leader Sunil Reddy and Anupama, wife of Pro Kabaddi team owner Srinivas Rao.

### Only two Great Indian bustards seen in Karnataka

#### Six months ago, there were six birds in Siruguppa and today, there are just two.

BALLARI: With just two individuals of Great Indian Bustard birds being sighted in the last six months in Ballari district, the state forest department is planning some urgent measures to safeguard the last remaining population of these majestic birds. Around 14 sqkm of land in Siruguppa taluk of Ballari district, which has been declared the GIB sanctuary, now serves as the last remaining habitat of these birds in Karnataka. Six months ago, there were six birds in Siruguppa and today, there are just to.

Desperate measures planned by the forest department include GPS-tagging of the birds, artificial hatching of eggs, introducing young birds to the forest, involving local communities and setting up a research centre in Siruguppa. The Ballari division of the forest department has requested the state

government to allow GPS tagging of the two individuals (one male and one female) sighted in Siruguppa and surroundings. The forest division has already set up CCTV cameras to constantly monitor the movement of the birds a long the Karnataka-Andhra Pradesh border.

#### Less than 200 GIBs in the wild today

"Today, less than 200 GIBs exist in the wild in India. While the majority of them are breeding in Rajasthan, few individuals can be sighted in Gujarat, Maharashtra, Andhra Pradesh and Karnataka. Karnataka has the least number of birds. Till two decades ago, they were found in five districts of Karnataka. But now they are restricted just to Siruguppa.ix months ago, we had counted six birds. It's possible that the remaining four could have migrated to Andhra Pradesh. It's



important to monitor their flight preferences and habitats in Siruguppa. We have requested the government to give permission to GPS-tag these birds," said a senior forest official. The state government has agreed to release Rs 24 crore for GIB conservation. Of that, Rs 6 crore has been allocated in the first phase under the District Mineral Funds and

Kalyana Karnataka Regional Development Funds to take up the construction of GIB Research Centre in Siruguppa and conduct experiments like GPS tagging and artificial breeding of GIBs.

An expert team led by Ballari Deputy Conservator of Forests Sandip Suryavanshi visited the Desert National Park in Rajasthan recently to study the possibility of saving the last batch of GIBs in Karnataka. Experts from Dehradun are expected to work closely with the Karnataka forest department."We have involved the local communities, farmers and schoolchildren in Ballari district to bring about awareness. Our constant efforts have brought down poaching of these birds," he added.



#### 22-year-old woman dies in hit-&-run crash on KMP Expressway, Haryana

GURGAON: A 22-year-old woman from Jhajjar, who had come to Farrukhnagar with a neighbour on Sunday morning, died when she was hit by a van on the KMP Expressway.She was standing on the Farrukhnagar-Badli side of the expressway around 6am while trying to hitch a ride to Badli. A case was registered against the unknown driver by police on the complaint of the woman's neighbour. The van driver is absconding

Seema from Kosli Road in Quila Colony, of Jhajjar, arrived at the Farrukhnagar KMP toll plaza junction around 5am on Sunday with her neighbour Mukesh (50) for some personal work. Subsequently, the two women went to Farrukhnagar-Wazirpur Road. "From there, they climbed onto the Expressway. As they were standing on the Farrukhnagar-Badli side of the expressway, a van hit Seema," Farrukhnagar ASI Rajesh Kumar said.Mukesh, who was standing next to Seema at the time of the incident, immediately sought help from passersby and informed the staff at the nearby KMP Farrukhnagar toll plaza. "Seema suffered a severe head injury and began bleeding profusely from her ears. I only remember that it was a red van that hit her. The accident was caused by reckless driving," she said. The ASI said alerted by the toll staff, they reached the accident spot and shifted the victim to a govt hospital where she was declared dead. "We are verifying the CCTV footage at the toll plaza to identify the accused," the said.

#### Gurgaon: Man tries to jump off Dwarka Expressway, cops come to his rescue

GURGAON.Police, emergency services, NHAI staff and bystanders on Sunday rescued a man from the brink of death by pulling him off the railing of Dwarka Expressway as he threatened to jump onto traffic on NH-8 below. The man, who lives in Noida's Sector 50 and works for a private company, was inebriated at the time and was struggling with some personal problems.Cops said the incident was reported in the early hours of Sunday.A bystander called on the emergency helpline 112 and told authorities that a man was sitting on the noise barrier railing of the expressway at the NH-8 crossing near Kherki Daula. The expressway's elevation is around 6 metres from the highway. An emergency response vehicle, head constable Raju, constable Pradeep and special police officer Radheshyam reached the spot within minutes.Constable Pradeep said that bystanders and NHAI staff tried to engage with the man while emergency staffers and cops grabbed him from behind and brought him off the railing to the expressway."At the time of the incident, the man, identified as a native of Turra Mahoba village in UP, was under the influence of liquor and attempted suicide due to personal problems," a Gurgaon police spokesperson said.After the rescue, he was counselled, and his family members were called to take him home.No case was registered, police said.

Earlier this month, a woman attempted to jump off the Atal Setu in Mumbai and was saved by a car driver and traffic cops who pulled her to safety just as she was hanging off the sea bridge. The dramatic rescue was caught on CCTV camera.

## Haryana forest department to tranquilise and relocate Sariska tiger straying in Rewari

GURGAON: Sariska tiger ST-2303, which wandered into Jhabua forests in Rewari over a week ago, will be tranquilised and safely relocated in two-three days, according to the Haryana forest department. The patrolling team, which is tracking the tiger's movement, has strategically set up live baits in the dense forest.On Sunday, forest officials reassured nearby villagers that they are working to expedite the relocation process.AP Pandey, additional principal chief conservator of forests in south Haryana, told TOI, "There are approximately 12 villages around the dense forest, six in Haryana and the rest in Rajasthan. We engaged with the villagers and assured them that all necessary measures are being implemented to relocate the tiger safely. Also, we will ensure that no man-animal conflict occurs during



the process. We anticipate that the tiger might hunt within two to three days. We have carefully placed baits with cages. Our plan is to tranquilise it when it approaches the bait. After conducting a thorough analysis of the situation, we believe tranquilising it is the most effective option at present."When enquired about the decision not to tranquilise the tiger in the core area, the official said the dense and impenetrable nature of the forest could pose significant challenges for the

successful revival of the tiger after tranquilisation.

The area where the tiger is currently resting lacks navigable paths for vehicles, making it tough to relocate it from the dense forest. Also, if the tiger were to wander off after being hit by the tranquilising dart, locating and initiating the shifting process would be equally challenging," he further said. The forest is not a single continuous patch and consists of two distinct areas - the tiger's previous habitat and its current location.

Meanwhile, fresh pugmarks of the tiger were discovered near waterholes by the forest department, indicating that the feline is faring well. "We have spotted fresh pugmarks of the tiger near a water hole, and we believe it is doing well thus far," Rewari divisional forest officer Deepak Patil said.

### Gurgaon: Road revamp held up due to model code, patchwork washed away by rain

**GURGAON.** Three years ago, patches were dug up in Sector 23A to install new pipelines, but the roads were never fully repaired afterward. The contractor responsible for fixing the roads after laying down the pipelines failed to do so, residents said on Sunday.MCG initiated the tender process last year and handed over the work to an agency in October 2023. The contract, estimated at Rs 1.06 crore, included laying down internal roads of widths 10m, 12m, 15m, and 18m. However, the work never started.After repeated warnings, MCG eventually blacklisted the agency in July this year and re-invited bids to complete the roadwork. But no agency came forward, leaving residents stuck with deteriorating roads that have only worsened after the rains."We fail to understand why no agency wants to carry out roadwork in

Sector 23A. We have been waiting since October 2023 for roads to be recarpeted, but now they are citing the model code of conduct. Even at the level of joint commissioner, there is no



progress in the plan. MCG clearly lacks the intent to address civic grievances professionally," said Bhawani Shankar Tripathy, general secretary of Sector 23A RWA.With backlash mounting, MCG attempted a quick fix by filling potholes using a granular base earlier this month. However, this temporary solution proved ineffective, as the latest bout of rainfall destroyed the patchwork."Now they have done pothole filling, but even light rain washes away their so-called fixes. It's like living in a neglected corner of the city. Despite raising the matter with MCG repeatedly, nothing has been done," said Rohit Yadav, RWA president.When contacted, MCG executive engineer Manoj Kumar said, "After blacklisting the contractor, we floated the tender twice, but no agency has shown interest. Now, the process is held up due to the model code of conduct (MCC), and we will resume it once the code is lifted. In the meantime, we are maintaining the roads through patchwork repairs and will fill potholes again if the problem persists.'

#### **Gurgaon: Contract given in** April, drains not cleaned yet, sewage flows on to road

GURGAON: Sewer lines have been overflowing on streets near Delhi Public School and a community centre in Sector 45 for weeks, and the situation worsens after rains, leading to waterlogging with sewage, residents said on Sunday. They mentioned that stagnant water and sewage in those areas have become breeding grounds for mosquitoes. School students and nearby residents have to endure the stench, they added.

The stench is unbearable, and it has been like this for weeks. We have complained to the authorities multiple times, but nothing has been done. It feels like we are living in a slum, not a sector," a resident living near DPS said.In April this year, the MCG awarded a Rs 65 lakh contract for desilting sewer lines in the area using a bucket machine, but no work has been done on the ground. Residents noted that neither the bucket machine nor the super-sucker machine was used to clean the sewer lines, leading to the accumulation of waste and sewage overflows.





#### **Chinese army conducts** armed patrols near Myanmar border to 'maintain security'

World China's military said on Monday it had organised army units and joint air-ground police patrols near the Myanmar border to maintain security and stability as fighting between Myanmar's ruling junta and rebel forces escalates. The patrols will focus on Ruili, Zhenkang and other frontline areas, the military said in a statement. The Southern Theater of the Chinese People's Liberation Army organised army units to test troops' ability to "quickly move, block and control, and strike together, and maintain security and stability in the border areas," the military said. China had said it planned more drills near the Myanmar border as fighting between Myanmar's junta and rebels resulted in artillery shells injuring people and damaging structures in Chinese territory.China has said the conflict was having a negative effect on stability and social order on the China-Myanmar border. Chinese foreign minister Wang Yi also said recently that China would continue "its commitment to restore peace and stability in Myanmar."

#### British safety adviser for Reuters killed in missile strike on Ukraine hotel

World Ryan Evans, a member of the Reuters team covering the war in Ukraine, was killed and two Reuters journalists were injured in a strike on a hotel in the eastern Ukrainian city of Kramatorsk, the news agency said on Sunday.Evans, who was working as a safety adviser for the agency, was killed after a missile struck the Hotel Sapphire where he was staying as part of a six-person team on Saturday, Reuters said in a statement. Two of the agency's journalists were being treated in hospital; one of them was seriously injured, it said."We are urgently seeking more information about the attack, including by working with the authorities in Kramatorsk, and we are supporting our colleagues and their families," Reuters said.

Evans, a former British soldier, had been working with Reuters since 2022 and advised its journalists on safety around the world including in Ukraine, Israel and at the Paris Olympics. He was 38."We send our deepest condolences and thoughts to Ryan's family and loved ones. Ryan has helped so many of our journalists cover events around the world; we will miss him terribly," Reuters said. The three other members of the Reuters team who were in the hotel at the time of the strike were accounted for and safe, the agency said.President Volodymyr Zelenskiy said the hotel was hit by a Russian Iskander missile, a ballistic missile that can strike at distances up to 500 km (310 miles).

'An ordinary city hotel was destroyed by the Russian Iskander," he said in his evening address on Sunday, adding the strike was "absolutely purposeful, thought out ... my condolences to family and friends". The Russian Defence Ministry did not respond to a request for comment.Reuters was not able to independently verify if the missile that hit the hotel was fired by Russia or if it was a deliberate strike on that building.

## Trump wouldn't back national abortion ban if elected president: JD Vance

New York. Republican vice presidential candidate JD Vance says Donald Trump would not support a national abortion ban if elected president and would veto such legislation if it landed on his desk."I can absolutely commit that," Vance said when asked on NBC's "Meet the Press" whether he could commit to Trump not imposing such a ban. "Donald Trump's view is that we want the individual states and their individual cultures and their unique political sensibilities to make these decisions because we don't want to have a nonstop federal conflict over this issue."The Ohio senator also insisted that Trump, the former president who is the Republican nominee this year, would veto such legislation if it were passed by Congress.

'I mean, if you're not supporting it as the President of the United States, you fundamentally have to veto it," he said in an interview that aired Sunday.Vance's comments come after Democrats spent night after night of their national convention in Chicago last week assailing Trump for his role in appointing the Supreme Court Justices who overturned Roe v. Wade, ending the constitutional right to abortion in the United States and paving the way for bans and restrictions across Republican-led states.But efforts to try to neutralise an issue that Democrats hope will galvanise voters this fall also risk alienating parts of Trump's base opposed to abortion rights."God have mercy on this nation if this is now the position of what was the Pro-Life Party," wrote Family Research Council president Tony Perkins in a post Sunday linking to a story on Vance's comments. While Trump has repeatedly boasted about his role in overturning Roe, he has, in recent days, pushed back on Democrats' warnings that he will go even further to restrict access if he wins a second term."My Administration will be great for women and their reproductive rights," he wrote Friday on his Truth Social platform, appropriating language used by abortion rights activists and the left.His comments drew a wave of criticism from anti-abortion advocates, including the editor



of the conservative National Review, which published an article titled "Trump's Abandonment of Pro-Lifers Is Complete."Trump repeated his claim hours later at an event in Las Vegas."I'm very strong on women's reproductive rights. The IVF (in vitro fertilization), very strong. I mean, we're leaders in it. And I think people are seeing that," he told reporters."American women are not stupid, and we are not going to trust the futures of our daughters and granddaughters to two men who have openly bragged about blocking access to abortion

for women all across this country," said Massachusetts Sen. Elizabeth Warren told NBC.Trump ally Senator Lindsey Graham, R-S.C., brushed off a question asking how Trump would be "great' on reproductive rights."You need to ask him about that. What I would say is that President Trump was a very good pro-life president," he told CNN's "State of the Union.""The pro-life community," Graham said,, "is organised around the well-being of the child, giving the mother options other than an abortion. Graham said "that movement will continue after he's gone."Trump has often struggled to talk about abortion. Before he entered politics, he had described himself as "very pro-choice." Earlier this year, he grappled with his stance on a federal abortion ban, suggesting at one point that he would support one at around 15 weeks of pregnancy, with exceptions in cases of rape, incest and when the life of the mother is at risk. He then settled on his current position: That restrictions should be left to individual states

## Trump says Elon Musk won't have time to be in his cabinet, but could 'consult'

World What if tech mogul Elon Musk went to Washington to serve in Donald Trump's hypothetical cabinet in the White House? Questions like these loom large after the former US President said that he would offer Musk a cabinet post. However, breaking the suspense, the Republican presidential nominee hinted that the Tesla CEO is unlikely to serve in his 'future' cabinet, saying Musk will be busy managing his companies.In an interview with formal Navy Seal Shawn Ryan, Trump said that Musk wants to be "involved"; however, "he's

running big businesses and all that, so he can't, really, I don't think he could be in cabinet," CNBC reported.Reiterating his old offer, Trump said that would "put him in the cabinet, absolutely, but I don't know how he could do that with all the things he's got going."Trump's comment might offer him a strategic way to distance himself from his recently established alliance with Musk, should he emerge victorious in the November election

against Democratic nominee Kamala Harris.

CNBC quoted Trump as saying, "He can, as the expression goes, consult with the country and give you some very good ideas."He stated that Musk could offer help in areas like artificial intelligence.

Two years ago, Trump and Musk were in an open feud, exchanging insults on social media platforms and at political rallies. From enemies, the duo has emerged as

#### Australian employees can now ignore after-work calls as new law takes effect

World Is your boss texting you on the weekend? Work email pinging long after you've left for home? Australian employees can now ignore those and other intrusions into home life thanks to a new "right to disconnect" law designed to curb the creep of work emails and calls into personal lives. The new rule, which came into force on Monday, means employees, in most cases, cannot be punished for refusing to read or respond to contacts from their employers outside work hours.Supporters say the law gives workers the confidence to stand up against the steady invasion of their personal lives by work emails, texts and calls, a trend that has accelerated since the COVID-19 pandemic scrambled the division between home and work."Before we had digital technology, there was no encroachment, people would go home at the end of a shift and there would be no contact until they returned the following day," said John Hopkins, an associate professor at Swinburne University of Technology. Now, globally, it's the norm to have emails, SMS, phone calls outside those hours, even when on holiday."Australians worked on average 281 hours of unpaid overtime in 2023, according to a survey last year by the Australia Institute, which estimated the monetary value of the labour at A\$130 billion (\$88 billion). The changes add Australia to a group of roughly two dozen countries, mostly in Europe and Latin America, which have similar laws.Pioneer France introduced the rules in 2017 and a year later fined pest control firm Rentokil Initial 60,000 euros (\$66,700) for requiring an employee to always have his phone on.Rachel Abdelnour, who works in advertising, said the changes would help her disconnect in an industry where clients often have

#### Israel, Hamas fail to agree on 'compromises' in Gaza ceasefire talks: Report

World There was no agreement on Sunday in the Gaza ceasefire talks that took place in Cairo, with neither Hamas nor Israel agreeing to several compromises presented by mediators, two Egyptian security sources said, casting doubt on the chances of success in the latest US-backed effort to end the 10-month old war.A senior US official, however, described the talks as "constructive", saying they were conducted in a spirit on all sides to reach "a final and implementable agreement.""The process will continue over the coming days through working groups to further address remaining issues and details," said the official, speaking on the condition of anonymity, adding that the teams would remain in Cairo.Months of on-off talks have failed to produce an agreement to end Israel's devastating military campaign in Gaza or free the remaining hostages seized by Hamas in the militant group's October 7 attack on Israel that triggered the war.

Speaking at a news conference in Halifax, Canada, US National Security Advisor Jake Sullivan said Washington was still "feverishly" working in Cairo to get a ceasefire and a hostage deal.Key sticking points in ongoing talks mediated by the United States, Egypt and Qatar include an Israeli presence in the so-called Philadelphi Corridor, a narrow 14.5-km-long (9-milelong) stretch of land along Gaza's southern border with Egypt.Mediators put forward a number of alternatives to the presence of Israeli forces in the Philadelphi Corridor and the Netzarim Corridor which cuts across the middle of the Gaza Strip, but none were accepted by the parties, Egyptian sources said.

## Bangladesh's Muhammad Yunus vows 'free and fair' elections, urges restraint

Bangladesh interim government's Chief Adviser Muhammad Yunus on Sunday appealed to the people to have "patience" as it is difficult to address the "mountain-like Yunus said the timing of the challenges" overnight while promising them a free, fair and participatory election after implementing key reforms in different sectors.In a televised address to the nation, his second since assuming charge on August 8 after the fall of the government led by Sheikh Hasina on August 5, Yunus urged the people to refrain from storming institutions, putting pressure to accept cases and the tendency to do some kind of trial in advance by attacking people while taking them to the courts."I'll just say, you have to be patient. It is difficult to overcome mountain-like challenges overnight," he said, referring to the demands coming from various sections to punish those responsible for the deaths of many people during the recent antigovernment protests. These incidents will fade the glory of the successful struggle to build a new Bangladesh, the 84-year-old Nobel laureate said."We will maintain

friendly relations with all countries," he said. Mutual trust and cooperation will be the base of our foreign policy. We are respectful of all international laws, including human rights. We have taken steps to become signatory to the international convention on enforced disappearances," he was quoted as saying by the official BSS news agency.

election is a political decision and people will decide how long this interim government will remain in power.He assured the nation that his interim government will hold free, fair and inclusive elections in the country after undertaking reforms in various sectors."After completion of required reforms in administration, judiciary, election commission and electoral system, law and order and information flow systems --

Yunus did not give any deadline for the tenure of his interim government but acknowledged that "everyone is interested to know when our government will leave"."The answer lies with you when you will give us the farewell. None of us (council of advisers) are the ones to rule the country. We are happy with our professions. We took

charge, responding to the students' call during a national crisis," he said. Yunus said that his government would "put in all our efforts" to discharge the duty he has been entrusted with as all sections of people had welcomed his government. The chief adviser slammed Hasina's "fascist autocratic regime", saying they destroyed every institution of the country, crippled the economy and education system, and gauged people's voices through intimidation and torture. Yunus said his government believed in "national unity" and for that reason, he has appointed a special assistant with the status of an adviser with the responsibility of developing national

solidarity. Yunus said the main aim of the election is to introduce an accountable political system against corruption, looting and mass killing.Local government institutions, he said, must be strengthened and decentralisation of power should be ensured to consolidate democracy.

Claiming that the government has taken a strong stance against corruption, the Chief Adviser said all the advisers to the interim government will disclose their wealth statements within the quickest possible time.

#### Experts advocate key reforms in the education system

- VIJAYAWADA: Educationists in the State are advocating for significant reforms in the education system, particularly to integrate physical education for the holistic development of students.With an aim of creating a balanced educational footprint that prioritises academic excellence, physical well-being, cultural awareness and essential life skills, the experts are seeking policy changes to foster social skills, cultural values, physical fitness, and leadership qualities, all of which are as vital as academic knowledge.
- "Physical education and extracurricular activities are essential for the holistic development of students," said Krishna University Physical Directors Association secretary Dr BCH Sangeetha Rao. He expressed concern over parents choosing private colleges without necessary infrastructure and leaving well-equipped government colleges under utilised.
- A research scholar in physical education, Daram Naveen Kumar urged the State government to ensure thorough physical inspections while granting necessary permissions, as private institutions tend to present a perfect documentation even without proper facilities for physical education. He called for the immediate appointment of PETs (Physical Education Teachers) for Classes I to V and to fill the vacancies in all high schools and colleges. Similarly, Arts and Crafts Unemployed Teachers Association State president Gopaboina Edukondala Rao appealed to the government to include crafts. art, and music classes in the curriculum.

### **Beware! A 'like and subscribe' on** YouTube may land you in trouble

Cyber experts warn that these fraudsters may ask you to like or subscribe to YouTube channels or rate a business on Google Maps that you have never visited.

KOCHI: Be cautious when liking or subscribing to YouTube videos, reviewing movies, or rating businesses on Google following an offer of a good earning from However, when the scammers asked him to these activities as a few people have already

fallen prey to these scams and lost their money.Cyber experts warn that these fraudsters may ask you to like or subscribe to YouTube channels or rate a business on Google Maps that you have never visited. They offer small rewards, such as Rs 250 or Rs 500 or even Rs 1,000, to gain your trust. Once you are hooked, they lure you into paying a large sum, promising to double your earnings. After taking your money, they disappear.

Many victims realise the scam after receiving the initial small reward and try to back out. However, this could lead to further trouble, as the money they received may have been stolen from other victims. When these fraudulent transactions are traced back, the person's bank

account could be frozen, and they may face charges of cyber fraud once the police investigate. Recently, a resident of Kochi received an offer to earn money by liking YouTube videos, with a promise of Rs 250 for each 'like' or subscription. To receive the payment, he was required to share screenshots of the videos he had liked or subscribed to. Initially, he received between Rs 250 and Rs 1,000.

join a package scheme by paying Rs 1 lakh



to earn even more, he realised it was a fraud. He withdrew the initial amount and stopped participating. A few days later, his bank account was frozen due to an investigation into a cyber fraud case registered in another state, where money stolen from another victim had been transferred to his account.Cyber-law expert Jiyas Jamal said many people realise they have been scammed only after receiving small rewards and being pressured to invest

more."Unfortunately, the victims often face legal trouble themselves, as the money they receive is often traced back to other victims of fraud. If the authorities investigate, they may trace the funds back to the victim's bank account, leading to potential charges," said Jiyas, adding that a few persons have been booked in such cases registered by the police in other states. He further said that fraudsters frequently create fake businesses on Google Maps and send links to their victims.

In another case, a youth from Kaipamangalam in Thrissur lost Rs 46 lakh in a scam involving writing positive reviews to boost movie ratings. The scammers promised significant returns in exchange

for these reviews on a platform called Plex Movie. The victim, who owned a lottery shop, initially invested Rs 70,000 expecting a large return, and received Rs 90,000, which encouraged him to invest

#### NMR portal to streamline doctor verification, fight fraudulent medical practices

THIRUVANANTHAPURAM : With the launch of the National Medical Register (NMR) portal by the National Medical Commission (NMC), the effectiveness in detecting fake medical practitioners is expected to improve significantly.

he portal addresses the long-standing need for a credible national database of doctors that allows the public to verify credentials. Earlier, the lack of such an interactive repository was seen as a major obstacle in preventing impersonation and other fraudulent activities. With the new system, enforcement agencies can easily verify a doctor's credentials by matching their registration ID with the NMR database.

key feature of the NMR is its integration with the doctors' Aadhaar IDs, which helps ensure the authenticity of individuals. According to Dr Harikumaran Nair GS, president of the Kerala State Medical Council (KSMC) for Modern Medicine, the system allows public verification of registration numbers without compromising privacy.While some data will be accessible to the public, other information will be restricted to the Ethics & Medical Registration Board (EMRB) within the NMC, State Medical Councils (SMCs), the National Board of Examinations (NBE), medical institutions, and registered medical practitioners, based on specific needs. The General Practitioners Association (GPA) highlighted the prevalence of fraudulent practices and the challenges in enforcing regulations against them due to the lack of an effective mechanism. Only duly registered medical professionals are authorised to practice medicine in the state. Despite this mandate, instances of MBBS students, dropouts, and unqualified medical graduates who studied abroad practising are abound.

#### Food poisoning: Six more discharged, Rs 50,000 compensation for 44 students

VISAKHAPATNAM: Six more students, among those who were hospitalised due to food poisoning at a hostel run by the Parisudhatma Agni Stuthi Aradhana Trust (PASA Trust) in Kailasapatnam of Kotauratla mandal, Anakapalle district on August 17, were discharged on Sunday. The students have been identified as Killo Jyothi, Marri Meenakshi, Marri Kumari, Burada Abraham, Pangi Mounika, and Pangi Meera. It may be recalled that three students lost their lives in the incident while several others were admitted to various hospitals for treatment.

The children were sent to their homes in two ambulances provided by the district administration.Following the incident, the State government provided an ex-gratia payment of Rs 10 lakh to the families of the deceased. Additionally, a financial compensation of Rs 50,000 each was sanctioned to 44 students who faced severe health complications due to the f poisoning.Earlier, officials shifted the six students, who were under treatment at King George Hospital (KGH) in Vizag, to the Government Hospital in Paderu for further observation. On Sunday, Alluri Sitharama Raju district Joint Collector Dr MJ Abhishek, accompanied by ITDA Project Officer V Abishek, visited the hospital.hey consoled the parents of the affected students and handed over cheques for Rs 50,000 each to the families, along with 25 kg of rice and nutritional kits. During the visit, the officials also conducted a counselling session for the parents, advising them against enrolling their children in unauthorised hostels. They emphasised the importance of admitting students to government-approved hostels to avoid similar incidents in the future.

### Bengaluru: After bags, laptops Metro commuters leave gold behind

#### Costliest being bag with Rs 4 lakh worth gold items found in station, mangalsutras also found on platforms

BENGALURU: Gold jewellery, including mangalsutras, figures among the forgotten items by Metro commuters inside trains or platforms recently. With the ridership surging above the 8 lakh mark on a daily basis frequently, items left behind by the forgetful too are on the rise. Thanks to the stringent policy in place regarding items left behind by passengers and the overwhelming presence of CCTVs all over, commuters invariably get their items back if they make an attempt to collect them.A Metro source said gold jewellery worth Rs 4 lakh, among the costliest items found so far inside its trains, was found on August 17 at the Krantivira Sangolli Rayanna (BRCS) Metro station. "A bag with 50 gm of jewellery comprising two gold chains and two gold rings was left behind by a passenger on platform one of the station around 10.30 pm. The bag also had Rs 3,500 in cash. A private security guard who found it sometime later alerted the security officer at the station," the source added. As is the norm with abandoned bags, it was first scanned using handheld metal detectors and passed through the X-ray inspection system before the contents were examined.Within an hour, a passenger, Basavaraj Naganur, came to the station and staked claim to it. "He said he had arrived in Bengaluru from Belagavi the same day and was on way to Baiyappanahalli Metro station.

After reaching there, Naganur remembered his bag and came rushing back to the BRCS station as he recalled placing the bag on the platform floor. The passenger was able to tell the colour of the bag and the contents inside. After crosschecking his ID, he was handed over the property," the source said.

On August 14, a passenger, Beena Khan. forgot her handbag near the baggage scanner of Yeshwanthpur Metro station around 8 pm. "It had four gold rings and Rs 1,200 in cash. She reached the station later at night and got it," the source said.

A senior Metro official added that they had found two gold mangalsutras in two separate incidents on the platforms at Nadaprabhu Kemepgowda Metro stations ten days ago. "They must have slipped and fallen when boarding or alighting. We rarely find mangalsutras.

One woman came the following day to file a complaint and was relieved to find her jewellery with us.

NALGONDA: A day after a pregnant woman gave birth to a child on a chair in Nalgonda Government Hospital, the District Additional Collector (local bodies) T Purnachander issued show cause notices to four staff nurses and the duty doctor on Sunday for their alleged negligence while on duty.Following this, seven gynaecologists from the hospital went on a mass protest against the notices given to the duty doctor. The incident occurred after midnight on August 22 when the woman, who was asked to walk outside the labour room, delivered a baby in the chair. Reportedly, there was no one to support the woman while she was suffering labour pain. However, they said that they responded immediately and provided treatment to the mother and child. A hospital nurse said that it was impossible for one nurse to accompany every patient as there were only four nurses on night duty and there were 10 deliveries that day. They also said that the hospital does not have proper staff and facilities, but they are providing good service to the patients.

#### DC withdraws show cause notices

However, in the wake of seven gynaecologists mass leave, Nalgonda District Collector C Narayana Reddy, withdrew the show cause notices issued to the duty doctor and the staff nurses. However, the doctors who went on leave have not yet returned to work.

#### Second protest by doctors in three months

This is the second instance of doctors' protest in three months. In June, doctors protested for two days after the district collector appointed officials from various departments to supervise the hospital. The doctors argued that only the Collector and Additional Collector have the authority to supervise them. In response, the District Collector clarified that the district officials role was to oversee patient services, not directly supervise the doctors.

#### Tamil Nadu: Broken guardrails, no warning signs: **Mettupalayam-Kotagiri road nightmare for tourists**

COIMBATORE: Lack of sign boards warning motorists of the sharp curves and bends makes driving on Mettupalayam-Kotagiri ghat road a nightmarish experience, especially for tourists who may be

heading to the hills for the first time. The safety barricades installed along the road are also damaged in several stretches.During peak tourist season, vehicles will be diverted through this road to reach Mettupalayalm when Ooty and Coonoor witness dense traffic. On an average, at least 20 lakh tourists visit the Nilgiris district every year.According to sources, when the guardrails got damaged, instead of replacing them, the state highway officials have just placed tree branches. Several motorists voiced concern that high possibility vehicles would go off the road at the curves and fall into the gorge if the driver loses control.

Recently, damaged barricades fell on the road, endangering motorists.Arun Bellie, a social activist volunteer coordinator and

secretary of the Confederation of Environment Associations of Nilgiris (CEAN), said the state highway department should conduct a survey on the road and fix



barricades and awareness boards. Space should be provided for elephants to get down the slopes easily, he added.

The officials should set up barricades after a proper study. Guardrails were installed along the Kannerimukku -M Kaikatti road for more than 2km, which is unnecessary. More place should be covered between the first hairpin bend and Kotagiri," he said."This is the time for transport department and police to hold sensitisation sessions for drivers at the Mettupalayam forest depot checkpost," Arun Bellie added.

Echoing a similar opinion, Kotagiri-based resident and TNSTC driver who did not wish to be named said the state highway officials should provide a way for elephants to move from gorge to another gorge by crossing the road since there were incidents where the animals got stranded in the middle of the road. 'The barricades were placed decades ago and need to be replaced with modern roller crash barriers as setup in Thalaikundha

to Kalhatty road to prevent vehicles from falling into gorge," said the driver.

When contacted Divisional Engineer of State Highways Construction and Maintenance Ghana Moorthi told TNIE they have no plans to set up roller crash barriers. "We will inspect the spot on Monday and see what steps can be taken for the safety of motorists.'

#### Bengaluru: Pathway from FOB ramp to KR Pura platform planned

BENGALURU: Even as the new Foot Over Bridge (FOB) from Krishnarajapuram (KR Puram) Railway Station to KR Pura Metro Station was opened without any fanfare on Saturday, a specific issue poses inconvenience to the public. The down ramp of the bridge stairs touches down inside the railway premises, 100 metres away from Platform 4, throwing up a challenge for passengers with heavy luggage and senior citizens. It has now been decided that Bengaluru Division will create a pathway to help passengers reach the station.Deputy Commissioner of Police (Traffic East), Kuldeep Singh told TNIE, "We met senior officials of Metro and Railways on Tin Factory Main Road and surveyed the area. Our goal is to create an integrated traffic management plan at this critical junction, so the public can commute

seamlessly between all modes of transport."At present, there is enormous congestion and 700 to 800 passengers rush out of the railway station whenever a train arrives, and head to the road, impacting traffic there too. "There will be clear demarcated parking zones for auto and cabs, and other facilities. There is enough space inside the station and everything needs to be streamlined," he said. He added that both Railways and Metro have been told to come up with detailed sketches of their plans within a couple of days, before a final strategy is chalked out. Bengaluru Divisional Railway Manager Yogesh Mohan said, "As an immediate measure, we will be creating an opening from where the bridge connects to platform 4, so the public can easily reach it. From this platform, other platforms are accessible through.

### Loss and gain with having a leopard around the farm

- I was about to go meet my nephew, Balu, when my father told me that a leopard — perhaps the same one that I had photographed — had killed one of Balu's cows the previous night. I left home but then lingered in the front yard, wondering if Balu would be upset with me because he knew that I was fond of the leopard. Balu and I were almost the same age and had grown up together. He was a hard-working farmer and unlikely to let something this serious pass.
- The first time I heard of this leopard was when Balu had come home to deliver something from the farm and saw a picture of a leopard on my laptop. He said there was one in the ravine near our Lekurwali farm, the one that he managed and shared a portion of the produce with my father. This particular farm was adjacent to the Ajanta reserve forest. He was amused that I was so curious about leopards.My father told him that I was planning on studying them in the Himalayas for a PhD. He said he had heard of people going to the Himalayas for tirth yatra and tapasya. Going all the way to study leopards was a new one for him. "Anyway, why go all the way when there was one right by our farm," he said half-jokingly. I tried to explain to him the distinction between a snow leopard and a common leopard. I told him
- snow leopards were adapted to living at high elevations with limited oxygen and intense cold. "Then, the common leopard must also be adapted to

the heat of our Maharashtra summer," he remarked. He went on to tell me how he believed that this leopard near our farm was old. The next time I returned to our farm a year later, Balu said he hadn't seen the leopard in many months and suspected that he was dead. He was most surprised when I asked him if he suspected that someone had killed the leopard. He said nobody around here had a gun and a poisoned leopard would be found out.I frequented the Lekurwali farm over the next two years. I would regularly see wild boars, four-horned antelopes and nilgai, but never a leopard.Balu would usually be milking his cows and buffaloes around the time that I returned from the farm and passed by his gotha (animal shed). He always asked me about the animals I saw. If I reported nilgai or langurs, he would send one of his people to shoo them away. He would then make a trip himself to make sure that the crop-raiders were gone. Then, the first time I saw this new leopard was when I was returning from the farm. I looked back for a moment and saw a large male leopard walking casually on the other bank of the ravine. He walked out of a thicket and sat in the open on a rock in a grassy meadow. The monsoon rains had turned the meadow bright green, and the leopard's lemon-yellow coat, with its dark black rosettes, looked like a painting on someone's living room wall. He looked at me nonchalantly. He was a good 50 metres away, and there was a small stream between us, but still, I was surprised by his boldness. I watched him for a good 15 minutes and took some pictures before he got up and walked along the stream. Then, one night, when Balu was guarding his wheat crop, he saw an eye shine. He suspected it to be nilgai and tried to chase it away. He was fairly close when he realised that it was a leopard. He made a swift retreat but did not turn his back on the leopard. The next time I saw the leopard, it was closer home. My wife reminded me that it was near the same pool where our three-year-old daughter had been playing the previous evening. "But this leopard has never harmed a human," Balu joined the conversation.I was a little surprised when my father said that the leopard had killed one of Balu's cows. When I reached the gotha, I expected him to be a little cross, but he was his usual self. I did not want to bring up the cow or the leopard, but he jumped as soon as he saw me and started telling me all the details of how the leopard got into the gotha and killed the cow.

#### BJP's Maha quest: Future haunted by the past

The BJP's journey of the past decade illustrates the perils of short-termism in politics.

It was the run-up to the Maharashtra assembly polls in 2014. Devendra Fadnavis, the face of the BJP's campaign, was at a conference hosted by a news channel. The large screen behind him played the now-famous video clip where Fadnavis promised when the BJP came to power "Ajit dada chakki peesing, peesing and peesing". It was a smart blend of Bollywood and politics. asked Fadnavis if he had seen Sholay, in which Veeru and Basanti were eventually betrothed. To the 'what if' question, Fadnavis laughed and said it would be better to be a bachelor. The video has since led a charmed viral existence. It has also come to symbolise the past that haunts the future of the BJP in Maharashtra. If a week is a long time in politics, 10 years would qualify for an era. The BJP's journey of the past decade illustrates the perils of short-termism in politics. In a series of misadventures, the party surrendered the anti-corruption plank, engendered mistrust among allies, eroded credibility with break-and-make transitions, and stands accused of ragtag opportunistic politics.Stalled leader: The BJP's successful campaign in 2014 was built around personality and a promise. The slogan was, "Delhi mein Narendra, Mumbai mein Devendra." Fadnavis was convivial, yet aggressive and radical in his approach following a fire at the Mantralaya in 2012, he petitioned the police to file an FIR against the sitting chief minister. By 2019, Fadnavis had carved a stature, triggering envy. The image seems to have lost its way. In 2024, Fadnavis appears to be at odds and often at war within the party, seen as 'one man against Rome'. Broken promise: Central to the BJP's success was a promise to rid the state of corruption-underlined by a chargesheet accusing the Congress-NCP alliance of scams worth Rs 11 lakh crore. The BJP along with the Shiv Sena romped home in October 2019, winning 122 and 63 seats in the house of 288. A few weeks later, the Maharashtra government gave the nod to the state Anti-Corruption Bureau for a probe against Ajit Pawar and Sunil Tatkare of the NCP. A decade later, Fadnavis and Ajit Pawar are deputy chief ministers and co-campaigners for the 2024 elections.

Cratered alliance: Relationships define success in politics and language matters. For a quarter century, the BJP and Shiv Sena were siblings in the saffron alliance. The alliance chugged along despite what Shiv Sena chief Bal Thackeray dubbed as 'domestic squabbles'. The alliance collapsed after the 2019 elections following a battle of insinuations over chief ministership. Government formation was stalled. The details are fuzzy depending on who is telling the story, but what is clear is that by the end of October, Uddhav Thackeray walked out and the alliance was in tatters.Shotgun wedding: The BJP used to call itself the party with a difference. With 105 MLAs, it could have out-waited the opposition. But they chose not



to. In a move akin to a hostile corporate takeover, on November 23, 2019, the BJP roped in Ajit Pawar to form the government. NCP chief Sharad Pawar quickly dubbed the nephew's migration illegal and formed the Maha Vikas Aghadi (MVA) comprising the Shiv Sena (Uddhav Balasaheb Thackeray), NCP and Congress, with Uddhav as the CM-designate. The BJP's shotgun wedding didn't last beyond three days - Ajit Pawar and his group eventually joined the MVA government.

Split and rule: In 2022, the MVA appeared close to collapse under the weight of its contradictions when the BJP brought it down, partnering with the breakaway SS group led by Eknath Shinde. The opposition said the split was enabled by the misuse of central agencies; the BJP claimed innocence and the Shinde group said it was not a split. Fadnavis faced the ignominy of being directed to join as deputy chief minister.

In July 2023, the BJP revisited an old theme and inducted Ajit Pawar and an NCP faction into the government arguably to bridge the gaps in electoral footprint among social coalitions and in rural Maharashtra. It didn't pay off in June 2024, but sullied the party's playbook. Development detained: As politics unravelled, the state's

economy took a beating. Maharashtra's debt has spiralled to Rs 7.11 lakh crore (17.6 percent of the gross state domestic product); interest payments at Rs 48,578 crore account for 10 percent of revenues. Unlike the past, the state is growing slower at 7.6 percent compared to India's GDP growth of 8.2 per cent. BJP's 2014 success was catalysed by the support of angry farmers. In 2024, farmers are raging against the BJP.

The Maratha anger is about a loss of social standing, but it also symbolises unviability of farming - the net sown area is sliding and the gross cropped area is stagnant. The state is lagging in investments and its per capita income, at Rs 2.52 lakh, trails seven states.his month, the Election Commission announced the dates for elections in Haryana and Jammu & Kashmir. A parade of hubris and desperation, a series of missteps and the choice of tactical over strategic have stranded the party in a muddle that it must dig itself out of.

The chaos witnessed during his years in the Oval Office and the attack on the Capitol after he ended up as a sore loser in the 2020 election are still fresh in the minds of Americans. #### Are we prepared for digital accidents?



As we cruise along digital e-ways, bumps such as the Crowdstrike glitch are bound to come up. We need to move from overuse to optimal use of technology.

A Microsoft glitch triggered by an update from its security partner Crowdstrike recently brought down computer systems around the world. While we noticed airports and banks going down, many big and small businesses were impacted and incurred substantial losses. It was a short-lived digital version of what we saw during the Covid pandemic.Analysis-paralysis dominated the screens that were still working. Some blamed negligence on part of the company, while others worked out a conspiracy theory in a jiffy. This could have been a simple glitch that could be both intentional or unintentional. Most probably it was unintentional. You see, it is difficult to predict software behaviour during upgrades and updates, especially when many independent pieces are interacting with each other.Software engineers do test for all possible scenarios, but being exhaustive is close to impossible. At the same time, if a bug is to be inserted intentionally, it can be easily done by simply tweaking a few things. This is how the whole virus industry was born, which in turn gave birth to the anti-virus industry. Conspiracy theorists called it sabotage. I am yet to understand by whom and against whom. Is someone trying to hurt the businesses impacted or the one who is providing the services? Competition can play spoilsport but I do not see that as a case here. The only conspiracy I can think of is an attempt to sell some new cybersecurity product by occasionally creating an alarming situation like this. This, to my mind, is the biggest possibility given that many industries thrive on a bit of fear. Among the 'fear players', the insurance industry comes to my mind right on top.It could well be the insurance industry trying to build a new vertical in cybersecurity insurance. Well, it already exists for big corporations, but they are still not selling it to common users like you and me. We may well be on their radar. Remember, Berkshire Hathaway and Warren Buffet have started



talking about cybersecurity risks at their annual investor meets. I would call this breakdown a 'digital accident'. As we ride digital highways, some of these accidents are bound to happen. Some would be due to the negligence by either a naïve user or the lack of diligence at the technology provider's end.

Many such digital accidents would take place simply due to situations no one could foresee. Most systems fail at such exception points. Yes, there are blind spots on digital e-ways too, which are not so easily visible or predictable. At a personal level, we all have stories of lost files or precious pictures to a crashed hard disk or a phone that decided to reset itself. At a business level, these stories mostly stay within the organisation, as it shows both business risks as well as weak links within their systems. These risks have not been much spoken about since the Y2K days when the focus on technology risk was at a peak. The Indian IT industry owes its widespread reach to this bug that never really materialised. Those were the days when manual alternatives were still available, which is not the case now. There are questions the Crowdstrike incident raises. Should we have a few big companies owning a piece of every other business via technology? Should we not have many small companies so that the risks are distributed and losses are limited? To an extent, it also raises the question of how much of your technology should be outsourced. Going overboard with technology just because it is available is another syndrome that we need to deal with. Forcing a QR code

when a simple paper menu can work, or an automated entry pass when a security person is standing there doing nothing are things that we should let go of. We need to move from overuse to optimal use of technology. For example, check-in process that used to be a step act before digitisation is now a 5-6-step process - web check-in at home, printing of boarding passes at airport, printing luggage tags, struggling at various automated entry points when QR code readers fail, standing in queue to drop the luggage, time wasted when people struggle to find their boarding passes on their phones. One simple queue would have kept things simple for everyone. A clear case of technology overuse.Employees not trained in manual processes are a bigger risk in such scenarios. No one has any clue what to do if the system stops working. How many times we have heard 'Server not working' as an excuse for transactions not going through? There should be a system to keep the business running, potentially in a skeleton mode, even if all the systems come to a


standstill. This would demand a high level of integrity and accountability at the human resources level, which is questionable with the constant churn organisations face these days. Trusting technology more than people is also a trend that feeds this risk, as people simply shrug their shoulders and say, "It's not me, it's the system."Someone once asked, if a magnetic tsunami erased all data from the digital world could the world still function? While most of us may think of it as an impossibility, pauses are pretty much a reality that we need to live with as the Crowdstrike incident has shown us. Organisations and users need to be prepared for these pauses caused by digital accidents. Probably, we need some technologyindependent solutions as redundancy or alternatives.

- Never store apples with any other vegetables or fruits. Apples emit certain gases which make the other good items rot. Similarly, never store tomatoes and cucumber in the same compartment as even tomatoes emit gases which can make the cucumber rot.

- Always store items like eggs with the pointed side downward to keep them fresh longer.

- Store cheese with a few cubes of sugar in an air tight container as the cubes absorb the moisture from the cheese and help it stay fresh for a longer period of time.

### IMD Warns Of Intense Rains In Madhya Pradesh, Rajasthan, Gujarat, Maharashtra: Check Full Forecast

Issuing a red alert, the IMD said heavy to extremely heavy rainfall is expected in West Madhya Pradesh on August 26. Similar conditions are forecast for east and south Rajasthan, Gujarat, Saurashtra and Kutch.

New Delhi: A depression over northwest Madhya Pradesh and adjoining east Rajasthan has intensified into a deep depression, the India Meteorological Department said on Monday and warned of heavy to extremely heavy rainfall in parts of the two states and Gujarat, Goa and Maharashtra over the next two to three days.At 11:30 pm on August 25, the deep depression lay centred near 70 km southsoutheast of Chittorgarh, Rajasthan. This system is expected to move westsouthwest, affecting South Rajasthan, and Gujarat, and reaching Saurashtra, Kutch, and parts of Pakistan by August 29, the IMD said in an update issued at 2 am.

The weather department said another lowpressure area is located over Bangladesh and adjoining Gangetic West Bengal. It is

likely to intensify further and move towards Gangetic West Bengal, north Odisha, and Jharkhand over the next two days. Issuing a red alert, the IMD said heavy to

extremely heavy rainfall is expected in West Madhya Pradesh on August 26. Similar conditions are forecast for east and south Rajasthan, Gujarat, Saurashtra and Kutch from August 26 to 29.Konkan, Goa, Madhya Maharashtra, Odisha, Gangetic West Bengal, and Jharkhand are also expected to receive heavy to extremely heavy rainfall over the next two days.

The IMD has warned of strong winds reaching up to 50 kmph in Madhya Pradesh on August 26 and up to 60 kmph in south Rajasthan on August 26-27.In Gujarat, nearby Pakistan, north Maharashtra, and the northeast Arabian Sea, strong winds



gusting up to 55 kmph are expected on August 26, increasing to 60 kmph on August 27 and 28. Rough to very rough sea conditions are anticipated off the coasts of

After I finished the first stitch and was working on the second, the patient suddenly pushed me and began hurling abuses.

BJP's top leadership, including Amit Shah and JP Nadda, the party also decided to drop the candidacies of several prominent figures in the Jammu region, sources added.As expected, the

BJP is going to contest the Assembly elections, to be held after almost a decade, without forging an alliance with any party.

"Instead, the party will back strong independent candidates in the constituencies of the Kashmir Valley where it will not field its own candidates," sources added.In the last Assembly polls held in 2014, the BJP and People's Democratic Party (PDP)

formed a coalition government, with Mufti Mohammad Sayeed as the Chief Minister. After Sayeed's death in January 2016, Mehbooba Mufti succeeded her father following a brief period of Governor's Rule.In June 2018, the BJP

#### Tata Sons repays more than Rs 20,000 crore to remain private: Report

New Delhi. Tata Sons, the holding company of the Tata Group, has repaid over Rs 20,000 crore in debt to stay private, reported The Economic Times.

- The company settled Rs 20,300 crore in borrowings to avoid being forced to list its shares, a requirement for certain large financial firms under the Reserve Bank of India's rules.In 2022, the RBI classified Tata Sons as an NBFC-Upper Layer (NBFC-UL), which would have required it to expend out three verses Upware by required it to go public within three years. However, by repaying nearly all its debt, Tata Sons no longer has to comply with this rule and as asked to cancel its registration as an NBFC.Tata Sons also paid a record dividend of Rs 35,000 per share to its shareholders.
- The main beneficiaries are the Dorabji Tata Trust, which holds a 28% stake, and the Ratan Tata Trust, with 24%.
- Tata Sons collected Rs 24,000 crore in dividends from its group companies, with Rs 19,000 crore coming from Tata Consultancy Services (TCS), and additional contributions from Tata Motors and Tata Steel.
- Financially, Tata Sons performed strongly in FY24, with net profits rising 57% to Rs 34,654 crore, and revenues up 25% to Rs 43,893 crore. The company moved from a net debt of Rs 20,642 crore in March 2023 to a net cash position of Rs 2,670 crore by March 2024. This turnaround was helped by selling shares in TCS, raising over Rs 21,000 crore during the year.
- Tata Sons also reduced its expenses by 27% in FY24, and the value of its investments grew by 35.7% to Rs 15.21 lakh crore by the end of the fiscal year. The company continues to invest in its businesses to fuel growth and strengthen its finances, further securing its position as a private company.

#### Domestic Banks, NBFCs now hold 36% exposure of Adani Group's total debt

- New Delhi. Adani Group's debt mix now sees domestic banks and non-banking financial companies (NBFCs) accounting for 36% of its total debt, as per recent data.
- This shows a shift in the group's financial structure, with Indian lenders increasing their exposure by around 500 basis points during the 2023-24 financial year. The rise in debt is mainly attributed to capital expenditure in sectors like airports and green energy.
- As of March 31, 2024, Indian banks and NBFCs had lent Rs 88,100 crore to the Adani Group, contributing to the total debt of Rs 2,41,394 crore. This is a noticeable increase from March 31, 2023, when domestic lenders had an outstanding loan amount of Rs 70,213 crore, which was 31% of the group's total debt of Rs 2,27,248 crore.
- The increase in domestic lending includes contributions from major banks such as the State Bank of India, Bank of Baroda, Union Bank of India, Canara Bank, HDFC Bank, Axis Bank, and ICICI Bank. Despite the increased lending, queries sent to these banks remained unanswered at the time of reporting.
- Adani Group's debt has grown due to significant capital expenditures in its businesses, particularly in the airports and green energy sectors. The group operates across various industries, including infrastructure, ports, metals, building materials, utilities, and fastmoving consumer goods.
- During the last fiscal year, the group's debt from the domestic capital market also rose, reaching Rs 12,404 crore by March 2024, up from Rs 11,562 crore the previous year.
- On the other hand, debt from global banks saw a slight amounting to Rs ( 296 crore as of Marcl

### Heavy GST penalties on co executives face legal scrutiny

#### The ongoing investigations highlight the complexities surrounding tax compliance and the responsibilities of all parties involved in the supply chain.

NEW DELHI: The Directorate General of Goods and Services Tax Intelligence (DGGI) has issued thousands of notices to various companies, as well as their directors and promoters, regarding the wrongful availment of input tax credit (ITC), according to sources. This tax dispute primarily concerns the failure of the vendors to remit taxes to the government, in addition to other issues related to credit availment and utilisation.

According to experts, a key question arising from this situation is whether tax liability can be imposed on the service recipients, especially when they are not at fault. The ongoing investigations highlight the

complexities surrounding tax compliance and the responsibilities of all parties involved in the supply chain. When benefit has not been retained by these individuals, any penalty invoked on individuals will be subject to the test of constitutional validity before the jurisdictional High Court" explained Abhishek A Rastogi, founder of Rastogi Chambers, who has filed petitions against these huge penalties levied on

individuals. The burden to prove the malafide intent will be on the revenue in such cases, especially when no part is retained in the individual capacity", added Rastogi.

### India's GDP likely slowed to 6.9% in April-June quarter: Poll

New Delhi. India's economic growth likely moderated and grew at its slowest pace in a year in the April-June quarter due to lower government spending amid a national election that concluded in June, a Reuters poll found.Growth in Asia's third-largest economy had been well above 7% during previous quarters thanks to strong capital expenditure by the government led by Prime Minister Narendra Modi in a bid to secure a third term in the election. However, holding back on public spending ahead of the parliamentary elections has hurt growth. While the Modi-led Bharatiya Janata Party (BJP) came back to power, it lost its outright majority in the lower house.In the April-June quarter, gross domestic product (GDP) was forecast to have grown an annual 6.9%, down from 7.8% in the preceding quarter, the Aug. 19-26 poll of 52 economists showed. Forecasts ranged from 6.0% to 8.1%. The government is scheduled to announce data for the April-June quarter on Friday. If the median forecast



is realised, India will remain the world's fastest growing major economy.Official GDP growth releases for the preceding few quarters have surpassed predictions."The public spending slowdown was significant both by the centre and the states, especially on the capex front. So, there is the transitory element of growth slowdown. However...private consumption growth was better than the previous quarter and overall manufacturing and non-public services were steady," said Dhiraj Nim, an economist at ANZ."I will be watching out for how strong the private consumption revival is because that

would perhaps tell us how sustainable growth rates become over the coming quarters."Going forward, growth was expected to moderate, averaging 7.0% this fiscal year and 6.7% in the next, unchanged from a previous poll.



The S&P BSE Sensex was up 631.97 points at 81,718.18 at 10:16 am, while the NSE Nifty50 jumped 186.10 points to cross 25,000 mark.
- All the other broader market indices also gained sharply in early trade. It may be noted that the Nifty 50 has surged nearly 3% over the last seven sessions, marking its longest rally of the year, driven by growing speculation of a potential US rate cut in September and strong domestic inflows.Federal Reserve Chair Jeroe Powell, speaking at the Jackson Hole Economic Symposium on Friday, noted that "the time has come for policy to adjust," stoking anticipation of a rate cut.
- Analysts suggest that a US rate cut could channel funds into emerging markets like India, potentially extending the current rally in Indian equities.MSCI's Asia-Pacific index, excluding Japan, rose by 0.65%, while Wall Street closed on a high note Friday, bolstered by Powell's remarks, reinforcing expectations of a rate cut at the upcoming Sept. 17-18 Fed meeting. On the home front, twelve of the thirteen major sectors in the Nifty 50 advanced, with information technology stocks, which derive a significant portion of their revenue from the US, climbing 1.3%. The minutes of the Reserve Bank of India's monetary policy committee meeting published last week show that listed private manufacturing companies show sales and profits softened in the first quarter of fiscal year 2024-25. Consumer confidence fell, and the business expectations index has moderated since the previous quarter. In its outlook, RBI has reduced the first-quarter growth forecast.Within RBI's monetary policy committee, calls for rate cuts are rising. Professor Jayanth R Varma and Ashima Goyal, the two members of the committee, called for a cut in the repo rate, the rate at which RBI lends money to the banks. However, the committee voted to keep borrowing rates unchanged due to fears of a surge in food inflation contributing to consumer price inflation. In 2025, the RBI may have to consider reducing borrowing rates.

That means share prices are unlikely to fall significantly even as prospects for a rapid rise in share prices could diminish.

A phase of stagnancy in financial markets is not such a bad thing. You can spend a lot of time learning about the impact of monetary policy on the economy and the economy of the listed companies. The 24-year-old bettered his record set in the Paris Olympics by one centimetre as he cleared 6.26 metres in his second attempt at Silesia Stadium in Chorzow.
- It's the third time in the ongoing year that the Louisiana-born athlete has broken the world record, having done so previously at the Xiamen Diamond League and the Paris Olympics. Reacting on his marvellous feat, Duplantis said that his sole focus this year was on the Paris Olympics and the record came naturally since he was in good shape."This year I focused on the Olympics, the record just came naturally because I was in good shape. So I am not surprised with the record today, but I am thankful," Duplantis told Reuters after his historic feat.Further speaking ahead, Duplantis thanked the Poland crowd for their support and recalled his first world record at the same venue.

"It almost feels weird and unnatural to get so much love and support from the crowds when I compete. I see that especially in



Poland. The energy in this stadium just keeps getting better every year. My first world record also came in Poland, indoors in Torun (in 2020), so I have great memories from here," he added.Duplantis' viral moment from the Paris Olympics

Earlier, Duplantis won his second successive Olympic gold in Paris clearing the then world record height of 6.25 metres. As soon as he shattered the record, Duplantis was seen over the moon as he went running to his girlfriend to celebrate the historic achievement. The moment became one of the highlights of the Olympics with the video of the incident going viral on social media.Meanwhile, United States' Sam Kendricks, who won the silver medal in Paris, cleared 6.00 before failing at 6.08 to take the second spot. New Delhi Former Pakistan cricketer Mohammad Hafeez took a dig at PCB (Pakistan Cricket Board) Chairman Mohsin Naqvi's surgery remark after their loss to Bangladesh in the first Test. Notably, Bangladesh beat Pakistan for the first time in their Test history as they registered a tenwicket win in the first Test of the three-match series at Rawalpindi Cricket Stadium, Rawalpindi.Following their loss, there has been widespread criticism of the national cricket team with several former players and board officials launching a scathing attack on the current state of affairs of the side.



Jumping onto the bandwagon, former Pakistan's Director of Cricket also took a dig at PCB Chairman Naqvi for his surgery comment.Naqvi had commented that the Pakistan team needs a surgery after their humiliating six-run loss against India in the T20 World Cup 2024. In the aftermath of their T20 World Cup first stage exit which included another embarrassing loss against the USA, the PCB management sacked Hafeez and Chief Selector Wahab Riaz.Hence, to take a dig at Naqvi and PCB management Hafeez wrote "Surgery is On till death â€æ..," on his X account.Pakistan searching for home Test win since 2022Pakistan haven't won a single Test at

New Delhi. US Open's main draw is set to start later today on August 26. Defending champion in men's singles competition Novak Djokovic will be in action on Day 1 of the tournament, hoping to extend his form after winning the Paris Olympics gold medal. Alongside Djokovic, women's singles champion in 2023, Coco Gauff will also take the stage on August 26, hoping to maintain her domination in the tournament. The action begins at the Arthur Ashe Stadium at 9:30 PM IST with bigserving Ben Shelton taking on Dominic Thiem. After Shelton, Gauff will take on France's Varvara Gracheva in the women's singles competition to begin her title defence. With the US Open being played in two phases through the day as usual, Novak Djokovic's First Round tie will begin early in the morning (post 4:30 AM) for the Indian audience. Apart from Djokovic, Frances Tiafoe, Aryana Sabalenka and Victoria Azarenka will play late-night matches.



India's Sumit Nagal is set to be in action on Day 1 as well, taking on Netherlands' Tallon Griekspoor in his Round 1 match. Nagal will play on Court 15 and his match will start around midnight on 26 August. The US Open 2024 is expected to be under a lot of focus after the recent Jannik Sinner episode. The tennis world was divided after Sinner was allowed to play despite being caught positive twice for doping. The world no. 1 neb's singles player publicly addressed the recent anti-doping case involving him, marking his first statement since an independent tribunal cleared him of any fault or negligence related to two positive tests for the banned substance clostebol.Sinner also parted ways with his trainer, Umberto Ferrara, and physiotherapist, Giacomo Naldi, following a recent doping controversy. While the decision to separate from these key team members must have been difficult, reports indicate that Ferrara and Naldi were under scrutiny during the doping investigation.

New York.World No. 1 Jannik Sinner played down the chatter around his doping case, saying he was "treated like everyone else" after a section of the tennis fraternity alleged double standards in the way the global bodies and authorities handled the issue. Sinner acknowledged that he had the resources to put together a team of qualified people to deal with the doping case, which has created a stir in the tennis community in the lead-up to the US Open.Some notable names in tennis, including Nick Kyrgios and Denis Shapovalov, hinted at preferential treatment for Sinner after the Australian Open champion escaped sanctions despite testing positive twice for a banned substance in March 2024. Sinner tested positive for Clostebol -- a synthetic anabolicandrogenic steroid that is banned by the World Anti-Doping Agency (WADA) -during the Indian Wells tournament. Sinner's positive test was followed by another positive out-of-competition sample eight days later. He was provisionally

suspended but successfully appealed, allowing him to continue competing on tour. The swift action taken by Sinner's team after the two positive tests helped the young Italian avoid bigger sanctions.

SINNER'S DOPING CASE: EXPLAINED

The International Tennis Integrity Agency (ITIA), which investigated the doping case and held a hearing in August, accepted Sinner's explanation that the banned substance entered his body unintentionally when he was given a massage by his Clostebol. The ITIA concluded that the doping violation was not intentional, resulting in no period of ineligibility. It's also in the position where you are. Obviously, being where I am, I have the ability to take qualified people. Obviously, if this happens to a different player, it's going to be different, but again, I was treated like everyone else," Jannik Sinner told ESPN ahead of US Open 2024."The reason why I kept playing is because we (the team) knew

exactly how it (the banned substance) entered my system and where this clostebol was from, no? And this was in the spray. All things considered, I have not had any different treatment," he added.

'HOPE PEOPLE UNDERSTAND ....'

Sinner explained how the last few months were taxing for him as he awaited the judgement in his doping case. The numero uno of men's singles tennis urged people to understand why he was allowed to continue playing on the tour despite the positive tests. physiotherapist, who had used a spray with Sinner said he is looking forward to focusing on the job at hand as he begins his bid to win his maiden US Open crown.

"The process was very long. It was an even bigger wait towards the end, because when you feel like, 'okay, the result is coming', you still don't know what's coming out, but it was not an easy period for me," Sinner said."It has been a very tough time. It has been a doubtful time. I am happy that this finally is over, so a lot of weight on my shoulders is gone.
