

Three new criminal laws biggest reform of 21st century: Amit Shah

Chandigarh, August 4: Union Home Minister Amit Shah on Sunday dubbed three new criminal laws as the "biggest" reform of the 21st century, saying their objective is to ensure people get justice. He also said after the complete implementation of these laws-Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik



Suraksha Sanhita (BNSS) and Bharatiya Sakshya Adhiniyam (BSA) - India will have the most modern and technology-equipped criminal justice system in the world. Shah was addressing a gathering after launch ing the e-evidence, Nyay Setu, Nyay Shruti and e-summon systems to augment the criminal justice apparatus here. The BNS, the BNSS and the BSA, which came into effect on July 1, replaced the British-era Indian Penal Code, Code of Criminal Procedure and the Indian Evidence Act, respectively. Shah said Chandigarh will be the first administrative unit in the country where hundred per cent implementation of all the three laws will be completed in the next two months. He said these new laws through which the criminal justice system is run are the "biggest" reform of the 21st century. "Technologically we will be ahead in the world when these laws are completely imple mented... According to the spirit of the Constitution, these citizen-centric laws have been framed," he further said. "The BNS, BNSS and BSA are the laws made by elected representatives in Parliament and for the people of India. It has the fragrance of Indian soil and also the culture of our justice," he stressed. Shah said the purpose of these laws is to give justice to the people. Asserting that the Constitution is not just a book, it is a spirit, Shah said, "Every person has dignity and rights. It is the Constitution's responsibility to ensure that every person gets justice. The medium to bring this spirit of the Constitution to the ground is our criminal justice system." He said that a lot of changes have been made in these three new laws. "You will be able to register FIR through electronic medium. Strict provisions for mob lynching have been made in this law," the Union home minister said. Fleeing the country after committing a crime here will not be easy now, he

New Delhi, August 4: Almost 15 months after reserving its verdict on the Delhi Government's petition challenging the Lt. Governor's power to nominate aldermen to the Municipal Corporation of Delhi (MCD), the Supreme Court will pronounce it today. Amid a raging controversy over nomination of 10 aldermen to the MCD, a Bench of CJI Channdrachud, Justice PS Narasimha and Justice JB Pardiwala had on May 17, 2023, reserved the verdict on Lt Governor VK Saxena's controversial decision to nominate 10 members (aldermen) without the aid and advice of the council of ministers. While reserving the verdict, the Bench had said that giving such power to the Lt Governor will mean he can destabilise the elected civic body as they would get appointed to the standing committees and have vot-

Court sentences 17 people for stripping woman in Rajasthan

Jaipur, August 4: Nearly a year after a 20-year-old pregnant woman was stripped and paraded naked in Rajasthan, a district court has sentenced 14 men, including her husband, to seven-year imprisonment while noting that it was a "heinous crime" similar to the one committed in Manipur. Chief Judicial Magistrate, Pratapgarh, Ramkanya Soni on Saturday also sentenced three women involved in the case to five-year imprisonment, Special Public Prosecutor in the case, Manish Nagar said. While observing that women are revered in the country as goddesses and that the ancient scriptures also mention honouring women, he said violence and atrocities are continuing on women in 'kalyug' (depraved and final age of Hindu world cycle). "It was a serious crime committed against the woman by the accused. Similar heinous crime was committed in Manipur. Such crimes cause emotional hurt to women. Strict steps are necessary to curb crime against women then only crime will reduce," the judge said in the order. MP's Sagar Sagar, August 4: Nine children were killed and two others injured as a wall of a dilapidated house collapsed in Madhya Pradesh's Sagar district on Sunday, a senior official said. Rescuers to be deployed in spots where chances of recovery of bodies high

Wayanad, August 4: Rescue operations will continue in the landslides-hit areas in this north Kerala district on the sixth day with more force and equipment being deployed in spots where chances of recovering bodies were high, state Tourism Minister PA Mohamed Riyas said on Sunday, Rivas said search operations will continue in the 40-kilometre stretch of the Chaliyar river, which flows through Wayanad, Malappuram and Kozhikode districts, as many bodies and remains were recovered from it near Nilambur in Malappuram. In Mundakkai and Chooralmala areas, devastated by the landslides, that were segregated into six search zones, the operations will continue in the same way as in the last few days with more force and equipment being allocated to spots where chances of finding remains under the debris were high, the minister told a TV channel. Regarding the rehabilitation of the survivors, Riyas said discussions

need to be held with everyone, especially to the views of those living in the relief camps and those admitted to the hospitals. "Priority will be given to the views of those in the camps and hospitals," he said. But the discussion will not be held now, it will take place once the survivors are in a state of mind to talk about it, he added. The minister said immediate interventions will be carried out to help those who have lost identification and other important records. Steps will also be taken to ensure that the education of children in the landslides-hit areas is not hampered in any manner, Riyas said. According to the district administration, till Saturday night, 219 bodies and over 143 body parts were recovered with 206 persons missing. Advanced radars, drones and heavy machinery were used by rescue teams on Saturday, the fifth day of the tragic landslides that killed hundreds in Wavanad district, to locate survivors or deceased. The state government had also announced plans to establish a new township to rehabilitate displaced victims.

TMC asks West Bengal Jails Minister Akhil Giri to resign

Kolkata, August 4: The Trinamool Congress (TMC) on Sunday asked West Bengal Jails Minister Akhil Giri to resign and apologise to a woman officer of the state forest department following a controversy over video clips showing him threatening and verbally abusing her. Speaking to reporters at Kanthi in Purba Medinipur district, Giri said he would resign but not apologise. Giri, who is the MLA of Ramnagar within which the area is situated, was flanked by locals when he was seen in videos threatening forest ranger Manisha Sahu, warning her of reducing her tenure after she and her team removed encroachments on forest department land near Tajpur beach. "Following party instructions, state president Subrata Bakshi called Akhil Giri on Sunday afternoon, instructing him to apologise to the woman officer and submit his resignation immediately," TMC spokesperson Shantanu Sen said. Giri said there was "no question of apologising to any official," but he regretted his remarks made in an agitated state on Saturday. "I will email my resignation tonight and hand it over personally to Chief Minister Mamata Banerjee tomorrow in the Assembly,' he added. Another TMC spokesperson Jaiprakash Majumdar emphasised that the party does not tolerate such behaviour from its members and acknowledged that Giri's outburst had somewhat tarnished the party's image. Incidentally, two years ago in 2022, Giri's controversial remarks about President Droupadi Murmu were severely criticised.

Assam Government to bring law soon for life imprisonment in 'love jihad' cases: CM Himanta Biswa Sarma

Guwahati, August 4: Assam Chief Minister Himanta Biswa Sarma on Sunday said his government will soon introduce a law for life imprisonment in cases of 'love jihad'. He also said several measures have been initiated to "protect" the land rights and government jobs for indigenous people. Speaking at the state BJP's extended executive meet here, Sarma said, "We spoke about 'love jihad' during the elections. Soon, we will bring a law, which will award life imprisonment in such cases." The term 'love jihad' is used by right-wing groups to allege a ploy by Muslim men to lure Hindu women into religious conversion through marriage.Sarma said a new domicile policy will also be introduced soon, under which only those born in Assam will be eligible for state government jobs. Asserting that his government has been working to protect the rights of indigenous people, the CM said they have been accorded priority in the "one lakh government jobs" provided as per a pre-poll

complete list is published. Seed replacement rate drops as farmers buy from open market

BHUBANESWAR: Though broadcasting (seed sowing) of kharif paddy is almost over and raising of nursery and transplanting of paddy going on in full swing across the state, sale of certified paddy seeds to the farmers till date continues to be less than 50 per cent. The state government has programmed to supply 4.38 lakh quintal-quality seeds to farmers for the kharif crops in 2024. The target for supply of paddy seeds was 3.8 lakh quintal as against a requirement of nearly 8 lakh quintal at the rate of 20 kg per hectare. According to latest figure available from the state-run Odisha State Seeds Corporation (OSSC), the agency responsible for production and supply of certified seeds to the farmers of the state, only 1.85 lakh quintal of paddy seeds have been sold which is 47 per cent of the target. Sale of certified seeds is a measure of seed replacement rate (SRR) of cropped area covered with quality seed. SRR has a direct bearing on productivity augmentation and enhancement in farmers' income and is one of the means for doubling the farmers' income. Curiously, the SRR of the state is rapidly reducing after introduction of direct benefit transfer (DBT) scheme in 2015-16," sources in the corporation said. Prior to the introduction of DBT, the corporation was selling about 5 lakh quintal of paddy seeds when farmers were getting the subsidy benefit directly. After DBT came into play, most of the farmers preferred to buy from the

Agriculture department cracks down on spurious paddy seeds in Odisha

BARGARH: As kharif cultivation picks up after phase of deficient rainfall, the district agriculture department has intensified its efforts to identify and curb the sale of spurious paddy seeds to protect farmers from further distress. Over the past week, the department temporarily suspended the licences of two traders and canceled the licences of four others. With 514 authorised dealers across the 12 blocks of the district, 8,500 quintal of paddy seeds were brought in for the kharif season, and approximately 6,200 quintal have already been procured by farmers. The department is currently working to determine how many farmers may have been sold spurious seeds. Chief district agriculture officer Prasanna Kumar Mishra said it is important to ensure that farmers receive genuine seeds for a good yield. "Though farmers in the district are cautious and well aware of the quality of seeds, it is our responsibility to ensure they get genuine seeds. Non-notified seeds sold for additional profit are less likely to yield good results. We have taken action against traders selling such seeds and samples have been sent for lab tests," said Mishra.

Official sources revealed that the licences of Indian Seeds Centre and Bansal Traders have been temporarily suspended, while the licences of Hari Om Traders, Meher Pesticides, Shankar Shukla Traders and Indian Seeds Corporation have been cancelled. The association of agri-traders has expressed discontent over these actions. "Non-notified seeds are not necessarily inferior. Many farmers request these seeds because of good yields in the past. Traders have also applied for permission to sell nonnotified seeds but are unaware.

Amendments sought as Tamil Nadu local body Act curbs corpn's powers

CHENNAI: The city corporation has written to the Commissionerate of Municipal Administration (CMA) seeking certain amendments in the Tamil Nadu Urban Local Bodies (TNULB) Act that supersedes the Chennai Municipal Corporation Act 1919.

A committee headed by the directorate of municipal administration, to take into consideration representations from urban local bodies, is expected to give its response in around two weeks. The state government had given the corporation two relaxation periods of six months each to help ease the transition, which ended in March this year. Officials now expect far-reaching consequences for the Chennai Corporation with diminished powers for the corporation commissioner and the mayor. Officials, who are not eligible for promotions as per the new Act are in a state of unrest, pressuring the civic body to fight the Act.

As per the TNULB Act, the commissioner who was able to accord administrative sanction up to Rs 3 crore can now accord sanction only up to Rs 1 crore. The mayor can now only sanction projects up to Rs 2 crore, from the earlier Rs 4 crore.

"As far as Chennai is concerned, the limit should be higher than what is stipulated," a senior corporation official said. "The sanctioning powers will come down further in case the common rules, which are now applicable only for corporations other than Chennai, are also applied here. In this case, the commissioner can only accord sanction up to Rs 30 lakh. For projects of a higher value, the council has to pass a resolution that will be sent to the state to be passed as a GO. This will take significantly longer for the projects to take off," the official added.

PUDUCHERRY: In a significant breakthrough, the Puducherry cyber crime police have arrested four people from an apartment in Bengaluru in Karnataka for their alleged involvement in a nationwide job scam that defrauded over 3,400 people. The accused, identified as Shubham Sharma (29) and Niraj Gurjar of Morena in Madhya Pradesh, Deepak Kumar (28) of Nawada in Bihar, Raj Gound (23) of Basti in Uttar Pradesh, were part of an extensive cybercrime network operating across multiple states. The investigation was launched following a complaint from Ramesh Kumar, an engineering graduate from Lawspet. Kumar had contacted a mobile number listed on a Facebook advertisement offering job opportunities abroad. He was promised an executive job in Canada with a salary of Rs 2.5 lakh per month and was subsequently asked to pay for various expenses, including a visa (work permit), medical examination, and insurance.

Believing the promises, Kumar deposited a total of Rs 17.71 lakhs into multiple bank accounts over time. However, after receiving no response for a while, he complained with th Puducherry Cyber

Keerthy went to Kolkata and was able to trace the fraudulent bank accounts to Murshidabad in West Bengal. However, they discovered that the address and Aadhaar number linked to the account holder were fake. The police then traced



the four suspects to an apartment in Bengaluru, where they were apprehended. Crime Wing. A team led by Inspector B C During interrogation, it was revealed that

the accused were part of a larger network led by Azam Khan from Uttar Pradesh. This network diverged into several groups and had defrauded over 3,400 people, amassing more than Rs 200 crores by promising overseas job placements. The

accused received 50% of the defrauded amount as commission from Azam Khan, enabling them to purchase luxury items, including a car worth Rs 22 lakh and a flat for Rs 16 lakh, with an advance payment of Rs 12 lakh.The police seized 21 cell phones, two passports, 42 SIM cards, a laptop, 64 ATM cards, and Rs 41 lakh in cash during the raid. The accused were remanded in custody.

Police from nine states, including Karnataka, Tamil Nadu, Uttar Pradesh, Madhya Pradesh, Gujarat, Delhi, Assam, Telangana, and Uttarakhand, are also looking for the suspects in connection with fraud cases associated with them. Madras HC bins government order, sets woman convicted of infant's murder free

CHENNAI: Quashing an order of the Tamil Nadu Home department denying premature release of a life convict, the Madras High Court on Friday directed the superintendent of Puzhal prison to release her within two days of receipt of the order.he court passed the orders while hearing a writ petition filed by Manikandan, husband of the convict Poovarasi, who had contended that she was eligible for a premature release based on a November 2021 G.O, allowing release of convicts who had completed 10 years of actual imprisonment as on September 15, 2021, subject to certain conditions. The 2011 G.O. was announced as a one-time measure in commemoration of the 113th birth anniversary of former TN chief minister CN Annadurai. In October 2023, the government issued a G.O. and rejected her claim for early release based on the 2021 G.O, citing her involvement in the heinous crime of



murdering a three-and-a-half-year-old child and that her case had not been recommended by the state level committee for consideration. Another reason for the government rejecting Poovarasi's claim was the contention that the 2021 G.O. was only for those who were eligible for release as on September 15, 2021 and that it could not be extended later to persons even if they fulfilled the requisite conditions on a later date.Ordering her release, Justice MS Ramesh and Justice Sunder Mohan

completed 10 years of imprisonment on September 15, 2021, while the reason that the G.O. could not be applied to her is not legally sustainable.Poovarasi's probation officer had given a favourable recommendation for her release in his latest report on July 19, 2024, indicating no threat or danger to her or any other person. It was a negative report three years ago that had been used by the director general of prisons to reject her petition for early release. The judges cited the Supreme Court's case of Shor vs State of Uttar Pradesh which pointed out that merely stating that a crime was heinous and that release of prisoners would send out a wrong message against the justice system could not alone be a factor for rejection. Telangana best state for organ transplantation

HYDERABAD: Telangana was honoured as the best state for organ and tissue transplantation, by the Union Ministry of Health and Family Welfare on Sunday, receiving the prestigious award for its outstanding achievements. The accolade was presented during the 14th Indian Organ Donation Day ceremony, organised by the National Organ and Tissue Transplant Organization (NOTTO) in New Delhi. This recognition celebrates Telangana's remarkable Jeevandan Cadaver Transplantation programme, which has facilitated over 5,000 organ donation and 550 transplantation in the state since its inception in 2012.

According to the Health Department's latest report, the Jeevandan initiative has successfully retrieved 5,541 organs and tissues from 1,456 cadaveric donors and performed 550 transplants free of charge under the Arogyasri health scheme. Currently, 40 government hospitals across the state are authorised to perform transplants, including prominent institutions such as the Nizam's Institute of Medical Sciences (NIMS), Osmania General Hospital and Gandhi Hospital, with NIMS serving as the designated authority for cadaver transplantation (AACT). The Jeev programme operates in compliance with the Transplantation of Human Organs and Tissues Act (THOTA-1994), implementing various initiatives such as hospital licensing, coordinator training, an online portal and awareness programmes.

In 2023, Telangana achieved a notable donation rate of 5.48% per million population (PMP), against India's average organ donation rate of 0.8 pmp for the year.On National Organ Donation Day, Jeevandan honoured 143 donor families at Gandhi Medical College, acknowledging their contributions.

The union ministry of health and family welfare on Sunday recognised Telangana as the best state/best state organ and tissue transplantation organisation (STTO) and presented the award for the same. Statistics for 2023-24, reveal that 200 donors donated 729 organs - 287 kidneys, 173 liver, 15 hearts, 176 cornea, 76 lungs and two pancreas. For 2024 so far, 103 donors have donated 421 organs -170 kidneys, 100 livers, 15 hearts, 94 corneas and 42 lungs - bringing the total for 2023 and 2024 to 1,150 combined organs from 303 donors.

Wayanad landslide brings into focus need for people-centric early warning system

KOCHI: Can landslides be predicted hyperlocally, thereby preventing huge loss of lives? The question becomes pertinent in the wake of the Wayanad landslides amid reports that the authorities may have ignored warnings about an impending disaster following the forecast of heavy rain in Mundakkai, the epicentre of the devastating natural calamity. While a prediction with precise accuracy is near impossible, experts working on the ground in Wayanad reckon warnings can be issued to the residents in the landslide-prone areas after analysing micro-rainfall data. Along with the micro-rainfall data, close tracking of the cloud movement pattern and an analysis of the wind and its wind speed would go a long way in more accurate and actionable forecasts on landslides, thereby saving lives, say experts. After the 2019 flood havoc claimed 17 lives at Puthumala in Wayanad, 200 rain gauges were set up across the hill district with the help of local farmers and groups to record micro-rainfall

data in a move to prepare the people on rainfall-related havoc. This had an effect when the authorities evacuated people when 55 rain gauges recorded 1,000mm rainfall within a short period in and around Mundakkai. While several houses were destroyed, there were zero human casualties as hundreds of people in the area were shifted to safer places.

This time too, the warnings were issued, but there are criticisms from several quarters that the district administration may not have communicated the dangers to the people effectively. "After the heavy rains and warnings issued, there may have been some complacency among the people as the rains stopped and the sun came out on Monday (it rained heavily that night and the landslide occurred early Tuesday)," explains Deepa C B, assistant director (soil survey), Wayanad.But after the catastrophic landslide swept away Chooralmala, Attamala, and Mundakkai villages in Wayanad, there will be more

"Ours is a simple logic. If such a large amount of rain comes in an unstable slope, there are high chances of a landslide. If we can create awareness among the people



living in the area, we can shift those people to safer places. Sometimes, a landslide may not occur. But we can predict with 70% accuracy about landslides," says Dr Suma T R, scientist at the Hume Centre for Ecology and Wildlife Biology, Kalpetta.

Passenger tax to fee - pvt schools' body lists demands in Haryana

GURGAON. The Federation of Private Schools Welfare Association has listed a series of demands before the state govt, addressing issues such as pledge money, property tax, passenger tax on school buses, recognition, and fee regulation. The federation has submitted a comprehensive list of 24 points and is planning to organise a state-level rally in Ambala on August 10. With the Assembly election due this year, the federation has threatened to oppose the govt if their long-standing demands are not met. The 24-point demand list also includes reimbursement for teaching students belonging to economically weaker sections under Rule 134-A of Haryana School Education Rules. "Although the rule was revoked, outstanding dues persist. The schools were compelled to continue teaching the students up to class 12, and we did not receive any reimbursement for classes 9 to 12," added Sharma. The federation demands that no tax should be levied for using buses for student transportation. "A passenger tax of Rs 20 per student per month is unjust,"

Don't chop century-old trees for police station: HC to govt

GURGAON. The Punjab and Haryana high court has asked Haryana govt not to cut any of the 150-odd century-old trees for constructing a police station and police lines in Sonipat

The court was hearing a petition on July 27 filed by the National Environment and Forest Protection Trust, raising a public cause based on a resolution passed by the Thaska gram panchayat in Sonipat in 2023.

The gram panchayat had decided to allot two acres for the construction of a police station and five acres for the police lines. However, it would have come at the cost of 150 jaal (Salvadora oleoides) trees that are over 100 years old. The bench of chief justice Sheel Nagu and justice Vikas Suri ordered, "If the concerned authorities can construct the police station and the police line without cutting or damaging even a single tree out of the 150 trees standing on the spot, then the authorities are free to do so. If the concerned authorities are unable to construct a police station and the police line without cutting the above trees, then they are restrained from cutting the trees and are well advised to find an alternate site for the construction of the police line and police station."Sandeep Goyat, deputy conservator of forest, Sonipat, stated in a report that he submitted, "It is submitted that after receiving the letter from DDPO, Sonipat, respondent no.10 along with the Sarpanch of the village Thaska inspected the spot and found that there are approximately 150 trees of Jaal (Salvadora oleoides) standing over there which are nearly a century old. Jaal tree is a rare species which is the heritage of the village, and cutting it cannot be justified."The petitioner presented photographs to the court showing the area in question. The high court noted that, besides trees, a water body was also visible

That weight-loss pill comes before you take them, say

GURGAON. Doctors in NCR have raised concerns that people are increasingly turning to anti-obesity drugs and many of them taking the pills without prescription to rapidly lose weight without keeping in consideration their side effects. Drugs like semaglutide, which is available in India, are used for diabetes and obesity treatments, and have their benefits, but any patient should get consults before taking them, doctors said. They added that these drugs aren't like over-thecounter medicines like paracetamol and can have more serious side-effects."I have noticed that patients are becoming more aware of this drug and do their research before coming for a consultation. Its high cost can be a deterrent, but one out of every 25 diabetes patients is willing to take it. Women tend to inquire about it more due to its weight loss potential," said Dr Tushar Tayal, lead consultant at the department of internal medicine in CK Birla Hospital.Dr Satish Koul, senior director and unit head, internal medicine, Fortis, said, "I have seen many youngsters, especially women, who visit a dietitian or gym trainer and have started on semaglutide without prescription. These are people with no history of diabetes and are prescribed this drug by a nonmedical practitioner. Most of these patients are on weight loss regime." Asked if these were available over the counter, Dr Koul said, "In India, who needs a prescription for buying medicines? Oral drugs like semaglutide are easily available over the counter. No

MCG seals three illegal coaching centres operating in Gurgaon basements

GURGAON. MCG on Saturday sealed three coaching centres that were operating from basements without permission. Officials said a total of 22 coaching centres were surveyed, out of which three centres were found operating illegally from basements and were sealed. The move comes a week after the basement of a UPSC coaching centre in Delhi was flooded, claiming the lives of three aspirants.MCG commissioner Narhari Singh Banger has directed joint commissioners of all zones to initiate a campaign to crack down on coaching centres running from basements without authorisation, officials said. The centres sealed on Saturday were operating in Sector 14's Old DLF Colony, Krishna Colony, and Khandsa Road. MCG's enforcement teams are carrying out a survey of coaching centres across the city, including sectors 4, 7, 14, 42, 44 and 55, and Sushant Lok 1 and 2. The teams



have directed all coaching centres to submit their documents for verification at the MCG office on Monday. The centres will have to submit documents such as MCG permit, building plan and fire

NOC.If any centre is found flouting the norms, action will be taken against them, the commissioner said. "We have initiated a targeted initiative to avert

at the coaching centre in Delhi. It is crucial to adhere to safety regulations for basement structures and ensure that emergency exits remain unobstructed during any unforeseen incidents," Banger said.On the night of July 27, three students of Rau's IAS Study Circle in Delhi's Old Rajinder Nagar were trapped in the basement after water from a drain gushed into the room. Shreya Yadav, Tanya Soni and Nivin Dalwin - all in their 20s and preparing for the public services examination drowned. There were allegations that the door to the basement had been upgraded to one with a biometric system and got jammed when the water gushed in. Seven persons, including the owner of the institute, have been arrested. Since then, dozens of institutes running out of crammed buildings have been sealed across Delhi-NCR for throwing caution to the wind.

Bad earthing or sparks cause of fire that killed 16 in Haryana's Rewari

GURGAON. An electrostatic charge caused by improper earthing or a spark from a buffing machine shortcircuit caused the explosion that killed 16 workers at a factory in Rewari in March, the National Safety Council of Navi Mumbai has specified in a report. The document was also sent to the National Green Tribunal, which had taken suo motu cognizance of the blast.An audit team from NSC, comprising three expert members and the company's senior officials, visited Lifelong Pvt Ltd in Dharuhera town of Rewari in April to analyze the post-accident situation. "CCTV footage showed that the fire started near one of the buffing machines. No serious lapses or gross negligence were found during the inspection," the report said.

The spark is believed to have ignited fine



a PVC suction pipe and aluminum dust to catch fire and smolder.

The explosion injured 38 workers, with 16 later succumbing to their injuries at hospitals in Rohtak and Delhi.

GURGAON: Saturday morning was both cloudy and humid, with the minimum temperature rising by two notches to 27 degrees Celsius, up from Friday's 25 degrees and a notch above the season's normal. The daytime temperature rose slightly to 33.2 degrees Celsius from 33 degrees Celsius on the previous day. It was a notch below the normal. Pak-origin man set on fire in Canada, was involved in protests after Nijjar killing

World A Pakistani-Canadian businessman, who was involved in protests after the death of Khalistani terrorist Hardeep Singh Nijjar, was set on fire by an unidentified man in Canada's Surrey city in British Columbia

Rahat Rao was set on fire by a man aged 24 or 25 years on Friday. He was hospitalised and his condition is critical. According to sources, Rao is not an agent of Inter-Services Intelligence (ISI), Pakistan's intelligence agency.Rao is very active in Canada and was continuously involved in many protests after the death of Nijjar in June last year.

On June 18 last year, Nijjar was shot dead outside a gurdwara in Surrey. His name had been included in a list released by the Indian government with 40 other 'designated terrorists'. His death sparked a major diplomatic row between India and Canada after Canadian Prime Minister Justin Trudeau last September alleged a potential involvement of Indian government agents in the killing of the Khalistani terrorist.

India vehemently rebuffed Trudeau's claims, calling them "absurd" and "motivated".

Ukraine accuses Russia of killing and dismembering prisoner of war

Kyiv.Ukraine's human rights commissioner urged the International Committee of the Red Cross (ICRC) and the United Nations to investigate an image widely shared online on Saturday that he said likely showed a Ukrainian prisoner-of-war killed and dismembered by Russian forces. Ukraine's prosecutor general said separately that an urgent investigation had been launched into information being spread on social networks about the murder and dismemberment of a Ukrainian POW.A photograph, probably of a Ukrainian prisoner whose head and limbs were cut off by the Russians, has appeared online," Dmytro Lubinets, the country's leading human rights official, said in a post on the Telegram messaging app."In view of these horrific images, I have urgently appealed to the ICRC and the UN to record yet another human rights violation by the terrorist country," Lubinets wrote. Andriy Kostin, the prosecutor general, said an urgent investigation had been launched. "Russia consistently repeats the crimes of the Nazis, defiantly showing utter contempt for all norms of the civilised world," he wrote on Telegram.Russia denies torture or other forms of maltreatment of POWs.A United Nations commission of inquiry on Ukraine said in a report published in March that it had documented credible allegations of executions of at least 32 Ukrainian POWs in 12 separate incidents from December 2023 to February, and that it had independently verified three of the incidents.

The three-member Commission of Inquiry said it had also gathered more evidence that Russia had systematically tortured Ukrainian POWs, documenting rape threats and the use of electric shocks on genitals. It said the scale of such torture cases may amount to the most serious abuses known as crimes against humanity, describing their occurrence as "widespread and systematic".

Stop bulls***g me, furious Biden told Netanyahu amid Mideast tensions: Report

World Days after the killing of Hamas Political Bureau Chief Ismail Haniyeh in an Israeli strike in Iran, US President Joe Biden told Prime Minister Benjamin Netanyahu to "stop bullshitting me" during their conversation on Thursday, Channel 12 News reported without citing any official sources.

This comment came after Netanyahu informed Biden that Israel was advancing negotiations on a hostages-



for-ceasefire deal with Hamas and would soon send a delegation to resume talks. President Biden concluded the conversation by saying, "Don't take the president for granted."As per the report, this remark was made in the context of Israeli-US cooperation in anticipation of a possible full-scale war with Iran and its proxies.

This comes amid escalating tensions, as Iran and Tehran-backed groups have vowed revenge for the recent assassinations of several of their leaders. President Biden has rallied regional powers to assist in repelling Iran's unprecedented missile-and-drone attack on Israel during the night of April 13–14.

Responding to the report, the Israel Prime Minister's Office issued an official statement later on Saturday, stating, "The prime minister does not interfere in American politics and will work with whoever is elected president, just as he also expects the Americans not to interfere in Israeli politics," The Times of Israel reported. Meanwhile, after President Joe Biden's decision to drop out of the US presidential election race, Benjamin Netanyahu is feeling emboldened to take stringent action against Iran, a senior Israeli official told The Telegraph.

The official stated that the US President was trying to "restrain" Netanyahu while he was still running for re-election."He told him not to respond too harshly to Iran's attacks. And Iran knew this, which is why they exploited the situation to attack Israel," the official was quoted as saying by The Telegraph in its

Judge 'finds no basis' to dismiss Trump election case, sets hearing date

Washington The federal judge presiding over the election subversion case against former US President Donald Trump rejected Saturday a defence effort to dismiss the indictment on claims that he was prosecuted for vindictive and political purposes. The ruling from US District Judge Tanya Chutkan is the first substantive order since the case was returned to her Friday following a landmark Supreme Court opinion last month that conferred broad immunity for former presidents and narrowed special counsel Jack Smith's case against Trump.In their motion to dismiss the indictment, defence lawyers argued that Trump was mistreated because he was prosecuted even though others who have challenged election results have avoided criminal charges. Trump, the Republican nominee in the 2024 presidential race, also suggested that President Joe Biden and the Justice Department launched a prosecution to prevent him from winning re-election.But Chutkan rejected both



arguments, saying Trump was not charged simply for challenging election results but instead for "knowingly making false statements in furtherance of criminal conspiracies and for obstruction of election certification proceedings." She also said that his lawyers had misread news media articles that they had cited in arguing that the prosecution was political in nature.

After reviewing Defendant's evidence and arguments, the court cannot conclude that he has carried his burden to establish either actual vindictiveness or the presumption of it, and so finds no basis for dismissing this case on those

grounds," Chutkan wrote in her order.Also Saturday, she scheduled an August 16 status conference to discuss next steps in the case. The four-count indictment, brought in August 2023, accuses Trump of conspiring to overturn the results of the 2020 election he lost to Biden through a variety of schemes, including by badgering his vice president, Mike Pence, to block the formal certification of electoral votes. Trump's lawyers argued that he was immune from prosecution as a former president, and the case has been on hold since December as his appeal worked its way through the courts.

The Supreme Court, in a 6-3 opinion, held that presidents enjoy absolute immunity for core constitutional duties and are presumptively immune from prosecution for all other official acts. The justices sent the case back to Chutkan to determine which acts alleged in the indictment can remain part of the prosecution and which must be discarded.

Kamala Harris's husband admits to cheating on first wife: I took responsibility

World US Vice President Kamala Harris's husband, Doug Emhoff, admitted on Saturday to cheating on his first wife, following a British tabloid's report claiming he once got the family nanny pregnant. He had an affair with a blonde nanny, Najen Naylor, who taught at the private school attended by his two children, The Daily Mail reported. This took place more than 15 years ago, while Emhoff was still married to his then-wife, Kerstin.A close friend familiar with the situation disclosed that Naylor became pregnant but



didn't keep the baby. Emhoff, in a statement to CNN, acknowledged the affair without mentioning Naylor's name or addressing the pregnancy. Speaking with CNN, he stated, "During my first marriage, Kerstin and I went through some tough times on account of my actions. I took responsibility, and in the years since, we worked through things as a family and have come out stronger on the other side." Meanwhile, his first wife, Kerstin, stated in a

statement on Saturday, "Doug and I decided to end our marriage for a variety of reasons, many years ago. He is a great father to our kids, continues to be a great friend to me, and I am really proud of the warm and supportive blended family Doug, Kamala, and I have built together."CNN, while citing a source, reported that the affair was disclosed to President Biden's vetting panel four years ago before he selected Kamala Harris as his running mate for the 2020 US presidential elections.

Hyderabad: Rat faeces found in food racks in hotel near airport

HYDERABAD: Amid the growing concerns over food safety in Hyderabad, the Food Safety Task Force inspected local restaurants in Shamshabad and observed several violations.On Friday, the team found that 'Yes Bawarchi Multi Cuisine Restaurant' in Shamshabad had not kept FSSAI certificate on display and the TDS of drinking water provided was found to be 24 which is lower than the mandated minimum 75. The popular restaurant had stored synthetic food colours in its store room which were later discarded by the officials. Moreover, semi-prepared and raw food articles were without lids while rat faeces were seen on the racks and floor, hence rat infestation was suspected in the storeroom. Windows were not concealed with insect-proof screens and pest control records of the premises and medical certificates for the food handlers were not available with FBO. The officials further observed the flaking plasters on the ceiling and the flooring of the kitchen was untidy and

Similarly, at Airport Bawarchi Restaurant in Shamshabad, the task force team found pest control records and other similar violations.In another restaurant, Hotel Hyderabad Grand the team found expired food articles like red chilli sauce, sweet chilli sauce, coconut milk, rosewater, fish masala and thyme. The food safety officials seized and discarded some expired food articles from the restaurant for violating food safety

Forest officials rescue saltwater crocodile from village pond in Odisha

KENDRAPARA: A stray four-foot-long female saltwater crocodile was rescued by forest officials from the pond of one Kalpataru Khanduala at Barahapur village, near Bhitarkanika National Park, on Saturday.On being informed, forest officials rushed to the spot and five forest personnel took two hours to capture the crocodile that had strayed into the village pond from the nearby Hansua river during high tide. The reptile attempted to attack a woman washing utensils in the pond, informed villagers. "Crocodiles have killed around seven people within a year in Bhitarkanika and nearby areas," said Ranjan Behera of Barahapur.



Later, the forest officials released the crocodile back to Bhitarkanika. "We roped the reptile after netting it and later released it into the Bausagada river within the park. The crocodile did not attack humans and was not injured during the capture," said Chittaranjan Beura, forest range officer of Bhitarkanika.

Forest officials have advised villagers to use water bodies cautiously, erecting barricades in ghats of rivers and ponds to prevent crocodile attacks. Many such barricades have been built around Bhitarkanika to

'Voluntary intoxication' cannot be defence against commission of crime: Orissa HC

CUTTACK: Upholding a trial court's life imprisonment sentence to a man who murdered his mother by strangling and beheading her, the Orissa High Court has ruled that a person cannot be exempted from liability for commission of murder on the ground of 'voluntary intoxication'. The incident had occurred at Nathiapali village within Odagaon police limits in Nayagarh district on May 12, 2008. Rankanidhi Behera was sentenced to imprisonment for life by the court of additional sessions judge, Nayagarh on March 10, 2010. He had filed a Jail Criminal Appeal (JCRLA) in the high court the same year.

The division bench of Justice SK Sahoo and Justice Chittaranjan Dash said, "The Penal Code does not provide for any provision which can potentially protect an accused from liability for commission of any crime, much less a heinous crime like murder, merely because he chose to intoxicate himself

before execting his culpable intention." The bench said, "The instant case has exposed this court to a very unfortunate set of facts where a son did not think twice before killing his creator, i.e. the mother. As per the above position of law, the knowledge of the appellant for commission of the crime can be well inferred, notwithstanding the fact that he was intoxicated.

Furthermore, no evidence was led from the side of the defence to show that the intoxication was so intense that it affected the ability of the appellant to form intention to commit the

Telangana Record of Rights Bill addresses issues in earlier Act

HYDERABAD: The Telangana Record of Rights Bill (Draft), 2024, has dealt with many issues which were left unaddressed in The Telangana Rights in Land and Pattadar Pass Books Act, 2020.

The draft Bill has eliminated the need for stakeholders to approach civil courts for correction of land records. Significantly, the draft Bill also lists provisions for preventing fraudulent mutations, among others. The Telangana Rights in Land and Pattadar Pass Books Act, 2020, lacks record of rights for abadi lands, provisions for resolving part B cases, inquiry before mutation, provisions for mutation in case of sales certificate, 38E (ownership of lands held by protected tenants), Occupancy Rights Certificate (ORC), and assignment patta, survey and subdivision before registration and mutation, provision for creating unique land parcel identification number, appeal and revision, regularisation of Sada Bainama, and linkage to village accounts (Pahani).

In contrast, the newly proposed draft Bill has provisions for all the aforementioned issues.Interestingly, the draft Bill also proposed provisions for linking revenue records to villagelevel land accounts. The previous BRS government stopped recording the land transactions after the roll out of Dharani portal, the integrated land records system.

While the Telangana Rights in Land and Pattadar Pass Books Act, 2020, was a document of 12 pages, the proposed new bill runs into 24 pages which indicates the meticulous work done in identifying and addressing the issues. The state government has kept the Telangana Record of Rights Bill (Draft), 2024, in public domain, on the website https://ccla.telangana.gov.in enabling the general public to go through its contents and make recommendations and suggestions. The state government asked the public to send their suggestions and recommendations at their official email id "ror2024-rev@telangana.gov.in", and also to send them by post to the Chief Commissioner of Land Administration (CCLA).

The state government is likely to introduce the Bill in the next Assembly session.

Empowering girls with self-defence skills

RAJANNA-SIRCILLA: The district police have launched Operation Jwala, a self-defence training programme aimed at improving women's safety and confidence. Following the success of the first phase of the programme conducted last year, the police will again be imparting martial arts and self-defence techniques to girls in government institutions.Superintendent of Police (SP) Akhil Mahajan tells TNIE: "With Phase-II of Operation Jwala, we hope to further instil confidence among schoolgirls. Coordinated with the education department, the programme schedules a daily training period in all government schools. Around 2,000 girl students from Classes VI to X in 100 government schools are receiving selfdefence training."The SP said that priority

The SP says that despite the eforts of the is being given to women's safety. "The efforts of SHE teams, which work to protect women and girls, are there to see,"

he says. Mahajan explains the impetus for the programme was an incident where a girl reported harassment at bus stations and on her way home. "Though the SHE teams resolved the issue, the need for a



permanent solution led to the creation of Operation Jwala," he says.

police, incidents like harassment at Thangallapally hostel mean that such training programmes are needed. Martial arts instructors, including women, have been appointed by the police department. Md Naseema, one of the instructors, tells TNIE that strength is not required for self-

defence. She says techniques are the key. A Class VIII student, A Poojitha, shares that the training has built her confidence, and says that she feels more secure travelling to and from school.

Additional safety measures

In conjunction with Operation Jwala, the police department has also launched the "Bus-lo Bharosa" programme to enhance security in TGSRTC buses. CC cameras have been installed in 125 ses from Palle Velugu to AC bus services of Sircilla and Vemulawada depots. These cameras are connected to a command control cell to monitor women's safety and prevent harassment.

Robust marketing can boost handloom sector, say handloom activist

BENGALURU: Despite the capacity of the handloom sector to provide sustainable employment opportunities by tapping into the booming global market for eco-friendly and natural handwoven fabrics, it remains underutilised.Stakeholders and experts voice that the numerous handloom corporations, be it silk, wool or yarn, need to be promoted and built on the lines of milk federations in the state. The Congress-led Karnataka government in its 2023 budget had announced of a special cell called 'Mahatma Gandhi Vastrodyama' (MGV), to bring together designers, weavers, yarn producers and allied workers on a common platform. However, the project is yet to kickoff, and has not progressed beyond a few meetings at the initial proposal stage. With the Handloom Day just around the corner Handloom activist Prasanna Heggodu said, (August 7), stakeholders held a discussion on how implementing MGV can improve the condition of weavers, and the untapped



potential of the sector.

"The economic liberalisation has only benefitted top sectors and failed to penetrate into the rural economy. The MGV is a viable

workable model to meet this gap. Today, the spinning centres in the state and in India have already died down."Through MGV we are not demanding funds from the government, just loans and infrastructure need to be

provided on lease, to revive the dying corporations. We need a robust state-of-theart marketing facility for pure handloom and this model has the potential to provide it," Heggodu emphasised.

Designer and handloom revivalist Pavithra Muddaya explained the dire conditions of the weavers in interior Karnataka. "They feel defeated. A collective effort is needed to revive the industry. No weaver today wants their child to become a weaver, as they see no opportunity for growth in it. The other problem is that half of the weavers from Karnataka are illiterate, and are not registered. They are unable to use government benefits and often struggle because of middle-men," she said. The proposed MGV aims to indirectly provide large-scale rural livelihoods by providing state-of-the-art marketing backup for their products. If this is implemented, Karnataka will be the first such state to do so.

Bengalureans lost Rs 845 crore, 9,260 cases filed in first six months of 2024

BENGALURU: Bengalureans lost a whopping Rs 845 crore to cybercriminals in the first six months of this year. Of all the cases, the debit and credit card fraud was the most rampant, accounting for 1,485 of the total 9,260 cases. The victims were swindled of Rs 41.53 crore in this scam. Investigators highlighted a consistent pattern in the debit and credit scam – all calls were made using Voice over Internet Protocol (VoIP) services, which mask the caller's true location with 'international numbers' and make tracing impossible. Over half of the complainants had used public wi-fi for transactions before falling victim."When we verified the calls made to the victims, they all had different country codes, like +44, +7, and +07, but

none from +91 (India), which can be traced," an official said. Most victims also reported accessing wi-fi at hotels, lounges and other places before making the transactions, he added.In the first two months of this year, the total loss to cybercrimes amounted to Rs 240 crore. But over the next four months, they have skyrocketed to Rs 845 crore. The official said public wi-fi networks are often unencrypted, making it easy for cybercriminals to intercept data transmitted between your device and the network. "Avoid accessing sensitive information or performing financial transactions over public wi-fi. Switch to VPNs for encrypted connections," he suggested to the people.



Asked why suspected hefty transactions are not blocked, a bank official said if such a measure is implemented, it could lead to It happens when someone steals credit or debit widespread complaints. "Customers would argue that the bank is obstructing their transactions by imposing lengthy procedures," the bank official said, terming

the measure impractical.A senior police official said that current measures, specifically "awareness campaigns," are just an eyewash. As educated individuals are losing money, mere awareness will not work. Only an all-out war against cybercrimes can be the solution. The current approach fails to address the gravity of the situation, and without aggressive action, these financial losses will continue to spiral out of control, he warned.

Dengue alert: What to watch out for to avoid severe infection



As the monsoon advances and moisture becomes the ideal condition for mosquitoes to breed, dengue outbreaks are overwhelming cities in Karnataka, Kerala and Maharashtra. But we can manage this disease if we are vigilant.

Dengue fever presents itself with a sudden onset of fever, severe headache, pain behind the eyes, muscle and joint pains, nausea, vomitting, swollen glands and a rash. These usually appear 4-10 days after the mosquito bite and can last for 2-10 days. Early diagnosis is necessary because it can quickly transform into severe dengue, also known as dengue hemorrhagic fever or dengue shock syndrome, when the number of clotforming cells (platelets) in your bloodstream drops and your blood vessels are damaged enough to be leaky. This can lead to shock, internal bleeding and organ failure.

WHEN TO TEST FOR DENGUE?

If you have the symptoms listed above, go for the dengue NS1 antigen test, which measures the non-structural protein of the virus, or PCR tests. Then take the IgM antibody test on the fourth or fifth day when you are most likely to pick it up. Get a complete blood count (CBC) done and if diagnosed, repeat it on alternate days to check for platelet levels. One of the most important markers is the PCV (packed cell volume), which is a measure of blood viscosity. This indicates an increase in red blood cells or dehydration. WHY HYDRATION IS IMPORTANT?

Usually, the patient feels better after the fever subsides in four to five days. And if the patient has not kept themselves well-hydrated to compensate for fluid loss due to fever and vomitting, complications could arise after Day 4. Have between three to five litres of water or oral rehydration solutions, coconut water and clear soups. Severe dengue can lead to plasma leakage and intravenous (IV) fluid therapy may be required in a hospital setting.

HOW TO PREVENT SEVERE DENGUE

Regular blood tests to monitor platelet levels and importantly hematocrit levels can manage complications. Hematocrit level is simply the percentage of red cells in your blood. In dengue, an increased hematocrit is a clue for plasma leakage, whereas a decreased hematocrit is a clue for bleeding. If platelet levels drop significantly, medical intervention may be necessary.

The hematocrit level should be monitored every 24 hours to facilitate early recognition of dengue hemorrhagic fever and every 3-4 hours in severe cases of dengue hemorrhagic fever.

Pain relievers and fever reducers like paracetamol can help manage the symptoms. Avoid nonsteroidal anti-inflammatory drugs (NSAIDs) like aspirin and ibuprofen, as they can increase the risk of bleeding, which is a serious complication

Do not exert yourself when you feel better, rest is important to not aggravating this condition.

IS THERE A VACCINE? In some regions, a dengue vaccine (Dengvaxia) is available and recommended for individuals who have been infected previously. In India, trials are ongoing but finding one vaccine to tackle four prevalent virus strains is a challenge.

Machine-made fake research leading to digital inbreeding

Reese Richardson published papers in academic journals supposedly coauthored with his grandmother's cat, Larry. A service that helped the cat's 'career' claimed to have helped Indians too. The tsunami of Al-generated work is dangerous because governments can make big decisions based on it

Research recently published in Nature suggests that intelligent machines planning to replicate themselves for world domination are doomed to failure. This means that the Terminator genre of science fiction stands discredited. But we mustn't despair, because a fun hack has shown that following the loosening of norms in scientific publishing and the entry of digital entities in education, even a house cat can pose as a renowned scientist and get away with it.

The present learned cat is Larry Richardson. He is technically the uncle of researcher Reese Richardson, since he is his grandmother's cat. He was enrolled into the research rat race to overawe pioneering Siamese cat academic FDC Willard, whose initials stand for Felis Domesticus Chester. FDC Willard is not a fraud. He studies helium. He entered STEM when his human, professor emeritus of physics and astronomy at Michigan State University, Jack Hetherington, wrote a paper solo using the royal 'we'. Instead of laboriously replacing 'we' with 'I' throughout, he promoted his cat to researcher and shared credit with him.

Hetherington & Willard produced real work, which was really cited. The fact that FDC Willard became a popular meme cat does not detract from the physics he lent his awesome name to. In contrast, Larry signed off on completely fake papers generated using SCIgen and Mathgen, services that write up garbage papers in computer science and math using compelling technical jargon. These prank services help show how easily rubbish can be published to increase academic ratings, cutting through safeguards and bypassing peer review. A journal discredited itself by accepting the first Mathgen garbage paper in 2012, and 12 years later, Larry has used the same service to breach the ceiling for

Reese Richardson generated 12 fake papers by Larry, complete with references and citations, and used them to give the cat a fine profile on Google Scholar, whose ratings universities consult when hiring. The hack is to upload garbage papers to Researchgate, wait for Google to pick them up, then delete them. They linger on Google Scholar and the process costs nothing.



This issue is important because over the last decade, there's been a wave of fake academic journals and papers. In Covid years, standards were relaxed and unvetted preprints became commonplace as researchers rushed to bring vaccines to the market in record time, and the wave swelled into a tsunami. Authorship is now sold as a commodity, both freelance and via 'paper mills'—pay up, and you can be named lead researcher of a real or garbage paper. Journals have grown faster than papers in volume, indicating some of them are garbage bins.

The world's most populous country has contributed to the problem since 2010, when UGC made it compulsory for Indian college teachers to publish research to advance careers. Since India has thousands of institutions without trained staff, funds or infrastructure fit to conduct research, plagiarism and fakery have boomed. Larry's academic career began when Reese Richardson's attention was drawn to a service that offered to improve profiles on Google Scholar. All but two of the scholars it claimed to have helped were Indians.

With the rapid entry of AI into almost all aspects of life, fake content is no longer just an academic concern. For financial gain, AI is being used to fill millions of sites with garbage. Since AIs are trained on terabytes of content scraped from the internet, it is only a matter of time before they start using AIgenerated garbage as input.

A paper in Nature has now investigated the garbagein-garbage-out phenomenon by training generations of AIs on output of prior generations, instead of human-produced material. It worked like inbreeding in biology, which has explained the prevalence of haemophilia among European royalty. Starved of human input, the cannibal AIs became incoherent and by the ninth generation, produced only bizarre garbage. Als are not independently creative but only emulate human behaviour, so this was inevitable when human input was cut off.


The experiment used only textual material. It remains to be seen what sort of images and sounds result from digital inbreeding. Will the art be like Jackson Pollock or Joan Miró? Will degraded music be like chewed-up Kraftwerk cassettes or like Cacofonix at the feast the moment before Fulliautomatix censors

It is clear machine self-replication, which earlier attracted attention of scientists like John von Neumann and Freeman Dyson, will fail without human inputs. Sadly, that destroys credibility of most stirring dystopian fiction. We need a new genre where machines do not hunt humans but farm them to harvest their culture as input.

The fake content menace is scarier than fiction. Spacefillers that the internet has been fattened on can poison the well for AI projects, but fake academic material is even more dangerous. Governments make decisions on the basis of academic work, affecting millions of lives. Institutions, including those of academia, use it to make projections and create material that can affect almost anything—market conditions, space projects, defence planning, drug development, and teaching material for schools. Early internet marketing gurus used to say that "content is king", and the dictum was generally right. But in the age of alternative facts, it sounds ominous.

End the burden

Sulekha: A swadeshi ink flows again

Recently, I went on a visit to Kolkata and rediscovered Sulekha. Depending on which part of India you grew up in, at one point, Sulekha was a household name. Those were the days of fountain pens and ink. Who cares about fountain pens today? In this electronic world, writing is fast dying out. To the extent that writing on paper remains, but writing instruments mean ballpoint and gel pens. Fountain pens have a whiff of nostalgia about them. But rarely do people

While that statement is generally true, some fountain pen connoisseurs and aficionados still remain. There is a market, limited though it is, for fountain pens and ink. Who caters to that market? What fountain pen ink do people buy? Depending on taste-Pilot, Waterman, Lamy, Mont Blanc, Sailor, Diamine, Noodlers and so on. (Sheaffer is now Indian, having been acquired by William Penn.)

What is a fountain pen? Unlike dip pens of the past, a fountain pen possesses an internal reservoir of ink. You don't need to dip the pen into an ink pot. Once upon a time, fountain pens needed 'eye-droppers'. (They are still available.) You use a dropper to directly fill ink into the barrel. Smudges in pockets and inky fingers are associated with such eyedroppers. These days, it is either a cartridge or a convertor. A cartridge is plug-and-play and is often proprietary, not interchangeable between one pen and another. With a cartridge, there is no choice over the Indeed, the 'favourite' ink varied, depending on the ink. One is stuck with whatever the cartridge-maker provides. That's the reason many people prefer converters, where the ink goes into a tube-like gadget.

Sheaffer apart, which are the Indian ink makers and can they hold up to global competition? Bril, Sulekha, Camlin, Syahi, Krishna—you take your pick. One of the earliest was Sulekha, identified with the swadeshi movement. Satish Chandra Dasgupta had retired as chief chemist of Bengal Chemicals. Circa 1932, Mahatma Gandhi requested him to make a swadeshi ink. Satish Chandra came up with an ink named 'Krishnadhara', meaning black flow. It was sold through khadi outlets.

Dasgupta passed on the recipe to two brothers, Shankaracharya Maitra and Nani Gopal Maitra, for better commercial production. Thus, the manufacturing unit was set up as Sulekha Works in Rajshahi (now in Bangladesh) in 1934. Sulekha means 'beautiful writing'. There is an urban legend that the name was suggested by Rabindranath Tagore. But there is no evidence to substantiate this. In the late 1930s, Sulekha moved to Kolkata. There is a place in Jadavpur in South Kolkata famous as 'Sulekha More', or, Sulekha Crossroads.

When we were in school, Sulekha was the ubiquitous ink. Each bottle of 'Royal Blue' was sold with a photograph of Gandhiji on the

package. Sulekha also exported ink and set up factories on a turnkey basis in African countries. There is a report that says, in the early 1980s, Sulekha had a market share of 89 percent for ink in eastern

part of the country and the age profile of the respondent. Some will say Quink, others Camlin.

The founder of Camlin Subhash Dandekar recently passed away. Before the advent of liquid ink, all ink used to be in the form of dust and tablets to be dissolved in water to make ink. The tablets originally made by Camlin used to be called Horse. That was later changed to Camel to convey the impression of lasting a long time, since a camel can survive without water for a long period of time. Camel plus ink



became Camlin.

In common with other entrepreneurship in West Bengal, from the late 1970s, thanks to labour militancy, enterprises were hounded out and there was capital flight. It was no different with Sulekha. All production was suspended in 1988 and the company went into liquidation in 1991. That was that. Sulekha became a part of history. Those who pass Sulekha More might not even recognise what the crossroads was named after.

had some idea that liquidation proceedings were stayed by the Kolkata High Court in 2005 and Sulekha was reopened in 2006. Faced with competition, different pen and ink manufacturers reacted differently. Some closed down completely. Others diversified into stationery and unrelated products. Sulekha went into home care products and

What I didn't know, until my recent visit, is that the last four years have brought about a complete transformation. The production of ink has exploded and is doing well, with exports to neighbouring countries too. The range on offer is mind-boggling. I think there are more than 40 shades.

There is a myth that Indian-made ink isn't good for expensive fountain pens. For years, I have used Indian-made ink in my pens and they are none the worse. I am told the new Sulekha inks—there is even a permanent ink that does not wash away with water-can match the best in the world in terms of quality. The bogey, usually, is Chinese competition. In the case of ink, there isn't any. The Chinese quality is vastly inferior. In the Sulekha story, there is a broader message of revival of entrepreneurship in West Bengal, which runs contrary to the general trend. I hope it lasts.

But Sulekha didn't only make ink. It also made pens, though they were never as ubiquitous as the ink. Nor did Sulekha pursue registration of trademarks on writing instruments as vigorously as it did for ink. Therefore, some 'Sulekha' pens floated around that were not the genuine stuff. However, the genuine stuff has started again.

Fountain pens have different price bands. At the entry level, there is indeed the bogey of Chinese competition. Most pen manufacturers have been, and continue to be, small enterprises. This makes it impossible for them to invest in technology or marketing and distribution, or generate large volumes. At that level, there are a handful of pen makers who can match the Chinese on price, if not design. Sulekha has now joined that bandwagon. I tried out a few Sulekha pens and they are decent enough.



oil has a specific smoking point, - the temperature where the oil starts breaking down. Use oils like canola, peanut or vegetable oils with a high smoking point that won't break down easily. Avoid reusing olive oil as it has a low smoking point and a dominant flavour, which makes it a bad choice for deep-frying in the first place.

Filter the oil

After the first (and each subsequent) fry, drain the oil and filter it. Any impurities and unwanted extras like loose crumbs or bits of batter are going to spoil the oil's integrity, making it burn the next time you heat it. Put a few

layers of cheesecloth in a metal strainer to filter out the crumbs.

Refrigerate it

Let the oil cool down till it's at room temperature, and then refrigerate it in an air-tight container.

Use separate oils according to flavour The oil is going to take on the flavour of the food you cooked in it, which makes fried fish oil ideal for shrimp, but not good for onion rings. Separate the oils to prevent bad flavour overlaps.



Centre issues first-ever guidelines for organ transport across travel modes

New Delhi: The Union Health Ministry for the first time has come out with SOPs for transporting organs seamless transport of human organs through various modes of travel such as air, road, railways and waterways. The Standard Operating Procedure issued by the government which will serve as a guiding document for those involved in organs transplants across the country."By streamlining organ transport process, we aim to maximise the utilisation of precious organs and offer hope to countless patients awaiting life-saving transplants. These SOPs are a roadmap for organ retrieval and transplant institutions across the country ensuring adherence to best practices and quality standards," Union Health Secretary Apurva Chandra said.A live organ needs to be transported between hospitals when both the organ donor and the organ recipient are in different hospitals either within the same city or in different cities. According to the SOPs for transportation by air, airlines carrying

human cadaveric organs can request the Air Traffic Control for priority take-off and landing of the aircraftand arrange front-row seats. They can also request priority reservation and a provision for late check-in for medical personnel transporting organs.

The source airport will inform and

communicate to the destination airport to facilitate the arrival proces, according to the SOPs. The flight captain may make an inflight announcement that human organs are being transported, the guidelines stated. The SOPs said that trolleys can be arranged for carrying the organ box from the aircraft to the ambulance on arrival by the airport and airline staff and in case the ambulance is allowed until the runway, the airline crew can guide and assist the accompanying medical personnel carrying the organ box to disembark from the staircase onto the runway directly and into the waiting ambulance.oncerned airport official(s) should define a "green corridor" -- free from obstruction -- and a trolley for the organ box



from ambulance to the aircraft at the airport of origin and vice versa. According to the SOPs, to facilitate transport of organs by ambulance and other vehicles, the "green corridor" may be provided for organ transport on the request of specific authorities or agencies. The "One Trigger System" i.e. a request from the organ allocation authority (NOTTO/ROTTO/SOTTO) to initiate the process of organ transport by creation of

green corridors", may be considered for this purpose, it said. This may help minimise the concerns around internal security as the request would be obtained from a credible source. A nodal officer from the police department can be appointed to handle issues related to the creation of "green corridor" for organ transport in each state/city who may help iron out issues related to jurisdiction, approvals, security concerns, etc. during creation of the "green corridor", it said.

The SOPs also called for sensitising the state traffic police in various states about organ donation and transplant and the crucial role that they play in expediting organ transport by creation of green corridors. To facilitate the transfer of organs by metro, the Metro Traffic Control should accord priority transit for the metro carrying live human organs for transplant. The metro security staff should escort the clinical team carrying the organ box till their boarding at the metro station, it said.A metro official

cordon off at least the necessary area for the organ box, the SOPs read. Security Hold Area (SHA) shall be intimated by the metro security regarding such transport of live human organs to avoid any delay in security checks and the concerned metro personnel should also be intimated so that proper arrangement may be made for carrying of such organs at the destination, it said. Organ box should be kept in correct position and orientation i.e. upright straight vertical at 90 degrees to the surface during transport, and label of "handle with care" can be put on the organ box, it The organ box should be secured with a seat belt for greater safety, the guidelines said. Similarly SOPs to facilitate transport of organs by road, trains and through ports via shipping have been issued to outline the essential guidelines and protocols on it.Organ transport SOPs were developed in consultation with the NITI Aayog, concerned ministries and transplant professionals.



Delhi Assembly committee investigates shelter home after 'mysterious' deaths

New Delhi: The Petition Committee of the Delhi Assembly on Saturday launched an investigation into the shelter home in Rohini following the 27 deaths the centre has reported this year. The committee was led by Aam Aadmi Party (AAP) MLA Kuldeep Kumar, along with members Akhileshpati Tripathi, Jai Bhagwan Upkar, and special invitee Mohinder Goyal. After an inquiry, the committee members stated that they uncovered harrowing testimonies from residents detailing inadequate nutrition and medical care.

The committee's damning findings will soon be presented to the Assembly Speaker, with recorded accounts of the residents set for imminent release", said committee members in an official statement."We interacted with many people living there and recorded their videos. We will release it soon and will also show what arrangements are there for the people living in the home. We have two questions for Delhi LG (Lieutenant Governor). We want to ask LG that despite so much chaos and deaths in Asha Kiran Home, why has the administrator of the home, Rahul Agarwal, not been suspended yet?" MLA Kuldeep Kumar said.

'Rahul Agarwal was SDM in 2016 when a CBI investigation was going on against him. He was also kept suspended for five years. Even after this, LG gave such a big responsibility to such a corrupt officer. Secondly, why has no action been taken against the secretary of that department till now? Why is LG protecting these officers? Our demand is that action should be taken against such officers as soon as possible", he added. When all the members of the Petition Committee reached Asha Kiran Home under the leadership Kuldeep Kumar, they were stopped outside.

"The question arises as to why the LG did not suspend the officials even after such a big incident. With whose support the officer is not being suspended. The officer who committed corruption in 2016 must have been embezzling the money of the people of this shelter home. The secretary of this department, Dilip Tawale, has also not been suspended vet. No action has been taken against him yet. The LG is giving postings to his favourite corrupt officers, and this is the reason why so many deaths have happened in this home" he claimed.Meanwhile, Kuldeep Kumar said that the committee was stopped from entering the home. "What have they hidden inside? The petition committee has constitutional rights. We will submit this entire report to the Speaker of the Delhi

Developed by the Government of India, the NGDRS is a pioneering initiative aiming to streamline the property registration process, bolster transparency, curtail processing time, and mitigate fraud and corruption. The NGDRS project is underpinned by the concept of "One Nation, One Software," centralising property data into one accessible database. This centralisation is expected to bring about a drastic transformation in property transactions, making the process more secure and efficient.To

been successfully registered using NGDRS, showcasing the system's adoption and effectiveness, said officials. This integration is expected to further consolidate property data, thus contributing to an even higher level of transparency and security. Although the NGDRS has already been adopted in 18 states and Union Territories, its introduction in Delhi marks a significant milestone.

This will gradually pave the way for a faceless registration process, offering ease and convenience to property owners by eliminating the need for physical documentation and in-person visits to registration offices.

The implementation of the NGDRS aligns with the vision of a unified and efficient property registration system across the nation. How to poach eggs for breakfast



Chhavi Sachdev, communications consultant and radio journalist, shares her version of healthy poached eggs with HealthMeUp. She mentions two methods of preparing poached eggs - in a microwave or over the stove. Let's check them out. Over to Chhavi's healthy poached egg recipes... Shortcut "poached" eggs - microwave version:

You need: A microwave, a microwave safe small bowl/ramekin, an egg.

Break the egg into the ramekin and puncture the surface with a fork, swirl it around without breaking the yolk. You need the membrane to be porous or you will have an egg explosion inside your oven, which will stink and is a pain to clean up.

Nuke for 30 seconds on 50% power. If you can't figure this out, just nuke on full power for 20 seconds.

-Wait 3 seconds. Repeat nuking for 30/20 seconds.

-Wait 3 more seconds. Ignore any noises inside the microwave. Repeat nuking.

-If you like your egg yolk hard, do it one more time.

-Use a wet knife to get the perfectly rounded 'poached' egg out of the ramekin on to your waiting English muffin.

Shortcut "poached" eggs - stovetop version:

You need: A metal bowl, a saucepan with 200 ml of water heating in it (lid preferable), egg.

Set saucepan with water on stove, on full heat till boils.

Break egg into the metal bowl. I dab one drop of oil in it to make the egg removal easier

-Put the metal bowl into the saucepan with the water, reduce heat to simmer

-Cover, let the steam do it's job. -Peek in about 3 minutes in. switch off when yolk is at the colour/hardness you

require. -Use a "pakkad" or tongs to get the metal bowl out, and a wet knife to slide the egg out on to your toast.

Bank of India net profit rises 10 per cent to Rs 1,703 crore; asset quality improves

MUMBAI. State-owned Bank of India logged in a 10% year-on-year growth in net income at Rs 1,073 crore for the first quarter of the financial year 2024-25 (Q1FY25) despite robust loan sales but rising cost of funds offset this as new loans did not being in the desired margins.

The bank's net interest income rose a low 6% to Rs 6,275 crore despite a robust growth in advances but this was offset by lower non-interest income which declined by 12% to Rs 1,302 crore while the net interest margin, which is the key measure of profitability of a bank, declined marginally to 3.07%. Had it not been for the lower tax outgoers, the bank would have reported flat numbers as its provisions soared 57% to Rs 1,293 crore. Bank of India's provisions of increased 57% on a YoY

basis and declined 29% sequentially in in the reporting quarter to Rs 1,293 crore as fresh slippages rose to Rs 2,973 crore, of which Rs 1,056 were from the MSME sector, Rs 588 crore from retail, and Rs 737 crore came in from the agriculture portfolio.

Corporate slippages stood at Rs 564 crore. However, overall asset quality of the bank improved, with gross non-performing assets ratio falling 36 bps to 4.62 and net NPA ratio falling 23 bps to 0.99. Provision coverage ratio improved to 92.11 as against 90.59. The bank's advances rose 15.82% to Rs 6 trillion and deposits rose 9.91% to 6.47 trillion

The AI chip company unveiled its Blackwell chip series in March, succeeding its earlier flagship AI chip, the Grace Hopper Superchip, that was designed to speed generative AI applications."As we've stated before, Hopper demand is very strong, broad Blackwell sampling has started, and production is on track to ramp in the second half," an Nvidia spokesperson said in an emailed statement in response to the report.Microsoft said it had nothing to add, while Meta and Google did not immediately respond to requests for comment.

SBI net profit stagnant at Rs 17K crore

Provisions against aging loans grew, rising fund cost that jumped 23.4% crimped margins

MUMBAI: The country's The State Bank of India, country's largest lender, has reported a 0.89% rise in net income yearon-year to Rs 17,035 crore in the the June quarter, but fell by a steep 17.7% sequentially, as provisions against aging loans grew while the rising fund cost that jumped 23.4% crimped margins.

Chairman Dinesh Kumar Khara told reporters here on Saturday that the net interest margins fell 12 bps to 3.35% as the bank has been paying more for its funds by way of fixed deposits. But he said that the bank will be able to maintain the margins at 3.2-3.4% range in the reminder of the fiscal. The loan loss provisions rose by 70.4% to Rs 4,518



crore, from Rs 2,652 crore a year ago, despite the bank reporting improvements in overall asset quality with the gross bad loans ratio improving by 55 bps to 2.21 and the net bad loans ratio declining by 14 bps to 0.57 in the reporting period. Both these ratios are the best in over past ten years, Khara said. Provisions jumped 37.9% to Rs 3,449.42 crore and the provision coverage ratio excluding

technical write-offs stood at 74.41%. The second reason for the crimped bottom line is the higher cost of funds wherein the bank paid more in interest to depositors than it earned form borrowers — which means its interest income rose 16.2% to Rs 1,11,526 crore, while the bank saw its interest expenses rising by a much higher rate of 23.36% to Rs 70,401 crore. Low margin means lower collection from

borrowers, which is called the net interest income printed in a low 5.7% growth to Rs 41,125 crore. All this had the credit cost of the bank rising by 16 bps to 0.48%. The fourth reason for the poor show is the lower income from the treasury.

The fifth reason for the poor show is the rise in slippages, which rose 10 bps to 0.84% YoY at Rs 7,900 crore, led by personal loans and agri loans but the management discounted any worries on this front saying this is seasonal as the bank has recovered Rs 1,600 crore since the closing the quarter. CFO Saloni Naravan said of the total fresh slippages of Rs 7,900 crore, Rs 3,000 crore came in from personal loans and housing loans; Rs 2,500 crore from agri book, Rs 2,200 crore came from SMEs, and Rs 200 crore came in from small corporates. SGB redemption price fixed at Rs 6,938, holders to gain 122 per cent

MUMBAI: Putting at rest the concern of the public who invested the sovereign bonds over their reruns after the budget surprisingly slashed the import duty of gold, the Reserve Bank has announced the redemption price at Rs 6938 per gram of gold bonds issued in August 2016. The SGBs were issued at a price of Rs 3,119 per gram in August 2016. The RBI has set August 5, 2024, as the final redemption date, the monetary authority said in a statement. The final redemption price of sovereign gold bonds

(SGBs) will be Rs 6,938 per gram for those bonds issued on August 5, 2016, implying a gain of 122%, the central bank said. The price of SGBs are fixed on the basis of simple average of closing price of gold of the 999 purity published by the India Bullion & Jewellers Association for the week



preceding the subscription period, as per the RBI. The bondholders are offered an annual rate of 2.5%, making the scheme an attractive option. Earlier this week, a senior central government official was quoted as saying in a section of the media the SGB scheme is one of the most expensive instruments to fund the fiscal deficit as the cost of

funding fiscal deficit via SGBs was higher than the benefit of gold via the scheme, adding that the scheme is not a social sector scheme, rather an investment plan and that the government would take a "holistic call" on whether to continue with the scheme going ahead. The official added that the Centre was not looking to replace SGB with an alternate scheme as of now, if they decide to discontinue it.Recently, there has been some level of anxiety among SGB

investors following market corrections after the steep customs duty cut by 9 percentage points to 6%. Investors fear that their investments on the gold scheme may provide diminished returns. However, the revenue secretary Sanjay Malhotra had on July 30 had assured that SGBs would get at least 12% return.

'Israel Aerospace Industries in talks with HAL for wide body P2F conversion facility in India'

reducing dependence on physical **NEW DELHI.** Israel Aerospace Industries (IAI) is in talks with at least two desi aviation majors including Hindustan Aeronautics Ltd (HAL) to set up a passenger to freighter (P2F) facility in India for wide body aircraft. The Israeli major is sees IndiGo and Air India as potential partners for the P2F facility which it hopes to have up and running within two years. It is also keen to have an engine maintenance, repair and overhaul (MRO) in India, IAI's EVP (aviation group) Shmuel Kuzi told TOI.

'There is a huge market for P2F conversion and that is our forte. In a first globally, we are in the process of converting Boeing 777s which can carry 100 tonnes of cargo and will be a game changer for the freighter industry. The jumbo jet (B747) freighter can carry upto 115 tonnes but that is a four-engine plane (more fuel burn). As of now, twin engine wide body freighters can carry upto 60 tonnes. So one can imagine the demand for B777 and A330 freighters," Kuzi said.

IAI, which also makes Gulfstream G280 and wings for F35 and F16, has four facilities at four sites — Abu Dhabi, South Korea and two in the US. "All these sites are full till 2027. India has the ability for having a wide body conversion facility, it has immense potential. We are in talks with HAL and one more company. There is a situation in our region (the Mid East tensions and flights to Israel are currently suspended). We need some quiet. We will like to finalise the India facility at the earliest, hopefully by the end of the year so that it gets ready in another year and become operational by 2026," Kuzi said. HAL did not comment on this issue. Asked about the size of investment for the India facility, he said: "It will be a few million dollars. The most important thing is human resource; training them through on the job training at our sites; a few hangars at an airport and a right partner."

Kuzi sees a lot of demand for wide body conversion within India and also sees the facility here doing this job for global customers. "Each hangar can convert 2.1 planes annually. It takes about five months or 1 lakh man hours to convert a wide body as it's a highly technical job. The average cost of converting one wide body is \$38 million but that depends on how many planes a customer is getting for the job," he said. Indian carriers led by IndiGo, Air India and Akasa as of now have over 1,200 aircraft on order.

The tragic deaths in Delhi of students has once again underlined the sordid failure of city planning. A heavy shower inundates a large part of the Capital; and when there is no storm water drains to take away the water, roads of the city come to serve the purpose. It was the same story in Dubai in April. The engineers built a spanking city of glass and boulevards; but forgot to build a

drainage system.As climate change shifts monsoon patterns, cloudbursts and torrential rains have become common place. For rapidly expanding cities, the problem has been compounded by not being able to put water disposal systems in place. Indian cities are drowning in flood waters because uncontrolled concretization and construction has cemented vast swathes of surfaces not allowing water to seep naturally into underground streams and aquifers.

Many cities like Delhi and Mumbai are on the banks of rivers - Delhi abuts the Yamuna while the River Mithi divides the island city and suburban Mumbai. These natural water courses are choked with human habitation on the banks, and dumping of waste. So when the rains come and the river courses can't discharge the huge volumes, they overflow the banks and enter the city.Despite Mumbai's mess, the city keeps going because it has invested for over a century and a half in building storm water drains.


India to revamp liquor ad rules, crack down on celebrity endorsements: Report

New Delhi India, which bans direct advertising of liquor, is set to announce sweeping rules that will bar even surrogate ads and sponsoring of events, which could force firms such as Carlsberg, Pernod Ricard and Diageo to redraw marketing campaigns.

Such "surrogate ads" often get round the ban by ostensibly showing less desirable items instead, such as water, music CDs or glassware garbed in logos and hues linked to their key product, and often promoted by popular Bollywood film stars.Now, they could bring fines for companies and bans for celebrities endorsing tobacco and liquor ads deemed misleading, according to the top civil servant for consumer affairs and draft rules being reported for the first time by Reuters."You can't take a circuitous way to promote products," the official, Nidhi Khare, told Reuters, adding that final rules were expected to be issued within a month."If we find ads to be surrogate and misleading, then even those who are endorsing (products), including celebrities, will be held responsible,"

Khare said. For example, brewer Carlsberg promotes its Tuborg drinking water in India, with an ad showing film stars at a rooftop dance party and the slogan "Tilt Your World", which echoes its beer ads elsewhere, emblazoned with the message, "Drink Responsibly".Competitor Diageo's YouTube ad for its Black and White ginger ale, which has drawn 60 million views, features the signature black-andwhite terriers from its scotch of the same name. The changes threaten a seachange for liquor makers in India, the world's eighth-biggest alcohol market by volume, with annual revenues Euromonitor estimates at \$45 billion.

Growing affluence among its 1.4 billion people makes India a lucrative market for the likes of Kingfisher beer maker, United Breweries, part of the Heineken Group, which has more than a quarter of market share by volume.Popular for their whiskies, Diageo and Pernod taken together, have a market share of about a fifth, while for Pernod, India contributes about a tenth of global revenues.



The new rules call for "prohibition against engaging in surrogate advertisement", which extends to sponsorships and ads for products viewed as "brand extensions" that share the characteristics of an alcohol brand, the draft said. Penalties under the new rules rely on consumer law, opening manufacturers and endorsers to fines of up to 5 million rupees (\$60,000), while promoters risk endorsement bans running from one to three years. Carlsberg declined to comment, while other companies did not respond to Reuters' queries, including those on sales of nonalcohol products. Members of the International Spirits and Wines

Association of India, which represents Diageo and Pernod, "are committed to a compliant way of building brand extension businesses," said its outgoing chief executive, Nita Kapoor. The group was in talks with the government and supported advertising of "genuine" brand extensions, she added. **HEALTH IMPACT**

The World Health Organisation (WHO) said bans or comprehensive curbs on alcohol advertising "were cost-effective measures" in the interest of public health.

Its data shows India's consumption of alcohol per person will rise to nearly 7 litres in 2030, from about 5 litres in 2019, a period over which fellow Asian giant China's consumption will drop to 5.5 litres. And alcohol-related deaths in India stood at 38.5 for every 1,00,000 of its population, versus 16.1 for China.Khare said India's draft followed a review of global best practices, in countries such as Norway, which bans ads for alcohol and other goods relying on features of a liquor

Olympics: Triathlon swim training session cancelled over Seine water quality

New Delhi. The Paris Olympics organisers have canceled the swim training session for the triathlon mixed relay event due to suboptimal water quality in the Seine River following heavy rain. The swimming portion of the familiarization sessions for the mixed relay was called off on Saturday morning after tests revealed suboptimal conditions.



Earlier in the week, both individual events proceeded despite disruptions. The men's race was postponed by a day and eventually took place after the women's event on Wednesday. Before that, swim training sessions had been canceled twice due to safety concerns. Heavy rain recently prompted the decision to cancel Saturday's familiarization session, scheduled for 8 AM local time, ahead of Monday's event. An official statement from the organizers read: "At the daily meeting to review water quality held today (Friday) at 19:30, a decision was made to cancel the swim leg of the triathlon familiarization, which was due to be held on August 3rd at 8:00."The bike and run familiarizations proceeded as planned. The statement further noted: "Given the heavy rain over the last two nights, particularly upstream of Paris, and the expected decline in water quality, we have preemptively decided to cancel the swim familiarization on Saturday, August 3rd. Considering that conditions are unlikely to improve before the daily situation meeting scheduled for Saturday, August 3rd, at 4:00, we opted to cancel the swim familiarization tonight to prevent late communication to athletes. More updates on the water quality will be provided on August 3rd."

The mixed relay event, first introduced in Tokyo three years ago, involves four competitors completing a sprint triathlon as part of a team. In the women's event on Wednesday, Cassandre Beaugrand secured a home gold for France, while a dramatic comeback saw Alex Yee of Great Britain win gold in the men's event.

Olympic Boxing: Nishant Dev's coach plays down claims of unfair judging in QF exit

Nishant Dev's coach Surinder Kumar downplayed any claims of unfair judgement after the Indain boxer's exit from the quarter-final round at the Paris Olympics 2024.

New Delhi. Nishant Dev's coach Surinder Kumar downplayed the claims of any unfair judgement during the quarter-final match at the Paris Olympics 2024. Indian boxer Nishant suffered a narrow split-decision loss against Mexico's Marco Verde Alvarez in the 71kg category on August 3, Saturday. The 23-year-old who was making his Olympic debut lost the quarter-final bout and was just one win away from assuring India another medal at the Paris Games. However, Nishant's loss did not sit well with a certain section of users on social media as they claimed the umpiring was unfair and that India was "robbed-off" a medal. "In our eyes, he was winning the first round, and he was winning the second round as well, but the judges didn't give it to him. Even in the third round, we can say it was a neck-to-neck



fight. The scoring was good by both boxers, Nishant's coach said while speaking exclusively to India Today. The bronze medallist in the World Championship could not maintain his advantage afterwards. Nishant won the first round 4-1, and looked in complete control of the bout in the second round as well, where he landed a streak of massive jab hooks on the Mexican, yet the judges surprisingly sided with Alvarez in that round, putting him 3-2 ahead

in the tie. In the final round, Nishant should have played it smart, but he paid the price for being over aggressive. He lost by split decision in the end. However, the Mexican was seen holding and grabbing Nishant a lot. There was a lot of passivity and the judges let it go on more than one occasion.

The coach was asked if point should have been docked: "Yes, it should have been done. He (mexican) should have been given a

warning. The boxer could have been psychologically down and our boxer would have taken the lead."Surinder Kumar suggested that they would not lodge any protest against the match result and had gracefully accepted the defeat.

'The Mexican boxer did the same mistake in all the three rounds. He was hitting the head, was clinching. That is a loss for the boxer only. Because he doesn't have to fight just one bout only, he has to fight 2nd and 3rd as well."Asked if a protest could be lodged: "No, we did not think about a protest. We have accepted this. Jo jeeta wahi Sikander. He was a good and tough boxer from Mexico. But not that much, but its okay."

Nishant had earlier beaten Alvarez in the World Championship in 2021, but went on to lose in the third round at the quarter-final clash."We fought really closely. They both kept fighting really closely. They should have fought while maintaining a distance. In fact we earlier had a fight with Verde. We beat him in 2021 in a one-sided affair."Both are really strong. Nishant had good accuracy. We have to work on accuracy and range."

Lovlina Borgohain remained to be India's only medal hope in boxing at the Paris Olympics

Lovlina Borgohain's quarterfinal match at Paris Olympics: When and where to watch

New Delhi. Indian boxer Lovlina Borgohain is all set for her quarter-final clash at the Paris Olympics 2024. Lovlina will participate in the 75kg quarter-final bout against People's Republic of China's Li Qian on August 4, Sunday. History beckons Lovlina as she has a chance to become the first Indian boxer to win two Olympic medals. If she wins the bout, the Tokyo 2020 medallist will join the elite list of Manu Bhaker and PV Sindhu with 2 Olympic medals. If she wins the match and makes it to the semi-final of the boxing event, she will be assured of a medal.In boxing events at the Olympics, two bronze medals are awarded as the two losing semi-finalists receive a bronze medal each. During the Tokyo Olympics 2020, Lovlina won the bronze medal in the women's 69kg category and became only the third Indian boxer after Vijender Singh and Mary Kom to win an Olympic medal. China's top-seeded Li Qian is expected to pose a stiff challenge to Lovlina. Li Qian is a two-time Olympic medallist and a



former world champion who also beat Lovlina during the Asia Games in Hangzhou last year. Lovlina settled for a

silver medal with a 5-0 win over Lin Qian in the Asian Games 2023 and will look to overcome the challenge. When will Lovlina Borgohain's 75kg quarter-final at the Paris Olympics 2024 take place?

Katie Ledecky swims into history with 800 freestyle victory at the Paris Olympics

New Delhi. Every year on Aug. 3, Katie Ledecky is reminded of her first Olympic gold medal. She was just 15 years old, a reserved high schooler who had surprisingly made the U.S. swim team for the London Games. Then she went out and shocked the world, beating everyone in the 800-meter freestyle. Twelve years to the day, Ledecky did it again. Not a stunner, but one for the ages. Gold medal No. 9. Ledecky capped another stellar Olympics by becoming only the second swimmer to win an event at four straight Summer Games, holding off Ariarne Titmus, the "Terminator," to win the 800 free Saturday night.It was Ledecky's second gold medal in Paris and the ninth of her remarkable career, which marked another milestone. She became only the sixth Olympian to reach that figure, joining swimmer Mark Spitz, track star Carl Lewis Soviet gymnast Larisa Latynina and Finnish runner Paavo Nurmi in a tie for second place. The only athlete to win more golds: swimmer Michael Phelps with 23.Ledecky was very aware of the significance of the date."Every



Aug. 3, the video (of her first Olympic gold) gets posted somewhere and you kind of reminisce," she said. "So, when I saw it was Aug. 3, I was like, 'Oh boy, I've got to get the job done."That she did, going faster than her winning time in Tokyo to finish in 8 minutes, 11.04 seconds. Titmus was right on her shoulder nearly the entire race, but Ledecky pulled away in the final 100. Titmus, who beat Ledecky in the 400 freestyle, settled for silver at 8:12.29. The bronze went to another American, Paige Madden at 8:13.00.Phelps had been the only swimmer to win the same event at four straight Olympics, taking gold in the 200 individual medley at Athens, Beijing, London and Rio de Janeiro. Now he's got company. Titmus added some perspective to Ledecky's consistency over the last dozen years, noting where she was when the American won that first gold in London."I was in grade six in primary school," Titmus said. "That's how remarkable she is."Their friendly rivalry has driven both to greater heights. They each won two golds and four medals at these games, which pushed Ledecky to 14 overall and.

Olympics, Badminton: History-chasing Lakshya Sen looks to cross big Axelsen hurdle

New Delhi. Lakshya Sen was the last Indian shuttler to qualify for the Paris Olympics after a late revival of form in the qualification cycle. And he is now the laststanding Indian shuttler, keeping the hopes of India continuing its medal-winning streak in Olympic badminton alive. On Sunday, the 22-year-old faces one of the biggest tests of his nascent career -- an Olympic semi-final against one of the modern-day greats -reigning Olympic champion Viktor Axelsen.Lakshya is chasing history. He has already become the first Indian man to reach the badminton singles semi-final at the Olympics. If he wins on Sunday, he will become the first male shuttler from the country to medal at the Games. Regardless of the result against Axelsen, Lakshya is assured of a medal match. Facing Viktor Axelsen has been one of the toughest challenges in the men's singles circuit. Lakshya has experienced it first-hand as many as 8 times. The Danish shuttler, World No. 2, has very little areas of weakness that can be exploited. Lakshya has lost to Axelsen seven times and his only win came

two years ago in the semi-final of the German Open. Lakshya has stretched Axelsen to three games on only two occasions -- one of which came at the Singapore Open earlier this year.Viktor Axelsen has been on a ruthless run in Paris, having not lost a game yet. He decimated former All England Open champion Loh Kean Yew 21-9, 21-17 in the quarter-final. Axelsen has proved naysayers wrong after having had a relatively inconsistent run on the tour before the Olympic Games in 2024 and laid down a marker with his incredible

LAKSHYA CAN? Yes, Axelsen will start the semi-final as favourite, but not many will be counting Lakshya Sen out."Lakshya indicated that he is really looking forward to playing Viktor tomorrow in the semifinals," his coach Vimal Kumar told Indiatoday.in on the eve of the contest. After having missed out on a place in the Tokyo Olympics due to Covid-19 and health issues, the prodigiously talented Almorah youngster is shooting for the stars. He was handed a tough groupstage draw, but Lakshya achieved the improbable, beating World No. 3 Jonathan Christie to book his place in the Round of 16.He was pitted against his compatriot and higher-ranked HS Prannoy, but Lakshya had very little trouble outclassing the seasoned campaigner, who was looking down and out due to health issues. Lakshya faced another tough test against Chou Tien Chen, ranked 10 places higher than him at 12. Despite losing the opening game and having an argument with the chair umpire in the second, Lakshya managed to pull through and reach the last-four stage. For Lakshya, Axelsen is a familiar face. The Danish star has invited the young Indian to train with him on multiple occasions in Dubai. But familiarity does not add any advantage because shuttlers, who play 'regularly in the gruelling circuit' are well aware of each other's strengths and weaknesses, coach Vimal Kumar said.Lakshya needs to bring out his 'A game'. The youngster has looked sharp, willing to attack and give himself time on the court to make good use of his defensive skill, which is one of the best on


