Modi had unveiled the statue in December last year during the Navy Day celebrations in Sindhudurg district. The statue was aimed at honouring the legacy of Chhatrapati Shivaji Maharaj towards maritime defence. certain measures under Z-plus security cover

New Delhi, August 30: Nationalist Congress Party-SP chief Sharad Pawar, accorded Z-plus protective cover recently, is learnt to have turned down certain measures suggested by security agencies. The Centre accorded him the Z-plus cover of the Central Reserve Police Force's (CRPF) VIP security wing after a threat assessment review by central agencies. However, Pawar is learnt to have conveyed to them that he has not been told why his security is being increased. The 83-year-old former Maharashtra chief minister is learnt to have rejected the proposals to deploy additional security personnel inside his house in the national capital, change the vehicle he uses to travel within the city and that he be escorted by two security personnel inside his vehicle. Pawar was also amenable to increasing the height of the boundary walls of his house in Delhi as part of the enhanced security measures. The former defence minister is learnt to have conveyed this to the representatives of security agencies-the CRPF and the Delhi Police-at a meeting here on Friday. Besides them, representatives of the Delhi Fire Service, Central Public Works Department, New Delhi Municipal Council and Union home ministry were also part of the meeting. Sources had said that after the assessment recommended a strong security cover for Pawar, the Union home ministry asked the CRPF to give him Z-plus protection. 55 armed CRPF personnel have been earmarked for the task.



Former Jharkhand CM Champai Soren joins BJP

Ranchi, August 30: Two days after he quit the IMM, former Jharkhand chief minister Champai Soren joined the BJP on Friday. Soren along with a large number of his supporters crossed over to the saffron camp in the presence of Union Minister Shivraj Singh Chouhan and Assam Chief Minister Himanta Biswa Sarma at a ceremony here. The veteran politician visibly became emotional after he was welcomed into the



saffron fold. The joining of the 67-year-old tribal leader to the BJP was seen as a shot in the arm for the saffron party's efforts to boost its connection with the Scheduled Tribes, a community which has been the main voter base of the JMM. He was a close aide of JMM supremo Shibu Soren. Champai Soren guit the Jharkhand Mukti Morcha (JMM) on Wednesday asserting that the state government's present style of functioning and its policies compelled him to leave the party he served for years. Champai has earned the nickname 'Jharkhand's Tiger' for his contribution to the fight to create a separate state in the 1990s. Jharkhand was carved out of the southern part of Bihar in 2000. The elections to the 81-member assem bly are due later this year.

Manipur cannot be broken, will not allow separate administration for Kukis: Biren Singh

New Delhi, August 30: Manipur Chief Minister N Biren Singh has rejected the demand by Kuki groups for a separate administration, presenting himself as a champion of the state's interest and one who would not allow its identity to be diluted. He described Manipur as a small, hard-working state and said "our forefathers" have a history of 2,000 years. He said, "Many sacrifices were made to make this state. This state cannot be broken or have a separate administration. We will not allow this," the Chief Minister stated. This is the first unequivocal rejection of the demand by Kukis. At a press conference on Thursday in New Delhi, some representatives of Kuki-zo communities demanded the creation of a union territory with a legislature along the lines of Puducherry, arguing that it was the only way out of strife. Singh, a Meitei accused by Kukis of siding with his community in the ethnic

polarised Manipur society like never before, has, however, expressed his support for a special development package for the state's hilly region where Kukis live. He said, "We can look at what can be



done through the autonomous councils (present in hill districts) with a focus on development." Singh said he would also appeal to the Centre for a special package and acknowledged the need for the devel-

violence that erupted in May last year and opment of hilly areas. He rejected the allegation of bias in dealing with the crisis, asserting that he is Chief Minister of every community, be it Meiteis, Kukis, or Nagas. Singh claimed his government's crackdown on drugs, illegal immigrants,

and forest encroachers was used by some elements to stoke social unrest, which blew up into a full-blown ethnic violence after a high court order favouring Scheduled Tribes status for Meiteis. Omar Abdullah's divorce plea: Supreme Court pushes for mediation, seeks report by November 4

New Delhi, August 30: The Supreme Court on Friday asked National Conference leader Omar Abdullah and his estranged wife Payal Abdullah to appear for mediation for exploring the possibility of a settlement. A bench of Justice Sudhanshu Dhulia and Justice Ahsanuddin Amanullah said it would hear the matter on November 4, after a report from the Supreme Court Mediation Centre is submitted. The top court had earlier sought a response from Payal Abdullah on her husband's plea seeking divorce. The Delhi High Court had on December 12, 2023 dismissed Omar Abdullah's plea seeking divorce, saying there was no merit in his appeal.

Supreme Court protects news anchor from arrest for interviewing jailed gangster Lawrence Bishnoi

New Delhi, August 30: The Supreme Court on Friday protected from arrest a private news channel anchor facing a court-monitored SIT probe in a case related to mobile phone interviews of gangster Lawrence Bishnoi from jail aired in March last year. Bishnoi, who is one of the accused in the 2022 murder of singer Sidhu Moosewala, gave video interviews on mobile phone to the anchor of the news channel. He is also the alleged mastermind of a firing incident outside the Mumbai residence of actor Salman Khan. "The second petitioner shall cooperate with the SIT investigation. We direct that pending further orders from this court, no coercive steps shall be taken against him," a Bench led by CJI DY Chandrachud said. However, it noted that irrespective of the journalist's intention to expose criminals, interviewing inmates posed a serious breach of jail regulations. "At a certain level, perhaps your client seeking the interview may have breached certain regulations of the jail," the Bench told the petitioner's counsel as it issued notices to the Punjab government and IPS officer Prabodh Kumar who headed the special investigation team (SIT) set up by the Punjab and Haryana High Court. "The fact remains that you gain access to jail and publish interviews from jail.

Era of uninterrupted dialogue with Pakistan is over: Jaishankar

New Delhi, August 30: Almost a week after Ukraine questioned India's economic ties with Russia, External Affairs Minister S Jaishankar on Friday said there is an economic complementarity between India and Russia and "we should not be intimidated in pursing advantages of that complementarity". The minister was speaking at the release of a book 'Strategic conundrums: Reshaping India's foreign policy' written by Ambassador Rajiv Sikri. On Russia, Jaishankar said trade has gone up five-fold and it's not a simple crude oil relationship. Moscow, he said, was following its own look east policy. Post 2022 - when the conflict with Ukraine began - there is a profound shift in the way Russia looks at the world. "We in India need to take advantage of it rather

than get clouded by a larger narrative,

amended Rule 11 of the Rules of Procedure and Conduct of Business, effectively removing the special provision for Friday sittings. Also Read | Assam makes registering Muslim marriages and divorces mandatory under new law The break, which allowed the House to adjourn from 11:30 am to 3:00 pm on Fridays, has been a longstanding tradition, though the

rules did not explicitly state that it was for offering namaz. Himanta Biswa Sarma said the Assam assembly has prioritised productivity and shed another vestige of colonial baggage by doing away with the two-hour 'jumma' (Friday) break. "This practice was introduced by the Muslim League's Syed Saadulla in 1937. My gratitude to Hon'ble Speaker Biswajit Daimary and our legislators for this historical decision," he posted on X. The issue was raised by Speaker Biswajit Daimary, who felt that in view of the secular nature of the Constitution, proceedings of the assembly must be conducted on Fridays like any other day, according to officials aware of the matter. "They want to bother Muslims in some way or

the other and spread hatred in the society. BJP should understand that even Muslims had sacrificed their lives in the freedom struggle," the RJD leader said.

Heavy rains likely in parts of Andhra for next three days

VIJAYAWADA: The India Meteorological Department (IMD) has forecasted heavy rains over coastal districts for the next three days in coastal districts on Friday due to a low-pressure area formed under the influence of a cyclonic circulation over the east-central Bay of Bengal and its vicinity.

The low-pressure system, which developed at 8.30 hours IST on Thursday, is expected to move west-northwestwards and become more marked over the west-central and adjoining northwest Bay of Bengal by Friday. The IMD warns that the system is likely to intensify into a depression over the west-central and northwest Bay of Bengal in the coming days, with heavy to very heavy rainfall expected in isolated places across North and South Coastal Andhra Pradesh on Friday. Thunderstorms with lightning and strong surface winds, reaching speeds of 30-40 kmph, are also forecasted for isolated areas across the State.Several places in coastal Andhra Pradesh and a few in Rayalaseema received light to moderate rainfall. Visakhapatnam city recorded the highest rainfall of 6 cm, followed by 5 cm in Garugubill of Parvathipuram Manyam district, and 4 cm in various locations such as Cheepurupalle, Pusapatirega, and Denkada. Rainfall of up to 3 cm was observed in parts of coastal Andhra Pradesh and Rayalaseema on Thursday. In related developments, the Nagarjuna Sagar project is experiencing heavy inflows into the Pulichintala Project and subsequently to the Prakasam Barrage.

Orders reserved on challenge to GO 33 on medical admissions in Telangana

HYDERABAD: The High Court reserved orders on Thursday in a batch of writ petitions filed by MBBS course aspirants challenging the constitutionality of GO 33, dated July 19, 2024, amending the Telangana Medical and Dental Colleges (Admission into MBBS and BDS Courses) Rules of 2017. In the course of the hearings that spanned three days, counsel for the petitioners argued that the recent amendments, particularly the insertion of sub-rule (iii), were a deliberate attempt by the respondents to circumvent a binding judgment issued by the High Court in a previous writ petition in 2023. The 2023 judgment had declared certain provisions of the 2017 Rules unconstitutional, counsel for the petitioners told a bench of Chief Justice

Aloke Aradhe and Justice J Sreenivas Rao. Counsel argued that the court's earlier ruling had specifically addressed Rule 3(III)(B)(b) of the 2017 Rules, finding it misaligned with its intended objectives. The court had ruled that this provision could not be justified solely on the basis of study or residence in the local area.As a result, the rule was

Centre's aid to help create 54,000 jobs in Andhra's Kopparthi

KADAPA: In a significant boost to industrial development in Andhra Pradesh, the Central government has approved the development of industrial smart cities across the State. Kopparthi Mega Industrial Hub in Kadapa district's Kamalapuram constituency is among the key beneficiaries of the initiative. With an investment of Rs 2,137 crore, the project aims to develop 2,596 acres of land and create employment opportunities for around 54,000 people.Information and Broadcasting Minister Ashwini Vaishnaw made the announcement on Wednesday, following a Union Cabinet meeting chaired by Prime Minister Narendra Modi. A total of 6,500 acres has been earmarked for Kopparthi as a part of the larer Visakhapatnam - Chennai Industrial Corridor.

The Centre's announcement is expected to bring investments to the tune of Rs 8,860 crore, which can further develop Kopparthi into a full-fledged industrial hub and create numerous job opportunities for the local unemployed youth. Focus will be on sectors such as renewables, automotive spare parts, non-metallic minerals, textiles, chemicals, engineering components, and metallic goods production. New substation to help curb outages in Old Gurgaon

NEWS BOX

GURGAON. Residents of Old Gurgaon are expected to get relief from power outages during summer, when electricity supply is often cut to counter overloading, once the 220kV substation in Sector 15 is completed. The substation will be connected to the 400kV substation in Sector 72, and once commissioned, it will significantly improve power supply in the area.

To meet power demands, HVPNL and DHBVN had planned to upgrade the existing 66kV power house to a 220kV facility. HVPNL has been constructing a GIS substation in Sector 15 and laying transmission lines on multi-circuit towers from Sector 72

This project is expected to benefit residents of sectors 2, 14, 15, 16, 17, 18, 23, 30, 31 and 32, and areas around Old Railway Road, New Railway Road, Civil Lines, Friends Colony, Patel Nagar, Mini Secretariat and surrounding regions. It will help mitigate overloading of the power system and reduce load shedding, especially during the summer season. Line work is in final stages and is scheduled for completion in Oct this year.PC Meena, commissioner of Hisar and managing director of DHBVN, in a meeting with officials of HVPNL and DHBVN, assessed the capacity of the currently overloaded power houses and directed that capacities of old substations be increased in line with future demand. He emphasised on the need to enhance resources wherever required to ensure uninterrupted power supply to consumers. "Continuous improvements in power supply to consumers is our main objective," he said.

HVPNL officials said that since 2021, a 220kV substation has been under construction in Sector 15, which will be connected to the 400kV substation in Sector 72 and the 220kV substation in Sector 72.

"The construction of this new substation is a muchneeded relief for the residents of Old Gurgaon who have been facing frequent power cuts and load shedding during the summer months when the demand for electricity is at its peak. The existing infrastructure was not able to cope with the increasing demand, leading to frequent power outages and load shedding," said an official

7mm rainfall, but city comes to a crawl

Gurgaon: Overnight rain in NCR left the Delhi-Gurgaon border at Kapashera submerged once again on Thursday, bringing traffic to a crawl for hundreds of officegoers and marooning residents living in its vicinity. Though flooding is far from a new occurrence on the stretch, civic authorities have done little to resolve the problem. The city recorded just 7mm of rainfall till Thusday evening. There's no proper drainage system in place and adjoining roads are at higher elevation, because of which runoff from Kapashera in Delhi, and Dundahera in Gurgaon flows downstream, turning the border stretch into a waterlogged mess. The situation worsens during monsoon, as the portion gets flooded after every bout of rain and makes it difficult for motorists to cross the cities. The Old Delhi-Gurgaon Road is key to get to Udyog Vihar, where scores of businesses and companies employ thousands. Commuters who take the route said that they had to navigate waterlogging, with little idea of damaged sections of the road. Inter-city buses, which are the only public transport available for commuters in the area, also stopped at the border and asked passengers to walk through the waterlogged roads."The road conditions are terrible. It's difficult to gauge the depth of water. I almost lost my balance because of the uneven surface. You can't see what's beneath the water, and that makes it very dangerous," said Anil Arora, who travels on his motorcycle from Delhi's Dwarka to Udyog Vihar for work. Residents of Surya Vihar, on the Gurgaon side of the border, said stepping out of the society becomes a challenge every time it rains.

Showers in Gurgaon bring maximum temp down by 2°C in 24 hours, more expected

GURGAON. The city's maximum temperature dropped by over 2 degrees Celsius due to the overnight showers on Thursday. At 30 degrees Celsius, it was 3.7 degrees below normal. The city received intermittent rain till 8.30am on Thursday, followed by cloudy skies and drizzle throughout the day. By 5.30pm, it recorded an average of 7mm rainfall. The India Meteorological Department (IMD) said light rain or drizzle is likely on Friday as well. Thursday's downpour provided much-anticipated respite from the oppressive and sultry weather conditions. The minimum temperature, however, rose marginally from 25 degrees Celsius on Wednesday to 25.6 degrees on Thursday, near normal for this time of the year.

On Thursday, Manesar saw the maximum rainfall at 25mm, followed by Wazirabad (22mm), Kadipur and Harsaru (11mm), Sohna (10mm), Badshapur (7mm), Pataudi (5mm) and Farukhnagar (4mm). The city has received the third-highest rainfall in Haryana so far this monsoon at 492.8mm, after Nuh (608mm) and Chandigarh (536mm). Between June 1



and August 29, Gurgaon recorded 492.8mm of rainfall against the normal of 402.2mm, a 23% increase. The state's average rain is 295.7mm this season - a 15% decline from the normal of 348.2mm, which is 15% less than the anticipated amount. After Gurgaon, Mahendergarh recorded the maximum rain at 484mm.Although rainfall is

expected on Friday, no weather alert has been issued. The cloud cover is expected to diminish over the weekend, which could result in a rise in temperatures.In the first week of Sept, however, the weather is expected to change again. Heavy showers are likely on Sept 2 (Monday), potentially bringing about a slight dip in the maximum temperature.

'Scattered light to moderate rainfall is very likely over Punjab, Haryana, Chandigarh, Delhi and west Rajasthan during the weekend. Heavy rain s likely on Sept 2," said an IMD official.

The maximum temperature during this period will range between 34 and 35 degrees Celsius, while the minimum temperature is expected to settle between 25 and 26 degrees.

Meanwhile, the city's air quality index (AQI) was 'satisfactory' at 80 on Thursday, the same as the day before. On Tuesday, the city had seen its first 'good' air day in nearly two yars with an overall AQI of 35.Streets in Delhi also got waterlogged after heavy rainfall on Thursday. The only positive was the reduction of the temperature by over 5 degrees Celsius in the past 24 hours. Delhi may still get some rain, but experts said the intensity will drop. The weather department measured the rainfall between Wednesday and Thursday morning at 77.1mm. IMD has issued an orange alert for moderate rain. This will be followed by a brief break with intense rain activity resuming from Sept 1 or 2.

In Kosli & Ateli seats, poll battle likely to turn into a family affair

GURGAON. Kosli and Ateli assembly seats are set to be among the most closely watched contests in Haryana polls, with at least three members of a family vying to get tickets from rival parties that could pit them against each other.Rao Yadavendra Singh, a former two-time MLA from Kosli, is hoping to be fielded from the Congress once again.Yadavendra, the younger brother of Union minister and BJP's Gurgaon MP Rao Inderjit Singh, said on Thursday that the "deserving candidate" should be a contender from Kosli."Anyone can be a contender, but

what matters is who has the weight. The wind may be in Congress's favour, but that doesn't mean we overlook the most deserving candidate," he said. Yadavendra's race for Congress ticket

from Kosli is not without its challenges. His candidacy is



complicated by the possibility that Rao Inderjit Singh is pitching for his daughter Aarti Rao to be fielded by BJP from the constituency.

Rao Inderjit Singh, who was with Congress for most of his political career till he switched to BJP ahead of 2014 Lok Sabha elections, is the most prominent Ahir face from the region. Kosli and Ateli are part of the Ahirwal belt in Haryana.On the other side, Yadavendra was elected from Kosli

for two consecutive terms from 2005 till 2014, but political fortunes took a downturn after Inderjit left the party for BJP. Since then, the younger sibling lost the seat as a Congress candidate consecutively in 2014 and 2019. Sources told TOI that the contest in Ateli could also end up becoming a Rao family affair. Inderjit's nephew Abhijeet is eager to make a mark in politics, while BJP is also considering fielding Aarti from here.On Thursday, a source in BJP said the party was confident of victory. "Rao Inderjit Singh has a huge following in the region and irrespective of any candidate fielded by Congress, the party will lead," the

Tiger, tiger, hunting right1 1 days gone, ST-2303 at home in Jhabua

GURGAON. An abundant prey base of nilgai, wild boar and chinkara, and no competitors to hunt them down - ST-2303 seems to have found a home, 125km away from home. It's been 11 days since the adult male tiger wandered out of the Sariska reserve and entered the dense jungles of Jhabua in Rewari, making an arduous trek of 125km along the Sahibi river. But the three-year-old animal is showing no signs of a retreat. This has raised concerns among forest department officials, many of whom feared that the tiger might stray into nearby villages where farmers work in fields during the day. This is the second time since Jan this year that ST-2303 has entered the Jhabua forest from Sariska. The last time, it had returned to its original habitat in four days. Officials agreed that tranquilising the tiger and capturing it was easier said than done, given the topography and density of the Jhabua jungle. Around 95% of the forest is covered by various trees and shrubs - the lush canopy giving the tiger enough camouflage to hide."We have been a little cautious because if the tiger escapes after being darted and we fail to trace it in the dense core jungle, it might pose a grave risk to the animal's life," a forester said. Although the forest department hasn't found any animal carcasses, officials are certain that the tiger would have made a hunt after its 125km trek and hidden the remains in some vegetation. On Monday morning, fresh pugmarks were spotted near a waterbody. 

World The X handle of an anonymous social m e d i a u s e r, B a r r y S t a n t o n (@barrystantonGBP), who went viral for his racist posts and rants in which he criticised Indians and Indian immigrants, was suspended on Friday. The action came after Stanton's posts were flagged by hundreds of irate Indians, with several even calling out X owner Elon Musk for not suspending the account. The suspension of the account became a subject of intense debate and memes on X. The hashtag "suspended" was among the top trends on X on Friday morning.Stanton, who has a verified handle with over 1.8 lakh followers, has shared several cartoons and memes depicting Indians defecating in the open.He also praised a post on X on how to drive Indians away from "white neighbourhoods". Several hateful and abusive posts against Jews and Africans have also been tweeted from the handle.

An X user, Akshit Singh, tweeted that he had flagged the Barry Stanton account to Minister of Information and Broadcasting Ashwini Vaishnaw and the UK High Commission in India. Israel, Hamas agree to 3-day pause in fighting for Gaza polio vaccinations: WHO

Tel Aviv/Gaza City Israel's military and Palestinian terror group Hamas have agreed to three separate, zoned three-day pauses in fighting in Gaza to allow for the first round of vaccination of 640,000 children against polio, a senior WHO official said on Thursday.The vaccination campaign is due to start on Sunday, with the pauses scheduled to take place between 6 am and 3 pm (local time), said Rik Peeperkorn, the World Health Organisation's senior official for the Palestinian territories.He said the campaign would start in central Gaza with three consecutive daily pauses in fighting, then move to southern Gaza, where there would be another three-day pause, followed by northern Gaza. Peeperkorn added there was an agreement to extend the pause in each zone to a fourth day if needed."From our experience, we know an additional day or two is very often needed to achieve sufficient coverage," Mike Ryan, WHO emergencies director, told the UN Security Council on Thursday during a meeting on the humanitarian situation in Gaza.

5 dead as Typhoon Shanshan hits Japan, power lines snapped, flight ops hit

Tokyo. Typhoon Shanshan slowly barrelled up the Japanese archipelago Friday, dumping torrential rains and causing transport havoc as its reported death toll reached five. The typhoon, one of the strongest to hit Japan in decades, had weakened by early morning, though gusts were still reaching 126 kilometres (78 miles) per hour.Even before making landfall on the island of Kyushu, a landslide caused by the heavy rains preceding it killed three members of the same family late Tuesday in Aichi prefecture, around 1,000 kilometres (600 miles) away. Two more people were reported to have died including a man last seen on a small boat in Kyushu and another whose two-storey home partially collapsed in Tokushima prefecture on the neighbouring island of Shikoku.At least 81 others have been injured, including many hurt by broken glass after the typhoon smashed windows and ripped tiles off roofs when it slammed into Kyushu on Thursday with gusts up to 252 kph.Authorities issued their highest alert in several areas, with more than five million people advised to evacuate, although it was unclear how many did.As far away as the town of Ninomiya near Tokyo,



authorities urged residents to take "immediate measures" to secure safety such as moving to higher floors after a local river flooded.Some parts of Kyushu saw record rains for August, with the town of Misato recording a staggering 791.5 millimetres (31 inches) in 48 hours, the Japan Meteorological Agency said.Power cuts hit more than 250,000 Kyushu households but the utility operator said Friday that only 6,500 were still without electricity as engineers repaired damaged transmission lines.Overnight, many motorways were fully or partially closed in Kyushu, as well as others further afield, media reports said.Shinkansen bullet trains remained suspended in Kyushu and were also halted on the major route between Tokyo and Osaka, with operators warning of disruptions elsewhere.Japan Airlines and ANA had already announced the cancellation of more than 600 flights between them for Friday, having scrapped a similar number the previous day, affecting almost 50,000 passengers.Auto giant Toyota suspended production at all 14 of its factories in Japan.Nissan and Honda also halted operations at their Kyushu plants, as did chipmakers including Tokyo Electron, reports said.

Shanshan comes in the wake of Typhoon Ampil, which dumped heavy rain that disrupted hundreds of flights and trains this month but caused only minor injuries and damage.Typhoons in the region have been forming closer to coastlines, intensifying more rapidly and lasting longer over land due to climate change, according to a study released last month.

Another released by World Weather Attribution (WWA) on Thursday said that climate change turbocharged Typhoon Gaemi, which killed dozens of people across the Philippines, Taiwan and China this year.

Kamala Harris's nod to Republican in cabinet, if elected: Diversity of opinion

World The Democratic candidate for the US presidential election, Kamala Harris, on Thursday (US time) said that she might name a Republican to her cabinet if J elected, in her first interview since being nominated for the November election. She emphasised "diversity" and serving as President for "all Americans," but said she did not have a particular name in mind.

did not have a particular name in mind. "But I would, I think. I think it's really important. I have spent my career inviting diversity of opinion. I think it's important to have people at the table when some of the most important decisions are being made that have different views, different experiences. And I think it would be to the benefit of the American public to have a member of my Cabinet who was a Republican," Vice President Harris told CNN's Dana Bash.US presidents have previously appointed members of the opposite party to their Cabinet. However, no such move has been made during the tenure of Joe Biden or former president Donald Trump in the past eight years.

Harris, in her interview, explained her stance on several policy matters and insisted that her "values have not changed," even as she is "seeking consensus".

When specifically asked about reversals of fracking and decriminalising illegal border crossings, she said, "I think the most important and most significant aspect of my policy perspective and decisions is my values have not changed"."I believe it is important to build consensus. It is important to find a common place of understanding where we can actually solve the problem," Harris said.Said further said, if elected, her administration would renew a push for comprehensive border legislation that would tighten migration into the United States. "We have laws that have to be followed and enforced, that address and deal with people who cross our border illegally, and there should be consequences," she said.

On Israel's war with Hamas in Gaza, Harris said, "I am unequivocal and unwavering in my commitment to Israel's defence and its ability to defend itself." But the vice president also reiterated what she's said for months, that civilian deaths are too high amid the fighting.She also brushed off Republican Donald Trump's questioning of her racial identity after he said she "happened to turn Black." Harris, who is of Black and South Asian heritage, said it was the "same old, tired playbook." Harris, who was nominated as the Democratic candidate for the presidential race after Joe Biden opted out, is set to debate with rival Donald Trump on September 10.

ABBA asks Donald Trump not to play their music while campaigning

World Swedish supergroup ABBA has asked Donald Trump to stop using their music at campaign rallies, but the Republican presidential nominee's campaign says it has permission.

ABBA has recently discovered the unauthorised use of their music and videos at a Trump event through videos that appeared online," said a statement to The Associated Press from the band, whose hits include "Waterloo," "The Winner Takes It All" and "Money, Money, Money.""As a result, ABBA and its representatives have promptly requested the removal and deletion of such content. No request has been received; therefore, no permission or licence has been granted."A spokesman for the Trump campaign said it had obtained a licence. "The campaign had a licence to play ABBA music through our agreement with BMI and ASCAP," the spokesperson told the AP.

ABBA joins a long list of performers who've objected to Trump using their songs. Ahead of the 2020 election, that included Bruce Springsteen, Rihanna, Phil Collins, Pharrell, John Fogerty, Neil Young, Eddy Grant, Panic! at the Disco, R.E.M. and Guns N' Roses. This cycle, Celine Dion asked the candidate to stop using "My Heart Will Go On" and Beyoncé blocked Trump from using her song "Freedom" in a campaign video. In 2016, Adele asked Trump to quit playing her songs at political rallies. Campaigns don't need an artist's express permission to play their songs at rallies as long as the political organisation or the venue has gotten what's known as a blanket licence from the performing rights organisations ASCAP and BMI. Danish court rejects extradition of Purulia arms drop case mastermind to India

World A Danish court on Thursday rejected India's request for the extradition of Niels Holck, also known as Kim Peter Davy, who is wanted in connection with the Purulia arms drop case.On the night of December 17, 1995, a Latvian Antonov An-26 aircraft flew over Indian airspace, dropping a cache of weapons over the village of Joupur in West Bengal's Purulia district. The consignment was allegedly meant for a rebel group in West Bengal.For years, New Delhi has sought Davy's extradition to stand trial in an Indian court. However, the Danish court rejected India's request, stating that sending him to India would violate Denmark's extradition act due to a risk that he would be subjected to

treatment in breach of the European Convention on Human Rights.Anders Rechendorff, the public prosecutor who last year nominated Davy for a handover to stand trial in India, told news agency Reuters that it had yet to be decided whether the decision would be appealed. World In a move likely aimed at appealing to women voters, Republican presidential nominee Donald Trump announced on Thursday that he supports having the government or insurance companies cover the costs of in vitro fertilisation (IVF).

"Under the Trump administration, we are going to be paying for that treatment," Trump said in an interview with NBC News. "Or we're going to be mandating that the insurance company pay."Health insurance companies in the US are not currently obligated to cover IVF treatments, which can cost tens of thousands of dollars. Trump reiterated that one option would be to have insurance companies pay "under a mandate".

The former president unveiled the policy later at a rally in Michigan, telling the crowd, "Your government will pay for or your insurance company will be mandated to pay for all costs associated with IVF treatment." Trump also stated his administration would push for new parents to deduct "major newborn expenses" from their taxes. "We want more babies," he added.TRUMP 'BACKS'ABORTION RIGHTS

In the NBC News interview, the Republican opposed Florida's six-week abortion ban and indicated support for overturning it. "I'm going to be voting that we need more than six weeks," he said.At the same time, he backed exceptions in abortion laws for cases where the pregnancy poses a threat to the mother's life, or is the result of rape or



incest.However, Trump's campaign quickly moved to clarify his stance on the divisive issue of abortion."President Trump has not yet said how he will vote on the ballot initiative in Florida," said Karoline Leavitt, Trump's press secretary, in a statement to NPR. "He simply reiterated that he believes six weeks is too short."The issue of reproductive rights has turned into a major point of contention in the 2024 election. At the Democratic National Convention, Harris claimed that Trump and his party would "limit access to birth control, ban medication abortion, enact a nationwide ban on the procedure, and force states to report on w o m e n's miscarriages and abortions."The issu of access to fortility treatment here a plained

fertility treatments became a political flashpoint earlier this year when the Alabama Supreme Court ruled that frozen embryos were considered children under the law, leading to a temporary pause in IVF treatments in the state.Trump's pledge to support IVF coverage may be seen as an attempt to moderate his stance and appeal to voters concerned about his record on abortion rights. He had urged Alabama lawmakers to preserve IVF acces.

Israel Agrees To Three-Day 'Humanitarian Pauses' In Gaza For Polio Vaccinations

Jerusalem, Israel Israel has agreed to a series of three-day "humanitarian pauses" in Gaza to allow health officials to administer polio vaccinations to children in the territory, the World Health Organization said Thursday.

The way we discussed and agreed, the campaign will start on the first of September, in central Gaza, for three days, and there will be a humanitarian pause during the vaccination," said Rik Peeperkorn, the agency's representative for Palestinian territories. The vaccination rollout will also cover southern and northern Gaza, which will each get their own three-day pauses, Peeperkorn told reporters, adding that Israel had agreed to allow an additional day if required. The vaccination campaign aims to cover more than 640,000 children under the age of 10."We stress the critical importance for all parties to adhere to the commitments that have been made," Michael Ryan, WHO deputy director-general, told the UN

Security Council. "At least 90 percent of coverage is needed during each round of the campaign in order to stop the outbreak and prevent international spread of polio," he added.

He said that 1.26 million doses of the NoPV2 vaccine had been delivered in Gaza, with another 400,000 still to arrive. The vaccine is administered orally in two drops. Health workers will need to return in four weeks' time to give two more drops to each child to complete the vaccination, although so far there has been no public discussion of arranging another pause in the fighting.

Oren Marmorstein, Israel's foreign affairs spokesman, said on X that his government has "has coordinated a large-scale operation



with WHO and UNICEF to vaccinate children in the Gaza Strip against polio." Hamas said it supports the "UN humanitarian truce." Robert Wood, US deputy ambassador to the United Nations,

said it is "vital that this campaign be implemented without delay."He called on Israel to "facilitate access for agencies carrying out the vaccination campaign, and for it to ensure periods of calm and refrain from military operations during vaccination campaign periods." The United States and European Union have voiced concern over polio in Gaza, after the first case there in 25 years was confirmed this month in an unvaccinated 10-month-old baby. Poliovirus is highly infectious and most often spread through sewage and contaminated water - an increasingly common problem in Gaza with much of the territory's infrastructure destroyed by Israel in

its war against Hamas. The disease mainly affects children under the age of five. It can cause deformities and paralysis, and is potentially fatal.

Two Indian fishers sentenced to jail in SL for violating IMBL, seven released

MADURAI: A Sri Lankan court sentenced two fishermen, including a boat driver and a second-time IMBL violator, to jail on Thursday. The court also ordered the release of seven fishermen, who were later handed over to the Indian Embassy officials.On July 23, the Sri Lankan Navy caught two fishing boats and arrested nine Indian fishermen from Rameswaram for alleged violation of the IMBL near Delft Island. The arrested fishermen were taken to the Kankesanthurai Harbour and handed over to the Mailadi Fisheries Inspector for further legal proceedings. After over a month of legal custody, the fishermen were produced before a Lankan court on Thursday.Judge Nalini Subashkaran released seven fishermen under the condition of not violating the IMBL in the future. Sahaya Robert (49) of Rameswaram, the driver of the first boat, was sentenced to one year imprisonment, while the second boat's driver, Harikrishnan (50) of Rameswaram, was sentenced to 18 months imprisonment as he was caught violating the IMBL for second time. They were sent back to prison on Thursday. Meanwhile, fishermen's associations condemned the continuous action of jailing Indian fishermen. Considering the welfare of the fishermen, the union government should take immediate action to secure the release of jailed Indian fishers in Sri Lanka, they said.

Fisherfolk stages protest as one man still missing at sea

Demanding the state government to intensify the search for a fisherman, who went missing after their boat capsized at sea on Tuesday, fishermen and CITU cadre staged a protest in Rameswaram. Two fishermen, who swam to Katchatheevu and were rescued by SL Navy, reached India by flight on Thursday. While one remains missing, the body of another was recovered on Wednesday.

KSRTC unit heads were told to propose ideas to achieve Rs 9 crore daily target

KOCHI: The cash-strapped Kerala State Road Transport Corporation (KSRTC) has issued strict instructions to all unit heads to come out with 'feasible' proposals to achieve a collective daily collection of Rs 9 crore, a 33 per cent rise from the current operational earnings of Rs six to seven crore.

As part of this, the Chairman and Managing Director is convening an online review meeting at 4 pm on August 31, when all the unit heads and the Regional Chief Traffic Officers have to submit feasible proposals to increase the collection of their respective units."The same has to be first sent to the Traffic Department and the Executive Director (Operations), and they need to be explained how the same will result in increased earnings. The unit heads should demand additional buses and crew only after conducting a proper study of the feasibility of the new routes. A circular has been sent to all the unit heads," said a senior KSRTC officer.

Also, daily, weekly and monthly review meetings will be held to assess the progress towards achieving the target collection and the additional measures being taken from time to time to achieve the Rs 9 crore target. Currently, the daily earnings of the corporation are in the range of Rs 6 to 7 crore. For instance, the total collection of all units on August 26 is Rs 6,08,60,578, with an Earnings Per Kilometre (EPM) of Rs 46.06.

Meanwhile, the Chief Office has fixed the new revenue targets to be achieved by each unit. The highest target of Rs 40.21 lakh is for Thiruvananthapuram Central unit, which operates the maximum number of buses.

Give time limit for finishing Madurai AIIMS: Madras HC to centre

MADURAI: The Madurai Bench of the Madras High Court on Thursday directed the secretary of the Union Ministry of Health and Family Welfare to file a report setting out a time limit within which the construction of AIIMS Madurai will be completed.A division bench of Justices R Subramanian and L Victoria Gowri was hearing a petition filed by RK Basker of Madurai. The petitioner stated that the union government had proposed to set up AIIMS in Tamil Nadu in 2015 and finalised Madurai as the location in 2018. own funds and will hand over

the same to us. They have informed us that the process to hand over the vehicles is in the final stage," said Mayor Adv M Anilkumar.When contacted, a senior CSML official said they were awaiting the delivery of the 10-tonne garbage compactor trucks from the company, and the same will be

after Onam. The corporation owns 13 refuse compactor trucks, but often a majority of vehicles of the ageing fleet, procured from a foreign firm over 10 years ago, would lie idle. Though it had 24 covered tippers too for waste



collection, they too are now over 15 years old. and havebeen taken off the roads."The problem with our refuse compactor trucks was that they were procured from a foreign company. So upon developing technical snags, the company personnel had to come from Bengaluru as there were no local units here. This often caused

much delay. Now seven such vehicles are under repair," said a senior corporation official.The same has forced the civic body to collect waste by hiring lorries. "Since each lorry handles only 5tonnes of waste, we're forced to hire around 20 to 25 trucks per day. The maximum waste

collected per day is around 250 tonnes," he aded.

The maintenance of the old compactor truck fleet and the cost of hiring lorries for transportation of waste have burnt a hole in the corporation's pocket. The civic body coughed up Rs 96 lakh between April 2020 and December 2022 alone for waste collection.The corporation aims to save a

substantial amount once the CSML hands over the 15 refuse compactor trucks. "We've already shelved our plan to purchase modern trucks. Also, we can cut the lorries needed to be hired to just five or below. The same would save us a substantial amount," the official pointed out.

Thinking straight, not laterally, the way forward

The manner in which the recruitment of 45 officers of the Joint Secretary/Director level laterally was requisitioned and withdrawn suddenly is a good example. The withdrawal was surprising on three counts. One, lateral induction had been resorted to in the past, including by this government without getting mired in debilitating controversies. Second, as the Opposition fired its precision-guided 'reservation' missile, some ministers launched a counterattack, not aware of the swift, embarrassing retreat being planned. Third, a government known to be tough buckled under a smoking gun. The irony was that ministers who should have known better were brandishing their swords even as the retreat was being sounded.Before coming to the issues involved in the non-political endeavour of lateral recruitment, one cannot help but pity the language of the 'instrument of surrender', which could have been a straightforward official communication instead of a demi-official letter from the minister giving the impression that his ministry made a mistake, which the Prime Minister (who is in charge of the ministry) stepped in to correct. He even traduced the Opposition for overlooking the principle of 'social justice' it advocated while making lateral recruitment when in power.

- Much has been written about previous governments inducting experts from the market into the bureaucratic system, the recommendations of the Administrative Reform Commission and the Group of Secretaries, the examination of the proposal by the Department of Personnel from various angles, and the peaceful induction earlier. This was not the first attempt by the government, and hopefully it will not be the last, to draft outside talent to shore up its skill set. It would be unfair to endorse lateral entry or dismiss it without understanding the context and the motivation for such a move. Let us look at some fundamental issues. The Government of India (GOI) runs the affairs of the Central Government and other national-level bodies by recruiting officers to services such as income tax, Railways and Posts through the Union Public Service Commission (UPSC), following the reservation policy. It also takes on deputation All India Services (AIS) officers borne on state cadres recruited through the same process. The GOI has no cadre of AIS officers; the states maintain a deputation reserve as part of their sanctioned cadre strength. The GOI draws upon this reserve to fill positions at different levels in the ministries and other apex organisations through an empanelment process for joint secretaries and above.
- Many GOI ministries have their specialised services to deal with their allotted subjects, as in the case of agriculture, commerce, civil and cost accounts, etc. In addition, the government has fruitfully drawn upon the expertise of outside talent occasionally without being bound by its reservation policy. While earlier governments selected eminent experts through an informal system, this government tried to institutionalise the selection through the UPSC. Also, there has never been an attempt at such large-scale lateral induction.It would be interesting to understand how effectively is the expertise of the existing specialised cadres utilised by the government, especially when professional advice conflicts with short-term objectives of the government or the political interests of the ruling party.

50 years of India's steady outperformance

The country has become the third-largest contributor to global growth

IT may not have seemed so at the time, but 50 years ago India reached a turning point. There was an economic crisis and political turmoil. The decisive action a year later was the imposition of Emergency rule by Indira Gandhi. But that was overturned in less than two years. What proved more long-lasting was something barely noticed at the time: A new direction in economic policy, away from Mrs Gandhi's overtly Leftist phase. There followed in due course an end to India's long-term underperformance as an economy, and over time the birth of a new 'India story'.Until the mid-1970s, India had been growing more slowly than the world

economy. The transition in the second half of the 1970s followed some 15 years of crises in the form of wars, failed harvests and even famine, a traumatic rupee devaluation and two oil shocks. Many of these events had contributed to a loss of national self-belief after the early optimism under Jawaharlal Nehru.But once the economy stabilised, what followed was a half century of steady outperformance. Growth outpaced both low-income and middle-income countries, as well as the world economy. The country consequently has an international heft today that it never enjoyed before. Yet, it has not been a 'shining' record, because of continuing poor socioeconomic metrics and rising

inequality.Prior to the transition, India's share of the global economy had been on the decline — from 2.7 per cent in 1960 to 1.9 per cent in 1975 before the decline slowed, stabilised and eventually improved. Even in 2013, India's share of the world GDP was slightly smaller than in 1960. Now, in 2024, it is 3.5 per cent of the global GDP. And since the economy is growing at twice the global average, India is the third-largest contributor to global growth.

Per capita income similarly improved. From 8.4 per cent of the global average in 1960, India's per capita income dipped to 6.4 per cent in 1974. The numbers improved to 13.5 per cent in 2011, and further to 18.1 per cent in 2023. That is a near-trebling over five decades. Yet people in most countries enjoy a much better standard of living. Indeed, there are hardly any countries outside of Africa and in India's own South Asian neighbourhood where per capita incomes are lower. A long road lies ahead.What transforms the India story is the size of its population. Per capita income is modest, but when multiplied 1,400 million times it makes the Indian economy the fifth largest. Already, India is the second-largest market for mobile phones and motorcycles/scooters, and the third- or fourthlargest for aviation and cars. Growth in these product and service markets has been underpinned by a burgeoning middle class. Businesses catering to it have generated great wealth for investors, leading to the rise of dollar-billionaires (at 200, the world's third-largest tally), while the stock market



ranks fourth by market capitalisation.Up to the mid-1970s, close to half the population lived below a bare-bones poverty line. Today, less than 10 per cent of the people are officially poor. International mention of India is now more likely to refer to it as a rising power rather than as a country of poor people. Yet, India continues to feature as only a 'medium development' country in its human development, while countries like Vietnam have attained 'high development' status. India is unlikely to make it to the 'high development' category for another decade or more — beyond which lies the 'very high development' category comprising the developed economies, to which the country aspires.

Even here, though, the numbers are improving. The mean years of schooling have improved from 4.4 years in 2010 to 6.57 years now. India also has more than the WHO-prescribed ratio of a doctor per 1,000



population, and life expectancy has finally crossed the 70 threshold.Higher incomes find reflection in a more varied and richer diet. Milk consumption has multiplied 10-fold. So has fish consumption, while the consumption of eggs has increased more than 20-fold. Add to this the rapid growth of horticulture — fruits and vegetables. Meanwhile, household savings as a share of the income have gone up 70 per cent, even as average incomes have multiplied sixfold in real terms.More important than all these may be a change in mindset. India in the mid-1970s was still committed to socialist rhetoric. Apart from large-scale nationalisation of several industries,

there was also price and production control on everything, from paper to steel, and sugar to cement, even bathing soaps and cars! The inevitable result was shortages and black markets. State governments routinely sided with trade unions in industrial disputes. But things have changed. Indian politics is now more populist than socialist, the Communist parties are in the ICU, and governments want to change labour laws to facilitate business. Tax rates have become reasonable.Rs 12 crore (about Rs 350 crore in today's money). In comparison, in the last couple of years, several companies have done

public issues of Rs 15,000-21,000 crore (LIC, Adani, Vodafone, etc). As recently as a decade ago, mutual fund companies managed sums equal to less than an eighth of bank deposits; that share has doubled to more than a quarter. The next five years could see India add more to its GDP, in absolute numbers, than it has done in the last 10.And yet, there is no story in India without a counter-story. The production of consumer durables has not increased at all compared to seven years earlier, and has gone up by an annual average of just 2.8 per cent for non-durables. Clearly, consumers are financially stressed, especially in the lower rungs of the income ladder - probably reflecting the lack of enough work on good wages. Only when that changes will the economy be able to get to the 7-plus per cent rate that once marked out the truly high-growth economies.

Farmers need assured prices to withstand market shocks



The only plausible way to pull the farmers out of perpetual poverty is by ensuring a legally binding framework for guaranteeing farm prices.

IT is called the pension reform. Prime Minister Narendra Modi has said that the Unified Pension Scheme (UPS) ensures dignity and financial security for government employees. "We are proud of the hard work of all government employees who contribute significantly to national progress," he said.In reality, the UPS - which assures a pension equivalent to 50 per cent of the last drawn salary - is an acknowledgement that the earlier market-linked New Pension Scheme had not worked for government employees. To assure a 'defined benefit' for government employees, the Union Cabinet tweaked the pension scheme to ensure that the retirees do not have to face the tyranny of the markets.While the PM has also applauded the country's farmers on a number of occasions and has often admired the resilience demonstrated by the farming community, there have been no takers for their long-pending demand for guaranteed prices. If markets have failed for retired employees, let me make it clear that markets have also failed for farmers. If employees need an assured pension, farmers also need an assured price.Nowhere in the world have markets ensured a higher income for farmers. In the major economies, either the subsidy fills the income gap (China has emerged at the top in providing agricultural subsidies) or agriculture is conveniently left at the mercy of market forces, like in India. The result, as some studies have shown, is not only that Indian farmers are at the bottom of the pyramid but also that they have been incurring losses year after year for nearly 25 years now.

The only plausible way to pull the farmers out of perpetual poverty is by ensuring a legally binding framework for guaranteeing farm prices. Regardless, the NDA government had sworn in an affidavit before the Supreme Court some years back that a law to guarantee a minimum support price (MSP) would distort the markets. Strangely, when it comes to farmers, policymakers raise the bogey of assured prices distorting markets. For employees, everyone is fine with an assured pension; the fear of distorting markets suddenly disappears.

While mainline economists believe that a legal MSP will jack up consumer prices and thereby distort markets, in reality, it will squeeze corporate profits, and hence the outcry. Strangely, the same breed of freemarket economists remain quiet when corporates in America go in for 'price gouging' — jacking up prices to rip off the consumers. This actually is price distortion. Already, 38 states, including California, Florida and New York, have brought in laws that prohibit the practice. For instance, the

state of New York went against companies that had hiked the prices of hand sanitisers by 400 per cent during the pandemic. And yet, many market economists have called such checks on visible market distortions a return to Soviet-style price controls. The bias in favour of markets crops up when farmers have to be provided with economic security, but not when corporates jack up prices to extract their pound of flesh. This double speak on market distortion is coming in the way of providing farmers with a living income. As I have said before, markets will automatically adjust to the assured prices for farmers. It is only the ideology that is coming in the way.US Vice-President Kamala Harris has called for a ban on corporate price gouging, which alone is responsible for a 53 per cent increase in the prices of food and grocery items since the pandemic. Republicans have called her position on it



'communist'. Whatever the right wing may say, there is no denying, as some economists have acknowledged, that a ban on price gouging is good economics as well as good politics. Harris has promised action against companies that are keeping food prices artificially high.

Returning to the employees' pension, it is interesting to see the Department of Expenditure make an all-out effort to justify the decision, terming it 'fiscally prudent' and claiming that "it will be preventing fiscal hardship to future generations of citizens." Certainly, there is no one against an assured pension for employees. But if the employees can be assured of social security, there is no reason why economic security cannot be assured for farmers. They also contribute significantly to the national progress, and it is because of their relentless hard work that the country has food security. When Kamlesh Patidar a farmer from Madhya Pradesh's Mandsaur district, re-ploughed his standing soybean crop on 10 acres, he did not realise that it would trigger a chain reaction. Just few days after a video of the incident went viral, reports of several anguished farmers uprooting the crop poured in. The crash in soybean prices - and that too, a month and a half before the harvesting season - has negated another economic belief that suggests farmers should hold on to harvest till the time they can realise a better price. Patidar had saved his last year's harvest in the hope of getting a higher price later. But even that did not work.

While the ruling soybean prices have dropped to a level that existed 12 years

back, the destruction of farm livelihoods leaves hundreds of thousands of soybean farmers seething with anger. The prices, which are much lower than the MSP, are not even enough to cover the production costs. I wonder when we will have an assured price policy for farmers that will prevent fiscal hardship for not only future generations of farmers but also the present one. Soon thereafter, reports about tomato prices crashing by 60 per cent to a low of Rs 300 per crate of 25 kg poured in. And then came news reports about basmati prices falling by 28 per cent to Rs 2,500 per quintal. Make your Kitchen a sleek and stylish Space

1. Anyone with the interest and little space for growing plants, even on a window-sill or balcony can build and enjoy Bonsai collection.

2. The 3 main techniques to grow your own Bonsai plants are growing, pruning and shaping.



Growing- select a tree from a nursery which has a thick trunk. take a small ceramic container to plant the bonsai - usually the depth of the pot should be equal to the thickness of the trunk of the plant. Place a plastic net at the base of the container, so that water can drain out. Now add the specially prepared bonsai soil made of garden soil, cow manure, broken brick pieces, sand and organic manure (available in the market). Trim 1/2 to 1/3rd pf the existing roots of the plant. leaving most if the thin white roots (known as feeder roots) and some old thick roots. Plant the tree into the pot.

NOTE- materials matter, so if the soil good, the bonsai will take few months or even a year to grow, and two years for fruits to flower

Pruning: Generally, you have to prune the roots and the foliage. Pruning bonsais is one of the more enjoyable aspects of growing bonsais.

4. For the flower and fruit bonsais, four to five hours of direct sunlight is essential.

5. Avoid too much of watering. Alternate days are good enough.

6. Ready-made bonsais are available. Plant them into containers with the given steps

7. Bonsais are kept indoors, but a suitable place is on the window sill, balcony, terrace or a garden shelf. Avoid keeping them in an A/C room for long. 8. Although Bonsai trees can be grown from seeds,

Acid attack, rain, and a gangrapemurder that shook Bengal 42 years ago

A cold-blooded gangrape and murder on a rainy June night in 1982 left the town of Cooch Behar, in West Bengal, scarred forever.

New Delhi: June in Cooch Behar is the month of incessant rain. It was the June of 1982. The Jyoti Basu government had just come to power. CPI(M) was at the peak of prominence in the state of West Bengal.Up north, a young woman had left her Balurghat home and moved to Cooch Behar for a government job. She was employed as the staff nurse at the state-run Maharaja Jitendra Narayan Hospital. She lived on rent with her sister and brother-in-law in a small house off an old post office in the town. The para, or locality, was known by that post office. Like every other workday, she came home in the evening. It was raining cats and dogs, like it is with rain in North Bengal.

June in Cooch Behar is the month of incessant rain. It was the June of 1982. The Jyoti Basu government had just come to power. CPI(M) was at the peak of prominence in the state of West Bengal.Up north, a young woman had left her Balurghat home and moved to Cooch Behar for a government job. The para, or locality, was known by that post office. Like every other workday, she came home in the evening. It was raining cats and dogs, like it is with rain

in North Bengal. It rained all night that June day, and it rained through the next day. The roads of the town were inundated. The nurse's neighbours raised an alarm early in the morning. They found her naked, half-dead, unable to speak, allegedly gangraped. Her throat was scalded. Her private parts burnt. A bottle of acid had been poured into her mouth



through a Ryle's tube to ensure she never identified her rapists. The same acid was used to wipe off all physical marks of the rape. The tin roof of her home swallowed her cries that night. The rain was just too loud.A few good men hailed a cyclerickshaw and helped her still-alive body on to it. They then pushed the rickshaw for a kilometre, through the knee-deep water of that June day, to MJN Hospital. She was admitted to her workplace. Sometime later, she died. The long arm of law caught hold of ten men but justice was many miles away. Of these ten, three served a tenyear jail term. They then secured bail from a higher court. The other seven were let go. The main men behind the crime were allegedly very powerful, very close to the ruling government. Their power and the people in power shielded them from the blind eyes of

justice. Her screams, once silenced by the rain and a bottle of acid, were silenced again in the courts of justice. Some of the real perpetrators were also interrogated by the police. But the power of the party in power reigned supreme. They had to be let go. No police officer in-charge was allowed to speak on the record. Questions posed to them were met with sad, wistful smiles.

This was a time before mobile phones were mainstream, and social media the mainstay of people. Cooch Behar was not a place that

usually needed many journalists. Nothing really happened in that small town. So, when the story finally made it to a fledgling daily called Uttar Banga Sambad the next day, public rage spilled on to the streets.

Cooch Behar reclaimed the voice of the girl who was gangraped, killed in cold blood, doused in acid. But all of the town's cries fell on the deaf ears of blind justice. A few days later, the nurse's grief-stricken father breathed his last. Her sister and brother-inlaw are still waiting for justice for their bright-eyed girl, forty-two years later. The town has seen forty-two Junes, eight governments, three chief ministers, and two political parties in power since then. It has seen inundated roads and government apathy. It still rains cats and dogs every June. Every oldtimer in the town sighs, cries, shakes their head when that June is brought up.

Rights body's notice to Kolkata cops over 'barbaric' action on Nabanna protesters

New Delhi:The National Human Rights Commission (NHRC) on Friday issued a notice to Kolkata Police seeking a report on the "barbaric" and "brutal" assault on the protesters during the 'Nabanna Abhijan' rallies. In its notice, issued to the Kolkata Police Commissioner, the human rights body has sought an "action taken" report in 14 days.On August 27, the 'Nabanna Abhijan' march was called demanding justice for the 31-year-old trainee doctor, capital punishment for the culprit, and the resignation of West Bengal Chief Minister Mamata Banerjee.

Large-scale violence was reported in Kolkata



and adjacent Howrah during the 'Nabanna Abhijan' protest march after protestors, aiming to reach the West Bengal state secretariat, Nabanna, fought pitched battles with the police at multiple stoppage points. The violence, which lasted for nearly four hours, led to several injuries on both sides, with senior police officers and women protestors among those who were hurt.

Bengal Governor meets Amit Shah, discusses Kolkata rape-murder case

New Delhi: West Bengal Governor CV Ananda Bose met Union Home Minister Amit Shah today at his residence to discuss the law and order situation in the state in the light of the rape and murder of a Kolkata trainee doctor at RG Kar hospital in Kolkata. The meeting continued for nearly an hour. According to sources, the Governor provided detailed information on the current situation in West Bengal. Protests erupted nationwide, particularly in Kolkata, over the trainee doctor's rape and murder, with protesters demanding swift action in the case. In Kolkata, protesting university students led the crowds, on August 27, in breaking through barricades set up by security forces to demand the resignation of West Bengal Chief Minister Mamata Banerjee for her handling of the case.

The governor arrived in Delhi yesterday evening for the scheduled meeting.Last week, Governor CV Ananda Bose also met with President Droupadi Murmu and Vice President Jagdeep Dhankhar to brief them on the RG Kar incident and the subsequent events that unfolded in the state.

The body of the woman postgraduate trainee was found in a seminar hall at the hospital on August 9 morning. A civic volunteer, Sanjay Roy, was arrested the next day in connection with the crime. The Kolkata Police and hospital administration were criticised for their handling of the trainee doctor's case, with the Supreme Court highlighting the 14-hour delay in filing of the FIR. The case is now being probed by the Central Bureau of Investigation.

Over a dozen leaders from AAP, BJP join Congress ahead of Delhi Assembly polls

New Delhi:More than a dozen leaders from the BJP and AAP joined the Congress in Delhi on Thursday ahead of next year's Assembly

polls.At a ceremony held at Rajiv Bhawan, the headquarters of the Congress's Delhi unit, leaders from the Aam Aadmi Party (AAP) and the Bharatiya Janata Party (BJP) formally joined the Congress and were welcomed by Delhi Congress chief Devender Yadav.

'Leaders from both BJP and AAP, along with their supporters, are transitioning to the Congress, motivated by the party's progressive policies and the strong leadership of Mallikarjun Kharge and Rahul Gandhi," Yadav said.During the



event, Yadav specifically welcomed Amarlatha Sangwan, a former councillor and MLA candidate from Timarpur, back to the Congress fold. "Sangwan will strengthen the party's position. She criticised the BJP's communal politics and lack of focus on public welfare," Yadav

Revanth Reddy regrets remarks on K Kavitha's bail: Highest regard for judiciary

New Delhi: Telangana Chief Minister Revanth Reddy on Friday apologised for his remarks about the bail granted to Bharat Rashtra Samithi (BRS) leader K Kavitha in the Delhi liquor policy case. This comes a day after the Supreme Court reprimanded him for his comments about a 'deal' between the BJP and the BRS for securing bail for Kavitha.In a post on X, Reddy wrote that he has "the highest regard and full faith" in the Indian Judiciary."I understand that certain press reports dated 29th August, 2024 containing comments attributed to me have given the impression that I am questioning the judicial wisdom of the Hon'ble Court. I reiterate that I am a firm believer of the judicial process.I unconditionally express my regret for the statements reflected in the press reports," the Telangana Chief Minister wrote.

The Congress leader alleged that his comments were "taken out of context" and stressed that he has "unconditional respect and the highest regard for the Judiciary and its independence". The Supreme Court granted bail to K Kavitha in the Delhi excise policy scam case on August 27, observing that prolonged incarceration before being pronounced guilty of an offence should not be permitted to become a punishment without trial. After the court verdict, the Telangana Chief Minister commented, "It is a fact that BRS worked for the victory of the BJP in the 2024 LS polls. There is also talk that Kavitha got bail because of the deal between BRS and BJP".Strongly criticising these comments, the Supreme Court on Thursday observed that such statements might create apprehensions in the minds of people. "Do we pass orders after consultations with political parties?" the court asked angrily, voicing displeasure"Have you read in the newspaper what he said? Just read what he has stated. What sort of statement is this by a responsible chief minister. That might rightly create apprehension in the minds of people. Is this a kind of statement which should be made by a chief minister? A constitutional functionary is speaking in this manner," a three-judge bench headed by Justice B R Gavai told senior advocate Mukul Rohatgi, appearing for Reddy. The bench continued, "Why should they drag court in political rivalry? Do we pass orders after consultations with political parties? We are not bothered by politicians or if anybody criticises our orders. We do our duty as per conscience and oath".

Shiv Sena (UBT) leader slammed the Maharashtra 🏴 government over reports on removing the state's first woman Chief Secretary with someone with the backing of Chief Minister Eknath Shinde and invoked President Droupadi Murmu's recent statement on women's safety while speaking about the rape-murder of a trainee doctor in Kolkata. Thackeray's reaction came after Maharashtra Congress leader Sachin Sawant shared local reports that claimed that Chief Secretary Sujata Saunik could be replaced with former Brihanmumbai Municipal Corporation (BMC) chief Iqbal Singh Chahal, who was recently appointed Additional Chief Secretary (Home), and facing corruption allegations."Just as the

President of India, Murmu ji, speaks about countering the mindset that sees women as 'less powerful, less capableâ€æ', reports state that the BJP-Mindhe



government in Maharashtra is working on making Chief Secretary Sujata Saunik ji resign even before her tenure ends, to accommodate one of their favorites who can help BJP loot Maharashtra," Thackeray tweeted.

'What a shame! Why should she resign before her tenure ends? Only because the illegal Chief Minister and BJP want their man who can give contracts to their ladka (male) contractors? This is the same mindhe-BJP mindset that tries to lure women votes through Ladki Bahin, but

has cabinet ministers who have been accused of crimes against women," he alleged.Earlier, Sawant alleged that a reported move was being made to appoint Saunik as the state election commissioner and pressure her to make way for Chahal in her place. He questioned whether this was being done to facilitate Chahal's appointment as the Chief Minister with the help of a confidant of Shinde.Notably, Chahal has been embroiled in several scams, including the alleged irregularities in contracts for Covid care centres during the pandemic. His recent appointment as the Additional Chief Secretary (Home) in the state government snowballed into a controversy, with the Opposition slamming the move. Sawant also cited the transfer of IAS officer V Radha from the agriculture department due to alleged disagreements with Agriculture Minister Dhananjay Munde, who belongs to the Ajit Pawar faction of the NCP, which is a part of the Shinde-led government.His

allegations came against the backdrop of the post of the Maharashtra Election Commission that will become vacant following the completion of five years by retired IAS officer UPS Madan. For the new commissioner, the names of retired IAS officers Manoj Saunik (Sujata's husband), Nitin Kareer and Shrikant Deshpande, and serving IAS officers Rajiv Jalota and Rajgopal Deora are doing the rounds.According to sources, Saunik is reportedly not very interested and has not yet applied for the post of state election commissioner.

Saunik, a 1987 IAS officer, became the first woman Chief Secretary of the state on June 30 and her term is till May 31, 2025, when she will turn 60. If she is appointed as the state election commissioner, she will get a term of five years.Born on June 15, 1965, Saunik is a resident of Haryana. Her husband, Manoj Saunik, is a resident of Bihar and both are IAS officers of the same batch. Manoj Saunik earlier served as the Maharashtra Chief Secretary.

Moody's raises India's growth forecast to 7.2% from 6.8% for 2024

NEW DELHI. Moody's Ratings has revised India's growth forecast for 2024, increasing it from the previously projected 6.8% to 7.2%. This adjustment is based on expectations for a stronger rebound in private consumption. Meanwhile, for 2025, growth has been pegged at 6.6% from 6.4% previously."... These forecast changes assume strong broad-based growth and we recognise potentially higher forecasts if the cyclical momentum, especially for private consumption, gains more traction," the ratings agency said.As per Moody's, household consumption is set to rise as headline inflation approaches the RBI's target. It noted that indications of a resurgence in rural demand are already visible, driven by favorable agricultural output prospects due to above-average rainfall during the monsoon season. It highlighted that both the industrial and services sectors have shown robust performance, with the services Purchasing Managers' Index (PMI) remaining consistently above 60 since the beginning of the year. UK's Aviva found guilty in \$26 million fake invoice scandal in India: Report

New Delhi. The Income Tax Department has accused British insurer Aviva of breaching local regulations by using a system of fake invoices and clandestine cash payments to bypass commission caps for sales agents, reported news agency Reuters. According to the report, this discovery was made by the Directorate General of GST Intelligence, which is responsible for monitoring indirect tax violations. The report, based on a notice sent to Aviva on August 3rd, revealed that the insurer's India business paid approximately \$26 million between 2017 and 2023 to entities that supposedly provided marketing and training services. However, the tax notice alleged that these vendors did not do any actual work. Instead, they served as a front for transferring funds to Aviva's agents, enabling the company to bypass regulatory limits on agent commissions.

The Directorate General of GST Intelligence described the situation as a "deep-rooted conspiracy," with Aviva and its officials allegedly using fake invoices

to divert funds to insurance distributors. "Aviva and its officials have indulged in a deep-rooted conspiracy and used the modus of fake invoices (without receipt of services) to pass on certain money to ... insurance distributors of Aviva," investigators wrote in the notice, Reuters reported.Such "show cause" notices usually require companies to explain why authorities should not impose penalties for their actions. This case is part of a broader investigation involving over a dozen Indian insurers for allegedly evading \$610 million in unpaid taxes, interest, and penalties. The notice indicated that Aviva wrongly claimed tax credits on the \$26 million in fake invoices, thereby evading \$5.2 million in taxes.Aviva has not yet issued any statement on the development.A source familiar with the situation mentioned that the company intends to challenge the allegations but has not yet formally responded, reported Reuters.Alleged fake invoices and cash paymentsThe tax agency's 205-page report included emails



and WhatsApp messages between Aviva executives and insurance distributors, discussing ways to circumvent compensation regulations.

The report also summarised interviews conducted by tax officials, including one with Aviva India's Chief Financial Officer, Sonali Athalye, who explained the process of making the payments.

One significant finding was an email from 2019, in which Trevor Bull, the then-CEO of Aviva India, was copied. The email discussed payments exceeding regulatory limits, indicating that senior management was aware of these practices. Both Bull and Athalye, along with Indian tax and

insurance authorities, did not respond to requests for comment. The tax notice stated that Aviva could face penalties amounting to roughly \$11 million, a sum equivalent to its 2023 profit from life insurance sales in India. Aviva operates in India through a joint venture with Dabur Invest Corp, a well-known local firm. Aviva holds a 74% stake in the business, which it increased from 49% in 2022. Despite being a relatively small market for Aviva, India is considered a growth market by the company, given its status as the world's most populous nation.India's life insurance sector, though competitive, represents a smaller portion of the national GDP compared to the UK.Data from India's insurance regulator shows that life insurance premiums accounted for 3% of the national GDP, whereas the figure in Britain stands at 8.1%. The tax notice suggested that Aviva's actions were part of a broader strategy to increase its market share in this challenging environment.

It was also his sixth hundred at Lord's as he got levelled with Graham Gooch and Michael Vaughan who also have six hundreds each to their name at the historic venue. Osaka made her return to Grand Slams earlier this year when she lost to France's Caroline Garcia in the opening round of the Australian Open. In the French Open, she ran Swiatek close and fetched a match point, but the latter won the second-round match to advance. Osaka also faltered at Wimbledon, where she could not go beyond the second round.

New Delhi Carlos Alcaraz called out the tight scheduling of the Tennis calendar after his shocking exit from second round of the US Open 2024. Notably, the Spaniard was stunned by Botic van de Zandschulp who beat him in three straight sets on Friday, August 30 at Arthur Ashe Stadium.

Van de Zandschulp beat the world number three by 6-1, 7-5, 6-4 knocking out one of the title favourites in the second round itself. Having won back-to-back Grand Slam titles earlier this year by clinching titles at Roland Garros and Wimbledon, no one expected Alcaraz to bow out this early at Flushing Meadows.Following his loss, the 2022 US Open winner spoke about the tight scheduling of the tournaments one after the other. The 21-year-old mentioned the fact that he wasn't at his best heading into the tournament and highlighting his demands for longer breaks ahead of big events."Probably, yeah. The tennis schedule is so tight.

I've been playing a lot of matches lately. With Roland Garros, Wimbledon, Olympics. I took a little break after Olympics. I thought it was enough. It was really helpful for me. Probably it wasn't enough. I came here without as much energy



as I thought I was going to come with," said Alcaraz after the game. "But I don't want to use that as an excuse. But it's so tight. I'm a player who needs more days or more of a break coming into the big tournaments and important ones. I have to think about it and learn about it. Let's see," he added. I thought he would give me more free points: AlcarazFurther speaking ahead, Alcaraz praised Van de Zandschulp for his gameplay and rued not being able to match his level as the game progressed. "I don't know what to say right now. First of all he played great. He played really good tennis. I thought he would give me more free points. He didn't make a lot of mistakes I thought he was going to make... it was confusing a bit. I didn't

know how to manage or deal with it. I couldn't increase my level. I think my level stayed the same the whole match. It wasn't enough to do it or to give myself

the chance to get into the match or try to give myself chances," he further said.

Meanwhile, the Dutchman earned the highestranked victory of his career. The World No 74 will next face 25th seed Jack Draper in the third round Saturday.

Again the onus is put on women to name and shame and take the brunt of it after that. My question's always been, what is the proof of justice you can show for you to demand that we must name and shame (the perpetrators)? After that, what happens to us, our careers, lives, legal fees and mental health issues? No one gives a damn about that. Why, again and again, the onus is put on the women to take care of the problems that are not caused by us?" she said.
