Kolkata, August 31: A civic volunteer of Kolkata Police was arrested on Saturday for allegedly riding into a barricaded area with his motorcycle and injuring one of Rabindra Bharati University students who were holding a demonstration there against the rape and murder of a doctor, a senior officer said. The incident occurred at 2 AM when the civic volunteer of the Sithi Police Station entered the barricaded area, where a night vigil seeking justice for the deceased doctor was going on, and hit one of the agitating students he said. The accused was in an inebriated condition when the incident took place on B T Road at Sinthi crossing near the varsity in the northern part of the city, one of the protesting students said. The agitating students blocked the arterial road for nearly five hours, alleging that a traffic sergeant helped the civic volunteer escape from the spot and demanding that penal action be taken against the offender. "An FIR has been filed in this matter and the civic volunteer was arrested. We have demobilised him and necessary legal steps have been taken," a senior police officer told.

District judiciary is 'backbone of the judiciary': CJI DY Chandrachud

New Delhi, August 31: Terming the district judiciary the "backbone of the judiciary", Chief Justice of India DY Chandrachud on Saturday said as a crucial component of the rule of law, district court judges have the ability to transform the present and future of our society. "The district judiciary is the first point of contact for a citizen in search of justice. The district judiciary is a crucial component of the rule of law. The arc of pending cases is defined by a triangle or a pyramid, large at the base and tapering as we move upwards. Data reveals a basic truth - the district judiciary is not just the first but is also the final point of contact for citizens," the CJI said. Addressing the inaugural session of the two-day 'National Conference of the District Judiciary', the CJI said it was necessary to stop calling district judiciary subordinate. "The district judiciary is therefore called upon to shoulder tremendous responsibility and is aptly described as the 'backbone of the judiciary'. The spine is the core of the nervous system. To sustain the spine of the legal system, we must stop calling the district judiciary as the subordinate judiciary. Seventy-five years after Independence, district judiciary in the past few years. In Kerala, 72% of the total number of judicial officers are women in the latest recruitment," he said at the conference which will also deliberate on gender dynamics in the judiciary and the need to ensure an inclusive workplace. The CJI asked the judges to keep up

with evolving times by updating themselves with new law and changing societal conditions. "Society changes with the passage of time and while judges are required to be islands, standing apart from others in society, they must still be aware of the world around them. This is indispensable in ensuring that justice is delivered in each case," he said.

more than 22,000 court Rooms have been computerised under the e-Courts Project, Justice Chandrachud lauded the district judiciary for playing a crucial role in deploying technology in day-to-day affairs. "The district courts in the country have heard 2.3 crore cases through video conferencing. The judgments of the Supreme Court are being translated in every language recognized by the Constitution. 73,000 translated judgments are in the public realm," he said. Urging the judges to focus on skill upgradation, the CJI said, "Our education is not complete with the completion of our degrees. While our formal education may end there, our practical learning extends beyond our days at university. Each case has the potential to make us more sensitive to the human condition and the human story behind the case. This, in turn, enables us to practice judging with empathy and compassion." He expressed hope that "The conference will facilitate a dialogue between and understand the concerns of judges of the district courts and enable us to chart out collective vision for the future of the Indian legal system."

EC defers Haryana Assembly poll by 4 days to October 5, result on October 8

New Delhi, August 31: The Election Commission on Saturday deferred the Haryana Assembly poll date to October 5 from October 1, keeping in mind a centuries-old festival of the Bishnoi community. The counting of votes for the Jammu and Kashmir and Haryana Assembly polls will now be held on October 8 instead of October 4, the poll body said. It said the decision has been taken to honour both the voting rights and tradi-



tions of the Bishnoi community, which has upheld a 300-400 years old practice in remembrance of their Guru Jambheshwar. The EC had received a representation from the national president of the All India Bishnoi Mahasabha, Bikaner, Rajasthan, for rescheduling the date for the Haryana assembly elections. New Delhi, August 31: Union Minister Annapurna Devi on Friday asserted that existing laws were stringent enough to tackle violence and crimes against women and urged the West Bengal government to implement the same in "letter and spirit". In a letter to West Bengal Chief Minister Mamata Banerjee, the second in a week, Devi, the Union Minister for Women and Child Development, said the state government has not operationalised additional 11 Fast Track Special Courts (FTSC) to specifically deal with cases of rape and POCSO cases. Devi said West Bengal has established 88 Fast Track Courts (FTCs), which are not the same as the Fast Track Special Courts (FTSCs) covered under the Central Government Scheme. Banerjee on Friday wrote to Prime Minister Narendra Modi, reiterating her request for stringent central legislation and exemplary punishment on heinous crimes like rape and murder.

"As may be seen, the information contained in your letter in this regard is factually incorrect and appears to be a step in the direction to cover up the delays in operationalising the FTSCs by the state," Devi said. Concerning Banerjee's observation on the need to post permanent judicial officers in FTSCs, the Union minister said the scheme guidelines clearly provide for one judicial officer and

seven staff to work exclusively for the disposal of rape and POCSO Act cases. "Hence, an additional charge of FTSCs cannot be given to any permanent judicial officer or court staff. This position was clarified

said in the event of an insufficient workforce, states and Union Territories have the option to engage judicial officers and court staff on a contractual basis under the FTSC scheme. "As regards, stringent legislations and exemplary punishment on heinous crimes like rape/rape and murder, I reiterate my earlier communication conveying that stringent punishments for rape/rape with murder already exist in the Bharatiya Nyaya Sanhita (BNS)," the minister said. Devi said the enactments by the central government are comprehensive and stringent enough to tackle the violence and crimes against women. "If the state government follows the central legislations in letter and spirit, it will certainly have a lasting impact on strengthening the criminal justice system, bringing the perpetrators of such crimes to face the consequences commensurate with the offence and also in ensuring justice to the victims or survivors," the union minister said.

Gujarat HC rejects Asaram's plea for suspension of sentence in rape case

Ahmedabad, August 31: The Gujarat High Court has rejected a plea for the suspension of sentence filed by jailed selfstyled godman Asaram in a 2013 rape case, stating that there were no "exceptional grounds" to consider the application. Asaram was sentenced to life imprisonment in the case by a Gandhinagar court in 2023. Refusing to suspend the sentence and grant him bail, a division bench of Justices Ilesh Vora and Vimal Vyas in the order passed on Thursday observed that no case for relief was made out. The sessions court in January 2023 convicted Asaram in the 2013 rape case, filed by a woman who was living in his ashram near Gandhinagar at the time of the crime. Asaram is currently lodged in Jodhpur jail in Rajasthan in another rape case. The high court noted that his contentions about possible delay in the disposal of his appeal, his age and the medical condition were not relevant to the tion. Second-century inscription found in Prakasam district

ONGOLE: A second-century common era (CE) period Brahmi inscription in the Prakrit language was recently discovered near Tripurantakam village in Prakasam district recently. Local historian and Village Revenue Officer (VRO) Thurimella Srinivasa Prasad of Yerragondapalem, along with his team, found this inscription on a pillar near the Tripurantakesvara temple. The team has sent them to the Archaeological Society of India



(ASI) in Mysore for verification.

Munirathnam Reddy, Director (Epigraphy) at ASI, Mysore, confirmed the inscription's contents. Experts identified the text as being in Prakrit, using Brahmi script from the second century CE. The inscription reads: 'Gahapatisa Sehisa Chadamukhasa Deyadhama,' accompanied by a swastika symbol. It records a donation of a six-faced pillar (Chadamukhasa) by a householder named Sethisa (Gahapati).Additionally, two 15 century Telugu stone inscriptions were also found within the Pullalacheruvu mandal of the district.

Karnataka updates signage rules for integrated medical practitioners

BENGALURU: In response to the concerns from the Karnataka State Registered Integrated Medical Practitioners Association, the health department introduced a new regulation for integrated doctors.Previously, practitioners who are qualified to offer both allopathy and indigenous medicine had to use a light green colour board similar to that of Ayush doctors, who practise Indian medicine (Unani, Ayurveda, Siddha, and Homeopathy). However, the common use of a light green board lacked a clear differentiation, which was potentially misleading patients, as per the integrated doctors. The association president Dr Aravinda Paradkar argued that the uniform green board failed to distinguish integrated doctors from their Ayush counterparts. He highlighted that the use of a single colour could confuse patients into single colour could confuse patients into believing that all doctors at the establishments, which display a light green board, provide both allopathic and Ayush services, especially in rural areas. With integrated medical courses discontinued nearly 30 years ago, and only a limited number of these practitioners remaining number of these practitioners remaining, clear signage became crucial to avoid deception. Considering these issues, the health department mandated a new board design for integrated doctors. Under the new regulation, these doctors must display a board that is horizontally divided, with the upper half in light green, and the lower half in light blue, to ensure transparency and avoid confusion among visitors.

Bengal student leader gets bail for role in violence during Nabanna protest

The Calcutta High Court on Friday granted bail to Paschim Banga Chhatra Samaj leader Sayan Lahiri, who was claimed to be one of the organisers of a rally to state secretariat Nabanna on August 27 to protest the rape and murder of a The court directed the state to file an trainee doctor at RG Kar Medical College and Hospital in Kolkata.Paschim Banga Chhatra Samaj, an unregistered student group, was one of the two organisations that gave the call for 'Nabanna

Abhijan'.Lahiri was arrested on August 27 evening for playing an active role in leading the rally which, the police said, turned violent causing destruction of public and private property and attacks on police officers.

Observing that Lahiri appears to be an absolutely insignificant character who does not hold any position of power or influence "in the massive cry for justice in the aftermath of the

RG Kar incident", Justice Amrita Sinha said that to uphold and restore the faith of the public in the judiciary, he was liable to be released on bail. Acting on a petition by Lahiri's mother Anjali seeking cancellation of proceedings against him and grant of bail, the court ordered his release from custody by 2 pm on Saturday.Justice Sinha restrained the police from taking any

coercive action against Lahiri in connection with the case, which he has been arrested or any other case which has been or may be registered against him without the leave of the court.

social uproar against the unfortunate incident at RG Kar," she said in the order.Justice Sinha said that the Supreme Court had on August 22 made it clear that peaceful protest should not be disturbed or disrupted, while restraining the state authorities from taking any precipitate action against peaceful protesters.

Karnataka: Missing Gadag woman found alive in empty well after three days

GADAG : A woman, who went missing from Totaganti village in Gadag district on August 20, was found alive in an abandoned empty well on the outskirts of the village after three days.She is now under treatment at the Gadag Institute of Medical Sciences (GIMS) Hospital.Parvati Kalmath of Totaganti village told police that an unidentified woman entered her house around 5 am on August 20 when she was working in the kitchen. "The woman dragged me to an isolated place in the village where she snatched my mangalsutra, bangles and other ornaments and pushed me into the empty well," Parvati said."I lost consciousness after the woman pushed me into the well. I regained consciousness on the third day when I got drenched in rain. I screamed for help for almost two hours. Finally, some people heard my cries and pulled me out of the well," she said.

Some villagers said many such incidents happened in the village in the past where lonely women were targeted. They had informed the police about such incidents.

Docs: Parvati recovering fast

The villagers said Parvati and her husband came to Totaganti village six months ago. They have been living in the village since then. The villagers said some boys, who were grazing their sheep and goats near the well, rushed to Parvati's rescue after hearing her screams for help. Parvati was weak and could not even speak when she was pulled out of the well. The police said that they will question Parvati once she recovers fully. Meanwhile, the doctors attending to her said she is recovering fast.

No takers for 66% tech seats, 74% vacancy in private colleges

Government colleges, on the other hand, have fared well in counselling this year.

BHUBANESWAR: A significant chunk of engineering seats in Odisha has remained vacant after completion of the BTech counselling for 2024-25 with private colleges and institutions facing yet another year of declining enrollment.Data from the Odisha Joint Entrance Examination (OJEE) committee that carried out BTech admission to different colleges and institutions for the current academic year reveal that 66 per cent of engineering seats are still vacant after four rounds of counselling. The rate of decline in enrollment is 3.8 per cent more than the



previous year during which around 62.80 per cent of seats had remained vacant after four rounds of OJEE counselling.Of the total 44,484 BTech seats available in nine government and 75 private engineering

colleges and institutions in the state, sources said, only 15,342 seats have been filled up A technical education official said BTech seats while the remaining 29,142 are vacant after the OJEE counselling that concluded on Thursday.Out of the total 38,758 BTech seats in private engineering colleges, only 10,052 have been filled up. Over 74 per cent BTech seats are vacant in less reputed private engineering colleges. Last year, seat vacancy in private engineering colleges was 68.5 per cent.Government colleges, on the other hand, have fared well in counselling this year. BTech enrollment in these colleges rose to 92.5 per cent in 2024-25 from 80.4 per

cent last year.

have remained vacant primarily due to disinterest of students towards traditional engineering courses in the rapidly evolving job market. However, this is also an opportunity to bring new reforms, especially in private institutions, he added. OJEE officials said the vacant seats will now be handed over to private colleges for enrollment at their level. Spot admission will also be carried out for a few hundred seats which have remained vacant in government engineering colleges.



48 arrested in Bengaluru water resources recruitment scam

BENGALURU: The Special Enquiry Squad of Central Crime Branch (CCB) arrested 48 people, including three government employees, in connection with a scam in the direct recruitment of second division assistants in the Water Resources Department (WRD). The arrested include 37 candidates, who had submitted fake documents, and 11 middlemen. The Department had invited online applications to fill 182 backlog 'C' group posts in October 2022. The middlemen had a network of creating counterfeit marks cards of class 12. The candidates who were not eligible as per the department criteria used the services of these middlemen. They obtained marks cards with good marks in all subjects as prescribed in the eligibility criteria.Department officials filed a police complaint at the Central division on July 28, 2023 after finding 62 ineligible candidates applying for the vacancies by submitting fake Class 12 marks cards. The case was later handed over to Central Crime Branch.

The three arrested government employees are Anand, principal, Morarji Desai Residential PU College in Kalaburgi, Krishna Gurunath Rathod, First Division Assistant, Karnataka Power Corporation Limited, Jog in Shivamogga and Gangoor Pradeep, Second Division Assistant, Water Resources Department, Hassan. The 11 middlemen were arrested from Hassan, Mandya, Jewargi, Vijayapura, KGF, Bengaluru, Shivamogga and Tumakuru. The middlemen reportedly created fake marks cards for II PUC, Class 12 of CBSE and NIOS. The counterfeit mark cards were submitted online, robbing genuine candidates of their opportunity.In all, 62 candidates from 12 districts submitted fake marks cards, of whom 25 were from Kalaburagi, 12 from Hassan, six from Belagavi, three each from Yadgir, Vijayapura and Bidar, two from Chitradurga district, and one each from Ramanagara, Koppal, Kolar, Raichur and Vijayanagar districts.

Gurgaon: Remove campaign posters from autos, MCG tells owners

GURGAON. With autorickshaws being used increasingly for political campaigning ahead of Haryana assembly election, MCG on Friday took cognizance and directed unions to ensure that such posters are taken down as model code of conduct (MCC) was in effect. The corporation told autorickshaw owners that they have two days to remove any political posters, and if they don't, stern action will be taken by the regional transport authority (RTA). Autorickshaws are fast becoming a new method of campaigning, with posters being displayed on the three-wheelers while they traverse the city. Officials said that it is a convenient alternative to putting up posters or hoardings, which are often taken down by authorities. MCG additional commissioner Balpreet Singh, who is also the MCC nodal officer in the city, said that a drive was initiated to remove hoardings, banners, stickers and wall paintings of political parties or functionaries from public places." If any vehicle is found with promotional materials of campaigning for the election, the vehicle will be seized, and an FIR will be registered," Singh told RTA officials on Friday. Tek Chand, a member of the Gurgaon Auto Association, said representatives of the group attended Friday's meeting too."We understand that model code of conduct is in place. So, we have decided to take down these posters and advertisements," Chand said.Haryana goes to the polls on Oct 1, and results will be declared on Oct 4. On Friday. The additional commissioner said anyone can flag MCC violations through the C-Vigil app, social media and other channels. "If any MCC violations are found during any inspection by EC and administration officials, action will be taken against responsible officials of that area. All concerned officials must ensure strict compliance with MCC within their jurisdictions," Singh said.

informed scrap vendor Ramveer. 'Around 10.30am, Ramveer and two of his friends Pankaj and Jitesh came on two bikes and forcibly took Naresh with them to an unknown location. The scrap vendor and three of his friends then thrashed Naresh for hours. Later, they left him near a private hospital on Basai Road," said Gurgaon police spokesperson Sandeep Kumar.Naresh, cops said, got first-aid at the hospital and went back to his home in Dhankot village."After reaching home, Naresh told the family members that he was beaten up by Ramveer and tried to rest. But, in the evening, his condition suddenly deteriorated due to internal injuries and family members rushed him to a private hospital in Sector 43. He



succumbed to his injuries while undergoing treatment," the spokesperson said.Naresh's brother Jagbir Singh filed a complaint and an FIR was registered under sections 103(1) (murder), 140(1) (kidnapping or abducting in order to murder), 190 (unlawful assembly) and 191(2) (punishment for rioting) of BNS at New Colony police station on

Now, barriers on Gurgaon's **IFFCO** Chowk flyovers

GURGAON: The National Highways Authority of India (NHAI) has started installation of visual barriers on the IFFCO Chowk U-turn flyovers as part of a trial to enhance road safety and reduce accidents on the stretch.

Installation work has already begun on the U-turn flyover towards Delhi and is expected to be completed within the next 15 days, an NHAI official said.Similar barriers will be installed on the Delhi-Gurgaon U-turn as well. According to NHAI officials, buildings in the vicinity of the flyover contribute to visual clutter, diverting drivers' attention from the road."These barriers will help reduce chances of drivers getting distracted by surrounding buildings and will enhance road safety. If the trial proves successful, this could be replicated at other structures along the Delhi-Gurgaon Expressway," a senior official said on Friday.

The visual barriers comprise thick metal-framed plastic sheets and are designed to minimise distractions and help drivers maintain focus,



particularly on elevated or curved sections of the road where motorists are more likely to lose control.In recent years, FFCO Chowk U-turn flyovers have witnessed multiple accidents. In June this year, a 19-year-old student lost his life

- Municipal Corporation of Gurgaon (MCG) has planned to purchase 40 hydraulic trash compactor systems at a cost of Rs 36 crore. The corporation had sought approval from the state govt to buy waste compactors before the implementation of model code of conduct, but it is still pending.Under the proposed plan, each of the 35 wards will be allocated one compactor and the remaining will be deployed to serve the extended areas under the corporation's jurisdiction.
- The direction to acquire such systems came during a July 7 meeting conducted by Haryana chief secretary TVSN Prasad to assess the progress of Solid Waste Environment Exigency Programme (SWEEP).
- "The decision was made in the light of the termination of the concessionaire agreement with Ecogreen. We have written to the state govt to procure 40 hydraulic waste compactors. Our proposal would have to be tabled before the high-powered purchase committee, which approves purchases of over Rs 5 crore, as each compactor costs around Rs 90 lakh," said an MCG official privy to the matter. The corporation terminated the contract with its concessionaire Ecogreen on June 15. The concessionaire was engaged in primary (doorstep) waste collection, secondary waste collection and transportation of waste to Bandhwari. Two agencies were hired for secondary waste collection and transportation, one of which was recently issued a notice for not transporting enough waste to the landfill site.Meanwhile, the MCG also recently sought 600 additional sanitation workers through Haryana Kaushal Rozgar Nigam (HKRN).

Rash, fever and lymph nodes: UP lists Mpox symptoms

Noida. The health department issued an advisory on Friday on possible Monkeypox symptoms, asking people to report to the doctor if they had rash, fever, and swollen lymph nodes. The advisory noted that Mpox was usually self-limiting and lasted 2 to 4 weeks. It added that in severe cases, the mortality rate was between 1-10%. The disease, it said, can be transmitted through contact with infected animals, humans, or contaminated surfaces, entering the body via broken skin, respiratory tract, or mucous membranes.The guidelines suggest animal-to-human transmission may occur through bites, scratches, or consumption of bushmeat from wild mammals and can spread through contaminated bedding."The clinical presentation of Mpox is similar to Smallpox, though less contagious and severe. The incubation period ranges from 6 to 13 days, and affected individuals are typically not contagious during the infection. However, they can spread the virus 1-2 days before rash onset until the scabs fall off," said Sunil Sharma, CMO of Noida. Sharma added.

Nepalese rapist-killer gets death for Faridabad rape-murder, court calls 2022 crime 'diabolical & dastardly'

GURGAON: A Nepali man arrested in 2022 for the brutal rape and murder of a woman sitting alone near a metro station in Faridabad was handed the death sentence on Thursday by a local court, which saw no reason to show leniency for a crime that it described as "diabolical, revolting and dastardly"

Manoj Nepali was arrested after he was spotted on CCTV footage walking with the woman close to the crime scene. What made this case "brutal and grotesque" was the horrific manner in which the crime was committed. The woman was found dead with a trauma injury on her head. She also had internal injuries from a broken pipe he thrust into her private parts.On the night of Nov 7, 2022, she was sitting alone near Bata Chowk metro station after a fight with her mother when Manoj - a daily wager - walked up to her and enquired if all was well. After striking up a conversation, he offered to share her problems and persuaded her to walk with him. Manoj took her to a vacant building in Sector 7, where he overpowered and raped her.He forced her to walk with him and sexually assaulted her again near a park.s the woman tried to fight him off, he pulled the two ends of her dupatta, strangled her and banged her head against a wall."The tormentor would not let go of the dupatta. After some time, she slumped



to the ground. Realising she had died, Manoj picked up an iron pipe lying nearby, inserted it into her private parts and fled the spot," said Suresh Chaudhary, the public prosecutor.Passersby spotted her body the next morning and informed police. A case of rape and murder was registered at Sector 8 police station and a manhunt was launched for Manoj, based on the footage. The hunt took police all the way to the Nepal border at Sonauli in UP. On Nov 18 - 11 days after the crime -Manoj was trying to sneak into Nepal when he was arrested. Originally from Samdu, he had been working in Faridabad

for some years

On Nov 21, police reached out to the woman's husband with her photograph. He identified her as his wife. The husband told police his wife had left for her parents' house in Ballabhgarh three months before the day she was murdered.On Nov 7, when his in-laws informed him she had left home after a fight, he said he had started looking for her. Police had said at the time the husband - a construction site worker - did not have a TV set or phone at home, which was why he was not aware of the rape and murder.During the course of the hearing,

the prosecution submitted in court the footage showing Manoj walking with the woman, and other forensic and medical evidence to seek capital punishment for him.Sudhir Kumar, who represented Manoj in court, argued there was no witness to the crime and police had relied only on circumstantial evidence to arrest his client. This argument was rejected by the court.On Thursday, additional sessions judge Purushottam Kumar observed that "all incriminating circumstances were duly proved by the prosecution and are consistent only with the hypothesis of the guilt of accused Manoj Nepali and are inconsistent with his innocence"."It formed a complete chain and proved that in all human probabilities, the victim/deceased was orutally raped and murdered by the accused Manoj Nepali only and no one else," the court said.

The court, in its order, also took note of the multiple injuries on the woman, bloodstains on the wall where she banged her head and marks of resistance on the ground."The offence was committed in an extremely brutal, grotesque, diabolical, revolting, and dastardly manner, so as to arouse intense and extreme indignation of the society," the udge observed.

Doctor charged in 'Friends' star Matthew Perry's death 'incredibly remorseful'

World. One of two doctors who are amongst the five people charged in the ketamine overdose death of "Friends" star Matthew Perry was barred by a federal judge on Friday from practising medicine and through his lawyer afterward expressed remorse.

Dr. Mark Chavez appeared in U.S. District Court in Los Angeles for a brief arraignment on a single felony count of conspiracy to illegally distribute ketamine and was permitted to remain free on \$50,000 bond.Chavez has previously signed an agreement with federal prosecutors to enter a guilty plea, which defence lawyer Matt Binninger told reporters his client would do at a later proceeding to be scheduled within a few weeks. No plea was entered on Friday.As part of the bond conditions set by Magistrate Judge Jean Rosenbluth, Chavez also surrendered his passport and was ordered not to practice medicine. He had agreed to surrender his medical licence at a separate administrative hearing earlier this week, according to a spokesperson for the U.S. Attorney's Office."My client is accepting responsibility. He's doing everything in his power to cooperate, to help in this situation, and he's incredibly remorseful," Binninger said outside the courthouse. The lawyer added that Chavez's regret stemmed not from Perry's celebrity but from the fact that "someone who was trying to seek treatment died."

You could almost hear the river crying 'I am free'': Tribes celebrate as dams fall in US river, freeing salmon trapped for a century

- World. Workers on Wednesday dismantled the final dams on a crucial section of the Klamath River, US. This action cleared the way for salmon to swim freely for the first time in a century. The removal is part of the largest dam removal project in US history.
- Yurok tribal member and attorney, Amy Bowers Cordalis, had tears in her eyes as she witnessed the return of the river: "It was surreal. It was so emotional. I felt so hopeful and so satisfied that we have restored this river," she said. "And looking at it you could almost hear the river crying, 'I am free, I am free', as reported by the Associated Press.
- Cordalis is engaged in a battle for the removal of Klamath damns since 2002 when she witnessed thousands of salmon die in the river due to a bacterial outbreak caused by low and warm temperatures.As the river flows freely once more, how quickly the salmon will return to their historical habitats remains uncertain. Early reports suggest that salmon have already begun their journey upstream. Michael Belchik, senior water analyst for the Yurok Tribe, said,

Wells Fargo employee death tragedy: How did body go unnoticed for 4 days of ignored odors

World. In a tragic and unsettling case, Wells Fargo employee Denise Prudhomme, 60, was found dead at the company's Tempe office on August 20, four days after her last recorded scan into work. Authorities and colleagues are grappling with the disturbing details of the discovery, raising questions about the conditions at the office.

Prudhomme had scanned into the Wells Fargo corporate office near Priest Drive and Washington Street at 7 am on August 16, according to reports. The body was discovered only when security personnel, responding to reports of an unresponsive individual, checked the building. The Tempe Police Criminal Investigations Bureau confirmed that there were no signs of foul play. An anonymous worker shared their shock and was reported by 12News as saying, "It's really heartbreaking and I'm thinking, 'What if I were just sitting there?' No one would check on me?" Another employee expressed their distress over the incident, revealing that several people had noticed a foul odor but passed it



off as faulty plumbing.

The cubicle where Prudhomme was found was reportedly located on the third floor, away from the main aisle. This isolation may have contributed to the delayed discovery of her body. "To hear she's been sitting at the desk like that would make me feel sick," the employee said, highlighting


concerns about the lack of immediate action.

- Despite Wells Fargo's statement expressing deep sadness and offering support through Employee Assistance Consulting services, some employees feel the bank has not been transparent enough about the incident. "I just feel like they aren't being transparent with us," one worker lamented. "Somebody needs to acknowledge this."
- The Tempe Police Department and the Maricopa County Medical Examiner's Office are working together to determine the cause of Prudhomme's death. The investigation is ongoing, but preliminary findings indicate no signs of criminal activity.Wells Fargo has assured the public that they are fully cooperating with the investigation and have addressed the situation internally. The company's statement to 12News emphasized their commitment to supporting affected employees and ensuring the building was thoroughly cleaned.

US woman found dead in cubicle 4 days after checking into building for work

World. Four days after last scanning in for work, a 60year-old office worker in Arizona was found dead in a cubicle at her workplace, having never left the building during that time, authorities said.Denise Prudhomme, who worked at a Wells Fargo corporate office, was found dead in a third-floor cubicle on Tuesday, August 20, Tempe police said. She had last scanned into the building

on Friday, August 16, at 7 am, police said. There was no indication she scanned out of the building after that.Prudhomme



worked in an underpopulated area of the building. Her cause of death has not been determined, but police said the preliminary investigation found no

obvious signs of foul play. The investigation is continuing."We are deeply saddened by the loss of our colleague, Denise Prudhomme," Wells Fargo said in a statement. "Our thoughts are with her family and loved ones, and we are in contact to ensure they are well-supported during this difficult time. We are committed to the safety and wellness of our workforce."Counsellors have been made available to support employees, the company said.Police responded after on-site security called about an

employee they believed to be dead. Prudhomme was pronounced dead at 4:55 pm on August 20, police said.

China reasserts its claims in regional disputes, pushes rivals' limits

Beijing. China's campaign of confrontation, from remote reefs in Southeast Asia to Taiwan and farflung Japanese islands, is designed to wear down regional rivals competing with it for contested territories, analysts say. Beijing in recent years has asserted its claims in the long-running disputes far more boldly as its military strength has grown.

The escalating actions -- over islands in the East China Sea claimed by Japan, the self-ruled territory of Taiwan and the South China Sea -have also come as Beijing's rivals have drawn closer to the United States.China) believes its strong-arm tactics are paying dividends," Duan Dang, a Vietnam-based maritime security analyst, told AFP.China has in recent months deployed military and coast guard vessels in a bid to eject the Philippines from a trio of strategically important reefs and islands in the South China Sea."The number of fronts where an accident could spiral suddenly is very real," Dylan Loh, an assistant professor at Singapore's Nanyang Technological University, told AFP.The latest flashpoint is Sabina Shoal, just 140 kilometres (86 miles) west of the Philippine island of Palawan and roughly 1,200 kilometres from China's nearest major landmass, the island of Hainan.On Monday, Beijing said it took "control measures" against two Philippine Coast Guard ships that "illegally' entered the waters near Sabina Shoal.

Brazil's Supreme Court judge orders suspension of X amid feud with Elon Musk

Sao Paulo/Brasilia. A Brazilian Supreme Court justice ordered on Friday the "immediate suspension" of social media platform X in the country, after a courtimposed deadline expired for the company to identify a legal representative in Brazil. The move is the latest chapter in an ongoing feud between Brazilian Supreme Court Justice Alexandre de Moraes and Elon Musk, which also included the freezing of the satellite internet provider Starlink's financial accounts in Brazil. In the decision, Moraes ordered the full and immediate suspension of X in the country until all related court orders on X were complied with, including the payment of fines amounting to 18.5 million reais (around Rs 27.66 crore) and the Brazil. Moraes ordered telecommunications regulator Anatel to implement the suspension order, and to confirm to the court within 24 hours that it had carried it out.In a bid to avoid the use of virtual private networks (VPNs) to circumvent the blockage, Moraes said that individuals or companies who tried to keep access to the social network that Amid the underlying feud over X, Brazil's

BLA terror attacks may delay launch of Chinabacked airport in Pakistan

ISLAMABAD. The start of operations at a Chinese-funded airport in Pakistan's Balochistan has been pushed back for a security review after last week's attacks by separatists in the area, govt and aviation sources said. More than 70 people were killed in the attacks, where militants seeking the region's secession have been targeting govt forces and projects being developed as part of the China Pakistan Economic Corridor. \$200-million airport in Gwadar, a joint venture between Pakistan, Oman and China, is close to completion. The initial plan was for PM Shehbaz Sharif to inaugurate it on Aug 14 alongside Chinese officials,

but that was called off after an ethnic Baloch rights group started a sit-in protest, the officials said. Following the attacks, two officials at CAA and two others in the provincial govt said the start of flights would be delayed as authorities review security in the region.

Pakistan's military, meanwhile, said it had killed five insurgents and wounded three others in intelligence-based operations launched in the province in response to the attacks. "Operations will continue until all perpetrators, facilitators and abetters are brought to justice," the army said.

A Russian guided bomb attack on Ukraine's northeastern city of Kharkiv hit a residential building and a playground on Friday, killing seven people and injuring at least 77 more, local authorities said.Ukraine's President Volodymyr Zelenskyy said a 14-year-old girl was amongst the dead. Ihor Terekhov, the city's mayor, had earlier said on Telegram that one child was killed in the playground. The 12-storey apartment block caught fire as a result of the strike, the mayor said. The death toll from the attack climbed to seven when a woman's body was recovered from the rubble, he added in a later statement. About 20 of the injured were in severe condition, regional governor Oleh Svniehubov said.One end of the block was engulfed in black smoke, with many of the upper floors in flames. Several cars parked outside

were gutted by fire.Emergency services and rescue volunteers rushed to carry survivors out of the building. The body of one of the victims lay under a carpet on the ground outside, surrounded by police.

Residents of all ages, some of them covered in blood, sat stunned on benches and walls outside as medics attended to their



injuries.Kharkiv has been the focus of heavy Russian bombing throughout the war, although there has been a drop in intensity in recent weeks, possibly related to a shock incursion launched by Ukrainian forces into Russia's Kursk region. Ukrainian authorities said that Friday's attack involved five aerial guided bombs launched from planes in Russia's Belgorod region, also known as

"glide bombs", which are fitted with a navigation system taking them to their targets. The weapons are hard to intercept, and they have become a fearsome tool in the war in eastern Ukraine in recent months that can cause huge devastation.Russia denies deliberately targeting civilians. Thousands have been killed and wounded during the full-scale invasion Moscow launched in Ukraine in 2022.In the wake of the Kharkiv strike, Zelenskiy renewed a call on Western allies to allow Ukraine to use long-range Western weapons to attack Russian military air bases."A strike ... would not have happened if our defence forces had the ability to destroy Russian military aircraft where they are based," Zelenskiy said on Telegram. "There is no rational reason to restrict Ukraine's defences.'

Kyiv says that the most effective way to counter such strikes is to target Russian planes, not the bombs themselves.

US dog breeder Paul Peavey's murder: Suspect Sergio Ferrer arrested, puppies still missing

World In a case that has captivated local and national interest in the US, the murder of Paul Peavey, a renowned Colorado dog breeder, has taken a chilling turn. Peavey, 57, was found dead on August 21 at the bottom of a hill on his 110-acre Idaho Springs property, his body covered by debris. The discovery was made by friend Bruce Boynton, who had grown concerned after Peavey failed to answer his phone."I'm the one that went up to the property and realized things were awry to the point where the puppies were gone, the house was tossed, anything of value missing," Boynton recounted, revealing the disturbing scene, reported the Washington Post. The home was in disarray, with Peavey's gun, metal detector equipment, and jewelry missing. The door to the shed where Peavey kept his Dobermans was open, and a few adult dogs were found wandering outside.As per the reports, the Clear Creek County Sheriff's Office has since arrested Sergio Ferrer, 36, on charges of murder and aggravated



robbery. Ferrer was initially detained on an unrelated warrant from Nebraska but was identified as a person of interest in Peavey's death. Authorities are now focusing on the missing puppies as a crucial piece of the puzzle. "Locating Peavey's unaccountedfor puppies may also help solve his

homicide," the sheriff's office said. Peavey, known for his business Elite European Dobermans, bred high-quality Dobermans and was an active community member. His dedication to his dogs was evident, with each puppy trained to be both a trusted companion and a skilled guardian. "That

was his life," Boynton said. "I mean, that's what kept him going, was those dogs,' quoted the Washington Post. The missing puppies, all microchipped, may have been sold through social media since August 20. The sheriff's office is urging anyone who has recently purchased a Doberman puppy to check for a microchip and report any findings.Boynton's frustration with the investigation's initial handling led him to organize a search party. His group quickly located Peavey's body, prompting an apology from Sheriff Matthew Harris for the mishandling of the initial welfare check. "I felt a lot of sadness and a lot of anger," Boynton said.As the search for Peavey's stolen puppies continues, the case has drawn significant attention, highlighting the intersection of grief, crime, and the deep bond between a breeder and his beloved dogs. The investigation into Ferrer's alleged involvement remains ongoing as authorities piece together the mystery surrounding Peavey's tragic death.

- The administration assured students that stricter measures will be implemented to prevent such untoward incidents in the future. The institute's administration has reviewed the incident and promised to enhance safety measures, particularly for female students. The security officer has been instructed to increase vigilance to prevent similar occurrences.

Chief administrator of the temple Arabinda Padhee said after all the expenses of 2024-25 financial year, the surplus amount would be Rs 100.98 crore.

As per the decision of the managing committee, the Natya Mandap will be air-conditioned for convenience of thousands of devotees visiting the temple everyday. Besides, all almirahs and chests kept in mandap will be removed to allow movement of elderly devotees, women and men in three separate queues. There will also be an elevation in the mandap to allow devotees to have a clear 'darshan' of the Trinity from the 'Bahara Katha'. "We have had a preliminary round of discussions on these arrangements to be made in the Natya Mandap with our structural engineers. Subsequently, we will speak to the Chhattisha Nijog and other servitors to streamline the movement of devotees," said Padhee.Further, doors of both the chambers of Ratna Bhandar will be clad with gold after the Archaeological Survey of India (ASI) completes its renovation work of the temple treasury. "Earlier, there was a proposal to clad the Bahara Bhandar door with silver and the Bhitara Bhandar door with gold. But the managing committee decided on the day that the doors of both the chambers will be covered in gold," he said. This apart, the temple administration will have an FM channel of its own and also come out with an SOP to provide financial aid to sevayats who are doing well in wrestling, body-building and extracurricular activities. For streamlining 'nitis' in the shrine and ensuring proper coordination with sevayats of various nijogs for the purpose, it was decided that a niti sub-committee meeting will be held once in a month by the district collector or deputy chief administrator.

The court ruled that Mallunathan, who was entrusted with the bank funds, had taken undue advantage of the trust reposed on him, while Quiam took undue advantage of the situation for personal gain. Online rummy loss: Chennai woman stages theft of 25 sovereigns

CHENNAI: A 55-year-old woman was arrested by Valasaravakkam police on Friday for staging a robbery. The suspect allegedly pawned her daughter's 25 sovereigns of gold and lost the money in online rummy. She staged the robbery to keep her daughter in the dark about the loss. - "She was hospitalised and the police were alerted. The family told the police that an unidentified gang broke into their house and stole 25 sovereigns. They also claimed that the gang sprayed a sedative on Shanthi before tying her up. However, CCTV footage showed no one entering the house and there was no sign of forced entry. Growing suspicious, they checked the house and found receipts of pledged gold jewellery," a source said.
- Perusal of Shanthi's call records showed that she regularly spoke to a pawn shop owner. Upon inquiry, the shop owner said that the woman had pawned 25 sovereigns with him. Upon further interrogation at the hospital, Shanthi allegedly confessed to the staged robbery," a police officer said. She will be taken into custody after her discharge from the hospital.

Vethan Thandel and Akshay Naik received money every month for eight months. Sunil, who received money from her for four months, later blocked her on Facebook.

Mobile phones, electronic devices seized from trio

NIA sleuths from Hyderabad nabbed one Deepak and a few others in 2023 at Vishakapatnam in a similar case. During interrogation, they revealed their Karwar network. Vethan, Sunil and Akshay got money transferred to their bank accounts from the same account Deepak and his team used to get.

Vethan and Akshay stopped getting money. Based on this evidence, NIA sleuths from Bengaluru and Hyderabad arrived in Karwar on August 27 and took the trio into custody on August 28. The sleuths have seized mobile phones and some electronic devices from the trio. Notices have been issued to them.

Vethan has been directed to go to Hyderabad for further investigation. Akshay has been asked to appear before a team of NIA officers next week.

Stray dog bite cases surge in Bengaluru amid population control efforts

BENGALURU: After back to back stray dog bite cases being reported in Bruhat Bengaluru Mahanagara Palike (BBMP) in just three days, TNIE gathers that there have been 11,448 stray dog bite cases recorded from January this year. However, the Palike's Animal Husbandry Department maintains that the number of cases reported has been coming down, compared to previous years."There were as many as 42,818 cases of stray dog bites, in the 2019-2020. However, this year, only 16,888 are reported, which also include caes of pet dog bites,' said a senior official. According to the BBMP special health commissioner Suralkar Vikas Kishore, "Around 30 to 40 cases have been recorded daily, since January. Compared to the statistics from 2018, the numbers have drastically reduced.

This apart, stray dog population has also come down. "There were over 3.10 lakh stray dogs in 2019. With continuous Animal Birth Control (ABC) programs, the number has reduced to 2.7 lakh, as per a survey in 2023," said the special commissioner. A senior animal husbandry department official said that the palike has managed to cover 72 per cent of stray dogs, and operated in core areas of Bengaluru, and added that majority of the stray dog population is in outer areas like Bommanahalli, RR Nagar and Mahadevapura."There are 2,79,335 stray dogs in Bengaluru, out of which 1,65,341 are male dogs and 82,757 are female.

Details about 31,237 dogs is still not known. The department has managed to cover 12,773 stray dogs under the ABC program since January, and has vaccinated 37,394 stray dogs by engaging four agencies," said the Deputy Director of BBMP animal husbandry department, Dr Chandraiah T.A senior animal husbandry department official said that the palike has managed to cover 72 per cent of stray dogs, and operated in core areas of Bengaluru, and added that majority of the stray dog population is in outer areas like Bommanahalli, RR Nagar and Mahadevapura.

Corporate dominance widening rich-poor gap

INDIAN economy has witnessed a meteoric rise of corporate companies over the decades. Although the Industrial Policy Resolution of 1956 reserved the commanding heights - steel, heavy industries, machine building sector, metallurgy, defence, etc. - in the public sector through the licensing system, private companies were able to grow in consumer goods and banking businesses. The RK Hazari Committee and S Dutt Committee

were set up in the 1960s to review and examine the working of the licensing system and suggest measures to improve its working. These committees found that companies belonging to large business houses violated and exploited the system; these firms were able to get licences in areas such as defence, reserved for the public sector. Also, private companies owned by large business houses were able to get licences in sectors reserved for small and medium companies. It was found that on the pretext of foreign collaboration in 70 items in the category of non-essential items, licences were given to companies of business houses. In view of the above, the Government of India enacted the Monopolies and Restrictive Trade Practices Act in 1969. According to this Act, a monopoly company/business house owned assets of Rs 20 crore or above. Such a company or business house was not to be given licences for further expansion and setting up of new enterprises. This limit was raised toRs 100 crore or above in 1985. This limit of assets and definition of a monopoly house became redundant with the abolition of the licensing system.In the wake of a foreign exchange crisis, a package of policy changes was introduced in 1991. This was called the new economic policy, marked by liberalisation, privatisation and globalisation. This was done to allow private corporate companies to expand their businesses and freely collaborate with foreign capital. This also reflected the growing clout of these companies in India. According to the National Account Statistics, the share of corporate companies in the GDP has risen to 40 per cent. A report by the World Inequality Lab at the Paris School of Economics, authored by Thomas Piketty and others, brings out that top 1 per cent of India's population possesses 40.1 per cent of the wealth. Consequently, the number of billionaires has risen from one in 1991 to 162 in 2022. The Forbes Global List of billionaires shows that the number of Indian billionaires has reached 200. On the other hand, 80 crore people out of 140 crore are dependent on the government for the supply of free ration. With their increasing grip on the economy, corporates have spread their businesses in various sectors. They control industrial production, distribution of products, fruits and vegetables, telecommunications, roads, airports, ports, TV channels and newspapers, etc. The character of these houses is oligopolistic. A few companies (three or four) control a major proportion of the business in a specific line. They collude to fix supply prices of the output or purchase prices of inputs from small business or agriculture. These firms pay low wages/salaries to workers and employees. Using market power, they charge higher prices as suppliers and pay low prices when acquiring inputs to earn high profits. These firms are major beneficiaries of loan waivers and huge subsidies given by the government in the name of incentives. They have penetrated the government through lateral entry at the joint secretary level and are major contributors of election funds to political parties. Thus, the clout of the corporate sector extends from economy to administration and politics. A nexus has emerged between the ruling party at the Centre and corporate firms. With the increase in the area of operation of big business, they have started setting the terms of discourse or the agenda for discussion in the country. One remembers how the mainstream media came out in support of the new economic policy in 1991 and later globalisation under the World Trade Organisation. It was one-sided uncritical support for the new economic regime, shifting from regulated capitalist development towards free and liberalised regime for corporates.

Curb the menace of child molestation

TRYSTS AND TURNS: The proliferation of sex offenders in cities and towns across the country must be combated

TWO four-year-old girls were sexually abused by a sweeper in a privately run school in Badlapur, a small town in Thane district adjoining Mumbai city. He had been employed just days before the crime took place. He was reportedly the only male employee in the pre-primary section of the school.

On two consecutive days, he was sent by a teacher to take the two girls to the toilet.It turned out that no background check was conducted prior to his hiring. Police investigations into his antecedents revealed that the man was just 24 years old but had been married thrice in a short period of less than a year. He had discarded his first wife two or three days after marriage and the second one within 10 days. The third wife, who is presently with him, is in her fifth month of pregnancy.

Even if a proper background check had been done, it is doubtful if the man's proclivities would have been detected. But his act of changing his partners should have alerted the principal against taking him on in a school which had many girl children.

Sexual offences are being reported

almost daily in the media. This particular case hit the headlines probably because the school was rumoured to be owned by someone connected to one of the ruling parties in Maharashtra. The Assembly elections are due in the state before the year ends. highlighted in the court by a few affected citizens in sworn affidavits.In place of the projected bandh, parents of schoolgoing children, politicians and their followers taped their own mouths with black cloth and marched through the city streets demanding better security for schoolchildren.

Punjab should make the most of Rajpura project

FHE Centre's nod to set up an industrial smart city in Rajpura presents a now-or-never opportunity to Punjab to establish itself as a major destination for investors. Fiscal mismanagement by successive state governments has led to the double whammy of high indebtedness and low investment, stifling the state's potential for economic growth. The fact that Rajpura has been chosen as one of the 12 sites for projects on the Golden

constable, specially selected, was assigned to each of the 91 police stations in the commissionerate to visit each school in the precinct every month, address the parent-teacher meetings and impress on the parents first, the teachers next and the senior students later the lurking possibility of molestation and ways and means to prevent it.

The steps to be taken in case sexual offenders from within the school or outside manage to break the law were also listed. In some European countries, child pornography has become such a menace that special squads have been created in crime-fighting units to address the problem.

The steady proliferation of sex offenders in many cities and even towns in our country needs immediate attention and involvement of the state. In Mumbai, NGOs involved in helping the authorities combat the menace are many. The current government at the Centre distrusts civil society bodies working to address such secular issues. Corporate funding has been discontinued to such NGOs and diverted to the PM Cares Fund.

The government would be well advised not to frown on such NGOs whose only motive is to better the quality of life of ordinary citizens. To dump every NGO in one basket is a strange way of going about the business of governance.

> For that, it is vital to cut red tape and minimise disruptions. Domestic as well as foreign investors prefer to pump their money into states where hassle-free, uninterrupted industrial activity can be conducted. Around 1,100 acres have been acquired and fenced for the Rajpura project. This is a welcome development, in stark contrast to the land acquisition hitches that have led to the termination of

Juadrilateral, which connects the country's major industrial, agricultural and cultural hubs, shows that the border state is very much part of the Centre's scheme of things.

Chief Minister Bhagwant Mann's recent visit to Mumbai, where he met several industry leaders,

to foreign lands. Hopefully, the industrial smart city, where world-class infrastructure will be created, will help the state make an economic turnaround and incentivise its young people to stay on and work here.

India has its bases covered ahead of Lanka's presidential poll Sri Lankan leaders know that when the chips were down, India provided \$4-bn aid to bail the island nation out.



INDIA is keeping a close eye on the developments in the run-up to the September 21 presidential election in Sri Lanka, where public protests had led to the exit of then President Gotabaya Rajapaksa in 2022 at a time of severe economic distress. However, Sri Lanka had not dissolved its Parliament and allowed the political system to operate. This led to a consensus on former Prime Minister Ranil Wickremesinghe, whose United National Party (UNP) had fallen on hard times. He was elected President by Parliament and has seen through the rest of Gotabaya's term. Ranil is a candidate again, but this time, his Puluwan Sri Lanka front has got 34 parties backing him, including leaders who, though from other parties, are a part of hs government.

- Ranil has stated that there is unfinished business with regard to Sri Lanka's economic distress. He has maintained good relations with India, China and the West for debt relief and management plans.
- The main party in Parliament, the Sri Lanka Podujana Peramuna (SLPP) of the Rajapaksas, which backed Ranil for the presidency during the crisis, decided not to support him further. It has pitched for Namal Rajapaksa, son of Mahinda Rajapaksa, as their candidate. If Namal fails to perform well, the SLPP would face challenges in the parliamentary elections, likely to be held within a year.Sajith Premadasa founded the Samagi Jana Balawegaya (SJB) after splitting from the UNP in 2020 and it has been the main Opposition front in Parliament. He marshalled his political resources to be seen as a viable candidate. He has formed an alliance with 27 small parties and mobilised public support against the government.A potent challenger is Anura Kumara Dissanayake of the National People's Power (NPP), which is the political wing of the radical Janatha Vimukthi Peramuna (JVP). The JVP, after its hostile

activity till 1989, has become a political party and works overground. It was the mainstay of Aragalaya (the struggle), the 2022 agitation. The people's angst and frustration led to Mahinda's resignation as Prime Minister; subsequently, Gotabaya quit as President. Despite having only three MPs, the NPP worked assiduously to harness public anger.

According to a pre-poll survey, Anura is leading with 43 per cent of the votes. Ranil (27 per cent) is ahead of Sajith (22 per cent). Namal has only 3 per cent support. In recent weeks, 10 per cent of the undecided voters seem to have moved in Ranil's direction, giving his campaign a fillip. However, poll analysts in Colombo say the contest is between Anura and Sajith.In the Sri Lankan system, there are three preferences for voters. A candidate must get 50 per cent plus of the first-preference votes to be elected President. If no candidate gets that, the second and third-preference votes of candidates, besides the top two, will be counted. Analysts say that it is these second and third-preference votes which are likely to determine whether the second-placed candidate can upstage Anura, who is the leading choice on first-preference votes.Should India be worried about the outcome of this election? The turmoil in Bangladesh months after January's General

Election, which was won by now-ousted Prime Minister Sheikh Hasina's Awami League, is a cause for concern. India seems to have played its cards better in Sri Lanka. During his June visit to Sri Lanka, External Affairs Minister (EAM) S Jaishankar met leaders of all hues, including Sajith and Anura. Anura made the first-ever visit by a JVP leader to India at the

government's invitation in February. He met the National Security Adviser, the EAM and others while visiting Delhi, Thiruvananthapuram and Ahmedabad. He acknowledged India's role in helping Sri Lanka during an economic crisis two years ago. Anura said he did not follow the JVP's old policy of being anti-India and would like to work



with everybody possible.Sajith, whose father Ranasinghe Premadasa was an anti-India UNP leader, has modulated his stance. Though invited to India, he decided not to come this year, possibly under astrological advice not to travel overseas before the election get over. In his meeting with Jaishankar in Colombo, Sajith acknowledged that India's timely assistance was of great sustenance to

Sri Lanka, and that Delhi was a valuable friend.Ranil has been a friend to India since long. He attended PM Modi's swearing-in in June and discussed various matters with the Indian leadership.India has got its bases covered with all major parties in Sri Lanka and is not taking sides in this contest whose result is not easy to predict. India would have laid out its

> preferences to all the parties, in line with the Neighbourhood First policy, supporting economic activity and seeking a level playing field for Indian economic interests and no threats to Indian security.

> Sri Lankan leaders know that when the chips were down, India provided \$4billion aid to bail the island nation out, and then participated in a debt rescheduling exercise when China did neither. Yet, China will always remain important to Sri Lanka for investment in its projects, and to balance India out. Hence, Chinese naval ships will not be prohibited from visiting Sri Lanka, but they will be advised not to carry out surveillance or anti-India activity, like it was done in the case of a research vessel two years ago.India would have to live with this and do more, possibly with Japan, trilaterally, to build economic relationships to balance China out in Sri

Lanka. India's private sector investments in Sri Lanka and development cooperation projects are highly regarded, giving India the reputation of a good neighbour.If this election can pass off without attracting nationalist voters' sentiment targeting India, Delhi would have indeed learned a new lesson and implemented it.

BE OPEN TO CHANGES



Kids cause greater strain in relationships than illness

No discrepancies in EVM-VVPAT data matched so far: Poll panel

After the Lok Sabha elections, applications seeking checking of results and matching and confirmation of data were received from only eight out of 543 constituencies. Out of these eight, four have been checked so far and all have proved correct.

New Delhi: Doubts and questions raised on the accuracy of Electronic Voting Machines (EVMs) by certain political parties have been put to rest for the time being as the data of four Voter Verifiable Paper Audit Trail (VVPAT) checked so far have been found to be correct, officials said on Friday. After the Lok Sabha elections, applications seeking checking of results and matching and confirmation of data were received from only eight out of 543 constituencies. Out of these eight, four have been checked so far. These applications were related to matching of data from 92 polling booths in six states. In the Assembly elections, three applications related to 26 polling stations of two states were received. According to a Supreme Court verdict, the two closest rivals who lost in the general election can

get the data verified by getting the data of EVMs and VVPATs matched after paying a fixed amount of fee. If the complaint is found to be correct, meaning if there is any discrepancy found in terms of the data, the fee will be refunded and appropriate action will be taken. If the complaint is found to be false, the fee will be confiscated. According to Election Commission officials, an investigation on two out of eight Check and Verification i.e. Cand V applications, remained pending because the defeated candidates who challenged the results had filed an election petition in court.In two of the cases, the C and V process was stopped because the complaining candidates did not show up. However, four C and V processes were completed, and no irregularities were



found in any of them.As a significant step towards transparency in the democratic process, the Election Commission has provisioned that candidates who suspect irregularities in voting, those who are unsatisfied with the voting and counting, can choose any EVM of any polling station for examination, whose data and VVPAT

slips can be matched. The chief poll body received complaints and applications for EVM-VVPAT re-matching from eight candidates since the results of the Lok Sabha elections were declared on June 4. Hallett said: "When you're sitting in that business meeting, be attentive to when the

talk drifts away from the official task at hand to people who aren't present.

"Be aware that what is going on is a form of politics and it's a form of politics that can be a weapon to

undermine people who aren't present. But it also can be a gift. If people are talking positively it can be a way to enhance someone's reputation."



Mumbai Non-food bank credit registered a growth of 15.1 per cent to Rs 162.92 lakh crore as of July 2024 as compared with 14.7 per cent a year ago, according to the Reserve Bank of India's latest data.

However, deposit growth of banks lagged behind at 11.3 per cent at Rs 213.28 lakh crore, RBI data shows. With deposits growth slowing down, banks are racing to mobilise funds through special deposit schemes and other innovative plans to meet the credit demand in the system. Many banks have reported a decline in deposits during the quarter ended June 2024 as customers are now looking at alternative avenues like the capital markets to park their funds at better returns.Credit to agriculture and allied activities remained robust registering a growth of 18.1 per cent at Rs 21.55 lakh crore in July 2024, compared with 16.7 per cent a year ago, RBI said.Credit growth to industry strengthened significantly at 10.2 per cent to Rs 37.05 lakh crore in July 2024 compared with 4.6 per cent in July 2023. Among major industries, credit to chemicals and

chemical products, food processing, petroleum, coal products and nuclear fuels and infrastructure recorded a higher growth in July 2024 as compared to their growth a year ago, while credit to basic metal and metal product and textiles moderated, the RBI said. The central bank said credit growth to medium industries rose to 17.2 per cent to Rs 3.17 lakh crore and large industry by 8.5 per cent to Rs 26.74 lakh crore.

Festive offerCredit growthto services sector moderated to 15.4 per cent in July 2024 from 19.7 per cent a year ago, primarily driven down by relatively lower credit growth in non-banking financial companies (NBFCs) and trade segments. Sebi amends rules to regulate influencers

NEW DELHI. Markets watchdog Sebi has amended norms in a bid to regulate unregistered financial influencers or finfluencers amid growing concerns about potential risk associated with such unregistered persons. In three separate notifications, the regulator has restricted associations between its regulated entities and unregistered individuals. This came after the board of Sebi approved a proposal in this regard last month.

- As per the notifications, the persons regulated by Sebi and the agents of such persons will not have any association like any transaction involving money, referral of a client, interaction of information technology systems with any other person who, directly or indirectly, provides advice, recommendation or makes explicit claim of return.
- "No person regulated by the Board (Sebi) or the agent of such a person shall have any direct or indirect association, with another person who provides advice or any recommendation, directly or indirectly, in respect of or related to a security or securities, unless the person is registered with or otherwise permitted by the Board to provide such advice or recommendation; or makes any claim, of returns or performance expressly or impliedly, in respect of or related to a security or securities, unless the person has been permitted by the Board to make such a claim," the regulator said. By requiring finfluencers to register with Sebi and adhere to specific guidelines, the regulator is setting a standard for accountability and expertise in the sector, market experts said. The move would ensure that mutual fund houses, research analysts, registered investment advisors and stock brokers do not partner with finfluencers. On the other hand, a small window has been provided for investor education from such partnership. This is subject to a condition that these finfluencers do not provide any recommendation or claim any return or performance. This came amid growing concern over the potential risks associated with unregulated finfluencers who might offer biased or misleading advice. They usually work on a commission-based model.Finfluencers have significantly impacted their followers' financial decisions in the last few years and thus Sebi's regulatory framework can make them accountable

and responsible for the advice they provide. To give this effect, Sebi has amended norms governing depository participants, intermediaries and Securities

Contracts.

NEW DELHI. India's growth fairy seems to have lost a bit of its roar. During the first quarter of the current fiscal, real GDP grew by 6.7%, as against 7.8% in Q4, FY24 and 8.2% a year ago. The continuing decline in agriculture, private consumption along with a slowdown in government expenditure landed a sidewinder punch on the growth rate, which hit below 7%.

The estimate is within the consensus expectations that stretched a wide range of 6%-7.1%, but the slowdown in economic activity raises doubts if India can see another banner year, especially after FY24's growth momentum, which seemed unstoppable, like the march of time.Analysts had forewarned about the likely decline in growth citing lower government expenditure amid the 2024

election season. But what's upsetting is the fact that all the other moving parts of the economy, taken together, couldn't make up for the decline in the gold vein of government spending. In other words, private consumption, investments and agricultural sector that were expected to ginger up and aid growth, are yet to commit themselves fully.

According to he data released by the National Statistics Office on Friday, real Gross Value Added (GVA) grew by 6.8% in Q1, FY25 as against 8.3% in Q1 of the previous financial year, led by the growth in secondary sector that turned in 8.4% growth over last year. In absolute numbers, real GDP at constant prices is estimated at Rs 43.64 lakh crore during Q1, compared to Rs 40.91 lakh crore a year before, registering a 6.7% growth rate. Real GVA in Q1 is estimated at Rs 40.73 lakh crore as against Rs 38.12 lakh crore last year, showing a growth of 6.8%.On the supply side, if both primary and tertiary sector saw a slowdown, Q1 headline number got the gentlest of encouragement from the secondary sector. Primary sector comprising agriculture and mining and quarrying registered a pale growth of 2.7% in Q1, as against 4.2% last year. Within this, growth in agriculture and allied services sector, which is enduring a sober fate, crawled to a dismal 2% compared to 3.7% registered a year before. Mining and quarrying, on the other hand, saw a



flat growth of 7.2% compared to 7% last year. The primary sector is like the breath of life itself and needs to do better. It holds the keys for both food inflation, as well as, private consumption -- the two other components that are troubling households.Tertiary sector, like the primary sector, witnessed a slowdown registering 7.2% growth rate during Q1 compared to 10.7% registered last year. Two of three sub-components namely trade, hotels, and other services and financial, real estate and professional

services saw a significant decline in economic activity during the quarter gone by. However, public administration, defence and other services posted a growth rate at 9.5% in Q1 compared to

the previous year's 8.3%, but the marginal increase wasn't significant enough to make up for the decline in trade and financial services sectors.It's the secondary sector that did the heavy lifting during Q1, having turned in a growth rate of 8.4% as against 5.9% last year. All the three sub-components namely manufacturing, electricity, and other utility services and construction clocked in higher growth rates over last year at 8.4%, 10.4% and 10.5% respectively.On the expenditure side, private consumption, the largest component accounting for over 56 % of the GDP, needs lots of improvisatory energy. During Q1, it grew by 9.8% as against the previous year's 8.2%, but has much potential. Government final consumption expenditure, which has been playing to the whistle, finally took a break, thanks to the elections. It saw a degrowth of declined to 0.2% y-o-y at Rs .14 lakh crore.Gross fixed capital formation, an indicator of investment activity, increased by 7.5% in Q1.
