PM Sheikh Hasina resigns and leaves Bangla

Dhaka, August 5: With Bangladesh descending into chaos, Prime Minister Sheikh Hasina surreptitiously fled the country for London in a military aircraft on Monday and the Army stepped in to fill the power vacuum, ending one uncertain chapter and opening another in the nation's restive history. As news of Hasina's departure spread, hundreds broke into Hasina's residence, vandalising and looting the interiors, providing dramatic expression to the anti-government protests that have killed more than 100 people in the last two days. At the centre of people anger is the Hasina government's controversial quota system reserving 30 per cent jobs for families of veterans who fought the 1971 liberation war. With volatile crowds taking to the streets—some clambering on Hasina's father and Bangladesh founder Sheikh Mujibur Rahman's statue and smashing it with hammers in a lasting image underscoring the fickleness of history—Army Chief General Waqar-uz-Zaman announced that the 76-year-old Prime Minister has resigned. An interim government will be taking over, he said in a televised address

Zaman added, signalling the end of Hasina's 15-

year power run. The Army Chief said he had met political leaders and told them the Army would take over responsibility for law and order. However, there were no leaders from Hasina's Awami League party at the meeting. As protests spiralled across the country, the Army Chief said he had asked both the Army and the police not to fire any shots. Zaman

also urged restraint and asked protesters to end the violence. He vowed "justice" for all the people. After hours of uncertainty in a day of sudden developments, Hasina landed at the Hindon airbase in Ghaziabad near New Delhi on her way to London, diplomatic sources in the Indian capital said. Two Arunachal Pradesh men missing for 2 years

New Delhi, August 5: Two men from Arunachal Pradesh, missing for nearly two years after they disappeared from a remote area along the India-China border, are believed to be in the People's Liberation Army's (PLA) custody but the Chinese military has not confirmed their presence. Batelum Tikro, 35, and his cousin, Bainsi Manyu, 37, went missing on August 19, 2022, while looking for medicinal herbs in a highaltitude region of the Chaglagam area in the state's Anjaw district. Extensive searches have yielded no information about their whereabouts. Families and local authorities continue to seek answers, raising concerns about the security and safety of individuals in border areas. "I have come to know that they were detained by the Chinese army," Tikro's brother Dishanso Chikro told PTI over phone. Chikro said he has approached local army authorities several times to seek information about his brothers. "I am told that the issue was raised by the Indian Army with their Chinese counterparts. Haryana and amid a fresh spotlight on the while looking for medicinal herbs. Wayanad's 'super hero' rescuer, who risked his life to save many, now 'missing'

Wayanad (Kerala), August 5: Local lad Prajeesh drove his jeep up through the treacherous hill path twice and returned with many hapless people who were stranded atop after the deadly landslides hit Wayanad's highrange Mundakkai last week. Just before he could move to safety came a phone call for a third 'mission,' but the ever popular localite is now missing, his damaged jeep seen at Chooralmala, leading to both fears of the worst and hopes for good news. Risking his own life, the young man drove the vehicle up the hill for a third time but lost himself midway in the gushing flood water and mud and the barrage of

huge boulders that rolled down the mountains. That was the heartbreaking story of Prajeesh, who had plunged into a rescue mission and saved the precious lives of many people after the news about the dev-

astating landslides broke out in the hamlets here in the wee hours of July 30. With heavy heart and teary eyes, the people of Chooralmala village now call him their "super hero." Hailing from landslide-hit



Chooralmala, Prajeesh was already popular among the villagers for his ever-readyto-help anyone attitude, local people said. A villager said that after hearing about the first series of landslides that hit hill twice at his own risk and came back with many individuals who were stranded there. "After that, he was about to shift to a safer place with his family members. Suddenly, he got another phone call, fol-

> lowing which he again drove up the hill...but this time, he did not return," he said. Prajeesh's damaged jeep was later found down in Chooralmala town, the man said, adding no one has seen him since then. Another villager said Prajeesh had been an inevitable presence in all the activities in the village and a favourite of everyone. "Whether it is a marriage or funeral, he will be there from beginning to end. Like many other people, he personally

helped me also a lot, especially during the marriage of my daughter," he said. Prajeesh's friends said they warned him not to go to the hill when he began his journey for the third time. But he didn't heed them, saying there were more people trapped in Mundakai and that he wanted to save them. "Prajeesh was the super hero of our land...But we have lost him now," an emotional villager said.

NIA conducts spot inspection along with two accused

PM Modi terms abrogation of Article 370 'watershed' moment

New Delhi, August 5: On completion of five years of the abrogation of Article 370, Prime Minister Narendra Modi and Union Home Minister Amit Shah on Monday described the step as a watershed moment in the nation's history that started a new era of progress in Jammu and Kashmir, and Ladakh. The principal opposition Congress criticised the BIP's policy for the region, saying it neither respects 'Kashmiriyat' nor upholds 'Jamhuriyat'. The removal of Article 370 that gave special rights to Jammu and Kashmir had been part of the BJP's core agenda. Modi assured the people of Jammu and Kashmir and Ladakh on Monday that his government would keep working for them and fulfil their aspirations. He said the move to abrogate Article 370 meant that the Constitution was implemented in these places in letter and spirit, in line with the vision of the great men and women who made the Constitution. "With abrogation came women, youth, backward, tribal and marginalised communities who were deprived

of the fruits of development. At the same time, it has ensured that corruption, which plagued Jammu and Kashmir for decades, has been kept at bay," the Prime Minister said. The Modi government had on this day in 2019 annulled Article 370 and Jammu and Kashmir state was also bifurcated into two Union territories. The government also scrapped Article 35A which was conceived exclusively for the "benefit" of Jammu and Kashmir through a Presidential order issued in 1954. It empowered the Jammu and Kashmir legislature to define the erstwhile state's 'permanent

residents' and their special rights and privileges. Home Minister Shah said the abrogation of Article 370 ushered in a new era of empowerment for the marginalised sections and strengthened grassroots democracy in the region. He said the

India suspends train services to Bangladesh indefinitely

New Delhi/Kolkata, August 5: All train services between India and Bangladesh have been suspended indefinitely, Railway officials said on Monday following unrest in the neighbouring country. According to the Railway Ministry, Maitri Express, Bandhan Express and Mitali Express operated their last trips in mid-July this year and have been cancelled since then due to violent protests in Bangladesh. Both Maitri Express and Bandhan Express were initially cancelled from July 19, 2024, to August 6, 2024, they said. However, due to the prevailing situation in Bangladesh, the cancellation has been extended indefinitely, the officials said. The service of Mitali Express also stands suspended indefinitely, according to the Indian Railways. Bangladesh Prime Minister Sheikh Hasina on Monday resigned and left the country while Army Chief General Wagar-uz-Zaman announced an interim government was taking over in dramatic developments amid massive violent protests there. "Mitali Express, which runs between New Jalpaiguri-Dhaka, went to Dhaka on July 17, 2024, but it didn't return after that," the Divisional Railway Manager (DRM) of Katihar told. He added, "The train has 10 coaches owned by Indian Railways but since these coaches were used in that particular train only, there is no inconvenience of any sort to us. The train's loco used to be changed at the border. So when it enters Bangladesh, they attach their own engine to the train replacing ours" Maitri runs between Dhaka and Kolkata while the bi-weekly Bandhan Express operates between Khulna and Kolkata.

Death threat letter: Armstrong's family receives police protection

Cage fish farmers gearing up to restart cultivation in Kochi

Likely to start mid-September; small-scale farmers have already begun process



CHENNAI. The Ayanavaram police have made security arrangements and deployed personnel at the Ayanavaram apartment where former BSP state chief K Armstrong's family resides at present.

This comes after an unidentified person sent a death threat letter to one of Armstrong's houses in Sembium, which is now unoccupied. Police have registered a case and inquiry is under way. A police source said, "Police personnel have been stationed outside the apartment complex

in Avanavaram and outside the residence in Sembium." After Armstrong's death, his wife Porkodi was made the state coordinator of BSP, while advocate Anandhan was appointed as the party's state president. On July 5, Armstrong was hacked to death by a gang at Sembium.

KOCHI. May 20 was a black day for the cage fish farmers in the district as the sudden increase in the pollutants in Periyar river led to major fish deaths. It caused a loss of of Rs 31.25 crore for cage fish farmers and Rs 10.6 crore for capture fisheries. Yet, the farmers have decided to give another go at cage fishing that once brought them dividends.

'However, we need to wait until mid-September to restart it," said Swapnalal, a cage fish farmer and member of the Cage Fish Farmers Association. According to him, cage fish farming will also act as a deterrent to the industries functioning on the banks of the river from dumping pollutants into the water body. "Once the farming restarts, these errant companies will have to think twice before resorting to any such moves," he added.

Gratus, owner of the Gratus Fish Farm who lost Rs 14 lakh worth of fish, says, "At present, it is not the right time to restart the farming. The turbidity of the river As to what makes them go back to cage fish water plus the possibility of flooding due to heavy rain does not make it conducive to put the fishlings in cages." The time towards September-end is more suitable,

Gratus pointed out that some farmers doing the fish cultivation on a small scale have already begun the process. "Those who



have more cages will be doing so later when the climate and weather are more favourable," he says.

In a decade, Gujarat's rainfall up by 11%, Kutch-Saurashtra by 19%

AHMEDABAD. The monsoon of 2024 is marked by heavy to very heavy rain lashing parts of Saurashtra and Kutch with several cities and towns in Devbhoomi Dwarka, Porbandar, Junagadh and Kutch experiencing deluge for several days with more than 150 mm rains in a few hours. But it is indicative of the changing regional rainfall pattern with Saurashtra and Kutch known for frequent droughts - recording 15% and 25% rise in average rainfall in a decade! Cumulatively, they have recorded 19% decadal rise compared to 11% for Gujarat.

An analysis of data by the State Emergency Operations Centre (SEOC) under the Gujarat State Disaster Management Authority (GSDMA) from 2015 to 2024 indicates that the state has witnessed 11% rise in overall seasonal rainfall in a decade - from 797 mm in 2015 to 883 mm in 2024, report Parth Shastri & Himanshu Kaushik.

'Rain has become more intense, but erratic'

The average seasonal rainfall is calculated based on a 30-year moving average. Thus, the rise in average rainfall is indicative of better rains in the past three decades, indicate Met department experts. The decadal rise for Kutch is 25% - from 387 mm to 485 mm - whereas for Saurashtra it is 15% - from 643 mm to 738 mm. In fact, these are the only two regions that have above the state average rise in rains as south Gujarat, the region with the most rainfall, has recorded 10% rise, north Gujarat 8%, and east-central Gujarat mere 4%. Ashok Kumar Das, head of IMD Gujarat, said that several studies have indicated a rising rainfall pattern for Saurashtra and Kutch over the past few decades. "This year's rainfall trend should be seen in context of multiple systems activated over the region with Devbhoomi Dwarka getting all-time high rains," he said.

Has the improved rainfall resulted in improved conditions on ground? Experts are divided. Prof DV Karu, principal and dean of the College of Horticulture at Junagadh Agriculture University (JAU), said that the rainfall has become more intense, but more erratic, too. "There is an uneven distribution of rain over the region and perhaps it may be premature for the farmers to understand the pattern. Farmers who had cultivated cotton in past years are sowing more groundnut due to excess rains. But the same is not seen for papaya or dates," he said.On the other hand, several farmers are taking three crops a year due to better availability of water. Arvind Patel, a farmer from Amreli, said that in the 1990s, it was one crop a year, which improved to two crops in the mid-2010s with better availability of water. "Water levels went down very quickly, and only those in the vicinity of rivers were able to get more crops. But now we are taking soybean and groundnut so that the field is ready for winter crops such as cumin and gram. It was not the case earlier," he

Forsaken for decades, Nerkundram burial ground in Chennai raises a grave concern

CHENNAL. For the past eight decades, the cremation ground alongside Cooum River, one of the two crematoriums in Nerkundram, has been functioning without basic amenities. While a single streetlight caters to the entire stretch, the narrow approach road is in poor shape and the ground has no compound wall. Barring a sheltered cremation platform, there is nothing to suggest that the Since both areas lack a proper crematorium is regularly used.

This ground on PH Road near Cooum has been a final resting place for departed souls since the time Nerkundram was controlled by a panchayat administration. Due to its poor condition, residents have to carry the bodies through a damaged approach road, navigating through droves of pigs. As a result, the number of people using the facility has been on a gradual decline. Hence, the residents The gravedigger in charge of both have been demanding proper maintenance of the crematorium.

The alternative burial ground in Valliammai Nagar, located a kilometre away, also lacks a cremation platform for the last many years. The authorities had dismantled the platform as it was located

within a residential area. Further, 13 cents of the ground was handed over to the Chennai Metro Water and Sewerage Board for constructing a pumping station. So, without a crematorium platform, the ground is solely used for burials

cremation platform and basic amenities, residents from areas near PH Road like Pallavan Nagar, Selliamman Kovil Street, and other areas are forced to depend on Virugambakkam or Arumbakkam burial grounds for most cremations, which are at least 4-5 km, said residents.

the burial grounds said if the facility near the Cooum River is maintained properly with appropriate facilities, it would be a huge relief to the residents. M Hari Kumar (45), a resident, said, "Whenever it rains, the PH Road burial ground area gets inundated, making it difficult to walk



through. There is no water supply, and it also doesn't have a toilet or a compound wall. We need the civic body to take maintenance.'

Speaking to , Ward 145 Councillor T Sathyanathan stated, "I have raised this issue multiple times in council meetings.

Despite the PH Road burial ground being in use for decades, the civic body has not taken appropriate measures. While they are willing to provide water and toilet facilities for the Valliammai Nagar burial ground, which now has a proper compound wall, no action has been taken for the PH Road ground. After multiple requests to corporation officials, one streetlight was installed in the area. The poor road condition and other monsoon risks remain unaddressed."

A corporation official told TNIE that the land used for cremations along the Cooum appears to belong to the Water Resources Department, "We have written to the revenue department seeking some clarifications and will initiate action as soon as we get a response," the official

City doctor duped of 23L by fake police & CBI officers

Mumbai. Cyber fraudsters, posing as police and CBI officers extorted Rs 23 lakh from a city doctor by threatening to arrest him in a money laundering, drug trafficking, and identity theft case.

The doctor, a consultant at a city hospital, who is in his early 70s, told the police he had received a WhatsApp call from a person "from the telecom department" who said illegal activities were done using his phone and the number would be disconnected in an hour. He then connected him to "a Delhi police officer" who told the doctor that a case was registered against him. The fake cop suggested that the doctor speak to a "CBI officer in police uniform" who made a video call, and asked the doctor that a "serious" case which he referred to as 'Sandeep Kumar money laundering, drug trafficking and identity theft' was registered against him. The doctor was threatened with arrest. The accused, through WhatsAppm sent him a letter on a fake CBI letterhead about a 'confidentiality agreement'

The accused sent an acknowledgement letter to the complainant which had names of an IAS and two IPS officers. The accused asked the doctor to transfer Rs 23 lakh, to an account number.

The accused told the doctor that his money would be returned once the judgment in the case was out. The accused were watching his activities through the video call, the complainant has told the police. He sent Rs 23 lakh to the account number given and later realised he had been cheated. A case of cheating, has been filed.

BHUBANESWAR. With the state capital grappling with loss of green cover, rising temperature and pollution, the Bhubaneswar Municipal Corporation (BMC) has decided to take up projects to create mini urban forests using the Miyawaki method of plantation.

Gurgaon: Air you breathed overshot annual pollution 'quota' in Jan itself, says report

GURGAON: The city surpassed the annual permissible limits of air pollution set by World Health Organization (WHO) in the first month of this year itself. It crossed the national ambient air quality standards (NAAQS) for PM2.5 and PM10 by May and April, respectively, according to an analysis of pollution levels in the city

Both PM2.5 and PM10 levels overshot the pollution quota required to comply with WHO guidelines on Jan 16 and 24, respectively, as per an analysis by the Centre for Research and Energy for Clean Air (CREA). NAAQS standards for PM2.5 and PM10 were overshot on May 17 and April 3, respectively.

The annual WHO guidelines for PM2.5 and PM10 are 5 g/m³ and 15 g/m³, respectively, while the annual NAAQS for PM2.5 and PM10 are 40 g/m³ and 60 g/m³, respectively.

The "overshoot day" is defined as a day when the average pollution levels preceding that day are so high that even a 0.1 g/m³ daily concentration of the pollutant for the remaining days of the year would ensure non-compliance of the city to the prescribed annual standard or guideline. The analysis, which studied data of six years, raises concerns as the pollution levels overshot even before the onset of winter, when the city witnesses high pollution levels. During winter months, the city's air quality index (AQI) remains in the 'poor', 'very poor" or 'severe' category on most days."Gurgaon overshooting WHO standards for both PM2.5 and PM10 in Jan and NAAQS in April and May underscores the severity of the hazardous air pollution levels in the city. This emphasises the urgent necessity for more stringent regulations at the airshed level, transitioning to an emission-load reduction-based approach, and efficiently utilising emission inventories, source apportionment studies, and technology for pollution control and regulation," stated Sunil Dahiya, an analyst at CREA."While NAAQS has lenient standards compared to WHO, this leniency is resulting in prolonged exposure to harmful particulate matter. A recent study revealed that short-term PM2.5 exposure in India poses a significant risk of death even at concentrations well below current standards.

Years of delay and fund diversion probe leave homebuyers in Gurgaon in a fix

GURGAON. A group of homebuyers of ATS Marigold project in Sector 89A has been in a limbo for years as the developer is investigated for diverting funds and faces allegations of defaulting on pre-EMI payments.

The project, initially licensed to three developers in 2013, was later transferred to ATS.Homebuyers approached the National Consumer Disputes Redressal Commission/Economic Offences Wing in 2021, seeking a refund of the amount they had paid along with interest. Four of the initial 24 complainants are still continuing with their case before NCDRC. One of them filed a complaint before Rera and after getting a favourable order on refund, withdrew from the NCDRC case. Six others withdrew as well, filing complaints before the real estate regulatory authority, and 11 complaints settled with the developer.

Two others are in the process of settling in return for immediate possession of flats.

According to the complaints, the developer collected funds from homebuyers even before a licence was granted to it. "Accused persons transferred the funds of the investors into their other accounts, creating layering of transactions. This shows the malafide intention of diversion of the funds of the investors. The complainant had also alleged the diversion of their funds by the alleged persons for some other purposes. In view of the above, IPC Section 409 (criminal breach of trust) in the case has been invoked and is being investigated accordingly," the economic offences wing said in its status report submitted to Patiala House court on July 29.

The next date of hearing is in Sept.

Homebuyers told TOI on Sunday that they have still not gotten possession of their flats while they have been paying EMIs for years. Sudhanshu Kanungo, one of he complainants, said he booked a flat in 2013 and paid Rs 1.1 crore with an expected possession date in 2018.

State govt contests GMC's report at NGT, admits part of park encroached

GHAZIABAD. A report submitted by UP govt in the National Green Tribunal (NGT) has admitted that 864.2sqm of a park in Rajendra Nagar industrial area is encroached by some factory owners, who have constructed an approach road through it. The tribunal was hearing a petition by environmentalist Sushil Raghav two years ago, alleging that it was the Ghaziabad Municipal Corporation (GMC) that was constructing the road and a drain, which had reduced the size of the park. In Nov last year, the NGT sought reports from GMC and a joint committee of senior officials from the district administration and UP Pollution Control Board.GMC, in its report, ruled out any encroachment in the park, saying it hadn't constructed any road or drain whatsoever. On the contrary, the civic body said, it had planted 21,000 saplings in the park. The joint committee filed its report on Feb 5 this year. The committee report merely said that 10,880 sqm of the park area had been freed of encroachment and that Babu Jagjivan Ram Colony had been built on another 7,120sqm. The NGT asked the chief secretary to carry out a detailed survey of the area."We are surprised with the stand of the district magistrate that there is no material available relating to the existence of the park.

Gurgaon tailor bludgeons worker to death, handed life term

GURGAON. A tailor from Sarhaul was sentenced to life imprisonment by a local court on Saturday for murdering a migrant worker from UP in 2019.

Thirty-three-year-old Gabbar Singh was bludgeoned to death next to his rented house in Sham Chander Jha colony in Sikandarpur on the night of May 7, 2019. While returning home from a gambling den in DLF -1, the accused, Manoj Kumar (25), had an altercation with Gabbar. In a fit of rage, he bludgeoned Gabbar to death using slabs of stones and fled with his cell phone. Gabbar's brother Kalu Singh found him dead in an open space next to their room on May 8.

'After dinner on May 7, I went to sleep on the roof of the room. At that time, my brother was talking to someone on the phone. The next morning, at around 7.30 am, I woke up and found my brother lying dead next to our room with bleeding injuries to his head," Kalu Singh said in his complaint.

A case was registered under Section 302

(murder) of the IPC at DLF Phase 1 police station on May 8, 2019. Inspector Ashok Kumar said before the court that the call details records of the victim showed that calls were made to two phone numbers on May 9. One number belonged to Rajesh and another to Vinod, who is Manoj's brother. The duo confessed that Manoj had called them from a new phone number. "The accused was arrested from his house in Sarhaul. The cell phone and earphones of the victim were recovered from his possession. Manoj confessed to have committed the murder," Ashok Kumar said in his deposition. Defence counsel, Hemant Gupta, contended that there were no eyewitnesses to the crime and even the victim's brother, Kalu Singh, had not identified the accused in the court. "The mobile phone and earphones of the deceased were planted by the investigating officer to implicate the accused. The prosecution failed to prove that it was the accused who had



committed the murder," the defence counsel contended.Assistant public prosecutor (APP), Abhishek Sanwaria, said, "RFSL report proves that the blood group of the deceased matches with the stains found on the clothes of the accused. A witness, Ved Prakash, saw the victim in the company of the accused on the night of May 7. There is no eyewitness to the occurrence, but the circumstantial

evidence clearly proves that it was the accused who had committed the murder of Gabbar Singh with slabs of stones."After hearing the argument, Virender Malik, additional sessions judge said in his order, "The cell phone and earphone of the deceased were recovered from the accused based on his disclosure. The defence of the accused is that he had purchased the victim's phone for Rs 400. However, he had not disclosed from whom he had purchased the said phone. Moreover, the blood stains of the deceased were also found on his clothes. These are the material

circumstances which prove that it was the accused who had committed the murder of Gabbar Singh. The testimony of prosecution witnesses proves the case beyond any doubt." The court held the accused guilty and convicted him under IPC section 302 (murder). On Saturday, Manoj was sentenced to life imprisonment and was fined Rs 10,000.

in-law for killing her husband Gurgaon: A woman and her brother-in-law were awarded life terms by a district court

Life term for woman and brother-

in the city on Saturday for killing her husband in 2019. According to the case diary, Jyoti and Sandeep got married in 2014 after a few years of courtship. Since Sandeep - who worked with a transport company - had married against the wishes of his family, he would hardly visit his parents. But they would visit his maternal uncle. Over the years, Jyoti established a relationship with the uncle's son, Sachin. By then, she and Sandeep had a 4-yearold son. Sandeep's brother Mohanbir said that in March 2019, Sandeep allegedly found his wife and Sachin together in a room and slapped his cousin. Sachin then threatened to kill Sandeep, he added.In Nov 2019, Sandeep was on his way home from work when Sachin fired at him with an illegal gun. Sandeep, who took a bullet in the back, was rushed to Civil Hospital, from where he was referred to Safdarjung hospital in Delhi when his condition deteriorated. He succumbed to injuries at the hospital. Following a complaint by Mohanbir, a case was registered against Jyoti and Sachin at Sector 37 police station under sections 302 (murder) and 120B (criminal conspiracy) of the Indian Penal Code (IPC) and relevant provisions of the Arms Act. What made the prosecution's case stronger was a video statement in hospital by Sandeep, who named Sachin and Jyoti and accused them of orchestrating the

attack on him. Jyoti was arrested the same day. Sachin was picked up almost a week later. While passing the judgment, additional sessions judge Tarun Singal observed that the prosecution had proved "beyond reasonable doubt that the accused Jyoti and Sachin were in an illicit relationship and had hatched a conspiracy to eliminate Sandeep". The court also noted there was no ground to doubt the dying statement of Sandeep, who named Sandeep and Jyoti.Sachin and Jyoti's lawyer argued that the case did not have any witness but relied on circumstantial evidence. The judge, however, rejected the argument, saying that the chain of circumstances "clearly pointed towards the

guilt of the accused".The court also observed that Sachin had acquired an illegal weapon to commit murder, which showed his premeditation

Robert F Kennedy Jr admits to dumping dead bear in New York's **Central Park**

Wilmington Independent US presidential candidate Robert F. Kennedy Jr said in a video posted online on Sunday that he dumped a dead bear in New York City's Central Park a decade ago and staged it to look like a bike had hit it.

Kennedy suggested in the video, which was posted on social media platform X, that he is trying to get ahead of a not-yet-published story from the New Yorker."Looking forward to seeing how you spin this one, @NewYorkerâ€æ" Kennedy posted on his X account with a video of himself at a kitchen table talking to comedian Roseanne Barr.Kennedy said in the video that he was driving to the Hudson Valley in New York state when a woman in a van in front of him hit a young bear and killed it. He put the bear's body into the back of his car because he was going to skin the bear and store its meat at his house, he said. But after a late dinner in New York City at the Peter Luger Steak House, he had to go straight to the airport and did not want to leave the bear in his vehicle."I had an old bike in my car that somebody asked me to get rid of. I said, 'Let's go put the bear in Central Park and we'll make it look like he got hit by a bike," he said and then laughed, saying it would be "amusing" for whoever found it.

The Kennedy campaign did not immediately comment further on the incident.

In October 2014, the body of a black bear cub was found in the bushes of Central Park and police launched a criminal investigation into the death. Foul play was suspected in the case, Reuters reported at the time, and state wildlife officials later concluded it was likely struck and killed by a vehicle.

Kennedy said in the video that the New Yorker had asked him about the incident and was planning on doing a "big article" about him.

Missile attack by Yemen's Houthi rebels hits container ship in first attack in two weeks

DUBAI. A missile attack by Yemen's Houthi rebels struck a Liberian-flagged container ship traveling through the Gulf of Aden, authorities said Sunday, the first assault by the group since Israeli airstrikes targeted them. The Houthis offered no explanation for the two-week pause in their attacks on shipping through the Red Sea corridor, which have seen similar slowdowns since the assaults began in November over Israel's war on Hamas in the Gaza Strip. But the resumption comes after the assassination of Hamas leader Ismail Haniyeh in Iran, the Houthis' main benefactor, amid renewed concerns over the war breaking out into a regional conflict. The rebels separately said they shot down another U.S. spy drone Sunday, later publishing imagery of the aircraft's wreckage on the side of the mountain. The attack on Saturday happened some 225 kilometers (140 miles) southeast of Aden in a stretch of the Gulf of Aden that has seen numerous Houthi attacks previously. It hit the container ship Groton just above its waterline, causing minor damage, said the Joint Maritime Information Center, a multinational coalition overseen by the U.S. Navy. An earlier missile attack missed the vessel, the JMIC said."All crew on board are safe," the center said. "The vessel was reported diverting to a port nearby."

Australian probe into Gaza aid worker deaths 'omitted crucial details': Israel

SYDNEY. Australia "omitted crucial details' when presenting a report into the deaths of seven aid workers in Gaza, Israel's embassy in Canberra said Monday in a frank diplomatic rebuke. Australian national Lalzawmi "Zomi" Frankcom was among a group of seven charity workers killed in April when their World Central Kitchen aid convoy was mistakenly hit by an Israeli air strike. A declassified Australian report last week blamed the lethal error on operational failures such as the "mistaken identification" of armed security staff as Hamas hijackers.

Israel's embassy hit back on Monday morning, saying the Australian government
"regrettably included some
misrepresentations and omitted crucial details", such as its military's willingness to cooperate."The IDF (military) has taken full responsibility for the grave mistakes that led to the tragic incident of the night of April 1,' the embassy said in a statement. The deaths -of an Australian, three Britons, a North American, a Palestinian and a Pole -triggered global outrage and a renewed push to ensure the safety of aid workers in Gaza.

Former Australian air force chief Mark Binskin was tasked with monitoring Israel's efforts to unravel what went wrong. His declassified report, released Friday, found three vehicles in the aid convoy were "struck in relatively quick succession" after they were tagged as suspicious.An Israeli surveillance drone flagged the vehicles after noticing some of the charity's security personnel were carrying guns, Binskin

US deploying additional forces in Middle East to de-escalate tensions: White House

Washington. The US is deploying additional military might in the Middle East as a defensive measure with a goal of deescalating tensions in the region, a White House official said on Sunday.Regional tensions have increased following the assassination on Wednesday of Ismail Haniyeh, the leader of the Palestinian Islamist group Hamas, in Tehran a day after an Israeli strike in Beirut killed Fuad Shukr, a senior military commander from the Lebanese group Hezbollah. Both groups are backed by Iran. There are mounting fears that Israel's war against Palestinian militants in Gaza, which began last October after attacks on the Jewish state, could escalate into a wider Middle East conflict. Iran and Hamas have blamed Israel for Haniyeh's killing in the Iranian capital, and they, together with Hezbollah, have vowed revenge. Israel has not claimed or denied responsibility.U.S. President Joe Biden will convene his national security team in the situation room on Monday to discuss

developments in the Middle East, the White House said, adding that he would speak with Jordan's King Abdullah as well.U.S. news service Axios reported that U.S. Secretary of State Antony Blinken told his counterpart from G7 countries that Iran and Hezbollah could start attacking Israel as early as Monday, citing three sources briefed on the call. But Blinken, according to Axios, said it was unclear how Iran and Hezbollah would attack and did not know the exact timing. When asked about the report, the State Department referred to a readout of the call, where it said the ministers discussed "the urgent need for de-escalation in the Middle East."The Pentagon said on Friday it would deploy additional fighter jets and Navy warships to the region."The overall goal is to turn the temperature down in the region, deter and defend against those attacks, and avoid regional conflict," Jonathan Finer, the White House's deputy national security adviser, said on CBS' "Face the Nation" program. The U.S. and Israel are

preparing for every possibility, Finer added. There was a "very close call" of regional conflagration in April, Finer said, when Iran launched an attack on Israeli territory with drones and missiles after what it called an Israeli strike on its consulate in Damascus on April 1 that killed seven officers of the Islamic Revolutionary Guard Corps in the Syrian capital. The U.S. wants to be prepared should that situation rise again, Finer added. In a call with his Israeli counterpart, the

Pentagon said U.S. Defense Secretary Lloyd Austin reiterated the United States' support defense against threats from Iran, Lebanese Hizballah (Hezbollah), Houthis, and other Iranian-backed terrorist groups."Blinken spoke with Iraqi Prime Minister Mohammed Shia al-Sudani on Sunday and emphasized "the importance of all parties taking steps to calm regional tensions, avoid further escalation, and advance stability," the State Department

Biden on Saturday expressed hope that Iran would stand down despite its threat to avenge Haniyeh's killing. The U.S. on Wednesday urged its citizens who wish to leave Lebanon to start making plans immediately."This is no prediction about future events. Tropical storm Debby strengthens into Category 1 hurricane as it heads to Florida

UPDATED Debby strengthened into a hurricane late Sunday as it bore down on Florida's Gulf Coast with potential for history-making levels of rain and major flooding, prompting evacuation orders. Debby grew rapidly into a Category One hurricane, the lowest on a five-stage scale, thanks to unusually warm Gulf of Mexico and is expected to slam into Florida's Big Bend region around mid-day Monday. The National Hurricane Center warned there is a danger of life-threatening storm surges along Florida's Gulf Coast with six to 10 feet (1.8 to 3.0 meters) of inundation above ground level in some areas. The storm will probably cause catastrophic flooding with "potentially historic heavy rainfall" when Debby moves northeast across Georgia and South Carolina over the next few days, the NHC said. "We are looking at potentially really, really significant flooding that will happen, particularly in north-central Florida," Governor Ron DeSantis told an emergency briefing on



the storm Sunday.He and NHC deputy director Jamie Rhome have stressed that Floridians should be making and completing their final emergency preparations immediately.

As of 11:00 pm (2100 GMT), Debby was about 100 miles (160 kilometers) west of Tampa carrying maximum sustained winds of 75 miles per hour and moving north at 12 miles per hour, the advisory said. As residents rushed to prepare, mandatory evacuations were ordered for part of Citrus County, Florida, with eight other counties under voluntary evacuation

orders, local media reported."Take the situation seriously," Paul Hasenmeier, Hernando County fire chief and public safety director, told reporters late Saturday. "We know the water's going to come up as the storm passes."Debby is expected to dump six to 12 inches of rain in parts of Florida, and as much as 20 to 30 inches in coastal Georgia and South Carolina before the week is over, the NHC said. The governors of Georgia and South Carolina have declared a state of emergency ahead of the storm's arrival.Brennan predicted "multiple days of very, very heavy rainfall"—at possibly record-breaking levels. He said there likely will be severe flash flooding "in areas that don't normally flood."President Joe Biden on Sunday approved an emergency declaration for Florida, allowing federal aid to be expedited.DeSantis has activated the state's National Guard, with 3,000 service members on standby to help with storm

DHAKA. The Bangladesh government on Monday ordered a complete internet shutdown as protestors asked the general public to join a "Long March to Dhaka", a day ofter nearly 100 months died in force day after nearly 100 people died in fierce clashes between demonstrators demanding Prime Minister Sheikh Hasina's resignation and the ruling party supporters in different parts of the country. The clashes broke out Sunday morning when protesters attending the non-cooperation programme under the banner of the Students Against

Discrimination with the one-point demand of Hasina's resignation over a job quota system faced opposition from the supporters of the ruling Awami League, Chhatra League, and Jubo League activists.At least 98 people, including 14 policemen, were killed in clashes on Sunday, leading Bengalilanguage newspaper Prothom Alo reported. The violence forced authorities to cut off mobile internet and enforce a nationwide curfew for an indefinite period. The Anti-Discrimination Student

Movement has rescheduled their "Long March to Dhaka" to be held on Monday, a day earlier than initially planned. The decision was taken during an urgent meeting amid growing concerns in the country, Asif Mahmud, a coordinator of the movement, said in a press release issued on Sunday night."In an urgent decision to review the situation, our 'March to Dhaka' program has been changed from August 6 to August 5. In other words, we are calling on students from all over the country

Kamala Harris strengthens against Donald Trump in new survey

Kamala Harris has a one percent advantage against Donald Trump in the latest polls, transforming the race for the White House. With the election approaching, Harris's choice of running mate is eagerly anticipated.

UPDATED. A new poll confirmed Sunday that Kamala Harris -- set to name her vice presidential pick imminently -- has drawn level with Donald Trump, transforming a White House race that the Republican had been increasingly confident he was going to win. As the November 5 election rapidly approaches, Harris has erased the growing lead that Trump was building before President Joe Biden dropped his re-election bid.According to the CBS News/YouGov poll released Sunday, Harris has a one percent advantage on Trump nationwide -- compared to Trump's previous five-point edge on Biden. In the swing states that decide the Electoral College contest in US elections, Harris and Trump -- who shocked the world with his 2016 presidential victory but was beaten by Biden in 2020 -- are equal. These are considered good numbers for a Democratic candidate who parachuted into the race only last month, when Biden bowed to mounting concerns over his mental acuity and ability at 81 years old to serve a second term. But Harris, who is Biden's vice president and the first Black and South Asian woman ever in the role, is in a sprint to define herself to voters before Trump does.A big moment in that process will be when Harris announces her choice for running mate in a





historic bid to become America's first female president. This could happen as early as Sunday or Monday. Expectations are that Harris will pick a white man to balance the ticket -- and likely a moderate Democrat who would help counterweigh attacks on Harris from Republicans that she is too far to the left.The three figures seen as heading the short list --Minnesota Governor Tim Walz, Pennsylvania Governor Josh Shapiro and Senator Mark Kelly of Arizona -- were all visiting Harris in Washington on Sunday, The Washington Post reported."It's her first major decision that she's making as an executive, so it tells you about her thought process," Amy Walter, a polling expert But with Biden's dramatic exit and Harris's fast from Cook Political Report newsletter, told CBS

News.The CBS poll, which echoes numerous other surveys indicating rapid gains by Harris, shows that Trump is still favored by voters on the key issue of the economy.Only 25 percent the key issue of the economy. Only 25 percent said they expected to be better off financially if Harris wins, compared to 45 percent who said so about Trump. However, when it comes to trust in the candidates' temperament, the poll shows voters prefer the former California prosecutor to Trump, a convicted felon who has made a career out of publicly insulting those who oppose him -- including while president. The issue of cognitive health, which used to bedevil Biden, is now a liability for 78-year-old Trump, the poll found. Only 51 percent year-old Trump, the poll found. Only 51 percent of respondents thought Trump is mentally capable for the presidency, compared to 64 percent for Harris. The Democrats believe that if you "make this referendum on Trump rather than a referendum on the current state of the economy. then we have a real opportunity to win," Cook said. Trump was riding high politically last month after surviving an assassination attempt at a rally, then using the Republican convention to highlight his image of vigor against the physically frail Biden.

Hurricane Debby to bring heavy rains and catastropic flooding to Florida, Georgia and South Carolina

TAMPA. The center of Hurricane Debby is expected to reach the Big Bend coast of Florida early Monday bringing potential record-setting rains, catastrophic flooding and life-threatening storm surge as it moves slowly across the northern part of the state before stalling over the coastal regions of Georgia and South Carolina.Debby was located about 100 miles (161 kilometers) west of Tampa, Florida, with maximum sustained winds of 75 mph (120 kph). The storm was moving north at 12 mph (19 kph), the National Hurricane Center in Miami said Sunday evening. Debby is the fourth named storm of the 2024 Atlantic hurricane season after Tropical Storm Alberto, Hurricane

Beryl and Tropical Storm Chris, all of which formed in June.Forecasters warned heavy amounts of rain from Debby could spawn catastrophic flooding in Florida, South Carolina and Georgia. The storm was expected to make landfall around midday Monday in the Big Bend area of Florida, about 16 miles (26 kilometers) south of Tampa, the hurricane center said. A tornado watch also was in effect for parts of Florida and Georgia until 6 a.m. Monday."Right now, we are to trying secure everything from floating away," said Sheryl Horne, whose family owns the Shell Island Fish Camp along the Wakulla River in St. Marks, Florida, where some customers moved their



boats inland. The sparsely populated Big Bend region in the Florida Panhandle also was hit last year by Hurricane Idalia, which made landfall as a Category 3 hurricane."I am used to storms and I'm used to cleaning up after storms," Horne said.

Debby was expected to move eastward over northern Florida and then stall over the coastal regions of Gorgia and South Carolina, thrashing the region with potential record-setting rains totaling up to 30 inches (76 centimeters) beginning Tuesday.Officials also warned of lifethreatening storm surge along Florida's Gulf Coast, with 6 to 10 feet (1.8 to 3 meters) of inundation expected Monday between the Ochlockonee and Suwannee

There's some really amazing rainfall totals being forecast and amazing in a bad way," Michael Brennan, director of the hurricane center, said at a briefing.

Group 'with secrets' to welcome public to tour its halls in south Mumbai

MUMBAI: Nestled within an inconspicuous heritage edifice in south Mumbai lies the headquarters of an enigmatic fraternity with an opulent 120year-old history that dates back to Biblical times.

The Freemasons' Hall at Fort, situated opposite Sterling Cinema, is the convening place for members of this ancient brotherhood, and it is set to welcome the public for an extensive tour of its hallowed halls and commemorate one of its most distinguished members of founding fathers, oriental scholar and linguist, K R Cama, on Aug 10. He was a prominent Freemason and the first Indian to be bestowed with the title of Provincial Grandmaster.

KR Cama was a renowned figure

among the Bombay Parsi reformers, celebrated for his pioneering efforts in promoting education for girls and advancing oriental studies. The Freemasons boast a roster of illustrious members, including luminaries like Sir Jamshetjee Jeejeebhoy, Sir Phirozshah Mehta, and Dadabhoy Nowroji Tata.All over the world, there are around 50 lakh Freemasons. In India, there are about 20,000, and in Mumbai, the number is estimated at 4,000. "This edifice was built for Freemasonry in Mumbai, its foundation stone was laid by Lord Sandhurst, then Governor General of Bombay, on 5th June 1897. The 127-year-



old building has four temples which are four meeting rooms," said P Venkatraman, a Freemason for 30-odd years. For years, the Freemasons have piqued curiosity and interest of historians, academics, and public; from rumours of alleged devil worship to purported control over the US dollar. "All those are just myths and rumours. We are essentially a brotherhood, and we believe in making good men better and use stonemason's customs and tools as allegorical guides," said Noshir Godrej Paghdiwalla, District Grand Secretary.

The earliest records of Freemasons meeting were in the rooms above Kala Ghoda. They have often been called a secret society with special rituals, initiation ceremonies, However, Kersi Limathwalla, the District Grandmaster, says, "We are not a secretive organisation, rather an organisation that has secrets. For example, if you went to big corporate companies and asked them for minutes of their meetings, would they give it to you? Or would Coca-Cola give you the recipe of their drink? Similarly, we have certain secrets.'

Aside from the rituals and symbols, charity, equality, and morality are pillars of Freemasonry, say members. "To be a Freemason, it is essential to believe in God, irrespective of which religion you belong to and follow. In

our meetings, our altar has all religious texts to symbolise that God is above all. Within our doors, we leave politics and religious debate outside as well as class or stature. In one such instance, there was once a king who was a member and had to salute his gardener who held a prominent role in the organisation," said Limathwalla.

Charity is a distinguishing characteristic of masons. "Charity is done by individual lodges, district or grand lodges. However, we believe in the idea that your left hand should not know what is in your right hand, and so we refrain from publicity," said Limathwalla.

As per initial complaint filed on July 19 by IndusInd Bank, Cyberabad police registered a case against bank officials Ramaswamy and Rajesh, and Reddy for allegedly siphoning off Rs 40 crore Aditya Birla Housing Finance Ltd's (ABHFL) Mumbai account. As per police probe, the money was diverted into the account of Reddy from where it was transferred into multiple accounts across the country. Subsequently, police found the involvement of a fourth person - Basheed - and arrested him along with Rajesh and Ramaswamy on July 30.

It was after the trio's arrest that the ex-IAF officer filed a police complaint."The IAF veteran came across Basheed a few months ago through a real estate agent while he was looking to sell his Jubilee Hills property," said a Cyberabad cop.

In his complaint, Reddy said Basheed projected himself as a wealthy man and expressed interest in buying the property. On knowing that the complainant was willing to sell another property in Yapral, Basheed convinced him that he'd buy both for 12.5 crore."Under the pretext of this transaction, Basheed convinced the complainant to open an account in IndusInd Bank's Shamshabad branch. The former also called manager Ramaswamy who sent his staff to help the complainant with the process," the cop said.

Following an initial delay in execution of the sale deed and payment, Basheed informed the complainant that one of his business associates would credit 40 crore into his account and requested him to allow it.

'He asked the complainant to retain 12.5 crore as payment against the two properties and transfer the remaining amount to different bank accounts. He roped in Ramaswamy to convince the complainant," the cop said, quoting from the complaint. Subsequently, the complainant alleged he was made to execute the sale deed in a hurry without being given much time to go through the content. The ex-servicemen claimed he realised that he was cheated when his account was frozen by the bank which told him that the 40 crore credited to his account were proceeds of fraudulent transactions. "As per the complainant. both his money and properties are now inaccessible because of the fraud. We are verifying the allegations, and will take action accordingly, a police personnel from Cyberabad said.

Just 4 cluster varsity proposals in 8 months

Mumbai. Eight months after the Proposals from MKES and state govt released regulations for cluster universities, there have been only four proposals. Three are from private colleges, and one from Nagpur involves government-managed colleges. Despite the state's push for colleges to use new schemes and become independent, managements remain hesitant. For instance, the vertical university plan has also seen no interest since Malad's Atharva Educational Trust.

While TOI reported on the proposal from Malad-Kandivali Education Society's (MKES) Nagindas Khandwala College, two other proposals are from Kolhapur's Shree Warana Shikshan Sanstha and Wardha's Shiksha Mandal, with Bajaj College of Science as the lead college. An official said that another group from Latur is interested, but their proposal is not yet on paper. A Mumbai college that showed interest a few months ago has now delayed its plans to focus on improving its infrastructure.

Kolhapur's Warana group are being reviewed by a stateappointed committee and will be presented to the cabinet for approval. The third proposal, involving government colleges in Nagpur, is also under consideration and will be the second government-managed cluster in the state after Homi Bhabha State University, which unified Sydenham, Elphinstone, Institute of Science, and ST Teachers' Training College. But it was formed under the central government's Rashtriya Uchchatar Shikshan Abhiyan scheme, not under the National Education Policy of 2020.

An MKES official said they've moved their school to a new location and are redeveloping their old building into a 12-storey structure for the cluster university. Additional plans are underway.

When the state govt came out with its regulations, at least 15 college managements across the state showed interest. However, after the regulations were released in

December, many colleges took a step back to assess them. A principal from a city college said the cluster universities will be public universities under the chancellorship of the governor, which not many managements are seeing as a lucrative option. "Instead, colleges are exercising more flexibility under the empowered autonomy status, where degrees can be awarded jointly with the parent university. Colleges are free to collaborate with other institutions, offer innovative courses," said the principal.

Haryana government amended state award policy for teachers in universities and collegesHaryana's chief minister, Nayab Singh Saini, approved an amendment to the State Award policy for university and college teachers, reducing the service evaluation period from 15 to 10 years. Heart attack among techies in 30s: How overwork, 70-hour week and stress can damage your heart



Just the other day, a 33-year-old executive, came to the emergency in the evening as he suffered a heart attack. I had to do an emergency stenting in all three of his arteries which were blocked well over 90 per cent. He worked from home but rarely detached himself from his laptop, logging in at 7 am and logging out at 8 pm. Then he took a 10minute break and living alone, ordered food almost every day. He would have his dinner by 9.30 pm, would enjoy a smoke or drink occasionally, take work or personal calls and sleep by 11 pm.I recount this story to highlight how punishing 12-hour work days (assuming there is one weekly off) to meet the 70-hour work week rule being advocated by the likes of Infosys founder Narayana Murthy and now OLA CEO Bhavish Aggarwal can cost the body. The young executive's life is a perfect example of how a decade of long sedentary work hours, with the stress of delivery deadlines that left little time for him to unwind, amplified moderate risks or underlying conditions faster. Remember the young man slept the requisite hours but being on a wire during the most productive decade of his life, had poor sleep quality. I admitted another young patient with a blood pressure of 200/115 mmHg, without him feeling it (young people generally do not feel symptoms of elevated blood pressure). He did sports with a friend on weekends but that wasn't enough to offset his high-stress 14-hour five day week.

HOW DO LONG WORKING HOURS AFFECT THE HEART? Most of my patients are from the tech park in Bengaluru's Whitefield, between 20 and 35. All of them have a similar work profile—no less than 12-hour workdays or long night shifts, emergency duties, two hours of commute time through congested roads and crunching sleep, family time and recreation in about an eight to ten-hour window, often interrupted by work calls. Zero physical activity.

The body is clearly in a prolonged adrenaline rush because of too much stress and demands made on it. Excess adrenaline constricts the arteries that supply the heart with blood, reducing blood flow, hastening plaque buildup and inflammation. Stress hormones like adrenaline and cortisol cause the heart to beat faster, elevating blood pressure in the process. Over time that damages the heart, and even accelerates levels of blood sugar, cholesterol and triglycerides. No exercise means weight gain. Chronic stress results in irregular heart rhythms, which can cause blood to pool in the left atrial chamber of the heart, contributing to clot formation. The clot can then travel from the heart to the brain and result in a stroke.

For those with underlying conditions like diabetes, cholesterol or with a family history, even short-term stress can dislodge plaques from the arteries it narrows down, resulting in a blood clot that, in its attempt to repair the torn wall of the arteries, could grow large enough to block blood flow completely and cause a heart attack. During angioplasty procedures among the young, I have often found that the plaque may not have been big enough but the stress-induced thickness of the blood has led to quicker clot formation.

Finepoint | Israel's Assassination Spree Forces Iran to Choose: Total War or Total Humiliation

It remains to be seen whether Iran will go all in or make a symbolic attack like it did in April. Ultimately, Iran will lose face if it doesn't respond but it will lose much more if it does

Iran's 'Axis of Resistance' is in a crisis. If Iran is the mothership, the Houthis, Hamas and Hezbollah are its proxies, extending far and wide into the West Asian region. These extensions of Iran have allowed it to project power across the Middle East, tackling its enemy Israel and keeping Arab powers in check. But Israel attacked all three of these heavily armed militant offshoots within days, and it has not even spared Iranian territory in the process.

News of the assassination of Hamas political chief Ismail Haniyeh in the Iranian capital of Tehran has sent shockwaves across the world and has embarrassed Iran. After all, he was a guest of Iran to attend the inauguration of its new President Masoud Pezeshkian, when he was killed in a blast. Before this, Israel struck a building in another capital city, Beirut in Lebanon, eliminating Fuad Shukr, Hezbollah's most senior military commander and a right-hand man to the Shia militant group's leader Hassan Nasrallah. This was apparently in response to a rocket attack by Hezbollah which killed 12 children in the Golan Heights, a Syrian territory controlled by Israel since the 1967 war.Israel also declared that Mohammad Deif, the military leader of Hamas in Gaza, was also killed in an air raid last month. And this is not it. The Houthis also got a taste of Israeli retaliation when a crucial Yemeni lifeline, the Hodeida port, came under attack. The massive air strike on this Red Sea Port was an answer to a drone attack by the Houthis.Israel is prepared for any further escalation, it says, and is on high alert anticipating a response from Iran. Meanwhile, Iran is trapped in its own web. Israel has killed one of Iran's dearest guests in its capital city. Haniyeh was a guest of the Iranians. He attended the inauguration of the new Iranian President, met Supreme Leader Khamenei with a warm hug and posed with the victory sign with other Iranian leaders. That was the last the world saw of him as he was killed before dawn in his special residence in Tehran.

Iran's Islamic Revolutionary Guard Corps (IRGC) reported it as a "Zionist raid" that took his life. It was initially theorised that it was an Israeli missile attack, and it raised serious questions about Iran's air defence capabilities. But it is now being reported that it was actually a bomb placed inside the guesthouse where Haniyeh was staying. And it was placed almost two months before the attack. For two

months, the security apparatus in Iran failed to track this bomb. When Haniyeh was finally inside, the bomb was detonated remotely. This raises serious questions about Iran's security and intelligence capabilities. This was a lapse at many levels, if it was a lapse at all. After all, how could it be so easy to take Haniyeh out? This Hamas leader had been evading the Israelis for decades, enjoying safe haven in



Qatar. Israel had been trying to take him out for years. Haniyeh was no small target— he was the political chief of Hamas since 2017, representing the group in diplomatic conversations with Arab and Western leaders. He shuttled from Turkey to Qatar and Iran to secure funding for Hamas. This is why some media reports will tell you that he was seen as a so-called "moderate" face of Hamas. This is not because he did not subscribe to the radical extremist ideology of Hamas but because leaders engaged with him behind closed doors to keep tabs on the Palestinian movement in Gaza.

The truth is that Haniyeh was responsible for the intense militarisation of Hamas during his time in Gaza and was even accused of diverting humanitarian aid to the Hamas armed wing. He is also believed to have amassed a wealth of \$4 billion while being a leading face of Hamas. Israel believes that he was involved in the gruesome October 7 Hamas attack which killed over a thousand Israeli civilians. But the hunt is not over yet, as Israel has hinted that its next target could be Yahya Sinwar, the leader of Hamas within the Gaza Strip. With Haniyeh gone, Hamas is searching for a new leader. Some say

that it could be Khaled Meshaal, who had previously lost Iran's favour when he supported a rebel movement against Syria's Bashar Al Assad. Meshaal has already survived an assassination attempt by Israel. In 1997, he was injected with poison by Israeli agents in the Jordanian capital of Amman. But the mission was botched, the agents were captured and the then-king Hussein was so furious that he

threatened to hang the agents, and scrap Jordan's peace deal with Israel unless it shared the antidote.

Under Netanyahu, who was in his first term at the time, Israel agreed to hand over the antidote and Meshaal was saved. If he returns to the paramount position in Hamas, he will surely need to watch his back or perish like his predecessor. Coming back to Haniyeh's death which has caused serious embarrassment for Iran. Everyone wants to know whether Iran will respond. After all, all its proxies and its own sovereign territory are under attack. Israel's message is pretty clear. No one is safe. So, will Iran sit back down, take the loss and lose face as a result— or will it strike back? If you go by the reactions of Iran's leaders, then revenge is right


around the corner. President Pezeshkian said, "I raised his victorious hand and today I have to bury him on my shoulders. Iran will make the terrorist invaders regret their cowardly action."

Meanwhile, Ayatollah Khamenei said, "The criminal, terrorist Zionist regime martyred our dear guest in our territory and has caused grief, but it has also prepared the ground for a severe punishment... It is our duty to take revenge." Khamenei has even ordered a direct attack on Israel, according to reports. But it's not as simple as it looks. Iran's words are failing to match its actions. In April this year, Israel attacked the Iranian embassy in Syria and killed several IRGC officers. Iran retaliated but it seemed like it did not want a war. It rained down missiles over Israel, almost all of which were intercepted by the Iron Dome air defence systems. The damage was little and by no means a major escalation. Moreover, reports said that Iran had notified countries in the region, indirectly tipping Israel off about the attack and letting it prepare its defences in advance. Could it be that Iran does not want to be dragged into an all-out war with Israel.

AP needs more from centre to keep promises

Chief Minister Naidu reveals alarming debt figures and outstanding liabilities, raising concerns about the state's ability to manage new welfare schemes and major projects.

In a departure from tradition, instead of presenting a fullfledged budget, the Chandrababu Naidu-led Andhra government promulgated an ordinance for vote-onaccount with an estimated expenditure of Rs 1.29 lakh crore for a period of four months. The reason was that the state finance department was still finalising the liabilities and resources. It sounds reasonable as the new government assumed charge in the second half of June. The government is likely to present the full budget in September. What is of concern is not the vote-onount but the chief minister's remarks that the state's finances are in a terrible shape. He released a white paper on the issue that paints a bleak picture. The white paper says the overall debt stands close to Rs 10 lakh crore and outstanding bills are at over Rs 1 lakh crore. The state's own resources are not enough to meet essential expenditures like salaries and pensions. The paper has been disputed by the opposition YSR Congress. What cannot be disputed though is that the state is on a sticky wicket. Revenues have gone up over the last decade



barring the Covid years, but so has expenditure, with welfare schemes accounting for a lion's share. All avenues to incur debt have already been explored, which leaves Naidu with little elbow room. He has promised much more than his predecessor Y S Jagan Mohan Reddy. New schemes such as free bus travel for women, higher investment for farmers, dole for the unemployed and education subsidy for each child would cost the exchequer more than the Rs 2.7 lakh crore spent on welfare in the last five years. On top, the mandate to complete the Polavaram irrigation project and develop capital Amaravati would increase the financial burden.

Naidu is riding a tiger, in the sense that there appears to be only one way forward. The Centre's announcement of Rs 15,000-crore aid for Amaravati must be renegotiated to make it a grant. The Polavaram project's terms must be amended as the Centre had set a condition of paying at 2014 prices, whereas the AP Reorganisation Act clearly states it is the Centre's responsibility to build the project. The implementation of schemes could be staggered, which might invite a backlash; but the government must be bold enough to prioritise them. Without changes, the state could end up staring at a debt trap.

For millenniums, caste has been cast in stone in the Indian psyche. Ironically, the legacy of discrimination was carried forward when India became a democracy, muddying the pristine playground of liberation. The social pyramid was turned on its head and generous generations scrambled up the ladder of power as a genetic journey to pelf. It also allowed uninterrupted caste-led parivarvaad to thrive without facing challenges.

The legacy of the bloodlines of India's rich and powerful in politics and bureaucracy sustains the system. However, a Supreme Court ruling last week could derail the gravy train. The current katzenjammer on caste—in parliament, elections and institutions—agitated a seven-member Constitution bench of the top court. Four of them led by Justice B R Gavai felt that caste-based reservations are meritocratic, nor bureaucratic or plutocratic.

Gavai, who could be the chief justice next year, wrote: "The State must evolve a policy for identifying the creamy layer even from the Scheduled Castes and Scheduled Tribes so as to exclude them from the benefit of affirmative action. In my view, only this and this alone can achieve the real equality as enshrined under the Constitution... The question that will have to be posed is whether equal treatment to unequals in the category of Scheduled Castes would advance the constitutional objective of equality or would thwart it. Can a child of an IAS, IPS or Civil Service officers be equated with a child of a disadvantaged member belonging to the Scheduled Castes studying in a gram panchayat or zilla parishad school in a village?"



Caste reservation fabric needs new pattern

create a parti pris paradigm to win elections. Caste-based reservations began almost 125 years ago. Considering the plight of Scheduled Castes and Tribes, the Constitution-smiths added affirmative clauses for proportionate representation of underprivileged castes in the executive and the legislature—a temporary provision for just a decade.

Indian politics revels in status quo and subverts change into stasis. No party has altered the clause or dropped it. So it's discussion over. Instead, they've reserved the weltschmerz-laden caste system for election manifestos. Reservations were meant to raise the social and economic status of India's first postindependence generation's underclasses. Instead, it has filtered down as a third-generation prerogative. Reservation was meant as an equaliser. Now it is a combo of oligopoly and monopoly of the social elite. By their sheer control over their part of the establishment, Dalit and backward monarchs constructed a fortresslike exclusive armature that denied right of entry to those who were at the bottom of the pyramid. While the establishment has sedulously secured

the advantages for itself, the constitutional principle of checks and balance has come into play. Making a powerful case for creaming the creamy layer, Justice Gavai felt, "It is also commonly known that disparities and social discrimination, which is highly prevalent in the rural areas, start diminishing when one travels to the urban and metropolitan areas. I have no hesitation to hold that putting a child studying in St Paul's High School and St Stephen's College and a child studying in a small village in the backward and remote area of the country in the same bracket would obliviate the equality principle enshrined in the Constitution." Gavai wasn't alone in his views. Justice Pankaj Mithal added,



"Reservation, if any, has to be limited only for the first generation or one generation, and if any generation in the family has taken advantage of the reservation and have achieved higher status, the benefit of reservation would not be logically available to the second generation." If the judicial stand is accepted by the states and the Centre, a Scheduled Caste or Scheduled Tribe family will lose reservation status if any member has availed it in the past. The Supreme Court has diluted the quota enjoyed by subjectively- and selectively-listed castes by making it inclusive: bringing in more deserving sub-castes that were left out. The creamy layer was already eligible for OBC reservation. It excludes

people whose family income exceeds Rs 8 lakh a month. The unfairness lies in agricultural income not being included in the total income. Hence, the landed backward-class peasantry enjoys reservation's benefits. Politicians are unlikely to heed the judicial advice. Since the categorising of reservations falls under the legislature, it is highly improbable that the political and bureaucratic nexus will yield to fair play. Rural India is still an area of darkness—a Naipaulian nightmare of unpunished humiliation, bondage, rape and murder. In the past three decades, politics, civil services and business have become hereditary institutions. Successive successors continue to replace powerful progenitors. Caste-based reservations are grossly misused by caste leaders, too.

Though no official data exists about the number of SC and ST youth entering the IAS, IPS, IFS or IRS, a sample of current legislators in the states and the Centre reveals every fourth member got his or her seat from their parents. Over the past two decades, the kin of at least 20 percent of services officers were from the same Cosy Cub Club. Recently, a few youngsters

from poor backgrounds made the cut, but the overwhelming majority of the marginalised classes don't have access to good education or skill development that will empower them to compete with upper-caste spawn.

V P Singh, prime minister during 1989-90, wanted to restrict senior government jobs to one person per family, irrespective of their caste. He felt that the recruitment mechanism heavily favoured the affluent. The joke doing the rounds in the power circles then was about the unsaid convention of children of senior officers appearing before a panel of UPSC interviewers made up of 'uncles and aunties'.

New Delhi: Delhi High Court on Monday remarked that the recent deaths of 14 inmates in the city governmentrun Asha Kiran shelter home for the mentally challenged was a "strange coincidence" and directed the social welfare secretary to visit the premises on August 6 and file a report. Noting that "nearly all" the dead suffered from tuberculosis, a bench headed by Acting Chief Justice Manmohan directed the Delhi Jal Board (DJB) to test the quality of water in the shelter home as well as the condition of water and sewer pipelines and



The bench, also comprising Justice Tushar Rao Gedela, emphasised that "curative measures" were needed in the matter and said if the shelter home was overcrowded, the authorities would decongest it and move some inmates to another facility.

The court, hearing a PIL seeking a probe into the deaths, listed the matter for further hearing on August 7.Since February, 25 inmates have died at the centre, currently housing 980 "intellectually disabled" persons, including men, women and children, according to

"Coaching Centres Have Become Death Chambers": Top Court On Delhi Tragedy

New Delhi: Coaching centres have become "death chambers" and are playing with the lives of children, the Supreme Court said today, issuing notice to the Centre and the Delhi government over last month's death of three Civil Service aspirants. They drowned after the basement of a coaching centre in Delhi's Rajendra Nagar - operating in violation of civic and fire safety rules - was flooded due to heavy rainDuring the hearing the Supreme Court, which had taken suo moto cognisance of the tragedy, accused the coaching centres of "playing with the lives of children".

The court also demanded to know what rules, if any, had been laid down for coaching centres, of which there are hundreds, potentially, in Delhi alone, many of which charge exorbitant fees to prep students for the IAS entrance exam and yet operate in unsafe environments. These places have become death chambers. Coaching

institutes can operate online unless there is full compliance of safety and basic norms for a dignified life. Coaching centres are playing with the lives of aspirants..." Justice Surya Kant and Justice Ujjal Bhuyan said. These norms should include proper ventilation and safe entrances and exits, the court said.

The Supreme Court also imposed a fine of? 1 lakh on a petition - the Coaching Institute Federation - for challenging a Delhi High Court order to shutdown all such business that have not passed civic and fire safety checks; nearly three dozen such centres were closed. The students' deaths - the result of drains failing to clear stagnant rainwater that was washed back into the basement with sewage - have triggered a row over infrastructure in the city. The Delhi High Court ripped into police ad city officials last week; "Some officer has to be liable... these people must be alive," the court said before it transferred inquiries to the CBI.A furious court asked serious questions of the Municipal Corporation and its ability to plan and maintain city infrastructure, particularly in times of crises like floods.

If you don't have any idea about what exactly you want on your body, the artist will be at a loss about what to suggest and you might get something you regret." Indian economy likely to grow at 7-7.2 per cent in FY25, says Deloitte

New Delhi. India's economy is expected to grow at 7-7.2 per cent in the current fiscal year driven by robust economic fundamentals and continuity in domestic policy reforms, Deloitte India said on Monday.

The August update of Deloitte's India Economic Outlook said several initiatives in the Union Budget 2024-25 toward improving agriculture productivity, creating jobs for the youth, and in manufacturing and addressing the challenge of access to finance for micro, small, and medium enterprises, would help improve supply-side demand, curb inflation, and prop up consumer spending, especially in rural areas.

Deloitte India Economist Rumki Majumdar said, India would witness robust growth in the second half after a period of uncertainty in the first six months of the year.

'Key contributing factors include the continuity in domestic policy reforms, reduced uncertainties in the US post-elections, and more synchronous global growth within a low inflation regime.

'Additionally, improved global liquidity conditions, as central banks in the West ease their monetary policy stance, will enhance capital flows and drive higher investments, particularly in the private sector,"

Japan's Nikkei 225 stock index sinks 10%, registers worst crash since 1987

The last time the Nikkei experienced such a severe drop was on "Black Monday" in October 1987, when it plunged 3,836 points, or 14.9%.

Japan's Nikkei 225 share index plunged as much as 10% on Monday, driven by heavy selling amid concerns that the U.S. economy may be in worse shape than previously expected. By midafternoon in Tokyo, the Nikkei index was down more than 3,500 points at 32,385.01. The index had already dropped 5.8% on Friday, and it is now headed for its worst two-day decline ever. The last time the Nikkei experienced such a severe drop was on "Black Monday" in October 1987, when it plunged 3,836 points, or 14.9%.

The drop follows the Bank of Japan's decision to raise its



benchmark interest rate on Wednesday, bringing it to around the same level as a year ago.

Share prices have been falling in Tokyo since the announcement. Adding to the turmoil, Asian equities plummeted to multi-year lows on Monday as investors rushed out of risky assets and into safe-haven bonds, driven by fears that the Federal Reserve's prolonged fight against inflation might have pushed the United States into a recession. Meanwhile, the benchmark Indian stock market indices, Sensex and Nifty, crashed 3% each. While the crash in the domestic markets wiped out significant amount of investor wealth, the situation was better than in other Asian stock markets.

US recession fears to Middle East crisis: Decoding global stock market crash

New Delhi. Stock markets around the globe, especially those in Asia, crashed on Monday on fears of a recession in the US economy and rising geopolitical tensions in the Middle East.The global stock market meltdown was triggered by widespread sell-offs, as investors hurried to move their risky assets into safer havens such as bonds and gold. Asian stock markets took the biggest knock, plunging to multi-year lows, with Japan and the tech-focused markets of Taiwan and Korea experiencing the heaviest losses. It may be noted that Japan's Nikkei 225 plunged the most since 1987 due to the sell-off sparked by US recession fears on Monday. Taiwanese stocks are down approximately 18% since their peak in mid-July but remain up over 11% for the year.South Korean shares, which had been marginally positive earlier in the year, are now 6% below their starting point. While the Indian benchmark stock

market indices, Sensex and Nifty, crashed 3% each, they were still in a better position than other Asian markets.Factors behind global market meltdownLast week's disappointing US economic data raised doubts about the Federal Reserve's ability to engineer a soft landing for the world's largest economy and whether more aggressive rate cuts might be necessary to prevent a slowdown. Santosh Meena, Head of Research, Swastika Investmart Ltd, said, "The global market is reeling as bears enter with a cocktail of bad news. The fear of a reverse Yen carry trade, following an interest rate hike in Japan, was the initial catalyst.""This was compounded by fears of a recession in the USA after extremely poor job data, which spooked market sentiment. China and Europe are already grappling with slowdowns, and escalating geopolitical tensions are

adding further pressure on the markets," he added."We are witnessing signs of the first meaningful correction in global markets after an extended bull run. Investors and traders should be cautious and avoid rushing in immediately, as better entry levels may emerge," he said, adding that the "the outlook for our market remains very bullish".

Rupee hits all-time low amid global stock sell-off and US economic worries

NEW DELHI. Rupee reached an alltime low on Monday as fears of a sharp Investors moved away from risky assets slowdown in the United States led to a sell-off in global stocks and a pullback from local equities. The rupee (INR)

fell to a record low of 83.82 against the US dollar. This drop in yields came amid rising expectations that the Federal Reserve might soon lower rates more aggressively. In a recent note, DBS Bank said that markets are increasingly worried about a potential economic slowdown.

They mentioned that while some analysts are predicting significant rate cuts, they believe a 50 basis point cut would be sufficient for now.

Sensex falls over 2,500 points, Nifty crashes; Rs 18 lakh crore wiped out

New Delhi. Benchmark indices, Sensex and Nifty, tumbled sharply for the second consecutive session today, mirroring global market fears of a potential recession in the US economy.

Investor wealth declined by Rs 18 lakh crore, with the market valuation dropping to Rs Rs 443.29 lakh crore from the previous session's Rs 457.16 lakh crore. The S&PBSE Sensex was down 2,345 points lower at 78,636.37 at around 12:09 pm, while the NSE Nifty50 plunged 698.70 points to trade at 24,019. The market downturn was broadbased, with small and midcap stocks experiencing significant declines.

Several top multibagger stocks declined sharply during the session. Volatility surged as global market uncertainty took its toll. All major sectoral indices suffered substantial losses in realty, IT, banking, and financial services stocks. Factors behind today's stock market crash

Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, highlighted US job data, which led to a global sell-off, was the key factor behind today's steep fall in Sensex and Nifty.He explained that expectations of a soft landing for the US economy is now in jeopardy due to a decline in job creation in July and a sharp rise in the US unemployment rate to 4.3%.

Geopolitical tensions in the Middle East are also exacerbating market fears, Vijayakumar noted. Another critical factor is the unwinding of the Yen carry trade, which has significantly impacted the Japanese market. The Nikkei index's crash by over 4% this morning signals a crisis in the Japanese market. Vijayakumar also pointed out that valuations in India remain high, particularly in the mid and smallcap segments, driven mainly by sustained liquidity flows. Overvalued sectors such as Defence and Railways are expected to face pressure. He advised investors against rushing to buy during this correction and to wait for market stabilisation. Amid the ongoing selloff, Sameet Chavan, Head of Research, Technical and Derivatives at Angel One, highlighted the importance of staying vigilant and monitoring global developments. He advised observing these trends thoroughly over the weekend to be well-prepared to respond effectively. Meanwhile, Tanvi Kanchan, Head -UAE Business & Strategy, Anand Rathi Shares and Stock Brokers, said, "The broader indices traded at a negative zone, emulating the global indices after the Nasdaq and the S&P lost 3.2% in 2 trading days, post the federal reserve decided to

Sebi amends mutual fund rules to curb front-running, insider trading

NEW DELHI. Capital markets regulator Sebi has amended mutual fund norms requiring Asset Management Companies (AMCs) to put in place an institutional mechanism to identify and deter front-running and insider

trading in securities. Additionally, the management of AMCs will be responsible for ensuring the effectiveness of the institutional mechanism.Also, the regulator has directed AMCs to have a whistleblower mechanism. This came in the wake of Sebi's passing two orders regarding front-running cases involving Axis AMC and Life Insurance Corporation of India

In a gazette notification dated August 1, Sebi said, "Asset management companies shall put in place an institutional mechanism, as may be specified by the Board, for the identification and deterrence of potential market abuse including frontrunning and fraudulent transactions in securities."Front-running refers to an illegal practice, where an entity trades based on advanced information from a



stock broker or analyst before the information has been made available to clients.As per the notification, the Chief Executive Officer (CEO) or Managing Director (MD)or such other person of equivalent or analogous rank

and Chief Compliance Officer of the asset management company will be responsible and accountable for the implementation of such an institutional mechanism."The asset management

company shall establish, implement and maintain a documented whistle-blower policy that shall provide for a confidential channel for employees, directors, trustees, and other stakeholders to raise concerns about suspected fraudulent, unfair or unethical practices, violations of regulatory or legal requirements or governance vulnerability, and establish procedures to ensure

adequate protection of the whistleblowers," Sebi said. To give these effects, the Securities and Exchange Board of India (Sebi) has amended mutual fund rules, which will come into force from November 1.

PV sales rise 10 per cent in July on new launches, enhanced discounts: FADA

NEW DELHI. Passenger vehicle retail sales in India witnessed a 10 per cent onyear jump in July driven by new model launches and enhanced discounts, industry body FADA said on Monday.

Total passenger vehicle retail sales rose to 3,20,129 units in July, as compared to 2,90,564 units in July 2023."Dealers reported benefits from good product availability, attractive schemes, and a Two-wheeler retail sales last month wider range of products," the Federation of Automobile Dealers Associations (FADA) Vice President C S Vigneshwar said in a statement. Heavy rains, low consumer sentiment, and intense competition posed challenges but dealers managed to sustain sales through strong promotions and incremental discounts, he added. Vigneshwar, however, noted that the growth is accompanied by high inventory levels which has surged to a historic high of 67-72 days, equating to Rs 73,000 crores worth of stock.

"This poses a substantial risk for dealer Commercial vehicle retail sales grew 7 per sustainability, necessitating extreme caution. FADA urges PV original equipment manufacturers (OEMs) to be

vigilant about potential dealer failures due to these high inventory levels," he stated. This victory in Paris marks the culmination of Lyles' relentless effort and dedication to his mental and physical well-being, underscoring the importance of mental health in achieving athletic excellence.

"I did this against the best of the best, on the biggest stage, with the biggest pressure," Lyles said. "And I wasn't even entered in the 100 in 2021. You know, here I am, first Olympics in the 100, going around now the Olympic champion."Lyles will now be in action in the 200 m event as he bids to complete a rare sprint double at the Olympics. Novak Djokovic aims to play LA 2028 Games after gold medal win in Paris Olympics

Novak Djokovic is already aiming to play in the Los Angeles Olympics 2028 after his gold medal win at the Paris Olympics 2024.

New Delhi. Novak Djokovic ended his 16year-long wait to win a gold medal at Paris Olympics 2024 in what he called "probably the biggest sporting success". The Serbian is also eyeing to play the Los Angeles Olympics in 2028, when he would turn 41. The 37-yearold already became the oldest to win an Olympic gold in the history of singles tennis event. Djokovic beat Spain's Carlos Alcaraz 7-6 (7/3), 7-6 (7/2) in an enthralling final at the Court Phillippe Chartier in Paris."This is probably the biggest sporting success I have

ever had and the most special feeling," the 37-year-old Serb said. "I want to play in Los Angeles, I enjoy playing for my country in the Olympic Games, in the Davis Cup," he added. Djokovic won a bronze medal in the Beijing Olympics 2008 and lost three semi-finals before clinching the gold medal at the Paris Games

Djokovic wins gold in Paris

With the historic win, Djokovic joined Andre Agassi, Rafael Nadal, Steffi Graf and Serena Williams in an elite club. These are the only players to win all four Grand Slam tournaments and Olympic singles gold, completing the career Golden Slam."I thought carrying the flag at the opening ceremony for my country at the 2012 Olympics was the best feeling an athlete could have until today."Djokovic, who has won a men's record 24 majors and swept up every title there is in tennis, finally clinched



Olympic gold at his fifth Games. He also managed to beat Alcaraz, who got the better of him in two consecutive Wimbledon finals. The 37-year-old said that he was not assured of a win until the final shot and gave his everything thinking that this could be his last shot at the Olympic gold."Now at the age of 37 and facing a 21-year-old who is probably the best player in the world right now, winning Roland Garros and Wimbledon

back-to-back, I can say that this is probably the biggest sporting success I have ever had."How Wimbledon loss worked in Djokovic's favour"We almost played three hours, the final shot was the only moment when I was sure I could win the match," said Djokovic."I knew that this could be my last chance of a gold medal," added Djokovic at his post-final press conference still draped in his country's flag and with his medal hanging proudly around his neck."I did everything I possibly could to prepare myself for this period. The injury sidetracked me a little bit. But coming into the Olympic Games, I felt like a different player in terms of how I moved, how I played. Alcaraz, 21, was also in tears after the match, but became the youngest to win a silver medal in the tennis event on his Olympic debut."In a way losing heavily to Alcaraz at Wimbledon probably worked in my favour as I knew I couldn't play any worse than that."
