Bangladesh new interim leader Muhammad Yunus heads home, government to be sworn in today

Dhaka, August 7: The Nobel Peace laureate tapped to lead an interim government in Bangladesh called for calm and boarded a flight on Wednesday to return home, a day before his new government is expected to be sworn in to replace ousted Prime Minister Sheikh Hasina. Muhammad Yunus, 84, was picked by President Mohammed Shahabuddin to lead the new interim government, a key demand of student demonstrators whose uprising drove Hasina to flee to India on Monday. "Let us make the best use of our new victory," he said in a statement before departing Paris, where he had been receiving medical treatment while out on bail from criminal cases brought under Hasina. "I fervently appeal to everybody to stay calm. Please refrain from all kinds of violence." Outside the airport he told reporters: "I'm looking forward to going back home and see what's happening there and how we can organise ourselves to get out of the trouble that we're in." "I'll go and talk to them. I'm just fresh in this whole area," said Yunus, an economist who was awarded the



2006 Nobel Peace Prize for founding a bank that pioneered fighting poverty with small loans to ordinary people. President Shahabuddin said the rest of the interim government needed to be finalised soon to overcome the crisis and pave the way for elections. Nahid Islam, a key student leader, said he expected the members to be chosen by late Wednesday. Army chief General Waker-Uz-Zaman said that he was hopeful the interim government would be sworn in by late Thursday and that the situation in the country was improving and was expected to become normal in the next three to four days. He also said that military lead ers had held discussions with student leaders, political parties, and the president and that he was confident that Yunus would be able to take the country towards a democratic process. President Shahabuddin also announced the appointment of a new police chief, Mohammad Mainul Islam, to replace Chowdhury Abdullah Al Mamun as part of a shake-up of the security top brass that also included a new head of the technical intelligence monitoring agency and changes among senior army officials.

Ten Rajya Sabha seats fell vacant as the sitting members, including Union ministers Piyush Goyal, Sarbananda Sonowal and Jyotiraditya Scindia, were elected to the Lok Sabha. Bypolls are also being held for two seats in Telangana and Odisha. K Keshava Rao from Telangana resigned recently from the House after quitting the Bharat Rashtra Samithi (BRS) to join the Congress while Biju Janata Dal (BJD) MP Mamata Mohanta resigned from her Rajya Sabha seat and primary membership of the party. Besides Goyal, Sonowal and Scindia, the other Rajya Sabha members who won the parliamentary polls and moved to the Lok Sabha are Kamakhya Prasad Tasa (BJP), Misha Bharti (RJD), Vivek Thakur (BJP), Deepender Singh Hooda (Congress), Udayanraje Bhosle (BJP), K C Venugopal (Congress) and Biplab Kumar Deb (BJP). The notification for the Rajya Sabha elections will be issued on August 14 and the last date for filing of poll papers is August 21, the commission said. The separate elections for each Rajya Sabha seat will be held on September 3 and the results will be announced the same day.

New Delhi, August 7: Terming it as "absolutely unwarranted", "wholly unnecessary" and "a matter of great concern", the Supreme Court on Wednesday expunged the critical comments made by Justice Rajbir Sehrawat of the Punjab and Haryana High Court against it for staying contempt proceedings in a case pending before his Bench. "Compliance with the orders passed by the Supreme Court is not a matter of choice but a matter of bounden constitutional obligation. Parties may be aggrieved by an order. Judges are never aggrieved by an order passed by a higher constitutional forum," a five-judge Special Bench led by Chief Justice of India DY Chandrachud said."Whether individual judges are in agreement with merits of the order passed by a superior court is beside the point," it noted. "Justice Rajbir Sehrawat has made observations in regard to the Supreme Court of India, which are a matter of grave concern...Judicial discipline in the context of the hierarchical nature of the judicial system

Courts, or High Courts or the Supreme Court," the CJI said, terming the judge's comments as "scandalous". "We are pained by the observations made by the single judge of the Punjab and Haryana High Court. The observations are made in regard to an order passed by the Supreme Court," said the Bench which had on Tuesday taken suo motu cognisance of Justice Sehrawat's comments made in his July 17 order. CHENNAI: A Sri Lankan court has sentenced three boat drivers of Rameswaram to undergo one-year imprisonment or pay a fine of 40 lakh Sri Jesuraja and Rayappan, fishermen Lankan Rupee each for allegedly entering the Sri Lankan waters in violation of

International Maritime Boundary Line on June 23. The court on Tuesday also ordered the release of 19 fishermen, and extended the custody of nine other fishers, sources said. Lingayat Mahasabha challenges 'Vachana Darshana' book, poses questions

BENGALURU: The release of the book 'Vachana Darshana', which has found support among right-wing groups, has been challenged by progressive Lingayat groups. Jagathika Lingayat Mahasabha, challenging the book in a letter to Dharwad Deputy Commissioner, said, "The book 'Vachana Darshana' published by Ayodhya Prakashana and being released in many places across Dharwad district, distorts what great social reformer Shri Basavanna taught." They requested that permission granted to the publishers to release the book in Hubballi on Wednesday, besides other places, be withdrawn forthwith.Progressive Lingayat groups have posed ten questions to heads of mutts and Lingayats who are ignorant about the book and its purpose.

At least one mutt head, Moorusavira Mutt pontiff Guru Siddha Rajayogindra Mahaswamigalu, accepted their arguments and said he would not participate in the book release in Hubballi, where he is one of the invitees, said Kumaranna Patil, a Lingayat activist based out of Dharwad.

The ten questions posed to Lingayat mutts are: Are you truly following Basavanna's teachings and his concepts? Had social reformer Basavanna accepted the primacy of Vedas, Upanishads, Agamas and caste system in Lingayat Dharma? Basavanna was a former conformist Hindu and not a social reformer: What is your opinion? Who are the persons behind this book which has distorted Basavanna's teachings? And why have they distorted his teachings? Many progressive Lingayat group leaders said, "We see they are planning to release the book in dozens of places in the next few days, and we will protest silently.

What social reformer Basavanna said in the 13th century cannot be diluted or distorted to suit anyone's needs, least of all Hindutva." A group of 50 Lingayat protesters had raised slogans on Saturday, saying the book does not present the true picture of Basavanna, and why it cannot be accepted by Lingayats, and were detained by police before being let off. The function was attended by BJP National General Secretary (org) BL Santosh and Shivananda Swamiji of Gadag.Lingayats said they would continue with their protests across the state and are expected to protest silently wherever the book is slated for release.

Meanwhile, actor Chetan, a Lingayat, said, "The storm over the book 'Vachana Darshana' is a binary ideological struggle between those trying to co-opt Basavanna into Hindutva fold, and the establishment's 'progressive' thinkers. PUTHUMALA (WAYANAD) : C Muraleedharan stood at the Puthumala mass burial ground with a heavy heart. A resident of Chooralmala School Road, he was in the area searching for his cousin, 27-year-old Haridas, who has been missing since the catastrophic

landslides. Though Muraleedharan and Haridas' elder brother Arun suspected that a body kept at the Meppadi Community Health Centre might have been his, it was buried along with other unidentified bodies and body parts because other members of their family were unable to arrive to identify the body for sure."Let him sleep here as all his dear ones too are resting here," said Muraleedharan, standing next to the grave marked with the DNA identification number 176 where that

particular body was buried Muraleedharan's mother and Haridas' father too are among those missing. The family believes they were all buried together and are yet to decide whether to exhume the body and perform the religious rites before cremation."The two of us agreed on burying him here as we feel our other relatives too are buried here. It feels as if he is sleeping near us. Our house and property are devastated,



and we have no proper place to bury him Though Seva Bharan volunteers offered to perform the last rites according to our religious practice, we prefer not to exhume the body," Muraleedharan said, his voice choked with emotion.Blood

Spike in amoebic infection cases perplexes health department in Kerala

KOZHIKODE: The health department is grappling with a surge in primary amoebic eningoencephalitis (PAM) cases, a development that has perplexed experts. Though the Southwest monsoon is currently on in the state, the state is witnessing an unusual spike in this typically warm-weather infection. Amoebic meningoencephalitis is a rare but severe brain infection caused by amoeba, which usually thrives in extreme temperatures. However, the current climatic conditions in Kerala, characterised by persistent rainfall and resulting cooler temperatures, should have curtailed the proliferation of the amoeba.hings took a turn for the worse after four youths from Nellimoodu in Thiruvananthapuram tested positive for amoebic meningoencephalitis. It's for the

first time in the state that the infection was confirmed in adults and one of them even died of the infection on July 23.

Specialist in infectious diseases Dr Rajesh Kumar said, "We did not expect an increase in amoebic meningoencephalitis cases during the rainy season. Typically, this amoeba proliferates in warmer climates. The current trend is both alarming and unusual."Efforts are under way to identify the sources of infection and implement containment measures. Public health advisories urging residents to avoid swimming in freshwater bodies and to maintain strict personal hygiene have been

Experts said that Naegleria fowleri, also known as 'brain eating amoeba', the most reported variant of PAM, occurred

following exposure to warm, fresh water in lakes and rivers or any stagnant water body during summer. It can also live in hot springs or warm water discharged from industrial plants, poorly maintained swimming pools with minimal or no chlorination and soil. It can even grow in water heaters at temperatures of up to 115° F (46° C) and survive for short periods at higher temperatures.

Naegleria does not live in salt water. When people, usually children or young adults, swim in contaminated water, the amoebas can enter the central nervous system through the nose. When they reach the brain, they cause inflammation and tissue destruction, which usually progress rapidly to death Dr Reshma Rajan, a public health expert,

who emphasised the need for immediate action said, "The government is investigating all possible sources of contamination.

It is crucial for the public to follow safety guidelines and for healthcare providers to remain vigilant in diagnosing and treating potential cases."The state government has allocated additional resources to the health department to manage the crisis. Medical facilities are being equipped to handle the influx of patients and awareness campaigns are being intensified to educate the public on risks and preventive measures.

The health department continues to monitor the situation closely, hoping to understand the underlying factors contributing to this unprecedented rise in amoebic meningitis cases during an atypical season.

Judge orders trial court to frame charges, hold trial expeditiously ; ministers told to appear in **September**

TN Ministers Ramachandran, Thennarasu to face trial in disproportionate assets cases: Madras HC

CHENNAI: In a significant order that is likely to have legal and political ramifications, the Madras High Court on Wednesday set aside the orders of a trial court, discharging incumbent Ministers KKSSR Ramachandran and Thangam Thennarasu of DMK from two separate disproportionate assets (DA) cases filed against them. The court sent the cases back to the trial court and ordered it to conduct trial expeditiously to take the cases to their logical conclusion. Justice N Anand Venkatesh, who had initiated the suo motu revision cases after finding issues in the manner in which the ministers were discharged by the trial court, delivered the verdict.Restoring the cases on the file of the trial court, which is the special court for cases under Prevention of Corruption Act (PCA), Principal District and Sessions Court of Srivilliputhur in Virudhunagar district, the judge ordered that the 'final closure report'



filed in the cases by the Directorate of Vigilance and Anti-Corruption (DVAC) be treated as a 'supplementary report'. "As prima facie materials are available to frame charges, the special court shall proceed to frame charges, and thereafter, proceed in accordance with the law," he said in the order. Consequently, Justice Venkatesh,

dismissed the discharge petitions filed by the ministers and the other accused persons in the case.e directed Ramachandran and the other accused in his case to appear before the special court on September 9, 2024 and Thennarasu and the others accused in his case to appear on September 11, 2024 to furnish bonds with or without surety. The trial court was further directed to 'conduct the trial on day-to-day basis' and dispose the cases as expeditiously as possible. However, he added that the High Court has not commented on the merits of the case, and therefore, the cases can be decided by the special court 'without being influenced' by any of the comments. Justice Venkatesh took up the suo motu revision against the orders of the trial court passed in 2022 and 2023 to respectively discharge Thennarasu and Ramachandran from the DA cases. The trial court had given a clean chit to the ministers, following the DVAC's

submission of an "additional final report" following a "further investigation". The judge said that stated that there was a 'pattern' in the manner the "further investigation" was held and the submission of the additional report, that too only after the politicians concerned came back to power (in 2021). He had said that such favours to political leaders alone by the DVAC cannot be let go without being questioned. Similar suo motu revision cases were initiated against another incumbent minister K Ponmudy, former Chief Minister O Panneerselvam and former minister B Valarmathi.While delivering the judgement on Wednesday, Justice Anand Venkatesh quoted James Jeffrey Roache's poem "The net of law is spread so wide, No sinner from its sweep may hide. Its meshes are so fine and strong, They take in every child of wrong. O wondrous web of mystery! Big fish alone escape from thee!".

Sewer lines choked in Gurgaon's Badshapur, MCG seeks FIR against agencies

GURGAON: MCG has lodged a police complaint against two contractors for their alleged negligence in maintaining sewer lines in Badshapur's Tyagiwada. The complaint sent by MCG executive engineer Sanjeev Kumar to the Gurgaon police commissioner has requested an FIR against the agencies responsible for the area's sewerage. According to officials, MCG had assigned the work of sewer line upkeep in Ward 25 to one contractor, while another was engaged for the operation and maintenance of the sewage motor pump.

Despite the accumulation of a large amount of water in Tyagiwada on Sunday due to rain and choked drains, both contractors allegedly failed to respond to MCG's repeated requests to send the required equipment to the site for unclogging of drains."It is the responsibility of both agencies to provide the required equipment to resolve such issues. Residents reported that the contractors' negligence led to numerous accidents in the area, causing significant inconvenience to the public and tarnishing the image of the corporation. As a result, the complaint seeks to register a case against both contractors for creating public nuisance, causing accidents, and damaging the corporation's reputation, Kumar said in his complaint, which was filed on Monday.Kumar added that MCG assistant engineer Ashish Hooda and junior engineer Arif Khan promptly reached the affected site on Sunday, arranged the necessary equipment and machinery and oversaw water drainage, providing relief to residents.

No relief on caste certs, applicants of CET Mains told



GURGAON: Haryana govt has reiterated its stand that applicants who submitted caste certificates issued more than two years ago won't be eligible to give the CET Mains examination for Group C posts.Govt cleared its stand after a group of applicants gathered at the Haryana Staff Selection Commission (HSSC) headquarters in Panchkula on Monday to get their admit cards for the exam. Many of them found out that they would not get the admit cards because of their caste certificates. Officials said on Tuesday that HSSC told aspirants that the only option for relief is to approach the high court.

Last week, the Punjab and Haryana high court, in an interim order, directed Haryana govt to provisionally allow the petitioner to appear for the CET Mains exam. The division bench of Justice Mahabir Singh Sindhu on Aug 2 rejected govt's argument that the caste certificate was outdated. HC said that HSSC explicitly said in its advertisement that backward class applicants should upload the latest caste certificate. Otherwise, the caste and category mentioned in the family identity document will be considered. Even if applicants approach high court, it may be too late. Govt-aided colleges in Haryana must implement biometric attendance, warns DHE

GURGAON. The Department of Higher Education (DHE) has cautioned govt-aided private colleges throughout the state of potential disciplinary measures if they neglect to ensure compliance with regular biometric digital attendance for their teaching and non-teaching staff. According to sources, DHE issued the directive in response to complaints alleging that many employees of these colleges are absent from the workplace during instructional hours.DHE issued show-cause notices to principals of 167 govt colleges after over 3,000 employees failed to mark biometric attendance on July 9.The requirement for daily biometric attendance was initially limited to govt colleges, but now, aided colleges have also been included in the mandate. Dayanand Malik, president of a teachers' body at govt-aided colleges, expressed the teachers' willingness to comply with every measure to improve the standard of higher education. However, he argued that if DHE imposes all conditions applicable for govt colleges on aided colleges, it should also ensure the same benefits for both.

Driving Gurgaon mad: 1.3 lakh challans issued for traffic offences, fines up to Rs 1 crore

GURGAON. Over 1,000 people were penalised every day for riding without a helmet last month, while 575 were issued challans for driving on the wrong side, according to traffic police data.

Police conducted a drive from July 1 to 31 targeting common traffic violations, including riding without helmets, wrong-side driving, illegal parking and lane changing, drunken driving, placing dark film on windows, and riding bikes with modified silencers. Over the course of the month, police issued a staggering 1.3 lakh challans for these offences.

The maximum challans - 31,099 - were issued for riding without a helmet, followed by wrong-side driving (17,258), illegal parking (11,213), lane change violations (5,881), drunken driving (2,917) and illegally placing dark films (971). The total fines collected amounted to over Rs 1.1 crore. The primary goal of this rigorous

enforcement drive was to make the city's roads safer and to significantly reduce accidents. As part of our strategy, we also organised 60 awareness programmes in July, which were attended by around 8,000 people. They were educated about road safety and the importance of adhering to traffic rules," said DCP (traffic) Virender Vij. During these programmes, police urged parents to prevent underage children from driving, and also asked the public to ensure that only two people ride on twowheelers and use helmets. They also highlighted the dangers of driving in the wrong direction and the importance of driving heavy vehicles in appropriate lanes. Avoiding driving under the influence of alcohol was another crucial

"By following traffic regulations, individuals can contribute to a safer and more orderly traffic environment. The campaign was not just about issuing challans and collecting fines; it was about fostering a culture of road safety and responsibility among the city's residents," said DCP.Fines for almost all major traffic offences were raised last year, but little has deterred motorists from breaking the rules. Wrong-side driving remains a leading cause of fatal accidents. While first-time violators face

a fine of Rs 5,500, repeat offenders will



1 dead, 8 trapped after hotel partially collapses in Germany

Kroev, Germany. A hotel partially collapsed overnight near the banks of the river Moselle in Germany, killing one person and trapping eight others, some of whom suffered severe injuries in the incident, local police said on Wednesday.

The body of the victim was located but could not yet be recovered, said police, who established contact with some of those still trapped."Due to the nature of the damage, this is an extremely demanding operation," the police statement said, and the building in the town of Kroev could only be entered by emergency responders with the utmost caution. Firefighters and paramedics gathered outside the building, whose upper floor caved in at around 11 pm on Tuesday. One emergency responder was seen carrying a barefoot woman out of the damaged building. Investigators believe 14 people were in the hotel when the incident occurred, five of whom escaped without injury. Police said 31 neighbours were also evacuated from their homes for their own safety. The Moselle region is known for its picturesque towns and vineyards on steep river banks.

Tropical storm Debby brings heavy rain, tornadoes to US states, streets flooded

Charleston. Tropical storm Debby drenched coastal cities in Georgia and South Carolina, stirred up tornadoes and submerged streets with waist-high floodwaters on Tuesday, just the beginning of a prolonged storm that could dump staggering rain totals of up to 25 inches (64 centimetres). Charleston and Savannah, Georgia, took the first blow, with up to a foot (30 centimetres) of rain falling along the coast between the two cities in just over 24 hours. Police blocked all roads into Charleston's downtown peninsula to everyone but essential workers and emergency personnel. Dozens of roads were closed in the historic city because of flooding similar to what it sees several times a year because of rising sea levels. As Debby swirls just offshore, the heavy rain is expected to move north into parts of South and North Carolina that have already seen two billion-dollar floods in eight years.In one Savannah neighbourhood, firefighters used boats to evacuate some residents and waded through floodwaters to deliver bottled water and other supplies to those who refused to leave. Michael Jones said water gushed into his home on Monday evening, overturning the refrigerator and causing furniture to float. Outside, the water seemed to be everywhere and was too deep to flee safely. So, Jones spent a sleepless night on his kitchen table before firefighters going door to door came in a boat on Tuesday morning."It was hell all night," Jones said, adding, "It was a struggle, but God is good."In Charleston, Mayor William Cogswell said the road closures have kept businesses and homes from unnecessary damage and avoided the need for any highwater rescues."We especially don't need any yahoos driving through the water and causing damage to properties," Cogswell said.South Carolina Governor Henry McMaster said Debby has not been as bad as feared so far, but he warned that the slow-moving storm was far from over.It will be a nervous few days for northern South Carolina and southern North Carolina, where forecasters warned of up to 15 inches (38 centimetres) of rain. Those totals are close to what the region saw in a historic flood from Hurricane Matthew in 2016. Two years later, many of those records were broken during Hurricane Florence. Both storms killed

A recent report said that Tesla's political group has been collecting personal data from people in Michigan and other states through its website.

Bangladesh army defied Sheikh Hasina's order to impose curfew by force: Report

➡ Bangladesh army chief Gen Waker-Uz-Zaman told Sheikh Hasina's office that troops would not impose a curfew by firing upon people who were demanding her removal from the post over the controversial job quota system, two officers told Reuters.

Dhaka The night before long-time leader Sheikh Hasina abruptly fled Bangladesh amid deadly protests, her army chief held a meeting with his generals and decided that troops would not open fire on civilians to enforce a curfew, two serving army officers with knowledge of the discussions told Reuters.

Gen Waker-Uz-Zaman then reached out to Hasina's office, conveying to the prime minister that his soldiers would be unable to implement the lockdown she had called for, according to an Indian official briefed on the matter. The message was clear, the official said: Hasina no longer had the army's support. Details of the online meeting between military top brass and the message to Hasina that she

had lost their backing had not previously been reported. They help to explain how Hasina's 15-year rule, during which she brooked little dissent, came to such a chaotic and sudden end on Monday, when she fled from Bangladesh to India. The nationwide curfew had been imposed after at least 91 people were killed and hundreds injured in nationwide clashes on Sunday (August 4), the deadliest day since student-led protests against Hasina began in July.Army spokesperson Lt Col Sami Ud Dowla Chowdhury confirmed the Sunday evening discussions, which he described as a regular meeting to take updates after any disturbance. He did not provide details when presented with additional questions about decisionmaking at that meeting. Hasina could not be reached and her son and advisor, Sajeeb Wazed, did not respond to repeated requests for comment.Reuters spoke to ten people familiar with the events of the past week, including four serving army officers and two other informed sources in Bangladesh, to piece together the final 48 hours of Hasina's

reign. Many of them spoke on condition of anonymity due to the sensitivity of the matter. Hasina, whohas ruled Bangladesh for 20 of the last 30 years, was elected to a fourth term leading the country of 170 million in January, after arresting thousands of opposition leaders and workers. Her iron-fisted grasp on power has been challenged since summer by protests triggered by a court ruling to reserve government jobs - heavily coveted amid high youth unemployment for certain segments of the population. Indian-origin doctor in UK fakes assault to drop patient from surgery list

World A 58-year-old Indian-origin medical practitioner has been suspended for 12 months for fabricating an assault to frame a patient to remove him from his surgery list. Gurkirit Kalkat, who worked at Thames View Medical Centre in Dagenham, Essex, England, wanted to drop the patient due to a merger with another doctor's practice. He went to extreme lengths, including beating himself up and falsely claiming the patient had attacked him. The incident occurred when Kalkat called the patient in for an appointment, threw himself against the door, and hit himself in the chest while shouting, "Stop hitting me!"The patient, who had drug issues, sat in a chair and looked on in shock.Kalkat then pressed a panic button, and police officers arrived, taking the patient away in handcuffs. However, the investigation was dropped when Kalkat refused to proceed with a prosecution, reported the Daily Mail.Kalkat had previously lied to the patient about having terminal blood cancer to encourage him to register with another general practitioner (GP).He even paid £44,000 for the patient's rehabilitation treatment.

Kalkat was unable to explain why he was paying for the patient's treatment out of his own pocket, reported the Daily Mail.

PATIENT SECRETLY FILMED MEDICAL **PRACTITIONER**

During an earlier consultation, the patient secretly videoed Kalkat, a medical practitioner, as he falsely claimed he had six months to live and offered him a further £15,000 to leave the practice, reported the Daily Mail.

At the Medical Practitioners Tribunal Service in Manchester, Kalkat from Loughton, Essex, was suspended from practising medicine for 12 months after being found guilty of serious professional misconduct. The tribunal chairman, Stephen Killen, stated, "Dr Kalkat had been taking increasingly inappropriate, desperate and dishonest actions with a view to Patient A registering elsewhere. The government has said 6,000 specialist police are being readied to deal with England's worst disorder in over a decade,

which has seen hundreds arrested and more than 100 charged. The violence broke out after three girls, aged nine, seven and six, were killed and five more children critically injured during a knife attack at a Taylor Swift dance class in Southport, north west England. False rumours initially spread on social

media saying the attacker was a Muslim asylum seeker. The suspect was later identified as 17-year-old Axel Rudakubana, born in Wales. UK media reported that his parents are from Rwanda.Despite the police statement, initial disturbances in Southport centred around a local mosque, and widespread violence has rocked England and Northern Ireland since.Prime Minister Keir Starmer late Tuesday warned anyone involved would face "the full force of the law", including those inciting violence online.Starmer, a former chief state prosecutor, said he expected "substantive sentencing before the end of this week" for the rioters, after chairing his second emergency meeting in as many days on Tuesday."That should send a very powerful message to anybody involved, either directly or online," he added in televised comments. The unrest,



Britain's worst since the 2011 London riots, has led a number of countries to warn its citizens about the dangers of travelling in the United Kingdom. Thiruvananthapuram: Sutured glove piece sparks row; doctor says part of procedure THIRUVANANTHAPURAM: A post-

surgical procedure at General Hospital in Thiruvananthapuram has sparked a controversy after a piece of surgical glove was found sutured to a patient's wound.

Shiju, a 38-year-old from Nedumangad, underwent surgery to remove a cyst from his back on August 3. His wife found the protruding piece of the glove while dressing the wound. Unaware of the procedure, they thought it was a mistake from the surgeon. Later, Dr Suresh, who carried out the procedure, explained that the glove was



intentionally sutured to facilitate the drainage of pus and blood after the sebaceous cyst was removed. "This is a cost-effective technique that is commonly used. A portion of the glove is cut and attached to the dressing to ensure the flow of pus and blood. The patient was informed about this method, and it is documented in his medical records," he said.

The family, however, contends that there was insufficient communication about the glove and that the nurse only advised them to seek treatment at the nearest hospital for dressing changes. Meanwhile, the Kerala Government Medical Officers' Association has called for action against those spreading misinformation about the procedure, arguing that such claims could demoralise medical professionals.


Minibuses to ply on interior routes of Tripunithura in Kochi soon

KOCHI: The demands for connectivity to interior areas and the narrow roads in the hinterlands have prompted the Motor Vehicle Department (MVD) to contemplate issuing permits to private buses, especially minibuses, in new routes in Tripunithura region. This comes in the wake of the huge response

to a 'Janakeeya Sadas' held by the department as per the directives of Transport Minister K B Ganesh Kumar at Tripunithura on Tuesday. The same was attended by K Babu MLA, Municipal Chairpersons of Tripunithura and Maradu, the Udayamperoor Panchayat President, officials of KSRTC, Police, PWD, NHAI, private bus owners and r e s i d e n t s associations."Basically, we're considering the issuance of permits in

routes where there is no bus service and the ones where permits have been cancelled. The decision from the higher-ups is to allot permits to minibuses as well, given the narrow road stretches in the region. We've received 45 representations in all, having numerous proposals, from private bus owners and other stakeholders," said Tripunithura Joint RTO Abdul Rahman."We'll codify all the proposals and consider the feasibility of the same before forwarding them to the Ernakulam

RTO. The latter will forward them to the transport department, which will again conduct a feasibility study on factors like beneficiaries, type of buses, viability, etc. Finally, an auction will be held for the The residents' associations batted for finalised routes," the official added. There were many proposals for new routes such



as Poothotta-Ameda; Tripunithura Railway Station- Town Bus Stand; Thoppumpady-Kannangad bridge-Kakkanad Civil Station; and Tripunithura-Nettoor (via NH 966 (B) parallel bridge), among others."Permits should be allotted to minibuses in narrow routes where conventional buses cannot be operated. Similarly, several permits in routes such as Udayamperoor-Poothotta were cancelled. The same should be reissued, diverting such services to benefit people in the interior areas. The bus services to destinations like Kumbalam and Cheppanam should be restored," said Tripunithura MLAK Babu.



However, Health Minister C Damodar Rajanarasimha assured them that the new order will not be a disadvantage to Telangana students.On July 19, the department issued GO 33, amending the eligibility criteria for MBBS and Dental admissions. The amended order said the eligibility for the student to get admission under Competent Authority Quota is: "A student must have studied in local educational institutions for at least four consecutive academic years ending with the year they first appeared for or as the case may have first appeared in the relevant qualifying examination". Telangana students argue that this could make those who studied Intermediate outside the state ineligible for admissions, while students from other states who studied in Telangana from Class 9 to Intermediate would be

KTR expresses concern

BRS working president KT Rama Rao expressed concerns about the potential injustice to Telangana students. "The eligibility criteria for nativity fixed by the government is raising several doubts. As Hyderabad has reputed educational institutions, students from other states would come to Hyderabad for studies. With the new guidelines, all of them would become locals and Telangana students, who studied in other states, would become nonlocals," the BRS working president wrote on X.Meanwhile, Rajanarasimha countered these concerns, stating that the previous BRS government's GO 114 on July 5, 2017, had similar provisions and that the Congress government is continuing these rules. He clarified that the new GO 33 aligns with the existing policies and that students who studied four consecutive years in combined AP would be considered locals.Meanwhile, A Sandeep, a student from Mahabubabad district, said there was no issue with the amendment in the NEET admission of 2024-25 and there is no shortfall of MBBS seats. "I am happy to say it's good for the local students. However, if any student moved to another state for Intermediate, it would cause trouble for them," he said.Ch Swathi, a student from Kumurambheem Asifabad district, said: "I completed my school education here and moved to Hyderabad for Intermediate. Both districts are in Telangana, so GO 33 does not affect my NEET admission. I secured an All India Rank 2,40,000 in NEET 2024-25.

Political pressure may be leading to delays in deciding on MLA's disqualification: Telangana HC

HYDERABAD: The Telangana High Court has raised critical questions regarding the prolonged delay in making a decision on disqualification complaints against several MLAs who defected to the Congress.

During a hearing on Tuesday, Advocate General A Sudarshan Reddy faced inquiries from the court on whether a specific deadline has been set up for the Speaker to address these complaints. When the AG responded that the court lacks the jurisdiction to issue directions to the Speaker, Justice B Vijaysen Reddy emphasised the need for timely decisions in such matters. He observed that district courts are frequently given deadlines to complete proceedings and constitutional tribunals should have similar authority to compel the Speaker, who serves asthe chairman of the tribunal, to adhere to deadlines.

Justice Reddy also expressed concern that political pressure might be contributing to the delays in taking a decision, which he deemed unacceptable from an individual who occupies a constitutional position. The court referenced the Supreme Court's decision in Kaisham Meghchandra Singh vs Speaker of Manipur case, where the Speaker was ordered to make a decision within a specified timeframe. However, senior advocate Jandhyala Ravi Shankar contested this point, asserting that the Supreme Court did not establish a fixed deadline for the

Speaker in disqualification petitions. On the other hand, senior lawyer Gandra Mohan Rao argued that the Speaker should indeed be required to make a decision within a stipulated period.

The disqualification petitions were filed by BRS MLAs KP Vivekanand, Padi Kaushik Reddy and BJP's LP Maheshwar Reddy against MLAs Kadiyam Srihari, Tellam Venkata Rao and Danam Nagender.Justice Reddy reiterated the Supreme Court's instruction in a Manipur MLAs case, which mandated a decision within three months. He noted that more than three months had elapsed since these petitions were filed and suggested that the Speaker should be given clear instructions to expedite the decision-making process.

Justice Reddy further highlighted that failing to act promptly undermines the constitutional responsibility of the Speaker and sets a negative precedent. He stated, "Everyone has respect for the Speaker. But it must be assumed that he is not taking the decision due to political pressures. It is not right to sit in a constitutional position and yield to political pressure. If this continues, eve five years will pass without a decision."Following the arguments, the judge adjourned the hearing to Wednesday, granting senior advocates Mayur Reddy and Sriraghuram additional time to prepare their arguments.

'Casting director' promises movie role, dupes girl in Bengaluru

BENGALURU: A 21-year-old girl has lodged a police complaint stating that she was duped of Rs 1.7 lakh by a man who promised to cast her in a Tamil movie. Nanditha K Shetty of Chunchaghatta Main Road, a student of a private college, filed a complaint with the Konanakunte police on August 1. Police said Nanditha saw a Tamil movie advertisement on Instagram and registered her name and mobile number. An unknown person messaged her on WhatsApp introducing himself as Suresh Kumar and claimed to be

a casting director for the Tamil movie 'Hunter'. The accused took an audition online and promised her a role in the film. He told her that she needs to pay for charges such as

Poor condition in Warangal ITI keeps students away

WARANGAL: Students at the state-run Industrial Training Institute (ITI) in Warangal have been avoiding attending classes of late reportedly due to the poor conditions of their classrooms and workshops. In fact, the situation is such that even the faculty is also reluctant to take classes, fearing that the leaking roof may cave in due to rains. Students are calling for better infrastructure and construction of a new building. College convener and principal M Chander told TNIE: "As many as 14 classrooms and five workshops are in a dilapidated condition. We are worried that the equipment and machines could be damaged due to leakage from the ceiling during rains."According to the faculty, funds were sanctioned in 1957 for the college building to come up on a nine acre parcel of land. The institute proposals to authorities concerned for conducting repairs to the college building in 2018 and 2022, nothing was done. In 2018, the School Education

department inspected the college. Rs 80 lakh needed for repairs to ITI

Bengaluru: Indira Canteens will now take digital orders

BENGALURU: Technological interventions in IT hub Bengaluru have enabled the revival of Indira Canteens, which will now take orders just as it's done in private restaurants and food courts -- on digital screens which will be monitored at the head office. However, this idea has not gone down well with citizens and activists, with some even terming it another scam in the making.

While Bruhat Bengaluru Mahanagara Palike (BBMP) claims that of 169 Indira Canteens (IC), 160 are functioning, citizens and activists say the ground reality is different. They point out that many canteens, including those in Nagarbhavi, Bannerghatta Road, Queen's Road, Magadi oad and Jayanagar 7th Block,

are locked. A senior BBMP official told TNIE that tenders will soon be called to digitise the setup in ICs. "There are reports that ICs are not functioning. It could be because of contractor problems, canteen problems, staff issues, few or even missing meals. We need to So we are working on introducing digital screens in ICs, where customers will place orders and they will be noted on the screens. These screens will be linked to the head office and orders will be monitored live. Through this, we will get to know which ones are functioning, where the demand is high, what are the complaints and what citizens feel. Tenders for this will soon be called

Lured into a lifekilling rat race

ENOUGH has already been said and discussed about the tragic death of three IAS aspirants in New Delhi. It is like realising the implications of the all-pervading civil services myth, the agony of the perplexed/exploited generation, the crude business of India's black education system — the demonic coaching industry — and above all, the unholy alliance of the merchants of education and corrupt government functionaries. Imagine the callousness and corruption — a fancy and welladvertised IAS coaching centre running a library in the basement of the building, and feeling quite at ease with this illegal act. Think of the way these aspirants bargain with the gang of brokers/property dealers for finding an accommodation in tiny/dark cells that characterise the lanes and bylanes of Old Rajinder Nagar in Delhi — supposedly the 'sacred' sites for aspiring civil servants. Think of the monsoon malady and the pathetic drainage system in the area. And think of the intense flow of rainwater entering the basement library, and three youngsters dying a terrible death. Everything, it seems, is possible in this soon-to-be Viksit Bharat!Even though I understand the agony of these IAS aspirants, I feel like urging them to go deeper, question the myth that seems to have completely hypnotised them, rethink the meaning of 'success' and their life projects, and reflect on the price they pay - financial, mental and existential — for pursuing a goal that has often been imposed on them. To begin with, they need to understand the shallowness in the arguments they often make: "We want to become civil servants in order to serve the country." Well, IAS/IPS officers do not monopolise patriotism. One who collects the garbage from our houses and keeps the 'gated societies' clean is no less a patriot. Moreover, only a naïve person would say that our bureaucrats are saints and altogether free from the influence of the hugely problematic politics-business nexus.

The IAS myth has such an overwhelming impact on this generation because it promises officially 'legitimised' power and privilege. Anyone who has lived in a small town or village in India knows how the power/aura of the district collector, the superintendent of police, or even the block development officer tempts the aspiring class. For many, it is a path towards upward social mobility. Yes, accept it — it is not essentially the unconditional love for the country, but the 'will to power' and associated privileges that fascinate these youngsters — from engineers and doctors to PhD holders, or from history/anthropology graduates to even political activists. The result is the life-killing rat race. Imagine more than 10 lakh aspirants appearing in the UPSC prelims exam, and eventually 1,000 or a little more getting selected for IAS/IPS and allied services! Yet, the power of the myth is so strong that most of these aspirants try repeatedly, spend a huge amount of money (say, Rs 1.75 lakh only for general studies), end up wasting five or six years of their youthful lives, and eventually carry the stigma of 'failure'. Is it time for these youngsters to come to their senses, and debunk this myth? Think of the intensity of the damage it causes to them. For five/six years, what do they do? They shop around the overpriced coaching centres, and get attracted by the 'star strategists' (I do not regard them as teachers because meaningful teaching has a higher purpose) who instruct them how to prepare for general studies, history, psychology or Hindi literature, or 'motivate' them through their carefully crafted discourses. And from early morning to late night, they keep consuming the 'notes' or 'success manuals' through which the coaching centres colonise their lifeworld. Accept it, dear aspirants: In this highly mechanised and dehumanised process, there is no light, there is no joyful learning, and there is no serious engagement with even the 'skills' a future civil servant needs to cultivate. Possibly, after this tedious journey and endless drilling, most of these aspirants realise the utter meaninglessness of this process. If, for five years, you study history.

Hard questions before Sri Lanka's presidential poll

India has almost 15 million shops. What holds this essential segment back is the lack of broader market access and branding. It's time to think different.

India is a nation of shopkeepers. Today, we boast a total of 14.6 million shops in the country. Look around. Even as you and I step out of our homes, not more than three minutes goes by without passing either a paan shop, a small kirana or daily provisions store, or a large supermarket. Our lives are a clutter of the small shop. We are spoilt bad. For our every need, want, desire and aspiration, there is a store close by. At arm's-length reach. At desire's-length reach even.

Look at it from another perspective. Ho many of us have a shop within us? How many of our close relatives actually run a shop, big or small? The answer is loaded. We have a shopkeeper in our family either in the first, second or third rung of relationships. The shop and its upkeep is therefore within our DNA as Indians in more ways than one. If you don't own a shop, you possibly cater to a shop.

You sell stocks into a shop possibly through a sales and distribution business. And then there is yet another enterprise that intermediates between the manufacturer and the retailer at the street level. Informal numbers indicate the size of this business in sheer number terms to be as large as \$1.3 trillion in 2022 when last audited. Finally, all of us are related to shops in some way or the other. Which one of us has survived without going out to that small little shop to buy a bar of soap, sugar or cigarette?

The shop then is the true-blue representative of early-stage small entrepreneurship. It began with a shop and in many ways it ends with a shop. All entrepreneurships are leverage-businesses to ensure the satiation of man's want and need to buy and use. The most modern apps of today that cater to the needs of a new generation of consumers for both products and services are just this.

The shop began small, went medium-sized, went self-service, grew into a mega-mart, and then disappeared altogether to enter into those very homes that came to the shop in the days gone by through ecommerce. You don't have to go to the shop anymore. Instead, the shop comes to you. In the bargain, instead of you stepping out to buy that loaf of bread from your corner bakery, the bread came home, driven in on an outsourced e-bike, brought in by an outsourced delivery boy and paid for on an e-payment gateway. The shop in many cases is no more. Long live the shop. The shop is on the cloud. Long live the cloud. Interestingly, this very kirana

shop of yours is possibly selling more in the delivery-format than the in-shop format. Life has changed. Business has. This nation of shopkeepers of ours is therefore best poised to do business, more than any other. Yes, we are a nation of tech people today. But that's a total of 5.4 million people. We are a nation of doctors too, with 13.08 lakh allopathic ones registered with the National Medical Commission as on June 22. We are a nation of engineers, of teachers. But then, in sheer terms of numbers, exposure, relationships and the DNA of business intent, we are essentially a nation of shopkeepers. The agenda of the shopkeeper is therefore the biggest agenda we need to focus on. We



must plan for the future of the shopkeeper. What does the shopkeeper do next? Where is he stuck today? In the beginning he was small. Then big. And now bigger still in the virtual format. The shopkeeper reaches out to the rest of the world, which was hitherto inaccessible. Business today comes from all over. The humble Indian broomstick finds its way into Walmart across its stores in the US, just as Indian firewood finds its way into an ASDA in the UK. The most rustic offerings from India find value-added homes in the best of Western supermarkets. India is a supply waiting to feed the demand of the world. And the supply chain to facilitate this is that much more in a flux than ever before. Herein lies the story of the future, as it should unfold. Today's story of Indian exports into a global market is rather lopsided. If one examines Indian export earnings, we still earn from the core category of commodity, as opposed to the higher-end category of product and brand. Our top five exports are leather and its products, petroleum products, gems and

jewellery, auto, equipment parts and electronic goods, and pharmaceutical products.

When the product pipeline seems to dry up, we move into services (the best being IT services of value \$193 billion in 2022). The worst of the lot is the agriculture pipeline. We still do live out a life-script carved out for us by the British, as exporters of the basic commodity that markets of the West need and want. The business of India happens not only from and through the big conglomerates and business houses that dominate our imagination by the very fact that they are in the news all the time. The business of India resides in its small towns and villages. India today boasts of a population of 63.4

million medium, small and micro enterprises. As the Union Budget 2024 just unveiled by Finance Minister Nirmala Sitharaman brings the MSME category into focus, we need to understand very simply that we are all shopkeepers. We are medium, small and micro shops. Some of our shops sell 'kirana', and some sell services such as healthcare and beauty. Some of our shops manufacture small tools that go as components in bigger manufacture. Some of us offer intermediary services in consulting, tax, audit and more. The net of it is that we are all about the shop and the shopkeeper in us.My study of the MSME sector in India, across eight regions

(concluded in March 2024) indicates just two primary gaps that keep our 63.4 million MSMEs down. The first is the fact that we have no access to the expanded markets of today. Our distribution does not tap into the e-format in B2B and B2C marketing equally, where the world is really our oyster. Our goto market strategy thinks small, medium and micro. Never massive. The second lag and gap is branding. We do not believe enough in it. As the world of consumption across 126 countries swears by the branded offering, we are still content being in the space that is a basic commodity. The MSME sector in India needs to sit up and smell the opportunity. The world is indeed my oyster today. I need to invest in both the e-format of reaching out to markets as well as prudent investments into the subject of building relevant, original and innovative brands for the world at large. I am a shopkeeper for sure. I need to think like an e-shopkeeper now. I need to think like the branded shopkeeper.

fighters who won independence for Bangladesh in 1971. The next government in Bangladesh will have to address the burning issues of high youth unemployment, economic stagnation and inflation. New Delhi, which enjoyed good ties with Hasina-ruled Dhaka, will have to recalibrate its strategy in view of the colossal churn in the neighbouring country. With the return of Pakistanaligned BNP and Jamaat-e-Islami imminent, India needs to be wary of adverse headwinds in the

Railways' race against time

The prime minister has promised Indians at home and abroad that he will not rest till the country becomes the third largest economy, after the US and China. The average Indian railway commuter must wonder what this means for her.Last week, I travelled overnight by train from Bengaluru to Ernakulam. Little seems to have changed. The air conditioning was as cold as a morgue. A complaint was raised. The attendant obliged. Soon it was as hot as an oven. The black blanket smelled of others' sleep; the little white pillows had on them sepia maps of strangers' nightmares. The washroom taps did not work, the door bolts were not aligned, and, in the vestibules passengers hopeful of a miraculous berth squatted by their dozens. The Indian train, despite the efficientlyrun Vande Bharat and others such, continues to be an arbitrary, uncertain, olfactory experience for most of the 23 million daily passengers.

My journey was behind schedule. But it did not kill or hurt, a probable outcome of buying a railway ticket. Last month, at least 10 passengers were killed and more than 50 injured because of track misalignment due to 'maintenance work'. In the last five years, there have been many accidents. In June 2023, in the Coromandel Express collision in Odisha, at least 293 people were killed and over 1,100 were injured. The causes were couched in bureaucratese: 'signalling errors and lack of real-time communication'. The year before, the major accident that occurred was the Bikaner-Guwahati Express derailment at Jalpaiguri, West Bengal: 9 killed, 45 injured. Track fracture was blamed. In 2021, it was the Doda train collision in Jammu: 20 killed, 70 injured, owing to 'signalling failure'. None of this makes much sense because the technology we have is capable of detecting the problems and sending the information to the right people. Dead passengers receive a compensation of Rs 5 lakh. The 'seriously injured' get Rs 50,000. What's Rs 5 lakh to the spouse and children of the



deceased, who, in most cases, are the main earning members? If you lose an arm, leg, or eye, what would Rs 50,000 do for you? The meanness of the compensation is an indication of how little value India attaches to Indian life. As a nation with just too many humans, we naturally prefer to know more about feasts than funerals. We know everything about the Anant Ambani wedding, for example. The estimated budget of Rs 5,000 crore, to begin with. The VIP list of invitees. The warmth of million-dollar hugs between total strangers in golden gowns. But we do not know, or cannot recall, the name or face of a single railway passenger who bought his ticket

for his/her final ride. Surely a death that they are not responsible for must rate a higher monetary value than the Rs 2 crore watches that Bollywood stars got for attending a wedding?

Almost every other year, India witnesses a railway accident. But there has been no sustained discussion about the nature of the accidents, compensation or safety. The last white paper on the railways was in 2009. Neither the treasury benches nor the opposition has followed up on the seemingly permanent backwardness of the railways. How odd it is to talk about sending a rocket to land on the moon at a precise spot, and the country's inability to warn one

train that another is coming at it from the opposite direction on the same track, though the same satellite information systems are at work. These systems can sense oncoming trains and alert the pilots and control centres almost instantly.

Yet, rail travel is a bit like a war to the average Indian. If the same rate of accidents was applied to air travel, there would be hell to pay. Recently, when the Delhi airport roof began leaking, it made headlines in every newspaper. Almost every railway station, used by the poorer classes a million times more, is in much worse shape—and yet, it is seen as pretty much all right.

The present minister has done a lot, introducing new high-speed trains and modernising the railways. Among the safety measures he has introduced is the Kavach, a train collision avoidance system named with a mythological allusion. This too involves satellite communication in part, we are told. None of this is cutting-edge technology. All of it has been there for scores of years. It is that we are way behind. It is that despite our ambition—Bovarian in its delusions of grandeur—to become a superpower or the third largest economy, we do not attach importance to the individual or try hard to make his or her life a little easier. In government offices, ration shops and even splendidly garish public toilets, the guiding sentiment is that the individual consumer is a subject receiving a favour. The railways itself affords a prime example of this almost philosophical disposition. How else can one explain the Mumbai local trains, which feel like travelling concentration camps, transporting 7.5 million commuters daily when they should be carrying less than half that number? There are changes in Mumbai's daily commuting, of course. The metro, for example—but it is about 50 years late in making its entry.

Clearly, the problem with the railways is the same as most of its trains: it is racing against time, and constantly falling behind.

Engelberg

A quiet resort in the heart of Switzerland, Engelberg is a paradise for ski lovers and an ideal destination for those looking for some peace and serenity. Located around 25 km from Lake Lucerne, this rustic retreat is perched at a height of 1000 m and is home to a striking 12th century Benedictine Monastery.

The hotels and homes of the locals are strongly reminiscent of the Belle Epoque period and travellers often feel like they have gone back in time. Towering above its story-book townscape, Mount Titlis and its glacier seems to be within arm's reach and the Hahnen mountain is almost tangible. While the winters are all about snowboarding and sledding at a dizzying altitude of 2000 m, the summer months in Engelberg entail hiking, golfing and biking around its verdant pastures. In fact, the town hosts an annual Ski Jumping World Cup that attracts adventure-sports enthusiasts from all over the

A part of the Canton of Obwalden, Engelberg has a tiny population of 4000 and also includes the hamlets of Obermatt, Schwand and Grafenort. The resort is merely 45 min from Lucerne by a direct train (Luzern-Engelberg Express) along the Zentralbahn. For those who do not own a Swiss Pass, tickets should cost around 20 Euros. Think of Engelberg as a side journey and stay for a day or two in order to make the most of its delights.

Stanserhorn

Perched at 1898 m, Mount Stanserhorn is all about breathing in fresh Alpine air and soaking in the views of green valleys, blue skies and emerald lakes that include the Bernese Alps, Mount Pilatus and Lake Lucerne. Accessed by virtue of an aerial Cabrio cableway that comes with an open-air deck, the journey to the summit is the drawcard of Stanserhorn.

In fact, open roof wooden coaches have been transporting travellers to the top ever since the 19th century. Don't be surprised if R Kelly's 'I believe I can fly' plays in your head on an endless loop as you make your ascent.

The circular walk of Stanserhorn looks eerily futuristic, while the gifts of nature stand elegantly in the background-a noteworthy juxtaposition. Apart from magnificent vistas, the peak has a revolving restaurant by the name of 'Rondorama' that serves excellent Swiss cuisine.

The journey from Lucerne to Stanserhorn merely takes 40 min. You would first have to take a train to the town of Stans followed by a 5 min walk to the Valley Station to hop aboard the funicular to Kälti which is the boarding point for the Cabrio ride. This cableway is operational during the summer months of April and November. Try buying the 'Good Morning Ticket' as it is a lot cheaper and check the weather forecast before planning your day trip.

Things to do in Pokhara for all kind of visitors



Pokhara is a wonderful and scenic city and a major city in Nepal after capital Kathmandu. This has made this city a tourist favourite and a hub for both group vacationers and backpackers. There are plenty of sightseeing options in Pokhara and you can spend a good amount of time exploring them. Introduced midyear in 2014, bungee jumping in Pokhara has been attracting travellers and adventure junkies alike. Only the second bungee spot in the country of Nepal, Pokhara will always be a memorable mark in your adventure diary. The usual plunge is of around 70 metres with a water body underneath. Trained professionals will guide you through the dos and don'ts of the jump and will harness you well for the maximum safety measures.

Paragliding

Paragliding has to be one of the most common and easily accessible adventure sport in Pokhara. Many also hold that Pokhara is in fact one of the best paragliding destinations of Asia! There are several paragliding schools here from where you can go for a memorable flight across the skyline of Pokhara. The vast open space and lack of high rises offer the ideal background for an unhindered glide as you fly over the lush green hills and blue water lakes with the stunning Annapurna Mountains in the backdrop.

Cycling

Cycling is both a leisure activity and a common yet important fitness aspect. Some cycle to cut through pensive moments, some to avoid the rush and some to push their physical limits.

Well, Pokhara caters to all the above mentioned kinds of cycling enthusiasts. Leisure seekers can go for a cycling day out in the Lakeside region along the shore of Phewa Lake's north eastern side. This will help explore the city from a close corner and minus the conveyance hassles. Adventure lovers or the ones who are regular cyclists will also like to take a cycling trip down the lush green valleys passing through tiny hamlets and temples.

Heritage trail

Pokhara is an ancient and significant urban establishment of Nepal which is trying hard to hold on to its old world remnants. This opens up the opportunity for an amazing heritage trail in the city. The Old Town of Pokhara is the ideal place to kick off your culture trip. Located north of the buzzing Mahendra Pul, the Old Town is a treat for the ones who love to get the pulse of a new place from its epicentre. Best explored on foot, Old Town Pokhara offers an unmatched view of the new parts of the city in the morning before the traffic and daily chores take over the landscape. One will find several hotels and restaurants here along with lines of shops and stalls selling takeaway style items. A stark contrast to the commercial Lakeside market is the Old Bazaar where time seems to be taking a slower route. Give Timeframe By Aug 27 For Survey On Reservations In Local Body Polls: High Court To Telangana Government

HYDERABAD: The Telangana High Court has directed the state government to inform it by August 27 of the time it needed for conducting a survey to come out with recommendations on reservations for BCs and other categories in local body elections. A bench of Chief Justice Alok Aradhe and Justice J Sreenivas was hearing a bunch of petitions seeking implementation of reservations for BCs category wise in local body elections, including in Greater Hyderabad Municipal Corporation. The bench referred to the Supreme Court's earlier direction that states should first set up a dedicated commission to conduct a "contemporaneous empirical survey" to collect data of various categories of BCs by the panel before earmarking reservations. The petitioners challenged the powers given by the BC Finance Corporation to collect the empirical data of BC, saying that cannot be done by a corporation and needs a dedicated commission to do it.

In 2021, the Telangana government designated the existing BC Commission as "Dedicated Commission" and vested powers in it to conduct the empirical survey, BC Commission sources said. The petitioners contended that the election notification for local bodies should be issued only after the survey is done. The high court's directive came on a petition filed by BRS leader Sravan Dasoju, who among others sought a direction to the Telangana government, the state election commission and other respondents to forthwith undertake the exercise. Puja Khedkar Case: UPSC Says 'Fake' IAS To Get Candidature Cancellation Copy Within Two Days

NEW DELHI: The Union Public Service Commission (UPSC) informed the Delhi High Court on Wednesday that it will communicate within two days its order cancelling former probationary Indian Administrative Service (IAS) officer Puja Khedkar's candidature to her. Noting the submissions of UPSC, Justice Jyoti Singh disposed of Khedkar's plea challenging the Commission's press release stating that her candidature has been dismissed.

The petition is disposed of granting liberty to the petitioner to approach the appropriate forum in accordance with law. It is made clear that this court has neither entered into nor expressed any opinion on the merits of the case and the filing of the present petition will not come in the way of the appropriate forum in adjudicating the issue on merits," the court said.

The court asked Khedkar to give her address to the UPSC, and said the order be supplied to her physically and electronically. It also said that for other reliefs like challenge to the cancellation order, Khedkar will have to go to the Central Administrative Tribunal (CAT). During the hearing, senior advocate Indira Jaising, appearing for Khedkar, said the cancellation order was never communicated to her and she came to know about it only through the press release.

On being asked by the court as to why she has not approached CAT with her challenge, Khedkar's lawyer said since she was not served with the official order by UPSC, the plea was moved before the high court impugning the press release. Senior advocate Naresh Kaushik, representing UPSC, said the order will be communicated by the Commission to Khedkar within two days on her email id as well as her last known address.

On July 31, the UPSC cancelled Khedkar's candidature and debarred her from future exams. She was accused of 'misrepresenting information' in her application for the UPSC Civil Services Examination, 2022. Khedkar was also accused of cheating and wrongly availing of OBC and disability quota benefits. On August 1, a trial court here had denied her anticipatory bail, saying these are serious allegations that "require a thorough investigation".

However, all diplomats remain in Bangladesh and the missions are functional, sources said. Sources said around 20-30 senior staff are left at the High Commission in Dhaka. Apart from the High Commission in Dhaka, India has assistant high commissions or consulates in Chittagong, Rajshahi, Khulna and Sylhet.On Tuesday, External Affairs Ministr S Jaishankar said around 10,000 Indians were presently residing in Bangladesh and the government was in "close and continuous" touch with the community through its diplomatic

The situation in Bangladesh is still evolving... We are



in close and continuous touch with Indians in Bangladesh through our diplomatic community," Jaishankar said in Parliament. Addressing MPs in Parliament during an all-party meeting, Jaishankar said the situation in Bangladesh was not that alarming to require the evacuation of the 10,000 Indians in the violence-hit country.

Of particular concern for India has been the attack on houses and temples of the Hindus in Bangladesh. With an interim government still to be formed, widespread vandalism and looting of homes have been reported. The interim government will be headed by Nobel laureate Muhammad Yunus.

The neighbouring country plunged into chaos after a controversial quota system for government jobs saw massive street protests and violence, leaving over 400 dead and hundreds more injured. On Monday, Sheikh Hasina quit as prime minister and fled to India as protesters stormed her residence and vandalised it. After her departure, the Awami League's main office was set on fire and several leaders were targeted by the protesters. Around 20 bodies of Awami League leaders have reportedly been found across Bangladesh.

Supreme Court's Stern Reprimand For Judge Who Criticised Its Order

New Delhi: The Supreme Court on Wednesday responded firmly to a challenge to its authority - stressing that compliance with its orders is "not a matter of choice" - and expunged critical remarks made by a single-judge bench of the Punjab and Haryana High Court last month regarding a land dispute case. The judge had reacted sharply to a May 3 order staying certain contempt proceedings.Chief Justice DY Chandrachudcalled the criticism "unnecessary" and said it lowered the dignity of both courts. "A party may be dissatisfied with a decision... but judges can never express dissatisfaction over the order passed by a higher constitutional forum," the Chief Justice declared.

A five-judge bench of the Chief Justice and Justice Sanjiv Khanna, BR Gavai, Surya Kant, and Hrishikesh Roy was responding suo moto to the judge's comment, and called it a "matter of grave concern". The bench also warned the judge - Justice Rajbir Sehrawat - who made the remark, saying it expected



restraint while commenting on orders passed by the Supreme Court.

"Justice Sehrawat made observations in regard to the Supreme Court of India, which are a matter of grave concern... judicial discipline in the context of the hierarchical nature of the system is intended to preserve the dignity of all institutions, whether a district or a High Court, or the Supreme Court.""The observations made... were unnecessary for the ultimate order which was passed.

Gratuitous observations in regard to previous orders passed by Supreme Court are absolutely unwarranted."

he Supreme Court underlined that compliance with its orders is not "a matter of choice but a matter of constitutional obligation". "Parties may be aggrieved by an order... but judges are never aggrieved by an order passed by a higher constitutional forum," the Chief Justice-led bench. The top court, however, declined to initiate contempt proceedings of its own against the judge, particularly since a Division Bench had acted first and stayed Justice Sehrawat's order. The court did, though, express hope that judges of other courts would learn from this episode and be cautious while commenting on orders passed by the country's foremost legal forum. The matter broke after a video of the judge making his observations went viral. Solicitor General Tushar Mehta suggested the video "makes (for) a case of aggravated contempt" against the There are more than one billion tourists in the world, but some destinations don't get quite as many visitors as you would expect.

The beaches may be beautiful and the coastline inviting, but you can understand why Tuvalu doesn't get much through-traffic. It's tiny for a start; one of the smallest nations in the world, and not much bigger than Vatican City. It's also about as far from the beaten track as possible—right out in the middle of the South Pacific.

So the 1,200 international arrivals recorded there in 2011-according to the World Bank-had to make quite an effort. It had the least number of recorded visitors for all countries where data was available (and no, there were no figures for North Korea). Incidentally, if you are curious about Tuvalu, the official tourism website is surprisingly enticing.

Low tourism to other nations is less easy to explain. Here we round up some of the places where visitor numbers are surprisingly low.

Ten countries that deserve more lourists



India

The world's most populous democracy ought to be a huge hitter when it comes to tourism. Right in the centre of Asia, with strong historical links to Britain, it has some amazing attractions, from the Taj Mahal to tigers. But

with less than seven million foreign arrivals last year, it is hardly setting the world alight with its visitor numbers. To put that into context, that's less than a third of Thailand's 22.4m during the same year.

Why are numbers low?

The difficult visa process is one problem—one that tourist

authorities are apparently trying to address, with a drive to reduce bureaucracy. The recent spate of bad publicity about attitudes towards women-including some recent attacks on tourists-has also done little to boost the country's

Once upon a time it was, but visitor numbers have declined in recent years-it now registers around 1.8m visitors (compared to South Africa's 9.2m), and many more head to the mighty Victoria Falls from the Zambian side nowadays.

Why are numbers low? Robert Mugabe.

Bosnia and Herzegovina

At the intersection of two great empires-the Austro-Hungarian and the Ottoman-this region has huge historic appeal, perhaps most notably in its capital city, Sarajevo. With its rivers and mountains, it is also being touted as a future adventure capital of Eastern Europe. Yet, of all the

belonging to the former Yugoslavia, only Croatia has been a true success with its tourist industry (10.4m in 2012), with only 439,000 going to Bosnia and Herzegovina in the same year.



Why are numbers low?

The shadow of the Balkans conflict has been hard to shake-and it lacks the magnificent coastline of Croatia, for example. There are also currently no direct flights from Britain either.

A glorious archipelago with miles and miles of pristine The Philippines beaches, the Philippines certainly look enticing. On an unscientific level, news that the Philippines featured in Telegraph's 20 places to visit in 2014 was greeted enthusiastically and retweeted widely on social networks. Yet the number of visitors was only just above four million in 2012. It's a shortfall that's recognised within the country's own borders, with tourism officials aiming for more than 10m visitors in 2016. Why are numbers Political instability bedevilled the country for many years, and natural disasters certainly have not helped, Typhoon Haiyan being a recent, tragic example. Despite those images of devastation, most of the country remains open for business, as explained here.

Bhu<u>tan</u>

This landlocked country in South Asia is a beautiful, mountainous nation. With a strongly Buddhist culture, wonderful treks, remote forests and Himalayan kingdoms, there is a wealth of visitor attractions-yet there were only around 44,000 to appreciate them in 2012.

Why are numbers low?

This is the country's own choice. Bhutan has long limited tourists: visitors have to pay a tariff of \$250 a day to enter, a fee that immediately excludes many of the backpackers that head to Thailand.

New Zealand With The Lord of the Rings and The Hobbit offering a

giant marketing boost over the last few years, the number of tourists to this beautiful country is on the increase. But at just over 2.5m international arrivals at the last full count, it is still a long way behind Australia, its neighbour across the Tasman-it has only slightly more than a third of the visitors.

It's a very long way away from almost everywhere, with a much smaller population than Australia (and hence fewer European relatives to visit). Australia also has more flight connections, and a reputation for its

High prices are probably the main reason-although with the devalued yen, that is less of a problem than it used to be. The country's cultural complexity could be another-perhaps the writing and language are viewed as obstacles by novices. The 2020 Olympics could provide a boost, however.



Brazil

It may be the most visited country in South America, but that continent as a whole remains relatively unexplored. For a country with such a reputation for its beaches, natural assets and football culture, Brazil is arguably still not punching its full weight. It's comfortably the biggest economy in the region, and its attractions vary from the beaches of Salvador, Rio's Carnival to the remote flora and fauna of the Amazon.

Why are numbers low?

5.7 million visitors isn't that bad, you might argue, considering the country is hardly positioned at the world's crossroads. But then, Australia gets more than six million, and it is further away from both Europe and the USA. Bolivia and Peru are two other countries where the visitor numbers don't seem to match the attractions on offer.

Ola Electric IPO subscribed 4.26 times on final day of bidding

NEW DELHI. The much-anticipated initial public offering (IPO) of Ola Electric was subscribed 4.26 times on the final day of bidding, receiving bids for 198.16 crore equity shares against 46.52 crore on offer. The low subscription level came despite the leading electric two-wheeler company's valuation eased to about \$4 billion ahead of the Rs 6,145 crore IPO.

Categories-wise, the heavy lifting was done by qualified institutional buyers (QIBs) and retail investors as their portion was subscribed 5.31 times and 3.86 times the allotted quota, respectively. The non-institutional investors (high networth individuals) bid 2.39 times the portion set aside for them. The portion set aside for employees was subscribed 11.66 times against the reserved portion. Owing to low enthusiasm and rising volatility in the broader market, the grey market premium (GMP) of Ola Electric has fallen sharply in recent times, indicating a not-so-buoyant listing gain. Last checked, Ola Electric was commanding no premium in the unofficial market.

Brokerage firms and analysts too have mixed views on the IPO as they expect Ola Electric to incur losses. They are also not satisfied with the \$4 billion valuation. The Bengaluru-based reported a net loss of Rs 1,584.40 crore with a revenue of Rs 5,243.27 crore for the financial year ended on March 31, 2024.

Ola Electric is demanding an EV/sales multiple of 6.3 times, which is at a significant premium, said Choice Broking in a note. It added that key concern for the company is its reliance on government subsidies for generating sales and its loss-making operations.

New Delhi. Finance Minister Nirmala Sitharama introduced a new regime for the long term capital gains (LTCG) in

The long term capital gains (LTCG) tax was raised from 10% to 12.5%, and the Short Term Capital Gains (STCG) tax on certain assets were increased from 15% to 20%."Short term gains on certain financial assets shall henceforth attract a tax rate of 20%, while that on all other financial assets and all non-financial assets shall continue to attract the applicable tax rate," Nirmala Sitharaman said durig the Budget presentation. The Finance Minister shared the reason

behind it and said, "We wanted to simplify the approach to taxation, also for the capital gains. Second, if anything, the average taxation actual has come down. When we say it is 12.5%, because we have worked out for each of the different classes. But the point is that we have brought it down from below average to 12.5%, which is the lowest if you look at several years, encourages investment in the market," said Sitharaman.

Ukrainian wrestler and member of parliament has a goal for Paris: 'Show that Ukraine is still alive'

PARIS: Zhan Beleniuk's focus wavered at times as he trained in hopes of winning a second Olympic gold medal in Greco-Roman wrestling. The Ukrainian doesn't just represent his country in international competition. He's a member of parliament. And since Russia invaded Ukraine in 2022, well, it's been easy for his mind to drift.

'It's difficult because you are thinking about your safety, the safety of your relatives, your friends," Beleniuk said. "And you know, it's friends," Beleniuk said. "And you know, it's not comfortable training when some missiles are flying about your head. That's why it's difficult, it's dangerous. But it's our reality." Beleniuk, 33, said his team mostly trained in Ukraine before the Games, but it spent more time outside the country than usual, including places such as Croatia and Poland. India lost Olympic gold: Nishant Dev unhappy with quarter-final result in Paris

the judges was different and I was not at all happy with their decision," Nishant told ANI.ishant's loss did not sit well with a certain section of users on social media as they claimed the umpiring was unfair and that India was "robbed-of" a medal. Nishant won the first round 4-1, and looked in complete control of the bout in the second round as well, where he landed a streak of massive jab hooks on the Mexican, yet the judges surprisingly sided with Alvarez in that round, putting him 3-2 ahead in the tie. The Indian boxer, who had defeated his

Mexican counterpart earlier, lost the last round as well.

Nishant was aiming for gold

Nishant seemed dejected as he felt that 15 years of his blood, sweat and tears had come to a disappointing end."And I just don't have anything to say because the years of hard work that I had put in morning, evening, day and night for this Olympics, my boxing training of the last fifteen years, have seen it coming to a disappointing end here today. But it doesn't matter, the sadness inside me says that in the coming Olympics, such a

thing should not happen to any athlete. Unless you are an athlete, no one can understand how much sorrow and pain you have inside you.""IOC should look at poor judging decisions"Nishant wanted the International Olympic Committee to intervene and look into the judging decisions."I would like the Olympics and the IOC to look at these poor judging decisions and take some action against them. First of all, I don't understand that if there are five judges. They are giving the decision and the first thing is that the boxer can do whatever he wants, the decision is in the hands of the referees and earlier the scoring was good given this time the scoring is disappointing."It is not known which athlete is winning, still these people do it in favor of the other opponent.If there is a judging scoring system of five-zero and a blue corner is winning a one-sided fight and it is still in its favor. One is coming and four are those who are going in favor of the red corner."Nishant was India's last hope for a boxing medal in men's category, but he suffered an agonizing loss."So I want ask, what is lacking in that judge that he is not able to see why he has been given each scoring, rather he was dominating the entire round, so I would like to know that.

Despite the best efforts of Vinesh, her coaches, and support staff, which included extreme measures like cutting her hair and trying to draw out blood, they could not achieve the desired results.

Prime Minister Narendra Modi spoke with IOA President P.T. Usha to get firsthand information on the issue and explore any options available to India following Vinesh's setback. According to UWW rules, "If an athlete does not attend or fails the weigh-in, he/she will be eliminated from the competition and ranked last without rank."Vinesh is the first athlete to be disqualified from her final for not making weight. She made history on Tuesday, August 6, 2024, by becoming the first Indian woman wrestler to reach the Olympic final after defeating Cuba's Yusneylis Guzman 5-0, thereby assuring a medal for India. "It is with regret that the Indian contingent shares news of the disqualification of Vinesh Phogat from the Women's Wrestling 50kg class. Despite the best efforts by the team through the night, she weighed in a few grams over 50kg this morning. No further comments will be made by the contingent at this time. The Indian team requests respect for Vinesh's privacy and would like to focus on the ongoing competitions," the Indian Olympic Association said in a statement.

Both Vinesh and Sakshi Malik have been prominent faces in the wrestlers' protest against alleged sexual harassment by the former Wrestling Federation of India leadership. Vinesh, who usually competed in the 53kg category, had to switch to the 50kg category to ensure her qualification for the Olympics."I will have to manage my weight a lot better. I have brought myself down to 50kg after so long, so I will try and maintain this as much as I can. It's not easy for me not to put on weight because my muscle mass is very high," Vinesh told PTI in April after securing the 50kg quota for India. Vinesh had previously faced heartbreaks at the Rio Olympics and Tokyo Games, where she was eliminated early despite being a

UPDATED. Vinesh Phogat fainted and had to be hospitalised due to dehydration at the Paris Olympics 2024. The 29-year-old Indian wrestler was disqualified from the

50kg freestyle final at the Olympic Games. Vinesh was found over-weighed by 150 grams during the weigh-ins and that led to her disqualification. It was learnt that Vinesh was found 2kg over-weight on the eve of her gold medal clash against the USA's Sarah Hildebrandt.Vinesh Phogat was determined and undeterred as she worked out the whole night to shed weight. She did skipping,

jogging, cycling and everything in her potential to lose 1.85kgs. Eventually, she fell short by just 150 grams, which led to a heartbreaking disqualification from the final round. The Indian wrestler worked out all night to shed those extra kilos, showcasing her determination towards bringing India Olympic glory. However, all this was not enough for her to be able to compete in a gold medal match. Phogat contested in the 53kg



category in the last two Olympics, in 2016 and 2020, which is her usual category. She had to shed her weight from 53kgs to 50kgs to participate in the Paris Olympics 2024. Debutant Antim Panghal had qualified in the 53kg category and that led to Vinesh Phogat cutting down her weight to book Olympic berth. Vinesh entered the contest unseeded

in the category and registered three emphatic wins on August 6, Tuesday to seal an Olympic medal for India.

Why was Vinesh Phogat disqualified: Weigh-in rules explained

Vinesh disqualified from the Olympic final matchAccording to the rules, wrestlers must weigh in twice: once on the morning of the preliminary rounds and again on the morning of the final. On Tuesday morning, Vinesh was within the permissible 50kg limit. However, her weight likely increased

throughout the day as she replenished herself after three bouts.

It is understood that she needed to lose about 2kg overnight. Vinesh was seen skipping in a sweatsuit last evening after her semifinal bout and reportedly worked on losing weight
