#### Former IAS probationer Puja Khedkar moves Delhi HC

New Delhi, August 8: Former IAS probationer Puja Khedkar, who has been accused of cheating and wrongly securing OBC and disability quota benefits, on Thursday approached the Delhi High Court seeking anticipatory bail in the criminal case against her. Her plea for pre-arrest bail is hearing before Justice scheduled for



Subramonium Prasad on Friday. Khedkar allegedly misrepresented information in her application for the UPSC Civil Services Examination, 2022, to get reservation benefits. On August 1, a sessions court here had denied anticipatory bail to her and said there are serious allegations against her which "require a thorough investigation". Khedkar, who has not been arrested in the case, had approached the sessions court, saying she faces "immediate threat of arrest". "Custodial interrogation of the accused is required to unearth the whole conspiracy and to establish involvement of the other persons involved in conspiracy," the sessions court had said, adding that the case is "only the tip of the iceberg". The judge had directed the Delhi Police to conduct its investigation "in all fairness" to find out candidates recommended in the recent past who might have illegally availed of such benefits, and whether some insider from the UPSC also helped Khedkar. In response to Khedkar's claim of having been falsely implicated in the case and being a victim of media trial and witch-hunt, the sessions court had said the argument was not tenable because there were sufficient incriminating material on record. "The conspiracy has been hatched in a pre-planned manner. The conspiracy was executed by the accused in many years. The accused alone could not have executed the conspiracy without the assistance of some outsider or insider," it had said.

#### Punjab and Haryana High Court upholds Agniveer's discharge

Chandigarh, August 8: The Punjab and Haryana decision to invalidate an Agniveer out of service within three months of the training due to a pre-existing medical condition. The Bench of Justice Sudhir Singh and Justice Karamjit Singh also dismissed the Agniveer's claim for compensation under the Agnipath scheme. Gourav had moved the high court seeking the quashing the order dated April 25 passed by the Armed Forces Tribunal, whereby his plea against the decision was dismissed. The Bench during the course of hearing was told that the petitioner was invalided from service on May 16, 2023, after he was found unfit for service due to a scar on his left leg. The surgical specialist was of the opinion that the scar

being "hypertrophic" in nature might break down during hard training and in hot and humid climate. The Bench asserted the chronological order of the facts would show that the petitioner was put through a proper procedure to assess the disability suffered by him. It was the petitioner's admitted case that he was having a scar on his left leg prior to his recruitment as Agniveer. It was noticed in the clinical assessment that the petitioner had revealed sustaining injury to the left leg five years back, when he hit a wall's corner accidentally and resulting wound was managed conservatively. The primary medical examination report at the time of the recruitment was not final. He was initially admitted to a medical hospital for provisional diagnosis after he reported for the military duties.


New Delhi, August 8: The Waqf (Amendment) Bill was introduced in Lok Sabha on Thursday and referred to a joint parliamentary panel after a heated debate, with the government asserting the proposed law did not intend to interfere with the functioning of mosques and the Opposition calling it targeting of Muslims and an attack on the Constitution. Lok Sabha Speaker Om Birla said he will talk with leaders of all parties for constituting the joint parliamentary committee. Soon after Union Minority Affairs Minister Kiren Rijiju sought leave to introduce the Bill, opposition INDIA bloc MPs strongly protested the introduction of the Waqf (Amendment) Bill, calling it an "attack" on the Constitution and aimed at targeting Muslims. New Delhi, August 8: The democratic representation and decision-making powers of the Ladakh Autonomous Hill Development Councils (LAHDCs) have been retained following the formation of the Union Territory of Ladakh in 2019, the government informed Parliament on Thursday. However, in the 1995 Wakf Act, there are provisions that are above the provisions in the Constitution. Shouldn't that be changed?"





### wrestling career, saying that she doesn't Muhammad Yunus takes oath as head of Bangladesh's interim government

Dhaka, August 8: Nobel laureate Muhammad Yunus on Thursday took oath as the head of an interim government, replacing Sheikh Hasina who abruptly resigned and fled to India leaving the country in turmoil following deadly protests against her government over a controversial quota system in jobs. Yunus, 84, was administered the oath of office by President Mohammed Shahabuddin at a ceremony at the presidential palace 'Bangabhaban'. A 16-member council of advisers was announced to assist Yunus in running the state's affairs. Md. Nahid Islam and Asif Mahmud, two key organisers of the Anti-Discrimination Student Movement, were also part of the advisory council. Women's rights activist Farida Akhtar, right-wing party Hefazat-e-Islam's deputy chief AFM Khalid Hossain, Grameen Telecom trustee Nurjahan Begum, freedom fighter

Yunus, who was in Paris for the Olympic Games, returned to the country via Dubai on Thursday on an Emirates flight. Army chief General Waker-Uz-Zaman, senior officials, student leaders and civil society members welcomed him at the airport. "Today is a day of our pride," he said at an emotional press conference at Dhaka's Hazrat Shahjalal International Airport after his arrival. "We have got independence for the second time. We have to protect this independence." He

expressed gratitude to the youth who made the protest movement against Hasina successful and said he would like to stress first to "save the country from violence so that we can move forward on the path that the students have shown us." He urged people from all walks of life to listen to him and said he agreed to take charge of the interim administration responding to the call of the students and youths. "If you have faith in me and trust me, then ensure that there will be no attack anywhere in the country. This is our first responsibility," he said at the crowded press briefing. "If I can't do it and you do not listen to me, I don't have any utility here." He termed the anarchic activities and attacks on minority communities as "part of a conspiracy". "We have to form a government which assures safety to its citizens," he said. Yunus said the country was now in the hands of the young people. "The nation is in your hands now. Now you have to rebuild it as

## Parties demand immediate Assembly polls in J-K during meeting with Election Commission in Srinagar

Srinagar, August 8: Immediate Assembly polls in Jammu and Kashmir was the dominant demand of all political leaders from the Union Territory who met the visiting Election Commission (EC) team here on Thursday. The team led by Chief Election Commissioner Rajiv Kumar arrived here in the morning and met with representatives of registered political parties, including the National Conference (NC), the People's Democratic Party (PDP), the Bharatiya Janata Party (BJP), the Congress and the Jammu and Kashmir Panthers Party (JKPP), at the Sher-i-Kashmir International Convention Centre (SKICC). The EC delegation also comprising election commissioners Gyanesh Kumar and S S Sandhu was here on a three-day visit to review the preparedness for Assembly polls in Jammu and Kashmir and take feedback from political parties. Talking to reporters after party-wise meetings with the poll panel's delegation, political leaders said they were unanimous in their demand for immediate Assembly elections in

"What justification is there not to hold polls when the government says the situation has improved and is better, when one crore tourists came here, and when the parliamentary polls and (Amarnath) yatra took place without any incident," he asked. He said the need of the hour is to restore democracy in J-K. "The county believes in democracy, so we should have elections immediately," the PDP leader said and added that the there was a very positive response from the EC. NC leader Wani said the party also demanded a level-playing field in terms of providing a secure environment for the polls. #### Lawyer arrested for inciting woman for selfimmolation bid in Lucknow

Lucknow. A day after a 30-year-old woman suffered severe burn injuries following a self-immolation bid near Uttar Pradesh Chief Minister Yogi Adityanath's residence in the Vikramaditya Marg area in Lucknow, claiming torture by her husband and in-laws, police arrested her lawyer on Wednesday for allegedly inciting her for the act. The husband of the woman and his brother have already been arrested.

According to a press statement issued by the Lucknow Police, Sunil Kumar, the woman's lawyer, was arrested for allegedly inciting her for the act. Police have alleged that Kumar incited the woman with an intention of "maligning the image of police and the government".

An FIR has been lodged against Kumar at the Gautam Palli police station. Deputy Commissioner of Police (Lucknow Central) Raveena Tyagi on Tuesday said Anjali Jatav, the mother of a one-year-old boy from Unnao district, had accused her husband and in-laws of subjecting her to physical as well as mental harassment.

The woman attempted to immolate herself by pouring a flammable liquid on her body near Vikramaditya Marg within the Gautam Palli police station limits.Police personnel extinguished the flames and got her admitted to the Dr Shyama Prasad Mukherjee (Civil) Hospital, where doctors confirmed that she had suffered 90-per cent burns.

Unnao district authorities said in a statement on Tuesday that instructions were issued to initiate action in the case, leading to the arrest of Jatav's husband and his brother on charges of harassment.

#### For less than 40% disability, govt plans white UDID card

PUNE. The ministry of social justice and empowerment has, as part of draft amendments to the Rules of the Rights of Persons with Disabilities (RPwD) Act, 2016, proposed issuing white unique disability ID (UDID) cards to those with less than 40% disability.

This comes in the wake of probationary IAS officer Puja Khedkar getting three disability certificates from two hospitals in Ahmednagar and Pune districts after changing her name and surname and with different residential addresses.

On July 29, the ministry published these draft changes, introducing a new colour-coded system for UDID cards. White cards would be issued to those with disability levels below 40%, yellow cards for 40-80% disability, and blue cards for more than 80% disability.

'Entire system faces revamp after Khedkar

The draft amendments have also proposed extending the timeframe for issuing disability certificates and UDID cards to three months instead of one month. This extended timeline aims to allow medical authorities more time for a thorough

Ministry officials told TOI on Tuesday that they are plugging loopholes in the system. "The draft rules and a standard operating procedure have been in place and can be seen on our website. After the Khedkar case, we are taking caution and the entire system is being revamped. The Centre has sought suggestions on the draft rules before the end of this month, after which they will be implemented," an official said.

### Wayanad landslides: Crowdfunding feast in Tamil Nadu to raise funds for victims

A crowdfunding feast was held in Tamil Nadu's Dindigul to raise funds for the victims of Wayanad landslides, which have claimed over 400 lives so far. People donated money either by keeping it in a cash box or under a banana leaf after having their food.

**Dindigul.** Thousands of people participated in a 'moi virundhu' ceremony (crowdfunding feast) in Tamil Nadu's Dindigul to donate funds for the rehabilitation of victims affected due to massive landslides in Wayanad in Kerala.

'Moi virundhu' is a traditional event done by inviting people to participate in a feast and people are free to contribute any amount of money for any purpose. People donated money either by keeping it in a cash box or under a banana leaf after having their food.

One of the participants, Rasathi, said 'Moi Virundhu' was conducted by villagers to help a family in financial distress.

"The event is held in such a way that nobody would be compelled to contribute and one can anonymously provide whatever they can. For this purpose, the food is served on a banana leaf and the contribution will be left underneath it," Rasathi said.

Another participant, Nazriya, said he and his seven-year-old son saved Rs 700, which they

had contributed to the cause. Mujib, who runs an eatery and had organised the event, said he was overwhelmed by the healthy participation of people

'We could have collected the money and provided it to the Chief Minister. But, we realised many people wished to participate but could contribute very little money considering their situation. So we decided to go the traditional way as we wanted to include them as well and the response was overwhelming," Mujib said.

A hundi (cash box) was installed for people who could even contribute Rs 5 or Rs 10. A cheque of Rs 10,000 was found under the banana leaf after



On July 30, torrential rainfall triggered landslides in Mundakkai and Chooralmala areas of Wayanad, flattening houses and trapping people under the debris. So far, 417 people have died in the disaster.

### Gujarat: Babus who got jobs under disability quota to take fresh medical exam

GANDHINAGAR. At least four IAS officers of Gujarat will have to get their disability certificates re-checked after Union Public Service Commission (UPSC) directed all officers of the All India Services (AIS) who provided disability certificates for jobs, to get a medical reexamination done, sources here said.UPSC initiated this exercise in the wake of the controversy triggered by Maharashtra cadre IAS officer Puja Khedkar, who was sacked after being charged with providing fake disability certificates and other irregularities.

"All IAS, IPS and IFS officers in the state who have submitted disability certificates will be required to get a re-examination done at the Civil Hospital in Ahmedabad. They will be required to send reports of



the re-examination of their 'disability' to UPSC," top govt sources said.

Following the Khedkar incident, four IAS scanner after the state govt's general administration department (GAD) found that their disability certificates needed closer scrutiny. had reported this in its edition dated July 20.

Sources said there is no immediate information on how many more officers posted in the state have got into the services by providing disability certificates.

One of the four IAS officers whose disability certificates are being checked is a senior officer and three others are junior-level officers, sources said. While the senior officer had cited 'visual impairment' as a disability, the three junior officers had cited 'locomotive disability' reasons in

#### Guj spends 503cr in a year to ease pain

Ahmedabad. The surging need for pain relief has driven the growth of the analgesics therapy market, which has expanded by 43% in size over the past four years to touch Rs 503 crore. Medical practitioners attribute this rise to reckless consumption of over the counter (OTC) analgesics. According to data by Pharmarack, the pain and analgesics segment in Gujarat has grown from Rs 354 crore in moving annual turnover (MAT) for June 2020 to Rs 503 crore in MAT for June 2024 a rise of 42%. For MAT of June 2024 itself, about 74% of these drugs were analgesics including diclofenac, aceclofenac, ibuprofen and tramadol, amounting to about Rs 377 crore.

The demand for pain management and muscle relaxants has increased since the pandemic due to stress and anxiety and lack of physical during the lockdown, chemists and medical practitioners say. Trends suggest that bad postures, lack of exercise and excessive use of laptops and handheld devices has contributed to muscle pain.

"Analgesics abuse is rampant among patients across age groups. In rural areas, people recklessly pop painkillers without prescriptions, out of ignorance to avoid surgeries. In urban areas, poor lifestyle is largely responsible for many serious conditions. Most patients visiting us with non-traumatic conditions are often on heavy painkillers like diclofenac or tramadol. Common conditions include plantar fasciitis, degenerative back pain, cervical spondylitis and trapezitis, often triggered by a sedentary lifestyle," said Dr Maharshi Bhatt, anAhmedabad-based orthopaedic and joint replacement surgeon. "Lifestyle modification coupled with rest and physiotherapy are key to resolving these concerns but instead, patients turn

At least a third of the cases of renal failure are due to prolonged and reckless consumption of analgesics and painkillers," he added. The rising cases of viral and bacterial infections are also a major reason behind the rise in the prescription of analgesics. "For instance, analgesics like paracetamol are often co-prescribed with ailments that cause body

## Anna Canteens in Vijayawada ready to open

VIJAYAWADA. The renovation of Anna Canteens in Vijayawada, overseen by the Vijayawada Municipal Corporation (VMC), is completed. The government is planning to inaugurate 100 Anna Canteens across the State on August 15, with nearly Rs 80 lakh allocated for renovating 11 canteens in

These canteens had ceased operations during the previous YSRC government, and their buildings were repurposed. With the TDPled NDA government back in power, Chief Minister N Chandrababu Naidu has approved the revival of Anna Canteens statewide. Consequently, renovation efforts commenced.

The State government has also earmarked funds for constructing new Anna Canteens to provide affordable meals. The budgets are as follows: Rs 8.00 lakh each for canteens at APSRM School, Ranigari Thota (Cement Godown), Sai Baba Temple near Netaji Bridge, and Patamata High School. Similarly, Rs 7.00 lakh each for canteens at Dharna Chowk, Bavaji Pet (Gulabi Thota) near AŠ Raju Bridge, Singh Nagar, and Budameru Vagu, Ayodhya Nagar. Additionally, Rs 6.75 lakh for the canteen at RTC Workshop Road, Vidyadharapuram, and Rs 6.50 lakh each for canteens at Gandhi Mahila Kalasala and Housing Board Colony.

Speaking to TNIE, VMC Commissioner HM Dhyanchandra stated, "The revival of Anna

Canteens is a significant step towards providing affordable meals to the public. We are working diligently to ensure these canteens are ready for the inauguration and can serve the community effectively."

He added that the 11 Anna Canteens within VMC limits are ready to start.

The renovations, including food counters, supply counters, and washrooms for males and females, are 100 per cent complete. The outer and inner designs have also been finished.

Dhyanchandra mentioned that he has inspected the sites twice and will visit once

more on Thursday to check for any additional work needed.

#### Women are more aware of their rights, says Haryana Women's Commission chairperson Renu Bhatia

#### Driven to death: Auto driver killed in Gurgaon family feud

GURGAON: Two more men were arrested from Sanp Ki Nangli on Wednesday for murdering a 27-year-old auto driver who allegedly had an affair with a married woman from their family. They had dumped his body behind KR Mangalam University in Sohna.

Kuldeep from Raisina village had gone missing on Monday. His body was discovered early on Tuesday, leading to the arrest of one of the accused, Veerender alias Ajay. Preliminary investigation suggested that 22year-old Veerender, an electrician from Sanp Ki Nangli, along with his cousins-30-year-old Janakraj, a farmer, and 23-year-old Naveen, a food delivery executive-kidnapped Kuldeep in a car while he was waiting in his auto near GD Goenka University."The trio said that the auto driver was blackmailing their family member with her intimate videos, and when he refused to unlock the cell phone to delete the videos, they bludgeoned him to death with sticks. The trio recced his house before hatching the plan. They also confessed to assaulting the deceased in an isolated area for over three hours before dumping his body in a garbage-filled drain around 2.30 pm," an investigator said.Kuldeep, who used to drive girls from his village to the government high school in Sohna and bring them back in the afternoon, did not turn up after classes on Monday. #### Blockbuster weight loss and anti-diabetes drugs could soon be available in India

New Delhi, August 8: The USFDA-approved blockbuster weight loss and anti-diabetes drugs—Ozempic and Wegovy—could soon make it to the Indian market. The Ministry of Health on Thursday approved local clinical trial waivers for high-end select drugs approved by the stringent national regulators of US, UK, Japan, Australia, Canada and EU. The waiver will apply to drugs that fall in the following five categories—orphan drugs for rare diseases; gene and cellular therapies, new drugs used in pandemic situations, new drugs used for special defence purposes and new drugs with significant therapeutic advance over the current available standard care. Asked if weight loss drugs, currently a range in Hollywood, with even Tesla's Elon Musk learnt to be using, could qualify in the waiver category, government officials here said, "yes, if the manufacturers prove these have significant therapeutic value over the currently available treatment."

### US auto workers union chief calls Trump 'sellout' over ties with Elon

Detroit. United Auto Workers President Shawn Fain on Wednesday criticized Republican presidential candidate Donald Trump's ties to billionaire Elon Musk while campaigning for Democratic Vice President Kamala Harris.Musk endorsed Trump for November's election after the former president survived an assassination attempt in July. Later that month, the Wall Street Journal reported Musk planned to commit around \$45 million a month to a new pro-Trump super political-action committee. However, after that report's publication, both Musk and Trump said the Tesla CEO never pledged any such donation. For months, Donald Trump has gone around trashing our state, trashing our industry, trashing the American autoworker, saying he was against electric vehicles. And then something happened," Fain said on Wednesday while campaigning for Harris.

We saw Elon Musk announce he was going to give Donald Trump \$45 million dollars a month. And all of a sudden, guess what, Trump changed his tune," Fain added, calling Trump a "sellout."Trump has opposed any electric car mandate and been critical of EV policies under Democratic President Joe Biden but he has said recently he supports electric vehicles."I'm for electric cars. I have to be, because Elon endorsed me very strongly. So I have no choice," Trump said at a weekend rally, but added he supports electric vehicles "for a small slice." He went on to add: "You want to have gaspropelled cars, you want to have hybrids, you want to have every kind of a car imaginable."UAW has endorsed Harris, who became the Democratic presidential candidate recently after Biden stepped aside as

#### UK Muslim ice cream vendor's sweet gesture, gives out free cones to riot police

London. A British Muslim social media star who travels around the country in his ice cream van has thanked police officers trying to control racist and antiimmigration riots by handing out free cones.Mr Tee, King of Desserts, posted a TikTok video taken in the English city of Sunderland that amassed over 2.6 million views, in which he offered a police van full of officers ice creams, with the theme tune to 1980s hit TV show 'The A-Team' blaring."We just thought we'd show them a little bit of love," Mr Tee, whose real name is Ashiq, told Reuters. The two-minute clip - in which one policeman asked for a special birthday ice cream for a colleague - struck a chord with the British public, the vast majority of whom think the riots are unjustified, according to a recent YouGov poll.

'This is brill - remember under the uniforms there is a dad, husband, uncle brother, human," said commenter sayithowitis1970.Riots have erupted at antiimmigration protests in towns and cities across the UK in the last week, with attacks by far-right groups on hotels housing asylum seekers and on mosques.Mr Tee said most of the praise for his video came from non-Muslims who value their community."It's just a very small minority that are unfortunately (not) feeling in this way," Mr Tee said. Based in the northern Welsh town of Wrexham, Mr Tee said he would take a week off to let the tensions around the country die down."Some people are scared to leave the house, ladies especially, they don't want to be seen walking about with their hijabs," he said. But Mr Tee pointed to the reaction to his video as a reason for hope

"It just showed the genuine true colours of the UK and the people that live here, and obviously the welcoming side of the people here," he said.

#### France seeks FBI's help in probe of train sabotage before Paris Olympics: Report

Paris Police in France investigating the sabotage of high-speed rail lines hours before the Paris Olympics's opening ceremony have asked the US's FBI for help, two sources with direct knowledge of the French inquiry said. Investigators called in the FBI after media organisations, including Reuters, received an email the police believe may have been sent by the perpetrators. It set out a rambling list of grievances but did not explicitly claim responsibility.

The email, signed by "an unexpected delegation", was sent from a riseup.net address, a Seattle-based collective that says it provides "communication and computer resources to allies engaged in struggles against capitalism and other forms of oppression". The saboteurs targeted four high-speed TGV lines heading into Paris with incendiary devices, causing travel chaos hours before a global audience tuned in to follow the parade of Olympic athletes along the River Seine on July 26.

There have been no arrests. French officials suspect domestic far-left groups, but have not ruled out foreign involvement. As riseup.net is US-based, French police have asked the FBI to push that organisation to identify the email account-holder, the two sources told Reuters. The FBI declined to comment. Riseup did not respond to an emailed request for comment. The FBI would need to subpoena Riseup to hand over the details, but Riseup would be unlikely to comply. We will actively fight any attempt to subpoena or otherwise acquire any user information," it says on its website. "We do not share any of our user data with anyone."In a 2020 interview with Belarusian anarchist group Pramen, Riseup said it had never complied with a foreign legal request."We regularly get legal requests from all around the world. We are not required to respond, and so our policy is to not."However, the FBI has previously served warrants on Riseup.

In 2012, FBI agents seized a server used by Riseup as part of a probe into bomb threats. In 2017, Riseup begrudgingly complied with two FBI warrants seeking the identity of accounts involved in extortion. The author of the email railed against France's arms, energy and nuclear sectors, and criticised a TGV network as only benefiting "a few privileged people". They said the impact of the attacks - "spoiling tourists' trips or disrupting holiday departures" - was minimal when compared with the legacy.

# Kamala Harris shuts down Gaza protesters: If you want Trump to win, say that

Pro-Palestinian protesters chant 'genocide' slogans at Kamala Harris's rally

World US Vice President Kamala Harris, the Democratic presidential nominee, on Wednesday (local time) criticised a group of people who interrupted her while they were protesting against the war in Gaza. Harris, visibly irritated, fired back at the protesters, saying they should either say they wanted former President Donald Trump to win or listen to her speaking. While addressing a rally in Romolus in



Michigan, protesters repeatedly chanted "genocide" slogans at the Vice President as a mark of protest against Israel's war on Gaza, now into its tenth month, The Hill reported. "Kamala, Kamala you can't hide, we won't vote for genocide," the protesters said and booed at her.Reacting to the protesters' interruption, she said, "I'm here because we believe in democracy. Everyone's voice matters, but I am speaking now. I am speaking now," Harris said amid cheers from her supporters. As Gaza protesters continued to interrupt her speech, Harris took aim at them. "You know what, if you want Donald Trump to win, then say that. Otherwise, I'm speaking," she said, drawing cheers from the crowd. The protesters were escorted out of Harris's rally as they continued protesting and

raising slogans. The Gaza war is a major issue in Michigan, a battleground state which has a high Arab-American population. Harris, as a member of President Joe Biden's administration, has come under fire for not doing enough to help civilians in the war-ravaged coastal enclave.A section of Democrats have expressed concerns that the Biden administration's handling of the Gaza war could cost them votes in the November 5 election, The Hill reported. Michigan, which has 15 electoral votes, was carried by Biden in the 2020 election. Like Biden, Harris has vowed ironclad support for Israel but has also stressed that it also mattered how the Jewish nation carried out its military response against Hamas. She also raised the high civilian casualties, calling it "devastating" and said she could be silent on seeing the sufferings of the people there. Nearly 40,000 people have died since Israel launched a full-fledged attack against Hamas in Gaza after the Palestinian outfit attacked the Jewish nation and took some 250 hostages on October 7 last year, which triggered.

"As Bangladesh prepares to swear in its interim government, I urge all government officials, the new administration and police chief, and the people of Bangladesh to do all they can to end the violence that has emerged across the country, including



the brutal targeting of the country's Hindu minority, their homes, businesses, and their temples," Krishnamoorthi said in a statement on Wednesday.He said the violence must stop and those responsible must be brought to justice to help the people of Bangladesh move forward as a nation. He added that he will continue to closely monitor developments in Bangladesh in coordination with the US State Department.Democratic Leader Hakeem Jeffries said that he is

deeply concerned and saddened by the violence, casualties and human rights abuses in Bangladesh over the past weeks.Jeffries noted that Bangladesh's new leadership must bring with them respect for democratic principles and the rule of law and a commitment to investigating the attacks, calling for accountability for those responsible and demanding justice for the victims.

#### Hezbollah has fired over 7,500 rockets at Israel since beginning of Gaza war

World Israel is battling on two fronts now. While it has launched a counter-operation against Hamas in Gaza, the Israeli forces are facing another challenge in the north from Lebanon's Hezbollah group. According to data from security forces of Israel, between October 9, 2023 and August 6, the Iranian terror army proxy of Hezbollah has launched over 7,500 rockets toward Israel, out of which 6,500 landed on Israeli territory. This shows that 1,000 rockets either misfired or landed back in Lebanon and Syria."That is a crime against humanity and another reason why Hezbollah needs to be kicked out of Lebanon, to protect the Lebanese people, never mind Israel. They are a menace to Lebanon", Israeli government spokesperson David Mencer said on Wednesday. Since the beginning of the war, Hezbollah has also launched 187 drones into Israel.Over 43 people, including 23 civilians (including an Indian national) and 19 members of Israel's security forces have been killed due to the attacks by Hezbollah since the beginning of the war. The civilian casualties includes eight children aged between seven and 13 years and four children aged between 14 and 18 years,

### **Deforestation in Brazil's Amazon** rainforest dips to lowest level in 8 years

Amazon rainforest slowed by nearly half compared to the year before, data released Wednesday. It's the largest reduction since 2016, when officials began using the current method of measurement. In the past 12 months, the Amazon rainforest lost 4,300 square kilometers (1,700 square miles) of land, roughly the size of Rhode Island. That is a nearly 46% decrease compared to the previous period. Brazil's deforestation surveillance year runs from August 1 to July 30. The figures are preliminary and come from the Deter satellite sytem, managed by the National Institute for Space Research, a federal agency and used by environmental law enforcement agencies to detect realtime deforestation. The most accurate deforestation calculations are usually released in November.Amazon deforestation has steeply declined

Brasília. Deforestation in Brazil's since the end of far-right President Jair Amazon absorbs large amounts of



government, forest loss reached a 15year high.Still, much remains to be done to end the destruction. President Luiz Inácio Lula da Silva pledged "deforestation zero" by 2030. ## Israel not invited: US envoy to Japan to skip Nagasaki atomic bomb memorial

Tokyo. U.S. Ambassador to Japan Rahm Emanuel will skip this year's atomic bombing memorial service in Nagasaki because Israel was not invited, the embassy said Wednesday.Emanuel will not attend the event on Friday because it was "politicised" by Nagasaki's decision not to invite Israel, the embassy said.He will instead honour the victims of the Nagasaki atomic bombing at a ceremony at a Buddhist temple in Tokyo, it said. An atomic bomb dropped by the United States on Hiroshima on Aug. 6, 1945, destroyed the city, killing 140,000 people. A second bomb dropped three days later on Nagasaki killed 70,000 more. Japan surrendered on Aug. 15, 1945, ending World War II and the country's nearly half-century of aggression in Asia.

Nagasaki Mayor Shiro Suzuki had indicated his reluctance in June to invite Israel, noting the escalating conflict in the Middle East. He announced last week that Israel was not invited because of concern over "possible unforeseen situations" such as protests, sabotage or attacks on attendants. Nagasaki hoped to honour the atomic bomb victims "in a peaceful and solemn atmosphere," he



said.Suzuki said he made the decision based on "various developments in the In contrast, Hiroshima invited the Israeli international community in response to the ongoing situation in the Middle East" that suggested a possible risk that the

The exclusion of Israel would make their "high-level participation" difficult, they said.British Ambassador to Japan Julia Longbottom, who attended the 79th anniversary of the atomic bombing of Hiroshima on Tuesday, told Japanese media that she planned to skip the Nagasaki ceremony because the city's decision to exclude Israel could send a wrong message.

#### Cops crack whip on wrong-side driving

### EV battery explodes, destroys house

Ahmedabad. A blast in an e-scooter battery left everything inside a home in ashes in the Vasna area early on Wednesday. The fire erupted while the battery was charging, requiring a swift rescue operation by the Ahmedabad Fire and Emergency Services (AFES) team to save three residents.

According to AFES officers, the incident occurred in the third-floor flat of Siddha-Shila Apartments around 4.30am."The scooter's owner, a young man of about 20 years old, was asleep near the charging battery in the drawing room when a sudden explosion, triggered by a spark, set the house ablaze," said a resident of the apartment building, seeking anonymity.

The resident said that the man's mother and sister were sleeping in another room and were trapped by the fire and the smoke. "They were asleep in the bedroom where the window was open. This saved their lives as the air flowing in through the window, dispersed the smoke."

They then sought refuge in the balcony of the house until AFES personnel arrived and rescued them. The young man managed to escape first, said the officers. The inferno consumed various household

items, including a TV, washing machine,



air conditioner and dining tables.One family member said that the explosion took place even though they had bought a new battery for the scooter on July 4. The e-scooter itself had been purchased just two years ago for Rs 75,000. This incident is not an isolated one in Ahmedabad. A showroom of e-vehicles in Asarwa caught fire on Friday. Three electric buses were charred at the Vastral depot, managed by the Ahmedabad Municipal Corporation, while they were being charged on June 24.

study found that those subscribing to a plant-based diet have a higher intake of protein, calcium, folate, and vitamin C.Their vitamin B12 is low. On the other hand, meat-fish eaters consume more carbohydrates, sodium, riboflavin, iron, and vitamin B12."The higher intake of protein among vegetarians suggests a potential positive impact on mental health, as adequate protein is vital for overall brain function," the findings stated. Also, when compared to nonvegetarians, the non-meat eaters often exhibit elevated levels of antioxidants in their bloodstream and experience reduced oxidative stress. ## TN government expedites land acquisition to convert 10km of ECR into six lanes

CHENNAI. In light of the proposed 14.6km four-lane elevated corridor from Jayanthi Theatre Junction to Uthandi on East Coast Road (ECR), and the modernisation of Thiruvanmiyur bus stand, the state highways department has expedited land acquisition for converting the 10.3 km stretch of ECR from Thiruvanmiyur to Akkarai

Last week, nearly 20 buildings opposite Thiruvanmiyur bus stand were demolished to facilitate the widening work. Once the six-lane work is complete, construction of the elevated corridor is likely to be taken up by next year, according to senior highways officials.

The ECR stretch from LB Road-OMR intersection to Uthandi experiences heavy traffic congestion throughout the day, mainly due to vehicles travelling between densely populated residential areas along ECR.

According to the Indian Road Congress norms and highway guidelines, an elevated corridor should be constructed if 40% of the road traffic is heading straight without deviations. "ECR now meets the criteria for an elevated corridor," an official said. The road carries about 1.2 lakh vehicles daily. Official sources also told TNIE about 85% of the land acquisition is completed for widening the 8.7km stretch passing through Kottivakkam, Palavakkam, Neelankarai, Injambakkam, and Sholinganallur. "Civil works are underway for the 8.7km stretch, which involves constructing stormwater drains, culverts, and medians. For the remaining 1.6km in Thiruvanmiyur, 50% of the land acquisition work is complete, and ?document verification is underway for remaining buildings," said an official.

The official added that the project was delayed due to issues in acquiring natham land parcels, as cases were filed



seeking increased compensation and against alienation of government land. "Additionally, the ongoing ECR widening works are synchronised with two metro water projects, including laying of pipelines for a water supply scheme and a sewerage system. Only after metro water completes the work can we commence civil works for road laying."In March, the state highways department allocated

'52 lakh to conduct a techno-feasibility study for developing the 14.6km four-lane elevated corridor. "During the study, vehicle density, two-way traffic, traffic movement to linked roads from ECR, and locations for down ramps will be studied. Once the six-laning project is complete, the works may be taken up next year," added

### Trump, Harris poles apart on Indian govt's human rights policies

THE Indian foreign policy establishment is keenly following the twists and turns of the US presidential campaign. Despite the rise of China and, with it, the growing global importance of its top leader, it is the US President who holds, by far, the most important political office on the planet. The US President and his administration's decisions impact almost every country and issues of international significance, such as climate change.President Joe Biden had been his party's obvious candidate for this year's presidential election. There was no hint that this would change till Biden performed disastrously in the debate with his predecessor Donald Trump on June 27. Thereafter, a growing number of Democrats demanded Biden's replacement with another candidate because it became increasingly clear that he would lose the election. Yet, it took Biden more than three weeks to decide on giving up the candidacy. Finally, on July 21, he announced that he would not contest the election and endorsed Vice-President Kamala Harris as the party's candidate. The Democrats, in disarray, quickly rallied around her and the race is now between Trump and Harris. Opinion polls indicate that both are almost tied in the swing states, where this election will really be decided.Trump was generally leading Biden by substantial margins in the swing states by early summer. It was also becoming increasingly clear that the infirmities of age were telling on Biden. Hence, despite Trump's conviction in the Stormy Daniels hush money case in May, his candidature continued to remain strong. Would it then be wrong to assume that some influential voices in the Indian system, especially those with intimate professional knowledge and experience of US politics, had reached the conclusion by mid-June that it was more than likely that Trump would trump Biden in the polls. While the Ministry of External Affairs announced Prime Minister Narendra Modi's visit to Russia on July 4, it is believed that the dates for the visit were finalised around June 21. With Biden's debacle in the debate and his disinclination to give up his candidature, the impression that Trump would be the next US President would have been only strengthened before Modi's Russia visit. India has continuously exercised its strategic autonomy and displayed this from the beginning of Russia's invasion of Ukraine in February 2022. This has been evident through its increasing purchase of Russian oil. However, it is one matter to do this and quite another for Modi to visit Moscow. There would have obviously been comfort in doing so if the assessment was that Trump would be back in the White House in January next year. And, this was because it is known that his views on the Ukraine issue are, at least, till now, at great variance with Biden's. The race for the Oval Office has entirely changed with Harris as the Democratic Party's candidate. It can no longer be assumed that Trump will win the election. Hence, is Modi's proposed visit to Ukraine later this month a hedging exercise? Harris is likely to remain strong on Russia. This question also arises because of Ukrainian President Volodymyr Zelenskyy's intemperate comments on Modi meeting Putin in Moscow. It is understood that Modi will also visit Poland along with Ukraine. Modi has been correctly insisting on the path of peace and diplomacy for a resolution of the Ukraine issue. But the conflict is hardly ready for a resolution. Though Modi's international reputation is strong, does India have the heft to play a role in matters of European security and bringing warring parties there together? This cruel question has to be faced squarely. At a basic level, India can successfully deal with Trump or Harris as the next incumbent of the White House.

#### What led to Hasina's fall & flight

#### Awami League govt exacerbated the crisis by mishandling the student protest movement

REGIONAL stability in South Asia saw a marked improvement after Sheikh Hasina assumed power in Bangladesh in January 2009. Her cooperation with New Delhi in addressing insurgent and terrorist threats in India's northeastern states and the decisive action she took against Islamists in Bangladesh significantly enhanced the security situation in the region. Hasina's uninterrupted 15-year rule was largely marked by peace and tranquillity, which, in turn, spurred economic development in Bangladesh and bolstered regional cooperation. Several

long-standing issues between India and Bangladesh were amicably resolved during her tenure, facilitating increased sub-regional collaboration, particularly as the regional organisation SAARC (South Asian Association for Regional Cooperation) remained largely ineffective. However, the dramatic collapse of law and order on August 4, which led to Hasina's ouster, can undermine these achievements and set back the progress made in both national and regional contexts. The trigger for the deteriortion in the security situation was the resurfacing of student protests, resulting in around 100 deaths and injuries to hundreds. The police used tear gas and rubber bullets on protesters demanding Hasina's resignation. The government imposed an indefinite nationwide curfew and banned access to the Internet to quell the protests

These demonstrations began in June,

with student activists at Dhaka University agitating against a controversial quota system in government jobs that reserved 30 per cent of the positions for the family members of war veterans who had participated in the 1971 Liberation War. The protesters argued that the system was discriminatory and favoured Hasina's Awami League party; they demanded a merit-based system instead. The quota system, established in 1972, was briefly abolished in 2018 but later reinstated. It was abolished once again after nearly 200 students were killed by the security forces in July. The protests paused for a while after the Supreme Court scrapped/slashed quotas but resumed over the demand for justice for those killed. The stir evolved from being focused on the quota issue to a broader antigovernment movement that witnessed the participation of people from diverse sections of society, including celebrities and garment manufacturers. Support for the

protests also grew among former military figures, including ex-army chief Gen Iqbal Karim Bhuiyan, who turned his Facebook profile picture red as a gesture of solidarity. This was significant as a large number of former army officers in Bangladesh have backgrounds in the Pakistani army. There were also allegations that the protesters were being used by the Opposition Bangladesh Nationalist Party and Jamaat-e-Islami for their own political goals. Amid the unrest, the army intervened to



restore order. Army chief Gen Waker-Uz-Zaman had first directed officers to ensure peace. However, as the situation threatened to spiral out of control, the army took an ambiguous stance. On August 3, the army chief had addressed officers at the military headquarters in Dhaka, emphasising that "the Bangladesh army is the symbol of trust of the people." He assured them that the army would stand by the people and the state in times of need, but he did not clarify if the army supported the protests.

Though the peace and tranquillity during Hasina's rule brought economic prosperity to Bangladesh, she was accused of entrenching power by using state institutions and suppressing dissent. It was alleged that the Awami League, supposedly the people's party, had lost touch with the populace. These clashes were among the deadliest in the country's history of civil unrest. The Awami League

attempted to use its student wing, the Bangladesh Chhatra League, against the protesters, forgetting that the student wing was not an auxiliary police force and should not attack fellow students. It was actually the forces aligned with the ruling party that initially caused the protests to degenerate into civil disorder.

The worsening situation in Bangladesh drew the attention of the United Nations (UN), which called for a cessation of violence, the release of detainees, the restoration of access to the Internet and a meaningful dialogue. India,

> concerned about the situation but limited in its ability to intervene as it is an internal matter of Bangladesh, has advised its nationals to avoid travel within that country. New Delhi is also worried about the spillover of the unrest in Bangladesh, particularly in the states bordering the neighbouring country. The crisis has brought to the forefront the cumulative grievances of the citizens: rising prices of daily necessities, the pernicious influence of syndicates and unchecked corruption permeating almost every branch of the government. The people were also frustrated with the government's determination to suppress political opposition. The Bangladeshi economy has faced significant challenges of late, particularly a crisis of foreign currency. While the economy was performing well, citizens paid less attention to the democratic political space available to them. However, as the economic situation began to

deteriorate, concerns over jobs, employment and political freedom became increasingly important. The Hasina government exacerbated the crisis by mishandling the student protest movement, treating the agitators as political adversaries. The army chief announced that an interim government would take charge, promising that the military would stand down and investigate the deadly crackdown on protesters.

The Bangladeshi army is unlikely to remain at the helm for long, as it is a major beneficiary of the UN peacekeeping operations, and the UN does not encourage such an arrangement. As seen during the time of the caretaker government in 2007, the army prefers backseat driving, similar to the situation in Pakistan. However, for India, the bilateral relations will now depend on the new regime that emerges once the dust raised by the protests settles.

### Greater localisation is the key to equitable economic growth

INDIA does not have a growth problem: its GDP is growing faster than other countries. The problems of the Indian economy are its inequitable growth and the harm caused to the natural environment. India's policymakers must adopt new theories of growth.

In the prevalent theory of economic development, labour must move from agriculture into manufacturing, and then to services. Therefore, the productivity of agriculture must be improved with inputs provided by the industry (fertilisers, pesticides, machinery), and surplus labour moved into manufacturing. India's manufacturing sector is not able to provide enough employment to workers displaced from agriculture. This is the structural reason for large numbers in India remaining in agriculture. Economists measure the productivity of all sectors -agriculture, manufacturing, and services - by the amount of labour required to produce its output. The productivity of agriculture is improved by reducing the amount of human labour required to produce food from the soil, and substituting it with other technological inputs -machines, chemicals, etc. The productivity of manufacturing is improved by reducing human labour input, substituting it with technology; similarly for services. It is not the size of its GDP that determines whether a nation is more advanced than others: it is the per capita GDP that counts. Technology, including AI, can improve productivity in all sectors by increasing the output of human effort or eliminating it altogether. Economically advanced nations that have more financial capital can afford to use more technology than labour. The measure of productivity of Indian economic enterprises must be changed. More labour and less capital must be used for growth and improvement of the Indian economy's performance. Scale is a concept beloved by managers. Large-scale factories and farms, each specialising in the production of a single item or crop, enable the use of standardised machinery and inputs (chemicals, components, etc), also produced in large-scale factories, thereby reducing overall costs. However, large-scale production requires larger markets for every factory and

farm. Underutilised large factories and farms can be a waste of capital.

International trade expands markets for specialist producers, each producing what it does best. In trade theorist David Ricardo's example, the Portuguese should produce port wine and the British textiles, and trade with each other; rather than the British trying to grow grapes in their climate and the Portuguese learning to run mechanised textile mills. Global GDP is higher when each country produces only what it does best and imports the rest of its needs. Increased global trade with reductions in costs of transportation (containerised supply chains, giant ships and large cargo planes), along with a decline in trade barriers, has enabled faster globalisation and increased the global GDP in the last 30 years.

'Free market' economists say that a market is the most efficient way for fixing prices by matching supply with demand. A change in price also provides a signal to investors to adjust production capacities. This simplistic view of a market is blind

to inequities in markets caused by unequal power between capital owners and the providers of perishable resources. Workers who have only their time and work to sell must be employed regularly, and paid on time, or their lives are wasted. Workers and farmers with perishable produce cannot withhold the sale to induce price rises, whereas their buyers can delay purchases and payments, compelling them to sell at a loss. With the expansion of global trade, the power of consumers over producers (workers and farmers) has increased. Buyers threaten to find lower cost sources in other countries if they cannot obtain lower prices from the current suppliers. Inequalities in incomes and wealth have been increasing between those



who earn their incomes and wealth from financial investments and workers and small farmers, even in advanced countries (unless farmers are heavily subsidised). Environmental scientist Vaclav Smil analyses the use of fossil fuels in the modern economy in How the World Really Works: A Scientist's Guide to Our Past, Present and Future. They are used in the production and distribution of four foundational materials for modern civilisation: steel, concrete, plastics and food. He evaluates the 'total system' requirements of fossil energy in the production of these.

Food is the most fundamental of these for human survival: more fundamental than steel, concrete and plastics. Food systems are also the largest users of fossil fuel-based

inputs. Fertilisers are produced from fossilfuel feedstock. Farm machinery is made of steel and runs on fossil fuels. Plastics are used for hygienic transportation of food in global supply chains. Fossil fuel-based solutions became integral for increasing the scale of food production and distribution for meeting the needs of the human population, which increased in the last 100 years from two billion to eight billion (1.4 billion in India). The world does not have a problem with the overall quantity of food produced any more. The problem is the inequitable distribution and wastage of food.Smil calculates the benefits of locally circular, organic multi-cropping systems. He says they could be the solution for the world. He wonders though: "Could we return to purely organic cropping, relying on recycled organic wastes and natural pest controls, and could we do without engine-powered irrigation and without field machinery by bringing back draft animals? We could, but purely organic farming would require most of us to abandon cities, resettle villages, dismantle central animal feeding operations, and bring all animals back to farms to use them for labour and as sources of manure.

Are we prepared to do this?"The solution for the twin problems of environmental degradation and inequitable economic growth is less globalisation and more localisation. About 64 per cent of the people in India live in rural areas (36 per cent in China, 17 per cent in the US). They mostly work on farms and in small industries in rural areas, not in large factories that use automated equipment. Rather than trying to catch up with rich countries on their historical development paths, India should take advantage of its present realities. Local, systemic, small-scale agricultural solutions, and small industries, cooperatively managed by communities in their own villages and towns,



## Your cell phone can give you Jancer

Mobile is an inseparable part of our life. We are completely dependent on our mobile phones and everyone has it, even school children.

There are reports that radiation can even turn your brain into an omelette. We did a little research and got you some factual answers.

Radiation from your mobile?
Yes! Radiation is present from mobile phone in the form of electromagnetic waves. Through a particular radio frequency on these electromagnetic waves, you are able to make and receive calls. The radiation emission is present in small amounts from your mobile as these emissions are of short range waves.

Small amount of radio waves emitted from your mobile is

absorbed by the body. According to Wikipedia - the maximum power output from a mobile phone is regulated by the mobile phone standard. In most systems the mobile and the base station check reception quality, signal strength and the power level. It is increased or decreased automatically within a certain span to accommodate different situations - when you are inside or outside the building or vehicle.

The rate at which energy is absorbed by the human body is measured by the Specific Absorption Rate (SAR). SAR data for specific mobile phones, along with other useful information, can be found directly on manufacturers'

#### Effects by mobile radiation

The effects can be of two types - thermal and non-thermal.

One of the most common effects by electromagnetic waves is dielectric heating. When a person uses a cell phone, most of the heating effect will occur at the surface of the head.

This heating can increase your head temperature by a fraction of a degree. However this heat is less than the heat obtained by sunlight. The blood circulation isn't affected much, as the brain's blood circulation is capable enough to deal with excess heat, but the cornea of the eyes is not accustomed to a lot of heat.

#### Non-thermal effects

The communications procedure used by mobile phones often result in low-frequency pulse from the carrier signal.

"Non-thermal effects" could be reinterpreted as a normal cellular response to an increase in temperature. This heat can activate several messenger system, gene expression and production of heat shock protein in order to defend the cell against stress caused

According to a study conducted by The Journal of the American Medical Association - exposure to radio frequency signal waves within parts of the brain closest to the cell phone antenna resulted in increased levels of glucose metabolism.

In non-thermal effects, following problems can be

- Blood-brain barrier effects

- Cognitive effects

- Electromagnetic hypersensitivity like tingling sensation in the skin of the head, headache, dizziness, loss of mental attention etc.

- Sleep disorders

- Behavioural effects

Reduce the effect of phone radiation

In order to lower the effects of mobile phone radiation follow these simple steps

Keep some distance Behind every phone packaging, in fine prints most of the mobile brands recommend to keep your cell at least 10millimeters away from your body. Learn to maintain some distance with your tiny buddy. It may sound difficult but it is not impossible.

Cell phones release more radio frequency radiation when the signal is low. That means, if your signal is low avoid using your cell phone to prevent unnecessary harm.

Choose hands-free headsets Always choose hands-free headsets, as it will help to reduce the radiation emissions to the brain.

Change hands (and ears) frequently while talking on your cell phone to limit the amount of exposure to one side of your head.

Use speakers to dial numbers
The radiofrequency radiation is strongest when your phone is attempting to place a call, so hold it away from your head until you hear someone pick up.

#### Broccoli



## Himachal Pradesh cloudburst death toll mounts to 22, over 100 roads closed

New Delhi: The death toll from Spiti, two in Sirmaur and one in deploying more machinery, sniffer dog cloudburst-triggered flash floods in Hamirpur, are closed while 58 squads, drones and other Himachal Pradesh has reached 22, with rescue operations ongoing to find over 30 missing people. The flash floods were reported in Kullu's Nirmand, Sainj and Malana, Mandi's Padhar and Shimla's Rampur. The worst hit was Samej village in Rampur subdivision, where about 25 people went missing. Nine bodies have been recovered from Mandi's Rajbhan village, three from Nirmand and Bagipul in Kullu district and 10 from Samej and surrounding areas of Dhadkol, Bro and Sunni Dam in Shimla district.

Twelve out of the 22 bodies have been identified so far and DNA samples for others are being taken for identification of the bodies.Incessant rain in the state has caused landslides and the closing of over 100 roads in Himachal Pradesh.

A total of 109 roads, including 37 in Mandi, 29 in Shimla, 26 in Kullu, six in Kangra, four each in Kinnaur and Lahaul and transformers and 15 water supply schemes are disrupted, as per the state emergency operation centre.Furthermore, as the rains continued to pound the region, the local meteorological office issued an orange alert of heavy to very heavy rainfall, thunderstorm and lightning at isolated places in the state for Saturday. The weather office has also cautioned of low to moderate flash flood risk in isolated parts of Kangra, Sirmaur, Chamba, Shimla, Kullu, Kinnaur, Solan and Mandi districts in the next 24 hours. The Met also said that monsoon activity is likely to intensify in the next five to six days with fairly widespread rains.Over 650 rescuers from teams of the Army, NDRF, SDRF, ITBP, CISF, Himachal Pradesh Police and home guards are involved in the search and rescuers have intensified the search operation by

equipment.Chief of Defence Staff Anil Chauhan said that the Army has intensified its rescue operations."In response to the devastating cloudburst that struck Samej Village in Shimla, Himachal Pradesh, extensive rescue operations are currently in progress. The civilian administration has deployed 10 heavy-duty excavators to aid in the efforts. Additionally, the Army has deployed two drones to assist in the search and rescue operations. Medical assistance has been provided to 65 patients affected by the disaster. Tragically, one body was recovered near the Lunhari area in the Sutlej River by the state administration," he said. A total of 94 people were killed in rain-related incidents between June 27 and August 7 and the state suffered losses amounting to Rs 787 crore, according to the

#### Top Court To Hear Petition Seeking Postponement Of NEET-PG 2024 Today

New Delhi: The Supreme Court said on Thursday said that it will hear the petition tomorrow seeking to reschedule the NEET-PG 2024 due to the allocation of "highly inconvenient" exam centres and concerns about the normalisation of marks. Advocate Anas Tanwir, who is appearing for the petitioners, has mentioned the plea before the bench led by the Chief Justice of India DY Chandrachud and sought an urgent listing of it.CJI Chandrachud assured that the matter will be listed for hearing tomorrow. NEET-PG 2024 is scheduled to be held on August 11.

The candidates have approached the Supreme Court and preferred seeking directions to the respondents to reschedule the NEET-PG 2024 Examination on the ground that the petitioners and many similarly placed candidates have been allocated cities that are highly inconvenient for them to reach, further seeking details of the formula for normalisation of the four sets of question papers, and seeking clarity on ensuring that the normalisation formula is disclosed to the candidates, thereby eliminating any possibility of arbitrariness in the process.

The petitioners said that the allocation of test cities was made on July 31 and the specific centres are scheduled to be declared on August 8. The petitioner, while appreciating that the same has been done to curb any malpractice in the examinations, however, given such short notice, it has become highly difficult for students to make arrangements for their travel to their specific cities. The petitioners submitted that more than two lakh students are scheduled to appear in the examination. The examination is scheduled to be held in 185 test cities, therefore resulting in the nonavailability of train tickets as well as the hiking of airfares due to dynamic pricing, thereby making it almost impossible for a large number of students to reach their test centres, the petition said. The petition further submitted that the respondent had announced the date of the examination will be on August 11 and that it would be conducted in two batches."The fact that the examinations will be conducted in two batches and that the formula for normalisation is unknown to the candidates thereby causing an apprehension to the petitioners herein. There is a likelihood that one batch of candidates may face a more difficult question paper than the other batch.

### Muslim women in waqf boards, central council: Key features of Waqf bill

to take oath as the head of NEW DELHI: The Waqf (Amendment) Bill, the first major legislation set to be introduced by the Modi 3.0 government, has stirred a hornet's nest among Muslim organisations and the opposition. The bill, which aims to streamline the manner of registration of waqf properties through a central portal, was tabled by the government in Parliament on Thursday. The bill proposes renaming the Waqf Act, 1995, as the Unified Waqf Management, Empowerment, Efficiency and Development Act.

#### **BUT, WHAT IS WAQF?**

In simple terms, waqf refers to any property dedicated solely for religious or charitable purposes under Islamic law. Once a property is declared waqf, it becomes irrevocable. The amendments to the bill aim to tackle this issue. Around 30 waqf boards in the country control properties spread over 9 lakh acres, with an estimated value of Rs 1.2 lakh crore. This makes the waqf boards the third-largest owner of land in India after the Railways and Defence Ministry.

#### WAQF (AMENDMENT) BILL KEY

### Delhi coaching deaths: Probe says owners responsible, misuse of basement

New Delhi: A magisterial probe conducted in the Delhi coaching centre incident that claimed the lives of three UPSC aspirants has accused the officials of MCD's building and work department of allowing Rau's IAS Study Circle to operate a library in the basement without any proper drainage facility. In the report submitted to the Revenue Department on Wednesday, the probe stated that the "owners and management of RAU's IAS Study Circle were also responsible for the criminal negligence by indulging in dangerous misuse of the basement without regard to the lives of the students."The probe revealed that the "violation of rules" in the building was noticed before the July 27 incident by officials of MCD and the Fire Department. However, they took no action against the owner.

The report highlighted that the building where the coaching centre was housed had permissions for "office/business" use, for which no fire "NOC" was required. However, as it was used for




"educational purposes," the building required a "No Objection Certificate" from the fire department. Earlier in 2023, following a fire engulfing a coaching centre in Mukherjee Nagar, the civic body issued a notice citing "misuse" of property."The failure to seal the basement after the issue of the misuse

notice and not even mentioning the same in the show cause notice and misleading the deputy commissioner of the factual field position of misuse appears to be deliberate misconduct with malafide intentions on the part of the concerned engineers of the building department of MCD," the report was quoted by news

The Fire Department also neglected to report the "misuse" of the building's basement as a library to the MCD during an inspection on July 1 this year, it said."The fire department should not have granted a fire safety certificate dated 9.7.2024 concealing the misuse of the basement as a library in violation of the building by-laws provisions of MPD-2021. This is a serious lapse on the part of the fire services inspection team," the report noted.It also accused MCD officials of encroachment on stormwater and a lack of desilting.

The report mentioned that the drains in the area had not been desilted for the past five years, in spite of being prone to waterlogging because of their low-lying location.Delhi's Revenue Minister ordered a magisterial probe, and the preliminary report in this regard was submitted on July 29. The Central Bureau of Investigation (CBI) has taken over the case following the Delhi High Court's August 2 order.

#### RBI MPC: Real GDP growth projection for FY25 retained at 7.2%

New Delhi The Reserve Bank of India's Monetary Policy Committee (MPC) has maintained its projection for India's real GDP growth at 7.2% for FY25, despite moderating the outlook for the first quarter, Governor Shaktikanta Das announced on Thursday."Domestic economic activity remains resilient. The steady progress of the southwest monsoon, higher cumulative Kharif sowing, and improving reservoir levels bode well for Kharif output. Manufacturing activity continues to gain momentum, supported by improving domestic demand," Das said while announcing the MPC's decision to keep the benchmark rates unchanged at 6.5%. While the forecasts for FY25's second, third, and fourth quarters were left unchanged, the projection for the first quarter was reduced to 7.1%. In its June 2024 meeting, the MPC had projected India's GDP growth at 7.2% for FY25, with quarterly growth rates of 7.3%, 7.2%, 7.3%, and 7.2%. The Indian economy grew at 8.2% in FY24.

However, the Economic Survey released in July 2024 ahead of the Union Budget forecasted a more conservative growth rate of 6.5-7% for the current financial year, citing global uncertainties and domestic



challenges. Prominent global rating agencies like the IMF and ADB have projected growth at 7%.

The Survey said, "...the Survey conservatively projects a real GDP growth of 6.5-7%, with risks evenly balanced, cognizant of the fact that market expectations are on the higher side."A normal rainfall forecast by the India Meteorological Department and the satisfactory spread of the southwest monsoon so far are expected to improve agricultural sector performance and support the revival of rural demand. The Economic Survey also highlighted a bright outlook for India's financial sector but emphasized the need to remain vigilant about vulnerabilities, warning that India cannot afford overfinancialization at this stage.

It added, "With the strong financial foundation the airline has built, it anticipates a year-on-year increase of 50% in its available seat kilometers.'

The airline, which now has a market share of less than 5% in the domestic market, operated its first commercial flight on 07 August 2022 from Mumbai to Ahmedabad. Akasa now operates over 900 weekly flights across 22 domestic and five international destinations, achieving the milestone of serving over 11 million passengers in two years. In January 2024, the airline announced a firm order of 150 aircraft to support its expansion plans. In March 2024, it became the first Indian airline to fly overseas in a record period of 19 months. Vinay Dube, founder & CEO, Akasa Air, said, "In this past year, we have been India's leader in on-time performance while registering greater operational reliability, and lowest customer complaints, and cancellations in the industry.'

## Adani Enterprises to raise Rs 12K cr via QIP

#### Share sale will lead to 2.75-3.3% dilution of promoters' stake in the company

NEW DELHI. The flagship Gautam Adani Group firm -- Adani Ênterprises Ltd (AEL) – will be testing waters in the equity market for the first time since its aborted follow-on offer in February 2023. The company is planning to raise Rs 10,000-Rs 12,000 crore via qualified institutional placement (QIP) as early as September this year. Sources close to the development confirmed the plans of Adani Enterprises. As per sources, top banks like State Bank of India (SBI), ICICI Bank and HDFC Bank are likely to participate in the QIP. Some foreign banks including Jefferies are likely to participate in the current round of the fundraising.Last year, it had to scrap its



Rs 20,000 crore follow-on offer after the Hindenburg report was released on 24 January 2024. The report had levelled serious allegations of price rigging and insider trading, among others, on Adani group. AEL in May this year has decided to enter the capital market again with Rs 16,600 crore

equity fundraising plan to fund its growth plans.

QIPs are an easier way of raising money through sale of shares to institutional investors. The share sale by Adani Enterprises may lead to 2.75-3.3% dilution of promoters' shares. Currently, promoters hold 74.92% in Adani Enterprises. After the company had to cancel its FPO plans in February 2024, the US-based GQG Partners had come to its rescue and bought shares worth Rs 15,500 crore in four Adani Group companies including Adani Enterprises. Adani Enterprises houses energy & utility, infrastructure (including airports), minerals, metals and mining and direct-to-consumer businesses. AEL has a market cap of Rs 3.6 lakh crore. Its shares were trading at Rs 3,186 a piece, still 21% below its alltime high of Rs 4,019 prices achieved in November 2022. It has debt of Rs 56,664 crore as of June 30, 2024, up from Rs 50,124 crore at the end of March quarter. It has been able to improve its net debt/EBIDTA ratio from the high of 5.2 times at the end of FY22 to 2.1 times at the end of first quarter of FY25.Recently, Adani Energy Solutions (AESL) raised Rs 8,373 crore via QIP route. This marks AESL's first equity raise in capital market since its demerger and listing from Adani Enterprises Limited in July 2015.

### UPI transaction limit raised to Rs 5 lakh for tax payments

New Delhi The Reserve Bank of India (RBI) announced an increase in the transaction limit for tax payments through the Unified Payments Interface (UPI) on Thursday. The new limit is set at Rs 5 lakh, up from the previous cap of Rs 1 lakh. The increase in limit aims to simplify and facilitate higher-value tax transactions for consumers.RBI Governor Shaktikanta Das said, "Currently, the transaction limit for UPI is Rs 1 lakh except for certain categories of payments that have higher limits. We have decided to enhance the limit for tax payments through UPI to Rs 5 lakh per transaction. This will make it easier for consumers to make tax payments using UPI."The current UPI limit, set at Rs 1 lakh, has been periodically reviewed and adjusted for different types of transactions, including capital markets, IPO subscriptions, loan collections, insurance, medical, and educational services. With the new change, tax payments, which are frequent and often high in value, can now benefit from this increased limit. In addition to the higher transaction limit, the RBI introduced a new UPI feature called 'Delegated Payments.'This feature allows a



to carry out UPI transactions up to a specified limit from the primary user's bank account. The secondary user does not need a separate UPI-linked bank account. This feature is expected to boost the adoption of digital payments by making it more convenient.Governor Das also announced that the repo rate would remain unchanged at 6.5%. Alongside this, the RBI revealed several measures to enhance the digital lending ecosystem.One of these measures includes creating a public repository under a regulated entity to ensure accurate credit information. Lenders are now required to report credit information to Credit Information Companies (CIC) every two weeks, which will provide borrowers with faster updates.Furthermore, the RBI is reducing the cheque clearing cycle from two working days to just a few hours, which will speed up the process significantly. Despite the unchanged repo rate, inflation continues to be a concern. The inflation rate rose to 5.08% in June, exceeding the RBI's target of 4%. This rise, particularly in food prices, has complicated the

possibility of rate cuts. Governor Das emphasised that price stability is essential for sustained economic growth and that monetary policy must remain focused on controlling inflation. Following the RBI's announcement, there was a noticeable reaction in the financial markets. India's bond market saw a decline, with the 10-year yield increasing by 2 basis points to 6.88%. The rupee's value remained stable, but the benchmark NSE Nifty 50 Index fell by up to 0.7%.

This policy decision comes amid global market volatility, influenced by recent actions from central banks in advanced economies. The Bank of England reduced interest rates last week, and there is increasing pressure on the Federal Reserve to lower rates to

#### RBI proposes to reduce cheque clearance time to a few hours

New Delhi. The Reserve Bank of India (RBI) has announced a major change in the chequeclearing process.

RBI Governor Shaktikanta Das announced this new initiative during the Monetary Policy Committee (MPC) meeting announcement.

The new system aims to cut the time needed for cheque clearing from the current two-day period to just a few hours." Cheque Truncation System (CTS) currently processes cheques with a clearing cycle of up to two working days. To improve the efficiency of cheque clearing and reduce settlement risk for participants, and to enhance customer experience, it is proposed to transition CTS from the current approach of batch processing to continuous clearing with 'onrealisation-settlement'. Cheques will be scanned, presented, and passed in a few hours and on a continuous basis during business hours. The clearing cycle will reduce from the present T+1 days to a few hours," said a RBI press release. Governor Shaktikanta Das explained that the updated system is designed to simplify and speed up the cheque-clearing process. This move addresses long-standing delays in fund transfers and aims to make transactions more efficient overall."At present, cheque clearing through Cheque Truncation System (CTS) operates in a batch processing mode and has a clearing cycle of up to two working days. It is proposed to reduce the clearing cycle by introducing continuous clearing with 'on-realisationsettlement' in CTS. This means that cheques will be cleared within a few hours on the day of presentation. This will speed up cheque payments and benefit both the payer and the payee," said the RBI Governor. With this new system, account holders can expect faster processing of cheque-based transactions. This change will allow funds to be credited more quickly, which is beneficial for urgent payments and better financial planning. Both individuals and businesses will see improved liquidity and a more efficient banking experience. The Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) opted to maintain the key repo rate at 6.5%, continuing its focus on the 'withdrawal of accommodation'. This marks the ninth consecutive meeting in which the central bank's six-member MPC has decided to keep the key policy rates unchanged.

RBI Governor Shaktikanta Das said four members of the 6-member MPC voted in favour of keeping the policy reporate unchanged at 6.5%.

# RBI retains FY25 inflation projection at 4.5%, warns against 'food price shocks'

RBI Governor Shaktikanta Das stressed the need for vigilance to prevent the spillover effects of persistent food inflation and to preserve the gains made in monetary policy credibility.

New Delhi. The Reserve Bank of India (RBI) has maintained its inflation forecast for the current fiscal year at 4.5%, despite ongoing concerns about food prices and geopolitical tensions that could impact crude oil prices.RBI Governor Shaktikanta Das stressed the need for vigilance to prevent the spillover effects of persistent food inflation and to preserve the gains made in monetary policy credibility. The central bank has now projected inflation for the second, third, and fourth quarters of FY25 at 4.4%, 4.7%, and 4.3%, respectively.

In its June policy, the inflation forecasts were slightly lower at 3.8%, 4.6%, and 4.5%, respectively. Inflation stood at

4.9% in the first quarter of FY25.Additionally, the RBI has provided its inflation forecast for the first quarter of the next fiscal year, pegging it at 4.4%.

Das mentioned that while the Monetary Policy Committee (MPC) might overlook temporary spikes in food inflation, it cannot afford to do so if the inflation persists. The RBI Governor said the MPC remains focused on inflation and supporting price stability to ensure growth, highlighting that inflation is moderating, but the pace is slow. Kapil Gupta, Executive Director- Research, Nuvama Institutional Equities, said, "The RBI policy was largely a status quo policy, both on rates and stance. Policymakers remain comfortable with the evolving growth trajectory and emphasized that RBI remains resolute in aligning headline inflation to the target of 4% on a durable basis.""While core inflation is benign, the stubborn food inflation poses the risk of second round effects and there requires constant vigil.



Thus, policymakers are in no rush to lower their guard as of now. Trajectory of domestic food inflation and evolving path of the Fed rate are the key monitorables in the near-term," he added.

#### RBI MPC policy rate decision

With a four-to-two majority, the RBI's Monetary Policy Committee decided to keep the repo rate unchanged at 6.5% for the ninth consecutive time. The decision comes amid speculation that the Federal Reserve may cut rates in September due to weak jobs data, raising concerns about a potential recession in the world's largest economy. However, Das reiterated the RBI's stance of not mirroring developed

world policies and basing decisions on domestic factors like recent bountiful rains and other local conditions.Das noted that while India's growth remains robust and core inflation has moderated to historic lows, fuel group disinflation could reverse in the coming quarters due to the base effect wearing out.He acknowledged that high food price momentum likely continued in July, slowing the

disinflation process in the first quarter of FY25. The MPC must carefully consider the impact of food inflation, given its significant role in overall inflation.Experts have highlighted that higher food inflation could prevent overall inflation from declining significantly. The cost of key vegetables like onions, tomatoes, and potatoes has risen, with a Crisil analysis indicating that the cost of a vegetarian thali in India increased by 11% sequentially in July. Concerns about weather variations impacting inflation and economic stability persist.

#### Rohit Sharma on India's batting debacle vs Sri Lanka: Weren't smart against spin

New Delhi. Rohit Sharma said that India lacked smartness while batting against spin in the ODI series against Sri Lanka. On Wednesday (August 7), the Men in Blue slumped to a massive 110-run defeat in the third game at the R Premadasa Stadium in Colombo. After being asked to chase down a target of 249, the visitors were bowled out for 138 in 26.1 overs. Rohit praised Kusal Mendis and Avishka Fernando for manipulating the field to good effect by playing sweeps, paddle sweeps and reverse sweeps. Fernando's 96 and Mendis' 59 laid the platform for the home team. They also put on a partnership of 82 runs for the second wicket. On the back of their performance, Sri Lanka won the series 2-0. They were consistent with sweeps, taking their chances. There weren't a lot of runs scored down the ground. They didn't use the feet as much as we expected. It was about using sweeps and piercing that deep square leg and midwicket field. That is something we failed to do as a batting unit. We didn't play enough sweeps, reverse sweeps, or paddle sweeps, and used our feet too much. That was the difference," Rohit said after the match."If you look at Kusal Mendis and Avishka Fernando today [who put on an 82-run stand], they got a lot of runs square of the wicket. They were using the turn, and sweeping, making the fielder move left and right. They were smart with how they batted and we were not,"

It is a part of the game, we all sometimes win and sometimes lose," Mirabai told after her campaign."Next time I will work harder to win a medal for the country. I will try my best and will deliver my best performance in the next game," Mirabai added.Interestingly, Mirabai finished only a point less than Thailand's Surodchana's tally of 200 (88 in snatch and 112 in clean and jerk).

As the flash of red, white and blue streaked past one sprinter then the next, then the next - the American man delivering the latest out-of-nowhere comeback on the track said he had one thing going through his mind: "Get home, son! Get home, son!"Quincy Hall got home in first, then fell to the ground and did snow angels. Just another routine day in a comefrom-behind kind of Olympics for the USA.

Hall reeled in three runners down the stretch of the 400-meter final Wednesday to deliver another heart-stopping win for his country at the Stade de France. He finished in 43.40 seconds, beating Britain's Matthew Hudson-Smith by .04 seconds; they are now the



fourth- and fifth-fastest men in history at the distance.Hall's late push came the evening after American Cole Hocker rocked his sport by coming from way back to beat the favorites in a memorable men's 1500.

### After Vinesh Phogat's disqualification, Sarah Hildebrandt wins wrestling gold

Paris Sarah Hildebrandt of the United States put a chaotic morning behind her to win the women's 50kg freestyle event, after Vinesh Phogat's disqualification from the bout on

Wednesday, 7 August in Paris. Hildebrandt was originally scheduled to meet Vinesh Phogat in the gold medal match but the Indian was disqualified for being overweight. Cuba's Yusneylys Guzman, who lost to Phogat in Tuesday's semi-finals, was promoted instead and Hildebrandt prevailed 3-0 to win the gold after claiming bronze in Tokyo three years ago."My mind and body are not computing everything, especially with the chaotic morning I had with the change of opponent," Hildebrandt said at the mixed zone

while nibbling a muffin."It was very strange, like 'Oh my god, I just won the Olympics'" she said of the assumption she had prevailed by forfeit. "So there had to be a reset. I took a nap, woke up, and it was like a fever dream."Earlier in the day, Vinesh Phogat was disqualified from the women's 50kg wrestling final at the Paris Olympics. The 29-year-old was found ineligible to compete on the second day as she was found



100 grams overweight during the weigh-in on the day of the final. Despite the best efforts from Vinesh Phogat's team on Tuesday night, the wrestler missed the weight on Wednesday. Vinesh Phogat was in the 50kg permissible limit on Tuesday. She stunned World No. 1 Yui Susaki in the opening round before working her way through in the quarter-final and the semifinal to become the first-ever Indian woman to reach the Olympic wrestling final. The

Indian Olympic Association (IOA), in an official statement, confirmed the disqualification. It also requested all stakeholders to ensure Vinesh Phogat's privacy. The International Olympic Committee confirmed Vinesh Phogat's disqualification, confirming that Cuba's Yusneylis, who lost to Vinesh in the semifinal, will play the Gold medal match.

However, Vinesh's uncle, who gave wings to her dreams to become a wrestler, felt that this decision had come out of sheer disappointment from her."She informed about the news early in the morning at 5:00

am. This announcement could have come because of the kind of mental state she must be in after losing out on a medal despite coming so close. After meeting Vinesh, will make her sit and explain to her to change this decision and work hard on herself. Whenever anyone reaches this close a medal win, they can take such a kind of decision out of anger," Mahavir uncle said while speaking exclusively to India Today.

#### Vinesh to play LA Olympics 2028? Mahavir uncle also mentioned that him

alongside other wrestlers, including Bajrang Punia would urge her to come out of retirement and participate in the LA Olympics 2028This was her third Olympics and being this near to good broke her heart. This is common that any athlete who could do this in anger. When she returns, we all me, Bajrang Punia and others will, motivate her for the upcoming 2028 Olympics. In 2016, she could not win the Olympics due to injury. In 2020 and 2024, she was under pressure due to protests against the federation and Brij Bhushan. I think court could give her respite, but it's hard."He also wants to prepare his younger daughter for the



upcoming Olympics in 2028 and asked the female wrestlers to give their everything for the next Games."In the future I will talk with Sangeeta, my younger daughter to prepare for the Olympics. Will make 100 Vinesh Phogat who will be winning medals in the Olympics. I want to say women wrestlers that start preparing for the 2028 Olympics and appeal to coaches to train athletes with

discipline. There is no conspiracy. They have their rules and this happened according to rule book." Mahavir uncle said.

There was a sense of disappointment, dejection and sorrow on Mahavir uncle's face after the grappler was disqualified, as he broke down soon after.
