5 killed in rain-related incidents New Delhi, August 1: Several parts of Delhi remained waterlogged on Thursday, a day after heavy showers unleashed chaos in the city, officials said, adding that five people had died in separate rain-related incidents so far. Six weather stations across Delhi recorded over 100 mm of rain in a single day, the India Meteorological Department (IMD) said on Thursday, categorising it as an "extremely intense spell". According to the IMD, the city's primary weather station, Safdarjung, recorded 107 mm of rainfall in the last 24 hours. Other stations, which also received significant rainfall are Mayur Vihar (147 mm), Najafgarh and Ridge (113 mm), Lodi Road (106 mm) and Delhi University (104 mm), it said. Rajinder Nagar area, which has become the epicentre of protest following the death of three civil services aspirants in a flooded basement of a coaching centre, was heavily waterlogged on Wednesday, with MCD officials toiling till early hours to pump out the water. Students continued to protest despite the adverse weather conditions demanding accountability from authorities. Till midnight, the Delhi Police received 26 calls of building collapse and one more such incident was reported till 7 am on Thursday, data showed. 

New Delhi, August 1:The Supreme Court reserved its order on the issue of whether royalty levied by the Centre on mines and mineral-bearing lands since 1989 will be refunded to the states. In a significant verdict on July 25, a nine-judge Constitution bench headed by Chief Justice D Y Chandrachud, by a majority 8:1 verdict, had held that the legislative power to tax mineral rights vests with the states and the royalty paid on minerals is not a tax. The verdict, which gave a huge revenue boost to mineral-rich states, however, led to another dispute with regard to the operation of the verdict. A nine-judge Constitution bench headed by Chief Justice DY Chandrachud reserved its verdict after hearing the arguments of the Centre, states and mining companies on whether its July 25 verdict giving states legislative competence to impose tax on mineral wealth will have prospective or retrospective effect. The bench also comOka, JB Pardiwala, Manoj Misra, Ujjal Bhuyan, Satish Chandra Sharma and

Augustine George Masih was told by Solicitor General Tushar Mehta, appearing for the Centre that making the July 25 verdict retrospective will have cascading effects on common person as companies will pass on the financial burden on them. The Centre opposed the plea of the mineralrich states seeking refund of the royalty levied by it on mines and mineral-bearing land since 1989, saying any such order asking it to pay the alleged dues with retrospective effect will have a "multipolar" impact. Senior advocate Rakesh Dwivedi, appearing for Jharkhand mineral development authority, urged the court to make the July 25 verdict retrospective and direct for refund of the royalty in a staggered manner. Some opposi-

prising Justices Hrishikesh Roy, Abhay S the top court to make the verdict operational with retrospective effect so that they can seek refund of royalty from the



Centre. However, the Centre opposes any such order saying it will have a "multipolar impact". Many firms involved in mining activities also support the Centre's view on refund of royalty to mineral-bearing states. The Solicitor General said

states like Madhya Pradesh and Rajasthan, which are ruled by the BJP, wanted the judgement to be made applicable prospectively. The BJP-ruled Odisha government did not take any clear stand despite being prod-

ded by the bench and the counsel appearing for the state only said they don't want the exchequer to feel the burden. The 200-page majority verdict was penned by the CJI for himself and on behalf of the bench said, "Royalty is not a tax. Royalty is a contractual consideration paid by the mining lessee to the lessor for enjoyment of mineral rights. The liability to pay royalty arises out of the contractual conditions of the mining lease. The pay-

ments made to the government cannot be deemed to be a tax merely because the statute provides for their recovery as arrears." However, Justice B V Nagarathna had dissented and said the

AFT's larger bench rules that tribunal has powers of contempt, giving it teeth to get orders implemented

Chandigarh, August 1:A larger Bench of Armed Forces Tribunal (AFT) ruled that it possesses the powers of contempt to get its orders implemented in case there is wilful non-compliance by the respondents. The judgment will now give muchneeded teeth to AFT to get its orders, which in many instances were being ignored by the Ministry of Defence (MoD), implemented. The larger bench was constituted in the year 2014 when a two-member bench at Delhi had expressed apprehensions in following a judgment of the Kerala High Court which had directed the Kochi Bench to invoke powers of contempt in case of non-compliance by defence authorities. The landmark judgment running into more than 500 pages with appendices and perhaps the longest in

the tribunal's history, interpreted Section 29 of the AFT Act and Rule 25 of the AFT Rules to hold that the legislature did not intend keeping the AFT toothless. The Bench, comprising Justice Anu Malhotra, Lt Gen CP Mohanty and Rear Admiral Dhiren Vig observed that more than 5,000 of the Tribunal's orders are lying unimplemented without any stay from the High Court or the Supreme Court. The bunch matter referred to the larger bench included cases filed by Lt Col Mukul Dev in the year 2014 at the Kolkata Bench and suo-moto contempt proceedings initiated by the Chandigarh Bench. 

Lake stock swells to 77% from 5% in 1 mth

Mumbai. The city recorded its second highest ever rainfall for July this year. Till Wednesday, IMD's Colaba observatory had recorded 1,909mm rainfall this season, which was 632mm above normal, while the Santacruz observatory recorded 2,050mm, 657mm above normal.

In its forecast for the next five days, IMD has issued a yellow alert for Mumbai from Aug 1 to 3. A yellow alert indicates the likelihood of heavy rain at isolated places. Meanwhile, an orange alert has been issued for Aug 3 for Thane and Palghar, indicating heavy to very heavy rainfall at isolated places

This month has been good for the city, with lakes also having received a bountiful amount of rain, increasing water stocks from 5% to 77% now. On Wednesday, the total water stocks in the seven lakes that supply the city stood at 11.2 lakh million litre or 77.3%. The lakes need 14.5 lakh million litre of water for the city to go without a water cut until the next monsoon season arrives. When the month of July began, water stocks in the lakes had stagnated at 5.9%

On Wednesday in the nine hours ended 5.30pm, IMD's Santacruz observatory recorded 2.6mm rainfall and the one at Colaba negligible or trace rain activity.

Mumbai rain: IMD issues red alert for Mumbai, Thane and PalgharMumbai experienced heavy rain on Thursday, prompting a 'red alert' from the weather bureau. Not just the city, but the suburbs and nearby areas also saw significant rainfall. Thane recorded the highest with 163mm, while various places noted triple-digit rainfall totals.112009759

IMD issues red alert for Delhi NCR after heavy rains, waterlogging at several placesThe India Meteorological Department issued a red alert for Delhi and surrounding regions due to heavy rainfall, leading to severe traffic and waterlogging. Flights were diverted, and significant areas like Parliament faced flooding. Authorities recommended residents stay indoors and avoid unnecessary travel. Conditions are expected to persist until August 5, with further rain forecasted for neighboring states.

Telangana HC upholds death to man who raped, killed 6-year-old

HYDERABAD. Terming it "the rarest of the rare", the Telangana High Court on Wednesday upheld the death sentence of a migrant worker awarded for raping and murdering a six-year-old girl in Narsingi in 2017. A division bench, comprising justices P Sam Koshy and Sambasivarao Naidu, dismissed the appeal filed by the petitioner against the sentence originally handed down on February 9, 2021. The convict, Dinesh Kumar Dharne (23 at the time), had lured the victim under the pretext of buying her chocolates from a nearby kirana shop. However, he took her to a secluded area where he raped her twice. Fearing that she would reveal the crime to her parents, he later bludgeoned her to death. The victim's parents hailed from Bihar and had migrated to the city for livelihood. They were familiar with the Dinesh as they worked together at a construction site under the Cyberabad police commissionerate limits. After their girl went missing, they filed a complaint at Narsingi police station, following which the accused was detained. Earlier, the Metropolitan Sessions Judge, Cyberabad, at LB Nagar, Rangareddy district, found him guilty and sentenced him to death. Dharne challenged the verdict by filing a criminal appeal. However on Wednesday, the high court upheld the death sentence.

Administer TB BCG vaccine to curb disease in adults: Andhra health commissioner

VIJAYAWADA. Commissioner of Health and Family Welfare C Hari Kiran instructed officials to achieve targets in administering the Bacillus Calmette-Guérin (BCG) vaccine to prevent tuberculosis (TB) and other mycobacterial infections in adults. He also directed them to design Ayushman Bharat Health Account (ABHA) ID numbers while administering the vaccine.

During a review of the National TB Elimination Programme with the departmental officials at the Health and Medical Department's headquarters on Wednesday, he stated that 17.78 lakh people have been administered the TB BCG vaccine to date. Efforts must continue to achieve the target of vaccinating 50 lakh individuals.

He suggested approaching industrialists to supply nutritional food baskets to TB patients and directed district officials to collaborate with district industrial departments for effective implementation of the food basket distribution program. He also instructed the preparation of proposals for setting up additional laboratories as needed.

He further noted that 35 per cent to 40 per cent of people are affected by TB annually across the country and stressed that all efforts should be made to make the State TB-free by 2025. Proposals for filling vacant positions in the TB department should be prepared, he added.

State TB Joint Director, Dr T Ramesh, said 84,000 TB cases were detected last year in the State, and 43,000 cases were detected from January to June this year. He said 94% of patients were treated and cured.

Extended green line to open on Tumakuru road by October-end

BENGALURU. The extended Green Line of Namma Metro on Tumakuru Road from Nagasandra to Madavara (BIEC) is expected to commence commercial operations by Oct. Maheshwar Rao, MD of Bangalore Metro Rail Corporation Limited (BMRCL), told TOI trial runs will shortly start on the 3-km

The extended line, which is part of phase II of Namma Metro has three new stations at Manjunathnagar, Chikkabidarakallu and Madavara. The line will be opened after obtaining safety clearance from the Commissioner of Metro Railway Safety (CMRS), which officials hope will happen by Sept. This will increase Metro's network to 76km in the city.

"On the Green Line, at present, trains terminate at Nagasandra on Tumakuru Road. Once the extended line becomes operational, trains services will be operated till Madavara. However, depending on the patronage, a decision will be taken on frequency of services," a BMRCL official said. BMRCL anticipates the extended service will help them gain an additional ridership of 25,000 to 30,000.Regarding the status of construction works at Madavara, an official said, "Work is nearing completion at Madavara. Traction power supply is done in other two stations and will be done shortly at Madavara. We are getting ready for trial tests on the line; it will happen in the next couple of weeks.

How it will benefit

Extending the Metro line to Madavara will benefit Bengalureans in several ways. It will provide seamless access to

Bangalore International Exhibition Centre, which is a prominent venue hosting consumer and industrial expos. People coming from Nelamangala and nearby villages in KSRTC buses and others will be able to travel by Metro to reach various points within the city, avoiding traffic congestion. Providing parking space for long-distance buses at Madavara station will

help passengers use the Metro with ease. Under Phase II, BMRCL has extended its two operational lines in four directions. Three of these extensions, from Mysuru Road to Challaghatta (on Mysuru Road), Yelachenahalli to Silk Institute (on Kanakpura Road), and Byappanahalli to Whitefield, have already been opened for commercial operations in a phased manner.

BMRCL had previously set multiple deadlines to open this line, but factors such as delays in construction, land acquisition issues with NICE authorities and the pandemic affected the project's

The other three Metro lines being constructed under phases II, II A and II B are new lines from Kalena Agrahara to Nagawara, RV Road to Bommsandra, and Silk Board to Kempegowda International Airport.

A decade ago, the transport department and traffic police considered shifting private bus operations to points such as Kengeri, Madavara and KR Puram, but the plan was eventually dropped. Once BMRCL opens Yellow Line from RV Road to Electronics City, people will be able to travel from Madavara to Electronics City. BMRCL will provide an interchange facility at RV Road station that links Green and

Digital evidence gives Kollam doctor away

THIRUVANANTHAPURAM . The police relied on CCTV visuals and digital evidence to identify the culprit – a 38year-old female medical practitioner who had allegedly fired at a female staff of the National Rural Health Mission (NRHM). Dr Deepthi Mol Jose, who worked as a pulmonologist at a private hospital in Kollam, was nabbed from her quarters at Parippally on Tuesday evening. Her arrest was recorded later in the day.

Police sources said Deepthi and Shini, who was injured after being shot at using an air gun, knew each other. It was the past relationship Shini's husband had with Deepthi that proved to be the bone of contention between the two. Shini's husband had earlier worked in Kollam and was in contact with Deepthi, who is also



married. The relationship later soured and Deepthi decided to exact revenge on Shini's husband by attacking her.

Even as the police managed to obtain some information regarding this past episode connecting the two women, CCTV visuals threw up details of the assailant. The police had found that the assailant had fled to Kollam in her car after the attack. Once her identity was confirmed, the cops

searched for digital leads and learnt that Deepthi had ordered an air gun, which do not require a licence to operate, from an ecommerce platform.The air gun was purchased a few months back and since then the doctor was watching videos online to learn how to operate it. The cops proceeded to round up the doctor who confessed to the crime after being shown the mountain of evidence against her, a police source said. Sources added that Deepthi had recced Shini's house several times to draw an action plan. It was during one such clandestine visit that she noticed that couriers were regularly being sent to Shini. And she decided to disguise herself as a courier delivery person to enter the premises of Shini's house and target her. Shini was attacked on Sunday morning.

Bengaluru: Rift in the open? JD(S) pulls out of padayatra, BJP in a fix

BENGALURU. Hours after ally JD(S) withdrew from the proposed Bengaluru-Mysuru padayatra that was to begin on August 3, BJP was on Wednesday uncertain about the seven-day march, which aims to demand CM Siddaramaiah's resignation over Mysore Urban Development Authority (Muda) scam. "There's confusion between JD(S) and BJP over the padayatra.

Our national leadership is in clearing that confusion. I'm confident the padayatra will go on as per plan," stated BY Vijayendra, state BJP chief. However, some BJP functionaries hinted the rally might be postponed by a week. Union minister HD Kumaraswamy, also state president of JD(S), has refused to support the padayatra, expressing anger over invitation to Preetham J Gowda, the former MLA of

Hassan.Kumaraswamy was present at the BJP-JD(S) meeting on Sunday that finalized the padayatra plan. On Wednesday, he expressed frustration that neither he nor his party functionaries were consulted on the padayatra schedule. "From Bengaluru to Mysuru, it is JD(S) which is strong. How can you neglect us or take such a decision without consulting us?" he said.Kumaraswamy asked whether he should share the stage with the person (Preetham Gowda) who "poisoned the Deve Gowda's family"

When they (BJP) are not ready to take us into confidence, then why should we give support to them? They must tell us how they treated us regarding the padayatra. What are they trying to achieve? I'm hurt, it pains me. Who is Preetham Gowda? He's the one who

tried to destroy the Gowda family. They (BJP) bring him on stage and make him sit with me. Who is responsible for the distribution of those pen drives (in Prajwal Revanna's case)? Don't they (BJP) know what happened in Hassan? Electoral alliance is different, and politics is different," Kumaraswamy said. When the people are suffering due to heavy rain and floods, going on padayatra is not right. "We've decided to distance from it, we won't even extend moral support," said Kumaraswamy. Byju's settles row with BCCI, not off the hook yet

Mumbai/Chennai. Troubled edtech startup Byju's and BCCI have arrived at a settlement over a dispute related to the non-payment of Rs 159 crore in dues that the company owed the cricket governing body, the firm's lawyers told the National Company Law Appellate Tribunal (NCLAT) on Wednesday. The settlement of the dispute creates scope for Byju's to escape insolvency. The once high-

flying startup, however, has been denied immediate reprieve by the appellate tribunal. Founder & CEO Byju Raveendran's brother & company board member Riju Ravindran has raised funds to clear the dues, the first tranche of which amounting to Rs 50 crore

has been paid. Byju's counsel said that the

money is not coming from the corporate debtor's (Byju's) account and nothing "precludes him (Riju) from making this payment". The full amount will be paid in three tranches by Aug 9. The NCLAT deferred accepting the settlement and instead directed Byju's to file an undertaking (to the court), providing the source of funds to BCCI after the company's US-based lenders argued that the source of the money is "tainted" and the court should not "bless" this transaction of settlement.

Senior lawyer Mukul Rohatgi, appearing for Byju's overseas lenders, questioned the company's and its promoters' ability to pay the funds to BCCI when they couldn't even pay salaries to employees. The missing \$533 million (part of the \$1.2-billion term loan proceeds) which the lenders have accused Byju's of hiding was once again at the forefront of the legal argument put forth by them at the NCLAT.

"The missing \$533 million is likely the debtor's only way to pay creditors. This is my money," Rohatgi said. The lenders also argued that payment of operational creditor (BCCI) over financial creditors violates the provisions of the Insolvency and Bankruptcy (IBC) Code. The court adjourned the case to Aug 1. had reported that BCCI and Byiu's were close to resolving the dispute and the company has transferred Rs 50 crore to BCCI on Tuesday. BCCI's lawyers said that the board doesn't condone any kind of illegal activity and the first tranche of payment has been made to them by way of banking

Byjus founder reaches settlement with BCCI over pending duesByju Raveendran agreed to settle Rs 159 crore dues with BCCI, raising questions about the source of funds. Raveendran assured the National Company Law Appellate Tribunal that payments would be made in two tranches, while USbased lenders opposed the settlement, highlighting earlier fund transfer issues. His brother Riju Raveendran will raise the necessary funds.

Haryana: Teaching for 10 years? You can now apply for govt awards

GURGAON. CM Nayab Saini has approved amendments to the state govt's policy for awarding prizes to teachers working in state universities, govt colleges, and govt-aided private colleges for their exemplary services. According to the amendments, 15 years of service has now been reduced to 10 years. The decision by the govt will provide an opportunity for newer teachers to receive the awards as well. A spokesperson for the higher education department stated that the state govt has implemented a scheme to award State Teacher Prizes for outstanding and commendable services rendered by educators working in various state universities, govt colleges, and govt-aided private colleges in recognition of their contribution towards academic, curricular, and extracurricular assignments. The objective of these awards is to honour faculty members for their exceptional performance in the field of teaching. He said further that teachers would be honoured with a total of 14 state awards - two awards for state universities under the ambit of higher education, eight for govt colleges, and four for govt-aided private colleges - every year for their excellent services.

The award winners will receive a cash prize of Rs 1 lakh and a letter of appreciation, the spokesperson said. The spokesperson further added that teachers awarded once will not be eligible for the award again. Teachers will be scored out of 200 points in four levels based on their academic excellence and service record, extracurricular achievements and contribution to society, contribution to institutional development, and research work over the past 10 years.

Newborn treated for rare congenital condition

Gurgaon: A newborn girl has successfully been treated for a rare congenital condition gastroschisis — at a city hospital. The condition, which results in a baby being born with with intestines outside the body through an aperture in the abdominal wall near the umbilical cord, can be life-threatening if not surgically corrected immediately after birth, doctors said.

The mother, Sakshi Shukla (36) from Punjab, was alerted about the congenital defect in the foetus during the level-2 scan, which is conducted at 18-20 weeks of pregnancy, following which she came to Medanta -The Medicity and settled in the city for treatment given the high-risk pregnancy.

A multidisciplinary team of doctors, spearheaded by Dr Shandip Kumar Sinha (director, paediatric surgery), Dr Preeti Rastogi (director, obstetrics and gynaecology) and Dr T J Antony (director, neonatology), collaborated seamlessly to save the baby.In India, the overall survival rate of children with gastroschisis is 45% whereas in Western countries, it is 90%. "When the natient came to us at 26 weeks we first ruled out any associated developmental problems. We recommended close followups. At 37 weeks, she underwent an elective Caesarean section earlier this month," Dr

"After emptying the meconium (the first stool of an infant) and mobilising the delicate skin flap, we were able to create space for intestine to be placed inside abdominal cavity. The entire surgery took 1 hour 30 minutes and there were no post-operative complications," Dr Sinha said. The baby was discharged 12 days after the surgery, he

Housing board hikes circle rates for plots in 2 townships

Ghaziabad: Plots in Vasundhara and Siddharth Vihar are set to get dearer as the UP Housing Boarding recently increased the circle rates for the two townships under its jurisdiction by nearly 10% to 15% for the current financial year. Nabendra Bahadur, an estate manager of the housing board, told TOI the market rates for plots in the areas in and around the influence zone of the Delhi-Meerut rapid rail corridor have shot up due to a discernible increase in demand, necessitating a revision in the circle rate. Circle rates for the two townships were increased by over 3% in the previous fiscal year even before commercial runs on the corridor began in Oct 2023. Currently, nearly 50% of the 82km corridor is operational.On Tuesday, the stamp and registry department also proposed to increase the circle rate by 20% across residential and commercial categories citing rapid infrastructural development in the city.

Of the 19 sectors in Vasundhara, the hike is specifically steep for the odd-number ones where the circle rate will go up by nearly 15% — about Rs 11,100 per sqm — as the new rate comes into effect retrospectively from April 1, Bahadur said. "After the revision, the cost of plots in the odd sectors will stand at Rs 73,000 per sqm, up from Rs 61,900 per sqm. In the even sectors, the rates have been hiked by Rs 6,700 per sqm, about 10%. So, one will have to pay Rs 75,000 per sqm instead of the previous Rs 68,300 per sqm," the official said. The housing board, which is planning to develop 80 acres of land in sectors 7 and 8, both under the rapid rail's transit-oriented development (TOD) zone, is set to benefit from the recent hike.

Year on, no verdicts in Nuh riot cases, most accused out on bail in Gurgaon

GURGAON. A year since the Nuh riots which broke out during a religious procession on July 31, killing six people and leading to mob violence in Gurgaon and other districts - trials are progressing slowly and none of the 60 cases filed by police has reached the verdict stage. After the riots, 49 cases were filed in Nuh for rioting and 11 cases for provocative speeches and social media posts, leading to the arrest of 441 people. At present, 405 of them have been released on bail. The absence of a dedicated court for the riots cases has led to hearings making slow progress. Proceedings have also been affected by the reluctance of witnesses to depose before courts, fearing for their safety. As many as 20 Whats App groups had come under the scanner of investigators for their alleged involvement in the July 31, 2023 violence, and Nuh police had carried out three encounters to make arrests.

Nuh SP Vijay Pratap Singh said those who were found to be involved in the riots were arrested after questioning. "Chargesheets have been filed and cases are in court. Initially, very few people were named in the FIRs, but after questioning, many more names came up and a large number of people were arrested," Singh said.

A public prosecutor said one significant factor contributing to the delay is the lack of special courts for handling the riot cases, which are now scattered across 5-6 courts.



The trials, which are proceeding in an isolated manner, should be fast-tracked. Most accused, who are out on bail, are not appearing for the trial even after nonbailable warrants have been issued against them. Many new names have been added to the cases, but most of them have not yet been arrested. There are no consolidated numbers of arrested people, those who have granted bail, the number of people still on the run, and non-bailable warrants that have been issued. Multiple sets of officials from police and prosecution are dealing with these cases," he said.

Manish Shandilya, counsel for some of the victims, said the trials may take much longer as witnesses are apprehensive about visiting Nuh to record their statements in court. "They fear for their safety. Also, there are many witnesses who are yet to be traced. It will be difficult to have a fair trial. Tracing witnesses from across Haryana and nearby states and bringing them to court is timeconsuming," Shandilya said.

He also pointed out there is a lack of zeal on the victims' side to pursue the cases. "Most victims are from outside Nuh. It is a challenge for their families to travel to Nuh for court hearings which will take years. They are also not comfortable visiting a place that is hostile towards them," he added.Chargesheets filed by the police in all the cases has a common thread on the cause of violence - anger against Bajrang Dal members due to the alleged

murder of Junaid and Nasir, two Rajasthan residents who were kidnapped by cow vigilantes near the Haryana border in Nuh, last Feb and provocative social media posts by cow vigilantes Monu Manesar and Bittu Bajrangi UAPA sections added to four FIRs

Police had in Feb this year added stringent sections of UAPA to four cases, one of which was registered against Congress MLA Mamman Khan along with 43 others. Khan was accused of distributing Rs 500 each to rioters through a village sarpanch and orchestrating objectionable social media posts and provocative messages on WhatsApp groups to incite people. Tahir Hussain Rupadiya, counsel for Khan, said the addition of UAPA sections came to light when police filed their reply after the court asked them for a status report of cases in Jan. "Till now, police have added sections of UAPA to

four FIRs," said Rupadiya.

Gurgaon municipal body set to pay cos Rs 2.3 crore for garbage collection, transportation

GURGAON: MCG is set to pay Rs 2.3 crore to agencies for the collection and transportation of waste to the Bandhwari landfill site. The agencies hired by the corporation for secondary collection have transported 58,701 metric tonnes of garbage to Bandhwari so far since the implementation of Solid Waste Environment Exigency Programme (SWEEP). According to Nijesh Kumar, MCG executive engineer of Swachh Bharat Mission, "Under SWEEP, 58,701 MT of garbage was collected from various secondary garbage collection points in July and sent to Bandhwari landfill site. The work was assigned to the agencies at the rate of Rs 390 per tonne." The agencies were instructed to unload the garbage



using a dozer and poclain machinery, officials said. "MCG would pay Ecogreen around Rs 3 crore every month for the Gurgaon's waste management,' added executive engineer Kumar.

Gurgaon: Stretch on key NH8 link riddled with craters, commute a nightmare now

GURGAON. Residents have raised concerns about the dilapidated condition of a stretch of the key Rampura-Pataudi Road near Bestech Ananda in Sector 81.

The 120m stretch has numerous potholes and uneven surfaces, making it difficult for commuters to navigate safely on the stretch. This has led to several accidents and frequent traffic jams in the area, residents said. Though redevelopment of the 5.6km road - which links new sectors to NH-8 - began in Feb 2022 with an Aug 2023 deadline, GMDA has not been able to revamp the road as planned, missing several deadlines.Officials have cited ongoing litigation as one of the main reasons for the delay. Delays in acquisition of two stretches of 100 metres

and 120 metres, along with the removal of a temple structure, have hindered progress, they said. The redevelopment project, estimated to cost Rs 66 crore, aims to widen the existing four-lane road into a six-lane main carriageway.The design includes service roads, cycle tracks, footpaths, and green areas, promising enhanced traffic flow and safety for commuters and residents.

Residents criticised GMDA's "indifferent attitude". "For us, commuting is a struggle every day. Due to the rains, several potholes have formed on the road, which are not just causing inconvenience but pose a serious safety hazard too. Those on two-wheelers are the worst affected. Several accidents have been reported here. When will GMDA wake up from its deep slumber?" questioned Kumar Ashok, president of Bestech Grand Spa RWA.Dharamvir Singh, president of Mapsko Casabella RWA, urged the authorities to work together to find a solution. "If there are problems, officials need to resolve them and provide some relief. The GMDA is shirking its responsibility by blaming litigation."GMDA chief engineer Arun Dhankar said two patches on the main carriageway are under litigation."A depression has formed near Sector 81, leading to water accumulation and deterioration of the road," he said. Asked about completion of the project, he said: "Besides pending litigation.

Gurgaon's air this July worst in 4 years, reveals CPCB data

Gurgaon. The city's air pollution levels in July were the highest since 2021, a report by the Central Pollution Control Board (CPCB) has shown. July's average air quality index (AOI) this year was 108 -'moderate' - compared to 89 (satisfactory) in the month last year. Experts attributed the rise in pollution to lack of rain and local factors such as traffic congestion and waste burning.

The average AQI in July 2021 was 88 (satisfactory), while it was 106 (moderate) in the same month the following year. According to CPCB data, no 'good' air days were recorded this July. The city

The deteriorating air quality is a cause for concern and indicates a need for effective measures to control pollution, experts said. Pakistan man suspects 19-year-old wife of having an affair, sets her ablaze

Lahore.A newly-wed 19-year-old woman was allegedly burnt alive by her husband in the name of honour in Pakistan's Punjab province, police said on Wednesday.

Ali Raza, the husband of victim Saba Iqbal, killed her in Bahawalnagar, some 400 kilometres from Lahore, on July 28 as he suspected that his wife was having an affair.

According to police, Saba and Raza contracted a court marriage about eight months ago. Soon after the marriage, Raza started suspecting that Saba was in a relationship with someone else," police said.

Muhammad Iqbal, the father of the girl, said Raza told him over the phone on July 28 that Saba had left home after a quarrel and that she had been missing since then.

Iqbal said he and other family members rushed to Raza's house and launched a search to find her. Saba's burnt body was found in the field the next day, the girl's father said. Police said they arrested Raza who confessed to his crime.

The police said Raza brutally tortured Saba on the day of the incident before burning her alive and then dumping her charred body in the field."In his confession, Raza said he killed Saba after knowing that she had relations with someone else outside his locality," police said. A murder case has been registered against Raza and two unidentified suspects.

Hezbollah confirms death of top commander in Israeli strike on Lebanon

Beirut. Lebanon's Hezbollah confirmed on Wednesday that senior commander Fuad Shukr was killed in an Israeli strike on the outskirts of the Lebanese capital, making him the most senior figure from the group to be killed in nearly 10 months of conflict with

The strike hit the southern suburbs of Beirut, a Hezbollah stronghold, at dusk on Tuesday. It was the second time that the area had been struck since October, when Hezbollah and Israel began trading fire in parallel with the Gaza War.Israel's military announced late on Tuesday it had killed Shukr, whom it named as Hezbollah's most senior commander and whom it blamed for an attack on July 27 that left a dozen youngsters dead in the Israelioccupied Golan Heights.Iran-backed Hezbollah denied any involvement in the Golan attack. The strike on Beirut happened hours before the assassination of Hamas leader Ismail Haniyeh in the early hours of Wednesday in Iran, in a development that has further fanned fears of wider regional escalation. Hezbollah is an ally of Hamas.

Hezbollah said that its secretary general Hassan Nasrallah would speak on Thursday on the occasion of Shukr's funeral. Shukr was an adviser to Nasrallah, according to Hezbollah sources and the Israeli military's announcement of his killing.

Israeli Defence Minister Yoav Gallant said Shukr "has the blood of many Israelis on his hands. Tonight, we have shown that the blood of our people has a price, and that there is no place out of reach for our forces to this end".

9/11 attack mastermind, two other plotters agree to plead guilty, says Pentagon

Washington The man accused of masterminding the September 11, 2001 attacks, Khalid Sheikh Mohammed, and two of his accomplices, held at the US military prison at Guantanamo Bay, Cuba, have agreed to plead guilty, the Pentagon said on Wednesday. The Pentagon did not elaborate on the plea deals. A US official, speaking on condition of anonymity, said the plea deals almost certainly involved guilty pleas in exchange for taking the death penalty off the table. The official said the terms of the agreement had not been publicly disclosed but acknowledged a plea for a life sentence was possible. Mohammed is the most well known inmate at the detention facility in Guantanamo Bay, which was set up in 2002 by then-US President George W Bush to house foreign militant suspects following the September 11 attacks on the United States. Îts population grew to a peak of about 800 inmates before it started to shrink. There are 30 inmates today.

Mohammed is accused of masterminding the plot to fly hijacked commercial passenger aircraft into the World Trade Center in New York City and into the Pentagon. The 9/11 attacks, as they're known, killed nearly 3,000 people and plunged the United States into what would become a two-decade-long war in Afghanistan. His interrogations have long been the subject of scrutiny. A 2014 Senate Intelligence Committee report on the CIA's use of waterboarding and other "enhanced interrogation techniques" said that Mohammed had been waterboarded at least 183 times.

Kuntzman and his followers have used markers to redraw plate numbers that have been scraped away, removed tape and stickers, fixed bent plates or unscrewed coverings that render plates unreadable. Their repair efforts often focus on the private vehicles of law enforcement officers and court system personnel parked near police precincts and courthouses.

An X profile associated with Heymann

showed dozens of posts about obscured licence plates and illegally parked police vehicles in Manhattan.

"I do feel a certain amount of responsibility here," Kuntzman told The Associated Press Wednesday. A spokesperson for the Secret Service didn't respond to a question about why the two vehicles featured licence plate covers."Like this gentleman who may or may not have broken the law, I have been outraged by the way in which public officials, including those whose job it is to enforce the law, have wilfully broken the law and made our roads less safe," Kuntzman added.He continued: "As members of the public, we do have a responsibility to play a role in keeping the roadways safe. New video from Trump rally shows figure moving on roof moments before gunfire

World A new video from the Pennsylvania rally, where an assassination attempt was made on former US President Donald Trump, shows a figure moving swiftly across the roof of a building just minutes before shots were fired. It was recorded by James Copenhaver, one of the two rallygoers who were critically injured in the July 13 assassination attempt. In the video, exclusively obtained by Fox News, the person appears on the roof of the American Glass Research (AGR) building only minutes before shots were fired at the Republican presidential nominee. The figure could be seen moving from one side of the roof to another as Donald Trump was speaking. Towards the end of the video, the figure can be prominently seen on the roof, appearing to take position. The video was taken at 6.08 pm on July 13. Officials believe that Thomas Matthew Crooks, 20, opened fire three minutes later - around



6.11 pm - Fox News reported. A Secret Service sniper quickly shot and killed him, with law enforcement officials later finding eight shell casings near his body.James Copenhaver, 74, and David 'Jake' Dutch, 57, were shot twice by Crooks in his attempt to assassinate Trump. A 50-year-old volunteer firefighter Corey Comperatore was killed. The eight shots that Crooks fired at the former US President narrowly missed his face and grazed his ear. Both Copenhaver

and Dutch were discharged from the hospital in recent weeks.Even as investigations continue into the assassination attempt, a mystery remains about how Thomas Crooks reached the roof of the AGR building with a weapon. While testifying before a congressional committee last month, FBI director Christopher Wray said that Thomas Crooks bought a ladder on the day of the shooting, but it appeared

he did not use it. Instead, he climbed onto the roof using mechanical equipment on the ground and vertical piping. Wray also said that the 20-year-old's AR-style gun had a collapsable stock, which may explain why rally-goers or law enforcement officials didn't see him with the weapon before the shooting.Crooks flew a drone over the rally about two hours before Donald Trump took the stage, and bought as many as 50 rounds of ammunition on the day of the attack.

Elon Musk accepts Venezuelan President's fight challenge: Coming for you Maduro

World Tech Mogul Elon Musk accepted the challenge to fight Venezuelan President Nicolas Maduro on national television, and stated that he is "coming for Maduro."The Tesla chief took to his social media platform X and wrote, "I will carry you to Gitmo on a donkey."The tension between Musk and Maduro erupted after the SpaceX chief accused the socialist leader of "major election fraud," as both Maduro and his opponent claimed victory in the recently concluded Venezuelan presidential election. In his speech on national television, Maduro blamed Elon Musk for engineering attacks against Venezuela, claiming that the Tesla chief is behind a supposed "computer hacking" at the National Electoral Council (CNE). Interestingly, CNE had declared Maduro the victor in the presidential polls without giving detailed figures, a step that has led to allegations of rigging. In response to Musk's remarks against him, Maduro stated, "Social media create a virtual reality, and who controls the virtual reality? Our new archenemy is the famous Elon Musk. Do you want to fight? Let's do it. Elon Musk, I'm ready. I'm not afraid of you, Elon Musk. Let's fight, wherever you want."To which, Musk on X replied that someone should "tell Maduro I'll fight him anytime, anywhere." "In fact, tell him to bring his favourite donkey too," the tech mogul added. The tussle between Musk and Mogul led to a flurry of reactions online. While replying to one of the posts, Musk stated, "Maduro is a big guy himself and probably knows how to fight, so this would be a real fight. Zuck is a little fella, so that would be a short fight, lol.""If I win, he resigns as dictator of Venezuela. If he wins, I give him a free ride to Mars," Musk said.After Venezuela's election results were declared, Musk voiced his disapproval while referring to Maduro as a "dictator" and calling the polls a "travesty."In response, Maduro stated, "He wants to come here with his guns and an army to invade Venezuela. Elon Musk, good thing you showed your face because we knew you were behind it all! With your money and your satellites."

The teen will be remanded in custody and will appear at the Liverpool Magistrates Court on Thursday, the police said. The 17-year-old was in police custody on suspicion of murder and attempted murder after the bloody rampage on Monday at a "Taylor Swift yoga and dance workshop", a summer vacation event for children

aged 6 to 11 in the English seaside town. 9. Police said the person charged cannot be named for legal reasons because he is under 18 years of age.Disturbances in Southport on Tuesday took place after false information was spread on social media that the suspect behind the stabbings was a radical Islamist migrant.

Police have said the attack was not terrorism-related and that the suspect was born in Britain,

Iran's Khamenei orders 'direct' attack on Israel after Haniyeh's killing: Report

World Iran's supreme leader, Ayatollah Ali Khamenei, has ordered a "direct attack" on Israel in retaliation for the killing of top Hamas's leader, Ismail Haniyeh, in Tehran, The New York Times reported, while citing three Iranian

Shortly after announcing the death of Haniyeh, Iran called out an emergency meeting of the country's Supreme National Security Council on Wednesday morning. According to the officials, Khamenei gave orders of attack during the meeting. Such a meeting only occurs during extraordinary circumstances. Earlier in April, a similar meeting was called after an Israeli airstrike in Syria killed two top Iranian military commanders. Meanwhile, Israel's Channel 12 reported that messages have been sent to Iran through diplomatic backchannels that Israel is willing to go to a fullscale war if Iran and its proxies conduct any attack against the country.Iran and Hamas have blamed Israel for the killing. So far, Israel has neither accepted nor denied the killing of Haniyeh, who was in Tehran for the swearing-in



ceremony of Iran's new president Masoud Pezeshkian. Without mentioning the assassination, Prime Minister Benjamin Netanyahu has stated that Israel "will exact a very heavy price from any aggression against us on any front.' "There are challenging days ahead," he was quoted as saying

by the news agency Associated Press (AP) in its report. However, earlier, during the beginning of the Gaza war, Israel had vowed to kill Ismail Haniyeh and other Hamas leaders over the group's October 7 attack on Israel.After Haniyeh's killing in Tehran, Ayatollah Ali Khamenei, in a statement on his official website, stated that the "revenge" was "our duty", and that Israel had "prepared a harsh punishment for itself" by killing "a dear guest in our home."Iran and the regional forces it supports - including Hamas, Hezbollah in Lebanon, the Houthis in Yemen, and various militias in Iraq — refer to themselves as the "axis of resistance." Leaders from these groups gathered in Tehran on Tuesday for the inauguration of Pezeshkian. Haniyeh was killed around 2 am (local time), following his attendance at the ceremony and a meeting with Khamenei.

The assassination shocked Iranian officials, who called it crossing red lines. Meanwhile, according to Iran's state-run Press TV, Ayatollah Ali Khamenei will lead funeral prayers for Hamas leader Ismail Haniyeh on Thursday.

Chennai customs foils Bangkok-bound man's attempt to smuggle 427 star tortoises

CHENNAI. Customs officials at Chennai airport on Tuesday night foiled a Thailandbound passenger's attempt to smuggle 427 star tortoises. Sources said that Air Intelligence Unit (AIU) officials received an intelligence input that Sahul Hameed (29) of Ramanathapuram might be carrying suspicious objects. He was due to travel to Bangkok by flight FD 154.

Officials intercepted him at the departure hall and questioned him about the contents of his baggage. They searched his trolley suitcase and found four smaller bags inside which contained a total of 427 tortoises. Hameed, who claimed ignorance about the bag's contents, was immediately detained and Wildlife Crime Control Bureau (WCCB) officials were informed about the seizure.

WCCB officials reached the spot and confirmed that the animals were star tortoises, which are endangered species. Hameed was placed under arrest and the tortoises were handed over to Guindy National Park for rehabilitation.

Madhavaram-Red Hills NH traffic takes 'toll' on commuters

CHENNAI. Despite being a toll road, the 9.5 km national highway from Madhavaram junction to Padiyanallur of the Chennai-Kolkata national highway (NH-16) always faces heavy traffic congestion owing to junctions every 500m and poor upkeep. The dense residential and commercial areas on both sides exacerbates the situation.

Besides, the Madhvaram -Nallur section could not be widened to six lanes as relocating utilities like electrical cables and water pipelines is a monumental task, according to the NHAI.

The 33.5km NH from the Nallur toll plaza towards the Tamil Nadu -Andhra Pradesh border is six lanes. According to motorists and truckers heading to Vijayawada, Tada, and Tirupati, it takes 60-95 minutes to traverse 10km section S Suresh Babu, president of Billukuppam owing to numerous junctions where residents frequently cross the road. Despite toll fees being collected, the road shows signs of neglect and lack of attention. The section carries 1.4 lakh vehicles a day.

The 9.5 km section from Madhavaram to Nallur contains 11 major and minor junctions. "Local vehicles including trucks enter highway from both sides every 500m, forcing the traffic on NH carriageway to move at a snail's pace



during peak hours. Plans to make minor junctions one-way couldn't be implemented due to local resistance. On July 27, the highway and other roads were paralysed from 8am till 10pm," said a traffic police officer.

Village Welfare Association, said the Madhavaram-Red Hills section remains congested throughout the day, making it difficult for residents of Gummidipundi, Alamadhi, Ponneri, and nearby villages to access the city. "Other roads linked with the highway, including the Chennai-Tiruvallur highway, experience severe traffic during peak hours, with vehicle queues extending three to four km," he said.Following frequent representations from business groups, truckers'

NHAI proposed a 10.5km sixlane elevated corridor from Madhavaram junction, with a ramp connecting Chennai bypass with the outer ring road, at a cost of `1,700 crore. Although proposed in 2018, the project was stalled due to disagreements between the state government and NHAI over waiving royalties for minerals like gravel and earth used in construction and levy of state GST on construction materials. While the state government agreed to waive the mineral royalties in June last year, it refused to waive

the state component of the 9% GST on construction materials.

According to NHAI Chennai officials, the detailed project report is in its final stages and action will be taken once approved by the ministry. Meanwhile, '38 crore was allocated for relaying the 9.6km section from Madhavaram to Red Hills and building stormwater drains. "The drain construction works have already commenced," said an official.

'It is illegal to collect toll fees on the Madhavaram-Red Hills section without widening the road to six lanes. The toll fee should only apply to the 35.5 km stretch that has already been widened to six lanes," R Rajan Kumar, a trucker,

Mettur discharge at 1.7L cusecs; 250 moved to safety

ERODE: The discharge of water from the Mettur dam into the Cauvery river was increased to 1.7 lakh cusecs on Wednesday evening as the inflow

continued to surge. As a result, 250 people living in low-lying areas along the banks of the river in Namakkal and Erode districts were moved to relief shelters.

The water level reached the full reservoir level of 120 feet (93.4 tmcft) on Tuesday evening, following which the entire inflow was discharged into the river. Water flow in the river at Hogenakkal surged to 1.4 lakh cusecs on Wednesday. A month ago, the water level was a meagre 300 cusecs, which was one of the lowest in the last five years. As of 7 pm on

Wednesday, 1.7 lakh cusecs of water was released into the river. Due to this, a flood warning was issued to the people living along the banks of the Cauvery. In Namakkal, people living in low-lying areas in Kumarapalayam and were



accommodated in temporary camps.In Kumarapalayam, 186 people belonging to 78 families have been taken to two camps.

Thirty-seven people belonging to 15 families have been accommodated in a camp in Pallipalayam. Namakkal collector S Uma inspected the river banks

> and interacted with the people staying in the camps.In Erode, flooding was reported in residential areas in Bhavani. A total of 28 people belonging to 14 families were accommodated in two camps. Over 900 narcotics cases in eight months; efforts on to disrupt supply chains in Ernakulam

KOCHI. Affirming concerns over the increasing drug usage in the district, more than 900 narcotics cases were registered in Ernakulam Rural district in the past eight months. Despite that, significant seizures - including 370g of MDMA, two LSD stamps, and approximately one kilogram of ganjawere made during 'Operation Clean Ernakulam Rural' on June 26, the International Day against Drug Abuse and Illicit Trafficking.Moreover, a Congolese national, suspected to be the kingpin of an international drug-trafficking racket and a 'cook' of synthetic drugs, was arrested from Bengaluru while smuggling drugs on a tourist bus during the period, a senior police officer said."The Ernakulam Rural police have initiated action to confiscate the assets of 22 individuals involved in drug peddling during this period. We have impounded assets, including properties purchased with drug money and bank accounts where such funds were deposited, under Section 68F (2) of the NDPS Act," he said. Additionally, the police have detained 10 offenders under the Preventing Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act, he added.Detailing the recent crackdown on individuals involved in drug smuggling, the officer said, "The arrest of a three-member gang smuggling 1.8kg of MDMA under the cover of making short films in North Paravoor and the capture of a woman from Bengaluru with 1kg of MDMA were among the biggest drug seizures by the rural police during this.

Rain deficit induces drought fear among Sundargarh farmers

The situation has brought paddy transplantatio n and broadcasting operations to a grinding halt in major parts of the district.

ROURKELA: With deficit rain situation persisting in Sundargarh district during most of the monsoon, farmers here are worried over the possibility of a drought-like situation which, they fear, will affect paddy cultivation in their areas. The situation has brought paddy transplantation and broadcasting operations to a grinding halt in major parts of the district.

If agriculture authorities are to be believed, the district is lagging far behind with regards to paddy transplantation and broadcasting operations owing to deficit rainfall in July by 47 per cent. The same situation was witnessed in June too, which received 42 per cent less than normal rain this year.Normal rainfall for July has been downwardly revised to 352.2 mm from the previous 383.4 mm. While Bargaon is the worst affected receiving 105 mm rain, Hemgir block has recorded the highest rain at 363 mm. Meanwhile, Bonai, Gurundia, Nuagaon, Lefripada, Subdega



and Tangarpali received between 202 mm and 238 mm rain. Balishankara, Bisra, Koida, Kuanrmunda, Kutra, Lahunipada, Lathikata, Rajgangpur and Sundargarh blocks received between 150 mm and 187 mm.

Samuel Toppo, a marginal farmer of Bargaon block said majority of paddy farmers depend on monsoon rain for kharif cultivation as irrigation coverage in the district is poor. "In ideal conditions, paddy transplantation and broadcasting activities should have been completed by now," he said. Paddy cultivation target for this kharif crop season has been downwardly fixed for 1,94,700 hectare (ha), while nonpaddy crop cultivation areas increased to 1,18,230 ha.

Admitting that paddy coverage achievement is lagging in the district due to inadequate rainfall, chief district agriculture officer Harihar Nayak, however, said nothing has been lost as yet. "There is a forecast of heavy rainfall for the next three to four days which can improve the situation," he said adding, in the event the present dry spell continues beyond the next two to three weeks, it could be problematic.

He further noted that similar situation was witnessed during 2023 kharif season where deficit rainfall was followed by frequent low-pressure induced showers and that helped revive the cultivation scenario. "So far the district has reported 30 per cent achievement in paddy broadcasting and above 20 per cent achievement in paddy transplanting," the CDAO said.He further hoped that the situation would improve with a good spell of rainfall as there is adequate moisture in the soil.

Indigenous fighter programme remains a work in progress

WHEN the Vice Chief of the Indian Air Force (IAF), Air Marshal AP Singh, publicly states that "Aatmanirbharta (self-reliance) shouldn't be a buzzword at the cost of the nation's defence and should be pursued holistically in letter and spirit", the matter needs a close look. The Air Marshal has tried to bring to the nation's notice the acute shortage of fighters and consequential understrength of the IAF — 31 squadrons against the $sanctioned\, strength\, of\, 42.$

So, where does the problem lie? How to sort things out? What are the options for the government and the IAF? Since the focus is on Aatmanirbharta, it points to a deficiency in indigenous fighter production and a diminishing fleet resulting in reduced fighting capability of the Air Force. One, therefore, has to link indigenous fighter production to the big picture.

The most critical aspect of the indigenous fighter programme of any country is the engine/power plant of the flying machine, without which it is a non-starter. There are broadly nine manufactured sub-units/instruments which need to be interfaced to make a machine fly; fuselage, flying controls, structure, landing gear, power plant (engine), systems, avionics, equipment and armament. With the modern computer-aided design and computer-aided maintenance, Indian engineers and technologists surely can do eight out of nine jobs efficiently. Nevertheless, it's the power plant which constitutes the most challenging task, requiring sustained research and development by the best of brains and test-flying. Thus, just as no Rolls Royce is Rolls Royce without a matching engine, a fighter without a power plant at best could be an exciting item on display in a park or a museum for those aspiring to be pilots.

India, therefore, has its task cut out with regard to an aero-engine. India does have a full-fledged fighter engine-manufacturing Gas Turbine Research Establishment in Bengaluru, However, going by the list of fighter users, as gleaned from the last 50 years' editions of the annual Jane's All the World's Aircraft (JAWA) and the recently launched Janes Aero-Engines, it transpires that no single-engine fighter today can be considered useful if its thrust is less than 30,000 pounds static and without additional power generated by the afterburner during critical air-to-air missions. Unfortunately, JAWA reports that the 'performance ratings' of "India's first indigenously produced jet engine" Kaveri are "maximum dry 11,462-pound static thrust" and "maximum 19,000-pound static thrust with afterburner" (static thrust is the thrust developed by an airplane engine that is at rest with respect to the earth and the surrounding air). That would certainly pose problems pertaining to aerial power-to-weight combat for IAF pilots, being below par by modern fighter standards, notwithstanding different roles for different fighters. The IAF squadron's single-engine Mirage-2000, imported from France in 1985, has the Snecma M53 power plant's 21,385-pound static thrust, making it a potent "single-seat interceptor and air superiority fighter". What helped America's General Dynamics F-16 with one Pratt & Whitney F100-PW-200 engine succeed in the military market and combat missions was essentially the generation of 25,000-pound static thrust, which has gone up exponentially to ensure its longevity and durability — having been in ops for almost 50 years. F-16 production changed hands from General Dynamics to Lockheed Martin, but it now has two engine makers: the 29,100-pound static thrust Pratt & Whitney F100-PW-229 and General Electric's 29,588-pound static thrust F110-GE-129 power plant.Fast-forward to the 21st century. Lockheed Martin's multirole F35 single Pratt & Whitney power plant generates 40,000-pound-plus thrust, making it one of the heaviest 'maximum take-off weight' fighter of 15.785 tonnes in the single-engine category with an impressive maximum payload of 8.165 tonnes. The quality and efficiency of the engine make the machine airworthy and a potential victor.

Changing dynamics in South Asia keep India on toes

Americans have the luxury of viewing South Asia through a moralistic prism, whereas, for India, it is a strategic call.

THE unrest in Bangladesh, where amorphous forces are coming together to challenge the Awami League government, is a matter of concern for India. Since 2009, with Sheikh Hasina at the helm, Bangladesh's relations with India have improved significantly.


But instability in Bangladesh can be a tipping point in India's neighbourhood. SAARC (South Asian Association for Regional Cooperation) is in deep freeze. And the same is the case with India's relationship with Pakistan, whose efforts to cause disturbances in the union territory of Jammu and Kashmir continue unabated. Since the Taliban Another country in India's neighbourhood, takeover in 2021, India's diplomatic relations with Afghanistan have not been raised to a level where

they are tantamount to a recognition of the regime. With the emergence of President Mohamed Muizzu in the Maldives and his victory in the parliamentary elections, India has to live with his administration despite its anti-India stance.

A common thread running through these countries is the China factor. Beijing tends to support their regimes and stoke anti-India sentiments. As a result, India has been working with countries on the Bay of Bengal coast and trying to strengthen regional cooperation, particularly through BIMSTEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation). Headquartered in Bangladesh, BIMSTEC is now a bigger responsibility for India. Recently, there was a change of government in Nepal, a BIMSTEC country. The minority Maoists are out, and the Nepali Congress is in power, which should be considered a slightly positive gain for India.

However, KP Sharma Oli's return as the Prime Minister blunts the advantage of the Maoists' ouster, as Oli is known to be anti-India. He is one of those neighbourhood politicians who like to play the China card against India. Further, India has paid a heavy price for providing relief and debt settlement solutions to keep Sri Lanka afloat. President Ranil Wickremesinghe is well-disposed towards India. However, his United National Party is in a minority, having only one seat in Parliament and living on the largesse of a divided ruling class. A presidential election is due in September. While Wickremesinghe remains the most plausible candidate, which party will back him and whose candidate will win remains open to question. He needs to marshal a set of political parties behind him which will also possibly win a majority in the parliamentary elections that will follow. Otherwise, he will again be a President with a Parliament not beholden to him. Some parties in Sri Lanka also play the anti-India card and use China to foment such sentiments. Economic and cultural largesse offered in times of distress act as a soothing balm in these countries. But when elections come, anti-India sentiments can help a party draw more votes than it would get if the nation has friendly ties with New Delhi.

Myanmar, is also in dire straits. The situation has



only worsened since the military coup. India has kept up a delicate balancing act to safeguard its security by engaging with the junta while also maintaining partial ties with the democratic forces.

ASEAN is divided on how to deal with Myanmar. Among the ASEAN members that would rather engage with Myanmar than isolate it are Thailand, Cambodia, Laos and Vietnam. India has engaged with them. But for India, Myanmar is more of a neighbourhood problem and less of an ASEAN issue. Therefore, there is a perception in the region that Bangladesh has been our most stable and friendly neighbour. Dhaka has provided Beijing with many opportunities for the supply of defence equipment, economic engagement and infrastructure-building. But Bangladesh has taken the trouble to ensure that its engagement with China does not create security concerns for India. Further, The challenge for India comes shortly after it hosted a Bangladesh has given India a level playing field to the extent that it is the largest recipient of Indian credit lines, and several infrastructure projects are in progress there. For many years, India thought of

Myanmar as the route of connectivity with the North-East. That is why the Kaladan Multi-Modal Transit Transport Project and the trilateral highway project were launched. At that time, concerns over Bangladeshi instability and its hostile attitude towards India made New Delhi look at Myanmar as the bridge to the North-East. Besides, Myanmar's domestic situation has not helped matters. And since 2009, India-Bangladesh relations have gone from strength to strength. Therefore, Bangladesh has emerged as the bridge with the North-East in recent years, particularly since the conditions in Myanmar are not conducive to the completion of


ongoing infrastructure projects. If the situation worsens in Bangladesh, India will have reasons to worry. The congruence of Pakistani and Chinese interests in supporting a non-Awami League government, which is more open to them, is evident. Hasina had cut short her recent visit to China for unspecified reasons. Perhaps she was not fully satisfied with what the Chinese were able to offer. Of late, she has been more receptive to infrastructure support from Japan and India. Further, Hasina has drawn America's ire since the Americans have alleged that the elections in Bangladesh were not free and fair. The Americans have the luxury of viewing South

Asia through a moralistic prism, whereas, for India, it is a strategic call. This tests the limitations of the India-US partnership.Like in Nepal, Myanmar and Sri Lanka, India is playing a low-key role in Bangladesh, trying to engage all parties and to be seen as supportive of the country rather than a particular party. But when a certain party, like the one in Bangladesh, stays in power for a long time, ties with the country often come to be seen as an engagement with that ruling party. Therefore, India needs to diversify its engagement with other political parties and emerging interest groups that seem to be calling the shots. India does not want to be seen as interfering in the internal affairs of its neighbours. But then, these affairs should also be better handled and not allowed to become platforms for anti-India tirades.

Otherwise, the dream of Viksit Bharat will

remain just that — a dream.

Targeted policies can make exports soar

A paradigm shift from import dependence can make a world of difference

GLOBAL trade flows continue to be sluggish, so India may find the going tough in world markets this year. Merchandise exports in the first quarter (April to June) of the current fiscal showed a marginal growth of about 6 per cent, even as services exports continue to be buoyant. Despite the positive growth data, the medium-term outlook remains uncertain with many potential external headwinds. These include slowing import demand in advanced economies and geopolitical strife affecting worldwide cargo movements. Logistics issues created by the bottlenecks in the Red Sea have already raised shipment costs, while container shortage is another stumbling block. Other issues related to non-tariff barriers could potentially assume grave dimensions. This includes the imposition of new trade rules, especially those linked to climate change and environmental issues. The European Union's decision to impose higher tariffs on high carbon goods like steel, aluminium and cement — the carbon border adjustment mechanism — has already rattled exporters dealing with this major market. This does not mean that India's exports cannot show an exponential rise in the coming years. There are a few areas where higher investments and facilitation measures have already worked wonders in driving growth. These include mobile phones, toys and defence equipment. The success story of mobiles is well known. The phenomenal rise in exports over the past two years has pushed this country into becoming the sixth largest exporter now from the 23rd rank in 2014. The stimulus has primarily come from two leading global brands, Samsung and Apple. They have made large investments here which have translated into a spurt in domestic output and exports. The toy export story, in contrast, has been highlighted

only recently in the Economic Survey. It attributes the rise in toy exports and the shift away from import dependence to a raft of measures launched over the past decade. This includes a national action plan for toys, raising import duties and laying down quality

control guidelines. Significantly, there has been an integration into the global value chain for toys along with zero duties in key markets like the UAE and Australia. The end result has been a compound annual growth rate of nearly 16 per cent for toy exports over the past decade. At the same time, the dependence on supplies from China has waned considerably. Its share in toy imports dipped from 94 to 64 per cent over this period. The number of manufacturing units doubled, while the reliance on imported inputs fell from 33 to 12 per cent from 2013 to 2020, according to the

This may not make the country one of the top toy exporters in the world, but it does show that targeted policies can make a dent in unexpected areas. One must remember that this is an industry utterly dominated by China,

which accounts for over 86 per cent of the world's exports. Yet another area that has witnessed a dramatic turnaround is defence exports. Though India remains the world's leading arms importer, it has shifted gears in recent years to figure among the top 25 arms exporters. The reasons for the change are said to be simplifying of export procedures and curtailing delays by going with online export authorisations.


Given these success stories, it is clear that specific policy initiatives can play a pivotal role in crafting success on the trade front. Such strategies need to be replicated in other sectors. Agriculture and allied areas, for instance, are recognised as having enormous potential for exports but have not yet fulfilled this promise. The need for agro-processing units in rural areas to enable easy movement of



products from farm to factory has been discussed for many years, but there has been little action on the ground. Apart from processing units for adding value to fruits and vegetables, there is a need for a cold chain infrastructure. This is essential if India is to become a significant player in the global food products trade. Some schemes were launched in 2017 to support the creation of the cold chain, but these are reported to have made progress in only a few states. Besides providing infrastructural support, giving a boost to agricultural exports will also require a shift in policy approach to support farmers rather than consumers. For instance, the traditional

kneejerk reaction to market fluctuations in prices of commodities like wheat, rice, sugar or onions has always been to curb exports to improve domestic availability. This creates a disadvantage for the country in global markets, making it appear as an unreliable supplier. It also deprives farmers of the benefits of higher market prices. A long-term policy for the export of agricultural products is necessary in order to achieve the twin aims of retaining India's reputation as a trusted supplier as well as of providing remunerative prices to cultivators. While there is admittedly a need to keep food inflation in check, it needs to be done through better long-term management of surplus stocks rather than imposing export bans.

In evolving trade policies, greater attention also needs to be paid to the handicraft sector, which has faced a decline in exports in the last financial year due to recessionary conditions in major advanced economy markets. Exports are usually viewed as being dependent on economic conditions in key markets. This is true to a large extent. But it is also true that formulating policies targeting specific sectors can have a dramatic impact, as in the case of toys. One of the key elements in all sectors that have shown a spurt in growth is higher investment. This has been evident for mobile phones, but it has also been so for defence equipment, where the process of indigenisation has entailed sizeable public and private sector investments. A fresh look is thus needed at export policies in order to replicate the remarkable success of these sectors in other areas.

A lot of people in India suffer from Obstructive Sleep Apnea (OSA) and are four times more prone to suffer from cardiovascular risk factors. Obese people are more prone to OSA, but that does not reduce the risk of occurrence in the slim



people. If you snore and often wake up feeling tired, consult your doctor; there are easy ways to screen for apnea.

Ignoring your dental health

While the exact reason is unknown, there is a strong link between gum disease and heart disease, if you don't floss, sticky, bacterialaden plaque build-up over time, which can lead to gum disease. One theory is that these bacteria trigger inflammation in the body. "Inflammation promotes all aspects of Atherosclerosis," says Dr. Sharad Kasarle. Treating gum disease can improve blood vessel function.

Withdrawing from the world

It's no secret that on some days, other human beings can seem annoying, irritating, and just plain difficult to get along with. However, it

makes sense to strengthen your connections to the ones you actually like. People with stronger connections to family, friends, and society in general tend to live longer, healthier lives. Everyone needs alone time, but you should still reach out to others and keep in touch whenever you can.

Drinking (too much) alcohol

Sure, studies suggest a small amount of alcohol may be good for your heart. Alas,

too many over-imbibe. Excess alcohol is linked to a greater risk of high blood pressure, high levels of blood fats, and heart failure. In addition, the extra calories can lead to weight gain, a threat to heart health. Avoid excessive intake of alcohol as much as you can for a healthy life.

Overeating

Being overweight is a major risk factor for heart disease. Try to eat less, avoid oversize portions, and replace sugary drinks with water. Dr. Sharad Kasarle also suggest cutting portion sizes for highcalorie carbohydrates (think refined pastas and breads) and watching out for foods labelled "low-fat," which are often high in calories

Smoking or living with a smoker

Sure, you've heard it a million times before: Don't smoke. But it bears repeating. "Smoking is a total disaster for your heart," says Dr. Kasarle. Smoking promotes blood clots, which can block blood flow to the heart, and contributes to plaque build-up in the arteries. High blood pressure and cholesterol, diabetes, being overweight and smoking are all risk factors that should be kept in check.



32 dead in rain, flooding in 7 states, several missing in hills

As many as 32 people have died in seven states in the past 24 hours as monsoon mayhem continued across the country.

New Delhi: As many as 32 people have died in rain-related incidents in seven states in the past 24 hours, as monsoon mayhem continued in India. While record single-day rain submerged Delhi-NCR, cloudbursts in Uttarakhand and Himachal Pradesh claimed the lives of at least 14 even as several others were missing. According to the latest figures, 10 deaths have been reported in Uttarakhand, four in Himachal Pradesh, five in Delhi, two in Greater Noida in Uttar Pradesh, three in Gurugram in

Haryana, three in Rajasthan's Jaipur, and five in Bihar. With this, the nationwide death toll due to rain-related incidents have shot up to 283, with Wayanad in Kerala being the most affected with 256 fatalities. Three massive landslides triggered by incessant rainfall hit the hilly areas near Meppadi in Kerala's Wayanad on Tuesday. As rescue operations continued on war footing for the third consecutive day on Thursdy, hundreds others remained missing. Delhi-NCR was hammere by incessant rainfall on Wednesday evening, with data from the weather department later stating that the national capital received 108 mm of rain in 24 hours - the highest in a single day in July in 14 years. The downpours left several

areas of the city inundated, heavily hit traffic movement, and caused wall collapse. Visuals showed several underpasses in Delhi- Over 250 people have been killed in massive NCR were submerged, with traffic especially affected on roads leading to Noida, Gurugram, Faridabad and Ghaziabad - the regions under the national capital region (NCR). Heavy rainfall triggered cloudbursts in Uttarakhand and Himachal Pradesh, killing at least 14 as scores of others were missing. The Met

Department has forecast more rainfall in the next five days in both the hill states, even as Heavy rainfall triggered flash floods in the rescue operations are underway. Prime Minister Narendra Modi is closely monitoring the situation in Himachal Pradesh and have ensured all possible

assistance is provided, news agency ANI reported. Five people have died in lightning strikes in two Bihar districts in the past 24 hours, news agency PTI reported, citing an official statement by the Chief Minister's Office (CMO). Chief Minister Nitish Kumar has condoled the loss of lives and announced a financial compensation of Rs 4 lakh to the families of the victims, the statement added. He also urged citizens to follow advisories issued by the Disaster Management Department.

water, causing damage to bridges and buildings close to the drains. Meanwhile, rivers in Rajouri district were overflowing as visuals showed severe waterlogging in roads. A woman and her niece and another man drowned after rainwater entered the basement of their house in Jaipur on Thursday morning, officials said. The bodies of the victims were recovered after an hours-long rescue operation, which

included using mud pumps to pump out the rainwater. Police said the passage to the basement was narrow and deep. The IMD on Thursday said that India recorded nine per cent more rainfall than normal in July, with the central part of the country

receiving 33 per cent excess rain. The weather department said that its data showed significant rainfall deficits in east Uttar Pradesh, Bihar, Jharkhand, Gangetic West Bengal, and parts of the Northeast, news agency PTI reported.\

The IMD further predicted India to record above-normal rainfall in August and September, with a high chance of favourable La Nina conditions developing by August-end. The Met department said that rainfall over India in these months would be 106 per cent

of the long-period average of 422.8 mm. India has so far recorded 453.8 mm since June 1, an excess of two per cent due to the wetter-than-normal July.According to the latest IMD bulletin, the seven states which have so far reported rain-related deaths, will see no immediate relief. Heavy rain has been forecast for Delhi, Himachal Pradesh, Uttarakhand, Rajasthan and Bihar, among others, till August 7.

"We Grant Bail To Killers But...": Supreme Court On Bibhav Kumar **Bail Plea**

New Delhi: The Supreme Court on Thursday issued notice to Delhi Police on a bail plea filed by Bibhav Kumar, an aide of Aam Aadmi Party boss and Chief Minister Arvind Kejriwal. Mr Kumar was arrested in May after allegations of assault, inside Mr Kejriwal's home, by AAP MP Swati Maliwal.

Mr Kumar, in judicial custody till July 16, faces charges of criminal intimidation, assault or criminal force on a woman with intent to disrobe, and attempt to commit culpable homicide.He also faces charges of "disappearing evidence and giving false information".In the brief hearing this morning the court acknowledged "we normally grant bail... we grant bail to murderers and killers". However, in what may be seen as a bad sign going forward, it also remarked "look at the FIR. She (Ms Maliwal) was crying (during the assault)" and seemed unconvinced by arguments that Bibhav Kumar, if given bail, would not influence witnesses."If this kind of person can't influence who can? Was anyone in the drawing room (of the Chief Minister's home, where the alleged assault began) to speak against him... he doesn't seem ashamed, we think," a bench of Justices Surya Kant, Dipankar Datta and Ujjal Bhuyan remarked.

The court, in a particularly strong observation, also called Mr Kumar a "goon". Earlier today senior advocate Abhishek Singhvi, appearing for Mr Kumar, began by questioning the delay by Ms Maliwal in filing her complaint. He referred to Ms Maliwal's visit to Delhi's Civil Lines Police Station on May 13 (the day of the alleged assault) and the "strange story" in her FIR."Incident was on May 13. FIR was lodged May 16... the story in FIR is strange. She went on the first day to the police station but came back (Ms Maliwal did not file a police complaint or make a statement on that day). Did not lodge FIR. Three days later, FIR was lodged with injuries..."

"Scheduled Castes Socially Heterogenous Class": Top Court's Big Quota Order

New Delhi: A seven-judge Constitution bench of the Supreme Court today okayed sub-classification within Scheduled Caste and Scheduled Tribe categories to provide reservation in jobs and education for the more marginalised among backward communities.

The landmark verdict was passed by the bench led by Chief Justice of India DY Chandrachud by a 6:1 majority, with Justice Bela Trivedi dissenting. Six separate judgments were written. The verdict overrules the 2004 judgment of a five-judge Constitution bench in the case of EV Chinnaiah vs State of Andhra Pradesh. The other judges on the bench were Justice BR Gavai, Justice Vikram Nath, Justice Pankaj Mithal, Justice Manoj Misra and Justice Satish Chandra Mishra. During the hearing, the Centre had told the court that it in favour of sub-classification in the Scheduled Caste and Scheduled Tribe categories. The Chief Justice had observed that there was a distinction between "subclassification" and "sub-categorisation" and held that states may have to sub-categorise reserved category communities to ensure that benefits reach more backward groups.

There are six opinions. mine is for Justice Manoj Misra and me. A majority of us has overruled EV Chinnaiah (verdict) and we hold sub-classification is permitted. Justice Bela trivedi has dissented," he said this morning."The members of SC/ST categories are not often unable to climb up the ladder due to the systemic discrimination they face. Article 14 permits subclassification of caste," the Chief Justice said, adding, "Historical and empirical evidence demonstrates that the Scheduled Castes are a socially heterogenous class."Justice BR Gavai said, "I have referred to a speech of Dr BR Ambedkar in 1949 where he said that unless we have social democracy there is no use of political democracy."Hardships and backwardness suffered by some of the Scheduled Castes is different for each caste. EV Chinnaiah was wrongly decided. It was argued that a party can give reservation to a sub-caste to gain political mileage, but I do not agree with this. The ultimate objective would be to realise real equality," he said.

'Water dripping program': Opposition MPs Indians in Lebanon asked to jab BJP over Parliament roof leakage

New Delhi: The BJP-led Central government found itself in hot water after the Congress and Samajwadi Party posted videos of water leaking in the Parliament lobby as Delhi received heavy rainfall. While Congress MP Manickam Tagore moved an adjournment motion on the issue in Lok Sabha, Akhilesh Yadav taunted the BJP for spending billions on constructing a new Parliament and sought proceedings be moved to the old building.

New Delhi:The Indian Embassy in Beirut has advised Indian nationals to avoid all non-essential travel to the country amid a spike in tensions in the Middle East after Israel's strikes on Lebanon and Iran's plan to attack Israel as retaliation for Hamas chief Ismail Haniyeh's death in Tehran earlier this week.In a tweet, the Indian Embassy asked the Indian nationals to exercise caution and restrict their movements while in Lebanon and remain in contact with the embassy officials. It also issued an emergency number for Indian nationals in Lebanon."In view of the recent escalations in the region, Indian nationals are advised to avoid all non-essential travel to Lebanon. All Indian nationals in Lebanon are advised to exercise caution, restrict their movements and remain in contact with the Embassy of India in Beirut through their email id: cons.beirut@mea.gov.in or the emergency phone number +96176860128," the tweet said

Several countries, including the US, Australia and Canada have issued advisories for its citizens, telling them to leave Lebanon at the earliest. Tensions in the Middle East, already on due to the Israel-Hamas war in Gaza since October 7 last year, rose on Monday after an Israeli drone strike killed two people in southern Lebanon, Reuters reported. The strike was in retaliation for a rocket strike in the Israeli-occupied Golan Heights on July 27 that killed 12 teenagers and children, which Israel and the US claim was carried out by the Hezbollah, which is backed by Iran Flights at Beirut airport have been cancelled or delayed over fears that Israel and Hezbollah could engage in a full-scale war, The Associated Press reported. Earlier on Monday, the Indian Embassy in Lebanon asked Indian nationals in the country to "exercise caution" and remain in contact with the embassy amid growing tensions between Israel and Hezbollah. 
Satellite Images Show Devastation From Landslides In Kerala's Wayanad

New Delhi: High resolution images taken by Indian satellites show the widespread damage and devastation caused by The latest report accessed by NDTV, landslides in Kerala's Wayanad. More

than 150 people have died and over 200 injured even as the rescue works are ongoing. The before and after images show that about 86,000 square meters of land slipped and the debris flowed for about 8 kilometers along the Iruvaiphuzha river. Interestingly the Indian Space Research Organisation report also presents evidence of an old landslide at the same location, suggesting its vulnerability was documented. The National Remote Sensing Center, Hyderabad a part of the Indian

Space Research Organization deployed its highest resolution Cartosat-3 optical satellite and the RISAT satellite that is capable of seeing through cloud cover. The space agency says the landslide was above the sea level.

landslide at the same location. A 2023 'Landslide Atlas of India' prepared by ISRO had placed Wayanad region as a vulnerable to landslides.ISRO satellite images show widespread devastation at Wayanad landslide. Almost 86,000 square meters of land slipped causing the landslide almost five times the size of the Rashtrapati Bhawan. The debris flowed

for almost 8 kilometers downstream washing away towns and settlements.

ISRO says there is evidence of an old landslide at same location. The National Remote Sensing Center used the Cartosat-3 satellite and the RISAT satellite to see through cloud cover. The NRSC reports says "a major debris flow was triggered by heavy rainfall in and around the Chooralmala town of Wayanad District in Kerala state of India". Very high resolution RISAT SAR images of 31 July,

2024 show the entire extent of the debris flow from crown to end of run out zone. The approximate length of the flow is 8 km. The crown zone is a reactivation of an older landslide. The size of the main scarp of the landslide in 86,000 square meters. The debris flow has widened the course of the Iruvaniphuza River causing breach of its banks. Houses and other infrastructures located along the banks have been damaged by the debris flow, 3D rendition of the crown of the landslide illustrates that a large section of the hill slope has been affected. The areal extent of the landslide is 86,000 square meters. The crown is located at an approximate elevation of approximately 1,550 m above MSL. India" which diligently documents the 80,000 landslides that have occurred over 20 years and lists landslide from Puthumala, Wayanad district, and large parts of Kerala are marked red as being prone to landslides.

Dr S Somanath, the Chairman of ISRO in the 2023 report says it presents "the overall landslide scenario in India and ... the field of landslide hazard. I am sure that the atlas will be beneficial to everyone involved in disaster management endeavors."

Though viral infection is the most common cause, other sources of infection are bacteria, chemical irritants, dust and pollens. For severe cases, there are antibiotic medication and steroid. If the Nifty50 sustains above 25,100, then 25,600 should be the next target. The psychologically important level of 25,000 will play a crucial role here," Jain explained. Nifty50 should take support at 24,800 and 24,500. As the Nifty50 ventures into uncharted territories, respecting stop-loss is non-negotiable."

Infosys shares trade in red after Rs 32,000 crore GST notice

New Delhi. Infosys shares dipped 1% to a low of Rs 1,845.40 on the Bombay Stock Exchange (BSE) on Thursday following news of alleged GST evasion by the information technology giant. Shares of the company were down 0.59% at Rs 1,857.10 at 11:00 am. The Directorate General of GST Intelligence is probing the company for an alleged GST evasion of over Rs 32,000 crore. Infosys responded to the news with a clarification through an official filing."Karnataka State GST authorities have issued a pre-show cause notice for payment of GST amounting to Rs 32,403 crores for the period from July 2017 to March 2022. This pertains to expenses incurred by overseas branch offices of Infosys Limited," the company said."We have responded to this pre-show cause notice. Following the news articles, we have also received a pre-show cause notice from the Director General of GST Intelligence on the same issue, and we are in the process of responding," it added. Infosys has contested the claim, citing a recent circular from the Central Board of Indirect Taxes and Customs, which aligns with GST Council recommendations. According to Infosys, GST is not applicable to services provided by overseas branches to Indian entities."It is also important to note that the GST payments are eligible for credit or refund against the export of IT services," the company added.

Infosys assured that it has paid all GST dues and is in full compliance with both central and state regulations.

Despite this recent development, Infosys shares saw a significant rise in July, surging 19% following their Q1 results announcement, where the company reported a 7% year-on-year increase in profit after tax.

Over the past year, Infosys shares have increased by 36% and have grown 20% in the current calendar year so far.

The surge, up from \$75.4 billion in Q1'24, was fuelled by nine mega-deals exceeding \$1 billion each, marking the second-highest total for a single quarter. Despite the increase in investment, the

volume of VC deals fell to 7,691, the lowest since Q3'16, reflecting ongoing challenges such as high interest rates and geopolitical uncertainties. Artificial Intelligence (AI) was a significant driver,

Have you missed ITR filing deadline? Check penalty and other consequences

New Delhi. The Income Tax Department (I-T Department) has not extended the deadline to file Income Tax Returns (ITRs) for the assessment year 2024-25 beyond July 31. As a result, taxpayers who missed the deadline face several consequences, including penalties and the loss of certain benefits. Firstly, late filing penalties will be imposed. If you file your ITR after July 31 but before December 31, you will incur a late fee of Rs 5,000. For returns filed after December 31, the penalty increases to Rs 10,000. However, for taxpayers with a total income of less than Rs 5 lakh, the maximum penalty is limited to Rs 1,000. These penalties are levied under Taxpayers who have missed the deadline Section 234F of the Income Tax Act.Other consequences of late ITR filingIn addition to penalties, late filers will also lose out on the opportunity to carry forward losses to future years.Losses under the 'Capital Gains' or 'Business and Profession' categories cannot be carried forward if the return is filed after the due date. This can significantly impact taxpayers who rely on these deductions to reduce their tax liabilities in subsequent



years. Another consequence of missing the deadline is the accrual of interest on any unpaid tax. Under Section 234A, an interest rate of 1% per month or part of a month is charged on the outstanding tax amount from the original due date until the date of payment. This interest is in addition to the penalty for late filing.

Core sector output at 20-month low of four per cent in June

NEW DELHI. The output of the May, was an improvement over the 4.2 and cement, compared to May country's eight key infrastructure industries grew by 4 per cent year-onyear in June, slowest in last 20 months owing to a high base effect and reduced electricity demand due to the monsoon season among other reasons. In comparison, the output growth was 6.4 per cent in May 2024 and 8.4 per cent in June 2023. The eight sectors - coal, steel, cement, fertilizers, electricity, natural gas, refinery products, and crude oil - account for two-fifths of India's overall industrial production.

Except for crude oil and refinery products, all other sectors reported positive growth in June. Coal production surged by 14.8 per cent, driven by increased demand for electricity. Electricity generation grew by 7.7 per cent which although lower than the 13.7 per cent growth seen in

per cent growth recorded in June 2023. Additionally, the production of fertilizers, natural gas, steel, and cement saw growth rates of 2.4 per cent, 3.3 per cent, 2.7 per cent, and 1.9 per cent respectively, compared to the same period last year. The eight core sectors contribute 40.27 per cent to the Q1 deficit at 8.1% of FY25 target which measures overall industrial growth. Crude oil, and refinery products' output contracted by (-) 2.6 per cent and (-) 1.5 per cent, respectively, in June.Aditi Nayar, Chief Economist, head of research and outreach at ICRA Ltd, said, "The core sector expansion slid to a 20 month low of 4.0% in June 2024, led by a moderation in growth or deepening contraction in five of the eight constituents, barring coal, fertilizers

US Fed meeting key takeaways: Rate cut prediction, commentary and more

New Delhi The US Federal Reserve hinted on Wednesday that it might cut its key lending rate in the coming months. US Fed chief Jerome Powell shared this after a meeting that ended on July 31.

Powell praised recent progress in US inflation and said, "The second quarter's inflation readings have added to our confidence, and more good data would further strengthen that confidence."This potential rate cut would lead to lower borrowing costs for Americans, affecting mortgages, car loans, and credit cards. He also mentioned that the US job market seems to have returned to its prepandemic state. For now, interest rates will stay at their current range of 5.25-5.50%. Powell mentioned that future long-term rates might be higher than previously expected. However, he admitted that deciding when to cut rates would be 'a very difficult judgement call'.

Powell said that inflation has eased over the past few years but is still somewhat above the Fed's long-term goal of 2%. The Personal Consumption Expenditures

Inflation less of an issue

(PCE) index showed that consumer prices rose by 2.5% in June from a year earlier. This is down from May's 2.6% annual rate and closer to the Fed's 2% target.He said, "This is such a welcome outcome for the people we serve. What we're thinking about all the time is, how do we keep this going? Dhoni, known for his cool demeanour and finishing skills, carried the weight of the nation's hopes. With 25 runs needed from 10 balls, Dhoni aimed to turn the tide. But then, the unthinkable happened.

Dhoni's run-out

A throw from Martin Guptill caught Dhoni short of the crease. Dhoni's run-out was the heart-breaking moment that shattered India's World Cup dream. As he walked back to the pavilion, the silence was deafening. Fans around the world were left shocked, witnessing the end of an era.

Dhoni admitte that it was a heartbreak, but also pointed out that he got a lot of time to recover from the loss."It was a difficult one because I knew that this will be my last World Cup, so it would have been good to be on the winning side.

Shah Rukh Khan and Ness Wadia reportedly argued over the number of retentions or Right to Match card that should be allowed for the mega auction ahead of IPL 2025. The BCCI, in a statement on Wednesday, confirmed it had a 'productive dialogue' with team owners over the

preparations for IPL 2025 and that the IPL governing council will discuss the talking points from the meeting before taking the final call. The meeting did not yield any 'real outcome' but the BCCI understood what the team owners felt about the pressing issues in the lead-up to the next season. A mega auction is slated to be held before the start of the IPL 2025 season, but several team owners have spoken against



it, highlighting the need to have a stable roaster of players and rewards for scouting and backing young players who go on to become superstars. The owners debated and discussed various aspects, including the need for a mega auction, retention policy, and the Impact Player rule. According to a top BCCI source who was part of the meeting, Shah Rukh fiercely made the case against mega auctions. At one stage, the KKR owner was also

believed to be engaged in a heated argument with Ness Wadia over the number of retentions. Shah Rukh was in favour of major retentions while Wadia is believed to be against too many of them. Among the team owners or co-owners who attended the meeting were Shah Rukh Khan from Kolkata Knight Riders, Kavya Maran from Sunrisers Hyderabad, Ness Wadia from Punjab Kings, Sanjiv Goenka with his son

Shashwat from Lucknow Super Giants, KK Grand and Parth Jindal from Delhi Capitals.Manoj Badale and Ranjit Barthakur from Rajasthan Royals, Prathamesh Mishra from Royal Challengers Bengaluru, Kasi Viswanathan and Rupa Gurunath from Chennai Super Kings, Amit Soni from Gujarat Titans while Mumbai Indians' owners attended it

Chinese swimmer wins Olympic gold by smashing his own record in 100m freestyle

NewDelhi. Chinese swimmer Pan Zhanle smashed his own world record in 100 metres freestyle at the Paris Olympics 2024 on Wednesday to win a gold medal in the event. En route to his quest for gold, Pan also humbled a slew of his champion rivals. The 19-year-old sensation bettered his previous world-record timing by 0.40 seconds which was set at the World Championships in Doha in February this year. He bettered his timing by 0.40 seconds in the Paris Olympic Games and clocked 46.40 seconds in the race. Australia's Kyle Chalmers bagged the silver medal as he finished 1.08 seconds behind Pan. Meanwhile, while David Popovici finished a further 0.01 seconds behind Chalmers to win the bronze. There was no easing in for Pan, who took off like a rocket and crushed the opening 50 metres in an outrageous 22.28 seconds. He mowed down any hopes Chalmers and Popovici might have had of catching him as he stretched his lead and flew to the wall."I tried my best to get the best result. I was very surprised in the end that I broke the world record and it was a magical moment," Pan told reporters through a translator.

A doping storm has followed China's swimming team to Paris. Ahead of the Games, revelations were made in April that 23 Chinese athletes had tested positive for a banned heart medication but were allowed to swim at the Tokyo Olympics in 2021. Wenzhou native Pan rose above all this to earn his first Olympic gold medal, five months after he became the world champion. The 19-year-old revealed he had been tested more than 20 times over the past few months.

"The testing was essentially done under all the regulations, so I don't feel there was any difference or influence," he said.

Pan Zhanle overcomes challenges

Chalmers won the gold medal at Rio 2016 and won his second silver in the event and eighth medal at the Olympic Games. He won another silver after having finished as a runner-up behind Caeleb Dressel at the Tokyo Olympic Games. Chalmers overcame a back injury before the Olympic trials and a change of coach after his former one, Peter Bishop, was stood down in March after an undisclosed investigation."I've been swimming the same race plan for the last eight years, and it's worked pretty well for me. It almost worked well for me. I guess tonight to get a silver medal still was amazing," Chalmers said.Popovici previously held the world record before Pan took it at Doha, added the bronze to his 200m freestyle gold medal at Paris.

Jindal suggested there was a debate about whether there should be an auction in the IPL at all."There was, yeah, I was surprised. There was a debate. Some people said that there should not be a mega auction at all. There should be only smaller auctions,' Jindal said."I'm not in that camp. I feel that it (auction) evens the playing field, and it's very good for everyone. It makes the IPL what it is. It makes it competitive. It makes it an even-playing field," he added.

Mahesh Bhatt has always been open about his personal life. In a 1998 interview with Rediff, the filmmaker opened up on his parents' diverse religious backgrounds. His father, Nanabhai Bhatt, was a Gujarati Brahmin, while his mother, Shirin Mohammad Ali, was a Shia Muslim. Bhatt shared how his mother felt a bit embarrassed by his open embrace of his Muslim heritage and expressed concern when he chose Muslim names for his daughters, Alia and Shaheen. He noted that she likely feared her minority status might affect their everyday lives, particularly during the communal riots in Mumbai in 1992, which heightened her anxieties. The filmmaker recalled that his mother always wore a big tika and sari but was worried about their minority status affecting their lives. She felt embarrassed when he embraced his Muslim identity. "I could see that there was something she was hiding. She felt that her minority status would perhaps interfere with our day-to-day lives. She was a little embarrassed when I flaunted my Muslim roots... when I came to know about it. Yes, she was a little embarrassed about it. She was worried about me during the communal riots in 1992. She was worried when we named my little girls - because my second wife (Soni Razdan) liked those names - Shaheen and Alia. Both are Muslim names. Everybody was worried in 1992. What was going to happen?" Bhatt shared.

Mahesh recalled how his father, who wore a janoi, stayed true to his own beliefs. Despite his parents' deep love for each other, they didn't try to change their individual faiths. "I had the best of both worlds. My mother was a Shia Muslim, while my father was a janoi-clad man. He never pretended to be secular. What's very interesting, both (father and mother) retained their individual faiths. They were madly in love but neither indulged in the farce of wanting to do things the other way," he remembered.
