Arvind Kejriwal Bail Hearing Today

New Delhi, Sep. 12: The Supreme Court on Thursday reserved its verdict on Delhi chief minister and AAP convenor Arvind Kejriwal's plea challenging his arrest by the Central Bureau of Investigation (CBI) and requesting bail in connection with the alleged liquor policy scam. A bench comprising Justices Surya Kant and Ujjal Bhuyan reserved the decision after hearing arguments from senior advocate Abhishek Manu Singhvi, representing Kejriwal and the Aam Aadmi Party (AAP), and Additional Solicitor General (ASG) S V Raju, representing the CBI. Singhvi argued that the CBI, which had not arrested Kejriwal for two years, made a sudden "insurance arrest" to prevent his release in a related money laundering case. He also contended that Kejriwal was arrested for "non-cooperation and evasive replies" but cited Supreme Court rulings that held cooperation in a probe should not require self-incrimination or a confession of guilt. Earlier, on August 14, the Supreme Court declined to grant interim bail to Kejriwal but sought a response from the CBI regarding his plea contesting his arrest. The Delhi high court had previously ruled that Kejriwal's arrest was legal and remarked that the CBI had sufficiently demonstrated how Kejriwal, the Aam Aadmi Party (AAP) chief, could influence potential witnesses. "There was no malice in the acts done by the CBI which was able to demonstrate how the AAP supremo could influence witnesses who could muster the courage to depose only after his arrest," said the Delhi High Court. The high court also instructed Kejriwal to seek regular bail from the trial court in the CBI case. Additionally, the court observed that the evidence loop involving Kejriwal was closed after the collection of necessary evidence following his arrest and that the arrest was justified and legal. "It cannot be said that it was without any justifiable reason or illegal," said the high court. The court acknowledged Kejriwal's status, noting he is not an ordinary citizen but "a distinguished recipient of the Magsaysay Award and the convenor of the Aam Aadmi Party." The high court dismissed Kejriwal's plea contesting his arrest. It was only after the collection of sufficient evidence and obtaining sanction in April 2024 that the agency progressed with the investigation against him. The court noted that witnesses were initially reluctant to come forward due to Kejriwal's influence stemming from his position. However, following his arrest, they were willing to record their statements. The court remarked, "Material witnesses were not coming forward due to the influence exercised by Kejriwal by virtue of his position. It was only after he got arrested that the witnesses came forward to record their statements." Kejriwal, who was arrested by the Enforcement Directorate (ED) on March 21, had previously been granted bail by the trial court in the money laundering case on June 20.

Involvement in criminal case no ground for demolition of property: Supreme Court

File photo Maintaining that alleged involvement in a crime is not a ground to demolish properties, the Supreme Court on Thursday asked the civic body of Kathlal in Kheda district of



Gujarat to maintain status quo and not threaten to bulldoze the house of a man accused in a criminal case. "In a country where actions of the State are governed by the rule of law, the transgression by a family member cannot invite action against other members of the family or their legally-constructed residence. Alleged involvement in crime is no ground for the demolition of a property, a Bench led by Justice Hrishikesh Roy said. "Moreover, the alleged crime has to be proved through due legal process in a court of law. The court cannot be oblivious to such demolition threats inconceivable in a nation where law is supreme. Otherwise, such actions may be seen as running a bulldozer over the laws of the land," said the Bench which also included Justice Sudhanshu Dhulia and Justice SVN Bhatti. As many BJP-ruled states resort to bulldozer action against 'illegal' houses of offenders. another Bench led by Justice BR Gavai on September 2 said that it will lay down guidelines on the issue as it wondered how someone's house can be demolished just because the person happened to be an accused. Issuing notices to the Gujarat Government and the Kathlal civic body on a petition filed by one JM Saiyed seeking protection from the proposed demolition, the top court on Thursday asked them to respond to the petition in four weeks and listed it for hearing after a month. "In the meantime, status quo in respect of the petitioner's property is to be maintained by all concerned," it said, taking note of the petitioner's contention that the civic body has no reason to either threaten or take any steps, such as using bulldozers, to demolish his legally-constructed and legally-occupied house.

Chandigarh, Sep 12: Karnataka, one of the only three states under the Congress rule, has again been plunged into dramatic political turmoil, which it is known for. With Chief Minister Siddaramaiah facing sustained attacks from the BJP over allegations of irregularities in allot-ment of land by the Mysore Urban Development Authority (MUDA), the state is again in the news for its characteristic high-voltage politics. A group of Congress leaders has urged Rahul Gandhi, the Leader of the Opposition in the Lok Sabha, to warn those making such statements as they are "bringing down the morale of the cadre across the state". Instead of fighting the BJP and JD(S), such leaders are "demoralising cadres", who are "losing hope" in the government and the party, they said. Cow vigilante kidnapped, thrashed by two men in Than



Thane. A 30-year-old "gau rakshak" (cow vigilante) from Kalyan in Thane district was kidnapped and brutally assaulted by two men, police said on Wednesday. According to a complaint cited by the police, the victim was forcibly removed from his car by the two individuals, placed into an autorickshaw, and taken to a location on the Govind Wadi bypass road where he was severely beaten up at around 9.30 am on Tuesday. The attackers also verbally abused the victim, accusing him of tipping off the police about a pickup truck transporting beef, which had led to the vehicle's seizure,

After the assault, the victim, described as a "gau rakshak" (cow vigilante) in the FIR, was transferred to another vehicle and dropped near a flower market in the Patripool area, according to the police.

Police identified the accused as one Aslam Mulla and his brother Sam, and said efforts were going on to apprehend them.

They have registered an FIR against the duo under sections 137(2) (kidnapping), 118(1) (voluntarily causing hurt or grievous hurt by dangerous weapons or means), 352 (intentional insult with intent to provoke a breach of peace), 351(3) (criminal intimidation), and 3(5) (criminal act done by several persons in furtherance of a common intention) of the Bharatiya Nyaya Sanhita.

Malaika's father falls from 6th floor of Bandra bldg, dies

Mumbai. Bollywood actress Malaika Arora's father, Anil Mehta(62), allegedly died by suicide after falling from the balcony of his sixth-floor apartment at Ayesha Manor in Bandra (W) on Wednesday.

Bandra police are investigating the case to determine the motive behind his action as no suicide note was found at the scene.Initial suspicions point towards old age and depression due to ill health as the reasons for this extreme step.Police are also looking for Mehta's diary hoping that it may provide insights into the exact cause behind his action, said police sources. Mehta, originally from Fazilka in Punjab, had worked in the Indian Merchant Navy.

The deceased was in the balcony when he fell off between 10.30am and 11am. The family said they suspect it is a case of suicide. A case of accidental death report has been registered. No suicide note was found from the flat or in possession of the deceased ' said an officer from Bandra police station. "We are going through the building's CCTV footage."Mehta's wife was alerted to the incident by a building resident. "A resident standing near a parked car on the building premises saw him fall. The eyewitness alerted other residents who then called the police," the police officer said.

Following the incident, Malaika and her sister Amrita rushed to Ayesha Manor, while many celebrities visited to pay their respects. Probe lapses 'indirectly help accused, state not serious in tackling deficiencies': HC

Mumbai. Bombay high court on Wednesday expressed anguish over how police investigations are being conducted into crimes against women and stressed lapses "indirectly help the accused". "The state is not serious in tackling deficiencies," it added.

'We wanted to bring to your notice that this is the state of affairs. This is not about expressing pleasure or displeasure. It is our anguish... Regularly come across such cases and we implore you to bring it to the notice of higher authorities," Justices Ajay Gadkari and Neela Gokhale told advocate general Birendra Saraf. For instance, in two cases where the accused sought quashing of FIRs under IPC Section 354 for outraging of modesty, no seizure panchnama was done of the complainants' clothes that were allegedly torn. The judges noted in the Dindoshi case, Mumbai police commissioner Vivek Phansalkar had directed the torn clothes preserved by the complainant to be taken into account after the chargesheet was filed on June 12. "What happens with the most important piece of evidence?... Ultimately it results in acquittal," said Justice Gadkari. The judges also noted that in the Pune case, the investigation was done by a head constable. Saraf said the constable is suspended, but the judges said it is of no use.

46 detained after communal clashes in Mandya during Ganpati procession

Five of family killed in car crash near Chidambaram in Tamil Nadu

CUDDALORE. Five people, including two women and a child, were killed in a head-on collision between a car and a lorry near Chidambaram in the early hours of Thursday.

The victims were travelling from Chennai to Mayiladuthurai district after visiting a relative who had been hospitalised.

The victims have been identified as A Muhammad Anwar (56) of Nakkampadi, near Kuthalam in Mayiladuthurai district, along with his relatives B Shahida Begum (60) of the same village, M Arafat Nisha (27), her son M Adnan (4) of Thirumangalam, and S Yasar Arafat (38) of Karuppur, near Kumbakonam in Tanjore district. They started their return journey late Wednesday, with Yasar Arafat driving the



car.The accident occurred in the early hours of Thursday, at around 2 am, on the Villupuram-Nagapattinam highway, which is still under construction. While crossing the flyover at Anaiyankuppam, near Chidambaram in Cuddalore district, the car collided with a lorry that was carrying soap from Chidambaram to Cuddalore. All five occupants of the car were found dead at the scene. "The car as severely damaged, and all five were trapped inside. They were already dead when we arrived," said a police official. The bodies were taken to the Government Hospital in Chidambaram for post-mortem.

Parangipettai police have registered a case and are searching for the lorry driver and cleaner, who fled the scene after the accident. "The accident likely occurred because both vehicles were travelling at high speed on the single-lane, as the road was under construction," a police source alleged. The damaged vehicles were cleared from the highway.

ED conduct raids in Mumbai, Kolkata over Axis Mutual Fund front-running case

Mumbai. The Mumbai Zonal Office of the Enforcement Directorate (ED) conducted a series of raids in Mumbai and Kolkata on September 9 under the Foreign Exchange Management Act (FEMA) of 1999, as part of an ongoing investigation into a front running scheme involving Axis Mutual Fund.

During the raids, the central probe agency seized movable assets, including foreign currencies worth Rs 12.96 lakh (GBP, Euro, and AED), various incriminating documents related to overseas immovable properties, and digital devices. The investigation was initiated following an interim order from the Securities and Exchange Board of India (SEBI), which accused Viresh Joshi and others of engaging in front running, earning wrongful gains estimated at Rs 30.56 crore. Front running is a fraudulent practice in securities trading, where a broker or trader makes trades for their account based on advanced knowledge of pending orders from their clients. This practice is illegal as it gives the trader an unfair advantage and compromises market integrity. According to sources, the ED's investigation has uncovered significant evidence exposing the mechanics of the front running scheme. Joshi allegedly shared market-sensitive information with brokers operating from terminals in Dubai in exchange for kickbacks. He also approached other entities in India, renting their trading accounts to execute his strategy.

The illicit gains generated from the scheme were reportedly received by Joshi in cash and funnelled through Kolkata-based operators into multiple shell companies. These companies then provided unsecured loans to Joshi, his family, and the firms

A spokesperson from Dr Moopen Medical College, where Jensen had been admitted, confirmed that he died at 8:50 pm, following a critical struggle with multiple injuries sustained in the accident. The doctors had noted his extremely low vital signs, excessive bleeding from his nose, and severe internal bleeding in his brain, news agency

reported. Jensen's accident occurred on Tuesday when



his car collided head-on with a private bus. Shruti and several of Jensen's family members, who were also in the vehicle, sustained injuries but survived the crash. Despite the best efforts of medical staff, Jensen, who worked at a car cleaning company, could not be

The landslide disaster on July 30 claimed the lives of nine of Shruti's family members, including her parents, Shivanna and Sabitha, and her younger sister, Shreya, in the villages of Chooralmala and Mundakkai in Meppadi panchayat. The calamity left her without any close relatives. Her fiancé, Jensen, with whom she had shared a decadelong relationship, was her sole

source of support during this painful time. The couple got engaged on June 2, just weeks before the tragedy.

On August 29, Shruti and Jensen visited the Puthumala crematorium where some of her family members were cremated, reaffirming

their commitment to each other in the shadow of immense loss. Days later, their world was again shattered when Jensen was critically injured in a car accident

Gurgaon. Congress general secretary Randeep Surjewala's son Aditya and five women, including an advocate, are among the 40 names declared by Congress in its third list of candidates released late on Wednesday. With the latest list, candidates for just ten of the 90 seats are yet to be announced by Congress for the Oct 5 assembly polls. The party had earlier declared Mohit Grover as its Gurgaon candidate and fielded Vardhan Yadav from Badshapur. On Wednesday, Pearl Chaudhary's nomination was declared from the Pataudi assembly seat. Sohna is the only seat from the district for which Congress is yet to announce its candidate.Aditya Surjewala, in his electoral debut, will contest from Kaithal. He has been associated with Congress youth wings from Narwana and other parts of the state. Congress reposed its trust in another youth leader and fielded Parag Singh – an advocate and wife of an army man – from Ballabgarh in Faridabad.

The other women candidates on the list includes the name of Pooja Chaudhary, the wife of Ambala MP Varun Chaudhary. Pooja will fight from Mulana. Other women on the list are Sunita Virk from Karnal, Pearl Chaudhary from Pataudi and Anita Yadav from Ateli. Anita Yadav will be up against Aarti, the daughter of sixtime MP and Union minister Rao Inderjit Singh.

Colleges cut Rs1k as penalty for cancelling admissions

Gurgaon. Colleges can deduct a fixed amount if a student cancels their admission after enrolling and refund the remaining money, said the Department of Higher Education. This year, the amount has been fixed at Rs 1,000. Students who secured admission by paying a late fee will not receive a refund of the same. The department has issued directives to colleges about the decision. If a student cancels their admission within a week of enrolling, they will receive a full refund of the fees, but the late fee will not be refunded. The Department of Higher Education is currently conducting an admission process for vacant seats in the first year of undergraduate courses through open

Govt employees press for old pension scheme ahead of polls

Gurgaon. As the election campaign intensifies, the debate surrounding the old pension scheme (OPS) has resurfaced. Demanding reinstatement of the old scheme, a group of govt employees wore black ribbons and bands at their workplaces in protest.Congress already implemented the OPS in Himachal Pradesh (despite a financial crisis) and made a similar promise in Rajasthan. Although the party has not yet released its manifesto for the Haryana assembly elections, it has been vocal in its support for the old scheme. On the other hand, BJP does not favour it. However, Centre introduced the unified pension scheme (UPS). The Pension Restoration Struggle Committee, which has been organising protest marches, argues that "UPS is not in the interest of the employees". The committee had planned an OPS Tiranga March in Rohtak on Sept 8 after Ambala on Aug 25, and Hisar on Sept 1. However, the Rohtak administration cancelled the permission a day before the event. Dr Arvind Yadav, a member of the committee and in charge of Gurgaon and Rewari, said, "Cancelling the permission for the OPS Tiranga March is an infringement of the democratic process. All employees and officers in the state will wear black ribbons from Sept 9 to Sept 11 to express their anger."He added that UPS is not in the interest of employees, and they cannot benefit without the OPS "Our struggle will continue until the restoration of OPS," he said. Congress MP Deepender Sinh Hooda earlier termed the UPS as "anti-employee" and assured restoration of OPS after the formation of the Congress govt in Haryana. State media in-charge of Haryana BJP Arvind Saini said the govt should take a rational and financially viable decision."Restoration of OPS is not financially viable and prudent. The union govt has introduced UPS for the welfare of the govt employees, he said. The UPS was approved on Aug 24, announcing an assured pension of 50% of the basic salary for those who joined after Jan 1, 2004.

Employees opting for UPS would be eligible for an assured pension after 25 years of service. Under the OPS, effective before Jan 2004, employees got 50% of their last drawn basic pay as a pension. Unlike the OPS, the UPS is contributory.

Light rain brings down mercury by 3°C

Gurgaon: The India Meteorological Department (IMD) issued an 'orange' alert for Thursday, forecasting heavy to very heavy rainfall accompanied by thunderstorms at isolated locations. The department also issued 'yellow' alert for Sept 13 and Sept 14, indicating the possibility of continued precipitation.

Various parts of the city experienced light showers throughout the day on Wednesday and the minimum temperature recorded was 24.9 degrees Celsius, 0.4 degrees above the normal for this time of year. The maximum temperature was 31.8 degrees Celsius, 3.4 degrees lower than the previous day.

"Heavy to very heavy rainfall is anticipated on Thursday, while on Friday and Saturday, Haryana may witness heavy rain in isolated areas," an IMD official stated. The IMD defines heavy rain as 64.5–124.4 mm of rainfall in a day.

The weather department also warned that waterlogging in low-lying areas could cause traffic disruptions in some parts of the city due to the heavy rain. The department advised people to avoid venturing out unless necessary. Meanwhile, the MCG and GMDA allocated resources towards ensuring the city's drainage system does not get blocked due to the anticipated rain. All master drains and sewer lines falling under GMDA were cleared and pumps and personnel were kept in reserve. The MCG deployed machinery including 62 suction tankers, 61 tractormounted pumps, and 25 diesel engines, to quickly drain out water from waterlogged areas.

Light rain lashed parts of Delhi on Wednesday. An 'orange' alert was issued for the capital as well for light to moderate rain or thundershowers in many places, accompanied by gusty winds at a speed of 30-40 kmph, on Thursday.

First flight in April 2025, NIA to get new power connection by Sept end main receiving substation (MRSS).

Noida. With flight operations from Noida International Airport likely to start by Apr 2025, the power department will start providing staggered electricity connection to the terminal. While the airport will use an estimated 93.5 MVA by 2030, by Sept end, a 4MVA power connection will be provided. Currently, the discom has provided a temporary power connection for the works underway at the terminal, its runway and the ATC tower.

An application for the phased power supply was submitted to the chief engineer of Noida's power department on Feb 13 last year for the energy storage system (ESS) of Yamuna International Airport Pvt Ltd and the

Subsequently, two separate 2MVA connections were approved —on Oct 21, 2023, for MRSS and on Aug 17 this year for ESS.On Wednesday, Uttar Pradesh Power Corporation Limited (UPPCL) officials said the 4MVA connection will be provided by this month from two 33kV lines that will be energised by two 132kV substations in sectors 18 and 32 in the areas under Yamuna Expressway Industrial Development Authority. The two substations are currently waiting for safety certificates from the directorate of electrical safety, which are expected within this month, Harish Bansal, chief zonal engineer, told TOI.

Street vendor paying 5k 'hafta' a month gets full refund as corpn makes harasser pay up

Gurgaon.In an attempt to curb rampant extortion of street vendors, Municipal Corporation of Manesar (MCM) assisted a vendor in recovering the amount he paid to a clerk of a private firm outside which he had set up his stall. The vendor, Rajiv Mishra, had a licence to operate the stall from the MCM under the Street Vending Policy-2014. However, he was made to pay Rs 5,000 every month in exchange for permission to run his stall set up at ÎMT, Sector 7.The case came to light when Mishra, who was unable to pay the amount for two months, approached MCM following harassment by the clerk. On not receiving the amount, the clerk allegedly confiscated Mishra's gas cylinders and forcibly locked his stall. The civic body intervened and recovered Rs 65,000 that he had paid since Sept 2023, with help of the

police, demonstrating intolerance to the practice of extortion."The clerk asked for money in exchange of allowing me to operate my business. When I didn't pay up, he locked my It is every citizen's duty to raise their stall. I had a licence to operate my stall and so, I approached the corporation," said Rajiv, who was felicitated by the corporation for speaking up against the harassment. 8 years gone, MCG still doesn't have land for cultural complex

Gurgaon. The city's equivalent of India Habitat Centre (IHC) in Delhi, the cultural complex announced in 2016 was assigned five acres of land in Sector 53, but in the years since, officials are back to looking for a site for the project.

It was in 2015 that the cultural complex — a onestop destination for art, performances and events in the city — was conceived on the lines of IHC on Lodhi Road in the heart of the capital. Then chief minister Manohar Lal Khattar formally announced the project in 2016. At the time, the city had just one such site, Epicentre in Sector 44, but that shut down in 2017.

Artists have time and again demanded that the Millennium City, with its reputation as a corporate and IT hub, must offer its increasing population spaces dedicated to cultural events and experiences. There's currently just an open theatre in Sector 29 that acts as the city's de facto cultural centre, though it is too little to do the role any justice.Land earmarked for the cultural complex in Sector 53 belonged to Haryana Shehri Vikas Parishad (HSVP), and because of that, MCG had signed an MoU with the agency to use it for the project. Haryana govt gave its administrative approval in 2019, and a detailed project report (DPR) was prepared with an estimated budget of Rs 194 crore. The corporation floated a tender, but no firm showed an interest. Seeing no movement, govt handed over the project to its public works department, but in Feb 2020, MCG took back charge as PWD hadn't started any work on the complex either. The corporation woke up to the cultural complex two years later, still nothing changed on the ground. It was in May 2023 that the urban local bodies (ULB) department told MCG to invite tenders for the Wazirabad stadium and the cultural complex. A few months down the line, in Sept, ULB department again told MCG to expedite the process for the complex.MCG,

Dhaka, Bangladesh Bangladesh's Chief Adviser Dr Muhammad Yunus on Wednesday said his country wants good relations with India and other neighbouring nations on the basis of "fairness and

In a televised address, marking the first month of the interim government's formation, Yunus said after he took oath as the head of the administration, many foreign leaders, including Indian Prime Minister Narendra Modi and his Pakistani counterpart Shehbaz Sharif, telephoned to congratulate him. We want good relations with India and other neighbouring nations, but that relations should be on the basis of fairness and equality," he said. Yunus said Bangladesh has already started high-level bilateral cooperation talks with India to deal with floods."I have also taken the initiative to revive SAARC to enhance regional cooperation in South Asia," he said. SAARC comprises Afghanistan, Bangladesh, Bhutan, India, the Maldives, Nepal, Pakistan and Sri Lanka.

Typhoon Yagi sweeps through Vietnam: More than 170 dead, flood waters threaten Hanoi

World. While, the state-run power utility, EVN, announced on Wednesday that it had cut off power to some flooded areas of the capital due to safety concerns. Mai Van Khiem, director of the National Centre for Hydro-Meteorological Forecasting, stated that the Red River was at its highest level in two decades, with more rain expected over the next two days. The government has estimated that the typhoon and subsequent landslides and floods have killed 179 people, with 145 others reported missing. The Blue Dragon Children's Foundation, a charity, evacuated its office on Tuesday after authorities warned of flood risks. Spokesperson Carlota Torres Lliro expressed concern for the dozens of children and families living in makeshift houses by the river, news agency Reuters stated.EVN also reported that it had halted water discharge from the Hoa Binh hydropower dam, the second largest in northern Vietnam, into the Da River, a tributary of the Red River, to reduce water flow.Additionally, Vietnamese authorities have raised concerns about Chinese hydropower plants releasing water into another tributary of the Red River, the Lo River (known as Panlongjiang in China), though Beijing has stated that the two countries are cooperating on flood prevention."My house's first floor is completely under water. Now we have no fresh water and electricity," Nguyen Duc Tam, a 40-year-old resident of Thai Nguyen, about 60 km (37 miles) from Hanoi, told Reuters.

Factories and warehouses in coastal industrial hubs east of Hanoi have been severely affected, with many forced to close, potentially disrupting global supply chains.

From Chinese to Italians and beyond, maligning culture via its foods is longtime American habit

NEW YORK. It's a practice that's about as American as apple pie - accusing immigrant and minority communities of engaging in bizarre or disgusting behaviors when it comes to what and how they eat and drink, a kind of shorthand for saying they don't belong. The latest iteration came at Tuesday's presidential debate, when former President Donald Trump spotlighted a false online tempest around the Haitian immigrant community of Springfield, Ohio. He repeated the groundless claim previously spread by his running mate, JD Vance, that the immigrants were stealing dogs and cats, the precious pets belonging to their American neighbors, and eating them. The furor got enough attention that officials had to step in to refute it, saying there was no credible evidence of any such thing.But while it might be enough to turn your stomach, such food-based accusations are not new. Far from it.Food-related scorn and insults were hurled at immigrant Chinese communities on the West Coast in the late 1800s as they started coming to the United States in larger numbers, and in later decades spread to other Asian and Pacific Islander communities like Thai or Vietnamese. As recently as last year, a Thai restaurant in California was hit with the stereotype, which caused such an outpouring of undeserved vitriol that the owner had to close and move to another location. Behind it is the idea that "you're engaging in something that is not just a matter of taste, but a violation of what it is to be human," says Paul Freedman, a professor of history at Yale University. By tarring Chinese immigrants as those who would eat things Americans would refuse to, it made them the "other."

Biden, Trump, Kamala Harris appear together at 9/11 ceremony in New York

New York With presidential candidates looking on, some 9/11 victims' relatives appealed to them on Wednesday for accountability as the US marked an anniversary laced with election-season politics.In a remarkable tableau, President Joe Biden, former President Donald Trump and Vice President Kamala Harris stood together at ground zero just hours after Trump and Harris faced off in their first-ever debate. Trump and Biden — the successor whose inauguration Trump skipped shook hands, and former New York Mayor Michael Bloomberg appeared to facilitate a handshake between Harris and Trump. Then the campaign rivals stood only a few feet (meters) apart, Biden and Bloomberg between them, as the hours-long reading of victims' names began. At Trump's side was his running mate, Senator JD Vance. The image was one of putting politics aside at this year's solemn commemoration of the hijacked-plane attacks that killed nearly 3,000 people on September 11, 2001. But some victims' relatives, after reading out names, delivered political messages of their own."We are pleading for your help, but you

ignore us", Allison Walsh-DiMarzio said, directly challenging Trump and Harris to press Saudi Arabia about any official involvement in the attacks. Most of the 19 hijackers were Saudi, but the kingdom denies it was behind their plot."Which one of you will have the courage to be our hero? We deserve better", Walsh-DiMarzio said. She's a daughter of 9/11 victim Barbara P Walsh, an administrative assistant. Joanne Barbara was one of multiple readers who spoke out against a now-revoked plea deal that military prosecutors struck with alleged 9/11 mastermind Khalid Sheikh Mohammed and two fellow defendants."It has been 23 years, and the families deserve justice and accountability", said the widow of Assistant Fire Chief Gerard A Barbara.Biden, on his last September 11 in office, and Harris paid respects on Wednesday at all three 9/11 attack sites: ground zero, the Pentagon and a rural part of Pennsylvania. The president, vice president — and, separately, Trump — laid wreaths on Wednesday afternoon at the Flight 93 National Memorial near Shanksville, Pennsylvania. Biden and Harris spoke with



victims' relatives and visited the local fire department; Trump and Vance went to a New York City firehouse earlier in the day. The Flight 93 memorial stands where one of the hijacked planes crashed after crew members and passengers tried to storm the cockpit. Trump described the site as an "incredible place" in brief remarks from afar to reporters. The attacks killed 2,977 people and left thousands of bereaved relatives and scarred survivors. The planes took down the World Trade Center's twin towers and carved a gash in the Pentagon, the US military headquarters, where Biden

and Harris laid a red, white and blue wreath on Wednesday afternoon.While many Americans may not observe 9/11 anniversaries anymore, "the men and women of the Department of Defense remember", Defense Secretary Lloyd Austin said earlier in the day. The attacks altered US foreign policy, domestic security practices and the mindset of many Americans who had not previously felt vulnerable to foreign extremists. Effects rippled around the world. Victims came from more than 90 different countries, and

the US responded to the attacks with a "Global War on Terrorism". US-led invasions of Afghanistan and Iraq killed hundreds of thousands of Afghans and Iraqis and thousands of American troops.Communities around the country hold events on the anniversary, which Congress has titled both Patriot Day and a National Day of Service and Remembrance.

Thousands of Americans comemorate it with volunteer work - among them Harris' running mate, Minnesota Governor Tim Walz. He packed meals in St. Paul for people

Ohio man slams Trump, Vance for politicising son's death in immigration row

World During Tuesday's presidential debate, Donald Trump referenced Springfield, Ohio, as an example to criticise immigration and attack Kamala Harris. He alleged, "Look at Springfield, Ohio, or Aurora, Colorado. Immigrants are taking over towns, violently occupying buildings. These are the people Biden and Harris have allowed in, and they are destroying our country. They're dangerous and at the highest level of criminality." Meanwhile, in Springfield, just an hour before the debate, Nathan Clark, father of an 11-year-old boy named Aiden who died in a crash involving an immigrant's vehicle, spoke out against Trump and his ally JD Vance. Speaking at a Springfield City Commission meeting, Clark condemned the politicians for exploiting his son's death to spread hate. The 11-year-old had died after a car crossed the centreline on a two-lane road and struck a school bus carrying dozens of children. Clark, who



was thrown off the bus as it veered off the roadway and flipped, died on the spot.Hermanio Joseph, a 35-year-old Haitian national, was behind the wheels of the car that caused the accident. He was convicted of involuntary manslaughter in May and faces up to nine years in prison.

The incident, which occurred over a year ago, became a flashpoint for growing tensions about the influx of Haitian immigrants to the area.

The debate intensified after JD Vance, a political ally of Trump, brought national

attention to Springfield's demographic changes, labelling them as harmful consequences of Biden's border policies. These immigrants, who have legal status and work permits, have moved to Springfield to fill jobs in manufacturing and other industries. However, Vance's remarks have stoked fears and amplified false narratives. The Trump campaign further escalated the issue by posting

on social media about Aiden, featuring his picture alongside that of Hermanio Joseph, the Haitian immigrant involved in the crash. Vance went a step ahead and alleged that "a child was murdered by a Haitian migrant."However, the politicisation of Aiden Clark's death is something that his parents never wanted and have now spoken against.During the meeting on Tuesday, Nathan Clark, standing beside his wife Danielle, expressed his heartbreak and frustration over the manipulation of his son's death.

34 killed as Israeli airstrikes hit United Nations school, homes in Gaza

Gaza Strip Israeli airstrikes across Gaza overnight and Wednesday hit a UN school sheltering displaced Palestinian families as well as two homes, killing at least 34 people, including 19 women and children, hospital officials said. A UN official said six staffers were among the dead. The war in Gaza is now into its 11th month, with tens of thousands of people dead, and international efforts to mediate a cease-fire between Israel and the Hamas militant group have repeatedly stalled as they accuse each other of making additional and unacceptable demands. In the occupied West Bank, Israeli troops launched raids in several towns backed by airstrikes, continuing a crackdown across the territory that the military says is targeting militants but has wrecked neighbourhoods and killed civilians. One airstrike killed five people the military said were militants threatening its troops. A second strike on a car killed at least three people, the Palestinian Health Ministry said. An attacker crashed a fuel truck into a West Bank bus stop near the Israeli settlement of GIvat Assaf, killing an Israeli soldier, the military said. Officials said soldiers and an armed civilian "neutralised" the attacker. The strike on the UN's al-Jaouni Preparatory Boys School in the Nuseirat refugee camp killed at least 14, including two children and a woman, officials from Awda and al-Aqsa Martyrs hospitals said. At least 18 other people were wounded, they said. The Israeli military said it was targeting Hamas militants planning attacks from inside the school. The claim could not be independently confirmed. One of the children killed was the daughter of Momin Selmi, a member of Gaza's civil defence agency, which rescues wounded and retrieves bodies after strikes, the agency said. Gaza's schools are packed with tens of thousands of Palestinians driven from their homes by Israeli offensives and evacuation orders. The al-Jaouni school, one of many in Gaza run by the UN agency for Palestinians, or UNWRA, has been hit by multiple strikes during the war.UNRWA said six staffers aiding the displaced, including the manager of the shelter, were killed. "Humanitarian staff, premises & operations have been blatantly & unabatedly disregarded since the beginning of the war," the agency's director, Philippe Lazzarini, wrote on X.

Tajikistan's chief mufti injured in attack in Dushanbe mosque



World. Tajikistan's top Muslim cleric Šayeedmukarram Abduqodirzoda got injured in a stabbing attack outside a mosque in the capital city on Wednesday. Abduqodirzoda, the chairman of the country's Islamic Council of Ulema, was attacked following a

prayer service in Dushanbe, the interior ministry said as reported by Reuters. The attacker was detained, and authorities have launched an investigation into the incident. Abdugodirzoda, 61, a respected religious leader in the predominantly Sunni Muslim country, sustained minor injuries and was released from the hospital.

Peru's ex-President Alberto Fujimori, convicted for human rights abuses, dies

Lima Former Peruvian president Alberto Fujimori, who steered economic growth during the 1990s but was later jailed for human rights abuses stemming from a bloody war against Maoist rebels, died on Wednesday. He was aged 86. Close But many Peruvians saw Fujimori as an colleagues visited him earlier in the day, reporting that he was in a critical condition."After a long battle with cancer, our father... has just departed to meet the Lord," his daughter Keiko Fujimori wrote in a message on X, also signed by te former leader's other children. Fujimori, the son of Japanese immigrants, was the little-known chancellor of a farming university when elected to office in 1990. He quickly established himself as a cunning politician whose hands-on style produced results even as he angered critics for concentrating on power.He slayed hyperinflation that had thrown millions of Peruvians out of work, privatised dozens of state-run companies. and slashed trade tariffs, setting the foundations for Peru to become, for a while, one of Latin America's most stable economies. Under his watch, the feared

leader of the Maoist Shining Path, Abimael Guzman, was captured - dealing a crucial blow to a movement that in the 1980s seemed close to toppling the Peruvian state. Guzman died in prison in September 2021.

autocrat after he used military tanks to shut down Congress in 1992, redrafting the constitution to his liking to push free-market reforms and tough anti-terrorism laws.

A slew of corruption scandals during his 10vear administration also turned public opinion against him. Shortly after he won a third election in 2000, amending the constitution to run, videos emerged of his top adviser and spy chief Vladimiro Montesinos doling out cash to bribe politicians. Fujimori fled to exile in Japan.

He resigned via fax from Tokyo and then unsuccessfully campaigned for a Japanese senatorial seat. Montesinos was later captured in Venezuela and jailed, convicted for the hundreds of videos he recorded of himself handing out cash bribes to politicians and business and media executives. The cases against Fujimori piled



up, including accusations that he had ordered the use of death squads in his battle against Shining Path militants. Fujimori was safe in Japan - he was a dual citizen and Japan does not extradite its citizens. So many were shocked when, in 2005 he decided to head back to Peru, apparently in hopes of forgiveness and a return to politics.Instead, he was detained during a layover in Chile, extradited to Peru in 2007, and in 2009 he was convicted and sentenced to 25 years in prison.

'FUJI-SHOCK' Once jailed, Fujimori's public appearances

often appeared dishevelled and unwell. While detractors dismissed his health complaints as a ploy to get out of prison, then-president Pedro Pablo Kuczynski briefly pardoned Fujimori in 2017. Months later, Kuczynski was impeached, and the pardon overturned by Peru's top constitutional court, sending Fujimori back to the special prison that held him and no other inmates. The court restored the pardon in December 2023, releasing the ailing Fujimori, who had suffered from stomach ulcers, hypertension and tongue cancer. In May 2024, Fujimori announced he had been diagnosed with a malignant tumour.Fujimori's legacy has been most passionately defended by his daughter Keiko, who has been close to clinching the presidency herself three times on a platform that has included pardoning her father and defending his constitution. The late Fujimori was born in Lima on Peruvian Independence Day, July 28, 1938.A mathematician and agricultural engineer, Fujimori was a political nobody when he decided to run for

She was one of the first two

Muslim-American women elected to Congress.Born in Somalia, Omar and her family fled the country's civil war when she was eight. The family spent four years in a refugee camp in Kenya before coming to the United States in 1990s. In 1997, she moved to Minneapolis with her family.Before

worked as a community educator at the

University of Minnesota, was a Policy

Fellow at the Humphrey School of Public Affairs and served as a Senior Policy Aide for the Minneapolis City Council.Omar is Budget Committee. Mumbai likely to get 7th Vande Bharat Express train on Kolhapur route

MUMBAI. In a significant boost to rail connectivity, Mumbai is likely to receive its 7th Vande Bharat Express, with plans underway to operate the semi-high-speed train on the Mumbai-Pune-Kolhapur route.

This will be the second Vande Bharat Express from Mumbai to connect Pune, following the CSMT-Pune-Solapur route. The introduction of this train is expected to enhance connectivity for passengers travelling between Mumbai, Pune, and Kolhapur, making journeys faster and more convenient, and further boosting economic ties in the region. A senior Central Railway (CR) official said, "At present, the fastest train between Mumbai and Kolhapur is the Mahalaxmi Express, which covers the distance in around 10.30 hours.'

The Mahalaxmi Express train covers a total distance of 518 kilometres. The average speed of the Mahalaxmi Express train is 48.94 Kmph.

The Vande Bharat, with its superior acceleration and deceleration capabilities, is expected to significantly reduce travel time, although the exact schedule is yet to be finalised. Another official added, "With the completion of the Pune-Miraj line doubling, there is now more track availability to allow faster train operations. This will undoubtedly result in substantial time savings compared to the existing services on this route.'

With this addition, Central Railway will operate five Vande Bharat Express trains from Mumbai, while Western Railway will continue with two, running between Mumbai and Gujarat. WR's services include the Mumbai Central-Gandhinagar and Mumbai Central-Ahmedabad routes.

Maharashtra's total count of Vande Bharat Express trains will rise to 11, including existing services from Nagpur and Pune. Additionally, two more routes-Nagpur-Secunderabad and Pune-Hubli-are likely to be introduced soon. The Vande Bharat Express, celebrated for its speed, comfort, and cutting-edge facilities, remains a key component of Indian Railways' modernisation efforts, offering passengers a superior travel experience.

Now, Mumbai's Marine Drive to CSMIA T2 in 30 minutes

MUMBAI. Imagine driving from south Mumbai to the international terminal of the airport in just about 30 minutes. Motorists can look forward to a signal-free drive from Marine Drive to T2 as the north-bound Coastal Road connector to the Bandra-Worli Sea Link is set to partially open on Friday, a day after its inauguration. This journey would normally take 90 minutes to two hours on a heavy traffic day. But the Coastal Road could speed up the traffic

The Coastal Road from Marine Drive to Worli has been operational, but one arm of the connector bridge to the Sea Link is under motorists will be able to access the Sea Link, continue to Bandra, and then take Western Express Highway to the airport.

Currently, it takes less than 10 minutes to drive through the Coastal Road and another 10 minutes on the Sea Link. Nandini Chabria, a member of the Breach Candy Residents Forum, said this duration assumes minimal traffic and non-peak hours. "We frequently encounter traffic jams at the Breach Candy and Worli exits, which highlights the importance of good last-mile connectivity. If it's lacking, the entire project's benefits cannot be reaped, especially when it's built at such a high cost. That has not been an issue with Marine Drive, where exits are smooth," said Chabria. "During non-peak hours, zooming through the road is a breeze."

Ahmedabad. In a strategic move ahead of the city's bid for the 2036 Olympics, state govt has earmarked 5.50 lakh sq m of land in Nana Chiloda for world-class sports infrastructure. This prime location will join the ranks of Motera, Bhat, Koteshwar and Manipur-Godhavi as areas undergoing significant development to accommodate Olympic-level sporting events.

The state urban development department and Ahmedabad Urban Development Authority (Auda)'s Olympic cell have earmarked the land adjacent to Sabarmati Riverfront Phase 3, for Olympics infrastructure. The third phase of the riverfront includes the stretch between Indira Bridge and Narmada Canal. On Tuesday, Ahmedabad Municipal Corporation's town planning committee earmarked 1.86 lakh sq m of land in TP Scheme 241 in Nana Chiloda and 'reserved this area for commercial sale' purposes. Also, roughly 3.50 lakh sq m of state revenueowned land was also reserved.

A senior source in AMC told, "A letter was sent by state govt's urban planning and valuation department to Sabarmati Riverfront Development Corporation Ltd's (SRFDCL) executive director and to Auda's Olympic cell to reserve private lands in TP Scheme 241 of Nana Chiloda for Olympic infrastructure."

Abode ready, but politics stalls King Mahabali's arrival at Thrikkakara

KOCHI. The renowned Thrikkakara temple in Kochi is one of the few shrines in Kerala dedicated to Lord Vamana, the fifth incarnation of Lord Vishu. Myth has it that Thrikkakara is also where Lord Vamana met King Mahabali, and is the reason why Onam is celebrated ardently in the region.

Hence, it was only natural that the place also serve as the abode of the benevolent and generous demon king. The decision was taken. A prominent spot on the corner of the temple's right entrance was selected for installing a bronze statue of King Mahabali. A sum of Rs 1 crore was allotted for the project.

That was in 2016. Eight years later, all that graces the spot is a half-built, fullyneglected 'Smriti Mandapam'. No statue.

The Travancore Devaswom Board (TDB) had on October 21, 2016, decided to construct the 'Smriti Mandapam' at the temple, one of the 105 Vaishnav temples in the country, and install the king's statue. The work began and the foundation and the mandapam were built within a year. Then things came to a standstill.

Ajay Tharayil, the then TDB member, blamed some members for stalling the project mid-way by giving it a "political and religious contour.""The TDB decided



to set up a bronze statue of the Mahabali, considering the region's historical prominence with regard to the demon king, as per the myth. A sum of Rs 1 crore was allotted in the budget too. However, certain members in TDB opposed the project midway and the work was suspended. There has been no progress since... think the TDB has dropped the project," said Ajay, a Congress leader under whom the project took shape.

People could connect the myth related to the harvest festival of Onam, that is centered around the Mahabali. That was our idea, but then it was given a political and religious contours," Ajay said.

'Difference of opinion in TDB over statue's design stalled project' Ajay expressed

confidence that if the Congress comes to power, the project will be implemented.

In between, a writ petition was filed against installation of a statue of King Mahabali within the "precincts of a temple dedicated to Lord 'Vamana'". However, sources said it was disposed of, after the TDB contended that it purchased 5.680 cents for the purpose just outside the temple compound.

When contacted, temple secretary P C Pramod Kumar said the temple administration has got nothing to do with the project. "The project to install the statue has been lying idle for the past several years. It's a matter concerning the

Meanwhile, Hindu Aikya Vedi denied that right-wing Hindu outfits were against the statue's installation. "We have no objection... What led to the project getting stalled is difference of opinion within TDB over the statue's design. The one finalised was a drawing of Mahabali by former Travancore King Marthanda Varma in which the king is depicted as a warrior as against his common image as a fat, pot-bellied person," said senior Hindu Aikya Vedi leader R V Babu.

Locations shortlisted for GMB's port-led city

Ahmedabad. Reviving its port-led city project envisaged over a decade ago, the Gujarat Maritime Board (GMB) is making progress by finalizing four locations to realize this ambitious project.

The state maritime regulator has shortlisted Porbandar, Bhavnagar, Surat and Valsad for this urban transformation project, often touted to be built on the lines of global shipping hubs like Dubai and Singapore. The project promises industrial growth, job creation and a thriving maritime ecosystem that can push Gujarat to the forefront of global trade and development. The locations were carefully chosen, factoring in deep-water access, ample waterfront space, strong road and rail connections, and their potential to support long-term industrial growth.

Rajkumar Beniwal, MD of GMB, highlighted the project's scale: "We are developing a port city with a complete ecosystem, much like Dubai or Singapore. After an international consultant's study, we narrowed down from 10 to four prime locations. The port city will be built over 300-400 sq km in phases. It will feature a port, industrial zone for MSMEs, logistics hub with warehousing, and residentialcommercial zones. It's set to attract major investments. The final site will be chosen in three months." Among the shortlisted sites, South Gujarat stands out with its excellent connectivity and proximity to key cargo hubs like SEZs. Bhavnagar is another strong candidate, thanks to its deep draft and strategic location. Other coastal areas of Gujarat were also considered, widening future opportunities for similar developments.Senior GMB officials explained that the final four locations were selected through a multi-criteria analysis framework, ensuring they met all maritime, industrial and environmental requirements.

No full-time chief fire officer in 4 major cities

Surat/Rajkot/Ahmedabad/Vadodara. When a disaster strikes a city, whether it is a

fire, flood or an accident, the fire and emergency service (FES) department is the first to be called upon. However, despite the crucial role it plays, the process of recruiting a chief for the department is not met with the urgency it deserves. For over a decade now, Surat and Vadodara have not had a full-time or regular chief fire officer (CFO). In Ahmedabad, the post of CFO has been held by an in-charge officer for the past 42

Rajkot, which witnessed one of its worst fire tragedies just four months ago, is without a CFO after the officer and his deputy were arrested for alleged dereliction of duty in connection with the TRP Game Zone fire that claimed 27 lives. These vacant posts

come at a time when there has been considerable thrust of fire safety regulations and firefighting infrastructure in the state. Ahmedabad: Lack of suitable candidates

For the past 42 months, the CFO position at the Ahmedabad Municipal Corporation (AMC's) FES has been held by an officer in charge, with the process of appointing a permanent CFO still ongoing.

Following the retirement of former CFO M F Dastur in Jan 2021, Rajesh Bhatt, the thenadditional CFO, was given the charge. However, he left the position on Feb 28, 2022. Since March 2022, Jayesh Khadia has been the in-charge CFO.

In June, the AMC announced direct recruitment for several positions, including one CFO, one additional CFO, and two deputy CFOs. Out of the 53 applications received for the CFO's position, only two candidates qualified. As a result, the recruitment process was cancelled in Aug. A new announcement was made to fill the CFO's position in accordance with the recruitment rules of the state govt and AMC. The document verification process is underway.

Surat: Legal battle hampers

In Surat, the CFO's vacancy has persisted for over a decade despite the city expanding and its population growing significantly during the period. The absence of a permanent CFO was underscored by the Takshashila Arcade fire tragedy in May 2019 that claimed the lives of 22 students. Former Surat CFO Pankaj Patel was dismissed in 2014. While his dismissal was revoked after he went to the court, he was placed under suspension. As a result, the Surat FES has been operating without a regular CFO.

"As the matter was pending in the court, nobody was recruited on the post. But the Surat civic body has worked out an alternative and created the post of additional CFO until the regular CFO is appointed," a senior officer of the Surat Municipal Corporation (SMC) explained.

The additional CFO was given the CFO's responsibilities which include managing the fire and emergency service operations in the interim. Recently, Patel reached the age of retirement, making his potential reinstatement impossible even if the court ruled in his favour. In the wake of this development, the SMC has now initiated the process to recruit a new CFO.

The previous breaches severely impacted two villages, submerging thousands of acres of agricultural land.Pawan Kalyan spoke with the District Collector to assess the flood situation, with approximately 62,000 acres submerged due to heavy inflows from the Yeleru and Tandava reservoirs following intense rains. He was also informed that mudslides and waterlogging had caused traffic disruptions on the Pithapuram-Raparthi, Peddapuram-Gudivada, and Samalkot-Pithapuram roads in the Pithapuram and Peddapuram constituencies.

Vehicles were diverted onto the national highway at Gollaprolu. The Collector further mentioned that boats and support teams are conducting relief operations.

On Wednesday, a local resident of Surampeta, Esarapu Suribabu (62), passed away due to illness, and with no transport available, revenue officials arranged a boat to ferry the body to the burial ground. Residents of Gollaprolu, Pithapuram, and Kirlampudi mandals are facing severe hardships due to the ongoing floods.

Kerala Finance Ministers' conclave to call for revision of tax devolution mechanism

THIRUVANANTHAPURAM. Kerala's own tax revenue rose by Rs

30,000 crore during the past three years, Finance Minister K N Balagopalhas said. "The revenue rose from Rs 47,000 crore in 2020-21 to Rs 77,000 crore in 2023-24. But the state did not gain much from this as there was a considerable drop in central share of funds," he said.

The decline in central share has pushed the state into a financial crisis. The 16th Finance Commission should formulate its policies in view of this situation," he

What a JVP President may mean for India

AFTER a tumultuous three years during which Sri Lanka went broke and public protests forced the President to flee the country, it will elect a new President on September 21. The next President has to steer the country through the economic crisis, engage with the IMF over the financial bailout it received in 2023, address pending postwar issues of justice and accountability as well as political resolution of the Tamil question. He (all candidates are male) must also deal with the regional rivalry between India and China and big power geopolitics in the Indian Ocean.

A record 38 candidates are in the fray. Only three count. Incumbent Ranil Wickremesinghe, who took charge after President Gotabaya Rajapaksa fled, is banking on his two-year record of managing a bankrupt country and his acceptability to the international donor community. Sajith Premadasa, son of late President Ranasinghe Premadasa who was assassinated by an LTTE suicide bomber in 1992, is campaigning on his promise of a just government that works for "the welfare of all". Anura Kumara Dissanayake of the National People's Power, a coalition led by the Janatha Vimukthi Peramuna (JVP), who contested the elections in 2019, and polled just over three per cent of the vote, is campaigning as the candidate of the 'change' that voters want to see. Of the three, the 75-year-old Wickremesinghe is the only one who can claim experience of running a government. But he appears least likely to win. He is literally alone in this race, with no party or political support to speak of. His United National Party (UNP) is close to extinction after its rout to nil seats in the 2020 parliamentary election. Wickremesinghe's presidency is propped up in Parliament by the Sri Lanka Podujana Peramuna, the party of the reviled Rajapaksas. This association has made him even more unpopular. Plus he is taking the rap for conditions imposed by the IMF in return for its bailout package, negotiated on his watch, which have inflicted more economic pain.Premadasa is far more popular than Wickremesinghe. He walked out of the UNP with several others in 2020 when he realised Wickremsinghe would never hand over the party leadership to him. His Samagi Jana Balawegaya (SJB) or United People Power won more than 50 seats in Parliament, and is stronger than the parent party. He won brownie points for not succumbing to the lure of the prime ministership or the presidency in 2022 when it became evident he would have to depend on the Rajapaksas to keep him in office. Premadasa has promised to renegotiate the IMF deal so that its conditions do not hurt the people. He is going all out to woo not just the majority Sinhalese voters, but also the Tamil and Muslim communities. He is the only candidate to mention in his manifesto the 13th Amendment, a provision in the Sri Lanka Constitution to share political power with Tamils, with the promise of its "full implementation". This may hurt his campaign in the Sinhalese south, where devolution and federalism are bad words, much like Article 370 in India.Dissanayake is said to be the strongest contender. He is seen by most young voters as the symbol of "system change", the demand of the public uprising against the Rajapaksas. He was the first to call for renegotiating the IMF deal. The party's formidable cadre-based grassroots mobilisation has been laying the groundwork for over three years. But for those old enough to have witnessed the JVP's insurgencies in 1971 and from 1987-1990, the promise of Dissanayake is laced with memories of the violence of those years, and concerns about its political ideology. The JVP, which began as a radical left organisation, was banned after its first attempt to take over the state. But the JVP rose up again in 1987 against the Sri Lanka state, this time as a Sinhala chauvinist force opposing the Indian intervention that led to political concessions to the Tamil minority in the 13th Amendment to the Constitution, and the arrival of the Indian Peace Keeping Force in northern Sri Lanka.

SEBI's credibility at stake

Allegations against chairperson Madhabi Puri Buch highlight deep systemic failures

THE integrity of the Securities and Exchange Board of India (SEBI), which regulates the fifth largest capital market in the world, is under intense scrutiny. Revelations involving SEBI chairperson Madhabi Puri Buch are spilling out on a daily basis, raising significant concerns about conflict of interest and inadequate disclosures at the top of this critical institution. In fact, held to the standards of its own orders regarding disclosures by key management persons (KMP) of listed companies and insider trading, it is clear that the chairperson's transparency is woefully inadequate. So

far, three sets of entities are making these allegations: Hindenburg Research was the first to put out 'whistleblower' documents, alleging conflict of interest; the Congress party has held a series of press conferences, making a series of charges and demanding an independent inquiry; and Subhash Chandra Goel, founder of the Zee group and himself under SEBI's lens, has levied charges of corruption against Buch.

A few things stand out and beg clear answers. They are based on the very standards that SEBI has applied to market participants, financial intermediaries, market infrastructure institutions and listed companies while filing prosecution cases against them or levying serious penalties on them. The first thing is by Hindenburg Research about Buch's failure to recuse herself from the Adani investigation although she and her husband had offshore derivative investments in the same set of

nested entities that were under a high-profile investigation of the Adani group, monitored by the Supreme Court. Hindenburg's second allegation is that she continues to hold a 99% stake in a private advisory entity — which is admittedly being used by her husband since his retirement — and has received income from 'well-known' Indian entities. The Congress first said that during her current employment as a regulator, she earned five times as much as (Rs16.80 crore) she did in ICICI Bank. It turns out that Buch was exercising shares granted to her under the Employee Stock Options Plan (ESOPs). Given that SEBI has handled several regulatory issues pertaining to ICICI Bank, the fact that Buch exercised ESOPs almost every year and benefited from the price rise raises disclosure issues and questions about whether she had access to unpublished pricesensitive information when she exercised her ESOPs. The Congress has also released documents about the renting of her personal property to the associate of a investigation. A separate issue has simultaneously blown up. It pertains to SEBI employees' discontent over the unprofessional work culture, unreasonable productive expectations and issues relating to perks, housing allowances and compensation. Like the Hindenburg allegations, this was badly handled, leading to a public protest by a few hundred employees, asking the management to withdraw the inaccurate press release which claimed that employees were influenced by



'misguided external elements.' The SEBI employees claimed that the management was 'spreading lies about employees.

This backdrop sets the stage for a deep dive into how these charges — the lack of adequate disclosures, appropriate recusal and the failure to sufficiently severe her financial ties upon transition to SEBI's leadership — impact SEBI's credibility in regulating the capital market and expose the absence of a robust framework to deal with conflict.In contrast, developed countries which have a revolving door between public and private sectors provide a sharp counterpoint. In the US, regulatory chiefs are required to divest themselves of holdings that could present potential conflicts or place such assets in a blind trust. Such stringent measures ensure that the individuals in public positions as heads of regulatory bodies are free from influences that could compromise their roles. This principle is underscored by the famous Pinochet case, which held that judges should not only


avoid actual impropriety but also the appearance of it. listed entity which has been under SEBI's SEBI demands high standards of transparency from those it regulates. The same strictures don't seem to apply to its own leadership, a hypocrisy not lost on market observers. Even more surprising is the National Democratic Alliance (NDA) government's decision to pretend that it has seen and heard nothing. The government, including the Finance Minister, has buried its heads in the sand. In the process, the powerful SEBI board has been rendered meaningless. Apart from the chairperson and three whole-time members, the board

> includes the Secretary, Department of Economic Affairs, the Secretary, Ministry of Economic Affairs, a Deputy Governor of the Reserve Bank of India and an academic, who is the public representative. There was a time, under the United Progressive Alliance (UPA) government, when a joint secretary in charge of capital markets was a SEBI board member and wielded more power than the chairperson. This time around, the SEBI board is behaving like the proverbial three monkeys who 'see no evil, hear no evil and speak no evil'. To my mind, their role as members of a regulatory body do not give them that choice. Contrast this with what SEBI expects from boards of listed companies. Over the past two decades, SEBI has repeatedly tightened corporate governance requirements and listed rules casting

onerous responsibilities on independent directors in connection with corporate disclosures, price-sensitive information and fiduciary responsibility. Every time these directors fail to question the management, proxy advisory firms are quick to issue sanctimonious missives, highlighting their failure and advising institutional investors on how to respond. The government members on the SEBI board have an even greater responsibility to ensure that they meet a higher standard of transparency and accountability. By refusing to question the SEBI chairperson or conduct an impartial inquiry and take steps to protect SEBI's credibility, the SEBI board has clearly failed. This exposes an important loophole in the regulatory system. It shows that there is nothing that stakeholders can do to hold a regulator accountable if the administrative ministry and the government refuse to initiate corrective action. Most people seem to think litigation would also be futile.

GST collections have risen steadily after the Covid-led dip. There's a perception, and not without reason, that both the Centre and the states are averse to changing the taxation structure when revenues are healthy. The multiplicity of slabs runs contrary to the aim of streamlining the complex taxation system. An organic tax readjustment based on positive or negative end results is essential.

Drone attacks in Manipur must set alarm bells ringing

The Indian establishment has been ambivalent in its approach to the resolution of the crisis in Manipur.

THE September 1 drone bomb attack on Koutruk and Kadangband villages in Manipur's Imphal West district marked an escalation in the violence between the Kukis and Meiteis. Two persons were killed and nine injured in this first such use of drones by insurgents to target civilians. This was followed by more attacks the next day. They destroyed three India Reserve Battalion bunkers at Meikhang village in Imphal East district.

Since the security forces have explicit 'shoot-at-sight' orders against those crossing the buffer zone between the valley and the hill tribes, this new mode of attack could become the preferred tactic by insurgents. These weaponised drones can operate between 500 m and 15 km. Capable of carrying various explosives, including hand grenades and mortar bombs, these can hover and capture images, adding to the threat complexity. Their value lies not just in their destructive ability, but also in documenting the kills.

The recent attacks targeted Meitei-dominated villages. The Kuki-Zo militias are suspected to be behind these attacks. The use of drones to target civilians has been documented since August 2021, when such attacks were witnessed in the neighbouring Myanmar, in areas bordering Mizoram, not far from south Manipur. The drones were being used by the People's Defence Force (PDF) against forces of the Myanmarese junta. The PDF is the armed wing of the Myanmarese National Unity Government, which has been Myanmar's government-in-exile since the military junta-led coup in February 2021. It now controls all areas across the Manipur border, except the two pockets of Moreh and Ukhrul. Some hardware and ammunition/bombs could have been sold by the PDF and other Myanmar rebel groups (some supported by China) to valley-based banned Meitei groups and groups of Chin-Kuki ethnicity that fuel the conflict in Manipur.

The security forces in the beleaguered Manipur are too busy separating the warring factions to guard the Indo-Myanmar border. Armed cadres belonging to the radicalised militia Arambai Tenggol and separatist terror group United National Liberation Front (UNLF) openly roam the streets and flaunt weapons (including those looted from state police armouries in May, last year). This, despite a peace agreement signed between the UNLF and the Centre in the presence of Home Minister Amit Shah in November, last year. Taking advantage of the ambiguity in the peace accord, UNLF cadres have not been restricted to camps and designated areas. Nor have weapons been withdrawn by the state government, which uses these Meitei militias to dominate the Imphal valley with impunity and challenge the remit

of the Army and Assam Rifles (AR) checkpoints. The Army, AR and Central Armed Police Forces, which made tremendous sacrifices in the past while waging a successful battle against separatist elements, have effectively been sidelined by the removal of the Armed Forces (Special Powers) Act from the Meiteidominated Manipur valley. The Army and the AR face a serious challenge in maintaining the fragile internal security situation, controlled by the predominantly Meitei state government. This freedom accorded by the state government to the factions responsible for last year's ethnic violence in Manipur is a serious security concern; the possibility of orchestrated violence or an offensive against the



Kuki-Zo tribals and an escalation in armed response

remains. Two extraordinary threats to India's security have manifested themselves in the past four years. One threat is that of the Chinese incursions in Ladakh, which saw the occupation of Depsang, Chumar and Chang Chenmo by China's People's Liberation Army. Despite several rounds of negotiations and mutual disengagement in the Pangong Tso lake area, the status quo ante has not been restored, as demanded by the Indian Government. While the security forces are being augmented by weapon and equipment procurements (an inordinately long process), a gradual sidelining and deliberate

diversion from the issue of incursions by the government and the media have fostered a sense of acceptance in the minds of the populace. This is an encouragement to China in many ways.

The second threat is the situation in Manipur that had been festering since early 2023 and escalated in May 2023. The ineptitude of the state government and the subsequent induction of 60,000 paramilitary forces and the Army by the Centre has not resulted in the deescalation of violence. Conversely, new dimensions have emerged in the attacks, as the recent drone bombings show. The ongoing disturbances in Manipur have a debilitating effect on security as the open, porous border with Myanmar is ripe for exploitation. The Indian establishment has been ambivalent in its approach to the resolution of the crisis in Manipur. In the initial period, after clashes broke out in May 2023, the Centre had rushed Central

and Army forces into the state. But thanks to a lack of coordination and partisan handling of the state police forces, which are predominantly Meitei, there was no let-up in the ethnic clashes. Then, in last December, the government took its eye off the ball and entered the General Election mode. Consequently, national security was relegated to local political expediency.

The escalation through drone bombings is an act of terror. The new level of the destabilising effects of a prolonged conflict and the exploitation of the situation by China should be of concern to the security establishment. Let us hope that it doesn't come to a point when concerted military action will be the only solution to the crisis.

People with Crohn's disease -a serious bowel condition -- are more likely to experience a recurrence after surgery if they continue to smoke, new research has found.

Crohn's disease occurs when the immune system attacks the lining of the gut and bowel to cause severe inflammation. It results in abdominal pain, urgent diarrhoea, sickness and profound lethargy.

Doctors recommend people with the condition stop smoking to avoid their illness worsening.

"Our study confirms that the most important thing somebody with



Crohn's disease can do for their health is not to smoke," said Jack Satsangi, Professor at University of Edinburgh in

Most patients with Crohn's disease require surgery to remove the affected section of their bowel. Surgery is not curative, however, and the condition often relapses.

The researchers also assessed whether a drug treatment that is commonly used in treating the disease is effective at preventing it from coming back after surgery.

They found that the therapy had limited beneficial effects for non-smokers in preventing relapse after surgery. It did, however, offer protection for smokers.

A class of drugs called thiopurines have often been prescribed to patients after surgery to try to prevent relapse but until now, it was not clear whether the therapy

The rate of relapse in the non-smoking group was much lower and was unaffected by treatment with the medicine, showed the findings published in The Lancet Gastroenterology and Hepatology.

SC to deliver verdict on Sep 13 on Arvind Kejriwal's bail plea in excise policy case

NEW DELHI. The Supreme Court is scheduled to deliver on Friday its verdict on Delhi Chief Minister Arvind Kejriwal's petitions seeking bail and challenging his arrest by the CBI in the excise policy 'scam'.

As per the cause list of September 13 uploaded on the apex court website, a bench headed by Justice Surya Kant is slated to pronounce the verdict. The bench, also comprising Justice Ujjal Bhuyan, had on September 5 reserved its verdict on the pleas.

Kejriwal has filed two separate petitions challenging the denial of bail and against his arrest by the CBI in the corruption case filed by the central agency. The AAP chief was arrested by the Central Bureau of Investigation (CBI) on June 26. He has challenged in the apex court the Delhi High Court's August 5 order which upheld his arrest in the corruption case. The high court had noted that the loop of evidence against Kejriwal got closed after collection of relevant evidence following his arrest by the



CBI and it cannot be said that it was without any justifiable reason or illegal.

The high court had also granted him liberty to approach a trial court with his plea seeking bail in the case. The matter relates to alleged corruption in the formulation and execution of the Delhi government's excise policy for 2021-22, which has now been scrapped. The Enforcement Directorate (ED) has also lodged a separate money laundering case linked to the alleged excise policy 'scam'. According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue

favours extended to licence holders.

On July 12, the apex court had granted interim bail to Kejriwal in the money laundering case.

The top court had referred to a larger bench, preferably of five judges, for in-depth consideration of three questions on the aspect of "need and necessity of arrest" under the Prevention of Money Laundering Act (PMLA). The ED had on March 21 arrested Kejriwal in connection with the money laundering case. During the arguments on September 5 on Kejriwal's plea in the corruption case, the chief minister had vehemently opposed in the apex court the CBI's contentions that he should have approached the trial court first for bail in the corruption case.

Questioning the maintainability of Kejriwal's pleas, Additional Solicitor General S V Raju, appearing for the CBI, had submitted that even in the money laundering case in which he had challenged his arrest by the ED, he was sent back by the apex court to the trial court.

MCD captures stray cattle in Delhi's Keshavpuram zone

NEW DELHI. In an effort to tackle the issue of stray cattle and illegal dairies across the city, the Municipal Corporation of Delhi (MCD) has launched a special drive in the Keshavpuram zone, leading to the impounding of 18 stray cattle on Wednesday.

The operation, carried out by the Veterinary Services Department with the assistance of local police, is part of MCD's larger plan to reduce the problem of stray cattle within its jurisdiction. The MCD has been actively conducting raids and impounding stray cattle in different parts of the city to address the ongoing issue. The corporation's veterinary department is also focusing on taking action against illegal dairies that contribute to the stray cattle problem.

An MCD spokesperson emphasised that the civic body is committed to addressing the menace of stray cattle and illegal dairies in urban zones. "This is just one step in a series of measures. More stringent action will be taken in the coming days," the spokesperson added. According to MCD data, 9,984 head of cattle have been impounded this year between January and July.

FORDA threatens nationwide strike if action taken against West Bengal junior doctors

FORDA president Dr Aviral Mathur said if the Bengal government initiates punitive action against the protesting junior doctors, "we will resume the nationwide strike."

NEW DELHI. Expressing solidarity with the junior doctors in West Bengal, who have defied a Supreme Court directive to return to work amid the state government's claims of a healthcare crisis, resident doctors in the national capital are contemplating a renewed strike.

The Federation of Resident Doctors Association (FORDA) has warned of escalated protests if any coercive action is taken to end their Bengal counterparts' peaceful demonstration.

"The movement for justice for Abhaya continues to be undermined by the very institutions meant to protect the rights and safety of our society," FORDA said in a letter. "We had hoped for a swift and fair resolution to this horrific crime, but instead, the proceedings have taken a disappointing turn. It is not only the court's inaction but also the appalling defense put up by representatives of the West Bengal government, led by Kapil Sibal, that shocked us," the letter further read. "We understand the anger, frustration and the deep sense of betrayal that has driven this protest. We will not allow it to be silenced," the letter said, adding that FORDA shall consider intensifying its protest after discussion with all stakeholder RDAs.

'Address women quota in DUSU polls': Delhi High Court

NEW DELHI. The Delhi High Court on Wednesday directed the Delhi University Vice-Chancellor to swiftly address a representation seeking the introduction of women's reservation in the upcoming Delhi University Students' Union (DUSU) poll.

A bench of Acting Chief Justice Manmohan and Justice Tushar Rao Gedela urged the university to resolve the petition within three weeks. Filed by Shabana Hussain and represented by advocate Ashu Bidhuri, the plea calls for a 50 per cent reservation for women in the DUSU polls, emphasising the lack of female participation due to the influence of money and muscle power in the elections.

It also calls for the Centre, UGC, and the university to reserve 50 per cent of seats for female candidates in both



DUSU and college student union elections. The plea stresses the need for reservation for women to foster gender equality. It notes that a notification for the DUSU polls has

been issued, with nominations starting on September 17, 2024, and the election scheduled for September 27, 2024

Hussain has raised concerns about challenges faced by women despite 75 years of Independence. She underscored that the Constitution guarantees equality and participation for women, and highlighted the importance of political representation for women in a male-dominated society to achieve genuine empowerment.

'Bio-decomposer will be sprayed free of cost to stop stubble burning': Delhi environment minister

Stubble burning, included in this year's 21 focus points, also plays an important role in increasing the problem of pollution in the winter season.

NEW DELHI. Aiming to curb pollution during the upcoming winter months, the Delhi government has decided to spray biodecomposers free of cost to decompose stubble in farmlands.

The government said that by spraying bio-decomposer, farmers will not have to burn stubble, which will prevent air pollution and will also increase fertility of fields. Delhi Development Minister

Gopal Rai, following a high-level meeting with officials and experts, announced that so far 841 farmers have already signed up for the initiative aimed at curbing pollution and promoting sustainable farming practices in both Basmati and non-Basmati paddy fields within the



capital.

Giving more details about the meeting, Rai said, "In order to solve the problem of pollution occurring in the winter season inside Delhi, the Kejriwal government is constantly moving towards making its Winter Action Plan by meeting with different departments." The Delhi Development Minister continued, "All the departments have been assigned d i f f e r e n t responsibilities on 21 focus points regarding the Winter Action Plan, under which the E n v i r o n m e n t Department will prepare a joint action plan for it. Stubble burning, included in this year's 21 focus

points, also plays an important role in increasing the problem of pollution in the winter season."

He said that this year the government will spray bio-decomposer free of cost in more than 5,000 acres of land to decompose the stubble. Right now the farmers are being asked to fill the form.

No ventilator in Delhi govt-run hospital, sixday-old infant dies



NEW DELHI. A six-day-old baby lost her life in the absence of a neonatal ventilator at a Delhi government-run hospital, sources said on Wednesday. She was put on oxygen support, but without access to a neonatal ventilator, her condition deteriorated. Since no neonatal ventilator was available, we put the child on oxygen support and administered antibiotics. Her SPO2 level was maintained with the support of oxygen. But she died," a doctor said. Hospital's Medical Superintendent Digbijoy Dutta said all nearby government hospitals, including Baba Saheb Ambedkar and Lok Nayak Hospital, were contacted but none of them responded positively. He said the hospital had only one ventilator bed, which was occupied by another

Delhi BJP Sikh cell protests Rahul Gandhi's remark in US, seeks apology

NEW DELHI. The Delhi BJP's Sikh cell - Sikh Prakosth
- on Wednesday staged a protest against Congress leader
Rahul Gandhi for his alleged controversial remarks in
the United States concerning Sikhs in India.

The protesters, including women, attempted to march towards Gandhi's residence but were not allowed by the police. As the protesters tried to disobey the police orders, they were subsequently detained but later released after a warning. The protesters demanded an apology from Gandhi, the Leader of Opposition in the lower house of Parliament, for his recent remarks in the US while addressing a gathering of Indian Americans in a Washington DC suburb. "The fight is about whether a Sikh is going to be allowed to wear his turban in India or a kada in India. Or he, as a Sikh, is going to be able to go to Gurdwara. That's what the fight is about. And not just



for him, for all religions," Gandhi had said.

BJP's Sikh Cell convener Sardar Charanjeet Singh Lovely condemned this statement and remarked that

Congress has historically been the party that caused the most harm to Sikhs. "The Sikh community and the nation can never forget or forgive these atrocities be it Operation Blue Star, Rahul Gandhi must apologise to the Sikhs across the country and retract his statement," Lovely said.

The Delhi BJP accused Rahul of being the first leader of the opposition who makes controversial statements on India's internal matters in front of the foreign media.

Party's national spokesperson RP Singh stated that Gandhi should refrain from making such statements, especially about the Sikh community. Meanwhile, Delhi BJP president Virendra Sachdeva also slammed Gandhi for his comments on caste-based reservation. Gandhi during his address had said that his party will "think of ending reservation when India is a fair place".

Gurgram battles civic woes as municipal polls pending for two years

NEW DELHI. Every year, the onset of monsoon brings about a familiar site for the residents of Gurgram - heavily waterlogged streets that make daily commute nearly impossible.

Residents often take to social media to ridicule the city's misgovernance with many sarcastically praising authorities for turning their flats into "sea-facing" luxury apartments.

Flooding, however, is not the only issue plaguing the 'Millenium City'. Residents frequently complain of overflowing sewers, water scarcity, damaged roads and irregular garbage collection. Some of the city's Residents Welfare Associations (RWAs) even went so far as to boycott the recently-held Lok Sabha polls until conditions improved.

"The situation has gotten consistently worse in the last 2-3 years," said Raj Kumar Yadav, president of Sector 46 RWA. According to Yadav, garbage collection is one of the worst-hit services with private contractors selling off their tenders from one to another with no accountability to residents. "Garbage collection is usually delayed by several days and despite fixed rates for garbage collection, based on plot size, contractors also grossly overcharge us. These contractors are no better than goons and threaten us if we complain to the



Municipal Corporation," he said. The situation in private societies under the management of the Municipal Corporation of Gurgaon (MCG) is no better. Mayfield Garden, a private colony spread over 327 acres was recently taken over by the MCG. Residents had been pooling their funds together and managing the locality on their own ever since the group of builders that developed the area stopped its maintenance in 2012.

We have made several representations to MCG officials but nothing has been done to improve our situation. A single hour of rain can easily flood our entire locality," said RK Sharma, president of Mayfield Garden-BRWA.

Notably, elections to the MCG House were last held in 2017, with the term of the councillors and the mayor ending in 2022. Fresh elections were supposed to be held within six months but were delayed as the delimitation exercise could not be completed. Elections can be held only after the delimitation is carried out and approved by the state government, said officials. In the absence of elected officials, residents' pleas often go unheard in the MCG.

According to Kuldeep Singh Bohra, who served as a councillor from 2017 to 2022, elected representatives play a crucial role in bringing residents' concerns to the attention of civic officials.



They can log in to either the BSE website or the website of Kfin Technologies Limited, the registrar for the issue.The latest Grey Market Premium (GMP) for Bajaj Housing Finance's IPO stands at Rs 74, as of 08:27 AM on September 12, 2024. Given the price band of Rs 70, the projected listing price for the IPO is Rs 144 (which is the cap price plus the current GMP). This suggests an anticipated gain of 105.71% per share.

The price band for Bajaj Housing Finance's IPO was set at Rs 66-70 per share. Investors could apply for a minimum of 214 equity shares, with applications accepted in multiples thereafter.

SpiceJet: HC orders to ground three engines

NEW DELHI. The Delhi High Court on Wednesday upheld a ruling mandating budget airline SpiceJet to ground three of its aircraft engines due to overdue payments to French lessors. A Division Bench, consisting of justices Rajiv Shakdher and Amit Bansal, decided not to overturn the previous single-judge order issued on August 14 regarding nonpayment of dues for engines leased from two French companies. The airline had contested this order, but the Division Bench's ruling reinforces the enforcement of the initial directive. While pronouncing the judgement, the bench noted that "...The record reveals SpiceJet is in default, and past and current outstanding dues remain unpaid. At the risk of repetition, it must be stressed that SpiceJet has violated an agreed interim arrangement for payment of dues, which included a term that, upon breach, it would ground the engines that Team France and Sunbird France could then repossess". This ruling delivers a significant blow to SpiceJet, which has been grappling with financial challenges, including legal bttles over aircraft leases.

'....the fact that the financial condition of SpiceJet is weak is evident from its conduct and the stand taken on its behalf in court, which is that it is attempting to infuse funds through loans and/or equity. If the position in which SpiceJet is at this juncture, Team France and Sunbird France could well end up both without its engines or the monies due under the engine lease agreements." Restructuring: Samsung to cut 200 jobs in India

NEW DELHI. Technology giant Samsung is planning to lay off nearly 200 employees in India as part of its cost-cutting measures, as per company sources.

The move is part of Samsung's global restructuring plan, which aims to cut up to 30% of its global workforce across various divisions. As per reports, the job cuts will primarily impact sales, marketing, and administrative staff in regions such as the Americas, Europe, Asia, and Africa. It has halted new hiring and is not filling roles left vacant by voluntary exits. Reports indicate its management recently summoned Indian team to South Korea to discuss ongoing issues and restructuring efforts.

In India, Samsung fell to third place in volume in the April-June quarter of 2024, as per IDC. Its smartphone shipments fell by 15.4%, marking its third consecutive quarterly decline, with its market share dropping to 12.9%. It is facing competition from rivals like Apple in the smartphone market and SK Hynix in the high-end memory chip sector.

In China, the company plans to cut 30% of its sales staff. It employed 267,800 people as of the end of 2023, with over half, or 147,000 employees, based overseas, according to its latest sustainability report.

UP to clear investment of Rs 10L cr soon'

NEW DELHI. The Uttar Pradesh government will soon organise the groundbreaking ceremony of investment proposals worth Rs 10 lakh crore, Chief Minister Yogi Adityanath said on Wednesday.

Inviting semiconductor industry to invest in the state, he highlighted that Uttar Pradesh offers incentives such as land subsidies and capital subsidies of 25% for chip units under a policy. Together with the Centre's incentives of 50%, chip units can get subsidies of up to



75% for investment proposals, the chief minister stated. Addressing the international conference on semiconductors, Semicon India, Adityanath said the state has attracted huge investment proposals from the industry. He recalled that a team which was preparing for an investor summit in the state earlier told him investment proposals of Rs 20,000 crore would come in UP. "Same Uttar Pradesh after 7 years has brought investment proposals of Rs 40 lakh crore.

Out of which, Rs 10 lakh crore was done in February. Rs 10 lakh crore investments are in pipeline, for which we will soon do a groundbreaking in the state," he said.

New Delhi, The Union Cabinet has approved a major expansion of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) to cover How does the scheme work? all senior citizens aged 70 years and above. This change allows anyone in this age group to be eligible for health insurance, regardless of their income level. After the Cabinet meeting, Union Minister Ashwini Vaishnaw said, "Prime Minister Narendra Modi had made a commitment that all senior citizens above the age of 70 years will be given coverage under Ayushman Bharat PM Jan Arogya Yojana. There are many families which are already covered and have senior citizens. In such families, additional coverage, topup coverage will be Rs 5 lakh."This expansion aims to address the healthcare needs of the elderly, who often face higher medical expenses as they age. By lifting income restrictions, the government is ensuring that more senior citizens can benefit from much-

help ease the financial burden of healthcare.

The AB PM-JAY now covers an additional 6 crore individuals from 4.5 crore families, focusing on seniors aged 70 and above. Each senior citizen will be given a health card, allowing them easy access to healthcare services under the scheme. The scheme provides Rs 5 lakh coverage annually per family. If there are multiple senior citizens in the same family, this coverage is shared among them. The scheme is particularly beneficial for nuclear families, where the financial burden on elderly members can be more difficult to manage. Eligibility - All senior citizens aged 70 and above are eligible for Rs 5 lakh health coverage, regardless of income or social status.

Top-up coverage - For families already enrolled in Ayushman Bharat, senior members will receive an extra Rs 5 lakh top-up, which is solely for their use.

needed health coverage, which will Private insurance - Senior citizens with private health insurance can still take advantage of the scheme without any conflict with their existing coverage.

Public health schemes - Seniors who are part of other public health schemes like the Central Government Health Scheme (CGHS), Ex-Servicemen Contributory Health Scheme (ECHS), or Ayushman Central Armed Police Force (CAPF) will need to choose between their current insurance and the new Ayushman Bharat health coverage.New health cards - All eligible senior citizens will receive a separate health card, which will help them access the scheme's benefits more efficiently.

Who pays for the coverage?

The cost of this expanded coverage will be Rs 3,437 crore initially. State governments will bear 40% of the expenses, while the Centre will cover the remaining 60%. For states in hilly and northeastern regions, the Centre will fund 90% of the costs.

Zomato shares jump 4% to hit alltime high. Will it gain further

New Delhi, Zomato shares climbed 4% in early trading on Thursday, reaching an all-time high of Rs 283.50. At around 11:14 am, shares of the food delivery giant were trading 3.79% higher at Rs 282 apiece on the Bombay Stock Exchange (BSE). The rise comes after global brokerage firm UBS reaffirmed its bullish stance on the stock, maintaining a 'buy' rating and setting a target price of Rs 320.UBS cited strong growth prospects as the key driver behind its optimism.In a recent note, UBS highlighted that industry volumes grew by 2.5% month-on-month in August 2024, with adjustments made for the number of days.

The firm also pointed to the ongoing competitive dynamics between Zomato and Swiggy, describing the situation as a "push-and-pull" battle that has extended into Q2FY25.

Will it gain further?

UBS estimates that Zomato's Gross Merchandise Value (GMV) could see a 7% quarter-on-quarter rise for Q2FY25. The stock has been on a six-day winning streak, gaining 15.6% during this period. The rally gained momentum after Zomato closed its acquisition of Paytm's events and movie ticketing business. Following the deal, analysts from major global brokerage firms like Jefferies and JP Morgan have also turned bullish on Zomato's prospects. Earlier this month, JP Morgan revised its target price for Zomato to Rs 240, up from Rs 208, while maintaining an overweight rating. The brokerage believes Zomato is at the forefront of a retail transformation through its focus on convenience and selection in the quick commerce segment. The firm noted Zomato's successful expansion across metro cities, particularly in NCR, and raised its FY25-27 forecasts by 15-41%. Furthermore, Zomato's integration of its dining services with the newly acquired ticketing business has bolstered its growth outlook. Jefferies, another major brokerage, set a base target of Rs 335 for Zomato, reflecting a potential 31% upside.Jefferies is optimistic about Zomato's recent moves in the food delivery space, predicting a 20% compound annual growth rate (CAGR) in delivery revenue between FY24 and FY27.As per the agreement with Paytm, Zomato acquired the entire stake held by OCL in Orbgen Technologies Private Limited (OTPL) and Wasteland Entertainment Private Limited (WEPL). Both entities have now become fully owned subsidiaries of Zomato.In its latest financial results, Zomato reported a sharp increase in consolidated net profit, posting Rs 253 crore for the quarter ending June 30, 2024, marking a significant year-on-year jump.

Evs get Rs 11k crore boost from government

NEW DELHI: The Union Cabinet, chaired by Prime Minister Narendra Modi, has approved the proposal of the Ministry of Heavy Industries (MHI) for the implementation of 'PM Electric Drive Revolution in Innovative Vehicle Enhancement (PM E-DRIVE) Scheme' to promote electric mobility in the country.

The PM E-DRIVE has replaced the FAME scheme and the temporary Electric Mobility Promotion Scheme (EMPS) 2024. The new scheme has an outlay of Rs 10,900 crore over a period of two years. Subsidies/demand incentives worth Rs 3,679 crore have been provided to incentivise electric two-wheelers, electric three-wheelers, eambulances, e-trucks and other emerging EVs. The scheme will support 24.79 lakh e-2Ws, 3.16 lakh e-3Ws, and 14,028 e-buses. There isn't much for electric car buyers.

The scheme allocates Rs 500 crore for the deployment of e-ambulances. A sum of Rs 4,391 crore has been provided for procurement of 14,028 e-buses by STUs/public transport agencies. The demand aggregation will be done by CESL in the nine



cities with more than 40 lakh population namely Delhi, Mumbai, Kolkata, Chennai, Ahmedabad, Surat, Bangalore, Pune and Hyderabad. Intercity and Interstate ebuses will also be supported in consultation with states. The scheme will promote the deployment of etrucks in the country. Rs.500 crore has been allocated for incentivising etrucks. The government said the scheme addresses range anxiety of

EV buyers by promoting the installation of electric vehicle public charging stations (EVPCS). "These EVPCS shall be installed in the selected cities with high EV

penetration and on selected

highways. The scheme proposes installation of 22,100 fast chargers for e-4 Ws, 1,800 fast chargers for e-buses and 48,400 fast chargers for e-2W/3Ws. The outlay for EV PCS will be Rs 2,000 crore," said a statement issued by the Cabinet.Further, the government has approved an outlay of Rs 780 crore to modernise the test agencie.

The Ministry of Heavy Industries (MHI) is introducing e-vouchers for EV buyers to avail demand incentives under the scheme.At the time of purchase of EV, the scheme portal will generate an Aadhaar authenticated e-Voucher for the buyer. A link to download the evoucher will be sent to the registered mobile number of the buyer.

Crude oil prices decline below \$70; petrol, diesel unlikely to get cheaper

Brent Crude Future prices dropped below \$70 a barrel on Tuesday, triggered by OPEC+'s downward revision of its demand forecast.

NEW DELHI.Even as crude oil prices declined below \$70 a barrel for the first time since December 2021, analysts believe that petrol and diesel prices in India are unlikely to come down anytime soon. They indicated that oil marketing companies (OMCs) would prefer to see a sustained trend of lower crude prices for a longer period before making any decisions on domestic fuel prices.

'Oil marketing companies would possibly like to see sustenance of the trend of lower crude prices for longer before they take a call on prices," said Prashant Vasisht, VP & co-head, corporate ratings, ICRA.Brent Crude Future prices dropped below \$70 a barrel on Tuesday, triggered by OPEC+'s downward revision of its demand forecast. Though the prices rebounded early on Wednesday, they fell below the \$70 mark. Brent crude futures was trading at \$69.68 a barrel and US West Texas

Intermediate (WTI) crude at \$66.37 at 7.56 PM IST.

"Crude oil prices have been depressed owing to repeated instances of increasingly weak demand from China even as US production is high at over 13 million barrels a day. Additionally, OPEC+ has extended oil production cut by two months leading to fears that there is disagreement on further production cuts leading to a bearish scenario. It is unclear whether this is a short term phenomenon as OPEC+ may after all increase cuts which could lead to increase in prices," said Vasisht.Indian oil Marketing companies have made revision of the prices of petrol and diesel across the country in March 2024 by Rs 2 per litre. Now, the elections approaching in Haryana and Jammu & Kashmir, there is speculation that oil marketing companies might consider reducing fuel prices. Moreover, Indian oil marketing companies, including Indian Oil Corporation Ltd (IOCL), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL), have reported significant profits in recent quarters, with a combined consolidated net profit of Rs 7,371 crore in the first quarter of this fiscal.

Vinicus apologises to fans for Brazil defeat, addresses Real Madrid comparisons

New Delhi. Brazilian winger Vinicius Junior issued an apology to fans following Brazil's 0-1 defeat to Paraguay in the FIFA World Cup Qualifiers on September 11. This loss continued Brazil's troubling run, leaving them in a precarious position in the CONMEBOL standings. In his statement, Vinicius expressed regret for the team's poor form and assured fans of his commitment to improving his own performance. Vinicius acknowledged the difficult situation Brazil is in, as the fivetime World Cup winners now sit fifth in the standings with just 10 points from eight games. This places them behind Argentina, Colombia, Uruguay, and Ecuador, and only narrowly ahead of Venezuela on goal difference. With only



the top six teams qualifying for the World Cup, Brazil's current position is alarming. 'We apologise to the fans, who are always on our side...But this is a difficult time, we just want to improve... I know my potential, I know what I can do for the national team. Of course it's been a very difficult process, because when you don't have confidence, you don't get goals, you don't get assists and good performances," Vinicius told Sportv"We know the situation we're in, we want to get Brazil out of this situation at any cost, we all have to go home now and start thinking about what we can do to get back to playing well. We cannot come here, lose these points and play the way we did," Vinicius added. Vinicius also addressed criticism regarding his performances, noting that while he has excelled at Real Madrid, he has struggled to replicate that success with the national team. He promised to work harder to meet expectations.

'It's completely different [tharazil's next World Cup Qualifiers will be crucial, with matches against Chile on October 11 and Peru to follow. These games will be vital for Brazil's hopes of securing a spot in the tournament, and for Vinicius, who will be under pressure to lead his team to victory and turn their fortunes around.

Is Carlos Alcaraz's secondhalf slump in 2024 a cause for concern

New Delhi Carlos Alcaraz and Jannik Sinner have solidified their status as the leaders of the next generation in men's singles tennis. sharing all four Grand Slam titles between them in 2024. Alcaraz claimed victories at the French Open and Wimbledon, while Sinner completed the hard-court double,



winning both the Australian Open and the US Open, heading towards finishing the year as the World No. 1.While Sinner's performance only grew stronger, culminating in his US Open triumph after successfully distancing himself from the noise surrounding his doping case, Alcaraz experienced a late-season slump. Though not alarming, questions have surfaced about the Spaniard's ability to win on his bad days — a trait that often distinguishes legends from the rest.In 2023, Roger Federer expressed concerns about placing immense pressure on young tennis stars, cautioning that unrealistic expectations could hinder their development. It seems the very scenario Federer warned about may now be unfolding."I always don't like to put too much pressure on younger players, especially like, 'He's going to do this.' But he's (Alcaraz) the type of player who says, 'Well, I'm coming to Wimbledon, I'm coming to win. I'm coming to Paris, I'm coming to win.' So he's putting that pressure on his own, which is great," Federer told CNN Sports in 2023.Despite Alcaraz's impressive achievements in 2024, some fans have been quick to speculate whether the mounting pressure is beginning to affect the four-time Grand Slam champion. Since his Wimbledon triumph in July, Alcaraz has suffered three concerning defeats — in the final of the Paris Olympics to Novak Djokovic, a second-round loss to Gaël Monfils at the Cincinnati Masters, and a shocking second-round exit to World No. 68 Botic van de Zandschulp at the US Open. These defeats have led to concerns that Alcaraz might be a victim of his own success. Some argue that the high standards Alcaraz has set are starting to impact his mental game, potentially causing him to lose his usual flair during crucial moments.

exactly the right way to go about it yet. I mean, he only goes one way, but when he's thinking about hitting the ball to different parts of the ground is when you see the best Jake Fraser-McGurk quite often," Ponting said."He'll get sort of stuck in trying to hit him one which is normally down over long

scoring 360 degrees around the ground, he's as clean a striker as I think I've ever seen. He's probably 5 ft 10, he's not a big kid, but he hits the ball extremely hard and he's got no fear, and he's a gun in the field. He's someone that I think that in the future can be a three-format player for Australia," Ponting added.Ponting's remarks come at a time when Australian cricket is transitioning after the retirement of veteran opener David Warner. Recalling Bangladesh's Test debut vs India: Dhaka witnesses history in 2000

New Delhi The 1999 ODI World Cup holds special memories for Bangladesh. It started with Aminul Islam Bulbul's men taking down a red-hot Pakistan at the County Ground in Northampton. With the likes of Saeed Anwar, Inzamam-ul-Haq and Wasim Akram in their ranks, beating Pakistan wasn't a walk in the park back then, but the Tigers did the unthinkable and neutralized their opponents.On the back of their impressive showing, Bangladesh got Test status in June 2000. Later that year, they made history after playing their maiden Test match against India, captained by Sourav Ganguly. Naimur Rahman Durjoy had the honour of captaining Bangladesh in front of a packed house at the Bangabandhu National Stadium in Dhaka.India went into the game as the favourites and they won by

nine wickets, a result which wasn't any different from expectations. But it was Aminul Islam, who etched his name in the history of Bangladesh cricket by becoming their first centurion. He scored 145 runs off 380 balls with 17 fours and helped his team post an impressive 400 in their very first Test innings.Skipper Naimur also made history, becoming the first Bangladeshi with a fivewicket haul in Test cricket. With figures of 44.3-9-132-6, Durjoy allowed India to take a lead of only 29 runs. The match was well and truly in the balance until the opening session of the fourth day. But then, gap of experience between the two teams showed. India bowled their opponents out for 91 in 46.3 overs and set themselves a target of 63. Rahul Dravid's brisk 49-ball knock of 41

made sure that India romped past the finish

line in 15 overs. Sunil Joshi walked away with the Player of the Match award after he took five wickets in the first innings followed by a three-wicket haul.

Bangladesh yet to open their account

Since 2000, India and Bangladesh have faced each other 13 times in Test cricket. While India have won 11 times, the Tigers are yet to get on the board. Habibul Bashar and Mushfiqur Rahim are the Bangladeshi skippers to have led their team to draws in 2007 and 2015 respectively. Back in December 2022, Bangladesh got close to beating India for the first time in Test cricket. They gave themselves a more than realistic chance of pulling off a massive heist at the Sher-e-Bangla National Stadium in Mirpur.Defending 145 in the fourth


