Lucknow, Sep 14: Nand Kishor Gurjar, who holds the Loni assembly seat of Ghaziabad, also condemned this act of 'jihad against Sanatan Dharma.' BJP leader Nand Kishor Gurjar on Saturday demanded a case under the stringent National Security Act (NSA) against a vendor who was allegedly selling fruit juices mixed with urine in Uttar Pradesh's Ghaziabad. "People should not buy edible items from vendors with such a 'sick mentality.' Those who can mix urine in juice, can also mix poison," Gurjar said in a video message, according to. In his video message, he also described the alleged act of mixing juice and urine, as a 'jihad by Muslims against the Sanatan Dharma to corrupt the Hindu religion.' Aamir, the 29-yearold vendor, and a boy (15) working at his shop, were arrested for allegedly selling the 'contaminated' fruit juice. During his questioning, Aamir told police that as there was no place near his stall to urinate, he was collecting the urine in a plastic bottle. "He was interrogated about the bottle found at his stall. He could not give a 'satisfactory reply' Therefore, we outrightly rejected his response," Assistant Commissioner of Police (ACP), Ankur Verma, told the media.

"This time, the (assembly) election will decide the future of Jammu and Kashmir, which has remained the target of foreign powers since Independence," he told the gathering. "Not only this, dynasdren. 

Himachal Pradesh first state to introduce provision for property seizure in illegal liquor trade

Shimla, Sep 14: Himachal Pradesh has become the first state in India to introduce a provision for property seizure in cases involving illegal and spurious liquor, Chief Minister Sukhvinder Singh Sukhu announced today. The state government has taken stringent measures to combat the illicit liquor trade, including recent amendments to the Himachal Pradesh Excise Act, 2011, passed during the state assembly's monsoon session. "The most significant amendment is the introduction of a provision allowing for the



seizure of properties belonging to individuals involved in illegal activities, as well as their relatives and associates, which was previously absent from the Act," Sukhu explained. He emphasised that Himachal Pradesh is the first state to implement this provision, making these offenses cognisable and non-bailable to enhance effective ness. The amendments also include increased penalties and longer punishment durations under various sections of the Act. Sukhu stated that sell ing liquor to minors or using them as sales personnel is a serious crime, punishable by six months' imprisonment or a fine of up to Rs 50,000. To ensure effective implementation, enforcement agencies are being empowered, and the establishment of an Excise Police force has been proposed to expedite excise case handling and discourage illegal activities. Recalling the 2022 hooch tragedy in Mandi district, which claimed eight lives due to spurious liquor consumption, the CM assured that stringent provisions are being implemented to prevent such incidents. The state government is taking decisive steps to combat drug abuse, with the recruitment of over 1,200 constables underway, focusing on tackling these issues

Time has come for India to take lead in fostering culture of international arbitration: CJI Chandrachud

New Delhi, Sep 14: Time has come for the country to take the lead in fostering a culture of international arbitration, providing a level playing field for dispute resolution beyond domestic courts, CJI DY Chandrachud has said. "The rule of

law shares a symbiotic relationship with the creation of an environment which fosters economic stability and growth. Rule of law principles are, in other words, the virtual semi-conductors of our digital era," the CJI said at a conference on international arbitration and rule of law here last evening. Noting that the International Monetary Fund (IMF) has predicted a 7% growth in GDP for India for 2024-25, making the country rank at the virtual top of the ladder, and the World

Bank has followed the suit, the CJI said, "The time has come for India to take the lead in fostering a culture of international arbitration, providing a level playing field for dispute resolution beyond domestic courts." He also referred to figures about gross foreign direct investment inflows in India as well as the overseas direct investment. The CJI said respect for the rule of law promotes fairness, stability and predictability which in turn creates a conducive envi-

ronment for economic growth as investors

thrive in a system where rights are protected, contracts are enforced and disputes are resolved efficiently. A strong rule of law

ment, promotes trade and enhances a nation's global competitiveness, ultimately driving sustainable economic development and improving living standards, Justice Chandrachud said. "The arbitration community across the world often emphasises the importance of commercial efficiency and

ease of business, but these values are inextricably linked to a deep respect for the rule of law. Put simply, the rule of law heralds better economic and commercial outcomes," he said. By establishing robust institutional frameworks, India can champion the growth of arbitration in the global South, promoting a fair, efficient and reliable means of resolving commercial disputes, he said. The CJI said Parliament has initiated efforts to revamp the Arbitration and Conciliation Act of 1996. "To this end, the Ministry of Law and Justice has established a committee to review the effectiveness of the Act and suggest amendments. The committee has submitted its report, which is now being acted upon by the ministry, paving the way for potential reform," he said

Ramesh, and NCP-SCP chief Sharad Pawar paid homage to Yechury, who passed away on September 12 at AIIMS. Politburo members Prakash Karat, Brinda

Karat, Pinaravi Viiavan and MA Baby also paid tributes. DMK MP Kanimozhi said, "I am here on behalf of my party and also on a personal level to pay my respects to a



very important and great leader of this country. He was a thinker, a writer and a philosopher." "Only when I saw him in a box could I believe that someone so full of life, wit, and love could just go, leaving us

in shock and disbelief. Highness, I wish it was not you in that box. I just can't accept it," she said. Recounting his meeting with Yechury, RJD MP Manoj K Jha said, "He

was always full of ideas on what to do next. It is difficult to fill the void left by him. Without the mention of his name, no discussion in Indian politics will be completed. I was constantly in touch with him and always found him to be full of energy." Rajya Sabha MP Kapil Sibal said, Many politicians live for themselves and power, but people like Yechury dedicated their lives to others. He was a dear friend." On Friday, Yechury's body was taken to Iawaharlal Nehru University from AIIMS, where students and faculty

members paid their last respects. A bus draped in flowers, with a portrait of Yechury, has been prepared to carry his mortal remains back to AIIMS, where his body will be donated for research.

Lawyer Harish Salve's big claim on Paris Olympics: 'Wrestler Vinesh Phogat

New Delhi, Sep 14 Top lawyer Harish Salve has claimed that Vinesh Phogat did not want to challenge the decision of the Court of Arbitration for Sport (CAS) which disqualified her from the women's 50kg freestyle final at the Paris Olympics 2024 on August 7. Harish Salve's statement is in contrast to allegations by Vinesh Phogat, who stated that she had no support from the Indian Olympic Association (IOA), and that her lawyers had been lenient on the judgment that disqualified her, due to which she couldn't get a medal. Harish Salve had represented Vinesh Phogat in the international court



on behalf of the Indian Olympic Association (IOA) in her plea to get a jointsilver medal. However, they lost the plea and Vinesh Phogat had to return without a medal. In an interview, Harish Salve told TimesNow that Vinesh Phogat had not wanted to challenged the decision taken by the Court of Arbitration for Sport (CAS) even though he had offered. "Later on, we got everything and we fought hard. In fact, I even offered the lady that maybe we can challenge it in the Swiss court of appeal against the arbitration award but I was told by the lawyers that my impression is she didn't want to carry this any further," the lawyer said. "That's because the very good law firm which had been engaged by the Indian Olympic Association was told by some lawyers who the athlete had engaged that 'we will not share anything with you, we will not give anything to you," he added. Vinsh Phogat was disqualified from the final of the women's freestyle wrestling during the Paris Olympics, 2024 for being 100 grams overweight in the 50 kg category. Vinesh Phogat declared her retirement from the sport after the event. Recently, she joined the Congress party, which fielded her from the Julana seat in the upcoming Haryana assembly election.

Kolkata, Sep 14: Amid the continuing impasse, West Bengal Chief Minister Mamata Banerjee on Saturday made a surprise visit to the site where the junior doctors were protesting, and assured them that she would look into their demands and take action if anyone was found guilty. Addressing the protesting doctors amid chants of "we want justice" outside the Swasthya Bhawan in Salt Lake, Banerjee said she had been spending sleepless nights because the medics were agitating on the road amid rains and described her visit as the "last attempt" to resolve the crisis. Banerjee assured the protesting doctors that she would not take any action against them as she did not believe in suppressing a democratic movement as "Bengal is not Uttar Pradesh". However, after she left the site, the agitating doctors said they were not ready to compromise on their demands till discussions were held, indicating no immediate breakthrough in the impasse. "I will not take any action against you. This is not UP. They had implemented ESMA and stopped all sorts of strikes and rallies. But be rest

know that you do noble work. The seniors (doctors) need you. Think about my proposal. If I can come to this protest site to stand by you, I can also ensure justice and listen to your demands," she said. "I respect democratic movements. I am also a product of student movements and have been on hunger strike for 26 days during the Singur anti-land acquisition movement," she said. Banerjee also announced that patient welfare committees of all state-run hospitals would be dissolved with immediate effect. "The patient welfare committees of all hospitals will be dissolved and new ones

Banerjee had then said she was "ready to relinquish her chair for the sake of the people". The junior doctors have

been protesting for over a month, affecting the public healthcare infrastructure of the state. The government claimed that 29 people have died due to the protests allegedly after not receiving treatment.



Telangana announces transgender traffic troops under new recruitment programme

Hyderabad. The Telangana government has announced India's first-ever transgenderspecific government recruitment and social welfare program, under which transgender persons will be trained and recruited for traffic management. As per the program, announced by Chief Minister A Revanth Reddy, once transgender individuals are identified and recruited, they will undergo specialised training to assist the Hyderabad traffic police. The introduction of transgender traffic support troops aims to ensure smoother road management while empowering an underrepresented community with stable government employment, according to state government officials. The government is also working on creating distinct uniforms for transgender recruits, with separate designs for "He/She" and "Him/Her" individuals.

In addition, the terms of employment, including salaries and benefits, are being finalised to ensure equality and respect for the recruits, officials added. After training, the transgender troops will be deployed in Hyderabad.According to the government, this move is not only unprecedented in India but is also a global first, aiming to address two key societal issues--employment for the marginalised transgender community and the city's traffic management challenges.

Panel on Dharani submits report to govt, recommends new revenue system

HYDERABAD: Resurvey of lands, implementation of Land Titling Act, a new revenue act, issuance of loan eligibility cards to tenant farmers, finding an amicable solution for lands placed under Part B of revenue records and Sada Bainama, and establishing a separate academy to train land administration officers are some of the recommendations made by the state government-appointed committee on Dharani. The committee, which was constituted to study the implementation of land transactions, has submitted a comprehensive report to the state government. The committee, which comprises senior Congress leader M Kodanda Reddy as its chairman and retired IAS officer Raymond Peter, land laws expert M Sunil Kumar and retired special grade deputy collector B Madhusudan as members, also recommended a new integrated land revenue management system, Bhumata.

According to sources, the Dharani committee's recommendations include creation of a window for online as well as offline applications, and linking land transactions to Aadhaar-based authentication, grievance redressal mechanism at village level, reviving community paralegal programme and setting up help desks at mandal-level revenue offices. The state government has already placed the Telangana Record of Rights Bill (Draft), 2024, in the public domain. Now, it is a matter of time before the state government makes the proposed draft Bill into a legislation.

One boat removed from barrage gate

VIJAYAWADA: Irrigation department officials and workers engaged in removing the three iron boats stuck at the 69th gate of the Prakasam Barrage experienced a breakthrough on Friday evening. The team led by Dharmadi Satyam managed to cut one of the boats and drag it away from the barrage. However, the boat has not yet reached the shore, and workers are using a traditional rope-and-pull method to bring it closer to

Durga Ghat. The 12-member team from Kakinada arrived in Vijayawada on Friday morning and inspected the boats trapped near the barrage's gate no. 69. They dived into the water, secured strong iron and steel wires to the boat, and used a large crane from Durga Ghat to create a gap between the three boats. After multiple attempts, the team finally separated one boat and dragged it some distance away from the

barrage. 'We still need to bring the boat to shore, and there's a risk it could sink. We must act quickly to pull it further," said Abbulu, the temple head. "The remaining two boats will be removed within three days, though it's a challenging task."

Dharmadi Satyam's firm, Balaji Marines, had previously retrieved the capsised Royal Vashishta boat from the Godavari River near Kachchuluru in 2019. Meanwhile, Bekam company officials are also involved in ensuring the structure's safety.

Orissa HC seeks ATR on erring contractors for shoddy road works in Cuttack city

The bench also wanted to know if there was any provision in the agreement to take action against the contractors whose work was found to be substandard and the repaired roads were damaged within the guarantee period.

CUTTACK: Expressing ire over The bench also wanted to know if the dismal condition of roads in Cuttack city, the Orissa High Court has directed the civic authorities to file affidavits stating what action has been taken against the erring contractors for executing substandard works.

With officials of the Cuttack Municipal Corporation (CMC) and other departments concerned present in the court in virtual mode, the bench of Justice SK Sahoo and Justice V Narasingh asked if the work orders to contractors stipulated any guarantee period for the civil work and whether the officials checked the road works as per standard norms.

there was any provision in the agreement to take action against the contractors whose work was found to be substandard and the repaired roads were damaged within the guarantee period. With the officials submitting that there were suitable provisions in that respect, the special bench for PILs on civic problems in Cuttack city directed the superintending engineer of the Roads and Buildings department and the city engineer of CMC to file affidavits on the main roads and arterial roads respectively. The direction was given on Thursday after the bench took note of the report submitted by president of High Court Bar Association (HCBA) Bijay Dash along with photographs on condition of roads in 15 of the 59 wards in the city. The reports were collected by advocates from each of the wards as per direction issued earlier by the court.

Expressing serious concern over the condition of the roads which were getting damaged within a short period after construction or repair, the bench fixed September 26 for further consideration of the matter.

"The authorities concerned shall take immediate steps for repairing

the damaged roads in the aforesaid 15 wards and submit the progress report with the affidavit to be filed. Apart from the road works, the authorities shall also address the problems relating to the other civic amenities particularly street lights,

repairing of potholes, sanitation issues, waste disposal, covering of drains by concrete slabs, sweeping of streets at regular intervals and clearing growth of vegetation which provides an ideal breeding ground for mosquitoes," the bench ordered. The HCBA president was also asked to collect reports on the condition of roads and other civic

amenities by advocates in respect of the rest of the wards within a week and hand over the same to the CMC authorities to take necessary steps for addressing the issues immediately.

Mumbai woman arrested in Telangana for sending people to Cambodia for cybercrimes

Hyderabad. Telangana Police's cybercrime wing has arrested a 30-year-old woman from Mumbai, who is an alleged recruitment agent, in connection with an international job racket case.The woman, Priyanka Shivkumar Siddu, from Mumbai's Chembur, is accused of trafficking job seekers to Cambodia, where they were forced into cybercriminal activities under dire conditions, according to the Telangana Cyber Security Bureau (TGCSB). The officials allege that after previously working at a now-defunct job processing agency, Siddu launched her own unlicensed agency, misleading job seekers with promises of legitimate employment visas. Siddu's scheme involved collaboration with Narayana, another agent who had connections with one Jithender Shah, also known as Amer Khan, director of a Chinese-owned company in Cambodia.

Priyanka visited Cambodia to verify job opportunities and was offered a commission of around Rs 42,000 per candidate she sent. Upon returning to India, she began processing visas for her nephew Akshay Vaidhya and his friend Danish Khan, who were the first victims of her scam, police said.fter arriving in Cambodia, Vaidhya and Khan were subjected to intense travel before being coerced into cybercrime activities.Priyanka's deceptive advertisements attracted more victims, including Vamsi Krishna and Sai Prasad from Hyderabad, who paid Rs 30,000 each for their visas. These individuals faced severe abuse and psychological torture after refusing to comply with the cybercrime demands. The Telangana Cyber Crime Police have charged Siddu under multiple sections, including human trafficking and cybercrime laws. The investigation continues as authorities work to uncover the full extent of her criminal network and the suffering of her victims.

Cotton, meat waste dumped in irrigation canals; TN farmers enraged



TIRUPPUR: Farmers in Vellakovil complain that unidentified people have been dumping cotton waste in irrigation canals, including the PAP main canal, which blocked the flow of water. On Wednesday night, more than one tonne of cotton waste was dumped in the PAP main canal, following which farmers urged PCB, WRD, and police departments to take action.P Ashok, a farmer from Veppampalayam in Vellakoil, said,

We depend on PAP Irrigation. The PAP main canal and branch canals are very important structures for our livelihood. Waste cotton has been frequently dumped in the canals for the past few months. Even on Wednesday night, more than a tonne of waste cotton in sacks was dumped along the PAP main canal in Veppampalayam.

We noticed this only on Thursday. But it is not known who brought it there and dumped it. We contacted the private company in Gujarat whose name was printed on the poly ""There are many spinning mills in Vellakovil area and people buy first-grade waste cotton from them. We suspect that after using it they dump the waste in irrigation canals instead of disposing it of in the proper manner. It accumulates in irrigation canals and spreads to the grazing lands. This affects the environment and livestock. Most of the time we clean the waste from the canals ourselves. Officials should take appropriate action in this matter, the farmer added P Velusamy, President of PAP Vellakoil Branch Canal Water Conservation Movement, said, Apart from waste cotton, people also dump meat waste in these canals. The WRD, Pollution Control Board, and Police should prevent this.

MBA graduates and a Class 12 passout among 16 candidates in election fray

Gurgaon. Educational qualifications of all 16 candidates who are in the fray from Gurgaon assembly seat range from a Class 12 passout to one with an MBA degree from Belgium. While BJP's Mukesh Sharma dropped out after passing Class 12, Mohit Grover of Congress went abroad to study MBA.An analysis of candidate affidavits found that six of them have master's degrees, five are graduates, and the remaining did not pursue higher education. Mukesh Sharma's affidavit submitted to the Election Commission to file his nomination from Gurgaon showed that the 44year-old BJP candidate cleared Class 12 from the National Institute of Open Schooling in 2010.A wrestler-turned-politician, Mukesh Sharma of Dundahera village, is the co-convenor of Haryana BJP's sports cell. After being denied a BJP ticket in 2014, Sharma had contested as an Independent but lost the election. Sharma's key rival Mohit Grover (31) has a postgraduate degree in business management from the International Management Institute of Brussels, Belgium. Grover's affidavit showed that he got the degree in 2014.

BJP rebel Naveen Goyal, who announced that he was contesting as an Independent after he was denied a party ticket from the city, is a graduate from the University of Rohtak. Among others in the race is Sanjay Lal, an Independent who is fighting the election on behalf of a group of RWAs. Lal has a master's degree in history from the University of Mumbai. He is an entrepreneur and consultant.

Ankit Alag of Jan Sewak Kranti Party holds an MBA degree from the Indian Institute of Planning and Management (IIPM) and Independent candidate Akshat Gait is also an MBA postgraduate from Management Development Institute (MDI) in the city. Another Independent, Narender Kumar, is a retired postgraduate teacher (PGT). Though it is not a necessity,

some residents believe that it is high time parties start considering a candidate's education parameters. "The city has offices of Fortune 500 companies. It is a hub of IT firms and startups, and there are several industries. Parties should consider all this before selecting a candidate for Gurgaon," said Varun Sharma, a city resident who works for an IT firm. Joseph Benjamin, a retired professor of political science and political analyst, said at the time of framing the Constitution, the demography of the country was different and literacy rate was low.

MCG hires 6 cos to dump building waste in Basai

Gurgaon. MCG has hired six private agencies for collecting construction and demolition (C&D) waste throughout the city. The corporation has temporarily suspended its decision to dump and process the collected waste at three out of the four sites which were identified earlier, following opposition from the public. The agencies have been instructed to dispose of the waste at the Basai C&D waste plant."These agencies are hired at the rate of Rs 150 per metric tonne. We have not been able to make the other three sites operational because of public protests. However, we will proceed after the model code of conduct is lifted and elections are over," said a senior MCG official.

MCG had earlier identified Babupur, Basai, Baliawas, and Daultabad as potential C&D waste dumping sites. However, residents of these areas, especially Baliawas and Daultabad, protested this move. According to the C&D Waste Management Rules, 2016, "every waste generator will have to keep the waste within the premises or get the waste deposited at the collection centre made by the local body or hand it over to the authorised processing facilities". Furthermore, the rules mandate that the local authorities are responsible for transporting the "collected waste to appropriate sites for processing and disposal, either through their own resources or by appointing private operators."

According to MCG officials, residents can dispose of construction waste at the Basai C&D waste plant by paying a fee of Rs 360 per metric tonne. However, the waste generator will be responsible for arranging for the transportation and dumping of the waste at the designated plant.

1.2cr fines for using phones while driving in city this yr



Gurgaon. Around 10 persons are fined daily in the city for using mobile phones while driving. This year, 2,423 vehicle owners have paid Rs 1.2 crore in fines for being on the phone and at the wheels simultaneously. To curb this widespread wrong, police on Thursday organised a checking campaign and penalised 153 people in a day, fining them for Rs 7.6 lakh. A person caught using their phone while driving is liable to pay Rs 5,000 as fine.

"A special checking campaign was conducted by traffic police to discourage people from using mobile phones while driving," said DCP (traffic) Virender Vij, adding that the trend was a serious offence and a major threat to life of those inside the vehicle and on the road."It is important for drivers to understand the dangers of using mobile phones while driving. It distracts the driver and takes their attention away from the road, which can lead to accidents. Even a momentary distraction can prove to be fatal," said the DCP.According to the police, most of the people penalised for using mobile phones while driving are those riding two-wheelers and auto-rickshaws. "The majority of people who die in road accidents are twowheeler riders," said an officer.

Cratered & flooded every monsoon, but SPR waits for revamp since 2019

Gurgaon. With high-end condominiums offering the perfect backdrop, the 14km Southern Peripheral Road (SPR) was meant to seamlessly connect the new sectors with the established hubs off Golf Course Road and Sohna Road. For many, the promise of a well-connected, modern arterial road led to real estate investments in the area, with the belief that daily commute would improve. More than a decade after its initial development in 2012-2013, however, SPR is now synonymous with potholes, waterlogging, and traffic chaos. A redevelopment plan has been in the pipeline since 2019, leaving residents and computers grappling with a road that commuters grappling with a road that seems to worsen with each passing monsoon. Frequent waterlogging and deep potholes pose constant threats to both vehicles and pedestrians, making the stretch dangerous during rains.GMDA's continuous back-and-forth and revisions have delayed progress on the ground. Despite sporadic repairs by the metropolitan authority, such as partial repairs of the stretch from Ghata T-Point

to Vatika Chowk earlier this year, the section between Vatika Chowk and the CPR-SPR junction remains neglected.

Residents of nearby condominiums said they have to battle deteriorating conditions just beyond their gated communities. Dhirender Kumar Singh, a businessman from Sector 78, said SPR is the backbone of connectivity to south Gurgaon. "But govt has failed to ensure smooth connectivity. Deep potholes are damaging our vehicles, and during rains, the road virtually turns into a river. The drive from home to the airport should be under 45 minutes, but I was recently stuck in SPR alone for over 45 minutes. I nearly missed my flight. Authorities have been talking about redevelopment for years, but nothing is happening on the ground."

SPR was never fully completed, with some portions of the right of way still awaiting land acquisition, which need to be addressed before the authority can go ahead with the redevelopment plan. This, coupled with subpar maintenance over the years, has worsened its condition. With the opening of Dwarka

Expressway earlier in March and further improved connectivity with Manesar, Tauru and other areas, the traffic volume on this stretch has increased manifold. 'When we bought our flat, we were sold on the promise of excellent connectivity through SPR. But years later, it has been nothing but a hassle. Every day, we face traffic jams that sometimes last all the way to Badshapur. Even the pothole filling exercise is just an eyewash, as the repairs are washed away by the rains," said Harsh Mehra, an IT professional from Sector 69.

Though redevelopment plans have been on the cards since March 2019, with administrative approval granted in June 2022 for the upgrade of the 14km stretch from Ghata T-point to NH-8, bureaucratic delays and continuous revisions have kept the project from moving forward.GMDA has worked on multiple proposals to improve SPR, each more ambitious than the last, yet none has materialised. In March 2019, the authority proposed two options — one with traffic signals costing

free traffic movement through three flyovers and two underpasses, estimated to cost GMDARs 281.9 crore. The second plan was approved, but subsequent changes stalled the project. In 2020, the scope was extended to include a stretch from Ghata to Kherki Daula as traffic volumes increased. By Jan 2021, GMDA proposed constructing four flyovers and one underpass from Ghata to Vatika Chowk and an additional flyover between Vatika Chowk and NH-8, pushing the project cost to Rs 600 crore. These proposals, however, were constantly revised.In July 2021, GMDA altered the plan again, adding five flyovers, more green space, cycle tracks, and footpaths. By Dec 2021, a revised proposal costing Rs 541.9 crore was tabled, but soon afterwards, officials were once again directed to modify the plan to incorporate future metro corridor planning. Administrative approval was finally granted in June 2022 for eight flyovers, a six-lane main carriageway, and three-lane service roads at a cost of Rs

Sewer line, its boundary wall fall apart after rain; wastewater flows onto roads

Noida. A sewer line, the RCC boundary wall, and the mesh surrounding it near the Sector P3 roundabout were damaged after persistent showers since Thursday. The sewer line was already dilapidated and leaks had developed in several areas. The recent showers spilled sewage on the roads in Sector 36, Alpha, Beta, Gamma, Delta, Pari Chowk, P3, and Swarn Nagari, among others. TOI reported on Aug 24 about the damaged sewer line that was leaking.Greater Noida Authority engaged in arranging an alternate concrete sewer line later in the day. However, its quality was so poor and broken in many parts that residents raised concerns and opposed



its installation. As a result, the structure was taken back. The Greater Noida Authority started working on installing a new concrete sewer line, but its poor quality and damage to multiple parts drew opposition from residents. As a result, the structure was removed.

Residents said the sewer leakage problem has persisted for over three months now and there has been no redressal."We called GNIDA CEO Ashutosh Dwivedi, senior manager Vinod Sharma, and manager Shubhangi Tiwari to inform them about the damage to the sewer mainline. We also sent videos. Despite our efforts, no repair work has started in the last three months. As a result, the situation has worsened with recent showers, causing not only the sewer but also the surrounding RCC boundary wall and mesh to collapse. This poses a serious threat of a disease outbreak," said Harinder Bhati, a resident of Sector Beta 1

Leaking ceilings, snakes: What's keeping students away from Noida schools

Noida: Classes were disrupted in several primary schools across the city as persistent rain since Thursday left ceilings leaking, floors wet and playgrounds waterlogged. At a few schools in the rural pockets, students were sent home early as there were no spare rooms to shift them

once water started to drip from the ceilings of their classrooms.Praveen Sharma, the district president of UP Teachers' Association, told TOI that since across the city had flagged concerns over poor waterproofing and dilapidated school buildings on common WhatsApp groups. Principals of some schools claimed snakes were spotted on waterlogged playgrounds, triggering chaos among kids and staff.

Noida has 511 primary schools but most of them claim they do not have sufficient capital funding to maintain their buildings and facilities. In UP, schools receive a composite fund of Rs students' strength in each academic year. School principals claimed these funds are majorly utilised for purchasing classroom equipment, such

stationery, leaving little funds for renovating the infrastructure. Noida's basic education officer Rahul Panwar acknowledged the gap in funding and demand. "There are some schools with



dilapidated classrooms. However, in such situations, teachers can shift the students to other rooms and continue taking classes.'

But teachers disagree.

Dhoom Manikpur primary school, principal Sushma Rani said, "On Thursday, there was an ingress of water in two of our classrooms, forcing us to accommodate students of two classes Friday, several of these students decided to skip school."Principal of a primary school in Dankaur block said following overnight rain, the building's ceiling had become damp, and plasters started to come off here and there. "We were

scared that it could collapse anytime and could not let children sit in classrooms under such risky situations. There are not enough rooms for over 150 students here, so there was no question of shifting them to another classroom. What does the authority do throughout the year? Are they waiting for an accident to happen?" the principal said.

2 held for using bike with modified silencers

Gurgaon. Two youths were arrested on Thursday for allegedly using a Bullet bike with modified silencers. A fine of Rs 29,000 was issued, and the bike was impounded, the police said on Friday.

Police took action after the Sohna City police station received complaints from locals about the accused creating a nuisance with a modified Bullet bike at the Sohna Bus Stand.

Sending a strong message to those who like to draw attention by modifying bike silencers to emit loud and blaring sounds, ACP (Traffic) Abhilaksh Joshi said that police teams have been formed to impound these bikes and issue fines to the riders as per traffic rules."It is important to take action against people who replace the factory-fitted exhaust system of their bikes or modify the existing unit, resulting in the exhaust system emitting a loud noise far above the prescribed decibel limit, causing inconvenience to the public. It not only causes a disturbance to other road users but also to residents who are jolted by these piercing sounds. Causing silencer blast sounds is an offense under the Motor Vehicle Act," said ACP Joshi.Police have also been advising shopkeepers who sell vehicle spare parts and motor mechanics not to modify bikes to produce a thumping sound while driving, added ACP Joshi.In August, the police conducted a special campaign to crack down on traffic violations involving bikes with modified silencers, non-functional silencers, and pressure horns in Gurgaon. The police issued a total of 190 fines, including 71 for Bullets with modified silencers and 119 for pressure horns, amounting to Rs 19 lakh in fines." Previously, the police had issued challans to those who modified motorcycle silencers. However, with the increasing number of bikes making loud and disturbing sounds on the roads, the police have decided to take stricter action," said an official.

Appealing to the public to obey the rules, the official added, "It is important for vehicle owners to understand that modifying their vehicles is not only illegal but also dangerous. Modified silencers can cause hearing damage, and the loud noise can distract other motorists on the road, leading to accidents. It is the responsibility of every citizen to follow traffic rules and regulations and to keep their vehicles in a condition that does not pose a risk to public

Leachate harming Aravalis, Bandhwari waste plant is set to lose its green NOC

Gurgaon. The wildlife department on Friday initiated the process to withdraw the no-objection certificate (NOC) it issued for the Bandhwari waste treatment plant. MCG has been given 10 days' notice before the department proceeds with the withdrawal of the NOC, which was initially granted to ensure the plant operated without causing any harm to the surrounding Aravali forest area.In the notice, the department also said there was non-adherence to directives such as orders by Supreme Court (SC) and National Green Tribunal (NGT) at the Bandhwari site, as well as infringements of legislations like the Indian Forest Act (IFA), 1927; Wildlife Protection Act (WLPA), 1972; and Forest Conservation Act (FCA), 1980.A recent survey conducted by the department found that the revenue rasta, a road utilised for water filling and patrolling in the Aravalis, is being obstructed by solid waste from the landfill, hindering officials from accessing the forest. Furthermore, leachate from the landfill is seeping into the forest and accumulating in waterbodies and low-lying areas, contaminating groundwater and posing a substantial threat to the local wildlife,

officials said. Based on these findings, Gurgaon divisional wildlife officer Rajesh Chahal wrote to the chief conservator of forest and wildlife (south Haryana) AP Pandey, recommending that the NOC for the Bandhwari plant be revoked unless the issues are resolved. Subsequently, the process to revoke the NOC was initiated.MCG was granted the NOC in 2019 on the condition that the civic corporation and waste management concessionaire Ecogreen deposit Rs 2 crore with the wildlife department as environmental compensation. Apprehensions have been raised about the presence of leachate in a pond near the landfill in the Aravalis that was once a source of water for wildlife. The consumption of this contaminated water by animals could be lethal, officials said. Despite repeated communications to the MCG commissioner urging compliance with the conditions of the wildlife NOC for proper landfill management, no significant improvements have been observed, they added. The landfill's proximity to a richly biodiverse forest area with abundant wildlife is causing habitat disturbance and increasing the



potential for man-animal conflicts in Gurgaon and its vicinity, the department said in its notice.

.. inspected the area on Aug 28 and found that land and water in a pond just behind the landfill inside the forest area is encroached with municipal waste and leachate...A 1km-long black river of death with toxic leachate is flowing continuously to the Aravalis from the landfill," the notice stated. Officials said a survey by the wildlife department had also found in 2021 that Ecogreen was

"intentionally" spilling thousands of litres of leachate from the landfill onto mining pits in the eco-sensitive Aravalis.Spread over 33 acres on the Gurgaon-Faridabad road, lakhs of tonnes of waste from the two NCR cities has been piling up at the massive Bandhwari landfill - and an estimated 2,000 tonnes is added daily. Meanwhile, wildlife enthusiasts said they have complained of leachate spill into the Aravalis several times. "HSPCB has already collected samples near the Bandhwari

plant several times to check if it is leachate, and it has been confirmed every time that the water is contaminated. Spilling of leachate is a grave issue in the area, but no concrete action has been taken by the civic agencies over the years," said Vaishali Rana Chandra, an environmental activist.

Meanwhile, MCG commissioner Narhari Bangar said, "We are 100% carrying out compliance and we are also ensuring that no environmental violations happen at the News box

US Court in Pennsylvania rules against accepting misdated mail-in votes

World The Pennsylvania Supreme Court on Friday reversed a lower court's ruling from almost two weeks ago that had said the two most populous counties of the battleground state will not be able to throw out mail-in votes over incorrect envelope dates. **KEY QUOTES**

The Pennsylvania Supreme Court's Friday ruling said the Commonwealth Court of Pennsylvania "lacked subject matter jurisdiction to review the matter," according to a court filing.

The Republican Party welcomed the ruling. Voting rights advocates including the American Civil Liberties Union said they will look at pursuing additional legal options and said the ruling was a "setback for Pennsylvania voters." WHY IT'S IMPORTANT

Pennsylvania is a key battleground state in a tight presidential race for the Nov. 5 U.S. elections in which Democratic Vice President Kamala Harris faces Republican former President Donald Trump.

Battleground states are those where elections were won by a narrow margin of 3 percentage points or less in the last contest. Pennsylvania is one of seven such states.

The ruling will mean that state election officials will not be counting misdated ballots in the election unless courts intervene again before the elections.

The late August ruling in the Commonwealth Court of Pennsylvania applied to the Philadelphia and Allegheny Counties. It had said that refusal to count undated or incorrectly dated, and timely mail ballots submitted by eligible voters violated the

Netherlands announces toughest asylum policy ever to curb illegal migration

Amsterdam The Dutch government said on Friday it aimed to implement measures to limit migration in the coming months, including a moratorium on all new applications, days after Germany announced new border controls to keep out unwanted migrants.The new government, led by nationalist Geert Wilders' anti-Islam PVV party, said it would declare a national asylum crisis, enabling it to take measures to curb migration without parliamentary consent. Opposition parties have questioned whether the move is necessary or even legal, but the PVV's migration minister Marjolein Faber said she was acting on opportunities granted by the country's own migration laws. We are taking measures to make the Netherlands as unattractive as possible for asylum seekers," Faber said in a statement.

The Netherlands received two first-time asylum applications per 1,000 inhabitants in 2023, equal to the EU average, Eurostat data shows. Ten European countries had a higher relative number of asylum seekers last year.

But after years of budget cuts, the country's only registration center for asylum seekers has been struggling to deal with the flow of migrants, forcing hundreds of refugees at times to sleep in the rough. Despite the relatively moderate numbers, Prime Minister Dick Schoof said curbing the flow of migrants was necessary to deal with problems on the housing market and to improve access to healthcare and education. "I don't want to label it the only problem, but the fact is, it isn't helping," Schoof said.

3 US citizens among 37 sentenced to death in Congo over role in failed coup

Kinshasa Three US citizens are among 37 defendants sentenced to death by a military court on Friday for their role in a May failed coup in Democratic Republic of Congo.

Armed men briefly occupied an office of the presidency in the capital Kinshasa on May 19 before their leader, US-based Congolese politician Christian Malanga, was killed by security forces. His son, Marcel Malanga, was among the Americans on trial, along with Marcel's friend, Tyler Thompson, who played high school football with him in Utah. Both are in their 20s. The third American, Benjamin Zalman-Polun, was a business associate of Christian Malanga.

All three were found guilty of criminal conspiracy, terrorism and other charges, and sentenced to death in a ruling read on live TV.

Malanga had previously told the court that his father had threatened to kill him unless he participated. He also told the court it was his first time visiting Congo at the invitation of his father, whom he had not seen in years.

The Americans are among some 50 people, including US, British, Canadian, Belgian and Congolese citizens, standing trial following the failed coup. A total of 37 defendants were sentenced to death.

The verdict was read out under a tent in the yard of Ndolo military prison on the outskirts of Kinshasa. The defendants were seated in front of the judge, wearing blue and yellow prisonissued tops. In Washington, State Department spokesperson Matthew Miller said embassy staff had attended the proceedings and would continue to follow developments closely.

Bomb threat sounded in Ohio's Springfield amid anti-migrant tensions

World Government buildings and an elementary school in Springfield, Ohio were credible reports of pets being harmed by evacuated Thursday after an emailed bomb threat, police said, rattling the small US city at the heart of an anti-migrant conspiracy theory amplified by Donald Trump.

Springfield has been thrust into the spotlight in recent days after an unfounded story of Haitian migrants eating pets went viral on social media, with the Republican expresident and current White House candidate pushing the narrative despite it being debunked.Democrats have accused Trump and his running mate, Ohio Senator JD Vance, of fanning racial tensions as they use the Springfield conspiracy theory to elevate immigration as a campaign issue ahead of November's election.Trump doubled down on the rhetoric during a campaign rally in Tucson, Arizona on Thursday, saying that "migrants are walking off with the town's geese."Immediately after mentioning Springfield in his speech, Trump added: "I'm angry about young American girls being raped and sodomised and murdered by savage criminal aliens," though provided no specific details.

Iran sends satellite into space, 1st under President Masoud Pezezhkian: Report

Tehran. Iran on Saturday sent a research satellite into orbit with a rocket built by the paramilitary Revolutionary Guard, the state-run IRNA news agency

Though Iran has long planned to send satellites into orbit, this is the first launch under reformist President Masoud Pezezhkian after his hardline predecessor Ebrahim Raisi died in a May helicopter crash.In January, Iran said it successfully launched three satellites into space with a rocket. The program is seen by the West as part of the improvement of Tehran's ballistic missiles. The launch also comes as heightened tensions grip the wider Middle East over Israel's continued war on Hamas in the Gaza Strip, sparking fears of a regional conflict.

The United States has previously said Iran's satellite launches defy a UN Security Council resolution and called on Tehran to undertake no activity involving ballistic missiles capable of delivering nuclear weapons. UN sanctions related to Iran's ballistic missile program expired last

"One has to choose the lesser of two evils. Who is the lesser evil? That lady or that gentleman? I don't know. Everyone have to think and make this decision according to their conscience," Francis said.

Donald Trump vows to deport Haitians in Ohio if elected as President

World Republican presidential candidate Donald Trump pledged on Friday to conduct mass deportations of Haitian immigrants from the Ohio city of Springfield, even though the majority of them are in the United States legally. The city for days has found itself at the centre of a social media maelstrom after right-wing agitators latched onto false claims that Haitian arrivals were eating household pets."We will do large deportations in Springfield, Ohio," Trump said at a press conference at his golf resort near Los Angeles. The majority of the 15,000 Haitians in Springfield are there legally. Trump's long-standing pledge to conduct mass deportations usually refers to those in the country illegally. Trump did not repeat the assertion he made during Tuesday's presidential debate with Democrat Kamala Harris that immigrants were eating dogs and cats, remarks that have been widely mocked.wo elementary schools were evacuated and one middle school in Springfield was closed on Friday after anonymous bomb threats were made against the community for the second day in a row, according to ABC News.At the White House, President Joe Biden urged the attacks on the Haitian community to cease."It's simply wrong. There's no place in America. This has to stop - what he's doing. It has to stop," Biden said. The Biden administration extended Temporary Protected Status to hundreds of thousands of Haitians in the United States in June, a decades-old program that protects legal immigrants from deportation and gives them work permits. Gang wars in Haiti have displaced over half a million people and nearly five million are facing severe food insecurity. Trump has cited the tensions in Springfield as another example of the need for hardline immigration policies. The influx of Haitians has boosted the economy but also has strained social services."I'm angry about illegal Haitian migrants taking over Springfield, Ohio. You see that mess, don't you?" Trump said at a rally in Las Vegas, later on Friday.

Austrian court finds woman guilty of fatally infecting neighbour with Covid-19

A judge sentenced the 54-year-old on Thursday to four months' suspended imprisonment and an 800-euro fine (\$886.75) for grossly negligent homicide.

Vienna. A woman in Austria was found guilty of fatally infecting her neighbour with Covid-19 in 2021, her second pandemic-related conviction in a year, according to local media. A judge setenced the 54-year-old on Thursday to four months' suspended imprisonment and an 800-euro fine (\$886.75) for grossly negligent homicide. The victim, who was also a cancer patient, died of pneumonia that was caused by the coronavirus, according to Austrian news agency APA.A virological report showed that the virus DNA matched both the deceased and the 54-year-old woman, proving that the defendant "almost 100 percent" transmitted it, an expert told the court.

"I feel sorry for you personally -- I think that something like this has probably happened hundreds of times," the judge said Thursday.



has determined with almost absolute certainty that it was an infection that came from you."

While the judge issued the sentence Thursday, APA reported that the

verdict isn't yet final. The names of the victim and defendant were not released in line with Austrian privacy rules. The woman was convicted of a Covid-related offence last summer, APA reported.

The agency said she was sentenced to three months' suspended imprisonment for intentionally endangering people through communicable diseases. But she was acquitted on the grossly negligent homicide charge at that time. This week, the judge heard statements from the deceased's family, who said there had been contact in a stairwell between the neighbours on December 21, 2001

when the defendant would already have known she had Covid-19. But she denied the meeting, saying she was too sick to get out of bed that day. She also said she believed she had bronchitis, which she typically gets every year. But the woman's doctor told police that the defendant had tested positive with a rapid test and told him that she "certainly won't let herself be locked up" after the result.

14 dead in Afghanistan in one of deadliest attacks this year by Islamic State

A relative of one of the victims, Reza Ali, said the government was responsible for security and that the situation should have been avoided. A UN-appointed rights expert for Afghanistan, Richard Bennett, said he was alarmed by the spate of attacks claimed by the IS.The "appalling killings" of the Shiite Hazaras bore the hallmarks of international crimes, said Bennett, whom the Taliban have barred from Afghanistan. Hazaras make up around 9% of Afghanistan's population of about 40 million people and are mostly Shiite Muslims, despised by Sunni Muslim radicals like the Islamic State group.

Another week needed to count damaged trees

MULUGU: An 185-member team of Forest department staff is collecting details of the trees damaged in the Eturnagaram Wildlife Sanctuary in Mulugu due to a freak weather incident on August 31. Since the catastrophe that flattened thousands some estimates put the figure at around one lakh of trees, including some rare varieties, the forest staff has been busy trying to enumerate the extent of damage and possibly find the reason.

The forest department is collecting details of the uprooted trees using drones, from Medaram to Pasara and Medaram to Tadvai in the forest area of Tadvai mandal in the district.

Inspired by T-Works, JNTUK Mulugu District Forest Officer Rahul Jadhav Yadav told TNIE: "We have deployed forest staff from the nine ranges in Mulugu. The staff are collecting details of the damaged trees and marking each trunk with paint. It will take seven to eight days to complete the enumeration and only then we would know the exact number of trees that have been damaged in the sanctuary."He said that the Central team visited the Forest department office in Hyderabad and collected details from the higher officials. The officials gave a presentation on the damage to the trees in Eturnagaram Wildlife Sanctuary."After their inquiry, we got to know the reason for the freak weather incident. As per directions of higher officials, the entire staff is working on a war footing to identify the damaged trees, measuring them and marking them with paint," said Yadav.

J&K leaders must have an ear to the ground

KASHMIR is crisscrossing multiple fault lines ahead of the three-phase Assembly polls scheduled to begin on September 18. Most of these lines have been created by the traditional regional parties that are unable to explain why they are fighting as rivals when their manifestoes focus on two key promises — restoration of Article 370 and reclaiming the identity and dignity for the masses.

Both the National Conference (NC) and the Peoples Democratic Party (PDP) claim to be anchors of Kashmir's aspirations but have accused each other of wrecking the prospects of unity of thought and purpose in the most critical elections in the history of Jammu and Kashmir. The results of these elections will redefine J&K's place and claim to statehood, the biggest concern among its people. There are expectations that the polls will see the highest voter turnout ever. That s what makes the whole thing unpredictable. High voter participation will come with multiple claims and aspirations that have not been analysed so far. Nor can that be done until the votes are counted on October 8. The parties are also nervous, because it is difficult for them to decipher the trend. They know it through their recent experience during the Lok Sabha elections, in which both Omar Abdullah and Mehbooba Mufti lost to their rivals.

This time, the Assembly elections manifestation of the impatience of the people accumulated over the last 10 years (with greater intensity since the abrogation of Article 370) rest on two basic factors. One, Kashmir has rediscovered normalcy, and the residents want it to pass through this transitory stage and arrive at long-term peace. The thrust is on peace with the recognition of their claims to jobs and no compromise on their land rights. This, in translation, means the restoration of the provisions of Article 35A, which was also scrapped along with Article 370 on August 5, 2019. They are willing to adapt to the idea of India on their own, and not through imposed narratives or optics. The NC, after having declared that it would go solo, took a U-turn and entered into a pre-poll alliance with the Congress, conveniently forgetting the bitter experiences of past partnerships. The ghost of the alliance not passing the test of transferring votes to each other has already emerged, with former J&K Pradesh Congress Committee chief and party candidate from Banihal, Vikar Rasool Wani, hurling invectives at the NC and its leadership, causing embarrassment to Rahul Gandhi, who had campaigned for him on September 4. Rahul had promised a victory for the alliance and a defeat for the BJP, but Wani was bent on rocking the boat. It was an alliance of compulsions for both parties. The NC wanted to silence a whispering campaign that it had a secret pact with the BJP. It chose to ally with the 'secular' Congress. Rahul wanted to showcase himself as the leader of the INDIA bloc and got the NC to his side. The idea of a friendly contest on five seats in itself is self-defeating, though.

The NC's manifesto, which is similar to that of the PDP, People's Conference and even the Awami Ittehad Party of Engineer Rashid, has landed the Congress in a catch-22 situation. It can neither support the demand for the restoration of Article 370 because of the nation's mood overwhelmingly favouring its abrogation, nor can it oppose it because that will undermine the NC's position in Kashmir. And the BJP will play it as an endorsement of its policies vis-à-vis J&K.

Home Minister Amit Shah was quick to ask Rahul to say 'yes or no' to the NC's foremost agenda. The BJP is striking hard at it, making the grand old party look vulnerable in the Hindudominated Jammu region. The party is also sowing seeds of suspicion among the Kashmiri Muslims who want straight answers.

The dominance of Article 370 in the political discourse helps both sides stoke emotions regional parties in Kashmir are invoking the loss that the masses have suffered because of the August 5, 2019, decisions — it is not just that the symbolism of a separate flag and.

Recalibrate strategy to protect railway network from sabotage

Like his counterparts in UP and MP, Sarma has been allowing the use of bulldozers as a retaliatory measure.

THE Central Government said on September 10 that 18 incidents of sabotage of railway infrastructure had occurred since August 1 this year; a total of 24 incidents have happened in the past two years. On September 8, an LPG cylinder was found on a railway track near Kanpur. A fortnight ago, Railway Minister Ashwini Vaishnaw had expressed concern over recent train derailments and said that a "disturbing trend is being seen". As a result of this, the Railways and other agencies are investigating multiple attempts to derail trains. Terrorist involvement in the matter is also being looked into.

This spate of incidents to sabotage the railway network in India is not a new phenomenon. As per a press release of the Ministry of Railways, the Railways decided to undertake patrolling of tracks in the sections considered sabotage-prone, keeping in view the safety of passengers, in September 2003. Why target the Railways? Over the years, the establishment has focused largely on the security of the aviation sector and so the surface transport infrastructure has not received due emphasis. Terrorists are known for their ability and desire to innovate, both in terms of technology and tactics so as to be a step ahead of the security agencies to successfully carry out attacks. The railway network has always been a favourable target of terrorists due to its expanse, the high number of people who utilise it, as well as the vital logistics services it provides to the nation. The Railways is also expanding and this will likely result in it becoming increasingly vulnerable to attacks. The disruptive potential of such attacks can be gauged from the targeting of France's high-speed train lines that were targeted by 'malicious' acts, including arson and 'coordinated sabotage' to disrupt travel ahead of the opening ceremony of the Paris Olympics.

the safety and security of passengers and goods, a harmonised, coordinated and collaborative response by all stakeholders is required to prevent such attacks and reduce the vulnerability of rail infrastructure. The plan should also include measures to enhance our capability to minimise the damage and restore services promptly whenever such attacks occur. The first step is to understand the moives of the perpetrators. In Ajmer, Rajasthan, two cement blocks weighing 70 kg each were placed on the rail track. Despite hitting the cement blocks, the train was able to continue its journey without any damage. These are apparently attempts to derail trains with the aim of causing fatalities and destroying railway property. It seems that these attacks were carried out by rookies rather than by well-trained terrorists. These acts may have been executed by criminal elements; the terrorist-criminal nexus has existed since the advent of terrorism. More importantly, the execution



of such attacks has been outsourced to criminals who are acting like overground workers of terrorist organisations. As time passes, they can enhance the survivability and relevance of the terrorists to create an atmosphere of lawlessness and insecurity. Therefore, it is imperative to classify these intentional attempts to derail passenger and goods trains as terrorist acts and not sabotage by criminal elements.

While fragmented efforts have been initiated to enhance Secondly, while the train operations are under the control of the Ministry of Railways, the guarding of tracks and bridges against miscreant activity is the statutory responsibility of the state governments concerned. The Railways also has the Railway Protection Force and Government Railway Police under it. In such a situation, the Ministry of Home Affairs (MHA) has to step in to assume the role of coordinating and 'de-conflicting' roles of various agencies and stakeholders. The MHA should order a review of the security of railway infrastructure, risk and threat assessment to prioritise vulnerabilities and gaps in the security architecture to prevent and deter both physical and cyberattacks. These risk-based plans should be tailor-made for specific areas, including measures to enhance information-sharing, protection and leveraging technology to improve rail security. The Railways will need to focus on training employees, improving technology, infrastructure and coordinating with law enforcement agencies, industry,

state, local and community officials, emergency responders and Central agencies to foster collaboration and integrate resources for enhanced deterrence and response capabilities. Measures like surveillance through CCTV cameras, drone monitoring, patrolling and regular track inspections will have to be dovetailed in the plans to prevent such incidents. In high-threat areas, it would be advisable to have pilot engines clear the lines ahead of the passenger trains.

The Railways will also need to evolve a system of public participation in ensuring security of the infrastructure. For this, it could look at the US system developed in 2010, called the Nationwide Suspicious Activity Reporting Initiative throughout the entire rail system. This was a significant step toward enhancing the security of the national transportation infrastructure in partnership with federal, state and local law enforcement agencies to identify and report suspicious incidents or activity and share that information nationally so that it can be analysed in real time. One of the critical challenges will be to implement security measures to safeguard our rail system from terror attacks without compromising the accessibility and efficiency of train travel. In fact, the MHA should go beyond the railways and progressively prepare and implement a national infrastructure and key assets protection plan to remain ahead of the terrorists before they target other sectors

Puja curbs & trade ban

Dhaka's actions could strain ties with Delhi

BANGLADESH's interim government, led by Muhammad Yunus, has issued a directive mandating Hindu Puja committees to stop using musical instruments and sound systems five minutes before and during the Islamic azaan and namaz as the country prepares for Durga Puja. This move, ostensibly aimed at maintaining religious harmony, has the shades of a 'Talibani' order targeting the country's beleaguered minority Hindu population. It is a disproportionate imposition on an already vulnerable community in the garb of ensuring law and order during the largest Hindu festival of the region. The curbs may not only deepen the divide between the communities in Bangladesh, but they can also strain the country's relations with India. The timing is particularly sensitive, given the political situation following the ouster of Sheikh Hasina as the PM.

Dhaka's decision to ban the export of Padma hilsa — a beloved fish staple during puja festivities in West Bengal



to India could also escalate tensions. This ban is a reversal of the goodwill established by previous governments through 'hilsa diplomacy'. The symbolic exchange of fish had become a bilateral gesture

While these developments have not yet triggered an official diplomatic response from India, they raise concerns over religious and trade policies under Bangladesh's interim government. In this context, Yunus' statement on Wednesday that his country seeks strong ties with India based on fairness and equality contradicts his government's policies. Though the appeal highlights his government's intent on fostering regional cooperation and mutual respect, it is on an opposite trajectory, thus risking alienating India. The religious restrictions, along with the trade ban, could undermine the historic bond between the two countries. If Bangladesh seeks to maintain peaceful and fruitful relations with India,

religious inclusivity and balanced diplomacy must guide its actions moving forward.

Riding roughshod over rules and laws

TRYSTS AND TURNS: Supreme Court has rightly taken a serious note of cow vigilantism and 'bulldozer justice'

COW vigilantes chased a car-borne youth on a national highway in Haryana for around 25 km, caught up with him and shot him dead. He happened to be Aryan Mishra, a forward-caste Hindu who obviously sensed that he was being followed but did not know why. He must have thought that the miscreants were robbers, and his first reaction would be to drive fast and escape. The vigilantes fired four bullets, two of which hit their target. When the victim's identity was established, the cow enthusiasts, whose sole interest is to punish Muslim butchers, beef-eaters and traders, were left with egg on their faces. The core of the BJP's support base before 2014 came essentially from the forward castes. This case of 'mistaken identity' could turn many of the faithful against the vigilantes, if not against the party that spawned them.

Vigilantism is a double-edged weapon. It can frighten potential victims, but it can also turn these unofficially empowered 'policemen' into criminals! A parallel example can be found in the police establishment itself where the emergence of 'encounter specialists' has led to crimes being committed by men in uniform.

It is much more difficult to check criminals in uniform than it is to counter the underworld. An honest and determined police officer, respected by his own men and the public at large, can tame the ganglords. But 'encounter specialists', whose birth is the result of the failure of the criminal justice system, are decidedly more difficult to control. 'Encounter specialists' are drawn from the ranks of subordinate officers imbued with courage, initiative and a flair for leadership. They are accepted by the public as they dispense fasttrack justice by assuming the roles of investigator, prosecutor and judge, all rolled into one. Public support translates into political support, and when the political establishment adopts them as the party's

saviours, it is well-nigh impossible for even enlightened police leaders to discourage them.

An identical principle applies to the cow vigilantes. They become a law unto themselves till a disaster like the 'mistaken identity' case occurs. Members of the Bajrang Dal are inducted into these vigilante groups as that is the most convenient source of recruitment for jobs that involve the use of muscle.

The Supreme Court recently took cognisance of this dangerous phenomenon. Poor Muslims, for whom the only source of protein is buffalo meat, are being serially subjected to vigilantism. The vigilantes barge into houses or stop vehicles if they suspect that beef is being stored or transported for sale or consumption. In states like Haryana, the police either close their eyes to these activities or support and encourage them.Lumpen elements find a very exciting occupation in these vigilante enterprises, like in the case of rape-murder of a trainee doctor at RG Kar Hospital in Kolkata. The suspect was employed unofficially as a civilian volunteer and given free rein in the hospital. He even had access to the local police station and often used police motorcycles to go to work. In the examples quoted above, one factor is common. They have the sanction of those in power.

Besides fake encounters and cow vigilantism, the apex court recently took a serious note of 'bulldozer justice'. Most municipalities keep

bulldozers to demolish constructions built without official permission. Most municipal officers desist from using bulldozers for the purpose for which they were purchased. Illegal constructions are a dime a dozen in my city, Mumbai, but bulldozers have not been used to punish criminals to the extent that CM Yogi Adityanath has done in Uttar Pradesh. When the

agitation against the Agnipath recruitment reached a crescendo in Uttar Pradesh and public buses and other government property were destroyed in many cities of the state, Yogi did not order bulldozers to respond. He reserved that usage to deal with crimes, even petty ones, committed by Muslims. He forgets that the Constitution makes no differentiation on the basis of the creed, caste or economic status of the



law-breakers. But in UP, Muslim boys falling in love with Hindu girls can expect the bulldozer at their

Talking about 'love jihad', my Christian Communion, the Roman Catholic, used to refuse to solemnise marriages of Catholics with non-Catholics (including with Protestants, who are Christians) unless the non-Catholic partner converted to Roman Catholicism. That rule has been abandoned for the past six decades or more. And rightly so.

Islam, which is also an Abrahamic religion like Christianity, has not yet relented on this rule. If nikah has to be performed, the non-Muslim partner has to convert to Islam. If the parties to the marriage decide on a registered marriage, like the more educated and

affluent do, the question of conversion does not arise. In that case, only 'love' remains the jihad goes. The accusation of a Muslim boy going out of his way to find a Hindu or Christian girl with the sole intention of augmenting the number of the faithful is ridiculous and outrageous. In a multireligious and multi-caste society, as exists in all states of the Union, a few inter-religious or inter-caste marriages are bound to happen. Some young people of different religions or castes are going to be attracted to each other. It is time to accept that fact and bury 'love jihad', and dispense with laws to prevent or punish such marriages that Uttarakhand and some other BJP-ruled states have enacted or are in the process of enacting.

In my immediate family and also in the families of some friends who have experienced inter-religious union, there has not been a single instance of conversion.

The phenomenon affects the poorer sections of society, which are surprisingly more conservative in such matters. It is surprising that accusations of 'love jihad' are made only in their cases. Perhaps the solution lies in ensuring better standards of living for all, which is what our Prime Minister has promised, but that is not going to happen anytime soon.

How to get Acquired

Bala Parthasarathy, managing partner at seed-stage fund AngelPrime, an early investor in ZipDial, writes <u>about the 7 things they learned from Twitter's acquisition of the Bengaluru-based venture</u>



Fortune favours the survivors -- The first rule in business is to survive. The longer you are around, the higher are your chances of being acquired or good things happening to you. Valerie Wagoner and Amiya Pathak (ZipDial founders) stuck it out through thick and thin. If they had folded their cards at the first hiccup, they would not have made history. Set your horizons for at least seven years. In the case of ZipDial, it happened to them in Year 5. If you want to start something and flip it in two years, you better be extremely lucky!

Traction, not just technology --Amiya (Pathak) built an amazingly scalable architecture that wowed Twitter. But unlike most technology companies I see, they had 60 million users, a strong sales team, growing revenues and ubiquitous presence. These must have been compelling factors when someone inside Twitter did a build-versus-buy decision.

Armchair matchmaking never works -- At AngelPrime, I hear entrepreneurs telling me why Facebook or Google or some other company would acquire them because of this-that-or-the-other. It never works that way. Based on my own experience in selling Snapfish and being the acquirer of startups, most large companies operate like independent fiefdoms ruled by fiercely protective leaders whose idea of what is best for them and what is

best for the overall company are typically at odds. It is these leaders. not the M&A team, that makes buying decisions, especially in technology.

Sow the seeds and be patient -- You should cultivate a business relationship with the potential acquirer that makes business sense for you and the company. Specifically, you should engage with one or more teams for which your technology or product would be interesting. Think business first, not acquisition first. And focus on why partnering with you helps them. In the process, get to understand the company's internal goals, the people and culture. ZipDial had a two-year business relationship with Twitter where they had worked together on various campaigns, including Bollywood and Indian elections.

People, not companies -- People, not companies, do deals. Valley companies are generally very insular and rarely do deals outside Bay Area, let alone India (Israel is an exception to the rule). They first need to build a relationship with you as a person before they see the value in your technology and business. The ZipDial team had solid relationships at multiple levels with different teams at Twitter, long before the deal was conceived. Luckily, there are plenty of people who can help you connect, if you're not the networking

type. iSpirt M&A Connect is a verv well designed programme which can formally help you forge relationships with many Valley companies.

Date many, marry one -- Though there might be one perfect company for you in the end, you should engage with multiple companies. And when I say engage, I mean build a business relationship.

There are so many rational and irrational factors that go into an acquisition decision from the acquirer's end that you'll never know about and thinking that THE ONE will eventually scoop you up, is foolish. Plus, your chances of being acquired are much higher when multiple companies court you. ZipDial had plenty of other business relationships, each of

which could have been THE ONE. Don't sell, be bought -- This cliche is certainly obvious to anyone who has ever bargained in a bazaar. If you're desperately looking to be sold, your chances of being acquired are very, very low. And even if you do get acquired, the price will be pathetic.

Indeed, the best way to be acquired is to go around building a solid business with traction, being patient and cultivating the relationships. And then, let the Gods of Luck play their role!

Is Lesbianism a Sexual Offense? NMC's New Medical Curriculum Sparks Outrage

New Delhi. The National Medical Commission has reintroduced 'sodomy and lesbianism' as unnatural sexual offences in the forensic medicine and toxicology curriculum for undergraduate medical students.It has also brought back topics such as the hymen and its type, and its medico-legal importance besides defining virginity and defloration, legitimacy and its medicolegal importance.

The revised curriculum under forensic medicine and toxicology also includes "Describe legal competencies including Bharatiya Nagarika Suraksha Sanhita (BNSS), Bharatiya Nyay Sanhita (BNS), Bharatiya Sakshya Adhiniyam (BSA)" besides "Protection of Children from Sexual Offences Act (POCSO), Civil and Criminal Cases, Inquest (Police Inquest and Magistrate's Inquest), cognisable and Non-cognisable offences".It talks about discussing sexual perversions, fetishism, transvestism, voyeurism, sadism, necrophagia, masochism, exhibitionism, frotteurism, and necrophilia. However, distinctions between consensual sex between queer individuals have been removed, a source said.

The amended curriculum has done away with the sevenhour training on disability. India successfully conducts first phase field trials of light tank in key step

New Delhi:Indian officials announced on Friday the successful completion of the first phase of field firing trials for an Indian Light Tank, a versatile platform capable of deployment in high-altitude areas.

Developed by the Defence Research and Development Organisation (DRDO) in collaboration with industry partner Larsen & Toubro, the tank demonstrated "exceptional" performance, efficiently meeting all intended objectives, according to the Defence Ministry."After producing the first prototype, it underwent preliminary automotive trials in-house. The field trials have successfully met the intended objectives in desert terrain. During the first phase of



field trials, the firing performance of the Light Tank was evaluated, and the tank demonstrated the required accuracy on the intended targets," the Army said in a statement.

The development of this Indian Light Tank strengthens indigenous defence manufacturing capabilities within the country, officials also noted. Defence Minister Rajnath Singh complimented the DRDO, the Indian Army, and the associated industries for the successful trials of the Indian Light Tank, calling it an "important step towards achieving self-reliance in critical defence systems and technologies". The Indian Army plans to deploy over 350 light tanks, primarily in mountainous border areas, to counter the increased military presence of China along the border.

Gang Rivalry, Torture, Web Of Conspiracy: Why Delhi Gym Owner Was Killed

New Delhi: The gym owner who was shot dead in South Delhi's upscale Greater Kailash area on Thursday night had come in the crosshairs of the Lawrence Bishnoi gang because he had asked his business partner not to pay? 5 crore that the outfit had tried to extort from him, sources have told NDTV. Nadir Shah, who is of Afghan origin, was allegedly also friends with two South Delhi gangsters. This friendship was used by the Bishnoi gang to tap the enemies of the gangsters, who, in turn, roped in people who had been threatened by Shah earlier, building a complex web before finally carrying out the murder. Shah was shot dead on a busy road in

Greater Kailash-1. A video of the shooting showed him standing and talking to one of his associates near some parked cars when a man in a checked shirt walked up to them and



began firing. Shah's associate managed to duck but the gym owner was shot six to eight times and was declared dead at a hospital.

While the shooter is on the run, four Spinning The Web people have been arrested so far and their interrogation and the police's investigation have revealed that Shah was a business partner of a man called Kunal Chhabra, who runs several illegal call centres in Delhi. Some time ago, members of Lawrence Bishnoi's gang had tried to extort? 5 crore from

Chhabra, but Shah had told him not to pay, saying he would protect him because he had friends in high places. Sources said this made Shah a target for the Bishnoi gang and he also spoke to Lawrence Bishnoi to negotiate a settlement, but was turned down. Around this time, Bishnoi was taken into police custody and allegedly tortured and he held Shah responsible for that. He allegedly declared in front of police officials that he would now take not five but? 10 crore from Shah and Chhabra.

Shah was friends with South Delhi gangsters Ravi Gangwal and Rohit Chaudhary, who were enemies of Hashim Baba, a North East Delhi gangster. Sources said Rohit Godara, a key member of the Bishnoi gang - who has claimed responsibility for Shah's murder - used this enmity.

To regain Dalit support, Maharashtra BJP to target Congress on reservation

Mumbai. The BJP suffered a massive setback in the Lok Sabha elections in Maharashtra, where they were accused of being 'anti-constitutional' and planning to change the Constitution. BJP leaders acknowledged that this was one of the key reasons for the backlash among Dalits and the backward classes. With just months left for the Assembly elections, the BJP is planning to counter this narrative by accusing Congress of pushing an "anti-reservation" agenda abroad, following Rahul Gandhi's remarks on reservations in the US. Leader of the Opposition in the Lok Sabha, Rahul Gandhi, during his visit to the US, told students at Georgetown University that the Congress would consider scrapping reservations when "India is a fair place," which he said it is not right now. These comments were met with massive criticism from the BJP.In Maharashtra, his statements led to statewide protests by the BJP, with party leaders condemning his remarks. BJP's Mumbai president Ashish Shelar and MLC Pankaja Munde staged a protest at Dr Ambedkar's statue in Ghatkopar, considered a stronghold of Dalit voters in Mumbai.

Ashish Shelar accused Congress of having defeated Dr Ambedkar in an election and opposing an Adivasi candidate for the Presidential post. "This shows Congress's anti-minority mindset," Shelar further charged. Additionally, Chief Minister Eknath Shinde held a program at the same location to distribute rent cheques for alternative accommodations to eligible tenants and to kick off the long-pending slum redevelopment project in Ramabai Nagar. Meanwhile, the scars of the 1997 police firing, in which ten locals were killed following a protest by Dalit activists reacting to the desecration of a statue of Dr Ambedkar in Ramabai Nagar during the then Shiv Sena-BJP alliance government, are still fresh. As a result, the Dalit community drifted away from the alliance and voted Congress-NCP back to power in the 1999 Assembly elections. Considering the complexities of the caste equation in the current political sphere, the BJP is facing challenges in retaining the support of Dalits and minorities According to political expert Abhijit

Brahmanathkar, opposition parties in the Lok Sabha elections subtly painted the BJP as 'anticonstitutional,' leading to significant losses for the BJP in SC and ST constituencies nationwide."Now, the BJP sees a new opportunity in Rahul Gandhi's recent remarks on reservations, which have sparked allegations of Congress's 'anti-reservation' stance.

Bank employees die after SUV gets stuck in submerged Faridabad underpass

A police official stated that the victims were warned about the underpass being submerged due to heavy rain in Delhi-NCR. However, the two insisted on driving through it.

Delhi. Two people, a bank manager and a cashier died after their SUV got stuck in a submerged underpass in Old Faridabad around 11.30 on Friday night.The underpass got submerged due to heavy rain in several parts of Delhi-NCR. The victims worked in a Gurugram branch of HDFC Bank and were heading to Faridabad when the incident took place.



According to one of their colleagues, the cashier was going to drop the bank manager at Greater Faridabad's Omaxe City, where the latter resided on Friday evening. The colleague claimed that no barricades were present near the underpass, due to which the victims tried driving through it. However, their car got stuck due to the extent of rainwater, leading to their deaths. He said that the bank manager's wife contacted him for

help after she found her husband's phone switched off. Upon reaching the underpass, police informed them about the tragic death of two people. He added that the incident could've been avoided had the police placed barricades, informing citizens about the submersion of the underpass.

However, a police official denied the colleague's claims that there was no barricading at the spot. He instead stated

that the police had warned them about taking the underpass, but the two insisted on going through it and removed the barricades."There was police barricading and caution boards near the railway underpass. However, the two removed the barricades and insisted on going through the underpass. Water entered their vehicle after it got stuck and locked in the underpass, leading to their deaths. We'll get to know if the two were intoxicated only after the postmortem," said subinspector Rajesh.He appealed to the public to pay heed to police warnings and instructions.

The official also urged everyone to remain cautious and adhere to police warnings and traffic regulations.

Max to buy 64% in Jaypee Healthcare

NEW DELHI. Max Healthcare (MHIL) is acquirng 64% stake in Jaypee Healthcare for an enterprise value of Rs 1,660 crore. In a regulatory filing, Max said it has entered into a strategic agreement with Lakshdeep Group, the promoter of Jaypee Healthcare Ltd (JHL) which is undergoing Corporate Insolvency Resolution Process (CIRP)This Strategic Collaboration and proposed acquisition will give MHIL a controlling stake in JHL including its flagship asset, the renowned 500-bed Jaypee Hospital, Noida. Under the agreement, MHIL will organise debt for repayment of admitted claims of the financial creditors of JHL and proposes to acquire 64% stake in the company, with call and put option for remaining stake. The acquisition includes two operational hospitals i.e. 500-bed Jaypee Hospital, Noida and 200-beds Jaypee Hospital Bulandshahr, built on land parcel of 18 acre and 5.75 acre respectively.JHL owns a 100 beds hospital spread over 2.35 acres at Anoopshahar, which is non-operational. JHL reported revenue of Rs 421 crore and EBITDA of Rs 70 crore for the year 2023-24.

Going once, going twice: Google's millisecond ad auctions are the focus of monopoly claim

ALEXANDRIA. It happens in milliseconds, ideally, as you browse the web. Networks of computers and software analyze who you are, what you are looking at and buy and sell the advertisements you see on web pages. The company that most likely determines which ads you get, and how much an advertiser paid to get on your screen, is Google.In fact, the Justice Department and a coalition of states say Google's dominance over the technology that controls the sale of billions of Internet display ads every day is so thorough that it constitutes an illegal monopoly that should be broken up.A trial under way in federal court in Alexandria, Virginia, will determine if Google's ad tech stack constitutes an illegal monopoly. The first week has included a deep dive into exactly how Google's products work together to conduct behind-the-scenes electronic auctions that place ads in front of consumers in the blink of an eye. Online advertising has rapidly evolved. Fifteen or so years ago, if you saw an internet display ad, there was a pretty good chance it featured people dancing over their enthusiasm for low mortgage rates, and those ads were foisted on you whether you were looking at real estate or searching for baseball scores.

Now, the algorithms that match ads to your interests are carefully calibrated, sometimes to an almost creepy extent.Google, for its part, says it has invested billions of dollars to improve the quality of ads that consumers see, and ensure that advertisers can reach the consumers they're seeking. The Justice Department contends that what Google has also done over the years is rig the automated auctions of ad sales to favor itself over other would-be players in the industry, and also deprived the publishing industry of hundreds of millions of dollars it would have received if the auctions were truly competitive. Government witnesses have explained the auction process and how it has evolved over the years in detail at the Virginia trial. In the government's depiction, there are three distinct tools that interact to sell an ad and place it in front of a consumer. There's the ad servers used by publishers to sell space on their websites, particularly the rectangular ads that appear on the top and right-hand side of a web page. Ad networks are used by advertisers to buy ad space across an array of relevant websites. And in between is the ad exchange, which matches the website publisher to the would-be advertiser by hosting an instant auction. Publishers naturally want to receive as high a price as possible for their ad space, but testimony at trial has shown that didn't always happen due to the rules Google imposed.

For years, Google gave its ad exchange, called AdX, the first chance to match a publisher's proposed floor price. For instance, if a publisher wanted to sell a specific ad impression for a minimum of 50 cents.

Centre lifts minimum export price cap on onion, basmati rice to boost farmer income

New Delhi The government on Friday scrapped the minimum price thresholds for onion and basmati rice to boost outbound shipments and enhance farmers' income. The government also halved export duty on onion to 20 per cent from 40 per cent. The duty cut is effective from September 14.The 40 per cent export duty had been in place since May 4. The decisions, including removal of the Minimum Export Price (MEP) on both onion and basmati rice and a cut in the export duty, came ahead of assembly elections in Maharashtra and Haryana. Haryana, along with Punjab, is the major producer of basmati rice.According to a communication from the Department of Commerce, the \$950 per tonne minimum export price on basmati rice has been removed.Commerce and Industry Minister Piyush Goyal said the move will help boost exports and increase farmers' income."It has been decided to remove the current minimum export price (MEP)

cum-Allocation Certificates (RCAC) for export of Basmati Rice", the communication said. The APEDA (Agricultural and Processed Food Products Export Development Authority) has been requested to take immediate action to implement the decision, and it will also closely monitor export contracts for any non-realistic prices for basmati exports.In October 2023, the government reduced the floor price for basmati rice exports to \$950 per tonne from \$1,200 per tonne amid concerns that higher prices were hurting outward shipments. The government on August 27, 2023 decided not to allow exports of basmati rice below \$1,200 per tonne to restrict possible "illegal" shipment of white non-basmati rice in the garb of premium basmati rice. India's total exports of basmati rice stood at \$5.9 billion in 2023-24.During the 2022-23 fiscal, basmati rice exports stood at \$4.8 billion in terms of price, while in volume terms it was at 45.6 lakh tonnes. As per the Foreign Trade Policy, APEDA is



mandated to register all contracts for the export of basmati rice and issue the registration-cum-allocation certificate for the export of basmati rice. The basmati crop is grown in the kharif (summersown) season. In another farmer-friendly decision ahead of the assembly election in Maharashtra, the directorate general of foreign trade (DGFT) removed the MEP on onion with immediate effect.In May this year, the government lifted the ban on onion exports but had imposed a \$550 per tonne as the minimum export price (MEP), which essentially meant farmers

could not sell their produce overseas at lower than this rate."The Minimum Export Price (MEP) condition on the export of onions is removed with immediate effect and until further orders," the DGFT said.India exported 2.6 lakh tonnes of onions till July of this fiscal year. The country had exported 16.07 lakh tonnes of onions in the last fiscal. The decision to remove the MEP on onion has been taken

despite high retail prices of this key kitchen item. According to the data compiled by the Department of Consumer Affairs, the All-India average price of onion on Friday was Rs 50.83 per kg, while the modal price was Rs 50 per kg. The maximum price of onion was Rs 83 per kg and the lowest was Rs 28 per kg.On September 5, the Centre began the first phase of retail sales of onion at a subsidised rate of Rs 35 per kg to provide relief to Delhi-NCR and Mumbai consumers from rising prices of the

MUMBAI. The Indian Renewable Energy Development Agency (IREDA) will be opening its IFSC unit shortly that will help the greenenergy-focused public sector financier mop up funds at much cheaper rates and thus lower its loan prices, a top official has said.

The IREDA had a runaway success in the capital market when it got listed last November and the shares have rallied more than sevenfold.

We hope to get permission to open a unit in Gift City at the International Financial Services Centre (IFSC) in Gandhinagar in the next two to three months. Once the permission is in we aim to complete the process very shortly," Pradip Kumar Das, chairman and managing director, told TNIE. "Once we open the unit, we will tap all sorts of bonds, primarily green and social bonds from there. Given our latest S&P ratings, we are confident we can raise funds at a much lower rate now,"Das also said, the discussions with the government on stake dilution are at an advanced stage, wherein it wants the government to pare up to 10 per cent. This will give at least Rs 4,500 crore of equity capital to the company, he added. Govt To Start Satellite-based Toll Collection Soon, Here's How It Will Work

NEW DELHI. The Government of India has approved the satellite-based toll system. After the new toll system is fully implemented, you will not need to stop at the toll plaza and pay the toll; rather, the toll will be paid automatically when you come in the range of the satellite. Preparations are underway to introduce some vehicles with on-board units (OBU) next week for testing the new toll system. The onboard unit (OBD) unit will work like a tracker device that will send your vehicle's signal to the satellite. After the implementation of the new toll system, the existing RFID-based FASTag system will be completely abolished. The main feature of the new toll system is that the help of a satellite or a group of satellites will be taken to monitor the movement of vehicles. The toll or user fee will be fixed based on the exact distance of the journey. The Ministry of Road Transport and Highways amended the NH fee rules earlier this week to allow toll collection using a satellite-based toll collection system. According to the information, Indian satellite NavIC will be used to implement the new toll system. Currently, some vehicles will be run with



on-board units for testing the new toll system, but let us know how long you will have to install it in your vehicle.

Fracking devices will be pre-installed in vehicles:For the satellite-based toll system to work, it will be mandatory to install on-board units in vehicles. in 15 months, and 50,000 km in two years. For this, the highway-owning agencies of the central government have completed geo-fencing of almost the entire length of national highways. Geofencing is important to mark accurate entry and exit points for the purpose of toll calculation. The total length of national highways in India is about 1.4 lakh km, out of which tolls are collected


