Arvind Kejriwal to resign as Delhi CM in 2

New Delhi, Sep 15: Delhi Chief Minister Arvind Kejriwal on Sunday said he would resign in the next two days. "I did not enter politics to play the game of politics and money. I will go to the public and ask them what do they think: am I an honest man or an accused," he said. He said the next CM would be decided after a meeting of party MLAs. He said that along with him, Sisodia will also go to the public and he will also not be vying for the CM's post. "Some people say that we will not be able to work because of restrictions imposed by the Supreme Court. If you think I am honest, vote for me in large numbers. I will sit in the CM's chair only after being elected," he added. The Delhi CM called for early election in Delhi in November along with other state assembly elections. "The elections are supposed to be held in February. I demand that these be held in November with the Maharashtra elections," he said. "Why did they (BIP) send me to jail? They know very well that I haven't committed any corruption. Their goal was to break AAP and crush my spirit. They thought that by sending me to jail, the party would fall apart and they could form a BJP government in Delhi. But our party didn't break. AAP is standing strong against their conspiracies," he added. Chief Minister Arvind Kejriwal's unexpected announcement to resign after two days kicked up a strong buzz on Sunday over the

names of his wife Sunita and his ministers Atishi and Gopal Rai as his possible replacement. Kejriwal, who was earlier this week released on bail from the Tihar

Jail in the excise policy graft case, said that he would

hold a meeting of the AAP MLAs in the next couple of days and a party leader would take over as the chief minister. The chief minister addressing the Aam Aadmi Party (AAP) leaders and workers at the party headquarters here made the announcement to resign and hold the post again only after he was given a "cer-

tificate of honesty" by the people of Delhi. He said that people should vote for him in the Delhi Assembly polls early next year if they thought he was honest, otherwise not. Kejriwal also ruled out the second

biggest leader of the AAP and former deputy chief minister Manish Sisodia as his replacement, saying he will also not hold the post unless given clean chit by the people of Delhi. Although there was no official comment from the AAP on the new chief minister after Kejriwal's resignation, sources said the CM's wife Sunita Kejriwal could be a potential candidate for replacement in the post. A party functionary said when the chief minister was arrested by the Enforcement Directorate (ED) on March 21, Sunita Kejriwal played a crucial role in the AAP's campaigning for the recent Lok Sabha polls in Delhi, Gujarat and Haryana. However, another senior AAP leader

claimed that an MLA of the party will become the new chief minister. Kejriwal said the name of the next chief minister will be decided in a meeting of the party MLAs on Tuesday. The potential candidates for the chief minister's post also include the names of ministers Kailash Gaĥlot and Saurabh Bharadwaj.

Anil Vij says he wants to be Haryana CM if BJP wins elections

New Delhi, Sep 15: Notably, Anil Vij remarks come at a time when the party has already made it clear that Nayab Singh Saini will be the CM if the BJP returns to power. Former cabinet minister and Bharatiya Janata Party (BJP) MLA Anil Vij demanded on Sunday that he be made the chief minister of Haryana if his party wins the upcoming assembly elections. Notably, the sixtime MLA's remarks come at a time when the party has already made it clear that Nayab Singh Saini will be the chief minister if the BJP returns to power. "I am the senior-most MLA of BJP in Haryana. I have contested elections for 6 times. On the demand of people, I will claim for the designation of CM on the basis of my seniority this time," Anil Vij said. "However, it is in the hands of high command whether they will make me CM or not. If they make me the CM I will change the picture of Haryana." VP Dhankar slams Rahul Gandhi for reservation remark

New Delhi, Sep 15 In the US, Rahul Gandhi said India can think of scrapping the reservation system only if it becomes a "fair place" providing equal opportunities to all Indians. Reacting to Rahul Gandhi's alleged remark on 'ending' the system of reservations in education and employment, Vice President Jagdeep Dhankar said on Sunday that such comments by a person holding a constitutional post shows his "anti-con



stitutional mindset". "A person from a constitutional post saying on a foreign land that reservation should be ended underscores the same anti-constitutional mindset. The baton of prejudices against reservation tional mindset," he said while addressing a public event in Mumbai, reported PTI. Hitting back at Dhankar, Congress party spokesperson Pawan Khera asked whether he agrees on Gandhi's demand to increase the ceiling limit on reservations. "Mr Rahul Gandhi has demanded removal of the 50% limit on reservations for SC/STs & OBCs. Do you support this demand of the Congress, Mr @VPIndia?," asked the Congress leader on X. The Rajya Sabha Chairman also said that creating awareness about India's constitution is the need of the hour as some people have forgotten its soul. "Reservation is not against meritocracy, but it is the soul of the country and the Constitution. It is an affirmative action and not negative. It is not depriving someone of opportunity but handholding those who are pillars of strength of the society," Dhankar added. At a conversation during his recent visit to the United States, the Leader of Opposition said India can think of scrapping the reservation system only if it becomes a "fair place" providing equal opportunities to Indians from every section of the society. The ruling BJP alleged that Rahul Gandhi wanted to 'scrap' the system immediately and his remark showed the Congress party's "anti-reservation" mindset. Home minister Amit Shah and defence minister Rajnath Singh alleged that Rahul Gandhi was standing with forces "conspiring to divide India".

Gunfight with terrorists in J&K's Kathua

New Delhi, Sep 15: A gunfight erupted between security forces and terrorists in the Bani area of Kathua district, Jammu and Kashmir, following intelligence reports. A joint operation by the police and Indian Army led to an exchange of fire after contact was made with the terrorists. The area has been cordoned off, and efforts to neutralize the threat are ongoing. The incident follows the killing of three terrorists in Baramulla the previous day, described as a significant success ahead of upcoming assembly elections. New Delhi, Sep 15: Rahul Gandhi had sparked a row with his remark in the US, alleging that Sikhs might not be allowed to practice their religious faith freely Union minister Ravneet Singh Bittu on Sunday lashed out at Lok Sabha leader of opposition Rahul Gandhi over the latter's remarks in the United States. Bittu, who quit Congress and joined the Bharatiya Janata Party (BJP) ahead of the Lok Sabha elections this year, called the Congress leader as the "number one terrorist". "Rahul Gandhi is not an Indian, he has spent most of his time outside. He does not love his country much because he goes abroad and says everything in a wrong way. The people who are most wanted, seperatists, experts in making bombs, guns and shells, have appreciated what

Rahul Gandhi has said," ANI quoted Bittu

as saying. Gandhi had sparked a row over his remark on Sikhs in the United States, alleging that the members of the commu-



nity might not be allowed to practice their religious faith freely. "The fight is about whether he, as a Sikh, is going to be allowed to wear a turban in India; or whether, he, as a Sikh, will be allowed to at Bittu, saying,

wear a kada in India; or whether he, as a Sikh, is allowed to go to a Gurudwara. That's what the fight is about, and not just

for him, but for all religion," Gandhi had said. Gandhi's remark triggered a political storm with the BJP accusing him of defaming the country. BJP 'wants to bury' Kashmir issue, Article 370: Mehbooba Mufti

Sri Nagar, Sep 15 Three days before the first phase of assembly elections in Jammu and Kashmir, former chief minister Mehbooba Mufti on Sunday accused the BJP of 'trying to bury' both the Kashmir issue and the matter of



Article 370 abrogation. "We are contesting (the election) because the BJP wants to bury the Kashmir issue and Article 370. It (BJP) wants everyone to talk only about the election," Mufti told reporters in Kulgam, according. The PDP chief, who was the last

CM of Jammu and Kashmir before it lost statehood and became a Union territory, also asserted that her party was 'adamant' that resolving the Kashmir issue was 'very important.' "It is a matter of shame for the BJP that has been saying that the situation has improved (in J&K), but they could not hold elections here in the last 10 years. People are annoyed... they want a government that addresses their concerns," she said. An ex-ally of the PDP, the BJP has been the country's governing party since May 2014. In August 2019, the central government abrogated Article 370 that gave 'special status' to Jammu and Kashmir. Meanwhile, Mufti promised permanent employment for daily wagers if the PDP was elected to power. She also assured efforts will be made to bring multi-national companies to the Valley.

Engineer Rashid's AIP joins forces with leaders of banned Jamaat-e-Islami for J&K polls

Sri Nagar, Sep 15: The leadership of both AIP and Jamaat-e-Islami have called upon their cadres to spread the message of support for each other's candidates. The Awami Ittehad Party (AIP), led by Lok Sabha MP Sheikh Abdul Rashid, also known as Engineer Rashid, has entered into a strategic alliance with former members of the banned Jamaat-e-Islami (JEI) ahead of the upcoming Jammu and Kashmir assembly elections "A joint meeting was held today in which the AIP delegation was led by AIP Supremo and chief spokesperson Inam Un Nabi, while the IEI delegation was led by Ghulam Qadir Wani. Prominent JEI members participated in the discussions," the AIP said in a statement. The Jamaat-e-Islami, banned by the Indian government under anti-terror laws in 2019, saw its ban extended for another five years earlier this year. Despite this, several former JEI leaders are contesting the assembly elections as independent candidates, supported in part by this new alliance with AIP. An AIP spokesperson said the alliance was formed in the larger interest of the region's population, aiming for a "resounding victory" for AIP and JEI-backed candi-

dates. The alliance will see AIP backing JEI candidates in key districts like Kulgam and Pulwama, while JEI will reciprocate by supporting AIP candi-



dates in other constituencies. In areas where both parties have fielded candidates, including Langate, Devsar, and Zainapora, a "friendly contest" has been agreed upon. "Both parties underscored the importance of unity in resolving the Kashmir issue and promoting a lasting and dignified peace in the region. "They highlighted the rapidly evolving political landscape, both regionally and internationally,

and stressed that neither JEI nor AIP can afford to remain passive observers," the spokesperson said. Earlier in the day, Sheikh Rashid, who was granted interim bail to campaign for his party, refuted allegations of being a proxy for the BJP, asserting that his electoral success in the general elections was a reflection of the public's sentiments against the Modi government's 'Naya Kashmir' initiative. Rashid said those labelling him as a BJP proxy should be "ashamed of themselves," as he considers himself the only mainstream leader to have faced persecution from the ruling party. "The people who accuse me of being a BJP proxy should feel ashamed. I am the only one who was victimised by the BJP. While Omar and Mehbooba were kept in SKICC for several months during the abrogation, I was

the only MLA jailed in Tihar," he said. "He (Abdullah) could neither become (Mahatma) Gandhi nor Subash Chandra Bose and same way Mehbooba neither became (queen) Razia Sultan nor Aung San Suu Kyi of Myanmar.



Area sabha meetings not held as per norms in Chennai, RTI reveals

CHENNAI: Two years have passed since the state government mandated the conduct of area and ward sabhas every three months across all urban local bodies (ULBs). However, a recent RTI response obtained by the NGO Voice of People (VoP), in which only 126 out of 663 ULBs responded, 86% reported holding meetings only between one and four times per ward over the past two years."Instead of consolidating responses from all ULBs under their (respective) jurisdiction, these departments redirected the RTI queries to individual ULBs, thereby evading accountability," said VoP member Charu Govindan. Despite requesting information from all 15 zones, RTI responses were received from only zones 1, 2, and 12. Each ward should have 4 to 10 area sabhas, meaning 16 to 40 area sabha meetings every year. The responses suggest only six provided meeting minutes. According to regulations, area sabha meetings are scheduled quarterly. Charu said that while officials initially assured holding area sabhas from January 1 to January 24, and a ward sabha on January 25, many ULBs are not following the practice including in the GCC. The report suggests that government should mandate ULBs to hold quarterly meetings, and maintain meeting records in the public domain. "Conducting all area sabhas within three months is challenging because of recurring public issues; like road repairs, may not be resolved in that timeframe," a councilor told TNIE.

Two college faculties booked for asking girl to consume liquor in TN's Tirunelveli

Actor abduction case: Witness examined for 109 days, longest in Kerala

KOCHI: In a landmark trial, the investigation officer in the 2017 actor abduction and rape case involving film star Dileep underwent witness examination for 109 days at Ernakulam District Principal Sessions Court. This may be the longest witness examination in Kerala, if not India. The prosecution witness examination, which began in January 2020, concluded on Friday. Baiju Paulose, DySP of Kerala Anti-Terrorist Squad (ATS) and the investigation officer, was the 261st and final prosecution witness.Baiju's examination started on January 4 this year. The Special Prosecutor conducted the chief examination for 19 days. The eight other accused's advocates crossexamined him for one day, followed by



Dileep's counsel's cross-examination, which lasted over 80 days."It might be one of the longest cross-examinations in the entire country. I can confidentially say that in Kerala Police's history, there has been no case in which a police officer was cross-examined for such a

long duration. Mostly the examination of the investigation officer lasts a couple of weeks. I assume that in Dileep's case, a lot of digital evidence was collected during the investigation stage. The records related to the witness examination of Baiju Paulose on

Wayanad landslides: Two sites chosen for rehabilitating survivors

KALPETTA: Steps are in progress to finalise a place for permanent resettlement of Wayanad landslide victims. Out of 29 places considered in the district, two are in the final list. The plots are located in Kalpetta municipality and Muppainad panchayat. If the government gives sanction, the authorities will start procedures to acquire the land. The collector said that efforts are being made to complete the rehabilitation as soon as possible. Distribution of financial aid to disaster victims is also progressing.

Latest trend: cyber Fraudsters buy crypto from swindled money

BENGALURU: With cybercrimes on the rise, police investigating these cases have identified a new trend in investment frauds where stolen funds are converted into cryptocurrency to evade detection. While layered money transfers are a common practice in cybercrimes, fraudsters are increasingly using digital currencies such as crypto, which are much harder for authorities and bank officials to trace. Once the money is converted into cryptocurrency, it is transferred across numerous accounts and wallets, often internationally, making it extremely difficult to track and recover.Till July 2023, only 26 investment fraud cases had been reported, resulting in losses of Rs 1.69 crore. However, this year till July, an alarming surge, with 143 cases leading to a staggering loss of Rs 42.35 crore was

One such recent case was reported in Bengaluru Rural CEN police station involving a 33-year-old man who has been working as an insurance agent and stock market investor for over 10 years. To make the investment, the victim borrowed money from relatives and sold his property, expecting a 500% return, only to be swindled out of everything. The victim lost more than Rs 1.2 crore to the insurance or investment fraud. The scam started with a WhatsApp message containing an 'app link' and continued for 46 days.

During this time, the victim invested Rs 1.2 crore, lured by the false promise of receiving more than Rs 60 crore, as indicated in the app's wallet balance. After making continuous investments, the victim attempted to withdraw the money from the wallet, but the application failed to respond and all access to the link and the app was promptly shut down. Counterfeit visa factory dismantled in Delhi's Tilak Nagar, 6 apprehended

NEW DELHI: The Delhi Police's IGI Airport unit has dismantled a sophisticated counterfeit visa manufacturing facility in Tilak Nagar, apprehending six accused agents in the process.

According to sources, the cladestine factory was engaged in producing fraudulent Schengen visas, and authorities have recovered 14 Nepalese and 2 Indian passports bearing counterfeit visas. The police have also confiscated an array of equipment employed in the creation of these fake visas, including stamps and watermark materials.

The apprehended individuals are suspected to be members of an extensive syndicate implicated in passport and visa-related crimes. The police are diligently investigating the scope of the syndicate's operations and the number of individuals affected by their illicit activities.A press conference is slated for today at 12 noon at the DCP/IGIA Office Complex, where the DCP, IGI Airport, will provide the media with a comprehensive briefing on the operation. This crackdown constitutes a notable achievement for the Delhi Police, underscoring their unwavering commitment to combating passport and visarelated crimes. The investigation remains ongoing, with further developments anticipated in the near future.

Candidates' aides come to blows at Fbd election office

Gurgaon. A scuffle broke out outside the election and registration office in Ballabgarh on Thursday when the Congress candidate, Parag Sharma, arrived to file her nomination.Supporters of former MLA Sharda Rathore, who is contesting as an Independent after being denied a ticket, allegedly snatched the nomination papers from Sharma's brother's hand, which led to the clash. Police lodged an FIR against unidentified individuals on Saturday. Sharma alleged that one of the assailants was Rathore's brother.On Thursday, when Sharma arrived at the office to file her nomination with her brother Vaibhav and party members, around 15 people who were standing at the gate — including Rathore's brother and her supporters — snatched the papers from Vaibhav's hand. Following this, a scuffle broke out between the two groups, despite the presence of police at the gate. Police intervened and escorted both Sharma and Rathore to the office."The incident occurred around 2.45pm when I was entering the main gate of the office while my sister was filing her nomination papers inside. She had half of the papers with her and I had the other half. The assailants stopped me at the gate and began physically assaulting me. During the altercation, they forcibly snatched important documents from me and ran off towards the road. Sharda Rathore, the Independent candidate, was sitting in a black Mahindra vehicle nearby, and her brother was in the group of assailants," said Vaibhav, who is an advocate, like his sister. The entire incident was captured on video, which Sharma has promised to provide to the authorities.

He was unable to file the complaint on the day of the incident due to ill health, he said. The assailants not only assaulted Sharma and snatched his documents but also threatened to kill him, he alleged."An FIR has been registered at the City Ballabgarh police station under sections 115 (physical assault), 126 (wrongful restraint), 304 (snatching, forcibly stealing) and 351 (2) (criminal intimidation) of BNS. The cops deployed at the office intervened in time and the candidates were able to file their nomination. The assailants were prevented from causing further harm. The case is under investigation," a police spokesperson said.

14 cos found dumping trash by road, MCG ends contract

Gurgaon. MCG has ended contracts with 14 private agencies which were hired to assist bulk waste generators (BWGs) with waste management.

The agencies were de-empanelled for dumping inert waste at garbage vulnerable points instead of transporting it to the designated waste collection centres across the city.

"Despite multiple directions in various meetings, you have failed to provide the required information as demanded by this office, such as the quantity of inert being dumped to secondary collection points. You have to take permission for off-site composting, but no permission has been taken by you. It has been reported by the SSIs that no inert reaches the secondary collection points, which shows that you are dumping waste at VPs. These non-compliance issues have not only disrupted the smooth execution of sanitation services but have also contravened the environment. Such conduct also creates adverse remarks towards the MCG office too. As a result, MCG has no option but to terminate the empanelment agreement with you effective immediately," read the order issued by MCG joint commissioner Swachh Bharat Mission Akhilesh Yadav. The agencies were informed that they could challenge the order within 30 days by submitting proof of their work. However, they alleged that MCG was moving forward with the deempanelment without any evidence. A representative of one of the agencies claimed that the de-empanelment was being done for the benefit of another private agency. "This is also being done to benefit a private agency that has got the door-to-door waste collection and transportation contract, so that our work is assigned to that agency," the representative said. In March, MCG had hired 15 private agencies for technical support and guidance to the BWGs of the city. The agencies were put into three categories. Agencies under the first category, who were in charge of the BWGs that manage dry, wet, and hazardous waste, were de-empanelled on Friday.

What's on candidates' lips Gurgaon's public health services

Gurgaon. Public health has become the talking point of candidates in the city this election season. Gurgaon district, which has four assembly constituencies -Gurgaon, Badshapur, Sohna, and Pataudi

contributes more than 70% to the state govt's revenue. The city has several world-class private hospitals catering to patients from across the world but lacks a govt trauma centre and has only one govt hospital operational at present — the Sector 10 Civil Hospital. The high cost of treatment at private facilities is beyond the means of a majority of people, forcing them to go to govt hospitals in Delhi or other cities for affordable treatment.

The city is in dire need of a trauma centre. According to health department data, due to the lack of a trauma centre here, 35% of patients who come to the emergency ward of Sector 10 Civil Hospital are referred to Delhi every month. Most of these patients have injuries from falls, road accidents, and head injuries. Approximately 110 or more patients are referred every day. Every year, more than 400 people die in road accidents in Gurgaon. Candidates in the electoral fray have now picked up public health services as a talking point and included them in their promises to

draw votes. During his public outreach campaigns, Badshapur BJP candidate and former minister Rao Narbir Singh has often highlighted that the public is unable to get treatment in pvt hospitals in the city. 'People have to go to Delhi and other cities for treatment. If BJP forms govt, I will

build four new hospitals for the general

public so that everyone can receive treatment in the city," he recently said. The demand for better public health services is not new. Rao Narbir Singh, while serving as a minister in the Manohar Lal Khattar-led cabinet in 2014, had recommended to then Union health minister JP Nadda to open a trauma centre

in Gurgaon. Ten years later, no work has ever been carried out on that plan.

Gurgaon Congress candidate Mohit Grover has also raised the issue of delay in the construction of a civil hospital and the lack of govt health facilities. "Health services for all are crucial for development and welfare of the people," said Grover.Suman, a Nathupur resident who works as a domestic staffer, said healthcare is a major concern for those who can't afford the exorbitant fees charged by private hospitals.

We can't afford treatment in big private facilities. Making trips to Delhi for treatment badly affects our daily earnings and disrupts our work," she said. Though Gurgaon has witnessed an alarming population surge in the past decade, healthcare facilities and infrastructure have not kept pace. A large chunk of the population can't

afford treatment in private hospitals. As a result, over 2,000 patients visit the outdoor department of the Sector 10 Civil Hospital daily, which is struggling to meet the demand. Construction of the Civil hospital in Civil Lines, meanwhile, is sexpected to start by the end of the year.

Woman slips on flooded road & hits ATM shutter; electrocuted

GURGAON. Two employees of a private bank died after getting trapped inside their SUV when they allegedly ignored warnings by police and entered a flooded underpass in Old Faridabad late Friday night.

Viraj (26), a cashier with HDFC Bank in Sector 31 of Gurgaon, had offered to drop his manager, Punyashreya Sharma (45), at his Faridabad home because of persistent rain through the day. Around 11.30pm, Viraj attempted to accelerate his XUV 700 through the flooded underpass, unwilling to make a detour of several kilometres.

As the vehicle reached the middle of the underpass, water started to gush in through the gaps.Realising the SUV wouldn't move ahead, the two even tried to come out, but the doors were jammed.Passersby rushed to their rescue and pulled Viraj out after almost 20 minutes. He was rushed to a nearby hospital, where doctors declared him dead on arrival. But Sharma could not be traced till 4am. He had died by the time rescuers pulled him out of the

cops deployed near the underpass had signalled at the two bankers against going ahead, but they chose to bypass the warnings."We had our cops deployed on the spot, and they even signalled to the two men inside the SUV to stop as the underpass was flooded. But they did not pay heed,



even waved their hands at the cops to tell them they would manage," said Yashpal Sharma, a spokesperson for Faridabad police."The underpass was under 6-7ft of water. At one point, they realised they couldn't navigate through and tried to escape. But they couldn't open the vehicle's doors despite repeated attempts. Passersby and cops pulled the bodies out," he added.

While Viraj was from Sector 28 in Gurgaon, manager Sharma lived in Omaxe BPTP in Faridabad. Viraj was supposed to spend the night at Sharma's house as it was quite late.

Sharma's wife tried reaching him on his phone, but the calls did not go through. After trying for an hour or so, she set out to find him along with a few neighbours. One of Sharma's neighbours accused the authorities of negligence, denying there was any cop or barricade to warn them about the flooded underpass.

There were no cops or barricades on the stretch. Police claimed they had warned locals about the waterlogged underpass a number of times. But how would others know? The man driving the car was not even from Faridabad. He was unlikely to have gauged the depth of the water. Even if there was a diversion in place, there was no sign or barricade to alert

commuters. If this isn't negligence of

authorities, what is," he asked TOI.

Big focus on sanitation workers during this year's 'Swachch Hi Seva' campaign



NEW DELHI. Single window health camps to ensure better quality of life to sanitation workers and their family members is one of the key elements of this year's 'Swachhata Hi Seva campaign starting September 17.

To honour the "everyday heroes" and to recognise their efforts, the Centre has asked district authorities across states and Union Territories (UTs) to set up preventive health checkup camps during the two-week long drive.

All workers — either a direct employee, contracted, or outsourced by local bodies to carry out key 'swachhata' functions such as road sweeping, door to door collection of waste from households, mechanical de-silting of sewers and septic tanks — will be benefitted from the initiative, said officials. Besides Personal Protective Equipment (PPE) kits, protective gears will be provided to sanitation workers to safeguard them from occupational hazards.

While briefing at the curtain raiser event of the campaign, Union Minister for Housing and Urban Affairs Manohar Lal said that in the camps, the sanitation workers would be helped in enrolling various social welfare schemes being run by the government.

Because our Swachhta Sipahis (sanitation warriors) are involved in a work that affects their wellbeing, health camps will be organised to carry out check-ups for them. If any treatment is required, it will be ensured. How can their economic status and lifestyle be improved? How can they benefit from various government schemes? This will also be ensured," said the minister. The theme of this year's campaign is 'Swabhav Swachhata Sanskaar Swachhata (4S) 2024'. As part of the initiative, the Centre has also planned to clean and transform about two lakh 'dirty and difficult' garbage spots or sites such as tourist places and water bodies.

Israel military says missile fired from Yemen, sirens sounded across cities

Jerusalem. A surface-to-surface missile fired at central Israel from Yemen hit an unpopulated area, causing no injuries, Israel's military said on Sunday. Moments earlier, air raid sirens had sounded in Tel Aviv and across central Israel, sending residents running for shelter.

"Following the sirens that sounded a short while ago in central Israel, a surface-tosurface missile was identified crossing into central Israel from the east and fell in an open area. No injuries were reported", the military said. Loud booms were also heard in the region, which the military said came from missile interceptors that had been launched. It added that its protective guidelines to Israel's residents were unchanged.In July, Iran-aligned Houthis in Yemen fired a long-range drone at Tel Aviv, killing one man and wounding four others. The attack prompted Israel to carry out a major air strike on Houthi military targets near Yemen's Hodeidah port, killing at least three people and wounding 87.

Mexico's Sinaloa state witnesses 19 homicides in 5 days as violence grips state



Mexico City Mexican authorities logged seven homicides in the western state of Sinaloa on Friday, the latest violence to plague an area where increasingly frequent shootouts are fueling fears of the possible start of an intra-cartel war. The deaths bring the number of killings within the week to 19, after 12 killings were registered between Monday and Thursday. The Sinaloa prosecutor's office in a statement late on Friday said the latest victims were found in four separate locations. Two people were killed in the capital of Culiacan, and five in the municipality of Concordia, both of which the statement described as places "where violent events have occurred between criminal groups."Sinaloa, on the Pacific Coast, is the home base of the powerful Sinaloa Cartel, a drug gang once led by kingpin Joaquin "El Chapo" Guzman, who is now serving a life sentence in the US.

The July arrest of another veteran gang leader, Ismael "El Mayo" Zambada, has stoked fears of infighting and turf battles. The prosecutor's office also said on Friday it received eight reports in Culiacan of men who had been kidnapped.In Culiacan, businesses have closed, public transportation has been cut back and Independence Day festivities have been canceled due to the worsening violence.

Tropical Storm Ileana makes landfall on Mexico's Sinaloa coast after pounding Los Cabos

MEXICO CITY. Tropical Storm Ileana made landfall on the coast of the Mexican state of Sinaloa Saturday a day after it pounded the resort-studded Los Cabos.

The tropical storm formed Thursday off Mexico's Pacific coast and was packing winds of 40 mph (65 kph) as it moved ashore Saturday, the Miami-based National Hurricane Center said. It made landfall near the coastal city of Topolobampo and was located late Saturday about 15 miles (25 kilometers) south-southeast of Los Mochis.

Forecasters say Ileana will churn over the coastal region of northern Sinaloa during the next several hours and then move over the Gulf of California roughly parallel to the coast on Sunday, weakening into a tropical depression. On Friday, a warning had been in effect for portions of the Baja California Peninsula, including Cabo San Lucas and San Jose del Cabo. Juan Manuel Arce Ortega, from Los Cabos Civil Protection, said the municipalities of La Paz and Los Cabos had suspended classes in schools due to the storm.

Authorities prepared 20 temporary shelters in San Jose del Cabo and Cabo San Lucas, according to Los Cabos Civil Protection.

At the Hacienda Beach Club and Residences in Cabo San Lucas, valet worker Alan Galvan said the rain arrived late Thursday night and has been constant. "The rain isn't very strong right now, but the waves are choppy," he said.

"The guests are very calm and already came down for coffee," Galvan said. "There's some flights canceled but everything is ok at the moment."The rain remained consistent through Los Cabos Friday afternoon, with several roads flooded and some resorts stacking up sandbags on their perimeters. Some people were still walking around boat docks with their umbrellas."The priority has to be safety, starting with the workers. We always have to check on our colleagues who live in risk areas," said Lyzzette Liceaga, a tour operator at Los Cabos.

Post-Hasina Bangladesh gravitates towards Urdu and Jinnah

World In a nation where Bangla was a central pillar of its independence movement against Pakistan, it came out as an unmissable irony when the 76th anniversary of the death of Muhammad Ali Jinnah, the founder of Pakistan, was celebrated with Urdu poetry and songs in Bangladesh's Dhaka. This was the first time in Bangladesh's history that Jinnah's death anniversary was commemorated in Dhaka. Speakers also said that without Jinnah, Bangladesh wouldn't exist. The unusual tribute came on Wednesday, a month after the military-led interim government took over following former PM Sheikh Hasina fled after massive student protests, hijacked by the Pakistanbacked BNP and Jamaat.

While the event marked a rejoice for some, Urdu, Jinnah and Pakistan are still engrained in the bloody memory of the minds of a section of its people. Some experts saw this as an attempt to rewrite history.

JINNAH COMMEMORATED AT DHAKA PRESS CLUB

The 76th death anniversary of Pakistan founder Muhammad Ali Jinnah was marked at the National Press Club in Dhaka on Wednesday, with a gathering of speakers, Urdu poetry recitations, and musical performances, reported Bangladeshi news outlet Dhaka Tribune.

The event, organised by the Nawab Salimullah Academy at the Tofazzal Hossain Manik Miah Hall, was where several speakers emphasised Jinnah's crucial role in the creation of Pakistan, stating that without him, "Bangladesh too would not exist."While the Pakistani High Commissioner to Bangladesh was expected to attend as the chief guest, he was notably absent. Instead, Deputy High Commissioner Kamran Dhangal represented Pakistan at the event in Bangladesh, where millions were killed, thousands were raped in a Pakistan-devised genocide, until its independence in 1971.

As early as 1952, East Pakistan saw protests advocating for Bangla to be recognised as a co-official language, used in government, education, media, currency, stamps, and to retain its script. The protests saw a heavyhanded crackdown by the West-dominated, Urdu-imposing Pakistani regime.

Dozens were killed in police firing in the pro-Bangla language movement, and five of them have been recognised as martyrs by the Bangladesh government.

On Wednesday, Professor Mostafizur Rahman presented a keynote paper that traced the milestones of Jinnah's life. Jafarul Haq Jafar,

meanwhile, paid tribute by reciting an Urdu

poem about Jinnah, and Pakistani students Mohammad Tahir and Kamran Abbas performed Urdu songs dedicated to him. These performances took on added significance in the context of Bangladesh, where the Bengali language once resisted Pakistan's attempts to impose Urdu as the national language. The president of the academy, Muhammad Abdul Jabbar, presided over the event, reported Bangladeshi news outlet Dhaka Tribune.In a controversial statement, Md Samsuddin said that without Pakistan, Bangladesh might have suffered the same fate as Kashmir, with India "holding weapons to our necks." He credited Jinnah's efforts for not only the

creation of Pakistan but also for enabling Bangladesh's eventual independence. "If we hadn't been part of Pakistan in 1947, Bangladesh wouldn't exist today," he said, adding that the removal of names of like 'Allama Iqbal Hall' or 'Jinnah Avenue' in Dhaka University campus, were decisions driven by New Delhi's interests, not Bangladesh's own.A speaker, Nazrul Islam, echoed similar sentiments, saying, "Jinnah is the father of our nation, but we do not acknowledge it. We must preserve our brotherhood with Pakistan.'

POST-HASINA JINNAH TRIBUTE, IS DHAKAREWRITINGHISTORY?

The celebration of Jinnah's legacy in post-Hasina Bangladesh —a nation whose very language was central to its struggle for independence from Pakistan — presents a curious juxtaposition. Moreover, Pakistani misadventures in East Pakistan until 1971, turned out to be the darkest chapter of South Asian history.

Cookie poll' predicts Trump leading against Kamala Harris in Pennsylvania state

World A local bakery in Pennsylvania, a key swing state in the US, is sweetening the 2024 Presidential race by offering customers a unique way to show support for their candidate — through cookies. The bakery's owner, Kathleen Lochel, has created a buzz with her red cookies for Donald Trump and blue cookies for Kamala Harris. Each sale is tracked as part of an unofficial "cookie poll" that has drawn national attention. A swing state in US elections is a state where both major political parties have similar levels of support, making it critical in determining the overall election outcome.Lochel has been regularly updating her bakery's followers on social media, announcing earlier that her political cookies had sold out for the weekend. By Friday morning, Trump cookies were leading in sales, with 5,200 sold compared to just 500 Harris cookies."I think people support Trump all over," Lochel told Fox & Friends First, highlighting that almost all of her Pennsylvania orders were for red cookies. "We've only shipped seven blue packages in Pennsylvania.'

Lochel stated that her customers are voicing their frustration over how high costs under the Biden-Harris administration are impacting them.

"A lot of people are upset right now about the cost of things, they're venting to us," she stated.

This is not the first time that the bakery has hosted the cookie poll. Lochel began the tradition in 2012, correctly predicting the winner of three out of four elections. However, her streak ended in 2020 when more Trump cookies were sold, despite Joe Biden's victory.Lochel attributes the idea to brainstorming during the challenges brought on by the Covid-19 pandemic. Since then, her cookie poll has expanded, with customers across the US placing orders. "A third of that number is being shipped across the United States," she said, adding that people often share their frustrations with the current economic situation. Despite the competitive nature of the poll, Lochel stresses that her bakery remains neutral. "We love all," she said As of this week, Vice President Kamala Harris has taken a five-point lead over Republican nominee Donald Trump in the latest national polls.

Venezuela arrests US, Spanish, Czech nationals over 'destabilisation' plot

UPDATED. Three Americans, two Spaniards and a Czech citizen were detained in Venezuela on suspicion of plotting to destabilise the country, the government said Saturday, as the United States denied Caracas's allegations it was involved. The arrests come amid heightened tensions between Venezuela and both the United States and Spain over Venezuela's disputed July 28 presidential election, which the country's opposition accuses President Nicolas Maduro of stealing.Interior Minister Diosdado Cabello said that the five foreign nationals were being held on suspicion of planning an attack Maduro and his government.We know that the United

Typhoon Yagi kills 74 in Myanmar, search ops on for 89 missing people

Bangkok The death toll in Myanmar from flooding and landslides caused by Typhoon Yagi has reached at least 74, with 89 people missing, Myanmar's state television said

Difficulties in compiling information have raised fears that the number of casualties may be higher. The new official death toll announced by the country's military government was more than double the 33 reported on Friday. Typhoon Yagi earlier hit Vietnam, northern Thailand and Laos, killing more than 260 people and causing major damage. The new totals were announced after state media reported that Senior Gen. Min Aung Hlaing, the head of the ruling military council, said that Myanmar was requesting relief aid from foreign countries. Nearly 240,000 people have been displaced, according to the reports. There were already 3.4 million displaced people in Myanmar at the beginning of

September, according to the UN refugee agency, mostly because of war and unrest in recent years.In Myanmar, low-lying areas in the central regions of Mandalay and Bago, as well as eastern Shan state and the country's capital, Naypyitaw, have been inundated by water since Wednesday.Min Aung Hlaing and other military officials inspected flooded areas and reviewed rescue, relief and rehabilitation efforts in Naypyitaw on Friday, the state-run Myanma Alinn newspaper reported. Its report said that

he instructed officials to contact foreign countries, as other countries affected by the storm did, to receive rescue and relief aid for the victims."It is necessary to manage rescue, relief and rehabilitation measures as quickly as possible," he was quoted as saying.

The exact extent of the damage still wasn't clear, but there were fears that the death toll may rise sharply. Local news outlets

reported more than 100 people missing. Efforts to tally casualties and damage and provide relief are complicated. Myanmar is in a state of civil war that began in 2021, after the army seized power from the elected government of Aung San Suu Kyi. Independent analysts believe the military controls much less than half of the country's territory. Myanmar experiences extreme weather virtually every year during the

monsoon season. In 2008, Cyclone Nargis killed more than 138,000 people. In that case, the military government then in power delayed accepting international assistance, and when it finally relented, tightly controlled its distribution, with little or no oversight by aid donors. Saturday evening's state television news said that 24 bridges, 375 school buildings, one Buddhist monastery, five dams, four pagodas, 14 electrical transformers, 456 lampposts and more than 65,000 houses were damaged by floods in central and eastern parts of the country. Naypyitaw is one of the areas that was hit hardest by the floods. Myanmar's Eleven Media group reported on Friday that record rainfall had damaged several pagodas in Bagan, the country's ancient capital that is a Unesco World Heritage site. The rain, said to be the heaviest in 60 years, collapsed walls at several centuries-old old temples, it News box

The public can also call the corporation helpline number 1533 for their complaints.Suralkar Vikas Kishore, Special Commissioner Health, Sanitation and Animal Husbandry, said, "The animal husbandry department is taking steps to control the population of stray dogs and rabies in a scientific and effective manner. For the control of stray dogs in all zones under the corporation, the sterilisation surgery programme is being carried out, as per the directives of the Supreme Court, and as per the guidelines of Pet Dogs Rules - 2023 of the Indian Animal Welfare Board."

Vaccine will be administered to protect stray dogs from rabies. The programme is progressing in all sectors to create awareness among the public about neutering of stray dogs, rabies vaccination campaign and measures to be taken in the case of culling of dogs, the official said.

CBI busts global cybercrime network, seizes 57 gold bars; arrests 1 in Mumbai

Mumbai. The CBI has busted an international cybercrime network and arrested an alleged accused from Mumbai, officials said on Saturday. The accused, Vishnu Rathi, was arrested in connection with the CBI's Operation Chakra-3, carried out against cybercriminals in coordination with the USA's Federal Bureau of Investigation (FBI).According to officials, the network has been targeting victims in foreign countries since 2022, with their operations involving cryptocurrencies and bullion.

In a latest such incident, Rathi allegedly duped a US citizen of approximately Rs 3.8 crore (USD 453,953) by posing as a technical support agent. The CBI conducted multiple raids over the last two days in connection with the case, during which the agency seized 57 gold bars of 100 grams each, Rs 16 lakh in cash, a mobile phone, a laptop used to manage cryptocurrencies, and details of lockers from Rathi's premises.A case was registered against the accused and others on September 9 for allegedly targeting a US citizen by gaining unauthorised remote access to the victim's computer and bank account in 2022. Under the pretext of offering tech support services, they falsely informed the US-based victim that her bank account had been compromised. Claiming the funds were at risk, they allegedly manipulated the victim into transferring Rs 3.8 crore to cryptocurrency wallets controlled by them, according to the CBI.

Searches were conducted by the CBI at seven locations across Mumbai and Kolkata on September 12 and 13. Further operations are ongoing to identify other victims and proceeds of the crime, officials added. The CBI is coordinating with the FBI and law enforcement agencies in multiple countries through Interpol to follow up on leads.

Clashes erupt in UP's Mahoba after stone pelting during Ganesh idol procession

Mahoba. A clash broke out between two communities in Uttar Pradesh's Mahoba district after stones were allegedly pelted at devotees during a Ganesh idol immersion. According to the allegations, buckets of water and stones were thrown at



the devotees while they were proceeding for the immersion through the Muslimdominated City Kotwali area. This led to a clash between the two communities.

Angered by the incident, Hindu organisations created chaos outside the police station, demanding action.Similar incidents were reported from other parts of the country. In Bihar's Rafiganj, tension prevailed when members of one community allegedly raised slogans against another during a Ganesh idol immersion procession.In Gujarat's Surat district on September 9, some minors reportedly threw stones at a Ganesh pandal, leading to the arrest of seven people in

connection with the incident. On September 7, stones were allegedly thrown at a Ganpati procession in Madhya Pradesh's Mochipura, resulting in violent protests

Tree of life: A nourishing tale of second innings

PUDUCHERRY: Beneath the scorching sun, where the sands of Pondy Marina glisten like gold, D Anandan, whose hands are calloused from nurturing plants, stands as a silent guardian in front of a banyan tree.The 55-year-old man from Pooranankuppam in Puducherry is not just a caretaker of trees - he is their saviour, their voice, and the one who breathes life into their roots once again.On that sunny day, he was inspecting the banyan tree he transplanted from Auroville, where trees were being uprooted for development work a few years ago. It was not an isolated act, in fact, he has given life to 45 trees that were either cut down or uprooted.

For Anandan, who works as the manager at Perunthalaivar Kamaraj Krishi Vigyan Kendra (PKKVK), love for nature is not just a fleeting hobby but a lifelong calling. His journey began in 2013, two years after winds of Cyclone Thane swept through Puducherry. For most, the aftermath was a blur of debris, but for Anandan, it was the heart-wrenching sight of countless trees, toppled and broken, that stirred him to action. "It was heartbreaking to see the trees that once lined our streets reduced to

debris," he recalls. And so, he embarked on a mission, one rooted in hope and nourished by his resolve, to revive trees. Yet, like many noble causes, the road was not smooth. His initial attempts at transplantation were fraught with



disappointment. "At first, I transplanted all kinds of trees, but many died. It was disheartening," he recalls. After consulting botany experts, he learned that certain trees-particularly banyan and peepal—have a better chance of survival when transplanted. Armed with this knowledge, Anandan refocused his efforts, on saving trees threatened by both human actions and natural calamities. "It costs between Rs 15,000 and Rs 20,000 to

transplant a single tree, and it requires manpower," says Anandan. More often than not, he digs into his own pockets to cover the expenses, though he occasionally receives donations from volunteers and private sponsors.

With the help of these volunteers, Anandan has planted over 700 trees in Puducherry town alone. He also plants saplings along roadsides for residents, sometimes offering his services for free or charging only for fencing.But perhaps the most enduring symbol of his work is the palm tree - the state tree of Tamil Nadu and a representation of its cultural and ecological identity. Since 2016, Anandan has earned the moniker 'Panai Anandan' for his relentless campaign to preserve and promote panaimaram. He has sown

lakhs of palm seeds across Tamil Nadu and Puducherry, working tirelessly to raise awareness about the tree's importance. "The palm tree is like the peacock, our national bird. Cutting it down should be treated as a serious offense," he says. He laments that it wasn't until 2021 that a law was introduced requiring permission to fell

BJP expels Tamil Nadu functionary over leak of businessman's apology video

Chennai. A BJP functionary in Tamil Nadu was expelled from the party following the leak of a video showing a businessman apologising to Union Finance Minister Nirmala Sitharaman, which went viral this week, sparking controversy.BJP's Singanallur Zonal President, Satish, was expelled for anti-party activities a day after the party's Tamil Nadu unit chief apologised for the video.Two videos surfaced recently, one of which shows the owner of the Annapoorna chain of restaurants, Srinivasan, purportedly voicing concerns over varying GST rates. In the second video, Srinivasan is seen allegedly apologising to the Finance Minister.The Congress and DMK, who widely shared the video, criticised the BJP, calling it an act of "arrogance" and claiming that Srinivasan was forced to apologise. Bangalore Blue grapes turn juicy for farmers

BENGALURU: The demand and availability of grapes is now all year round. Improved pruning patterns and change in weather patterns have helped in achieving this. Of all the grape varieties, Bangalore Blue is the most sought after. The Geographical Identification-(GI) tagged variety has seen a rising demand from Kerala, Maharashtra and Tamil Nadu, forcing the state government to regulate its trade. Not just the searing demand, but soaring temperatures too are worrying agri-scientists and farmers. Well-known expert on fruits and retired horticulture department officer SV Hittalmani said the grape variety is named after the state capital because of the city's climatic conditions. The dark blue grape needs a cool climate and ideal temperature hovering around 36-37 degrees Celsius for it to get that deep colour.

But the recent spike temperature in April and May affected the crop, making the grapes either pinkish or reddish. To keep its original colour, farmers are now consulting experts and scientists.Additional Director, Horticulture (Fruits), KB Dundi, said, "95% of the crop is used for juice making. The demand is from Bengaluru, Kerala and Tamil Nadu. It has grown substantially, especially in the last two years. Some of the produce is also sent to distilleries. At the moment, the market is unorganised. But farmers' produce organisations are being strengthened to avoid middlemen." Managing Director, Karnataka Wine Board, Somu T, said there is a 5 per cent year-on-year increase in the production and sale of Bangalore Blue. There is demand from distilleries in Maharashtra too.Hittalmani said Bangalore Blue is grown in abundance in Bengaluru Urban and Rural, Devanahalli, Chikkaballapur, Kolar, Sidlaghatta and surrounding areas.

Three more palliyodams to add glitz to Uthrattathi regatta in Kerala

PATHANAMTHITTA: This season, three stunning new palliyodams have joined the iconic snake boat fleet, used for the annual water processions of Uthrattathi Jalamela and Valla Sadhya in the Pampa river. Palliyodams are a symbolic representation of Lord Parthasarathy. These snake boats are Parthasarathy's 'Palli Kollunna Odam' (resting boats) and were made to look like Sheshanaga, the serpent on which Lord Vishnu rests. As these iconic

boats age, they are replaced or even exchanged among regions (karas). According to boat experts, they can last up to 60 to 100 years with proper maintenance. Skilled traditional carpenters from Vishwakarma families craft these expensive boats, valued between Rs 55 lakh to Rs 1 crore today. Varying from the traditional 'Chundan Vallam,' palliyodams have steep elevation on both ends and resemble a curved 'U". In a symbolic way, four



amarakkars (captains) of the boat represent four Vedic scriptures and the eight singers represent "Ashtadik palakanmar." As many as 64 oarsmen represent 64 arts."As many as 52 boats, including 34 belonging to NSS, funded by residents of various regions (Kara), will participate in the water carnival this time. Among the new three, one palliyodam belongs to Chakkamar Mahasabha," K V Sambadevan, president, Palliyoda Seva Sangham, a collective of snake boats,

National interest, balance of power continue to reign supreme

DURING a recent dialogue on 'A Global Order in Churn: Seeking Solutions' and their implications in the contemporary strategic context, a stray reference to two books written in the early and mid-1990s prompted a think.

These books were The End of History and the Last Man (1992) by American political scientist Francis Fukuyama and The Clash of Civilisations and the Remaking of World Order (1996) by Samuel P Huntington.Fukuyama's book was a sequel to a 1989 article that he wrote in a magazine called National Interest a couple of months before the collapse of the Berlin Wall. He argued that "What we may be witnessing is not just the end of the Cold War, or the passing of a particular period of post-war history, but the end of history as such: that is, the end point of mankind's ideological evolution and the universalisation of Western liberal democracy as the final form of human government...

Essentially, what he argued was that the Western liberal and democratic model would be the default option of the global order in the years and decades ahead.On the other hand, Huntington argued in his book that the epoch of ideology had reached an inflection point, and thereafter, humankind would regress into an age delineated by cultural conflict all over again. In his hypothesis, he argued that, henceforth, the primary axis of conflict would be along cultural trajectories.He postulated that the template of diverse civilisations as the pinnacle of cultural distinctiveness would evolve into a progressively efficacious matrix in analysing both the potential for conflict and the genesis of actual conflict. In a 1993 Foreign Affairs article, he prophesised about 'the clash of civilisations' by submitting that "This is not to advocate the desirability of conflicts between civilisations. It is to set forth descriptive hypothesis as to what the future may be like."Both Fukuyama and Huntington were gazing into the crystal ball, trying to predict the ebb and flow of historical and Westphalian impulses in shaping the post-communist world order that had led to a unique situation of unipolarity in international affairs, with the US emerging as the only hegemon after the dismemberment of the Soviet Union, the collapse of its Eastern European satellite states that brought about an end to 'bloc politics' that had characterised the post-World War II global

lmost three decades later, how did both these seminal treatises measure up in predicting the train of global events since their publication in the 1990s. This becomes especially relevant at a point in time when, after the end of World War II, humankind is witness to a three-continent conflict playing itself out concurrently. These battles are the Russia-Ukraine War that began in February 2022, the Israel-Hamas conflict that broke out in October last year and the rise of China over the past three decades that has attained portentous overtones in large parts of the world beyond the immediate Chinese realms in North Asia, Southeast Asia and South Asia.

Rewinding to September 11, 2001, when semi-state actors put the only omnipresent hyper power in the world, the US, on notice by crashing passenger-filled jet liners into the World Trade Centre, liberal democracy certainly has not emerged as the global choice. The events of 9/11 ned a new chapter in global affairs, wherein the 'war on terror' became the new buzzword to invade nation-states that were tyrannical in their disposition but by no stretch of imagination directly involved in the events that took place on that tragic September morning in New York. The invasion of the Taliban-controlled Afghanistan, codenamed Operation Enduring Freedom, on October 7, 2001, was not a clash of civilisations but a tactical attempt to get even with the masterminds of 9/11, namely the Osama bin Laden-led Al-Qaeda that had.

BJP can't afford to take Jammu for granted

THE national highway from Jammu to Kathua is drive home simple 'before' and 'after' messages between 2014 - when the former state last voted, to the situation today - when the Union Territory goes to the polls again in a few days, after a whole decade.

Dark images of smoke, flailing hands and burning cars on one side of the hoardings have been juxtaposed with bright, shiny pictures that hope to symbolise hope and prosperity. A photo of Prime Minister Narendra Modi, central to the BJP's advertising campaign, is splashed right across the frame.Matam-Swagatam. Dar-Nidar. Shanti-Ashanti. And then the line, "shanti, sthirta aur vikas/Jammu ko Modi par vishwas." Peace, stability and progress. That's why Jammu believes in Mo

The big question, of course, is whether Jammu will believe in Modi as well as the BJP's local candidates staking their claim to 43 constituencies in this large and unwieldy region south of the Pir Panjal - although these Assembly elections are being fought for the first time in an altered, rejigged landscape after the recent delimitation of constituencies added six more seats to the region. Another five candidates will be nominated to the new Assembly - making up a total of 95 MLAs, compared to 87 before.Saam. Daam. Dand. Bhed. In this part of the world, where the international boundary with Pakistan is within spitting distance, all of Chanakya's ancient wisdom that bespeaks endearment, bribery, punishment and betraval are certainly being employed by all political parties to win the affections of the people. had constituted a reassurance to the Muslim-majority Kashmiri population which had chosen to reject the two-nation theory by rejecting Pakistan and acceding to India - that they would be safe in a Hindu-majority India.


Mookerjee's death stirred the RSS-BJP into making the abrogation of Article 370 part of its core ideology, but the debate would soon, more or less, falter into history. The rest of India had so much else to do. There it would lie, unclaimed, until Modi, in August 2019, decided to permanently banish the argument. Article 370 was abrogated because the RSS-BJP believed that Hindu-majority Jammu deserved better than to play second fiddle to the Kashmiri Muslim elite that was predominant in the Valley.Jammu had

always held up its side of the bargain. It celebrated on the streets when Article 370 was revoked - in contrast, as we all know, the Valley was shut down, the Internet was shut down, protests were disallowed and political leaders arrested.

That's why the coming elections, hard-fought on the ground, constituency by constituency, mohalla by mohalla, village by village, are so important. Will Jammu give the BJP what it wants - enough seats it can use as a lever to negotiate a return to power in the newly refurbished Jammu & Kashmir? Or will it have to settle for less, with the region telling its mentors to go back and play by different rules. To bury Article 370 forever, but to also reach across the ideological divide and join the Valley and Plains together. To bridge the Himalayan gap. To recharge the whole of Jammu & Kashmir.

Chip challenge

Competitive field makes India's task tough



chain, is the global numero uno. Among the other leading nations are South Korea, Japan, the US and China. The

Covid-19 pandemic slowed down the manufacture of semiconductors, particularly in Taiwan and China. Amid these large-scale disruptions, India got its foot in the door by launching the ISM (India Semiconductor Mission) in 2021. A critical lesson from the pandemic was that the global supply chain should be diversified.

India is eyeing a bigger piece of the pie, but the road ahead is going to be anything but easy. Even as Asian nations are wooing investors with incentives, the US is projected to triple its domestic semiconductor manufacturing capacity by 2032, a decade after the CHIPS and Science Act was enacted. Beyond the optimism and hyperbole, India needs to set clear-cut timelines for achieving its goals. Ease of doing business holds the key to attracting long-term investments. India's semiconductor ecosystem is no doubt at an early stage, and there should be no reluctance to learn

from other countries' experience.

The wall between judiciary, executive must not fall

Our expectations of good conduct are far higher for judges than for politicians. Politicians can and do get away with things much more easily.

IMAGES are as powerful as oral messages, often more so. One can play with words, retract or deny. A picture, however, is a plain reflection which captures the moment. Just like Omar Khayyam's phrase "the moving finger writes and having writ moves on", so too can one say that "the picture has been clicked and once clicked the subjects cannot move out".

Many comments have been made on the photograph of Prime Minister Narendra Modi participating in Ganpati Puja at the residence of Chief Justice of India DY Chandrachud. It is likely that this arose from a polite invitation which was responded to, and the heads of the executive and the judiciary conducted themselves with propriety when they met. It is unlikely that any conversation would have transpired which should cause us alarm. Nevertheless, the dust does not settle easily, and perfect equanimity does not attend this image. There is a constitutional distance that must be maintained between the judiciary and the executive; the doctrine of separation of powers creates a wall between the two. Checks and balances are the stuff of democracy, but they are to be had only if the parties stand some distance apart and not chummily close to each other. In a democracy, the judiciary is the watchdog, the sentinel on the qui vive. It is the guardian and enforcer of the Constitution; it tempers the mighty State and makes it responsive to the plea of the hapless citizen. All this implies an elevation and a distancing; only if these two are there can we have the picture of the one who does not spare the rod when the other gets out of hand.

Judges and ministers are not supposed to be friends. There have been earlier instances when prime ministers have spoken of cordial relations between the executive and judicial branches and have been promptly corrected by Chief Justices, who pointedly referred to the need for a certain tension between the



government and the court and the constitutional requirement of the latter acting as a check on the former. Only thus is the constitutional balance maintained. The problem is one of precedent. Granted that there was no lack of a good motive on the part of the inviter and the invitee, yet the test to be applied is how this would look on a larger, repetitive scale. Would we feel comfortable if ministers and judges freely mix with one another at religious functions? And then why stop at religious functions, why not social functions too? Let's not get into private dinners. Once the line breaks, the natural order of things is that it will break again and again. More than anybody else, judges are aware of the power of precedent. One breaks the ranks and accepts to become a governor virtually under the Home Ministry, and lo and behold, after several years, another does, and this time there is less protest, Good conventions require much effort in their making, but the reverse is true of breaches, as in a dyke, one breach will occasion several more.

The problem is also one of perception. The judiciary is no stranger to the axiom that justice must not only be done but must be seen to be done. Similarly, the separation of powers involves barriers and distancing and this must be seen to be erected and to exist not just in the performance of official functions but every moment. Conformity to convention will not draw comment, but dissonance will get magnified. That is why those holding high offices must be particularly circumspect in the public imagery that they send forth. Ultimately, in these things, it is not for the high

and mighty to be satisfied that nothing is amiss. We must come lower to meet the eyes of the common man. The law affords a particular place of importance to this person who has no real shape (save in RK Laxman's drawings) but comes alive in the books of law. He represents the public at large, those whose good opinion one must secure for governance to be said to be good. If one pictures this little man, can one see him sanguine or would we see him perplexed and a little troubled on seeing this photograph? That's the simple test, and at the end of the day it is this test that matters. There are critical comments about the Chief Justice having invited the Prime Minister, but surely the PM also has the duty to uphold conventions and respect propriety. That said, it is the judiciary which is more damaged if the contact is looked at askance. This is because our expectations of good conduct are far higher for judges than for politicians. Part of the reason we surrender to them the power of deciding between right and wrong is because they are upholders of right, convention and propriety.

Politicians can and do get away with things much more easily; what would occasion the raising of eyebrows with respect to a judge will not cause a flicker with respect to a politician. Society needs these fine upholders of high values - and these values - to be on constant display. There is no need for excessive criticism or alarm and one should not read too much into this incident; yet, it is best if everyone learns a cautionary lesson from it. Our codes of conduct can be written, but it is in observance that the tone is set and the lesson ingrained. Of legal luminaries Motilal Setalvad and CK Daphtary it was said that when they were around, there was no need for a code of conduct; one had to just ask what they would have done in the circumstances. That is what we require today of our men and women holding high judicial offices.

To do this, use an angled brush (if you are using a shadow) or a pencil colour and apply it on your brows, without straying too far from your natural hair line. If you have a bigger spot to be filled, it is best to use an eyebrow pencil. Apply thin and light strokes in the direction that your hair grows.

Do not use tweezers too often



Tweezing your eyebrows more often will make them thin. If you have unwanted hair growth and wish to get rid of that, it is always best to go in for a threading than tweezing and taking out that hair. Punjab Police managed to arrest the first suspect, Rohan Masih, on September 13, just two days after the blast. The second accused, Vishal Masih, son of Sabi Masih and a resident of

Raimal village in Batala, District Gurdaspur, was arrested within 72 hours of the incident.

Investigations are ongoing as officials work to unravel the full details of the plot. The main

perpetrator of the suspected Chandigarh grenade blast case, Rohan Masih, was arrested a day after the incident in which the grenade was lobbed at the house of a retired police officer in the city's upscale Sector 10

area. The grenade attack took place at around 5.30 pm on September 11 and due to the impact of the blast, windows and flower pots were

Sources told India Today TV that three people arrived at the scene in an autorickshaw shortly before the explosion. The blast was loud enough to be heard even from far away.

According to the sources, the attackers had conducted surveillance of the house just two days before the grenade attack.A CCTV camera captured the moment when the explosion occurred. In the footage, an autorickshaw is seen speeding away, narrowly dodging a

car from the oppsite direction before making a swift turn. According to the sources, Khalistani terrorist Rinda, currently based in Pakistan, is suspected of involvement in the grenade attack case.

SpiceJet Cancels Flight Just 5 Minutes Before Boarding, **Sparks Outrage And Protests** At Delhi Airport

Kashmiri Samiti president Sameer Chrungoo questioned the Central government's actions over the past 11 years to alleviate the suffering caused by "forced

cancellation of her certificate by the Kendriya Sainik Board (KSB) in August 2024. The cancellation was

later acknowledged to be a mistake, as Assam Rifles personnel, under whose service Malik's father was awarded the

medal, fall under the purview of the Ministry of Home Affairs (MHA), not KSB.Consequently, she approached the HC challenging DU's decision denying her a seat.

"Women Judges Need To Be Tougher Because...": Justice Hima Kohli

New Delhi: Justice Hima Kohli (retired), who has always been vocal about women's rights and is considered a tough judge, recently retired from the Supreme Court. In an exclusive conversation with NDTV, Justice Kohli spoke on a range of issues from her long experience in the legal profession. Women judges need to be tougher because they face more difficulties in the judiciary. It was very difficult to become a woman judge back in the 1980s. Women also face many difficulties in advocacy," Justice Kohli told NDTV. She was the ninth woman judge in the history of the Supreme Court, and the first woman judge in the Delhi High Court.

Justice Kohli has been known as a tough judge, and has absolutely abhorrent. They face problems in working on women's rights. Explaining some of the difficulties that women face, Justice Kohli said first and foremost they have to take care of family and children. "Why should only women judges run family courts, child welfare, etc? Gender bias as far as bench composition is concerned is



been part of many historic decisions, with a focus on criminal cases... First-generation lawyers face the biggest challenge as they do not have any resources, office or anyone to handle files," she said."A woman choosing to be a lawyer was difficult in itself. While judicial officers had it easier to make it to the bench, Women judges should get jurisdiction in other areas too... going to the bench from the bar was more difficult for a woman lawyer," Justice Kohli told NDTV."How well

you handle any situation could determine if you reach there. As a judge, I never had a problem with my colleagues. Senior peers were quite supportive," she

She asked the public to keep their trust in the Supreme Court as judges listen to their conscience. Though there have been controversial cases, it is only natural for judges to make mistakes sometimes as they are also human, Justice Kohli said. She praised the use of virtual hearings as it has enabled justice to reach the homes of the common people directly.On professionalism, Justice Kohli said it is important for judges to see everyone equally. "Whatever kind of relationship you have with someone outside, you should not cross the line. Mutual relations should not come in the way of work. As judges, we have to look only at the merit of the case and not the face," Justice Kohli said. She pointed at the need for judges to be aware of what's happening in today's world and not to stay disconnected. "Judges should know the problems of the common people.

Adani Wins Bid to Supply 6,600 MW of Electricity, Rs 4.08/unit Tariff Beats JSW, **Torrent: Report**

New Delhi Adani group has won a bid to supply 6,600 MW of bundled renewable and thermal power to Maharashtra for the long term after its quote of Rs 4.08 per unit beat the likes of JSW Energy and Torrent Power, sources said.Its bid for the bundled renewable and thermal energy supply for 25 years was almost a rupee lower than the cost at which Maharashtra currently procures electricity and will help meet future electricity requirements of the state, two sources with direct knowledge of the matter said. Supplies are to start in 48 months from the date of award of the letter of intent.

As per the bid conditions, Adani Power will supply solar power at a fixed cost of Rs 2.70 per unit throughout the entire supply period, while that from coal will be indexed to coal prices.

Maharashtra State Electricity Distribution Company (MSEDCL), in March, floated a unique tender for sourcing 5,000 MW of electricity generated from sunlight and 1,600 MW of power generated from coal. That tender was floated just ahead of the model code of conduct for the Lok Sabha elections kicking in, and it was awarded to Adani before the announcement of the assembly elections in the state. The tender combined solar power with thermal electricity to meet peak energy demand and that during non-solar hours (like night hours or monsoon/winter months).

It gave equal energy weightage to electricity generated from renewable energy and that from coal. Bidders were asked to quote a unified tariff for the supply of 6,600 MW of electricity (5,000 MW from solar and 1,600 MW from thermal). Adani Power quoted Rs 4.08 per unit to win the contract, according to sources said.

Its bid compares to Rs 4.36 per unit quoted by the second lowest bidder, JSW Energy, and Rs 4.70 per unit average procurement cost of Maharashtra last year.

Nayara Energy Sees 14% Rise in Domestic Fuel Sales, **Exports Drop**

New Delhi Nayara Energy, India's largest private fuel retailer, posted a 14.3 per cent rise in fuel sales for the second quarter of the 2024 calendar year, while exports dropped as the firm met rising local demand for fuel. In the April-June quarter, Nayara sold 75 per cent of all diesel it produced at its Vadinar oil refinery in Gujarat in the local Indian market and 60 per cent of its petrol production locally, Nayara said.

Over the past few years, Nayara Energy has steadily built its domestic business while expanding its fuel retailing network strategically to underserved markets that uphold the potential to fuel India's growth. Retail diesel sales rose 14 per cent to 2.08 million tonnes in April-June from 1.82 million tonnes a year back, while institutional business' year-on-year growth was 23 per cent, Nayara said.Similarly, retail petrol sales grew 14.7 per cent to 0.916 million tonnes in the second quarter compared to 0.809 million tonnes a year back.Nayara Energy owns the largest private retail network with over 6,500 petrol pumps across India. Its retail network is fully automated (99 per cent of petrol pumps) for enhanced controls and standards, enhancing mobility and connectivity within our nation. The firm said over the last few years, it has strategically expanded its network, with almost 35 per cent of its fuel stations situated in Tier 3, 4 and 5 towns, enabling mobility and spurring commerce.

"Nayara Energy's positive sales momentum is the reflection of its growing presence through the strategic expansion of our fuel retail network," it said.

After fulfilling domestic demand in India, surplus products were exported by Nayara Energy – about 1.36 million tonnes (28 per cent of total sales), including jet fuel, diesel and others, during April-June 2024.

The market capitalisation (mcap) of ICICI Bank surged Rs 29,662.44 crore to Rs 8,80,867.09 crore.

Tata Consultancy Services (TCS) added Rs 23,427.12



crore taking its valuation to Rs 16,36,189.63 crore. The mcap of Hindustan Unilever soared Rs 22,438.6 crore to Rs 6,89,358.33 crore and that of HDFC Bank zoomed Rs 22,093.99 crore to Rs 12,70,035.77 crore.

The market valuation of Infosys climbed Rs 17,480.49 crore to Rs 8,07,299.55 crore and that of ITC rallied Rs 15,194.17 crore to Rs 6,42,531.82 crore

Amazon, Flipkart and major smartphone brands face antitrust heat: Report

NEW DELHI. The convenience of online shopping has changed the way we buy products, but it has also raised questions about fair competition. Amazon and Flipkart, along with major smartphone brands like Samsung and Xiaomi, are now facing antitrust scrutiny, reported news agency Reuters. The Competition Commission of India (CCI) has found that these companies have been involved in exclusive product launches on their platforms, which may have restricted competition and harmed smaller businesses.Samsung, Xiaomi, and other smartphone makers have allegedly colluded with Amazon and Walmartowned Flipkart to launch products exclusively on their platforms, a violation of India's competition laws. A report by the CCI, as seen by Reuters, highlights that this practice not only hurt smaller players but also gave an unfair advantage to certain sellers and products.

The CCI's investigation into Amazon resulted in a 1,027-page report, which claims that the Indian units of Samsung,

Xiaomi, Motorola, Realme, and OnePlus were involved in exclusive phone launches in coordination with Amazon and its affiliates, breaking competition laws.Similarly, a 1,696-page report on Flipkart states that brands like Samsung, Xiaomi, Motorola, Vivo, Lenovo, and Realme engaged in similar practices on Flipkart's platform. The involvement of major

smartphone brands in this case could lead to increased legal and compliance issues for them. G.V. Siva Prasad, the additional director general of the CCI, noted that exclusivity in business goes against free and fair competition and is not in the best interest of consumers.

Although these findings are not yet public, Reuters was the first to report the accusations of anticompetitive behaviour by these smartphone companies, which are detailed in the CCI's reports dated August 9. While Xiaomi declined to comment, other smartphone makers, Amazon, Flipkart, and the CCI have not



responded to requests for comments so far.The reports from the CCI also mentioned that Amazon and Flipkart attempted to downplay the allegations, but the investigation found that exclusive launches were quite common on both platforms. This practice has been a concern for years, with small retailers arguing that their businesses have been harmed as customers preferred shopping for exclusive models online.

Counterpoint Research data shows that Samsung and Xiaomi together hold nearly 36% of the Indian smartphone market, with Vivo holding 19%. India's e-

commerce sector is growing rapidly, with the market expected to reach over \$160 billion by 2028, up from Rs 57-60 billion in 2023, according to consultancy firm Bain. The findings of the investigation could be a significant blow to Amazon and Flipkart, especially in India, a key market where they have already faced criticism from small retailers. The CCI report also

noted that these e-commerce giants used foreign investments to offer discounted services like warehousing and marketing to select sellers, further tilting the playing field. Some smartphone makers, including Xiaomi, Samsung, OnePlus, Realme, and Motorola, have been instructed to submit their financial statements for the past three fiscal years to the CCI, according to a document from August 28. This move is part of the ongoing investigation, which started in 2020 following a complaint by an affiliate of the Confederation of All India Traders, a retailer association representing 80

US Fed Might Cut 50 bps Stock Market to Focus on US Interest Rate **Decision This Week**

New Delhi Even as the markets hit all-time high last week on Thursday, the Indian equities market the coming week will focus on the US Fed's interest rate decision on Wedensday. Apart from this, a host of macroeconomic data from the global front and trading activity of foreign investors will also be focus areas, according to

The Indian equity market had an exceptional last week, with both the Nifty and Sensex hitting their all-time high levels on Thursday. The BSE benchmark breached the 83,000 level for the first time on Thursday."One of the most anticipated events of the year is set to unfold this week with the US Federal Open Market Committee (FOMC) meeting scheduled for September 18th. It is almost certain that this will mark the beginning of an interest rate cut cycle in the US. The general consensus is for a 25 basis points (bps) rate cut, though some market participants are speculating a more aggressive 50 bps cut. Such a move would be a significant positive trigger for global markets, particularly for emerging markets like India, as it would likely result in a weaker dollar and lower US yields, spurring foreign inflows into Indian equities," said Santosh Meena, Head of Research, Swastika Investmart Ltd.Additionally, Japan's inflation data is due on Friday, followed by the Bank of Japan's (BoJ) monetary policy announcement, he said. "In addition to this, other crucial factors that will influence market sentiment include FII (Foreign Institutional Investors) flows, the geopolitical landscape, and crude oil prices," Meena added.

"The outlook for the market will be guided by the major domestic and global economic data such as India's WPI inflation, US industrial production, US Fed interest rate decision, US FOMC economic projections and US initial jobless claims," Palka Arora Chopra, Director, Master Capital Services Ltd, said.

Last week, the BSE benchmark jumped 1,707.01 points or 2.10 per cent and the Nifty climbed 504.35 points or 2.02 per cent. "Looking ahead, this week will be critical with the US Fed meeting scheduled, and its outcome expected on September 18. Domestically, participants will be closely monitoring WPI inflation data and foreign fund flows," said Ajit Mishra – SVP, Research, Religare Broking Ltd.V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said, "A significant trend in the market for the week ended 13th September is that FIIs were buyers of equity in the cash market on all days of the week." There are two reasons why FIIs have changed their strategy from selling to buying, he noted.

FPIs Inject Rs 27,856 Crore in Equities in September 2024 So Far on US Rate Cut Expectations

New Delhi Foreign investors have infused Rs 27,856 crore in domestic equities in the first fortnight this month, owing to the resilience of the Indian the potential interest rate cut in the US. Foreign Portfolio Investors (FPIs) have been consistently buying equities since June. Before that, they pulled out Rs 34,252 crore in April-May.

With the focus shifting to the US Federal Reserve's decision on interest rates in its upcoming FOMC meeting next week, its outcome will likely play a pivotal role in shaping the trajectory of future FPIs investments in Indian equities, Himanshu Srivastava, Associate Director- Manager Research, Morningstar Investment Research India, said. According to the data with the depositories, FPIs put in a net investment of Rs 27,856 crore into equities this month (till September 13). With this, FPIs' investment in equities reached Rs 70,737 crore so far this year. VK Vijayakumar, Chief Investment



Strategist, Geojit Financial Services, has attributed two major reasons for FPIs' strong buying. First, there is a consensus now that the US Fed will start cutting rates from this month onwards, pushing the US yields down.Recent data showing US inflation cooling for the fifth consecutive month, hitting a 43-month low of 2.5 per cent year-on-year in August, has strengthened expectations that the US Federal Reserve may proceed with a rate cut at its upcoming policy meeting. This will facilitate fund flows from the US to emerging markets. Secondly, the Indian market is

extremely resilient with strong momentum and missing out on the Indian market would be a bad strategy for FPIs, he added. High valuations in robust inflows are due to underlying factors such as global confidence in India's economic outlook and the government's commitment to drive a long-term growth story. Weighing the costs of renting

Renting provides flexibility and lower upfront costs, which is ideal in today's fast-moving job market. For example, a young professional in Bengaluru might rent a 2BHK in Whitefield for Rs 25,000 per month instead of buying a house worth Rs 80 lakh. This choice allows flexibility in career mobility and also frees up capital for other investments.

The biggest advantage of renting is that it requires much less financial commitment. Monthly rent payments are usually lower than the EMIs for a home loan, making renting a more affordable option, especially in metro cities where property prices are high. For example, in

cities like Mumbai, where the house price-to-rent ratio is very high, renting is often the smarter choice. However, renting has its downsides. Rent payments increase by 10% every year, and at the end of the rental period, you don't own the property. Over the long term, renting can feel like spending without building equity, especially in areas where property appreciation is strong.

Buying a home provides long-term financial security and ownership of an asset that typically appreciates over time. A family in Pune, for instance, might buy a Rs 60 lakh apartment and watch its value grow, creating equity over the years. While homeownership comes with additional costs like property tax, maintenance, and repair, the appreciation in value can make it a good long-term investment. For instance, property prices in prime areas of Gurgaon have risen over 150% in the past ten years. An apartment bought for Rs 70 lakh in 2013 could now be worth Rs 1.75 crore, offering substantial appreciation.

Owning a property also provides an additional income stream through rental yields, though rental returns in India are typically low at 2-3%. Still, this can help offset some costs.On the flip side, homeownership involves high upfront costs, including a down payment, and



monthly EMIs that are often higher than rent payments. For instance, buying a Rs 2.5 crore property with a Rs 50 lakh down payment would result in an EMI of around Rs 2.5 lakh per month at a 9% interest rate. Over 10 years, this amounts to about Rs 3 crore in payments, but the property's value could appreciate to Rs 4.6 crore, making it a valuable asset for

Understanding price-to-rent ratio

To make an informed decision, it's crucial to compare the price-to-rent ratio in your chosen area. A ratio above 20 generally favours renting, while a ratio below 15 makes buying a more financially sound option. In high-cost cities like Mumbai, renting often makes more sense, while in tier-2 cities like Indore, buying may be a better choice due to lower property prices

and a reasonable price-to-rent ratio. For people who anticipate staying in one place for at least 5-7 years, buying can be beneficial. In tech hubs like HITEC City in Hyderabad, where professionals may need to move for work, renting is often the more

practical choice. What do the experts say?

"The rent-versus-buy decision is not just about the monthly expenses. It's about understanding the wider financial implications," said LC Mittal, Director of Motia Group.He said that renting frees up capital that can be invested elsewhere, potentially yielding higher returns. For example, a professional in Delhi might rent a 2BHK house in Dwarka for Rs 20,000 per month and invest the savings in a diversified portfolio. Over time, investments in stocks or mutual funds could provide

significant returns. Manoj Goyal, Director at Forteasia Realty Pvt Ltd, pointed out that while renting allows more financial flexibility, buying offers the benefit of equity building and

the potential for property appreciation. 'It's all about balancing your financial goals with your personal situation," he said. He added that government schemes like the PMAY, which offers subsidies for first-time homebuyers, make the buy decision more attractive for some people.

born cricketer as he even bowled to his competitor Dinesh Karthik to help him

Out of action since the ODI



World Cup 2023 final due to surgery, Shami is determined to make a full recovery before returning to the national squad."I believe India are the favourites to win the series. In the last series in Australia, we played with a young team, with many senior players absent, yet we still proved we were the best. I expect the next series to be highly competitive, but I'm confident that India will come out victorious," Shami said. Speaking

at an awards function in Kolkata, Shami outlined his cautious approach to his return. "I don't want to rush myself, even though I want to come back as soon as possible. It's not advisable to return with any doubt. I need to be stronger, and the stronger I feel, the better it will be. My goal is to return at my strongest," Shami explained.Shami emphasized the importance of fitness, adding, "I've already started bowling. But

unless I'm 100 percent in every aspect – both mentally and physically – I won't consider returning to action. If needed, I'll even play domestic cricket to ensure I'm at my best.'

Shami, who has taken 229 wickets in 64 Test matches, is also optimistic about India's upcoming two-Test series against Bangladesh, which starts on September 19 in Chennai. Confident in India's form and playing conditions, he remarked, "It's fine if Bangladesh have beaten Pakistan, but we're playing at home. Bangladesh should consider our record, current form, and the strengths of the Indian team."

Looking ahead, Shami expressed a strong desire to represent Bengal in the Ranji Trophy as part of his comeback. "I definitely want to play for Bengal in the coming season. Playing two or three matches will help me make a strong return to international cricket," he stated, underscoring the importance of domestic cricket in regaining full match fitness. Shami also shared his deep gratitude toward Bengal, which played a pivotal role in shaping his cricketing career. "I was born in a family in UP where there was no opportunity. So I often say I was born in UP but made in Bengal. This is a journey of 22 years, and I am so grateful to Bengal for making me what I am," he said.

New Delhi. Ace Indian spinner Ravichandran Ashwin, now 37, has addressed growing speculation about his future in international cricket. While still a key figure in India's Test squad, Ashwin clarified that his retirement will come only when he no longer feels the drive to improve his game.

Speaking ahead of India's home Test series against Bangladesh, Ashwin revealed that he hasn't set any specific retirement timeline. Instead, his decision will hinge on his personal motivation and performance.



"There is nothing like that in my mind. I am only thinking about one day at a time because when you get older, you have to put in extra effort every single day. It's not the same. I have put in a lot of effort in the last 3-4 years. I haven't decided (retirement), but the day I feel that today I don't want to improve, I will leave. That's all," Ashwin said during a conversation with Vimal Kumar on his YouTube channel when asked if one can expect him to play till 40.Despite nearing 40, Ashwin remains highly motivated, stating that his daily effort and passion for the game fuel his performance. Ashwin holds the top spot in the ICC Test bowler rankings and will play a crucial role in India's upcoming five-Test home series,

starting with two matches against Bangladesh, followed by three against New Zealand. With 516 wickets in 100 Test matches, he is India's second-highest wicket-taker in the format, behind only Anil Kumble, who holds the record at 619. While many believe Ashwin could surpass Kumble's tally, the off-spinner downplayed such goals, choosing to focus on enjoying his game. "I haven't set any targets for myself. Anil Bhai wants me to break his record, but I'm just happy living day by day. I don't want to lose my love for the game by setting targets," he explained.

Ashwin also reflected on the challenges he faced between 2018 and 2020, a period where injuries and form affected his game. "I know how my life changed after that tough phase. I'm just holding on to my joy of cricket, and the moment I feel I'm losing it, I'll step away." The seasoned bowler acknowledged that all players eventually leave the game and that others will take their place, continuing the legacy of Indian cricket. "We all play, and we all have to leave. Somebody else will come and do well. It's Indian cricket," he concluded.
