New Delhi, Sep 18: Chandrayaan-4, Venus orbiter mission, Indian space station and next-gen launch vehicle development plan get approval from Narendra Modi government. Chandrayaan-4, the next phase following Chandrayaan-3's success ful lander and rover landing on the Moon, received approval from the Union Cabinet on Wednesday. The Cabinet also cleared the plan for the Venus orbiter mission, the development of an Indian space station, and the next-generation launch vehicle development, Union minister Ashwin Vaishnaw told a press briefing. The moon mission named Chandrayaan-4, aims to develop and demonstrate technologies for returning to Earth after a successful landing on the Moon. Indian Space Research Organisation (ISRO) will handle the development and launch of Chandrayaan-4 which is expected to be completed within 36 months. 2. SC seeks Centre response on hybrid hearing in CIC, land acquisition cases

New Delhi, Sep 18: The Supreme Court has sought the response of the Centre and states on providing hybrid hearings in the Central Information Commission (CIC) and the authority hearing pleas for compensation in land acquisition matters on separate public interest litigations (PILs) pointing out the lack of such facility as a reason for case pendency in these forums. In an order passed on Monday, made public on Tuesday, a bench headed by Chief Justice of India (CJI) Dhananjaya Y Chandrachud issued notice on the two petitions filed by advocate Kishan Chand Jain who underlined the need to provide speedy and effective justice to litigants by the integration of technology. Jain said that that the CIC, which has a nationwide jurisdiction, has to deal with appeals filed under the Right to Information (RTI) Act, which provides the backbone for transparency in matters of governance and decision-making. Instead of providing virtual hearing links to litigants and lawyers, the CIC conducts online hearing through the National information Commission (NIC) studios, which are designated spaces, often located in government offices or district headquarters. This practice requires appellants to travel to NIC studios, causing inconvenience, time loss, and additional expenses, besides having to wait at these studios for their

The guarantees were launched in the presence of Congress president Mallikarjun Kharge, Congress general secretary KC Venugopal, former Haryana CM Bhupinder Singh Hooda, Haryana Congress chief Udai Bhan and senior party leaders.

Delhi HC refuses bail to **British national Jagtar** Johal in UAPA cases

on Wednesday refused to grant bail to British national Jagtar Singh Johal in several cases lodged against him under anti-terror law UAPA. A bench headed by Justice Prathiba M Singh rejected the appeals filed by Johal against the trial court orders denying him the relief in seven cases being probed by the National Investigation Agency (NIA) in relation to a series of alleged targeted killings and attempts to kill in Ludhiana and Jalandhar districts of Punjab in 2016-2017. The probe was transferred from the Punjab Police to the NIA after it was "identified" that the offences were part of a "transnational conspiracy that intended to destabilise the law-and-order situation" in the state, the court noted. Opposing the pleas, the NIA claimed that Johal, who was arrested in November 2017, was "highly radicalised" and an "active member" of the Khalistan Liberation Force (KLF). It was alleged that being one of the main conspirators, the accused provided funds that were used for the procurement of arms and weapons by two shooters. The bench, also comprising Justice Amit Sharma, dismissed five appeals for being filed beyond the permissible period under the law.

New Delhi, Sep 18: Bahujan Samaj Party (BSP) president Mayawati on Wednesday said that her party holds a "positive" view on the Union cabinet's approval of the proposal to hold simultaneous elections, but its objective should be national and public interest. "Our party's stand on the approval given today by the Union Cabinet to the proposal to hold simultaneous elections of Lok Sabha, Assembly and local bodies in the country under the system of 'One Country, One Election' is positive, but its objective must be in the national and public interest," she stated in a post on X. Mayawati will hold a meeting of all party office-bearers on Thursday to review preparations for UP assembly bypolls to 10 seats expected by the yearend. She will also take stock of the progress of work assigned to differzational and public outreach. The party denial of tickets to stalwarts in the functionaries informed that Mayawati will hold the special meeting at the state office at 12, Mall Avenue from 11am. The BSP chief will take feedback from party workers over the selection of candidates,

Mondal was arrested on September 14 for allegedly tampering with evidence and delaying the registration of the FIR. He is at present in CBI custody. The RG Kar Medical College and Hospital, where the post-graduate trainee doctor was raped and murdered while on duty on August 9, is located in the Tala police station area in north Kolkata.

Kolkata, Sep 18: Kolkata rape-murder case: Trinamool Congress MP Abhishek Banerjee urged the protesting junior doctors in Kolkata to end their cease-work protest and work "collaboratively" with

safety and security, and I have always maintained that most of their concerns, barring a few, are valid, sensible and justified," he wrote on X. The Diamond Harbour MP also noted that the state government has transferred former Kolkata Police commis-

"Lastly, it is crucial to hold the CBI accountable and ensure that no perpetrators are spared, with swift punishment handed down at the earliest opportunity," Abhishek said. The TMC has been questioning the central agency ever since the probe was transferred from Kolkata police by the Calcutta High Court. In her address on TMC's foundation day, Chief Minister Mamata Banerjee also questioned the CBI for the alleged delay in completing the probe and said the Kolkata police would have completed the probe in seven days if the high court had not handed over the investigation to the central agency.

In response, Vaishnaw said, "The opposition might start feeling internal pressure (about One Nation One Election) as more than 80% of respondents who participated in the consultation process have expressed positive support, particularly the youth, who are very much in favour of this.' The Union Cabinet, led by Prime Minister Narendra Modi, approved the 'one nation, one election' proposal based on recommendations from a panel chaired by former President Ram Nath Kovind. The panel's recommendations include holding simultaneous elections for the Lok Sabha and state Assemblies as an initial step, followed by coordinated local body elections within 100 days. Additionally, the panel proposed the creation of an 'Implementation Group' to oversee the execution of these recommendations.

One nation, one election' cleared by Modi cabinet

New Delhi, Sep 18: The union cabinet chaired by Prime Minister Narendra Modi on Wednesday approved the Ram Nath Kovind committee recommendations to holding simultaneous elections in the country through the use of common electoral rolls. Information and Broadcasting Minister Ashwini Vaishnaw announced the cabinet decision and said the agenda of simultaneous elections was passed unanimously and all BJP allies were on board. The minister said the cabinet accepted the panel's suggestions to roll out the plan in two phases. "In the first phase, simultaneous elections to the Lok Sabha and state Assemblies will be held. In the second phase, all local body elections will be held within 100 days of the conclusion of the national election so that for the next five years, everyone can work to further the mission of national development," Vaishnaw said. The government said the "One nation, one election" idea would be implemented through consensus and an implementation committee would be constituted to finalise the rollout plan, which would require legal processes and constitutional requirements to be met.

electoral reforms with the Union Cabinet accepting the recommendations of the High-Level Committee on One... The Tribune reported on Tuesday that the government had decided to implement the "One nation, one election" plan in the current tenure of the NDA government. Vaishnaw, however, did not put a date to the rollout plan but said once consensus was achieved and legal requirements met, the plan would be implemented. Home Minister Amit Shah had yesterday said the plan would be implemented in this very tenure of the Modi government. Vaishnaw said the

Kovind panel received widespread support for the simultaneous election plan during its meetings and a large number of political parties also backed the idea, which was mooted much before the 2024 General Election. Vaishnaw

said the simultaneous elections would have a good positive economic impact, strengthen democracy, remove impediments to growth and enhance national progress. "We call upon



everyone to engage in detailed discussions on the plan," Vaishnaw said, adding that the discussions would be held nationally. The idea received a boost when the parliament committee on law and justice backed it in 2021. "Our bloc led by the Congress.

country remains in election mode throughout the year. We are of the view that the idea of "One nation, one election" is not new to our country as the first three elections (1952, 1957

and 1962) were held simultaneously," said the panel, giving the government a reason to move forward with the agenda. Conducting simultaneous elections would entail amendment to the Constitution to have fixed terms for local bodies, legislative Assemblies and the Lok Sabha. Amendments would also be required for common electoral rolls. The government then established a committee under former President Ram Nath Kovind to examine the issue and the panel submitted its 18,626-page report to President Droupadi Murmu in March this year. As many as 47 political parties sent their suggestions to the Kovind committee, with 32, mainly BJP and allies,

supporting the concept and 15 opposing it. Of the 32 supporters, 26 are part of the ruling NDA coalition. Among the 15 parties that resisted the idea, 10 are from the opposition INDIA

A leg lost in accident, cow moos on slow and steady with prosthetic limb

- MUMBAI. A cow that lost a leg to an accident last year is just getting back on all fours, one of them a newly fitted prosthetic limb. The five-year-old got the artificial leg three weeks ago and is slowly showing "signs of acceptance", said officials of Bai Sakarbai Dinshaw Petit Hospital for Animals (BSPCA), Parel, where it is undergoing treatment, reports Alex Fernandes.
- It was brought from a shelter in Palghar, where the accident happened. "So far, it has accepted the new limb well," said Dr Mayur Dangar, manager of BSPCA.
- Initially, the prosthetic was placed on the stub of the right hind leg for about half-an-hour a day for a week, going on for a couple of hours daily, graduating to 4 hours in the mornings, another 4 in the evenings, slowly getting her used to the new part. "She's slowly inching forward with the prosthetic ... But we will wait until we have kept it for 12 hours a day to be sure all is well," said Dr Dangar. Very few people make limbs for large animals, said Col B B Kulkarni, chief medical superintendent, BSPCA. "Acceptance of the new limb in large animals is rare," he said. "In this case, we've met with good progress so far."

New rail services off to a speedy start

- Ahmedabad. The launch of the Ahmedabad-Gandhinagar Metro and the Namo Bharat Rapid Rail Service kicked off with impressive passenger numbers on their debut day. The new metro line, stretching from GNLU to GIFT City, attracted nearly 5,000 passengers, while the Namo Bharat Rapid Rail saw a turnout of 320 passengers from the Ahmedabad, Sabarmati and Chandlodia stations in the city alone. The high interest signals a promising start for these new transit options in the region.
- S S Rathore, managing director of Gujarat Metro Rail Corporation, highlighted that initial estimate indicated close to 5,000 metro riders on Day 1, with final figures expected soon. Many of these passengers transitioned from crowded taxis and cabs, finding the Rs 35 fare a compelling draw. Metro officials anticipate even higher footfall once the line extends to Sachivalaya and Akshardham.
- Meanwhile, the Namo Bharat Rapid Rail, described as a local train by railway officials, recorded 200 passengers from Ahmedabad and Sabarmati stations, and 120 from Chandlodia. "Since the train operates on an unreserved basis, passengers purchase tickets at the counter. Its true popularity will be clearer in a month when monthly, fortnightly and weekly passes come into play," said a senior official.

The Rapid Rail, with a speed of 110 km/h, aims to make the 359km journey from Bhuj to Ahmedabad in just 5 hours and 45 minutes, compared to the seven hours by road. With fares starting at Rs 30 for the first 25km and Rs 1.20 per additional km, and options for regular passes, the train offers a costeffective alternative to road travel, where state transport bus fares range from Rs 260 to over Rs 700. "Due to the speed, we are hopeful of daily commuters shifting to this train," the official added. The train's 12-coach configuration accommodates 1,150 seated passengers and over 2,000 standing passengers. Rupesh Vora, a passenger from Sabarmati, praised the train for enabling same-day return trips from Bhuj. However, he noted that those travelling to Bhuj may need to plan for an overnight stay. "A morning train from Ahmedabad could enhance convenience for these travellers," he added.

This number was first recorded as an all-time record since 1920 on September 28, 2002. Similarly, an analysis of the data available with the Climate Research and Services Division of the Met Department, revealed that seven IMD stations in Tamil Nadu recorded equal or highest temperature during September and nine other stations record top 10

Corruption in the functioning of Covid First Line Treatment Centres (CFLTC) has come to the fore as the Vigilance and Anti-Corruption Bureau (VACB) registered a case against three persons for diverting funds granted for the expenses of one such treatment centre in Vengola near Perumbavoor in Ernakulam. Vigilance Ernakulam Range team has registered a case against former Vengola panchayat senior clerk Shyjil Kumar, Health Inspector Jomon Jacob and a person named Mahinkutty.

According to Vigilance officials, Vengola panchayat operated a CFLTC where patients were lodged after they turned positive during the test. As per the FIR of the case, the first accused was holding the post of CFLTC Nodal Officer.

Road rage: Realty firm owner threatened with hammer

Speaking to reporters in front of the said house on Tuesday, Lakshmana said Kumaraswamy is popular for "making hitand-run statements". "If he proves that Siddaramaiah snatched land belonging to a Dalit, we will ensure that he resigns from

the CM's post, but if Kumarawamy fails to prove it, then he should resign from the post of Union minister. Kumaraswamy must stop making baseless allegations against Siddaramaiah. If he spreads false information by releasing fake documents, we will pursue legal action," he said.

Lakshmana said, "The land belongs to Sakamma, grandmother of Congress leader Rakesh Papanna. In 1950, Puttegowda had divided the land in survey number 70/4 and given it to his children Chikkathammaiah and Sakamma, and each got 30 guntas.

The land survey number was changed to 70/4A (Sakkamma) and 70/4B (Chikkathammaiah). In 1967, Sakamma gave 10 guntas of land each to her sister's two children and kept the remaining 10 guntas with herself. In 1984, MUDA notified the land belonged to Chikkathammaiah and awarded him Rs 11,700 in 1986. In 1997, Sakamma sold her land to Siddaramaiah, who constructed a house on 100x120 sqft, with a loan from Merchants Coop Bank," he said.

Lakshmana said that after the bank issued

notice to Siddaramaiah for not repaying the loan, he sold the house to Khodays in 1999 for Rs 98 lakh, to clear the loan. But in 2018, RTI activist Gangaraju sought details of the survey 70/4. MUDA authorities gave information regarding 70/4B, which belonged to Chikkathammaiah and was notified. So he filed a complaint in the civil court in Mysuru, alleging that Siddaramaiah has constructed a house on notified land. The court judge directed Lakshmipuram police to probe the case and submit a B report.

Kerala trucks discharge fish waste on Pollachi roads

On September 9, a truck carrying fish from Kozhikode to Thoothukudi was detained by public at Gomangalam when the driver tried to discharge waste on the roadside.

COIMBATORE. People living in Pollachi and surrounding areas complain that vehicles transporting fish from Kerala to Tamil Nadu dispose waste in the open. Since the beginning of this months, four trucks have been detained by public for letting waste water from the fish stock on the road . The public urge authorities to tighten vigil and stop dumping of waste and releasing waste water.

Fish is transported by trucks from Kerala to various parts of Tamil Nadu to poultry farms as chicken feed and food processing units. During transit, fish is packed with ice bars to prevent spoilage and the wastewater accumulate from the ice bars is used to store inside the truck. The truck drivers and assistants discharge the waste water on the road which leaves behind a strong stench and raises the risk of infection.

On September 9, a truck carrying fish from Kozhikode to Thoothukudi was detained by public at Gomangalam when the driver tried to discharge waste on the roadside. Due to the strong stench, locals caught two more

trucks carrying fish waste and handed them over to the police on the same day. On September 13, another truck was caught near Pollachi town.

Further, two truck drivers were caught by public near Gomangalam on Monday when they were discharging fish waste on the roadside. The issue was informed to the police and they were investigating. The truck drivers P Selvam (46) from Andipalayam in Thiruvarur, and C Palanivel (50) from Vadakkuvellur near Cuddalore were arrested and the police registered a case against them under section 279 (fouling water of public spring or reservoir) and 280 (making atmosphere noxious to health) of the Bharatiya Nyaya Sanhita (BNS) Act. The accused were remanded to judicial custody and the trucks were seized, said police.

"Trucks transporting fish usually have a storage unit inside where they should store the waste and discharge them at their own place with proper mechanism. However, they dump the waste on roads while on the move.

Dengue stings hard, city tally crosses 40

Gurgaon. The count of patients being diagnosed with dengue has gone up, with the city adding 18 cases over the first 17 days of this month, taking its total for this year to 42. The city reported three new cases on Tuesday. According to data by the health department, four patients with active infection are being treated at hospitals across the city and are recovering well.Of the 18 cases this month, seven are women and all others are men. They are all between 17 and 48 years of age.An official said that the health department has identified Wazirabad, Bhangrola, Nakhrola, Badshapur, Bhondsi, Bhorakalan and Garhi as dengue hotspots in the city."We have been tracking down active cases and marking hotspots. MCG has been told to carry out fogging drives in areas with positive cases to curb breeding of dengue-causing mosquitoes," the official said.Experts have cautioned that warm and humid temperatures after showers or between spells of rain are ideal breeding grounds for mosquitoes that cause the illness. Dengue and cases of other mosquito-borne diseases, they said, are likely to increase in the coming weeks.Dr Tushar Tayal, lead consultant at the department of internal medicine at CK

Birla Hospital said OPDs have seen an uptick in the number of patients reporting dengue-like symptoms over the past two weeks."Symptoms are milder compared to the typical range of illnesses. But it is crucial to identify them promptly and get tested. Emergency departments are witnessing an influx of dengue patients who are receiving symptomatic treatment in the form of intravenous fluids and antipyretics. There is no need for panic even if you are diagnosed with dengue. Paracetamol for fever and adequate hydration are the keys to recovery," Dr Tayal said.Commonly seen symptoms of dengue include fever, headache, muscle and joint pain, and a characteristic skin rash.Doctors emphasised the need for taking preventive measures to slow the spread of infections. They recommend wearing full-sleeved clothes, using mosquitoe repellents and cleaning any pools of stagnant water from containers, coolers, among other precautions.

"Due to the accumulation of garbage, waterlogging, and humidity changes caused by waterlogging, the prevalence of these infections has become very high. We can prevent this disease burden through simple techniques like maintaining cleanliness in our surroundings," said Dr Amitabh Ghosh, consultant for internal medicine at Manipal Hospital in the city. The city had recorded a total of 276 dengue cases, including a fatality, last year. In 2022, cases touched 440, and the year before that, 327 patients were diagnosed with the infection.On Tuesday, doctors said

dengue cases were likely to go up because of extended monsoon this year.

'Several cases have been reported in Aug and Sept, and with the continuing rainy season, we anticipate the numbers to increase further. Our emergency departments are already managing a high volume of patients.

Extend social security benefits to gig workers, assn tells govt

Gurgaon. The Gig Workers Association (GigWA) has urged the govt to extend social security benefits such as employees' state insurance (ESI) and provident fund (PF) to gig workers, following the govt's move to register aggregators and their platform workers on the a Shrap portal GigWA has on the e-Shram portal.GigWA has proposed that costs of these benefits be shared among gig workers, aggregators, and the govt, citing current lack of social security for these workers. The association praised the ministry of labour and employment's initiative to register gig workers and establishment of a toll-free helpline (14434) to assist with the registration process. The ministry's advisory, which

includes a standard operating procedure (SOP) detailing aggregator responsibilities for worker registration and data updates, has been wellreceived. Under the new system, platform workers will receive a universal account number (UAN), granting them access to essential social security benefits.Nitesh Das, organising secretary of GigWA, said the need for social security through the employees' state insurance corporation (ESIC) and old-age protection via the employees' provident fund organisation (EPFO). He called for the same protections afforded to formal workers to be extended to platformbased gig workers.

A drain runs through it: Panel to probe what's killing Surajpur trees

Noida. The Greater Noida authority has set up a panel to probe how untreated industrial effluents were making way into the Surajpur wetland, where numerous trees died earlier this year. The committee, comprising three senior officials from the Greater Noida authority, with representatives from the district forest office, irrigation department, and pollution department, will investigate and submit a comprehensive report on the wetland's status by the end of this week. The complainant, Vikrant Tongad, said, "I already sent two complaints regarding the matter. Despite the formation of a joint inspection team, there has been no action on the ground. No steps have been taken against those discharging untreated water into the wetland and causing loss of vegetation."

- Environmentalist Vikrant Tongad claimed there are about 100 industrial units near the wetland and most of them were discharging untreated water into the wetland. "We have already lost more than dozens of trees and many more will be destroyed if this continues," he said.
- According to the Provisions of Environment (Protection) Act, 1986 and Water (Prevention & Control of Pollution), Act 1974, industrial units must install effluent treatment plants (ETPs) and treat their effluents to comply with environmental standards before discharging into river and water bodies. The central and state pollution control boards monitor industries' effluent discharge and act against noncompliance under these two acts."Upon visiting the wetland, our team found numerous trees that had perished due to industrial waste. A drain that runs through the wetland requires proper channelisation to prevent effluents from leaking into the ecosystem. We have advised the pollution department to inspect nearby factories and take appropriate measures if their effluents are found to be contaminating the wetland", said GNIDA general manager Indu Prakash.
- Residents living near wetland said they saw canopy thin, branches dry, and trees die on east bank over the last four years due to chemical discharge into the waterbody.



Taiwan firm denies making pagers that detonated in Lebanon

- World Gold Apollo, a Taiwan-based manufacturer that produces pagers, denied making the explosives-laden wireless devices which were detonated across Lebanon, killing at least nine people and injuring nearly 3,000 others. The company said the devices used in Tuesday's blasts were made by a European company called BAC which has a licence to use the Taiwan firm's brand name.
- Addressing reporters at the Gold Apollo's office in the city of New Taipei, Hsu Ching-Kuang, founder and president of the company, said that the "product is not ours. It only had our brand on it".He, however, did not elaborate on the location of the European firm. "We may not be a large company, but we are a responsible one. This is very embarrassing," news agency Reuters quoted Hsu as saying. The company chief stressed that he did not have any knowledge as to how the pagers were rigged with explosives. According to a Reuters report, the police arrived at the New Taipei offices while Hsu was meeting reporters. The development comes after a Lebanese security source told the news agency that the Iran-backed Hezbollah had ordered 5,000 pagers from Gold Apollo.The source identified the model of one exploded pager as the AP924 variant. Images of the damaged pagers also revealed a design and stickers on the back consistent with those produced by Gold

WHAT ARE PAGERS

Traditionally, pagers are one-way communication devices, meaning they can only receive alerts but cannot respond. More sophisticated versions, known as two-way pagers, offer the ability to send and receive text messages.

HOW PAGERS OPERATE

The operation of a pager relies on a dedicated network of radio transmitters. When a message is sent, it first passes through a central terminal, which then broadcasts the message over a specific frequency. Radio

Republicans block US Senate IVF bill despite Trump's support, Biden slams move

The IVF bill failed 51-44, falling short of the required 60-vote threshold in the US Senate after most Republicans voted against it for the second time. Following the bill's failure, US President Joe Biden slammed Republican Senators, calling their move "outrageous and unacceptable".

Washington A US Senate bill aimed at enshrining federal protections and expanding insurance coverage for fertility treatments failed on Tuesday, as Republicans voted against it days after Donald Trump surprised supporters by voicing support for such a policy. The bill failed 51-44, falling short of the required 60vote threshold after most Republicans voted against it for the second time. Democrats control the chamber by a slim 51-49 margin.US President Joe Biden slammed the blockade of the bill, calling it "outrageous and unacceptable"."Yet again, Senate Republicans refused to safeguard access to



fertility treatments for women trying to get pregnant. Republican officials have had every opportunity to protect reproductive freedom - from IVF to contraception - but they refuse to do so. The disregard for a woman's right to make these decisions for

herself and her family is outrageous and unacceptable," the US President said.The bill's sponsor, Democratic Senator Tammy Duckworth, first attempted to get a vote on the same bill in late February, after the Alabama Supreme Court ruled the embryos used in in vitro fertilization, or IVF, should be considered children, jeopardizing access to the treatment used by millions of Americans every year."The freedom to get reproductive care is at risk for millions of other women whose most desperate hope in the world is to have a little one of their own," Duckworth, who had her two daughters via fertility treatments, said in a Senate floor speech after Tuesday's vote. "Republicans only seem to care about protecting life when it supposedly consists of some cells in a medical lab freezer."Republican presidential candidate Trump said in August he would require the government or insurance companies to pay for IVF if he is elected, surprising some hardline Republicans for whom the treatment is controversial."We want to produce babies in this country, right?" Trump said during a town hall-style campaign event in La Crosse, Wisconsin.Trump's campaign did not immediately respond to a request for comment on Tuesday.

Israel's Mossad planted explosives in Hezbollah's Taiwan-made pagers: Reports

World. Israel's Mossad spy agency planted a small amount of explosives inside 5000 Taiwan-made pagers ordered by Lebanese militant group Hezbollah five months before Tuesday's detonations, multiple reports claimed, citing senior Lebanese security sources.Pagers, wireless communication devices used by thousands of members of the Iran-backed militant group Hezbollah, exploded simultaneously across Lebanon and parts of Syria on Tuesday, killing at least nine people and wounding scores. Nearly 100 cases of blasts were reported in Syria.A senior Lebanese security source who spoke to news agency Reuters alleged that the pagers exploded when a coded message was sent to them, simultaneously activating the explosives. Mossad injected a board inside the device that has explosive material that receives a code. It's very hard to detect it through any means. Even with any device or scanner," the source told Reuters. The Iran-backed militant group had ordered 5,000 pagers from Taiwan-based manufacturer Gold Apollo, which were smuggled into the country between April and May. A security source identified the model of one exploded pager as the AP924 variant. Images of the damaged pagers also revealed a design and stickers on the back consistent with those produced by Gold Apollo. The plot appears to have been many months in the making, according to the sources.Sources who spoke to Sky News Arabia alleged that the Israeli spy agency placed a quantity of PETN, a highly explosive material, on the batteries of the devices, and detonated them by

- Meanwhile, the White House described the call as a "cordial and brief conversation", adding that Harris spoke to Trump directly "to express that she is grateful he is safe".

World The first picture of the Titan submersible that imploded in June last year during its descent to the Titanic wreckage site was revealed by the US Coast Guard on Monday at a public hearing into the deaths of five people onboard the vessel.A text conversation between the Titan's crew and the Polar Prince, a nearby support ship, was also revealed during the hearing. When asked if it was visible on Polar Prince's informational display, a chilling three-word text from the Titan's crew came, saying, "All good here," even as the sub descended further, The Guardian reported. The image of the ill-fated Titan, captured during the frantic search for the vessel last year, showed the sub's broken tail cone resting on the floor of the Atlantic Ocean at a depth of 12,500 feet, giving a chilling reminder to the viewers about the aftermath of the implosion.Fragments of the sub were also visible on the ocean floor -- the debris that was found by the search teams that confirmed the sub's implosion. According to the Marine Board of Investigation, the Titan's detached tail cone and other debris gave "conclusive evidence" that the sub suffered a "catastrophic implosion", CNN reported.OceanGate, the company that developed the Titan, had come under intense scrutiny as former employees and whistleblowers expressed concerns over the design of the vessel. Tony Nissen, the former engineering director, spoke about the pressure to expedite the Titan's launch despite his reservations. Another contractor, Tym Catterson, expressed his doubts about the suitability of the materials -- carbon fibre and titanium -- used in the submersible's construction, according to The Guardian.

Kamala Harris opposes Israeli reoccupation of Gaza, calls for end to war

Kamala Harris called for a ceasefire and a two-state solution to end the Israel-Gaza war, emphasising the importance of preventing

Israel from reoccupying Gaza.

Washington US Democratic presidential candidate Kamala Harris called on Tuesday for an end to the Israel-Gaza war and said that Israel must not reoccupy the Palestinian enclave once the nearly year-old conflict comes to an end.

Speaking in Philadelphia to the National Association of Black Journalists, she called for a ceasefire between Israel and Palestinian Hamas militants, a two-state solution and Middle East stability in a way that does not empower Iran."We've made ourselves very clear this deal needs to get done in the best interest of everyone in the region," Harris, the US vice president, said in response to questions asked by three journalists.At least 41,252 people have been killed and 95,497 wounded in the Israeli offensive in the Hamas-ruled strip since October 7, the Gaza health ministry said. The

war began that day when Hamas attacked Israel, killing 1,200 people, mostly civilians, and taking about 250 hostages, according to Israeli tallies.Harris was asked about Springfield, Ohio, a city that for days has found itself at the centre of a social media maelstrom after rightwing agitators latched onto false claims that Haitian arrivals were eating household pets.Former President Donald Trump, Harris' Republican rival in the Nov. 5 presidential election, has pledged to conduct mass deportations of Haitian immigrants from Springfield if elected, even though the majority are in the United States legally."This is exhausting and it's harmful and it's hateful and grounded in some ageold stuff that we should not have the tolerance for," Harris said. The 45minute interview began with economic issues. Harris said that if elected president she will work with



private investors to boost housing supply, acknowledging that more work was needed to lower prices for Americans."One of the big issues that affects people right now in terms of the economy and their economic wellbeing is we have a shortage of housing supply," Harris said. Since the beginning of the Gaza war last year, Hezbollah members have been using some low-tech devices to evade Israel's sophisticated surveillance technology. However, reports suggest that Tuesday's pager explosions in Lebanon could be more than just a remote hack.

At least nine people were killed and 2,750 were injured in Lebanon on Tuesday after wireless communication devices used by militant group Hezbollah exploded in what appears to be a targeted attack. Multiple reports have now claimed that Israel's spy agency, Mossad, planted a small amount of explosives inside the Taiwanmade pagers five months before.Hezbollah and Lebanon blamed Israel for the wave of explosions, which lasted for about an hour, even as Tel Aviv did not immediately respond to the charges.Hezbollah, which is backed by Iran, has been engaged in crossborder warfare with Israel since the Gaza war erupted in October last year. The group had instructed its members to avoid mobile phones and to rely on its own telecommunications system instead to prevent Israeli breaches.

WHY WAS HEZBOLLAH USING PAGERS?

Reports suggested that following the killing of senior commanders in targeted Israeli airstrikes, Hezbollah has been using some low-tech devices, including landline phones and pagers, to try to evade Israel's sophisticated surveillance technology.Hezbollah has also been using its own drones to study and attack Israel's intelligence gathering capabilities in what the group's leader, Sayyed Hassan Nasrallah, described as a strategy of "blinding" Israel. These tactics have become crucial to facing a



formidable adversary like Israel, which uses hi-tech security cameras and remote sensing systems to identify and strike down its targets in enemy territory.Israel's electronic eavesdropping - including hacking into cell phones and computers - is also widely regarded as among the world's most sophisticated.

CAN PAGERS BE HACKED?

According to a Reuters report, some Lebanese sources told the agency that the pagers that

exploded were a modern model recently purchased by Hezbollah. Another report by Iran's Press TV suggested that the devices heated up before exploding.Since pager messages are typically transmitted over radio frequencies without encryption, hackers can use specialised radio equipment and software-defined radios (SDRs) to intercept large volumes of pager communications simultaneously. This allows them to capture and decode pager messages over a wide area, potentially

affecting thousands of users in hospitals, industries, or government sectors that still rely on pager systems.

While encryption makes it harder for attackers to intercept and read pager messages, vulnerabilities may still exist. Hackers can exploit weaknesses in the encryption protocol, find flaws in the pager's implementation, or use brute-force attacks if the encryption is weak.

News box AMC razes 23 illegal constructions in Fatehwadi area

Ahmedabad. AMC's south west zone teams demolished illegal constructions in the new Fatehwadi area of Sarkhej ward on Tuesday. In all, 23 illegal structures - 22 residential buildings and one commercial structure were razed.

Notices were issued by the AMC to demolish 51 illegal units - 32 residential buildings and 18 commercial units - spread across four survey numbers in Fatehwadi. According to a press release issued by the AMC, the individuals responsible for the illegal constructions filed a petition in the Gujarat high court on Sep 11.

The release mentioned that the high court initially granted a status quo but later ordered the petitioners on Sep 13 to voluntarily remove the illegal constructions by Sep 15. Since the petitioners did not comply, the civic body proceeded with the demolition, starting with 23 structures on Tuesday, the release said. The demolition work will continue on Wednesday, said a source.

ALAPPUZHA. Cherthala excise circle office has registered a case against six people for serving toddy (palm wine) to Class 7 students at Pallichanda near Poochakkal. Employees of shop TS No 52 Pallichanda K Manoharan, manager Mohanan, and licensees Chandrappan, Rama Devi, Ashokan, and S Sreekumar were booked under the Abkari Act 56g15G.

The incident relating to the case happened on August 13, on the occasion of Onam celebration at a school near Pallichanda. Seven students of Class 7 arrived at the shop and purchased two bottles of toddy. The students consumed a portion of the toddy in the bush near Pallipuram temple and kept it in their bags.

They drank the remaining portion in the school toilet. However, one of the students started vomiting soon after. He was then taken to Thuravoor Taluk Hospital by his parents. However, his condition deteriorated and he was shifted to Alappuzha Medical College Hospital. The boy was discharged from the hospital on Monday. The excise officials submitted a report on the incident to the excise commissioner on August 14.

The commissioner has the authority to take action against the violators. We expect the department will take proper action in the coming days," said Cherthala excise inspector P M Sumesh.Meanwhile, the department has decided to provide counselling for the children after their conditions get better. The samples of the toddy were collected from the shop and sent for laboratory examination to ascertain whether it had any adulteration.

He also visited Platform No. 4 on NTR Marg before the Khairatabad Ganesh idol was immersed. The 70-foot-tall idol was immersed between 1.35 pm and 1.40 pm with precautions in place. Unlike previous years, when the idol remained on the water's surface for days, this year it was fully submerged due to the deepening of the shoreline. Hydraulic cranes were used to expedite the process. The Khairatabad idol immersion procession began around 7 am, passing through Sensation Theatre, Telephone Bhavan and the Telugu Talli flyover before reaching Crane No. 4 on NTR Marg for immersion. A special pooja for the idol began at midnight at the mandap, with the loading of the idol onto a special trailer taking place late at night. The Balapur Ganesh idol was also immersed in the afternoon at Tank Bund, a change from previous years when its immersion



occurred at night."Second time in a row, the 70-feet Khairatabad Ganesh was immersed by 1.30 pm on the day of immersion. Despite the challenging procedure of moving the idol to the immersion point, de-welding and CM interacts with staff welding, our central zone police teams and the Utsav Committee members worked hard and succeeded. 300 cops check for drugs at tenements in Perumbakkam, return empty handed

CHENNAI. decade.Stating that the BJD had been repeatedly raising the demand for special category state status to Odisha during the last two decades, the party leaders said the previous government had taken up the matter with the President of India and the NITI Aayog, and an unanimous resolution



was also passed in the Assembly in this regard. But the Centre ignored the demands, they added.

"In the 2024 election, people of Odisha elected 20 BJP MPs out of 21 Lok Sabha seats in the state. But the Centre's disappointing attitude towards Odisha

further pointing out that while Bihar and Andhra Pradesh got special allocation of Rs 26,000 crore and Rs 16,000 crore respectively, Odisha was neglected.

Highlighting that coal royalty has not been revised by the Centre for the last 12 years, the BJD leaders said Odisha lost revenue of Rs 10,000 crore per year on this account.

"The then chief minister Naveen Patnaik had demanded revision of coal royalty from 14 per cent to 20 per cent at the Eastern Zone Council

meeting but there was no response from the Centre in this regard," they said.On Subhadra Yojana, the BJD leaders accused the BJP of cheating the women of the state as the latter would get Rs 50,000 assistance over a period of five years instead of two as previously promised.



HYDERABAD. Irrigation Minister N Uttam Kumar Reddy has called on the Union government to take steps to persuade central financial institutions to reduce or entirely waive the interest on loans taken by the previous government for irrigation projects in the state. He emphasised that these loans have become a financial burden for the current government and requested that the debt be cleared completely, or at least partially waived.

On Tuesday, Uttam attended the 8th International Water Week Summit - 2024, organised by the Ministry of Jal Shakti in New Delhi. During his speech, he sought robust support and cooperation from the Centre to complement the government's efforts. He pointed out that while the Union government has allocated substantial funds for infrastructure development nationwide, similar financial support should be allocated for irrigation projects. He also urged the Centre to provide financial assistance and expedite the clearances needed for these projects.

Uttam highlighted the state government's goal of developing new irrigation facilities for approximately six lakh acres annually and noted that the state has allocated Rs 29,000 crore for the irrigation sector in the Budget.

Additionally, he requested the Central government to take the lead in obtaining all necessary clearances for the Sammakka-Saralamma project through consultations with the Chhattisgarh government. He appealed to Union Jal Shakti Minister Patil to not only consider waiving or reducing the interest on past irrigation project loans but also to expedite the NOC (No Objection Certificate) process with Chhattisgarh for this crucial project.

On the sidelines of the summit, the irrigation minister engaged with representatives from the World Bank and the Asian Development Bank to discuss the need for soft loans for various irrigation projects. He also met with Chhattisgarh Irrigation Minister Kedar Kashyap to discuss the Sammakka-Saralamma project, emphasising that part of the project lies within Chhattisgarh and an NOC from the state is required to move forward.

Footpaths encroached by vendors, turned into parking lots in city

BENGALURU. Footpaths in Bengaluru, if and where they do exist, are meant for anything but people to walk safely on. Footpaths in residential areas are used as permanent parking spaces for cars, autos or two-wheelers. People use footpaths to place tree pots. They use footpaths to dump construction material like bricks, bars, sand, waste materials and what not.

Rampant commercialisation in residential areas sees hundreds of offices, shops, godowns and others being set up, with customers parking their vehicles on footpaths, blocking safe and easy movement for pedestrians. This apart, as commercial buildings fail to provide adequate basement parking facilities as mandated by the Bruhat Bengaluru Mahanagara Palike (BBMP), vehicles end up on footpaths.

In residential areas, footpaths exist only on paper. A majority of footpaths are turned into permanent parking spaces for cars, two-wheelers and autos. The kerb stones placed at the edge of footpaths to



separate walkways from roads are removed for easy entry of vehicles onto the footpaths. In many areas it is common to see permanent structures built by house owners on footpaths to protect their vehicles from rain and sun, without any sense of guilt that the pathways are meant for all and it's not anyone's personal property," says Purushotham Shiva, a resident of Chamrajpet."Footpaths in the city should be walkable for all, including the elderly and those with knee issues. For this, footpaths need to be flat, without debris and building material piled on them and no parked vehicles. They need to be at a

height from the road where the elderly can easily get on to them. It needs to be cladded with stones or concrete slabs, for easy maintenance, than having small tiles, which are not laid properly and keep coming out soon," said Rekha Chari from the Malleswaram Swabhimana Initiative (MSI), a neighbourhood organisation

that is working to improve the quality of lives of residents of the area.

Sharing her experience in the USA, she says, "We can't help marvelling at their footpaths as I can walk so easily on them despite my knee issues."

Vikram Rai, president, Bangalore Apartments Federation, says, "Having good footpaths encourages residents to walk to the neighbourhood store or to the nearby darshini or simply take a nice walk around. It encourages simple healthy activity, in the midst of most of our urban lifestyles which have come to be remote, digital and unhealthy."

Our China policy needs diplomacy & deterrence

of Actual Control (LAC) in eastern Ladakh continues, India's stance on the border issue has remained steadfast. National Security Adviser (NSA) Ajit Doval, while interacting with Chinese Foreign Minister Wang Yi recently on the sidelines of a meeting of the BRICS NSAs, emphasised that peace and respect for the LAC were precursors to the normalisation of India-China relations.External Affairs Minister S Jaishankar has also been reiterating this stand during his interactions with his Chinese counterpart, in Kazakhstan and Laos in July this year during the Shanghai Cooperation Organisation (SCO) summit and ASEAN Plus meeting, respectively. A few days ago, speaking at the Global Centre for Security Policy in Geneva, Jaishankar said while negotiations were underway, about 75 per cent of the disengagement issues at the LAC had been resolved. He again highlighted that while there was violence between the militaries of the two countries, the rest of the bilateral relationship could not be insulated from it. There cannot be a clearer statement from the political executive about the state of affairs, future expectations and prerequisites for peace. Like Jaishankar, Wang Yi has also been a career diplomat, adept at handling sensitive situations. Beijing's stance has always been ambiguous, emphasising on niceties and engagement, with the Chinese media, controlled by the Communist Party, often misquoting contents of bilateral exchanges to gain a perceived moral high ground. Though there are indications of some progress in resolving dispute points in Ladakh, but caution should always remain the buzzword in dealing with China.

The Chinese are used to picking quarrels, flexing military muscle and browbeating their neighbours. This is particularly so with countries having legitimate claims in the South China Sea (SCS). While bullying is the hallmark of its diplomacy, whether it is Taiwan, Vietnam, Philippines or the WHO, it may not have bargained for such a firm resolve from India. In fact, China's inability to ride roughshod in the border dispute with India seems to have become a major irritant that it finds problematic to a major initiant that it in this problemate to handle. It would surely wish to resolve the disputes along the LAC, entirely on its terms. Despite having been stymied at Doklam in south-west Bhutan or in east Ladakh, China's People's Liberation Army (PLA) has circumvented any disadvantage by encroaching upon Bhutan on the eastern flank of the Chumbi valley and by optimum use of the terrain that favours it along the LAC in Ladakh.Among China's pressing security concerns, like the Taiwan issue, sovereignty disputes with Philippines, Vietnam and other ASEAN nations in the SCS, the Himalayan borders appear to be the most vexing as the opponent can match up to it. Often enough, the difference between India and China in terms of comprehensive national power, which includes not only military muscle but also technology and economy, gets highlighted as a major concern for India. That may well be, but an armed conflict across the LAC will not be a viable option for China, and what Prime Minister Modi told Russia about "this not being an era of war," is equally applicable to Communist China. Instead, it will continuously endeavour to gain advantages through skirmishes on the northern border, while talking about peace and engagement. This would keep its manufactured claims alive and help in tying down India to an extent. Sanjauli mosque row rooted in anti-minority sentiment

Rising Islamophobia, legal prohibitions and a deepening sense of insecurity have led many Muslims to seek refuge in ghettos.

AS I walked through Shimla one morning, a sanitation worker, Vinod (name changed), remarked, "Inn Mullon ne Shimla mein gandh daal rakha hai," (Muslims are causing a nuisance in Shimla). His comment reflected the widespread hatred fuelled by the controversy over the Sanjauli mosque in the town. He claimed that the mosque was illegally built. Ironically, Vinod's house is on government forest land, a fact I was well aware of from my time as deputy mayor when policies were introduced to provide basic utilities to residents like him. When I asked him about the legality of his house compared to the mosque, he fell silent. This highlights that the issue is not just about legality but also has a strong religious undercurrent, and thus a different narrative is being built.Across Indian cities, the distinction between 'legal' and 'illegal' is often blurred. Legality isn't just about land ownership but also about compliance with sanctioned building plans. Any settlement on government land is illegal unless legalised by special laws passed by the

government. Even if a structure is built on privately owned land, it may still be illegal if it exceeds building plan limits.Government authorities, however, possess vast powers to convert illegal sites or structures into legal ones. Examples include the new Parliament building in New Delhi, where a designated district land use was changed and the building was constructed on it, and the entire Central Vista project. In Shimla, similar transformations include the state secretariat, the HP High Court and the lawyers' chambers there, Indira Gandhi Medical College & Hospital's 14-storey building and a building of a Hindu right-wing organisation at Nabha.Shimla's relationship with legality is complex. Built by the British, the town has one of the oldest municipalities in India, dating back to 1851. Over time, numerous land-use changes have occurred. While several areas merged into the municipal corporation are governed by the Town and Country Planning Act of 1979, other areas in old Shimla still operated under the Interim Development Plan till the Shimla Development Plan was finalised recently. Despite regularisation drives, an estimated 15,000 houses in Shimla remain classified as illegal.

Religious buildings, particularly Hindu temples (mandirs), gurdwaras and mosques, are often found violating the law of the land. The Sanjauli mosque stands on land owned by the Waqf Board, but additional floors



were constructed without authorisation. The famous Ram Temple in Shimla stands over 140 ft tall, with no regularisation certificate and an encroachment on municipal land.Other religious buildings face similar issues. The Summer Hill temple, where 20 people were killed in a landslide in 2023, is built on forest land without permission. The bus stand gurdwara and the temple next to Dhalli police station also lack the necessary approvals; in fact, the temple is on government land. The temple between Tutikandi bus stand and crossing is likewise on forest land, violating numerous laws. This pattern underscores how even religious spaces fall in the ambiguous zone of legality.

In her seminal work The Origins of Totalitarianism, political philosopher Hannah Arendt noted, "Only the mob and the elite can be attracted by the momentum of totalitarianism. The masses have to be won by propaganda." This is relevant to India today, where both elites and mobs have justified attacks on minorities.

The controversy over the Sanjauli mosque is just one of the many recent incidents rooted in anti-minority sentiment, and part of the totalitarian design. A Netflix series, Leila, shows a dystopian future where Hindutva extremism merges with technology to segregate society.

The definition of what is legal or illegal is relative. Anything constructed by minorities is often labelled illegal. A study by students from the School of Planning

and Architecture in Delhi, which I guided. examined how the State forced Muslims into ghettos over the last century. It found that Muslims were pushed into shanty towns and slums, occupying whatever land was available. This isn't unique to Muslims - large sections of the urban working class have also been relegated to slums due to exclusive city planning. However, under BJP rule since 2014, the situation has worsened, particularly for Muslims.

A striking example comes from a 1977 Delhi Development Authority (DDA) pamphlet on the Delhi Squatters Resettlement Project: "The urban poor live in dilapidated settlements that cling precariously to hillsides, line smelly canals, block roadsides, or crowd innercity alleys. In their tattered misery, they mock the aspiration of all those who yearn to make their cities sophisticated and modern." The pamphlet clearly dehumanised the urban poor, especially migrants.

Archives of the Delhi Municipal Corporation's Slum Development

Department mention the Turkman Gate massacre during the Emergency, when Muslims were targeted under the guise of a slum clearance drive and a sterilisation campaign. Jagmohan, then Vice-Chairman of the DDA, was allegedly asked whether displaced Muslims could be resettled in a new colony. His chilling response was, "Do you think we are mad to destroy one Pakistan to create another?" This mindset persists today, particularly against the Muslim community.

In her book Accumulation by Segregation: Muslim Localities in Delhi, Ghazala Jamil argues that Muslim ghettoisation is driven by neoliberal development policies and targeted persecution. Anything a Muslim builds is labelled illegal, and this justifies its demolition by the State. It's not just the physical structures that are being targeted - the goal is to attack the very idea of Muslim asset creation.

Rising Islamophobia, encounters with legal prohibitions, and a deepening sense of insecurity have led many Muslims to seek refuge in ghettos. This self-segregation further alienates them from urban development processes, exactly what the Hindutva forces desire. A few days ago, the Muslim community in Shimla offered to raze unauthorised portions of the Sanjauli mosque. Go all out to combat toxic masculinity Need to move towards a sane society reasonably free from the virus of sexual violence

IT's been over a month since a trainee doctor was raped and murdered in Kolkata's RG Kar Medical College and Hospital. An incident of this kind - and that too inside a government medical college - shocked the city or, for that matter, the entire West Bengal. Not surprisingly, a spontaneous social movement initiated by a spectrum of people - ranging from young doctors, students and ordinary men and women to the cultural elite - has shaken an otherwise 'popular' Chief Minister Mamata Banerjee. The tales of massive corruption and political networking in government medical colleges; the danger to the safety and dignity of trainee doctors; and the lack of trust in the state government as far as an impartial inquiry is concerned - yes, it is not easy for the Chief Minister to overcome this 'legitimation crisis'.

I notice positive things in this movement: the determination of trainee doctors to fight for their case and the carnival of protest - the way ordinary citizens are coming to the street, occupying the public space even late at night and singing the songs of 'justice'. Moreover, an attempt to rescue this In fact, if we wish to resist this rot, and try to move people's movement from the direct influence of mainstream political parties possibly indicates how 'politics' - particularly, the kind of politics professional politicians engage in - has acquired a bad connotation in our times.

However, the fact is that a movement of this kind will not last forever. The CBI will reveal its findings; the Supreme Court will give its judgment; the state government will try to negotiate with the doctors; the guilty will be punished; and some - including the CM - will continue to plea for capital punishment.

And then, everything will be 'normal'! Possibly, some of these young doctors who are protesting now will begin to prioritise more 'earthly' things, and eventually join corporate private hospitals, and sell 'good health' to their upper class clients as a commodity. And the cultural elite singing the songs of emancipation in the streets of Kolkata will come back to their own exclusivist spheres of work. And meanwhile, we will hear about yet another story of rape... Don't forget that we have almost normalised sexual violence in our society. As per the annual National Crime Records Bureau report, between 2017 and 2022, a total of 1.89 lakh rape cases were reported in India. And in a class-divided, castecentric society, who bothers about the victim if she is a Dalit woman, a domestic help, or even a schoolgirl in an unknown village? No social movement will take place; nobody will sing the songs of gender justice in the streets of Kolkata and Delhi.

towards a sane society reasonably free from the virus of sexual violence, we need to take part in yet another movement - psychic, educational and cultural - to combat the pathology called toxic masculinity. Well, in our families, boys grow up with a belief that they have to be bold, hard and courageous. However, toxic masculinity has got nothing to do with lifeaffirming courage, confidence and inner strength. Instead, it is a form of sadistic pleasure in causing harm to others. It is devoid of empathy and care. It glorifies violence and promotes sexual aggression.



As social psychologists would argue, it is "the constellation of socially regressive (masculine) traits that serve to foster domination, the devaluation of women, homophobia and wanton violence". It is difficult to imagine rape — the ultimate form of objectification of a woman, or her reduction into a soulless toy of sexual pleasure --- without the poison of toxic masculinity. It is important to realise that the psychology of toxic masculinity is often promoted and encouraged through the celebration of war, militarism, hyper-nationalism, vulgarly competitive 'masculine' sports and divisive communalism. Yes, it is a fact that sexual violence has often been used as a weapon in conflicts to humiliate, subjugate and terrorise people throughout history. To take an illustration, as many research findings indicate, between 200,000 and 400,000 women were sexually assaulted by Pakistani soldiers during the Bangladesh Liberation Movement. And a penetrating look at the Partition and the resultant communal hatred would reveal that women were sexually assaulted on both sides of the border.

Likewise, the prevalent culture industry is not altogether free from misogynic traits. The widespread dissemination

of porn literature, the objectification of women, and the celebration of brute masculinity intoxicated with the desire for instantaneous sexual pleasure - yes, there are multiple reasons for the continuous degradation and humiliation of women. It is, therefore, not surprising that a film like Animal was one of the highest-grossing Hindi movies of 2023, even though it was heavily criticised for its misogyny and portrayal of toxic masculinity and extreme violence. Or, for that matter, it is not impossible to see noisy youngsters - even in our colleges and universities - dancing to the repulsive song Main hoon balatkari.

While checking the Maldives off my list of beach retreats, I felt an inexplicable sense of pride and joy. Pride for pulling off my second international travel seamlessly, and joy for discovering a place I'd love to keep going back to.

is paradise Period

A holiday in the Maldives is like entering the world in a picture postcard where a turquoise sea gently laps the virgin sands as warm sunlight peeks through dense coconut groves, and everything is happy as the day is long. One full-fledged flight from Colombo and a seaplane ride from Male (capital of the Maldives), and you are in an island like Robinson Crusoe's where the sea dazzles you with its brilliance like its tropical sun, and the verdant wilderness comes into its own.

If you are arriving at an odd hour in Colombo and halting the night at the airport transit hotel like us, the anticipation for the onward journey can kill you especially if you haven't flown in a seaplane before, and that too, over a gorgeous reef-dotted ocean that changes colours as often as the clock time. Scheduled for an early morning flight from Colombo to Male, we could hardly sleep the night and landed up several hours early at the departure terminal only to discover that there were more like us, even those who chose to snuggle up and catch a wink instead on the waiting chairs. Finally, a little after sunrise we were aboard the SriLankan sailing among the clouds in the faint orange light of dawn enjoying as we did even the not so savoury vegetable burger and tea, musing about dreamy beaches and translucent waters.

Be glued to your window when landing in Ibrahim Nasir International Airport, Male, for you don't want to miss the vista to probably one of world's most scenic airports surrounded by a cobalt blue sea dotted with white speed boats and a strip of tarmac running through its center. But once you arrive, the immigration clearance can be a bit of a dampener as the procedure is lengthy and you find yourself standing in a long queue that barely moves. About an hour later you'll be on the little red bus to the air taxi terminal, or if you please, the speed boat jetty. Now since our resort Adaaran Select Meedhupparu is on an island about 132 kilometers off the Male coast, we thought it best to fly and enjoy the magnificent aerial views. To not carry a good camera on a trip like this is sacrilege as you'll hover over a string of islands, sometimes from up close, sometimes from far behind. And you'll fly over brilliant patches of corals in colours unimaginable the whole time you are airborne.

Forty-five minutes hence we were careering across the bay towards a picturesque wooden pier. As we emerged the last monsoon shower came down sending the resort staff in a tizzy over equipping us with an umbrella and towel each. What a welcome! But none complained. There was so much to behold, the livid sky, the relentless downpour over a colourful sea, the tropical vegetation sapling green in the rain, a white beach, the endangered Maldivian Fruit Bats flying for cover, and divers scampering to the head of the pier. It was surreal, and I couldn't wait to explore the whole 42 acres of this rain and sun drenched wilderness. In time for lunch, our host led us through a

path among overhanging vines and creepers

that opened up to a thatched gazebo-style dining area. The rain had let up by then, the birds were singing again, and we were sitting down to a buffet meal of lobsters, crabs, sauteed vegetables and curries to go with a glass of chilled white wine. It was the beginning of our tropical experience.

We walked around the island a little more before we thought it best to confirm with a staff member the way to our beach villa. The property has on it an array of beach villas scattered around the island affording brilliant sea views. Ours had its deck almost jutting into the sea with a watchtower adjacent to it. First I walked into the sea to get a closer view of the corals, a stone's throw away from the shore. The sand is so soft that it sinks under your feet and can hence be slippery. Don't be surprised to see snorkellers lurking around the shore, for marine life abounds right from there. Simply swim up to your nearest reef and watch the magic unfold as baby Angel fish, Tiger fish and Parrot fish swim out of its crevices.

For fish spotting and some refreshing sea breeze, we walked up the pier on the other end of the island that straddles the reef all the way to the deep blue sea. You'll spot Angel fish in royal blue with yellow strips, the yellow and black striped Tiger fish, the aqua blue Parrot fish with dark blue fins and stingrays swim around with gay abandon. You can sit on the pier for hours and watch the gorgeous marine life. Divers love to launch into the waters from this point. Besides, the pier is a vantage point to get a panoramic view of the beach, the island and its luxurious water villas that stand on symmetry. Their decks have a private pool and a staircase that goes down to the sea, a happy arrangement for diving enthusiasts. Dark clouds were gathering once again, and we decided to head to the poolside bar for a good sundowner. Evenings here are usually about guzzling beer over a game of cards, a quick table tennis match before settling down with a drink or reading in solitude, though the bar gets a lot of action by way of karaoke nights and some live orchestra.

The highpoint of a stay here is certainly the fish feeding session in the night at the pier when the dainty, colourful ones are replaced by predators like Jack fish, Barracudas, Tunas that invade the waters in shoals in search of food. You need to finish dinner early and find yourself a spot on the busy pier to witness this fascinating feeding session where portions of raw fish and crabs are hurled at the shoals of big fish by the hotel staff. My heart went out to the lonely yellow-necked turtle who tried in vain to get through the labyrinth of powerful fish.

Sunset cruise, jet skiing and dolphin spotting, bird watching are among other activities you can pursue at the resort. Else you can pull your sunbed onto the beach and spend hours reading and soaking up the sun. When making your way from one end of the island to the other through the jungle, remember to mind your head as the Fruit Bats hang quite low from the branches and give amused

If unwinding is your idea of a holiday, you shouldn't miss out a nice, rejuvenating therapy at the spa. Typically the spa therapies offered here are avant-garde. After a sauna and steam bath, we went in for a traditional Balinese full body massage with hibiscus aroma oil followed by a refreshing cucumber facial performed by expert masseurs from Bali. Though a tad expensive, you get good bang for your buck. So much so that I went back the next day for a foot massage and manicure!

Seafood lovers, this is your place. From tunas, crabs, prawns, squids, lobsters, cuttlefish, to oysters your options are aplenty. Added to your rice, your broth, grills and curries, they are a core ingredient in every meal. But just as wonderful is sipping the nectar from fresh fruits anytime of the day you please.

At the end of our fourth and last night in the Maldives we still hadn't had our fill of its unpredictable showers, the bright morning sunshine, swimming with fish, the striking colours of the sea reflected in the open sky, the large meals and endless swigs of wine. Like in answer to our prayers it began to rain without ceremony as we took our seats in the little aircraft

How politics, like Bollywood, restricts entry of outsiders

If there's any profession that can match Bollywood in restricting smooth entry of outsiders, it is politics. Even as Iltija Mufti, daughter of former J&K Chief Minister Mehbooba Mufti, makes her electoral debut, here's a study that reveals how 32% of MPs in the current Lok Sabha are political dynasts. Shah Rukh Khans are rare.

New Delhi: In a nation of over a billion people, the most recognisable faces are from the world of films and politics. While millions of Indians dream of attaining the celebrity status of a filmstar or a politician, it is very difficult to be one without being a nepo kid. Not just Bollywood, politics is notoriously restrictive when it comes to allowing the entry of newcomers without family connections. Though Bollywood's gatekeeping tendencies often spark debate and scrutiny, a report by Prajatantra Foundation, a non-profit organisation, highlights how politics mirrors the entertainment industry in erecting barriers for those outside the inner circles. The report reveals that just 20% (around 108) of the candidates winning the 2024 Lok Sabha poll were self-made individuals, while around 32% (more than 173) of the MPs belong to political dynasties.

BOLLYWOOD AND POLITICS, ENTRY ABOTTLENECK

The latest high-profile political entry is that

of Iltija Mufti, daughter of Mehbooba Mufti, the PDP chief and former Jammu and Kashmir CM. Iltija is also the granddaughter of PDP founder and former Union Home Minister, Mufti Mohammad Sayeed.She is contesting the Jammu and Kashmir Assembly election from Bijbehara, a family bastion of the Muftis. How often have you heard that a 37-year-old with near-zero electoral experience has been given a ticket by a prominent party, that too from a safe seat? Although Iltija has asserted her intentions to forge her own identity in politics, she acknowledges having derived a lot from her mother and her grandfather, who are known fces in the politics of Kashmir and beyond.

It's not just about Iltija Mufti. From Rahul and Priyanka Gandhi, Akhilesh Yadav, Tejashwi Yadav, KT Rama Rao to MK Stalin, there is no dearth of politicians heading political parties because they were Indian politics is deeply rooted in family born in their first families. The Yadavs and



Gandhis of the political world will find their nepo matches in the Kapoors, Chopras, Deols and Bachchans of Bollywood.

This is not to say that we do not have an occasional Narendra Modi or a Shah Rukh Khan, who rose from humble beginnings to reach the top. But such examples are rather rare.

The study of the 18th Lok Sabha winners by HOW MPs MADE IT TO LOK SABHA Prajatantra Foundation provides While dynastic politicians clearly dominate compelling evidence of how politics, like Bollywood, remains a bastion for the privileged.

The report used the recently concluded Lok Sabha election, that saw 543 representaties take office, to make its point.Beyond familial ties that sent 32% of MPs to the Lok Sabha, wealth plays a significant role in securing political power.

A staggering 98.3% of MPs possess some form of privilege, translating to more than 530 MPs, whether it be dynastic

connections, declared criminal cases, or assets worth Rs 1 crore or more.More alarmingly, 79.6% of MPs belong to the 'strong privilege' category, characterised by dynastic backgrounds, serious criminal records, or assets exceeding Rs 5 crore.Money, therefore, acts as a predominant gatekeeper, preventing those without substantial financial backing from accessing political offices.

the scene, non-privileged entry is far from a level playing field.Party organisational politics (16.2%) remains the most prominent non-privileged pathway, followed by local politics (14.4%) and student politics (9.2%). In particular, the Bharatiya Janata Party (BJP) sees many non-dynastic entrants coming from local politics, while the Indian National Congress (INC) relies more on party organisational pathways, according to the Prajatantra report.

New Delhi:Climate Central's seasonal analysis from June to August 2024 offers a striking look into the influence of human-induced climate change on global temperatures, with a detailed focus on India. The report leverages temperature anomalies and the Climate Shift Index (CSI) to illustrate the magnitude of climate change's role in raising temperatures across the region.India recorded its second-hottest season since satellite data tracking began in 1970. Over this three-month period, temperatures were at least three times more likely to spike due to climate change for 29 days. Approximately 20.5 million Indians faced temperatures influenced by climate change for at least 60 days (CSI 5), underscoring India's vulnerability to extreme heat compared to other



Southern Asian nations.Of India's 1.38 billion population, around 426 million people - almost a third - were exposed to potentially scorching temperatures for at least seven days, exceeding 90

In Big Step Towards One Nation, **One Election, Cabinet Clears Plan**

New Delhi: The Union Cabinet has approved the government's 'one nation, one election' push - which proposes simultaneous Lok Sabha and Assembly elections, with urban body and panchayat polls to be held within 100 days - accepting the report of a panel led by ex-President Ram Nath Kovind. The proposal will now be tabled in Parliament and must clear both Houses - the Lok Sabha and Rajya Sabha - en route to becoming the law. More significantly, as it will require an amendment to the Constitution and that amendment has to be ratified by all states and union territories.Holding simultaneous poll will "transform the electoral process (and) governance" and "optimise scarce resources", the high-profile panel said, noting 32 parties and prominent judicial figures, including former Supreme Court Chief

Justices and High Court judges, had backed this measure. Among the panel's listed advantages for the 'one nation, one election' measure are that it makes the electoral process easier for



voters. Synchronising polls will also result in higher and faster economic growth, and therefore a more stable economy, the panel argued, claiming a single round of elections will allow

businesses and corporate firms to take decisions without fear of adverse policy changes. The panel has also reasoned that (eventually) holding elections at all three levels - for the Lok Sabha, for state Assemblies, and for panchayats - will "avoid disruption of supply chains and production cycles due to migrant workers seeking leave of absence to cast their votes". The 'one nation, one election' push will also "prevent policy paralysis", and do away with the "atmosphere of uncertainty" the government argues is brought on by frequent elections. The panel, which submitted its report in March, also said it had studied "best practices from other countries", and consulted economists and the Election Commission, before delivering its verdict, but also called for a legally sustainable mechanism.

Perhaps more important than the Fed action would be the Fed commentary and the message.""An ideal and possible outcome would be a 25 bps rate cut with a dovish message indicating a series of rate cuts. Good retail sales data along with a weakening labor market point to such a possibility," he said.

Among the top gainers on Nifty50, Bajaj Finance led the pack with a 3.81% increase, followed by Shriram Finance at 3.10%. Bajaj Finserv also performed well, rising by 1.99%, while Mahindra & Mahindra (M&M) and Hero MotoCorp saw gains of 1.78% and 1.77% respectively. However, some stocks experienced losses. SpiceJet yet to pay Rs 350 crore in TDS, PF of employees

SpiceJet has not paid Rs 220 crore in TDS deductions from employees' salaries between April 2020 and August 2023 to tax authorities.

New Delhi The turbulence for SpiceJet seems far from over as the airline has revealed it has yet to pay Rs 355 crore in Tax Deducted at Source (TDS) and provident fund (PF) contributions owed to employees.

SpiceJet has not paid Rs 220 crore in TDS deductions from employees' salaries between April 2020 and August 2023 to The airline is also facing over 25 pending tax authorities. Additionally, the airline owes Rs 135.3 crore in PF contributions for the same period.In a preliminary placement document (PPD) filed with the Bombay Stock Exchange (BSE), SpiceJet mentioned that Rs 72 crore of TDS for the assessment years 2009-10 to 2013-14 is disputed. The company also mentioned disputes over customs, service

tax, and goods and services tax (GST). In an attempt to stabilise, SpiceJet plans to raise Rs 3,000 crore through a Qualified Institutional Placement (QIP), selling shares to institutional investors. While Yes Bank has approved the QIP, the airline awaits approval from ICICI and Indian Bank.

The funds will primarily be used to pay off Rs 601.5 crore in overdue taxes and contributions, including TDS, PF, and GST. An additional Rs 750 crore will be used to clear debts with creditors, including aircraft lessors, engine suppliers, and financiers. Pending lawsuits

lawsuits, excluding those involving its promoter. Significant defaults under aircraft lease agreements have grounded more than half its fleet, and legal actions by lessors and other vendors are ongoing."We have been in alleged default under several of our aircraft lease agreements, leading to the grounding of a large part of our fleet. This has triggered



legal or enforcement proceedings, including actions under the Insolvency and Bankruptcy Code, 2016, from aircraft lessors and other vendors," said the filing. The airline aims to use a large part of the money raised from the QIP to get its grounded planes back in service. SpiceJet believes that to become profitable in the future, it needs to expand its fleet, increase passenger traffic, and improve earnings.Grounded planes and falling market shareAs of June 30, 2024,

36 of SpiceJet's 64 aircraft were grounded due to financial difficulties and maintenance issues. SpiceJet has also faced multiple fines from the Securities and Exchange Board of India (SEBI) for non-compliance, with at least 20 instances reported in the past three years. The airline had been aggressively expanding before the pandemic, particularly after the collapse of Jet Airways, which initially gave SpiceJet growth opportunities. However, the global halt in travel during 2020, extended restrictions into 2022, rising aviation fuel prices,

and the global grounding of Boeing 737 Max aircraft in 2019 all created significant challenges for the airline.While competitors like IndiGo, with a stronger financial base, managed to recover from the disruptions caused by COVID-19, SpiceJet has struggled. Its market share has dropped below 4%, with fewer than 20 planes currently in operation. Most of its fleet remains grounded due to financial stress and a shortage of spare parts and engines.

Centre asks edible oil industry to maintain prices amid duty hike on imports

NEW DELHI The government has advised edible oil associations to maintain the minimum retail price (MRP) of oil until the availability of edible oil stocks imported at 0% and 12.5% Basic Customs Duty (BCD).

The Secretary of the Department of Food and Public Distribution (DFPD) chaired a meeting with representatives from the Solvent Extraction Association of India (SEAI), the Indian Vegetable Oil Producers' Association (IVPA), and the Soybean Oil Producers Association (SOPA) today to discuss pricing strategies. The leading edible oil associations were advised to ensure that the MRP of each type of oil is maintained until stocks imported at 0% and 12.5% BCD are exhausted. They were also asked to address this matter with their members immediately.Previously, following meetings held by the department with leading edible oil associations, the



MRP of oils such as sunflower oil, soybean oil, and mustard oil had been reduced by the industry. These price reductions were a result of falling international prices and reduced import duties on edible oils, making them cheaper. The industry has been periodically advised to align domestic prices with international prices to lessen the burden on consumers. The

Government of India has increased the basic customs duty on various edible oils to support domestic oilseed prices.Effective from September 14, 2024, the basic customs duty on crude soybean oil, crude palm oil, and crude sunflower oil has been raised from 0% to 20%, bringing the total effective duty on crude oils to 27.5%. Additionally, the basic customs duty on refined palm oil, refined

sunflower oil, and refined soybean oil has increased from 12.5% to 32.5%, making the total effective duty on refined oils 35.75%.

The central government is also aware that there is close to 30 lakh metric tonnes (LMT) of edible oil stock imported at lower duties, which is sufficient for 45 to 50 days of domestic consumption.

NEW DELHI: The government on Tuesday scrapped the windfall tax on domestically produced crude oil, set to take effect from September 18. The tax, imposed as a Special Additional Excise Duty (SAED), was reduced from Rs. 1850 per tonne to nil. This is the second time since the tax was introduced in July 2022 that it has been reduced to nil. The last time the SAED was reduced to zero was on April 4, 2023. The SAED on the export of diesel, petrol, and jet fuel or ATF remains at nil. The windfall tax is levied

fortnightly based on average oil prices in the preceding two weeks. The last revision took place on August 31, when the tax on crude petroleum was set at Rs.1850 per tonne. India first imposed windfall profit taxes on July 1,

2022, joining other countries that tax the excessive profits of energy companies. The levy on exports of petrol, diesel, and aviation fuel was introduced to encourage private refiners to sell fuel domestically instead of exporting it to benefit from higher refining margins.

The decision to scrap the windfall tax comes as global benchmark Brent crude prices have fallen below USD 75 a barrel from over USD 92 a

Wipro implements strict work-from-office policy; **Employees face leave** deductions

- New Delhi. Wipro, a leading IT company in India, has introduced a stringent work-from-office policy mandating employees to be present at least three days a week. Failure to comply with this requirement will result in deductions from their leave balance. In an email sent to employees on September 2, Wipro's management instructed the human resources team to
- revoke any existing work-from-home approvals, emphasizing that any absence from the office would directly affect leave entitlements. According to an employee quoted in reports, missing a day in the office will lead to the deduction of one day of leave for each day not attended. This new directive applies only to certain projects within the company, rather than being a blanket policy for all employees.
- Wipro's decision reflects a broader trend among Indian IT firms aiming to return to in-office work. LTIMindtree has implemented a similar policy requiring employees to work on-site four days a week, while Tata Consultancy Services (TCS) has linked variable pay to attendance, necessitating a full five-day office presence. Infosys has also adopted a three-day attendance rule akin to Wipro's. These changes highlight a growing emphasis on reinforcing office culture as hybrid work arrangements continue to evolve within the industry.

India's richest and poorest states: South leads GDP race, West Bengal stumbles

New Delhi. A working paper from the Instark contrast, West Bengal, once a top Economic Advisory Council to the Prime Minister (EAC-PM), released on Tuesday, has revealed significant disparities in the economic performance of Indian states.

While the southern states - Karnataka, Andhra Pradesh, Telangana, Kerala, and Tamil Nadu — have emerged as major contributors to India's GDP, states like West Bengal, once economically strong, have witnessed a puzzling decline.

Southern states make up 30% of India's GDP

In 1991, the per capita income of the five large southern states was below the national average. However, the liberalisation of India's economy brought rapid growth, allowing these states to surge ahead.By March 2024, these states accounted for 30% of India's GDP. Karnataka, with its booming tech sector, and Tamil Nadu, with its industrial hubs, have been pivotal in this growth.

Telangana, India's youngest state formed in 2014, has also shown impressive economic performance, becoming a major player in India's economy. West Bengal's sharp economic decline

contributor to India's GDP with a share of 10.5% in 1960-61, now accounts for only 5.6%. The state's per capita income, which was once 127.5% of the national average, has dropped to 83.7%. This decline places it below states like Rajasthan and Odisha, which have traditionally lagged behind."West Bengal has experienced a continuous decline in its relative economic performance over several decades," the report said.Despite its strategic maritime location and historical advantages, West Bengal's economic trajectory has been one of steady decline. Experts are puzzled by the state's inability to maintain its early economic strength. The report highlights West Bengal as an anomaly among maritime states, most of which have prospered. The question of what went wrong in West Bengal, particularly with its industrial policies, has been a subject of debate. The state's political climate, which shifted drastically after liberalisation, may have played a role in its economic stagnation.

Punjab's and Haryana's contrasting paths

Punjab, once a beneficiary of the Green



Revolution, has also experienced a flattening of economic growth since 1991. The state's per capita income, which had risen to 169% of the national average by 1971, has now declined to 106%.In contrast, Haryana has seen a sharp rise in per capita income to 176.8%, with much of this growth occurring after 2000. The divergence between Punjab and Haryana is striking, as Haryana, once economically behind Punjab, has now overtaken it in key economic metrics.

Maharashtra still tops GDP but faces challenges

Maharashtra remains India's largest contributor to GDP, though its share has declined from over 15% to 13.3% in recent years. Home to the financial

capital, Mumbai, the state's per capita income grew to 150.7% of the national average by 2024. However, the state no longer ranks among the top five in terms of per capita income. Poorest states struggle to keep pace The report also highlights the challenges faced by the poorest states.

Uttar Pradesh, once contributing 14% of India's GDP in 1960-61, now

accounts for 9.5%.Bihar, despite being the third-most populous state, contributes only 4.3% to the national economy.While Odisha has shown marked improvement, shedding its image as a laggard, Bihar remains far behind other states in terms of economic growth.The report suggests that states have taken dramatically different economic paths since liberalisation. The southern states have capitalised on the reforms, driving national growth. However, the case of West Bengal stands out as an unresolved economic puzzle, as the state continues to fall behind despite its early promise.With these regional disparities widening, the report calls for deeper investigation into the policies and factors influencing state-level economic growth.

ENG vs AUS: Adam Zampa accepts slim Ashes hopes as milestone 100th ODI nears

New Delhi Australia's leg-spinner Adam Zampa is gearing up for a major personal milestone as he approaches his 100th one-day international (ODI) appearance. Despite his significant contributions to Australia's white-ball success, Zampa has come to terms with the reality that his chances of playing in the prestigious Ashes series are slim. Zampa, who played a crucial role in Australia's title win in the 2023 World Cup, is set to reach his 100th ODI cap during the first match of a five-game series against England at Trent Bridge. While his achievements in the shorter formats of the game have been impressive, the 32-year-old has yet to make his Test debut and admits its unlikely he ever will."Realistically, I'm probably not going to play in an Ashes in my career," Zampa said at Trent Bridge ahead of Thursday's clash. "I'm OK with that. We have lots of Test cricket, and there's still a bit of drive to play, but playing in an Ashes, especially against England in England or Australia, doesn't seem to be on the cards."Australia' s Test side has long relied on Nathan Lyon as their go-to spinner in redball cricket. With emerging talents like Todd Murphy and Mitchell Swepson also in the mix, Zampa's opportunities in Test cricket have remained limited. Yet, he remains content with his white-ball career and the rivalry he enjoys with England in limited-overs formats."I think rivalry in any sport gives depth to the games," Zampa noted. "The Ashes has its own charm, but playing against England in any format is special. It's a great rivalry, and it's always a battle we look forward to." As he nears his ODI century, Zampa reflects on his journey with gratitude. "I never thought I'd play this many matches for Australia," he said. "It's an incredible honor to represent your country, and to be doing it for the 100th time is special. Having my family here with me - my wife, son, and parents - will make it an even more memorable occasion."Though Australia will look to defend their 50-over crown at the 2027 World Cup in southern Africa, Zampa is not setting any retirement deadlines. "I'm still enjoying playing for Australia, and as long as I feel like I'm bowling well and contributing, I'll keep going. I love being part of this group, and while I'm still motivated, there's no need to think about the end."

After a thrilling Azerbaijan Grand Prix, it seems like nearly half the field is capable of winning races in Formula 1.McLaren chief executive Zak Brown, whose driver Lando Norris is Max Verstappen's closest title challenger, says he's enjoying the best show he's seen in his eight years in F1.There have been six different winners in the last eight races, representing four different teams. Verstappen, whose dominance in 2022 and 2023 broke records, still leads the standings but his last win was in June."I think this is the



best season I can think of ever in Formula 1 since I've been here," Brown told The Associated Press from the IndyCar season finale at Nashville Superspeedway in Tennessee.Could it even be better than the 2021 fight between Verstappen and Lewis Hamilton, which was decided on the final lap of the year and helped fuel F1's Netflix boom? Brown thinks it might be."That was mega exciting, but it's just two guys, two good guys. Now you've got four good teams in today's race," he said. "To have four teams that can win any weekend, and (Sergio) Perez was obviously back on form today,

eight drivers going into Singapore and we're going 'I don't know which of these four teams might win. I don't know which of these eight drivers might win,' I can't recall Formula 1 having that level of competitiveness."

There was non-stop action Sunday.

McLaren's Oscar Piastri took the win in Baku, but only after a daring overtake on Ferrari's Charles Leclerc. Perez was in the mix for Red Bull until he and Ferrari's Carlos Sainz Jr. collided, handing third to Mercedes driver George Russell.Further back, Norris surged through the field from 15th on the grid to

finish fourth ahead of Verstappen and take another bite out of the champion's standings lead. Teams' performances fluctuate week by week, depending on upgrades from the factories, track conditions and setup changes, like the one which Verstappen blamed for ruining his weekend in Azerbaijan.Even a change of tires can turn an also-ran into a contender, Russell said Sunday."Just in this one race, we had a car that could have won if you took the pace from half of the race and a car that should have been outside the top 10 from the other half," he said, adding: "So I hope we've got the faster version" for next week's race in Singapore. The Singapore street track hosted one of the most competitive races of an otherwise Red Bull-dominated 2023 season. On worn tires, Sainz held off Norris' McLaren and the two Mercedes of seventime champion Lewis Hamilton and Russell, who crashed from third on the last lap.Piastri is F1's on-form driver with the most points of anyone in the last seven races. He knows just how many moving parts are involved in success this year, and how quickly it can all change."We've been in with a chance everywhere, and I think today was definitely one of those days where we weren't necessarily the quickest.

However, it should also be noted that neither the management of ECL nor Munawar has issued any official statement as of now.
