Badlapur accused fires at cop, dies in retaliatory firing protests erupted on streets

Sanjay Kumar Mumbai, Sep 23: The man accused of sexually assaulting two girls at a school Badlapur town of Maharashtra died in retaliatory firing by police after he snatched a cop's gun and opened fire, an official said on Monday. Akshay Shinde, who worked as a sweeper in the school, snatched the revolver of one of the policemen taking him from Taloja jail to Badlapur on Monday, the official said. He was rushed to a hospital in Kalwa where he succumbed to his injuries, the official said. An assistant police inspector, injured in the firing by Shinde, is undergoing treatment at the hospital, he added. When the vehicle near Mumbra bypass, Shinde snatched the revolver of one of the officers in the vehicle and fired two to three rounds, injuring the officer. In response, another offi-

cer opened fire on Shinde,

The school had appointed 23-year-old Shinde on a contractual basis to clean their toilets on August 1. The two minors were allegedly abused in the school toilet on August 12. The accused was arrested on August 17. On September 3, the Bombay High Court told the police to build a "watertight" case and do not file a charge sheet hurriedly under public pressure. New Delhi, Sep. 23: Hardeep Singh Mundian Barinder Kumar Goyal, Tarunpreet Singh Sond Ravjot Singh and Mohinder Bhagat were administered the oath of office and secrecy by Governor Gulab Chand Kataria. It was a quiet and solemn ceremony at the Punjab Raj Bhawan, lasting 20 minutes, with most ministers, some MLAs, senior bureaucrats and families and friends of new inductees in attendance. Chief Minister Bhagwant Mann was present on the stage when the new ministers were called in for taking oath



After taking oath, the newly appointed ministers thanked the CM, hugged him and shook hands. These ministers have been chosen after the AAP top brass did a thorough background check on the inductees, asking for a list of "honest MLAs' from their own party MPs and other senior lead ers. Since the results of the Lok Sabha elections were declared in June, there was a talk of a reshuffle in the cabinet. With this, the total number of ministers in the Bhagwant Mann-led Punjab cabinet has reached 16. This still leaves two vacant berths in the Cabinet, leaving room for more inductions later. The decision to induct the new members was taken on Sunday after the party decided to remove four ministers (Balkaur Singh, Brahm Shankar Jimpa, Chetan Singh Jouramajra and Anmol Gagan Maan) from the cabinet. The four had submitted their resignations yesterday. Earlier in the day, Bhagwant Mann removed his Officer on Special Duty Prof Onkar Singh, reportedly after senior AAP MLA from Delhi Jarnail Singh had complained about the OSD to the CM, during the days of campaign for the Jalandhar bypoll. Onkar Singh, who hails from Lambi in Muktsar, had been appointed OSD to Chairman of Punjab Rural Development Board, a charge held by CM Mann. Before his appointment as OSD, he was working at Punjabi University, Patiala.

Downloading and watching child pornography is crime: SC

New Delhi, Sep 23: Storage of child pornographic material is an offence under the Protection of Children from Sexual Offences Act (POCSO Act), the Supreme Court ruled on Monday. A three-judge Bench led by Chief Justice DY Chandrachud also suggested to Parliament to make certain changes in the Act. Disapproving of the use of the word 'child pornography', the top court said Parliament should amend the POCSO Act to refer to such material as 'child sexually abusive and exploitative material'. "We have suggested an ordinance can be brought in. We have asked all courts not to refer to it as 'child pornography' in any orders," it said. Pronouncing the verdict for the Bench, Justice JB Pariwala set aside the Kerala High Court's verdict which held that mere downloading and storing of child pornography on one's mobile phone couldn't be considered as an offence under the POCSO Act or the IT

Mumbai: Shops oppose classification of illuminated sign boards as ads

MUMBAI. The Federation for Retail Traders Welfare Association (FRTWA) has opposed the BMC classifying illuminated shop name boards as advertising. In a letter sent to the civic body on September 21, FRTWA president Viren Shah called for the removal of Section 328A, Mumbai Municipal Corporation Act, which treats illuminated shop sign boards as advertisements.

The section states, "No person shall, without the written permission of the commissioner, erect, exhibit, fix or retain any advertisement whether now existing or not, upon any land, building, wall, hoarding or structure."

In his letter, Shah said the BMC stated that a non-illuminated name board isn't considered an advertisement. "How illogical is it that once a name board is illuminated with neon lights for visibility at night, it suddenly becomes an advertisement? Multiple courts, including the Supreme Court, have issued stays on criminal notices under Section 328A-a non-bailable offence. Yet, innocent shopkeepers continue to be treated like criminals, facing threats and harassment, despite clear court rulings against this practice."

Shah said, "On one hand the govt is planning to make Mumbai like Singapore with nightlife and shopping to attract shoppers from around the world, and on the other, they want to wrongly send notices that if you put a glow sign on board then it's an advertisement. Any person will laugh at such kind of draconian wrongly interpreted Section 328A. If they do not withdraw these notices and harassment to shopkeepers continue, we will oppose the present govt which is against the traders and we will go one step ahead and call for a retail bandh."which, he insists, they are not.

IIT Bombay struggles to fill reserved faculty positions

MUMBAI. IIT Bombay, like several other IITs and IIMs, is grappling with challenges in filling reserved faculty positions despite a mandate to implement the quota system in recruitment.

Experts highlight that in a country where seats are reserved for backward categories across multiple education levels and PhD requirements for teaching have been relaxed, the shortage of faculty-both in the general and reserved categories-raises serious concerns about the state of education and the uncertain future it signals for the nation's academic landscape.

An RTI filed by the Ambedkar Periyar Phule Study Circle (APPSC) reveals that in 2023, IIT Bombay received 779 applications from OBC candidates nationwide but found none suitable for the positions. Similarly, no ST candidate was selected, while only 4 of the 523 SC applicants were hired. The situation showed slight improvement in 2024, with 2 out of 44 SC applicants, 1 out of 22 ST applicants, and 3 out of 106 OBC candidates being selected. Also, 17 general category faculty were appointed in 2023-24.

The student body stated that the situation is similar across IITs and IIMs. The RTI response to their query states that at IIT Delhi, where many more candidates applied, 6 out of 1,047 SC, 4 of 198 ST, and 16 out of 1,648 OBCs were selected in 2023. In 2021, all IITs advertised for hiring reserved category faculty after the govt mandated reservation in teaching posts. In 2023, education minister Dharmendra Pradhan had informed Parliament that 4,526 posts across the IITs were unfilled.

Surface water meets 69% of state's requirement: Govt

Gandhinagar. A note prepared by the state govt as a preparatory exercise for the distribution of Narmada water to stakeholder states that Gujarat meets 69% of its requirement from surface water, while the remaining is from groundwater sources.

Available water in Gujarat is 55,608 million cubic metres (MCM), of which 38,100 MCM (68.5%) is surface water, while 17,508 MCM (31%) is groundwater. Interestingly, the note prepared by the Gujarat Infrastructure Development Board (GIDB) says that 80% of surface water resources are located in south and central Gujarat, while the remaining 20% are in other regions of the state.Commenting on the availability of surface water, the note said that the state has 185 river basins, eight of which are perennial. These basins are unevenly distributed, with 80% of the surface water resources located in central and southern Gujarat, while the remaining 20% is spread across the remaining regions of the state.

"Gujarat's 1,600km coastline makes desalination a viable alternative. However, it has not been fully utilized due to high costs, the energy-intensive process, and significant capital expenditure for plant setup," the note said. The note added that despite these challenges, some progress has been made in the field of desalination with the setting up of a 100 MLD (million litres per day) desalination plant at Dahej in south Gujarat.

Remote villages in ASR district, Andhra Pradesh remain in darkness

<u>Villages</u> yet to be connected to power grid despite erection of electric poles and creation of other infrastructure

VISAKHAPTANAM. Buruga and Chinna Konela, two remote tribal hamlets in Rompalle Panchayat under Anantagiri mandal of Alluri Sitarama Raju (ASR) district, continue to wait for electricity, despite recent developments in their villages. While electric poles and transformers have been installed, the final stepsconnecting the power supply and installing metres-remain incomplete, leaving the villagers without access to power.

For the Kondh tribes who inhabit these villages, the absence of electricity poses significant challenges. Without lights after

dark, they rely on torches made from wooden sticks to navigate their surroundings, which are frequented by wild animals, including snakes. The lack of electricity also means that many daily



activities must end before sunset, especially for villagers who depend on Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) work and daily wage labour at local brick kilns. The villagers have repeatedly protested the delay in electrification. A few months ago, families in Buruga village faced the loss of livestock when a tiger killed their cattle. Despite notifying the Forest Department, they have yet to receive compensation for the incident.

The electrification process began after continued demands from the community, with the installation of poles and transformers marking significant progress. However, more than two weeks have passed since, and the final steps remain pending. The delay has frustrated the villagers, who are eager to see the completion of the project.

"The electricity connection brings us access to many basic needs, including drinking water and safety after dark. Without power, we cannot install tap water systems in our homes," they explained, adding, "We are happy to see the officials speeding up the work, but we urge them to finish it so we can have electricity in our homes."Ravi Kumar, Executive Engineer (Construction & Operation) at Andhra Pradesh Eastern Power Distribution Company Limited (APEPDCL) Paderu, explained the reason for the delay, saying, "Due to recent heavy rains, the roads were inaccessible. We have completed most of the work and are only left with installing metres in the households. The villages will have electricity within a week."

For the villagers, electricity represents more than just light. "It will allow our children to study and play after sunset, and it will help the elderly move around safely at night. We hope this final hurdle is cleared soon," they added.

The promise of electricity has sparked hope, but the wait continues. The villagers expressed optimism that their long-standing demand will soon be met, improving their quality of life.

Karnataka MSME heads interact with minister Shobha Karandlaje, call for reforms

BENGALURU. The Central government is actively addressing the challenges faced by micro- and small-scale industries with a series of initiatives aimed at bolstering the sector, said Union Minister of State for MSME and Labour & Employment Shobha Karandlaje on Sunday.

At an interaction organised by the Karnataka Small-Scale Industries Association (KASSIA), she also gave a summary of the measures taken by the ministry to boost the MSME sector in the country. The Association submitted a comprehensive memorandum on behalf of MSMEs in the state. Some of the announcements made



by the minister included a proposal to establish a Centre of Excellence for upskilling by the National Small Industries Corporation (NSIC) in Peenya, potential inclusion of KASSIA in the National Board for MSMEs and the rollout of four wage codes to form a National Wage Board.

KASSIA president MG Rajagopal stressed on the need for a holistic approach to ensure MSMEs' survival in the current economic climate. The memorandum highlighted several issues, such as the need for affordable technology, solar power subsidies and reforms in ESIC and EPFO policies. KASSIA also advocated for lower interest rates on MSME

loans and increased credit guarantee coverage to support business growth. Industry leaders, office-bearers and MSME representatives were present.

Karnataka govt plans to replace all 33 crest gates of Tungabhadra dam: CM Siddaramaiah

MUNIRABAD(KOPPAL). Chief Minister Siddaramaiah on Sunday said all 33 crest gates of the Tungabhadra dam will be replaced as soon as possible.As per an expert committee report, the crest present and the government will take necessary steps to save the state's oldest dam, he said after felicitating the team that replaced the damaged crest gate number 19 of the dam. The CM and some members of his cabinet also offered bagina to the Tungabhadra river on the occasion. Siddaramaiah said that after the crest gate was damaged, he was communicating regularly with

top officials and district district incharge ministers of Koppal and Vijayanagara, Shivaraj Tangadagi and Zameer Ahmed Khan, respectively.

"By the grace of God and the team of experts, temporary stop logs at the gate were successfully installed," he said. TB dam is a major water source for agricultural activities in 9,26,438 acres in Karnataka, 6,25,097 acres in Andhra Pradesh and 87,000 acres in Telangana, he said. "Farmers in three states were worried after the crest gate broke. But during my last visit to the dam after the incident, I had said I would come again and offer bagina," he said. "After the crest gate broke, BJP and other leaders

tried to politicise the incident, though it was a technical error. The TB Dam is among the oldest in the state and was constructed in 1953. Crest gates should be changed every 50 years. This is a lesson for everyone," he added.

Deputy Chief Minister and Water Resources M i n i s t e r D K Shivakumar said the hard work by the expert team of 130 completed an impossible task. "I personally thank all those behind this. We will finish the

BENGALURU. With the state government planning to implement the classification of Scheduled Caste reservation following a Supreme Court order that states can decide on the issue, the marginalised Handijogi community (pig rearers) in the state has sought adequate representation for them.

Lawyer HV Manjunath on Sunday urged the government to give more representation to the most backward Scheduled Caste communities while allocating internal reservation. He was speaking at a meeting held by the Akhila Karnataka Handijogis Sangh. "If there is a lack of representation for any caste, it means that the community is backward and if internal reservation is implemented, the most backward Scheduled Castes should benefit," he said.

He suggested that Handijogis mention their caste clearly in the caste census so that the government can know the population of the community. "We have to fight to get our share of internal reservation. There is a need to create awareness. Handjogis are socially and educationally backward, severely backward in employment and political fields. In this background, classification of internal reservation should be done," he said.

From reputed suppliers, Nandini and Alfa Foods. The ghee samples taken from the both have been sent for testing at NDDB and yielded positive results. For reference, the reports indicating the quality of pure and adulterated ghee would be shared with the media to point out variations, he said. He



further explained, "We initiated the process of sending samples to NABL-accredited labs, as they are the only reliable source for testing adulteration. TTD currently has no facility to test for adulteration in ghee, and the testing capacity at our labs is insufficient. Therefore, for the first time, we have begun sending samples to NABL labs to ensure the

quality of ghee used for Laddu Prasadam, and we will continue this practice."A sensory panel of 18 members, trained at Central Food Technological Research Institute (CFTRI) Mysore, has been deployed to evaluate the ghee based on colour, taste, and smell. Only ghee receiving a score of at least 7 out of 9 will be accepted for Prasadam making. Ghee with lower ratings will be rejected, he informed.

NDDB has offered to donate equipment worth Rs 75 lakhs to test the quality of ghee and adulteration, which is expected to be provided by

December. Additionally, the Food Safety and Standards Authority of India (FSSAI) has agreed to set up a lab in Tirumala. The building for the lab is already identified and the same was communicated with FSSAI. Rao emphasized that all necessary steps are being taken to ensure the quality

Riddled with craters, but no revamp now for SPR, GMDA starts patchwork

Gurgaon. GMDA has begun repair work of roads across the city, starting with Southern Peripheral Road (SPR) to fix the extensive damage caused during the monsoon,he SPR, a crucial link for commuters and residents living in new sectors, has been riddled with potholes. According to officials, teams have been deployed to carry out the repairs using bitumen, which is more durable compared to the granular material used earlier for filling potholes.

'We have deployed teams to fix the damaged roads. Now that the rains have subsided, we have started work on master roads across the city, including the SPR. We will ensure that all master roads are in motorable condition," said Arun Dhankar, chief engineer of GMDA (Infra-1 division). Earlier this year, GMDA undertook repairs on one section of the SPR — from Ghata T Point to Vatika Chowk. However, the remaining stretch, up to SPR-CPR junction, was left out, leading to deteriorating conditions exacerbated by heavy rainfall and poor drainage system.

Commuters expressed their dissatisfaction over the poor condition and pointed out that potholes not only disrupted traffic flow, but also posed a risk to vehicles and pedestrians alike. "The entire SPR has turned into a dust bowl. If GMDA has undertaken repair works to fix the stretch, it is a welcome respite. I hope it is not an eyewash," said Dhirender Kumar Singh, a resident of sector 78."Road dust is also the biggest contributor to air pollution. GMDA should complete the works before GRAP comes into effect in Oct," Singh added.

In addition to repairs on SPR, GMDA said plans are in place for recarpeting major arterial roads from sectors 81 to 95. However, these projects were delayed due to imposition of the model code of conduct, which restricts the allotment of new work. Once the model code of conduct is lifted, tenders will be allotted for these works too, said officials." Most of the roads from sectors 81-95 have been maintained through patch repair since they have been transferred to GMDA from HSVP. We have already called the tender for special repair and upgradation (of Manesar-Dwarka Expressway road) for the improvement of roads in these sectors. We hope to get the approvals soon,"

15 days and counting: Water pipe leakage leads to huge wastage, leaves roads inundated

Gurgaon. Citizens of Sector 22B have alleged inaction on the part of MCG in addressing leakage from a water pipeline near the community centre that was first detected 15 days ago. Water was gushing out of the pipeline and flowing onto the road, leading to a huge wastage in the area that has been marred by water scarcity especially during summer, they said.

The residents, who largely depend on GMDA's limited water supply and MCG tubewells, are also faced with the problem of stagnant water accumulating in large pools on roads, attracting mosquitoes and other pests.

"We have informed the municipal authority of the issue, but no action has been taken so far. It's disheartening to see such a precious resource being wasted, especially when GMDA's supply is already scarce and we are dependent on tubewells to fulfil our daily needs," said Bhim Singh Yadav, RWA president of Sector 22B.

"Moreover, the area has become a breeding ground for mosquitoes. We urge the MCG to address the issue promptly and fix the leak on priority," he added.

The leakage has also deteriorated the condition of the roads, with water seeping into the cracks and weakening the asphalt, they said, adding that the community centre too, was surrounded by muddy water, making it difficult for residents to access the facility."Water always flows onto the roads during supply hours. Moreover, the drainage system is not proper, causing both the leakage and rainwater to stagnate near my house. The road is starting to get damaged, and its surface has become slippery, making it dangerous for passersby, especially the elderly," said Shyam Sunder Muttreja, a resident.Meanwhile, a senior official of MCG said that the matter had not been brought to his knowledge. "However, I will direct the officials to check and get the issue rectified on priority," he added.

In Ggn's 4 assembly seats, 2way fight likely, with an edge to BJP

Gurgaon. Voters in the four assembly seats of Gurgaon mostly elected Congress till 2014, but from there on, BJP has won all the constituencies from the district apart from one.2014 was also the first time that BJP formed a govt in Haryana with full majority. Before that, Sita Ram Singla was the only BJP candidate to have won the Gurgaon assembly seat.

But the party has been dominant in the last 10 years.

In the 2014 Haryana assembly polls, BJP candidates won all four seats - Gurgaon, Badhshapur, Sohna and Pataudi. This trend continued to 2019, with the exception of Badshapur, which elected Independent candidate Rakesh Daultabad. the state's 90 assembly seats, the two largest constituencies in terms of voter count are in Gurgaon.Badshapur has 5.2 lakh registered voters, and Gurgaon is second, with 4.4 lakh voters. The south Haryana district, now a saffron stronghold that Congress could not clinch even in the Lok Sabha elections held earlier this year, is particularly significant for the state, considering more than 70% of the state's revenue comes from Gurgaon.

Regional party INLD was once a major player in the Gurgaon seats, but it too has fallen by the wayside since 2014. In the last four state elections, it won just once when INLD candidate Ganga Ram won Pataudi in 2009 by clinching 51% vote share from the constituency.In the last assembly polls, INLD candidates received just 2.5% of the votes from all four Gurgaon seats. JJP, INLD's breakaway party, has never won a seat from the district, but it still fared better than INLD in 2019.

NCLAT asks buyers & lenders to file feedback on NBCC's Supertech plan

Noida. National Company Law Appellate Tribunal (NCLAT) has asked 27,000 homebuyers and other stakeholders to submit objections, if any, to a proposal by National Buildings Construction Corporation Ltd (NBCC) to complete delayed Supertech projects.

On Sept 19, NCLAT asked the interim resolution professional to look into the concerns of homebuyers, compile a report on objections and suggestions from lenders and landowners as well and upload it on Supertech's website in two weeks. The stakeholders, who have been waiting for years for the completion of projects — many of which are stalled over funds — recently filed an application with NCLAT. Their key demands included an assurance against cost escalation of flats, a forensic audit of accounts to find out if there was any funds diversion and removal of all the then promoters. The tribunal will now review the objections and suggestions on Oct 21 and weigh them against NBCC's

proposal."Counsel for Noida, Greater Noida, landowners, lenders, the Yamuna Expressway Authority of India, and the homebuyers are granted two weeks to file objections to IA No. 6557 of 2024 (filed by NBCC). These objections should also be submitted to the IRP. All objections will be tabulated by the IRP, and the substance of the objections will be presented in chart form to the court on the next date of hearing so that NBCC's application and the objections can be considered and resolved. All lenders, homebuyers, landowners, and banks are permitted to e-file the objections with a copy sent to the IRP," read the Sept 19 order by NCLAT chairperson Ashok Bhushan and technical member Barun Mitra.Responding to an appeal from homebuyers, NCLAT had in May this year instructed the IRP to engage with NBCC and explore the possibility of the govt-backed construction company to take over the delayed Supertech projects, just like it had done in the case of



Amrapali

NBCC, subsequently, came up with an extensive plan to complete 50,000 flats across 17 Supertech projects in three years. It asked NCLAT for permission to act as the project management consultant. NCLAT asked NBCC to take prompt action and submit a detailed project report.

The tribunal also heard matters related to Supertech's Doon Square project in Dehradun. Bank of Baroda, one of the company's principal lenders, had recently proposal for the project. There are 750 units in the project, of which 150 studio apartments have been handed over.Bank of Baroda's proposal outlines specific conditions, including an initial deposit and a structured repayment plan contingent on NCLAT's clearance. The next hearing for Doon Square is scheduled for Sept 25, when NCLAT will review the terms of

the OTS approved by the bank and determine the next course of action.

It was in June 2022 that NCLAT limited insolvency proceedings against Supertech to just one of its projects, Ecovillage 2, using reverse CIRP. This allowed Supertech to maintain control over the project's execution in the presence of an IRP. The Supreme Court upheld this decision in June 2023, allowing for a project-wise resolution

FAR rates for large plots goes up 20%, home construction set to get costlier

Gurgaon. Construction of large properties is set to become costlier, with Haryana's department of town and country planning (DTCP) increasing rates for purchasing floor area ratio (FAR) by around 20%. It is the first hike since 2016.Officials told TOI on Sunday that the increase in rates is meant to address rising demand for land in cities like Gurgaon, where population density is rapidly growing.

FAR is the ratio of a building's total floor area to the size of the plot/land on which it was built.DTCP additional chief secretary Arun Kumar Gupta on Sept 10 issued the directive, which specified that there are no changes in FAR rates for plots up to 250sqm.For plots between 250sqm and 350sqm, the new FAR rate is Rs 4,500 per sqm, up 19% from Rs 3,770/sqm. The revised rate for plots between 350sqm and 450sqm is Rs 6,500/sqm, up 21% from Rs 5,380 earlier. The hike is almost

24% for plots larger than 500sqm. The FAR purchase rate for this category was Rs 8,070/sqm and goes up to Rs 10,000 per sqm.A DTCP official said apart from encouraging city planning, revenue earned from increased FAR rates will be given to the municipal corporation for development.But developers said the move could slow down large projects and substantially increase construction costs, forcing realtors to push the burden on homebuyers."A 20% increase in FAR rates will certainly impact construction costs for larger plots in Gurgaon. While this move is aimed at boosting municipal development, it poses a significant challenge for developers and individual homeowners, especially those working with tight budgets. The additional financial burden may slow down large-scale residential projects and could potentially shift demand towards

smaller plots. Developers will need to reassess their project budgets and pass some of the cost to buyers, which may affect property prices in the area," a developer said. Deepak Verma, a city resident, said the increase in FAR rate was worrying. "This makes it harder for people like us to afford homes, especially in a city like Gurgaon where prices are already high," he said.

The DTCP directive said there won't be an option to purchase additional FAR for plots up to 75sqm. The existing FAR rate for plots between 75 and 100 sqm remains at Rs 1,615 per sqm.

According to officials, the changes have been communicated to Haryana Shahari Vikas Pradhikaran (HSVP), town planning departments, urban local bodies (ULB) department, HSIIDC and other relevant agencies. All departments have been instructed to update their processes in line with the revised FAR pricing structure

60-yr-old dies after e-bike he hired takes an illegal cut to Dwarka e-way, hit by car

Gurgaon. A 60-year-old man on his way to hospital for dialysis succumbed to head injuries he suffered after the Uber bike he had hired allegedly took an illegal cut to enter Dwarka Expressway and was hit by a car from behind.

Ramchayan died at AIIMS trauma centre around 11am on Sept 20, two days after he met with the accident near pillar number 58. According to his family, he was not given a helmet by the Uber rider who accepted the booking. At the hospital, Ramchayan could not recognise anyone, his family said. When his son, Abhishek, called out to him in the ICU, all he replied was 'bhaiyya'. That was the last they heard from him.

Around 2.30pm on Sept 18, Abhishek had booked an Uber Moto to take his father from their house in Shankar Vihar to SGT Hospital for the dialysis. The bike, according to his family, got onto the expressway using an unauthorised cut to reach the hospital faster. A car – possibly a Maruti Swift - that was cruising on the speedway crashed into the bike from behind, causing it to skid on the cratered road.Ramchayan, who was oozing blood from head injuries, was rushed to nearby JSR

Haryana govt school students can apply for scholarship under Centre's scheme

GURGAON. Students in Class 8 of govt schools in the state can now apply for scholarships. The National Means-cum-Merit Scholarship Scheme (NMMS) is being implemented across the country by the department of school education and literacy under Union ministry of education. It has already been rolled out in many states. Asked if launching the programme was a violation of model code of conduct, an official said it's a centrally sponsored programme, the budget for which is allocated by the Union govt.Online applications for the scholarship will be accepted till Oct 10. After the application process ends, a written examination will be conducted at the district headquarters between 11am and 2pm on Nov 17.Students who pass the examination will receive the scholarship from Class 9 to 12. "Students qualifying for the programme will be given an

annual scholarship of Rs 12,000. Every month, Rs 1,000 will be deposited into the students' bank accounts for buying notebooks, pens, school bags, shoes, and other necessary items," an official of the school education department said. The combined annual income of the applicant's parents must not exceed Rs 3.5 lakh from all sources, in order to be eligible for the scholarship. Applicants should also have scored a minimum of 55%

marks in class 7 (or 50% marks for those from reserved categories).

Kamala Harris to unveil new economic policies on US wealth creation this week

World US Vice President Kamala Harris plans to roll out a new set of economic policies this week that aim to help Americans build wealth and set up economic incentives for businesses to aid that goal, three sources with knowledge of the matter said. The new policies, which have not been previously reported and could be announced in Pittsburgh on Wednesday, come as undecided voters continue to ask for more information about how Harris would help them economically if she were elected president in November, including those in critical swing states, the sources said. The rollout would follow heated debate in Democratic circles over whether releasing more economic policies so close to election day is a smart strategy."It's not just about affordability, it's also about showing (voters) they have a path to building wealth," said one of the sources with direct knowledge of Harris's economic plans, adding the weather that the show Americans have adding she wanted to show Americans how they can "get a foot in the door."

None of the sources would provide specific details on the expected new policies, and the Harris campaign would not comment on any new proposals. However, Harris' 2020 presidential run and President Joe Biden's administration included plans with similar goals.In her 2020 campaign, Harris proposed significant pay hikes for the millions of public school teachers, forcing companies to disclose their pay gap between men and women and penalising those who are not narrowing it. The Biden and Harris administration have pushed to eliminate bias in home appraisals and use the over \$700 billion federal contracting budget to buoy minority businesses. Harris has released a basket of economic policies focused on the high cost of housing, taxes, small business expenses, childcare and goods. Her plans often build on Biden's policies, like increasing the child tax credit and lifting the corporate tax rate to 28%.

Campaign spokesman James Singer did not comment on the story. He told Reuters that Harris "will continue to present her opportunity economic agenda to lower costs, make housing more affordable, and spur economic growth across America."

Israel probes possibility of Hamas leader Yahya Sinwar's death in strike: Report

World Israel is investigating the possibility that Yahya Sinwar, the leader of Hamas, was killed in a rocket strike on Saturday that hit a school sheltering displaced Palestinians in Gaza City, a media report said. The Israeli military said the attack targeted a Hamas command centre, but Palestinian health authorities said that women and children were among the 22 people killed in the strike.In a report on Sunday, the Times of Israel said that officials were investigating the possibility that Sinwar is dead, following up on military intelligence, as reported by Israeli journalist Ben Caspit.

"The Walla news site notes that the Shin Bet has rejected the report and believes that Sinwar is alive. The intelligence being investigated holds that Sinwar was killed during IDF operations in Gaza", the news report added. The Times of Israel added that Caspit reasoned that Sinwar might not be dead looking at his history, when he disappeared after past strikes and speculations of his death started making rounds.Reacting to speculations around Sinwar's death, Israeli journalist Barak Ravid said in a post on X, that officials with direct knowledge have told him that Jerusalem doesn't have the information that could confirm the Hamas leader is dead.

Rescue workers search for at least six people missing after heavy rain pounds Japan's Noto region

TOKYO. Rescue workers were searching for at least six people missing on Sunday after heavy rain battered Japan's north-central region of Noto, triggering landslides and floods, and resulting in one fatality in an area still recovering from a deadly earthquake on January 1The Japan Meteorological Agency issued the highest alert level for heavy rain across several cities in Ishikawa Prefecture on Saturday, including the severely impacted cities of Suzu and Wajima along the northern coast of the Noto Peninsula. Although the agency has since downgraded the heavy rain alert, landslide and flooding warnings remain in effect.;In Suzu, one person was confirmed dead and another was reported missing after being swept away by floodwaters. Another individual went missing in the nearby town of Noto, according to local officials. In Wajima, rescue workers were searching for four people who went missing following a landslide at a construction site where 60 workers were repairing a tunnel damaged by January's earthquake.; The Fire and Disaster Management Agency (FDMA) also reported one more person missing due to flooding in a different part of the city. Footage from NHK showed a wooden house in Wajima torn and tilted, apparently due to a landslide, though no injuries were reported from that site.

US boy kidnapped from California at age 6 in 1951 found aav live 70 years laterazz

World Luis Armando Albino was 6 years old in 1951 when he was abducted while playing at an Oakland, California park. Now, more than seven decades later, Albino has been found thanks to help from an online ancestry test, old photos and newspaper clippings. The Bay Area News Group reported Friday that Albino's niece in Oakland with assistance from police, the FBI and the Justice Department - located her uncle living on the East Coast. Albino, a father and grandfather, is a retired firefighter and Marine Corps veteran who served in Vietnam, according to his niece, 63year-old Alida Alequin. She found Albino and reunited him with his California family in June.On Feb. 21, 1951, a woman lured the 6-year-old Albino from the West Oakland park where he had been playing with his older brother and promised the Puerto Rico-born boy in Spanish that she would buy him candy.Instead, the woman kidnapped the child, flying him to the East Coast where he ended up with a couple who raised him as if he were their own son, the news group reported. Officials and family members didn't say where on the East Coast he lives. For more than 70 years Albino remained missing, but he was always in the hearts of his family and his photo hung at relatives' houses, his niece said. His mother died in 2005 but never gave up hope that her son was alive.;Oakland police acknowledged that Alequin's efforts "played an integral role in finding her uncle" and that "the outcome of this story is what we strive for."In an interview with the news group, she said her uncle "hugged me and said, 'Thank you for finding me' and gave me a kiss on the cheek.";Oakland Tribune articles from the time reported police, soldiers from a local army base, the Coast Guard and other city employees joined a massive search for the missing boy.

Cop killed, 3 injured in blast targeting foreign diplomats in Pakistan

a critical condition, hospital authorities said.



"All the diplomats are completely safe. The improvised explosive device targeted the convoy of police that was on security duty," the police official said. The Pakistan Foreign Ministry in a statement said the group of

diplomats has returned safely to Islamabad and expressed sympathies with the family of the deceased police officer.The Foreign Ministry said an advance scout police vehicle was hit by the IED which resulted in the police officer death."We honour our law enforcement authorities that remain steadfast in the face of terrorists. Such acts will not deter Pakistan from its commitment towards the fight against terrorism," the ministry said. The diplomats and their families were

going to Malam Jabba, a hill station, for a night stay. Under tight security, they were escorted back to Islamabad. Around 40 per cent cities, regions not meeting CO2 emission cut goals: Survey

World More than 40% of major companies, cities and regions have still not set any targets to cut greenhouse gas emissions, according to an annual "stocktake" released on Monday to gauge global progress in the fight against catastrophic climate change. While more governments and enterprises have issued net-zero pledges since last year, their attention has been further diverted by wars, elections and economic challenges, leaving a significant "commitment gap", said Net Zero Tracker, a coalition of research groups at the University of Oxford. As countries prepare to submit new 2035 climate targets to the United Nations, policymakers and company boardrooms are struggling to translate long-term goals into concrete action, with transition plans still lacking robustness and detail, the researchers said."A common theme throughout this report is the persistent lack of integrify across the board," said John Lang, who heads Net Zero Tracker's Energy and Climate Intelligence Unit. The report looked at net-zero commitments and action plans from



198 countries, 706 sub-national regions, 1,186 cities and nearly 2,000 publicly-listed companies.;

They found that while 1,750 entities out of more than 4,000 had made formal net-zero pledges, nearly 1,700 hadn't set targets of any kind.';Among the listed firms, just under 60% had set net-zero targets, up 23% since last year's report, with a significant rise in pledges from Asia. The total number of companies with no emissions targets dropped to 495, from 734 last year. They include electric vehicle makers Tesla TSLA.O and BYD 002594.SZ, Nintendo 7974.T and Berkshire Hathaway BRKa.N, Net Zero Tracker said.The report cited Costa Rica, Volvo VOLVb.ST and

as examples of "good practice" when it comes to implementing netzero pledges. However, only 5% of regions, cities and com; anies met all of Net Zero Tracker's criteria for "robustness" - which include having detailed plans to phase out fossil fuels, it said. Around half of the regions, cities and compani;s have failed to set targets for non-CO2 greenhouse gases like methane, and many firms also failed to account for emissions across their entire value chains or clarify how much they will rely on offsets to meet targets.As many as 148 states covering 88% of the world's total population have netzero commitments, with Mexico, Iran and Azerbaijan, host of the COP29 climate talks in November, amongst the exceptions, the report said. Technologies exist to triple the current levels of climate ambition, and the next round of nationally determined contributions (NDCs) submitted to the U.N. needs to provide more details about how targets will be implemented, it

She said she would undertake some limited engagements through the end of the year. While she stepped away from most public duties during her treatment, Kate made two appearances earlier this year. First, during the king's birthday parade in June, known as Trooping the Colour, and most recently during the men's final at Wimbledon in July, where she received a standing ovation.

668 cr sanctioned for constructing concrete rural roads

Gandhinagar. The state govt on Sunday said that a sum of Rs 668 crore has been sanctioned to convert 787 panchayat roads into concrete roads. An official statement said that the amount will be used to convert 1,020 kilometres of asphalt roads into concrete

The govt said that as a result of water accumulation and traffic movement, sections of asphalt roads get deteriorated. As a permanent solution to the problem, an allocation of Rs 668.30 crore has been made to construct 5.50 metre wide roads. In cases where concrete roads cannot be built, paver blocks will be used, the statement added.

The recent spell of rain in most areas of the state and subsequent water logging has damaged the road network to a large extent. The funds from this scheme will be used for strengthening roads in village areas of the state, the statement added.

Gujarat couple held in Delhi with forged Canada visas

AHMEDABAD. A couple from Mehsana were caught at Indira Gandhi International (IGI) airport in Delhi with forged Canadian visa stamps just before they were to board a flight to Toronto on Sep 15. Now, a team from Delhi Police is camping in Gandhinagar to search for the human smuggler from Mehsana.

According to a complaint filed at IGI Airport police station on Sep 15, Ashishsinh Chavda, 22, and wife Priyanka, 20, from Kada in Visnagar, were apprehended at the airport before they were to board an Air Canada flight to Toronto on counterfeit visas. "The couple were to board flight number AC-43, but while conducting document checks, airline staff discovered fake visa stickers on their passports. The stickers were affixed on seventh page of their passports, with serial numbers E741959470 and E741959471," the FIR states.

'The flight they were supposed to board was scheduled to take off from the Delhi airport at 10.50pm on Sep 15. Police have registered a case against the couple under Sections 318 (4) (cheating), 336 (3) (forgery) and 340 (2) (producing forged documents as genuine) under the Bharatiya Nyaya Sanhita (BNS) as well as Section 12 of the Passport Act for using a forged travel document," the FIR

Couple had planned to illegally enter the US According to sources at the IGI airport, during their four-day police remand, the couple told the investigating cops that they had sought the assistance of a visa agent from Kalol town in Gandhinagar to obtain visitor's visas

Sources at the IGI airport said the couple had planned to illegally cross into the US from Canada and their agent had even assured them of a job in the US. After the couple's confession, a Delhi Police team reached Gujarat and has been camping in Gandhinagar to trace the human smuggler who is on the run. Earlier, on Aug 22, Krupesh Patel, a man from the Ranip area of the city, was caught at the IGI airport in Delhi for allegedly trying to travel to Canada on a counterfeit visa stamp. This was his second attempt as he had been caught in 2019 at the Mumbai airport while trying to board a flight to Canada on the same forged visa.

Recently, Yash Prajapati, a 22-year-old man from Nardipur in Kalol taluka of Gandhinagar, died of a heart attack while attempting to cross the Canada-US border to enter the US. On Saturday, his body was sent to his native place, where he was cremated.

Ahmedabad. For the first time since 2014, the solid waste management department of the Ahmedabad Municipal Corporation (AMC) is set to revise debris disposal rates, following an intimation issued by the municipal commissioner.

The proposal will be placed before the health and solid waste committee on Monday for approval. The city's debris management rates have remained stagnant for nearly a decade, are now long overdue for an update.

The revision aims to address not just the increase in debris generation but also the operational costs involved in transportation and disposal. The municipal commissioner's letter also outlines a new Standard Operating Procedure (SOP), which all sectors - be it private properties, govt departments, or residential areas - will be required to follow. Additionally, the strengthening of the dedicated C&D debris cleaning squad is also on the agenda, ensuring that the new guidelines are implemented effectively.

The previous rate revision took place in 2014. Since then, the city has witnessed a surge in construction and renovation projects.

The AMC has set up 26 designated plots across the city for free debris disposal. However, citizens also have the option of lodging a complaint via the Comprehensive Complaint Redressal System (CCRS) number 155303, or via the municipality's website or mobile app.

Telangana government likely to amend GHMC Act to confer powers on HYDRAA

HYDERABAD. A day after the Cabinet granted statutory status to the Hyderabad Disaster Response and Assets Monitoring and Protection Agency (HYDRAA), it is learnt that the government is all set to promulgate an ordinance amending the Greater Hyderabad Municipal Corporation (GHMC) Act.

Sources said that officials are currently drafting these amendments, adding that a new act for HYDRAA will not be created, rather the existing GHMC Act will be amended to confer powers to HYDRAA.

Currently, powers to protect lakes, water bodies, parks and other public spaces in Hyderabad are held by HMDA, GHMC and HMWSSB. Some lakes are also protected under the WALTA act, overseen by district collectors and tahsildars. The Cabinet's decision will delegate similar powers to HYDRAA without removing those from existing organisations.

After the amendments, both HYDRAA and GHMC will work simultaneously to safeguard water bodies with the Outer Ring Road, including the recently added 27 Urban Local Bodies and

51 Gram Panchayats in GHMC. An official told TNIE that the government has sought legal action to avoid legal challenges. The official said: "There will



not be large-scale amendments, only one or two additional sections will be added to

CCTV cameras to monitor water bodies in city Meanwhile, sources reveal that to enhance lake protection, the Cabinet has decided to monitor lakes and water bodies with CCTV cameras and link them to Integrated Command and Control Centre (ICCC), and said that the chief minister believes in the need for continuous monitoring through ICCC.

Climate change led to floods: Collector G Srijana

VIJAYAWADA. G Srijana, NTR District Collector, attributed the recent disaster in Vijayawada to the growing impacts of climate change, stressing how the region's infrastructure narrowly averted a more severe crisis. She highlighted the importance of structures like Nagarjuna Sagar, Puli Chintala, and Almatti barrages, which helped manage the floodwaters. Built 67 years ago with a capacity of 11 lakh cusecs, the Prakasam Barrage faced unprecedented pressure during the recent heavy inflows. She raised concerns about the barrage's capacity to handle future disasters without additional infrastructure improvements.

Speaking at the Collectorate, she detailed the scale of the crisis, which resulted in 43,000 cusecs of water from the Budameru catchment area submerging low-lying areas and farmland. The Velagaleru regulator and the G Kondur region both recorded around 90 cm of rainfall, compounding the floodwaters in the Krishna River. She pointed out that if the Velagaleru gates had not been lifted, the regulator gates might have collapsed. The weak Budameru bund was another contributing factor to the disaster. Chief Minister N Chandrababu Naidu played a crucial role in managing the crisis, monitoring relief efforts for over ten days and launching 'Operation Budameru' to address the issue permanently. This initiative targets canal encroachments, with 270 acres of agricultural land, 80 structures, and 3,000 homes identified for action. In response to the flood, 4,036 enumerators carried out re-verification across 179 secretariats, identifying 1.75 lakh homes in flood-hit areas. Financial relief was swift, with Rs 157.85 crore processed for 2,740 accounts within three days. Insurance claims were handled by 20 companies, and over 2,000 workers provided additional relief

Police arrest main accused in petrol pump attack case in

THIRUVANANTHAPURAM: The main accused in the Ooruttambalam petrol pump attack case was arrested by Maranalloor police on Saturday. Adarsh, 27, a native of Balaramapuram, was arrested from Kollam where he had been lying low since the incident that took place on

February 4 this year. According to the police, Adarsh led an eight-member gang that attacked the petrol pump staff and looted Rs 25,000 from them. The gang had arrived at the petrol pump under the guise of filling fuel. After refilling, two of the bikes drove away after refusing to pay cash.

The pump staff questioned the group members over the matter. During the altercation, the gang members, some of them having criminal cases against them, attacked the pump staff and decamped with the collection bag that allegedly had Rs 25000 in it. This incident created a big furore, prompting the police to take strong action. The police registered

cases against eight people, who all went into hiding as the investigators began tracking them down. Seven of them were nabbed two months later from their hideouts. Adarsh, the first accused, meanwhile fled to Kollam and thus managed to evade the cops for some time. The police, meanwhile, got information about his presence in Kollam and took him into custody. The Maranalloor police said Adarsh has a strong criminal

Woman regains ability to walk after complex spine surgery at Kimshealth Hospital in Thiruvananthapuram

THIRUVANANTHAPURAM. A 52- As her spinal curvature worsened, she year-old woman from Kottarakkara who had been paralysed for months due to a complicated spinal condition has regained her ability to walk following a complex surgery at Kimshealth Hospital. The patient suffered from upper thoracic kyphoscoliosis, a rare spinal deformity characterised by abnormal inward and lateral curvature, which caused paralysis of both legs.

Despite experiencing symptoms earlier, the woman delayed surgery due to concerns about the risks involved. Her condition was further complicated by neurofibromatosis, a genetic disorder that leads to tumour growth on nerves

lost control of her bladder and bowel function. The medical team headed by consultant Orthopaedic Spine Surgeon, Dr Ranjith Unnikrishnan, recommended a complex Posterior Vertebral Column Resection (PVCR) surgery to correct the spinal curvatures and relieve pressure on the spinal cord. The procedure involved reconstructing the spinal column with titanium rods and cages.

After a 14-hour surgery, the patient started walking within ten days.

Dr Jacob John Theophilus, Dr Ashwin C Nair, Dr Anoop Shivakumar, Dr Pradeep Moni V B and Dr Jerry John were also part of the surgical team.

Krishna village craves for basic amenities

VIJAYAWADA. Residents of Nagavaram village in Krishna district are facing hardships due to inadequate infrastructure, including poor road connectivity, drinking water crisis, limited transportation, and inadequat medical services. The village is split between two Assembly constituencies, two mandals, and two panchayats, resulting in a lack of accountability, with no leader or official taking responsibility for the issues.

The jurisdictional split has caused confusion and inaction, with 200 of the 350 families in the village falling under Mukkolu Panchayat of Guduru mandal in Pedana constituency, while the remaining 150 families are part of Vemavaram Panchayat, Gudlavalleru mandal of Gudivada constituency. This division has hampered efforts to address the village's common problems effectively.

One of the major concerns is the lack of educational infrastructure. The only government primary school in the village was closed and merged with an Urdu school, forcing students to travel six kilometres to Kautavaram or Vadlamannadu for high school education. College students must go to Gudlavalleru



or Pedana towns. While a private school bus from Pedana operates, most students have to walk three kilometres to catch it due to the absence of proper road connectivity. "The road problem affects us the most," said local resident Karra Veerababu. "When it rains, the gravel road becomes impassable, causing accidents and injuries to children on their way to school. We request Chief Minister N Chandrababu Naidu and Deputy Chief Minister Pawan Kalyan to help pave a proper road."Villagers must walk several kilometres from Vemavaram to reach the village, as auto drivers refuse to enter,

citing the poor condition of the roads. This poses difficulties for the elderly and pregnant women in need of medical care.

salty. Women are forced to walk at least a kilometre to fetch water from wells. Though water is supplied through street taps every two days, it is not drinkable. We urge the authorities to provide safe drinking water," said senior citizen Daram Pushpavathi.Daram Suresh, a resident, urged the CM to unify the

After 40 years, Alangad jaggery makes a sweet comeback in Kerala

"Groundwater in the village has turned KOCHI. Alangadan Sharkara is back. It has been disappeared from the shelves in Kerala. Now, the first batch of homegrown and homemade Alangad jaggery has re-entered the market. Having worked continually for around three months, the sugarcane-processing unit at Alangad has started churning out jaggery. So far, the unit has produced a total of 1,000kg of jaggery, which is priced at Rs 180 per kg.

Industries Minister P Rajeeve told, "For now, sugarcane for the production of Alangadan Sharkara is being cultivated on a 16-acre farm. The aim is to expand the cultivation to 50 acres." He said the project was launched as part of the

'Krishikkoppam Kalamassery' initiative that envisions the development of agriculture in the village. "Under the initiative, water bodies are being restored, irrigation systems are being



improved, and efforts are being made to bring back traditional agricultural produce and to create value-added products from them," Rajeeve said. According to Alangad panchayat president P M Manaf, the crop is being cultivated at Neerikode, Kongorpilly and Thiruvallur. "The initiative is receiving all

support from the Ernakulam Krishi Vigyan Kendra (KVK), Alangad Cooperative Bank, Krishi Bhavan, agriculture department, Atma, and Alangad block panchayat," he added.

Further, Rajeeve said some of the texts associated with Kerala's trading history mentions Alangad jaggery. "It is said that the jaggery was even exported to China in the distant past. The jaggery was said to have medicinal properties. The different taste has been attributed to the quality of the soil where it grows. Unlike jaggery from other areas, Alangadan Sharkara is known for its pure sweetness. And this is what made the jaggery famous and was considered to be fit for royal families," the minister said. According to Jayaprakash, of the Alangad Cooperative Bank, full-fledged production using the entire harvest from the 16 acres will happen by February or march 2025.As per a document by ICAR-KVK Ernakulam, the sugarcane, particularly in the Periyar basin, holds significant historical significance in Kerala for its production of jaggery. "Despite the rich history, sugarcane farming in Kerala faced challenges like low profitability, high labour costs, and competition from cheaper alternatives, leading to a decline in quality and quantity of jaggery, particularly the renowned Alangadan Sharkara," it said.

Playing for country, for money

Sania and Bopanna won the first set 6-2, and we fans, sports writers, coaches, Indian sportspersons — were hoping for an encore in the second... All except the anxious legend. He didn't want Sania and Bopanna to win a silver – or any medal! — because he had not been picked to partner Sania in the Olympics. Sania-Bopanna were, also, foes to him, for they were members of the camp of his former male doubles partner. Thus, he was willing hard, with all his heart, for Sania-Bopanna to fail, to lose in the semifinals, to not win a medal — the Indian medal count be damned. In the event, Sania and Bopanna lost the second set 2-6 and the third 3-10 to Venus-Ram; they still had the opportunity of winning a medal, a bronze, but they lost the third-place playoff 1-6, 5-7 to Radek Stepanek and Lucie Hradecka. It was a heartbreaking loss for Sania-Bopanna, for the Indian media pack, for the Indian fans — but not so for the aforementioned legend.

the anxiousness of this great player at the possibility of a medal for Sania-Bopanna, and then the glee at them missing it — came to one's mind when controversy broke out over India No. 1 Sumit Nagal demanding \$50,000 from the All India Tennis Association to play for India in the Davis Cup tie against Sweden. India, missing top singles stars Nagal, Sasikumar Mukund and Yuki Bhambri, got a 0-4 hammering from Sweden.

Sportspersons are human, not exemplars of morality, rectitude, patriotism. They're just like us — and possibly we're a bit better, because we're never exposed to the temptations that some sportspersons, especially cricketers, face every day of their lives. And if they do give in to temptation, those watching from the sidelines start booing. Sportspersons turn cynics when quite young, for their experience, of fellow players and coaches, tells them that the sports administrator is venal and undependable — often a politician or bureaucrat or businessman who joins up for clout in his city, then country, then the world. Once they have the vote in, say, the global governing body of a sport, or in the Olympics, such men are like kings — feted and lionised at the biggest sports events — the world. Power can be difficult to digest for the petty — they turn autocrats, treating athletes like menials.

Some of these men turn up at, say, the tennis event at the Olympics, sozzled silly, courtesy complimentary alcoholic beverages. We in the media have seen them countless times, as have athletes. Sportspersons have utter contempt for such freeloaders. Somdev Devvarman, the former India No. 1 who had a highest global ranking of No. 61, said in 2017 about certain AITA officebearers who had missed the fourth and fifth sets of his Davis Cup match in 2014: "They were getting late for their single malt party down at the club as they thought my match was done and I had no chance of coming back. This information certainly didn't come as a surprise to me. I expect them to be unpolished. I also got a solid whiff of their single malt Scotch as they poured over me with congratulations after the match."Nagal, facing criticism for asking for money to play for India, clarified: "It is standard practice in professional sports for athletes to be compensated for their participation in events, even when representing their country."

Nagal also said he was undergoing rehab after an injury, and had informed "AITA well in advance about my inability to participate" in the Davis Cup.It must be stated that playing tennis as a pro with the need for a team of coach, physio, trainer, doctor, etc - is a very expensive proposition, and players do need to focus on their bread and butter, the ATP tournaments.AITA officials did not reveal that the association does get money from the International Tennis Federation with which to compensate Nagal that players do get paid for playing in the Davis

Fences and Fault Lines: Why Border Security Alone Won't Heal Manipur

Securing the border is a start, but fences alone can't heal the wounds of ethnic conflict

It is encouraging that Union Home Minister Amit Shah, in the context of the ongoing crisis in Manipur, stated on 16 September 2024 that "we are talking to the Kuki and Meitei groups. We have prepared a road map and will take all possible steps (to ensure peace)." He also mentioned that the government has begun the process of fencing the India-Myanmar border and has completed the deployment of Central Reserve Police Forces (CRPF) in the troubled state. Manipur, he further asserted, has experienced relative calm, with no 'major incidents', except for three days of violence in the previous week. While this conveys a sense of proactiveness and optimism, some basic questions stare us in the face. The violence in Manipur, between the Meitei and Kuki-Zo people, began on May 3, 2023. The Meitei people, who constitute the majority population of the state, largely occupy the Imphal valley, while the Kuki-Naga people, who account for 30 per cent of the total population of roughly 3 million, are predominantly settled in the hill areas abutting the border with Myanmar. The clashes were triggered by a ruling of the Manipur High Court on April 14, 2023, directing the state government to send a recommendation to the Central government regarding the Meitei community's demand for Scheduled Tribe status. The Kukis felt this would jeopardise their share of reservation rights and allow the larger population to occupy land in Kukidominated areas, which were already under threat due to hill forests being cleared by the state administration, ostensibly to combat poppy cultivation. The ethnic divide was further deepened by religious differences: the Meitei are predominantly Hindu, while the Kuki and Naga communities are largely Christian.

To be fair to the BJP government in Delhi, ethnic clashes in Manipur are not a new occurrence. Even before May 2023, such violence would sporadically erupt, sometimes with dangerous consequences. However, what we have witnessed over the past sixteen months has intensified the Meitei-Kuki divide to unprecedented levels. Trust between the two communities has completely broken down, violence has escalated—now involving the use of drones and sophisticated weapons-and the segregation is near total, with a physical buffer zone cutting across like a gash between the two ethnic groups. As per reports, the violent clashes that broke out on May 3, 2023, resulted in 81 deaths, of which 77 were Kukis and 10 were Meiteis. In the 16 months since, official figures report that 235 people have been killed, over 1,000 injured, 60,000 displaced and still living in refugee camps, 4,786 houses burned, and 386 religious structures vandalised, including temples and churches. Unofficial estimates suggest these numbers may be much higher. The violence has been marked by a great deal of atrocity. On July 19, a viral



video showed two women being stripped, paraded naked, sexually assaulted, and gang-raped, presumably by Meitei men. One of the victims' father and brother were killed while trying to protect her. A police complaint was lodged, but no action was taken for two months until the video emerged. The Supreme Court, taking suo motu cognisance of the video, stated bluntly that there seems to be a complete breakdown of the Constitutional machinery in the state. Simply put, Manipur has been engulfed in unrelenting violence, arson, and rioting for far too long, with no signs of a resolution. This situation should be of prime concern to the government. Manipur is a sensitive border state, with a 352 km porous boundary shared with unstable Myanmar. The Kuki population overlaps with the Chin tribe in Myanmar, and the entire region is flooded with arms, the intervention of hostile powers-notably China—awash in drugs, plagued by cross-border narco-terrorism, and rampant illegal immigration.


Given the above, questions inevitably arise as to why the Central government has allowed this volatile situation to fester and escalate for so long. Why is Amit Shah only now speaking about having a 'road map for peace' after 16 months of continuous violence, when the warring

groups are nearly irreparably divided? Why is the fencing of the Myanmar border being initiated only now, when both the Central and state governments have consistently blamed illegal immigration from Myanmar for the crisis? Is border fencing a desirable or feasible solution, given the challenging topography and overlapping tribal ties on both sides? Why has the CRPF been deployed so late, despite longstanding allegations regarding the partisan role of the Assam Rifles? And why has Chief Minister Biren Singh remained in office despite facing criticism for his handling of the crisis and accusations of bias towards the Meitei majority?

Above all, the lack of direct intervention from Prime Minister Modi is increasingly a point of concern. A visit from the PM or a concerted effort to lead an all-party delegation could signal a commitment to finding a lasting resolution. Since 1947, no secessionist movement against the Indian Union has succeeded. But the neglect of the Manipur tinder box situation poses a serious threat to our hitherto untarnished record. It is for this reason perhaps, that Mohan Bhagwat, the RSS chief, expressed serious concern in June this year about the year-long violence in Manipur, emphasising that the situation needs to be dealt with on a priority basis.

guarantees: an MSP law, 300 units of free electricity, Rs 6,000 pension for seniors, widows and the disabled and a Rs 2,000 monthly allowance for women aged 18 to 60. It



also promises to restore the Old Pension Scheme and conduct a caste census. The BJP, under JP Nadda, pledges to establish 10 industrial towns, create two lakh

government jobs and provide Rs 2,100 per month to women. Its manifesto emphasises industrial growth alongside housing projects and expanded healthcare. Both visions, however, face hurdles, including the state's financial health, in the implementation of these ambitious promises.

Interestingly, AAP, another party contesting all 90 seats, is making a pitch with focus on education, healthcare and clean governance. Though Arvind Kejriwal, after quitting as the Delhi CM, is going full throttle in campaigning, AAP may not disrupt the twoparty dominance. But it could divide the anti-BJP vote and weaken the Congress' chances. The INLD, in alliance with the BSP, remains influential in rural and Jat-dominated areas.

Abhay Chautala is positioning himself as a strong alternative. With multiple contenders, this election will test Haryana's evolving political dynamics.

PM Modi's US Visit: Time to Capitalise on Shared Interests

The Biden presidency has, on the whole, been positive for India. During it, Prime Minister Modi made a State visit to the US and also addressed the American Congress for the second time

Prime Minister Narendra Modi's is visiting the US where he will participate in the Quad summit, address the Summit of the Future at the UN, and meet American CEOs as well as the Indian diaspora. At the UN summit, he may also have some bilateral meetings with leaders of some countries.

A meeting with Bangladesh's Muhammad Yunus is not on the cards, even though Yunus had expressed a desire to meet with Modi. Some may argue that a meeting would provide an occasion for a frank exchange of views on our concerns about the developing situation in Bangladesh and the anti-Indian orientation that it is taking. On the other hand, it is also apparent that Yunus is a figurehead and not in control of the internal forces at play, besides the fact that his interim position is not constitutionally legitimate. In any case, our High Commissioner in Bangladesh is engaging the key members of the interim government. Donald Trump said at one of his rallies that he would be meeting Modi. Unless Trump is in New York it is not clear how this meeting can be arranged. Since the electoral race is very close and Trump could well win, it might be politic not to appear to snub him by declining a meeting, which he seems to want. On the other hand, politics in the US has got so highly polarised that the Kamala Harris camp may not view Modi's meeting with Trump kindly, especially because of their past Houston bonhomie, and impute it as interference in the election process. Since Modi will not be meeting Harris, it would obviously be best to avoid meeting Trump. The Foreign Secretary in his press briefing has been evasive on the subject. The Quad summit is being hosted by Joe Biden in his native Delaware. He is still the president but he is a diminished figure because of the manner in which his bid for a second term was ingloriously terminated by Democratic Party leaders, apart from his cognitive difficulties. The presidential election is also only a few weeks away. If he were still in the race, the Quad summit would have had a different meaning. Prime Minister Fumio Kishida of Japan, another participant, is also on his way out. In any case, whether Trump wins or Harris wins, the China challenge, which both parties recognise, means that the Quad will remain relevant and important. The Biden presidency has, on the whole, been positive for India. During this time, Modi made a state visit to the US and addressed the US Congress for the second time. Differences between the US and India on our ties with Russia, including in the area of defence, our purchase of discounted Russian oil, our unwillingness to take sides in the Russia-Ukraine conflict and abstaining on resolutions in the UN targeting Russia, were contained, though simmering resentments on the US side remain. Many agreements in the area of defence-related cooperation, including on the easing of export controls, were signed. Some significant projects such as the supply of GE 404 engines for our Teias Mk1 and Mk1A aircraft and the co-production of GE 414 engines for Tejas Mk2 and initial batches of the AMCA, with substantial transfer of technology have been concluded. The supply of GE 404 engines has, however, encountered delays because of supply chain issues on the US side, leading to some speculation about the reasons, but it appears that the US had outsourced manufacturing of some parts of the engine to other countries and that is where bottlenecks have arisen.India-US cooperation in the



area of critical and emerging technologies as part of the ICET agreement breaks vital ground for cooperation in areas such as AI, quantum computing, robotics, biotechnology, critical materials, 5G and 6G, human spaceflight semiconductors etc. That the ICET is headed by the National Security Advisers on both sides testifies to the serious commitment of both countries to this initiative. Progress is bound to be slow, and is slow, because of the very complex layers of US controls on technology cooperation, besides the fact that the ICET project involves government, research bodies, academia and the private sector. Added to which are US concerns about leakages of such technologies to Russia from India. The INDUS X is an India-US Defence Acceleration Eco-System

involving India and US startups was also launched during the Biden presidency. US NSA Jake Sullivan has been a motivating force in India-US ties.

It is under the Biden presidency that the Quad was raised to the summit level. In that light, India's decision to cede its turn to hold the summit to Biden, as a farewell gesture to him, is the right one. India is committed to the Quad, which we now describe as a global good, notwithstanding the opposition of both China and Russia as they see it as a throwback to bloc politics. No doubt, China is a glue that binds the Quad together, as all four countries have concerns about Chinese geopolitical

assertiveness and expansionism. At the same time, all four have major trade ties with China, which prevents a robust confrontation with China, as the cost to all in varying degrees will be high.

The US does not want a military confrontation with China, which gives China scope for putting steady pressure on Taiwan and the Philippines, and, in general, asserting itself in the South and East China Seas. Australia has reached out to China after a period of tensions. Japan is flexing its military muscles a bit, but the US security umbrella is vital for it. Under Kishida, it has moved even more firmly into the US orbit to the extent of supporting Ukraine and breaking off with Russia.





"Egregious Error By High Court": Big Supreme Court Order On Child Porn

New Delhi: Downloading and watching child pornography is an offence under the Protection of Children from Sexual Offences (POCSO) Act, the Supreme Court ruled today in a landmark judgment on the stringent law to prevent child abuse. The bench of Chief Justice of India DY Chandrachud and Justice JB Pardiwala set aside the Madras High Court order that had ruled that merely downloading and watching child pornography was not an offence under the POCSO Act. The Supreme Court noted that the high court had committed an "egregious error" in passing the judgment. The Madras High Court's order had come in a case in which a 28-year-old man was charged with downloading child pornography on his phone. The court had quashed the criminal proceedings against the man and said children these days are grappling with the serious issue of watching pornography and society must be mature enough to educate them instead of punishing them.



The Supreme Court today restored the criminal proceedings against the man.At the outset, Justice Pardiwala thanked the Chief Justice for the opportunity to pen this judgment.

The order focused on Section 15 of the POCSO Act which lays down punishment

for the storage of pornographic material involving children.

"Any person who stores any pornographic material involving a child and fails to report or destroy it is punishable with a fine of not less than five thousand rupees., and repeat offence will be punishable with

fine of not less than ten thousand rupees. If the material is stored for further transmitting or propagating, then along with fine, it is punishable with upto three years of imprisonment.

For storing child pornographic material for commercial purpose is punishable with three to five years of imprisonment, and in subsequent conviction, upto seven years of imprisonment," the Section says.

Justice Pardiwala said that in this case, mens rea is to be gathered from actus rea -- mens rea refers to the intent behind the crime and actus rea is the actual criminal act."We have said on the lingering impact of child pornography on the victimisation and abuse of children... We have suggested to the Parliament to bring an amendment to POCSO... so that child pornography can be referred to as child sexually abusive and exploitative material. We have suggested an ordinance can be brought in. We have asked all courts not to refer to child pornography in any order," the bench said.



Sensex, Nifty hit alltime highs as bulls dominate Dalal Street



NEW DELHI. Benchmark stock market indices opened Monday's trading session on a positive note as investors remain hopeful of more policy easing by the US Federal Reserve later this year.

The S&P BSE Sensex climbed to an all-time high of 84,843.72 moments after opening, while the NSE Nifty50 rose to 25,910.35. At around 9:30 am, the Sensex was up 257.38 points at 84,801.69, while the Nifty50 rose to 107.30 points to trade at 25,898.25.Both benchmark indices reached all-time highs on Friday, fueled by optimism that the US economy is on track for a "soft landing". Most of the other broader market indices also opened the trading session on a positive note, indicating that risk appetite among investors has gone up after the US central bank's recent rate cut.

Nifty Pharma and Nifty Auto led the sectoral gains, while Nifty IT traded in the red due to sectoral weakness.

Dr. V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, "The charging bull got a shot of steroids from the Fed when it cut interest rates by 50bps on September 18th. More than the rate cut, it was the Fed chief's optimistic commentary that lifted the markets sharply."

'The signal from the Fed is that inflation is under control and the economy is unlikely to tip into recession. This message is positive for equities, positive for emerging markets and positive for India," he added.

Meanwhile, Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said, "Key US data during the week like the GDP growth numbers for the second quarter and Federal Reserve Chair Jerome Powell's Speech this Thursday, followed by US PCE inflation on Friday will be in focus. On the technical front, the Nifty may see aggressive targets between 26300-26500 zone with support at 24301."

Netflix India being probed over visa violations, racial discrimination: Report

NEW DELHI. India is investigating the business practices of US streaming giant Netflix's local operations, including allegations of visa violations and racial discrimination, according to a government email sent to a former executive. The details of India's investigation were included in a July 20 email, reviewed by Reuters, which was written by a home ministry official to Netflix's former director of business and legal affairs for India, Nandini Mehta, who left the company in 2020."This is regarding visa and tax violations concerns regarding the business practices of Netflix in India," wrote Indian official Deepak Yadav from the Foreigners Regional Registration Office (FRRO) of the home ministry in Delhi."We have received certain details in this regard w.r.t (with respect to) the stated company's conduct, visa violation, illegal structures, tax evasion and other malpractices including incidents of racial discrimination that the company has been engaged in while conducting its business in India," he added.

In an emailed statement, Mehta said she was pursuing a lawsuit in the US against Netflix for alleged wrongful termination as well as racial and gender discrimination - charges the company denies. Mehta said she welcomed the Indian investigation and hoped the authorities made their findings public, but did not elaborate on the allegations made by the government. Yadav declined to comment, saying he was not authorised to speak to the media. The FRRO and India's home ministry did not respond to Reuters queries. A Netflix spokesperson said the company was "unaware of an investigation by the Indian government". The Indian official's email shows growing scrutiny of Netflix in India, where it has roughly 10 million users and which it considers a growth market where companies target affluent people in the nation of 1.4 billion people. Over the years, the US streaming giant has developed more local content featuring Bollywood actors.

It has also often faced heat in India over its content deemed insensitive by some users. Is Warren Buffett's cash pile costing him billions in missed gains

NEW DELHI. Warren Buffett, investor and CEO of Berkshire Hathaway, has built up a massive cash reserve following the sale of shares in companies like Apple and Bank of America. These sales have left him sitting on an enormous cash pile, now totalling around \$280 billion. However, some investors are questioning whether this strategy is costing him potential gains in the booming US stock market.One such investor, Samir Arora, founder and fund manager at Helios Capital, recently shared his thoughts on the matter. He said that Buffett's decision to hold on to so much cash, instead of reinvesting it during the current market rally, could have led to a significant loss in potential returns. According to Arora, Buffett may have missed out on as much as \$60 billion by keeping the funds on the sidelines. Missed market gains

Buffett's cash position has grown after he sold shares in some of his biggest investments. The decision to sell off a portion of his stake in Apple and Bank of America, while earning modest returns through safe investments like treasury bonds, has been a

The US stock market has risen sharply over the last two years, with an estimated gain of around 50% from September 2022 to September 2024. In contrast, Buffett's cash, invested in lower-risk assets like treasuries, is earning just around 5% per year. Arora suggests that the Oracle of Omaha has effectively lost out on around 40% of potential returns on the \$150 billion he was holding in cash over that time. reviewing Goods and Services Tax (GST) rates is set to meet on September 25, 2024, to discuss possible changes to the current tax slabs and rates, reported news agency PTI.The meeting, which will take place in Goa, is part of the ongoing efforts to streamline and rationalise the GST structure. This panel, known as the Group of Ministers Possible changes in GST slabs (GoM), is led by Bihar Deputy Chief There has been ongoing discussion about Minister Samrat Chaudhary.The GoM, merging the 12% and 18% GST slabs into which consists of six members, last met on August 22. They submitted a status report to the GST Council on September 9, outlining their initial findings. One of the key areas of focus has been evaluating the impact of changing tax rates on certain goods and services. At present, the GST system in India operates on a four-tier structure. Goods and services are taxed at different rates, depending on their category, which are 5%, 12%, 18%, and 28%.

New Delhi. A ministerial panel in charge of Essential goods, such as food items, are either exempt from GST or are taxed at the lowest slab of 5%. In contrast, luxury and demerit goods (which include items like cars and tobacco products) are placed in the highest slab of 28%. Additionally, some of these items also attract a cess, which is levied on top of the 28% GST.

one unified rate. However, no formal proposal has been made so far. The current average GST rate is around 12%, which is lower than the revenue-neutral rate of 15.3%. A revenue-neutral rate is the rate at which the government neither loses nor gains revenue after the implementation of GST. The lower-than-expected average rate has raised concerns about revenue generation, prompting the GoM to initiate discussions on possible adjustments to the



current tax rates.

Not all states are in favour of changing the GST structure. West Bengal and Karnataka, in particular, have expressed reservations about making any immediate changes to the tax slabs. After the August meeting, West Bengal Finance Minister Chandrima Bhattacharya commented that she did not support altering the existing GST rates. She argued that the current structure should remain untouched for now.Similarly, Karnataka Revenue Minister Krishna Byre Gowda noted that the GST system has largely stabilised in recent years, and any changes could disrupt this balance. He suggested that the panel should carefully analyse the need for any adjustments before making decisions. "What do you achieve by disturbing it?" he asked, adding that the GoM would revisit the issue in the upcoming meeting. During the last meeting in August, the GoM tasked the fitment committee—comprising tax officers from both the Centre and the states-with collecting more data and analysing the potential impact of tax rate changes on various items. The data gathered by this committee will be crucial in determining whether any adjustments should be made to the GST slabs and rates. The panel, in its upcoming meeting, is expected to delve deeper into these matters.

London Arsenal manager Mikel Arteta has voiced his frustration over the controversial sending off of Leandro Trossard during Arsenal's dramatic 2-2 draw with Manchester City, predicting that this season could see "100 Premier League games" affected by similar dismissals. Referee Michael Oliver showed the Belgian winger a second yellow card for delaying the restart by kicking the ball away just before halftime. The first of Trossard's two yellow cards came after a foul on City's Savinho in the 33rd minute. However, the incident that led to his dismissal came shortly after, as he kicked the ball away following a foul call, a decision which drew sharp criticism from Arteta. The incident evoked memories of Declan Rice's red card against Brighton & Hove Albion last month, where the Arsenal midfielder was similarly punished for

Manjrekar criticized this decision, suggesting that India missed an opportunity by not playing Kuldeep, even though the Chennai pitch was expected to favor seamers early on. Even if it was not a turner, India would have benefited forms a laying him in Chemoi benefited." from playing him in Chennai because seamers get help for just one or one-and-ahalf days on an Indian pitch. Even if it's a green top and the sun is out, they should keep in mind that the green top will be just for the first few hours, and Siraj and Bumrah are enough for that. When you have three proven spinners, you should play all of them," Manjrekar added.Kuldeep's ability to trouble batters with his written and vositions and the with his wrist spin and variations could be a decisive factor in Kanpur, where conditions might favor India's spin attack as the match progresses. 
