New Delhi, Sep. 24: Karnataka Deputy Chief Minister D K Shivakumar on Tuesday said there is no question of Chief Minister

Siddaramaiah resigning over the High Court dismissing his petition challenging Governor Thaawarchand Gehlot's approval for investigation against him in a site allotment case. He alleged that there was a "big conspiracy" against the Chief Minister, as he asserted that the latter has done no wrong in the issue and will come out clean. When questioned about BJP demanding CM's resignation over the High Court's order, Shivakumar

said: "There is no question, the CM has not done anything wrong. He is not involved in any scam. It is a political conspiracy by the BJP against all opposition leaders in the country,

this is what is going on.' Shivakumar, who is also the state Congress President, said he and his party stand in support of the Chief Minister, who is doing a good job for the party and the state. He was reacting to High Court on dismissing Tuesdav Siddaramaiah's petition challenging Governor's approval for investigation against him the Mysuru Urban

Development Authority (MUDA) site allotment case. "(There is a) big conspiracy against our Chief Minister, like how the BJP had hatched a big conspiracy against me by filing a case and sending me to jail. Because of God's grace I came out. The case in which I went to jail was dismissed. Similarly they have hatched a conspiracy against the Chief Minister and his family," Shivakumar said.

## Congress to put pressure on Centre to restore J&K statehood: Rahul Gandhi

New Delhi, Sep. 24: Batting in support of the early estoration of 'statehood' to the Union territory

of Jammu and Kashmir, Leader of the Opposition in Lok Sabha Rahul Gandhi Monday said his party would put pressure on the Centre to restore J-K's statehood after the ongoing assembly polls. Addressing a rally along with the President of the Jammu and Kashmir National Conference Dr Farooq Abdullah in the Surankote assembly segment of Poonch district, Gandhi also trained his guns toward Prime Minister Narendra Modi, claiming the INDIA bloc "broke his psychology" after the Lok Sabha elections. "He used to boast about a 56-inch chest but he is not the same person anymore". Seeking support for Congress-National Conference alliance candidates, he said his party wanted the restoration of statehood before the ongoing polls. He said there are numerous examples of Union

Territories being upgraded to states but never in the history of India a state was downgraded to a union territory. "For the first time, a full-fledged state (J&K) was turned into a UT, and your democratic rights were snatched," he told the rally. "We will put pressure on them (Government) and we will ensure that it (restoration of statehood) is done. If they don't do it we will," Gandhi said. Rahul reiterated the stand of the party in



his second election meeting in Srinagar. "Whenever you need me, you just have to give me an order and I will be present before you. I will raise your issues in Parliament. You know the special relationship I have with you. I do not have to even mention it," Gandhi told an election rally in the Zainakote area on the city's out-

skirts. "I will be your voice in parliament," he told the gathering. Gandhi said the biggest issue for the people of J-K is the restoration of statehood. "We guarantee

that it will be restored. If the BJP does not give it to you (after elections), we will ensure that it is restored." The Lok Sabha MP accused the BJP and RSS of spreading "hatred and violence" in the country and dividing people on the lines of caste, creed, religion, region, and language. Taking a dig at Prime Minister Narendra Modi's monthly radio show 'Mann ki Baat', Gandhi said Modi makes long and "meaningless" speeches but is not willing to address the issues of the country. "He only talks about his Mann Ki Baat and not Kaam ki Baat. Kaam ki baat is to give jobs and vision to the youth and reduce and restore statehood to J-K. No one is listening to your Mann ki Baat (anymore)," Gandhi said at the rally. Addressing the huge gathering in Surankote, NC chief Farooq Abdullah also made a strong appeal to the people urging them to

unite and support its alliance with the Congress in the ongoing J&K polls, which he said is not about religion but action. "Aaj yah dharm ki baat nahin hai, yeh karm ki baat hai kyunki yeh badi jung hai nafrat ke khilaf (Today, it is not about religion but it is about action, because this is a big fight against hatred).

### NRI quota expansion in Punjab is fraud on education system: Supreme Court

New Delhi, Sep 24: The Supreme Court on Tuesday condemned the expansion of the nonresident Indian (NRI) quota in Punjab's medical colleges, calling it a "fraud" that forces more meritorious students out of the admission process. (ANI Photo) (Sanjay Sharma) A bench led by Chief Justice of India Dhananjaya Y Chandrachud dismissed a set of petitions challenging a Punjab and Haryana high court order that quashed the Punjab government's move to broaden the

NRI quota criteria, including distant relatives of NRIs. "We must stop this NRI quota business now! This is complete fraud, and this is what we are doing to our education system," remarked the bench, which included Justices JB Pardiwala and Manoj Misra, emphasising that the NRI quota was being exploited to sidestep merit-based admissions. The bench said a broad interpretation of NRI eligibility, which even allowed distant relatives to qualify, amounted to a "money-spinning tactic" that undermines the integrity of the education system. "All three peti-





tions are dismissed. Let us put a lid on this. This fraud has to come to an end. This NRI business is nothing but a fraud. This comes to an end now. What is ward? You just have to say 'I am looking after X'. See the students who got three times high scores have lost out. We cannot lend our authority to something which is blatantly illegal," observed the bench. comments came against the backdrop of a Punjab government notification issued on August 20, which redefined "NRI candidates" to include relatives such as uncles, aunts, grand-

parents and cousins. This expansion was quashed by the Punjab and Haryana high court on September 11, which found the move "unjustified" and contrary to the original purpose of the NRI quota - meant to provide genuine NRIs an opportunity to study in India. During the hearing, senior advocate Shadan Farasat argued that the broader interpretation of the NRI quota was already being used in other states, including Himachal Pradesh and Uttar Pradesh. However, the Supreme Court firmly rejected these arguments, reiterating that the broader definition diluted merit and allowed ess deserving candidates to gain admission based on financial power and connections

rather than academic performance. Senior advocate Abhimanyu Bhandari, representing the original petitioner who challenged the notification before the high court, pointed out that a constitution bench in the PA Inamdar judgment (2005) frowned upon the fact that the NRI quota cannot be misused to pave the way for the people to use money power to get in.

### Holding talks with state govts, police to prevent train sabotage bids: Ashwini Vaishnaw

New Delhi, Sep. 24: Union minister Ashwini Vaishnaw on Tuesday said the railway administration is on alert for potential train sabotage bids and is holding talks with the administration and police in several states to prevent any unto-



ward incident. The central government treats security threats with the utmost seriousness and strict action will be taken against anyone attempting to sabotage trains, the railway minister told reporters at the Jaipur airport. Vaishnaw arrived here on Tuesday to inspect a Kavach-fitted train to check the efficiency of the automatic train protection system at Sawai Madhopur. According to railway officials, the minister will board the Kavach-fitted engine of a train at 4 pm at the Sawai Madhopur railway station and travel for 45 minutes up to the Indargarh station. He

is also scheduled to inspect a roof plaza constructed at the Gandhi Nagar railway station in Jaipur. Speaking to reporters, Vaishnaw said, "There is dialogue going on with state governments, DGPs and home secretaries. The NIA is also involved. Strict action will be taken against anyone who tries to cause such an accident. This is our resolve." He also said that the entire railway administration in divisions and zones was working with vigilance with the Railway Protection Force and local state police across the country. After reaching Jaipur, the railway minister called on Chief Minister Bhajanlal Sharma. Later, he inter-

acted with BJP workers at Bhatia Bhawan in the Rajapark area of the city. The Kavach system, also known as an Automatic Train Protection System (ATP), has been developed by the Research Designs and Standards Organisation, and it can apply brakes automatically in an emergency when a train driver fails to act in time.

### Sanjay Raut claims 'big conspiracy' behind **Badlapur** encounter

Mumbai, Sep 24: Shiv Sena (UBT) leader Sanjay Raut attacked the Mahayuti government in Maharashtra, saying that the Badlapur rape accused was killed to "save the main accused". Shiv Sena (UBT) leader Sanjay Raut on Tuesday attacked the BJP-led Mahayuti government in Maharashtra over the death of Akshay Shinde, the accused in Badlapur sexual assault case, in a police encounter. Terming his death as an "encounter", Raut said that Shinde was killed to save the "main accused" in the case, which is the school management. While speaking to reporters, the Rajya Sabha MP said that while there is no reason to show any sympathy to the accused, the "encounter" was suspicious, questioning how a janitor can snatch a gun and fire a locked weapon while in custody. "But this murder or encounter that has taken place was



done to save the main accused (school management) How convincing is it that a janitor snatches a gun from a policeman and fire a locked weapon? This is a basic question," Raut said. Accusing the government of protecting the school authorities over the incident, Raut said, "This is a big conspiracy. Opposition questions police version He also said the CCTV footage of the school, where the sexual assault incident occurred, is missing. "The school is related to BJP and yesterday's story (Akshay Shinde's killing) was done to save them," the Shiv Sena (UBT) leader claimed. Akshay Shinde, accused of sexually assault ing two minor girls in a government school in Badlapur, was shot dead on Monday evening when he snatched the revolver of a police officer and fired at a cop. The incident occurred at 6.15 pm when Shinde was being taken to Badlapur in Thane district from Taloja Jail in Navi Mumbai in a police vehicle.

Meanwhile, India's food safety regulator has also issued a show-cause notice to a Tamil Nadu firm for allegedly providing substandard ghee to the Tirumala Tirupati Devasthanam temple authority. This comes amid increasing calls for a comprehensive investigation and strict action regarding claims of animal fat being used in Tirupati laddus. BJP leader and former minister Subramanian Swamy has urged for a court-monitored investigation. Meanwhile, former Tirumala Tirupati Devasthanams (TTD) chairman and YSRCP MP YV Subba Reddy, who denied the allegations of adulteration has sought an inquiry by an independent committee headed by a retired Supreme Court judge.

### EC to have 'zero tolerance' towards use of money power in J'khand assembly polls

Ranchi, Sep.24: The Election Commission on Tuesday made it clear to central and state enforcement agencies that it will have "zero tolerance towards use of money power" in the upcoming elections to the 81-member Jharkhand assembly. Chief Election Commissioner Rajiv Kumar along with Election Commissioners Gyanesh Kumar and Dr SS Sandhu reviewed poll preparedness here and held meetings with political parties, security forces and other stakeholders since Monday. "During the review meeting with nearly 20 central and state enforcement agencies like DRI, NCB, state and central GST, RPF, RBI, state police, income tax, enforcement directorate, etc, the commission underscored its focus for inducementfree elections. The commission conveyed its zero tolerance towards use of money power in the elections," the EC said in a release. The CEC cautioned the officials to

avoid any undue harassment of the public in the name of checking during the elections. The Election Commission (EC) directed all enforcement agencies to work in a coordinated manner to "curb illicit liquor, cash and drug inflow in the state

To avoid any undue harassment by authorities, a few parties highlighted the need for clear guidelines and demarcation of areas for setting up of desks near polling stations by parties on election days, he said. "One of the parties also raised concern about the deletion of names on voter lists in certain constituencies in previous elections.

### 'Opened multiple bank accounts': Rs 382 crore tax notice leads to Aadhaar, PAN misuse scam in Thane

THANE. A real estate agent from Diva was shocked on receiving an income tax notice, accusing him of conducting transactions amounting to Rs 382 crore. The unsuspecting agent, who resides in a chawl, soon learnt that he had become a victim of a massive financial scam involving fraudulent bank accounts and proprietary firms set up in his name for money laundering purposes, said a police officer.

The ordeal began in 2022, when the complainant was approached by an acquaintance. The prime accused offered him a job at a monthly salary of Rs 20,000. The prime accused, with two others, asked for his Aadhaar card, PAN card, photos, and a signed cheque. The trio allegedly used the documents to open multiple bank accounts and set up fake firms, including a proprietorship firm. These accounts were used for huge monetary deals to the tune of Rs 382 crore. The scam came to light when the complainant received a notice from the Income Tax Department, asking him to explain the massive financial activity under his name. He approached the cyber crime police, who registered a case and began an investigation into the matter.

The police said the accused had used the complainant's documents to orchestrate the scam, facilitating illegal financial operations and money laundering through fake firms. "They opened multiple bank accounts used for large-scale money laundering," said an officer. Police have warned the public about sharing personal documents as such scams are becoming common.

### Mumbai: Month after dentist died in crash, 'drunk' acquaintance who drove her home held

MUMBAI. A 26-year-old son of a businessman from Ghatkopar was arrested on Sunday two days after his blood report in a drunk driving case came positive for alcohol content. The case pertains to the death of a 26-year-old dentist in a car crash at Vikhroli last month. The permissible blood alcohol content in India is 0.03% per 100 ml of blood. The report stated there was a presence of 0.145% of alcohol in his blood samples, indicating he had consumed a high dose of hard drinks and yet drove the car, leading to the accident.

The Vikhroli police arrested Vishak Harilal Patel. While he was initially booked for rash and negligent driving, and endangering human life, the police on Sunday invoked stringent sections of culpable homicide not amounting to murder and intentional knowledge.

### Tamil Nadu govt allots houses to families of Kannapar thidal in Moolakothalam after two decades

These families were evicted from the streets near Nehru Stadium in 2002 and relocated to the Kannappar Thidal shelter.

CHENNAI. Ending the two-decade-long struggle of 114 families residing at the corporation-run shelter in Kannappar Thidal, Minister of Youth Welfare and Sports Development Udhayanidhi Stalin on Monday issued housing allotment orders for them. The authorities have planned to resettle the families at the Tamil Nadu Urban Habitat Development Board tenements at Moolakothalam.

The beneficiary contribution that each family was to pay for their house had initially worked out to Rs 4.27 lakh. However, the city corporation later decided to fund twothirds of this amount, bringing it down to Rs 1.42 lakh per family. The residents can pay this amount in instalments.

These families were evicted from the streets near Nehru Stadium in 2002 and relocated to the Kannappar Thidal shelter. Over the years, as residents increased in the building, many families found themselves cramped into small spaces, unable to even stretch their legs.In 2023, Chief Minister MK Stalin



visited the shelter following Cyclone Michaung and promised the residents that 2024 monsoon.Initially, it was proposed to relocate them to Kannagi Nagar, but following opposition from the families as the site was far from their workplaces, the Moolakothalam tenements were decided on. Protesting the Rs 4.27 lakh beneficiary

contribution, the residents staged a protest in August this year, demanding free housing. housing would be provided to them before Speaking at an event held to hand over the allotment orders on Monday, Udhayanidhi said, "Just as food and water are basic necessities, housing is equally vital. During the 2021 election, CM Stalin assured the residents that they would receive housing, and now that promise has been fulfilled. The

22-year dream of these residents has come true." Rajesh, a resident of Kannapar Thidal, told TNIE, "After all these years, we are finally going to have a proper home. Electrical work at Moolakothalam is still pending, but we expect to move there in 10 days.'

Protests in Allikulam

The residents of Thideer Nagar in Allikulam, and V V Koil Street near Kannapar Thidal staged a protest, seeking housing allotments. They said an enumeration was carried out but they had not been allotted houses. Egmore MLA I Paranthamen told TNIE, "These protestors earlier requested homes to be built in same location. So, we planned to relocate the residents in the homeless shelter first and then construct houses on that land for these people. But now, Allikulam and VV Koil street residents are suddenly demanding houses at Moolakothalam. We are in discussions with them, and we are taking measures to ensure that they receive housing soon."



### Watch: Snake on Jabalpur-Mumbai train sparks panic

MUMBAI. Panic spread among passengers aboard an air-conditioned coach of the JabalpurMumbai Garib Rath Express on Sunday after they spotted a snake during their journey. The incident occurred while the train was en route to Mumbai. A video of the snake quickly went viral on social media, showing the reptile hanging from the iron grip of a side berth, with passengers leaving their seats in alarm in G17 coach."According to railway officials, as soon as the presence of the snake was reported at Kasara, passengers were promptly shifted to another coach. No one faced any major inconvenience. The coach where the snake was found was locked, and it was safely removed."The snake reportedly entered the train while it was statio nary near Kasara, possibly from anearby tree. Some passengers attempted to throw the snake out using a blanket, but while the blanket fell out, the snake retreated into the air-conditioning panel. Another official said, "The train continued its journey after the coach with the snake was detached from the rake's configuration."This is the second incident of asnake being found on a Mumbai-bound long-distance train. In July 2024, one was spotted on the side upper berth of an AC coach on the Gorakhpur-Bandra Terminus Weekly Express at Charbagh station in Lucknow division. That incident, too, had gone viral, showing the snake's tail emerging from an opening in the coach roof.

### On WhatsApp, man lured to invest in shares, loses 1 crore

Noida. A resident of Noida was cheated of over Rs 1 crore by fraudsters, who lured him into making stock investments. The complainant said he was scammed by at least four fraudsters who added him to WhatsApp groups between April and June. In an FIR filed with the Cyber Crime police station on Sept 22, the complainant, son of a retired professor, said that he was first added to a WhatsApp group called "The Vanguard Group Investment Club 140", managed by someone named Kuldeep Khanapurkar, and an assistant, Priya Sharma. On their advice, he transferred a total of Rs 91.8 lakh to different bank accounts. However, when he tried to collect his profits, the suspected fraudsters did not allow him to withdraw his alleged gains. Instead, they began to offer more high-profit opportunities which he invested in, but did not see any money in return.

The complainant said he was similarly added to another WhatsApp group called "Wealth Storm Plan 928", managed by Dev Vyas and an assistant, Sunita Singh. The fraudsters here convinced him to invest Rs 10 lakh in high-profit IPO opportunities.On the basis of his complaint, a case has been registered under sections 419 (punishment for cheating by personation) and 420 (cheating and dishonestly inducing delivery of property) of the BNS, and section 66 D (punishment for cheating by personation by using computer resource) of the Information Technology Act. Further investigation in the case is underway, said police officials

### Paved sidewalks to modern streetlights: Udyog Marg set for a Rs 50cr makeover

Noida. Noida Authority will redevelop Udyog Marg as a model road with better streelights and paved sidewalks.DGM Civil Vijay Rawal said acontractor for the project will be finalised soon, and the work order is expected to be issued within next two weeks. Udyog Marg, which extends from sectors 14 A to 11, sees severe traffic jams during peak hours. The redevelopment project will include extensive upgrades to civil infrastructure, electricity, traffic management, water, and sewer systems along the entire stretch. The total investment in this transformation is estimated to be Rs 49.4 crore.

The main carriageway will be developed with side tracks, paved with tiles. A narrow central verge will be built to prevent vehicles from criss-crossing, which has been a major cause of traffic disruptions. Furthermore, the existing brick masonry drains will be

### Seen no change here in past 10 years': Sohna voters demand better civic infra

Gurgaon. The Sohna assembly constituency, which comprises 56 villages, has long struggled with inadequate civic amenities, such as water and electricity supply, broken roads, schools and employment opportunities. The area is now witnessing a new real estate boom with many new projects coming up. Despite these changes, civic issues continue to plague the constituency.With a large population of Ahirs, as well as Gujjars, Jats, Rajputs, and Muslims, Sohna's diverse regional ethnicity has often led to caste-based politics and polarisation. The seat has a total of 2,83,000 registered voters at present, with 292 booths built for the Oct 5 polls.In 2019, the Sohna assembly constituency had a total of 2,30,071 electors. The total number of valid votes in the polls was 1,63,499. BJP candidate Sanjay Singh won, securing a total of 59,117 votes. JJP candidate Rohtas Singh stood

second with a total of 46,664 votes, losing by 12,453 votes. Over the past 10 years, urban areas of Sohna have seen some development related to roads, health, and electricity, but rural areas have been left untouched, according to residents. Locals recently demanded that political parties field local candidates who reflect their needs and aspirations, instead of giving tickets to 'outsiders'. On Aug 27, residents of around 100 villages in Sohna and Tauru conducted a mahapanchayat to oppose "outsider" candidates for the upcoming assembly elections. The mahapanchayat threatened to boycott the upcoming polls if political parties field candidates who are not locals.Since 1972, none of the MLAs elected from the Sohna assembly constituency are from the area. They mostly belong to adjoining districts and constituencies.IMT Sohna, which was expected to bring employment opportunities to the area,

has failed to attract major firms, leaving the local population struggling for jobs. "There are no universities or colleges in this constituency. As a result, a majority of the population is not very well educated. There is a lack of employment opportunities. Even the development of Sohna-Palwal Road (NH-919) and DND Delhi-Vadodara Expressway has not resulted in any benefits for locals. We want a candidate who will focus on education and generation of jobs for our youth," said Om Prakash Gaur, a resident of Sohna.Another resident, Manish Khatana, said: "Nothing has changed on the ground all these years. IMT Sohna failed to attract any major firms and thus no employment was generated. We have been suffering for the past 10 years.'

Elections were held for the Sohna Assembly seat for the first time in 1967, when Independent candidate Rao Mahavir won.BJP first won the seat in 2014, with Tejpal Tanwar becoming the MLA. In 2019, BJP again won, with Sanjay Singh elected as the MLA in 2019. Singh is currently a minister in the Nayab Singh Saini-led govt, a first for Sohna.

Political parties seem to have taken into account voters' demand for local candidates — this time, the four top contenders in the electoral fray include Tejpal Tanwar from BJP, Rohtash Khatana (Congress), Sunder Bhadana (BSP), and Dharmendra Khatana (AAP), all from the Gujjar community and residents of Sohna. Political experts expect it to be a tough contest between BJP and Congress this time. There are Ataullah Khan from the Loktantra Suraksha Party, Vinesh Kumar from the Azad Samaj Party (Kanshiram), and Independent candidates Kalyan Singh, Javed Ahmed, Dayaram, and Subhash Chand.

### Sexual harassment charge against GBU prof not under purview of physical assault'

Noida. A report by the internal complaints committee (ICC) has said allegations of sexual harassment levelled by a PhD student against a Gautam Buddha University (GBU) professor did not fall under the purview of physical assault.

The university, however, will form another committee to implement the recommendations of the ICC. Until then, the professor will be barred from heading his department"The ICC report highlights that the act of sexual harassment, as alleged by the PhD student, does not fall under the purview of physical assault," the GBU registrar said on Monday. The ICC was set up by the university after a written complaint was submitted by the PhD scholar's sister on June 10.

An FIR was registered against the professor on Sept 18 after the PhD scholar accused him of sexual harassment in June. A complaint submitted by the woman's family members at Ecotech 2 police station claimed the professor, who is also the dean of the department where she was completing her degree, had called her to his office on June 8 and used "obscene words" and behaved with "indecency". According to the ICC report, the PhD scholar's signature on some forms related to an international seminar was missing, so the dean called her to his office on June 8 and asked her to sign the document. However, she did not have a pen, and the conversation escalated. The report said the complainant's statement mentioned that the professor told her that "she must be able to insert a 6-inch one", which allegedly were vulgar words, however, the word "mobile" was later added to the sentence. The professor, in his statement before the committee, clarified that he had told the student that "pen and book are the ornaments and pride of a student and teacher, you should also k pen along with a mob pocket". The ICC report states the student and two of her associates, also did not abide by the university's rules in their research discourse. "Due to this the quality of the research work also seems to be affected. If the university wants, another independent academic committee can be formed to check the seriousness and progress of the research of the said students. Because the related subject matter does not come under the purview of the internal complaint committee and the committee cannot take cognizance of it," the registrar said. However, the report stated,



### California passes law to ban smartphones in schools by 2026

- Sacramento California Governor Gavin Newsom signed into law on Monday a bill that requires schools to limit or ban the use of smartphones, amid a growing consensus that excess usage can increase the risk of mental illness and impair learning.
- Thirteen other states this year have banned or restricted cellphones in school or recommended local educators do so, after Florida led the way by banning phones in class in 2023, according to Education Week.California, with nearly 5.9 million public school students, has followed the lead of its own Los Angeles County, whose school board banned smartphones for its 429,000 students in June. That same month US Surgeon General Vivek Murthy called for a warning label, on social media platforms, akin to those on cigarette packages, likening the problem to a mental health emergency.
- Murthy cited a study, in the medical journal JAMA showing adolescents who spend more than three hours a day on social media may be at heightened risk of mental illness, while referring to a Gallup poll, showing the average teen spends 4.8 hours per day on social media.California's bill, which passed 76-0 in the state assembly and 38-1 in the senate, requires school boards or other governing bodies to develop a policy to limit or prohibit student use of smartphones on campus by July 1, 2026, and update the policy every five years."We know that excessive smartphone use increases anxiety. depression, and other mental health issues but we have the power to intervene. This new law will help students focus on academics, social development, and the world in front of them, not their screens, when they're in school," Newsom said in a statement

### Tsunami hits Japanese islands after 5.9magnitude earthquake, residents on alert

World A small tsunami hit Japan after an earthquake of magnitude 5.9 hit an unpopulated island in the Pacific Ocean on Tuesday. According to the Japan Meteorological Agency, a tsunami of 50 cm (1.6 feet) entered Hachijo island, one of the Izu islands, around 40 minutes after the earthquake.Smaller tsunamis have been detected on three other islands, Kozushima, Miyakejima and Izu Oshima as well, the weather body said.No casualties have been reported due to the tsunami or the earthquake so far.

The weather body has also issued a warning for a tsunami of around 1 m (3.3 feet) high for Izu and Ogasawara islands. About 21,500 people live on the islands in the Izu group and about 2,500 on the Ogasawara Islands, news agency The Associated Press reported.Meanwhile, record rains hit central Japan's Noto region on Saturday, killing at least one person and ovr seven people were reported missing. Hourly rainfall hit record 121 mm (4.8 inches) on Saturday morning in Wajima, while neighbouring Suzu received 84.5 mm in an hour, also an all-time high.

### Donald Trump Says He Won't Seek Reelection if He Loses In 2024 US Presidential Election

The 78-year-old former president is pitched in a tight race with Democratic presidential candidate Vice President Kamala Harris. Trump would be 82 by the time of the next elections in 2028.

World Former US president Donald Trump has ruled out running for the White House in 2028 if he loses his presidential bid in November this year. "No, I don't. No, I don't. I think that that will be, that will be it. I don't see that at all. I think that hopefully we're gonna be successful," Trump told host Sharyl Attkisson in an interview over the weekend. Trump is running for presidential elections for the third consecutive term this time. He won the first time in 2016 and lost in his second attempt in 2020. The 78-year-old former president is pitched in a tight race with Democratic presidential candidate Vice

President Kamala Harris. Trump would be 82 by the time of the next elections in 2028. The presidential elections in the US will take place on November 5. When asked what keeps him healthy, Trump said he plays golf and tries to eat properly."Well, I used to play golf a little bit. That gave me, so I don't know, but it seems to be quite a dangerous sport in retrospect. I try and eat properly. try. I do the best," the Republican presidential candidate said."I like perhaps all the wrong food. But then I

say 'Does anybody know what the right food is?" he asked. "I have people lecturing me for years, 'Oh don't eat this, don't eat that'. They're gone, they have passed away long ago," Trump said. During the interview, Trump stressed that he does not get credit for the fight against COVID-19. "I never got great credit on the fighting of the China virus, which is COVID. But we call it the China virus 'cause we like to be accurate.



But if you think of what I've done, I took, I took a disaster that came into our shores. That dust flew in from China and we started making things like the ventilators. We were supplying the whole world with ventilators," he said."Within a period of seven months, we took auto factories and started making ventilators and auto factories. We did the gowns, the cost, you know, all of the

different things, all of the rubberised products, the masks, all, everything. And we also had to go, because our, you know, when I took over, the cupboards were bare. We had nothing," Trump said."We had, we were supposed to have, but we had nothing. And in all fairness to previous presidents, the reason is that nobody really thought a pandemic in this world, in this age, was possible. You know, you remember 1917, we had the great pandemic that people talk about. A hundred million people they say died," he said.

And basically this would've happened here too. And it didn't happen here. I think I did a great job. I think I will not be given credit for it. But there are a lot of people that think I did a really fantastic job on that. Nobody knew what it was. Nobody knew where it came from. And remember, we had far fewer deaths than (incumbent President Joe) Biden. And Biden just got the tail end. So we did a good job," Trump claimed.


### Gunman who killed 10 at Colorado supermarket in 2021 gets life imprisonment

Denver, The man who killed 10 people in a mass shooting at a Colorado grocery store in 2021 was convicted on Monday of firstdegree murder and sentenced to life in prison without the possibility of parole.

Ahmad Al Aliwi Alissa, 25, had pleaded not guilty by reason of insanity. The jury instead found the Syria-born man guilty in Boulder District Court on 10 counts of first-degree murder. Jurors also found him guilty on dozens of counts of attempted murder and weapons offenses.

After relatives of the victims addressed the court, Judge Ingrid Bakke formally gave Alissa the mandatory sentence under Colorado law of life in prison without the possibility of parole.Colorado Governor Jared Polis said in a statement that "though I know this guilty verdict won't heal the pain so many of us feel, or bring back He is methodical and he is brutal," District those who were killed, I hope that it can



provide some peace."

It was never in dispute that Alissa carried out the rampage. The case focused on his mental state at the time of the shootings. Under Colorado law, a person must be found to be unable to distinguish between right and wrong for an insanity defense to prevail.Authorities said Alissa was armed with a legally purchased Ruger AR-556 pistol, which resembles an AR-15 semiautomatic rifle, when he entered the King Soopers grocery store in Boulder. about 30 miles (50 km) northwest of Denver, on March 22, 2021. Alissa shot dead two people in the parking lot before She recounted other high-profile shootings entering the store and killing eight others, including a police officer who responded to the shooting.

Attorney Michael Dougherty told jurors in

closing arguments on Friday. The psychologists and psychiatrists who testified during the trial that began last month agreed that Alissa was diagnosed as a schizophrenic who was profoundly mentally ill. But that diagnosis alone does not render a person legally insane.

'This tragedy was born out of disease, not choice," defense attorney Kathryn Herold told the jury.Eyewitnesses described Aissa as focused as he opened fire, shooting dead at least two victims at point-blank range after wounding them in the opening salvo.

Sarah Chen, a pharmacist working that day, testified during the trial that she heard Alissa shriek with delight as he fired his weapon as she and other workers crouched behind a counter. Alissa did not testify in his own defense.

Erika Mahoney, whose father Kevin was killed in the shooting, told the court during victim impact statements on Monday that shortly after learning of her father's murder she envisioned standing in court and facing the gunman.

"I wish the young man behind the gun had received more love in his life, because then maybe none of this would have happened," Mahoney said.

### Pope asks for liberation of Myanmar's detained ex-leader Aung San Suu Kyi, offers Vatican as safe haven

Rome. Pope Francis has called for the liberation of Myanmar's detained former leader and Nobel laureate Aung San Suu Kyi and offered the Vatican as a safe haven, the pontiff said in a recent conversation with Jesuits in Asia.

I asked for the Ms Aung San Suu Kyi's release and received her son in Rome. I offered the Vatican to receive her in our territory," he said in a private conversation during a recent 12-day tour across Southeast Asia. The 87-year old pontiff visited Myanmar in December 2017.Suu Kyi has been detained by the military since it overthrew her government in a 2021 coup. It is unclear where the hugely popular 78-year-old is being held or if she has been allowed any visitors.Italian daily Corriere della Sera published the comments on Tuesday in an article by Father Antonio Spadaro, a Rome-based Jesuit priest who attends the meetings and writes about them afterwards with the pope's permission."The future of the (Myanmar) must be peace based on respect for the dignity and rights of all, on respect for a democratic order that allows everyone to contribute to the common good," Pope Francis added.Suu Kyi, the British-educated daughter of Myanmar independence hero Aung San, has been jailed for a total of 27 years for crimes ranging from treason and bribery to violations of telecommunications and disaster management laws, which she denies.Her supporters say the cases were politically motivated to keep her out of the spotlight and stifle pro-democracy forces. The military maintains Suu Kyi was given due process.On Tuesday, a source familiar with Suu Kyi's previous legal cases, who declined to be identified due to the sensitivity of the issue, said her lawyers had no access to her to relay any messages.

### 'Hezbollah Has Used You'...: Day After Deadly Strikes, Israeli PM Netanyahu Sends Out Message For Lebanese Citizens

Source Amid the ongoing deadly conflict between Israel and Hezbollah, Israeli Prime Minister Benjamin Netanyahu addressed the Lebanese people, emphasizing that Israel's military actions are not aimed at them but specifically targeted at Hezbollah. Notably, his remarks come in the wake of Israeli strikes on Monday that resulted in the deaths of nearly 500 Lebanese citizens.In his video message shared online, Netanyahu said, "For a long time, Hezbollah has used you as human shields. They have stored rockets in your homes and missiles in your neighborhoods. These weapons are aimed directly at our cities and citizens, and to defend our people from Hezbollah's attacks, we must destroy these weapons."Warning the Lebanese people, Netanyahu further said, "Earlier today, the military started advising you to evacuate the danger zone. I strongly encourage you to take this warning seriously. Don't let Hezbollah jeopardize your safety or that of your loved ones. Don't allow Hezbollah to place Lebanon in harm's way."Deadly Israeli AttacksLebanon's Hezbollah-led Health Ministry reported 492 casualties as of Monday night, including 35 children and 58 women. According to the reports, at least 1,645 people were injured, and thousands of families had been forced to flee their homes. According to Lebanese officials, the recent wave of attacks marks the deadliest since the 2006 conflict between Israel and Hezbollah. The Israeli military urged civilians in southern and eastern Lebanon to evacuate as it intensifies its airstrikes on Hezbollah positions.

### Russia says Ukraine's incursion into Kursk region killed 56 civilians

Moscow At least 56 civilians have been killed and 266 wounded during Ukraine's sevenweek-old incursion into Russia's western Kursk region, the Russian Foreign Ministry

said on Monday.Kyiv began the crossborder attack on August 6, more than two years after Moscow sent tens of thousands of troops into Ukraine, and Ukrainian forces remain in the Kursk region. The Russian Foreign Ministry had earlier put the death toll at 31 in the period to September 5. The new toll covered the period up to Sept. 20.It said 131,000 civilians had left the most dangerous areas of the region but accused Ukrainian forces of holding some civilians against their will, including 70-120 people in the town of Sudzha.Asked by Reuters about the statement, Ukrainian Foreign Ministry spokesman Heorhiy Tykhyi said Ukraine abides by international humanitarian law and does not target civilians, and that it was unable to verify the assertions."Given Russia's long history of false numbers and



propaganda, there is simply no way of verifying their claims. If Russia wants to show the real situation on the ground it can grant such access to the UN and ICRC," he said.Reuters was unable to immediately verify battlefield reports from either side. Both sides have denied targeting civilians and making false claims for propaganda

purposes during the 31-month-old conflict. The Kremlin has previously made clear it regards Ukraine's invitation to the United Nations and International Committee of the Red Cross to the Kursk region as "provocative", and that Moscow expects the UN and ICRC not to accept the invitation.

Kyiv has said its incursion, the biggest foreign attack on Russia since World War Two, is intended partly to prevent Russian forces in the area launching their own incursion across the border into Ukraine.Ukrainian President Volodymyr Zelenskiy said earlier this month that his forces controlled 100 settlements in Kursk region over an area of more than 1,300 sq km (500 sq miles). Russian sources disputed this figure and Russia says it has since taken back some villages in a counter-attack.

### What to know about the growing conflict between Israel and Lebanon's Hezbollah

CAIRO. The past week has seen a rapid escalation in the nearly yearlong conflict between Israel and Lebanon's Hezbollah. First came two days of exploding pagers and walkie-talkies used by Hezbollah in deadly attacks pinned on Israel that also maimed civilians across Lebanon.Hezbollah's leader vowed to retaliate, and on Friday the militant group launched a wave of rockets into northern Israel. Later in the day, the commander of Hezbollah's most elite unit was killed in a strike in Beirut that killed dozens more people. The cross-border attacks ramped up early Sunday, with Hezbollah, an Iranian-backed Shiite group that is Lebanon's most powerful armed force, launching more than 100 rockets deeper into northern Israel, with some landing near the city of Haifa. Israel launched hundreds of strikes on Lebanon. Then, on Monday, Israel launched a series of strikes that killed more than 490 Lebanese, the deadliest attack since the 2006 Israel-Hezbollah war. Israel warned residents in southern and eastern Lebanon to leave their homes ahead of a spreading air campaign against Hezbollah.Many fear the escalating violence could lead to an all-out war between Israel and Hezbollah, which would further destabilise a region already shaken by the fighting in Gaza. Both sides have said they don't want that to happen,

even as they have defiantly warned of heavier attacks.Israel and Hezbollah have launched repeated strikes against each other since the Gaza war began, but both sides have pulled back when the spiral of reprisals appeared on the verge of getting out of control, under heavy pressure from the U.S. and its allies. But in recent weeks, Israeli leaders have warned of a possible bigger military operation to stop attacks from Lebanon to allow hundreds of thousands of Israelis displaced by the fighting to return to homes near the border.

#### Here are some things to know about the situation

More than 1,600 Lebanese were injured in Monday's deadly strikes and thousands more fled southern Lebanon. Israel said it was targeting Hezbollah weapons sites, and had hit some 1,600 targets. Lebanon's health minister said hospitals, medical centres and ambulances had been struck.

The Israeli military warned residents to immediately leave areas where Hezbollah is storing weapons. The Lebanese media said the evacuation warning was repeated in text messages.Hezbollah said it had fired dozens of rockets toward Israel, including at military bases, and officials said a series of air-raid sirens were ringing out in northern Israel warning of rocket attacks.On Friday, an

Israeli airstrike brought down a high-rise building in Beirut's southern suburbs, killing Ibrahim Akil, the commander of Hezbollah's elite Radwan unit, and other top unit leaders. Israel said Akil led the group's campaign of rocket, drone and other fire into northern Israel. At least 45 people were killed in that attack and more than 60 were wounded.

That strike came after the shock of the electronic device bombings, in which thousands of pagers and walkie-talkies used by Hezbollah detonated on Tuesday and Wednesday. At least 37 people were killed, including two children, and around 3,000 were wounded. Israel has neither confirmed nor denied its involvement. Analysts say that What is Israel planning? attack had little effect on Hezbollah's manpower, but could disrupt its communications and force it to take tighter security measures.

#### What is the situation on the border?

The Israel-Lebanon border has seen almost daily exchanges since the Israel-Hamas war began on Oct. 7. Before Monday, the exchanges had killed around 600 people in Lebanon-mostly fighters but also about 100 civilians and about 50 soldiers and civilians in Israel. It has also forced hundreds of thousands of people to evacuate homes near the border in both Israel and Lebanon.

Hezbollah leader Hassan Nasrallah promised

to retaliate for the electronic device bombings. But Hezbollah also has proved wary of further stoking the crisis. The group faces a difficult balance of stretching the rules of engagement by hitting deeper into Israel in response to its brazen attacks, while at the same time trying to avoid the kind of large scale attacks on civilian areas that can trigger a full-scale war that it could be blamed for.Hezbollah says its attacks against Israel are in support of Hamas. Last week, Nasrallah said the barrages won't end and Israelis won't be able to return to homes in the north until Israel's campaign in Gaza ends

Israeli officials say they haven't yet made an official decision to expand military operations against Hezbollah and haven't said publicly what those operations might be. Last week, though, the head of Israel's Northern Command was quoted in local media as advocating for a ground invasion of Lebanon.Meanwhile, as fighting in Gaza has slowed, Israel has increased its forces along the Lebanese border, including the arrival of a powerful army division believed to include thousands of troops.Israeli Defense Minister Yoav Gallant last week declared the start of a "new phase" of the war as Israel turns its focus toward Hezbollah..





### Road accidents in Chennai city outskirts claim three lives

- CHENNAI. Three persons died in two road accidents on the outskirts of the city within just 12 hours. In the first incident, two men, both aged 22, residing in the western suburbs of Thirumazhisai died after their two-wheeler crashed into a stationary truck near Puduchathiram around 10 pm on Sunday. They were on their way to Poonamallee when the incident occurred.
- The deceased were identified as Dinesh, an engineering student, and Balaji, a private firm employee. While Dinesh died on the spot, Balaji succumbed to his injuries at a hospital later. Poonamalee traffic investigation wing has registered a case and begun investigation.
- On Monday morning, two cars travelling in opposite directions collided head-on near Kalpakkam on the East Coast Road (ECR), about 40km south of Chennai. Venkatesan (60), who was driving towards Kalpakkam along with his daughter-in-law Monisha and granddaughter Monika, died in the accident.
- Police said that the other car was travelling from Chennai to Pondicherry. Venkatesan's car was allegedly in the wrong path and crashed into the other car. He suffered fatal injuries as the front portion of his car got crushed. Personnel from Sathurangapattinam police station in Chengalpattu district rushed the grievously injured Monisha and Monika to Chengalpattu government hospital. Travellers in the other car escaped with minor injuries, the police said.

### Rains lash various parts of Telangana



HYDERABAD. Various parts of the state experienced light to moderate rains and thunderstorms on Monday. Hyderabad also experienced intermittent heavy rainfall from early morning.

According to the Telangana Development Planning Society (TGDPS), the highest rainfall in the state was recorded in Nalgonda (61.5 mm), followed by Rangareddy (52.3 mm). In Hyderabad, the highest rainfall was observed in Saroomagar (40.3 mm). The India Meteorological Department (IMD) observed that two cyclonic circulations one over the west-central Bay of Bengal and the other over south-coastal Myanmar and neighbouring areas - merged into a single cyclonic circulation over the central Bay of Bengal, extending up to 5.8 km above mean sea level and tilting southwestward with height. Under its influence, a low-pressure area is expected to form over the west-central Bay of Bengal and surrounding areas within the next 24 hours. The state will continue to experience light to moderate rains and thundershowers until September 29. The IMD has issued a yellow warning for heavy rains and thunderstorms accompanied by gusty winds of 30-40 kmph until September 26 for the entire state. Over the next 48 hours, Hyderabad will experience light to moderate rain or thundershowers accompanied by gusty winds (30-40 kmph). Maximum and minimum temperatures are likely to hover around 31°C and 23°C, respectively. Surface winds are expected to be from the north or north-east, with speeds ranging from 6 to 10 kmph.

### 30 truckloads of gunny bags stranded as to trigger rain millers refuse to accept consignment BHUBANESWAR. A fresh low pressure area is

BHUBANESWAR. Around 30 trucks laden with gunny bags purchased by Odisha government for paddy procurement in the upcoming kharif marketing season are stranded across the state as rice millers are refusing to accept the consignment due to storage space constraints.

In a memorandum to principal secretary, Food Supplies and Consumer Welfare Vir Vikram Yadav, the All Odisha Rice Millers' Association (AORMA) said they are not obligated to keep the gunny bags as there is no agreement with the department

for custom milling of paddy for kharif marketing season (KMS) 2024-25."We the rice millers of Odisha do hereby decide not to keep the new gunny bags for procurement of paddy for KMS 2024-25 at millers godown. We have neither executed the agreement for the coming KMS nor any specific guideline for storage of gunny bags and its usages are received from the department," said the memorandum jointly issued by AORMA president Mahesh Kumar Bansal and general secretary Deepak Ranjan Das.

Citing storage space constraint as the major reason for their refusal to keep the gunny bags, the association said it's not the responsibility of millers to unload and store the jute bags as it violates the standard operating procedure (SOP) defined by the Odisha State Civil Supplies Corporation.

As per the SOP, it is the job of the corporation to supply gunny bags to its procurement agencies like primary agriculture cooperative societies (PACS), women self-help groups and pani panchayats for packing paddy. Registered rice millers lift the paddy stocks from the paddy purchase centres (PCCs) for custom milling purpose.

The millers' body said the operational guidelines issued by the state government for KMS 2023-24 stated that two new and as many old gunny bags are to be used for packing paddy required for one quintal of rice. The old gunny bags will be supplied by millers to PACS in advance while the corporation will supply new gunny bags to PACS in advance

The paddy procured at PACS will be packed at 37.5 kg per bag. This way, the complain of PCCs of not getting gunny bags in time will be solved and storage of paddy at mill point as per the SOP will also be adhered to, the memorandum added.

## Fresh low pressure

places in the state in next 24 hours. Widespread rainfall activity is expected to reduce from Wednesday onwards," said director of Bhubaneswar Meteorological Centre Manorama Mohanty.

Experts said the anticipated low pressure area may not intensify further but they are closely monitoring the weather system. As the monsoon season nears its end, Odisha has recorded only nine per cent deficit rains between June 1 and September 23. At least 10 districts recorded deficit rains, 19 witnessed normal rains and one received excess rains during the period.

### **Government to implement** SC ruling on child porn

BHUBANESWAR. THE state government announced to make watching and downloading child pornography a criminal offence soon after the Supreme Court's ruling in this regard on

Monday. In a release, the Women and Child Development department said the Supreme Court ruling reinforces the responsibility of each citizen to protect children, ensuring their safety and wellbeing. The state firmly asserts that ignorance of the law will



no longer serve as a defence for those who exploit or endanger minors. The government plans to enhance coordination with law enforcement agencies to combat dissemination and consumption of child pornography. This includes establishment of task forces to

#### investigate and prosecute such crimes. In line with the Supreme Court's recommendations, the state will invest in comprehensive support services for victims of child abuse, providing them with the care and resources they need for recovery. Stating that the government has a zerotolerance policy towards child sexual exploitation, the department urged citizens to report any suspicious activity to authorities to protect vulnerable children.

### Kerala schools clinch top spots at EducationWorld rankings

#### THIRUVANANTHAPURAM. Five schools from Kerala figured in the all-India top 10 ranks in various categories in the 18th edition of EducationWorld India School Rankings (EWISR) 2024-25 released on Monday.

Government Vocational Higher Secondary School for Girls, Nadakkavu, Kozhikode, was ranked second best in the country in the 'State Government Day Schools' category. In the last two years, the school was placed in the all-India third position in this category. Kendriya Vidyalaya, Pattom, Thiruvananthapuram bagged the all-India seventh rank among 'Central Govt Day Schools'. Last year, the school was placed in the sixth spot. Jawahar Navodaya Vidyalaya, Chennithala, Alappuzha was ranked sixth in the 'Government Boarding Schools' category. In last year's ranking, the school had won the second spot. In the 'Day-Cum-Boarding Schools' category, Pallikoodam School, Kottayam retained its third rank at the national level. Sadbhavana World School, Kozhikode improved its position among 'International Day-Cum-Boarding Schools' by bagging the ninth position. It denoted a slight improvement from the 10th rank last year in the category.

in the past four years, Palakkad has emerged as the electrical accident capital of Kerala. In 2023-24, the district saw 54 electrical accidents and 27 deaths, both highest in the state, according to the statistics with the department of electrical inspectorate (DEI).

As many as 205 humans and 48 animals in the state were killed by electric shock over the past year, with the total number of accidents being 362. Palakkad recorded the highest number of accidents, 72, and deaths, 35, in the preceding 2022-23 as well. The number of deaths in the district in 2021-22 and 2020-21 were 27 and 38 respectively.

Thrissur is the second district with a high prevalence of electrical accidents. In 2023-24, Thrissur recorded 49 accidents. In terms of death, Thiruvananthapuram stood second with 22. In 2022-23, Thrissur was second in both accidents (47) and deaths (28).Unauthorised electric fencing is among the major reasons for the unusually

high number of accidents in Palakkad, says Santhosh K T, DEI's electrical inspector in the district. The use of iron rods or ladders near power lines to pluck fruits and the absence of the Residual Current Circuit Breaker (RCCB) at houses are other reasons. The electrical inspectorate, the government department responsible for the safety of electrical installations, is

Santhosh. "We conduct several awareness programmes, mostly mass media campaigns. The number of accidents and deaths in the district saw a significant decline in 2023-24 compared to the previous year. Accidents came down from 72 to 54 and deaths from 35 to 27," the inspector said.

Several old houses, especially in rural areas, lack RCCB and are susceptible to accidents. RCCB is an electrical safety device that cuts off electricity supply in case of electric leakage that causes accidents. The department had asked the Kerala State Electricity Board to create awareness on RCCB among consumers.

In 2023-24, there were nine deaths in the district due to electrocution from illegal fencing. "The menace is not confined to agricultural lands. Recently, we came across a case in which a woman was killed by a fence put around a poultry farm. The owner installed it to save birds from stray dogs," Santhosh said.

### SRR pupils face classroom shortage VIJAYAWADA. For 11 years, students at communicated our concerns to the

SRR Government Degree College have struggled with a severe shortage of classrooms, compounded by the ongoing presence of the Social Welfare Residential Government Degree College (SWRGDC) for Girls, which remains on SRR's premises instead of relocating to its intended site in Kanchikacherla.Established in 2013, SWRGDC has yet to move 42 kilometres away from its designated location, resulting in overcrowded classrooms and insufficient hostel facilities for both institutions.

'The college requires nine classrooms to SRR and CVR College Principal Dr K accommodate all three groups offered at SWRGDC, but we only have three. Nearly 175 girls are crammed into just three hostel rooms," said Thelagatu Praneetha, Girls' Convenor of the Students' Federation of India (SFI) at SRR College. She expressed frustration over the government's failure to allocate the necessary funds for the past decade, despite substantial budgets announced annually for education. The overcrowding has significantly affected



the academic experience for SWRGDC students and added strain on SRR College.

Bhagya Lakshmi highlighted the severe space constraints caused by the classroom shortage. "Our college operates two sessions and we offer 28degree programmes and require 84 classrooms to accommodate students, but currently, we only have 25," she explained to .

She emphasised that moving SWRGDC to Kanchikacherla, where land has already been allocated, would alleviate overcrowding at SRR College. "We have officials, and higher authorities are actively pursuing the issue," Dr Bhagya Lakshmi added.

Currently, SRR College has allocated eight rooms to SWRGDC, but two are designated for the principal and staff, leaving only six rooms for classes and hostel. "We are managing with what we have, but we still need at least three more rooms," said SWRGDC Principal Dr Neeraja V.Neeraja shared, "Ten acres of land have already been allocated in Kanchikacherla for the new campus. We urged Nandigama MLA Tangirala Sowmya to provide at least a temporary structure until the main building is constructed, and she assured us she would bring this to the attention of IT Minister N Lokesh."

Commissioner of Collegiate Education, Pola Bhaskar told TNIE, "The land for the College is ready, but funds need to be sanctioned for the permanent building, which is under the government's purview. We are also working to address the issue of dual colleges by identifying a temporary structure for SWRGDC."

'It has taken more than two years to complete the connecting road which is just 350 metres in length. What is the use of such a government office if it cannot complete a small road on time? Taking more than two years for it makes GIDA redundant," said Goban T G, a resident of Pizhala.

The bridge had been a longtime dream of the residents of the island.

"And it became a reality after it was commissioned in 2020. But due to the unfinished connectivity road, the travel to the bridge has become akin to taking a ride on a track designed for dirt racing!" said Goban

"It is a test of people's patience that it takes more than two years to build a small road that is essential for the entire population of Pizhala, who were excited by the commissioning of the infrastructure development project," said Biju Kannanganattu, another resident.

According to Goban, the road has been built over marshy land and hence needs proper reinforcement to last long.

But the way things are going on seems to point otherwise. Even though work started on Monday after the agitation and sit-in that was staged by the residents, the pace seems to be towards the slower side. On Monday, some workers could be seen levelling the road. The residents are keeping their fingers crossed," he added.

### Playing for country, for money

Rio de Janeiro 2016. The Olympics mixed doubles semifinal is on, and an Indian tennis legend is getting a bit anxious, for there looms the real possibility that Sania Mirza and Rohan Bopanna would beat Venus Williams and Rajeev Ram. Sania and Bopanna won the first set 6-2, and we-

fans, sports writers, coaches, Indian sportspersons — were hoping for an encore in the second... All except the anxious legend. He didn't want Sania and Bopanna to win a silver — or any medal! — because he had not been picked to partner Sania in the Olympics. Sania-Bopanna were, also, foes to him, for they were members of the camp of his former male doubles partner. Thus, he was willing hard, with all his heart, for Sania-Bopanna to fail, to lose in the semifinals, to not win a medal — the Indian medal count be damned.In the event, Sania and Bopanna lost the second set 2-6 and the third 3-10 to Venus-Ram; they still had the opportunity of winning a medal, a bronze, but they lost the third-place playoff 1-6, 5-7 to Radek Stepanek and Lucie Hradecka. It was a heartbreaking loss for Sania-Bopanna, for the Indian media pack, for the Indian fans - but not so for the aforementioned legend.

- the anxiousness of this great player at the possibility of a medal for Sania-Bopanna, and then the glee at them missing it — came to one's mind when controversy broke out over India No. 1 Sumit Nagal demanding \$50,000 from the All India Tennis Association to play for India in the Davis Cup tie against Sweden. India, missing top singles stars Nagal, Sasikumar Mukund and Yuki Bhambri, got a 0-4 hammering from Sweden.
- Sportspersons are human, not exemplars of morality, rectitude, patriotism. They're just like us — and possibly we're a bit better, because we're never exposed to the temptations that some sportspersons, especially cricketers, face every day of their lives. And if they do give in to temptation, those watching from the sidelines start booing.Sportspersons turn cynics when quite young, for their experience, of fellow players and coaches, tells them that the sports administrator is venal and undependable — often a politician or bureaucrat or businessman who joins up for clout in his city, then country, then the world. Once they have the vote in, say, the global governing body of a sport, or in the Olympics, such men are like kings - feted and lionised at the biggest sports events in the world. Power can be difficult to digest for the petty — they turn autocrats, treating athletes like menials.
- Some of these men turn up at, say, the tennis event at the Olympics, sozzled silly, courtesy complimentary alcoholic beverages. We in the media have seen them countless times, as have athletes. Sportspersons have utter contempt for such freeloaders. Somdev Devvarman, the former India No. 1 who had a highest global ranking of No. 61, said in 2017 about certain AITA officebearers who had missed the fourth and fifth sets of his Davis Cup match in 2014: "They were getting late for their single malt party down at the club as they thought my match was done and I had no chance of coming back. This information certainly didn't come as a surprise to me. I expect them to be unpolished. I also got a solid whiff of their single malt Scotch as they poured over me with congratulations after the match."Nagal, facing criticism for asking for money to play for India, clarified: "It is standard practice in professional sports for athletes to be compensated for their participation in events, even when representing their country."

Nagal also said he was undergoing rehab after an injury, and had informed "AITA well in advance about my inability to participate" in the Davis Cup.It must be stated that playing tennis as a pro with the need for a team of coach, physio, trainer, doctor, etc — is a very expensive proposition, and players do need to focus on their bread and butter, the ATP tournaments.AITA officials did not reveal that the association does get money from the International Tennis Federation with which to compensate Nagal that players do get paid for playing in the Davis Cup.

### Don't let the State trample over the law of the land

While courts can be expected to perform their assigned tasks, it would be unfair to impose a disproportionate burden on the judiciary.

THE Supreme Court's interim order of September 17, staying the demolition of properties of persons accused in criminal cases, is premised on the unexceptionable principle of constitutional governance, that the exercise of State power is accountable to the discipline of the Constitution. It is a reminder to the executive authorities that in a State governed by the rule of law, mere lip service to procedural niceties is not a sufficient assurance of substantive compliance with the mandatory requirements of legal due process. The court's order, rooted in 'the ethos of the Constitution', echoes the outraged conscience of the nation against the State's exercise of brute force in meting out retributive justice. That the order was resisted in court by the government in a matter seen as a frontal assault on constitutional conscience and an indelible scar on the soul of the nation speaks for itself. The court's intervention in a petition filed by the Jamiat Ulama-i-Hind in the wake of widely reported demolitions across the country was sought on the touchstone of Article 21 of the Constitution that guarantees to all individuals the right to life with dignity, which includes the right to shelter, privacy and reputation. Though belated, the court's order interdicts what is now infamously known as 'bulldozer justice', a punitive mode wholly incompatible with the first principles of constitutional justice. In a purposive judicial intervention, the court proposed a set of guidelines on a 'pan-India basis' to prevent unlawful demolitions anywhere in the country and has thus exercised its plenary jurisdiction to fill a legal vacuum. In a perfect harmonising of equities, it has ruled that the injunction regarding demolitions would not apply in cases of encroachment of public spaces such as "road, footpath, abutting railway line or any river body or water In the cause that is yet to be argued, the court is expected to bodies and also to cases where there is an order for demolition made by the court..."It is worrisome that the apex court's intervention came after several residential and commercial premises were unlawfully razed in what is prima facie a legally indefensible action across several states, such as Uttar Pradesh, Madhya Pradesh, Haryana, Maharashtra and Delhi. Even as attempts to justify 'bulldozer justice' persist, the unlawful use of brutal force by executive authorities to deprive citizens of their homes and places of work has shamed the nation. We are compelled to ask ourselves if there is "fair play for poor as well as for rich, for private persons as well as government officials" and whether "the right of the individual, subject to his duties to the State, be maintained, asserted and exalted" (from Winston Churchill's 1938 speech, expounding the necessary conditions of democracy). Clearly, as long as the sanctity of our homes is not secure against unjust State intrusion, the cherished ideal of Gandhi's Swaraj and a vision of a libertarian democracy in which, "...the poorest man may




in his cottage bid defiance to all the force of the crown..." will remain a distant dream. Discriminatory, disproportionate, arbitrary and violative of the rule of law, 'bulldozer justice' is an anathema to any civilised society, especially in a country whose political and social consciousness has been shaped in the crucible of a long and arduous struggle for freedom gainst the oppressive colonial rule.

Summoned to defend fundamental freedoms, it must revalidate its role as the nation's impartial judicial arbiter by scripting a credible remedy that will minimise, if not eliminate, the excesses of the State against its citizens.But the issue at hand raises larger questions: Must citizens be compelled to approach the highest court for relief against recurring high-handedness of the executive branch? Can a constitutional State sanction retribution through processes unknown to law and extend the consequences to the innocent family members of the accused, including women, children and the elderly, depriving them of a roof over their heads and the means of subsistence? Implicit in the interrogatory is a perceived perversion of constitutional governance at different levels that compels an urgent review of the nation's governing processes to ensure that administrative justice meets the test of fairness. institutional limitations. The defence of democracy and the rule of law is, after all, the collective burden of the three wings of the Indian State and, in the ultimate analysis, of the people as a whole, who must write their own story through peaceful democratic assertion against unjust actions of the State. As a repository of the people's power, the government is expected to exercise its authority in demonstrable compliance with the established legal procedures so that justice is not only done but is also seen to be done. We must confront a broader question: is the smallness of our politics conducive to the establishment of a just society? Indeed, it is necessary to state the obvious and ask difficult questions, lest we forget who we are. No apologies are owed for condemning the unacceptable, particularly, the inhuman acts that have wounded national sensitivities and have left behind an unhealable pain in an unending 'daze of grief'. By a robust refusal to countenance injustice and abuse of power, Justices BR Gavai and KV Viswanathan have once again vindicated the oath of their high office. In their path-breaking judgments on bail and 'bulldozer justice', the judges have validated the view of distinguished historian Arnold Toynbee that the history of the human civilisation is the history of how civilisations respond to challenges that shape the world. The tragedy of 'bulldozer justice' and the court's action will doubtless define the future course of India's democracy.

DESPITE opposition from political parties and civil society, the Union Government, on September 18, decided to move forward with simultaneous elections, accepting recommendations from a highlevel committee led by former President Ram Nath Kovind. The committee proposed that Lok Sabha and Assembly elections be held together, with municipal and panchayat elections following within the next 100 days. To implement this plan, the government will need to secure constitutional amendments in both Parliament and the Assemblies. The issue of simultaneous elections has been raging for decades. In 2013, before becoming the Prime Minister, Narendra Modi had emphasised the need for simultaneous elections, citing high costs and disruptions to development activities. Since then, various committees have examined the issue but failed to reach a viable solution. It was in this context that the Kovind-led

committee was formed, with a clear mandate to propose concrete methods for holding simultaneous elections rather than debating the merits of the proposal.

The committee delivered a comprehensive report within the mandated time frame. Established on September 2, 2023, it worked for 191 days and submitted an 18,626-page report on March 14, 2024. Its members included distinguished individuals from various fields. It sought inputs from political parties and legal experts, including former chief justices, former chief election commissioners and state election commissioners. Suggestions from the public were welcomed, with organisations like the Bar Council of India, the Confederation of Indian Industry and the Federation of Indian Chambers of

Commerce and Industry given opportunities to present their views. The report indicated that 21,558 responses were received, with 80 per cent supporting simultaneous elections. But critics have pointed out that suggestions were invited only in Hindi and English. Therefore, the response is not reflective of all regions of India. Inputs came from 47 political parties, of which 32 (all members of the NDA) favoured the proposal and 15 opposed it, labelling it



anti-democratic and anti-federal. Opposing parties raised concerns that the move could marginalise regional parties, promote national party dominance and lead to a presidential-style government. Based on these contributions and thorough research, the committee conducted an in-depth analysis.

Supporters of simultaneous elections argue that separate polls waste resources and lead to policy paralysis. While a majority of the experts agree that constitutional amendments are necessary, they contend that these changes would not be antidemocratic or anti-federal, nor would they undermine

the Constitution's basic structure or lead to a presidential form of government.A significant strength of the report is its comprehensiveness, consisting of 21 volumes of annexures, as it faithfully reproduces all past and present opinions, making it a valuable document. The committee unanimously recommended that simultaneous elections be implemented nationwide. It proposed necessary amendments to the Constitution and laws, including a

new Article, 82A, stating that "notwithstanding anything contained in Articles 83 and 172, all the legislative assemblies constituted in any general election held after the appointed date shall come to an end on the expiry of the full term of the House of the people." It clarified that "simultaneous elections" refers to elections for the Lok Sabha and all Vidhan Sabhas, excluding panchayat elections, which are proposed to be held "within 100 days". However, this does not amount to simultaneous elections. In fact, the proposed remedy may be worse than the current situation. First, it leaves out over three million elected representatives compared to the 5,000 included. Moreover, an election held three months later is not a simultaneous election but constitutes an absolutely new one, necessitating all logistical preparations again setting up polling stations, selecting and training polling parties and redeploying security. All this has to be done within three months, when the 15-million staff would have barely recovered from what is officially described as the largest management exercise in the world. Importantly, voters would have to return to the polls and millions of them will not be able to do so as they are poor daily-wage workers, losing their important constitutional right. The report



also states that "where any state legislative assembly is dissolved on account of a no-confidence motion, a hung House, or any other event, fresh elections will be held for such a new House with the tenure ending with that of the House of the people." This provision does not eliminate the possibility of midterm polls. Candidates could end up spending crores on an election for a truncated term - potentially as short as one to two years. This certainly does not constitute simultaneous elections. The committee has commendably emphasised the need for a single electoral roll by proposing an amendment to Article 325, recognising that the voters for all three tiers of elections are the same. This essentially shifts the responsibility for local bodies' electoral rolls to the Election Commission of India (ECI) "in consultation with State Election Commissioners", a task that is far from simple. It has also acknowledged the ECI's "detailed requirements for equipment such as EVMs, VVPATs, polling personnel, security forces, and election materials", along with expenditure estimates. Although the specific costs are not mentioned, it is clear that we will require at least three times the current number of EVMs and VVPATs, which would entail humongous expenses on nearly 40 lakh EVMs and VVPATs each, that should have been explicitly outlined, especially since cost reduction is one of the main reasons for this proposal.With such significant compromises, the moral authority of the simultaneous poll proposal has been undermined. 

Karnataka High Court bars using, uploading videos of hearings amid Pak remark row

The court has also ordered social media platforms, including YouTube, Facebook, X to takedown the videos taken, and uploaded from the **High Court's** official livestreaming footage.

New Delhi: The Karnataka High Court on Tuesday prohibited the public from using or uploading videos of court proceedings, the Bar and Bench reported. This development comes after two video clips featuring Karnataka High Court judge Justice V Srishananda, making controversial remarks, went viral. The court has also ordered social media platforms, including YouTube, Facebook, X to takedown the videos taken, and uploaded from the High Court's official live-streaming footage.Justice Hemant Chandangoudar also directed certain social media users to delete the videos of court proceedings from their social media handles. 'Till next date, respondents 6 to 8



[social media platforms] and 9 to 14 [private respondents] are restrained from displaying the videos on their channels. Any video already uploaded in violation of Rules must be deleted," the court's interim order was quoted by the Bar and Bench in its report. The court, while issuing a notice on a petition filed by the Advocates' Association in Bengaluru, addressed concerns over the public use of live-streamed court

social media platforms. The petition was filled after two The Advocates' Association of video clips featuring Karnataka High Court judge Justice V Srishananda, making controversial remarks, went viral.

Despite the association's request to stop livestreaming, the court made it clear that stopping the broadcasts was not the

answer to the misuse of such videos. Justice Chandangoudar emphasised that while the morale of lawyers could be impacted, judges and lawyers alike must develop resilience."You have to be thickskinned. Even judges have to be thick-skinned. I agree that lawyers' morale can be affected, but the solution is not to stop livestreaming. If any offence is

> Bengaluru has filed a petition in the Karnataka High Court, seeking measures to prevent the public from editing, morphing, or illegally using live-streamed court proceedings. The plea also asked for a directive to social media platforms like YouTube, Facebook, and X (formerly Twitter) to remove any videos or reels created using footage from the court's live-streams.

This legal move followed widespread criticism of two video clips featuring Justice V Srishananda. In one video, the judge referred to a Muslim-majority neighbourhood in West Bengaluru as "Pakistan." In another, he made a genderinsensitive comment while addressing a woman lawyer. These remarks ignited public outrage,

prompting the Advocates' Association to request that livestreaming be paused until clear guidelines on courtroom conduct are established. The controversy caught the attention of the Supreme Court, which asked the Karnataka High Court Registrar General for a report on the matter. Justice Srishananda later expressed regret for his comments.During the hearing of the Association's petition, Additional Solicitor General Arvind Kamath highlighted that the High Court already has mechanisms in place to address complaints about video misuse. He stated, "If an offence comes to someone's notice, only a complaint has to be made, and action will be taken." Kamath also defended the live-streaming of court proceedings, calling it a "boon" for transparency in the judicial process.

### **Arrest Warrant Against** Actor Siddique In Rape **Case, Cops Begin Search**

The charges stem from a complaint filed by an actress who alleged that Siddique raped her at a state-owned hotel in Thiruvananthapuram in 2016.

New Delhi: Kerala Police are reportedly gearing up to arrest actor Siddique following the Kerala High Court's decision to deny him anticipatory bail in the Malayalam cinema #MeToo case, sources said. The court rejected Siddique's bail plea in a rape case lodged against him by a former actress. A lookout circular has been issued as police intensify efforts to trace Siddique's whereabouts.

The charges stem from a complaint filed by an actress who alleged that Siddique raped her at a state-owned hotel in Thiruvananthapuram in 2016. According to sources, the victim had initially refrained from reporting the incident but came forward after the explosive Hema Committee report was released last month. The report highlighted the systemic abuse and harassment faced by women in the Malayalam film industry, encouraging several former actresses to share their stories of exploitation. The actress, in her complaint, claims that Siddique coerced her into providing sexual favours in exchange for a role in a Tamil movie. When she refused, he allegedly raped her. Siddique, who was recently elected general secretary of the Association of Malayalam Movie Artistes (AMMA), resigned from his post soon after the allegations surfaced, prompting the entire committee, chaired by actor Mohanlal, to step down as well.Siddique has denied the allegations, accusing the complainant of harassing him since 2019

### Gujarat school principal kills girl for resisting rape, dumps body; arrested

The principal said that when he tried to rape the girl, she started screaming. He put his hands on her mouth tightly to stop her screaming. However, the girl died, following which he hid her in the back of the car. He took her body and left it inside the school compound in the evening, after the classes were over.

#### New Delhi. Three railway employees were arrested in Gujarat's Surat district on Monday for allegedly tampering with tracks and then alerting officials about a "sabotage" in a bid to take credit for averting a possible train accident, police said. Surat Rural Superintendent of Police (SP) Hotesh Joysar said the three employees -- Subhash Poddar (39), Manish Mistry (28) and Shubham Jaiswal (26) -are trackmen in the railways' maintenance department. He added that the accused indulged in such an act to get themselves felicitated. The Surat Police launched a probe after some unidentified people allegedly tampered with a railway track by removing fish plates and loosening several bolts in an attempt to derail trains on September 21.

The SP said Poddar and others, while on inspection between Kosamba and Kim stations, had alerted authorities at 5:30 am on September 21 about "miscreants" removing elastic clips and two fishplates from one set of tracks and placing them on another to derail a train. According to the SP, the accused, who were on night duty, had sent a video of the compromised truck to their seniors while alerting them. He also said the Railway officials had informed the police that a train had passed on the route just before the tampering was discovered.



### "What Are We Doing To Education System?" Chief Justice On Punjab NRI Quota

New Delhi: The NRI quota system in college admissions was nothing but a fraud, the Supreme Court said today as it dismissed the Punjab government's appeal against a high court order that junked amended rules to avail admission to MBBS courses through this quota. The Punjab government had, in a notification dated August 20, widened the



definition of an NRI candidate and made relatives of Non-Resident Indians (NRI) eligible to seek admission to the MBBS course under this quota. The Punjab and Haryana High Court shot down this notification, observing that this "opens the door for potential misuse".In the Supreme Court today, the Punjab

government's counsel said that Himachal Pradesh and Uttar Pradesh were following a broad definition for NRI quota admissions. "HP, UP, Chandigarh, everyone is following the definition which I am saying ... so only I am under (a) narrow definition," he said.Chief Justice of India DY Chandrachud replied, "You are saying the nearest relation of NRI will also be considered. what is this? just a money-spinning tactic by the state."The bench, also comprising Justice JB Pardiwala, backed the high court order. "We must stop this NRI quota business now! This is a complete fraud. This is what we are doing to our education system," the Chief Justice said. "Look at the result. Those who got marks three times high won't get admission," he added. Justice Pardiwala said all the applicants are from India. "They are just relatives, tai (aunt), taau (uncle), chacha, chachi."

The Chief Justice said, "What is a ward? you just have to say I am looking after X." He said the court cannot back something that is "blatantly illegal".

### **Badlapur sex abuse accused killed in** police encounter: A timeline of events

New Delhi: Akshay Shinde, the prime accused who sexually abused two kindergarten girls at a school in Badlapur in Maharashtra's Thane district in August, died on Monday in a retaliatory firing after he snatched a policeman's gun and opened fire.Shinde (23), a sweeper employed at the school, was arrested on August 17 for sexually abusing the two girls, aged four and five, in a school toilet, four days ago. The incident had triggered widespread protests with parents and other locals blocking railway lines at Badlapur railway station before the police removed them forcibly.On Monday, Shinde was being taken from Taloja jail to Badlapur in connection with a case of unnatural sex filed by his former wife. According to the police, the accused snatched a weapon from an officer and opened fire while he was being transported from jail in a police vehicle. He was critically injured in the firing and later died in hospital.

The encounter triggered a war of words



between the Maharashtra government and the Opposition. Here is a timeline of when the incident unfolded to Shinde's death in the encounter:

August 13: Two kindergarten girls were sexually abused in a school toilet by Shinde in Badlapur. Shinde was employed on a contractual basis on August 1. August 16: The incident came to light when one of

the victims narrated her ordeal to her parents.

August 17: Shinde was arrested by the police after the incident came to light.

August 20: 'Rail roko' protest at Badlapur railway station with hundreds of August 23: SIT adds Pocso sections against protesters blocking railway tracks hindering train operations. Police later removed the protesters from the site.August 20: The ruling Mahayuti alliance suspended policeman who refused to initially file an FIR in the sexual abuse case. Later, three police officers were also suspended.August 20: The Maharashtra government forms a Special Investigation Team (SIT) to probe the Badlapur incident. August 20: People call for bandh. Parents and others protest and vandalise the school where the two girls were sexually abused. They later protested at the Badlapur railway station for over 10 hours, demanding that the accused be hanged in public.

August 21: The principal and two staffers working at Badlapur school were suspended.August 22: The Bombay High Court took note of the case, questioning why no action was taken against the school.August 22: SIT begins a probe into the case

### Vodafone Idea shares fall 2% as **ICICI Securities cuts target price**

ICICI Securities has reduced Vodafone Idea's EV/EBITDA multiple to 13 times FY27 from 14 times and lowered its target price to Rs 11 from Rs 15.

New Delhi. Vodafone Idea shares declined over 2% after ICICI Securities slashed its target price, citing concerns over the company's financial outlook.At 11:36 am, shares of the telecom operator were down 2.03% at Rs 10.60 on the Bombay Stock Exchange (BSE).Following an analyst call with the management, ICICI Securities noted that Vodafone Idea remains hopeful of resolving an "arithmetical error" in the calculation of its Adjusted Gross Revenue (AGR) dues. The telecom operator is currently engaging with the government on the matter, despite the Supreme Court's rejection of its curative petition regarding these dues.According to ICICI Securities,



Vodafone Idea believes its case has strong merit, and discussions with the government have been encouraging. The company is factoring in the conversion of Rs 29,000 crore of government debt into equity at the end of the moratorium period under the recent telecom reform package.

While Vodafone Idea has not included AGR relief in its business recovery plan, ICICI Securities moved its estimate of AGR relief worth Rs 35,000 crore from FY25 to FY26. This shift, along with the delayed capex acceleration, resulted in revised net profit projections for FY25-27E, although its EBITDA estimate for the same period remains unchanged. Given the rising uncertainty surrounding the AGR resolution, ICICI Securities reduced

Vodafone Idea's EV/EBITDA multiple to 13 times FY27 from 14 times and lowered its target price to Rs 11 from Rs 15. The brokerage maintained a 'Hold' rating on the stock. Meanwhile, Motilal Oswal Financial Services (MOFSL) has a target price of Rs 12 and a 'Neutral' rating.

ICICI Securities also noted that Vodafone Idea is close to finalising Rs 25,000 crore in debt funding, with an additional Rs 10,000 crore for non-fund facilities, which should bolster its capex efforts.

The telecom firm has signed agreements with major equipment suppliers for Rs 30,000 crore worth of radios, set to be delivered over the next three years. Capex is expected to begin in November 2024, alongside a potential tariff hike of 15-20% over the next 15 months.Meanwhile, Motilal Oswal Financial Services (MOFSL) highlighted that despite the company's high operating leverage, the significant cash required to service its debt limits the upside potential for equity holders. The conversion of unpaid installments into equity postmoratorium could start by FY26/FY27, further affecting the company's financial structure.

Over nine out of 10 individual traders in the equity futures and options segment continue to incur significant losses, revealed the study, adding that despite consecutive years of losses, more than 75 per cent of loss-making traders continued trading in F&O.The proportion of young traders (below 30 years) in the F&O segment rose from 31 per cent in FY23 to 43 per cent in FY24. Moreover, individuals from beyond top 30 (B30) cities made up over 72 per cent of the total F&O trader base, a higher proportion compared to mutual fund investors, 62 per cent of whom are from B30 cities.About 93 per cent of over 1 crore individual F&O traders incurred



average losses of around Rs 2 lakh per trader (inclusive of transaction costs) during the study period. Top 3.5 per cent of loss-makers, approximately 4 lakh traders, faced an average loss of Rs 28 lakh per person over the same period, inclusive of transaction costs.Only 1 per cent of individual traders managed to earn profits exceeding Rs 1 lakh, after adjusting for transaction costs, the findings showed. The SEBI study found that in contrast to individual traders, proprietary traders and Foreign Portfolio Investors (FPIs) as a class booked gross trading profits of Rs 33,000 crore and Rs 28,000 crore, respectively in FY24 (before accounting for transaction costs). Against this, Individuals and others incurred a loss of over Rs 61,000 crore in FY24 (before accounting for transaction costs). Most of the profits were generated by larger entities that used trading algorithms, with 97 per cent of FPI profits and 96 per cent of proprietary trader profits coming from algorithmic trading, said the study. On an average, individual traders spent Rs 26,000 per person on F&O transaction costs in FY24.Over the threeyear period from FY22 to FY24, individuals collectively spent about Rs 50,000 crore on transaction costs.

India is one of those," said Scindia.Scindia highlighted India's fastest 5G rollout, with 4.5 lakh base tower stations installed and 97% of cities covered with 5G. The telecom sector's robustness enabled this achievement, with Rs 4.26 lakh crore invested in capex over two years.

Regarding 4G coverage in uncovered villages, a total of 7,101 4G mobile

towers have been commissioned by the telecom service providers including Reliance Jio, Bharti Airtel, and BSNL, under various Digital Bharat Nidhi-funded 4G schemes, including the 4G saturation scheme. Out of these, 2,618 towers have been made operational since June 2024.

### **GoM to discuss rate rationalisation on September 25**

NEW DELHI. The Group of Ministers responsible for Goods and Services Tax (GST) rate rationalisation is set to convene on September 25 in Goa to deliberate on potential adjustments to tax slabs and rates. The six-member Group of Ministers (GoM), led by Bihar Deputy Chief Minister Samrat Chaudhary, last convened on August 22.

They submitted a status report to the GST Council on September 9. The government aims to finalise the process of GST rate rationalisation by the end of the year, as per sources. According to sources, the panel is likely to deliberate on the possibility of merging 12% and 18% goods and services tax slabs into a single unified rate, though no formal proposal has been put forward yet. Meanwhile, the Centre is also concerned about the revenue generation -- the average GST rate at about 12% is below the revenueneutral rate of 15.3%.

'The revenue-neutral rate is crucial as it represents the level at which government revenue remains stable following the implementation of GST. The lower-thananticipated average rate has raised concerns about the government's ability to generate adequate revenue, leading the Group of Ministers (GoM) to initiate discussions on possible adjustments to the existing tax rates. However, not all states are in agreement with the idea of altering the goods and services tax structure," a top source told TNIE.

Notably, both West Bengal and Karnataka have voiced their concerns and are hesitant to support any immediate changes to the tax slabs.Following the August meeting, West Bengal finance minister Chandrima Bhattacharya expressed her opposition to changing the current goods and services tax rates, advocating for the preservation of the existing structure.

In a similar vein, Karnataka Revenue Minister Krishna Byre Gowda remarked that the GST system has largely stabilized over the past few years, warning that any alterations could upset this equilibrium. He also mentioned that the Group of Ministers (GoM) would revisit this topic in their next meeting.

The image in question had recently resurfaced on social media and was considered offensive and a violation of the ECB's directive 3.3, which covers "acts or omissions prejudicial to the interests of cricket or likely to bring cricket or cricketers into disrepute."Despite the breach, the Cricket Discipline Commission (CDC) clarified that Knight's actions were without "racist or discriminatory intent.""The independent Cricket Discipline Commission (CDC) has issued its sanctions



decision in relation to Heather Knight after she was charged over a non-recent photograph which appeared on social media.""Ms Knight admitted a breach of ECB Directive 3.3 which stated at the time of the offence in 2012\*: "No such person may conduct himself in a manner or do any act or omission which may be prejudicial to the interests of cricket or which may bring the game of cricket or any Cricketer or group of Cricketers into disrepute." read the statement from the CDC.

#### What did Knight say about fine?

At the time of the incident, Heather Knight was 21 years old and has since apologised, acknowledging her naivety. She emphasised that there was no malicious intent behind her actions and expressed regret for any offense caused."I'm truly sorry for the mistake I made in 2012. It was wrong, and I have long regretted it. Back then, I simply was not as educated as to the implications and consequences of my actions as I have become since. There was no ill-intent meant. But none of the other top eight Afghan batters could score more than 10 with three of them run out.No. 9 batter AM Ghazanfar made a whirlwind 31 not out off 15 but South Africa always looked in control through the

disciplined bowling of Lungi Ngidi, Nqabayomzi Peter and Andile Phehlukwayo, who all picked up two wickets each. 


New Delhi. Manchester City midfielder Rodri is expected to miss the remainder of the season after tests on Monday indicated he

### If I were Vinesh Phogat, I would apologise for Olympic disqualification: Yogeshwar

New Delhi Olympic medalist Yogeshwar Dutt disqualification was the right call. They criticised Vinesh Phogat, stating that the wrestler did not take responsibility after the Paris Olympics, instead blaming others for her disqualification. Yogeshwar, who won a bronze medal at the London Olympics, said that if he had been disqualified, he would have apologised to the entire nation. He expressed disappointment with how Vinesh handled the highly-publicised ordeal.

Speaking at the Panchayat AajTak Haryana 2024 event, Yogeshwar said he was surprised when Vinesh started spreading conspiracy theories about her Olympic disqualification. He even claimed that Vinesh went as far as blaming Prime Minister Narendra Modi for the incident."She was disqualified from the Olympic Games, she should have apologised in front of the entire nation, saying that she FALSE PERCEPTION WAS CREATED: made mistakes. But instead, she termed it a VINESH

legal teams involved, and that Phogat herself chose not to pursue further legal action after the CAS verdict.Following her disqualification and the rejection of her appeal, Phogat announced her retirement from wrestling and has since entered politics, joining the Indian National Congress.
