BJP's intent to dismantle Waqf Board clear in Amendment Bill: Owaisi

New Delhi, Sep 25: AIMIM chief Asaduddin Owaisi alleged that the Waqf (Amendment) Bill, 2024, has been introduced by the Centre to per-



manently abolish the Waqf Board. Lok Sabha MP and AIMIM chief Asaduddin Owaisi on Wednesday alleged the BJP-led NDA at the Centre does not have intentions to protect, develop or bring efficiency in Wagf properties. He said the Wagf (Amendment) Bill, 2024, has been introduced by the Centre to permanently abolish the Waqf Board. Citing legal provisions, Owaisi explained that the Waqf Act of 1995 is based on the concept of 'Waqf by user,' which

mandates that if a place is used for prayers, functions as an orphanage, or serves as a graveyard, it becomes Waqf property, something the government now intends to dismantle.

"In Hinduism, there are many endowment boards where places become religious by usage. In Uttar Pradesh, out of 1,21,000 registered properties under the Sunni Waqf Board, 1,12,000 are Waqf by user. Once Waqf by user is abolished, what law will they implement?" asked Owaisi. He also alleged that the draft of the Waqf (Amendment) Bill states that a practising Muslim of five years can donate to the Waqf Board.

However, it does not clarify what is meant by "practising Muslim," he said. "Does it imply someone who offers prayers five times a day, keeps a beard, wears a skullcap, or doesn't have a non-Muslim wife?" Owaisi questioned. He added that no such law applies to people of the Hindu religion, where anyone can donate at any time without these legal restrictions. "I want to ask the government, why did they come up with such terminology as 'practising Muslim'?

"As I said yesterday, I repeat today: there is no question of fearing an investigation; I am determined to face everything. After discussing with legal experts, I will decide the next course of action," he added. It was alleged that Siddaramaiah's wife Parvathi was illegally allotted 14 sites worth ?56 crore by the Mysuru Urban Development Authority (MUDA). The MUDA had allotted plots to Parvathi under a 50:50 ratio scheme in lieu of 3.16 acres of her land, where it developed a residential layout, as per the allegations. Earlier, the high court granted temporary relief to Siddaramaiah in its interim order passed on August 19.

My father is 'most accepted face' in Maharashtra at present: Aaditya Thackeray

Mumbai, Sep. 25: Shiv Sena (UBT) leader Aaditya Thackeray on Wednesday said his father and former Maharashtra chief minister Uddhav Thackeray is the "most accepted face" in the state at present. While Congress leaders have pointed out that the chief minister's post traditionally goes to the party in an alliance that wins the highest number of seats, Aaditya said at the India Today Conclave here that his father was one of the "foremost leaders who can lead Maharashtra." Congress, Shiv Sena (UBT) and NCP (Sharadchandra Pawar) are part of the Opposition's Maha Vikas Aghadi (MVA) in the state and INDIA grouping at the national level. Asked what would the Sena (UBT) do if the Congress won more seats in the coming state elections, Thackeray referred to the work done by his father's government during the coronavirus pandemic, and said it was one of the best governments of the past few decades. "Even today, he is the most accepted face. If you go out to the hinterlands of Maharashtra, farmlands of Maharashtra, and (ask people) they will tell you that Uddhav Balasaheb Thackeray is the only man who stood with us in our

toughest of times," Aaditya said. Asked if he would like Uddhav Thackeray projected as the face of the alliance, Aaditya said, "If today




there is a person who can lead the state in a unified manner, in a manner that is able, (then) yes, Uddhav Balasaheb Thackeray stands as one of the foremost people who can

Seat-sharing talks of the MVA were proceeding in a better manner than those of the BJP and its "broken" allies in the ruling Mahayuti coalition, he claimed. To a question about the Shiv Sena (UBT)'s low strike rate in comparison to its allies in the Lok Sabha elections, Thackeray said his party won nine seats even after it had lost 40 MLAs and 12 MPs (when Eknath Shinde split the party in June 2022 and toppled the Uddhav Thackeray-led MVA government). The votes it polled in Thane and Dombivli, considered to be Chief Minister Shinde' strongholds, were "very good", he added. Of the 48 Lok Sabha seats in Maharashtra, the Congress won 13 of the 17 seats it contested, Sena (UBT) won nine out of 21 and NCP (SP) eight out ten. The Sena (UBT)'s strike rate of 42 percent was lower than the rival Shinde-led Shiv Sena's 47 per cent strike rate. "We may go low in terms of strike rate but we will not lose out on principles which the BJP compromises on for electoral gains," the Thackeray scion further said. "We have a clear-cut understanding in the MVA. We are not fighting for the post.

Badlapur killing: Troubled history of encounters returns to haunt Mumbai

MUMBAI. The killing of the Badlapur accused has stirred memories of Mumbai's troubled history of police encounters dating back to mid-1980s. Between the 1980s and 2010, more than 200 suspects and accused persons were killed in police encounters.

While a magisterial enquiry followed in every such case, convictions were rare. One of the few cases where policemen were convicted involved the encounter of alleged Chhota Rajan aide Ramnarayan Gupta, also known as Lakhan Bhaiyya, in 2006. Several officers were held accountable, marking a rare moment of judicial success in a landscape otherwise dominated by acquittals and clean chits. Other high-profile cases such as the killing of UP gangster Sandeep Gadoli are still under trial. Another notable case is the custodial death of Khwaja Yunus, whose murder trial is still pending. Assistant police inspector Sachin Waze and three of his constables are accused of killing Yunus in custody while claiming that Yunus had escaped. Police encounters became common in Mumbai during the 1980s and peaked in the 1990s, when organised gangs ruled the underworld. Back in the day, police often claimed that in most cases, suspects opened fire first and officers were forced to retaliate in self-defense. Police sources attribute the decline in the trend to the elimination or escape of many dreaded gangsters.

Among police officers who came under the radar for fake encounters in this era were Vijay Salaskar, Pradip Sharma, Praful Bhosale and Daya Nayak. Salaskar died in the 26/11 Mumbai terror attack while Sharma was convicted in the Lakhan Bhaiyya case. Bhosale was implicated in the Khwaja Yunus case but was acquitted and rejoined the force.

'Waqf Board laid unlawful claim on 600 families' land in Munambam'

Residents to stage protest in Munambam alleging unlawful claims of the Waqf Board on the land owned by them, KCBC, Syro-Malabar Public Affairs Commission declare support

KOCHI. The plight of over 600 families residing in Munambam, who are fighting the alleged unlawful claims of the Waqf Board on the land owned by them, has been brought before the Lok Sabha Secretariat by the Kerala Catholic Bishops' Council (KCBC) and the Syro-Malabar Public Affairs Commission (SMPAC). In two separate missives, the organisations have expressed their support for the Union government's proposed amendment of the Waqf laws. On

September 27, the residents of Munambam will hold an agitation at Vanchi Square in

Both KCBC and the Syro-Malabar Public Affairs Commission have urged the Joint Committee of Parliament on the Waqf (Amendment) Bill to take immediate and decisive action to resolve the issue and ensure that such claims on lawfully owned

Speaking about the issue that has placed the residents in a quandary, Fr Michael Pulickal CMI, secretary of KCBC's Commission for Social Harmony and Vigilance, said, "Nearly five years ago, the Waqf Board had laid claim to the areas of Munambam, Cherai, and Pallikal islands in Ernakulam district, located along the northern coast of

Vypeen. This region comprises around 1,000 land titles and is home to more than 600 families of various religious backgrounds, with land ownership records dating back to 1989. These residents are now facing severe hardship as they are being forced to vacate the land they legally purchased. This situation has led to serious human rights violations, infringing on their constitutional

rights to live and own property.'

Elaborating on the issue, he said, "The history of ownership of this disputed land dates back to 1902. At that time, the King of Travancore leased 404 acres of land and 60 acres of water to Abdul Sattar Musa Haji Seth, who had come to Kerala from Gujarat for farming purposes. The lease had previously excluded the land of local fishermen who had lived there for many years before it."

Later in 1948, his successor Siddique Seth registered this land at Edapally (Ernakulam) Sub-Registrar Office. During the last 50 years, sea erosion led to significant land loss in this region. In particular, torrential rains and rough seas in 1934 completely obliterated a locality 'Pandara seaside'. A significant portion of this was the land leased by the King to Seth. But, later on, land registered by Seth included areas where fishermen had resided for nearly a century,"

BMC issues Rs 1,600cr tender for concretisation NIA charges cafe blast of EEH, WEH service and slip roads

Mumbai. BMC has proposed to spend Rs 1,600 crore for concretisation of service roads, slip roads, and junctions of both Eastern Express Highway (EEH) and Western Express Highway (WEH).

In a tender notice published on Sept 23, BMC said that the contract period for the work would be 24 months excluding monsoons. The scope of work includes civil works, concretisation works,

construction of storm water drains, ducts, footpaths, and allied works.

"The contractor is expected to maintain the project road in traffic-worthy conditions/motorable by using asphalt mixes during monsoon after notification of award of works and till completion of RTI activist Anil Galgali criticised the move, contract period or completion of entire work whichever is later. The trenches excavated by various utilities including



BMC's departments on Eastern Express Highway, during the contract period shall be reinstated by the contractor of the said work, as per existing policy guidelines and relevant specifications and as directed by the engineer including intervening monsoon," states the tender document.

stating that service roads are not meant for heavy vehicles and therefore do not require concretisation. "If they are properly asphalted and maintained, service roads can last just as long. These roads are frequently dug up for trenching work, and once concretised, it will be harder to do so repeatedly without compromising the road's quality," said Galgali. This year, a tender was floated before monsoon for repair of bad patches on both WEH and EEH during monsoons.

While EEH spans across 20km of road length, WEH is spread across 35km. They are two of the busiest traffic stretches, especially during peak hours in the morning and evenings.

In Nov 2022, MMRDA handed over EEH and WEH to BMC. Since then, BMC has taken over repairs of the road, beautification, and also full-fledged

BENGALURU. The National Investigation Agency (NIA) on Tuesday charge-sheeted The Rameshwaram Cafe blast co-accused Abdul Matheen Ahmed Taaha alias Taha, and Mussavir Hussain Shazib alias Shazib in the Shivamogga ISIS conspiracy case, taking the total chargesheeted accused to 10 in the case.

The duo was charged under various sections of the former criminal code, the Indian Penal Code (IPC), and the Unlawful Activities (Prevention) Act (UAPA) in the third supplementary chargesheet filed by NIA before the special cour in Bengaluru.

Taha and Shazib were earlier charge-sheeted by NIA in the Rameshwaram Cafe blast case, and for their involvement in Al-Hind ISIS module, Bengaluru. "Residents of Shivamogga district, the two men were engaged in radicalising and recruiting gullible Muslim youths, including the co-accused, in the ISIS conspiracy case," NIA stated in an official release on Tuesday.

The case relates to the anti-India activities of the proscribed terrorist organization Islamic State (IS/ISIS). The Central counter-terrorism agency had taken over the case from Karnataka police in November 2022. "The accused were involved in violent activities like arson, trial explosions and burning of the Indian national flag, in addition to radicalization, recruitment, terror funding, as part of the IS conspiracy to spread terror and destabilise the nation," the agency added. Investigations in the case, originally filed in September 2022 by the state police, are ongoing.

MSc graduate arrested for arson after setting royal enfield bullets on fire

The accused is identified as Pulakith, a resident of Mahalakshmipuram. Despite having an MSc in Tourism, he was unemployed.

BENGALURU. Upset over not having a Royal Enfield Bullet motorcycle of his own, a 25-yearold MSc graduate went about setting three motorcycles of the type on fire, for which he has been arrested by the Peenya police. The accused had set fire to three Bullets that were parked outside a PG accommodation in HMT Layout. He sourced petrol from the vehicles that he targeted, and used it to ignite the fire.

The accused is identified as Pulakith, a resident of Mahalakshmipuram. Despite having an MSc in Tourism, he was unemployed. Pulakith had set fire to the motorcycles around 1 am on September Deepanshu Agarwal, one of the bike



owners, had filed a complaint in this regard. Agarwal, who is a student, had purchased a second-hand Bullet, a few months ago. The accused had

specifically set Agarwal's Bullet afire, however, the flames spread to the other Bullets parked nearby, and incinerated them. The inmates of the PG, on seeing the flames, alerted Agarwal. Based on CCTV footage, the police arrested the accused, who has since been released on bail. "The accused and the complainant don't know each other. Pulakith, who keeps loitering around, saw Agarwal's Royal Enfield Bullet parked outside the PG. Upset over not having a Bullet himself, he set fire to the two-wheeler. Two other motorcycles that were parked on either side also caught fire in the incident. Initially, it was suspected that some local criminals could be involved," said an officer. The

Thiruvananthapuram: Finally, KWA charges new pipelines on Vellayambalam-Thycaud stretch

KWA will take up another major work along the stretch in coming week, at Vazhuthacaud jn

THIRUVANANTHAPURAM. After months-long protests and delays, the Kerala Water Authority (KWA) finally charged the new pipelines in the Althara-Thycaud areas in Thiruvananthapuram on Tuesday. Several residential areas on the Vellayambalam-Thycaud stretch suffered water-supply disruptions owing to the smart road works for several weeks, forcing the residents to stage multiple protests demanding immediate restoration of water supply.

Charging the new pipelines along the Althara-Thycaud stretch is among the major works taken up after the controversial pipeline shifting at Nemom, which led to a five-day disruption of water supply in the capital city. On Tuesday, the KWA managed to complete the 12-hour-long work ahead of schedule.

"The work began at 10am and we were able to complete the work by 4pm. We have successfully charged the lines and everything is under control. The higher areas will start getting water soon, and by midnight, the water supply will be restored," said a KWA official.

Following a series of protests by the residents'



association along the stretch, the Kerala State Human Rights Commission too had intervened in the matter. On account of the

Max temp 37°C, no respite from sultry weather for a few days

Gurgaon: The city witnessed a sultry day on Tuesday with the maximum temperature soaring to 37.2 degrees Celsius, which was 1.8 notches higher than the previous day — highest for the month in Sept so far. It felt like a hot summer day. The sultry weather conditions may continue for the next few days, according to India Meteorological Department (IMD).On Tuesday, the minimum temperature was at 26.1 degrees Celsius, which was 0.8 notches higher than the previous day. IMD predicted that the maximum temperature for the next five days is likely to remain in the range of 34 and 35 degrees Celsius, while the minimum temperature may fall between 25 and 26 degrees Celsius. This means that the sultry weather conditions are expected to continue for a few more days, much to the dismay of the residents.

However, there is some relief in sight as isolated areas in the region are expected to experience light showers from Thursday onwards. An IMD official said, "Weather has been dry for Haryana on Monday. Gurgaon is likely to see partly cloudy skies with one or two spells of rain or thundershowers between Sept 26 and 30."The city's air quality index (AQI) remained in the 'satisfactory' category on Tuesday at 71.

Meanwhile, a haze hung over Delhi on Tuesday as the national capital's air quality deteriorated. The average AQI worsened to the higher end of 'moderate' category at 197 at 4pm. By 6pm, it entered the 'poor' category with an AQI of 201, rising to 204 by 8pm. The last time Delhi recorded a 'poor' air day was on June 12, when the AQI stood at 211.

Man treated for cancer without stoma bag in city

Gurgaon. A 53-year-old Indian-origin man residing in the UK, diagnosed with stage one rectal cancer, discovered a life-altering solution at a hospital in the city. The patient was initially advised to undergo radiation and chemotherapy in the UK. The recommended treatment plan involved radiation and chemotherapy, along with the excision of his rectum, necessitating a permanent stoma bag for stool passage. He then travelled to India and visited CK Birla Hospital. Dr Vinay Samuel Gaikwad, director (surgical oncology) at the hospital, said: "We opted for TAMIS procedure as this technology is cost-effective, abbreviates hospital stay and diminishes morbidity. Had it not been for TAMIS, the surgery would have left a long incision besides posing the risk of infection and

No relief from water, sewer problems': Minister heckled

Gurgaon. Mool Chand Sharma, the BJP candidate from Faridabad's Ballabhgarh, encountered resistance from locals during an event late on Monday evening.

Sharma, Haryana minister for industries and two-time MLA, has been given the party ticket for the third time. When he arrived in Sector 22 Ballabhgarh for campaigning later than the scheduled time, a crowd of locals surrounded him and heckled him. In response, he took an oath on stage, promising to resolve the area's issues. People said despite him being an MLA for 10 years and a minister in the govt, they neither got uninterrupted drinking water supply, nor relief from choked sewer lines. Sharma then started making promises that he would resolve the grievances if elected this time. Dissatisfied by his replies, people continued to heckle him and soon began leaving. Seeing this, Sharma said: "I swear that after winning this time, I will provide relief to the people from drinking water shortage and sewer overflow."

E.coli in water of condo with 5k residents

Ghaziabad. The health department confirmed on Tuesday that coliform bacteria were present in water samples collected from KW Srishti, a housing society in Raj Nagar Extension (RNE).

The apartment complex with 1,500 flats is home to over 5,000 people. Over the last two weeks, several residents have flagged the poor quality — blackish and pungent — of water reaching their taps. Nearly, 20 people have also complained of stomach aches.



Earlier this month, nearly 800 residents of a Greater Noida society fell ill after consuming contaminated water. Traces of coliform bacteria were also found in the water samples collected from Ecovillage 2

District surveillance officer RK Gupta said 39 water samples were collected from the overhead tanks of the 11 towers of the housing society and a borewell — the main water source of the society —first on Sept 18 and then again on Sept 21— and sent to the district lab for tests. The analysis confirmed the presence of coliform bacteria in all the samples. The presence of these pathogens indicates faecal contamination, which can lead to diarrhoea, vomiting, and fever. If left untreated, these conditions can have serious consequences.

ssistant CMO RK Gupta said residents have been advised not to use tap water for drinking purposes till the superchlorination process — a water treatment process where large amounts of chlorine are added to the water supply to ensure rapid disinfection — is complete. He accused the society's maintenance team of "negligence" and said if the situation persisted soon there could be an outbreak of diarrhoea cases.

"The developer has been directed to set up a dossier pump for superchlorination by next week.

Dust control, checks on farm fires: Haryana draws up winter action plan

Gurgaon. Haryana State Pollution Control Board (HSPCB) unveiled its winter action plan on Tuesday with the aim of tackling pollutants as the colder months approach. The plan includes promoting use of public transport, ensuring timely maintenance of vehicles, and minimising construction activities.he state will also focus on identifying and repairing major roads before winter, hiring additional mechanised sweepers and sprinklers, and planting 1.3 crore saplings. It also plans to manage 73.1 lakh MT of paddy straw through in-situ and ex-situ strategies and reduce stubble burning. The action plan takes into account the fact that over the past three years, PM2.5 and PM10 have emerged as the primary pollutants in Haryana. The three-year annual average of PM2.5 in various districts is between 70μg/m3 and 80μg/m3, significantly higher than the National Ambient Air Quality Standards (NAAQS) of 40µg/m3 .Similarly, the annual average PM10 level from 2021 to 2023 in various districts

falls between 150µg/m3 and 170µg/m3, more than double the national standard of NAAQS of 60µg/m3, according to calculations by the pollution control board. "All districts have been instructed to implement measures as per the action plan from now onwards," HSPCB chairman P Raghavendra Rao told TOI.Officials stated that the action plan will address local sources of pollution such as dust generated from traffic on roads and construction and demolition sites, emissions from industries and vehicles, and burning of waste."In this context, in 2024-25, the state will focus on undertaking preventive maintenance of all sprinkling and sweeping machines to ensure they are in working condition, efficiently operating existing sprinkling and sweeping machines to minimise resuspension of road dust due to movement of vehicles and procuring new machines... and surprise inspections and atmosphere at lower heights. test runs," the HSPCB plan To ensure the effective implementation and stated.Furthermore, the state govt also

plans to leverage the Centre's 'Nagar Van Yojana', under which urban local bodies will receive assistance to establish nagar vans (city forests) in 10-50 hectares of land and vatikas (gardens/parks) in 1-10 hectares of land. For 2023-24, Haryana achieved 88% of its plantation target of 98 lakh plants and shrubs. After a detailed identification exercise, nearly 76% of the identified pollution hotspots have already been rectified and converted to green spots by urban local bodies and other agencies.HSPCB aims to undertake measures which, to the extent possible, prevent the AQI forecast from breaching the thresholds for stage 1 of the Graded Response Action Plan (GRAP). To achieve this, pollution sources in the state must be abated with greater intensity, officials said. This is because in winter, due to temperature inversion, pollutants tend to remain suspended in the

success of the winter action plan, a review

and monitoring mechanism will be established, officials said. A high-level committee will be constituted under the chairmanship of the HSPCB member secretary, comprising officials from key govt departments, experts, industry stakeholders, and academic institutions."When it comes to air pollution, citizens are as much a part of the problem as they are of the solution. The state will launch a 360-degree information and awareness campaign urging people to avoid unnecessary use of vehicles and choose public transport wherever possible, and scrap personal vehicles which are nearing end-of-life," the action plan stated. Experts, meanwhile, said the state should work on pollution mitigation throughout the year, not just in the winter months. "Though Haryana's action plan is very precise and has details of what has been done last year and what is planned for this year, several works which were supposed to be done by municipalities are still pending.

Rules flouted, water and power supply to 11 buildings to be snapped

Gurgaon. The department of town and country planning (DTCP) has initiated action against 11 illegally-constructed buildings in Palam Vihar's C2 block, ordering that their water, sewer and electricity connections be cut off.

Each 500 sq yd plot, originally meant to have a single housing unit per floor, has as many as 16 unauthorised flats. District town planner (enforcement) Manish Yadav has written to the MCG commissioner, GMDA executive engineer and DHBVN requesting the disconnections. The tehsildar has also been instructed to halt any further registration of these properties."All three departments have been instructed to take immediate action, and our enforcement office is actively working on the necessary measures," Yadav said. The case is currently pending in the Punjab and Haryana high court, following a petition by the Palam Vihar

City sees 36 dengue cases this month, year's tally reaches 60

Gurgaon. Four patients were diagnosed with dengue on Tuesday, taking the city's tally for this month to 36 and total count to 60 this year.

ccording to the health department, two dengue patients are being treated at hospitals and are stable, while 30 others are recovering at home. All others have recovered. Of the 36 cases this month, 17 are women. All patients are between 7 and 56 years old. An official from the department told TOI that Wazirabad, Bhangrola, Nakhrola, Badshapur, Bhondsi, Bhorakalan, and Garhi have been identified as dengue hotspots in the city.

Officials said they expect more cases in the coming weeks. "We anticipate a further rise in dengue cases, with a potential decline in Gurgaon by mid-Oct. Currently, warm and humid conditions following rainfall create an ideal environment for breeding of mosquitoes that transmit the disease, leading to an increase in dengue and other mosquito-borne illnesses. We have shared the list of hotspots with MCG for carrying out fogging drives," said Virender Yadav, chief medical officer, Gurgaon.

Last year, the city recorded 276 dengue cases, and one of the patients succumbed to the infection. In 2022, the number of cases reached 440, and the previous year, 327 patients were diagnosed with dengue.Doctors emphasised the importance of implementing preventive measures to curb the spread of infections. They advise wearing fullsleeved clothing, using mosquito repellents, and eliminating any stagnant water from containers, coolers and other sources.

Common symptoms of dengue include fever, headache, muscle and joint pain, and a distinctive skin rash."Although the current strain appears to be mild, we are implementing all necessary measures to ensure that patients receive prompt and effective care. Our team of doctors and medical staff is working tirelessly to manage the increasing number of cases, providing comprehensive treatment and support," said Dr Govind Prakash, head of emergency at Paras Health Hospital.Other medical professionals cautioned about the prevalence of various other viruses circulating."Due to changing weather

Mexico's most popular president in decades is retiring. What will he leave behind

MEXICO CITY. Many Mexicans will feel a deep sense of loss when folksy, charismatic, nationalistic President Andrés Manuel López Obrador leaves office on Sept. 30—and that's no surprise. López Obrador himself has spent an inordinate amount of time talking about his own legacy—and his place in history—over his six-year term, something he brings up at almost every one of his marathonic daily 7 a.m. media briefings.But what legacy will the rumpled, grinning López Obrador leave behind?

It is perhaps the main question for a man who is obsessed with history, and one thing appears clear: he has changed the way politics is done in Mexico, perhaps forever.

Unlike decades of reserved and distant presidents, López Obrador has built a deep personal connection with many Mexicans. He has stripped the office of the thousands of presidential guards, limousines and walled compounds that once characterized it, saying "you can't have a rich government with poor people.""He is a politician who evokes familiarity, he reminds people of a father, an uncle, a grandfather," said Carlos Pérez Ricart, a political analyst at Mexico's Center for Economic Research and Teaching. That's not a coincidence, either. López Obrador constantly praises the traditional family and says it has saved the country. "He does feel nostalgia for some of the social structures of the 1970s in Mexico and nostalgia for the amily," said Pérez Ricart.Will his legacy be like that of US President Franklin D. Roosevelt, whose New Deal created lasting institutions like Social Security and home mortgage programs that resulted in an enormous, stable middle class?The Mexican leader stakes his movement on cash social-benefit programs, he likes to compare himself to Roosevelt and many Mexicans think of him with the same fondness that the more patrician FDR inspired in his day.

China test-fires ICBM into Pacific Ocean using 'dummy warhead'

BEIJING. China test-launched an intercontinental ballistic missile into the Pacific Ocean on Wednesday, the defence ministry said, announcing the rare trial run as Beijing flexes its military might.

The Chinese military's "Rocket Force launched an ICBM... carrying a dummy warhead to the high seas in the Pacific Ocean at 08:44 on September 25, and the missile fell into expected sea areas", the ministry said in a statement. An analyst told AFP hat China has typically conducted such tests in its own airspace. "This is extremely unusual and likely the first time in decades that we've seen a test like this," Ankit Panda, Stanton Senior Fellow at the Carnegie Endowment for International Peace, said."(The test) likely speaks to China's ongoing nuclear modernisation manifesting in new requirements for testing," he added.

China's defence ministry, however, called the firing a "routine arrangement in our annual training plan.""It is in line with international law and international practice and is not directed against any country or target," it said.

Last October, the US Defense Department said China was developing its nuclear arsenal more quickly than the United States had anticipated. China possessed more than 500 operational nuclear warheads as of May 2023 and is likely to have more than 1,000 by 2030, it said. The United States and China in November held rare talks on nuclear arms control, part of a bid to ease mistrust ahead of a summit between leader Joe Biden and Xi

Missouri executes man for 1998 murder of woman despite calls from victim's family to spare his life

BONNE TERRE. A Missouri man convicted of breaking into a woman's home and repeatedly stabbing her was executed Tuesday over the objections of the victim's family and the prosecutor, who wanted the death sentence commuted to life in prison.Marcellus Williams, 55, was convicted in the 1998 killing of Lisha Gayle, who was stabbed during the burglary of her suburban St. Louis home. Williams was put to death despite questions his attorneys raised over jury selection at his trial and the handling of evidence in the case. His clemency petition focused heavily on how Gayle's relatives wanted Williams' sentence commuted to life without the possibility of parole.

'The family defines closure as Marcellus being allowed to live," the petition stated. "Marcellus' execution is not necessary."

As Williams lay awaiting exeution, he appeared to converse with a spiritual advisor seated next to him. Williams wiggled his feet underneath a white sheet that was pulled up to his neck and moved his head slightly while his spiritual advisor continued to talk. Then Williams' chest heaved about a half dozen times, and he showed no further movement.

Williams' son and two attorneys watched from another room. No one was present on behalf of the victim's family. No juror nor judge has ever found Williams' innocence claim to be credible," Parson said in a statement.

Deadly flooding in Central Europe made twice as likely by climate change

WASHINGTON. Human-caused climate change doubled the likelihood and intensified the heavy rains that led to devastating flooding in Central Europe earlier this month, a new flash study found.

Torrential rain in mid-September from Storm Boris pummeled a large part of central Europe, including Romania, Poland, Czechia, Austria, Hungary, Slovakia and Germany causing widespread damage. The floods killed 24 people, damaged bridges, submerged cars, and left towns without power and in need of significant power and in need of significant infrastructure repairs. The severe four-day rainfall was "by far" the heaviest ever recorded in Central Europe and twice as likely because of warming from the burning of coal, oil and natural gas, World Weather Attribution, a collection of scientists that run ranid climate attribution, studies, said rapid climate attribution studies, said Wednesday from Europe. Climate change also made the rains between 7% and 20% more intense, the study found.

'Yet again, these floods highlight the devastating results of fossil fuel-driven warming," said Joyce Kimutai, the study's

lead author and a climate researcher at Imperial College, London.To test the influence of human-caused climate change, the team of scientists analyzed weather data and used climate models to compare how such events have changed since cooler preindustrial times to today. Such models simulate a world without the current 1.3 degrees Celsius (2.3 degrees Fahrenheit) of global warming since preindustrial times, and see how likely a rainfall event that severe would be in such a world. The study analyzed four-day rainfall events, focusing on the countries that felt severe impacts. Though the rapid study hasn't been peerreviewed, it follows scientifically accepted techniques.

"In any climate, you would expect to occasionally see records broken," said Friederike Otto, an Imperial College, London, climate scientist who coordinates the attribution study team. But, "to see records being broken by such large margins, that is really the fingerprint of climate change. And that is only something that we



see in a warming world."Some of the most severe impacts were felt in the Polish-Czech border region and Austria, mainly in urban areas along major rivers. The study noted that the death toll from this month's flooding was considerably lower than during catastrophic floods in the region in 1997 and 2002. Still, infrastructure and emergency management systems were overwhelmed in

many cases and will require billions of euros to fix.

Last week, European Union chief Ursula von der Leyen pledged billions of euros in aid for countries that suffered damage to infrastructure and housing from

The World Weather Attribution study also warned that in a world with even more warming — specifically 2 degrees Celsius (3.6 degrees Fahrenheit) of warming since preindustrial times, the likelihood of ferocious four-day storms would grow by 50% compared to current levels. Such storms would grow in

intensity, too, the authors found. The heavy rainfall across Central Europe was caused by what's known as a "Vb depression" that forms when cold polar air flows from the north over the Alps and meets warm air from Southern Europe. The study's authors found no observable change in the number of similar Vb depressions since the 1950s.

In a statement to NBC News on Tuesday, Tempe Police confirmed that the incident occurred the previous night, adding that "damage from gunfire" was discovered at the Democratic National Committee office. However, there were no reports of



any injuries. Tempe Police's Public Information Officer Sgt. Ryan Cook said no one was inside the office premises at the time of the incident, "but this raises concerns about the safety of those who work in that building, as well as those nearby", reports The New York Post.Local TV stations aired footage that showed two bullet holes in a door and two more in windows of the office.An investigation into the incident is currently underway, with detectives analysing evidence collected from the crime scene. The police also said that additional security measures have been put in place for employees of

the campaign office, as well as others in the area. Confirming the incident, Arizona Democratic Party Chairwoman Yolanda Bejarano said in a statement that it was "extremely sad that the Arizona Democratic Party has become the target of violence - it's not who we are as Arizonans or Americans", reports NBC News.We are working with law enforcement to ensure this threat is taken seriously and that our staff members are safe while they're at work," she added.

The gunfire incident comes just days before Harris's scheduled trip to Arizona on Friday, during which she is likely to visit the US-Mexico border.

The office in Tempe is one of 18 field offices for the Democratic nominee's campaign in Arizona.On September 15, Harris's Republican rival Donald Trump survived a second attempted assassination at his gold club in Florida. The 58-year-old suspect, Democratic supported Ryan Routh, was arrested shortly after.

Israel foils Lebanon missile attack, airstrikes on Hezbollah kill over 550

World Israeli air defence systems intercepted a missile launched from Lebanon on Wednesday, following sirens in Tel Aviv, the nation's economic centre, according to the Israeli military. No casualties or damage were reported, and no changes to civil defence instructions were required, news agency Reuters reported while citing officials. Thousands of people fled southern Lebanon as Israel intensified strikes against the Iran-backed Hezbollah militant organisation, resulting in 558 deaths, according to Lebanon's health minister, CNN reported. Amid two days of intense Israeli attacks, panic-stricken civilians continued to flee southern Lebanon, crowding main roads and gas stations en route to the capital. United Nations (UN) and Lebanese officials on Tuesday stated that 27,000 displaced individuals had been settled in temporary shelters, while many others were forced to sleep in cars, parks, and along the beach.Top PointsAn Israeli airstrike in Beirut on Tuesday killed a senior Hezbollah commander, Ibrahim Qubaisi, heightening fears of a full-scale war in the region as cross-border rocket attacks surged between both sides. Israel stated that Qubaisi headed the group's missile and rocket brigade.Israel's airstrikes since Monday morning have killed 569 people, including 50 children, and injured 1,835 in Lebanon, said Health Minister Firass Abiad, news agency

While Western dawdling has amplified Ukraine's

losses, some Ukrainian officials, diplomats and analysts fear Kyiv's aim to have the plan implemented before a new US president takes office in January may be out of reach.US Ambassador to the UN Linda Thomas-Greenfield, reportedly briefed on the plan, said it "can work," but many privately question how. The specifics of Zelenskyy's blueprint have been kept under wraps until it can be formally presented to President Joe Biden, but contours of the plan have emerged, including the need for fast action on decisions Western allies have been mulling since the fullscale invasion began in 2022.It

NATO membership, according to Zelenskyy's chief of staff, Andrii Yermak—a principal demand of Kyiv and Moscow's key point of contention. Man who staked out Donald Trump at Florida golf course charged with attempted assassination

WASHINGTON. A man who authorities say staked out Donald Trump for 12 hours on his golf course in Florida and wrote of his desire to kill him was indicted Tuesday on an attempted assassination charge.Ryan Wesley Routh had been initially charged with two federal firearms offences. The upgraded charges contained in a five-count indictment reflect the Justice Department's assessment that he methodically plotted to kill the Republican nominee, aiming a rifle through the shrubbery surrounding Trump's West Palm Beach golf course on an afternoon Trump was playing on it. Routh left behind a note in which he described his intention, prosecutors said. Court records show the case has been assigned to Aileen Cannon, a Trumpappointed federal judge who generated intense scrutiny for her handling of a criminal case charging Trump with illegally hoarding classified documents at his Mar-a-Lago estate in Florida. She dismissed that case in July, a decision now being appealed by special counsel Jack Smith's team.

The attempted assassinatio indictment had been foreshadowed during a court hearing Monday in which prosecutors successfully argued for the 58-year-old Routh to remain behind bars as a flight risk and a threat to public safety.video

They alleged that he had written of his plans to kill Trump in a handwritten note months before his Sept. 15 arrest, in which he referred to his actions as a failed "assassination attempt on Donald Trump" and offered \$150,000 for anyone who could

Surge in crimes against women: 1.18 lakh cases reported since 2017 in Kerala

KOCHI. In the backdrop of several women raising allegations of sexual abuse in the film industry, concerns have resurfaced over women's safety in the state. Despite the LDF government's creation of a dedicated women and child development (WCD) department in 2017, incidents of violence against women continue to rise.

Data from the home department reveals that since 2017, a total of 1,18,581 cases related to crimes against women have been reported in the state. As of June this year, 1,338 rape cases and 2,330 molestation cases have been recorded, bringing the total number of crimes against women to 9,501 in just the first six months. In 2023, the figures were even more alarming, with 18,980 cases including 2,562 rapes and 4,816 molestations. This was slightly higher compared to 2022, which saw 18,943 cases including 2,518 rapes and 4,940

According to the latest National Crime Records Bureau (NCRB) data, Kerala has an 82% crime rate-significantly higher than the national average of 66.4%.

Former MLA and Kerala Women's Commission member Elizabeth Mammen Mathai said that while crimes against women are rising, the women and child development department has established an effective complaint disposal mechanism.

'Complaints are steadily pouring in, but we have an effective system to address the issues," Elizabeth said.

Lokayukta sleuths raid 62 excise offices, find cannabis



BENGALURU. Following complaints of irregularities in the distribution, renewal, and relocation of excise licences, sleuths of the Lokayukta carried out simultaneous raids across 62 excise offices in the Bengaluru Urban excise district on Tuesday afternoon. They found cannabis, liquor bottles, and unaccounted cash of Rs 2 lakh during the raids.

A release from the Lokayukta office stated that in response to public complaints, teams were formed to investigate the allegations. After gathering information, a suo motu case was taken up. On Tuesday afternoon, the Lokayukta officials, including the police, simultaneously raided 62 excise offices. During the raid, Lokayukta Justice BS Patil, and Upalokayukta Justice B Veerappa visited the Yeshwantpur and Byatarayanapura excise offices and ordered an investigation into several flaws found during the visit.

Inquiry is also ordered in connection with detection of unaccounted cash amounting to Rs 2 lakh, and seized cannabis and liquor bottles. Additionally, it has been noted that there are 132 cases with the anticorruption agency related to irregularities in excise department offices across the state, which are under investigation at various stages.

The ADGP's report had triggered a fresh controversy after it was criticised that the conspiracy angle was overlooked during the inquiry. The UDF and the CPM-backed MLA P V

Anvar had alleged that the Pooram was sabotaged to help the BJP make electoral gains in the Lok Sabha polls and the



ADGP was the architect behind the plan. Both the CPI and Congress leadership had come out against the report as they felt it failed to identify the actual reason behind the Pooram

fiasco. While CPI mouthpiece 'Janayugam' came out with a detailed article criticising the report, senior CPI leader and party candidate in the last Lok Sabha poll V S Sunil Kumar dismissed the findings in the

Stating that there's a conspiracy behind Pooram disruption, Sunil Kumar said the finding ruling out the conspiracy angle could not be accepted. Senior Congress leader K Muraleedharan too criticised the ADGP's report.

had put the government on a backfoot following which the CM answered that a probe was conducted.

Eateries can stay open till 1 am: Police memo

Sanitation worker's cease-work leaves Capital Hospital stinking

However, the agitating sanitation workers remained unfazed and sat outside the hospital director's office shouting slogans.

BHUBANESWAR. Uncollected garbage left the Capital Hospital stinking on Tuesday as hundreds of sanitation workers staged dharna over various demands including pay hike and Dussehra bonus.

The trash-filled bins in all the wards of the hospital caused serious inconvenience to patients and their attendants after sanitation workers resorted to cease-work protest from Monday evening.

Attendants of a few patients alleged that the uncollected left-over food items and biomedical waste led to an unhygienic condition on the hospital premises.

However, the agitating sanitation workers remained unfazed and sat outside the hospital director's office shouting slogans. They warned of intensifying the protest if



their demands are not met soon. A female sanitation worker alleged that there is discrepancy in payment of wages to them. "The agency which has engaged us is paying wages for 26 days only. There is no payment for the four weekly-offs which is totally unacceptable," she claimed.

A male worker said at the time of engagement, the agency had assured to pay bonus on Dussehra. However, it has gone back on its promise. The agitators further alleged that they are not able to meet the agency's owner and air their grievances. They also claimed that the hospital authorities have turned a blind eye to their plight. Hospital director Dr Dilip Kumar Panda said he has apprised senior officials of the Health department and labour commission about the matter.

"Quess Corporation, which was awarded the contract to clean the hospital premises, has been asked to look into the demands of the agitating workers and resolve the matter at the earliest to ensure that the sanitation services are not affected," he added.

The rise of Anura Kumara Dissanayake

IN January 2020, weeks after becoming the President of Sri Lanka, Gotabaya Rajapaksa set up a commission of inquiry "to investigate allegations of political victimisation, 2015-19". Anura Kumara Dissanayake, or AKD, sworn in as Sri Lanka's ninth President on Monday, was among the many named by the commission for punitive action as he was part of an anticorruption panel set up after Mahinda Rajapaksa's authoritarian and nepotistic presidency was voted out in 2015 to investigate the alleged misdeeds of the Rajapaksa clan and cronies. Had the economic meltdown in 2021 not interrupted the Rajapaksas' nightmarish rerun from 2019, Dissanayake may have been stripped of his civil rights for seven years and imprisoned. The incident may be a footnote in Dissanayake's political journey from a student cadre of the Janatha Vimukthi Peramuna (JVP) in rural Sri Lanka during its blood-soaked armed insurrection of 1987-90 to a pragmatic leader of his party and its National People's Power (NPP) alliance, and now to the country's most powerful office, the executive presidency. It is also true that this historic, politically shape-shifting election victory may not have come about had it not been for the Rajapaksas, and not just for their mismanagement of the economy

A quick flashback: Through the first dozen years of the new millennium, the JVP split twice on the question of whether its alliances with the main ruling coalitions of that period, led by President Chandrika Kumaratunga first and then her successor, Mahinda Rajapaksa, had identified the party with Sri Lanka's entrenched power elite, robbing it of its unique identity as an antiestablishment, 'pro-people' entity

In those years, the JVP was an eager partner in the war against the LTTE, with no daylight between it and the Sri Lanka Freedom Party, of which Rajapaksa was then the leader. JVP's charismatic leaders of that period favoured the alliance and quit the party, hoping to reap electoral benefits from the war. AKD, who had been a parliamentarian since 2000, stayed put. By 2014, he had risento the leadership of the JVP.

In the presidential elections of 2015, held against the backdrop of popular discontent against the authoritarian regime of Mahinda Rajapaksa, AKD's JVP backed the common Opposition candidate, Maithripala Sirisena, the main challenger to Mahinda. But the association with the dysfunctional successor government — this was the period in which AKD was part of the anticorruption committee against the Rajapaksas burnt the JVP once more.In 2019, AKD stepped out of the mould. He formed a 'socialist coalition', the NPP, with 27 other leftist and likeminded groups such as trade unions, women's rights groups and youth organisations, and announced himself as a candidate in the presidential election of that year. He polled just 3.16 per cent of the votes. Gotabaya Rajapaksa won with 52 per cent of the votes, while Sajith Premadasa, then the main Opposition candidate, representing the United National Party (UNP), polled 42 per cent.

In the parliamentary elections of 2020, the NPP did just as badly. It won just three seats. This was still slightly better than Ranil Wickremesinghe's UNP, which was wiped out after most of its members walked out with Premadasa, whose new party, Samagi Jana Balawegaya, emerged as the main Opposition party in Parliament. Undeterred by the double defeat, AKD set to work. He saw the 2022 Aragalaya, the people's movement to demand accountability from the Rajapaksas for the economic crisis, as an opportunity to stay relevant in the Sri Lankan polity. The JVP's participation in the movement leading to the ouster of President Gotabaya Rajapaksa, without grabbing its leadership from the disparate student and youth entities at its helm, was the turning point for the party.

The seeds of AKD's victory were sown right then, when people saw the Rajapaksas clawing their way back to power by propping up Wickremesinghe as the new President.

Punjab's agri draft policy fails to tick all the boxes

The draft policy proposes to promote production and marketing through the cooperative mode, even though state-controlled cooperatives have failed in the state.

THE absence of an agricultural policy in Punjab is baffling, given that there are policies for the industry and other sectors. In the past decade, two drafts remained on paper only. Now, we have a draft of the much-awaited agricultural policy in the public domain almost a year after it was submitted. Let us hope that this will not meet the fate of previous drafts. However, it had a flawed start as the policy committee was set up without any terms of reference (ToR); the committee, too, did not deem it fit to frame the ToR.

The policy vision "to continuously improve the livelihoods of farmers, farm workers and those dependent on agriculture by making farming healthier, profitable and globally competitive... for future generations" is silent on the sector's social sustainability, which includes equity, concern for small producers, etc. In 2018-19, 27.8 per cent of the area in Punjab was under lease. Some field-based studies suggest it to be even 50 per cent in some regions.

The practice of reverse tenancy and a reduction of small and marginal farmers in the state's agriculture, both in terms of numbers (35 per cent of the total, compared to India's 86 per cent) and the area operated by them (9 per cent against 45 per cent in the country), underline the need for incorporating this sustainability dimension. The draft proposes land leasing reforms but fails to mention the draft land leasing Bill, which is problematic. Punjab can end up with only large farmers with higher incomes if the policy remains blind to social sustainability.

The report terms the task of rejuvenating the agriculture sector as a 'holy' one by setting up a system and the use of science, which can lead to agricultural per capita income being comparable to other sectors of the economy. It is difficult to understand how the farm sector can create value comparable to that in other sectors. The very idea of such a 'holy task' makes the theory of structural transformation stand on its head. The major objective of the policy - to promote healthier agricultural production, value addition and marketing systems for globally competitive agriculture - is intended to be achieved through the cooperative mode. This is like betting on a lame horse, as traditional and state-controlled cooperatives have failed in Punjab or are no more than a part of the state system. The report itself confirms this when it says that these public sector organisations should not behave like private enterprises to earn super-normal profits. Terming these agencies as PSUs also reflects the poor understanding of the committee. Unfortunately, the more promising alternative of farmer producer organisations (FPOs) is not even recognised in the draft policy when the Centre is promoting it with plenty of resources. There are more than 25,000 such entities in India, while Punjab has only



a few dozen despite having a so-called FPO policy since 2018.It is surprising that the draft has not specified any time frame for achieving the objectives and has no milestones, except in saving water. It was important to specify these, as by the time the policy is finalised and as and when accepted for implementation, just two years will be left for the present government to deliver on it.

The biggest weakness of the draft is its neglect of the marketing issues of the state's farm sector, which are well known and debated for long. It recognises that there is a potential (not real) exploitation of farmers by commission agents. But it does not suggest the abolition of commission agents unlike Madhya Pradesh, which did it decades ago.


It is a sad commentary on the agricultural markets of the state that today no farmer can sell directly, and no buyer can buy directly in the state's agricultural markets, especially grain markets. The irony is that the state has not conducted elections to APMCs (Agricultural Produce Market Committees) for more than 40 years, and this absence of governance has not been even pointed out. Opening up of regulatory market space can provide alternative marketing channels for farmers; that too has not been discussed. Another doable mechanism that can protect farmers from low prices and exploitative credit linkage - warehouse receipts - does not even find a mention in the report. The draft recommends a legal guarantee of procurement of all crops, including perishables like milk and poultry, at the MSP and a statelevel commission to provide cost estimates for all produce to determine the MSP. How can a committee make such definitive recommendations regarding the MSP issue that is not even a state mandate? It is also not clear why the committee did not propose a state-level mechanism for MSP for perishable produce like in Kerala or Haryana. It could have mandated all purchases in APMC mandis at or above the MSP for all buyers under the APMC Act as in MP's legislation. It also goes beyond its mandate while recommending 200 days of MGNREGA (Mahatma Gandhi National Rural Employment Guarantee Act) work as this is not a state government programme.

The report points out that the power subsidy per connection varies from a low of

Rs 21,234 to as high as Rs 89,556 across districts. Sadly, it does not recognise the equity issue in this wherein bigger and better-placed farmers get bigger subsidies and those who don't own tubewells (mostly small and marginal farmers) are left out. It is also a wasteful subsidy which perpetuates the cultivation of paddy (except basmati), which should be eliminated from the state. The committee should not have been so mindful of political considerations if it was serious about addressing the issues of the sector and farmers therein. A policy should be framed at the level of ideas and innovations with adequate reference to various worldviews on the state's farm sector, which, unfortunately, are found missing in this draft policy.

such interventions. It's a long, tough road ahead. Much Like last year, paddy harvesting, and stubble burning as a result, has started early in Punjab this season. Those setting stubble on fire insist that since the window for

sowing wheat is short, this is the quickest way to get rid of the paddy residue. Several districts have been identified as stubble-burning hotspots. Teams of government staff have been activated. With farmers' unions warning against coercive methods, any stringent action is unlikely. A reassuring aspect is the growing awareness among farmers of the need to desist from stubble burning and how it is in everyone's interest, in particular their own. The worrying part is the inefficacy of policy initiatives. State support and optimum incentivisation have to be at the core of plans to counter the resistance.

The farm fire season often becomes a

rallying point against the farmers. Irresponsible and uninformed reactions only complicate the pressing issue and dilute the debate.

1977 J&K Assembly elections were a watershed

The initial effort of the state administration was to 'arrange' the election, as had been the practice.

EVEN though these are but UT elections to a limp Assembly in Jammu and Kashmir, they have evoked reminiscences of the Assembly elections of 1977. Those elections, held under Governor's rule, are often cited as a watershed. All shades in Kashmir's political firmament had leaped eagerly into the fray.

Pro-independence Mirwaiz Farooq of the Awami Action Committee put up candidates but, like the Jamaat-e-Islami now, not under the party's name. The pro-Pakistan Jamaat-e-Islami led by Ali Shah Geelani was a contender, as it had been in 1972, when it won five seats, and is contesting again today, in thin disguise. Former supporters of Sheikh Abdullah become antagonists and set up a branch of the Janata Party, the ruling party at the Centre. Among its leaders was Hameed Karra, nephew of Mohiuddin Karra one of the Sheikh's lieutenants in the 1940s and 1950s. Maulana Masoodi, another of the Sheikh's former close associates and the Assembly Speaker in 1953, threw his considerable clout with his Gujjar community behind the Janata Party. Maulana Iftikhar Ansari, the leading Shia cleric, was a formidable opponent. The Sheikh's party stood alone. Yet, his appeal, as always, was his promise to restore to the people their dignity. His son Farooq is heir to that


The Janata Party pulled out all stops in its campaign. Among the leaders who descended on Kashmir were Home Minister Chaudhary Charan Singh, Industries Minister George Fernandes, Minister for Works and Housing Sikander Bakht and Defence Minister Babu Jagjivan Ram, once a pillar of the Congress. Finally, on the eve of polling, then Prime Minister Morarji Desai, like the present PM, made a campaign visit.

The initial effort of the state administration was to

'arrange' the election, as had been the practice. As deputy commissioner, I was the returning officer for the district of Srinagar, Hameed Karra soon came calling to ask that I make appointments of the election staff in consultation with him. He was the secretary to the state unit of the Janata Party. When I stated clearly that any such step was illegal, he was surprised. I was a promising young Muslim officer, he averred, and it would break his heart to have to destroy my career. The morning after my meeting with Karra, my boss, the commissioner of Kashmir, called me to his office. Upon entry to his chamber, whom did I find but Karra! 'What is the difficulty Karra sahib is facing?' asked Commissioner Ghulam

Mustafa Khan. I told him of Karra's demand. But the commissioner's response, uttered with endearment, was that I was an innocent person, that administering Poonch, where I had just conducted parliamentary elections, was another matter, and I should now recognise that the demands of Srinagar were different.

As the election approached, the strong support base of Sheikh Abdullah's National Conference (NC) became increasingly manifest. He suffered a heart attack that confined him to his home, but that led to an upsurge of support, causing his opponents to claim that the reports on the Sheikh's health were fake. The administration decided to attempt to cripple his election campaign. All deputy commissioners in Kashmir were given orders requiring that leading NC volunteers be arrested under the Preventive Detention



Act, which permitted detention without trial. Up all night, I approved nine arrests, only to receive a call early next morning from Chief Secretary Pushkar Nath Kaul, asking why I had been so slow. He told me that the deputy commissioners of other districts had each issued 30 to 80 warrants in one night. When I protested that a deputy commissioner was expected to satisfy himself that the grounds for detention made a convincing case of a threat to public security, he suggested that time spent scrutinising grounds was time wasted. Prime Minister Desai paid a visit on June 25, 1977. As we prepared for our meeting, I was told by the IG of the state police, Peer Ghulam Hassan Shah, that the PM would ask that we ensure his party's victory and that we should comply, for this was a duty to the nation. I told him that in that event, I, inexperienced in this art, must be replaced. As it happened, our meeting with the PM witnessed an amiable chat. When asked by the chief secretary if he had any advice for the state's administration on the elections, the PM's response was simple: "One doesn't know whom to trust in Kashmir."

The state police, frustrated with my insistence on adhering to the law, launched a flurry of arrests of NC activists, particularly of its youth wing, under Section 107 of the CrPC. Then party president Ghulam Mohiuddin Shah. brother of the Sheikh's son-in-law, visited my office to object formally to this repression. I explained that this was the way the police wished to display their national commitment and asked him whether this would hamper or, in fact, strengthen his campaign. At this, Shah allowed himself a grin.

On election day, as I raced about the city, responding to calls, allegations and threats, Farooq Abdullah called on the IG, ensconced in the police control room, to complain that the elections were a farce. When results began to be announced and it was clear that the NC would win, I drove around Srinagar with the IG. The city rejoiced. Our car was repeatedly stopped, our hands kissed, blessings showered, as is the Kashmiri's wont.

The June 1977 elections were a milestone in the political evolution of the state. Because of the high public participation and the healthy slate of candidates across the state's political leadership, some believe that these were the fairest elections ever held there. Others have gone even further to declare them the only real elections ever held in J&K. Are the 2024 elections a resonance of that?

Smoking prompts Crohn's relapse after surgery

People with Crohn's disease -a serious bowel condition -- are more likely to experience a recurrence after surgery if they continue to smoke, new research has found.

Crohn's disease occurs when the immune system attacks the lining of the gut and bowel to cause severe inflammation. It results in abdominal pain, urgent diarrhoea, sickness and profound lethargy.

Doctors recommend people with the condition stop smoking to avoid their illness worsening.

"Our study confirms that the most important thing somebody with



Crohn's disease can do for their health is not to smoke," said Jack Satsangi, Professor at University of Edinburgh in

Most patients with Crohn's disease require surgery to remove the affected section of their bowel. Surgery is not curative, however, and the condition often relapses.

The researchers also assessed whether a drug treatment that is commonly used in treating the disease is effective at preventing it from coming back after surgery.

They found that the therapy had limited beneficial effects for non-smokers in preventing relapse after surgery. It did, however, offer protection for smokers.

Straight Angle Pose or Samakonasana: Start the asana with sitting on the ground and stretch the legs forward. Keep you legs straight and be legs sideways so that it should form a straight line and keep the body straight. Stay in this posture for a few seconds and then slowly bring back the legs to the normal position.

A class of drugs called thiopurines have often been prescribed to patients after surgery to try to prevent relapse but until now, it was not clear whether the therapy offers any benefit.

The researchers conducted a trial of the therapy involving 240 people with Crohn's disease.

Patients were monitored for three years after they had undergone surgery. Some 128 patients were treated with a drug from the thiopurine family called mercaptopurine and 122 were given a dummy medicine.

Only three of 29 smokers treated with the therapy experienced a relapse compared with 12 of 26 who received the dummy drug. The rate of relapse in the non-smoking group was much lower and was unaffected by treatment with the medicine, showed the findings published in The Lancet Gastroenterology and Hepatology.

"There is an unmet need to identify therapies or life-style changes that prevent Crohn's disease recurrence after surgery to avoid patients having to undergo multiple operations," Satsangi

More than 300 dengue cases recorded in a week in Delhi

Last year, the city saw a total of 426 malaria cases, with **West Delhi** being the worst affected.

NEW DELHI. Delhi has reported over 300 new dengue cases in the past week, bringing the total number of cases this year to 1,229, according to official data. Malaria cases in the city have also surged compared to last year, with 363 cases recorded this month, up from 294 during the same period in 2023.

Last year, the city saw a total of 426 malaria cases, with West Delhi being the worst affected. Chikungunya cases have also risen, with 43 reported so far this year, nearly double the 23 cases reported last

According to Municipal Corporation of Delhi (MCD) data, between January and September 21, Delhi saw 1,229 dengue cases, including the death of a 54year-old man at Lok Nayak Hospital. This month alone, Delhi has recorded 651 dengue cases, a notable increase from the 256 cases reported in August. However, despite the



recent rise, the numbers are still lower than last year when the city had already recorded 3,013 dengue cases by this time. In contrast, in 2022, there were only 525 cases in the same period. Last year, Delhi saw a total of 9,266 dengue cases and 19 deaths, with 2,141 cases occurring in September alone. This year, the

highest number of dengue cases, 180, has been reported in the Najafgarh zone, with 45 cases recorded in the past week. The South zone has reported an equal number of cases. Non-MCD areas, including the New Delhi Municipal Council (NDMC), Delhi Cantonment, and Railways, have contributed 312 cases to the total count. However, the data excludes patients who are not residents of Delhi, those with incomplete or incorrect addresses, and those who could not be located at their recorded address.Civic

officials credit the lower number of dengue cases this year to their intensified efforts, including door-to-door inspections, regular insecticide spraying, and public awareness initiatives. The MCD has issued over 1.14 lakh legal notices and 39,338 challans.

Badee U Zaman, a 24-year-old final-year student of MA Arabic, is originally from Kerala. He completed his graduation from Kerela and came to DU to pursue post-graduation last year. Badee U Zaman is contesting from the Fraternity Movement, a seven-year-old organisation on the campus.Zaman, sharing his election manifesto, said, "We have been highlighting the issue of low voter turnout. Over the past two years, only 30% of students have participated in the elections, leaving a staggering 70% out of the electoral process. This low turnout highlights a serious problem: the current election system at Delhi University is driven by money and muscle power, leaving many students' voices unheard and their issues unaddressed.""We envision a university where democracy flourishes and anti-caste politics are actively promoted. on property defacement

NEW DELHI. The Delhi High Court on Tuesday issued strong directives against the Delhi University (DU) and civic authorities for their failure to prevent the defacement of public property in the run-up to the Delhi University Students Union (DUSU) elections. The HC criticised the authorities for not taking necessary steps to spare public places of graffiti and posters.

A bench, led by Chief Justice-designate Manmohan and Justice Tushar Rao Gedela, asked DU to issue immediate disqualification notices to candidates responsible for defacing properties. The court also



ordered the university to recover the costs of damage caused by such actions. "Issue them disqualification notices today itself and ask for recovery of funds for the defacement," the bench said.

It also asked Delhi Metro and the MCD to list the names of people involved in defacement. The judges expressed shock over the lack of coordination between government agencies. The court directive came on a petition filed by advocate Prashant Manchanda, who raised concerns about the deteriorating state of public spaces as a result of election campaigning. The HC summoned the Chief Election Officer of DU to appear before it on Wednesday. The hearing will continue to address a plea requesting strict compliance with antidefacement guidelines for the DUSU elections.

19-year-old tries to sexually assault minor, arrested in Delhi

NEW DELHI. A 14-year-old girl was rescued by her family members from a vacant shanty in southwest Delhi's Kusumpur Pahari area when a 19-year-old youth was allegedly trying to sexually assault her, an official said on Tuesday. The accused, identified as Harender, a native of Sultanpur district of Uttar Pradesh, was arrested by the police.

DCP (southwest) Rohit Meena said the father of the victim girl came to Vasant Vihar police station on Sunday and stated that his 14-year-old daughter went to a public urinal where she met a person named Harender.



'Harender took her to a vacant shanty in Kusumpur Pahari area and attempted to sexually assault her," the DCP said.At the same time, the family members of the victim girl also

reached the place of the incident, broke open the makeshift door of the shanty, and rescued the victim girl. The accused was also caught by them and handed over to the cops after thrashing him black and blue. The victim was medically examined and counselled by a Delhi Commission for Women (DCW) counsellor, following which the police registered a case under appropriate sections of the law.During the investigation, the accused was formally placed under arrest. Interrogation revealed that the accused is a Class 10 passout and presently unemployed. Further investigations are underway, the DCP added.

Delhi HC raps DU for inaction Posters, banners continue to scar Delhi University walls

NEW DELHI. Campaign posters and banners continue to cover the walls of Delhi University campuses, despite a 24-hour ultimatum issued by the chief election officer a day earlier directing candidates to remove the printed material or face

A spot check of Delhi University's North and South campuses revealed that not only were the walls lined with campaign material but also roads were littered with pamphlets in hues of white, red, and blue.

On Monday, the chief election officer for the DUSU elections issued notices to all candidates, instructing them to remove posters and banners featuring their names and ballot numbers from university premises within 24 hours. The notification also emphasised that

candidates are only permitted to use the designated "Walls of Democracy" for pasting handmade posters. However, enforcement of these rules appeared lacking on the ground. The display of printed posters and banners violates norms established by the Lyngdoh Committee, which governs student elections.

We are keeping a close vigil on any violations of election rules. Notices were issued yesterday, and we are in the process of identifying violators. Appropriate action will be taken soon," said Chief Election Officer Satyapal Singh.

Defacement of property is also prohibited under the Delhi Prevention of Defacement of Property Act, 2007. Despite this, campaign material continues resurfacing with a traffic constable noting that over 50 challans are issued daily.

'MCD workers remove the posters and banners, but by night, students hang them up again," he said. The constable also pointed out that convoys of cars during campaign rallies cause significant traffic jams, making it difficult to manage the area.

Heart attacks among young adults doubled post-Covid: Study

NEW DELHI. In a five-year-long study analysis over its cardiac patients, Aakash Healthcare has found that the cases of heart attacks jumped more than double after the pandemic, especially in adults under 40. Besides, the patient landing up in emergency jumped by 60 percent.

The study analysed 762 cases coming to the hospital in ward and emergency spanned into three distinct periods-pre COVID, during COVID, and post-COVID—each of 22 months, from May, 2018 to October, 2023.Dr Harpeet Kaur, Medical Superintendent, Aakash Healthcare, said, "Study paints a worrying picture of cardiovascular risks amid a changing healthcare landscape. These statistics presents intriguing picture demanding investigation and proactive intervention"

The analysis dives deeper, revealing major trends within specific age groups. While all age brackets saw a rise in STEMI cases after COVID, the under-40 demographic saw a sharp rise, with a threefold increase



compared to the pre-pandemic period. The study sheds light on intertwined relationship between STEMI and pre-existing health conditions. The proportion of diabetic patients among STEMI cases soared by 50 percent post-COVID. While a rise in hypertension cases was observed, it didn't reach statistical significance."This statistically significant association warrants further research with larger groups to understand potential impact of COVID on metabolic health and its subsequent influence on cardiovascular risk." Dr Aashish Chaudhry, MD, Aakash Healthcare, said, "The observed rise in STEMI cases, particularly among younger individuals and diabetes patients, demands attention for necessary preventive measures."

Delhi HC says even able-bodied divorced women entitled to maintenance

NEW DELHI. The Delhi High Court, in a ruling, observed that a wife forced to leave her matrimonial home because of husband's extra marital affair makes her a victim of domestic violence under the Domestic Violence Act.

Justice Subramonium Prasad also upheld the lower court's previous order towards payment of maintenance by the

petitioner/husband to his estranged

"...No lady can tolerate that her husband is cohabiting with another lady and has a child from her. All these facts make the respondent/wife a victim of domestic violence. The contention of the petitioner that the complaint filed by the respondent/wife doesn't come within the four corners of the Domestic Violence Act can't be accepted," read the order.

Rejecting the husband's plea, Justice Subramonium Prasad observed "...that the amount of Rs 30,000 per month awarded by the trial court to be paid by the petitioner herein/husband to the respondent/wife doesn't require any interference."It further added that the fact that the respondent/wife is capable of earning can't work to her detriment. The couple, married since 1998, has been embroiled in a contentious legal battle after the respondent/wife accused her



husband of domestic abuse, adultery, and neglect.In her complaint, she detailed the deteriorating relationship, attributing it to husband's extramarital affair, which eventually led to his abandonment of their matrimonial home. She further alleged that the husband had introduced a lady to his family and later had a child with her.

The Delhi High Court, while rejecting the petitioner/husband's contentions, remarked that the respondent/wife had no choice but to leave her two children with petitioner's parents, as she was unable to take care for them. The Delhi High Court also stated that even if the respondent is able bodied and can earn a living does not absolve the husband not to provide maintenance to his wife and children.

> Check the label and go for low salt products: As explained earlier, the

trick lies in going for food products which are low in sodium content by carefully checking the label.

Go for herbs and other spices instead of that extra dash of salt: One can go for in-season produce of dried herbs to add that extra flavour in your meals. You can also use fresh fruits juices, citrus fruits and spices to boost the flavour in your meals.

Be careful when selecting salt

substitutes: They may contain excess volumes of potassium, which does help in lessening some of the problems caused by high salt content, but too much of it can lead to kidney or eventually heart problems.

Skip sugary alcohols. Stay away from sugar-free fizzy drinks as much as you can, even when they promise to be full of calorie-free sugar substitutes. This is because sugar substitutes, such as - sorbitol, xylitol, maltitol, isomalt, lactitol, mannitol,

erythritol and hydrogenated starch hydrolysates (HSH) - tend to add to the feeling of bloating and thus, are best avoided.

Be wise about dairy. Dairy products are full of natural sugar; called lactose that might interrupt the digestion process leading to bloating. And, if you are lactose-intolerant, make sure to avoid cheese and yogurt, as it can lead to acifity build-up and cramping.

Eat small. Now eating small is the biggest golden rule, if you want to lose weight, but it is also a beneficial exercise if you are battling stomach bloating. Perk up your meal with a healthy snack, if you think your stomach is about to explode and quit indulging in heavy meals. Go for 4-6 mini meals in a day and make sure to eat slowly.

Move it. Get off the couch, if you feel bloated. Never skip your workout, if your belly feels full and uncomfortable. Exercise is a proven solution for any kind of digestive disorders as it helps regulate your body's

However, if your bloating continues then it might be a case of chronic bloating and can be something as serious as celiac disease. So follow the thumb-rule of elimination and failing all else, visit your doctor for a check

Light weight exercise increases bone density in adults



A new study has revealed that indulging in low-weight, high-repetition exercise can increase bone mineral density up to eight percent in adults.

According to the findings, this type of strength training may be an effective and maintainable method of increasing bone mineral density in older people and sedentary groups.

Lead researcher Jinger Gottschall of the Penn State said that this was such a profound finding because low-weight, high-repetition exercise was easily attainable by anybody and everybody.

In the study, 20 untrained adults completed a 27-week group exercise program. Participants were assigned to one of two groups that either completed

full-body weight-training workouts or workouts focused on building core muscles, in addition to cardiovascular workouts. The weight-training group completed two to three BODYPUMP(R); classes per week, a low-weight, highrepetition resistance training program in which the participants used a bar and selfselected weights. The study analysis found that participants in the weighttraining group demonstrated an eight percent increase in leg bone mineral density, a seven percent increase in pelvis bone mineral density, a four percent increase in arm bone mineral density and a four percent increase in spine bone mineral density. The core group's bone mineral density did not change significantly. Postmenopausal women and osteopenic individuals experienced significant bone mineral density increases of up to 29 percent.



A new study has revealed that many young heart attack patients, especially women, are unaware of the impending cardiac risks. Examining 3,501 heart attack survivors, the researchers found that only 53 percent had considered themselves at risk. Even fewer, 46 percent, of the patients reported being told they were at risk by a healthcare provider, and only 49 percent reported discussing heart disease and risk modification with a doctor.

Women were 11 percent less likely than men to be told by their doctors that they were at risk for a heart attack and were 16 percent less likely to report having a healthcare provider discuss heart disease and ways that they could reduce their risk.

Lead author Erica Leifheit-Limson of the Yale School of Public Health said that many younger women and men, even those with multiple cardiac risk factors, were not receiving adequate counseling on heart disease.

Leifheit-Limson and colleagues used data from the VIRGO (Variation in Recovery: Role of Gender on Outcomes of Young AMI Patients) study to analyze medical records and the results of interviews with heart attack patients from more than 100 hospitals in the United States and Spain. Study participants ranged in age from 18 to 55.

In the study, Leifheit-Limson and colleagues compared the prevalence of five cardiac risk factors (diabetes, high cholesterol, hypertension, obesity, and smoking status) as well as reports of clinical counseling on

They found that 97 percent of the women and 99 percent of the men had at least one risk factor, and nearly two-thirds had three or more. The most common risk factor was high cholesterol.

Senior author Judith Lichtman said that they need to empower individuals to seek information about heart health, and ensure that care

providers were educating patients about risk factor management. The study appears in the Journal of the American College of Cardiology.

Left nostril magic This yoga method is known to reduce blood pressure and calm you. The way to do it is to lie on your left side, and rest a finger on your right nostril to close it. Start slow, deep breathing through the left nostril. This technique is particularly good when overheating or menopausal hot flushes are preventing sleep.

Squeeze and relax Relaxing all your muscles can prepare your body for sleep. Lie on your back, take a deep, slow breath in through your nose and, at the same time, squeeze your toes tightly as if you are trying to curl them under your foot. Then release the squeeze. On another slow breath, curl your foot up toward your knee, then release. Breathe again, contract your calf muscles, then your thighs, buttocks, belly, chest, arms, and so on until you have moved all the way up your body, squeezing and releasing the muscles one by one. When you have gone from head to toe, your

breathing should be steady and you should feel ready for

Sensex, Nifty open flat as investors take breather after record run

New Delhi Benchmark stock market indices opened Wednesday's trading session flat, snapping their record run for the past four sessions. The S&P BSE Sensex was down 20.70 points to 84,893.34 at 10:23 am, while the NSE Nifty50 fell 18.20 points to trade at 25,922.20.11 the other broader market indices were trading in negative territory as the momentum seen over the past few trading sessions seems to have fizzled out. The top five gainers on the Nifty50 were Power Grid, HDFC Bank, Divi's Lab, M&M and Hindalco.

On the other hand, the top losers were Tata Consumer Products, LTIM, Tech Mahindra, Britannia and Tata Motors. Dr. V K Vijayakumar, Chief Investment



Strategist, Geojit Financial Services, said, "The Chinese monetary stimulus measures lifted the Chinese and Hong Kong markets yesterday and if the rally continues it is possible that FIIs will move more funds to invest in these markets which are highly attractive on valuations.""In India, metal stocks rallied in response to the Chinese stimulus measures," he added.He went on to say that it remains to be seen whether the "Chinese monetary stimulus will have an enduring positive impact since China's economic woes are structural and difficult to address through a monetary stimulus". It is more likely that the positive sentiments now being felt may soon dissipate and weaken, Vijayakumar noted.He explained that the gush of domestic liquidity, which is the main driving force behind the rally in India, is likely to keep the market resilient. "If Nifty is to go past 26000 decisively and sustain there, it has to be led by the Bank Nifty. There is more steam in this segment."

Airtel to launch AI-enabled network tech to crack down on spam calls. messages

NEW DELHI. Bharti Airtel is all set to roll out artificial intelligence enabled technology on its network to crackdown on spam calls and messages, company Managing Director and CEO Gopal Vittal said on Wednesday.

The technology will be rolled out at midnight starting September 26, which will alert users about probable spam calls and messages.

"There are several indicators based on which we have identified spammers. We have developed an AI-enabled spam detection solution which analyse calls in 2 millisecond and alert users on dialler," Vittal said. He said that the solution will be rolled out free of cost for all Airtel smartphone users."In 2 milliseconds our solution processes 1.5 billion messages and 2.5 billion calls every day. Our solution has been able to identify 100 million potential spam calls and 3 million spam SMSes originating every day," Vittal said.

The technology will not block the call on its own but it will be for users to decide on blocking calls, as sometimes there are 'false positives', which means even genuine calls get displayed as spam. He said that the solution will not be able to help users getting spam calls on over-the-top apps like WhatsApp. "It is one of the pain points (spam calls on OTT apps) which we have not been able to address," Vittal said.

Not withdrawing investment from Odisha: JSW

NEW DELHI. Billionaire Sajjan Jindal-led JSW group is not withdrawing its proposed Rs 40,000 crore electric vehicle (EV) and battery project from Odisha and not shifting the same to Maharashtra. This clarification from the JSW group came amid a report that the JSW group is planning to shift its multi-billion dollar EV and battery project from the eastern state."We are not withdrawing from Odisha," said Ranjan Nayak, executive vice president of corporate strategy, office of chairman and managing director. Odisha Industries Minister Sampad Swani on Tuesday said the state government was talking to the JSW group for implementation of the EV project in the state. In February this year, the JSW group, which now owns a stake in MG Motor India, signed a memorandum of understanding (MoU) with the Odisha government for the establishment of an integrated electric vehicle and EV battery manufacturing project at an investment of

GST circular tweak to help Infosys, others

Confusion is about applicability where services are not free and nominal amount is charged

NEW DELHI. The government is considering amendments in the GST circular 210, which clarifies on valuation of supply of services import by a related party where recipient is eligible to full input tax credit, to make it simpler for its correct interpretation by tax officers, according to a senior finance ministry official. This is in context of the recent show cause notices sent to Infosys, foreign shipping lines and several food and beverage companies engaged in relatedparty transactions by the Directorate General of Goods and Services Tax Intelligence (DGGI). The circular was issued in June. According to the official, despite this circular there have been several instances where GST authorities erroneously sent show cause notices. IT



major Infosys was served a show cause notice for evading taxes amounting to Rs 32,000 crore for the period July 2017 to March 2022. Though the government has waived off the tax demand for FY18 of Rs 3,898 crore for remaining years, they are looking at it on year-on-year basis.

"Infosys issue is being addressed at the field level. Infosys has to send its response by November 30, which is the last date for filing the annual return by companies. There seems to be a mistake made by the field officers," the official said, indicating the likely relief to be given to the IT major, another official said.

Revenue Secretary Sanjay Malhotra, during the press conference held after the 54th GST Council meeting, explained that circulars have already been issued clarifying GST applicability on relatedparty transactions. While the Council in its last meeting, didn't announce any relief to Infosys and other sector companies, it exempted import of services by branch offices of foreign airline companies from related entities."It is understood that DGGI

has held up certain taxpayers for paying up GST on matters related to interpretation of Circular 210/4/2024 and Circular No. 199/11/2023-GST, along with the amended Rule 28 of the CGST Rules and hence there is a need for clarity" said Vivek Jalan, Partner at Tax Connect Advisory Services LLP. As per Pratik Jain, Partner, PwC India, while circular 210 addresses most of the issues, there is some confusion about its applicability where the services are not on free of cost basis and say a nominal amount is charged between related entities, though logically it should also be covered."Further, it is not clear whether the circular will also apply in cases where the recipient has some minor non-taxable income (such as trading in shares or mutual fund). It will be good if these aspects are further clarified," said Jain. 'Authorities sent several show cause notices' As per an official, despite this circular there have been several instances where GST authorities erroneously sent show cause notices. Infosys was served show cause notice for evading taxes of Rs 32,000 crore for period July 2017 to March 2022. Though the govt has waived off demand for FY18 of Rs 3,898 cr for remaining years.

Vodafone Idea shares fall 2% as ICICI Securities cuts target price

ICICI Securities has reduced Vodafone Idea's EV/EBITDA multiple to 13 times FY27 from 14 times and lowered its target price to Rs 11 from Rs 15.

Hyundai Motors India is all set to launch the country's biggest-ever initial public offering (IPO) after receiving approval from the Securities and Exchange Board of India (Sebi). The company submitted its draft papers in June 2024 and the IPO may be laurehed as a contract of October properted. launched as soon as October, reported Businesstoday.in.The South Korean automaker's Indian unit plans to raise \$3 billion, which is around Rs 25,000 crore, through the IPO. The offering will be a



complete offer-for-sale (OFS), meaning that the promoter, Hyundai Motor Company, will sell a portion of its shares to the public.

This IPO is expected to not only raise funds but also improve Hyundai Motors India's visibility in the Indian market. By listing on the stock exchange, the company aims to increase its brand image and give more liquidity to its shares. Hyundai Motors India was the second-largest carmaker in India in terms of passenger vehicle sales in the financial year 2023-24, just behind Maruti Suzuki.

Several major financial institutions are involved in handling the IPO process. Citi, HSBC Securities, JP Morgan, Kotak Mahindra Capital, and Morgan Stanley are the lead banks advising Hyundai on the transaction.

In terms of legal support, the company has hired Shardul Amarchand Mangaldas as its counsel, while Cyril Amarchand Mangaldas will represent the banks. Internationally, Latham and Watkins will act as legal counsel. KFin Technologies has been appointed as the

registrar for the issue. The upcoming IPO is expected to be a major event in the Indian stock market, given its size and the reputation of Hyundai Motors India. However, more details about the share price and exact launch date are awaited as the company prepares to enter the final stages of its offering.

Start-up funding falls 7% to \$7.6 billion in January-September

NEW DELHI: Indian start-ups have secured only \$7.6 billion in funding in the last nine months, marking a 7% decline from \$8.2 billion in 2023 and a 66% fall from \$22.4 billion funding in 2022. As per Tracxn's India Tech 9M 2024 report (Jan 1- Sept 13, 2024), the majority of funding came from late-stage rounds -— about \$4.7 billion, compared to \$4.9 billion in 2023 and \$14.3 billion in 2022. The country saw peak funding of \$29.9 billion in 2021, but since then funding has declined due to ongoing geopolitical headwinds and the global funding winter. Retail, fintech, and food and agriculture tech have emerged as the top-performing sectors. The retail sector managed to attract \$1.95 billion in funding so



far this year, and this is a 23% increase from 2023 but a 61% drop from 2022. Flipkart raised \$350 million from Google, and Meesho secured \$275 million during this period. Fintech emerged as the second-highest funded sector as the sector raised \$1.49 illion. However, this is a 39% fall from \$2.46 billion in 2023 and a 70% fall from \$4.97 billion in 2022. The food and agriculture tech sector too saw an increase in funding as the sector saw \$1.43 billion in funding, a 63% rise from \$880 million in 2023. However, this is down 48% from \$2.75 billion in 2022.Six start-ups have turned unicorns during this period as against just one in 2023. IPO activity also surged, with 29 tech companies going public, up from 15 in the same period last year."Despite the broader economic challenges, India's tech ecosystem continues to demonstrate resilience. The emergence of six new unicorns and a surge in IPOs with 29 tech companies going public reflects investor confidence in the sector. While overall funding has slowed, late-stage investments and the increasing momentum in fintech and retail show innovation-driven growth is still thriving in India's start-up landscape," said Neha Singh, co-founder Tracxn. Foxconn eyes \$1 billion display module plant in Tamil Nadu: Report

New Delhi Foxconn, one of the world's largest electronics manufacturers, is planning to invest \$1 billion to establish a new facility in Tamil Nadu. The new plant will focus on assembling smartphone display modules, according to a report by The Economic Times. This will be the first display module facility Foxconn has built in India, and it is expected to mainly support the production of Apple's iPhones. The new plant could also benefit other manufacturers such as Pegatron and Tata Electronics, as these companies may have access to the components produced at the facility.Foxconn has reportedly secured 5,00,000 square feet of land at an industrial park in Oragadam, near Chennai.

This new site is close to its existing smartphone assembly plant, allowing for streamlined operations and potentially faster production cycles. According to Tarun Pathak, research director at Counterpoint, assembling display modules locally could add between 2-3% more value to the overall production process in India, on top of the 5% value already added by phone assembly. "This is a strategic move that could help India climb higher in the global electronics manufacturing ladder," said Pathak.Foxconn's new display plant



may also align with its broader plans to assemble other tech products in India, including Google Pixel phones, which are gaining popularity worldwide. Foxconn has been rapidly expanding its business in India over the past few years, with a strong focus on smartphone assembly.

The new display module unit is part of a wider plan by the company to diversify its operations. Beyond smartphones, Foxconn has shown interest in expanding into sectors like electric vehicles (ÊVs), batteries, and semiconductors.At present, India imports most of its smartphone display modules from countries like China and South Korea.

By setting up local production, Foxconn could help reduce these imports and bring down the cost of components for phone manufacturers. As per the report, this move could also help brands shorten delivery times by reducing supply chan delays.

Globally, major players in the display module market include companies such as Samsung Display, BOE Technology, and LG Display. In India, however, local assembly is dominated by Chinese firms such as TCL CSOT and TXD (India) Technology.One of the biggest hurdles for Foxconn will be sourcing components for the display modules. Currently, a large portion of these components are still imported from China, and reducing this reliance will take time. Another challenge is the need to build a skilled workforce to manage the production of advanced display technologies.Foxconn's deeper investment in India aligns closely with Apple's strategy to reduce its reliance on China.

Salaried employees work longer hours than casual workers, finds survey

For many corporate workers, these 48-hour weeks translate to roughly 9 hours of work each day if they're working five days a week, or 8 hours if it's a six-day work week.

New Delhi. A new government survey has shed light on an alarming trend in the workplace—salaried employees, especially those working in corporate environments, are putting in significantly more hours each week than their casual or self-employed

According to the Periodic Labour Force Interestingly, while salaried employees are Survey (PLFS) for July 2023-June 2024, regular wage earners are clocking an average of 48.2 hours a week, compared to just under 40 hours for casual laborers and the selfemployed. This difference in work hours isn't just a statistic; it paints a picture of the

demanding corporate work culture that salaried employees face. Tight deadlines, high expectations, and the ever-present need for productivity are stretching working hours to new extremes. For many corporate workers, these 48-hour weeks translate to roughly 9 hours of work each day if they're working five days a week, or 8 hours if it's a six-day work week. While some HR experts argue that these hours aren't necessarily overwhelming, others suggest that it's not just the number of hours that matter-it's the environment.

The constant hustle, the pressure to perform, and the rising demands of modern workplaces are pushing many employees to

working longer hours, casual laborers and the self-employed are facing a different kind of stress. Although they tend to work fewer hours—just under 40 per week—these workers often deal with income instability and irregular schedules. Self-employed



individuals may enjoy the flexibility of setting their own hours, but their work often depends on market demand, and they don't have the safety net of a stable paycheck.

The conversation around work hours and employee well-being gained renewed urgency after the death of Anna Sebastian Perayil, a 26-year-old Ernst & Young employee in Pune. Her death has been linked to extreme work-related stress, igniting a nationwide debate on the toll that long hours and high-pressure environments can take on

employees. The incident has prompted a government investigation into work culture and the impact of long hours on employee health. As more details emerge, many are calling for companies to rethink how they approach deadlines and employee expectations. Experts argue that businesses should foster a more balanced work culture-one that values productivity within reasonable limits and discourages the notion that working long hours is a badge of honor. As work-related stress continues to make headlines, one thing is clear: the way we

work needs to change. Whether it's the

long hours salaried employees are putting in or the unstable schedules of casual workers, the current system isn't sustainable. A healthier work-life balance is no longer just a luxury—it's becoming a necessity. For salaried employees, it's not just about managing the hours in a week, but also about creating a work environment that supports well-being. And for companies, the message is simple: the time has come to prioritise employee health over outdated ideas of commitment and productivity.

Speaking about the Olympiad, the 20-year-old said Anand did have an indirect influence on their performances."He is one of the main reasons why most of us started playing chess. When we started playing chess, we wanted to be like Anand. It was like an inspiration. So he is the reason why we started and reached the level we are. This Olympiad, he didn't have a direct influence. But definitely, there was a lot of indirect influence," said Erigaisi.

England pacer Mark Wood told not to lift kids up after elbow fracture

New Delhi. England fast bowler Mark Wood, 34, has revealed that he has been instructed to avoid lifting his children with his right arm due to a stress injury in his elbow. Wood, a key member of England's bowling attack, has been ruled out for the remainder of 2024 after medical scans confirmed the extent of the injury. Wood, who has played 37 Test matches and claimed 119 wickets, spoke candidly about the injury during an interview on BBC's Test Match Special. "There is nothing I can really do on my right side," said Wood. "I have been told to stop picking my kids up with my right arm. I have to do everything with my left."The injury first came to light during England's Test series against Sri Lanka last month. Initially, Wood was sidelined by a groin strain, but while undergoing scans for the groin issue, his elbow also raised concerns. The scans revealed bone stress in his right elbow,



leading doctors to order further checks to assess whether the injury could develop into a stress fracture."It was a bizarre injury," Wood said, explaining the unexpected nature of the diagnosis. "I had a bit of a groin tweak and went for a scan with a stiff elbow, which is not uncommon for fast bowlers. I

thought I might need an injection, but they found bone stress in the elbow. I must have been playing with it."

This is not the first time Wood has dealt with elbow issues. He underwent surgery in 2022 for a similar problem, and the latest setback will see him miss key upcoming tours, including England's Test series against Pakistan in October and New Zealand in December. The England and Wales Cricket Board (ECB) has confirmed that Wood is aiming to return to full fitness in early 2025. He is targeting England's white-ball tour of India and the ICC Champions Trophy in Pakistan, which begins in February 2025.

England will sorely miss Wood's express pace, which has been a crucial asset for the team, particularly ahead of their Ashes campaign in Australia in 2025-26. As one of the fastest bowlers in the world, Wood's absence leaves a significant void in England's bowling
