New Delhi, Sep 27: The move comes days after a special court in Bengaluru ordered directing the Lokayukta to carry out a probe against Siddaramaiah on allegation of illegalities in allotment of 14 sites worth ?56 crore to the chief minister's wife Parvathi by MUDA. The special court exclusively to deal with criminal cases related to former and elected MPs/MLAs had issued the order directing the Lokayukta police in Mysuru to initiate an investigation on the complaint filed by RTI activist Snehamayi Krishna. Accusation against RG Kar ex-principal grave, can attract death penalty

Kolkata, Sep 27: A designated CBI court, denying bail to former RG Kar Medical College and Hospital principal Sandip Ghosh, has observed that the nature of the accusation against him is grave and it can attract capital punishment if proved. The CBI had arrested Ghosh and former officer in-charge of Tala police station, Abhijit Mondal, for alleged tampering of evidence and delay in filing of FIR in the rape and murder of a doctor at the state-run hospital on August 9. The court in its order, dictated on September 25, said it appears from the case diary that the process of investigation by the central probe agency is in full swing. Denying the bail prayer of Ghosh, Additional Chief Judicial Magistrate S Dey observed that the nature and gravity of the accusation is grave and if proved, it may attract capital punishment. which is handed in the rarest of rare cases. New Delhi, Sep 27: Jagdeep Dhankhar said "values in the Constitution reflect the essence of Sanatana Dharma," calling it all-encompassing and the only way forward for humanity. Vice President Jagdeep Dhankhar on Thursday referred to religious conversions as "antithetical" to both national values and constitutional principles, emphasising that a "sugar-coated philosophy" is being used to target vulnerable sections of society, news agency ANI reported. Addressing the inaugural ceremony of the 'Hindu Spiritual and Service Fair' in Jaipur, Dhankhar said that the "values enshrined in the Constitution reflect the essence of



Sanatana Dharma," describing it as all-encompassing and the only path forward for humanity. He further highlighted that Hinduism advocates for humanity and stresses the protection of all living beings and nature. "Sanatana never spreads poison; it channels its own powers. There is another indication that is very dangerous, one that could change the country's politics. This is happening through policy, institutionally, and in a planned conspiracy, and that is a religious conversion!" he said. "A sugar-coated philosophy is being sold. Where do they go? They target the vulnerable sections of society. They encroach more into our tribal communities. They lure them with temptation. I firmly believe that we are witnessing, very painfully, religious conversions in a structured manner as a policy, and this is antithetical to our values and constitutional principles. There is an urgent need to neutralize such sinister forces. We must remain vigilant and act swiftly," he added. "You cannot imagine the scale of those currently active in fragmenting India," he said. New Delhi, Sep 27: The latest status report presented by CAQM showed that between September 18 and 25, Punjab reported 93 incidents of stubble burning, while Haryana registered 70 farm fires. Tackling stubble burning requires a proactive approach by the Commission for Air Quality Management (CAQM), the Supreme Court said on Friday as it was visibly upset over the orders passed by the panel failing to translate into action on ground. The latest figures from Punjab and Haryana over the past week showed a spike in stubble burning as compared to last year, raising alarms as yet another Delhi winter approaches. CAQM is the pollution watchdog for Delhi and adjoining areas - "Though the CAQM has taken certain steps, the commission needs to be more active. It must ensure that its efforts and directions actually translate into reducing the problem of pollution," the SC bench headed by justice Abhay S Oka said. With the CAQM chairman Rajesh Verma attending the hearing via video conferencing, the court questioned the work that was being done by the three sub-committees constituted under the CAQM Act, 2021. On being told



that they meet at least once every three months, the court asked the chairman. "You are acting as silent spectators. If they are meeting once in three months, is it sufficient considering the situation that we

are in?" The bench, also comprising justice Augustine George Masih, noticed that the Act empowers the commission to launch criminal prosecution against officials, close polluting units and direct compensation for not complying with its orders.

"Can you say for the three years that this commission has existed, because of you, air quality is improving in Delhi? You have issued 82 directions to various states and authorities. What is the use of these orders if there is no enforcement or criminal action against officers," the bench observed. The court was referring to section 14 of the Act, which makes any contravention of the provisions of the Act, or any order or direction issued by

the commission, to be a punishable offence, with imprisonment for a term which may extend up to 5 years or fine

Treasury glitch: Secretariat staff get 'advance' salary in Kerala

THIRUVANANTHAPURAM. In a major glitch, around 200 employees of the state Secretariat received their September's salary well in advance, on Thursday. Sources said it was a mistake on the part of an officer of the the secretariat sub-treasury.

The salary bills of Secretariat employees are processed at the Secretariat sub-treasury. Normally, September's salary should be disbursed on October 1. The salary bills from different departments and offices will be submitted by the month-end following which the salary is processed by the treasuries.

A source in the treasuries department said an error in setting the due date of bills resulted in the mistake. The sub-treasury gets online bills. There was an error in setting the due date of three bills. The issue came to the notice of treasury officers after working hours on Thursday. The treasuries directorate will decide the further course of action, an officer said.

Salaries were credited to a number of officials, including personnel staff of about five ministers, including the chief minister, in addition to Secretariat staff working with a couple of departments. It's learned that the government is likely to take immediate action against the official responsible for the lapse."It was a mistake on the part of one of the sub-treasury officers in signing the salary bills. The bills to be scheduled for October 1 were signed in advance and handed over. As per information, a bill of Rs 43 lakh got cleared. The total amount would come to less than a crore," said an official. What's more interesting is that the staffers who got the salaries, immediately transferred the amount to other accounts so as to prevent the government from holding it back.

Guest lecturers' fight yields result, to receive remuneration every month

THIRUVANANTHAPURAM. The government has intervened to address the complaint of guest lecturers in colleges across the state that their remuneration has been pending for many months. The higher education department will bring out detailed guidelines to ensure that guest lecturers are paid their remuneration in a timely manner every month.

TNIE had earlier reported that majority of around 3,000 guest lectures in colleges across the state have been languishing without pay for many months due to apathy of the officials in issuing approval orders.

In the wake of the report, Higher Education Minister R Bindu convened a high-level meeting on Thursday to address the issue.

The meeting decided to evolve a Standard Operating Procedure (SOP) for payment of guest lecturers. From now on, guest lecturer aspirants will not have to get their certificates verified annually. Instead, they need to carry out one-time online registration for the

A special registration option will be provided for guest faculty who once get approval order from the office of the Deputy Director (DD) of Collegiate Education. This registration will enable them to work in any college in the state. The DD office concerned need to only

examine if the appointment is in order. After appointing a guest lecturer, it will be mandatory for the principal concerned to submit the proposal to the DD office within a month. The proposal will be given quick approval and their remuneration will also be disbursed without delay," the minister said.

Move to preserve historic documents in Kerala begins, but concerns remain

KOCHI. The state government's attempt to preserve and conserve heritage records in public archives, comprising manuscripts, palm leaf inscriptions, and historical documents, began on Thursday with a team of officials led by the minister concerned visiting the Ernakulam Regional Archives.

It's been noticed for a long time that important heritage records from the District Heritage Centre, Chalakudy, which have

attempts for digitalisation of the records were initiated 16 years ago. But they have not been followed up. Beyond just meetings and discussions, the department has to be adept at acting upon this issue.

What the new committee should look into is to conserve what is left in our hands without any delay. Also, thorough investigations into the department and its activities must be done," he added. The regional archives in Ernakulam is home to many historic records dating from the days of the erstwhile Cochin Kingdom and the colonial period.

Btech student allegedly assaulted by seniors after he refused to pay money for Onam celebrations

Recounting the incident, Vishnu said,"The seniors asked me to contribute Rs 350 for Onam celebration expenses. I only had Rs 200 at that time, which I gave them. Without believing what I said, they slapped me and left. Later, as I was going to bed,w a friend took me to them. They brutally attacked me, citing my refusal to pay, and previous disagreements." Out of fear, he did not reveal the ordeal he



faced to his parents."But the doctor who treated me informed my parents that I had suffered serious injuries from some attack," said Vishnu, adding that the police did not register an FIR based on his

But, an officer from Mulanthuruthy police station said, "We received the complaint on Wednesday evening and provided an acknowledgment receipt. Based on the claims, we contacted the suspects to verify the authenticity of the incident."During the preliminary investigation, it appears the incident may have stemmed from a regular fight among the students, he said.

Anna varsity to set up drone pilot training centre in Ladakh

While University of Ladakh will provide infrastructure like space on the campus, Anna university will take care of trainers and simulators for training drone pilots.

CHENNAL After opening a branch of its Remote Pilot Training Organisation (RPTO) in Bengaluru, the Anna University is all set to spread its tentacles

The varsity will soon set up RPTO's branch in University of Ladakh, Leh campus, to train drone pilots. A team from the university had recently visited Ladakh to participate in a drone expo, conducted by the defence force.

"In the expo, we met the governor and chancellor of university of Ladakh and he asked us to open a branch in the university. In a place like Ladakh, utility of drone is very much needed," said Senthil Kumar, director of the Centre for Aerospace



Research (CASR) under MIT at Anna University.Both the universities had a detailed discussion on the issue. While University of Ladakh will provide infrastructure like space on the campus, Anna university will take care of trainers

and simulators for training drone pilots. The initiative will boost the revenue of AU, as it will get 10% royalty from the earnings through admissions."After getting approval from Directorate General of Civil Aviation, we will start the centre. The whole process will take two months," said Kumar.

The university opened its RPTO on MIT campus in 2021. Since then, it has trained over 2,000 drone pilots. Anna University has already opened RPTO branch at a private engineering college in Bengaluru, and it is fully functional.

Controlled implosion razes four storey building in seconds, owner expresses frustration over official

SANGAREDDY. A four-storey building constructed on the FTL of Pedda Cheruvu in Malkapur village of Kondapur mandal was demolished on Thursday, using implosion, a controlled process that uses explosives to weaken and collapse a structure into itself. Recently, District Collector Valluru

Kranthi ordered an inquiry upon discovering that the building was built on the FTL of the lake years ago with the assistance of certain officials. Following an investigation by the Revenue and

Irrigation officials, a report revealed that the building was built on the FTL and the collector ordered the demolition of the structure.

During the explosion, a stone was dislodged and struck Gopal, a home guard on duty at the site, resulting in a severed head injury. He was taken to Sangareddy government hospital and then later

Locals against HYDRAA survey in Hyderabad, threaten to end lives

HYDERABAD. Amid the ongoing demolition drive of HYDRAA in various parts of the city, the residents of the Musi River Catchment areas expressed dismay over the authorities conducting surveys in the area. The residents are reportedly warning that they will end their lives if they are forced out of their houses."Come what may, we will not move out of our houses. We will ignite our bodies to mark the protest against the authorities and protect our properties," a large number of residents said, adding "Despite possessing valid documents, and having constructed our houses with our hard-earned money, the authorities are still forcing us out.""We had thought after Revanth Reddy becomes the chief minister, our lives would become better. However, looking at his actions, he seems to be heartless," they expressed.

A few people also appealed to Congress leader Rahul Gandhi to intervene and direct the chief minister to stop this eviction programme against the impoverished families. On Thursday, the survey teams also visited KCR Nagar in Ramanthapur to gather details on houses built in the catchment area, sparking outrage among the residents. "As the state government is hellbent on displacing us, the future looks bleak and there is no scope to live, the only solution for us is to end our lives by igniting ourselves," a resident said. Another resident lamentably asked, "How can I make a livelihood if the government displaces us and gives us a 2BHK apartment in a far-off place where there is no way to earn or launch a business?"

The BJP's star campaigner will hold two rallies this week in south Haryana — while the first rally will be held in Rewari on Friday, he will address the second rally in Badshahpur on Sunday in support of BJP candidate Rao Narbir Singh.Narbir faces Independent candidate Kumudni Rakesh Daultabad (wife of former MLA Rakesh Daultabad) and Congress candidate Vardhan Yadav in Badshahpur.In Rewari, the BJP has pitted Laxman Singh Yadav against sitting Congress MLA Chiranjeev Rao. Both the seats fall under the Gurgaon Lok Sabha constituency.part from former chief minister Bhupinder Singh Hooda, till now no big Congress leader has campaigned in south Haryana. South Haryana, which overwhelmingly supported the saffron party in 2014 and 2019, played a crucial role in the formation of the BJP-led govt in the state.

South Haryana is the only region in the state where the BJP still holds the ground in this assembly election. During the parliamentary election, the tally of the BJP dropped to five from 10 in 2019.

Out of the five LS seats won by the BJP, three — Gurgaon, Mahendragarh-Bhiwani and Faridabad — are in south Haryana. BJP candidate from Badshahpur and former minister Narbir said Shah's arrival will create a wave for the BJP in the region. Shah will hold a rally on Sept 29 in Dhorka village, located in Sector 95, which comes under Badshahpur assembly constituency. "Southern Haryana has always played a crucial role in forming the BJP govt. The region will again play an important role in the formation of the BJP govt for the third term,"

FSO demanded bribe & threatened to kill': Resto manager goes to cops

Gurgaon. A complaint has been lodged against a food safety officer (FSO) from Food and Drugs Administration for allegedly demanding a bribe and issuing threats to the manager of a restaurant in a city mall. While an FIR is yet to be filed, the complaint was lodged at CM window and PM window. Abhay Raj, an assistant general manager at Barbeque Nation restaurant, filed the complaint, asserting that FSO Ramesh Chauhan demanded a bribe to avoid conducting a raid and collecting samples from the restaurant's outlet in Ambience Mall on Aug 24, when he purportedly visited for an inspection based on a complaint received on the CM window. According to the complaint, when Raj refused to pay the bribe, the FSO became enraged and resorted to issuing "unlawful threats". The situation escalated on Sept 24, when Chauhan revisited the restaurant and met with outlet manager Neeraj Kumar. During this encounter, the FSO allegedly used abusive language towards Raj and threatened him with severe consequences "for not acquiescing to the bribe demand". TOI has obtained access to a recording of the conversation, which was captured on Kumar's phone, where the FSO can be heard using derogatory terms towards Raj. The audio clip also allegedly contains a threat where the FSO can be heard saying, "Thok doonga (implying will eliminate you)". In addition to requesting the lodging of an FIR against Chauhan, Raj has also sought necessary measures to ensure the safety of his life and the lives of his family members, which he believes are imperilled due to the "FSO's threats". However, the FSO, while speaking to TOI, said he received phone calls to not raid the restaurant, adding that he was also threatened and abused at the mall

All eyes on Jats: What's making them crucial for winning Badshapur seat

Gurgaon. In fiercely contested Badshapur, it's the battle for Jat votes. The political contest in this key south Haryana constituency has turned into a four-pronged fight. Biden signs stopgap spending bill to avoid government shutdown before polls

Washington. President Joe Biden on Thursday signed a temporary government spending bill that keeps agencies operating into December, after Congress punted key spending decisions until after the November election.

The bill generally funds agencies at current levels through December 20, setting up the prospect of a government shutdown fight just before the holiday season. Lawmakers did agree to add \$231 million to bolster the Secret Service after the two assassination attempts against Republican presidential nominee Donald Trump. Money was also added to aid with the presidential transition. The measure easily passed Congress on Wednesday on a bipartisan basis, 341-82 in the House and 78-18 in the Senate, with Republicans supplying all the no votes in both chambers. House Speaker Mike Johnson, R-La., billed the measure as doing "only what's absolutely necessary," a statement directed at members of his own conference concerned about spending levels. Johnson said the only alternative to the continuing resolution at this stage would have been a government shutdown.

The temporary measure was needed because Congress is nowhere close to completing work on the dozen annual appropriations bills that fund much of the federal government. The House has passed five of the 12 bills, mostly along party lines. The Senate has passed zero.

Indian-American Judge indicted for misrepresenting himself to influence election outcome

HOUSTON. Fort Bend County Judge KP George was on Thursday evening booked into jail following his indictment by a grand jury for misrepresenting himself online to influence the outcome of his election.

According to Fort Bend County judicial records, George was booked at 7.17 pm on a misdemeanour charge connected to a social media scheme aimed at swaying voters. His bond was set at USD 1,000.

A statement from his office said George was released from jail on a personal recognizance (PR) bond, meaning he was released without paying bail by signing a written agreement to appear in court as scheduled and comply with any conditions of his release. The allegations have sparked increased calls for George's resignation, he has however made it clear that he does not intend to step down. Earlier on Thursday, the grand jury indicted George on a Class A misdemeanour after he was alleged to have coordinated online imposture with his former chief of staff, Taral Patel.Patel was arrested in June on felony charges of online misrepresentation for his involvement in the scheme. During his successful re-election campaign in 2022, George claimed he was a victim of racist and xenophobic attacks. However, accusations have surfaced alleging that he collaborated with Patel to create targeted posts to generate sympathy and support. Sources said one of the accounts used for these posts operated under the screen name Antonio Scalywag. The indictment alleges that George utilised a fake Facebook account to post racist comments aimed at damaging his opponent Trever Nehls during the November 2022 election.

Who is Sanae Takaichi Japan's potential first female prime minister

World Sanae Takaichi, a conservative leader and protégé of former Prime Minister Shinzo Abe, is aiming to become Japan's first-ever female prime minister. Japan's ruling party is set to elect its new leader on Friday, with the victor poised to become the country's next prime minister. Among a record nine candidates, three frontrunners are locked in a tight race, which is likely to result in a runoff vote. The winner will inherit leadership of the world's fourth-largest economy amid surging living costs, driven by a weak yen and high inflation. Japan is also grappling with increasing regional security challenges and heightened tensions with neighbors, particularly China. Here's all you need to know about Sanae Takaichi: Japan's potential first woman prime minister —A political veteran from the right wing of the Liberal Democratic Party, she has pledged to focus on economic growth while maintaining a hardline stance on national security, with an emphasis on strengthening cyber and space defence. Despite her economic agenda, Takaichi has faced criticism for her conservative views on social issues, including her opposition to same-sex marriage and gender reforms.

She has also resisted legislation allowing married women to retain their maiden names. Her ties to controversial members of the Abe faction and admiration for Margaret Thatcher, the former British prime minister, further highlights her traditionalist stance.If successful, the 63-year-old would break significant barriers in Japan, where men continue to dominate politics and business leadership.

Florida braces for 'unsurvivable' storm surge as Hurricane Helene intensifies

UPDATED. Driving rain flooded roadways and closed airports in Florida as an intensifying Hurricane Helene marched toward the state's panhandle region, bringing the threat of a potentially deadly storm surge to much of the coastline. The storm became a major Category 4 hurricane on Thursday with sustained winds near 130 mph (209 kph), the National Hurricane Center said, and was expected to continue gaining power. Helene was forecast to make landfall around 11 pm EDT (0300 GMT Friday) in Florida's Big Bend region, Florida officials said.

Officials pleaded with residents in the path of the storm to heed mandatory evacuation orders or face life-threatening conditions. Helene's surge - the wall of seawater pushed on land by hurricane-force winds - could rise to as much as 20 feet (6.1 meters) in some spots, as tall as a two-story house, the center's director, Michael Brennan, said in a video briefing.A really unsurvivable scenario is going to play out" in the coastal area, Brennan said, with water capable of destroying buildings and carrying cars pushing inland. The hurricane was about 130

miles (209 km) west of Tampa, Florida, as of 5 pm EDT (2100 GMT), the center said.Strong rain bands were whipping parts of coastal Florida, and rainfall had already lashed Georgia, South Carolina, central and western North Carolina and portions of Tennessee. Atlanta, hundreds of miles north of Florida's Big Bend, was under a tropical storm warning.In Pinellas County, which sits on a peninsula surrounded by Tampa Bay and the Gulf of Mexico, roads were already filling with water before noon. Officials warned the storm's impact could be as severe as last year's Hurricane Idalia, which flooded 1,500 homes in the low-lying coastal county.

Videos posted on the county's social media site showed some swamped beachside roads and water rising over boat docks. Airports in Tampa, Tallahassee and St. Petersburg all suspended operations on Thursday.

Governor Ron DeSantis warned North Florida residents to flee before time ran out.

'You have time to get to a shelter, but you've got to do it now," he said at a news briefing.
"Every minute that goes by brings us closer

to having conditions that are going to be

simply too dangerous to navigate.

Helene is expected to remain a full-fledged hurricane as it rolls through the Macon, Georgia, area on Friday, forecasters said. It could bring 12 inches (30.5 cm) of rain or more, potentially devastating the state's cotton and pecan crops, which are in the middle of harvesting season."The current forecast for Hurricane Helene suggests this storm will impact every part of our state, Georgia Governor Brian Kemp said.

After making landfall across the Florida coast,

Helene is expected move more slowly over the Tennessee Valley on Friday and Saturday, the NHC said.Storm surge was forcast to reach 15 to 20 feet (4.6 to 6.1 meters) in the Big Bend area of Florida's Panhandle region where the storm is expected to come ashore.

Numerous evacuations were ordered along Florida's Gulf Coast, including Sarasota and Charlotte counties.Pinellas County officials ordered evacuations of long-term

healthcare facilities near the coast, including nursing homes, assisted living centers and hospitals. Not everyone heeded the evacuation orders. In coastal Dunedin, Florida, about 25 miles west of Tampa, state ferry boat operator Ken Wood, 58, planned to ride out the storm with his 16-year-old cat, Andy."We're under orders, but I'm going to stay right here at the house," Wood told Reuters by telephone. "The storm looks like it'll be a bit west of us, but who knows? I'm sure it'll be interesting, to say the least."

Iran never forgets those who...: Vice President on arming Russia in Ukraine war

World Iran's Vice President Mohammad Javad Zarif said Tehran "never forgets" those who help it in difficult times while stressing that its supply of weapons to Russia in the Ukraine war was more of a business to "earn currency". In an interview with CNN, the fiery former Iranian Foreign Minister, however, asserted that "war was not an answer" to any crisis."We do not believe that war is an answer to anything. In any war, everybody will lose. All roads have been closed for Iran in violation of international law, and we need to engage in business and earn currency. The Russians engage with Iran in trade," Zarif said.Lambasting the West for ceasing all business ties with Iran, the Vice President said it was willing to discuss ways to end the various crises



that have been created due to the United States's withdrawal from the Iran nuclear agreement, formerly known as the Joint Comprehensive Plan of Action (JCPOA)."The US has closed all possibilities of trade with Iran. We never forget those who help us in times of difficulty. Europeans have to answer why

they closed all businesses in Iran. Had Iran violated deals? Why should we be concerned about the concerns of Europe when they are not concerned about their own obligations under international law," he said. Under the nuclear deal, Iran had agreed to dismantle much of its nuclear program and open its facilities to more extensive inspections in exchange for billions of dollars' worth of sanctions relief. However, the deal has been in jeopardy since former President Donald Trump withdrew the United States from it in 2018."Everyone has to come down from their high heels and walk with us. We are willing to negotiate and willing to talk about how to end the various crises that have been created because of the US's withdrawal from the JCPOA," he said.

One dead, 25 injured in blast inside police station in Pakistan Peshawar A powerful blast ripped through a police

station in northwest Pakistan's Khyber Pakhtunkhwa province on Thursday, killing a child and injuring 25 mostly policemen. The incident occurred at Swabi police station, some 70 km off Peshawar.

As per an initial report received by the Central Police Office, the explosion apparently occurred "due to a short circuit" inside a depot on the first floor of the police station. Rescue and firefighting teams rushed to the scene immediately and started shifting the wounded policemen to the Bacha Khan Medical where emergency has been imposed. There are multiple injuries, and "the top portion of the building has caved in...", police officials said. A child has been killed and 25 others



mostly policemen have been injured in the blast, officials said. The power blast affected the building which caught fire, however, it was doused following an immediate response from firefighting teams. A senior Khyber Pakhtunkhwa provincial government official clarified that the explosion at the police station was not a terrorist act. According to the official, who wished to remain anonymous, "explosives confiscated during multiple operations accidentally detonated due to malfunction, despite plans for controlled disposal at some safe location outside."Rescue officials say they have pulled out 12 injured from the rubble so far and expect more. Chief Minister KPK Ali Amin Gandapur has expressed condolence over the death of a child in the

Several killed as Israel rejects US-supported ceasefire plan, hits Lebanon again

Beirut. Israel rejected global calls on Thursday for a ceasefire with the Hezbollah movement, defying its biggest ally in Washington and pressing ahead with strikes that have killed hundreds in Lebanon and heightened fears of an allout regional war. Despite Israel's stance, the US and France sought to keep prospects alive for an immediate 21-day truce they proposed on Wednesday, and said negotiations continued, including on the sidelines of a United Nations meeting in New York.An Israeli warplane struck the edges of the capital Beirut, killing two people and wounding 15, including a woman in critical condition, Lebanon's health ministry said. That took deaths from hits overnight and on Thursday to 28 and over 600 since Monday. The strike killed the head of one of Hezbollah's air

force units, Mohammad Surur,

Hezbollah said, the latest senior Hezbollah commander to be targeted in days of assassinations among the group's top ranks. Israel said it has struck about 220 Hezbollah targets over the past day.

On the Israeli side of the border with Landing in the US to address the UN Lebanon, the army staged an exercise simulating a ground invasion - a potential next stage after relentless airstrikes and

explosions of communications devices. Israel's air force is planning to assist troops in the event of a ground operation and will stop any arms transfers from Iran, Air Force Commander Major General Tomer Bar said late on Thursday. We are preparing shoulder to shoulder with Northern Command for a ground maneuver. Prepared, if activated. This is a decision to be made above us," he told soldiers, in a video distributed by the Israeli military. Israel has vowed to secure its north and return thousands of citizens who have evacuated since Hezbollah launched a campaign of cross-border strikes last year in solidarity with Palestinian militants fighting in Gaza.

Harris, the Democratic presidential candidate, enjoys a slight lead over former president Trump in Michigan, as per the latest poll released by UMass Lowell's Center for Public Opinion and YouGov. Harris is slightly leading 48 per cent to 43 per cent in the Great Lakes State against Trump, it said. "For a swing state, this margin is good news for the vice president's campaign," Rodrigo Castro Cornejo, UMass Lowell political science assistant professor and Center for Public Opinion associate director, said.If Trump wants to beat this margin, he has an uphill battle to fight in the Great Lakes State. "The Trump campaign,"



Castro Cornejo said, "has a negative favorability in Michigan that needs to be overcome if they want to remain competitive in the state."Harris stands at 48 per cent against Trump's 46 per cent in



Pennsylvania, the UMass Lowell's Center for Public Opinion said."The presidential race remains very close in Pennsylvania with the coming weeks a crucial time for both campaigns," Cornejo said."As can be

with few undecided voters, get-out-thevote strategies will become increasingly important to mobilise supporters and ensure they go to the polls on Election Day," he said. According to a new poll from Fox News, Harris has a slight lead over Trump in Georgia but trails behind in Arizona. In Georgia, Harris has 51 per cent of votes against Trump's 48 per cent, the poll said. However, in Arizona, as per the Fox News poll, Trump leads Harris by a similar margin. He has the support of 51 per cent against Harris' 48 per cent.According to Real Clear Politics, which tracks all major polls,

Alabama carries out second-ever nitrogen gas execution of convicted murderer

murderer Alan Miller on Thursday in the second-ever nitrogen-asphyxiation execution since the state pioneered the method in January.

Miller, 65, was convicted for the 1999 murders of three men, including two co-workers, in a shooting spree at two offices in Pelham, Alabama. His victims were Lee Michael Holdbrooks, Terry Lee Jarvis and Christopher Scott Yancy.Miller was taken into the execution chamber on Thursday evening at the Holman Correctional Facility in Atmore, and was pronounced dead at 6:38 pm, Alabama Governor Kay Ivey said in a statement. Alabama officials and journalists who witnessed the execution were due to speak at a press conference later in the evening.In January, Alabama executed

nitrogen asphyxiation, the first use of a new execution method since lethal injections began in the US four decades ago. The state called its new protocol "the most painless" execution method yet, and predicted that Smith would lose consciousness and suffocate within a few seconds of pure nitrogen flowing through an industrialsafety respirator mask strapped to his face. That did not happen. Multiple witnesses, including five journalists and members of Smith's family, saw Smith heaving against his restraints and convulsing as the nitrogen flowed, and it appeared to take him several minutes to lose consciousness. The administration of US President Joe Biden, a Democrat who promised to abolish the death penalty, said it was "deeply troubled" by the

senior UN human rights officials, who say it may amount to torture or cruel and inhuman treatment. Alabama has defended the method, with Attorney General Steve Marshall calling Smith's death a "textbook" execution. After Smith's execution, Miller sued Alabama over fears that its asphyxiation method could violate a constitutional ban on cruel and unusual punishments. He sought assurances that the mask would be properly fitted and that its seal be tested to ensure no oxygen seeps in, prolonging his death or even averting it entirely and leaving him alive with brain damage. His litigation ended in a confidential settlement. The Alabama Department of Corrections declined to say if it made any changes to its gassing protocol. Alabama has asphyxiation executions, saying they are a simpler alternative for states struggling to find lethal-injection drugs. Advocacy groups against capital punishment have long pressured pharmaceutical companies to forbid their drugs be used in executions, and have turned their attention to nitrogen suppliers and mask makers, including the maker of the Allegro Safety mask Alabama acquired for its executions. Stephanie Boucher, a spokesperson for Allegro parent company Walter Surface Technologies in Connecticut, said the company will not comment on the use of its masks in executions.A spokesperson for Canadian private equity firm Onex Corp ONEX.TO, which has a majority stake in Walter Surface, did not respond to requests for comment.

IISER to be established in Gandhinagar

Gandhinagar. State capital Gandhinagar is set to become home to the prestigious Indian Institute of Science Education & Research (IISER) in the near future. The Government of India (GoI) has recently granted approval for the establishment of the institute at Gandhinagar, with the remaining formalities and official announcement expected to take place within the next few weeks, top sources in the state govt said.

IISERs are a group of autonomous institutions established by the Union govt for teaching and research in natural science and to provide collegiate education in basic sciences integrated with research at the undergraduate level. Seven such institutions are presently operational in the

According to the sources, since the formation of IIT (Indian Institute of Technology), Gandhinagar in 2008, no major institution of national or international repute has been established in the city. "After a hiatus of more than a decade, the GoI has accepted the Gujarat govt's long-standing request to establish an Indian Institute of Science & Research. To fulfill the primary requirement of land, the Gujarat govt has proposed allocating a substantial parcel of govt land in close proximity to the National Institute of Design (NID), National Institute of Fashion Technology (NIFT), and the InfoCity in Gandhinagar. The state govt has also expressed its willingness to provide additional land near Gandhinagar if required," sources said.

Commenting on the GoI's in-principle approval for setting up an IISER in Gandhinagar, officials said that a majority of the investment will be borne by the GoI, while the state govt will provide the land free of cost. "The IISER will offer cuttingedge courses in pure sciences such as physics, biology and chemistry, as well as new-age courses. The institute will also undertake significant research activities for both academic purposes and potentially provide research services to industries within the state and across the country," said official sources.

These include gaming establishments that had obtained necessary NOCs, development permissions and building use (BU) permits from the concerned authorities before the date of the govt notification (Sept 5) and establishments that have already been constructed as per the approved plans and possess valid fire NOCs." The state govt issued the order under Section 122 of the Gujarat Town Planning and Urban Development Act.

Multi-level parking facility at Bengaluru's Gandhinagar metro station may shut over heavy losses

BENGALURU. The Bruhat Bengaluru Mahanagara Palike's (BBMP) multi-level parking facility at Gandhinagar, inaugurated under the 'Brand Bengaluru' initiative by Deputy Chief Minister and Bengaluru Development Minister DK Shivakumar, is facing significant challenges with Prince Royal Solution Pvt Ltd, the agency managing the facility since June 21, expressing its intentions of withdrawing the same due to mounting losses.



Kumar HN, who runs the agency said that he has written at least eight representations to the BBMP Chief Commissioner, appealing to

reduce rentals and wave off power bills due to low occupancy rates, which is contrary to BBMP's promises. "We paid Rs 1 crore security deposit after securing the 5-year contract. Every four months, we are supposed to pay Rs 48 lakh as rent. So far, we have incurred a loss of Rs 64 lakh," said

The agency highlighted that the BBMP had initially estimated around 80 per cent occupancy at the multi-level parking facility in which 600 four-wheelers and 750 accommodated. Additionally, it had also assured that no parking would be permitted within a 500metre radius of the parking facility, but these promises have fallen flat."There is hardly 10 per cent occupancy. To remove unauthorised vehicles parked in the surrounding areas, we have been paying Rs 7,500 daily for towing charges and staff, adding an additional Rs 4.5 lakh in losses. In August alone, we collected Rs 3.38 lakh but ended up paying Rs 56,000 to cover up 18 percent of GST. On the whole, we have incurred a loss of Rs 64 lakh so far, making it impossible for us to pay the salaries of 46 employees," he added. An official from the agency stressed that, if the Palike reduces rentals and waives off power bills (as BESCOM has threatened to cut off power supply), the facility can be run, else the agency will be forced to close down the business and take legal measures to recover its losses. Meanwhile, in an effort to offset the losses, the agency has proposed to the BBMP of running a restaurant in the basement.

Land acquisition process for Bengaluru metro Phase-3 kickstarts afresh

BENGALURU. With the land acquisition process for the 44.65-km Phase-3 line of the Metro being abruptly stalled earlier this month, due to the need to incorporate doubledecker flyovers along the route, the Bangalore Metro Rail Corporation Limited (BMRCL) restarted the process again on Wednesday. The preliminary notification to acquire 299 properties for one stretch on the Outer Ring Road Line has been submitted to the Karnataka Industrial Areas Development Board (KIADB).

The Rs 15,611-crore project comprises two elevated corridors - the 32.15-km ORR Line, from JP Nagar IV Phase to Kempapura; and the 12.5-km Magadi Road corridor, from Hosahalli to Kadabgere. The Union Cabinet gave the green signal on August 17.

In the case of package-3, we plan to issue the preliminary notification for acquisition under 28(1) of the Land Acquisition Act, next week. Land acquisition is yet to begin for the Magadi Road corridor. The line has a deadline of 2028, and is expected to carry 9.12 lakh passengers by 2051.

Metro mess: Subway flooded, station roof leaks; citizens slam Aarey, Jogeshwari chaos



MUMBAI. A flooded subway near the Aarey Metro car shed and rainwater leaking through the roof of the Jogeshwari Metro station on the Western Express Highway during Wednesday's torrential rain sparked widespread criticism

The flooding at the Aarey subway led to questions being raised about the construction of the Metro 3 car shed in an area which environmentalists said was a crucial green lung of the city.

Tasneem Shaikh, a resident of Jogeshwari-Vikhroli Link Road, said that the water currents were so strong that the subway, which abuts the Metro Line 3 car shed, was closed by sunset. "It was completely flooded and stayed shut all night. People had a tough time trying to navigate through the strong currents," she said.

Aarey Conservation activist Amrita Bhattacharjee said the water currents were so strong that a person on a scooter fell into the waters.

"Luckily, he was rescued by others, but then his scooter got stuck in the culvert," she said.

The leaking of Jogeshwari Metro station roof led to many on social media calling out Mumbai Metropolitan Region Development Authority (MMRDA) for poor construction.

The second phase of Metro Line 7 and 2A (Gundavali-Dahisar-Andheri West) was inaugurated by Prime Minister Narendra Modi on Jan 20, 2023, following the opening of the first phase by then chief minister Uddhav Thackeray on April 22, 2022.

In response to the backlash, Maha Mumbai Metro Operation Corporation Ltd (MMMOCL) issued an apology on X (formerly Twitter), stating: "We sincerely apologise for the water leakage at the metro station. This occurred due to heavy rains that dislodged storm water pipes in some areas because of excessive water pressure. Geopolitical challenges keeping India on its toes

INDIA is recognised as the fastest-growing major economy in the world. The International Monetary Fund's assessment is that India's economy will grow at a rate of 7 per cent this financial year. Even as the country looks to maintain the growth momentum, it must be borne in mind that its position and influence in the world will be determined largely by its economic and technological progress. Given these imperatives, India has little choice but to strengthen its ties with countries in its immediate neighbourhood. This would ensure security and peace in the area extending from the Red Sea and Persian Gulf to its west to the Strait of Malacca to its east. The main challenges India faces beyond its borders arise from the expansionist ambitions and policies of China, even as Pakistan is mired in virtually perpetual bankruptcy. India has also sought for long to develop closer ties with the oilrich (Persian) Gulf Region, comprising Iran and the Arab nations, where around six million Indians live. India has built good ties with Saudi Arabia while simultaneously reinforcing its strong relations with the UAE. Delhi also played an important role in restoring a cordial working relationship between the US and Saudi Arabia after intemperate comments made by President Joe Biden about the Saudi monarchy were resented by the Saudis. The national security adviser of the UAE, Sheikh Tahnoon bin Zayed Al Nahyan, also participated in talks between US National Security Adviser Jake Sullivan and Saudi Arabia's Crown Prince, Mohammed bin Salman. The talks were reportedly facilitated by India's National Security Adviser, Ajit Doval. An agreement for promoting cooperation between the UAE, the US and India was also reportedly finalised and signed shortly thereafter. The stage is now set for India to play an increasingly positive and cooperative role across the shores of the Indian Ocean, together with six Arab Gulf states.India-US relations have grown significantly amid Washington's expectations that Delhi can balance out the growth of Chinese power across the Indian Ocean. China's policies remain committed to limiting and containing Indian influence. Beijing continues to strengthen Pakistan's missile and nuclear capabilities. It also works in close collaboration with Pakistan along and across India's western border with Afghanistan. New Delhi's recent moves for strengthening ties with Iran, including the construction of the strategic Chabahar Port, give India increasing economic and maritime access to Central Asia and limit the space for Pakistan to hinder India's access to Afghanistan. While the US had objected to India's growing ties with Iran, it now appears reconciled to Delhi going ahead with the project for a transport corridor linking it to Afghanistan and Iran. Pakistan is predictably not pleased with this corridor, as it prevents Rawalpindi from hindering India's access to Afghanistan, Iran and Central Asia. This corridor, thereafter, can become a key gateway for India's access to the International North-South Transport Corridor, which, in turn, would eventually link India to Central Asia, Russia and,

ultimately, to Europe by sea, rail and road. One important factor that has cast a shadow on India-US relations is the constant criticism by the US media of alleged violation of human rights in India, evidently with some encouragement from Washington. India may be among the few countries whose leadership found then President Donald Trump to be friendly - but blunt during his visit to India. Trump has no illusions or expectations about China and has little inclination to even think about Pakistan. India can be confident that this relationship will grow, irrespective of whether Kamala Harris or Trump wins the upcoming presidential elections. Nevertheless, relations with the US have grown steadily, with considerable cooperation for strengthening maritime links. This is an important development amid the tensions and piracy in the high seas - across the Indian Ocean — that have been accompanied by the Israeli occupation of Gaza.

The path to simultaneous elections is dotted with hurdles

Elections are an essential requirement for the operationalisation of democracy. Do we wish to merely go through the motions of holding elections?

The Union Cabinet has accepted the Ram Nath Kovind Committee report on 'one nation, one election' (ONOE). Union Minister Ashwini Vaishnaw, who announced the decision, also laid out an action plan, starting with the drafting of a Constitution Amendment Bill that will presumably amend several Articles. This ambitious and complicated Bill has to be drafted and presented in Parliament first. Then, it must be passed in each House by a special majority (more than 50 per cent), with twothirds of the members present and voting.

The Bill, if and when approved by Parliament, will then have to be ratified by the legislatures of half of the states by a simple majority, that is, by a majority of the members of the House present and voting. This is needed because it will seek to amend some critical provisions of the Constitution. If and when all of the above happens, the Bill will need the President's assent. How long will all this take is anyone's guess. This reminds one of the Women's Reservation Act, called Nari Shakti Vandan Adhiniyam, which was passed as the 128th Constitutional Amendment Bill, 2023, reserving onethird of the seats for women in Lok Sabha and state Assemblies. It received the President's assent on September 29, 2023. Amid the fanfare, most laypersons believed that the 2024 General Election would see 33 per cent women members in the Lok Sabha. However, when that did not happen, many read the fine print to discover that this law would be implemented only after the next delimitation exercise that first required a census to be held. As the 2021 census has not been held so far, when this Act will be implemented is not known.

The same fate awaits the ONOE proposal. It has been reported that LK Advani mentioned in a blog in May 2010 that there should be simultaneous elections. It was included in the BJP's election manifesto in the 2014 Lok Sabha election. From 2015 to 2018, there was hectic activity about this proposal, but after 2018, the matter seemed to have gone into cold storage. Then, on September 2, 2023, the Kovind Committee was formed. A committee that has such an obvious political intent being headed by a former President was a novelty in itself. This committee submitted its report on March 14, 2024. This report was accepted by the Cabinet on September 18.

Three main reasons have been given for recommending ONOE: recurring poll expenses, suspension of development works due to the imposition of the Model Code of Conduct (MCC) and neglect of governance because ministers get involved in campaigning.

The argument that ONOE will result in significant saving of money that can be used for development works is antidemocratic. I have three questions: Are democracy and development mutually exclusive? Can we have either



one or the other? Do we want the most effective democracy or the cheapest possible?

Elections are an essential requirement for the operationalisation of democracy. Do we wish to merely go through the motions of holding elections and provide a formal stamp of people's approval without them necessarily expressing their true opinion? Democracy has a cost and it will be a sad day when India concludes that it cannot afford to pay the cost of democracy and decides to have the least expensive or cheapest democracy. Anyone who has read the MCC would know that all it says is that the government cannot introduce new schemes which may have the potential to influence the election result. If there are some new schemes that the government feels must be initiated, the MCC has a provision for that — the government can seek clearance from the Election Commission. The MCC does not prohibit the continuance of ongoing development schemes. The question of governance suffering because ministers get busy campaigning is baffling. Two issues need to be highlighted in this context. One, political parties, particularly those in power at the Centre and in the states, have a large membership. Therefore, there should be no dearth of effective campaigners. It follows that it should be possible to easily exclude ministers from responsibilities for campaigning during elections.


The second issue is that those who become ministers take an oath of office in which they swear to discharge their responsibilities to the best of their ability. It follows that

if they neglect their executive or ministerial responsibilities in favour of campaigning, they are violating their constitutional oath, hich should make them liable for prosecution.

What makes the dream unrealisable is the simple fact of the existence of the Basic Structure Doctrine of the Constitution, laid down by a 13-Judge Bench of the Supreme Court (SC) in the landmark Kesavananda Bharati judgment pronounced on April 24, 1973. The essence of the doctrine is that while Parliament has the right to amend the Constitution under Article 368(1), it does not have the right to amend what the SC called the Basic Structure. The elements comprising the Basic Structure have been laid down in the Kesavananda judgment itself and have been added in some subsequent judgments. One constant element in all such judgments is the federal character of the Constitution. The Constitution has separate sections/chapters titled 'The Union' and 'The States'. Each of these two entities, therefore, has separate and independent constitutional existence, which includes electoral dynamics. Forcefitting all these dynamics into one is a clear violation of the federal character of the Constitution, and is therefore a violation of its Basic Structure. Even if Parliament and the required number of states approve amendment to some Articles of the Constitution - and the President gives assent to that - it can still be challenged by concerned citizens in court for violation of the Basic Structure and will be subjected to a judicial review.

Lessons from the southern surge

Laggard states must focus on economic development rather than political brinkmanship

IT was in the 1990s that the trend of new industrial projects moving southwards gained ground. Hyundai and Ford set up factories in Tamil Nadu soon after the liberalised regime for foreign direct investment was rolled out. This territory was far away from the large passenger car markets of the National Capital Region. But global car companies were prepared to incur high freight costs rather than set up plants in northern states. This was followed by the information technology revolution, which centred around the capitals of Karnataka and then undivided Andhra Pradesh. Bengaluru and Hyderabad became the preferred locations for Big Tech to set up huge campuses. Even fledgling Indian IT companies like Infosys and Wipro established their bases in these states. The result was an influx of software professionals to these IT hubs and the creation of what is now considered India's Silicon Valley in Bengaluru.By now, it is accepted wisdom that southern states are the natural home of hi-tech industries and that overall growth is also better in this region than in the more densely populated northern and eastern states like Uttar Pradesh, Bihar, Punjab and West Bengal. The fact that states like UP accounted for a big chunk of the country's GDP in the 1960s has been forgotten over the years. It has taken a working paper by the Prime Minister's Economic Advisory Council on states' relative development to highlight the fact that these regions lost their preeminence over the past six decades. The study has focused on the relative performance of states from 1960-61 to 2023-24. It has used two indicators — the share of India's GDP and relative per capita income. This has shown wide variations in development

For instance, in the northern region, the paper has

indicators over this period.

Haryana. The former's share of the GDP rose to reach 4.3 per cent in the 1960s, apparently due to the Green Revolution. It declined to only 2.4 per cent in 2023-24. Haryana's share now exceeds that of Punjab, and the per capita income has reached 176.8 per cent of the national average in 2023-24 compared to the larger state's 106.7 per cent. The study raises the

question of whether the focus on agriculture hindered the transition to industrialisation for Punjab. But the same phenomenon could have occurred in Haryana, which was also part of the Green Revolution. Clearly, aggressive policies to attract investments that led to the creation of the corporate hub in Gurugram have made a difference. As for the western region, primarily Maharashtra and Gujarat, it saw consistent growth even prior to 1991, according to the paper. One of the historical factors in the case of Maharashtra is the fact that it developed around Mumbai, which was a key colonial outpost and emerged as the country's financial capital. Favourable commercial policies continued after Independence, ensuring that the west coast became an

industrial hub with many of the so-called Bombay Club industrial houses located there. The discovery of oil in the Bombay High offshore region in the 1970s fuelled the establishment of refineries and ancillary industries. Gujarat, too, benefited from being close to offshore gas fields that led to the proliferation of small and medium industries using the fuel as feedstock. State government policies were also consistently industry-friendly, whether it was the Congress or the BJP in power.

highlighted the divergent growth paths of Punjab and In contrast, West Bengal, with similar advantages of

being a major commercial hub in colonial times, has exhibited a sharp deterioration in economic performance. The paper finds that it held the third largest share of the national GDP at 10.5 per cent in 1960-61 but now accounts for only 5.6 per cent. The relative per capita income has fallen from 127.5 per cent to 83.7 per cent. The reasons for the decline have



to be found in policies of various state governments over six decades. This includes the Left Front, which was in power for 34 years of the period under review. Though the front has been lauded for carrying out land reforms, it cannot escape blame for the slow pace of growth. The Trinamool Congress took charge in 2011, but it has not been able to reverse the declining trend.Regarding Uttar Pradesh, the paper describes it as being the largest economic powerhouse in 1960-61 with a 14.4 per cent share in the country's GDP. The decline began even after Uttarakhand was carved out

of UP, and the share is now only 8.4 per cent. Similarly, Bihar presents a dismal picture, with the relative per capita income dropping from 70.3 per cent in 1960-61 (when it was undivided) to 33 per cent. For both UP and Bihar, it cannot be denied that the decline in relative economic performance has to be laid at the door of successive governments.

> On the other hand, the southern states, which did not show exceptional performance prior to 1990-91, surged ahead later. Governments of these states tailored their incentives for fresh investments to make productive use of liberalised economic policies. As a result, by 2023-24, Karnataka, Andhra Pradesh, Telangana, Kerala and Tamil Nadu together accounted for about 30 per cent of India's GDP. In addition, the per capita income of all southern states became higher than the national average after 1991.

This data shows that som states used the 1991 reforms and liberalisation policies as a springboard to attract

both domestic and foreign investment. Others failed to take advantage of the opening up of the economy. The result has been the creation of vast regional disparities, with western and southern states racing towards affluence while central and eastern states still have large swathes mired in poverty. It is not too late, however, for laggard states to learn lessons in effective governance. The study is a timely reminder for them to recognise that the focus must be on economic development rather than political brinkmanship. "It's the economy, stupid," an American catchphrase, fits perfectly here.





"All In The Air": Supreme Court Comes Down Heavily On Delhi Air Quality Panel

New Delhi: The Supreme Court came down heavily on the central air quality panel on Friday for not taking adequate steps to monitor the air quality and curb pollution in the national capital region. The Commission for Air Quality Management (CAQM) did not form any committee for monitoring the air quality, contended a bench of Justices Abhay S Oka and AG Masih."There has been total noncompliance of the Act. Have committees been constituted? Please show us a single step taken, which directions have you used under the Act? Just see the affidavit. Show us a single direction issued under S 12 and others," said Justice Oka."It is all in the air, nothing they have showed as to what they have said to the NCR States," he added.

Towards the end of the hearing, the bench noted that it cannot be said that the CAQM did not take any action, but they did not perform the way they were expected to.Come winter, the NCR plunges into a severe air quality crisis every year, with stubble burn in the neighbouring states of Haryana and Punjab among the major contributors.On being informed by CAQM chairman Rajesh Verma that they meet once

Heavy rain pounds Mumbai, red alert issued, showers to continue throughout week

NEW DELHI. The Indian Meteorological Department (IMD) has issued warnings for heavy to very heavy rainfall across Mumbai and Maharashtra, with significant impacts expected over the coming days. Following the recent trend of erratic monsoons, Mumbai is bracing for widespread rain, particularly in the Konkan region, which is anticipated to experience intense downpours today. According to the latest bulletin by the Met Department, a cyclonic circulation lies over north-central Maharashtra, and, under its effect, Maharashtra is expected to witness more downpour in coming days. Heavy rain lashed out at several places in Mumbai

today. The IMD has issued a red alert for Nashik, while orange alerts have been placed for Palghar, Pune, Nandurbar, and Dhule. Additionally, nearly every city in Maharashtra is under a yellow alert for the day.

The Brihanmumbai Municipal Corporation predicted a generally cloudy sky over Mumbai today, with chances



of moderate rain and thundershowers across the city and suburbs. According to the weather department, the Konkan and Goa region, along with central Maharashtra, is likely to see fairly widespread light to moderate rainfall throughout the week. However, September 27 is marked as a critical day, with heavy

rainfall expected to occur in isolated locations. The IMD predicted that some areas could receive more than 12 centimetres of rain. The weather department also predicted light to moderate rainfall in most areas of north central Maharashtra, many parts of south central Maharashtra, and a few locations in Marathwada. The IMD further stated that from September 28, the risk of heavy rainfall will extend to various parts of central Maharashtra and Gujarat. With isolated heavy rain projected for these regions, officials are urging residents to remain cautious and prepared. The agency has also highlighted a moderate flash flood risk for

several watersheds, especially in the south Gujarat region and the coastal areas of Konkan and Goa.Residents are advised to avoid unnecessary travel during periods of heavy rainfall. Local authorities are monitoring the situation closely, ready to respond to any emergency that may arise due to flooding.

Who flooded Waqf Bill JPC's mailbox with millions of feedback?

New Delhi: The joint parliamentary committee (JPC) scrutinising and holding consultations over the Waqf (Amendment) Bill has received overwhelming feedback, triggering a controversy. Panel member and BJP MP Nishikant Dubey questioned the origins of the "unprecedented" 1.25 crore suggestions sent to the JPC, and sought a probe into the possible role of a "foreign hand". The All India Muslim Personal Law Board (AIMPLB) and the Congress both lashed out at Dubey, and called the massive response normal in a country as populous as India.In fact, the AIMPLB BJP MP SEEKS PROBE INTO told India Today Digital that the number of 1.25 crore was a gross understatement, and that 3.7 crore suggestions were sent to the JPC on its appeal.On August 8, the government introduced the Waqf (Amendment) Bill, 2024, in the Lok Sabha, saying that the law was aimed to streamline the Waqf Board's work and ensure the efficient management of Waqf properties.It was immediately sent to a

joint parliamentary committee after Opposition parties and Muslim organisations expressed concerns, claiming that the bill was a targeted measure against the community and an

infringement on its constitutional rights.The JPC had in August invited views and suggestions from the public, NGOs, experts, stakeholders and institutions on the law that the NDA government had proposed to change the Waqf law. It gave a 15-day window for people to send in their feedback.

'UNPRECEDENTED' RESPONSE

The JPC might not have expected such a massive response to its invitation for suggestions.The contentious issue saw mobilisation from both sides and crores of emails landing up with the parliamentary panel. Nishikant Dubey, in a letter to Jagdambika Pal, chairman of the JPC on the Waqf (Amendment) Bill, has now sought an investigation by the Union home ministry into the origin of the feedback to the parliamentary panel, reported news agency PTI.Dubey, a four-time MP, said



the number of submissions was "unprecedented" and had set a global record for legislative submissions. He alleged the possibility of the involvement of China or Pakistan's spy agency ISI or other fundamentalist organisations. He also named wanted Islamist preacher Zakir Naik among the suspects.Dubey wrote it was essential to ask whether foreign entities, organisations, and individuals may be deliberately

orchestrating this "flood of responses to manipulate the democratic process".

NOT 1.25 CRORE, BUT 5 CRORE SUGGESTIONS SENT, SAYS AIMPLB

Swiggy's plan to go public comes at a time when investors are showing confidence in new age companies. Shares of Swiggy's rival Zomato have gained more than 184% in the last one year. Backed by Japan's SoftBank investment major Prosus, Swiggy competed against Zomato in India's fast growing online restaurant and food delivery market. India's food delivery market is estimated to grow to Rs 2 lakh crore by 2030, as per industry estimates. Swiggy and Zomato together commanding over 90% of this market.

Prosus with 32% stake is among the leading stakeholder in the company. SoftBank, Accel, Elevation Capital, DST Global, Norwest, Tencent, Qatar Investment Authority (QIA) and Singapore's GIC are other shareholders in Swiggy. The Bengaluru-based company was valued at \$10.7 billion when it last raised funds in January 2022. Market experts believed that Swiggy can list with a market valuation of around \$10-14 billion.

OMCs can reduce petrol, diesel prices by Rs 2-3: ICRA

NEW DELHI. Oil marketing companies (OMCs) could reduce petrol and diesel prices by Rs 2-3 per litre if the international crude prices remain stable, according to a report by ICRA. The rating agency noted that the recent decline in crude oil prices has improved margins on retail auto fuels, allowing state-owned companies to consider price cuts. The average price of India's crude oil imports fell to \$74 per barrel in September, down from \$83-84 per barrel in March, when petrol and diesel prices were last reduced by Rs 2 per litre.

"ICRA estimates that the OMCs' net realisation was higher by Rs 15 per litre for petrol and Rs 12 a litre for diesel vis-a-vis international product prices in September 2024 (till September 17).

The retail selling price (RSPs) of these fuels have been unchanged since March 2024 (Rs 2/litre was reduced on



petrol and diesel on March 15, 2024) and there appears to be headroom for their downward revision by Rs 2-3 per litre, if crude prices remain stable," said Girishkumar Kadam, Senior Vice President and Group Head, Corporate Ratings, ICRA. The last revision in fuel prices took place in March, with a Rs 2 per litre cut for both petrol and diesel. Crude prices have seen a significant drop in recent months, primarily due to weak global economic growth and high US production.

Extensions and reappointments should be concluded and announced well ahead avoiding last minute delays. Mumbai. "This becomes relevant especially for the financial markets that seek signals around policy continuity, she said. The RBI's policy committee is made up of three external members usually well-known economists from the academic or finance worlds — and three RBI officials, comprising the governor, the deputy governor in charge of the monetary policy, and another official, typically the executive director of the monetary policy department. Das's contract — already extended once by three years - comes to an end on December 9 and Patra finishes his term on January 14. Neither the government nor the RBI have signaled if they will remain in their posts. MPC doves

Before the MPC was appointed in 2016, interest rates were decided by the governor alone. While policymaking is more consensus-based now, the governor still has veto power to break a deadlock in the six-member MPC.Change in the leadership of the RBI can bring sweeping monetary policy shifts. Urjit Patel, who was RBI governor before Das took over in December 2018, was a policy hawk, rejecting calls to cut interest rates even when inflation tumbled to a record low of 1.46% in June 2017. In Das's first MPC meeting in February 2019, he promptly cut rates in a surprise move.Das is now facing calls to cut interest rates as global central banks pivot and the economy shows signs of moderating. The governor has repeatedly said he's not considering a cut yet and wants to see inflation easing to the 4% target and staying there. If the new MPC members are appointed before the October MPC meeting, analysts don't expect they will have enough time to acquaint themselves with the issues to call for a rate cut. Economists surveyed by Bloomberg predict the RBI will likely ease in December.

According to brokerage firm Nomura, the Indian IT industry is likely to see growth bottom out in FY25. The firm anticipates a gradual recovery in discretionary spending, although it may take a few more quarters for a full rebound.

Nomura predicts revenue growth for large-cap Indian IT companies to improve significantly in FY26, forecasting a 7.9% year-on-year



of Rs 1,974.60 on the National Stock Exchange, making it one of the top gainers on the Nifty index.Other IT firms, including Coforge, Wipro, LTIMindtree, and Tech Mahindra, also saw gains of up to 4%. Motilal Oswal, in its recent analysis, expressed minimal concern about short-term revenue fluctuations for Indian IT companies in

the upcoming quarter, believing that these variations are unlikely to affect market estimates or valuations significantly.

The brokerage said that the sector's critical catalyst will come after Q3 FY25, when corporate client budgets for calendar year 2025 are finalized, providing a clearer picture of demand. Accenture's report highlighted 2% year-on-year growth in FY24, including a 3% contribution from inorganic acquisitions. The company's outlook for consulting and outsourcing services suggests further growth, a development that is

particularly positive for Indian IT firms, as it signals a recovery in discretionary spending.Dr. V.K. Vijayakumar, Chief Investment Strategist at Geojit Financial Services, noted that Indian IT stocks are expected to respond positively to Accenture's strong guidance, suggesting potential gains for the sector in the near future.

"As we reenter the field of neuropsychiatry, we are dedicated to changing the conversation around serious mental illness, beginning with today's approval for schizophrenia."Bristol Myers Squibb plans to make Cobenfy, a twice-daily pill, available by late October. The drug will cost \$1,850 per month, or \$22,500 annually, before insurance and rebates. Schizophrenia affects around 2.8 million people in the United States, impacting how they think, feel, and behave. Symptoms of Schizophrenia usually appear in early adulthood



and vary greatly among individuals, making the condition hard to diagnose and manage. Current treatments can be effective, but up to 60% of patients find them inadequate or experience intolerable side effects.

"For people living with schizophrenia, it's often difficult to find a treatment that works for them. Having a variety of treatment options gives patients and healthcare providers the tools to help manage this serious condition," said Gordon Lavigne, CEO of the Schizophrenia & Psychosis Action Alliance. Government to borrow Rs 6.61L cr in H2, maintains target

NEW DELH. The Centre has retained its borrowing target for the current financial year as it announced its Rs 6.61 lakh crore borrowing plan for the second half of the financial year. The government borrowed Rs 7.4 lakh crore in the first half out of the gross market borrowing of Rs 14.01 lakh crore estimated for 2024-25.As per the Centre, out of

Gross Market borrowing of Rs 14.01 lakh crore budgeted for 2024-25, Rs 6.61 lakh crore (47.2%) is planned to be borrowed in second half of the year through issuance of dated securities, including Rs 20,000 crore of Sovereign Green Bonds. The government said it will continue to reserve the right to exercise greenshoe option to retain an additional subscription of up to Rs 2,000 crore against each of the securities indicated in the auction notifications. In the third quarter of FY25, weekly borrowing via issuance of Treasury Bills is projected to reach Rs 19,000 crore over a span of



crore from 91-day dated Treasury Bills (DTBs), Rs 6,000 crore from 182-day DTBs, and Rs 6,000 crore from 364day DTBs.To manage temporary discrepancies in government accounts, the Reserve Bank of India has set the Ways and Means Advances (WMA) limit for the second half of FY 2024-25 at Rs 50,000 crore. Of the total estimated gross market borrowing of Rs 14.01 lakh crore for 2024-25, Rs 7.4 lakh crore, accounting for 52.8%, has already been raised in the first half of the fiscal year. It is to be noted that the gross borrowing for FY25 is lower than

Swipe, spend, struggle: How credit card defaults are spiking in India

Once a symbol of freedom, credit cards now trap young Indians in growing debt. Could defaults be the new norm?

NEW DELHI. India's credit card boom has reached a tipping point. While credit cards were once seen as a symbol of financial freedom and convenience, they are now pushing many young Indians into a growing debt trap. Defaults on credit card payments have surged, particularly among millennials and Gen Z, despite growing awareness of credit

The growing popularity of Buy Now, Pay Later (BNPL) schemes, EMI-based ecommerce purchases, and easy access to credit have made the situation even more precarious. In the first half of 2024, credit card defaults climbed to 1.8%, up from 1.7% at the end of 2023, according to data

from TransUnion CIBIL. While a 0.1% rise might seem negligible, the real concern lies in the mounting outstanding dues. Credit card outstanding amounts hit an alarming Rs 2.7 lakh crore by June 2024, compared to Rs 2.6 lakh crore in March. This marks a massive jump from Rs 87,686 crore in March 2019, representing a compound annual growth rate (CAGR) of 24% over five years

Youth at greater risk of default

The most concerning aspect is the behaviour of young millennials and Gen Z, who are driving this surge in credit card defaults. Sold on the convenience of EMI-based purchases and BNPL schemes, many young borrowers are maxing out their credit limits without How defaults spiral out of control even attempting to revolve their loans.A recent report by Macquarie Capital indicated that most young millennials are using the entire limit and directly defaulting, turning into an NPA without even revolving the loan. The report said net credit losses for credit cards have surged to 5-6%. E-commerce platforms like Amazon have fuelled this spending



frenzy, with the majority of transactions made through credit cards. Experts suggested that the rise of BNPL and attractive EMI schemes on e-commerce platforms are directly contributing to higher credit card spending among the

The path to default often starts innocently enough, typically with a large purchase the borrower plans to pay off in easy installments. However, those seemingly manageable payments come with steep interest rates that can climb as high as 48% annually. As the debt balloons, many borrowers find themselves able to pay only the minimum due each month,

trapping them in a cycle of accumulating

interest and worsening debt. A common misconception about credit scores adds fuel to the fire. Many borrowers believe they're financially stable as long as they continue making minimum payments, which temporarily prevents them from being marked as defaulters. However, as interest continues to compound, the financial strain intensifies, turning the situation into a downward spiral.RBI's wake-up call goes ignoredIn response to the rapid surge in credit card defaults, the Reserve Bank of India (RBI) has flagged concerns over the growing risk in unsecured loans.Retail lans, driven largely by personal loans and credit card debt, have been the backbone of Indian banking growth for two decades. However, as the demand for unsecured loans has risen, so have the risks. The RBI increased risk weights on unsecured consumer credit in late 2023, forcing banks to set aside more capital to cushion against potential losses. The RBI's measures appear to be working. Virat Kohli faces more pressure than Smith, Root and Williamson: Parthiv, Tamim

New Delhi. Parthiv Patel and Tamim Iqbal has claimed that the rest of the Fab four don't face the same pressure as Virat Kohli. The fab four has been a collection of Kohli, Joe Root, Steve Smith and Kane Williamson, who have been considered as the greats of the modern generation. Compared to the three, Kohli hasn't had the best of times in Tests as he has scored just 2 fifties and 2 hundreds since 2023. Before the start of the Kanpur Test, Parthiv and Tamim was asked if Kohli has been facing pressure in recent times. The former wicketkeeper said that he doesn't feel pressure while playing and Smith, Root and Williamson don't go through what the Indian star is going through.Parthiv feels that the pressure of expectation is huge for Kohli because of the standard he has set for himself."I don't think he's feeling that kind of pressure. And as you rightly mentioned that, I don't think Smith or Joe Root or Williamson can even think of the type of pressure he must be feeling.'

"The pressure of expectation, that is huge. He has set his standard so high that even if he



scores 60 or 70, that comes across as a failure. Because every time he walks in, we expect him to score 100. We expect him to play with that kind of intensity, which he has always been playing," said Parthiv.Parthiv said that the hunger to perform will remain in Kohli as long as he is playing Tests.

"But you have to understand that he is also getting older but that zeal to play Test cricket and to do well, does not die, and it will never die is as long as Virat Kohli is playing Test cricket. But yeah, I think I don't think he would be feeling that kind of pressure to

perform. But the expectation of us is always high because of the standard which he has set," said Parthiv.

Kohli has won games single-handedly in white-ball cricket

Tamim pointed out to white-ball cricket records of the Fab 4 and claimed that Kohli had won more games for his side single-handedly compared to Smith, Root and Williamson. And also, I think yes in Test match cricket, the Fab 4 that we are talking about have done wonders. Because in Test match

cricket, basically as a batter, you can't win a game single-handedly. There are two innings and everything."

"But we also call them Fab 4 in white-ball cricket and hands down, in what Kohli has done for India, amount of games that he has won single-handedly, I'm pretty sure none of the other three has won that many of the games. And as you mentioned because of the amount of pressure that he goes through, I think those three combined do not have the similar pressure," said Tamim.

India become first team to win toss and bowl first in Kanpur Test in 60 years

New Delhi, The Test series between India and Bangladesh seems to be defying the norms of Test cricket in India. After Bangladesh became the first team in 42 years to win the toss and opt to bowl at the MA Chidambaram Stadium in Chennai, India ended a 60-yearlong wait in Kanpur. At Green Park, Rohit Sharma won the toss and opted to field on Friday, September 27, against Bangladesh. After an hour's delay due to a wet outfield and overnight rain, Rohit Sharma and Najmul Hossain Shanto walked out for the toss. Rohit did not hesitate to bowl as the conditions were overcast and the curators left a patch of grass on the pitch. A total of 24 Tests have been played at one of India's traditional venues, and only two teams have opted to field after winning the toss. An Indian team led by Mansur Ali Khan Pataudi won the toss and opted to field in Kanpur and India snatched a draw after being made to followon. Dilip Sardesai's 79 in the first innings helped India post 266 in response to a mammoth England total of 559 for 8

Barry Knight and Peter Parfitt hit hundreds for England in the first innings. India were asked to follow on and they came up with a better effort in the second innings.
