Congress demands Nirmala Sitharaman's resignation over FIR in electoral bond case

New Delhi, Sep 29: The Congress launched a sharp attack on the Bharatiya Janata Party (BJP) on Sunday, demanding the resignation of Union finance minister Nirmala Sitharaman after a case was registered against her in connection with the nowscrapped electoral bonds scheme. The opposition party accused Sitharaman of "undermining democracy" and called for a Supreme Court-monitored inquiry into the controversial scheme through a Special Investigation Team (SIT). 

The Congress also reiterated its call for a thorough investigation into the electoral bonds scheme, which was struck down by the Supreme Court earlier this year. The apex court ruled that the scheme violated the right to information and freedom of speech, posing a threat to free and fair elections in the country. "The Finance Minister cannot do this on her own. We know who is number 1 and number 2 and this was done on whose directions," Singhvi said. "The larger issue is the level playing field which is nec-

essary for free and fair polls. Free and fair polls are critical for democracy. This is an attack on our democratic system," Singhvi said while terming it as "EBS - Extortionist BJP Scheme".

Govt mulls 3 Bills to implement 'one nation, one election' plan

New Delhi, Sep 29: The proposed first constitutional amendment bill would deal with making provisions for holding Lok Sabha and state legislative Assembly electogether. Representative

image/iStock The government is likely to bring three bills, including two to amend the Constitution, to put in place its plan to hold simultaneous elections. One of the proposed Constitution amendment bills, that deals with aligning the local bodies elections to that of the Lok Sabha and the Assemblies, will require an endorsement from at least 50 per cent of the states. Moving ahead with its 'one nation, one election' plan, the government earlier this month accepted the recommendations of the

high-level committee for holding simultaneous polls for the Lok Sabha, state Assemblies and local bodies in a phased

manner after a countrywide consensusbuilding exercise. The proposed first constitutional amendment bill would deal with making provisions for holding Lok Sabha and state legislative Assembly elections together. Citing recommendations of the



posed bill would seek to amend Article 82A by adding sub-clause (1) relating to the 'appointed date'. It will also seek to insert sub-clause (2) to Article 82A relating to the islative assemblies together. It also proposes to amend Article 83(2) and insert new sub-clauses (3) and (4) relating to the duration and dissolution of the Lok Sabha. It also has provisions related to the dissolution of the legislative Assemblies and

amending Article 327 to insert the term "simultaneous elections". This bill will not require ratification by at least 50 per cent of the states, the recommendation said. The proposed second Constitutional amendment bill will require ratification by at least 50 per cent of the state assemblies as it will deal with matters relating to state affairs. It will seek to amend constitutional provisions relating to the preparation of electoral rolls by the Election Commission (EC) in consultation with State Election Commissions (SECs) for elections to local bodies. Constitutionally, the EC and SECs are separate bodies. The EC holds elections to the post of the President, the Vice President, Lok Sabha, Rajya Sabha, state Assemblies and state legislative councils while the SECs are mandated to conduct

polls to local bodies such as municipalities

end of terms of the Lok Sabha and state leg- Constitution amendment bill will also create provisions to hold simultaneous elections to municipalities and panchayats, along with elections to Lok Sabha and state legislative Assemblies by inserting a new Article 324A. The third bill will be an ordinary one to amend provisions in three laws dealing with Union territories having legislative Assemblies - Puducherry, Delhi and Jammu and Kashmir - to align the terms of these Houses with other legislative Assemblies and the Lok Sabha as proposed in the first constitutional amendment bill. The statutes it proposes to amend are the Government of National Capital Territory of Delhi Act-1991, the Government of Union Territories Act-1963 the Jammu and Kashmir Reorganisation Act-2019. The proposed bill will be an ordinary legislation not requiring a change in the Constitution and will also not need ratification by the states. The high-level committee had proposed amendments to three Articles, insertion of 12 new sub-clauses in the existing articles and tweaking three laws related to Union Territories having legislative and panchayats. Article 370 can be restored only by Central govt: Ghulam Nabi Azad

Bani/Jammu, Sep 29: Democratic Progressive Azad Party chairman Ghulam Nabi Azad addresses a public meeting ahead of the Jammu and Kashmir Assembly elections, at Bani in Kathua on Saturday. Congress MP Rahul Gandhi warned the BJP-led Union government Wednesday, vowing that the opposition INDIA bloc will "hit the road and use full force" both inside and outside Parliament if Jammu and Kashmir's statehood is not restored after the assembly elections. Azad, who was campaigning for his party's candidate in the Bani Assembly of the Kathua district, said there is immense enthusiasm among people for the polls. "There is huge enthusiasm among the people as they are participating in these elections after ten years," he added. Azad addressed a public meeting in Bani, where he appealed to people for unity and urged them to vote for development and progress. He urged people not to be "exploited" by false promises and slogans. "By voting for the DPAP, we believe the people of Bani can pave the way for a prosperous and inclusive future,' he said, adding, "Together, we shall rebuild Jammu and Kashmir."

KOCHI: Kerala High Court Judge Justice Devan Ramachandran had a lucky escape on Saturday after one of the tyres of his car burst while travelling on the Thrissur-Kuttippuram State Highway, a sizeable stretch of which is in a dilapidated condition.

TN introduces apartment ownership rules to regulate common areas, infrastructure

CHENNAI: Tamil Nadu Housing and Urban Development Department has notified Apartment Ownership Rules 2024, which covers common passages, driveways and pathways in the property and common infrastructure intended for the common use of all phases. The rule specifies that any redevelopment of building would require the consent of two-third of apartment owners confirming the terms and agreement for redevelopment and acknowledging the association's statutory empowerment to sign the agreement for redevelopment. The board of managers either suo motu or on request from one fourth of the apartment owners, shall convene a special general meeting with regard to redevelopment. Pursuant to the resolution passed, the association with the consent in writing of not less than two-third of apartment owners of the project, shall intimate the chief planner on area units under CMDA if the building is in Chennai Metropolitan Planning Area or member secretary of local planning authority on the in-principle decision taken by the association for redevelopment. If the building is in ruins, the association shall convene a general meeting and adopt a resolution for engaging promoter or consultant for preparation of detailed redevelopment report and to submit it to the association for approval.

Madras HC sets aside conviction of AIADMK ex-MP in graft case

CHENNAI: The Madras High Court has set aside the conviction and imprisonment of former AIADMK MP KN Ramachandran in a corruption case relating to bribing a top bank official for availing of loans in excess of the permissible limits.

Justice G Jayachandran recently passed the orders to set aside the judgment of a special court for CBI, which convicted Ramachandran and sentenced him to seven years in jail with a fine of Rs 1.11 crore in



2020. The conviction and sentence of his son R Rajasekaran and the then deputy general manager (DGM) of Central Bank of India R Thiagarajan was also set aside."In this case, the prosecution has miserably failed to prove the basic facts by not examining the best evidence, namely, a representative from Marlin Apartments," Justice Jayachandran said referring to the allegation that Ramachandran had arranged for air tickets and stay of Thiagarajan's son and other family in the US. The DGM was accused of sanctioning a loan of Rs 7 crore even though the overall exposure of the trust stood around Rs 15 crore. Over 100 families have already started relocating their belongings from the riverbed to the 2BHK units allotted through lottery conducted after Aadhaar verification.Officials told TNIE that they are coordinating with the residents and the process is going on peacefully. More families are expected to move within the next few days, the officials

M Dana Kishore disclosed that a survey identified 974 homes in the riverbed, of which 576 have been marked for relocation. "Around 400 families have expressed their willingness to move, which is approximately 80% of the affected families," he stated. Since the marking of



encroachments began on Thursday, 120 families have agreed to shift to 2BHK units in various parts of the city. On Saturday, authorities handed over 20 houses to residents, with an additional 100 families

also receiving homes. However, some people who had constructed larger structures and rented them out are reportedly reluctant to relocate as they fear losing a source of good revenue.

BHUBANESWAR: If commuting in the state capital through the chaotic traffic and incessant rains has become a pain, blame it on the poor plight of roads. Be it the streets or major thoroughfares, there is no escape from the back-breaking experience in Bhubaneswar. With Durga Puja knocking at the doors, the roads are a major concern for citizens as well as puja organisers. The delayed annual maintenance by Bhubaneswar Municipal Corporation (BMC) has left most of the city roads in dire straits. Cracks, rough and uneven surfaces, chocked drainage and even lack of markings have become common. Many residential localities grapple with pothole-ridden streets, making commuting a nightmare for residents. The rains have only added to the problem. While the surfaces have come off at many places even along the NH, those in the city are in even more precarious condition. Sources said the road repair works, ideally taken up prior to monsoon, were delayed as BMC struggled to finalise maintenance contractors and award of works through tender. With the change in government, the tender process was



delayed. It shows on the roads. "The stretch connecting Mancheswar to VSS Nagar is full of potholes, and during rain, it becomes extremely difficult to navigate. The Vani Vihar square area is another glaring example. It's the poor roads which have been causing traffic congestions," Deepak Rout, a local commuter said. The potholes on

the road at Vani Vihar square were repaired days before the visit of Prime Minister Narendra Modi earlier this month. However, after a few spells of heavy rain, it's back to square one.

A senior BMC official admitted that tender for repair works was approved only this month. "Around 17 tenders worth Rs 10 crore were

approved about five days back," the officer said. Around 500 roads and streets having a total damaged stretch of about 168 km have been identified and will be repaired soon

29 arrests in 3 mths lift veil off gang that mopped 24 crore

Gurgaon. The police have arrested 29 cyber fraudsters this year for cheating people across the country of approximately Rs 24.1 crore. A total of 5,953 complaints were made against the gang's fraudulent activities, the police said. Ankit and Abhishek Singh wereheld in June, Md Ali Husain was arrested in July; Hulas Mandal, Mani Choubey, Khushwant Gaut, Rohit Singh, Mahendra Singh Panihar, Shriya, Chiezote U Lachu, Palak, K Lalbiakzuali, Mose Sangtam L Athihri, Min Bite, Vikhomnau Chwang, Lalboy Kipgen, Amos, Vidanwangbo, Paominlun, Ashish Ojha, Manish Kumar, Ramesh Gurung, Namchunbo, Monu Kumar and Ritu were arrested in Aug; Jyoti Mehra, Rahul Bisht and Gulshan Kumar were held in Sept.

"Upon examination of the data from the recovered devices by I4C, it was revealed that there are 5,953 complaints and 256 cases registered against these individuals across the country, involving fraudulent activities. Out of these cases, 17 are registered in Haryana, with two cases in cyber crime police station east, four cases in cyber crime police station west, and one each at cyber crime police station, Manesar and cyber crime police station south.

'The investigation revealed that the accused were involved in various fraudulent activities, such as scamming people on the pretext of KYC updates, using fake Instagram accounts, providing technical support, and promising contracts with Maruti company. They would ask their victims to transfer money into their bank accounts and then never respond," said an official at the cyber police station.

The police team recovered Rs 40,500 in cash, 7 mobile phones, 5 SIM cards, and 17 laptops from the possession of the accused.

Truck rams scooter near Rajiv Chk flyover, 2 die

Gurgaon. Two persons were killed after a speeding truck allegedly rammed into the scooter they were riding under the Rajiv Chowk flyover on Saturay morning. The truck driver is on the run, police said.

The victims have been identified as 40-year-old Khem Singh and his sister-in-law Pooja (25). A native of Alwar in Rajasthan, Khem was employed at a spare parts company in Delhi.He lived with his wife -Pooja's sister — in Rajendra Park.Pooja, who was originally from Kotputli in Rajasthan, had come to Gurgaon a few days earlier to visit her sister and brother-in-law.Early on Saturday morning, Khem and Pooja left his house as he planned to drop her off at a bus stand. She was headed home to appear for the Central Teacher Eligibility Test (CTET) on Sunday.

The incident occurred around 6am, when the speeding truck, which was coming from the Sohna side, rammed into the scooter beneath the flyover.

The truck driver abandoned the vehicle and fled. Passersby rushed the injured duo to a nearby private

hospital, where they were declared brought dead by the attending doctors.

Police have initiated an investigation into the matter. "The bodies of the victims have been sent for a postmortem examination. We are investigating the case and scanning CCTV footage of nearby areas to identify the accused truck driver. He will be arrested soon," an

Noida. Cardiovascular diseases, considered to be a condition affecting older generations, are increasingly being reported among individuals in the age group of 25-40. Sedentary lifestyles, smoking, prolonged screen time, and stress contribute significantly to this trend, doctors said on the eve of World Heart Day, observed each year on Sept 29.

The latest NCRB data reveals that 9,277 people out of 34,210 who died of heart attacks in India were between 30 and 45 years old. According to the report, heart attack cases rose by 12.5% in 2022 compared to the previous year."In the past five years, there has been an increase of 25-30% in cases of cardiac arrest in young adults below the age of 40. We are witnessing around 70-80 cases of cardiac ailments every year, many of them 30-40 years old. Stress and sedentary lifestyles are key factors behind the rise," said Dr Sanjeev Gera, director and HOD of the cardiology department at Fortis, Noida. Explaining the major causes of heart attacks in young adults, Dr Purshotam Lal, chairman at Metro Hospital, Noida, said, "Unhealthy lifestyles, such as poor diet, lack of exercise, smoking, and excessive alcohol intake, are major contributors to obesity, high blood pressure, and high cholesterol - key risk factors for heart attacks. Chronic stress and untreated mental health issues, like anxiety and depression, can lead to harmful coping mechanisms, further increasing heart disease risk."He added that these risk factors are becoming more prevalent among young adults with increased desk jobs, screen time, and physical inactivity. Experts opined that chances of heart attack are equal for men and women; however, it is more prone to those with conditions such as high cholesterol, stressful activities, irregular lifestyles, smoking habits, and other underlying conditions.

The most common symptoms of heart attacks include radiating chest pain, shortness of breath, cold sweat, nausea, and high blood pressure, among others.

"Given the escalating trajectory of cardiovascular diseases among young adults, early screening for hypertension, diabetes, and dyslipidemia (abnormal lipid levels in the blood) emerges as imperative. Timely detection through routine health check-ups can pave the path for enhanced management and treatment of these conditions, potentially mitigating the risk of heart disease," said Dr Ajay Kaul, chairman of cardiac sciences at Fortis Hospital, Noida.

came into effect on Dec 29, 2007, was amended by UP govt on Aug 3 last year to revise the stamp duty on property transfers via gift deeds. Earlier, the stamp duty was 5% for gift deeds in Noida and 7% for other parts of the state. The govt took into note that a gift deed has sentimental value attached to it, that such transactions are completely nonfinancial, based on mutual trust and love among family members, and reduced the stamp duty on gift deeds to just Rs 5,000.

AIG, stamp and registration (Ghaziabad), Pushpendra Kumar said there are cases where senior citizens revoked gift deeds (used to transfer property) mostly due to "neglect and abandonment" by their children. Lawyer Prashant Kanha, who practises in the Supreme Court, said a gift deed and a will were two different legal documents. A senior citizen can execute a gift deed to transfer property to a donee during their lifetime, which is based on trust and the promise that they will be looked after. Whereas a will becomes applicable only after the death of the senior citizen, he said.

112 killed in Nepal due to heavy rain, floods; search ops on for 68 missing

Kathmandu. Devastating floods and landslides triggered by heavy rain have claimed the lives of at least 112 people in Nepal in the last 24 hours, as per official data. In addition, over 100 people are injured, and rescue operations are on to locate 68 people who have gone missing due to the calamity in the Himalayan country, several parts of which have been inundated since Friday. A police official claimed that 200 incidents of floods and landslides have been reported, but the number is likely to increase.Rain-related calamities are common in South Asia during the monsoon season. However, experts claim that the severity and the frequency of these disasters is increasing due to climate change.On Saturday, Nepal logged record-breaking rainfall in its 54 years with 323 millimetres of rainfall recorded within 24 hours. More than 3,000 security personnel were deployed to assist rescue efforts with helicopters and motorboats even as 412,000 households are expected to be affected due to monsoon-related diasters, as per the National Disaster Risk Reduction Management Authority (NDRRMA).

Rivers around the capital Kathmandu burst their banks, inundating nearby houses. Kathmandu's main river, the Bagmati, has also been flowing above danger levels following heavy rain. Visuals surfaced, showing people standing on top of buildings or wading through murky waters to get to safety. Videos also showed rescue teams using rafts to pull survivors to safety.

Trump touts possibility of Elon Musk heading 'department of efficiency'

World The US is slowly heading to the November 5 election date, the date candidates have spent months preparing for by spending money, explaining policies and shouting rhetoric and making promises. Death of Hezbollah's Nasrallah historic turning point, settles score: Netanyahu

Israeli Prime Minister Benjamin Netanyahu said on Saturday that Israel "settled the account" with a "mass murderer" after death of Hezbollah chief Hassan Nasrallah in an Israeli airstrike in Lebanon's Beirut.In his first public statement since Israel killed Nasrallah, Netanyahu said that Israel has "settled the account" with a "mass murderer" responsible for the killings of "countless Israelis" and many American and French citizens, The Times of Israel reported.

After returning from his trip to the United Nations in New York, Netanyahu said that the killing of Hassan Nasrallah was a "historic turning point". "Citizens of Israel, these are momentous days. We are at what will be seen as a historic turning point. One year ago, on October 7, our enemies attacked us and thought that Israel was on the road to being wiped out. One year later, blow after blow, achievement after achievement, they understand how their hopes have dissipated. Israel has momentum; we are winning," Netanyahu said.Israel's military said on Saturday it had "eliminated" Nasrallah after bombing Hezbollah's central command in the Lebanese capital, where the 64-year-old was reportedly holed up in a bunker.Netanyahu said that Nasrallah's death was a "necessary condition" to achieve Israel's goals."Nasrallah was not a terrorist, he was the terrorist," Netanyahu said in a statement.

'Nasrallah's killing was a necessary step toward achieving the goals we have set, returning residents of the north safely to their homes and changing the balance of power in the region for years to come," he added.The Israeli Prime Minister said that he gave the directive for the attack that targeted Hassan Nasrallah, as the blows the Israeli Defence Forces (IDF) had been landing on Hezbollah in recent days were "not enough", BBC News reported.

Ukraine claims 10 killed as Russian 'suicide drones' hit hospital

10 people were killed and at least 22 others injured after Russia attacked a hospital in Sumy, northeastern Ukraine, early on Saturday.

Kyiv. Russia attacked a hospital in Sumy in northeastern Ukraine early on Saturday, killing 10 people and injuring at least 22 others, Ukrainian officials said.Danielle Bell, head of the UN Human Rights Monitoring Mission in Ukraine, said "loitering munitions" - or suicide drones - hit the Saint Panteleimon Clinical Hospital in two attacks 45 minutes apart." Most of the fatalities occurred during the second strike, which hit as first responders arrived at the site and patients attempted to evacuate," she said.Sumy's regional administration said late on Saturday that 10 people had been killed and 22 injured, including 15 who were in hospital, five of them in serious condition.
All the hospital's patients were evacuated to other facilities, it added. Sumy City Council said on its website that nine high-rise buildings were damaged in addition to the hospital.Bell said she had been in Sumy last week following up on a deadly September 19 attack on a geriatric centre in which at least one civilian had been killed and 13 injured, and recalled an August 13 attack on another hospital complex in the



city."Medical facilities are protected under international humanitarian law and are entitled to special protection. They must not be the object of attack," she said, adding that 33 civilians had been killed and 132 injured in Sumy city and the surrounding region since August 6.Ukrainian prosecutors said

that at the time of the Saturday morning attacks 86 patients and 38 staff members were in the hospital

DRONE ATTACKS

The hospital shared a photograph on its Facebook page it said showed one of those killed, a nurse and mother of two daughters

named Tatiana Tikhonova."The first attack killed one person and damaged the ceilings of several floors of the hospital," Interior Minister Ihor Klymenko said on Telegram.

"Everyone in the world who talks about this war should pay attention to where Russia is hitting. They are fighting hospitals, civilian objects and people's lives," Ukrainian President Volodymyr Zelenskyy said on Telegram."Only force can force Russia to peace. Peace through force is the only right way."Klymenko did not specify what weapons were used in Saturday's attacks. The regional administration and air forces said the strike was carried out by drones, which Bell identified as loitering munitions.

Attacks on Sumy city and the Sumy region have become more frequent since Ukrainian forces launched an operation in Russia's Kursk region in August and captured dozens of settlements. Sumy city is located just 32 km (20 miles) from the Russian border, and Russian forces, which began a full-scale invasion of Ukraine in February 2022, have been attacking the region and the city with drones and guided bombs.

Kim Yo Jong, the powerful sister of North Korean leader Kim Jong Un, said Washington is escalating the Ukraine



conflict and driving all of Europe to the brink of a nuclear war. The United States and the West should not dismiss or underestimate Russia's serious warning," Kim said in a statement published by state news agency KCNA."Are the United States and the West really able to handle the consequences as they recklessly play with fire against Russia, which is a nuclear superpower?" she said.Russian President Vladimir Putin has warned he could use nuclear weapons if Russia was hit with missiles and would consider any assault against it that is backed by a nuclear power to be a joint attack. World. Israel has claimed that it eliminated a top intelligence commander of Hezbollah in an airstrike in the southern suburb of Beirut on Saturday. The Israel Defence Forces (IDF) said that Hassan Khalil Yassin, headed a unit in Hezbollah's intelligence division that was tasked with locating Israeli military and civilian sites in Israel to be targeted.

The military claimed that Yassin worked closely with Hezbollah missile and drone units and was "personally" involved in



terror plots that were carried out against civilians and soldiers from the beginning of the war and had also planned additional attacks on the Jewish nation in the coming days. The news of his elimination by Israel comes hours after Hezbollah leader Hassan Nasrallah was killed in an Israeli airstrike on Beirut."Hassan Nasrallah will no longer be able to terrorise the world," the IDF said while confirming the news of his death in the strikes.Protests broke out in Iran following the news of Nasrallah's death. Protesters carried portraits of the killed Hezbollah leader and also chanted slogans like "Revenge," "Down with Israel," and "Down with the US". Iran has also called for an urgent meeting of the UN Security Council amid Hezbollah's dramatically escalating

tensions with Israel. Lebanon declared a three-day mourning period following Nasrallah's death. Soon after Israel announced Nasrallah's killing, sirens were sounded in several parts

of the Jewish nation. A projectile fired by Lebanon crashed into an Israel-occupied West Bank area, but no injuries were reported. Air raid sirens were also sounded on the outskirts of Jerusalem, which the Israeli military said were triggered by "a launch from Lebanon toward Israeli territory".Israel Prime Minister Benjamin Netanyahu described his killing as a "historic turning point", claiming that the country had "settled its account" with a mass murderer responsible for the killings of "countless Israelis" and many American and French citizens. Notably, Israeli strikes in Lebanon killed 33 people and wounded 195 others on Saturday, the Lebanese health ministry said. More than 1,000 people have been killed and more than 6,000 wounded as a result of Israeli attacks in the past two weeks, and about one million Lebanese have been displaced by the strikes.

SpaceX launches rescue mission for two NASA astronauts who are stuck in space until next year

CAPE CANAVERAL.SpaceX launched a rescue mission for the two stuck astronauts at the International Space Station on Saturday, sending up a downsized crew to bring them home but not until next year. The capsule rocketed into orbit to fetch the test pilots whose Boeing spacecraft returned to Earth empty earlier this month because of safety concerns. The switch in rides left it to NASA's Nick Hague and Russia's Alexander Gorbunov to retrieve Butch Wilmore and Sunitha Williams.Because NASA rotates space station crews approximately every six months, this newly launched flight with two empty seats reserved for Wilmore and Williams won't return until late February.

Officials said there wasn't a way to bring them back earlier on SpaceX without interrupting other scheduled missions.By the time they return, the pair will have logged more than eight months in space. They expected to be gone just a week when they signed up for Boeing's first astronaut flight that launched in June.NASA ultimately decided that Boeing's Starliner was too risky after a cascade of thruster troubles and helium leaks marred its trip to the orbiting complex. The space agency cut two astronauts from this SpaceX launch to make room on the Dragon capsule's return leg for Wilmore and Williams. Wilmore and Williams watched the liftoff via a live link

sent to the space station, prompting a cheer of "Go Dragon!" from Williams, NASA deputy program manager Dina Contella said. Williams has been promoted to commander of the space station, which will soon be back to its normal population of seven. Once Hague and Gorbunov arrive on Sunday, four astronauts living there since March can leave in their own SpaceX capsule. Their homecoming was delayed a month by Starliner's turmoil. Hague noted before the flight that change is the one constant in human spaceflight."There's always something that is changing. Maybe this time it's been a little more visible to the public," he said. Hague was thrust into the

commander's job for the rescue mission based on his experience and handling of a launch emergency six years ago. The Russian rocket failed shortly after liftoff, and the capsule carrying him and a cosmonaut catapulted off the top to safety.Rookie NASA astronaut Zena Cardman and veteran space flier Stephanie Wilson were pulled from this flight after NASA opted to go with SpaceX to bring the stuck astronauts home. Promised a future space mission, both were at NASA's Kennedy Space Center, taking part in the launch livestream. Gorbunov remained on the flight under an exchange agreement between NASA and the Russian Space Agency.

Shirur landslide rescue mission becomes India's longest search operation

KOZHIKODE: The rescue mission at Shirur, following a devastating landslide on June 16, has become one of the longest in Indian history. The incident gained national attention on June 19, when it was reported that Arjun, a truck driver from Kozhikode, was feared trapped in the landslide. After intervention at the ministerial level, the rescue operations were ramped up. The landslide prompted a massive response involving the Navy, divers, rescue volunteers, and a dredging unit, all participating in the 72-day mission. While India has faced numerous natural disasters, such as the 2004 Tsunami and the 2013 floods in Uttarakhand and Himachal Pradesh, most rescue operations have lasted only a few days. The 2004 Tsunami, which primarily impacted coastal regions, saw rescue efforts completed within 96 hours. The 2013 floods, considered one of the largest rescue operations in India, saw the Indian armed forces evacuate civilians over a two-week period. In contrast, the twin landslides in Wayanad, which claimed hundreds of lives, saw Army-led rescue operations conclude in 10 days, with civilian teams continuing the search for missing persons shortly afterward.

At Shirur, efforts focussed on finding Arjun and two brothers from Karnataka, Jagannath Naik and Lokesh Naik, who were also reported missing. The landslide struck early on July 16 near Ankola on the Karwar-Kumta Road (NH 66). By evening, six bodies were recovered from the Gangavali River, with 12 more people reported missing. On July 19, four days after the landslide, news of Arjun's situation surfaced. Kerala Transport Minister K B Ganesh Kumar reached out to Karnataka Transport Minister Ramalinga Reddy, leading to intensified search operations.

E-pass for vehicles at Marudhamalai Temple in Coimbatore

COIMBATORE: To manage the flow of vehicles and the parking issues at Marudhamalai Temple, the temple trust has decided to implement an online e-pass booking system for four-wheelers in which they plan to allow 300 vehicles to climb the hill per day. However, this does not imply to those visiting the temple by bike or walk. As a large number of devotees visit the Arulmigu Subramaniaswamy Temple at



Maruthamalai everyday, the number increases every Sunday, Tuesday, Kiruthigai days, and festival days. Due to the lack of parking space in the temple premises, it can only accommodate around 60 cars and 350 bikes at a time. Hence the temple trust denied permission for four-wheelers to access Ghat road on special occasions and the devotees are only allowed to visit the temple either by bus operated by the Hindu Religious and Charitable Endowments Department (HR &CE) or by walking. Therefore, to streamline this practice, the trust and the department have planned to implement an Epass system for four-wheelers.

Police find 9-year-old girl, who was believed to be killed after rape

BENGALURU: In a dramatic turn of events, a nine-year-old girl, initially believed to be dead after her neighbour falsely confessed to her rape and murder, was found safe and unharmed after a gripping four-day investigation.Pooja (name changed), the daughter of a ragpicker from Goripalya, went missing when her parents entrusted her to Puneeth, a neighbour and another ragpicker, who had always treated her like family. On September 18, the day she went missing, Puneeth told Pooja he would take her to visit his sister in Rajajinagar. Her parents allowed her to go.

However, the next day, Puneeth returned without Pooja. When confronted by her parents, he claimed he had no idea where she was. Her parents filed a missing person's complaint at the JJ Nagar police

The police summoned Puneeth, and he told them that he had taken Pooja to Mandya, but got down at Shettihalli. He then falsely confessed to raping and killing her, claiming he had disposed of the body at an onion market in Mandya. But the police remained sceptical as he was intoxicated at the time of questioning, and continued their investigation. The police found out that Pooja with Puneeth had boarded a train to Mysuru from the Kengeri Railway Station. The police then brought him back for questioning and this time, he randomly picked up a piece of cloth from the ground,



claiming he used it to smother Pooja after

The police, still wary of Puneeth's claims, ramped up their investigation and soon made a crucial breakthrough. They found out that the train he claimed to have taken was an express that did not stop at Shettihalli and had stopped only at Mandya before reaching Mysuru.

The police continued their probe and circulated Pooja's picture across all railway stations. Just when hopes were dimming, the police received a call, saying a girl had been found alone in a train coach in Mysuru on the same day Pooja had gone missing. The Mysuru Railway Police, who had taken her to a local shelter -- Balamandir, informed the Bengaluru police. When Pooja was finally located, she revealed that Puneeth had treated her kindly during the journey.

The police conducted tests on Pooja and confirmed that she was safe and was not raped. After learning that she was born in Bengaluru in 2014, the police checked all hospital records and obtained her birth certificate from a now-closed hospital in Vijaynagar. They enrolled her for an Aadhaar card and are now searching for a school to help her start anew.

They have found that the number of species present in Karnataka has increased from 92 species in 2015 to 102 now in the year 2024. Researchers also pointed that of these 102, 31 are endemic species. Aatmanirbharta should not cost IAF dear

The world has seen the robust Indian Humanitarian Assistance and Disaster Relief (HADR) capability in the past two decades through the tireless flying done by the IAF's (Indian Air Force) transport aircraft fleet flying great distances in the neighbourhood — and many times to distant lands too. The IL-76 was the workhorse of this effort in the past but now it is the C-17 and C-130 that hog the limelight. Planned for acquisition in the beginning of this century, when one political party was in power in Delhi, the project, however, fructified when another party had taken over the reins of running the government.

Similarly, the Sukhoi 30, inducted in 1997 by the Deve Gowda government on plans made earlier by the PV Narasimha Rao administration, would be the backbone of our nation's deterrence posture for many more decades. The induction schedule of the Rafale fighter jets has followed a comparable timeline. Likewise, the present government would also plan many projects that would strengthen India's hard power in the coming years. There is, thus, a continuity that gets mandated in defence procurements, and since deterrence and war-fighting capability accretion takes decades to build, there must be a continuum too in policy making. As India builds up its hard power through the aatmanirbharta campaign to face its challenging security environment, a recent statement of the Vice Chief of the Air Staff (now the Air Chief designate) made at an airpower seminar gains salience; the Vice Chief had remarked that, "aatmanirbharta is what we are riding on, but this self-reliance cannot be at the cost of the nation's defence." Wise words they are in the current stridency of misplaced nationalism vis-à-vis the self-sufficiency campaign; they need an analysis, lest their import is lost in the cacophony of our robust political atmosphere. The aatmanir bharta campaign is indeed noteworthy in India's desire to attain selfsufficiency in arms to prevent being at the mercy of supplier nations who have a history of armtwisting to meet their geopolitical plans. Thus, the negative lists of imports and positive lists of items to be bought only from indigenous sources are indeed welcome, but with a rider; these directions cannot be at the cost of hollowing up of the fighting potential of the three services. The media has highlighted innumerable examples of projects slipping up on timelines and costs that reveal the continuing trend by R&D (research and development) and production agencies of promising more than their capability and expertise to bag armament contracts. The Vice Chief's statement is a public acceptance of the prevalence of this malaise. And, if another example is needed, then the present delay in the supply of Tejas Mk1A fighters to a squadrondeficient IAF should drive home the point.

The delay in Tejas Mk1A deliveries has been attributed to the delay in supply of the F-404 engines by the US manufacturer, General Electric (GE). The supply of Apache helicopters to the Army, too, has been delayed by a year. One hopes that this has nothing to do with India's assertion of its relations with Russia in the Ukraine-Russia imbroglio, despite US opposition. The problem is that the follow-on Tejas Mk2 (a conventional design) is also being planned around a higher power F-414 engine from GE who, incidentally, is also setting up a plant with supposedly 80 per cent transfer of technology to make the engine. Next in line for the IAF is the futuristic Advanced Combat Aircraft (AMCA) whose Mk1 version would have the same 98 kN thrust F-414, followed by a Mk2 version with an indigenous engine producing a higher 110 kN of thrust to give true fifth-generation capability to the AMCA. The AMCA prototype is expected in 2028 — pushed from earlier pronouncements of 2024 and then 2026. Logically, and hopefully, the Tejas Mk2 prototype would come before this new AMCA target date.

Rising Islamophobia in Himachal Pradesh worrisome


From architecture and painting to music and religion, the role of Muslims has been crucial to the state's evolution.

As Islamophobic activities rage across Himachal Pradesh, every iota of pretense about the state's 'intrinsic', 'inclusive' character is being shredded into smithereens. With their epicentre at Shimla just a couple of weeks ago, where right-wing outfits protested against an illegal mosque, the matter has far surpassed its original purpose. Similar demands have been voiced at Mandi and Kullu, and Muslim-owned shops have been marked in red and vandalised in Solan and Palampur. With over 25,000 illegal buildings strewn across Himachal, 15,000 of which can be found in Shimla itself, the mass mobilisation against a few minority structures, howsoever 'illegal', is nothing but a political exercise.

While many people have been quick to point out how such a sentiment has "never" been witnessed before in the state, in reality, there have been precedents. In June this year, a Muslim shop owner in Nahan was violently attacked by a Hindutva mob for purportedly sharing a photograph of an animal sacrifice during Eid-al-Adha. During the pandemic, many people belonging to the majority held

Muslims responsible for "introducing" the virus to the state. That the minority constitutes barely two per cent of the population hardly deterred such opinions. In the ongoing crisis, the most striking claim has been that Himachal's demography is in "acute danger," since the state never had a Muslim population history, let alone cultural contributions, to speak of. In the same vein, the repeatedly invoked "growing number" of Muslims is unambiguously posited as a "threat" to the overall character, despite little evidence to back the claim. Such assertions are not only ignorant of the past but also dangerously deceptive. Because from architecture and painting to music, religion and everyday activities, the role of Muslims has been crucial to the hill state's flourishing for centuries.

The state capital's predominant architectural style of dhajji, widely used across heritage buildings, was introduced by Muslim workers. As Simla, the summer capital of the Raj, was reaching its heyday in the middle of the nineteenth century, Muslim labourers and coolies were brought in from Kashmir and Ladakh to carry out the construction work. Dhajji's timber-framed model with infills of stones, bricks, pine needles and mud was not only earthquake resistant but also pleasing to the eye. As conservation architect Saumya Sharma observes, "It was not difficult to reproduce a European aesthetic



inspired by the Tudor style in Simla because of the presence of craftsmen from Kashmir and Ladakh."

Going back even further, the beginnings of Pahari art, unarguably Himachal's greatest cultural gift to the world, are inextricably linked to the social context and styles of Mughal paintings. Nearly three decades ago, the famed Indian novelist and art critic Mulk Raj Anand had remarked that "the dispersal of Mughal-trained artists had started in the late Akbar period in the regions of Nurpur, Chamba and Mandi", where numerous paintings were done by those "working in the popular Mughal style." He said that the treatment of architectural elements such as "turrets, panelled doors, latticed windows, trellis work and wooden pillars, and the intricate design, were not a characteristic of the folk paintings of the hill areas, but were adapted from the Mughal paintings brought home from Delhi by the Rajas."Interfaith expressions can also be gleaned from diverse zones. At the outskirts of Shimla lies the dargah of Hazrat Baba Strotri (also spelled Salautri) at Ghora Chowki, visited by all communities in the hope of curing skin diseases. In different parts of Sirmour district, Goga Maharaj is worshipped as a pir by the Muslims and as a deity by the Hindus. Chamba's famous Sui Mata Temple is located on Shah Madar Hill, the latter named after a Syrian Sufi saint who migrated to India more than six centuries ago. In the same region, the international Minjar Mela commences with the offering of the holy minjar (silk tassels resembling maize blossoms) by a Muslim family a

Kullu's Jamlu devta belonging to Malana village is annually worshipped via its affinity to the emperor Akbar. In Kangra's Khaniyara village, at the Indru Nag Dev temple, Hindu chants accompany drumbeats and shehnais, traditionally played by Muslim musicians. In the same district, frescoes inside the two-century-old temple of Dada Siba transpose Krishna, Ram and Dwarpalas to the Arabic tale of Laila Majnu.Numerous well-known names have also been attached to the capital's Muslim heritage. Many old timers remember affluent businessmen like Mir Nadir Hoosain, who owned major properties like Elysium Hotel and Belvedere. Hamid Karzai, the former president of Afghanistan, remembers his time spent in Shimla while pursuing higher studies from Himachal Pradesh University in the 70s and 80s. Sitarist


Ustad Vilayat Khan also made Shimla his home in the early decades of Independence. Professor Abdul Majid Khan, an academic, foreign ambassador and the town's most "visible" Gandhian, had left his family in Pakistan to settle in the capital. Residents still recall Professor's habitual "pause" before the Ridge-based statue of Mahatma Gandhi daily, when he bowed to pay his respects, replete in a Gandhi cap and achkan.

But it is the common labourers and migrants, whether Gujjar tribesmen or the coolies and porters, that remain the most abiding symbol of the state's Muslims. The latter's association with Himachal goes back to the times of the Central Asian trade, when many Muslims travelled far and wide exchanging goods and ideas. Today, of course, from Shimla to Chamba, there exist several mohallas named after Kashmiris and Ladakhis, attesting to their assimilation within the social fabric.

As these workers continue carrying backbreaking loads every day to keep the local economies alive, it must be introspected in times such as these, if we, as a majority, are only content to see the "other" in "subservient" roles. And as chants from Hanuman Chalisa and of "Jai Shri Ram" get vindictively appropriated for ousting every imprint of the minority community, we also have to ask ourselves if this is what the devtas of Dev Bhoomi actually stand for.

It must not forget in a hurry the PM's words that 'we need to instil a sense of fear amongst those abusing women'. Conniving with rapists and murderers will only dent the State's credibility and embolden criminals.

War-torn world needs Gandhian balm

Our modernity, despite the grand Enlightenment promises of reason and freedom, has failed

AS I recall Mohandas Karamchand Gandhi or seek to understand his worldview through an interpretative understanding of the texts he is known for - The Story of My Experiments with Truth and Hind Swaraj I confront a paradox. A careful look at the harsh reality of the world we live in indicates that Gandhi is dead, or his spirit is negated everywhere - from the domain of political economy to the spheres of culture and education. Yet, despite this negation, I feel strongly that we need to have a serious engagement with him in order to save and heal this tormented world. To begin with, as I look at our collective destiny in these hyper-modern/hyper-nationalist times, I feel that we are defining ourselves primarily as reckless consumers seduced by the market-driven ideologies of 'good living' and militant warriors intoxicated by a set of exclusivist identity markers. As we internalise the gospel of ceaseless consumption a logical consequence of neoliberal market fundamentalism -- our needs multiply and our insatiable greed (more cars, more gadgets, more consumption, more electricity, more fossil fuel extraction, more deforestation and hence more carbon emissions) causes severe damage to the environment. Likewise, as we become more and more hyper-nationalist, we further divide and fragment the world. In a way, it becomes exceedingly difficult to free ourselves from the oppressive binaries: Hindu vs Muslim; India vs Pakistan; or for that matter, Israel vs Palestine. Yes, we find ourselves in what many social scientists would characterise as a 'risk society' - a society tormented by war, militarism, terrorism, authoritarianism and above all, a climate emergency. Of course, there is not even the slightest trace of the Gandhian spirit in this world.

Gandhi — possibly, like Henry David Thoreau — urged us to reduce our artificial needs, value

spiritually awakened simplicity and live in harmony with the ecosystem. Gandhi urged us to discover the source of inner strength, courage, commitment to truth and justice and the art of resistance against an unjust system (say, colonialism or the caste system) in ahimsa, aparigraha and sarvodaya. Possibly, in Gandhi's mental landscape, there was a creative blend of the Bhagavadgita's notion of karmayoga and the redemptive power of the love Jesus articulated in his Sermon on the Mount. Moreover, it is not difficult to find the traces of philosophic anarchy and romanticism in Gandhi's ways of critiquing the entire edifice of industrial capitalism. Yes, his sharp comments on 'doctors and lawyers' in Hind Swaraj or his romance with a fairly decentralised village swaraj indicates that he differed significantly from the standardised notion of modernity prevalent in his times, be it bourgeois industrial capitalism or Marxian socialism. Likewise, as he articulated sharply in his Autobiography, John Ruskin had a profound impact on the way he celebrated the dignity of labour and interrogated the oppressive binary: mental vs manual. In Gandhi's worldview, farmers, weavers and carpenters play no less an important role than doctors and lawyers. And of course, as the politics behind his assassination revealed, the brigade of militant Hindu nationalists loathed Gandhi — and his doctrine of ahimsa and religious pluralism. These critiques notwithstanding, the fact is that it is difficult to escape Gandhi. The reason is that our modernity, despite the grand

Enlightenment promises of reason and freedom, has failed. We live amid all-pervading violence — the violence of techno-science and its instrumental rationality leading to a massive environmental disaster; the violence of new devices of surveillance through which the modern state seeks to establish its

devalues the fundamental principles of democracy; the violence of religious fundamentalism and the simultaneous growth of diverse forms of terrorism; and above all, the routinisation and normalisation of war - one war leading to another! Yet, those who refuse to be paralysed by the pessimism this dystopian world creates and believe that it is still possible to save this world are likely to plead for a paradigm shift from the aggression of power to the civility of dialogue; from possessiveness to distributive justice; from religion as an instrument of hyper-nationalism to what late Vietnamese Buddhist monk Thich Nhat Hanh characterised as the religiosity of loving kindness and compassionate listening; from revenge and violence to what political philosopher Martha Nussbaum regarded as peace, reconciliation and

absolute control over its citizens and

forgiveness; and from one-sided emphasis on economic prosperity to the cultivation of soul force. Air quality panel under SC fire over **Delhi pollution**

SC bench says no punitive action has been taken against those who burn crop stubble

NEW DELHI: Slamming the Commission for Air Quality Management (CAQM) over its failure to curb air pollution due to crop residue burning, the Supreme Court on Friday observed that the air quality panel needed to be more active in its approach in dealing with the issue.A two-judge bench of Justices Abha S Oka and Augustine George Masih expressed its dissatisfaction with the CAQM's report on the stubble burning issue and sought a better compliance report. It fixed the matter for further hearing on October 3. Underscoring that the Commission should do its best to ensure that stubble-burning alternative equipment is used at the grassroots level, the top court asked for effective steps taken in this regard.



"There has been total non-compliance of the Act. Please show us a single direction issued to any stakeholder under the Act," Justice Oka said, questioning whether any substantive steps had been taken to address the problem.

Additional Solicitor General (ASG) Ashwarya Bhati, senior law officer representing the Central govt, emphasised that effective steps such as issuing advisories and guidelines to manage the crisis have been taken in this regard. The apex court, however, was unimpressed."It is all in the air, nothing they have shown regarding what has been done in the National Capital Region (NCR) states," Justice Oka observed. "Not a single committee has been formed to tackle the stubble burning issue. Every year, we witness stubble burning, indicating total non-compliance with the CAQM Act. Have any committees been constituted? Show us one step taken. What directions have you utilised under the Act? You are merely silent spectators," the bench said.

Amicus curiae Aparajita Singh pointed out that the CAQM was not doing enough to tackle the issue. "What effective action are they taking? ... If it is still continuing year after year, then these are not

Chandrayaan-3 May Have Landed On Moon's Oldest Craters, Says Researchers

The Pragyan rover was deployed on the lunar surface by the <u>Vikram</u> lander, on board the ChandrayaanNew Delhi: India's lunar mission Chandrayaan-3 possibly landed in one of the oldest craters of the Moon, according to scientists who analysed images from the mission and satellites.

The crater was formed during the Nectarian period, which dates back to 3.85 billion years and is one of the oldest time periods in the Moon's history, the team, including researchers from the Physical Research Laboratory and Indian Space Research Organisation (ISRO), Ahmedabad, said.S Vijayan, an associate professor in the Planetary Sciences Division, Physical Research Laboratory, told PTI, "Chandrayaan-3 landing site is a unique geological setting where no other missions have gone. The images from the mission's Pragyan rover are the first on-site ones of the Moon at this latitude. They reveal how the Moon evolved over time".

A crater is formed when an asteroid crashes into the surface of a larger body like a planet or a Moon, and the displaced material is called 'ejecta'. Revealing how the Moon evolved over time, the images showed that




one-half of the crater was buried under material thrown out or 'ejecta' from the South Pole-Aitken basin -- the largest and most known impact basin on the Moon, the researchers said.

An impact basin is a large, complex crater with a diameter of over 300 km, while a crater The Pragyan rover was deployed on the lunar measures under 300 km in diameter. Forming of ejecta is "similar to when you throw a ball on the sand and some of it gets displaced or thrown outwards into a small pile," explained Vijayan, who is the corresponding author on the study that appeared in the journal

Icarus."When an impact basin is forming, surface material will be thrown out. If the diameter of the impact basin is larger, subsurface materials from greater depths will be excavated," Vijayan said.In this case, Chandrayaan-3 was found to have landed within a crater -- about 160 km in diameter -- and detected in the images as a nearly semi-circular structure.

The researchers said this likely indicated one half of the crater, the other half of which was 'degraded' by getting buried under ejecta from the South Pole-Aitken basin."Further, near the landing site, ejecta or material 'thrown out' from another impact crater further away was observed -- images captured by the Pragyan rover revealed that material of the same nature was present at the landing site," Vijayan said.

Restless in Seattle: How concerned are airlines in India over the Boeing workers' strike

NEW DELHI. Talks between American aerospace major Boeing and the Union representing around 33,000 of its striking workers collapsed Friday with no further negotiations scheduled for the time being.

This has left Boeing's customer airlines globally among them India's Akasa Air and Air India Express disconcerted and anxious. However, they might not be pressing the panic button just yet.

The strike over wage revision, which has now entered its third week without a resolution in sight, has brought to a grinding halt the production of Boeing's best-selling 737 narrow-body aircraft, which currently have nearly 5,000 outstanding orders. Boeing's aircraft delivery schedules, which were already delayed due to other problems, could be hit further in the event of a protracted strike. So, how worried are Akasa Air and Air India Express, which have 300-plus Boeing 737 MAX aircraft on order between them?

According to sources in the two airlines and industry watchers, the strike is unlikely to impact the carriers' planned operations in the immediate-to-near term as they are assured of aircraft deliveries till the end of this year, and their network and capacity expansion plans in the short term are already tuned to that schedule. The key concern is the impact that a potentially long-drawnout strike could have on aircraft deliveries over the subsequent months and even the next couple of years. But any clarity on that front is contingent upon the resolution of the strike. Additional delays could directly hinder the airlines' capacity and network expansion plans over the medium term, sources indicated. Then there could be additional headaches like inability to acquire and hold additional slots at airports due to slow capacity addition, being forced to extend leases on older and less efficient aircraft (in Air India Express's case) that were to be replaced by the new jets, and difficulty in retaining pilots who are on the bench and not released for flying due to aircraft delivery delays—more relevant for Akasa Air.

The airlines are in regular touch with Boeing but with no real progress in negotiations with the workers' union, the aircraft manufacturer has not given the carriers any guidance on the agitation's likely impact on delivery timelines, it is learnt."We know our business challenges cause disruption for our customers and we deeply regret the impact on them. We continue to provide technical support and stay in close contact with our customers during this time," Boeing said in response to The Indian Express's queries. Air India Express and Akasa Air did not respond to requests for comments.

Govt eases export curbs for non-basmati white rice

New Delhi. A day after removing the export duty, the Centre on Saturday revised the export policy for nonbasmati white rice from "prohibited" to "free," but imposed a minimum export price (MEP) of \$490 per tonne. A notification to this effect was issued by the Directorate General of Foreign Trade (DGFT).

"The export policy of Non-Basmati White rice (semimilled or wholly milled rice, whether or not polished or glazed: Other) under HS code 10063090 is amended from 'prohibited' to 'free' subject to MEP of \$490/tonne with immediate effect and until further orders," states the DGFT order. The DGFT order came a day after the Centre removed the export duty on nonbasmati white rice. According to the notification, which came into effect immediately, the export duty on "semi-milled or wholly milled rice, whether or not polished or glazed (other than parboiled rice and basmati rice)" has been reduced to "nil" from the current rate of 20 per cent. The Finance Ministry also reduced the export duty on three categories of nonbasmati rice. The export duty on rice in the husk (paddy or rough), husked (brown) rice, and parboiled rice has been cut from 20 per cent to 10 per cent, according to the notification

India had banned the export of non-basmati white rice in July of last year to boost domestic supply. While the Centre had banned shipments of non-basmati white rice, it had allowed exports through the newly formed National Cooperative Exports Limited (NCEL). In the financial year 2023-24, India exported 23.59 lakh tonnes of non-basmati white rice, with the largest quantities shipped to Kenya, Mozambique, and

Gold rises 29% so far this year, may soar to Rs 8,000/g by December

sizzle for the third day on the back of global rally that began since the Ukraine war and has gained an unprecedented speed since the US Federal Reserves cut the interest by 50 bps—first time in four years.

Every analyst is expecting the rally to continue for some more time ranging from \$2,800-3,000/ounce or Rs 7,550-8,000 per gram by December. The yellow metal has already gained 29% this year after a 20% rally in the previous year. Gold continued to gain on Friday, adding Rs 35/g which took the retail price to Rs 7,575/g for pure gold. Similarly, silver also shot up by Rs 1,705/kg to Rs 92,522, according the closing price details on the Indian Bullion & Jewellers Association website. Since the rate cut hope gained traction, gold has been performing well in the global markets, already reaching the yearend target of \$2700/ounce. After crossing the sensitive price



barrier, the metal is trading today at \$2691/ounce.In a note on Friday, a day after the metal crossed the \$2700/ounce mark on the Chicago Mercantile Exchange, global agency Fitch Solutions said they are expecting the price to jump to \$2800/ounce by the end of the year."We are revising up our 2024 gold price forecast from \$2,250/oz to\$2,375/oz, expecting gold prices to trade within the range of \$2,500-2,800/oz in the coming months," Fitch Solutions said. This marks a departure from the \$1,943/oz

neutral to bullish towards gold for Q4, 2024- Q1, 2025 as prices receive support from the US Fed's rate cuts and high levels of geopolitical tension. Can Anil Ambani make a comeback

MUMBAI: The Anil Ambani group, under financial distress for years, has come up with some financial recovery claims. In the last couple of weeks, the group's only remaining functional companies Reliance Infra and Reliance Power have announced that they are going to be net debt-free and that these companies are on a solid financial footing. Both RInfra and RPower have announced a cumulative fund raising plan of Rs 7,500 crore. The speed at which Anil moved to clear debt, and simultaneously announce new fundraising plans, have surprised investors and shares of the firms surged, with RInfra's market cap rising 50% to Rs 12,500 crore and of RPower's by 25% to Rs 14,600 crore in one month.Of the Rs 6,000 crore fund infusion into Reliance Infra, Rs 1,200 crore will come from Anil himself and Rs 1,800 crore from fund managers including former Blackstone xecutive and fund manager Mathew Cyriac's Florintree Innovation and the rest Rs 3,000 crore from qualified institutional buyers. If fructified, post-issue Florintree will become the secondargest shareholder in RInfra.The board of RPower has approved Rs 1,525 crore preferential issue on Monday, with Rs 600 crore coming from its promoter company Reliance Infra and

remaining Rs 900 crore from Authum Investment

and Infra and Sanatan Financial Advisory Services. Authum Investment and Infra, an NBFC, had acquired Reliance Commercial Finance from Anil for Rs 1 crore in 2022. RInfra will cut its debt from Rs 3,831 crore to Rs 475 crore, which is 87% reduction, by clearing outstanding dues to lenders like Life Insurance Corporation (Rs 600 cr), Edelweiss ARC, ICICI Bank, and Union Bank, as per company filings. But the filings didn't disclose where the money has come from as it has an accumulated loss of about Rs 3,900 crore in last three years. With these fund infusions, RInfra's net worth will rise from Rs 9,000 crore to Rs 12,000 crore, so says the filings. What is to be seen how the new investors will gain a few years down the line. The board approved seeking shareholder nod to raise an additional Rs 3,000 crore via a QIP.On September 18, RPower said.

Anna Sebastian's death: why is Narayana Murthy silent

New Delhi. The tragic death of Ernst & Young (EY) employee, Anna Sebastian Perayil, from overwork and stress has not gone in vain. It has forced the cavalier managers of the accounting firm to issue guarded regrets. It has triggered a national debate on the toxic work culture and the slave driving that happens behind the hallowed portals of these service organisations; and the government has ordered a "thorough investigation into the allegation of unsafe and exploitative work environment" at EY.

In this swirling debate, an important person whose silence is deafening is Înfosys co-founder N R Narayana Murthy. He took the country by storm in September last year when he called on young people to work a 70-hour week to boost productivity and improve the economy. He was backed by Ola's Bhavesh Aggarwal and Vinod Khosla, co-founder of IT major, Sun Microsystems. The latter described Murthy's critics as those who needed mental health therapy. Narayana Murthy's call for a 70-hour-week got

so much traction that MPs in Parliament wanted to know if there was a government proposal to switch to these new work hours. Given his strident stand, shouldn't Mr Narayan Murthy have some comment to make on the death of Anna Sebastian Peravil? Why Are Vinod Khosla and Bhavesh Aggarwal silent too? After all wasn't it overwork that did her in? Anita Augustine, the distraught mother of Anna, points this out in her letter to In Australia, a sporting nation, there is no E&Y chairman Rajiv Memani:

"Anna confided in us about the overwhelming workload, especially the additional tasks assigned verbally beyond the official work. I would tell her not to take on such tasks, but the managers were relentless. She worked late into the night, even on weekends, with no opportunity to catch her breath...With the collapse of the trade unions and collective bargaining in recent years, employees are forced to compete with each in a debilitating rat race. India's corporate culture glorifies long hours, and expects employees to stay and work late into the night. Those

that stick to their working hours are looked down upon as 'losers' or 'under-performers'. The belief that long and arduous worktime increases productivity has been proven to be a fallacy. It is the quality of work that matters. A balance of worktime with recreation, sports and family time not only creates a more eager and happy worker, but also a more productive

one in offices to take a call past 5.00 PM. They are all out in the open on their bicycles, in the swimming pool or wielding a tennis or squash racket. No one has accused these employees of delivering low productivity!Long, sweat shop working hours are no guarantee to economic advancement. In fact, the most economically advanced countries have progressively reduced working hours: European Union countries have a low average of 36.4 hours per week. Of these the most advanced - Netherlands, Norway, Germany – average between 32.4 and 34.6 hours per week.

SEBI board meeting set to address allegations against chairperson Madhabi Puri Buch

MUMBAI. The first board meeting of the Securities and Exchange Board of India (SEBI) since Chairperson Madhabi Puri Buch came under scrutiny from Hindenburg Research and faced a series of charges from the Congress Party is scheduled for Monday. The board is expected to discuss the numerous allegations regarding non-disclosures and conflicts of interest against her, alongside a range of policy decisions related to consultation papers that have surpassed their public consultation deadlines.Notably, a formal agenda has not been finalised for this critical board meeting, according to sources. Should the allegations against Buch be addressed, she will need to recuse herself from the proceedings.On August 10, the New York-based short-seller Hindenburg Research levelled several allegations against Madhabi Buch and her husband, Dhaval, primarily concerning nondisclosure of income from her private advisory businesses to both the government and SEBI, as well as conflicts of interest arising from Dhaval's employment following her appointment.Subsequently, Congress spokesperson Pawan Khera raised

additional charges based on her income tax filings and other official documents. The Buchs have categorically denied all charges, describing them as "malicious and baseless," and have threatened legal action. While SEBI refrained from convening an emergency board meeting, it did issue a statement the following day, cautioning investors against reacting to allegations made by the short-seller and assuring them

that the regulatory framework in the country remains robust. The statement reaffirmed confidence in the regulatory leadership but did not delve into the specifics of the various disclosures.A SEBI source stated, "The Madhabi issue has been in deliberation for the past week or so, and the board cannot but discuss it. The nature of the allegations makes it clear that the board cannot ignore them."It is unusual that SEBI did not call for an emergency board meeting following the Hindenburg and Congress allegations, especially given that Madhabi Buch has participated in four public events in Mumbai since then, though she has avoided press interactions—contrary to her previous



practice of engaging with the media on the sidelines. Additionally, the government has yet to issue an official response to these allegations, with the only governmental action thus far being the Public Accounts Committee of Parliament inviting her for a performance review. Some observers argue that it is "unfair to expect the board to be answerable for the chairperson's alleged non-disclosures, as she has been appointed by the government."The board is also expected to discuss eleven consultation papers that have passed their public consultation deadlines and are ready for final decisions. Among the significant topics likely to be addressed are proposed measures to restrict retail

participation in the Futures and Options (F&O) segment—a development the market is watching closely—and regulations for a 'mutual fund lite' aimed at passively managed funds.Other discussions may include the introduction of a new asset class bridging Portfolio Management Services (PMS) and mutual funds, as well as an extension of the definition of 'connected persons' under insider trading norms

to include certain relatives. Since January, SEBI has published two studies highlighting the significant losses retail investors have faced in the derivatives market. The latest report, released last week, revealed that 93 percent of retail investors in the derivatives space lost an average of ?2 lakh each in the last three fiscal years ending March 2024, amounting to a collective loss of ?1.8 trillion during that period. The anticipated reforms concerning the derivatives framework are expected to have a considerable impact on the market, aiming to curb the gambling-like trading behaviours that have proliferated with daily expirations of indexderivative contracts.

LaLiga: Barcelona's perfect start ended after 4-2 Osasuna thrashing

New Delhi, Barcelona's perfect start to the LaLiga 2024/25 season came to an end as Osasuna thrashed them 4-2 on Saturday, September 28. Croatian striker Ante Budimir was the star of the show for the home side as he scored a brace to secure a major upset on Saturday.Barcelona manager Hansi Flick made strategic changes to his lineup, benching regular starters Lamine Yamal, Raphinha, and Inigo Martinez in preparation for their upcoming Champions League match against Young Boys. This decision, however, did not pay off as Osasuna, fuelled by a sold-out home crowd, adopted an aggressive approach from the start. They pressed high and utilised quick



counter-attacks that exploited the weaknesses in Barcelona's altered lineup. The scoring began in the 18th minute when Bryan Zaragoza, on loan from Bayern Munich, delivered a precise cross that Budimir headed home for the opener. MS Dhoni as uncapped player IPL's revived rule will not just benefit CSK

→ IPL 2025: MS Dhoni fans were overjoyed after the BCCI brought back the 'uncapped player' rule for retentions ahead of the mega auction. Former India opener Aakash Chopra highlighted that the rule will not just benefit CSK and the former India captain.

New Delhi, MS Dhoni has returned to the spotlight as the Board of Control for Cricket in India announced the retention and auction rules for the Indian Premier League (IPL) 2025. The organisers brought back the 'uncapped player' rule, which had existed from 2008 to 2020. The rule enables teams to buy an Indian player, who has not played international cricket in the last five years or hasn't had a central contract, as an uncapped player. An uncapped player can be bought for Rs 4 lakh while teams have to shell out at least Rs 11 crore to retain a capped player. The BCCI confirmed that a team can retain a total of six players through retentions and Right To Match (RTM) options. India Today has learnt that the first choice and the fourth



choice will have to be paid Rs 18 crore, while the second choice and the fifth choice need to be paid Rs 18 crore and the third option Rs 11 crore. Notably, the BCCI increased the overall purse to Rs 120 crore.MS Dhoni was expected to retire from the IPL at the end of the 2024 season after having hinted about his swansong last year. Dhoni won the IPL 2023 title, leading the Super Kings. Dhoni stepped down as captain and handed over the baton to Ruturaj Ĝaikwad in 2024, but he remained tight-lipped about his future after the end of the season. Dhoni stressed in the past that his future in the league would depend on the auction rules, as he has been conscious of not

impacting the purse of the team with his position in the team.

New Delhi Liverpool climbed to the top of the Premier League table with a hard-fought 2-1 victory over bottomplaced Wolverhampton Wanderers. Îbrahima Konaté scored his first-ever Premier League goal, and Mohamed Salah secured the win with a secondhalf penalty. → IPL 2025 Retention: The Indian cricket board reintroduced the uncapped player rule which enables a team to retain an Indian player who has not played international cricket in the last five calendar years for a reported sum of Rs 4 crore. The rule is likely to enable Chennai Super Kings retain MS Dhoni at a cost that would still enable them to go for big-money buys in the mega auction.

New Delhi. Cricket fans on social media have stepped up their meme game following the Board of Control for Cricket in India (BCCI) announcement regarding retention rules ahead of the Indian Premier League (IPL) 2025 auction. Among the major announcements, one notable change is the return of the uncapped player rule. Fans have

quickly drawn conclusions about this rule, highlighting the possibility of MS Dhoni continuing to play in the IPL, this time as an uncapped player.

In a significant announcement, which was slotted as the seventh in the eight-point list, the BCCI announced that Indian players, who hadn't played any international game for at least five calendar years would be considered an uncapped players. MS Dhoni retired from all formats of international cricket in August 2020, but the former captain played his last match for India in July 2019 - in India's World Cup semi-final defeat to New Zealand." A capped Indian player will become uncapped if the player has in the last five calendar years preceding the year in which the relevant Season is held, not played in the starting XI in International Cricket (Test match, ODI, Twenty20 International) or does not have a Central Contract with BCCI. This will be applicable for Indian

He had hinted after winning IPL 2023 with Chennai Super Kings that 2024 edition would be his last and he would see it as a way of giving it back to his fans. However, Dhoni has not announced retirement from the IPL and it looks likely that the 'uncapped player' rule might facilitate another season of Dhoni in the cash-rich T20 league.

The retention cost for an uncapped player in IPL 2025 will be Rs 4 cropre, according to news agency PTI.

Dhioni has been conscious about how his retention affects the Super Kings. In 2022, Ravindra Jadeja was paid Rs 16 crore as the retention fees by CSK while Dhoni got Rs 12 crore.On Saturday, the IPL announced each team can retain a maximum of six players. This can be either via retention or using the Right to Match (RTM) option. The six retentions/RTMs can have a maximum of 5 capped players (Indian and Overseas) and a maximum of 2 uncapped players.


