Bomb attack at former Manipur CM Koireng's residence kills 1 Sanjay Kumar

Imphal, Sep 6: The rocket which fell on the compound of former chief minister Mairembam Koireng's residence seemed to be an improvised one. An elderly man was killed and five others were injured after suspected militants launched a bomb attack on a residential area of Moirang in Bishnupur district on Friday afternoon, officials said. The rocket which fell on the compound of former chief minister Mairembam Koireng's residence seemed to be an improvised one. "The elderly man was preparing for some religious rituals in the compound when the bomb exploded. He died on the spot," the official said. The rocket fell at a spot around two km from the Indian National Army (INA) headquarters complex. On April 14, 1944, Lieutenant Colonel Shaukat Ali of INA hoisted the Tricolour of free India for the first time on Indian soil under the guidance of INA Supreme Commander Netaji Subhas Chandra Bose at Moirang. Earlier in the day, a rocket was fired from an elevated position in the nearby hill areas toward the low-lying residential locality of Tronglaobi, located around 45km from the state capital Imphal.

Jammu, Sep 6: Union Home Minister Amit Shah, Jammu and Kashmir BJP president Ravinder Raina, Union Ministers Jitendra

Singh and G Kishan Reddy and others release the party's election manifesto ahead of the state Assembly elections, in Jammu on September 6, 2024. Highlighting an appreciable decrease in terror-related and stone-pelting incidents in the past 10 years in Jammu and Kashmir, Union Home Minister Amit Shah on Friday asserted that Article 370 has become "history" and will never make a comeback. Releasing the BJP's manifesto for the Jammu and Kashmir Assembly polls at a press conference here, Shah also questioned Congress leader Rahul

Gandhi on his party's alliance with the National Conference (NC), and urged people to vote for the BJP to continue good governance. He said the last 10-year period will be written about in golden letters in the history of the country and Jammu and Kashmir. Shah reached Jammu earlier in the day on a twoday visit to kick-start the BJP's campaign for the Assembly polls scheduled to be held in three phases on September 18, 25 and the agenda of the NC and seen the Congress supporting it. I want to make it clear to the whole country that Article 370 and Article 35A have become history and will never make

a comeback," Shah said before talking about his party's manifesto. He said Article 370 is not part of the Constitution anymore. "This Article was the reason why weapons and stones were handed to the youth and they were then facilitated to tread the path of terrorism instead of contributing to development," Shah added. The BJP leader also accused the previous governments of bowing down before separatism, and said peace, development and social justice were restored on the ground after the abrogation of Article 370. "There used

to be a time when separatists were calling the shots and making demands. The governments were bowing down before groups like the Hurriyat Conference... different state and non-state actors linked to terrorism and separatism destabilised J&K as all the govern-record-breaking numbers," he said.

Shah added that the past 10 years saw peace, prosperity and development. "The sound of guns and bomb blasts used to be heard in Kashmir for a very long time but everything changed in the last 10 years. Any BJP candidate will defeat Phogat, Punia in Haryana: Brij Bhushan Singh

Gonda (UP), Sep 6: Former BJP MP and ex-WFI chief Brij Bhushan Sharan Singh on Friday sought to downplay wrestlers Vinesh Phogat and Bajrang Punia's foray into politics, saying any BJP candidate will defeat them if they contest in Haryana and also offered to campaign in the upcoming Assembly elections should his



party allow. Talking to mediapersons at his residence Vishnoharpur, about 40 km from the district headquarters, he said, "These wrestlers made a name in the sport and became famous on the strength of wrestling. Now after joining the Congress, their name will be erased." Earlier, Phogat and Punia, who were at the forefront of the wrestlers' protest against the then WFI chief Singh joined the Congress with a vow of "not being scared or backing off". There are indications that both or at least one might contest the October 5 Assembly polls in Haryana. Reacting to this development, Singh said, These people consider politics to be a wind. They are thinking that they will win the assembly elections from Haryana. They can contest from any assembly seat in Haryana, a small BJP candidate will defeat them." He went on to add: "If my party directs, I will also go and campaign in the Haryana Assembly elections. I claim that I will get maximum support from the people of their community. I am ready to campaign in favour of the BJP candidate in front of them as well." He also claimed that during the Lok Sabha elections, the "people of Haryana were saying that if you come and contest elections from here, we will make you win, but at that time I had refused them". Singh said many Congress leaders joined the wrestlers' protests in the name of getting justice for them. "One after the other, many wrestlers were made their pawns. Focus on Rahul Gandhi on his first visit to US as Leader of Opposition

Chandigarh, Sep 6: Congress MP Rahul Gandhi would visit the United States from September 8 to 10. This is his first visit to the US after this year's Lok Sabha elections, following which he became the

Leader of Opposition (LoP) in the lower house of parliament. According to Congress leaders, Rahul's itinerary comprises several interactions in Washington DC and Dallas, including at the University of Texas. The visit is being watched keenly by the Bharatiya Janata Party because his past statements on foreign soil have stirred up political controversies - during his last visit to the US in 2023, for instance, Gandhi attracted a lot of attention thanks to his criticism of the Indian government and its functioning. The BJP has severely criticised comments

Gandhi has made in his speeches abroad, asserting that criticism of the Indian government on foreign soil undermines the

country's global standing. The ruling party has also argued that domestic disagreements, if any, should be sorted in the country and not raked up on foreign soil. Apart from the expected interest among political observers and the media, what makes this

visit interesting is that it precedes Prime Minister Narendra Modi's expected visit to the US. Therefore, what Gandhi may say in the US could set the narrative for the PM to follow in his meetings with the Indian Diaspora. Gandhi will meet academics, journalists, representatives of think-tanks, technocrats, businessmen and other people from the Indian Diaspora and local com-

munities, according to Congress leaders. They say that Gandhi has evoked a lot of overseas interest after the party's "good run" in the Lok Sabha elections and him becoming the LoP. The Indian Overseas Congress claims that it has been "bombarded with requests" for meetings with Gandhi. Party leaders say that after the 2024 Lok Sabha elections, the post of the LoP has gained prominence after 10 years, and the "world wants to listen to Gandhi, his views on democracy, Constitution and India's future". "Since Mr Rahul Gandhi has become the Leader of Opposition, I as chairman of the Indian Overseas Congress with presence in 32 countries have been bombarded with requests from Indian diaspora, diplomats, academicians, businessmen, leaders, and international media for interactions with Mr Rahul Gandhi.

SC dismisses RG Kar ex-principal's plea challenging HC order

Adani delivers Teacher's Day lecture at Mumbai college that rejected him Mumbai: Sep 6: Gautam Adani had in

the late 1970s applied for admission to a Mumbai college, but his application was rejected. He did not pursue education but turned to business and went on to build a USD 220 billion empire. About four-anda-half decades later, he was invited to the college to deliver a lecture on Teachers Day. Adani moved to Mumbai at 16 and began working as a diamond sorter. Around the same time in 1977 or 1978, he applied for admission at the city's Jai Hind College. "But they rejected him," said Vikram Nankani, President of the Jai Hind College Alumni Association, as he introduced India's second richest person before the lecture. Gautam had applied to Jai Hind College because his older brother Vinod had studied there. "Fortunately or unfortunately, the college did not accept him and he went on to work full time and pursued an alternative career," Nankani said, declaring Gautam Adani as a "deemed alumni" since he had applied to join. After working as a diamond sorter for almost two years, he returned to Gujarat to run a packaging factory managed by a brother. He never really looked back after he launched his firm in 1998, trading in commodities. Over the next two-and-half-decades, his debt-fuelled companies diversified into ports, mines, infrastructure, power, city gas, renewable energy, cement, real estate, data centres and media. The infrastructure tycoon, who runs 13 seaports in India, operates seven airports, is the largest private player in power, is the biggest renewable energy producer, runs the country's second-largest cement company, is building expressways and re-developing Asia's largest slums, is described by some as the most aggressive of India's new generation of entrepreneur. When will full statehood return to J-K, why has security situation deteriorated there: Jairam

New Delhi, Sep 06: The Congress on Friday took a swipe at Home Minister Amit Shah over the government's policy on Jammu and Kashmir, asking when full statehood would be restored and why the security situation there had "deteriorated under your watch". Congress general secretary in-charge communications Jairam Ramesh also asked why the Centre was attempting to "infringe" on the Jammu and Kashmir political executive's powers and why the economic situation in the Union Territory had only "declined" since 2019. "The self-styled Chanakya is in Jammu and Kashmir today. Since the fall of the PDP-BJP government in 2018, Jammu and Kashmir has been administered primarily by the home ministry," he said in a statement, adding that there were four questions the "swaghoshit (self-declared) Chanakya" should answer about his governance. Ramesh alleged that since 2018, the people of Jammu and Kashmir were denied any avenue to express grievances and the region had become a bureaucratic fiefdom controlled by

the BJP-RSS cabal. "While claiming to have asked if the Home Minister could give a Jammu and Kashmir. "The mood on the

the government has, in fact, created an extra-special situation of a new and unique political system: one where the state has been downgraded to a Union Territory, elections have been suspended, and all norms of constitutional morality violated," he alleged. In his speech in Parliament on December 11, 2023, Shah said that full statehood to Jammu and Kashmir would be restored at an "appropriate time", Ramesh pointed out. Sale of ultra-luxury properties across five cities: Mumbai grabs lion's share

MUMBAI. Of the 25 ultra-luxury properties sold across the top five cities in 2024 so far, Mumbai sold 21 units collectively worth Rs

Sale of ultra-luxury homes - units priced over Rs 40 crore each - remained strong in 2024 despite spiralling prices, said a report by Anarock. Its latest data released on Thursday finds that a total of 25 ultraluxury homes were sold in Mumbai, Hyderabad, Gurugram and Bengaluru in the first eight months of 2024 for a collective sales value of Rs 2,443 crore. Pune, Chennai and Kolkata did not record any sales in this price bracket.

Of the total of 25 ultra-luxury homes sold in 2024 so far, at least 20 were high-rise apartments worth about Rs 1,694 crore. The remaining five sales were of bungalows cumulatively worth about Rs 748 crore. At least two separate ultra-luxury home deals collectively worth Rs 80 crore were closed in Hyderabad's Jubilee Hills. Gurugram in NCR witnessed one ultra-luxury home sold for Rs 95 crore, while Bengaluru also closed one deal worth Rs 67.5 crore.

Anuj Puri, chairman, Anarock Group, said, "The whole of 2023 saw about 61 deals with a cumulative sales value of approximately Rs 4,456 crore in Mumbai, Hyderabad, and Gurugram. With four months remaining in 2024 and the festive quarter from Oct to Dec ongoing, we are likely to see more such large ticket-size residential deals happening before the year

Andheri's Gokhale Bridge deadline extended to April next

MUMBAI. The BMC has started moving the second girder of Andheri's Gokhale Bridge, nearly seven months after its partial reopening. The civic body moved 25 metres of the 86-metre girder between Wednesday and Thursday. The BMC has set a new deadline (April 30, 2025) for the full commissioning of the bridge.

BMC said work on the railway overbridge section of the flyover in the second phase is expected to be finished by the middle of Nov this year. "Additionally, the approach road work within municipal limits is planned to be completed by April 30, 2025," said an official.

The operation to move the southern iron girder of the bridge, connecting Andheri East and West, started at 10pm on September 4 and continued until 5am on September 5.

BMC said, "After obtaining permission from the Western Railway administration and receiving the next railway block, the remaining distance will be covered. Installing the girder is an extremely challenging task. According to the approved plan and instructions from Western Railway, this work is progressing under the technical supervision of RITES Limited. This work is being carried out after assessing risks and technical aspects and obtaining blocks for railway traffic and power supply. Moving the initial 25 metres of the total 86 metres was challenging, but with its success, moving the remaining distance will be relatively easier.

Badlapur station firing: Accused booked for attempt to murder

NEW DELHI. A 25-year-old man has been charged with attempted murder after allegedly opening fire at two people, injuring one, at Badlapur railway station in Thane district, Maharashtra, on Thursday around 6 pm. The incident, which police said was the fallout of business rivalry, took place at platform number 1 at around 6 pm on Thursday when the suburban station on the Central Railway route was chock-a-block with commuters.

Vikas Nana Pagare, the accused, is now facing charges under the Bharatiya Nyaya Sanhita (BNS) and the Arms Act.

Senior inspector Pandhari Kande of the Kalyan Government Railway Police (GRP) confirmed the registration of an FIR against Pagare for attempt to murder. Efforts are underway to determine if more individuals were involved in the shooting besides Pagare.

The entire incident was recorded on cameras, and a video of the event quickly went viral on social media. Following the shooting, Pagare attempted to escape by running towards the railway tracks but was apprehended by policemen on duty with the help of some commuters. The injured person, Shankar Sansare, was immediately taken to a local hospital and treated for gunshot wounds. The second man targeted by Pagare managed to escape unhurt, though his identity has not been disclosed. "The incident was a result of professional rivalry over a TV cable business between the individuals involved," police stated, adding that both the assailant and the duo he targeted have criminal records. Initially, a fight broke out between Pagare and the duo outside the railway station.

Bihar hospital, awaiting inauguration for 10 years, becomes haven for thieves

A government hospital in Bihar, built at a cost of Rs 5 crore and equipped with modern facilities, has become a derelict structure abandoned for almost 10 years even without an inauguration.

Muzaffarpur. A government hospital in Bihar's Muzaffarpur, built at a cost of crores, has become a derelict structure in the middle of a field and a haven for thieves and vandals, as it was apparently abandoned without ever being inaugurated.

The 30-bed hospital, situated on six acres in the Chand Pura area, was built in 2015 at a cost of Rs 5 crore. Although it was equipped with modern facilities, not a single patient was treated there, and the medical devices were left to deteriorate.

As it nears ten years since its construction, the hospital has not been taken over by the health department, and officials allegedly claim to be unaware of

ED attaches assets worth Rs 55 crore linked to ex-DMK leader Jaffar Sadiq

Chennai. The Enforcement Directorate (ED) has attached assets worth Rs 55.3 crore belonging to former DMK functionary Jaffar Sadiq and his associates under the Prevention of Money Laundering Act (PMLA).

The attached assets include 14 immovable properties, such as the JSM Residency Hotel and a luxurious bungalow, as well as seven high-end vehicles, including Jaguar and Mercedes cars, which the ED claims were acquired through criminal activities.

The action follows an investigation into the smuggling of pseudoephedrine and ketamine by an international drug cartel, of which Sadiq is alleged to be the kingpin. The probe, based on investigations by the Narcotics Control Bureau (NCB) and

customs, led to searches at 15 locations across Tamil Nadu.

The ED found that Sadiq, along with his brother Mohammed Saleem and others, were actively involved in exporting and concealing pseudoephedrine and other narcotics. Sadiq, who held positions in various firms, allegedly used these entities to channel and launder proceeds from drug trafficking.

According to the ED, the proceeds of the crime were invested in legitimate ventures such as real estate, film production, hospitality, and logistics. The funds were moved through a network of bank accounts controlled by Sadiq and his family, deposited and layered through The ED stated that further investigation into financiers, and recorded as unsecured

loans in financial statements.

"This entire set up was used to route the Proceeds of Crime (PoC) earned from the illicit drug trafficking," the ED stated. Sadiq was arrested by the ED on June 26,

2024, and his brother Mohammed Saleem was arrested on August 12, 2024.

"The PoC were channelled into these investments through a network of bank accounts, including those controlled by Sadiq and his family members. The illicit cash was deposited, layered by financiers, and recorded as unsecured loans in financial statements. The funds were used to acquire both immovable and movable assets," the agency added.

A case has been filed against the director of the film, Yogaraj Bhat, and two others, including the manager, named Suresh, who have been accused of negligence in implementing adequate safety measures during the shoot.

The deceased belonged to Tumakuru district's Koratagere. The incident occurred at the VRL arena situated on the northern outskirts of Bengaluru. Kumar was living with his brother in a Bengaluru neighbourhood and worked as light boys in the film industry.

Kitchen staples dearer: Coriander at Rs 600 per kg, potatoes Rs40

Noida. The prices of all vegetables, especially potatoes and onion, shot up at retail shops during the last week, following a similar trend in the wholesale market. The skyrocketing prices were attributed to the monsoon, which led to supply shortages due to crop damage caused by rain and humidity. At Sector 27's Indira Market, onions were sold at Rs 60 per kg, 50% higher than last week's Rs 40. Potato prices have nearly doubled at Rs 40 per kg compared to around Rs 20 per kg a week ago. Sadanand Sah, a vegetable seller, listed the current prices — cucumbers were being sold at Rs 60 per kg against last week's Rs 40, radish at Rs 60, up from Rs 40, brinjal at Rs 80, up from Rs 60, cauliflower at Rs 120, up from Rs 100, ginger at Rs 160, up from Rs 120, and garlic at Rs 400, up from Rs 300 last week. Meanwhile, the price of tomatoes has decreased from Rs 70 to Rs 50 per kg due to fresh arrivals, while the price of pumpkin has remained constant at Rs 40 per kg for two weeks.

'The govt should keep the vegetable prices in check as they affect each household," said Aanchal Kumari, a resident of Sector 26 who was shopping at the Indira Market.Sonu Kumar, another vegetable seller in the Sector 12 market, said that there is a 20-30% price increase in all vegetables due to the monsoon at his store. "We get the vegetables from Azadpur Mandi and Ghazipur Mandi. The prices have increased at the wholesale market as well and this rise is reflecting at the retail shops," he said. The price hike has also devoid customers of complementary coriander leaves and green chillies by the shopkeepers.

Gurgaon's maximum temperature up 2.2°C, rain likely for 3 days

Gurgaon. With no rainfall, the city's maximum temperature rose by 2.2 notches in the past 24 hours. At 34 degrees Celsius, it was 1 degree above normal. The India Meteorological Department (IMD) said partly cloudy skies with one or two spells of rain or thundershowers are likely for the next three days. The minimum temperature, meanwhile, dropped marginally from 24.6 degrees Celsius on Wednesday to 24.3 degrees on Thursday, near normal for this time of the year. The humidity level increased to 69% on Thursday, from 45% the day before. No weather alert has been issued. "Scattered light to moderate rain is very likely over Punjab, Haryana, Chandigarh, Delhi and west Rajasthan this week in isolated areas for the next three days. No heavy rain is likely this week," said an IMD official. The maximum temperature during this period will range between 34 and 35 degrees Celsius, while the minimum temperature is expected to settle between 25 and 26 degrees. Meanwhile, the city's air quality index (AQI) remained 'satisfactory' at 70 on

Lessons from BJP rebellion Cong likely to delay release of first list of candidates

Gurgaon: Congress is set to delay the announcement of its first list of candidates for Haryana elections by at least two days to avoid triggering discontent within party ranks as consultations continue over a possible alliance with AAP.Party sources told TOI that the decision was taken because BJP is grappling with defections and internal strife after it released the party's first list of 67 candidates for polls to Haryana's 90member assembly."The Congress high command is treading cautiously to avoid a similar reaction from ticket aspirants. The party is reviewing each constituency and considering all factors before making any announcements," a Congress functionary said on Thursday. Congress, which is riding on a revival wave after bagging half of the parliamentary seats from Haryana in the general election earlier this year, has finalised the names for 66 assembly constituencies. But the remaining seats require further deliberations.

On Thursday, Congress in charge for Haryana Deepal Babaria also hinted at the delay and said final decision on ticket nominations might take a few more days.

"The delay is also attributed to the ongoing seat-sharing negotiations under the INDIA alliance, which includes the Aam Aadmi Party and other regional parties. Congress is keen on aligning its strategies with alliance partners, and any disagreements or unresolved issues in seat distribution could further postpone the list," the functionary quoted above said. Another faction that is of concern is nominating candidates backed by senior Congress functionaries Kumari Selja and Randeep

Get pollution cert in 3 mths to operate: NGT to hotels, restos & malls

Ghaziabad. The National Green Tribunal (NGT) directed on Wednesday hospitality establishments hotels, malls, banquet halls, restaurants with seating capacity of 36 upwards — in the district to obtain consent to operate certificate from the state pollution control board within 3 months or face shut down. The certification allows for the discharge of effluent (sewage or trade effluent) into a sewer or land, as well as the emission of air pollutants.NGT asked the UPPCB to take "punitive, preventive, prohibitive and remedial steps including, assessment and recovery of environmental compensation, expeditiously " against establishments that were previously granted time by it to obtain consent to operate certificate but had not done so. Compliance conditions mentioned in consent to operate certifiactes must be abided by the establishments and this has to be made sure by the board, it added. The directive came in the wake of an original application filed by environmentalists Pradeep Dahalyia and Prasoon Pant in NGT last year. The duo had alleged that 21 large hospitality entities in the city were not following environmental norms and were causing pollution.

2 cases against him, 1 still in court; yet, he sat on cow protection pane

GURGAON. Anil Kaushik, main accused in the murder of a 20-year-old Class XII student on Aug 24, has been booked in the past in two cases of phone snatching and extortion, contradicting initial claims by cops that he had no criminal history. One of the cases, in fact, has gone to trial. This, evidently, did not come in the way of Kaushik (37) being inducted in the 11member district cow protection task force in Faridabad. Kaushik also holds an arms licence, but with the announcement of polls on Aug 16, the firearm was deposited in the armoury at the time of the incident, police said.Kaushik was carrying a country-made gun with which he allegedly shot Aryan Mishra, who sustained two bullet injuries, the first when Kaushik and his cow vigilante associates were chasing Aryan's car on the Agra highway from Faridabad to Palwal and the next one when Aryan's car had stopped and the vigilantes shot him again point-blank.Kaushik was accused in a cellphone snatching case registered in 2018 at Mujesar police station in Faridabad. He is among the four accused against whom police filed a charge sheet



in May 2019. The case is currently under trial in the Faridabad district sessions court. Police sources said the other case against Kaushik is on extortion charges. But details were not available. According to Haryana Gau Seva Ayog officials, Kaushik joined the Faridabad district cow protection task force in 2023 as a member. Asked about background checks for non-official members, a senior

member of the Ayog said before an appointment, a police verification is mandatory. "If it was a heinous case, I think they would have flagged it. If it is not a serious allegation, then innocent till proven guilty applies," said the member. According to the FIR in the phonesnatching case, at 10.30pm on June 24, 2018 complainant Chhotu Kumar, an automobile company worker, was

returning home when his phone was stolen. "I was talking on the mobile phone while walking back home. When reached a chowk behind Mujesar PS, two unknown men suddenly came from behind and snatched my phone," Kumar alleged. A case was registered under section 379A (snatching) of the IPC on July 31. After investigating the case, Gurudutt alias Amit, Kaushik, Rahul and Sushil were arrested in the first week of Aug 2018. In view of the murder case registered against Kaushik now, his gun licence will come under scrutiny. "Once the investigation is completed, we will receive a recommendation to review or suspend the licence. Based on that, we will initiate appropriate action," said a senior police officer. The crime branch has, meanwhile, identified the person from whom Kaushik had procured the illegal firearm and the ammunition that was allegedly used to kill Aryan. "Linking the murder weapon to the accused is crucial to establish culpability. We have identified the gun supplier too," said a crime branch officer.

Eye on core voter base, Congress may field Punjabi candidate from Gurgaon

Gurgaon. In its first list for the upcoming state polls, BJP has placed its bet on Brahmin candidate Mukesh Sharma for the Gurgaon seat, surprising many party workers. While BJP's move is seen as an attempt to appease the Brahmin community, it now faces the challenge of balancing its core Punjabi and Vaishya voter base. In turn, Congress is likely to field a Punjabi candidate to reap benefits from the situation. Sources in the party said Mohit Grover is likely to emerge as the frontrunner if Congress selects a Punjabi nominee. But Grover, despite contesting as an Independent last time, has been relatively inactive in local politics, leading the party to also consider alternatives, including actorturned-politician Raj Babbar.On the other hand, former CM Bhupinder Hooda's reluctance to launch new faces in the fray could pose a challenge.Political experts believe the selection by BJP has also upset several BJP hopefuls. Mukesh Sharma previously contested the 2009 elections from the Badshapur seat but faced a heavy defeat."His selection by BJP from Gurgaon has raised eyebrows within the party. He had contested the 2014 polls against BJP as an Independent.

55% drop from July: Legacy waste processing in Aug lowest this year

Gurgaon: Private agencies hired by MCG treated a mere 53,935 metric tonnes (MT) of legacy waste at Bandhwari in Aug, the lowest amount processed in the past nine months and a 55% decrease compared to the 1.2 lakh MT processed in July.MCG earlier told National Green Tribunal (NGT) that it would clear all legacy waste at Bandhwari by Dec end this year. Meeting this deadline, however, appears to be a daunting task for the corporation, as the daily waste processing capacity has plummeted to 2,000 MT per day, from 4,000 MT a few months ago. According to MCG data, the agencies engaged for legacy waste management at the landfill site processed 69,696 MT waste in Jan, 1.9 lakh MT in Feb, 2.3 lakh MT in March, 2.2 lakh MT in April, 2.5 lakh MT in May, and 3.5 lakh MT in June (see gfx). Meanwhile, the landfill received over 4.1 lakh MT of waste from Gurgaon and Faridabad, the maximum in July (91,550 MT). The corporation has attributed the decline in waste processing to the monsoon.

Joe Biden's son Hunter pleads guilty in \$1.4 million tax evasion case

World Hunter Biden, son of U.S. President Joe Biden, pleaded guilty to federal tax charges on Thursday, a surprise move that avoids a potentially embarrassing trial weeks before the U.S. presidential election. Biden had been set to stand trial in a Los Angeles federal courthouse on criminal charges of failing to pay \$1.4 million in taxes while spending lavishly on drugs, sex workers and luxury items. Judge Mark Scarsi told Biden he faces up to 17 years in prison and up to \$450,000 in penalties. He set sentencing for December 16. Defendants who plead guilty in criminal cases typically work out an agreement with prosecutors beforehand, hoping to receive a lower sentence in exchange for avoiding trial.

That did not appear to be the case here. Earlier in the day, Biden had offered to plead guilty to the charges but avoid admitting wrongdoing, an unusual legal manoeuvre called an "Alford plea." Prosecutors opposed that move. After a break, Biden's lawyer, Abbe Lowell, told the judge that he would plead guilty, despite having no prior agreement with prosecutors that would ease his sentence. In a statement after the hearing, Biden said he pleaded guilty to spare his family from having to sit through a trial that would have aired messy details from a period of his life where he was suffering from drug addiction. "For all I have put them through over the years, I can spare them this," he said. He added that he had paid back his taxes. Lowell told repoters afterward that Biden might appeal his sentence. He did not answer when asked why Biden waited until the trial's opening day to plead guilty.

Bangladesh: Hindu boy accused of blasphemy, thrashed by mob inside police station

New Delhi A 15-year-old Hindu boy named Utsav Mondal was brutally beaten by a mob inside a police station in Bangladesh after he was accused of making derogatory remarks about the Prophet Muhammad on social

The incident took place on Wednesday night in the Sonadanga residential area of Khulna.

Local media reports initially suggested that Mondal had succumbed to his injuries, but Khulna Metropolitan Police's Deputy Commissioner (South), Mohammad Tajul Islam, later confirmed to India Today that the teenager is alive and receiving treatment.

He is admitted to an army hospital and is out of danger," Islam said. The incident occurred around 11:45 PM when a group of local madrasa students brought Utsav to the police station, accusing him of posting "objectionable comments" on Facebook about the Prophet. Tensions escalated quickly as more students and members of the Imam Association gathered outside the police station, demanding immediate and severe punishment for the boy. Mohammad Tajul Islam recounted the sequence of events stating that initially, the students demanded that Utsav be judged according to their own laws, which involved execution. The deputy commissioner assured them that a case would be filed under existing laws, but this did not satisfy the crowd. The situation turned volatile as the number of protestors swelled to nearly thousand by evening, creating a highly charged atmosphere outside the police

China's Xi promises \$50 billion for Africa over next three years

BEIJING. Chinese leader Xi Jinping pledged on Thursday more than \$50 billion in financing for Africa over the next three years, promising to deepen cooperation in infrastructure and trade with the continent as he addressed Beijing's biggest summit since the Covid pandemic. More than 50 African leaders and UN Secretary-General Antonio Guterres are attending the China-Africa forum, according to state media. African leaders already secured a plethora of deals this week for greater cooperation in infrastructure, agriculture, mining, trade and energy.Xi hailed ties with Africa as their "best period in history" as he addressed the leaders at the forum's opening ceremony in Beijing's ornate Great Hall of the People on Thursday.

"China is ready to deepen cooperation with African countries in industry, agriculture, infrastructure, trade and investment," he said. "Over the next three years, the Chinese government is willing to provide financial support amounting to 360 billion yuan (\$50.7 billion)," Xi said. More than half of that will be in credit, he said, with \$11 billion "in various types of assistance" as well as \$10 billion through encouraging Chinese firms to invest.

He also promised to help "create at least one million jobs for Africa".Xi pledged \$141 million in grants for military assistance, saying Beijing would "provide training for 6,000 military personnel and 1,000 police and law enforcement officers from Africa".Guterres told the forum that growing ties between China and Africa could "drive the renewable energy revolution"

"China's remarkable record of development -including on eradicating poverty — provides a wealth of experience and expertise," he said.

Chinese foreign minister Wang Yi hailed the summit as a "complete success" at a joint news conference with his Senegalese and Congolese counterparts later on Thursday.

Brazilian court orders two slaughterhouses to pay for Amazon reforestation

A court in Brazil has convicted two beef slaughterhouses guilty of buying cattle from a protected area and directed them to pay \$764,000 for causing environmental damage and reforestation of the Amazon forest.

Brasilia A judge in the Brazilian state of Rondonia has found two beef slaughterhouses guilty of buying cattle from a protected area of former rainforest in the Amazon and ordered them, along with three cattle ranchers, to pay a total of \$764,000 for causing environmental damage, according to the decision issued Wednesday. Cattle raising drives Amazon deforestation. The companies Distriboi and Frigon and the The lawsuits are based on transfer ranchers may appeal. Father of US teen who killed 4 in Georgia school shooting arrested

World Georgia state officials arrested the father of the 14-year-old suspected school shooter Colt Gray on Thursday in connection with Wednesday's shooting that killed four people and wounded nine at Apalachee High School.Colin Gray, 54, was charged with four counts of involuntary manslaughter, two counts of seconddegree murder and eight counts of cruelty to children, the Georgia Bureau of Investigation said."These charges stem from Mr. Gray knowingly allowing his son Colt to possess a weapon," Chris Hosey, director of the Georgia Bureau of Investigation, told a media conference.Colt Gray has been charged with four counts of felony murder and would be tried as an adult, officials said.

Both Grays had been questioned by local officials in neighbouring Jackson County last year in connection with an online threat to commit a school shooting, but there was no probable cause for their arrest, the FBI said on Wednesday.

In that 2023 probe, the father said he had hunting guns in the house but that his son did not have unsupervised access to them, and the son denied making the threats online, the FBI said.

Georgia state and Barrow County investigators say the younger Gray used an "AR platform style weapon," or semi-automatic rifle, to carry out the attack in which two teachers and two 14-year-old students were killed. It remained unclear how the shooter obtained the weapon. Investigators have yet to comment on what may have motivated the first U.S. campus mass shooting since the start of the school year.Jackson County sheriff's investigators closed the case after being unable to substantiate that either Gray was connected to the Discord account where the threats were made, and did not find grounds to seek the needed court order to confiscate the family's guns, according to police reports released by the sheriff's office on Thursday. "This case was worked, and at the time the boy was 13, and it wasn't enough to substantiate.


Singapore jails Gurkha Contingent officers for running unlawful cross-border money transfer services

Deputy Public Prosecutor (DPP) Brian Tan told the court that sometime in or before June 2021, Pratik began offering a money remittance service to the other GC officers within their camp.

SINGAPORE. Five officers from the Gurkha Contingent (GC), Singapore's most trusted police force division, were sentenced to jail terms after they pleaded guilty to operating unlawful cross-border money transfer services, with each man's case involving transactions between SGD 1,03,473 and SGD 2.86 million. They were given jail sentences on Thursday after they pleaded guilty to charges under the Payment Services Act (PSA), The Straits Times reported. The Gurkha officers from a special unit of the police force are deployed in sensitive areas here. Officer Sitaram Tamang's case involved over SGD 2.86 million in total and he was sentenced to five months in jail.

The 40-year-old had pleaded guilty to a charge under the PSA involving nearly SGD 1.6 million. Three other charges were also considered during sentencing. Dik Bahadur Gurung, 32, was sentenced to 14 weeks in jail after he pleaded guilty to two

charges relating to more than SGD 1 million in total.Ganga Prasad Rai, 43, pleaded guilty to two charges involving more than SGD 6,00,000 and was sentenced to 10 weeks in jail. Ashok Kumar Thapa Magar, 39, and Mingmar Sherpa, 44, pleaded guilty to one charge each under the PSA.Mingmar's case involved nearly SGD 4,72,000, and he was sentenced to seven weeks in jail, while Ashok, whose case was linked to more than SGD 1,03,000, was ordered to spend four weeks behind bars. The prosecution said that a sixth man, Pratik Tamang, 41, is linked to some of the charges.He joined the GC in 2004 and returned to Nepal in February 2022 after his retirement.He is still at large, according to the Strait Times.Deputy Public Prosecutor (DPP) Brian Tan told the court that sometime in or before June 2021, Pratik began offering a money remittance service to the other GC officers within their



documents, he later recruited Ganga and Dik to work with him.He also engaged Sitaram to help him collect the money.Pratik was already in Nepal when Sitaram worked with him between February and July 2022 to provide an unlawful payment service in Singapore.DPP Tan said, "Under the arrangement, GC officers looking to remit money from Singapore dollars to Nepalese rupees (NPR) from Singapore to Nepal would contact Pratik via his

mobile number." After informing Pratik of the amount in dollars that they were looking to remit, Pratik would first transfer the equivalent amount in NPR to the remitters' beneficiaries in Nepal."He would then ask the remitters to contact Sitaram in Singapore to transfer the equivalent value in dollars to Sitaram's bank account linked to the payment platform PayNow.Nearly USD

1.6 million involving 111 deposits went through the bank account.After that, Sitaram would arrange to hand over the remittance monies in dollars to Pratik, either by PayNow transfers to the latter's bank account or in cash to Pratik's friends.Between February and July 2022, Ganga engaged in a conspiracy with Sitaram and Pratik to offer a cross-border money transfer service. Ganga then collected more than SGD 2,43,000. which he handed over to Sitaram.

Feeling the heat as Earth breaks yet another record for hottest summer

World Summer 2024 sweltered to Earth's hottest on record, making it even more likely that this year will end up as the warmest humanity has measured, European climate service Copernicus reported Friday. And if this sounds familiar, that's because the records the globe shattered were set just last year as human-caused climate change, with a temporary boost from an El Nino, keeps dialing up temperatures and extreme weather,

The northern meteorological summer — June, July and August — averaged 16.8 degrees Celsius (62.24 degrees Fahrenheit), according to Copernicus. That's 0.03 degrees Celsius (0.05 degrees Fahrenheit) warmer than the old record in 2023.

American, British and Japanese records, which start in the mid-19th century, show the last decade has been the hottest since regular measurements were taken and likely in about 120,000 years, according to some scientists. The Augusts of both 2024 and 2023 tied for the hottest Augusts globally at 16.82 degrees Celsius (62.27 degrees Fahrenheit). July was the first time in more than a year that the world did not set a record, a tad behind 2023, but because June 2024 was so much hotter than June 2023, this

summer as a whole was the hottest, Copernicus Director Carlo Buontempo said. 'What those sober numbers indicate is how the climate crisis is tightening its grip on us," said Stefan Rahmstorf, a climate scientist at the Potsdam Institute for Climate Research, who wasn't part of the research.

Copernicus records go back to 1940, but It's a sweaty grip because with the high temperatures, the dew point — one of several ways to measure the air's humidity — probably was at or near record high this summer for much of the world, Buontempo said.Until last month Buontempo, like some other climate scientists, was on the fence over whether 2024 would smash the hottest year record set last year, mostly because August 2023 was so enormously hotter than average. But then this August 2024 matched 2023, making Buontempo "pretty certain" that this year will end up hottest on record."In order for 2024 not to become the warmest on record, we need to see very significant landscape cooling for the remaining few months, which doesn't look likely at this stage," Buontempo said.

With a forecasted La Nina — a temporary natural cooling of parts of the central Pacific - the last four months of the year may no longer be record-setters like most of the past year and a half. But it's not likely cool enough to keep 2024 from breaking the annual record, Buontempo said.

These aren't just numbers in a record book, but weather that hurts people, climate scientists said."This all translates to more misery around the world as places like Phoenix start to feel like a barbecue locked on high for longer and longer stretches of the year," said University of Michigan environment dean and climate scientist Jonathan Overpeck.

Decision soon on Hatkeshwar flyover bid

Ahmedabad. At a meeting held on Thursday, the standing committee deliberated on measures to address the problem of waterlogging in various areas of the city and the demolition of Hatkeshwar flyover.

Standing committee chairman Devang Dani said, "Waterlogging issues arose at locations such as Madhumalti housing scheme and Makarba police headquarters. All the officials have been directed to examine these spots and create an action plan within the next 50 days to prevent waterlogging in these

He said that an agency has finally placed a bid for the project involving demolition and reconstruction of the Hatkeshwar flyover. Three previous attempts to secure a contractor for this purpose had been unsuccessful. The process of finalizing the bid is expected to conclude in 15 days.

Besides, in response to requests from local residents for improved lighting in specific locations, the authorities have commissioned the installation of 3,000 additional streetlight poles. Directions have been given to initiate the required tendering procedure for the same.

Dani said that complaints have been received that nearly 20% of the installed CCTV cameras in the city are non-functional. Officials have been directed to ensure all cameras are operational. Are Haryana regional parties fighting for their existence?

With the influence of national parties in Haryana continuing to dominate, it is a stiff challenge ahead for the regional parties to stay relevant in the upcoming Assembly polls.

Chandigarh. The influence of national parties in Haryana continues to overshadow regional parties, with Congress and BJP dominating the 2019 Assembly elections. Congress secured 36.49 per cent of the vote, while BJP garnered 28.08 per cent. The Jananayak Janata Party (JJP) emerged as the thirdlargest party, winning ten seats with 14.80 per cent of the vote.

The Indian National Lok Dal (INLD), once a dominant regional force, saw its popularity wane after the formation of JJP. Internal disputes within the Chautala family were blamed for INLD's downfall. In the 2019 elections, INLD's vote share dropped to 2.44 per cent, winning only one seat, while JJP played the role of kingmaker.

Although the JJP initially looked poised to replace the INLD, internal divisions led to its decline. By 2024, four of its ten MLAs joined the BJP, while others sought Congress tickets. Only Dushyant Chautala, his mother Naina Chautala, and one other MLA remain with JJP.

The 2024 Lok Sabha elections reflected the declining popularity of both JJP and INLD. JJP's vote share plummeted to 0.87 per cent, while INLD's dropped to 1.74 per cent. The



Jat community, once the core vote bank of these parties, shifted its support to Experts predict that the 2024 Haryana Congress. In a bid to survive, INLD formed an alliance with the Bahujan Samaj Party (BSP), while JJP joined hands with the Azad Samaj Party (ASP), which would contest Haryana elections for the first time. JJP has promised 20 seats to ASP, and Chautalas will select their candidates. However, the BSP's influence in Haryana has been minimal, with its vote share declining to 0.16 per cent in 2019.

According to Professor Gurmeet Singh, a political analyst from Punjab University, both JJP and INLD are fighting for survival and positioning themselves as

kingmakers in the upcoming elections. However, their popularity is on a continuous

Whatever may be claimed, the reality is that the popularity of both these parties is continuously falling. Both parties are contesting the elections with the thought that if they are not in a position to form the government, they will at least be successful as kingmakers," said Professor

Assembly elections will see a direct contest between Congress and BJP, with regional parties struggling to stay relevant. Professor Singh noted that the INLD, which once posed a strong challenge to national parties, lost its footing after its disintegration.

Historically, regional parties in Haryana have struggled to maintain power. INLD, led by Om Prakash Chautala, managed to serve a full term only once between 2000 and 2005. The political landscape in Haryana has now shifted significantly, with regional parties marginalised and fighting for their existence.

HC starts proceedings in PIL against Chd add'l public prosecutor

Chandigarh. The Punjab and Haryana high court has initiated proceedings in a PIL seeking the removal of Charanjit Singh Bakshi as the additional public prosecutor of Chandigarh and senior panel counsel of the Centre. The petition filed by Sanjeev Kochhar and Thakur Amandeep Singh challenged Bakshi's appointment, citing alleged gross misconduct and legal disqualifications. Representing the petitioners, advocate Sumit Mehta and his legal team presented the case before the high court. The petition contended that Bakshi allegedly secured his appointments through fraudulent concealment of serious misconduct, including the unauthorised recording of court proceedings and the manipulation of judicial records. Advocate Mehta emphasized the gravity of these allegations, claiming that Bakshi's actions not only violated the Contempt of Courts Act, 1971, but also undermined the integrity of the judicial system. In a hearing presided over by Chief Justice Sheel Nagu and Justice Anil Kshetarpal last month, the court stated that while the petition appeared lacking in immediate substance, the serious nature of the allegations warranted a detailed response from Bakshi. As a result, the court issued a notice to Bakshi and his appointing authorities, demanding their replies by September 23. In his arguments, advocate Mehta outlined Bakshi's disqualification based on two successive criminal contempt proceedings. According to the petition, Bakshi was found guilty of making unauthorised recordings of judicial proceedings, a violation that should have rendered him ineligible to hold public office under Section 34(1) of the Advocates Act, 1961, and

ED raids relative of ex-RG Kar principal, 2 other locations in Bengal

Kolkata. The Enforcement Directorate (ED) on Friday carried out search operations at multiple locations in West Bengal's Howrah, Sonarpur and Hooghly in connection with the alleged financial scam involving RG Kar Medical Centre and Hospital

In August this year, a 31-year-old trainee doctor was brutally raped and murdered at the government-run RG Kar Medical Centre and Hospital, triggering nationwide

According to sources, one of the places that the central probe agency was raiding in Hooghly included the premises of a relative of RG Kar Medical Centre and Hospital's ex-principal, Dr Sandip Ghosh.

Last week, the central agency filed a case against alleged financial irregularities at the RG Kar Medical College. The case was registered on the basis of the Central Bureau of Investigation's (CBI) FIR, which named Dr Ghosh in connection with its probe into the doctor's murder.

In the FIR, the CBI has slapped criminal conspiracy, cheating, and dishonesty along with Section 7 of the Prevention of Corruption Act in connection with the financial misconduct at RG Kar Medical College. The cases account for cognisable offences and are non-bailable in nature.

Dr Ghosh served as the principal of RG Kar Medical College from February 2021 until September 2023. Although he was transferred in October 2023, he inexplicably resumed his role at the hospital within a month. He remained in this position until the day of the brutal rape and murder of a trainee doctor.On September 2, the CBI arrested Dr Ghosh in the corruption case, and he was later sent to the probe agency's custody.

Her dreams brutally killed: Kolkata doctor's mother writes note on Teachers' Day

Kolkata. "Because she got good teachers like you, she was able to become a doctor... However, her dreams were brutally strangled," the mother of the trainee doctor who was raped and killed at RG Kar Medical College and Hospital in Kolkata wrote in a heartfelt letter on Teachers' Day.

In an open letter, the mother of the victim thanked all the teachers for helping her daughter achieve her dream of becoming a doctor. "I salute all her teachers on behalf of my

daughter. She had a dream of becoming a doctor since childhood. You were the driving force behind that dream," she said. 'My daughter used to say, 'I don't need money. I just want lots of degrees next to my name. And may I heal as many patients

as possible'," she wrote. The body of the 31-year-old doctor was found at the seminar hall of RG Kar Medical College and Hospital on August 9, sparking nationwide protests. Doctors across the country also went on strike

demanding safety at workplaces. A civic volunteer attached to the Kolkata Police, named Sanjay Roy, was arrested a



day later. The case has been handed over to the CBI even though protests have refused to die down.

'ARRANGEMENTS WERE MADE TO DESTROYALL EVIDENCE'

Speaking on the day of the incident, the victim's mother said her daughter had served many patients in the hospital, but she was brutally killed by miscreants while on duty.

"Even on that day, when she went out of the house, she served many patients in the hospital. However, her dreams were brutally strangled. The dream of becoming a gold medallist in MD, written that night,

remains elusive. Even after this heinous incident, all arrangements were made to destroy all the evidence by the hospital authorities and the administration," she said.

A diary found near her body revealed that she harboured dreams of winning a gold medal and other big honours in the medical field. There have also been allegations that renovation work was ordered near the crime

scene to destroy evidence - a charge refuted by the government. India Today has exclusively accessed a letter written by Sandip Ghosh, former RG Kar Hospital principal, on August 10 to the PWD, asking them for renovation and reconstruction of on-duty doctors' rooms in all departments of the institution.

Seeking justice for her daughter, she further said, "As the mother, I humbly request all medical college teachers, doctors, health authorities, nursing staff to bring forward any information and evidence regarding the incident. The silence of some good people emboldens criminals."

Chinese handshake costing Pak dear in Balochistan

RECENT attacks on multiple targets in Pakistan's Balochistan province mark an escalation in hostilities. The attacks were a consequence of festering problems and the damage to Balochistan's sociocultural and economic fabric. A major reason for the attacks was the CPEC (China-Pakistan Economic Corridor) desire to run an ambitious communications corridor from Xinjiang to Gwadar through Balochistan, a move not supported by residents of the province.

A close ally of China for decades, Pakistan has sought to use the Chinese largesse to address many of its problems. While their India-centred agenda has several convergences, Pakistan hoped that China would align with it against India. A review of the period since 1947 reveals that while China's diplomatic and military support to Pakistan may have been overtly nuanced on occasions, its covert facilitation and huge military supplies are central to Pakistan's operational capability and vital for Pakistan's missile, nuclear and submarine development. Unfortunately, strategic relations between unequals demand concessions from the less strong partner. From the act of ceding the Shaksgam valley of Kashmir to China in 1963, based on a specious boundary settlement, to the hosting of the CPEC and virtually surrendering control of northern Gilgit, the list of Pakistan's strategic giveaways to China is long. Enabling the Chinese to reach the high waters of the Arabian Sea through the Khunjerab Pass on the Karakoram mountains up to the port of Gwadar has been one of the major giveaways. This mega plan promises to transform Pakistan with a goal of 2.3 million jobs, 2-2.5 per cent additional growth and an enormous upgrade of road, rail, industrial and electrical facilities. For China, its 12,000-km oil transportation journey from the Gulf gets reduced to 2,395 km, with a saving of about \$2 billion a year (according to present estimates). It also negates China's Malacca dilemma and furthers its ambition to have a base in the Arabian Sea. The heart of the CPEC projects lies in Balochistan, a province that has never been integrated and remains restive. For the Balochis, their identity, autonomy, human rights abuse by the Pakistani state and the extraction of economic gains without returns remain major troubling issues.

Historically, Pakistan has chosen alliances mostly based on security and development-related priorities. The country's engagement with the US has given it a slew of advantages. Pakistan's centrality to the conflicts in Afghanistan, coupled with its own convoluted priorities, however, left it more divided, scarred and economically deprived. Its flawed vision of using covert entities to get leverage in Afghanistan and seek strategic depth has unravelled. Consequently, insecurity prevails in the region, including Afghanistan. In its pursuit of powerful allies like the US and China, Pakistan has neglected to integrate the western provinces and their people. A complex and twisted issue that has fomented resentment among Afghans, Pathans and Balochis is the Punjabi centralism and exceptionalism. Further, Pakistan has always preferred to use military force to deal with resistance movements instead of focusing on reconciliation. This has caused the Tehreek-e-Taliban Pakistan (TTP) and the Baloch movements to converge in resisting the Pakistani

In February 2022, then Pakistani Interior Minister Sheikh Rasheed Ahmad officially acknowledged this reality. Later, in November 2022, ill-fated talks with the TTP collapsed. Five main Baloch nationalist groups have seldom been approached for reconciliation. The brutal killing of Akbar Bugti, a Baloch leader, in 2006 by the Pakistani army marked a definitive break for the Balochis. For Pakistan, pursuing powerful and demanding foreign powers while letting deep internal fractures widen is hardly strategic wisdom.

At 11,317, the year 2009 saw the highest number of fatalities because of internal conflict in Pakistan. The number slumped to 365 in 2019 due to military measures and its focus on Afghanistan.

Assembly polls ignite J&K's hopes for restoration of statehood

After years of Central rule, there is a strong desire among people to elect a government that can represent their voices.

THE three-phase Assembly elections in Jammu and Kashmir (J&K), starting on September 18, are historic, being the first after the state became a Union Territory (UT). The last Assembly elections As political parties prepare for the elections, their were held in 2014 under entirely different political circumstances. As a UT, J&K has undergone significant changes since August 5, 2019. The Reorganisation Act, 2019, implemented following these changes, has resulted in new constituencies, based on the recommendations of the Delimitation Commission. The UT is abuzz with political activity. Participants include traditional regional parties, some separatist organisations, and even individuals

charged under the Unlawful Activities Prevention Act (UAPA).Jamaat-e-Islami Jammu Kashmir, banned under Section 3(1) of UAPA, has fielded candidates in Kulgam, Pulwama and other areas of South Kashmir. Sugra Barkati, daughter of jailed separatist leader Sarjan Barkati who was the face of the 2016 protests in South Kashmir, had last week filed nomination on his behalf, which was rejected. Barkati may now contest from the Ganderbal Assembly seat in Central Kashmir. The brother of Afzal Guru, a convict in the Parliament attack case, may also contest.Engineer Rashid brought noticeable changes to the politics of the Valley. There was already a strong sentiment in his favour, but it remains uncertain whether a similar sentiment will be seen again. If Rashid is

released from jail, he might create an impact that could benefit his Awami Ittehad Party candidates. However, without him, the main contest seems to be between the Congress-National Conference (NC) alliance and the BJP, with the Peoples Democratic Party (PDP) following behind. In this year's parliamentary election, the Congress- NC alliance secured over 41 per cent of the votes, while the BJP received 24 per cent and the PDP 8 per cent. Whether the same pattern will be observed in the Assembly elections remains uncertain. In the parliamentary elections, people in Jammu had voted for the BJP in support of Prime Minister Narendra Modi. However, dissatisfaction was seen among

party workers when they protested against the first list of candidates. The BJP had to withdraw the list and release a new one.

manifestos continue to echo familiar promises. The NC has once again included autonomy as one of its key promises. However, despite an absolute majority in the past, the party could not fulfil this promise, even after passing a resolution in the Assembly in 2000. Similarly, the PDP has also promised to pursue the restoration of J&K to its 'original status' and to establish full connectivity across the Line of Control for trade and social



exchange. Both the NC and PDP have called for resuming talks with Pakistan.

The manifestos of the NC and the PDP are almost similar. However, Mehbooba Mufti has added the "resolution of the Kashmir issue" to the PDP's manifesto promises. What this means and how she intends to achieve it remains unclear though. Engineer Rashid's party has promised to prioritise "land security," and address the "issue of prisoners in various jails across the country."

In the Kashmir valley too, the BJP faces major challenges. While its ally Sajjad Lone of the People's Conference performed well in the parliamentary elections, others did not achieve success. Traditional regional parties like the NC and

Congress are expected to have an advantage, and the PDP may also see gains. There is, however, some residual dissatisfaction with the PDP due to its earlier campaign against the BJP in 2014, and then its subsequent coalition with the same party. The NC appears to be the party that has made the most gains in the last four to five years.

There had been a consistent demand for the restoration of statehood before the elections. There is a widespread perception that unless the Central Government restores statehood, the next government may find it hard to address the aspirations of the people. Nevertheless, the

> formation of a local government will be a crucial first step toward raising voices and passing resolutions in the Assembly that could eventually lead to meaningful change. This election is seen as a clash between pre-2019 and post-2019 politics. Despite this, many across J&K, regardless of their identity, want statehood to be restored. Therefore, there is interest in parties, alliances or ideologies that promise a quick restoration of statehood.

The elections are expected to see a considerable increase in the voter turnout. Factors that previously discouraged participation, such as boycotts and threats from terror groups, are now largely absent. People are not likely to vote based on what is offered in party manifestos but rather to restore democracy in the

region. After years of direct rule from New Delhi, there is a strong desire among the people to elect a government that can represent their voices.

Some narratives at the national level had suggested that Governor's rule was beneficial and welcomed by the people. While it is true that there was widespread resentment against earlier state governments, as well as corruption and backdoor appointments in the government machinery, it is not a corollary that the people desire continuous Governor's rule, regardless of how effective it may have been in the past. Given the current political scenario, there is a high possibility of a coalition government being formed.

Western and Gulf nations is the best bet to counter the Vietnamese-Chinese challenge.

Old wine in a new biotech bottle

Biotechnology for Economy, Environment & Employment Policy silent on timelines, investments

CLIMATE change, energy transition, waste management, sustainability, agricultural productivity, the need for new health tools and much more. India can not only address these pressing challenges through the application of biotechnology but can do so while generating jobs and contributing to the national economy. This is what the Biotechnology for Economy, Environment and Employment (BioE3) Policy released by the government on August 31 would have us believe. The only caveat is that the policy is silent on the timeframe, the quantum of investment and human resources required, the possible number or types of jobs that will be generated and the pathway to achieve the goal. The 'vision' of the policy is to "set Bharat at the forefront of the future that is more sustainable and responsive to global challenges by accelerating and harnessing biomanufacturing solutions that encompass diverse bioeconomic activities while safeguarding environmental and climate impacts." The 'goal' of the policy is "to fasttrack innovation-to-technology" by weaving together fragmented activities under the umbrella of biomanufacturing and to incentivise "concrete options to build a sustainable future". The overall 'objective' is to present a framework to ensure the adoption of cutting-edge technologies and accelerate the development and production of bio-based highvalue products. While presenting the policy, Department of Biotechnology (DBT) Secretary Rajesh Gokhale declared that the goal was the 'industrialisation of biology' and making India a global leader in this field. If one cuts the fluff, all that the policy document indicates is the government's intent to promote biotechnology-based industry and the use of new tools like digitalisation, artificial intelligence and machine learning. If that is so, there

is nothing new here because the last policy document the DBT released in 2021 - National Biotechnology Development Strategy (2021-25) — said precisely the same thing but it was backed with timelines, financial targets and clear pathways. The goal set in 2021 by the DBT was to develop a biotechnology-led 'knowledge and innovation-driven bioeconomy' and make India a 'global biomanufacturing hub' by 2025. This was to be achieved by building a skilled workforce and enabling infrastructure for industry like bio-foundries, and incentives to the industry for developing and producing affordable products. The thrust areas identified in 2021 were climate change, food security, green energy, waste management, etc. The list has been repeated in the 2024 document, but the DBT has cleverly made no mention of previous policies and strategies to avoid questions being asked about missed goals. The only follow-up action since 2021 is a new scheme to promote bio-foundries announced in the 2024-25 Budget.

In the past four decades, biotechnology has demonstrated its potential in applications ranging from new vaccines and novel crop varieties to environmental cleanup using microbes. Indian policymakers recognised its potential early on, establishing a dedicated government department for its promotion in 1986. The DBT, in its formative years, focused on building research and education capabilities, which has made India a significant player in this field. However, the biotech-based industry was slow to pick up due to reasons such as a lack of venture capital and an enabling environment. Whatever industry developed was not a result of the DBT's programmes. The poster boy of the Indian biotech industry, Biocon, predates the formation of the DBT, and other pioneers like Shantha Biotech and Bharat Biotech took root with the help of risk financing by another government body, the Technology Development Board.

In the 2000s, the governments of Karnataka and then undivided Andhra Pradesh rolled out their policies that gave incentives to the biotech industry. The success of the Genome Valley and the IKP Knowledge Park in Hyderabad are shining examples



of a state-sponsored technology cluster developing with the active participation of the private sector. It was only in 2012 that the DBT established a commercial arm for industry promotion - the Biotechnology Industry Research Assistance Council. The government should boost the industrial base in biotechnology by leveraging existing strengths and learning from the experience. However, the new policy does not mention successful models like the Genome Valley or IKP Knowledge Park. Instead, it has rehashed the same concept and given it a new name (Mulankur Bio-Enabler Hub). These hubs, the policy says, will 'augment discovery and translational research' and 'support facilities for pilot scale and pre-commercial scale research'. This is what the functional technology clusters are doing and have successfully incubated firms that have grown to become billion-

dollar companies. While unveiling a grand utopian vision of solving all problems, the policy underplays the key role of regulation (it calls regulation a 'roadblock'), the need to invest in developing technical manpower and boosting state funding for fundamental research. Regulation is critical as biomanufacturing is all about genetically modified and other organisms. At present, regulation is fragmented and opaque. The Biotechnology Regulatory Authority of India Bill has been in cold storage since 2013. Before embarking upon building a large-scale biotech industry, it would be prudent to develop a robust, autonomous and statutory regulatory system.

The DBT Secretary talks about a 'new industrial revolution' fuelled by biotechnology, like the much-celebrated IT Revolution. He should remember that the communication revolution was triggered not by a policy but by the government's resolve to develop a digital telephone exchange from scratch with a committed investment and a tight deadline. In the same way, it was the state-promoted Software Technology Parks scheme that led to an exponential growth of the software industry and the IT Revolution. Decisive government actions are more important than policy pronouncements.

He said that Carol Info Services Ltd was affiliated to Wockhardt Limited, which is being investigated by Sebi in several cases, including one of insider trading. The Congress leader claimed that Madhabi Buch received Rs 2.16 crore from Carol Info Services Ltd as rent from 2018-19 to 2023-24.

New Delhi: The Supreme Court on Friday issued a notice to the Centre and the Bihar government on a petition challenging the High Court's order striking down a hike in reservation in Bihar to 65%, but has not imposed a stay for now.

The Rashtriya Janata Dal, which is the principal opposition party in Bihar, had moved the top court against the Bihar High Court's verdict on the increased reservation, legislation for which was passed after a caste survey last year. Reacting to the developments in the Supreme Court, the RJD said it will continue to fight for reservation and the "rights of the deprived". "Supreme Court issues notice on RJD's petition against Patna HC order quashing Bihar Reservation Amendment Act.

RJD will keep fighting for the reservation and rights of the deprived and the neglected on the streets, in the House and in the courts," the party wrote in Hindi in a post on X while also hitting out at Bihar Chief Minister Nitish Kumar and the BJP. Goldman Sachs gives SBI 'sell' rating with revised target price. Know why

New Delhi Goldman Sachs downgraded its outlook for the State Bank of India (SBI), cutting its earnings estimates for FY25 and FY26 by 3% and 9%, respectively. The brokerage highlighted a growing risk-reward imbalance, driven by challenges in sustaining return on assets (RoA). Goldman Sachs forecasted that RoA would fall below 1% by FY26, down from 1% in FY24. The revised target price indicated a 9% downside from SBI's current trading level of Rs 818.60.The downgrade was due to concerns over lower net interest income and higher loan loss provisions. Goldman Sachs noted increasing credit costs because of rising slippages in MSME, agricultural, and unsecured loan portfolios. Despite this, SBI's shares had a slight increase of 0.26%

on Thursday. Analysts from Axis Securities viewed SBI as a strong player in the banking sector, aligning well with India's economic growth. The analysts highlighted SBI's focus on increasing deposits and shifting assets from investments to loans. This strategy was expected to improve its Loan-to-Deposit Ratio (LDR) and maintain its margin at 3.2% in the medium term.

Axis Securities also pointed out SBI's healthy Provision Coverage Ratio (PCR) and adequate capitalization, forecasting that the bank would maintain a RoA of 1-1.1% over the next few years.InCred Equities remained optimistic about SBI, maintaining it as a high-conviction stock and setting a target price of Rs 1,100

Unsold passenger vehicle inventory rises to 7.8L units: **FADA**

NEW DELHI. Despite an assurance by carmakers to cut down dispatches, top dealer association body FADA said inventory levels at passenger vehicle (PV) showrooms remain at alarming levels, with stock days now stretching to 70-75 days. Inventory totalling 7.8 lakh vehicles, valued at an alarming Rs 77,800 crore. The Federation of Automobile Dealers Associations (FADA) on Thursday alleged rather than responding to the situation, PV makers continue to increase dispatches to dealers on a month-to-month basis, exacerbating the issue."FADA is raising SOS signals as PV sales fell by 3.46% MoM and 4.53% YoY in August. Even with the arrival of the festive season, the market remains under significant strain due to delayed customer purchases, poor consumer sentiment and persistent heavy rains. Inventory levels have reached alarming levels, with stock days stretching to 70-75 days and inventory totalling 7.8 lakh vehicles, valued at an alarming Rs.77,800 crore," said FADA President, Manish Raj Singhania.FADA said dealers must act swiftly to stop taking on additional stock to protect their financial health. OEMs, too, must recalibrate their supply strategies without delay, or the industry faces a potential crisis from this inventory overload, it said. Banker warns of systemic risk arising from flight of bank deposits to Mfs

MUMBAI: A veteran banker on Thursday expressed concerns over the present trend of deposit flight out of banks, saying that if the trend, especially in the Casa segment, is not arrested there could be systemic risks down the lineSeeking active participation of the government and the regulator to arrest the flight of money into non-banking assets like equities and mutual funds, IBA chairman MV Rao said if the present trend needs to be contained to avoid systemic risk.

Addressing the IBA-Ficci organised national banking summit here on Thursday, Rao, who also heads the public sector Central Bank of India, said, "Our analysis of mutual fund investors has found that as much as 99% of them are not analysing the technical or fundamentals of their investments but they are following some group.

After six-seven years when the cycle turns, definitely this will have a lot of systemic risk that may come out of. Because mutual funds invest in companies or stocks and they don't make provisions unlike banks which must make provision of 20% even to AAA-rated investments". He further elaborated saying with the current generational shift, cultural changes also happen. The earlier culture of security is moving now to securitisation. People who are now keeping deposits are in the higher age group while the younger lots are moving to become investors. Admitting that the return given by mutual funds are higher, he said restricted rate of interest for many bnaking assets/products vis-a-vis mutual funds don't have restrictions. Santosh Meena, Head of Research at Swastika Investmart Ltd., said the dramatic drop comes after the Indian markets had been holding steady at all-time highs. Today's market turbulence is partly linked to investor jitters ahead of the US non-farm payrolls report expected later today."One key factor could be weaker job data from the USA, fuelling concerns about a potential global economic slowdown," he said. Analysts predict an increase of 165,000 jobs and a drop in the unemployment rate to 4.2%. However, concerns about weaker job openings and a possible rate cut by the Federal Reserve have added to the market uncertainty.Dr. V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services, noted, "If the August jobs data falls short of expectations and unemployment rises, the Fed might cut rates by 50 basis points. This could worry the markets further, especially with fears of a potential slowdown."Additionally, India's weight in the MSCI Emerging Markets index has surpassed China's, reaching its highest level."This raises the risk of a strategic reduction in weight allocation, especially given India's relatively high valuations," Meena said.

The report suggests that people, especially the poorest households, are now using their saved money to add more variety to their diets, including milk, fruits, eggs, and meat. The decrease in food spending has been mainly driven by government schemes that provide free wheat and rice, making essential grains available at no cost to many families.

The report notes that for the first time in



modern India, average household spending on food has fallen below 50% of total monthly expenses. This shift is being seen as a significant change in spending habits, particularly in rural

Changes in food expenditure

The EAC-PM working paper reveals that spending on cereals, a staple food category, has reduced notably, especially among the poorest 20% of households. This drop in cereal spending is seen as a direct result of the government's food security programmes, such as the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). This scheme, which provides free grains to around 800 million people across the country, has played a key role in reducing the burden of food costs for households. The report shows that the money saved from spending less on cereals has allowed families to diversify their diets. More people are now buying milk, fruits, eggs, fish, and meat, which were previously considered luxury items for many lowincome households."This change is more noticeable in the poorest households," the report said. "The free grain distribution has acted like an expansionary policy, enabling families to shift their spending from basic cereals to

Despite this improvement in dietary diversity, the report also points out that efforts to boost iron intake have not yielded the desired results. Anaemia remains a widespread issue in the country. The paper suggests that the government's approach to fortifying cereals with iron, while simple to implement, may not be enough to combat anaemia effectively."Improving iron intake and reducing anaemia might require promoting more diverse diets, rather than relying on fortification of cereals alone," the paper mentioned. The report also highlights improvements in dietary diversity across states and Union Territories. Northeastern states like Sikkim, Arunachal Pradesh, and Tripura have seen some of the most notable gains. In other regions, states like Bihar and Odisha have made good progress in improving micronutrient intake through diverse diets, though states like Rajasthan have only seen minor changes. The rise in dietary diversity, especially for the poorest 20%, shows that better infrastructure, transport, and storage have made items like fruits, milk, eggs, and meat more accessible and


