Youth's death at RG Kar hospital 'without | treatment' sparks row Sanjay Kumar

Kolkata, Sep 7: Trinamool Congress's Kunal Ghosh claimed that Bikram Bhattacharjee did not receive proper treatment. RG Kar hospital refuted the allegations. The death of 28-year-old Bikram Bhattacharjee from West Bengal's Konnagar who died at RG Kar Medical College and Hospital in Kolkata on Friday after being hit by a truck, has sparked controversy. The incident took place a day after the state health department reportedly had to close down help desks at all the five medical colleges in Kolkata following the agitation of 'Joint Platform of Doctors'. The youth from Hooghly's Konnagar was brought to RG Kar Medical College and died allegedly due to nontreatment at the same hospital. Bomb threat diverts Vistara flight to Turkey, new aircraft deployed

Mumbai, Sep 7: Vistara on Saturday said it is dispatching an alternative aircraft along with a fresh set of crew to fly the passengers of its Mumbai-Frankfurt flight to their destination after it was diverted to Erzurum Airport in Turkey due to an alleged bomb threat on Friday. The substitute



aircraft is expected to arrive at the Turkish airport by 12.25 (local time) and depart for Frankfurt with all passengers by 14.30 hours (Local time), Vistara said in an updated statement of X (formerly Twitter). The flight UK 27, operating on Mumbai Frankfurt route, departed from Mumbai at 1.01 pm on Friday after a delay of an hour and was scheduled to arrive in Frankfurt (Germany) at 5.30 pm (local time). The Dreamliner 787-9 aircraft was, however, diverted to Turkey after the airline's crew on-board found a paper note stating that there was a bomb on the aircraft. Vistara sources had said. "Since the crew have exceeded their duty time limitation, we are sending an alternate aircraft, with a fresh set of crew, to Erzurum Airport, Turkey, which is expected to arrive there by 1225 hours (local time) and depart for Frankfurt, with all customers, by 1430 hours(local time)," Vistara said in its updated statement. It said that all the necessary checks have been conducted and the customers, along with the crew and aircraft, have been cleared by the security agencies. In the meantime, all efforts are being made to minimize inconvenience to customers, including offering them refreshments and meals, Vistara said in the statement. On Friday the airline had said its Flight UK27 from Mumbai to Frankfurt, "has been diverted to Turkey (Erzurum airport) due to security reasons and has landed safely at 1905 hours", without divulging the number of passengers and crew on board the aircraft.

India presents a different picture than 10 years ago: Dhankhar

New Delhi, Sep.: 7: With foreign exchange reserves of USD 680 billion, India has come a long a way since the time it had to pledge its gold to tide over a financial crisis, Vice-President

Jagdeep Dhankhar said on Saturday. Dhankhar was speaking during the inauguration programme of Uttar Pradesh Sainik School in Gorakhpur. "Today's India presents a completely different picture than what was 10 years ago. There was a time when the same country, which was referred to as 'sone ki chidiya', had to pledge its gold in foreign banks. Back then, our foreign exchange was between USD 1 billion and USD 2 billion. Today, it is USD 680

billion. Look at the kind of progress we have made since," he said. India's foreign exchange reserves jumped by USD 2.299 billion to a new high of USD 683.987 billion for the week ended on August 30. The vice-president also showered praise on Prime Minister Narendra Modi for India's turnaround and said Uttar Pradesh under Chief Minister Yogi Adityanath also played a crucial role in it.

"A deserted Srinagar welcomed me

when I visited Kashmir in 1990. Now, over the last two to three years, two crore tourists have visited (Kashmir)," Dhankhar said. This has happened in present-day India. Article 370 was described by the Constitution makers as

"temporary" but some people mistook it as "permanent". It was again in the present that Article 370 was scrapped. This is the present-day India, he added. Dhankhar further said, "If we compromise with nationalism, it will be a betray-

al to the nation. Those who are doing this need to be made to understand. Otherwise, the public will have to spiritually retaliate against them. How can anyone imagine that conditions like those in the neighbouring country can take place in this great India? It cannot be done." "Whenever someone questions the nation, we will not tolerate it. I am sure that this will not happen," the vice-president said. He claimed India was on a very big journey, which will culminate in 2047 on the centenary of Indian independence. "In this marathon march, Sainik School will contribute through its students," Dhankhar said. "I request you that everyone should sacrifice themselves in the 'havan' that is being performed to make India a devel-

Centre discharges Puja Khedkar from IAS with immediate effect

New Delhi, Sep 7: The central government has discharged Puja Khedkar from the Indian Administrative Service (IAS) with immediate effect, over a month after the Union Public Service Commission cancelled her selection, official sources said on Saturday. Khedkar, who was a trainee officer from the 2023 batch, has been accused of cheating and wrongly availing Other Backward Classes (OBC) and disability quota benefits to ensure her selection in the government service. She has denied all allegations. The central government, vide order dated September 6, 2024, "discharged" Khedkar from the Indian Administrative Service under Rule 12 of IAS (Probation) Rules, 1954, with immediate effect, the sources said. An IAS officer is "dismissed" from service while a probationer is "discharged". One of the provisions of Rule 12 provides for discharge on the grounds of a probationer being found to be ineligible to be recruited to the Service, they said. Khedkar,

who was provisionally allotted the Indian Administrative Service (Maharashtra cadre), on the basis of the result of the civil services examination (CSE)-2022 taken by her, was



also accused of misusing power and privileges during her training in Pune. A criminal case was registered against her in July by Delhi Police for "misrepresenting and falsifying facts" following a "thorough investigation" by the UPSC into allegations of misconduct. As reports emerged that she may have been ineligible to be a candidate at the CSE-2022 and previous exams, a single-member committee was constituted on July 11, 2024 to verify her candidature claims. The panel

submitted its reports on July 24, 2024. Taking note of the findings and conclusions of the committee, the government proceeded for a summary enquiry according to the provisions of Rule 12 of IAS (Probation) Rules, 1954, including giving Khedkar a reasonable opportunity. It was seen that she had applied and appeared for the CSE between 2012 to 2023, the sources said. According to the information submitted by herself in her civil services examination application forms between CSE-2012 to CSE-2023, it was seen that she had availed more attempts at examination than

the maximum permissible limit of nine in her claimed category (Other Backward Classes and Persons with Benchmark Disability), which she had exhausted by attempting the civil services examinations between 2012 and 2020, i.e., prior to the CSE-2022 itself,

The Bharatiya Janata Party (BJP) on Saturday lashed out at National Conference vice president Omar Abdullah over his remarks on the execution of 2001 Parliament attack convict Afzal Guru. "The unfortunate thing was that the J-K government had nothing to do with Afzal Guru's execution. Otherwise, you would have had to do it with the permission of the state government, which I can tell you in no uncertain terms would not have been forthcoming. We wouldn't have done it. I don't believe that any purpose was served by executing him," Abdullah, who was serving as the chief minister of erstwhile state of Jammu and Kashmir, told ANI. Abdullah's remarks have triggered a storm ahead of the Jammu and Kashmir assembly elections. Union minister of state for home Nityanand Rai said,"Omar Abdullah's statement is extremely objectionable and anti-India, any amount of criticism is not enough... He is speaking in favour of such terrorists... The Congress is with such anti-India statements. There is no difference between Abdullah and Congress... The people of India will not forgive this." Former J&K deputy chief minister Kavinder Gupta told ANI,"After all, what does Omar Abdullah want to solve? If anti-national elements who hatched a conspiracy against India are given the death penalty, why do they object to this? They want to create a situation by taking support from terrorists. They are taking support from terrorists; that is why he is speaking such language." "Omar Abdullah is openly supporting Pakistan's policy and Pakistan so that he can win the election. He is scared after the loss in the Parliament election," BJP leader Altaf Thakur said. Kolkata horror: SC to consider CBI's status report on Monday

New Delhi, Sep 7: The Supreme Court which took suo motu cognizance of the rape and murder of a junior doctor at the RG Kar Medical College and Hospital, Kolkata following a nationwide outrage and protests by doctors - will hear the matter on Monday. The matter is listed for hearing on September 9 before a Bench of Chief Justice of India DY Chandrachud, Justice JB Pardiwala and Justice Manoj Misra. The Bench - which had on August 20 asked the CBI to submit a status report on the probe into the case - was likely to peruse the report and issue any further directions, if needed. While ordering the Centre to deploy CISF personnel for security of RG Kar Medical College and Hospital and its hostels, it had also asked the West Bengal Government to furnish a separate status report on the mid-night vandalism on the Hospital campus in which peacefully protesting doctors were allegedly targeted. However, alleging "unpardonable" non-cooperation by the West Bengal Government and Kolkata Police in providing logistical support to the CISF, the Centre on September 3 moved the

central force. In an affidavit filed in the top court, the Union Ministry of Home Affairs (MHA) urged the top court to direct the West Bengal Government to extend full cooperation to the Central Industrial Security Force (CISF) and ensure full compliance, in letter and spirit, of its orders in the Kolkata rape and murder case. UP woman beaten, head shaved after complaining of nephew's harassment

Kannauj. A woman in Uttar Pradesh's Kannauj was brutally beaten and had her head shaved after complaining that her nephew sexually harassed her. A disturbing video of the incident went viral, sparking outrage and prompting police to arrest six people, including the woman's husband. The incident occurred on September 3, but the video only recently came to the fore. The footage shows the woman, with her head shaved and hands and legs tied, being beaten repeatedly with a wooden stick by her husband in front of a small crowd. The men take turns to assault the woman, who winces in pain and cries before collapsing.

The woman claimed that her nephew, Raja Nath, had been harassing her for some time. When she went to his house to complain, her husband and his family attacked her, shaving her head and beating her with sticks. Police took cognisance of the viral video and launched an investigation.

"A video of a woman being beaten is being shared. The man seen beating in the video is the husband of a woman. Six people have been arrested and an inquiry is underway," said Kannauj Superintendent of Police Amit Kumar Anand.

After UP's Bahraich, wolf attacks 5 people in Madhya Pradesh's Khandwa


Khandwa. Five people were injured after a wolf attacked them while they were sleeping outside their home in Madhya Pradesh's Khandwa, police said on Saturday. This incident comes amid reports of a series of wolf attacks in Uttar Pradesh's Bahraich, which has left the entire region in fear. The incident occurred early on Friday when the family was sleeping outside their house near a field in the tribal-dominated Khalwa area. A woman sustained wounds on her hands, while four men were bitten on their hands. All of them have been hospitalised.

Following the attack, the villagers caught the wolf, beat it, and tied it with a rope. The animal was seen motionless in visuals. However, forest department officials have not confirmed whether it was killed. They stated that action will be taken after investigating the entire matter.

According to forest department officials, the area, which is just 20 kilometres away from the district headquarters, frequently sees animals like wild dogs, wolves, and foxes roaming around, as it is near forests. The wolf attack has left 35 villages in the region

The program was initiated at the request of the Jammu and Kashmir Police and has already trained around 500 individuals in Rajouri and 85-90 in Doda and Kishtwar.VDGs are also being equipped with Self-Loading Rifles (SLRs) provided through a joint effort by the Army's Ordnance Depots and Jammu & Kashmir Police, further empowering them to defend their communities. This initiative underscores the commitment to protect the lives of civilians in Jammu and Kashmir.

Raids lead Enforcement Directorate to RG Kar ex-principal's luxurious bungalow

Local residents said the property, which bears the nameplate 'Sangeetasandip Villa' is named after Ghosh and his wife, Sangeeta.Locals, who refer to the bungalow as "Doctor Babu's house", claimed that they often see the Ghosh visiting the residence with family

While she remained at the bus stop, two men on two bikes approached her and offered her a lift to her village. The woman rode pillion on one of the bikes while the other rider followed. Midway, near Palayeevayal, the duo stopped their vehicles, dragged her to a fallow paddy field and sexually assaulted her, sources said. Later the duo dropped her midway, threatening her not to disclose the incident to anyone, and sped away. Meanwhile, worried over her not returning home for long, her son went looking for her and found her on the

He took her back to their village where she narrated the incident to the family members. Following this, she lodged a complaint with the Budalur police. The police registered a case under relevant sections of the BNS, including that for

gang-rape and criminal intimidation. The woman was admitted to the Government Raja Mirasdar Hospital

Chennai Police approves over 1,500 Ganesh Idols to install for festival

Chennai. With the Ganesh Chaturthi festival round the corner, the Chennai Police on Friday granted permission to install 1,519 idols across the city. Elaborate security measures have been put in place by the Tamil Nadu Police to ensure a peaceful celebration.A total of 64,217 police personnel have been deployed to manage traffic and maintain law and order during the installation and immersion of the idols. Sensitive and high-risk areas have been identified, and measures are being taken to prevent any untoward incidents.

The immersion process will be closely monitored through CCTV cameras and drones, with livestreaming from sensitive routes and locations

YS Sharmila urges Centre to supply drinking water to people in flood-hit Vijayawada

Vijayawada. Andhra Pradesh Congress chief YS Sharmila Reddy on Friday wrote to Railway Minister Ashwini Vaishnaw, urging him to allow the Railways to supply bottled water from Rail Neer plant in Visakhapatnam to the people of flood-hit Vijayawada.For the past few days, Vijayawada and other parts of Andhra Pradesh have been battered by heavy rainfall, leading to flooding and restricting access to potable water."I write this letter to draw your attention to the severe situation currently faced by Vijayawada. As you are aware, the city has experienced an unprecedented rainfall of approximately 40 cm over two days, which has caused extensive damage. The rivulets

and drains in and around the city are overflowing, leading to widespread inundation and isolation of numerous

colonies,", Sharmila wrote in the letter. "To begin with, on behalf of the people of Andhra Pradesh, I appeal to you to consider supplying water from the Rail Neer plant for the next few days. Your prompt action would be greatly appreciated and would significantly aid in the faster recovery of the city in these challenging times, she said.Sharmila pointed out that people's lives have been hit hard in the floods and that the lives of children, the elderly, and those who are suffering from ailments, werethe worst affected."The city now encounters a major challenge as the drinking water supply pipelines have been heavily silted up. This has made water unsafe for drinking and cooking," she said.

"The process of clearing the silt and making the water safe again will be timeconsuming. Until then, there have to be alternate ways through which the people of the city will get drinking water," she added. The Andhra Pradesh Congress chief also highlighted that the Vijayawada division, under the South Central Railway zone, contributes an annual revenue of close to Rs 6,000 crore. She said it was the duty of the Indian Railways to help the people in the region."We understand that a Rail Neer plant has recently commenced operations near Visakhapatnam. I request you to consider exploring the possibility of arranging water supply from the plant to the affected areas in Vijayawada," she added."In light of this urgent situation, your immediate intervention will be of immense help to the people," Sharmila further said. Till September 3, at least 19 people died in Andhra Pradesh due to rainrelated incidents, prompting the Chandrababu Naidu-led government to take effective relief measures. Naidu described the floods as the "worst devastation" he had ever witnessed. The Chief Minister announced a compensation of Rs 5 lakh to families of those who lost their lives due to the floods.

BJP plans major overhaul in Uttar Pradesh after poor poll performance

Lucknow, Uttar Pradesh. The BJP is planning a largescale reorganisation in Uttar Pradesh, with district presidents in about 50 districts where the party faced defeats likely to be replaced. As the BJP's ongoing membership campaign wraps up, the party will initiate organisational elections, signalling

a major shift. The district presidents in Lok Sabha constituencies where the BJP lost will be replaced, along with district and Mahanagar presidents who have served two terms or have complaints against them. The party aims to restructure from divisional to state level, with Uttar Pradesh currently divided into 98 districts for organisational purposes. The

BJP is currently focused on a two-phase membership drive. The first phase, from September 2 to 25, involves enrolling ordinary members, while the second phase, from October 1 to 15, will target active members.

Organisational elections will begin as soon as the membership drive concludes in October. The BJP's performance in the recent Lok Sabha polls, where it COIMBATORE: A special team dropped from 64 to 33 seats in Uttar Pradesh, has raised concerns from the state to the central leadership, as the

seat reduction affected the party's majority at the Centre. The upcoming organisational elections will tighten control over irregularities, targeting district presidents and other leaders who are inactive or disruptive. State General Secretary, Dharampal Singh, hinted at these

In response to the complaint, the company collected a sample of the milk on Friday afternoon for further investigation."I purchased a one-litre pack of Mother Dairy toned milk from the store in our society premises. When I was filtering the milk using a strainer, I noticed tiny worms on the mesh. I promptly set the milk aside. Without delay, I returned to the store and lodged a complaint," said Amit Chaudhary, the complainant.

Sarvesh Mishra, assistant commissioner of FSDA, said, "We got the details of the case through X. We will investigate the matter and do the needful."

This is not the first time renowned brands have come under the scanner over the quality issue. In May, food safety and drug administration teams collected samples of palm oil, cheese, and mayonnaise from a McDonald's outlet in Sector 18 and pineapply cake from Theobromaafter customers' complaints.

Kidnapped man rescued from Mathura, 2 held

Ghaziabad. Police successfully rescued a 35-year-old YouTuber on Friday after he was kidnapped from the Vijay Nagar area the day before. The Ghaziabad resident was safely rescued from Mathura and two accused were arrested for their alleged involvement in the abduction scheme. Four other accused are currently absconding. The arrested accused were identified as Manish Kumar (36 and Surendra alias Saurabh (32) from Mathura.

According to DCP (City) Rajesh Kumar, police received a complaint from Jagadu Singh on Thursday evening alleging that his son Praveen had been kidnapped. Praveen runs a YouTube channel (Godpraveen YT) with over three lakh subscribers. Multiple teams were formed and initial investigation revealed that Praveen developed a Tiranga gaming app and has been promoting it on social media.

"Rahul Gupta, who is absconding, is a Delhi-based businessman and a good friend of Kumar. He had lost over Rs 1.5 crore on Praveen's app after putting money in several games after Kumar forced him. Later he decided to take revenge," he said. Gupta and Kumar planned to kidnap Praveen and extort money from his family, the DCP said. Kumar called four of his friends from Mathura, who have criminal histories, to execute the plan.On Thursday morning, Praveen was on his way to pick up his father, who was being released from a hospital. The accused hit Praveen's car from behind on NH-9 in Vijay Nagar. When Praveen exited the car, the accused kidnapped him at gunpoint and began driving Praveen towards Mathura. When Praveen didn't reach the hospital by afternoon his father approached police. Mathura police stopped the accused's car, leading some of the accused to flee. Surendra was arrested after an encounter and Kumar was later arrested on Friday. The accused were booked under BNS Section 140 (kidnapping or abducting in

BSP announces candidate for Gzb assembly seat, wait on for BJP & Cong

Ghaziabad. BSP announced Ravi Gautam as its candidate for the Ghaziabad assembly constituency, which is among the 10 seats set to go to bypolls later this year. The seat fell vacant after the incumbent MLA Atul Garg was elected to the Lok Sabha earlier this year.Last week, Azad Samaj Party (Kanshi Ram), led by Chandrashekhar Azad 'Ravan', announced former journalist Satpal Choudhary as its candidate for the seat and all eyes are now on BJP and the INDIA block, who are yet to announce theirs. The 31-year-old BSP candidate belongs to the scheduled caste category and is an advocate. His roots go deep into the party as he is the third generation in his family to be associated with it."I met Mayawati on Aug 30 and presented to her my credentials. A day after the meeting, the party announced my name for the Ghaziabad assembly seat, said Gautam."My family has been with the BSP for three generations now. Members of my family have held positions like the party's booth-level president and sector-level president, and I head an organisation called Yuva Shakti Dal, which works for the BSP and assists it in organising rallies and public meetings across the country," added Gautam.In the last two assembly elections-2017 and 2022-Ghaziabad was won by Atul Garg, but in 2012 it was won by a BSP candidate.

Meanwhile, ahead of announcing the names of candidate for the seat, chief minister Yogi Adityanath recently held a closed-door meeting with party workers in the city. The party has received 13 names of people willing to contest from the seat. Of the ten seats that will go to bypolls, five were won by the Samajwadi Party (SP) in 2022, one was won by the Rashtriya Lok Dal (RLD), which was then in alliance with the SP but is now part of the NDA, three were won by the BJP and one went to its ally Nishad Party. When asked whether he thinks the Azad Samaj Party (Kanshi Ram) will pose a challenge for the BSP because they share their core vote bank, Gautam said, "The BSP's cadre is intact, and Azad has no footing in Ghaziabad. Our party is a prominent player here."

Faridabad youth murder: Shanky, who was in car when Aryan was shot, named in 7 chargesheets

GURGAON. As Anil Kaushik and other cow vigilantes chased the Duster for 29km on Aug 24, they were convinced the car was carrying beef as it tried to speed away. And the reason why it didn't stop was Shanky - who has been named in seven chargesheets since 2021, mostly related to attempted murder cases.

Shanky or Sagar Gulati was one of five occupants in the Duster that night when Aryan Mishra was shot dead by a group of cow vigilantes led by Kaushik on the Delhi-Agra highway in Palwal.

Aryan, his landlord's wife, two sons and a neighbour had gone out to have noodles at Vardhaman mall in Faridabad around 10pm when a white Swift started chasing them on their way back.Shanky - who was out on bail in an assault case - asked his brother Harshit to step on the accelerator as feared he was being chased by cops in civvies. As bullets were fired behind, Shanky apprehended the attackers could be his rivals he had assaulted in the past.It was only when one of the bullets hit Aryan - who was seated in front - in the back of his head that Harshit pulled the car over near Gadpuri



toll plaza. Kaushik and the others ran to the window where Aryan was sitting and fired at his neck again from close range. When they peered into the car, they realised it was not Aryan they were looking for. With two women seated behind, the vigilantes were convinced the occupants of the car weren't cattle smugglers. The 20-year-old succumbed to injuries hours in hospital. Kaushik and his aides, according to police, have admitted the murder was a case of "mistaken identity". In a brief exchange

with Aryan's father, the attackers also apologised for it. Since then, Shanky has been picked up again in connection with an old case. His criminal record, police said, includes not just assault, but rioting and cases registered under Arms Act too. The last police complaint against Shanky was registered on Aug 15, when Chirag Bhatia of NIT Colony in Faridabad alleged that his house was attacked with liquor bottles and stones in the dead of night. Shanky and at least six others allegedly fired at Bhatia's

neighbour too, but the bullet missed him. A case of attempt to murder and under provisions of the Arms Act was registered against Shanky and his friends. He was arrested and remanded in judicial custody. He was out on bail when Aryan was attacked. Earlier, on June 25, a gang led by Shanky allegedly abducted Mohit of AC Nagar in a car and tried to rob him.

"I was on my way to Santosh Hospital around 2.30am on June 25 when they stopped our car at gunpoint. They pulled me out and bundled me in their car. Seated next to the driver, Shanky turned back and pointed his gun at me again, asking me to hand over whatever I had. He pointed his gun at my leg and pressed the trigger. I removed my leg in reflex, but the gun didn't fire. Its magazine fell down," Mohit said in his complaint.

As they stopped the car and started looking for the magazine below the seat, Mohit opened the door and ran away near Bikaner Sweets. A case was registered against Shanky, Shivam, Bharat and Lucky.

Man gets 20 yrs' RI for rape of girl (4) in 2021

Gurgaon. A man was handed 20 years' rigorous imprisonment for the rape of a four-year-old girl in Panipat in 2021. The girl – who lived in his neighbourhood — was alone at home when she was assaulted. The fast-track court for Protection of Children from Sexual Offences (POCSO) Act, which awarded the sentence, also directed the District Legal Service Authority to give compensation to the girl's family under the victim compensation scheme.Public prosecutor Kuldeep Dhull said that on Dec 20, 2021, the girl's mother, who had gone to the fields for some work, found her she asked her child what the matter was, the latter told her that she was sexually assaulted by her neighbour,

Pintu. The complainant then went to Pintu's house and confronted his mother, Neelam, who in turn allegedly threatened her. The accused was arrested the next day under Section 6 of the POCSO Act, and his mother was arrested under the charges of criminal intimidation on January 15, 2022. Meanwhile, Ravita Kumari, counsel for the accused, argued during the trial that both the accused were being framed with the intention to extort money and that the statements of the witnesses were not consistent. She also said that the police had not carried out a proper investigation in the case.

Student abducted, made to sell Rs6L superbike & withdraw Rs1L

Gurgaon. Three men were arrested for allegedly abducting a 19-year-old BTech student on Aug 28, keeping him captive for seven hours and robbing him of Rs 6.8 lakh last month

The trio called the victim out of his PG and forced him into a car, following which they made him withdraw money from his bank account, sell his bike for Rs 5.8 lakh to a dealer in Delhi and stole his gadgets. Atharv, who is Palwal and a second-year student at Gurgaon University, stayed at Hello World PG in Sector-55. A few months ago, he met Bhanu, Tilak Tewatia of Palwal, and Gaurav of Faridabad through his friend Pankaj. According to Sector 56 police, the accused are graduated and unemployed. On the evening of Aug 28, when Atharv was in his room, he received a call from Tilak. "I reached the PG room at 4.15pm and got a call from Tilak. He asked me to come outside. I went out and saw Bhanu's car parked there. When I approached it, they forced me to sit inside the car. They threatened to kill me and made me withdraw Rs 1 lakh from my bank account," Atharv said, adding that Bhanu also stole his iPad, PlayStation, watch, AirPods and power bank from his room and made him sell his bike.

In addition to all the gadgets, Bhanu stole my Kawasaki Z900 bike which was parked at the PG," Atharv said.Following this, Tilak and Gaurav drove the victim to the dealer in Delhi's Naraina from where he had originally bought the bike, while Bhanu rode the bike to it. The victim didn't enter the showroom but he was made to convince its owner to buy back cash."Atharv had purchased the superbike from the same showroom and when he wanted to sell it there, the owner accepted the offer. He gave the accused Rs 5 lakh in cash and transferred Rs 80,000 to the victim's bank account. This amount was also later transferred to the accounts of the accused," Gurgaon police spokesperson Sandeep Kumar said on Friday. After extorting the amount, the accused dropped off the victim on the Golf Course Road in Sector-56 at around 11pm. The victim then contacted his cousin who lodged a complaint with Sector-56 police early on Thursday morning. All three accused were arrested from Sector-80 on Thursday night and police recovered a car, an iPad, and a PlayStation from them. They are currently in police remand.

E-rick stops to pick up passenger, drunk driver rams car into it; 2 die

Ghaziabad. An e-rickshaw driver and his teenaged nephew died when a speeding Honda Amaze car crashed into their threewheeler from behind near Haldiram on Kalka Garhi junction in Sihani Gate. The car was seized, and the driver, who was drunk at the time, was arrested. Another passenger, Sonu Kumar (25), in the erickshaw suffered critical injuries due to the severe impact of the collision. According to Piyush Singh, additional DCP (traffic), Rinku Singh (34), who was returning home with his nephew, Shaksham Singh (15), stopped the vehicle to pick up another passenger after crossing the Kalka Garhi junction near Haldiram around 10pm on Thursday. A speeding Honda Amaze (UP14DR-1386) coming from the Old Bus Stand collided with the erickshaw from behind."The impact was so powerful that the e-rickshaw went for a toss in the air as well. Rinku was flung in the air, and his landed on the road on his head, while Shaksham received severe injuries. Both died on the spot. A police team reached the spot immediately and took the injured persons to a nearby hospital for medical treatment, but Rinku and Shaksham were declared dead on arrival, and Sonu was admitted for treatment. Later, he was referred to



Safdarjung hospital for better treatment," Singh said. The accused, identified as Pranav Mittal (28), is a resident of Ghantaghar and a scrap businessman. He had consumed alcohol with his friends before the accident and was intoxicated when the accident happened, cops said, adding he was on his way to meet his other friends for another alcohol party. After a complaint from the

family of the deceased, an FIR was registered against the accused under sections 106 (causing death by negligence) and 281 (rash driving) of the Bharatiya Nyaya Sanhita at Sihani Gate police station. According to police data. from Jan 1 to July 31 this year, a total of 329 accidents took place in the city, killing 145 and injuring 322.

Colleague kills man in Greater Noida, dumps body near factory over 'affair with wife'



NOIDA. A 21-year-old man was found dead with his neck slit in Greater Noida's Surajpur was allegedly killed by a colleague who suspected him of having an affair with his wife. Santosh Kumar, also known as Kalu, was found dead on the 130-metre service road, barely 2-3 km from a factory where he was employed.

Surajpur SHO Vinod Kumar told TOI that Santosh had not reported on duty for nearly 2-3 km before his body was recovered on Thursday morning.

When we questioned his colleagues, the needle of suspicion pointed at Umesh, a 26-year-old resident of Dadri, as he was last

spotted with Santosh on Wednesday night. Since then, both men were missing."Four teams were set up to nab Umesh. On Thursday night, when the police team was checking near the 130m road, Umesh was spotted on a motorcycle. When a police team chased him, he fired back and was injured in a retaliatory firing," ACP (Central Noida) Sumit Shukla said.

Umesh allegedly told interrogators that he and Santosh had shared a few drinks on Wednesday night."Umesh ensured that Santosh was

inebriated and took him to the usually desolate 130m road. There he slit his throat with a knife and left him bleeding on the spot," the SHO said.

According to police, Umesh suspected Santosh was having an illicit relationship with his wife and had planned to kill him. olice recovered Santosh's motorcycle, a

country-made pistol, two live cartridges, and two empty cartridges from Umesh's possession. He was booked under Section 103(1) (murder) of the Bharatiya Nyaya Sanhita after a case was registered at Surajpur police station on Thursday.

Thieves on prowl in trans-Hindon: 10 bikes & 4 chains stolen in 3 days

Ghaziabad. Trans-Hindon areas saw a significant rise in street crimes over the past few days, with 10 bike thefts reported in Indirapuram and Kaushambi over the last three days.

Four chains and two mobile phone snatching cases were also logged in the two areas within the same period. A bike owned by Dharmendra Kumar, a channel manager at RBL Bank in Indirapuram, was stolen on Aug 3. "Around 10am, I parked my grey TVS Radeon bike at RBL Bank in Aditya Mall and went for a briefing. When I returned, I didn't find the bike where I had parked it. I parked my bike with other colleagues, but only mine was missing. I called the police, who came to investigate. Indirapuram police lodged an FIR in the matter on Thursday evening," he said.Kaushambi police registered another FIR on Thursday regarding the theft of a Blinkit delivery executive's bike. Indirapuram resident Khadimul Byapari reported he parked his bike outside the Blinkit store in front of Cloud 9, Sector 1 in Vaishali, around 7.30pm on Aug 25.

"When I returned after ten minutes, I couldn't find my black Hero-Splendor BS6. I dialed 112 and cops reached the spot. They advised me to

register a complaint through UP COP. A person I know typed my complaint in English in the app as I did not find an option for Hindi," he said.

Varsha Saxena (29), a resident of Lajpat Nagar in Sahibabad, was a victim of mobile phone snatching while traveling in an auto-rickshaw on Aug 3. Another woman received minor injuries on her neck after two boys on a scooter snatched the gold chain she was wearing when she was



crossing Rajbagh Metro Station with her eight-year-old daughter. Her father, Bishwajit Sharma, filed a complaint on Aug 31. "The incident occurred around 2pm. After snatching Julie's chain, the two fled towards Sunday Bazaar Road in Shalimar Garden," he said.Nimish Patil, DCP Trans-Hindon, said the criminals flee to Delhi after committing crimes.

Israel strikes school, residential building in Gaza, 13 Palestinians killed

World At least 13 Palestinians were killed and 15 wounded in Israeli strikes on a school sheltering refugees and a residential building in Gaza, the Palestinian Authority's official news agency WAFA reported early on Saturday. At least eight of the dead were in refugee tents at Halima al-Sa'diyya School in Jabalia in northern Gaza, WAFA said. The Israeli army said in a statemen it had "conducted a precise strike on terrorists who were operating inside a Hamas command and control center embedded inside a compound that previously served as the 'Halima al-Sa'diyya' School in the northern Gaza Strip."In a separate incident, five Palestinians were killed in an Israeli strike on a residential building in the Nuseirat camp in central Gaza. The latest bloodshed in the decades-old Israeli-Palestinian conflict was triggered on October 7 last year when Hamas-led militants stormed into Israel, killing 1,200 and taking about 250 hostages, according to Israeli tallies.Israel's subsequent assault on the Hamas-governed enclave has since killed over 40,800 Palestinians, according to the local health ministry, while displacing nearly the entire population of 2.3 million, causing a hunger crisis and leading to genocide allegations at the World Court that Israel denies. According to the United Nations, at least 1.9 million people in the Gaza Strip are internally displaced, including some uprooted more than 10 times.

Panama deports 130 Indian 'irregular' migrants under USbacked repatriation deal

World Panama on Friday deported 130 Indian irregular migrants who had entered the country via the inhospitable Darien jungle, under a deal on repatriations signed with the United States in July. This was the first such expulsion outside the Americas under the deal, and the fourth in total

Washington pledged \$6 million for migrant repatriations from the Central American nation in the hopes of reducing irregular crossings at its own southern border.Panama's director of migration, Roger Mojica, told reporters the Indians were deported on a charter flight to New Delhi for "irregular migration."At the same press conference, US Security Attache for Central America Marlen Pineiro said Washington was "very grateful to the government of Panama for all this support," adding that: "Irregular migration cannot continue."

The Darien Gap between Colombia and Panama has become a key corridor for migrants traveling overland from South America through Central America and Mexico to the United States. Despite the dangers, including attacks by criminal gangs, more than half a million undocumented migrants- mostly Venezuelans- crossed the Darien last year

Transit countries such as Panama and Mexico have come under increased pressure from Washington to tackle the highly contentious migration issue in a US election year.

Joe Biden to host UK PM Keir Starmer in White House on September 13

Washington US President Joe Biden will host British Prime Minister Keir Starmer on September 13, the White House said on Friday.

UN investigator accuses Israel of a 'starvation campaign' in Gaza that Netanyahu denies

UNITED NATIONS. The UN independent investigator on the right to food accused Israel of carrying out a "starvation campaign" against Palestinians during the war in Gaza, an allegation that Israel vehemently denies. In a report this week, investigator Michael Fakhri claimed it began two days after Hamas' surprise attack in southern Israel that killed some 1,200 people, when Israel's military offensive in response blocked all food, water, fuel and other supplies into Gaza.Israeli Prime Minister Benjamin Netanyahu said accusations of Israel limiting humanitarian aid were "outrageously false." A deliberate starvation policy? You can say anything — it doesn't make it true," he said in a press conference Wednesday.Following intense international pressure — especially from close ally the United States — Netanyahu's government gradually has opened several border crossings for tightly controlled deliveries. Fakhri said limited aid initially went mostly to southern and central Gaza, not to the north where Israel had ordered Palestinians to go.

His online messages described the Brooklyn site, which is not named in court documents, as "the ultra orthodox hasidic jews world headquarters.

US teen shot dead by another during altercation in school bathroom

World A student at a Maryland high school died after being shot by another student during an altercation on Friday in a school bathroom, Harford County Sheriff Jeff Gahler said.Warren Curtis Grant, 15, died after the shooting at Joppatowne High School, the sheriff said at a media briefing.

A 16-year-old student whom police identified as the shooter fled shortly afterward but was caught minutes later nearby."He has yet to be charged, but will be charged, and at the time those charges are preferred as an adult, we will release the name of the suspect," Gahler said.

Gahler also said that the sheriff's office has had more than 10 incidents since 2022



"where the suspect was either the victim, witness or the suspect in an incident handled by the Harford County Sheriff's Office," adding that the investigation was in its early stages.

Wednesday's attack renewed debate about safe storage laws for guns and had parents wondering how to talk to their children about school shootings and trauma.

UK man gets 9 years in jai after far-right riot at hotel housing asylum seekers

World. A man who helped fuel a fire outside a hotel housing more than 200 asylum-seekers was sentenced Friday to nine years in prison, the longest punishment handed so far to those involved in last month's wave of far-right riots in England.At the sentencing hearing at Sheffield Crown Court in the north of England, painter and decorator Thomas Birley pleaded guilty to the charge of arson with the intent to endanger life at the Holiday Inn Express hotel in nearby Rotherham last month.Judge Jeremy Richardson told Birley, 27, that his case was "unquestionably" one of the most serious of the dozens he has dealt with in the past month in relation to the rioting outside the hotel on Aug. 4. He said he needed to pass an extended sentence due to Birley's danger to the public, and ordered that when he is eventually released he should be on licence for five years, meaning that if he reoffends he would be liable to go back to prison. The judge said he was particularly concerned about aspects of a presentence report that said Birley had an interest that "borders the territory, if not crosses it, to a white supremacist mindset."Birley, who has previous convictions, including for racially aggravated harassment, admitted arson with intent to endanger life, violent disorder and possession of an offensive weapon at a previous hearing. Overall, the judge said that like the other outbreaks of violence in England in early August, the case around the attack on the hotel was "suffused with racism."The court heard how the masked Birley was involved in many of the worst incidents on that Sunday afternoon, including adding wood to the fire in a bin that had been pushed against an one ablaze. Birley was also filmed throwing projectiles at the police, squaring up to officers while brandishing a police baton and throwing a large bin that crashed into a line of police with riot

Turkish-American Woman "Shot In The Head" After Israeli Forces Open Fire

Nablus. A Turkish-American woman was shot dead Friday while demonstrating against Israeli settlements in the occupied West Bank town of Beita, where the army acknowledged opening fire.Turkey identified the woman as Aysenur Ezgi Eygi, condemning her death, while the United States called it a "tragic" event and called on its ally Israel to carry out an investigation. While Washington stopped short from blaming anyone, the UN rights office directly accused Israeli forces of killing Eygi, saying Israeli security forces "shot in the head and killed" her. The incident occurred as Israeli forces withdrew from a deadly 10-day raid in the West Bank city of Jenin, another flashpoint in the Israeli-Palestinian conflict, amid the ongoing Gaza war. The raid, part of broader Israeli military

operations, has drawn international criticism, with Israeli ally Germany warning against escalating military actions in the West Bank. The UN said Eygi, 26, was participating in a "peaceful anti-settlement protest" in Beita, scene of weekly demonstrations. Israeli settlements in the West Bank -- where some 490,000 people live -- are illegal under international law. She arrived at the Rafidia hospital in Nablus "with a gunshot in the head" and was later pronounced dead, said hospital director Fouad Nafaa. Turkey said she was killed by "Israeli occupation soldiers". President Recep Tayyip Erdogan condemned the Israeli action as "barbaric". "We are deeply disturbed by the tragic death of an American citizen." said White House Press Secretary Karine Jean-Pierre

aboard Air Force One travelling with President Joe Biden."We have reached out to the government of Israel to ask for more information and request an investigation into the incident," she added.The Israeli army said it was looking into her death. Eygi was a member of the International Solidarity Movement (ISM), a pro-Palestinian organisation, and was in Beita for a weekly demonstration against Israeli settlements, said Neta Golan, the group's cofounder.Beita mayor Mahmud Barham said he was told an Israeli soldier "fired two shots" at protesters demonstrating against an Israeli settlement outpost, with one bullet hitting Eygi "in the head". Goats, rabbits, horses: US man kills 81 animals in 3-hour shooting spree

The accused went on a shooting spree in Northern California and killed 81 animals, including miniature horses, goats and chickens.

San Francisco. A man suspected of going on a three-hour shooting rampage in Northern California and killing 81 animals, including miniature horses, goats and chickens, pleaded not guilty to animal cruelty and other charges.

Vicente Arroyo, 39, made his first court appearance Thursday after Monterey County Sheriff deputies arrested him earlier in the week for allegedly using several weapons to shoot the animals being housed in pens and cages on a lot in the small community of Prunedale. The animal owners do not want to be identified or speak with the media, Monterey County Sheriff Commander Andres Rosas told The Associated Press Friday.

"I went out there, and it was a pretty traumatic scene. These were people's pets," he said. One of the miniature horses belonged to the owner of the lot where the animals were housed, and the other 80 belonged to someone who rented the

land to house their pets, Rosas said. According to court records, Arroyo was charged with killing 14 goats, nine chickens, seven ducks. five rabbits, a guinea pig and 33 parakeets and cockatiels. Arroyo is also charged with killing a pony named Lucky and two miniature horses named Estrella and Princessa, KSBW-TV reported.Some animals survived the shooting that lasted several hours but had to be euthanized because of the severity of their injuries, Rosas said. Rosas said Arroyo lived in a camper in a vineyard next to the lot where the animals were kept and that a motive is not yet known. His attorney, William Pernik, said that after talking to Arroyo and his family he became concerned about his client's mental competency and asked the judge for a mental health evaluation. 'We're dealing with an individual who has very serious charges and who does not appear to be in the

CRIME SCENE DO NOT CROSS right state of mind to understand the proceedings against him," Pernik said.Pernik said that Arroyo's family had reached out to various country agencies to get help for him but that "unfortunately, he did not

receive that mental health help in time before this tragic incident.

The judge ordered Arroyo, who is being held on a \$1 million bail, to undergo a mental evaluation. The court will get an update on Arroyo's mental status in two weeks, Pernik said. Authorities received multiple 911 calls around 3.25 am Tuesday reporting shots being fired in

Prunedale, an incorporated community about 8 miles (13 kilometres) from the city of Salinas, he said. Deputies who arrived on the scene could hear shots being fired, and a shelter-in-place was ordered for a five-mile radius.Monterey County SWAT members were sent in, and the sheriff's office also

requested drone assistance from the nearby Seaside Fire Department and Gonzales Police Department, Rosas said.Officers in an armored vehicle arrested Arroyo without incident, he said.Deputies found a crashed pickup truck and recovered eight firearms, including long rifles, shotguns and handguns, at the scene. After executing a search warrant on Arroyo's camper, they found another seven firearms, including an illegal AK-47 assault rifle, two ghost guns, and about 2,000 rounds of various calibers of ammunition,

TN health authority to attempt whole genome sequencing of dengue virus

CHENNAI: In a first, the State Public Health Laboratory under the Directorate of Public Health and Preventive Medicine (DPH) is attempting to carry out whole genome sequencing (WGS) of the dengue virus to determine the strain and severity of the disease, as was done in the case of Covid-19. Speaking at a presser on Friday, Health Minister Ma Subramanian stated that this is the first time that genome sequencing of the dengue virus is going to be attempted at the State Public Health Laboratory, DMS campus. Since there are no Covid-19 cases at present, the lab can be utilised for this purpose. Testing kits will be imported from the US, he added.Director of Public Health Dr T S Selvavinayagam said that after Covid-19, dengue is currently growing into a challenge and this research attempt will help take preventive and control measures for dengue. "We will also know the severity of the disease. So we can take measures," he

Selvavinayagam said the technicians at the lab were trained in genome sequencing as they already performed it for Covid-19.The minister further cautioned that dengue cases may rise this year, based on the pattern of such cases spiking once every five years. Since January, Tamil Nadu has reported over 12,000 dengue cases and five deaths so

Bharat Electronics Limited proposes to fell 900 trees on campus, enraging greens in Bengaluru

BENGALURU: Bharat Electronics Limited (BEL) has proposed to fell over 900 trees on its campus to create infrastructure facilities for production, testing, storage and upgradation for export manufacturing, including the production of large-scale EVMs. The proposal has been submitted to the tree committee, which directed the Bruhat Bengaluru Mahanagara Palike (BBMP) to issue a paper notification inviting objections.Bengaluru Biodiversity member Vijay Nishanth, objecting to the move said that the ten-day timeframe for objections is insufficient and that enough time should be given to consider the proposal. "There should be public consultation on the same, as the number of trees to be cut is a huge figure. The primary purpose of the tree committee should be to conserve trees and not merely approve or deny the felling of trees when an application is filed," said Nishanth and added that the committee has not yet published any report about the planting of tree saplings as a backup, its success rates and the current status.Dattatreya Davare, Trustee of Bengaluru Environment Trust, opined that a conclusion about the felling of the trees can be drawn only after an inspection by the authorities. BEL may have carried out plantations in the past due to the availability of land. The question here is whether such expansion is required or another location

New biotech policy to boost sector in Karnataka

BENGALURU: Aiming to solidify the state's position as a global leader in the biotechnology sector, Minister for IT/BT Priyank Kharge unveiled the Karnataka Biotechnology Policy 2024-2029 on Friday. The new policy is targeting a market value of \$100 billion by 2030. The policy is centred on 'Focused transformation through impactful implementation' aiming to synergise with existing state policies, while addressing the specific needs of the biotechnology sector.Key objectives of the policy include: Strengthening biotech education through skilling programmes, streamlining biotech regulations to facilitate business setups and attract investment, and supporting biomanufacturing aligned with health, climate and energy goals to enhance food security.It also focuses on providing continued support for early-stage biotech startups with funding and mentorship, and for mid-stage ventures with growth facilities and market access through preferential procurement of local products, apart from enabling preferential procurement for local biotech products and expediting innovation through a Regulatory Sandbox, and supporting research and development and commercialization in genomics, molecular biology and related fields.

The goal is to facilitate the creation of 300 biotech companies, including 50 innovative firms with a robust incentive package, generate 30,000 high-quality jobs in biotech by 2029 and partner with over 200 institutions to train 20,000 individuals in specialized skills. The updated policy is built on six pillars - skill development for a futureready workforce, streamlining regulatory frameworks, specific support to biomanufacturing activities, scaling up biotech startups and MSME ecosystem, preferential procurement and sandbox, and fiscal incentives and concessions. The policy works on emerging areas such as bioagriculture, bio-industrial applications, marine biotechnology, synthetic biotechnology, medical.

India not yet ready for AI regulations says Experts

HYDERABAD: On the second day of the Global AI Summit 2024 at HICC, experts from various fields discussed key aspects of Artificial Intelligence (AI).n the panel discussion on 'Building Trust into AI Systems', experts emphasised the importance of transparent,

ethical and accountable AI practices. Opinions varied on how to adapt regulations similar to the European Union Artificial Intelligence Act. Arghya Sengupta, Founder & Research Director of Vidhi Centre for Legal Policy, said that India is not yet ready for AI regulations and that small

innovators and developers could be most affected and recommended adopting certain codes of practice to make AI more responsible.Sunil Abraham, Public Policy Director, Data Governance & Emerging Technologies at Meta, stressed the importance of focusing on model development, with developers playing a key role in creating AI models.Experts from

Georgia University discussed how Al could improve society by integrating technology into daily life and governance.Dr Devesh Ranjan, Eugene C Gwaltney, Jr School Chair and Professor, George W Woodruff School of Mechanical Engineering, Georgia



Institute of Technology, highlighted five areas where AI could enhance services in India: improving government services (natural disaster and risk assessment), increasing access to services (digital extensions for farmers), maximising effectiveness of frontline workers (upskilling Anganwadi workers and healthcare professionals), reducing.

China shifts gears to combat strong rivals

THE Chinese military is shifting its focus to winning wars against stronger opponents amid mounting challenges. According to a South China Morning Post report, President Xi Jinping, who is also the Chairman of the Central Military Commission (CMC), China's highest defence body, has directed the People's Liberation Army (PLA) to enhance its strategic capabilities to defend the country's sovereignty and developmental interests.Xi unveiled the new directive while commemorating Deng Xiaoping's 120th birth anniversary on August 22. He highlighted Deng's vision for the PLA which was instrumental in developing it into a strong, modernised and well-organised force emphasising the importance of 'fewer but better troops'. General Miao Hua, a member of the CMC, stated while commenting on the strategic shift, "In the new journey, we should focus on strengthening capabilities to defeat strong enemies and opponents."A recent article in the PLA Daily, while referring to Deng's 1980 strategic judgement that "a world war can be postponed or avoided", noted that China now faces great changes unseen in a century. It asserted the need for the armed forces to remain vigilant and maintain strategic clarity on the possible risk of war, make full preparations for military struggle, effectively deter war and resolutely win it. The Chinese leadership has refined its warfighting doctrines of winning local wars since the 1990s through white papers and strategic guidelines. The first 'White Paper on National Defence' was published in 1998. Following the release of 'White Paper on National Defence (2006)', the PLA adopted the 'local wars under informationised conditions' doctrine to match technologically superior adversaries. Through the 'informationised war' doctrine, China sought to impose high costs on conventionally superior opponents by targeting command, control, communication, computer, intelligence, surveillance and reconnaissance (C4ISR) networks. The recent directive to the military to prepare for wars against strong enemies marks another strategic shift, primarily as a response to the challenges China is facing, both in the maritime domain and on the land borders. Incidentally, Xi, on assuming power in 2012, had initiated a slew of deep-rooted military reforms as he had envisioned the PLA to play a key role in realising the 'China Dream' of a prosperous and powerful China by the middle of the century. Sovereignty was identified as one of the key national objectives. Besides fostering nationalism, it was to ensure the security of periphery and the integration of Taiwan and all claimed territories with the motherland. To provide strategic direction to implement Xi's vision, the 'White Paper on National Defence, 2015' (China's Military Strategy) was released. Its theme was 'active defence', and its focus was on winning 'local wars under conditions of modern technology'. It implied a major transition in the naval strategy from 'offshore waters defence' to a combined strategy of 'offshore waters defence and open sea protection' to secure China's maritime

To operationalise the new doctrine, the CMC was restructured and military regions reorganised into theatre commands. A number of measures were instituted to enhance military capabilities across the spectrum. PLA navy (PLAN), numerically the biggest navy today with more than 350 ships, is expected to reach a strength of few years. The Chinese Coast Guard is the largest in the world, with over 100 vessels. The PLA air force is in the process of building an 'air space defence force' to enhance its power projection capabilities. It is expected to have a fleet of over 1,000 stealth and fifth-generation fighter aircraft by around 2035. Besides, the Rocket Force arsenal is anticipated to go up to 700 before the end of the decade, duly complemented by hypersonic glide vehicles and cruise missiles.

Crumbling statues, falling standards

TRYSTS AND TURNS: The fear that haste may lead to waste does not seem to worry the authorities

A 35-ft statue of Chhatrapati Shivaji Maharaj, the great Maratha warrior known for his guerrilla warfare skills — which he successfully used against the Mughals — was knocked down by strong winds blowing across the coastal town of Malwan in the Konkan region of Maharashtra. The statue had been erected in a hurry prior to the Lok Sabha elections this year to permit Prime Minister Narendra Modi to inaugurate it. Modi, always willing to perform such

pre-election chores, obliged. Just six months later, he was forced to apologise for the mishap, though he himself could hardly be blamed for nature's vagaries. His sycophants were the real culprits.

Around Rs 83 crore were spent on the statue's construction, which was entrusted to the Navy in deference to the memory of Maratha admiral Kanhoji Angre, who commanded the Maratha navy in those glorious days. The original plan, it now appears, was to build a six-ft statue and the design for it was scrutinised and approved by the Directorate of Art as per the prescribed procedure. One wonders who raised its height and why. Those who would have claimed credit for the statue will now seek anonymity for valid security concerns.

Stories of incompetence and blatant corruption are doing the rounds, all leading to the doorstep of Mahayuti leaders Eknath Shinde, the Maharashtra Chief Minister who leads a faction of the Shiv Sena, and BJP leader Devendra Fadnavis, one of the two deputy chief ministers. Nationalist Congress Party (NCP) leader Ajit Pawar, who abandoned his uncle Sharad Pawar for personal aggrandisement, is the other Deputy CM, but he has distanced himself from his partners because he had sensed the Maratha anger against the toppling of the statue.

The BJP realises that Ajit is proving to be a liability in the three-party alliance. Ajit's uncle still commands the loyalty of the Maratha community, as was proved in the 2024 Lok Sabha elections. Fadnavis, the BJP's loyal pointsman in the state, had erroneously calculated that the ambitious Ajit would be able to bring in the bulk of the NCP's vote bank, but that was not to be. Sharad continues to be the Maratha strongman, despite his advancing age and ill health. Ajit's tirade against his friends in the

Mahayuti is not going to help him advance his political career. At present, it has only succeeded in weakening the ruling alliance's chances of retaining power. The molestation of two four-year-old girls in a school at Badlapur in Thane district had already done harm to the fortunes of the Mahayuti. And now, nature has joined forces with the Opposition MVA (Maharashtra Vikas Aghadi), led by the Congress and consisting of a resurgent Shiv Sena-UBT



(Uddhav Balasaheb Thackeray) and the presently dominant Sharad-led faction of the NCP.

As of today, the dice is loaded against the parties in power. The BJP had made inroads in urban areas of the state. It will hold on to its voters, but the two parties on whose strength it relied will not be able to contribute to the extent Fadnavis expected them to do. In fact, there is the distinct possibility of the NCP's Ajit faction gradually fading into oblivion. When the foot soldiers find that their leader will not be able to provide the expected goodies, they will gravitate to those in a position to oblige.

Reverting to the matter of the statue, it is quite obvious to even the poorly informed that such construction needs expertise of a superior calibre. It also needs supervision of a higher order with officials for the purpose being chosen from among those with a reputation for integrity. Fortunately, there still remain many in the IAS with that qualification.

The pressure to complete works expeditiously, which is happening often when elections are round the corner, should be avoided. The PM inaugurated the


new Parliament building in a bit of a hurry and very soon it developed leakages and defects. Modi did not apologise for that fiasco like he did for the fall of Shivaji's statue! According to his statement, the Maratha warrior was a 'god'. Agreed that a building cannot be deified, but a Parliament building is a sacred place, because like the poet Byron wrote about the Castle of Chillon in Switzerland, "May none those marks efface! For they appeal from

> tyranny to God." A massive project is underway in my city of Mumbai. It is the Coastal Road project that has reclaimed acres and acres of land from the sea to decongest the heavy traffic caused by the proliferation of cars. The work goes on relentlessly day and night since targets are set (as they should be) and important leaders are eager to inaugurate even minor sections of the project. The fear that haste may lead to waste does not seem to worry the authorities like it worries thinking citizens. I remember the car journey I took once from Kowloon to the mainland of Hong Kong through an undersea tunnel. It was a feat of engineering. A similar tunnel was a part of Mumbai's Coastal Road. Very

soon, it developed leaks. When the media carried the news, many senior citizens decided against travelling by car through that tunnel. I am told that the leaks have been patched. That is a consolation, but why are we so tolerant of shoddy work which is inevitable if it has to be completed in a hurry to accommodate leaders who want their names embossed on stone?Bihar has not yet received its annual quota of rainfall, but as soon as the first showers fell, as many as a dozen newly constructed bridges collapsed! In Rajkot (Gujarat), a bridge collapse resulted in the death of car passengers. Are our engineers and contractors incompetent or, as is more likely, have they dipped their hands into the till? Since no one is held responsible and punished, Modi's promise of remaining squeaky clean himself and ensuring that his administrators also remain above board is like his promise to show no mercy to those convicted of molesting women — only an empty promise meant for luring voters to keep double-engine governments in office.

rape, creates a legal conundrum. Andhra Pradesh and Maharashtra have struggled to secure the presidential assent on similar Bills. Plus, even as the death penalty has not proved effective as a deterrent, the irreversible nature of such a punishment raises human rights

The passing of the Aparajita Bill is a desperate move by the TMC government, aiming to restore public faith and regain control over the narrative. Whether this legislation will bring the desired change or simply add to the long list of unimplemented laws remains to be seen. As the Bill awaits approval by the Governor and President, the broader question of its efficacy and ethical implications looms large. The state would do well to focus on improving the investigative and judicial processes, ensuring a swift and fair trial and addressing

the systemic issues that lead to such heinous crimes.



Gautam's departure from the AAP is the third high-profile exit from the party in recent times, following the exit of MLA Kartar Singh Tanwar and ex-Minister Raaj Kumar Anand.



Delhi govt to pay Rs 7.5 lakh relief for prisoners dying in jail

NEW DELHI. Delhi government has decided to pay a compensation of Rs 7.5 lakh to the next of kin or legal heirs of prisoners who die due to unnatural reasons while confined in the jails of Delhi. The city government has submitted a proposal in this regard to the Lieutenant Governor (L-G) for his nod.

Unnatural custodial death could be caused due to quarrels among inmates, beatings by prison staff, torture, negligence by prison officers, or negligence by medical or paramedical officers. However, compensation will not be admissible in cases of unnatural death due to suicide, escape attempts from jail or lawful custody outside the jail, or in cases of natural death, disaster, or calamity. It will also not apply to deaths

Commenting on this, Delhi Home Minister Kailash Gahlot, stated, "The state government believes that this measure will act as a deterrent against misconduct and negligence in our jails." Once approved, the policy will take effect from the date of notification, he added.

The superintendent of the jail concerned will be required to submit a detailed report, including a copy of the magisterial enquiry report, postmortem report, final cause of ⋐ death, medical history at the time of admission in jail, and details of any medical treatment provided before the custodial death. The report will be sent to the Director General (DG) of Prisons, Delhi, for onward submission to the National Human Rights Commission (NHRC).

Dengue cases dropped by 94 per cent this year, says NDMC

NEW DELHI. Over 94% drop in cases of dengue were recorded this year, the New Delhi Municipal Council (NDMC) said on Friday. According to the data released by the civic body, seven cases of dengue were recorded till August 29, in comparison to 131 of the last year.

Moreover, no case of Chikungunya was recorded this time. Previous year, one case was reported. The data showed that the NDMC has issued 1,679 notices this year so far where mosquito breeding was found and 104 challans were issued till now.

NDMC Member Kuljeet Singh Chahal said that the NDMC is making all efforts to identify and eliminate existing mosquito-borne breeding conditions to prevent the

outbreak of malaria and dengue in the area.
"Due to surveillance and awareness, cases of mosquito-borne diseases, especially dengue, have come down by 94 per cent. This year only seven patients of dengue have been detected as compared to the last year of 131."There was one patient of malaria, not a single patient of chikgunya has been registered this year. As compared 🍣 to the MCD, it has reported 237 cases of malaria, 578 cases of dengue, and 30 cases of chikungunya," Chahal said.

The NDMC area divided into 14 circles wherein 15, anti-malaria mate 15 surveillance worker, 83 anti-malaria gangman, and 29 seasonal anti-malaria workers with 30 additional workforce from civil department during monsoon seasons developed to prevent and checked the area by providing the machines like knap sack, battery spray machine, puls fog, vehicles mounted fogging machines, he said.



Probe agency NIA charges UK national for 2023 attack on Indian Mission in UK

New Delhi. The National Investigation Agency (NIA) has filed a chargesheet against a key accused, Inderpal Singh Gaba, in connection with the 2023 attack on the Indian High Commission in London. Gaba, a resident of Hounslow, UK, was arrested by the NIA in April this year in connection with the attack by pro-Khalistan supporters on March 19 and 22, 2023.

According to the NIA chargesheet, Inderpal Singh Gaba was one of the agitators who actively participated in the anti-India protest outside the Indian High Commission on March 22 last year. On that day, over 2,000 pro-Khalistan supporters vandalised



the High Commission buildings, throwing various objects, including ink, to deface them. Three days earlier, a mob had pulled down the Indian flag, injuring some embassy staffers in the process.

The attack was allegedly orchestrated by Avtar Singh Khanda, a UK-based leader of the Khalistan Liberation Force (KLF), who later died in a UK hospital in June last year.

Meanwhile, Inderpal Singh Gaba was detained by immigration authorities at the Attari border in December 2023 upon his arrival from London via Pakistan. The detention was based on a lookout circular issued against him.

According to the NIA, a probe was initiated and Gaba was instructed not to leave the country while the investigation was ongoing. The NIA stated that it seized his mobile phone and analysed the data, uncovering several incriminating videos and photos of the incident, which eventually established his involvement.

Delhi government approves compensation for unnatural custodial deaths

The Kejriwal government has approved a compensation of Rs 7.5 lakh for the families of those who die under unnatural circumstances in Delhi's prisons.

New Delhi. The Delhi government has approved a compensation of Rs 7.5 lakh for the families or legal heirs of prisoners who die under unnatural circumstances while in custody in Delhi's prisons. The proposal has been submitted to Lieutenant Governor VK Saxena for final approval.

Unnatural custodial deaths may include incidents caused by inmate fights, beatings by prison staff, torture, or negligence by prison officers, medical, or paramedical staff. However, compensation will not be provided in cases of death due to suicide, escape attempts, lawful

custody outside the jail, natural causes, disasters, or illness.

Delhi Home Minister Kailash Gahlot said the measure aims to deter misconduct and negligence in prisons. The policy, once



approved, will take effect from the date of notification.

The jail superintendent must submit a detailed report, including a magisterial inquiry report, postmortem results, the final cause of death, medical history upon

admission, and any medical treatment provided before the death. This report will be sent to the Director General of Prisons for submission to the National Human Rights Commission (NHRC).

A committee led by the Director General of Prisons, including the Additional Inspector General, Resident Medical Officer, DCA, and Law Officer, will review the reports and decide on compensation according to the rules. The committee is required to meet quarterly or as needed to review cases of custodial deaths and must inform the NHRC when compensation is awarded.

The policy also includes provisions for recovering compensation from the salaries of prison officials found responsible. If staff involvement is proven, the committee may order the



recovery of the compensation amount from the salaries of the erring officials as deemed appropriate.

India beats China in MSCI EM market index

NEW DELHI. India has overtaken China in the MSCI EM Investable Market Index (IMI) on September 4 to become the largest weight, and is nearing the threshold to surpass China as the top weight in the broader MSCI Emerging Markets index as well.

The weight of India in MSCI EM IMI stood at 22.27% compared to 21.58% of China. MSCI IMI consists of 3,355 stocks and includes large, mid and small cap companies. It captures stocks across 24 Emerging Markets countries and targets coverage of nearly 8 of the free float-adjusted market capitalisation in each country. While main MSCI EM index covers large and midcap space, the IMI includes large, mid, and smallcap stocks. India's heavier weight vis-a-vis China in MSCI IMI stems from greater small-cap weighting in its basket. The rebalancing reflects broader market trends. While Chinese markets have struggled due to economic headwinds, Indian markets have benefitted from favourable macroeconomic conditions. In recent past, India posted a much better market performance, driven by macroeconomic fundamentals as well as robust performance by corporates.

Indices fall over 1 per cent ahead of US jobs data release

NEW DELHI. Following three weeks of a bull run, domestic equity market corrected sharply on Friday with the benchmark indices - BSE Sensex and NSE Nifty - crashing more than 1% each.

BSE Sensex closed 1,017 points or 1.24% lower at 81,183 levels while the Nifty shut shop 293 points or 1.17% lower at 24,852 levels. Investors lost a whopping Rs 5.31 lakh crore as the market capitalisation came down to Rs 460.37 lakh crore on Friday against Rs 465.68 lakh crore in the previous session.

The fall is attributed to the nervousness ahead of the release of the US job data as this would give clarity on the state of the world's largest economy and its willingness to go for a rate cut in near future. Profit booking at record high levels took place due to the Sebi's deadline over foreign institutional investors (FIIs) disclosure norm. Vishnu Kant Upadhyay, AVP, research and advisory at Master Capital Services, said investors are opting to stay on the sidelines, holding cash in anticipation of the US jobs report's release. "This fall is attributed to concerns over a potential slowdown in the US labour market, following the ADP non-farm employment report, which revealed that private businesses added only 99,000 jobs in August, much below the forecasted 144,000. Market participants are awaiting official non-farm payrolls report from the Bureau of Labor Statistics, expected later today," added Upadhyay

Additionally, nervousness in banking stocks has surfaced ahead of the release of loan and deposit growth data. Nifty50 has fallen below the critical 25,000 mark, prompting put writers to cover their short positions, exacerbating the market downturn, he said.

Council may cut GST on health insurance to 5 per cent

NEW DELHI. The Goods and Services Tax (GST) Council is set to discuss crucial matters that could reshape tax implications for mediclaim policies during its meet on September 9.

The meeting will focus on proposals aimed at rationalising the current GST structure, which currently imposes an 18% tax on mediclaim premiums, which many stakeholders argue is unsustainable for consumers and insurers alike.

As per sources, among the proposals under consideration are options to allow mediclaim companies to charge a



reduced GST rate of 5% without the benefit of input tax credit (ITC) or to implement a uniform 5% rate specifically for business-to-consumer (B2C)

In the interest of common people, the best way for the GST Council it seems would be that the GST rate on mediclaim be reduced to 5% or 12% with the benefit of ITC available to the suppliers of the announce extending GST amnesty

policy. This would mean a pure vanila reduction of the GST rate for common people.Insurance companies are duty bound to pass on this benefit as they can't make profit from rate reduction due to anti-profiteering provisions under GST,' suggested Vivek Jalan, Partner at Tax Connect Advisory Services LLP.

Maharashtra govt nod for USD 10 billion Adani-Tower Semicon proposal

government approved a USD 10 billion semiconductor investment proposal from a joint venture between Tower Semiconductor and the Adani Group on Friday.As per Deputy Chief Minister Devendra Fadnavis, the unit will be established in Taloja, Panvel. While the government has approved the proposal, it has not yet received approval from the Union Ministry of Electronics and Information Technology, which has allocated USD 1 billion for semiconductor projects in the country.

As per the reports, the joint application by Tower Semiconductor and Adani Group is still under consideration by the India Semiconductor Mission (ISM) and the IT ministry.

ccording to the reports, the unit located in Navi Mumbai suburbs of Raigad district will have an initial overall



capacity of 40,000 wafer starts per month (WSPM) and a capacity of 80.000 WSPM. Of the total investment, Rs 58,763 crore will be allocated to the first phase and Rs 25,184 crore to the second phase, deputy chief minister said.If approved, this project will be the country's second chip manufacturing facility and the sixth semiconductor plant for manufacturing or testing and packaging silicon chips. Earlier this week, the government had approved a Rs 3,307 crore outsourced assembly and testing (OSAT) unit proposal by Mysore-based Kaynes Semicon.

The OSAT unit will be set up in Sanand, Gujarat, with a capacity of 6.3 million chips a day. So far, the government has approved several semiconductor projects, including a chip fabrication unit in Dholera,

Gujarat, and four chip packaging units: three in Sanand, Gujarat, and one in Morigaon, Assam. The cumulative investment in these projects is Rs 1.50

This Italian town bans cricket as mayor targets Bangladeshi immigrants

... Monfalcone has officially banned cricket, with fines up to €100 for those playing the sport within town limits. The ban is part of a broader antiimmigrant crackdown by the town's far-right mayor.

New Delhi. A town in northern Italy has banned cricket, a decision made by its mayor, who views the sport and the Bangladeshi immigrants who play it as foreign and "incompatible" with local culture.ccording to a report by the BBC, the town of Monfalcone officially banned the sport and has imposed fines of up to €100 on those found playing cricket within its limits. The ban has become a symbol of the broader ethnic tensions in Monfalcone, which is situated near Italy's Adriatic coast.The town-with a population of about 30,000—has nearly a third of its residents as

foreigners, mainly Bangladeshi Muslims who came in the late 1990s to at a major shipyard.Monfalcone's cultural landscape has been reshaped with Bangladeshi restaurants, halal shops, and a network of cycle paths frequented by the South Asian community. Mayor Anna Maria Cisint, representing

former Prime Minister Matteo Salvini's far-right Lega party, campaigned on an anti-immigration platform and has made efforts to "protect local culture" and "Christian values.""Our history is being erased," she told the BBC, lamenting the changes she believes are

negatively impacting the town. Miah Bappy, a Bangladeshi migrant worker at Italy's largest shipyard, Fincantieri, told the BBC that he and his fellow countrymen are forced to play cricket on the outskirts of the city.Bappy explained that playing within Monfalcone attracted immediate police intervention. He cited a recent incident where Bengali teens were fined after being caught on security cameras while playing in a local park.But the cricket ban is merely the tip of the iceberg, reflecting a wider anti-



immigrant crackdown spearheaded by the mayor.During her two terms, Cisint has removed benches from the town square and criticised the attire of Muslim women at the beach.ensions escalated when Cisint reportedly banned collective prayer at the town's two Islamic centres, citing urban planning issues. She also accused the Bangladeshi community of fostering "Islamic fundamentalism." On the cricket ban, Cisint told the BBC that the Bangladeshi community has contributed nothing to the city and should play elsewhere. She argued that there is neither space nor funds to build a cricket pitch and cites safety concerns over cricket balls."They've given nothing to this city, to

our community. Zero.""They are free to go and play cricket anywhere else...outside of Monfalcone," she told the BBC. The mayor is also facing death threats due to her views on Muslims and has been under 24-hour police protection.Meanwhile, Cisint has accused Fincantieri of wage dumping, paying below market rates, but Cristiano Bazzara, the shipyard director, asserts that wages comply with Italian law."We are not able to find trained workers. In

Europe, it's very difficult to find young people who want to work in a shipyard," Bazzara told the BBC.Notably, Italy faces significant labour shortages and has one of Europe's lowest birth rates, necessitating a continued influx of foreign workers. The country is projected to need 280,000 foreign workers annually until 2050 to address the shrinking workforce. This has prompted Prime Minister Giorgia Meloni to increase work permits for non-EU nationals despite running on an anti-immigration platform.Bangladeshi residents, such as 19year-old Meheli, feel targeted by the mayor's actions and report harassment due to their heritage.

I cannot take names, but they told me, 'Aap yeh kapde pehno aur yeh scene karo' (wear these clothes and do this scene). I didn't wear those clothes. In the scene, he told me he was my boss, and I had to seduce him. I was very innocent then, so I did the scene. That person tried to force himself on me, and I got so scared. I pushed him away and ran out. The security staff realised what had happened and asked me to leave immediately. They thought I would make a scene and call for help," she shared. However, the former Bigg Boss winner chose not to reveal the producer's name. "He was from the Hindi film industry. I agreed to do the scene because he was also an actor," she said, adding, "I'm not lying, but I cannot take his name. His children are probably a little younger than me, and if I name him, they will suffer too."Shilpa also recounted an encounter with the same producer years later. "After a few years, I met him again, and he spoke to me kindly. He didn't recognize me and even offered me a film role. I refused. He still doesn't remember me."The actress, who rose to fame with Bhabi Ji Ghar Par Hai!, went on to say that similar experiences have happened to many others in the industry. "These things happen to
